ON THE BETTI MAP ASSOCIATED TO ABELIAN LOGARITHMS

ABSTRACT. (draft 5)

1. PROBLEM AND MAIN RESULTS.

1.1. Let A be a complex abelian variety of dimension g. We write Λ for the its *period lattice* $H_1(A(\mathbb{C}), \mathbb{Z})$, identified with the kernel of the exponential map $\exp_A : Lie A \to A$.

We fix a complex point σ of A, and let Λ_{σ} be the lattice formed by the pairs $(\ell \in Lie\ A, m \in \mathbb{Z})$ such that $exp_A(\ell) = m\sigma$. It sits in an extension

$$(1.1) 0 \to \Lambda \to \Lambda_{\sigma} \overset{(\ell,m) \to m}{\to} \mathbb{Z} \sigma \to 0,$$

and we fix a splitting $\lambda:\mathbb{Z}\sigma\to\Lambda_\sigma$ (*i.e.* a branch of the "abelian logarithm"). On the other hand, let us consider the first projection $\Lambda_\sigma\stackrel{(\ell,m)\mapsto\ell}{\to}Lie\ A$ and its \mathbb{R} -linear extension $\Lambda_\sigma\otimes_\mathbb{Z}\mathbb{R}\to Lie\ A$. Since the composed map

$$(1.2) \Lambda \otimes_{\mathbb{Z}} \mathbb{R} \to \Lambda_{\sigma} \otimes_{\mathbb{Z}} \mathbb{R} \to Lie A$$

is an isomorphism, one has a canonical projection $\Lambda_{\sigma} \otimes_{\mathbb{Z}} \mathbb{R} \to \Lambda \otimes_{\mathbb{Z}} \mathbb{R}$, and the image of $\lambda(\sigma)$ in $\Lambda \otimes_{\mathbb{Z}} \mathbb{R}$ can be expressed, in terms of a basis $\underline{\ell}$ of Λ , by 2q real coordinates: the *Betti coordinates*¹ of σ .

1.2. We are actually interested in the relative setting. Let S be a smooth connected complex algebraic variety.

Let $A \xrightarrow{f} S$ be an abelian scheme of relative dimension g. Its Lie algebra $Lie\ A$ is a rank g vector bundle on S. For our purpose, there will be no

loss of generality² in assuming, as we shall do, that S is affine and that this vector bundle is trivial, i.e. $\Gamma Lie\ A$ is a free $\Gamma \mathcal{O}_S$ -module of rank g.

Let $\sigma: S \to A$ be a section of f. The above constructions extend to this relative setting as follows. Let \tilde{S} be a universal covering of $S(\mathbb{C})$, with its canonical structure of complex analytic manifold. The kernel of \exp_A is a locally constant sheaf on $S(\mathbb{C})$, which can be viewed as a constant lattice Λ on \tilde{S} . Similarly, one constructs an exact sequence of lattices on \tilde{S}

$$(1.3) 0 \to \Lambda \to \Lambda_{\sigma} \stackrel{(\ell,m) \to m}{\to} \mathbb{Z}\sigma \to 0$$

and fixes a splitting $\lambda : \mathbb{Z}\sigma \to \Lambda_{\sigma}$.

Let \tilde{S}^{real} be \tilde{S} viewed as a real-analytic manifold and let $\mathcal{O}^{\mathbb{R}}(\tilde{S}^{real})$ (resp. $\mathcal{O}(\tilde{S}^{real})$) be the ring of real-valued (resp. complex valued) real-analytic functions on \tilde{S} . The composed map

$$(1.4) \quad \Lambda \otimes_{\mathbb{Z}} \mathcal{O}^{\mathbb{R}}(\tilde{S}^{real}) \to \Lambda_{\sigma} \otimes_{\mathbb{Z}} \mathcal{O}^{\mathbb{R}}(\tilde{S}^{real}) \to \Gamma Lie A \otimes_{\Gamma O_{S}} \mathcal{O}(\tilde{S}^{real})$$

is an isomorphism of free $\mathcal{O}^{\mathbb{R}}(\tilde{S}^{real})$ -modules. One thus has a canonical projection $\Lambda_{\sigma} \otimes_{\mathbb{Z}} \mathcal{O}^{\mathbb{R}}(\tilde{S}^{real}) \to \Lambda \otimes_{\mathbb{Z}} \mathcal{O}^{\mathbb{R}}(\tilde{S}^{real})$, and the image of $\lambda(\sigma)$ in $\Lambda \otimes_{\mathbb{Z}} \mathcal{O}^{\mathbb{R}}(\tilde{S}^{real})$ can be expressed, in terms of a basis $\underline{\ell}$ of the lattice Λ , by a real-analytic map (the *Betti map*)

(1.5)
$$\beta = \beta(\sigma, \lambda, \underline{\ell}) : \quad \tilde{S} \to \mathbb{R}^{2g}.$$

1.3. We assume for convenience that $A \to S$ is *principally polarized*, which allows to consider to the *moduli map* $\mu: S \to \mathcal{A}_g$. We denote by $A_{\bar{\eta}}$ the geometric generic fiber, and we set

$$(1.6) d = \dim \mu(S).$$

We are interested in the range of β . It is easy to see that the its dimension is $\leq \min(2d, 2g)$. Under what condition is the range of β maximal, i.e. of dimension $\min(2d, 2g)$?

This may not be the case for various trivial reasons (e.g. when the σ is a torsion section, or when $A \xrightarrow{f} S$ is the pull-back of an abelian scheme defined over a base of dimension $< d \le g$).

- **1.4.** Here is a sample of concrete results [not our final results, hopefully!]:
- **1.4.1. Theorem.** Assume that $g \leq \min(3, d)$ and that the section σ is not contained in a proper subgroup scheme of A. Then the range of β has real dimension 2g. More precisely, the restriction of β to the inverse image of a dense Zariski-open subset of S is a submersion.

The proof relies on an analysis of the Kodaira-Spencer map.

- **1.4.2. Theorem.** Assume that σ is not contained in a proper subgroup scheme of A. Assume moreover that $d \leq \min(2, g)$. Then β has real image 2d. More precisely, the restriction of β to the inverse image of a dense Zariski-open subset of S is an immersion.

 - **2.** AN INFINITESIMAL APPROACH, AND ITS HOLOMORPHIC TRANSLATION.
- **2.1.** Our approach is infinitesimal. In fact, the problem we address is the following:

under what condition is β almost everywhere an immersion, resp. a submersion (according to whether $d \leq g$ or $g \leq d$)?

2.1.1. Proposition. For every $s \in \tilde{S}$, $\operatorname{Ker} \beta(s)$ is a complex vector subspace of $Lie A_s \cong \mathbb{R}^{2g}$. Moreover the fibers of β are complex-analytic subspaces of \tilde{S} , and all non-empty fibers have dimension $\geq 2d - r$, where r is the generic rank of β .

2.2. We may first replace S by a finite etale covering and assume that for some $n \geq 3$, the n-torsion sections are defined over S, then replace it by its image in the moduli space $\mathcal{A}_{g,n}$ of principally polarized abelian varieties of dimension g with level n-structure. We thus consider the rank of a jacobian matrix of size (2d, 2g), and for this purpose, we introduce the following notation:

 $(\omega_1,\ldots,\omega_g,\eta_1,\ldots,\eta_g)$ is a symplectic basis of $\mathcal{H}^1_{dR}(A/S)$ with $\omega_1,\ldots,\omega_g\in\Omega_A$,

 $(\gamma_1, \ldots, \gamma_q)$ is a symplectic basis of Λ ,

$$\Omega_1 := \left(\int_{\gamma_i} \omega_j\right)_{i,j=1,\dots g}, \ \Omega_2 := \left(\int_{\gamma_{i+g}} \omega_j\right)_{i,j=1,\dots g}, \ Z := \Omega_1 \cdot \Omega_2^{-1} = {}^tZ$$
 (which takes values in \mathfrak{H}_g), $L := \left(\int^{\sigma} \omega_j\right)_{j=1,\dots g} \cdot \Omega_2^{-1}$.

Let r be $\min(d,g)$. In the next step, we transform the vanishing of a 2r-2r-minor involving real-analytic functions by the vanishing of a r-r-minor of a related matrix involving only complex-analytic functions on \tilde{S} . In order to do this, we take advantage of the monodromy, using a theorem of linear independence of abelian logarithms with respect to periods [A1, th. 2] (cf. also [A2, $\S1$]).

At the end, we come along with the following translation of the problem (under extra assumptions):

2.2.1. Proposition. (with $S \subset A_{g,n}$). Assume that σ is not contained in a proper sub-group scheme. Then for any $s \in \tilde{S}$, β is an immersion, resp. a submersion (according to whether $d \leq g$ or $g \leq d$) at s if and only if for some $(\lambda_1, \ldots, \lambda_q) \in \mathbb{C}^g$, the matrix

(2.1)
$$((\partial_i L)(s) + \sum_{k=1,\dots,q} \lambda_k (\partial_i Z_{kj})(s))_{i=1,\dots,d, j=1,\dots q}$$

has maximal rank (where the ∂_i form a basis of the tangent space $T_{\tilde{S}}(s)$). This is already the case if for some $(\lambda_1, \ldots, \lambda_g) \in \mathbb{C}^g$, the matrix

(2.2)
$$(\sum_{j=1,\dots,g} \lambda_k(\partial_i Z_{kj})(s))_{i=1,\dots,d,\ j=1,\dots g}$$

has maximal rank.

Proof. ... [your §3.5].

The second assertion follows from the first, putting an arbitrary coefficient λ_0 in front of $(\partial_i L)(s)$ and letting λ_0 tend to 0.

Remark. For d = g, the negation of the conclusion leads to a special case of "Dieudonné's problem", which is notoriously difficult: describe vector spaces of singular matrices Z, resp. singular symmetric matrices, cf. e.g. $[L]^3$.

3. ROLE OF THE KODAIRA-SPENCER MAP.

3.1. We know consider the following condition:

(3.1)

For every s in an dense open affine subset of S, the matrix (2.2) has maximal rank.

We shall translate it in terms of the Kodaira-Spencer map

$$\theta: T_S \otimes \Omega_A \to \Omega_A^{\vee} = \operatorname{Lie} A,$$

where Ω_A denotes the locally free \mathcal{O}_S -module of invariant 1-forms on A. We refer to [A3, 1.4, 2.1] for background about the Kodaira-Spencer map of a polarized abelian scheme A of relative dimension g over a smooth \mathbb{C} -scheme S. For any $\partial \in \Gamma T_S$, we denote by θ_∂ the corresponding map $\Omega_A \to \Omega_A^\vee$, which belongs to $\operatorname{Hom}_{\operatorname{sym}}(\Omega_A, \Omega_A^\vee)$. Let us recall that in terms of the symplectic basis $\omega_1, \ldots, \omega_g, \eta_1, \ldots, \eta_g$, the matrix of θ_∂ is given by the lower left quadrant T_∂ of the Gauss-Manin connection written in the form

$$\partial \begin{pmatrix} \Omega_1 & \mathbf{N}_1 \\ \Omega_2 & \mathbf{N}_2 \end{pmatrix} = \begin{pmatrix} \Omega_1 & \mathbf{N}_1 \\ \Omega_2 & \mathbf{N}_2 \end{pmatrix} \begin{pmatrix} R_{\partial} & S_{\partial} \\ T_{\partial} & U_{\partial} \end{pmatrix},$$

where $R_{\partial}, S_{\partial}, T_{\partial}, U_{\partial} \in M_q(\mathcal{O}(S))$. Moreover T_{∂} is a symmetric matrix.

3.1.1. Lemma. Assume that d = g. Then condition (3.1) is equivalent to:

$$(3.2) \exists \omega \in \Gamma \Omega_A, \ \forall \partial \in \Gamma T_S \setminus 0, \ \theta_{\partial}.\omega \neq 0.$$

Proof. One has

$$\begin{split} \partial Z &= (\partial \Omega_1 - \Omega_1 \Omega_2^{-1} \partial \Omega_2) \Omega_2^{-1} = ((\Omega_1 R_\partial + N_1 T_\partial) - \Omega_1 \Omega_2^{-1} (\Omega_2 R_\partial + N_2 T_\partial)) \Omega_2^{-1} \\ &= (N_1 - \Omega_1 \Omega_2^{-1} N_2) T_\partial \Omega_2^{-1} = -\Omega_2^{-1} ({}^t \Omega_1 N_2 - {}^t \Omega_2 N_1) T_\partial \Omega_2^{-1} = -2\pi i \Omega_2^{-1} T_\partial \Omega_2^{-1}. \end{split}$$
 If $\vec{\mu} = -2\pi i \vec{\lambda} \Omega_2^{-1}$, one has

$$\det(\sum_{k=1,\dots,g} \lambda_k(\partial_i Z_{kj})(s)) = \det(\sum_{k=1,\dots,g} \mu_k(T_{\partial_i})_{kj}(s)) \cdot (\det \Omega_2)^{-1}.$$

Setting $\omega = \sum \mu_k \omega_k$, one has $\sum \mu_k (T_{\partial_i})_{kj} = \theta_{\partial_i}(\omega) \cdot \eta_j$. Thus (3.1) is equivalent to: there is a dense open affine subset $S' \subset S$ such that

$$\forall s \in S'(\mathbb{C}), \exists \omega_s \in \Omega^1(A_s), \forall \partial_s \in T_{S,s} \setminus 0, (\theta(s)_{\partial_s})(\omega_s) \neq 0.$$

It is easy to see that this condition is equivalent in turn to (3.2) (for the direct implication, any ω lifting ω_s for some s will do).

3.2. In [A3], a condition similar to (3.2) is studied (*cf.* [A3, lemma 1.4.5]), where the quantifiers are interchanged:

$$(3.3) \qquad \forall \partial \in \Gamma T_S \setminus 0, \exists \omega \in \Gamma \Omega_A, \ \theta_{\partial}.\omega \neq 0.$$

3.2.1. Theorem. [A3, def. 4.2.1, th. 4.2.2] *In the restricted PE case, condition* (3.3) *is satisfied.*

3.2.2. Lemma. If d = q, (3.2) \Rightarrow (3.3).

Proof. Let $\theta^{\omega}: T_S \to \Omega_A^{\vee}$ the contraction of θ by $\omega \in \Omega_A$. Condition (3.2) is equivalent to the injectivity of θ^{ω} for some ω . Since d=g, this is equivalent to the generic surjectivity of θ^{ω} for some ω , which implies the generic surjectivity of θ , which is in turn equivalent to (3.3).

- **3.2.3. Question.** Does the converse of the lemma holds?
- **3.2.4. Remark.** Let η be the generic point of S and $P(\Omega_{A_{\eta}})$ (resp. $P(T_{\eta})$) be the projective space of lines on $\Omega_{A_{\eta}}$) (resp. T_S). We denote by $\bar{\omega}$ (resp. $\bar{\partial}$) the class of ω in $P(\Omega_{A_{\eta}})$ (resp. ∂ in $P(T_{\eta})$).

One could try to answer the question in general by explaining the "logical seesaw" between quantifiers from (3.3) to (3.2) through a "geometric seesaw" provided by the incidence variety $\Sigma \subset P(\Omega_{A_{\eta}}) \times P(T_{\eta})$ formed by pairs $(\bar{\omega}, \bar{\partial})$ such that $\theta_{\partial} \cdot \omega = 0$, and let p_1, p_2 be the projections on the

factors. Let further $\check{P}_h \subset P(T_\eta)$ be the locally closed subvariety formed by elements $\bar{\partial}$ such that $\theta_{\partial,\eta}$ has rank h. One has

$$p_2(\Sigma) \subset \coprod_{h=1}^{h=g-1} \breve{P}_h \subset P(T_\eta) = \coprod_{h=1}^{h=g} \breve{P}_h,$$

and

$$\dim p_2^{-1}\{\partial\}=g-1-h \ \text{ if } \ \partial\in \breve{P}_h.$$

By (3.3), \check{P}_g is non empty and in fact dense (the condition is open in ∂), hence $\dim p_2(\Sigma) \leq g-2$.

The key problem is whether one has

$$\dim \breve{P}_{h-1} < \dim \breve{P}_h$$

(which is equivalent to $\dim \breve{P}_h \neq \emptyset$ since $\overline{\breve{P}_h} \supset \breve{P}_{h-1}$) for e < h < g, where e is the first index such that $\breve{P}_e \neq \emptyset$.

If so, then dim $\check{P}_h \leq h-1$ and dim $\Sigma \leq g-2$, so p_1 is not dominant, and any $\bar{\omega}$ outside the image of p_1 will do.

We have only partial answers to 3.2.3.

3.2.5. Proposition. *If* $d = g \le 3$, $(3.3) \Rightarrow (3.2)$.

Proof. We use the previous remark: the case $g \leq 2$ is trivial ((3.4) is satisfied). For g=3, $\dim \overline{\check{P}}_2=1$, and it suffices to show that $\overline{\check{P}}_1$ is of dimension 0 or empty. Let us identify $P(T_\eta)$ with a plane in the projective space of $S^2 \mathrm{Lie}\, A_\eta$. Let $\Delta_h \subset P(S^2 \mathrm{Lie}\, A_\eta)$ be the locus of matrices of rank h. Then Δ_1 may be identified with the Veronese surface $V \subset \mathbb{P}^5$, since

its elements are the symmetric matrices of the form
$$\begin{pmatrix} x_0^2 & x_0x_1 & x_0x_2 \\ x_0x_1 & x_1^2 & x_1x_2 \\ x_0x_2 & x_1x_2 & x_2^2 \end{pmatrix},$$

and $P(T_{\eta}) \cap V$ may be identified with \check{P}_1 . It is enough to show that there any plane $P \subset \mathbb{P}^5$ such that $P \cap V$ is a curve is contained in $\overline{\Delta}_2$. Such a plane would be cut by three hyperplanes, which would correspond to three non collinear quadratic forms q_0, q_1, q_2 in x_0, x_1, x_2 . If $P \cap V$ is a curve, then one could choose the q_i 's of the form $\ell.x_i$, where ℓ is a linear form in x_0, x_1, x_2 ; by change of coordinates, ℓ may be taken to be x_0 , and it is then clear that $P \subset \overline{\Delta}_2$.

3.2.6. Proposition. If $\mu(S)$ is a sufficiently general subvariety of dimension g of a special subvariety S_1 of A_g of restricted PEL type (cf. [A3, 4.2.1]), then (3.3) \Rightarrow (3.2).

Proof. Let $D:=\operatorname{End} A_\eta$ (assumed to be a division algebra), E a maximal subfield of D containing F (and chosen to be CM except if D is a totally real field) and E^+ the maximal totally real subfield of E. One has a decomposition $\Omega_A=\oplus_{\nu:E\to\mathbb{C}}\Omega_A\otimes_{E\otimes\mathbb{C},\nu}\mathbb{C}$. Fix $\omega\in\Omega_A$ with non-zero components ω_ν . Fix $s\in S(\mathbb{C})$ such that $\omega_{\nu,s}$ remains non-zero. With the notation of [A3, rem. 4.2.3 i)], the tangent space $T_{S_1,s}$ decomposes as $\oplus_{\nu:E\to\mathbb{C}}T_{S_1,s,\nu}$, and the universal Kodaira-Spencer map on the family of PEL type induces an isomorphism $T_{S_1,s,\nu}\cong S^2\Omega_{A,s,\nu}^\vee$ or $T_{S_1,s,\nu}\cong S^2\Omega_{A,s,\nu}^\vee$ (according to whether D is of type I or II, or of type III or IV). In particular the contraction $(\theta_1^{\omega_\nu})_s:T_{S_1,s,\nu}\to\Omega_{A,s,\nu}^\vee$ is surjective, hence also $(\theta_1^\omega)_s:T_{S_1,s}\to\Omega_{A,s}^\vee$. Since S is sufficiently general in S_1 of dimension S_1 , then S_2 is transverse to the kernel of S_2 on a suitable dense open subset of S_2 [details should be checked].

3.3. A counterexample. We indicate here what seems to be an example with smallest g > 0 of a subvariety (resp. a special subvariety) of dimension d of $\mathcal{A}_{g,n}$ with d = g, such that the restriction of the universal abelian scheme does not satisfy condition (3.3) (hence not (3.1); in this example the Betti map is nowhere a submersion). In fact d = g = 5 (resp. 6).

Let us first treat the modular example. Let E^+ be a real quadratic field and E a totally imaginary quadratic extension fo E^+ . Let $A \to S$ be a principally polarized abelian scheme of relative dimension 6, with level $n \ge 3$ structure, such that $\operatorname{End}_S A = \mathcal{O}_E$, and with Shimura type $(r_\nu, s_\nu) = (1,2), (1,2)$ (for the two embeddings ν_1, ν_2 of E^+ in \mathbb{C}). According to [S], there exists such a family, with base S a special subvariety of dimension $\sum r_\nu \cdot s_\nu = 6$ of $\mathcal{A}_{6,n}$. By functoriality, θ commutes with the \mathcal{O}_L -action, hence respects the decomposition $\mathcal{H}^1_{dR}(A/S) = \bigoplus_{\rho: E \to \mathbb{C}} \mathcal{H}_\rho$. For every ρ , and general ∂ , the restriction of the Kodaira-Spencer map θ_∂ to $(\Omega_A)_\rho$ has rank 1 (either the source or the target is of rank 1), hence θ_∂ has rank 4 < 6.

The non modular example consists in taking a general hypersurface section in a modular example with d=6,g=5. Here E is a quadratic imaginary field, and $\operatorname{End}_S A=\mathcal{O}_E$ with Shimura type (r,s)=(2,3). For each complex embedding ρ of E, the restriction of the Kodaira-Spencer map θ_{∂} to $(\Omega_A)_{\rho}$ has rank 2 (either the source or the target is of rank 2), hence θ_{∂} has rank 4<5.

3.3.1. Remark. It would be interesting to go beyond, and settle (3.2) fro instance in the case of maximal monodromy Sp_{2g} . Let $A \to S$ be the jacobian of the universal hyperelliptic curve of genus g > 0. Here S is the affine space $\mathcal{M}_{0,2g+2} \cong (\mathbb{P}^1 \setminus \{0,1,\infty\})^{2g-1}$. By Torelli's theorem, one has dim $\mu(S) = 2g - 1$. On the other hand, according to [M2, th. 5.6], $\operatorname{End} A_{\bar{\eta}} = \mathbb{Z}$ (in fact, it is knwon that the monodromy representation,

which is a specialization of the Burau representation of the braid group, has Zariski dense image in Sp_{2g} , cf. [aC]). Hence (3.2) whould imply that, after replacing $(\mathbb{P}^1 \setminus \{0,1,\infty\})^{2g-1}$ by a suitable dense Zariski-open affine subset, β is a submersion. [There are explicit calculations (without detail) by Bryant of θ in this case on MathOverflow (tag: hyperelliptic) which should settle the matter]

3.4. Let us turn to the proof of th. 1.4.1. [sketch] One may replace S by a finite etale covering and assume that A/S has a level n structure for some $n \geq 3$, then replace S by a smooth dense affine open subset of its image in $\mathcal{A}_{g,n}$. By assumption, $d = \dim \mu(S) \geq g$. Taking a sufficiently general locally closed affine subvariety $S' \subset S$ of dimension g, the restriction to S' of the abelian scheme and of the section satisfy the same assumption. Moreover, one checks that the condition $d \geq g$ implies that we are in the restricted PE case⁴. Remplacing S by S', one is in the situation d = g. One can then combine prop. 2.2.1, 3.2.5 and th. 3.2.1. [A similar deduction holds with prop. 3.2.6 in place of 3.2.5].
