- 51 Abstract
- Fire is a crucial event regulating the structure and functioning of many ecosystems. Yet few studies have focused on how fire affects taxonomic and functional diversity of soil microbial communities, along with changes in plant communities and soil carbon (C) and nitrogen (N) dynamics. Here, we analyze these effects in a grassland ecosystem nine-months after an experimental fire at the Jasper Ridge Global Change Experiment (JRGCE) site in California, USA. Fire altered soil microbial communities

considerably, with community assembly process analysis showing that environmental 58 selection pressure was higher in burned sites. However, a small subset of highly 59 connected taxa were able to withstand the disturbance. In addition, fire decreased the 60 relative abundances of most functional genes associated with C degradation and N 61 cycling, implicating a slow-down of microbial processes linked to soil C and N 62 dynamics. In contrast, fire stimulated above- and below-ground plant growth, likely 63 enhancing plant-microbe competition for soil inorganic N, which was reduced by a 64 factor of about 2. To synthesize those findings, we performed structural equation 65 modeling, which showed that plants but not microbial communities were responsible 66 for significantly higher soil respiration rates in burned sites. Together, our results 67 demonstrate that fire "reboots" the grassland ecosystem by differentially regulating 68 plant and soil microbial communities, leading to significant changes in soil C and N 69 dynamics. 70

71 Introduction

Anthropogenic activities, and in particular changes in land use and management, 72 have considerably altered fire regimes (Andersson, Michelsen, Jensen, & Kjøller, 73 2004). Climate change is likely to also affect fire regimes because antecedent wet 74 75 periods could provide herbaceous fuels for fire, while drought and warming could extend weather patterns that are conducive to fire (Bowman et al., 2009). As a 76 consequence, recent years have witnessed increased fire frequencies in many areas, 77 and it is anticipated that fire frequency and intensity will further increase in the coming 78 century (Westerling, Hidalgo, Cayan, & Swetnam, 2006). It is likely that fire in 79 California would burn more rapidly, with higher intensity, under warmer climate 80 scenarios (Fried, Torn, & Mills, 2004). 81

Fire affects plant diversity by increasing resource availability for subordinate and 82 early-successional species (Pickett, White, & Brokaw, 1985). Fire also has a 83 short-term stimulatory effect on N availability to plants but a long-term negative effect 84 due to increased N losses (Reich, Peterson, Wedin, & Wrage, 2001). Fire can 85 stimulate fine root production and aboveground net primary production in the first 86 post-fire growing season in grasslands (Docherty, Balser, Bohannan, & Gutknecht, 87 2011; Strong, Johnson, Chiariello, & Field, 2017). Changes in aboveground 88 communities could indirectly affect belowground systems via altering nutrient inputs, 89 increasing solar warming and surface soil temperatures, 90 and changing evapotranspiration and soil moisture (Hart, DeLuca, Newman, MacKenzie, & Boyle, 91 This article is protected by copyright. 2005; Strong et al., 2017). Fire can also induce higher greenhouse gases emissions, 92 including CO₂ (Strong et al., 2017) and N₂O (Niboyet et al., 2011). Responses of soil 93 C dynamics to fire vary between ecosystems. For instance, soil respiration was 94 stimulated shortly after fire and then decreased in a tropical savanna woodland 95 (Andersson et al., 2004) and a permafrost forest (Tas et al., 2014), but CO₂ efflux 96 rates decreased after fire in a ponderosa pine forest (Sullivan et al., 2010) and an arid 97 grassland (Vargas et al., 2012). In a grassland ecosystem, three mechanisms -98 increases in soil temperature, fine root production and aboveground net primary 99 100 production – were shown to explain changes in soil respiration rates post fire (Strong et al., 2017). 101

Fire plays an important role in structuring and altering underground microbial 102 communities. Fire can directly kill microbes by heating the soil upper layer (Delmas et 103 al. 1995) and indirectly affect microbial community composition by altering plant 104 community composition and plant-driven organic matter inputs to soil (Docherty et al., 105 2011; Hart et al., 2005), as well as soil environmental conditions. In boreal forests, fire 106 decreased microbial biomass and dissolved organic C in surface organic horizons 107 five years post fire (Waldrop & Harden, 2008). In contrast, fire stimulated microbial 108 109 growth by increasing soil ammonium (NH₄⁺) and dissolved organic C concentrations by 20 - 52% in a tropical savannah woodland (Andersson et al., 2004). However, 110 microbial N immobilization and plant N uptake were reduced by fire. In grasslands, 111 enzyme activities related to C degradation and P cycling decreased, the effect being 112 mild in the first growing season after fire, higher in the second growing season after 113 fire, but subsidizing in the third growing season after fire (Gutknecht, Henry, & Balser, 114 2010). In contrast, microbial enzyme activities related to organic N degradation have 115 been shown to either decrease (Gutknecht et al., 2010) or increase (Ajwa, Dell, & 116 Rice, 1999), after fire, likely due to site specific differences. As fire could strongly 117 affect soil nutrients, responses of microbial functional groups to pulse increases of 118 nutrient availability could cause long-term changes in ecosystem. For example, fire 119 significantly decreased soil microbial biomass and changed compositions of 120 nitrogen-fixing and ammonia-oxidizing communities in a mixed conifer forest, linking 121 to fire-related increases in soil NH4⁺ or soil pH (Yeager, Northup, Grow, Barns, & 122 Kuske, 2005). This can change nitrification rates, NO and N₂O flux in post-fire 123 ecosystems (Serça et al., 1998). Overall, some inconsistencies among fire effects on 124 soil N processes have been reported, which reflects differences in soil type, fire 125 This article is protected by copyright. intensity, vegetation type and the timing of measurements after fire.

Microbe-mediated soil bioprocesses are considered to be one of the important 127 drivers of ecosystem recovery from fire (Neary, Klopatek, DeBano, & Ffolliott, 1999). 128 Although many studies have investigated the responses of below- and above-ground 129 communities to fire in grasslands, studies examining the fire effects on soil microbes 130 have largely focused on microbial population sizes and microbial activity (Ajwa et al., 131 1999; Andersson et al., 2004; Gutknecht et al., 2010; Waldrop & Harden, 2008; 132 Yeager et al., 2005). In contrast, how fire affects the total soil microbial community 133 composition largely remains to be studied in grassland ecosystems, and it is unclear 134 which assembly processes control post-fire microbial community dynamics. Moreover, 135 it is needed to analyze fire effects not only on the taxonomic diversity of soil microbial 136 community, but also on its functional diversity, particularly the range of microbial 137 functional groups linked to soil C and N dynamics, is required to expand our 138 understanding of the effects of fire on soil function in grassland ecosystems. 139

Here, we studied fire effects in an annual Mediterranean grassland in California, 140 USA, as part of the long-term Jasper Ridge Global Change Experiment (JRGCE) 141 (Henry, Juarez, Field, & Vitousek, 2005). In particular, we examined fire effects on the 142 soil microbial community nine months after the prescribed burn in July 2011. We used 143 bacterial 16S rRNA gene amplicon sequencing (Illumina MiSeq) and functional gene 144 array (GeoChip 4.6) analyses to examine the effects of fire on the taxonomic and 145 functional diversities of soil microbial communities. These techniques allow for 146 high-resolution profiling of community composition for both facets of microbial 147 diversity. We also examined whether the fire would had cascading effects on 148 ecosystem functioning such as soil CO₂ efflux. 149

Given that fire typically increases soil C and N inputs, we hypothesized that there 150 would be a shift of microbial taxonomic composition, and more particularly that 151 functional genes associated with labile C degradation would be stimulated, leading to 152 higher soil CO₂ efflux. Since previous results at our study site showed that fire 153 significantly increased soil NH₄⁺ concentrations (Docherty et al., 2011) in the first 154 growing season post 2003 fire, and soil N₂O emission (Niboyet et al., 2011) in the 155 second and third growing seasons after a 2003 fire, we also hypothesized that 156 functional microbial groups associated with N cycling would be stimulated. 157

159 Materials and methods

160 Site description

The Californian annual grassland ecosystem experiences a Mediterranean-type 161 climate, in which the growing season is cool and wet from November to May, and the 162 rest of the year is hot and dry. The plant community comprises non-native annual 163 grasses, perennial native grasses, native annual forbs and non-native forbs (Henry et 164 al., 2005). Soil mainly consists of weathered alluvium, which is a fine and mixed Typic 165 Haploxeralf. This experiment was initiated in October 1998 at the Jasper Ridge 166 Global Change Experiment (JRGCE) site located in central California, USA (37°24'N, 167 122°13'W). Initially, the JRGCE was designed to assess grassland ecosystem 168 responses to single and multiple components of global changes, including elevated 169 CO₂, warming, N deposition, and enhanced precipitation. To this end, each 2 170 m-diameter circular plot at the JRGCE was equally divided into four quadrants (i.e., 171 subplots) of 0.78 m². N deposition and enhanced precipitation treatments were 172 arranged at the guadrant level, and the elevated CO₂ and warming treatments were 173 arranged at the plot level in a full factorial design. In the summer of 2003, an 174 accidental wildfire burned two of the eight blocks of the experiment (i.e. 32 of the 128 175 subplots). In the summer of 2011, a controlled fire was applied to four of the eight 176 177 blocks (i.e. 64 of the 128 subplots including the subplots that were already burned in 2003). Soil samples were collected on 26 and 27 April 2012, i.e. 9 months post fire 178 and 14 years after the experiment began. We collected one soil core with 5 cm 179 diameter x 7 cm deep per quadrant to generate each of 64 unburned and 64 burned 180 samples. We thoroughly mixed each sample and sieved soil through a 2 mm mesh. 181 Those soil samples were stored at -80°C prior to DNA extraction or at -20°C prior to 182 soil geochemical measurements. 183

185 DNA extraction, purification and quantification

DNA was extracted from 5 g of soil samples with a freeze-grinding mechanical lysis 186 method (Zhou, Bruns, & Tiedje, 1996). DNA was purified by gel electrophoresis with a 187 0.5% low-melting-point agarose, then extracted with phenol and chloroform and 188 finally precipitated with butanol. DNA quality was assessed by ratios of light 189 absorbance at A₂₆₀/A₂₈₀ (>1.8) and A₂₆₀/A₂₃₀ (>1.7), using a Nanodrop (NanoDrop 190 Technologies Inv., Wilmington, DE, USA). The final DNA concentration was 191 quantified using a PicoGreen® method using a FLUOstar Optima microplate reader 192 (BMG Labtech, Jena, Germany) (S. Liu et al., 2015). 193

195 16S rRNA amplicon sequencing and raw data processing

A PCR amplification targeting the V4 hypervariable region of 16S rRNA genes was 196 carried out to examine the bacterial community diversity, using the primers F515 197 (5'GTGCCAGCMGCCGCGG3') and R806 (3'TAATCTWTGGGVHCATCAG5'). The 198 PCR products were sequenced by 2x250 bp paired-end sequencing with MiSeq 199 instrument (Illumina, San Diego, CA, USA). Raw sequence data were processed on 200 the Galaxy platform (http://zhoulab5.rccc.ou.edu:8080). The paired-end raw 201 202 sequences were demultiplexed to remove PhiX sequences and then sorted to appropriate samples based on paired barcodes. These sequences were then 203 trimmed with Btrim based on quality scores and paired-end reads were combined 204 with FLASH into full-length sequences (Magoc & Salzberg, 2011). Sequences less 205 than 200 bp or containing ambiguous bases were removed and chimeric sequences 206 were discarded based on prediction by Uchime using the reference database mode. 207 Operational taxonomic units (OTUs) were clustered at the 0.97 identity level by 208 UCLUST (R.C. Edgar, 2010; R. C. Edgar, Haas, Clemente, Quince, & Knight, 2011). 209 Taxonomic annotation was assigned to OTUs based on representative sequences 210 211 with RDP's 16S Classifier. The number of sequences retrieved from each sample might differ, and this reflects different efficiency of the sequencing process rather than 212 actual biological variation (Weiss et al., 2017). We thus standardized the number of 213 sequences across samples. 214

216 GeoChip hybridization and raw data processing

To study functional genes of bacterial, archaeal and fungal communities, DNA 217 hybridization with GeoChip 4.6 was carried out as previously described (Y. Yang et al., 218 2013). Microbial DNA extracted from soil was labeled with Cy-3 fluorescent dye using 219 random priming method, and then purified with a DNA purification kit (Qiagen, 220 Valencia, CA, USA). After drying at 45°C with SpeedVac (ThermoSavant, Milford, MA, 221 USA), labeled DNA was hybridized to GeoChip 4.6 at 42°C for 16 h in a MAUI 222 hybridization system (BioMicro, Salt Lake City, UT, USA). After washing the slides 223 with buffers provided by NimbleGen, the hybridized DNA was scanned using a 224 NimbleGen MS 200 Microarray Scanner (Roche, Basel, Switzerland). 225

Raw GeoChip data were processed as follows: (i) remove the spots with a
 signal-to-noise ratio (SNR) less than 2.0; (ii) perform log-transformation on the signal

intensity for each gene and divide them by the mean intensity in the sample; and (iii)
 remove genes detected only in one out of the four replicates from the same
 treatment.

232 Soil abiotic measurements

To characterize the microclimate of the soil where samples were taken, soil 233 temperature at the depth of 2 cm was measured hourly during 2012 with in situ 234 thermocouples. The average values measured during April, 2012, (the month when 235 soils were sampled), were calculated. One soil core (5 cm diameter x 7 cm deep) per 236 quadrant was sampled and stored at -20°C prior to soil abiotic measurements. Soil 237 moisture was measured by drying 10 g of freshly collected soil at 105°C for one week. 238 Soil pH was measured using 5 g of soil dissolved in distilled water. Soil ammonium 239 (NH_4^+) and nitrate (NO_3^-) concentrations were measured by suspending 5 g of soil in 240 a 2 M KCI solution, filtering the extracts, and analyzing them colorimetrically using a 241 SEAL Automated Segmented Flow analyzer in the Loyola University, Chicago, IL, 242 USA. Soil CO₂ efflux of each sample was measured three times by a closed-chamber 243 method in April 2012 as previously described (Strong et al., 2017), where a LiCOR 244 LI-6400 portable photosynthesis system and LI6400-09 Soil Flux Chamber (LiCOR, 245 Lincoln, NE, USA) were used. 246

248 Vegetation variable measurements

Aboveground plant biomass was collected from 141 cm² of each quadrant on the sampling in April 2012. Individual plant species were separated into functional groups (annual grasses, perennial grasses, annual forbs, perennial forbs, and litter), and the biomass was oven-dried at 70°C and weighed. Root biomass was estimated by separating roots from two soil cores (2.5 cm diameter by 15 cm depth) from the same area of the aboveground biomass collection, and the root biomass was oven-dried at 70°C and weighed.

257 Statistical analyses

Unpaired *t*-tests were used to determine fire effects on relative abundances of microbial taxa, functional genes and soil and vegetation variables. *P* values were adjusted by the Benjamini-Hochberg method with sequentially modified Bonferroni Correction, using the p.adjust function in the vegan package in R version 3.5.0. Permutational multivariate ANOVA (PERMANOVA) was implemented to rank global 262 change drivers of the composition of environmental variables, using adonis function in 263 the vegan package. Analysis of variance (ANOVA) was performed to rank global 264 change drivers of each environmental variable, using aov function in the vegan 265 package. Three nonparametric dissimilarity tests (Multi-response permutation 266 procedure (mrpp), Analysis of similarities (anosim) and Permutational multivariate 267 analysis of Variance (adonis) in the vegan package in R) were used to compare 268 differences of microbial community composition. Shannon Index (H') was used to 269 270 calculate the α -diversity of the microbial community in the unburned and burned plots, using the alpha g function in the leggr package in R. 271

Microbial community assembly could be shaped by interspecies competition for 272 resources and cooperative interactions (Zelezniak et al., 2015). Metabolically 273 interdependent microbial groups are strongly coupled through mutualistic interactions 274 which support species growth: thus these groups form persistent sub-networks within 275 the soil microbial communities (Zelezniak et al., 2015). Such high degree of 276 connectivity among keystone taxa can dampen soil microbial compositional changes 277 in response to environmental changes and disturbances (Herren & McMahon, 2018; 278 279 Zelezniak et al., 2015). Therefore, we used linear mixed model to examine whether the connectivity among keystone taxa, measured by cohesion metrics, could explain 280 microbial compositional changes. Cohesion metrics measure the instantaneous 281 connectivity of a microbial community and contain two metrics showing the strength 282 of positive and negative relationships between taxa. Bray-Curtis dissimilarity was 283 used to measure community compositional changes at OTUs level. The regression 284 analysis using the most highly connected taxa was conducted to examine the 285 relationship between Bray-Curtis dissimilarity and cohesion metrics. The R² of each 286 model was recorded. Highly connected taxa would be better predictors of the whole 287 bacterial community than randomly selected taxa since the former has 288 disproportionate influence in determining bacterial community dynamics. Regression 289 analyses using random subsets of taxa were repeated 500 times to generate a 290 distribution of model R². We compared the R² value of a model using the most highly 291 connected taxa with that of models using random taxa: if the former is higher than the 292 95th percentile of the latter, then the model using the most highly connected taxa was 293 considered to be significantly different from the model using random taxa, suggesting 294 that interactions among keystone taxa indeed have an important role regarding 295 This article is protected by copyright. 296 compositional changes of the bacterial community. In addition, we used the pnull 297 function in the ieggr package in R to calculate the β -nearest taxon index (β NTI), 298 which measures the degree to which microbial community composition is governed 299 by environmental filtering based on OTUs' ecological niches (Stegen et al., 2013).

Using the psem function in the piecewiseSEM package in R, structural equation 300 models (SEM) were also fitted to calculate the direct and indirect effects of soil 301 variables, soil microbial community composition and plant biomass on soil CO₂ efflux 302 rates. Model fits were measured by a non-significant Shipley's test of d-separation, 303 304 with Fisher's P > 0.05 indicating that no paths were missing, and low Akaike information criterion (AIC) being used to choose among competing models (Jing et al., 305 2015). The first principal components (PCo1) of microbial taxonomic community were 306 used to represent the microbial community composition, using the pco function in the 307 vegan package in R. 308

310 **Results**

The fire impact on the soil bacterial community did not vary largely across different 311 levels of CO₂, nitrogen deposition, warming and precipitation (Table S1). Furthermore, 312 313 of over 26 possible interactive effects tested between fire and other global climate changes, only one was statistically significant - the interaction between fire and 314 nitrogen deposition on soil nitrate concentration (Table S2 & S3). Since the 315 responses to fire across the sixteen factorial combinations of CO₂, nitrogen 316 deposition, warming and precipitation (n=64) were similar to those for fire as a sole 317 treatment (n=4) (Table S1), data were pooled across all the other treatment levels 318 following a previous example (Reich et al., 2006). The n=64 samples increased the 319 statistical power and identified trends valid across the range of climate change 320 scenarios tested at the Jasper Ridge Global Change Experiment. 321

323 Changes of taxonomic composition of bacterial communities by fire

A total of 8,882,825 sequences were obtained, ranging from 29,275 to 92,183 reads per sample. After re-sampling with 29,275 sequences per sample, 87,275 operational taxonomic units (OTUs) were obtained. Singletons were removed, which might represent inherently unreplicated data possibly resulting from sequencing errors (Dickie, 2010), leading to a total of 64,515 OTUs. Using three non-parametric statistical analyses (Anosim, Adonis, and MRPP), we found that fire significantly This article is protected by copyright. All rights reserved

changed taxonomic composition ($P \le 0.003$ for all three methods, Table 1). However, 330 the α -diversity of the bacterial community, based on Shannon index, was similar 331 between the unburned (8.16 \pm 0.02) and burned (8.24 \pm 0.02) sites (P = 0.270). 4,503 332 unique OTUs were detected in unburned plots, and 6,744 unique OTUs in burned 333 plots, while 53,268 OTUs were found in both plots (Fig. S1a). The relative abundance 334 of *Proteobacteria* was significantly higher in burned plots (P = 0.047), while the 335 relative abundances of Planctomycetes (P = 0.047), OD1 (P = 0.009), Chlorobi (P = 336 0.009), OP11 (P = 0.007) and Spirochaetes (P = 0.006) were significantly lower in 337 burned plots (Fig. S1b). At finer taxonomic levels, relative abundances of 19 genera 338 (such as Agromyces, Ferruginibacter and Pasteuria) were significantly decreased, 339 whereas those of 16 genera (such as Actinoplanes, Bdellovibrio and Flavisolibacter) 340 were significantly increased (Table S4). 341

Cohesion metrics were significant predictors of compositional changes in burned 342 sites (P = 0.017 and P < 0.001) (Table S5), with both the negative and positive 343 cohesion metrics related to the compositional changes (P < 0.001) (Fig. S2). The R² 344 values of models using the most highly connected taxa remained unchanged when 345 the least-connected taxa were removed, whereas the R² values of models containing 346 random subsets of taxa decreased when more taxa were removed (Fig. 1a). The 347 explanatory power of these models increased to 13% when a small subset (46) of 348 highly connected taxa was used to calculate the cohesion metrics, suggesting that 349 biotic interactions among taxa could partially explain the community compositional 350 change. These keystone taxa included 13 genera from Proteobacteria (such as 351 Rudaea, Bauldia and Microvirga), 9 genera from Acidobacteria (Gp1-Gp7, Gp16 and 352 Gp17), 6 genera from Actinobacteria (such as Rugosimonospora, Catenulispora and 353 Agromyces), 6 genera from Bacteroidetes (sucha as Terrimonas, Adhaeribacter and 354 Ferruginibacter), 4 genera from Planctomycetes (Gemmata, Planctomyces, 355 Singulisphaera and Isosphaera), and 7 genera from Armatimonadetes, Chloroflexi, 356 Firmicutes, Verrucomicrobia and WS3 (Table S6). 357

In burned sites, the models with highly connected taxa showed significantly higher performance than those with randomly selected taxa (Fig. 1a). As the negative cohesion was a better predictor of compositional changes of the bacterial community than positive cohesion (Fig. S2), we focused on 46 genera showing the strongest negative associations with others. Among them, 7 genera of *Gp5* (P = 0.039), *Agromyces* (P = 0.010), *Ferruginibacter* (P = 0.039), *Pasteuria* (P = 0.001), This article is protected by copyright. All rights reserved

Planctomyces (P = 0.001), *Isosphaera* (P = 0.041) and *Verrucomicrobium* (P < 0.001) 364 decreased in relative abundances compared to control (Fig. S3). Many of those highly 365 connected genera had low relative abundances. For example, Rudaea was the 9th 366 most connected genus but its relative abundance ranked only the 144th among all the 367 genera, with a mean relative abundance across all treatments of 0.03% (Table S6). In 368 unburned sites, the explanatory power of models constructed using either randomly 369 selected or most connected taxa remained very low (< 2%, Fig. 1a), suggesting that 370 there was no keystone taxa effect in the unburned sites. 371

The β -nearest taxon index (β NTI), indicating the degree to which bacterial community composition is governed by environmental filtering, increased from 3.28 ± 0.025 in unburned plots to 3.74 ± 0.027 in burned plots (P < 0.001) (Fig. 1b), suggesting that the bacterial community was more strongly governed by environmental filtering in burned plots.

378 Changes of microbial functional potentials by fire

A total of 68,695 microbial functional genes were detected by GeoChip. Fire caused significant changes in the overall functional composition of soil microbial communities according to the three non-parametric statistical analyses conducted (P < 0.001) (Table 1) and significantly decreased microbial functional α -diversity.

For functional genes associated with C degradation, the signals detected (hereafter called relative abundances) for 16 relevant genes all declined in response to fire (see Fig. 2). In contrast, only *camDCAB* had higher abundances for burned compared to unburned plots. For methane cycling, the abundances of the *mcrA* gene related to methanogenesis and *mmoX* genes related to methane oxidation decreased in burned sites (Fig. S4). Other methane-oxidation genes (*pmoA* and *hdrB*) remained unchanged.

Similar to C cycling genes, a number of N cycling genes also declined in response to fire (see Fig. 3). In contrast, the abundances of the two genes *nifH* and *amoA* were not significantly altered by fire (Fig. 3). The P cycling genes encoding phytase, polyphosphate kinase (*ppk*) and exopolyphosphatase (*ppx*) also decreased in response to fire (Fig. S5).

396 *Fire influence on soil and vegetation variables*

After nine months post fire, aboveground plant biomass (+25.8%, P = 0.034) and This article is protected by copyright. All rights reserved belowground biomass increased (+24.6%, P = 0.080) but litter mass decreased (-86.6%, P < 0.001) (Table S7). Soil temperature also increased (+1°C, P < 0.001) (Table S7). Soil NO₃⁻ decreased from 346 mg L⁻¹ to 189 mg L⁻¹ (P = 0.029), and soil NH₄⁺ from 834 mg L⁻¹ to 389 mg L⁻¹ (P = 0.034) (Table S7). Soil CO₂ efflux significantly increased in the burned plots (+ 37.1%, P < 0.001) (Table S7). Other soil variables such as soil moisture, pH and TN remained unchanged by fire (Table S7).

405 Drivers of changes in soil functioning and bacterial communities

In the unburned sites, soil CO₂ efflux was correlated to root biomass ($\beta = 0.436$, P = 0.003) and to a similar extent to bacterial community composition ($\beta = 0.421$, P = 0.006) (Fig. 4a). In contrast, soil CO₂ efflux in burned sites was only and strongly correlated to root biomass ($\beta = 0.936$, P = 0.044, Fig. 4b). In these burned sites, bacterial community composition was related to aboveground plant biomass ($\beta = 0.205$, P = 0.011) and soil moisture ($\beta = 0.171$, P = 0.043), though soil pH ($\beta = 0.610$, P < 0.001) had stronger effects on microbial community (Fig. 4b).

414 **Discussion**

Fire significantly altered the taxonomic composition of the bacterial community. The 415 change could be predicted by cohesion metrics revealing the existence of 'keystone' 416 taxa, which exert disproportionate influence on community composition through 417 strong biotic interactions (Herren & McMahon, 2018). Biotic interactions can include 418 metabolite exchanges among taxa, which enhances self-reinforcing modules within 419 microbial communities that can stabilize community composition (Levy & Borenstein, 420 2013). More particularly, stronger negative cohesion was related to lower levels of 421 compositional change in the burned sites (Table S5). Those strong negative cohesion 422 values represented the negative feedback loops formed by biotic interactions among 423 taxa, which had an important role in stabilizing community composition and mitigating 424 the effects of fire. Similar results were reported for other environmental disturbances 425 (Coyte, Schluter, & Foster, 2015; Konopka, Lindemann, & Fredrickson, 2015). This is 426 also consistent with recent studies reporting that negative interactions among taxa, 427 such as competition and predation, prevail in microbial communities (Herren & 428 McMahon, 2018). For instance, a previous study focusing on bacterial strains isolated 429 from a rainwater pool showed that negative interactions accounted for a great 430 majority of pairwise taxa interactions, owing to potential resource competition among 431 This article is protected by copyright. microbes (Foster & Bell, 2012). Since microbial diversity is typically high, investing in
positive interactions often specific to a few other species could bring little evolutionary
benefit, which may explain the dominance of negative interactions (Foster & Bell,
2012).

Higher BNTI values in burned sites indicated more phylogenetically clustered 436 bacterial assemblages than expected by chance and suggested that fire increased 437 the relative influence of deterministic environmental filtering for shaping bacterial 438 communities (S. Yang et al., 2017). This result leads us to propose an explanation to 439 440 the observed decreased microbial functional potentials, especially those related to C degradation and N cycling. As fire stimulated above- and below-ground plant growth, 441 plant-bacterial competition for soil inorganic N might be enhanced, possibly imposing 442 higher deterministic environmental filtering on bacterial communities. This would 443 explain the higher βNTI values and is consistent with previous works on microbial 444 assemblages in salt marsh, desert, agricultural fields, aguatic and forest ecosystems 445 (Caruso et al., 2011; Dini-Andreote, Stegen, van Elsas, & Salles, 2015; Mendes, 446 Kuramae, Navarrete, van Veen, & Tsai, 2014; Wang et al., 2013; S. Yang et al., 2017). 447 In particular, Jurburg et al. (2017) reported that a heat disturbance imposed a strong 448 selective pressure on the community composition of active soil bacteria. In this case, 449 phylogenetic turnover patterns indicated that the community experienced stronger 450 deterministic selection during recovery post heat shock. Overall, significantly 451 increased BNTI values suggested higher deterministic environmental filtering on soil 452 bacterial communities following fire and provided an insight into the mechanisms 453 structuring community composition. 454

In sharp contrast to higher above- and belowground plant biomass in response to 455 fire (Table S7), most of the microbial genes related to C degradation were 456 significantly decreased (Fig. 2). Among all the 16,326 C degradation genes detected 457 in our study, 1.9% were archaeal genes, 14.7% were fungal genes and 83.3% were 458 bacterial genes. Archaeal, fungal and bacterial C degradation genes were affected by 459 fire to similar extent, approximately one-third of each category being significantly 460 changed. Fire largely consumed the standing dead plant biomass, which likely 461 explains that litter mass was reduced by 86.6% in burned plots (Table S7). In the 462 unburned plots, litter mass was probably not only comprised of dead biomass 463 produced in the nine months period since fire but also from a longer time frame. 464 Therefore, it is likely that the decrease in microbial C degradation genes in burned 465 This article is protected by copyright. plots was driven by a strong decrease in both fresh and old aboveground plant 466 material inputs to soil. Consistently, there was significant decrease in the relative 467 abundance of the amyX and glucoamylase genes associated with degradation of 468 labile C in burned plots. The reduced access to labile C by microbial communities 469 could be aggravated by the formation of severely or partly charred plant necromass 470 (i.e., charcoal) by fire, which effectively absorbs soil organic C, especially plant root 471 exudates (MacKenzie & DeLuca, 2006). Charcoal has indeed a polycyclic aromatic 472 structure that makes it chemically and biologically stable (Hart et al., 2005). However, 473 474 we also observed decreases in the abundances of genes related to the degradation of chemically recalcitrant C, i.e., chitin and lignin (Fig. 2). Several mechanisms could 475 offer explanations. First, absorbed soil organic C can block charcoal pores, 476 preventing degradation of the charcoal surface by microbial enzymes as well as 477 desorption of charcoal components into the solution (Zimmerman, Gao, & Ahn, 2011). 478 Consistently, grass charcoal showed a negative priming effect in soil with low organic 479 matter, reducing C mineralization rates (Zimmerman et al., 2011). Second, charred C 480 is more resistant to degradation owing to the formation of mineral-organic aggregates 481 (Czimczik, Preston, Schmidt, & Schulze, 2003; Jastrow, Amonette, & Bailey, 2006). 482 483 Third, charcoal contains many toxic substances, such as dioxins, furans, phenols and ethylene, that reduce microbial activities, allowing charred C to reside in soil for a long 484 time (Zimmerman et al., 2011). 485

However, we observed an increase of soil CO₂ efflux by 37% (Table S7), which 486 was similar to the observation after the 2003 fire at the JRGCE during the second and 487 third growing seasons post fire (Niboyet et al. 2011). Post-fire increases of soil CO₂ 488 efflux ranging from 10% to 33% were observed in many grassland systems (Knapp, 489 Conard, & Blair, 1998; Munoz-Rojas, Lewandrowski, Erickson, Dixon, & Merritt, 2016; 490 Xu & Wan, 2008). In our grassland, this effect was attributed to increased plant root 491 biomass (Fig. 4b), consistent with previous studies indicating that plants mediated the 492 increased CO₂ efflux post-fire in grassland ecosystems (Strong et al., 2017; Xu & 493 Wan, 2008). This could be attributed to reduced early season shading by litter 494 removal, and to a fertilization effect as litter combustion increased N and P inputs to 495 soil (Henry, Chiariello, Vitousek, Mooney, & Field, 2006). Increased respiration rates 496 from the increased root biomass and higher soil temperatures in the burned plots 497 could also contribute to this plant-mediated mechanism (Strong et al., 2017). 498 Alternatively, increased CO₂ efflux can be attributed to increased soil moisture 499 This article is protected by copyright. 500 (Knapp et al., 1998; Munoz-Rojas et al., 2016; Xu & Wan, 2008), though it could be 501 more important in the short than medium and long terms. In contrast, when soil 502 moisture was limited during the warm growing season, Vargas et al. (2012) also 503 found that soil CO_2 efflux rates in an arid grasslands decreased by nearly 70% in 504 2-year post fire.

Bacterial community composition, as represented by the first principal component 505 of bacterial community, was not significantly correlated with changes of soil 506 respiration in burned sites (Fig. 4b), reflecting a decreased microbial C degradation 507 potential (Fig. 2). In contrast, soil bacterial community composition was significantly 508 correlated with plant aboveground biomass in burned sites (Fig. 4b). Similarly, a 509 previous study found that plant aboveground biomass and the flux of C assimilated to 510 roots drove both microbial community composition and soil respiration (Litton, Ryan, 511 Knight, & Stahl, 2003). The apparent lack of stimulated degradation of older soil C by 512 microbial community, as shown by decreased soil C degradation potentials (Fig. 2), 513 suggests that there is a negative feedback to stabilize recalcitrant C after fire. 514

Fire is a strong controller of soil mineral N availability and plant community in 515 semi-arid grassland ecosystems. At the JRGCE, the 2003 fire increased soil NH₄⁺ 516 517 concentration (Docherty et al., 2011) but decreased the N:P ratio of plant tissue (Henry et al., 2006) in the first growing season post fire. At the second year after the 518 2003 fire, there was a significant decrease of soil NH_4^+ concentration, as well as a 519 decreasing trend of gross N mineralization rates (Niboyet et al., 2011). We found that 520 the 2011 fire significantly decreased both soil NH₄⁺ and NO₃⁻ concentrations (Table 521 S7). Due to the low microbial activity and removal of aboveground plants, leaching 522 likely occurred during the rainfalls after fire, leading to a substantial loss of inorganic 523 N. In accordance, C. L. Turner, Blair, Schartz, and Neel (1997) showed that fire 524 reduced soil net N mineralization rates. In contrast, total plant production nine months 525 after the 2003 fire also increased in the burned plots supplied with nitrate (Henry et al. 526 2006), while 33 months after the 2003 fire, aboveground and belowground plant 527 biomasses were indistinguishable between the unburned and burned plots (Docherty 528 et al., 2011). Both aboveground and belowground plant biomasses were increased by 529 fire (Table S7). Therefore, the stimulatory effects of fire on plant biomass, possibly 530 through the elimination of detrital shading and increase of soil temperature (Table S7), 531 can offset the negative effects derived from reduced N supply. Our results suggest 532 that post-fire controls of soil N cycling and plant biomass may operate independently, 533 This article is protected by copyright. All rights reserved

leading to a large decoupling between an increased plant growth and decreased N
cycling and availability in burned grasslands (Reich et al., 2001; C. L. Turner et al.,
1997).

Many microbial genes related to N cycling were decreased in response to fire, 537 which was likely due to the substantial decrease of litter biomass (from 166 to 22 g/m²) 538 and might also explain the reduced soil net N mineralization rate often observed post 539 fire (Reich et al., 2001; C. L. Turner et al., 1997). Consistent with decreased soil 540 mineralization rates in burned northern forest ecosystems (Smithwick, Turner, Mack, 541 542 & Chapin, 2005), we found that *ureC* –which is related to ammonification– was decreased (Fig. 3). Although the pyrolysis of organic matter and the deposition of N in 543 ash may have led to a short-lived pulse of soil NH_4^+ after fire (Smithwick et al., 2005), 544 microbial genes related to N cycling tended to decrease in the longer term. For 545 example, the relative abundances of genes associated with denitrification (e.g., nirS 546 and *nosZ*) and dissimilatory nitrite reductase decreased steadily throughout several 547 years post fire (Cobo-Diaz et al., 2015; X. Liu et al., 2013), which was attributed to 548 reduced soil moisture and availability of C and N substrates (X. Liu et al., 2013; 549 Smithwick et al., 2005). However, almost three years after the 2003 fire disturbance, 550 551 soil N₂O efflux and denitrifying enzyme activity remained higher in our burned plots (Niboyet et al., 2011). This inconsistency might be caused by different sampling time 552 after fire disturbance. 553

Although fire did not change the abundance of amoA gene associated with 554 nitrification, the abundance of hao gene -also associated with nitrification- was 555 significantly decreased by 7.2% (Fig. 3), which was concomitant with lower soil NH₄⁺ 556 concentration (Table S7). Several mechanisms might contribute to those results. First, 557 increased soil temperatures could stimulate NH₄⁺ to volatilize into atmosphere 558 (Romanyà, Casals, & Vallejo, 2001). Indeed, fire caused a loss of 10-40 kg N ha⁻¹ yr⁻¹ 559 across a forest-grassland continuum by volatilization (Reich et al., 2001). Second, 560 nitrification may be inhibited by charcoal (M. G. Turner, Smithwick, Metzger, Tinker, & 561 Romme, 2007). Third, soil P could affect the competition between nitrifiers and other 562 soil organisms. Although we did not measure the concentration of available P in soil, 563 the significant decrease of P cycling genes in relative abundance (Fig. S5) suggested 564 a decreased microbial potential for P cycling. Fourth, there might be an increased 565 competition for soil N between plants and microbes, including nitrifiers, thus leading 566 to lower nitrification rates (Fig. 3 & 4). 567

Our findings highlight how fire affects microbial communities and soil 568 biogeochemical cycling potentials nine months post fire, reflecting the recovery of the 569 ecosystem during the first growing season after fire. First, our results add to growing 570 evidence from multiple grassland ecosystems that fire increases growing-season soil 571 CO₂ efflux, suggesting that altered fire regimes could affect grassland C turnover 572 rates and increase greenhouse gas emissions from grasslands to atmosphere. As the 573 grasslands in our study are used to frequent fires (Docherty et al., 2011), the plant 574 community is likely to be highly resilient to infrequent, high-intensity fires by 575 developing adaptive plant traits to fire regimes (Keeley & Brennan, 2012; Keeley, 576 Pausas, Rundel, Bond, & Bradstock, 2011). This might contribute to higher post-fire 577 soil CO₂ efflux than that in grasslands that are not well adapted to frequent fire 578 regimes (Knapp et al., 1998). Second, we demonstrate that negative biotic 579 interactions and deterministic filtering have a key role regarding fire effects on the 580 taxonomic composition of the bacterial community. Third, our study shows that fire 581 influence on soil microorganisms and plants induces a decoupling between increased 582 plant growth both above- and below-ground, and decreased soil N cycling potentials 583 and availability. Therefore, fire might exacerbate the competition for soil N between 584 plants and soil microorganisms, then altering the competitive balance between them. 585 Fire-induced N limitation in this grassland could also constrain the responses of plant 586 and soil microorganisms to other global change factors, such as elevated CO₂, 587 warming and precipitation. 588
