21 22	(Composed of several components (natural aggregates and attached cement paste)
22	crushe	d concrete aggregates (CCA) are not widely recommended in new concrete
23	formu	ations. Their properties considerably complicate the determination of effective water
25	in free	the concrete. The evolution of effective water in fresh concrete during mixing was
26	studied	d using an original method based on the power evolution of the mixer. The presented
20	experi	ments analyzed the water migration kinetics during mixing and the level of
28	stabili	zation of the effective water at the end of the mixing. This analysis was established
29	accord	ing to the initial moisture of the CCA and of the type of pores filled with water in
30	these	aggregate, and, of the total water in the new concrete mixture. It was shown that the
31	exchar	nge of water between recycled aggregate and the new concrete mixture during the
32	mixing	g is more complex than generally considered. The water can get into or get out from

33 the CCA, depending on the history of their initial moisture. The direction of water migration

34 can also change at different stages of concrete mixing. Therefore, the amount of effective

water decreases or increases during mixing and tends to stabilize once the uniform newconcrete is obtained.

1. Introduction

40

41 The world faces crucial environmental issues such as the over exploitation of natural 42 resources and the production of million tons of construction and demolition wastes (C&D) 43 in the building and public works sector [1-3]. The reuse of recycled concrete aggregates 44 (RCA) (aggregates containing crushed concrete, brick, asphalt and other impurities), 45 representing a major part of the C&D wastes in new concretes seems a solution for these 46 two problems [4-5]. In this paper, crushed concrete aggregates (CCA) will be used and 47 distinguished from RCA. CCA were made of more than 99% concrete. Composed of several 48 components (natural aggregates and adherent cement paste), CCA are not widely 49 recommended in new concrete formulations [6-7]. However, different studies were aiming 50 to develop concrete production with RCA that comply with applicable codes and standards 51 [8-12]. Until now a small percentage (20-30%) of these materials was reused to produce new 52 recycled concretes [13]. The new concretes are therefore part of the NF EN206-1 standard. 53 This standard defines effective water as the difference between the total amount of water 54 contained in fresh concrete and the amount of water absorbable by aggregates. Its 55 determination is generally not a problem for non-porous natural aggregates, but this concept 56 leads to different performance for porous natural aggregates [14] and recycled aggregates. 57 Their intrinsic properties (high absorption, heterogeneity, etc.) [15-16], compared to natural 58 aggregates, considerably complicates the control of effective water in fresh concrete [17]. It 59 has been shown in previous works [18] that water exchange between recycled aggregates 60 and a medium other than water (such as a fresh cement paste [18]) is more complex than 61 generally considered. Therefore, the real effective water (W_{eff} (real)) in recycled aggregate 62 concrete may decrease and/or increase during mixing. Weff (real) represents here the amount 63 of water present in the cement paste at a given time of mixing, excluding the water present 64 in the porosity of aggregates. When using RCA, the real effective water could differ, at a 65 given mixing time, from the theoretical effective water (W_{eff} (th)), computed according to 66 standards from the difference between total water and water absorbed by aggregates.

67 Several technical solutions can be found in the literature to improve the quality of
68 recycled aggregates before incorporating them in new formulations of recycled concretes
69 [19-20]. The pre-saturation of RCA could be a potential technical solution to this problem.
70 However, the pre-saturation of RCA, especially recycled fine aggregate, without excess
71 water, is a very complex task in the industrial production of concrete [21].

72 In addition, usually the initial moisture found in RCA is greater than the initial 73 moisture of natural aggregates. Thus, the initial water content in natural aggregates (NA) 74 does not exceed 1% while in RCA it can exceed 3.5% [17]. A higher moisture is not 75 problematic, in case of using the RCA without any preparation, the real question here is to 76 know if the initial water will affect the effective water content in concrete formulation or 77 not. The effective water content has a major influence on the properties of cement-based 78 materials. Therefore, the formulations of new recycled concrete can be wrong due to the 79 extra ignored water in mixing [22] according to the specifications. The determination of the 80 water absorption capacity (WA) and the knowledge of the initial state of saturation of the 81 RCA are necessary for the formulation of new concretes. Several studies, like [22], show the 82 variability of the actual absorption of aggregates in water depending on their initial moisture 83 state. Khoury et al. [22] investigated the influence of pre-wetting history of CCA on their 84 water absorption capacity. For this purpose, 6.3/10 mm CCA were pre-wetted using 85 different methods simulating long-term (LT) and short-term (ST) pre-moistened aggregates. 86 It was shown that this pre-moistened history (LT or ST) leads to different levels of total 87 water absorption for a same initial moisture level. Previous studies already demonstrated 88 that different initial moisture conditions lead to different mixing results for the concrete 89 [23].

Recent improvements [24-25] have been made to existing procedures to take into
account the specifications of recycled aggregates and their water absorption kinetics.
However, the results obtained from previous studies have left questions to which the present
experimental work provides answers.

Concrete mixing goes through several stages leading to agglomeration of powders and granulation [26]. The wet agglomeration behaviors of powders and the granulation process can differ and be modified by several parameters like the amount of water in the mixture. In the literature, the different states of wet particles were described as a function of the amount of added liquid [27]. The use of the power curves consumed by the mixer during concrete mixing is one of the methods for monitoring the evolution of the mixture. This technique
was developed by Cazacliu et al. [26] and was more recently calibrated by coupling with
image analysis [28].

102 The main objective of this paper is to estimate the evolution of W_{eff} (real) during the 103 mixing of recycled aggregate concretes. At first, the effects of pre-wetting history of CCA 104 (long-term (LT) and short-term (ST) pre-moistened aggregates) on fresh recycled concrete 105 properties were investigated. Then, a relevant cut-points of the power consumption curves 106 recorded during mixing was proposed and based on physical considerations (wet 107 agglomeration steps [27]). A method was then proposed from this division to estimate the 108 evolution of the W_{eff} (real) during the mixing as well as the absorption capacity of the CCA 109 at the end of the mixing.

2. Experimental method

111 **2.1. Materials**

112 Normal concretes based on natural aggregates and recycled aggregates concretes based
113 on coarse CCA were made. The common materials used for these two types of concretes
114 were:

- CEMI 52.5 cement from Lafarge Cements (St Pierre La Cour, France), having a
 real dried density of 3.13 g/cm³
- limestone filler (BETOCARBHP-EB, Omya) having a real dried density of 2.63
 g/cm³
- 119 natural silico-calcareous sand 0/4 mm
- superplasticizer high water reducer of the Chryso company (HRWR) of type
 Optima 352 EMx.

In addition, recycled aggregates concretes were prepared using CCA as the coarse aggregates. The 6.3/10 mm CCA were sourced from the "Gonesse recycling platform" in France and were composed of 99% of crushed concrete and 1% of other inert materials. Normal concretes were made from 5.6/11.2 mm rolled natural siliceous aggregates (NA) as coarse aggregates.

127 **Table 1** summarizes the most significant characteristics of the used materials. The 128 water absorption coefficient (WA₂₄) and the real dried density in water of the CCA were 129 determined according to European standard NF EN 1097-6.

135 The CCA were prepared and pre-wetted prior to mixing using different initial 136 moistures conditions and different modes of pre-wetting. Three different initial moisture 137 conditions were used:

- Oven-dried (coded OD): samples were dried at 70±5°C in the oven for 48 hours to
 obtain constant mass and were cooled down to room temperature prior to mixing
- 140 Under-saturated surface dry state (coded USSD)
- 141 Saturated surface dry (coded SSD)

142 Under-saturated and saturated surface dry CCA were obtained from aggregates pre-143 wetted using four different methods:

- 144 1) In the first method, CCA were immersed in water under atmospheric pressure for 145 24 hours, then they were brought to saturated surface dry state by letting them 146 drained on sieves and gently drying their surface with absorbing paper (according 147 to NF EN 1097-6), they are coded by "air-SSD" (initial water content (w_i) = 4.9%)
- 148
 2) In the second method, CCA were under-saturated: varying amounts of water (wi
 149 =1, 2, 3 or 4%) were sprayed on dry CCA sited on a sieve under the atmospheric
 150 pressure. The under-saturated CCA are coded by "air-USSD1%", "air151 USSD2%", "air-USSD3%", and "air-USSD4%"
- 152 3) In the third method, CCA were immersed in water under low pressure (40 mbar)
 153 for 24 hours then drained and gently toweled, they are coded by "void-SSD" (w_i=
 154 6%)
- 155 4) In the fourth method, CCA were soaked in water under partial vacuum according 156 to the third method. Then, they were left air drying for several time intervals to 157 obtain different water contents, w_i = 1.2, 2, 3.22, and 4.3%. These tests are coded

by "void-USSD1.2%", "void-USSD2%", "void-USSD3.22%", and "void-USSD4.3%".

For all cases, the real water content was measured before using the pre-wetted CCA in concrete mixtures by taking a sample from the pre-wetted aggregates. After their preparation, the CCA were kept in large waterproof bags then used in the formulations of the concrete.

164 **2.2. Mix design**

165 Normal and recycled aggregate concretes were produced following the recipes given 166 in **Table 2**. Recycled aggregate concretes were formulated by performing a total substitution 167 of NA with the same real volume of CCA. The values of the other parameters in the **Table 2** 168 were changed according to the correction of the compositions to have total volume of 1 m³.

171 A total of 41 batches of recycled concrete and 4 batches of normal concrete were carried out. 172 Four series of concretes are prepared by varying only the effective theoretical water-to-173 powder ratio (Weff (th)/P), between 0.3 and 0.34 for recycled concretes and between 0.34 174 and 0.37 for normal ones. Here, $W_{eff}(th)$ vary from 132 to 152 kg/m3 in the recycled 175 concretes formulations and from 153 to 168 kg/m3 in the natural concretes.

176

177 **Table 3** presents the different types of water that can be found in the concretes 178 formulated with NA or CCA. For recycled aggregate concretes, and for each $W_{eff}(th)/P$, 179 eleven batches were made incorporating CCA used in different conditions of initial 180 moisture. Concretes are noted according to the initial moisture state of the CCA.

For each recycled concrete formulation, the $W_{eff}(th)$ and the mixing water added after dry mixing of components (W_{mixing}) were determined according to **Eq.1** and **Eq.2** respectively. The total water (W_{total}) corresponds to the volume of water added to the mixer plus the initial water (w_i) contained in all the constituents (natural or recycled aggregates) and the water brought by the superplasticizer (w_{sp}). The W_{mixing} was calculated to have 186 approximately the same $W_{eff}(th)$ in all concretes of the same series, regardless of the initial 187 moisture of CCA.

In the **Eq. 1** and **Eq. 2**, WA_{24, sand} and WA_{24,A} correspond to the water absorption coefficients determined according to standard NF EN 1097-6 for aggregates. w_i is the initial water quantity in CCA and in the sand. The NA were used dry in the mixtures.

2.3. Mixer and mixing power monitoring

An inverter with an acquisition frequency of 10 Hz was connected to the mixer to record the power. The power curves presented in the results were plotted after an application of two consecutive averages on 10 points each (in total over 2 seconds).

2.4. Experimental Procedure

The CCA were used immediately in the mixing of concrete after their preparation (oven dried, pre-saturated or pre-wetted). The mixer was first filled with coarse aggregates, sand, cement and filler. Then all components were dry mixed for 30 seconds. The mixing water together with the superplasticizer were then added during 10 seconds at a constant flow rate. Then, mixing was pursued for 5 minutes. Immediately after mixing, the slump of fresh concrete was measured according to standard slump test procedure (NF EN 12350-2) but using a mini Abrams cone, half size with the same geometric ratio as the Abrams cone.

3. Results and discussions

3.1. Slump after mixing

Figure 1 shows the variation of the initial slump of the fresh recycled concretes as a function of $W_{eff}(th)/P$ for different initial moisture contents and different pre-wetting methods of CCA. For each initial water content, the variations of the initial slump were established for the two types of pre-humidification under air and under partial vacuum.

219 The slump values of all mixes increased with the W_{eff}(th)/P and the initial slump 220 varies between 0 and 12 cm. In addition, the initial slumps of all the concretes tested 221 increase with the W_{eff}(th)/P ratio, whatever the conditions of initial humidity. It is also 222 observed that recycled concretes containing LT pre-wetted CCA (dashed lines) are less fluid 223 than those containing ST pre-wetted CCA (continuous lines), for the same ratio W_{eff}(th)/P 224 and the same amount of the initial water in CCA. This observation can be explained by the 225 fact that, in recycled concrete, the LT pre-wetted RCA absorb more water than the ST pre-226 wetted CCA, leading to lack of free water in the mixture influencing the slump. However,

for $w_i = 3\%$, it is noted that at low $W_{eff}(th)/P$, the pre-humidification mode (under atmospheric or low pressure) did not affect the initial slump of fresh concrete. On the other hand, the maximum difference was obtained between the initial slump of fresh recycled concrete containing air-USSD4% CCA and void-USSS4.3% CCA. This is in complete agreement with the results observed on water absorption tests performed in water on prewetted recycled concrete aggregate in the study of Khoury et al. [22].

At low initial moisture, the behavior of both LT and ST pre-wetted samples was rather similar to the oven dried sample. The behavior remained similar for all ST under saturated samples, but with some more free water in the mixture for the lower initial moisture CCA. At opposite, the LT under saturated CCA induced less free water in the mixture for the higher initial moisture cases. To finish, the air-saturated CCA (air-SSD) had intermediate behavior between the ST pre-wetted samples and the LT pre-wetted samples.

3.2. Mixing power curves

Figures 2 presents the results of mixing power recorded for different batches of recycled concrete with $W_{eff}(th)/P$ near to 0.34. These results show that variation in the initial 247 moisture condition changed the mixing behavior of the mixture. By considering the higher 248 water content level (0.34) it can be observed that the mixing power remains constant during 249 the dry mixing of the components for 30 seconds (after the stabilization of the effect of 250 mixer starting). The level of stabilized power is dependent on the initial moisture condition. 251 When the addition of the mixing water began, the power increased considerably. The power 252 continued to increase after the end of the addition of the mixing water until reaching the 253 point of maximum cohesion [26]. This can be explained by the fact that, after the addition of 254 the mixing water, the amount of liquid in the overall mixture increases. The space between 255 the particles begins to be filled, it is the funicular state. When the spaces are completely 256 filled with water, the bridges are saturated but with a dry outer surface, this is the capillary 257 state. When particles are totally enclosed in a liquid, a state of solid-liquid dispersion is 258 obtained. So the mixture needs less power to be well mixed.

Subsequently, the power gradually decreased during the formation of the granular paste and continued decreasing to reach the fluidity point [26], in these cases there is a limitation of detection of the point of fluidity. After fluidity point, the power continued to decrease at a lower rate up to the end of the mixing as a consequence of the dispersion of fine particles produced by the plasticizer.

It can be observed that the power curves of recycled concrete incorporating CCA premoistened under partial vacuum (LT) are upper than the power curves of recycled concrete incorporating CCA that were pre-moistened under atmospheric pressure (ST). This can be explained by the fact that the LT pre-wetted CCA absorbed more water than the ST prewetted CCA [22]. So, there was less free water in recycled concrete mixture using LT prewetted CCA, the concrete was less fluid, and the mixer consumed more power.

A very particular case is the 4% of initial moisture. It was shown in a previous work that the nearly saturated CCA under spraying, blocked the absorption of new water during subsequent immersion in water [22]. So, the total **water absorbed** was lower in this case compared to all other initial moisture conditions [22]. This was not the case for the same level of initial moisture obtained by long-term wetting. This phenomenon explains the large difference between the levels of the power curves for these two tests: the LT test shows much more absorbed water by the CCA than the ST test.

Results in **Figure 2** also show that slightly under-saturated samples (both LT and ST tests) were more workable than oven dry CCA. The saturated CCA produced much less workable mixture. These conclusions are in agreement with the experimental results presented in [23].

285 The behavior at lower total water content globally presented the main trends as for the 286 previously discussed situation. It is interesting to underline that in all cases the lower fluidity 287 with short-term under saturated CCA was obtained for an intermediate level -3% (OD, 1%, 288 2% and 4% produced more workable mixture). The LT and ST saturated CCA produced 289 very similar workability and had very similar mixing power evolutions with the mixing 290 time, even if the level of saturation was significantly different for these situations. Finally, in 291 all cases, the less workable mixture was obtained for the LT highest level under-saturated 292 CCA (4%). The water absorbed by these CCA during mixing was even higher than the water 293 absorbed by the LT saturated CCA which was supposed to liberate some water into the 294 mixture during the mixing. This was a very surprising result consistently observed.

4. Interpretation of power results

296

297 4.1. Different steps of agglomeration during concrete mixing298

In the literature, the evolution of wet granular mixtures is described as a function of the amount of added liquid [29]. In this part, the mixing procedure is divided into three stages: - dry mixing - start of the wet mixing (after the addition of the mixing water) and - end of the wet mixing. During these three mixing steps, the effective water content in the granular mixture varies.

In the following analysis, three averages of recorded power are performed over three time intervals: 1- power during dry mixing (average power over the first 30 seconds), 2- power at the beginning of wet mixing (average between 50 and 60 seconds) and 3- power at the end of wet mixing (average over the last 10 seconds).

308 - Dry mixing

309 Figure 3 shows the average of the power results recorded during dry mixing of the 310 components of recycled aggregates with different W_{eff}(th)/P ratios in function of initial 311 moisture of CCA incorporated in the formulations. In this figure, each point represents the 312 average power measured during dry mixing for concretes with the same initial water 313 content, corresponding to the four $W_{eff}(th)/P$ ratios tested. Here, the ratio $W_{eff}(th)/P$ does not 314 affect the interpretation of the powers during the dry mixing. In all recycled concrete 315 mixtures, the same quantities of dry materials (cement, filler and sand) were used and the 316 only difference was in the initial saturation state of the CCA. At the beginning of the dry 317 mixing the power fluctuations are negligible (average standard deviation for all the mixtures 318 is around 0.0018 kW). These differences are very small compared to the small amount of 319 concrete produced (4 liters) and the error can be considered systematic because the mixing 320 tests were performed at the same time, in the same period of the year.

321 It can be observed that, during the dry mixing, and when the w_i increases the power 322 increases because the capillary bridges increase in the mixture. This observation can be 323 explained by the fact that during dry mixing, the water in the pre-moistened CCA tends to 324 come out in the mixture. The power of the mixer therefore increases with the initial 325 humidity of the CCA. But it should not be forgotten that at this stage the water content is 326 very low in the overall mixture (CCA pre-humidified or not, dry sand, cement and filler) 327 before the addition of the mixing water. The phenomenon observed at the beginning of dry 328 mixing corresponds to the distribution of the liquid on the surface of the particles. The 329 amount of water is still low so as not to form enough liquid bridges and increase the 330 cohesion of the system.

In addition, it can be observed that, in the recycled concrete with CCA pre-moistened with LT mode, the power during dry mixing is smaller than that for concretes with GBR premoistened with ST. This can be explained by the fact that, in LT pre-wetted CCA, the water was located in a less accessible porosity than that contained in ST pre-wetted CCA. The amount of water released in the mixture is therefore in this case lower than in the concrete with ST pre-wetted CCA.

The recycled concrete incorporating dry CCA and LT pre-wetted CCA with small $w_i =$ 1.2% have the same power in dry mixing. Therefore, initially wet CCA with a very small amount of water have the same behavior in the concrete as if they are dry.

344 - Wet mixing: beginning and end

Figure 4 shows the evolution of the power of the mixer at the beginning and the end of wet mixing for one case with $w_i = 4-4.3\%$. The wet mixing begins just at the end of loading of mixing water. In the two graphs presented in Figure 4, same phenomenon is observed at the beginning and at the end of the wet mixing. It can be observed that, the power decreases with the W_{eff}/P ratio. And this is observed for all initial conditions of prewetting of CCA.

4.2. Evolution of the real effective water according to the power curves

In this section, an original method to estimate the evolution of $W_{eff}(real)$ in recycled aggregates concrete during mixing is developed. To do this, the power curves registered during mixing of normal concretes are used as calculation charts for the recycled aggregate concretes.

Figure 5 shows the power consumed during the mixing of normal concretes for the four $W_{eff}(th)/P$ ratios (0.338, 0.351, 0.357 and 0.371). It is observed that the power consumed increases when the ratio $W_{eff}(th)/P$ decreases, therefore with the $W_{eff}(real)$ reduction in the mixer. It can be considered in this analysis that the $W_{eff}(th)/P$ ratios of normal concretes are equal to $W_{eff}(real)/P$ because the NA used are quasi non absorbing. It is thus considered that there was no water exchange between the NA and the mixture of normal concrete.

In addition, we hypothesize that, when the dissipated power for a recycled concrete is the same as that dissipated for a normal concrete, then the $W_{eff}(real)$ they contain are identical for the two concretes. This assumption can be justified on the basis of the following arguments:

Formulations of recycled aggregate concrete were close to those of normal concretes
and were designed to remain in the same consistency range as normal concretes (initial
slumps ranged from 0 to 11 cm). The NA were notably replaced by the same real volume of
CCA

In the 4 formulations of normal concrete, only the effective amount of water
changed. Consequently, the differences observed between the powers of these 4 concretes
are due solely to the variation of the effective water from one batch to another

Finally, the power consumed during the dry mixing of normal concrete was almost identical to the power consumed by recycled concrete. It is therefore assumed here that it was only the variation of the effective water during mixing which was responsible for the variation of power from one concrete to another.

In addition, **Figure 5** shows an example of how to exploit a power curve obtained for a normal concrete in order to estimate the $W_{eff}(real)/P$ in a recycled aggregate concrete (void-SSD 0.337). We can, from the points of intersection and with an interpolation, determine the evolution of the $W_{eff}(real)/P$ at every moment of concrete mixing.

From the intersection of the power curves of each recycled aggregate concrete with the power curves of the four normal concretes, the $W_{eff}(real)/P$ is determined for each recycled aggregates concrete for 9 given intervals of mixing time (T_i= 0, 10, 30, 60, 90, 120, 180, 260 and 290 seconds?). Here, the intervals of time are taken from the end of the introduction of water into the mixture. For each of these intervals (Ti), the power taken into account is
the average of the powers consumed between the instants Ti and Ti + 10s.

397 At the instant T_0 , $W_{eff}(real, T_0)/P$ is determined according to **Eq. 3** neglecting the 398 water exchanged by the humidified CCA with the mixture during dry mixing.

Where, w_i is the initial amount of water and M_{CCA} mass of CCA.

403 At 10, 30, 60, 90, 120, 180, 260 and 290 seconds after the end of the water 404 introduction, $W_{eff}(real)/P$ is extrapolated linearly at each moment using the power curves 405 and the W_{eff} (th)/P of the normal concretes. The same procedure is used for all formulations 406 with CCA in different initial moisture states and with different $W_{eff}(th)/P$. For the 407 presentation of results in the following figures the very beginning of wet dry mixing is 408 considered as the origin of the time axis.

409 Figure 6 shows the evolution of W_{eff}(real)/P in recycled aggregate concrete, 410 incorporating OD CCA, during mixing. It can be observed in this figure that the W_{eff}(real)/P 411 estimated decreases with the mixing time. It is also observed that, whatever the mixing time 412 is, the effective water actually present in the concrete is systematically higher than the 413 effective water theoretically determined according to the European standard NF EN 206-414 1/CN. As a result, CCA are unable to absorb the full amount of water added according to the 415 standard to compensate for their absorption. We can conclude from this that the water 416 absorption of CCA in concrete must be determined by another method than that used for NA 417 in normal concretes.

421 Figure 7 shows the evolution of W_{eff}(real)/P in the recycled concrete mixture 422 containing CCA pre-wetted with different modes under air (ST) and under partial vacuum 423 (LT) and with different amounts of initial water (wi = 2% and 4-4.3%). First, it is observed 424 that the same behavior is obtained for the evolution of W_{eff} (real) /P in all the cases 425 presented. Indeed the effective water decreases during the first 300 seconds of mixing time. 426 After it remains substantially constant until the end of mixing. W_{eff} (real) / P thus stabilizes 427 after about 300 seconds during mixing, for recycled concretes incorporating initially CCA 428 pre-moistened with small amounts of water either under vacuum or under air. Second, for 429 the recycled concretes contained initially CCA pre-moistened with larger amounts of water 430 either under vacuum or under air, the actual effective water estimated increases at the 431 beginning of mixing up to about 60 seconds and then decreases during mixing until 432 stabilization is achieved. This stabilization appears to occur earlier than for the lower initial 433 water contents, approximately 240 seconds instead of 300 seconds previously. Thus, with 434 pre-humidification under partial vacuum, the stabilization of the W_{eff} (real) seems to be 435 faster.

441 4.3. Estimation of the water absorbed by CCA during the mixing of recycled 442 concrete 443

The data analyzed above make it possible to determine the trapped water (W_T) in the CCA at each moment of mixing (T) according to **Eq.4**. The latter takes into account: W_{eff} (th), $W_{eff, T}$ (real) at the instant T determined by the method discussed above, the quantity of powders P (cement and filler), the mass of CCA (M_{CCA}) and the water absorption coefficient of CCA ($WA_{24, CCA}$). Then the water absorption capacity of CCA during mixing (W_{abs} , concrete) is estimated using **Eq.5**. $W_{abs, concrete}$ therefore represents the amount of water absorbed by the CCA during mixing.

Figure 8 shows the variation of the water absorption capacity of CCA in recycled concrete during mixing in function of their initial moisture conditions and prehumidification mode, and in function of $W_{eff}(th)/P$. A difference can be observed between the water absorption capacity of dry CCA (OD) and under saturated CCA with $w_i = 2 \%$ at CT and LT. With a long-term pre-humidification (partial vacuum) the absorption of CCA in concrete is higher. For partially saturated CCA (USSS2%, USSS3-3.2% and USSS4-4.3%), water absorption is 0.5 to 1% greater when CCA were pre-wetted under partial vacuum than when they wre pre-wetted under atmospheric pressure. The same observations were made in a previous work [22].

Figure 9 shows the variation of the water absorption capacity of CCA in recycled concrete in function of their initial moisture states, and their pre-humidification mode, and in function of $W_{eff}(th)/P$. Here, the studied cases are under saturation states with w_i close to 80% of WA₂₄ (air-USSS4% and void-USSS4.3%) and saturation states (air-SSS and void-SSS).

467 Apart from the initial state void-USSS4.3% which absorbs a small amount of water, 468 the absorptions of the other 3 states studied are all negative and this can be explained by the 469 fact that the CCA release water during mixing. This result differs from what was observed in 470 previous work [22] where the absorption in water was negligible. In addition, CCA under 471 saturated with 80% of WA₂₄ (air-USS4%) releases more water into the mixture than CCA 472 saturated under vacuum. These results confirm the observations on the results of the initial 473 slump of these concretes and the power curves.

4.4. Saturation level in the CCA 487

Till this section, two modes of humidification are distinguished. Short-term 489 490 humidification, where water is initially located in pores accessible to water and long-term 491 using partial vacuum, in this case the initial water is also located in the less accessible pores.

492 In this section, the saturation rate of CCA during concrete mixing is investigated. To 493 do this a comparison between W_{eff} (th) and W_{eff} (real, T=335s) is carried.

494 Figure 10 shows the evolution of W_{eff} (real, T = 335s)/P as a function of W_{eff} (th)/P. 495 the recycled concretes incorporating CCA with different initial moisture are separated into 4 496 groups: a first group with concretes based on OD, air-USSS (1 to 4%) and void- USSS1% 497 CCA, a second group with recycled concretes based on air-SSS and void-USSS3.22% CCA, 498 a third group with recycled concrete based on void-USSS2% CCA, and a last group with 499 recycled concretes based on void-SSS and void-USSS4.3% CCA.

504 For concretes initially containing small quantities of initial water (OD, air-USSS1-4% and void-USSS1%) the slope of the evolution of $W_{eff}(real, T=335s)/P$ in function of $W_{eff}(th)$ 505 506 is 1.11. Therefore, the actual effective water estimated is 11% larger than the theoretical 507 effective water. For concrete based on air-SSS and void-USSS3.22% CCA, the slope is 1.03. 508 The actual effective water is 3% larger compared to the theoretical effective water. For 509 saturated CCA with vacuum (void-SSS and void-USSS4.3%) the slope is 1.01. In this case 510 the calculation of the effective theoretical water provides a good estimate of the actual 511 effective water. Therefore, to control the actual effective water in fresh concrete, the 512 theoretical water calculation must consider not only the water absorption capacity of CCA in 513 concrete but also the humidification history of these ones.

5. Conclusion 514

515

516 This paper presents an original method for tracking the actual effective water 517 exchanges as well as the water absorption capacity of a CCA when mixing new concrete. 518 The method consists in following the power curves evolution of the mixer during mixing for 519 different scenarios of initial moisture porous aggregates. Some previously observed 520 phenomena were confirmed, and several new phenomena were consistently observed.

Actual effective water is estimated from a comparison between fresh recycled aggregate concrete power curves and those of normal concretes with compositions and properties like recycled concrete. One of the main advantages of the method is that it allows continuous monitoring of water exchanges between the aggregate and the mixture.

525 The results show that, except for some saturation conditions (high saturation rate for 526 LT saturation), the actual effective water in the mixture is consistently higher than the 527 theoretical effective water calculated according to water absorption capacity measured 528 according to EN 1097-6. This deduction was confirmed by the results of the initial slumps of 529 fresh recycled concretes incorporating OD CCA that were more fluid than expected. This 530 can be explained by the fact that the CCA cannot absorb during mixing the total amount of 531 water added to compensate for its absorption determined by EN 1097-6. Thus, effective 532 water must be determined considering not only the water absorption capacity but also the 533 history of its pre-humidification or its initial moisture.

In addition, it can be deduced that the W_{eff} (real /P) in the mixture with CCA that were LT pre-wetted stabilizes faster than that in a mixture with CCA that were ST pre-wetted. For pre- saturated CCA after immersion in water for 24 hours under partial vacuum or under air respectively, the real effective water decreases with the mixing time but with a stabilization at 180 seconds.

539 The results show also that with a vacuum saturation the real effective water can be 540 controlled by determining the effective theoretical water at the beginning of the concrete 541 production as a function of the initial state of saturation. Long-term humidification allows 542 the least accessible pores of CCA to be filled and then reduces water exchange between 543 CCA and cement paste in concrete. On the contrary, for ST saturation with spraying, the 544 water is located essentially in the most accessible pores and is thus easily exchangeable 545 during mixing. However, these results have yet to be completed in order to be able to further 546 the analyses.

Finally, recommendation could be considered in the use of CCA in new concrete formulation for example using a lower nominal absorption value than the standard WA₂₄ in calculating effective water. This value can be equal to 60-75% of WA₂₄ if the CCA is used dry. And if used pre-humidified the value will be proportional to the initial water content in the porosity of CCA and higher for the CCA slowly pre-wetted (LT pre-wetted).
