21 Abstract

22 Intensive shrimp farming generates high loads of wastewaters that are released along tropical coastlines with potential impacts on the ecosystems. In this study, we 23 used an experimental approach to analyze the behavior of shrimp pond effluents 24 released in the Can Gio mangrove waterways (Southern Vietnam). We incubated shrimp 25 pond effluents (EF), river water (RV), and a mixture of both (MI; 90% RV + 10% EF) in a 26 27 dark room and measured fatty acid (FA) compositions, C and N concentrations and stable isotopes ratios (δ^{13} C and δ^{15} N) of suspended particulate matter during 16 days. 28 Fatty acid concentrations rapidly decreased in EF with a 50% loss of FA during the first 29 24h of the experiment and a 75% loss after 4 days of incubation. Proportions of the FA 30 18:1ω7 increased in MI during incubation, suggesting that this FA may be used as a 31 32 tracer of anthropogenic substances release in marine environments.

53 1. Introduction

Shrimp farming has strongly grown in the last decades. Global shrimp production 54 was 1.1 billion tons in 2000, 3.4 billion tons in 2008 and reached 4.9 billion tons in 2015 55 (FAO, 2016). Although shrimp farming generates important social and economic 56 benefits (Primavera, 1997), its huge development is strongly criticized for its negative 57 environmental impacts (Anh et al., 2010). Intensive shrimp farming is characterized by 58 59 high shrimp density, high amount of inputs (food pellets, fertilizers and antibiotics) and high water renewal in ponds (15% every two weeks in Vietnam; Anh et al. 2010). This 60 leads to high effluent releases (including dissolved nutrients, toxic compounds, 61 62 microorganisms, shrimp excrements, unconsumed food pellets, etc.) associated with highly degraded water quality close to shrimp farming areas (Molnar et al., 2013; Páez-63 Osuna, 2001; Páez-Osuna and Ruiz-Fernández, 2005) that may stimulate algal blooms 64 and create anoxic water conditions (Kemp et al., 2009; Naylor et al., 1998; Smith et al., 65 66 1999).

Despite potential impacts of shrimp pond effluent discharges in estuarine waters are recognized, their effect is mostly investigated regarding nutrients (Páez-Osuna and Ruiz-Fernández, 2005; Trott and Alongi, 2000) and other parameters are poorly documented, as for example the nutritional value of impacted water suspended particulate matter (SPM). In New Caledonia, Aschenbroich et al. (2015) have shown that the nutritional quality of mangrove surface sediments was affected by shrimp pond effluents releases (i. e. modified fatty acid composition). Indeed, sediments integrate

chronic disturbances on a relatively long-time basis (Molnar et al., 2013), while SPM
naturally varies at short spatial scales in mangrove estuaries (Trott and Alongi, 2000),
making difficult to differentiate changes induced by environmental parameters (e.g.
season, salinity, SPM concentration, daylight presence) from those due to shrimp pond
effluent releases (David et al. 2019).

Lipids have been successfully employed to detail the nutritional composition of 79 organic matter (OM) in marine ecosystems (Canuel, 2001; David et al., 2019; Meziane 80 and Tsuchiya, 2000). They are good indicators of microalgae and bacteria relative 81 82 abundances and allow to evaluate the physiological state of phytoplankton cells (Pan et al., 2017, 2014). In complement to fatty acids, stable isotopes may inform on the 83 84 processes occurring during OM decomposition (Caraco et al., 1998; De Brabandere et al., 2002; Pan et al., 2014; 2017). Finally, nitrogen is a major compound of OM that is 85 newly made available for primary producers after OM has been degraded, thus 86 releasing ammonia in the surrounding waters which can fuel nitrification and 87 eutrophication. 88

89 A few studies have been examining the degradation of lipids from urban sewages in natural environments (Matsumoto, 1983; Marty et al., 1996) but none has yet 90 91 investigated their decomposition in shrimp farm effluents, although the latter are known to cause serious threats to coastal ecosystems in Southeast Asia (e.g. increasing 92 93 nitrogen influx and change in C/N balance; Lee, 2016). The Can Gio mangrove biosphere reserve is located at the downstream end of Ho Chi Minh City (Southern 94 95 Vietnam) and covers an area of 719.6 km² (Tuan and Kuenzer, 2012). At the north-east border of the mangrove forest, a transition area between the forested core and the 96

Southern limit of Ho Chi Minh City covers about 300 km² where shrimp farming is the 97 main economic activity, releasing wastewaters in the nearby waterways, with potential 98 impacts (e.g. high nutrient loading, spread of diseases, antibiotics accumulation in 99 100 sediments) on the ecosystem (Le and Munekage 2004, Anh et al., 2010). The release of shrimp ponds effluents is not controlled in this region. Effluents are not being treated 101 102 and directly released on defined schedules in the nearby rivers throughout the year (Anh 103 et al., 2010), thus rapidly reaching the 600m wide and 10-20m deep main estuary 104 located a few hundred meters downstream and further flooding the mangrove forest (a 105 map of the Can Gio mangrove biosphere reserve can be found in David et al. 2019).

106 In the present study, we used an experimental approach based on the one 107 employed by Marty et al. (1996) to examine changes in SPM nutritional quality during 108 decomposition of shrimp pond effluents released in a mangrove river in the Can Gio district. We aimed at characterizing the initial FA composition of shrimp pond effluents 109 110 and then follow the dynamics of FA once their release in the environment has been 111 simulated. We also measured variations of carbon and nitrogen forms and their isotopic ratios as markers of degradation processes and their kinetics. We expected to measure 112 elevated phytoplanktonic abundances in shrimp ponds, as they generally exhibit high 113 114 primary production (Burford et al. 2003), which may induce a strong bacterial development during effluents decomposition in mangrove waters. We sampled water 115 from shrimp ponds and a nearby mangrove river to study the degradation of lipids in 116 SPM in the absence of light (thus imitating natural conditions in the deep and turbid 117 estuary). Pure shrimp pond effluents, pure river water and a combination of both were 118 incubated in controlled conditions during 16 days. We hypothesized that (1) specific 119

bacterial strains (e.g. denitrifying ones) and/or degradation pathways were favored in a
mix of shrimp pond effluents with river water compared to both waters taken in isolation
(2) specific fatty acids could be used as tracers of shrimp pond effluents release in
natural ecosystems.

125 2. Materials and methods

126 2.1. Water collection

Water samples were collected in shrimp ponds and a nearby mangrove river of the Can Gio mangrove Biosphere Reserve in February 2017. Surface estuarine water (river water; RV) was collected using a wired bucket from the middle of the Rung Sat bridge (10° 35' 2.94" N; 106° 49' 32.68" E) at the beginning of ebb tide, while a composite sample of shrimp pond effluents (EF) was made using water from three different intensive shrimp ponds (40-60 shrimps/m²) located close to the river water sampling point.

135 2.2. Experimental design

Water samples were brought in white plastic jerrycans at ambient temperature to the CARE (Centre Asiatique de Recherche sur l'Eau) facilities in Ho Chi Minh City in February 2017. Jerrycans containing the same water source (EF of RV) were mixed together before being disseminated in 14L plastic buckets. These buckets were meant to test three conditions: (1) pure shrimp pond effluents (EF), (2) pure river water (RV) and, (3) a combination of both (mixed water; MI: 90% RV + 10% EF). Each experimental

condition was tested in 4 replicates (12 buckets). The amount of wastewaters released 142 from shrimp ponds to the mangrove river is unknown but probably much below 10% of 143 the discharge of this large estuary (about 300 m³ s⁻¹ in February, the month we 144 145 conducted our experiment, Nguyen et al., 2019). Proportion of RV and EF in the MI condition (90/10) was chosen in a way to place shrimp pond effluents in the 146 147 environmental conditions found in river waters, without excessively diluting the FA signal. In addition, previous studies (unpublished data) revealed concentrations of FA 148 149 roughly 10 times higher in shrimp pond effluents compared to river water. Fatty acids 150 originating from EF and RV are thus expected to be added in similar guantities in the MI condition. All buckets were incubated in a dark room at 30°C and continuously 151 homogenized with 200L h⁻¹ aquarium pumps during 16 days without aeration. Dark 152 conditions are meant to simulate the high turbidity of mangrove waters. The estimated 153 light penetration in the estuary is actually lower than 1m and considering the estuary 154 depth (10-20 m) most of SPM is transported in the dark (David et al. 2019) although 155 156 suspended particles may reach the photic zone from time to time due to elevated water turbulence. 157

Water samples were taken at short intervals at the beginning of the experiment and more spaced thereafter (Matsumoto, 1983; Marty et al., 1996). Sampling were performed at T0, and after 8 h, 16 h, 24 h, 2 days, 3 days, 4 days, 6 days, 8 days, 12 days and 16 days of incubation (T8, T16, T24, D2, D4, D6, D8, D12 and D16). Two water subsamples were collected at each sampling time from the 12 buckets and filtered for analysis of fatty acids and stable isotopes of SPM. Filtrations were performed using pre-combusted and pre-weighed (4h at 450°C) 0.7 µm Whatman[®] GF/F glass microfiber

filters and filtered water was kept for dissolved nutrients analysis. All filters were kept at 25°C and analyzed within two months.

168 2.3. Sample processing

169 Salinity, dissolved oxygen and pH were measured at the beginning of the 170 experiment (T0) using a multi-parameter probe (WTW 3420®). Dissolved inorganic 171 nitrogen forms (NH₄⁺, NO₂⁻ and NO₃⁻) were measured at T0,T8, T24, D2, D4, D8 and 172 D16 only, using a Hach-Lang kit photolab DR 1900 employing standard colorimetric 173 methods (APHA, 1995; Nguyen et al., 2019). Reproducibility for replicated 174 measurements was higher than 5%.

Lipids were extracted following a slightly modified method of (Bligh and Dyer, 175 1959) as described in Meziane et al. (2006). An internal standard (23:0) was added to 176 177 samples prior to extraction. Lipids first extracted the were using а methanol:water:chloroform mixture (2:1:2 v:v:v). Chloroform, containing lipid extracts, 178 was isolated and evaporated under nitrogen (N₂) flux. Dried lipid extracts were then 179 180 saponified with a solution of methanol and sodium hydroxide (NaOH, 2N) (2:1, v:v) at 90°C for 1h30 min. Subsequently, methylation was performed, transforming all fatty acid 181 esters into fatty acid methyl esters using methanolic boron trifluoride (BF3-CH₃OH). 182 Fatty acids were separated by gas chromatography (Varian 3800), using an Agilent[®] VF-183 WAXms capillary column 30m long, 0.25mm inner diameter and with 0.25 μ m film 184 185 thickness, and quantified using a flame ionization detector. Identification of fatty acids 186 was performed using gas chromatography-mass spectrometry (Varian 450-GC; Varian 187 220-MS) and comparison of GC retention times with commercial standards (Supelco®).

188 The internal standard (23:0) was used to determine the concentration of each fatty acid 189 (C_{FA}) in µg FA per mg SPM.

190 Stable isotopes of carbon and nitrogen were measured at T0, T24, D4 and D16. 191 SPM samples were fumigated for 4h using 35% HCl to remove all carbonates. Samples were prepared in tin capsules at the Muséum National d'Histoire Naturelle (MNHN-Paris) 192 and analyzed at the University of California Davis Stable Isotope Facility (Department of 193 Plant Sciences, UC Davis, Davis, California), using a Vario EL Cube elemental analyzer 194 (Elementar Analysensysteme GmbH, Hanau, Germany) interfaced to a PDZ Europa 20-195 196 20 isotope ratio mass spectrometer (Sercon Ltd., Cheshire, U.K.). During analysis, laboratory standards (bovine liver, nylon 6, enriched alanine and glutamic acid) 197 198 previously calibrated against international standard reference materials were 199 interspersed with samples. Carbon and nitrogen stable isotope results were reported in parts per thousand (‰), using standard delta notation (δ^{13} C and δ^{15} N) and are relative to 200 201 V-PDB (Vienna PeeDee Belemnite) and atmospheric air, respectively. The C/N ratio was calculated as the molar ratio of particulate organic carbon (POC) vs. particulate 202 organic nitrogen provided by the isotope mass ratio spectrometer. 203

205 2. 4. Data analysis

Degradation rate constants of fatty acids were calculated using an exponential decay model on the form $C_{FAfinal} = C_{FAinitial} \times e^{-kt}$, where C_{FA} is the final or initial concentration of a given FA or group of FA in the treatment, k is the degradation rate constant in days⁻¹ and t is the incubation time in days. Data treatment and graphical representations were performed using R 3.3.2.

212 3. Results

213 3.1. Water parameters

214 Salinity was lower in effluents (10.1 ± 0.0) compared to river water (13.2 ± 0.0) 215 and pH was higher in EF (8.35 \pm 0.01) compared to RV (7.45 \pm 0.01) (Table 1). As 216 intended, the mixed condition almost kept the conditions displayed by RV (salinity = 12.8 217 \pm 0.0 and pH = 7.53 \pm 0.00). Suspended particulate matter concentration was about half 218 as much in EF (91.2 \pm 10.3 mg L⁻¹) compared to RV (204.6 \pm 4.3 mg L⁻¹) and C/N ratio was lower in EF (7.0 \pm 0.0) compared to RV (9.7 \pm 1.4; Table 1). Shrimp pond effluents 219 were enriched in both dissolved inorganic nitrogen (DIN) and total nitrogen compared to 220 221 RV (NH₄⁺, NO₂⁻ and NO₃⁻ were summed to get free of the nitrogen cycle steps that are 222 not meant to be discussed in this paper; Fig. 1). Concentrations of DIN slightly increased in EF at the beginning of the experiment (from 1.26 \pm 0.04 mmol L⁻¹ at T0 to 1.76 \pm 0.19 223 224 mmol L⁻¹ at D2) and then dropped from 1.78 ± 0.14 mmol L⁻¹ at D8 to 0.23 ± 0.04 mmol 225 L⁻¹ at D16 (Fig. 1a). Total nitrogen decreased during the experiment, reaching about one third of its initial value at the end of the experiment (2.95 \pm 0.05 mmol L⁻¹ at T0 vs. 1.01 226 \pm 0.05 mmol L⁻¹ at D16), while it increased during the same period in MI and RV (from 227 228 0.77 ± 0.01 mmol L⁻¹ to 1.03 ± 0.02 mmol L⁻¹ in MI and from 0.60 ± 0.02 mmol L⁻¹ to 1.42 \pm 0.11 mmol L⁻¹ in RV; Fig. 1b). 229

Concentrations of POC were about 3 times higher in EF (10.1 \pm 0.8 mg L⁻¹) compared to RV (3.3 \pm 0.3 mg L⁻¹; Fig. 2a). It rapidly dropped to 6.1 \pm 0.2 to during the first 24h of the experiment in EF, while it slightly increased in MI and RV, reaching 5.7 \pm

- 233 0.5 mg L⁻¹ and 6.4 \pm 0.8 mg L⁻¹, respectively in MI and RV at the end of the experiment 234 (Fig. 2a).

247 3.2. Fatty acids

Identified FA in SPM samples included saturated fatty acids (e.g. 16:0 and 18:0), 248 polyunsaturated fatty acids (PUFA; e.g. 18:2w6 and 20:5w3), monounsaturated fatty 249 acids (e.g. 16:1w7 and 18:1w9), and branched fatty acids (BrFA; e.g. iso-15:0 and 250 251 anteiso-15:0) (Table 2). Total FA (TFA) concentrations at T0 were about 15 times higher 252 in EF (1.00 \pm 0.16 mg L⁻¹) compared to RV (0.07 \pm 0.02 mg L⁻¹; Fig. 2b). High proportions of PUFA were identified in EF ($32.9 \pm 1.1\%$), with a dominant contribution of 253 254 C₁₆ PUFA, 18:3ω3 and 20:5ω3 (Table 2). In contrast, RV was dominated by saturated FA (56.8 \pm 4.1%) and exhibited low PUFA proportions (8.8 \pm 0.7%; Table 2). 255

The concentrations of TFA and specific or groups of PUFA rapidly decreased 256 257 during the first day of incubation, gradually decreased from T24 to D4 and then only slowly degraded over these periods (Fig. 2b and Fig. 3). The degradation of fatty acids 258 thus apparently occurred in three steps, similarly to the observations of Matsumoto 259 (1983) during the incubation of river water. Consequently, we fitted three degradation 260 rate constants for each treatment. Degradation rate constants were highest in the EF 261 condition, while they were lower or not significantly different from 0 in the MI condition 262 263 and always not significant in the RV condition (Table 3). A 50% loss of TFA was measured in EF during the first 24h of the experiment, reaching 75% at D4, while TFA 264 remained almost stable or even increased in MI and RV during the entire experiment 265 (Fig. 2b and Table 3). Concentrations of total PUFA, 18:3w3 and 20:5w3 followed the 266 same trend as TFA (Fig. 3), while relative contributions remained almost stable between 267 T0 and T24 in EF, and dropped rapidly after T24 (Fig. 3). In contrast, total PUFA and 268 269 18:3ω3 relative proportions decreased since the first hours of the experiment in MI (Fig.

3) and almost did not changed in RV during the entire experiment. Concentrations of BrFA and 18:1 ω 7 remained almost stable during the entire experiment, while relative proportions increased in all conditions (Fig. 3). Relative proportions of 18:1 ω 7 showed a sharp increase in MI from 5.3 ± 0.3% at T0 to a maximum of 23.6 ± 0.8% at D4, reaching values higher than in EF (12.8 ± 1.1%) and RV (15.8 ± 2.4%) at the same moment (Fig. 3). 281 3.3 Stable isotopes δ^{13} C and δ^{15} N

 δ^{13} C ratios of SPM at T0 were lower in EF (-27.89 ± 0.15%) compared to RV (-283 25.66 ± 0.04‰; Fig. 4a). It decreased in EF from T0 to T24 (-38.35 ± 0.09‰) and then 284 increased until the end of the experiment, while it slightly increased during the entire 285 experiment in MI and RV (Fig. 4a). δ^{15} N ratios of SPM were higher in EF (9.14 ± 0.07‰) 286 compared to RV (5.16 ± 0.73‰; Fig. 4b). It increased until D4 up to 14.2 ± 0.3‰ in EF, 287 and then decreased to 10.0 ± 0.6‰ at D16, while it oscillated between 4.7‰ and 8.4‰ 288 in MI and RV during the entire experiment.

296 4. Discussion

297 4.1. Composition of SPM sources at T0

High PUFA proportions in EF (32.9 ± 1.1%; Table 2) and C/N ratios close to the 298 Redfield ratio (6.6; Table 1), show that a substantial fraction of SPM is constituted by 299 living phytoplankton (Canuel, 2001; Moynihan et al., 2016; Napolitano et al., 1997). 300 301 Shrimp ponds generally exhibit high primary production (Burford et al., 2003) and the elevated level of DIN we measured in EF (Fig. 1) provides ideal conditions for 302 phytoplankton growth. In our experiment, dominant algal cells were diatoms and green 303 algae, as indicated by the high proportions of PUFA 20:5w3, C₁₆ PUFA, and PUFA 304 305 18:3ω3, indicative, respectively for the two first of Bacillariophyceae, and for the latter of Chlorophyceae (Dalsgaard et al., 2003). In contrast, low POC concentrations (Fig. 2a) 306 307 and low PUFA relative proportions in RV (8.79 ± 0.7%, Table 2) show that SPM was in 308 an advanced state of decomposition (Canuel, 2001; Jaffé et al., 1995), as we previously highlighted in this ecosystem (David et al., 2019). Lower δ^{13} C and higher δ^{15} N in EF 309 compared to RV may be attributed to shrimp pellets with high proportion of carbon 310 originating from terrestrial plants with low $\delta^{13}C$ and high proportion of nitrogen 311 originating from fish trashes with high δ^{15} N. However, other measurements in the area 312 313 revealed high variability of δ^{13} C and δ^{15} N of SPM in shrimp ponds (-22.9 to -31.8 for δ^{13} C and -0.6 to 20.7 for δ^{15} N: unpublished data) suggesting that initial values may be 314 poorly informative in this study and that focus is mainly to be given to changes in 315 isotopic values through time. Total concentration of FA in RV at T0 (0.07 \pm 0.02 mg L⁻¹) 316 was much below the findings of Matsumoto (1983) who studied the decomposition of 317 organic compounds in a highly polluted river of Japan (about 1 mg of TFA per L). 318

Actually, although the estuary is subjected to a strong anthropogenic pressure (Nguyen et al., 2019), the sewage effluents released within Ho Chi Minh City are strongly diluted before entering the mangrove area (David et al. 2019). In contrast, TFA in EF at T0 $(1.00 \pm 0.16 \text{ mg L}^{-1})$ were about similar to the concentrations measured by Matsumoto (1983) in river water at the beginning of their experiment, thus possibly allowing relevant comparisons.

326 4.2. Degradation of shrimp pond effluents

327 The high degradation rate of FA in EF indicates that algal lipids were rapidly 328 degraded once photoautotrophic production was made impossible (in the absence of light). However, the sustaining of PUFA relative proportions during the first 24h of the 329 experiment (from T0 to T24) followed by their gradual decay from T24 to D16 (Fig. 3) 330 suggests that two different processes are successively involved in FA degradation. In 331 complete darkness, living algal cells consume lipids from intracellular storage 332 compartments (Brown et al., 1996; Eltgroth et al., 2005), possibly allowing them to 333 survive during a few days using triacylglycerols and galactolipids as an energy source 334 335 (Manoharan et al., 1999). In the present study, phytoplankton from shrimp pond effluents most probably survived during the first 24h of the experiment (from T0 to T24), 336 leading to the maintaining of their PUFA relative proportions. In contrast, the decrease of 337 338 PUFA proportions after T24 suggests the death of algal cells, as usually observed during microbial degradation of phytoplankton (Ding and Sun, 2005; Pan et al., 2017, 339 340 2014). The dynamics of δ^{13} C confirms the succession of these two processes, with 341 decreasing values during the first 24h of the experiment and increasing values thereafter 342 (Fig. 4a). Pan et al. (2014) actually measured decreasing values of phytoplankton δ^{13} C 343 during cell respiration, and increasing values during its microbial degradation.

344 Degradation rate constants k1 of FA during the first 24h of the experiment (Table 345 3) were much higher than those measured during the respiration phase by Pan et al. (2014), suggesting that experimental conditions may have conducted algal cells to 346 rapidly depleting their energy stocks. As a consequence, natural populations of 347 microalgae in our experiment died after 24h, while algal cells cultured in laboratory 348 conditions may last weeks in darkness (Manoharan et al., 1999, Pan et al., 2014). The 349 350 setting up of the experiment may have stressed natural microalgal communities and induced a rapid collapse of their populations. Nevertheless, such situation probably 351 352 better reflects what happens once effluents are released in the river than the suppression of light alone in sterile laboratory cultures. During the first degradation 353 phase, k1 remained lower than values measured in a highly urbanized river of Japan by 354 Matsumoto (1983; up to 1.5 d⁻¹) and the 50% loss of FA was higher than measured 355 during the first 24h in a sewage-seawater mixture by Marty et al. (1996), where initial FA 356 concentration was about half that of our experiment. Such results suggest that 357 decomposition rates may be both sensitive to initial concentration and the conditions in 358 359 which effluents are placed.

The increase of BrFA and FA 18:1 ω 7 relative proportions, indicative of bacteria (Dalsgaard et al., 2003; Kaneda, 1991; Meziane and Tsuchiya, 2000), along with the maintaining of their concentrations (Fig. 2), indicate that the bacterial compartment remained active during the entire experiment. Bacterial OM mineralization led to the release of DIN in EF during the first 2 days of the experiment (Fig. 1a). The preferential

consumption of the lighter isotope by heterotrophic bacteria increases $\delta^{15}N$ in SPM 365 during decomposition (De Brabandere et al., 2002; Caraco et al., 1998), and most 366 probably induced the δ¹⁵N increase in shrimp pond effluents SPM during our experiment 367 368 (Fig. 4b). However, the decrease of DIN concentrations at the end of the experiment (Fig. 1a) was unexpected. This nitrogen was not transferred to the SPM (Fig. 1b) and 369 370 the nitrogen loss can only be explained by the implementation of a denitrification 371 process, leading to the release of gaseous forms of nitrogen to the atmosphere. 372 Denitrification generally occurs only in anaerobic condition (Chen et al., 2012), which 373 should not have happened in our experiment in which water was continuously mixed with pumps. Nevertheless, mature biofilms may have developed on the bucket walls and 374 in SPM microniches during the experiment and supplied a microbial habitat that contains 375 both aerobic and anaerobic conditions where denitrification could take place (Li et al. 376 2017). 377

4.3. Mixing of shrimp farm effluents with river water

Conversely to EF, significantly null decomposition rates in RV (Table 3) indicated 380 381 that organic matter was poorly processed during the experiment and that SPM was in an advanced state of decomposition, as we already evidenced in a previous study (David et 382 al. 2019). The SPM is thus poorly reactive and the transformation processes measured 383 384 in MI can be mainly attributed to the input of shrimp pond effluents. In the absence of interaction effect between EF and RV (e. g. RV inhibiting the degradation of EF or EF 385 386 inducing a priming effect promoting the degradation of RV), we expected measured FA 387 to remain between the values obtained for EF and RV during the entire experiment.

388 In MI, no maintaining of PUFA relative proportions was measured during the first 24h of the experiment, conversely to EF (Fig. 3), suggesting that phytoplankton cells 389 390 immediately died and started to decompose just after water mixing. This is confirmed by 391 the δ^{13} C of SPM, which immediately increased in MI due to microbial degradation, unlike in EF where cell respiration and microbial degradation occurred successively and 392 393 showed two different trends in SPM δ^{13} C variation (Fig. 4a). This immediate cell death in 394 MI was not due to light depletion, as there was no light available in both MI and EF, but 395 rather to the mixing of the two different water masses. It may have occurred because of 396 a virus present in RV or the sudden change in environmental conditions (pH, salinity, etc.) and/or increased oxidative stress (yet of poorly understood origin; Escher et al. 397 2013) that may have activated programmed cell death (Bidle and Falkowski, 2004). 398 Although the volume of shrimp pond effluents released in the environment is unknown, it 399 400 is necessarily lower than 10% (the ratio used in our experiment) of this large river 401 discharge. The changes in environmental conditions undergone by the shrimp pond 402 effluents released in mangrove channels are thus at least as intense as in our 403 experiment and immediate cell death would most probably also occur in natural conditions. Decomposition rates k1 were lower than those measured for EF (Table 3) 404 but we may expect the fraction originating from the 90% of river water not to being 405 406 decomposed. During the second step (T24 to D4), decomposition rates k2 were mostly 407 not significantly different from 0 and total FA even increased (Table 3), along with a two-408 fold increase in POC concentrations (Fig. 2a), suggesting that the input of shrimp pond effluents in river water may have stimulated primary producers and lipid synthesis. 409

410 The FA 18:1 ω 7 showed an interesting dynamic in MI since its relative proportion 411 increased between T0 and D4 up to values that exceed proportions measured in both 412 EF and RV (Fig. 3). Its temporal trend was different from that of the BrFA's one, which 413 never exceeded either that of EF or RV and suggesting that specific bacterial strains may have grown in MI, probably as a result of substrate availability brought by EF and/or 414 415 the bacterial inoculum brought by RV. The FA 18:1ω7 is commonly used as a bacterial 416 biomarker in natural environments (Dalsgaard et al., 2003; Meziane and Tsuchiya, 2000). Marty et al. (1996) measured the degradation of FA from urban wastes in 417 418 seawater and also found a significant production of FA 18:1w7 during the first days of their experiment followed by its decrease after 5 days of incubation. Studying the 419 decomposition of pure phytoplankton strains, Pan et al. (2014) found that FA 18:1ω7 420 became a major component (20-30% of total FAs) during cells microbial degradation. 421 422 Such elevated proportions of the FA 18:1w7 were previously found in phospholipids of alphaproteobacteria, such as Paracoccus denitrificans, which are involved in aerobic 423 denitrification (Zelles, 1997). Further analysis (e.g. DNA) would be required to 424 investigate the presence of aerobic denitrifying bacteria in decomposing shrimp pond 425 effluents, which may have consequences on the release of greenhouse gases in the 426 atmosphere such as NO and N₂O (Ji et al., 2015; Queiroz et al., 2019). In natural 427 428 conditions, Aschenbroich et al. (2015), found a higher concentration of FA 18:1ω7 in 429 mangrove sediments receiving shrimp pond effluents during the active farm period 430 compared to the non-active period and also attributed this increase to the grow of specific bacterial strains. We thus suggest that the FA 18:1w7 represents a potential 431 biomarker of anthropogenic substance (i. e. shrimp farm effluents or urban sewage) 432 releases in natural waters. Finally, shrimp farm effluents are rich in PUFA, that are of 433

high economic value. Developing methods to recover lipids from these effluents may
bring additional income to farmers, as well as avoiding excessive inputs of potential
polluting substances to the nearby environments.

438 5. Conclusion

439 Our study confirms that shrimp pond effluents are enriched in phytoplankton and 440 nitrogen compared to mangrove waters. Placed in dark conditions, phytoplankton cells first depleted their intracellular storage lipids, leading to a 50% loss of FA during the first 441 442 24h of the experiment with little effect on relative proportions. Then, cells death led to changes in FA relative proportions with preferential degradation of PUFA, leading to a 443 444 total of 75% FA loss after 4 days of incubation. In contrast to shrimp pond effluents 445 alone (EF), the mixture of shrimp pond effluents + river water (MI) induced immediate phytoplankton cells death, most likely due to the sudden change in environmental 446 conditions and representative of the processes that could happen in the natural 447 environment. The degradation of SPM was then accompanied by the growth of specific 448 bacterial communities (yet undetermined and characterized by especially high levels of 449 450 the FA 18:1 ω 7), as indicated by higher relative proportions of the FA 18:1 ω 7 compared 451 to that of EF or RV taken in isolation. This result confirms our hypothesis that the mixing 452 of waters favors specific bacterial strains and/or specific degradation pathways. As a 453 consequence, shrimp ponds effluents release in mangrove waters may impact the nutritional quality of SPM by modifying the balance of fatty acids that filtering organisms 454 are expected to feed on. High proportions of the FA 18:1w7 in mangrove sediments 455 were also associated to the nearby shrimp farming activity in New Caledonia 456

457 (Aschenbroich et al. 2015). We suggest that the FA $18:1\omega7$ represents a potential 458 biomarker of anthropogenic substance (e.g. shrimp farm effluents, urban sewage) 459 releases in natural waters, thus confirming our hypothesis that specific fatty acids may 460 be used as tracers of shrimp farm effluent releases (although not exclusively targeting 461 shrimp farm effluents) in marine environments.
