# 19 Abstract

Glycans analysis is challenging due to their immense structural diversity. Isotachophoresis was investigated as separation method for the purification of isobaric sulfated disaccharides prior to their characterization by Mass Spectrometry (MS) and tunable IR multiple photon dissociation (IRMPD). This proof of feasibility study was applied to the separation and characterization of chondroitin sulfate (CS) disaccharides. ITP separation conditions were optimized. Separation starts using a 2.5 mM chloride ions and 10 mM glycine at pH 3.2 solution as leading electrolyte and a terminating electrolyte composed of formic acid 2.5 mM and glycine 10 mM at pH 3.5. The CS disaccharides sample were prepared in the terminating electrolyte. The length of injection was also investigated in order to create longer plateau-like bands of pure solutes. This strategy was helpful for collecting fraction at such microseparation scale. Indeed, capillary ITP affords the injection of few tens of nanoliter of sample. Fractionation of the CS disaccharides mixture in isolated ITP bands and collection of solutes were successfully done using a HPC coated fused silica capillary of 1m-length and 75  $\mu$ m of internal diameter. Collected fractions in a final of volume 10  $\mu$ L were analyzed by CZE, tandem MS and IRMPD spectroscopy. The purity of each fraction is higher than 90% and is well-adapted to IRMPD characterization.

#### 1. Introduction

A general trend in analytical chemistry concerns the development of original approaches opening new perspectives in the context of complex molecules analysis and/or characterization. Such analyses are driven, for example, by the pressing demand of biologists investigating biomolecules and bio-molecular interactions as well as pharmacists qualifying new biologic drugs that enter the pharma market, to mention just a few. Dealing with complex samples, oligosaccharides analysis (also referred to as carbohydrates or glycans) are very exciting due to their inherent structural complexity and importance in biological and physiological processes through the regulation of their various protein partners. [1,2] Glycosaminoglycans (GAGs) are of particular importance in this context. Their presence on the cell membranes and in the extracellular matrix plays a critical role in the intercellular communication in organisms [3,4]. The GAG family, composed of 5 members: hyaluronan (HA), heparan sulfate (HS; including the highly sulfated form heparin), chondroitin sulfate (CS), dermatan sulfate (DS) and keratin sulfate (KS), are linear, highly charged, polysaccharides, composed of repeating disaccharides units. Understanding the structure of GAGs via building blocks composition, blocks connectivity, stereochemical configuration and sulfation patterns, represents a major analytical challenge. [5] Standard approaches for GAGs characterization, rely on depolymerization

reactions (chemical or enzymatic reactions) followed by fractionation for their further structural identification by sensitive mass spectrometry and nuclear magnetic resonance experiments [6,7]. Such bottom-up approaches benefit from optimal fractionation methods. Chromatographic methods such as size-exclusion chromatography (SEC) and anion exchange chromatography (AEX) as well as capillary electrophoresis are widely used and even coupled to one another for the separation of heterogeneous mixtures before their characterization. Each have their pros and cons and there is still great way of improvement in the sample preparation [6]. Underivatized oligosaccharides are hydrophilic species that can be separated in ion exchange (IEX), ion-pair chromatography (IPC) and HILIC modes. With respect to mass spectrometric detection, HILIC is usually preferred as this chromatographic mode, compared to IEX and IPC, does not suffer from ionization suppression effects due to mobile phase components. But this separation mode has not always been effective in resolving isomeric oligosaccharides [6,8]. With regard to sample volume, standard chromatographic autosamplers require often few tens to hundreds microliters of sample volume even when low volume of sample (i.e. 1 µL) is injected. Capillary electrophoresis is an alternative and powerful separation technique for and ionized compounds. Its separation mechanism depends on the ratio of the ionic charge to the hydrodynamic radius that determines the effective mobility of ionic species in a given background electrolyte. The high peak efficiencies in CE lead to very narrow peaks (a few seconds) requiring high sampling rate detection systems. Isotachophoresis (ITP) is a powerful but often overlooked electrokinetic separation technique because its unique plateau-like signal signature may be disturbing for chromatographers accustomed to work with peak signals. This technique is amenable to work with small volume of crude samples [9] (no additional sample preparation needed before analysis) and produces pure solute bands (without impurities like salts or organic modifiers that impede subsequent MS characterization). Capillary ITP was successfully applied to the preconcentration and microseparation of heparin and heparan sulfate samples on-line coupled to NMR detection via a 1-mm microcoil probes wrapped around the fused silica capillary [10,11]. The plateau-like signals of ITP was well-adapted to such specific microcoil NMR probes and the relatively long acquisition time required for NMR (1.4 s). IRMPD spectroscopy benefits from the sensitivity of Mass Spectrometry and the structural resolution of IR spectroscopy: it is a powerful tool to deduce detailed structural information on the monosaccharide content and stereochemistry of the glycosidic linkages [10-12]. However, the acquisition time required to obtain an IR spectrum using this technique is several minutes, which is very long compared to standard in-line detectors of separation methods. Therefore, the online coupling of IRMPD with peak signal analytical separation methods is a tremendous challenge. [16]

In this context, we propose capillary ITP as microseparation technique prior to IRMPD characterization. Capillary ITP was investigated due to its plateau-like signals that allow more time for relatively long acquisition time for the detection system or for the collection of pure bands of solutes for off-line coupling with sophisticated characterization methods at the microscale. The proof of feasibility was demonstrated with the separation of two chondroitin sulfate disaccharide isomers, namely CSA (ΔU(1-3)GalNAc,4S) and CSC (ΔU(1-3)GalNAc,6S). Chondroitin Sulfates like other GAGs display substantial diversity within tissues and molecular diversity across different tissues and over developmental time [3] and are involved in controlling neurogenesis, neuronal plasticity and regeneration after injury to the central nervous system for example. In addition, it was demonstrated that the specificity of interaction of CS with proteins depends on the level and distribution of sulfation [4]. The ITP conditions were optimized for the separation of these two CS disaccharides isomers. Collected fractions were then characterized by CZE to determine the purity yield. Finally, the collected fractions were analyzed by IRMPD by nanospray infusion, demonstrating the effectiveness of such coupling at the microscale.

#### 2. Materials and methods

## 2.1. Reagents and chemicals

Methanol (HPLC grade), triethylamine (TEA), dipotassium hydrogen phosphate ( $K_2HPO_4$ ), O-phosphoric acid, sodium hydroxide (NaOH), acetic acid, hydroxypropylcellulose (HPC, Mw ~100,000), hydrochloric acid, glycine, formic acid were purchased from Sigma Aldrich (France). Chondroitin sulfate disaccharide standards  $\Delta U(1-3)GalNAc,4S$  (CSA) and  $\Delta U(1-3)GalNAc,6S$  (CSC) were purchased from Iduron (ALderley Edge, UK). Stock solutions of each chondroitin sulfate disaccharides (CSA and CSC) were prepared in ultra-pure water at 100 mM. Acetic acid (AcOH) was purchased from Riedel-de Haënn (Riedel-de Haënn, Seelze, Germany). All aqueous solutions were prepared using >18 MΩ-cm water (Millipore, Molsheim, France). Polyimide (TSP)- coated fused-silica capillaries were purchased from Polymicro Technologies (Polymicro Technologies, Arizona, USA).

# 2.2. HPC Coating protocols

Capillary liquid manipulations were controlled by pressure using the microfluidic flow controller MFCS-100 system (Fluigent, France). This system is useful to fill, wash and dry capillaries.

The HPC coating procedure follows the protocol proposed by Koval et al [17]. Briefly, a 5 % (w/v) HPC aqueous solution was flushed through 1 m of polyimide coated fused silica capillary (75  $\mu$ m ID and 375 OD  $\mu$ m) at 5 bars pressure. The capillary was placed in a gas chromatography oven (HP 5890 series II GC system) heated at 60°C, and flushed with nitrogen at 1 bar pressure, for 10 minutes. The temperature was increased up to 140°C with a 5°C/min ramp and kept at 140°C for 20 min.

## 2.3. ITP experiments

- ITP experiments were carried out on an Agilent HP3DCE instrument (Agilent Technologies, Waldbronn, Germany) equipped with a diode array detector (detection at 230 nm).
- 123 Separations were done in a 35-cm long HPC coated fused silica capillary (75-μm id / 365 μm od).
- Otherwise stated in the text, ITP experiments were performed using a pH 3.2 leading electrolyte composed of HCl 2.5 mM, glycine 10mM and a pH 3.5 terminating electrolyte composed of formic acid 2.5 mM and glycine 10 mM. Mixtures of CSA and CSC at 1 mM each were prepared in the terminal electrolyte. Injections were done under hydrodynamic pressure mode.

## 2.4. CZE experiments

Capillary zone electrophoresis experiments were carried out on an Agilent 7100 CE instrument (Agilent Technologies, Waldbronn, Germany) equipped with a diode array detector. Separations were done in a 35-cm length HPC coated fused silica capillary (75- $\mu$ m id / 365  $\mu$ m od). Prior to each injection, the capillary was equilibrated by flushing with the background electrolyte (formic acid 50 mM and glycine 100 mM pH 3.24) for 30 sec. Samples were injected under hydrodynamic mode by applying a 5 mbar pressure for 1s. Separation was done at - 20 kV.

## 2.5 Mass Spectrometry and IRMPD spectroscopy

Off-line coupling experiments were realized by injecting 22 nl of the 1 mM chondroitin sulfate disaccharides mixture (corresponding to 44 pmol of each chondroitin sulfate disaccharides). Bands collection of CSA and CSC after ITP separation were done in  $10 \, \mu L \, H_2O$  and diluted in  $10 \, \mu L \, MeOH$ . MS analysis was carried out in a commercial mass spectrometer (Thermofinnigan LTQ XL) equipped with a nanospray ionization source set in negative mode (production of deprotonated ions) and a linear ion trap analyzer. Tandem MS experiments are performed via collision induced dissociation (CID) in a helium collision gas. A similar setup used for IRMPD analysis was previously described by Schindler *et al.*[18]. In brief, the mass spectrometer is modified to allow irradiation of the trapped ions by a laser beam produced by a YAG-pumped tunable IR OPO/OPA. This enables in situ gas-phase IRMPD (InfraRed Multiple Photon Dissociation) spectroscopy of the trapped ions. Excitation of a vibrational

mode by the laser induces photofragmentation, which is detected by mass spectrometry. The photofragmentation yield is calculated using the formula: IRMPD yield =  $-\log[I_{parent} \div (I_{parent} + I_{fragment})]$ , where  $I_{parent}$  is the intensity of the parent ion and  $I_{fragment}$  is the total intensity of the fragments detected after laser excitation. The fragmentation yield is then monitored as a function of the wavenumber to retrieve the absorption spectrum of the analyte. The spectral range 2700-3700 cm<sup>-1</sup> was scanned at 1 cm<sup>-1</sup>/s, which correspond to an acquisition time of 17 minutes. In these conditions mass-selected ions were isolated and irradiated for 500 ms per photofragmentation MS spectrum and MS spectra were not averaged. The reference IRMPD spectra of pure CSC and CSA standards were measured on a different setup, as described in [13].

## 3. Results

- 3.1. Determination of the optimal ITP separation conditions
- 158 Choice of the electrolytes (pH and nature)
- As for other differential migration methods, the condition for ITP separation is that the ionized solutes in the sample will separate whenever their migration rates in the mixed state are different.

The two chondroitin sulfate disaccharides will better separate if the pH in the mixing zone increases the difference in their respective effective mobility. The electrophoretic mobility of the two chondroitin sulfate disaccharides was thus first investigated in Capillary Zone Electrophoresis in acidic conditions due to the weak acidic properties of the CS disaccharides (carboxylic acid and sulfate groups)[19]. Figure 1 presents the relative electrophoretic mobility difference between the two CS disaccharides at a pH ranging from 2.18 to 4.06. The largest relative electrophoretic mobility difference was observed between pH 3.21 to 3.45. This pH range was thus considered optimal for the ITP separation and was fixed for the preparation of the leading electrolyte and terminal electrolyte.

A high effective mobility constituent such as chloride (strong ionic species commonly used in ITP) must be used as leader. The pH of the leading electrolyte was adjusted using glycine to pH 3.2. To cope with the objective to form long "plateau-like" bands of pure solute, low chloride leading electrolyte concentrations were investigated (ranging from 1 to 10 mM). The lowest concentration that can be used is however limited by the minimal current that can be carried by the electrolyte and controlled accurately (down to  $1\mu$ A) by the CE instrument. The best compromise for chloride concentration versus applied current was 2.5 mM.

Considering the mobility of the chondroitin sulfate disaccharides in this pH range, formate anions were used as constituent of the terminating electrolyte. Formic acid (pKa 3.75, formate electrophoretic mobility 5.66  $10^{-4}$  cm<sup>2</sup> V<sup>-1</sup> s<sup>-1</sup>)[20] has an effective mobility below pH 3.5 lower than  $2.18 \ 10^{-4}$  cm<sup>2</sup> V<sup>-1</sup> s<sup>-1</sup>, which is a lower mobility value than the mobility of CS disaccharides.

The terminating electrolyte was thus prepared by adjusting the pH of the formic acid solution with glycine as counter buffering and counter constituent.

## - Sample zone optimization

ITP separation of CS disaccharides injected individually. In first approach, each chondroitin was injected separately (Figure 2A, blue and orange plot) after conditioning the capillary with the leading electrolyte (HCl 2.5 mM, Glycine (10 mM) pH 3.5). ITP separation was initiated by applying a constant current between the inlet side of the capillary immersed in the terminating electrolyte and its outlet sideimmersed in the leading electrolyte. While contactless conductivity was also tested, the difference in conductivity of the two CS disaccharide zones is quite low. Hence it is preferred to monitor the separation using UV detection. A plateau was detected at the optimal wavelength of 230 nm for the two CS disaccharides. The two CS disaccharides present a relatively different absorbance that is useful to attribute the signal obtained to the chondroitin passing through the detector. The two CS disaccharides were then injected successively (CSC was injected in first position). Two plateaus were obtained and the UV signal for each chondroitin (Fig2A, purple plot) was comparable to the signal observed for the individual ITP separated CS disaccharides. UV detection is useful for monitoring electrokinetic separation using commercial instrument as the UV detection is done incapillary, the two CS disaccharides are detected at 230 nm and can be differentiated.

ITP separation of CS disaccharides in mixture. A mix of the two CS disaccharides solubilized in water was injected according to the previous experimental conditions. Only one plateau was observed (Figure 2B, grey plot). The two CS disaccharides were not separated in these experimental conditions. The pH of the sample zone is also an important experimental parameter for the separation of ionic species in ITP [21]. In order to trigger the separation at the early stage of the ITP separation, the pH of the sample zone was adjusted to 3.2-3.5. The CS were diluted in the terminating electrolyte to adjust the pH. The buffering of the sample zone separation allowed to successfully separate the CS disaccharides (Fig 2B, dark plot). The ITP separation leads to the formation of two plateaus of increasing UV absorbance signals. The more mobile CSC solute is detected first and CSA second.

# 3.2. Fractionation/collection of the ITP separated CS disaccharides

- Optimization of the injection volume

For in-line or off-line coupling, preparation of long band lengths of pure solute would be obviously highly valuable. This is ever true at the miniaturized scale where collecting fraction is not easy. In order to maximize the band width, a 1-m long HPC coated capillary (75  $\mu$ m ID) was used. Indeed, the length of capillary needed to separate efficiently the two CS disaccharides increases with the quantity injected. A 1-m column is the longest capillary compatible with our instrumental set-up. This is due to the low leading electrolyte concentration used. Indeed, it is difficult to maintain constant current during the separation using longer capillary.

The sample volume was increased linearly by adjusting the injection pressure during the injection step (Figure 3). Up to 30 mbar, the separation led to the formation of two plateaus. At 40 mbar, two plateaus were still detected but the boundary between the two plateaus seemed less pronounced and at higher injection pressure conditions (50 mbar) 3 plateaus were observed. This intermediate plateau corresponds to a mixing zone of CS A and CS S between the two pure bands in formation. For the following experiments, the injection conditions were set to 30 mbar for 10 sec. The linear velocity of mobile phase at 30 mbar was estimated to be 0.05 cm/sec using leading electrolyte. This corresponds to an injection plug length of 5 mm. After separation, the band lengths (plateau) were about 12 mm (this was estimated by measuring the duration of plateaus under pressure after their formation by ITP).

In the context of miniaturized separation methods, the optimization of the ITP separation conditions led to increase the injection volume up to about 22 nL and the formation of individual bands of solutes of about 12 mm highlighting the potential interest of such methods for sample preparation at the miniaturized scale.

#### - Fractionation of the two chondroitins and analysis of each fraction by CZE

Under the optimized separation conditions, the two CS disaccharides were well-separated and formed two plateaus of more than 1 cm length. Fractionation of the sample after separation was conducted by collection of a fraction of each plateau in 10  $\mu L$  of water. From the experimental point of view, the ITP separation was stopped before complete elution of the CS disaccharides from the

capillary. The outlet vial was then replaced by a vial containing a low volume conical insert filled with 10 μL of water. The fraction of pure solute selected was eluted under hydrodynamic flow mode (50 mbar). The two fractions were recovered using two different ITP separations. The hydrodynamic flow is convenient to accurately fractionate a part of the band, however it was supposed that during this step, all interfaces (CSC/CSA, CSA or CSC/electrolyte) undergo band diffusion. This is expected to mix the two separated chondroitins and thus affect their purity. Purity of each collected fraction was assessed by capillary zone electrophoresis (Figure 4 B). Regarding the electrophoregram obtained using a chondroitins standard solution, two pairs of chondroitin peaks were detected. Each pair was attributed to chondroitin sulfate anomer forms. The first peak pattern corresponds to the CSC chondroitin sulfate and the second one to the CSA. Each collected fraction presents a major chondroitin sulfate isomer. Fraction 1 correspond to the CSC isoform with a purity of 89.6% and fraction 2 corresponds to the CSA isoform with a purity of 94.6 %. The isolation of oligosaccharide components for structural investigations must have a purity greater that 80% to 90 %. Moreover, organic impurities or salts that can impede the characterization must also be minimized [6]. These are generally observed in HPLC separations for example. ITP seems well-adapted for the separation and purification of CS samples.

# 3.3. IRMPD analysis

Each collected fraction was characterized by IRMPD spectroscopy. The two disaccharides (CSA and CSC) derived from chondroitin sulfate are challenging to characterize as they possess two neighboring sites of sulfation on the *N*-acetyl galactosamine that is O6 and O4. Infrared multiple photon dissociation spectroscopy (IRMPD) was recently applied to the characterization of isomeric glycosaminoglycan disaccharides from heparins and chondroitin sources and has shown great potential as a novel structural tool for carbohydrates [13]. However, this powerful technique requires relatively long time of acquisition, which is not convenient for coupling with most separation methods [16,22]

The MS/MS spectra of CSA and CSC are shown in the top layer of Figure 5. The singly deprotonated precursor ions are observed at m/z 458. CSA features a main fragment at m/z 300, which corresponds to the sulfated GalNAc moiety and is generally considered as its diagnostic fragment ion; and CSC features a main fragment at m/z 282, which is generally considered as its diagnostic fragment ion. [22]. [23,24]. Several authors reported that the fragmentation patterns are highly dependent on the experimental conditions and MS/MS analysis must be carried out with extreme

caution. Yet, LC coupled to MS and/or tandem MS analysis is the most widespread approach for the analysis of glycosaminoglycan composition [25].

The use of the IR vibrational spectrum of molecular ions(sensitive towards structural details) enables the investigation of functional groups, intra- or intermolecular interactions and molecular conformations bringing additional information compared to the MS/MS analysis. The IR spectrum presents intrinsic features, which do not depend on the MS conditions, that benefits to the saccharides analysis by recording IR fingerprints of the CS disaccharides for unambiguous characterization. The IRMPD spectra of the two collected fractions show an apex at 3410 cm<sup>-1</sup> and 3375 cm<sup>-1</sup> attributed to the CSA and CSC disaccharides respectively, which is in good agreement with reference spectra of CS disaccharides standards [13]. In the specific case of CSA and CSC, the MS/MS fingerprint is sufficient to distinguish between the isomers, and the differences in the IRMPD signatures are relatively subtle. However, IRMPD has proven useful to distinguish between a variety of isomers when tandem MS is ambiguous. [14] Therefore, the presented example supports that the fractionation of tens of nL of isobaric saccharides mixtures using ITP can be applied to the off-line collection of high purity compounds for further IR spectroscopic characterization. This demonstrates the pertinence of such coupling strategy at the microscale separation.

## 4. Conclusion

Electrokinetic separation of isomeric chondroitin sulfate disaccharides (CSA and CSC) at the microscale was achieved by isotachophoresis and fractions of high purity were collected for further structural analysis. ITP generates plateau-like bands of purified compounds which is particularly advantageous for collecting sample at the microscale or for coupling with long acquisition time detection methods. In contrast with ion exchange chromatography, ITP does not require the use of high salt concentration that can interfere severely with Mass Spectrometry. Such proof of feasibility aims at bringing an original coupling strategy with sophisticated spectroscopic characterization method of oligosaccharides. The molecular characterization of such complex molecules requires combined approaches of separation and characterization. Optimization of the ITP conditions allows the separation of two isobaric CS disaccharides from few tens of nL sample solution and their collection in 10  $\mu$ L. The purity of the collected fraction, more than 90 %, is well-adapted to off-line coupling with gas phase IR action spectroscopy. This case study validates this proof of feasibility study using two similar CS disaccharides GAGs precursor. In order to fully respond to biological demand, the in-line coupling ITP-IRMPD spectroscopy would be further investigated allowing miniaturized and automated analysis of complex samples.

- Figure 1. Plot of the relative electrophoretic mobility difference between CS A and CS C as a function of the pH of the glycine/HCl electrolyte. Electrophoretic mobilities were determined by capillary zone electrophoresis using the procedure described by Vigh et al. [18].
- 396 Figure 2. Isotachophoregrams of each individual chondroitin (CSA and CSC at 1 mM) injected separately and injected in stacked configuration (CSC + CSA) (A) and ITP separation of CS 397 398 disaccharides in mixture in water or in the terminating electrolyte (B). Conditions for (A): HPC-coated 399 capillary length: 50 cm, Injection 50 mbar for 3 sec. Applied Current = -4 μA and in mixture (CSA and 400 CSC at 1 mM each in water (grey) and solubilized in the terminating electrolyte (black)). Conditions 401 for (B): ITP of CS disaccharides solubilized in water was realized in a 45.9 cm-length HPC-coated 402 capillary, injection 5 mbar for 8 sec. Applied Current = - 5μA. ITP of CS disaccharides solubilized in 403 terminating electrolyte was realized in a 58.7 cm length HPC-coated capillary, injection 20 mbar for 404 4sec). Applied Current =  $-5\mu$ A.

Influence of the injection pressure of CS disaccharides mixture at 1 mM solubilized in the terminating electrolyte, separation at -3 μA, HPC-coated fused silica capillary (75 μm id, total length 1m), UV detection at 230 nm, injection time (10 sec), corresponding injection volumes 7.8 to 39 nL.
  - Figure 4. ITP separation of chondroitin sulfate disaccharides (CSA and CSC) in a 1-m long HPC-coated capillary and fractionation of the separated solutes. Injection of chondroitin sulfate disaccharides at 1 mM each in terminating electrolyte, separation under -3  $\mu$ A, detection at 230 nm, injection 30 mbar/ 10 sec (A). CZE separation of the two collected fractions and of the mixture of the two chondroitin sulfate disaccharides. HPC Fused silica capillary (75  $\mu$ m id, 30-cm total length, 21.5 cm-length to detection), UV detection at 230 nm, BGE: Formate 50 mM, glycine 10 mM, pH 3.5, injection CS standard mixture (20  $\mu$ M in terminating electrolyte) (-10kV, 5 sec) injection of the CS fraction (-10kV, 10 sec), response time 0.063 sec (40 Hz).
    - Figure 5. IRMPD analysis of fraction 2 (A) and fraction 1 (B). Top panels: CID spectra of singly deprotonated disaccharides (m/z 458). Center panels: IRMPD signatures of the m/z 458 ions. Lower panels: reference IRMPD spectra of pure CSA (A) and CSC (B) disaccharide standards. Strips corresponding to the maximum of absorption of CSA (light red) and CSC (light blue) standards are overlaid for facile structural identification.
