# **Energy Management Strategy Based on a New** Adaptive Filtering Algorithm for **Battery-Ultracapacitor Electric Vehicles**

Abstract—This paper presents an energy management algorithm based on a new adaptive filtering method for a multisources battery-ultracapacitor electric vehicle. Compared to literature where most of the filtering techniques are developed based on empirical knowledge of the system, the proposed adaptation method is performed online to optimize a cost function that considers the state of charge of the ultracapacitor. The developed approach allows a better power sharing between both electric sources while respecting their constraints and physical limitations. Simulations on Matlab/Simulink validate the performances of the proposed method.

Index Terms-Electric vehicle, Energy management strategy, Ultracapacitor, Battery, Adaptive filtering.

#### I. INTRODUCTION

The transport sector is witnessing the gradual integration of electric vehicles in recent years. Electric vehicles have the advantage of not emitting atmospheric pollutants in operation, but are however disadvantaged on the autonomy side, because of the batteries limitations [1].

To improve the autonomy of the vehicle, preserve the battery life time and reduce the system weight, sources like the UltraCapacitor (UC) or the fuel cell could be added [2]. However, a multi-sources system can only be effective if it is controlled by an Energy Management Strategy (EMS) that coordinates the power splitting between sources taking their characteristics and limitations into account. The main goal of EMS is essentially to coordinate the power flows between the sources and the load so as to improve the system global efficiency. The used power sources are usually of different natures and the EMS must implement strategies that aim not only to take advantage of each source but also to extend their lifetime as much as possible.

EMS using fixed frequency filtering represents simple method of spectral distribution of energy between energy sources to protect those with low internal dynamics such as the battery

or the Fuel Cell (FC). Unlike the methods using the optimal control and the dynamic programming which need to know in advance the entire load profile, the frequency approach has the advantage to achieve a real-time optimization; it has been applied for a Battery-UC system [3], a FC-Battery system [4], and FC-Battery-UC hybrid power systems [5], [6]. However, this technique has the disadvantage of not respecting the constraints on the State Of Charge (SOC) of the auxiliary storage system [3], [7]. Thus, to solve this problem, strategies using adaptive filtering have been developed. Unlike the fixed frequency method, the adaptive filtering approach adjusts the filter frequency depending on the UC state of charge.

In the literature, adaptive filtering techniques differ mainly by frequency update method. For example, a look-up table is used in [3] while a fuzzy controller is used in [7]. These techniques are mostly based on empirical knowledge of the system. Consequently, some arbitrary tunings are made and the resulted online frequency adjustment is not necessarily optimized.

This paper presents an EMS based on a new adaptive filtering method. In this method, the frequency adjustment is performed online in order to optimize a cost function related to the UC state of charge. It is supposed that the power sharing control system is organized hierarchically into two levels (see Fig.1) as in [8] [9]: the high level also called supervision layer and the low level. The EMS is implemented by the supervision layer that determines the reference powers for the different power sources, and imposes them to the system using a sub-layer (low level) based on power converter controllers. This paper mainly focuses on the development of the EMS supervision layer.

In what follows, first the description of the studied system is presented, then the developed EMS is introduced followed by the results of the simulations with some discussions and conclusion.

#### II. DESCRIPTION OF THE ENERGY CHAIN

As shown in Fig.1, the studied system is a vehicle with electric motorization powered via the DC bus by two sources: a battery and a pack of UC. The battery is considered as the main source of energy and the UC as the auxiliary one. Each source is connected to the DC bus via a reversible controlled power converter.

### A. Powertrain

Consisting essentially of the wheels, the speed reducer, the electric motor and its power converter, the powertrain must provide the required mechanical power for the movement of the vehicle according to the instructions imposed by the driver. In order to fulfill this role, it must be properly supplied with electrical energy by the energy sources. This necessarily involves an instantaneous estimation of the reference power taking into account the constituent elements of the vehicle and the driving environment. The required power to supply the powertrain of an electric vehicle of mass M, and of frontal surface S evolving at a speed v is given by (1):

$$P_{pt} = \frac{v}{\eta_{pt}} \left[ \frac{1}{2} \rho_a S C_x v^2 + Mg\mu cos(\alpha) + Mgsin(\alpha) + M\frac{dv}{dt} \right]$$

where  $\alpha$ ,  $\rho_a$ ,  $v_a$ ,  $C_x$ ,  $\mu$  and  $\eta_{pt}$  are respectively, the slope of the road, the air density, the wind speed, the vehicle aerodynamic coefficient, the rolling coefficient, the gravitational acceleration, and the efficiency of the powertrain. The values of  $P_{pt}$ on a driving cycle constitute the power profile. In this work, the power profiles shown in Fig. 2 and 3 corresponding to the NEDC (New European Driving Cycle) and the IFSTTAR (Institut Français des Sciences et Technologies des Transports, de l'Aménagement et des Réseaux) are used. They represent urban driving cycles with regular braking and accelerations.

### B. The battery

The battery is a complex electrochemical system. In the literature, different approaches are used to model its behavior according to the desired objective [10] and [11]. In this work, a simple electrical model of the lithium-ion battery is used. This model consists of the association of a voltage source  $V_{bat}$  in series with the internal resistance  $R_{bat}$  (see Fig.1).

### C. Ultracapacitor

The UC uses the formation of an electrochemical double layers at the electrodes - electrolyte interfaces to store energy [12]. Because of its ability to provide/absorb important instantaneous powers, UC is used as auxiliary source to assist sources of low internal dynamic like battery. Among the existing models in literature to describe the UC dynamic behavior, there are in particular the distributed constant model, the localized constant model and the behavioral model with two branches [12], [13]. The model used in this work consists of the association of a capacitance  $C_{uc}$  in series with resistance  $R_{uc}$  (see Fig.1). Its state of charge  $SOC_{uc}$  is determined at each time t by :

$$\begin{cases} SOC_{uc}(\%) = 100(E_{uc} - E_{ucmin})/(E_{ucmax} - E_{ucmin}) \\ E_{uc} = E_{uc0} - \int_0^t P_{uc}(\tau) \cdot \eta_{uc}^{-p} \cdot d\tau \\ E_{uc0} = \frac{1}{2} \cdot C_{uc} \cdot V_{uc0}^2 \end{cases}$$

where:  $\eta_{uc}$ ,  $P_{uc}$  are respectively the efficiency and the power supplied or absorbed by the UC, p is the  $P_{uc}$  sign,  $E_{uc0}$  is the UC initial energy,  $V_{uc0}$  is the UC initial open circuit voltage,  $E_{ucmin}$  and  $E_{ucmax}$  are respectively the UC minimum and maximum energy.

#### III. ENERGY MANAGEMENT STRATEGY

The EMS in a multi-sources system must ensure a good distribution of the power  $P_{pt}$  requested by the powertrain between the energy sources while respecting the constraints and limits of each source in terms of power, power dynamics and UC state of charge. The battery is considered as the main source, ans thus, it is supposed to be adequately charged.

In the studied system, at each sampling k of period  $T_s$ , the constraints can be summarized as follows:

$$\begin{cases}
P_{pt}(k) = P_{bat}(k) + P_{uc}(k) \\
P_{batmin} \leq P_{bat}(k) \leq P_{batmax} \\
P_{ucmin} \leq P_{uc}(k) \leq P_{ucmax} \\
SOC_{ucmin} \leq SOC_{uc}(k) \leq SOC_{ucmax}
\end{cases}$$

where  $P_{bat}$  and  $P_{uc}$  represent the power supplied by the battery and the UC, respectively.

As shown in Figure 4, the energy management method developed here is based on filtering. The filtering frequency is determined online in order to optimize a cost function. The cost to be optimized here is the SOC of the UC which must be maintained in a certain range. This is necessary to ensure that the UC will continue to assist the battery for peak power demands. To realize the algorithm that will perform the desired task for each sampling, the first order low-pass filter is discretized.

#### A. Discrete model of the low-pass filter

As it is shown in Fig. 4, a first order low-pass filter is used to smooth the battery power reference. The relation between the filter input  $P_{pt}$  and output  $P_{bat}$  in the frequency domain is given by :

$$P_{bat} = \frac{\omega_c}{s + \omega_c} \cdot P_{pt},\tag{4}$$

where  $\omega_c(rad/s)$  is the filter cutoff frequency. In the time domain, equation (4) becomes :

$$P_{bat} + \omega_c P_{bat} = \omega_c P_{pt}.$$

Taking account of the initial conditions, the solution of the first-order differential equation (5) is given by :

$$P_{bat}(t) = e^{-\omega_c t} (P_{bat}(0) + \int_0^t \omega_c P_{pt}(\tau) e^{-\omega_c \tau} d\tau), \quad (6)$$

where  $P_{bat}(0)$  is  $P_{bat}$  initial value.

In discrete time, by a recurrent calculation, the relation (6) becomes:

$$P_{bat}(k) = P_{pt}(k) + (P_{bat}(k-1) - P_{pt}(k))e^{-\omega_c \cdot T_s}.$$

This last equation represents the first-order low-pass filter of cutoff frequency  $\omega_c$  model and discretized between two

samplings k - 1 and k.

# B. Energy management algorithm

At each instant k, the power requested by the powertrain is sent to the low-pass filter which determines the reference power of the battery  $P_{bat}$  for different values of  $\omega_c \in$  $[0, \omega_{cmax}]$  with a frequency step  $\delta \omega_c$  using the filter discrete model (8):

$$P_{bat}(k,\omega_c) = P_{pt}(k) + (P_{bat}(k-1) - P_{pt}(k))e^{-\omega_c \cdot T_s},$$

where  $\omega_{cmax}$  represents the maximum value of  $\omega_c$ . It can be determined objectively by  $\omega_{cmax} = 2\pi f_s$  with  $f_s$ , the battery specific frequency defined as the ratio of its specific power to its specific energy [7].

Taking account the constraints defined in (3), the UC power reference is determined by (9):

$$P_{uc}(k,\omega_c) = P_{pt}(k) - P_{bat}(k,\omega_c).$$

The optimal frequency  $\omega_{cOpt}$  is determined in the interval  $[0, \omega_{cmax}]$ , at each sampling so as to minimize a cost function C which takes into account the state of charge of the UC:

$$C(k,\omega_c) = |SOC_{ucref} - SOC_{uc}(k,\omega_c)|$$

where  $SOC_{ucref}$  is the reference value of the UC state of charge.

The minimum cost  $C_{min}$ , the corresponding optimal frequency, and the sources power reference are thus determined by:

$$\begin{cases}
C_{min}(k) = min(C(k, \omega_c)), \omega_c \in [0, \omega_{cmax}] \\
\omega_{cOpt}(k) = \operatorname{argmin}_{\omega_c} C(k, \omega_c) \\
P_{batref}(k) = P_{bat}(k, \omega_{cOpt}) \\
P_{ucref}(k) = P_{uc}(k, \omega_{cOpt})
\end{cases}$$

 $P_{batref}$  and  $P_{uctref}$  correspond to the reference powers of the battery and the UC which minimize the cost C between two samplings (k - 1 and k). Note that the developed adaptive filtering algorithm requires low computing time, and thus, it is therefore suitable for real-time implementation.

## IV. SIMULATION RESULTS

Matlab simulations of the developed algorithm were performed for NEDC and IFSTARR power profiles given in Section II. Recall that  $\omega_{cmax}$  depends essentially on the characteristics of the battery and the objectives of the energy management strategy. Generally, it is chosen as low as possible for a better protection of the battery from strong power dynamics. The performance of the developed algorithm are tested with  $\omega_{cmax} = 0.31rad/s$  obtained as explained in (III-B). The initial and the reference states of charge of the UC are set to 50%.

Fig. 5 and 6 show the battery and the UC power references determined by the developed adaptive filtering algorithm for the NEDC and IFSTTAR driving cycles, respectively. For each case, it can be noticed that due to the filtering effect, the dynamic power is provided by the UC while battery supplies the mean power.

The corresponding evolutions of the UC state of charge are shown in Fig.7. It can be noticed that the SOC of the UC never reaches its extreme values and returns at the end of the cycle to approximately less than +10% from the reference SOC. Indeed, the final SOCs of the UC are 59.5% and 55% for the NEDC and IFSTTAR driving cycles, respectively. Fig. 8 and 9 show how the frequency  $\omega_{cOpt}$  varies over the IFSTTAR and NEDC driving cycles. As expected, it varies between 0 and  $\omega_{cmax}$  according to the UC state of charge.

The developed energy management algorithm is compared to the classic passive filtering EMS with constant frequency. Fig. 10 shows the evolution of the UC's SOC for the classic filtering for the two driving cycles with  $\omega_c = \omega_{cmax} = 0.31 rad/s$ . It can be noticed that the final SOC deviates much from the reference SOC and even reaches its lower limit for the IFSTTAR driving cycle. From these simulations, it can be deduced that the developed adaptive algorithm gives better

results than the passive filtering while considering constraints on the UC's SOC.

The proposed adaptive EMS was also simulated with different initial UC state of charge values  $Soc_{uc0}$  to analyze its behavior regarding initial condition. Fig.11 and 12 show the evolution of UC state of charge for  $Soc_{uc0} = 90\%$  and  $Soc_{uc0} = 25\%$  for the two considered power profiles. It can be noticed that for each case, throughout the driving cycle, the algorithm tends to bring back the UC state of charge to its desired or reference value  $SOC_{ucref}$  which is set to 50%. Thus, the final UC state of charge values are very close to  $SOC_{ucref}$ . This behavior is very important as it ensures that, regardless of the driving cycle and of the initial UC state of charge, the UC will continue to assist the battery by providing the peak power with a good regulation of its state of charge.

### V. CONCLUSION

This paper presents a new adaptive filtering EMS for a battery-UC electric vehicle. Simulations with different power profiles and different state of charge scenarios, confirm that the developed EMS ensures UC's State of charge regulation while ensuring a pertinent frequency distribution of the power profile spectral between the battery and the UC. Indeed, in all cases, the low dynamic power demands are provided by the battery, while the peaks power are given by the UC.

The proposed adaptive filtering method is simple, low computational cost, and does not require empirical knowledge nor model-based controller development to adapt the filter frequency. Depending on the characteristics of the used battery, only the value of  $\omega_{cmax}$  must be set to apply the proposed method to the multi-sources electric system.

For future works, the improvement of the developed EMS with consideration of the system global efficiency while minimizing electrical losses will be our main topics.
