# SIGNATURE FOR PIECEWISE CONTINUOUS GROUPS 

OCTAVE LACOURTE


#### Abstract

Let $\widehat{\mathrm{PC}^{\bowtie}}$ be the group of bijections from [0, $1[$ to itself which are continuous outside a finite set. Let $\mathrm{PC}^{\bowtie}$ be its quotient by the subgroup of finitely supported permutations.

We show that the Kapoudjian class of $\mathrm{PC}^{\bowtie}$ vanishes. That is, the quotient map $\widehat{\mathrm{PC}^{\bowtie}} \rightarrow \mathrm{PC}^{\bowtie}$ splits modulo the alternating subgroup of even permutations. This is shown by constructing a nonzero group homomorphism, called signature, from $\widehat{\mathrm{PC}^{\bowtie}}$ to $\mathbb{Z} / 2 \mathbb{Z}$. Then we use this signature to list normal subgroups of every subgroup $\widehat{G}$ of $\widehat{\mathrm{PC}^{\bowtie}}$ which contains $\mathfrak{S}_{\text {fin }}$ and such that $G$, the projection of $\widehat{G}$ in $\mathrm{PC}^{\bowtie}$, is simple.


## 1. Introduction

Let $X$ be the right-open and left-closed interval $[0,1[$. We denote by $\mathfrak{S}(X)$ the group of bijections of $X$ to $X$. This group contains the subgroup composed of all finitely supported permutations is denoted by $\mathfrak{S}_{\text {fin }}$. The classical signature is well-defined on $\mathfrak{S}_{\text {fin }}$ and its kernel, denoted by $\mathfrak{A}_{\text {fin }}$, is the only subgroup of index 2 in $\mathfrak{S}_{\text {fin }}$. An observation, originally due to Vitali [10], is that the signature does not extend to $\mathfrak{S}(X)$.

For every subgroup $G$ of $\mathfrak{S}(X) / \mathfrak{S}_{\text {fin }}$, we denote by $\widehat{G}$ its inverse image in $\mathfrak{S}(X)$. The cohomology class of the central extension

0 \rightarrow \mathbb{Z} / 2 \mathbb{Z}=\mathfrak{S}_{\mathrm{fin}} / \mathfrak{A}_{\mathrm{fin}} \rightarrow \widehat{G} / \mathfrak{A}_{\mathrm{fin}} \rightarrow G \rightarrow 1
$$

is called the Kapoudjian class of $G$; it belongs to $H^{2}(G, \mathbb{Z} / 2 \mathbb{Z})$. It appears in the work of Kapoudjian and Kapoudjian-Sergiescu [6, 7]. The vanishing of this class means that the above exact sequence splits; this means that there exists a group homomorphism from the preimage of $G$ in $\mathfrak{S}(X)$ onto $\mathbb{Z} / 2 \mathbb{Z}$ which extends the signature on $\mathfrak{S}_{\text {fin }}$ (for more on the Kapoudjian class, see [3, §8.C]). This implies in particular that $\widehat{G} / \mathfrak{A}_{\mathrm{fin}}$ is isomorphic to the direct product $G \times \mathbb{Z} / 2 \mathbb{Z}$. One can notice that for $G=\mathfrak{S}(X) / \mathfrak{S}_{\text {fin }}$ we have $\widehat{G}=\mathfrak{S}(X)$; in this case the Vitali's observation implies that the Kapoudjian class does not vanish.

The set of all permutations of $X$ continuous outside a finite set is a subgroup denoted by $\widehat{\mathrm{PC}^{\bowtie}}$. The aim here is to show the following theorem:
Theorem 1.1. There exists a group homomorphism $\varepsilon: \widehat{\mathrm{PC}^{凶}} \rightarrow \mathbb{Z} / 2 \mathbb{Z}$ that extends the classical signature on $\mathfrak{S}_{\text {fin }}$.
Corollary 1.2. Let $G$ be a subgroup of $\mathrm{PC}^{\bowtie}$. Then the Kapoudjian class of $G$ is zero.

This solves a question asked by Y. Cornulier [4, Question 1.15].
The subgroup of $\widehat{\mathrm{PC}^{\bowtie}}$ consisting of all permutations of $X$ that are piecewise isometric elements is denoted by $\widehat{\text { IET }^{\bowtie}}$ and the one consisting of all piecewise affine permutations of $X$ is denoted by $\widehat{\text { PAff }}$. We also consider for each of these groups the subgroup composed of all piecewise orientation-preserving elements by replacing the symbol " $\bowtie$ " by the symbol " + ".
Let us observe that when $G \subset \mathrm{PC}^{+}$Corollary 1.2 is trivial. Indeed, in this case $G$ can be lifted inside $\widehat{\mathrm{PC}^{+}}$itself. However, such a lift does not exist for $\mathrm{PC}^{\bowtie}$ or even IET $^{\bowtie}$, as was proved in [4].

The idea of proof of Theorem 1.1 is to associate for every $f \in \widehat{\mathrm{PC}^{\bowtie}}$ and every finite partition $\mathcal{P}$ of $[0,1[$ into intervals associated with $f$, two numbers. The first is the number of interval of $\mathcal{P}$ where $f$ is order-reversing and the second is the signature of a particular finitely supported permutation. The next step is to prove that the sum modulo 2 of this two numbers is independent from the choice of partition. Then we show that it is enough to prove that $\left.\varepsilon\right|_{\text {IET }} \bowtie$ is a group homomorphism. For this we show that it is additive when we look at the composition of two elements of $\widehat{\mathrm{IET}^{\bowtie}}$ by calculate the value of the signature with a particular partition.

In Section 4, we apply these results to the study of normal subgroups of $\widehat{\mathrm{PC}^{\bowtie}}$ and certain subgroups. More specifically we prove:

Theorem 1.3. Let $\widehat{G}$ be a subgroup of $\widehat{\mathrm{PC}^{\bowtie}}$ containing $\mathfrak{S}_{\text {fin }}$ and such that its projection $G$ in $\mathrm{PC}^{\bowtie}$ is simple nonabelian. Then $\widehat{G}$ has exactly five normal subgroups given by the list: $\left\{\{1\}, \mathfrak{A}_{\text {fin }}, \mathfrak{S}_{\text {fin }}, \operatorname{Ker}(\varepsilon), \widehat{G}\right\}$.

We denote by $\widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$the subgroup of $\widehat{\mathrm{IET}^{+}}$composed of all right-continuous elements. We know that it is naturally isomorphic to $\mathrm{IET}^{+}$. The same is true when we replace $\mathrm{IET}^{+}$by $\mathrm{PAff}^{+}$or $\mathrm{PC}^{+}$. This allows us to use the work of P . Arnoux [2] and the one of N. Guelman and I. Liousse [5] where they prove that $\mathrm{IET}^{\bowtie}, \mathrm{PC}^{+}$and $\mathrm{PAff}^{+}$are simple. From this we deduce:
Theorem 1.4. The groups $\mathrm{PC}^{\bowtie}$ and $\mathrm{PAff}{ }^{\bowtie}$ are simple.

This gives us some examples of groups that satisfy the conditions of the Theorem 1.3.

Finally Section 5 is independent and we study some normalizers and in particular we show that the behaviour when we look the group inside $\widehat{\mathrm{PC}^{\bowtie}}$ or $\mathrm{PC}^{\bowtie}$ may not be the same. We denote by $\mathcal{R} \in I E T^{\bowtie}$ the map $x \mapsto 1-x$. Then we define $\mathrm{IET}^{-}$as the coset $\mathcal{R}$. $\mathrm{IET}^{+}$and $\mathrm{PC}^{-}$as the coset $\mathcal{R}$. $\mathrm{PC}^{+}$. Then the groups $\mathrm{IET}^{ \pm}:=\mathrm{IET}^{+} \cup \mathrm{IET}^{+}$and $\mathrm{PC}^{ \pm}:=\mathrm{PC}^{+} \cup \mathrm{PC}^{-}$are well-defined.
Proposition 1.5. The subgroup $\widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$(resp. $\widehat{\mathrm{PC}_{\mathrm{rc}}^{+}}$) is its own normalizer in $\widehat{\mathrm{IET}^{\bowtie}}$ (resp. $\widehat{\mathrm{PC}_{\mathrm{rc}}^{+}}$). The normalizer of $\mathrm{IET}^{+}\left(\mathrm{PC}^{+}\right.$respectively) in $\mathrm{IET}^{\bowtie}\left(\mathrm{PC}^{\bowtie}\right.$ respectively) is $\mathrm{IET}^{ \pm}\left(\mathrm{PC}^{ \pm}\right.$respectively).

## 2. Preliminaries

For every real interval $I$ we denote by $I^{\circ}$ its interior in $\mathbb{R}$ and if $I=[0, t[$ we agree that its interior is $] 0, t[$.

### 2.1. Partitions associated.

An important tool to study elements in $\widehat{\mathrm{PC}^{\bowtie}}$ and $\mathrm{PC}^{\bowtie}$ are partitions into intervals of $[0,1[$. All partitions are assumed to be finite.
Definition 2.1. For every $f$ in $\widehat{\mathrm{PC}^{\bowtie}}$, a finite partition $\mathcal{P}$ into right-open and left-closed intervals of $[0,1[$ is called a partition into intervals associated with $f$ if and only if $f$ is continuous on the interior of every interval of $\mathcal{P}$. We denote by $\Pi_{f}$ the set of all partitions into intervals associated with $f$.
We define also the arrival partition of $f$ associated with $\mathcal{P}$, denoted $f(\mathcal{P})$, the partition of $[0,1[$ composed of all right-open and left-closed intervals such that their interior is equal to the image by $f$ of the interior of an interval of $\mathcal{P}$.
Remark 2.2. For every $f$ in $\widehat{\mathrm{PC}^{\bowtie}}$ there exists a unique partition $\mathcal{P}_{f}^{\min }$ associated with $f$ which has a minimal number of intervals. It is actually minimal in the sense of refinement: $\Pi_{f}$ consists precisely of the set of partitions refining $\mathcal{P}_{f}^{\min }$.

### 2.2. Decompositions.

We define a family of elements which plays an important role inside our groups:
Definition 2.3. Let $I$ be a non-empty right-open and left-closed subinterval of $\left[0,1\left[\right.\right.$. The element $f \in \widehat{\mathrm{PC}^{\bowtie}}$ which sends the interior of $I$ on itself with slope -1 while fixing the rest of $[0,1[$ is called the $I$-flip. We define $a$ flip as any $I$-flip for some $I$.

From the definition we deduce a decomposition inside $\widehat{\mathrm{IET}^{\bowtie}}$ and $\widehat{\mathrm{PC}^{\bowtie}}$.
Proposition 2.4. Let $h$ be an element of $\widehat{\mathrm{IET}^{\bowtie}}$. There exist $f, g \in \widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$and $r, s$ finite products of flips and $\sigma, \tau$ finitely supported permutations such that $h=$ $r \sigma f=g \tau s$.
Proof. Let $h$ be an element of $\widehat{\operatorname{IET}^{\bowtie}}, n \in \mathbb{N}$ and $\mathcal{P}:=\left\{I_{1}, I_{2}, \ldots, I_{n}\right\} \in \Pi_{h}(\S 2.1)$. We denote by $h(\mathcal{P}):=\left\{J_{1}, J_{2}, \ldots, J_{n}\right\}$ the arrival partition of $h$ associated with $\mathcal{P}$. Let $g$ be the map that sends $I_{j}^{\circ}$ on $J_{j}^{\circ}$ by preserving the order and acts as $h$ for every left endpoints of $I_{j}$ for every $1 \leq j \leq n$. Note that $g$ is bijective and then belongs to $\widehat{\mathrm{IET}^{+}}$. For $1 \leq j \leq n$ let $r_{j}$ be the $J_{j}$-flip if $h$ is order-reversing on $I_{j}$ otherwise let $r_{j}$ be the identity. Let $r$ be the product of all $r_{j}$, we can notice that $r$ fixes all endpoints of $J_{j}$ for every $1 \leq j \leq n$. Then it is just a verification to check that $h=r g$. Now as $g$ belongs to $\mathrm{IET}^{+}$there exists $\sigma$ in $\mathfrak{S}_{n}$ such that $g=\sigma f$ with $f$ in $\mathrm{IET}_{\mathrm{rc}}^{+}$.
The other decomposition follows by decomposing $h^{-1}$ under the previous decomposition.
Proposition 2.5. For every $h$ in $\widehat{\mathrm{PC}^{\bowtie}}$ there exist $\phi$ and $\psi$ two order-preserving homeomorphisms of $\left[0,1\left[\right.\right.$ and $f, g$ in $\widehat{\mathrm{IET}^{\bowtie}}$ such that $h=\psi \circ f=g \circ \phi$.
Proof. Let $\lambda$ be the Lebesgue measure on $\left[0,1\left[\right.\right.$. Let $h \in \widehat{\mathrm{PC}^{\bowtie}}$ and $\mathcal{P} \in \Pi_{h}$. Then there exist $\phi, \psi \in \operatorname{Homeo}^{+}([0,1[)$ such that for every $I \in \mathcal{P}, \lambda(\phi(I))=\lambda(h(I))$ and $\lambda(\psi(h(I)))=\lambda(I)$. Then $h \circ \phi$ and $\psi \circ h$ belongs to $\widehat{\mathrm{IET}^{\bowtie}}$.

## 3. Construction of the signature homomorphism

In our case we have $X=\left[0,1\left[\right.\right.$ and $\widehat{\mathrm{PC}^{\bowtie}}$ is a subgroup of $\mathfrak{S}(X)$. We denote here $\mathfrak{S}_{\text {fin }}=\mathfrak{S}_{\text {fin }}(X)$ and $\varepsilon_{\text {fin }}$ the classical signature on $\mathfrak{S}_{\text {fin }}$ taking values in $(\mathbb{Z} / 2 \mathbb{Z},+)$.

### 3.1. Definitions.

Definition 3.1. Let $h$ be an element of $\widehat{\mathrm{PC}^{\bowtie}}, n \in \mathbb{N}$ and $\mathcal{P}=\left\{I_{1}, I_{2}, \ldots, I_{n}\right\} \in$ $\Pi_{h}$. For every $1 \leq j \leq n$, let $\alpha_{j}$ be the left endpoint of $I_{j}$ and $\beta_{j}$ be the left endpoint of $h\left(I_{j}^{\circ}\right)$. We define the default of pseudo right continuity for $h$ about $\mathcal{P}$ denoted $\sigma_{(h, \mathcal{P})}$ as the finitely supported permutation which sends $h\left(\alpha_{j}\right)$ to $\beta_{j}$ for every $1 \leq j \leq n$ (this is well-defined because the set of all $h\left(\alpha_{j}\right)$ is equal to the set of all $\beta_{j}$ ).
Definition 3.2. Let $h$ be an element of $\widehat{\mathrm{PC}^{\bowtie}}$ and $\mathcal{P} \in \Pi_{h}$. Let $k$ be the number of interval of $\mathcal{P}$ on which $h$ is order-reversing. We called the flip number of $h$ about $\mathcal{P}$ the number $k$. We denote it by $R(h, \mathcal{P})$.
Definition 3.3. For $h \in \widehat{\mathrm{PC}^{\bowtie}}$ and $\mathcal{P} \in \Pi_{h}$, define $\varepsilon(h, \mathcal{P}) \in \mathbb{Z} / 2 \mathbb{Z}$ as $R(h, \mathcal{P})+$ $\varepsilon_{\text {fin }}\left(\sigma_{(h, \mathcal{P})}\right)[\bmod 2]$. We define also $\varepsilon(h)=\varepsilon\left(h, \mathcal{P}_{h}^{\text {fin }}\right)$.

Proposition 3.4. For every $\tau \in \mathfrak{S}_{\text {fin }}$ and every $\mathcal{P} \in \Pi_{\tau}$ we have $\varepsilon(\tau, \mathcal{P})=\varepsilon_{\mathrm{fin}}(\tau)$.
Proof. It is clear that for every $\tau \in \mathfrak{S}_{\text {fin }}$ and every partition $\mathcal{P}$ associated with $\tau$ we have $R(\tau, \mathcal{P})=0$ and $\sigma_{(\tau, \mathcal{P})}=\tau$.

We deduce that $\varepsilon$ extends the classical signature $\varepsilon_{\text {fin }}$. Thus we will write $\varepsilon$ instead of $\varepsilon_{\text {fin }}$.
Proposition 3.5. Every right-continuous element $f$ of $\widehat{\mathrm{PC}^{+}}$satisfies $\varepsilon(f, \mathcal{P})=0$ for every $\mathcal{P} \in \Pi_{f}$.

Proof. In this case, for every partition $\mathcal{P}$ into intervals associated with $f$ we always have $R(f, \mathcal{P})=0$ and $\sigma_{(f, \mathcal{P})}=\mathrm{Id}$.

### 3.2. Proof of Theorem 1.1.

In order to prove that $\varepsilon$ is a group homomorphism, it is useful to calculate $\varepsilon(h)$ thanks to $\varepsilon(h, \mathcal{P})$ for every $h \in \widehat{\mathrm{PC}^{\bowtie}}$ and $\mathcal{P} \in \Pi_{h}$.

Lemma 3.6. For every $h \in \widehat{\mathrm{PC}^{\bowtie}}$ and every $\mathcal{P} \in \Pi_{h}$ we have $\varepsilon(h)=\varepsilon(h, \mathcal{P})$.
Proof. Let $h$ and $\mathcal{P}$ be as in the statement. By minimality of $\mathcal{P}_{h}^{\min }$, in term of refinement, we deduce that there exist $n \in \mathbb{N}$ and $\mathcal{P}_{1}, \mathcal{P}_{2}, \ldots, \mathcal{P}_{n} \in \Pi_{h}$ such that:
(1) $\mathcal{P}_{1}=\mathcal{P}_{h}^{\text {min }}$;
(2) $\mathcal{P}_{n}=\mathcal{P}$;
(3) for every $2 \leq i \leq n$ the partition $\mathcal{P}_{i}$ is a refinement of the partition $\mathcal{P}_{i-1}$ where only one interval of $\mathcal{P}_{i-1}$ is cut into two.
Hence it is enough to show $\varepsilon(h, \mathcal{Q})=\varepsilon\left(h, \mathcal{Q}^{\prime}\right)$ where $\mathcal{Q}, \mathcal{Q}^{\prime} \in \Pi_{h}$ such that there exist consecutive intervals $I, J \in \mathcal{Q}$ with $I \cup J \in \mathcal{Q}^{\prime}$ and $\mathcal{Q}^{\prime} \backslash\{I \cup J\}=\mathcal{Q} \backslash\{I, J\}$.

Let $\alpha$ be the left endpoint of $I$ and let $x$ be the right endpoint of $I$ ( $x$ is also the left endpoint of $J$ ). There are only two cases but in both cases, we know that $\sigma_{(h, \mathcal{Q})}=\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}$ except maybe on $h(\alpha)$ and $h(x)$ :
(1) The first case is when $h$ is order-preserving on $I \cup J$. Then as $\mathcal{Q} \backslash\{I, J\}=$ $\mathcal{Q}^{\prime} \backslash\{I \cup J\}$ we get $R(h, \mathcal{Q})=R\left(h, \mathcal{Q}^{\prime}\right)$. As $h$ is order-preserving on the interior of $I \cup J$ we know that $\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(\alpha))$ is the left endpoint of $h(I \cup J)$ which is the left endpoint of $h(I)$ thus equals to $\sigma_{(h, \mathcal{Q})}(h(\alpha))$. With the same reasoning we deduce that $\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(x))=\sigma_{(h, \mathcal{Q})}(h(x))$ hence $\sigma_{(h, \mathcal{Q})}=$ $\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}$. Thus in $\mathbb{Z} / 2 \mathbb{Z}$ we have $R\left(h, \mathcal{Q}^{\prime}\right)+\varepsilon\left(\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}\right)=R(h, \mathcal{Q})+\varepsilon\left(\sigma_{(h, \mathcal{Q})}\right)$.
(2) The second case is when $h$ is order-reversing on $I \cup J$. Then we get $R(h, \mathcal{Q})=R\left(h, \mathcal{Q}^{\prime}\right)+1$. This time $\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(\alpha))$ is still the left endpoint of $h(I \cup J)$ which is the left endpoint of $h(J)$ thus equals to $\sigma_{(h, \mathcal{Q})}(h(x))$. With the same reasoning we deduce that $\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(x))=\sigma_{(h, \mathcal{Q})}(h(\alpha))$. Then by denoting $\tau$ the transposition $\left(h(x) \sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(\alpha))\right)$, we obtain $\sigma_{(h, \mathcal{Q})}=$ $\tau \circ \sigma_{\left(h, \mathcal{Q}^{\prime}\right)}$. We must notice that the transposition is not the identity because $h^{-1}\left(\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(\alpha))\right)$ is an endpoint of one of the intervals of $\mathcal{Q}^{\prime}$ and
$x$ is not.
In conclusion in $\mathbb{Z} / 2 \mathbb{Z}$ we have:

$$
R\left(h, \mathcal{Q}^{\prime}\right)+\varepsilon\left(\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}\right)=R\left(h, \mathcal{Q}^{\prime}\right)+1+1+\varepsilon\left(\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}\right)=R(h, \mathcal{Q})+\varepsilon\left(\sigma_{(h, \mathcal{Q})}\right)
$$




Figure 1. Illustrations of the two cases appearing in Lemma 3.6.
On the left we assume $h$ order-preserving on $I \cup J$ and see that $\sigma_{(h, \mathcal{Q})}(h(x))=$ $\sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(x))$. On the right we assume $h$ order-reversing on $I \cup J$ and see that $\sigma_{(h, \mathcal{Q})}(h(x))=\left(h(x) \sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(\alpha))\right) \circ \sigma_{\left(h, \mathcal{Q}^{\prime}\right)}(h(x))$.

If $\phi \in \operatorname{Homeo}^{+}([0,1[)$, then it follows from Proposition 3.5 that $\varepsilon(\phi)=0$. We improve this, showing that $\varepsilon$ is invariant by the action of $\mathrm{Homeo}^{+}\left(\left[0,1[)\right.\right.$ on $\widehat{\mathrm{PC}^{\bowtie}}$.
Lemma 3.7. For every $h \in \widehat{\mathrm{PC}^{\bowtie}}$ and every $\phi \in \operatorname{Homeo}^{+}([0,1[)$ we have $\varepsilon(h \phi)=$ $\varepsilon(h)=\varepsilon(\phi h)$.

Proof. Let $h \in \widehat{\mathrm{PC}^{\bowtie}}$ and $\phi \in \operatorname{Homeo}^{+}([0,1[)$ be as in the statement. Let $n \in \mathbb{N}$ and $\mathcal{P}:=\left\{I_{1}, I_{2}, \ldots, I_{n}\right\} \in \Pi_{h}$. Then $\mathcal{Q}:=\left\{\phi^{-1}\left(I_{1}\right), \phi^{-1}\left(I_{2}\right), \ldots, \phi^{-1}\left(I_{n}\right)\right\}$ is in $\Pi_{h \phi}$. We know that $\phi$ is order preserving then for every $1, \leq i \leq n, h \phi$ preserves (reverses respectively) the order on $\phi^{-1}\left(I_{i}\right)$ if and only if $h$ preserves (reverses respectively) the order on $I_{i}$, so $R(h, \mathcal{P})=R(h \phi, \mathcal{Q})$. We can notice that the left endpoint of $\phi^{-1}\left(I_{i}\right)$ (denoted by $\alpha_{i}$ ) is send on the left endpoint of $I_{i}$ (denoted by $\left.a_{i}\right)$ by $\phi$ hence $h\left(a_{i}\right)=h \phi\left(\alpha_{i}\right)$ has to be send on $\sigma_{(h, \mathcal{P})}\left(h\left(a_{i}\right)\right)$ so $\sigma_{(h \phi, \mathcal{Q})}=\sigma_{(h, \mathcal{P})}$. we deduce that $\varepsilon(h \phi)=\varepsilon(h)$.
The other equality has a similar proof. We denote $h(\mathcal{P})$ the arrival partition of $h$ associated with $\mathcal{P}$. We know that $\phi$ is continuous thus $h(\mathcal{P})$ is in $\Pi_{\phi}$ and we deduce that $\mathcal{P} \in \Pi_{\phi h}$. Also $\phi$ is order-preserving then $\left.R(h, \mathcal{P})=R(\phi h, \mathcal{P})\right)$. We know that $\sigma_{(\phi, h(\mathcal{P}))}=$ Id then we can notice that $\phi \circ \sigma_{(h, \mathcal{P})} \circ h$ send the left endpoint of $I_{i}$ to the left endpoint of $\phi h\left(I_{i}^{\circ}\right)$. Then $\sigma_{(\phi h, \mathcal{P})}=\phi \sigma_{(h, \mathcal{P})} \phi^{-1}$ and we deduce that $\varepsilon\left(\sigma_{(\phi h, \mathcal{P})}\right)=\varepsilon\left(\sigma_{(h, \mathcal{P})}\right)$. Hence $\varepsilon(\phi h)=\varepsilon(h)$.

Thanks to Proposition 2.5 it is enough to prove that $\left.\varepsilon\right|_{\overparen{I E T 凶}}$ is a group homomorphism.
Lemma 3.8. The map $\left.\varepsilon\right|_{\widehat{\mathrm{IET}^{\bowtie}}}$ is a group homomorphism.
Proof. Let $f, g \in \widehat{\overline{\mathrm{IET}}^{\bowtie}}$. Let $\mathcal{P} \in \Pi_{f}$ and $\mathcal{Q} \in \Pi_{g}$. For every $I \in \mathcal{Q}$ (resp. $J \in \mathcal{P}$ ) we denote by $\alpha_{I}$ (resp. $\beta_{J}$ ) the left endpoint of $I$ (resp. $J$ ). Up to refine $\mathcal{P}$ and $\mathcal{Q}$ we can assume that $\mathcal{P}=g(\mathcal{Q})$ thus $g\left(\left\{\alpha_{I}\right\}_{I \in \mathcal{Q}}\right)=\left\{\beta_{J}\right\}_{J \in \mathcal{P}}$. Then $Q \in \Pi_{f \circ g}$ and for every $K \in f \circ g(Q)$ we denote by $\gamma_{K}$ the left endpoint of $K$.
In $\mathbb{Z} / 2 \mathbb{Z}$, we get immediately that $R(f \circ g, Q)=R(g, Q)+R(f, g(Q))$. Now we want to describe the default of pseudo right continuity for $f \circ g$ about $\mathcal{Q}$. We recall that $\sigma_{(f \circ g, \mathcal{Q})}$ is the permutation that sends $f \circ g\left(\alpha_{I}\right)$ on $\gamma_{f \circ g(I)}$ for every $I \in \mathcal{Q}$ while fixing the rest of $\left[0,1\left[\right.\right.$. Furthermore $\sigma_{(g, \mathcal{Q})}\left(g\left(\alpha_{I}\right)\right)=\beta_{g(I)}$ and $\sigma_{(f, g(\mathcal{Q}))}\left(f\left(\beta_{g(I)}\right)\right)=\gamma_{f \circ g(I)}$. Then $\sigma_{(f, g(\mathcal{Q}))} \circ f \circ \sigma_{(g, \mathcal{Q})} \circ g\left(\alpha_{I}\right)=\gamma_{f \circ g(I)}$ and we deduce that the permutation $\sigma_{(f, g(\mathcal{Q}))} \circ f \circ \sigma_{(g, \mathcal{Q})} \circ f^{-1}$ sends $f \circ g\left(\alpha_{I}\right)$ on $\gamma_{f \circ g(I)}$ for every $I \in \mathcal{Q}$ while fixing the rest of $\left[0,1\left[\right.\right.$. Thus $\sigma_{(f \circ g, \mathcal{Q})}=\sigma_{f, g(\mathcal{Q})} \circ f \circ \sigma_{(g, \mathcal{Q})} \circ f^{-1}$. Then $\varepsilon\left(\sigma_{(f \circ g, \mathcal{Q})}\right)=\varepsilon\left(\sigma_{f, g(\mathcal{Q})}\right)+\varepsilon\left(\sigma_{(g, \mathcal{Q})}\right)$ and we conclude that $\varepsilon(f \circ g)=\varepsilon(f)+\varepsilon(g)$.
Corollary 3.9. The map $\varepsilon$ is a group homomorphism.

## 4. Normal subgroups of $\widehat{\mathrm{PC}^{\bowtie}}$ and some subgroups

Here we present some corollaries of Theorem 1.1. For every group $G$ we denote by $D(G)$ its derived subgroup.
Definition 4.1. For every group $H$, we define $J_{3}(H)$ as the subgroup generated by elements of order 3 .

Let $\widehat{G}$ be a subgroup of $\widehat{\mathrm{PC}^{\bowtie}}$ containing $\mathfrak{S}_{\text {fin }}$. We denote by $G$ its projection on $\mathrm{PC}^{\bowtie}$. We recall that $\mathfrak{A}_{\mathrm{fin}}$ is a normal subgroup of $\widehat{G}$, and has a trivial centraliser. We deduce that for every nontrivial normal subgroup $H$ of $\widehat{G}$ contains $\mathfrak{A}_{\text {fin }}$.

From the short exact sequence:

$$
1 \longrightarrow \mathfrak{S}_{\mathrm{fin}} \longrightarrow \widehat{G} \longrightarrow G \longrightarrow 1
$$

we deduce the next short exact sequence which is a central extension:

$$
1 \longrightarrow \mathbb{Z} / 2 \mathbb{Z} \longrightarrow \widehat{G} / \mathfrak{A}_{\mathrm{fin}} \longrightarrow G \longrightarrow 1
$$

This short exact sequence splits because the signature $\varepsilon_{\mid \widehat{G}}: \widehat{G} \rightarrow \mathbb{Z} / 2 \mathbb{Z}$ constructed in $\S 3$ is a retraction. Then we deduce that $\widehat{G} / \mathfrak{A}_{\mathrm{fin}}$ is isomorphic to the direct product $\mathbb{Z} / 2 \mathbb{Z} \times G$.
Corollary 4.2. The projection $\widehat{G}_{\mathrm{ab}} \rightarrow G_{\mathrm{ab}}$ extends in an isomorphism $\widehat{G}_{\mathrm{ab}} \sim$ $G_{\mathrm{ab}} \times \mathbb{Z} / 2 \mathbb{Z}$. Furthermore $D(\widehat{G})=\operatorname{Ker}(\varepsilon) \cap \widehat{D(G)}$ is a subgroup of index 2 in $\widehat{D(G)}$. In particular, if $G$ is a perfect group then $\widehat{G}_{\mathrm{ab}}=\mathbb{Z} / 2 \mathbb{Z}$.

Corollary 4.3. Let $\widehat{G}$ be a subgroup of $\widehat{\mathrm{PC}^{\bowtie}}$ containing $\mathfrak{S}_{\mathrm{fin}}$ and such that its projection $G$ in $\mathrm{PC}^{\bowtie}$ is simple nonabelian. Then $\widehat{G}$ has exactly 5 normal subgroups given by the list: $\left\{\{1\}, \mathfrak{A}_{\mathrm{fin}}, \mathfrak{S}_{\mathrm{fin}}, \operatorname{Ker}(\varepsilon), \widehat{G}\right\}$.
Proof. Let $\widehat{G}$ as in the statement. First we immediately check that the subgroups in the list are distinct normal subgroups of $\widehat{G}$. In the case of $\operatorname{Ker}(\varepsilon)$, there exists $g \in \widehat{G} \backslash \mathfrak{S}_{\text {fin }}$ thus either $g \in \operatorname{Ker}(\varepsilon) \backslash \mathfrak{S}_{\text {fin }}$ or $\sigma g \in \operatorname{Ker}(\varepsilon) \backslash \mathfrak{S}_{\text {fin }}$ for any transposition $\sigma$.
Second let $H$ be a normal subgroup of $\widehat{G}$ distinct from $\{1\}$. Then it contains $\mathfrak{A}_{\text {fin }}$. Also $H / \mathfrak{A}_{\text {fin }}$ is a normal subgroup of $\widehat{G} / \mathfrak{A}_{\text {fin }} \simeq \mathbb{Z} / 2 \mathbb{Z} \times G$. Furthermore $G$ is simple then there are only four possibilities for $H / \mathfrak{A}_{\text {fin }}$. As two normal subgroups $H, K$ of $\widehat{G}$ containing $\mathfrak{A}_{\text {fin }}$ such that $H / \mathfrak{A}_{\text {fin }}=K / \mathfrak{A}_{\text {fin }}$ are equal, we deduce that $\widehat{G}$ has at most 5 normal subgroups.
Corollary 4.4. Let $\widehat{G}$ be a subgroup of $\widehat{\mathrm{PC}^{\bowtie}}$ containing $\mathfrak{S}_{\mathrm{fin}}$ and such that its projection $G$ in $\mathrm{PC}^{\bowtie}$ is simple nonabelian. If there exists an element of order 3 in $G \backslash \mathfrak{A}_{\text {fin }}$ then $J_{3}(\widehat{G})=\operatorname{Ker}(\varepsilon)=D(\widehat{G})$.
Remark 4.5. In the context of topological-full groups, the group $J_{3}(G)$ appears naturally (with some mild assumptions) and is denoted by $\mathrm{A}(G)$ by Nekrashevych in [9]. In some case of topological-full groups of minimal groupoids (see [8]) we have the equality $A(G)=D(G)$ thanks to the simplicity of $D(G)$. In spite of the analogy, it is not clear that the corollary can be obtained as particular case of this result.
Remark 4.6. A lot of groups satisfy the conditions of Corollary 4.4. When $\widehat{G}$ contains $\widehat{\mathrm{IET}^{+}}$there is an element of order 3 in $G \backslash \mathfrak{A}_{\mathrm{fin}}$. We recall that $\mathrm{IET}^{\bowtie}$, $\mathrm{PC}^{+}$and $\mathrm{PAff}^{+}$are simple (see $[2,5]$ ). Thus these groups satisfy the conditions of Corollary 4.4. The next theorem add $\mathrm{PC}^{\bowtie}$ and $\mathrm{PAff}^{\bowtie}$ to the list of examples.

Theorem 4.7. The groups $\mathrm{PC}^{\bowtie}$ and $\mathrm{PAff}^{\bowtie}$ are simple.
Lemma 4.8. The group $\mathrm{IET}^{\bowtie}$ is generated by fips ( $=$ images of fips from $\widehat{\mathrm{IET}^{\bowtie}}$ ).
Proof. By Proposition 2.4 it is enough to show that $\mathrm{IET}^{+}$is generated by flips. For every consecutive, right-open and left-closed subintervals $I$ and $J$ of $[0,1[$, we define $R_{I, J}$ the map that exchanges $I$ and $J$. They are elements of $\widehat{\mathrm{IET}}_{\mathrm{rc}}^{+}$and they formed a generating set. Then their image $r_{I, J}$ in IET ${ }^{\bowtie}$ is a generating set of $\mathrm{IET}^{+}$. For every right-open and left-closed subinterval $I$ of $\left[0,1\left[\right.\right.$, we define $s_{I}$ the $I$-flip. Take $I$ and $J$ be two consecutive, right-open and left-closed subintervals of $\mid 0,1\left[\right.$. Then $r_{I, J}=s_{I} s_{J} s_{I \cup J}$.
Proof of Theorem 4.7 (sketched).
Since the argument in [2] could also be adapted, we only provide a sketch.

We work with elements of $\mathrm{PC}^{\bowtie}$; all intervals below are meant modulo finite subsets. Let $N$ be a nontrivial normal subgroup of $\mathrm{PC}^{\bowtie}$ (resp. $\mathrm{PAff}{ }^{\bowtie}$ ). Let $g$ be a nontrivial element of $N$. There exists a subinterval $I$ of $[0,1[$ such that:
(1) $g$ is continuous (resp. affine) on $I$,
(2) $g(I) \cap I=\varnothing$ (modulo finite subsets),
(3) $I \cup g(I) \neq[0,1[$ (modulo finite subsets).

Let $f$ be the $I$-flip. If $g$ is affine on $I$ then $h=g f g^{-1} f^{-1}$ is the product of the $I$-flip with the $g(I)$-flip. Observe that $h$ is conjugate to a single flip by a suitable element of IET ${ }^{+}$. If $g$ is only continuous then $h$ is still of order 2 and it is conjugate in $\mathrm{PC}^{\bowtie}$ to a single flip. Conjugating by elements of $\mathrm{PAff}^{+}$, one obtains that $N$ contains flips of intervals of all possible lengths, and hence contains all flips. Thanks to Lemma 4.8 we know that IET $^{\bowtie}$ is generated by the set of flips thus $N$ contains IET ${ }^{\bowtie}$, in particular $N$ intersects $\mathrm{PC}^{+}$(resp. $\mathrm{PAff}^{+}$) nontrivially. By simplicity of $\mathrm{PC}^{+}$(resp. $\mathrm{PAff}^{+}$) we deduce that $N$ contains $\mathrm{PC}^{\bowtie}=\left\langle\mathrm{PC}^{+}, \mathrm{IET}^{\bowtie}\right\rangle$ (resp. PAff $\left.{ }^{\bowtie}=\left\langle\mathrm{PAff}^{+}, \mathrm{IET}^{\bowtie}\right\rangle\right)$.

## 5. About some Normalizers

Here we show that computing normalizers inside $\widehat{\mathrm{PC}^{\bowtie}}$ and $\mathrm{PC}^{\bowtie}$ may leads to different behaviour. We look the case of $\mathrm{PC}^{+}, \mathrm{IET}^{+}$and $\widehat{\mathrm{PC}_{\mathrm{rc}}^{+}}$and $\widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$.
Proposition 5.1. The normalizer of $\mathrm{IET}^{+}$in $\mathrm{IET}^{\bowtie}$ is reduced to $\mathrm{IET}^{ \pm}$.
Proof. Let $f \in \mathrm{IET}^{+}$and $g \in \mathrm{IET}^{ \pm}$. If $g \in \mathrm{IET}^{+}$then $g f g^{-1} \in \mathrm{IET}^{+}$. We assume $g \in \mathrm{IET}^{-}$then $g f g^{-1}=(g \circ \mathcal{R}) \circ(\mathcal{R} \circ f \circ \mathcal{R}) \circ(\mathcal{R} \circ g) \in \mathrm{IET}^{+}$.
For the inclusion from left to right, let $g \in \mathrm{IET}^{\bowtie} \backslash \mathrm{IET}^{ \pm}$and let $\widehat{g}$ be a representative of $g$ in $\widehat{\mathrm{IET}^{\bowtie}}$. Hence we can find $I, J, K, L$ four right-open and left-closed intervals of the same length such that their image by $\widehat{g}$ are intervals and such that $\widehat{g}$ is order-reversing on $I$ and order-preserving on $J, K$ and $L$. We define $\widehat{f} \in \widehat{\mathrm{IET}^{+}}$as the element which exchanges $\widehat{g}(I)$ with $\widehat{g}(J)$ and $\widehat{g}(K)$ with $\widehat{g}(L)$ while fixing the rest of $\left[0,1\left[\right.\right.$. Then the image $f$ of $\widehat{f}$ in $\mathrm{IET}^{+}$is not trivial and $\widehat{g} \widehat{f} \widehat{g}^{-1} \notin \widehat{\mathrm{IET}^{+}}$implies $g f g^{-1} \notin \mathrm{IET}^{+}$.

A similar argument stands for the case of PC thus we obtain:
Proposition 5.2. The normalizer of $\mathrm{PC}^{+}$in $\mathrm{PC}^{\bowtie}$ is reduced to $\mathrm{PC}^{ \pm}$.
We now take a look to inside $\widehat{\mathrm{PC}^{\bowtie}}$ :
Proposition 5.3. The normalizer of $\widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$in $\widehat{\mathrm{IET}^{\bowtie}}$ is $\widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$.
Proof. Let $g$ be an element of $\widehat{\text { IET }^{\bowtie}}$ which is not the identity. There are two cases:
(1) If $g \in \widehat{\mathrm{IET}^{+}} \backslash \widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$then $g=\sigma g^{\prime}$ with $\sigma \in \mathfrak{S}_{\mathrm{fin}} \backslash\{\mathrm{Id}\}$ and $g^{\prime} \in \widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$. Then for every $f \in \widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$we have $g f g^{-1}=\sigma g^{\prime} f g^{\prime-1} \sigma^{-1}$. Thus it is enough to treat the case of $\mathfrak{S}_{\text {fin }}$. Let us assume $g \in \mathfrak{S}_{\text {fin }}$ then let $x$ in the support of $g$. There exist two consecutive right-open and left-closed intervals $I$ and $J$ of the same length such that $x$ is the right endpoint of $I$ (and the left endpoint of $J$ ). Up to reduce $I$ and $J$ we can assume that $I$ does not intersect the support of $g$. Then let $f \in \widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$which exchanges $I$ and $J$ while fixing the rest of $\left[0,1\left[\right.\right.$. Then $g f g^{-1}$ exchanges the interior of $I$ with the interior of $J$ but $g \mathrm{fg}^{-1}(x)$ is not equal to $f(x)$ because $f(x)$ is the left endpoint of $I$ and $I$ does not intersect the support of $g$. Then we deduce that $g \mathrm{fg}^{-1}$ is not right-continuous on $J$.
(2) If $g \in \widehat{\mathrm{IET}^{\bowtie}} \backslash \widehat{\mathrm{IET}^{+}}$. Then we can find two consecutive subinterval $I$ and $J$ where $g$ is continuous and order-reversing on $I \cup J$. Let $a$ be the right endpoint of $J$. Let $f$ be the element in $\widehat{\mathrm{IET}_{\mathrm{rc}}^{+}}$which exchanges $I$ and $J$. Then $g f^{-1}$ exchanges the interior of $g(J)$ with the interior of $g(I)$. However the left endpoint of $g(J)$ is send by $g^{-1}$ on $a$ which is fixed by $f$. Then $g f g^{-1}$ fixes the left endpoint of $g(J)$, thus $g f g^{-1}$ is not right-continuous on $g(J)$.

A similar argument stands for the case of PC thus we obtain:
Proposition 5.4. The normalizer of $\widehat{\mathrm{PC}_{\mathrm{rc}}^{+}}$in $\widehat{\mathrm{PC}^{\bowtie}}$ is $\widehat{\mathrm{PC}_{\mathrm{rc}}^{+}}$.
