# LARGE MASS MINIMIZERS FOR ISOPERIMETRIC PROBLEMS WITH INTEGRABLE NONLOCAL POTENTIALS 

MARC PEGON


#### Abstract

This paper is concerned with volume-constrained minimization problems derived from Gamow's liquid drop model for the atomic nucleus, involving the competition of a perimeter term and repulsive nonlocal potentials. We consider potentials given by general radial nonnegative kernels which are integrable on $\mathbb{R}^{n}$, such as Bessel potentials, and study the behavior of the problem for large masses (i.e., volumes). Using the integrability of those kernels, we rewrite the problem as the minimization of the difference between the classical perimeter and a nonlocal perimeter. Renormalizing to a fixed volume, and noticing that the parametrized family of functionals localizes to a multiple of the classical perimeter as the mass goes to infinity, we show that, if the first moment of the kernels is small enough, the problem admits minimizers of arbitrarily large mass. In addition, we prove that, after renormalization, any sequence of minimizers converges to the ball as the mass goes to infinity. Finally, we study the stability of the ball, and show that our upper bound on the first moment of the kernels is a sharp stability threshold for large balls. A direct consequence of the instability of large balls above this threshold is that there exist nontrivial compactly supported kernels for which the problems admit minimizers which are not balls, that is, symmetry breaking occurs.

## 1. Introduction

We study large mass minimizers for a variant of Gamow's liquid drop model for the atomic nucleus, in which the repulsive term is given by a general nonnegative, integrable, radial kernel. More precisely, given $G: \mathbb{R}^{n} \rightarrow[0,+\infty)$ a measurable nonnegative radial function, where $n \geqslant 2$, we originally consider the minimization problem

$$
\min \left\{P(E)+\iint_{E \times E} G(x-y) \mathrm{d} x \mathrm{~d} y:|E|=m\right\}
$$

where the minimum is taken over all sets of finite perimeter of volume $|E|=m$ - which we call the mass - and $P(E)$ denotes the perimeter of $E$. Observe that this problem exhibits a competition between two
terms and is thus nontrivial: the local perimeter term constrains the set $E$ to concentrate as much as possible, while the nonlocal term acts as a repulsive term, forcing $E$ to spread. Indeed, it is known that the perimeter is minimized by balls under volume constraint, while the nonlocal term is maximized by balls (by Riesz' symmetric rearrangement, using e.g. [23, Chapter 3.7], and the fact that $G$ is equal to its symmetric rearrangement).

As we show just below, the integrability assumption on $G$ allows us to reformulate this problem as

$$
\min \left\{P(E)-\gamma \operatorname{Per}_{G_{\lambda}}(E):|E|=\left|B_{1}\right|\right\}
$$

where $B_{1}$ stands for the open unit ball of $\mathbb{R}^{n}$ centered at the origin, $\lambda$ and $\gamma$ are positive constants, the kernel $G_{\lambda}$ is given by

$$
\begin{equation*}
G_{\lambda}(\cdot):=\lambda^{n+1} G(\lambda \cdot), \tag{1.1}
\end{equation*}
$$

and the functional $\operatorname{Per}_{G}$ is defined by

$$
\operatorname{Per}_{G}(E):=\iint_{E \times E^{c}} G(x-y) \mathrm{d} x \mathrm{~d} y .
$$

The parameter $\lambda>0$ will represent the mass (to the power $\frac{1}{n}$ ), and $\gamma>0$ will be chosen to adjust the first moment of $G$ (that is, its integral against the measure $|x| \mathrm{d} x)$ to a particular universal constant. As will be justified later on, $\operatorname{Per}_{G}$ should be considered as a "nonlocal perimeter", which behaves in several ways as a standard perimeter term rather than as a volume term.

Before elaborating on the reformulation, let us say a few words on the original problem ( $\star$ ). This problem has been studied extensively in the literature when $G$ is a Riesz kernel (whose definition we recall in Section 2.2) or a general integrable kernel with compact support. In the Riesz case, it is known that the problem admits the ball as unique minimizer below a critical mass, up to translations, and it is conjectured that there is no minimizer above a (possibly different) critical mass. This conjecture has already been proven in a few cases. We will discuss the Riesz case and compact support case further, and provide references, in the next section. In this paper, we are interested in kernels decreasing faster than Riesz kernels at infinity, enough to make them integrable, but not necessarily compactly supported, and in order to highlight the differences with the Riesz case, we focus exclusively on the behavior for large masses.
Reformulation of the problem. Let us remark that, $G$ being integrable on $\mathbb{R}^{n}$, for any set $E$ of mass $m$, we may rewrite the nonlocal repulsive term as

$$
\iint_{E \times E} G(x-y) \mathrm{d} x \mathrm{~d} y=m\|G\|_{L^{1}\left(\mathbb{R}^{n}\right)}-\iint_{E \times E^{\mathrm{c}}} G(x-y) \mathrm{d} x \mathrm{~d} y,
$$

so that $(\star)$ is in fact strictly equivalent to

$$
\min \left\{P(E)-\operatorname{Per}_{G}(E):|E|=m\right\}
$$

Now, to further normalize our problem, for $k \in\{0,1\}$, we define the quantity

$$
I_{G}^{k}:=\int_{\mathbb{R}^{n}}|x|^{k} G(x) \mathrm{d} x
$$

and for every positive natural numbers $p$ and $n$, we denote by $\mathbf{K}_{p, n}$ the constant defined by

$$
\begin{equation*}
\mathbf{K}_{p, n}:=f_{\mathbb{S}^{n-1}}|e \cdot x|^{p} d \mathscr{H}^{n-1}(x) \tag{1.2}
\end{equation*}
$$

which does not depend on $e \in \mathbb{S}^{n-1}$ by symmetry. Here $\mathbb{S}^{n-1}$ denotes the unit sphere in $\mathbb{R}^{n}$ and $\mathscr{H}^{n-1}$ the $(n-1)$-dimensional Hausdorff measure. Now, up to dividing $G$ by the constant $\gamma=\left(I_{G}^{1} \mathbf{K}_{1, n}\right) / 2$, without renaming $G$, we may assume that

$$
I_{G}^{1}=\frac{2}{\mathbf{K}_{1, n}}
$$

and may look instead at the problem

$$
\begin{equation*}
\min \left\{P(E)-\gamma \operatorname{Per}_{G}(E):|E|=m\right\} \tag{1.3}
\end{equation*}
$$

where $\gamma>0$. Keep in mind that the parameter $\gamma$ plays the role of a constant times $I_{G}^{1}$, the first moment of $G$. As a last simplification step, in order to study the asymptotic behavior when the mass goes to infinity, it is more convenient to look at the rescaled problem with fixed mass equal to the volume of the unit ball in $\mathbb{R}^{n}$. Given $m>0$, setting $\lambda:=\left(\frac{m}{\left|B_{1}\right|}\right)^{\frac{1}{n}}$ and $F:=\lambda^{-1} E$, it is then easy to see that $|F|=\left|B_{1}\right|, I_{G_{\lambda}}^{1}=I_{G}^{1}$, and by a change of variables

$$
P(E)-\operatorname{Per}_{G}(E)=\lambda^{n-1}\left(P(F)-\operatorname{Per}_{G_{\lambda}}(F)\right)
$$

so that the set $E$ is a minimizer of (1.3) if and only if $F$ is a minimizer of the rescaled problem $\left(\mathrm{P}_{\gamma, \lambda}\right)$. In the rest of the paper, we shall always work with this equivalent formulation.

General assumptions and results. Except in Section 2, we shall always assume that $G$ satisfies the two following general hypotheses:
(H1) $G$ is radial, that is, there exists a nonnegative function $g:(0,+\infty) \rightarrow \mathbb{R}$ such that $G(x)=g(|x|)$ for $\mathscr{L}^{n}$ - a.e. $x \in \mathbb{R}^{n}$;
(H2) $G \in L^{1}\left(\mathbb{R}^{n}\right)$, and

$$
I_{G}^{1}=\frac{2}{\mathbf{K}_{1, n}}
$$

Starting from Section 5, we may add the extra assumptions
(H3) $G(x)=o\left(|x|^{\alpha-n}\right)$ near the origin, for some $\alpha>0$;
(H4) $G(x)=o\left(|x|^{-(n+\beta)}\right)$ at infinity for some $\beta>0$ when $n \geqslant 3$, and $G(x)=o\left(|x|^{-3}\right)$ at infinity when $n=2$;
We motivate assumptions (H3) and (H4) at the very beginning of Section 3. As we will see, Bessel kernels satisfy those general assumptions (see Sections 2.4 and 3.2). We are interested in the asymptotic behavior of the minimization problem $\left(\mathrm{P}_{\gamma, \lambda}\right)$ as $\lambda$ (that is, the mass) goes to infinity, and give answers to several natural questions: does $\left(\mathrm{P}_{\gamma, \lambda}\right)$ admit a minimizer? If so, what do minimizers look like, are they regular? Can the unit ball be a minimizer? We decided to state in a concise manner just below three of the main results obtained in the paper, and an application to Bessel kernels, however these results are not necessarily arranged in the same way in the paper.

Theorem A (Consequence of Theorems 4.5 and 4.16). Assume $\gamma<1$. Then there exists $\lambda_{e}=$ $\lambda_{e}(n, \gamma, G)$ such that, for any $\lambda>\lambda_{e},\left(\mathrm{P}_{\gamma, \lambda}\right)$ admits a minimizer, and in addition, minimizers have a $C^{1, \frac{1}{2}}$ reduced boundary and are essentially connected.

Let us point out that the regularity of the reduced boundary is actually true for any minimizer, if one exists, no matter the value of $\gamma$ and $\lambda$. Connectedness of minimizers also holds in any case, provided that $G$ is not compactly supported (see Theorem 4.16). In terms of the original problem ( $\star$ ), Theorem A means that if $I_{G}^{1}<\frac{2}{\mathbf{K}_{1, n}}$, then there exists a critical mass $m_{e}=m_{e}(n, G)$, such that, above this mass, the problem admits a minimizer.

The main obstacle for proving existence with the direct method in the calculus of variations is the possibility for a minimizing sequence to have some mass escape at infinity. We solve this problem by showing that, for large values of $\lambda$, a minimizing sequence may be constrained inside a ball via a truncation lemma. This relies heavily on the fact that the nonlocal perimeter behaves to some extent as the classical perimeter and localizes to it as $\lambda$ goes to infinity. Note that the general kernels we consider (and in particular Bessel kernels) do not behave as nicely as Riesz kernels under scaling, which are homogeneous. The $C^{1, \frac{1}{2}}$-regularity of the reduced boundary of minimizers follows by results in [27] on quasi-minimizers for the perimeter.

For any $\gamma$ and $\lambda$, let us define the functional to be minimized

$$
\begin{equation*}
\mathcal{F}_{\gamma, G_{\lambda}}(E):=P(E)-\gamma \operatorname{Per}_{G_{\lambda}}(E) \tag{1.4}
\end{equation*}
$$

When $\gamma \in[0,1)$, we are able to compute the $\Gamma$-limit in $L^{1}$ of these functionals as $\lambda$ goes to infinity, and we show independently that, up to translations, any sequence of minimizers converges to the unit ball. More precisely, we prove that minimizers are included in the set difference between two balls whose radii converge to 1 as $\lambda$ goes to infinity, which implies in particular Hausdorff convergence of the boundaries of minimizers to the unit sphere, up to translations.

Theorem B (See Theorem 4.5, Theorem 4.12 for more precise statements). Assume $\gamma<1$. For any minimizer $E$ of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ with $\lambda>\lambda_{e}$, up to a translation, we have

$$
\begin{equation*}
\bar{B}_{1-\eta_{\gamma, G}(\lambda)} \subseteq E \subseteq B_{1+\eta_{\gamma, G}(\lambda)} \tag{1.5}
\end{equation*}
$$

where $\eta_{\gamma, G}$ is a function depending only on $n, \gamma$ and $G$ which vanishes at infinity. In addition, the family of functionals $\mathcal{F}_{\gamma, G_{\lambda}}$ (with the added constraint of being the indicator function of a set of finite perimeter with volume $\left.\left|B_{1}\right|\right) \Gamma$-converges in $L^{1}$ to $(1-\gamma) P$ as $\lambda$ goes to infinity.

Of course, the $\Gamma$-convergence to a positive multiple of the perimeter implies $L^{1}$ convergence of minimizers to the ball as $\lambda$ goes to infinity (together with their compactness), but (1.5) is stronger and in fact a direct consequence of the proof of existence above $\lambda_{e}$.

Then we recall a well-suited notion of stability for functionals on sets under volume constraint (see Definition 5.4), and show that the threshold $\gamma=1$ is a stability threshold of the unit ball for $\left(\mathrm{P}_{\gamma, \lambda}\right)$ for large values of $\lambda$.

Theorem C (Consequence of Theorems 5.8 and 5.14 ). Assume that $G$ satisfies all the hypotheses (H1) to (H4). Then the following holds:
(i) if $\gamma<1$, then there exists $\lambda_{s}=\lambda_{s}(n, \gamma, G)>0$ such that, for any $\lambda>\lambda_{s}, B_{1}$ is a (critical) stable set for $\mathcal{F}_{\gamma, G_{\lambda}}$;
(ii) if $\gamma>1$, then there exists $\lambda_{u}=\lambda_{u}(n, \gamma, G)$ such that, for any $\lambda>\lambda_{u}, B_{1}$ is a (critical) unstable set for $\mathcal{F}_{\gamma, G_{\lambda}}$ : in particular, it cannot be a minimizer, i.e., symmetry-breaking occurs.

In terms of the original problem $(\star)$, this means that the threshold $\frac{2}{\mathbf{K}_{1, n}}$ for $I_{G}^{1}$ is a threshold for which large balls go from stable to unstable.

The proofs for the stability and instability of the ball rely essentially on the two following ingredients:
(i) the decomposition in spherical harmonics of the Jacobi operator associated with the second variation of the perimeter and of the nonlocal term (given by the so-called Funk-Hekke formula for the latter);
(ii) results analogous to the one by J. Bourgain, H. Brezis, and P. Mironescu in [7] for Sobolev spaces on spheres, that is, computation of the limit and of a sharp "asymptotic" upper bound for the quantity

$$
\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|f(x)-f(y)|^{2}}{|x-y|^{2}} \eta_{\varepsilon}(x-y) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}
$$

where $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$ is a $(n-1)$-dimensional approximation of identity, and $f$ belongs to $H^{1}\left(\mathbb{S}^{n-1}\right)$.
A particularly interesting consequence of Theorem C is that there exist kernels for which $\left(\mathrm{P}_{\gamma, \lambda}\right)$ admits nontrivial minimizers, that is, minimizers which are not balls. Indeed, working from the formulation ( $\star$ ), S. Rigot proved in [27] that ( $\mathrm{P}_{\gamma, \lambda}$ ) always admits a minimizer whenever $G$ is compactly supported. Hence, taking $\gamma>1$, minimizers still exist but cannot be the unit ball when $\lambda$ is large enough, since it is unstable.

Theorems A to C directly apply when $G$ is a so-called Bessel kernel: for every $\alpha, \kappa>0$, we denote by $\mathcal{B}_{\kappa, \alpha}$ the Bessel kernel of order $\alpha$ defined as the fundamental solution of the operator $(I-\kappa \Delta)^{\frac{\alpha}{2}}$, that is,

$$
(I-\kappa \Delta)^{\frac{\alpha}{2}} \mathcal{B}_{\kappa, \alpha}=\delta_{0} \quad \text { in } \mathscr{D}^{\prime}\left(\mathbb{R}^{n}\right)
$$

where $\boldsymbol{\delta}_{0}$ is the Dirac distribution at the origin. We then have:
Application D (Corollary 3.12 and Lemma 3.13). For every $\kappa, \alpha \in(0,+\infty)$, we consider the problem ( $\star$ ) with $G=\mathcal{B}_{\kappa, \alpha}$. Let us define

$$
\boldsymbol{\kappa}_{\alpha}:=\pi\left(\frac{(n+1) \Gamma\left(\frac{\alpha}{2}\right)}{2 \Gamma\left(\frac{1+\alpha}{2}\right)}\right)^{2} .
$$

Then we have:
(i) if $\kappa<\boldsymbol{\kappa}_{\alpha}$, there exist $m_{e}=m_{e}(\alpha, \kappa)>0$ and $m_{s}=m_{s}(\alpha, \kappa)>0$ such that, for every $m>m_{e}$, $(\star)$ admits a minimizer, and for every $m>m_{s}$, the ball of volume $m$ centered at the origin, denoted by $[B]_{m}$, is a stable critical point for the functional of $(\star)$. In addition, rescaling minimizers so that they are of volume $\left|B_{1}\right|$, and translating them, they converge to the unit ball as $m$ goes to infinity;
(ii) if $\kappa>\boldsymbol{\kappa}_{\alpha}$, there exists $m_{u}=m_{u}(\alpha, \kappa)$ such that for every $m>m_{u},[B]_{m}$ is an unstable critical point of the functional of $(\star)$. In particular, $[B]_{m}$ cannot be a minimizer.

In view of Theorems A to C, we conjecture that for $\gamma<1$, there should be a critical value $\lambda_{B}$ such that, for $\lambda>\lambda_{B}$, the unique minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ is the unit ball, up to translations. This conjecture will be the subject of a future work.
Outline of the paper. This paper is organized as follows. In Section 2 we discuss a few variants of Gamow's liquid drop model which have already been studied in the literature, and we motivate the choice of our assumptions (H1) and (H2). We also recall some well-known results on isoperimetric inequalities. In Section 3 we establish basic prerequisites on nonlocal perimeters and on Bessel kernels, which justify Application D. Section 4 is devoted to the proofs of Theorems A and B. First, we prove existence of minimizers for $\gamma<1$ and $\lambda$ large enough, as well as convergence to the ball as $\lambda$ goes to infinity in Theorem 4.5. Then, we compute the $\Gamma$-limit of the functionals $\mathcal{F}_{\gamma, G_{\lambda}}$ as $\lambda$ goes to infinity, and conclude this section by establishing $C^{1, \frac{1}{2}}$-regularity (applying directly results from [27]) and connectedness of minimizers. In Section 5 , we focus on the stability of the unit ball for large $\lambda$, and show that $\gamma=1$ is a threshold for which the unit ball goes from stable to unstable, i.e., Theorem C. To conclude on the stability issue, we need to study asymptotics for some nonlocal seminorms on the sphere, which is done in Appendix A: here we compute the limit of these seminorms as the kernels concentrate to the Dirac distribution, and obtain a uniform upper bound which is asymptotically sharp.

## Notation.

Operations on sets. For any set $E \subseteq \mathbb{R}^{n}$, we define $E^{c}:=\mathbb{R}^{n} \backslash E$, and we write $|E|$ for its volume (that is, its Lebesgue measure) whenever $E$ is measurable. We write $E \sqcup F$ for the union of two sets which are disjoint. Given two sets $E$ and $F$, we denote by $E \triangle F:=(E \backslash F) \sqcup(F \backslash E)$ their symmetric difference. We say that two sets $E$ and $F$ in $\mathbb{R}^{n}$ are equivalent if $|E \triangle F|=0$.

Hausdorff measures. We denote by $\mathscr{H}^{k}$ the $k$-dimensional Hausdorff measure in $\mathbb{R}^{n}$, and by $\operatorname{dim}_{\mathscr{H}}(E)$ the Hausdorff dimension of a set $E \subseteq \mathbb{R}^{n}$. When integrating w.r.t. the measure $\mathscr{H}^{k}$ in a variable $x$, we use the notation $d \mathscr{H}_{x}^{k}$ instead of the more standard but less compact $d \mathscr{H}^{k}(x)$.

Balls and spheres. We denote by $B_{r}(x)$ the open ball in $\mathbb{R}^{n}$ of radius $r$ centered at $x$. For simplicity we write $B_{r}$ when $x$ is the origin. The volume of $B_{1}$ is $\omega_{n}:=\left|B_{1}\right|=\frac{\pi^{\frac{n}{2}}}{\Gamma\left(1+\frac{n}{2}\right)}$, and the area of the unit sphere $\mathbb{S}^{n-1}$ is $\mathscr{H}^{n-1}\left(\mathbb{S}^{n-1}\right)=n \omega_{n}$. More generally we denote by $\mathbb{S}^{k}$ the $k$-dimensional unit sphere, and for simplicity we write $\left|\mathbb{S}^{k}\right|=\mathscr{H}^{k}\left(\mathbb{S}^{k}\right)$ for its surface area. For any $m>0$ and $x \in \mathbb{R}^{n}$ we let $[B]_{x, m}$ be the open ball of volume $m$ centered at $x$, or simply $[B]_{m}$ if $x=0$.

Sets of finite perimeter. For any nontrivial open set $\Omega \subseteq \mathbb{R}^{n}$, we denote by $\operatorname{BV}(\Omega)$ the space of functions with bounded variation in $\Omega$, and for any $f \in \mathrm{BV}(\Omega)$ we let $|D f|$ be its total variation measure, and set $[f]_{\mathrm{BV}(\Omega)}:=\int_{\Omega}|D f|$. For a set of finite perimeter $E$ in $\Omega$, we let $\mathbf{1}_{E} \in \operatorname{BV}(\Omega)$ be its characteristic function (i.e., $\mathbf{1}_{E}(x)=1$ if $x \in E$ and 0 otherwise), and define its perimeter in $\Omega$ by $P(E ; \Omega):=\int_{\Omega}\left|D \mathbf{1}_{E}\right|$. If $\Omega=\mathbb{R}^{n}$ we simply write $P(E):=P\left(E ; \mathbb{R}^{n}\right)$. We denote by $\mu_{E}:=D \mathbf{1}_{E}$ the Gauss-Green measure associated with the set of finite perimeter $E$ and $\nu_{E}(x)$ the outer unit normal of $\partial^{*} E$ at $x$, where $\partial^{*} E$ stands for the reduced boundary of $E$. We refer e.g. to [11, Chapter 5] or [25] for further details on functions of bounded variations and sets of finite perimeter.

## 2. Motivation and context

2.1. No repulsion: the classical isoperimetric problem. First let us say a few words about the simplest case for $(\star)$, that is, when $G \equiv 0$. In that case, $(\star)$ is the classical isoperimetric problem which consists in minimizing the perimeter under a volume constraint. It is known that the unique minimizer is the ball, up to translations (see e.g. [10]), which gives the classical isoperimetric inequality

$$
P(E) \geqslant P\left([B]_{m}\right)
$$

for any set of finite perimeter $E$ with volume $m$, and can be rewritten

$$
\begin{equation*}
P(E) \geqslant n \omega_{n}^{\frac{1}{n}}|E|^{1-\frac{1}{n}} . \tag{2.1}
\end{equation*}
$$

Knowing that balls are solutions to the classical isoperimetric problem, it is then natural to consider the related question: if the perimeter of a set $E$ of volume $m$ is close to $P\left([B]_{m}\right)$, is $E$ close to the ball $[B]_{m}$ in some sense, and if so, is it possible to quantify it? An answer to this question has been given in [14] (see also [13] for a refinement), in the form of a so-called quantitative version of the isoperimetric
inequality, which we recall just below. Given a set with finite perimeter $E$ such that $|E|=m$, we define the isoperimetric deficit of $E$ by

$$
D(E):=\frac{P(E)-P\left([B]_{m}\right)}{P\left([B]_{m}\right)}
$$

and its Fraenkel asymmetry by

$$
\alpha(E):=\min \left\{\frac{\left|E \triangle[B]_{x, m}\right|}{m}: x \in \mathbb{R}^{n}\right\} .
$$

The sharp quantitative isoperimetric inequality proven in [14] then states that there exists a constant $C=C(n)$ such that

$$
\begin{equation*}
\alpha(E) \leqslant C \sqrt{D(E)} \tag{2.2}
\end{equation*}
$$

and that the $\frac{1}{2}$ exponent over $D(E)$ is sharp. In addition to their intrinsic interest, isoperimetric inequalities are a very useful tool to study related isoperimetric problems, and we shall often rely on them in the rest of the paper.
2.2. Slow decay at infinity: Riesz potentials. Problems such as $(\star)$ are essentially inspired by a simple model for the atomic nucleus introduced by George Gamow in the late 1920s, which is now referred to as Gamow's liquid drop model. This denomination is due to the fact that in this simple model (then refined by Heisenberg, von Weizsäcker and Bohr in the 1930s), the protons and neutrons inside the atomic nucleus are treated as an incompressible and uniformly charged fluid. In this model, the atomic nucleus is represented by a set $\Omega \subseteq \mathbb{R}^{3}$ of volume $m$ (which corresponds to its mass), and its energy is given by

$$
P(\Omega)+\frac{1}{8 \pi} \iint_{\Omega \times \Omega} \frac{1}{|x-y|} \mathrm{d} x \mathrm{~d} y .
$$

The perimeter term represents the energy associated with the attractive short-range nuclear force, while the Coulombic repulsive term is due to the positively charged protons pushing themselves away from each other. This model successfully explained the phenomenon of nuclear fission: indeed, there are two critical masses $0<m_{1} \leqslant m_{2}<\infty$ such that, below $m_{1}$, the problem admits a minimizer (no fission), and above $m_{2}$, there is no minimizer (fission). In fact, there exists another threshold $0<m_{0} \leqslant m_{1}$ such that, below it, the ball is the unique minimizer (up to translations). These results were first rigorously proven in [20]. Many variants and generalizations of this model have been proposed since then, one of the most natural being to replace the Newton potential $\frac{1}{|x|^{n-2}}$ in dimension 3 with Riesz potentials in arbitrary dimension $n \geqslant 2$, that is

$$
G(x)=\frac{1}{|x|^{n-\alpha}}, \quad \alpha \in(0, n)
$$

The Newton case $\alpha=2$ in dimension $n \geqslant 3$ was treated e.g. in [18], the Riesz cases in dimension 2 for $\alpha \in(0,2)$ in [19], in arbitrary dimension for $\alpha \in(0, n-1)$ in [6], and finally the complete Riesz case in arbitrary dimension for every $\alpha \in(0, n)$ in [12], where the perimeter $P(E)$ can also be replaced by the $s$-fractional perimeter $P_{s}(E)$ with $s \in(0,1)$.

Let us sum up some of what is known in the Riesz case in the following theorems.
Theorem 2.1 ( $[19,20,18,6,12])$. Given $n \geqslant 2$ and $\alpha \in(0, n)$, there exists $m_{0}=m_{0}(n, \alpha)$ such that for any $m<m_{0}$ the ball $[B]_{m}$ is the unique minimizer of $(\star)$ for $G(x)=|x|^{-(n-\alpha)}$, up to translations.

There are also some nonexistence results.
Theorem $2.2([6,19,20,24])$. Given $n \geqslant 2$ and $\alpha \in(n-2, n)$, there exists $m_{1}=m_{1}(n, \alpha)$ such that for any $m>m_{1},(\star)$ admits no minimizer for $G(x)=|x|^{-(n-\alpha)}$.

These nonexistence results for large masses are in a sense not surprising. Indeed, on the one hand, note that without the perimeter term the problem

$$
\min \left\{\iint_{E \times E} \frac{1}{|x-y|^{n-\alpha}} \mathrm{d} x \mathrm{~d} y:|E|=m\right\}
$$

admits no minimizer, as it is always better to split a set $E$ into infinitely many pieces and send them farther from each other at infinity, since Riesz kernels are (strictly) radially decreasing. On the other hand, the relatively slow decay at infinity of the Riesz kernels make them nonintegrable, which would
explain why the repulsive potential takes over the perimeter term in ( $\star$ ) for large masses, resulting in the nonexistence of minimizers.

As for the thresholds $m_{0}, m_{1}$, and $m_{2}$, physical evidence indicate that in dimension $n=3$ at least, they should be equal, but this has yet to be proven.

It is worth noting that in [15], the authors obtain existence of minimizers of arbitrarily large mass by adding to the perimeter term and the Riesz potential an extra cohesive term of the form $\int_{E}|x|^{\beta} \mathrm{d} x$, where $\beta$ is a positive number.
2.3. Compactly supported kernels. An interesting case is when the kernel $G$ has compact support, i.e., when the long-range interaction fully disappears at some distance. Recalling our informal discussion on nonexistence of minimizers for Riesz potentials, we see that in the compact case, sending disjoint pieces of a set $E$ at infinity does not decrease the energy of the nonlocal term: when the pieces are far enough, they simply do not interact with each other. Thus we may imagine that it is possible to build a minimizing sequence lying in a fixed ball, and prove existence of minimizers by the direct method. In dimension $n=2$, this strategy could probably be implemented quite readily, provided one controls the number of connected components of a minimizing sequence (the advantage being that sets of finite perimeter are essentially bounded, that is, included in a ball), but in higher dimension it is much more complex.

Fortunately, using the link between minimizers of $(\star)$ and quasi-minimizers of the perimeter (see Section 4.4), that case was successfully treated by S. Rigot in [27], yielding the following result.

Theorem 2.3 ([27]). If $G$ is compactly supported, then $(\star)$ always admits minimizers. In addition, for any minimizer $E, \partial^{*} E$ is a $C^{1, \frac{1}{2}}$-hypersurface, and, up to choosing a good representative, $E$ has a finite number of connected components $N$, where $N$ can be bounded depending only on $G$, $n$ and $m$.

Note that Theorem 2.3 stands true even if $G$ is not radial. A consequence of this theorem and of Theorem C is that we can easily build kernels such that large mass minimizers exist and are nontrivial, as mentioned in the introduction.
2.4. Intermediate case: Bessel kernels. Between Riesz kernels, which are slowly decreasing kernels, and compactly supported kernels, it is natural to wonder what happens in the intermediate case of rapidly decreasing kernels such as Bessel kernels. Bessel kernels are usually given by the operators $(I-\Delta)^{-\frac{\alpha}{2}}$ for $\alpha \in(0, n)$, i.e., the Bessel kernel of order $\alpha$ is the fundamental solution of

$$
(I-\Delta)^{\frac{\alpha}{2}} f=\delta_{0} \quad \text { in } \mathscr{D}^{\prime}\left(\mathbb{R}^{n}\right)
$$

where $\boldsymbol{\delta}_{0}$ is the Dirac distribution at the origin. In fact, we consider the "generalized" Bessel kernels given by $(I-\kappa \Delta)^{-\frac{\alpha}{2}}$, where $\alpha, \kappa \in(0,+\infty)$. As far as we know, there is little literature on $(\star)$ when $G$ is a Bessel kernel, and especially on the asymptotic behavior for large masses. Compared with Riesz kernels (which are associated with the operators $(-\Delta)^{-\frac{\alpha}{2}}$ ), Bessel kernels are generally not explicit, in the sense that they only have an integral representation, and they do not behave as nicely as Riesz kernels under scaling. Near the origin, Riesz and Bessel kernels of the same order $\alpha$ behave similarly, however at infinity Bessel kernels decay much faster. Their decay at infinity is exponential (in particular, they are integrable), making them an intermediate case between Riesz kernels and compactly supported kernels.

Physically, Bessel kernels are suggested in [21] to model diblock copolymer melts when the long-range interactions are partially screened by fluctuations in the background nuclear fluid density.

Note that even though Bessel kernels decay exponentially, the situation is very different from the compact support case: here, there is always a little interaction between pieces of $E$, no matter how far they are to one another, thus we cannot use the strategy implemented in [27] to get compactness of minimizing sequences, even in dimension $n=2$.

For small masses, the similarity between Riesz and Bessel kernels near the origin suggests that ( $\star$ ) presents the same kind of behavior whether $G$ is a Riesz or a Bessel kernel of the same order $\alpha$, that is, there exists a critical mass below which, up to translations, the ball of volume $m$ is the unique minimizer. In this "small volume" case, we believe the approach for the Riesz case in [12] can be adapted without major difficulties, but this is not the subject of this paper. We are more interested in the case of large volumes. For Riesz kernels of order $\alpha \in(n-2, n)$, it is known that above a critical mass, $(\star)$ admits no minimizers. Here, the better integrability of the Bessel kernels changes the asymptotic behavior when the mass goes to infinity: if $\kappa$ is small enough, ( $\star$ ) admits large mass
minimizers, and up to translations, any sequence of normalized (to unit mass) minimizers converges to the unit ball as the mass goes to infinity (see Application D). We end this introductory discussion on Bessel kernels here, leaving the more technical reminders for Section 3.2.

## 3. Preliminaries

For the rest of the paper, we shall always assume that the kernel $G$ satisfies assumptions (H1) to (H2). The more restricive bounds at the origin and at infinity given by (H3) and (H4) are in fact required only in Section 5 dedicated to the stability of the ball, essentially in order to be able to use directly computations from [12] for the second variation of the nonlocal perimeter. In dimension $n=2$, (H4) requires $G(x)=o\left(|x|^{-3}\right)$ at infinity, which is stronger than what is required in higher dimension: this is due to the presence of a jacobian determinant when integrating on the sphere, which appears to be singular only in dimension 2 (see Lemma 5.9).
3.1. Nonlocal perimeters. As mentioned in the introduction, the rest of our study relies on the introduction of the functional $\mathrm{Per}_{G}$, sometimes referred to as the nonlocal $G$-perimeter of $E$ (see e.g. $[5,8])$ and the reformulation $\left(\mathrm{P}_{\gamma, \lambda}\right)$ of the original problem. Since the ball $B_{1}$ maximizes $\iint_{E \times E} G(x-$ $y) \mathrm{d} x \mathrm{~d} y$ under volume constraint, it minimizes $\operatorname{Per}_{G}(E)$ among sets of volume $\left|B_{1}\right|$, so we notice again the competition between the two term $P$ and $\mathrm{Per}_{G}$ in the minimization problem. One of the reasons why $\operatorname{Per}_{G}$ can be thought of as a perimeter appears if one imagines that the kernel $G$ is singular at the origin, and decreases quickly away from it. Heuristically in that case the part in $\operatorname{Per}_{G}(E)$ that prevails would be when $x$ and $y$ are close to one another, so that

$$
\operatorname{Per}_{G}(E) \simeq \iint_{\substack{E \times E^{\mathrm{c}} \\|x-y|<\varepsilon}} G(x-y) \mathrm{d} x \mathrm{~d} y
$$

for a small positive $\varepsilon$. But notice that the set $\left(E \times E^{c}\right) \cap\{|x-y|<\varepsilon\}$ is included in $\left(\partial E+B_{\varepsilon}\right)^{2}$. Hence what seems to prevail in $\operatorname{Per}_{G}(E)$ is the interaction near the boundary $\partial E$; however, in our case the kernel may not be singular at the origin, nor radially nonincreasing.

In addition, $\operatorname{Per}_{G}(E)$ can be controlled by the classical perimeter, using that

$$
\|f(h+\cdot)-f\|_{L^{1}\left(\mathbb{R}^{n}\right)} \leqslant|h|[f]_{\mathrm{BV}\left(\mathbb{R}^{n}\right)}, \quad \forall f \in \mathrm{BV}\left(\mathbb{R}^{n}\right), \forall h \in \mathbb{R}^{n}
$$

Indeed, by a change of variables and Fubini's theorem we find

$$
\begin{aligned}
\operatorname{Per}_{G}(E)=\iint_{E \times E^{c}} G(x-y) \mathrm{d} x \mathrm{~d} y & =\frac{1}{2} \iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}}\left|\mathbf{1}_{E}(x+h)-\mathbf{1}_{E}(x)\right| G(h) \mathrm{d} x \mathrm{~d} h \\
& =\frac{1}{2} \int_{\mathbb{R}^{n}}\left\|\mathbf{1}_{E}(h+\cdot)-\mathbf{1}_{E}\right\|_{L^{1}\left(\mathbb{R}^{n}\right)} G(h) \mathrm{d} h \\
& \leqslant \frac{1}{2} \int_{\mathbb{R}^{n}}|h| P(E) G(h) \mathrm{d} h=\frac{I_{G}^{1}}{2} P(E) .
\end{aligned}
$$

We can actually refine the constant in this inequality using the following proposition, inspired by [9, Lemma 3].

Proposition 3.1. Let $f \in \mathrm{BV}\left(\mathbb{R}^{n}\right)$, and let $\rho:(0,+\infty) \rightarrow[0,+\infty)$ be a measurable function such that $\int_{\mathbb{R}^{n}} \rho(|x|) \mathrm{d} x=1$. Then

$$
\begin{equation*}
\iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}} \frac{|f(x)-f(y)|}{|x-y|} \rho(|x-y|) \mathrm{d} x \mathrm{~d} y \leqslant \mathbf{K}_{1, n} \int_{\mathbb{R}^{n}}|D f|, \tag{3.1}
\end{equation*}
$$

where $\mathbf{K}_{1, n}$ is defined by (1.2).
Proof. The proof is similar to [9, Proof of Lemma 3], but we detail it here for the reader's convenience. Up to a translation, without loss of generality we may assume that $x_{0}=0$. By approximation (see e.g. [11, Theorem 5.3]), we may assume that $f \in C^{\infty}\left(\mathbb{R}^{n}\right)$, and by cut-off, that $f$ is also compactly supported. Integrating on lines we have

$$
f(x+h)-f(x)=\int_{0}^{1} \nabla f(x+t h) \cdot h \mathrm{~d} t
$$

thus, making the change of variables $h=x-y$, using Fubini's theorem we find

$$
\begin{equation*}
\iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}} \frac{|f(x)-f(y)|}{|x-y|} \rho(|x-y|) \mathrm{d} x \mathrm{~d} y=\int_{\mathbb{R}^{n}}\left(\int_{\mathbb{R}^{n}}\left|\int_{0}^{1} \nabla f(x-t h) \cdot h \mathrm{~d} t\right| \mathrm{d} x\right) \frac{\rho(|h|)}{|h|} \mathrm{d} h . \tag{3.2}
\end{equation*}
$$

Applying the coarea formula to (3.2) and then Cauchy-Schwarz inequality and Fubini's theorem gives

$$
\begin{align*}
& \iint_{B_{R} \times B_{R}} \frac{|f(x)-f(y)|}{|x-y|} \rho(|x-y|) \mathrm{d} x \mathrm{~d} y \\
& \quad=\int_{0}^{\infty} \int_{\mathbb{S}^{n-1}}\left(\int_{\mathbb{R}^{n}}\left|\int_{0}^{1} \nabla f(x-t r \sigma) \cdot \sigma \mathrm{d} t\right| \mathrm{d} x\right) \rho(r) r^{n-1} d \mathscr{H}_{\sigma}^{n-1} \mathrm{~d} r \\
& \quad \leqslant \int_{0}^{\infty} \int_{\mathbb{S}^{n-1}}\left(\int_{0}^{1} \int_{\mathbb{R}^{n}}|\nabla f(x-t r \sigma) \cdot \sigma| \mathrm{d} x \mathrm{~d} t\right) \rho(r) r^{n-1} d \mathscr{H}_{\sigma}^{n-1} \mathrm{~d} r  \tag{3.3}\\
& \quad=\int_{0}^{\infty} \int_{\mathbb{S}^{n-1}} \int_{\mathbb{R}^{n}}|\nabla f(x) \cdot \sigma| \mathrm{d} x \rho(r) r^{n-1} d \mathscr{H}_{\sigma}^{n-1} \mathrm{~d} r .
\end{align*}
$$

Using Fubini's theorem once again and the equality

$$
f_{\mathbb{S}^{n-1}}|\nabla f(x) \cdot \sigma| d \mathscr{H}_{\sigma}^{n-1}=\mathbf{K}_{1, n}|\nabla f(x)|
$$

from (3.3) we obtain

$$
\begin{aligned}
& \iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}} \frac{|f(x)-f(y)|}{|x-y|} \rho(|x-y|) \mathrm{d} x \mathrm{~d} y \\
& \quad \leqslant\left|\mathbb{S}^{n-1}\right| \mathbf{K}_{1, n} \int_{0}^{\infty} \int_{\mathbb{R}^{n}}|\nabla f(x)| \rho(r) r^{n-1} \mathrm{~d} x \mathrm{~d} r=\mathbf{K}_{1, n}\left(\int_{\mathbb{R}^{n}}|\nabla f(y)| \mathrm{d} y\right)\left(\int_{\mathbb{R}^{n}} \rho(|x|) \mathrm{d} x\right),
\end{aligned}
$$

hence (3.1), since

$$
\int_{\mathbb{R}^{n}} \rho(|x|) \mathrm{d} x=1 .
$$

Remark 3.2. Note that by Proposition 3.8 further below, the constant $\mathbf{K}_{1, n}$ in Proposition 3.1 is optimal

Setting $\rho_{G}(r):=\frac{r g(r)}{2}$, we have $\int_{\mathbb{R}^{n}} \rho_{G}(|x|) \mathrm{d} x=\frac{1}{\mathbf{K}_{1, n}}$, and rewriting $\operatorname{Per}_{G}(E)$ as

$$
\begin{align*}
\operatorname{Per}_{G}(E) & =\frac{1}{2} \iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}}\left|\mathbf{1}_{E}(x)-\mathbf{1}_{E}(y)\right| G(x-y) \mathrm{d} x \mathrm{~d} y \\
& =\iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}} \frac{\left|\mathbf{1}_{E}(x)-\mathbf{1}_{E}(y)\right|}{|x-y|} \rho_{G}(|x-y|) \mathrm{d} x \mathrm{~d} y, \tag{3.4}
\end{align*}
$$

a direct application of the previous proposition with $f=\mathbf{1}_{E}$ leads to the following control of the nonlocal perimeter by the local perimeter.

Corollary 3.3. For any set of finite perimeter E, we have

$$
\operatorname{Per}_{G}(E) \leqslant P(E) .
$$

Recall that the classical perimeter is lower semicontinuous with respect to the classical topology of $L^{1}\left(\mathbb{R}^{n}\right)$. Here the nonlocal perimeter is in fact continuous w.r.t. the $L^{1}$ convergence, as is shown in the following lemma.

Lemma 3.4. For any sets $E$ and $F$ with finite Lebesgue measure, we have

$$
\left|\operatorname{Per}_{G}(E)-\operatorname{Per}_{G}(F)\right| \leqslant I_{G}^{0}|E \triangle F| .
$$

Proof. Let $E$ and $F$ be sets with finite (possibly different) Lebesgue measure. Using

$$
\operatorname{Per}_{G}(E)=\frac{1}{2} \iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}}\left|\mathbf{1}_{E}(x)-\mathbf{1}_{E}(y)\right| G(x-y) \mathrm{d} x \mathrm{~d} y,
$$

we have

$$
\operatorname{Per}_{G}(E)-\operatorname{Per}_{G}(F)=\frac{1}{2} \iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}}\left(\left|\mathbf{1}_{E}(x)-\mathbf{1}_{E}(y)\right|-\left|\mathbf{1}_{F}(x)-\mathbf{1}_{F}(y)\right|\right) G(x-y) \mathrm{d} x \mathrm{~d} y .
$$

Thus by the triangle inequality,

$$
\begin{aligned}
\left|\operatorname{Per}_{G}(E)-\operatorname{Per}_{G}(F)\right| & \leqslant \frac{1}{2} \iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}}\left(\left|\mathbf{1}_{E}(x)-\mathbf{1}_{F}(x)\right|+\left|\mathbf{1}_{E}(y)-\mathbf{1}_{F}(y)\right|\right) G(x-y) \mathrm{d} x \mathrm{~d} y \\
& =\frac{1}{2} \iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}}\left(\mathbf{1}_{E \Delta F}(x)+\mathbf{1}_{E \Delta F}(y)\right) G(x-y) \mathrm{d} x \mathrm{~d} y=I_{G}^{0}|E \Delta F|
\end{aligned}
$$

One of the nice properties of the classical perimeter is also its behavior under scaling. For any set of finite perimeter $E$ and any $t>0$, we obviously have $P(t E)=t^{n-1} P(E)$. This is unfortunately not the case for such nonlocal perimeters. However just as $\frac{\mathrm{d}}{\mathrm{d} t}[P(t E)]=(n-1) t^{n-2} P(E)$, one can show that $\frac{\mathrm{d}}{\mathrm{d} t}\left[\operatorname{Per}_{G}(t E)\right]$ is (essentially) bounded by $C t^{n-2} P(E)$, for some $C=C(n)$, thanks to assumptions (H1) and (H2).

Lemma 3.5. For any set of finite perimeter $E$, the function $t \mapsto \operatorname{Per}_{G}(t E)$ is locally Lipschitz continuous in $(0,+\infty)$, and for almost every $t$,

$$
\begin{equation*}
\frac{\mathrm{d}}{\mathrm{~d} t}\left[\operatorname{Per}_{G}(t E)\right]=\frac{n}{t} \operatorname{Per}_{G}(t E)+\frac{1}{t} \int_{t E}\left(\int_{\partial(t E)} G(x-y)(x-y) \cdot \nu_{E}(y) d \mathscr{H}_{y}^{n-1}\right) \mathrm{d} x \tag{3.5}
\end{equation*}
$$

In particular

$$
\begin{equation*}
\left|\frac{\mathrm{d}}{\mathrm{~d} t}\left[\operatorname{Per}_{G}(t E)\right]\right| \leqslant C t^{n-2} P(E), \quad \text { for a.e. } t \in(0,+\infty) \tag{3.6}
\end{equation*}
$$

for some $C=C(n)$.
Proof. By approximation, there exists a sequence of functions $\left(G_{k}\right)_{k \in \mathbb{N}} \subseteq C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ converging to $G$ in $L^{1}\left(\mathbb{R}^{n}\right)$ and such that $\left|G_{k}\right| \leqslant G$. By scaling, we have

$$
\operatorname{Per}_{G_{k}}(t E)=t^{2 n} \iint_{E \times E^{\mathrm{c}}} G_{k}(t(x-y)) \mathrm{d} x \mathrm{~d} y
$$

thus, differentiating under the integral and changing variables, we find

$$
\begin{align*}
\frac{\mathrm{d}}{\mathrm{~d} t}\left[\operatorname{Per}_{G_{k}}(t E)\right] & =\frac{2 n}{t} \operatorname{Per}_{G_{k}}(t E)+t^{2 n} \iint_{E \times E^{\mathrm{c}}} \nabla G_{k}(t(x-y)) \cdot(x-y) \mathrm{d} x \mathrm{~d} y \\
& =\frac{2 n}{t} \operatorname{Per}_{G_{k}}(t E)+\frac{1}{t} \iint_{(t E) \times(t E)^{\mathrm{c}}} \nabla G_{k}(x-y) \cdot(x-y) \mathrm{d} x \mathrm{~d} y \tag{3.7}
\end{align*}
$$

Notice that

$$
\operatorname{div}_{y}\left((x-y) G_{k}(x-y)\right)=-n G_{k}(x-y)-\nabla G_{k}(x-y) \cdot(x-y)
$$

thus by the divergence theorem,

$$
\begin{aligned}
& \int_{(t E)^{\mathrm{c}}} \nabla G_{k}(x-y) \cdot(x-y) \mathrm{d} y=-n \int_{(t E)^{\mathrm{c}}} G_{k}(x-y) \mathrm{d} y \\
&+\int_{\partial(t E)} G_{k}(x-y)(x-y) \cdot \nu_{t E}(y) d \mathscr{H}_{y}^{n-1} .
\end{aligned}
$$

Plugging this into (3.7) gives

$$
\begin{equation*}
\frac{\mathrm{d}}{\mathrm{~d} t}\left[\operatorname{Per}_{G_{k}}(t E)\right]=\frac{n}{t} \operatorname{Per}_{G_{k}}(t E)+\frac{1}{t} \int_{t E}\left(\int_{\partial(t E)} G_{k}(x-y)(x-y) \cdot \nu_{t E}(y) d \mathscr{H}_{y}^{n-1}\right) \mathrm{d} x \tag{3.8}
\end{equation*}
$$

One the one hand, notice that

$$
\left|\operatorname{Per}_{G}(t E)-\operatorname{Per}_{G_{k}}(t E)\right| \leqslant t^{n}|E|\left\|G_{k}-G\right\|_{L^{1}\left(\mathbb{R}^{n}\right)}, \quad \forall k \in \mathbb{N}
$$

thus $t \mapsto \operatorname{Per}_{G_{k}}(t E)$ and $t \mapsto \frac{n}{t} \operatorname{Per}_{G_{k}}(t E)$ converge respectively locally uniformly in $(0, \infty)$ to $t \mapsto$ $\operatorname{Per}_{G}(t E)$ and $t \mapsto \frac{n}{t} \operatorname{Per}_{G}(t E)$ as $k$ goes to infinity. On the other hand, given $\varepsilon>0$, since $I_{G}^{1}$ is finite and $\left|G_{k}\right| \leqslant G$, we may choose $R$ large enough so that

$$
\int_{B_{R}^{c}}|x| G(x) \mathrm{d} x \leqslant \varepsilon \quad \text { and } \quad \int_{B_{R}^{\mathrm{c}}}|x|\left|G_{k}(x)\right| \mathrm{d} x \leqslant \varepsilon
$$

for every $k \in \mathbb{N}$. Thus, splitting the integral below into the two parts $|x-y|<R$ and $|x-y| \geqslant R$, we find

$$
\begin{aligned}
& \int_{t E}\left(\int_{\partial(t E)}\left|\left(G_{k}-G\right)(x-y)(x-y) \cdot \nu_{t E}(y)\right| d \mathscr{H}_{y}^{n-1}\right) \mathrm{d} x \\
& \quad \leqslant P(t E)\left(\int_{B_{R}}|x|\left|\left(G_{k}-G\right)(x)\right| \mathrm{d} x+2 \varepsilon\right) \\
& \quad \leqslant t^{n-1} P(E)\left(R\left\|G_{k}-G\right\|_{L^{1}\left(\mathbb{R}^{n}\right)}+2 \varepsilon\right), \quad \forall t>0, \forall k \in \mathbb{N}
\end{aligned}
$$

which shows local uniform convergence in $(0, \infty)$ of the last term in (3.8), by the arbitrarines of $\varepsilon$. Whence, given any $\varphi \in C_{c}^{\infty}(0, \infty)$, passing to the limit in

$$
\int_{0}^{\infty} \operatorname{Per}_{G_{k}}(t E) \varphi^{\prime}(t) \mathrm{d} t=\int_{0}^{\infty} \frac{\mathrm{d}}{\mathrm{~d} t}\left[\operatorname{Per}_{G_{k}}(t E)\right] \varphi(t) \mathrm{d} t
$$

yields that $t \mapsto \operatorname{Per}_{G}(t E)$ is weakly differentiable, and for a.e. $t \in(0, \infty)$, we have

$$
\frac{\mathrm{d}}{\mathrm{~d} t}\left[\operatorname{Per}_{G}(t E)\right]=\frac{n}{t} \operatorname{Per}_{G}(t E)+\frac{1}{t} \int_{t E}\left(\int_{\partial(t E)} G(x-y)(x-y) \cdot \nu_{t E}(y) d \mathscr{H}_{y}^{n-1}\right) \mathrm{d} x
$$

Then (3.6) follows by using $\operatorname{Per}_{G}(t E) \leqslant P(t E)$ and noticing that

$$
\left|\int_{t E}\left(\int_{\partial(t E)} G(x-y)(x-y) \cdot \nu_{E}(y) d \mathscr{H}_{y}^{n-1}\right) \mathrm{d} x\right| \leqslant I_{G}^{1} P(t E)=\frac{2}{\mathbf{K}_{1, n}} P(t E)
$$

In turn, (3.6) gives the local Lipschitz continuity of $t \mapsto \operatorname{Per}_{G}(t E)$.
Now, although (3.6) would be sufficient for our needs, we can use Lemma 3.5 to get a clearer idea of how much $\mathcal{F}_{\gamma, G_{\lambda}}(E)$ may increase or decrease by scaling $E$.

Lemma 3.6. Assume $\gamma<1$, and let $E$ be a set with finite perimeter. Then for any $t>1$, we have

$$
\mathcal{F}_{\gamma, G_{\lambda}}(t E)-\mathcal{F}_{\gamma, G_{\lambda}}(E) \leqslant\left(t^{n}-1\right) \mathcal{F}_{\gamma, G_{\lambda}}(E),
$$

and for any $0<t<1$,

$$
\mathcal{F}_{\gamma, G_{\lambda}}(t E)-\mathcal{F}_{\gamma, G_{\lambda}}(E) \leqslant\left(t^{n-1}-1\right) \mathcal{F}_{\gamma, G_{\lambda}}(E)
$$

In particular, $\mathcal{F}_{\gamma, G_{\lambda}}(E)$ decreases when downscaling $E$.
Proof. Defining $u(t):=\operatorname{Per}_{G}(t E), u$ satisfies $u^{\prime}(t)=\frac{n}{t} u(t)+\frac{1}{t} f(t)$, where

$$
f(t):=\int_{t E}\left(\int_{\partial(t E)} G(x-y)(x-y) \cdot \nu_{t E}(y) d \mathscr{H}_{y}^{n-1}\right) \mathrm{d} x .
$$

Since we want an upper bound on $\mathcal{F}_{\gamma, G_{\lambda}}$, we are going to give a lower bound for $f(t)$. Dropping the subscript in $\nu_{t E}$, let us write

$$
\begin{aligned}
f(t) & \geqslant \iint_{\substack{t E \times \partial(t E) \\
(x-y) \cdot \nu(y)<0}} G(x-y)(x-y) \cdot \nu(y) \mathrm{d} x d \mathscr{H}_{y}^{n-1} \\
& \geqslant-\int_{\partial(t E)}\left(\int_{\mathbb{R}^{n} \cap\{z \cdot \nu(y)<0\}} G(z)|z \cdot \nu(y)| \mathrm{d} z\right) d \mathscr{H}_{y}^{n-1} .
\end{aligned}
$$

Using the coarea formula, it follows

$$
\begin{aligned}
f(t) & \geqslant-\int_{\partial(t E)}\left(\int_{0}^{\infty} r^{n} g(r) \int_{\mathbb{S}^{n-1} \cap\{\sigma \cdot \nu(y)<0\}}|\sigma \cdot \nu(y)| \mathrm{d} \sigma \mathrm{~d} r\right) d \mathscr{H}_{y}^{n-1} \\
& =-\frac{\mathbf{K}_{1, n}}{2} \int_{\partial(t E)}\left(\left|\mathbb{S}^{n-1}\right| \int_{0}^{\infty} r^{n} g(r) \mathrm{d} r\right) d \mathscr{H}_{y}^{n-1} \\
& =-\frac{\mathbf{K}_{1, n} I_{G}^{1}}{2} P(t E)=-P(t E) .
\end{aligned}
$$

Thus

$$
\frac{\mathrm{d}}{\mathrm{~d} t}\left[t^{-n} u(t)\right]=t^{-n}\left(u^{\prime}(t)-\frac{n}{t} u(t)\right)=t^{-(n+1)} f(t) \geqslant-\frac{P(E)}{t^{2}},
$$

which gives, integrating between 1 and $t$,

$$
u(t) \geqslant t^{n} u(1)+t^{n-1}(1-t) P(E)
$$

Hence,

$$
\begin{aligned}
\mathcal{F}_{\gamma, G_{\lambda}}(t E)-\mathcal{F}_{\gamma, G_{\lambda}}(E) & =\left(t^{n-1}-1\right) P(E)-\gamma(u(t)-u(1)) \\
& \leqslant\left(t^{n-1}-1\right) P(E)-\gamma\left(t^{n}-1\right) u(1)-\gamma t^{n-1}(1-t) P(E) .
\end{aligned}
$$

Let us distinguish between the two cases $t<1$ and $t>1$. If $t>1$ we write

$$
\begin{aligned}
\mathcal{F}_{\gamma, G_{\lambda}}(t E)-\mathcal{F}_{\gamma, G_{\lambda}}(E) & \leqslant\left(t^{n}-1+t^{n-1}-t^{n}\right) P(E)-\gamma\left(t^{n}-1\right) u(1)-\gamma t^{n-1}(1-t) P(E) \\
& \leqslant\left(t^{n}-1\right) \mathcal{F}_{\gamma, G_{\lambda}}(E)+(1-\gamma) t^{n-1}(1-t) P(E) \\
& \leqslant\left(t^{n}-1\right) \mathcal{F}_{\gamma, G_{\lambda}}(E),
\end{aligned}
$$

and if $t<1$, we write

$$
\begin{aligned}
\mathcal{F}_{\gamma, G_{\lambda}}(t E)-\mathcal{F}_{\gamma, G_{\lambda}}(E) & \leqslant\left(t^{n-1}-1\right) P(E)-\gamma\left(t^{n-1}-1+t^{n}-t^{n-1}\right) u(1)-\gamma t^{n-1}(1-t) P(E) \\
& \leqslant\left(t^{n-1}-1\right) \mathcal{F}_{\gamma, G_{\lambda}}(E)-\gamma t^{n-1}(1-t)(P(E)-u(1)) \\
& \leqslant\left(t^{n-1}-1\right) \mathcal{F}_{\gamma, G_{\lambda}}(E)
\end{aligned}
$$

where in both cases we used the fact that $\gamma<1$. This concludes the proof.
Starting from $\rho_{G}(r)=\frac{r g(r)}{2}$, let us introduce the rescalings

$$
\begin{equation*}
\rho_{G, \varepsilon}(r):=\varepsilon^{-n} \rho_{G}\left(\varepsilon^{-1} r\right), \tag{3.9}
\end{equation*}
$$

for every $\varepsilon>0$. Then it is convenient to rewrite $\operatorname{Per}_{G_{\lambda}}(E)$ as

$$
\begin{equation*}
\operatorname{Per}_{G_{\lambda}}(E)=\iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}} \frac{\left|\mathbf{1}_{E}(x)-\mathbf{1}_{E}(y)\right|}{|x-y|} \rho_{G, 1 / \lambda}(|x-y|) \mathrm{d} x \mathrm{~d} y . \tag{3.10}
\end{equation*}
$$

Notice that

$$
\begin{equation*}
\int_{\mathbb{R}^{n}} \rho_{G, 1 / \lambda}(|x|) \mathrm{d} x=\frac{I_{G}^{1}}{2}=\frac{1}{\mathbf{K}_{1, n}} \tag{3.11}
\end{equation*}
$$

The nice thing with this expression is that the family of functions $\left(\rho_{G, \varepsilon}\right)_{\varepsilon>0}$ constitutes, up to multiplication by the universal constant $\mathbf{K}_{1, n}$, a $n$-dimensional approximation of identity, which we define just below.
Definition 3.7 (Approximation of identity). For any $k \in \mathbb{N} \backslash\{0\}$, we say that a family of measurable functions $\left(\rho_{\varepsilon}\right)_{\varepsilon>0}$ from $(0,+\infty)$ into $[0,+\infty)$ is a $k$-dimensional approximation of identity if, for all $\varepsilon>0$, we have
(i) $\left|\mathbb{S}^{k-1}\right| \int_{0}^{\infty} \rho_{\varepsilon}(r) r^{k-1} \mathrm{~d} r=1$;
(ii) $\lim _{\varepsilon \rightarrow 0} \int_{\delta}^{\infty} \rho_{\varepsilon}(r) r^{k-1} \mathrm{~d} r=0, \quad \forall \delta>0$.

The following proposition will be crucial to shed a light on the behavior of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ when $\lambda$ goes to infinity.

Proposition $3.8([9])$. Let $f \in \mathrm{BV}\left(\mathbb{R}^{n}\right)$, and $\left(\rho_{\varepsilon}\right)_{\varepsilon>0}$ be a $n$-dimensional approximation of identity.
Then we have

$$
\iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}} \frac{|f(x)-f(y)|}{|x-y|} \rho_{\varepsilon}(|x-y|) \mathrm{d} x \mathrm{~d} y \xrightarrow{\varepsilon \rightarrow 0} \mathbf{K}_{1, n} \int_{\mathbb{R}^{n}}|D f|,
$$

where $\mathbf{K}_{1, n}$ is defined by (1.2).
Taking $f=\mathbf{1}_{E}$ in Proposition 3.8 gives the following immediate corollary, in view of (3.10) and (3.11).
Corollary 3.9. For any set of finite perimeter $E$ in $\mathbb{R}^{n}$, we have

$$
\operatorname{Per}_{G_{\lambda}}(E) \xrightarrow{\lambda \rightarrow \infty} P(E) .
$$

This implies that the functional $\mathcal{F}_{\gamma, G_{\lambda}}$ converges pointwise to $(1-\gamma) P$ when $\lambda$ goes to infinity. Thus we may guess that if $\gamma<1$, $\left(\mathrm{P}_{\gamma, \lambda}\right)$ will reduce to minimizing the classical perimeter under the volume constraint $\left|B_{1}\right|$ when $\lambda$ is large.
3.2. Bessel kernels. For any $\kappa$ and $\alpha$ in $(0,+\infty)$, the Bessel kernel $\mathcal{B}_{\kappa, \alpha}$ is the fundamental solution $f$ of

$$
(I-\kappa \Delta)^{\frac{\alpha}{2}} f=\delta_{0} \quad \text { in } \mathscr{D}^{\prime}\left(\mathbb{R}^{n}\right)
$$

When $\kappa=1$, we write $\mathcal{B}_{\alpha}:=\mathcal{B}_{1, \alpha}$. The following proposition sums up some basic properties of $\mathcal{B}_{\alpha}$ (see e.g. [16, Chapter I.2.2], [30, Chapter V.3] and [3, Chapter II.3]).

Proposition 3.10. The Bessel kernel of order $\alpha \in(0,+\infty)$ in $\mathbb{R}^{n}$ is given by

$$
\begin{equation*}
\mathcal{B}_{\alpha}(x)=\frac{1}{(4 \pi)^{\frac{\alpha}{2}}} \frac{1}{\Gamma\left(\frac{\alpha}{2}\right)} \int_{0}^{\infty} e^{-\frac{\pi|x|^{2}}{t}} e^{-\frac{t}{4 \pi}} t^{\frac{\alpha-n}{2}} \frac{\mathrm{~d} t}{t} \tag{3.12}
\end{equation*}
$$

The kernel $\mathcal{B}_{\alpha}$ is radial and radially nonincreasing. In addition

$$
I_{\mathcal{B}_{\alpha}}^{0}=1, \quad \text { and } \quad I_{\mathcal{B}_{\alpha}}^{1}=n \frac{\Gamma\left(\frac{1+\alpha}{2}\right)}{\Gamma\left(\frac{\alpha}{2}\right)} \frac{\Gamma\left(\frac{1+n}{2}\right)}{\Gamma\left(1+\frac{n}{2}\right)} .
$$

The asymptotic behavior of $\mathcal{B}_{\alpha}$ is

$$
\mathcal{B}_{\alpha}(x) \underset{0}{\sim} \begin{cases}\frac{\Gamma\left(\frac{n-\alpha}{2}\right)}{2^{\alpha} \pi^{\frac{n}{2}} \Gamma\left(\frac{\alpha}{2}\right)} \frac{1}{|x|^{n-\alpha}} & \text { if } 0<\alpha<n \\ \frac{-\log (|x|)}{2^{n-1} \pi^{\frac{n}{2}} \Gamma\left(\frac{n}{2}\right)} & \text { if } \alpha=n \\ \frac{\Gamma\left(\frac{\alpha-n}{2}\right)}{2^{n} \pi^{\frac{n}{2}}} & \text { if } n<\alpha,\end{cases}
$$

and

$$
\mathcal{B}_{\alpha}(x) \sim \frac{1}{\infty} \frac{1}{2^{\frac{n+\alpha-1}{2}} \pi^{\frac{n-1}{2}} \Gamma\left(\frac{\alpha}{2}\right)}|x|^{\frac{\alpha-n-1}{2}} e^{-|x|} .
$$

By scaling, for any $\alpha, \kappa>0$, the (generalized) Bessel kernel $\mathcal{B}_{\kappa, \alpha}$ is given by

$$
\begin{equation*}
\mathcal{B}_{\kappa, \alpha}(x)=\frac{1}{\kappa^{\frac{n}{2}}} \mathcal{B}_{\alpha}\left(\frac{x}{\sqrt{\kappa}}\right), \quad \forall x \in \mathbb{R}^{n} \backslash\{0\} \tag{3.13}
\end{equation*}
$$

thus

$$
I_{\mathcal{B}_{\kappa, \alpha}}^{0}=1, \quad \text { and } \quad I_{\mathcal{B}_{\kappa, \alpha}}^{1}=\kappa^{\frac{1}{2}} I_{\mathcal{B}_{\alpha}}^{0,1} .
$$

Proof. The integral representation (3.12) and the asymptotics can be found respectively in [16] and [3], and the fact that $I_{\mathcal{B}_{\alpha}}^{0}=\left\|\mathcal{B}_{\alpha}\right\|_{L^{1}\left(\mathbb{R}^{n}\right)}=1$ is well known, so we detail only the computations of $I_{\mathcal{B}_{\alpha}}^{1}$. By (3.12), using Fubini's theorem, we find

$$
\begin{equation*}
I_{\mathcal{B}_{\alpha}}^{1}=\int_{\mathbb{R}^{n}}|x| \mathcal{B}_{\alpha}(x) \mathrm{d} x=\frac{1}{(4 \pi)^{\frac{\alpha}{2}}} \frac{1}{\Gamma\left(\frac{\alpha}{2}\right)} \int_{0}^{\infty} e^{-\frac{t}{4 \pi}} \frac{\alpha-n}{\frac{\alpha-n}{2}}\left(\int_{\mathbb{R}^{n}}|x| e^{-\frac{\pi|x|^{2}}{t}} \mathrm{~d} x\right) \frac{\mathrm{d} t}{t} . \tag{3.14}
\end{equation*}
$$

Changing variables, we compute

$$
\begin{align*}
\int_{\mathbb{R}^{n}}|x| e^{-\frac{\pi|x|^{2}}{t}} \mathrm{~d} x & =n \omega_{n}\left(\frac{t}{\pi}\right)^{\frac{n+1}{2}} \int_{0}^{\infty} r^{n} e^{-r^{2}} \mathrm{~d} r \\
& =n \omega_{n}\left(\frac{t}{\pi}\right)^{\frac{n+1}{2}} \frac{\Gamma\left(\frac{n+1}{2}\right)}{2}=\frac{n t^{\frac{n+1}{2}}}{\sqrt{4 \pi}} \frac{\Gamma\left(\frac{n+1}{2}\right)}{\Gamma\left(1+\frac{n}{2}\right)} . \tag{3.15}
\end{align*}
$$

Injecting (3.15) into (3.14) yields

$$
\begin{aligned}
I_{\mathcal{B}_{\alpha}}^{1} & =\frac{1}{(4 \pi)^{\frac{1+\alpha}{2}}} \frac{1}{\Gamma\left(\frac{\alpha}{2}\right)} \frac{n \Gamma\left(\frac{n+1}{2}\right)}{\Gamma\left(1+\frac{n}{2}\right)} \int_{0}^{\infty} e^{-\frac{t}{4 \pi}} t^{\frac{\alpha+1}{2}} \frac{\mathrm{~d} t}{t} \\
& =\frac{1}{(4 \pi)^{\frac{1+\alpha}{2}}} \frac{1}{\Gamma\left(\frac{\alpha}{2}\right)} \frac{n \Gamma\left(\frac{n+1}{2}\right)}{\Gamma\left(1+\frac{n}{2}\right)}(4 \pi)^{\frac{1+\alpha}{2}} \Gamma\left(\frac{1+\alpha}{2}\right)=n \frac{\Gamma\left(\frac{1+\alpha}{2}\right)}{\Gamma\left(\frac{\alpha}{2}\right)} \frac{\Gamma\left(\frac{1+n}{2}\right)}{\Gamma\left(1+\frac{n}{2}\right)} .
\end{aligned}
$$

Remark 3.11. In some cases, the Bessel kernels $\mathcal{B}_{\alpha}$ take a very simple form. Indeed, they can also be expressed in terms of the modified Bessel functions of the third kind $\mathrm{K}_{\nu}:(0,+\infty) \rightarrow(0,+\infty)$, defined for any $\nu \in \mathbb{R}$ by

$$
\begin{equation*}
\mathrm{K}_{\nu}(r)=\left(\frac{\pi}{2}\right)^{\frac{1}{2}} \frac{r^{\nu} e^{-r}}{\Gamma\left(\nu+\frac{1}{2}\right)} \int_{0}^{\infty} e^{-r t}\left(t+\frac{t^{2}}{2}\right)^{\nu-\frac{1}{2}} \mathrm{~d} t \quad \text { if } \nu>-\frac{1}{2} \tag{3.16}
\end{equation*}
$$

and the relation $\mathrm{K}_{\nu}=\mathrm{K}_{-\nu}$ (see [3, Chapter II.3]). Then by [3, Chapter II.4], $\mathcal{B}_{\alpha}$ is given by

$$
\begin{equation*}
\mathcal{B}_{\alpha}(x)=\frac{1}{2^{\frac{n+\alpha-2}{2}} \pi^{\frac{n}{2}} \Gamma\left(\frac{\alpha}{2}\right)} \frac{\mathrm{K}_{\frac{n-\alpha}{2}}(|x|)}{|x|^{\frac{n-\alpha}{2}}}, \quad \forall x \in \mathbb{R}^{n} \backslash\{0\} . \tag{3.17}
\end{equation*}
$$

From (3.16) and (3.17) it is easy to see that when $\alpha=n-1, \mathcal{B}_{\alpha}$ takes the explicit form

$$
\mathcal{B}_{n-1}=\frac{1}{(4 \pi)^{\frac{n-1}{2}} \Gamma\left(\frac{n-1}{2}\right)} \frac{e^{-|x|}}{|x|}
$$

In particular, when $n=3$ and $\alpha=2, \mathcal{B}_{\alpha}(x)=\frac{1}{4 \pi} \frac{e^{-|x|}}{|x|}$. When $\alpha=n+1$, changing variables in (3.12), one can compute $\mathcal{B}_{\alpha}$ explicitly as well. Indeed, in that case,

$$
\mathcal{B}_{n+1}(x)=\frac{1}{(4 \pi)^{\frac{n+1}{2}}} \frac{1}{\Gamma\left(\frac{n+1}{2}\right)} 2 \sqrt{4 \pi} \int_{0}^{\infty} e^{-t^{2}-\frac{|x|^{2}}{4 t^{2}}} \mathrm{~d} t=\frac{2 \pi}{(4 \pi)^{\frac{n+1}{2}}} \frac{1}{\Gamma\left(\frac{n+1}{2}\right)} e^{-|x|}
$$

We have the following straightforward corollary of Proposition 3.10.
Corollary 3.12. For every $\alpha, \kappa \in(0,+\infty)$, the kernel $\mathcal{B}_{\kappa, \alpha}$ satisfies assumptions (H1) to (H4).
We can express the constants $\mathbf{K}_{p, n}$ in terms of the Gamma function as follows, in order to compute explicitly $\gamma$ such that $\gamma I_{\mathcal{B}_{\kappa, \alpha}}^{1}=\frac{2}{\mathbf{K}_{1, n}}$ and apply Theorems A to C.
Lemma 3.13. For any $n \in \mathbb{N}$ and $p>0$, we have

$$
\mathbf{K}_{p, n}=\frac{\Gamma\left(\frac{n}{2}\right) \Gamma\left(\frac{1+p}{2}\right)}{\sqrt{\pi} \Gamma\left(\frac{n+p}{2}\right)},
$$

where $\mathbf{K}_{p, n}$ is given by (1.2). In particular

$$
\mathbf{K}_{1, n}=\frac{\Gamma\left(\frac{n}{2}\right)}{\sqrt{\pi} \Gamma\left(\frac{n+1}{2}\right)} \quad \text { and } \quad \mathbf{K}_{2, n}=\frac{1}{n}
$$

Proof. In the definition of $\mathbf{K}_{p, n}$, we may assume $e=(0, \ldots, 0,1)$ without loss of generality, so that $e \cdot x=x_{n}$. Recall that for every nonnegative $\mathscr{H}^{n-1}$-measurable function $f$ on $\mathbb{S}^{n-1}$, we have (see e.g. [17, Section D.2] or [4, Corollary A.6])

$$
\int_{\mathbb{S}^{n-1}} f d \mathscr{H}^{n-1}=\int_{-1}^{1}\left(1-t^{2}\right)^{\frac{n-3}{2}} \int_{\mathbb{S}^{n-2}} f\left(\sqrt{1-t^{2}} x, t\right) d \mathscr{H}_{x}^{n-2} \mathrm{~d} t
$$

This way we compute

$$
\int_{\mathbb{S}^{n-1}}\left|x_{n}\right|^{p} d \mathscr{H}^{n-1}=\left|\mathbb{S}^{n-2}\right| \int_{-1}^{1}|t|^{p}\left(1-t^{2}\right)^{\frac{n-3}{2}} \mathrm{~d} t=\left|\mathbb{S}^{n-2}\right| \frac{\Gamma\left(\frac{n-1}{2}\right) \Gamma\left(\frac{p+1}{2}\right)}{\Gamma\left(\frac{n+p}{2}\right)},
$$

thus

$$
\mathbf{K}_{p, n}=\frac{\left|\mathbb{S}^{n-2}\right|}{\left|\mathbb{S}^{n-1}\right|} \frac{\Gamma\left(\frac{n-1}{2}\right) \Gamma\left(\frac{p+1}{2}\right)}{\Gamma\left(\frac{n+p}{2}\right)}=\frac{\Gamma\left(\frac{n}{2}\right) \Gamma\left(\frac{1+p}{2}\right)}{\sqrt{\pi} \Gamma\left(\frac{n+p}{2}\right)}
$$

In view of of the computations of this section, Application D is then a direct application of Theorems A to C.

## 4. Existence and study of large mass minimizers

4.1. Existence and convergence as $\boldsymbol{m} \rightarrow \infty$. In order to prove existence of minimizers for large masses, we want to use the direct method in the calculus of variations, starting from a minimizing sequence. When $\gamma<1$, we will see that any minimizing sequence is bounded in $\operatorname{BV}\left(\mathbb{R}^{n}\right)$, but in order to get compactness in $L^{1}\left(\mathbb{R}^{n}\right)$ and pass to the limit, we need to show that no mass escapes at infinity. To do so, we will need to establish a few lemmas. First we show that for large masses, if the energy $\mathcal{F}_{\gamma, G_{\lambda}}$ of some set $E$, (where $\mathcal{F}_{\gamma, G_{\lambda}}$ is defined by (1.4)) is smaller than that of $B_{1}$, then $E$ is actually close to $B_{1}$.

Lemma 4.1. Assume that $\gamma<1$. Then for any set $E$ of finite perimeter with volume $\left|B_{1}\right|$ such that

$$
\mathcal{F}_{\gamma, G_{\lambda}}(E) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)
$$

we have

$$
\left|E \triangle B_{1}(x)\right| \leqslant C_{0} \eta(\lambda)
$$

for some $x \in \mathbb{R}^{n}$, where

$$
\begin{equation*}
\eta(\lambda):=\left(\left(P-\operatorname{Per}_{G_{\lambda}}\right)\left(B_{1}\right)\right)^{\frac{1}{2}} \tag{4.1}
\end{equation*}
$$

and $C_{0}=C_{0}(n, \gamma)$.
Remark 4.2. Notice that $\eta(\lambda)$ vanishes as $\lambda$ goes to infinity by Corollary 3.9.
Proof of Lemma 4.1. The inequality

$$
\mathcal{F}_{\gamma, G_{\lambda}}(E) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)
$$

rewrites

$$
P(E)-P\left(B_{1}\right) \leqslant \gamma\left(\operatorname{Per}_{G_{\lambda}}(E)-\operatorname{Per}_{G_{\lambda}}\left(B_{1}\right)\right)
$$

By Corollary 3.3, this implies

$$
\begin{aligned}
P(E)-P\left(B_{1}\right) & \leqslant \gamma\left(P(E)-\operatorname{Per}_{G_{\lambda}}\left(B_{1}\right)\right) \\
& =\gamma\left(P(E)-P\left(B_{1}\right)\right)+\gamma\left(P\left(B_{1}\right)-\operatorname{Per}_{G_{\lambda}}\left(B_{1}\right)\right)
\end{aligned}
$$

thus

$$
\begin{equation*}
P(E)-P\left(B_{1}\right) \leqslant \frac{\gamma}{1-\gamma}\left(\left(P-\operatorname{Per}_{G_{\lambda}}\right)\left(B_{1}\right)\right) \tag{4.2}
\end{equation*}
$$

By the quantitative isoperimetric inequality (2.2), we have $\alpha(E) \leqslant C \sqrt{P(E)-P\left(B_{1}\right)}$, where $C=$ $C(n)$. Hence there exists $x \in \mathbb{R}^{n}$ such that

$$
\left|E \triangle B_{1}(x)\right| \leqslant C_{0} \eta(\lambda)
$$

where we set

$$
\eta(\lambda):=\left(\left(P-\operatorname{Per}_{G_{\lambda}}\right)\left(B_{1}\right)\right)^{\frac{1}{2}}
$$

and $C_{0}=C_{0}(n, \gamma)$.
We also need a truncation lemma akin to [25, Lemma 29.12] or [12, Lemma 4.5] to quantify by how much the energy decreases after properly cutting a set which is already close to a ball.
Lemma 4.3 (Truncation). Assume $\gamma<1$. There exist $C_{1}, C_{2} \in(0,+\infty)$ depending only on $n$ and $\gamma$ such that the following holds. If $E$ is a set of finite perimeter satisfying $\left|E \backslash B_{r_{0}}\right| \leqslant \eta$, for some positive constants $\eta$ and $r_{0}$, then there exists $r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right]$ such that

$$
\begin{equation*}
\mathcal{F}_{\gamma, G_{\lambda}}\left(E \cap B_{r}\right) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)-\frac{\left|E \backslash B_{r}\right|^{1-\frac{1}{n}}}{C_{2}} \tag{4.3}
\end{equation*}
$$

Proof. Let $C_{1}, C_{2}>0$ to be fixed later, and $E$ be a set of finite perimeter such that $\left|E \backslash B_{r_{0}}\right| \leqslant \eta$. We define $u(r):=\left|E \backslash B_{r}\right|$, and for now we assume that $u\left(r_{0}+C_{1} \eta^{\frac{1}{n}}\right)>0$. Since $u$ is nonincreasing, we have $u(r)>0$, for all $r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right]$. Notice that $u$ is absolutely continuous, and $u^{\prime}(r)=$ $-\mathscr{H}^{n-1}\left(E \cap \partial B_{r}\right)$ for $\mathscr{L}^{1}$-almost every $r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right]$. By contradiction, let us assume that

$$
\begin{equation*}
P(E)-\gamma \operatorname{Per}_{G_{\lambda}}(E)<P\left(E \cap B_{r}\right)-\gamma \operatorname{Per}_{G_{\lambda}}\left(E \cap B_{r}\right)+\frac{\left|E \backslash B_{r}\right|^{1-\frac{1}{n}}}{C_{2}} \tag{4.4}
\end{equation*}
$$

for all $r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right]$. Recall that for almost every $r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right]$ we have $\mathscr{H}^{n-1}\left(\partial^{*} E \cap \partial B_{r}\right)=0$ (see e.g. [25, Proposition 2.16]). Given such an $r$, note that $P(E)=P\left(E ; B_{r}\right)+P\left(E ;{\overline{B_{r}}}^{\mathrm{c}}\right.$ ), and $P\left(E \cap B_{r}\right)=P\left(E ; B_{r}\right)+\mathscr{H}^{n-1}\left(E \cap \partial B_{r}\right)$ (see e.g. [25, Lemma 15.12]). Thus

$$
\begin{align*}
P(E)-P\left(E \cap B_{r}\right) & =P\left(E ;{\overline{B_{r}}}^{\mathrm{c}}\right)-\mathscr{H}^{n-1}\left(E \cap \partial B_{r}\right) \\
& =P\left(E \backslash B_{r}\right)-2 \mathscr{H}^{n-1}\left(E \cap \partial B_{r}\right)=P\left(E \backslash B_{r}\right)+2 u^{\prime}(r), \tag{4.5}
\end{align*}
$$

where we also used $P\left(E \backslash B_{r}\right)=P\left(E ;{\overline{B_{r}}}^{\mathrm{c}}\right)+\mathscr{H}^{n-1}\left(E \cap \partial B_{r}\right)$. On the other hand, noticing that

$$
\begin{aligned}
\operatorname{Per}_{G}(E)= & \iint_{\left(E \backslash B_{r}\right) \times E^{c}} G(x-y) \mathrm{d} x \mathrm{~d} y+\iint_{\left(E \cap B_{r}\right) \times E^{c}} G(x-y) \mathrm{d} x \mathrm{~d} y \\
= & \iint_{\left(E \backslash B_{r}\right) \times\left(E \backslash B_{r}\right)^{c}} G(x-y) \mathrm{d} x \mathrm{~d} y-\iint_{\left(E \backslash B_{r}\right) \times\left(E \cap B_{r}\right)} G(x-y) \mathrm{d} x \mathrm{~d} y \\
& +\iint_{\left(E \cap B_{r}\right) \times E^{c}} G(x-y) \mathrm{d} x \mathrm{~d} y \\
= & \operatorname{Per}_{G}\left(E \backslash B_{r}\right)-\iint_{\left(E \backslash B_{r}\right) \times\left(E \cap B_{r}\right)} G(x-y) \mathrm{d} x \mathrm{~d} y+\iint_{\left(E \cap B_{r}\right) \times E^{c}} G(x-y) \mathrm{d} x \mathrm{~d} y
\end{aligned}
$$

and

$$
\operatorname{Per}_{G}\left(E \cap B_{r}\right)=\iint_{\left(E \cap B_{r}\right) \times E^{c}} G(x-y) \mathrm{d} x \mathrm{~d} y+\iint_{\left(E \cap B_{r}\right) \times\left(E \backslash B_{r}\right)} G(x-y) \mathrm{d} x \mathrm{~d} y
$$

we find

$$
\begin{equation*}
\operatorname{Per}_{G}(E)-\operatorname{Per}_{G}\left(E \cap B_{r}\right)=\operatorname{Per}_{G}\left(E \backslash B_{r}\right)-2 \iint_{\left(E \cap B_{r}\right) \times\left(E \cap B_{r}^{\mathrm{c}}\right)} G(x-y) \mathrm{d} x \mathrm{~d} y \tag{4.6}
\end{equation*}
$$

Injecting (4.5) and (4.6) into (4.4), one gets

$$
\begin{align*}
P\left(E \backslash B_{r}\right)-\gamma \operatorname{Per}_{G}\left(E \backslash B_{r}\right) & <-2 u^{\prime}(r)-2 \gamma \iint_{\left(E \cap B_{r}\right) \times\left(E \cap B_{r}^{c}\right)} G(x-y) \mathrm{d} x \mathrm{~d} y+\frac{u(r)^{1-\frac{1}{n}}}{C_{2}}  \tag{4.7}\\
& \leqslant-2 u^{\prime}(r)+\frac{u(r)^{1-\frac{1}{n}}}{C_{2}},
\end{align*}
$$

for almost every $r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right]$. Note that by Corollary 3.3, we know that $\operatorname{Per}_{G}\left(E \backslash B_{r}\right) \leqslant P\left(E \backslash B_{r}\right)$, thus

$$
\begin{equation*}
(1-\gamma) P\left(E \backslash B_{r}\right)<-2 u^{\prime}(r)+\frac{u(r)^{1-\frac{1}{n}}}{C_{2}} \quad \text { for a.e. } r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right] \tag{4.8}
\end{equation*}
$$

Now by the isoperimetric inequality (2.2) we have

$$
\begin{equation*}
P\left(E \backslash B_{r}\right) \geqslant n \omega_{n}^{\frac{1}{n}} u(r)^{1-\frac{1}{n}}, \tag{4.9}
\end{equation*}
$$

hence from (4.8), it follows

$$
\left[n \omega_{n}^{\frac{1}{n}}(1-\gamma)-\frac{1}{C_{2}}\right] u(r)^{1-\frac{1}{n}}<-2 u^{\prime}(r)
$$

We can then choose $C_{2}$ large enough depending only on $\gamma$ and $n$ such that

$$
\begin{equation*}
C_{3} n u(r)^{\frac{n-1}{n}}<-u^{\prime}(r) \tag{4.10}
\end{equation*}
$$

for some positive $C_{3}=C_{3}(n, \gamma)$. Then (4.10) can be rewritten

$$
\left(u(r)^{\frac{1}{n}}\right)^{\prime}=\frac{1}{n} u^{\prime}(r) u(r)^{\frac{1}{n}-1}<-C_{3} \quad \text { for a.e. } r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right]
$$

so that integrating between $r_{0}$ and $r_{0}+C_{1} \eta^{\frac{1}{n}}$ yields

$$
u\left(r_{0}+C_{1} \eta^{\frac{1}{n}}\right)^{\frac{1}{n}} \leqslant u\left(r_{0}\right)^{\frac{1}{n}}-C_{3} C_{1} \eta^{\frac{1}{n}} \leqslant\left(1-C_{1} C_{3}\right) \eta^{\frac{1}{n}} .
$$

Choosing $C_{1}$ large enough, depending only on $n$ and $\gamma$, we get $u\left(r_{0}+C_{1} \eta^{\frac{1}{n}}\right)^{\frac{1}{n}}<0$, which is a contradiction. Recall that we assumed $u\left(r_{0}+C_{1} \eta^{\frac{1}{n}}\right)>0$, so there are two cases: for this $C_{1}$ large enough, either $u\left(r_{0}+C_{1} \eta^{\frac{1}{n}}\right)>0$, and then as we have seen there exists $r \in\left[r_{0}, r_{0}+C_{1} \eta^{\frac{1}{n}}\right]$ such that (4.3) holds for some $C_{2}=C_{2}(n, \gamma)$, or $u\left(r_{0}+C_{1} \eta^{\frac{1}{n}}\right)=0$, and then (4.3) holds for any $C_{2}$ with $r=r_{0}+C_{1} \eta^{\frac{1}{n}}$. In any case, (4.3) holds.

We can also prove the following counterpart of the truncation lemma when taking the union with a ball.
Lemma 4.4 (Union with a ball). Assume $\gamma<1$. There exist $C_{1}, C_{2} \in(0,+\infty)$ depending only on $n$ and $\gamma$ such that the following holds. If $E$ is a set of finite perimeter satisfying $\left|B_{r_{0}} \backslash E\right| \leqslant \eta$, for some positive constants $\eta$ and $r_{0}$, then there exists $r \in\left[r_{0}-C_{1} \eta^{\frac{1}{n}}, r_{0}\right]$ such that

$$
\mathcal{F}_{\gamma, G_{\lambda}}\left(E \cup B_{r}\right) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)-\frac{\left|B_{r} \backslash E\right|^{1-\frac{1}{n}}}{C_{2}}
$$

Proof. The proof is almost identical to the one of the truncation lemma, by considering the quantity $u(r):=\left|B_{r} \backslash E\right|$, and so is left to the reader.

We are now able to prove the existence of large mass minimizers. We would like to kindly thank F. GÉnÉrau for pointing out that the proof of Theorem 4.5 actually shows that any minimizer $E$ lies between two balls close to the unit ball.
Theorem 4.5. Assume $\gamma<1$. Then there exists $\lambda_{e}=\lambda_{e}(n, \gamma, G)$ such that, for any $\lambda>\lambda_{e},\left(\mathrm{P}_{\gamma, \lambda}\right)$ admits a minimizer. In addition, up to a translation and up to a Lebesgue negligible set, any minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ with $\lambda>\lambda_{e}$ satisfies

$$
\begin{equation*}
\bar{B}_{1-C \eta(\lambda)^{\frac{1}{n}}} \subseteq E \subseteq B_{1+C \eta(\lambda)^{\frac{1}{n}}} \tag{4.11}
\end{equation*}
$$

where $C=C(n, \gamma)$ and $\eta(\lambda)$ is given by (4.1) and vanishes as $\lambda$ goes to infinity by Corollary 3.9.
Proof. In this proof, $C$ denotes a constant depending only on $n$ and $\gamma$, possibly changing from line to line. We proceed in three steps.
Step 1. Let us show that there exists $\lambda_{e}>0$ depending only on $n, \gamma$ and $G$ such that the following holds. For any set of finite perimeter $E$ of mass $\left|B_{1}\right|$ satisfying $\mathcal{F}_{\gamma, G_{\lambda}}(E) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)$, up to a translation, there exists a set of finite perimeter $\widetilde{E}$ of same mass such that

$$
\begin{equation*}
\mathcal{F}_{\gamma, G_{\lambda}}(\widetilde{E}) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)-\left|E \backslash B_{1+C \eta(\lambda)^{\frac{1}{n}}}\right| \quad \text { and } \quad \widetilde{E} \subseteq B_{1+C \eta(\lambda)^{\frac{1}{n}}} \tag{4.12}
\end{equation*}
$$

Let $\lambda_{e}>0$ to be fixed later. By Lemma 4.1, if $E$ satisfies $\mathcal{F}_{\gamma, G_{\lambda}}(E) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)$, then up to translating $E$, we have

$$
\left|E \triangle B_{1}\right| \leqslant C_{0} \eta(\lambda)
$$

where $C_{0}=C_{0}(n, \gamma)$. Using Lemma 4.3 with $C_{0} \eta(\lambda)$ in place of $\eta$, we can find $r \leqslant 1+C_{1} C_{0}^{\frac{1}{n}} \eta(\lambda)^{\frac{1}{n}}$ such that

$$
\begin{equation*}
\mathcal{F}_{\gamma, G_{\lambda}}\left(E \cap B_{r}\right) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)-\frac{u^{1-\frac{1}{n}}}{C_{2}} \tag{4.13}
\end{equation*}
$$

where $C_{2}$ depends only on $n$ and $\gamma$, and where we have set $u:=\left|E \backslash B_{r}\right|$. If $u=0$, then $E \subseteq B_{r} \subseteq$ $B_{1+C_{1} C_{0}^{\frac{1}{n}} \eta^{\frac{1}{n}}}$ (up to a Lebesgue negligible set) and (4.12) holds with $C=C_{1} C_{0}^{\frac{1}{n}}$ and $\widetilde{E}=E$, so we may now assume that $u>0$. To compensate for the loss of some mass, we define the rescaled set $\widetilde{E}:=\mu\left(E \cap B_{r}\right)$, where $\mu:=(1-u)^{-\frac{1}{n}}$, so that $|\widetilde{E}|=\left|B_{1}\right|$. Then since $\mu \geqslant 1$, by Lemma 3.6, we have

$$
\begin{equation*}
\mathcal{F}_{\gamma, G_{\lambda}}(\widetilde{E})-\mathcal{F}_{\gamma, G_{\lambda}}\left(E \cap B_{r}\right) \leqslant\left(\mu^{n}-1\right) \mathcal{F}_{\gamma, G_{\lambda}}\left(E \cap B_{r}\right) \leqslant u \mathcal{F}_{\gamma, G_{\lambda}}\left(E \cap B_{r}\right) \tag{4.14}
\end{equation*}
$$

provided $\lambda_{e}$ is large enough (depending only on $n$ and $G$ ), since $u \leqslant C_{0} \eta(\lambda)$ and thus vanishes as $\lambda$ goes to infinity. Injecting (4.13) into (4.14) and using that $u>0$, one gets

$$
\begin{align*}
\mathcal{F}_{\gamma, G_{\lambda}}(\widetilde{E}) & \leqslant(1+u)\left(\mathcal{F}_{\gamma, G_{\lambda}}(E)-\frac{u^{1-\frac{1}{n}}}{C_{2}}\right)  \tag{4.15}\\
& \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)+u\left(\mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)-\frac{1}{C_{2} u^{\frac{1}{n}}}\right) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)+u\left(P\left(B_{1}\right)-\frac{1}{C_{2} u^{\frac{1}{n}}}\right) .
\end{align*}
$$

Since $u \leqslant C_{0} \eta(\lambda)$ vanishes uniformly as $\lambda$ goes to infinity, this gives

$$
\mathcal{F}_{\gamma, G_{\lambda}}(\widetilde{E}) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)-u \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)-\left|E \backslash B_{1+C \eta(\lambda)^{\frac{1}{n}}}\right|
$$

provided $\lambda_{e}$ is chosen large enough depending only on $n, \gamma$ and $G$. Recall that $\widetilde{E} \subseteq B_{\mu r}$, and notice that,

$$
\mu r=\frac{r}{(1-u)^{\frac{1}{n}}} \leqslant r(1+C u) \leqslant\left(1+C \eta(\lambda)^{\frac{1}{n}}\right)\left(1+C_{0} \eta(\lambda)\right) \leqslant 1+C \eta(\lambda)^{\frac{1}{n}}
$$

whenever $\lambda_{e}$ is large enough, thus $\widetilde{E} \subseteq B_{1+C \eta(\lambda)^{\frac{1}{n}}}$, which concludes this step.
Step 2. We prove existence of minimizers. For $\lambda \geqslant \lambda_{e}$, consider a minimizing sequence $\left(E_{k}\right)_{k \in \mathbb{N}}$ for $\left(\mathrm{P}_{\gamma, \lambda}\right)$. There are two cases: either $B_{1}$ is a minimizer of $\mathcal{F}_{\gamma, G_{\lambda}}$, and we are done, or $B_{1}$ is not a minimizer of $\mathcal{F}_{\gamma, G_{\lambda}}$, and up to a subsequence (not relabeled), for all $k \in \mathbb{N}$, we have $\mathcal{F}_{\gamma, G_{\lambda}}\left(E_{k}\right) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)$. In the latter case, by Step 1 we can build another minimizing sequence $\left(\widetilde{E}_{k}\right)_{k \in \mathbb{N}}$ of sets included in $B_{1+C \eta(\lambda)^{\frac{1}{n}}}$ such that $\mathcal{F}_{\gamma, G_{\lambda}}\left(\widetilde{E}_{k}\right) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}\left(E_{k}\right)$, for all $k \in \mathbb{N}$. Now $\left(\mathbf{1}_{\widetilde{E}_{k}}\right)_{k \in \mathbb{N}}$ is also bounded in $\operatorname{BV}\left(\mathbb{R}^{n}\right)$. Indeed $\mathcal{F}_{\gamma, G_{\lambda}}\left(\widetilde{E}_{k}\right) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)$ implies

$$
P\left(\widetilde{E}_{k}\right) \leqslant(1-\gamma)^{-1} P\left(B_{1}\right),
$$

thus $\left[\mathbf{1}_{\widetilde{E}_{k}}\right]_{\mathrm{BV}\left(\mathbb{R}^{n}\right)}$ is bounded, and $\left\|\mathbf{1}_{\widetilde{E}_{k}}\right\|_{L^{1}\left(\mathbb{R}^{n}\right)}=\left|B_{1}\right|$. By compactness of $\mathrm{BV}\left(\mathbb{R}^{n}\right)$ in $L_{\text {loc }}^{1}\left(\mathbb{R}^{n}\right)$ and the fact that $\widetilde{E}_{k} \subseteq B_{1+C \eta(\lambda)^{\frac{1}{n}}}$ after translation, up to the extraction of a subsequence (still not relabeled), $\mathbf{1}_{\widetilde{E}_{k}}$ converges to some function $f \in \operatorname{BV}\left(\mathbb{R}^{n}\right)$ in $L^{1}\left(\mathbb{R}^{n}\right)$ and almost everywhere. The almost everywhere convergence implies that $f$ is the indicator function of some set of finite perimeter $E$, and the $L^{1}$ convergence ensures $|E|=\left|B_{1}\right|$. Now by lower semicontinuity of the perimeter w.r.t. the $L^{1}$ convergence, we have $P(E) \leqslant \liminf _{k} P\left(\widetilde{E}_{k}\right)$, and by continuity of the nonlocal perimeter in $L^{1}\left(\mathbb{R}^{n}\right)$ shown in Lemma 3.4, it follows that $\operatorname{Per}_{G_{\lambda}}\left(\widetilde{E}_{k}\right)$ converges to $\operatorname{Per}_{G_{\lambda}}(E)$ as $k$ goes to infinity. Hence $\mathcal{F}_{\gamma, G_{\lambda}}(E) \leqslant \liminf _{k} \mathcal{F}_{\gamma, G_{\lambda}}\left(\widetilde{E}_{k}\right)$, which shows that $E$ is a minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$, since $\widetilde{E}_{k}$ is a minimizing sequence.
Step 3. There remains to check that, for $\lambda_{e}$ large, for any $\lambda \geqslant \lambda_{e}$, any minimizer of ( $\mathrm{P}_{\gamma, \lambda}$ ) satisfies (4.11), up to a translation and up to a Lebesgue negligible set. Consider $E$ such a minimizer, then by minimality, we have $\mathcal{F}_{\gamma, G_{\lambda}}(E) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)$, thus applying Step 1 there exists a set of finite perimeter $\widetilde{E}$ with mass $\left|B_{1}\right|$ such that

$$
\mathcal{F}_{\gamma, G_{\lambda}}(\widetilde{E}) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)-\left|E \backslash B_{1+C \eta(\lambda)^{\frac{1}{n}}}\right| .
$$

By minimality of $E$, necessarily $\left|E \backslash B_{1+C \eta(\lambda)^{\frac{1}{n}}}\right|=0$, which shows the upper inclusion of (4.11). For the other inclusion, one can show, proceeding almost exactly as in Step 1 but using Lemma 4.4 instead of the truncation lemma and the fact that $\mathcal{F}_{\gamma, G_{\lambda}}$ decreases by downscaling, that if $E$ is a minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$, then there exists a set of finite perimeter $\widetilde{E}$ with mass $\left|B_{1}\right|$ such that

$$
\mathcal{F}_{\gamma, G_{\lambda}}(\widetilde{E}) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E)-\left|B_{1-C \eta(\lambda)^{\frac{1}{n}}} \backslash E\right|,
$$

which implies $\left|B_{1-C \eta(\lambda)^{\frac{1}{n}}} \backslash E\right|=0$. Note that in Step 1 we have possibly translated $E$ to get the upper inclusion, but in fact we can use the same translation for both: indeed, Lemma 4.1 ensures that there exists $y \in \mathbb{R}^{n}$ such that

$$
\left|E \backslash B_{1}(y)\right|+\left|B_{1}(y) \backslash E\right| \leqslant C_{0} \eta(\eta) .
$$

This concludes the proof.
An immediate consequence of Theorem 4.5 is the convergence of minimizers to the unit ball and of their boundaries to the unit sphere as $\lambda$ goes to infinity.

Corollary 4.6 (Convergence). Assume $\gamma<1$. Then for any $\lambda>\lambda_{e}$ given by Theorem 4.5, any minimizer $F$ of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ satisfies, up to a translation,

$$
\mathrm{d}_{\mathscr{H}}\left(E, B_{1}\right)+\mathrm{d}_{\mathscr{H}}\left(\partial E, \partial B_{1}\right) \leqslant C \eta(\lambda)^{\frac{1}{n}},
$$

where $\mathrm{d}_{\mathscr{H}}$ denotes the Hausdorff distance, $C$ is a constant depending only on $n$ and $\gamma$, and $\eta(\lambda)$ is given by (4.1).
4.2. Indecomposability of minimizers. The aim of this section is to prove connectedness of minimizers of ( $\mathrm{P}_{\gamma, \lambda}$ ) when $\gamma<1$ and $\lambda$ is large enough, or in any case when the kernel $G$ is not compactly supported. Since any minimizer is always defined up to a set of vanishing Lebesgue measure, and we do not know yet if there is a precise (partially) regular representative, we work here with a measure theoretic notion of connectedness for sets of finite perimeter (see e.g. [1]), which is referred to as indecomposability.

Definition 4.7. We say that a set of finite perimeter $E$ is decomposable if there exist two sets of finite perimeter $E_{1}$ and $E_{2}$ such that $E=E_{1} \sqcup E_{2},\left|E_{1}\right|>0,\left|E_{2}\right|>0$ and $P(E)=P\left(E_{1}\right)+P\left(E_{2}\right)$. Naturally, we say that a set of finite perimeter is indecomposable if it is not decomposable.

As with the usual topological notion of connectedness, it is possible to partition a set of finite perimeter $E$ into indecomposable sets (see [1, Theorem 1]) in a unique way (up to sets of vanishing Lebesgue measure). We call the sets composing this partition the $\mathcal{M}$-connected components of $E$. We have the following result establishing a link between the $\mathcal{M}$-connected components of a set of finite perimeter and the topological connected components.
Theorem 4.8 ([1, Theorem 2]). If $E$ is an open set of finite perimeter such that $\mathscr{H}^{n-1}(\partial E)=$ $\mathscr{H}^{n-1}\left(\partial^{*} E\right)$, then the $\mathcal{M}$-connected components of $E$ coincide with their topological connected components.

We can show that if $G$ is not compacly supported, then any minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ (if one exists, no matter the value of $\gamma$ or $\lambda$ ) is indecomposable.

Proposition 4.9. If $G$ is not compactly supported, then any minimizer $E$ of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ which is included in a ball $B_{R}$, for some $R>0$, is indecomposable.

Remark 4.10. In fact, the restriction that $E$ is included in a ball can be dropped, since any minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ (if one exists) is in fact included in a ball, as is pointed out later in the proof of Theorem 4.16.
Proof of Proposition 4.9. We proceed by contradiction. Assume that there exists a minimizer $E \subseteq B_{R}$ and two sets of finite $E_{1}$ and $E_{2}$ such that $E=E_{1} \sqcup E_{2},\left|E_{1}\right|>0,\left|E_{2}\right|>0$ and $P(E)=P\left(E_{1}\right)+P\left(E_{2}\right)$. Here we prefer to work with the equivalent formulation $(\star)$ of the minimization problem, and show that $E$ cannot be a minimizer of $P+\gamma \mathcal{V}_{G_{\lambda}}$ under the volume constraint $|E|=\left|B_{1}\right|$, where $\mathcal{V}_{G_{\lambda}}$ is the functional defined by

$$
\mathcal{V}_{G_{\lambda}}(E):=\iint_{E \times E} G_{\lambda}(x-y) \mathrm{d} x \mathrm{~d} y
$$

for every measurable set $E$. Note that we have the decomposition

$$
P(E)+\gamma \mathcal{V}_{G_{\lambda}}(E)=P\left(E_{1}\right)+P\left(E_{2}\right)+\gamma \mathcal{V}_{G_{\lambda}}\left(E_{1}\right)+\gamma \mathcal{V}_{G_{\lambda}}\left(E_{2}\right)+2 \gamma \iint_{E_{1} \times E_{2}} G_{\lambda}(x-y) \mathrm{d} x \mathrm{~d} y
$$

Let $h \in \mathbb{R}^{n}$ such that $|h|>2 R$. Since $E_{1}$ and $E_{2}$ are included in $B_{R}$, then for any $(x, y) \in E_{1} \times\left(E_{2}+h\right)$ we have $|x-y| \geqslant|h|-2 R>0$. Obviously $P\left(E_{2}\right)=P\left(E_{2}+h\right)$ and $\mathcal{V}_{G_{\lambda}}\left(E_{2}\right)=\mathcal{V}_{G_{\lambda}}\left(E_{2}+h\right)$ by a change of variables. Now let us define the competitor $E_{h}:=E_{1} \sqcup\left(E_{2}+h\right)$, which satisfies $\left|E_{h}\right|=\left|E_{1}\right|+\left|E_{2}\right|=|E|$. Since $|x-y|>2 R$ whenever $(x, y) \in E_{1} \times\left(E_{2}+h\right)$, we have $P\left(E_{h}\right)=P\left(E_{1}\right)+P\left(E_{2}+h\right)$, thus we compute

$$
\begin{align*}
& P\left(E_{h}\right)+\gamma \mathcal{V}_{G_{\lambda}}\left(E_{h}\right) \\
& \quad=P\left(E_{1}\right)+P\left(E_{2}\right)+\gamma \mathcal{V}_{G_{\lambda}}\left(E_{1}\right)+\gamma \mathcal{V}_{G_{\lambda}}\left(E_{2}\right)+2 \gamma \iint_{E_{1} \times\left(E_{2}+h\right)} G_{\lambda}(x-y) \mathrm{d} x \mathrm{~d} y  \tag{4.16}\\
& \quad=P(E)+\gamma \mathcal{V}_{G_{\lambda}}(E)+2 \gamma \iint_{E_{1} \times\left(E_{2}+h\right)} G_{\lambda}(x-y) \mathrm{d} x \mathrm{~d} y-2 \gamma \iint_{E_{1} \times E_{2}} G_{\lambda}(x-y) \mathrm{d} x \mathrm{~d} y
\end{align*}
$$

where we used the fact that $P(E)=P\left(E_{1}\right)+P\left(E_{2}\right)$ for the last equality. On the one hand, by a change of variables, we have

$$
\begin{equation*}
\iint_{E_{1} \times\left(E_{2}+h\right)} G_{\lambda}(x-y) \mathrm{d} x \mathrm{~d} y \leqslant\left|E_{1}\right| \int_{B_{2|h|-R}} G_{\lambda}(y) \mathrm{d} y \xrightarrow{|h| \rightarrow \infty} 0 \tag{4.17}
\end{equation*}
$$

since $G \in L^{1}\left(\mathbb{R}^{n}\right)$. On the other hand, since $G$ is radial and not compactly supported, we have

$$
\int_{A} G_{\lambda}(x) \mathrm{d} x>0
$$

for any measurable set $A$ such that $|A|>0$. In particular

$$
\begin{equation*}
\iint_{E_{1} \times E_{2}} G_{\lambda}(x-y) \mathrm{d} x \mathrm{~d} y=\int_{E_{1}}\left(\int_{x-E_{2}} G_{\lambda}(y) \mathrm{d} y\right) \mathrm{d} x>0 \tag{4.18}
\end{equation*}
$$

since $\left|E_{1}\right|>0$ and $\left|E_{2}\right|>0$. Thus by (4.16) to (4.18), for any $|h|$ large enough we have

$$
P\left(E_{h}\right)+\gamma \mathcal{V}_{G_{\lambda}}\left(E_{h}\right)<P(E)+\gamma \mathcal{V}_{G_{\lambda}}(E)
$$

which contradicts the minimality of $E$.
Now, even if $G$ is compactly supported, we know that when $\gamma<1$ and $\lambda$ is large enough, any minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ lies between two balls which are very close to the unit ball, which implies that it is indecomposable.
Proposition 4.11. Assume $\gamma<1$. Then any minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ with $\lambda>\lambda_{e}$ is indecomposable, where $\lambda_{e}$ is given by Theorem 4.5.

Proof. The proof is trivial. Let $E$ be a minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ with $\lambda>\lambda_{e}$, and assume that it can be written $E=E_{1} \sqcup E_{2}$ with $\left|E_{1}\right|>0,\left|E_{2}\right|>0$, and $P(E)=P\left(E_{1}\right)+P\left(E_{2}\right)$. Since $P(E)=P\left(E_{2}\right)+P\left(E_{2}\right)$ we may translate $E_{2}$ without changing the perimeter. Hence, translating it far and outside the ball $B_{1+C \eta(\lambda)^{\frac{1}{n}}}$ by some vector $h \in \mathbb{R}^{n}$, we have

$$
\mathcal{F}_{\gamma, G_{\lambda}}\left(E_{1} \sqcup\left(h+E_{2}\right)\right) \leqslant \mathcal{F}_{\gamma, G_{\lambda}}(E),
$$

so that $E_{1} \sqcup\left(h+E_{2}\right)$ is still a minimizer but outside any ball $B_{1+C \eta(\lambda)^{\frac{1}{n}}}(y), y \in \mathbb{R}^{n}$, which contradicts Theorem 4.5.
4.3. $\Gamma$-convergence to the classical perimeter. Using the results from Section 3.1, we can easily compute the $\Gamma$-limit of the functionals of the rescaled problems $\left(\mathrm{P}_{\gamma, \lambda}\right)$. In view of (3.10), for any $\lambda \in(0,+\infty)$, let us define on $L^{1}\left(\mathbb{R}^{n}\right)$ the functional

$$
\mathcal{E}_{\gamma, G_{\lambda}}(f):=\left\{\begin{array}{l}
\int_{\mathbb{R}^{n}}|D f|-\gamma \iint_{\mathbb{R}^{n} \times \mathbb{R}^{n}} \frac{|f(x)-f(y)|}{|x-y|} \rho_{G, 1 / \lambda}(x-y)  \tag{4.19}\\
\quad \text { if there exists a set of finite perimeter } E \text { s.t. } f=\mathbf{1}_{E} \text { and }|E|=\left|B_{1}\right|, \\
+\infty \quad \text { otherwise, }
\end{array}\right.
$$

which is well defined and finite whenever $f=\mathbf{1}_{E}$ for some set of perimeter $E$ such that $|E|=\left|B_{1}\right|$ by Proposition 3.1. It is obviously defined so that it "coincides" with $\mathcal{F}_{\gamma, G_{\lambda}}$ on sets of finite perimeter, in the sense that $\mathcal{E}_{\gamma, G_{\lambda}}\left(\mathbf{1}_{E}\right)=\mathcal{F}_{\gamma, G_{\lambda}}(E)$ for every set of finite perimeter $E$ with volume $\left|B_{1}\right|$, and so that minimizers of $\mathcal{E}_{\gamma, G_{\lambda}}$ are precisely those functions which are indicator functions of sets of finite perimeter solving $\left(\mathrm{P}_{\gamma, \lambda}\right)$.
Theorem 4.12. If $\gamma<1$, then the functionals $\mathcal{E}_{\gamma, G_{\lambda}}$ defined by (4.19) $\Gamma$-converge in $L^{1}$ to the functional

$$
\mathcal{E}_{\gamma, \infty}(f):= \begin{cases}(1-\gamma) \int_{\mathbb{R}^{n}}|D f| \\ & \text { if there exists a set of finite perimeter } E \text { s.t. } f=\mathbf{1}_{E} \text { and }|E|=\left|B_{1}\right|, \\ +\infty & \text { otherwise },\end{cases}
$$

as $\lambda$ goes to infinity.
Proof. We shall check, in that order, that

$$
\Gamma-\limsup \mathcal{E}_{\gamma, G_{\lambda}}(f) \leqslant \mathcal{E}_{\gamma, \infty}(f), \quad \text { and } \quad \mathcal{E}_{\gamma, \infty}(f) \leqslant \Gamma-\liminf \mathcal{E}_{\gamma, G_{\lambda}}(f)
$$

where

$$
\Gamma-\lim \sup \mathcal{E}_{\gamma, G_{\lambda}}(f):=\min \left\{\underset{k}{\lim \sup } \mathcal{E}_{\gamma, G_{\lambda_{k}}}\left(f_{k}\right): f_{k} \xrightarrow{L^{1}\left(\mathbb{R}^{n}\right)} f\right\} .
$$

and

$$
\Gamma-\lim \inf \mathcal{E}_{\gamma, G_{\lambda}}(f):=\min \left\{\underset{k}{\lim \inf } \mathcal{E}_{\gamma, G_{\lambda_{k}}}\left(f_{k}\right): f_{k} \xrightarrow{L^{1}\left(\mathbb{R}^{n}\right)} f\right\}
$$

Step 1. Let $f \in L^{1}\left(\mathbb{R}^{n}\right)$. If $f$ is not the indicator function of a set of finite perimeter of volume $\left|B_{1}\right|$, $\mathcal{E}_{\gamma, \infty}(f)=+\infty$ so the inequality is trivial. Let us assume $f=\mathbf{1}_{F}$ for some set of finite perimeter $F$ such that $|F|=\left|B_{1}\right|$, and consider the constant sequence $f_{k} \equiv \mathbf{1}_{F}$. Then by Proposition 3.8 we have

$$
\mathcal{E}_{\gamma, G_{\lambda_{k}}}\left(\mathbf{1}_{F}\right) \xrightarrow{k \rightarrow \infty} \mathcal{E}_{\gamma, \infty}\left(\mathbf{1}_{F}\right),
$$

thus $\Gamma-\lim \sup \mathcal{E}_{\gamma, G_{\lambda}}(f) \leqslant \mathcal{E}_{\gamma, \infty}(f)$.
Step 2. Given $f \in L^{1}\left(\mathbb{R}^{n}\right)$, consider a sequence $f_{k} \in L^{1}\left(\mathbb{R}^{n}\right)$ such that $f_{k} \xrightarrow{L^{1}\left(\mathbb{R}^{n}\right)} f$.
If $f$ is not given by the indicator function of a measurable set $F$, we claim that there exists $k_{0} \in \mathbb{N}$ such
that for any $k \geqslant k_{0}, f_{k}$ is also not an indicator function. By contradiction, let us assume that there exists a subsequence $\left(f_{n_{k}}\right)_{k \in \mathbb{N}}$ such that for every $n_{k}, f_{n_{k}}$ is the indicator function of a set $F_{n_{k}}$. By $L^{1}$ convergence, up to a further subsequence (not relabeled), we may assume that $f_{n_{k}}=\mathbf{1}_{F_{n_{k}}}$ converges almost everywhere to $f$. But then, for almost every $x \in \mathbb{R}^{n}, f(x)=\lim _{k \rightarrow \infty} \mathbf{1}_{F_{n_{k}}}(x) \in\{0,1\}$, so that $f$ is an indicator function, which is a contradiction. Thus for any $k \geqslant k_{0}, f_{n_{k}}$ is not an indicator function, hence $\mathcal{E}_{\gamma, G_{\lambda_{k}}\left(f_{k}\right)}=+\infty$, and we indeed have

$$
\begin{equation*}
+\infty=\liminf _{k \rightarrow \infty} \mathcal{E}_{\gamma, G_{\lambda_{k}}}\left(f_{k}\right) \geqslant \mathcal{E}_{\gamma, \infty}(f)=+\infty \tag{4.20}
\end{equation*}
$$

Now we assume that $f=\mathbf{1}_{F}$ for some measurable set $F$. If $|F| \neq\left|B_{1}\right|$, then by $L^{1}$ convergence there exists $k_{0}$ such that for all $k \geqslant k_{0}, \int_{\mathbb{R}^{n}} f(x) \mathrm{d} x \neq\left|B_{1}\right|$, thus $\mathcal{E}_{\gamma, G_{\lambda_{k}}}\left(f_{k}\right)=+\infty$ and (4.20) holds as well. Hence we may now assume that $|F|=\left|B_{1}\right|$. By Proposition 3.1, we have

$$
\mathcal{E}_{\gamma, G_{\lambda_{k}}}\left(f_{k}\right) \geqslant(1-\gamma) \int_{\mathbb{R}^{n}}\left|D f_{k}\right|
$$

which trivially holds even if $f_{k} \notin \mathrm{BV}\left(\mathbb{R}^{n}\right)$ or $\int_{\mathbb{R}^{n}} f_{k}(x) \mathrm{d} x \neq\left|B_{1}\right|$. Since the BV seminorm is lower semicontinuous with respect to the usual $L^{1}$ topology, and $(1-\gamma)>0$, we find

$$
\liminf _{k} \mathcal{E}_{\gamma, G_{\lambda_{k}}}\left(f_{k}\right) \geqslant(1-\gamma) \int_{\mathbb{R}^{n}}|D f|=\mathcal{E}_{\gamma, \infty}(f)
$$

where we used the fact that $\int_{\mathbb{R}^{n}} f(x) \mathrm{d} x=|F|=\left|B_{1}\right|$ for the last equality. Putting these cases together, we get that $\mathcal{E}_{\gamma, \infty}(f) \leqslant \Gamma-\lim \inf \mathcal{E}_{\gamma, G_{\lambda}}(f)$.

As usual, the $\Gamma$-convergence implies that any converging sequence of minimizers of ( $\mathrm{P}_{\gamma, \lambda_{k}}$ ), associated with positive numbers $\lambda_{k}$ going to infinity, necessarily converges in $L^{1}$ to a minimizer of the perimeter, hence to the unit ball; however, we already knew this by Corollary 4.6.
4.4. Regularity of minimizers. We address here the question of regularity of minimizers of $\left(\mathrm{P}_{\gamma, \lambda}\right)$. Applying the extensive regularity theory of volume-constrained quasi-minimizers for the perimeter developed in [27], we readily obtain $C^{1, \frac{1}{2}}$-regularity of the boundary of any minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ up to a singular set of Hausdorff dimension at most $(n-8)$ (the singular set being empty for $n \leqslant 7$ ).

Since sets of finite perimeter are defined up to a Lebesgue negligible set, we shall specify which sense we are giving to the boundary. Here we are not referring to the reduced boundary of $E$ (which in fact does not have singular points if $E$ is a minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$, as we will see), but rather to the support of the Gauss-Green measure of $E$, which is given by

$$
\operatorname{spt} \mu_{E}=\left\{x \in \mathbb{R}^{n}: 0<\left|E \cap B_{r}(x)\right|<\left|B_{r}(x)\right|, \forall r>0\right\}
$$

It is known (see e.g. [25, Proposition 12.19]) that for any set of finite perimeter $E$, there exists $E_{0}$ an equivalent representative of $E$ (that is, $\left|E \triangle E_{0}\right|=0$ ) such that the topological boundary of $E_{0}$ agrees with spt $\mu_{E}=\operatorname{spt} \mu_{E_{0}}$. Some authors simply denote spt $\mu_{E}$ by $\partial E$, but we refrain from doing so here.

In [27], S. Rigot studied regularity of volume-constrained quasi-minimizers of the perimeter (defined just below), and as an application obtained regularity results for minimizers of ( $\mathrm{P}_{\gamma, \lambda}$ ) (using the original equivalent formulation $(\star)$ ).
Definition 4.13 (Volume-constrained quasi-minimizers). Let $f:[0,+\infty) \rightarrow[0,+\infty)$ be such that $f(r)=o\left(r^{\frac{n-1}{n}}\right)$ near 0 . We say that a set of finite perimeter $E$ of volume $m$ is a quasi-minimizer of the perimeter w.r.t. $f$ under the volume constraint $m$ if for every ball $B_{r}(x) \subseteq \mathbb{R}^{n}$ and every set of finite perimeter $F$ of volume $m$ such that $E \triangle F \subset \subset B_{r}(x)$, we have

$$
P\left(E ; B_{r}(x)\right) \leqslant P\left(F ; B_{r}(x)\right)+f(|E \triangle F|) .
$$

While in [27] the kernel $G$ is assumed to be compactly supported, this assumption is only used to get existence of a minimizer, and the regularity results rely only on the integrability of the kernel on $\mathbb{R}^{n}$ (not even on the fact that it is radial). Let us now recall just a few of those results. By [27, Lemma 5.2.1], any minimizer of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ is a volume-constrained almost-minimizer of the perimeter w.r.t. $f(r)=\lambda \gamma I_{G}^{0} r$. It is also a direct consequence of Lemma 3.4. Indeed, we see that if a set $E$ solves $\left(\mathrm{P}_{\gamma, \lambda}\right)$, then for any set of finite perimeter $F$ such that $|F|=\left|B_{1}\right|$, we have

$$
P(E) \leqslant P(F)+\gamma\left(\operatorname{Per}_{G_{\lambda}}(E)-\operatorname{Per}_{G_{\lambda}}(F)\right) \leqslant P(F)+\gamma I_{G_{\lambda}}^{0}|E \triangle F|=P(F)+\lambda \gamma I_{G}^{0}|E \triangle F|
$$

It is then proven in [27, Proposition 4.3.1] that the volume constraint can be dropped in the quasiminimality condition, and that any volume-constrained quasi-minimizer of the perimeter is a local quasi-minimizer of the perimeter, without a volume constraint.

Proposition 4.14 ([27, Proposition 4.3.1]). If $f(r)=C_{1} r^{p}$ for some $p>\frac{n-1}{n}$, and $E$ is a volumeconstrained quasi-minimizer of the perimeter of volume $m$ w.r.t. $f$, then there exist $r_{0}=r_{0}\left(n, C_{1}, p, m\right)$ and $C_{2}=C_{2}\left(n, C_{1}, p, m\right)$ such that the following holds. For every ball $B_{r}(x) \subseteq \mathbb{R}^{n}$ such that $r \in\left(0, r_{0}\right)$ and every set of finite perimeter $F$ satisfying $E \triangle F \subset \subset B_{r}(x)$, we have

$$
P\left(E ; B_{r}(x)\right) \leqslant(1+\omega(r)) P\left(F ; B_{r}(x)\right),
$$

where $\omega(r):=C_{2} r^{2 \alpha}$ and $\alpha:=\min \left(\frac{n p-(n-1)}{2}, \frac{1}{2}\right)$.
Remark 4.15. We could also apply directly results from [32] to get rid of the volume constraint. However, the approach differs from the one in [27] and does not give any control on the radius $r_{0}$ of quasi-minimality, which may depend on the minimizer $E$ considered.

From this are deduced partial $C^{1, \alpha}$-regularity results when $n \geqslant 8$ and $C^{1, \alpha^{\prime}}$-regularity everywhere when $n \leqslant 7$ (see [27, Theorems 1.4.8 \& 1.4.9], which are consequences of [28, Theorems $2.6 \& 6.4]$; see also [2, Theorems $4.7 \& 4.10]$ ), with regularity constants depending only on $n, m$ and $f$. In our case, $p=1$, and we obtain $C^{1, \frac{1}{2}}$-regularity. Let us sum up some of the regularity results we obtain in the end for minimizers of $\left(\mathrm{P}_{\gamma, \lambda}\right)$ in the following theorem.
Theorem 4.16. Let $E$ be a minimizer ${ }^{1}$ of $\left(\mathrm{P}_{\gamma, \lambda}\right)$. Then $\partial^{*} E$ is locally a $(n-1)$-dimensional graph of class $C^{1, \frac{1}{2}}$, with $C^{1, \frac{1}{2}}$-regularity constants bounded depending only on $n, \gamma, \lambda$ and $I_{G}^{0}$. In addition, defining

$$
E_{0}:=\left\{x \in \mathbb{R}^{n}: \text { there exists } r>0 \text { s.t. }\left|B_{r}(x) \cap E\right|=\left|B_{r}(x)\right|\right\}
$$

$E_{0}$ is an open set equivalent to $E$ such that $\partial E_{0}=\operatorname{spt} \mu_{E}$, whose topological connected components coincide with the $\mathcal{M}$-connected components of $E$, and it is included in some ball $B_{R}$, where $R$ depends only on $n, \gamma, \lambda$ and $I_{G}^{0}$. If $n \leqslant 7$, then $\partial E_{0}=\partial^{*} E$, making the topological boundary of $E_{0}$ a $C^{1, \frac{1}{2}}$ hypersurface, and if $n \geqslant 8$, then $\operatorname{dim}_{\mathscr{H}}\left(\partial E_{0} \backslash \partial^{*} E\right) \leqslant n-8$. Furthermore, if $\gamma<1$ and $\lambda>\lambda_{e}$ (given by Theorem 4.5), or if $G$ is not compactly supported, then $E_{0}$ is connected.

Proof. This is essentially a consequence of well-known results on quasi-minimizers of the perimeter, but for the sake of clarity, we give precise references.

The fact that $E_{0}$ is an open set equivalent to $E$ such that $\partial E_{0}=\operatorname{spt} \mu_{E}$ is due to [27, Lemma 2.1.3 \& Proposition 2.2.1] (more precisely, see equations (2.1.6) \& (2.2.5) therein, which characterize $\partial E_{0}$; see also [28, Lemma 3.6]). By Proposition 4.14 with $f(r)=\lambda \gamma I_{G}^{0} r$ (i.e., $p=1$ ), $E$ is a $r_{0}$-quasi-minimizer of the perimeter w.r.t. to $\omega(r)=C r$ for some $C$ and $r_{0}$ depending only on $n, \gamma, \lambda$ and $I_{G}^{0}$.

Using [31, Theorem 1] (see also [25, Theorem 28.1]), $\partial^{*} E$ is a $C^{1, \frac{1}{2}}$-hypersurface, with $\operatorname{dim}_{\mathscr{H}}\left(\partial E_{0} \backslash\right.$ $\left.\partial^{*} E\right) \leqslant n-8$ whenever $n>8$, and $\partial E_{0}=\partial^{*} E$ whenever $n \leqslant 7$. By the results of [27, 28] we know that there exists a singular set $\Sigma(E)$ (which is defined by a condition of mean-flatness, see [28, Section 6] or [2, Definition 4.6]) such that $\partial E_{0} \backslash \Sigma(E)$ is locally made of ( $n-1$ )-dimensional graphs of class $C^{1, \frac{1}{2}}$, where $\operatorname{dim}_{\mathscr{H}}(\Sigma(E)) \leqslant n-8$ for $n>8$ and $\Sigma(E)=\emptyset$ for $n<7$ (see [2, Theorem 4.10]). In addition, a look at the proofs in [2] or at [28] shows that the $C^{1, \frac{1}{2}}$-regularity constant outside $\Sigma(E)$ are bounded depending only on the radius $r_{0}$ and the constant of quasi-minimality. By definition of this singular set and $C^{1, \frac{1}{2}}$-regularity of $\partial^{*} E$, we see that $\Sigma(E) \subseteq \partial E_{0} \backslash \partial^{*} E$, so that the $C^{1, \frac{1}{2}}$-regularity constant of $\partial^{*} E$ is obviously bounded depending only on $n, \gamma, \lambda$ and $I_{G}^{0}$ as well.

Since $E_{0}$ is open and $\mathscr{H}^{n-1}\left(\partial E_{0}\right)=\mathscr{H}^{n-1}\left(\operatorname{spt} \mu_{E}\right)=\mathscr{H}^{n-1}\left(\partial^{*} E\right)$, Theorem 4.8 implies that the $\mathcal{M}$-connected components of $E$ coincide with the topological connected components of $E_{0}$. The fact that $E_{0}$ is included in a ball $B_{R}$ such that $R=R\left(n, \gamma, \lambda, I_{G}^{0}\right)$ comes from the density estimate

$$
\begin{equation*}
\left|E \cap B_{r}(x)\right| \geqslant c\left|B_{r}(x)\right|, \quad \text { for } \mathscr{L}^{n} \text {-a.e. } x \in E \text { and every } 0<r<r_{1}, \tag{4.21}
\end{equation*}
$$

where $c=c\left(n, \gamma, \lambda, I_{G}^{0}\right), r_{1}=r_{1}\left(n, \gamma, \lambda, I_{G}^{0}\right)$, which is a consequence of the results in [27]: more precisely, a uniform version (in the sense that the density and radius constants depend only of the minimized functional, not on a specific minimizer $E$ ) of [27, Lemma 2.1.3] is obtained in [27, Section 4.1] (see in particular paragraph 4.1.3 therein), which readily implies (4.21). Eventually, if $\gamma<1$ and

[^0]$\lambda>\lambda_{e}$, or if $G$ is not compactly supported, by Propositions 4.9 and $4.11, E$ has only one $\mathcal{M}$-connected component, thus $E_{0}$ is connected.

## 5. Stability of the ball

As in the previous section, we always assume that the kernel $G$ satisfies assumptions (H1) and (H2).
5.1. First and second variations of perimeters. In this subsection we recall formulas for the first and second variations of the classical and nonlocal perimeters, which can be found e.g. in [12, Section 6]. In all this subsection, $E$ denotes an open set of finite parameter such that $\partial E$ is a $C^{2}$ hypersurface. First we define some terminology.

Given a vector field $X \in C_{c}^{\infty}\left(\mathbb{R}^{n} ; \mathbb{R}^{n}\right)$, we define the flow induced by $X$ as the solution in $t \in \mathbb{R}$ of the ODEs

$$
\left\{\begin{array}{l}
\partial_{t} \Phi_{t}(x)=X\left(\Phi_{t}(x)\right) \\
\Phi_{0}(x)=x
\end{array}\right.
$$

for every $x \in \mathbb{R}^{n}$. It is well known that $\Phi_{t}(x)$ is well defined for every $t \in \mathbb{R}$ and $x \in \mathbb{R}^{n}$, and that $\left(\Phi_{t}\right)_{t \in \mathbb{R}}$ is a one-parameter group of smooth diffeomorphisms on $\mathbb{R}^{n}$, i.e., $\Phi_{t} \circ \Phi_{s}=\Phi_{s+t}$ for all $s, t \in \mathbb{R}$, and $\Phi_{0}=\mathrm{id}_{\mid \mathbb{R}^{n}}$. Given $\Phi_{t}$ a flow induced by $X$, we let $E_{t}:=\Phi_{t}(E)$.
Definition 5.1. We say that a vector field $X \in C_{c}^{\infty}\left(\mathbb{R}^{n} ; \mathbb{R}^{n}\right)$ induces a volume-preserving flow on $E$ if there exists $\delta>0$ such that $\left|E_{t}\right|=|E|$ for all $|t|<\delta$.

Given a functional $\mathcal{F}$ on sets of finite perimeter such that $t \mapsto \mathcal{F}\left(E_{t}\right) \in C^{2}(-\delta, \delta)$ for some $\delta>0$, we define the first and second variations of $\mathcal{F}$ at $E$ in the direction $X \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ by

$$
\delta \mathcal{F}(E)[X]:=\left[\frac{\mathrm{d}}{\mathrm{~d} t} \mathcal{F}\left(E_{t}\right)\right]_{\mid t=0}, \quad \delta^{2} \mathcal{F}(E)[X]:=\left[\frac{\mathrm{d}^{2}}{\mathrm{~d} t^{2}} \mathcal{F}\left(E_{t}\right)\right]_{\mid t=0}
$$

Then we define the notion of volume-constrained stationary sets (that is, critical points) for a functional.
Definition 5.2. We say that $E$ is a volume-constrained stationary set for the functional $\mathcal{F}$ if for every $X \in C_{c}^{\infty}\left(\mathbb{R}^{n} ; \mathbb{R}^{n}\right)$ inducing a volume-preserving flow on $E$, we have $\delta \mathcal{F}(E)[X]=0$.

We are interested in the variations of the classical perimeter $P$ and of the nonlocal perimeter $\mathrm{Per}_{G}$, which we will deduce from the variations of the nonlocal term

$$
\mathcal{V}_{G}(E):=\iint_{E \times E} G(x-y) \mathrm{d} x \mathrm{~d} y=|E| I_{G}^{0}-\operatorname{Per}_{G}(E)
$$

For the classical perimeter, it is known that $t \mapsto P\left(E_{t}\right)$ is smooth in $(-\delta, \delta)$ whenever $E$ is a set of finite perimeter, and if $\partial E$ is a $C^{2}$-hypersurface, the first variation is

$$
\delta P(E)[X]=\int_{\partial E} H_{\partial E} \zeta_{X} d \mathscr{H}^{n-1}
$$

where $\zeta_{X}:=X \cdot \nu_{E}, \nu_{E}$ denotes the outer unit normal to $E$, and $H_{\partial E}$ is the scalar mean curvature of $\partial E$. The second variation is given by

$$
\delta^{2} P(E)[X]=\int_{\partial E}\left|\nabla_{\tau} \zeta_{X}\right|^{2}-c_{\partial E}^{2} \zeta_{X}^{2} d \mathscr{H}^{n-1}+\int_{\partial E} H_{\partial E}\left((\operatorname{div} X) \zeta_{X}-\operatorname{div}_{\tau}\left(\zeta_{X} X_{\tau}\right)\right) d \mathscr{H}^{n-1}
$$

where $c_{\partial E}^{2}(x)$ is the sum of the squares of the principal curvatures of $\partial E$ at $x, X_{\tau}:=X-\zeta_{X} \nu_{E}$, and $\nabla_{\tau}$ and $\operatorname{div}_{\tau}$ denote respectively the tangential gradient and divergence on $\partial E$. In addition, if $E$ is a volume-constrained stationary set for the perimeter, and $X$ induces a volume-preserving flow on $E$, then the second variation of the perimeter takes the simpler form

$$
\begin{equation*}
\delta^{2} P(E)[X]=\int_{\partial E}\left|\nabla_{\tau} \zeta_{X}\right|^{2}-c_{\partial E}^{2} \zeta_{X}^{2} d \mathscr{H}^{n-1} \tag{5.1}
\end{equation*}
$$

Indeed, in that case $H_{\partial E}$ is constant, and the fact that $t \mapsto\left|E_{t}\right|$ is constant in a neighborhood of 0 implies

$$
0=\left[\frac{\mathrm{d}}{\mathrm{~d} t}\left|E_{t}\right|\right]_{\mid t=0}=\int_{\partial E} \zeta_{X} d \mathscr{H}^{n-1} \quad \text { and } \quad 0=\left[\frac{\mathrm{d}^{2}}{\mathrm{~d} t^{2}}\left|E_{t}\right|\right]_{\mid t=0}=\int_{\partial E}(\operatorname{div} X) \zeta_{X} d \mathscr{H}^{n-1}
$$

As for the second variation of $\mathcal{V}_{G}$, assuming that $G(x)=o\left(|x|^{\alpha-n}\right)$ at the origin and $G(x)=$ $o\left(|x|^{-(n+\beta)}\right)$ at infinity for some $\alpha>0$ and $\beta>0$, it satisfies the assumption $[12,(6.7)]$, and, since $E$
is an open set with finite volume such that $\partial E$ is a $C^{2}$-hypersurface, we can apply [12, Theorem 6.1] directly to get

$$
\begin{align*}
& \delta \mathcal{V}_{G}(E)[X]= \int_{\partial E} H_{G, \partial E}^{*} \zeta_{X} d \mathscr{H}^{n-1}, \\
& \delta^{2} \mathcal{V}_{G}(E)[X]=-\iint_{\partial E \times \partial E} G(x-y)\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}+\int_{\partial E} c_{G, \partial E}^{2} \zeta_{X}^{2} d \mathscr{H}^{n-1}  \tag{5.2}\\
& \quad+\int_{\partial E} H_{G, \partial E}^{*}\left((\operatorname{div} X) \zeta_{X}-\operatorname{div}_{\tau}\left(\zeta_{X} X_{\tau}\right)\right) d \mathscr{H}^{n-1},
\end{align*}
$$

where

$$
c_{G, \partial E}^{2}(x):=\int_{\partial E} G(x-y)\left|\nu_{E}(x)-\nu_{E}(y)\right|^{2} d \mathscr{H}_{y}^{n-1}, \quad \forall x \in \partial E
$$

and $H_{G, \partial E}^{*}$, which plays the role of a nonlocal mean curvature of $\partial E$, is defined by

$$
\begin{equation*}
H_{G, \partial E}^{*}(x):=2 \int_{E} G(x-y) \mathrm{d} y, \quad \forall x \in \partial E . \tag{5.3}
\end{equation*}
$$

Note that all the integrals in (5.2) are finite whenever $\partial E$ is a $C^{2}$-hypersurface by the assumptions on $G$, since $X_{\tau}, \zeta_{X}$ and $\nu_{E}$ are bounded and $C^{1}$ functions. Similarly to the perimeter functional, if $E$ is a volume-constrained stationary set for $\mathcal{V}_{G}$, and $X$ induces a volume-preserving flow on $E$, the fact that $t \mapsto\left|E_{t}\right|$ is constant in a neighborhood of 0 implies that the second variation of $\mathcal{V}_{G}$ is simply given by

$$
\delta^{2} \mathcal{V}_{G}(E)[X]=-\iint_{\partial E \times \partial E} G(x-y)\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}+\int_{\partial E} c_{G, \partial E}^{2} \zeta_{X}^{2} d \mathscr{H}^{n-1}
$$

Recalling that,

$$
\operatorname{Per}_{G}\left(E_{t}\right)=I_{G}^{0}\left|E_{t}\right|-\mathcal{V}_{G}\left(E_{t}\right), \quad \forall t \in(-\delta, \delta),
$$

we see that $E$ is a volume-constrained stationary set for $\mathcal{V}_{G}$ if and only if it is such a set for $\operatorname{Per}_{G}$. Hence, we get the following expression of the second variation of the nonlocal perimeter.

Proposition 5.3. Assume that $G(x)=o\left(|x|^{\alpha-n}\right)$ at the origin, and $G(x)=o\left(|x|^{-(n+\beta)}\right)$ at infinity for some positive constants $\alpha$ and $\beta$. Then, if $X$ induces a volume-preserving flow on $E$, we have

$$
\begin{aligned}
\delta^{2} \operatorname{Per}_{G}(E)[X] & =-\delta^{2} \mathcal{V}_{G}(E)[X] \\
& =\iint_{\partial E \times \partial E} G(x-y)\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}-\int_{\partial E} c_{G, \partial E}^{2} \zeta_{X}^{2} d \mathscr{H}^{n-1} .
\end{aligned}
$$

We end this section by recalling the definition of stability in that setting.
Definition 5.4. We say that $E$ is a volume-constrained stable set for the functional $\mathcal{F}$ if $E$ is a volume-constrained stationary set for $\mathcal{F}$, and $\delta^{2} \mathcal{F}(E)[X] \geqslant 0$ for every vector field $X \in C_{c}^{\infty}\left(\mathbb{R}^{n} ; \mathbb{R}^{n}\right)$ inducing a volume-preserving flow on $E$.

Obviously, if $E$ is a volume-constrained minimizer for some functional $\mathcal{F}$, it is a volume-constrained stable set for $\mathcal{F}$ in this sense.
5.2. The stability threshold for the unit ball. We are interested in the stability of the unit ball for $\left(\mathrm{P}_{\gamma, \lambda}\right)$.
5.2.1. Instability when $\gamma>1$. First, we give the expression of the second variation of $\mathcal{F}_{\gamma, G_{\lambda}}$ at $B_{1}$.

Proposition 5.5 (Second variation). For every $\gamma>0, \lambda>0$, the unit ball $B_{1}$ is a volume-constrained stationary set for $\mathcal{F}_{\gamma, G_{\lambda}}$. Furthermore, if $G(x)=o\left(|x|^{\alpha-n}\right)$ at the origin, and $G(x)=o\left(|x|^{-(n+\beta)}\right)$ at infinity for some positive constants $\alpha$ and $\beta$, then for any vector field $X \in C_{c}^{\infty}\left(\mathbb{R}^{n} ; \mathbb{R}^{n}\right)$ inducing a volume-preserving flow on $B_{1}$, the second variation of $\mathcal{F}_{\gamma, G_{\lambda}}$ at $B_{1}$ in the direction $X$ is given by

$$
\begin{align*}
& \delta^{2} \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)[X] \\
& =\int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} \zeta_{X}\right|^{2} d \mathscr{H}^{n-1}-\gamma \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2}}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}  \tag{5.4}\\
& \quad-\left(c_{\mathbb{S}^{n-1}}^{2}-\gamma c_{G, \lambda, \mathbb{S}^{n-1}}^{2}\right) \int_{\mathbb{S}^{n-1}} \zeta_{X}^{2} d \mathscr{H}^{n-1} .
\end{align*}
$$

where $c_{\mathbb{S}^{n-1}}^{2}=n-1$ is the sum of the squares of the principal curvatures of $\mathbb{S}^{n-1}$,

$$
c_{G, \lambda, \mathbb{S}^{n-1}}^{2}:=\int_{\mathbb{S}^{n-1}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{y}^{n-1},
$$

and where for all $r \in(0,+\infty)$ and $\varepsilon>0$, we defined

$$
\begin{equation*}
\eta_{G}(r):=r^{2} g(r), \quad \eta_{G, \varepsilon}(r):=\varepsilon^{-(n-1)} \eta_{G}\left(\varepsilon^{-1} r\right) . \tag{5.5}
\end{equation*}
$$

Proof. Since the unit ball is a minimizer of the perimeter under volume constraint, it is a volumeconstrained stationary set for the perimeter. Recall that $\mathcal{V}_{G_{\lambda}}$ is maximized by balls under volume constraint, so that $\operatorname{Per}_{G_{\lambda}}$ is minimized by balls under volume constraint, thus the unit ball is a stationary set for the nonlocal perimeter ${ }^{2}$. Since $B_{1}$ has a smooth boundary, applying Proposition 5.3 to $\operatorname{Per}_{G_{\lambda}}$, we find

$$
\begin{align*}
\delta^{2} \operatorname{Per}_{G_{\lambda}}\left(B_{1}\right)[X]=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} & G_{\lambda}(x-y)\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \\
& \quad-\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} G_{\lambda}(x-y)|x-y|^{2} \zeta_{X}(x)^{2} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \tag{5.6}
\end{align*}
$$

for every $X \in C_{c}^{\infty}\left(\mathbb{R}^{n} ; \mathbb{R}^{n}\right)$ inducing a volume-preserving flow on $B_{1}$.
Now, we can rewrite (5.6) in terms of $\eta_{G, 1 / \lambda}$ by

$$
\begin{aligned}
& \delta^{2} \operatorname{Per}_{G_{\lambda}}\left(B_{1}\right)[X]=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2}}{|x-y|^{2}} \eta_{G, 1 / \lambda}(x-y) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \\
& \quad-\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \eta_{G, 1 / \lambda}(x-y) \zeta_{X}(x)^{2} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} .
\end{aligned}
$$

Note that

$$
c_{G, \lambda, \mathbb{S}^{n-1}}^{2}=\int_{\mathbb{S}^{n-1}} \eta_{G, 1 / \lambda}(x-y) d \mathscr{H}_{y}^{n-1}
$$

does not depend on $x \in \mathbb{S}^{n-1}$, since $\eta_{G, 1 / \lambda}$ is invariant under rotations, thus by Fubini's theorem we find

$$
\begin{gathered}
\delta^{2} \operatorname{Per}_{G_{\lambda}}\left(B_{1}\right)[X]=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2}}{|x-y|^{2}} \eta_{G, 1 / \lambda}(x-y) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \\
-c_{G, \lambda, \mathbb{S}^{n-1}}^{2} \int_{\mathbb{S}^{n-1}} \zeta_{X}^{2} d \mathscr{H}^{n-1},
\end{gathered}
$$

which concludes the proof, since the second variation of the perimeter is given by (5.1).
Remark 5.6. In view of the expression of $\delta^{2} \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)[X]$, it would be natural to define the quadratic functional $\mathcal{Q} \mathcal{F}_{\gamma, G_{\lambda}}(u):=\mathcal{Q} P(u)-\gamma \mathcal{Q} \operatorname{Per}_{G_{\lambda}}(u)$, where

$$
\mathcal{Q} P(u):=\int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} u\right|^{2} d \mathscr{H}^{n-1}-(n-1) \int_{\mathbb{S}^{n-1}} u^{2} d \mathscr{H}^{n-1}
$$

and

$$
\begin{aligned}
& \mathcal{Q} \operatorname{Per}_{G_{\lambda}}(u):=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \lambda^{n+1} G(\lambda(x-y))|u(x)-u(y)|^{2} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \\
& \quad-\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \lambda^{n+1} G(\lambda(x-y))|x-y|^{2} u(x)^{2} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1},
\end{aligned}
$$

on the vector space of functions $u \in H^{1}\left(\mathbb{S}^{n-1}\right)$ such that $\int_{\mathbb{S}^{n-1}} u d \mathscr{H}{ }^{n-1}=0$ (recall that $\zeta_{X}=X \cdot \nu_{B}$ is null-averaged on $\mathbb{S}^{n-1}$ whenever $X$ induces a volume-preserving flow on $B_{1}$, since $B_{1}$ is a volumeconstrained stationary set). Instead of defining the stability of the unit ball by the nonnegativity of the quantity $\delta^{2} \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)[X]$ for every flow $X$ inducing a volume-preserving flow on $B_{1}$, we could have defined it by the nonnegativity of the quadratic functional $\mathcal{Q} \mathcal{F}_{\gamma, G_{\lambda}}$ on null-averaged functions in $H^{1}\left(\mathbb{S}^{n-1}\right)$. In fact, it is worth pointing out that, by the proof of [12, Theorem 7.1], those two notions of stability coincide.

[^1]Similarly to the family $\left(\rho_{G, \varepsilon}\right)_{\varepsilon>0}$ introduced in (3.9) for rewriting $\operatorname{Per}_{G_{\lambda}}$, we see that the family $\left(\eta_{G, \varepsilon}\right)_{\varepsilon>0}$ is, up to multiplication by a constant, an approximation of identity as well, as defined in Definition 3.7 - however, here it is a $(\mathbf{n}-\mathbf{1})$-dimensional approximation of identity.
Lemma 5.7. After multiplication by $\mathbf{K}_{2, n-1}$, the family $\left(\eta_{G, \varepsilon}\right)_{\varepsilon>0}$ defined by (5.5) is a $(n-1)$ dimensional approximation of identity.

Proof. First, let us check that

$$
\mathbf{K}_{2, n-1}\left|\mathbb{S}^{n-2}\right| \int_{0}^{\infty} r^{n-2} \eta_{G}(r) \mathrm{d} r=1
$$

Using that

I_{G}^{1}=\frac{2}{\mathbf{K}_{1, n}}
$$

and the expression of $\mathbf{K}_{p, n}$ given by Lemma 3.13, we find

$$
\mathbf{K}_{2, n-1}\left|\mathbb{S}^{n-2}\right| \int_{0}^{\infty} \eta_{G}(r) \mathrm{d} r=\frac{\mathbf{K}_{2, n-1}\left|\mathbb{S}^{n-2}\right|}{\left|\mathbb{S}^{n-1}\right|} I_{G}^{1}=\frac{2 \mathbf{K}_{2, n-1}\left|\mathbb{S}^{n-2}\right|}{\mathbf{K}_{1, n}\left|\mathbb{S}^{n-1}\right|}=1
$$

By a change of variables, we see that

$$
\int_{0}^{\infty} r^{n-2} \eta_{G, \varepsilon}(r) \mathrm{d} r=\int_{0}^{\infty} r^{n-2} \eta_{G}(r) \mathrm{d} r
$$

thus there remains only to check that for every $\delta>0$, we have

$$
\int_{\delta}^{\infty} \eta_{G, \varepsilon}(r) r^{n-2} \mathrm{~d} r \xrightarrow{\varepsilon \rightarrow 0} 0 .
$$

By yet another change of variables

$$
\int_{\delta}^{\infty} r^{n-2} \eta_{G, \varepsilon}(r) \mathrm{d} r=\frac{1}{\left|\mathbb{S}^{n-1}\right|} \int_{B_{\delta}^{\mathrm{c}}} \frac{\eta_{G, \varepsilon}(|x|)}{|x|} \mathrm{d} x=\frac{1}{\left|\mathbb{S}^{n-1}\right|} \int_{B_{\frac{\delta}{\varepsilon}}^{\mathrm{c}}}|x| G(x) \mathrm{d} x
$$

which vanishes as $\varepsilon$ goes to 0 , since $G$ is integrable on $\mathbb{R}^{n}$ w.r.t. to the measure $|x| \mathrm{d} x$ by (H2).
To see if the unit ball is stable or not when $\lambda$ is large, we wish to pass to the limit in the second variation of $\mathcal{F}_{\gamma, G_{\lambda}}$ at $B_{1}$, but since we integrate over $\mathbb{S}^{n-1}$ instead of $\mathbb{R}^{n}$, we cannot use Proposition 3.8. In [22, Theorem 1.1], an equivalent to this proposition is given for smooth Riemannian manifolds, however, the requirements on the family $\left(\eta_{G, \varepsilon}\right)_{\varepsilon>0}$ seem too strong: namely the requirement that the functions $\eta_{G, \varepsilon}$ are nonincreasing, i.e., that $r \mapsto r^{2} g(r)$ is nonincreasing. In any case, the convergence result given by [22, Theorem 1.1] would not be enough to show, as we do below, that the unit ball is stable when $\gamma<1$, provided that $\lambda$ is large enough. In order to prove this, we also need an upper bound similar to Proposition 3.1.

In Appendix A, we establish the required counterparts of Propositions 3.1 and 3.8 for the sphere. This allows us to prove that balls go from stable to unstable as $\gamma$ passes the threshold 1 , when $\lambda$ is large enough.

Theorem 5.8. Assume that $G$ satisfies assumptions (H1) to (H4). If $\gamma>1$, there exists $\lambda_{u}=\lambda_{u}(n, G)$ such that for any $\lambda>\lambda_{u}$ the unit ball $B_{1}$ is an unstable critical point of the functional $\mathcal{F}_{\gamma, G_{\lambda}}$.
Proof. Consider a vector field $X \in C_{c}^{\infty}\left(\mathbb{R}^{n} ; \mathbb{R}^{n}\right)$ inducing a volume-preserving flow on $B_{1}$ such that $\delta^{2} P\left(B_{1}\right)[X]>0$. Note that $G(x)=o\left(|x|^{\alpha-n}\right)$ at the origin and $G(x)=o\left(|x|^{-(n+\beta)}\right)$ by (H3) and (H4) respectively, thus the second variation of $\mathcal{F}_{\gamma, G_{\lambda}}$ at $B_{1}$ is given by Proposition 5.5, and by Lemma 5.7, up to multiplying my $\mathbf{K}_{2, n-1}$, the family $\left(\eta_{G, \varepsilon}\right)_{\varepsilon>0}$ is a $(n-1)$-dimensional approximation of identity. In order to apply Proposition A.4, we need to check that this family also satisfies assumption (T) in dimension $n=2$. Let $r>0$. Given $\delta>0$, by (H4), there exists $t_{*}$ such that, for any $t>t_{*}$, we have $t^{3} g(t) \leqslant \delta r$. Thus there exists $\varepsilon_{*}$ such that, for every $\varepsilon<\varepsilon_{*}$ and every $s>r$, we have $\varepsilon^{-1} s>t_{*}$, hence

$$
\left(\frac{s}{\varepsilon}\right)^{3} g\left(\frac{s}{\varepsilon}\right) \leqslant \delta r, \quad \forall s>r,
$$

which implies

$$
\eta_{G, \varepsilon}(s)=\varepsilon^{-3} s^{2} g\left(\varepsilon^{-1} s\right)=\frac{1}{s}\left(\frac{s}{\varepsilon}\right)^{3} g\left(\frac{s}{\varepsilon}\right) \leqslant \delta, \quad \forall s>r
$$

so that $\sup _{s>r} \eta_{G, \varepsilon}(s)$ vanishes as $\varepsilon$ goes to 0 , i.e., the family $\left(\eta_{G, \varepsilon}\right)_{\varepsilon>0}$ satisfies (T) in dimension $n=2$, by the arbitrariness of $r$. Hence we can always apply Proposition A.4, which gives

$$
\begin{equation*}
\lim _{\lambda \rightarrow \infty} \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2}}{|x-y|^{2}} \eta_{G, 1 / \lambda}(x-y) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}=\int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} \zeta_{X}\right|^{2} d \mathscr{H}^{n-1} \tag{5.7}
\end{equation*}
$$

Similarly, we compute

$$
\begin{align*}
c_{G, \lambda, \mathbb{S}^{n-1}}^{2} & =\frac{1}{\left|\mathbb{S}^{n-1}\right|} \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \eta_{G, 1 / \lambda}(x-y) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \\
& =\frac{1}{\left|\mathbb{S}^{n-1}\right|} \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|x-y|^{2}}{|x-y|^{2}} \eta_{G, 1 / \lambda}(x-y) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}  \tag{5.8}\\
& \xrightarrow{\lambda \rightarrow \infty} \frac{1}{\left|\mathbb{S}^{n-1}\right|} \int_{\mathbb{S}^{n-1}}|\nabla \tau \mathrm{id}|^{2} d \mathscr{H}^{n-1}=n-1=c_{\mathbb{S}^{n-1}}^{2} .
\end{align*}
$$

Combining (5.7) and (5.8) with Proposition 5.5, we find

$$
\begin{aligned}
\lim _{\lambda \rightarrow \infty} \delta^{2} \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)[X] & =(1-\gamma)\left(\int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} \zeta_{X}\right|^{2}-c_{\mathbb{S}^{n-1}}^{2} \zeta_{X}^{2} d \mathscr{H}^{n-1}\right) \\
& =(1-\gamma) \delta^{2} P\left(B_{1}\right)[X]<0
\end{aligned}
$$

since $\gamma>1$ and $\delta^{2} P\left(B_{1}\right)[X]>0$. This shows that there exists $\lambda_{u}>0$ such that for any $\lambda>\lambda_{u}$, the unit ball is unstable for $\mathcal{F}_{\gamma, G_{\lambda}}$, which concludes the proof.
5.2.2. Decomposition in spherical harmonics. We have just seen that if $\gamma>1$, then the unit ball is unstable for large values of $\lambda$. Conversely, we prove that if $\gamma<1$, then the unit is stable for large values of $\lambda$, which shows that this stability threshold is sharp. In order to prove this, we are going to use the decomposition of the Jacobi operator associated with the second variation of $\mathcal{F}_{\gamma, G_{\lambda}}$ in spherical harmonics.

Looking at the quadratic form of the second variation given by Proposition 5.5, we see that the three different terms on the right-hand side of (5.4) derive, first, from the Laplace-Beltrami operator on the sphere, second, the identity map on the sphere, and third, the integral operator

$$
\begin{equation*}
\mathscr{R}_{G, \lambda}(u)(x):=2 \int_{\mathbb{S}^{n-1}} \frac{u(x)-u(y)}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{y}^{n-1}, \tag{5.9}
\end{equation*}
$$

(we will justify later that it is well-defined on $C^{1}\left(\mathbb{S}^{n-1}\right)$ ). Indeed, formally, we have

$$
\int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} u\right|^{2} d \mathscr{H}^{n-1}=\int_{\mathbb{S}^{n-1}}\left(-\Delta_{\mathbb{S}^{n-1}} u\right) u d \mathscr{H}^{n-1}
$$

and, by symmetry,

$$
\int_{\mathbb{S}^{n-1}} u \mathscr{R}_{G, \lambda}(u) d \mathscr{H}^{n-1}=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)| 2}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}
$$

As is well-known, spherical harmonics are eigenfunctions for the Laplace-Beltrami operator on the sphere, and as we show, they are also eigenfunctions for the integral operators $\mathscr{R}_{G, \lambda}$. In the end, to establish the stability of the ball, one needs only study the eigenvalues of the three operators, and deduce that the eigenvalues of the operator associated with the second variation of $\mathcal{F}_{\gamma, G_{\lambda}}$ are all positive for large values of $\lambda$.

Let us now recall a few basic facts on spherical harmonics and justify that the $\mathscr{R}_{G, \lambda}$ are well defined. For $k \in \mathbb{N}$, we denote by $\mathcal{S}_{k}$ the finite dimensional subspace of $L^{2}\left(\mathbb{S}^{n-1}\right)$ made of the spherical harmonics of degree $k$, and $\left(Y_{k}^{i}\right)_{1 \leqslant i \leqslant d(k)}$ an orthonormal basis of $\mathcal{S}_{k}$ in $L^{2}\left(\mathbb{S}^{n-1}\right)$. When there can be no confusion, we denote by $Y_{k}$ a generic element of $\mathcal{S}_{k}$. Let us recall that $Y_{k} \in \mathcal{S}_{k}$ and $Y_{l} \in \mathcal{S}_{l}$ are orthogonal in $L^{2}\left(\mathbb{S}^{n-1}\right)$ whenever $k \neq l$, and that the family

$$
\begin{array}{r}
\left(Y_{k}^{i}\right)_{\substack{0 \leqslant k<\infty \\
1 \leqslant i \leqslant d(k)}}, ~
\end{array}
$$

is total, i.e., it is an orthonormal basis of $L^{2}\left(\mathbb{S}^{n-1}\right)$. For any $u \in L^{2}\left(\mathbb{S}^{n-1}\right)$, we denote by $a_{k}^{i}(u)$ its $(i, k)$-coordinate in the basis, that is,

$$
\begin{equation*}
u=\sum_{k=0}^{\infty} \sum_{i=1}^{d(k)} a_{k}^{i}(u) Y_{k}^{i} \tag{5.10}
\end{equation*}
$$

In the following, we will often use the following to integrate $\mathbb{S}^{n-1}$ by slices (see e.g. [17, Section D.2] or [4, Corollary A.6]): a $\mathscr{H}^{n-1}$-measurable function $f$ is integrable on $\mathbb{S}^{n-1}$ if and only $(x, t) \mapsto$ $\left(1-t^{2}\right)^{\frac{n-3}{2}} f\left(\sqrt{1-t^{2}} x, t\right)$ is integrable on $\mathbb{S}^{n-2} \times(-1,1)$, and in that case we have

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} f d \mathscr{H}^{n-1}=\int_{-1}^{1}\left(1-t^{2}\right)^{\frac{n-3}{2}} \int_{\mathbb{S}^{n-2}} f\left(\sqrt{1-t^{2}} x, t\right) d \mathscr{H}_{x}^{n-2} \mathrm{~d} t \tag{5.11}
\end{equation*}
$$

Lemma 5.9. Let $f$ be a nonnegative measurable function on $(0,2)$. Then for every $x \in \mathbb{S}^{n-1}$, the map $F: y \mapsto f(|x-y|)$ belongs to $L^{1}\left(\mathbb{S}^{n-1}\right)$ if and only if

$$
\int_{\mathbb{S}^{n-1}} f(|x-y|) d \mathscr{H}_{y}^{n-1}=\left|\mathbb{S}^{n-2}\right| \int_{0}^{2}\left(1-\frac{s^{2}}{4}\right)^{\frac{n-3}{2}} s^{n-2} f(s) \mathrm{d} s<\infty
$$

If $n \geqslant 3$ and

$$
\begin{equation*}
\int_{0}^{2} f(r) r^{n-2} \mathrm{~d} r<+\infty \tag{5.12}
\end{equation*}
$$

then $F \in L^{1}\left(\mathbb{S}^{n-1}\right)$ and we have,

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} f(|x-y|) d \mathscr{H}_{y}^{n-1} \leqslant\left|\mathbb{S}^{n-2}\right| \int_{0}^{2} s^{n-2} f(s) \mathrm{d} s \tag{5.13}
\end{equation*}
$$

For $n=2$, if (5.12) holds and we have $f(r) \leqslant M$ on $(1,2)$, for some $M>0$, then $F \in L^{1}\left(\mathbb{S}^{n-1}\right)$ and

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} f(|x-y|) d \mathscr{H}_{y}^{n-1} \leqslant\left|\mathbb{S}^{n-2}\right|\left(\frac{2}{\sqrt{3}} \int_{0}^{1} f(s) s^{n-2} \mathrm{~d} s+\frac{M \pi}{3}\right) . \tag{5.14}
\end{equation*}
$$

Proof of Lemma 5.9. Up to a change of variables, we can assume that $x=N=(0, \ldots, 0,1)$ is the "north pole". Our computations will show that $y \mapsto f(|N-y|) \in L^{1}\left(\mathbb{S}^{n-1}\right)$. Applying (5.11) to $y \mapsto f(|N-y|)$ we find

$$
\begin{aligned}
\int_{\mathbb{S}^{n-1}} f(|N-y|) d \mathscr{H}_{y}^{n-1} & =\int_{-1}^{1}\left(1-t^{2}\right)^{\frac{n-3}{2}} \int_{\mathbb{S}^{n-2}} f\left(\left|N-\left(\sqrt{1-t^{2}} y, t\right)\right|\right) d \mathscr{H}_{y}^{n-2} \mathrm{~d} t \\
& =\int_{-1}^{1}\left(1-t^{2}\right)^{\frac{n-3}{2}} \int_{\mathbb{S}^{n-2}} f(\sqrt{2(1-t)}) d \mathscr{H}_{y}^{n-2} \mathrm{~d} t \\
& =\left|\mathbb{S}^{n-2}\right| R^{n-1} \int_{-1}^{1}\left(1-t^{2}\right)^{\frac{n-3}{2}} f(\sqrt{2(1-t)}) \mathrm{d} t
\end{aligned}
$$

Changing variables with $s=\sqrt{2(1-t)}$, it follows

$$
\begin{aligned}
\int_{\mathbb{S}^{n-1}} f(|N-y|) d \mathscr{H}_{y}^{n-1} & =\left|\mathbb{S}^{n-2}\right| \int_{0}^{2}\left[\left(s^{2}\left(1-\frac{s^{2}}{4}\right)\right]^{\frac{n-3}{2}} f(s) s \mathrm{~d} s\right. \\
& =\left|\mathbb{S}^{n-2}\right| \int_{0}^{2}\left(1-\frac{s^{2}}{4}\right)^{\frac{n-3}{2}} s^{n-2} f(s) \mathrm{d} s
\end{aligned}
$$

There remains to show that the integral on the right-hand side is finite, with the desired upper bounds. When $n \geqslant 3$, we have

$$
\left(1-\frac{s^{2}}{2}\right)^{\frac{n-3}{2}} \leqslant 1, \quad \forall s \in(0,2)
$$

which gives the required estimate and shows that the integral is finite. When $n=2$, assuming that $f(r) \leqslant M$ on $(0,1)$ and splitting the integral into two parts gives

$$
\begin{align*}
\int_{0}^{2}\left(1-\frac{s^{2}}{4}\right)^{-\frac{1}{2}} f(s) s^{n-2} \mathrm{~d} s & =\int_{0}^{1}\left(1-\frac{s^{2}}{4}\right)^{-\frac{1}{2}} f(s) s^{n-2} \mathrm{~d} s+\int_{1}^{2}\left(1-\frac{s^{2}}{4}\right)^{-\frac{1}{2}} f(s) \mathrm{d} s  \tag{5.15}\\
& \leqslant \frac{2}{\sqrt{3}} \int_{0}^{1} f(s) s^{n-2} \mathrm{~d} s+\frac{M \pi}{3}
\end{align*}
$$

hence the required estimate.

Proposition 5.10. If $n=2$, assume that $G(x) \leqslant M$ on $B_{R}^{\mathrm{c}}$, for some positive constants $M$ and $R$, and if $n \geqslant 3$, let us just set $R:=0$ and assume no upper bound on $G$. Then for every $\lambda>R$, the operator $\mathscr{R}_{G, \lambda}$ defined by (5.9) is an operator from $C^{1}\left(\mathbb{S}^{n-1}\right)$ to $L^{2}\left(\mathbb{S}^{n-1}\right)$. If in addition $G(x)=o\left(|x|^{\alpha-n}\right)$ near the origin for some $\alpha>1$, then for every $\lambda>R, \mathscr{R}_{G, \lambda}$ is actually an operator from $L^{2}\left(\mathbb{S}^{n-1}\right)$ to $L^{2}\left(\mathbb{S}^{n-1}\right)$. In any case, we have

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} u \mathscr{R}_{G, \lambda}(u) d \mathscr{H}^{n-1}=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)| 2}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \tag{5.16}
\end{equation*}
$$

whenever $u \in C^{1}\left(\mathbb{S}^{n-1}\right)$.
Remark 5.11. The extra assumption that $G(x) \leqslant M$ on some $B_{R}^{\mathrm{c}}$ in dimension $n=2$ is justified by Lemma 5.9. In any case, it holds if $G$ satisfies (H4).

Proof of Proposition 5.10. Assume that $\lambda>R$. We first focus on the case where $G$ satisfies the stronger assumption $G(x)=o\left(|x|^{\alpha-n}\right)$ near the origin.
Case 1. Assume $G=o\left(|x|^{\alpha-n}\right)$ near the origin, for some $\alpha>1$. In view of Lemma 5.9, we have

$$
\begin{align*}
\int_{\mathbb{S}^{n-1}} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|^{2}} d \mathscr{H}_{y}^{n-1} & =\lambda^{n+1} \int_{\mathbb{S}^{n-1}} r^{n-2} g(\lambda|x-y|) d \mathscr{H}_{y}^{n-1} \\
& =\lambda^{n+1}\left|\mathbb{S}^{n-2}\right| \int_{0}^{2}\left(1-\frac{s^{2}}{4}\right)^{\frac{n-3}{2}} s^{n-2} g(\lambda s) \mathrm{d} s \tag{5.17}
\end{align*}
$$

whose last integral is finite in both cases $n=2$ and $n \geqslant 3$, since $r^{n-2} g(\lambda r)=o\left(r^{\alpha-2}\right)$ in a neighborhood of 0 , and by the extra assumption $G(x) \leqslant M$ on $B_{R}^{\mathrm{c}}$ for $n=2$. Thus, using Cauchy-Schwarz inequality, for any $u \in L^{2}\left(\mathbb{S}^{n-1}\right)$ we find

$$
\begin{align*}
\int_{\mathbb{S}^{n-1}} & \left(\int_{\mathbb{S}^{n-1}}|u(y)| \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|^{2}} d \mathscr{H}_{y}^{n-1}\right)^{2} d \mathscr{H}_{x}^{n-1} \\
& \leqslant \int_{\mathbb{S}^{n-1}}\left(\int_{\mathbb{S}^{n-1}}|u(y)|^{2} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|^{2}} d \mathscr{H}_{y}^{n-1}\right)\left(\int_{\mathbb{S}^{n-1}} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|^{2}} d \mathscr{H}_{y}^{n-1}\right) d \mathscr{H}_{x}^{n-1} \\
& \leqslant C \int_{\mathbb{S}^{n-1}} \int_{\mathbb{S}^{n-1}}|u(y)|^{2} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|^{2}} d \mathscr{H}_{y}^{n-1} d \mathscr{H}_{x}^{n-1} \\
& \leqslant C \int_{\mathbb{S}^{n-1}}|u(y)|^{2}\left(\int_{\mathbb{S}^{n-1}} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|^{2}} d \mathscr{H}_{x}^{n-1}\right) d \mathscr{H}_{y}^{n-1} \leqslant C \int_{\mathbb{S}^{n-1}}|u(y)|^{2} d \mathscr{H}_{y}^{n-1} \tag{5.18}
\end{align*}
$$

for some $C=C(n, G, \lambda)$ and for every $u \in L^{2}\left(\mathbb{S}^{n-1}\right)$. As a consequence, by Fubini's theorem, the integral in (5.9) converges for $\mathscr{H}^{n-1}$-almost every $x \in \mathbb{S}^{n-1}$, and $\mathscr{R}_{G, \lambda}(u) \in L^{2}\left(\mathbb{S}^{n-1}\right)$ whenever $u \in L^{2}\left(\mathbb{S}^{n-1}\right)$.
Case 2. In the general case, $r^{n-2} g(\lambda r)$ is not necessarily integrable at the origin, so that the corresponding kernel is hypersingular, and $\mathscr{R}_{G, \lambda}(u)$ may not be well defined for every $u \in L^{2}\left(\mathbb{S}^{n-1}\right)$. Nonetheless, when $u \in C^{1}\left(\mathbb{S}^{n-1}\right)$, we have

$$
\frac{|u(x)-u(y)|}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) \leqslant C\|u\|_{C^{1}\left(\mathbb{S}^{n-1}\right)} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|}
$$

for every $x, y \in \mathbb{S}^{n-1}$, so that $\mathscr{R}_{G, \lambda}(u)(x)$ is still well defined for every $x \in \mathbb{S}^{n-1}$, and $\mathscr{R}_{G, \lambda}(u) \in$ $L^{2}\left(\mathbb{S}^{n-1}\right)$. Indeed, by Lemma 5.9 the integral

$$
\begin{aligned}
\int_{\mathbb{S}^{n-1}} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|} d \mathscr{H}_{y}^{n-1} & =\lambda^{n+1} \int_{\mathbb{S}^{n-1}} r^{n-1} g(\lambda|x-y|) d \mathscr{H}_{y}^{n-1} \\
& =\lambda^{n+1}\left|\mathbb{S}^{n-2}\right| \int_{0}^{2}\left(1-\frac{s^{2}}{4}\right)^{\frac{n-3}{2}} s^{n-1} g(\lambda s) \mathrm{d} s
\end{aligned}
$$

is finite, by the integrability of $G$ given by (H2) and the extra assumption on $G$ in dimension $n=2$. Then (5.16) is trivial by using the symmetry of $\mathbb{S}^{n-1}$ and of the kernel.

Let us recall the so-called Funk-Hekke formula, from which we deduce that spherical harmonics are actually eigenfunctions of the operator $\mathscr{R}_{G, \lambda}$ in both cases $\alpha \in(0,1]$ and $\alpha \in(1,+\infty)$, and obtain an expression of their associated eigenvalues.

Theorem 5.12 (Funk-Hekke formula [29, Theorem 1.7]). Let $f:(-1,1) \rightarrow \mathbb{R}$ be such that

$$
\int_{-1}^{1}\left(1-t^{2}\right)^{\frac{n-3}{2}}|f(t)| \mathrm{d} t<\infty
$$

Then for every $Y_{k} \in \mathcal{S}_{k}$ and every $x \in \mathbb{S}^{n-1}$, we have

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}} f(x \cdot y) Y_{k}(y) d \mathscr{H}_{y}^{n-1}=\mu_{k} Y_{k}(x) \tag{5.19}
\end{equation*}
$$

where $\mu_{k}$ is given by

$$
\mu_{k}=\left|\mathbb{S}^{n-1}\right| \int_{-1}^{1} P_{n, k}(t) f(t)\left(1-t^{2}\right)^{\frac{n-3}{2}} \mathrm{~d} t
$$

and $P_{n, k}$ denotes the Legendre polynomial of degree $d$ in dimension $n$, that is,

$$
P_{n, k}(t)=(-1)^{k} \frac{\Gamma\left(\frac{n-1}{2}\right)}{2^{k} \Gamma\left(k+\frac{n-1}{2}\right)}\left(1-t^{2}\right)^{-\frac{n-3}{2}}\left(\frac{\mathrm{~d}}{\mathrm{~d} t}\right)^{k}\left(1-t^{2}\right)^{k+\frac{n-3}{2}}
$$

Proposition 5.13. If $n=2$, assume that $G(x) \leqslant M$ on $B_{R}^{\mathrm{c}}$, for some positive constants $M$ and $R$, and if $n \geqslant 3$, let us just set $R:=0$ and assume no upper bound on $G$. Then spherical harmonics are eigenfunctions of the operators $\mathscr{R}_{G, \lambda}$, for any $\lambda>R$. More precisely, for every $k \in \mathbb{N}$, there exists $\mu_{G, \lambda, k} \in \mathbb{R}$ such that

$$
\mathscr{R}_{G, \lambda}\left(Y_{k}\right)=\mu_{G, \lambda, k} Y_{k}, \quad \forall Y_{k} \in \mathcal{S}_{k} .
$$

As a consequence, for every $u \in C^{1}\left(\mathbb{S}^{n-1}\right)$, we have

$$
\begin{equation*}
\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)| 2}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}=\sum_{k=0}^{\infty} \sum_{i=1}^{d(k)} \mu_{G, \lambda, k} a_{k}^{i}(u)^{2}, \tag{5.20}
\end{equation*}
$$

and $\mu_{G, \lambda, k}$ is given by

$$
\begin{equation*}
\mu_{G, \lambda, k}=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{\left|Y_{k}(x)-Y_{k}(y)\right|^{2}}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}, \tag{5.21}
\end{equation*}
$$

for any $Y_{k} \in \mathcal{S}_{k}$.
Proof. Let $\lambda>R$. The situation is actually easier if we add the extra assumption that $G(x)=o\left(|x|^{\alpha-n}\right)$ at the origin, for some $\alpha>1$, so for the clarity of the exposition we first prove that spherical harmonics are eigenfunctions for the operator $\mathscr{R}_{G, \lambda}$ under this extra assumption, and we drop it completely in a second step. In a third step we easily deduce (5.20) and (5.21).
Step 1. Here we assume $g(r)=o\left(r^{\alpha-n}\right)$ near 0 , for some $\alpha>1$. Then we can consider the operator

$$
\mathcal{R}_{G, \lambda}(u)(x):=\int_{\mathbb{S}^{n-1}} \frac{u(y)}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{y}^{n-1}
$$

and proceeding as above in (5.17) and (5.18), we see that it is a bounded linear operator from $L^{2}\left(\mathbb{S}^{n-1}\right)$ into $L^{2}\left(\mathbb{S}^{n-1}\right)$. Now let us see that we can just use the Funk-Hekke formula. Recalling that $|x-y|=$ $\sqrt{2(1-x \cdot y)}$ for every $x, y \in \mathbb{S}^{n-1}$, let us define

$$
\begin{equation*}
f_{G, \lambda}(t):=\frac{\eta_{G, 1 / \lambda}(\sqrt{2(1-t)})}{2(1-t)} \tag{5.22}
\end{equation*}
$$

so that for any $Y_{k} \in \mathcal{S}_{k}$, we have

$$
\mathcal{R}_{G, \lambda}\left(Y_{k}\right)(x)=\int_{\mathbb{S}^{n-1}} f_{G, \lambda}(x \cdot y) Y_{k}(y) d \mathscr{H}_{y}^{n-1}
$$

Changing variables, we compute

$$
\begin{equation*}
\int_{-1}^{1}\left(1-t^{2}\right)^{\frac{n-3}{2}}\left|f_{G, \lambda}(t)\right| \mathrm{d} t=\lambda^{n+1} \int_{0}^{2}\left(1-\frac{s^{2}}{4}\right)^{\frac{n-3}{2}} g(\lambda s) s^{n-2} \mathrm{~d} s \tag{5.23}
\end{equation*}
$$

which is finite in view of the fact that $g(r)=o\left(r^{\alpha-n}\right)$ with $\alpha>1$ at the origin, and by the extra assumption $G(x) \leqslant M$ in $B_{R}^{\mathrm{c}}$ when $n=2$ (cutting the integral into two parts as in Lemma 5.9). Thus Theorem 5.12 applies and shows that spherical harmonics are eigenfunctions of the operator $\mathcal{R}_{G, \lambda}$.

In addition, for every $k \in \mathbb{N}$, all the $Y_{k} \in \mathcal{S}_{k}$ share the same eigenvalue, which we denote by $\mu_{G, \lambda, k}^{*}$. Taking $Y_{k}=1$ in (5.19), one gets in particular

$$
\mu_{G, \lambda, 0}^{*}=\int_{\mathbb{S}^{n-1}} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|^{2}} d \mathscr{H}_{y}^{n-1}, \quad \forall x \in \mathbb{S}^{n-1}
$$

so that $\mathscr{R}_{G, \lambda}$ is simply given by

$$
\mathscr{R}_{G, \lambda}=2\left(\mu_{G, \lambda, 0}^{*} \mathrm{id}-\mathcal{R}_{G, \lambda}\right)
$$

Whence we deduce that spherical harmonics are also eigenfunctions for the operator $\mathscr{R}_{G, \lambda}$, and the eigenvalue associated with any $Y_{k} \in \mathcal{S}_{k}$ is

$$
\mu_{G, \lambda, k}:=2\left(\mu_{G, \lambda, 0}^{*}-\mu_{G, \lambda, k}^{*}\right)
$$

Step 2. When we do not know that $G(x)=o\left(|x|^{\alpha-n}\right)$ at the origin, the last integral on the right-hand side of (5.23) is not necessarily finite, so we cannot apply the Funk-Hekke formula directly on $f_{G, \lambda}$ to prove that spherical harmonic are eigenfunctions of the operator $\mathcal{R}_{G, \lambda}$. In fact, $\mathcal{R}_{G, \lambda}(u)$ is not even well defined for every $u \in C^{\infty}\left(\mathbb{S}^{n-1}\right)$, since

$$
\int_{\mathbb{S}^{n-1}} \frac{\eta_{G, 1 / \lambda}(|x-y|)}{|x-y|^{2}} d \mathscr{H}_{y}^{n-1}
$$

may not converge. Instead, we proceed similarly to [29, Lemmas $6.25 \& 6.26]$, defining the operators

$$
\begin{align*}
\mathscr{R}_{G, \lambda}^{\varepsilon}(u)(x) & :=2 \int_{\mathbb{S}^{n-1} \cap\{|x-y|>\varepsilon\}} \frac{u(x)-u(y)}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{y}^{n-1}  \tag{5.24}\\
& =2 \int_{\mathbb{S}^{n-1}}(u(x)-u(y)) f_{G, \lambda}^{\varepsilon}(x \cdot y) d \mathscr{H}_{y}^{n-1}
\end{align*}
$$

for every $\varepsilon \in(0,1)$, where

$$
f_{G, \lambda}^{\varepsilon}(t):=f_{G, \lambda}(t) \mathbf{1}_{\left(0,1-\frac{\varepsilon^{2}}{2}\right)}(t)
$$

and $f_{G, \lambda}$ is given by (5.22). Now by introducing this cutoff we have removed the singularity making $f_{G, \lambda}$ nonintegrable on $(-1,1)$ and the operator hypersingular, so that we may now use the Funk-Hekke formula with $f_{G, \lambda}^{\varepsilon}$, which gives

$$
\begin{equation*}
\mathscr{R}_{G, \lambda}^{\varepsilon}\left(Y_{k}\right)(x)=2 \mu_{G, \lambda, k}^{\varepsilon} Y_{k}(x), \quad \forall Y_{k} \in \mathcal{S}_{k}, \forall x \in \mathbb{S}^{n-1}, \tag{5.25}
\end{equation*}
$$

where

$$
\begin{equation*}
\mu_{G, \lambda, k}^{\varepsilon}=\left|\mathbb{S}^{n-1}\right| \int_{-1}^{1-\frac{\varepsilon^{2}}{2}}\left(1-P_{n, k}(t)\right) f_{G, \lambda}(t)\left(1-t^{2}\right)^{\frac{n-3}{2}} \mathrm{~d} t \tag{5.26}
\end{equation*}
$$

and $P_{n, k}$ is given by Theorem 5.12. It is known (see references in the proof of [29, Lemma 6.25]) that

$$
\left|P_{n, k}(t)-1\right| \leqslant \frac{k(k+n-2)}{n-1}(1-t), \quad \forall t \in(-1,1)
$$

thus

$$
\begin{equation*}
\left|\left(1-P_{n, k}(t)\right) f_{G, \lambda}(t)\left(1-t^{2}\right)^{\frac{n-3}{2}}\right| \leqslant \frac{k(k+n-2)}{n-1} f_{G, \lambda}(t)(1+t)^{\frac{n-3}{2}}(1-t)^{\frac{n-1}{2}} \tag{5.27}
\end{equation*}
$$

for all $t \in(-1,1)$. A change of variable gives

$$
\int_{-1}^{1}\left|f_{G, \lambda}(t)\right|(1+t)^{\frac{n-3}{2}}(1-t)^{\frac{n-1}{2}} \mathrm{~d} t=\frac{1}{2} \int_{0}^{2}\left(1-\frac{s^{2}}{4}\right)^{\frac{n-3}{2}} s^{n-2} \eta_{G, 1 / \lambda}(s) \mathrm{d} s
$$

which is finite in view of the integrability of $r \mapsto r^{n} g(r)$ given by (H2), and the extra assumption on $G$ when $n=2$ (still cutting the integral as in Lemma 5.9). Thus the integrand of the integral on the right-hand side of (5.26) belongs to $L^{1}(-1,1)$. Hence, letting $\varepsilon$ go to 0 in (5.26) gives

$$
\lim _{\varepsilon \rightarrow 0} \mu_{G, \lambda, k}^{\varepsilon}=\left|\mathbb{S}^{n-1}\right| \int_{-1}^{1}\left(1-P_{n, k}(t)\right) f_{G, \lambda}(t)\left(1-t^{2}\right)^{\frac{n-3}{2}} \mathrm{~d} t=: \mu_{G, \lambda, k}
$$

Combining this with (5.25), and passing to the limit in (5.24) (with $u=Y_{k}$ ) yields

$$
\mathscr{R}_{G, \lambda}\left(Y_{k}\right)=\mu_{G, \lambda, k} Y_{k},
$$

which shows that spherical harmonics are eigenfunctions of the operator $\mathscr{R}_{G, \lambda}$ in that case too. Step 3. Using the decomposition of $u \in L^{2}\left(\mathbb{S}^{n-1}\right)$ in the orthonormal basis of spherical harmonics given by (5.10), and the spectral representation of $\mathscr{R}_{G, \lambda}$ given the previous step, from (5.16) we deduce

$$
\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)| 2}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}=\sum_{k=0}^{\infty} \sum_{i=1}^{d(k)} \mu_{G, \lambda, k} a_{k}^{i}(u)^{2}
$$

for every $u \in C^{1}\left(\mathbb{S}^{n-1}\right)$, which is precisely (5.20). Taking $u=Y_{k}$ in (5.20) gives (5.21).

### 5.2.3. Stability when $\gamma<\mathbf{1}$.

Theorem 5.14. Assume that $G$ satisfies assumptions (H1) to (H4). If $\gamma<1$, there exists $\lambda_{s}=$ $\lambda_{s}(n, G)$ such that for any $\lambda>\lambda_{s}$ the unit ball $B_{1}$ is a stable critical point of the functional $\mathcal{F}_{\gamma, G_{\lambda}}$.
Proof. Consider any vector field $X \in C_{c}^{\infty}\left(\mathbb{R}^{n} ; \mathbb{R}^{n}\right)$ inducing a volume-preserving flow on $B_{1}$. We can use Proposition 5.5, since $G$ satisfies (H3) and (H4), so that the second variation of $\mathcal{F}_{\gamma, G_{\lambda}}$ at $B_{1}$ is given by

$$
\begin{align*}
& \delta^{2} \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)[X] \\
& =\int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} \zeta_{X}\right|^{2} d \mathscr{H}^{n-1}-\gamma \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{\left|\zeta_{X}(x)-\zeta_{X}(y)\right|^{2}}{|x-y|^{2}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}  \tag{5.28}\\
& \quad-\left(c_{\mathbb{S}^{n-1}}^{2}-\gamma c_{G, \lambda, \mathbb{S}^{n-1}}^{2}\right) \int_{\mathbb{S}^{n-1}} \zeta_{X}^{2} d \mathscr{H}^{n-1} .
\end{align*}
$$

It is well known (see e.g. [26]) that for any $u \in H^{1}\left(\mathbb{S}^{n-1}\right)$, we have

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} u\right|^{2} d \mathscr{H}^{n-1}=\sum_{k=1}^{\infty} \sum_{i=1}^{d(k)} l_{k} a_{k}^{i}(u)^{2}, \tag{5.29}
\end{equation*}
$$

where

$$
l_{k}=k(k+n-2), \quad \forall k \in \mathbb{N}
$$

Since $G$ satisfies (H4), by Proposition 5.10 and Remark 5.11 , the operator $\mathscr{R}_{G, \lambda}$ is well defined on $C^{1}\left(\mathbb{S}^{n-1}\right)$ whenever $\lambda>\lambda_{s}$, for some $\lambda_{s}$ depending only on $G$, and the conclusion of Proposition 5.13 holds as well. Recall that the coordinate functions $x \mapsto x_{i}$ are spherical harmonics of degree 1 , thus inserting these functions into (5.21) and summing over $i$ gives

$$
\begin{align*}
\mu_{G, \lambda, 1} & =\frac{1}{\left|\mathbb{S}^{n-1}\right|} \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}  \tag{5.30}\\
& =\int_{\mathbb{S}^{n-1}} \eta_{G, 1 / \lambda}(|x-y|) d \mathscr{H}_{y}^{n-1}=c_{G, \lambda, \mathbb{S}^{n-1}}^{2} .
\end{align*}
$$

Furthermore, since $X$ induces a volume-preserving flow on $B_{1}$, we have

$$
\int_{\mathbb{S}^{n-1}} \zeta_{X} d \mathscr{H}^{n-1}=0
$$

Writing

$$
\zeta_{X}=\sum_{k=0}^{\infty} \sum_{i=1}^{d(k)} a_{k}^{i}\left(\zeta_{X}\right) Y_{k}^{i}
$$

and using the well-known fact that

$$
\int_{\mathbb{S}^{n-1}} Y_{k} d \mathscr{H}^{n-1}=0
$$

for all spherical harmonic $Y_{k}$ of degree $k>0$, it follows that $a_{0}^{1}\left(\zeta_{X}\right)=0$. Combining this with (5.28) to (5.30), using Proposition 5.13 and recalling $c_{\mathbb{S}^{n-1}}^{2}=n-1=l_{1}$, we find

$$
\begin{align*}
\delta^{2} \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)[X] & =\sum_{k=\mathbf{1}}^{\infty} \sum_{i=1}^{d(k)}\left(l_{k}-l_{1}-\gamma\left(\mu_{G, \lambda, k}-\mu_{G, \lambda, 1}\right)\right) a_{k}^{i}\left(\zeta_{X}\right)^{2}  \tag{5.31}\\
& =\sum_{k=\mathbf{2}}^{\infty} \sum_{i=1}^{d(k)}\left(l_{k}-\gamma \mu_{G, \lambda, k}+\gamma \mu_{G, \lambda, 1}-l_{1}\right) a_{k}^{i}\left(\zeta_{X}\right)^{2}
\end{align*}
$$

We have seen in the proof of Theorem 5.8 that the family $\left(\eta_{G, \varepsilon}\right)_{\varepsilon>0}$ is a $(n-1)$-dimensional approximation of identity (up to multiplication by $\mathbf{K}_{2, n-1}$ ) and that in dimension $n=2$, it satisfies the assumption (T) (which is ensured by (H4)). In particular for every $\lambda>0, \sup _{r>1} \eta_{G, 1 / \lambda}(r)<\infty$, so that we can apply Proposition A. 1 to (5.21) (even in dimension $n=2$ ), which yields

$$
\mu_{G, \lambda, k} \leqslant Q\left(\eta_{G, 1 / \lambda}\right) \int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} Y_{k}\right|^{2} d \mathscr{H}^{n-1}=Q\left(\eta_{G, 1 / \lambda}\right) l_{k}
$$

where $Q\left(\eta_{G, 1 / \lambda}\right)$ is given by (A.4). By Lemma A.2, $Q\left(\eta_{G, \lambda}\right)$ vanishes as $\lambda$ goes to infinity, thus for $\varepsilon>0$ to be fixed later, there exists $\lambda_{s}$ such that, for any $\lambda>\lambda_{s}$, we have

$$
\mu_{G, \lambda, k} \leqslant(1+\varepsilon) l_{k}
$$

whence

$$
\begin{equation*}
l_{k}-\gamma \mu_{G, \lambda, k} \geqslant(1-\gamma(1+\varepsilon)) l_{k} \tag{5.32}
\end{equation*}
$$

As we have seen in the proof of Theorem 5.8 (see (5.8)) we have

$$
\mu_{G, \lambda, 1}=c_{G, \lambda, \mathbb{S}^{n-1}}^{2}=\int_{\mathbb{S}^{n-1}} \eta_{G, 1 / \lambda}(x-y) d \mathscr{H}_{y}^{n-1} \xrightarrow{\lambda \rightarrow \infty} c_{\mathbb{S}^{n-1}}^{2}=l_{1},
$$

thus up to choosing $\lambda_{s}$ even larger if necessary, we have

$$
\begin{equation*}
\mu_{G, \lambda, 1} \geqslant l_{1}(1-\varepsilon), \quad \forall \lambda>\lambda_{s} . \tag{5.33}
\end{equation*}
$$

Combining (5.32) and (5.33), it follows

$$
\begin{equation*}
l_{k}-\gamma \mu_{G, \lambda, k}+\gamma \mu_{G, \lambda, 1}-l_{1} \geqslant(1-\gamma(1+\varepsilon)) l_{k}+(\gamma(1-\varepsilon)-1) l_{1} \tag{5.34}
\end{equation*}
$$

for all $\lambda>\lambda_{s}$, where $\lambda_{s}=(n, \gamma, G, \varepsilon)$. Since $\gamma<1$, we may choose $\varepsilon$ small enough depending only on $n$ and $\gamma$ so that

$$
1-\gamma(1+\varepsilon)>0
$$

thus, noting that $l_{k}$ is bounded from below by $l_{2}>0$ for all $k \geqslant 2$, because $\left(l_{k}\right)_{k \in \mathbb{N}}$ is an increasing sequence, (5.34) yields

$$
\begin{aligned}
l_{k}-\gamma \mu_{G, \lambda, k}+\gamma \mu_{G, \lambda, 1}-l_{1} & \geqslant(1-\gamma(1+\varepsilon)) l_{2}+(\gamma(1-\varepsilon)-1) l_{1} \\
& =(1-\gamma)\left(l_{2}-l_{1}\right)-\gamma\left(l_{1}+l_{2}\right) \varepsilon,
\end{aligned}
$$

whenever $\lambda>\lambda_{s}(n, \gamma, G, \varepsilon)$. Hence, since $\gamma<1$, choosing $\varepsilon$ even smaller if needed, depending only on $n$ and $\gamma$, we have

$$
l_{k}-\gamma \mu_{G, \lambda, k}+\gamma \mu_{G, \lambda, 1}-l_{1}>0
$$

for all $k \geqslant 2$ and every $\lambda>\lambda_{s}$, where $\lambda_{s}=\lambda_{s}(n, \gamma, G)$, hence $\delta^{2} \mathcal{F}_{\gamma, G_{\lambda}}\left(B_{1}\right)[X] \geqslant 0$ in view of (5.31), and the unit ball $B_{1}$ is a volume-constrained stable set for $\mathcal{F}_{\gamma, G_{\lambda}}$.

Let us emphasize that Theorem 5.8 relies heavily on the computation, in Appendix A, of the limit of the quantity

$$
\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta_{\varepsilon}(x-y) \mathrm{d} x \mathrm{~d} y d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}
$$

as $\varepsilon$ goes to 0 , for every $u \in H^{1}\left(\mathbb{S}^{n-1}\right)$ and every $(n-1)$-dimensional approximation of identity $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$, but that this is not enough for proving Theorem 5.14. For the latter, we need to obtain an upper bound for this quantity, and we need this bound to be uniform and asymptotically sharp, in the sense that the multiplicative constant in front of $\left\|\nabla_{\tau} u\right\|_{H^{1}\left(\mathbb{S}^{n-1}\right)}^{2}$ converges to $\mathbf{K}_{2, n-1}$ independently of $u$ as $\varepsilon$ vanishes.

## Appendix A. Asymptotics for nonlocal seminorms on the sphere

In this appendix, we prove Bourgain-Brezis-Mironescu-type results similar to the ones in Propositions 3.1 and 3.8 , in the case where $\mathbb{R}^{n}$ is replaced by the $(n-1)$-dimensional sphere $\partial B_{1}=\mathbb{S}^{n-1}$. In [22] the case of a general Riemannian manifold is considered, yet the monotonicity of the radial kernels is required, which is too strong to be applicable in our case. In addition, it does not provide a satisfying upper bound on the quantity

$$
\begin{equation*}
\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta_{\varepsilon}(x-y) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \tag{A.1}
\end{equation*}
$$

in the sense that we want a bound which is uniform in $u$, and asymptotically sharp as $\varepsilon$ goes to 0 .

The following is the counterpart of Proposition 3.1.
Proposition A.1. Let $\eta:(0,2) \rightarrow[0,+\infty)$ be a nonnegative measurable function such that

\int_{0}^{2} \eta(t) t^{n-2} \mathrm{~d} t<\infty \tag{A.2}
\end{equation*}
$$

When $n=2$ we assume in addition that $|\eta(r)| \leqslant M$ for all $r \in(R, 2)$, for some constants $M>0$ and $R \in(0,2)$. Then for any $u \in H^{1}\left(\mathbb{S}^{n-1}\right)$, we have

$$
\begin{equation*}
\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \leqslant \mathbf{K}_{2, n-1} Q(\eta) \int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} u\right|^{2} d \mathscr{H}^{n-1} \tag{A.3}
\end{equation*}
$$

where

$$
\begin{equation*}
Q(\eta):=\left|\mathbb{S}^{n-2}\right| \int_{0}^{\pi}\left(\frac{\theta}{2}\right)^{2} \frac{(\sin \theta)^{n-2}}{\left(\sin \left(\frac{\theta}{2}\right)\right)^{2}} \eta\left(2 \sin \left(\frac{\theta}{2}\right)\right) \mathrm{d} \theta \tag{A.4}
\end{equation*}
$$

is finite.
Proof. By Fatou's Lemma and density of $C^{1}\left(\mathbb{S}^{n-1}\right)$ in $H^{1}\left(\mathbb{S}^{n-1}\right)$, we may assume that $u \in C^{1}\left(\mathbb{S}^{n-1}\right)$. For $x, y \in \mathbb{S}^{n-1}$, we denote by $\widehat{x y}$ the shortest arc in $\mathbb{S}^{n-1}$ from $x$ to $y$ ( $x$ and $y$ excluded), which is well defined and nonempty whenever $x \neq \pm y$. Note that the set $\left\{(x, y) \in \mathbb{S}^{n-1} \times \mathbb{S}^{n-1}: x \neq \pm y\right\}$ is in fact $\mathscr{H}^{2(n-1)}$-negligible. For $x \neq \pm y$, we parametrize the arc $\widehat{x y}$ by $\gamma_{x, y}:(0,1) \rightarrow \mathbb{S}^{n-1}$ with constant speed $\left|\gamma_{x, y}^{\prime}(t)\right|=\mathscr{H}^{1}(\overparen{x y})$. Integrating, we find

$$
u(y)-u(x)=\mathscr{H}^{1}(\widehat{x y}) \int_{0}^{1} \nabla_{\tau} u\left(\gamma_{x, y}(t)\right) \cdot e_{x, y}(t) \mathrm{d} t,
$$

where $e_{x, y}(t):=\frac{\gamma_{x, y}^{\prime}(t)}{\left|\gamma_{x, y}^{\prime}(t)\right|}$ is the unit tangent vector of the arc $\widehat{x y}$ at $\gamma_{x, y}(t)$. By Cauchy-Schwarz inequality,

$$
|u(y)-u(x)|^{2} \leqslant \mathscr{H}^{1}(\widehat{x y})^{2} \int_{0}^{1}\left|\nabla_{\tau} u\left(\gamma_{x, y}(t)\right) \cdot e_{x, y}(t)\right|^{2} d \mathscr{H}_{\xi}^{1}
$$

Hence, by Fubini's theorem we have

$$
\begin{align*}
I & :=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \\
& \leqslant \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \int_{0}^{1}\left|\nabla_{\tau} u\left(\gamma_{x, y}(t)\right) \cdot e_{x, y}(t)\right|^{2} \frac{\mathscr{H}^{1}(\widehat{x y})^{2}}{|x-y|^{2}} \eta(|x-y|) \mathrm{d} t d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}  \tag{A.5}\\
& =\int_{\mathcal{N}}\left|\nabla_{\tau} u\left(\gamma_{x, y}(t)\right) \cdot e_{x, y}(t)\right|^{2} \frac{\mathscr{H}^{1}(\widehat{x y})^{2}}{|x-y|^{2}} \eta(|x-y|) d \mathscr{H}_{x, y, t}^{2 n-1}=: I I,
\end{align*}
$$

where $\mathcal{N}$ is the smooth $(2 n-1)$-dimensional submanifold of $\mathbb{R}^{2 n+1}$ defined by

$$
\mathcal{N}:=\left\{(x, y, t) \in \mathbb{S}^{n-1} \times \mathbb{S}^{n-1} \times(0,1): x \neq \pm y\right\} .
$$

Now we want to make the proper change of variables. Let us consider the smooth ( $2 n-1$ )-dimensional submanifold

$$
\mathcal{M}:=\left\{(e, f, \theta, \varphi) \in \mathbb{S}^{n-1} \times \mathbb{S}^{n-1} \times(0, \pi) \times(0, \pi): e \cdot f=0 \text { and } \theta+\varphi<\pi\right\} \subseteq \mathbb{R}^{2 n+2}
$$

Now we define the smooth map $\Phi: \mathcal{M} \rightarrow \mathcal{N}$ by

$$
\begin{equation*}
\Phi(e, f, \theta, \varphi)=(x, y, t)=\left((\cos \theta) e-(\sin \theta) f,(\cos \varphi) e+(\sin \varphi) f, \frac{\theta}{\theta+\varphi}\right) \tag{A.6}
\end{equation*}
$$

Note that the map $\Phi$ is one-to-one: given $(x, y, t) \in \mathcal{N}$, defining $e$ by $\gamma_{x, y}(t), f$ by the rotation of $e$ in the plane $\operatorname{Vect}(x, y)$ of angle $\pi / 2$ (where the orientation is given by the arc from $x$ to $y$ ), $\theta$ by the angle between $x$ and $e$, and $\varphi$ by the angle between $y$ and $e$, one gets $(e, f, \theta, \varphi) \in \mathcal{M}$ with $\Phi(e, f, \theta, \varphi)=(x, y, t)$ : see Figure 1 to picture the situation.


Figure 1. The situation of (A.6) in the proof of Proposition A.1. Here $t=\frac{\theta}{\theta+\varphi}$.

Then the change of variables $(x, y, t)=\Phi(e, f, \theta, \varphi)$ gives

$$
\begin{align*}
I I & =\int_{\Phi(\mathcal{M})}\left|\nabla_{\tau} u\left(\gamma_{x, y}(t)\right) \cdot e_{x, y}(t)\right|^{2} d \mathscr{H}_{x, y, t}^{2 n-1} \\
& =\int_{\mathcal{M}}\left|\nabla_{\tau} u(e) \cdot f\right|^{2}\left|\operatorname{det} J_{\Phi}\right| d \mathscr{H}_{e, f, \theta, \varphi}^{2 n-1} \\
& =\iint_{\substack{\theta, \varphi \in(0, \pi) \\
\theta+\varphi<\pi}} \iint_{\substack{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1} \\
e \cdot f=0}}\left|\nabla_{\tau} u(e) \cdot f\right|^{2} \frac{(\theta+\varphi)^{2}}{\left(2 \sin \left(\frac{\theta+\varphi}{2}\right)\right)^{2}} \eta\left(2 \sin \left(\frac{\theta+\varphi}{2}\right)\right)\left|\operatorname{det} J_{\Phi}\right| d \mathscr{H}_{(e, f)}^{2 n-3} \mathrm{~d} \theta \mathrm{~d} \varphi, \tag{A.7}
\end{align*}
$$

where we have used the facts that $e_{x, y}(t)=f, \mathscr{H}^{1}(\overparen{x y})=\theta+\varphi$ and

$$
|x-y|=\sqrt{2(1-\cos (\theta+\varphi))}=2 \sin \left(\frac{\theta+\varphi}{2}\right)
$$

Here $J_{\Phi}$ denotes the matrix of the differential $D \Phi: \operatorname{Tan}_{\mathcal{M}}(e, f, \theta, \varphi) \rightarrow \operatorname{Tan}_{\mathcal{N}} \Phi(e, f, \theta, \varphi)$ in orthonormal bases of the tangent spaces. After computations that we detail further below, we get

$$
\begin{equation*}
\left|\operatorname{det} J_{\Phi}\right|=\frac{(\sin (\theta+\varphi))^{n-2}}{\sqrt{2}(\theta+\varphi)} \tag{A.8}
\end{equation*}
$$

Hence, (A.7) yields

$$
\begin{gather*}
I I=\iint_{\substack{\theta, \varphi \in(0, \pi) \\
\theta+\varphi<\pi}} \frac{(\theta+\varphi)(\sin (\theta+\varphi))^{n-2}}{\left(2 \sin \left(\frac{\theta+\varphi}{2}\right)\right)^{2}} \eta\left(2 \sin \left(\frac{\theta+\varphi}{2}\right)\right) \mathrm{d} \theta \mathrm{~d} \varphi \\
\times \frac{1}{\sqrt{2}} \int_{\substack{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1} \\
e \cdot f=0}}\left|\nabla_{\tau} u(e) \cdot f\right|^{2} d \mathscr{H}_{e, f}^{2 n-3} . \tag{A.9}
\end{gather*}
$$

Now, on one hand, the Jacobian determinant of the map $F: \mathbb{S}^{n-1} \times \mathbb{S}^{n-1} \rightarrow \mathbb{R}$ given by $F(e, f)=e \cdot f$ is $\left|\operatorname{det} J_{F}(e, f)\right|=\sqrt{\left|P_{e}(f)\right|^{2}+\left|P_{f}(e)\right|^{2}}=\sqrt{2}|1-e \cdot f|$, where $P_{e}(f)$ and $P_{f}(e)$ denote respectively the projection of $f$ on $\operatorname{Tan}_{\mathbb{S}^{n-1}}(e)$ and the projection of $e$ on $\operatorname{Tan}_{\mathbb{S}^{n-1}}(f)$. On the other hand, for every $e \in \mathbb{S}^{n-1}$, the Jacobian determinant of the map $G_{e}: \mathbb{S}^{n-1} \rightarrow \mathbb{R}$ given by $G_{e}(f)=e \cdot f$ is $\left|\operatorname{det} J_{G_{e}}(f)\right|=\left|P_{e}(f)\right|=|1-e \cdot f|$, hence

$$
\begin{equation*}
\int_{\substack{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1} \\ e \cdot f=0}}\left|\nabla_{\tau} u(e) \cdot f\right|^{2} d \mathscr{H}_{e, f}^{2 n-3}=\sqrt{2} \int_{\mathbb{S}^{n-1}}\left(\int_{\mathbb{S}^{n-1} \cap\{e\}^{\perp}}\left|\nabla_{\tau} u(e) \cdot f\right|^{2} d \mathscr{H}_{f}^{n-2}\right) d \mathscr{H}_{e}^{n-1} \tag{A.10}
\end{equation*}
$$

In addition, by definition of $\mathbf{K}_{2, n-1}$, we have

$$
\begin{equation*}
\int_{\mathbb{S}^{n-1} \cap\{e\}^{\perp}}\left|\nabla_{\tau} u(e) \cdot f\right|^{2} d \mathscr{H}_{f}^{n-2}=\mathbf{K}_{2, n-1}\left|\mathbb { S } ^ { n - 2 } \left\|\left.\nabla_{e^{\perp}} u(e)\right|^{2} \leqslant \mathbf{K}_{2, n-1}\left|\mathbb{S}^{n-2} \| \nabla_{\tau} u(e)\right|^{2}\right.\right. \tag{A.11}
\end{equation*}
$$

where $\nabla_{e^{\perp}} u(e)$ denotes the projection of $\nabla_{\tau} u(e)$ on $\{e\}^{\perp}$. Finally, changing variables, we compute

$$
\begin{equation*}
\iint_{\substack{\theta, \varphi \in(0, \pi) \\ \theta+\varphi<\pi}} \frac{(\theta+\varphi)(\sin (\theta+\varphi))^{\frac{n-2}{2}}}{\left(2 \sin \left(\frac{\theta+\varphi}{2}\right)\right)^{2}} \eta\left(2 \sin \left(\frac{\theta+\varphi}{2}\right)\right) \mathrm{d} \theta \mathrm{~d} \varphi=\int_{0}^{\pi} \frac{t^{2}(\sin (t))^{n-2}}{(2 \sin (t / 2))^{2}} \eta(2 \sin (t / 2)) \mathrm{d} t \tag{A.12}
\end{equation*}
$$

Whence, plugging (A.10) to (A.12) into (A.9) gives

$$
\begin{equation*}
I I=\mathbf{K}_{2, n-1} Q(\eta) \int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} u\right|^{2} d \mathscr{H}^{n-1} \tag{A.13}
\end{equation*}
$$

which implies (A.3), in view of (A.5). Now let us justify that $Q(\eta)$ is finite. A further change of variables gives

$$
\begin{equation*}
Q(\eta)=\int_{0}^{2}\left(\frac{2}{t} \arcsin \left(\frac{t}{2}\right)\right)^{2}\left(1-\frac{t^{2}}{4}\right)^{\frac{n-3}{2}} t^{n-2} \eta(t) \mathrm{d} t \tag{A.14}
\end{equation*}
$$

When $n \geqslant 3$, for any $t \in(0,2)$, we have $\left(1-\frac{t^{2}}{4}\right)^{\frac{n-3}{2}} \leqslant 1$, and the function $t \mapsto \frac{1}{t} \arcsin t$ is continuous, so by (A.2) we see that $Q(\eta)$ is finite. When $n=2$, we use the fact that $\eta(r) \leqslant M$ for every $t \in(R,+\infty)$, and we cut the integral into two parts, so that

$$
Q(\eta) \leqslant C_{R} \int_{0}^{R} t^{n-2} \eta(t) \mathrm{d} t+C_{R} M<\infty
$$

where $C_{R}$ is a constant depending only on $R$. There only remains to show (A.8) to conclude the proof, which is sketched separately just below, for the sake of completeness.

Proof of Proposition A.1, continued: Computation of $\left|\operatorname{det} J_{\Phi}\right|$. For simplicity, we assume that $n=3$. It will be made clear what happens when $n=2$ and in higher dimension. Let us first give an orthormal basis of $\operatorname{Tan}_{\mathcal{M}}(e, f, \theta, \varphi)$. Considering the curve $\gamma(t)=(e(t), f(t), \theta, \varphi) \in \mathcal{M}$ such that $\gamma(0)=(e, f, \theta, \varphi)$ and $\gamma^{\prime}(0)=(\sigma, \tau, 0,0)$, the condition $e(t) \cdot f(t)=0$ implies that $\sigma \cdot f+\tau \cdot e=0$, hence $(f,-e, 0,0)$ belongs to $\operatorname{Tan}_{\mathcal{M}}(e, f, \theta, \varphi)$. One sees then easily that an orthonormal basis of $\operatorname{Tan}_{\mathcal{M}}(e, f, \theta, \varphi)$ is given by

$$
\begin{align*}
u_{0}:=\frac{1}{\sqrt{2}}(f,-e, 0,0), \quad u_{1}:=(0,0,1,0), \quad u_{2}:=(0,0,0,1)  \tag{A.15}\\
u_{3}:=(e \wedge f, 0,0,0), \quad u_{4}:=(0, e \wedge f, 0,0),
\end{align*}
$$

where $e \wedge f$ is the cross product of the vectors $e$ and $f$. As for $\operatorname{Tan}_{\mathcal{N}}(x, y, t)$, let us denote by $x^{\perp}$ and $y^{\perp}$ respectively the rotations of $x$ and $y$ of angle $\pi / 2$ in the plane $\operatorname{Vect}(x, y)$, where the orientation is given by $(x, y, x \wedge y)$. Then it is easy to see that $\left(x^{\perp}, 0,0\right)$ and $\left(0, y^{\perp}, 0\right)$ belong to $\operatorname{Tan}_{\mathcal{N}}(x, y, t)$, and so do $(x \wedge y, 0,0),(0, x \wedge y, 0)$ and $(0,0,1)$, hence an orthonormal basis is

$$
\begin{align*}
& v_{0}:=\left(x^{\perp}, 0,0\right), \quad v_{1}:=\left(0, y^{\perp}, 0\right), \quad v_{2}:=(0,0,1) \\
& \quad v_{3}:=\frac{1}{|x \wedge y|}(x \wedge y, 0,0)=(e \wedge f, 0,0), \quad u_{4}:=\frac{1}{|x \wedge y|}(0, x \wedge y, 0)=(0, e \wedge f, 0), \tag{A.16}
\end{align*}
$$

where we used the fact that $\frac{x \wedge y}{|x \wedge y|}=e \wedge f$. Here, since we are in dimension $n=3$, there is only one orthogonal direction to the plane $\operatorname{Vect}(e, f)$. In higher dimension, the cross products appearing in the bases can just be replaced by an orthonormal basis of $\operatorname{Vect}(e, f)^{\perp}$, which is a $(n-2)$-dimensional vector space. Straightforward computations give that the matrix of $D \Phi$ at $(e, f, \theta, \varphi)$ in theses bases is

$$
J_{\Phi}=\left(\begin{array}{ccccc}
\frac{1}{\sqrt{2}} & -1 & 0 & 0 & 0 \\
\frac{1}{\sqrt{2}} & 0 & 1 & 0 & 0 \\
0 & \frac{\varphi}{(\theta+\varphi)^{2}} & \frac{-\theta}{(\theta+\varphi)^{2}} & 0 & 0 \\
0 & 0 & 0 & \cos \theta & -\sin \theta \\
0 & 0 & 0 & \cos \varphi & \sin \varphi,
\end{array}\right)
$$

whose determinant is $\frac{\sin (\theta+\varphi)}{\sqrt{2}(\theta+\varphi)}$. In dimension $n=2$, there is no orthogonal direction to $\operatorname{Vect}(e, f)$, so there is no block with sine and cosine functions, while for $n>3$, there are $(n-2)$ orthogonal directions, hence ( $n-2$ ) such blocks, which gives (A.8).

Lemma A.2. Let $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$ be a $(n-1)$-dimensional approximation of identity. In dimension $n=2$, assume in addition that it satisfies

$$
\begin{equation*}
\sup _{r>R} \eta_{\varepsilon}(r) \xrightarrow{\varepsilon \rightarrow 0} 0, \quad \forall R \in(0,2) \tag{T}
\end{equation*}
$$

Then

$$
Q\left(\eta_{\varepsilon}\right) \xrightarrow{\varepsilon \rightarrow 0} 1,
$$

where $Q\left(\eta_{\varepsilon}\right)$ is defined by (A.4).
Proof. Let $\delta>0$, and then let $\theta_{0}>0$ small to be chosen later. Let us split the outer integral defining $Q\left(\eta_{\varepsilon}\right)$ into the two parts $\theta<\theta_{0}$ and $\theta>\theta_{0}$. The integrand is always nonnegative, and for the integral on ( $0, \theta_{0}$ ), by changing variables as in (A.14), we have

$$
\begin{equation*}
\int_{0}^{\theta_{0}} \frac{\theta^{2}(\sin \theta)^{n}}{\left(2 \sin \left(\frac{\theta}{2}\right)\right)^{2}} \eta_{\varepsilon}\left(2 \sin \left(\frac{\theta}{2}\right)\right) \mathrm{d} \theta=\int_{0}^{2 \sin \left(\frac{\theta_{0}}{2}\right)}\left(\frac{2}{t} \arcsin \left(\frac{t}{2}\right)\right)^{2}\left(1-\frac{t^{2}}{2}\right)^{\frac{n-3}{2}} t^{n-2} \eta_{\varepsilon}(t) \mathrm{d} t \tag{A.17}
\end{equation*}
$$

Since

$$
t \mapsto\left(\frac{2}{t} \arcsin \left(\frac{t}{2}\right)\right)^{2}\left(1-\frac{t^{2}}{2}\right)^{\frac{n-3}{2}}
$$

converges to 1 as $t$ vanishes, we may choose $\theta_{0}$ small enough such that

$$
\begin{equation*}
\left|\int_{0}^{2 \sin \left(\frac{\theta_{0}}{2}\right)}\left(\frac{2}{t} \arcsin \left(\frac{t}{2}\right)\right)^{2}\left(1-\frac{t^{2}}{2}\right)^{\frac{n-3}{2}} t^{n-2} \eta_{\varepsilon}(t) \mathrm{d} t-\int_{0}^{2 \sin \left(\frac{\theta_{0}}{2}\right)} t^{n-2} \eta_{\varepsilon}(t) \mathrm{d} t\right| \leqslant \delta \tag{A.18}
\end{equation*}
$$

for every $\varepsilon>0$. Now since $\left(\delta_{\varepsilon}\right)_{\varepsilon>0}$ is a $(n-1)$-dimensional approximation of identity, we also have

$$
\begin{equation*}
\int_{0}^{\infty} t^{n-2} \eta_{\varepsilon}(t) \mathrm{d} t=1, \quad \text { and } \quad \int_{2 \sin \left(\frac{\theta_{0}}{2}\right)}^{\infty} t^{n-2} \eta_{\varepsilon}(t) \mathrm{d} t \xrightarrow{\varepsilon \rightarrow 0} 0 \tag{A.19}
\end{equation*}
$$

Thus, by (A.17) to (A.19), we have

$$
\begin{equation*}
\left|\int_{0}^{\theta_{0}} \frac{\theta^{2}(\sin \theta)^{n}}{\left(2 \sin \left(\frac{\theta}{2}\right)\right)^{2}} \eta_{\varepsilon}\left(2 \sin \left(\frac{\theta}{2}\right)\right) \mathrm{d} \theta-1\right| \leqslant 2 \delta \tag{A.20}
\end{equation*}
$$

for our choice of $\theta_{0}$, and any $\varepsilon$ large enough. Now let us focus on the integral on $\left(\theta_{0}, \pi\right)$, and distinguish the cases $n=2$ and $n \geqslant 3$. When $n=2$, we have

$$
\begin{align*}
\int_{\theta_{0}}^{\pi} \frac{\theta^{2}(\sin \theta)^{n}}{\left(2 \sin \left(\frac{\theta}{2}\right)\right)^{2}} \eta_{\varepsilon}\left(2 \sin \left(\frac{\theta}{2}\right)\right) \mathrm{d} \theta & \leqslant C\left[\sup _{\theta \in\left(\theta_{0}, \pi\right)} \eta_{\varepsilon}\left(2 \sin \left(\frac{\theta}{2}\right)\right)\right]  \tag{A.21}\\
& \leqslant C\left(\sup _{r>\delta_{0}} \eta_{\varepsilon}(r)\right) \xrightarrow{\varepsilon \rightarrow 0} 0
\end{align*}
$$

for some $C=C\left(n, \theta_{0}\right)$, where $\delta_{0}:=2 \arcsin \left(\frac{\theta_{0}}{2}\right)$, and where we used the fact that $\sin (\theta / 2)$ is bounded from below and decreasing on $\theta \in\left(\theta_{0}, \pi\right)$, as well as assumption $(\mathrm{T})$. When $n \geqslant 3$, a change of variable gives

$$
\begin{align*}
\int_{\theta_{0}}^{\pi} \frac{\theta^{2}(\sin \theta)^{n}}{\left(2 \sin \left(\frac{\theta}{2}\right)\right)^{2}} \eta_{\varepsilon}\left(2 \sin \left(\frac{\theta}{2}\right)\right) \mathrm{d} \theta & =\int_{2 \sin \left(\frac{\theta_{0}}{2}\right)}^{2}\left(\frac{2}{t} \arcsin \left(\frac{t}{2}\right)\right)^{2}\left(1-\frac{t^{2}}{4}\right)^{\frac{n-3}{2}} t^{n-2} \eta_{\varepsilon}(t) \mathrm{d} t  \tag{A.22}\\
& \leqslant C \int_{2 \sin \left(\frac{\theta_{0}}{2}\right)}^{2} t^{n-2} \eta(t) \mathrm{d} t \xrightarrow{\varepsilon \rightarrow 0} 0
\end{align*}
$$

since $\left(1-\frac{t^{2}}{4}\right)^{\frac{n-3}{2}} \leqslant 1$ in $(0,2)$ and $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$ is a $(n-1)$-dimensional approximation of identity. The result follows by gathering both cases (A.21) and (A.22), in view of (A.20) and the arbitrariness of $\delta$.

Corollary A.3. Let $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$ be a $(n-1)$-dimensional approximation of identity, and in dimension $n=2$, assume that it satisfies in addition assumption (T). Then there exists $\varepsilon_{0}>0$ such that the maps $N_{\varepsilon}: H^{1}\left(\mathbb{S}^{n-1}\right) \rightarrow[0,+\infty)$ defined by

$$
N_{\varepsilon}(u):=\left(\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta_{\varepsilon}(|x-y|) \mathrm{d} x \mathrm{~d} y\right)^{\frac{1}{2}}
$$

for any $0<\varepsilon<\varepsilon_{0}$, are uniformly equicontinuous.
Proof. In dimension 2, since the family $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$ satisfies (T), we have in particular

$$
\sup _{r>1} \eta_{\varepsilon}(r)<\infty .
$$

Thus, by Proposition A. 1 and the reverse triangle inequality, we have

$$
\left|N_{\varepsilon}(g)-N_{\varepsilon}(h)\right| \leqslant N_{\varepsilon}(g-h) \leqslant\left(\mathbf{K}_{2, n-1} Q\left(\eta_{\varepsilon}\right)\right)^{\frac{1}{2}}\|g-h\|_{H^{1}\left(\mathbb{S}^{n-1}\right)}
$$

for all $g, h \in H^{1}\left(\mathbb{S}^{n-1}\right)$. Then by Lemma A. $2,\left(Q_{\varepsilon}\right)_{k \in \mathbb{N}}$ vanishes as $\varepsilon$ goes to 0 , whence the uniform equicontinuity of the maps $N_{\varepsilon}$ when $\varepsilon<\varepsilon_{0}$, for some positive $\varepsilon_{0}$.

We can now compute the limit of (A.1), which is a counterpart of Proposition 3.8 for the sphere.
Proposition A.4. Let $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$ be a $(n-1)$-dimensional approximation ou identity. In dimension $n=2$, assume that in addition, it satisfies $(\mathrm{T})$. Then for any $u \in H^{1}\left(\mathbb{S}^{n-1}\right)$, we have

$$
\lim _{\varepsilon \rightarrow 0} \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta_{\varepsilon}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}=\mathbf{K}_{2, n-1} \int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} u\right|^{2} d \mathscr{H}^{n-1}
$$

Proof. Let $u \in H^{1}\left(\mathbb{S}^{n-1}\right)$. Since $C^{1}\left(\mathbb{S}^{n-1}\right)$ is dense in $H^{1}\left(\mathbb{S}^{n-1}\right)$ and, by Corollary A.3, the functions $N_{\varepsilon}$ are equicontinuous whenever $\varepsilon<\varepsilon_{0}$ for some positive $\varepsilon_{0}$, we shall assume without loss of generality that $u \in C^{1}\left(\mathbb{S}^{n-1}\right)$. Let us define the quantities

$$
I(\eta):=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}
$$

and

$$
I I(\eta):=\mathbf{K}_{2, n-1} Q(\eta) \int_{\mathbb{S}^{n-1}}\left|\nabla_{\tau} u\right|^{2} d \mathscr{H}^{n-1}
$$

whenever $\eta$ satisfies the assumptions of Proposition A.1. The aim is then to show

$$
\begin{equation*}
E\left(\eta_{\varepsilon}\right):=I\left(\eta_{\varepsilon}\right)-I I\left(\eta_{\varepsilon}\right) \xrightarrow{\varepsilon \rightarrow 0} 0 . \tag{A.23}
\end{equation*}
$$

Let us cut $\eta_{\varepsilon}$ into two parts: one for the contribution close to the origin $\eta_{\varepsilon}^{c}:=\eta_{\varepsilon} \mathbf{1}_{(0, r)}$, and one for the contribution far from the origin $\eta_{\varepsilon}^{f}:=\eta_{\varepsilon} \mathbf{1}_{(R, \infty)}$, for some small $r \in(0,2)$ to be chosen later. Note that

$$
I\left(\eta_{\varepsilon}\right)=I\left(\eta_{\varepsilon}^{c}\right)+I\left(\eta_{\varepsilon}^{f}\right), \quad \text { and } \quad I I\left(\eta_{\varepsilon}\right)=I I\left(\eta_{\varepsilon}^{c}\right)+I I\left(\eta_{\varepsilon}^{f}\right)
$$

One the one hand, for any $x \in \mathbb{S}^{n-1}$, we have

$$
I\left(\eta_{\varepsilon}^{f}\right) \leqslant C_{r}\|u\|_{\infty, \mathbb{S}^{n-1}}^{2} \int_{\mathbb{S}^{n-1}} \eta_{\varepsilon}^{f}(|x-y|) d \mathscr{H}_{y}^{n-1}=C_{r}\|u\|_{\infty, \mathbb{S}^{n-1}}^{2} \int_{r}^{2}\left(1-\frac{t^{2}}{4}\right)^{\frac{n-3}{2}} t^{n-2} \eta_{\varepsilon}(t) \mathrm{d} t
$$

where we used Lemma 5.9 for the last equality. When $n \geqslant 3$, this immediately implies

$$
I\left(\eta_{\varepsilon}^{f}\right) \leqslant C_{r}\|u\|_{\infty, \mathbb{S}^{n-1}}^{2} \int_{r}^{2} \eta_{\varepsilon}(t) \mathrm{d} t \xrightarrow{\varepsilon \rightarrow 0} 0
$$

since $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$ is a $(n-1)$-dimensional approximation of identity. When $n=2$, we split the integral into two parts and use ( T ) to obtain

$$
I\left(\eta_{\varepsilon}^{f}\right) \leqslant C_{r, u}\left[\int_{r}^{1} \eta_{\varepsilon}(t) \mathrm{d} t+\left(\sup _{r>1} \eta_{\varepsilon}(r)\right)\right] \xrightarrow{\varepsilon \rightarrow 0} 0
$$

Thus, in both cases, one has

$$
I\left(\eta_{\varepsilon}^{f}\right) \xrightarrow{\varepsilon \rightarrow 0} 0 .
$$

On the other hand, by Lemma A.2, we have

$$
I I\left(\eta_{\varepsilon}^{f}\right) \xrightarrow{\varepsilon \rightarrow 0} 0 .
$$

Hence (A.23) amounts to showing that for any $\delta_{0}>0$, we may find $r$ small enough so that

$$
\begin{equation*}
E\left(\eta_{\varepsilon}^{c}\right)=I\left(\eta_{\varepsilon}^{c}\right)-I I\left(\eta_{\varepsilon}^{c}\right) \leqslant \delta_{0}, \quad \forall \varepsilon>0 \tag{A.24}
\end{equation*}
$$

Now, by the proof of Proposition A. 1 (in particular (A.5) and (A.13), with $\eta=\eta_{\varepsilon}^{c}$ ), we have

$$
I I\left(\eta_{\varepsilon}^{c}\right)=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}}\left(\int_{0}^{1} \left\lvert\, \nabla_{\tau} u\left(\left.\gamma_{x, y}(t)\right|^{2} \mathrm{~d} t\right) \frac{\mathscr{H}^{1}(\widehat{x y})^{2}}{|x-y|^{2}} \eta_{\varepsilon}^{c}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}\right.\right.
$$

so that, using the identity

$$
\left(\int_{0}^{1} f(t) \mathrm{d} t\right)^{2}-\int_{0}^{1} f(t)^{2} \mathrm{~d} t=-\frac{1}{2} \int_{0}^{1}(f(t)-f(s))^{2} \mathrm{~d} t \mathrm{~d} s
$$

with $f(t):=\nabla_{\tau} u\left(\gamma_{x, y}(t)\right) \cdot e_{x, y}(t)$, we find

$$
\begin{align*}
& I\left(\eta_{\varepsilon}^{c}\right)-I I\left(\eta_{\varepsilon}^{c}\right) \\
& =-\frac{1}{2} \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}}\left(\int_{0}^{1} \int_{0}^{1}\left|\nabla_{\tau} u\left(\gamma_{x, y}(t)\right) \cdot e_{x, y}(t)-\nabla_{\tau} u\left(\gamma_{x, y}(s)\right) \cdot e_{x, y}(s)\right|^{2} \mathrm{~d} t \mathrm{~d} s\right)  \tag{A.25}\\
& \frac{\mathscr{H}^{1}(\widehat{x y})^{2}}{|x-y|^{2}} \eta_{\varepsilon}^{c}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}
\end{align*}
$$

Notice that the integrand in (A.25) vanishes when $|x-y|>r$. Recall that $u \in C^{1}\left(\mathbb{S}^{n-1}\right)$ and that $e_{x, y}(t)$ is the unit tangent vector of $\mathbb{S}^{n-1}$ at $\gamma_{x, y}(t)$. Thus, given any small $\delta>0$, we may choose $r$ small enough so that

$$
\left|e_{x, y}(t)-e_{x, y}(s)\right|\left\|\nabla_{\tau} u\right\|_{\infty, \mathbb{S}^{n-1}} \leqslant \delta
$$

and also, by uniform continuity of $\nabla_{\tau} u$ on $\mathbb{S}^{n-1}$, so that

$$
\left|\nabla_{\tau} u\left(\gamma_{x, y}(t)\right)-\nabla_{\tau} u\left(\gamma_{x, y}(s)\right)\right| \leqslant \delta
$$

for every $x, y \in \mathbb{S}^{n-1}$ s.t. $|x-y|<r$ and every $s, t \in(0,1)$. Hence, using the squared triangle inequality, (A.25) yields

$$
\left|I\left(\eta_{\varepsilon}^{c}\right)-I I\left(\eta_{\varepsilon}^{c}\right)\right| \leqslant \delta^{2} \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{\mathscr{H}^{1}(\widehat{x y})^{2}}{|x-y|^{2}} \eta_{\varepsilon}^{c}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}
$$

Then up to choosing $r$ even smaller if needed, we may assume

$$
\mathscr{H}^{1}(\widehat{x y}) \leqslant 2|x-y|,
$$

which gives

$$
\begin{equation*}
\left|I\left(\eta_{\varepsilon}^{c}\right)-I I\left(\eta_{\varepsilon}^{c}\right)\right| \leqslant 4 \delta^{2}\left|\mathbb{S}^{n-1}\right| \int_{\mathbb{S}^{n-1}} \eta_{\varepsilon}^{c}(|x-e|) d \mathscr{H}_{x}^{n-1} \tag{A.26}
\end{equation*}
$$

for any $e \in \mathbb{S}^{n-1}$. Finally, a change of variables shows that the integral of the right-hand side of (A.26) is always finite and uniformly bounded (even in dimension $n=2$, since $r<2$ ). Hence, by arbitrariness of $\delta,(\mathrm{A} .24)$ holds, which concludes the proof.

Note that Lemma A. 2 and Proposition A. 4 justify that the upper bound given in Proposition A. 1 is in some sense asymptotically sharp.

Remark A.5. Let us point out that as a consequence of Proposition A.4, we recover the well-known convergence of the Gagliardo-Sobolev $H^{s}$ seminorm to the $H^{1}$ seminorm on the sphere as $s$ goes to 1 (see e.g. [12, (8.4)]), that is,

$$
(1-s)[u]_{H^{s}\left(\mathbb{S}^{n-1}\right)}^{2} \xrightarrow{s \uparrow 1} \frac{\omega_{n-1}}{2}\left\|\nabla_{\tau} u\right\|_{L^{2}\left(\mathbb{S}^{n-1}\right)}^{2}, \quad \forall u \in H^{1}\left(\mathbb{S}^{n-1}\right)
$$

where

$$
[u]_{H^{s}\left(\mathbb{S}^{n-1}\right)}^{2}=\iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{n-1+2 s}} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1}
$$

Indeed, we have

$$
\begin{aligned}
\lim _{s \uparrow 1^{-}} & (1-s)[u]_{H^{s}\left(\mathbb{S}^{n-1}\right)}^{2} \\
& =\lim _{\varepsilon \downarrow 0} \frac{\varepsilon}{2}[u]_{H^{1-\frac{\varepsilon}{2}}}^{2}\left(\mathbb{S}^{n-1}\right) \\
& =\lim _{\varepsilon \downarrow 0} \frac{\varepsilon}{2} \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{n+1-\varepsilon}} d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \\
& =\lim _{\varepsilon \downarrow 0} 2^{\varepsilon-1}\left|\mathbb{S}^{n-2}\right| \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta_{\varepsilon}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1},
\end{aligned}
$$

where $\eta_{\varepsilon}:[0,+\infty) \rightarrow[0,+\infty)$ is defined by

$$
\eta_{\varepsilon}(r):=\frac{\varepsilon}{2^{\varepsilon} r^{n-1-\varepsilon}\left|\mathbb{S}^{n-2}\right|} \mathbf{1}_{[0,2]}(r) .
$$

We readily check that $\left(\eta_{\varepsilon}\right)_{\varepsilon>0}$ is a $(n-1)$-dimensional approximation of identity which satisfies (T), thus

$$
\begin{aligned}
& \lim _{\varepsilon \downarrow 0} 2^{\varepsilon-1}\left|\mathbb{S}^{n-2}\right| \iint_{\mathbb{S}^{n-1} \times \mathbb{S}^{n-1}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{2}} \eta_{\varepsilon}(|x-y|) d \mathscr{H}_{x}^{n-1} d \mathscr{H}_{y}^{n-1} \\
& \quad=\frac{\mathbf{K}_{2, n-1}\left|\mathbb{S}^{n-2}\right|}{2}\left\|\nabla_{\tau} u\right\|_{L^{2}\left(\mathbb{S}^{n-1}\right)}^{2} \\
& \quad=\frac{\omega_{n-1}}{2}\left\|\nabla_{\tau} u\right\|_{L^{2}\left(\mathbb{S}^{n-1}\right)}^{2},
\end{aligned}
$$

where we used Lemma 3.13 for the last equality.
