Harmonic vibrational analysis using DFT/M06-2X is performed to the lowest-energy structure and the spectra are drawn in Figure S1. The calculated frequencies have been scaled by a factor of 0.949.<sup>1</sup> In Figure S1, the strong IR peak at 1759 cm<sup>-1</sup> is readily assigned to the carbonyl group, which is in agreement with the typical C=O vibrational frequency in between 1760 and 1668 cm<sup>-1</sup> found in organic compounds,<sup>2-4</sup> and reasonably close to the experimental result<sup>5</sup> of 1735 cm<sup>-1</sup> obtained from melting dimeric forms as well as from an other *ab initio* work.<sup>6</sup> The latter agrees remarkably well with the slightly lower dimer frequencies.<sup>7</sup> Two C-O bonds stretching locate at 1081 and 1090 cm<sup>-1</sup>. The C1-H7 and C2-H10 stretching modes have the vibrational frequency of 2841 and 2857 cm<sup>-1</sup>. The IR bands at 1435, 2990 and 2958 cm<sup>-1</sup> are assigned to the bending of H11-C3-H12 angle, the symmetric and asymmetric stretches of the two C-H bonds, respectively.
