# UNITARY SKEW-DILATIONS OF HILBERT SPACE OPERATORS 

VIDAL AGNIEL


#### Abstract

The aim of this paper is to study, for a given sequence $\left(\rho_{n}\right)_{n \geq 1}$ of complex numbers, the class of Hilbert space operators possessing $\left(\rho_{n}\right)$-unitary dilations. This is the class of bounded linear operators $T$ acting on a Hilbert space $H$, whose iterates $T^{n}$ can be represented as $T^{n}=\left.\rho_{n} P_{H} U^{n}\right|_{H}, n \geq 1$, for some unitary operator $U$ acting on a larger Hilbert space, containing $H$ as a closed subspace. Here $P_{H}$ is the projection from this larger space onto $H$. The case when all $\rho_{n}$ 's are equal to a positive real number $\rho$ leads to the class $C_{\rho}$ introduced in the 1960s by Foias and Sz.-Nagy, while the case when all $\rho_{n}$ 's are positive real numbers has been previously considered by several authors. Some applications and examples of operators possessing ( $\rho_{n}$ )-unitary dilations, showing a behavior different from the classical case, are given in this paper.


## 1. Introduction

Classes $C_{\rho}$ have been introduced by B. Sz-Nagy and C. Foias [22] in 1966. For a complex Hilbert space $H$ and a real number $\rho>0$, a bounded linear operator $T \in \mathcal{L}(H)$ is said to be in the class $C_{\rho}(H)$ if all powers of $T$ can be skew-dilated to powers of a unitary operator on a Hilbert space $K$, containing $H$ as a closed subspace. This means that

$$
T^{n}=\left.\rho P_{H} U^{n}\right|_{H}, \text { for all } n \geq 1
$$

where $U \in \mathcal{L}(K)$ is a suitable unitary operator, and $P_{H} \in \mathcal{L}(K)$ denotes the orthogonal projection onto $H$. Such an operator $T$ is called a $\rho$-contraction, while the unitary operator $U$ is called a $\rho$-dilation, or a $\rho$-unitary dilation, of $T$.

The famous Sz.-Nagy dilation theorem (see [22]) shows that $C_{1}(H)$ is exactly the class of all Hilbert space contractions i.e., operators of norm no greater than one. It is also known (see [6]) that the class $C_{2}(H)$ coincides with the class of all operators $T$ with numerical range $W(T)$ included in the closed unit disk; equivalently, those $T$ satisfying $w(T) \leq 1$. Here the numerical range $W(T)$ and the numerical radius $w(T)$ of $T$ are defined by

$$
W(T)=\{\langle T x, x\rangle:\|x\|=1\} \quad ; \quad w(T)=\sup \{|\lambda|: \lambda \in W(T)\} .
$$

Let $T$ be an operator in the class $C_{\rho}$. Then
(i) $T$ is power-bounded. More precisely, we have $\left\|T^{n}\right\| \leq \max (1, \rho)$, for all $n \geq 0$. In particular, the spectral radius $r(T)$ of $T$ satisfies $r(T) \leq 1$;
(ii) $T^{k}$ is in $C_{\rho}(H)$ for every $k \geq 1$;
(iii) For a closed subspace, $F$, of $H$ which is stable by $T$ (i.e., $T(F) \subset F$ ), the restriction $\left.T\right|_{F}$ is in $C_{\rho}(F)$;
(iv) The functional calculus map $f \mapsto f(T)$ that sends a polynomial $f$ into $f(T)$ can be extended in a well-defined manner to the disk algebra $\mathbb{A}(\mathbb{D}):=C^{0}(\overline{\mathbb{D}}) \cap \operatorname{Hol}(\mathbb{D})$. It is a morphism of Banach algebras, and satisfies

$$
\|f(T)\| \leq \max (1, \rho)\|f\|_{L^{\infty}(\mathbb{D})} ;
$$

(v) $T$ is similar to a contraction: there is an invertible operator $L \in \mathcal{L}(H)$ such that $\left\|L T L^{-1}\right\| \leq 1$.

We refer the reader to $[11,12,15,17,23]$ for proofs of these results, which mainly use several characterizations of classes $C_{\rho}(H)$. We record the principal ones in the following theorem.

Theorem. - Let $T$ be an operator in $\mathcal{L}(H)$ and let $\rho>0$. The following are equivalent:
(i) $T \in C_{\rho}(H)$;
(ii) $r(T) \leq 1$ and, for all $z \in \mathbb{D}$, we have $\left(1-\frac{2}{\rho}\right) I+\frac{2}{\rho} \operatorname{Re}\left((I-z T)^{-1}\right) \geq 0$;
(iii) For all $z \in \mathbb{D}$ and all $h \in H$ we have $\left(\frac{2}{\rho}-1\right)\|z T h\|^{2}+\left(2-\frac{2}{\rho}\right)\langle z T h, h\rangle \leq\|h\|^{2}$.

We remark that these characterization can be expressed in terms of classes of operator-valued holomorphic functions. For instance, (ii) says that the map $z \mapsto\left(1-\frac{2}{\rho}\right) I+\frac{2}{\rho}(I-z T)^{-1}$ is in the Caratheodory class of operator-valued holomorphic functions on $\mathbb{D}$, having all real parts positive-definite operators. Item (iii) can be equivalently expressed by the membership of $z \mapsto z T((\rho-1) z T-\rho I)^{-1}$ to the Schur class of holomorphic maps $f: \mathbb{D} \rightarrow \mathcal{L}(H)$ having all norms no greater than one (i.e., $\|f(z)\| \leq 1$ for every $z \in \mathbb{D}$ ).
J.A.R. Holbrook [11] and J.P. Williams [24] introduced the notion of $\rho$-radius of an operator $T \in \mathcal{L}(H)$ as follows:

$$
w_{\rho}(T):=\inf \left\{u>0: \frac{1}{u} T \in C_{\rho}(H)\right\} .
$$

This $\rho$-radius is a quasi-norm on the Banach space $\mathcal{L}(H)$, equivalent to the operator norm, whose closed unit ball is exactly $C_{\rho}(H)$. Recall ([13]) that a quasi-norm satisfies all properties of a norm, except that the triangular inequality holds true up to a multiplicative constant. For $\rho>2$, the quasi-norm $w_{\rho}$ satisfies $([14,23])$

$$
w_{\rho}\left(T_{1}+T_{2}\right) \leq \rho\left(w_{\rho}\left(T_{1}\right)+w_{\rho}\left(T_{2}\right)\right) .
$$

Therefore the $\rho$-contractions are exactly the contractions for the $\rho$-radius, and many relationships between classes $C_{\rho}$ can be expressed more easily using the associated $\rho$-radii. The $\rho$-radius is a usual Banach-space norm for $0<\rho \leq 2$.

Some generalizations of classes $C_{\rho}$ have been studied, like classes $C_{A}(H)$ introduced by H. Langer (see [23, page 53] and its references, and [20]), or the classes $C_{\left(\rho_{n}\right)}(H)$ considered by several authors (see $[4,17,18]$ ). This latter generalization will be the main topic of study in this paper, with the novelty that we consider the general case when the $\rho_{n}$ 's are non-zero complex scalars. This will lead to classes of operators with several new features and different behavior.

## 2. Hilbert space operators with $\left(\rho_{n}\right)$-Dilations

Definition and first properties. In light of the preceding discussion we introduce the following definition.

Definition 2.1 (Classes $\left.C_{\left(\rho_{n}\right)}\right)$. - Let $\left(\rho_{n}\right)_{n \geq 1}$ be a sequence of complex numbers, with $\rho_{n} \neq 0$ for each $n$. We write $\left(\rho_{n}\right)_{n \geq 1} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$. Let $H$ be a complex Hilbert space. Define now

$$
\begin{aligned}
C_{\left(\rho_{n}\right)}(H):= & \{T \in \mathcal{L}(H): \text { there exists a Hilbert space } K \text { and a unitary operator } U \in \mathcal{L}(K) \\
& \text { with } \left.H \subset K \text { and } T^{n}=\left.\rho_{n} P_{H} U^{n}\right|_{H}, \forall n \geq 1\right\} .
\end{aligned}
$$

Here $P_{H} \in \mathcal{L}(K)$ is the orthogonal projection from $K$ onto its closed subspace $H$. We say in this case that $T$ possesses ( $\rho_{n}$ )-dilations.

In other words, an operator $T$ is in the class $C_{\left(\rho_{n}\right)}(H)$ if and only if all its powers admit dilations of the form $\rho_{n} U^{n}$ for a certain unitary operator $U$ acting on a larger Hilbert space. For the rest of this paper, we will suppose that the Hilbert space $H$ on which $T$ acts is fixed. If there is no ambiguity, $C_{\left(\rho_{n}\right)}(H)$ will be abbreviated as $C_{\left(\rho_{n}\right)}$. Note also that the sequence $\left(\rho_{n}\right)=\left(\rho_{n}\right)_{n \geq 1}$ starts at $n=1$ : for $n=0$ we have of course $T^{0}=I_{H}=\left.P_{H} U^{0}\right|_{H}$.

In the papers $[4,17,18]$, the case when the $\rho_{n}$ 's are non-negative real numbers is considered. We went for a broader choice of sequences as the main ideas do not rely heavily on the fact that $\rho_{n}$ are in $\mathbb{R}_{+}^{*}$ and as this eventually allows for some interesting new phenomena for the classes $C_{\left(\rho_{n}\right)}$. One first difference is recorded in the following remark.
Remark 2.2. - The definition of $C_{\left(\rho_{n}\right)}$ easily gives that $T \in C_{\left(\rho_{n}\right)}$ if and only if $T^{*} \in C_{\left(\overline{\left.\rho_{n}\right)}\right.}$. Therefore, when the $\rho_{n}$ are real scalars, the class $C_{\left(\rho_{n}\right)}$ is stable under the adjoint map $T \mapsto T^{*}$. This is no longer true in the general case.

Remark 2.3. - As another basic remark, we note that if $T$ is in $C_{\left(\rho_{n}\right)}$, then we have $\left\|T^{n}\right\| \leq\left|\rho_{n}\right|$. Thus, $r(T) \leq \lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$. This relationship implies that two different cases appear in the study of the classes $C_{\left(\rho_{n}\right)}$ :
(i) $0<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) \leq+\infty$;
(ii) $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=0$.

Although many of the proofs below work the same way in both cases, most of the results will be stated in the case $(i)$. The study of the case ( $i i$ ) is more problematic. Indeed, in case ( $i i$ ), the class $C_{\left(\rho_{n}\right)}$ will only contain quasinilpotent operators, that is operators whose spectra reduce to $\{0\}$.
We also note that when $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=+\infty$, we trivially have $r(T)<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$ for every operator $T$. We also note that the condition $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=+\infty$ leads to small changes in the proofs below: the main difference between this condition and $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)<+\infty$ in case (i) is the fact that the quantity $\frac{1}{\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}$, which exists when $\left.\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) \in\right] 0,+\infty[$, has to be replaced by 0 when $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=+\infty$. This motivates the following convention.

Convention. For the rest of this paper, we assume that

$$
\begin{equation*}
\frac{1}{\liminf \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}=0 \quad \text { whenever } \quad \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=+\infty . \tag{2.1}
\end{equation*}
$$

One of the main tools to characterize the classes $C_{\left(\rho_{n}\right)}$ is the following Herglotz-type theorem.
Theorem 2.4. - Let $H$ a Hilbert space. Let $F: \mathbb{D} \rightarrow H$ be an analytic function such that:
(i) $F(0)=I$
(ii) $\operatorname{Re}(F(z)) \geq 0, \forall z \in \mathbb{D}$.

Then, there exists a Hilbert space $K$ containing $H$ and $U \in \mathcal{L}(K)$ an unitary operator such that

$$
F(z)=\left.P_{H}(I+z U)(I-z U)^{-1}\right|_{H}, \forall z \in \mathbb{D}
$$

A proof of this theorem can be found in [8, p.65-69].
Definition 2.5. - For $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ and for $w$ in a complex Banach algebra, $f_{\left(\rho_{n}\right)}$ denotes the entire series given by $f_{\left(\rho_{n}\right)}(w)=\sum_{n \geq 1} \frac{2 w^{n}}{\rho_{n}}$.
For $a \in \mathbb{R}$, we denote $R e_{\geq a}$ the half-plane $\{z \in \mathbb{C}, \operatorname{Re}(z) \geq a\}$, while $R e_{>a}$ is the half-plane $\{z \in \mathbb{C}, \operatorname{Re}(z)>a\}$.

Proposition 2.6. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ and let $T \in \mathcal{L}(H)$. The following are equivalent:
(i) $T \in C_{\left(\rho_{n}\right)}$;
(ii) The series

$$
f_{\left(\rho_{n}\right)}(z T)=\sum_{n=1}^{\infty} \frac{2}{\rho_{n}} z^{n} T^{n}
$$

is absolutely convergent in $\mathcal{L}(H)$ and

$$
I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}(z T)\right) \geq 0, \text { for all } z \in \mathbb{D} .
$$

Proof. $(i) \Rightarrow($ ii $)$ Let $U$ be an unitary operator on a Hilbert space $K$, with $K$ containing $H$ as a closed subspace, such that

$$
T^{n}=\left.\rho_{n} P_{H} U^{n}\right|_{H}, \forall n \geq 1 .
$$

For every polynomial $P(X)=a_{0}+\cdots+a_{n} X^{n}$ and every $z \in \mathbb{D}$, we have

$$
a_{0} I+\frac{a_{1}}{\rho_{1}} z T+\cdots+\frac{a_{n}}{\rho_{n}}(z T)^{n}=\left.P_{H}\left(a_{0} I+a_{1} z U+\cdots+a_{n}(z U)^{n}\right)\right|_{H}=\left.P_{H} P(z U)\right|_{H} .
$$

Since the series $1+\sum_{n \geq 1} 2 w^{n}$ converges absolutely to $f(w)=\frac{1+w}{1-w}$ for all $w \in \mathbb{D}$, and since $U$ is unitary, the series $I+\sum_{n \geq 1} 2(z U)^{n}$ converges in norm to

$$
f(z U)=(I+z U)(I-z U)^{-1}, \text { for all } z \in \mathbb{D} .
$$

Thus, as

$$
\left\|\frac{T^{n}}{\rho_{n}}\right\|=\left\|\left.P_{H} U^{n}\right|_{H}\right\| \leq\left\|U^{n}\right\| \leq 1
$$

the series $I_{H}+\sum_{n \geq 1} \frac{2}{\rho_{n}}(z T)^{n}$ is absolutely convergent and converges to $\left.P_{H}\left[(I+z U)(I-z U)^{-1}\right]\right|_{H}$ for all $z \in \mathbb{D}$. As $U$ is unitary, $f(z U)$ is normal, so the closure of its numerical range $W(f(z U))$
is the convex hull of its spectrum. We have

$$
\sigma(f(z U))=f(\sigma(z U)) \subset f(\mathbb{D}) \subset R e_{>0}
$$

Thus,

$$
\left.W\left((I+z U)(I-z U)^{-1}\right)\right)=W(f(z U)) \subset H u l l\left(\sigma(f(z U)) \subset R e_{\geq 0} .\right.
$$

Furthermore, $W\left(\left.P_{H} f(z U)\right|_{H}\right) \subset W(f(z U))$, so the numerical range of $I_{H}+f_{\left(\rho_{n}\right)}(z T)$ is included in $\operatorname{Re} \geq 0$. This is equivalent to $\operatorname{Re}\left(I_{H}+f_{\left(\rho_{n}\right)}(z T)\right) \geq 0$, so $(i i)$ is true.

- $(i i) \Rightarrow(i)$ We define $F(z):=I_{H}+f_{\left(\rho_{n}\right)}(z T)$. Thus, $F$ is analytic on $\mathbb{D}, F(0)=I_{H}$, and $\operatorname{Re}(F(z)) \geq 0$ for all $z \in \mathbb{D}$. By applying Theorem 2.4, we obtain a Hilbert space $K$ and a unitary operator $U \in \mathcal{L}(K)$, such that $F(z)=\left.P_{H}(I+z U)(I-z U)^{-1}\right|_{H}$, for all $z \in \mathbb{D}$. By developing both analytic expressions in entire series, and identifying their coefficients, we obtain $\frac{2}{\rho_{n}} T^{n}=\left.2 P_{H} U^{n}\right|_{H}$ for all $n \geq 1$. Therefore $T \in C_{\left(\rho_{n}\right)}$.

We will obtain most of the following results by applying Proposition 2.6. We can directly see by applying this proposition that any class $C_{\left(\rho_{n}\right)}$ contains 0 , the null operator, so none of these classes is empty.

One remark is in order. We did not consider the case where $\rho_{n}=0$ for some $n$ in Definition 2.1. Indeed, this condition does not go well with computations similar to the ones in the proof of Proposition 2.6. Having $\rho_{n}=0$ implies $T^{n}=0$, but it does not give any information on $\left.P_{H} U^{n}\right|_{H}$. This prevents us from showing that certain sums of powers of $T$ and $T^{*}$ are positive, which is a crucial tool when dealing with operators in the class $C_{\left(\rho_{n}\right)}$.

If we were to denote $m:=\inf \left(\left\{n: \rho_{n}=0\right\}\right)$, then any operator $T$ in $C_{\left(\rho_{n}\right)}$ would need to be nilpotent of order at most m . The following Corollary treats this nilpotent case and gives a characterization that was the one we expected in the case $\rho_{m}=0$. See also [5, Proposition 6.1] for another use of the positivity condition (ii) below.

Corollary 2.7. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ and $m \geq 1$. Let $T \in \mathcal{L}(H)$ be such that $T^{m}=0$. Then, the following are equivalent:
(i) $T \in C_{\left(\rho_{n}\right)}$;
(ii) $I+\operatorname{Re}\left(\sum_{n=1}^{m-1} z^{n} \frac{2}{\rho_{n}} T^{n}\right) \geq 0$ for all $z \in \mathbb{D}$.

Thus, for any sequence $\left(\tau_{n}\right)$ such that $\rho_{k}=\tau_{k}$, for all $1 \leq k<m$, we have $T \in C_{\left(\tau_{n}\right)}$ if and only if $T \in C_{\left(\rho_{n}\right)}$.

Proof. A direct application of Proposition 2.6 with the extra condition $T^{m}=0$ gives the equivalence.

Now we come back to Proposition 2.6. When $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$, we can see that the series $\sum_{n=1}^{\infty} \frac{2}{\rho_{n}} z^{n} T^{n}$ is absolutely convergent if and only if $|z| r(T)<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$. We can thus reformulate Proposition 2.6 as follows.

Theorem 2.8. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. Let $T \in \mathcal{L}(H)$.
Then, the following assertions are equivalent:
(i) $T \in C_{\left(\rho_{n}\right)}$;
(ii) $r(T) \leq \lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$ and, for $f_{\left(\rho_{n}\right)}(z T):=\sum_{n=1}^{\infty} \frac{2}{\rho_{n}} z^{n} T^{n}$, we have

$$
I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}(z T)\right) \geq 0, \forall z \in \mathbb{D} .
$$

Remark 2.9. - Replacing the condition of absolute convergence of a series by a condition concerning the spectral radius of $T$ is useful in several instances. We can first notice that if we take $v>0$ small enough, then $v T$ will satisfy the spectral radius condition. However, if $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=0$, this condition must be replaced by $\lim \sup _{n}\left(\frac{\left\|T^{n}\right\|^{\frac{1}{n}}}{\left|\rho_{n}\right|}\right) \leq 1$, which can only be satisfied by certain quasinilpotent operators. Hence, aside from nilpotent operators and Corollary 2.7, knowing which operators can be "near" operators belonging to a class $C_{\left(\rho_{n}\right)}$ is a difficult problem. In this case, the map $f_{\left(\rho_{n}\right)}$ also has convergence radius 0 , so we cannot use analytic or geometric properties related to the images of certain disks by $f_{\left(\rho_{n}\right)}$.

Many of the following results, related to specific operators or to $f_{\left(\rho_{n}\right)}$ will have no meaning in this case, but others will be true under the additional condition

$$
\limsup _{n}\left(\frac{\left\|T^{n}\right\|}{\left|\rho_{n}\right|}\right)^{\frac{1}{n}} \leq 1
$$

We look now at the closure of the class $C_{\left(\rho_{n}\right)}$ for the operator norm.
Corollary 2.10. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. Then the class $C_{\left(\rho_{n}\right)}$ is closed for the operator norm: if $\left(T_{m}\right)_{m}$ a sequence of operators converging in $\mathcal{L}(H)$ to $T$, such that $T_{m} \in C_{\left(\rho_{n}\right)}$, then $T \in C_{\left(\rho_{n}\right)}$.

Proof. Let $\left(T_{m}\right)_{m}$ a sequence of operators converging to $T$ such that $T_{m} \in C_{\left(\rho_{n}\right)}$. We have

$$
r(T)=\lim _{m}\left(r\left(T_{m}\right)\right) \leq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) .
$$

Thus, for any $z \in \mathbb{D}$, the series $f_{\left(\rho_{n}\right)}(z T)$ converges absolutely and $f_{\left(\rho_{n}\right)}(z T)=\lim _{m} f_{\left(\rho_{n}\right)}\left(z T_{m}\right)$. Hence, for any $h \in H$, we have

$$
\operatorname{Re}\left(\left\langle\left(I+f_{\left(\rho_{n}\right)}(z T)\right) h, h\right\rangle\right)=\operatorname{Re}\left[\lim _{m}\left\langle\left(I+f_{\left(\rho_{n}\right)}\left(z T_{m}\right)\right) h, h\right\rangle\right] \geq 0 .
$$

This implies that $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}(z T) \geq 0\right.$, and the proof is complete by using Theorem 2.8.
Operator radii. The condition in Theorem 2.8 will be useful when studying the $\left(\rho_{n}\right)$-radius, which is introduced in the following definition.

Definition 2.11. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$. Let $T \in \mathcal{L}(H)$. We define the $\left(\rho_{n}\right)$-radius of $T$ as:

$$
w_{\left(\rho_{n}\right)}(T):=\inf \left\{u>0: \frac{T}{u} \in C_{\left(\rho_{n}\right)}\right\} \in[0,+\infty] .
$$

The definition of the $\left(\rho_{n}\right)$-radius is similar to the definition of the $\rho$-radius that can be found in $[1-3,11]$. As the classes $C_{\left(\rho_{n}\right)}$ and $C_{\rho}$ share the same type of definition, the $\left(\rho_{n}\right)$-radius and
the $\rho$-radius will share the same role with some slight different variations.

We will for now focus on properties of the $\left(\rho_{n}\right)$-radius.

Lemma 2.12. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. Then, the map $T \mapsto w_{\left(\rho_{n}\right)}(T)$ takes values in $[0,+\infty[$, is a quasi-norm, is equivalent as a quasi-norm to the operator norm $\|\cdot\|$, and its closed unit ball is the class $C_{\left(\rho_{n}\right)}$.
We also have

$$
w_{\left(\rho_{n}\right)}(T) \geq\left(\frac{\left\|T^{m}\right\|}{\left|\rho_{m}\right|}\right)^{\frac{1}{m}} \text { and } w_{\left(\rho_{n}\right)}(T) \geq \frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}
$$

Proof. We start off by showing that the $\left(\rho_{n}\right)$-radius is finite while obtaining its equivalence with the operator norm $\|\cdot\|$. Let $T \in \mathcal{L}(H)$. Let $u>0$ be such that $\frac{T}{u} \in C_{\left(\rho_{n}\right)}$. For any $m \geq 1$, we have $\frac{\left\|T^{m}\right\|}{u^{m}} \leq\left|\rho_{m}\right|$, that is

$$
u \geq\left(\frac{\left\|T^{m}\right\|}{\left|\rho_{m}\right|}\right)^{\frac{1}{m}}
$$

Therefore, by taking the infimum over $u$ such that $\frac{T}{u} \in C_{\left(\rho_{n}\right)}$, we get

$$
w_{\left(\rho_{n}\right)}(T) \geq\left(\frac{\left\|T^{m}\right\|}{\left|\rho_{m}\right|}\right)^{\frac{1}{m}}
$$

For $m=1$ we obtain $w_{\left(\rho_{n}\right)}(T) \geq\left(\frac{\|T\|}{\left|\rho_{1}\right|}\right)$. If we also take the limsup of the right-hand side quantity, we get

$$
w_{\left(\rho_{n}\right)}(T) \geq \frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}
$$

Now, let $r<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$. Therefore, the series $f_{\left(\left|\rho_{n}\right|\right)}(r z):=\sum_{n=1}^{\infty} \frac{2}{\left|\rho_{n}\right|} r^{n} z^{n}$ is absolutely convergent for all $z \in \mathbb{D}$, thus analytic on $\mathbb{D}$. Since $f_{\left(\left|\rho_{n}\right|\right)}(0)=0$, there is a radius $r_{0}$, with $1>r_{0}>0$, such that $\left|f_{\left(\left|\rho_{n}\right|\right)}\left(r_{0} w\right)\right| \leq 1$ for all $|w| \leq r$. Let $u>0$ be such that $\frac{\|T\|}{u}<r_{0} r$. Thus, we have

$$
r\left(\frac{T}{u}\right)<r_{0} r<\lim _{n} \inf \left(\left|\rho_{n}\right|^{\frac{1}{n}}\right),
$$

and for all $z \in \mathbb{D}$ we have

$$
\left\|f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right\| \leq \sum_{n=1}^{\infty} \frac{2}{\left|\rho_{n}\right|}|z|^{n}\left(\frac{T}{u}\right)^{n} \leq \sum_{n=1}^{\infty} \frac{2}{\rho_{n}}|z|^{n}\left(r_{0} r\right)^{n}=\left|f_{\left(\left|\rho_{n}\right|\right)}\left(r_{0}|z| r\right)\right| \leq 1
$$

We recall that for any $B \in \mathcal{L}(H)$ we have

$$
\operatorname{Re}(B) \geq-\|\operatorname{Re}(B)\| \cdot I=-\left\|\frac{B+B^{*}}{2}\right\| I \geq-\|B\| I
$$

Thus, for any $z \in \mathbb{D}, f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)$ converges absolutely and we have

$$
I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right) \geq I-\left\|f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right\| I \geq 0
$$

This means that $\frac{T}{u} \in C_{\left(\rho_{n}\right)}$ according to Proposition 2.6, so $w_{\left(\rho_{n}\right)}(T) \leq u<+\infty$. Furthermore, since $\frac{T}{u} \in C_{\left(\rho_{n}\right)}$ for every $u$ such that $u>\frac{\|T\|}{r_{0} r}$, we get $w_{\left(\rho_{n}\right)}(T) \leq \frac{\|T\|}{r_{0} r}$. Hence, we have

$$
\frac{\|T\|}{\left|\rho_{1}\right|} \leq w_{\left(\rho_{n}\right)}(T) \leq \frac{\|T\|}{r_{0} r} .
$$

With these inequalities we immediately get

$$
w_{\left(\rho_{n}\right)}(T)=0 \Leftrightarrow T=0
$$

These inequalities also imply that, for $S, T \in \mathcal{L}(H)$, we have

$$
w_{\left(\rho_{n}\right)}(S+T) \leq \frac{\|S+T\|}{r_{0} r} \leq \frac{\|S\|+\|T\|}{r_{0} r} \leq \frac{\left|\rho_{1}\right|}{r_{0} r}\left(w_{\left(\rho_{n}\right)}(S)++w_{\left(\rho_{n}\right)}(T)\right) .
$$

In order to show that $w_{\left(\rho_{n}\right)}($.$) is a quasi-norm, we still have to show that it is homogeneous,$ that is $w_{\left(\rho_{n}\right)}(z T)=|z| w_{\left(\rho_{n}\right)}(T)$ for any $z \in \mathbb{C}$. Let $z \in \mathbb{C}$. The cases $z=0$ and $T=0$ have been treated, so we now consider $z=e^{i t}|z| \neq 0$ and $T \neq 0$. Let $u \geq w_{\left(\rho_{n}\right)}(z T)$ be such that $\frac{z T}{u} \in C_{\left(\rho_{n}\right)}$. Denote $u^{\prime}=\frac{u}{|z|}$. We can see that $r\left(\frac{z T}{u}\right)=r\left(\frac{T}{u^{\prime}}\right)$ and that $f_{\left(\rho_{n}\right)}\left(w \frac{z T}{u}\right)=f_{\left(\rho_{n}\right)}\left(e^{i t} w \frac{T}{u^{\prime}}\right)$ for any $w \in \mathbb{D}$. Thus, the series $f_{\left(\rho_{n}\right)}\left(e^{i t} w \frac{T}{u^{\prime}}\right)$ converges absolutely and $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(e^{i t} w \frac{T}{u^{\prime}}\right)\right) \geq 0$, for any $w \in \mathbb{D}$. Hence $\frac{T}{u^{\prime}} \in C_{\left(\rho_{n}\right)}$, so

$$
u^{\prime}=\frac{u}{|z|} \geq w_{\left(\rho_{n}\right)}(T)
$$

Thus, by taking the infimum for $u \geq w_{\left(\rho_{n}\right)}(z T)$, we get

$$
w_{\left(\rho_{n}\right)}(z T) \geq|z| w_{\left(\rho_{n}\right)}(T)
$$

Applying the same result to $T^{\prime}=z T$ and $z^{\prime}=\frac{1}{z}$, we obtain

$$
w_{\left(\rho_{n}\right)}(T)=w_{\left(\rho_{n}\right)}\left(z^{\prime} T^{\prime}\right) \geq\left|z^{\prime}\right| w_{\left(\rho_{n}\right)}\left(T^{\prime}\right)=\frac{1}{|z|} w_{\left(\rho_{n}\right)}(z T),
$$

which proves the desired equality.
We will now prove that the closed unit ball for the $\left(\rho_{n}\right)$-radius is exactly $C_{\left(\rho_{n}\right)}$. Notice again that $w_{\left(\rho_{n}\right)}(T)=0$ reduces to $T=0$. If $T \in C_{\left(\rho_{n}\right)}$, then $w_{\left(\rho_{n}\right)}(T) \leq \frac{1}{1}=1$. Conversely, suppose that $w_{\left(\rho_{n}\right)}(T) \leq 1$ and let $\left(u_{m}\right)_{m}$ be a sequence, with $u_{m}>0$, converging to $w_{\left(\rho_{n}\right)}(T)$ such that $\frac{T}{u_{m}} \in C_{\left(\rho_{n}\right)}$. Using the fact that the class $C_{\left(\rho_{n}\right)}$ is closed for the operator norm, as proved in Corollary 2.10, we get $\frac{T}{w_{\left(\rho_{n}\right)}(T)} \in C_{\left(\rho_{n}\right)}$. Therefore, we have

$$
r(T) \leq r\left(\frac{T}{w_{\left(\rho_{n}\right)}(T)}\right) \leq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)
$$

and

$$
I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}(z T)\right) \geq 0, \text { for every } z \text { with }|z| \leq \frac{1}{w_{\left(\rho_{n}\right)}(T)} .
$$

Since $\frac{1}{w_{\left(\rho_{n}\right)}(T)} \geq 1$, we can conclude that $T \in C_{\left(\rho_{n}\right)}$. The proof is now complete.
Remark 2.13. In the case when $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=0$, we have $w_{\left(\rho_{n}\right)}(T)=+\infty$ unless $T$ is quasinilpotent and the sequence of $\left\|T^{n}\right\|^{\frac{1}{n}}$ decreases to 0 fast enough.

Remark 2.14. Since the ( $\rho_{n}$ )-radius is homogeneous and

$$
w_{\left(\rho_{n}\right)}(T) \leq 1 \Leftrightarrow T \in C_{\left(\rho_{n}\right)},
$$

whenever $T \neq 0$, we have

$$
\left\{u>0: \frac{T}{u} \in C_{\left(\rho_{n}\right)}\right\}=\left[w_{\left(\rho_{n}\right)}(T),+\infty[.\right.
$$

Corollary 2.15. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. Let $T \in \mathcal{L}(H)$. We have
(i) For any $z \neq 0, \frac{1}{|z|} w_{\left(\rho_{n}\right)}(T)=w_{\left(\rho_{n}\right)}\left(\frac{1}{z} T\right)=w_{\left(z^{n} \rho_{n}\right)}(T)$;
(ii) If $T \in C_{\left(\rho_{n}\right)}(H)$, then $T^{k} \in C_{\left(\rho_{k n}\right)}(H)$, for all $k \geq 1$;
(iii) $w_{\left(\rho_{k n}\right)_{n}}\left(T^{k}\right) \leq w_{\left(\rho_{n}\right)}(T)^{k}$, for all $k \geq 1$;
(iv) $w_{\left(\rho_{n}\right)}(T)=w_{\left(\overline{\left.\rho_{n}\right)}\right.}\left(T^{*}\right)$.

Proof. (i) The left-hand equality is given by the homogeneity of $w_{\left(\rho_{n}\right)}(\cdot)$. For the right-hand one, we can see that

$$
\left(\frac{T}{z}\right)^{n}=\left.\rho_{n} P_{H} U^{n}\right|_{H} \text { if and only if } T^{n}=\left.z^{n} \rho_{n} P_{H} U^{n}\right|_{H}
$$

Thus $\frac{T}{z} \in C_{\left(\rho_{n}\right)}$ if and only if $T \in C_{\left(z^{n} \rho_{n}\right)}$. Lemma 2.12 implies that

$$
w_{\left(\rho_{n}\right)}\left(\frac{1}{z} T\right)=w_{\left(z^{n} \rho_{n}\right)}(T)
$$

- (ii) By definition of the class $C_{\left(\rho_{n}\right)}$, if $T \in C_{\left(\rho_{n}\right)}$, then

$$
\left(T^{k}\right)^{m}=\left.\rho_{k m} P_{H}\left(U^{k}\right)^{m}\right|_{H}
$$

so $T^{k} \in C_{\left(\rho_{k n}\right)}(H)$.

- (iii) The result is true when $T=0$. When $T \neq 0$, consider $T^{\prime}=\frac{T}{w_{\left(\rho_{n}\right)}(T)}$. By homogeneity of $w_{\left(\rho_{n}\right)}(\cdot)$, we have $w_{\left(\rho_{n}\right)}\left(T^{\prime}\right)=1$, so $T^{\prime} \in C_{\left(\rho_{n}\right)}$ according to Lemma 2.12. Thus, for any $k \geq 1$, $\left(T^{\prime}\right)^{k} \in C_{\left(\rho_{k n}\right)}(H)$. Using again the homogeneity of the $\left(\rho_{n}\right)$-radius, we obtain

$$
\frac{w_{\left(\rho_{k n}\right)_{n}}\left(T^{k}\right)}{w_{\left(\rho_{n}\right)}(T)^{k}}=w_{\left(\rho_{k n}\right)}\left(\left(T^{\prime}\right)^{k}\right) \leq 1
$$

This completes the proof.

- (iv) We use Remark 2.2 and Lemma 2.12 to obtain the equivalence

$$
w_{\left(\rho_{n}\right)}(T) \leq 1 \Leftrightarrow w_{\left(\overline{\rho_{n}}\right)}\left(T^{*}\right) \leq 1
$$

Since the $\left(\rho_{n}\right)$-radii are homogenous, these quantities must be equal.
Corollary 2.16. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. Let $T \in \mathcal{L}(H)$. The following assertions are true:
(i) Let $F$ be an invariant closed subspace of $T$. Then $w_{\left(\rho_{n}\right)}\left(\left.T\right|_{F}\right) \leq w_{\left(\rho_{n}\right)}(T)$;
(ii) For any isometry $V$ we have $w_{\left(\rho_{n}\right)}\left(V T V^{*}\right) \leq w_{\left(\rho_{n}\right)}(T)$, with equality if $V$ is unitary;
(iii) For a Hilbert space $K$ we have $w_{\left(\rho_{n}\right)}\left(T \otimes I_{K}\right)=w_{\left(\rho_{n}\right)}(T)$;
(iv) For $T_{m} \in \mathcal{L}\left(H_{m}\right), m \geq 1$, n with $\sup _{m}\left(\left\|T_{m}\right\|\right)<+\infty$, we have

$$
w_{\left(\rho_{n}\right)}\left(\oplus_{m \geq 1} T_{m}\right)=\sup _{m \geq 1}\left(w_{\left(\rho_{n}\right)}\left(T_{m}\right)\right)
$$

(v) If $T^{(\infty)}$ denotes the countable orthogonal sum $T \oplus T \oplus \cdots$, then $w_{\left(\rho_{n}\right)}\left(T^{(\infty)}\right)=w_{\left(\rho_{n}\right)}(T)$.

Proof. - (i) We have $r\left(\left.T\right|_{F}\right) \leq r(T)$. If $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}(z T)\right)$ is positive, then $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(\left.z T\right|_{F}\right)\right)$ is positive too. Thus, by using Lemma 2.12 we obtain

$$
w_{\left(\rho_{n}\right)}(T) \leq 1 \Rightarrow w_{\left(\rho_{n}\right)}\left(\left.T\right|_{F}\right) \leq 1
$$

The homogeneity of the $\left(\rho_{n}\right)$-radius gives the result.

- (ii) We have $r\left(V T V^{*}\right) \leq r(T)$ and $\left(V T V^{*}\right)^{n}=V T^{n} V^{*}$. Thus, $f_{\left(\rho_{n}\right)}\left(z V T V^{*}\right)=V f_{\left(\rho_{n}\right)}(z T) V^{*}$. Hence, for any $h \in H$ and any $z \in \mathbb{D}$, we have

$$
\operatorname{Re}\left(\left\langle\left(I+f_{\left(\rho_{n}\right)}\left(z V T V^{*}\right)\right) h, h\right\rangle\right)=\operatorname{Re}\left(\left\langle\left(I+f_{\left(\rho_{n}\right)}(z T)\right) V^{*} h, V^{*} h\right\rangle\right)
$$

By applying Theorem 2.8 and Lemma 2.12, we get

$$
w_{\left(\rho_{n}\right)}(T) \leq 1 \Rightarrow w_{\left(\rho_{n}\right)}\left(V T V^{*}\right) \leq 1
$$

The homogeneity of the $\left(\rho_{n}\right)$-radii gives the desired inequality. When the isometry $V$ is also invertible, the converse inequality is true, so both quantities are equal.

- (iii) Since $\left\|T^{n}\right\|=\left\|\left(T \otimes I_{K}\right)^{n}\right\|$, we have $r(T)=r\left(T \otimes I_{K}\right)$. Let $u>0$ be such that $u \geq \frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}$. Thus the series $f_{\left(\rho_{n}\right)}\left(z \frac{T \otimes I_{K}}{u}\right)$ is absolutely convergent for all $z \in \mathbb{D}$, and $f_{\left(\rho_{n}\right)}\left(z \frac{T \otimes I_{K}}{u}\right)=f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right) \otimes I_{K}$. Since for any $h_{1} \otimes k_{1}, h_{2} \otimes k_{2} \in H \otimes K$ we have

$$
\left\langle h_{1} \otimes k_{1}, h_{2} \otimes k_{2}\right\rangle=\left\langle h_{1}, h_{2}\right\rangle\left\langle k_{1}, k_{2}\right\rangle
$$

we can see that the condition

$$
\left\langle\left(I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T \otimes I_{K}}{u}\right)\right)\right)(h \otimes k), h \otimes k\right\rangle \geq 0, \forall h \otimes k \in H \otimes K
$$

is equivalent to

$$
\left\langle\left(I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right)\right)(h), h\right\rangle \geq 0, \forall h \in H
$$

Hence, $\frac{T \otimes I_{K}}{u} \in C_{\left(\rho_{n}\right)}(H \otimes K)$ is equivalent to $\frac{T}{u} \in C_{\left(\rho_{n}\right)}(H)$, which implies that $w_{\left(\rho_{n}\right)}(T)=$ $w_{\left(\rho_{n}\right)}\left(T \otimes I_{K}\right)$.

- (iv) Since $\sup _{m}\left(\left\|T_{m}\right\|\right)<+\infty$, the linear map $T=\oplus_{m \geq 1} T_{m}$ is bounded on the Hilbert space $H=\oplus_{m \geq 1} H_{m}$, and $\|T\|=\sup _{m}\left(\left\|T_{m}\right\|\right)$. Thus, $r(T)=\sup _{m}\left(r\left(T_{m}\right)\right)$. Let $u>0$ be such that $u \geq \frac{\bar{r}(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}$. We have

$$
r\left(\frac{T_{m}}{u}\right) \leq r\left(\frac{T}{u}\right) \leq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)
$$

Thus, the series $f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)$ and $f_{\left(\rho_{n}\right)}\left(z \frac{T_{m}}{u}\right)$ are absolutely convergent for all $z \in \mathbb{D}$, and

$$
f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)=\oplus_{m \geq 1} f_{\left(\rho_{n}\right)}\left(z \frac{T_{m}}{u}\right)
$$

Since for any $h=\left(h_{m}\right)_{m} \in H$, we have

$$
\left[I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right)\right](h)=\left(\left(I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T_{m}}{u}\right)\right)\right)\left(h_{m}\right)\right)_{m},
$$

this implies that

$$
\left\langle\left(I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right)\right)(h), h\right\rangle \geq 0, \forall h \in H
$$

is equivalent to

$$
\left\langle\left(I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T_{m}}{u}\right)\right)\right)\left(h_{m}\right), h_{m}\right\rangle \geq 0, \forall h_{m} \in H_{m}, \forall m \geq 1
$$

Hence, the assertion $\frac{T}{u} \in C_{\left(\rho_{n}\right)}(H)$ is equivalent to $\frac{T_{m}}{u} \in C_{\left(\rho_{n}\right)}\left(H_{m}\right), \forall n \geq 1$, which implies that $w_{\left(\rho_{n}\right)}(T)=\sup _{m}\left(w_{\left(\rho_{n}\right)}\left(T_{m}\right)\right)$.

- (v) The proof is a consequence of item (iii) and [5, Remark 1.1].

The items ( $i$ ) and (ii) of this Corollary show that the classes $C_{\left(\rho_{n}\right)}$ are unitarily invariant, and stable under the restriction to an invariant closed subspace. The item $(i v)$ is a generalization of a known property of direct sums of operators in the class $C_{(\rho)}$. Items $(i),(i i)$ and $(v)$ show that, under the condition of Corollary 2.16, the radius $w_{\left(\rho_{n}\right)}$ is an admissible radius in the terminology of [5, Definition 1.1]. Thus, all the results proved in [5] for admissible radii are valid for $w_{\left(\rho_{n}\right)}$ when $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. In particular, the following result is true.

Corollary 2.17. - Let $T \in \mathcal{L}(H)$, with $\|T\| \leq 1$ and $T^{n}=0$ for some $n \geq 2$. Then, for each polynomial $p$ with complex coefficients, we have

$$
w_{\left(\rho_{n}\right)}(p(T)) \leq w_{\left(\rho_{n}\right)}\left(p\left(S_{n}^{*}\right)\right) .
$$

Here $S_{n}^{*}$ is the nilpotent Jordan cell

$$
S_{n}^{*}=\left(\begin{array}{cccccc}
0 & 1 & 0 & \cdots & 0 & 0 \\
0 & 0 & 1 & \cdots & 0 & 0 \\
\vdots & \vdots & \vdots & \ddots & \vdots & \vdots \\
0 & 0 & 0 & \cdots & 0 & 1 \\
0 & 0 & 0 & \cdots & 0 & 0
\end{array}\right)
$$

on the standard Euclidean space $\mathbb{C}^{n}$.
Some other consequences of the condition $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$ are proved in the next Proposition.

Proposition 2.18. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. The following assertions are true:
(i) We have

$$
w_{\left(\rho_{n}\right)}(I)=\min \left(\left\{r \geq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)^{-1}: f_{\left(\rho_{n}\right)}\left(\mathbb{D}\left(0, \frac{1}{r}\right)\right) \subset R e_{\geq-1}\right\}\right) ;
$$

(ii) For any $T \in \mathcal{L}(H)$, we have $w_{\left(\rho_{n}\right)}(T) \geq r(T) \cdot w_{\left(\rho_{n}\right)}(I)$;
(iii) If $T$ is normal, then $w_{\left(\rho_{n}\right)}(T)=\|T\| \cdot w_{\left(\rho_{n}\right)}(I)$.

Proof. - (i) Take $u=w_{\left(\rho_{n}\right)}(I)$ such that $\frac{I}{u} \in C_{\left(\rho_{n}\right)}$. We have $r\left(\frac{I}{u}\right) \leq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$, so $\frac{1}{u}$ is no greater than the convergence radius of $f_{\left(\rho_{n}\right)}$. For any $z \in \mathbb{D}$, we have $f_{\left(\rho_{n}\right)}\left(z \frac{I}{u}\right)=f_{\left(\rho_{n}\right)}\left(\frac{z}{u}\right) I$. Thus, $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{I}{u}\right)\right) \geq 0$ for any $z \in \mathbb{D}$ if and only if $f_{\left(\rho_{n}\right)}\left(\mathbb{D}\left(0, \frac{1}{u}\right)\right) \in \operatorname{Re} e_{\geq-1}$.

- (ii) Let $T \in \mathcal{L}(H)$. There is nothing to prove if $T=0$ or $r(T)=0$. Otherwise, let $u=w_{\left(\rho_{n}\right)}(T)$ be such that $\frac{T}{u} \in C_{\left(\rho_{n}\right)}$ (cf. Lemma 2.12). Since $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right) \geq 0$, the spectrum of $I+f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)$ lies in $R e_{\geq 0}$. This spectrum is the set $\left\{1+f_{\left(\rho_{n}\right)}(z w), w \in \sigma\left(\frac{T}{u}\right)\right\}$. The union of these spectra, when $z$ describes $\mathbb{D}$, is $\left\{1+f_{\left(\rho_{n}\right)}(w),|w|<\frac{r(T)}{u}\right\}$. Since $\frac{r(T)}{u}>0$, we obtain from item (i) that $\frac{u}{r(T)} \geq w_{\left(\rho_{n}\right)}(I)$. Hence $w_{\left(\rho_{n}\right)}(T) \geq r(T) w_{\left(\rho_{n}\right)}(I)$.
- (iii) Let $T$ be a normal operator with $T \neq 0$. For $u=\|T\| \cdot w_{\left(\rho_{n}\right)}(I)$, we have

$$
r\left(\frac{T}{u}\right)=\frac{\|T\|}{u}=\frac{1}{w_{\left(\rho_{n}\right)}(I)} \leq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) .
$$

Thus, we obtain that

$$
\bigcup_{z \in \mathbb{D}} \sigma\left(I+f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right)=\left\{1+f_{\left(\rho_{n}\right)}(w),|w|<\frac{1}{w_{\left(\rho_{n}\right)}(I)}\right\} .
$$

Item ( $i$ ) of this Proposition tells us that this set is included in $R e_{\geq 0}$. As $T$ is normal, $I+f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)$ is also normal, so

$$
W\left(I+f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right) \subset H u l l\left(\sigma\left(I+f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right)\right) \subset R e_{\geq 0}, \forall z \in \mathbb{D} .
$$

Hence, $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(z \frac{T}{u}\right)\right) \geq 0$, and $\frac{T}{u} \in C_{\left(\rho_{n}\right)}$. By Lemma 2.12, we then have

$$
w_{\left(\rho_{n}\right)}(T) \leq u=\|T\| w_{\left(\rho_{n}\right)}(I) .
$$

The inequality of item (ii) provides the desired equality.
Remark 2.19. Since we also have

$$
w_{\left(\rho_{n}\right)}(I) \geq \frac{1}{\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)},
$$

the inequality in Proposition 2.18 is better than the last one of Lemma 2.12. Thus, if there is $T$ such that $w_{\left(\rho_{n}\right)}(T)=\frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}$, the same must be true for the identity operator $I$. In the case when $\rho_{n}=\rho, \rho>0$, this can only happen when $\rho \geq 1$.

## 3. Classes $C_{(\rho)}$ FOR $\rho \neq 0$

In this section, we will focus on the case where $\rho_{n}=\rho$, for some $\rho \in \mathbb{C}^{*}$. This is an intermediate class between the classical case considered by Sz.-Nagy and Foias (classes $C_{\tau}$ for $\tau>0$ ) and the the general $C_{\left(\rho_{n}\right)}$-classes. Thus the obtained results are already known when $\rho>0$, but the generalization to the case $\rho \in \mathbb{C}^{*}$ seems to be new. Nevertheless, we acknowledge the influence of $[1,2,14,23]$ for the results of this section. The results obtained here will turn out to be useful when we will look again at $C_{\left(\rho_{n}\right)}$-classes in the next section.

## Some characterizations.

Lemma 3.1. - Let $\rho \neq 0$ and $\rho_{n}=\rho, \forall n \geq 1$. Let $T \in \mathcal{L}(H)$.
The following are equivalent:
(i) $T \in C_{(\rho)}(H)$;
(ii) $r(T) \leq 1$ and $\operatorname{Re}\left(\left(1-\frac{2}{\rho}\right) I+\frac{2}{\rho}(I-z T)^{-1}\right) \geq 0, \forall z \in \mathbb{D}$;
(iii) $r(T) \leq 1$ and $\operatorname{Re}\left(\frac{2}{\rho}(I-z T)\right)+\operatorname{Re}\left(1-\frac{2}{\rho}\right)(I-z T)^{*}(I-z T) \geq 0, \forall z \in \mathbb{D}$;
(iv) $\operatorname{Re}\left(\frac{2}{\rho}(I-z T)\right)+\operatorname{Re}\left(1-\frac{2}{\rho}\right)(I-z T)^{*}(I-z T) \geq 0, \forall z \in \mathbb{D}$.

Proof. - $(i) \Leftrightarrow(i i)$ We have $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=1$. When $r(T) \leq 1$, for $z \in \mathbb{D}$, we have

$$
I+\sum_{n \geq 1} \frac{2}{\rho}(z T)^{n}=\left(1-\frac{2}{\rho}\right) I+\frac{2}{\rho}(I-z T)^{-1}
$$

Apply now Proposition 2.6.

- (ii) $\Leftrightarrow($ iii $)$ We will use several times the known fact that for $A, B \in \mathcal{L}(H)$, with $A$ invertible,

$$
\operatorname{Re}(B) \geq 0 \Leftrightarrow \operatorname{Re}\left(A^{*} B A\right) \geq 0 .
$$

We obtain the equivalence $(i i) \Leftrightarrow(i i i)$ by choosing

$$
A=(I-z T), B=\left(1-\frac{2}{\rho}\right) I+\frac{2}{\rho}(I-z T)^{-1}
$$

and by rearranging the expression, using that $(I-z T)^{*}(I-z T)$ is a positive self-adjoint operator and $\operatorname{Re}\left(A^{*}\right)=\operatorname{Re}(A)$.

- $(i i i) \Rightarrow(i v)$ is immediate.
- $(i v) \Rightarrow(i i i)$ Suppose that $r(T)>1$. Thus, there exists $\gamma \in \mathbb{C}$ such that $|\gamma|=r(T)>1$, and there is a sequence $\left(h_{n}\right)$ of vectors $h_{n} \in H$ such that $\left\|h_{n}\right\|=1$ and $\left\|(T-\gamma I) h_{n}\right\| \rightarrow 0$ as $n \rightarrow \infty$. Let $0<\epsilon<|\gamma|-1$ and set $g_{n}:=(T-\gamma I) h_{n}$. Let also $\eta=\epsilon$. $e^{i t}$, for some $t$ that will be chosen later on. Let $z:=\frac{1+\eta}{\gamma}$. Then, $|z|<\frac{1+(|\gamma|-1)}{|\gamma|}=1$. Furthermore, we have

$$
(I-z T) h_{n}=\left(I-\frac{1}{\gamma} T\right) h_{n}-\frac{\eta}{\gamma} T h_{n}+\eta h_{n}-\eta h_{n}=-z g_{n}-\eta h_{n} .
$$

Thus, we obtain

$$
\begin{aligned}
& \left.\operatorname{Re}\left(\left\langle\left[\frac{2}{\rho}(I-z T)\right)+\left(1-\frac{2}{\rho}\right)(I-z T)^{*}(I-z T)\right] h_{n}, h_{n}\right\rangle\right) \geq 0 \\
\Rightarrow & \operatorname{Re}\left(\frac{2}{\rho}\left[-\eta \cdot\left\|h_{n}\right\|^{2}-\left\langle z g_{n}, h_{n}\right\rangle\right]+\left(1-\frac{2}{\rho}\right)\left\|(I-z T) h_{n}\right\|^{2}\right) \geq 0 \\
\Rightarrow & \operatorname{Re}\left(\frac{2}{\rho}\left[-\eta-\left\langle z g_{n}, h_{n}\right\rangle\right]+\left(1-\frac{2}{\rho}\right)\left[|\eta|^{2}+2 \operatorname{Re}\left(\left\langle z g_{n}, h_{n}\right\rangle\right)+|z|^{2}\left\|g_{n}\right\|^{2}\right]\right) \geq 0
\end{aligned}
$$

Hence, by taking the limit as $n \rightarrow+\infty$, we obtain

$$
\operatorname{Re}\left(\frac{2}{\rho}(-\eta)+\left(1-\frac{2}{\rho}\right)|\eta|^{2}\right)=\operatorname{Re}\left(\frac{-2}{\rho} e^{i t}\right) \epsilon+\operatorname{Re}\left(1-\frac{2}{\rho}\right) \epsilon^{2} \geq 0
$$

We can then choose $t \in \mathbb{R}$ depending on $\arg (\rho)$ and $\operatorname{sgn}\left(\operatorname{Re}\left(1-\frac{2}{\rho}\right)\right)$ to obtain

$$
\text { either } \frac{-2}{|\rho|} \epsilon+\left|\operatorname{Re}\left(1-\frac{2}{\rho}\right)\right| \epsilon^{2} \geq 0 \text { or } \frac{2}{|\rho|} \epsilon-\left|\operatorname{Re}\left(1-\frac{2}{\rho}\right)\right| \epsilon^{2} \leq 0 .
$$

But since $\frac{-2}{|\rho|}<0$, there is some $\epsilon>0$ such that $\frac{-2}{|\rho|}+\left|\operatorname{Re}\left(1-\frac{2}{\rho}\right)\right| \epsilon$ is strictly negative, which is impossible. This contradiction shows that $r(T) \leq 1$, which concludes the proof.

Lemma 3.2. - Let $\rho \neq 0$ and $\alpha>0$ be two scalars. Let $T \in \mathcal{L}(H)$.
The following asertions are equivalent:
(i) $w_{(\rho)}(T) \leq \alpha$;
(ii) $r(T) \leq \alpha,((\rho-1) z T-\rho \alpha I)$ is invertible and $\left\|(z T)((\rho-1) z T-\rho \alpha I)^{-1}\right\| \leq 1, \forall z \in \mathbb{D}$;
(iii) $r(T) \leq \alpha,((\rho-1) T-\rho w I)$ is invertible and $\left\|T((\rho-1) T-\rho w I)^{-1}\right\| \leq 1, \forall|w|>\alpha$.

Proof. - $(i) \Rightarrow(i i)$ When replacing $T$ with $\frac{T}{\alpha}$, all expressions in (i) and (ii) are reduced to the case $\alpha=1$. Now, as $w_{\left(\rho_{n}\right)}(T) \leq \alpha=1$, we use Lemma 3.1 to have $r(T) \leq 1$ and

$$
\operatorname{Re}\left(\left(1-\frac{2}{\rho}\right) I+\frac{2}{\rho}(I-z T)^{-1}\right) \geq 0, \forall z \in \mathbb{D} .
$$

We denote $C_{z}:=\left(1-\frac{2}{\rho}\right) I+\frac{2}{\rho}(I-z T)^{-1}$, for $z \in \mathbb{D}$. We recall that since $\operatorname{Re}\left(C_{z}\right) \geq 0$, we have $\left(C_{z}+I\right)$ invertible and

$$
\left\|\left(C_{z}-I\right)\left(C_{z}+I\right)^{-1}\right\| \leq 1 .
$$

A computation gives

$$
C_{z}-I=\frac{2}{\rho} z T(I-z T)^{-1} \text { and } C_{z}+I=\left[2 I+\left(\frac{2}{\rho}-2\right) z T\right](I-z T)^{-1} .
$$

Thus,
$\left(C_{z}-I\right)\left(C_{z}+I\right)^{-1}=\frac{1}{\rho} z T\left[I+\left(\frac{1}{\rho}-1\right) z T\right]^{-1}=z T[\rho I+(1-\rho) z T]^{-1}=-z T[-\rho I+(\rho-1) z T]^{-1}$.
This means that all the conditions of (ii) are fulfilled.

- $(i i) \Rightarrow(i)$ We again reduce to the case $\alpha=1$. We denote $D_{z}=z T[\rho I-(\rho-1) z T]^{-1}$, for $z \in \mathbb{D}$. Since $\left\|D_{z}\right\| \leq 1$, we have $D_{z} \in C_{(1)}$ so $r\left(D_{z}\right) \leq 1$ and $\operatorname{Re}\left(\left(I+w D_{z}\right)\left(I-w D_{z}\right)^{-1}\right) \geq 0$, for all $w \in \mathbb{D}$. We obtain:

$$
I+w D_{z}=[\rho I+(w+1-\rho) z T][\rho I-(\rho-1) z T]^{-1}
$$

and

$$
I-w D_{z}=[\rho I+(-w+1-\rho) z T][\rho I-(\rho-1) z T]^{-1}
$$

Thus,

$$
\left(I+w D_{z}\right)\left(I-w D_{z}\right)^{-1}=[\rho I+(w+1-\rho) z T][\rho I+(-w+1-\rho) z T]^{-1}
$$

Since $r(T) \leq 1,(I-z T)$ is invertible so $[\rho I+(-w+1-\rho) z T]^{-1}$ converges to $\frac{1}{\rho}(I-z T)^{-1}$ when $w$ tends to 1 , by continuity of the inverse map. Thus,

$$
\lim _{w \rightarrow 1, w \in \mathbb{D}}\left(I+w D_{z}\right)\left(I-w D_{z}\right)^{-1}=\frac{1}{\rho}(\rho I+(2-\rho) z T)(I-z T)^{-1}=C_{z} .
$$

Hence, $\operatorname{Re}\left(C_{z}\right) \geq 0$ for all $z \in \mathbb{D}$ and $r(T) \leq 1$, so $T \in C_{(\rho)}$.

- (ii) $\Leftrightarrow(i i i)$ For $z \neq 0$, we take $w=\frac{\alpha}{z}$ to obtain the result. The converse gives the result for all $z \in \mathbb{D}, z \neq 0$, which extends to $\mathbb{D}$ by continuity.

Reducing to the case $\rho>0$. With this characterization of $C_{(\rho)}$ classes, we are now able to obtain the main relationship between $(\rho)$-radii and $(\tau)$-radii, $\rho \in \mathbb{C}^{*}, \tau>0$. This relationship extends the "symmetric" relationship

$$
\tau w_{(\tau)}(T)=(2-\tau) w_{(\tau)}(T), 0<\tau<2
$$

that was already known (see [2, Thm.3]).
Proposition 3.3. - Let $\rho \neq 0$ and $\alpha>0$ be two scalars. Let $T \in \mathcal{L}(H)$.
The following asertions are equivalent:
(i) $w_{(\rho)}(T) \leq \alpha$;
(ii) $((\rho-1) z T-\rho \alpha I)$ is invertible and $\left\|(z T)((\rho-1) z T-\rho \alpha I)^{-1}\right\| \leq 1, \forall z \in \mathbb{D}$;
(iii) $((\rho-1) T-\rho w I)$ is invertible and $\left\|T((\rho-1) T-\rho w I)^{-1}\right\| \leq 1, \forall|w|>\alpha$.

Furthermore, we have:

$$
\begin{equation*}
|\rho| w_{(\rho)}(T)=(1+|\rho-1|) w_{1+|\rho-1|}(T) . \tag{3.1}
\end{equation*}
$$

Hence, the map $\rho \in \mathbb{C}^{*} \mapsto|\rho| w_{(\rho)}(T)$ is constant on circles of center 1 , is continuous on $\mathbb{C}^{*}$ and can be extended continuously to $2 w_{(2)}(T)$ at 0 .

Proof. Using the results of Lemma 3.2, we can see that items (ii) and (iii) are equivalent and that item $(i)$ implies item (ii). We only need to show that item $(i i)$ implies $r(T) \leq \alpha$. We can reduce the proof to the case $\alpha=1$ by considering $\frac{T}{\alpha}$ instead of $T$. We also recall that if $\rho>0$, the result is valid (see [19, Thm.1] or [7] for a proof). Let $\rho \neq 0$. We denote $S=\frac{1+|\rho-1|}{|\rho|} T$. Suppose that $[(\rho-1) z T-\rho I]^{-1}$ exists and that $\left\|z T[(\rho-1) z T-\rho I]^{-1}\right\| \leq 1$, for all $z \in \mathbb{D}$. With $\rho-1=|\rho-1| e^{i t}, \rho=|\rho| e^{i s}$ and $w=z . e^{-i s+i t}$ we then have

$$
\begin{aligned}
& \left\|z T[(\rho-1) z T-\rho I]^{-1}\right\| \leq 1 \\
\Leftrightarrow & \left\|z T\left[|\rho-1| e^{i t} z T-|\rho| e^{i s} I\right]^{-1}\right\| \leq 1 \\
\Leftrightarrow & \left\|z e^{-i s} e^{i t} e^{-i t} T\left[|\rho-1| z e^{-i s} e^{i t} T-|\rho| I\right]^{-1}\right\| \leq 1 . \\
\Leftrightarrow & \left|e^{-i t}\right|\left\|w T[|\rho-1| w T-|\rho| I]^{-1}\right\| \leq 1 \\
\Leftrightarrow & \left\|w T[(1+|\rho-1|-1) w T-|\rho| I]^{-1}\right\| \leq 1 \\
\Leftrightarrow & \left\|w \frac{1+|\rho-1|}{|\rho|} T\left[(1+|\rho-1|-1) w \frac{1+|\rho-1|}{|\rho|} T-(1+|\rho-1|) I\right]^{-1}\right\| \leq 1 \\
\Leftrightarrow & \left\|w S[(1+|\rho-1|-1) w S-(1+|\rho-1|) I]^{-1}\right\| \leq 1 .
\end{aligned}
$$

Since $w$ describes $\mathbb{D}$ when $z$ does, this is true for all $w \in \mathbb{D}$. Therefore $w_{(1+|\rho-1|)}(S) \leq 1$ as $1+|\rho-1|>0$ (see the beginning of the proof and Lemma 3.2). Thus, $r(S) \leq 1$, which implies $r(T) \leq \frac{|\rho|}{1+|\rho-1|} \leq 1$.

Now that we have showed that the condition about the spectral radius of $T$ is not necessary, we can see that the equivalences in the previous computations give

$$
w_{(\rho)}(T) \leq 1 \Leftrightarrow w_{(1+|\rho-1|)}\left(\frac{1+|\rho-1|}{|\rho|} T\right) \leq 1
$$

By homogeneity of the $\left(\rho_{n}\right)$-radii, this is equivalent to

$$
|\rho| w_{(\rho)}(T)=(1+|\rho-1|) w_{(1+|\rho-1|)}(T) .
$$

- The properties of the map $\rho \in \mathbb{C}^{*} \mapsto|\rho| w_{(\rho)}(T)$ can now be obtained from its restriction to $[1,+\infty[$, which is known to be continuous (see [2, Cor.2] for example ).

Equation (3.1) gives a simple geometric understanding of a formula that was previously known only for real numbers $\rho$ between 0 and 2 . It also implies the following relationship between $C_{\rho}$ classes.

Corollary 3.4. - We have

$$
C_{(\rho)}=\frac{1+|\rho-1|}{|\rho|} C_{(1+|\rho-1|)} .
$$

We conclude that complex ( $\rho$ )-radii of an operator $T$ can be expressed in terms of the real positive ones.

Corollary 3.5. - Let $\rho \neq 0$ and let $T \in \mathcal{L}(H)$. We have:
(i) $w_{(\rho)}(I)=\frac{1+|\rho-1|}{|\rho|}, \forall \rho \neq 0$;
(ii) If $T$ is normal, then $w_{(\rho)}(T)=\|T\| \frac{1+|\rho-1|}{|\rho|}$;
(iii) If $T^{2}=0$, then $w_{\left(\rho_{n}\right)}(T)=w_{\left(\rho_{1}\right)}(T)=\frac{2 w(T)}{\left|\rho_{1}\right|}=\frac{\|T\|}{\left|\rho_{1}\right|}$;
(iv) It $T^{2}=b I, b \in \mathbb{C}$, then $|\rho| w_{(\rho)}(T)=w(T)+\sqrt{w_{2}(T)^{2}+|b|\left(|\rho-1|^{2}-1\right)}$;
(v) It $T^{2}=a T, a \in \mathbb{C}$, then $|\rho| w_{\rho}(T)=2 w(T)+|a||\rho-1|$.

Proof. - ( $i$ It is known that $w_{(\rho)}(I)=1$ when $1 \leq \rho$. The relationship of Proposition 3.3 gives the result.

- (ii) When $T$ is normal, we have $w_{\left(\rho_{n}\right)}(T)=\|T\| w_{\left(\rho_{n}\right)}(I)$.
- (iii) If $T^{2}=0$, then $T \in C_{\left(\rho_{n}\right)}$ if and only if $I+\operatorname{Re}\left(\frac{2}{\rho_{1}} z T\right) \geq 0$ for all $z \in \mathbb{D}$. By Corollary 2.7, this is equivalent to $\frac{T}{\left|\rho_{1}\right|} \in C_{(1)}$, to $\frac{2 T}{\left|\rho_{1}\right|} \in C_{(2)}$ and to $T \in C_{\left(\rho_{1}\right)}$. Thus, Lemma 2.12 and the following facts

$$
w_{(2)}(T)=w(T) \text { and } w_{(1)}(T)=\|T\|
$$

imply that

$$
w_{\left(\rho_{n}\right)}(T)=w_{\left(\rho_{1}\right)}(T)=\frac{2 w(T)}{\left|\rho_{1}\right|}=\frac{\|T\|}{\left|\rho_{1}\right|}
$$

- (iv), (v) We can reduce these cases to $T^{2}=I$ (respectively $T^{2}=T$ ) by taking $\delta$ to be a square root of $b$ (respectively $a$ ) and looking at $\frac{T}{\delta}$ (respectively $\frac{T}{\delta^{2}}$ ). Then, [2, Theorem 6] gives the result when $\rho>0$, and we extend it to $\rho \in \mathbb{C}^{*}$ by using Proposition 3.3.

Computations and some applications. For the next auxiliary result we need some notation. For an operator $T$ acting on $H$ and for $h \in H$, define

$$
V_{h}:=\overline{\operatorname{Span}\left(T^{n}(h), n \geq 0\right)} \text { and } T_{h}:=\left.T\right|_{V_{h}} \in \mathcal{L}\left(V_{h}\right) .
$$

Lemma 3.6. - Let $T \in \mathcal{L}(H)$. Let $\rho \neq 0$. Then, with the previous notation, we have

$$
w_{(\rho)}(T)=\sup _{h \in H}\left(w_{(\rho)}\left(T_{h}\right)\right) .
$$

If we also have $P(T)=0$ for some $P \in C[X]$ with $\operatorname{deg}(P)=n$, then $T_{h}$ can be identified as some matrix $S \in M_{n}(\mathbb{C})$ such that $P(S)=0$, and the computation of $w_{(\rho)}\left(T_{h}\right)$ can be obtained from the computation of $w_{(\rho)}(S)$.

Proof.
Let $h \in H$. We already proved in Corollary 2.16 that $w_{(\rho)}\left(T_{h}\right) \leq w_{(\rho)}(T)$. Conversely, for $\frac{1}{u}=\sup _{h \in H}\left(w_{(\rho)}\left(T_{h}\right)\right),\left(I-z \frac{T}{u}\right)$ is invertible as $\left(I-z \frac{T_{h}}{u}\right)$ is invertible for all $h \in H$ and we have $\operatorname{Re}\left(\left\langle\left(I+f_{(\rho)}\left(z \frac{T}{u}\right)\right) g, g\right\rangle\right) \geq 0$ for all $g \in H$. Thus $\frac{T}{u} \in C_{(\rho)}$, which implies $\sup _{h \in H}\left(w_{(\rho)}\left(T_{h}\right)\right) \geq w_{(\rho)}(T)$ and concludes the proof.

Remark 3.7. - Here is an attempt to compute $w_{(\rho)}(T), \rho>1$, when $T$ satisfies the quadratic equation $T^{2}+a T+b I=0$. We use some ideas from [2], which allows one to obtain an expression of $w_{(\rho)}(T)$ depending on $w_{(2)}(T)$ when $a=0$ or $b=0$.
Up to considering $r e^{i t} T$, we can assume that $|b|=1$ and $\operatorname{Re}(\bar{a} b)=0$. With $\alpha, \beta$ the roots of $X^{2}+a X+b$ and $\eta \in \mathbb{C}$, we want to compute $w_{(\rho)}(M)$, for $M=\left(\begin{array}{cc}\alpha & \eta \\ 0 & \beta\end{array}\right)$. Using Lemma 3.2, (ii), and Proposition 3.3, we obtain that $w_{(\rho)}(M)$ is the largest (in modulus) $z$ that is solution of

$$
2(\rho-1)^{2}+\rho^{2}|z|^{2}\left(\frac{|a|^{2}+\left|a^{2}-4 b\right|}{2}\right)+|\eta|^{2} \rho^{2}|z|^{2}=\left|(\rho-1)^{2} \frac{i a}{|a|}+a(\rho-1) \rho z+\rho^{2} z^{2}\right|^{2}+1 .
$$

In the case $\rho=2$, the equation simplifies into

$$
2+2|z|^{2}\left(|a|^{2}+\left|a^{2}-4 b\right|\right)+4|\eta|^{2}|z|^{2}=\left|4 z^{2}+2 a z+\frac{i a}{|a|}\right|^{2}+1 .
$$

However, unlike the case where $a=0$ or $b=0$ in [2], we couldn't find a way to have an algebraic expression of $w_{(\rho)}(T)$ in terms of $w_{(2)}(T)$.

Using Proposition 3.3, we can also generalize some results of [1] about characterizing unitary operators through their $\rho$-radii.

Proposition 3.8. - Let $T \in \mathcal{L}(H)$ be invertible. Then
(i) $T$ is unitary if and only if $\sigma(T) \subset \partial \mathbb{D}$ and there exists $\rho \in \mathbb{C}^{*}$ such that

$$
w_{(\rho)}(T) \leq w_{(\rho)}(I) .
$$

(ii) $T=\|T\| U$ for $U$ unitary if and only if there exists $\rho \in \mathbb{C}^{*}$ and $m>0$ such that

$$
\frac{w_{(\rho)}\left(T^{-m}\right)}{w_{(\rho)}(I)}=\left(\frac{w_{(\rho)}(T)}{w_{(\rho)}(I)}\right)^{-m}
$$

Proof. - (i) The formula of Proposition 3.3 can be rewritten as $w_{(\rho)}(S)=w_{(\rho)}(I) w_{(1+|\rho-1|)}(S)$. It allows us to obtain the same relationship between $T$ and $I$ for $w_{(1+|\rho-1|)}$, and we can then
apply [1, Theorem 2.1] to get the result.

- (ii) The formula of Proposition 3.3 allows us to obtain the same relationship for $w_{(1+|\rho-1|)}$, which simplifies into:

$$
w_{1+|\rho-1|}\left(T^{-m}\right)=w_{1+|\rho-1|}(T)^{-m} .
$$

We can now apply [1, Theorem 1.1], and the proof is complete.
Proposition 3.9. - Let $\rho \neq 0$ be a complex number. Then
(i) The $\rho$-radius $w_{(\rho)}(\cdot)$ is a norm on $\mathcal{L}(H)$ if and only if $|\rho-1| \leq 1$;
(ii) If $|\rho-1|>1$, then, for all operators $T_{1}$ and $T_{2}$ in $\mathcal{L}(H)$, we have

$$
w_{\rho}\left(T_{1}+T_{2}\right) \leq(1+|\rho-1|)\left(w_{\rho}\left(T_{1}\right)+w_{\rho}\left(T_{2}\right)\right) .
$$

Proof. For two operators $T_{1}, T_{2}$, we have $w_{(\rho)}\left(T_{1}+T_{2}\right) \leq C\left(w_{(\rho)}\left(T_{1}\right)+w_{(\rho)}\left(T_{2}\right)\right)$ if and only if the same is true for $w_{(1+|\rho-1|)}$. It is known [14,23] that for $\tau>0, w_{(\tau)}$ is a norm if and only if $0<\tau \leq 2$. We conclude that $w_{(\rho)}(\cdot)$ is a norm if and only if $\rho$ lies in the closed circle of center 1 and radius 1 . Moreover, when $\tau>2, w_{(\tau)}$ is a quasi-norm with multiplicative constant (also called the modulus of concavity of the quasi-norm [13]) lower or equal to $\tau$. We thus obtain (ii).

For the next proposition we recall that for $r>0$ the disc algebra over the disc $\mathbb{D}(0, r)$, $\mathbb{A}(\mathbb{D}(0, r))$, is the set of holomorphic functions on $\mathbb{D}(0, r)$ that are continuous on $\overline{\mathbb{D}(0, r)}$.

Proposition 3.10. - Let $\rho \neq 0$ be a complex number. Let $T \in C_{(\rho)}$. Then the functional calculus map $f \mapsto f(T)$ that sends a polynomial $f$ into $f(T)$ can be extended continuously to the disk algebra $\mathbb{A}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right)$. It is a morphism of Banach algebras, and satisfies

$$
\|f(T)\| \leq(1+|\rho-1|)\|f\|_{L^{\infty}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(\mathbb{I})}\right)\right.}
$$

Furthermore, for $f \in \mathbb{A}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right)$ such that $f(0)=0$, we have

$$
w_{(\rho)}(f(T)) \leq w_{(\rho)}(I)\|f\|_{L^{\infty}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right)} .
$$

If $f \in \mathbb{A}(\mathbb{D})$ with $f(0)=0$, we also have

$$
w_{(\rho)}(f(T)) \leq\|f\|_{L^{\infty}(\mathbb{D})} .
$$

The constants in these three inequalities are optimal.
Proof. We notice first that $T \in C_{(\rho)}$ is equivalent to $w_{(\rho)}(T) \leq 1$, which is equivalent to

$$
w_{(1+|\rho-1|)}(T) \leq \frac{|\rho|}{1+|\rho-1|}=\frac{1}{w_{(\rho)}(I)} \leq 1
$$

Hence, $w_{(\rho)}(I) T$ lies in $C_{(1+|\rho-1|)}$, so there exists a Hilbert space $K$ and an unitary operator $U$ over $K$ such that

$$
\left(w_{(\rho)}(I) T\right)^{n}=\left.(1+|\rho-1|) P_{H} U^{n}\right|_{H}, \forall n \geq 1
$$

Therefore, if we denote $V:=\frac{U}{w_{(\rho)}(I)}$, for any polynomial $P$ we get

$$
P(T)=\left.P_{H}[(1+|\rho-1|) P(V)-|\rho-1| P(0) I]\right|_{H}
$$

Since V is a normal operator with spectral radius $\frac{1}{w_{(\rho)}(I)}$, we then have

$$
\|P(T)\| \leq\|(1+|\rho-1|) P(V)-|\rho-1| P(0) I\| \leq\|(1+|\rho-1|) P-|\rho-1| P(0)\|_{L^{\infty}\left(\mathbb{D}\left(0, \frac{1}{\left.w_{(\rho)}^{(I)}\right)}\right)\right.}
$$

As the polynomials are dense in the algebra $\mathbb{A}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right)$, the morphism of algebras $P \mapsto P(T)$ extends continuously on $\mathbb{A}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right)$.

Let us estimate the norm of this map. For $f$ in the algebra we denote $g(z):=f\left(\frac{z}{w_{(\rho)}(I)}\right)$. Hence, $g \in \mathbb{A}(\mathbb{D})$, and we have $f(T)=g\left(w_{(\rho)}(I) T\right)$. Applying a reformulation of Theorem 2 in [15] by Ando and Okubo, we obtain

$$
\|f(T)\|=\left\|g\left(w_{(\rho)}(I) T\right)\right\| \leq \max (1,1+|\rho-1|)\|g\|_{L^{\infty}(\mathbb{D})}=(1+|\rho-1|)\|f\|_{L^{\infty\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}^{(I)}}\right)\right)}}
$$

We will now prove the two remaining inequalities. The fact that $V$ is normal implies that $f \mapsto f(V)$ is well defined and bounded on $\mathbb{A}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right)$. Therefore

$$
f(T)=\left.P_{H}[(1+|\rho-1|) f(V)-|\rho-1| f(0) I]\right|_{H}, \forall f \in \mathbb{A}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right)
$$

We now suppose that $f$ satisfies $f(0)=0$. If $f \equiv 0$, then $f(T)=0$ and the statements are true. Otherwise, up to dividing $f$ by its norm, we may assume that $\|f\|_{L^{\infty}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right.}=1$. For a fixed $n \geq 1$, we get

$$
f(T)^{n}=f^{n}(T)=\left.(1+|\rho-1|) P_{H} f^{n}(V)\right|_{H}=\left.(1+|\rho-1|) P_{H} f(V)^{n}\right|_{H}
$$

As we have $\|f(V)\| \leq\|f\|_{L^{\infty}\left(\mathbb{D}\left(0, \frac{1}{\left.w_{(\rho)}^{(I)}\right)}\right)\right.}=1$, the operator $f(V)$ lies in $C_{(1)}$ which in turns implies that $f(V)$ can be dilated on a larger Hilbert space as follows

$$
f(V)^{m}=\left.P_{K} W^{m}\right|_{K}, \forall m \geq 1
$$

with $W$ a suitable unitary operator. Combining the two dilations, we obtain

$$
f(T)^{n}=\left.(1+|\rho-1|) P_{H} W^{n}\right|_{H}, \forall n \geq 1
$$

Therefore $f(T)$ lies in $C_{(1+|\rho-1|)}$, which is equivalent to $w_{(1+|\rho-1|)}(f(T)) \leq 1$. This inequality is in turn equivalent to $w_{(\rho)}(f(T)) \leq w_{(\rho)}(I)$, which proves the second inequality of this Proposition. Lastly, if $f \in \mathbb{A}(\mathbb{D})$ with $f(0)=0$, we can use Schwarz's lemma to obtain

$$
\|f\|_{L^{\infty}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}(I)}\right)\right)} \leq \frac{1}{w_{(\rho)}(I)}\|f\|_{L^{\infty}(\mathbb{D})}
$$

which in turn gives $w_{(\rho)}(f(T)) \leq\|f\|_{L^{\infty}(\mathbb{D})}$.
For the optimality of these inequalities, let us take $T$ such that $T^{2}=0$ and $\|T\|=|\rho|$, and
$f(z)=z$. We then have

$$
w_{(\rho)}(T)=\frac{\|T\|}{|\rho|}=1=w_{(\rho)}(I)\|f\|_{L^{\infty}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)}^{(I)}}\right)\right)}=\|f\|_{L^{\infty}(\mathbb{D})}
$$

and

$$
\|f(T)\|=|\rho|=(1+|\rho-1|)\|f\|_{L^{\infty}\left(\mathbb{D}\left(0, \frac{1}{w_{(\rho)^{(I)}}}\right)\right)}
$$

The proof is complete.
When $\rho$ does not lie in $[1,+\infty[$, the algebra where the functional calculus is defined strictly contains the disc algebra $\mathbb{A}(\mathbb{D})$. For $0<\rho<1$, the norm of this map is then $2-\rho$. This result differs from [15, Theorem 2] as Ando and Okubo looked in [15] at the map $f \mapsto f(T)$ on $\mathbb{A}(\mathbb{D})$ and not on a larger algebra.

## 4. INEQUALITIES AND PARAMETRIZATIONS FOR $\left(\rho_{n}\right)$-RADII

Operator radii of products and tensor products. A useful tool, used to study the behavior of a product or sum of double-commuting operators, is the following result, proved in [11, Thm.4.2].

Proposition 4.1. - Let $T_{n}, S_{n} \in \mathcal{L}(H)$, $n \in \mathbb{Z}$, be such that for all $0 \leq r<1, t \in \mathbb{R}$, the series $\sum_{n=-\infty}^{\infty} r^{|n|} e^{i n t} T_{n}$ and $\sum_{n=-\infty}^{\infty} r^{|n|} e^{i n t} S_{n}$ converge absolutely and have self-adjoint non-negative sums. If, moreover, we have $T_{n} \cdot S_{m}=S_{m} \cdot T_{n}, \forall m, n \in \mathbb{Z}$, then the series $\sum_{n=-\infty}^{\infty} r^{|n|} e^{i n t} T_{n} \cdot S_{n}$ converges absolutely and has a self-adjoint non-negative sum, for all $0 \leq r<1, t \in \mathbb{R}$.

Using Proposition 4.1 we can easily obtain the following auxiliary result.
Lemma 4.2. - Let $T, S \in \mathcal{L}(H)$ be two operators that are double-commuting (i.e., $T S=S T$, $\left.T S^{*}=S^{*} T\right) . \operatorname{Let}\left(\rho_{n}\right)_{n},\left(\tau_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$ and $\liminf \inf _{n}\left(\left|\tau_{n}\right|^{\frac{1}{n}}\right)>0$. Then, we have

$$
w_{\left(\rho_{n} \tau_{n}\right)}(S . T) \leq w_{\left(\rho_{n}\right)}(S) w_{\left(\tau_{n}\right)}(T)
$$

Proof. If $S=0$ or $T=0$, then $S T=0$ and both sides of the inequality are equal to zero. If $S \neq 0$ and $T \neq 0$, then, up to dividing $S$ and $T$ by their respective radius, we can consider that $w_{\left(\rho_{n}\right)}(S)=w_{\left(\tau_{n}\right)}(T)=1$. Thus, we need to prove that $w_{\left(\rho_{n} \tau_{n}\right)}(S . T) \leq 1$. We define

$$
T_{m}:=\left\{\begin{array}{l}
\frac{1}{\rho_{m}} T^{m} \text { if } m \geq 1 \\
I \text { if } m=0 \\
\frac{1}{\rho_{|m|}}\left(T^{*}\right)^{|m|} \text { if } m \leq-1
\end{array} \quad, S_{m}:=\left\{\begin{array}{l}
\frac{1}{\tau_{m}} S^{m} \text { if } m \geq 1 \\
I \text { if } m=0 \\
\frac{1}{\tau_{|m|}}\left(S^{*}\right)^{|m|} \text { if } m \leq-1
\end{array}\right.\right.
$$

The condition $w_{\left(\rho_{n}\right)}(S)=w_{\left(\tau_{n}\right)}(T)=1$, together with Lemma 2.12 and Proposition 2.6, ensure us that the conditions of Proposition 4.1 are fulfilled, since $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}\left(r e^{i t} S\right)=\right.$ $\sum_{m \in \mathbb{Z}} r^{|m|} e^{i m t} S_{m}$, for all $0 \leq r<1, t \in \mathbb{R}$. Thus, $\sum_{m \in \mathbb{Z}} r^{|m|} e^{i m t} S_{m} T_{m}$ converges absolutely, is self-adjoint, and has a positive sum, for all $0 \leq r<1, t \in \mathbb{R}$. This implies that the series

$$
\sum_{n \geq 1} \frac{2}{\rho_{n} \tau_{n}}\left(r e^{i t} S T\right)^{n}=f_{\left(\rho_{n} \tau_{n}\right)}\left(r e^{i t} S T\right)
$$

is absolutely convergent and that $I+\operatorname{Re}\left(f_{\left(\rho_{n} \tau_{n}\right)}\left(r e^{i t} S T\right)\right) \geq 0$ for all $0 \leq r<1, t \in \mathbb{R}$. Thus $S T \in C_{\left(\rho_{n} \tau_{n}\right)}$ and $w_{\left(\rho_{n} \tau_{n}\right)}(S T) \leq 1$, which concludes the proof.
Corollary 4.3. - Let $T, S \in \mathcal{L}(H)$ and let $\left(\rho_{n}\right)_{n},\left(\tau_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$ and $\liminf n_{n}\left(\left|\tau_{n}\right|^{\frac{1}{n}}\right)>0$.
(i) If $T$ and $S$ double-commute, then

$$
w_{\left(\rho_{n}\right)}(S T) \leq w_{(1)}(S) w_{\left(\rho_{n}\right)}(T) \leq\left|\tau_{1}\right| w_{\left(\tau_{n}\right)}(S) w_{\left(\rho_{n}\right)}(T)
$$

This inequality is optimal when $\operatorname{dim}(H) \geq 4$.
(ii) We have

$$
w_{(1)}(S T) \leq w_{(1)}(S) w_{(1)}(T) \leq\left|\tau_{1}\right|\left|\rho_{1}\right| w_{\left(\tau_{n}\right)}(S) w_{\left(\rho_{n}\right)}(T)
$$

This inequality is optimal when $\operatorname{dim}(H) \geq 2$.
(iii) For $R \in \mathcal{L}\left(H^{\prime}\right)$, we have

$$
w_{\left(\rho_{n} \tau_{n}\right)}(T \otimes R) \leq w_{\left(\rho_{n}\right)}(T) w_{\left(\tau_{n}\right)}(R)
$$

Proof. - (i) We use Lemma 4.2 for $S, T$ and $(1)_{n},\left(\rho_{n}\right)_{n}$ to get the left-hand side inequality. The right-hand side inequality comes from the fact $w_{\left(\tau_{n}\right)}(S) \geq \frac{\|S\|}{\left|\tau_{1}\right|}$ (cf. Lemma 2.12). By taking

$$
S=\left(\begin{array}{llll}
0 & 1 & 0 & 0 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0
\end{array}\right), T=\left(\begin{array}{llll}
0 & 0 & 1 & 0 \\
0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right) \text { such that } S T=\left(\begin{array}{cccc}
0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right),
$$

some computation show that $S$ and $T$ double-commute, and that

$$
\|S\|=\|T\|=\|S T\|, S^{2}=T^{2}=(S T)^{2}=0 .
$$

Corollary $3.5,($ iii $)$, shows that all three quantities are equal to $\frac{\|S T\|}{\left|\rho_{1}\right|}$.

- (ii) The inequality on the right-hand side follows again from Lemma 2.12. By taking

$$
S=\left(\begin{array}{ll}
0 & 1 \\
0 & 0
\end{array}\right), T=\left(\begin{array}{ll}
0 & 0 \\
1 & 0
\end{array}\right) \text { such that } S T=\left(\begin{array}{ll}
1 & 0 \\
0 & 0
\end{array}\right)
$$

we have

$$
\|S\|=\|T\|=\|S T\|=1, S^{2}=T^{2}=0, \text { and } S T \text { is self-adjoint. }
$$

Thus, $w_{\left(\tau_{n}\right)}(S)=w_{\left(\rho_{n}\right)}(T)=\frac{1}{\rho}$ and $w_{(1)}(S T)=1$, so all quantites are equal to 1 .

- (iii) As $I_{H}, T$ double-commute and $I_{H^{\prime}}, R$ double-commute too, we can apply Lemma 4.2 to $\left(T \otimes I_{H^{\prime}}\right)\left(I_{H} \otimes R\right)=T \otimes R$. We then apply item (iii) of Corollary 2.16.

Although these inequalities are optimal for some operators, they tend to lose a good part of the information in the general case. For example, we have $w_{(3)}(I)=1 \leq w_{(-1)}(I) w_{(-3)}(I)=5$. Such a loss of information on the radius of the identity operator $I$ also impacts almost every estimate of radii for other operators in $\mathcal{L}(H)$.

Corollary 4.4. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. Then,

$$
\frac{\|T\|}{\left|\rho_{1}\right|} \leq w_{\left(\rho_{n}\right)}(T) \leq\|T\| w_{\left(\rho_{n}\right)}(I) .
$$

Furthermore, the coefficients in this equivalence of quasi-norms are optimal.
Proof. The left-hand side inequality $\frac{\|T\|}{\left|\rho_{1}\right|} \leq w_{\left(\rho_{n}\right)}(T)$ has been obtained in Lemma 2.12. The equality case is obtained for $T$ such that $T^{2}=0$, as seen in Corollary 3.5. The right-hand side inequality comes from Lemma 4.2 , with $S=I$ and $\tau_{n}=1$. It is an improvement of the one that was obtained in Lemma 2.12. The equality case is obtained for any $T$ normal of norm 1.

Operator radii as 1-parameter families. To better understand the behavior of the associated radii associated with classes of operators, it is useful to look at $\left(\rho_{n}\right)$-radii as 1-parameter families. This is obtained by studying the map $z \mapsto w_{\left(z \rho_{n}\right)}$. We will present results for the real parameter case $(r \in] 0,+\infty[)$ and for the complex one $\left(z \in \mathbb{C}^{*}\right)$.

The two main ingredients we are using are the double-commuting inequality of Lemma 4.2 for $T, I$ and $\left(\rho_{n}\right)_{n},(1)_{1}$, and the fact that $f_{\left(z \rho_{n}\right)}=\frac{1}{z} f_{\left(\rho_{n}\right)}$.

Proposition 4.5. - Let $T \in \mathcal{L}(H)$ and consider $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ with $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$.
(i) For all $z \neq 0$, we have:

$$
\frac{|z|}{1+|z-1|} w_{\left(z \rho_{n}\right)}(T) \leq w_{\left(\rho_{n}\right)}(T) \leq w_{\left(z \rho_{n}\right)}(T)(|z|+|z-1|) .
$$

(ii) The map $z \mapsto w_{\left(z \rho_{n}\right)}(T)$ is continuous on $\mathbb{C}^{*}$, and $r \mapsto w_{\left(r . e^{i t} \rho_{n}\right)}(T)$ is continuous and decreasing on $] 0,+\infty[$, for all $t \in]-\pi, \pi]$.
(iii) We have

$$
\frac{1}{3} \cdot w_{\left(z \rho_{n}\right)}(T) \leq w_{\left(|z| \rho_{n}\right)}(T) \leq 3 \cdot w_{\left(z \rho_{n}\right)}(T)
$$

and these inequalities are optimal.
Proof. - (i) We use Lemma 4.2 to obtain

$$
w_{\left(z \rho_{n}\right)}(T) \leq w_{(z)}(I) w_{\left(\rho_{n}\right)}(T) \text { and } w_{\left(\rho_{n}\right)}(T) \leq w_{\left(z^{-1}\right)}(I) w_{\left(z \rho_{n}\right)}(T)
$$

As $w_{(z)}(I)=\frac{1+|z-1|}{|z|}$ and $w_{\left(z^{-1}\right)}(I)=|z|+|z-1|$, we obtain the desired inequalities.

- (ii) Up to changing $\left(\rho_{n}\right)_{n}$ by $\left(w \rho_{n}\right)_{n}$, the continuity must only be shown at the point $w=1$, that is when $z \rightarrow 1$. As we have

$$
w_{\left(\rho_{n}\right)}(T) \leq w_{\left(z \rho_{n}\right)}(T)(|z|+|z-1|) \leq w_{\left(\rho_{n}\right)}(T)(|z|+|z-1|) \frac{1+|z-1|}{|z|}
$$

and as $(|z|+|z-1|), \frac{1+|z-1|}{|z|}$ both tend to 1 from above as $z \rightarrow 1$, we obtain

$$
\lim _{z \rightarrow 1} w_{\left(z \rho_{n}\right)}(T)=w_{\left(\rho_{n}\right)}(T) .
$$

For any $t \in \mathbb{R}$ and $0<r<R$, we have

$$
w_{\left(\operatorname{Re}^{i t} \rho_{n}\right)}(T) \leq w_{\left(R \cdot r^{-1}\right)}(I) w_{\left(r e^{i t} \rho_{n}\right)}(T)=w_{\left(r e^{i t} \rho_{n}\right)}(T) .
$$

Thus, $r \mapsto w_{\left(r . e^{i t} \rho_{n}\right)}(T)$ is decreasing on $] 0,+\infty[$.

- (iii) We use the fact that $w_{\left(e^{i t}\right)}(I)=1+\left|e^{i t}-1\right|$ has a maximum of 3 when $e^{i t}=-1$. The equality case for the inequality on the left-hand side is attained at $T=I, \rho_{n}=1$ and $z=-1$, whereas the equality case for the one on the right-hand side is attained at $T=I, \rho_{n}=-1$, $z=-1$.

Since $r \mapsto w_{\left(r \rho_{n}\right)}(T)$ is decreasing, the classes $C_{\left(r \rho_{n}\right)}$ are increasing (for the usual order of inclusion of sets), for $r \in] 0,+\infty[$. By using nilpotent operators of order 2, and item (iii) of Corollary 3.5 , we can also immediately show that these inclusions are always strict.

For the following propositions, we recall that $\frac{1}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}=0$ if $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=+\infty$.
Proposition 4.6. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ and $T \in \mathcal{L}(H)$ be such that $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>r(T) \geq 0$. Then, there is $r>0$ such that for all $z$ with $|z|=r$,

$$
\frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)} \leq w_{\left(z \rho_{n}\right)}(T) \leq 1
$$

Proof. Let $s>1$ be such that $r(s T)<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$. As

$$
\limsup _{n \rightarrow \infty}\left(\frac{2 s^{n}\left\|T^{n}\right\|}{\left|\rho_{n}\right|}\right)^{\frac{1}{n}}=\frac{r(s T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}<1,
$$

there is $B>0$ such that $\frac{2 s^{n}\left\|T^{n}\right\|}{\left|\rho_{n}\right|} \leq B$. Thus, for all $w \in \mathbb{D}$, we have

$$
\left\|f_{\left(z \rho_{n}\right)}(w T)\right\| \leq \sum_{n \geq 1} \frac{2\left\|T^{n}\right\|}{|z|\left|\rho_{n}\right|} \leq \sum_{n \geq 1} \frac{B}{|z| s^{n}}=\frac{1}{|z|} \frac{s B}{1-s}<+\infty
$$

By taking $|z|$ large enough, we have $\left\|f_{\left(z \rho_{n}\right)}(w T)\right\|<1$, which implies that

$$
I+\operatorname{Re}\left(f_{\left(z \rho_{n}\right)}(w T)\right) \geq 0, \forall w \in \mathbb{D}
$$

Thus $w_{\left(z \rho_{n}\right)}(T) \leq 1$. The left-hand side inequality comes from items $(i)$ and (ii) of Proposition 2.18: we have

$$
w_{\left(z \rho_{n}\right)}(T) \geq r(T) w_{\left(z \rho_{n}\right)}(I) \text { and } w_{\left(z \rho_{n}\right)}(I) \geq \frac{1}{\lim \inf _{n}\left(\left|z \rho_{n}\right|^{\frac{1}{n}}\right)}
$$

Proposition 4.7. - Let $T \in \mathcal{L}(H)$ and let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ be such that $\lim _{\inf }^{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. Then

$$
\lim _{|z| \rightarrow+\infty}\left(w_{\left(z \rho_{n}\right)}(T)\right)=\frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)} .
$$

Proof. According to Proposition 4.5 and Proposition 2.18, the map $r \mapsto w_{\left(r e^{i t} \rho_{n}\right)}(T)$ is decreasing on $] 0,+\infty[$ and

$$
w_{\left(\rho_{n}\right)}(T) \geq r(T) w_{\left(\rho_{n}\right)}(I) \geq \frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}
$$

We will show that $w_{\left(z \rho_{n}\right)}(T)$ is as close to this lower bound as we want when $z$ is large enough. Let $\epsilon>0$. If $r(T)=0$, then $r\left(\frac{1}{\epsilon} T\right)=0$, so Proposition 4.6 implies the existence of $r>0$ such that $w_{\left(z \rho_{n}\right)}\left(\frac{T}{\epsilon}\right) \leq 1$ for all $z$ with $|z|=r$. Thus, $w_{\left(z \rho_{n}\right)}(T) \leq \epsilon$.
If $r(T) \neq 0$, for $0<R<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$ we have

$$
r\left(\frac{R T}{(1+\epsilon) r(T)}\right) \leq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) .
$$

Thus, by Proposition 4.6, there exists $r>0$ such that $w_{\left(z \rho_{n}\right)}\left(\frac{R T}{(1+\epsilon) r(T)}\right) \leq 1$ for all $z$ with $|z|=r$. Hence,

$$
\frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)} \leq w_{\left(z \rho_{n}\right)}(T) \leq \frac{(1+\epsilon) r(T)}{R}
$$

We then obtain the result by taking $R=\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)(1-\epsilon)$ if $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$ is finite, or $R=\frac{1}{\epsilon}$ if $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=+\infty$.

Proposition 4.8. - Let $T \in \mathcal{L}(H)$. Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ be such that $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. We have:
(i) $z \mapsto w_{\left(z \rho_{n}\right)}(T)$ is uniformly continuous on $\mathbb{C} \backslash \mathbb{D}(0, \epsilon)$, for all $\epsilon>0$. This maps tends to $+\infty$ as $|z| \rightarrow 0$, and to $\frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}$ as $|z| \rightarrow+\infty$;
(ii) For any $t \in \mathbb{R}$, the map $r \mapsto w_{\left(r e^{i t} \rho_{n}\right)}(T)$ is log-convex on $] 0,+\infty[$.

Proof. - (i) On the closed set $\mathbb{C} \backslash \mathbb{D}(0, \epsilon)$, the function

$$
z \mapsto w_{\left(z \rho_{n}\right)}(T)
$$

is continuous, decreasing on every half-line of the form $e^{i t}[\epsilon,+\infty[$, and converges to

$$
\frac{r(T)}{\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}
$$

as $|z| \rightarrow+\infty$. Thus, a standard argument (considering two cases, $\epsilon \leq|z| \leq R$ and $|z| \geq R$ ) shows that this map is uniformly continuous. One can also use the double-commuting inequality of Lemma 4.2 for $T$ and $I_{H}$, as well as the uniform continuity of the map $z \mapsto w_{(z)}(I)$ on $\mathbb{C} \backslash \mathbb{D}(0, \eta)$, in order to prove the uniform continuity of $z \mapsto w_{\left(z \rho_{n}\right)}(T)$. The limit as $|z| \rightarrow+\infty$ has been obtained in Proposition 4.7, while the limit as $|z| \rightarrow 0$ comes from the fact that $w_{\left(z \rho_{n}\right)}(T) \geq \frac{\|T\|}{\mid z \| \rho_{1}}$, as remarked in Lemma 2.12.

- (ii) Let $t \in \mathbb{R}$. Denote $G^{\prime}(z):=-e^{-i t} f_{\left(\rho_{n}\right)}(z T)$. For any $\alpha>0$, we have $w_{\left(r e^{i t} \rho_{n}\right)}(T) \leq \alpha$ if and only if $f_{\left(e^{i t} \rho_{n}\right)}\left(z \frac{T}{\alpha}\right)$ is analytic on $\mathbb{D}$ and $I+\operatorname{Re}\left(\frac{1}{r} f_{\left(e^{i t} \rho_{n}\right)}\left(z \frac{T}{\alpha}\right)\right) \geq 0$, for all $z \in \mathbb{D}$. By taking $w=\frac{z}{\alpha}$, this is equivalent to $G^{\prime}(w)$ being analytic on $\mathbb{D}\left(0, \frac{1}{\alpha}\right)$ and $\operatorname{Re}\left(G^{\prime}(w)\right) \leq r I$, for all $w \in \mathbb{D}\left(0, \frac{1}{\alpha}\right)$. The result is then obtained by mimicking the proof of [2, Theorem 1] by Ando and Nishio and replacing $G$ with $G^{\prime}$.

Even though the expression of $f_{\left(z \rho_{n}\right)}$ is more complex than $f_{(z)}(w)=\frac{2}{z} \frac{w}{1-w}$, the main regularity properties remain valid due to its analyticity.

Proposition 4.9. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ be such that $\lim _{\inf }^{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. If one of the following assertions is true
(i) $\liminf \operatorname{in}_{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)<1$;
(ii) $\left|\rho_{n}\right|<1$ for some $n \geq 1$;
(iii) $w_{\left(\rho_{n}\right)}(I)>1$;
(iv) $\rho_{n}=M+x_{n},\left(x_{n}\right)_{n} \in \ell_{2}(\mathbb{C})$,
then all operators in $C_{\left(\rho_{n}\right)}(H)$ are similar to contractions.
If, on the contrary, we have:
(i') $w_{\left(\rho_{n}\right)}(I)<1$,
then $C_{\left(\rho_{n}\right)}(H)$ contains operators that are not similar to contractions.
Both statements remain true if the conditions are only fulfilled for the subsequence $\left(\rho_{k n}\right)_{n}$, for some fixed $k \geq 1$.

Proof. - $(i),(i i),(i i i)$ We can see that $(i) \Rightarrow(i i) \Rightarrow(i i i)$. If (iii) is true, then for $T \in C_{\left(\rho_{n}\right)}$, we have

$$
r(T) \leq \frac{w_{\left(\rho_{n}\right)}(T)}{w_{\left(\rho_{n}\right)}(I)}<1,
$$

so T is similar to a contraction.

- (iv) It has been shown in [17, Ch.2] (see also [4, Cor 5.2.1]) that when $\rho_{n}=M+x_{n},\left(x_{n}\right)_{n} \in$ $\ell_{2}(\mathbb{C})$, all operators in $C_{\left(\rho_{n}\right)}$ are similar to contractions.
- $\left(i^{\prime}\right)$ On the contrary, when $w_{\left(\rho_{n}\right)}(I)<1, \frac{1}{w_{\left(\rho_{n}\right)}(I)} I \in C_{\left(\rho_{n}\right)}$ and this operator is not similar to a contraction.
The last assertion of the theorem follows from two facts. The first one is that $T \in C_{\left(\rho_{n}\right)}$ implies $T^{k} \in C_{\left(\rho_{k n}\right)}$. The second one is that $T^{k}$ is similar to a contraction if and only if $T$ is similar to a contraction: see [10, Problem 6,(ii)] for a proof when $k=2$ that extends to any $k$ by taking $((f, g)):=\sum_{j=1}^{k-1}\left\langle A^{j} f, A^{j} g\right\rangle$.

Proposition 4.10. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ be such that $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$.
(i) If $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=+\infty$, then $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}(H)=\mathcal{L}(H)$.
(ii) If $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)<+\infty$, then we have

$$
\left\{T: r(T)<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)\right\} \subset \bigcup_{r>0} C_{\left(r \rho_{n}\right)}(H) \subset\left\{T: r(T) \leq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)\right\}
$$

(iii) Moreover, we have

$$
\left\{T: r(T)<\lim _{n} \inf \left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)\right\}=\bigcup_{r>0} C_{\left(r \rho_{n}\right)}(H)
$$

if and only if

$$
w_{\left(r \rho_{n}\right)}\left(\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) \cdot I\right)>1, \forall r>0 .
$$

Proof. - (i) By using Proposition 4.6, for any $T$ there exists $r>0$ such that $w_{\left(r \rho_{n}\right)}(T) \leq 1$.

- (ii) We use again Proposition 4.6 in order to obtain the left-hand side inclusion. The other
inclusion follows from Proposition 2.6.
- (iii) Suppose that there is a number $r>0$ and an operator $T$ with $r(T)=\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$ such that $w_{\left(r \rho_{n}\right)}(T) \leq 1$. Then

$$
1 \geq w_{\left(r \rho_{n}\right)}(T) \geq r(T) w_{\left(r \rho_{n}\right)}(I) \geq \frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}=1
$$

Thus all inequalities are equalities, and $w_{\left(r \rho_{n}\right)}\left(\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) \cdot I\right)=1$. Hence, the union of all $C_{\left(r \rho_{n}\right)}$ strictly contains $\left\{T: r(T)<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)\right\}$ if and only if it contains $\left(\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) I\right)$. The proof is complete.

Remark 4.11. - Replacing $\left(\rho_{n}\right)_{n}$ by $\left(e^{i t} \rho_{n}\right)_{n}$ leaves unchanged the quantity $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$. However, the union of all classes $C_{\left(r \rho_{n}\right)}$ can become a different set.
With $\rho_{n}=\rho$, we have $\liminf \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=1$ and $w_{(\rho)}(I)=1$ if and only if $\rho \in[1,+\infty[$. Thus,

$$
\bigcup_{r>0} C_{\left(r e^{i t}\right)_{n}}(H)=\{T: r(T)<1\} \text { if } t \neq 0[2 \pi] .
$$

This is not an equality if $t=0$ (look at the identity operator $I$ ). However, the set $\bigcup_{r>0} C_{(r)}(H)$ does not contain all operators with spectral radius one. Indeed, it has been proven in [17, Ch.2] (see also [4, Cor 5.2.1]) that all operators contained in this union are all similar to contractions. Furthermore, all operators similar to a contraction are not in this union. For a counterexample, any non-orthogonal projection T (that is $T^{2}=T$ and $\|T\|>1$ ) is not in this union since Corollary $4.3,(v)$, says that $w_{(\rho)}(T)=\frac{\|T\|+|\rho-1|}{|\rho|}>1$.

- For a sequence $\left(\rho_{n}\right)_{n}$ that satisfies $\left.\alpha=\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) \in\right] 0,+\infty[$, we can go back to the case $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=1$ by considering the sequence $\left(\frac{\rho_{n}}{\alpha^{n}}\right)_{n}$. As this normalization is equivalent to a dilation by a factor $\frac{1}{\alpha}$ on the class $C_{\left(\rho_{n}\right)}$, we can then try to see if in this case the class $C_{\left(\rho_{n}\right)}$ is always included in the set of operators that are similar to contractions. This question is motivated by Properties 4.10 and 4.9. The answer is true when $w_{\left(\rho_{n}\right)}(I)>1$, but Corollary 4.18 will give a negative answer in many remaining cases, even if we consider the inclusion in the set of power-bounded operators.

At this point we would like to mention that, for every $k \geq 2$, there is ([9]) a Hilbert space operator $T \notin \cup_{\rho>0} C_{\rho}$ but with $T^{k}$ belonging to $C_{(\tau)}$ for every $\tau \geq 1$. Related results are given in the next proposition.

Proposition 4.12. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ be such that $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. Let H a Hilbert space of dimension at least 2.
(i) For $T \in \mathcal{L}(H)$ with $T^{2}=0$ and $\|T\|>\left|\rho_{1}\right|, T^{k}$ is in the class $C_{\left(\rho_{n}\right)}$ for every $k \geq 2$, but $T$ is not.
(ii) If $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>1$, then $T^{k} \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ for some $k \geq 2$ implies that $T \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$.
(iii) If $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)<1$, then there exists $T \in \mathcal{L}(H)$ such that $T^{k}$ lies in $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ for every $k \geq 2$ whereas $T$ does not.
(iv) If $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=1$ and $I \notin \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$, then $T^{k} \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ for some $k \geq 2$ implies that $T \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$.
Proof. - (i) As we have $\|T\|>\left|\rho_{1}\right|, T$ cannot lie in $C_{\left(\rho_{n}\right)}$, whereas $T^{k}=0$ does.

- (ii) Let $T$ be such that $T^{k} \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ for some $k \geq 2$. Then, $r\left(T^{k}\right) \leq \liminf \operatorname{in}_{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)$. Hence,

$$
r(T) \leq \liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)^{\frac{1}{k}}<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right),
$$

that is $T \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ according to Proposition 4.10, (i) and (ii).

- (iii) Take $r>0$ such that

$$
\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)<r<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)^{\frac{1}{2}},
$$

and denote $T=r . I$. Thus, using item (ii) of Proposition 4.10, we can see that since for every $k \geq 2$ we have

$$
r\left(T^{k}\right) \leq r\left(T^{2}\right)<\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)<r(T)
$$

$T$ doesn't lie in $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ whereas $T^{k}$ does.

- (iv) If $T^{k} \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$, then $r\left(T^{k}\right)<1$ according to item (iii) of Proposition 4.10. This implies that $r(T)<1$, which implies in turn that $T \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$.
Remark 4.13. - As the classes $C_{\left(r \rho_{n}\right)}$ are increasing for the inclusion of sets, the assertion $T \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ is equivalent to the existence of $R>0$ such that $T \in C_{\left(r \rho_{n}\right)}$ for every $r \geq R$. When $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=1$ and $I \in \bigcup_{r>0} C_{\left(r \rho_{n}\right)}$, which is the case when $\rho_{n}=\rho>0$, we do not know if the result of Găvruţa [9] stays true, as the type of operators he used in his proof is not suited in this setting: since there are sequences $\left(\rho_{n}\right)$ such that $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ contains all power-bounded operators (see Corollary 4.18), taking a $T$ such that $T^{k}=I$ will not work.
Example 4.14. - For $\rho_{n}=2(n!)$, we have $I+f_{\left(\rho_{n}\right)}(z T)=\exp (z T)$, and a quick computation gives $w_{(2(n!))}(I)=\frac{2}{\pi}<1$ (see item (iv) of Example 4.20 for another proof). Therefore $\frac{\pi}{2} I \in$ $C_{(2(n!))}(H)$ and this class contains an operator not similar to a contraction.

We can also try to obtain some relationships between the $\left(\gamma_{n} \rho_{n}\right)$-radii of an operator, for sequences $\left(\gamma_{n}\right)_{n} \in \partial \mathbb{D}^{\mathbb{N}^{*}}$, in order to see for which sequences $\left(\gamma_{n}\right)_{n}$ the maximal or minimal radii are attained. The following Lemma answers the question for the maximal radii when $T=I$.
Lemma 4.15. - Let $\left(\rho_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ be such that $\alpha=\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$. If $\lim _{x \rightarrow \alpha^{-}} f_{\left(\left|\rho_{n}\right|\right)}(x)>$ 1 , then $f_{\left(\left|\rho_{n}\right|\right)}(x)=1$ has a unique solution, $r_{1}$, on $] 0, \alpha\left[\right.$. Otherwise, denote $r_{1}=\alpha$. We then have:
(i) $w_{\left(-\left|\rho_{n}\right|\right)}(I)=\frac{1}{r_{1}}$;
(ii) $w_{\left(-\left|\rho_{n}\right|\right)}(I) \geq w_{\left(\gamma_{n} \rho_{n}\right)}(I) \geq \frac{1}{\alpha}$, for any $\left(\gamma_{n}\right)_{n} \in \partial \mathbb{D}^{\mathbb{N}^{*}}$;
(iii) The condition

$$
w_{\left(r \gamma_{n} \rho_{n}\right)}(I)=\frac{1}{\alpha}, \forall r \geq 1, \forall \gamma_{n} \in \partial \mathbb{D}
$$

is equivalent to

$$
\lim _{x \rightarrow \alpha^{-}} f_{\left(\left|\rho_{n}\right|\right)}(x) \leq 1
$$

and to

$$
w_{\left(-\left|\rho_{n}\right|\right)}(I)=\frac{1}{\alpha}
$$

Proof. - $(i),(i i)$ The right-hand side inequality of $(i i)$ is the last inequality of Lemma 2.12. For any $z \in \mathbb{D}(0, \alpha)$ and $\gamma_{n} \in \partial \mathbb{D}$, we have

$$
\left|f_{\left(\gamma_{n} \rho_{n}\right)}(z)\right| \leq \sum_{n \geq 1} \frac{2|z|^{n}}{\left|\rho_{n}\right|}=f_{\left(\left|\rho_{n}\right|\right)}(|z|) .
$$

Also, the map $x \mapsto f_{\left(\left|\rho_{n}\right|\right)}(x)$ is strictly increasing on $] 0, \alpha\left[\right.$, as $f_{\left(\left|\rho_{n}\right|\right)}$ is non-constant with positive Taylor coefficients, so if $\lim _{x \rightarrow \alpha^{-}} f_{\left(\left|\rho_{n}\right|\right)}(x)>1$ the real number $r_{1}$ is indeed unique. Let $u>0$ be such that $u \geq \frac{1}{r_{1}} \geq \frac{1}{\alpha}$. Then $\frac{1}{u} \leq r_{1}$ and

$$
\lim _{x \rightarrow \frac{1^{-}}{u}} f_{\left|\rho_{n}\right|}(x) \leq 1
$$

Since we have

$$
f_{\left(\gamma_{n} \rho_{n}\right)}\left(\mathbb{D}\left(0, \frac{1}{u}\right)\right) \subset \mathbb{D}\left(0, \lim _{x \rightarrow \frac{1^{-}}{u}} f_{\left(\left|\rho_{n}\right|\right)}(x)\right) \subset \mathbb{D},
$$

Proposition 2.18 implies that $w_{\left(\gamma_{n} \rho_{n}\right)}(I) \leq \frac{1}{r_{1}}$. When $\gamma_{n}=-\frac{\overline{\rho_{n}}}{\left|\rho_{n}\right|}$, we have

$$
f_{\left(\gamma_{n} \rho_{n}\right)}(x)=f_{\left(-\left|\rho_{n}\right|\right)}(x)=-f_{\left(\left|\rho_{n}\right|\right)}(x) .
$$

Thus, the negative number $\lim _{x \rightarrow \frac{1}{u}}-\left(-f_{\left(\left|\rho_{n}\right|\right)}(x)\right)$ lies in the adherence of $f_{\left(-\left|\rho_{n}\right|\right)}\left(\mathbb{D}\left(0, \frac{1}{u}\right)\right)$, and the smallest $u \geq \frac{1}{\alpha}$ such that

$$
f_{\left(-\left|\rho_{n}\right|\right)}\left(\mathbb{D}\left(0, \frac{1}{u}\right)\right) \subset R e_{\geq-1}
$$

is $\frac{1}{r_{1}}$. Hence,

$$
w_{\left(-\left|\rho_{n}\right|\right)}(I)=\frac{1}{r_{1}} \geq w_{\left(\gamma_{n} \rho_{n}\right)}(I)
$$

- (iii) By (ii) and using that $r \mapsto w_{\left(r \gamma_{n} \rho_{n}\right)}(I)$ is decreasing, we have

$$
w_{\left(r \gamma_{n} \rho_{n}\right)}(I)=\frac{1}{\alpha}, \forall r \geq 1, \forall\left(\gamma_{n}\right)_{n} \in \partial \mathbb{D}^{\mathbb{N}^{*}}
$$

if and only if

$$
w_{\left(-\left|\rho_{n}\right|\right)}(I)=\frac{1}{\alpha} .
$$

This equation is equivalent to $r_{1}=\alpha$, that is $\lim _{x \rightarrow \alpha^{-}}\left(f_{\left(\left|\rho_{n}\right|\right)}(x)\right) \leq 1$.
We do not know if the $\left(\left|\rho_{n}\right|\right)$-radius of $I$ is always the minimal one.
The idea of the proof of Lemma 4.15 can be transported to any operator $T$ if we add a summability condition to the sequence $\left(\rho_{n}\right)_{n}$.
Proposition 4.16. - Let $a=\left(a_{n}\right)_{n} \in\left(\mathbb{C}^{*}\right)^{\mathbb{N}^{*}}$ be such that $\sum_{n \geq 1} \frac{1}{\left|a_{n}\right|} \leq 1$. Let $T \in \mathcal{L}(H)$ and define

$$
\rho_{n}:=\left\{\begin{array}{l}
2 a_{n}\left\|T^{n}\right\| \text { if } T^{n} \neq 0 \\
1 \text { otherwise }
\end{array}\right.
$$

(i) If $r(T)>0$ or if $T$ is nilpotent, then $T \in C_{\left(\rho_{n}\right)}$.
(ii) If $r(T)>0$ and $\liminf _{n}\left(\left|a_{n}\right|^{\frac{1}{n}}\right)=1$, then $w_{\left(z_{n} \rho_{n}\right)}(T)=1$, for all $z_{n}$ such that $\left|z_{n}\right| \geq 1$ and $\lim _{n}\left(\left|z_{n}\right|^{\frac{1}{n}}\right)=1$.

Proof. - (i) Suppose first that $r(T)>0$. Since $\sum_{n} \frac{1}{\left|a_{n}\right|}<+\infty$, we have $\lim _{\inf }^{n}\left(\left|a_{n}\right|^{\frac{1}{n}}\right) \geq 1$, thus $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right) \geq r(T)>0$. We also have:

$$
\left\|f_{\left(\rho_{n}\right)}(z T)\right\| \leq \sum_{n \geq 1} \frac{2|z|^{n}| | T^{n} \|}{2\left|a_{n}\right|\left\|T^{n}\right\|} \leq \sum_{n \geq 1} \frac{1}{\left|a_{n}\right|} \leq 1 .
$$

Thus, $I+\operatorname{Re}\left(f_{\left(\rho_{n}\right)}(z T)\right) \geq\left(1-\left\|f_{\left(\rho_{n}\right)}(z T)\right\|\right) I \geq 0$ for all $z \in \mathbb{D}$, so $T \in C_{\left(\rho_{n}\right)}$. If $T$ is nilpotent then $f_{\left(\rho_{n}\right)}(z T)$ becomes a finite sum and the same computation gives the result, as $\lim \inf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)>0$.


$$
1 \geq w_{\left(\rho_{n}\right)}(T) \geq \frac{r(T)}{\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)}=1
$$

Thus $w_{\left(\rho_{n}\right)}(T)=1$. If we multiply each $a_{n}$ by a complex number $z_{n}$ with $\left|z_{n}\right| \geq 1$ and $\lim _{n}\left(\left|z_{n}\right|^{\frac{1}{n}}\right)=1$, the sum $\sum_{n \geq 1} \frac{1}{\left|z_{n} a_{n}\right|}$ decreases, while $\liminf _{n}\left(\left|z_{n} a_{n}\right|^{\frac{1}{n}}\right)=1$. Thus, we can apply the previous result to $\left(z_{n} \rho_{n}\right)_{n}$ and obtain $w_{\left(z_{n} \rho_{n}\right)}(T)=1$.

Remark 4.17. - For any $T$ with $r(T)>0$, if we take a sequence $\left(\rho_{n}\right)_{n}$ as in item (ii) of the previous Proposition, then the result says that $z \mapsto w_{\left(z \rho_{n}\right)}(T)$ is constant and equal to 1 on $\mathbb{C} \backslash \mathbb{D}$.

- The choice of $\left(\rho_{n}\right)_{n}$ only depends on $\left\|T^{n}\right\|$. For example, with any $T$ normal with $\|T\|=1$, by taking $a_{n}=\frac{\pi^{2}}{6} n^{2}$, we have $w_{\left(2 a_{n} z_{n}\right)}(T)=1$ for any sequence $\left(z_{n}\right)_{n}$ such that $1 \leq\left|z_{n}\right|$ and $\sup \left|z_{n}\right|<+\infty$.
- If $T$ is quasinilpotent but not nilpotent, we have $\lim _{\inf }^{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=0$. However, the statement of item ( $i$ ) holds true for such a $T$, with a very similar proof.

Using the ideas in the proof of Proposition 4.16, we can show that some sets $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ largely differ from $\bigcup_{\rho>0} C_{(\rho)}$ or $\{T: r(T)<1\}$ even if $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=1$.

Corollary 4.18. - Let $\left(\rho_{n}\right)_{n}$ be such that $\liminf _{n}\left(\left|\rho_{n}\right|^{\frac{1}{n}}\right)=1$. The following assertions are true:
(i) If $\left(\frac{1}{\rho_{n}}\right) \in \ell^{1}$, then $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ contains all power-bounded operators;
(ii) If $f_{\left(\rho_{n}\right)} \in H^{\infty}(\mathbb{D})$ and $f_{\left(\rho_{n}\right)}^{\prime} \in H^{\infty}(\mathbb{D})$, then $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ contains an operator that is not power-bounded.
(iii) If $n^{k+1+\epsilon}=O\left(\left|\rho_{n}\right|\right)$ for $k \in \mathbb{N}^{*}$ and some $\epsilon>0$, then $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ contains all operators $T$ such that $\left\|T^{n}\right\|=O\left(n^{k}\right)$.

Proof. - (i) Let $T$ be a power-bounded operator with $\left\|T^{n}\right\| \leq C$. Let $r>0$ and $z \in \mathbb{D}$. We have

$$
\left\|f_{\left(r \rho_{n}\right)}(z T)\right\| \leq \sum_{n \geq 1} \frac{2}{r\left|\rho_{n}\right|}|z|^{n}\left\|T^{n}\right\| \leq \frac{2 C}{r} \sum_{n \geq 1} \frac{1}{\left|\rho_{n}\right|}<+\infty .
$$

Hence, for $r$ large enough, we have $\left\|f_{\left(r \rho_{n}\right)}(z T)\right\| \leq 1$ for every $z \in \mathbb{D}$. This implies that

$$
I+\operatorname{Re}\left(f_{\left(r \rho_{n}\right)}(z T) \geq 0, \forall z \in \mathbb{D} .\right.
$$

This in turn implies that $T \in C_{\left(r \rho_{n}\right)}$ since we also know that $r(T) \leq 1=\liminf _{n}\left(\left|r \rho_{n}\right|^{\frac{1}{n}}\right)$.

- (ii) We first note that both the entire series $f_{\left(\frac{\rho_{n}}{n}\right)}(z)=\sum_{n \geq 1} \frac{2 n}{\rho_{n}} z^{n}$ and $f_{\left(\rho_{n}\right)}$ have radii of convergence 1 , so their sum is analytic on $\mathbb{D}$. We also have $f_{\left(\frac{\rho_{n}}{n}\right)}(z)=z f_{\left(\rho_{n}\right)}^{\prime}(z)$. Let $N$ be a nilpotent operator of order 2 and set $T=I+N$. Since $T^{n}=I+n N$, we have $\left\|T^{n}\right\| \simeq n .\|N\|$ so $T$ is not power-bounded. We will show that $T$ belongs to a class $C_{\left(r \rho_{n}\right)}$ for large enough $r>0$. Let $r>0$ and $z \in \mathbb{D}$. We have:

$$
\begin{aligned}
\left\|f_{\left(r \rho_{n}\right)}(z T)\right\| & =\left\|\sum_{n \geq 1} \frac{2}{r \rho_{n}} z^{n}(I+n N)\right\|=\left\|\frac{1}{r} f_{\left(\rho_{n}\right)}(z) I+\frac{1}{r} z f_{\left(\rho_{n}\right)}^{\prime}(z) N\right\| \\
& \leq \frac{1}{r}\left(\left\|f_{\left(\rho_{n}\right)}\right\|_{H^{\infty}}+\left\|f_{\left(\rho_{n}\right)}^{\prime}\right\|_{H^{\infty}}\|N\|\right)<+\infty
\end{aligned}
$$

Hence, for $r$ large enough, we have $\left\|f_{\left(r \rho_{n}\right)}(z T)\right\| \leq 1$ for every $z \in \mathbb{D}$, which implies that

$$
I+\operatorname{Re}\left(f_{\left(r \rho_{n}\right)}(z T) \geq 0, \forall z \in \mathbb{D} .\right.
$$

This in turn implies that $T \in C_{\left(r \rho_{n}\right)}$ since we also know that $r(T)=1=\liminf _{n}\left(\left|r \rho_{n}\right|^{\frac{1}{n}}\right)$.

- (iii) Let $T$ be such that $\left\|T^{n}\right\|=O\left(n^{k}\right)$ and let $z \in \mathbb{D}$. We have $\frac{\left\|T^{n}\right\|}{\left|\rho_{n}\right|}=O\left(\frac{1}{n^{1+\epsilon}}\right)$, so this sequence is in $\ell^{1}$. If $T$ is nilpotent, then $T$ is power-bounded and we can apply ( $i$ ) to get a positive $r>0$ such that $T \in C_{\left(r \rho_{n}\right)}$. Otherwise, we can consider the complex numbers

$$
a_{n}:=\frac{\rho_{n}}{\left\|T^{n}\right\|}\left\|\left(\frac{\left\|T^{n}\right\|}{\left|\rho_{n}\right|}\right)_{n}\right\|_{\ell^{1}} .
$$

We have

$$
\sum_{n \geq 1} \frac{1}{\left|a_{n}\right|}=\left\|\left(\frac{\left\|T^{n}\right\|}{\left|\rho_{n}\right|}\right)_{n}\right\|_{\ell^{1}}^{-1} \sum_{n \geq 1} \frac{\left\|T^{n}\right\|}{\left|\rho_{n}\right|}=1 .
$$

Thus, for $\tau_{n}:=2 a_{n}\left\|T^{n}\right\|$, we can use Proposition 4.16 to obtain $T \in C_{\left(\tau_{n}\right)}$. Since $\tau_{n}=$ $2 \rho_{n}\left\|\left(\frac{\left\|T^{n}\right\|}{\left|\rho_{n}\right|}\right)_{n}\right\|_{\ell^{1}}$, we have $\tau_{n}=r \rho_{n}$ for some $r>0$, which concludes the proof.

The condition $f_{\left(\rho_{n}\right)}^{\prime} \in H^{\infty}(\mathbb{D})$ implies that the sequence $\left(\frac{n}{\rho_{n}}\right)_{n}$ is bounded, but it does not imply the condition $\left(\frac{1}{\rho_{n}}\right) \in \ell^{1}$ from $(i)$. Thus, for a sequence $\left(\rho_{n}\right)$ satisfying the conditions of item (ii), the set $\bigcup_{r>0} C_{\left(r \rho_{n}\right)}$ may not contain every power-bounded operator.

Some examples. We conclude this paper by providing a computation of $w_{\left(z \rho_{n}\right)}(I)$ in two examples, where sequences $\left(\rho_{n}\right)_{n}$ were chosen to match some common analytic maps. The difficulty lies in the computation of the boundary of $f_{\left(z \rho_{n}\right)}\left(\mathbb{D}\left(1, \frac{1}{u}\right)\right)$, as some specific points on the boundary do not always have an explicit expression.

Example 4.19. - Let $R>0$ and $-\pi<t \leq \pi$. We have:
(i) $I+f_{\left(R e^{i t} n\right)}(z I)=I-\frac{2}{R \cdot e^{i t}} \log (1-z I)$;
(ii) $w_{\left(R e^{i t} n\right)}(I)=1$ if $t=0$ and $R \geq 2 \log (2)$;
(iii) $w_{\left(R e^{i t} n\right)}(I)=\frac{1}{\exp \left(\frac{R}{2}\right)-1}>1$ if $t=0$ and $0<R<2 \log (2)$;
(iv) $w_{\left(R e^{i t} n\right)}(I)=\frac{1}{1-\exp \left(\frac{-R}{2}\right)}>1$ if $t=\pi$;
(v) $w_{\left(R e^{i t} n\right)}(I)=1$ if $t= \pm \frac{\pi}{2}$ and $R \geq \pi$;
(vi) $w_{\left(R e^{i t} n\right)}(I)=\frac{1}{\sin \left(\frac{R}{2}\right)}$ if $t= \pm \frac{\pi}{2}$ and $0<R<\pi$;
(vii) $w_{\left(\operatorname{Re}^{i t} n\right)}(I)=1$ if $0<|t|<\frac{\pi}{2}$ and $R \geq 2 \cos (t) \log (2 \cos (t))+2 \sin (t) t$;
(viii) If we have $0<|t|<\frac{\pi}{2}$ and $0<R<2 \cos (t) \log (2 \cos (t))+2 \sin (t) t$, then

$$
w_{\left(R e^{i t} n\right)}(I)=\inf \left(\left\{u>1: 1-\frac{2}{R} g_{t}(u) \geq 0\right\}>1\right.
$$

with $g_{t}(u):=\cos (t) \log \left(\frac{\sqrt{u^{2}-\sin (t)^{2}}+\cos (t)}{u}\right)+\arcsin \left(\frac{\sin (t)}{u}\right) \sin (t)$.
The same holds if $\frac{\pi}{2}<|t|<\pi$.

Proof. Let $R>0, t \in]-\pi, \pi]$. As $n \in \mathbb{R}$, we have $w_{\left(R e^{-i t} n\right)}(I)=w_{\left(R e^{i t} n\right)}(I)$, so we can restrict the study to $t \in[0, \pi]$. A direct computation gives:

$$
f_{\left(R . e^{i t} n\right)}(z T)=-\frac{2}{R e^{i t}} \log (1-z T)
$$

As $\lim \inf _{n}\left(|n|^{\frac{1}{n}}\right)=1$, we have $w_{\left(\operatorname{Re}^{i t} n\right)}(I) \geq 1$. Thus, we consider those $u>1$ such that $I+\operatorname{Re}\left(f_{\left(R . e^{i t} n\right)}\left(\frac{z I}{u}\right)\right)$ is positive for every $z \in \mathbb{D}$. It is equivalent to look at the positivity of

$$
1+\operatorname{Re}\left(f_{\left(R \cdot e^{i t} n\right)}\left(\frac{z}{u}\right)\right)=1-\frac{2}{R} R e\left(e^{-i t} \log \left(1-\frac{z}{u}\right)\right)
$$

We start off by studying the boundary of $\log \left(\mathbb{D}\left(1, \frac{1}{u}\right)\right)$. By analyticity, we have $\partial \log \left(\mathbb{D}\left(1, \frac{1}{u}\right)\right) \subset$ $\log \left(\partial \mathbb{D}\left(1, \frac{1}{u}\right)\right)$. As $\log \left(e^{i s} \mathbb{R} \cap \mathbb{D}\left(1, \frac{1}{u}\right)\right)$ is a horizontal interval that is non-empty if and only if $|s| \leq$ $\arcsin \left(\frac{1}{u}\right)$, the previous sets are equal and $\log \left(\mathbb{D}\left(1, \frac{1}{u}\right)\right)$ is convex. Thus, the set $\log \left(\partial \mathbb{D}\left(1, \frac{1}{u}\right)\right)$ can be parametrized by two arcs depending on the imaginary part of its elements:

$$
s \mapsto \log \left(\cos (s) \pm \frac{1}{u} \sqrt{1-\sin (s)^{2} u^{2}}\right)+i s, s \in\left[-\arcsin \left(\frac{1}{u}\right) ; \arcsin \left(\frac{1}{u}\right)\right]
$$

We want to compute the minimum of $1-\frac{2}{R} R e\left(e^{-i t} \log \left(1-\frac{e^{i s}}{u}\right)\right)$ in order to find for which $u>1$ this minimum is non-negative. For the cases $t=0, t=\pi$, and $t=\frac{\pi}{2}$, computing this minimum amounts to finding the extrema of the real or imaginary part of the elements in $\log \left(\partial \mathbb{D}\left(1, \frac{1}{u}\right)\right)$. As these extrema are $\log \left(1 \pm \frac{1}{u}\right)$ for the real part and $\pm \arcsin \left(\frac{1}{u}\right)$ for the imaginary part, an easy computation gives all the $u>1$ such that $\inf _{w \in \mathbb{R}}\left(1-\frac{2}{R} R e\left(e^{-i t} \log \left(1-\frac{e^{i w}}{u}\right)\right)\right) \geq 0$ in all three cases, which proves the items $(i i),(i i i),(i v),(v),(v i)$.
For $0<t<\frac{\pi}{2}$, computing this minimum leads to searching the lower bound of

$$
f_{1}(s):=\cos (\pi-t) \log \left(\cos (s)-\frac{1}{u} \sqrt{1-\sin (s)^{2} u^{2}}\right)-s \sin (\pi-t)
$$

For $\frac{\pi}{2}<t<\pi$, computing this minimum leads to searching the lower bound of

$$
f_{2}(s):=\cos (\pi-t) \log \left(\cos (s)+\frac{1}{u} \sqrt{1-\sin (s)^{2} u^{2}}\right)-s \sin (\pi-t)
$$

The derivatives of these maps are:

$$
f_{1}^{\prime}(s)=\frac{\sin (s) u \cos (\pi-t)}{\sqrt{1-\sin (s)^{2} u^{2}}}-\sin (\pi-t), f_{2}^{\prime}(s)=-\frac{\sin (s) u \cos (\pi-t)}{\sqrt{1-\sin (s)^{2} u^{2}}}-\sin (\pi-t)
$$

Both of them only have one zero, at $s=-\arcsin \left(\frac{\sin (t)}{u}\right)$. And in both cases the searched minimum for $1-\frac{2}{R} \operatorname{Re}\left(e^{-i t} \log \left(1-\frac{e^{i s}}{u}\right)\right)$ is:

$$
1-\frac{2}{R}\left[\cos (t) \log \left(\frac{\sqrt{u^{2}-\sin (t)^{2}}+\cos (t)}{u}\right)+\arcsin \left(\frac{\sin (t)}{u}\right) \sin (t)\right]=1-\frac{2}{R} g_{t}(u) .
$$

If $0<t<\frac{\pi}{2}$, this minimum decreases towards $1-\frac{2}{R} g_{t}(1):=1-\frac{2}{R}[\cos (t) \log (2 \cos (t))+t \sin (t)]$ when $u \rightarrow 1^{+}$. So $\frac{I}{u} \in C_{\left(R e^{i t} n\right)}$ for every $u>1$ if and only if $1-\frac{2}{R} g_{t}(1) \geq 0$, that is $R \geq 2 g_{t}(1)$. This proves item (vii) and half of item (viii).
If $\frac{\pi}{2}<t<\pi$, this minimum decreases towards $-\infty$ as $u \rightarrow 1^{+}$, so the smallest $u$ for which this minimum is non-negative verifies $u>1$ and $w_{\left(\operatorname{Re}^{i t} n\right)}(I)=u$. This gives the other half of item (viii) and concludes the proof.

Example 4.20. - Let $R>0$ and $-\pi<t \leq \pi$. We have:
(i) $I+f_{\left(R e^{i t} n!\right)}(z I)=I+\frac{2}{R \cdot e^{i t}}(\exp (z I)-I)$;
(ii) $w_{\left(R e^{i t} n!\right)}(I)=\frac{1}{\log \left(\frac{R}{2}+1\right)}$ if $t=\pi$;
(iii) $w_{\left(R e^{i t} n!\right)}(I)=\frac{1}{\log \left(\frac{2}{2-R}\right)}$ if $t=0$ and $0<R \leq 2-\frac{2}{e}$;
(iv) $w_{\left(R e^{i t} n!\right)}(I)=\frac{1}{\frac{\pi}{2}-t}$ if $0 \leq|t|<\frac{\pi}{2}$ and $R=2 \cos (t)$;
(v) $w_{\left(R e^{i t} n!\right)}(I) \leq \frac{1}{\log \left(\frac{R}{2}-\cos (t)\right)}$ for $R>2+2 \cos (t)$;
(vi) $w_{\left(R e^{i t} n!\right)}(I) \geq \frac{1}{\sqrt{\pi^{2}+\log \left(\frac{R}{2 \cos (t)}-1\right)^{2}}}$ if $0 \leq|t|<\frac{\pi}{2}$ and $R>4 \cos (t)$;
(vii) In general, we have

$$
\begin{aligned}
& w_{\left(R e^{i t} . n!\right)_{n}}(I)=\inf \left(\left\{u>0: \forall \theta \in[-\pi, \pi] \text { with } \theta+\frac{\sin (\theta)}{u}=t+k \pi,\right.\right. \\
& k\left.\left.\in \mathbb{Z} \text {, we have }(-1)^{k} e^{\frac{\cos (\theta)}{u}} \cos (\theta) \geq \cos (t)-\frac{R}{2}\right\}\right) .
\end{aligned}
$$

For $R \geq 2 e^{\pi / 2}-2$, we can restrict the infimum after $u$ in $\left.] 0, \frac{2}{\pi}\right]$ and to the smallest $\left.\theta \in] \frac{-\pi}{2}, 0\right]$ such that $\theta+\frac{\sin (\theta)}{u}=t+k \pi$.

Proof. Let $R>0, t \in[-\pi, \pi]$ and $u>0$. As $n \in \mathbb{R}$, we have $w_{\left(R e^{-i t} n!\right)}(I)=w_{\left(R e^{i t} n!\right)}(I)$, so we restrict the study to $t \in[0, \pi]$. A computation gives

$$
I+f_{\left(R e^{i t} n!\right)}(z I)=I+\frac{2}{R \cdot e^{i t}}(\exp (z I)-I)
$$

We will first use Lemma 4.15 to compute $w_{(-R n!)}(I)$ and rule out the case $t=\pi$. As $f_{(R n!)}(x)=$ $\frac{2}{R}(\exp (x)-1)$, we get

$$
f_{(R n!)}(x)=1 \Leftrightarrow x=\log \left(\frac{R}{2}+1\right)
$$

Hence, $w_{(-R n!)}(I)=\frac{1}{\log \left(\frac{R}{2}+1\right)}$ and item (ii) is proved.
As $\lim \inf _{n}\left(|n!|^{\frac{1}{n}}\right)=+\infty$, we have $\frac{I}{u} \in C_{\left(R e^{i t} n!\right)}$ if and only if $u \geq w_{\left(R e^{i t} n!\right)}(I)$, if and only if
$I+\operatorname{Re}\left(f_{\left(R e^{i t} n!\right)}\left(z \frac{I}{u}\right)\right)$ for every $z \in \mathbb{D}$. Thus, we need to study the positivity of

$$
1+\operatorname{Re}\left(f_{\left(R e^{i t} n!\right)}\left(\frac{z}{u}\right)\right)=1+\frac{2}{R} R e\left(e^{-i t}\left(\exp \left(\frac{z}{u}\right)-1\right)\right)
$$

for every $z \in \mathbb{D}$ and for any $u>0$. By analyticity, we only need to make the computations for $z \in \partial \mathbb{D}$. We have

$$
\begin{aligned}
& 1+\frac{2}{R} \operatorname{Re}\left(\exp \left(\frac{z}{u}-i t\right)-e^{-i t}\right) \geq 0 \\
\Leftrightarrow & \exp \left(\operatorname{Re}\left(\frac{z}{u}\right)\right) \cos \left(\frac{\operatorname{Im}(z)}{u}-t\right) \geq-\frac{R}{2}+\cos (t)
\end{aligned}
$$

Denote, for $s \in[-\pi, \pi]$,

$$
g_{u}(s):=e^{\frac{\cos (s)}{u}} \cos \left(t-\frac{\sin (s)}{u}\right)
$$

Thus, $\frac{I}{u} \in C_{\left(R e^{i t} n!\right)}$ is equivalent to

$$
\min _{s \in[-\pi, \pi]}\left(g_{u}(s)\right) \geq-\frac{R}{2}+\cos (t)
$$

Therefore, this inequality will be verified if and only if $u \geq w_{\left(R e^{i t} n!\right)}(I)$. Also, since

$$
\min _{s}\left(g_{u}(s)\right)=\min _{|w|=\frac{1}{u}}(\operatorname{Re}(\exp (w-i t)))=\min _{|w|<\frac{1}{u}}(\operatorname{Re}(\exp (w-i t)))
$$

we can see that $\min _{s}\left(g_{u}(s)\right)$ is the minimum of a harmonic non-constant map over the disc $\mathbb{D}\left(0, \frac{1}{u}\right)$. The maximum principle implies that the map $u \mapsto \min _{s}\left(g_{u}(s)\right)$ is strictly increasing. Hence, $w_{\left(R e^{i t} n!\right)}(I)$ is the only number $u>0$ such that $\min _{s \in[-\pi, \pi]}\left(g_{u}(s)\right)=-\frac{R}{2}+\cos (t)$.
Let us focus now on the minimum of $g_{u}$. The derivative of $g_{u}$ is

$$
g_{u}^{\prime}(s)=\frac{1}{u} e^{\frac{\cos (s)}{u}} \sin \left(t-\frac{\sin (s)}{u}-s\right)
$$

Hence, the minimum of $g_{u}$ will be reached for a $s_{0}$ such that $h_{u}\left(s_{0}\right):=t-s_{0}-\frac{\sin \left(s_{0}\right)}{u}=k \pi$, for some $k \in \mathbb{Z}$. For such a $s_{0}$, we will also have

$$
g_{u}\left(s_{0}\right)=(-1)^{k} e^{\frac{\cos \left(s_{0}\right)}{u}} \cos \left(s_{0}\right)
$$

If $u \geq 1$, the map $h_{u}$ is strictly decreasing, with range $[t-\pi, t+\pi]$. Hence, there will only be 2 (resp. 3) values of $s$ such that $h_{u}(s)=k \pi$ if $\left.t \in\right] 0, \pi[$ (resp. $t=0$ ). If $t=0$ and $u \geq 1$, these values of $s$ will be $-\pi, 0, \pi$, and the minimum of $g_{u}$ will be $g_{u}(\pi)=\exp \left(\frac{-1}{u}\right)$. Thus, if $t=0$ and $w_{(R n!)}(I) \geq 1$, we will have

$$
\exp \left(\frac{-1}{w_{(R n!)}(I)}\right)=-\frac{R}{2}+1
$$

which is equivalent to $0<R \leq 2-\frac{2}{e}$. Thus $w_{(R n!)}(I)=\frac{1}{\log \left(\frac{2}{2-R}\right)}$, proving item (iii).
When $t \in] 0, \pi[$ and $u \geq 1$, we have however no explicit formula for the two values of $s$ mentioned above.
For $t \in\left[0, \frac{\pi}{2}\left[\right.\right.$ and $R=2 \cos (t)$, we will have $\min _{s}\left(g_{w_{\left(R e^{i t} n!\right)}(I)}(s)\right)=0$. As $e^{\frac{\cos (s)}{u}} \cos (s)=0$ if and only if $s= \pm \frac{\pi}{2}$, this minimum will be attained at $\frac{\pi}{2}$ or $\frac{-\pi}{2}$, and $w_{\left(R e^{i t} n!\right)}(I)$ will be the largest
$u>0$ such that $g_{u}\left(\frac{\pi}{2}\right)=0$ or $g_{u}\left(-\frac{\pi}{2}\right)=0$. The latter condition is equivalent to $\frac{1}{u} \pm t=\frac{\pi}{2}+k \pi$, that is $\frac{1}{u}=\frac{\pi}{2} \pm t+k \pi$. Since we have $0 \leq t<\frac{\pi}{2}$, the integer $k$ needs to be positive. By looking at the smallest possible value for $\frac{1}{u}$ we get $w_{\left(R^{i t} n!\right)}(I)=\frac{1}{\frac{\pi}{2}-t}$, proving item $(i v)$.
In general, we can see that $\min _{s}\left(g_{u}(s)\right) \geq-e^{\frac{1}{u}}$. When $R>2+2 \cos (t)$, the inequality $-e^{\frac{1}{u}} \geq$ $\cos (t)-\frac{R}{2}$ is equivalent to $u \geq \frac{1}{\log \left(\frac{R}{2}-\cos (t)\right)}$, which proves item $(v)$.
If $u \pi<1$, we have $u \pi=\sin (\alpha)$ for some $\alpha>0$, and $g_{u}(\alpha)=-\cos (t) e^{\frac{\sqrt{1-u^{2} \pi^{2}}}{u}}$. When $R>$ $4 \cos (t)$, the inequality $g_{u}(\alpha) \leq \cos (t)-\frac{R}{2}$ is equivalent to $u \leq \frac{1}{\sqrt{\pi^{2}+\log \left(\frac{R}{2 \cos (t)}-1\right)^{2}}}$. Item $(v i)$ is now proved.
Taking $R \geq 2 e^{\pi / 2}-2=R_{0}$, we get $-\frac{R}{2}+1 \leq 2-e^{\pi / 2}<-1$ and

$$
w_{\left(\operatorname{Re}^{i t} n!\right)}(I) \leq w_{(-R n!)}(I) \leq w_{\left(-R_{0} n!\right)}(I)=\frac{2}{\pi},
$$

for every $0 \leq t \leq \pi$, according to Lemma 4.15. We can then see that for $u=w_{\left(R e^{i t} n!\right)}(I)$ and for a number $s_{0}$ such that $g_{u}\left(s_{0}\right)=\min _{s}\left(g_{u}(s)\right)$ and $h_{u}\left(s_{0}\right)=k \pi$, the relationship

$$
(-1)^{k} e^{\frac{\cos \left(s_{0}\right)}{u}} \cos \left(s_{0}\right)=g_{u}\left(s_{0}\right)=-\frac{R}{2}+\cos (t)<-1
$$

implies that $\cos \left(s_{0}\right)>0$ and that $k$ is odd. In this case, $\left|s_{0}\right|$ will be the smallest real $s$ in $\left[0, \frac{\pi}{2}[\right.$ such that $h_{u}(s)$ or $h_{u}(-s)$ is equal to $k \pi$ with $k$ odd. As we also have $h_{u}\left(\frac{-\pi}{2}\right)=t+\frac{\pi}{2}+\frac{1}{u} \geq$ $\pi \geq t=h_{u}(0) \geq 0$, we can see that $s_{0}$ lies in $\left.] \frac{-\pi}{2}, 0\right]$. This gives all the announced results.
