# On numerical semigroups with at most 12 left elements 

S. Eliahou and D. Marín-Aragón


#### Abstract

For a numerical semigroup $S \subseteq \mathbb{N}$ with embedding dimension $e$, conductor $c$ and left part $L=S \cap[0, c-1]$, set $W(S)=e|L|-c$. In 1978 Wilf asked, in equivalent terms, whether $W(S) \geq 0$ always holds, a question known since as Wilf's conjecture. Using a closely related lower bound $W_{0}(S) \leq W(S)$, we show that if $|L| \leq 12$ then $W_{0}(S) \geq 0$, thereby settling Wilf's conjecture in this case. This is best possible, since cases are known where $|L|=13$ and $W_{0}(S)=-1$. Wilf's conjecture remains open for $|L| \geq 13$.


## 1 Introduction

Let $\mathbb{N}=\{0,1,2, \ldots\}$ denote as usual the set of nonnegative integers. Given integers $a \leq b$, we denote by $[a, b[=[a, b-1]=\{z \in \mathbb{Z} \mid a \leq z<b\}$, and by $[a, \infty[=$ $\{z \in \mathbb{Z} \mid a \leq z\}$, the integer intervals they span. A numerical semigroup is a submonoid $S$ of $(\mathbb{N},+)$ such that $|\mathbb{N} \backslash S|$ is finite. Equivalently, it is a subset $S$ of $\mathbb{N}$ of the form $S=\left\langle a_{1}, \ldots, a_{n}\right\rangle=\mathbb{N} a_{1}+\cdots+\mathbb{N} a_{n}$ where $\operatorname{gcd}\left(a_{1}, \ldots, a_{n}\right)=1$. The least such $n$ is called the embedding dimension of $S$ and is often denoted $e$. The multiplicity of $S$ is $m=\min S^{*}$, where $S^{*}=S \backslash\{0\}$. The conductor of $S$ is $c=\max (\mathbb{Z} \backslash S)+1$, or equivalently, the least $c \in \mathbb{N}$ such $[c, \infty[\subseteq S$. The genus of $S$ is $g=|\mathbb{N} \backslash S|$. The left part of $S$ is

$$
L=\{s \in S \mid s<c\}=S \cap[0, c[.
$$

The left elements of $S$ are the elements of $L$. Finally, as in [5], we denote

$$
\begin{equation*}
W(S)=e|L|-c . \tag{1}
\end{equation*}
$$

In 1978 Wilf asked, in equivalent terms, whether the inequality

$$
W(S) \geq 0
$$

holds for every numerical semigroup $S$ [16]. This open question is now known as Wilf's conjecture. Various particular cases have been settled, including the six independent cases $e \leq 3,|L| \leq 6, m \leq 18, g \leq 60, c \leq 3 m$ and $e \geq m / 3$. See e.g. [1, 2, 4, 5, 6, 8, 9, 10, 12, 11, 14, 15]. See also [3] for a recent extensive survey on this topic.

The authors of [4] settled Wilf's conjecture in case $|L| \leq 4$. This was later extended in [5], where a certain lower bound $W_{0}(S) \leq W(S)$ was introduced and shown to satisfy $W_{0}(S) \geq 0$ whenever $|L| \leq 6$. Here we further extend this result by showing that $W_{0}(S) \geq 0$ holds whenever $|L| \leq 12$. This is best possible since, as shown in [7], there are numerical semigroups $S$ such that $|L|=13$ and $W_{0}(S)<0$. See also Section 2.2.

This paper is organized as follows. In Section 2 we recall some notation and background, including the definition of $W_{0}(S)$. In Section 3 we establish $W_{0}(S) \geq$ 0 in some special circumstances. Our main result, namely $W_{0}(S) \geq 0$ if $|L| \leq 12$, and hence Wilf's conjecture in that case, is proved in Section 4 .

For extensive information on numerical semigroups, see [13].

## 2 Background and notation

In this section, we recall some notation and terminology introduced in [5]. Let $S$ be a numerical semigroup. We denote by $P \subset S^{*}$ the unique minimal generating set of $S$, so that $S=\langle P\rangle$ and $|P|=e$, the embedding dimension. It coincides with the set of primitive elements of $S$, i.e. those $x \in S^{*}$ which are not the sum of two smaller elements of $S^{*}$. Let $m, c$ be the multiplicity and conductor of $S$, respectively. The depth of $S$ is $q=\lceil c / m\rceil$ and its offset is $\rho=q m-c$. Thus

$$
\begin{equation*}
c=q m-\rho, \quad \rho \in[0, m[. \tag{2}
\end{equation*}
$$

The set of decomposable elements of $S$ is

$$
D=S^{*} \backslash P=S^{*}+S^{*}
$$

Note that $D$ contains $[c+m, \infty[$. Indeed, if $z \geq c+m$, then $z=m+(z-m)$, so that $z \in S^{*}+S^{*}$ since both $m \in S^{*}$ and $z-m \in S^{*}$ as $z-m \geq c$. It follows that

$$
\begin{equation*}
P \subseteq[m, c+m[. \tag{3}
\end{equation*}
$$

Throughout Section 2, the symbols $m, c, q$ and $\rho$ will denote, often tacitly so, the multiplicity, conductor, depth and offset of the numerical semigroup $S$ under consideration, respectively.

### 2.1 The level function $\lambda$

Let $S \subseteq \mathbb{N}$ be a numerical semigroup. We shall further use the following notation, as in [5].

Notation 2.1. For all $j \in \mathbb{Z}$, we denote

$$
\begin{aligned}
I_{j} & =[j m-\rho,(j+1) m-\rho[, \\
S_{j} & =S \cap I_{j}, P_{j}=P \cap I_{j}, D_{j}=D \cap I_{j} .
\end{aligned}
$$

In particular, we have

$$
I_{q}=[q m-\rho,(q+1) m-\rho[=[c, c+m[.
$$

The following set addition rules are shown in [5]. The proof is straightforward and left to the reader.

Proposition 2.2. Let $S$ be a numerical semigroup. For all $i, j \geq 1$, we have

$$
\begin{aligned}
S_{1}+S_{j} & \subseteq S_{1+j} \cup S_{2+j} \\
S_{i}+S_{j} & \subseteq S_{i+j-1} \cup S_{i+j} \cup S_{i+j+1} \quad \text { if } i, j \geq 2
\end{aligned}
$$

Notation 2.3. The level function $\lambda_{S}: \mathbb{N} \rightarrow \mathbb{N}$ associated to $S$ is defined by

$$
\lambda_{S}(x)=j \Longleftrightarrow x \in I_{j} \Longleftrightarrow j m-\rho \leq x \leq(j+1) m-\rho-1
$$

for all $x \in \mathbb{N}$. In particular, if $x \in S$ then $\lambda_{S}(x)=j$ if and only if $x \in S_{j}$.
In the sequel, for simplicity, we shall write $\lambda$ for $\lambda_{S}$. Using this function, the above proposition translates as follows.

Corollary 2.4. Let $x, y \in S^{*}$. If $\lambda(x), \lambda(y) \geq 2$ then

$$
\begin{equation*}
\lambda(x)+\lambda(y)-1 \leq \lambda(x+y) \leq \lambda(x)+\lambda(y)+1 . \tag{4}
\end{equation*}
$$

If $\boldsymbol{\lambda}(x)=1$ or $\lambda(y)=1$, then $\lambda(x)+\lambda(y) \leq \lambda(x+y) \leq \lambda(x)+\lambda(y)+1$.
Here are some more consequences.

Corollary 2.5. Let $a, x, y \in S^{*}$. Then $\lambda(x+y)>\max \{\lambda(x), \lambda(y)\}$. If $\lambda(a+x)=$ $\lambda(a+y)$, then $|\lambda(y)-\lambda(x)| \leq 1$.

Proof. The first statement directly follows from Corollary 2.4. As for the second one, let $i=\lambda(x), j=\lambda(y)$. We may assume $i \leq j$. Let $k=\lambda(a+x)$. Then $a+$ $x, a+y \in S_{k}$. Hence $|y-x|=|(a+y)-(a+x)| \leq m-1$. It follows that $j \leq i+1$, since if $j \geq i+2$ then $\min S_{j}-\max S_{i} \geq m+1$.

### 2.2 The number $W_{0}(S)$

Notation 2.6. For a numerical semigroup $S$, we denote

$$
\begin{equation*}
W_{0}(S)=|P \cap L||L|-q\left|D_{q}\right|+\rho . \tag{5}
\end{equation*}
$$

Introduced in [5], this number bounds $W(S)$ from below and is sometimes easier to evaluate. See also [2], where $W_{0}(S)$ is denoted $E(S)$. The following result is Proposition 3.11 in [5]. For convenience, we recall the short proof.

Proposition 2.7. Let $S$ be a numerical semigroup. Then $W(S) \geq W_{0}(S)$.
Proof. We have $W(S)=|P||L|-c=|P||L|-q m+\rho$. We have $m=\left|P_{q}\right|+\left|D_{q}\right|$, since $m=\left|S_{q}\right|=\left|P_{q} \sqcup D_{q}\right|$, and $|P|=|P \cap L|+\left|P_{q}\right|$. It follows that

$$
W(S)=W_{0}(S)+\left|P_{q}\right|(|L|-q) .
$$

Now $|L| \geq q$, since $L$ contains the $q$-subset $\{0,1, \ldots, q-1\} m$.
Corollary 2.8. Let $S$ be a numerical semigroup such that $W_{0}(S) \geq 0$. Then $S$ satisfies Wilf's conjecture.

Proof. We have $W(S) \geq W_{0}(S) \geq 0$.
This corollary is the basis of our approach in this paper, whose main result is that $W_{0}(S) \geq 0$ whenever $|L| \leq 12$. Note that in contrast to Wilf's conjecture, the number $W_{0}(S)$ can be negative, but such cases are extremely rare. For instance, among the more than $10^{13}$ numerical semigroups of genus $g \leq 60$, only five of them satisfy $W_{0}(S)<0$. See [ 2, 7, 9]. More specifically, these five exceptions all satisfy $W_{0}(S)=-1,|L|=13$ and $c=4 m$, and they occur at genus $43,51,55,55$ and 59 , respectively. The first one, of genus $g=43$, is $S=\langle 14,22,23\rangle \cup[56, \infty[$.

The following result has been established in [5].

Theorem 2.9. Let $S$ be a numerical semigroup of depth $q \leq 3$. Then $W_{0}(S) \geq 0$. In particular, $S$ satisfies Wilf's conjecture.

Consequently, in proving here that $W_{0}(S) \geq 0$ if $|L| \leq 12$, we only need to consider the case of depth $q \geq 4$. The next three sections focus on the Apéry set of $S$ with respect to $m$ and provide tools to evaluate $W_{0}(S)$ and prove our main result.

### 2.3 The Apéry profile of $S$

Let $S \subseteq \mathbb{N}$ be a numerical semigroup. We denote by

$$
A=\operatorname{Ap}(S, m)=\{x \in S \mid x-m \notin S\}
$$

the Apéry set of $S$ with respect to $m$. Equivalently, $A=S \backslash(m+S)$. Each Apéry element $x \in A$ is the smallest element in $S$ of its class $\bmod m$, since $x-m \notin S$. Hence $|A|=m$. We have

$$
A \subseteq[0, c+m[.
$$

Indeed, this follows from the inclusion $[c+m, \infty[=m+[c, \infty[\subseteq m+S$. We now introduce the Apéry profile of $S$.

Notation 2.10. Let $S$ be a numerical semigroup of depth $q \geq 1$. For all $0 \leq i \leq q$, we set $A_{i}=A \cap I_{i}$ and

$$
\alpha_{i}=\left|A_{i}\right| .
$$

We have $A_{0}=\{0\}$, so $\alpha_{0}=1$. Moreover, $P_{1}=\{m\} \sqcup A_{1}$ and $P_{i} \subseteq A_{i}$ for all $i \geq 2$.
Definition 2.11. We call Apéry profile of $S$ the $(q-1)$-tuple

$$
\alpha(S)=\left(\alpha_{1}, \ldots, \alpha_{q-1}\right) \in \mathbb{N}^{q-1}
$$

As noted above, we have

$$
\begin{equation*}
\alpha_{1}=\left|P_{1}\right|-1 \text { and } \alpha_{i} \geq\left|P_{i}\right| \text { for all } 2 \leq i<q \tag{6}
\end{equation*}
$$

Moreover, since $A \subseteq\left[0, c+m\left[=I_{0} \sqcup I_{1} \sqcup \cdots \sqcup I_{q}\right.\right.$, we have

$$
\begin{equation*}
A=A_{0} \sqcup A_{1} \sqcup \cdots \sqcup A_{q} . \tag{7}
\end{equation*}
$$

Therefore

$$
\begin{equation*}
\sum_{i=0}^{q} \alpha_{i}=|A|=m \tag{8}
\end{equation*}
$$

This justifies why $\alpha_{0}, \alpha_{q}$ are not included in the profile $\alpha(S)$, as $\alpha_{0}=1$ and $\alpha_{q}$ may be recovered from $\alpha(S)$ and $m$ by the above formula.

### 2.4 Primitive and decomposable Apéry elements

Let $S$ be a numerical semigroup of multiplicity $m$ and Apéry set $A=S \backslash(m+S)$. A key point in the sequel is to distinguish, in $A^{*}=A \backslash\{0\}$, the primitive elements from the decomposable ones. Indeed, the partition

$$
A^{*}=(A \cap P) \sqcup(A \cap D)
$$

plays an important role and motivates the following notation.
Notation 2.12. Let $S$ be a numerical semigroup of depth $q \geq 1$. For all $1 \leq i \leq q$, we set

$$
\alpha_{i}^{\prime}=\left|A_{i} \cap P\right|, \quad \alpha_{i}^{\prime \prime}=\left|A_{i} \cap D\right| .
$$

Thus $\alpha_{i}=\alpha_{i}^{\prime}+\alpha_{i}^{\prime \prime}$ for all $i$.
Since $P \subseteq\left[m, c+m\left[\right.\right.$ as seen above, and since $\left[m, c+m\left[\subseteq I_{1} \cup \cdots \cup I_{q}\right.\right.$, we have

$$
\begin{equation*}
|P|=1+\alpha_{1}^{\prime}+\cdots+\alpha_{q}^{\prime} . \tag{9}
\end{equation*}
$$

In particular,

$$
\begin{aligned}
\alpha_{q}^{\prime} & =|P \backslash L|=\mid P \cap[c, c+m[\mid, \\
\left|D_{q}\right| & =\mid D \cap[c, c+m[|=|[c, c+m[\backslash P \mid, \\
m & =\left|P_{q}\right|+\left|D_{q}\right| .
\end{aligned}
$$

The following properties of the Apéry set $A$ will be widely used below, often tacitly so.

Lemma 2.13. Let $z \in A \cap D$. If $z=x+y$ with $x, y \in S^{*}$, then $x, y \in A^{*}$.
Proof. If $x \notin A$, then $x=m+s$ for some $s \in S$, implying $z=x+y=m+(s+y)$. Since $s+y \in S$, it follows that $z \notin A$, contrary to the hypothesis.

Proposition 2.14. For all $k \geq 2$, we have $A_{k} \cap D \subseteq \cup_{i, j}\left(A_{i}+A_{j}\right)$ where $1 \leq i \leq j$ and $k-1 \leq i+j \leq k+1$.

Proof. Directly follows from Proposition 2.2 and Lemma 2.13 .
Corollary 2.15. If $A_{k} \neq \emptyset$ and $A_{i}=\emptyset$ for all $1 \leq i \leq k-1$ for some $k \geq 2$, then $A_{k}=P_{k}$.

Proof. Directly follows from the above proposition.

### 2.5 Compressed Apéry elements

Throughout, let $S$ denote a numerical semigroup with multiplicity $m$, conductor $c$ and Apéry set $A=S \backslash(m+S)$.

Definition 2.16. Let $s \in S^{*}$. We say that $s$ is compressed if there exist $x, y \in S^{*}$ such that $s=x+y$ and $\lambda(s)<\lambda(x)+\lambda(y)$.

By Corollary 2.4, we have $\lambda(x+y) \geq \lambda(x)+\lambda(y)-1$ for all $x, y \in S^{*}$. Thus, the inequality $\lambda(x+y)<\lambda(x)+\lambda(y)$ is equivalent to $\lambda(x+y)=\lambda(x)+\lambda(y)-1$. Estimating the number of compressed elements in $A$ is important in the sequel. This motivates the following notation.

Notation 2.17. $C=C(S)=\{z \in A \cap D \mid z$ is compressed $\}$.
Recall from Lemma 2.13 that if $z \in A \cap D$ and $z=x+y$ with $x, y \in S^{*}$, then in fact $x, y \in A^{*}$. Consequently, for all $i, j \geq 2$, we have

$$
\begin{equation*}
\left(S_{i}+S_{j}\right) \cap A_{i+j-1}=\left(A_{i}+A_{j}\right) \cap A_{i+j-1} \subseteq C \tag{10}
\end{equation*}
$$

More generally, even if the description below will not be needed here, we have

$$
C=\bigcup_{k=3}^{q} A_{k} \cap\left(\cup_{i=1}^{k-1}\left(A_{i}+A_{k+1-i}\right)\right) .
$$

The next result provides a key lower bound on $\rho$, where $\rho$ is the offset as defined in (2). See also Proposition 3.20 in [6].

Proposition 2.18. Let $S$ be a numerical semigroup. Then $\rho \geq|C|$.
Proof. Let $z \in C$, and assume $z=x+y$ with $x, y \in A^{*}$ such that $\lambda(z)=\lambda(x)+$ $\lambda(y)-1$. Say $\lambda(x)=i, \lambda(y)=j$ and $\lambda(z)=i+j-1$. By the definition of $S_{i}$, we have

$$
\left(S_{i}+S_{j}\right) \cap S_{i+j-1} \subseteq[(i+j) m-2 \rho,(i+j) m-\rho[.
$$

Thus $z \in[(i+j) m-2 \rho,(i+j) m-\rho[$. Now, the only classes $\bmod m$ occurring in the latter interval are those in $[-2 \rho,-\rho[$, a set of cardinality $\rho$. Since there is only one element in $A$ per class $\bmod m$, and since $C \subset A$, the statement follows.

In particular, we shall invoke the following simplified version.
Corollary 2.19. For all $i, j \geq 2$, we have $\rho \geq\left|\left(A_{i}+A_{j}\right) \cap A_{i+j-1}\right|$.
Proof. Follows from (10) and Proposition 2.18.

### 2.6 Computing $W_{0}(S)$

The following formulas allow to evaluate $W_{0}(S)$ using the Apéry profile of $S$ as defined in Definition 2.10 and the decomposition $\alpha_{q}=\alpha_{q}^{\prime}+\alpha_{q}^{\prime \prime}$ given by Notation 2.12. Recall that both $|L|$ and $\left|D_{q}\right|$ are involved in the expression of $W_{0}(S)$.
Proposition 2.20. Let $S \subseteq \mathbb{N}$ be a numerical semigroup with Apéry profile $\alpha(S)=$ $\left(\alpha_{1}, \ldots, \alpha_{q-1}\right)$. Then

$$
\begin{aligned}
|L| & =q+(q-1) \alpha_{1}+\cdots+\alpha_{q-1} \\
\left|D_{q}\right| & =\alpha_{0}+\alpha_{1}+\cdots+\alpha_{q-1}+\alpha_{q}^{\prime \prime} .
\end{aligned}
$$

Proof. Let $s \in L$ be minimal in its class mod $m$. Then $s \in L \cap A$. Let $i \geq 0$ be the unique integer such that $s \in A_{i}$. Then $0 \leq i \leq q-1$ since $s \in L$. Let $z \in L$ be such that $z \equiv s \bmod m$. Then $z=s+j m$ with $0 \leq j \leq q-1-i$. It follows that

$$
|L \cap(s+m \mathbb{N})|=q-i
$$

Letting now $s$ run through all elements of $L$ which are minimal in their respective classes $\bmod m$, the above discussion implies

$$
|L|=q\left|A_{0}\right|+(q-1)\left|A_{1}\right|+\cdots+\left|A_{q-1}\right|,
$$

yielding the first formula. Since $m=\left|P_{q}\right|+\left|D_{q}\right|=\alpha_{q}^{\prime}+\left|D_{q}\right|$, it follows that

$$
\left|D_{q}\right|=m-\alpha_{q}^{\prime}=m-\alpha_{q}+\alpha_{q}^{\prime \prime} .
$$

The second formula now follows from (8), i.e. $m=\sum_{i=0}^{q} \alpha_{i}$.

### 2.7 Notation

We shall use the following notation throughout the remainder of the paper. Given a numerical semigroup $S$, we denote by $m$ its multiplicity, by $c$ its conductor, by $q$ its depth, by $\rho$ its offset, by $L$ its left part, by $P$ its set of primitive elements, by $D$ its set of decomposable elements, by $A=S \backslash(m+S)$ its Apéry set with respect to $m$, and by

$$
\alpha(S)=\left(\alpha_{1}, \ldots, \alpha_{q-1}\right)
$$

its Apéry profile, where $\alpha_{i}=\left|A_{i}\right|$ for all $0 \leq i \leq q$. For $i \geq 1$, we have $\alpha_{i}=\alpha_{i}^{\prime}+\alpha_{i}^{\prime \prime}$ where $\alpha_{i}^{\prime}=\left|A_{i} \cap P\right|$ and $\alpha_{i}^{\prime \prime}=\left|A_{i} \cap D\right|$. We shall constantly use the formulas below to compute the ingredients involved in

$$
W_{0}(S)=|P \cap L||L|-q\left|D_{q}\right|+\rho,
$$

namely

$$
\begin{equation*}
|P \cap L|=1+\sum_{i=1}^{q-1} \alpha_{i}^{\prime},|L|=\sum_{i=0}^{q-1}(q-i) \alpha_{i}, \quad\left|D_{q}\right|=\sum_{i=0}^{q-1} \alpha_{i}+\alpha_{q}^{\prime \prime} \tag{11}
\end{equation*}
$$

Finally, as in the preceding section, we denote by $C$ the set of compressed Apéry elements, i.e

$$
C=\left\{z \in A \cap D \mid \exists x, y \in A^{*}, z=x+y, \lambda(z)<\lambda(x)+\lambda(y)\right\} .
$$

In a few cases, the estimate $\rho \geq|C|$ provided by Proposition 2.18 will be crucially needed in order to be able to conclude $W_{0}(S) \geq 0$.

## 3 An occurrence of $W_{0}(S) \geq 0$

In this section, we establish $W_{0}(S) \geq 0$ for numerical semigroups $S$ under suitable assumptions on $\alpha(S)$ but not on $|L|$. We use the notation of Section 2.7 throughout.
Theorem 3.1. Let $S$ be a numerical semigroup of depth $q \geq 4$. Let $h=\lceil q / 2\rceil$. Assume that $\alpha_{i}=0$ for all $1 \leq i \leq h-1$. Then $W_{0}(S) \geq 0$.
Proof. Since $P=\cup_{1 \leq i \leq q}$ and $P_{1}=\{m\} \sqcup A_{1}$, we have $|P|=1+\alpha_{1}+\alpha_{2}^{\prime}+\cdots+\alpha_{q}^{\prime}$ and

$$
\begin{equation*}
|P \cap L|=1+\alpha_{1}+\alpha_{2}^{\prime}+\cdots+\alpha_{q-1}^{\prime} \tag{12}
\end{equation*}
$$

- Assume $q$ odd. Then $h=(q+1) / 2$. Since $A_{1}=\cdots=A_{h-1}=\emptyset$, we have

$$
A \cap D \subseteq \bigcup_{i, j=h}^{q-1}\left(A_{i}+A_{j}\right)
$$

By Proposition 2.2, we have $A_{i}+A_{j} \subseteq S_{i+j-1} \sqcup S_{i+j} \sqcup S_{i+j+1}$. Since $A_{t}=0$ for $t \geq q+1$, and since $2 h=q-1$, it follows from the above that

$$
A \cap D \subseteq 2 A_{h}
$$

Hence $\alpha_{q}^{\prime \prime} \leq\left|2 A_{h}\right|$. It also follows that $A_{i}=P_{i}$ for all $h \leq i \leq q-1$. Hence

$$
\begin{aligned}
|P \cap L| & =1+\alpha_{h}+\cdots+\alpha_{q-1} \\
& \geq 1+\alpha_{h}, \\
|L| & =q+(h-1) \alpha_{h}+(h-2) \alpha_{h+1}+\cdots+\alpha_{q-1} \\
& \geq q+(h-1) \alpha_{h}, \\
\left|D_{q}\right| & =1+\alpha_{h}+\cdots+\alpha_{q-1}+\alpha_{q}^{\prime \prime} \\
& =|P \cap L|+\alpha_{q}^{\prime \prime} .
\end{aligned}
$$

Thus,

$$
\begin{aligned}
W_{0}(S) & =|P \cap L||L|-q\left|D_{q}\right|+\rho \\
& =|P \cap L||L|-q\left(|P \cap L|+\alpha_{q}^{\prime \prime}\right)+\rho \\
& =|P \cap L|(|L|-q)-q \alpha_{q}^{\prime \prime}+\rho \\
& =\left(1+\alpha_{h}\right)(h-1) \alpha_{h}-q \alpha_{q}^{\prime \prime}+\rho .
\end{aligned}
$$

Since $A \cap D_{q} \subseteq 2 A_{h}$, and since $q=2 h-1$, it follows from Lemma 2.18 that $A_{q} \cap D \subseteq C$, where $C$ is the subset defined in that Lemma. Consequently, we have $\left|A_{q} \cap D\right| \leq|C| \leq \rho$, whence

$$
\alpha_{q}^{\prime \prime} \leq \min \left(\left|2 A_{h}\right|, \rho\right)
$$

Therefore

$$
W_{0}(S) \geq\left(1+\alpha_{h}\right)(h-1) \alpha_{h}-q \min \left(\left|2 A_{h}\right|, \rho\right)+\rho .
$$

The following bound will take care of the last two summands.
Claim. For all $t \geq 0$, we have

$$
\begin{equation*}
-q \min (t, \rho)+\rho \geq-(q-1) t \tag{13}
\end{equation*}
$$

Indeed, if $\rho \leq t$, then $-q \min (t, \rho)+\rho=-(q-1) \rho \geq-(q-1) t$. And if $\rho>t$, then $-q \min (t, \rho)+\rho=-q t+\rho>-(q-1) t$. This proves the claim.

Moreover, as a very crude estimate, we have

$$
\left|2 A_{h}\right| \leq \alpha_{h}\left(\alpha_{h}+1\right) / 2
$$

Hence, using (13) and the above, we get

$$
W_{0}(S) \geq\left(1+\alpha_{h}\right)(h-1) \alpha_{h}-(q-1) \alpha_{h}\left(\alpha_{h}+1\right) / 2
$$

Since $(q-1) / 2=h-1$, it follows that $W_{0}(S) \geq 0$, as desired.

- Assume $q$ even. Then $h=q / 2$. Since $A_{1}=\cdots=A_{h-1}=\emptyset$, we have

$$
A \cap D \subseteq \bigcup_{i, j=h}^{q-1}\left(A_{i}+A_{j}\right)
$$

By Proposition 2.2, we have $A_{i}+A_{j} \subseteq S_{i+j-1} \sqcup S_{i+j} \sqcup S_{i+j+1}$. Since $A_{t}=\emptyset$ for $t \geq q+1$, and since $2 h=q$, it follows from the above that

$$
A \cap D \subseteq\left(2 A_{h}\right) \cup\left(A_{h}+A_{h+1}\right)
$$

Moreover, we have

$$
2 A_{h} \cap A \subseteq A_{q-1} \cup A_{q}, \quad\left(A_{h}+A_{h+1}\right) \cap A \subseteq A_{q}
$$

Hence

$$
A \cap D \subseteq\left(2 A_{h} \cap A_{q-1}\right) \cup\left(2 A_{h} \cap A_{q}\right) \cup\left(A_{h}+A_{h+1}\right) \cap A_{q} .
$$

We have

$$
\begin{aligned}
\alpha_{q-1}^{\prime \prime} & =\left|2 A_{h} \cap A_{q-1}\right| \\
\alpha_{q}^{\prime \prime} & =\left|\left(2 A_{h} \cap A_{q}\right) \cup\left(A_{h}+A_{h+1}\right) \cap A_{q}\right| .
\end{aligned}
$$

Hence

$$
\begin{equation*}
\alpha_{q-1}^{\prime \prime}+\alpha_{q}^{\prime \prime} \leq\left|2 A_{h}\right|+\left|\left(A_{h}+A_{h+1}\right) \cap A_{q}\right| . \tag{14}
\end{equation*}
$$

Moreover, since $q=2 h$, Corollary 2.19 yields

$$
\left|\left(A_{h}+A_{h+1}\right) \cap A_{q}\right| \leq \rho .
$$

Moreover, we have $\left|\left(A_{h}+A_{h+1}\right) \cap A_{q}\right| \leq \alpha_{h} \alpha_{h+1}$. Hence

$$
\begin{equation*}
\left|\left(A_{h}+A_{h+1}\right) \cap A_{q}\right| \leq \min \left(\rho, \alpha_{h} \alpha_{h+1}\right) \tag{15}
\end{equation*}
$$

Combining (14) and (15), we get

$$
\begin{equation*}
\alpha_{q-1}^{\prime \prime}+\alpha_{q}^{\prime \prime} \leq\left|2 A_{h}\right|+\min \left(\rho, \alpha_{h} \alpha_{h+1}\right) \tag{16}
\end{equation*}
$$

It also follows that $A_{i}=P_{i}$ for all $h \leq i \leq q-2$. Hence

$$
\begin{aligned}
|P \cap L| & =1+\alpha_{h}+\cdots+\alpha_{q-2}+\alpha_{q-1}^{\prime} \\
& \geq 1+\alpha_{h}+\alpha_{h+1}, \\
|L| & =q+h \alpha_{h}+(h-1) \alpha_{h+1}+\cdots+\alpha_{q-1} \\
& \geq q+h \alpha_{h}+(h-1) \alpha_{h+1}, \\
\left|D_{q}\right| & =1+\alpha_{h}+\cdots+\alpha_{q-1}+\alpha_{q}^{\prime \prime} \\
& =|P \cap L|+\alpha_{q-1}^{\prime \prime}+\alpha_{q}^{\prime \prime} .
\end{aligned}
$$

Thus,

$$
\begin{aligned}
W_{0}(S) & =|P \cap L||L|-q\left|D_{q}\right|+\rho \\
& =|P \cap L||L|-q\left(|P \cap L|+\alpha_{q-1}^{\prime \prime}+\alpha_{q}^{\prime \prime}\right)+\rho \\
& =|P \cap L|(|L|-q)-q\left(\alpha_{q-1}^{\prime \prime}+\alpha_{q}^{\prime \prime}\right)+\rho \\
& \geq\left(1+\alpha_{h}+\alpha_{h+1}\right)\left(h \alpha_{h}+(h-1) \alpha_{h+1}-q\left(\alpha_{q-1}^{\prime \prime}+\alpha_{q}^{\prime \prime}\right)+\rho\right.
\end{aligned}
$$

Therefore, using (16), we get

$$
W_{0}(S) \geq\left(1+\alpha_{h}+\alpha_{h+1}\right)\left(h \alpha_{h}+(h-1) \alpha_{h+1}\right)-q\left(\left|2 A_{h}\right|+\min \left(\rho, \alpha_{h} \alpha_{h+1}\right)\right)+\rho .
$$

Using (13) again for the last two summands, we have

$$
-q \min \left(\rho, \alpha_{h} \alpha_{h+1}\right)+\rho \geq-(q-1) \alpha_{h} \alpha_{h+1} .
$$

We also have the very crude estimate

$$
\left|2 A_{h}\right| \leq \alpha_{h}\left(\alpha_{h}+1\right) / 2
$$

Hence
$W_{0}(S) \geq\left(1+\alpha_{h}+\alpha_{h+1}\right)\left(h \alpha_{h}+(h-1) \alpha_{h+1}\right)-q \alpha_{h}\left(\alpha_{h}+1\right) / 2-(q-1) \alpha_{h} \alpha_{h+1}$.
Using $q=2 h$, it follows that

$$
W_{0}(S)=(h-1) \alpha_{h+1}\left(\alpha_{h+1}+1\right) .
$$

Hence $W_{0}(S) \geq 0$, as desired.
We conclude this section with an easy particular case.
Proposition 3.2. Let $S$ be a numerical semigroup of depth $q \geq 4$ such that $|P \cap L| \geq$ $\max \left(\alpha_{q}^{\prime \prime}, q\right)$. Then $W_{0}(S) \geq \rho$.

Proof. $W_{0}(S)=|P \cap L||L|-q\left|D_{q}\right|+\rho$. Recall that $|L|=\sum_{i=0}^{q-1}(q-i) \alpha_{i}$ and that $\left|D_{q}\right|=\sum_{i=0}^{q-1} \alpha_{i}+\alpha_{q}^{\prime \prime}$. Hence

$$
W_{0}(S)=q\left(|P \cap L|-\alpha_{q}^{\prime \prime}\right)+\sum_{i=1}^{q-1}((q-i)|P \cap L|-q) \alpha_{i}+\rho .
$$

Since $|P \cap L| \geq \alpha_{q}^{\prime \prime}$ and $|P \cap L| \geq q$ by hypothesis, the claimed inequality follows.

## 4 Main result

Let $S$ be a numerical semigroup. We use the notation of Section 2.7 throughout. Wilf's conjecture has been successively settled for $|L| \leq 4$ and $|L| \leq 6$ in [4] and [5], respectively. Here we extend these results to the case $|L| \leq 12$. Even more so, we show that if $|L| \leq 12$ then $W_{0}(S) \geq 0$. As mentioned earlier, this is best possible, since there are numerical semigroups $S$ satisfying $|L|=13$ and $W_{0}(S)<$ 0 . At the time of writing, it remains an open problem to determine whether all numerical semigroups $S$ with $|L|=13$ satisfy Wilf's conjecture. In this section we prove the following result.

Theorem 4.1. Let $S$ be a numerical semigroup such that $|L| \leq 12$. Then $W_{0}(S) \geq 0$. In particular, $S$ satisfies Wilf's conjecture.

By Theorem 2.9, the bound $W_{0}(S) \geq 0$ holds for all numerical semigroups of depth $q \leq 3$. Consequently, in the sequel, we shall freely assume $q \geq 4$, since it suffices to prove Theorem 4.1 in that case. In fact, it also suffices to consider the case $q \leq 7$, as follows from the following proposition.

Proposition 4.2. Let $S$ be a numerical semigroup of depth $q \geq 8$ such that $|L| \leq 12$. Then $W_{0}(S) \geq 0$.

Proof. Let $h=\lceil q / 2\rceil$. Then $12 \geq|L| \geq q+(q-1) \alpha_{1}+\cdots+(q-h+1) \alpha_{h-1}$. This implies $\alpha_{i}=0$ for all $1 \leq i \leq h-1$. For if not, then $|L| \geq q+(q-h+1)$, and since $h \leq(q+1) / 2$, we would get $12 \geq|L| \geq 2 q-(q+1) / 2+1=(3 q+1) / 2$ and hence $3 q+1 \leq 24$, contrary to the hypothesis $q \geq 8$. It now follows from Theorem 3.1 that $W_{0}(S) \geq 0$.

Finally, the following result strongly restricts the values of $\alpha_{1}$ to consider.
Lemma 4.3. Let $S$ be a numerical semigroup of depth $q \geq 4$ such that $|L| \leq 12$. Then $\alpha_{1} \leq 2$.

Proof. By Proposition 2.20, we have $|L|=q+(q-1) \alpha_{1}+(q-2) \alpha_{2}+\cdots+\alpha_{q-1}$. Hence $|L| \geq q+(q-1) \alpha_{1}$. We have $q \geq 4$. If $\alpha_{1} \geq 3$ then $|L| \geq 4+9=13$, contrary to the hypothesis on $|L|$.

The cases $\alpha_{1}=2,1$ and 0 will now be treated successively. We shall occasionally use the following notation.

Notation 4.4. For all $i \geq 1$, we denote by $\mathbf{1}_{i}=\mathbf{1}_{A_{i}}$ the indicator function of $A_{i}$.

### 4.1 When $\alpha_{1}=2$

Proposition 4.5. Let $S$ be a numerical semigroup of depth $q \geq 4$ such that $|L| \leq 12$. If $\alpha_{1}=2$, then $q=4$ and $W_{0}(S) \geq 0$.
Proof. Since $\alpha_{1}=2$, we have $12 \geq|L| \geq q+2(q-1)=3 q-2$. It follows that $q<5$, whence $q=4$ since $q \geq 4$ by hypothesis. We have

$$
|P \cap L| \geq 3,|L|=10+2 \alpha_{2}+\alpha_{3},\left|D_{4}\right|=3+\alpha_{2}+\alpha_{3}+\alpha_{4}^{\prime \prime}
$$

Hence $2 \alpha_{2}+\alpha_{3} \leq 2$ and so $\alpha_{2} \leq 1$.

- If $\alpha_{2}=0$, then $|L|=10+\alpha_{3}$ and so $\alpha_{3} \leq 2$. Since $2 A_{1} \subset S_{2} \cup S_{3}$, and since $A_{2}=\emptyset$ and $2 S_{3} \cap S_{4}=\emptyset$, it follows that

$$
A_{4} \cap D \subseteq\left(A_{1}+A_{3}\right)
$$

Hence $\alpha_{4}^{\prime \prime} \leq 2 \alpha_{3}$. Therefore

$$
\begin{aligned}
W_{0}(S) & \geq 3\left(10+\alpha_{3}\right)-4\left(3+\alpha_{3}+2 \alpha_{3}\right)+\rho \\
& =18-9 \alpha_{3}+\rho \\
& \geq \rho
\end{aligned}
$$

$\bullet$ If $\alpha_{2}=1$, then $|L|=12+\alpha_{3}$ and so $|L|=12$ and $\alpha_{3}=0$. Since $2 A_{1} \subset S_{2} \cup S_{3}$ and $A_{3}=\emptyset$, it follows that

$$
A_{4} \cap D \subseteq\left(A_{1}+A_{2}\right) \cup\left(2 A_{2}\right)
$$

Hence $\alpha_{4}^{\prime \prime} \leq 2+1=3$. Therefore

$$
\begin{aligned}
W_{0}(S) & \geq 3 \cdot 12-4(3+1+3)+\rho \\
& =8+\rho .
\end{aligned}
$$

Remark 4.6. A better lower bound on $W_{0}(S)$ may be obtained by splitting $\alpha_{i}$ as $\alpha_{i}^{\prime}+\alpha_{i}^{\prime \prime}$ for $i=2,3$ in the above proof. For instance, we have only used $|P \cap L| \geq 3$. But we could have used $|P \cap L| \geq 4$ if either $\alpha_{2}^{\prime}$ or $\alpha_{3}^{\prime}$ were assumed positive, while if $\alpha_{2}^{\prime}=\alpha_{3}^{\prime}=0$, a sharper estimate on $\alpha_{4}^{\prime \prime}$ can been derived.

### 4.2 When $\alpha_{1}=1$

Since $12 \geq|L| \geq q+(q-1)=2 q-1$, it follows that $q \leq 6$. We shall successively treat the cases $q=4,5$ and 6 . Throughout Section 4.2, we set

$$
A_{1}=\{x\} .
$$

### 4.2.1 $\quad$ Case $q=4$

Then $\alpha(S)=\left(1, \alpha_{2}, \alpha_{3}\right)$. We have $|L|=4+3+2 \alpha_{2}+\alpha_{3}$, whence $2 \alpha_{2}+\alpha_{3} \leq 5$, implying $\alpha_{2} \leq 2$. We successively examine the cases $\alpha_{2}=2,1,0$. To start with, we have

$$
\begin{equation*}
A_{4} \cap D \subseteq\left(A_{1}+A_{2}\right) \cup\left(A_{1}+A_{3}\right) \cup\left(A_{2}+A_{2}\right) \cup\left(A_{2}+A_{3}\right) \tag{17}
\end{equation*}
$$

$\underline{\text { Subcase } \alpha_{2}=2 .}$ Then $\alpha(S)=\left(1,2, \alpha_{3}\right)$. We have $|L|=11+\alpha_{3}$, whence $\alpha_{3} \leq 1$. Denote

$$
A_{2}=\left\{y_{1}, y_{2}\right\} .
$$

Since $A_{2} \cap D \subseteq 2 A_{1}$, and since $\left|2 A_{1}\right|=1$, we have $\alpha_{2}^{\prime \prime} \leq 1$ whence $\alpha_{2}^{\prime} \in\{1,2\}$.
$\bullet$ Assume first $\alpha_{2}^{\prime}=1$. Say $y_{1} \in P, y_{2} \in D$. Then $y_{2}=2 x$, and $|P \cap L|=3+\alpha_{3}^{\prime}$. We have $\left|D_{4}\right|=4+\alpha_{3}+\alpha_{4}^{\prime \prime}$, and

$$
\left(A_{1}+A_{2}\right) \cup\left(2 A_{2}\right)=\left\{4 x, 3 x, 2 x+y_{1}, x+y_{1}, 2 y_{1}\right\}
$$

Since $4 x \notin S_{3}$ and since $\alpha_{3} \leq 1$, there are at most four possibilities for $A_{3} \cap D$, listed below together with their consequences on $A_{4} \cap D$. Note that Lemma 2.13 plays a key role to deduce these consequences. For example, if $4 x \in A_{4}$ or $2 x+y_{1} \in A_{4}$, then necessarily $3 x \in A_{3}$ or $x+y_{1} \in A_{3}$, respectively. Note also that the level function $\lambda=\lambda_{S}$ is nondecreasing. Consequently, in the last case $A_{3}=\left\{2 y_{1}\right\}$ below, it follows that $x+y_{1} \notin A_{4}$, for $\lambda\left(x+y_{1}\right) \leq \lambda\left(2 y_{1}\right)=3$ since $x<y_{1}$. Here then are the possibilities for $A_{3} \cap D$ :

1. If $A_{3} \cap D=\emptyset$ then $A_{4} \cap D \subseteq\left\{3 x, x+y_{1}, 2 y_{1}\right\}$.
2. If $A_{3} \cap D=\{3 x\}$ then $A_{4} \cap D \subseteq\left\{4 x, x+y_{1}, 2 y_{1}\right\}$.
3. If $A_{3} \cap D=\left\{x+y_{1}\right\}$ then $A_{4} \cap D \subseteq\left\{3 x, 2 x+y_{1}, 2 y_{1}\right\}$.
4. If $A_{3} \cap D=\left\{2 y_{1}\right\}$ then $A_{4} \cap D \subseteq\left\{3 x, 2 y_{1}\right\}$.

In either case, we have $\alpha_{4}^{\prime \prime} \leq 3$. Recall also that $\alpha_{3} \leq 1$ here. Hence

$$
\begin{aligned}
W_{0}(S) & =\left(3+\alpha_{3}^{\prime}\right)\left(11+\alpha_{3}\right)-4\left(4+\alpha_{3}+\alpha_{4}^{\prime \prime}\right)+\rho \\
& \geq\left(3+\alpha_{3}^{\prime}\right)\left(11+\alpha_{3}\right)-4\left(7+\alpha_{3}\right)+\rho \\
& \geq 4+11 \alpha_{3}^{\prime}+\alpha_{3}^{\prime} \alpha_{3}+\rho
\end{aligned}
$$

- Assume now $\alpha_{2}^{\prime}=2$, so that $y_{1}, y_{2} \in P$. Then $|P \cap L|=4+\alpha_{3}^{\prime}$. We have $\left|D_{4}\right|=4+\alpha_{3}+\alpha_{4}^{\prime \prime}$, and

$$
\left(2 A_{1}\right) \cup\left(A_{1}+A_{2}\right) \cup\left(2 A_{2}\right)=\left\{2 x, x+y_{1}, x+y_{2}, 2 y_{1}, y_{1}+y_{2}, 2 y_{2}\right\} .
$$

Up to permutation of $y_{1}, y_{2}$, and using $\alpha_{3} \leq 1$ and $2 x \notin S_{4}$, here are the possibilities for $A_{3} \cap D$, together with their consequences for $A_{4} \cap D$ :

1. If $A_{3} \cap D=\emptyset$ then $A_{4} \cap D \subseteq\left\{x+y_{1}, x+y_{2}, 2 y_{1}, y_{1}+y_{2}, 2 y_{2}\right\}$.
2. If $A_{3} \cap D=\{2 x\}$ then $A_{4} \cap D \subseteq\left\{3 x, x+y_{1}, x+y_{2}, 2 y_{1}, y_{1}+y_{2}, 2 y_{2}\right\}$.
3. If $A_{3} \cap D=\left\{x+y_{1}\right\}$ then $A_{4} \cap D \subseteq\left\{x+y_{2}, 2 y_{1}, y_{1}+y_{2}, 2 y_{2}\right\}$.
4. If $A_{3} \cap D=\left\{2 y_{1}\right\}$ then $A_{4} \cap D \subseteq\left\{x+y_{1}, x+y_{2}, y_{1}+y_{2}, 2 y_{2}\right\}$.
5. If $A_{3} \cap D=\left\{y_{1}+y_{2}\right\}$ then $A_{4} \cap D \subseteq\left\{x+y_{1}, x+y_{2}, 2 y_{1}, 2 y_{2}\right\}$.

In either case, we have $\alpha_{4}^{\prime \prime} \leq 6$. Hence

$$
\begin{aligned}
W_{0}(S) & =\left(4+\alpha_{3}^{\prime}\right)\left(11+\alpha_{3}\right)-4\left(4+\alpha_{3}+\alpha_{4}^{\prime \prime}\right)+\rho \\
& \geq\left(4+\alpha_{3}^{\prime}\right)\left(11+\alpha_{3}\right)-4\left(10+\alpha_{3}\right)+\rho \\
& =4+11 \alpha_{3}^{\prime}+\alpha_{3}^{\prime} \alpha_{3}+\rho .
\end{aligned}
$$

Subcase $\alpha_{2}=1$. Then $\alpha(S)=\left(1,1, \alpha_{3}\right)$. We have $|L|=9+\alpha_{3}$, whence $\alpha_{3} \leq 3$. We also have $|P \cap L|=2+\alpha_{2}^{\prime}+\alpha_{3}^{\prime}$ and $\left|D_{4}\right|=3+\alpha_{3}+\alpha_{4}^{\prime \prime}$. Denote

$$
A_{2}=\{y\} .
$$

- Assume first $y \in A_{2} \cap D$. Then $y=2 x,|P \cap L|=2+\alpha_{3}^{\prime}$ and $A_{3} \cap D \subseteq\{3 x\}$. Thus $\alpha_{3}^{\prime \prime} \leq 1$, and either

$$
A_{4} \cap D \subseteq\{3 x\} \cup\left(x+P_{3}\right) \text { or } A_{4} \cap D \subseteq\{4 x\} \cup\left(2 x+P_{3}\right) \cup\left(x+P_{3}\right)
$$

We claim that $\alpha_{4}^{\prime \prime} \leq 1+\alpha_{3}^{\prime}$ in both cases. This is clear in the first one. In the second one, for all $z \in P_{3}$ we have

$$
\left|A_{4} \cap\{2 x+z, x+z\}\right| \leq 1
$$

Therefore $\left|A_{4} \cap\left(\left(2 x+P_{3}\right) \cup\left(x+P_{3}\right)\right)\right| \leq\left|P_{3}\right|$, implying $\alpha_{4}^{\prime \prime} \leq 1+\alpha_{3}^{\prime}$ here as well. Using $\alpha_{3}=\alpha_{3}^{\prime}+\alpha_{3}^{\prime \prime} \leq \alpha_{3}^{\prime}+1$, we have

$$
\begin{aligned}
W_{0}(S) & =\left(2+\alpha_{3}^{\prime}\right)\left(9+\alpha_{3}\right)-4\left(3+\alpha_{3}+\alpha_{4}^{\prime \prime}\right)+\rho \\
& \geq\left(2+\alpha_{3}^{\prime}\right)\left(9+\alpha_{3}\right)-4\left(4+\alpha_{3}^{\prime}+\alpha_{3}\right)+\rho \\
& =2+5 \alpha_{3}^{\prime}-2 \alpha_{3}+\alpha_{3} \alpha_{3}^{\prime}+\rho \\
& \geq 2+5 \alpha_{3}^{\prime}-2\left(\alpha_{3}^{\prime}+1\right)+\alpha_{3} \alpha_{3}^{\prime}+\rho \\
& \geq 3 \alpha_{3}^{\prime}+\alpha_{3} \alpha_{3}^{\prime}+\rho .
\end{aligned}
$$

- Assume now $y \in A_{2} \cap P$. Hence $|P \cap L|=3+\alpha_{3}^{\prime}$. Here we have

$$
A_{3} \cap D \subseteq\{2 x, x+y, 2 y\}
$$

and so $\alpha_{3}^{\prime \prime} \leq 3$. Let us examine in turn the possibilities for $A_{3} \cap D$ and their consequences for $A_{4} \cap D$ :

1. If $A_{3} \cap D=\emptyset$ then $A_{4} \cap D \subseteq\{x+y, 2 y\} \cup\left(\{x, y\}+P_{3}\right)$.
2. If $A_{3} \cap D=\{2 x\}$ then $A_{4} \cap D \subseteq\{3 x, x+y, 2 y\} \cup\left(\{x, y\}+P_{3}\right)$.
3. If $A_{3} \cap D=\{x+y\}$ then $A_{4} \cap D \subseteq\{2 y\} \cup\left(\{x, y\}+P_{3}\right)$.
4. If $A_{3} \cap D=\{2 y\}$ then $A_{4} \cap D \subseteq\{x+y, 3 y\} \cup\left(\{x, y\}+P_{3}\right)$.
5. If $A_{3} \cap D=\{2 x, x+y\}$ then $A_{4} \cap D \subseteq\{3 x, 2 x+y, 2 y\} \cup\left(\{x, y\}+P_{3}\right)$.
6. If $A_{3} \cap D=\{2 x, 2 y\}$ then $A_{4} \cap D \subseteq\{3 x, x+y, 2 y\} \cup\left(\{x, y\}+P_{3}\right)$.
7. If $A_{3} \cap D=\{x+y, 2 y\}$ then $A_{4} \cap D \subseteq\{x+2 y, 3 y\} \cup\left(\{x, y\}+P_{3}\right)$.
8. If $A_{3} \cap D=\{2 x, x+y, 2 y\}$ then $A_{4} \cap D \subseteq\{3 x, 2 x+y, x+2 y, 3 y\} \cup(\{x, y\}+$ $P_{3}$ ).
Note that $\left|\{x, y\}+P_{3}\right| \leq 2\left|P_{3}\right|=2 \alpha_{3}^{\prime}$. Consequently, distinguishing between the first seven cases and the last one, we have

$$
\begin{aligned}
& \alpha_{3}^{\prime \prime} \leq 2 \Rightarrow \alpha_{4}^{\prime \prime} \leq 3+2 \alpha_{3}^{\prime} \\
& \alpha_{3}^{\prime \prime}=3 \Rightarrow \alpha_{4}^{\prime \prime} \leq 4+2 \alpha_{3}^{\prime}
\end{aligned}
$$

- Assume first $\alpha_{3}^{\prime \prime} \leq 2$, so that $\alpha_{3} \leq \alpha_{3}^{\prime}+2$ and $\alpha_{4}^{\prime \prime} \leq 3+2 \alpha_{3}^{\prime}$. We have

$$
\begin{aligned}
W_{0}(S) & =\left(3+\alpha_{3}^{\prime}\right)\left(9+\alpha_{3}\right)-4\left(3+\alpha_{3}+\alpha_{4}^{\prime \prime}\right)+\rho \\
& \geq\left(3+\alpha_{3}^{\prime}\right)\left(9+\alpha_{3}\right)-4\left(6+\alpha_{3}+2 \alpha_{3}^{\prime}\right)+\rho \\
& =3+\alpha_{3}^{\prime}-\alpha_{3}+\alpha_{3}^{\prime} \alpha_{3}+\rho \\
& \geq 1+\alpha_{3}^{\prime} \alpha_{3}+\rho .
\end{aligned}
$$

- Assume now $\alpha_{3}^{\prime \prime}=3$, so that $\alpha_{4}^{\prime \prime} \leq 4+2 \alpha_{3}^{\prime}$. Since $\alpha_{3} \leq 3$, it follows that $\alpha_{3}=$ $\alpha_{3}^{\prime \prime}=3$, whence $\alpha_{3}^{\prime}=0$ and $\alpha_{4}^{\prime \prime} \leq 4$. We have

$$
\begin{aligned}
W_{0}(S) & =\left(3+\alpha_{3}^{\prime}\right)\left(9+\alpha_{3}\right)-4\left(3+\alpha_{3}+\alpha_{4}^{\prime \prime}\right)+\rho \\
& \geq 3 \cdot 12-4 \cdot 10+\rho \\
& =-4+\rho
\end{aligned}
$$

We now show that $\rho \geq 6$ here. Indeed, since $y \in A_{2}$ and $3 y \in A_{4}$, we have

$$
2 m-\rho \leq y, \quad 3 y \leq 5 m-\rho-1
$$

Therefore $3(2 m-\rho) \leq 3 y \leq 5 m-\rho-1$, implying $m \leq 2 \rho-1$. Now, since $m=$ $1+\alpha_{1}+\alpha_{2}+\alpha_{3}+\alpha_{4} \geq 10$ by (8), it follows that $\rho \geq 6$, whence $W_{0}(S) \geq 2$ and we are done.
$\underline{\text { Subcase } \alpha_{2}=0 . ~ T h e n ~} \alpha(S)=\left(1,0, \alpha_{3}\right)$ here, and incidentally $\alpha_{3} \leq 5$ since $|L| \leq$ 12. We have

$$
|P \cap L|=2+\alpha_{3}^{\prime},|L|=7+\alpha_{3},\left|D_{4}\right|=2+\alpha_{3}+\alpha_{4}^{\prime \prime} .
$$

Recalling that $A_{1}=\{x\}$, we distinguish the cases where $2 x \in A$ or not.

- Assume first $2 x \in A$. Since $\lambda(2 x) \in\{2,3\}$ and since $A_{2}=\emptyset$, it follows that $2 x \in A_{3}$. Hence $\alpha_{3}^{\prime \prime}=1$ and so $\alpha_{3}=1+\alpha_{3}^{\prime}$. Thus

$$
|L|=8+\alpha_{3}^{\prime},\left|D_{4}\right|=3+\alpha_{3}^{\prime}+\alpha_{4}^{\prime \prime} .
$$

Since $A_{4} \cap D \subseteq\{3 x\} \cup P_{3}$, it follows that $\alpha_{4}^{\prime \prime} \leq 1+\alpha_{3}^{\prime}$ and hence $\left|D_{4}\right| \leq 4+2 \alpha_{3}^{\prime}$. A straightforward computation then yields

$$
W_{0}(S) \geq \rho .
$$

- Assume now $2 x \notin A$. It follows that $A_{3} \subseteq P$, i.e. $\alpha_{3}=\alpha_{3}^{\prime}$, and $A_{4} \cap D \subseteq x+A_{3}$. Therefore $\alpha_{4}^{\prime \prime} \leq \alpha_{3}$ n and so $\left|D_{4}\right|=2+\alpha_{3}+\alpha_{4}^{\prime \prime} \leq 2+2 \alpha_{3}$. This implies here

$$
W_{0}(S) \geq 6+\rho
$$

This concludes the case $\alpha_{1}=1$ and $q=4$.

### 4.2.2 Case $q=5$

We now tackle the case $\alpha_{1}=1$ and $q=5$, i.e. $\alpha(S)=\left(1, \alpha_{2}, \alpha_{3}, \alpha_{4}\right)$. We have $|L|=9+3 \alpha_{2}+2 \alpha_{3}+\alpha_{4}$, whence $3 \alpha_{2}+2 \alpha_{3}+\alpha_{4} \leq 3$, implying $\alpha_{2} \leq 1$.
Subcase $\alpha_{2}=1$. Then $\alpha(S)=\left(1,1, \alpha_{3}, \alpha_{4}\right)$. Then $|L|=12$ and $\alpha_{3}=\alpha_{4}=0$. Moreover, $\left|D_{5}\right|=\alpha_{0}+\alpha_{1}+\alpha_{2}+\alpha_{5}^{\prime \prime}=3+\alpha_{5}^{\prime \prime}$. Set

$$
A_{2}=\{y\} .
$$

- Assume first $y \in D$. Then $y=2 x$. Since $A_{3}=A_{4}=\emptyset$ by hypothesis, it follows that $|P \cap L|=2$ and $A_{5} \cap D \subseteq\{3 x\}$. Therefore $\alpha_{5}^{\prime \prime} \leq 1$. We conclude that

$$
\begin{aligned}
W_{0}(S) & =2 \cdot 12-5\left(3+\alpha_{5}^{\prime \prime}\right)+\rho \\
& \geq 4+\rho
\end{aligned}
$$

- Assume now $y \in P$. Then $|P \cap L|=3$ and $A_{5} \cap D \subseteq\{2 y\}$ since $\lambda(2 x) \leq 3$ and $\lambda(x+y) \leq 4$. Hence $\alpha_{5}^{\prime \prime} \leq 1$ and

$$
\begin{aligned}
W_{0}(S) & =3 \cdot 12-5\left(3+\alpha_{5}^{\prime \prime}\right)+\rho \\
& \geq 16+\rho
\end{aligned}
$$

Subcase $\alpha_{2}=0$. Then $\alpha(S)=\left(1,0, \alpha_{3}, \alpha_{4}\right)$ and $|L|=9+2 \alpha_{3}+\alpha_{4}$. Hence $\alpha_{3} \leq 1$. Moreover, $\left|D_{5}\right|=\alpha_{0}+\alpha_{1}+\alpha_{3}+\alpha_{4}+\alpha_{5}^{\prime \prime}=2+\alpha_{3}+\alpha_{4}+\alpha_{5}^{\prime \prime}$. We have $A_{2}=\emptyset$.

Subsubcase $\alpha_{3}=1$. Then $\alpha(S)=\left(1,0,1, \alpha_{4}\right)$. We have $|L|=11+\alpha_{4}$, hence $\alpha_{4} \leq 1$. Since $A_{2}=\emptyset$, we have $2 x \in A$ if and only if $2 x \in A_{3}$.

- Assume first $2 x \in A$. Then $A_{3}=\{2 x\}$ since $A_{2}=\emptyset$ and $\alpha_{3}=1$. Hence $A_{4} \cap D \subseteq\{3 x\}$ and $A_{5} \cap D \subseteq\{3 x, 4 x\} \cup\left(x+A_{4} \cap P\right)$. Therefore

$$
\begin{equation*}
\alpha_{4}^{\prime \prime}=\mathbf{1}_{4}(3 x), \alpha_{5}^{\prime \prime} \leq \mathbf{1}_{5}(3 x)+\mathbf{1}_{5}(4 x)+\alpha_{4}^{\prime} . \tag{18}
\end{equation*}
$$

Note also that if $4 x \in A_{5}$, then $A_{4}=\{3 x\}$ by Lemma 2.13 and the bound $\alpha_{4} \leq 1$. We have

$$
|P \cap L|=2+\alpha_{4}^{\prime},|L|=11+\alpha_{4},\left|D_{5}\right|=3+\alpha_{4}+\alpha_{5}^{\prime \prime}=3+\alpha_{4}^{\prime}+\mathbf{1}_{4}(3 x)+\alpha_{5}^{\prime \prime} .
$$

A straightforward computation, using (18), then yields

$$
\begin{aligned}
W_{0}(S) & =\left(2+\alpha_{4}^{\prime}\right)\left(11+\alpha_{4}\right)-5\left(3+\alpha_{4}^{\prime}+\mathbf{1}_{4}(3 x)+\alpha_{5}^{\prime \prime}\right)+\rho \\
& \geq\left(2+\alpha_{4}^{\prime}\right)\left(11+\alpha_{4}\right)-5\left(3+2 \alpha_{4}^{\prime}+\mathbf{1}_{4}(3 x)+\mathbf{1}_{5}(3 x)+\mathbf{1}_{5}(4 x)\right)+\rho \\
& \geq 7-3 \cdot \mathbf{1}_{4}(3 x)-5 \cdot \mathbf{1}_{5}(3 x)-5 \cdot \mathbf{1}_{5}(4 x)+\rho .
\end{aligned}
$$

If $4 x \notin A_{5}$ then $W_{0}(S) \geq 2+\rho$ since $\mathbf{1}_{4}(3 x)+\mathbf{1}_{5}(3 x) \leq 1$ and we are done. If $4 x \in A_{5}$, then $3 x \in A_{4}$ as noted above, whence $W_{0}(S) \geq-1+\rho$. But then $4 x \in C$, since $\lambda(4 x)=5$ whereas $\lambda(2 x)=3$. Thus $\rho \geq|C| \geq 1$, implying $W_{0}(S) \geq 0$, as desired.

- Assume now $2 x \notin A$. Then $\alpha_{3}^{\prime}=\alpha_{3}=1$ and $|P \cap L|=3+\alpha_{4}^{\prime}$. We have $A_{5} \cap D \subseteq\left(A_{1}+A_{3}\right) \cup\left(A_{1}+A_{4}\right)$, whence $\alpha_{5}^{\prime \prime} \leq 2$ since $\alpha_{1}=\alpha_{3}=1$ and $\alpha_{4} \leq 1$. Therefore $\left|D_{5}\right|=3+\alpha_{4}+\alpha_{5}^{\prime \prime} \leq 6$, so that

$$
\begin{aligned}
W_{0}(S) & =\left(3+\alpha_{4}^{\prime}\right)\left(11+\alpha_{4}\right)-5\left|D_{5}\right|+\rho \\
& \geq 3 \cdot 11-30+\rho \\
& \geq 3+\rho .
\end{aligned}
$$

Subsubcase $\alpha_{3}=0$. Then $\alpha(S)=\left(1,0,0, \alpha_{4}\right)$. We have $|L|=9+\alpha_{4}$, hence $\alpha_{4} \leq 3$ and $\left|D_{5}\right|=2+\alpha_{4}+\alpha_{5}^{\prime \prime}$. Since $A_{2}=A_{3}=\emptyset$, and since $2 \leq \lambda(2 x) \leq 3$, it follows that $2 x \notin A$ and $A_{4}=P_{4}$. Thus $A_{5} \cap D \subseteq x+P_{4}$, so that $\alpha_{5}^{\prime \prime} \leq \alpha_{4}$ and $|P \cap L|=2+\alpha_{4}$. It follows that

$$
\begin{aligned}
W_{0}(S) & \geq\left(2+\alpha_{4}^{\prime}\right)\left(9+\alpha_{4}\right)-5\left(2+\alpha_{4}+\alpha_{5}^{\prime \prime}\right)+\rho \\
& \geq\left(2+\alpha_{4}^{\prime}\right)\left(9+\alpha_{4}\right)-5\left(2+2 \alpha_{4}\right)+\rho \\
& \geq 8+\alpha_{4}+\alpha_{4}^{2}+\rho .
\end{aligned}
$$

This concludes the case $\alpha_{1}=1$ and $q=5$.

### 4.2.3 Case $q=6$

Still for $\alpha_{1}=1$, we now tackle the last case $q=6$. Then $\alpha(S)=\left(1, \alpha_{2}, \alpha_{3}, \alpha_{4}, \alpha_{5}\right)$. We have $|L|=11+4 \alpha_{2}+3 \alpha_{3}+2 \alpha_{4}+\alpha_{5}$, whence $\alpha_{2}=\alpha_{3}=\alpha_{4}=0$ and $\alpha_{5} \leq 1$.
Subcase $\alpha_{5}=1$. Then $\alpha(S)=(1,0,0,0,1)$. We have $|L|=12$ and $\left|D_{6}\right|=\alpha_{0}+$ $\overline{\alpha_{1}+\alpha_{5}+\alpha_{6}^{\prime \prime}=3}+\alpha_{6}^{\prime \prime}$. Recall that $A_{1}=\{x\}$. Since $\lambda(2 x) \leq 3$ and $A_{2}=A_{3}=A_{4}=$ 0 , it follows that $2 x \notin A$. Whence $A_{5}=P_{5}$, i.e. $\alpha_{5}^{\prime}=\alpha_{5}=1$, and $A_{6} \cap D \subseteq x+A_{5}$. Hence $l P \cap L l=4$ and $\alpha_{6}^{\prime \prime} \leq 1$. Consequently $\left|D_{6}\right| \leq 4$, and

$$
\begin{aligned}
W_{0}(S) & \geq 3 \cdot 12-6 \cdot 4+\rho \\
& =12+\rho
\end{aligned}
$$

Subcase $\alpha_{5}=0$. Then $\alpha(S)=(1,0,0,0,0)$. We have $|L|=11$ and $\left|D_{6}\right|=2+\alpha_{6}^{\prime \prime}$. Since $A_{1}=\{x\}$ and $A_{2}, A_{3}, A_{4}, A_{5}$ are all empty, it follows that $|P \cap L|=2$ and $A_{6} \cap D=\emptyset$, i.e. $\alpha_{6}^{\prime \prime}=0$. Thus

$$
W_{0}(S)=2 \cdot 11-6 \cdot 2+\rho=10+\rho .
$$

Summarizing, we have shown that if $|L| \leq 12, \alpha_{1}=1$ and $q=6$, then $W_{0}(S) \geq$ $10+\rho$. This concludes the case $|L| \leq 12$ and $\alpha_{1}=1$.

### 4.3 When $\alpha_{1}=0$

As noted at the beginning of Section 4, it suffices to consider the cases $4 \leq q \leq 7$.

### 4.3.1 $\quad$ Case $q=4$

Then $\alpha(S)=\left(0, \alpha_{2}, \alpha_{3}\right)$. Since $\lceil q / 2\rceil=2$ here, Theorem 3.1 yields $W_{0}(S) \geq 0$.

### 4.3.2 Case $q=5$

Then $\alpha(S)=\left(0, \alpha_{2}, \alpha_{3}, \alpha_{4}\right)$. We have $12 \geq|L|=5+3 \alpha_{2}+2 \alpha_{3}+\alpha_{4}$. Hence $\alpha_{2} \leq 2$. We now examine successively the cases $\alpha_{2}=2,1,0$. Since $A_{1}=0$, it follows that $A_{2} \subset P$.

Subcase $\alpha_{2}=2$. Then $\alpha(S)=\left(0,2, \alpha_{3}, \alpha_{4}\right)$. We have $|L|=11+2 \alpha_{3}+\alpha_{4}$. Hence $\alpha_{3}=0$ and $\alpha_{4} \leq 1$. Since $A_{2} \subset P$, we have $\alpha_{2}^{\prime}=\alpha_{2}=2$ here. Thus $|P \cap L| \geq 3$. Set

$$
A_{2}=\left\{x_{1}, x_{2}\right\} .
$$

$\underline{\text { Assume first } \alpha_{4}=1 . ~ T h e n ~} \alpha(S)=(0,2,0,1)$, so that $|L|=12$ and $\left|D_{5}\right|=4+$ $\alpha_{5}^{\prime \prime}$. Denote $A_{4}=\{z\}$.

- If $z \in P$, then $|P \cap L|=4$ and $2 A_{2} \cap\left(A_{3} \cup A_{4}\right)=\emptyset$. Now

$$
A_{5} \cap D \subseteq 2 A_{2} \cup\left(A_{2}+A_{4}\right)
$$

Since $\left|2 A_{2}\right| \leq 3$ and $\left|A_{2}+A_{4}\right| \leq\left|A_{2}\right|$, it follows that $\alpha_{5}^{\prime \prime} \leq 5$. Hence

$$
\begin{aligned}
W_{0}(S) & =|P \cap L||L|-5\left|D_{5}\right|+\rho \\
& \geq 4 \cdot 12-5 \cdot 9+\rho \\
& =3+\rho
\end{aligned}
$$

and we are done if $z \in P$.
$\bullet$ If $z \in D$, then $|P \cap L|=3$ and $z \in A_{2}$ since $A_{3}=\emptyset$. Hence, up to renumbering, either $z=2 x_{1}$ or $z=x_{1}+x_{2}$. If $z=2 x_{1}$ then $A_{5} \cap D \subseteq\left\{3 x_{1}, x_{1}+x_{2}, 2 x_{2}\right\}$, whereas if $z=x_{1}+x_{2}$, then $A_{5} \cap D \subseteq\left\{2 x_{1}, 2 x_{2}\right\}$. In either case, we have $\alpha_{5}^{\prime \prime} \leq 3$. Therefore $\left|D_{5}\right| \leq 7$. It follows that

$$
\begin{aligned}
W_{0}(S) & =|P \cap L||L|-5\left|D_{5}\right|+\rho \\
& \geq 3 \cdot 12-5 \cdot 7+\rho \\
& =1+\rho
\end{aligned}
$$

and we are done as well if $z \in D$.
Assume now $\alpha_{4}=0$. Then $\alpha(S)=(0,2,0,0)$, so that $|L|=11$ and $\left|D_{5}\right|=3+$ $\alpha_{5}^{\prime \prime}$. In that case, we have $A_{5} \subseteq 2 A_{2}$, whence $\alpha_{5}^{\prime \prime} \leq 3$ and $\left|D_{5}\right| \leq 6$. It follows that

$$
W_{0}(S) \geq 3 \cdot 11-5 \cdot 6+\rho \geq 3+\rho
$$

That concludes the subcase $\alpha_{2}=2$, i.e. $\alpha(S)=\left(0,2, \alpha_{3}, \alpha_{4}\right)$ here.
 $\alpha_{3} \leq 2$. Since $A_{2} \subset P$, we have $\alpha_{2}^{\prime}=\alpha_{2}=1$ here. Set

$$
A_{2}=\{x\} .
$$

Subsubcase $\alpha_{3}=2$. Then $\alpha(S)=\left(0,1,2, \alpha_{4}\right)$. We have $|L|=12+\alpha_{4}$, whence $|L|=12$ and $\alpha_{4}=0$. Thus $\alpha(S)=(0,1,2,0)$. Hence $\left|D_{5}\right|=4+\alpha_{5}^{\prime \prime}$. Since $A_{3} \cap D \subseteq$ $2 A_{2}$, it follows that $\alpha_{3}^{\prime \prime} \leq 1$ and hence $\alpha_{3}^{\prime} \in\{1,2\}$. Therefore $|P \cap L| \geq 3$. Set

$$
A_{3}=\left\{y_{1}, y_{2}\right\}
$$

$\bullet$ Assume first $\alpha_{3}^{\prime}=1$. Hence $\alpha_{3}^{\prime \prime}=1$, and up to renumbering, we may assume $y_{1}=2 x, y_{2} \in P$. Hence $|P \cap L|=3$ and

$$
A_{5} \cap D \subseteq\left\{3 x, x+y_{2}, 2 y_{2}\right\}
$$

Therefore $\alpha_{5}^{\prime \prime} \leq 3$ and so $\left|D_{5}\right| \leq 7$. We then have

$$
\begin{aligned}
W_{0}(S) & =|P \cap L||L|-5\left|D_{5}\right|+\rho \\
& \geq 3 \cdot 12-5 \cdot 7+\rho \\
& =1+\rho
\end{aligned}
$$

and we are done here.

- Assume now $\alpha_{3}^{\prime}=\alpha_{3}=2$. Thus $y_{1}, y_{2} \in P$ and so $|P \cap L|=4$. We have

$$
A_{5} \cap D \subseteq\{2 x\} \cup\left(x+A_{3}\right) \cup\left(2 A_{3} \cap A_{5}\right)
$$

Thus $\alpha_{5}^{\prime \prime} \leq 3+\left|2 A_{3} \cap A_{5}\right|$, and of course $\left|2 A_{3} \cap A_{5}\right| \leq\left|2 A_{3}\right| \leq 3$ since $\left|A_{3}\right|=2$. At this point we have

$$
\left|D_{5}\right| \leq 7+\left|2 A_{3} \cap A_{5}\right| .
$$

Therefore

$$
\begin{aligned}
W_{0}(S) & =|P \cap L||L|-5\left|D_{5}\right|+\rho \\
& \geq 4 \cdot 12-5 \cdot\left(7+\left|2 A_{3} \cap A_{5}\right|\right)+\rho \\
& =13-5\left|2 A_{3} \cap A_{5}\right|+\rho .
\end{aligned}
$$

Now $\rho \geq\left|2 A_{3} \cap A_{5}\right|$, since $2 A_{3} \cap A_{5} \subseteq C$ and $|C| \leq \rho$. Hence

$$
W_{0}(S) \geq 13-4\left|2 A_{3} \cap A_{5}\right| .
$$

But $\left|2 A_{3} \cap A_{5}\right| \leq 3$ as seen above. It follows that $W_{0}(S) \geq 1$ and we are done here.
$\underline{\text { Subsubcase } \alpha_{3}=1}$. Then $\alpha(S)=\left(0,1,1, \alpha_{4}\right)$. We have

$$
\begin{equation*}
|P \cap L|=2+\alpha_{3}^{\prime}+\alpha_{4}^{\prime},|L|=10+\alpha_{4},\left|D_{5}\right|=3+\alpha_{4}+\alpha_{5}^{\prime \prime} \tag{19}
\end{equation*}
$$

We examine four subcases, depending on which multiples of $x$ belong to $A$.
Case 1. $2 x \in A_{3}, 3 x \in A_{4}$. Then $A_{3}=\{2 x\}$ since $\alpha_{3}=1$, and $A_{4} \cap D=\{3 x\}$. Hence $\alpha_{4}=\alpha_{4}^{\prime}+1$. Moreover,

$$
A_{5} \cap D \subseteq\{4 x\} \cup\left(x+A_{4} \cap P\right)
$$

Whether $4 x$ belongs to $A_{5}$ or not will be measured by $\mathbf{1}_{5}(4 x) \in\{0,1\}$, where $\mathbf{1}_{i}=\mathbf{1}_{A_{i}}$ denotes the indicator function of $A_{i}$ for all $i$. Thus,

$$
\alpha_{5}^{\prime \prime} \leq \mathbf{1}_{5}(4 x)+\alpha_{4}^{\prime},
$$

and so

$$
\begin{equation*}
|P \cap L|=2+\alpha_{4}^{\prime},|L|=11+\alpha_{4}^{\prime}, \quad\left|D_{5}\right|=4+\alpha_{4}^{\prime}+\alpha_{5}^{\prime \prime} \leq 4+2 \alpha_{4}^{\prime}+\mathbf{1}_{5}(4 x) \tag{20}
\end{equation*}
$$

Plugging this data into (5), we get

$$
W_{0}(S) \geq 2+3 \alpha_{4}^{\prime}+\alpha_{4}^{\prime 2}-5 \cdot \mathbf{1}_{5}(4 x)+\rho
$$

If either $\alpha_{4}^{\prime} \neq 0$ or $\mathbf{1}_{5}(4 x)=0$, then $W_{0}(S) \geq \rho$ and we are done. If $\alpha_{4}^{\prime}=0$ and $\mathbf{1}_{5}(4 x)=1$, then $W_{0}(S) \geq-3+\rho$. But in this case, we claim that $\rho \geq 3$. Indeed, both $2 x, 3 x$ are compressed Apéry elements, since $\lambda(x)=2, \lambda(2 x)=3, \lambda(3 x)=4$ and $2 x=x+x, 3 x=x+2 x$. Moreover, since $\mathbf{1}_{5}(4 x)=1$ here, then $4 x$ is also a compressed Apéry element, using $\lambda(4 x)=5$ and $4 x=2 x+2 x$. Hence $\{2 x, 3 x, 4 x\} \subseteq C$. Since $\rho \geq|C|$, this proves $\rho \geq 3$ as claimed and yields $W_{0}(S) \geq 0$, as desired.

Case 2. $2 x \in A_{3}, 3 x \notin A_{4}$. Then $A_{3}=\{2 x\}$ and $A_{4} \subset P$, so that $\alpha_{4}=\alpha_{4}^{\prime}$. We have

$$
A_{5} \cap D \subseteq\{3 x\} \cup\left(x+A_{4}\right)
$$

Hence $\alpha_{5}^{\prime \prime} \leq 1+\alpha_{4}$, and so

$$
|P \cap L|=2+\alpha_{4},|L|=10+\alpha_{4},\left|D_{5}\right|=3+\alpha_{4}+\alpha_{5}^{\prime \prime} \leq 4+2 \alpha_{4} .
$$

Hence $W_{0}(S) \geq 2 \alpha_{4}+\alpha_{4}^{2}+\rho$ and we are done in the present case.
Case 3. $2 x \in A_{4}$. Then $A_{3}=A_{3} \cap P$, so that $\alpha_{3}^{\prime}=\alpha_{3}=1$. We set $A_{3}=\{y\}$. We have $\{2 x\} \subseteq A_{4} \cap D \subseteq\{2 x, x+y\}$ and $A_{5} \cap D \subseteq\{3 x, 2 y, x+y\}$. Since $x+y$ cannot belong to both $A_{4}, A_{5}$, it follows that $\alpha_{4}^{\prime \prime}+\alpha_{5}^{\prime \prime} \leq 4$.

Assume first $\alpha_{4}=2$. We then have

$$
\begin{equation*}
|P \cap L|=3+\alpha_{4}^{\prime},|L|=12, \quad\left|D_{5}\right|=3+\alpha_{4}^{\prime}+\alpha_{4}^{\prime \prime}+\alpha_{5}^{\prime \prime} \leq 7+\alpha_{4}^{\prime} . \tag{21}
\end{equation*}
$$

It follows that $W_{0}(S) \geq 12\left(3+\alpha_{4}^{\prime}\right)-5\left(7+\alpha_{4}^{\prime}\right)+\rho \geq 1+\rho$ and we are done.
Assume now $\alpha_{4}=1$. Then $A_{4}=\{2 x\}$ and $|L|=11$. If $\alpha_{5}^{\prime \prime} \leq 2$, then

$$
|P \cap L|=3,|L|=11,\left|D_{5}\right|=4+\alpha_{5}^{\prime \prime} \leq 6
$$

It follows that $W_{0}(S) \geq 3 \cdot 11-5 \cdot 6+\rho \geq 3+\rho$ and we are done. But if $\alpha_{5}^{\prime \prime}=3$, i.e. if $A_{5} \cap D=\{3 x, 2 y, x+y\}$, then we only get $W_{0}(S) \geq-2+\rho$. But in this case, since $3 x, 2 y \in C$, it follows that $\rho \geq 2$ whence $W_{0}(S) \geq 0$ as desired.

Case 4. $2 x \notin A$. Then as above, $A_{3}=A_{3} \cap P$, so that $\alpha_{3}^{\prime}=\alpha_{3}=1$, and we set $A_{3}=\{y\}$. If $x+y \in A$, then it belongs to either $A_{4}$ or $A_{5}$. But in any case, $x+2 y \notin A$ since $\lambda(x+2 y) \geq 6$, as easily seen. It follows that $A_{4} \cap D \subseteq\{x+y\}$ and $A_{5} \cap D \subseteq\{x+y, 2 y\}$. Hence

$$
\alpha_{4}=\alpha_{4}^{\prime}+\mathbf{1}_{4}(x+y), \alpha_{5}^{\prime \prime} \leq 1+\mathbf{1}_{5}(x+y)
$$

It follows that
$|P \cap L|=3+\alpha_{4}^{\prime},|L|=10+\alpha_{4}^{\prime}+\mathbf{1}_{4}(x+y),\left|D_{5}\right| \leq 4+\alpha_{4}^{\prime}+\mathbf{1}_{4}(x+y)+\mathbf{1}_{5}(x+y)$.
A straightforward computation, using $\mathbf{1}_{4}(x+y)+\mathbf{1}_{5}(x+y) \leq 1$, then yields

$$
\begin{aligned}
W_{0}(S) & \geq 10+8 \alpha_{4}^{\prime}+\alpha_{4}^{\prime 2}+\left(\alpha_{4}^{\prime}-2\right) \cdot \mathbf{1}_{4}(x+y)-5 \cdot \mathbf{1}_{5}(x+y)+\rho \\
& \geq 5+\rho
\end{aligned}
$$

and we are done.
$\underline{\text { Subsubcase } \alpha_{3}=0 .}$ Then $\alpha(S)=\left(0,1,0, \alpha_{4}\right)$. We have

$$
|P \cap L|=2+\alpha_{4}^{\prime},|L|=8+\alpha_{4},\left|D_{5}\right|=2+\alpha_{4}+\alpha_{5}^{\prime \prime}
$$

Here $A_{3}=\emptyset$, and $\alpha_{4} \leq 4$ since $|L| \leq 12$ by assumption.
Case 1. $2 x \in A$. Then $2 x \in A_{4} \sqcup A_{5}$. Thus

$$
A_{4} \cap D \subseteq\{2 x\}, \quad A_{5} \cap D \subseteq\{2 x, 3 x\} \cup\left(x+A_{4} \cap P\right)
$$

Hence $\alpha_{4}=\alpha_{4}^{\prime}+\alpha_{4}^{\prime \prime}=\alpha_{4}^{\prime}+\mathbf{1}_{4}(2 x)$ and $\alpha_{5}^{\prime \prime} \leq \mathbf{1}_{5}(2 x)+\mathbf{1}_{5}(3 x)+\alpha_{4}^{\prime}$. We have
$|P \cap L|=2+\alpha_{4}^{\prime},|L|=8+\alpha_{4}^{\prime}+\mathbf{1}_{4}(2 x),\left|D_{5}\right| \leq 2+2 \alpha_{4}^{\prime}+\mathbf{1}_{4}(2 x)+\mathbf{1}_{5}(2 x)+\mathbf{1}_{5}(3 x)$.
A straightforward computation then yields

$$
W_{0}(S) \geq 6-3 \cdot 1_{4}(2 x)-5 \cdot 1_{5}(2 x)-5 \cdot 1_{5}(3 x)+\rho .
$$

If $3 x \notin A$, then $1_{5}(3 x)=0$ and $W_{0}(S) \geq 1+\rho$. The case $3 x \in A$ is more delicate. It implies $3 x \in A_{5}$, i.e. $\mathbf{1}_{5}(3 x)=1$, and then of course $2 x \in A_{4}$, i.e. $\mathbf{1}_{4}(2 x)=1$ and $\mathbf{1}_{5}(2 x)=0$. Thus $W_{0}(S) \geq-2+\rho$. It remains to show $\rho \geq 2$. Since $(\lambda(x), \lambda(2 x), \lambda(3 x))=(2,4,5)$ here, it follows that $3 x \in C$, whence $\rho \geq 1$. This is not strong enough yet. However, since $(\lambda(2 x), \lambda(3 x))=(4,5)$, we have

$$
4 m-\rho \leq 2 x, 3 x \leq 6 m-\rho-1
$$

Therefore $3(4 m-\rho) / 2 \leq 3 x \leq 6 m-\rho-1$, implying $\rho \geq 2$ as desired, and hence $W_{0}(S) \geq 0$.

Case 2. $2 x \notin A$. Then $A_{3}=A_{4} \cap D=\emptyset$. Hence $A_{4}=A_{4} \cap P$ and $A_{5} \cap D \subseteq$ $x+A_{4}$. That is, we have $\alpha_{4}=\alpha_{4}^{\prime}$ and $\alpha_{5}^{\prime \prime} \leq \alpha_{4}$. Thus $\left|D_{5}\right| \leq 2+2 \alpha_{4}$, and a straightforward computation yields

$$
W_{0}(S) \geq 6+\rho .
$$

### 4.3.3 Case $q=6$

Then $\alpha(S)=\left(0, \alpha_{2}, \alpha_{3}, \alpha_{4}, \alpha_{5}\right)$. We have $12 \geq|L|=6+4 \alpha_{2}+3 \alpha_{3}+2 \alpha_{4}+\alpha_{5}$, whence $\alpha_{2} \leq 1$.
Subcase $\alpha_{2}=1$. Then $|L|=10+3 \alpha_{3}+2 \alpha_{4}+\alpha_{5}$, implying $\alpha_{3}=0$ and $\alpha_{4} \leq 1$. Thus $\alpha(S)=\left(0,1,0, \alpha_{4}, \alpha_{5}\right)$. We set

$$
A_{2}=\{x\},
$$

with $x \in P$ since $A_{2} \cap D=\emptyset$. We have $A_{3}=\emptyset$.
Subsubcase $\alpha_{4}=1$. Then $|L|=12$, whence $\alpha_{5}=0$ and so $\alpha(S)=(0,1,0,1,0)$. Set $A_{4}=\{z\}$. Since $A_{3}=A_{5}=\emptyset$, it follows that $2 x \in A$ if and only if $2 x=z$. That is, either $z \in A \cap P$ and $2 x \notin A$, or else $z=2 x$. In either case, we have

$$
A_{6} \cap D \subseteq x+A_{4}
$$

whence $\alpha_{6}^{\prime \prime} \leq 1$. Summarizing, we have

$$
|P \cap L|=2+\alpha_{4}^{\prime},|L|=12,\left|D_{6}\right|=3+\alpha_{6}^{\prime \prime} \leq 4 .
$$

It follows that

$$
W_{0}(S) \geq\left(2+\alpha_{4}^{\prime}\right) \cdot 12-6 \cdot 4+\rho \geq \rho
$$

and we are done here.
Subsubcase $\alpha_{4}=0$. Then $\alpha(S)=\left(0,1,0,0, \alpha_{5}\right)$. Since $\lambda(2 x) \in[3,5]$ and $A_{3}=A_{4}=\emptyset$, we have $2 x \in A$ if and only if $2 x \in A_{5}$. Therefore $A_{5} \cap D \subseteq\{2 x\}$, i.e. $\alpha_{5}^{\prime \prime} \leq 1$. However $3 x \notin A_{6}$. For if $3 x \in A_{6}$, then $2 x \in A_{5}$ by Lemma 2.13, whence

$$
5 m-\rho \leq 2 x, 3 x \leq 7 m-\rho-1
$$

Thus $3(5 m-\rho) / 2 \leq 3 x \leq 7 m-\rho-1$, whence $\rho \geq m+2$, in contradiction with $\rho \in\left[0, m\left[\right.\right.$. Therefore $A_{6} \cap D \subseteq x+\left(A_{5} \cap P\right)$, i.e. $\alpha_{6}^{\prime \prime} \leq \alpha_{5}^{\prime}$. Summarizing, we have

$$
|P \cap L|=2+\alpha_{5}^{\prime},|L|=10+\alpha_{5},\left|D_{6}\right|=2+\alpha_{5}+\alpha_{6}^{\prime \prime} \leq 2+\alpha_{5}+\alpha_{5}^{\prime} .
$$

A straightforward computation then yields

$$
W_{0}(S) \geq 8-4 \alpha_{5}^{\prime \prime}+\rho,
$$

whence $W_{0}(S) \geq 4+\rho$ since $\alpha_{5}^{\prime \prime} \leq 1$.
Subcase $\alpha_{2}=0$. Then $\alpha(S)=\left(0,0, \alpha_{3}, \alpha_{4}, \alpha_{5}\right)$ and Theorem 3.1 yields $W_{0}(S) \geq$ 0 .

### 4.3.4 Case $q=7$

Here $\alpha(S)=\left(0, \alpha_{2}, \alpha_{3}, \alpha_{4}, \alpha_{5}, \alpha_{6}\right)$. Then $12 \geq|L| \geq 7+5 \alpha_{2}$, whence $\alpha_{2} \leq 1$.

- If $\alpha_{2}=1$, then $|L|=12$ and $\alpha_{3}=\cdots=\alpha_{6}=0$. It follows that $A \cap D=0$, whence $\alpha_{7}^{\prime \prime}=0$. Thus $|P \cap L|=2$ and $\left|D_{7}\right|=2$. Therefore

$$
W_{0}(S)=2 \cdot 12-7 \cdot 2+\rho=10+\rho
$$

and we are done in this case.

- If $\alpha_{2}=0$, then $|L|=7+4 \alpha_{3}+3 \alpha_{4}+2 \alpha_{5}+\alpha_{6}$, whence $\alpha_{3} \leq 1$.
-• Assume $\alpha_{3}=1$. Then $\alpha(S)=\left(0,0,1, \alpha_{4}, \alpha_{5}, \alpha_{6}\right)$ and $|L|=11+2 \alpha_{5}+\alpha_{6}$, whence $\alpha_{4}=\alpha_{5}=0$ and $\alpha_{6} \leq 1$. Thus in fact, $\alpha(S)=\left(0,0,1,0,0, \alpha_{6}\right)$ and $|L|=$ $11+\alpha_{6}$. We set

$$
A_{3}=\{x\} .
$$

Of course $x \in P$ since $A_{1}=A_{2}=\emptyset$. Since $A_{4}=A_{5}=\emptyset$, it follows that $A_{6} \cap D \subseteq$ $\{2 x\}$. Moreover, since $\left(S_{3}+S_{6}\right) \cap S_{7}=\emptyset$, we also have $A_{7} \cap D \subseteq\{2 x\}$. Thus

$$
\alpha_{6}^{\prime \prime}=\mathbf{1}_{6}(2 x), \quad \alpha_{7}^{\prime \prime}=\mathbf{1}_{7}(2 x)
$$

Summarizing, we have
$|P \cap L|=2+\alpha_{6}^{\prime},|L|=11+\alpha_{6},\left|D_{7}\right|=2+\alpha_{6}+\alpha_{7}^{\prime \prime}=2+\alpha_{6}^{\prime}+\mathbf{1}_{6}(2 x)+\mathbf{1}_{7}(2 x)$.
A straightforward computation, using $\mathbf{1}_{6}(2 x)+\mathbf{1}_{7}(2 x) \leq 1$, then yields

$$
W_{0}(S) \geq 1+\rho
$$

and we are done.
$\bullet$ Finally, assume $\alpha_{3}=0$. Then $\alpha(S)=\left(0,0,0, \alpha_{4}, \alpha_{5}, \alpha_{6}\right)$. In that case, since $\alpha_{1}=\cdots=\alpha_{h-1}=0$ where $h=\lceil q / 2\rceil=4$, Theorem3.1 implies $W_{0}(S) \geq 0$.

### 4.3.5 $\quad$ Case $q \geq 8$

For depth $q \geq 8$, Proposition 4.2 yields $W_{0}(S) \geq 0$.

### 4.4 Concluding remarks

Having examined above all possible Apéry profiles $\alpha(S)$ compatible with $|L| \leq 12$, the proof of Theorem 4 is now complete.

As mentioned earlier, among the more than $10^{13}$ numerical semigroups of genus $g \leq 60$, exactly five of them satisfy $W_{0}(S)<0$. These five exceptions have depth $q=4$ and Apéry profile $\alpha(S)=(2,0,3)$, yielding $|L|=4+2 \cdot 3+3=13$. Moreover, they satisfy $c=4 m,|P \cap L|=\left|P_{1}\right|=3$ and $\alpha_{4}^{\prime \prime}=4$, whence $\left|D_{4}\right|=10$ and $W_{0}(S)=3 \cdot 13-4 \cdot 10=-1$.

Infinite families of numerical semigroups satisfying $W_{0}(S)<0$ have been constructed in [2, 7]. However, they all turn out to satisfy $W(S) \geq 0$. It would be very interesting to characterize those $S$ satisfying $W_{0}(S)<0$, but that will likely be hard to achieve. Less ambitiously, can one determine how many such cases occur in, say, genus $g \leq 100$ ?
