# ON SOME SUBSPACES OF THE EXTERIOR ALGEBRA OF A SIMPLE LIE ALGEBRA 

JEAN-YVES CHARBONNEL


#### Abstract

In this article, we are interested in some subspaces of the exterior algebra of a simple Lie algebra $\mathfrak{g}$. In particular, we prove that some graded subspaces of degree $d$ generate the $\mathfrak{g}$-module $\wedge^{d}(\mathfrak{g})$ for some integers $d$.

## 1. Introduction

In this note, the base field $\mathbb{k}$ is algebraically closed of characteristic $0, g$ is a simple Lie algebra of finite dimension, $\ell$ is its rank, and $G$ is its adjoint group.
1.1. Main results. Let $\mathfrak{b}$ be a Borel subalgebra of $\mathfrak{g}, \mathfrak{b}$ a Cartan subalgebra of $\mathfrak{g}$, contained in $\mathfrak{b}$ and $\mathfrak{u}$ the nilpotent radical of $\mathfrak{b}$. Set $\mathrm{b}_{\mathfrak{g}}:=\operatorname{dim} \mathfrak{b}$ and $n:=\mathrm{b}_{\mathfrak{g}}-\ell$. For $k$ a nonnegative integer, let $\Lambda^{k}(\mathfrak{g})$ be the component of degree $k$ of the exterior algebra $\Lambda(\mathfrak{g})$ of $\mathfrak{g}$. The adjoint action of $G$ in $\mathfrak{g}$ induces an action of $G$ in $\bigwedge(\mathfrak{g})$. For all $k, \bigwedge^{k}(\mathfrak{g})$ is invariant under this action.

For $\mathfrak{p}$ parabolic subalgebra of $\mathfrak{g}$, containing $\mathfrak{b}$, denote by $\mathfrak{p}_{\mathfrak{u}}$ the nilpotent radical of $\mathfrak{p}$, $\mathfrak{I}$ the reductive factor of $\mathfrak{p}$, containing $\mathfrak{h}$, $\mathfrak{z}$ the center of $\mathfrak{I}$ and $\mathfrak{p}_{-, u}$ the complement to $\mathfrak{p}$ in $\mathfrak{g}$, invariant under the adjoint action of $\mathfrak{h}$. Let $\mathfrak{D}$ be the derived algebra of $\mathfrak{I}$ and $\mathfrak{D}_{1}, \ldots, \mathfrak{D}_{\mathrm{n}}$ its simple factors. Set:

\mathbb{I}_{k}:=\left\{\left(j_{1}, \ldots, j_{\mathrm{n}}\right) \in \mathbb{N}^{\mathrm{n}} \mid j_{1} \leq n_{1}, \ldots, j_{\mathrm{n}} \leq n_{\mathrm{n}}, j_{1}+\cdots+j_{\mathrm{n}}=k\right\}
\end{gathered}
$$

[^0]for $k$ positive integer. Denote by $V_{k, p}^{\prime}$ and $V_{k, \mathfrak{p}}$ the subspaces of $\bigwedge^{k}(\mathfrak{g})$,
$$
V_{k, \mathfrak{p}}^{\prime}:=\bigoplus_{\left(j_{1}, \ldots, j_{\mathrm{n}}\right) \in \mathbb{I}_{k}} \wedge^{j_{1}}\left(\mathrm{D}_{1}\right) \wedge \cdots \wedge \bigwedge^{j_{\mathrm{n}}}\left(\mathrm{D}_{\mathrm{n}}\right) \quad \text { and } \quad V_{k, \mathfrak{p}}:=\bigoplus_{i=0}^{k} \bigwedge^{i}\left(E_{\mathfrak{p}}\right) \wedge V_{k-i, p}^{\prime}
$$

The goal of this note is the following theorem:
Theorem 1.1. Let $k=1, \ldots, n$. Then $\bigwedge^{k}(\mathfrak{g})$ is the $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $V_{k, p}$.
This result arises from the study of the commuting variety of $\mathfrak{g}$ (see [Ch20]). One of the main step of the proof is to consider the orthogonal complements to some subspaces of $\bigwedge^{k}(\mathrm{~g})$ in $\bigwedge^{k}(\mathrm{~g})$ with respect to the canonical extension of the Killing form of $\mathfrak{g}$ to $\bigwedge^{k}(\mathfrak{g})$.
1.2. Notations. • Let $\mathbb{k}^{*}:=\mathbb{k} \backslash\{0\}$. For $E$ a finite set, its cardinality is denoted by $|E|$. For $k, m$ positive integers, set:

\mathbb{N}_{k}^{m}:=\left\{\left(j_{1}, \ldots, j_{m}\right) \in \mathbb{N}^{m} \mid j_{1}+\cdots+j_{m}=k\right\}
$$

As usual, for $i=\left(i_{1}, \ldots, i_{m}\right)$ in $\mathbb{N}^{m}$,

$$
|i|:=i_{1}+\cdots+i_{m}
$$

- For $V$ vector space, denote by $\Lambda(V)$ the exterior algebra of $V$. This algebra has a natural gradation. For $i$ integer, denote by $\bigwedge^{i}(V)$ the space of degree $i$ of $\bigwedge(V)$. In particular, for $i$ negative, $\bigwedge^{i}(V)$ is equal to $\{0\}$. As $\mathfrak{g}$ is a $G$-module for the adjoint action, so is $\bigwedge^{i}(\mathfrak{g})$ for all $i$.

Lemma 1.2. Let $A$ be a subgroup of $G$, $k$ a positive integer, $i$ a positive integer smaller than $k, V$ a subspace of $\bigwedge^{i}(\mathfrak{g})$ and $W$ the $A$-submodule of $\bigwedge^{i}(\mathfrak{g})$ generated by $V$. Then, for all $A$-submodule $W^{\prime}$ of $\bigwedge^{k-i}(\mathfrak{g}), W \wedge W^{\prime}$ is the A-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $V \wedge W^{\prime}$.

Proof. Let $W^{\prime \prime}$ be the $A$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $V \wedge W^{\prime}$. Let $\omega$ and $\omega^{\prime}$ be in $W$ and $W^{\prime}$ respectively. For some $\omega_{1}, \ldots, \omega_{m}$ in $V$ and $g_{1}, \ldots, g_{m}$ in $A$,

$$
\omega=g_{1} \cdot \omega_{1}+\cdots+g_{m} \cdot \omega_{m}
$$

whence

$$
\omega \wedge \omega^{\prime}=g_{1} \cdot\left(\omega_{1} \wedge g_{1}^{-1} \cdot \omega^{\prime}\right)+\cdots+g_{m} \cdot\left(\omega_{m} \wedge g_{m}^{-1} \cdot \omega^{\prime}\right)
$$

and $W^{\prime \prime}=W \wedge W^{\prime}$.

- The Killing form of $\mathfrak{g}$ is denoted by $\langle.,$.$\rangle . For k$ positive integer, the Killing form of $\mathfrak{g}$ has a natural extension to $\bigwedge^{k}(\mathfrak{g})$ and this extension is not degenerate.
- For $\mathfrak{a}$ a semisimple Lie algebra, denote by $\mathrm{b}_{\mathrm{a}}$ the dimension of its Borel subalgebras and $\ell_{\mathrm{a}}$ its rank.
- Let $\mathcal{R}$ be the root system of $\mathfrak{h}$ in $\mathfrak{g}, \mathcal{R}_{+}$the positive root system of $\mathcal{R}$ defined by $\mathfrak{b}$ and $\Pi$ the basis of $\mathcal{R}_{+}$. For $\alpha$ in $\mathcal{R}, H_{\alpha}$ is the coroot of $\alpha$, the corresponding root subspace is denoted by $\mathfrak{g}^{\alpha}$ and a generator $x_{\alpha}$ of $\mathfrak{g}^{\alpha}$ is chosen so that $\left\langle x_{\alpha}, x_{-\alpha}\right\rangle=1$.
- We consider on $\Pi$ its structure of Dynkin diagram. As $\mathfrak{g}$ is simple, $\Pi$ is connected and has three extremities when $\Pi$ has type $\mathrm{D}_{\ell}, \mathrm{E}_{6}, \mathrm{E}_{7}, \mathrm{E}_{8}$, one extremity when $\Pi$ has type $\mathrm{A}_{1}$ and 2 otherwise. The elements $\beta_{1}, \ldots, \beta_{\ell}$ of $\Pi$ are ordered as in [Bou02, Ch. VI].
- Let $X$ be a subset of $\Pi$. We denote by $\mathcal{R}_{X}$ the root subsystem of $\mathcal{R}$ generated by $X$ and we set

<X>:=\mathcal{R}_{+} \cap \mathcal{R}_{X} \quad \text { so that } \quad \mathcal{R}_{X}=<X>\cup-<X>
$$

Let $\mathfrak{p}_{X}$ be the parabolic subalgebra of $\mathfrak{g}$,

$$
\mathfrak{p}_{X}:=\mathfrak{b} \oplus \bigoplus_{\alpha \in\langle X\rangle} \mathfrak{g}^{-\alpha}
$$

$\mathfrak{p}_{X, u}$ its nilpotent radical, $\mathfrak{l}_{X}$ the reductive factor of $\mathfrak{p}_{X}$ containing $\mathfrak{h},{ }_{3}$ the center of $\mathfrak{l}_{X}, \mathfrak{D}_{X}$ the derived algebra of $\mathfrak{l}_{X}, \mathfrak{p}_{X,-,, \mathrm{u}}$ the complement to $\mathfrak{p}_{X}$ in $\mathfrak{g}$, invariant under ad $\mathfrak{h}$ and $E_{X}$ the sum of ${ }_{3 X}, \mathfrak{p}_{X, \mathrm{u}}, \mathfrak{p}_{X,-, \mathrm{u}}$. When $X$ is empty, $\mathfrak{p}_{X}$ is the Borel subalgebra b .

- Let $X$ be a nonempty subset of $\Pi$ and $X_{1}, \ldots, X_{\mathrm{n}_{X}}$ its connected components. For $i=$ $1, \ldots, \mathrm{n}_{X}$, denote by $n_{i}$ the cardinality of $\left\langle X_{i}\right\rangle$ and $\mathfrak{D}_{i}$ the subalgebra of $\mathfrak{g}$ generated by $\mathfrak{g}^{ \pm \beta}, \beta \in X_{i}$. Then $\mathfrak{D}_{1}, \ldots, \mathfrak{D}_{\mathrm{n}_{X}}$ are the simple factors of $\mathfrak{D}_{X}$. For $k$ positive integer, set:

$$
V_{k, \mathrm{p}_{X}}:=\bigoplus_{j_{1}=0}^{n_{1}} \cdots \bigoplus_{j_{\mathrm{n}_{X}}=0}^{n_{\mathrm{n}_{X}}} \bigwedge^{j_{1}}\left(\mathrm{D}_{1}\right) \wedge \cdots \wedge \bigwedge^{j_{\mathrm{n}_{X}}}\left(\mathrm{D}_{\mathrm{n}_{X}}\right) \wedge \bigwedge^{k-j_{1}-\cdots-j_{\mathrm{n}_{X}}}\left(E_{X}\right)
$$

and denote by $V_{k, X}$ the $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $V_{k, p_{X}}$.

## 2. Orthogonal complement

Let $\ell \geq 2$ and $X$ a nonempty subset of $\Pi$. Set:

$$
\begin{aligned}
& \mathfrak{p}:=\mathfrak{p}_{X}, \quad \mathfrak{p}_{\mathrm{u}}:=\mathfrak{p}_{X, \mathrm{u}}, \quad \mathfrak{l}:=\mathfrak{l}_{X}, \quad \mathfrak{p}_{-, \mathrm{u}}:=\mathfrak{p}_{X,-\mathrm{u}}, \\
& \mathfrak{p}_{ \pm, \mathrm{u}}:=\mathfrak{p}_{\mathrm{u}} \oplus \mathfrak{p}_{-, \mathrm{u}}, \quad \mathfrak{p}_{-}:=\mathfrak{l} \oplus \mathfrak{p}_{-, \mathrm{u}}, \quad d:=\operatorname{dim} \mathfrak{p}_{\mathrm{u}} .
\end{aligned}
$$

2.1. General fact. Let $A$ be a subgroup of $G$. For $k$ positive integer and $W$ subspace of $\bigwedge^{k}(\mathfrak{g})$, denote by $W^{\perp}$ the orthogonal complement to $W$ in $\bigwedge^{k}(\mathfrak{g})$. As the bilinear form on $\bigwedge^{k}(\mathfrak{g})$, defined by the Killing form, is not degenerate,

$$
\operatorname{dim} W+\operatorname{dim} W^{\perp}=\operatorname{dim} \bigwedge^{k}(\mathfrak{g})
$$

Lemma 2.1. Let $k$ be a positive integer smaller than $\operatorname{dimg}$. Let $V$ be a subspace of $\bigwedge^{k}(\mathfrak{g})$. Denote by $W$ the $A$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $V$. Then $W^{\perp}$ is the biggest $A$-submodule of $\bigwedge^{k}(\mathfrak{g})$, contained in $V^{\perp}$.

Proof. Denote by $W^{\#}$ the biggest $A$-submodule contained in $V^{\perp}$. As $W$ is a $A$-module, so is $W^{\perp}$. Then $W^{\perp}$ is contained in $W^{\#}$. Moreover, $V$ is contained in the orthogonal complement to $W^{\#}$ in $\bigwedge^{k}(\mathfrak{g})$. Hence $W$ is orthogonal to $W^{\#}$ since the orthogonal complement to $W^{\#}$ is a $A$-module. As a result, $W^{\#}=W^{\perp}$.
2.2. Orthogonality. Let $V$ be a finite dimensional vector space with a non degenerate symmetric bilinear form on $V$. For $k$ positive integer, it induces a non degenerate symmetric bilinear form on $\bigwedge^{k}(V)$. Let $V_{1}, \ldots, V_{m}$ be pairwise orhogonal subspaces of $V$ such that $V$ is the direct sum of these subspaces. For $i=\left(i_{1}, \ldots, i_{m}\right)$ in $\mathbb{N}_{k}^{m}$, set:

$$
C_{i, V}:=\bigwedge^{i_{1}}\left(V_{1}\right) \wedge \cdots \wedge \wedge^{i_{m}}\left(V_{m}\right) .
$$

If $V_{m}$ is the direct sum of two isotropic subspaces $V_{m,+}$ and $V_{m,-}$, for $i=\left(i_{1}, \ldots, i_{m+1}\right)$ in $\mathbb{N}_{k}^{m+1}$, set:

$$
\begin{gathered}
i^{*}:=\left(i_{1}, \ldots, i_{m-1}, i_{m+1}, i_{m}\right) \text { and } \\
C_{i, V}^{\prime}:=\bigwedge^{i_{1}}\left(V_{1}\right) \wedge \cdots \wedge \bigwedge^{i_{m-1}}\left(V_{m-1}\right) \wedge \bigwedge^{i_{m}}\left(V_{m,+}\right) \wedge \bigwedge^{i_{m+1}}\left(V_{m,-}\right) .
\end{gathered}
$$

## Lemma 2.2. Let $k$ be a positive integer.

(i) For $i, i^{\prime}$ in $\mathbb{N}_{k}^{m}$, if $i \neq i^{\prime}$ then $C_{i, V}$ is orthogonal to $C_{i^{\prime}, V}$.
(ii) Suppose that $V_{m}$ is the direct sum of two isotropic subspaces $V_{m,+}$ and $V_{m,-}$. For $i, i^{\prime}$ in $\mathbb{N}_{k}^{m+1}$, if $i^{\prime} \neq i^{*}$ then $C_{i, V}^{\prime}$ is orthogonal to $C_{i^{\prime}, V}^{\prime}$.
Proof. Denote by $\langle.,$.$\rangle the symmetric bilinear form on V$ and $\bigwedge^{k}(V)$. As $V_{1}, \ldots, V_{m}$ are pairwise orthogonal and $V$ is the direct sum of these subspaces, for $i=1, \ldots, m$, the restriction to $V_{i} \times V_{i}$ of $\langle.,$.$\rangle is non degenerate. For j=1, \ldots, m$, let $n_{j}$ be the dimension of the sum

$$
V_{1} \oplus \cdots \oplus V_{j}
$$

and $v_{1}, \ldots, v_{n_{m}}$ an orthonormal basis of $V$ such that $\left\{v_{1}, \ldots, v_{n_{j}}\right\}$ is contained in the union of $V_{1}, \ldots, V_{j}$ for $j=1, \ldots, m$.
(i) Let $i$ and $i^{\prime}$ be in $\mathbb{N}_{k}^{m}$ such that $i \neq i^{\prime}$. If $k>n_{m}$, there is nothing to prove. Suppose $k \leq n_{m}$. For $j=j_{1}, \ldots, j_{k}$ in $\left\{1, \ldots, n_{m}\right\}$ such that $1 \leq j_{1}<\cdots<j_{k} \leq n_{m}$, set:

$$
w_{j}:=v_{j_{1}} \wedge \cdots \wedge v_{j_{k}} .
$$

Setting $n_{0}:=0, w_{j}$ is in $C_{i, V}$ if and only if

$$
\left|\left\{l \in\{1, \ldots, k\} \mid n_{s-1}+1 \leq j_{l} \leq n_{s}\right\}\right|=i_{s}
$$

for $s=1, \ldots, m$. Denote by $I_{i}$ the set of $j$ satisfying this condition so that $w_{j}, j \in I_{i}$ is a basis of $C_{i, V}$.

Let $\left(j, j^{\prime}\right)$ be in $I_{i} \times I_{i^{\prime}}$. By definition,

$$
\left\langle w_{j}, w_{j^{\prime}}\right\rangle=\operatorname{det}\left(\left\langle v_{j l}, v_{j_{l^{\prime}}}\right\rangle, 1 \leq l, l^{\prime} \leq k\right) .
$$

As the basis $v_{1}, \ldots, v_{n_{m^{\prime}}}$ is orthonormal,

$$
\left\langle v_{j l}, v_{j_{l}^{\prime}}\right\rangle=\delta_{j_{l}, j_{l}^{\prime}}
$$

with $\delta_{s, s^{\prime}}$ the Kronecker symbol. As a result, if all the lines of the above matix are all different from 0 then

$$
\left|\left\{l \in\{1, \ldots, k\} \mid n_{s-1}+1 \leq j_{l} \leq n_{s}\right\}\right|=\left|\left\{l \in\{1, \ldots, k\} \mid n_{s-1}+1 \leq j_{l}^{\prime} \leq n_{s}\right\}\right|
$$

for $s=1, \ldots, m$ since $V_{1}, \ldots, V_{m}$ are pairwise orthogonal. Then $\left\langle w_{j}, w_{j^{\prime}}\right\rangle=0$ since $i \neq i^{\prime}$, whence the assertion.
(ii) Let $i$ and $i^{\prime}$ be in $\mathbb{N}_{k}^{m+1}$ such that $i^{\prime} \neq i^{*}$. By (i), we can suppose that $i_{s}=i_{s}^{\prime}$ for $s=$ $1, \ldots, m-1$. Since $V_{m,+}$ and $V_{m,-}$ are isotropic, they have the same dimension $m_{0}$ and $V_{m}$ has a basis $u_{1}, \ldots, u_{2 m_{0}}$ such that

$$
\left\{u_{1}, \ldots, u_{m_{0}}\right\} \subset V_{m,+}, \quad\left\{u_{m_{0}+1}, \ldots, u_{2 m_{0}}\right\} \subset V_{m,-}, \quad\left\langle u_{s}, u_{s^{\prime}+m_{0}}\right\rangle=\delta_{s, s^{\prime}}
$$

for $1 \leq s, s^{\prime} \leq m_{0}$. Let $v_{1}^{\prime}, \ldots, v_{n_{m}}^{\prime}$ be the basis of $V$ such that $v_{l}^{\prime}=v_{l}$ for $l=1, \ldots, n_{m-1}$ and $v_{l^{\prime}}^{\prime}=$ $u_{l^{\prime}-n_{m-1}}$ for $l^{\prime}=n_{m-1}+1, \ldots, n_{m}$. For $j=j_{1}, \ldots, j_{k}$ in $\left\{1, \ldots, n_{m}\right\}$ such that $1 \leq j_{1}<\cdots<j_{k} \leq n_{m}$, set:

$$
w_{j}^{\prime}=v_{j_{1}}^{\prime} \wedge \cdots \wedge v_{j_{k}}^{\prime}
$$

Then $w_{j}^{\prime}$ is in $C_{i, V}^{\prime}$ if and only if

$$
\begin{gathered}
\left|\left\{l \in\{1, \ldots, k\} \mid n_{m-1}+1 \leq j_{l} \leq n_{m-1}+m_{0}\right\}\right|=i_{m}, \quad\left|\left\{l \in\{1, \ldots, k\} \mid n_{m-1}+m_{0}+1 \leq j_{l} \leq n_{m}\right\}\right|=i_{m+1} \\
\left|\left\{l \in\{1, \ldots, k\} \mid n_{s-1}+1 \leq j_{l} \leq n_{s}\right\}\right|=i_{s}
\end{gathered}
$$

for $s=1, \ldots, m-1$. Denote by $I_{i}$ the set of $j$ satisfying this condition so that $w_{j}^{\prime}, j \in I_{i}$ is a basis of $C_{i, V}^{\prime}$.

Let $\left(j, j^{\prime}\right)$ be in $I_{i} \times I_{i^{\prime}}$. By definition,

$$
\left\langle w_{j}^{\prime}, w_{j^{\prime}}^{\prime}\right\rangle=\operatorname{det}\left(\left\langle v_{j l}^{\prime}, v_{j_{l}^{\prime}}^{\prime}\right\rangle, 1 \leq l, l^{\prime} \leq k\right)
$$

Then

$$
\begin{gathered}
j_{l} \leq n_{m-1} \Longrightarrow\left\langle v_{j l}^{\prime}, v_{j_{l}^{\prime}}^{\prime}\right\rangle=\delta_{j_{j}, j_{l}^{\prime}}, \\
j_{l}>n_{m-1} \quad \text { and } \quad j_{l}^{\prime}>n_{m-1} \Longrightarrow\left\langle v_{j_{l}}^{\prime}, v_{j_{l}^{\prime}}^{\prime}\right\rangle=\delta_{\left|j_{j}-j_{l}^{\prime}\right|, m_{0}}
\end{gathered}
$$

As a result, if all the lines of the above matix are all different from 0 then

$$
\left|\left\{l \in\{1, \ldots, k\} \mid n_{m-1}+1 \leq j_{l} \leq n_{m-1}+m_{0}\right\}\right|=\left|\left\{l \in\{1, \ldots, k\} \mid n_{m-1}+m_{0}+1 \leq j_{l}^{\prime} \leq n_{m}\right\}\right|
$$

since $i_{s}=i_{s}^{\prime}$ for $s \leq m-1$ and $V_{1}, \ldots, V_{m}$ are pairwise orthogonal. Then $\left\langle w_{j}, w_{j^{\prime}}\right\rangle=0$ since $i^{\prime} \neq i^{*}$, whence the assertion.

For $i=\left(i_{1}, i_{2}, i_{3}\right)$ in $\mathbb{N}^{3}$, set:

C_{i}:=\bigwedge_{1}^{i_{1}}(\mathfrak{l}) \wedge \bigwedge^{i_{2}}\left(\mathfrak{p}_{\mathrm{u}}\right) \wedge \bigwedge^{i_{3}}\left(\mathfrak{p}_{-, \mathrm{u}}\right)
$$

and denote by $i^{*}$ the element $\left(i_{1}, i_{3}, i_{2}\right)$ of $\mathbb{N}^{3}$.
Corollary 2.3. Let $k$ be a positive integer.
(i) For $i, i^{\prime}$ in $\mathbb{N}_{k^{\prime}}^{3}, C_{i}$ is orthogonal to $C_{i^{\prime}}$ if $i^{*} \neq i^{\prime}$.
(ii) For $i$ in $\mathbb{N}_{k}^{3}$, the orthogonal complement to $C_{i}$ in $\bigwedge^{k}(\mathfrak{g})$ is equal to

$$
\bigoplus_{\left.i^{\prime} \in \mathbb{N}_{k}^{3}\right\}\left\{i^{*}\right\}} C_{i^{\prime}}
$$

Proof. (i) Let $i$ and $i^{\prime}$ be in $\mathbb{N}_{k}^{3}$ such that $i^{*} \neq i^{\prime}$. By Lemma 2.1(ii), $C_{i}$ is orthogonal to $C_{i^{\prime}}$ since I and $\mathfrak{p}_{ \pm, \mathrm{u}}$ are orthogonal and $\mathfrak{p}_{\mathrm{u}}$ and $\mathfrak{p}_{-, \mathrm{u}}$ are isotropic.
(ii) Since $\bigwedge^{k}(\mathrm{~g})$ is the direct sum of $C_{i^{\prime}}, i^{\prime} \in \mathbb{N}_{k}^{3}$, the orthogonal complement to $C_{i}$ in $\bigwedge^{k}(\mathrm{~g})$ is the direct sum of $C_{i^{\prime}}, i^{\prime} \in \mathbb{N}_{k}^{\mathrm{n}+3} \backslash\left\{i^{*}\right\}$ by (i).

Corollary 2.4. Let $k=1, \ldots, d$.
(i) The orthogonal complement to $\bigwedge^{k}\left(\mathfrak{p}_{-, \mathrm{u}}\right)$ in $\bigwedge^{k}(\mathfrak{g})$ is equal to $\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$.
(ii) The orthogonal complement to $\bigwedge^{k}\left(\mathfrak{p}_{ \pm, u}\right)$ in $\bigwedge^{k}(\mathfrak{g})$ is equal to $\mathfrak{I} \wedge \bigwedge^{k-1}(\mathfrak{g})$.

Proof. (i) Let $I_{1}$ be the subset of $\mathbb{N}_{k}^{3}$,

The complement to $I_{1}^{*}$ in $\mathbb{N}_{k}^{3}$ is equal to

\left\{\left(i_{1}, i_{2}, i_{3}\right) \in \mathbb{N}_{k}^{3} \mid i_{1}>0 \quad \text { or } \quad i_{3}>0\right\}
$$

whence the assertion by Corollary 2.3 since

\bigwedge^{k}\left(\mathfrak{p}_{-, \mathrm{u}}\right)=\bigoplus_{i \in I_{1}} C_{i} .
$$

(ii) Let $I_{2}$ be the subset of $\mathbb{N}_{k}^{3}$,

I_{2}:=\left\{\left(i_{1}, i_{2}, i_{3}\right) \in \mathbb{N}_{k}^{3} \mid i_{1}=0\right\} .
$$

The complement to $I_{2}^{*}$ in $\mathbb{N}_{k}^{3}$ is equal to

\left\{\left(i_{1}, i_{2}, i_{3}\right) \in \mathbb{N}_{k}^{3} \mid i_{1}>0\right\}
$$

whence the assertion by Corollary 2.3 since $\bigwedge^{k}\left(\mathfrak{p}_{ \pm, \mathrm{u}}\right)$ is the sum of $C_{i}, i \in I_{2}$.

## 3. Action of the unipotent radical of a parabolic subgroup

Let $\ell \geq 2$ and $X$ a subset of $\Pi$. Set:

\mathfrak{p}:=\mathfrak{p}_{X}, \quad \mathfrak{p}_{\mathrm{u}}:=\mathfrak{p}_{X, \mathrm{u}}, \quad \mathfrak{l}:=\mathfrak{l}_{X}, \quad \mathfrak{p}_{-, \mathrm{u}}:=\mathfrak{p}_{X,-, \mathrm{u}}, \\
\mathfrak{p}_{ \pm, \mathrm{u}}:=\mathfrak{p}_{\mathrm{u}} \oplus \mathfrak{p}_{-, \mathrm{u}}, \quad \mathfrak{p}_{-}:=\mathfrak{l} \oplus \mathfrak{p}_{-, \mathrm{u}}, \quad d:=\operatorname{dim} \mathfrak{p}_{\mathrm{u}}
\end{gathered}
$$

Denote by $L$ and $H$ the connected closed subgroups of $G$ whose Lie algebras are $\mathfrak{I}$ and $\mathfrak{h}$ respectively. Let $P$ and $P_{-}$be the normalizers of $\mathfrak{p}$ and $\mathfrak{p}_{-}$in $G$ and $P_{\mathrm{u}}$ and $P_{-, \mathrm{u}}$ their unipotent radicals.
3.1. Invariant subspaces. Let $k=1, \ldots, d, W_{k}$ the biggest $P_{\mathrm{u}}$-submodule of $\bigwedge^{k}(\mathfrak{g})$ contained in $\mathfrak{p}_{-} \wedge \Lambda^{k-1}(\mathfrak{g})$ and $V_{k, \mathrm{u}}$ the $P_{\mathrm{u}}$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $\Lambda^{k}\left(\mathfrak{p}_{-, \mathrm{u}}\right)$.

Lemma 3.1. Let $W_{k, 0}$ be the subspace of elements of $\mathfrak{p}_{-} \wedge \wedge^{k-1}(\mathfrak{g})$ invariant under $\mathfrak{u}$.
(i) The subspace $W_{k}$ of $\bigwedge^{k}(\mathfrak{g})$ is invariant under $\mathfrak{u}$.
(ii) The subspace $W_{k, 0}$ of $\bigwedge^{k}(\mathfrak{g})$ is contained in $W_{k}$ and generated by highest weight vectors.
(iii) The subspace $\mathrm{U}\left(\mathfrak{u}_{-}\right) . W_{k, 0}$ of $\bigwedge^{k}(\mathfrak{g})$ is the biggest $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$ contained in $\mathfrak{p}_{-} \wedge$ $\bigwedge^{k-1}(\mathfrak{g})$.

Proof. (i) Denote by $W_{k}^{\prime}$ the $L$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $W_{k}$. As $\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$ is invariant under $L, W_{k}^{\prime}$ is contained in $\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$. For $x$ in $\mathfrak{p}_{\mathrm{u}}$ and $g$ in $L$,

$$
x \cdot g \cdot W_{k}=g \cdot \operatorname{Ad} g^{-1}(x) \cdot W_{k} \subset W_{k}^{\prime},
$$

since $\mathfrak{p}_{\mathrm{u}}$ is invaraint under the adjoint action of $L$ in $\mathfrak{g}$. Then $W_{k}^{\prime}$ is invariant under $P_{\mathrm{u}}$, whence $W_{k}=W_{k}^{\prime}$. As a result, $W_{k}$ is a $\mathfrak{u}$-submodule of $\bigwedge^{k}(\mathfrak{g})$ since $\mathfrak{u}$ is contained in $\mathfrak{p}$.
(ii) For $\omega$ in $W_{k, 0}$, the subspace of $\bigwedge^{k}(\mathfrak{g})$ generated by $\omega$ is a $P_{\mathrm{u}}$-submodule contained in $\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$. Hence $W_{k, 0}$ is contained in $W_{k}$. Moreover, for $x$ in $\mathfrak{u}$ and $g$ in $H$,

$$
x \cdot g \cdot \omega=g \cdot \operatorname{Ad}^{-1}(x) \cdot \omega=0 .
$$

Hence $W_{k, 0}$ is invariant under $H$. As a result, $W_{k, 0}$ is generated by highest weight vectors.
(iii) By (ii), $\mathrm{U}\left(\mathfrak{u}_{-}\right) . W_{k, 0}$ is the $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $W_{k, 0}$. As $\mathfrak{u}_{-}$is contained in $\mathfrak{p}_{-}, \mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$ is a $U\left(\mathfrak{u}_{-}\right)$-submodule of $\bigwedge^{k}(\mathfrak{g})$ so that $U\left(\mathfrak{u}_{-}\right) . W_{k, 0}$ is contained in $\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$. Since a $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$ is generated by highest weight vectors, $\mathrm{U}\left(\mathfrak{u}_{-}\right) . W_{k, 0}$ is the biggest $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$ contained in $\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$.

Corollary 3.2. (i) The subspace $W_{k}$ of $\bigwedge^{k}(\mathfrak{g})$ is the biggest $G$-submodule contained in $\mathfrak{p}_{-} \wedge$ $\bigwedge^{k-1}(\mathrm{~g})$.
(ii) The subspace $V_{k, \mathrm{u}}$ of $\bigwedge^{k}(\mathfrak{g})$ is a $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$.

Proof. (i) Denote by $\widetilde{W}_{k}$ the biggest $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$ contained in $\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$. Then $\widetilde{W}_{k}$ is contained in $W_{k}$. Let $W_{k, 1}$ be a complement to $\widetilde{W}_{k}$ in $\wedge^{k}(\mathfrak{g})$, invariant under $G$. Then $W_{k}$ is the direct sum of $\widetilde{W}_{k}$ and $W_{k} \cap W_{k, 1}$. By Lemma 3.1(i), $W_{k} \cap W_{k, 1}$ is invariant under $\mathfrak{u}$. Then, by Lie's Theorem, $W_{k, 0} \cap W_{k, 1} \neq\{0\}$ if $W_{k} \cap W_{k, 1} \neq\{0\}$. Hence $W_{k}=\widetilde{W}_{k}$ since $W_{k, 0}$ is contained in $\widetilde{W}_{k}$ by Lemma 3.1(iii).
(ii) By Corollary 2.4(i) and Lemma 2.1, $W_{k}$ is the orthogonal complement to $V_{k, \mathrm{u}}$ in $\bigwedge^{k}(\mathrm{~g})$. Hence $V_{k, \mathrm{u}}$ is a $G$-module by (i).
3.2. A particular case. In this subsection, for some $\beta$ in $\Pi, X:=\Pi \backslash\{\beta\}$. Denote by $\mathfrak{b}_{\beta}$ the orthogonal complement to $H_{\beta}$ in $\mathfrak{h}$. Let $Z$ be the subset of elements $\alpha$ of $<X>$ such that $\beta+\alpha$ is a root. Set:

Y:=\mathcal{R}_{+} \backslash(<X>\cup\{\beta\}), \quad Z^{\prime}:=<X>\backslash Z, \quad E:=\bigoplus_{\alpha \in Y} \mathfrak{g}^{\alpha}, \quad E-:=\bigoplus_{\alpha \in Y} \mathfrak{g}^{-\alpha}, \\
\mathfrak{u}_{0}:=\bigoplus_{\alpha \in Z} \mathfrak{g}^{\alpha}, \quad \mathfrak{u}_{0,+}:=\bigoplus_{\alpha \in Z^{\prime}} \mathfrak{g}^{\alpha}, \quad \mathfrak{u}_{0,0}:=\bigoplus_{\alpha \in Z} \mathfrak{g}^{-\alpha}, \quad \mathfrak{u}_{0,-}:=\bigoplus_{\alpha \in Z^{\prime}} \mathfrak{g}^{-\alpha} .
\end{gathered}
$$

Then

\mathfrak{g}:=E_{-} \oplus \mathfrak{g}^{-\beta} \oplus \mathfrak{u}_{0,-} \oplus \mathfrak{u}_{0,0} \oplus \mathbb{k} H_{\beta} \oplus \mathfrak{h}_{\beta} \oplus \mathfrak{u}_{0} \oplus \mathfrak{u}_{0,+} \oplus \mathfrak{g}^{\beta} \oplus E .
$$

For $i=\left(i_{1}, \ldots, i_{10}\right)$, set:

\begin{aligned}
C_{i}:= & \bigwedge^{i_{1}}\left(E_{-}\right) \wedge \bigwedge^{i_{2}}\left(\mathfrak{g}^{-\beta}\right) \wedge \bigwedge^{i_{3}}\left(\mathfrak{u}_{0,-}\right) \wedge \bigwedge^{i_{4}}\left(\mathfrak{u}_{0,0}\right) \wedge \bigwedge^{i_{5}}\left(\mathbb{k} H_{\beta}\right) \wedge \\
& \bigwedge^{i_{6}}\left(\mathfrak{h}_{\beta}\right) \wedge \bigwedge^{i_{7}}\left(\mathfrak{u}_{0}\right) \wedge \bigwedge^{i_{8}}\left(\mathfrak{u}_{0,+}\right) \wedge \bigwedge^{i_{9}}\left(\mathrm{~g}^{\beta}\right) \wedge \bigwedge^{i_{10}}(E) .
\end{aligned}
$$

For $k$ positive integer, $\bigwedge^{k}(\mathrm{~g})$ is the direct sum of $C_{i}, i \in \mathbb{N}_{k}^{10}$.

For $\alpha$ in $Z$, denote by $\omega_{\alpha}^{\prime}$ and $\omega_{\alpha}$ the elements of $\bigwedge^{2}(\mathfrak{g})$,

$$
\begin{gathered}
\omega_{\alpha}^{\prime}:=H_{\beta} \wedge\left[x_{\beta}, x_{\alpha}\right]+2 x_{\beta} \wedge x_{\alpha}, \quad \omega_{\alpha}:=H_{\beta} \wedge\left[x_{-\beta}, x_{-\alpha}\right]+c_{\alpha} x_{-\beta} \wedge x_{-\alpha}, \quad \text { with } \\
c_{\alpha}:=-\frac{1}{2}\left\langle H_{\beta}, H_{\beta}\right\rangle\left\langle\left[x_{\beta}, x_{\alpha}\right],\left[x_{-\beta}, x_{-\alpha}\right]\right\rangle
\end{gathered}
$$

so that $\omega_{\alpha}$ is orthogonal to $\omega_{\alpha}^{\prime}$.
Lemma 3.3. Let $k=1, \ldots, d$. Denote by I the subset of elements $i$ of $\mathbb{N}_{k}^{10}$ such that $i_{1}+\cdots+i_{8} \geq$ 2, $M^{\prime}$ the subspace of elements $\mu_{\alpha}, \alpha \in Z$ of $\bigwedge^{k-1}(E)^{Z}$ such that

\sum_{\alpha \in Z}\left[x_{\beta}, x_{\alpha}\right] \wedge \mu_{\alpha}=0
$$

and $M$ the image of $M^{\prime}$ by the map

\bigwedge^{k-1}(E)^{Z} \longrightarrow \bigwedge^{k}(\mathfrak{g}), \quad\left(\mu_{\alpha}, \alpha \in Z\right) \longmapsto \sum_{\alpha \in Z} x_{\alpha} \wedge \mu_{\alpha} .

The space $W_{k}$ is contained in the subspace of $\bigwedge^{k}(\mathfrak{g})$ generated by $M, \omega_{\alpha}^{\prime} \wedge \bigwedge^{k-2}(E), \alpha \in Z$, $C_{i}, i \in I$.

Proof. By Corollary 2.4(i) and Corollary 3.2, $W_{k}$ is the biggest $G$-module contained in $\mathfrak{p}_{-} \wedge$ $\Lambda^{k-1}(\mathfrak{g})$. Denoting by $I^{\prime}$ the subset of elements $i$ of $\mathbb{N}_{k}^{10}$ such that

i_{1}+\cdots+i_{8}>0
$$

$\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$ is the sum of $C_{i}, i \in I^{\prime}$. Then for $i$ in $I$ and $x$ in $\mathfrak{g}, x . C_{i}$ is contained in $\mathfrak{p}_{-} \wedge \bigwedge^{k-1}(\mathfrak{g})$. The complement to $I$ in $I^{\prime}$ is equal to the subset of elements $i$ of $I^{\prime}$ such that $i_{9}+i_{10}=k-1$. For $i$ in $I^{\prime} \backslash I$ such that $i_{5}=i_{7}=0, x_{\beta} . C_{i}$ is contained in $\mathfrak{p}_{-} \wedge \wedge^{k-1}(\mathfrak{g})$ since

\left[x_{\beta}, E_{-}\right] \subset \mathfrak{p}_{-}, \quad\left[x_{\beta}, \mathfrak{g}^{-\beta}\right] \subset \mathfrak{p}_{-}, \quad\left[x_{\beta}, \mathfrak{u}_{0,-}+\mathfrak{u}_{0,0}+\mathfrak{h}_{\beta}+\mathfrak{u}_{0,+}\right]=\{0\} .

For $i$ in $I^{\prime} \backslash I$,

i_{7}=1 \quad \text { and } \quad i_{9}=0 \Longrightarrow x_{\beta} \cdot C_{i} \subset C_{i} \oplus \bigwedge^{k}(E), \\
i_{7}=1 \quad \text { and } \quad i_{9}=1 \Longrightarrow x_{\beta} \cdot C_{i} \subset C_{i} \oplus \mathrm{~g}^{\beta} \wedge \bigwedge^{k-1}(E), \\
i_{5}=1 \quad \text { and } \quad i_{9}=0 \Longrightarrow x_{\beta} \cdot C_{i} \subset C_{i} \oplus \mathrm{~g}^{\beta} \wedge \bigwedge^{k-1}(E), \\
i_{5}=1 \quad \text { and } i_{9}=1 \Longrightarrow x_{\beta} \cdot C_{i} \subset C_{i} .
\end{gathered}
$$

As a result, for $\omega$ and $\mu_{\alpha}, \alpha \in Z$ in $\bigwedge^{k-1}(E)$ and $\mu_{\alpha}^{\prime}, \alpha \in Z$ in $\bigwedge^{k-2}(E)$ such that

for some $\omega^{\prime}$ in the sum of $C_{i}, i \in I$,

-2 \omega+\sum_{\alpha \in Z}\left[x_{\beta}, x_{\alpha}\right] \wedge \mu_{\alpha}^{\prime}=0 \quad \text { and } \quad \sum_{\alpha \in Z}\left[x_{\beta}, x_{\alpha}\right] \wedge \mu_{\alpha}=0

since $x_{\beta} . W_{k}$ is contained in $\mathfrak{p}_{-} \wedge \wedge^{k-1}(\mathfrak{g})$, whence the lemma.

For $i=\left(i_{1}, \ldots, i_{10}\right)$ in $\mathbb{N}^{10}$, denote by $i^{*}$ the element of $\mathbb{N}^{10}$,

i^{*}:=\left(i_{10}, i_{9}, i_{8}, i_{7}, i_{5}, i_{6}, i_{4}, i_{3}, i_{2}, i_{1}\right)
$$

By Lemma 2.2(ii), for $k$ positive integer and $i, i^{\prime}$ in $\mathbb{N}_{k}^{10}, C_{i}$ is orthogonal to $C_{i^{\prime}}$ if and only if $i^{\prime} \neq i^{*}$.

Corollary 3.4. Let $k=1, \ldots, d$ and $\alpha$ in $Z$.
(i) The space $\omega_{\alpha} \wedge \bigwedge^{k-2}\left(E_{-}\right)$is contained in $V_{k, \mathrm{u}}$.
(ii) The space $\mathrm{g}^{\alpha} \wedge \wedge^{k-1}\left(E_{-}\right)$is contained in $V_{k, \mathrm{u}}$.
(iii) The spaces $H_{\alpha} \wedge \wedge^{k-2}\left(E_{-}\right)$and $\mathfrak{g}^{-\alpha} \wedge \bigwedge^{k-1}\left(E_{-}\right)$are contained in $V_{k, \mathrm{u}}$.
(iv) The space $\mathfrak{h}_{\beta} \wedge \wedge^{k-1}\left(E_{-}\right)$is contained in $V_{k, \mathrm{u}}$.

Proof. (i) Let $I_{1}$ be the subset of elements $i$ of $\mathbb{N}_{k}^{10}$ such that

\left(i_{1}=k-1 \quad \text { and } \quad i_{5}=1\right) \quad \text { or } \quad\left(i_{1}=k-2, i_{2}=1, i_{4}=1\right) .
$$

Then $\omega_{\alpha} \wedge \bigwedge^{k-2}\left(E_{-}\right)$is contained in the sum of $C_{i}, i \in I_{1}$. Hence $\omega_{\alpha} \wedge \bigwedge^{k-2}\left(E_{-}\right)$is orthogonal to $C_{i}$ for all $i$ in $I$ and for $i$ such that $i_{7}=1$ and $i_{10}=k-1$. By Corollary 2.3(i), for all $\gamma$ in $Z, \omega_{\alpha} \wedge \bigwedge^{k-2}\left(E_{-}\right)$is orthogonal to $\omega_{\gamma}^{\prime} \wedge \bigwedge^{k-2}(E)$ since $\omega_{\alpha}$ and $\omega_{\gamma}^{\prime}$ are orthogonal, whence the assertion by Lemma 3.3 since $V_{k, \mathrm{u}}$ is the orthogonal complement to $W_{k}$ in $\Lambda^{k}(\mathfrak{g})$ by Lemma 2.1.
(ii) The space $\mathfrak{g}^{\alpha} \wedge \bigwedge^{k-1}\left(E_{-}\right)$is contained in $C_{i}$ with $i$ in $\mathbb{N}_{k}^{10}$ such that $i_{7}=1$ and $i_{1}=k-1$. Hence $\mathfrak{g}^{\alpha} \wedge \bigwedge^{k-1}\left(E_{-}\right)$is orthogonal to $C_{j}$ for all $j$ in $I$. Moreover, it is orthogonal to $C_{j}$ for $j$ in $\mathbb{N}_{k}^{10}$ such that $j_{7}=1$ and $j_{10}=k-1$ and $C_{j^{\prime}}$ for $j^{\prime}$ in $I_{1}$. As a result, $\mathfrak{g}^{\alpha} \wedge \bigwedge^{k-1}\left(E_{-}\right)$is orthogonal to $W_{k}$ by Lemma 3.3, whence the assertion since $V_{k, \mathrm{u}}$ is the orthogonal complement to $W_{k}$ in $\bigwedge^{k}(\mathrm{~g})$ by Lemma 2.1.
(iii) By (ii) and Corollary 3.2(ii), for $\omega$ in $\bigwedge^{k-1}\left(E_{-}\right)$,

V_{k, \mathrm{u}} \ni x_{-\alpha} \cdot\left(x_{\alpha} \wedge \omega\right) & =-H_{\alpha} \wedge \omega+x_{\alpha} \wedge x_{-\alpha} \cdot \omega \quad \text { and } \\
x_{-\alpha} \cdot\left(H_{\alpha} \wedge \omega\right) & =2 x_{-\alpha} \wedge \omega+H_{\alpha} \wedge x_{-\alpha} \cdot \omega
\end{aligned}
$$

As $E_{-}$is invariant under the adjoint action of $x_{-\alpha}, x_{\alpha} \wedge x_{-\alpha} \cdot \omega$ is in $V_{k, \mathrm{u}}$ by (ii), whence the assertion.
(iv) The space $\mathfrak{b}_{\beta} \wedge \bigwedge^{k-1}\left(E_{-}\right)$is equal to $C_{i}$ for $i$ such that $i_{1}=k-1$ and $i_{6}=1$. Then $C_{i}$ is orthogonal to $C_{j}$ for $j$ in $I$. Moreover, it is orthogonal to $\mathrm{g}^{\alpha} \wedge \wedge^{k-1}(E)$ for all $\alpha$ in $Z$ and $H_{\beta} \wedge \bigwedge^{k-1}\left(\mathfrak{p}_{\mathfrak{u}}\right)$ since $\mathfrak{h}_{\beta}$ is orthogonal to $H_{\beta}$ and $\mathfrak{u}$. As a result, $\mathfrak{h}_{\beta} \wedge \bigwedge^{k-1}\left(E_{-}\right)$is orthogonal to $W_{k}$ by Lemma 3.3, whence the assertion since $V_{k, \mathrm{u}}$ is the orthogonal complement to $W_{k}$ in $\wedge^{k}(\mathfrak{g})$ by Lemma 2.1.

Denote by $D$ the derived algebra of $I$.
Proposition 3.5. Let $k=1, \ldots, d, i=0, \ldots, k-1$.
(i) Let $M$ be a $P_{\mathrm{u}}$-submodule of $\bigwedge^{i}(\mathfrak{g})$. Then the $P_{\mathrm{u}}$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $\bigwedge^{k-i}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge$ $M$ contains $\wedge^{k-i-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{D} \wedge M$.
(ii) Let $N$ be a $P_{-, \mathrm{u}}^{- \text {-submodule of } \bigwedge^{i}(\mathrm{~g}) \text {. Then the } P_{-, \mathrm{u}} \text {-submodule of } \bigwedge^{k}(\mathrm{~g}) \text { generated by }}$ $\bigwedge^{k-i}\left(\mathfrak{p}_{\mathrm{u}}\right) \wedge N$ contains $\bigwedge^{k-i-1}\left(\mathfrak{p}_{\mathrm{u}}\right) \wedge \mathfrak{D} \wedge N$.

Proof. (i) By Lemma 1.2, it is sufficient to prove that $V_{k-i, \mathrm{u}}$ contains $\bigwedge^{k-i-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{D}$ since $M$ is a $P_{\mathrm{u}}$-module. For $\alpha$ in $Z$,

$$
H_{\alpha} \in \frac{\beta\left(H_{\alpha}\right)}{2} H_{\beta}+\mathfrak{h}_{\beta} .
$$

So, by Corollary 3.4,(iii) and (iv), $H_{\beta} \wedge \bigwedge^{k-i-1}\left(E_{-}\right)$is contained in $V_{k-i, u}$. Then, by Corollary 3.4(i),

$$
V_{k-i, u} \supset \mathfrak{g}^{-\beta} \wedge \mathfrak{g}^{-\alpha} \wedge \wedge^{k-i-2}\left(E_{-}\right)
$$

As a result, by Corollary 3.4(iii), for all $\alpha$ in $Z, \mathfrak{g}^{-\alpha} \wedge \bigwedge^{k-i-1}\left(\mathfrak{p}_{-, u}\right)$ is contained in $V_{k-i, \mathrm{u}}$. As $\mathfrak{g}$ is simple, the $\mathfrak{l}$-submodule of $\mathfrak{g}$, generated by $\mathfrak{g}^{\alpha}, \alpha \in Z$ is equal to $\mathfrak{D}$. By Corollary 3.2(ii), $V_{k-i, \mathrm{u}}$ is a I-module. Then, by Lemma $1.2, V_{k-i, u}$ contains $\bigwedge^{k-i-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{D}$ since $\bigwedge^{k-i-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right)$ is a I-module, whence the assertion.
(ii) For some automorphism $g$ of $\mathfrak{g}, g\left(\mathfrak{p}_{\mathbf{u}}\right)=\mathfrak{p}_{-, u}, g\left(\mathfrak{p}_{-, \mathrm{u}}\right)=\mathfrak{p}_{\mathrm{u}}, g(\mathfrak{h})=\mathfrak{h}$. Then $\mathbb{I}$ and $\mathfrak{D}$ are invariant under $g$. A a result, by (i), the $P_{-, \mathrm{u}}$-submodule of $\wedge^{k}(\mathfrak{g})$ generated by $\wedge^{k-i}\left(\mathfrak{p}_{\mathrm{u}}\right) \wedge N$ contains $\bigwedge^{k-i-1}\left(\mathfrak{p}_{\mathrm{u}}\right) \wedge \mathfrak{D} \wedge N$ since $g(N)$ is a $P_{\mathrm{u}}$-submodule of $\bigwedge^{i}(\mathfrak{g})$.

## 4. Proof of Theorem 1.1

Let $\ell \geq 2$ and $X$ a nonempty subset of $\Pi$, different from $\Pi$. Set:

$$
\begin{gathered}
\mathfrak{p}:=\mathfrak{p}_{X}, \quad \mathfrak{p}_{\mathrm{u}}:=\mathfrak{p}_{X, \mathrm{u}}, \quad \mathrm{l}:=\mathfrak{l}_{X}, \quad \mathfrak{j}:=\mathfrak{j} X, \quad \mathfrak{d}:=\mathfrak{b}_{X}, \quad \mathrm{n}:=\mathrm{n}_{X}, \\
\mathfrak{p}_{-, \mathrm{u}}:=\mathfrak{p}_{X,-, \mathrm{u}}, \quad \mathfrak{p}_{ \pm, \mathrm{u}}:=\mathfrak{p}_{\mathrm{u}} \oplus \mathfrak{p}_{-, \mathrm{u}}, \quad E:=E_{X}, \quad \mathfrak{p}_{-}:=\mathfrak{l} \oplus \mathfrak{p}_{-, \mathrm{u}}, \quad d:=\operatorname{dim} \mathfrak{p}_{\mathrm{u}} .
\end{gathered}
$$

Recall that $\mathfrak{D}_{1}, \ldots, \mathfrak{D}_{\mathrm{n}}$ are the simple factors of $\mathfrak{D}$ and for $i=1, \ldots, \mathrm{n}, n_{i}$ is the number of positive roots $\alpha$ such that $\mathfrak{g}^{\alpha}$ is contained in $\mathfrak{D}_{i}$. Let $P_{\mathrm{u}}$ and $P_{-, \mathrm{u}}$ be as in Section 3. For $k=1, \ldots, n$, set $V_{k, \mathfrak{p}}:=V_{k, p_{X}}$ and $V_{k, X}:=V_{k}$.
4.1. A partial result. Let $n^{\prime}$ be the sum $n_{1}+\cdots+n_{\mathrm{n}}$. For $k=1, \ldots, n$, denote by $V_{k}^{\prime}$ the subspace of $\bigwedge^{k}(\mathfrak{g})$,

$$
V_{k}^{\prime}:=\bigoplus_{j=0}^{n^{\prime}} \bigwedge^{j}(\mathfrak{D}) \wedge \bigwedge^{k-j}(E)
$$

Proposition 4.1. Suppose $|X|=\ell-1$. Let $k=1, \ldots, n$. Then $\bigwedge^{k}(\mathfrak{g})$ is the $G$-submodule of $\bigwedge^{k}(\mathrm{~g})$ generated by $V_{k}^{\prime}$.

Proof. For $k=1, \ldots, d$, denote by $E_{k}$ the $G$-submodule of $\bigwedge^{k}(\mathfrak{g})$ generated by $\bigwedge^{k}(E)$. For $k=1, \ldots, n^{\prime}, V_{k}^{\prime}=\Lambda^{k}(\mathrm{~g})$ and for $k>n^{\prime}$,

$$
V_{k}^{\prime}=\bigwedge^{n^{\prime}}(\mathfrak{g}) \wedge \bigwedge^{k-n^{\prime}}(E)
$$

So, by Lemma 1.2, it is sufficient to prove that $E_{k}=\bigwedge^{k}(\mathfrak{g})$ for $k=1, \ldots, d$ since $n=n^{\prime}+d$.
Prove the assertion by induction on $k$. For $k=1$ the assertion is true since $\mathfrak{g}$ is simple. Suppose $k>1$ and the assertion true for $k-1$. As $|X|=\ell-1, \jmath$ has dimension 1 and

\bigwedge^{k}(E)=\bigwedge^{k}\left(\mathfrak{p}_{ \pm, \mathrm{u}}\right) \oplus \mathfrak{\jmath} \wedge \bigwedge^{k-1}\left(\mathfrak{p}_{ \pm, \mathrm{u}}\right)=
$$

$$
\bigoplus_{j=0}^{k} \bigwedge^{k-j}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \bigwedge^{j}\left(\mathfrak{p}_{\mathrm{u}}\right) \oplus \bigoplus_{j=0}^{k-1} \bigwedge^{k-1-j}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{z} \wedge \bigwedge^{j}\left(\mathfrak{p}_{\mathrm{u}}\right)
$$

For $j=0, \ldots, d, \bigwedge^{j}\left(\mathfrak{p}_{\mathrm{u}}\right)$ and $\bigwedge^{j+1}\left(\mathfrak{p}_{\mathrm{u}}\right)+\mathfrak{z} \wedge \bigwedge^{j}\left(\mathfrak{p}_{\mathrm{u}}\right)$ are $P_{\mathrm{u}}$-submodules of $\bigwedge^{j}(\mathfrak{g})$ and $\bigwedge^{j+1}(\mathfrak{g})$ respectively. Then, by Proposition $3.5(\mathrm{i}), E_{k}$ contains

$$
\wedge^{k-j-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{D} \wedge \bigwedge^{j}\left(\mathfrak{p}_{\mathbf{u}}\right) \quad \text { and } \quad \bigwedge^{k-j^{\prime}-2}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{z} \wedge \mathfrak{D} \wedge \bigwedge^{j^{\prime}}\left(\mathfrak{p}_{\mathrm{u}}\right)
$$

for $j=0, \ldots, k-1$ and $j^{\prime}=0, \ldots, k-2$. Hence $E_{k}$ contains

$$
\bigwedge^{k-j-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{g} \wedge \bigwedge^{j}\left(\mathfrak{p}_{\mathrm{u}}\right) \quad \text { and } \quad \bigwedge^{k-j^{\prime}-2}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{z} \wedge \mathfrak{g} \wedge \bigwedge^{j^{\prime}}\left(\mathfrak{p}_{\mathrm{u}}\right)
$$

for $j=0, \ldots, k-1$ and $j^{\prime}=0, \ldots, k-2$ since $\wedge^{k}(E)$ contains

$$
\begin{gathered}
\bigwedge^{k-j}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \bigwedge^{j}\left(\mathfrak{p}_{\mathbf{u}}\right),
\end{gathered} \quad \bigwedge^{k-j-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \bigwedge^{j+1}\left(\mathfrak{p}_{\mathrm{u}}\right), ~\left(\bigwedge_{-, \mathrm{u}}\right) \wedge \mathfrak{z} \wedge \bigwedge^{j}\left(\mathfrak{p}_{\mathrm{u}}\right), \quad \bigwedge^{k-j^{\prime}-2}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{j} \wedge \bigwedge_{j^{\prime}+1}\left(\mathfrak{p}_{\mathrm{u}}\right) .
$$

for $j=0, \ldots, k-1$ and $j^{\prime}=0, \ldots, k-2$. As a result, $E_{k}$ contains $\mathfrak{g} \wedge \wedge^{k-1}(E)$. Then, by Lemma 1.2 and the induction hypothesis, $E_{k}=\Lambda^{k}(\mathfrak{g})$, whence the proposition.

Remark 4.2. When $X$ is connected, $V_{k, \mathfrak{p}}=V_{k, \mathfrak{p}}^{\prime}$. Then, in this case under the assumption $|X|=$ $\ell-1, V_{k}=\Lambda^{k}(\mathrm{~g})$ by Proposition 4.1.
4.2. A first particular case. In this subsection, $|X|=\ell-1$ so that $\mathrm{n} \in\{1,2,3\}$. As a matter of fact, $\mathrm{n}=3$ only for type D and E. As in Subsection 4.1, $n^{\prime}=n_{1}+\cdots+n_{\mathrm{n}}$. For $i=\left(i_{1}, \ldots, i_{\mathrm{n}}\right)$ and $k=0, \ldots, n$, set:

$$
\mathfrak{D}_{i}:=\bigwedge_{1}^{i_{1}}\left(\mathfrak{D}_{1}\right) \wedge \cdots \wedge \bigwedge^{i_{\mathrm{n}}}\left(\mathrm{D}_{\mathrm{n}}\right) \quad \text { and } \quad \mathbb{I}_{k}:=\left\{\left(i_{1}, \ldots, i_{\mathrm{n}}\right) \in \mathbb{N}_{k}^{\mathrm{n}} \mid 0 \leq i_{1} \leq n_{1}, \ldots, 0 \leq i_{\mathrm{n}} \leq n_{\mathrm{n}}\right\} .
$$

For $l, l^{\prime}$ nonnegative integers and $i$ in $\mathbb{N}^{n}$, set:

$$
\begin{aligned}
V_{l, l^{\prime}, i} & :=\bigwedge^{l}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{D}_{i} \wedge \bigwedge^{l^{\prime}}\left(\mathfrak{p}_{\mathrm{u}}\right) \quad \text { and } \\
V_{l, l^{\prime}, i}^{\prime} & :=\bigwedge^{l}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{z} \wedge \mathfrak{D}_{i} \wedge \bigwedge^{l^{\prime}}\left(\mathfrak{p}_{\mathrm{u}}\right)
\end{aligned}
$$

For $j$ in $\mathbb{N}^{\mathrm{n}}$ and $t=0, \ldots,|j|$, denote by $\Delta_{j}$ and $\Delta_{j, t}$ the subsets of $\mathbb{N}^{\mathrm{n}}$,

$$
\Delta_{j}:=\left\{j^{\prime} \in \mathbb{N}^{\mathrm{n}} \mid j_{1}^{\prime} \leq j_{1}, \ldots, j_{\mathrm{n}}^{\prime} \leq j_{\mathrm{n}}\right\} \quad \text { and } \quad \Delta_{j, t}:=\Delta_{j} \cap \mathbb{N}_{t}^{\mathrm{n}}
$$

Lemma 4.3. Let $k=1, \ldots, n$, $\left(l, l^{\prime}\right)$ in $\mathbb{N}^{2}$ such that $l+l^{\prime} \leq 2 d$, in $\mathbb{I}_{k-l-l^{\prime}}$ and $i^{\prime}$ in $\mathbb{I}_{k-l-l^{\prime}-1}$.
(i) Suppose that $V_{l, l^{\prime}+s, j}$ is contained in $V_{k}$ for all nonnegative integer $s$ such that $l+l^{\prime}+s \leq 2 d$ and all $j$ in $\Delta_{i, i|l|-s}$. Then $\mathfrak{D} \wedge V_{l-1, l^{\prime}, i}$ is contained in $V_{k}$.
(ii) Suppose that $V_{l+s, l^{\prime}, j}$ is contained in $V_{k}$ for all nonnegative integer s such that $l+l^{\prime}+s \leq 2 d$ and all $j$ in $\Delta_{i, l|l|-s}$. Then $\mathfrak{D} \wedge V_{l, l^{-1, i}}$ is contained in $V_{k}$.
(iii) Suppose that $V_{l, l^{\prime}+s, j}^{\prime}$ is contained in $V_{k}$ for all nonnegative integer s such that $l+l^{\prime}+s \leq 2 d$ and all $j$ in $\Delta_{i^{\prime}, i^{\prime} \mid-s}$. Then $\mathfrak{D} \wedge V_{l-1, l^{\prime}, i^{\prime}}^{\prime}$ is contained in $V_{k}$.
(iv) Suppose that $V_{l+s, l^{\prime}, j}^{\prime}$ is contained in $V_{k}$ for all nonnegative integer s such that $l+l^{\prime}+s \leq 2 d$ and all $j$ in $\Delta_{i^{\prime}, i^{\prime} \mid-s}$. Then $\mathrm{D} \wedge V_{l, l^{\prime}-1, i^{\prime}}^{\prime}$ is contained in $V_{k}$.

Proof. For $m$ in $\mathbb{N}$ and $j$ in $\mathbb{N}^{n}$, set:

$$
\begin{gathered}
M_{m, j}:=\bigoplus_{t=0}^{|j|} \bigoplus_{l \in \Delta_{j, t}} \mathfrak{D}_{\imath} \wedge \bigwedge^{m+|j|-t}\left(\mathfrak{p}_{\mathrm{u}}\right), \quad M_{m, j,-}:=\bigoplus_{t=0}^{|j|} \bigoplus_{\iota \in \Delta_{j, t}} \mathfrak{D}_{\iota} \wedge \bigwedge^{m+|j|-t}\left(\mathfrak{p}_{-, \mathrm{u}}\right), \\
M_{m, j}^{\prime}:=\bigoplus_{t=0}^{|j|} \bigoplus_{l \in \Delta_{j, t}} \mathfrak{j} \wedge \mathfrak{D}_{\iota} \wedge \bigwedge^{m+|j|-t}\left(\mathfrak{p}_{\mathrm{u}}\right), \quad M_{m, j,-}^{\prime}:=\bigoplus_{t=0}^{|j|} \bigoplus_{l \in \Delta_{j, t}} \mathfrak{j} \wedge \mathfrak{D}_{\iota} \wedge \bigwedge^{m+|j|-t}\left(\mathfrak{p}_{-, \mathrm{u}}\right) .
\end{gathered}
$$

Then $M_{m, j}$ is a $P_{\mathrm{u}}$-submodule of $\bigwedge^{m+|j|}(\mathfrak{g}), M_{m, j,-}$ is a $P_{-, \mathrm{u}}$-submodule of $\bigwedge^{m+|j|}(\mathfrak{g}), M_{m, j}^{\prime}$ is a $P_{\mathrm{u}}$-submodule of $\bigwedge^{m+|\mathrm{j}|+1}(\mathfrak{g}), M_{m, j,-}^{\prime}$ is a $P_{-, \mathrm{u}}$-submodule of $\bigwedge^{m+|j|+1}(\mathfrak{g})$.
(i) By hypothesis,

$$
V_{k} \supset \bigwedge^{l}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge M_{l^{\prime}, i} \supset V_{l, l^{\prime}, i} .
$$

Then by Proposition 3.5(i), © $\wedge V_{l-1, l^{\prime}, i}$ is contained in $V_{k}$.
(ii) By hypothesis,

$$
V_{k} \supset \bigwedge^{\prime \prime}\left(p_{\mathrm{u}}\right) \wedge M_{l, i,-} \supset V_{l, l^{\prime}, i} .
$$

Then by Proposition 3.5(ii), $\mathrm{D} \wedge V_{l, l^{\prime}-1, i}$ is contained in $V_{k}$.
(iii) By hypothesis,

$$
V_{k} \supset \bigwedge^{l}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge M_{l^{\prime}, i^{\prime}}^{\prime} \supset V_{l, l^{\prime}, i^{\prime}}^{\prime} .
$$

Then by Proposition 3.5(i), $\mathrm{D} \wedge V_{l-1, l^{\prime}, i^{\prime}}^{\prime}$ is contained in $V_{k}$.
(iv) By hypothesis,

$$
V_{k} \supset \bigwedge^{l^{\prime}}\left(\mathfrak{p}_{\mathrm{u}}\right) \wedge M_{l^{\prime}, i^{\prime},-}^{\prime} \supset V_{l, l^{\prime}, i^{\prime}}^{\prime} .
$$

Then by Proposition 3.5(ii), $\mathrm{D} \wedge V_{l, l^{\prime}-1, i^{\prime}}^{\prime}$ is contained in $V_{k}$.
Corollary 4.4. Let $k=1, \ldots, n$, $\left(l, l^{\prime}\right)$ in $\mathbb{N}^{2}$ such that $l+l^{\prime}<2 d$, in $\mathbb{I}_{k-l-l^{\prime}-1}$ and $i^{\prime}$ in $\mathbb{I}_{k-l-l^{\prime}-2}$. Then $\mathfrak{g} \wedge V_{l, l^{\prime}, i}$ and $\mathfrak{g} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ are contained in $V_{k}$.

Proof. Since $V_{l, l^{\prime}, i}$ is contained in $V_{k-1, \mathfrak{p}}, \mathfrak{p}_{\mathrm{u}} \wedge V_{l, l^{\prime}, i}$ and $\mathfrak{p}_{-, \mathrm{u}} \wedge V_{l, l^{\prime}, i}$ are contained in $V_{k, \mathfrak{p}}$. Moreover, for all nonnegative integer $s$ such that $l+l^{\prime}+s+1 \leq 2 d$ and all $j$ in $\Delta_{i, i \mid-s}, \mathfrak{p}_{\mathrm{u}} \wedge V_{l, l^{\prime}+s, j}, \mathfrak{p}_{-, \mathrm{u}} \wedge V_{l, l^{\prime}+s, j}$, $\mathfrak{p}_{\mathrm{u}} \wedge V_{l+s, l^{\prime}, j}, \mathfrak{p}_{-, \mathrm{u}} \wedge V_{l+s, l^{\prime}, j}$ are contained in $V_{k, \mathfrak{p}}$. Then, by Lemma 4.3,(i) and (ii), $\mathfrak{D} \wedge V_{l, l^{\prime}, i}$ is contained in $V_{k}$.

Since $V_{l, l^{\prime}, i^{\prime}}^{\prime}$ is contained in $V_{k-1, \mathfrak{p}}, \mathfrak{p}_{\mathrm{u}} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ and $\mathfrak{p}_{-, \mathrm{u}} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ are contained in $V_{k, \mathfrak{p}}$. Moreover, for all nonnegative integer $s$ such that $l+l^{\prime}+s+1 \leq 2 d$ and all $j$ in $\Delta_{i^{\prime}, l^{\prime} \mid-s}, \mathfrak{p}_{\mathrm{u}} \wedge V_{l, l^{\prime}+s, j}^{\prime}, \mathfrak{p}_{-, \mathrm{u}} \wedge V_{l, l^{\prime}+s, j}^{\prime}$, $\mathfrak{p}_{\mathrm{u}} \wedge V_{l+s, l^{\prime}, j}^{\prime}, \mathfrak{p}_{-, \mathrm{u}} \wedge V_{l+s, l^{\prime}, j}^{\prime}$ are contained in $V_{k, \mathfrak{p}}$. Then, by Lemma 4.3,(iii) and (iv), $\mathfrak{D} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ is contained in $V_{k}$. By definition,

V_{k, p} \supset \mathfrak{p}_{-, \mathrm{u}} \wedge V_{k-1, \mathfrak{p}}+\mathfrak{\jmath} \wedge V_{k-1, \mathfrak{p}}+\mathfrak{p}_{\mathrm{u}} \wedge V_{k-1, \mathfrak{p}} .
$$

Hence $\mathfrak{g} \wedge V_{l, l^{\prime}, i}$ and $\mathfrak{g} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$, are containe in $V_{k}$.
Proposition 4.5. Let $k=1, \ldots, n$. Suppose that one of the following condition is satisfied:
(1) $\Pi$ is exceptional,
(2) $\Pi$ has type $\mathrm{D}_{\ell}$ and $\mathrm{n}=3$,
(3) $\Pi$ has classical type, $\mathrm{n}=2,2 d+n_{1}$ and $2 d+n_{2}$ are bigger than $n$.

Then $V_{k}=\bigwedge^{k}(\mathfrak{g})$.
Proof. Prove the proposition by induction on $k$. For $k=1$, it is true since $\mathfrak{g}$ is simple. Suppose $k>1$ and the proposition true for $k-1$. By Lemma 1.2 and the induction hypothesis, it is sufficient to prove that $\mathfrak{g} \wedge V_{k-1, \mathfrak{p}}$ is contained in $V_{k}$. As a matter of fact, we have to prove that $\mathfrak{g} \wedge V_{l, l^{\prime}, i}$ and $\mathfrak{g} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ are contained in $V_{k}$ for $\left(l, l^{\prime}\right)$ in $\mathbb{N}^{2}$ such that $l+l^{\prime} \leq 2 d, i$ in $\mathbb{I}_{k-l-l^{\prime}-1}$ and $i^{\prime}$ in $\mathbb{I}_{k-l-l^{\prime}-2}$ since

V_{k-1, \mathfrak{p}}=\bigoplus_{t=0}^{2 d} \bigoplus_{\left(l, l^{\prime}\right) \in \mathbb{N}_{t}^{2}} \bigoplus_{i \in \mathbb{I}_{k-t-1}} V_{l, l^{\prime}, i} \oplus \bigoplus_{t=0}^{2 d} \bigoplus_{\left(l, l^{\prime}\right) \in \mathbb{N}_{t}^{2}} \bigoplus_{i^{\prime} \in \mathbb{I}_{k-t-2}} V_{l, l^{\prime}, i^{\prime}}^{\prime}
$$

Let $\left(l, l^{\prime}\right)$ be in $\mathbb{N}^{2}$ such that $l+l^{\prime} \leq 2 d, i$ in $\mathbb{I}_{k-l-l^{\prime}-1}$ and $i^{\prime}$ in $\mathbb{I}_{k-l-l^{\prime}-2}$. If Condition (1) or Condition (2) is satisfied, then $l+l^{\prime}<2 d$ by Proposition A.1. As a result, by Corollary 4.4, $\mathfrak{g} \wedge V_{l, l^{\prime}, i}$ and $\mathfrak{g} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ are contained in $V_{k}$. If Condition (3) is satisfied, $l+l^{\prime}<2 d$ or $l+l^{\prime}=2 d$, $i_{1}<n_{1}, i_{2}<n_{2}$. In the first case, by Corollary 4.4, $\mathfrak{g} \wedge V_{l, l^{\prime}, i}$ and $\mathfrak{g} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ are contained in $V_{k}$. In the second case, $\mathfrak{g} \wedge V_{l, l^{\prime}, i}$ and $\mathfrak{g} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ are contained in $V_{k, \mathfrak{p}}$, whence the proposition.
Remark 4.6. By the proof of Proposition 4.5, when $\mathrm{n}=2$, for $k=1, \ldots, \inf \left\{2 d+n_{1}-1,2 d+n_{2}-1\right\}$, $V_{k}=\Lambda^{k}(\mathfrak{g})$.
4.3. A second particular case. In this subsection, $|X|=\ell-1$, $\Pi$ has classical type, $\mathrm{n}=2$ and $2 d+n_{1} \leq n$. By Proposition A.1, $2 d+n_{2}>n, \ell \geq 6$ for $\Pi$ of type $\mathrm{A}_{\ell}, \ell \geq 7$ for $\Pi$ of type $\mathrm{B}_{\ell}$ or $\mathrm{C}_{\ell}, \ell \geq 8$ for $\Pi$ of type $\mathrm{D}_{\ell}$.

For $i=\left(i_{0}, i_{1}, i_{2}, i_{3}, i_{4}\right)$ in $\mathbb{N}^{5}$, set:

C_{i}:=\bigwedge^{i_{0}}(\mathfrak{z}) \wedge \bigwedge^{i_{1}}\left(\mathrm{D}_{1}\right) \wedge \bigwedge^{i_{2}}\left(\mathrm{D}_{2}\right) \wedge \bigwedge^{i_{3}}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \bigwedge^{i_{4}}\left(\mathfrak{p}_{\mathrm{u}}\right)
$$

Let $k=2 d+n_{1}, \ldots, n$ and $j=k-2 d-n_{1}$. Set:

\begin{gathered}
\iota:=\left(0, n_{1}, j, d, d\right), \quad \iota^{\prime}:=\left(1, n_{1}, j-1, d, d\right), \\
\iota_{+}:=\left(0, n_{1}+1, j-1, d, d\right), \quad \iota_{+}^{\prime}:=\left(1, n_{1}+1, j-2, d, d\right), \quad \kappa:=\left(0, n_{1}+1, j, d-1, d\right), \\
\kappa^{\prime}:=\left(1, n_{1}+1, j-1, d-1, d\right), \quad \kappa_{-}:=\left(0, n_{1}+1, j, d, d-1\right), \quad \kappa_{-}^{\prime}:=\left(1, n_{1}+1, j-1, d, d-1\right) .
\end{gathered}
$$

Lemma 4.7. Denote by $M_{\iota}$ and $M_{\iota^{\prime}}$ the $G$-submodules of $\bigwedge^{k}(\mathfrak{g})$ generated by $C_{\iota}$ and $C_{\iota^{\prime}}$ respectively.
(i) The subspace $M_{\iota}$ of $\bigwedge^{k}(\mathfrak{g})$ contains $C_{\kappa}$ and $C_{\kappa_{-}}$, and $M_{\iota^{\prime}}$ contains $C_{\kappa^{\prime}}$ and $C_{\kappa_{-}^{\prime}}^{\prime}$.
(ii) The spaces $C_{\iota_{+}}$and $C_{\iota_{+}^{\prime}}$ are contained in $M_{\iota}$ and $M_{\iota^{\prime}}$ respectively.

Proof. (i) The subspaces of $\bigwedge^{k-d}(\mathrm{~g})$,

$$

are invariant under $P_{\mathrm{u}}$. So, by Proposition 3.5(i), $M_{\iota}$ and $M_{\iota^{\prime}}$ contain $C_{\kappa}$ and $C_{\kappa^{\prime}}$ respectively. The subspaces of $\bigwedge^{k-d}(\mathfrak{g})$,

\bigwedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \bigwedge^{n_{1}}\left(\mathrm{D}_{1}\right) \wedge \bigwedge^{j}\left(\mathrm{D}_{2}\right) \quad \text { and } \quad \bigwedge^{d}\left(\mathfrak{p}_{-\mathrm{u}}\right) \wedge \bigwedge^{n_{1}}\left(\mathrm{D}_{1}\right) \wedge \bigwedge^{j}\left(\mathrm{D}_{2}\right) \wedge 3
$$

are invariant under $P_{-\mathrm{u}}$. So, by Proposition 3.5(ii), $M_{\iota}$ and $M_{\iota^{\prime}}$ contain $C_{\kappa_{-}}$and $C_{\kappa_{-}^{\prime}}$ respectively.
(ii) For $i=\left(i_{0}, i_{1}, i_{2}, i_{3}, i_{4}\right)$ in $\mathbb{N}^{5}$, set: $i^{*}:=\left(i_{0}, i_{1}, i_{2}, i_{4}, i_{3},\right)$. By corollary $2.3(\mathrm{i})$, for $i, j$ in $\mathbb{N}^{5}$, $C_{i}$ is orthogonal to $C_{j}$ if and only if $j \neq i^{*}$.

Denote by $M_{\iota}^{\perp}$ and $C_{\iota}^{\perp}$ the orthogonal complements to $M_{\iota}$ and $C_{\iota}$ in $\wedge^{k}(\mathfrak{g})$ respectively. By Lemma 2.1, $M_{\iota}^{\perp}$ is the biggest $G$-module contained in $C_{\iota}^{\perp}$. Suppose that $C_{\iota_{+}}$is not contained in $M_{\iota}$. A contradiction is expected. As $\bigwedge^{k}(\mathrm{~g})$ is the direct sum of $C_{i}, i \in \mathbb{N}_{k}^{5}, C_{\iota}^{\perp}$ is the direct sum of $C_{i}, i \in \mathbb{N}_{k}^{5} \backslash\{\iota\}$ since $\iota^{*}=\iota$. By (i), $M_{\iota}^{\perp}$ is contained in the sum of $C_{i}, i \in \mathbb{N}_{k}^{5} \backslash\left\{\iota, \kappa_{,} \kappa_{-}\right\}$. Since $\iota_{+}^{*}=\iota_{+}$, the orthogonal complement to $C_{\iota_{+}}$is the sum of $C_{i}, i \in \mathbb{N}_{k}^{5} \backslash\left\{\iota_{+}\right\}$. Then $M_{\iota}^{\perp}$ is not contained in the direct sum of $C_{i}, i \in \mathbb{N}_{k}^{5} \backslash\left\{\iota, \kappa, \kappa_{-}, \iota_{+}\right\}$since $C_{\iota_{+}}$is not contained in $M_{\iota}$. Hence for some subspace $M$ of $\bigwedge^{n_{1}+1}\left(D_{1}\right) \wedge \bigwedge^{j-1}\left(D_{2}\right)$,

M \neq\{0\} \quad \text { and } \quad M_{\imath}^{\perp} \supset \bigwedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge M \wedge \bigwedge^{d}\left(\mathfrak{p}_{\mathrm{u}}\right)
$$

since $\bigwedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \bigwedge^{d}\left(\mathfrak{p}_{\mathrm{u}}\right)$ has dimension 1. As a result, by Proposition 3.5, (i) and (ii),

& M_{\iota}^{\perp} \supset \bigwedge^{d-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{D}_{2} \wedge M \wedge \bigwedge^{d}\left(\mathfrak{p}_{\mathrm{u}}\right) \\
& M_{\iota}^{\perp} \supset \bigwedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{D}_{2} \wedge M \wedge \bigwedge^{d-1}\left(\mathfrak{p}_{\mathrm{u}}\right)
\end{aligned}
$$

since $M \wedge \bigwedge^{d}\left(\mathfrak{p}_{\mathrm{u}}\right)$ is a $P_{\mathrm{u}}$-submodule of $\bigwedge^{d+j+n_{1}}(\mathfrak{g})$ and $M \wedge \bigwedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right)$ is a $P_{-, \mathrm{u}}$-submodule of $\bigwedge^{d+j+n_{1}}(\mathrm{~g})$. As $j$ is smaller than dim $\dot{D}_{2}$ and $M$ is different from zero, $\boldsymbol{D}_{2} \wedge M \neq\{0\}$. Then $C_{\kappa}+C_{\kappa,-}$ is not contained in $M_{\iota}$ since $C_{\kappa}+C_{\kappa_{-}}$is orthogonal to $C_{i}$ for all $i$ in $\mathbb{N}_{k}^{5} \backslash\left\{\kappa, \kappa_{-}\right\}$, whence the contradiction.

Denote by $M_{\iota^{\prime}}^{\perp}$ and $C_{\iota^{\prime}}^{\perp}$ the orthogonal complements to $M_{\iota^{\prime}}$ and $C_{\iota^{\prime}}$ in $\Lambda^{k}(\mathfrak{g})$ respectively. By Lemma 2.1, $M_{\iota^{\prime}}^{\perp}$ is the biggest $G$-module contained in $C_{t^{\prime}}^{\perp}$. Suppose that $C_{l_{+}^{\prime}}$ is not contained in $M_{\iota^{\prime}}$. A contradiction is expected. As $\bigwedge^{k}(\mathfrak{g})$ is the direct sum of $C_{i}, i \in \mathbb{N}_{k}^{5}, C_{\iota^{\prime}}^{\perp}$ is the direct sum of $C_{i}, i \in \mathbb{N}_{k}^{5} \backslash\left\{\iota^{\prime}\right\}$ since $\iota^{\prime *}=\iota^{\prime}$. By (i), $M_{\iota^{\prime}}^{\perp}$ is contained in the sum of $C_{i}, i \in \mathbb{N}_{k}^{5} \backslash\left\{\iota^{\prime}, \kappa^{\prime}, \kappa_{-}^{\prime}\right\}$. Since $\iota_{+}^{\prime *}=\iota_{+}^{\prime}$, the orthogonal complement to $C_{\iota_{+}^{\prime}}$ is the sum of $C_{i}, i \in \mathbb{N}_{k}^{5} \backslash\left\{\iota_{+}^{\prime}\right\}$. Then $M_{\iota^{\prime}}^{\perp}$ is not contained in the direct sum of $C_{i}, i \in \mathbb{N}_{k}^{5} \backslash\left\{\iota^{\prime}, \kappa^{\prime}, \kappa_{-}^{\prime}, \iota_{+}^{\prime}\right\}$ since $C_{\iota_{+}^{\prime}}$ is not contained in $M_{\iota^{\prime}}$. Hence for some subspace $M^{\prime}$ of $\bigwedge^{n_{1}+1}\left(D_{1}\right) \wedge \bigwedge^{j-2}\left(D_{2}\right)$,

M^{\prime} \neq\{0\} \quad \text { and } \quad M_{\iota^{\prime}}^{\perp} \supset \bigwedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{z} \wedge M^{\prime} \wedge \bigwedge^{d}\left(\mathfrak{p}_{\mathrm{u}}\right)
$$

since $\} \wedge \wedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \bigwedge^{d}\left(\mathfrak{p}_{\mathrm{u}}\right)$ has dimension 1. As a result, by Proposition 3.5, (i) and (ii),

& M_{\iota^{\prime}}^{\perp} \supset \bigwedge^{d-1}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{z} \wedge \mathfrak{D}_{2} \wedge M^{\prime} \wedge \bigwedge^{d}\left(\mathfrak{p}_{\mathrm{u}}\right) \\
& M_{\iota^{\prime}}^{\perp} \supset \bigwedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right) \wedge \mathfrak{z} \wedge \mathfrak{D}_{2} \wedge M^{\prime} \wedge \bigwedge^{d-1}\left(\mathfrak{p}_{\mathrm{u}}\right)
\end{aligned}
$$

since $\mathfrak{\jmath} \wedge M^{\prime} \wedge \bigwedge^{d}\left(\mathfrak{p}_{\mathrm{u}}\right)$ is a $P_{\mathrm{u}}$-submodule of $\bigwedge^{d+j+n_{1}}(\mathfrak{g})$ and $\mathfrak{\jmath} \wedge M^{\prime} \wedge \bigwedge^{d}\left(\mathfrak{p}_{-, \mathrm{u}}\right)$ is a $P_{-, \mathrm{u}}$-submodule of $\bigwedge^{d+i+n_{1}}(\mathrm{~g})$. As $j$ is smaller than $\operatorname{dim}_{D_{2}}$ and $M^{\prime}$ is different from zero, $D_{2} \wedge M^{\prime} \neq\{0\}$. Then $C_{\kappa^{\prime}}+C_{\kappa^{\prime},-}$ is not contained in $M_{\iota^{\prime}}$ since $C_{\kappa^{\prime}}+C_{\kappa_{-}^{\prime}}$ is orthogonal to $C_{i}$ for all $i$ in $\mathbb{N}_{k}^{5} \backslash\left\{\kappa^{\prime}, \kappa_{-}^{\prime}\right\}$, whence the contradiction.

Proposition 4.8. For $k=2 d+n_{1}, \ldots, n, V_{k}$ is equal to $\bigwedge^{k}(\mathfrak{g})$.
Proof. Prove the proposition by induction on $k$. Let $\left(l, l^{\prime}\right)$ be in $\mathbb{N}^{2}$ such that $l+l^{\prime} \leq 2 d, i \in \mathbb{I}_{k-l-l^{\prime}-1}$, $i^{\prime} \in \mathbb{I}_{k-l-l^{\prime}-2}$. If $l+l^{\prime}<2 d$ then $\mathfrak{g} \wedge V_{l, l^{\prime}, i}$ and $\mathfrak{g} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ are contained in $V_{k}$ by Corollary 4.4. If $l=l^{\prime}=d$ and $i_{1}<n_{1}$ then $\mathfrak{g} \wedge V_{l, l^{\prime}, i}$ is contained in $V_{k, \mathfrak{p}}$ since $2 d+n_{2}>n$ by Proposition A.1. If
$l=l^{\prime}=d$ and $i_{1}^{\prime}<n_{1}$ then $\mathfrak{g} \wedge V_{l, l^{\prime}, i^{\prime}}^{\prime}$ is contained in $V_{k, \mathfrak{p}}$ since $2 d+n_{2}>n$ by Proposition A.1. As a result, for $k=2 d+n_{1}$, by Lemma 1.2 and Remark 4.6, $V_{k}=\wedge^{k}(\mathfrak{g})$.

Suppose $k>2 d+n_{1}, V_{k-1}=\bigwedge^{k-1}(\mathfrak{g}), i=\left(n_{1}, k-2 d-n_{1}-1\right)$ and $i^{\prime}=\left(n_{1}, k-2 d-n_{1}-2\right)$. By definition, $V_{k, p}$ contains the subspaces of $\bigwedge^{k}(\mathfrak{g})$,

$$
\mathfrak{p}_{-, \mathrm{u}} \wedge V_{d, d, i}, \quad \mathfrak{p}_{\mathrm{u}} \wedge V_{d, d, i}, \quad \mathfrak{D}_{2} \wedge V_{d, d, i}, \quad \mathfrak{p}_{-, \mathrm{u}} \wedge V_{d, d, i^{\prime}}^{\prime}, \quad \mathfrak{p}_{\mathrm{u}} \wedge V_{d, d, i^{\prime}}^{\prime}, \quad \mathfrak{D}_{2} \wedge V_{d, d, i^{\prime}}^{\prime}
$$

since $i_{2}$ and $i_{2}^{\prime}$ are smaller than $n_{2}$. By Lemma 4.7(ii), $V_{k}$ contains $D_{1} \wedge V_{d, d, i}$ and $D_{1} \wedge V_{d, d^{\prime}, i^{\prime}}^{\prime}$. Then $V_{k}$ contains $\mathfrak{g} \wedge V_{d, d, i}$ and $\mathfrak{g} \wedge V_{d, d, i^{\prime}}^{\prime}$. As a result, by our previous remark, $V_{k}$ contains $\mathfrak{g} \wedge V_{k-1, \mathfrak{p}}$, whence the proposition by Lemma 1.2 and the induction hypothesis.
4.4. The general case. First, we consider the case when $X$ contains the extremities of $\Pi$.

Lemma 4.9. Suppose $\ell \geq 2, \mathrm{n} \geq 2$ and the extremities of $\Pi$ contained in $X$. If $|X|$ is smaller than $\ell-1$ then for some $\beta$ in $\Pi \backslash X, Y:=\Pi \backslash\{\beta\}$ has two connected components, $X$ is contained in $Y$ and a connected component of $Y$ is a connected component of $X$.
Proof. Suppose $|X|<\ell-1$. We consider the following cases:
(1) $\Pi$ has not type D, E,
(2) $\Pi$ has type $\mathrm{D}_{\ell}$,
(3) $\Pi$ has type $E_{6}$,
(4) $\Pi$ has type $E_{7}$,
(5) $\Pi$ has type $\mathrm{E}_{8}$.
(1) Let $X_{1}$ be the connected component of $X$ containing $\beta_{1}$. There is only one element $\beta$ of $\Pi \backslash X$ not orthogonal to $X_{1}$. Then $Y:=\Pi \backslash\{\beta\}$ has two connected components and $X_{1}$ is a connected component of $Y$.
(2) Let $X_{1}$ be the connected component of $X$ containing $\beta_{1}$. As $\beta_{\ell}$ and $\beta_{\ell-1}$ are in $X$, for some $i$ smaller than $\ell-2, \beta_{i}$ is not in $X$ since $|X|<\ell-1$. Then there is only one element $\beta$ in $\Pi \backslash X$ not orthogonal to $X_{1}$ so that $Y:=\Pi \backslash\{\beta\}$ has two connected components and $X_{1}$ is a connected component of $Y$.
(3) As $\beta_{1}, \beta_{2}, \beta_{6}$ are in $X, \beta_{3}$ or $\beta_{5}$ is not in $X$ since $|X|<\ell-1$. Setting $Y_{i}:=\Pi \backslash\left\{\beta_{i}\right\}$ for $i=3,5, Y_{i}$ has two connected components and for some $i, X$ is contained in $Y_{i}$ and a connected component of $X$ is a connected component of $Y_{i}$.
(4) As $\beta_{1}, \beta_{2}, \beta_{7}$ are in $X, \beta_{3}$ or $\beta_{5}$ or $\beta_{6}$ is not in $X$ since $|X|<\ell-1$. Setting $Y_{i}:=\Pi \backslash\left\{\beta_{i}\right\}$ for $i=3,5,6, Y_{i}$ has two connected components and for some $i, X$ is contained in $Y_{i}$ and a connected component of $X$ is a connected component of $Y_{i}$.
(5) As $\beta_{1}, \beta_{2}, \beta_{8}$ are in $X, \beta_{3}$ or $\beta_{5}$ or $\beta_{6}$ or $\beta_{7}$ is not in $X$ since $|X|<\ell-1$. Setting $Y_{i}:=\Pi \backslash\left\{\beta_{i}\right\}$ for $i=3,5,6,7, Y_{i}$ has two connected components and for some $i, X$ is contained in $Y_{i}$ and a connected component of $X$ is a connected component of $Y_{i}$.
Proposition 4.10. Let $k=1, \ldots, n$. Suppose that Theorem 1.1 is true for the simple algebras of rank smaller than $\ell$ and $X$ contains the extremities of $\Pi$. Then $V_{k}=\Lambda^{k}(g)$.
Proof. As $X$ contains the extremities of $\Pi$ and is different from $\Pi, \ell \geq 3$ and $\mathrm{n} \geq 2$. By Proposition 4.5, Remark 4.6 and Proposition $4.8, V_{k}=\Lambda^{k}(\mathfrak{g})$ when $|X|=\ell-1$. In particular, $V_{k}=\Lambda^{k}(\mathrm{~g})$ when $\ell=3$. Suppose $\ell>3$ and $|X|<\ell-1$.

Let $Y$ be as in Lemma 4.9. Then $\mathfrak{D}_{Y}$ has two simple factors $\mathfrak{D}_{1}$ and $\mathfrak{a}$ and $\mathfrak{D}_{1}$ is a simple factor of D. Denote by $V_{k, Y}$ the $G$-submodule of $\bigwedge^{k}(\mathrm{~g})$ generated by $V_{k, p_{Y}}$. Then, by Proposition 4.5, Remark 4.6 and Proposition 4.8, $V_{k, Y}=\bigwedge^{k}(\mathfrak{g})$. The intersection $\mathfrak{q}:=\mathfrak{a} \cap \mathfrak{p}$ is a parabolic subalgebra of $\mathfrak{a}$. Let $E^{\prime}$ be the intersection of $E$ and $\mathfrak{a}$. Then $E$ is the direct sum of $E^{\prime}$ and $E_{Y}$. As a result, setting $n_{*}:=\mathrm{b}_{\mathfrak{a}}-\ell_{\mathfrak{a}}$,

$$
V_{k, \mathfrak{p}}=\bigoplus_{i=0}^{n_{1}} \bigoplus_{j=0}^{n_{*}} \bigwedge^{i}\left(\mathrm{D}_{1}\right) \wedge V_{j, \mathfrak{q}} \wedge \bigwedge^{k-i-j}\left(E_{Y}\right)
$$

Let $A$ be the connected closed subgroup of $G$ whose Lie algebra is $\mathfrak{a}$. By the hypothesis, for $j=$ $1, \ldots, n_{*}$, the $A$-submodule of $\bigwedge^{j}(\mathfrak{a})$, generated by $V_{j, \mathfrak{q}}$, is equal to $\bigwedge^{j}(\mathfrak{a})$. Hence, by Lemma 1.2, $V_{k, p_{Y}}$ is contained in $V_{k}$ since $\mathfrak{D}_{1}$ and $E_{Y}$ are invariant under $A$, whence $V_{k}=\Lambda^{k}(\mathfrak{g})$.

To finish the proof of Theorem 1.1, we have to consider the case when $X$ does not contain all the extremities of $\Pi$.

Lemma 4.11. Suppose that $X$ does not contain all the extremities of $\Pi$.
(i) There exists a sequence

$$
X_{0} \subset \cdots \subset X_{m}=\Pi
$$

of connected subsets of $\Pi$ satisfying the following conditions:
(1) for $i=1, \ldots, m,\left|X_{i} \backslash X_{i-1}\right|=1$,
(2) $X$ contains the extremities of $X_{0}$.
(ii) For $i=0, \ldots, m$, let $\mathfrak{a}_{i}$ be the subalgebra of $\mathfrak{g}$ generated by $\mathfrak{g}^{ \pm \beta}, \beta \in X_{i}$. Then $\mathfrak{a}_{i}$ is a simple algebra and $\mathfrak{p}_{i}:=\mathfrak{p} \cap \mathfrak{a}_{i}$ is a parabolic subalgebra of $\mathfrak{a}_{i}$.
(iii) For $i=0, \ldots, m, E$ is the direct sum of $E_{i}:=E \cap \mathfrak{a}_{i}$ and $E_{X_{i}}$.

Proof. (i) Define $X_{i}$ by induction on $i$. Let $X_{0}$ be a connected subset of $\Pi$, containing $X$ of minimal cardinality. By minimality of $\left|X_{0}\right|, X$ contains the extremities of $X_{0}$. Suppose $i>0$ and $X_{i-1}$ defined. If $X_{i-1}=\Pi$ there is nothing to do. Suppose $X_{i-1} \neq \Pi$. As $\Pi$ is connected, there is some $\beta$ in $\Pi \backslash X_{i-1}$, not orthogonal to an extremity of $X_{i-1}$. Then $X_{i}:=X_{i-1} \cup\{\beta\}$ is a connected subset of $\Pi$ since so is $X_{i-1}$, whence the assertion.
(ii) As $X_{i}$ is connected, $\mathfrak{a}_{i}$ is a simple algebra. For $\alpha$ in $\left\langle X_{i}\right\rangle, \mathfrak{g}^{\alpha}$ is contained in $\mathfrak{a}_{i} \cap \mathfrak{p}$. Hence $\mathfrak{p}_{i}$ contains the Borel subalgebra of $\mathfrak{a}_{i}$ generated by $\mathfrak{b} \cap \mathfrak{a}_{i}$ and $\mathfrak{g}^{\beta}, \beta \in X_{i}$, whence the assertion.
(iii) Let $\alpha$ be a positive root such that $\mathfrak{g}^{\alpha}$ is contained in $E$. If $\alpha$ is in $<X_{i}>$ then $\mathfrak{g}^{\alpha}$ and $\mathfrak{g}^{-\alpha}$ are contained in $E_{i}$. Otherwise, $\mathfrak{g}^{\alpha}$ and $\mathfrak{g}^{-\alpha}$ are contained in $E_{X_{i}}$ by definition.

Let $z$ be in $E \cap \mathfrak{h}$. By definition, $\mathfrak{h} \cap E_{X_{i}}$ is the orthogonal complement to $\mathfrak{a}_{i}$ in $\mathfrak{h}$. Then $z=z_{1}+z_{2}$ with $z_{1}$ in $\mathfrak{a}_{i} \cap \mathfrak{h}$ and $z_{2}$ in $E_{X_{i}}$. Hence $z_{1}$ is orthogonal to $\mathfrak{a}_{i} \cap \mathfrak{p}$. As a result, $z_{1}$ is in $E_{i}$ and $z$ is in $E_{i}+E_{X_{i}}$, whence the assertion.

We can now give the proof of Theorem 1.1.
Proof. Prove the theorem by induction on $\ell$. First of all, for $X$ empty subset of $\Pi, V_{k, \mathrm{p}_{X}}=\Lambda^{k}(\mathrm{~g})$. For $\ell=1, n=1$. Hence the theorem is true in this case and we can suppose $X$ nonempty and $\ell \geq 2$. By Proposition 4.1 and Remark $4.2, V_{k}=\bigwedge^{k}(\mathfrak{g})$ when $X$ is connected. In particular, the
theorem is true in rank 2. Then, by Proposition 4.10, the theorem is true for $\ell=3$ since in this case $X$ contains all the extremities of $\Pi$ when it is not connected.

Suppose $\ell>3$ and the theorem true for the simple algebras of rank smaller than $\ell$. By induction hypothesis and Proposition $4.10, V_{k}=\bigwedge^{k}(\mathfrak{g})$ when $X$ contains all the extremities of $\Pi$. So, we can suppose that $X$ does not contain all the extremities of $\Pi$. Let $X_{0}, \ldots, X_{m}$ be as in Lemma 4.11. For $i=0, \ldots, m$, set $e_{i}:=\left|\left\langle X_{i}\right\rangle\right|$ and prove by induction on $i$ the inclusion

$$
\bigoplus_{j=0}^{e_{i}} \bigwedge^{j}\left(\mathfrak{a}_{i}\right) \wedge \bigwedge^{k-j}\left(E_{X_{i}}\right) \subset V_{k} .
$$

For $i=0, \ldots, n$, denote by $A_{i}$ the connected closed subgroup of $G$ whose Lie algebra is $\mathfrak{a}_{i}$. By Lemma 4.11,(ii) and (iii),

$$
V_{k, p}=\bigoplus_{j=0}^{e_{i}} V_{j, p_{i}} \wedge \bigwedge^{k-j}\left(E_{X_{i}}\right),
$$

for $i=0, \ldots, m$. Then, by Proposition 4.10, the induction hypothesis and Lemma 1.2, the inclusion is true for $i=0$ since $E_{X_{0}}$ is invariant under $A_{0}$. Suppose $i>0$ and the inclusion true for $i-1$. Let $E_{X_{i}}^{\prime}$ be the intersection of $E_{X_{i-1}}$ and $\mathfrak{a}_{i}$. Denote by $\mathfrak{q}_{i}$ the parabolic subalgebra of $\mathfrak{a}_{i}$ containing $\mathfrak{b} \cap \mathfrak{a}_{i}$ and such that $\mathfrak{a}_{i-1}$ is the derived algebra of the reductive factor of $\mathfrak{q}_{i}$ containing $\mathfrak{h} \cap \mathfrak{a}_{i}$. Then

$$
\begin{gathered}
E_{X_{i-1}}=E_{X_{i}}^{\prime} \oplus E_{X_{i}}, \quad \mathfrak{a}_{i}=\mathfrak{a}_{i-1} \oplus E_{X_{i}}^{\prime}, \\
\bigwedge^{j}\left(\mathfrak{a}_{i-1}\right) \wedge \bigwedge^{k-j}\left(E_{X_{i-1}}\right)=\bigoplus_{l=0}^{k-j} \bigwedge^{j}\left(\mathfrak{a}_{i-1}\right) \wedge \bigwedge^{l}\left(E_{X_{i}}^{\prime}\right) \wedge \bigwedge^{k-j-l}\left(E_{X_{i-1}}\right)
\end{gathered}
$$

for $j=0, \ldots, e_{i-1}$. As a result,

$$
\bigoplus_{j=0}^{e_{i-1}} \wedge^{j}\left(\mathfrak{a}_{i-1}\right) \wedge \bigwedge^{k-j}\left(E_{X_{i-1}}\right)=\bigoplus_{j=0}^{e_{i}} V_{j, \mathfrak{q}_{i}} \wedge \bigwedge^{k-j}\left(E_{X_{i}}\right)
$$

By Proposition 4.1 and Remark 4.2, for $j=0, \ldots, e_{i}$, the $A_{i}$-submodule of $\wedge^{j}\left(\mathfrak{a}_{i}\right)$ generated by $V_{j, \mathfrak{q}_{i}}$ is equal to $\bigwedge^{j}\left(\mathfrak{a}_{i}\right)$ since $\mathfrak{a}_{i-1}$ is simple and $\ell_{\mathfrak{a}_{i}}-\ell_{\mathfrak{a}_{i-1}}=1$. Then, by Lemma 1.2, the $A_{i}$-submodule of $\bigwedge^{k}(\mathrm{~g})$ generated by

$$
\bigoplus_{j=0}^{e_{i-1}} \bigwedge^{j}\left(\mathfrak{a}_{i-1}\right) \wedge \bigwedge^{k-j}\left(E_{X_{i-1}}\right)
$$

is equal to

$$
\bigoplus_{j=0}^{e_{i}} \bigwedge^{j}\left(\mathfrak{a}_{i}\right) \wedge \bigwedge^{k-j}\left(E_{X_{i}}\right)
$$

since $E_{X_{i}}$ is invariant under $A_{i}$, whence the assertion and the theorem since for $i=m$ the sum is equal to $\bigwedge^{k}(\mathfrak{g})$.

## Appendix A. Some remarks on root systems

Let $\beta$ be in $\Pi$ and $X:=\Pi \backslash\{\beta\}$. Set $\mathfrak{p}_{\mathrm{u}}:=\mathfrak{p}_{\mathrm{u}, X}$ and $d:=\operatorname{dim} \mathfrak{p}_{\mathrm{u}, X}$. The goal of the section is the following proposition:
Proposition A.1. (i) Suppose $\Pi$ of type $\mathrm{A}_{\ell}$ and $X$ not connected. Then $\beta=\beta_{s+1}$ for some $s$ in $\{1, \ldots, \ell-2\}$,

$$
\mathrm{n}=2, \quad n_{1}=\frac{s(s+1)}{2}, \quad n_{2}=\frac{(\ell-s-1)(\ell-s)}{2}
$$

Moreover, if $2 d+n_{1} \leq n$ then

$$
\ell \geq 6, \quad s \leq \frac{1}{6}\left(2 \ell-3-\sqrt{4 \ell^{2}+12 \ell+9}\right), \quad 2 d+n_{2}>n
$$

(ii) Suppose $\Pi$ of type $\mathrm{B}_{\ell}$ or $\mathrm{C}_{\ell}$ and $X$ not connected. Then $\beta=\beta_{s+1}$ for some s in $\{1, \ldots, \ell-2\}$,

$$
\mathrm{n}=2, \quad n_{1}=\frac{s(s+1)}{2}, \quad n_{2}=(\ell-s-1)^{2} .
$$

Moreover, if $2 d+n_{1} \leq n$ then

$$
\ell \geq 7, \quad s \leq \frac{1}{10}\left(8 \ell-9-\sqrt{24 \ell^{2}+16 \ell+1}\right), \quad 2 d+n_{2}>n
$$

 connected, then

$$
\mathrm{n}=2, \quad n_{1}=\frac{s(s+1)}{2}, \quad n_{2}=(\ell-s-1)^{2} .
$$

Moreover, if $2 d+n_{1} \leq n$ then

$$
\ell \geq 8, \quad s \leq \frac{1}{10}\left(8 \ell-13-\sqrt{24 \ell^{2}-8 \ell+9}\right), \quad 2 d+n_{2}>n
$$

(iv) Suppose that $\Pi$ is exceptional. If $2 d \leq n$ then $X$ is connected.

We prove the proposition case by case. So, in the classical case, we suppose $\ell \geq 3$ and $X$ not connected.
A.1. Type $\mathrm{A}_{\ell}$. As $X$ is not connected, $\mathrm{n}=2$ and $\beta=\beta_{s+1}$ for some $s$ in $\{1, \ldots, \ell-2\}$. Then

$$
\begin{gathered}
n_{1}=\frac{s(s+1)}{2}, \quad n_{2}=\frac{(\ell-s-1)(\ell-s)}{2}, \quad d=n-n_{1}-n_{2} \\
n-2 d-n_{1}=\frac{1}{2}\left(3 s^{2}+(-4 \ell+3) s+\ell^{2}-3 \ell\right) .
\end{gathered}
$$

If $n-2 d-n_{1} \geq 0$ then

$$
s \leq \frac{1}{6}\left(4 \ell-3-\sqrt{4 \ell^{2}+12 \ell+9}\right) \quad \text { or } \quad s \geq \frac{1}{6}\left(4 \ell-3+\sqrt{4 \ell^{2}+12 \ell+9}\right) .
$$

As $s \geq 1$, the first inequality is possible only if $\ell \geq 6$. The second inequality is impossible since its right hand side is bigger than $\ell-2$ and $s$ is at most $\ell-2$.

By the above equalities,

$$
n-2 d-n_{2}=3 s^{2}+(-2 \ell+3) s-2 \ell
$$

If the left hand side is nonnegative then

$$
s \leq \frac{1}{6}\left(2 \ell-3-\sqrt{4 \ell^{2}+12 \ell+9}\right) \quad \text { or } \quad s \geq \frac{1}{6}\left(2 \ell-3+\sqrt{4 \ell^{2}+12 \ell+9}\right) .
$$

The first inequality is impossible since its right hand side is negative. The second inequality is possible only if $\ell \geq 7$ since $s \leq \ell-2$. Moreover, it is not possible to have $n \geq 2 d+n_{1}$ and $n \geq 2 d+n_{2}$ since

$$
\frac{1}{6}\left(2 \ell-3+\sqrt{4 \ell^{2}+12 \ell+9}\right)>\frac{1}{6}\left(4 \ell-3-\sqrt{4 \ell^{2}+12 \ell+9}\right),
$$

whence Assertion (i) of Proposition A.1.
A.2. Type $\mathrm{B}_{\ell}$ or $\mathrm{C}_{\ell}$. As $X$ is not connected, $\mathrm{n}=2$ and $\beta=\beta_{s+1}$ for some $s$ in $\{1, \ldots, \ell-2\}$. Then

$$
\begin{aligned}
& n_{1}=\frac{s(s+1)}{2}, \quad n_{2}=(\ell-s-1)^{2}, \quad d=n-n_{1}-n_{2}, \\
& n-2 d-n_{1}=\frac{1}{2}\left(5 s^{2}+(-8 \ell+9) s+2 \ell^{2}-8 \ell+4\right) .
\end{aligned}
$$

If $n-2 d-n_{1} \geq 0$ then

$$
s \leq \frac{1}{10}\left(8 \ell-9-\sqrt{24 \ell^{2}+16 \ell+1}\right) \quad \text { or } \quad s \geq \frac{1}{10}\left(8 \ell-9+\sqrt{24 \ell^{2}+16 \ell+1}\right) .
$$

As $s \geq 1$, the first inequality is possible only if $\ell \geq 7$. The second inequality is impossible since its right hand side is bigger than $\ell-2$ and $s$ is at most $\ell-2$.

By the above equalities,

$$
n-2 d-n_{2}=2 s^{2}+(-2 \ell+5) s-4 \ell+4
$$

If the left hand side is nonnegative then

$$
s \leq \frac{1}{4}\left(2 \ell-5-\sqrt{4 \ell^{2}+12 \ell-7}\right) \quad \text { or } \quad s \geq \frac{1}{4}\left(2 \ell-5+\sqrt{4 \ell^{2}+12 \ell-9}\right) .
$$

The first inequality is impossible since its right hand side is negative. The second inequality is impossible since

$$
s \leq \ell-2 \quad \text { and } \quad \frac{1}{4}\left(2 \ell-5+\sqrt{4 \ell^{2}+12 \ell-9}\right)>\ell-2
$$

whence Assertion (ii) of Proposition A.1.
A.3. Type $\mathrm{D}_{\ell \text {. }}$ As $X$ is not connected, $\beta$ is different from $\beta_{1}, \beta_{\ell-1}, \beta_{\ell}$. If $\beta=\beta_{\ell-2}$ then $X$ has three connected components and

$$
d=\ell(\ell-1)-2-\frac{1}{2}(\ell-3)(\ell-2)
$$

In this case $n<2 d$. Suppose $\ell \geq 5$ and $\beta=\beta_{s+1}$ for some $s$ in $\{1, \ldots, \ell-4\}$. Then

$$
\begin{gathered}
n_{1}=\frac{s(s+1)}{2}, \quad n_{2}=(\ell-s-1)(\ell-s-2), \quad d=n-n_{1}-n_{2}, \\
n-2 d-n_{1}=5 s^{2}-s(4 \ell-7)+\ell^{2}-5 \ell+4 .
\end{gathered}
$$

If $n-2 d-n_{1} \geq 0$ then

$$
s \leq \frac{1}{10}\left(8 \ell-13-\sqrt{24 \ell^{2}-8 \ell+9}\right) \quad \text { or } \quad s \geq \frac{1}{10}\left(8 \ell-13+\sqrt{24 \ell^{2}-8 \ell+9}\right) .
$$

As $s \geq 1$, the first inequality is possible only if $\ell \geq 8$. The second inequality is impossible since its right hand side is bigger than $\ell-4$ and $s$ is at most $\ell-4$.

By the above equalities,

$$
n-2 d-n_{2}=2 s^{2}+(-2 \ell+4) s-2 \ell+2
$$

If the left hand side is nonnegative then

$$
s \leq-1 \quad \text { or } \quad s \geq \ell-1 .
$$

These inequalities are impossible since $s$ is positive and smaller than $\ell-3$, whence Assertion (iii) of Proposition A.1.
A.4. The exceptional case. Set $\mathfrak{I}:=\mathfrak{I}_{X}, \mathfrak{D}:=\mathfrak{D}_{X}$. Then $2 d=\operatorname{dimg}-\operatorname{dim} I$. For each case, we give all the possible dimensions of I when $|X|=\ell-1$.
(a) The algebra $\mathfrak{g}$ has type $\mathrm{G}_{2}$. Then $X$ is connected, whence Assertion (iv) of Proposition A. 1 for this case.
(b) The algebra $\mathfrak{g}$ has type $\mathrm{F}_{4}$. In this case $n=24$ and

$$
\operatorname{dim} I \in\{12,22\} \quad \text { whence } \quad 2 d \in\{40,30\}
$$

and Assertion (iv) of Proposition A. 1 for this case.
(c) The algebra $\mathfrak{g}$ has type $\mathrm{E}_{6}$. In this case $n=36$ and

$$
\operatorname{dim} I \in\{20,28,36,46\} \quad \text { whence } \quad 2 d \in\{58,50,42,32\}
$$

and Assertion (iv) of Proposition A. 1 for this case since $\begin{gathered}\text { d } \\ \text { is simple of type } \\ D_{5}\end{gathered}$ when $2 d=32$.
(d) The algebra $\mathfrak{g}$ has type $\mathrm{E}_{7}$. In this case $n=63$ and

$$
\operatorname{dim} I \in\{27,33,39,49,67,79\} \quad \text { whence } \quad 2 d \in\{106,100,94,84,66,54\}
$$

and Assertion (iv) of Proposition A. 1 for this case since $\boldsymbol{D}$ is simple of type $\mathrm{E}_{6}$ when $2 d=54$.
(e) The algebra $\mathfrak{g}$ has type $\mathrm{E}_{8}$. In this case $n=120$ and $\operatorname{dimI} \in\{36,40,52,54,64,82,92,134\} \quad$ whence $2 d \in\{212,208,196,194,184,166,156,114\}$ and Assertion (iv) of Proposition A. 1 for this case since d is simple of type $\mathrm{E}_{7}$ when $2 d=114$.
