# MATHEMATICAL ANALYSIS OF A THREE-TIERED FOOD-WEB IN THE CHEMOSTAT

#### Abstract

A mechanistic model describing the anaerobic mineralization of chlorophenol in a three-step food-web is investigated. The model is a sixdimensional system of ordinary differential equations. In our study, the phenol and the hydrogen inflowing concentrations are taken into account as well as the maintenance terms. The case of a large class of growth kinetics is considered, instead of specific kinetics. We show that the system can have up to eight types of steady states and we analytically determine the necessary and sufficient conditions for their existence according to the operating parameters. In the particular case without maintenance, the local stability conditions of all steady states are determined. The bifurcation diagram shows the behavior of the process by varying the concentration of influent chlorophenol as the bifurcating parameter. It shows that the system exhibits a bi-stability where the positive steady state can lose stability undergoing a supercritical Hopf bifurcation with the emergence of a stable limit cycle.


1. Introduction. The chemostat model is widely used in microbiology and ecology as a mathematical representation of the continuous culture of micro-organisms, that is, the growth of micro-organisms in ecosystems that are continuously fed with nutrients $[18,20,30]$. Several textbooks on the mathematical analysis of this model with one and more species are available [17, 27]. The chemostat model predicts that coexistence of two or more microbial populations competing for a single nonreproducing nutrient is not possible. Only the species with the lowest 'break-even' concentration survives. This result, known as the Competitive Exclusion Principle (CEP), has a long history in the literature of bio-mathematics and the reader may consult [22] and the references therein.

Although the theoretical prediction of the CEP has been corroborated by the experiences of Hansen and Hubell [16], the biodiversity found in nature as well as

[^0]in biological reactors seems to contradict the CEP. This has led to a great deal of mathematical research aimed at extending the chemostat model to better match theory and observations. Among the mechanisms that promote the coexistence of species, we can cite : the crowding effects (see $[1,8]$ and the references therein), the role of density-dependent growth functions (see [15] and the references therein), more complex food webs (see [2, 19, 33] and the reference therein), the presence of inhibitors that affects the strongest competitor (see [3, 9, 10, 32], and the references therein), the commensalistic relationship where a second species (the commensal) needs the first one (the host) to grow while the host species is not affected by the growth of the commensal one (see $[5,6,11,26]$ and the references therein), the syntrophic relationship where two microbial species depend on each other for survival (see $[7,12,14,23,24,34]$ and the reference therein).

Some of these models were constructed to have a better understanding of anaerobic digestion (AD), which is an important process used in the treatment of wastewater and waste, including a large number of species that coexist in a very complex relationship. The full anaerobic digestion model (ADM1) developed in [4] includes 32 state variables and a large number of parameters. Therefore, the qualitative analysis and the control of this model are very difficult because of its complexity and its dependence on many operational variables. The so-called AM2 model developed in [6] represents a two-tiered food-web and provides satisfactory prediction of the AD process by using the parameter identification theory and experimental data. In [14], a three-tiered food-web model including enzymatic degradation of a substrate and commensalistic relationship is considered. In [31], the authors consider a three-tiered food-web with three microbial species (chlorophenol and phenol degraders and hydrogenotrophic methanogen) that encapsulates the essence of the AD process. The corresponding model represents an extension of the model describing the interactions between propionate degraders and hydrogenotrophic methanogens in a two-tiered feeding chain [34]. For a recent review of mathematical modeling of anaerobic digestion, the reader is refereed to [29].

The aim of our paper is to consider the three-tiered microbial 'food-web', developed in [31] which is written as follows:

where $X_{\mathrm{ch}}, X_{\mathrm{ph}}$ and $X_{\mathrm{H}_{2}}$ denote, respectively, the chlorophenol, phenol and hydrogen degrader concentrations; $f_{0}, f_{1}$ and $f_{2}$ are the corresponding growth rates; $S_{\mathrm{ch}}$, $S_{\mathrm{ph}}$ and $S_{\mathrm{H}_{2}}$ are the chlorophenol, phenol and hydrogen substrates concentrations; $S_{\mathrm{ch}}^{\mathrm{in}}, S_{\mathrm{ph}}^{\mathrm{in}}$ and $S_{\mathrm{H}_{2}}^{\mathrm{in}}$ are the substrate concentrations in the feed bottle; $k_{\mathrm{dec}, \mathrm{ch}}, k_{\mathrm{dec}, \mathrm{ph}}$ and $k_{\mathrm{dec}, \mathrm{H}_{2}}$ represent the decay rates; $D$ is the dilution rate of the chemostat; $Y_{\mathrm{ch}}$, $Y_{\mathrm{ph}}$ and $Y_{\mathrm{H}_{2}}$ are the yield coefficients.

The choice of the application of chlorophenol-mineralising food-web in [31] is due to the availability of experimental data but the study of model (1) applies to any other similar microbial food chain. Indeed, the parameter values related to hydrogen are deduced from that of ADM1 [4]. For chlorophenol and phenol, they
were chosen based on a combination of literature data (see [31] and the references therein). Recently, a rigorous mathematical analysis of this model (1) was done in [25] with general growth rates but only the chlorophenol inflowing concentration has been taken into account. Using the linear change of variables given by (7) and (8), model (1) can be written as follows:

where $s_{i}, i=0,1,2$ are the three substrates; $x_{i}$ are the three microbial species; $\mu_{i}$ are the specific growth rates given by (9); $a_{i}$ are the mortality rates; $s_{i}^{\text {in }}$ are the concentrations of the three substrates in the feed device. All the yield coefficients in (1) are normalized to one except of $\omega$.

In [25], system (2) can have at most three types of steady states when $s_{0}^{\text {in }}>0$ and $s_{1}^{\text {in }}=s_{2}^{\text {in }}=0$ : the washout steady state, a coexistence steady state of three species and a steady steady state where only the hydrogen degrader is extinct. The local stability analysis is achieved when the maintenance is excluded from system (2) where this six-dimensional model is reduced to a three-dimensional one. A numerical evidence shows that, when maintenance is included, the positive steady state can destabilize through a supercritical Hopf bifurcation with the appearance of a stable periodic orbit [25]. In [28], when maintenance is excluded, the emergence of a supercritical Hopf bifurcation was analytically determined. In [13], the threetiered model of [31] was studied by neglecting the part of hydrogen produced by the phenol degrader and the mortality rates.

When in addition to $s_{0}^{\text {in }}>0$, the phenol and hydrogen inflowing concentrations are taken into account $\left(s_{1}^{\text {in }}>0\right.$ and $\left.s_{2}^{\text {in }}>0\right)$, it was proven in [31] that system (1) can have up to eight steady states, a fact that was confirmed in [13] and [28] when a larger class of growth functions is considered, but the maintenance terms are neglected. In [31] most of the results on the existence and stability of steady states of model (1) were obtained only numerically.

In this paper, we generalize [31] by allowing a larger class of growth functions and by giving rigorous proofs for the results on the existence of steady states obtained in [31] for system (1). For this class of growth function, we generalize [13, 28] by allowing maintenance terms and we generalize [25] by allowing phenol and hydrogen inflowing concentrations. More precisely, our main objective is to determine the existence of steady states of model (2) in the general case including maintenance and the inflow of the three substrates. Moreover, we analyze the asymptotic behavior of the system without maintenance and we apply our theoretical results to the three-tiered microbial model (1). Actually, the results on the stability of steady state in [31] were obtained when maintenance terms are included. In a forthcoming publication [21], we study theoretically this case, where system (2) cannot be reduced to a three-dimensional one.

The paper is organized as follows. The next section presents general assumptions for the growth rates and the mathematical analysis of the existence of steady states of model (2) with respect to the operating parameters. In Section 3, the asymptotic behavior analysis of (2) was done in the particular case without maintenance.

Considering specific growth rates, numerical simulations are presented in Section 4 as an application of our theoretical results to model (1). Finally, conclusions are drawn in Section 5. The proofs of all the propositions and theorems are reported in Appendix A. The parameter values and some auxiliary functions are presented in Tables in Appendix B.
2. Assumptions and steady states. Considering model (2), we make the following general assumptions on the growth functions which are continuously differentiable ( $\mathcal{C}^{1}$ ).
(H1) For all $s_{0}>0$ and $s_{2}>0,0<\mu_{0}\left(s_{0}, s_{2}\right)<+\infty, \mu_{0}\left(0, s_{2}\right)=0, \mu_{0}\left(s_{0}, 0\right)=0$. No growth can occur for species $x_{0}$ without substrates $s_{0}$ and $s_{2}$.
(H2) For all $s_{1}>0$ and $s_{2} \geqslant 0,0<\mu_{1}\left(s_{1}, s_{2}\right)<+\infty, \mu_{1}\left(0, s_{2}\right)=0$. No growth can occur for species $x_{1}$ without substrate $s_{1}$.
(H3) For all $s_{2}>0,0<\mu_{2}\left(s_{2}\right)<+\infty, \mu_{2}(0)=0$. No growth can occur for species $x_{2}$ without substrate $s_{2}$.
(H4) For all $s_{0}>0$ and $s_{2}>0, \frac{\partial \mu_{0}}{\partial s_{0}}\left(s_{0}, s_{2}\right)>0, \quad \frac{\partial \mu_{0}}{\partial s_{2}}\left(s_{0}, s_{2}\right)>0$. The growth rate of species $x_{0}$ increases with substrates $s_{0}$ and $s_{2}$.
(H5) For all $s_{1}>0$ and $s_{2}>0, \frac{\partial \mu_{1}}{\partial s_{1}}\left(s_{1}, s_{2}\right)>0, \quad \frac{\partial \mu_{1}}{\partial s_{2}}\left(s_{1}, s_{2}\right)<0$. The growth rate of species $x_{1}$ increases with the substrate $s_{1}$ but is inhibited by the production of $s_{2}$.
(H6) For all $s_{2}>0, \mu_{2}^{\prime}\left(s_{2}\right)>0$. The growth rate of species $x_{2}$ increases with substrate $s_{2}$.
(H7) The function $s_{2} \mapsto \mu_{0}\left(+\infty, s_{2}\right)$ is monotonically increasing and the function $s_{2} \mapsto \mu_{1}\left(+\infty, s_{2}\right)$ is monotonically decreasing. The maximum growth rate of the species $x_{0}$ and $x_{1}$ increases and decreases, respectively, with the concentration of substrate $s_{2}$.

First, we show that the solutions of model (2) are nonnegative and bounded, which is a prerequisite for any reasonable model of the chemostat.

Proposition 1. For any nonnegative initial conditions, all solutions of system (2) remain nonnegative and are bounded for all $t \geqslant 0$. Moreover, the set

is positively invariant and a global attractor for (2).
A steady state exists (or is said to be 'meaningful') if and only if all its components are nonnegative. This predicts eight possible steady states, labeled below as in [31]:

- SS1 $\left(x_{0}=0, x_{1}=0, x_{2}=0\right)$ : the washout of all three microbial populations.
- SS2 $\left(x_{0}=0, x_{1}=0, x_{2}>0\right)$ : only the hydrogen degraders are maintained.
- SS3 $\left(x_{0}>0, x_{1}=0, x_{2}=0\right)$ : only the chlorophenol degraders are maintained.
- SS4 $\left(x_{0}>0, x_{1}>0, x_{2}=0\right)$ : only the hydrogen degraders are washed out.
- SS5 $\left(x_{0}>0, x_{1}=0, x_{2}>0\right)$ : only the phenol degraders are washed out.
- SS6 $\left(x_{0}>0, x_{1}>0, x_{2}>0\right)$ : all three microbial populations are present.
- SS7 $\left(x_{0}=0, x_{1}>0, x_{2}=0\right)$ : only the phenol degraders are present.
- SS8 $\left(x_{0}=0, x_{1}>0, x_{2}>0\right)$ : only the chlorophenol degraders are washed out.

To determine these steady states, we need to define some auxiliary functions that are listed in Table 1. The existence and definition domains of these functions are all relatively straightforward and can be found as in [25]. Following [25], we add a hypothesis on the function $\Psi$ which then assures that there are at most two steady
states of the form SS4.
(H8) When $\omega<1$, the function $\Psi$ has a unique minimum $\bar{s}_{2}=\bar{s}_{2}(D)$ on the interval $\left(s_{2}^{0}, s_{2}^{1}\right)$, such that $\frac{\partial \Psi}{\partial s_{2}}\left(s_{2}, D\right)<0$ on $\left(s_{2}^{0}, \bar{s}_{2}\right)$ and $\frac{\partial \Psi}{\partial s_{2}}\left(s_{2}, D\right)>0$ on $\left(\bar{s}_{2}, s_{2}^{1}\right)$.
As we will show in Section 4, this hypothesis (H8) is fulfilled with the specific growth rates (9). Now, we can state our main result.

Theorem 1. Assume that Hypotheses (H1) to (H6) hold. The steady states SS1, SS2,..., SS8, of (2) are given in Table 2. Assume also that Hypothesis (H7) holds. The necessary and sufficient conditions of existence of the steady states are given in Table 3. When they exist, all steady states (except SS4) are unique.

- If $\omega \geqslant 1$, when it exists, SS4 4 is unique.
- If $\omega<1$, assuming also that (H8) holds, the system has generically two steady states of the form SS4.

Remark 1. If $\omega<1$, equation $\Psi\left(s_{2}, D\right)=(1-\omega) s_{0}^{\text {in }}+s_{1}^{\text {in }}+s_{2}^{\text {in }}$ has two solutions $s_{2}^{* 1}$ and $s_{2}^{* 2}$ if and only if $(1-\omega) s_{0}^{\text {in }}+s_{1}^{\text {in }}+s_{2}^{\text {in }}>\phi_{1}(D)$, so that $\frac{\partial \Psi}{\partial s_{2}}\left(s_{2}^{* 1}, D\right)<0$ and $\frac{\partial \Psi}{\partial s_{2}}\left(s_{2}^{* 2}, D\right)>0$ (see Fig. 1). We denote by $\mathrm{SS} 4^{1}$ and $\mathrm{SS} 4^{2}$ the steady states of type SS4 corresponding to $s_{2}^{* 1}$ and $s_{2}^{* 2}$, respectively. These steady states coalesce when $(1-\omega) s_{0}^{\text {in }}+s_{1}^{\text {in }}+s_{2}^{\text {in }}=\phi_{1}(D)$.

In the particular cases, where $s_{1}^{\text {in }}=0$ or $s_{2}^{\text {in }}=0$, some of the steady states described in Theorem 1 do not exist and the existence conditions of the existing steady states can be simplified. More precisely, we have the following result.

Proposition 2. If $s_{1}^{\text {in }}=0$ then, $S S 7$ and SS8 do not exist. If $s_{2}^{\text {in }}=0, S S 2, S S 3$ and SS5 do not exist. If $s_{1}^{\text {in }}=s_{2}^{\text {in }}=0$, we have:

- The steady states SS2, SS3, SS5, SS7 and SS8 do not exist.
- If $\omega \geqslant 1, S S 4$ and SS6 do not exist. If $\omega<1$, SS4 and SS6 exist, respectively, if and only if

Remark 2. Assume that $s_{1}^{\text {in }}=s_{2}^{\text {in }}=0$. Then, only the steady states SS1, SS4 and SS6 can exist. The existence conditions (3) of SS4 and SS6, respectively, are equivalent to the following conditions given in Lemmas 3 and 4 of [25]:

Hence, we recover the results of [25] where the study is restricted to the case $s_{1}^{\text {in }}=$ $s_{2}^{\text {in }}=0$. Notice that, in [25], the steady states SS1, SS4 and SS6 were labeled SS1, SS2 and SS3, respectively.
3. Study of the model without maintenance. In this section, we determine the existence and stability conditions of steady states of model (2) in the particular case without maintenance. For convenience, we shall use the abbreviation LES for Locally Exponentially Stable. We define the function $\phi_{4}$ by

Theorem 2. Assume that Hypotheses (H1) to (H8) hold. Without maintenance, the steady states and their existence conditions of (2) are given in Tables 2 and 3 by putting $a_{0}=a_{1}=a_{2}=0$. In addition, the necessary and sufficient conditions of local exponential stability of the steady states are given in Table 4.

Remark 3. If $\omega \geqslant 1$, when SS4 exists, its stability condition $\frac{\partial \Psi}{\partial s_{2}}\left(s_{2}, D\right)>0$ is always satisfied (see Lemma 3). If $\omega<1$, when $\mathrm{SS}^{1}$ exists, it is unstable (see Remark 1). When $\mathrm{SS} 4^{2}$ exists, its stability condition $\frac{\partial \Psi}{\partial s_{2}}\left(s_{2}, D\right)>0$ is always satisfied.
4. Application to a chlorophenol-mineralising three-tiered microbial 'food web'. The aim of this section is to illustrate the theoretical results of this paper in the case of the chlorophenol-mineralising three-tiered microbial model (1) considered in [31] where the specific growth rates take the form:

The biological parameter values are provided in Table 10. They were previously used in [25, 31]. Following [25], model (1) can be rescaled to obtain model (2) using the following change of variables:

For the specific growth functions (9), various functions defined in Table 1 are listed in Table 11. From the expression of $\Psi$ in Table 11, a straightforward calculation shows that, for all $s_{2} \in\left(s_{2}^{0}, s_{2}^{1}\right)$,

which is positive since $\omega<1$ and $m_{0}>D+a_{0}$. Thus, the function $s_{2} \mapsto \Psi\left(s_{2}, D\right)$ is convex and fulfills (H8) (see Figure 1). Furthermore, model (1) is of the form (2) where the growth functions (9) satisfy Hypotheses (H1) to (H8). Consequently, the results of our paper apply to model (1).

Using the steady states in Table 2 and the auxiliary functions given in Table 11 in the case of specific growth functions (9), a straightforward computation shows that all components of the steady states of model (2) are the same as those in [31] where another rescaling model and change of variables are used. However, the existence conditions in Table 3 of SS3, SS4 and SS7 were not established in [31] (see Appendix C.3, C. 4 and C.7) where they were checked only numerically, by considering the roots of polynomials of degree 2 or 3 (see formulas (C.3), (C.11) and (C.49)), respectively. All other existence conditions were established in [31]. Hence, our analytical study of model (2) permits to give rigorous proofs for (1).

In what follows, we consider the input concentrations $S_{\mathrm{ph}}^{\mathrm{in}}=0$ and $S_{\mathrm{H}_{2}}^{\mathrm{in}}=2.67 \times$ $10^{-5}$, corresponding to Fig. 3(a) in [31] when $D=0.01$ and $k_{\mathrm{dec}, \mathrm{ch}}=k_{\mathrm{dec}, \mathrm{ph}}=$ $k_{\mathrm{dec}, \mathrm{H}_{2}}=0$. As a consequence of Theorem 2, we obtain the following result which
determines the existence and the stability of the steady states of (1) with respect to the input concentration $S_{\mathrm{ch}}^{\mathrm{in}}$.
Proposition 3. Assume that the biological parameters in (1) are given as in Table 10. Assume that $S_{\mathrm{ph}}^{\mathrm{in}}=0, S_{\mathrm{H}_{2}}^{\mathrm{in}}=2.67 \times 10^{-5}, D=0.01$ and $k_{\mathrm{dec}, \mathrm{ch}}=k_{\mathrm{dec}, \mathrm{ph}}=$ $k_{\mathrm{dec}, \mathrm{H}_{2}}=0$. Let $\sigma_{i}, i=1, \ldots, 6$ be the bifurcation values defined in Table 5. The existence and stability of steady states of (1), with respect to the input concentration $S_{\mathrm{ch}}^{\mathrm{in}}$ is given in Table 6. The nature of the bifurcations when $S_{\mathrm{ch}}^{\mathrm{in}}$ crosses the values $\sigma_{i}, i=1, \ldots, 6$ is given in Table 7.

Figs. 2 and 3 depict the bifurcation diagram of system (1) where $X_{\text {ch }}$ is represented as a function of the bifurcation parameter $S_{\mathrm{ch}}^{\mathrm{in}}$. Figs. 2(b) and 3 show magnifications of the bifurcation diagram showing the transcritical bifurcations occurring at $\sigma_{1}, \sigma_{3}, \sigma_{4}$ and $\sigma_{5}$, the saddle-node bifurcation occurring at $\sigma_{2}$, the Hopf
bifurcation occurring at $\sigma_{6}$, and the disappearance of the cycle occurring at $\sigma^{*}$. In Fig. 2(b), the steady states SS1 and SS2 cannot be distinguished since they have both a zero $X_{\mathrm{ch}}$-component. Since for $S_{\mathrm{ch}}^{\mathrm{in}}<\sigma_{3}$, SS2 is LES and SS1 is unstable, the $X_{\mathrm{ch}}=0$ axis is plotted in blue, which is the color for SS2 in Table 8.

Numerical simulations have shown that there exists a critical value $\sigma^{*} \in\left(\sigma_{5}, \sigma_{6}\right)$, which corresponds to the value of $S_{\mathrm{ch}}^{\mathrm{in}}$, where the stable limit cycle that appears for $S_{\mathrm{ch}}^{\mathrm{in}}=\sigma_{6}$ through a supercritical Hopf bifurcation, disappears when $S_{\mathrm{ch}}^{\mathrm{in}}$ is decreasing. In [28], a numerical study of the bifurcation diagram with respect to the parameter $D$ is given in the case without maintenance and $s_{1}^{\text {in }}=s_{2}^{\text {in }}=0$. Fig. 6 in [28] shows that the disappearance of the stable limit cycle occurs through a saddlenode bifurcation with another unstable limit cycle. We conjecture that in our case

also the stable limit cycle disappears by a confluence with an unstable limit cycle at $S_{\mathrm{ch}}^{\mathrm{in}}=\sigma^{*}$.

When $S_{\mathrm{ch}}^{\mathrm{in}} \in\left(\sigma^{*}, \sigma_{6}\right)$, the system exhibits a bi-stability with convergence either to SS3 or to a stable limit cycle according to the initial condition. Fig. 4 illustrates the three-dimensional space where the trajectories in yellow and blue converge toward the stable limit cycle in red, while the green trajectory converges toward the steady state SS3. Fig. 5 illustrates the time courses of the yellow and blue trajectories in Fig. 4 proving that the oscillations are maintained with a positive periodic solution. Concerning the green trajectory, the period and the amplitude of oscillations are slightly increased until their destruction over time so that the solution converges to SS3. Finally, when $S_{\mathrm{ch}}^{\mathrm{in}}>\sigma_{6}$, the system exhibits also a bi-stability which becomes between SS3 and SS6.
5. Conclusion. In this work, we have extended model (1) of a chlorophenolmineralising three-tiered microbial 'food web' presented in [31], by considering the model (2) with general growth functions. Our first aim was the theoretical analysis of (2) by providing the existence conditions of all steady states with respect to the
operating parameters. Our study considers the effects of the phenol and hydrogen input concentrations, which were neglected in the analytical analysis given in [25], together with the effects of maintenance terms, which were neglected in the theoretical analysis given in [13, 28]. System (2) can have up to eight types of steady states: the washout steady state which always exists, a coexistence steady state of all degrader populations and six other steady states corresponding to the extinction of one or two degrader populations. Each type of steady state is unique except that of the exclusion only of the hydrogen degraders (SS4) where there are at most two steady states of this type.

In [31], results on the existence of some steady states of model (1) were obtained only numerically without knowing their exact number. Our analytical results on the existence of the steady states of (2) give rigorous proofs for (1).

Our second achievement was to determine theoretically the asymptotic behavior of system (2) in the particular case without maintenance and to analyze numerically the bifurcation diagram by varying the chlorophenol input concentration when $s_{1}^{\text {in }}=$ 0 . It shows that the system exhibits a bi-stability where the coexistence steady state can destabilize undergoing a supercritical Hopf bifurcation with the occurrence of a stable periodic solution. These interest phenomena have been already depicted in [25], in the particular case $s_{0}^{\text {in }}>0, s_{1}^{\text {in }}=s_{2}^{\text {in }}=0$. The possibility of the Hopf bifurcation of the positive steady state is analytically proved in [28], in the case without maintenance. The destabilization of the positive steady state was not detected by the numerical analysis of the operating diagram in [31].

Our works under investigation will focus on the analysis of the stability of steady states of (2) including maintenance and on the operating diagrams which were obtained numerically in [31]. In fact, the operating diagram is very useful for the biologist as discussed in [3, 9, 10] because it allows to predict qualitatively the different asymptotic behaviors of the process according to their control parameters.

## Appendix A. Proofs.

Proof of Proposition 1. Since the vector field defined by (2) is $\mathcal{C}^{1}$, the uniqueness of solution to initial value problems holds. From (2), for $i=0,1,2$,

Indeed, for example, consider the case of $s_{0}$ where $D$ and $s_{0}^{\text {in }}$ are positive with $s_{0}(0) \geqslant 0$. Assume that it exists $\tau>0$ such that $s_{0}(\tau)=0$ and $s_{0}(t)>0$ for all $t \in(0, \tau)$. Thus, the solutions of (2) are positively bounded and are defined for all $t \geqslant 0$. From (11), it can be deduced that the set $\Omega$ is positively invariant and from (10), it is a global attractor for (2).

To determine the number of SS3, SS4 and SS7-type steady states and the conditions of their existence, we need the following result.

Lemma 3. The equation $\psi_{i}\left(s_{0}\right)=y, i=0,1$, has a solution in the interval $J_{i}$ defined in Table 1 if and only if $\mu_{i}\left(s_{i}^{\mathrm{in}}, s_{2}^{\mathrm{in}}\right)>y$. - For SS5, $x_{0}>0, x_{2}>0$ and $x_{1}=0$. Using (21) together with $x_{1}=0$ in (25) results in

Using (21) and this expression in (23) results in

x_{0}=\frac{D}{D+a_{0}}\left(s_{0}^{\mathrm{in}}-s_{0}\right) \quad \text { and } \quad x_{2}=\frac{D}{D+a_{2}}\left(s_{2}^{\mathrm{in}}-s_{2}-\omega\left(s_{0}^{\mathrm{in}}-s_{0}\right)\right)
$$

Since $x_{0}>0$ and $x_{2}>0$, (14) and (16) result in $\mu_{0}\left(s_{0}, s_{2}\right)=D+a_{0}$ and $\mu_{2}\left(s_{2}\right)=D+a_{2}$. Using definitions of $M_{0}, M_{2}$ and $\varphi_{0}$ in Table 1, it follows that

s_{2}=M_{2}\left(D+a_{2}\right) \quad \text { and } \quad s_{0}=\varphi_{0}(D)
$$

SS5 exists if and only if its components $x_{0}, x_{2}$ and $s_{1}$ are positive. This condition is equivalent to $s_{0}^{\text {in }}>\varphi_{0}(D)$ and $s_{2}^{\text {in }}-\omega s_{0}^{\text {in }}>M_{2}\left(D+a_{2}\right)-\omega \varphi_{0}(D)$.

- For SS6, $x_{0}>0, x_{1}>0$ and $x_{2}>0$. Then, as a consequence of (14), (15) and (16), we obtain:

Using definitions of $M_{0}, M_{1}, M_{2}, \varphi_{0}$ and $\varphi_{1}$ in Table 1, it follows that $s_{2}, s_{0}$ and $s_{1}$ are given by:

(21), (22) and (23) give the $x$-components of SS6 in Table 2. SS6 exists if and only if its $x$-components are positive, that is, $s_{0}^{\mathrm{in}}>s_{0}, s_{1}^{\text {in }}+s_{0}^{\mathrm{in}}>s_{0}+s_{1}$ and $(1-\omega) s_{0}^{\mathrm{in}}+s_{1}^{\mathrm{in}}+s_{2}^{\mathrm{in}}>(1-\omega) s_{0}+s_{1}+s_{2}$. Using the $s$-components of SS6, these conditions are the same as those in Table 3.

- For SS7, $x_{0}=x_{2}=0$ and $x_{1}>0$. Hence, (24) results in $s_{0}=s_{0}^{\mathrm{in}}$. From (22), we have

where $\psi_{1}$ is defined in Table 1. SS7 exists if and only if equation (35) has a positive solution and the $s_{2}$ and $x_{1}$-components of SS 7 are positive. This last condition is equivalent to $0<s_{1}<s_{1}^{\text {in }}$, that is, (35) must have a solution in the interval $J_{1}$. Using Lemma 3, there exists a solution $s_{1} \in J_{1}$, satisfying (35), if and only if $\mu_{1}\left(s_{1}^{\mathrm{in}}, s_{2}^{\mathrm{in}}\right)>D+a_{1}$. If it exists, this solution is unique.

- For SS8, $x_{0}=0, x_{1}>0$ and $x_{2}>0$. Hence, (24) results in $s_{0}=s_{0}^{\mathrm{in}}$. Using this expression in (22) and (23) results in

Since $x_{1}>0$ and $x_{2}>0$, as a consequence of (15) and (16), we have $\mu_{1}\left(s_{1}, s_{2}\right)=$ $D+a_{1}$ and $\mu_{2}\left(s_{2}\right)=D+a_{2}$. Using definitions of $M_{1}, M_{2}$ and $\varphi_{1}(D)$ in Table 1, it follows that $s_{2}$ and $s_{1}$ are given by:

SS8 exists if and only if its components $x_{1}$ and $x_{2}$ are positive, that is, $s_{1}^{\text {in }}>s_{1}$ and $s_{1}^{\text {in }}+s_{2}^{\text {in }}>s_{1}+s_{2}$. Using the $s$-components of SS8, these conditions are the same as those in Table 3.

Proof of Proposition 2. If $s_{1}^{\text {in }}=0$, then $\mu_{1}\left(s_{1}^{\text {in }}, s_{2}^{\text {in }}\right)=0$, so that the conditions $\mu_{1}\left(s_{1}^{\text {in }}, s_{2}^{\text {in }}\right)>D+a_{1}$ and $s_{1}^{\text {in }}>\varphi_{1}(D)$ of existence of SS7 and SS8, respectively, cannot be satisfied. Therefore, SS7 and SS8 do not exist. If $s_{2}^{\text {in }}=0$, then $\mu_{2}\left(s_{2}^{\text {in }}\right)=0$ and $\mu_{0}\left(s_{0}^{\text {in }}, s_{2}^{\text {in }}\right)=0$, so that the existence conditions $\mu_{2}\left(s_{2}^{\text {in }}\right)>D+a_{2}$, $\mu_{0}\left(s_{0}^{\mathrm{in}}, s_{2}^{\mathrm{in}}\right)>D+a_{0}$ of SS2 and SS3 cannot be satisfied, respectively. Moreover, the second existence condition of SS5 implies that

Assume that $s_{1}^{\text {in }}=s_{2}^{\text {in }}=0$. If $\omega=1$, the first existence condition of SS4 in Table 3 is written $0 \geqslant \phi_{1}(D)$. This condition cannot be satisfied, since $\phi_{1}(D)=$ $\Psi\left(s_{2}^{0}, D\right)>0$ from Lemma 3. Thus, SS4 does not exist if $\omega=1$. When $\omega>1$, we have $s_{2}$ is solution of equation

Regarding the steady state SS 6 in the particular case $s_{1}^{\mathrm{in}}=s_{2}^{\mathrm{in}}=0$, the first existence condition in Table 3 becomes

Proof of Theorem 2. In the particular case without maintenance, the steady states and their existence conditions are easily obtained from Tables 2 and 3 by putting $a_{i}=0, i=0,1,2$. To analyze the local stability, we use the change of variables:

The steady states $\mathrm{SS} 1, \mathrm{SS} 2, \ldots, \mathrm{SS} 8$ of (38) now take the form $\left(x_{0}, x_{1}, x_{2}, s_{0}^{\mathrm{in}}, s_{1}^{\mathrm{in}}, s_{2}^{\mathrm{in}}\right)$ where the $x_{0}$-components of each steady state are given by those in Table 2 with $a_{i}=0$. The Jacobian matrix of (38) has an upper block triangular form:

\mu_{0}-D-(E+\omega F) x_{0} & F x_{0} & -F x_{0} \\
(G+\omega H) x_{1} & \mu_{1}-D-(G+H) x_{1} & H x_{1} \\
-\omega I x_{2} & I x_{2} & \mu_{2}-D-I x_{2}
\end{array}\right], \tag{39}
\end{gather*}

and $\mathbf{J}_{\mathbf{3}}$ is the $3 \times 3$ diagonal matrix whose diagonal elements are all $-D$. Consequently, three eigenvalues of $\mathbf{J}$ are given by $-D$ and the three other eigenvalues are given by those of the $3 \times 3$ upper-left matrix $\mathbf{J}_{\mathbf{1}}$. Thus, the stability of the steady state is determined by the sign of the real parts of the eigenvalues of $\mathbf{J}_{\mathbf{1}}$. Note that, the functions $E, F, G, H$ and $I$ defined by (5) are evaluated at the steady state. We have used the opposite sign of the partial derivative $H=-\partial \mu_{1} / \partial s_{2}$, such that all constants involved in the computation become positive.

- For SS1, the characteristic polynomial of $\mathbf{J}_{\mathbf{1}}$ is $P_{1}(\lambda)=\left(\lambda-\lambda_{1}\right)\left(\lambda-\lambda_{2}\right)\left(\lambda-\lambda_{3}\right)$, where

\lambda_{1}=\mu_{0}\left(s_{0}^{\mathrm{in}}, s_{2}^{\mathrm{in}}\right)-D, \quad \lambda_{2}=\mu_{1}\left(s_{1}^{\mathrm{in}}, s_{2}^{\mathrm{in}}\right)-D, \quad \lambda_{3}=\mu_{2}\left(s_{2}^{\mathrm{in}}\right)-D
$$

Therefore, SS1 is LES if and only if $\lambda_{1}<0, \lambda_{2}<0$ and $\lambda_{3}<0$, that is, the stability conditions of SS1 in Table 4 hold.

- For SS2, the characteristic polynomial of $\mathbf{J}_{\mathbf{1}}$ is $P_{2}(\lambda)=\left(\lambda-\lambda_{1}\right)\left(\lambda-\lambda_{2}\right)\left(\lambda-\lambda_{3}\right)$, where

As $\lambda_{3}<0$, SS2 is LES if and only if $\lambda_{1}<0$ and $\lambda_{2}<0$. Since $M_{0}$ and $M_{1}$ are increasing, these conditions are equivalent to the stability conditions of SS2 in Table 4.

- For SS3, the characteristic polynomial of $\mathbf{J}_{\mathbf{1}}$ is $P_{3}(\lambda)=\left(\lambda-\lambda_{1}\right)\left(\lambda-\lambda_{2}\right)\left(\lambda-\lambda_{3}\right)$, where
$\lambda_{1}=\mu_{1}\left(s_{1}^{\text {in }}+s_{0}^{\text {in }}-s_{0}, s_{2}^{\text {in }}-\omega\left(s_{0}^{\text {in }}-s_{0}\right)\right)-D, \quad \lambda_{2}=\mu_{2}\left(s_{2}^{\text {in }}-\omega\left(s_{0}^{\text {in }}-s_{0}\right)\right)-D$,
and $\lambda_{3}=-(E+\omega F) x_{0}$, where $s_{0}$ is the solution in the interval $J_{0}$ of equation $\psi_{0}\left(s_{0}\right)=D$. As $\lambda_{3}<0$, SS3 is LES if and only if $\lambda_{1}<0$ and $\lambda_{2}<0$. The condition $\lambda_{1}<0$ is the first stability condition of SS3 in Table 4. Since $M_{2}$ is increasing, the condition $\lambda_{2}<0$ is equivalent to

- For SS4, the characteristic polynomial of $\mathbf{J}_{\mathbf{1}}$ is $P_{4}(\lambda)=\left(\lambda-\lambda_{1}\right)\left(\lambda^{2}+c_{1} \lambda+c_{2}\right)$, where
$\lambda_{1}=\mu_{2}\left(s_{2}\right)-D, c_{1}=(E+\omega F) x_{0}+(G+H) x_{1}, c_{2}=(E(G+H)+(\omega-1) F G) x_{0} x_{1}$,
and $s_{2}$ is defined by (33). We always have $c_{1}>0$. Using (5) and (13), we obtain

Since E and G are positive, condition $c_{2}>0$ is equivalent to $\frac{\partial \Psi}{\partial s_{2}}\left(s_{2}, D\right)>0$. As $\mu_{2}$ is increasing, SS4 is LES if and only if

Indeed, when $\omega \geqslant 1$, the mapping $s_{2} \mapsto \Psi\left(s_{2}, D\right)$ is increasing for all $s_{2} \in\left(s_{2}^{0}, s_{2}^{1}\right)$ (see Lemma 3). Hence, the condition $s_{2}<M_{2}(D)$ is equivalent to

Moreover, the mapping $s_{2} \mapsto \Psi\left(s_{2}, D\right)$ is increasing for all $s_{2} \in\left(\bar{s}_{2}, s_{2}^{1}\right)$. Thus, the condition $s_{2}^{* 2}<M_{2}(D)$ implies the first and the second conditions of (42). Inversely, if the first condition of (42) or equivalently (43) holds, then

and $c_{2}=E I x_{0} x_{2}$. As $c_{1}>0$ and $c_{2}>0$, SS5 is LES if and only if $\lambda_{1}<0$. Since $M_{1}$ is increasing, this stability condition of SS5 is equivalent to that in Table 4.

- For SS6, the characteristic polynomial of $\mathbf{J}_{\mathbf{1}}$ is $P_{6}(\lambda)=\lambda^{3}+c_{1} \lambda^{2}+c_{2} \lambda+c_{3}$, where

From (41), one has $E(G+H)+(\omega-1) F G=E G \phi_{3}(D)$. Since $c_{1}$ and $c_{3}$ are positive, according to the Routh-Hurwitz criterion, SS6 is LES if and only if

$\lambda_{1}=\mu_{0}\left(s_{0}^{\text {in }}, s_{2}^{\text {in }}+s_{1}^{\text {in }}-s_{1}\right)-D, \lambda_{2}=\mu_{2}\left(s_{2}^{\text {in }}+s_{1}^{\text {in }}-s_{1}\right)-D, \lambda_{3}=-(G+H) x_{1}$, where $s_{1}$ is the solution in the interval $J_{1}$ of equation $\psi_{1}\left(s_{1}\right)=D$. Since $\lambda_{3}<0$, SS7 is LES if and only if $\lambda_{1}<0$ and $\lambda_{2}<0$. Since the functions $M_{2}$ and $M_{3}$ are increasing, the conditions $\lambda_{1}<0$ and $\lambda_{2}<0$ are equivalent to

Since the function $\psi_{1}$ is increasing and $\psi_{1}\left(s_{1}\right)=D$, (45) is equivalent to

\mu_{1}\left(s_{2}^{\mathrm{in}}+s_{1}^{\mathrm{in}}-M_{3}\left(s_{0}^{\mathrm{in}}, D\right), M_{3}\left(s_{0}^{\mathrm{in}}, D\right)\right)<D, \mu_{1}\left(s_{2}^{\mathrm{in}}+s_{1}^{\mathrm{in}}-M_{2}(D), M_{2}(D)\right)<D .
$$

Since $M_{1}$ is increasing, these stability conditions of SS7 are equivalent to those in Table 4.

- For SS8, the characteristic polynomial of $\mathbf{J}_{\mathbf{1}}$ is $P_{8}(\lambda)=\left(\lambda-\lambda_{1}\right)\left(\lambda^{2}+c_{1} \lambda+c_{2}\right)$, where

$$
\lambda_{1}=\mu_{0}\left(s_{0}^{\mathrm{in}}, M_{2}(D)\right)-D, \quad c_{1}=(G+H) x_{1}+I x_{2}, \quad c_{2}=G I x_{1} x_{2}
$$

As $c_{1}$ and $c_{2}$ are positive, SS8 is LES if and only if $\lambda_{1}<0$. Since $M_{0}$ is increasing, this stability condition of SS8 is equivalent to that in Table 4.

Proof of Proposition 3. Using the change of variables (8) and from Tables 3 and 4, the necessary and sufficient conditions of existence and stability of steady states of (1) are summarized in Table 9 when $S_{\mathrm{ph}}^{\mathrm{in}}=0$ and $k_{\mathrm{dec}, \mathrm{ch}}=k_{\mathrm{dec}, \mathrm{ph}}=k_{\mathrm{dec}, \mathrm{H}_{2}}=0$. Since $s_{1}^{\mathrm{in}}=0$, SS7 and SS8 do not exist, as shown in Proposition 2. Using Table 9, we see that:

Table 9. Existence and local stability conditions of steady states of (1), when $S_{\mathrm{ph}}^{\mathrm{in}}=0$ and $k_{\mathrm{dec}, \mathrm{ch}}=k_{\mathrm{dec}, \mathrm{ph}}=k_{\mathrm{dec}, \mathrm{H}_{2}}=0$. All functions are given in Tables 1 and 11, while $\phi_{4}$ and $\mu_{i}$ are given by (4) and (9).

- SS1 always exists and is unstable, since the second stability condition in Table 9 does not hold, as

$$
\begin{equation*}
\mu_{2}\left(S_{\mathrm{H}_{2}}^{\mathrm{in}}\right) \simeq 1.0845>D=0.01 \tag{46}
\end{equation*}
$$

- SS2 exists, since the existence condition in Table 9 holds from (46). It is LES if and only if

$$
S_{\mathrm{ch}}^{\mathrm{in}}<\varphi_{0}(D) / Y=: \sigma_{3}
$$

- SS3 exists if and only if $\mu_{0}\left(Y S_{\mathrm{ch}}^{\mathrm{in}}, S_{\mathrm{H}_{2}}^{\mathrm{in}}\right)>D$, which is equivalent to

$$
S_{\mathrm{ch}}^{\mathrm{in}}>\left(M_{0}\left(D, S_{\mathrm{H}_{2}}^{\mathrm{in}}\right)\right) / Y=: \sigma_{1}
$$

For $S_{\mathrm{ch}}^{\mathrm{in}}=\sigma_{1}$, there is a transcritical bifurcation of SS 3 and SS 1 , which have the same components at $\sigma_{1}$ (see Table 2). Consider the function $y=F\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)$ defined by:

$$
\begin{equation*}
F\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)=\mu_{1}\left(Y S_{\mathrm{ch}}^{\mathrm{in}}-s_{0}, S_{\mathrm{H}_{2}}^{\mathrm{in}}+\omega\left(Y S_{\mathrm{ch}}^{\mathrm{in}}-s_{0}\right)\right) \tag{47}
\end{equation*}
$$

where $s_{0}$ depends also on $S_{\mathrm{ch}}^{\mathrm{in}}$. The first stability condition of SS3 in Table 9 is written $F\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)<D$. Fig. 6 shows that this condition holds for all $S_{\mathrm{ch}}^{\mathrm{in}}>\sigma_{1}$, since the maximum of the function $F$ is smaller than 0.0013 and $D=0.01$. From the second stability condition, SS3 is LES if and only if

$$
S_{\mathrm{ch}}^{\mathrm{in}}>\frac{S_{\mathrm{H}_{2}}^{\mathrm{in}}-M_{2}(D)+\omega \varphi_{0}(D)}{\omega Y}=: \sigma_{4} .
$$

- Recall that $\omega \simeq 0.53<1$ for the set of parameters given in Table 10. Therefore, equation $\Psi\left(s_{2}, D\right)=(1-\omega) Y S_{\mathrm{ch}}^{\mathrm{in}}+S_{\mathrm{H}_{2}}^{\mathrm{in}}$ admits two solutions $s_{2}^{* 1}$ and $s_{2}^{* 2}$ which correspond to two steady states $\mathrm{SS} 4^{1}$ and $\mathrm{SS} 4^{2}$, respectively. When it exists, $\mathrm{SS}^{1}{ }^{1}$ is unstable, as stated in Remark 3. From Table 9, the first existence condition of these steady states holds if and only if

$$
S_{\mathrm{ch}}^{\mathrm{in}} \geq \frac{\phi_{1}(D)-S_{\mathrm{H}_{2}}^{\mathrm{in}}}{(1-\omega) Y}=: \sigma_{2} .
$$

Fig. 7 shows that the second existence condition of $\mathrm{SS} 4^{1}$ and $\mathrm{SS}_{4}{ }^{2}$ in Table 9 holds, for all $S_{\mathrm{ch}}^{\mathrm{in}} \in\left[\sigma_{2}, 0.05\right]$, since the straight line of equation $y=Y S_{\mathrm{ch}}^{\mathrm{in}}$ is above the curves of the functions $y=M_{0}\left(D, s_{2}^{* i}\right)+M_{1}\left(D, s_{2}^{* i}\right)$, for $i=1,2$, respectively. $\mathrm{SS} 4^{2}$ is unstable, since the third stability condition does not hold as $\phi_{3}(D) \simeq-6513<0$. Therefore, $\mathrm{SS} 4^{1}$ and $\mathrm{SS} 4^{2}$ exist and are unstable for all $S_{\mathrm{ch}}^{\mathrm{in}} \geq \sigma_{2}$. They disappear for $S_{\mathrm{ch}}^{\mathrm{in}}<\sigma_{2}$. For $S_{\mathrm{ch}}^{\mathrm{in}}=\sigma_{2}$ there is a saddle-node bifurcation. For $S_{\mathrm{ch}}^{\mathrm{in}}=\sigma_{5}$ there is a transcritical bifurcation of SS4 ${ }^{1}$ and SS6.

- From Table 9, SS5 exists if and only if

$$
\sigma_{3}:=\frac{\varphi_{0}(D)}{Y}<S_{\mathrm{ch}}^{\mathrm{in}}<\frac{S_{\mathrm{H}_{2}}^{\mathrm{in}}-M_{2}(D)+\omega \varphi_{0}(D)}{\omega Y}=: \sigma_{4} .
$$

For $S_{\mathrm{ch}}^{\mathrm{in}}=\sigma_{3}$, there is a transcritical bifurcation of SS 5 and SS 2 . For $S_{\mathrm{ch}}^{\mathrm{in}}=\sigma_{4}$, there is a transcritical bifurcation of SS5 and SS3. When it exists, SS5 is LES since

$$
S_{\mathrm{ch}}^{\mathrm{in}}<\sigma_{4} \simeq 0.011191<\frac{\varphi_{0}(D)+\varphi_{1}(D)}{Y} \simeq 0.013717
$$

- From Table 9, SS6 exists if and only if

$$
S_{\mathrm{ch}}^{\mathrm{in}}>\frac{\phi_{2}(D)-S_{\mathrm{H}_{2}}^{\mathrm{in}}}{(1-\omega) Y}=: \sigma_{5} \simeq 0.016575, \quad S_{\mathrm{ch}}^{\mathrm{in}}>\frac{\varphi_{0}(D)+\varphi_{1}(D)}{Y} \simeq 0.013717 .
$$

Then, SS6 exists if and only if $S_{\mathrm{ch}}^{\mathrm{in}}>\sigma_{5}$. For the stability of SS6, we have $\phi_{3}(D)<0$ and we plot the functions $\phi_{4}$ with respect to $S_{\mathrm{ch}}^{\mathrm{in}}$. Fig. 8 shows that the equation $\phi_{4}\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)=0$ has a unique solution $\sigma_{6} \simeq 0.029877$ such that $\phi_{4}\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)<0$ for all $\sigma_{5}<S_{\mathrm{ch}}^{\mathrm{in}}<\sigma_{6}$ and $\phi_{4}\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)>0$ for all $S_{\mathrm{ch}}^{\mathrm{in}}>\sigma_{6}$.

To give a numerical evidence of the Hopf bifurcation occurring through the positive steady state SS 6 as $S_{\mathrm{ch}}^{\mathrm{in}}$ varies, we determine the eigenvalues of the matrix $\mathbf{J}_{\mathbf{1}}$ defined by (39) and evaluated at this steady state. Fig. 9(a) shows that one eigenvalue $\lambda_{1}\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)$ remains negative for all $S_{\mathrm{ch}}^{\mathrm{in}} \in\left(\sigma_{5}, 0.05\right]$. Fig. 9(b) shows that the two other eigenvalues are real and distinct for all $S_{\mathrm{ch}}^{\mathrm{in}} \in\left(\sigma_{5}, \sigma^{\star}\right)$ and we denote them by $\lambda_{2}\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)$ and $\lambda_{3}\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)$, then they become a complex-conjugate pair for all $S_{\mathrm{ch}}^{\mathrm{in}} \in\left(\sigma^{\star}, 0.05\right)$ and we denote them by

$$
\lambda_{2,3}\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)=\alpha\left(S_{\mathrm{ch}}^{\mathrm{in}}\right) \pm i \beta\left(S_{\mathrm{ch}}^{\mathrm{in}}\right)
$$

which becomes purely imaginary for the particular value $S_{\mathrm{ch}}^{\mathrm{in}}=\sigma_{6}$ such that $\alpha\left(\sigma_{6}\right)=0$, with $\beta\left(\sigma_{6}\right) \neq 0$. Moreover, one has

$$
\frac{d \alpha}{d S_{\mathrm{ch}}^{\mathrm{in}}}\left(\sigma_{6}\right)<0
$$

Therefore, SS6 changes its stability through a supercritical Hopf bifurcation with the emergence of a stable limit cycle that we illustrate in Fig. 4.
