# A BRAID-LIKE PRESENTATION OF THE INTEGRAL STEINBERG GROUP OF TYPE $C_{2}$

#### Abstract

We show that the Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ associated with the Lie type $C_{2}$ and with integer coefficients can be realized as a quotient of the braid group $B_{6}$ by one relation. As an application we give a new braid-like presentation of the symplectic modular group $\mathrm{Sp}_{4}(\mathbb{Z})$.

## 1. Introduction

Let $B_{6}$ be the braid group on six strands. It has a standard presentation with five generators $\sigma_{1}, \sigma_{2}, \sigma_{3}, \sigma_{4}, \sigma_{5}$, and the following ten relations $(1 \leq$ $i, j \leq 5)$ :

\end{equation*}

and

\sigma_{i} \sigma_{j} \sigma_{i}=\sigma_{j} \sigma_{i} \sigma_{j} \quad \text { if }|i-j|=1 \tag{1.2}
\end{equation*}
$$

The purpose of this note is to show that if we add the single relation

\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)=1 \tag{1.3}
\end{equation*}
$$

to Relations (1.1) and (1.2), we obtain a presentation of the Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ associated with the Lie type $C_{2}$ over the ring of integers (see Theorem 4.1). This group was defined for general commutative rings in [15].

If we further add the relation

\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{4}=1 \tag{1.4}
\end{equation*}
$$

we obtain a presentation of the symplectic modular group $\mathrm{Sp}_{4}(\mathbb{Z})$ (see Corollary 4.2). It is known that the Steinberg group $\mathrm{St}\left(C_{2}, \mathbb{Z}\right)$ is a group extension of $\mathrm{Sp}_{4}(\mathbb{Z})$ with infinite cyclic kernel.

In order to prove these results we construct a surjective group homomorphism $f: B_{6} \rightarrow \operatorname{St}\left(C_{2}, \mathbb{Z}\right)$, show that $f$ vanishes on the normal subgroup $N$ of $B_{6}$ generated by the element represented by the braid word in (1.3), and construct a group homomorphism $\varphi: \operatorname{St}\left(C_{2}, \mathbb{Z}\right) \rightarrow B_{6} / N$ such that $\varphi \circ f=\mathrm{id}$. The homomorphism $f$ is a lifting of a map $B_{6} \rightarrow \mathrm{Sp}_{4}(\mathbb{Z})$, which is a special case of the homomorphism $\bar{f}: B_{2 g+2} \rightarrow \mathrm{Sp}_{2 g}(\mathbb{Z})$ constructed in [12, Sect. 4$]$ for any $g \geq 1$.

[^0]The note is organized as follows. In Section 2 we give a presentation of the Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ and we prove a number of relations between special elements of $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$. In Section 3 we construct the homomorphism $f$ from the braid group to the Steinberg group. In Section 4 we state and prove our results. In Appendix A we give a presentation of the Steinberg group $\operatorname{St}\left(C_{2}, R\right)$ with coefficients in an arbitrary commutative ring $R$.

Notation. All the groups we consider are noted multiplicatively. We denote their identity elements by 1 and we use brackets for the commutators:

Recall that $[y, x]=[x, y]^{-1}$.

## 2. The Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$

The positive roots of the root system $C_{2}$ consist of four vectors $\alpha, \beta$, $\alpha+\beta$ and $2 \alpha+\beta$ of the Euclidean plane $\mathbb{R}^{2}$, where the roots $\alpha$ and $\alpha+\beta$ are of length $\sqrt{2}$, the roots $\beta$ and $2 \alpha+\beta$ are of length 2 , and $\alpha$ is orthogonal to $\alpha+\beta$. Together with $-\alpha,-\beta,-(\alpha+\beta)$ and $-(2 \alpha+\beta)$, they form the root system $\Phi$ of type $C_{2}$ (see e.g. $[6,7]$ ).
2.1. Defining relations for the Steinberg group. We have the following presentation for the Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ of type $C_{2}$ over the ring $\mathbb{Z}$ of integers.

Proposition 2.1. The Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ has a presentation with eight generators

x_{\alpha}, x_{\beta}, x_{\alpha+\beta}, x_{2 \alpha+\beta}, x_{-\alpha}, x_{-\beta}, x_{-(\alpha+\beta)}, x_{-(2 \alpha+\beta)}
$$

and the following 24 relations:

Note that in view of Relations (2.10), (2.11) and (2.14) the generators $x_{\alpha}$, $x_{-\alpha}$ and $x_{-(\alpha+\beta)}$ can be expressed in terms of the five remaining generators $x_{\beta}, x_{\alpha+\beta}, x_{2 \alpha+\beta}, x_{-\beta}, x_{-(2 \alpha+\beta)}$.

Proposition 2.1 will be proved in Section 2.3 below.
2.2. The surjection $\pi: \operatorname{St}\left(C_{2}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{4}(\mathbb{Z})$. Recall that the symplectic modular group $\mathrm{Sp}_{4}(\mathbb{Z})$ is the group of automorphisms of the free abelian rank 4 group $\mathbb{Z}^{4}$ preserving the standard alternating form, namely the group of $4 \times 4$-matrices $M$ with integer entries such that

-I_{2} & 0
\end{array}\right)

where $M^{T}$ is the transpose of $M$ and $I_{2}$ is the identity $2 \times 2$-matrix.
It is known that the group $\mathrm{Sp}_{4}(\mathbb{Z})$ is generated by the following eight matrices (see [1] or [11]):

X_{\alpha+\beta} & =\left(\begin{array}{llll}

0 & 1 & 1 & 0 \\
0 & 0 & 1 & 0 \\
0 & 0 & 0 & 1
\end{array}\right), \quad X_{-(\alpha+\beta)}=\left(\begin{array}{llll}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 \\
0 & 1 & 1 & 0 \\
1 & 0 & 0 & 1
\end{array}\right) \\
X_{2 \alpha+\beta} & =\left(\begin{array}{llll}
1 & 0 & 1 & 0 \\
0 & 1 & 0 & 0 \\
0 & 0 & 1 & 0 \\
0 & 0 & 0 & 1
\end{array}\right), \quad X_{-(2 \alpha+\beta)}=\left(\begin{array}{llll}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & 0 \\
1 & 0 & 1 & 0 \\
0 & 0 & 0 & 1
\end{array}\right) \tag{2.19}
\end{array}
$$

Observe that each matrix $X_{-\gamma}(\gamma \in \Phi)$ is the transpose of $X_{\gamma}$.
It is easy to check that the matrices $X_{\gamma}(\gamma \in \Phi)$ satisfy the relations (2.1)(2.15) defining the Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$. Therefore there exists a unique homomorphism

$$
\begin{equation*}
\pi: \operatorname{St}\left(C_{2}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{4}(\mathbb{Z}) \tag{2.20}
\end{equation*}
$$

such that $\pi\left(x_{\gamma}\right)=X_{\gamma}$ for all $\gamma \in \Phi$. Since the matrices $X_{\gamma}(\gamma \in \Phi)$ generate $\mathrm{Sp}_{4}(\mathbb{Z})$, the homomorphism $\pi$ is surjective.
2.3. Proof of Proposition 2.1. By [2, Sect. 3] the Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ has a presentation with the set of generators $\left\{x_{\gamma}: \gamma \in \Phi\right\}$ subject to the following relations: if $\gamma, \delta \in \Phi$ such that $\gamma+\delta \neq 0$, then

\begin{equation*}
\left[x_{\gamma}, x_{\delta}\right]=\prod x_{i \gamma+j \delta}^{c_{i, j}^{\gamma, \delta}}, \tag{2.21}
\end{equation*}
$$

where $i$ and $j$ are positive integers such that $i \gamma+j \delta$ belongs to $\Phi$ and the exponents $c_{i, j}^{\gamma, \delta}$ are integers depending only on the structure of $\operatorname{Sp}_{4}(\mathbb{Z})$. In order to find the structure constants $c_{i, j}^{\gamma, \delta}$ it is enough to apply the homomorphism $\pi$ of (2.20) and to compute the integers $c_{i, j}^{\gamma, \delta}$ appearing in the relations

$$
\left[X_{\gamma}, X_{\delta}\right]=\prod X_{i \gamma+j \delta}^{c_{i, j}^{\gamma, \delta}}
$$

where $X_{\gamma}=\pi\left(x_{\gamma}\right)$ are the elements of $\mathrm{Sp}_{4}(\mathbb{Z})$ defined by (2.16)-(2.19).
In particular, when $X_{\gamma} X_{\delta}=X_{\delta} X_{\gamma}(\gamma, \delta \in \Phi)$, then $x_{\gamma} x_{\delta}=x_{\delta} x_{\gamma}$. Relations (2.1)-(2.3) follow from this remark. We next have the following equalities in $\mathrm{Sp}_{4}(\mathbb{Z})$ :

{\left[X_{\alpha}, X_{\beta}\right]=X_{\alpha+\beta} X_{2 \alpha+\beta}, \quad\left[X_{\alpha}, X_{\alpha+\beta}\right]=X_{2 \alpha+\beta}^{2}} \\
{\left[X_{\alpha}, X_{-(\alpha+\beta)}\right]=X_{-\beta}^{-2}, \quad\left[X_{\alpha}, X_{-(2 \alpha+\beta)}\right]=X_{-\beta} X_{-(\alpha+\beta)}^{-1}} \\
{\left[X_{\beta}, X_{-(\alpha+\beta)}\right]=X_{-\alpha} X_{-(2 \alpha+\beta)}, \quad\left[X_{\alpha+\beta}, X_{-\alpha}\right]=X_{\beta}^{-2}} \\
{\left[X_{\alpha+\beta}, X_{-\beta}\right]=X_{\alpha} X_{2 \alpha+\beta}^{-1}, \quad\left[X_{\alpha+\beta}, X_{-(2 \alpha+\beta)}\right]=X_{-\alpha} X_{\beta}^{-1}} \\
{\left[X_{2 \alpha+\beta}, X_{-\alpha}\right]=X_{\alpha+\beta}^{-1} X_{\beta}^{-1}, \quad\left[X_{2 \alpha+\beta}, X_{-(\alpha+\beta)}\right]=X_{\alpha} X_{-\beta}} \\
{\left[X_{-\alpha}, X_{-\beta}\right]=X_{-(\alpha+\beta)}^{-1} X_{-(2 \alpha+\beta)}, \quad\left[X_{-\alpha}, X_{-(\alpha+\beta)}\right]=X_{-(2 \alpha+\beta)}^{-2}}
\end{gathered}

From these relations the remaining relations of Proposition 2.1 follow.
2.4. The elements $w_{\gamma}$. For any root $\gamma \in \Phi$, set

w_{\gamma}=x_{\gamma} x_{-\gamma}^{-1} x_{\gamma} \tag{2.22}
\end{equation*}
$$

In Steinberg's notation (see $[16,17]$ ), we have $x_{\gamma}=x_{\gamma}(1)$ and $w_{\gamma}=w_{\gamma}(1)$.
In the sequel we need to know that the kernel of $\pi: \operatorname{St}\left(C_{2}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{4}(\mathbb{Z})$ is generated by $w_{\gamma}^{4}$ for any long root $\gamma$, for instance by $w_{\beta}^{4}$ or by $w_{2 \alpha+\beta}^{4}$; this follows from [2, Kor. 3.2]. The fact that such a generator of the kernel is of infinite order was established in [14, Th. 6.3].

We now list a few properties of the elements $w_{\gamma}$.
Lemma 2.2. We have $w_{\gamma}=w_{-\gamma}^{-1}$ for all $\gamma \in \Phi$.
Proof. By [16] (see also [14, Lemme 5.2 (g)]) we have

w_{\gamma} & =w_{\gamma}(1)=w_{-\gamma}(-1) \\
& =x_{-\gamma}(-1) x_{\gamma}(1) x_{-\gamma}(-1)=x_{-\gamma}^{-1} x_{\gamma} x_{-\gamma}^{-1} \\
& =\left(x_{-\gamma} x_{\gamma}^{-1} x_{-\gamma}\right)^{-1}=w_{-\gamma}^{-1}
\end{aligned}
$$

which was to be proved.

Lemma 2.3. We have

$$
\begin{array}{cc}
w_{\beta} x_{\alpha} w_{\beta}^{-1}=x_{\alpha+\beta}^{-1}, & w_{\beta} x_{-\alpha} w_{\beta}^{-1}=x_{-(\alpha+\beta)}^{-1} \\
w_{\beta} x_{\alpha+\beta} w_{\beta}^{-1}=x_{\alpha}, & w_{\beta} x_{-(\alpha+\beta)} w_{\beta}^{-1}=x_{-\alpha} \\
w_{\beta} x_{2 \alpha+\beta} w_{\beta}^{-1}=x_{2 \alpha+\beta}, & w_{\beta} x_{-(2 \alpha+\beta)} w_{\beta}^{-1}=x_{-(2 \alpha+\beta)} \\
w_{2 \alpha+\beta} x_{\beta} w_{2 \alpha+\beta}^{-1}=x_{\beta}, & w_{2 \alpha+\beta} x_{-\beta} w_{2 \alpha+\beta}^{-1}=x_{-\beta} \\
w_{2 \alpha+\beta} x_{\alpha} w_{2 \alpha+\beta}^{-1}=x_{-(\alpha+\beta)}^{-1}, & w_{2 \alpha+\beta} x_{-(\alpha+\beta)} w_{2 \alpha+\beta}^{-1}=x_{\alpha} \\
w_{2 \alpha+\beta} x_{\alpha+\beta} w_{2 \alpha+\beta}^{-1}=x_{-\alpha}, & w_{2 \alpha+\beta} x_{-\alpha} w_{2 \alpha+\beta}^{-1}=x_{\alpha+\beta}^{-1} \\
w_{\alpha} x_{\beta} w_{\alpha}^{-1}=x_{2 \alpha+\beta}, & w_{\alpha} x_{-\beta} w_{\alpha}^{-1}=x_{-(2 \alpha+\beta)} \\
w_{\alpha} x_{\alpha+\beta} w_{\alpha}^{-1}=x_{\alpha+\beta}^{-1}, & w_{\alpha} x_{-(\alpha+\beta)} w_{\alpha}^{-1}=x_{-(\alpha+\beta)}^{-1} \\
w_{\alpha} x_{2 \alpha+\beta} w_{\alpha}^{-1}=x_{\beta}, & w_{\alpha} x_{-(2 \alpha+\beta)} w_{\alpha}^{-1}=x_{-\beta} \\
w_{\alpha+\beta} x_{\alpha} w_{\alpha+\beta}^{-1}=x_{\alpha}^{-1}, & w_{\alpha+\beta} x_{-\alpha} w_{\alpha+\beta}^{-1}=x_{-\alpha}^{-1} \\
w_{\alpha+\beta} x_{\beta} w_{\alpha+\beta}^{-1}=x_{-(2 \alpha+\beta)}^{-1}, & w_{\alpha+\beta} x_{-(2 \alpha+\beta)} w_{\alpha+\beta}^{-1}=x_{\beta}^{-1} \\
w_{\alpha+\beta} x_{2 \alpha+\beta} w_{\alpha+\beta}^{-1}=x_{-\beta}^{-1}, & w_{\alpha+\beta} x_{-\beta} w_{\alpha+\beta}^{-1}=x_{2 \alpha+\beta}^{-1}
\end{array}
$$

Proof. By Relation (R7) in [17, Chap.3, p. 23], for any two roots $\gamma$ and $\delta$ such that $\gamma+\delta \neq 0$ we have $w_{\gamma} x_{\delta} w_{\gamma}^{-1}=x_{\delta^{\prime}}^{\varepsilon}$, where $\delta^{\prime}$ is the image of $\delta$ under the reflection in the line orthogonal to $\gamma$ and $\varepsilon= \pm 1$. To determine the root $\delta^{\prime}$ and the sign $\varepsilon$ it is enough to compute the image $\pi\left(w_{\gamma} x_{\delta} w_{\gamma}^{-1}\right)$ in $\mathrm{Sp}_{4}(\mathbb{Z})$.

## 3. From the braid group to the Steinberg group

We now construct a homomorphism from the braid group $B_{6}$ to the Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$.

Proposition 3.1. There exists a unique homomorphism $f: B_{6} \rightarrow \operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ such that

\begin{gathered}
f\left(\sigma_{1}\right)=x_{2 \alpha+\beta}, \quad f\left(\sigma_{2}\right)=x_{-(2 \alpha+\beta)}^{-1}, \\
f\left(\sigma_{3}\right)=x_{\beta} x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta}, \\
f\left(\sigma_{4}\right)=x_{-\beta}^{-1}, \quad f\left(\sigma_{5}\right)=x_{\beta} .
\end{gathered}
$$

The homomorphism $f$ is surjective.
The homomorphism $f$ lifts the homomorphism $\bar{f}: B_{6} \rightarrow \mathrm{Sp}_{4}(\mathbb{Z})$ constructed in $[12$, Sect. 4.2] in the sense that $\bar{f}=\pi \circ f$, where $\pi$ is the natural surjection $\operatorname{St}\left(C_{2}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{4}(\mathbb{Z})$ defined in (2.20).
Proof. For the existence and the uniqueness of $f$ it suffices to check that the five elements $f\left(\sigma_{i}\right)(1 \leq i \leq 5)$ of the Steinberg $\operatorname{group} \operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ satisfy the braid relations (1.1) and (1.2).
(i) Let us first check the commutation relations (1.1).

- Commutation of $f\left(\sigma_{1}\right)$ with $f\left(\sigma_{3}\right), f\left(\sigma_{4}\right)$ and $f\left(\sigma_{5}\right)$. This follows from the fact that $x_{2 \alpha+\beta}$ commutes with $x_{\beta}$ and $x_{\alpha+\beta}$ by (2.1), and with $x_{-\beta}$ by (2.2).
- Commutation of $f\left(\sigma_{2}\right)$ with $f\left(\sigma_{4}\right)$ and $f\left(\sigma_{5}\right)$. It follows from (2.2) and (2.3).
- Commutation of $f\left(\sigma_{3}\right)$ with $f\left(\sigma_{5}\right)$. It follows from (2.1).
(ii) The relation $f\left(\sigma_{1}\right) f\left(\sigma_{2}\right) f\left(\sigma_{1}\right)=f\left(\sigma_{2}\right) f\left(\sigma_{1}\right) f\left(\sigma_{2}\right)$ reads as

$$
x_{2 \alpha+\beta} x_{-(2 \alpha+\beta)}^{-1} x_{2 \alpha+\beta}=x_{-(2 \alpha+\beta)}^{-1} x_{2 \alpha+\beta} x_{-(2 \alpha+\beta)}^{-1},
$$

which is equivalent to $w_{2 \alpha+\beta}=w_{-(2 \alpha+\beta)}^{-1}$. The latter holds by Lemma 2.2.
(iii) The relation $f\left(\sigma_{2}\right) f\left(\sigma_{3}\right) f\left(\sigma_{2}\right)=f\left(\sigma_{3}\right) f\left(\sigma_{2}\right) f\left(\sigma_{3}\right)$ reads as

$$
x_{-(2 \alpha+\beta)}^{-1} x_{\beta} x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta} x_{-(2 \alpha+\beta)}^{-1}=x_{\beta} x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta} x_{-(2 \alpha+\beta)}^{-1} x_{\beta} x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta} .
$$

Let LHS (resp. RHS) be the element of $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ represented by the lefthand (resp. right-hand) side of the previous equation. By (2.1), (2.2), (2.3), (2.11), (2.22) we obtain

$$
\begin{aligned}
\mathrm{LHS} & =x_{\beta} \underbrace{x_{-(2 \alpha+\beta)}^{-1} x_{\alpha+\beta}^{-1}} x_{-(2 \alpha+\beta)} w_{-(2 \alpha+\beta)}^{-1} \\
& =x_{\beta} x_{\alpha+\beta}^{-1} \underbrace{x_{-(2 \alpha+\beta)}^{-1} x_{-\alpha}^{-1} x_{\beta} x_{-(2 \alpha+\beta)}} w_{-(2 \alpha+\beta)}^{-1} \\
& =\underbrace{x_{\beta} x_{\alpha+\beta}^{-1} x_{-\alpha}^{-1} x_{\beta}} w_{-(2 \alpha+\beta)}^{-1} \\
& =x_{\beta}^{2} x_{\alpha+\beta}^{-1} x_{-\alpha}^{-1} w_{-(2 \alpha+\beta)}^{-1}
\end{aligned}
$$

(The above underbraces $\underbrace{\text { mark the places to which we apply the relations }}$ we refer to.)

Let us now deal with RHS. Since by (2.1) and (2.2) $x_{\beta}$ commutes with $x_{\alpha+\beta}$ and with $x_{ \pm(2 \alpha+\beta)}$, and $x_{\alpha+\beta}$ commutes with $x_{2 \alpha+\beta}$, we obtain

$$
\text { RHS }=x_{\beta}^{2} x_{\alpha+\beta}^{-1} w_{2 \alpha+\beta} x_{\alpha+\beta}^{-1} .
$$

Now by Lemma 2.3, we have $w_{2 \alpha+\beta} x_{\alpha+\beta}^{-1}=x_{-\alpha}^{-1} w_{2 \alpha+\beta}$. Therefore,

$$
\mathrm{RHS}=x_{\beta}^{2} x_{\alpha+\beta}^{-1} x_{-\alpha}^{-1} w_{2 \alpha+\beta}
$$

It follows that LHS $=$ RHS is equivalent to $w_{-(2 \alpha+\beta)}^{-1}=w_{2 \alpha+\beta}$, which again holds by Lemma 2.2.
(iv) The relation $f\left(\sigma_{3}\right) f\left(\sigma_{4}\right) f\left(\sigma_{3}\right)=f\left(\sigma_{4}\right) f\left(\sigma_{3}\right) f\left(\sigma_{4}\right)$ reads as

$$
x_{\beta} x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta} x_{-\beta}^{-1} x_{\beta} x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta}=x_{-\beta}^{-1} x_{\beta} x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta} x_{-\beta}^{-1}
$$

Let LHS ${ }^{\prime}$ (resp. RHS ${ }^{\prime}$ ) be the element of $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ represented by the lefthand (resp. right-hand) side of the previous equation. Since by (2.1) and (2.2) $x_{2 \alpha+\beta}$ commutes with $x_{\alpha}$, with $x_{\alpha+\beta}$ and with $x_{ \pm \beta}$, hence with $w_{\beta}$, and $x_{\beta}$ commutes with $x_{\alpha+\beta}$, we obtain

$$
\text { LHS }^{\prime}=x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta}^{2} w_{\beta} x_{\alpha+\beta}^{-1}=x_{\alpha+\beta}^{-1} x_{2 \alpha+\beta}^{2} x_{\alpha}^{-1} w_{\beta}=x_{\alpha+\beta}^{-1} x_{\alpha}^{-1} x_{2 \alpha+\beta}^{2} w_{\beta},
$$

the second equality holding by Lemma 2.3. For $\mathrm{RHS}^{\prime}$, by Lemma 2.2 we have

$$
\mathrm{RHS}^{\prime}=w_{\beta} x_{-\beta} x_{\alpha+\beta}^{-1} x_{-\beta}^{-1} x_{2 \alpha+\beta} .
$$

Now by (2.10), we have $x_{-\beta} x_{\alpha+\beta}^{-1} x_{-\beta}^{-1}=x_{\alpha+\beta}^{-1} x_{\alpha} x_{2 \alpha+\beta}^{-1}$. Therefore,

$$
\operatorname{RHS}^{\prime}=w_{\beta} x_{\alpha+\beta}^{-1} x_{\alpha} .
$$

It follows from Lemma 2.3 that $w_{\beta} x_{\alpha+\beta}^{-1}=x_{\alpha}^{-1} w_{\beta}$ and $w_{\beta} x_{\alpha}=x_{\alpha+\beta}^{-1} w_{\beta}$. Moreover by (2.5) we have $x_{\alpha}^{-1} x_{\alpha+\beta}^{-1}=x_{\alpha+\beta}^{-1} x_{\alpha}^{-1} x_{2 \alpha+\beta}^{2}$. Therefore,

$$
\mathrm{RHS}^{\prime}=x_{\alpha}^{-1} w_{\beta} x_{\alpha}=x_{\alpha}^{-1} x_{\alpha+\beta}^{-1} w_{\beta}=x_{\alpha+\beta}^{-1} x_{\alpha}^{-1} x_{2 \alpha+\beta}^{2} w_{\beta}=\text { LHS }^{\prime} .
$$

(v) The relation $f\left(\sigma_{4}\right) f\left(\sigma_{5}\right) f\left(\sigma_{4}\right)=f\left(\sigma_{4}\right) f\left(\sigma_{5}\right) f\left(\sigma_{4}\right)$ reads as

$$
x_{-\beta}^{-1} x_{\beta} x_{-\beta}^{-1}=x_{\beta} x_{-\beta}^{-1} x_{\beta},
$$

which is equivalent to $w_{-\beta}^{-1}=w_{\beta}$. The last equality holds by Lemma 2.2.
As we noted after stating Proposition 2.1, the five elements $x_{\beta}, x_{\alpha+\beta}$, $x_{2 \alpha+\beta}, x_{-\beta}, x_{-(2 \alpha+\beta)}$ generate $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$. They clearly are in the image of $f$, which implies the surjectivity of the latter.

## 4. Results

Let $f: B_{6} \rightarrow \mathrm{St}\left(C_{2}, \mathbb{Z}\right)$ be the surjective homomorphism defined in Proposition 3.1. We now state our main result.

Theorem 4.1. The kernel of the homomorphism $f: B_{6} \rightarrow \operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ is the normal subgroup of $B_{6}$ generated by

$$
\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right) .
$$

This means that the Steinberg group $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ has a presentation with five generators $\sigma_{1}, \sigma_{2}, \sigma_{3}, \sigma_{4}, \sigma_{5}$, and eleven relations consisting of the ten braid relations (1.1)-(1.2) and the additional relation

$$
\begin{equation*}
\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}=\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)^{-1} . \tag{4.1}
\end{equation*}
$$

This relation is clearly equivalent to (1.3).
As mentioned at the beginning of Section 2.4, the kernel of the projection $\pi: \operatorname{St}\left(C_{2}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{4}(\mathbb{Z})$ is generated by $w_{2 \alpha+\beta}^{4}$. Since

$$
\begin{equation*}
w_{2 \alpha+\beta}=x_{2 \alpha+\beta} x_{-(2 \alpha+\beta)}^{-1} x_{2 \alpha+\beta}=f\left(\sigma_{1} \sigma_{2} \sigma_{1}\right), \tag{4.2}
\end{equation*}
$$

we deduce the following presentation ${ }^{1}$ of $\mathrm{Sp}_{4}(\mathbb{Z})$.
Corollary 4.2. The symplectic modular group $\mathrm{Sp}_{4}(\mathbb{Z})$ has a presentation with five generators $\sigma_{1}, \sigma_{2}, \sigma_{3}, \sigma_{4}, \sigma_{5}$, and twelve relations consisting of Relations (1.1)-(1.2) and the two relations

$$
\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}=\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)^{-1}
$$

and

$$
\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{4}=1
$$

Let $N$ be the normal subgroup of $B_{6}$ generated by

$$
\beta=\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right) .
$$

Theorem 4.1 is a consequence of the following two propositions.
Proposition 4.3. We have $f(N)=1$.

[^1]Proof. It suffices to check that $f(\beta)=1$. By (4.2) we have $f\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)=$ $w_{2 \alpha+\beta}$. We also have

$$
f\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)=x_{2 \alpha+\beta}\left(x_{2 \alpha+\beta}^{-1} x_{\alpha+\beta} x_{\beta}^{-1}\right) x_{\beta}=x_{\alpha+\beta}
$$

Therefore, using Lemma 2.3, we obtain

$$
f(\beta)=w_{2 \alpha+\beta}^{2} x_{\alpha+\beta} w_{2 \alpha+\beta}^{-2} x_{\alpha+\beta}=w_{2 \alpha+\beta} x_{-\alpha} w_{2 \alpha+\beta}^{-1} x_{\alpha+\beta}=x_{\alpha+\beta}^{-1} x_{\alpha+\beta}=1
$$

It follows from the previous proposition that $f: B_{6} \rightarrow \operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ factors through a homomorphism $B_{6} / N \rightarrow \operatorname{St}\left(C_{2}, \mathbb{Z}\right)$, which we still denote by $f$.

Proposition 4.4. There exists a homomorphism $\varphi: \operatorname{St}\left(C_{2}, \mathbb{Z}\right) \rightarrow B_{6} / N$ such that

$$
\begin{aligned}
\varphi\left(x_{\alpha}\right) & =\left(\sigma_{5} \sigma_{4}\right)\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{5} \sigma_{4}\right)^{-1} \\
\varphi\left(x_{\beta}\right) & =\sigma_{5} \\
\varphi\left(x_{\alpha+\beta}\right) & =\sigma_{1} \sigma_{3}^{-1} \sigma_{5} \\
\varphi\left(x_{2 \alpha+\beta}\right) & =\sigma_{1} \\
\varphi\left(x_{-\alpha}\right) & =\left(\sigma_{1} \sigma_{2}\right)\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2}\right)^{-1} \\
\varphi\left(x_{-\beta}\right) & =\sigma_{4}^{-1} \\
\varphi\left(x_{-(\alpha+\beta)}\right) & =\left(\sigma_{1} \sigma_{2} \sigma_{5} \sigma_{4}\right)\left(\sigma_{1}^{-1} \sigma_{3} \sigma_{5}^{-1}\right)\left(\sigma_{1} \sigma_{2} \sigma_{5} \sigma_{4}\right)^{-1} \\
\varphi\left(x_{-(2 \alpha+\beta)}\right) & =\sigma_{2}^{-1}
\end{aligned}
$$

modulo $N$. Moreover, $\varphi \circ f=\mathrm{id}$.
Before we prove Proposition 4.4, let us record the following four equalities in the braid group $B_{6}$. One may check them using one's favorite algorithm for solving the word problem in braid groups (see for instance the monographs $[5,8,9,10,13])$.

Lemma 4.5. The following equalities hold in $B_{6}$ :

$$
\begin{aligned}
& {\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{\beta}\right)\right]^{-1} \varphi\left(x_{\alpha+\beta}\right) \varphi\left(x_{2 \alpha+\beta}\right)} \\
& \quad=\left(\sigma_{4} \sigma_{5} \sigma_{4}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{4} \sigma_{5} \sigma_{4}\right)^{-2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right) \\
& {\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{\alpha+\beta}\right)\right]^{-1} \varphi\left(x_{2 \alpha+\beta}^{2}\right)}
\end{aligned}=\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{4} \sigma_{5} \sigma_{4}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{4} \sigma_{5} \sigma_{4}\right)^{-2}, ~ \begin{aligned}
& {\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{-(\alpha+\beta)}\right)\right] \varphi\left(x_{-\beta}^{2}\right) } \\
&==\left(\sigma_{5} \sigma_{4} \sigma_{1} \sigma_{2}\right)\left(\sigma_{1} \sigma_{2} \sigma_{3}\right) \gamma^{-1}\left(\sigma_{1} \sigma_{2} \sigma_{3}\right)^{-1}\left(\sigma_{5} \sigma_{4} \sigma_{1} \sigma_{2}\right)^{-1}
\end{aligned}
$$

where $\gamma=\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}$, and

$$
\left[\varphi\left(x_{\alpha+\beta}\right), \varphi\left(x_{-\alpha}\right)\right] \varphi\left(x_{\beta}^{2}\right)=\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}
$$

We make also the following observation. Let

$$
\Delta=\left(\sigma_{1} \sigma_{2} \sigma_{3} \sigma_{4} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{3} \sigma_{4}\right)\left(\sigma_{1} \sigma_{2} \sigma_{3}\right)\left(\sigma_{1} \sigma_{2}\right) \sigma_{1}
$$

be the 'half-twist' in the braid group $B_{6}$. It has the following important property (see for instance [5] or [13, Sect.1.3.3]):

$$
\begin{equation*}
\Delta \sigma_{i} \Delta^{-1}=\sigma_{6-i}, \quad(i=1, \ldots, 5) \tag{4.3}
\end{equation*}
$$

which implies that its square $\Delta^{2}$ is central (actually $\Delta^{2}$ generates the center of the braid group). Note that the braids $\sigma_{1} \sigma_{5}, \sigma_{2} \sigma_{4}$ and $\sigma_{3}$ are invariant under conjugation by $\Delta$ so that

$$
\Delta\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right) \Delta^{-1}=\sigma_{5} \sigma_{3}^{-1} \sigma_{1}=\sigma_{1} \sigma_{3}^{-1} \sigma_{5}
$$

whereas $\sigma_{1} \sigma_{2} \sigma_{1}$ and $\sigma_{4} \sigma_{5} \sigma_{4}$ are interchanged:

$$
\begin{equation*}
\Delta\left(\sigma_{1} \sigma_{2} \sigma_{1}\right) \Delta^{-1}=\sigma_{5} \sigma_{4} \sigma_{5}=\sigma_{4} \sigma_{5} \sigma_{4} \tag{4.4}
\end{equation*}
$$

In view of (4.3) and of the definition of $\varphi$ we have the following "symmetries":

$$
\begin{gather*}
\Delta \varphi\left(x_{\beta}\right) \Delta^{-1}=\varphi\left(x_{2 \alpha+\beta}\right)  \tag{4.5}\\
\Delta \varphi\left(x_{-\beta}\right) \Delta^{-1}=\varphi\left(x_{-(2 \alpha+\beta)}\right)  \tag{4.6}\\
\Delta \varphi\left(x_{\alpha}\right) \Delta^{-1}=\varphi\left(x_{-\alpha}\right)  \tag{4.7}\\
\Delta \varphi\left(x_{ \pm(\alpha+\beta)}\right) \Delta^{-1}=\varphi\left(x_{ \pm(\alpha+\beta)}\right) \tag{4.8}
\end{gather*}
$$

Geometrically speaking, conjugating the elements $\varphi\left(x_{\gamma}\right)(\gamma \in \Phi)$ by $\Delta$ corresponds in the root system $C_{2}$ to the reflection in the one-dimensional vector space spanned by $\alpha+\beta$.

Remark 4.6. It follows from [4, Th. 0.2] that the centralizer of $\Delta$ is an Artin group of type $C_{3}$. Actually it is generated by the above-mentioned elements $\beta_{1}=\sigma_{1} \sigma_{5}, \beta_{2}=\sigma_{2} \sigma_{4}$ and $\beta_{3}=\sigma_{3}$, which satisfy the relations

$$
\beta_{1} \beta_{2} \beta_{1}=\beta_{2} \beta_{1} \beta_{2}, \quad \beta_{1} \beta_{3}=\beta_{3} \beta_{1}, \quad \beta_{2} \beta_{3} \beta_{2} \beta_{3}=\beta_{3} \beta_{2} \beta_{3} \beta_{2}
$$

Proof of Proposition 4.4. To prove the existence of $\varphi: \operatorname{St}\left(C_{2}, \mathbb{Z}\right) \rightarrow B_{6} / N$ it suffices to check that the elements $\varphi\left(x_{\gamma}\right)(\gamma \in \Phi)$ satisfy the 24 relations (2.1)-(2.15) in the quotient group $B_{6} / N$.
(a) Relations (2.1): in view of the braid relations (1.1), we have

$$
\begin{gathered}
{\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{2 \alpha+\beta}\right)\right]=\left[\left(\sigma_{5} \sigma_{4}\right)\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{5} \sigma_{4}\right)^{-1}, \sigma_{1}\right]=1} \\
{\left[\varphi\left(x_{\beta}\right), \varphi\left(x_{\alpha+\beta}\right)\right]=\left[\sigma_{5}, \sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right]=1} \\
{\left[\varphi\left(x_{\beta}\right), \varphi\left(x_{2 \alpha+\beta}\right)\right]=\left[\sigma_{5}, \sigma_{1}\right]=1} \\
{\left[\varphi\left(x_{\alpha+\beta}\right), \varphi\left(x_{2 \alpha+\beta}\right)\right]=\left[\sigma_{1} \sigma_{3}^{-1} \sigma_{5}, \sigma_{1}\right]=1}
\end{gathered}
$$

(b) Relations (2.2): again in view of the commutation relations (1.1), but also of the braid relations (1.2), we have

$$
\begin{aligned}
{\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{-\beta}\right)\right] } & =\left[\left(\sigma_{5} \sigma_{4}\right)\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{5} \sigma_{4}\right)^{-1}, \sigma_{4}^{-1}\right] \\

& =\sigma_{5} \sigma_{4}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right) \underbrace{\sigma_{5}^{-1} \underbrace{\sigma_{4}^{-1} \sigma_{5}^{-1} \sigma_{5} \sigma_{4}}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)^{-1} \sigma_{5} \sigma_{4}^{-1} \sigma_{5}^{-1}} \\
& =\sigma_{5} \sigma_{4}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)^{-1} \sigma_{4}^{-1} \sigma_{5}^{-1}=1
\end{aligned}

(Here and below the underbraces indicate the places where we apply the braid relations and the trivial relations $\sigma_{i} \sigma_{i}^{-1}=\sigma_{i}^{-1} \sigma_{i}=1$.)

Similarly, by (1.1) we have

Note that only $\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{-\beta}\right)\right]=1$ requires one of the braid relations (1.2).
(c) Relations (2.3): for the first one, using (4.6) and (4.7), we have

& =\left(\sigma_{1} \sigma_{2}\right)\left[\varphi\left(x_{-\beta}\right), \varphi\left(x_{\alpha}\right)^{-1}\right]\left(\sigma_{1} \sigma_{2}\right)^{-1}
\end{aligned}
$$

Since $\varphi\left(x_{-\beta}\right)$ commutes with $\varphi\left(x_{\alpha}\right)$ by Item (b), it commutes with its inverse $\varphi\left(x_{\alpha}\right)^{-1}$. Hence, $\left[\varphi\left(x_{-\beta}\right), \varphi\left(x_{-(\alpha+\beta)}\right]=\left(\sigma_{1} \sigma_{2}\right)\left(\sigma_{1} \sigma_{2}\right)^{-1}=1\right.$.

For the third one, we have $\left[\varphi\left(x_{-\beta}\right), \varphi\left(x_{-(2 \alpha+\beta)}\right)\right]=\left[\sigma_{4}^{-1}, \sigma_{2}^{-1}\right]=1$ by (1.1).
For the fourth one, conjugating by $\Delta$, and using (4.6) and (4.8), we reduce the desired equality $\left[\varphi\left(x_{-(\alpha+\beta)}\right), \varphi\left(x_{-(2 \alpha+\beta)}\right)\right]=1$ to the previous equality $\left[\varphi\left(x_{-\beta}\right), \varphi\left(x_{-(\alpha+\beta)}\right]=1\right.$.

\end{aligned}

It follows that $\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{\beta}\right)\right]^{-1} \varphi\left(x_{\alpha+\beta}\right) \varphi\left(x_{2 \alpha+\beta}\right)$ belongs to the normal subgroup $N$, hence is trivial in $B_{6} / N$.
(e) Relation (2.5): we use the second equality in Lemma 4.5 and argue as in Item (d). It follows that $\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{\alpha+\beta}\right)\right]^{-1} \varphi\left(x_{2 \alpha+\beta}^{2}\right)$ is trivial in $B_{6} / N$.
(f) Relation (2.6): consider the third equality in Lemma 4.5; the braid $\gamma$ is trivial in $B_{6} / N$; hence, so is $\left[\varphi\left(x_{\alpha}\right), \varphi\left(x_{-(\alpha+\beta)}\right)\right] \varphi\left(x_{-\beta}^{2}\right)$.
(g) Relation (2.7): we have

which in view of Item (d) above implies that $\left[\varphi\left(x_{2 \alpha+\beta}\right), \varphi\left(x_{-\alpha}\right)\right] \varphi\left(x_{\alpha+\beta}\right) \varphi\left(x_{\beta}\right)$ is trivial in $B_{6} / N$.
(m) Relation (2.13) reduces to Relation (2.8) after conjugating by $\Delta$. In the same way Relations (2.14) and (2.15) reduce to Relations (2.7) and (2.6) respectively.

To complete the proof it remains to check that $\varphi \circ f=\mathrm{id}$. This is a consequence of the equalities $(\varphi \circ f)\left(\sigma_{i}\right)=\sigma_{i}(1 \leq i \leq 5)$, which follow immediately from the definitions of $f$ and $\varphi$.

As can be seen in the previous proof, 18 out of the 24 images under $\varphi$ of the relations defining $\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ hold in the braid group $B_{6}$ itself. Only six of them hold modulo the normal subgroup $N$.

Remark 4.7. In [12, Cor. 7] we gave a braid-like presentation of the symplectic modular group $\mathrm{Sp}_{4}(\mathbb{Z})$ with four additional relations rather than the two additional ones in Corollary 4.2 above. In [12] the first relation in Equation (27) is equivalent (modulo the braid relations) to the relation $\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{4}=1$ above. Relation (28) in loc. cit. is equivalent to the relation $\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}=\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)^{-1}$. Our corollary 4.2 shows that the relation $\Delta^{2}=1$ of [12, Eq. (26)] is not needed. Actually, one can prove

## Appendix A. The Steinberg group of type $C_{2}$ over a commutative ring

For completeness we give a presentation of the Steinberg group $\operatorname{St}\left(C_{2}, R\right)$ over an arbitrary commutative ring $R$.

By [15, Sect.3] (see also [16] or [17, Chap. 6]) the group $\operatorname{St}\left(C_{2}, R\right)$ has a presentation with the set of generators $\left\{x_{\gamma}(u): \gamma \in \Phi, u \in R\right\}$ subject to the following relations:

- $x_{\gamma}(u+v)=x_{\gamma}(u) x_{\gamma}(v)$ for all $u, v \in R$;
- if $\gamma, \delta \in \Phi$ such that $\gamma+\delta \neq 0$, then

\left[x_{\gamma}(u), x_{\delta}(v)\right]=\prod x_{i \gamma+j \delta}\left(c_{i, j}^{\gamma, \delta} u^{i} v^{j}\right),

where $i$ and $j$ are positive integers such that $i \gamma+j \delta$ belongs to $\Phi$. The coefficients $c_{i, j}^{\gamma, \delta}$ are the integers which have already come up in Relations (2.21) in the proof of Proposition 2.1.

In this way we obtain the following 24 defining relations for $\operatorname{St}\left(C_{2}, R\right)$ (where $u, v \in R$ ):
