On p-Laplacian reaction-diffusion problems with dynamical boundary conditions in perforated media

Abstract

This paper deals with the homogenization of the *p*-Laplacian reaction-diffusion problems in a domain containing periodically distributed holes of size ε , with a dynamical boundary condition of *pure-reactive* type. We generalize our previous results (see [2]) established in the case where the diffusion is modeled by the Laplacian operator, i.e., with p = 2. We prove the convergence of the homogenization process to a nonlinear *p*-Laplacian reaction-diffusion equation defined on a unified domain without holes with zero Dirichlet boundary conditions.

1 Introduction and setting of the problem

Homogenization problems in perforated media for the p-Laplacian operator have been considered in the literature over the last decades. The homogenization of the equation

$$-\operatorname{div}\left(|\nabla u_{\varepsilon}|^{p-2}\nabla u_{\varepsilon}\right) = f \tag{1}$$

in a periodically perforated domain is considered by Labani and Picard in [28] with Dirichlet boundary conditions. Such a problem is a generalization of the linear problem for Laplace's equation, which corresponds to p = 2, and was studied by Cioranescu and Murat in [9]. Donato and Moscariello in [16] study the homogenization of a class of nonlinear elliptic Neumann problems in perforated domains of \mathbb{R}^N . As a consequence of [16], we are able in particular to describe the homogenization of (1) with Neumann boundary conditions. This result is a generalization of earlier related works, for instance, Cioranescu and Donato [7] and Cioranescu and Saint Jean Paulin [10]. In [34] Shaposhnikova and Podol'skii study the homogenization of (1) with a nonlinear perturbed Robin-type boundary condition in an ε periodically perforated domain where the size of the particles is smaller than the period ε , and the asymptotic behavior of the solution is studied as $\varepsilon \to 0$. The closest articles to this one in the literature are [25, 26, 27], where Gómez *et al.* consider the case 2 , and [14], where Díaz*et al.*study the case <math>p > N.

It has been discovered by physicists that, as far as the Allen-Cahn equation is concerned, for certain materials a dynamical interaction with the walls must be taken into account (see Fischer *et al.* [20, 21] for more details). In this sense, in the context of reaction-diffusion equations, dynamical boundary conditions have been rigorously derived in Gal and Shomberg [23] based on first and second thermodynamical principles and their physical interpretation was also given in Goldstein [24]. We point out that these types of boundary conditions are also used for modelling various physical situations including fluid diffusion within a semi-permeable boundary (see Crank [12], Langer [29], and, March and Weaver [31] for more details) or several situations when the hear flow

inside the domain is subject to nonlinear heating or cooling on the boundary (see Favini *et al.* [18, 19] for more details).

As far as we know, in the previous literature there is no study for the homogenization of p-Laplacian parabolic models associated with nonlinear dynamical boundary conditions in a periodically perforated domain, as we consider in this article. Such equations model nonlinear fluid diffusion through a semi-permeable membrane (see Duvaut and Lions [17, Ch.1]) or nonlinear heat flow with radiation on the boundary causing nonlinear cooling (see Friedman [22, Ch.7, §5]).

In a recent article (see [2]) we addressed the problem of the homogenization of the reaction-diffusion equations with a dynamical boundary condition of *pure-reactive* type in a domain perforated with holes (for the physical motivation of this model, see, for instance, Timofte [36], and in the stochastic case, see Wang and Duan [38]).

More recently, in [3] we generalize this previous study to the case of a dynamical boundary condition of *reactive-diffusive* type, i.e., we add to the dynamical boundary condition a Laplace-Beltrami correction term, and in [4] we carried out the first study on the asymptotic behavior of the solution of parabolic models associated with dynamical boundary conditions of *pure-reactive* type in a thin porous media.

In the present article, we consider *p*-Laplacian parabolic problems with nonlinear dynamical boundary conditions of *pure-reactive* type occurring as generalizations of semilinear reaction-diffusion equations with dynamical boundary conditions. Let us introduce the model we will be involved with in this article.

The geometrical setting. Let Ω be a bounded connected open set in \mathbb{R}^N $(N \ge 2)$, with smooth enough boundary $\partial \Omega$. Let us introduce a set of periodically distributed holes. As a result, we obtain an open set Ω_{ε} , where ε represents a small parameter related to the characteristic size of the holes.

Let $Y = [0,1]^N$ be the representative cell in \mathbb{R}^N and F an open subset of Y with smooth enough boundary ∂F , such that $\overline{F} \subset Y$. We denote $Y^* = Y \setminus \overline{F}$. For $k \in \mathbb{Z}^N$ and $\varepsilon \in (0,1]$, each cell $Y_{k,\varepsilon} = \varepsilon k + \varepsilon Y$ is similar to the unit cell Y rescaled to size ε and $F_{k,\varepsilon} = \varepsilon k + \varepsilon F$ is similar to F rescaled to size ε . We denote $Y_{k,\varepsilon}^* = Y_{k,\varepsilon} \setminus \overline{F}_{k,\varepsilon}$. We denote by F_{ε} the set of all the holes contained in Ω , i.e. $F_{\varepsilon} = \bigcup_{k \in K} \{F_{k,\varepsilon} : \overline{F}_{k,\varepsilon} \subset \Omega\}$, where $K := \{k \in \mathbb{Z}^N : Y_{k,\varepsilon} \cap \Omega \neq \emptyset\}$.

Let $\Omega_{\varepsilon} = \Omega \setminus \bar{F}_{\varepsilon}$. By this construction, Ω_{ε} is a periodically perforated domain with holes of the same size as the period. Remark that the holes do not intersect the boundary $\partial\Omega$. Let $\partial F_{\varepsilon} = \bigcup_{k \in K} \{\partial F_{k,\varepsilon} : \bar{F}_{k,\varepsilon} \subset \Omega\}$. So

$$\partial \Omega_{\varepsilon} = \partial \Omega \cup \partial F_{\varepsilon}.$$

Position of the problem. The prototype of the *p*-Laplacian parabolic initial-boundary value problems that we consider in this article is

$$\begin{cases} \frac{\partial u_{\varepsilon}}{\partial t} - \Delta_p \, u_{\varepsilon} + \kappa |u_{\varepsilon}|^{p-2} u_{\varepsilon} = -f(u_{\varepsilon}) & \text{in } \Omega_{\varepsilon} \times (0,T), \\ \partial_{\nu_p} u_{\varepsilon} + \varepsilon \, \frac{\partial u_{\varepsilon}}{\partial t} = -\varepsilon \, g(u_{\varepsilon}) & \text{on } \partial F_{\varepsilon} \times (0,T), \\ u_{\varepsilon} = 0, & \text{on } \partial \Omega \times (0,T), \\ u_{\varepsilon}(x,0) = u_{\varepsilon}^0(x), & \text{for } x \in \Omega_{\varepsilon}, \\ u_{\varepsilon}(x,0) = \psi_{\varepsilon}^0(x), & \text{for } x \in \partial F_{\varepsilon}, \end{cases}$$

where $u_{\varepsilon} = u_{\varepsilon}(x,t), x \in \Omega_{\varepsilon}, t \in (0,T)$, with T > 0, and $\kappa > 0$ is a given constant. Here the diffusion is modeled by the *p*-Laplacian operator $\Delta_p u_{\varepsilon} := \operatorname{div} \left(|\nabla u_{\varepsilon}|^{p-2} \nabla u_{\varepsilon} \right)$ with $p \in [2, N]$. Notice that p = 2 corresponds to the linear diffusion operator. The "normal derivative" must be understood as $\partial_{\nu_p} u_{\varepsilon} = |\nabla u_{\varepsilon}|^{p-2} \nabla u_{\varepsilon} \cdot \nu$, where ν denotes the outward normal to ∂F_{ε} . The boundary equation (2)₂ is multiplied by ε to compensate the growth of the surface by shrinking ε , where the value of u_{ε} is assumed to be the trace of the function u_{ε} defined for $x \in \Omega_{\varepsilon}$. Notice that on ∂F_{ε} we assume that $\psi_{\varepsilon}^{0}(x)$ is equal to the trace of $u_{\varepsilon}^{0}(x)$. We also assume that the functions fand $g \in C(\mathbb{R})$ are given, and satisfy that there exist exponents q_1 and q_2 , such that

$$p \le q_1 < +\infty$$
, if $p = N$ and $2 \le q_1 \le \frac{Np}{N-p}$, if $p \in [2, N)$, (3)

$$2 \le q_2 < +\infty$$
, if $p = N$ and $2 \le q_2 \le \frac{(N-1)p}{N-p}$, if $p \in [2, N)$, (4)

and constants $\alpha_1 > 0$, $\alpha_2 > 0$, $\beta > 0$, and l > 0, such that

$$\alpha_1 |s|^{q_1} - \beta \le f(s)s \le \alpha_2 |s|^{q_1} + \beta, \quad \text{for all } s \in \mathbb{R},$$

$$\alpha_1 |s|^{q_2} - \beta \le g(s)s \le \alpha_2 |s|^{q_2} + \beta, \quad \text{for all } s \in \mathbb{R},$$

$$(f(s_1) - f(s_2))(s_1 - s_2) \ge -l(s_1 - s_2)^2, \quad \text{for all } s_1, s_2 \in \mathbb{R},$$

and

$$(g(s_1) - g(s_2))(s_1 - s_2) \ge -l(s_1 - s_2)^2, \quad \text{for all } s_1, s_2 \in \mathbb{R}.$$

Finally, we also assume that

$$u_{\varepsilon}^{0} \in L^{2}(\Omega), \quad \psi_{\varepsilon}^{0} \in L^{2}(\partial F_{\varepsilon}), \qquad (9)$$

are given, and we suppose that

$$|u_{\varepsilon}^{0}|_{\Omega_{\varepsilon}}^{2} + \varepsilon |\psi_{\varepsilon}^{0}|_{\partial F_{\varepsilon}}^{2} \le C, \tag{10}$$

where C is a positive constant, and we denote by $|\cdot|_{\Omega_{\varepsilon}}$ and $|\cdot|_{\partial F_{\varepsilon}}$ the norm in $L^2(\Omega_{\varepsilon})$ and $L^2(\partial F_{\varepsilon})$, respectively.

In [2], we consider the homogenization of the problem (2) with p = 2 and we obtain rigorously a nonlinear parabolic problem with zero Dirichlet boundary condition and with extra-terms coming from the influence of the dynamical boundary conditions as the homogenized model. We would like to highlight that analyzing a *p*-Laplacian problem involves additional (nontrivial) difficulties compared to the study for the Laplacian. Due to the presence of *p*-Laplacian operator in the domain, the variational formulation of the *p*-Laplacian reactiondiffusion equation is different that in [2]. We have to work in the space

$$V_p := \left\{ (v, \gamma_0(v)) : v \in W^{1,p}(\Omega_{\varepsilon}), \gamma_0(v) = 0 \text{ on } \partial\Omega \right\},\$$

where γ_0 denotes the trace operator $v \in W^{1,p}(\Omega_{\varepsilon}) \mapsto v|_{\partial\Omega_{\varepsilon}} \in W^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon})$. New $W^{1,p}$ -estimates are needed to deal with problem (2). To prove these estimates rigorously, we use the Galerkin approximations where we have to introduce a special basis consisting of functions in the space

$$\mathcal{V}_{s} := \left\{ \left(v, \gamma_{0}(v) \right) : v \in W^{s,2}\left(\Omega_{\varepsilon}\right), \gamma_{0}(v) = 0 \text{ on } \partial\Omega \right\}, \quad s \ge \frac{N(p-2)}{2p} + 1,$$

in the sense of Lions [30, p. 161]. Therefore, thanks to the assumption made on s, we have $\mathcal{V}_s \subset V_p$. We use the so-called energy method introduced by Tartar [35] and considered by many authors (see, for instance, Cioranescu and Donato [7]). Finally, in order to identity the limit equation, it is necessary to use monotonicity arguments. In summary, we prove that the solution of problem (2), properly extended to the whole Ω , converges to the unique solution of a new nonlinear problem, defined all over the domain Ω , given by a new operator and containing extra zero order terms, capturing the effect of the influence of the non-homogeneous dynamical condition imposed on the boundary of F_{ε} . In particular, we prove the following theorem:

Theorem 1.1 (Main Theorem). Under the assumptions (3), (5)–(8) and (10), assume that $g \in C^1(\mathbb{R})$, the exponent q_2 satisfies that

$$p \le q_2 < +\infty \quad if \quad p = N \quad and \quad 2 \le q_2 \le \frac{(N-1)p}{N-p} \quad if \quad p \in [2,N),$$
 (11)

and $(u_{\varepsilon}^{0}, \psi_{\varepsilon}^{0}) \in V_{p}$. Let $(u_{\varepsilon}, \psi_{\varepsilon})$ be the unique solution of the problem (2), where $\psi_{\varepsilon}(t) = \gamma_{0}(u_{\varepsilon}(t))$ a.e. $t \in (0, T]$. Then, as $\varepsilon \to 0$, we have

 $\tilde{u}_{\varepsilon}(t) \to u(t)$ strongly in $L^{p}(\Omega), \quad \forall t \in [0, T],$

where $\tilde{\cdot}$ denotes the $W^{1,p}$ -extension to $\Omega \times (0,T)$ and u is the unique solution of the following problem

$$\begin{cases} \left(\frac{|Y^*|}{|Y|} + \frac{|\partial F|}{|Y|}\right) \frac{\partial u}{\partial t} - \operatorname{div} b\left(\nabla u\right) + \frac{|Y^*|}{|Y|} (\kappa |u|^{p-2}u + f(u)) + \frac{|\partial F|}{|Y|} g(u) = 0, \text{ in } \Omega \times (0, T), \\ u(x, 0) = u_0(x), \text{ for } x \in \Omega, \\ u = 0, \text{ on } \partial\Omega \times (0, T). \end{cases}$$

For any $\zeta \in \mathbb{R}^N$, if w(y) is the solution of the problem

$$\begin{cases} \int_{Y^{\star}} |\nabla_y w(y)|^{p-2} \nabla_y w(y) \cdot \nabla_y \varphi(y) dy = 0 \quad \forall \varphi \in \mathbb{H}_{per}(Y^*), \\ w \in \zeta \cdot y + \mathbb{H}_{per}(Y^*), \end{cases}$$
(13)

then b is defined by

$$b(\zeta) = \frac{1}{|Y|} \int_{Y^*} |\nabla_y w(y)|^{p-2} \nabla_y w(y) dy,$$
(14)

where $\mathbb{H}_{per}(Y^*)$ is the space of functions from $W^{1,p}(Y^*)$ which have the same trace on the opposite faces of Y.

Remark 1.2. Note that in the case p = 2 (i.e., if the diffusion is modeled by the Laplacian operator), the homogenized equation (12) is exactly the equation obtained in [2].

Remark 1.3. In this setting, a typical nonlinearity in the applications is an odd degree polynomial, $\sum_{j=0}^{2k+1} c_j s^j$, where $c_{2k+1} > 0$.

Remark 1.4. It seems possible to improve the regularity assumed on the functions f and g when they are assumed non-increasing and Hölder continuous (for more details, see the recent book [15] where Díaz et al. present this improvement for the linear diffusion case).

The article is organized as follows. In Section 2, we introduce suitable functions spaces for our considerations. We recall here some well-know facts on the Sobolev spaces $W^{s,p}$. To prove the main result, in Section 3 we prove the existence and uniqueness of solution of (2), *a priori* estimates are established in Section 4 and some compactness results are proved in Section 5. Finally, the proof of Theorem 1.1 is established in Section 6.

2 Functional setting

Notation: We denote by $(\cdot, \cdot)_{\Omega_{\varepsilon}}$ (respectively, $(\cdot, \cdot)_{\partial F_{\varepsilon}}$) the inner product in $L^{2}(\Omega_{\varepsilon})$ (respectively, in $L^{2}(\partial F_{\varepsilon})$), and by $|\cdot|_{\Omega_{\varepsilon}}$ (respectively, $|\cdot|_{\partial F_{\varepsilon}}$) the associated norm. We also denote by $(\cdot, \cdot)_{\Omega_{\varepsilon}}$ the inner product in $(L^{2}(\Omega_{\varepsilon}))^{N}$.

If $r \neq 2$, we will also denote by $(\cdot, \cdot)_{\Omega_{\varepsilon}}$ (respectively, $(\cdot, \cdot)_{\partial F_{\varepsilon}}$) the duality product between $L^{r'}(\Omega_{\varepsilon})$ and $L^{r}(\Omega_{\varepsilon})$ (respectively, the duality product between $L^{r'}(\partial F_{\varepsilon})$ and $L^{r}(\partial F_{\varepsilon})$). We will denote by $|\cdot|_{r,\Omega_{\varepsilon}}$ (respectively $|\cdot|_{r,\partial F_{\varepsilon}}$) the norm in $L^{r}(\Omega_{\varepsilon})$ (respectively in $L^{r}(\partial F_{\varepsilon})$).

We denote by $(\cdot, \cdot)_{\Omega}$ the inner product in $L^2(\Omega)$, and by $|\cdot|_{\Omega}$ the associated norm. If $r \neq 2$, we will also denote by $(\cdot, \cdot)_{\Omega}$ the duality product between $L^{r'}(\Omega)$ and $L^r(\Omega)$. We will denote by $|\cdot|_{r,\Omega}$ the norm in $L^r(\Omega)$.

The Sobolev spaces $W^{s,p}(\Omega_{\varepsilon})$:

We recall here, for the reader's convenience, some well-know facts on the Sobolev spaces $W^{s,p}$. We refer to Adams and Fournier [1], Brézis [5, Chapter 9] and Nečas [32, Chapter 2] for more details and proofs.

For any positive integer s and $p \ge 1$, we define the Sobolev space $W^{s,p}(\Omega_{\varepsilon})$ to be the completion of $C^s(\overline{\Omega}_{\varepsilon})$, with respect to the norm

$$||v||_{s,p,\Omega_{\varepsilon}} = \left(\sum_{0 \le |\alpha| \le s} |D^{\alpha}v|_{p,\Omega_{\varepsilon}}^{p}\right)^{1/p}$$

Observe that $W^{s,p}(\Omega_{\varepsilon})$ is a Banach space.

By the Sobolev embedding Theorem (see [1, Chapter 4, p. 99]), we have the embedding

$$W^{s,p}(\Omega_{\varepsilon}) \subset W^{1,r}(\Omega_{\varepsilon}),\tag{15}$$

where $s \ge 1$ and $\frac{1}{p} - \frac{s-1}{N} \le \frac{1}{r} \le \frac{1}{p}$.

In particular, for $p \ge 1$, we define the Sobolev space $W^{1,p}(\Omega_{\varepsilon})$ to be the completion of $C^1(\overline{\Omega}_{\varepsilon})$, with respect to the norm

$$||v||_{p,\Omega_{\varepsilon}} := \left(|v|_{p,\Omega_{\varepsilon}}^{p} + |\nabla v|_{p,\Omega_{\varepsilon}}^{p} \right)^{1/p}.$$

We set $H^1(\Omega_{\varepsilon}) = W^{1,2}(\Omega_{\varepsilon}).$

By $||\cdot||_{p,\Omega_{\varepsilon},T}$ we denote the norm in $L^{p}(0,T; W^{1,p}(\Omega_{\varepsilon}))$. If $r \neq 2$, by $|\cdot|_{r,\Omega_{\varepsilon},T}$ (respectively, $|\cdot|_{r,\partial F_{\varepsilon},T}$), we denote the norm in $L^{r}(0,T; L^{r}(\Omega_{\varepsilon}))$ (respectively, $L^{r}(0,T; L^{r}(\partial F_{\varepsilon}))$).

By $\|\cdot\|_{p,\Omega}$ we denote the norm in $W^{1,p}(\Omega)$, by $\|\cdot\|_{p,\Omega,T}$ we denote the norm in $L^p(0,T;W^{1,p}(\Omega))$ and if $r \neq 2$, we denote by $|\cdot|_{r,\Omega,T}$ the norm in $L^r(0,T;L^r(\Omega))$.

We define

$$p^{\star} = \begin{cases} \frac{Np}{N-p} & \text{if } p < N, \\ +\infty & \text{if } p = N. \end{cases}$$

We have the continuous embedding

$$W^{1,p}(\Omega_{\varepsilon}) \subset \begin{cases} L^{r}(\Omega_{\varepsilon}) & \text{if } p < N \text{ and } r = p^{\star}, \\ L^{r}(\Omega_{\varepsilon}) & \text{if } p = N \text{ and } p \le r < p^{\star}. \end{cases}$$

By Rellich-Kondrachov Theorem (see [5, Chapter 9, Theorem 9.16]), we have the compact embedding

$$W^{1,p}(\Omega_{\varepsilon}) \subset \begin{cases} L^{r}(\Omega_{\varepsilon}) & \text{if } p < N \text{ and } 1 \le r < p^{\star}, \\ L^{r}(\Omega_{\varepsilon}) & \text{if } p = N \text{ and } p \le r < p^{\star}. \end{cases}$$
(17)

In particular, we have the compact embedding

$$W^{1,p}(\Omega_{\varepsilon}) \subset L^2(\Omega_{\varepsilon}), \quad \forall 2 \le p \le N.$$

One can define a family of spaces intermediate between L^p and $W^{1,p}$. More precisely for $p \ge 1$ we define the fractional order Sobolev space

$$W^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon}) := \left\{ v \in L^{p}(\partial\Omega_{\varepsilon}); \frac{|v(x) - v(y)|}{|x - y|^{1-\frac{1}{p} + \frac{N}{p}}} \in L^{p}(\partial\Omega_{\varepsilon} \times \partial\Omega_{\varepsilon}) \right\},$$

equipped with the natural norm. We set $H^{1/2}(\partial \Omega_{\varepsilon}) = W^{\frac{1}{2},2}(\partial \Omega_{\varepsilon})$. These spaces play an important role in the theory of traces.

We denote by γ_0 the trace operator $v \mapsto v|_{\partial\Omega_{\varepsilon}}$. The trace operator belongs to $\mathcal{L}(W^{1,p}(\Omega_{\varepsilon}), W^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon}))$, and we will use $||\gamma_0||$ to denote the norm of γ_0 in this space.

We will use $\|\cdot\|_{p,\partial\Omega_{\varepsilon}}$ to denote the norm in $W^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon})$, which is given by

$$\|\phi\|_{p,\partial\Omega_{\varepsilon}} = \inf\{\|v\|_{p,\Omega_{\varepsilon}} : \gamma_0(v) = \phi\}.$$

We define

$$p_b^{\star} = \begin{cases} \frac{(N-1)p}{N-p} & \text{if } p < N\\ +\infty & \text{if } p = N. \end{cases}$$

We have the continuous embedding

$$W^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon}) \subset \begin{cases} L^{r}(\partial\Omega_{\varepsilon}) & \text{if} \quad p < N \quad \text{and} \quad r = p_{b}^{\star}, \\ L^{r}(\partial\Omega_{\varepsilon}) & \text{if} \quad p = N \quad \text{and} \quad 1 \le r < p_{b}^{\star}. \end{cases}$$

By [32, Chaper 2, Theorem 6.2], we have the compact embedding

$$W^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon}) := \gamma_0 \left(W^{1,p}(\Omega_{\varepsilon}) \right) \subset L^r(\partial\Omega_{\varepsilon}) \quad \text{if} \quad 1 \le r < p_b^{\star}.$$
⁽²⁰⁾

In particular, we have the compact embedding

$$W^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon}) \subset L^{2}(\partial\Omega_{\varepsilon}) \quad \forall 2 \le p \le N.$$
(21)

Some notations: Finally, for any positive integer s and $p \geq 1$, we denote by $W^{s,p}_{\partial\Omega}(\Omega_{\varepsilon})$ and $W^{s,p}_{\partial\Omega}(\partial\Omega_{\varepsilon})$ the standard Sobolev spaces which are closed subspaces of $W^{s,p}(\Omega_{\varepsilon})$ and $W^{s,p}(\partial\Omega_{\varepsilon})$, respectively, and the subscript $\partial\Omega$ means that, respectively, traces or functions in $\partial\Omega_{\varepsilon}$, vanish on this part of the boundary of Ω_{ε} , i.e.

$$W^{s,p}_{\partial\Omega}(\Omega_{\varepsilon}) = \{ v \in W^{s,p}(\Omega_{\varepsilon}) : \gamma_0(v) = 0 \text{ on } \partial\Omega \},\$$

and

$$W^{s,p}_{\partial\Omega}(\partial\Omega_{\varepsilon}) = \{ v \in W^{s,p}(\partial\Omega_{\varepsilon}) : v = 0 \text{ on } \partial\Omega \}$$

Let us notice that, in fact, we can consider an element of $W^{1-\frac{1}{p},p}(\partial F_{\varepsilon})$ as an element of $W^{1-\frac{1}{p},p}_{\partial\Omega}(\partial\Omega_{\varepsilon})$.

Analogously, for $r \geq 2$, we denote

$$L^r_{\partial\Omega}(\partial\Omega_{\varepsilon}) := \{ v \in L^r(\partial\Omega_{\varepsilon}) : v = 0 \text{ on } \partial\Omega \}.$$

Let us notice that, in fact, we can consider the given ψ_{ε}^0 as an element of $L^2_{\partial\Omega}(\partial\Omega_{\varepsilon})$.

Let us consider the space

$$H_r := L^r \left(\Omega_{\varepsilon} \right) \times L^r_{\partial \Omega} \left(\partial \Omega_{\varepsilon} \right), \quad \forall r \ge 2,$$

with the natural inner product $((v, \phi), (w, \varphi))_{H_r} = (v, w)_{\Omega_{\varepsilon}} + \varepsilon(\phi, \varphi)_{\partial F_{\varepsilon}}$, which in particular induces the norm $|(\cdot, \cdot)|_{H_r}$ given by

 $|(v,\phi)|_{H_r}^r = |v|_{r,\Omega_\varepsilon}^r + \varepsilon |\phi|_{r,\partial F_\varepsilon}^r, \quad (v,\phi) \in H_r.$

For the sake of clarity, we shall omit to write explicitly the index r if r = 2, so we denote by H the Hilbert space

$$H := L^2(\Omega_{\varepsilon}) \times L^2_{\partial\Omega}(\partial\Omega_{\varepsilon})$$

For each p > 1, we consider the space

$$V_p := \left\{ (v, \gamma_0(v)) : v \in W^{1,p}_{\partial\Omega}(\Omega_{\varepsilon}) \right\}.$$

We note that V_p is a closed vector subspace of $W^{1,p}_{\partial\Omega}(\Omega_{\varepsilon}) \times W^{1-\frac{1}{p},p}_{\partial\Omega}(\partial\Omega_{\varepsilon})$, and we endow it with the norm $\|(\cdot,\cdot)\|_{V_p}$ given by

$$(v, \gamma_0(v)) \|_{V_p}^p = \|v\|_{p,\Omega_{\varepsilon}}^p + \|\gamma_0(v)\|_{p,\partial F_{\varepsilon}}^p, \quad (v, \gamma_0(v)) \in V_p.$$

Moreover, V_p is a reflexive and separable space.

Let p', q'_1 and q'_2 be the conjugate exponents of p, q_1 and q_2 , respectively. Taking into account the continuous embeddings (16) and (19), and the assumptions (3)-(4), we have the following useful continuous inclusions

$$V_p \subset W^{1,p}(\Omega_{\varepsilon}) \subset L^{q_1}(\Omega_{\varepsilon}) \subset L^2(\Omega_{\varepsilon}), \quad V_p \subset W^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon}) \subset L^{q_2}(\partial\Omega_{\varepsilon}) \subset L^2(\partial\Omega_{\varepsilon}),$$
(22)

and

$$L^{2}(\Omega_{\varepsilon}) \subset L^{q'_{1}}(\Omega_{\varepsilon}) \subset \left(W^{1,p}(\Omega_{\varepsilon})\right)' \subset V'_{p},$$
(23)

where $(W^{1,p}(\Omega_{\varepsilon}))'$ and V'_p denote the dual of $W^{1,p}(\Omega_{\varepsilon})$ and V_p , respectively. Note that $(W^{1,p}(\Omega_{\varepsilon}))'$ is a subspace of $W^{-1,p'}(\Omega_{\varepsilon})$, where $W^{-1,p'}(\Omega_{\varepsilon})$ denotes the dual of the Sobolev space $W^{1,p}_0(\Omega_{\varepsilon}) := \overline{\mathcal{D}(\Omega_{\varepsilon})}^{W^{1,p}(\Omega_{\varepsilon})}$.

Taking into account the compact embeddings (18) and (21), we have the compact embedding

$$V_p \subset H \quad \forall \, 2 \le p \le N. \tag{24}$$

Finally, for $s \ge 1$, we consider the space

$$\mathcal{V}_s := \left\{ (v, \gamma_0(v)) : v \in W^{s,2}_{\partial\Omega}\left(\Omega_{\varepsilon}\right) \right\}.$$

We note that \mathcal{V}_s is a closed vector subspace of $W^{s,2}_{\partial\Omega}\left(\Omega_{\varepsilon}\right) \times W^{s-\frac{1}{2},2}_{\partial\Omega}\left(\partial\Omega_{\varepsilon}\right)$.

Observe that by (15), we have that $W^{s,2}(\Omega_{\varepsilon}) \subset W^{1,2}(\Omega_{\varepsilon})$ and by Rellich's Theorem (see [32, Chapter 1, Theorem 1.4]), we obtain the compact embedding

$$W^{1,2}(\Omega_{\varepsilon}) \subset L^2(\Omega_{\varepsilon}),$$

and by [32, Chapter 1, Exercise 1.2], we have the compact embedding

$$W^{s-\frac{1}{2},2}(\partial\Omega_{\varepsilon}) := \gamma_0 \left(W^{s,2}(\Omega_{\varepsilon}) \right) \subset L^2(\partial\Omega_{\varepsilon}).$$

Thus, we can deduce the compact embedding

$$\mathcal{V}_s \subset H.$$

3 Existence and uniqueness of solution

Along this paper, we shall denote by C different constants which are independent of ε . We state in this section a result on the existence and uniqueness of solution of problem (2). It is easy to see from (5) and (6) that there exists a constant C > 0 such that

$$|f(s)| \le C\left(1+|s|^{q_1-1}\right), \quad |g(s)| \le C\left(1+|s|^{q_2-1}\right), \text{ for all } s \in \mathbb{R}.$$

Definition 3.1. A weak solution of (2) is a pair of functions $(u_{\varepsilon}, \psi_{\varepsilon})$, satisfying

$$u_{\varepsilon} \in C([0,T]; L^{2}(\Omega_{\varepsilon})), \quad \psi_{\varepsilon} \in C([0,T]; L^{2}_{\partial\Omega}(\partial\Omega_{\varepsilon})), \quad \text{for all } T > 0,$$

$$u_{\varepsilon} \in L^{p}(0,T; W^{1,p}(\Omega_{\varepsilon})), \quad \text{for all } T > 0,$$
(28)

$$\psi_{\varepsilon} \in L^{p}(0,T; W^{1-\frac{1}{p},p}_{\partial\Omega}(\partial\Omega_{\varepsilon})), \quad \text{for all } T > 0,$$
⁽²⁹⁾

$$\gamma_0(u_\varepsilon(t)) = \psi_\varepsilon(t), \quad a.e. \ t \in (0,T],$$
(30)

$$\frac{d}{dt}(u_{\varepsilon}(t),v)_{\Omega_{\varepsilon}} + \varepsilon \frac{d}{dt}(\psi_{\varepsilon}(t),\gamma_{0}(v))_{\partial F_{\varepsilon}} + (|\nabla u_{\varepsilon}(t)|^{p-2}\nabla u_{\varepsilon}(t),\nabla v)_{\Omega_{\varepsilon}} + \kappa(|u_{\varepsilon}(t)|^{p-2}u_{\varepsilon}(t),v)_{\Omega_{\varepsilon}} + (f(u_{\varepsilon}(t)),v)_{\Omega_{\varepsilon}} + \varepsilon (g(\psi_{\varepsilon}(t)),\gamma_{0}(v))_{\partial F_{\varepsilon}} = 0$$
(31)

$$(in \mathcal{D}'(0,T), for all v \in W^{1,p}_{\partial\Omega}(\Omega_{\varepsilon}),$$

$$u_{\varepsilon}(0) = u_{\varepsilon}^{0}, \quad and \quad \psi_{\varepsilon}(0) = \psi_{\varepsilon}^{0}.$$
 (32)

We have the following result.

Theorem 3.2. Under the assumptions (3)–(9), there exists a unique solution $(u_{\varepsilon}, \psi_{\varepsilon})$ of the problem (2). Moreover, this solution satisfies the energy equality

$$\frac{1}{2} \frac{d}{dt} \left(|(u_{\varepsilon}(t), \psi_{\varepsilon}(t))|_{H}^{2} \right) + |\nabla u_{\varepsilon}(t)|_{p,\Omega_{\varepsilon}}^{p} + \kappa |u_{\varepsilon}(t)|_{p,\Omega_{\varepsilon}}^{p} \\
+ (f(u_{\varepsilon}(t)), u_{\varepsilon}(t))_{\Omega_{\varepsilon}} + \varepsilon \left(g(\psi_{\varepsilon}(t)), \psi_{\varepsilon}(t) \right)_{\partial F_{\varepsilon}} = 0, \quad a.e. \ t \in (0,T).$$
(33)

Proof. The proof of this result is standard. For the sake of completeness, we give a sketch of a proof.

First, we prove that V_p is densely embedded in H. In fact, if we consider $(w, \phi) \in H$ such that

 $(v,w)_{\Omega_{\varepsilon}} + \varepsilon(\gamma_0(v),\phi)_{\partial F_{\varepsilon}} = 0, \text{ for all } v \in W^{1,p}_{\partial\Omega}(\Omega_{\varepsilon}),$

in particular, we have

$$(v, w)_{\Omega_{\varepsilon}} = 0, \quad \text{for all } v \in W_0^{1, p}(\Omega_{\varepsilon}),$$

and therefore w = 0. Consequently,

$$(\gamma_0(v), \phi)_{\partial F_{\varepsilon}} = 0, \quad \text{for all } v \in W^{1,p}_{\partial \Omega}(\Omega_{\varepsilon})$$

and then, as $W_{\partial\Omega}^{1-\frac{1}{p},p}(\partial\Omega_{\varepsilon}) = \gamma_0\left(W_{\partial\Omega}^{1,p}(\Omega_{\varepsilon})\right)$ is dense in $L^2_{\partial\Omega}(\partial\Omega_{\varepsilon})$, we have that $\phi = 0$.

Now, on the space V_p we define the nonlinear monotone operator $A_p: V_p \to V'_p$, given by

$$\langle A_p((v,\gamma_0(v))), (w,\gamma_0(w)) \rangle = (|\nabla v|^{p-2} \nabla v, \nabla w)_{\Omega_{\varepsilon}} + \kappa (|v|^{p-2} v, w)_{\Omega_{\varepsilon}}, \tag{34}$$

for all $v, w \in W^{1,p}_{\partial\Omega}(\Omega_{\varepsilon})$.

We observe that A_p is coercive. In fact, we have

$$\langle A_{p}\left((v,\gamma_{0}(v)),(v,\gamma_{0}(v))\right) \rangle \geq \min\{1,\kappa\} \|v\|_{p,\Omega_{\varepsilon}}^{p}$$

$$= \frac{1}{1+\|\gamma_{0}\|^{p}} \min\{1,\kappa\} \|v\|_{p,\Omega_{\varepsilon}}^{p} + \frac{\|\gamma_{0}\|^{p}}{1+\|\gamma_{0}\|^{p}} \min\{1,\kappa\} \|v\|_{p,\Omega_{\varepsilon}}^{p}$$

$$\geq \frac{1}{1+\|\gamma_{0}\|^{p}} \min\{1,\kappa\} \|(v,\gamma_{0}(v))\|_{V_{p}}^{p},$$

$$(35)$$

for all $v \in W^{1,p}_{\partial\Omega}(\Omega_{\varepsilon})$.

Let us denote

$$V_{1} = V_{p}, \quad V_{2} = L^{q_{1}}(\Omega_{\varepsilon}) \times L^{2}_{\partial\Omega}(\partial\Omega_{\varepsilon}), \quad V_{3} = L^{2}(\Omega_{\varepsilon}) \times L^{q_{2}}_{\partial\Omega}(\partial\Omega_{\varepsilon})$$
$$A_{1} = A_{p}, \quad A_{2}(v,\phi) = (f(v),0), \quad A_{3}(v,\phi) = (0,\varepsilon g(\phi)).$$

From (26) one deduces that $A_i: V_i \to V'_i$ for i = 2, 3.

With this notation, and denoting $V = \bigcap_{i=1}^{3} V_i$, $p_1 = p$, $p_2 = q_1$, $p_3 = q_2$, $\vec{u}_{\varepsilon} = (u_{\varepsilon}, \psi_{\varepsilon})$, one has that (27)–(32) is equivalent to

$$\vec{u}_{\varepsilon} \in C([0,T];H), \quad \vec{u}_{\varepsilon} \in \bigcap_{i=1}^{3} L^{p_i}(0,T;V_i), \quad \text{for all } T > 0,$$
(36)

$$(\vec{u}_{\varepsilon})'(t) + \sum_{i=1}^{3} A_i(\vec{u}_{\varepsilon}(t)) = 0 \quad \text{in } \mathcal{D}'(0,T;V'), \tag{37}$$

$$\vec{u}_{\varepsilon}(0) = (u_{\varepsilon}^0, \psi_{\varepsilon}^0). \tag{38}$$

Taking into account (22)-(23) and applying a slight modification of [30, Ch.2, Th.1.4], it is not difficult to see that problem (36)–(38) has a unique solution. Moreover, $\vec{u_{\varepsilon}}$ satisfies the energy equality

$$\frac{1}{2}\frac{d}{dt}|\vec{u}_{\varepsilon}(t)|_{H}^{2}+\sum_{i=1}^{3}\langle A_{i}(\vec{u}_{\varepsilon}(t)),\vec{u}_{\varepsilon}(t)\rangle_{i}=0 \quad \text{a.e.} \ t\in(0,T),$$

where $\langle \cdot, \cdot \rangle_i$ denotes the duality product between V'_i and V_i . This last equality turns out to be just (33).

4 A priori estimates

In this section we obtain some energy estimates for the solution of (2). By (33) and taking into account (5)-(6), we have

$$\frac{d}{dt} \left(\left| \left(u_{\varepsilon}(t), \psi_{\varepsilon}(t) \right) \right|_{H}^{2} \right) + 2 \left| \nabla u_{\varepsilon}(t) \right|_{p,\Omega_{\varepsilon}}^{p} + 2\kappa \left| u_{\varepsilon}(t) \right|_{p,\Omega_{\varepsilon}}^{p} + 2\alpha_{1} \left| u_{\varepsilon}(t) \right|_{q_{1},\Omega_{\varepsilon}}^{q_{1}} \right. \tag{39}$$

$$+ 2\alpha_{1}\varepsilon \left| \psi_{\varepsilon}(t) \right|_{q_{2},\partial F_{\varepsilon}}^{q_{2}} \leq 2\beta \left(\left| \Omega_{\varepsilon} \right| + \varepsilon \left| \partial F_{\varepsilon} \right| \right),$$

where $|\Omega_{\varepsilon}|$ and $|\partial F_{\varepsilon}|$ denotes the measure of Ω_{ε} and ∂F_{ε} , respectively.

Observe that the number of holes is given by

$$N(\varepsilon) = \frac{|\Omega|}{(2\varepsilon)^N} \left(1 + o(1)\right)$$

then using the change of variable

$$|\partial F_{\varepsilon}| = N(\varepsilon)|\partial F_{k,\varepsilon}| = N(\varepsilon)\varepsilon^{N-1}|\partial F| \le \frac{C}{\varepsilon}$$

 $|\Omega_{\varepsilon}| + \varepsilon |\partial F_{\varepsilon}| \le C.$

And since $|\Omega_{\varepsilon}| \leq |\Omega|$, we have that

Let us denote

$$\mathcal{F}(s) := \int_0^s f(r)dr$$
 and $\mathcal{G}(s) := \int_0^s g(r)dr$.

Then, there exist positive constants $\tilde{\alpha}_1$, $\tilde{\alpha}_2$, and β such that

$$\widetilde{\alpha}_1 |s|^{q_1} - \widetilde{\beta} \le \mathcal{F}(s) \le \widetilde{\alpha}_2 |s|^{q_1} + \widetilde{\beta} \quad \forall s \in \mathbb{R},$$

$$\widetilde{\alpha}_1 |s|^{q_2} - \widetilde{\beta} \le \mathcal{G}(s) \le \widetilde{\alpha}_2 |s|^{q_2} + \widetilde{\beta} \quad \forall s \in \mathbb{R}.$$

Lemma 4.1. Assume the assumptions (3)–(8) and (10). Then, for any initial condition $(u_{\varepsilon}^{0}, \psi_{\varepsilon}^{0}) \in V_{p}$, there exists a constant C independent of ε , such that the solution $(u_{\varepsilon}, \psi_{\varepsilon})$ of the problem (2) satisfies

$$\|u_{\varepsilon}\|_{p,\Omega_{\varepsilon},T} \le C, \quad \sup_{t \in [0,T]} \|u_{\varepsilon}(t)\|_{p,\Omega_{\varepsilon}} \le C.$$
(43)

Proof. Taking into account (40) in (39), we obtain

$$\frac{d}{dt}\left(\left|\left(u_{\varepsilon}(t),\psi_{\varepsilon}(t)\right)\right|_{H}^{2}\right)+2\left|\nabla u_{\varepsilon}(t)\right|_{p,\Omega_{\varepsilon}}^{p}+2\kappa\left|u_{\varepsilon}(t)\right|_{p,\Omega_{\varepsilon}}^{p}+2\alpha_{1}\left|u_{\varepsilon}(t)\right|_{q_{1},\Omega_{\varepsilon}}^{q}+2\alpha_{1}\varepsilon\left|\psi_{\varepsilon}(t)\right|_{q_{2},\partial F_{\varepsilon}}^{q}\leq C.$$
(44)

From (34)-(35), in particular, we can deduce

$$\frac{d}{dt}\left(\left|\left(u_{\varepsilon}(t),\psi_{\varepsilon}(t)\right)\right|_{H}^{2}\right) + \frac{2\min\{1,\kappa\}}{1+\|\gamma_{0}\|^{p}}\left|\left|\left(u_{\varepsilon}(t),\gamma_{0}(u_{\varepsilon}(t))\right)\right|\right|_{V_{p}}^{p} \le C.$$
(45)

Integrating between 0 and t and taking into account (10), in particular, we have the first estimate in (43).

Now, if we want to take the inner product in the problem (2) with u'_{ε} , we need that $u'_{\varepsilon} \in L^p(0,T; W^{1,p}_{\partial\Omega}(\Omega_{\varepsilon})) \cap L^{q_1}(0,T; L^{q_1}(\Omega_{\varepsilon}))$ with $\gamma_0(u'_{\varepsilon}) \in L^{q_2}(0,T; L^{q_2}_{\partial\Omega}(\partial\Omega_{\varepsilon}))$. However, we do not have it for our weak solution. Therefore, we use the Galerkin method in order to prove, rigorously, new *a priori* estimates for u_{ε} .

At first, we introduce a special basis consisting of functions $(w_j, \gamma_0(w_j)) \in \mathcal{V}_s$ with $s \geq \frac{N(p-2)}{2p} + 1$ in the sense of [30, Chapter 2, Remark 1.6, p. 161]. Therefore, thanks to the assumption made on s, taking into account (15),

we have $\mathcal{V}_s \subset V_p$. The scalar product in H generates on $\mathcal{V}_s \subset H$ the bilinear functional $((v, \gamma_0(v)), (w, \gamma_0(w)))_H$ which can be represented in the form $((v, \gamma_0(v)), (w, \gamma_0(w)))_H = \langle L((v, \gamma_0(v))), (w, \gamma_0(w)) \rangle_{\mathcal{V}_s}$, where L is a selfadjoint operator. The compact embedding (25) implies the compactness of the operator L. Hence, L has a complete system of eigenvectors $\{(w_j, \gamma_0(w_j)) : j \geq 1\}$. These vectors are orthonormal in H and orthogonal in \mathcal{V}_s . Observe that $span\{(w_j, \gamma_0(w_j)) : j \geq 1\}$ is dense in \mathcal{V}_p .

Taking into account the above facts, we denote by

$$(u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t))) = (u_{\varepsilon,m}(t;0,u_{\varepsilon}^0,\psi_{\varepsilon}^0),\gamma_0(u_{\varepsilon,m}(t;0,u_{\varepsilon}^0,\psi_{\varepsilon}^0)))$$

the Galerkin approximation of the solution $(u_{\varepsilon}(t; 0, u_{\varepsilon}^{0}, \psi_{\varepsilon}^{0}), \gamma_{0}(u_{\varepsilon}(t; 0, u_{\varepsilon}^{0}, \psi_{\varepsilon}^{0})))$ to (2) for each integer $m \geq 1$, which is given by

$$(u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t))) = \sum_{j=1}^m \delta_{\varepsilon m j}(t)(w_j,\gamma_0(w_j)),$$
(46)

and is the solution of

$$\frac{d}{dt}((u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t))),(w_j,\gamma_0(w_j)))_H + \langle A_p((u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t)))),(w_j,\gamma_0(w_j))\rangle + (f(u_{\varepsilon,m}(t)),w_j)_{\Omega_{\varepsilon}} + \varepsilon(g(\gamma_0(u_{\varepsilon,m}(t))),\gamma_0(w_j))_{\partial F_{\varepsilon}} = 0, \quad j = 1,\ldots,m,$$
(47)

with initial data

$$(u_{\varepsilon,m}(0),\gamma_0(u_{\varepsilon,m}(0))) = (u^0_{\varepsilon,m},\gamma_0(u^0_{\varepsilon,m})),$$
(48)

and

$$\delta_{\varepsilon m j}(t) = (u_{\varepsilon,m}(t), w_j)_{\Omega_{\varepsilon}} + (\gamma_0(u_{\varepsilon,m}(t)), \gamma_0(w_j))_{\partial F_{\varepsilon}}$$

and $(u_{\varepsilon,m}^0, \gamma_0(u_{\varepsilon,m}^0)) \in span\{(w_j, \gamma_0(w_j)) : j = 1, ..., m\}$ converges (when $m \to \infty$) to $(u_{\varepsilon}^0, \psi_{\varepsilon}^0)$ in a suitable sense which will be specified below.

Let $(u_{\varepsilon}^{0}, \psi_{\varepsilon}^{0}) \in V_{p}$. For all $m \geq 1$, since $span\{(w_{j}, \gamma_{0}(w_{j})) : j \geq 1\}$ is densely embedded in V_{p} , there exists $(u_{\varepsilon,m}^{0}, \gamma_{0}(u_{\varepsilon,m}^{0})) \in span\{(w_{j}, \gamma_{0}(w_{j})) : 1 \leq j \leq m\}$, such that the sequence $\{(u_{\varepsilon,m}^{0}, \gamma_{0}(u_{\varepsilon,m}^{0}))\}$ converges to $(u_{\varepsilon}^{0}, \psi_{\varepsilon}^{0})$ in V_{p} . Then, in particular we know that there exists a constant C such that

$$||(u^0_{\varepsilon,m},\gamma_0(u^0_{\varepsilon,m}))||_{V_p} \le C.$$

$$\tag{49}$$

For each integer $m \ge 1$, we consider the sequence $\{(u_{\varepsilon,m}(t), \gamma_0(u_{\varepsilon,m}(t)))\}$ defined by (46)-(48) with these initial data.

Multiplying by the derivative $\delta'_{\varepsilon m j}$ in (47) and summing from j = 1 to m, we obtain

$$|(u_{\varepsilon,m}'(t),\gamma_0(u_{\varepsilon,m}'(t)))|_H^2 + \frac{1}{p}\frac{d}{dt}(\langle A_p((u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t)))),(u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t)))\rangle) + (f(u_{\varepsilon,m}(t)),u_{\varepsilon,m}'(t))_{\Omega_{\varepsilon}} + \varepsilon(g(\gamma_0(u_{\varepsilon,m}(t))),\gamma_0(u_{\varepsilon,m}'(t)))_{\partial F_{\varepsilon}} = 0.$$
(50)

We observe that

$$(f(u_{\varepsilon,m}(t)), u'_{\varepsilon,m}(t))_{\Omega_{\varepsilon}} = \frac{d}{dt} \int_{\Omega_{\varepsilon}} \mathcal{F}(u_{\varepsilon,m}(t)) dx$$

and

$$(g(\gamma_0(u_{\varepsilon,m}(t))),\gamma_0(u_{\varepsilon,m}'(t)))_{\partial F_{\varepsilon}} = \frac{d}{dt} \int_{\partial F_{\varepsilon}} \mathcal{G}(\gamma_0(u_{\varepsilon,m}(t))) d\sigma(x)$$

Then, integrating (50) between 0 and t, and taking into account (35) and (40)-(42), we obtain

$$\begin{split} &\int_0^t |(u_{\varepsilon,m}'(s),\gamma_0(u_{\varepsilon,m}'(s)))|_H^2 ds + \frac{\min\{1,\kappa\}}{1+\|\gamma_0\|^p} \frac{1}{p} ||(u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t)))||_{V_p}^p \\ &+ \widetilde{\alpha}_1 \left(|u_{\varepsilon,m}(t)|_{q_1,\Omega_{\varepsilon}}^{q_1} + \varepsilon |\gamma_0(u_{\varepsilon,m}(t))|_{q_2,\partial F_{\varepsilon}}^{q_2} \right) \leq \frac{\max\{1,\kappa\}}{p} ||(u_{\varepsilon,m}^0,\gamma_0(u_{\varepsilon,m}^0))||_{V_p}^p \\ &+ \widetilde{\alpha}_2 \left(|u_{\varepsilon,m}^0|_{q_1\Omega_{\varepsilon}}^{q_1} + \varepsilon |\gamma_0(u_{\varepsilon,m}^0)|_{q_2,\partial F_{\varepsilon}}^{q_2} \right) + 2\widetilde{\beta}C, \end{split}$$

for all $t \in (0, T)$. In order to estimate the right hand side of the last inequality we use (22) together with (49) and $\varepsilon \ll 1$. In particular, we can deduce

$$\int_{0}^{t} |(u_{\varepsilon,m}'(s), \gamma_{0}(u_{\varepsilon,m}'(s)))|_{H}^{2} ds + \frac{\min\{1,\kappa\}}{1+\|\gamma_{0}\|^{p}} \frac{1}{p} ||(u_{\varepsilon,m}(t), \gamma_{0}(u_{\varepsilon,m}(t)))||_{V_{p}}^{p} \le C,$$
(51)

for all $t \in (0,T)$. We have proved that the sequence $\{(u_{\varepsilon,m},\gamma_0(u_{\varepsilon,m}))\}$ is bounded in $C([0,T];V_p)$, and $\{(u'_{\varepsilon,m},\gamma_0(u'_{\varepsilon,m}))\}$ is bounded in $L^2(0,T;H)$, for all T > 0.

If we work with the truncated Galerkin equations (46)-(48) instead of the full PDE, we note that the calculations of the proof of (45) can be following identically to show that $\{(u_{\varepsilon,m}, \gamma_0(u_{\varepsilon,m}))\}$ is bounded in $L^p(0, T; V_p)$, for all T > 0.

Moreover, taking into account the uniqueness of solution to (2), using Aubin-Lions compactness lemma (e.g., cf. Lions [30]) and the fact that A_p is a monotone operator, it is not difficult to conclude that the sequence $\{(u_{\varepsilon,m}, \gamma_0(u_{\varepsilon,m}))\}$ converges weakly in $L^p(0, T; V_p)$ to the solution $(u_{\varepsilon}, \gamma_0(u_{\varepsilon}))$ to (2). Since the inclusion $V_p \subset H$ is compact (see (24)) and $(u_{\varepsilon}, \gamma_0(u_{\varepsilon})) \in C([0, T]; H)$, it follows using [33, Lemma 11.2] that

$$\sup_{\varepsilon \in [0,T]} \left\| \left(u_{\varepsilon}(t), \gamma_0(u_{\varepsilon}(t)) \right) \right\|_{V_p} \le C,$$

and, in particular, the second estimate in (43) is proved.

The extension of u_{ε} to the whole $\Omega \times (0, T)$: since the solution u_{ε} of the problem (2) is defined only in $\Omega_{\varepsilon} \times (0, T)$, we need to extend it to the whole $\Omega \times (0, T)$ to be able to state the convergence result. In order to do that, we shall use the following well-known extension result given by Donato and Moscariello [16, Lemma 2.4]: Let $\tilde{u}_{\varepsilon} \in W_0^{1,p}(\Omega)$ be a $W^{1,p}$ -extension of u_{ε} , that satisfies the following condition

$$|\nabla \tilde{u}_{\varepsilon}|_{p,\Omega} \le C |\nabla u_{\varepsilon}|_{p,\Omega_{\varepsilon}}.$$
(52)

Using (52) and taking into account Lemma 4.1, we obtain some *a priori* estimates for the extension of u_{ε} to the whole $\Omega \times (0, T)$.

Corollary 4.2. Assume the assumptions in Lemma 4.1. Then, there exists a $W^{1,p}$ -extension \tilde{u}_{ε} of the solution u_{ε} of the problem (2) into $\Omega \times (0,T)$, such that

$$\|\tilde{u}_{\varepsilon}\|_{p,\Omega,T} \le C, \quad \sup_{t \in [0,T]} \|\tilde{u}_{\varepsilon}(t)\|_{p,\Omega} \le C,$$
(53)

where the constant C does not depend on ε .

Proof. Using Poincaré's inequality, (52) and the first estimate in (43), we obtain

$$\|\tilde{u}_{\varepsilon}\|_{p,\Omega,T}^{p} = |\tilde{u}_{\varepsilon}|_{p,\Omega,T}^{p} + |\nabla \tilde{u}_{\varepsilon}|_{p,\Omega,T}^{p} \le C |\nabla \tilde{u}_{\varepsilon}|_{p,\Omega,T}^{p} \le C |\nabla u_{\varepsilon}|_{p,\Omega_{\varepsilon},T}^{p} \le C,$$

and the first estimate in (53) is proved. Similarly, using Poincaré's inequality, (52) and the second estimate in (43), we have the second estimate in (53). \Box

5 A compactness result

In this section, we obtain some compactness results about the behavior of the sequence \tilde{u}_{ε} satisfying the *a priori* estimates given in Corollary 4.2.

By $\chi_{\Omega_{\varepsilon}}$ we denote the characteristic function of the domain Ω_{ε} . Due to the periodicity of the domain Ω_{ε} , from [8, Theorem 2.6] one has, for $\varepsilon \to 0$, that

$$\chi_{\Omega_{\varepsilon}} \xrightarrow{*} \frac{|Y^*|}{|Y|}$$
 weakly-star in $L^{\infty}(\Omega)$, (54)

where the limit is the proportion of the material in the cell Y.

Let $\xi_{\varepsilon} := |\nabla u_{\varepsilon}|^{p-2} \nabla u_{\varepsilon}$ in $\Omega_{\varepsilon} \times (0, T)$ and let us denote by $\tilde{\xi}_{\varepsilon}$ its extension with zero to the whole of $\Omega \times (0, T)$, i.e.

$$\tilde{\xi}_{\varepsilon} = \begin{cases} \xi_{\varepsilon} & \text{in } \Omega_{\varepsilon} \times (0, T), \\ 0 & \text{in } (\Omega \setminus \overline{\Omega_{\varepsilon}}) \times (0, T). \end{cases}$$
(55)

Proposition 5.1. Under the assumptions in Lemma 4.1, there exists a function $u \in L^p(0,T; W_0^{1,p}(\Omega))$ (u will be the unique solution of the limit system (12)) and a function $\xi \in L^{p'}(0,T;L^{p'}(\Omega))$ such that, at least after extraction of a subsequence, we have the following convergences for all T > 0,

$$\tilde{u}_{\varepsilon}(t) \rightharpoonup u(t)$$
 weakly in $W_0^{1,p}(\Omega), \quad \forall t \in [0,T],$ (56)

(57)

$$\widetilde{u}_{\varepsilon}(t)|^{p-2}\widetilde{u}_{\varepsilon}(t) \to |u(t)|^{p-2}u(t) \quad strongly \ in \ L^{p'}(\Omega), \quad \forall t \in [0,T],$$
(58)

$$\begin{aligned} \tilde{u}_{\varepsilon}(t) &= u(t) & \text{weakly in } W_0^{-}(\Omega), \quad \forall t \in [0, T], \end{aligned}$$
(50)

$$\tilde{u}_{\varepsilon}(t) \to u(t) & \text{strongly in } L^p(\Omega), \quad \forall t \in [0, T], \end{aligned}$$
(57)

$$p|^{p-2}\tilde{u}_{\varepsilon}(t) \to |u(t)|^{p-2}u(t) & \text{strongly in } L^{p'}(\Omega), \quad \forall t \in [0, T], \end{aligned}$$
(58)

$$f(\tilde{u}_{\varepsilon}(t)) \to f(u(t)) & \text{strongly in } L^{q'_1}(\Omega), \quad \forall t \in [0, T], \end{aligned}$$
(59)

$$\tilde{\xi}_{\varepsilon} \to \xi & \text{weakly in } L^{p'}(0, T; L^{p'}(\Omega)). \end{aligned}$$
(60)

$$\xi \qquad \qquad \text{weakly in} \quad L^{p'}(0,T;L^{p'}(\Omega)), \tag{60}$$

where $\tilde{\xi}_{\varepsilon}$ is given by (55).

Let q_2 be the exponent satisfying (11). Let $\bar{q} > 1$ given by

$$\bar{q} \in (1, p)$$
 if $p = N$, $\bar{q} = \frac{Np}{(N-p)(q_2 - 2) + N}$ if $p < N$.

Assume that $q \in C^1(\mathbb{R})$. Then, we have the following convergences for all T > 0,

$$g(\tilde{u}_{\varepsilon}(t)) \to g(u(t))$$
 strongly in $L^{\bar{q}}(\Omega), \quad \forall t \in [0,T],$ (61)

$$g(\tilde{u}_{\varepsilon}(t)) \rightharpoonup g(u(t)) \qquad weakly \ in \quad W_0^{1,\bar{q}}(\Omega), \quad \forall t \in [0,T].$$
(62)

Proof. By the first estimate in (53), we observe that the sequence $\{\tilde{u}_{\varepsilon}\}$ is bounded in the space $L^p(0,T;W_0^{1,p}(\Omega))$, for all T > 0. Let us fix T > 0. Then, there exists a subsequence $\{\tilde{u}_{\varepsilon'}\} \subset \{\tilde{u}_{\varepsilon}\}$ and function $u \in L^p(0,T;W_0^{1,p}(\Omega))$ such that

$$\tilde{u}_{\varepsilon'} \rightharpoonup u \quad \text{weakly in } L^p(0,T; W^{1,p}_0(\Omega)).$$
 (63)

By the second estimate in (53), for each $t \in [0, T]$, we have that $\{\tilde{u}_{\varepsilon}(t)\}$ is bounded in $W_0^{1,p}(\Omega)$, and since we have (63), we can deduce (56). The conclusions of the Rellich-Kondrachov Theorem are also valid substituting $W^{1,p}(\Omega_{\varepsilon})$ for $W^{1,p}_0(\Omega)$, so using (17) and (56), we obtain

$$\tilde{u}_{\varepsilon'}(t) \to u(t)$$
 strongly in $L^r(\Omega), \quad \forall t \in [0,T],$ (64)

where $1 \leq r < p^{\star}$ if p < N and $p \leq r < p^{\star}$ if p = N. Observe that, in particular, we have (57).

On the other hand, observe that

$$||v|^{p-2}v| \le C(1+|v|^{p-1}),$$

then, applying [11, Theorem 2.4] for $G(x,v) = |v|^{p-2}v$, t = p' and r = p, we have that the map $v \in L^p(\Omega) \mapsto$ $|v|^{p-2}v \in L^{p'}(\Omega)$ is continuous in the strong topologies. Then, taking into account (64) with r = p, we get (58).

Thanks to (26), applying [11, Theorem 2.4] for G(x, v) = f(v), $t = q'_1$ and $r = q_1$, we have that the map $v \in L^{q_1}(\Omega) \mapsto f(v) \in L^{q'_1}(\Omega)$ is continuous in the strong topologies. Then, taking into account (64) with $r = q_1$, we get (59).

From the first estimate in (43) and (55), we have $|\tilde{\xi}_{\varepsilon}|_{p',\Omega,T} \leq C$, and hence, up to a subsequence, there exists $\xi \in L^{p'}(0, T, L^{p'}(\Omega))$ such that we obtain (60).

By the arbitrariness of T > 0, all the convergences are satisfied, as we wanted to prove.

Now, we analyze the convergences for the nonlinear term g. We separate the cases p < N and p = N. Case 1: p < N. Since

$$\frac{p^{\star}}{\bar{q}} = \frac{(N-p)(q_2-2)+N}{N-p} = q_2 - 1 + \frac{p}{N-p} > q_2 - 1,$$

there exists $r \in [2, p^{\star})$ such that $\frac{r}{\bar{q}} \ge q_2 - 1$ and

$$|g(s)| \le C\left(1+|s|^{q_2-1}\right) \le C\left(1+|s|^{\frac{r}{q}}\right).$$

Then, applying [11, Theorem 2.4] for G(x,v) = g(v), $t = \bar{q}$ and $r \in [2, p^*)$ such that $\frac{r}{\bar{q}} \ge q_2 - 1$, we have that the map $v \in L^r(\Omega) \mapsto g(v) \in L^{\bar{q}}(\Omega)$ is continuous in the strong topologies. Then, taking into account (64), we get (61).

Finally, we prove (62). Observe that as we are assuming that $g \in C^1(\mathbb{R})$, it is easy to see from (6) that there exists a constant C > 0 such that

$$|g'(s)| \le C\left(1 + |s|^{q_2 - 2}\right)$$

Then, we get

$$\int_{\Omega} \left| \frac{\partial g}{\partial x_{i}} (\tilde{u}_{\varepsilon}(t)) \right|^{\bar{q}} dx \leq C \int_{\Omega} \left(1 + |\tilde{u}_{\varepsilon}(t)|^{(q_{2}-2)\bar{q}} \right) \left| \frac{\partial \tilde{u}_{\varepsilon}(t)}{\partial x_{i}} \right|^{\bar{q}} dx \qquad (65)$$

$$\leq C \left(1 + \left(\int_{\Omega} |\tilde{u}_{\varepsilon}(t)|^{(q_{2}-2)\bar{q}\gamma} dx \right)^{1/\gamma} \right) \left(\int_{\Omega} |\nabla \tilde{u}_{\varepsilon}(t)|^{\bar{q}\eta} dx \right)^{1/\eta},$$

where we took γ and η such that $\bar{q}\eta = p$, $1/\gamma + 1/\eta = 1$ and $(q_2 - 2)\bar{q}\gamma = p^*$. Note that from here we get

$$\bar{q} = \frac{Np}{(N-p)(q_2-2)+N}.$$

Observe that $\bar{q} > 1$. Indeed,

$$q_2 \le \frac{(N-1)p}{N-p} = \frac{N(p-1)}{N-p} + 1 < \frac{N(p-1)}{N-p} + 2 \Rightarrow (N-p)(q_2-2) + N < Np \Rightarrow \frac{Np}{(N-p)(q_2-2) + N} > 1.$$

Then, we have

$$\int_{\Omega} \left| \frac{\partial g}{\partial x_i} (\tilde{u}_{\varepsilon}(t)) \right|^{\bar{q}} dx \quad \leq \quad C \left(1 + \left| \tilde{u}_{\varepsilon} \right|_{p^{\star},\Omega}^{p^{\star}/\gamma} \right) \left| \nabla \tilde{u}_{\varepsilon} \right|_{p,\Omega}^{p/\eta}.$$

The conclusions of (16) are also valid substituting $W^{1,p}(\Omega_{\varepsilon})$ for $W_0^{1,p}(\Omega)$, so using (16) and the second estimate in (53), we get

$$|\nabla g(\tilde{u}_{\varepsilon}(t))|_{\bar{q},\Omega} \le C.$$
(66)

Then, from (61) and (66), we can deduce (62).

Case 2: p = N. We consider $s \in [\frac{p(q_2-1)}{p-1}, +\infty)$ and

$$\bar{q} = \frac{sp}{p(q_2 - 2) + s}.$$
(67)

Taking into account (11), we can deduce

$$\frac{s}{\bar{q}} = \frac{p(q_2 - 2) + s}{p} = q_2 - 1 + \frac{s - p}{p} \ge q_2 - 1,$$

and, we have

$$|g(s)| \le C\left(1+|s|^{q_2-1}\right) \le C\left(1+|s|^{\frac{s}{q}}\right).$$

Then, applying [11, Theorem 2.4] for G(x, v) = g(v), $t = \bar{q}$ and r = s, we have that the map $v \in L^s(\Omega) \mapsto g(v) \in L^{\bar{q}}(\Omega)$ is continuous in the strong topologies. Thanks to (11), we can consider (64) with r = s, and we get (61).

Finally, we prove (62). In (65) we took γ and η such that $\bar{q}\eta = p$, $1/\gamma + 1/\eta = 1$ and $(q_2 - 2)\bar{q}\gamma = s$. Note that from here we get \bar{q} given by (67).

Observe that $\bar{q} \in (1, p)$. Indeed, taking into account that $\frac{1}{\bar{q}} = \frac{q_2 - 2}{s} + \frac{1}{p}$, we can deduce

$$\frac{p(q_2-1)}{p-1} \le s < +\infty \Rightarrow 0 < \frac{1}{s} \le \frac{p-1}{p(q_2-1)} \Rightarrow \frac{1}{p} < \frac{1}{\bar{q}} \le \frac{(q_2-2)(p-1)}{p(q_2-1)} + \frac{1}{p} \Rightarrow \frac{p(q_2-1)}{(q_2-2)(p-1) + (q_2-1)} \le \bar{q} < p,$$

and using that $\frac{p(q_2-1)}{(q_2-2)(p-1)+(q_2-1)} > 1$, we have that $\bar{q} \in (1,p)$.

Then, we have

$$\int_{\Omega} \left| \frac{\partial g}{\partial x_i} (\tilde{u}_{\varepsilon}(t)) \right|^{\overline{q}} dx \leq C \left(1 + \left| \tilde{u}_{\varepsilon} \right|_{s,\Omega}^{s/\gamma} \right) \left| \nabla \tilde{u}_{\varepsilon} \right|_{p,\Omega}^{p/\eta}.$$

The conclusions of (16) are also valid substituting $W^{1,p}(\Omega_{\varepsilon})$ for $W_0^{1,p}(\Omega)$, so using (16) and the second estimate in (53), we get

$$|\nabla g(\tilde{u}_{\varepsilon}(t))|_{\bar{q},\Omega} \le C.$$
(68)

Then, from (61) and (68), we can deduce (62).

6 Homogenized model: proof of the main Theorem

In this section, we identify the homogenized model.

We multiply system (2) by a test function $v \in \mathcal{D}(\Omega)$, and integrating by parts, we have

$$\frac{d}{dt} \left(\int_{\Omega} \chi_{\Omega_{\varepsilon}} \tilde{u}_{\varepsilon}(t) v dx \right) + \varepsilon \frac{d}{dt} \left(\int_{\partial F_{\varepsilon}} \gamma_0(u_{\varepsilon}(t)) v d\sigma(x) \right) + \int_{\Omega} \tilde{\xi}_{\varepsilon} \cdot \nabla v dx \\ + \kappa \int_{\Omega} \chi_{\Omega_{\varepsilon}} |\tilde{u}_{\varepsilon}(t)|^{p-2} \tilde{u}_{\varepsilon}(t) v dx + \int_{\Omega} \chi_{\Omega_{\varepsilon}} f(\tilde{u}_{\varepsilon}(t)) v dx + \varepsilon \int_{\partial F_{\varepsilon}} g(\gamma_0(u_{\varepsilon}(t))) v d\sigma(x) = 0,$$

in $\mathcal{D}'(0,T)$.

We consider $\varphi \in C_c^1([0,T])$ such that $\varphi(T) = 0$ and $\varphi(0) \neq 0$. Multiplying by φ and integrating between 0 and T, we have

$$-\varphi(0)\left(\int_{\Omega}\chi_{\Omega_{\varepsilon}}\tilde{u}_{\varepsilon}(0)vdx\right) - \int_{0}^{T}\frac{d}{dt}\varphi(t)\left(\int_{\Omega}\chi_{\Omega_{\varepsilon}}\tilde{u}_{\varepsilon}(t)vdx\right)dt$$
$$-\varepsilon\varphi(0)\left(\int_{\partial F_{\varepsilon}}\gamma_{0}(u_{\varepsilon}(0))vd\sigma(x)\right) - \varepsilon\int_{0}^{T}\frac{d}{dt}\varphi(t)\left(\int_{\partial F_{\varepsilon}}\gamma_{0}(u_{\varepsilon}(t))vd\sigma(x)\right)dt$$
$$+ \int_{0}^{T}\varphi(t)\int_{\Omega}\tilde{\xi}_{\varepsilon}\cdot\nabla vdxdt + \kappa\int_{0}^{T}\varphi(t)\int_{\Omega}\chi_{\Omega_{\varepsilon}}|\tilde{u}_{\varepsilon}(t)|^{p-2}\tilde{u}_{\varepsilon}(t)vdxdt$$
$$+ \int_{0}^{T}\varphi(t)\int_{\Omega}\chi_{\Omega_{\varepsilon}}f(\tilde{u}_{\varepsilon}(t))vdxdt + \varepsilon\int_{0}^{T}\varphi(t)\int_{\partial F_{\varepsilon}}g(\gamma_{0}(u_{\varepsilon}(t)))vd\sigma(x)dt = 0.$$
(69)

For the sake of clarity, we split the proof in five parts. Firstly, we pass to the limit, as $\varepsilon \to 0$, in (69) in order to get the limit equation satisfied by u. In the first step, we pass to the limit in the integrals on Ω , using Proposition 5.1 and (54), in the second step we pass to the limit in the integrals on the boundary of the holes, where we use a convergence result based on a technique introduced by Vanninathan [37], and in the third step we deduce the limit equation satisfied by u. In the fourth step we identify ξ making use of the solutions of the problems (13), and finally we prove that u is uniquely determined.

Step 1. Passing to the limit, as $\varepsilon \to 0$, in the integrals on Ω :

From (57)-(59) and (54), we have respectively, for $\varepsilon \to 0$,

$$\int_{\Omega} \chi_{\Omega_{\varepsilon}} \tilde{u}_{\varepsilon}(t) v dx \to \frac{|Y^*|}{|Y|} \int_{\Omega} u(t) v dx, \quad \forall v \in \mathcal{D}(\Omega),$$
$$\int_{\Omega} \chi_{\Omega_{\varepsilon}} |\tilde{u}_{\varepsilon}(t)|^{p-2} \tilde{u}_{\varepsilon}(t) v dx \to \frac{|Y^*|}{|Y|} \int_{\Omega} |u(t)|^{p-2} u(t) v dx, \quad \forall v \in \mathcal{D}(\Omega).$$

and

$$\int_{\Omega} \chi_{\Omega_{\varepsilon}} f(\tilde{u}_{\varepsilon}(t)) v dx \to \frac{|Y^*|}{|Y|} \int_{\Omega} f(u(t)) v dx, \quad \forall v \in \mathcal{D}(\Omega),$$

which integrating in time and using Lebesgue's Dominated Convergence Theorem, gives

$$\int_{0}^{T} \frac{d}{dt} \varphi(t) \left(\int_{\Omega} \chi_{\Omega_{\varepsilon}} \tilde{u}_{\varepsilon}(t) v dx \right) dt \to \frac{|Y^{*}|}{|Y|} \int_{0}^{T} \frac{d}{dt} \varphi(t) \left(\int_{\Omega} u(t) v dx \right) dt,$$
$$\kappa \int_{0}^{T} \varphi(t) \int_{\Omega} \chi_{\Omega_{\varepsilon}} |\tilde{u}_{\varepsilon}(t)|^{p-2} \tilde{u}_{\varepsilon}(t) v dx dt \to \kappa \frac{|Y^{*}|}{|Y|} \int_{0}^{T} \varphi(t) \int_{\Omega} |u(t)|^{p-2} u(t) v dx dt$$

and

$$\int_0^T \varphi(t) \int_\Omega \chi_{\Omega_\varepsilon} f(\tilde{u}_\varepsilon(t)) v dx dt \to \frac{|Y^*|}{|Y|} \int_0^T \varphi(t) \int_\Omega f(u(t)) v dx dt.$$

By (57) and (54), we have

On the other hand, using (60), we obtain, for $\varepsilon \to 0$

Step 2. Passing to the limit, as $\varepsilon \to 0$, in the surface integrals on the boundary of the holes:

We make use of the technique introduced by Vanninathan [37] for the Steklov problem which transforms surface integrals into volume integrals. This technique was already used as a main tool to homogenize the non homogeneous Neumann problem for the elliptic case by Cioranescu and Donato [7].

By [7, Definition 3.2], let us introduce, for any $h \in L^{s'}(\partial F)$, $1 \leq s' \leq \infty$, the linear form μ_h^{ε} on $W_0^{1,s}(\Omega)$ defined by

where $\langle \mu_h, \varphi \rangle = \mu_h \int_{\Omega} \varphi(x) dx$, with

In the particular case in which $h \in L^{\infty}(\partial F)$ or even when h is constant, we have

 strongly in $W^{-1,\infty}(\Omega)$.

We denote by μ_1^{ε} the above introduced measure in the particular case in which h = 1. Notice that in this case μ_h becomes $\mu_1 = |\partial F|/|Y|$.

Observe that from (56) and (70) with s = p, we can deduce, for $\varepsilon \to 0$,

for all $v \in \mathcal{D}(\Omega)$, which integrating in time and using Lebesgue's Dominated Convergence Theorem, gives

Moreover, from (56) and (70) with s = p, we can deduce, for $\varepsilon \to 0$,

$$\varepsilon \int_{\partial F_{\varepsilon}} \gamma_0(u_{\varepsilon}(0)) v d\sigma(x) = \langle \mu_1^{\varepsilon}, \tilde{u}_{\varepsilon|_{\Omega_{\varepsilon}}}(0) v \rangle \to \mu_1 \int_{\Omega} u(0) v dx = \frac{|\partial F|}{|Y|} \int_{\Omega} u(0) v dx,$$

for all $v \in \mathcal{D}(\Omega)$.

On the other hand, from (62) and (70) with $s = \bar{q}$, we conclude

$$\varepsilon \int_{\partial F_{\varepsilon}} g(\gamma_0(u_{\varepsilon}(t))) v d\sigma(x) = \langle \mu_1^{\varepsilon}, g(\tilde{u}_{\varepsilon}(t)) v \rangle \to \frac{|\partial F|}{|Y|} \int_{\Omega} g(u(t)) v dx,$$

for all $v \in \mathcal{D}(\Omega)$, which integrating in time and using Lebesgue's Dominated Convergence Theorem, gives

$$\varepsilon \int_0^T \varphi(t) \int_{\partial F_\varepsilon} g(\gamma_0(u_\varepsilon(t))) v d\sigma(x) dt \to \frac{|\partial F|}{|Y|} \int_0^T \varphi(t) \int_\Omega g(u(t)) v dx dt.$$

Step 3. Passing to the limit, as $\varepsilon \to 0$, in (69):

All the terms in (69) pass to the limit, as $\varepsilon \to 0$, and therefore taking into account the previous steps, we get

$$+ \int_{0}^{T}\varphi(t)\int_{\Omega}\xi\cdot\nabla vdxdt + \kappa\frac{|Y^*|}{|Y|}\int_{0}^{T}\varphi(t)\int_{\Omega}|u(t)|^{p-2}u(t)vdxdt$$
$$+ \frac{|Y^*|}{|Y|}\int_{0}^{T}\varphi(t)\int_{\Omega}f(u(t))vdxdt + \frac{|\partial F|}{|Y|}\int_{0}^{T}\varphi(t)\int_{\Omega}g(u(t))vdxdt = 0.$$
(71)

Hence, ξ verifies

$$\left(\frac{|Y^*|}{|Y|} + \frac{|\partial F|}{|Y|}\right)\frac{\partial u}{\partial t} - \operatorname{div}\xi + \frac{|Y^*|}{|Y|}\left(\kappa|u|^{p-2}u + f(u)\right) + \frac{|\partial F|}{|Y|}g(u) = 0, \quad \text{in} \quad \Omega \times (0,T).$$
(72)

Step 4. It remains now to identify ξ . For the sake of completeness, we give a sketch of a proof, following, for instance, the proof of [16, Theorem 3.1].

Let us consider $\forall \nu \in \mathbb{N}$ and for any i = 1, ..., N, a partition of \mathbb{R}^N by intervals $\{Q_{i\nu}\}_i$ of side $2^{-\nu}$. Since the holes F_{ε} do not intersect $\partial \Omega$, we can assume that $\forall \varepsilon > 0$, F_{ε} does not intersect $\partial Q_{i\nu}$. Let us denote by $x_{i\nu}$ and $\chi_{i\nu}$ respectively the center and the characteristic function of $Q_{i\nu}$. Then, we define $I_{\nu} = \{i : Q_{i\nu} \subset \Omega\}$, $\Omega_{\nu} = \bigcup_{i \in I_{\nu}} Q_{i\nu}$. For any *i*, let us denote

$$\langle \nabla u \rangle_{i\nu} := \frac{1}{|Q_{i\nu}|} \int_{Q_{i\nu}} \nabla u(x) dx.$$

By the continuity of b (see [16, Lemma 2.11]), we have, if $\nu \to +\infty$, that

where b is given by (14).

Moreover, from [16, Lemma 2.10], we have for any measurable set $E \subset \Omega$ that

Let $w_{i\nu} \in \langle \nabla u \rangle_{i\nu} \cdot y + \mathbb{H}_{per}(Y^*)$ the solution of the problem (13) corresponding to $\langle \nabla u \rangle_{i\nu}$. Then

and so, by [16, Lemma 2.3], we can consider $\tilde{v}_{i\nu} \in \mathbb{H}_{per}(Y)$, where $\tilde{\cdot}$ denotes the $W^{1,p}$ -extension to Y. If we extend $\tilde{v}_{i\nu}$, by periodicity, the resulting function (still denoted by $\tilde{v}_{i\nu}$) is in $W^{1,p}(\Omega)$.

Let us define

Arguing as in the proof of [16, Lemma 2.13], we obtain

$$\widetilde{a}_p(\nabla \Psi_{i\nu}^{\varepsilon}) \rightharpoonup b(\langle \nabla u \rangle_{i\nu}) \quad \text{weakly in} \quad L^{p'}(\Omega),$$
(77)

and

$$\operatorname{div}\widetilde{a}_p(\nabla\Psi_{i\nu}^{\varepsilon}) = 0. \tag{78}$$

By Rellich-Kondrachov Theorem and (76), we can deduce

Using the periodicity of $\tilde{v}_{i\nu}$ and [16, Lemma 2.3], we have

Then, due to the structure properties of b (see [16, Lemma 2.10]), writing the last term as an integral over Ω_{ν} , we have

$$\sum_{i\in I_{\nu}} \int_{Q_{i\nu}} |\nabla \Psi_{i\nu}^{\varepsilon}|^p dx \le C \left(1 + \varepsilon^N 2^{\nu N}\right) \int_{\Omega} \left(1 + |\nabla u|\right)^p dx.$$
(80)

Let now $\eta \in C_0^1(Q_{i\nu}), 0 \le \eta \le 1$, and extend it by periodicity to the whole \mathbb{R}^N . We consider $\varphi \in C_c^1([0,T])$ such that $\varphi(T) = 0$ and $\varphi(0) \ne 0$. If $\psi \in C^0(\overline{\Omega})$, set $M_{\psi} = \sup_{\Omega} |\psi|$ and $M_{\varphi} = \sup_{[0,T]} |\varphi|$, we have

$$\left| \int_{0}^{T} \varphi(t) \int_{\Omega} \tilde{\xi}_{\varepsilon} \psi \eta dx dt - \int_{0}^{T} \varphi(t) \sum_{i \in I_{\nu}} \int_{Q_{i\nu}} \tilde{a}_{p} (\nabla \Psi_{i\nu}^{\varepsilon}) \psi \eta dx dt \right|$$

$$\tag{81}$$

$$\leq CM_{\psi}M_{\varphi}|\Omega \setminus \Omega_{\nu}|^{1/p} + \left| \int_{0}^{T} \varphi(t) \sum_{i \in I_{\nu}} \int_{Q_{i\nu} \cap \Omega_{\varepsilon}} \left(|\nabla u_{\varepsilon}|^{p-2} \nabla u_{\varepsilon} - |\nabla \Psi_{i\nu}^{\varepsilon}|^{p-2} \nabla \Psi_{i\nu}^{\varepsilon} \right) \psi \eta dx dt \right|$$

$$\leq CM_{\psi}M_{\varphi}|\Omega \setminus \Omega_{\nu}|^{1/p} + \int_{0}^{T}\varphi(t)\sum_{i\in I_{\nu}}\int_{Q_{i\nu}\cap\Omega_{\varepsilon}}M_{\psi}\eta\left(\left(|\nabla u_{\varepsilon}| + |\nabla\Psi_{i\nu}^{\varepsilon}|\right)^{p-2}\cdot|\nabla u_{\varepsilon} - \nabla\Psi_{i\nu}^{\varepsilon}|\right)dxdt$$

$$\leq CM_{\psi}M_{\varphi}|\Omega\setminus\Omega_{\nu}|^{1/p} + CM_{\psi}^{p/(p-1)}\delta^{p/(p-1)}\left(1+\varepsilon^{N}2^{\nu N}\right) + \delta^{-p}\int_{0}^{T}\varphi(t)\sum_{i\in I_{\nu}}\int_{Q_{i\nu}\cap\Omega_{\varepsilon}}\eta|\nabla u_{\varepsilon}-\nabla\Psi_{i\nu}^{\varepsilon}|^{p}dxdt,$$

where the last inequality is obtained by applying Young inequality with $\delta > 0$ and the first estimate in (43), the first estimate in (53) and (80).

On the other hand, from monotonicity, we can deduce

= \int_{0}^{T} \varphi(t) \sum_{i \in I_{\nu}} \int_{Q_{i\nu}} \eta \left(\tilde{\xi}_{\varepsilon} - \tilde{a}_{p} (\nabla \Psi_{i\nu}^{\varepsilon}) \right) \cdot \nabla \rho_{i\nu}^{\varepsilon} dx dt \qquad (82) \\
+ \int_{0}^{T} \varphi(t) \sum_{i \in I_{\nu}} \int_{Q_{i\nu}} \eta \left(\tilde{\xi}_{\varepsilon} - \tilde{a}_{p} (\nabla \Psi_{i\nu}^{\varepsilon}) \right) \cdot (\nabla u - \langle \nabla u \rangle_{i\nu}) dx dt,$$

where $\rho_{i\nu}^{\varepsilon} := \tilde{u}_{\varepsilon} - \Psi_{i\nu}^{\varepsilon} - u + \langle \nabla u \rangle_{i\nu} \cdot x$. Taking into account (57) and (79), we have

Now, we multiply system (2) by the test function $\eta \rho_{i\nu}^{\varepsilon}$ and integrating by parts, we get

$$\begin{split} \int_0^T \varphi(t) \sum_{i \in I_\nu} \int_{Q_{i\nu}} \eta \tilde{\xi}_{\varepsilon} \cdot \nabla \rho_{i\nu}^{\varepsilon} dx dt &= -\sum_{i \in I_\nu} \int_{Q_{i\nu}} \varphi(0) \chi_{\Omega_{\varepsilon}} \tilde{u}_{\varepsilon}(0) \eta \rho_{i\nu}^{\varepsilon} dx \\ &- \int_0^T \frac{d}{dt} \varphi(t) \sum_{i \in I_\nu} \int_{Q_{i\nu}} \chi_{\Omega_{\varepsilon}} \tilde{u}_{\varepsilon}(t) \eta \rho_{i\nu}^{\varepsilon} dx dt - \varphi(0) \langle \mu_1^{\varepsilon}, \tilde{u}_{\varepsilon|_{\Omega_{\varepsilon}}}(0) \eta \rho_{i\nu}^{\varepsilon} \rangle - \int_0^T \frac{d}{dt} \varphi(t) \langle \mu_1^{\varepsilon}, \tilde{u}_{\varepsilon|_{\Omega_{\varepsilon}}}(t) \eta \rho_{i\nu}^{\varepsilon} \rangle dt \\ &- \int_0^T \varphi(t) \sum_{i \in I_\nu} \int_{Q_{i\nu}} \tilde{\xi}_{\varepsilon} \cdot \nabla \eta \rho_{i\nu}^{\varepsilon} dx dt - \kappa \int_0^T \varphi(t) \sum_{i \in I_\nu} \int_{Q_{i\nu}} \chi_{\Omega_{\varepsilon}} |\tilde{u}_{\varepsilon}(t)|^{p-2} \tilde{u}_{\varepsilon}(t) \eta \rho_{i\nu}^{\varepsilon} dx dt \\ &- \int_0^T \varphi(t) \sum_{i \in I_\nu} \int_{Q_{i\nu}} \chi_{\Omega_{\varepsilon}} f(\tilde{u}_{\varepsilon}(t)) \eta \rho_{i\nu}^{\varepsilon} dx dt - \int_0^T \varphi(t) \langle \mu_1^{\varepsilon}, g(\tilde{u}_{\varepsilon}(t)) \rho_{i\nu}^{\varepsilon} \rangle dt. \end{split}$$

We pass to the limit, as $\varepsilon \to 0$. Taking into account (83), we reason as in the first two steps and we can deduce

$$\int_{0}^{T} \varphi(t) \sum_{i \in I_{\nu}} \int_{Q_{i\nu}} \eta \tilde{\xi}_{\varepsilon} \cdot \nabla \rho_{i\nu}^{\varepsilon} dx dt \to 0.$$
(84)

On the other hand, integrating by parts, taking into account (77)-(78) and (83), as $\varepsilon \to 0$, by Lebesgue's Dominated Convergence Theorem, we obtain

(85)

Then, passing to the limit, as $\varepsilon \to 0$, in (82), by (60), (77), (84)-(85), we obtain

(86)

If we first pass to the limit in (81), as $\varepsilon \to 0$, then $\eta \to 1, \nu \to +\infty$, by (60), (74), (77) and (86) we get

Moreover, taking into account (87) in (71), we obtain exactly the variational formulation of the limit problem (12), so we get the initial condition of (12). A weak solution of (12) is any function u, satisfying

$$\tag{90}$$

and

$$u(0) = u_0. (91)$$

Due to the structure properties of b (see [16, Lemmas 2.10-2.13]), applying a slight modification of [30, Chapter 2, Theorem 1.4], we obtain that the problem (12) has a unique solution. We give a sketch of a proof.

From [16, Lemmas 2.10-2.13]), for any $\zeta \in \mathbb{R}^N$, we have

$$|b(\zeta)| \le c(1+|\zeta|)^{p-1},$$
(92)

where c > 0, and for $\zeta_1, \zeta_2 \in \mathbb{R}^N$, we have

$$(b(\zeta_1) - b(\zeta_2), \zeta_1 - \zeta_2) \ge \alpha |\zeta_1 - \zeta_2|^p, \quad \text{if } p \ge 2,$$
(93)

where $\alpha > 0$.

On the space $W_0^{1,p}(\Omega)$ we define the nonlinear monotone operator $A_p: W_0^{1,p}(\Omega) \to (W_0^{1,p}(\Omega))'$, given by

$$\langle A_p(v), w \rangle = C_1(b(\nabla v), \nabla w)_{\Omega} + C_1 \frac{|Y^*|}{|Y|} \kappa(|v|^{p-2}v, w)_{\Omega}, \quad \forall v, w \in W_0^{1,p}(\Omega),$$
(94)

where $C_1 = \left(\frac{|Y^*|}{|Y|} + \frac{|\partial F|}{|Y|}\right)^{-1}$.

We observe that A_p is coercive. In fact, taking into account (93) with $\zeta_1 = \nabla v$ and $\zeta_2 = 0$, we have

$$\langle A_p(v), v \rangle = C_1(b(\nabla v), \nabla v)_{\Omega} + C_1 \frac{|Y^*|}{|Y|} \kappa |v|_{p,\Omega}^p$$

$$\geq C_1 \alpha |\nabla v|_{p,\Omega}^p + C_1 \int_{\Omega} b(0) \nabla v dx + C_1 \frac{|Y^*|}{|Y|} \kappa |v|_{p,\Omega}^p,$$

$$(95)$$

for all $v \in W_0^{1,p}(\Omega)$.

On the other hand, using (92) with $\zeta=0$ and Young's inequality, we can deduce

$$\left| \int_{\Omega} b(0) \nabla v dx \right| \leq \int_{\Omega} c |\nabla v| dx \leq \frac{2}{p\alpha} \frac{c^{p'}}{p'} |\Omega| + \frac{\alpha}{2} |\nabla v|_{p,\Omega}^{p},$$
(96)

where $|\Omega|$ denotes the measure of Ω and p' is the conjugate exponent of p.

Then, taking into account (96) in (95), we obtain

$$\langle A_{p}(v), v \rangle + C_{1} \frac{2}{p\alpha} \frac{c^{p'}}{p'} |\Omega| \geq C_{1} \frac{\alpha}{2} |\nabla v|_{p,\Omega}^{p} + C_{1} \frac{|Y^{*}|}{|Y|} \kappa |v|_{p,\Omega}^{p} \geq \min\{C_{1} \frac{\alpha}{2}, C_{1} \frac{|Y^{*}|}{|Y|} \kappa\} ||v||_{p,\Omega}^{p},$$

for all $v \in W_0^{1,p}(\Omega)$, so A_p is coercive.

Let us denote

$$V_1 = W_0^{1,p}(\Omega), \quad V_2 = L^{q_1}(\Omega), \quad V_3 = L^{q_2}(\Omega),$$

$$A_1(v) = A_p, \quad A_2(v) = C_1 \frac{|Y^*|}{|Y|} f(v), \quad A_3(v) = C_1 \frac{|\partial F|}{|Y|} g(v).$$

From (26) one deduces that $A_i: V_i \to V'_i$ for i = 2, 3.

Taking into account the continuous embedding (16) for Ω , and the assumptions (3) and (11), we have the following useful continuous inclusions

$$W_0^{1,p}(\Omega) \subset W^{1,p}(\Omega) \subset L^{q_1}(\Omega) \subset L^2(\Omega), \quad W_0^{1,p}(\Omega) \subset W^{1,p}(\Omega) \subset L^{q_2}(\Omega) \subset L^2(\Omega),$$
(97)

and

$$L^{2}(\Omega) \subset L^{q'_{1}}(\Omega) \subset \left(W^{1,p}(\Omega)\right)' \subset \left(W^{1,p}_{0}(\Omega)\right)', \quad L^{2}(\Omega) \subset L^{q'_{2}}(\Omega) \subset \left(W^{1,p}(\Omega)\right)' \subset \left(W^{1,p}_{0}(\Omega)\right)', \tag{98}$$

where $(W^{1,p}(\Omega))'$ and $(W^{1,p}_0(\Omega))'$ denote the dual of $W^{1,p}(\Omega)$ and $W^{1,p}_0(\Omega)$, respectively.

With this notation, and denoting $V = \bigcap_{i=1}^{3} V_i = W_0^{1,p}(\Omega)$, $p_1 = p$, $p_2 = q_1$, $p_3 = q_2$, one has that (88)–(91) is equivalent to

$$u \in C([0,T]; L^{2}(\Omega)), \quad u \in \bigcap_{i=1}^{3} L^{p_{i}}(0,T; V_{i}) = L^{p}(0,T; W_{0}^{1,p}(\Omega)), \quad \text{for all } T > 0,$$
(99)

$$u'(t) + \sum_{i=1}^{3} A_i(u(t)) = 0 \quad \text{in } \mathcal{D}'(0, T; V'),$$
(100)

$$u(0) = u_0.$$
 (101)

Taking into account (97)-(98) and applying a slight modification of [30, Ch.2, Th.1.4], it is not difficult to see that problem (99)–(101) has a unique solution. As u is uniquely determined, the whole sequence \tilde{u}_{ε} converges to u and this completes the proof of Theorem 1.1.
