42 Abstract

43 Purpose. South Africa is undergoing rapid urban transition favoring ideals of thinness which 44 increases eating disorders risk for female adolescents, while older women continue to uphold 45 corpulence as a female cultural value. This study aims to assess the potential conflicting 46 relationship between urban male and female adolescents' weight loss attempts (WLA) and 47 maternal body image norms within households.

Methods. The study included a longitudinal sample of mother-daughter and mother-son pairs from the Birth to Twenty Plus Cohort (Bt20+) (N=1613), utilizing data collected at 13, 17 and 22 years. Sociodemographic characteristics, eating attitudes, WLA and body mass index (BMI) were assessed in mothers and their offspring. Relationships between maternal factors and offspring's WLA were assessed using both logistic regression and structural equation modelling.

Results. More females had WLA compared to their male counterparts at 13, 17 and 22 years. Multivariable models showed an independent positive association between maternal household socioeconomic status and boys' WLA at 13 years, while independent negative associations were found between mothers' BMI and boys' WLA at 17 and 22 years. Mothers' age and sons' WLA at 22 years showed an independent positive association. No association was found between maternal factors and daughters' WLA.

60 **Conclusions.** Strong gender-differentiated intergenerational patterns were observed between 61 maternal factors and offspring's WLA from early adolescence to early adulthood. The lack of 62 relationship between maternal factors and daughters' behavior in contrast to that of sons 63 suggests that Western acculturation may pose a greater risk for females to modern body image 64 disturbances and eating disorders.

66 Introduction

Over the past several decades, there has been increasing stigmatization of body weight 67 alongside rising rates of obesity in high-income countries (HICs).¹ Body weight norms 68 promoting thinness as the preferred body size have been reported to exacerbate psychological 69 and eating attitude disturbances among overweight and obese people, including African 70 populations.^{2,3} In addition, with increasing urbanization and exposure to Western media and 71 obesity prevalence in sub-Saharan Africa (SSA)⁴, African countries are increasingly affected 72 by emerging norms on thinness⁵. This is accentuated in emerging transitional countries such 73 as South Africa and among younger generations. 74

Even though media can influence contemporary thinking in favor of thinner body sizes amongst South African youth as well as African migrants,^{6–8} traditional African norms around stoutness as a symbol of wealth, peacefulness, health and fertility remain.^{9–11} In transitional contexts, stoutness is perceived to be a protective factor against modern body image disturbances and eating disorders, serving to counteract Western norms of thinness. Young people occupy a critical position between these two cultural models.^{12–14}

Moreover, many South African studies show coexistence between admiration and 81 stigmatization of stoutness. Older Black populations perceive stoutness as a symbol of health 82 and prosperity whilst younger people consider body fat as indicative of disease and sexual 83 undesirability^{15,16} While parents may still transmit traditional perceptions around large body 84 size to their children^{16,17}, young people acculturated by modernization increasingly eschew 85 overweight and obesity.^{18,19} Some studies also show that parents' lifestyle and behaviors can 86 influence their children's body weight perceptions and management^{20,21}, with the potential for 87 intergenerational transmission of body image disturbances and eating disorders.^{20–23} 88

Recent South African studies show that adolescents are exposed to modern body image norms
in urban areas from an early age.¹⁸ The impact of Western media is reported to be greater

among adolescent females than males regarding body weight perception and management¹⁵, 91 92 but the influence of maternal behaviors and lifestyle on sons' and daughters' body image and weight management remains underexplored. As in other studies conducted in Western 93 countries^{24,25}, we assume that the familial environment of adolescents, including maternal 94 BMI and eating attitudes, could impact on their body image and weight management. 95 Therefore, this study aims to examine the intergenerational association between maternal 96 factors (sociodemographic characteristics, body size and eating attitudes) and weight loss 97 behaviors among adolescent sons and daughters within families living in Soweto, a poor 98 urban South African township with high rates of obesity.²⁶ 99

101 Methods

102 *Sample*

The current study consisted of a sample of 1,613 mother-adolescent (both sexes) pairs from the Birth to Twenty Plus cohort study (Bt20+). The Bt20+ study aimed to investigate the determinants of health and development among children and families in Soweto, Johannesburg.²⁷ Data were collected longitudinally on sociodemographic characteristics, maternal and adolescent eating attitudes, weight loss behaviors, and Body Mass Index (BMI) of both mothers and their children when aged 13 (early adolescence), 17 (late adolescence) and 22 years (early adulthood). Mothers were studied once when their child was 12 years old.

111 Measures

112 Data instruments were administered to both adolescents (males and females) and mothers.

113 Sociodemographic characteristics

114 Maternal sociodemographic characteristics that were assessed included age, socioeconomic 115 status (SES) and level of education. SES was assessed by enumeration of the assets in the household and education was assessed by collecting the highest academic grade (e.g. grade 7)
reached by the mother.²⁸

119 Weight Loss Attempt (WLA)

Participants were asked if they had engaged in behaviors with an aim to lose weight during the past year. A positive response coded as "weight loss attempt" indicated a WLA and a negative response coded as "no weight loss attempt" indicated an absence of WLA.

124 *Eating attitudes*

125 The risk of eating disorders was measured using a 26-item questionnaire, the Eating Attitudes Test-26 (EAT-26) administered by study field workers.²⁹ The EAT-26 is one of the most 126 widely used standardized measures to assess eating disorders risk based on feelings and 127 128 behaviors related to symptoms and concerns characteristic of eating disorders (e.g. vomiting after meal, food phobia and restriction, body weight concern). The EAT-26 can be used as a 129 130 whole to assess a global eating disorders risk (as in this study) but can also be divided into three subscales (Dieting, Bulimia and Food Preoccupation and Oral Control subscales) to 131 more specifically assess these main dimensions of eating disorders risk. The 26 items were on 132 a Likert scale and coded using the system developed by Garner et al.²⁹ The EAT-26 varies 133 from 0 (minor value) to 78 (major value). An EAT-26 score of > 20 indicates the need for 134 clinical referral due to risk of eating disorders. The instrument's reliability in other South 135 African studies ranged from α (Cronbach's) of 0.75 to 0.79.¹⁴ 136

138 Anthropometry

A portable stadiometer (Holtain, UK) was used to measure height, recorded to the nearest
mm. Weight was measured using a digital weighing scale and recorded to the nearest 100g.

From these measures, BMI was calculated as: weight (kg)/height (m) ². Underweight was defined as a BMI < 18.5 kg/m², normal weight as \geq 18.5 kg/m² and < 25 kg/m², overweight as \geq 25 kg/m², and obesity as \geq 30 kg/m².

145 *Statistical analysis*

Stata software 15.1 (StataCorp, College Station, TX) was used for all analyses. We used the 146 chi square test to evaluate the prevalence of underweight, overweight, obesity, and eating 147 disorders risk (EAT-26 scores \geq 20), and the frequency of WLA. Normality of continuous 148 variables was checked using the Shapiro-Wilk test, and study characteristics were compared 149 150 between males and females using the Wilcoxon sum-rank and chi square tests. Logistic regression was performed to assess the associations between maternal factors and WLA 151 among their adolescent children at ages 13, 17 and 22 years, separately for males and females; 152 153 logistic regression was used since the response variable of interest (WLA) is binomial. We used BMI as a continuous rather than a categorical variable for better statistical power. Odds 154 ratios (ORs), 95% confidence intervals (CIs) and p-values were reported.³⁰ 155

Structural equation modelling (SEM) was used to determine whether there was an 156 intergenerational effect of maternal factors on offspring early adulthood WLA (i.e. age 22 157 years) through specific pathways³¹. Multivariable analyses performed using SEM were guided 158 by an *a priori* conceptual model (Figure 1). We hypothesized that: 1) maternal factors (BMI, 159 education, eating disorders risk and age) are associated with BMI (at 13, 17 and 22 years), 160 eating disorders risk (at 13, 17 and 22 years) and WLA at 22 years, and 2) BMI (at 13, 17 and 161 22 years) and eating disorders risk (at 13, 17 and 22 years) are associated with WLA at 22 162 years. We conducted our analyses separately for males and females. 163

166 *Ethics*

167 The study was approved by the Human Research Ethics Committee (Medical) of the 168 University of the Witwatersrand. The present secondary analysis was approved by the 169 Stanford Institutional Review Board. All participants gave written informed consent and 170 assent was provided by children under the age of 18 years.

172 **Results**

173 Descriptive statistics

A total of 1,613 mothers were included in the analyses (Table 1). The majority of mothers completed at least Grade 8, 86% had scores indicative of risk for eating disorders (i.e., greater or equal to 20), and 27.5% had a WLA, with a BMI median of 30 kg/m². On average, households in our sample had four physical assets. Adolescent children of the maternal participants were nearly evenly distributed by sex (Table 2).

Table 1

Females had higher BMIs compared to males at ages 13, 17 and 22 years (p<0.001 for each). More female adolescents wanted to change their weight compared to their male counterparts at 13 (p=0.018), 17 (p<0.001) and 22 years (p<0.001). The EAT-26 score was similar at all three ages in both sexes, but with a median significantly higher in girls than in boys at 17 years.

186 Pair-wise correlations between eating disorders risk and BMI

187 The correlations between eating disorders risk and BMI were 0.1 at 13 years, 0.05 at 17 years

- and 0.1 at 22 years, indicating a small positive correlation at the 3 measurement points.
- 189 Separately, BMIs measured at 13, 17 and 22 years were highly correlated with each other.
- 190 Eating disorders risk at 13 had low positive correlation with eating disorders risk at 17 and 22

years (rho=0.05 and 0.07, respectively) while eating disorders risk at 17 was moderately
correlated with eating disorders risk at 22 years (rho=0.45). Only the correlation between 13
and 17 years was not significant (Supplementary Table 1).

195 Logistic regressions for WLA

Maternal WLA was associated with lower eating disorders risk, lower maternal age, highereducation level (Grade 8 and more) and higher maternal BMI (Supplementary Table 2).

198 At age 13, boys' WLA was associated with higher maternal SES (Supplementary Table 3).

199 No maternal factors were associated with WLA among girls at age 13. Higher girls' BMI was

- 200 persistently associated with their WLA in the hierarchical regressions (Supplementary Table201 4).
- At age 17, boys' WLA was associated with their BMI. The odds for WLA were higher by 50% [OR=1.53; 95% CI (1.27; 1.84)] among boys with higher BMI. In addition, lower maternal BMI was associated with boys' WLA. Among girls, their higher BMI and eating disorders risk were significantly associated with WLA (Table 3, Supplementary Table 5).

Table 3

At age 22 years among males, there was strong evidence that WLA was associated with their own higher eating disorders risk and BMI, lower maternal BMI and higher maternal age (Supplementary Table 6). However, among females aged 22 years, WLA was associated with their own high eating disorders risk and higher BMI (Supplementary Table 7).

212 Structural Equation Model results

Table 4 summarizes the results from the SEM for WLA at 22 years, based on the conceptual
framework shown in Figure 1. Supplementary Figures 1 and 2 show pathways for WLA.
Among both sons and daughters, WLA was associated with higher BMI and higher eating

disorders risk at 22 years. In addition, for boys only, higher BMI at 13 years, higher maternal
age, and lower maternal BMI were also significantly associated with WLA.

Maternal education was found to be indirectly associated with sons' WLA at 22 years through eating disorders risk at 22 years and BMI at 22 years. In addition, maternal BMI had an indirect effect on WLA at 22 years through higher eating disorders risk at 22 years and BMI at 22 years. Further, maternal age was indirectly associated with WLA at age 22 through BMI at 13 years. For females, as shown in Supplementary Figure 2, only maternal BMI was indirectly associated with WLA through BMI at 22 years.

226 **Discussion**

227 This study analyzed the relationships between multiple maternal factors and daughters' and 228 sons' body weight management in a poor-urban, obesogenic environment (Soweto, South Africa). We observed that multiple maternal factors, including higher maternal SES, higher 229 230 maternal age and lower maternal BMI were associated with sons' WLA. Moreover, a negative association between maternal BMI and sons' WLA was found at ages 13 and 17. In contrast, 231 no association between maternal factors and daughters' WLA was found, even though the 232 233 frequency of WLA was significantly higher among daughters than sons at the three time points. 234

We first observed that the prevalence of WLA was significantly higher in daughters than in sons and this trend could be undoubtedly linked to the significantly higher eating attitude median score in daughters than in sons at age 17 years. Therefore, WLA practices were higher in daughters, a trend commonly identified in other South African and Western studies.^{15,32} Globally, the impact of the norm of thinness, through Western media, appears to be stronger in young females than in males as women are more targeted by the media and affected by fatness stigmatization.^{33,34} This trend, identified around the world, is confirmed by our results
showing that WLA was significantly associated with increasing BMI and eating disorders risk
at earlier time points in daughters than in sons.

In Soweto, most mothers are single and suffer from overweight or obesity.^{35,36} In this 244 household environment, daughters and sons are confronted daily with household members 245 who are overweight and possibly obese, and this excess of fat is frequently associated with 246 eating disorders risk. The maternal lifestyle, especially eating behaviors, choice of foods and 247 dietary intake can expose her offspring to obesity.²⁰ Moreover, maternal normalization and 248 valorization of obesity, already identified in several African studies,^{23,37} can make overweight 249 and obesity the body norm at home for children, as observed in a recent South African 250 study.¹⁷ Thus, adolescents living in urban-poor Soweto could be exposed to two distinct body 251 norm models, with the household environment and cultural values potentially promoting 252 253 stoutness, and the adolescent peer network reinforced by media images and messages promoting thinness, as discussed in a recent South African study.²³ The impact of these two 254 255 exposures has rarely been studied.

Our results demonstrate that the impact of maternal factors was stronger in sons than in 256 daughters. Importantly, we observed that decreasing maternal BMI was associated with 257 increasing WLA in sons. This finding does not mean that sons' WLA is only driven by 258 259 maternal factors. Males' WLA is also positively associated with their own BMI at 17 and 22 years, and their eating disorders risk at 22 years. The recent literature in Western countries 260 shows that the impact of media on body image and weight management is also affecting 261 young men, although the trend seems lower than in young women.³⁸ In South Africa, a similar 262 tendency was found, with young black men having body image concerns and eating disorders 263 risk equivalent to their young black female counterparts, and an engagement in unhealthy 264 control behaviors.¹⁵ 265

Secondly, we found that decreasing maternal age was associated with increasing sons' WLA 266 267 at 22 years only. The explanation of this finding may emanate from the association between decreasing maternal age and increasing maternal WLA, showing that younger mothers were 268 more likely to attempt to lose weight. This tendency could be the consequence of a higher 269 influence of modern values around thinness in this age group, as observed in other African 270 populations³⁹. In this context, younger mothers could exacerbate their sons' WLA, if we 271 hypothesize that sons at adult age may be more aware of risks of obesity, even more so as 272 they see their BMI increase with their age, as observed in a recent study⁴⁰. In addition, this 273 scenario seems particularly probable as sons grew up in most cases with mothers who were 274 overweight or obese, so that they might be more likely to attempt to lose weight at 22 years 275 through the partial influence of their younger mothers' attempts to decrease their own weight. 276

Since the maternal environment influences boys more than girls, despite girls presenting with 277 278 higher rates of WLA and eating disorders risk, it appears that WLA external influences such as peer network and media are impacting daughters more than sons, and the influence of 279 280 external factors exceeds that of maternal factors for girls. Indeed, African studies found that the acculturation process towards thinness valorization, through the influence of Western 281 media, has a higher impact on females than males.^{11,15} Thus, the maternal and more generally 282 283 traditional influences towards body norms seem to be lower in young adolescent females who have more tendency to adhere to modern norms of thinness.⁵ 284

While the modern trend for thinness could affect more females than males in African countries, other dimensions of the body valued by the modernity and the consumer society, such as becoming muscular, are of greater concern for masculine than feminine identity.⁴¹ In South Africa, Black males could be more concerned by the obsession to be muscular than White males, as a symbol of Black masculinity.⁸ The mental disorder called "muscle dysmorphia", identified in the DSM-V as a hybrid category between eating and body
dysmorphic disorders,⁴² was observed in a South African sample.⁴³

A limitation of our study is that we only considered WLA based on weight-loss practices, and 292 293 did not specifically investigate WLA based on practices to become more muscular. The desire to be more muscular could involve different pathways between maternal factors and weight 294 management by their sons, and is an important dimension to consider in future studies. 295 Another limitation is that our sample did not comprise of fathers, and therefore, does not 296 include paternal factors in body image construction and weight management of their 297 adolescents. This interaction has not been explored within the South African context due to 298 299 the labor migration and absence of fathers in the household. Indeed, only 20% of Bt20+ participants had contact with their fathers during adolescence. 300

301 Therefore, it would be interesting to investigate in future qualitative studies how the paternal 302 role could mediate the body size and shape of their offspring, especially the muscular component of their sons' body, in addition to the potential influence of media and peer 303 304 networks. A comparison between families with and without a father would be informative for assessing this intergenerational relationship, rarely studied, between males' body image and 305 weight management from the same household. Future South African studies should integrate 306 307 simultaneously these parameters to assess their respective contribution on body image and weight management of adolescents and young adults.⁴⁴ 308

The final limitations of this study concern the measurement tools used to assess our variables. First, the Eating Attitude Test identified eating disorders risk for most mothers from our sample unlike their adolescents. Indeed, this questionnaire can measure different kinds of eating disorders having contrasting aetiologies. Most mothers suffered from overweight or obesity, and excess weight is commonly strongly associated with binge eating disorders⁴⁵. Moreover, the negative association found between eating disorders risk and WLA in mothers could be explained by the fact that they might have suffered from binge eating disorders,
while the cause of eating disorders risk in underweight and normal weight adolescents might
be linked to fat phobia generally associated with other eating disorders as anorexia or bulimia
nervosa⁴⁶.

More globally, the second limitation related to our measurements is the degree of reliability of 319 320 self-report in response to our questionnaires. Indeed, eating attitudes and WLA were assessed by self-report rather than through clinical assessments. This subjective self-assessment 321 presents its limitations and was already discussed in different research areas.⁴⁷ Nevertheless, 322 our data quality and the validity of the study instruments used suggests that questionnaire 323 324 items were reliable. The differentiated intergenerational patterns we observed between sons and daughters should be confirmed, however, by clinical diagnosis and qualitative inquiry 325 into the relative impact of the family and peers/media on the development of body weight 326 327 concerns in young males and females.

The implications of our findings suggest that public health interventions need to assist adolescents and their families to better understand the multiple factors that are influencing their attitudes and behaviors around eating and body image so as to promote healthy weight status and minimize eating disorders risk, especially in female adolescents.

333 Conclusions

Differing patterns were observed between adolescent males and females in the intergenerational relationships with maternal factors and their longitudinal WLA from early adolescence to adulthood. The lack of relationship between maternal norms and daughters' behavior may reinforce the notion of body image acculturation and movement away from traditional cultural norms and a greater exposition to modern body image disturbances and eating disorders risk.

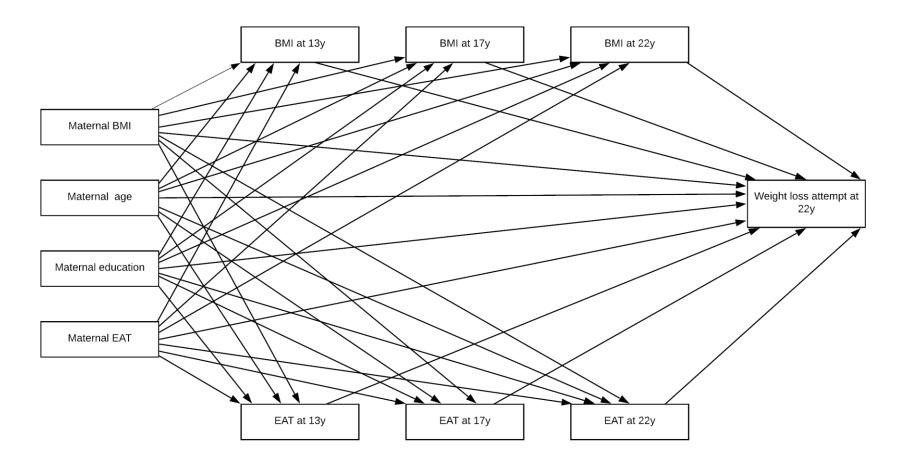

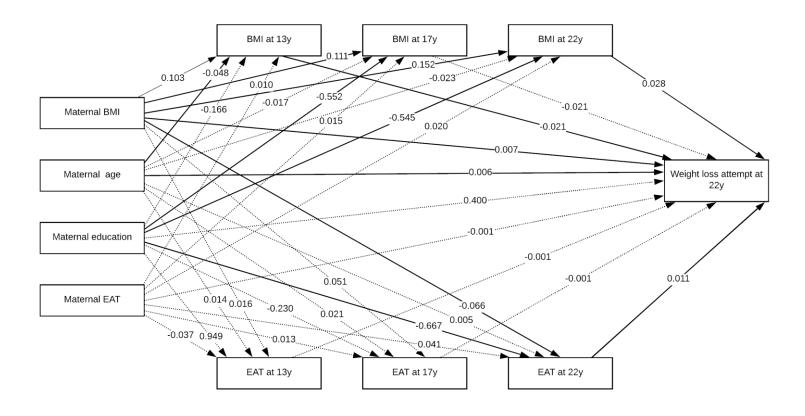

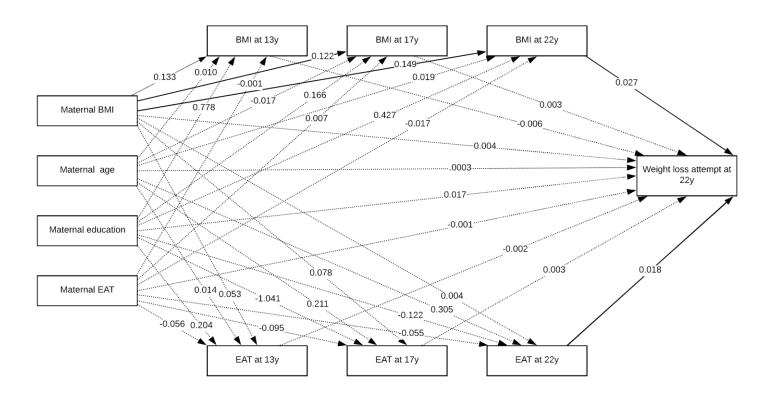

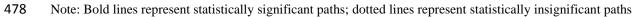
