# Existence of martingale solutions for stochastic flocking models with local alignment

#### Abstract

We establish the existence of martingale solutions to a class of stochastic conservation equations. The underlying models correspond to random perturbations of kinetic models for collective motion such as the Cucker-Smale [6, 7] and Motsch-Tadmor [16] models. By regularizing the coefficients, we first construct approximate solutions obtained as the mean-field limit of the corresponding particle systems. We then establish the compactness in law of this family of solutions by relying on a stochastic averaging lemma. This extends the results obtained in $[12,11]$ in the deterministic case.


Keywords: Stochastic partial differential equations, mean-field limit, collective motion.

## 1 Introduction, main results

### 1.1 Collective motion with local alignment

The emergence of a consensus or ordered motion amongst a population of interacting agents has been drawing a fair amount of attention among the scientific community in recent years. This phenomenon, consistently observed in nature, from schooling fish to swarming bacteria, is usually referred to as flocking. One of the earliest and most commonly studied mathematical models describing this kind of behavior is the celebrated Cucker-Smale model, introduced in $[6,7]$. In this model, agents interact in a mean-field manner: for $1 \leq i \leq N$, denoting by $X^{i, N}, V^{i, N} \in \mathbb{R}^{d}$ the position and velocity of the $i$-th individual, the evolution of the system is given by

\left\{\begin{array}{l}
\frac{d}{d t} X_{t}^{i, N}=V_{t}^{i, N} \\
\frac{d}{d t} V_{t}^{i, N}=\frac{1}{N} \sum_{j=1}^{N} \psi\left(X_{t}^{i, N}-X_{t}^{j, N}\right)\left(V_{t}^{j, N}-V_{t}^{i, N}\right),
\end{array}\right.
$$

where the weight function $\psi: \mathbb{R}^{d} \rightarrow \mathbb{R}^{+}$is even, typically of the form

$$
\psi(x-y)=\frac{\lambda}{\left(1+|x-y|^{2}\right)^{\gamma}}, \quad \lambda, \gamma>0 .
$$

Equivalently, one may consider the conservation equation

$$
\begin{equation*}
\partial_{t} f+v \cdot \nabla_{x} f+\nabla_{v} \cdot\left(L^{C S}[f] f\right)=0 \tag{1.1}
\end{equation*}
$$

where the Cucker-Smale alignment term $L^{C S}[f]$ is given by the convolution

$$
\begin{equation*}
L^{C S}[f](x, v)=\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \psi(x-y)(w-v) f(y, w) d y d w \tag{1.2}
\end{equation*}
$$

Equation (1.1) is naturally associated to the particle system, since it is satisfied by the empirical measure

$$
\mu_{t}^{N}=\frac{1}{N} \sum_{i=1}^{N} \delta_{\left(X_{t}^{i, N}, V_{t}^{i, N}\right)}
$$

in the sense of distributions. In [16], Motsch and Tadmor brought to light several drawbacks regarding the physical relevance of the Cucker-Smale model when confronted to strongly nonhomegeneous distributions of agents, due to the normalizing constant $\frac{1}{N}$ in the alignment force, which involves the whole group of individuals. To remedy these issues, they proposed a new model where the influence between two agents is normalized by the total influence:

$$
\left\{\begin{array}{l}
\frac{d}{d t} X_{t}^{i, N}=V_{t}^{i, N}, \\
\frac{d}{d t} V_{t}^{i, N}=\frac{1}{\sum_{j=1}^{N} \phi\left(X_{t}^{i, N}-X_{t}^{j, N}\right)} \sum_{j=1}^{N} \phi\left(X_{t}^{i, N}-X_{t}^{j, N}\right)\left(V_{t}^{j, N}-V_{t}^{i, N}\right) .
\end{array}\right.
$$

Considering some weight function $\phi: \mathbb{R}^{d} \rightarrow \mathbb{R}^{+}$with compact support, we may naturally consider a hybrid model, letting the Cucker-Smale forcing dictate the long-range interaction and the Motsch-Tadmor term dictate the short-range interaction:

$$
\begin{equation*}
\partial_{t} f+v \cdot \nabla_{x} f+\nabla_{v} \cdot\left(\left(L^{C S}[f]+L^{M T}[f]\right) f\right)=0 \tag{1.3}
\end{equation*}
$$

where the $L^{M T}[f]$ is given by

$$
\begin{equation*}
L^{M T}[f](x, v)=\frac{\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \phi(x-y)(w-v) f(y, w) d y d w}{\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \phi(x-y) f(y, w) d y d w} \tag{1.4}
\end{equation*}
$$

Note that the Motsch-Tadmor forcing term can also be written

$$
L^{M T}[f](x, v)=u[f](x)-v
$$

expressing the alignment of the speed with the local average velocity $u[f]$, defined as

$$
u[f](x)=\frac{\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \phi(x-y) w f(y, w) d y d w}{\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \phi(x-y) f(y, w) d y d w}
$$

As suggested in [12], we may also consider (1.3) in the singular limit where the weight function $\phi$ governing the short-range interaction converges to the Dirac function $\delta_{0}$, leading to

$$
\begin{equation*}
\partial_{t} f+v \cdot \nabla_{x} f+\nabla_{v} \cdot\left(\left(L^{C S}[f]+L^{S L A}[f]\right) f\right)=0 \tag{1.5}
\end{equation*}
$$

In (1.5), the Strong Local Alignment term $L^{S L A}[f]$ is given by

$$
\begin{equation*}
L^{S L A}[f](x, v)=u_{0}[f](x)-v \tag{1.6}
\end{equation*}
$$

where the local velocity $u_{0}[f]$ is given by

$$
u_{0}[f](x)=\frac{\int_{\mathbb{R}^{d}} w f(x, w) d w}{\int_{\mathbb{R}^{d}} f(x, w) d w}
$$

The existence of solutions to the kinetic equations (1.3) and (1.5) has been established in [12]. Moreover, in [11], the authors rigorously explore the limit $\phi \rightarrow \delta_{0}$ : considering some $\phi_{1} \in C_{c}\left(\mathbb{R}^{d}\right)$ and weight functions of the form $\phi^{r}(x)=r^{-d} \phi_{1}(x / r)$, solutions $\left(f^{r}\right)_{r \geq 0}$ of (1.3) converge (up to some subsequence) to a solution $f$ of (1.5).

In order to take into account random phenomena emerging from the environment, or unpredictable interactions between the agents, it is rather natural to perturb the deterministic equations (1.3) and (1.5) with some noise, driven by a Wiener process $d W(z)=\sum_{k} K_{k}[f](z) d \beta_{t}^{k}$, leading to the stochastic conservation equation

$$
d f_{t}+\left[v \cdot \nabla_{x} f_{t}+\nabla_{v} \cdot\left(\left(L\left[f_{t}\right] f_{t}\right)\right] d t+\sum_{k} \nabla_{v} \cdot\left(K_{k}\left[f_{t}\right] f_{t}\right) \circ d \beta_{t}^{k}=0\right.
$$

with $L[f]=L^{C S}[f]+L^{M T}[f]$ or $L[f]=L^{C S}[f]+L^{S L A}[f]$. Here, for simplicity purposes, we choose to only consider a "one-dimensional" noise driven by a real valued Brownian motion $\beta=\left(\beta_{t}\right)_{t \geq 0}$, leading to equations

$$
\begin{equation*}
d f_{t}+\left[v \cdot \nabla_{x} f_{t}+\nabla_{v} \cdot\left(\left(L^{C S}\left[f_{t}\right]+L^{M T}\left[f_{t}\right]\right) f_{t}\right)\right] d t+\nabla_{v} \cdot\left(K\left[f_{t}\right] f_{t}\right) \circ d \beta_{t}=0 \tag{1.7}
\end{equation*}
$$

and

$$
\begin{equation*}
d f_{t}+\left[v \cdot \nabla_{x} f_{t}+\nabla_{v} \cdot\left(\left(L^{C S}\left[f_{t}\right]+L^{S L A}\left[f_{t}\right]\right) f_{t}\right)\right] d t+\nabla_{v} \cdot\left(K\left[f_{t}\right] f_{t}\right) \circ d \beta_{t}=0 \tag{1.8}
\end{equation*}
$$

The methods developed in the present paper shall not rely on this particular form, so that the results may be easily generalized to SPDEs with multiple Brownian motions. Note that
these stochastic conservation equations are written in Stratonovitch form, since it is the most physically relevant form. As in the deterministic case, equation (1.7) is naturally associated to the stochastic particle system

$$
\left\{\begin{array}{l}
d X_{t}^{i, N}=V_{t}^{i, N} d t,  \tag{1.9}\\
d V_{t}^{i, N}=L\left[\mu_{t}^{N}\right]\left(X_{t}^{i, N}, V_{t}^{i, N}\right) d t+K\left[\mu_{t}^{N}\right]\left(X_{t}^{i, N}, V_{t}^{i, N}\right) \circ d \beta_{t}
\end{array}\right.
$$

where $\mu_{t}^{N}=\frac{1}{N} \sum_{i=1}^{N} \delta_{\left(X_{t}^{i, N}, V_{t}^{i, N}\right)}$ and $L[\mu]=L^{C S}[\mu]+L^{M T}[\mu]$.
The mean-field convergence of (1.9) to the corresponding limiting SPDE has been studied in the litterature in the case of the Cucker-Smale interaction, that is with $L[\mu]=L^{C S}[\mu]$. The diffusion coefficient $K[\mu](x, v)=D\left(v-v_{c}\right)$ for some constant $v_{c} \in \mathbb{R}^{d}$ is considered in [1] ; the coefficient $K[\mu](x, v)=\sqrt{2 \sigma}(v-\bar{v})$, where $\bar{v}=\int w d \mu(y, w)$, is looked upon in [4] and [10]; some more general (non linear) diffusion coefficients are considered in [18].

As for the Motsch-Tadmor model, that is for $L[\mu]=L^{M T}[\mu]$, the flocking phenomenon for the particle system (1.9) (alignment of speeds, distance between the individuals bounded over time) is studied in [15] in the case of a multiplicative noise $K[\mu](x, v)=D v$. However, even in the deterministic case, due to the singular ratio involved in the non-linear term $L^{M T}[\mu]$, the mean-field limit of the Motsch-Tadmor particle system is a very delicate question (as suggested in [16] and [17]) to which the authors could not find a proper answer in the litterature. It should also be noted that the strong local alignment term $L^{S L A}[f]$ given by (1.6) is ill-defined when $f$ is a general measure, so that the particle system associated with equation (1.8) cannot in fact be written.

In the present work, we shall consider a diffusion coefficient of the form

$$
\begin{equation*}
K[f](x, v)=F(x)+\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \tilde{\psi}(x-y)(w-v) f(y, w) d y d w \tag{1.10}
\end{equation*}
$$

which corresponds to some random environmental forcing $F(x) \circ d \beta_{t}$, as well as a random perturbation $\psi \leftarrow \psi+\tilde{\psi} \circ d \beta_{t}$ of the weight function involved in the Cucker-Smale alignment term (1.2) (as considered in [4] and [18] in the case of the Cucker-Smale model only). Note that the choice $F=0$ and $\widetilde{\psi}=\sqrt{2 \sigma}$ leads in particular to the simpler coefficient $K[\mu](x, v)=\sqrt{2 \sigma}(v-\bar{v})$. The arguments developed in the present work also easily apply to the case $K[\mu](x, v)=D v$ looked upon in [15].

In this paper, we extend the work developed in [12] and [11] in the deterministic case to establish the existence of martingale solutions (see Definition 1.1 below) for the stochastic conservation equations (1.7) and (1.8). To this intent, we start by regularizing the coefficients: in section 2, we prove the existence of a unique solution of equation (1.7) with regularized coefficients, which is naturally constructed as the mean-field limit of the corresponding stochastic particle system. Then, in section 3, we prove the tightness of these approximate solutions with respect to the regularizing parameter, and rigorously pass to the limit in the martingale problem associated with (1.7).

### 1.2 Assumptions and main results

The weight functions $\psi, \tilde{\psi}: \mathbb{R}^{d} \rightarrow \mathbb{R}^{+}$involved in (1.2) and (1.10) are assumed to satisfy

$$
\begin{equation*}
|\psi(x)|+|\widetilde{\psi}(x)| \lesssim 1, \quad\left|\partial_{x}^{\alpha} \psi(x)\right|+\left|\partial_{x}^{\alpha} \widetilde{\psi}(x)\right| \lesssim 1 \text { for } 1 \leq|\alpha| \leq 4 \tag{1.11}
\end{equation*}
$$

The weight function $\phi: \mathbb{R}^{d} \rightarrow \mathbb{R}^{+}$involved in (1.4) is assumed to be smooth and compactly supported around zero: $\phi \in C^{\infty}\left(\mathbb{R}^{d}\right)$ and for some $0<r_{1}<r_{2}<\infty$,

$$
\begin{equation*}
\inf _{x \in B\left(0, r_{1}\right)} \phi(x)>0, \quad \operatorname{Supp}(\phi) \subset B\left(0, r_{2}\right) . \tag{1.12}
\end{equation*}
$$

The forcing $F$ involved in (1.10) is assumed to be smooth and sublinear:

$$
|F(x)| \lesssim 1+|x| .
$$

Simple calculations show that the proper Itô form associated with SPDE (1.7) is

$$
d f_{t}+\nabla_{v} \cdot\left(\left(L^{C S}\left[f_{t}\right]+L^{M T}\left[f_{t}\right]+S\left[f_{t}\right]\right) f_{t}\right) d t+\nabla_{v} \cdot\left(K\left[f_{t}\right] f_{t}\right) d \beta_{t}=\frac{1}{2} \nabla_{v}^{2}\left(K\left[f_{t}\right] K\left[f_{t}\right]^{T} f_{t}\right) d t
$$

where we have used the notation

$$
\nabla_{v}^{2}\left(K[f] K[f]^{T} f\right)=\sum_{1 \leq i, j \leq d} \partial_{v_{i} v_{j}}^{2}\left[K[f]^{i} K[f]^{j} f\right]
$$

and the additional drift forcing term $S[f]$ is given by

$$
S[f](z)=\frac{1}{2} \int_{\mathbb{R}^{2 d}} \widetilde{\psi}(x-y)(K[f](y, w)-K[f](x, v)) f(y, w) d y d w
$$

This motivates the following definition.
Definition 1.1. Let $T>0$ and $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{0 \leq t \leq T}, \mathbb{P}, \beta\right)$ be a filtered probability space equipped with an $\left(\mathcal{F}_{t}\right)$-brownian motion $\beta$. Let $f_{0}: \mathbb{R}^{2 d} \rightarrow \mathbb{R}_{+}$with $\int_{\mathbb{R}^{2 d}} f_{0}(z) d z=1$.
A process $f \in L^{\infty}\left(\Omega ; L^{\infty}\left([0, T] ; L^{1}\left(\mathbb{R}^{2 d}\right)\right)\right)$ with

$$
\begin{equation*}
\left[\int_{\mathbb{R}^{2 d}}|f(\omega)(t, z)| d z \leq 1, \quad d t \text {-a.e }\right], \mathbb{P} \text {-a.s } \tag{1.13}
\end{equation*}
$$

satisfying the estimate

$$
\begin{equation*}
\mathbb{E}\left[\int_{0}^{T} \int_{\mathbb{R}^{2 d}}\left(1+|v|^{2}\right)|f(t, z)| d z d t\right]<\infty \tag{1.14}
\end{equation*}
$$

is said to be a solution of (1.7) on $(\Omega, \beta)$ (with initial value $f_{0}$ ) when, for any test function $\Psi \in C_{c}^{\infty}\left(\mathbb{R}^{2 d}\right)$, the process $(\langle f(t), \Psi\rangle)_{0 \leq t \leq T}$ is adapted with a continuous version and satisfies

$$
\langle f(t), \Psi\rangle=\left\langle f_{0}, \Psi\right\rangle+\int_{0}^{t}\langle\mathcal{L}[f(s)] \Psi, f(s)\rangle d s+\int_{0}^{t}\left\langle K[f(s)] \cdot \nabla_{v} \Psi, f(s)\right\rangle d \beta_{s}, \quad t \in[0, T]
$$

where $\mathcal{L}[f]$ denotes the second order operator

$$
\begin{equation*}
\mathcal{L}[f] \Psi=v \cdot \nabla_{x} \Psi+\left(L^{C S}[f]+L^{M T}[f]+S[f]\right) \cdot \nabla_{v} \Psi+\frac{1}{2} \sum_{1 \leq i, j \leq d} K[f]^{i} K[f]^{j} \partial_{v_{i} v_{j}}^{2} \Psi \tag{1.15}
\end{equation*}
$$

If there exists some probability tuple $\left(\bar{\Omega}, \overline{\mathcal{F}},\left(\overline{\mathcal{F}}_{t}\right)_{0 \leq t \leq T}, \overline{\mathbb{P}}, \bar{\beta}\right)$ and a solution $\bar{f}$ of $(1.7)$ on $(\bar{\Omega}, \bar{\beta})$, we say that equation (1.7) has a martingale solution (in the sense of [8], Chapter 8).

Estimates (1.13) and (1.14) are quite natural since we expect solutions of (1.7) to be densities. On can easily check that these estimates guarantee that the process $(\langle f(t), \Psi\rangle)_{t \geq 0}$ is well defined, the stochastic integral being a square integrable martingale. Solutions of equation (1.8) are defined similarly. We now state our main results.

Theorem 1 (Stochastic Motsch-Tadmor flocking).
Let $f_{0}: \mathbb{R}^{2 d} \rightarrow \mathbb{R}_{+}$with $\int_{\mathbb{R}^{2 d}} f_{0}(z) d z=1$ such that, for some $\delta>1$ and $\theta \in(0,1)$,

$$
\begin{equation*}
\int_{\mathbb{R}^{2 d}}\left|f_{0}(z)\right|^{p} d z+\int_{\mathbb{R}^{2 d}}\left(|x|^{\delta}+|v|^{k}\right) f_{0}(z) d z<\infty, \quad p=1+\frac{1}{\theta}, \quad k>\frac{\max (d+2,4)}{1-\theta} \tag{1.16}
\end{equation*}
$$

Then there exists a martingale solution $f$ of equation (1.7) with initial data $f_{0}$.

We also prove the existence of a martingale solution of (1.8), which can be constructed as a weak limit of solutions of (1.7) as the function $\phi$ involved in the Motsch-Tadmor alignment term (1.4) properly approaches the Dirac function $\delta_{0}$, similarly to the result established in [11].

Theorem 2 (Stochastic flocking with strong local alignment).
Let $\phi_{1} \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ satisfy (1.12). Let us consider the sequence of functions $\left(\phi_{r}\right)_{r>0}$ given by

$$
\forall x \in \mathbb{R}^{d}, \quad \phi_{r}(x)=r^{d} \phi_{1}(x / r) .
$$

Assuming (1.16), the martingale solution $f^{r}$ of equation (1.7) with $\phi=\phi_{r}$ constructed in Theorem 1 satisfies, along some subsequence $r_{n} \rightarrow 0$,

$$
f^{r_{n}} \rightarrow f \text { in law, in } C\left([0, T] ; H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right) \text { for all } \sigma>0
$$

where $f$ defines a martingale solution of (1.8). The weighted Sobolev space $H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)$, with $W^{-1}(z)=(1+|z|)^{-1}$ is introduced in (3.34) below.

Note that, although $f$ only converges weakly in space, the use of a stochastic averaging lemma (developed in Proposition 3.4 below) will guarantee that integrated quantities of the form

$$
\rho_{\varphi}=\int_{\mathbb{R}^{d}} \varphi(v) f d v
$$

converge in the strong space $L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right)$. This allows to properly pass to the limit in the non-linear equation (1.7).

## 2 Regularized equation

In this section, we prove existence and uniqueness of a solution of equation (1.7) with regularized coefficients. This solution will be naturally obtained as the mean-field limit of the corresponding particle system.

For $R>0$ let us introduce smooth, compactly supported truncation functions

$$
\chi_{R} \in C_{c}^{\infty}\left(\mathbb{R}^{d} ; \mathbb{R}\right), \quad \theta_{R} \in C_{c}^{\infty}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)
$$

satisfying

$$
\begin{cases}\chi_{R}(x)=1 \text { if }|x| \leq R, & \left|\chi_{R}(x)\right| \leq 1,  \tag{2.1}\\ \theta_{R}(v)=v \text { if }|v| \leq R, & \left|\theta_{R}(v)\right| \leq|v|, \\ \left|\nabla_{v} \cdot \theta_{R}(v)\right| \lesssim 1 & \text { uniformly } \text { in } R>0 .\end{cases}
$$

We may then introduce the following regularized coefficients:

$$
\left\{\begin{array}{l}
L_{R}^{C S}[\mu](z)=\int \chi_{R}(x-y) \psi(x-y) \theta_{R}(w-v) d \mu(y, w)  \tag{2.2}\\
u_{R}[\mu](x)=\frac{\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \phi(x-y) \theta_{R}(w) d \mu(y, w)}{R^{-1}+\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \phi(x-y) d \mu(y, w)} \\
L_{R}^{M T}[\mu](z)=u_{R}[\mu](x)-v \\
K_{R}[\mu](z)=\chi_{R}(x) F(x)+\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \chi_{R}(x-y) \widetilde{\psi}(x-y) \theta_{R}(w-v) d \mu(y, w) \\
S_{R}[\mu](z)=\frac{1}{2} \int_{\mathbb{R}^{2 d}} \widetilde{\psi}(x-y)\left(K_{R}[\mu](y, w)-K_{R}[\mu](x, v)\right) d \mu(y, w)
\end{array}\right.
$$

Simple calculations show that, for fixed $R$, these regularized coefficients are globally Lipschitz continuous in the following sense: for all $z, z^{\prime} \in \mathbb{R}^{2 d}, \mu, \nu \in \mathcal{P}\left(\mathbb{R}^{2 d}\right)$,

$$
\begin{align*}
& \left|L_{R}^{C S}[\mu](z)-L_{R}^{C S}[\nu]\left(z^{\prime}\right)\right|+\left|L_{R}^{M T}[\mu](z)-L_{R}^{M T}[\nu]\left(z^{\prime}\right)\right| \lesssim\left|z-z^{\prime}\right|+W_{1}[\mu, \nu]  \tag{2.3}\\
& \left|K_{R}[\mu](z)-K_{R}[\nu]\left(z^{\prime}\right)\right|+\left|S_{R}[\mu](z)-S_{R}[\nu]\left(z^{\prime}\right)\right| \lesssim\left|z-z^{\prime}\right|+W_{1}[\mu, \nu]
\end{align*}
$$

where the constants involved in $\lesssim$ in (2.3) depend on $R$, and $W_{1}$ denotes the Wasserstein distance. The assumptions made also guarantee the uniform sub-linearity of some coefficients: for all $z \in \mathbb{R}^{2 d}, \mu \in \mathcal{P}\left(\mathbb{R}^{2 d}\right)$,

From the sub-linearity of the coefficients, we easily deduce the following result.
Proposition 2.1. For any $T>0$ and $z_{0}^{i, N} \in \mathbb{R}^{2 d}, i \in\{1, \ldots, N\}$, the $\operatorname{SDE}$ system (2.5) with initial condition $Z_{0}^{i, N}=z_{0}^{i, N}$ has a unique global solution $\left(Z_{t}^{i, N}\right)_{t \in[0, T]}^{i \in\{1, \ldots, N\}}$ which satisfies the following estimates: for any $p \geq 1$,

The constants involved in $\lesssim$ depend on $R, p$ and $T$ only.

Proof. The coefficients of (2.5) being locally Lipschitz-continuous, the local existence and uniqueness of solutions is guaranteed. The estimates of Proposition 2.1 should first be established with the stopping time

Burkholder-Davis-Gundy's inequality (from [3]) gives

W_{2}^{2}\left[\mu^{N}, \nu\right] \leq \int_{\left(z_{1}, z_{2}\right) \in\left(\mathbb{R}^{2 d}\right)^{2}} \sup _{t \in[0, T]}\left|Z_{t}^{\mu^{N}}\left(z_{1}\right)-Z_{t}^{\mu}\left(z_{2}\right)\right|^{2} d \pi\left(z_{1}, z_{2}\right)=: J_{T}^{N} .
$$

As in (2.14), Itô's formula gives an expression of the form

$$
\begin{aligned}
d\left|Z_{t}^{\mu^{N}}\left(z_{1}\right)-Z_{t}^{\mu}\left(z_{2}\right)\right|^{2} & \lesssim\left(\left|Z_{t}^{\mu^{N}}\left(z_{1}\right)-Z_{t}^{\mu}\left(z_{2}\right)\right|^{2}+W_{1}^{2}\left[\mu_{t}^{N}, \mu_{t}\right]\right) d t+\zeta_{t} d \beta_{t} \\
& \lesssim\left(\left|Z_{t}^{\mu^{N}}\left(z_{1}\right)-Z_{t}^{\mu}\left(z_{2}\right)\right|^{2}+W_{2}^{2}\left[\mu^{N}, \mu\right]\right) d t+\zeta_{t} d \beta_{t}
\end{aligned}
$$

Proceeding as in the first part of the proof, we eventually obtain

$$
\mathbb{E}\left[W_{2}^{2}\left[\mu^{N}, \nu\right]\right] \lesssim \mathbb{E}\left[W_{2}^{2}\left[\mu^{N}, \mu\right]\right] .
$$

Letting $N$ go to infinity, we conclude that $\mu=\nu$ a.s, that is exactly (2.10).
We may once again use the same arguments to prove that the fixed-point-like equation (2.10) has a unique solution: considering $\mu$ and $\nu$ such that $\mu=\left(Z^{\mu}\right)^{*} \mu_{0}$ a.s and $\nu=\left(Z^{\nu}\right)^{*} \nu_{0}$ a.s, we are led to

$$
\mathbb{E}\left[W_{2}^{2}[\mu, \nu]\right] \lesssim W_{2}^{2}\left[\mu_{0}, \nu_{0}\right]
$$

so that $\mu_{0}=\nu_{0}$ implies $\mu=\nu$ a.s.
Finally, let us notice that any $\mu$ satisfying (2.10) defines a solution of (2.8). Indeed, for any test function $\Psi \in C_{c}^{\infty}\left(\mathbb{R}^{2 d}\right)$, Itô's formula gives exactly

\Psi\left(Z_{t}^{\mu}(z)\right)=\Psi(z)+\int_{0}^{t} \mathcal{L}_{R}\left[\mu_{s}\right] \Psi\left(Z_{s}^{\mu}(z)\right) d s+\int_{0}^{t} \nabla \Psi\left(Z_{s}^{\mu}(z)\right) \cdot K_{R}\left[\mu_{s}\right]\left(Z_{s}^{\mu}(z)\right) d \beta_{s}
$$

where $\mathcal{L}_{R}[\mu] \Psi$ is given by (2.9). Since $\left\langle\Psi, \mu_{t}\right\rangle=\int_{z \in \mathbb{R}^{2 d}} \Psi\left(Z_{t}^{\mu}(z)\right) d \mu_{0}(z)$, integrating with respect to $d \mu_{0}(z)$ using a stochastic Fubini theorem gives the expected result.

### 2.2 Flow of characteristics, regular solutions

For some fixed $R>0$, let us consider the unique solution $\mu$ of (2.8) constructed in Proposition 2.2. Although this measure, as well as the associated characteristics $\left(Z_{t}^{\mu}\right)_{t \geq 0}$, depend on $R>0$, we shall hide this dependence in the following expressions to avoid cluttering notation. One may note from expressions (2.2) that the coefficients

L_{R}^{C S}\left[\mu_{t}\right](z), \quad L_{R}^{M T}\left[\mu_{t}\right](z), \quad S_{R}\left[\mu_{t}\right](z), \quad K_{R}\left[\mu_{t}\right](z)
$$

involved in the $\operatorname{SDE}$ (2.11) have the regularity $C^{4}\left(\mathbb{R}^{2 d}\right)$ in the $z$ variable. More precisely, assumption (1.11) guarantees that, for fixed $R>0$, for $1 \leq|\alpha| \leq 4$,

$$
\left|\partial_{z}^{\alpha} L_{R}^{C S}\left[\mu_{t}\right]\right|+\left|\partial_{z}^{\alpha} L_{R}^{M T}\left[\mu_{t}\right]\right|+\left|\partial_{z}^{\alpha} S_{R}\left[\mu_{t}\right]\right|+\left|\partial_{z}^{\alpha} K_{R}\left[\mu_{t}\right]\right| \lesssim 1
$$

uniformly in $t \in[0, T]$ and $\omega \in \Omega$. In particular, the first, second and third order $z$-derivatives of the coefficients are globally Lipschitz-continuous. As a result, Theorem 4.4 of [13], Chapter II, yields

$$
\begin{equation*}
\left[\forall t \in[0, T], \quad Z_{t}^{\mu}: z \in \mathbb{R}^{2 d} \mapsto Z_{t}^{\mu}(z) \in \mathbb{R}^{2 d} \text { is a } C^{3} \text {-diffeomorphism }\right], \mathbb{P} \text { - a.s. } \tag{2.16}
\end{equation*}
$$

More precisely, for $0 \leq s \leq t$, denoting by $Z_{s, t}^{\mu}(z)$ the solution of the SDE

\left\{\begin{array}{l}
X_{s, t}^{\mu}(z)=x+\int_{r=s}^{t} V_{s, r}^{\mu}(z) d r \\
V_{s, t}^{\mu}(z)=v+\int_{r=s}^{t}\left(L_{R}^{C S}\left[\mu_{r}\right]+L_{R}^{M T}\left[\mu_{r}\right]+S_{R}\left[\mu_{r}\right]\right)\left(Z_{s, r}^{\mu}(z)\right) d r+\int_{r=s}^{t} K_{R}\left[\mu_{r}\right]\left(Z_{s, r}^{\mu}(z)\right) d \beta_{r},
\end{array}\right.
$$

the inverse map $\left(Z_{s, t}^{\mu}\right)^{-1}(z)$ satisfies the corresponding backward SDE

$$
\left\{\begin{aligned}
&\left(X_{s, t}^{\mu}\right)^{-1}(z)=x-\int_{r=s}^{t}\left(V_{r, t}^{\mu}\right)^{-1}(z) d r \\
&\left(V_{s, t}^{\mu}\right)^{-1}(z)=v-\int_{r=s}^{t}\left(L_{R}^{C S}\left[\mu_{r}\right]+L_{R}^{M T}\left[\mu_{r}\right]+S_{R}\left[\mu_{r}\right]-\widetilde{S}_{R}\left[\mu_{r}\right]\right)\left(\left(Z_{r, t}^{\mu}\right)^{-1}(z)\right) d r \\
& \quad-\int_{r=s}^{t} K_{R}\left[\mu_{r}\right]\left(\left(Z_{r, t}^{\mu}\right)^{-1}(z)\right) \widehat{d \beta_{r}}
\end{aligned}\right.
$$

where $\widetilde{S}_{R}[\mu]=\nabla_{v} K_{R}[\mu] K_{R}[\mu]$ and $\int_{s}^{t} \cdot \widehat{d \beta_{t}}$ denotes the backward Stratonovich integral (see again [13] Theorem 7.3 for this result and p. 194 for the definition of the backward integral). When $s=0$, we simply denote

Z_{t}^{\mu}(z)=Z_{0, t}^{\mu}(z), \quad\left(Z_{t}^{\mu}\right)^{-1}(z)=\left(Z_{0, t}^{\mu}\right)^{-1}(z)
$$

In the particular case where the initial measure $\mu_{0}$ admits a density $f_{0} \in L^{1}\left(\mathbb{R}^{2 d}\right)$ with respect to the Lebesgue measure on $\mathbb{R}^{2 d}$, for any test function $\Psi \in C_{b}\left(\mathbb{R}^{2 d}\right)$ we may write

\int_{z \in \mathbb{R}^{2 d}} \Psi(z) d \mu_{t}(z)=\int_{z \in \mathbb{R}^{2 d}} \Psi\left(Z_{t}^{\mu}(z)\right) f_{0}(z) d z=\int_{z \in \mathbb{R}^{2 d}} \Psi(z)\left|J_{t}(z)^{-1}\right| f_{0}\left(\left(Z_{t}^{\mu}\right)^{-1}(z)\right) d z
$$

where $J_{t}(z)^{-1}$ denotes the jacobian determinant

$$
\begin{equation*}
J_{t}(z)^{-1}=\operatorname{det}\left[D_{z}\left(\left(Z_{t}^{\mu}\right)^{-1}\right)(z)\right] \tag{2.17}
\end{equation*}
$$

Considering a countable separating family of such test functions $\Psi$, from $\mu=\left(Z^{\mu}\right)^{*} f_{0}$ in $\mathcal{P}(\mathcal{C})$, we deduce that

\left[\forall t \in[0, T], \quad d \mu_{t}(z)=f(t, z) d z\right], \mathbb{P}-a . s
$$

where

$$
\begin{equation*}
f(t, z)=J_{t}(z)^{-1} f_{0}\left(\left(Z_{t}^{\mu}\right)^{-1}(z)\right) \tag{2.18}
\end{equation*}
$$

Note that we may drop the absolute value in (2.18) since $J_{t}(z)^{-1} \geq 0$ a.s. Let us now give some estimates regarding the forward and backward characteristics.

## Proposition 2.3.

For all $p \geq 1$, let $f_{0} \in L^{1}\left(\mathbb{R}^{2 d}\right)$ such that $\int\left|z^{\prime}\right|^{p} f_{0}(z) d s^{\prime}<\infty$. Let $\mu \in L^{2}\left(\Omega ; \mathcal{P}_{2}(\mathcal{C})\right)$ such that $\mu=\left(Z^{\mu}\right)^{*} f_{0}$ as in (2.10). Then for all $z, z_{1}, z_{2} \in \mathbb{R}^{2 d}, t, t_{1}, t_{2} \in[0, T]$ and $1 \leq k \leq 3$,

$$
\begin{align*}
& \mathbb{E}\left[\sup _{t \in[0, T]}\left|Z_{t}^{\mu}(z)\right|^{p}\right] \lesssim 1+|z|^{p}+\int\left|z^{\prime}\right|^{p} f_{0}(z) d z^{\prime}  \tag{2.19}\\
& \mathbb{E}\left[\left|D_{z}^{k}\left(Z_{t}^{\mu}\right)(z)\right|^{p}\right] \lesssim 1+\int\left|z^{\prime}\right|^{p} f_{0}(z) d z^{\prime} \\
& \mathbb{E}\left[\sup _{t \in[0, T]}\left|Z_{t}^{\mu}\left(z_{1}\right)-Z_{t}^{\mu}\left(z_{2}\right)\right|^{p}\right] \lesssim\left|z_{1}-z_{2}\right|^{p}  \tag{2.20}\\
& \mathbb{E}\left[\left|\left(Z_{t}^{\mu}\right)^{-1}(z)\right|^{p}\right] \lesssim|z|^{p}+\int\left|z^{\prime}\right|^{p} f_{0}(z) d z^{\prime} \\
& \left.\left.\mathbb{E}\left[\mid\left(Z_{t_{1}}^{\mu}\right)^{-1}\right)\left(z_{1}\right)-\left(Z_{t_{2}}^{\mu}\right)^{-1}\right)\left.\left(z_{2}\right)\right|^{p}\right] \lesssim\left|z_{1}-z_{2}\right|^{p}+\left(1+\left|z_{1}\right|^{p}+\int\left|z^{\prime}\right|^{p} f_{0}(z) d z^{\prime}\right)\left|t_{1}-t_{2}\right|^{p / 2}  \tag{2.21}\\
& \mathbb{E}\left[\left|D_{z}^{k}\left(\left(Z_{t}^{\mu}\right)^{-1}\right)(z)\right|^{p}\right] \lesssim 1+\int\left|z^{\prime}\right|^{p} f_{0}(z) d z^{\prime}  \tag{2.22}\\
& \mathbb{E}\left[\left|D_{z}^{k}\left(\left(Z_{t_{1}}^{\mu}\right)^{-1}\right)(z)-D_{z}^{k}\left(\left(Z_{t_{2}}^{\mu}\right)^{-1}\right)\left(z^{\prime}\right)\right|^{p}\right] \lesssim\left|z-z^{\prime}\right|^{p}+\left|t_{1}-t_{2}\right|^{p / 2} \tag{2.23}
\end{align*}
$$

The constants involved in $\lesssim$ depend on $p, k, T, R$ only.
These estimates are deduced in a classical manner from the sub-linearity and the global Lipschitz continuity of the coefficients of the equations satisfied by $Z_{t}^{\mu}(z)$ and $\left(Z_{t}^{\mu}\right)^{-1}(z)$. Applying Kolmogorov's lemma to (2.21) and (2.23), we deduce that, for all $0 \leq k \leq 3$,

\begin{equation*}
(t, z) \in[0, T] \times \mathbb{R}^{2 d} \mapsto D^{k}\left(\left(Z_{t}^{\mu}\right)^{-1}\right)(z) \tag{2.24}
\end{equation*}
$$

is continuous $\mathbb{P}$ - a.s. Additionally, we may deduce from (2.19) and (2.20) the following estimate: given a compact set $K \subset \mathbb{R}^{2 d}$ and $z_{0} \in K$, for any $p \geq 1$ and $\alpha \in(0,1)$,

$$
\begin{equation*}
\mathbb{E}\left[\sup _{z \in K} \sup _{t \in[0, T]}\left|Z_{t}^{\mu}(z)\right|^{p}\right] \lesssim \mathbb{E}\left[\sup _{t \in[0, T]}\left|Z_{t}^{\mu}\left(z_{0}\right)\right|^{p}\right]+\mathbb{E}\left[\left\|Z^{\mu}\right\|_{C_{z}^{\alpha} L_{t}^{\infty}}^{p}\right] \operatorname{diam}(K)^{\alpha p} \leq C_{K, T, p}<\infty \tag{2.25}
\end{equation*}
$$

In (2.25), $\operatorname{diam}(K)=\sup \left\{\left|z_{1}-z_{2}\right|, z_{1}, z_{2} \in K\right\}$ and $\left\|Z^{\mu}\right\|_{C_{z}^{\alpha} L_{t}^{\infty}}$ denotes the $\alpha$-Hölder semi-norm

$$
\left\|Z^{\mu}\right\|_{C_{z}^{\alpha} L_{t}^{\infty}}=\sup _{z_{1} \neq z_{2} \in \mathbb{R}^{2 d}} \sup _{t \in[0, T]} \frac{\left|Z_{t}^{\mu}\left(z_{1}\right)-Z_{t}^{\mu}\left(z_{2}\right)\right|}{\left|z_{1}-z_{2}\right|^{\alpha}}
$$

which satisfies indeed $\mathbb{E}\left[\left\|Z^{\mu}\right\|_{C_{z}^{\alpha} L_{t}^{\infty}}^{p}\right] \lesssim 1$ by applying Kolmogorov's lemma to (2.20). We may now establish the following result.

Proposition 2.4 (Regular solution). Let $f_{0} \in C_{c}^{2}\left(\mathbb{R}^{2 d}\right)$. Let $\mu \in L^{2}\left(\Omega ; \mathcal{P}_{2}(\mathcal{C})\right)$ such that $\mu=\left(Z^{\mu}\right)^{*} f_{0}$ as in (2.10), and let $f(t, z)$ be defined as in (2.18), so that $\mu$ may be represented as $d \mu_{t}(z)=f(t, z) d z$. Then $f$ is a regular solution of (2.8) in the following sense:

- $\mathbb{P}$-almost surely, $f(t, \cdot) \in C^{2}\left(\mathbb{R}^{2 d}\right)$ for all $t \in[0, T]$ and the maps

$$
(t, z) \in[0, T] \times \mathbb{R}^{2 d} \mapsto \partial_{z}^{\alpha} f(t, z), \quad 0 \leq|\alpha| \leq 2
$$

are continuous.

- Denoting the operator

$$
\begin{equation*}
\left(\mathcal{L}_{R}[f]\right)^{*} g=-v \cdot \nabla_{x} g-\nabla_{v} \cdot\left(\left(L_{R}^{C S}[f]+L_{R}^{M T}[f]+S_{R}[f]\right) g\right)+\frac{1}{2} \nabla_{v} \cdot \nabla_{v}\left(K_{R}[f] K_{R}[f]^{T} g\right) \tag{2.26}
\end{equation*}
$$

we have for all $z \in \mathbb{R}^{2 d}, t \in[0, T], \mathbb{P}$-almost surely,

$$
\begin{equation*}
f(t, z)=f_{0}(z)+\int_{0}^{t}\left(\mathcal{L}_{R}[f(s)]\right)^{*} f(s, z) d s-\int_{0}^{t} \nabla_{v} \cdot\left(K_{R}[f(s)] f(s, z)\right) d \beta_{s} \tag{2.27}
\end{equation*}
$$

Proof. As a consequence of (2.24), it is clear from expression (2.18) that the first condition is met. Furthermore, $f(t, \cdot)$ is almost surely compactly supported, uniformly in $t \in[0, T]$, with

\forall t \in[0, T], \quad \operatorname{Supp}(f(t, \cdot)) \subset\left\{z \in \mathbb{R}^{2 d}, \quad|z| \leq \sup _{z^{\prime} \in K} \sup _{t \in[0, T]}\left|Z_{t}^{\mu}\left(z^{\prime}\right)\right|\right\}
$$

Since $f$ is a solution of (2.8), for any $\Psi \in C_{c}^{\infty}\left(\mathbb{R}^{2 d}\right), \mathbb{P}$-almost surely,

$$
\langle f(t), \Psi\rangle=\left\langle f_{0}, \Psi\right\rangle+\int_{0}^{t}\left\langle\left(\mathcal{L}_{R}[f(s)]\right)^{*} f(s), \Psi\right\rangle d s-\int_{0}^{t}\left\langle\nabla_{v} \cdot\left(K_{R}[f(s)] f(s)\right), \Psi\right\rangle d \beta_{s}
$$

We can then interchange the integrals

$$
\int_{0}^{t}\langle\cdot, \Psi\rangle d s=\left\langle\int_{0}^{t} \cdot, \Psi\right\rangle d s, \quad \int_{0}^{t}\langle\cdot, \Psi\rangle d \beta_{s}=\left\langle\int_{0}^{t} \cdot, \Psi\right\rangle d \beta_{s}
$$

Since all functions are compactly supported (for fixed $\omega \in \Omega$ ), the integrals with respect to $d s$ cause no issue. As for the stochastic integral, we may use a stochastic Fubini theorem, as long as

\int_{0}^{t} \int_{z \in \mathbb{R}^{2 d}} \mathbb{E}\left[\left|\nabla_{v} \cdot\left(K_{R}[f(s)] f(s)\right) \Psi(z)\right|^{2}\right] d z d s<\infty

From expressions (2.2), we deduce (for fixed $R>0$ )

\left|K_{R}[f(t)](z)\right|+\left|\nabla_{v} \cdot\left(K_{R}[f(t)]\right)(z)\right| \lesssim 1
$$

From expression $(2.18)$, (and $|\operatorname{det}[A]| \lesssim|A|^{2 d}$ ) it is clear that

$$
|f(t, z)|^{2}+\left|\nabla_{z} f(t, z)\right|^{2} \lesssim\left(1+\max _{k=1,2}\left|D_{z}^{k}\left(\left(Z_{t}^{\mu}\right)^{-1}\right)(z)\right|^{q}\right)\left(\left\|f_{0}\right\|_{L^{\infty}}^{2}+\left\|\nabla_{z} f_{0}\right\|_{L^{\infty}}^{2}\right)
$$

for some $q=q(d) \geq 1$. We may hence write

$$
\begin{equation*}
\mathbb{E}\left|\nabla_{v} \cdot\left(K_{R}[f(s)] f(s)\right)(z)\right|^{2} \lesssim 1+\mathbb{E}\left[\max _{k=1,2}\left|D_{z}^{k}\left(\left(Z_{t}^{\mu}\right)^{-1}\right)(z)\right|^{q}\right] \lesssim 1 \tag{2.28}
\end{equation*}
$$

thanks to the bound (2.22). It follows that

$$
\int_{0}^{t} \int_{z \in \mathbb{R}^{2 d}} \mathbb{E}\left[\left|\nabla_{v} \cdot\left(K_{R}[f(s)] f(s)\right) \Psi(z)\right|^{2}\right] d z d s \lesssim \int_{z \in \mathbb{R}^{2 d}}|\Psi(z)|^{2} d z<\infty
$$

Consequently, P-a.s, (2.27) holds when integrated against any $\Psi \in C_{c}^{\infty}\left(\mathbb{R}^{2 d}\right)$. We deduce that (2.27) holds for almost every $z \in \mathbb{R}^{2 d}$. Since both sides of (2.27) are continuous with respect to $z$ (thanks to (2.28) again), we conclude that the equality holds for every $z \in \mathbb{R}^{2 d}$.

## 3 Weak convergence of approximate solutions

From now on, let us fix some initial data $f_{0}$ satisfying (at least) for some $\delta>1$,

$$
f_{0} \geq 0, \quad \int_{z \in \mathbb{R}^{2 d}} f_{0}(z) d z=1, \quad \int_{z \in \mathbb{R}^{2 d}}|z|^{\delta} f_{0}(z) d z<\infty
$$

For any $R>0$, considering the particle system (2.5), with initial data satisfying

$$
\mu_{0}^{N}(d z) \rightarrow f_{0}(z) d z \text { in } \mathcal{P}_{\delta}\left(\mathbb{R}^{2 d}\right)
$$

we may introduce the solution $\mu_{R}$ of (2.8) constructed in Proposition 2.2. As previously discussed, we naturally identify $\mu^{R}$ with its density $f^{R}=\left(f^{R}(t, z)\right)_{t \in[0, T], z \in \mathbb{R}^{2 d}}$ defined by (2.18).

### 3.1 Uniform estimates

In this section, we shall establish some estimates on $f^{R}$ uniformly on the regularization parameter $R$.

Proposition 3.1. Let $p \geq 1$ and $f_{0} \in L^{p}\left(\mathbb{R}^{2 d}\right)$. Then $f^{R} \in L^{\infty}\left([0, T] ; L^{p}\left(\mathbb{R}^{2 d}\right)\right)$ a.s, with the estimate

$$
\mathbb{E}\left[\sup _{t \in[0, T]}\left\|f^{R}(t)\right\|_{L^{p}}^{p}\right] \lesssim\left\|f_{0}\right\|_{L^{p}}^{p}
$$

The constant involved in $\lesssim$ depends on $p$ and $T$ only.
Proof. Let us start by considering $f_{0} \in C_{c}^{2}\left(\mathbb{R}^{2 d}\right)$ supported in some compact $K \subset \mathbb{R}^{2 d}$. Then $f^{R}$ is a regular solution of (2.8) in the sense of Proposition 2.4. For any $z \in \mathbb{R}^{2 d}$, applying Itô's formula to $\left|f^{R}(t, z)\right|^{p}$ hence gives

$$
\begin{align*}
\left|f^{R}(t, z)\right|^{p} & =f_{0}(z)^{p}-p \int_{0}^{t}\left|f^{R}(s, z)\right|^{p-1}\left[v \cdot \nabla_{x} f^{R}(s, z)+\nabla_{v} \cdot\left(B_{R}\left[f^{R}(s)\right] f^{R}(s, z)\right)\right] d s \\
& +\frac{p}{2} \int_{0}^{t}\left|f^{R}(s, z)\right|^{p-1} \nabla_{v} \cdot \nabla_{v} \cdot\left(K_{R}\left[f^{R}(s)\right] K_{R}\left[f^{R}(s)\right]^{T} f^{R}(s, z)\right) d s \\
& +\frac{p(p-1)}{2} \int_{0}^{t}\left|f^{R}(s, z)\right|^{p-2}\left|\nabla_{v} \cdot\left(K_{R}\left[f^{R}(s)\right] f^{R}(s, z)\right)\right|^{2} d s \\
& -p \int_{0}^{t}\left|f^{R}(s, z)\right|^{p-1} \nabla_{v} \cdot\left(K_{R}\left[f^{R}(s)\right] f^{R}(s, z)\right) d \beta_{s} \tag{3.1}
\end{align*}
$$

where $B_{R}[f]$ denotes the drift coefficient $L_{R}^{C S}[f]+L_{R}^{M T}[f]+S_{R}[f]$. We can now integrate (3.1) with respect to $d z$ and interchange the integrals:

$$
\int_{z \in \mathbb{R}^{2 d}} \int_{0}^{t} \cdot d s d z=\int_{0}^{t} \int_{z \in \mathbb{R}^{2 d}} \cdot d z d s, \quad \int_{z \in \mathbb{R}^{2 d}} \int_{0}^{t} \cdot d \beta_{s} d z=\int_{0}^{t} \int_{z \in \mathbb{R}^{2 d}} \cdot d z d \beta_{s}
$$

Since all the integrands in (3.1) are compactly supported in $z$ uniformly for $t \in[0, T]$ (for fixed $\omega \in \Omega$ ), the integrals with respect to $d s$ cause no issue. As for the stochastic integral, we may use a stochastic Fubnini theorem if we can justify that

& \lesssim \int_{|z| \leq S}(1+|z|)^{m} d z+\int_{z \in \mathbb{R}^{2 d}} \max _{k=1,2}\left|D_{z}^{k}\left(\left(Z_{t}^{\mu}\right)^{-1}\right)(z)\right|^{2 q} \frac{d z}{(1+|z|)^{m}} \\
& \lesssim\left(1+S^{m+1}\right)+\int_{z \in \mathbb{R}^{2 d}} \max _{k=1,2}\left|D_{z}^{k}\left(\left(Z_{t}^{\mu}\right)^{-1}\right)(z)\right|^{2 q} \frac{d z}{(1+|z|)^{m}}
\end{aligned}

Using (2.25) and (2.22), we deduce

& I_{2}(t)=\frac{p}{2} \int_{0}^{t} \int_{\mathbb{R}^{2 d}}\left|f^{R}(s, z)\right|^{p-1} \nabla_{v}^{2}\left(K_{R}\left[f^{R}(s)\right] K_{R}\left[f^{R}(s)\right]^{T} f^{R}(s, z)\right) d z d s \\
& I_{3}(t)=\frac{p(p-1)}{2} \int_{0}^{t} \int_{\mathbb{R}^{2 d}}\left|f^{R}(s, z)\right|^{p-2}\left|\nabla_{v} \cdot\left(K_{R}\left[f^{R}(s)\right] f^{R}(s, z)\right)\right|^{2} d z d s \\
& I_{4}(t)=-p \int_{0}^{t} \int_{\mathbb{R}^{2 d}}\left|f^{R}(s, z)\right|^{p-1} \nabla_{v} \cdot\left(K_{R}\left[f^{R}(s)\right] f^{R}(s, z)\right) d z d \beta_{s}
\end{aligned}

Simple calculations lead to the classical identity

& \nabla_{v} \cdot K_{R}[f](z)=\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \chi_{R}(x-y) \widetilde{\psi}(x-y) \nabla_{v} \cdot\left(\theta_{R}(w-v)\right) f(y, w) d y d w \\
& \nabla_{v} \cdot S_{R}[f](z)=-\frac{1}{2}\left(\int_{\mathbb{R}^{d} \times \mathbb{R}^{d}} \widetilde{\psi}(x-y) f(y, w) d y d w\right) \nabla_{v} \cdot K_{R}[f](z)
\end{aligned}

Assumptions (1.11), (2.1) guarantee that these terms are bounded uniformly in $t \in[0, T]$, $z \in \mathbb{R}^{2 d}, \omega \in \Omega, R>0$, so that

& +k(k / 2-1)\left|V_{t}\right|^{k-4}\left|V_{t}(z) \cdot K_{R}\left[f_{t}\right]\left(Z_{t}(z)\right)\right|^{2} d t+k\left|V_{t}(z)\right|^{k-2}\left|K_{R}\left[f_{t}\right]\left(Z_{t}(z)\right)\right|^{2} d t .

\left|X_{t}(z)\right|^{\delta}=\left|x+\int_{0}^{t} V_{s}(z) d s\right|^{\delta} \lesssim 1+|x|^{\delta}+\int_{0}^{t}\left|V_{s}(z)\right|^{2} d s
$$

since $\delta \leq 2$, we derive the second estimate, which concludes the proof.

### 3.2 Stochastic averaging lemma

Proposition 3.4. Let us assume that the initial data $f_{0}$ satisfies, for some $\theta \in(0,1)$,

For all, $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$, letting $\eta=1 / 6$, the averaged quantity

$$

lies in $L^{2}\left([0, T] ; H^{\eta}\left(\mathbb{R}^{d}\right)\right)$ almost surely, with the estimate

\mathbb{E}\left[\left\|\rho_{\varphi}^{R}\right\|_{L_{t}^{2} H_{x}^{\eta}}^{2}\right] \lesssim 1 \tag{3.15}
\end{equation*}

The constant involved in $\lesssim$ in (3.15) depends on $f_{0}, \varphi, T$ and $\phi$ only.

Proof. The proof of this result is based on a classical $L^{2}$ averaging lemma (see e.g [2] for the deterministic case), which we adapt here to the stochastic case, in a similar fashion to [9], Lemma 4.3. Let us first consider some initial data $f_{0} \in C_{c}^{2}\left(\mathbb{R}^{2 d}\right)$ so that $f=f^{R}$ is a regular solution of (2.8) in the sense of Proposition 2.4 , which may be written as follows: $\mathbb{P}$-a.s, for all $z \in \mathbb{R}^{2 d}$,

where we have introduced the coefficients

G^{i}(t, z)=\left(L_{R}^{C S}[f(t)]+L_{R}^{M T}[f(t)]+S_{R}[f(t)]\right)(z)^{i} f(t, z)  \tag{3.17}\\
G^{i j}(t, z)=K_{R}[f(t)](z)^{i} K_{R}[f(t)](z)^{j} f(t, z) \\
H^{i}(t, z)=K_{R}[f(t)]^{i} f(t, z)
\end{array}\right.
$$

Let us fix $\xi \in \mathbb{R}^{d}$. For simplicity, let us drop the summation signs in (3.16) and integrate it with respect to $e^{-i \xi \cdot x} d x$. This is possible (for every $v \in \mathbb{R}^{d}$ ) thanks to the bound (3.2) with $p=1$ established previously. Denoting the $x$-Fourier transform

Therefore, introducing some $\lambda=\lambda(\xi)>0$, we get

d \hat{f}(t, \xi, v)+(\lambda+i v \cdot \xi) \hat{f}(t, \xi, v) d t=\lambda \hat{f}(t, \xi, v) d t & +\left(\widehat{\left(\partial_{v_{i}} G^{i}\right.}+\widehat{\partial_{v_{i} v_{j}}^{2} G^{i j}}\right)(t, \xi, v) d t \\
& +\widehat{\partial_{v_{i}} H^{i}}(t, \xi, v) d \beta_{t}
\end{aligned}
$$

from which we deduce the expression

$$
\begin{align*}
\hat{f}(t, \xi, v)= & e^{-(\lambda+i v \cdot \xi) t} \hat{f}_{0}(\xi, v)+\lambda \int_{0}^{t} e^{-(\lambda+i v \cdot \xi)(t-s)} \hat{f}(s, \xi, v) d s \\
& +\int_{0}^{t} e^{-(\lambda+i v \cdot \xi)(t-s)}\left(\widehat{\partial_{v_{i}} G^{i}}+\widehat{\partial_{v_{i} v_{j}}^{2} G^{i j}}\right)(s, \xi, v) d s \\
& +\int_{0}^{t} e^{-(\lambda+i v \cdot \xi)(t-s)} \widehat{\partial_{v_{i}} H^{i}}(s, \xi, v) d \beta_{s} \tag{3.18}
\end{align*}
$$

We now integrate (3.18) with respect to $\varphi(v) d v$. This is possible since one could show that

& \quad \lesssim \mathbb{E} \int_{0}^{T} \int_{v \in \mathbb{R}^{d}}\left(1+|v|^{2}\right) \mid\left(\int_{x \in \mathbb{R}^{d}}\left|\nabla_{v} \cdot\left(K_{R}[f(s)] f(s)\right)\right| d x\right)^{2} d v d s<\infty
\end{aligned}
$$

for fixed $R>0$, by a method similar to the one employed to establish (3.2) in the proof Proposition 3.1. Introducing the $(x, v)$-Fourier transform

& +\int_{0}^{t} e^{-\lambda(t-s)}\left(\mathcal{F}\left(\left(\partial_{v_{i}} G^{i}\right) \varphi\right)+\mathcal{F}\left(\left(\partial_{v_{i} v_{j}}^{2} G^{i j}\right) \varphi\right)\right)(s, \xi, \xi(t-s)) d s \\
& +\int_{0}^{t} e^{-\lambda(t-s)} \mathcal{F}\left(\left(\partial_{v_{i}} H^{i}\right) \varphi\right)(s, \xi, \xi(t-s)) d \beta_{s}
\end{aligned}
$$

Note that since

& \left(\partial_{v_{i}} G^{i}\right) \varphi=\partial_{v_{i}}\left(G^{i} \varphi\right)-G^{i} \partial_{v_{i}} \varphi  \tag{3.19}\\
& \left(\partial_{v_{i} v_{j}}^{2} G^{i j}\right) \varphi=\partial_{v_{i} v_{j}}^{2}\left(G^{i j} \varphi\right)-\partial_{v_{i}}\left(G^{i j} \partial_{j} \varphi\right)-\partial_{v_{j}}\left(G^{i j} \partial_{i} \varphi\right)+G^{i j} \partial_{v_{i} v_{j}}^{2} \varphi \tag{3.20}
\end{align*}

forgetting the summation signs again, we may as well only consider terms of the form

& +\int_{0}^{t} e^{-\lambda(t-s)} \mathcal{F}\left(\partial_{v}^{\gamma}\left(H^{i} \Psi\right)\right)(s, \xi, \xi(t-s)) d \beta_{s} \tag{3.21}
\end{align*}

where $\Psi \equiv \Psi(v) \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ and $\alpha, \beta$ and $\gamma$ are multi-indexes of order $0 \leq|\alpha| \leq 2,1 \leq|\beta| \leq 2$ and $0 \leq|\gamma| \leq 1$. From (3.21) Itô's isometry gives

& J_{2}(\xi)=\lambda^{2} \mathbb{E} \int_{0}^{T}\left|\int_{0}^{t} e^{-\lambda(t-s)} \mathcal{F}(f \Psi)(s, \xi, \xi(t-s)) d s\right|^{2} d t \\
& J_{3}(\xi)=\mathbb{E} \int_{0}^{T}\left|\int_{0}^{t} e^{-\lambda(t-s)} \mathcal{F}\left(\partial_{v}^{\alpha}\left(G^{\beta} \Psi\right)\right)(s, \xi, \xi(t-s)) d s\right|^{2} d t \\
& J_{4}(\xi)=\mathbb{E} \int_{0}^{T} \int_{0}^{t} e^{-2 \lambda(t-s)}\left|\mathcal{F}\left(\partial_{v}^{\gamma}\left(H^{i} \Psi\right)\right)(s, \xi, \xi(t-s))\right|^{2} d s d t
\end{aligned}
$$

Using a trace lemma (see e.g [19], Theorem 2.7.2) we get, for some $s>(d-1) / 2$,

& \lesssim|\xi|^{-1} \int_{\mathbb{R}^{d}}\left|\left(I d-\Delta_{w}\right)^{s} \mathcal{F}\left(f_{0} \Psi\right)(\xi, w)\right|^{2} d w
\end{aligned}

It then follows by Plancherel's identity, since $\Psi$ is compactly supported, that

\end{equation*}

For the second term $J_{2}(\xi)$, Jensen's inequality gives

J_{2}(\xi) & \leq \lambda \mathbb{E} \int_{0}^{T} \int_{0}^{t} e^{-\lambda(t-s)}|\mathcal{F}(f \Psi)(s, \xi, \xi(t-s))|^{2} d s d t \\
& \leq \lambda \mathbb{E} \int_{0}^{T} \int_{s}^{T}|\mathcal{F}(f \Psi)(s, \xi, \xi(t-s))|^{2} d t d s \leq \lambda \mathbb{E} \int_{0}^{T}\left(\int_{\mathbb{R}}|\mathcal{F}(f \Psi)(s, \xi, \xi t)|^{2} d t\right) d s
\end{aligned}
$$

and the same manipulation leads to

Similarly, for the third term $J_{3}(\xi)$, Jensen's inequality gives

& \leq \lambda^{-1} \mathbb{E} \int_{0}^{T} \int_{0}^{t} e^{-\lambda(t-s)}|\xi|^{4}(t-s)^{4}\left|\mathcal{F}\left(G^{\beta} \Psi\right)(s, \xi, \xi(t-s))\right|^{2} d s d t \\
& \lesssim \lambda^{-5}|\xi|^{4} \mathbb{E} \int_{0}^{T}\left(\int_{\mathbb{R}}\left|\mathcal{F}\left(G^{\beta} \Psi\right)(s, \xi, \xi t)\right|^{2} d t\right) d s
\end{aligned}
$$

where we have used $e^{-\lambda(t-s)}(t-s)^{4} \lesssim \lambda^{-4}$. The same manipulation hence leads to

\end{aligned}
$$

and the same manipulation leads to

I_{1} & =\mathbb{E} \int_{0}^{T} \int_{\mathbb{R}^{d}}\left|\widehat{\rho_{\varphi}}(t, \xi)\right|^{2} d \xi d t+\mathbb{E} \int_{0}^{T} \int_{|\xi| \leq 1}|\xi|^{2 \eta}\left|\widehat{\rho_{\varphi}}(t, \xi)\right|^{2} d \xi d t,  \tag{3.27}\\
I_{2} & =\mathbb{E} \int_{0}^{T} \int_{|\xi|>1}|\xi|^{2 \eta}\left|\widehat{\rho_{\varphi}}(t, \xi)\right|^{2} d \xi d t . \tag{3.28}
\end{align*}
$$

On one hand, making use of Plancherel's identity, and since $\varphi$ is compactly supported,

& \lesssim \mathbb{E} \int_{0}^{T} \int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}}|f(t, x, v)|^{2} d v d x d t \lesssim 1
\end{aligned}
$$

thanks to Proposition 3.1, and the initial bound (3.14). On the other hand, from the bounds (3.23), (3.24), (3.25) and (3.26) we deduce (using Plancherel's identity once again)

& \times\left[\int_{z \in \mathbb{R}^{2 d}}\left|f_{0}\right|^{2} d z+\mathbb{E} \int_{0}^{T} \int_{z \in \mathbb{R}^{2 d}}\left(|f|^{2}+\left|G^{\beta}\right|^{2}+\left|H^{i}\right|^{2}\right) d z d t\right] . \tag{3.29}
\end{align*}
$$

Expressions (3.17) and the sublinearity estimate (2.4) immediately give

& \left|G^{i}(t, z)\right|^{2} \lesssim\left(1+|v|^{2}+\int\left|v^{\prime}\right|^{2} f\left(t, z^{\prime}\right) d z^{\prime}+\left|u_{R}[f(t)](x)\right|^{2}\right)|f(t, z)|^{2},  \tag{3.30}\\
& \left|G^{i j}(t, z)\right|^{2} \lesssim\left(1+|v|^{4}+\int\left|v^{\prime}\right|^{4} f\left(t, z^{\prime}\right) d z^{\prime}\right)|f(t, z)|^{2},  \tag{3.31}\\
& \left|H^{i}(t, z)\right|^{2} \lesssim\left(1+|v|^{2}+\int\left|v^{\prime}\right|^{2} f\left(t, z^{\prime}\right) d z^{\prime}\right)|f(t, z)|^{2}, \tag{3.32}
\end{align*}
$$

from which we easily deduce (using the same method as in the proof of Proposition 3.3 for the term involving $\left.u_{R}[f(t)]\right)$, for $\theta \in(0,1)$,

& \int_{z \in \mathbb{R}^{2 d}}\left|G^{i}\right|^{2} d z \lesssim \int_{z \in \mathbb{R}^{2 d}}\left(1+|v|^{\frac{2}{1-\theta}}\right) f(t) d z+\int_{z \in \mathbb{R}^{2 d}}|f(t)|^{1+\frac{1}{\theta}} d z, \\
& \int_{z \in \mathbb{R}^{2 d}}\left|G^{i j}\right|^{2} d z \lesssim \int_{z \in \mathbb{R}^{2 d}}\left(1+|v|^{\frac{4}{1-\theta}}\right) f(t) d z+\int_{z \in \mathbb{R}^{2 d}}|f(t)|^{1+\frac{1}{\theta}} d z, \\
& \int_{z \in \mathbb{R}^{2 d}}\left|H^{i}\right|^{2} d z \lesssim \int_{z \in \mathbb{R}^{2 d}}\left(1+|v|^{\frac{2}{1-\theta}}\right) f(t) d z+\int_{z \in \mathbb{R}^{2 d}}|f(t)|^{1+\frac{1}{\theta}} d z,
\end{aligned}
$$

so that, thanks again to Proposition 3.1, Proposition 3.3 and the initial bound (3.14), (3.29) yields

which can be met as soon as $\eta \leq 1 / 6$. For such $\eta$, we have shown that

which concludes the proof in the case of a regular initial data $f_{0} \in C_{c}^{2}\left(\mathbb{R}^{2 d}\right)$. We may extend this last inequality to general initial data similarly to the proof of Proposition 3.1.

H_{W^{-1}}^{-2}\left(\mathbb{R}^{2 d}\right)=\left(H_{W^{-1}}^{2}\left(\mathbb{R}^{2 d}\right)\right)^{\prime} \text { with }\|h\|_{H_{W-1}^{-2}}=\sup \left\{\langle h, \Psi\rangle,\|\Psi\|_{H_{W}^{2}}=1\right\} \tag{3.34}
\end{equation*}

We may also define the intermediate Sobolev spaces $H_{W}^{\sigma}\left(\mathbb{R}^{2 d}\right)$, $H_{W}^{-\sigma}\left(\mathbb{R}^{2 d}\right)$ for non-integer $0<$ $\sigma<2$. Note that $\|\Psi\|_{H^{2}} \leq\|\Psi\|_{H_{W}^{2}}$ so that $\|h\|_{H_{W-1}^{-2}} \leq\|h\|_{H^{-2}}$.

Proposition 3.5. Let us assume that the initial data $f_{0}$ satisfies, for some $\delta>1$ and $\theta \in(0,1)$,

\int_{z \in \mathbb{R}^{2 d}}\left|f_{0}(z)\right|^{p} d z+\int_{z \in \mathbb{R}^{2 d}}\left(|x|^{\delta}+|v|^{k}\right) f_{0}(z) d z<\infty \text { with } p=1+\frac{1}{\theta}, \quad k>\frac{4}{1-\theta} \tag{3.35}
\end{equation*}
$$

Then for all $\sigma>0$, the family of random variables $\left(f^{R}\right)_{R>0}$ is tight in $C\left([0, T] ; H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right)$.
Proof. Without loss of generality, let $\sigma \in(0,2)$. For some $\alpha \in(0,1 / 2)$ and $M>0$, let us introduce the set

$$
K_{M}=\left\{f \in C\left([0, T] ; H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right) \mid\|f\|_{L_{t}^{\infty} L_{z}^{2}} \leq M,\|f\|_{C_{t}^{\alpha} H_{W^{-1}}^{-2}} \leq M\right\}
$$

where $\|\cdot\|_{C_{t}^{\alpha} H_{W}^{-2}}$ denotes the $\alpha$-Hölder semi-norm

$$
\|f\|_{C_{t}^{\alpha} H_{W^{-1}}^{-2}}:=\sup _{t \neq s} \frac{\| f t)-f(s) \|_{H_{W^{-1}}^{-2}}}{|t-s|^{\alpha}} \leq\|f\|_{C_{t}^{\alpha} H^{-2}}
$$

Since the embedding $H_{W}^{\sigma}\left(\mathbb{R}^{2 d}\right) \subset L^{2}\left(\mathbb{R}^{2 d}\right)$ is compact, the dual embedding $L^{2}\left(\mathbb{R}^{2 d}\right) \subset H_{W}^{-\sigma}\left(\mathbb{R}^{2 d}\right)$ is compact. Additionally, for $f \in K_{M}$, an interpolation inequality (in weighted Sobolev spaces) yields, for some $\tau \in(0,1)$,

$$
\|f\|_{C_{t}^{\alpha} H_{W^{-1}}^{-\sigma}} \lesssim\|f\|_{L_{t}^{\infty} L_{W^{-1}}^{2}}^{\tau}\|f\|_{C_{t}^{\alpha} H_{W^{-1}}^{-2}}^{1-\tau} \lesssim M^{2}
$$

Consequently, Arzelà-Ascoli's theorem guarantees that $K_{M}$ is a relatively compact subset of the separable, complete space $C\left([0, T] ; H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right)$. Markov's inequality gives

$$
\left.\mathbb{P}\left[f^{R} \notin K_{M}\right] \leq M^{-2} \mathbb{E}\left[\sup _{t \in[0, T]}\left\|f^{R}(t)\right\|_{L^{2}}^{2}\right]+M^{-\gamma} \mathbb{E}\left[\left\|f^{R}\right\|_{C_{t}^{\alpha} H^{-2}}^{\gamma}\right]\right)
$$

for $\gamma>0$. The first term is bounded uniformly in $R$ thanks to Proposition 3.1. The bound on the second term results directly from Kolmogorov's continuity theorem and the following lemma.
Lemma 3.1. For some $q>1$, for all $t, s \in[0, T]$,

The constant involved in $\lesssim d e p e n d s$ on $q, f_{0}$ and $T$ only.
We now prove this lemma: let $0 \leq s \leq t \leq T$. Let us simply denote $f=f^{R}$ and note that

As in the proof of Proposition (3.4), we may apply the $(x, v)$-Fourier transform $\mathcal{F} f(t, \xi, \zeta)$ to equation (3.16) to get (forgetting the summation signs)

\mathcal{F} f(t)-\mathcal{F} f(s)=\int_{s}^{t}\left(-i \xi \cdot \mathcal{F}(v f)+i \zeta^{i} \mathcal{F}\left(G^{i}\right)-\zeta^{i} \zeta^{j} \mathcal{F}\left(G^{i j}\right)\right) d \sigma+i \int_{s}^{t} \zeta^{i} \mathcal{F}\left(H^{i}\right) d \beta_{\sigma}
$$

Itô's formula results in

$$
\begin{aligned}
|\mathcal{F} f(t)-\mathcal{F} f(s)|^{2}= & 2 \int_{s}^{t} \overline{\mathcal{F} f(\sigma)-\mathcal{F} t(s)}\left(-i \xi \cdot \mathcal{F}(v f)+i \zeta^{i} \mathcal{F}\left(G^{i}\right)-\zeta^{i} \zeta^{j} \mathcal{F}\left(G^{i j}\right)\right) d \sigma \\
& +\int_{s}^{t}\left|\zeta^{i}\right|^{2}\left|\mathcal{F}\left(H^{i}\right)\right|^{2} d \sigma+2 i \int_{s}^{t} \overline{\mathcal{F} f(\sigma)-\mathcal{F} t(s)} \zeta^{i} \mathcal{F}\left(H^{i}\right) d \beta_{\sigma}
\end{aligned}
$$

so that, integrating against $\left(1+|\xi|^{4}+|\zeta|^{4}\right)^{-1} d \xi d \zeta$, we get

$$
\begin{equation*}
\|f(t)-f(s)\|_{H^{-2}}^{2} \lesssim \int_{s}^{t}\|f(\sigma)-f(s)\|_{H^{-2}}^{2} d \sigma+D_{t}+M_{t} \tag{3.36}
\end{equation*}
$$

where

$$
\begin{aligned}
& D_{t}=\int_{s}^{t} \int_{\mathbb{R}^{2 d}}\left(|\mathcal{F}(v f)|^{2}+\left|\mathcal{F}\left(G^{i}\right)\right|^{2}+\left|\mathcal{F}\left(G^{i j}\right)\right|^{2}+\left|\mathcal{F}\left(H^{i}\right)\right|^{2}\right) d \xi d \zeta d \sigma \\
& M_{t}=2 i \int_{s}^{t}\left(\int_{\mathbb{R}^{2 d}}\left(1+|\xi|^{4}+|\zeta|^{4}\right)^{-1} \overline{\mathcal{F} f(\sigma)-\mathcal{F} t(s)} \zeta^{i} \mathcal{F}\left(H^{i}\right) d \xi d \zeta\right) d \beta_{\sigma}
\end{aligned}
$$

From (3.36) we derive

$$
\begin{equation*}
\mathbb{E}\|f(t)-f(s)\|_{H^{-2}}^{2 q} \lesssim \int_{s}^{t} \mathbb{E}\|f(\sigma)-f(s)\|_{H^{-2}}^{2 q} d \sigma+\mathbb{E}\left[\left|D_{t}\right|^{q}\right]+\mathbb{E}\left[\left|M_{t}\right|^{q}\right] \tag{3.37}
\end{equation*}
$$

Plancherel's identity gives

$$
\begin{aligned}
\left|D_{t}\right|^{q} & =\left|\int_{s}^{t}\left(\|v f\|_{L^{2}}^{2}+\left\|G^{i}\right\|_{L^{2}}^{2}+\left\|G^{i j}\right\|_{L^{2}}^{2}+\left\|H^{i}\right\|_{L^{2}}^{2}\right) d \sigma\right|^{q} \\
& \lesssim|t-s|^{q-1} \int_{s}^{t}\left(\|v f\|_{L^{2}}^{2 q}+\left\|G^{i}\right\|_{L^{2}}^{2 q}+\left\|G^{i j}\right\|_{L^{2}}^{2 q}+\left\|H^{i}\right\|_{L^{2}}^{2 q}\right) d \sigma
\end{aligned}
$$

so that

$$
\mathbb{E}\left[\left|D_{t}\right|^{q}\right] \lesssim|t-s|^{q} \mathbb{E}\left[\sup _{t \in[0, T]}\left(\|v f(t)\|_{L^{2}}^{2 q}+\left\|G^{i}(t)\right\|_{L^{2}}^{2 q}+\left\|G^{i j}(t)\right\|_{L^{2}}^{2 q}+\left\|H^{i}(t)\right\|_{L^{2}}^{2 q}\right)\right]
$$

Considering (3.30), (3.31), (3.32), we see that we essentially need a bound (uniform in $R$ ) on

$$
\begin{equation*}
\mathbb{E}\left[\left.\left.\sup _{t \in[0, T]}\left|\int_{\mathbb{R}^{2 d}}\left(1+|v|^{4}\right)\right| f(t, z)\right|^{2} d z\right|^{q}\right] . \tag{3.38}
\end{equation*}
$$

This is possible since, for any $m>2 d$,

$$
\begin{aligned}
\left.\left.\left|\int_{\mathbb{R}^{2 d}}\left(1+|v|^{4}\right)\right| f(t, z)\right|^{2} d z\right|^{q} & \lesssim \int_{\mathbb{R}^{2 d}}\left(1+|v|^{4 q}\right)(1+|z|)^{m(q-1)}|f|^{2 q} d z \\
& \lesssim \int_{\mathbb{R}^{2 d}}\left(1+|v|^{4 q+m(q-1)}+|x|^{m(q-1)}\right)|f|^{2 q} d z
\end{aligned}
$$

so that, for $\tau \in(0,1)$,

$$
\begin{aligned}
\left.\left.\left|\int_{\mathbb{R}^{2 d}}\left(1+|v|^{4}\right)\right| f(t, z)\right|^{2} d z\right|^{q} & \lesssim \int_{\mathbb{R}^{2 d}}\left(1+|x|^{\frac{m(q-1)}{1-\tau}}+|v|^{\frac{4 q+m(q-1)}{1-\tau}}\right) f d z+\int_{\mathbb{R}^{2 d}}|f|^{1+\frac{2 q-1}{\tau}} d z \\
& \lesssim \int_{\mathbb{R}^{2 d}}\left(1+|x|^{\delta}+|v|^{k}\right) f d z+\int_{\mathbb{R}^{2 d}}|f|^{p} d z
\end{aligned}
$$

whenever, recalling (3.35), for some $\gamma>0$,

$$
\frac{2 q-1}{\tau}=\frac{1}{\theta}, \quad \frac{m(q-1)}{1-\tau} \leq \delta, \quad \frac{4 q+m(q-1)}{1-\tau} \leq k:=\frac{4+\gamma}{1-\theta} .
$$

These requirements can be met for some $q=q(\gamma)>1$ close enough to 1 (and $\tau$ close to $\theta$ ). As for the martingale term, Burkholder-Davis-Gundy's inequality gives

\begin{align*}
\mathbb{E}\left[\left|M_{t}\right|^{q}\right] & \lesssim \mathbb{E}\left[\left|\int_{s}^{t}\left(\int_{\mathbb{R}^{2 d}}\left(1+|\xi|^{4}+|\zeta|^{4}\right)^{-1}\left|\mathcal{F} f(\sigma)-\mathcal{F} t(s)\|\zeta\| \mathcal{F}\left(H^{i}\right)\right| d \xi d \zeta\right)^{2} d \sigma\right|^{q / 2}\right] \\
& \lesssim \mathbb{E}\left[\left|\int_{s}^{t}\|f(\sigma)-f(s)\|_{H^{-2}}^{2}\left\|H^{i}\right\|_{L^{2}}^{2} d \sigma\right|^{q / 2}\right] \\
& \lesssim \mathbb{E}\left[\left|\sup _{t \in[0, T]}\left\|H^{i}(t)\right\|_{L^{2}}^{2}\right|^{q / 2}\left|\int_{s}^{t}\|f(\sigma)-f(s)\|_{H^{-2}}^{2} d \sigma\right|^{q / 2}\right] \\
& \lesssim \mathbb{E}\left[\sup _{t \in[0, T]}\left\|H^{i}(t)\right\|_{L^{2}}^{2 q}\right]+\int_{s}^{t} \mathbb{E}\|f(\sigma)-f(s)\|_{H^{-2}}^{2 q} d \sigma . \tag{3.39}
\end{align*}
$$

Considering (3.32), the first term in (3.39) is again controlled by the bound on (3.38). We may then come back to (3.37) and use Grönwall's lemma to conclude.

Proposition 3.6. Let us assume that the initial data $f_{0}$ satisfies (3.35).
Then, for all $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$, the family of random variables $\left(\rho_{\varphi}^{R}\right)_{R>0}$ is tight in $L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right)$.
Proof. Let us introduce the weight function

V(x)=1+|x|
$$

and the associated weighted spaces $H_{V}^{2}\left(\mathbb{R}^{d}\right)$ and $H_{V^{-1}}^{-2}\left(\mathbb{R}^{d}\right)$ as in (3.33) and (3.34). One could prove the following lemma as previously.
Lemma 3.2. For some $q>1$, for all $t, s \in[0, T]$,

\mathbb{E}\left[\left\|\rho_{\varphi}^{R}(t)-\rho_{\varphi}^{R}(s)\right\|_{H^{-2}}^{2 q}\right] \lesssim|t-s|^{q}
$$

The constant involved in $\lesssim$ depends on $q, f_{0}, \varphi$ and $T$ only.
We may now fix some $M>0$ and naturally introduce the set

$$
K_{M}=\left\{\rho_{\varphi}:=\int \varphi(v) f d v \mid f \in \mathcal{F}_{M}\right\}
$$

where $\mathcal{F}_{M}$ denotes the set of functions $f \equiv f(t, x, v)$ satisfying, for $\eta=1 / 6$ and some $\alpha \in(0,1 / 2)$,

$$
\begin{align*}
& \sup _{t \in[0, T]}\|f(t)\|_{L_{z}^{p}}^{p} \leq M  \tag{3.40}\\
& \sup _{t \in[0, T]} \int\left(1+|x|^{\delta}+|v|^{k}\right) f(t) d z \leq M  \tag{3.41}\\
& \left\|\rho_{\varphi}\right\|_{L_{t}^{2} H_{x}^{\eta}}^{2} \leq M  \tag{3.42}\\
& \left\|\rho_{\varphi}\right\|_{C_{t}^{\alpha} H^{-2}} \leq M
\end{align*}
$$

Markov's inequality, gives, for some $\gamma>0$,

$$
\begin{aligned}
\mathbb{P}\left[\rho_{\varphi}^{R} \notin K_{M}\right] \leq & M^{-1} \mathbb{E}\left[\sup _{t \in[0, T]}\left\|f^{R}(t)\right\|_{L_{z}^{p}}^{p}\right]+M^{-1} \mathbb{E}\left[\sup _{t \in[0, T]} \int\left(1+|x|^{\delta}+|v|^{k}\right) f^{R}(t) d z\right] \\
& +M^{-1} \mathbb{E}\left[\left\|\rho_{\varphi}^{R}\right\|_{L_{t}^{2} H_{x}^{\eta}}^{2}\right]+M^{-\gamma} \mathbb{E}\left[\left\|\rho_{\varphi}^{R}\right\|_{C_{t}^{\alpha} H^{-2}}^{\gamma}\right]
\end{aligned}
$$

which tends to zero uniformly in $R>0$ as $M$ goes to infinity, thanks to Proposition 3.1, 3.3, 3.4 and Lemma 3.2. It only remains to prove that $K_{M}$ is a relatively compact subset of $L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right)$. Let us introduce a sequence $\left(\rho_{\varphi}^{n}\right)_{n \geq 1}$ in $K_{M}$.

First, let us show that $\left(\rho_{\varphi}^{n}\right)_{n}$ is compact locally in space, that is in $L^{2}\left([0, T] ; L^{2}(B(0, r))\right)$ for any $r>0$. Since $\left\|\rho_{\varphi}^{n}\right\|_{L_{t}^{\infty} L_{x}^{1}} \leq\|\varphi\|_{L^{\infty}}$, we deduce from (3.40) that

\left\|\rho_{\varphi}^{n}\right\|_{L_{t}^{\infty} L_{x}^{2}} \lesssim M
$$

Similarly to the proof of Proposition 3.5, we may then use Arzelà-Ascoli's theorem to deduce that $\left(\rho_{\varphi}^{n}\right)_{n}$ converges in $C\left([0, T] ; H_{V^{-1}}^{-2}\left(\mathbb{R}^{d}\right)\right)$ up to some subsequence (which we omit for clarity). An interpolation inequality (in weighted Sobolev spaces: $H_{V^{-1}}^{\eta} \subset L_{V^{-1}}^{2} \subset H_{V^{-1}}^{-2}$ ) yields

\|\rho\|_{L^{2}(B(0, r))} \lesssim\|\rho\|_{L_{V^{-1}}^{2}} \lesssim\|\rho\|_{H_{V}^{-1}}^{\tau}\|\rho\|_{H_{V}^{-1}}^{1-\tau} \lesssim\|\rho\|_{H_{V-1}^{-2}}^{\tau}\|\rho\|_{H^{\eta}}^{1-\tau}
$$

where $\tau=\frac{\eta}{\eta+2} \in(0,1)$. It follows that

\int_{0}^{T}\left\|\rho_{\varphi}^{n}(t)-\rho_{\varphi}^{m}(t)\right\|_{L^{2}(B(0, r))}^{2} d t & \leq \int_{0}^{T}\left\|\rho_{\varphi}^{n}(t)-\rho_{\varphi}^{m}(t)\right\|_{H_{V-1}^{-2}}^{2 \tau} \times\left\|\rho_{\varphi}^{n}(t)-\rho_{\varphi}^{m}(t)\right\|_{H^{\eta}}^{2(1-\tau)} d t \\
& \leq\left(\int_{0}^{T}\left\|\rho_{\varphi}^{n}(t)-\rho_{\varphi}^{m}(t)\right\|_{H_{V-1}^{-2}}^{2} d t\right)^{\tau}\left(\int_{0}^{T}\left\|\rho_{\varphi}^{n}(t)-\rho_{\varphi}^{m}(t)\right\|_{H^{\eta}}^{2} d t\right)^{1-\tau} \\
& \leq T^{\tau}\left\|\rho_{\varphi}^{n}-\rho_{\varphi}^{m}\right\|_{C\left([0, T] ; H_{V-1}^{-2}\right)}^{2 \lambda} \times\left\|\rho_{\varphi}^{n}-\rho_{\varphi}^{m}\right\|_{L_{t}^{2} H^{\eta}}^{2(1-\tau)}
\end{aligned}
$$

Thanks to (3.42), we deduce that

$$
\left\|\rho_{\varphi}^{n}-\rho_{\varphi}^{m}\right\|_{L^{2}\left([0, T] ; L^{2}(B(0, r))\right.} \rightarrow 0 \text { as } n, m \rightarrow \infty .
$$

To derive compactness globally in space, that is in $L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right)$, it is enough to establish a uniform integrability estimate of the form

\sup _{n \geq 1}\left[\int_{0}^{T} \int_{|x| \geq r}\left|\rho_{\varphi}^{n}(t, x)\right|^{2} d x d t\right] \rightarrow 0 \text { as } r \rightarrow \infty

To this intent, since $\varphi$ is compactly supported, we may simply write

\int_{|x| \geq r}\left|\rho_{\varphi}^{n}(x)\right|^{2} d x \lesssim \int_{\mathbb{R}^{d}} \int_{|x| \geq r}\left|f^{n}(x, v)\right|^{2} d x d v & \leq r^{-\gamma} \int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}}\left(1+|x|^{\gamma}\right)\left|f^{n}(x, v)\right|^{2} d x d v \\
& \lesssim r^{-\gamma}\left(\int_{\mathbb{R}^{2 d}}\left(1+|x|^{\delta}\right) f^{n}(z) d z+\int_{\mathbb{R}^{2 d}}\left|f^{n}(z)\right|^{p} d z\right)
\end{aligned}
$$

where $\gamma=\delta(1-\theta)>0$, according to (3.35), and then use the bounds (3.40) and (3.41) to conclude.

### 3.4 Convergence of the martingale problem

Let us introduce a sequence $R_{n} \rightarrow \infty$ and a countable subset $\mathcal{D}$ of $C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$, which we assume to contain the truncation functions

\left\{\theta_{R_{n}}, n \geq 1\right\} \subset \mathcal{D} \subset C_{c}^{\infty}\left(\mathbb{R}^{d}\right) \tag{3.43}
\end{equation*}
$$

Recall that the function $\theta_{R}(v)$ has been introduced in (2.1). Since $\mathcal{D}$ is countable, it follows from Proposition 3.5, Proposition 3.6 and Tykhonov's theorem that the family of random variables $\left(f^{R_{n}},\left(\rho_{\varphi}^{R_{n}}\right)_{\varphi \in \mathcal{D}}\right)_{n \geq 1}$ is tight in the space

$$
C\left([0, T] ; H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right) \times\left(L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right)^{\mathcal{D}}\right.
$$

for $\sigma>0$. Using Skorokhod's representation theorem, up to a subsequence of $\left(R_{n}\right)_{n}$ which we omit for simplicity, we may introduce random variables $\bar{f}^{n}, \bar{\rho}_{\varphi}^{n}, \bar{f}, \bar{\rho}_{\varphi}$ defined on some other probability space $(\bar{\Omega}, \overline{\mathcal{F}}, \overline{\mathbb{P}})$ such that, for all $n \geq 1$,

\left(\bar{f}^{n},\left(\bar{\rho}_{\varphi}^{n}\right)_{\varphi \in \mathcal{D}}\right) \sim\left(f^{R_{n}},\left(\rho_{\varphi}^{R_{n}}\right)_{\varphi \in \mathcal{D}}\right) \text { in law, in } C\left([0, T] ; H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right) \times\left(L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right)\right)^{\mathcal{D}}
$$

and the following convergences hold $\overline{\mathbb{P}}$-almost surely:

$$
\begin{aligned}
& \bar{f}^{n} \rightarrow \bar{f} \text { in } C\left([0, T] ; H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right) \text { a.s, } \\
& \forall \varphi \in \mathcal{D}, \quad \bar{\rho}_{\varphi}^{n} \rightarrow \bar{\rho}_{\varphi} \text { in } L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right) \text { a.s. }
\end{aligned}
$$

More precisely, since Proposition 3.1 and Proposition 3.4 provide the bounds

$$
\begin{equation*}
\overline{\mathbb{E}}\left[\left\|\bar{f}^{n}\right\|_{L_{t}^{\infty} L_{x}^{2}}^{2}\right]=\mathbb{E}\left[\left\|f^{n}\right\|_{L_{t}^{\infty} L_{x}^{2}}^{2}\right] \lesssim 1, \quad \overline{\mathbb{E}}\left[\left\|\bar{\rho}_{\varphi}^{n}\right\|_{L_{t}^{2} H_{x}^{\eta}}^{2}\right]=\mathbb{E}\left[\left\|\rho_{\varphi}^{n}\right\|_{L_{t}^{2} H_{x}^{\eta}}^{2}\right] \lesssim 1 \tag{3.44}
\end{equation*}
$$

uniformly in $n \geq 1$, we derive in particular that the families of random variables $\left(\bar{f}^{n}\right)_{n}$ and $\left(\bar{\rho}_{\varphi}^{n}\right)_{n}$ are uniformly integrable, and therefore

$$
\begin{align*}
& \bar{f}^{n} \rightarrow \bar{f} \text { a.s and in } L^{1}\left(\bar{\Omega} ; C\left([0, T] ; H_{W^{-1}}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right)\right)  \tag{3.45}\\
& \forall \varphi \in \mathcal{D}, \quad \bar{\rho}_{\varphi}^{n} \rightarrow \bar{\rho}_{\varphi} \text { a.s and in } L^{1}\left(\bar{\Omega} ; L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right)\right) . \tag{3.46}
\end{align*}

Consequently, up to a subsequence, we may also assume that

Coming back to (3.56), we have shown that

$$
\begin{aligned}
& \int_{s}^{t} \mathcal{M}_{n}^{1}\left(\bar{f}^{n}(\sigma)\right) d \sigma \rightarrow \int_{s}^{t} \mathcal{M}^{1}(\bar{f}(\sigma)) d \sigma \text { in probability, } \\
& \overline{\mathbb{E}}\left[\left|\int_{s}^{t} \mathcal{M}_{n}^{1}\left(\bar{f}^{n}(\sigma)\right) d \sigma\right|^{2+\gamma}\right] \lesssim 1
\end{aligned}
$$

which is sufficient to pass to the limit in the corresponding term of (3.53) and the left-hand side of (3.54).

The terms involving $\mathcal{M}_{n}^{i}(f)$ for $i=2,3,5$ can be treated with similar arguments. Let us now handle the more delicate term, involving $\mathcal{M}_{n}^{4}(f)$ : we wish to prove that

$$
\begin{equation*}
\int_{s}^{t} \int_{x} \frac{\phi * \bar{\rho}_{\theta_{R_{n}}}^{n}}{R_{n}^{-1}+\phi * \bar{\rho}^{n}} \cdot \bar{\rho}_{\nabla \Psi_{2}}^{n} \Psi_{1} d x d \sigma=\int_{s}^{t} \int_{x} u_{R}\left[\bar{f}^{n}\right] \cdot \bar{\rho}_{\nabla \Psi_{2}}^{n} \Psi_{1} d x d \sigma \tag{3.58}
\end{equation*}
$$

converges to the expected limiting term. Let us introduce

$$
\begin{equation*}
\bar{J}^{n}:=u_{R_{n}}\left[\bar{f}^{n}\right] \cdot \bar{\rho}_{\nabla \Psi_{2}}^{n}=u_{R_{n}}\left[\bar{f}^{n}\right] \cdot \int_{v} \nabla_{v} \Psi_{2}(v) \bar{f}^{n} d v . \tag{3.59}
\end{equation*}
$$

For some $q>2$ and $\tau \in(0,1)$, we have

$$
\begin{aligned}
\int\left|\bar{J}^{n}\right|^{q} d x \lesssim \int_{x} \int_{v}\left|u_{R_{n}}\left[\bar{f}^{n}\right]\right|^{q}\left|\bar{f}^{n}\right|^{q} d x d v & \lesssim \int_{x} \int_{v}\left|u_{R_{n}}\left[\bar{f}^{n}\right]\right|^{\frac{q}{1-\tau}} \bar{f}^{n} d x d v+\int_{x} \int_{v}\left|\bar{f}^{n}\right|^{1+\frac{q-1}{\tau}} d x d v \\
& \lesssim \int_{x} \int_{v}\left(1+\left|u_{R_{n}}\left[\bar{f}^{n}\right]\right|^{k}\right) \bar{f}^{n} d x d v+\int_{x} \int_{v}\left|\bar{f}^{n}\right|^{p} d x d v
\end{aligned}
$$

as soon as $\tau=\theta(q-1)$ and $\frac{q}{1-\tau} \leq \frac{4}{1-\theta}$, which can be met for $q$ close enough to 2 . Hence, thanks to Proposition 3.2, we derive

$$
\begin{equation*}
\overline{\mathbb{E}}\left[\sup _{t \in[0, T]} \int_{x}\left|\bar{J}^{n}(t, x)\right|^{q} d x\right] \lesssim \mathbb{E}\left[\sup _{t \in[0, T]}\left(\int_{z}(1+|v|)^{k} f^{n}(t, z) d z+\int_{z}\left|f^{n}(t, z)\right|^{p} d z\right)\right] \lesssim 1 \tag{3.60}
\end{equation*}
$$

As a consequence, up to some subsequence which we omit for simplicity,

$$
\begin{equation*}
\bar{J}^{n} \rightharpoonup \bar{J} \quad \text { weak } * \text { in } L^{q}\left(\bar{\Omega} ; L^{\infty}\left([0, T] ; L^{q}\left(\mathbb{R}^{d}\right)\right)\right) \tag{3.61}
\end{equation*}
$$

It is clear that this weak convergence is enough for the term (3.58) to pass to the limit in (3.53). Therefore, it only remains to identify the limit as

$$
\bar{J}=\bar{u} \cdot \bar{\rho}_{\nabla \Psi_{2}}, \quad \text { where } \bar{u}(x, t):=u[\bar{f}](x, t)= \begin{cases}\frac{(\phi * \bar{j})(t, x)}{(\phi * \bar{\rho})(t, x)} & \text { if }(\phi * \bar{\rho})(t, x) \neq 0  \tag{3.62}\\ 0 & \text { if }(\phi * \bar{\rho})(t, x)=0\end{cases}
$$

First, considering the set, for $r>0, \omega \in \bar{\Omega}$,

$$
A_{r}(\omega)=\{(t, x) \in[0, T] \times B(0, r) \mid(\phi * \bar{\rho})(\omega, t, x)=0\}
$$

we have

$$
\begin{equation*}
\int_{A_{r}}\left|\bar{J}^{n}\right| d x d t \lesssim\left(\int_{(t, x) \in A_{r}} \int_{v \in S u p p\left(\Psi_{2}\right)}\left|u_{R_{n}}\left[\bar{f}^{n}\right]\right|^{2} \bar{f}^{n} d x d t\right)^{1 / 2}\left(\int_{A_{r}} \bar{\rho}^{n} d x d t\right)^{1 / 2} \tag{3.63}
\end{equation*}
$$

so that, with Proposition 3.2,

$$
\left.\left.\overline{\mathbb{E}}\left[\int_{A_{r}(\omega)}\left|\bar{J}^{n}\right| d x d t\right] \lesssim \mathbb{E}\left[\int_{0}^{T} \int_{\mathbb{R}^{2} d} \mid v\right]\right|^{2} f^{R_{n}} d z d t\right]^{1 / 2} \overline{\mathbb{E}}\left[\int_{A_{r}(\omega)} \bar{\rho}^{n} d x d t\right]^{1 / 2} \lesssim \overline{\mathbb{E}}\left[\int_{A_{r}(\omega)} \bar{\rho}^{n} d x d t\right]^{1 / 2} .
$$

From (3.61) and Lemma 3.3, we deduce

$$
\overline{\mathbb{E}}\left[\int_{0}^{T} \int_{A_{r}(\omega)}|\bar{J}| d x d t\right] \lesssim \overline{\mathbb{E}}\left[\int_{0}^{T} \int_{\{x \in B(0, r) \mid \phi * \bar{\rho}=0\}} \bar{\rho} d x d t\right]^{1 / 2}=0 .
$$

Indeed, it is easy to see that, when $\rho \in C\left(\mathbb{R}^{d}\right)$,

$$
\int_{\{x \in B(0, r) \mid \phi * \bar{\rho}=0\}} \rho(x) d x=0
$$

and the same equality is deduced for any $\rho \in L^{2}\left(\mathbb{R}^{d}\right)$ by density. Hence, $\overline{\mathbb{P}}$ almost surely, $\bar{J}=0$ a.e on $A_{r}$. Since this holds for any $r>0$, we deduce that, $\mathbb{P}$ almost surely, $\bar{J}=0$ holds whenever $\phi * \bar{\rho}=0$, so that we only have to check equality (3.62) whenever $(\phi * \bar{\rho})(t, x) \neq 0$.

Recalling (3.47) and Lemma 3.3, we have

$$
\bar{J}^{n}=\frac{\phi * \bar{\rho}_{\theta_{R_{n}}}^{n}}{R_{n}^{-1}+\phi * \bar{\rho}^{n}} \cdot \bar{\rho}_{\nabla \Psi_{2}}^{n} \rightarrow \frac{\phi * \bar{j}}{\phi * \bar{\rho}} \cdot \bar{\rho}_{\nabla \Psi_{2}}=\bar{u} \cdot \rho_{\nabla \Psi_{2}}
$$

almost everywhere on the set $\left\{(t, x) \in[0, T] \times \mathbb{R}^{d} \mid \phi * \bar{\rho} \neq 0\right\}, \overline{\mathbb{P}}$ almost surely. It follows that equality (3.62) holds.

Finally, it remains to pass (3.58) to the limit in the quadratic equality (3.54). To this intent, we simply notice that

$$
\left|\int_{s}^{t} \int_{x} \frac{\phi * \bar{\rho}_{\theta_{R_{n}}}^{n}}{R_{n}^{-1}+\phi * \bar{\rho}^{n}} \cdot \bar{\rho}_{\nabla \Psi_{2}}^{n} \Psi_{1} d x d \sigma\right|^{2}=\int_{\sigma_{1}} \int_{\sigma_{2}} \int_{x} \int_{y} \bar{J}^{n}\left(\sigma_{1}, x\right) \bar{J}^{n}\left(\sigma_{2}, y\right) \Psi_{1}(x) \Psi_{2}(y) d x d y d \sigma_{1} d \sigma_{2}
$$

where $\bar{J}^{n}(\sigma, x)$ is defined as in (3.59). We have the uniform bound
with $q / 2>1$ so that, up to some subsequence

$$
\bar{J}^{n}\left(\sigma_{1}, x\right) \bar{J}^{n}\left(\sigma_{2}, y\right) \rightharpoonup \bar{J}\left(\sigma_{1}, \sigma_{2}, x, y\right) \text { weak } * \text { in } L^{q / 2}\left(\bar{\Omega} ; L^{\infty}\left([0, T]^{2} ; L^{q}\left(\left(\mathbb{R}^{d}\right)^{2}\right)\right)\right)
$$

This time, thanks to (3.60)

$$
\begin{aligned}
\overline{\mathbb{E}}\left[\int_{\left(x, \sigma_{1}\right) \in A_{r}}\right. & \left.\int_{\left(y, \sigma_{2}\right) \in B(0, r) \times[0, T]}\left|\bar{J}^{n}\left(\sigma_{1}, x\right) \bar{J}^{n}\left(\sigma_{2}, y\right)\right| d x d \sigma_{1} d y d \sigma_{2}\right] \\
& \lesssim \overline{\mathbb{E}}\left[\left(\int_{A_{r}}\left|\bar{J}^{n}\right| d x d t\right)^{2}\right]^{1 / 2} \overline{\mathbb{E}}\left[\int_{0}^{T} \int_{B(0, r)}\left|\bar{J}^{n}\right|^{2} d x d t\right]^{1 / 2} \lesssim \overline{\mathbb{E}}\left[\left(\int_{A_{r}}\left|\bar{J}^{n}\right| d x d t\right)^{2}\right]^{1 / 2} .
\end{aligned}
$$

Using (3.63), it follows that

$$
\begin{aligned}
\overline{\mathbb{E}}\left[\left(\int_{A_{r}}\left|\bar{J}^{n}\right| d x d t\right)^{2}\right] & \lesssim \mathbb{E}\left[\int_{0}^{T} \int_{\mathbb{R}^{2 d}}\left|u_{R_{n}}\left[f^{R_{n}}\right]\right|^{4}\left|f^{R_{n}}\right|^{2} d z d t\right]^{1 / 2} \overline{\mathbb{E}}\left[\int_{A_{r}}\left|\bar{\rho}^{n}\right|^{2} d x d t\right]^{1 / 2} \\
& \lesssim \mathbb{E}\left[\int_{0}^{T} \int_{\mathbb{R}^{2 d}}|v|^{k} f^{R_{n}}+\left|f^{R_{n}}\right|^{p} d z d t\right]^{1 / 2} \overline{\mathbb{E}}\left[\int_{A_{r}}\left|\bar{\rho}^{n}\right|^{2} d x d t\right]^{1 / 2} \\
& \lesssim \overline{\mathbb{E}}\left[\int_{A_{r}}\left|\bar{\rho}^{n}\right|^{2} d x d t\right]^{1 / 2}
\end{aligned}
$$

Using again Lemma 3.3, we deduce that, $\overline{\mathbb{P}}$ almost surely, $\bar{J}=0$ almost everywhere on

$$
\left\{\left(\sigma_{1}, \sigma_{2}, x, y\right) \in[0, T]^{2} \times\left(\mathbb{R}^{d}\right)^{2} \mid(\phi * \bar{\rho})\left(\sigma_{1}, x\right)=0 \text { or }(\phi * \bar{\rho})\left(\sigma_{2}, y\right)=0\right\}
$$

The limit is then determined to be $\bar{J}\left(\sigma_{1}, \sigma_{2}, x, y\right)=\left(\bar{u}(x) \cdot \rho_{\nabla \Psi_{2}}\left(\sigma_{1}, x\right)\right)\left(\bar{u}(y) \cdot \rho_{\nabla \Psi_{2}}\left(\sigma_{2}, y\right)\right)$ on the complementary set using pointwise convergence, as done previously.

From the martingale problem of Proposition 3.7, we classically construct a martingale solution of (1.7), in the sense of Definition 1.1, using a martingale representation theorem. First, note that estimates (1.13) and (1.14) are easily derived from the convergence (3.45) using Fatou's Lemma. Introducing the process

$$
\begin{equation*}
\bar{M}(t)=\bar{f}(t)-f_{0}-\int_{0}^{t}(\mathcal{L}[\bar{f}(s)])^{*} \bar{f}(s) d s, \quad t \in[0, T] \tag{3.64}
\end{equation*}
$$

we see that, for all test function $\Psi \in C_{c}^{\infty}\left(\mathbb{R}^{2 d}\right)$ of the form (3.52),

$$
\langle\bar{M}(t), \Psi\rangle=\bar{M}_{\Psi}(t), \quad t \in[0, T]
$$

which is a continuous $L^{2}$ martingale with respect to the filtration $\left(\overline{\mathcal{F}}_{t}\right)_{t \in[0, T]}$, with quadratic variation $\bar{V}_{\Psi}$. With Remark 3.2 in mind, by density, we may carefully extend this statement to any test function $\Psi$ in some separable Hilbert space $\mathcal{H}$. One may convince oneself for instance that the weighted Sobolev space

$$
\mathcal{H}=\left\{\Psi \in D^{\prime}\left(\mathbb{R}^{2 d}\right), \quad \max _{|\beta| \leq 2} \int_{\mathbb{R}^{2 d}} e^{|z|}\left|\partial_{z}^{\beta} \Psi(z)\right|^{2} d z\right\}
$$

is suitable. Using a polarization formula, we deduce that for $\Psi_{1}, \Psi_{2} \in \mathcal{H}$,

$$
\left\langle\bar{M}(t), \Psi_{1}\right\rangle\left\langle\bar{M}(t), \Psi_{2}\right\rangle-\left\langle\bar{V}(t) \Psi_{1}, \Psi_{2}\right\rangle, \quad t \in[0, T]
$$

defines a continuous $\left(\overline{\mathcal{F}}_{t}\right)_{t \in[0, T]}$-martingale, where the operator $\bar{V}(t)$ is defined through

$$
\left\langle\bar{V}(t) \Psi_{1}, \Psi_{2}\right\rangle=\int_{0}^{t}\left\langle K[\bar{f}(s)] \cdot \nabla_{v} \Psi_{1}, \bar{f}(s)\right\rangle\left\langle K[\bar{f}(s)] \cdot \nabla_{v} \Psi_{2}, \bar{f}(s)\right\rangle d s
$$

The martingale representation theorem from [8] (p222, Theorem 9.2) holds for the $\mathcal{H}^{\prime}$-valued process $(3.64)$, giving another probability space $(\hat{\Omega}, \hat{\mathcal{F}}, \hat{\mathbb{P}})$ equipped with a filtration $\left(\hat{\mathcal{F}}_{t}\right)_{t \in[0, T]}$, and a $\left(\overline{\mathcal{F}}_{t} \times \hat{\mathcal{F}}_{t}\right)$-brownian motion $\left(W_{t}\right)_{t \in[0, T]}$ on $\bar{\Omega} \times \hat{\Omega}$ such that

$$
\bar{M}(t)(\bar{\omega}, \hat{\omega}):=\bar{M}(t)(\bar{\omega})=-\int_{0}^{t} \nabla_{v} \cdot(K[\bar{f}(s)] \bar{f}(s)) d W_{s}(\bar{\omega}, \hat{\omega})
$$

It follows that $(\bar{\omega}, \hat{\omega}) \in \bar{\Omega} \times \hat{\Omega} \mapsto(\bar{f}(t)(\bar{\omega}))_{t \in[0, T]}$ defines a solution of (1.7) on $\bar{\Omega} \times \hat{\Omega}$. This concludes the proof of Theorem 1 .

### 3.5 Strong local alignment

The proof of Theorem 2 can be established using the same arguments. Indeed, the only role played by the weight function $\phi$ in the estimates of sections 3.1 and 3.2 is through the constant $C(\phi)$ in Proposition 3.2, given by (3.9). Introducing $\phi_{r}$ of the form $\phi_{r}(x)=r^{d} \phi_{1}(x / r)$ we notice that

$$
C\left(\phi_{r}\right) \propto \frac{r^{d} \sup _{B\left(0, r_{2}\right)} \phi_{1}}{\inf _{B\left(0, r_{1}\right)} \phi_{1}}\left(\frac{r_{2}}{r_{1} \times r}\right)^{d}=\frac{\sup _{B\left(0, r_{2}\right)} \phi_{1}}{\inf _{B\left(0, r_{1}\right)} \phi_{1}}\left(\frac{r_{2}}{r_{1}}\right)^{d} \propto C\left(\phi_{1}\right)
$$

uniformly in $r>0$. As a result, introducing $f^{r}$ a weak solution of (1.7) with $\phi=\phi^{r}$ constructed (in law) as previously, the following estimates hold uniformly in $r>0$ : for any $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$,

$$
\mathbb{E}\left[\sup _{t \in[0, T]} \int_{\mathbb{R}^{2} d}\left|f^{r}(t, z)\right|^{p}+\left(1+|x|^{2}+|v|^{k}\right) f^{r}(t, z) d z\right]+\mathbb{E}\left[\left\|\rho_{\varphi}^{r}\right\|_{L_{t}^{2} H_{x}^{\eta}}^{2}\right] \lesssim 1
$$

and for some $q>1$,

$$
E\left[\left\|f^{r}(t)-f^{r}(s)\right\|_{H^{-2}}^{2 q}\right]+\mathbb{E}\left[\left\|\rho^{r}(t)-\rho^{r}(s)\right\|_{H^{-2}}^{2 q}\right] \leq|t-s|^{q} .
$$

From here, we may use the same arguments as previously to establish the tightness of $\left(f^{r}\right)_{r>0}$ (resp. $\left.\left(\rho_{\varphi}^{r}\right)_{r>0}\right)$ in $C\left([0, T] ; H_{W-1}^{-\sigma}\left(\mathbb{R}^{2 d}\right)\right.$ ) for $\sigma>0\left(\right.$ resp. in $L^{2}\left([0, T] ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ ) and then pass to the limit in the martingale problem satisfied by $f^{r_{n}}$ as $n$ goes to infinity.
