## NEW STABILITY RESULTS FOR A LINEAR THERMOELASTIC BRESSE SYSTEM WITH SECOND SOUND

ABSTRACT. In this paper, we consider a linear one-dimensional thermoelastic Bresse system with second sound consisting of three hyperbolic equations and two parabolic equations coupled in a certain manner under mixed homogeneous Dirichlet-Neumann boundary conditions, where the heat conduction is given by Cattaneo's law. Only the longitudinal displacement is damped via the dissipation from the two parabolic equations, and the vertical displacement and shear angle displacement are free. We prove the well-posedness of the system and some exponential, non exponential and polynomial stability results depending on the coefficients of the equations and the smoothness of initial data. Our method of proof is based on the semigroup theory and a combination of the energy method and the frequency domain approach.

**Keywords:** Bresse system, Heat conduction, Well-posedness, Asymptotic behavior, Semigroup theory, Energy method, Frequency domain approach.

#### 1. INTRODUCTION

In this paper, we consider the following linear Bresse system with second sound: (1.1) (1.1)  $h_{1}(x_{1}, y_{2}, y_{3}) = h_{2}(x_{1}, y_{3}) = h_{3}(x_{1}, y_{3}) = h_{3}(x$

with the initial data

$$\begin{cases} \varphi(x,0) = \varphi_0(x), \ \varphi_t(x,0) = \varphi_1(x) & \text{in } (0,1), \\ \psi(x,0) = \psi_0(x), \ \psi_t(x,0) = \psi_1(x) & \text{in } (0,1), \\ w(x,0) = w_0(x), \ w_t(x,0) = w_1(x) & \text{in } (0,1), \\ \theta(x,0) = \theta_0(x), \ q(x,0) = q_0(x) & \text{in } (0,1) \end{cases}$$

and mixed homogeneous Dirichlet-Neumann boundary conditions

(1.3) 
$$\begin{cases} \varphi(0,t) = \psi_x(0,t) = w_x(0,t) = \theta(0,t) = 0 & \text{in } (0,\infty), \\ \varphi_x(1,t) = \psi(1,t) = w(1,t) = q(1,t) = 0 & \text{in } (0,\infty), \end{cases}$$

where  $\rho_1$ ,  $\rho_2$ ,  $\rho_3$ , b, k,  $k_0$ ,  $\tau$ ,  $\beta$ ,  $\delta$  and l are positive constants, the initial data  $\varphi_0$ ,  $\varphi_1$ ,  $\psi_0$ ,  $\psi_1$ ,  $w_0$ ,  $w_1$ ,  $\theta_0$  and  $q_0$  belong to a suitable Hilbert space, and the unknowns

of (1.1) - (1.3) are the following variables:

$$(\varphi, \psi, w, \theta, q) : (0, 1) \times (0, \infty) \to \mathbb{R}^5.$$

The Bresse system [3] is consisting of three coupled hyperbolic equations

(1.4) 
$$\begin{cases} \rho_1 \varphi_{tt} - k \left( \varphi_x + \psi + l \, w \right)_x - lk_0 \left( w_x - l \varphi \right) = F_1 & \text{in } (0, L) \times (0, \infty) ,\\ \rho_2 \psi_{tt} - b \psi_{xx} + k \left( \varphi_x + \psi + l \, w \right) = F_2 & \text{in } (0, L) \times (0, \infty) ,\\ \rho_1 w_{tt} - k_0 \left( w_x - l \varphi \right)_x + lk \left( \varphi_x + \psi + l \, w \right) = F_3 & \text{in } (0, L) \times (0, \infty) , \end{cases}$$

where L > 0,

$$F_i: (0,L) \times (0,\infty) \to \mathbb{R}$$

are the external forces (controllers) and w,  $\varphi$  and  $\psi$  represent, respectively, the longitudinal, vertical and shear angle displacements. For more details, we refer to [14] and [15].

For the last few years, many researchers studied the well-posedness and the stability of Bresse systems (1.4). Under different types of controls  $F_i$ , various stability results have been obtained depending on the nature and the number of controls, the regularity of initial data and the following parameters:

(1.5) 
$$s_1 = \frac{k}{\rho_1}, \quad s_2 = \frac{b}{\rho_2} \quad \text{and} \quad s_3 = \frac{k_0}{\rho_1};$$

for this purpose, we refer the reader to [1], [2], [4], [7], [20], [23], [24], [25] and [26] in case of (local or global, linear or nonlinear) frictional damping, and [5], [9], [10] and [11] in case of memories. In some papers, it was proved that, when each equation of (1.4) is directly damped; that is

 $F_1F_2F_3 \neq 0,$ 

the stability of (1.4) holds regardless to  $s_1$ ,  $s_2$  and  $s_3$ . However, when at least one equation in (1.4) is free; that is

$$F_1F_2F_3 = 0$$
 and  $(F_1, F_2, F_3) \neq (0, 0, 0),$ 

system (1.4) is still stable depending on the relation between the coefficients  $s_1$ ,  $s_2$  and  $s_3$  like:

$$s_i = s_j, \quad i, j \in \{1, 2, 3\}.$$

When

$$(F_1, F_2, F_3) = (0, 0, 0),$$

system (1.4) is conservative, which means that the energy is conserved and equal to the energy of initial data along the trajectory of solutions.

When the Bresse system is indirectly damped via the coupling (in a certain manner) with other equations, we mention here the work [17], where the authors studied the stability of a thermoelastic Bresse system consisting of the following

equations: (1.6)

with homogeneous Dirichlet-Neumann-Neumann boundary conditions

(1.7) 
$$\varphi(x,t) = \psi_x(x,t) = w_x(x,t) = \theta(x,t) = q(x,t) = 0, \quad x = 0, L, t \in (0,\infty)$$

or homogeneous Dirichlet-Dirichlet-Dirichlet boundary conditions

$$(1.8) \quad \varphi(x,t) = \psi(x,t) = w(x,t) = \theta(x,t) = q(x,t) = 0, \quad x = 0, \, L, \, t \in (0,\infty) \, .$$

They proved that the norm of solutions in the energy space decays exponentially to zero at infinity if

(1.9) 
$$s_1 = s_2 = s_3.$$

Otherwise, the norm of solutions decays polynomially to zero with rates depending on the regularity of the initial data. For the classical solutions, these rates were  $t^{-\frac{1}{4}+\epsilon}$  in case (1.7), and  $t^{-\frac{1}{8}+\epsilon}$  in case (1.8), where  $\epsilon$  is an arbitrary positive constant.

In [8], the authors considered the following coupled Bresse system with only one heat equation:

(1.10) 
$$\begin{cases} \rho_{1}\varphi_{tt} - k\left(\varphi_{x} + \psi + l\,w\right)_{x} - lk_{0}\left(w_{x} - l\varphi\right) = 0 & \text{in } (0, L) \times (0, \infty), \\ \rho_{2}\psi_{tt} - b\psi_{xx} + k\left(\varphi_{x} + \psi + l\,w\right) + \delta\theta_{x} = 0 & \text{in } (0, L) \times (0, \infty), \\ \rho_{1}w_{tt} - k_{0}\left(w_{x} - l\varphi\right)_{x} + lk\left(\varphi_{x} + \psi + l\,w\right) = 0 & \text{in } (0, L) \times (0, \infty), \\ \rho_{3}\theta_{t} - \theta_{xx} + (\beta\psi_{t})_{x} = 0 & \text{in } (0, L) \times (0, \infty) \end{cases}$$

with (1.7) or (1.8). They proved that the exponential stability of (1.10) is equivalent to (1.9). On the other hand, when (1.9) is not satisfied, the obtained decay rate in [8] for classical solutions is  $t^{-\frac{1}{6}+\epsilon}$  in general, and  $t^{-\frac{1}{3}+\epsilon}$  when  $s_1 \neq s_2$  and  $s_1 = s_3$ . The results of [8] were extended in [19] to the case where the thermal dissipation is locally distributed; that is  $\delta$  and  $\beta$  are non negative functions on x such that theirs minimums on some open interval  $I \subset (0, L)$  are positive. Moreover, when (1.9) is not satisfied, the authors of [19] improved the polynomial stability estimates of [8] by getting the decay rates  $t^{-\frac{1}{4}}$  and  $t^{-\frac{1}{2}}$  instead of  $t^{-\frac{1}{6}+\epsilon}$  and  $t^{-\frac{1}{3}+\epsilon}$ , respectively.

In [13], the authors considered the following coupled system:

(1.11) 
$$\begin{cases} \rho_{1}\varphi_{tt} - k\left(\varphi_{x} + \psi + l\,w\right)_{x} - lk_{0}\left(w_{x} - l\varphi\right) = 0 & \text{in } (0,1) \times (0,\infty), \\ \rho_{2}\psi_{tt} - b\psi_{xx} + k\left(\varphi_{x} + \psi + l\,w\right) + \delta\theta_{x} = 0 & \text{in } (0,1) \times (0,\infty), \\ \rho_{1}w_{tt} - k_{0}\left(w_{x} - l\varphi\right)_{x} + lk\left(\varphi_{x} + \psi + l\,w\right) = 0 & \text{in } (0,1) \times (0,\infty), \\ \rho_{3}\theta_{t} + q_{x} + \delta\psi_{xt} = 0 & \text{in } (0,1) \times (0,\infty), \\ \tau q_{t} + \beta q + \theta_{x} = 0 & \text{in } (0,1) \times (0,\infty). \end{cases}$$

They proved that (1.11) is exponentially stable if

$$s_1 = s_3$$
,  $\left(\frac{\rho_1}{k} - \frac{\rho_2}{b}\right) \left(1 - \frac{\tau k \rho_3}{\rho_1}\right) = \frac{\tau \delta^2}{b}$  and  $l$  small,

and (1.11) is not exponentially stable if

$$s_1 \neq s_3$$
 or  $\left(\frac{\rho_1}{k} - \frac{\rho_2}{b}\right) \left(1 - \frac{\tau k \rho_3}{\rho_1}\right) \neq \frac{\tau \delta^2}{b}.$ 

Moreover, when

$$s_1 = s_3, \quad \left(\frac{\rho_1}{k} - \frac{\rho_2}{b}\right) \left(1 - \frac{\tau k \rho_3}{\rho_1}\right) \neq \frac{\tau \delta^2}{b} \quad \text{and} \quad l \text{ small},$$

the polynomial stability for (1.11) was proved in [13] with the decay rate  $t^{-\frac{1}{2}}$ .

In (1.6) and (1.10), the heat equations are governed by Fourier's law of heat conduction. However, the heat conduction in (1.1) and (1.11) is given by Cattaneo's law (for more details, see [13]).

In [6], the author considered the following coupled system:

(1.12) 
$$\begin{cases} \rho_{1}\varphi_{tt} - k(\varphi_{x} + \psi + lw)_{x} - lk_{0}(w_{x} - l\varphi) = 0, \\ \rho_{2}\psi_{tt} - b\psi_{xx} + k(\varphi_{x} + \psi + lw) + \delta\theta_{x} = 0, \\ \rho_{1}w_{tt} - k_{0}(w_{x} - l\varphi)_{x} + lk(\varphi_{x} + \psi + lw) = 0, \\ \rho_{3}\theta_{t} - k_{1}\int_{0}^{\infty} g(s)\theta_{xx}(t - s)ds + \gamma\psi_{xt} = 0, \end{cases}$$

with homogeneous Dirichlet-Neumann boundary conditions

(1.13) 
$$\varphi(x,t) = \psi_x(x,t) = w_x(x,t) = \theta(x,t) = 0, \quad x = 0, \, L, \, t \in (0,\infty)$$

He proved that (1.12) is exponentially stable if and if

(1.14) 
$$k = k_0, \quad \left(\frac{\rho_1}{\rho_3 k} - \frac{1}{g(0)k_1}\right) \left(\frac{\rho_1}{k} - \frac{\rho_2}{b}\right) - \frac{1}{g(0)k_1} \frac{\rho_1 \gamma^2}{\rho_3 k b} = 0.$$

On the other hand if (1.14) is not satisfied no decay rates was derived in [6]. We need to mention here, that the coupling (through the second equation) and the boundary conditions considered in [6] are not the same as the one considered in this paper. Notice that, when the three hyperbolic equations in Bresse system are (all or some of them) directly damped; that is

$$(F_1, F_2, F_3) \neq (0, 0, 0),$$

system (1.4) is dissipative. However, systems (1.1), (1.6), (1.10) and (1.11) are consisting of coupled conservative three hyperbolic equations with one or two parabolic equations, so the stability of the overall system is preserved thanks to the dissipation generated by the parabolic equations. On the other hand, we remark that in (1.6), the second and third hyperbolic equations are indirectly damped by the coupling with the heat equations, and the first hyperbolic one is only weakly damped through the coupling with the second and the third hyperbolic equations. On the other hand, in (1.10) and (1.11), only the second hyperbolic equations is effectively damped by the dissipation coming from the parabolic equations.

In our case (1.1), only the third hyperbolic equation is indirectly damped through the coupling with the heat equations. Our objective, first is to consider (1.1) - (1.3), we prove the well-posedness and we establish some decay rates for the solutions (like: exponential stability, non exponential stability and polynomial stability) depending on the relationship between the coefficients of (1.1) and the smoothness of the initial data.

Without loss of generality, we consider the domain (0,1) instead of (0, L). The proof of the well-posedness is based on the semigroup theory. However, the stability results are proved using the energy method combining with the frequency domain approach.

The paper is organized as follows. In section 2, we prove the well-posedness of (1.1) - (1.3). In sections 3 and 4, we show, respectively, our non exponential and exponential stability results for (1.1) - (1.3). The proof of our polynomial decay for (1.1) - (1.3) is proved in section 5.

### 2. Well-posedness of (1.1) - (1.3)

In this section, we prove the existence, uniqueness and smoothness of solutions for (1.1) - (1.3) using the semigroup theory. In order to transform (1.1) - (1.3) into a first order evolution system on a suitable Hilbert space, we introduce the vector functions

$$\Phi = \left(\varphi, \,\tilde{\varphi}, \,\psi, \,\tilde{\psi}, \,w, \,\tilde{w}, \,\theta, \,q\right)^T \quad \text{and} \quad \Phi_0 = \left(\varphi_0, \,\varphi_1, \,\psi_0, \,\psi_1, \,w_0, \,w_1, \,\theta_0, \,q_0\right)^T,$$

where  $\tilde{\varphi} = \varphi_t$ ,  $\tilde{\psi} = \psi_t$  and  $\tilde{w} = w_t$ . System (1.1) with initial data (1.2) can be written as

(2.1) 
$$\begin{cases} \Phi_t = \mathcal{A}\Phi & \text{ in } (0,\infty) \\ \Phi(0) = \Phi_0, \end{cases}$$

where  $\mathcal{A}$  is a linear operator defined by

$$(2.2) \qquad \mathcal{A}\Phi = \begin{pmatrix} \tilde{\varphi} \\ \frac{k}{\rho_1} (\varphi_x + \psi + l \, w)_x + \frac{lk_0}{\rho_1} (w_x - l\varphi) \\ \tilde{\psi} \\ \frac{b}{\rho_2} \psi_{xx} - \frac{k}{\rho_2} (\varphi_x + \psi + l \, w) \\ \tilde{w} \\ \frac{k_0}{\rho_1} (w_x - l\varphi)_x - \frac{lk}{\rho_1} (\varphi_x + \psi + l \, w) - \frac{\delta}{\rho_1} \theta_x \\ -\frac{1}{\rho_3} q_x - \frac{\delta}{\rho_3} \tilde{w}_x \\ -\frac{\beta}{\tau} q - \frac{1}{\tau} \theta_x \end{pmatrix}$$

Now, we introduce the following spaces:

$$\left\{ \begin{array}{l} H^1_*\left(0,1\right) = \left\{ f \in H^1\left(0,1\right) : f\left(0\right) = 0 \right\}, \\ \widetilde{H}^1_*\left(0,1\right) = \left\{ f \in H^1\left(0,1\right) : f\left(1\right) = 0 \right\}, \\ H^2_*\left(0,1\right) = H^2\left(0,1\right) \cap H^1_*\left(0,1\right), \\ \widetilde{H}^2_*\left(0,1\right) = H^2\left(0,1\right) \cap \widetilde{H}^1_*\left(0,1\right) \end{array} \right. \right.$$

and the energy space is given by

$$\mathcal{H} = H^{1}_{*}(0,1) \times L^{2}(0,1) \times \overset{\sim}{H^{1}_{*}}(0,1) \times L^{2}(0,1) \times \overset{\sim}{H^{1}_{*}}(0,1) \times \left(L^{2}(0,1)\right)^{3}$$

equipped with the inner product, for  $\Phi_j = (\varphi_j, \tilde{\varphi}_j, \psi_j, \tilde{\psi}_j, w_j, \tilde{w}_j, \theta_j, q_j)^T \in \mathcal{H}, j = 1, 2,$ 

$$\begin{split} \langle \Phi_1, \Phi_2 \rangle_{\mathcal{H}} &= k \left\langle \left( \varphi_{1x} + \psi_1 + l \, w_1 \right), \left( \varphi_{2x} + \psi_2 + l \, w_2 \right) \right\rangle_{L^2(0,1)} + b \left\langle \psi_{1x}, \psi_{2x} \right\rangle_{L^2(0,1)} \\ &+ k_0 \left\langle \left( w_{1x} - l \varphi_1 \right), \left( w_{2x} - l \varphi_2 \right) \right\rangle_{L^2(0,1)} + \rho_1 \left\langle \tilde{\varphi}_1, \tilde{\varphi}_2 \right\rangle_{L^2(0,1)} \end{split}$$

 $+\rho_1 \left\|\tilde{\varphi}\right\|_{L^2(0,1)}^2 + \rho_2 \left\|\tilde{\psi}\right\|_{L^2(0,1)}^2 + \rho_1 \left\|\tilde{w}\right\|_{L^2(0,1)}^2 + \rho_3 \left\|\theta\right\|_{L^2(0,1)}^2 + \tau \left\|q\right\|_{L^2(0,1)}^2.$ The domain of the operator  $\mathcal{A}$  will be

$$D(\mathcal{A}) = \left\{ \Phi \in \mathcal{H} \mid \mathcal{A}\Phi \in \mathcal{H}, \, \varphi_x\left(1\right) = \psi_x\left(0\right) = w_x\left(0\right) = 0 \right\}.$$

Based on the definition of  $\mathcal{A}$  and  $\mathcal{H}$ , one can see that

$$D(\mathcal{A}) = \left\{ \begin{array}{c} \Phi \in \mathcal{H} \mid \varphi \in H_*^2(0,1) \, ; \, \psi, \, w \in \overset{\sim}{H_*^2}(0,1) \, ; \, \tilde{\varphi}, \, \theta \in H_*^1(0,1) \, ; \\ \tilde{\psi}, \, \tilde{w}, \, q \in \overset{\sim}{H_*^1}(0,1) \, ; \, \varphi_x(1) = \psi_x(0) = w_x(0) = 0 \end{array} \right\}.$$

Since the homogeneous Dirichlet-Neumann boundary conditions in (1.3) are included in the definition of  $H^1_*(0,1)$ ,  $H^1_*(0,1)$  and  $D(\mathcal{A})$ , it follows that, if  $\Phi \in D(\mathcal{A})$  and satisfies (2.1), then (1.1) – (1.3) holds.

It is clear from the homogeneous Dirichlet boundary conditions in  $H^1_*(0,1)$  and  $\overset{\sim}{H^1_*}(0,1)$  that, if  $(\varphi,\psi,w) \in H^1_*(0,1) \times \overset{\sim}{H^1_*}(0,1) \times \overset{\sim}{H^1_*}(0,1)$  satisfying

$$k \left\| \left(\varphi_x + \psi + l \, w\right) \right\|_{L^2(0,1)}^2 + b \left\| \psi_x \right\|_{L^2(0,1)}^2 + k_0 \left\| \left(w_x - l\varphi\right) \right\|_{L^2(0,1)}^2 = 0,$$

then

$$\psi = 0$$
,  $\varphi = -c\sin(lx)$  and  $w = c\cos(lx)$ ,

where c is a constant such that c = 0 or  $l = \frac{\pi}{2} + m\pi$ , for some  $m \in \mathbb{N}$ . Furthermore, we get  $\varphi = \psi = w = 0$  if

(2.3) 
$$l \neq \frac{\pi}{2} + m\pi, \quad \forall m \in \mathbb{N}.$$

Here and after we assume that (2.3) is satisfied. Thus,  $\mathcal{H}$  is a Hilbert space and  $D(\mathcal{A})$  is dense in  $\mathcal{H}$ . If the domain (0,1) is replaced by (0,L), then (2.3) becomes

$$L \neq \frac{\pi}{2} + m\pi, \quad \forall m \in \mathbb{N}.$$

Now, we prove that the operator  $\mathcal{A}$  generates a  $C_0$  semigroup of contractions on  $\mathcal{H}$ . For this purpose, it is sufficient to prove that  $\mathcal{A}$  is maximal monotone. A direct calculation gives

(2.4) 
$$\langle \mathcal{A}\Phi, \Phi \rangle_{\mathcal{H}} = -\beta \left\| q \right\|_{L^2(0,1)}^2 \le 0.$$

l

Hence,  $\mathcal{A}$  is dissipative in  $\mathcal{H}$ . On the other hand, it is easy to show that  $0 \in \rho(\mathcal{A})$ ; that is, for any  $F = (f_1, \dots, f_8)^T \in \mathcal{H}$ , there exists  $Z = (z_1, \dots, z_8)^T \in D(\mathcal{A})$  satisfying

$$(2.5) \qquad \qquad \mathcal{A}Z = F.$$

Indeed, from the first, third and fifth equations in (2.5), we get

(2.6) 
$$z_2 = f_1, \quad z_4 = f_3 \quad \text{and} \quad z_6 = f_5,$$

and then

(2.7) 
$$z_2 \in H^1_*(0,1) \text{ and } z_4, z_6 \in H^1_*(0,1).$$

Substituting  $z_2$  into the seventh equation in (2.5), we conclude from the last two equations in (2.5) that

(2.8) 
$$z_{7x} = -\beta z_8 - \tau f_8$$
 and  $z_{8x} = -\delta f_{5x} - \rho_3 f_7$ .

By a direct integration, we see that (2.8) has a unique solution satisfying

(2.9) 
$$z_7 \in H^1_*(0,1)$$
 and  $z_8 \in H^1_*(0,1)$ .

Finally, the second, fourth and sixth equations in (2.5) become

(2.10) 
$$\begin{cases} k (z_{1x} + z_3 + l z_5)_x + lk_0 (z_{5x} - lz_1) = \rho_1 f_2, \\ b z_{3xx} - k (z_{1x} + z_3 + l z_5) = \rho_2 f_4, \\ k_0 (z_{5x} - lz_1)_x - lk (z_{1x} + z_3 + l z_5) = \delta z_{7x} + \rho_1 f_6 \end{cases}$$

To prove that (2.10) admits a solution satisfying

(2.11)  $z_1 \in H^2_*(0,1)$ ,  $z_3, z_5 \in H^2_*(0,1)$  and  $z_{1x}(1) = z_{3x}(0) = z_{5x}(0) = 0$ , we define the following bilinear form:

$$G_{1}((v_{1}, v_{2}, v_{3}), (w_{1}, w_{2}, w_{3})) = k \langle v_{1x} + v_{2} + lv_{3}, w_{1x} + w_{2} + lw_{3} \rangle_{L^{2}(0,1)} + b \langle v_{2x}, w_{2x} \rangle_{L^{2}(0,1)} + k_{0} \langle v_{3x} - lv_{1}, w_{3x} - lw_{1} \rangle_{L^{2}(0,1)} , \forall (v_{1}, v_{2}, v_{3})^{T}, (w_{1}, w_{2}, w_{3})^{T} \in \mathcal{H}_{0} \times \mathcal{H}_{0},$$

and the following linear form:

$$G_{2}(v_{1}, v_{2}, v_{3}) = \langle v_{1}, \rho_{1}f_{2} \rangle_{L^{2}(0,1)} + \langle v_{2}, \rho_{2}f_{4} \rangle_{L^{2}(0,1)} + \langle v_{3}, \delta z_{7x} + \rho_{1}f_{6} \rangle_{L^{2}(0,1)}, \quad \forall (v_{1}, v_{2}, v_{3})^{T} \in \mathcal{H}_{0},$$

where

$$\mathcal{H}_{0} = H^{1}_{*}(0,1) \times H^{1}_{*}(0,1) \times H^{1}_{*}(0,1)$$

Thus, the variational formulation of (2.10) is given by

(2.12)  $G_1((z_1, z_3, z_5), (w_1, w_2, w_3)) = G_2(w_1, w_2, w_3), \forall (w_1, w_2, w_3)^T \in \mathcal{H}_0.$ From Lax-Milgram theorem, it follows that (2.12) has a unique solution

$$(z_1, z_3, z_5) \in \mathcal{H}_0$$

Therefore, using classical elliptic regularity arguments, we conclude that  $(z_1, z_3, z_5)$  solves (2.10) and satisfies the regularity and boundary conditions (2.11). This proves that (2.5) has a unique solution  $Z \in D(\mathcal{A})$ . By the resolvent identity, we have  $\lambda I - \mathcal{A}$  is surjective, for any  $\lambda > 0$  (see [18]), where I denotes the identity operator. Consequently, the Lumer-Phillips theorem implies that  $\mathcal{A}$  is the infinitesimal

generator of a linear  $C_0$  semigroup of contractions on  $\mathcal{H}$ . Thus, the well-posedness result for (2.1) is stated in the following (see [21]):

**Theorem 2.1.** Assume that (2.3) holds. For any  $p \in \mathbb{N}$  and  $\Phi_0 \in D(\mathcal{A}^p)$ , system (2.1) admits a unique solution

(2.13) 
$$\Phi \in \bigcap_{j=0}^{p} C^{p-j}\left(\mathbb{R}_{+}; D\left(\mathcal{A}^{j}\right)\right),$$

where  $D(\mathcal{A}^{j})$  is endowed by the graph norm  $\|\cdot\|_{D(\mathcal{A}^{j})} = \sum_{r=0}^{j} \|\mathcal{A}^{r}\cdot\|_{\mathcal{H}}$ .

In the next three sections, we will show some exponential, non exponential and polynomial stability results for (2.1). The proof of these results is based on the following frequency domain theorems:

**Theorem 2.2.** ([12] and [22]) A  $C_0$  semigroup of contractions on a Hilbert space  $\mathcal{H}$  generated by an operator  $\mathcal{A}$  is exponentially stable if and only if

(2.14) 
$$i\mathbb{R} \subset \rho(\mathcal{A}) \quad and \quad \sup_{\lambda \in \mathbb{R}} \left\| (i\lambda I - \mathcal{A})^{-1} \right\|_{\mathcal{L}(\mathcal{H})} < \infty.$$

**Theorem 2.3.** ([16]) If a bounded  $C_0$  semigroup  $e^{t\mathcal{A}}$  on a Hilbert space  $\mathcal{H}$  generated by an operator  $\mathcal{A}$  satisfies, for some  $j \in \mathbb{N}^*$ ,

(2.15) 
$$i\mathbb{R} \subset \rho(\mathcal{A}) \quad and \quad \sup_{|\lambda| \ge 1} \frac{1}{\lambda^{j}} \left\| (i\lambda I - \mathcal{A})^{-1} \right\|_{\mathcal{L}(\mathcal{H})} < \infty.$$

Then, for any  $p \in \mathbb{N}^*$ , there exists a positive constant  $c_p$  such that

(2.16) 
$$\left\|e^{t\mathcal{A}}z_0\right\|_{\mathcal{H}} \le c_p \left\|z_0\right\|_{D(\mathcal{A}^p)} \left(\frac{\ln t}{t}\right)^{\frac{p}{j}} \ln t, \quad \forall z_0 \in D\left(\mathcal{A}^p\right), \ \forall t > 0.$$

3. Lack of exponential stability of (1.1) - (1.3)

 $\boldsymbol{n}$ 

Our objective here is to show that the semigroup associated with our Bresse system with second sound (2.1) is not exponentially stable depending on the following relations:

(3.1) 
$$(k - k_0) \left(\rho_3 - \frac{\rho_1}{\tau k}\right) - \delta^2 = b\rho_1 - k\rho_2 = 0$$

and

(3.2) 
$$l^{2} \neq \frac{\rho_{2}k_{0} + \rho_{1}b}{\rho_{2}k_{0}} \left(\frac{\pi}{2} + m\pi\right)^{2} + \frac{\rho_{1}k}{\rho_{2}\left(k + k_{0}\right)}, \quad \forall m \in \mathbb{Z}.$$

**Theorem 3.1.** We assume that (2.3) holds, and (3.1) or (3.2) does not hold. Then the semigroup associated with (2.1) is not exponentially stable.

*Proof.* We use Theorem 2.2 by proving that the first or second condition in (2.14) is not satisfied. First, we prove that the first condition in (2.14) is equivalent to (3.2). Note that, according to the fact that  $0 \in \rho(\mathcal{A})$  (see section 2),  $\mathcal{A}^{-1}$  is bounded and it is a bijection between  $\mathcal{H}$  and  $D(\mathcal{A})$ . Since  $D(\mathcal{A})$  has a compact embedding into  $\mathcal{H}$ , so it follows that  $\mathcal{A}^{-1}$  is a compact operator, which implies that the spectrum of  $\mathcal{A}$  is discrete. Let  $\lambda \in \mathbb{R}^*$ . We will prove that the unique

$$\Phi = \left(\varphi, \tilde{\varphi}, \psi, \tilde{\psi}, w, \tilde{w}, \theta, q\right)^T \in D(\mathcal{A})$$

satisfying

$$(3.3) \qquad \qquad \mathcal{A}\,\Phi = i\,\lambda\,\Phi$$

is  $\Phi = 0$  if and only if (3.2) holds; that is the fact that  $i\lambda$  is not an eigenvalue of  $\mathcal{A}$ is equivalent to (3.2). But equation (3.3) is equivalent to

$$(3.4) \begin{cases} \tilde{\varphi} = i\lambda\varphi, \quad \tilde{\psi} = i\lambda\psi, \quad \tilde{w} = i\lambda w, \\ \frac{k}{\rho_1} \left(\varphi_x + \psi + l\,w\right)_x + \frac{lk_0}{\rho_1} \left(w_x - l\varphi\right) = i\lambda\tilde{\varphi}, \\ \frac{b}{\rho_2}\psi_{xx} - \frac{k}{\rho_2} \left(\varphi_x + \psi + l\,w\right) = i\lambda\tilde{\psi}, \\ \frac{k_0}{\rho_1} \left(w_x - l\varphi\right)_x - \frac{lk}{\rho_1} \left(\varphi_x + \psi + l\,w\right) - \frac{\delta}{\rho_1}\theta_x = i\lambda\tilde{w}, \\ -\frac{1}{\rho_3}q_x - \frac{\delta}{\rho_3}\tilde{w}_x = i\lambda\theta, \quad -\frac{\beta}{\tau}q - \frac{1}{\tau}\theta_x = i\lambda q. \end{cases}$$

~

Using (2.4), we find

$$-\beta \left\|q\right\|_{L^{2}(0,1)}^{2} = Re \left\langle \mathcal{A}\Phi, \Phi \right\rangle_{\mathcal{H}} = Re \left\langle i\lambda \Phi, \Phi \right\rangle_{\mathcal{H}} = Re i\lambda \left\|\Phi\right\|_{\mathcal{H}}^{2} = 0.$$

Then

(3.5)q = 0.

Taking into account that  $\theta \in H^1_*(0,1)$ , using (3.5) and the eight equation in (3.4), we deduce that

$$(3.6) \qquad \qquad \theta = 0.$$

Inserting (3.5) and (3.6) into the seventh equation in (3.4), we find

(3.7) 
$$\tilde{w}_x = 0.$$

Then, the third equation in (3.4), implies that

As  $w \in \overset{\sim}{H^1_*}(0,1)$ , we have

$$(3.9) w = \tilde{w} = 0.$$

Using (3.5), (3.6) and (3.9), then the system (3.4) is reduced into:

(3.10) 
$$\begin{cases} \tilde{\varphi} = i\lambda\varphi, \quad \tilde{\psi} = i\lambda\psi, \\ k\left(\varphi_x + \psi\right)_x - l^2k_0\varphi = -\rho_1\lambda^2\varphi, \\ b\psi_{xx} - k\left(\varphi_x + \psi\right) = -\rho_2\lambda^2\psi, \\ -k_0\varphi_x - k\left(\varphi_x + \psi\right) = 0, \end{cases}$$

which is equivalent to  $\tilde{\varphi} = i\lambda\varphi$ ,  $\tilde{\psi} = i\lambda\psi$  and

(3.11) 
$$\begin{cases} \left(l^2 k_0 - \rho_1 \lambda^2\right) \varphi - k \left(\varphi_x + \psi\right)_x = 0, \\ -\rho_2 \lambda^2 \psi - b \psi_{xx} + k \left(\varphi_x + \psi\right) = 0, \\ \varphi_x + \psi = -\frac{k_0}{k} \varphi_x. \end{cases}$$

By deriving  $(3.11)_3$  and combining with  $(3.11)_1$ , we see that  $\varphi$  satisfy the following equation:

(3.12) 
$$\varphi_{xx} + \alpha \varphi = 0,$$

where  $\alpha = \frac{l^2 k_0 - \rho_1 \lambda^2}{k_0}$ . At this stage, we distinguish three cases.

Case 1:  $\lambda^2 = \frac{l^2 k_0}{\rho_1}$ . Then

$$p(x) = c_1 x + c_2,$$

for  $c_1, c_2 \in \mathbb{C}$ . Using the boundary conditions

(3.13) 
$$\varphi(0) = \varphi_x(1) = 0$$

we find

 $(3.14) \qquad \qquad \varphi = 0,$ 

which implies that, using the first two equations in (3.10) and the last one in (3.11),

$$(3.15) \qquad \qquad \widetilde{\varphi} = 0$$

and

$$\psi = \psi = 0$$

Consequently, we get

(3.17)

Case 2:  $\lambda^2 > \frac{l^2 k_0}{\rho_1}$ . Then

$$\varphi(x) = c_1 e^{\sqrt{-\alpha}x} + c_2 e^{-\sqrt{-\alpha}x}$$

 $\Phi = 0.$ 

Using again the boundary conditions (3.13), we find (3.14), and similarly as before, we arrive at (3.17).

Case 3:  $\lambda^2 < \frac{l^2 k_0}{\rho_1}$ . Then

$$\varphi(x) = c_1 \cos\left(\sqrt{\alpha}x\right) + c_2 \sin\left(\sqrt{\alpha}x\right)$$

Using the boundary conditions (3.13), we deduce that  $c_1 = 0$ , and

(3.18) 
$$c_2 = 0 \quad \text{or} \quad \exists m \in \mathbb{Z} : \ \alpha = \left(\frac{\pi}{2} + m\pi\right)^2.$$

If  $c_2 = 0$ , then (3.14) holds, and as before, we find (3.17). If  $c_2 \neq 0$ , then, by (3.18),

(3.19) 
$$\exists m \in \mathbb{Z} : \frac{l^2 k_0 - \rho_1 \lambda^2}{k_0} = \left(\frac{\pi}{2} + m\pi\right)^2.$$

Therefore,  $(3.11)_3$  is equivalent to

(3.20) 
$$\psi(x) = -c_2 \left(1 + \frac{k_0}{k}\right) \sqrt{\alpha} \cos\left(\sqrt{\alpha}x\right),$$

and then the first two equations in (3.11) are reduced to

(3.21) 
$$\lambda^{2} = \frac{k_{0} \left[ kk_{0} + bl^{2} \left( k + k_{0} \right) \right]}{\left( k + k_{0} \right) \left( k_{0}\rho_{2} + b\rho_{1} \right)}$$

We see that (3.19) and (3.21) lead to

$$\exists m \in \mathbb{Z} : \ l^2 = \frac{\rho_2 k_0 + \rho_1 b}{\rho_2 k_0} \left(\frac{\pi}{2} + m\pi\right)^2 + \frac{\rho_1 k}{\rho_2 \left(k + k_0\right)};$$

that is (3.2) does not hold. So, if (3.2) holds, we get a contradiction, and hence,  $c_2 = 0$  and, as before, we find (3.17).

If (3.2) does not hold, then, for  $\lambda \in \mathbb{R}$  satisfying (3.21), the function

$$\Phi(x) = c_2 \left( \sin\left(\sqrt{\alpha}x\right), i\lambda \sin\left(\sqrt{\alpha}x\right), -\left(1 + \frac{k_0}{k}\right)\sqrt{\alpha}\cos\left(\sqrt{\alpha}x\right), -i\lambda \left(1 + \frac{k_0}{k}\right)\sqrt{\alpha}\cos\left(\sqrt{\alpha}x\right), 0, 0, 0, 0 \right)^T$$

is a solution of (3.3), for any  $c_2 \in \mathbb{C}$ , and then  $i\lambda \notin \rho(\mathcal{A})$ . Thus, we proved that  $i \mathbb{R} \subset \rho(\mathcal{A})$  is equivalent to (3.2).

Now, we show that the second condition in (2.14) does not hold if (3.1) is not satisfied, i.e. we assume that (3.1) is not satisfied and we will prove that there exists a sequence  $(\lambda_n)_n \subset \mathbb{R}$  such that

$$\left\| (\lambda_n I - \mathcal{A})^{-1} \right\|_{\mathcal{L}(\mathcal{H})} \longrightarrow \infty,$$

which is equivalent to prove that there exists  $(F_n)_n \subset \mathcal{H}$  with  $||F_n||_{\mathcal{H}} \leq 1$ , for which we have

(3.22) 
$$||\underbrace{(\lambda_n I - \mathcal{A})^{-1} F_n}_{\Phi_n}||_{\mathcal{H}} \longrightarrow \infty,$$

therefore, we have

.

(3.23) 
$$\lambda_n \Phi_n - \mathcal{A} \Phi_n = F_n$$

Our objective is to show that the solution  $\Phi_n$  is not bounded when  $F_n$  is bounded in  $\mathcal{H}$ . The equation (3.23) implies that

$$(3.24) \begin{cases} i\lambda_{n}\varphi_{n}-\widetilde{\varphi}_{n}=f_{1n},\\ i\lambda_{n}\rho_{1}\widetilde{\varphi}_{n}-k\left(\varphi_{nx}+\psi_{n}+l\,w_{n}\right)_{x}-lk_{0}\left(w_{nx}-l\varphi_{n}\right)+\delta\theta_{nx}=\rho_{1}f_{2n}\\ i\lambda_{n}\psi_{n}-\widetilde{\psi}_{n}=f_{3n},\\ i\lambda_{n}\rho_{2}\widetilde{\psi}_{n}-b\psi_{nxx}+k\left(\varphi_{nx}+\psi_{n}+l\,w_{n}\right)=\rho_{2}f_{4n},\\ i\lambda_{n}w_{n}-\widetilde{w}_{n}=f_{5n},\\ i\lambda_{n}\rho_{1}\widetilde{w}_{n}-k_{0}\left(w_{nx}-l\varphi_{n}\right)_{x}+lk\left(\varphi_{nx}+\psi_{n}+l\,w_{n}\right)=\rho_{1}f_{6n},\\ i\lambda_{n}\tau q_{n}+\beta q_{n}+\theta_{nx}=\tau f_{7n},\\ i\lambda_{n}\rho_{3}\theta_{n}+q_{nx}+\delta\widetilde{w}_{nx}=\rho_{3}f_{8n}. \end{cases}$$

We will show that, for all  $n \in \mathbb{N}$ , given  $c_4 \in \mathbb{C}^*$  and

$$F_n(x) = (0, 0, 0, c_4 \cos(Nx), 0, 0, 0, 0)^T,$$

where  $N = \frac{(2n+1)\pi}{2}$ , there exists  $\lambda_n \in \mathbb{R}$  and  $\Phi_n = (i\lambda_n - \mathcal{A})^{-1}F_n \in D(\mathcal{A})$  such that

$$\lim_{\lambda_n \to \infty} \|\Phi_n\|_{\mathcal{H}} = \infty.$$

The system (3.24) will be written as

$$(3.25) \qquad \begin{cases} i\lambda_n\varphi_n - \widetilde{\varphi}_n = 0, \ i\lambda_n\psi_n - \widetilde{\psi}_n = 0, \ i\lambda_nw_n - \widetilde{w}_n = 0, \\ -\lambda_n^2\rho_1\varphi_n - k\left(\varphi_{nx} + \psi_n + l\,w_n\right)_x - lk_0\left(w_{nx} - l\varphi_n\right) = 0, \\ -\lambda_n^2\rho_2\psi_n - b\psi_{nxx} + k\left(\varphi_{nx} + \psi_n + l\,w_n\right) = \rho_2c_4\cos\left(Nx\right), \\ -\lambda_n^2\rho_1w_n - k_0\left(w_{nx} - l\varphi_n\right)_x + lk\left(\varphi_{nx} + \psi_n + l\,w_n\right) + \delta\theta_{nx} = 0, \\ i\lambda_n\rho_3\theta_n + q_{nx} + \delta\widetilde{w}_{nx} = 0, \\ i\lambda_n\tau q_n + \beta q_n + \theta_{nx} = 0. \end{cases}$$

Because of the boundary conditions, one can take the following solution:

where the constants  $\alpha_1, \alpha_2, \alpha_3, \alpha_4$  and  $\alpha_5$  are the solution of the following system: (3.27)

#### 4. EXPONENTIAL STABILITY OF (1.1) - (1.3)

In this section, we use again Theorem 2.2 to prove that the semigroup associated with (2.1) is exponentially stable provided that (2.3), (3.1) and (3.2) hold.

**Theorem 4.1.** We assume that (2.3), (3.1) and (3.2) hold. Then the semigroup associated with (2.1) is exponentially stable.

*Proof.* In section 3, we have proved that the first condition in (2.14) is equivalent to (3.2). Now, by contradiction, we will prove the second condition in (2.14). So, we assume that the second condition in (2.14) is false, then there exist sequences  $(\Phi_n)_n \subset \mathcal{D}(\mathcal{A})$  and  $(\lambda_n)_n \subset \mathbb{R}$  satisfying

$$\tau \left\langle \left( i\lambda_{n}\rho_{3}\theta_{n} + q_{nx} + \delta\widetilde{w}_{nx} \right), \left( i\lambda_{n}\varphi_{n} - \widetilde{\varphi_{n}} \right) \right\rangle_{L^{2}(0,1)} + \tau \left\langle \left( i\lambda_{n}\rho_{3}\theta_{n} + q_{nx} + \delta\widetilde{w}_{nx} \right), \widetilde{\varphi_{n}} \right\rangle_{L^{2}(0,1)} \right. \\ \left. -\lambda_{n}\tau \left\langle i\rho_{3}\theta_{n}, \left( i\lambda_{n}\varphi_{n} - \widetilde{\varphi_{n}} \right) \right\rangle_{L^{2}(0,1)} - \lambda_{n}\tau \left\langle i\rho_{3}\theta_{n}, \widetilde{\varphi_{n}} \right\rangle_{L^{2}(0,1)} \right. \\ \left. +\tau\delta \left\langle \widetilde{w}_{n}, \left( i\lambda_{n}\varphi_{n} - \widetilde{\varphi_{n}} \right)_{x} \right\rangle_{L^{2}(0,1)} - \tau\delta \left\langle \widetilde{w}_{nx}, \widetilde{\varphi_{n}} \right\rangle_{L^{2}(0,1)} - \frac{\lambda_{n}\rho_{1}}{k} \left\langle \theta_{n}, i\widetilde{\varphi_{n}} \right\rangle_{L^{2}(0,1)} \longrightarrow 0, \\ \text{so, using (4.1), (4.4)_{1}, (4.4)_{7}, we get} \\ \left. \left( \tau\rho_{3} - \frac{\rho_{1}}{k} \right) \lambda_{n} \left\langle \theta_{n}, i\widetilde{\varphi_{n}} \right\rangle_{L^{2}(0,1)} - \tau\delta \left\langle \widetilde{w}_{nx}, \widetilde{\varphi_{n}} \right\rangle_{L^{2}(0,1)} \right.$$

$$-\lambda_n \tau \left\langle i\rho_3 \theta_n, \left(i\lambda_n \varphi_n - \widetilde{\varphi_n}\right) \right\rangle_{L^2(0,1)} \longrightarrow 0.$$

On the other hand, integrating by parts and using the boundary conditions, we find that

$$-\lambda_{n}\rho_{2}\left\langle\widetilde{\psi_{n}},i\varphi_{nx}\right\rangle_{L^{2}(0,1)} - \rho_{2}\left\langle\widetilde{\psi_{n}},\left(i\lambda_{n}\psi_{n}-\widetilde{\psi_{n}}\right)\right\rangle_{L^{2}(0,1)} - \rho_{2}\left\|\widetilde{\psi_{n}}\right\|_{L^{2}(0,1)}^{2}$$
$$-l\rho_{2}\left\langle\widetilde{\psi_{n}},\left(i\lambda_{n}w_{n}-\widetilde{w_{n}}\right)\right\rangle_{L^{2}(0,1)} - l\rho_{2}\left\langle\widetilde{\psi_{n}},\widetilde{w_{n}}\right\rangle_{L^{2}(0,1)}$$
$$-\frac{b}{k}\left\langle\psi_{nx},\left[i\lambda_{n}\rho_{1}\widetilde{\varphi_{n}}-k\left(\varphi_{nx}+\psi_{n}+lw_{n}\right)_{x}-lk_{0}\left(w_{nx}-l\varphi_{n}\right)\right]\right\rangle_{L^{2}(0,1)}$$
$$+\frac{b}{k}\left\langle\psi_{nx},i\lambda_{n}\rho_{1}\widetilde{\varphi_{n}}\right\rangle_{L^{2}(0,1)} - \frac{lk_{0}b}{k}\left\langle\psi_{nx},\left(w_{nx}-l\varphi_{n}\right)\right\rangle_{L^{2}(0,1)} + k\left\|\varphi_{nx}+\psi_{n}+lw_{n}\right\|_{L^{2}(0,1)}^{2} \longrightarrow 0,$$
using (4.1), (4.4)<sub>2</sub>, (4.4)<sub>3</sub>, (4.4)<sub>5</sub>, (4.8), (4.11), (4.14) and (4.24), we get

Now, we use that

and by integrating by parts and using the boundary conditions, we have

### 5. Polynomial stability of (1.1) - (1.3)

In this section, we prove the polynomial decay of the solutions of (2.1) using Theorem 2.3. Our main result is stated as follow:

**Theorem 5.1.** We assume that (2.3) and (3.2) hold. Then, for each  $p \in \mathbb{N}^*$ , there exists a constant  $c_p > 0$  such that

(5.1) 
$$\forall \Phi_0 \in D\left(\mathcal{A}^p\right), \forall t > 0, \left\| e^{t\mathcal{A}} \Phi_0 \right\|_{\mathcal{H}} \le c_p \left\| \Phi_0 \right\|_{D\left(\mathcal{A}^p\right)} \left( \frac{\ln t}{t} \right)^{\frac{p}{8}} \ln t.$$

*Proof.* In section 3, we have proved that the first condition in (2.15) is satisfied if (3.2) holds. Now, we need to show that

$$\sup_{|\lambda| \ge 1} \frac{1}{\lambda^8} \left\| (i\lambda I - \mathcal{A})^{-1} \right\|_{\mathcal{H}} < \infty.$$

We establish (5.2) by contradiction. So, if (5.2) is false, then there exist sequences  $(\Phi_n)_n \subset \mathcal{D}(\mathcal{A})$  and  $(\lambda_n)_n \subset \mathbb{R}$  satisfying

which implies that (5.6)

$$\begin{split} \lambda_{n}^{8} \left( i\lambda_{n}\varphi_{n} - \widetilde{\varphi}_{n} \right) &\to 0 \text{ in } H_{*}^{1} \left( 0, 1 \right), \\ \lambda_{n}^{8} \left[ i\lambda_{n}\rho_{1}\widetilde{\varphi}_{n} - k \left( \varphi_{nx} + \psi_{n} + lw_{n} \right)_{x} - lk_{0} \left( w_{nx} - l\varphi_{n} \right) \right] &\to 0 \text{ in } L^{2} \left( 0, 1 \right), \\ \lambda_{n}^{8} \left( i\lambda_{n}\psi_{n} - \widetilde{\psi}_{n} \right) &\to 0 \text{ in } \widetilde{H}_{*}^{1} \left( 0, 1 \right), \\ \lambda_{n}^{8} \left[ i\lambda_{n}\rho_{2}\widetilde{\psi}_{n} - b\psi_{nxx} + k \left( \varphi_{nx} + \psi_{n} + lw_{n} \right) \right] &\to 0 \text{ in } L^{2} \left( 0, 1 \right), \\ \lambda_{n}^{8} \left( i\lambda_{n}w_{n} - \widetilde{w}_{n} \right) &\to 0 \text{ in } \widetilde{H}_{*}^{1} \left( 0, 1 \right), \\ \lambda_{n}^{8} \left[ i\lambda_{n}\rho_{1}\widetilde{w}_{n} - k_{0} \left( w_{nx} - l\varphi_{n} \right)_{x} + lk \left( \varphi_{nx} + \psi_{n} + lw_{n} \right) + \delta\theta_{nx} \right] &\to 0 \text{ in } L^{2} \left( 0, 1 \right), \\ \lambda_{n}^{8} \left( i\lambda_{n}\rho_{3}\theta_{n} + q_{nx} + \delta\widetilde{w}_{nx} \right) &\to 0 \text{ in } L^{2} \left( 0, 1 \right), \\ \lambda_{n}^{8} \left( i\lambda_{n}\tau q_{n} + \beta q_{n} + \theta_{nx} \right) \to 0 \text{ in } L^{2} \left( 0, 1 \right). \end{split}$$

Our goal is to derive  $\|\Phi_n\|_{\mathcal{H}} \to 0$  as a contradiction with (5.3). This will be established through several steps.

**Step 1.** Taking the inner product of  $\lambda_n^8 (i \lambda_n I - A) \Phi_n$  with  $\Phi_n$  in  $\mathcal{H}$ , we get (as for (4.5))

$$Re\left(\left\langle\lambda_n^8\left(i\,\lambda_n\,I\,-\,\mathcal{A}\right)\,\,\Phi_n,\Phi_n\right\rangle_{L^2(0,1)}\right)=\beta\left\|\lambda_n^4q_n\right\|_{L^2(0,1)}^2,$$

Step 2. Applying triangle inequality, we obtain

 $\|\lambda_n^3 \theta_{nx}\|_{L^2(0,1)} \le \|\lambda_n^3 (i\lambda_n \tau q_n + \beta q_n + \theta_{nx})\|_{L^2(0,1)} + \|i\lambda_n^4 \tau q_n + \beta\lambda_n^3 q_n\|_{L^2(0,1)},$ then, using (5.4), (5.6)<sub>8</sub> and (5.7), we have

**Step 3.** Using (5.3), (5.4),  $(5.6)_1$ ,  $(5.6)_3$  and  $(5.6)_5$ , we obtain

Step 4. By triangle inequality, we have

$$\begin{split} \left\|\frac{w_{nxx}}{\lambda_n}\right\| &\leq \left\|\frac{1}{k_0\lambda_n} \left[i\lambda_n\rho_1\widetilde{w}_n - k_0\left(w_{nx} - l\varphi_n\right)_x + lk\left(\varphi_{nx} + \psi_n + lw_n\right) + \delta\theta_{nx}\right]\right\|_{L^2(0,1)} \\ &+ \frac{1}{k_0} \left\|i\rho_1\widetilde{w}_n + lk_0\frac{\varphi_{nx}}{\lambda_n} + \frac{lk}{\lambda_n}\left(\varphi_{nx} + \psi_n + lw_n\right) + \frac{\delta}{\lambda_n}\theta_{nx}\right\|_{L^2(0,1)}, \end{split}$$

 then, by using (5.2), (5.4), (5.6), (5.6), (5.7), (5.8), (5.10), and (5.11), we find

then, by using (5.3), (5.4), (5.6)<sub>5</sub>, (5.6)<sub>7</sub>, (5.7), (5.8), (5.10) and (5.11), we find (5.12)  $\lambda_n^2 w_{nx} \to 0$  in  $L^2(0,1)$ .

As  $w_n$  in  $\overset{\sim}{H^1_*}(0,1)$ , we deduce from (5.12) that (5.13)  $\lambda_n^2 w_n \to 0$  in  $L^2(0,1)$ , and using (5.4) and  $(5.6)_5$ , we see that

**Step 5.** Taking the inner product of  $(5.6)_7$  with  $\frac{iw_{nx}}{\lambda_n^4}$  in  $L^2(0,1)$ , integrating by parts and using the boundary conditions, we get

Using (5.3), (5.4),  $(5.6)_5$ , (5.7), (5.8), (5.13) and (5.16), we obtain

and from  $(5.6)_5$ , we get

$$\left\|\frac{\varphi_{nxx}}{\lambda_n}\right\|_{L^2(0,1)} \leq \frac{1}{k} \left\|\frac{1}{\lambda_n} \left[i\lambda_n\rho_1\widetilde{\varphi}_n - k\left(\varphi_{nx} + \psi_n + lw_n\right)_x - lk_0\left(w_{nx} - l\varphi_n\right)\right]\right\|_{L^2(0,1)} + \frac{1}{k} \left\|i\rho_1\widetilde{\varphi}_n - \frac{k}{\lambda_n}\left(\psi_{nx} + lw_{nx}\right) - \frac{lk_0}{\lambda_n}\left(w_{nx} - l\varphi_n\right)\right\|_{L^2(0,1)},$$

and using (5.3), (5.4) and  $(5.6)_2$ , we deduce that

(5.19) 
$$\left(\frac{\varphi_{nxx}}{\lambda_n}\right)_n$$
 is uniformly bounded in  $L^2(0,1)$ .

Taking the inner product of  $(5.6)_6$  with  $\frac{\varphi_{nx}}{\lambda_n^8}$  in  $L^2(0,1)$ , integrating by parts and using the boundary conditions, we obtain

$$\rho_{1}\left\langle i\lambda_{n}\widetilde{w}_{n},\varphi_{nx}\right\rangle_{L^{2}(0,1)}+k_{0}\left\langle \lambda_{n}w_{nx},\frac{\varphi_{nxx}}{\lambda_{n}}\right\rangle_{L^{2}(0,1)}+l\left(k+k_{0}\right)\left\|\varphi_{nx}\right\|_{L^{2}(0,1)}^{2}$$
$$+lk\left\langle \left(\psi_{n}+lw_{n}\right),\varphi_{nx}\right\rangle_{L^{2}(0,1)}+\delta\left\langle\theta_{nx},\varphi_{nx}\right\rangle_{L^{2}(0,1)}\longrightarrow0,$$

then, from (5.3), (5.4), (5.8), (5.10), (5.12), (5.15) and (5.19), we have (5.20)  $\varphi_{nx} \longrightarrow 0 \text{ in } L^2(0,1).$ 

**Step 7.** Taking the inner product of  $(5.6)_6$  with  $\frac{\varphi_{nx}}{\lambda_n^7}$  in  $L^2(0,1)$ , integrating by parts and using the boundary conditions, we get

$$-\rho_{1}\left\langle \widetilde{w}_{n},\lambda_{n}\left(i\lambda_{n}\varphi_{nx}-\widetilde{\varphi_{nx}}\right)\right\rangle_{L^{2}(0,1)}+\rho_{1}\left\langle \lambda_{n}\widetilde{w}_{nx},\widetilde{\varphi_{n}}\right\rangle_{L^{2}(0,1)}\\+k_{0}\left\langle \lambda_{n}^{2}w_{nx},\frac{\varphi_{nxx}}{\lambda_{n}}\right\rangle_{L^{2}(0,1)}+l\left(k+k_{0}\right)\lambda_{n}\left\|\varphi_{nx}\right\|_{L^{2}(0,1)}^{2}$$

 $+lk \left\langle \lambda_n \left( \psi_n + lw_n \right), \varphi_{nx} \right\rangle_{L^2(0,1)} + \delta \left\langle \lambda_n \theta_{nx}, \varphi_{nx} \right\rangle_{L^2(0,1)} \longrightarrow 0,$ 

hence, using (5.3), (5.4),  $(5.6)_1$ , (5.8), (5.10), (5.12), (5.19) and (5.20), we obtain

(5.21) 
$$\lambda_n \|\varphi_{nx}\|_{L^2(0,1)}^2 \longrightarrow 0$$

Taking the inner product of  $(5.6)_2$  with  $\frac{\varphi_n}{\lambda_n^7}$  in  $L^2(0,1)$ , integrating by parts and using the boundary conditions, we get

$$-\rho_1 \lambda_n \left\langle \widetilde{\varphi}_n, \left( i \lambda_n \varphi_n - \widetilde{\varphi}_n \right) \right\rangle_{L^2(0,1)} - \rho_1 \lambda_n \left\| \widetilde{\varphi}_n \right\|_{L^2(0,1)}^2$$

 $+k\lambda_n \left\langle \left(\varphi_{nx} + \psi_n + lw_n\right), \varphi_{nx}\right\rangle_{L^2(0,1)} - lk_0\lambda_n \left\langle \left(w_{nx} - l\varphi_n\right), \varphi_n\right\rangle_{L^2(0,1)} \longrightarrow 0,$ which implies

$$-\rho_1 \left\langle \widetilde{\varphi}_n, \lambda_n \left( i\lambda_n \varphi_n - \widetilde{\varphi}_n \right) \right\rangle_{L^2(0,1)} - \rho_1 \lambda_n \left\| \widetilde{\varphi}_n \right\|_{L^2(0,1)}^2$$
$$+k\lambda_n \left\| \varphi_{nx} \right\|_{L^2(0,1)}^2 + k \left\langle \left( \lambda_n \psi_n + l\lambda_n w_n \right), \varphi_{nx} \right\rangle_{L^2(0,1)}$$
$$-lk_0 \left\langle \left( \lambda_n w_{nx} - l\lambda_n \varphi_n \right), \varphi_n \right\rangle_{L^2(0,1)} \longrightarrow 0,$$

so, using (5.3), (5.4),  $(5.6)_1$ , (5.10), (5.12) and (5.21), we deduce that

(5.22) 
$$\lambda_n \left\| \widetilde{\varphi}_n \right\|_{L^2(0,1)}^2 \longrightarrow 0,$$

and from  $(5.6)_1$ , we obtain that

(5.23) 
$$\lambda_n^3 \left\|\varphi_n\right\|^2 \longrightarrow 0.$$

**Step 8.** Multiplying  $(5.6)_2$  by  $\frac{1}{|\lambda_n|^{\frac{1}{2}} \lambda_n^8}$ , we get

$$i\frac{\lambda_{n}}{|\lambda_{n}|}\rho_{1}|\lambda_{n}|^{\frac{1}{2}}\widetilde{\varphi}_{n}-k\frac{\varphi_{nxx}}{|\lambda_{n}|^{\frac{1}{2}}}-k\frac{\psi_{nx}}{|\lambda_{n}|^{\frac{1}{2}}}-l\left(k+k_{0}\right)\frac{w_{nx}}{|\lambda_{n}|^{\frac{1}{2}}}+l^{2}k_{0}\frac{\varphi_{n}}{|\lambda_{n}|^{\frac{1}{2}}}\longrightarrow0\text{ in }L^{2}\left(0,1\right),$$

then, using (5.3), (5.4) and (5.22), we deduce that

(5.24) 
$$\frac{\varphi_{nxx}}{|\lambda_n|^{\frac{1}{2}}} \longrightarrow 0 \text{ in } L^2(0,1)$$

On the other hand, by integrating by parts and using the boundary conditions, we see that

$$\lambda_n \langle w_{nxx}, i\lambda_n \varphi_{nx} \rangle_{L^2(0,1)} = \lambda_n^2 \langle iw_{nx}, \varphi_{nxx} \rangle_{L^2(0,1)}$$
$$= \left\langle \lambda_n \left( i\lambda_n w_{nx} - \widetilde{w}_{nx} \right), \varphi_{nxx} \right\rangle_{L^2(0,1)} + \lambda_n \left\langle \widetilde{w}_{nx}, \varphi_{nxx} \right\rangle_{L^2(0,1)}$$
$$= \left\langle \lambda_n^2 \left( i\lambda_n w_{nx} - \widetilde{w}_{nx} \right), \frac{\varphi_{nxx}}{\lambda_n} \right\rangle_{L^2(0,1)} + \left\langle \lambda_n \left| \lambda_n \right|^{\frac{1}{2}} \widetilde{w}_{nx}, \frac{\varphi_{nxx}}{\left| \lambda_n \right|^{\frac{1}{2}}} \right\rangle_{L^2(0,1)}$$

then, using (5.4),  $(5.6)_5$ , (5.18) and (5.24), we obtain

(5.25)  $\lambda_n \langle w_{nxx}, i\lambda_n \varphi_{nx} \rangle_{L^2(0,1)} \longrightarrow 0.$ 

Furthermore, integrating by parts and using the boundary conditions,

$$\lambda_n \left\langle \left(\varphi_{nx} + \psi_n + lw_n\right)_x, \widetilde{\varphi}_n \right\rangle_{L^2(0,1)} = -\lambda_n \left\langle \left(\varphi_{nx} + \psi_n + lw_n\right), \widetilde{\varphi}_{nx} \right\rangle_{L^2(0,1)} \right\rangle_{L^2(0,1)}$$

$$= -\frac{1}{lk} \left\langle \lambda_n^2 \left[ i\lambda_n \rho_1 \widetilde{w}_n - k_0 \left( w_{nx} - l\varphi_n \right)_x + lk \left( \varphi_{nx} + \psi_n + lw_n \right) + \delta\theta_{nx} \right], \frac{\widetilde{\varphi}_{nx}}{\lambda_n} \right\rangle_{L^2(0,1)} \right. \\ \left. - \frac{1}{lk} \left\langle \left( i\lambda_n \rho_1 \widetilde{w}_n + \delta\theta_{nx} \right), \lambda_n \left( i\lambda_n \varphi_{nx} - \widetilde{\varphi}_{nx} \right) \right\rangle_{L^2(0,1)} \right. \\ \left. + \frac{k_0}{lk} \left\langle \left( w_{nx} - l\varphi_n \right)_x, \lambda_n \left( i\lambda_n \varphi_{nx} - \widetilde{\varphi}_{nx} \right) \right\rangle_{L^2(0,1)} - \frac{\lambda_n^3}{lk} \left\langle i\rho_1 \widetilde{w}_{nx}, i\varphi_n \right\rangle_{L^2(0,1)} \right. \\ \left. + \frac{\delta}{lk} \left\langle \lambda_n^2 \theta_{nx}, i\varphi_{nx} \right\rangle_{L^2(0,1)} - \frac{k_0 \lambda_n}{lk} \left\langle w_{nxx}, i\lambda_n \varphi_{nx} \right\rangle_{L^2(0,1)} - \frac{k_0 \lambda_n^2}{k} i \left\| \varphi_{nx} \right\|_{L^2(0,1)}^2, \\ \text{then, using (5.6)}, (5.8), (5.15), (5.16), (5.18), (5.23) \text{ and } (5.25), \text{ we find}$$

(5.26) 
$$\lambda_n \left\langle (\varphi_{nx} + \psi_n + lw_n)_x, \widetilde{\varphi}_n \right\rangle_{L^2(0,1)} + \frac{k_0}{k} i \|\lambda_n \varphi_{nx}\|_{L^2(0,1)}^2 \longrightarrow 0.$$

Taking the inner product of  $\left(5.6\right)_2$  with  $\frac{\widetilde{\varphi}_n}{\lambda_n^7}$  in  $L^2\left(0,1\right),$  we get

$$\rho_1 i \left\| \lambda_n \widetilde{\varphi}_n \right\|_{L^2(0,1)}^2 - k \lambda_n \left\langle \left( \varphi_{nx} + \psi_n + l w_n \right)_x, \widetilde{\varphi}_n \right\rangle_{L^2(0,1)} - l k_0 \left\langle \left( \lambda_n w_{nx} - l \lambda_n \varphi_n \right), \widetilde{\varphi}_n \right\rangle_{L^2(0,1)} \longrightarrow 0,$$
 then, using (5.26), we obtain

$$\rho_1 i \left\| \lambda_n \widetilde{\varphi}_n \right\|_{L^2(0,1)}^2 + ik_0 \left\| \lambda_n \varphi_{nx} \right\|_{L^2(0,1)}^2 - lk_0 \left\langle \left( \lambda_n w_{nx} - l\lambda_n \varphi_n \right), \widetilde{\varphi}_n \right\rangle_{L^2(0,1)} \longrightarrow 0,$$
  
and from (5.3), (5.4), (5.6)<sub>1</sub>, (5.12), (5.22) and (5.23), we deduce that

(5.27) 
$$\lambda_n \widetilde{\varphi}_n \longrightarrow 0 \text{ in } L^2(0,1)$$

and

(5.28) 
$$\lambda_n \varphi_{nx} \longrightarrow 0 \text{ in } L^2(0,1).$$

**Step 9.** Multiplying  $(5.6)_4$  by  $\frac{1}{\lambda_n^9}$ , we obtain

$$i\rho_{2}\tilde{\psi}_{n} - b\frac{\psi_{nxx}}{\lambda_{n}} + \frac{k}{\lambda_{n}}\left(\varphi_{nx} + \psi_{n} + lw_{n}\right) \to 0 \text{ in } L^{2}\left(0,1\right).$$

By triangle inequality, we deduce from (5.3) and (5.4) that

(5.29) 
$$\left(\frac{\psi_{nxx}}{\lambda_n}\right)_n$$
 is uniformly bounded in  $L^2(0,1)$ .

Taking the inner product of  $(5.6)_2$  with  $\frac{\psi_{nx}}{\lambda_n^8}$  in  $L^2(0,1)$ , we get

$$\rho_1 \left\langle i\lambda_n \widetilde{\varphi}_n, \psi_{nx} \right\rangle_{L^2(0,1)} - k \left\langle \varphi_{nxx}, \psi_{nx} \right\rangle_{L^2(0,1)} - k \left\| \psi_{nx} \right\|_{L^2(0,1)}^2$$

$$-l(k+k_0)\langle w_{nx},\psi_{nx}\rangle_{L^2(0,1)}+l^2k_0\langle \varphi_n,\psi_{nx}\rangle_{L^2(0,1)}\to 0,$$

then, integrating by parts and using the boundary conditions, we obtain

$$\rho_1 \left\langle i\lambda_n \widetilde{\varphi}_n, \psi_{nx} \right\rangle_{L^2(0,1)} + k \left\langle \lambda_n \varphi_{nx}, \frac{\psi_{nxx}}{\lambda_n} \right\rangle_{L^2(0,1)} - k \left\| \psi_{nx} \right\|_{L^2(0,1)}^2$$

$$-l(k+k_0) \langle w_{nx}, \psi_{nx} \rangle_{L^2(0,1)} + l^2 k_0 \langle \varphi_n, \psi_{nx} \rangle_{L^2(0,1)} \to 0,$$

so, using (5.3), (5.4), (5.10), (5.12), (5.27), (5.28) and (5.29), we deduce that (5.30)  $\psi_{nx} \longrightarrow 0$  in  $L^2(0,1)$ . Taking the inner product of  $(5.6)_4$  with  $\frac{\psi_n}{\lambda_n^8}$  in  $L^2(0,1)$ , integrating by parts and using the boundary conditions, we get

$$-\rho_{2}\left\langle \widetilde{\psi}_{n},\left(i\lambda_{n}\psi_{n}-\widetilde{\psi}_{n}\right)\right\rangle_{L^{2}(0,1)}-\rho_{2}\left\|\widetilde{\psi}_{n}\right\|_{L^{2}(0,1)}^{2}+b\left\|\psi_{nx}\right\|_{L^{2}(0,1)}^{2}\right.\\\left.+\left\langle k\left(\varphi_{nx}+\psi_{n}+lw_{n}\right),\psi_{n}\right\rangle_{L^{2}(0,1)}\longrightarrow0,\right.$$

hence, using (5.3), (5.4),  $(5.6)_3$ , (5.10) and (5.30), we get

(5.31) 
$$\overset{\sim}{\psi}_{n} \longrightarrow 0 \text{ in } L^{2}(0,1).$$

A combination of (5.4) and all the above convergence leads to

$$\|\Phi_n\|_{\mathcal{H}} \longrightarrow 0,$$

which is a contradiction with (5.3). Consequently, the proof of our Theorem 5.1 is completed.  $\hfill \Box$
