13	ABSTRACT

15	Repeated application of organic fertilizer has unintentionally let to the introduction into
16	surface water and soils of many phytotoxic substances that compromise agricultural
17	production and threaten environmental quality. Recent studies using hydroponic systems have
18	reported that bisphenol A (BPA) affects essential mineral elements contents and root
19	absorptive function, thereby impacting nutrient content in plant. However, in soils, plants
20	develop specific traits related to nutrient acquisition strategies. In order to ensure optimized
21	supply of nutrients, understanding the response of these traits under BPA stress is thus
22	essential. Here, we therefore, investigated how leaf nutrient contents (P, Ca, K), root
23	morphology, P- mobilizing exudates and rhizospheric microbiota biomass respond to BPA

soil contamination using wheat (Triticum aestivum) as plant model. After 7 weeks, root and 24 leaf traits were not markedly affected by the exposure to BPA at low and high concentrations 25 (0.1 and 1000 mg. kg<sup>-1</sup> soil). Significant change on average root diameter and aerial biomass 26 were only observed at the highest dose. BPA contamination had no influence on nutrients 27 acquisition traits and root associated microbiota. Specific root length, carboxylates exudation 28 and P, Ca, K concentrations in leafs were similar irrespective of the treatments. In addition, 29 total microbial biomass, bacteria and fungi abundance measured by phospholipid fatty acid 30 analysis did not differ among controls and contaminated soils. In summary, this experiment 31 suggests a limited influence of BPA contaminated soils on traits involved in nutrient 32 acquisition in wheat. 33

#### 41 INTRODUCTION

42

In recent years, the cumulative use of numerous chemical substances in agriculture, industry, household and cosmetic products has led to the build-up of emerging contaminants in soils, surface water , and groundwater with unpredictable consequences for the ecosystems. In Europe, contaminants of emerging concern refer to natural or synthetic chemicals recently identified or detected with increased concentration in soils and water which are not framed by legislative regulation for environmental monitoring programs (Farré et al. 2008). Emerging
contaminants include pharmaceuticals, cosmetics, personal care products, nutrients, food
additives, pesticides and manufacturing materials for which limited knowledge is available on
their environmental fate and impacts on ecosystems (Naidu et al. 2016).

52 Bisphenol A [2,2-bis(4-hydroxyphenyl)propane ; BPA] is a typical emerging contaminant with biological activities posing irreversible adverse effects in wildlife and humans. BPA has 53 54 been extensively used since the 1940s for the formulation of plastics, thermal sensitive papers or raw materials intended to sport, electronic, automotive and medical equipment 55 (Michałowicz 2014). BPA is one of the world's highest production volume chemicals with a 56 57 worldwide consumption and production exceeding 6 million tons per year (Owczarek et al. 2018). This chemical does not belong to the class of persistent organic pollutant, possesses 58 short elimination half-lives under aerobic conditions and is easily removed 59 from the contaminated matrices (Kang et al. 2006). However, BPA is recognized as a major 60 environmental pollutant and a serious concern for ecosystems protection and human health. 61

62 BPA is widespread in oceans, rivers, sediments and soils because of it's large-scale employment, the continuous emissions with effluents and the decomposition of plastic wastes 63 (Im and Löffler 2016; Teuten et al. 2009). Occurrence of BPA residues have been evidenced 64 in soils at low concentrations and reported at highest levels up to 150 µg/kg on cultivated soils 65 (Careghini et al. 2015). In addition, agricultural soils, frequently irrigated and fertilized with 66 treated sewage water and sludge respectively, can accumulate and transfer BPA to vegetation 67 and food chains and ultimately expose vulnerable populations to this reprotoxic agent with 68 endocrine disrupting properties (Firmin et al. 2016; Mercogliano and Santonicola 2018; 69 70 Staples et al. 2010). Associations between BPA exposure and foetal development, immunity, metabolism, reproductive functions or it's relation with chronic diseases have been mostly 71

explored last decades (Bókony et al. 2018; Flint et al. 2012; Jörg et al. 2009; Shafei et al.
2018).

74 Toxic effects of BPA have been more recently observed on terrestrial plants such as broad 75 bean, carrot, wheat, lettuce, tomato, soybean and Arabidopsis Thaliana (Ferrara et al. 2006; 76 Jiao et al. 2017; Li et al. 2018; Pan et al. 2013; Sun et al. 2013). In these studies generally mainly carried out in hydroponic conditions, BPA inhibited seed germination, growth and 77 78 reproductive development by interfering with mechanisms regulating nitrogen assimilation, photosynthesis, anti-oxidative defenses or hormone secretion. In some such experiment, plant 79 roots exhibited characteristics of abnormal development with reduced growth and lower 80 81 energy metabolism under exposure to BPA suggesting that the global pollution of agricultural soils may dramatically alter the mineral nutrition of food crop culture and threaten human 82 food safety (Xia et al. 2017). 83

The effects of BPA on plant nutrition cannot be exclusively approached by hydroponic 84 85 experiments (Neumann and George 2009). Indeed, soil properties can mediate BPA mobility 86 and its effect on plant growth (Fent et al. 2003). Moreover, plants have evolved sophisticated strategies that manifest as functional traits ameliorating nutrient acquisition to cope with 87 constraining spatial variability and poorly available elements in soil (Faucon et al. 2017). 88 89 Traits involved in nutrient acquisition include morphological, physiological and biotic root traits, i.e. specific root length, exudation of protons and various metabolites as carboxylates 90 (Li et al. 2014) and beneficial associations with soil microbial communities which promotes 91 nutrient availability (Campos et al. 2018; Chen and Liao 2017). However, few data are 92 available about BPA pollution effects on the fate of nutrients in the soil-plant system. 93

Given the importance of the mineral nutrition in the productivity and sustainability of agroecosystems, challenge is to understand the influence of BPA on plant functional traits involved in the nutrient acquisition. For this purpose, the stress response of wheat, an 97 economic global cultivated crop model was tested in soils artificially contaminated with BPA.
98 To determine whether BPA concentration gradients could drive changes of specific above99 and belowground plant traits related to the uptake of nutrients, we examined plant biomass,
100 morphological root traits, root exudation of major carboxylates involved both in stress
101 response and in nutrient mobilization, essential nutrient contents in leaves, and soil microbial
102 biomass using PhosphoLipid Fatty Acids (PLFA) analysis techniques.

#### 103 MATERIALS AND METHODS

#### 104 Soil properties and contamination

The soil used in the present study was collected in the 10-20 cm depth horizon of cultivated 105 soil (wheat crop) in the farm of UniLaSalle Institute in Beauvais, France (N 49°28'13.88", E 106 2°4'0.45") and was classified as a Haplic luvisol (IUSS Working Group WRB, 2015). Soil 107 108 properties are presented in Table 1. The soil was sieved through a 5mm stainless mesh and 109 mixed with river sand (22%; v:v). Then a sub-sample of soil was spiked with 50 ml solution of bisphenol A dissolved in acetone. After evaporating acetone overnight at room 110 temperature, the spiked soil was homogenized and mixed with unspiked soil using a roller 111 mixer to reach concentrations of 0.1 and 1000 mg BPA . kg<sup>-1</sup> dry soil. A solvent control soil 112 was prepared with BPA free acetone solution using similar procedure. The highest 113 concentration was selected to improve knowledge of the BPA toxic effects on wheat model at 114 a comparable scale level known to provoke marked phytotoxicity for other plants (Kim et al. 115 2018; Nie et al. 2015). However, toxicological data obtained at high BPA doses which are 116 valuable in regulatory hazard and risk assessment purpose, cannot be considered as 117 representative of the actual environmental situation. A lower dose was also tested, which was 118 based on the average values found in surveys, allowing us to elucidate relevance of BPA 119 contamination in agricultural field (Tran et al. 2015). 120

#### 121 Greenhouse experiment and plant cultivation

A greenhouse experiment was conducted from April to May 2018. The plant growth was 122 conducted in a pot experiment using polypropylene pots filled with 4L of uncontaminated soil 123 124 (control), solvent control soil (acetone) or soil contaminated with BPA at 0.1 and 1000 mg.kg<sup>-</sup> <sup>1</sup> dry soil. All treatments were performed in four replicates. Pots were sown with 10 wheat 125 seeds (Triticum aestivum cultivar pakito) and randomly positioned in a greenhouse with 126 controlled conditions (photoperiod 16h light/8 h dark, light intensity of 10 Watts. m<sup>-2</sup>, 127 day/night temperature of 20 °C). Plants were watered three times a week with tap water. Half 128 of seedlings were removed after one week of exposure. Other seedlings (5 per pot) were 129 130 grown and harvested after 6 additional weeks. At the harvest, roots were gently rinsed with tap water to remove adhering soil and cleaned with adsorbing paper. After collecting root 131 exudates, root systems were scanned. Roots and shoots were then dried at 65°C for 48h for 132 the determination of biomass and nutrient concentration. Rhizospheric soil (i.e. only the 133 adhering soil to 2 mm on roots that is removed by subsequent brushing after bulk soil falling 134 135 off when shaking the root system) was sampled for PLFA analysis. Bulk soil sampling was performed at the beginning and the end of the experiment for BPA analysis. 136

#### 137 Plant functional traits

Measurement of plant functional traits representative of plant nutrient acquisition were made
after 7 weeks of cultivation. Three types of functional traits (morphological, physiological,
and biotic characteristics) were assessed on roots, leaves and rhizospheric soil.

Root exudates were collected by incubating 15mL CaCl<sub>2</sub> solution (0.2mM) for 1h.
Then, 2mL exudate solution was centrifuged (2 min, 10000 g) and 1.5mL supernatant solution
was filtered through a sterile millipore 0.22 µm filter. Fifty microliters of filtrate was injected
into an HPLC system (Thermo Fisher, San Jose, CA, USA) equipped with an auto-injector, a

degasser, a diode array detector. Carboxylates were separated using the method described by
Nobile et al. (2019) on a reverse phase Luna 5µm C18 column 250mm x 4 mm (Phenomenex,
Le Pecq, France) at 25°C by using an isocratic mobile phase : KH<sub>2</sub>PO<sub>4</sub> 25mM/methanol
(99 :1 ; v:v) buffered at pH 2.40. Flow rate was set at 1 mL.min<sup>-1</sup>. The UV signal was
recorded at 210 nm.

Root morphological trait measurements were performed according to Garnier et al. (2013). Shoots and roots of the plant were separated and weighted. Length, average volume and diameter of root were analysed using a root scanner and WinRHIZO® software (Regent Instruments Inc., Québec, Qc, Canada).

The concentrations of calcium, potassium and phosphorus in shoot were determined 154 using elemental mass spectrometry after an acidic digestion in microwave as detailed by 155 Lange et al. (2016). Briefly, 0.2 g of dry leaf was ground and mixed with 8 mL concentrated 156 HNO<sub>3</sub> and 2 mL concentrated HCl. The mixture was introduced in a microwave Teflon vessel 157 158 and heated to 185 °C for 1h. After cooling, the digested solution was filtered through 159 Wathman paper, then diluted to 30 g with ultrapure water and injected into the ICP-MS system (Thermo Scientific XSERIES2). Quality control was performed using the SRM1573a 160 CRM (tomato leaves). 161

After removing plant debris from soil samples, 3 g of freeze-dried soil (from each soil 162 sample) were analyzed to measure the PLFA content. Lipid extraction was performed 163 according to Frostegård et al. (1991) . The extracted lipids were fractionated into neutral 164 lipids, glycolipids and polar lipids on a silica acid column by successively eluting with 165 chloroform, acetone and methanol neutral lipids and phospholipids were subjected to a trans-166 esterification using a base solution (KOH (0.2 M) prepared in methanol) to transform the 167 PLFA and the Neutral Lipid Fatty Acids (NLFA) into free fatty acid methyl esters. Final 168 extracts were analyzed with the use of a PerkinElmer Autosystem gas chromatograph (GC) 169

equipped with a flame-ionization detector (Norwalk, CT) and an EC-1000 (Alltech) capillary 170 column (30 m \_ 0.53 mm i.d.) with hydrogen as carrier gas (3.6 mL min<sup>-1</sup>). Fatty acid 171 quantification was made by using nonadecanoic acid methyl ester (C19:0) as an internal 172 173 standard. Their identification relied on the retention times of a wide range of standards (fatty acid methyl ester mixtures C4-C24:1, Sigma- Aldrich) and mass analysis. The 174 characterization of FA was performed by Fast GC-MS on a Shimadzu 2010 Plus system 175 equipped with a Shimadzu QP 2010 Ultra mass spectrometer detector. The separation was 176 177 performed on a Zebron ZB-WAX capillary column (10 m \_ 0.1 mm i.d., 0.1 mm film thickness, Phenomenex). The system was operated in the constant linear velocity (70 cm s\_1) 178 179 using helium as a carrier gas. Fatty acids were identified by comparing their mass spectra with the standard mass spectra in the NIST MS library. The amounts of the PLFA 16:1v5 and the 180 NLFA 16:1v5 in the soil of the different experimental plots were determined and used as 181 182 indicators of the AMF biomass. The PLFA 18:2v6,9 was used as an indicator of saprophytic fungi biomass (Frostegård et al. 1991). Gram-positive (GP) bacteria biomass was estimated 183 by the quantification of the PLFA: i15:0, a15:0, i16:0, i17:0, a17:0 amounts and Gram-184 negative (GN) bacteria biomass by the quantification of the PLFA: cy17:0, C18:1v7 and 185 cy19:0 amounts in the soil. 186

#### 187 BPA dissipation analysis

BPA dissipation in soil was studied according to the HPLC method adapted from Matsumura et al. (2015). Briefly, each frozen soil sample was dried 4 h at 50°C then 500 mg of the dried soil was mixed with 600µl of ethylacetate in a 2mL polypropylene centrifuge tube. After 10 min shaking, the mixture was centrifuged (30s, 9000g) and 300µl of the supernatant was recovered. The extraction step was repeated by three successive washing with 300µl of ethylacetate. The combined supernatants were dried overnigth in the dark at room temperature. The extracts were reconstituted in 500µl acetonitrile–water (60:40) and 50µl were injected into the HPLC system described above. Separation and quantification of BPA in the standards and sample extracts was achieved using a mobile phase consisting of acetonitrile/water/acetic acid (40:59 :1, v/v) with a flow rate of 1 mL min–1. The column temperature and UV signal were set at 25 °C and 230 nm, respectively. The standard calibration curve exhibited linearity in the range 0.025–100 mg. L<sup>-1</sup> BPA (r > 0.998).

201 5. Statistical analysis

Data were analysed by Kruskall-Wallis test and pairwise comparison using IBM SPSS statistics 25.0 software. Differences between the treatments were declared significant at the *p*value of 0.05 (p < 0.05).

206 RESULTS

207 Leaf biomass and mineral content

Leaves did not share visible symptoms of BPA induced stress over the experimental period. However, the dry plant weight differed among treatment groups after 7 weeks of cultivation (figure 1). The dry shoot weight significantly decreased by 40 % at 1000 mg.kg<sup>-1</sup> BPA compared to the controls while shoot biomass production was not affected at 0.1mg .kg<sup>-1</sup> BPA. In contrast, soil contamination had no effect on the leaf mineral composition. For all treatments, leaf P, Ca, K concentrations exhibited similar values (table 3).

215 Root morphology, biomass and carboxylate exudates

Root diameter increased by 38% at 1000 mg.kg<sup>-1</sup> BPA compared to the control (table 2), 216 while no change was observed in the group that received low BPA dose. For all the 217 conditions, roots displayed similar values of length, volume, specific root length (SRL) (table 218 2) and dry weight biomass (figure 1). BPA addition in the soil had no significant effect on 219 carboxylates exudation pattern (figure 2). The main carboxylates released were a 220 combination of malate (up to 2.3 nmol.g<sup>-1</sup>), malonate (up to 2.7 nmol.g<sup>-1</sup>) and citrate (up to 221 1.5 nmol.g<sup>-1</sup>) while fumarate was less abundant (up to 0.4 nmol.g<sup>-1</sup>). Malate, citrate, malonate, 222 223 fumarate production were comparable among treatment groups and the sum of carboxylates accounted for up to 6.6 nmol.g<sup>-1</sup>. 224

### 226 Soil PLFA analysis

227 The composition and contents of microbial PLFA were similar in rhizosphere of plants grown in contaminated soil and uncontaminated soil (table 4). Total amount of microbial PLFA 228 ranged in average from 2.78 to 4.82  $\mu$ g.g<sup>-1</sup> dry roots. The predominant compounds were GN 229 230 bacteria and AM biomasses indicators. GP bacteria, saprotrophic and ectomycorrhyzal fungi PLFA were also detected in soil and represented less than 12 % of the total amount. There 231 was a tendency for PLFA contents specific to all microbial functional groups investigated and 232 their cumulative sum to reduce at 1000 mg.kg<sup>-1</sup> BPA (P < 0.1). In soil sample treated with 0,1 233 mg.kg<sup>-1</sup> BPA, the amount of PLFA markers of the bacterial and fungal community were not 234 significantly different from controls. The ratio of GN:GP bacteria and the ratio of bacterial to 235 fungi varied from 1.2 to 2.5 and were unaffected by soil treatments. 236

238 BPA soil analysis

BPA contamination was not detectable in control and soils spiked at 0.1 mg.kg<sup>-1</sup> with our
analytical method (data not shown). BPA was nearly totally removed from soil spiked at
1000 mg.kg<sup>-1</sup> after 7 weeks of culture as its final concentration decreased by 90% compared
with its initial concentration, indicating an estimated half-life of 15 days (figure 3).

#### 244 DISCUSSION

245

Effects of BPA on plant nutrition were mainly studied using hydroponic approaches so far. However, in soils, plants behave differently than in hydroponic condition. Optimisation of resource acquisition via anatomical root changes, exudation and contribution of telluric microorganisms may reverse the negative effects of BPA stress on nutrient uptake and vegetative growth and enhance plant tolerance for survival in contaminated soil. Therefore this study was conducted to explore how these key functional traits involved in nutrient acquisition respond to BPA contaminated soil and affect plant functioning.

254 Effects of BPA addition on root morphological and leaf traits

Root functional traits which are highly variable, provide a protective response to contaminants 255 in soils allowing to highlight their ecotoxicity. This response can be manifested by 256 morphological and architectural remodelling of the root systems dependent to plant species, 257 the nature of the contaminant and the exposure conditions (Potters et al. 2009). For wheat, 258 reduction of the principal roots has been documented in plants exposed to toxic elements or 259 organic chemicals (Lamhamdi et al. 2011; Qu et al. 2010). In our study, no evidence of BPA 260 effects was observed on roots functional traits response at environmentally relevant 261 concentration (figure 1, table 2). In the same way, BPA did not exert influence on root 262 biomass and length at high dose. Root traits response to soil contamination was only 263

observed by changes in root diameter at 1000 mg.kg<sup>-1</sup>. This observation could be explained 264 by changes in cortical cell number and size/width of stele diameter due to BPA induced stress 265 hormones production, reactive oxygen species generation, cell wall and organelles damages as 266 revealed by others studies (Wang et al. 2015; Xiao et al. 2019). This plasticity of cortical and 267 stelar tissue was mainly evidenced in plants limiting the surface contact with metallic 268 pollutant of the soil (Sofo et al. 2017). In our experiment, morphological root traits did no 269 play a role of protective barrier against BPA penetration as roots length and volume were not 270 271 reduced significantly with diameter increase. We postulated that changes in root morphology may have been beneficial to the transfer of BPA contaminant in above ground biomass of 272 wheat. Indeed, several studies have reported the presence of high amounts of BPA in shoot of 273 wheat, tomato and lettuce seedlings following root or foliar exposure (Lu et al. 2015; Wang et 274 al. 2018). Once absorbed by root systems, this organic compound does not accumulate in root 275 276 cells but rather distributes to stem and leaves of the plants and exerts toxic effects on 277 chlorophyll synthesis, photosynthetic activity of chloroplast and stomatal guard cells (Ali et 278 al. 2017; Jiao et al. 2017; Qiu et al. 2013). In the current study, no effects were shown in leaf 279 traits of plants exposed to the environmental dose (figure 1, table 3). Unlike root, shoot growth was severely inhibited by the soil contamination at 1000 mg.kg<sup>-1</sup> BPA. Our findings 280 281 are in agreement with several studies which reported that BPA disturbs the shoot development of various species including wheat with reduction of leaf biomass, area or anatomy 282 abnormalities (Ali et al. 2016; Frejd et al. 2016; Staples et al. 2010). Exposure to BPA was 283 also reported to reduce shoot growth more than root growth for Vigna radiata in another 284 experiment using artificially contaminated soil (Kim et al. 2018). Root systems were not 285 altered at BPA exposure below 1000 mg.kg<sup>-1</sup> while the threshold level of toxicity for shoot 286 was evidenced for 500 mg.kg<sup>-1</sup> BPA. Based on the current data, it is difficult to solely ascribe 287 the reduction of shoot biomass to deleterious events on chloroplastic cells in shoot of plant 288

grown in the presence of 1000 mg.kg<sup>-1</sup> BPA. Perturbation of nutrients acquisition of the roots 289 is another determining factor that could be influenced by BPA to promote inhibition of leave 290 growth. Indeed, previous studies have already pointed the better maintenance of root growth 291 than shoot in wheat experiencing mineral starvation (Shen et al. 2018). Nutrient exchanges in 292 developing plant result from a complex coordination between leaves and roots metabolisms. 293 Shoots produce metabolites, mainly carbohydrates, which are transferred and oxidized by 294 respiratory enzymes of the roots to sustain energy demand of the cell growth, active transport 295 296 of soluble elements or release of exudates at the soil/root interface (Jones 1998). Changes in roots activity, by controlling the absorption and translocation of nutrients, including elements 297 necessary for the chlorophyll synthesis and photosynthesis, can have negative impact on the 298 vegetative growth. 299

To understand whether defects of nutrient supply could explain shoot biomass reduction in the 300 1000 mg.kg<sup>-1</sup> BPA treatment, the concentrations of P and others major nutrients necessary for 301 cell growth (Ca, K) were analysed. The treatment effects on leaf P, Ca, and K contents were 302 not significant (table 3), suggesting that absorption function was not impaired in plant grown 303 on environmentally contaminated soil. Moreover, nutrient uptake by roots in our 304 experimental conditions seems less sensitive to BPA exposure than in artificial hydroponic 305 culture showing reduced roots activity, respiration enzymes, absorption of mineral elements 306 (P, K, Mg, Mn, and Zn) in soybean seedlings treated above  $3mg L^{-1}$  BPA (Xia et al. 2017). 307 These discrepancies might result from morphological and physiological strategies developed 308 by plants in solid matrices in interaction with soil microbiome to efficiently take up nutrients. 309 Previous observations of root systems under abiotic stress have revealed that the effects of 310 roots architecture on nutrients absorption are significant in soil but not in hydroponic 311 solutions (Aibara and Miwa 2014) while other findings pointed the importance of root 312

diameter changes in adaptive response of plants to fluctuations of nutrients availability insoils (Strock et al. 2018).

315 Effects of BPA addition on plant-microbiome interactions

Plant-microbiome interactions are mainly explained by a range of plant-derived exudates, 316 microbe-microbe interactions that could be enhanced in BPA contaminated soil to promote 317 nutrient acquisition by the root. Plant-microbiome interactions are determined at distance by 318 319 carbon assimilation capacity of the developing leaves. Keiluweit et al. (2015) have estimated that up to 40-60% of photosynthetically fixed carbon in shoots is allocated to the roots and 320 microorganisms of the rhizosphere via border cells, tissue, mucilage, and the release of 321 sugars, amino acids, phenolic compounds and carboxylates. Secretion of organic acids in the 322 rhizosphere soil can have direct and strong involvement on chelation, dissolution, desorption 323 of ionized elements and communication with beneficial microorganisms contributing to plant 324 nutrition (Zhang et al. 2013). Because plants which increased root/shoot ratio, direct higher 325 326 carbohydrates amounts from shoots to roots (Hermans et al. 2006), BPA-induced shoot 327 biomass reduction was expected to influence soil microbial communities and carboxylate exudates that can optimize nutrient access to the roots. However, no effect on organic acids 328 composition and release was observed at both high and low doses in our study. Malate, 329 330 malonate, citrate and fumarate were detected in all wheat root exudates (figure 2) as generally reported in previous environmental studies carried out with wheat species (Lyu et al. 2016; 331 Pearse et al. 2007; Vančura 1964). Low production rates of exudate were consistent with 332 other findings indicating that wheat release slow and largely constitutive carboxylates 333 amounts which do not always play a determinant role in improving nutrient mobility (Pearse 334 335 et al. 2005; Wang 2019). It has also been reported that the proportion of malate and citrate exuded in wheat were dependent on nutrient shoot status and were not systematically affected 336 by fluctuating nutrients availability in the soil (Pang et al. 2018; Shen et al. 2018; Wang 337

2019). Nevertheless, the unresponsiveness of carboxylates to BPA exposure in our 338 experimental conditions cannot be interpreted as a lack of effect on plant exudation and 339 nutrients acquisition efficiency. Syranidou et al (2017) detected a variation of carboxylates 340 341 exudates of Junctus Acutus soil leachates 2 hours after incubation with BPA. Formic acid was the only carboxylate affected by BPA addition. In our situation, exudates were not collected 342 within similar short term period. Moreover, we did not investigated all substances exuded 343 with selected carboxylates that could be influenced by BPA exposure to drive changes in 344 structure and diversity of microbial communities. In this line, previous researches have 345 proved that BPA used as carbon source can cause direct effects on abundance, structural 346 composition and enzymatic activities of bacteria communities of waste water treatment plant 347 sludge and sediments (Huang et al. 2017; Li et al. 2019). BPA in contaminated soil could 348 exert a selective pressure on microbial population at the interface of the root system to 349 350 optimize acquisition of nutrients but this effect has not received much attention in the literature. Among, microorganisms living in the plant rhizosphere, plant growth promoting 351 352 rhizobacteria, saprotrophic, ectomycorrhizal and AM fungi play an important role in nutrients capture from the soil and plant development (Bardgett et al. 2014; Wang et al. 2017). 353

In our study, the quantification of microbial biomass of the control and contaminated 354 355 rhizosphere using PLFA analyses revealed the domination of GN bacteria and AM biomass in agreement with the literature (Field et al. 2019; Zhang et al. 2019) (table 4). The 356 introduction of BPA in soil did not cause a pronounced disruption of microbial biomass at the 357 end of the experimental period. Environmental exposure to BPA did not caused any damage 358 to soil PLFA. A global trend of reducing bacteria and fungal PLFA concentrations was only 359 observed when high dose was applied. Our findings were in line with earlier results showing 360 that microorganisms were tolerant to low BPA concentration in sediment but could not 361 362 survive and proliferate when exposed to high loading (Matsumura et al. 2015). The soil

contamination at both environmental and toxic concentrations failed to change bacterial to 363 fungi ratio and GN:GP bacteria ratio. Comparable general observation was made in 364 bioreactors by Pilna et al (2019), reporting no differences of PLFA ratios of GN:GP, fungi 365 366 and bacteria in BPA contaminated sewage sludge. Some previous studies have also shown that microbial inhibition or promotion were dependent to the initial concentration of BPA 367 added and the duration of the experiment (Li et al. 2019; Wei et al. 2019). In other reports, 368 none persistent effects on microorganisms growth were evidenced following introduction of 369 370 antibiotics, organic chemicals or inoculation of living bacteria (Liu et al. 2016; Magdalena et al. 2019). In these disturbed soils where strong effects on microbial biomass accompanied 371 372 shift from bacterial to fungi, difference in PLFA markers of the first days reduced gradually to be not significant after several weeks of incubation. A similar situation, which implies that 373 microbial population was temporary affected at the beginning of the experiment, could have 374 375 occurred despite that no long-term effects were reported by our PLFA analyses in soil after 7 weeks of cultivation. The catabolic activity of microorganisms degrading BPA is another 376 377 important factor responsible to the changes of microbial equilibrium in BPA contaminated soil (Zhao et al. 2015). BPA is generally prone to a rapid decomposition and utilization in soil 378 from many bacterial and fungal strains producing ligninolytic enzymes able to catalyse 379 oxidation of aromatic compounds (Prieto 2016; Zhang et al. 2013). The presented PLFA 380 results do not rule out an active participation of such microorganisms to the removal of BPA 381 in soil within the experimental period. In our study, an important dissipation of BPA in soil 382 was confirmed with HPLC analysis by comparing soil collected prior and at the end of the 383 experiment (figure 3). This result, consistent with published values (Tran et al. 2015; Yu et al. 384 2013), suggests that BPA weakly bound to soil particle, was bioavailable to microorganisms 385 and plant. While further experiments are required to identify biodegradation processes of BPA 386

in soil, their mobilization did not influence plant-microbiome interactions mediating nutrientavailability.

#### 390 CONCLUSION

Our work demonstrates that plant trait responses to BPA exposure dose-dependent. While no influence on plant functional traits was found with BPA at environmental concentration, remodelling of morphological traits was the main strategy used by wheat plants to ensure nutrient acquisition in response to increasing BPA dose. Plant maintain optimum P, Ca, and K contents in shoot by favouring root growth rather than shoot growth and by producing more large roots under high BPA concentration. Root carboxylate exudation and microbial structure of the rhizosphere did not take part to BPA-induced stress adaptation.

398 This first attempt to identify long-term effects of environmentally relevant BPA soil contamination did not focus on early events that may transiently occur during developmental 399 stages of the plant. Therefore, the traits response of plant under BPA stress need to be 400 confirmed by extending experiments to more impoverished soil, i.e. more nutrient deficient as 401 for the P in which carboxylate exudation and root-microbial interactions will probably be 402 more important to cover nutritional requirements of the plant. A better understanding of 403 processes that control nutrient uptake through an accurate determination of functional traits 404 provide a benefit approach to successfully assess environmental risk of BPA and others 405 406 emerging contaminants under field conditions.
