#### Abstract

Determining the lipid content and fatty acid composition of aquatic organisms has been of major interest in trophic ecology, aquaculture and nutrition for over half a century. Although protocols for lipid analysis are well-described, their application to aquatic sciences often requires modifications to adapt to field conditions and to sample type. Here, we present the current state of knowledge of methods dedicated to both marine and freshwater lipid analyses, from sampling to data treatment. We review: (i) sample preservation, storage and transport protocols and their effects on lipids, (ii) lipid extraction, separation of polar and neutral lipids, derivatisation and detection methods, and (iii) available tools for statistical analysis of fatty acid data. We provide recommendations for best-practices in field situations and advocate for protocol standardisation and inter-laboratory calibration.

## 49 Introduction

Lipids and their fatty acids (FA) are ubiquitous components of all living organisms. They are essential compounds for the formation of cell and tissue membranes, act as major sources of metabolic energy, provide thermal insulation and serve as chemical messengers. Fatty acids generally consist of a linear hydrocarbon chain with a carboxyl group (-COOH) at its end. They are characterised by the length of their carbon chain, generally from 14 to 24 (up to 36) atoms, as well as by the position and the number of double bonds (usually from 0 to 6) that determine their degree of unsaturation. Fatty acids are constituents of lipids such as wax and sterol esters (WE, SE), triacylglycerols (TAG), diacylglycerols (DAG), monoacylglycerols (MAG), glycolipids and phospholipids (PL), which show different levels of regulation from ingestion to incorporation. One or several FA are linked either with an ester (or ether / vinyl-ether) bond to an alcohol, mainly glycerol, or with an amide linkage to a long-chain nitrogen base, mainly sphingosine. All of these molecules are categorised as either neutral lipids or polar lipids, with reference to chromatographic methods of lipid class separation but also to their metabolic roles (Christie, 1984). Among neutral lipids, FA-containing compounds include TAG and WE, which are the main storage lipids, whereas DAG, free FA (FFA), and MAG are generally minor constituents. Sterols (both in their free and esterified form) and fatty alcohols (ALC) are also found in neutral lipids. Free FA are rarely present in living organisms, as they may be toxic in high concentrations (Jüttner, 2001). Polar lipids include PL, glycolipids, and sphingolipids. Polar lipids are characterised by a hydrophilic polar head group which, in contrast to their hydrophobic aliphatic chains, allows for the formation of lipid bilayers found in cell membranes. Polar lipid properties are determined by the nature of the polar head groups, the nature of the linkage between the polar head group and aliphatic chain, the length of the carbon chain, as well as the position and the number of double bonds within the FA. These different properties influence the functioning of membrane receptors, the fluidity of membranes, and the stability of the bilaver structure (Hazel and Williams, 1990). 

Fatty acids have been analysed in aquatic sciences for over 50 years (Ackman et al., 1968) with the first evidence that FA composition of consumers resembles that of its food (Lee et al., 1971). Over the next 30 years, the concept of FA trophic markers (FATM) gained in popularity in aquatic trophic ecology (Dalsgaard et al., 2003). According to this concept, FA composition of some primary producers is characterised by specific compounds that can be transferred to upper trophic levels (e.g. Kelly and Scheibling, 2012). The FA composition of a consumer is therefore expected to reflect the FA composition of its food sources ('you are what you eat' principle). FA have accordingly been used to study energy flow in food webs in freshwater, estuarine, coastal and deep-sea, environments in all latitudes, and to examine functional responses to stressors (Kelly and Scheibling, 2012). More recently, the FATM concept has culminated in quantitative FA-based diet modelling (Iverson et al., 2004; Galloway et al., 2014; Bromaghin et al., 2017), and recent methodological developments allow for accurate estimation of prev contribution to consumer diet (Litmanen et al., 2020). However, diet modeling is based on the fact that aquatic consumers generally lack the ability to synthesise long-chain polyunsaturated FA (LC-PUFA,  $\geq$  C20), and have limited capacity for bioconversion of short-chain PUFA into long-chain PUFA (Castell et al., 1972; Langdon and Waldock, 1981; Sargent et al., 1999; Taipale et al., 2011). This view has recently been challenged (Kabeya et al., 2018). Diet is not the only determinant of the FA composition of aquatic consumers. FA composition 

Diet is not the only determinant of the FA composition of aquatic consumers. FA composition
varies with intrinsic factors such as phylogeny and developmental/reproductive stages (e.g. Galloway
and Winder, 2015), and extrinsic factors such as temperature, salinity and hydrostatic pressure (e.g.
Wodtke, 1981; Cossins and Macdonald, 1989; Hazel and Williams, 1990), thus providing information
about physiological condition and habitat type of aquatic organisms (e.g. Meyer *et al.*, 2019).

The analysis of the FA composition of aquatic organisms is based on procedures originally developed for applications in food science and medicine. Briefly, once a sample is collected, it is immediately stored in the dark at the lowest possible temperature for the shortest period of time with added antioxidants, and under a nitrogen atmosphere or vacuum. This is to avoid alteration caused by enzymes, heat, oxygen and light. Lipids are then extracted, and lipid classes may be separated using Page 7 of 207

chromatography. Next, derivatisation of FA is performed (methylation in most cases) and FA
composition is determined by gas chromatography. Finally, data are treated to obtain the quantitative
and qualitative FA profiles of the sample (Figure 1).

There are likely to be as many variations of procedures as there are laboratories (Parrish, 1999). Yet, not all may be applicable to aquatic samples. Procedures involved in sample collection, handling and storage, as well as extraction and transesterification steps, can cause biochemical modifications of FA and differential loss, leading to false or misleading interpretations. Identifying the most appropriate protocols and the best-practices in FA analysis of aquatic organisms may prove to be a difficult task for novices, as available literature is widespread and highly diverse, and many studies do not fully describe their methodology (e.g., "modified Folch extraction").

Our objective is to provide an up-to-date review of the procedures used for a large number and variety of aquatic samples and laboratories around the world. This review emerged from technical workshops of the conference "*Lipids in the oceans*" held in Brest (France) in November 2018. We answer practical questions that are not necessarily formulated in papers and textbooks, but essential to obtain a reliable FA profile. For example, which organ/tissue of particular specimens should be analysed to be representative in the context of trophic ecology? How are samples properly collected, transported or shipped? What are the most appropriate extraction/transesterification methods or solvent systems? How can one ensure reliable FA identification and quantification? How are FA data analysed? This paper aims to guide both novice and advanced scientists in identifying the most appropriate protocols and best-practices for FA analysis of aquatic samples. We hope that this comparative synthesis will stimulate further international collaborations and facilitate standardisation of lipid analyses.

## Sample handling and storage before lipid extraction

The choice of biological material, its collection and handling techniques, as well as storage methods, 123 124 are among the most important steps in lipid analysis (Fig. 1). Lipid degradation can occur by 11 hydrolysis (release of FFA from acyl lipids through the enzymatic activity of lipases) or oxidation of 125 126 carbon-carbon double bonds. In view of the labile nature of lipids, these processes often occur very 16 127 rapidly, leading to analytical errors and increased sample variability (Christie, 1984). Handling and 18 128 storage conditions and methods can help minimise sample degradation and analytical bias. Ideally, 20 129 lipids should be extracted immediately after collection. The second-best option is to flash-freeze samples in liquid nitrogen immediately after collection. As sampling of aquatic organisms is often <sub>23</sub> 130 25 131 performed in the field and in remote areas, optimal conditions can rarely be achieved, but samples <sup>27</sup> 132 28 need to be stored adequately. A broad set of procedures exists, including: (i) sample maintenance on \_\_\_\_\_ 30 133 ice, (ii) frozen sample storage from -18 °C (standard freezer), to -80 °C (laboratory freezers) and/or to -196 °C (liquid nitrogen), (iii) freeze-drying of samples, or (iv) sample storage in organic solvents 32 134 34 135 for varying storage periods, from a few hours to years prior to analysis. Adequate storage conditions will prevent (or at least limit) the degradation of lipids through hydrolysis and oxidation processes 136 38 induced by oxygen, temperature, light and/or enzymatic processes (Rudy et al., 2016). The rate of 39 137 41 138 oxidation and hydrolysis processes (hereafter referred to as "lipid degradation") is likely to vary 43 139 greatly across species and tissue types. These processes can be revealed by an increase in FFA and a 46 140 decrease in glycerolipids and polyunsaturated FA (PUFA) in samples (Christie, 1984, see section 4). 48 141 Here, we provide an overview of different methods used in the literature and discuss their strengths <sup>50</sup> 142 and limitations.

54 143 Sample type/ sampling strategy 1.1

<sup>58</sup> 144 Aquatic samples are highly diverse, ranging from bacteria to whales, and sampling procedures need 59 60 145 to be adapted to the nature of the studied organisms/functional groups. Samples of seston and

 phytoplankton are generally collected through water filtration on pre-combusted glass microfiber filters (GF/C or GF/F), while zooplankton can be sorted manually. Such small organisms or functional groups are often directly extracted as whole organisms and stored in solvent. For other organisms such as larger invertebrates, fish, and aquatic mammals, tissue dissection or biopsy is usually required. In the case of multi-purpose samples, it is possible to grind them under liquid nitrogen and subsample the powder (Soudant et al., 1996). In the case of a quantitative study where the mass of lipid or FA is reported per gram of sample, the sample will have to be weighed before or after storage. 16 152 18 153 Sample mass can be measured from fresh or dry tissue. In the latter case, the dry mass may be measured on a dedicated subsample. All material should be lipid-cleaned prior any sampling to avoid cross contamination (see section 3.1). Because it is not possible to describe all sampling strategies <sub>23</sub> 155 here, we highly recommend that any study involving lipid and FA analysis must start with a literature 25 156 <sup>27</sup> 157 review of available information on targeted organisms or on species that are phylogenetically Lien comparable. 

#### Sample handling 1.2

Maintaining samples on ice is often the first and only practical option available to limit lipid degradation between collection and further processing. Whenever possible, long-lasting dry ice is 40 161 <sup>42</sup> 162 preferable to water ice. Ideally, samples should be immediately flash-frozen in liquid N<sub>2</sub> in the field and transported to a freezer using a dry shipper. Crushed ice is useful for transportation between locations such as sample transport from the ocean (e.g., small and large vessels) to land, or transport 47 164 between laboratories. Crushed ice should preferably be used only for a few hours, as this method only slows, but does not stop, lipid and FA degradation (Wood and Hintz, 1971; Chaijan et al., 2006), and <sub>54</sub> 167 samples should therefore be frozen as soon as possible. As an alternative, deep-frozen, long-lasting ice packs are a convenient option for short-term storage in the field (e.g., TechniIce<sup>™</sup>). These ice 56 168 <sup>58</sup> 169 packs maintain temperatures around 0 °C for a few hours in a well-insulated container (L. Couturier pers. obs.). In the particular case of studies on thermal acclimation or adaptation, it may be preferable

59 60 to maintain samples at environment temperature rather than to cool them before freezing as it may induce a short-term cold-response. Freezing / thawing samples more than once should be avoided.

Storage 173 1.3

## 1.3.1 Frozen storage (-20 °C to -196 °C)

Storing samples at cryogenic temperature is likely the most common method of preservation before performing FA analyses. Yet, depending on the temperature, storage duration and type of biological 176 material, this may not be sufficient to limit lipid degradation. It can lead to increased FFA and products of oxidation (e.g., Christie, 1984; Gullian-Klanian et al., 2017; Tenyang et al., 2019). Lower freezing temperatures and short-term storage are generally associated with lower lipid degradation (e.g., Baron et al., 2007; Rudy et al., 2016; Gullian-Klanian et al., 2017). The level of lipid degradation in samples is highly dependent on initial freezing temperature and temperature variation 182 during storage, as well as storage duration prior to analyses (Han and Liston, 1987; Ramalhosa et al., 2012; Romotowska et al., 2017). When long-term storage is required, the safest approach is to freeze samples at -80 °C immediately after collection. Although not ideal, long-term storage at -20 °C can be suitable for some species and sample/tissue types, in particular when samples are kept frozen within the organic extraction solvent. Levels of n-3 and n-6 PUFA in fish muscle, stored at  $-30 \degree C$ and -80 °C, did not change for up to 12 months in both TAG and phospholipid fractions (Passi et al., 2005). Shark muscle samples archived for up to 16 years at -20 °C retained their FA profiles, while lipid class composition was not analysed (Meyer et al. 2017). Impacts of frozen storage on FA content 189 and composition are species-specific and can depend on the total lipid content of the organism and tissue (Rudy et al., 2016). Species with high total lipid content (>10% wet weight) must be treated with increased care (low temperature, and short storage period) to avoid changes in FA content during <sub>58</sub> 193 freezing (Rudy et al., 2016; Sardenne et al., 2019).

Based on the literature cited, samples should be stored for less than 6 months prior to analysis at temperature lower than -20 °C when no information is available on the collected biological material. Note that lipid analysis is also possible for samples stored using brine immersion freezing technique (e.g., fisheries-issued material) (Bodin *et al.*, 2014). The sensitivity of lipids to storage varies according to species and tissues. We therefore recommend evaluating the sensitivity of the samples for which there is no information available before the start of the study. For example, a temporal monitoring of the lipid composition of the biological material of interest at the available storage temperatures will make it possible to define the optimal conservation strategy.

1.3.2 Freeze-drying

Freeze-drying (or lyophilisation) is a low temperature dehydration process of frozen material that is used to reduce enzymatic activity and thus lipid degradation in samples. Freeze-drying samples immediately prior to extraction does not affect lipid class or FA compositions of aquatic animal tissues (e.g., Dunstan et al., 1993; Murphy et al., 2003; Sardenne et al., 2019). This can be a good alternative to frozen storage, as freeze-dried tissues can be easier to grind and to transport than frozen tissues. Rehydration may be required to improve the lipid extraction of TAG (e.g., Dunstan et al., 1993) and to comply with extraction procedures that rely on a particular proportion of water in the sample. Nonetheless, freeze-dried tissues still need to be carefully stored to prevent lipid degradation. Storage duration can also have detrimental effects on lipid composition of samples. In fish, crustacean and molluscs, the total duration between freeze-drying and lipid extraction should not exceed one month at -20 °C for quantitative analysis (Sardenne et al., 2019). Similarly, freeze-dried microalgae samples should not be stored for extended period of time (but see Rudy et al. 2015). The PUFA proportion of filtered Isochrysis galbana biomass decreased from 36% to 26% after 3 months storage at -76 °C (Babarro et al., 2001). Proportions of FFA in freeze-dried Phaeodactylum tricornutum increased from 4 mg/g to 6 mg/g DW after 35 days at -20 °C while the degree of oxidation was unaffected (Ryckebosch et al., 2011). Variability in freeze-dried sample stability/viability for lipid

analysis is likely to reflect differences of biological material and length/duration of the freeze-drying 219 220 process.

Overall, the quality of the freeze-dried storage depends on: (i) the storage temperature (lower 221 222 temperatures are the best), (ii) the storage duration (shorter durations are better) and (iii) the lipid content of samples (lean samples are conserved better than lipid-rich samples). Lipid oxidation in 223 224 food products occurs more rapidly when water activity is high (Labuza et al., 1972). Conversely, lowering water activity below 0.2 through freeze-drying process may be a factor promoting lipid 16 225 18 226 degradation through oxidation (Labuza et al., 1972), and specific testing should be considered for aquatic samples. Freeze-drying may offer some benefits when used as a short-term preservation 227 method (e.g., during transport), but it can be expensive (necessary equipment) and time-consuming, <sub>23</sub> 228 while potentially shortening the viability of samples for lipid analyses. 25 229

230 1.3.3 Solvent and fixative storage

<sup>35</sup> 232 One common storage strategy is to directly immerse small organisms such as phytoplankton collected on filters or small-bodied zooplankton into the lipid extraction solvent (e.g., Marty et al., 1992; 233 40 234 Soudant et al., 1998; Windisch and Fink, 2018). If samples in the extraction solvent (generally 42 235 chloroform CHCl<sub>3</sub> and methanol MeOH) are kept in the dark and at low (preferably freezing) 236 temperatures, lipid degradation is minimal. To our knowledge, maximum storage duration of <sub>47</sub> 237 extracted lipids has not been formally investigated. However, samples are likely to remain useable for months to years. For microalgae samples, it is advised to deactivate lipases by a rapid addition of 49 238 <sup>51</sup> 239 boiling water or isopropanol prior to extraction (Berge et al., 1995; Budge and Parrish, 1999; 54 240 Ryckebosch et al., 2012).

55 56 241 antioxidants (0.01%) butylated hydroxytoluene. Synthetic BHT 0.1% tertiary or 57 58 242 butylhydroquinone, TBHQ) can be added to solvent-stored samples to reduce radical formation and 59 60 243 oxidative losses of unsaturated lipids (Christie, 2003; Ryckebosch et al., 2012). However, addition

 of synthetic antioxidant is unnecessary in samples containing large amount of natural antioxidants such as microalgae (Ryckebosch *et al.*, 2012). Note that BHT elute with short-chain FA and when present in large quantities, it can overlap with FA of interest.

*1.3.3.2 Fixatives* 

Fixatives such as ethanol or formalin are commonly used for biodiversity, taxonomy, morphological, or DNA analyses. The use of fixed samples opens new research opportunities, by making it possible to analyse historical samples collected for purposes other than lipid analysis. However, fixatives influence the chemical composition of the samples and should therefore not be used as a routine procedure for lipid analyses. For example, FA composition of crustacean tissues is altered in formalin-preserved samples, but not in ethanol preserved samples (Phleger *et al.*, 2001). Direct evaluation of fixative effects on lipids are scarce and preliminary tests on different sample types are highly recommended.

#### Transport and shipping 2

The packaging, transport and shipping of samples for lipid analysis is a complex process, driven by safety laws, financial costs, stringent storage conditions, and limited duration of storage. Specific legal regulations, including quarantine, must be followed and they can vary, depending on whether the samples are shipped domestically or internationally, and whether there are stopovers during long distance travels. Shipping recommendations to ensure that samples arrive at their destination in good condition include triple packaging with a rigid outer layer and absorbent material, appropriate cooling, accurate labelling (i.e., name, address, phone number, e-mail address, size and weight of the package), and complete legal documentation (e.g., itemised list of content, permits) (IATA, 2010). This section reviews different options of packaging for shipping and traveling, and gives an overview of the main flying regulations and key legal information. 1.

#### 2.1 Shipping samples

Long-distance shipping from the sampling site to the laboratory is challenging. Multiple issues need consideration, such as the conservation state of the samples prior to transport (cooled, frozen, deepfrozen, freeze-dried), the distance, the duration and the type of transport. As samples are generally prone to degradation, temperatures must be kept low and oxidative conditions reduced as much as possible. Regardless of the method used, we recommend only to ship a part of the original sample and keep a backup sample when possible, and to take great care in the packaging (minimum empty space, adapted container to accommodate samples and cooling methods).

When possible, frozen samples should be shipped using dry shippers, which are aluminium containers flooded with liquid nitrogen. They contain adsorbent material that prevents spills of liquid nitrogen during shipment and have attached temperature loggers. Samples can be stored in these conditions for several weeks. However, dry shippers may not be readily available at sampling 279 locations or in laboratories. Restrictions for the transport of liquid nitrogen also need to be considered

(e.g. in airplanes or closed vehicles). With transporter authorisation, frozen samples can also be shipped on dry ice depending on transport duration (about 24 h for 2.5 kg of dry ice). Alternatively, 281 deep frozen (-80 °C) aqueous ice packs or reusable technical ice packs (e.g. TechniIce<sup>™</sup>, 2019) can 282 283 be used. A cost-effective option is to freeze-dry samples prior to shipping, as it reduces both the volume to be shipped and the risk of lipid hydrolysis by removing water (see section 1). When dry 284 285 ice packaging or deep-frozen ice packs are not available at the sampling location, freeze-dried samples should be kept cool and in an oxygen-free atmosphere by flushing containers with nitrogen gas and then sealing prior to packaging and shipping. It is also possible to ship samples with small 288 amounts of solvents with respect to international regulations. Note however that depressurisation in aircrafts promotes solvent leakage (F. Pernet pers. obs). To limit this phenomenon, tubes and caps can be coated with Teflon. Alternatively, preserved and/or extracted samples in solvent may be evaporated and flushed with nitrogen so that dried extracts can be air-transported as frozen biological material. Dried lipid extracts will have to be re-immersed in solvent as soon as possible upon arrival. We however recommend to perform preliminary testing before proceeding with this method.

The gold standard for shipping samples are specialised transport companies that maintain samples on dry ice and guarantee express delivery to the final destination. However, these options may not be practical for some laboratories and/or available for all sampling sites and destinations. Care should be taken when selecting the shipping company, as several unfortunate experiences have shown that some may not be reliable in maintaining the cold transportation chain.

## 9 2.2 Flying with samples

Although courier is preferable, one might consider putting samples in checked luggage. One of the safest options to transport samples as checked luggage is to use a dry shipper. However, airlines may have different regulations in transporting liquid nitrogen. Non-harmful materials, such as dry ice or technical ice packs are the best option to meet standard luggage regulations (e.g., < 2.5 kg of dry ice context of the best option to meet standard luggage regulations (e.g., < 2.5 kg of dry ice safest options (e.g., < 2.5 kg of dry ice)

per person) and safety (e.g. the package permitting the release of carbon dioxide gas when 304 305 transporting dry ice).

Transporting freeze-dried samples kept in a hermetically closed bag (or a thermos filled with ice) 306 307 is likely the safest and cheapest option. Upon arrival, samples need to be stored in a freezer (preferentially at -80 °C) or immediately put in a solvent solution for lipid extraction (see section 1 308 309 for more details on storage duration). Dried lipid extract should be transported as frozen samples and be returned to solvent as soon as possible (see section 2.1). Note that preservation methods requiring 16 310 18 311 flammable solvents (e.g. ethanol, methanol) are not permitted on aircraft within passenger luggage. 312 Recently, the emerging technology of drones opens new opportunities for a rapid and customisable aerial transport of sensitive samples from remote areas to laboratory facilities (e.g., Amukele et al., <sub>23</sub> 313 25 314 2017).

33 316 Prior to initiating sample collection and considering transporting them, it is necessary to be well 317 informed on import and export regulations that differ widely across countries and studied organisms' 38 318 status. It can be difficult to obtain the necessary information within custom departments and the paperwork involved. Some research institutions may have specialised services available to ensure 40 319 42 320 proper paperwork so that samples are shipped and received safely. To transport samples out of a 321 country, it is often necessary to follow The Nagoya Protocol on Access and Benefit Sharing (United Nations Convention on Biological Diversity, 2011). Although it was initially stated that this only 47 322 49 323 applies to samples for molecular research, all transports of tissue for biochemical screening are now 324 included. This applies only for countries that have signed and ratified the Nagoya Protocol.

53 <sub>54</sub> 325 When samples contain species listed in the Convention on International Trade in Endangered 55 Species of wild fauna and flora (CITES), it is necessary to request an import/export CITES permit 56 326 57 <sup>58</sup> 327 from each of the countries involved. This needs to be organised well ahead of sample collection, as 59 60

## 3 Lipid extraction

Because of their diverse structures, lipids range from non-polar to highly polar, which makes the selection of a solvent with matching polarity challenging. Methods based on chloroform and methanol (Folch *et al.*, 1957; Bligh and Dyer, 1959) have long been used across a wide range of matrix types with great success. Current alterations in environmental regulations have brought restrictions on the type and amount of solvent usage in laboratories worldwide, encouraging the exploitation of alternative organic solvents and novel eco-friendly methodologies for extraction (e.g., accelerated solvent extraction). Here, we review both the well-established techniques and the newly developed methods; we caution readers that full validation must be carried out with a given biological material before adopting any modified or adapted method.

3.1 Handling cautions

Contamination is an issue that needs to be carefully addressed at every stage of sample handling. It is recommended to; i) use material that have been cleaned using acetone or extraction solvent mixture to remove any potential lipids (e.g. Teflon-coated needles used for evaporation), ii) avoid plastic containers, tools or tips, iii) combust at 450 °C for 6 h or solvent-rinse all glassware and glass fibre filters, iv) use glass tubes fitted with Teflon-lined screw caps, v) prefer amber glassware (or aluminium foil protected) to limit solvent photo-degradation, vi) use the highest quality solvents for material/tool cleaning, extraction, or elution, vii) perform blank and reference samples for each batch of samples, and viii) wear laboratory gloves to limit exposure to toxic solvents and crosscontamination.

#### Sample preparation 3.2

Regardless of the technique used, extraction of lipids from aquatic samples requires that the solvent penetrates the sample particles so that it can make contact and solubilise the lipids present. The most 11 354 efficient extractions ensure that the particle size is as small as possible. The gold standard is to homogenise samples with a ball mill homogenizer (at -196 °C using liquid nitrogen with wet samples). With wet plant or animal tissue samples at macro-scales, this may be as simple as chopping 18 357 or blending. For wet microalgae, grinding of samples after immersion in solvent works well to break open cells. Small organisms (roughly between 1µm and 1 mm; on a filter or without) can also be directly extracted by direct immersion in the solvent mixture. The use of ultrasound-assisted extraction with a probe or bath may aid in breaking cell walls (Pernet and Tremblay, 2003). When 25 360 <sup>27</sup> 361 samples have been freeze-dried (section 1) for preservation, they may be most conveniently ground with mortar and pestle and it may be necessary to rehydrate prior to carrying out the extraction. Any of these techniques, when applied prior to subsampling for analysis, should also serve to homogenise 32 363 34 364 samples effectively, to ensure representative sampling. These diverse techniques also illustrate the need to adapt the preparatory steps and approach to the sample matrix.

<sup>40</sup> 366 Traditional extraction methods 3.3

While many researchers consider Folch et al. (1957) and Bligh and Dyer (1959) extraction methods to be similar, based on their use of chloroform and methanol, the two are quite different and were developed for different objectives. Prior to using those methods, one would do well to read the 49 369 original publications. Both methods rely on the formation of a biphasic mixture, with a lower layer 54 371 principally consisting of chloroform, and containing the isolated lipids, and an upper phase consisting 56 372 of methanol and water and containing the non-lipids. The Folch et al. procedure, using CHCl<sub>3</sub>:MeOH 58 373 (2:1, v:v) and a solvent to sample ratio of at least 20:1, was designed as a general and robust method for recovery of lipids from animal tissues (i.e., brain, liver, muscle), now applicable to several tissues

and species with a range of lipid content (Iverson et al. 2001). The Bligh and Dver method uses a 375 more polar solvent mixture of CHCl<sub>3</sub>:MeOH: H<sub>2</sub>O) (1:2:0.8, v:v:v) with a 4:1 solvent to sample ratio, 376 and was originally developed to rapidly extract lipids, principally polar lipids, from lean fish tissues. 377 While the Folch et al. method is more complicated to perform, it is more reliable and applicable 378 11 to almost all sample types. A key aspect of the original Folch et al. method that is often overlooked, 379 380 is the washing of the bottom phase that contains lipids with a mixture of solvents of the same 16 381 proportions as originally found in the upper phases. As originally described by Folch et al. (1957), 18 382 the upper phase consists of CHCl<sub>3</sub>:MeOH:H<sub>2</sub>O at 3:48:47 and while some groups do use a 50:50 383 MeOH: H<sub>2</sub>O wash as recommended by Christie (1982), it is exceedingly rare that the correct mixture is used. Thus, almost all Folch et al. procedures are best described as 'modified'. The Bligh and Dyer 23 384 method is easier to carry out, but requires greater consideration of sample type and potential 25 385 27 28 386 modification of the procedure. For instance, Christie (1982) notes that with high fat samples, an initial <sub>30</sub> 387 pre-extraction with chloroform or diethyl ether is necessary to extract TAG that would otherwise remain unrecovered. The use of the correct proportions of solvents and water are critical for 32 388 34 389 quantitative lipid recovery with both methods. One must take care to adjust the volume of water added when samples with varying moisture contents are analysed (i.e., freeze-dried material vs fresh tissue) 390 and it is often necessary to determine moisture content before beginning extraction. 39 391

41 392 These basic procedures may require some adjustments depending on lipid matrix before and/or during extraction to increase the yield or specificity of lipids to be analysed. For example, it may 393 46 394 include inactivation of lipase, changes of solvent proportions, or cell disruption (e.g. Kumari et al., 48 395 2011; Ryckebosch et al., 2012). In a general manner, authors must thus refer to the available literature <sup>50</sup> 396 on their model organisms or matrices. Given the numerous modified extraction procedures that reflect 53 397 the diversity of aquatic biological matrices, it is also essential that authors detail their protocol in publications when it differs from original methods. 55 398

Alternatives to chloroform: toward less toxic solvents 399 3.4

#### Dichloromethane 3.4.1

10 Many laboratories have become increasingly conscious of a range of occupational health and safety 401 12 13 402 areas in recent decades. Lipid studies historically used chloroform as a major solvent in many steps 14 15 403 including extraction. The less toxic dichloromethane (CH<sub>2</sub>Cl<sub>2</sub>) has regularly been used instead of 16 17 404 chloroform for lipid extraction in many aquatic labs. This replacement originated from food chemistry 18 19 research (e.g. Chen et al., 1981) and was later formally reported for aquatic samples (e.g., Cequier-405 20 22 406 Sánchez et al., 2008). Regardless of solvent choice, both dichloromethane and chloroform may 23 <sup>24</sup> 407 degrade on storage to produce HCl and phosgene (Noweir et al., 1972). Phosgene is a much more 25 26 27 408 acutely toxic chemical than either chloroform or dichloromethane, and inhalation can lead to 28 29 409 pulmonary oedema (e.g., Snyder et al., 1992). Chloroform degradation or insufficiently stabilised 30 <sup>31</sup> 410 may lead to lipid degradation (i.e., empty chromatograms, including disappearance of the internal 32 33 411 standard) (Le Grand and Pernet, pers. obs). To limit phosgene production, chloroform is stabilised 34 36 412 with either ethanol or amylene, with ethanol being the more effective stabiliser. Because 37 38 413 dichloromethane is less susceptible to degradation than chloroform, it is typically stabilised with 39 <sup>40</sup> 414 alkenes only. Safe lab practices, including restricting solvent use to fume hoods, can effectively avoid 41 42 43 415 risks associated with chlorinated solvents and phosgene formation. In the field, when samples are 44 preserved by direct immersion in solvent, caution is advised. 45 416 46

<sup>48</sup> 417 3.4.2 Methyl-tert-butyl ether 49

51 Methyl-tert-butyl ether (MTBE) was recently used as a less toxic solvent for the extraction of lipids, 52 418 53 54 419 but had lower recovery rates than chlorinated solvents (Sheng et al., 2011; Ryckebosch et al., 2012). 55 <sup>56</sup> 420 However, the MTBE based extraction protocol appeared especially well adapted to high-throughput 57 58 <sub>59</sub> 421 lipidomics, as the lipid extract recovered in the upper phase was cleaner with non-extractible material 60 remaining in the lower phase (Matyash et al., 2008). 422

#### The special case of ethanol preserved samples 423 3.5

The availability of historically preserved samples can often occur for a range of lipid studies (see 424 section 1.3.3.1). However, because ethanol extracts some lipids, the sample and all added ethanol 425 11 426 must be used in the lipid extraction protocol (Phleger et al., 2001). When using the Bligh and Dyer (1959) method, the extraction should be performed with chloroform (or dichloromethane), ethanol 427 and water, where ethanol replaces methanol. Care is needed when selecting historic ethanol-preserved 428 18 429 samples for lipid analysis and in which the ethanol preservative may have been replaced during <sup>20</sup> 430 storage.

<sup>28</sup> 432 Accelerated Solvent Extraction (ASE, Dionex), also known as Pressurised Fluid Extraction (PFE), is widely used method based on a controlled increase in solvent temperature and pressure during 433 extraction. This process maintains the liquid state of solvents near their supercritical region where 33 434 35 435 they have high extraction properties. Several ASE parameters can be adjusted to improve the extraction, such as temperature, pressure, extraction duration (including pre-heating) and number of 436 extraction cycles. All of these parameters affect the final solvent volume and can be adjusted 40 437 42 438 individually to each sample type to optimise the extraction yields and quality (Schäfer, 1998). This 439 sample type-specific adjustment enables high extraction efficiency with a low solvent volume and a short extraction time which is beneficial from a cost and environmental standpoint. Microscale lipid 440 extraction of fish tissues (100 mg) using ASE was shown to be as quantitatively and qualitatively 49 441 <sup>51</sup> 442 efficient as classical lipid extraction methods (Dodds et al., 2004).

55 443 Concluding remarks 3.7

<sup>59</sup> 444 This section did not aim to be exhaustive in describing existing extraction methods. When comparing 60 data from different studies, it is important to consider the lipid extraction techniques used as well as 445

handling and storage methods. When working on new matrices and developing new or optimised
extraction protocols, we recommend to compare them with Folch et al. (1957) or to Bligh & Dyer
(1959) methods, which generally remain the gold standards for lipid recovery. Ensuring complete
lipid extraction is critical when applying new protocols. Performing successive lipid extractions on a
same sample and measuring its lipid content at each step is a suitable approach to establish at which
stage the sample is totally lipid-depleted. We recommend monitoring extraction efficiency values and
ideally reporting them in publications. Alternatively to successive extractions, the fatty acid methyl
ester (FAME) content of the lipid extract can be compared to FAME recovered after direct
transesterification (section 6). A number of studies have compared the effect of extraction techniques
(ASE, Soxhlet, manual) on lipid recovery and FA content (e.g. Ewald *et al.*, 1998; Mulbry *et al.*,
2009; Balasubramanian *et al.*, 2013). While all report differences, there is little agreement as to which
may be an optimal method, likely due to substantial differences in the followed protocols.

Sample lipids may degrade through hydrolysis of ester bonds or through oxidation of carbon-carbon double bonds. These are two, largely independent processes leading to different compounds or groups of compounds, which may be used as indicators of sample degradation. Therefore, samples showing indicators of hydrolysis may not have been oxidised and vice versa. Unless necessary for a short time period (e.g. shipping), purified lipid extracts are susceptible to oxidation and should be kept under N<sub>2</sub> atmosphere with solvent (Folch mixture is generally preferred).

Hydrolysis 4.1 22 466

The most frequently encountered aquatic lipids are acylglycerols (TAG, PL, and glycolipids) in which 26 467 28 468 FA are esterified to a glycerol backbone. There are also ether lipids that replace one ester bond with an ether linkage or a vinyl ether linkage. Esters of carboxylic acids undergo hydrolysis in a reversible 469 reaction which is catalysed by hydrolase enzymes called esterases present in biological samples. 33 470 <sup>35</sup> 471 Lipases, a subclass of esterases, are found in animals, plants, fungi, bacteria and even in certain 38 472 38 viruses (Beisson et al., 2000). Lipid hydrolysis can be assessed from the FFA content, and from the 40 473 lysophospholipid content when samples are dominated by PL. Standard measurements of oil quality 42 474 are the acid value (AV) and FFA content, determined in the oil industry by titration and 475 chromatography, respectively. However, both these measurements are rarely used outside of the 47 476 industrial context.

49 477 Many chromatographic systems have been used over the past years for quantitative analysis of 50 51 major lipid classes including FFA. Free FA can be easily separated from extracted lipids by means of 478 52 53 54 479 well-known methods based on either liquid (LC) or thin layer chromatography (TLC) (reviewed by 55 56 480 Fuchs et al., 2011). For example, HPLC with light-scattering detection (HPLC-ELSD) has been 57 <sup>58</sup> 481 successfully used to detect and quantify FFA in fish with a relatively short processing time and highly 59 60 482 reproducible measurements (Christie, 1985; Silversand and Haux, 1997). As for LC, a number of

improvements to classic TLC have led to more sophisticated forms, providing better separation efficiencies and quantifications. High-performance thin-layer chromatography (HPTLC) coupled with densitometry or TLC coupled with flame ionisation detection (TLC-FID, Iatroscan, Shantha, 1992) have also been used to quantify lipid classes and FFA in samples from different origins including marine (Lochmann *et al.*, 1996; Parrish *et al.*, 2009), terrestrial (Zoumpoulakis *et al.*, 2012) and freshwater species (Litz *et al.*, 2017). In food studies, FFA determined by TLC-FID is generally equivalent to AV (Nishiba *et al.*, 2000). TLC is normally less expensive and less time-consuming than HPLC-based methods that can, of course, also be used to provide similar results.

The hydrolysis index of non-polar acyl lipids (HI) and the lipolysis index of all acyl lipids (LI) can be used as degradation indicators (Week et al, 1993; Parrish et al 1995) and are calculated as:

$$HI = \frac{FFA + ALC}{TAG + WE + FFA + ALC} * 100$$
$$LI = \frac{FFA + ALC}{\text{total acyl lipids} + ALC} * 100$$

LI values are always lower than HI values for any sample because all acyl lipids are considered.

6 4.2 Oxidation

Lipid oxidation mainly occurs through autoxidation when lipids react spontaneously with atmospheric oxygen. The process is usually autocatalytic, with oxidation products accelerating the reaction so that it increases over time. Other catalysts such as light, heat, enzymes and metals lead to photo-oxidation, thermal oxidation and enzymatic oxidation. Fatty acid oxidation is a process in which free radicals cause unsaturated FA to react with molecular oxygen forming acyl hydroperoxides, which can then breakdown into a variety of secondary products. A decrease in PUFA content may indicate oxidation as they are particularly susceptible to degradation (Sasaki and Capuzzo, 1984).

Lipid hydrolysis may accelerate lipid oxidation due to the formation of FFA that can be substrates
 for oxidation reactions, as found *in vivo* (Saponaro *et al.*, 2015). High levels of PUFA in lipids make

them susceptible to oxidation (Koshio *et al.*, 1994). Oxidation of *n*-3 and *n*-6 PUFA leads to the
formation of highly chemically reactive compounds such as malondialdehyde (MDA), 4-hydroxy-2hexenal (4-HHE) and 4-hydroxy-2-nonenal (4-HNE). HHE is an aldehyde derived from n-3 PUFA,
and HNE from *n*-6 PUFA.

A number of physical and chemical tests, including instrumental analyses, are available to determine primary and secondary products of oxidation (Shahidi and Zhong, 2005). Oil supplement, food and other industries have a range of standard measurements for determining oil oxidation. These include the internationally recommended peroxide value (PV) and *p*-anisidine value (pAV) (Nichols *et al.*, 2016). For example, PV can be measured by titration and 2-thiobarbituric acid reactive substances (TBARS) by spectrophotometry, and both can be determined using highly precise Fourier transform infrared spectroscopy (FTIR). MDA is commonly monitored using the direct TBARS test (Fernández *et al.*, 1997; Shahidi and Zhong, 2005) and with HPLC (Mendes *et al.*, 2009), while HHE and HNE can be quantified by GC-MS (using chemical ionisation) (Kenmogne-Domguia *et al.*, 2014). Recent analytical developments allowed simultaneous quantification of MDA, HHE and HNE by LC/APCI-MS and LC-MS/MS (Douny *et al.*, 2016; Tullberg *et al.*, 2016). Together with pAV, MDA, HHE and HNE are secondary markers of oxidation while PV, hydroperoxides and conjugated dienes are primary markers. However, it has to be noted that MDA, HHE and HNE quantifications do not necessary reflect PV and anisidine values (Viau *et al.*, 2016).

Sterols are also a source of oxygenated lipids named oxysterols which are sterols bearing a second oxygen functionality. Cholesterol oxidation likely proceeds in conjunction with oxidative decomposition of coexisting PUFA (Ohshima *et al.*, 1993). Cholesterol oxidation products (COP) can be determined by cold saponification of lipids (Ohshima *et al.*, 1993), followed by enrichment of COP by solid-phase extraction (SPE), and then quantification and identification by GC and GC–MS (Pickova and Dutta, 2003).

## 531 4.3 Concluding remarks

To conclude, we encourage as a minimum the assessing and reporting of hydrolysis indicators as a quality control criterion of sample handling and extraction procedures. The threshold above which sample/data quality should be questioned depends on the sample matrix, the logistical context and the study objective. In any case, the extent of either form of degradation should ideally be evaluated and compared with baseline values from fresh and properly extracted samples.

## Separation of neutral and polar lipids

Fatty acids are incorporated almost unaltered into the storage lipids such as WE, TAG, and ALC, 539 540 reflecting the FA profiles of the consumed food (Dalsgaard et al., 2003). In contrast, polar lipids are 11 541 primarily involved in cell membranes which regulate and adjust their FA composition in response to 542 environmental factors like temperature, salinity and hydrostatic pressure (Hazel and Williams, 1990). As such, inference of an organism's diet based on total lipids can be biased by the ratio of FA 16 543 18 544 originating from storage (mostly neutral lipids) and membrane lipids (mostly polar lipids). This ratio 545 varies widely across species, ontogenetic stages, reproduction, nutritional status and tissue types. For example, in small pelagic fish from the Mediterranean, the contribution of TAG stored in the muscle 546 in winter was 1.5%, 5.2% and 47.6% of total lipids for sardine, anchovy and sprat, respectively, the 25 547 <sup>27</sup> 548 remainder being mostly polar lipids (Pethybridge et al., 2014). This demonstrates that bulk FA 30 549 composition variations among species can be confounded with variations in lipid class composition. However, many studies in trophic ecology have based their trophic interpretation on the FA 32 550 <sup>34</sup> 551 composition of bulk lipids without considering the FA distribution between storage and structural lipids. 552

<sup>40</sup> 553 When should the lipid fraction be separated? 5.1

Lipid class composition should be assessed alongside the FA composition to decide whether lipid 554 47 555 class separation is necessary for robust dietary inference. Calculating the ratio of storage to structural 49 556 lipids provides a comprehensive assessment of the cost/benefit of separating neutral and polar lipids fractions. For samples dominated by storage lipids, the FA composition of bulk lipids will mostly 557 54 558 mirror the diet, and lipid class fractionation is not mandatory (e.g., fatty fish species, marine mammal blubber, and digestive gland and liver of marine organisms) (e.g. Sardenne et al., 2020). However, 56 559 <sup>58</sup> 560 for samples rich in structural lipids, fractionation of lipid classes will provide more reliable dietary 561 indicators. The analysis of FA in polar lipids can inform on nutritional requirements of the study

organism and on environmental conditions prevailing at the time of sampling. Comparing the relative 562 FA proportions in polar and neutral lipids allows the identification of the dietary FA that were 563 selectively retained/eliminated to form cell membranes (e.g. Delaunay et al., 1993; Plante et al., 564 565 2007). The unsaturation level of FA and PUFA incorporated in polar lipids is linked to the <sup>11</sup> 566 temperature in ectothermic organisms (Hazel and Williams, 1990; Hall et al., 2002; Pernet et al., 567 2007) and can be associated with the basal metabolic rate (Hulbert and Else, 1999; Pernet et al., 2008). Consequently, the separate analysis of neutral and polar lipids is a practical approach to 16 568 18 569 address questions on trophic ecology as well as on nutrition and comparative physiology.

570 To establish trophic relationships of species for which all potential food sources are known, a good strategy is to analyse the FA composition of total lipids in food sources (e.g., prey) and of neutral <sub>23</sub> 571 25 572 lipids in consumers to characterise their diet (e.g., predators). Such approach was implemented by the 27 28 573 pioneers of the use of FA as trophic indicators (reviewed in Dalsgaard et al., 2003). Alternatively, <sub>30</sub> 574 when study organisms are both prey and predator, or when predator-prey relationships are not wellknown, we suggest at a minimum analysing FA from both neutral and total lipids. Beyond trophic 32 575 <sup>34</sup> 576 considerations, quantification of lipid classes provides useful information on the physiological 37 577 condition of organisms (Fraser et al., 1989) and the quality of sample preservation through FFA and 39 578 lysophospholipids levels (see section 4).

43 579 5.2

Commonly used separation methods

Storage lipids (SE, WE, TAG, DAG, ALC) and FFA are defined as 'neutral' because they are 47 580 49 581 hydrophobic molecules lacking charged groups, whereas PL are defined as 'polar' because they have a charged hydrophilic head. Neutral and polar lipids can be separated from each other by TLC or by 582 <sub>54</sub> 583 adsorption chromatography using either laboratory packed or commercial prepared silica columns. A simple and widely used protocol for separation of neutral and polar lipids consists of a short column 56 584 <sup>58</sup> 585 of silica prepared in a glass disposable Pasteur pipette plugged with cotton wool (Christie, 1982b). 586 The sample is loaded on the top of the column and washed at low pressure with chloroform (or

dichloromethane) often mixed with methanol, (e.g., CHCl<sub>3</sub>:MeOH, 98:2 v/v) to elute neutral lipids. 587 It can then be washed with acetone to obtain acetone mobile polar lipids, generally dominated by 588 pigments and glycolipids. Finally, a last wash is performed with methanol to yield polar lipids 589 590 dominated by PL. Some PL with lower polarity may elute with acetone, while some glycolipids with <sup>11</sup> 591 higher polarity may elute with methanol. Including an elution step with acetone may not be necessary 592 in non-plant samples as they contain negligible amounts of glycolipids (Christie, 1982b). Yet, the latter step (elution step with acetone) can be useful in deciphering trophic links in deep-sea fishes 16 593 18 594 (Sen Özdemir et al., 2019). Diethyl-ether: acetic acid (98:2, v/v) can be used to recover pigments, 595 prior to elution of glycolipids and PL (Da Costa et al., 2017). Elutent and sample volumes must be adjusted to optimise separation. It is also important to note that hydration of silica changes the 23 596 efficiency of retention through a partition effect between bound water and polar lipids (Christie, 25 597 <sup>27</sup> 598 1982b). The use of silica hydrated with 6% water (m/m) can improve the recovery of polar lipids <sub>30</sub> 599 from marine bivalves (e.g., Marty et al., 1992; Pernet et al., 2006).

Commercially pre-packed columns connected to a vacuum manifold are widely used instead of 32 600 34 601 the manually packed Pasteur pipette (Christie, 1992; Ruiz-Gutiérrez and Pérez-Camino, 2000). This procedure, often referred to as SPE, is time effective and provides similar results as classic column 602 chromatography (Juaneda and Rocquelin, 1985). However, it is difficult to achieve quantitative 39 603 41 604 recovery of PL with this approach. Only  $\sim 62\%$  of total lipids were recovered from clam tissue using SPE due to the selective retention of phosphatidylcholine as silica is not rehydrated in these pre-605 44 46 606 packed columns (Pernet et al., 2006). Commercial SPE columns are available with a wide range of 48 607 chemically-bonded stationary phases. These have great potential for the isolation of specific lipid 50 classes, yet surprisingly few applications have been described to date. For example, an alternative 608 <sub>53</sub> 609 method developed by Kaluzny et al. (1985) using aminopropyl-bonded silica is suitable for separating lipid classes in oyster tissues, though particular care is required to recover the acidic lipids 55 610 <sup>57</sup> 611 quantitatively (Kim and Salem, 1990; Pernet et al., 2006). Aminopropyl bonded phases have also <sub>60</sub> 612 been used to separate groups of lipid classes, including neutral lipids such as cholesterol, and non-

acidic PL, and they are especially useful for the isolation of the FFA fraction from lipid extracts 613 (Kaluzny et al., 1985; Kim and Salem, 1990). 614

#### Practical recommendations 615 5.3

Before starting to use a separation protocol, we recommend reading handbooks describing the use 616 and applications of SPE for lipid separation including the choice of eluting solvents (Christie, 1982b; 617 Perkins, 1991), and to consult technical resources provided by the SPE manufacturers. Specifically, 17 618 care must be taken to avoid sample overload and subsequent cross-contamination. This problem can 619 be avoided by knowing the lipid composition of the sample and the carrying capacity of the column 620 24 621 prior to SPE. The amount of sample that can be loaded onto a column is governed by the proportion 26 622 of the retained lipids. For example, 2 to 5 mg of PL is considered as the maximum load for SPE of neutral and polar lipids on a 100 mg silica column (Christie, 1982b). Although sample overload leads 623 <sub>31</sub> 624 to cross-contamination, an excess of sorbent can also reduce recovery of the retained analytes. It is 33 625 therefore suggested to experimentally determine the sample load (mass ratio of lipid to sorbent) to optimise purity and recovery (Pernet et al., 2006). In order to use the SPE system, we suggest 626 <sub>38</sub> 627 replacing the silica originally contained in the pre-conditioned column with rehydrated silica (generally 6% m/m). 40 628

<sup>42</sup> 629 Purity and recovery analyses after SPE are crucial, particularly when the sample matrix is new to 630 the laboratory and when the stationary phase changes. Different brands or batches of silica gel may vary in their properties and cross-contamination of fractions may occur (Christie, 1982b). Purity can 47 631 49 632 be evaluated by TLC of lipid classes of each eluted fraction. The simplest way to evaluate recovery 633 is to quantify the lipid class content of samples before and after SPE by TLC and proceed with <sub>54</sub> 634 recovery calculation (i.e., the amount of collected lipid after SPE / the amount of lipids before SPE, as a percent). Alternatively, the recovery purity and efficiency can be estimated by adding an internal 56 635 <sup>58</sup> 636 standard of known mass before SPE. As such, lyso-phosphatidylcholine 12:0 (22.8 µg of FA) was 637 added to the lipid extract before SPE to assess PL recovery in oyster samples (Pernet et al., 2006).

Occurrence of 12:0 was exclusively associated to LPC as this FA is absent in ovsters. A full recovery of LPC following SPE on silica indicated that other PL were fully recovered as LPC is the most strongly retained phospholipid on silica (Pernet et al., 2006). To evaluate the purity of each lipid fraction and the absence of cross-contamination, it is necessary to add one standard based on the least neutral lipid which must remain in the neutral lipid fraction, and another one which corresponds to the least polar lipid which must be retained in the polar lipid fraction. For example, commercially available 12:0 diacylglycerol (DG) and 10:0 phosphatidic acid (PA) can be added to the lipid extracts 16 644 18 645 of oysters (F. Pernet unpub. data). Because these two shorter chain FA are naturally absent in oysters, their occurrence was exclusively associated with DG and PA standards. The FA 12:0 and 10:0 were expected in neutral and polar lipid fractions, respectively. Note that these standards do not replace 23 647 the traditional 23:0 used for mass quantification of FA (see section 7). In the case of SPE, 23:0 is 25 648 28 649 generally added directly in the elution tubes to avoid passage in the column as this standard would <sub>30</sub> 650 only be distributed in the neutral fraction.

#### Transesterification 6 652

Except in highly degraded samples, where FFA proportion can reach high values, FA are generally 653 654 part of more complex lipid molecules, and are linked to glycerol by an ester linkage (e.g., TAG, PL, glycolipids). Therefore, one approach to analyse FA by gas chromatography (GC) is to hydrolyse the 655 ester linkage and to convert the released non-volatile FA into their volatile derivatives, usually FA 656 16 657 methyl esters (FAME). Saponification followed by methylation is the classical method for preparing 18 658 FAME, and while laborious, it produces FAME without contamination with unsaponifiable lipid 659 compounds (e.g., non-volatiles, sterols, alcohols, hydrocarbons, phthalates and pigments). However, most researchers use transesterification. A number of transesterification methods exist, all based on 660 the presence of excess methanol, a catalyst (acid or base) and heat (see Schlechtriem et al., 2008). To 25 661 27 28 662 be analysed by GC, FAME are then extracted in a GC compatible solvent (often hexane), and the organic phase is washed several times by water to remove acid and glycerol. Produced FAME are 663 stable for months at 4 °C in the dark under nitrogen. Transesterification using ethanol instead of 32 664 665 methanol is also possible, but less used, leading to the formation of FA ethyl esters. Butanol can also be used as a substitute to methanol to quantify very short chain FA (down to *iso*5:0) by increasing 666 aliphatic chain length (Koopman *et al.*, 1996, 2003). Although the use of the boron trifluoride ( $BF_3$ ) 39 667 41 668 has been recommended by the AOCS (1989), many catalysts can be used in both acid- and basecatalysed transesterification, with each method having their own advantages and limits. 669

45 <sub>46</sub> 670 The efficiency of these transesterification methods differs as a function of the bound between the 47 48 671 aliphatic chains and the glycerol or sphingosine backbones (Christie and Han, 2010). This is 49 <sup>50</sup> 672 particularly important in aquatic samples because, depending on the matrix, a considerable part of 51 52 53 673 these aliphatic chains can be linked to the entire lipid molecule not by an ester linkage, but by a vinyl-54 55 674 ether (e.g., plasmalogens), an ether (e.g., alkyl lipids) or an amide (e.g., sphingolipids) linkage. It is 56 <sup>57</sup> 675 thus important to choose the most pertinent transesterification method with respect to the sample 58 59 59 60<sup>676</sup> nature and the scientific question. For example, the acid-catalysed transesterification of plasmalogens

leads to the formation of FAME (from the acyl lipids) and dimethyl acetals (DMA) (from vinyl-ether 677 lipids). DMA are mainly detected in polar lipids but are marginally present in neutral lipids, reflecting 678 the contribution of glyceride ether also named "neutral plasmalogens" (TAG containing at least one 679 680 vinyl ether bound aliphatic chain). Base-catalysed transesterification of these molecules only leads to 10 11 the formation of FAME, leaving vinyl ether bound aliphatic chains unreacted (Crackel et al., 1988; 681 12 13 682 Cruz-Hernandez et al., 2006). However, attention needs to be paid to the particular procedure 14 15 16 683 followed, as base-catalysed transesterification based on ISO standard methodology incorporates an 17 18 684 acid wash to neutralise the catalyst. This acidic wash may lead to DMA formation (Gomez-Cortes et 19 20 al. 2019). Moreover, neither acid- nor base-transesterifications have any effect on ether linkages 685 22 (Christie 1989). This point is important to consider when analysing samples containing large amounts 23 686 24 of alkyl ether lipids, such as alkylglyceryl ether lipids in shark liver oil. Transesterification of FA 25 687 26 27 28 688 sphingolipids components is acid-catalysed and is achieved by increasing the reaction time (Eder, <sub>30</sub> 689 1995; Le Grand et al., 2011). Finally, esterification of FFA is only possible by acid-catalysed transesterification (Christie, 2003). 32 690 33

691 Depending on the scientific question (e.g. nutritional value, trophic relationships, physiological responses), FA transesterification can be realised directly on the biomass (direct transesterification), 692 on a total lipid extract or on lipid fractions, such as polar or neutral lipids, lipid classes (e.g., TAG, 39 693 41 694 phosphatidylcholine) or lipid subclasses (e.g., phosphatidylethanolamine plasmalogen) isolated beforehand. It can be useful to purify FAME by HPLC or TLC before GC injection (Marty et al., 695 1992). This prevents the saturation and the degradation of the column through the injection of non-46 696 48 697 FAME molecules (e.g. non-volatiles, sterols, hydrocarbons, phthalates, pigments) and thus increases <sup>50</sup> 698 its lifespan. Obtained chromatograms are also "cleaner" (no contaminants) and easier to identify.

54 699 Boron trifluoride (BF<sub>3</sub>) 6.1

<sup>58</sup> 700 The Lewis acid boron trifluoride (BF<sub>3</sub>) in methanol (12-14%, w/v) is a powerful acidic catalyst for 59 60 701 the transesterification of FA. In general, 800 µL to 1 mL of BF<sub>3</sub>-MeOH (12-14%, w/v) is added to a dry lipid extract containing a maximum of 1-4 mg of lipids (Liu, 1994; Carrapiso and García, 2000; Le Grand *et al.*, 2011). This method is fast and efficient (Morrison and Smith, 1964; Carrapiso and García, 2000; Cavonius *et al.*, 2014), and it has been successfully used on marine lipid samples where almost all the lipid classes, including FFA and plasmalogens, were transesterified in 10 min at 100 °C (Le Grand *et al.*, 2011; Cavonius *et al.*, 2014). For the sphingolipids, such as sphingomyelin and ceramide aminoethylphosphonate, the transesterification should be prolonged and last for 1.5 h to 5 h at 100 °C (Eder, 1995; Le Grand *et al.*, 2011).

Heating is generally conducted in a dry bath, water bath or heat block. The higher the temperature used, the shorter the reaction time. An increase in reaction time has no negative effect, provided that no evaporation occurs (Morrison and Smith, 1964). Presence of residual water in the sample limits the acid-catalysed esterification by  $BF_3$  (Sattler *et al.*, 1991). It is thus necessary to dry the sample by either nitrogen evaporation or by addition of anhydrous sodium sulphate (Molnar-Perl and Pinter-Szakacs, 1986).

Because evaporation during the transesterification leads to acid concentration, which degrades FA and especially PUFA (Lough, 1964), it is crucial to prevent vial caps from unscrewing when heating samples (Morrison and Smith, 1964). Poor storage conditions and quality of BF<sub>3</sub> cause PUFA degradation (Morrison and Smith, 1964; Christie, 1993). It is recommended to use fresh reagent and to store it at 4 °C or colder (-20 °C). Despite these issues, the use of BF<sub>3</sub>-MeOH for transesterification was referenced as an official method (AOCS, 1973; IUPAC, 1979) and Ackman (1998) showed that issues could be avoided following simple rules. Yet, the potential PUFA degradation induced by using BF<sub>3</sub> as a transesterification catalyst, the difficulty in purchasing guaranteed anhydrous BF<sub>3</sub>-MeOH, its high cost and its high toxicity have led to a decreasing use of this reagent (Liu, 1994; Carrapiso and García, 2000; Cavonius *et al.*, 2014). In samples containing very high levels of storage lipids, such as salmon flesh, copepod oil and cod liver, the derivatisation efficiency can be quite low, leading to small but significant differences in some FA proportions (Schlechtriem *et al.*, 2008). For these reasons, BF<sub>3</sub> is no longer recommended as an acidic catalyst in the preparation of FAME.

Acidic alternatives to BF<sub>3</sub> 728 6.2

A number of alternatives to Lewis acids have been employed (Christie, 1982a). Methanolic HCl (3 729 N) appears to be the most commonly used reagent for transesterification of lipid-bound FA to FAME 730 11 731 in lipids from freshwater plankton (von Elert, 2002; Martin-Creuzburg et al., 2012; Windisch and Fink, 2018), but also from marine plankton (e.g., Troedsson et al., 2005). It can easily be produced 732 by adding 24 ml acetyl chloride to 100 ml of methanol, which leads to the formation of 10% (approx. 733 18 734 equivalent to 3 N) methanolic HCl. H<sub>2</sub>SO<sub>4</sub> is often recommended (Christie, 1982a; Budge et al., 2006), as it can easily be prepared by mixing a small amount of concentrated H<sub>2</sub>SO<sub>4</sub> (~98%) in 735 736 methanol to achieve a 1% solution (Schlechtriem et al., 2008).

The most commonly used acid catalysed reagents, such as HCl or H<sub>2</sub>SO<sub>4</sub>, are not associated with issues described for BF<sub>3</sub>. А number of comparisons of acid the catalysts for esterification/transesterification have been made (e.g. Medina et al., 1992; Budge and Parrish, 2003; Thiemann et al., 2004; Carvalho and Malcata, 2005), with no clear consensus on optimal methods. The best advice is likely to select a method and consistently apply it. As with BF<sub>3</sub>, caution is needed during heating to prevent evaporation.

#### 6.3 **Basic alternatives**

Several basic catalysts are available (e.g., NaOH, KOH) to transesterify acyl lipids. While a range of 744 procedures have been described (e.g. Christie, 1982a; Medina et al., 1992; Velasco et al., 2002), most 745 are very similar to the acid catalysed method described above with the substitution of the catalyst and 49 746 747 the introduction of an additional step after the reaction is quenched to neutralise the remaining base. 748 All base-catalysed transesterifications proceed very rapidly at room temperature (Christie, 1982a), 56 749 thereby preserving labile structures (i.e., epoxides, conjugated double bonds) that are often destroyed <sup>58</sup> 750 with harsher acid catalysts. This 'gentler' transesterification is the primary motivation for use of basic 751 catalysts. As noted above, basic-catalysts are unable to esterify FFA so these approaches should only

be used when one can be confident that FFA are present in very low amounts, or else when the analystis targeting esterified FA exclusively (e.g., studies on membrane lipids or storage lipids).

Finally, there are a number of official and approved methods that employ combined approaches, using both basic and acidic catalysts (e.g., AOCS, 1989). While at least one of these methods (i.e., AOAC 969.33-1969, 1997) describes the procedure as first saponification with NaOH, followed by methylation with  $BF_3$  in methanol, the short reaction time with NaOH in methanol is actually an alkali-catalysed transesterification, followed by acid-catalysed methylation of any FFA that remain (Ackman, 1998). Although direct acid-catalysed transesterification is sufficient for a typical aquatic lipid if performed with sufficient time and heat, the alkali-catalysed step may persist because of its adoption by official bodies (Ackman, 1998).

e 6.4 Direct transesterification

The standard procedure for determining FA profiles (e.g. extraction to isolate lipids, followed by transesterification to yield FAME), can be labour-intensive and increases analytical cost. In some cases, studies are only interested into the FA composition of total lipids in samples and therefore perform a direct one-step transesterification that considerably reduces the analytical time (Lewis *et al.*, 2000). This method is realised directly on the sample, and differs from the classical transesterification by the elimination of the lipid extraction step (Lewis *et al.*, 2000; Castro-Gómez *et al.*, 2014; Parrish *et al.*, 2015a).

Different methods have been tested and provided reproducible and similar results to the classical extraction-transesterification method (Castro-Gómez *et al.*, 2014; Parrish *et al.*, 2015a). Careful consideration is needed when using this approach as it may not be appropriate to the study goal and/or the matrices analysed. It may also be preferentially applied to small and homogenous (representative of the whole) samples. For example, while it is possible to carry out direct analyses on a small amount of tissue, accurate determination of total blubber FA composition in marine mammals was not possible with this approach due to significant variation in FA composition within the layers of the blubber (Thiemann *et al.*, 2008). Although this rapid direct transesterification approach is less timeconsuming and cheaper, once the entire sample is transesterified, it is not possible to redo the analysis,
or to analyse the FA composition of different lipid fractions.

## 780 6.5 Alternatives to hexane

Hexane, iso-hexane (2-methyl-pentane), or iso-octane are most frequently used to recover FAME after transesterification and before injection. However, hexane is carcinogenic, mutagenic and reprotoxic, and is a hazardous airborne pollutant. Less toxic solvents such as pentane and heptane can be used as alternatives to hexane (Alfonsi *et al.*, 2008). However, recovery of FA from macroalgae is lower with heptane than with hexane, with PUFA tending to be more affected than SFA and MUFA (Le Grand unpub. data). This preliminary result needs to be verified on other matrices. Pentane rather than hexane may also be used as the solvent in the BF<sub>3</sub>/MeOH procedure to reduce the reaction temperature from 85-100 °C to 80 °C to decrease artefact risk (Parrish, 1999).

#### Analysis of fatty acids 7 789

The full process of FAME analysis consists of injection, separation, identification and quantification 790 791 of FAME and each of these steps has to be optimised to achieve high accuracy and precision (see Eder, 1995; Christie, 2003 for review). Gas chromatography (GC) with flame ionisation detection 792 793 (FID) is generally the preferred method for the quantification of FAME in aquatic samples. GC-MS 16 794 methods for FAME quantification can be advantageous on a routine basis when spectrometric 18 795 confirmation of compound identity is required. This is especially useful for complex samples 796 containing contaminants, artifacts or co-eluting compounds. Although these methods compared satisfactorily with GC-FID, they are more complex and tedious to implement and calibrate. Such 797 approaches also require stronger chemistry / spectrometry backgrounds of the user and greater routine 25 798 <sup>27</sup> 799 . P.J.C. maintenance of the instrumentation.

#### 31 800 7.1 Injection

<sup>35</sup> 801 Sample injection is a critical step to achieve high accuracy in FAME analysis and we encourage readers to refer to seminal papers of Konrad Grob for a thorough overview of available techniques 802 40 803 (e.g., Grob, 2007). There are currently three injection techniques. Before being transferred into the 42 804 capillary column, the sample can be (i) evaporated in a permanently hot vaporising chamber (classical vaporising injection), (ii) injected into a cool chamber which is subsequently heated to vaporise the 805 47 806 sample (programmed temperature vaporising injection, referred to as PTV), or (iii) directly injected 49 807 into the column inlet (direct injection or on-column).

Once vaporised, the sample can be split (i.e., split injection) with only a small part of the vapour 808 54 809 entering the column while the rest is vented. This is the most appropriate technique for concentrated samples (e.g., Shantha and Ackman, 1990). Alternatively, the whole vaporised sample is transferred 56 810 <sup>58</sup> 811 from the injector to the column without splitting of the sample (i.e., splitless injection). This technique 812 is particularly appropriate for trace analysis. The major drawback of the split or splitless injection

techniques is the possible discrimination between high- and low-boiling compounds in the sample. 813 Fatty acids in aquatic samples have a wide range of boiling points and quantification may require 814 application of relative response factors (Grob, 2007). On-column injection avoids discrimination of 815 816 FA and therefore provides the best results. Yet, a large number of aquatic scientists use the vaporising <sup>11</sup> 817 injection method for suitability and flexibility reasons. High-speed injection, high injector 818 temperature (> 220 °C) and proper injector inserts all contribute to decreasing discrimination problems. However, we recommend regular checks of FAME discrimination factors using certified 16 819 18 820 reference mixtures (e.g. Supelco 37).

Upon injection, FAME are transferred into a wall-coated open tubular (WCOT) capillary column 26 822 allowing separation according to their carbon number, the number and location of the double bonds, 823 <sub>31</sub> 824 and the cis-trans configuration. The column is located in an oven and exposed to temperature ramps ranging from 60 °C to 300 °C (e.g. Tang and Row, 2013 for examples of temperature ramping). The 33 825 <sup>35</sup> 826 carrier gas is generally helium or hydrogen. The resolution capability of the column depends on 38 827 several factors such as polarity of the stationary phase, column length, internal diameter and film thickness. In view of its importance, this information should be reported in detail in the method 40 828 42 829 description of any study.

44 830 Based on the type of FA being investigated, one of the most important steps is the selection of the 45 46 stationary phase of the column which influences elution times of FAME, especially PUFA. The 47 831 48 49 832 polarity of the column ranges from non-polar to extremely polar. On non-polar columns, the elution 50 51 time generally increases with increasing boiling points of analytes. Therefore, the elution time of 833 52 53 54 834 FAME increases with chain length and with decreasing unsaturation (e.g., 18:2n-6 elutes first, 55 followed by 18:1*n*-7, and then by 18:0). The major drawback with non-polar columns is that some 56 835 57 <sup>58</sup> 836 FA isomers (cis-trans) or FA pairs may co-elute. Conversely, non-polar columns exhibit low bleed, 59 60 837 long lifetime, retention time stability and high temperature resistance (to 360 °C), which makes their

use suitable for a large range of compounds. These columns are well-suited for separating neutral
compounds such as sterols, alkenones, hydrocarbons. Commonly used non-polar columns are made
of 100% dimethylpolysiloxane or 5% phenyl-95% dimethylpolysiloxane.

Many researchers use polar columns which allow for a better separation of aquatic FA than nonpolar phases, with only some rare and minor co-elutions. Ackman (1986) was a strong advocate of the polyethylene glycol (PEG) phase. Columns coated with PEG are easily recognisable because of their commercial name with the suffix "wax". With this polar phase, FAME continue to elute in order of increasing boiling point, but also roughly in order of increasing numbers of double bonds. However, polar columns are highly sensitive to temperature (max 250 °C), water and oxygen, and are thus less stable over time than non-polar columns. Retention times may also vary (decrease) over time, especially for highly unsaturated compounds. Consequently, peak identification (based on elution time) needs to be checked regularly and rigorously.

An alternative phase consists of substituting 50% dimethylpolysiloxane (non-polar) with the polar cyanopropylmethyl (e.g., Iverson *et al.*, 2004; Pedro *et al.*, 2019). This phase provides similar resolution as PEG phases, although it is much less sensitive to oxygen, resulting in longer column lifetimes. The chemistry of this phase is more influenced by temperature than other polar columns. Separation of co-eluting peaks can sometimes easily be achieved simply by subtle adjustments to oven temperature ramps.

56 7.3 Identification

The most common way to identify FAME by GC-FID analysis is to compare their retention times with those of commercially-available individual purified standards. Among the most used standards for the FA identification in aquatic samples, there are PUFA No. 3, a complex qualitative standard mixture extracted from Menhaden oil, and Supelco® 37 Component FAME Mix, a comprehensive mixture of 37 FAME ranging from 4:0 to 24:1*n*-9. Several long-chain and (highly) unsaturated FAME occurring in some samples are not commercially available, but can be identified using fully

characterised natural products (e.g., the non-methylene interrupted fatty acids typical of marine 863 molluscs in Zhukova and Svetashev, 1986; Ackman, 1989; Kraffe et al., 2004). 864

In addition to these protocols, confirmation of FA identification is best achieved using GC-mass 865 866 spectrometry (GC-MS). Peak identification is achieved using commercial spectral libraries (e.g. The LipidWeb <http://lipidhome.co.uk>), or via personal/laboratory FA mass spectral libraries to assist 867 868 in identification of often complex environmental FAME samples. Further details on various GC-MS protocols together with specific MS information are available in Christie (1989). Briefly, the base 16 869 18 870 peak at m/z 74 is termed the McLafferty rearrangement ion, and is formed by cleavage of the parent 871 FAME molecule beta to the carboxyl group. Where chemical ionisation is used, the mass spectra have a more prominent quasi-molecular ion (MH<sup>+</sup>), and minor ions only at  $[MH - 32]^+$  and [MH -<sub>23</sub> 872 32 - 18]<sup>+</sup>. Because all FA will have the carboxylic acid (or ester) functionality in common, 25 873 27 28 874 knowledge of the molecular mass is particularly valuable in determining basic structure with respect <sub>30</sub> 875 to numbers of carbon atoms and double bonds. There are unfortunately generally no characteristic ions that indicate the position or geometry (i.e., *cis-trans*) of double bonds in positional isomers of 32 876 <sup>34</sup> 877 monounsaturated and polyunsaturated FAME (Christie, 1989).

37<sup>878</sup> Where hydroxyl groups are present on the FAME, conversion of the hydroxyl group to a trimethyl 39 879 silvl (O-TMSi) ether or other derivative is generally used. Bistrimethylsilvltrifluoroacetamide 41 880 (BSTFA) is a useful reagent to accomplish this. The high polarity of the free hydroxyl group is reduced by formation of the O-TMSi ether, thereby enhancing the chromatography of the derivative. 881 <sub>46</sub> 882 Fragmentation of the OTMSi derivative occurs alpha to the carbon containing the hydroxyl group, 48 883 with the main cleavage on the side adjacent to the carboxyl group.

<sup>50</sup> 884 Derivatisation protocols have been developed to provide more detailed position of double bonds 51 52 53 885 or geometry information. These include, for example, use of pyrrolidine, 3-pyridyl carbinol (picolinyl 54 ester), dimethyl disulphide (DMDS) and 4,4-dimethyloxazolazine (DMOX) derivatives. An 55 886 56 <sup>57</sup> 887 advantage of the use of the DMOX protocol is that the FAME and their corresponding DMOX 58 59 60 888 derivatives have the same elution order when run on the same GC column. PUFA DMOX derivatives

can be readily formed using the protocols described in Svetashev, 2011 and Lee Chang *et al.*, 2016. Interesting examples of application of the DMOX protocol have been the characterisation of a novel series of  $C_{18}$  to  $C_{22}$  *trans* n-3 PUFA from a marine haptophyte (Lee Chang *et al.*, 2016) and the 22:4n-9t in scallop (Marty *et al.*, 1999). MUFA double bond position and geometry is readily determined by capillary GC-MS of their DMDS derivatives (Nichols *et al.*, 1986). An example of application of the DMDS protocol has been the characterisation of a range of novel  $C_{16}$  and  $C_{18}$  MUFA, including both *cis* and *trans* isomers, from microbial monocultures and complex soil consortia (Nichols *et al.*, 1986). Other derivatisation procedures are also available, although they are not covered here, and are as detailed in Christie (1989).

7.4 Quantification

In GC-FID analyses, the response intensity is based on the number of oxidisable carbon atoms in the analyte; equivalent masses of FA having different carbon chain lengths and/or numbers of double bonds will not produce the same response in the FID (Ackman, 1972). FAME are usually quantified by peak areas, and absolute concentrations are determined by adding an internal standard. Discrimination of FAME may be associated with injection technique and it is often necessary to introduce empirical response factors, determined through careful use of commercially available authentic mixed standards (see section 7.1). A way to estimate the importance of bias from different origins (such as injector, or detector) is for example to analyse a FA mixture of known theoretical mass composition such as the Supelco® 37 Component FAME Mix. It is also possible to analyse a phospholipid with two different aliphatic chains, of different length and saturation (e.g., phosphatidylcholine 16:0/22:6*n*-3) and confirm that the molar percentage of each FA is 50/50.

The internal standard must not coelute with the FAME, its chemical structure must be close to the majority of the FAME and it must be absent from the sample. A known mass of internal standard should be added either after SPE or before transesterification to account for derivatisation yield and recovery of FAME (see section 5). The most widely used standards are the carboxylic form of

nonadecanoic acid (19:0), heneicosanoic (21:0) and tricosanoic acid (23:0). Data are generally 914 expressed as relative (area %, mass % or mole %) or absolute contents (e.g., mg FA g<sup>-1</sup> sample dry 915 916 mass).

917 With GC-MS analyses, one approach is to use the total ion chromatogram (TIC) in a similar <sup>11</sup> 918 fashion as peak area is used with GC-FID, by comparing the peak area of an internal standard with 13 14 919 peak areas of compounds of interest, and relative response factors determined individually using authentic standards. Note here that response factors vary with structure (carbon and unsaturation 16 920 18 921 numbers, mostly notably), ionisation methods (electronic vs chemical) and mass detector (e.g. <sup>20</sup> 922 Quadrupole vs ion trap) (Dodds *et al.*, 2005; Quehenberger *et al.*, 2011). Consequently, the range of response factors is greater in MS than with FID. Response factors for FA, where standards are not <sub>23</sub> 923 25 924 available, are assumed the same as those of structurally similar and available compounds but this is arguable.

For greater sensitivity, calibration can be based on prominent ion(s) using selected ion monitoring (SIM) as a single ion can be scanned many more times in a cycle than the full mass spectrum, giving a higher signal to noise ratio (Dodds et al., 2005; Thurnhofer and Vetter, 2005; Quehenberger et al., 2011). It involves the exclusive acquisition of a group of selected ions during a given period if the identity and retention time of a given analyte have been established through full scan mode. Since fragmentation can vary depending on chain length and degree of unsaturation, careful assignments of selected ions group to analytes and appropriate adjustments of SIM parameters are necessary to achieve accurate quantification and complete discrimination when some FA are coeluting.

Quantification of FA can be further improved by using mixtures of isotopically-labelled FA 53 936 internal standards (e.g. deuterated FA). These offer the advantage of being identical to the analyte of 55 937 interest in all aspects except mass, so that response, as well as matrix effects, of the labelled and 57 938 unlabelled component are the same (Quehenberger et al., 2011). The main limitation to this approach

As emphasised by the previous sections, obtaining reliable FA data can be a long and complex 942 943 process. The purpose of this section is therefore to offer guidance in how to valorise these hard-earned 11 944 data in the best possible way, and to use them to shape robust answers to a wide range of scientific questions. As environmental phenomena are inherently complex, a single variable rarely depicts them 945 16 946 in a satisfactory way (Buttigieg and Ramette, 2014). Moreover, FA studies typically deal with datasets 18 947 containing many variables (i.e., individual FA). This section will therefore mostly focus on 948 multivariate analysis. Readers looking for guidance about univariate tests and procedures are <sub>23</sub> 949 encouraged to refer to other publications (e.g. McDonald, 2014).

After adequate standardisation and/or transformation (section 8.1), FA data can be analysed in 25 950 27 951 28 different, non-mutually exclusive ways. Unconstrained ordination methods (section 8.2) can help visualising the data, and finding out which samples group together according to their similarity in FA composition. In doing so, they allow determining how similar to one another entities such as sampling 32 953 <sup>34</sup> 954 locations (Hughes et al., 2005; Parrish et al., 2015b), habitats (Hixson et al., 2015) or species (Sardenne et al., 2016) are. These exploratory methods are adequate to identify patterns between 955 samples, as well as FA markers responsible for these patterns. Conversely, investigators can be 39 956 interested in assessing the influence of one or several previously identified factors on FA composition, 41 957 <sup>43</sup> 958 e.g. to explicitly test whether FA composition is different across multiple experimental treatments, 46 959 ecological conditions, or species. This can be done through hypothesis testing and/or constrained 48 960 ordination (section 8.3).

<sup>50</sup> 961 Regardless of the data analysis approach, FA studies commonly rely on "biomarker compounds", 51 52 53 962 i.e., FA (or combinations of FA) whose origin can be assigned to a biogeochemical process, an 54 55 963 ecosystem compartment and/or an organism group. When doing so,, it is important to remember that 56 <sup>57</sup> 964 there are no ubiquitous FA biomarkers, and that their applicability will depend on the studied system 58 59 ر 60<sup>965</sup> or organism (e.g., Feiner et al., 2018). To avoid interpretation biases, biomarker compounds should

be chosen carefully with respect to the ecological context and scientific question of interest. When 966 used sensibly, biomarker compounds can be very useful, as proven by their routine use in ecological 967 literature (see Dalsgaard et al., 2003; Kelly and Scheibling, 2012 for review). 968

969 8.1 Standardisation and transformation

15 970 Choosing standardisation or a prior transformation method for FA data needs to be based on the research questions, as it can have important impacts on the final results and interpretations (Mocking 17 971 et al., 2012). FA can be expressed as either an absolute content or mass fraction, such as mg.g<sup>-1</sup> of <sup>19</sup> 972 lipids or of tissue, or as relative proportion (%) of total FA mass or molar concentration. 973 24 974 Concentrations are commonly used in nutrition studies, and can be useful in controlled feeding experiments (Elsdon, 2010). Proportions of total FA mass is the commonly used standardisation 26 975 <sup>28</sup> 976 method in trophic studies. It avoids occultation of compositional differences in FA profiles by <sub>31</sub> 977 removing the influence of non-FA components from both the lipid fraction (e.g., polar vs neutral 33 978 lipids) and the total lipid contents of tissues. Yet, proportion data are generally calculated in relation <sup>35</sup> 979 to identified FA in a sample, which vary across studies and FA analysis methodologies, limiting inter-38 980 study comparison.

Choice of data standardisation is interdependent with the choice of data transformation method (if 40 981 42 982 needed) and of applied statistical test (univariate vs. multivariate tests). FA data transformation can be recommended in some cases (e.g., Kelly and Scheibling, 2012), but the overall effect of the 983 procedure is highly variable (Happel et al., 2017). Deciding on a transformation method depends on 47 984 49 985 the test used and its assumptions (e.g., normal distribution of data, homoscedasticity). Although these 986 assumptions can be met for univariate analyses (that test the effect of one or several factors on 54 987 individual FA), this is rarely the case for multivariate analyses using large FA datasets, even after transformation (Budge et al., 2006). However, multivariate methods such as unconstrained 56 988 <sup>58</sup> 989 ordinations (e.g., principal component analysis, see below) give useful and adequate results when the 990 data are properly transformed (e.g., Legendre and Gallagher, 2001). Moreover, proper testing

procedures through permutations allows one to circumvent the violation of the multivariate normality assumption in constrained ordination methods such as redundancy analysis (RDA, Legendre and Legendre, 2012; see subsection 8.3).

Kelly and Scheibling (2012) reviewed some of the most common data transformation methods used in FA studies, including log-ratio (Budge *et al.*, 2006), arcsine and logit transformations. Arcsine transformation has been widely applied to transform proportional FA data, yet its use in biological analysis has been challenged in some studies. Warton and Hui (2011) suggested that applying logistic regression is more appropriate to transform proportion data. It is also important to note that some transformations such as log(x) or log(x+1) will give more weight to rare (i.e., found in small amounts) FA, while reducing the influence of the abundant FA (Happel *et al.*, 2017). Depending on the study objectives, it is essential to identify clearly whether the scientific question requires emphasising the presence and the role of rare FA, or if focusing on the dominant FA will give a more global pattern within and across organisms.

004 8.2 Exploring fatty acid data through ordination

Ordination methods are essential to describe and visualise sample dispersion in a complex multidimensional dataset, and to identify groups of co-varying variables. Those are computed based on a matrix of resemblances (distance, dissimilarities, similarities), or derived ranks, rather than raw (or transformed) data. In FA literature, the most commonly used resemblance measure between samples are either the Euclidean distance or Percentage difference (also called Bray-Curtis dissimilarity; Legendre and Legendre, 2012). Euclidean distance is generally preferred over Bray-Curtis for FA analysis (Happel *et al.*, 2017). However, just like data transformations, the choice of the resemblance measure can have important impacts on the final results. The choice of matrix will depend on whether a dataset includes null/absent values and if they need to be included in the analysis according to the study question. The Percentage difference coefficient is double-zero asymmetric, i.e. the absence of one FA from two individuals is not considered as contributing to their similarity. The

Euclidean distance, on the contrary, is double-zero symmetric, i.e. will be affected by double null 2 1016 1017 values (Legendre and Legendre, 2012). Other properties of resemblance measures should also be 1018 considered. Choice of the resemblance coefficient has received extensive attention in multivariate community ecology (e.g., Legendre and Legendre, 2012).

Commonly used methods to plot ordinations include principal components analysis (PCA), 13 14<sup>1021</sup> principal coordinates analysis (PCoA) and non-metric multidimensional scaling (nMDS). PCA can only use Euclidean distance, while PCoA and nMDS can use any resemblance measure. PCoA and 161022 181023 nMDS use the ranks of similarities or dissimilarities matrix to find a spatial arrangement of 20 21 individuals and represent relationships among them (Kelly and Scheibling, 2012). NMDS is conceptually simple, generally applicable, and well adapted to ecological data (Clarke and Warwick, 231025 251026 2001). However, it is crucial to take into account the stress coefficient, which is measured from the <sup>27</sup>1027 28 relationship between ranks of dissimilarities and ranks of sample distances on the plot. A high stress 29 30<sup>1</sup>028 score (> 0.05) indicates that data have been highly distorted to fit in the visualisation, which may not be representative and should be considered with caution (Clarke and Warwick, 2001; Buttigieg and 321029 <sup>34</sup>1030 35 Ramette, 2014). PCA also describes relationships among samples, reducing large numbers of 36 37<sup>1031</sup> variables to a few components that represent most of the variance and that are built by combining 391032 correlated variables (Budge et al., 2006; Kelly and Scheibling, 2012). It also helps to visualise 411033 variables that contribute the most to the dissimilarity among observed groups and FA that are highly 43 44 1034 correlated (Budge et al., 2006). After ordination, several procedures (similarity percentage, also 46<sup>1035</sup> called SIMPER, analysis; comparison of PCA loadings) can be applied to identify FA driving resemblance or dissimilarity among groups (Clarke and Warwick, 2001). 481036

Multivariate hypothesis tests and modelling 8.3

Multivariate analyses are commonly applied in ecological studies to discriminate the influence of 561038 <sup>58</sup>1039 different factors on FA composition, such as physiological, spatial or even temporal variations 60 1040 (Anderson, 2001). Statistical comparison of groups based on FA composition is generally performed

through non-parametric or randomisation procedures, as FA datasets rarely match the prerequisites 2 1041 1042 of parametric statistical tests (Anderson and Walsh, 2013). Analysis of similarity (ANOSIM; Clarke, 1043 1993) or permutational analysis of variance (PERMANOVA; Anderson, 2001) are among the most 9 1044 commonly used statistical tests (e.g. Hughes et al., 2005; Hixson et al., 2015; Parrish et al., 2015; 10 <sup>11</sup>1045 Sardenne et al., 2016; Mathieu-Resuge et al., 2019). ANOSIM uses ranks of pairwise dissimilarities 12 13 14<sup>1046</sup> and generates its own statistic by randomisation of rank dissimilarities (Clarke and Warwick, 2001). 15 161047 PERMANOVA tests for differences among group centroids (Anderson, 2001). Both methods are 17 181048 affected by dispersion heterogeneity, with ANOSIM being more sensitive than PERMANOVA 19 20 21 (Anderson and Walsh, 2013). PERMANOVA is unaffected by differences in correlation structure 22 and seems more powerful to detect changes in FA composition. As such, applying ANOSIM is 231050 24 251051 appropriate for a 1-way test (e.g. to compare one species submitted to different diets), but not for 26 <sup>27</sup>1052 28 more complex study designs (Kelly and Scheibling, 2012).

29 30<sup>1053</sup> Besides hypothesis testing, constrained ordination (e.g., redundancy analysis, RDA) offers a way to extract and summarise variability from a multivariate dataset (FA data) that can be explained by 321054 <sup>34</sup>1055 35 one or a set of explanatory variables (e.g., locations, species, diets, etc.). In other words, it allows 36 37<sup>1056</sup> regression of multiple response variables (FA) on multiple explanatory variables (chosen according 391057 to the scientific question). 491060 When tackling elaborate ecological questions, combining FA with other tracers has proven to be very 50 <sup>51</sup>1061 52 powerful. Tracers commonly combined with FA include stable isotope ratios of light biogenic 53 541062 elements (Kharlamenko et al., 1995, 2001; Nyssen et al., 2005), as well as contaminants (Kainz and 55 561063 Fisk, 2009; Le Croizier et al., 2016). In many cases, those combinations are qualitative. However, 57 <sup>58</sup>1064 modern data analysis frameworks allow quantitative coupling of stable isotope and fatty acids in 59 60 1065 mixing models (Stock et al., 2018) or ecological niche models (Jackson et al., 2011; Sardenne et al.,

1 2 1066 3	2016). Such developments hold great promise for ecological research, due to the complementarity of
4 5 1067	these two methods. More generally, multiple factor analysis (Pagès, 2014) or co-inertia analysis (Dray




Figure 1. Workflow for the analysis of fatty acids in aquatic samples. The star symbol indicates recommended methods. Dashed arrows point to suggested storage precautions after each analytical step. Transport requirements are color-coded, and the coldest transport temperature is always the best option regardless of the step. The grey syringe symbol represents the step at which the internal standard for recovery and purity should be added. The black syringe symbol represents the step at which the internal standard for quantification should be added.

<sup>5</sup> 1072 The use of FA analysis in trophic ecology, aquatic nutrition and aquaculture research and , 8 1073 development holds considerable promise to improve our understanding of the natural world from 101074 organism taxonomy and physiology to ecosystem functioning. However, the application of this 121075 approach needs to be carefully considered when initiating a new study to ensure that interpretations 14 15<sup>1076</sup> proposed for FA data are relevant and appropriate. Although protocols for lipid analysis are well-16 1*7*1077 described, their application to aquatic sciences often requires modifications to adapt to field 191078 conditions and to sample types. Here, we presented the current state of knowledge on methods <sup>21</sup>1079 22 dedicated to aquatic lipid analyses, from sampling to data treatment. We reviewed sample 23 24<sup>1080</sup> preservation, storage and transport protocols and their effects on lipids, lipid extraction methods, 25 261081 separation of polar and neutral lipids, transesterification and quantification techniques, and available 27 <sup>28</sup>1082 tools for treatment and statistical analysis of FA data. A simplified flowchart of all these steps is 30 31<sup>1083</sup> represented in Figure 1.

Lipids can be degraded by hydrolysis or oxidation at each stage of the lipid analysis process. We 331084 34 351085 thus encourage processing samples at low temperature under nitrogen atmosphere, and reporting 36 <sup>37</sup>1086 38 hydrolysis indicators. To limit possible deleterious effects, samples should be handled at the lowest 39 40<sup>1</sup>087 suitable temperature before direct extraction, or be immediately frozen for storage, ideally at -20 °C 41 for less than one month, -80 °C for less than 6 months or under liquid nitrogen with no time limit. 421088 43 <sup>44</sup>1089 45 Long-distance transport of samples must be planned well ahead of the start of the study to obtain 46 47</sub>1090 relevant import/export permits and to choose appropriate transportation to maintain sample viability 48 and respect transport regulations and national laws. When possible, we recommend transporting 491091 50 <sup>51</sup>1092 52 samples freshly frozen under a nitrogen atmosphere. Depending on the objectives of the study. <sup>53</sup> 54<sup>1093</sup> samples can be either directly transesterified or undergo extraction to isolate lipids. Lipid extraction 55 561094 is usually performed following well-established methods using either chloroform or dichloromethane 57 581095 (less toxic), mixed with methanol. We strongly encourage scientists to describe in their publication 59 <sup>60</sup>1096 any modifications from original extraction methods.

neutral lipids prior to transesterification allows for a better interpretation of FA profiles when seeking 8 information on nutritional status and/or physiology of organisms. Special attention should be paid to 9 control for the purity and recovery of each fraction. Non-volatile FA are then transesterified into their n volatile derivatives, usually FAME, before being analysed by GC. Acid catalysed reagents, such as HCl or H<sub>2</sub>SO<sub>4</sub> are the most commonly used in aquatic science as they present fewer analytical issues 2 than BF<sub>3</sub>. Hexane is the most widely used solvent to recover FAME after transesterification. Less 3 toxic alternatives are emerging, but are not applicable to all sample types. The analysis and 1 quantification of FAME is usually conducted by GC-FID. FAME are identified by comparing their 5 retention times with those of individual purified standards. They are quantified as relative proportions 6 using peak areas or by absolute concentration when an internal standard was added before 7 transesterification. When necessary, peak identification can be confirmed using GC-MS, but this 8 process may require additional derivatisation steps. Data treatment and statistical analysis of FA 9 should be carefully applied according to the investigated scientific question. We presented common 0 multivariate statistical procedures that we consider widely relevant for FA-related problems. This list is by no means exhaustive. We encourage analysts to explore their data in multiple ways. A good 2 starting point is usually a simple preliminary visualisation of data. This will not only help to check 3 for data quality, but also to make informed choices about subsequent procedures. When interpreting data and statistical results, it is crucial to take into account the studied organisms and/or ecosystems 5 and their specificities. 6

We argue that methodological consistency, controlled experimentation, and interlaboratory comparison and calibration can lead to enhanced progress in FA studies and are particularly important for comparative studies. Standardisation and optimisation of FA methodologies will ultimately improve our understanding on the role of lipids in biological mechanisms, and will enable us to use them as ecological or physiological tracers as efficiently as possible.



## Abstract

Determining the lipid content and fatty acid composition of aquatic organisms has been of major interest in trophic ecology, aquaculture and nutrition for over half a century. Although protocols for lipid analysis are well-described, their application to aquatic sciences often requires modifications to adapt to field conditions and to sample type. Here, we present the current state of knowledge of methods dedicated to both marine and freshwater lipid analyses, from sampling to data treatment. We review: (i) sample preservation, storage and transport protocols and their effects on lipids, (ii) lipid extraction, separation of polar and neutral lipids, derivatisation and detection methods, and (iii) available tools for statistical analysis of fatty acid data. We provide recommendations for bestpractices in field situations and advocate for protocol standardisation and inter-laboratory calibration.

# Introduction

Lipids and their derived fatty acids (FA) are ubiquitous components of all living organisms. They are essential compounds for the formation of cell and tissue membranes, act as major sources of metabolic energy, provide thermal insulation and serve as chemical messengers. Fatty acidsA generally consist of a linear hydrocarbon chain with a carboxyl group (-COOH) at its end. They are characterised by the length of their carbon chain, generally from 14 to 24 (up to 36) atoms, as well as by the position and the number of double bonds (usually from 0 to 6) that determine their degree of unsaturation. Fatty acids FA-are constituents of lipids such as wax and sterol esters (WE, SE), triacylglycerols (TAG), diacylglycerols (DAG), monoacylglycerols (MAG), glycolipids and phospholipids (PL), which show different levels of regulation from ingestion to incorporation. One or several FA are linked either with an ester (or ether / vinyl-ether) bond to an alcohol, mainly glycerol, or with an amide linkage to a long-chain nitrogen base, mainly sphingosine. All of these molecules are categorised as either neutral lipids or polar lipids, with reference to chromatographic methods of lipid class separation but also to their metabolic roles (Christie, 1984). Among neutral lipids, FA-containing compounds include TAG and WE, which are the main storage lipids, whereas DAG, free FA (FFA), and MAG are generally minor constituents. Sterols (both in their free and esterified form) and fatty alcohols (ALC) are also found in neutral lipids. Free FA are rarely present in living organisms, as they may be toxic in high concentrations (Jüttner, 2001)-. Polar lipids include PL, glycolipids, and sphingolipids. Polar lipids are characterised by a hydrophilic polar head group which, in contrast to their hydrophobic aliphatic chains, allows for the formation of lipid bilayers found in cell membranes. Polar lipid properties are determined by the nature of the polar head groups, the nature of the linkage between the polar head group and aliphatic chain, the length of the carbon chain, as well as the position and the number of double bonds within the FA. These different properties influence the functioning of membrane receptors, the fluidity of membranes, and the stability of the bilayer structure (Hazel and Williams, 1990). 

Fatty acids have been analysed in aquatic sciences for over 50 years (Ackman et al., 1968) with the first evidence that FA composition of consumers resembles that of its food (Lee et al., 1971). Over the next 30 years, the concept of FA trophic markers (FATM) gained in popularity in aquatic trophic ecology (Dalsgaard et al., 2003). The According to this concept of FATM, is based on the fact that the FA composition of some primary producers is characterised by specific FA compounds that can be transferred to upper trophic levels (e.g. (Kelly and Scheibling, 2012). The FA composition of a consumer is therefore expected to reflect the FA composition of its food sources ('you are what you eat' principle). FA have accordingly been used to study energy flow in food webs in freshwater, estuarine, coastal and deep-sea, environments in all latitudes, and to examine functional responses to stressors (Kelly and Scheibling, 2012). More recently, the FATM concept has culminated in quantitative FA-based diet modelling (Iverson et al., 2004; Galloway et al., 2014; Bromaghin et al., 2017), and recent methodological developments allow for accurate estimation of prev contribution to consumer diet (Litmanen et al., 2020). However, diet modeling is based on the fact that aquatic consumers generally lack the ability to synthesise long-chain polyunsaturated FA (LC-PUFA,  $\geq$  C20), and have limited capacity for bioconversion of short-chain PUFA into long-chain PUFA (Castell et al., 1972; Langdon and Waldock, 1981; Sargent et al., 1999; Taipale et al., 2011). This view has recently been challenged (Kabeya et al., 2018). 

Diet is not the only determinant of the FA composition of aquatic consumers. FA composition varies with intrinsic factors such as phylogeny and developmental/reproductive stages (e.g. Galloway and Winder, 2015), and extrinsic factors such as temperature, salinity and hydrostatic pressure (e.g. Wodtke, 1981; Cossins and Macdonald, 1989; Hazel and Williams, 1990), thus providing information about physiological condition and habitat type of aquatic organisms (e.g. Meyer et al., 2019).

The analysis of the FA composition of aquatic organisms is based on procedures originally developed for applications in food science and medicine. Briefly, once a sample is collected, it is 55 100 <sup>57</sup> 101 immediately stored in the dark at the lowest possible temperature for the shortest period of time with added antioxidants, and under a nitrogen atmosphere or vacuum. This is to avoid alteration caused by

enzymes, heat, oxygen and light. Lipids are then extracted, and lipid classes may be separated using
chromatography. Next, derivatisation of FA is performed (methylation in most cases) and FA
composition is determined by gas chromatography. Finally, data are treated to obtain the quantitative
and qualitative FA profiles of the sample (Figure 1).

There are likely to be as many variations of procedures as there are laboratories (Parrish, 1999). Yet, not all may be applicable to aquatic samples. Procedures involved in sample collection, handling and storage, as well as extraction and transesterification steps, can cause biochemical modifications of FA and differential loss, leading to false or misleading interpretations. Identifying the most appropriate protocols and the best-practices in FA analysis of aquatic organisms may prove to be a difficult task for novices, as available literature is widespread and highly diverse, and many studies do not fully describe their methodology (e.g., "modified Folch extraction").

Our objective is to provide an up-to-date review of the procedures used for a large number and variety of aquatic samples and laboratories around the world. This review emerged from technical workshops of the conference "*Lipids in the oceans*" held in Brest (France) in November 2018. We answer practical questions that are not necessarily formulated in papers and textbooks, but essential to obtain a reliable FA profile. For example, which organ/tissue of particular specimens should be analysed to be representative in the context of trophic ecology? How are samples properly collected, transported or shipped? What are the most appropriate extraction/transesterification methods or solvent systems? How can one ensure reliable FA identification and quantification? How are FA data analysed? This paper aims to guide both novice and advanced scientists in identifying the most appropriate protocols and best-practices for FA analysis of aquatic samples. We hope that this comparative synthesis will stimulate further international collaborations and facilitate standardisation of lipid analyses.

# 1 Sample handling and storage before lipid extraction

The choice of biological material, its collection and handling techniques, as well as storage methods, 127 128 are among the most important steps in lipid analysis (Fig. 1). Lipid degradation can occur by hydrolysis (release of FFA from acyl lipids through the enzymatic activity of lipases) or oxidation of 129 130 carbon-carbon double bonds. In view of the labile nature of lipids, these processes often occur very rapidly, leading to analytical errors and increased sample variability (Christie, 1984). Handling and storage conditions and methods can help minimise sample degradation and analytical bias. Ideally, 183 lipids should be extracted immediately after collection. The second-best option is to deepflash-freeze samples in liquid nitrogen immediately after collection. As sampling of aquatic organisms is often performed in the field and in remote areas, optimal conditions can rarely be achieved, but samples need to be stored adequately. A broad set of procedures exists, including: (i) sample maintenance on ice, (ii) frozen sample storage from -18 °C (standard freezer), to -80 °C (laboratory freezers) and/or to -196 °C (liquid nitrogen), (iii) freeze-drying of samples, or (iv) sample storage in organic solvents 139 for varying storage periods, from a few hours to years prior to analysis. Adequate storage conditions will prevent (or at least limit) the degradation of lipids through hydrolysis and oxidation processes 140 induced by oxygen, temperature, light and/or enzymatic processes (Rudy et al., 2016). The rate of oxidation and hydrolysis processes (hereafter referred to as "lipid degradation") is likely to vary 143 greatly across species and tissue types. These processes can be revealed by an increase in FFA and a decrease in glycerolipids and polyunsaturated FA (PUFA) in samples (Christie, 1984, see section 4). Here, we provide an overview of different methods used in the literature and discuss their strengths and limitations.

1.1 Sample type/ sampling strategy

Aquatic samples are highly diverse, ranging from bacteria to whales, and sampling procedures need to be adapted to the nature of the studied organisms/functional groups. Samples of seston and

phytoplankton are generally collected through water filtration on pre-combusted glass microfiber filters (GF/C or GF/F), while zooplankton can be sorted manually. Such small organisms or functional groups are often directly extracted as whole organisms and stored in solvent. For other organisms such as larger invertebrates, fish, and aquatic mammals, tissue dissection or biopsy is usually required. In the case of multi-purpose samples, it is possible to grind them under liquid nitrogen and subsample the powder (Soudant et al., 1996). In the case of a quantitative study where the mass of lipid or FA is reported per gram of sample, the sample will have to be weighed before or after storage. Sample mass can be measured from fresh or dry tissue. In the latter case, the dry mass may be measured on a dedicated subsample. All material should be lipid-cleaned prior any sampling to avoid cross contamination (see section 3.1). Because it is not possible to describe all sampling strategies here, we highly recommend that any study involving lipid and FA analysis must start with a literature review of available information on targeted organisms or on species that are phylogenetically Lien comparable.

## Sample handling 1.2

Maintaining samples on ice is often the first and only practical option available to limit lipid degradation between collection and further processing. Whenever possible, long-lasting dry ice is preferable to water ice. Ideally, samples should be immediately flash-frozen in liquid N<sub>2</sub> in the field and transported to a freezer using a dry shipper. Crushed ice is useful for transportation between locations such as sample transport from the ocean (e.g., small and large vessels) to land, or transport between laboratories. Crushed ice should preferably be used only for a few hours, as this method only slows, but does not stop, lipid and FA degradation (Wood and Hintz, 1971; Chaijan et al., 2006), and samples should therefore be frozen as soon as possible. As an alternative, deep-frozen, long-lasting ice packs are a convenient option for short-term storage in the field (e.g., TechniIce<sup>™</sup>). These ice packs maintain temperatures around 0 °C for a few hours in a well-insulated container (L. Couturier 174 pers. obs.). In the particular case of studies on thermal acclimation or adaptation, it may be preferable

to maintain samples at environment temperature rather than to cool them before freezing as it may induce a short-term cold-response. Freezing / thawing samples more than once should be avoided.

1.3 Storage

# 1.3.1 Frozen storage (-20 °C to -196 °C)

Storing samples at cryogenic temperature Frozen storage-is likely the most common method of preservation before performing FA analyses. Yet, depending on the temperature, storage duration and 180 type of biological material, this may not be sufficient to limit lipid degradation. It can lead to increased FFA and products of oxidation (e.g., Christie, 1984; Gullian-Klanian et al., 2017; Tenyang et al., 183 2019). Lower freezing temperatures and short-term storage are generally associated with lower lipid degradation (e.g., Baron et al., 2007; Rudy et al., 2016; Gullian-Klanian et al., 2017). The level of lipid degradation in samples is highly dependent on initial freezing temperature and temperature 186 variation during storage, as well as storage duration prior to analyses (Han and Liston, 1987; Ramalhosa et al., 2012; Romotowska et al., 2017). When long-term storage is required, the safest approach is to freeze samples at -80 °C immediately after collection. Although not ideal, long-term storage at -20 °C can be suitable for some species and sample/tissue types, in particular when samples are kept frozen within the organic extraction solvent. Levels of n-3 and n-6 PUFA in fish muscle, stored at -30 °C and -80 °C, did not change for up to 12 months in both TAG and phospholipid fractions (Passi et al., 2005). Shark muscle samples archived for up to 16 years at -20 °C retained their FA profiles, while lipid class composition was not analysed (Meyer et al. 2017). Impacts of 193 frozen storage on FA content and composition are species-specific and can depend on the total lipid content of the organism and tissue (Rudy et al., 2016). Species with high total lipid content (>10% wet weight) must be treated with increased care (low temperature, and short storage period) to avoid changes in FA content during freezing (Rudy et al., 2016; Sardenne et al., 2019).

Based on the literature cited, samples should be stored for less than 6 months prior to analysis at temperature lower than -20 °C when no information is available on the collected biological material. Note that lipid analysis is also possible for samples stored using brine immersion freezing technique (e.g., fisheries-issued material) (Bodin *et al.*, 2014). The sensitivity of lipids to storage varies according to species and tissues. We therefore recommend evaluating the sensitivity of the samples for which there is no information available before the start of the study. For example, a temporal monitoring of the lipid composition of the biological material of interest at the available storage temperatures will make it possible to define the optimal conservation strategy.

1.3.2 Freeze-drying

Freeze-drying (or lyophilisation) is a low temperature dehydration process of frozen material that is used to reduce enzymatic activity and thus lipid degradation in samples. Freeze-drying samples immediately prior to extraction does not affect lipid class or FA compositions of aquatic animal tissues (e.g., Dunstan et al., 1993; Murphy et al., 2003; Sardenne et al., 2019). This can be a good alternative to frozen storage, as freeze-dried tissues can be easier to grind and to transport than frozen tissues. Rehydration may be required to improve the lipid extraction of TAG (e.g., Dunstan et al., 1993) and to comply with extraction procedures that rely on a particular proportion of water in the sample. Nonetheless, freeze-dried tissues still need to be carefully stored to prevent lipid degradation. Storage duration can also have detrimental effects on lipid composition of samples. In fish, crustacean and molluscs, the total duration between freeze-drying and lipid extraction should not exceed one month at -20 °C for quantitative analysis (Sardenne et al., 2019). Similarly, freeze-dried microalgae samples should not be stored for extended period of time (but see Rudy et al. 2015). The PUFA proportion of filtered Isochrysis galbana biomass decreased from 36% to 26% after 3 months storage at -76 °C (Babarro et al., 2001). Proportions of FFA in freeze-dried Phaeodactylum tricornutum increased from 4 mg/g to 6 mg/g DW after 35 days at -20 °C while the degree of oxidation was unaffected (Ryckebosch et al., 2011). Variability in freeze-dried sample stability/viability for lipid

analysis is likely to reflect differences of biological material and length/duration of the freeze-drying 223 224 process.

Overall, the quality of the freeze-dried storage depends on: (i) the storage temperature (lower 225 226 temperatures are the best), (ii) the storage duration (shorter durations are better) and (iii) the lipid content of samples (lean samples are conserved better than lipid-rich samples). Lipid oxidation in 227 228 food products occurs more rapidely rapidly when water activity is high (Labuza et al., 1972). Conversely, lowering water activity below 0.2 through freeze-drying process Deep freeze-drying may 16 2 2 9 18 280 be a factor promoting lipid degradation through oxidation (Labuza et al., 1972), and specific testing should be considered for aquatic samples. Freeze-drying may offer some benefits when used as a 231 short-term preservation method (e.g., during transport), but it can be expensive (necessary equipment) <sub>23</sub> 232 and time-consuming, while potentially shortening the viability of samples for lipid analyses. 25 233

### 234 1.3.3 Solvent and fixative storage

<sup>35</sup> 236 One common storage strategy is to directly immerse small organisms such as phytoplankton collected on filters or small-bodied zooplankton into the lipid extraction solvent (e.g., Marty et al., 1992; 237 Soudant et al., 1998; Windisch and Fink, 2018). If samples in the extraction solvent (generally 40 238 42 239 chloroform CHCl<sub>3</sub> and methanol MeOH) are kept in the dark and at low (preferably freezing) 240 temperatures, lipid degradation is minimal. To our knowledge, maximum storage duration of 47 2<mark>41</mark> extracted lipids has not been formally investigated. However, samples are likely to remain useable for months to years. -For microalgae samples, it is advised to deactivate lipases by a rapid addition of 49 242 243 boiling water or isopropanol prior to extraction (Berge et al., 1995; Budge and Parrish, 1999; 54 244 Ryckebosch et al., 2012).

56 245 antioxidants (0.01%) butylated hydroxytoluene. Synthetic BHT 0.1% tertiary or 57 <sup>58</sup> 246 butylhydroquinone, TBHQ) can be added to solvent-stored samples to reduce radical formation and 59 60 247 oxidative losses of unsaturated lipids (Christie, 2003; Ryckebosch et al., 2012). However, addition

of synthetic antioxidant is unnecessary in samples containing large amount of natural antioxidants
such as microalgae (Ryckebosch *et al.*, 2012). Note that BHT elute with short-chain FA and when
present in large quantities, it can overlap with FA of interest.

*1.3.3.2 Fixatives* 

Fixatives such as ethanol or formalin are commonly used for biodiversity, taxonomy, morphological, or DNA analyses. The use of fixed samples opens new research opportunities, by making it possible to analyse historical samples collected for purposes other than lipid analysis. However, fixatives influence the chemical composition of the samples and should therefore not be used as a routine procedure for lipid analyses. For example, FA composition of crustacean tissues is altered in formalin-preserved samples, but not in ethanol preserved samples (Phleger *et al.*, 2001). Direct evaluation of fixative effects on lipids are scarce and preliminary tests on different sample types are highly recommended.

The packaging, transport and shipping of samples for lipid analysis is a complex process, driven by 261 262 safety laws, financial costs, stringent storage conditions, and limited duration of storage. Specific legal regulations, including quarantine, must be followed and they can vary, depending on whether 263 264 the samples are shipped domestically or internationally, and whether there are stopovers during long 16 265 distance travels. Shipping recommendations to ensure that samples arrive at their destination in good 18 266 condition include triple packaging with a rigid outer layer and absorbent material, appropriate 267 cooling, accurate labelling (i.e., name, address, phone number, e-mail address, size and weight of the package), and complete legal documentation (e.g., itemised list of content, permits) (IATA, 2010). 268 25 269 This section reviews different options of packaging for shipping and traveling, and gives an overview <sup>27</sup> 270 of the main flying regulations and key legal information. 2.02

#### 31 271 2.1 Shipping samples

<sup>35</sup> 272 Long-distance shipping from the sampling site to the laboratory is challenging. Multiple issues need 38 273 consideration, such as the conservation state of the samples prior to transport (cooled, frozen, deepfrozen, freeze-dried), the distance, the duration and the type of transport. As samples are generally 40 274 42 275 prone to degradation, temperatures must be kept low and oxidative conditions reduced as much as possible. Regardless of the method used, we recommend only to ship a part of the original sample 276 47 277 and keep a backup sample when possible, and to take great care in the packaging (minimum empty 49 278 space, adapted container to accommodate samples and cooling methods).

51 279 When possible, frozen samples should be shipped using dry shippers, which are aluminium 52 53 <sub>54</sub> 280 containers flooded with liquid nitrogen. They contain adsorbent material that prevents spills of liquid 55 56 281 nitrogen during shipment and have attached temperature loggers. Samples can be stored in these 57 <sup>58</sup> 282 conditions for several weeks. However, dry shippers may not be readily available at sampling 59 60 283 locations or in laboratories. Restrictions for the transport of liquid nitrogen also need to be considered

(e.g. in airplanes or closed vehicles). With transporter authorisation, frozen samples can also be shipped on dry ice depending on transport duration (about 24 h for 2.5 kg of dry ice). Alternatively, deep frozen (-80 °C) aqueous ice packs or reusable technical ice packs (e.g. TechniIce<sup>™</sup>, 2019) can be used. A cost-effective option is to freeze-dry samples prior to shipping, as it reduces both the volume to be shipped and the risk of lipid hydrolysis by removing water (see section 1). When dry ice packaging or deep-frozen ice packs are not available at the sampling location, freeze-dried samples should be kept cool and in an oxygen-free atmosphere by flushing containers with nitrogen gas and then sealing prior to packaging and shipping. It is also possible to ship samples with small amounts of solvents with respect to international regulations. Note however that depressurisation in aircrafts promotes solvent leakage (F. Pernet pers. obs). To limit this phenomenon, tubes and caps can be coated with Teflon. Alternatively, preserved and/or extracted samples in solvent may be evaporated and flushed with nitrogen so that dried extracts can be air-transported as frozen biological material. Dried lipid extracts will have to be re-immersed in solvent as soon as possible upon arrival. We however recommend to perform preliminary testing before proceeding with this method.

The gold standard for shipping samples are specialised transport companies that maintain samples on dry ice and guarantee express delivery to the final destination. However, these options may not be practical for some laboratories and/or available for all sampling sites and destinations. Care should be taken when selecting the shipping company, as several unfortunate experiences have shown that some may not be reliable in maintaining the cold transportation chain.

# 3 2.2 Flying with samples

Although courier is preferable, one might consider putting samples in checked luggage. One of the safest options to transport samples as checked luggage is to use a dry shipper. However, airlines may have different regulations in transporting liquid nitrogen. Non-harmful materials, such as dry ice or technical ice packs are the best option to meet standard luggage regulations (e.g., < 2.5 kg of dry ice

per person) and safety (e.g. the package permitting the release of carbon dioxide gas when 308 309 transporting dry ice).

Transporting freeze-dried samples kept in a hermetically closed bag (or a thermos filled with ice) 310 311 is likely the safest and cheapest option. Upon arrival, samples need to be stored in a freezer (preferentially at -80 °C) or immediately put in a solvent solution for lipid extraction (see section 1 312 313 for more details on storage duration). Dried lipid extract should be transported as frozen samples and be returned to solvent as soon as possible (see section 2.1). Note that preservation methods requiring 16 314 18 315 flammable solvents (e.g. ethanol, methanol) are not permitted on aircraft within passenger luggage. Recently, the emerging technology of drones opens new opportunities for a rapid and customisable 316 aerial transport of sensitive samples from remote areas to laboratory facilities (e.g., Amukele et al., <sub>23</sub> 317 25 318 2017).

33 320 Prior to initiating sample collection and considering transporting them, it is necessary to be well 321 informed on import and export regulations that differ widely across countries and studied organisms' 38 322 status. It can be difficult to obtain the necessary information within custom departments and the 40 323 paperwork involved. Some research institutions may have specialised services available to ensure 42 324 proper paperwork so that samples are shipped and received safely. To transport samples out of a 325 country, it is often necessary to follow The Nagoya Protocol on Access and Benefit Sharing (United Nations Convention on Biological Diversity, 2011). Although it was initially stated that this only 47 326 49 327 applies to samples for molecular research, all transports of tissue for biochemical screening are now 328 included. This applies only for countries that have signed and ratified the Nagoya Protocol.

53 <sub>54</sub> 329 When samples contain species listed in the Convention on International Trade in Endangered 55 Species of wild fauna and flora (CITES), it is necessary to request an import/export CITES permit 56 330 57 <sup>58</sup> 331 from each of the countries involved. This needs to be organised well ahead of sample collection, as 59

# 3 Lipid extraction

Because of their diverse structures, lipids range from non-polar to highly polar, which makes the selection of a solvent with matching polarity challenging. Methods based on chloroform and methanol (Folch *et al.*, 1957; Bligh and Dyer, 1959) have long been used across a wide range of matrix types with great success. Current alterations in environmental regulations have brought restrictions on the type and amount of solvent usage in laboratories worldwide, encouraging the exploitation of alternative organic solvents and novel eco-friendly methodologies for extraction (e.g., accelerated solvent extraction). Here, we will-review both the well-established techniques and the newly developed methods; we caution readers that full validation must be carried out with a given biological material before adopting any modified or adapted method.

3.1 Handling cautions

Contamination is an issue that needs to be carefully addressed at every stage of sample handling. It is recommended to; <u>i) use material that have been cleaned using acetone or extraction solvent mixture</u> to remove any potential lipids (e.g. Teflon-coated needles used for evaporation), <u>iii</u>) avoid plastic containers, tools or tips, <u>iii</u>) combust at 450 °C for 6 h or solvent-rinse all glassware and glass fibre filters, <u>iiiiv</u>) use glass tubes fitted with <u>a</u>-Teflon-lined screw caps, <u>ivv</u>) prefer amber glassware (or aluminium foil protected) to limit solvent photo-degradation, <u>vi</u>) use the highest quality solvents for material/tool cleaning, extraction, or elution, <u>vii</u>) perform blank and reference samples for each batch of samples, and <u>viii</u>) wear laboratory gloves to limit exposure to toxic solvents and crosscontamination.

#### Sample preparation 3.2

Regardless of the technique used, extraction of lipids from aquatic samples requires that the solvent penetrates the sample particles so that it can make contact and solubilise the lipids present. The most 11 358 efficient extractions ensure that the particle size is as small as possible. The gold standard is to homogenise samples with a ball mill homogenizer (at -196 °C using liquid nitrogen with wet samples). With wet plant or animal tissue samples at macro-scales, this may be as simple as chopping 18 361 or blending. For wet microalgae, grinding of samples after immersion in solvent works well to break open cells. Small organisms (roughly between 1µm and 1 mm; on a filter or notwithout) can also be directly extracted by direct immersion in the solvent mixture. The use of ultrasound-assisted extraction with a probe or bath may aid in breaking cell walls (Pernet and Tremblay, 2003). When 25 364 <sup>27</sup> 365 samples have been freeze-dried (section 1) for preservation, they may be most conveniently ground with mortar and pestle and it may be necessary to rehydrate prior to carrying out the extraction. Any of these techniques, when applied prior to subsampling for analysis, should also serve to homogenise 32 367 34 368 samples effectively, to ensure representative sampling. These diverse techniques also illustrate the need to adapt the preparatory steps and approach to the sample matrix.

<sup>40</sup> 370 Traditional extraction methods 3.3

While many researchers consider Folch et al. (1957) and Bligh and Dyer (1959) extraction methods ... 47 372 to be similar, based on their use of chloroform and methanol, the two are quite different and were developed for different objectives. Prior to using those methods, one would do well to read the 49 373 original publications. Both methods rely on the formation of a biphasic mixture, with a lower layer 54 375 principally consisting of chloroform, and containing the isolated lipids, and an upper phase consisting 56 376 of methanol and water and containing the non-lipids. The Folch et al. procedure, using CHCl<sub>3</sub>:MeOH 58 377 (2:1, v:v) and a solvent to sample ratio of at least 20:1, was designed as a general and robust method for recovery of lipids from animal tissues (i.e., brain, liver, muscle), now applicable to several tissues

379 and species with a range of lipid concentration content (Iverson et al. 2001). The Bligh and Dyer method uses a more polar solvent mixture of CHCl<sub>3</sub>:MeOH: H<sub>2</sub>O) (1:2:0.8, v:v:v) with a 4:1 solvent 380 to sample ratio, and was originally developed to rapidly extract lipids, principally polar lipids, from 381 382 lean fish tissues.

<sup>11</sup> 383 While the Folch et al. method is more complicated to perform, it is more reliable and applicable 384 to almost all sample types. A key aspect of the original Folch et al. method that is often overlooked, 16 385 is the washing of the bottom phase that contains lipids with a mixture of solvents of the same 18 386 proportions as originally found in the upper phases. As originally described by Folch et al. (1957), 387 the upper phase consists of CHCl<sub>3</sub>:MeOH:H<sub>2</sub>O at 3:48:47 and while some groups do use a 50:50 MeOH: H<sub>2</sub>O wash as recommended by Christie (1982), it is exceedingly rare that the correct mixture 23 388 is used. Thus, almost all Folch et al. procedures are best described as 'modified'. The Bligh and Dyer 25 389 27 28 390 method is easier to carry out, but requires greater consideration of sample type and potential <sub>30</sub> 391 modification of the procedure. For instance, Christie (1982) notes that with high fat samples, an initial pre-extraction with chloroform or diethyl ether is necessary to extract TAG that would otherwise 32 392 <sup>34</sup> 393 remain unrecovered. The use of the correct proportions of solvents and water are critical for quantitative lipid recovery with both methods. One must take care to adjust the volume of water added 394 when samples with varying moisture contents are analysed (i.e., freeze-dried material vs fresh tissue) 39 395 41 396 and it is often necessary to determine moisture content before beginning extraction.

These basic procedures may require some adjustments depending on lipid matrix before and/or 397 46 398 during extraction to increase the yield or specificity of lipids to be analysed. For example, it may 48 399 include inactivation of lipase, changes of solvent proportions, or cell disruption (e.g. Kumari et al., <sup>50</sup> 400 2011; Ryckebosch et al., 2012). In a general manner, authors must thus refer to the available literature 53 401 on their model organisms or matrices. Given the numerous modified extraction procedures that reflect the diversity of aquatic biological matrices, it is also essential that authors detail their protocol in 55 402 <sup>57</sup> 403 publications when it differs from original methods.

404 3.4 Alternatives to chloroform: toward less toxic solvents

# 3.4.1 Dichloromethane

10 Many laboratories have become increasingly conscious of a range of occupational health and safety 406 11 12 13 407 areas in recent decades. Lipid studies historically used chloroform as a major solvent in many steps 14 15 408 including extraction. The less toxic dichloromethane (CH<sub>2</sub>Cl<sub>2</sub>) has regularly been used instead of 16 17 409 chloroform for lipid extraction in many aquatic labs. This replacement originated from food chemistry 18 19 <sub>20</sub> 410 research (e.g. Chen et al., 1981) and was later formally reported for aquatic samples (e.g., Cequier-21 22 411 Sánchez et al., 2008). Regardless of solvent choice, both dichloromethane and chloroform may 23 <sup>24</sup> 412 degrade on storage to produce HCl and phosgene (Noweir et al., 1972). Phosgene is a much more 25 26 27 413 acutely toxic chemical than either chloroform or dichloromethane, and inhalation can lead to 28 pulmonary oedema (e.g., Snyder et al., 1992). Chloroform degradation or insufficiently stabilised 29 414 30 <sup>31</sup> 415 may lead to lipid degradation (i.e., empty chromatograms, including disappearance of the internal 32 33 416 standard) (Le Grand and Pernet, pers. obs). To limit phosgene production, chloroform is stabilised 34 35 36 417 with either ethanol or amylene, with ethanol being the more effective stabiliser. Because 37 38 418 dichloromethane is less susceptible to degradation than chloroform, it is typically stabilised with 39 <sup>40</sup> 419 alkenes only. Safe lab practices, including restricting solvent use to fume hoods, can effectively avoid 41 42 43 420 risks associated with chlorinated solvents and phosgene formation. In the field, when samples are 44 preserved by direct immersion in solvent, caution is advised. 45 421 46

<sup>48</sup> 422 3.4.2 Methyl-tert-butyl ether

47

50

51 Methyl-tert-butyl ether (MTBE) was recently used as a less toxic solvent for the extraction of lipids, 52 423 53 54 424 but had lower recovery rates than chlorinated solvents (Sheng et al., 2011; Ryckebosch et al., 2012). 55 <sup>56</sup> 425 However, the MTBE based extraction protocol appeared especially well adapted to high-throughput 57 58 <sub>59</sub> 426 lipidomics, as the lipid extract recovered in the upper phase was cleaner with non-extractible material 60 remaining in the lower phase (Matyash et al., 2008). 427

#### The special case of ethanol preserved samples 428 3.5

The availability of historically preserved samples can often occur for a range of lipid studies (see 429 section 1.3.3.1). However, because ethanol extracts some lipids, the sample and all added ethanol 430 11 431 must be used in the lipid extraction protocol (Phleger et al., 2001). When using the Bligh and Dyer (1959) method, the extraction should be performed with chloroform (or dichloromethane), ethanol 432 and water, where ethanol replaces methanol. Care is needed when selecting historic ethanol-preserved 433 18 434 samples for lipid analysis and in which the ethanol preservative may have been replaced during <sup>20</sup> 435 storage.

<sup>28</sup> 437 Accelerated Solvent Extraction (ASE, Dionex), also known as Pressurised Fluid Extraction (PFE), is widely used method based on a controlled increase in solvent temperature and pressure during 438 extraction. This process maintains the liquid state of solvents near their supercritical region where 33 439 35 440 they have high extraction properties. Several ASE parameters can be adjusted to improve the extraction, such as temperature, pressure, extraction duration (including pre-heating) and number of 441 40 442 extraction cycles. All of these parameters affect the final solvent volume and can be adjusted 42 443 individually to each sample type to optimise the extraction yields and quality (Schäfer, 1998). This 444 sample type-specific adjustment enables high extraction efficiency with a low solvent volume and a short extraction time which is beneficial from a cost and environmental standpoint. Microscale lipid 445 extraction of fish tissues (100 mg) using ASE was shown to be as quantitatively and qualitatively 49 446 <sup>51</sup> 447 efficient as classical lipid extraction methods (Dodds et al., 2004).

55 448 Concluding remarks 3.7

<sup>59</sup> 449 This section did not aim to be exhaustive in describing existing extraction methods. When comparing 60 data from different studies, it is important to consider the lipid extraction techniques used as well as 450

handling and storage methods. When working on new matrices and developing new or optimised extraction protocols, we recommend to compare them with Folch et al. (1957) or to Bligh & Dyer (1959) methods, which generally remain the gold standards for lipid recovery. Ensuring complete lipid extraction is critical when applying new protocols. Performing successive lipid extractions on a same sample and measuring its lipid content at each step is a suitable approach to establish at which stage the sample is totally lipid-depleted. We recommend monitoring extraction efficiency values and ideally reporting them in publications. Alternatively to successive extractions, the fatty acid methyl ester (FAME) content of the lipid extract can be compared to FAME recovered after direct transesterification (section 6). A number of studies have compared the effect of extraction techniques (ASE, Soxhlet, manual) on lipid recovery and FA eoneentration-content (e.g. Ewald *et al.*, 1998; Mulbry *et al.*, 2009; Balasubramanian *et al.*, 2013). While all report differences, there is little agreement as to which may be an optimal method, likely due to substantial differences in the followed protocols.

Sample lipids may degrade through hydrolysis of ester bonds or through oxidation of carbon-carbon double bonds. These are two, largely independent processes leading to different compounds or groups of compounds, which may be used as indicators of sample degradation. Therefore, samples showing indicators of hydrolysis may not have been oxidised and vice versa. Unless necessary for a short time period (e.g. shipping), purified lipid extracts are susceptible to oxidation and should be kept under N<sub>2</sub> atmosphere with solvent (Folch mixture is generally preferred).

Hydrolysis 4.1

The most frequently encountered aquatic lipids are acylglycerols (TAG, PL, and glycolipids) in which 26 474 475 FA are esterified to a glycerol backbone. There are also ether lipids that replace one ester bond with an ether linkage or a vinyl ether linkage. Esters of carboxylic acids undergo hydrolysis in a reversible 476 reaction which is catalysed by hydrolase enzymes called esterases present in biological samples. 33 477 <sup>35</sup> 478 Lipases, a subclass of esterases, are found in animals, plants, fungi, bacteria and even in certain viruses (Beisson et al., 2000). Lipid hydrolysis can be assessed from the FFA content, and from the 479 lysophospholipid content when samples are dominated by PL. Standard measurements of oil quality 40 480 42 481 are the acid value (AV) and FFA content, determined in the oil industry by titration and chromatography, respectively. However, both these measurements are rarely used outside of the 482 47 483 industrial context.

49 484 Many chromatographic systems have been used over the past years for quantitative analysis of 50 51 485 major lipid classes including FFA. Free FA can be easily separated from extracted lipids by means of 52 53 54 486 well-known methods based on either liquid (LC) or thin layer chromatography (TLC) (reviewed by 55 56 487 Fuchs et al., 2011). For example, HPLC with light-scattering detection (HPLC-ELSD) has been 57 <sup>58</sup> 488 successfully used to detect and quantify FFA in fish with a relatively short processing time and highly 59 60 489 reproducible measurements (Christie, 1985; Silversand and Haux, 1997). As for LC, a number of

improvements to classic TLC have led to more sophisticated forms, providing better separation
efficiencies and quantifications. High-performance thin-layer chromatography (HPTLC) coupled
with densitometry or TLC coupled with flame ionisation detection (TLC-FID, Iatroscan, Shantha,
1992) have also been used to quantify lipid classes and FFA in samples from different origins
including marine (Lochmann *et al.*, 1996; Parrish *et al.*, 2009), terrestrial (Zoumpoulakis *et al.*, 2012)
and freshwater species (Litz *et al.*, 2017). In food studies, FFA determined by TLC-FID is generally
equivalent to AV (Nishiba *et al.*, 2000). TLC is normally less expensive and less time-consuming
than HPLC-based methods that can, of course, also be used to provide similar results.

The hydrolysis index of non-polar acyl lipids (HI) and the lipolysis index of all acyl lipids (LI) can be used as degradation indicators (Week et al, 1993; Parrish et al 1995) and are calculated as:

$$HI = \frac{FFA + ALC}{TAG + WE + FFA + ALC} * 100$$
$$LI = \frac{FFA + ALC}{\text{total acyl lipids} + ALC} * 100$$

LI values are always lower than HI values for any sample because all acyl lipids are considered.

4.2 Oxidation

Lipid oxidation mainly occurs through autoxidation when lipids react spontaneously with atmospheric oxygen. The process is usually autocatalytic, with oxidation products accelerating the reaction so that it increases over time. Other catalysts such as light, heat, enzymes and metals lead to photo-oxidation, thermal oxidation and enzymatic oxidation. Fatty acidA oxidation is a process in which free radicals cause unsaturated FA to react with molecular oxygen forming acyl hydroperoxides, which can then breakdown into a variety of secondary products. A decrease in PUFA concentration-content may indicate oxidation as they are particularly susceptible to degradation (Sasaki and Capuzzo, 1984).

Lipid hydrolysis may accelerate lipid oxidation due to the formation of FFA that can be substrates
for oxidation reactions, as found *in vivo* (Saponaro *et al.*, 2015). High levels of PUFA in lipids make

1

them susceptible to oxidation (Koshio et al., 1994). Oxidation of n-3 and n-6 PUFA leads to the formation of highly chemically reactive compounds such as malondialdehyde (MDA), 4-hydroxy-2hexenal (4-HHE) and 4-hydroxy-2-nonenal (4-HNE). HHE is an aldehyde derived from n-3 PUFA, and HNE from n-6 PUFA.

A number of physical and chemical tests, including instrumental analyses, are available to determine primary and secondary products of oxidation (Shahidi and Zhong, 2005). Oil supplement, food and other industries have a range of standard measurements for determining oil oxidation. These include the internationally recommended peroxide value (PV) and p-anisidine value (pAV) (Nichols et al., 2016). For example, PV can be measured by titration and 2-thiobarbituric acid reactive substances (TBARS) by spectrophotometry, and both can be determined using highly precise Fourier transform infrared spectroscopy (FTIR). MDA is commonly monitored using the direct TBARS test (Fernández et al., 1997; Shahidi and Zhong, 2005) and with HPLC (Mendes et al., 2009), while HHE and HNE can be quantified by GC-MS (using chemical ionisation) (Kenmogne-Domguia et al., 2014). Recent analytical developments allowed simultaneous quantification of MDA, HHE and HNE by LC/APCI-MS and LC-MS/MS (Douny et al., 2016; Tullberg et al., 2016). Together with pAV, MDA, HHE and HNE are secondary markers of oxidation while PV, hydroperoxides and conjugated dienes are primary markers. However, it has to be noted that MDA, HHE and HNE quantifications do not necessary reflect PV and anisidine values (Viau *et al.*, 2016).

Sterols are also a source of oxygenated lipids named oxysterols which are sterols bearing a second oxygen functionality. Cholesterol oxidation likely proceeds in conjunction with oxidative decomposition of coexisting PUFA (Ohshima et al., 1993). Cholesterol oxidation products (COP) can be determined by cold saponification of lipids (Ohshima et al., 1993), followed by enrichment of COP by solid-phase extraction (SPE), and then quantification and identification by GC and GC-MS (Pickova and Dutta, 2003).

### 4.3 Concluding remarks

To conclude, we encourage as a minimum the assessing and reporting of hydrolysis indicators as a quality control criterion of sample handling and extraction procedures. The threshold above which 11 541 sample/data quality should be questioned depends on the sample matrix, the logistical context and the study objective. In any case, the extent of either form of degradation should ideally be evaluated 16 543 and compared with baseline values from fresh and properly extracted samples.

#### Separation of neutral and polar lipids 5 545

Fatty acids are incorporated almost unaltered into the storage lipids such as WE, TAG, and ALC, 546 547 reflecting the FA profiles of the consumed food (Dalsgaard et al., 2003). In contrast, polar lipids are 11 548 primarily involved in cell membranes which regulate and adjust their FA composition in response to 549 environmental factors like temperature, salinity and hydrostatic pressure (Hazel and Williams, 1990). 16 550 As such, inference of an organism's diet based on total lipids can be biased by the ratio of FA 18 551 originating from storage (mostly neutral lipids) and membrane lipids (mostly polar lipids). This ratio 552 varies widely across species, ontogenetic stages, reproduction, nutritional status and tissue types. For example, in small pelagic fish from the Mediterranean, the contribution of TAG stored in the muscle <sub>23</sub> 553 in winter was 1.5%, 5.2% and 47.6% of total lipids for sardine, anchovy and sprat, respectively, the 25 554 <sup>27</sup> 555 remainder being mostly polar lipids (Pethybridge et al., 2014). This demonstrates that bulk FA <sub>30</sub> 556 composition variations among species can be confounded with variations in lipid class composition. However, many studies in trophic ecology have based their trophic interpretation on the FA 32 557 <sup>34</sup> 558 composition of bulk lipids without considering the FA distribution between storage and structural 559 lipids.

### <sup>40</sup> 560 When should the lipid fraction be separated? 5.1

Lipid class composition should be assessed alongside the FA composition to decide whether lipid 561 47 562 class separation is necessary for robust dietary inference. Calculating the ratio of storage to structural 49 563 lipids provides a comprehensive assessment of the cost/benefit of separating neutral and polar lipids fractions. For samples dominated by storage lipids, the FA composition of bulk lipids will mostly 564 54 565 mirror the diet, and lipid class fractionation is not mandatory (e.g., fatty fish species, marine mammal 56 566 blubber, and digestive gland and liver of marine organisms) (e.g. Sardenne et al., 2020). However, <sup>58</sup> 567 for samples rich in structural lipids, fractionation of lipid classes will provide more reliable dietary 568 indicators. The analysis of FA in polar lipids can inform on nutritional requirements of the study

organism and on environmental conditions prevailing at the time of sampling. Comparing the relative 569 FA proportions in polar and neutral lipids allows the identification of the dietary FA that were 570 selectively retained/eliminated to form cell membranes (e.g. Delaunay et al., 1993; Plante et al., 571 572 2007). The unsaturation level of FA and PUFA incorporated in polar lipids is linked to the <sup>11</sup> 573 temperature in ectothermic organisms (Hazel and Williams, 1990; Hall et al., 2002; Pernet et al., 574 2007) and can be associated with the basal metabolic rate (Hulbert and Else, 1999; Pernet et al., 2008). Consequently, the separate analysis of neutral and polar lipids is a practical approach to 16 575 18 576 address questions on trophic ecology as well as on nutrition and comparative physiology.

577 To establish trophic relationships of species for which all potential food sources are known, a good strategy is to analyse the FA composition of total lipids in food sources (e.g., prey) and of neutral <sub>23</sub> 578 25 579 lipids in consumers to characterise their diet (e.g., predators). Such approach was implemented by the 27 28 580 pioneers of the use of FA as trophic indicators (reviewed in Dalsgaard et al., 2003). Alternatively, <sub>30</sub> 581 when study organisms are both prey and predator, or when predator-prey relationships are not wellknown, we suggest at a minimum analysing FA from both neutral and total lipids. Beyond trophic 32 582 <sup>34</sup> 583 considerations, quantification of lipid classes provides useful information on the physiological condition of organisms (Fraser et al., 1989) and the quality of sample preservation through FFA and 584 39 585 lysophospholipids levels (see section 4).

# Commonly used separation methods

Storage lipids (SE, WE, TAG, DAG, ALC) and FFA are defined as 'neutral' because they are 47 587 49 588 hydrophobic molecules lacking charged groups, whereas PL are defined as 'polar' because they have a charged hydrophilic head. Neutral and polar lipids can be separated from each other by TLC or by 589 <sub>54</sub> 590 adsorption chromatography using either laboratory packed or commercial prepared silica columns. A simple and widely used protocol for separation of neutral and polar lipids consists of a short column 56 591 <sup>58</sup> 592 of silica prepared in a glass disposable Pasteur pipette plugged with cotton wool (Christie, 1982b). 593 The sample is loaded on the top of the column and washed at low pressure with chloroform (or

dichloromethane) often mixed with methanol, (e.g., CHCl<sub>3</sub>:MeOH, 98:2 v/v) to elute neutral lipids. 594 It can then be washed with acetone to obtain acetone mobile polar lipids, generally dominated by 595 pigments and glycolipids. Finally, a last wash is performed with methanol to yield polar lipids 596 597 dominated by PL. Some PL with lower polarity may elute with acetone, while some glycolipids with 11 598 higher polarity may elute with methanol. Including an elution step with acetone may not be necessary 599 in non-plant samples as they contain negligible amounts of glycolipids (Christie, 1982b). Yet, the latter step (elution step with acetone) can be useful in deciphering trophic links in deep-sea fishes 16 600 18 601 (Sen Özdemir et al., 2019). Diethyl-ether: acetic acid (98:2, v/v) can be used to recover pigments, 602 prior to elution of glycolipids and PL (Da Costa et al., 2017). Elutent and sample volumes must be adjusted to optimise separation. It is also important to note that hydration of silica changes the <sub>23</sub> 603 efficiency of retention through a partition effect between bound water and polar lipids (Christie, 25 604 27 28 605 1982b). The use of silica hydrated with 6% water (m/m) can improve the recovery of polar lipids <sub>30</sub> 606 from marine bivalves (e.g., Marty et al., 1992; Pernet et al., 2006).

Commercially pre-packed columns connected to a vacuum manifold are widely used instead of 32 607 33 34 608 the manually packed Pasteur pipette (Christie, 1992; Ruiz-Gutiérrez and Pérez-Camino, 2000). This 35 36 procedure, often referred to as SPE, is time effective and provides similar results as classic column 609 37 38 chromatography (Juaneda and Rocquelin, 1985). However, it is difficult to achieve quantitative 39 610 40 <sup>41</sup> 611 recovery of PL with this approach. Only  $\sim 62\%$  of total lipids were recovered from clam tissue using 42 43 SPE due to the selective retention of phosphatidylcholine as silica is not rehydrated in these pre-612 44 45 46 613 packed columns (Pernet et al., 2006). Commercial SPE columns are available with a wide range of 47 48 614 chemically-bonded stationary phases. These have great potential for the isolation of specific lipid 49 50 615 classes, yet surprisingly few applications have been described to date. For example, an alternative 51 52 <sub>53</sub> 616 method developed by Kaluzny et al. (1985) using aminopropyl-bonded silica is suitable for separating 54 lipid classes in oyster tissues, though particular care is required to recover the acidic lipids 55 617 56 <sup>57</sup> 618 quantitatively (Kim and Salem, 1990; Pernet et al., 2006). Aminopropyl bonded phases have also 58 59 60<sup>619</sup> been used to separate groups of lipid classes, including neutral lipids such as cholesterol, and non-

acidic PL, and they are especially useful for the isolation of the FFA fraction from lipid extracts 620 (Kaluzny et al., 1985; Kim and Salem, 1990). 621

### Practical recommendations 5.3

Before starting to use a separation protocol, we recommend reading handbooks describing the use 623 <sub>15</sub> 624 and applications of SPE for lipid separation including the choice of eluting solvents (Christie, 1982b; Perkins, 1991), and to consult technical resources provided by the SPE manufacturers. Specifically, 17 625 care must be taken to avoid sample overload and subsequent cross-contamination. This problem can 626 be avoided by knowing the lipid composition of the sample and the carrying capacity of the column 627 <sub>24</sub> 628 prior to SPE. The amount of sample that can be loaded onto a column is governed by the proportion 26 629 of the retained lipids. For example, 2 to 5 mg of PL is considered as the maximum load for SPE of neutral and polar lipids on a 100 mg silica column (Christie, 1982b). Although sample overload leads 630 <sub>31</sub> 631 to cross-contamination, an excess of sorbent can also reduce recovery of the retained analytes. It is 33 632 therefore suggested to experimentally determine the sample load (mass ratio of lipid to sorbent) to optimise purity and recovery (Pernet et al., 2006). In order to use the SPE system, we suggest 633 <sub>38</sub> 634 replacing the silica originally contained in the pre-conditioned column with rehydrated silica (generally 6% m/m). 40 635

<sup>42</sup> 636 Purity and recovery analyses after SPE are crucial, particularly when the sample matrix is new to 637 the laboratory and when the stationary phase changes. Different brands or batches of silica gel may vary in their properties and cross-contamination of fractions may occur (Christie, 1982b). Purity can 47 638 49 639 be evaluated by TLC of lipid classes of each eluted fraction. The simplest way to evaluate recovery 640 is to quantify the lipid class content of samples before and after SPE by TLC and proceed with <sub>54</sub> 641 recovery calculation (i.e., the amount of collected lipid after SPE / the amount of lipids before SPE, as a percent). Alternatively, the recovery purity and efficiency can be estimated by adding an internal 56 642 <sup>58</sup> 643 standard of known mass before SPE. As such, lyso-phosphatidylcholine 12:0 (22.8 µg of FA) was 644 added to the lipid extract before SPE to assess PL recovery in oyster samples (Pernet et al., 2006).

Occurrence of 12:0 was exclusively associated to LPC as this FA is absent in ovsters. A full recovery of LPC following SPE on silica indicated that other PL were fully recovered as LPC is the most strongly retained phospholipid on silica (Pernet et al., 2006). To evaluate the purity of each lipid fraction and the absence of cross-contamination, it is necessary to add one standard based on the least neutral lipid which must remain in the neutral lipid fraction, and another one which corresponds to the least polar lipid which must be retained in the polar lipid fraction. For example, commercially 16 651 available 12:0 diacylglycerol (DG) and 10:0 phosphatidic acid (PA) can be added to the lipid extracts 18 652 of oysters (F. Pernet unpub. data). Because these two shorter chain FA are naturally absent in oysters, their occurrence was exclusively associated with DG and PA standards. The FA 12:0 and 10:0 were expected in neutral and polar lipid fractions, respectively. Note that these standards do not replace 23 654 the traditional 23:0 used for mass quantification of FA (see section 7). In the case of SPE, 23:0 is 25 655 28 656 generally added directly in the elution tubes to avoid passage in the column as this standard would <sub>30</sub> 657 only be distributed in the neutral fraction.

## Transesterification

Except in highly degraded samples, where FFA proportion can reach high values, FA are generally part of more complex lipid molecules, and are linked to glycerol by an ester linkage (e.g., TAG, PL, glycolipids). Therefore, one approach to analyse FA by gas chromatography (GC) is to hydrolyse the ester linkage and to convert the released non-volatile FA into their volatile derivatives, usually FA 16 664 methyl esters (FAME). Saponification followed by methylation is the classical method for preparing 18 665 FAME, and while laborious, it produces FAME without contamination with unsaponifiable lipid compounds (e.g., non-volatiles, sterols, alcohols, hydrocarbons, phthalates and pigments). However, most researchers use transesterification. A number of transesterification methods exist, all based on 25 668 the presence of excess methanol, a catalyst (acid or base) and heat (see Schlechtriem et al., 2008). To <sup>27</sup> 669 be analysed by GC, FAME are then extracted in a GC compatible solvent (often hexane), and the <sub>30</sub> 670 organic phase is washed several times by water to remove acid and glycerol. Produced FAME are stable for months at 4 °C in the dark under nitrogen. Transesterification using ethanol instead of 32 671 methanol is also possible, but less used, leading to the formation of FA ethyl esters. Butanol can also be used as a substitute to methanol to quantify very short chain FA (down to *iso*5:0) by increasing 39 674 aliphatic chain length (Koopman *et al.*, 1996, 2003). Although the use of the boron trifluoride ( $BF_3$ ) 41 675 has been recommended by the AOCS (1989), many catalysts can be used in both acid- and base-catalysed transesterification, with each method having their own advantages and limits.

46<sup>677</sup> The efficiency of these transesterification methods differs as a function of the bound between the aliphatic chains and the glycerol or sphingosine backbones (Christie and Han, 2010)The efficiency 48 678 of these transesterification methods differs as a function of the nature of the aliphatic chains. This is particularly important in aquatic samples because, depending on the matrix, a considerable part of 55 681 these aliphatic chains can be linked to the entire lipid molecule not by an ester linkage, but by a vinyl-<sup>57</sup> 682 ether (e.g., plasmalogens), an ether (e.g., alkyl lipids) or an amide (e.g., sphingolipids) linkage. It is thus important to choose the most pertinent transesterification method with respect to the sample 

nature and the scientific question. For example, the acid-catalysed transesterification of plasmalogens leads to the formation of FAME (from the acyl lipids) and dimethyl acetals (DMA) (from vinyl-ether lipids). DMA are mainly detected in polar lipids but are marginally present in neutral lipids, reflecting the contribution of glyceride ether also named "neutral plasmalogens" (TAG containing at least one vinyl ether bound aliphatic chain). Base-catalysed transesterification of these molecules only leads to the formation of FAME, leaving vinyl ether bound aliphatic chains unreacted (Crackel et al., 1988; 16 690 Cruz-Hernandez et al., 2006). However, attention needs to be paid to the particular procedure 18 691 followed, as base-catalysed transesterification based on ISO standard methodology incorporates an acid wash to neutralise the catalyst. This acidic wash may lead to DMA formation (Gomez-Cortes et al. 2019). Moreover, neither acid- nor base-transesterifications have any effect on ether linkages <sub>23</sub> 693 (Christie 1989). This point is important to consider when analysing samples containing large amounts 25 694 28 695 of alkyl ether lipids, such as alkylglyceryl ether lipids in shark liver oil. Transesterification of FA <sub>30</sub> 696 sphingolipids components is acid-catalysed and is achieved by increasing the reaction time (Eder, 1995; Le Grand et al., 2011). Finally, esterification of FFA is only possible by acid-catalysed 32 697 transesterification (Christie, 2003).

Depending on the scientific question (e.g. nutritional value, trophic relationships, physiological responses), FA transesterification can be realised directly on the biomass (direct transesterification), 39 700 41 701 on a total lipid extract or on lipid fractions, such as polar or neutral lipids, lipid classes (e.g., TAG, phosphatidylcholine) or lipid subclasses (e.g., phosphatidylethanolamine plasmalogen) isolated beforehand. It can be useful to purify FAME by HPLC or TLC before GC injection (Marty et al., 48 704 1992). This prevents the saturation and the degradation of the column through the injection of non-FAME molecules (e.g. non-volatiles, sterols, hydrocarbons, phthalates, pigments) and thus increases its lifespan. Obtained chromatograms are also "cleaner" (no contaminants) and easier to identify.

Boron trifluoride  $(BF_3)$ 6.1

The Lewis acid boron trifluoride (BF<sub>3</sub>) in methanol (12-14%, w/v) is a powerful acidic catalyst for the transesterification of FA. In general, 800 µL to 1 mL of BF<sub>3</sub>-MeOH (12-1414%, w/v) is added to 11 710 a dry lipid extract containing a maximum of 1-4 mg of lipids (Liu, 1994; Carrapiso and García, 2000; Le Grand et al., 2011). This method is fast and efficient (Morrison and Smith, 1964; Carrapiso and García, 2000; Cavonius et al., 2014), and it has been successfully used on marine lipid samples where almost all the lipid classes, including FFA and plasmalogens, were transesterified in 10 min at 100 °C 18 713 (Le Grand et al., 2011; Cavonius et al., 2014). For the sphingolipids, such as sphingomyelin and ceramide aminoethylphosphonate, the transesterification should be prolonged and last for 1.5 h to 5 25 716 h at 100 °C (Eder, 1995; Le Grand et al., 2011).

Heating is generally conducted in a dry bath, water bath or heat block. The higher the temperature used, the shorter the reaction time. An increase in reaction time has no negative effect, provided that no evaporation occurs (Morrison and Smith, 1964). Presence of residual water in the sample limits the acid-catalysed esterification by BF<sub>3</sub> (Sattler *et al.*, 1991). It is thus necessary to dry the sample by either nitrogen evaporation or by addition of anhydrous sodium sulphate (Molnar-Perl and Pinter-Szakacs, 1986).

Because evaporation during the transesterification leads to acid concentration, which degrades FA 41 723 and especially PUFA (Lough, 1964), it is crucial to prevent vial caps from unscrewing when heating samples (Morrison and Smith, 1964). Poor storage conditions and quality of BF<sub>3</sub> cause PUFA degradation (Morrison and Smith, 1964; Christie, 1993). It is recommended to use fresh reagent and 48 726 50 727 to store it at 4 °C or colder (-20 °C). Despite these issues, the use of BF<sub>3</sub>-MeOH for transesterification was referenced as an official method (AOCS, 1973; IUPAC, 1979) and Ackman (1998) showed that 55 729 issues could be avoided following simple rules. Yet, the potential PUFA degradation induced by using 57 730 BF<sub>3</sub> as a transesterification catalyst, the difficulty in purchasing guaranteed anhydrous BF<sub>3</sub>-MeOH, its high cost and its high toxicity have led to a decreasing use of this reagent (Liu, 1994; Carrapiso 

732 and García, 2000; Cavonius *et al.*, 2014). In samples containing very high levels of storage lipids, such as salmon flesh, copepod oil and cod liver, the derivatisation efficiency can be quite low, leading 733 to small but significant differences in some FA proportions (Schlechtriem et al., 2008). For these 734 735 reasons, BF<sub>3</sub> is no longer recommended as an acidic catalyst in the preparation of FAME.

Acidic alternatives to BF<sub>3</sub> 13 736 6.2

751

17 737 A number of alternatives to Lewis acids have been employed (Christie, 1982a). Methanolic HCl (3 N) appears to be the most commonly used reagent for transesterification of lipid-bound FA to FAME 738 in lipids from freshwater plankton (von Elert, 2002; Martin-Creuzburg et al., 2012; Windisch and 739 <sub>24</sub> 740 Fink, 2018), but also from marine plankton (e.g., Troedsson et al., 2005). It can easily be produced by adding 24 ml acetyl chloride to 100 ml of methanol, which leads to the formation of 10% (approx. 26 741 equivalent to 3 N) methanolic HCl. H<sub>2</sub>SO<sub>4</sub> is often recommended (Christie, 1982a; Budge et al., 742 <sub>31</sub> 743 2006), as it can easily be prepared by mixing a small amount of concentrated H<sub>2</sub>SO<sub>4</sub> (~98%) in 33 744 methanol to achieve a 1% solution (Schlechtriem et al., 2008).

745 The most commonly used acid catalysed reagents, such as HCl or H<sub>2</sub>SO<sub>4</sub>, are not associated with 38 746 described for BF<sub>3</sub>. A number of comparisons of acid issues catalysts the for esterification/transesterification have been made (e.g. Medina et al., 1992; Budge and Parrish, 2003; 40 747 <sup>42</sup> 748 Thiemann et al., 2004; Carvalho and Malcata, 2005), with no clear consensus on optimal methods. 749 The best advice is likely to select a method and consistently apply it. As with BF<sub>3</sub>, caution is needed during heating to prevent evaporation. 47 750

**Basic alternatives** 6.3

<sub>55</sub> 752 Several basic catalysts are available (e.g., NaOH, KOH) to transesterify acyl lipids. While a range of procedures have been described (e.g. Christie, 1982a; Medina et al., 1992; Velasco et al., 2002), most 57 753 59 754 are very similar to the acid catalysed method described above with the substitution of the catalyst and

the introduction of an additional step after the reaction is guenched to neutralise the remaining base. 755 All base-catalysed transesterifications proceed very rapidly at room temperature (Christie, 1982a), 756 thereby preserving labile structures (i.e., epoxides, conjugated double bonds) that are often destroyed 757 with harsher acid catalysts. This 'gentler' transesterification is the primary motivation for use of basic 758 10 11 catalysts. As noted above, basic-catalysts are unable to esterify FFA so these approaches should only 759 12 13 760 be used when one can be confident that FFA are present in very low amounts, or else when the analyst 14 15 is targeting esterified FA exclusively (e.g., studies on membrane lipids or storage lipids). 16 761

18 762 Finally, there are a number of official and approved methods that employ combined approaches, using both basic and acidic catalysts (e.g., AOCS, 1989). While at least one of these methods (i.e., 763 AOAC 969.33-1969, 1997) describes the procedure as first saponification with NaOH, followed by 764 methylation with BF<sub>3</sub> in methanol, the short reaction time with NaOH in methanol is actually an 25 765 <sup>27</sup> 766 alkali-catalysed transesterification, followed by acid-catalysed methylation of any FFA that remain <sub>30</sub> 767 (Ackman, 1998). Although direct acid-catalysed transesterification is sufficient for a typical aquatic lipid if performed with sufficient time and heat, the alkali-catalysed step may persist because of its 32 768 769 adoption by official bodies (Ackman, 1998).

### **Direct transesterification** 6.4

<sup>42</sup> 771 The standard procedure for determining FA profiles (e.g. extraction to isolate lipids, followed by transesterification to yield FAME), can be labour-intensive and increases analytical cost. In some 772 cases, studies are only interested into the FA composition of total lipids in samples and therefore 47 773 49 774 perform a direct one-step transesterification that considerably reduces the analytical time (Lewis et al., 2000). This method is realised directly on the sample, and differs from the classical 775 54 776 transesterification by the elimination of the lipid extraction step (Lewis et al., 2000; Castro-Gómez 56 777 et al., 2014; Parrish et al., 2015a).

<sup>58</sup> 778 Different methods have been tested and provided reproducible and similar results to the classical 59 60 779 extraction-transesterification method (Castro-Gómez et al., 2014; Parrish et al., 2015a). Careful consideration is needed when using this approach as it may not be appropriate to the study goal and/or the matrices analysed. It may also be preferentially applied to small and homogenous (representative of the whole) samples. For example, while it is possible to carry out direct analyses on a small amount of tissue, accurate determination of total blubber FA composition in marine mammals was not possible with this approach due to significant variation in FA composition within the layers of the blubber (Thiemann *et al.*, 2008). Although this rapid direct transesterification approach is less timeconsuming and cheaper, once the entire sample is transesterified, it is not possible to redo the analysis, or to analyse the FA composition of different lipid fractions.

6.5 Alternatives to hexane

Hexane, iso-hexane (2-methyl-pentane), or iso-octane are most frequently used to recover FAME after transesterification and before injection. However, hexane is carcinogenic, mutagenic and reprotoxic, and is a hazardous airborne pollutant. Less toxic solvents such as pentane and heptane can be used as alternatives to hexane (Alfonsi *et al.*, 2008). However, recovery of FA from macroalgae is lower with heptane than with hexane, with PUFA tending to be more affected than SFA and MUFA (Le Grand unpub. data). This preliminary result needs to be verified on other matrices. Pentane rather than hexane may also be used as the solvent in the BF<sub>3</sub>/MeOH procedure to reduce the reaction temperature from 85-100 °C to 80 °C to decrease artefact risk (Parrish, 1999).

#### Analysis of fatty acids 7 797

The full process of FAME analysis consists of injection, separation, identification and quantification 798 799 of FAME and each of these steps has to be optimised to achieve high accuracy and precision (see Eder, 1995; Christie, 2003 for review). Gas chromatography (GC) with flame ionisation detection 800 801 (FID) is generally the preferred method for the quantification of FAME in aquatic samples. GC-MS 16 802 methods for FAME quantification can be advantageous on a routine basis when spectrometric 18 803 confirmation of compound identity is required. This is especially useful for complex samples 804 containing contaminants, artifacts or co-eluting compounds. Although these methods compared satisfactorily with GC-FID, they are more complex and tedious to implement and calibrate. Such 805 approaches also require stronger chemistry / spectrometry backgrounds of the user and greater routine 25 806 <sup>27</sup> 807 . P.V.C. maintenance of the instrumentation.

#### 7.1 Injection

<sup>35</sup> 809 Sample injection is a critical step to achieve high accuracy in FAME analysis and we encourage , 38 810 readers to refer to seminal papers of Konrad Grob for a thorough overview of available techniques 40 811 (e.g., Grob, 2007). There are currently three injection techniques. Before being transferred into the 42 812 capillary column, the sample can be (i) evaporated in a permanently hot vaporising chamber (classical 813 vaporising injection), (ii) injected into a cool chamber which is subsequently heated to vaporise the sample (programmed temperature vaporising injection, referred to as PTV), or (iii) directly injected 47 814 49 815 into the column inlet (direct injection or on-column).

51 Once vaporised, the sample can be split (i.e., split injection) with only a small part of the vapour 816 52 53 54 817 entering the column while the rest is vented. This is the most appropriate technique for concentrated 55 samples (e.g., Shantha and Ackman, 1990). Alternatively, the whole vaporised sample is transferred 56 818 57 <sup>58</sup> 819 from the injector to the column without splitting of the sample (i.e., splitless injection). This technique 59 60 820 is particularly appropriate for trace analysis. The major drawback of the split or splitless injection

techniques is the possible discrimination between high- and low-boiling compounds in the sample. 821 822 Fatty acidsA in aquatic samples have a wide range of boiling points and quantification may require application of relative response factors (Grob, 2007). On-column injection avoids discrimination of 823 824 FA and therefore provides the best results. Yet, a large number of aquatic scientists use the vaporising <sup>11</sup> 825 injection method for suitability and flexibility reasons. High-speed injection, high injector 826 temperature (> 220 °C) and proper injector inserts all contribute to decreasing discrimination 16 827 problems. However, we recommend regular checks of FAME discrimination factors using certified 18 828 reference mixtures (e.g. Supelco 37).

Upon injection, FAME are transferred into a wall-coated open tubular (WCOT) capillary column 26 830 allowing separation according to their carbon number, the number and location of the double bonds, 831 <sub>31</sub> 832 and the cis-trans configuration. The column is located in an oven and exposed to temperature ramps ranging from 60 °C to 300 °C (e.g. Tang and Row, 2013 for examples of temperature ramping). The 33 833 <sup>35</sup> 834 carrier gas is generally helium or hydrogen. The resolution capability of the column depends on 38 835 several factors such as polarity of the stationary phase, column length, internal diameter and film thickness. In view of its importance, this information should be reported in detail in the method 40 836 42 837 description of any study.

838 Based on the type of FA being investigated, one of the most important steps is the selection of the stationary phase of the column which influences elution times of FAME, especially PUFA. The 47 839 49 840 polarity of the column ranges from non-polar to extremely polar. On non-polar columns, the elution time generally increases with increasing boiling points of analytes. Therefore, the elution time of 841 <sub>54</sub> 842 FAME increases with chain length and with decreasing unsaturation (e.g., 18:2n-6 elutes first, followed by 18:1*n*-7, and then by 18:0). The major drawback with non-polar columns is that some 56 843 <sup>58</sup> 844 FA isomers (cis-trans) or FA pairs may co-elute. Conversely, non-polar columns exhibit low bleed, 845 long lifetime, retention time stability and high temperature resistance (to 360 °C), which makes their

use suitable for a large range of compounds. These columns are well-suited for separating neutral
compounds such as sterols, alkenones, hydrocarbons. Commonly used non-polar columns are made
of 100% dimethylpolysiloxane or 5% phenyl-95% dimethylpolysiloxane.

Many researchers use polar columns which allow for a better separation of aquatic FA than nonpolar phases, with only some rare and minor co-elutions. Ackman (1986) was a strong advocate of the polyethylene glycol (PEG) phase. Columns coated with PEG are easily recognisable because of their commercial name with the suffix "wax". With this polar phase, FAME continue to elute in order of increasing boiling point, but also roughly in order of increasing numbers of double bonds. However, polar columns are highly sensitive to temperature (max 250 °C), water and oxygen, and are thus less stable over time than non-polar columns. Retention times may also vary (decrease) over time, especially for highly unsaturated compounds. Consequently, peak identification (based on elution time) needs to be checked regularly and rigorously.

An alternative phase consists of substituting 50% dimethylpolysiloxane (non-polar) with the polar cyanopropylmethyl (e.g., Iverson *et al.*, 2004; Pedro *et al.*, 2019). This phase provides similar resolution as PEG phases, although it is much less sensitive to oxygen, resulting in longer column lifetimes. The chemistry of this phase is more influenced by temperature than other polar columns. Separation of co-eluting peaks can sometimes easily be achieved simply by subtle adjustments to oven temperature ramps.

4 7.3 Identification

The most common way to identify FAME by GC-FID analysis is to compare their retention times with those of commercially-available individual purified standards. Among the most used standards for the FA identification in aquatic samples, there are PUFA No. 3, a complex qualitative standard mixture extracted from Menhaden oil, and Supelco® 37 Component FAME Mix, a comprehensive mixture of 37 FAME ranging from 4:0 to 24:1*n*-9. Several long-chain and (highly) unsaturated FAME occurring in some samples are not commercially available, but can be identified using fully

characterised natural products (e.g., the non-methylene interrupted fatty acids typical of marine 871 molluscs in Zhukova and Svetashev, 1986; Ackman, 1989; Kraffe et al., 2004). 872

In addition to these protocols, confirmation of FA identification is best achieved using GC-mass 873 874 spectrometry (GC-MS). Peak identification is achieved using commercial spectral libraries (e.g. The 875 LipidWeb <<u>http://lipidhome.co.uk</u>), or via personal/laboratory FA mass spectral libraries to assist 876 in identification of often complex environmental FAME samples. Further details on various GC-MS protocols together with specific MS information are available in Christie (1989). Briefly, the base 16 877 18 878 peak at m/z 74 is termed the McLafferty rearrangement ion, and is formed by cleavage of the parent 879 FAME molecule beta to the carboxyl group. Where chemical ionisation is used, the mass spectra have a more prominent quasi-molecular ion (MH<sup>+</sup>), and minor ions only at  $[MH - 32]^+$  and [MH -23 880 32 - 18<sup>+</sup>. Because all FA will have the carboxylic acid (or ester) functionality in common, 25 881 27 28 882 knowledge of the molecular mass is particularly valuable in determining basic structure with respect <sub>30</sub> 883 to numbers of carbon atoms and double bonds. There are unfortunately generally no characteristic ions that indicate the position or geometry (i.e., *cis-trans*) of double bonds in positional isomers of 32 884 <sup>34</sup> 885 monounsaturated and polyunsaturated FAME (Christie, 1989).

37<sup>886</sup> Where hydroxyl groups are present on the FAME, conversion of the hydroxyl group to a trimethyl silvl (O-TMSi) ether or other derivative is generally used. Bistrimethylsilvltrifluoroacetamide 39 887 41 888 (BSTFA) is a useful reagent to accomplish this. The high polarity of the free hydroxyl group is reduced by formation of the O-TMSi ether, thereby enhancing the chromatography of the derivative. 889 46 890 Fragmentation of the OTMSi derivative occurs alpha to the carbon containing the hydroxyl group, 48 891 with the main cleavage on the side adjacent to the carboxyl group.

<sup>50</sup> 892 Derivatisation protocols have been developed to provide more detailed position of double bonds 53 893 or geometry information. These include, for example, use of pyrrolidine, 3-pyridyl carbinol (picolinyl ester), dimethyl disulphide (DMDS) and 4,4-dimethyloxazolazine (DMOX) derivatives. An 55 894 57 895 advantage of the use of the DMOX protocol is that the FAME and their corresponding DMOX <sup>5</sup> 60<sup>896</sup> derivatives have the same elution order when run on the same GC column. PUFA DMOX derivatives

can be readily formed using the protocols described in Svetashev, 2011 and Lee Chang *et al.*, 2016. Interesting examples of application of the DMOX protocol have been the characterisation of a novel series of  $C_{18}$  to  $C_{22}$  *trans* n-3 PUFA from a marine haptophyte (Lee Chang *et al.*, 2016) and the 22:4n-900 9t in scallop (Marty *et al.*, 1999). MUFA double bond position and geometry is readily determined by capillary GC-MS of their DMDS derivatives (Nichols *et al.*, 1986). An example of application of the DMDS protocol has been the characterisation of a range of novel  $C_{16}$  and  $C_{18}$  MUFA, including both *cis* and *trans* isomers, from microbial monocultures and complex soil consortia (Nichols *et al.*, 1986). Other derivatisation procedures are also available, although they are not covered here, and are as detailed in Christie (1989).

7.4 Quantification

In GC-FID analyses, the response intensity is based on the number of oxidisable carbon atoms in the analyte; equivalent masses of FA having different carbon chain lengths and/or numbers of double bonds will not produce the same response in the FID (Ackman, 1972). FAME are usually quantified by peak areas, and absolute concentrations are determined by adding an internal standard. Discrimination of FAME may be associated with injection technique and it is often necessary to introduce empirical response factors, determined through careful use of commercially available authentic mixed standards (see section 7.1). A way to estimate the importance of bias from different origins (such as injector, or detector) is for example to analyse a FA mixture of known theoretical mass composition such as the Supelco® 37 Component FAME Mix. It is also possible to analyse a phospholipid with two different aliphatic chains, of different length and saturation (e.g., phosphatidylcholine 16:0/22:6n-3) and confirm that the molar percentage of each FA is 50/50.

The internal standard must not coelute with the FAME, its chemical structure must be close to the majority of the FAME and it must be absent from the sample. A known mass of internal standard should be added either after SPE or before transesterification to account for derivatisation yield and recovery of FAME (see section 5). The most widely used standards are the carboxylic form of 922 nonadecanoic acid (19:0), heneicosanoic (21:0) and tricosanoic acid (23:0). Data are generally 923 expressed as relative (area %, mass % or mole %) or absolute concentrations contents (e.g., mg FA g<sup>-1</sup> sample dry mass). 924

With GC-MS analyses, one approach is to use the total ion chromatogram (TIC) in a similar fashion as peak area is used with GC-FID, by comparing the peak area of an internal standard with peak areas of compounds of interest, and relative response factors determined individually using authentic standards. Note here that response factors vary with structure (carbon and unsaturation numbers, mostly notably), ionisation methods (electronic vs chemical) and mass detector (e.g. Quadrupole vs ion trap) (Dodds et al., 2005; Quehenberger et al., 2011). Consequently, the range of response factors is greater in MS than with FID. Response factors for FA, where standards are not available, are assumed the same as those of structurally similar and available compounds but this is arguable.

Response factors for analytes where standards are not available are assumed to be the same as those of available compounds. Note here that response also varies with structure, likely due to difference in ionisation so calibration remains important. For greater sensitivity, calibration can be based on a single (or multiple) prominent ion(s) using selected ion monitoring (SIM) as a single ion can be scanned many more times in a cycle than the full mass spectrum, giving a higher signal to noise ratio (Dodds et al., 2005; Thurnhofer and Vetter, 2005; Quehenberger et al., 2011). It involves the exclusive acquisition of a group of selected ions during a given period if the identity and retention time of a given analyte have been established through full scan mode. Since fragmentation can vary depending on chain length and degree of unsaturation, careful assignments of selected ions group to analytes and appropriate adjustments of SIM parameters are necessary to achieve accurate guantification and complete discrimination when some FA are co-eluting.

55 945 Quantification of FA can be further improved by using mixtures of isotopically-labelled FA <sup>57</sup> 9<mark>4</mark>6 internal standards (e.g. deuterated FA). These offer the advantage of being identical to the analyte of 59 60 947 interest in all aspects except mass, so that response, as well as matrix effects, of the labelled and

<u>unlabelled component are the same (Quehenberger *et al.*, 2011). The main limitation to this approach is the commercial availability of isotope-labelled fatty acids that could "match" all fatty acids present in aquatic samples. in the spectrum of the FA of interest, typically using an internal standard technique. Another approach with GC-MS is the use of stable isotope dilution methods, where labelled internal standards are used. These offer the advantage of being identical to the analyte of interest in all aspects except mass, so that response, as well as matrix effects, of the labelled and unlabelled component are the same (Quehenberger *et al.*, 2008).</u>

As emphasised by the previous sections, obtaining reliable FA data can be a long and complex 956 957 process. The purpose of this section is therefore to offer guidance in how to valorise these hard-earned 11 958 data in the best possible way, and to use them to shape robust answers to a wide range of scientific questions. As environmental phenomena are inherently complex, a single variable rarely depicts them 959 16 960 in a satisfactory way (Buttigieg and Ramette, 2014). Moreover, FA studies typically deal with datasets 18 961 containing many variables (i.e., individual FA). This section will therefore mostly focus on 962 multivariate analysis. Readers looking for guidance about univariate tests and procedures are <sub>23</sub> 963 encouraged to refer to other publications (e.g. McDonald, 2014).

After adequate standardisation and/or transformation (section 8.1), FA data can be analysed in different, non-mutually exclusive ways. Unconstrained ordination methods (section 8.2) can help visualising the data, and finding out which samples group together according to their similarity in FA composition. In doing so, they allow determining how similar to one another entities such as sampling locations (Hughes et al., 2005; Parrish et al., 2015b), habitats (Hixson et al., 2015) or species (Sardenne et al., 2016) are. These exploratory methods are adequate to identify patterns between samples, as well as FA markers responsible for these patterns. Conversely, investigators can be interested in assessing the influence of one or several previously identified factors on FA composition, *e.g.* to explicitly test whether FA composition is different across multiple experimental treatments, ecological conditions, or species. This can be done through hypothesis testing and/or constrained ordination (section 8.3).

Regardless of the data analysis approach, FA studies commonly rely on so-called "biomarker compounds", i.e., FA (or combinations of FA) whose origin can be assigned to a biogeochemical process, an ecosystem compartment and/or an organism group. When doing so, While this approach has proven very useful and deserves to be routinely applied, it is important to remember that there are

no ubiquitous FA biomarkers, and that their applicability will depend on the studied system or organism (e.g., Feiner *et al.*, 2018). To avoid interpretation biases, biomarker compounds should be chosen carefully with respect to the ecological context and scientific question of interest. When used sensibly, biomarker compounds can be very useful, as proven by their routine use in ecological literature (see (Dalsgaard *et al.*, 2003; Kelly and Scheibling, 2012) for review). This topic has been extensively discussed in other reviews (Dalsgaard *et al.*, 2003; Kelly and Scheibling, 2012) and will not be further elaborated upon here.

8.1 Standardisation and transformation

Choosing standardisation or a prior transformation method for FA data needs to be based on the research questions, as it can have important impacts on the final results and interpretations (Mocking *et al.*, 2012). FA can be expressed as either an absolute <u>concentration content</u> or mass <u>ratiofraction</u>, such as mg.g<sup>-1</sup> of lipids or of tissue, or as relative proportion (%) of total FA mass or molar concentration. Concentrations are commonly used in nutrition studies, and can be useful in controlled feeding experiments (Elsdon, 2010). Proportions of total FA mass is the commonly used standardisation method in trophic studies. It avoids occultation of compositional differences in FA profiles by removing the influence of non-FA components from both the lipid fraction (e.g., polar vs neutral lipids) and the total lipid contents of tissues. Yet, proportion data are generally calculated in relation to identified FA in a sample, which vary across studies and FA analysis methodologies, limiting inter-study comparison.

<sup>49</sup> 999 Choice of data standardisation is interdependent with the choice of data transformation method (if <sup>51</sup> needed) and of applied statistical test (univariate vs. multivariate tests). FA data transformation can <sup>53</sup> be recommended in some cases (e.g., Kelly and Scheibling, 2012), but the overall effect of the <sup>55</sup> procedure is highly variable (Happel *et al.*, 2017). Deciding on a transformation method depends on <sup>58</sup> the test used and its assumptions (e.g., normal distribution of data, homoscedasticity). Although these <sup>60</sup> assumptions can be met for univariate analyses (that test the effect of one or several factors on

individual FA), this is rarely the case for multivariate analyses using large FA datasets, even after 2 1005 1006 transformation (Budge et al., 2006). However, multivariate methods such as unconstrained 1007 ordinations (e.g., principal component analysis, see below) give useful and adequate results when the 9 1008 data are properly transformed (e.g., Legendre and Gallagher, 2001). Moreover, proper testing 10 <sup>11</sup>1009 12 procedures through permutations allows one to circumvent the violation of the multivariate normality 13 14<sup>1010</sup> assumption in constrained ordination methods such as redundancy analysis (RDA, Legendre and 15 161011 Legendre, 2012; see subsection 8.3). 17

181012 Kelly and Scheibling (2012) reviewed some of the most common data transformation methods 19 20 21 used in FA studies, including log-ratio (Budge et al., 2006), arcsine and logit transformations. Arcsine 22 transformation has been widely applied to transform proportional FA data, yet its use in biological 231014 24 251015 analysis has been challenged in some studies. Warton and Hui (2011) suggested that applying logistic 26 <sup>27</sup>1016 28 regression is more appropriate to transform proportion data. It is also important to note that some 29 30<sup>1017</sup> transformations such as log(x) or log(x+1) will give more weight to rare (i.e., found in small amounts) 31 FA, while reducing the influence of the abundant FA (Happel et al., 2017). Depending on the study 321018 33 <sup>34</sup>1019 35 objectives, it is essential to identify clearly whether the scientific question requires emphasising the 36 37</sub>1020 presence and the role of rare FA, or if focusing on the dominant FA will give a more global pattern 38 391021 within and across organisms.

471023 Ordination methods are essential to describe and visualise sample dispersion in a complex 48 491024 multidimensional dataset, and to identify groups of co-varying variables. Those are computed based 50 <sup>51</sup>1025 52 on a matrix of resemblances (distance, dissimilarities, similarities), or derived ranks, rather than raw 53 541026 (or transformed) data. In FA literature, the most commonly used resemblance measure between 55 561027 samples are either the Euclidean distance or Percentage difference (also called Bray-Curtis 57 <sup>58</sup>1028 dissimilarity; Legendre and Legendre, 2012). Euclidean distance is generally preferred over Bray-59 60 1029 Curtis for FA analysis (Happel et al., 2017). However, just like data transformations, the choice of

the resemblance measure can have important impacts on the final results. The choice of matrix will 2 1030 depend on whether a dataset includes null/absent values and if they need to be included in the analysis 1031 1032 according to the study question. The Percentage difference coefficient is double-zero asymmetric, i.e. 9 1033 the absence of one FA from two individuals is not considered as contributing to their similarity. The 10 <sup>11</sup>1034 Euclidean distance, on the contrary, is double-zero symmetric, i.e. will be affected by double null 12 13 14<sup>1035</sup> values (Legendre and Legendre, 2012). Other properties of resemblance measures should also be 15 161036 considered. Choice of the resemblance coefficient has received extensive attention in multivariate 17 181037 community ecology (e.g., Legendre and Legendre, 2012). 19

20 21 Commonly used methods to plot ordinations include principal components analysis (PCA), 231039 principal coordinates analysis (PCoA) and non-metric multidimensional scaling (nMDS). PCA can only use Euclidean distance, while PCoA and nMDS can use any resemblance measure. PCoA and 251040 <sup>27</sup>1041 28 nMDS use the ranks of similarities or dissimilarities matrix to find a spatial arrangement of 29 30<sup>10</sup>42 individuals and represent relationships among them (Kelly and Scheibling, 2012). They have been used to classify and compare FA compositions of consumers across sampling location (Hughes et al., 321043 <sup>34</sup>1044 35 2005; Parrish et al., 2015b), habitats (Hixson et al., 2015) or species (Sardenne et al., 2016). NMDS 36 37<sup>1045</sup> is conceptually simple, generally applicable, and well adapted to ecological data (Clarke and Warwick, 2001). However, it is crucial to take into account the stress coefficient, which is measured 391046 411047 from the relationship between ranks of dissimilarities and ranks of sample distances on the plot. A 43 44 1048 high stress score (> 0.05) indicates that data have been highly distorted to fit in the visualisation, .5 46<sup>1049</sup> which may not be representative and should be considered with caution (Clarke and Warwick, 2001; Buttigieg and Ramette, 2014). PCA also describes relationships among samples, reducing large 481050 <sup>50</sup>1051 51 numbers of variables to a few components that represent most of the variance and that are built by 52 53<sup>1052</sup> combining correlated variables (Budge et al., 2006; Kelly and Scheibling, 2012). It also helps to visualise variables that contribute the most to the dissimilarity among observed groups and FA that 551053 <sup>57</sup>1054 are highly correlated (Budge et al., 2006). After ordination, several procedures (similarity percentage,

also called SIMPER, analysis; comparison of PCA loadings) can be applied to identify FA driving 2 1055 1056 resemblance or dissimilarity among groups (Clarke and Warwick, 2001).

<sup>12</sup>1058 13 Multivariate analyses are commonly applied in ecological studies to discriminate the influence of 14 15<sup>1059</sup> different factors on FA composition, such as physiological, spatial or even temporal variations 16 (Anderson, 2001). Statistical comparison of groups based on FA composition is generally performed 171060 18 191061 through non-parametric or randomisation procedures, as FA datasets rarely match the prerequisites 20 21 22<sup>1062</sup> of parametric statistical tests (Anderson and Walsh, 2013). Analysis of similarity (ANOSIM; Clarke, 23 241063 1993) or permutational analysis of variance (PERMANOVA; Anderson, 2001) are among the most 25 261064 commonly used statistical tests (e.g. Hughes et al., 2005; Hixson et al., 2015; Parrish et al., 2015; 27 28 29 1065 Sardenne et al., 2016; Mathieu-Resuge et al., 2019). ANOSIM uses ranks of pairwise dissimilarities 30 311066 and generates its own statistic by randomisation of rank dissimilarities (Clarke and Warwick, 2001). 32 331067 PERMANOVA tests for differences among group centroids (Anderson, 2001). Both methods are 34 <sup>35</sup>1068 36 affected by dispersion heterogeneity, with ANOSIM being more sensitive than PERMANOVA 37 38<sup>1069</sup> (Anderson and Walsh, 2013). PERMANOVA is unaffected by differences in correlation structure 39 401070 and seems more powerful to detect changes in FA composition. As such, applying ANOSIM is 41 <sup>42</sup>1071 appropriate for a 1-way test (e.g. to compare one species submitted to different diets), but not for 43 44 45<sup>1072</sup> more complex study designs (Kelly and Scheibling, 2012).

Besides hypothesis testing, constrained ordination (e.g., redundancy analysis, RDA) offers a way 471073 48 491074 to extract and summarise variability from a multivariate dataset (FA data) that can be explained by 50 <sup>51</sup>1075 52 one or a set of explanatory variables (e.g., locations, species, diets, etc.). In other words, it allows 53 541076 regression of multiple response variables (FA) on multiple explanatory variables (chosen according 55 561077 to the scientific question). More details on this technique can be found elsewhere (Legendre and 57 <sup>58</sup>1078 Legendre, 2012). 59

8.4 Coupling fatty acids with other ecological markers

When tackling elaborate ecological questions, combining FA with other tracers has proven to be very powerful. Tracers commonly combined with FA include stable isotope ratios of light biogenic 9 1081 elements (Kharlamenko et al., 1995, 2001; Nyssen et al., 2005), as well as contaminants 14<sup>10</sup>83 concentrations (Kainz and Fisk, 2009; Le Croizier et al., 2016). In many cases, those combinations 16<sup>1084</sup> are qualitative. However, modern data analysis frameworks allow quantitative coupling of stable isotope and fatty acids in mixing models (Stock et al., 2018) or ecological niche models (Jackson et <sup>20</sup>1086 21 al., 2011; Sardenne et al., 2016). Such developments hold great promise for ecological research, due to the complementarity of these two methods. More generally, multiple factor analysis (Pagès, 2014)  $\frac{1}{23}$ 1087 or co-inertia analysis (Dray et al., 2003) could provide flexible, widely applicable and quantitative <sup>27</sup>1089 28 ways to couple data from different methods by allowing exploration of the links between multiple 30<sup>1090</sup> multivariate datasets.

<sup>5</sup> 1093 The use of FA analysis in trophic ecology, aquatic nutrition and aquaculture research and development holds considerable promise to improve our understanding of the natural world from 1094 organism taxonomy and physiology to ecosystem functioning. However, the application of this 101095 121096 approach needs to be carefully considered when initiating a new study to ensure that interpretations 14 15 1097 proposed for FA data are relevant and appropriate. Although protocols for lipid analysis are well-171098 described, their application to aquatic sciences often requires modifications to adapt to field 191099 conditions and to sample types. Here, we presented the current state of knowledge on methods <sup>21</sup>1100 22 dedicated to aquatic lipid analyses, from sampling to data treatment. We reviewed sample 23 24<sup>1101</sup> preservation, storage and transport protocols and their effects on lipids, lipid extraction methods, 261102 separation of polar and neutral lipids, transesterification and quantification techniques, and available <sup>28</sup>1103 tools for treatment and statistical analysis of FA data. A simplified flowchart of all these steps is 30 31<sup>1104</sup> represented in Figure 1.

Lipids can be degraded by hydrolysis or oxidation at each stage of the lipid analysis process. We 331105 34 351106 thus encourage processing samples at low temperature under nitrogen atmosphere, and reporting 36 <sup>37</sup>1107 hydrolysis indicators. To limit possible deleterious effects, samples should be handled at the lowest 39 40<sup>1</sup>108 suitable temperature before direct extraction, or be immediately frozen for storage, ideally at -20 °C 41 for less than one month, -80 °C for less than 6 months or under liquid nitrogen with no time limit. 421109 43 44 45 Long-distance transport of samples must be planned well ahead of the start of the study to obtain 46 47<sup>1111</sup> relevant import/export permits and to choose appropriate transportation to maintain sample viability 48 491112 and respect transport regulations and national laws. When possible, we recommend transporting 50 <sup>51</sup>1113 52 samples freshly -frozen under a nitrogen atmosphere. Depending on the objectives of the study. 53 54<sup>1114</sup> samples can be either directly transesterified or undergo extraction to isolate lipids. Lipid extraction 55 561115 is usually performed following well-established methods using either chloroform or dichloromethane 57 581116 (less toxic), mixed with methanol. We strongly encourage scientists to describe in their publication 59 <sup>60</sup>1117 any modifications from original extraction methods.

The lipid extract is either separated into classes or directly transesterified. Separation of polar and neutral lipids prior to transesterification allows for a better interpretation of FA profiles when seeking information on nutritional status and/or physiology of organisms. Special attention should be paid to control for the purity and recovery of each fraction. Non-volatile FA are then transesterified into their volatile derivatives, usually FAME, before being analysed by GC. Acid catalysed reagents, such as HCl or H<sub>2</sub>SO<sub>4</sub> are the most commonly used in aquatic science as they present fewer analytical issues than BF<sub>3</sub>. Hexane is the most widely used solvent to recover FAME after transesterification. Less toxic alternatives are emerging, but are not applicable to all sample types. The analysis and quantification of FAME is usually conducted by GC-FID. FAME are identified by comparing their retention times with those of individual purified standards. They are quantified as relative proportions using peak areas or by absolute concentration when an internal standard was added before transesterification. When necessary, peak identification can be confirmed using GC-MS, but this process may require additional derivatisation steps. Data treatment and statistical analysis of FA should be carefully applied according to the investigated scientific question. We presented common multivariate statistical procedures that we consider widely relevant for FA-related problems. This list is by no means exhaustive. We encourage analysts to explore their data in multiple ways. A good starting point is usually a simple preliminary visualisation of data. This will not only help to check for data quality, but also to make informed choices about subsequent procedures. When interpreting data and statistical results, it is crucial to take into account the studied organisms and/or ecosystems and their specificities.

We <u>believe\_argue\_that</u> methodological consistency, controlled experimentation, and interlaboratory comparison and calibration can lead to enhanced progress in FA studies and are particularly important for comparative studies. Standardisation and optimisation of FA methodologies will ultimately improve our understanding on the role of lipids in biological mechanisms, and will enable us to use them as ecological or physiological tracers as efficiently as possible.

This paper follows a clear objective and provides quite a bit of background information on potential pitfalls when analyzing lipids and their fatty acids. It is also a very critical review and advises the readers how and when methods may be used.

Fig. 1 is excellent and very informative and easy to follow.

The structure of the data analysis section may be improved. So far it reads like a collection of selected multivariate analysis methods that can be used. But before such methods can be used, research questions must be known and then the appropriate method(s) can follow. For the moment I read a series of methods but their application may be better described.

Agreed \_ To assist the reader in choosing which data analysis procedure is best suited to their research questions, we added a section detailing potential applications of described methods at the beginning of section 8 (lines 951-961). As suggested by reviewer 1 in PDF, we refrained from going into too much detail, as we feel that this is beyond the scope of this review, and did not want to provide a "laundry list" of example research questions and matching data analysis procedures.

Fatty acid based diet modeling have been employed in some aquatic consumers (Iverson et al. 2004, Galloway et al. 2014, Bromaghin 2017) and recent methodological development can result accurate estimation of diet contribution (Litmanen et al. 2020 Phil. Trans. R. Soc. B 20190651.). However, FA modeling is based on the fact that consumers are not able synthesize PUFA and limitedly bioconvert long-chain PUFA from short-chain PUFA (Castell et al., Langdon, Sargent, von Elert 2002, Taipale et al. 2011). However, some consumers are able to bioconversion (Kaybeya et al. 2018), and thus usability of fatty acid in diet modeling should be carefully studied for different aquatic consumers.

I consider that the best (accurate and works with low concentrations) results can be achieved when running samples with GCMS and using reference ions for identification and SIM (specific ion mode) for quantification (Taipale et al. 2016 doi: 10.3389/fpls.2016.00212). When using specific ions for quantification co-elution does not matter, since SAFA and PUFA differ in major ions. For beginners, it is easy to make mis-interpretation with GC-FID, but with reference and specific ions beginner can easily succeed. The price of GCMS is not so high anymore and thus many laboratories buy GC-MS instead of GC-FID.

Although the main advantage of the SIM approach is indeed quantification of co-eluting compounds, it only applies to a few chromatographic scenarios. In most cases, we believe that separation of FAME on polar columns and quantification by FID are sufficient and remain easier to implement than GC-MS. We totally agree that mis-interpretation is not uncommon in the literature. But pitfalls also exist when using GC-MS for FAME quantification as it requires some spectrometry and chemistry expertise. To some extent, GC-MS is probably more time consuming for data processing than GC-FID. The number of selected ions to be acquired/recorded in SIM may vary from 6 to 10 ions, gathered in group of 3 ions, in order to cover the structural diversity of FAME in biological samples. Whenever possible, the best is certainly to have a GC equipped with both FID and MS detectors.

Lines 793- separation: it could be also mentioned that sometimes two separate runs are required with different column, e.g. for PUFA and then separating 16 MUFA (cis-trans). Identification of 16 and 18 MUFA requires preparing DMDS adducts (Virtue et al. 1996; J Microbial Methods).

It is also possible to analyse a phospholipid with two different aliphatic chains, of different length and saturation (e.g., phosphatidylcholine 16:0/22:6n-3) and confirm that the molar percentage of each FA is 50/50."

## D Introduction

Lipids and their derived fatty acids (FA) are ubiquitous components of all living organisms. Fatty acidsA generally consist of a linear hydrocarbon chain with a carboxyl group (-COOH) at its end. They are characterised by the length of their carbon chain, generally from 14 to 24 (up to 36) atoms, as well as by the position and the number of double bonds (usually from 0 to 6) that determine their degree of unsaturation. Fatty acidsA are constituents of lipids such as wax and sterol esters (WE, SE), triacylglycerols (TAG), diacylglycerols (DAG), monoacylglycerols (MAG), glycolipids and phospholipids (PL), which show different levels of regulation from ingestion to incorporation. One or several FA are linked either with an ester (or ether / vinyl-ether) bond to an alcohol, mainly glycerol, or with an amide linkage to a long-chain nitrogen base, mainly sphingosine. All of these molecules are categorised as either neutral lipids or polar lipids, with reference to chromatographic methods of lipid class separation but also to their metabolic roles (Christie, 1984). Among neutral lipids, FA-containing compounds include TAG and WE, which are the main storage lipids, whereas DAG, free FA (FFA), and MAG are generally minor constituents. Sterols (both in their free and esterified form) and fatty alcohols (ALC) are also found in neutral lipids. Free FA are rarely present in living organisms, as they may be toxic in high concentrations (Jüttner, 2001). Polar lipids include PL, glycolipids, and sphingolipids. Polar lipids are characterised by a hydrophilic polar head group which, in contrast to their hydrophobic aliphatic chains, allows for the formation of lipid bilayers found in cell membranes. Polar lipid properties are determined by the nature of the polar head groups, the nature of the linkage between the polar head group and aliphatic chain, the length of the carbon chain, as well as the position and the number of double bonds within the FA. These different properties influence the functioning of membrane receptors, the fluidity of membranes, and the stability of the bilayer structure (Hazel and Williams, 1990).

Fatty acids have been analysed in aquatic sciences for over 50 years (Ackman *et al.*, 1968) with the first evidence that FA composition of consumers resembles that of its food (Lee *et al.*, 1971). 10 <sup>76</sup> trophic ecology (Dalsgaard et al., 2003). The concept of FATM is based on the fact that the FA 11 <sub>77</sub> 12 composition of some primary producers is characterised by specific FA that can be transferred to 13 78 upper trophic levels and that aquatic consumers generally lack the ability to synthesise long-chain 15 79 polyunsaturated FA (LC-PUFA,  $\geq C_{20}$ ) and have limited capacity for bioconversion (Castell *et al.*, 16 17 <sup>80</sup> 1972; Langdon and Waldock, 1981; Sargent et al., 1999), although this view has recently been 18 <sub>81</sub> challenged (Kabeya et al., 2018). As such, the FA composition of the food is expected to be reflected 20 82 in the FA profile of the consumer, according to the 'you are what you eat' principle. Today, FA are 21 22 <sup>83</sup> increasingly used to study energy flow in food webs in freshwater, estuarine, coastal and deep-sea, 23 <sub>84</sub> 24 environments in all latitudes, and to examine functional responses to stressors (Kelly and Scheibling, 25 85 2012). However, diet is not the only determinant of the FA composition of aquatic consumers. FA 26 27 <sup>86</sup> composition varies with intrinsic factors such as phylogeny and developmental/reproductive stages ( 28 29 <sup>87</sup> e.g. Galloway and Winder, 2015), and extrinsic factors such as temperature, salinity and hydrostatic 30 <sub>88</sub> pressure (e.g. Wodtke, 1981; Cossins and Macdonald, 1989; Hazel and Williams, 1990), thus 32 89 providing information about physiological condition and habitat type of aquatic organisms (e.g. 33 34 <sup>90</sup> Meyer et al., 2019).

35 <sub>91</sub> 36 The analysis of the FA composition of aquatic organisms is based on procedures originally 37 92 developed for applications in food science and medicine. Briefly, once a sample is collected, it is 38 39 <sup>93</sup> immediately stored in the dark at the lowest possible temperature for the shortest period of time with 40 <sub>94</sub> 41 added antioxidants, and under a nitrogen atmosphere or vacuum. This is to avoid alteration caused by 42 95 enzymes, heat, oxygen and light. Lipids are then extracted, and lipid classes may be separated using 43 44 96 chromatography. Next, derivatisation of FA is performed (methylation in most cases) and FA 45 46 <sup>97</sup> composition is determined by gas chromatography. Finally, data are treated to obtain the quantitative 47 <sub>98</sub> and qualitative FA profiles of the sample (Figure 1). 48

**49** 99 There are likely to be as many variations of procedures as there are laboratories (Parrish, 1999). 51<sup>100</sup> Yet, not all may be applicable to aquatic samples. Procedures involved in sample collection, handling 52<sub>101</sub> 53 and storage, as well as extraction and transesterification steps, can cause biochemical modifications

 of FA and differential loss, leading to false or misleading interpretations. Identifying the most appropriate protocols and the best-practices in FA analysis of aquatic organisms may prove to be a difficult task for novices, as available literature is widespread and highly diverse, and many studies do not fully describe their methodology (e.g., "modified Folch extraction").

Our objective is to provide an up-to-date review of the procedures used for a large number and variety of aquatic samples and laboratories around the world. This review emerged from technical workshops of the conference "*Lipids in the oceans*" held in Brest (France) in November 2018. We answer practical questions that are not necessarily formulated in papers and textbooks, but essential to obtain a reliable FA profile. For example, which organ/tissue of particular specimens should be analysed to be representative in the context of trophic ecology? How are samples properly collected, transported or shipped? What are the most appropriate extraction/transesterification methods or solvent systems? How can one ensure reliable FA identification and quantification? How are FA data analysed? This paper aims to guide both novice and advanced scientists in identifying the most appropriate protocols and best-practices for FA analysis of aquatic samples. We hope that this comparative synthesis will stimulate further international collaborations and facilitate standardisation of lipid analyses.

## 1 Sample handling and storage before lipid extraction

The choice of biological material, its collection and handling techniques, as well as storage methods, are among the most important steps in lipid analysis (Fig. 1). Lipid degradation can occur by hydrolysis (release of FFA from acyl lipids through the enzymatic activity of lipases) or oxidation of carbon-carbon double bonds. In view of the labile nature of lipids, these processes often occur very rapidly, leading to analytical errors and increased sample variability (Christie, 1984). Handling and storage conditions and methods can help minimise sample degradation and analytical bias. Ideally, lipids should be extracted immediately after collection. The second best option is to deep-freeze samples in liquid nitrogen immediately after collection. As sampling of aquatic organisms is often performed in the field and in remote areas, optimal conditions can rarely be achieved, but samples need to be stored adequately. A broad set of procedures exists, including: (i) sample maintenance on ice, (ii) frozen sample storage from -18 °C (standard freezer), to -80 °C (laboratory freezers) and/or to -196 °C (liquid nitrogen), (iii) freeze-drying of samples, or (iv) sample storage in organic solvents for varying storage periods, from a few hours to years prior to analysis. Adequate storage conditions will prevent (or at least limit) the degradation of lipids through hydrolysis and oxidation processes induced by oxygen, temperature, light and/or enzymatic processes. The rate of oxidation and hydrolysis processes (hereafter referred to as "lipid degradation") is likely to vary greatly across species and tissue types. These processes can be revealed by an increase in FFA and a decrease in glycerolipids and polyunsaturated FA (PUFA) in samples (Christie, 1984, see section 4). Here, we provide an overview of different methods used in the literature and discuss their strengths and limitations.

## 1.1 Sample type/ sampling strategy

Aquatic samples are highly diverse, ranging from bacteria to whales, and sampling procedures need to be adapted to the nature of the studied organisms/functional groups. 59 60 phytoplankton are generally collected through water filtration on pre-combusted glass microfiber filters (GF/C or GF/F), while zooplankton can be sorted manually. Such small organisms or functional groups are often directly extracted as whole organisms and stored in solvent. For other organisms such as larger invertebrates, fish, and aquatic mammals, tissue dissection or biopsy is usually required. In the case of multi-purpose samples, it is possible to grind them under liquid nitrogen and subsample the powder (Soudant *et al.*, 1996). Because it is not possible to describe all sampling strategies here, we highly recommend that any study involving lipid and FA analysis must start with a literature review of available information on targeted organisms or on species that are phylogenetically comparable.

## 1 1.2 Sample handling

Maintaining samples on ice is often the first and only practical option available to limit lipid degradation between collection and further processing. Whenever possible, long-lasting dry ice is preferable to water ice. Crushed ice is useful for transportation between locations such as sample transport from the ocean (e.g., small and large vessels) to land, or transport between laboratories. Crushed ice should preferably be used for a few hours, as this method only slows, but does not stop, lipid and FA degradation (Wood and Hintz, 1971; Chaijan *et al.*, 2006), and samples should therefore be frozen as soon as possible. As an alternative, deep-frozen, long-lasting ice packs are a convenient option for short-term storage in the field (e.g., Technilce<sup>TM</sup>). These ice packs maintain temperatures around 0 °C for a few hours in a well-insulated container (L. Couturier pers. obs.). In the particular case of studies on thermal acclimation or adaptation, it may be preferable to maintain samples at environment temperature rather than to cool them before freezing as it may induce a short-term coldresponse. Freezing / thawing samples more than once should be avoided.

#### 1.3 Storage

## 1.3.1 Frozen storage (-20 °C to -196 °C)

Frozen sStoring samples at cryogenic temperaturesage is likely the most common method of **16**166 17 18<sup>167</sup> preservation before performing FA analyses. Yet, depending on the temperature, storage duration and 19 20 type of biological material, this may not be sufficient to limit lipid degradation. It can lead to increased 21<sub>169</sub> FFA and products of oxidation (e.g., Christie, 1984; Gullian-Klanian et al., 2017; Tenyang et al., 22 23170 2019). Lower freezing temperatures and short-term storage are generally associated with lower lipid 24 25<sup>171</sup> degradation (e.g., Baron et al., 2007; Rudy et al., 2016; Gullian-Klanian et al., 2017). The level of lipid degradation in samples is highly dependent on initial freezing temperature and temperature variation during storage, as well as storage duration prior to analyses (Han and Liston, 1987; Ramalhosa et al., 2012; Romotowska et al., 2017). When long-term storage is required, the safest approach is to freeze samples at -80 °C immediately after collection. Although not ideal, long-term storage at -20 °C can be suitable for some species, in particular when samples are kept frozen within the organic extraction solvent. Levels of n-3 and n-6 PUFA in fish muscle, stored at -30 °C and -80°C, did not change for up to 12 months in both TAG and phospholipid fractions (Passi et al., 2005). Shark muscle samples archived for up to 16 years at -20 °C retained their FA profiles, while lipid class composition was not analysed (Meyer et al. 2017). Impacts of frozen storage on FA content and composition are species-specific and can depend on the total lipid content of the organism and tissue (Rudy et al., 2016). Species with high total lipid content (>10% wet weight) must be treated with increased care (low temperature, and short storage period) to avoid changes in FA content during freezing (Rudy et al., 2016; Sardenne et al., 2019).

Based on the literature cited, samples should be stored for less than 6 months prior to analysis at temperature lower than -20 °C when no information is available on the collected biological material. Note that lipid analysis is also possible for samples stored using brine immersion freezing technique (e.g., fisheries-issued material) (Bodin et al., 2014). The sensitivity of lipids to storage varies

according to species and tissues. We therefore recommend evaluating the sensitivity of the samples for which there is no information available before the start of the study. For example, a temporal monitoring of the lipid composition of the biological material of interest at the available storage temperatures will make it possible to define the optimal conservation strategy.

1.3.2 Freeze-drying

20194 Freeze-drying (or lyophilisation) is a low temperature dehydration process of frozen material that is 21 22<sup>195</sup> used to reduce enzymatic activity and thus lipid degradation in samples. Freeze-drying samples 23<sub>196</sub> 24 immediately prior to extraction does not affect lipid class or FA compositions of aquatic animal 25197 tissues (e.g., Dunstan et al., 1993; Murphy et al., 2003; Sardenne et al., 2019). This can be a good 26 27198 alternative to frozen storage, as freeze-dried tissues can be easier to grind and to transport than frozen 28 29<sup>199</sup> tissues. Rehydration may be required to improve the lipid extraction of TAG (e.g., Dunstan et al., 30<sub>200</sub> 1993) and to comply with extraction procedures that rely on a particular proportion of water in the 31 32201 sample. Nonetheless, freeze-dried tissues still need to be carefully stored to prevent lipid degradation. 33 34<sup>202</sup> Storage duration can also have detrimental effects on lipid composition of samples. In fish, crustacean 35<sub>203</sub> 36 and molluscs, the total duration between freeze-drying and lipid extraction should not exceed one 37204 month at -20 °C for quantitative analysis (Sardenne *et al.*, 2019). Similarly, freeze-dried microalgae 38 samples should not be stored for extended period of time. The PUFA proportion of filtered Isochrysis 39<sup>205</sup> 40 41<sup>206</sup> galbana biomass decreased from 36% to 26% after 3 months storage at -76 °C (Babarro et al., 2001). 42207 Proportions of FFA in freeze-dried Phaeodactylum tricornutum increased from 4 mg/g to 6 mg/g DW 43 44208 after 35 days at -20 °C while the degree of oxidation was unaffected (Ryckebosch et al., 2011). 45 46<sup>209</sup> Variability in freeze-dried sample stability/viability for lipid analysis is likely to reflect differences 47<sub>210</sub> 48 of biological material and length/duration of the freeze-drying process.

**49**211 Overall, the quality of the freeze-dried storage depends on: (i) the storage temperature (lower 51<sup>212</sup> temperatures are the best), (ii) the storage duration (shorter durations are better) and (iii) the lipid 52<sub>213</sub> 53 content of samples (lean samples are conserved better than lipid-rich samples). Lipid oxidation in Commented [MO3]: It may be noted here that sampled loaded onto filters can be both freeze-dried, but for subsequent quantification of lipids/FA it is critical that the empty filters are weighed BEFORE loading them with samples. food products occurs more rapidelyrapidly when water activity is high (Labuza et al., 1972). Deep freeze-drying may be a factor promoting lipid degradation through oxidation and specific testing should be considered for aquatic samples. Freeze-drying may offer some benefits when used as a short-term preservation method (e.g., during transport), but it can be expensive (necessary equipment) and time-consuming, while potentially shortening the viability of samples for lipid analyses.

1.3.3 Solvent and fixative storage

24221 One common storage strategy is to directly immerse small organisms such as phytoplankton collected 26222 on filters or small-bodied zooplankton into the lipid extraction solvent (e.g., Marty et al., 1992; 27 28 28 Soudant et al., 1998; Windisch and Fink, 2018). If samples in the extraction solvent (generally 29224 chloroform CHCl<sub>3</sub> and methanol MeOH) are kept in the dark and at low (preferably freezing) 31225 temperatures, lipid degradation is minimal. For microalgae samples, it is advised to deactivate lipases 33<sup>226</sup> by a rapid addition of boiling water or isopropanol prior to extraction (Berge et al., 1995; Budge and 34<sub>227</sub> 35 Parrish, 1999; Ryckebosch et al., 2012).

36228 Synthetic antioxidants (0.01% butylated hydroxytoluene, BHT or 0.1% tertiary 37 38<sup>229</sup> butylhydroquinone, TBHQ) can be added to solvent-stored samples to reduce radical formation and 39<sub>230</sub> 40 oxidative losses of unsaturated lipids (Christie, 2003; Ryckebosch et al., 2012). However, addition 41231 of synthetic antioxidant is unnecessary in samples containing large amount of natural antioxidants 42 43232 such as microalgae (Ryckebosch et al., 2012). Note that BHT elute with short-chain FA and when 44 45<sup>233</sup> present in large quantities, it can overlap with FA of interest.

## 1.3.3.2 Fixatives

Fixatives such as ethanol or formalin are commonly used for biodiversity, taxonomy, morphological, or DNA analyses. The use of fixed samples opens new research opportunities, by making it possible to analyse historical samples collected for purposes other than lipid analysis. influence the chemical composition of the samples and should therefore not be used as a routine procedure for lipid analyses. For example, FA composition of crustacean tissues is altered in formalin-preserved samples, but not in ethanol preserved samples (Phleger *et al.*, 2001). Direct evaluation of fixative effects on lipids are scarce and preliminary tests on different sample types are highly recommended.

## 2 Transport and shipping

The packaging, transport and shipping of samples for lipid analysis is a complex process, driven by safety laws, financial costs, stringent storage conditions, and limited duration of storage. Specific legal regulations, including quarantine, must be followed and they can vary, depending on whether the samples are shipped domestically or internationally, and whether there are stopovers during long distance travels. Shipping recommendations to ensure that samples arrive at their destination in good condition include triple packaging with a rigid outer layer and absorbent material, appropriate cooling, accurate labelling (i.e., name, address, phone number, e-mail address, size and weight of the package), and complete legal documentation (e.g., itemised list of content, permits) (IATA, 2010). This section reviews different options of packaging for shipping and traveling, and gives an overview of the main flying regulations and key legal information.

## 1 2.1 Shipping samples

Long-distance shipping from the sampling site to the laboratory is challenging. Multiple issues need consideration, such as the conservation state of the samples prior to transport (cooled, frozen, deep-frozen, freeze-dried), the distance, the duration and the type of transport. As samples are generally prone to degradation, temperatures must be kept low and oxidative conditions reduced as much as possible. Regardless of the method used, we recommend only to ship a part of the original sample and keep a backup sample when possible, and to take great care in the packaging (minimum empty space, adapted container to accommodate samples and cooling methods).

When possible, frozen samples should be shipped using dry shippers, which are aluminium containers flooded with liquid nitrogen. They contain adsorbent material that prevents spills of liquid nitrogen during shipment and have attached temperature loggers. Samples can be stored in these conditions for several weeks. However, dry shippers may not be readily available at sampling locations or in laboratories. Restrictions for the transport of liquid nitrogen also need to be considered

(e.g. in airplanes or closed vehicles). With transporter authorisation, frozen samples can also be shipped on dry ice depending on transport duration (about 24 h for 2.5 kg of dry ice). Alternatively, deep frozen (-80°C) aqueous ice packs or reusable technical ice packs (e.g. Technilce™, 2019) can be used. A cost-effective option is to freeze-dry samples prior to shipping, as it reduces both the volume to be shipped and the risk of lipid hydrolysis by removing water (see section 1). When dry ice packaging or deep-frozen ice packs are not available at the sampling location, freeze-dried samples should be kept cool and in an oxygen-free atmosphere by flushing containers with nitrogen gas and then sealing prior to packaging and shipping. It is also possible to ship samples with small amounts of solvents with respect to international regulations. Note however that depressurisation in aircrafts promotes solvent leakage (F. Pernet pers. obs). To limit this phenomenon, tubes and caps can be coated with Teflon. Alternatively, preserved and/or extracted samples in solvent may be evaporated and flushed with nitrogen so that dried extracts can be air-transported as frozen biological material. Dried lipid extracts will have to be re-immersed in solvent as soon as possible upon arrival. We however recommend to perform preliminary testing before proceeding with this method.

The gold standard for shipping samples are specialised transport companies that maintain samples on dry ice and guarantee express delivery to the final destination. However, these options may not be practical for some laboratories and/or available for all sampling sites and destinations. Care should be taken when selecting the shipping company, as several unfortunate experiences have shown that some may not be reliable in maintaining the cold transportation chain.

## 2.2 Flying with samples

Although courier is preferable, one might consider putting samples in checked luggage. One of the safest options to transport samples as checked luggage is to use a dry shipper. However, airlines may have different regulations in transporting liquid nitrogen. Non-harmful materials, such as dry ice or technical ice packs are the best option to meet standard luggage regulations (e.g., < 2.5 kg of dry ice

per person) and safety (e.g. the package permitting the release of carbon dioxide gas when transporting dry ice).

Transporting freeze-dried samples kept in a hermetically closed bag (or a thermos filled with ice) is likely the safest and cheapest option. Upon arrival, samples need to be stored in a freezer (preferentially at -80 °C) or immediately put in a solvent solution for lipid extraction (see section 1 for more details on storage duration). Dried lipid extract should be transported as frozen samples and be returned to solvent as soon as possible (see section 2.1). Note that preservation methods requiring flammable solvents (e.g. ethanol, methanol) are not permitted on aircraft within passenger luggage. Recently, the emerging technology of drones opens new opportunities for a rapid and customisable aerial transport of sensitive samples from remote areas to laboratory facilities (e.g., Amukele *et al.*, 2017).

### 2.3 Regulations and permits

Prior to initiating sample collection and considering transporting them, it is necessary to be well informed on import and export regulations that differ widely across countries and studied organisms' status. It can be difficult to obtain the necessary information within custom departments and the paperwork involved. To transport samples out of a country, it is often necessary to follow The Nagoya Protocol on Access and Benefit Sharing. Although it was initially stated that this only applies to samples for molecular research, all transports of tissue for biochemical screening are now included. This applies only for countries that have signed and ratified the Nagoya Protocol.

When samples contain species listed in the Convention on International Trade in Endangered Species of wild fauna and flora (CITES), it is necessary to request an import/export CITES permit from each of the countries involved. This needs to be organised well ahead of sample collection, as it can take up to 3 years to obtain these permits. Additional research permits may be required for the import and export of samples depending on national regulations and target species.

## 3 Lipid extraction

Because of their diverse structures, lipids range from non-polar to highly polar, which makes the selection of a solvent with matching polarity challenging. Methods based on chloroform and methanol (Folch *et al.*, 1957; Bligh and Dyer, 1959) have long been used across a wide range of matrix types with great success. Current alterations in environmental regulations have brought restrictions on the type and amount of solvent usage in laboratories worldwide, encouraging the exploitation of alternative organic solvents and novel eco-friendly methodologies for extraction (e.g., accelerated solvent extraction). Here, we will-review both the well-established techniques and the newly developed methods; we caution readers that full validation must be carried out with a given biological material before adopting any modified or adapted method.

## 5 3.1 Handling cautions

Contamination is an issue that needs to be carefully addressed at every stage of sample handling. It is recommended to<sub>i</sub> i) avoid plastic containers, tools or tips, ii) combust at 450 °C for 6 h or solventrinse all glassware and glass fibre filters, iii) use glass tubes fitted with a Teflon-lined screw caps, iv) prefer amber glassware (or aluminium foil protected) to limit solvent photo-degradation, v) use the highest quality solvents for material/tool cleaning, extraction, or elution, vi) perform blank and reference samples for each batch of samples, and vii) wear laboratory gloves to limit exposure to toxic solvents and cross-contamination.

### 4 3.2 Sample preparation

Regardless of the technique used, extraction of lipids from aquatic samples requires that the solvent penetrates the sample particles so that it can make contact and solubilise the lipids present. The most efficient extractions ensure that the particle size is as small as possible. The gold standard is to

homogenise samples with a ball mill homogenizer (at -196 °C using liquid nitrogen with wet samples). With wet plant or animal tissue samples at macro-scales, this may be as simple as chopping or blending. For wet microalgae, grinding of samples after immersion in solvent works well to break open cells. Small organisms (roughly between 1\_µm and 1 mm; on a filter or notwithout) can also be directly extracted by direct immersion in the solvent mixture. The use of ultrasound-assisted extraction with a probe or bath may aid in breaking cell walls (Pernet and Tremblay, 2003). When samples have been freeze-dried (section 1) for preservation, they may be most conveniently ground with mortar and pestle and it may be necessary to rehydrate prior to carrying out the extraction. Any of these techniques, when applied prior to subsampling for analysis, should also serve to homogenise samples effectively, to ensure representative sampling. These diverse techniques also illustrate the need to adapt the preparatory steps and approach to the sample matrix.

33<sup>350</sup> While many researchers consider Folch et al. (1957) and Bligh and Dyer (1959) extraction methods 34<sub>351</sub> 35 to be similar, based on their use of chloroform and methanol, the two are quite different and were 36352 developed for different objectives. Prior to using those methods, one would do well to read the **38<sup>353</sup>** original publications. Both methods rely on the formation of a biphasic mixture, with a lower layer 39 40<sup>354</sup> principally consisting of chloroform, and containing the isolated lipids, and an upper phase consisting 41<sub>355</sub> of methanol and water and containing the non-lipids. The Folch et al. procedure, using CHCl<sub>3</sub>:MeOH **43**356 (2:1, v:v) and a solvent to sample ratio of at least 20:1, was designed as a general and robust method 44 45<sup>357</sup> for recovery of lipids from animal tissues (i.e., brain, liver, muscle), now applicable to several tissues 46<sub>358</sub> 47 and species with a range of lipid concentration content (Iverson et al. 2001). The Bligh and Dyer 48859 method uses a more polar solvent mixture of CHCl<sub>3</sub>:MeOH: H<sub>2</sub>O) (1:2:0.8, v:v:v) with a 4:1 solvent 50<sup>360</sup> to sample ratio, and was originally developed to rapidly extract lipids, principally polar lipids, from 51<sub>361</sub> 52 lean fish tissues.

59 60 While the Folch et al. method is more complicated to perform, it is more reliable and applicable to almost all sample types. A key aspect of the original Folch et al. method that is often overlooked, is the washing of the bottom phase that contains lipids with a mixture of solvents of the same proportions as originally found in the upper phases. As originally described by Folch et al. (1957), the upper phase consists of CHCl<sub>3</sub>:MeOH:H<sub>2</sub>O at 3:48:47 and while some groups do use a 50:50 MeOH: H<sub>2</sub>O wash as recommended by Christie (1982), it is exceedingly rare that the correct mixture is used. Thus, almost all Folch et al. procedures are best described as 'modified'. The Bligh and Dyer method is easier to carry out, but requires greater consideration of sample type and potential modification of the procedure. For instance, Christie (1982) notes that with high fat samples, an initial pre-extraction with chloroform or diethyl ether is necessary to extract TAG that would otherwise remain unrecovered. The use of the correct proportions of solvents and water are critical for quantitative lipid recovery with both methods. One must take care to adjust the volume of water added when samples with varying moisture contents are analysed (i.e., freeze-dried material vs fresh tissue) and it is often necessary to determine moisture content before beginning extraction.

These basic procedures may require some adjustments depending on lipid matrix before and/or during extraction to increase the yield or specificity of lipids to be analysed. For example, it may include inactivation of lipase, changes of solvent proportions, or cell disruption (e.g. Kumari *et al.*, 2011; Ryckebosch *et al.*, 2012). In a general manner, authors must thus refer to the available literature on their model organisms or matrices. Given the numerous modified extraction procedures that reflect the diversity of aquatic biological matrices, it is also essential that authors detail their protocol in publications when it differs from original methods.

## 3.4 Alternatives to chloroform: toward less toxic solvents

## 3.4.1 Dichloromethane

Many laboratories have become increasingly conscious of a range of occupational health and safety areas in recent decades. Lipid studies historically used chloroform as a major solvent in many steps including extraction. The less toxic dichloromethane  $(CH_2Cl_2)$  has regularly been used instead of chloroform for lipid extraction in many aquatic labs. This replacement originated from food chemistry research (e.g. Chen et al., 1981) and was later formally reported for aquatic samples (e.g., Cequier-Sánchez et al., 2008). Regardless of solvent choice, both dichloromethane and chloroform may degrade on storage to produce HCl and phosgene (Noweir et al., 1972). Phosgene is a much more acutely toxic chemical than either chloroform or dichloromethane, and inhalation can lead to pulmonary oedema (e.g., Snyder et al., 1992). Chloroform degradation or insufficiently stabilised may lead to lipid degradation (i.e., empty chromatograms, including disappearance of the internal standard) (Le Grand and Pernet, pers. obs). To limit phosgene production, chloroform is stabilised with either ethanol or amylene, with ethanol being the more effective stabiliser. Because dichloromethane is less susceptible to degradation than chloroform, it is typically stabilised with alkenes only. Safe lab practices, including restricting solvent use to fume hoods, can effectively avoid risks associated with chlorinated solvents and phosgene formation. In the field, when samples are preserved by direct immersion in solvent, caution is advised.

## 3.4.2 Methyl-tert-butyl ether

Methyl-tert-butyl ether (MTBE) was recently used as a less toxic solvent for the extraction of lipids, but had lower recovery rates than chlorinated solvents (Sheng *et al.*, 2011; Ryckebosch *et al.*, 2012). However, the MTBE based extraction protocol appeared especially well adapted to high-throughput lipidomics, as the lipid extract recovered in the upper phase was cleaner with non-extractible material remaining in the lower phase (Matyash *et al.*, 2008).

#### 3.5 The special case of ethanol preserved samples

13408 The availability of historically preserved samples can often occur for a range of lipid studies (see section 1.3.3.1). However, because ethanol extracts some lipids, the sample and all added ethanol 15<sup>409</sup> 16 410 17 must be used in the lipid extraction protocol (Phleger et al., 2001). When using the Bligh and Dyer 18411 (1959) method, the extraction should be performed with chloroform (or dichloromethane), ethanol 20412 and water, where ethanol replaces methanol. Care is needed when selecting historic ethanol-preserved 22<sup>413</sup> samples for lipid analysis and in which the ethanol preservative may have been replaced during 23<sub>414</sub> 24 storage.

### 26415 3.6 Other methods

29<sub>416</sub> Accelerated Solvent Extraction (ASE, Dionex), also known as Pressurised Fluid Extraction (PFE), is widely used method based on a controlled increase in solvent temperature and pressure during 31/417 33<sup>418</sup> extraction. This process maintains the liquid state of solvents near their supercritical region where 34<sub>419</sub> 35 they have high extraction properties. Several ASE parameters can be adjusted to improve the 36420 extraction, such as temperature, pressure, extraction duration (including pre-heating) and number of 37 38<sup>421</sup> extraction cycles. All of these parameters affect the final solvent volume and can be adjusted 39<sub>422</sub> 40 individually to each sample type to optimise the extraction yields and quality (Schäfer, 1998). This 41423 sample type-specific adjustment enables high extraction efficiency with a low solvent volume and a 42 43<sup>424</sup> short extraction time which is beneficial from a cost and environmental standpoint. Microscale lipid 44 45<sup>425</sup> extraction of fish tissues (100 mg) using ASE was shown to be as quantitatively and qualitatively 46<sub>426</sub> efficient as classical lipid extraction methods (Dodds et al., 2004).

#### 49427 Concluding remarks 3.7

52428 This section did not aim to be exhaustive in describing existing extraction methods. When comparing 54<sup>429</sup> data from different studies, it is important to consider the lipid extraction techniques used as well as 20

handling and storage methods. When working on new matrices and developing new or optimised extraction protocols, we recommend to compare them with Folch et al. (1957) or to Bligh & Dyer (1959) methods, which generally remain the gold standards for lipid recovery. Ensuring complete lipid extraction is critical when applying new protocols. Performing successive lipid extractions on a same sample and measuring its lipid content at each step is a suitable approach to establish at which stage the sample is totally lipid-depleted. Alternatively to successive extractions, the fatty acid methyl ester (FAME) content of the lipid extract can be compared to FAME recovered after direct transesterification (**section 6**). A number of studies have compared the effect of extraction techniques (ASE, Soxhlet, manual) on lipid recovery and FA concentration (e.g. Ewald *et al.*, 1998; Mulbry *et al.*, 2009; Balasubramanian *et al.*, 2013). While all report differences, there is little agreement as to which may be an optimal method, likely due to substantial differences in the followed protocols.

## 4 Indicators of sample degradation

Sample lipids may degrade through hydrolysis of ester bonds or through oxidation of carbon-carbon double bonds. These are two, largely independent processes leading to different compounds or groups of compounds, which may be used as indicators of sample degradation. Therefore, samples showing indicators of hydrolysis may not have been oxidised and *vice versa*. Unless necessary for a short time period (e.g. shipping), purified lipid extracts are susceptible to oxidation and should be kept under N2 atmosphere with solvent (Folch mixture is generally preferred).

4.1 Hydrolysis

The most frequently encountered aquatic lipids are acylglycerols (TAG, PL, and glycolipids) in which FA are esterified to a glycerol backbone. There are also ether lipids that replace one ester bond with an ether linkage or a vinyl ether linkage. Esters of carboxylic acids undergo hydrolysis in a reversible reaction which is catalysed by hydrolase enzymes called esterases present in biological samples. Lipases, a subclass of esterases, are found in animals, plants, fungi, bacteria and even in certain viruses (Beisson *et al.*, 2000). Lipid hydrolysis can be assessed from the FFA content, and from the lysophospholipid content when samples are dominated by PL. Standard measurements of oil quality are the acid value (AV) and FFA content, determined in the oil industry by titration and chromatography, respectively. However, both these measurements are rarely used outside of the industrial context.

Many chromatographic systems have been used over the past years for quantitative analysis of major lipid classes including FFA. F<u>ree</u>FA can be easily separated from extracted lipids by means of well-known methods based on either liquid (LC) or thin layer chromatography (TLC) (reviewed by Fuchs et al., 2011). For example, HPLC with light-scattering detection (HPLC-ELSD) has been successfully used to detect and quantify FFA in fish with a relatively short processing time and highly reproducible measurements (Christie, 1985; Silversand and Haux, 1997). As for LC, a number of

improvements to classic TLC have led to more sophisticated forms, providing better separation 10<sup>467</sup> 11 468 12 efficiencies and quantifications. High-performance thin-layer chromatography (HPTLC) coupled 13469 with densitometry or TLC coupled with flame ionisation detection (TLC-FID, Iatroscan, Shantha, 15470 1992) have also been used to quantify lipid classes and FFA in samples from different origins 16 17<sup>471</sup> including marine (Lochmann et al., 1996; Parrish et al., 2009), terrestrial (Zoumpoulakis et al., 2012) 18<sub>472</sub> and freshwater species (Litz et al., 2017). In food studies, FFA determined by TLC-FID is generally 20473 equivalent to AV (Nishiba et al., 2000). TLC is normally less expensive and less time-consuming 22<sup>474</sup> than HPLC-based methods that can, of course, also be used to provide similar results. 23<sub>475</sub> 24 The hydrolysis index of non-polar acyl lipids (HI) and the lipolysis index of all acyl lipids (LI) can

25476 be used as degradation indicators (Week et al, 1993; Parrish et al 1995) and are calculated as:

38<sub>481</sub> 39 Lipid oxidation mainly occurs through autoxidation when lipids react spontaneously with 40482 atmospheric oxygen. The process is usually autocatalytic, with oxidation products accelerating the 42<sup>483</sup> reaction so that it increases over time. Other catalysts such as light, heat, enzymes and metals lead to 43 484 44 45<sub>485</sub> photo-oxidation, thermal oxidation and enzymatic oxidation. Fatty acidA oxidation is a process in which free radicals cause unsaturated FA to react with molecular oxygen forming acyl **47**486 hydroperoxides, which can then breakdown into a variety of secondary products. A decrease in PUFA 48 49<sup>487</sup> concentration may indicate oxidation as they are particularly susceptible to degradation (Sasaki and 50<sub>488</sub> 51 Capuzzo, 1984).

Lipid hydrolysis may accelerate lipid oxidation due to the formation of FFA that can be substrates for oxidation reactions, as found in vivo (Saponaro et al., 2015). High levels of PUFA in lipids make

59 60 them susceptible to oxidation (Koshio *et al.*, 1994). Oxidation of *n*-3 and *n*-6 PUFA leads to the formation of highly chemically reactive compounds such as malondialdehyde (MDA), 4-hydroxy-2hexenal (4-HHE) and 4-hydroxy-2-nonenal (4-HNE). HHE is an aldehyde derived from n-3 PUFA, and HNE from *n*-6 PUFA.

A number of physical and chemical tests, including instrumental analyses, are available to determine primary and secondary products of oxidation (Shahidi and Zhong, 2005). Oil supplement, food and other industries have a range of standard measurements for determining oil oxidation. These include the internationally recommended peroxide value (PV) and *p*-anisidine value (pAV) (Nichols *et al.*, 2016). For example, PV can be measured by titration and 2-thiobarbituric acid reactive substances (TBARS) by spectrophotometry, and both can be determined using highly precise Fourier transform infrared spectroscopy (FTIR). MDA is commonly monitored using the direct TBARS test (Fernández *et al.*, 1997; Shahidi and Zhong, 2005) and with HPLC (Mendes *et al.*, 2009), while HHE and HNE can be quantified by GC-MS (using chemical ionisation) (Kenmogne-Domguia *et al.*, 2014). Recent analytical developments allowed simultaneous quantification of MDA, HHE and HNE by LC/APCI-MS and LC-MS/MS (Douny *et al.*, 2016; Tullberg *et al.*, 2016). Together with pAV, MDA, HHE and HNE are secondary markers of oxidation while PV, hydroperoxides and conjugated dienes are primary markers. However, it has to be noted that MDA, HHE and HNE quantifications do not necessary reflect PV and anisidine values (Viau *et al.*, 2016).

Sterols are also a source of oxygenated lipids named oxysterols which are sterols bearing a second oxygen functionality. Cholesterol oxidation likely proceeds in conjunction with oxidative decomposition of coexisting PUFA (Ohshima *et al.*, 1993). Cholesterol oxidation products (COP) can be determined by cold saponification of lipids (Ohshima *et al.*, 1993), followed by enrichment of COP by solid-phase extraction (SPE), and then quantification and identification by GC and GC–MS (Pickova and Dutta, 2003).

## 4.3 Concluding remarks

To conclude, we encourage as a minimum the assessing and reporting of hydrolysis indicators as a quality control criterion of sample handling and extraction procedures. The threshold above which sample/data quality should be questioned depends on the sample matrix, the logistical context and the study objective. In any case, the extent of either form of degradation should ideally be evaluated and compared with baseline values from fresh and properly extracted samples.

## 5 Separation of neutral and polar lipids

Fatty acids are incorporated almost unaltered into the storage lipids such as WE, TAG, and ALC, reflecting the FA profiles of the consumed food (Dalsgaard *et al.*, 2003). In contrast, polar lipids are primarily involved in cell membranes which regulate and adjust their FA composition in response to environmental factors like temperature, salinity and hydrostatic pressure (Hazel and Williams, 1990). As such, inference of an organism's diet based on total lipids can be biased by the ratio of FA originating from storage (mostly neutral lipids) and membrane lipids (mostly polar lipids). This ratio varies widely across species, ontogenetic stages, reproduction, nutritional status and tissue types. For example, in small pelagic fish from the Mediterranean, the contribution of TAG stored in the muscle in winter was 1.5%, 5.2% and 47.6% of total lipids for sardine, anchovy and sprat, respectively, the remainder being mostly polar lipids (Pethybridge *et al.*, 2014). This demonstrates that bulk FA composition variations among species can be confounded with variations in lipid class composition. However, many studies in trophic ecology have based their trophic interpretation on the FA composition of bulk lipids without considering the FA distribution between storage and structural lipids.

## 5.1 When should the lipid fraction be separated?

Lipid class composition should be assessed alongside the FA composition to decide whether lipid class separation is necessary for robust dietary inference. Calculating the ratio of storage to structural lipids provides a comprehensive assessment of the cost/benefit of separating neutral and polar lipids fractions. For samples dominated by storage lipids, the FA composition of bulk lipids will mostly mirror the diet, and lipid class fractionation is not mandatory (e.g., fatty fish species, marine mammal blubber, and digestive gland and liver of marine organisms). However, for samples rich in structural lipids, fractionation of lipid classes will provide more reliable dietary indicators. The analysis of FA in polar lipids can inform on nutritional requirements of the study organism and on environmental

Comparing the relative FA proportions in polar and neutral lipids allows the identification of the dietary FA that were selectively retained/eliminated to form cell membranes (e.g. Delaunay *et al.*, 1993; Plante *et al.*, 2007). The unsaturation level of FA and PUFA incorporated in polar lipids is linked to the temperature in ectothermic organisms (Hazel and Williams, 1990; Hall *et al.*, 2002; Pernet *et al.*, 2007) and can be associated with the basal metabolic rate (Hulbert and Else, 1999; Pernet *et al.*, 2008). Consequently, the separate analysis of neutral and polar lipids is a practical approach to address questions on trophic ecology as well as on nutrition and comparative physiology.

To establish trophic relationships of species for which all potential food sources are known, a good strategy is to analyse the FA composition of total lipids in food sources (e.g., prey) and of neutral lipids in consumers to characterise their diet (e.g., predators). Such approach was implemented by the pioneers of the use of FA as trophic indicators (reviewed in Dalsgaard *et al.*, 2003). Alternatively, when study organisms are both prey and predator, or when predator-prey relationships are not wellknown, we suggest at a minimum analysing FA from both neutral and total lipids. Beyond trophic considerations, quantification of lipid classes provides useful information on the physiological condition of organisms (Fraser *et al.*, 1989) and the quality of sample preservation through FFA and lysophospholipids levels (see **section 4**).

## 5.2 Commonly used separation methods

Storage lipids (SE, WE, TAG, DAG, ALC) and FFA are defined as 'neutral' because they are hydrophobic molecules lacking charged groups, whereas PL are defined as 'polar' because they have a charged hydrophilic head. Neutral and polar lipids can be separated from each other by TLC or by adsorption chromatography using either laboratory packed or commercial prepared silica columns. A simple and widely used protocol for separation of neutral and polar lipids consists of a short column of silica prepared in a glass disposable Pasteur pipette plugged with cotton wool (Christie, 1982b). The sample is loaded on the top of the column and washed at low pressure with chloroform (or

dichloromethane) often mixed with methanol, (e.g., CHCl<sub>3</sub>:MeOH, 98:2 v/v) to elute neutral lipids. It can then be washed with acetone to obtain acetone mobile polar lipids, generally dominated by pigments and glycolipids. Finally, a last wash is performed with methanol to yield polar lipids dominated by PL. Some PL with lower polarity may elute with acetone, while some glycolipids with higher polarity may elute with methanol. Including an elution step with acetone may not be necessary in non-plant samples as they contain negligible amounts of glycolipids (Christie, 1982b). Yet, the latter step (elution step with acetone) can be useful in deciphering trophic links in deep-sea fishes (Şen Özdemir *et al.*, 2019). Diethyl-ether:acetic acid (98:2, v/v) can be used to recover pigments, prior to elution of glycolipids and PL (Da Costa *et al.*, 2017). Elutent and sample volumes must be adjusted to optimise separation. It is also important to note that hydration of silica changes the efficiency of retention through a partition effect between bound water and polar lipids (Christie, 1982b). The use of silica hydrated with 6% water (m/m) can improve the recovery of polar lipids from marine bivalves (e.g., Marty *et al.*, 1992; Pernet *et al.*, 2006).

Commercially pre-packed columns connected to a vacuum manifold are widely used instead of the manually packed Pasteur pipette (Christie, 1992; Ruiz-Gutiérrez and Pérez-Camino, 2000). This procedure, often referred to as SPE, is time effective and provides similar results as classic column chromatography (Juaneda and Rocquelin, 1985). However, it is difficult to achieve quantitative recovery of PL with this approach. Only  $\sim$ 62% of total lipids were recovered from clam tissue using SPE due to the selective retention of phosphatidylcholine as silica is not rehydrated in these prepacked columns (Pernet *et al.*, 2006). Commercial SPE columns are available with a wide range of chemically-bonded stationary phases. These have great potential for the isolation of specific lipid classes, yet surprisingly few applications have been described to date. For example, an alternative method developed by Kaluzny et al. (1985) using aminopropyl-bonded silica is suitable for separating lipid classes in oyster tissues, though particular care is required to recover the acidic lipids quantitatively (Kim and Salem, 1990; Pernet *et al.*, 2006). Aminopropyl bonded phases have also

been used to separate groups of lipid classes, including neutral lipids such as cholesterol, and nonacidic PL, and they are especially useful for the isolation of the FFA fraction from lipid extracts.

## 5.3 Practical recommendations

Before starting to use a separation protocol, we recommend reading handbooks describing the use and applications of SPE for lipid separation (Christie, 1982b; Perkins, 1991) and to consult technical resources provided by the SPE manufacturers. Specifically, care must be taken to avoid sample overload and subsequent cross-contamination. This problem can be avoided by knowing the lipid composition of the sample and the carrying capacity of the column prior to SPE. The amount of sample that can be loaded onto a column is governed by the proportion of the retained lipids. For example, 2 to 5 mg of PL is considered as the maximum load for SPE of neutral and polar lipids on a 100 mg silica column (Christie, 1982b). Although sample overload leads to cross-contamination, an excess of sorbent can also reduce recovery of the retained analytes. It is therefore suggested to experimentally determine the sample load (mass ratio of lipid to sorbent) to optimise purity and recovery (Pernet *et al.*, 2006). In order to use the SPE system, we suggest replacing the silica originally contained in the pre-conditioned column with rehydrated silica (generally 6% m/m).

Purity and recovery analyses after SPE are crucial, particularly when the sample matrix is new to the laboratory and when the stationary phase changes. Different brands or batches of silica gel may vary in their properties and cross-contamination of fractions may occur (Christie, 1982b). Purity can be evaluated by TLC of lipid classes of each eluted fraction. The simplest way to evaluate recovery is to quantify the lipid class content of samples before and after SPE by TLC and proceed with recovery calculation (i.e., the amount of collected lipid after SPE / the amount of lipids before SPE, as a percent). Alternatively, the recovery purity and efficiency can be estimated by adding an internal standard of known mass before SPE. As such, lyso-phosphatidylcholine 12:0 (22.8 µg of FA) was added to the lipid extract before SPE to assess PL recovery in oyster samples (Pernet *et al.*, 2006). Occurrence of 12:0 was exclusively associated to LPC as this FA is absent in oysters. A full recovery

of LPC following SPE on silica indicated that other PL were fully recovered as LPC is the most strongly retained phospholipid on silica (Pernet et al., 2006). To evaluate the purity of each lipid fraction and the absence of cross-contamination, it is necessary to add one standard based on the least neutral lipid which must remain in the neutral lipid fraction, and another one which corresponds to the least polar lipid which must be retained in the polar lipid fraction. For example, commercially available 12:0 diacylglycerol (DG) and 10:0 phosphatidic acid (PA) can be added to the lipid extracts of oysters (F. Pernet unpub. data). Because these two shorter chain FA are naturally absent in oysters, their occurrence was exclusively associated with DG and PA standards. The FA 12:0 and 10:0 were expected in neutral and polar lipid fractions, respectively. Note that these standards do not replace the traditional 23:0 used for mass quantification of FA (see section 7). In the case of SPE, 23:0 is generally added directly in the elution tubes to avoid passage in the column as this standard would only be distributed in the neutral fraction.

#### 6 Transesterification

13<sub>635</sub> Except in highly degraded samples, where FFA proportion can reach high values, FA are generally 15636 part of more complex lipid molecules, and are linked to glycerol by an ester linkage (e.g., TAG, PL, 16 17<sup>637</sup> glycolipids). Therefore, one approach to analyse FA by gas chromatography (GC) is to hydrolyse the 18<sub>638</sub> ester linkage and to convert the released non-volatile FA into their volatile derivatives, usually FA 20639 methyl esters (FAME). Saponification followed by methylation is the classical method for preparing 21 22<sup>640</sup> FAME, and while laborious, it produces FAME without contamination with unsaponifiable lipid 23<sub>641</sub> 24 25642 compounds (e.g., non-volatiles, sterols, alcohols, hydrocarbons, phthalates and pigments). However, most researchers use transesterification. A number of transesterification methods exist, all based on 26 27<sup>643</sup> the presence of excess methanol, a catalyst (acid or base) and heat. To be analysed by GC, FAME are 28 29<sup>644</sup> then extracted in a GC compatible solvent (often hexane), and the organic phase is washed several 30<sub>645</sub> times by water to remove acid and glycerol. Produced FAME are stable for months at 4 °C in the dark 32646 under nitrogen. Transesterification using ethanol instead of methanol is also possible, but less used, 33 34<sup>647</sup> leading to the formation of FA ethyl esters. Butanol can also be used as a substitute to methanol to 35<sub>648</sub> 36 quantify very short chain FA (down to iso5:0) by increasing aliphatic chain length (Koopman et al., **37**649 1996, 2003). Although the use of the boron trifluoride ( $BF_3$ ) has been recommended by the AOCS 38 39<sup>650</sup> (1989), many catalysts can be used in both acid- and base-catalysed transesterification, with each 40<sub>651</sub> 41 method having their own advantages and limits.

The efficiency of these transesterification methods differs as a function of the nature of the aliphatic chains. This is particularly important in aquatic samples because, depending on the matrix, a considerable part of these aliphatic chains can be linked to the entire lipid molecule not by an ester linkage, but by a vinyl-ether (e.g., plasmalogens), an ether (e.g., alkyl lipids) or an amide (e.g., sphingolipids) linkage. It is thus important to choose the most pertinent transesterification method with respect to the sample nature and the scientific question. For example, the acid-catalysed transesterification of plasmalogens leads to the formation of FAME (from the acyl lipids) and

dimethyl acetals (DMA) (from vinyl-ether lipids). DMA are mainly detected in polar lipids but are marginally present in neutral lipids, reflecting the contribution of glyceride ether also named "neutral plasmalogens" (TAG containing at least one vinyl ether bound aliphatic chain). Base-catalysed transesterification of these molecules only leads to the formation of FAME, leaving vinyl ether bound aliphatic chains unreacted (Crackel *et al.*, 1988; Cruz-Hernandez *et al.*, 2006). However, attention needs to be paid to the particular procedure followed, as base-catalysed transesterification based on ISO standard methodology incorporates an acid wash to neutralise the catalyst. This acidic wash may lead to DMA formation (Gomez-Cortes et al. 2019). Moreover, neither acid- nor basetransesterifications have any effect on ether linkages (Christie 1989). This point is important to consider when analysing samples containing large amounts of alkyl ether lipids, such as alkylglyceryl ether lipids in shark liver oil. Transesterification of FA sphingolipids components is acid-catalysed and is achieved by increasing the reaction time (Eder, 1995; Le Grand *et al.*, 2011). Finally, esterification of FFA is only possible by acid-catalysed transesterification (Christie, 2003).

Depending on the scientific question (e.g. nutritional value, trophic relationships, physiological responses), FA transesterification can be realised directly on the biomass (direct transesterification), on a total lipid extract or on lipid fractions, such as polar or neutral lipids, lipid classes (e.g., TAG, phosphatidylcholine) or lipid subclasses (e.g., phosphatidylethanolamine plasmalogen) isolated beforehand. It can be useful to purify FAME by HPLC or TLC before GC injection (Marty *et al.*, 1992). This prevents the saturation and the degradation of the column through the injection of non-FAME molecules (e.g. non-volatiles, sterols, hydrocarbons, phthalates, pigments) and thus increases its lifespan. Obtained chromatograms are also "cleaner" (no contaminants) and easier to identify.

6.1 Boron trifluoride (BF<sub>3</sub>)

The Lewis acid boron trifluoride (BF<sub>3</sub>) in methanol (12-14%, w/v) is a powerful acidic catalyst for
 the transesterification of FA. In general, 800 μL to 1 mL of BF<sub>3</sub>-MeOH (14%, w/v) is added to a dry
 lipid extract containing a maximum of 1-4 mg of lipids (Liu, 1994; Carrapiso and García, 2000; Le

Grand *et al.*, 2011). This method is fast and efficient (Morrison and Smith, 1964; Carrapiso and García, 2000; Cavonius *et al.*, 2014), and it has been successfully used on marine lipid samples where almost all the lipid classes, including FFA and plasmalogens, were transesterified in 10 min at 100°C (Le Grand *et al.*, 2011; Cavonius *et al.*, 2014). For the sphingolipids<sub>a</sub> such as sphingomyelin and ceramide aminoethylphosphonate, the transesterification should be prolonged and last for 1.5 h to 5 h at 100°C (Eder, 1995; Le Grand *et al.*, 2011).

Heating is generally conducted in a dry bath, water bath or heat block. The higher the temperature used, the shorter the reaction time. An increase in reaction time has no negative effect, provided that no evaporation occurs (Morrison and Smith, 1964). Presence of residual water in the sample limits the acid-catalysed esterification by  $BF_3$  (Sattler *et al.*, 1991). It is thus necessary to dry the sample by either nitrogen evaporation or by addition of anhydrous sodium sulphate (Molnar-Perl and Pinter-Szakacs, 1986).

Because evaporation during the transesterification leads to acid concentration, which degrades FA and especially PUFA (Lough, 1964), it is crucial to prevent vial caps from unscrewing when heating samples (Morrison and Smith, 1964). Poor storage conditions and quality of BF<sub>3</sub> cause PUFA degradation (Morrison and Smith, 1964; Christie, 1993). It is recommended to use fresh reagent and to store it at 4°C or colder (-20°C). Despite these issues, the use of BF<sub>3</sub>-MeOH for transesterification was referenced as an official method (AOCS, 1973; IUPAC, 1979) and Ackman (1998) showed that issues could be avoided following simple rules. Yet, the potential PUFA degradation induced by using BF<sub>3</sub> as a transesterification catalyst, the difficulty in purchasing guaranteed anhydrous BF<sub>3</sub>-MeOH, its high cost and its high toxicity have led to a decreasing use of this reagent (Liu, 1994; Carrapiso and García, 2000; Cavonius *et al.*, 2014). In samples containing very high levels of storage lipids, such as salmon flesh, copepod oil and cod liver, the derivatisation efficiency can be quite low, leading to small but significant differences in some FA proportions (Schlechtriem *et al.*, 2008). For these reasons, BF<sub>3</sub> is no longer recommended as an acidic catalyst in the preparation of FAME.

13/10 A number of alternatives to Lewis acids have been employed (Christie, 1982a). Methanolic HCl (3

15/11 N) appears to be the most commonly used reagent for transesterification of lipid-bound FA to FAME

17/12 in lipids from freshwater plankton (von Elert, 2002; Martin-Creuzburg *et al.*, 2012; Windisch and
18/13 Fink, 2018), but also from marine plankton (e.g., Troedsson *et al.*, 2005). It can easily be produced
19
20/14 by adding 24 ml acetyl chloride to 100 ml of methanol, which leads to the formation of 10% (approx.
21
21/15 equivalent to 3 N) methanolic HCl. H<sub>2</sub>SO<sub>4</sub> is often recommended (Christie, 1982a; Budge *et al.*,
2006), as it can easily be prepared by mixing a small amount of concentrated H<sub>2</sub>SO<sub>4</sub> (~98%) in
25/17 methanol to achieve a 1% solution (Schlechtriem *et al.*, 2008).

The most commonly used acid catalysed reagents, such as HCl or  $H_2SO_4$ , are not associated with the issues described for BF<sub>3</sub>. A number of comparisons of acid catalysts for esterification/transesterification have been made (e.g. Medina *et al.*, 1992; Budge and Parrish, 2003; Thiemann *et al.*, 2004; Carvalho and Malcata, 2005), with no clear consensus on optimal methods. The best advice is likely to select a method and consistently apply it.

#### 6.3 Basic alternatives

Several basic catalysts are available (e.g., NaOH, KOH) to transesterify acyl lipids. While a range of procedures have been described (e.g. Christie, 1982a; Medina *et al.*, 1992; Velasco *et al.*, 2002), most are very similar to the acid catalysed method described above with the substitution of the catalyst and the introduction of an additional step after the reaction is quenched to neutralise the remaining base. All base-catalysed transesterifications proceed very rapidly at room temperature (Christie, 1982a), thereby preserving labile structures (i.e., epoxides, conjugated double bonds) that are often destroyed with harsher acid catalysts. This 'gentler' transesterification is the primary motivation for use of basic catalysts. As noted above, basic-catalysts are unable to esterify FFA so these approaches should only

10732 be used when one can be confident that FFA are present in very low amounts, or else when the analyst 11<sub>733</sub> 12 is targeting esterified FA exclusively (e.g., studies on membrane lipids or storage lipids). 13734 Finally, there are a number of official and approved methods that employ combined approaches, 1*5*735 using both basic and acidic catalysts (e.g., AOCS, 1989). While at least one of these methods (i.e., 16 17<sup>36</sup> AOAC 969.33-1969, 1997) describes the procedure as first saponification with NaOH, followed by 18<sub>737</sub> methylation with BF<sub>3</sub> in methanol, the short reaction time with NaOH in methanol is actually an 20738 alkali-catalysed transesterification, followed by acid-catalysed methylation of any FFA that remain 22<sup>739</sup> (Ackman, 1998). Although direct acid-catalysed transesterification is sufficient for a typical aquatic 23<sub>740</sub> 24 lipid if performed with sufficient time and heat, the alkali-catalysed step may persist because of its 25741 adoption by official bodies (Ackman, 1998).

**31**743 The standard procedure for determining FA profiles (e.g. extraction to isolate lipids, followed by 33<sup>744</sup> transesterification to yield FAME), can be labour-intensive and increases analytical cost. In some 34<sub>745</sub> 35 cases, studies are only interested into the FA composition of total lipids in samples and therefore 36746 perform a direct one-step transesterification that considerably reduces the analytical time (Lewis et 38747 al., 2000). This method is realised directly on the sample, and differs from the classical 39 40<sup>748</sup> transesterification by the elimination of the lipid extraction step (Lewis et al., 2000; Castro-Gómez 41<sub>749</sub> et al., 2014; Parrish et al., 2015).

**437**50 Different methods have been tested and provided reproducible and similar results to the classical 44 45<sup>751</sup> extraction-transesterification method (Castro-Gómez et al., 2014; Parrish et al., 2015). Careful 46<sub>752</sub> consideration is needed when using this approach as it may not be appropriate to the study goal and/or 47 48753 the matrices analysed. It may also be preferentially applied to small and homogenous (representative 50754 of the whole) samples. For example, while it is possible to carry out direct analyses on a small amount 51<sub>755</sub> 52 of tissue, accurate determination of total blubber FA composition in marine mammals was not 53<sub>756</sub> possible with this approach due to significant variation in FA composition within the layers of the

blubber (Thiemann *et al.*, 2008). Although this rapid direct transesterification approach is less timeconsuming and cheaper, once the entire sample is transesterified, it is not possible to redo the analysis,
or to analyse the FA composition of different lipid fractions.

#### 6.5 Alternatives to hexane

Hexane, iso-hexane (2-methyl-pentane), or iso-octane are most frequently used to recover FAME after transesterification and before injection. However, hexane is carcinogenic, mutagenic and reprotoxic, and is a hazardous airborne pollutant. Less toxic solvents such as pentane and heptane can be used as alternatives to hexane (Alfonsi *et al.*, 2008). However, recovery of FA from macroalgae is lower with heptane than with hexane, with PUFA tending to be more affected than SFA and MUFA (Le Grand unpub. data). This preliminary result needs to be verified on other matrices. Pentane rather than hexane may also be used as the solvent in the BF<sub>3</sub>/MeOH procedure to reduce the reaction temperature from 85-100 °C to 80 °C to decrease artefact risk (Parrish, 1999).

## 7 Analysis of fatty acids

The full process of FAME analysis consists of injection, separation, identification and quantification of FAME and each of these steps has to be optimised to achieve high accuracy and precision (see Eder, 1995; Christie, 2003 for review). Gas chromatography (GC) with flame ionisation detection (FID) is generally the preferred method for the quantification of FAME in aquatic samples.

4 7.1 Injection

Sample injection is a critical step to achieve high accuracy in FAME analysis and we encourage readers to refer to seminal papers of Konrad Grob for a thorough overview of available techniques (e.g., Grob, 2007). There are currently three injection techniques. Before being transferred into the capillary column, the sample can be (i) evaporated in a permanently hot vaporising chamber (classical vaporising injection), (ii) injected into a cool chamber which is subsequently heated to vaporise the sample (programmed temperature vaporising injection, referred to as PTV), or (iii) directly injected into the column inlet (direct injection or on-column).

Once vaporised, the sample can be split (i.e., split injection) with only a small part of the vapour entering the column while the rest is vented. This is the most appropriate technique for concentrated samples (e.g., Shantha and Ackman, 1990). Alternatively, the whole vaporised sample is transferred from the injector to the column without splitting of the sample (i.e., splitless injection). This technique is particularly appropriate for trace analysis. The major drawback of the split or splitless injection techniques is the possible discrimination between high- and low-boiling compounds in the sample. Fatty acidsA in aquatic samples have a wide range of boiling points and quantification may require application of relative response factors (Grob, 2007). On-column injection avoids discrimination of FA and therefore provides the best results. Yet, a large number of aquatic scientists use the vaporising injection method for suitability and flexibility reasons. High-speed injection, high injector temperature (> 220 °C) and proper injector inserts all contribute to decreasing discrimination

problems. However, we recommend regular checks of FAME discrimination factors using certified

reference mixtures

# 7.2 Separation

Upon injection, FAME are transferred into a wall-coated open tubular (WCOT) capillary column allowing separation according to their carbon number, the number and location of the double bonds, and the cis-trans configuration. The column is located in an oven and exposed to temperature ramps ranging from 60 °C to 300 °C (e.g. Tang and Row, 2013 for examples of temperature ramping). The carrier gas is generally helium or hydrogen. The resolution capability of the column depends on several factors such as polarity of the stationary phase, column length, internal diameter and film thickness. In view of its importance, this information should be reported in detail in the method description of any study.

Based on the type of FA being investigated, one of the most important steps is the selection of the stationary phase of the column which influences elution times of FAME, especially PUFA. The polarity of the column ranges from non-polar to extremely polar. On non-polar columns, the elution time generally increases with increasing boiling points of analytes. Therefore, the elution time of FAME increases with chain length and with decreasing unsaturation (e.g., 18:2n-6 elutes first, followed by 18:1n-7, and then by 18:0). The major drawback with non-polar columns is that some FA isomers (*cis-trans*) or FA pairs may co-elute. Conversely, non-polar columns exhibit low bleed, long lifetime, retention time stability and high temperature resistance (to  $360 \,^\circ$ C), which makes their use suitable for a large range of compounds. These columns are well-suited for separating neutral compounds such as sterols, alkenones, hydrocarbons. Commonly used non-polar columns are made of 100% dimethylpolysiloxane or 5% phenyl-95% dimethylpolysiloxane.

Many researchers use polar columns which allow for a better separation of aquatic FA than nonpolar phases, with only some rare and minor co-elutions. Ackman (1986) was a strong advocate of the polyethylene glycol (PEG) phase. Columns coated with PEG are easily recognisable because of

their commercial name with the suffix "wax". With this polar phase, FAME continue to elute in order of increasing boiling point, but also roughly in order of increasing numbers of double bonds. However, polar columns are highly sensitive to temperature (max 250 °C), water and oxygen, and are thus less stable over time than non-polar columns. Retention times may also vary (decrease) over 16 17<sup>822</sup> time, especially for highly unsaturated compounds. Consequently, peak identification (based on elution time) needs to be checked regularly and rigorously.

20824 An alternative phase consists of substituting 50% dimethylpolysiloxane (non-polar) with the polar 21 22<sup>825</sup> cyanopropylmethyl (e.g., Iverson et al., 2004; Pedro et al., 2019). This phase provides similar 23<sub>826</sub> 24 resolution as PEG phases, although it is much less sensitive to oxygen, resulting in longer column 25827 lifetimes. The chemistry of this phase is more influenced by temperature than other polar columns. 27828 Separation of co-eluting peaks can sometimes easily be achieved simply by subtle adjustments to 28 29<sup>829</sup> 4.2 oven temperature ramps.

# 31<sub>830</sub> 32 7.3 Identification

34 831 35 The most common way to identify FAME by GC-FID analysis is to compare their retention times 36832 with those of commercially-available individual purified standards. Among the most used standards 38833 for the FA identification in aquatic samples, there are PUFA No. 3, a complex qualitative standard mixture extracted from Menhaden oil, and Supelco® 37 Component FAME Mix, a comprehensive mixture of 37 FAME ranging from 4:0 to 24:1n-9. Several long-chain and (highly) unsaturated FAME occurring in some samples are not commercially available, but can be identified using fully characterised natural products (e.g., the non-methylene interrupted fatty acids typical of marine molluscs in Zhukova and Svetashev, 1986; Ackman, 1989; Kraffe et al., 2004).

In addition to these protocols, confirmation of FA identification is best achieved using GC-mass spectrometry (GC-MS). Peak identification is achieved using commercial spectral libraries, or via personal/laboratory FA mass spectral libraries to assist in identification of often complex environmental FAME samples. Further details on various GC-MS protocols together with specific

MS information are available in Christie (1989). Briefly, the base peak at m/z 74 is termed the McLafferty rearrangement ion, and is formed by cleavage of the parent FAME molecule beta to the carboxyl group. Where chemical ionisation is used, the mass spectra have a more prominent quasi-molecular ion (MH<sup>+</sup>), and minor ions only at [MH – 32]<sup>+</sup> and [MH – 32 – 18]<sup>+</sup>. Because all FA will have the carboxylic acid (or ester) functionality in common, knowledge of the molecular mass is particularly valuable in determining basic structure with respect to numbers of carbon atoms and double bonds. There are unfortunately generally no characteristic ions that indicate the position or geometry (i.e., *cis-trans*) of double bonds in positional isomers of monounsaturated and polyunsaturated FAME (Christie, 1989).

Where hydroxyl groups are present on the FAME, conversion of the hydroxyl group to a trimethyl silyl (O-TMSi) ether or other derivative is generally used. Bistrimethylsilyltrifluoroacetamide (BSTFA) is a useful reagent to accomplish this. The high polarity of the free hydroxyl group is reduced by formation of the O-TMSi ether, thereby enhancing the chromatography of the derivative. Fragmentation of the OTMSi derivative occurs alpha to the carbon containing the hydroxyl group, with the main cleavage on the side adjacent to the carboxyl group.

Derivatisation protocols have been developed to provide more detailed position of double bonds or geometry information. These include, for example, use of pyrrolidine, 3-pyridyl carbinol (picolinyl ester), dimethyl disulphide (DMDS) and 4,4-dimethyloxazolazine (DMOX) derivatives. An advantage of the use of the DMOX protocol is that the FAME and their corresponding DMOX derivatives have the same elution order when run on the same GC column. PUFA DMOX derivatives can be readily formed using the protocols described in Svetashev, 2011 and Lee Chang *et al.*, 2016. Interesting examples of application of the DMOX protocol have been the characterisation of a novel series of  $C_{18}$  to  $C_{22}$  *trans* n-3 PUFA from a marine haptophyte (Lee Chang *et al.*, 2016) and the 22:4n-9t in scallop (Marty *et al.*, 1999). MUFA double bond position and geometry is readily determined by capillary GC-MS of their DMDS derivatives (Nichols *et al.*, 1986). An example of application of the DMDS protocol has been the characterisation of a range of novel  $C_{16}$  and  $C_{18}$  MUFA, including

both *cis* and *trans* isomers, from microbial monocultures and complex soil consortia (Nichols *et al.*, 1986). Other derivatisation procedures are also available, although they are not covered here, and are as detailed in Christie (1989).

#### 7.4 Quantification

In GC-FID analyses, the response intensity is based on the number of oxidisable carbon atoms in the analyte; equivalent masses of FA having different carbon chain lengths and/or numbers of double bonds will not produce the same response in the FID (Ackman, 1972). FAME are usually quantified by peak areas, and absolute concentrations are determined by adding an internal standard. Discrimination of FAME may be associated with injection technique and it is often necessary to introduce empirical response factors, determined through careful use of commercially available authentic mixed standards (see section 7.1). A way to estimate the importance of bias from different origins (such as injector, or detector) is for example to analyse a FA mixture of known theoretical mass composition such as the Supelco® 37 Component FAME Mix. It is also possible to analyse a phospholipid with two different aliphatic chains, of different length and saturation (e.g., phosphatidylcholine 16:0/22:6*n*-3) and confirm that the molar percentage of each FA is 50/50.

The internal standard must not coelute with the FAME, its chemical structure must be close to the majority of the FAME and it must be absent from the sample. A known mass of internal standard should be added either after SPE or before transesterification to account for derivatisation yield and recovery of FAME (see section 5). The most widely used standards are the carboxylic form of nonadecanoic acid (19:0), heneicosanoic (21:0) and tricosanoic acid (23:0). Data are generally expressed as relative (area %, mass % or mole %) or absolute <u>concentrations\_contents</u> (e.g., mg FA g<sup>-1</sup> sample dry mass).

With GC-MS analyses, one approach is to use the total ion chromatogram in a similar fashion as peak area is used with GC-FID, by comparing the peak area of an internal standard with peak areas of compounds of interest, and relative response factors determined individually using authentic

 standards. Response factors for analytes where standards are not available are assumed to be the same as those of available compounds. Note here that response also varies with structure, likely due to difference in ionisation so calibration remains important. For greater sensitivity, calibration can be based on a single (or multiple) prominent ion(s) in the spectrum of the FA of interest, typically using an internal standard technique. Another approach with GC-MS is the use of stable isotope dilution methods, where labelled internal standards are used. These offer the advantage of being identical to the analyte of interest in all aspects except mass, so that response, as well as matrix effects, of the ne (Qu... labelled and unlabelled component are the same (Quehenberger et al., 2008).

## 8 Data treatment

As emphasised by the previous sections, obtaining reliable FA data can be a long and complex process. The purpose of this section is therefore to offer guidance in how to valorise these hard-earned data in the best possible way, and to use them to shape robust answers to a wide range of scientific questions. As environmental phenomena are inherently complex, a single variable rarely depicts them in a satisfactory way (Buttigieg and Ramette, 2014). Moreover, FA studies typically deal with datasets containing many variables (i.e., individual FA). This section will therefore mostly focus on multivariate analysis.

Regardless of the data analysis approach, FA studies commonly rely on so-called "biomarker compounds", i.e., FA (or combinations of FA) whose origin can be assigned to a biogeochemical process, an ecosystem compartment and/or an organism group. While this approach has proven very useful and deserves to be routinely applied, it is important to remember that there are no ubiquitous FA biomarkers, and that their applicability will depend on the studied system or organism (e.g., Feiner *et al.*, 2018). To avoid interpretation biases, biomarker compounds should be chosen carefully with respect to the ecological context and scientific question of interest. This topic has been extensively discussed in other reviews (Dalsgaard *et al.*, 2003; Kelly and Scheibling, 2012) and will not be further elaborated upon here.

#### 8.1 Standardisation and transformation

Choosing standardisation or a prior transformation method for FA data needs to be based on the research questions, as it can have important impacts on the final results and interpretations (Mocking *et al.*, 2012). FA can be expressed as either an absolute concentration or mass ratio, such as mg.g<sup>-1</sup> of lipids or of tissue, or as relative proportion (%) of total FA mass or molar concentration. Concentrations are commonly used in nutrition studies, and can be useful in controlled feeding experiments (Elsdon, 2010). Proportions of total FA mass is the commonly used standardisation

It avoids occultation of compositional differences in FA profiles by 11<sub>927</sub> 12 removing the influence of non-FA components from both the lipid fraction (e.g., polar vs neutral 13928 lipids) and the total lipid contents of tissues. Yet, proportion data are generally calculated in relation 15929 to identified FA in a sample, which vary across studies and FA analysis methodologies, limiting inter-16 17<sup>930</sup> study comparison.

18<sub>931</sub> Choice of data standardisation is interdependent with the choice of data transformation method (if **20**932 needed) and of applied statistical test (univariate vs. multivariate tests). FA data transformation can 22<sup>933</sup> be recommended in some cases (e.g., Kelly and Scheibling, 2012), but the overall effect of the 23<sub>934</sub> 24 25<sub>935</sub> procedure is highly variable (Happel et al., 2017). Deciding on a transformation method depends on the test used and its assumptions (e.g., normal distribution of data, homoscedasticity). Although these 26 27<sup>936</sup> assumptions can be met for univariate analyses (that test the effect of one or several factors on 28 9<sup>37</sup> 29 individual FA), this is rarely the case for multivariate analyses using large FA datasets, even after 30<sub>938</sub> transformation (Budge et al., 2006). However, multivariate methods such as unconstrained **32**939 ordinations (e.g., principal component analysis, see below) give useful and adequate results when the 33 34<sup>940</sup> data are properly transformed (e.g., Legendre and Gallagher, 2001). Moreover, proper testing 35<sub>941</sub> 36 procedures through permutations allows one to circumvent the violation of the multivariate normality 37942 assumption in constrained ordination methods such as redundancy analysis (RDA, Legendre and 38 39<sup>943</sup> Legendre, 2012; see subsection 8.3).

40<sub>944</sub> 41 Kelly and Scheibling (2012) reviewed some of the most common data transformation methods **42**945 used in FA studies, including log-ratio (Budge et al., 2006), arcsine and logit transformations. Arcsine **44**946 transformation has been widely applied to transform proportional FA data, yet its use in biological 45 46<sup>947</sup> analysis has been challenged in some studies. Warton and Hui (2011) suggested that applying logistic 47<sub>948</sub> regression is more appropriate to transform proportion data. It is also important to note that some **49**949 transformations such as log(x) or log(x+1) will give more weight to rare (i.e., found in small amounts) 50 51<sup>950</sup> FA, while reducing the influence of the abundant FA (Happel et al., 2017). Depending on the study 52<sub>951</sub> 53 objectives, it is essential to identify clearly whether the scientific question requires emphasising the

presence and the role of rare FA, or if focusing on the dominant FA will give a more global pattern within and across organisms.

#### 14<sub>954</sub> Exploring fatty acid data through ordination 8.2

17<sub>955</sub> Ordination methods are essential to describe and visualise sample dispersion in a complex multidimensional dataset, and to identify groups of co-varying variables. Those are computed based on a matrix of resemblances (distance, dissimilarities, similarities), or derived ranks, rather than raw (or transformed) data. In FA literature, the most commonly used resemblance measure between samples are either the Euclidean distance or Percentage difference (also called Bray-Curtis dissimilarity; Legendre and Legendre, 2012). Euclidean distance is generally preferred over Bray-Curtis for FA analysis (Happel et al., 2017). However, just like data transformations, the choice of the resemblance measure can have important impacts on the final results. The choice of matrix will depend on whether a dataset includes null/absent values and if they need to be included in the analysis according to the study question. The Percentage difference coefficient is double-zero asymmetric, i.e. the absence of one FA from two individuals is not considered as contributing to their similarity. The Euclidean distance, on the contrary, is double-zero symmetric, i.e. will be affected by double null values (Legendre and Legendre, 2012). Other properties of resemblance measures should also be considered. Choice of the resemblance coefficient has received extensive attention in multivariate community ecology (e.g., Legendre and Legendre, 2012).

Commonly used methods to plot ordinations include principal components analysis (PCA), principal coordinates analysis (PCoA) and non-metric multidimensional scaling (nMDS). PCA can only use Euclidean distance, while PCoA and nMDS can use any resemblance measure. PCoA and nMDS use the ranks of similarities or dissimilarities matrix to find a spatial arrangement of individuals and represent relationships among them (Kelly and Scheibling, 2012). They have been used to classify and compare FA compositions of consumers across sampling location (Hughes et al., 2005; Parrish et al., 2015), habitats (Hixson et al., 2015) or species (Sardenne et al., 2016). NMDS

is conceptually simple, generally applicable, and well adapted to ecological data (Clarke and Warwick, 2001). However, it is crucial to take into account the stress coefficient, which is measured from the relationship between ranks of dissimilarities and ranks of sample distances on the plot. A high stress score (> 0.05) indicates that data have been highly distorted to fit in the visualisation, which may not be representative and should be considered with caution (Clarke and Warwick, 2001; Buttigieg and Ramette, 2014). PCA also describes relationships among samples, reducing large numbers of variables to a few components that represent most of the variance and that are built by combining correlated variables (Budge *et al.*, 2006; Kelly and Scheibling, 2012). It also helps to visualise variables that contribute the most to the dissimilarity among observed groups and FA that are highly correlated (Budge *et al.*, 2006). After ordination, several procedures (similarity percentage, also called SIMPER, analysis; comparison of PCA loadings) can be applied to identify FA driving resemblance or dissimilarity among groups (Clarke and Warwick, 2001).

## 89 8.3 Multivariate hypothesis tests and modelling

Multivariate analyses are commonly applied in ecological studies to discriminate the influence of different factors on FA composition, such as physiological, spatial or even temporal variations (Anderson, 2001). Statistical comparison of groups based on FA composition is generally performed through non-parametric or randomisation procedures, as FA datasets rarely match the prerequisites of parametric statistical tests (Anderson and Walsh, 2013). Analysis of similarity (ANOSIM; Clarke, 1993) or permutational analysis of variance (PERMANOVA; Anderson, 2001) are among the most commonly used statistical tests (e.g. Hughes *et al.*, 2005; Hixson *et al.*, 2015; Parrish *et al.*, 2015; Sardenne *et al.*, 2016; Mathieu-Resuge *et al.*, 2019). ANOSIM uses ranks of pairwise dissimilarities and generates its own statistic by randomisation of rank dissimilarities (Clarke and Warwick, 2001). PERMANOVA tests for differences among group centroids (Anderson, 2001). Both methods are affected by dispersion heterogeneity, with ANOSIM being more sensitive than PERMANOVA (Anderson and Walsh, 2013). PERMANOVA is unaffected by differences in correlation structure

and seems more powerful to detect changes in FA composition. As such, applying ANOSIM is appropriate for a 1-way test (e.g. to compare one species submitted to different diets), but not for more complex study designs (Kelly and Scheibling, 2012).

Besides hypothesis testing, constrained ordination (e.g., redundancy analysis, RDA) offers a way to extract and summarise variability from a multivariate dataset (FA data) that can be explained by one or a set of explanatory variables (e.g., locations, species, diets, etc.). In other words, it allows regression of multiple response variables (FA) on multiple explanatory variables (chosen according to the scientific question). More details on this technique can be found elsewhere (Legendre and Legendre, 2012).

## 1 8.4 Coupling fatty acids with other ecological markers

When tackling elaborate ecological questions, combining FA with other tracers has proven to be very powerful. Tracers commonly combined with FA include stable isotope ratios of light biogenic elements (Kharlamenko *et al.*, 1995, 2001; Nyssen *et al.*, 2005), as well as contaminant<u>s</u> concentrations (Kainz and Fisk, 2009; Le Croizier *et al.*, 2016). In many cases, those combinations are qualitative. However, modern data analysis frameworks allow quantitative coupling of stable isotope and fatty acids in mixing models (Stock *et al.*, 2018) or ecological niche models (Jackson *et al.*, 2011; Sardenne *et al.*, 2016). Such developments hold great promise for ecological research, due to the complementarity of these two methods. More generally, multiple factor analysis (Pagès, 2014) or co-inertia analysis (Dray *et al.*, 2003) could provide flexible, widely applicable and quantitative ways to couple data from different methods by allowing exploration of the links between multiple multivariate datasets.

## Conclusion

The use of FA analysis in trophic ecology, nutrition and aquaculture research and development holds considerable promise to improve our understanding of the natural world from organism taxonomy and physiology to ecosystem functioning. However, the application of this approach needs to be carefully considered when initiating a new study to ensure that interpretations proposed for FA data are relevant and appropriate. Although protocols for lipid analysis are well-described, their application to aquatic sciences often requires modifications to adapt to field conditions and to sample types. Here, we presented the current state of knowledge on methods dedicated to aquatic lipid analyses, from sampling to data treatment. We reviewed sample preservation, storage and transport protocols and their effects on lipids, lipid extraction methods, separation of polar and neutral lipids, transesterification and quantification techniques, and available tools for treatment and statistical analysis of FA data. A simplified flowchart of all these steps is represented in Figure 1.

Lipids can be degraded by hydrolysis or oxidation at each stage of the lipid analysis process. We thus encourage processing samples at low temperature under nitrogen atmosphere, and reporting hydrolysis indicators. To limit possible deleterious effects, samples should be handled at the lowest suitable temperature before direct extraction, or be immediately frozen for storage, ideally at -20 °C for less than one month, -80 °C for less than 6 months or under liquid nitrogen with no time limit. Long-distance transport of samples must be planned well ahead of the start of the study to obtain relevant import/export permits and to choose appropriate transportation to maintain sample viability and respect transport regulations and national laws. When possible, we recommend transporting samples fresh-frozen under a nitrogen atmosphere. Depending on the objectives of the study, samples can be either directly transesterified or undergo extraction to isolate lipids. Lipid extraction is usually performed following well-established methods using either chloroform or dichloromethane (less toxic), mixed with methanol. We strongly encourage scientists to describe in their publication any modifications from original extraction methods.

1<sup>1049</sup> The lipid extract is either separated into classes or directly transesterified. Separation of polar and 11 1050 12 neutral lipids prior to transesterification allows for a better interpretation of FA profiles when seeking 12051 information on nutritional status and/or physiology of organisms. Special attention should be paid to 13052 control for the purity and recovery of each fraction. Non-volatile FA are then transesterified into their 16 1<sup>1053</sup> volatile derivatives, usually FAME, before being analysed by GC. Acid catalysed reagents, such as 18<sub>054</sub> HCl or H<sub>2</sub>SO<sub>4</sub> are the most commonly used in aquatic science as they present fewer analytical issues **210**55 than BF<sub>3</sub>. Hexane is the most widely used solvent to recover FAME after transesterification. Less 21 2<sup>1056</sup> toxic alternatives are emerging, but are not applicable to all sample types. The analysis and 23 1057 24 quantification of FAME is usually conducted by GC-FID. FAME are identified by comparing their 2£058 retention times with those of individual purified standards. They are quantified as relative proportions 26 2<sup>‡059</sup> using peak areas or by absolute concentration when an internal standard was added before 28 1060 29 transesterification. When necessary, peak identification can be confirmed using GC-MS, but this 3<sub>061</sub> process may require additional derivatisation steps. Data treatment and statistical analysis of FA **312**062 should be carefully applied according to the investigated scientific question. We presented common 33 3<sup>1063</sup> statistical procedures that we consider widely relevant for FA-related problems. This list is by no 3<u>5</u> 1064 36 means exhaustive. We encourage analysts to explore their data in multiple ways. A good starting **31/**065 point is usually a simple preliminary visualisation of data. This will not only help to check for data 3<sup>1066</sup> quality, but also to make informed choices about subsequent procedures. When interpreting data and 40 1067 41 statistical results, it is crucial to take into account the studied organisms and/or ecosystems and their 42068 specificities.

**41**069 We believe that methodological consistency, controlled experimentation, and interlaboratory 45 1070 46 comparison and calibration can lead to enhanced progress in FA studies and are particularly important for comparative studies. Standardisation and optimisation of FA methodologies will ultimately improve our understanding on the role of lipids in biological mechanisms, and will enable us to use them as ecological or physiological tracers as efficiently as possible.
