# VOLUME OF THE MINKOWSKI SUMS OF STAR-SHAPED SETS

#### Abstract

For a compact set $A \subset \mathbb{R}^{d}$ and an integer $k \geq 1$, let us denote by $$
A[k]=\left\{a_{1}+\cdots+a_{k}: a_{1}, \ldots, a_{k} \in A\right\}=\sum_{i=1}^{k} A
$$ the Minkowski sum of $k$ copies of $A$. A theorem of Shapley, Folkmann and Starr (1969) states that $\frac{1}{k} A[k]$ converges to the convex hull of $A$ in Hausdorff distance as $k$ tends to infinity. Bobkov, Madiman and Wang (2011) conjectured that the volume of $\frac{1}{k} A[k]$ is non-decreasing in $k$, or in other words, in terms of the volume deficit between the convex hull of $A$ and $\frac{1}{k} A[k]$, this convergence is monotone. It was proved by Fradelizi, Madiman, Marsiglietti and Zvavitch (2016) that this conjecture holds true if $d=1$ but fails for any $d \geq 12$. In this paper we show that the conjecture is true for any star-shaped set $A \subset \mathbb{R}^{d}$ for arbitrary dimensions $d \geq 1$ under the condition $k \geq d-1$. In addition, we investigate the conjecture for connected sets and present a counterexample to a generalization of the conjecture to the Minkowski sum of possibly distinct sets in $\mathbb{R}^{d}$, for any $d \geq 7$.


## 1. Introduction

The Minkowski sum of two sets $K, L \subset \mathbb{R}^{d}$ is defined as $K+L=\{x+y: x \in$ $K, y \in L\}$, where, for brevity, we set $A[k]=\sum_{i=1}^{k} A$, for any $k \in \mathbb{N}$ and any compact set $A \subset \mathbb{R}^{d}$. Since Minkowski sum preserves the convexity of the summands and the set $\frac{1}{k} A[k]$ consists in some particular convex combinations of elements of $A$, the containment $\frac{1}{k} A[k] \subseteq$ conv $A$, and, for the special case of convex sets, the equality $\frac{1}{k} A[k]=\operatorname{conv} A$ trivially holds; here conv $A$ denotes the convex hull of $A$. These observations suggest that for any compact set $A$, the set $\frac{1}{k} A[k]$ looks "more convex" for larger values of $k$. This intuition was formalized by Starr [St1, St2], crediting also Shapley and Folkman, and independently by Emerson and Greenleaf [EG], by proving that the set $\frac{1}{k} A[k]$ approaches conv $A$ in Hausdorff distance as $k$ approaches infinity and by giving bounds on the speed of this convergence (we refer to [FMMZ2] for more discussion of this fact).

A further step in the investigation of the sequence $\left\{\frac{1}{k} A[k]\right\}$ is to examine the monotonicity of this convergence. Whereas this sequence is clearly not monotonous

[^0]in terms of containment, the main object of this paper is the following conjecture of Bobkov, Madiman, Wang BMW], relating the volumes of the elements of the sequence, and in which $\operatorname{vol}(K)$ denotes the Lebesgue measure (volume) of the measurable set $K \subset \mathbb{R}^{d}$.

Conjecture 1 (Bobkov-Madiman-Wang). Let $A$ be a compact set in $\mathbb{R}^{d}$ for some $d \in \mathbb{N}$. Then the sequence

$$
\left\{\operatorname{vol}\left(\frac{1}{k} A[k]\right)\right\}_{k \geq 1}
$$

is non-decreasing in $k$.
Equivalently, this conjecture asks whether for any integer $k \geq 1$ and compact set $A \subset \mathbb{R}^{d}$, the following inequality holds

$$
\begin{equation*}
\operatorname{vol}\left(\frac{1}{k} A[k]\right) \leq \operatorname{vol}\left(\frac{1}{k+1} A[k+1]\right) \tag{1}
\end{equation*}
$$

This inequality trivially holds for any compact set $A$ if $k=1$ since $A \subset \frac{1}{2} A[2]$. In the same way, it is easy to find monotone subsequences of the sequence $\left\{\operatorname{vol}\left(\frac{1}{k} A[k]\right)\right\}_{k \geq 1}$ by the same argument; one such example is $\left\{\operatorname{vol}\left(\frac{1}{2^{m}} A\left[2^{m}\right]\right)\right\}_{m \geq 0}$. On the other hand, even the first nontrivial case; that is, the inequality $\operatorname{vol}\left(\frac{1}{2} A[2]\right) \leq \operatorname{vol}\left(\frac{1}{3} A[3]\right)$ seems to require new methods to approach. Conjecture 1 was partially resolved in [FMMZ1, FMMZ2, where, following the approach of GMR, the authors proved it for any 1-dimensional compact set $A$, but constructed counterexamples in $\mathbb{R}^{d}$ for any $d \geq 12$. More precisely, they showed that for every $k \geq 2$, there is $d_{k} \in \mathbb{N}$ such that for every $d \geq d_{k}$ there is a compact set $A \subset \mathbb{R}^{d}$ such that $\operatorname{vol}\left(\frac{1}{k} A[k]\right)>$ $\operatorname{vol}\left(\frac{1}{k+1} A[k+1]\right)$. In particular, one has $d_{2}=12$, whence Conjecture 1 fails for $\mathbb{R}^{d}$ if $d \geq 12$.

Our goal is to find additional conditions on $A$ and $k$ under which the statement in Conjecture 1. or more precisely when the inequality (1) is satisfied.

In the paper, for any set $A \subset \mathbb{R}^{d}$ we denote by $\operatorname{dim} A$ the dimension of the smallest affine subspace containing $A$, and for any $p, q \in \mathbb{R}^{d}$, we denote the closed segment with endpoints $p, q$ by $[p, q]$. To state our main result, let us recall the following well-known concept.
Definition 1. A nonempty set $S \subset \mathbb{R}^{d}$ is called star-shaped with respect to a point $p$ if for any $q \in S$, we have $[p, q] \subseteq S$.

Our main result is the following.
Theorem 1. Let $d \geq 2$ and $k \geq d-1$ be positive integers. Then for any compact, star-shaped set $S \subset \mathbb{R}^{d}$ we have

$$
\operatorname{vol}\left(\frac{1}{k+1} S[k+1]\right) \geq \operatorname{vol}\left(\frac{1}{k} S[k]\right)
$$

with equality if only if $\frac{1}{k} S[k]=\operatorname{conv}(S)$.
We feel it is worth noting that the compact sets $A$ constructed in FMMZ2] as counterexamples to Conjecture 1 are star-shaped, which makes Theorem 1 fairly unexpected.

We prove Theorem 1 in Section 2 In Section 3 we adapt our techniques to investigate connected sets. Our main result in this section is summarized in Theorem 2. Finally, in Section 4 we collect some additional remarks and questions, and, in particular, we construct low dimensional counterexamples to a generalization of Conjecture 1, which also appeared in BMW.

## 2. Conjecture 1 for star-shaped sets: the proof of Theorem 1

We start this section with a couple of Lemmata which are needed for the proof. Throughout this section, we denote $X_{d}(t)=\left\{\left(x_{1}, \ldots, x_{d}\right) \in \mathbb{N}^{d}: x_{1}+\ldots+x_{d}=t\right\}$ and $N_{d}(t)=\operatorname{card} X_{d}(t)$ to be the number of elements of $X_{d}(t)$.

Lemma 1. For any integer $t \geq 1$, and $d \geq 2$, we have $N_{d}(t)=\binom{t+d-1}{d-1}$.
Proof. If $d=2$, then, clearly, $N_{2}(t)=t+1=\binom{t+2-1}{1}$. On the other hand, by induction, we have

$$
N_{d}(t)=\sum_{s=0}^{t} N_{d-1}(s)=\sum_{s=0}^{t}\binom{s+d-2}{d-2}=\binom{t+d-1}{d-1}
$$

Lemma 2. Let o be the origin of $\mathbb{R}^{d},\left(p_{1}, \ldots, p_{d}\right)$ be a basis of $\mathbb{R}^{d}$, and, let $B=$ $\bigcup_{i=1}^{d}\left[o, p_{i}\right]$. Consider $M \subset \mathbb{R}^{d}$ such that $B[k] \subseteq M \subseteq k \operatorname{conv}(B)$, then

$$
\begin{equation*}
\operatorname{vol}\left(\frac{1}{k+1}(M+B)\right) \geq \operatorname{vol}\left(\frac{1}{k} M\right) \tag{2}
\end{equation*}
$$

where, equality holds if and only if $M=k \operatorname{conv}(B)$. Furthermore, if $\operatorname{vol}\left(\frac{1}{k} M\right) \geq$ $\operatorname{vol}\left(\frac{1}{k+1}(M+B)\right)-\delta$ for some $\delta \geq 0$, then $\operatorname{vol}(M) \geq \operatorname{vol}(k \operatorname{conv}(B))-C(d, k) \delta$ for some constant $C(d, k)$ depending only on $d$ and $k$.

Proof. Since the inequality (2) is independent of a non-degenerate linear transformation applied to $B$ and $M$ simultaneously, we may assume that $\left(p_{1}, \ldots, p_{d}\right)$ is the canonical basis of $\mathbb{R}^{d}$. Let

$$
V(t)=\operatorname{vol}\left\{\left(x_{1}, \ldots, x_{d}\right) \in[0,1]^{d}: x_{1}+\ldots+x_{d} \leq t\right\}
$$

Let $C_{i}=i+[0,1]^{d}, i \in \mathbb{Z}^{d}$ be the unit cube cells of the lattice $\mathbb{Z}^{d}$, and set $\mu_{i}=\operatorname{vol}\left(C_{i} \cap M\right)$, and $\lambda_{i}=\operatorname{vol}\left(C_{i} \cap(M+B)\right)$.

Note that for any $i \in X_{d}(t), \operatorname{vol}\left(C_{i} \cap k \operatorname{conv}(B)\right)$ is independent of $i$, namely it is equal to 1 , if $t \leq k-d$, and to $V(k-t)$ if $t=k-d+1, \ldots, k-1$. A similar statement holds for $\operatorname{vol}\left(C_{i} \cap(k+1) \operatorname{conv}(B)\right)$. The number of unit cells contained in $k \operatorname{conv}(B)$ is equal to the number of the solutions of the inequality $x_{1}+x_{2} \ldots+x_{d} \leq k$, where each variable is a positive integer, and thus, it is $\binom{k}{d}$. This yields that the volume of these cells is $k^{\underline{d}} V$, where $k^{\underline{d}}=k(k-1) \ldots(k-d+1)$, and $V=\operatorname{vol}(\operatorname{conv} B)=\frac{1}{d!}$.

Thus,

$$
\begin{equation*}
\operatorname{vol}(M)=k^{\underline{d}} V+\sum_{t=k-d+1}^{k-1} \sum_{i \in X_{t}} \mu_{i}, \tag{3}
\end{equation*}
$$

and

$$
\operatorname{vol}(M+B)=(k+1)^{\underline{d}} V+\sum_{t=k-d+2}^{k} \sum_{i \in X_{t}} \lambda_{i}
$$

In the following step, we give a lower bound on the $\lambda_{i}$ 's depending on the values of the $\mu_{i}$ 's. We say that $i \in X_{d}(t)$ and $i^{\prime} \in X_{d}(t+1)$ are adjacent if the corresponding cells $C_{i}$ and $C_{i^{\prime}}$ have a common facet, or in other words, if $i^{\prime}-i$ coincides with one of the standard basis vectors $p_{j}$. In this case we write $i i^{\prime} \in I$. Let $i \in X_{d}(t)$, and let $S=M \cap C_{i}$. Then, for every $j=1,2, \ldots, d, S+p_{j} \subset(M+B) \cap C_{i^{\prime}}$ with $i^{\prime}=i+p_{j}$. Thus, for any $i \in X_{d}(t+1)$,

$$
\begin{equation*}
\lambda_{i} \geq \max \left\{\mu_{i^{\prime}}: i^{\prime} \in X_{d}(t) \text { is adjacent to } i\right\} \tag{4}
\end{equation*}
$$

Note that the right-hand side of this inequality is not less than any convex combination of the corresponding $\mu_{i^{\prime}} \mathrm{s}$. We show that, using a suitable convex combination for each $i \in X_{d}(t+1)$ this inequality implies that

$$
\begin{equation*}
\sum_{i \in X_{d}(t+1)} \lambda_{i} \geq \frac{t+d}{t+1} \sum_{i \in X_{t}} \mu_{i} \tag{5}
\end{equation*}
$$

Consider some $i=\left(i_{1}, i_{2}, \ldots, i_{d}\right) \in X_{d}(t+1)$. Then the indices in $X_{d}(t)$ adjacent to $i$ are all of the form $i-p_{j}$ for some $i=1,2, \ldots, d$. Furthermore, $i-p_{j}$ is adjacent to $i$ iff $i_{j} \geq 1$, or in other words, iff $i_{j} \neq 0$. Now, for any $i^{\prime} \in X_{d}(t)$ adjacent to $i$ we set $\alpha_{i i^{\prime}}=\frac{i_{j}}{t+1}$, where $i-i^{\prime}=p_{j}$ (cf. Figure 1). Then, since $i \in X_{d}(t+1)$, we clearly have $1=\sum_{j=1}^{d} \frac{i_{j}}{t+1}=\sum_{i^{\prime} \in X_{d}(t), i i^{\prime} \in I} \alpha_{i i^{\prime}}$. Thus, by 4), we have

$$
\begin{equation*}
\lambda_{i} \geq \sum_{i^{\prime} \in X_{d}(t), i i^{\prime} \in I} \alpha_{i i^{\prime}} \mu_{i^{\prime}} \tag{6}
\end{equation*}
$$

for all $i \in X_{d}(t+1)$. Now, let $i^{\prime} \in X_{d}(t)$, and $i^{\prime}=\left(i_{1}^{\prime}, i_{2}^{\prime}, \ldots, i_{d}^{\prime}\right)$. Then the indices in $X_{d}(t+1)$ adjacent to $i^{\prime}$ are exactly those of the form $i^{\prime}+p_{j}$ for some $i=1,2, \ldots, d$. Hence,

$$
\begin{equation*}
\sum_{i \in X_{d}(t+1), i i^{\prime} \in I} \alpha_{i i^{\prime}}=\sum_{j=1}^{d} \frac{i_{j}^{\prime}+1}{t+1}=\frac{t+d}{t+1} \tag{7}
\end{equation*}
$$

Finally, by (6) and (7)

$$
\begin{gathered}
\sum_{i \in X_{d}(t+1)} \lambda_{i} \geq \sum_{i \in X_{d}(t+1)} \sum_{i^{\prime} \in X_{d}(t), i i^{\prime} \in I} \alpha_{i i^{\prime}} \mu_{i^{\prime}}= \\
=\sum_{i^{\prime} \in X_{d}(t)}\left(\sum_{i \in X_{d}(t+1), i i^{\prime} \in I} \alpha_{i i^{\prime}}\right) \mu_{i^{\prime}}=\frac{t+d}{t+1} \sum_{i^{\prime} \in X_{d}(t)} \mu_{i^{\prime}} .
\end{gathered}
$$

Note that the sequence $\left\{\frac{t+d}{t+1}\right\}$, where $t=0,1,2, \ldots$, is strictly decreasing. Hence, using the fact that if $i \in X_{d}(t)$, then $\mu_{i} \leq V(k-t)$, it follows that

$$
\begin{equation*}
\operatorname{vol}(M+B) \geq(k+1)^{\underline{d}} V+\frac{k+1}{k-d+2} \sum_{t=k-d+1}^{k-1} \sum_{i \in X_{d}(t)} \mu_{i} \tag{8}
\end{equation*}
$$

$$
-\frac{k+1}{k-d+2} \sum_{t=k-d+1}^{k-1} V(k-t) N_{d}(t)+\sum_{t=k-d+1}^{k-1} \frac{t+d}{t+1} V(k-t) N_{d}(t)
$$

Observe that $\sum_{t=k-d+1}^{k-1} V(k-t) N_{d}(t)$ is the volume of the part of $k \operatorname{conv}(B)$ belonging to cells that are not contained in it, and thus, it is equal to $\left(k^{d}-k^{d}\right) V$. Similarly,

$$
\begin{aligned}
& \sum_{t=k-d+1}^{k-1} \frac{t+d}{t+1} V(k-t) N_{d}(t)=\sum_{t=k-d+1}^{k-1} \frac{t+d}{t+1} V(k-t)\binom{t+d-1}{d-1}= \\
& \sum_{t=k-d+1}^{k-1} \sum_{i \in X_{d}(t)} V(k-t)\binom{t+d}{d-1}=\sum_{t^{\prime}=k-d+2}^{k} \sum_{i \in X_{d}\left(t^{\prime}\right)} V\left(k+1-t^{\prime}\right) N_{d}\left(t^{\prime}\right)
\end{aligned}
$$

is the volume of the part of $(k+1) \operatorname{conv}(B)$ belonging to cells that are not contained in it. Thus, it is equal to $\left((k+1)^{d}-(k+1)^{d}\right) V$. Substituting these into (8) and by (3), we obtain

$$
\begin{aligned}
\operatorname{vol}(M+B) \geq(k+1)^{\underline{d}} V & +\frac{k+1}{k-d+2}\left(\operatorname{vol}(M)-k^{\underline{d}} V\right)-\frac{k+1}{k-d+2}\left(k^{d}-k^{\underline{d}}\right) V \\
& +\left((k+1)^{d}-(k+1)^{\underline{d}}\right) V \\
= & \frac{k+1}{k-d+2} \operatorname{vol}(M)+\left((k+1)^{d}-\frac{k+1}{k-d+2} k^{d}\right) V
\end{aligned}
$$

Thus,
(9) $\quad \operatorname{vol}\left(\frac{1}{k+1}(M+B)\right) \geq \frac{k^{d}}{(k-d+2)(k+1)^{d-1}} \operatorname{vol}\left(\frac{1}{k} M\right)$ $+\left(1-\frac{k^{d}}{(k-d+2)(k+1)^{d-1}}\right) V$.
Since $\operatorname{vol}\left(\frac{1}{k} M\right) \leq V$, the first inequality of the lemma readily follows.

Now we prove the equality case. By (9), equality in the lemma implies that $\operatorname{vol}\left(\frac{1}{k} M\right)=V$, or equivalently, $\operatorname{vol}(k \operatorname{conv}(\vec{B}) \backslash M)=0$. Note that since $\operatorname{vol}(k \operatorname{conv}(B))>$ 0 , its interior is not empty. Thus, $k \operatorname{conv}(B)$ is equal to the closure of its interior. On the other hand, $\operatorname{vol}(k \operatorname{conv}(B) \backslash M)=0$ implies that $\operatorname{int}(k \operatorname{conv} B) \subset M$, but as $M$ is compact, $M=k$ conv $B$ follows.

Finally, if $\operatorname{vol}\left(\frac{1}{k+1}(M+B)\right)-\delta \leq \operatorname{vol}\left(\frac{1}{k} M\right)$, then in the same way 9 yields the inequality $\operatorname{vol}(M) \geq \operatorname{vol}(k \operatorname{conv}(B))-C(d, k) \delta$, with $C(d, k)=\frac{k^{d}}{1-\frac{k^{d}}{(k-d+2)(k+1)^{d-1}}}$.

Proof of Theorem 1. Without loss of generality, we may assume that $S$ is starshaped with respect to the origin. Let $\varepsilon>0$ be an arbitrary positive number. By Carathéodory's theorem, we may choose a finite point set $A_{0} \subset S$ such that $\operatorname{vol}(\operatorname{conv}(S))-\varepsilon \leq \operatorname{vol}\left(\operatorname{conv}\left(A_{0}\right)\right)$, and without loss of generality, we may assume that the points of $A_{0}$ are in convex position. Clearly, the star-shaped set $A=\bigcup_{a \in A_{0}}[o, a]$ is a subset of $S$, satisfying $\operatorname{vol}(\operatorname{conv}(S))-\varepsilon \leq \operatorname{vol}(\operatorname{conv}(A))$. Consider a simplicial decomposition $\mathcal{F}$ of the boundary of $\operatorname{conv}(A)$ such that all vertices of $\mathcal{F}$ are vertices of $\operatorname{conv}(A)$. Let the $(d-1)$-dimensional faces of $\mathcal{F}$ be $F_{1}, F_{2}, \ldots, F_{m}$, and for $j=1,2, \ldots, m$, let $B_{j}=\bigcup_{t=1}^{d}\left[o, p_{t}^{j}\right]$, where $p_{1}^{j}, p_{2}^{j}, \ldots, p_{d}^{j}$ are the vertices of $F_{j}$. Then $B_{j} \subseteq S$ for all values of $j$, the sets $\operatorname{conv}\left(B_{j}\right)$ are mutually non-overlapping, and $\operatorname{conv}(A)=\bigcup_{j=1}^{m} \operatorname{conv}\left(B_{j}\right)$. Finally, let $M_{j}=$ $S[k] \cap\left(k \operatorname{conv}\left(B_{j}\right)\right)$. Then, since $B_{j} \subseteq S$, we have $B_{j}[k] \subseteq M_{j} \subseteq\left(k \operatorname{conv}\left(B_{j}\right)\right)$. Thus, Lemma 2 implies that $\operatorname{vol}\left(\frac{1}{k+1}\left(M_{j}+B_{j}\right)\right) \geq \operatorname{vol}\left(\frac{1}{k} M_{j}\right)$, or in other words, $\operatorname{vol}\left(M_{j}+B_{j}\right) \geq \frac{(k+1)^{d}}{k^{d}} \operatorname{vol}\left(M_{j}\right)$. Thus, we have

$$
\begin{aligned}
\frac{(k+1)^{d}}{k^{d}} \operatorname{vol}(S[k] \cap \operatorname{conv}(k A)) & =\sum_{j=1}^{m} \frac{(k+1)^{d}}{k^{d}} \operatorname{vol}\left(M_{j}\right) \\
& \leq \sum_{j=1}^{m} \operatorname{vol}\left(M_{j}+B_{j}\right) \leq \operatorname{vol}(S[k+1])
\end{aligned}
$$

On the other hand, since $0 \leq \operatorname{vol}(\operatorname{conv}(S))-\operatorname{vol}(\operatorname{conv}(A)) \leq \varepsilon$, we have $0<$ $\operatorname{vol}\left((S[k] \backslash \operatorname{conv}(k A)) \leq k^{d} \varepsilon\right.$, implying that

$$
\operatorname{vol}\left(\frac{1}{k} S[k]\right)-\varepsilon \leq \operatorname{vol}\left(\frac{1}{k+1} S[k+1]\right)
$$

This inequality is satisfied for all positive $\varepsilon$, and thus, the inequality part of Theorem 1 holds.

Now, assume that

$$
\operatorname{vol}\left(\frac{1}{k} S[k]\right)=\operatorname{vol}\left(\frac{1}{k+1} S[k+1]\right)
$$

Then, since $\operatorname{vol}\left((S[k] \backslash \operatorname{conv}(k A)) \leq k^{d} \varepsilon\right.$, it follows that $\operatorname{vol}(S[k+1])-k^{d} \varepsilon \leq$ $\frac{(k+1)^{d}}{k^{d}} \operatorname{vol}(S[k] \cap \operatorname{conv}(k A))$, and thus,

$$
\sum_{j=1}^{m}\left(\operatorname{vol}\left(\frac{1}{k+1}\left(M_{j}+B_{j}\right)\right)-\operatorname{vol}\left(\frac{1}{k} M_{j}\right)\right) \leq \frac{\varepsilon}{(k+1)^{d}}
$$

For $j=1,2, \ldots, m$, set $\delta_{j}=\operatorname{vol}\left(\frac{1}{k+1}\left(M_{j}+B_{j}\right)\right)-\operatorname{vol}\left(\frac{1}{k} M_{j}\right)$. Then, clearly $\sum \delta_{j} \leq \frac{\varepsilon}{(k+1)^{d}}$. On the other hand, by Lemma 2 for every $j=1,2, \ldots, m$, we have $\operatorname{vol}\left(k\right.$ conv $\left.B_{j}\right)-\operatorname{vol}\left(M_{j}\right) \leq C(k, d) \delta_{j}$ for some constant depending only on $k$ and $d$. Thus, it follows that

$$
\frac{\varepsilon C(k, d)}{(k+1)^{d}} \geq \operatorname{vol}(\operatorname{conv}(k A))-\operatorname{vol}(S[k] \cap \operatorname{conv}(k A))
$$

implying that $\varepsilon\left(k^{d}+\frac{C(k, d)}{(k+1)^{d}}\right) \geq \operatorname{vol}(\operatorname{conv}(k S))-\operatorname{vol}(S[k])$. This inequality holds for any value $\varepsilon>0$, and hence, $\operatorname{vol}(\operatorname{conv}(S))=\operatorname{vol}\left(\frac{1}{k} S[k]\right)$, or equivalently, $\operatorname{vol}\left(\operatorname{conv}(S) \backslash \frac{1}{k} S[k]\right)=0$. Since $\operatorname{conv}(S)$ is a compact, convex set with nonempty interior, and $\frac{1}{k} S[k]$ is compact, to show the equality $\operatorname{conv}(S)=\frac{1}{k} S[k]$, we may apply the argument at the end of the proof of Lemma 2.

## 3. Conjecture 1 for connected sets

In the first few lemmata we collect some elementary properties of the Minkowski sum of connected sets. Throughout this section, $e_{1}, e_{2}$ denotes the elements of the standard orthonormal basis of $\mathbb{R}^{2}$.

Lemma 3. Let $A \subset \mathbb{R}^{d}$ be a compact set with a connected boundary and let $\partial A \subseteq$ $B \subseteq A$. Then $B+B=A+A$.

Proof. We have $\partial A+\partial A \subseteq B+B \subseteq A+A$. Thus it is sufficient to prove that $\partial A+\partial A=A+A$. Clearly, $A+A \supseteq \partial A+\partial A$. We show that $\frac{A+A}{2} \subseteq \frac{\partial A+\partial A}{2}$, which then yields the assertion. Consider a point $p \in \frac{A+A}{2}$. Then $p$ is the midpoint of a segment whose endpoints are points of $A$. Let $\chi_{p}: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ be the reflection about $p$. To prove that $p \in \frac{\partial A+\partial A}{2}$ we need to show that for some $q \in \partial A$, we have $\chi_{p}(q) \in \partial A$. To do this, let us define $f_{p}(x)\left(x \in \mathbb{R}^{d}\right)$ as the signed distance of $\chi_{p}(x)$ from the boundary of $A$, where the sign is positive if $\chi_{p}(x) \notin A$, and not positive if $\chi_{p}(x) \in A$. Here we remark that since $A$ is compact, $\partial A$ is compact as well. Let $x_{1}$ be a point of $\partial A$ farthest from $p$. If $\chi_{p}\left(x_{1}\right) \in A$ then $\chi_{p}\left(x_{1}\right) \in \partial A$, and we are done. Thus, assume that $\chi_{p}\left(x_{1}\right) \notin A$, implying that $f_{p}\left(x_{1}\right)>0$. Now, since $p \in \frac{A+A}{2}$, we have some $y \in A$ such that $\chi_{p}(y) \in A$. Let $L$ be the line through $y, p$ and $\chi_{p}(y)$. Let $y^{\prime}$ and $y^{\prime \prime}$ be points of $L \cap \partial A$ closest to $y$ and $\chi_{p}(y)$, respectively. If $0<\left|y^{\prime}-y\right| \leq\left|y^{\prime \prime}-\chi_{p}(y)\right|$, then $y^{\prime} \in \partial A$ and $\chi_{p}\left(y^{\prime}\right) \in A$. If $0<\left|y^{\prime \prime}-\chi_{p}(y)\right| \leq\left|y^{\prime}-y\right|$, then the same holds for $y^{\prime \prime}$ in place of $y^{\prime}$. Thus, it follows that for some point $x_{2} \in \partial A, \chi_{p}\left(x_{2}\right) \in A$. If $\chi_{p}\left(x_{2}\right) \in \partial A$, then we are done, and so we may assume that $\chi_{p}\left(x_{2}\right) \in \operatorname{int} A$, which yields that $f_{p}\left(x_{2}\right)<0$.

We have shown that $f_{p}: \partial A \rightarrow \mathbb{R}$ attains both a positive and a negative value on its domain. On the other hand, since $f$ is continuous and $\partial A$ is connected, $f_{p}(q)=0$ for some $q \in \partial A$, from which the assertion readily follows.

Remark 1. Lemma 3 holds also for the boundary of the external connected component of $\mathbb{R}^{d} \backslash A$ in place of $\partial A$.

Remark 2. We note that the equality $A_{1}+A_{2}=\partial A_{1}+\partial A_{2}$ does not hold in general for different compact sets $A_{1}, A_{2}$ with connected boundaries. To show it, one may consider the sets $A_{1}=B_{2}^{2}$ and $A_{2}=\varepsilon B_{2}^{2}$ for some sufficiently small value of $\varepsilon$, where $B_{2}^{d}$ be the Euclidean unit ball of dimension $d$ centered at the origin.

Remark 3. Lemma 3 does not hold if we omit the condition that $\partial A$ is connected. To show it, we may choose $A$ as the union of $B_{2}^{2}$ and a singleton $\{p\}$ with $|p|$ being sufficiently large.

Corollary 1. If $A$ is a compact set with a connected boundary then $A+A=A+$ $\partial A=\partial A+\partial A$. Thus, for any positive integer $k \geq 2$, we have $\sum_{i=1}^{k} A=\sum_{i=1}^{k} \partial A$.

Corollary 2. For any $k \geq d-1$ and compact set $A$ such that $\partial S \subseteq A \subseteq S$ for some compact, star-shaped set $S \subset \mathbb{R}^{d}$, we have

$$
\operatorname{vol}\left(\frac{1}{k} A[k]\right) \leq \operatorname{vol}\left(\frac{1}{k+1} A[k+1]\right)
$$

Proof. Without loss of generality, we may assume that $S$ is star-shaped with respect to the origin. Set $S^{\prime}=S+\varepsilon B_{2}^{d}$ for some small value $\varepsilon>0$.

First, we show that $\partial S^{\prime}$ is path-connected. Let $L$ be a ray starting at $o$. Since $o \in \operatorname{int} S^{\prime}, L \cap \partial S^{\prime} \neq \emptyset$. Let $p \in L \cap \partial S^{\prime}$. Then there is a point $q \in S$ such that $|q-p|=\varepsilon$. Now, if $x$ is any relative interior point of $[o, q]$, then the line through $x$ and parallel to $[p, q]$ intersects $[o, q]$ at a point at distance less than $\varepsilon$ from $x$. Since $[o, q] \subseteq S$, from this it follows that $x \in S+\varepsilon \operatorname{int} B_{2}^{d} \subseteq \operatorname{int} S^{\prime}$. In other words, for any $p \in \partial S^{\prime}$, all points of $[o, p]$ but $p$ lie in int $S^{\prime}$. Thus, $L \cap \partial S^{\prime}$ is a singleton for any ray $L$ starting at $o$.

Let $0<r<R$ such that $\partial S^{\prime} \subset H=R B_{2}^{d} \backslash\left(r \operatorname{int} B_{2}^{d}\right)$. Let $P: H \rightarrow \mathbb{S}^{d-1}$ be the central projection to $\mathbb{S}^{d-1}$. Note that $P$ is Lipschitz, and thus continuous on $H$, and its restriction $\left.P\right|_{\partial S^{\prime}}$ to $\partial S^{\prime}$ is bijective. On the other hand, since $\partial S^{\prime}$ (as also $\left.S^{\prime}\right)$ are compact, this implies that the inverse of $\left.P\right|_{\partial S^{\prime}}$ is continuous, that is, $\partial S^{\prime}$ and $\mathbb{S}^{d-1}$ are homeomorphic. Thus, $\partial S^{\prime}$ is path-connected.

On the other hand, $\partial S \subseteq A \subseteq S$ implies that $A^{\prime}=A+\varepsilon B_{2}^{d} \subseteq S^{\prime}$, and $\partial S^{\prime} \subseteq$ $\partial S+\varepsilon \mathbb{S}^{d-1} \subseteq \partial S+\varepsilon B_{2}^{d} \subseteq A^{\prime}$. Now, we may apply Lemma 3 and Corollary 1 . and obtain that for any value of $k \geq d-1, A^{\prime}[k]=S^{\prime}[k]$. Thus, by Theorem 1 it follows that $\operatorname{vol}\left(\frac{1}{k} A^{\prime}[k]\right) \leq \operatorname{vol}\left(\frac{1}{k+1} A^{\prime}[k+1]\right)$. On the other hand, since volume is continuous with respect to Hausdorff distance, we have $\lim _{\varepsilon \rightarrow 0^{+}} \operatorname{vol}\left(\frac{1}{m} A^{\prime}[m]\right)=$ $\lim _{\varepsilon \rightarrow 0^{+}} \operatorname{vol}\left(\frac{1}{m} A[m]+\varepsilon B_{2}^{d}\right)=\operatorname{vol}\left(\frac{1}{k} A[k]\right)$, which implies the corollary.

Let us denote the closure of a set $A \subset \mathbb{R}^{d}$ by $\operatorname{cl}(A)$.
Proposition 1. Let $\gamma \subset \mathbb{R}^{2}$ be a simple continuous curve connecting o and $e_{1}$ such that its intersection with the x-axis is $\left\{o, e_{1}\right\}$. Let $D$ be the interior of the closed Jordan curve $\gamma \cup\left[o, e_{1}\right]$. For $i=0$, 1 , let $\gamma_{i}=\frac{i}{2} e_{1}+\frac{1}{2} \gamma$, and $D_{i}=\frac{i}{2} e_{1}+\frac{1}{2} D$. Then $\operatorname{cl}\left(D \backslash\left(D_{0} \Delta D_{1}\right)\right) \subseteq \frac{1}{2} \gamma[2]$, where $\Delta$ denotes symmetric difference.

Proof. For convenience, we assume that $\gamma$ lies in the half plane $\{y \leq 0\}$. As in the proof of Lemma 3, let $\chi_{p}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ denote the reflection about $p \in \mathbb{R}^{2}$, and note that $p \in \frac{1}{2} \gamma[2]$ if and only if there is some point $q \in \gamma$ such that $\chi_{p}(q) \in \gamma$, or in other words, if $\gamma \cap \chi_{p}(\gamma) \neq \emptyset$. Let $L$ denote the $x$-axis, $L_{p}=\chi_{p}(L)$, and let $S_{p}$ be the infinite strip between $L$ and $L_{p}$ (cf. Figure 2).

First, observe that $o, e_{1} \in \gamma$ yields that $\gamma_{0} \cup \gamma_{1} \subset \frac{1}{2} \gamma[2]$, and $\gamma \subset \frac{1}{2} \gamma[2]$ trivially holds. Thus, we need to show that if for some point $p$ we have $p \in D \backslash \operatorname{cl}\left(D_{0} \cup D_{1}\right)$

or $p \in D_{0} \cap D_{1} \cap D$, then $p \in \frac{1}{2} \gamma[2]$. We do it only for the case $p \in D \backslash \operatorname{cl}\left(D_{0} \cup D_{1}\right)$ since for the second case a similar argument can be applied.

Consider some point $p \in D \backslash\left(D_{0} \cup D_{1}\right)$. Then $p \notin \operatorname{cl}\left(D_{0} \cup D_{1}\right)$ yields that $\chi_{p}(o)=2 p \notin \mathrm{cl} D$, and the relation $\chi_{p}\left(e_{1}\right) \notin \mathrm{cl} D$ follows similarly.

Case 1: $\gamma \subset S$. Note that in this case $\chi_{p}(\gamma) \subset S$. Since $p \in D$ and $\chi_{p}(o) \notin \operatorname{cl} D$, $\partial D=\gamma \cup\left[o, e_{1}\right]$ and $\left[\chi_{p}(o), p\right] \cap\left[o, e_{1}\right]=\emptyset$, it follows by the continuity of $\gamma$ that $\gamma \cap\left[\chi_{p}(o), p\right] \neq \emptyset$. Hence, by the compactness of $\gamma$, there is a point $x \in \gamma \cap\left[\chi_{p}(o), p\right]$ closest to $p$. By its choice, $\chi_{p}(x) \in D \cup \gamma$. If $\chi_{p}(x) \in \gamma$, we are done, and thus, we assume that $\chi_{p}(x) \in D$. This implies that $\chi_{p}(\gamma)$ contains both interior and exterior points of $D$. On the other hand, since $\chi_{p}(\gamma) \subset S$, this implies that $\chi_{p}(\gamma) \cap \gamma \neq \emptyset$.

Case 2: $\gamma \not \subset S$. Let $\gamma_{p}=\gamma \cap S_{p}$, and let $\gamma_{1}$ and $\gamma_{2}$ denote the connected components of $\gamma_{p}$ containing $o$ and $e_{1}$, respectively. For $i=0,1$, we denote the endpoint of $\gamma_{i}$ on $L_{p}$ by $x_{i}$. Clearly, since $\gamma$ is simple and continuous, $x_{1}$ is on the left-hand side of $x_{2}$, and the curve $\gamma_{1} \cup\left[x_{1}, x_{2}\right] \cup \gamma_{2} \cup\left[o, e_{1}\right]$ is a Jordan curve. We denote the interior of this curve by $D_{p}$.

Consider the case where $p \notin D_{p}$. Then $p$ is an exterior point of $D_{p}$, and there is a connected component $\gamma^{*}$ of $\gamma_{p}$, with endpoints on $L_{p}$, that separates $p$ from $L$. Since the reflections of the endpoints of $\gamma^{*}$ about $p$ lie on $L$, we may apply the argument in Case 1 , and obtain that $\emptyset \neq \gamma^{*} \cap \chi_{p}\left(\gamma^{*}\right) \subseteq \gamma \cap \chi_{p}(\gamma)$. Thus, we may assume that $p \in D_{p}$.

If $\chi_{p}\left(x_{1}\right) \in\left[o, e_{1}\right]$, then the continuity of $\gamma_{1}$ and $\chi_{p}(o) \notin \operatorname{cl} D$ implies that $\emptyset \neq \gamma_{1} \cap \chi_{p}\left(\gamma_{1}\right) \subseteq \gamma \cap \chi_{p}(\gamma)$. If $\chi_{p}\left(x_{2}\right) \in\left[o, e_{1}\right]$, then we may apply a similar argument, and thus we may assume that $\chi_{p}\left(x_{1}\right), \chi_{p}\left(x_{2}\right) \notin\left[o, e_{1}\right]$. This implies that either $\left[\chi_{p}\left(x_{1}\right), \chi_{p}\left(x_{2}\right)\right]$ and $\left[o, p_{1}\right]$ are disjoint, or $\left[o, p_{1}\right] \subset\left[\chi_{p}\left(x_{1}\right), \chi_{p}\left(x_{2}\right)\right]$.

Consider the case where $\left[\chi_{p}\left(x_{1}\right), \chi_{p}\left(x_{2}\right)\right]$ and $\left[o, p_{1}\right]$ are disjoint; without loss of generality we may assume that $\chi_{p}\left(x_{1}\right), \chi_{p}\left(x_{2}\right), o$ and $e_{1}$ are in this consecutive order on $L$. Let $U$ be the closure of the connected component of $S \backslash \gamma_{1}$ containing $\gamma_{2}$. Then $\chi_{p}(p)=p \in \operatorname{int} U \cap \chi_{p}(U)$, implying that $\emptyset \neq \gamma_{1} \cap \chi_{p}\left(\gamma_{1}\right) \subseteq \gamma \cap \chi_{p}(\gamma)$. Thus, we may assume that $\left[o, p_{1}\right] \subset\left[\chi_{p}\left(x_{1}\right), \chi_{p}\left(x_{2}\right)\right]$. Since from this it follows that $\left[\chi_{p}(o), \chi_{p}\left(e_{1}\right)\right] \subset\left[x_{1}, x_{2}\right], \chi_{p}(o) \notin \operatorname{cl} D$ yields that there is a connected component
$\gamma^{\prime}$, with endpoints on $L_{p}$, that separates $\chi_{p}(o)$ from $L$. Thus, $\gamma^{\prime}$ separates $\chi_{p}(o)$ also from $\chi_{p}\left(x_{1}\right) \in L$, which yields that $\emptyset \neq \gamma^{\prime} \cap \chi_{p}\left(\gamma_{1}\right) \subseteq \gamma \cap \chi_{p}(\gamma)$.

The proof of Lemma 4 is based on the idea of the proof of Proposition 11 with some necessary modifications.

Lemma 4. Let $k \geq 2$, and let $\gamma \subset \mathbb{R}^{2}$ be a convex, continuous curve connecting o and $e_{1}$ such that its intersection with the $x$-axis is $\left\{o, e_{1}\right\}$. Let $D$ be the interior of the closed Jordan curve $\gamma \cup\left[o, e_{1}\right]$. For $i=0,1, \ldots, k-1$, let $\gamma_{i}=\frac{i}{k} e_{1}+\frac{1}{k} \gamma$, and $D_{i}=\frac{i}{k} e_{1}+\frac{i}{k} D$. Then $\operatorname{cl}\left(D \backslash\left(\bigcup_{i=1}^{k} D_{i}\right)\right) \subseteq \frac{1}{k} \gamma[k]$, and for any $i \neq j, D_{i} \cap D_{j} \subseteq$ $\frac{1}{k} \gamma[k]$.

Proof. First observe that $D$ is convex, hence $D_{i}$ is contained in $D$ for all values of $i$. In the proof, we denote the $x$-axis by $L$, for any $p \in \mathbb{R}^{2}$ the homothety with center $p$ and ratio $-\frac{1}{k-1}$ by $\chi_{p}^{k}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$. Furthermore, we set $L_{p}^{k}=\chi_{p}^{k}(L)$, and denote the infinite strip between $L$ and $L_{p}^{k}$ by $S$. The assertion for $k=2$ is a special case of Proposition 1. To prove it for $k \geq 3$, we apply induction on $k$, and assume that the lemma holds for $\gamma[k-1]$.

Let $p \in \operatorname{cl}(D) \backslash\left(\bigcup_{i=1}^{k} D_{i}\right)$. Clearly, since $\partial D=\gamma \subseteq \gamma[k]$, we may assume that $p \in D$. By the induction hypothesis for $\frac{k-1}{k} \gamma$, if $p \in X_{1}=\frac{k-1}{k} \mathrm{cl} D$, then $p \in \frac{k-1}{k} \cdot \frac{1}{k-1} \gamma[k-1]=\frac{1}{k} \gamma[k-1] \subseteq \frac{1}{k} \gamma[k]$. Similarly, if $p \in X_{2}=\frac{1}{k} e_{1}+\frac{k-1}{k} \operatorname{cl} D$, then $p \in \frac{1}{k} e_{1}+\frac{1}{k} \gamma[k-1] \subseteq \frac{1}{k} \gamma[k]$. Thus, assume that $p \notin X_{1} \cup X_{2}$, which yields that $\chi_{p}^{k}(o)$ and $\chi_{p}^{k}\left(e_{1}\right)$ are in the exterior of $D$. Let the (unique) intersection point of $\left[p, \chi_{p}^{k}(o)\right.$ ] and $\gamma$ be $q_{1}$ and the (unique) intersection point of $\left[p, \chi_{p}^{k}\left(e_{1}\right)\right.$ ] and $\gamma$ be $q_{2}$. As $\chi_{p}^{k}\left(q_{1}\right) \in[o, p]$, the convexity of $D$ implies that $\chi_{p}^{k}\left(q_{1}\right) \in D$, and the containment $\chi_{p}^{k}\left(q_{2}\right) \in D$ follows similarly.

Similarly like in Proposition 1 , if $\gamma \subset S$, then by continuity, $\gamma \cap \chi_{p}^{k}(\gamma) \neq \emptyset$, which implies the containment $p \in \frac{1}{k} \gamma[k]$. Assume that $\gamma \not \subset S$. Then $S \cap \gamma$ has two connected components $\gamma_{1}, \gamma_{2}$, where we choose the indices such that $o \in \gamma_{1}$, and $e_{1} \in \gamma_{2}$. Clearly, we have either $q_{1} \in \gamma_{2}, q_{2} \in \gamma_{1}$, or both. If $q_{1} \in \gamma_{2}$, then the containment relations $\chi\left(q_{1}\right) \in D, \chi\left(e_{1}\right) \notin \operatorname{cl} D$, and $\chi_{p}^{k}\left(\gamma_{2}\right) \subset S$ yield that $\emptyset \neq \gamma_{1} \cap \chi_{p}^{k}\left(\gamma_{2}\right) \subset \gamma \cap \chi_{p}^{k}(\gamma)$. If $q_{2} \in \gamma_{1}$, then the assertion follows by a similar argument.

Finally, we consider the case that $p \in D_{i} \cap D_{j}$ for some $i<j$. In this case the convexity of $D$ implies that $p \in D_{s}$ for any $i \leq s \leq j$. This yields that there are some distinct values $i, j \leq k-1$ or $i, j \geq 2$ such that $p \in D_{i} \cap D_{j}$. Thus, the assertion readily follows from the induction hypothesis.

Lemma 5 is a variant of Lemma 2 for some path-connected sets in $\mathbb{R}^{2}$.
Lemma 5. Let $k \geq 2$ and $\gamma$ be a bounded convex curve in $\mathbb{R}^{2}$, and let $\gamma[k] \subseteq M \subseteq$ $k$ conv $\gamma$. Then

$$
\operatorname{area}\left(\frac{1}{k} M\right) \leq \operatorname{area}\left(\frac{1}{k+1}(M+\gamma)\right)
$$

Proof. If $\gamma$ is closed, then Lemma 3 yields that $\frac{1}{k} \gamma[k]=\operatorname{conv} \gamma$ for all $k \geq 2$, which clearly implies the statement. Assume that $\gamma$ is not closed. Since the inqualities
in Lemma 5 do not change under affine transformations, we may assume that the endpoints of $\gamma$ are $o$ and $e_{1}$, and the $x$-axis is a supporting line of conv $\gamma$.
Let us define
$D=\operatorname{conv} \gamma, \alpha=\operatorname{area}\left(D \cap\left(e_{1}+D\right)\right)$, and $\beta=\operatorname{area}\left(D \cap\left(\left(e_{1}+D\right) \cup\left(-e_{1}+D\right)\right)\right)$.
Note that $0 \leq \alpha \leq \beta \leq 2 \alpha$. Let $D_{i}=i e_{1}+D$ for $i=0,1, \ldots, k$. For $0 \leq i \leq k-1$, let $\mu_{i}$ be the area of the region of $M$ in $D_{i}$ that do not belong to any $D_{j}, j \neq i$, where we note that since $k \geq 2$, by Lemma 4 we have that all other points of $D_{i}$ belong to $M$. Similarly, for $0 \leq i \leq k$, let $\lambda_{i}$ be the area of the region of $M+\gamma$ in $D_{i}$ that do not belong to any $D_{j}, j \neq i$. An elementary computation shows that

$$
\begin{align*}
\operatorname{area}(M) & =k^{2} \operatorname{area}(D)-2(\operatorname{area}(D)-\alpha)-(k-2)(\operatorname{area}(D)-\beta)+\sum_{i=0}^{k-1} \mu_{i} \\
& =\left(k^{2}-k\right) \operatorname{area}(D)+2 \alpha+(k-2) \beta+\sum_{i=0}^{k-1} \mu_{i} \tag{10}
\end{align*}
$$

and similarly,

$$
\begin{equation*}
\operatorname{area}(M+\gamma)=\left(k^{2}+k\right) \operatorname{area}(D)+2 \alpha+(k-1) \beta+\sum_{i=0}^{k} \lambda_{i} \tag{11}
\end{equation*}
$$

Since $o, e_{1} \in \gamma$, we have $M, e_{1}+M \subseteq M+\gamma$. Thus, $\lambda_{0} \geq \mu_{0}, \lambda_{k} \geq \mu_{k-1}$, $\lambda_{1} \geq \max \left\{\mu_{0}-(\beta-\alpha), \mu_{1}\right\}, \lambda_{k-1} \geq \max \left\{\mu_{k-2}, \mu_{k-1}-(\beta-\alpha)\right\}$, and for $2 \leq$ $i \leq k-2, \lambda_{i} \geq \max \left\{\mu_{i-1}, \mu_{i}\right\}$. Since $\lambda_{i} \geq \frac{i}{k} \mu_{i-1}+\frac{k-i}{k} \mu_{i}$ if $2 \leq i \leq k-2$, and $\lambda_{i} \geq \frac{i}{k} \mu_{i-1}+\frac{k-i}{k} \mu_{i}-\frac{1}{k}(\beta-\alpha)$ if $i=1$ or $i=k-1$, it follows that $\sum_{i=0}^{k} \lambda_{i} \frac{k+1}{k} \geq$ $\sum_{i=1}^{k-1} \mu_{i}-\frac{2}{k}(\beta-\alpha)$. Thus, by 10,

$$
\sum_{i=0}^{k} \lambda_{i} \geq \frac{k+1}{k}\left(\operatorname{area}(M)-\left(k^{2}-k\right) \operatorname{area}(D)-2 \alpha-(k-2) \beta\right)-\frac{2}{k}(\beta-\alpha)
$$

After substituting this into 11 and simplifying, we obtain

$$
\operatorname{area}(M+\gamma) \geq \frac{k+1}{k} \operatorname{area}(M)+(k+1) \operatorname{area}(D)
$$

which yields

$$
\operatorname{area}\left(\frac{1}{k+1}(M+\gamma)\right) \geq \frac{k}{k+1} \text { area }\left(\frac{1}{k} M\right)+\frac{1}{k+1} \operatorname{area}(D)
$$

Thus, the inequality area $\left(\frac{1}{k} M\right) \leq \operatorname{area}(D)$ yields the assertion.
In Theorem 2, by an open topological disc we mean the bounded connected component defined by a Jordan curve.

Theorem 2. Let $k \geq 2$. Let $K$ be a plane convex body, and let $\mathcal{F}=\left\{F_{i}: i \in I\right\}$ be a family of pairwise disjoint topological discs open in $K$ such that if $F_{i} \cap \partial K \neq \emptyset$ then $F_{i} \cap \partial K$ is a connected curve and $F_{i}$ is convex. Let $X=K \backslash\left(\bigcup_{i \in I} F_{i}\right)$. Then

$$
\operatorname{area}\left(\frac{1}{k} X[k]\right) \leq \operatorname{area}\left(\frac{1}{k+1} X[k+1]\right)
$$

Proof. First, note that since each member of $\mathcal{F}$ has positive area, it has countably many elements; indeed, for any $\delta>0$ there are only finitely many elements $F_{i}$ of $\mathcal{F}$ for which area $\left(F_{i} \cap K\right) \geq \delta$, and thus, we may list the elements according to area. Furthermore, since $X$ is compact, area $(X)$ exists.

By Lemma 3, we may assume that every member of $\mathcal{F}$ intersects $\partial K$. For any $i \in I$, let $\gamma_{i}$ denote the part of $\partial F_{i}$ in $K$. Clearly, $\gamma_{i}$ is a convex curve, and the line through two of its endpoints supports $K \backslash F_{i}$. Choose some finite subfamily $I_{\varepsilon} \subseteq I$ such that area $\left(X_{\varepsilon} \backslash X\right) \leq \varepsilon$, where $X_{\varepsilon}=K \backslash\left(\bigcup_{i \in I_{\varepsilon} F_{i}}\right)$. This is possible, since for any ordering of the elements, $\sum_{i \in I} \operatorname{area}\left(K \cap F_{i}\right)$ is a bounded series with positive elements, and hence, it is absolute convergent, and convex sets with small area and bounded diameter are contained in a small neighborhood of their boundary.

For any $i \in I_{\varepsilon}$, we set $D_{i}=F_{i} \cap K$, and observe that $D_{i}$ is a convex set separated from $X_{\varepsilon}$ by the convex curve $\gamma_{i}$. Clearly, for $k \geq 2$, only points in the $D_{i}$ 's may not belong to $\frac{1}{k} X_{\varepsilon}[k]$, and by Lemma 4 , only points contained in exactly one homothetic copy $\frac{1}{k} D_{i j}, j=1,2, \ldots, k$ of $\frac{1}{k} D_{i}$ in $D_{i}$. Let $M_{i}=\left(X[k] \cap\left(k D_{i}\right)\right)$. Then $M_{i} \subseteq \operatorname{conv}\left(k D_{i}\right)$, and thus, Lemma 5 yields that

$$
\operatorname{area}\left(\frac{1}{k} M_{i}\right) \leq \operatorname{area}\left(\frac{1}{k+1}\left(M_{i}+\gamma_{i}\right)\right)
$$

On the other hand, with the notation $D_{\varepsilon}=\bigcup_{i \in I_{\varepsilon}} D_{i}$, we have

$$
\left.\operatorname{area}\left(\frac{1}{k} X_{[ } k\right] \cap D\right)=\sum_{i \in I_{\varepsilon}} \operatorname{area}\left(\frac{1}{k} M_{i}\right)
$$

and

$$
\left.\operatorname{area}\left(\frac{1}{k} X_{[ } k+1\right] \cap D\right) \geq \sum_{i \in I_{\varepsilon}} \operatorname{area}\left(\frac{1}{k+1}\left(M_{i}+\gamma_{i}\right)\right)
$$

and thus, we have area $\left.\left(\frac{1}{k} X_{[ } k\right] \cap D\right) \leq$ area $\left(\frac{1}{k+1} X[k+1] \cap D\right)$. On the other hand, since $\operatorname{area}\left(X_{\varepsilon} \backslash X\right)<\varepsilon, X_{\varepsilon} \cup D=\operatorname{conv} X$, and $X \subseteq X_{\varepsilon}$, we have that area $\left(\frac{1}{m} X_{[m]} \backslash D\right) \leq \varepsilon$ for all $m \geq 1$. This implies that

$$
\operatorname{area}\left(\frac{1}{k} X_{[k]}\right) \leq \operatorname{area}\left(\frac{1}{k+1} X[k+1]\right)-\varepsilon
$$

This holds for all $\varepsilon>0$, which yields the assertion.

## 4. Additional remarks and questions

Remark 4. One can ask if the statement of Theorem 1 holds for arbitrary measure instead of volume. The answer to this question is negative. Indeed, consider the measure $\mu(K)=\operatorname{vol}(K \cap C)$, where $C=\left[-\frac{1}{d}, \frac{1}{d}\right]^{d}$ and $S=\bigcup_{i=1}^{d}\left[o, e_{i}\right]$, where $e_{1}, e_{2}, \ldots, e_{d}$ are the vectors of the standard orthonormal basis. Then, clearly, we have

$$
\mu\left(\frac{1}{2 k} S[2 k]\right)=\frac{1}{2^{d}} \operatorname{vol}(C)>\mu\left(\frac{1}{2 k+1} S[2 k+1]\right)
$$

Remark 5. The statement of Theorem 1 does not hold for arbitrary measures even for rotationally invariant measures in the plane: for any value of $k$ there is a compact, star-shaped set $S \subset \mathbb{R}^{2}$ such that $\operatorname{vol}\left(\frac{1}{k} S[k] \cap B_{2}^{2}\right)>\operatorname{vol}\left(\frac{1}{k+1} S[k+1] \cap B_{2}^{2}\right)$.

To prove this, set $S=\left[o, e_{1}\right] \cup\left[o, e_{2}\right]$, and let $E$ denote the ellipse centered at $o$ and containing the points $(1-1 / k, 0)$ and $(1-2 / k, 1 / k)$. It is an elementary computation to check that in this case $\operatorname{vol}\left(\frac{1}{k} S[k] \cap E\right)=\frac{1}{4} \operatorname{vol}(E)$. On the other hand, the boundary point $(1-2 /(k+1), 1 /(k+1))$ of $\frac{1}{k+1} S[k+1]$ lies in $\operatorname{int}(E)$, which implies that $\operatorname{vol}\left(\frac{1}{k+1} S[k+1] \cap E\right)<\frac{1}{4} \operatorname{vol}(E)$. Now, if $f: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ is defined as the linear transformation mapping $E$ into $B_{2}^{2}$, then $f(S)$ satisfies the required conditions.

One can use star-shaped sets together with ideas from [FMMZ2] to give a negative answer to a more general version of Conjecture 1, also from BMW].

Conjecture 2 (Bobkov-Madiman-Wang). For any $k \geq 2$, star-shaped compact sets $A_{1}, A_{2}, \ldots, A_{k+1}$ in $\mathbb{R}^{d}$, we have

$$
\operatorname{vol}\left(\sum_{i=1}^{k+1} A_{i}\right)^{1 / d} \geq \frac{1}{k} \sum_{i=1}^{k+1} \operatorname{vol}\left(\sum_{j \neq i} A_{j}\right)^{1 / d}
$$

in particular, for $k=2$,

$$
\begin{align*}
\operatorname{vol}\left(A_{1}+A_{2}\right. & \left.+A_{3}\right)^{1 / d} \\
& \geq \frac{1}{2}\left(\operatorname{vol}_{n}\left(A_{1}+A_{2}\right)^{1 / d}+\operatorname{vol}\left(A_{1}+A_{3}\right)^{1 / d}+\operatorname{vol}\left(A_{2}+A_{3}\right)^{1 / d}\right) . \tag{12}
\end{align*}
$$

The above conjecture is trivial for convex sets. Moreover, (12) is true when $A_{1}=A_{2}$ and $A_{1}$ is convex. Indeed, in this case 12 is equivalent to

$$
\begin{gathered}
\operatorname{vol}\left(A_{1}+A_{1}+A_{3}\right)^{1 / d} \geq \frac{1}{2}\left(\operatorname{vol}\left(2 A_{1}\right)^{1 / d}+2 \operatorname{vol}_{n}\left(A_{1}+A_{3}\right)^{1 / d}\right) \\
\operatorname{vol}\left(A_{1}+A_{1}+A_{3}\right)^{1 / d} \geq \operatorname{vol}\left(A_{1}\right)^{1 / d}+\operatorname{vol}\left(A_{1}+A_{3}\right)^{1 / d}
\end{gathered}
$$

where the last inequality follows from the Brunn-Minkowski inequality [Sch].
It was proved in [FMMZ2] that Conjecture 2 is true in $\mathbb{R}$. Since an affirmative answer to Conjecture 2 implies also Conjecture 1, the former is also false for $d \geq 12$ by [FMMZ1, FMMZ2]. Here we show that Conjecture 2 is false in $\mathbb{R}^{d}$ even for $d \geq 7$.
Proposition 2. For any $d \geq 7$, there are compact, star-shaped sets $A_{1}, A_{2}, A_{3} \subset \mathbb{R}^{d}$ satisfying
$\operatorname{vol}\left(A_{1}+A_{2}+A_{3}\right)^{1 / d}<\frac{1}{2}\left(\operatorname{vol}\left(A_{1}+A_{2}\right)^{1 / d}+\operatorname{vol}\left(A_{1}+A_{3}\right)^{1 / d}+\operatorname{vol}\left(A_{2}+A_{3}\right)^{1 / d}\right)$.
Proof. We give the proof for $d=7$ and the result follows for $d>7$ by taking direct products with a cube. consider the sets
$A_{1}=[0,1]^{4} \times\{0\}^{3} ; A_{2}=\{0\}^{4} \times[0,1]^{3}$ and $A_{3}=\left([0, a]^{4} \times\{0\}^{3}\right) \cup\left(\{0\}^{4} \times[0, b]^{3}\right)$,
where we select $a, b>0$ later. An elementary consideration shows that

$$
\operatorname{vol}\left(A_{1}+A_{3}\right)=b^{3}, \operatorname{vol}\left(A_{2}+A_{3}\right)=a^{4} \text { and } \operatorname{vol}\left(A_{1}+A_{2}\right)=1
$$

and

$$
\operatorname{vol}\left(A_{1}+A_{2}+A_{3}\right)=(a+1)^{4}+(b+1)^{3}-1
$$

The last step is to show that, with $a=3$ and $b=6$, the quantity

$$
\left((a+1)^{4}+(b+1)^{3}-1\right)^{1 / 7}-\frac{1}{2}\left(a^{4 / 7}+b^{3 / 7}+1\right)
$$

is negative, which gives a counterexample to 12 .
