Abstract: Competitive and non-competitive batch experiments were conducted on flax fibers to study Zn^{2+} , Cu^{2+} , and Pb^{2+} ions biosorption performance. Biosorption efficiency was dependent on contact time, pH, and biosorbent concentration. The results under competitive conditions were different from those obtained in non-competitive form. A high affinity of lead, with a selectivity sequence in general of Pb > Cu > Zn was observed. The biosorption data fitted very well the Langmuir model for lead in both types of solutions and for zinc and copper in the monometal form. The fit with the Freundlich model was not as successful, except for copper in the ternary system. Regarding zinc under competitive conditions, the sorption process was quite difficult and thus the equilibrium data could not fit well the adsorption models. The maximum adsorption capacities (mmol.kg⁻¹) were respectively 112, 122 and 71, for Pb, Cu and Zn in the single metal ion solution and 82, 57 and 8 only in the ternary, showing thus a high competition between metal ions when added simultaneously. Overall, lead could still be efficiently removed in spite of the presence of other ions while zinc would be overcome in the presence of lead and copper. 61 **1. Introduction**

Water resources contamination is one of the greatest and most current challenges. It is a 62 serious problem which can lead to dangerous risks on human health, flora, wildlife and also 63 environment. Discharge of effluents from industrial runoff, wastewater, agricultural fields and 64 also road runoff are the major sources of water bodies pollution, that release high levels of 65 toxic pollutants (Jern, 2006). These latter include essentially (1) total suspended solids as silts 66 and clays and organic matters, (2) heavy metals such as lead, cadmium, chromium, mercury, 67 zinc, nickel and copper ions, (3) nutrients, mainly phosphate and azote, (4) antibiotics and 68 also (5) polycyclic aromatic hydrocarbons (PAHs) (Jern, 2006; Flanagan et al., 2019). All 69 these pollutants are very persistent in the environment, especially heavy metals, due to their 70 toxicity nature and non-biodegradability (Jern, 2006). Therefore, various technologies have 71 been developed for metal ions removal. Among these, biosorption is one of the most attractive 72 methods, based on metal binding to biological adsorbents. Different types of inexpensive 73 biosorbents have been explored, they include dead biomass like agricultural waste and 74 75 vegetative fibers, as well as living biomass such as microbial and bacterial organisms. Among these biosorbents, we list wool fibers (Balköse et al., 1992), modified jute fibers (Shukla and 76 Pai, 2005), rice husk (Krishnani et al., 2008), pomegaranate peel (El-Ashtoukhy et al., 2008), 77 hazelnut and almond shell (Pehlivan et al., 2009b), pine bark (Cutillas-Barreiro et al., 2014), 78 wheat straw (Coelho et al., 2016) that have been explored for their high capacity of removing 79 heavy metals from contaminated aqueous solutions. The present work focused on the use of 80 flax fibers as biosorbent, in order to remove zinc, copper and lead ions under competitive and 81 non-competitive conditions. The choice of this plant material, is related to its low cost and 82 high availability. The Normandy region is one of the most prolific producers of flax in France 83 and in Europe (Meirhaeghe and Bewa, 2011). Depestele Group, for instance, has developed 84 numerous applications of this natural material in civil engineering. Actually, flax has been 85 extensively used in the manufacture of woven fabrics, insulation materials and non-woven 86 geotextiles (Ouagne et al., 2013). 87

Results of a previous study realized by Abbar et al., (2017) showed a good capacity of flax 88 fibers to remove zinc, copper and lead ions from aqueous solutions in a ternary system at 89 equal massic concentrations. However, numerous questions have been raised after that work, 90 especially regarding concentration effect and adsorption behaviors in non-competitive form 91 for each ion, in order to judge the competition effect which may occur when the three metals 92 are added simultaneously. With regards to heavy metals competition, relatively few studies 93 have considered both single and multi-element systems in biosorption studies. Park et al. 94 (2016), for instance, evaluated adsorption behaviors of zinc, copper, cadmium, chromium and 95 lead adsorption onto sesame straw biochar and found that multimetal and monometal 96 adsorption behaviors were not similar. Similarly, Pejic et al. (2009) explored the removal of 97 98 zinc, cadmium and lead ions from aqueous solutions by short hemp fibers and reported that the maximum total uptake capacity for each zinc and cadmium in monometal solutions (78 99 mmol.kg⁻¹) were different from multimetal solution (35 mmol.kg⁻¹), while for lead it was 100 quite the same (78 mmol.kg⁻¹ and 74 mmol.kg⁻¹ respectively). However, as long as we know, 101 no previous studies have dealt with zinc, copper and lead ions biosorption onto flax fibers in 102 both single and multimetal ion trials. In view of that, a series of biosorption experiments of 103 these three metals were performed in both single and ternary batch systems. The objectives 104 were (i) to compare biosorption capacities of the three metals under competitive and non-105 competitive forms, and (ii) to evaluate the competition effect on each metal biosorption onto 106 flax fibers when the three metals are added simultaneously. Different conditions, resulting 107 from changing parameters such as contact time, biosorbent concentration and pH, were 108 109 investigated. Pseudo-first order and pseudo-second order kinetics and intraparticle diffusion models were tested for the adsorption kinetic studies when Langmuir and Freundlich models 110 were used to fit the biosorption data. The goal of this study is to test afterwards a full-scale 111 stormwater device as a biofiltration system, in order to purify industrial and road runoff. 112

113 **2.** Materials and methods

114 2.1. Preparation of biosorbent

Flax tows were obtained from Depestele group in Normandy. They were defibrated after 115 retting and scutching processes of linen, which consist of separating the fibers from the 116 straws. Hence, the retrieved biosorbent consisted of flax byproduct. Initially, the tows were 117 rinsed with deionized water to remove dirt, and then dried in the oven for 24 h at 60 °C. The 118 fibers were next cut into small pieces of 0,2 - 2 mm. Scanning electron microscope images 119 and FT-IR spectrum were performed with S-3000N scanning electron microscope and Perkin 120 Elmer spectrum BX FT-IR instrument respectively. The spectrum of flax fibers was measured 121 by a Fourier Transform Infrared Spectrometer within the range 600 - 4000 cm⁻¹ in order to 122 determine the vibration frequency in the functional groups before and after adsorption. 123

124 2.2. Batch experiments

Adsorption experiments in both competitive and non-competitive forms have been conducted at a temperature of 18°C in order to determine adsorption characteristics of flax fibers for zinc, copper and lead ions. The biosorbent was added to 200 mL of the metallic solution initially prepared from zinc nitrates hexahydrated, (Zn(NO₃).6H₂O), copper nitrates trihydrate (Cu(NO₃).3H₂O) and lead nitrates (Pb(NO₃)), all purchased from Fisher Scientific (France). The pH was adjusted by adding 1M NaOH or 1M HNO₃ solution, purchased from Sigma Aldrich (France).

132 All solutions were prepared with deionized water and all experiments were run in triplicate.

133 2.2.1. Kinetics trials in monometal and mulimetal solutions

Single and ternary metal ion experiments were conducted in continuously stirred beakers 134 containing 200 mL of zinc, copper and lead ions solutions at a concentration respectively of 135 $0.044 \text{ mmol}.L^{-1}$, $0.042 \text{ mmol}.L^{-1}$ and $0.042 \text{ mmol}.L^{-1}$ under the ternary form, and 0.045136 mmol.L⁻¹, 0.045 mmol.L⁻¹ and 0.046 mmol.L⁻¹ under the single form. The pH was adjusted to 137 6.4 and the amount of biosorbent was 400 mg. The monometal and multimetal solutions were 138 shaken for 5, 15, 30 and 60 min and 2, 4, 6, 8 and 10 h using magnetic agitators, then filtered 139 through a 0.45 µm nylon membrane filter. Samples of 40 mL were retrieved from the filtrated 140 solutions and acidified with 1% of nitric acid, then stored in polyethylene bottles at 4 °C for 141

no more than three days. Zinc, copper and lead ions concentrations were determined in the
liquid fractions by means of ICP-AES (Inductively coupled plasma, Atomic emission
spectrometry) in COBRA laboratory at INSA-Rouen (France). The ICP-AES spectrometer
(ICAP6300, ThermoFisher Scientific, USA) was regularly verified and was calibrated at each
time of use.

The limits of detection were calculated as three times the standard deviation of the blank 147 matrix and corresponded to 19.2 µg.L⁻¹ (2.94 10⁻⁴ mmol.L⁻¹) for Zn, 0.9 µg.L⁻¹ (1.42 10⁻⁵ 148 mmol.L⁻¹) for Cu, and 2.1 μ g.L⁻¹ (1.01 10⁻⁵ mmol.L⁻¹) for Pb. The limits of quantification were 149 calculated as ten times the standard deviation of the blank matrix and corresponded to 64.0 150 μg.L⁻¹ (9.79 10⁻⁴ mmol.L⁻¹) for Zn, 3.0 μg.L⁻¹ (4.72 10⁻⁵ mmol.L⁻¹) for Cu, and 7.0 μg.L⁻¹ (3.38 151 10⁻⁵ mmol.L⁻¹) for Pb. The amount of each adsorbed metal (mmol.kg⁻¹) per unit of weight of 152 adsorbent, or adsorption capacity Q_t was calculated as the difference between the 153 concentration added at the start, called also initial concentration C_i (mmol.L⁻¹), and the 154 concentration of the remaining metal C_{t} (mmol.L⁻¹) in the dissolved fraction after any time t 155 of adsorption, all over solid liquid ratio $\frac{m}{w}$ (kg.L⁻¹) where m is the dried mass of adsorbent and 156 *V* the volume of the adsorbate solution: 157

The removal (%) of each heavy metal was calculated as the amount adsorbed (mmol.L⁻¹) over
the concentration added at the start:

162 Kinetic trials describe the biosorption behavior as a function of time, but also helps determine163 an equilibrium time that will be maintained for next adsorption experiments.

164 To better describe the kinetics of zinc, copper and lead biosorption onto flax fibers, the 165 experimental data was applied to pseudo-first and pseudo-second order kinetic models and 166 intraparticle diffusion model.

167 Introduced by Lagergren (1898), pseudo-first order kinetic model is obtained by integrating

the following general equation

171 Eq (4) becomes as follows:

173 Where Q_{ε} is the adsorption capacity at equilibrium and k_1 (min⁻¹) the rate constant of the 174 pseudo-first order model.

175 The pseudo-second order kinetic model is obtained from equation (3) for n = 2 (Ho and 176 McKay, 1999):

178 Integrating for the boundary conditions $Q_t = 0$ at t = 0 and Q_t at time t, and rearranging the 179 equation, we obtain:

181 where k_2 is the rate constant of pseudo-second order biosorption (kg, mmol⁻¹, min⁻¹).

182 According to the theory of Weber and Morris, (1963), the intraparticle diffusion model is183 expressed by:

185 where k_{pi} is the intra-particle diffusion rate constant (mmol.kg⁻¹.min^{-1/2}) and c_i is a constant 186 related to the thickness of the boundary layer. The higher is the value of c_i , the greater is the 187 effect of the boundary layer. The adsorption process is completely governed by intra-particle 188 diffusion if the plot of Q_t versus $t^{\frac{1}{2}}$ gives a straight line passing through the origin.

189 2.2.2. The study of pH and biosorbent concentration effects

In order to examine the influence of pH on flax biosorption, 400 mg of flax fibers has been maintained in contact with 200 mL of zinc, copper and lead ions solutions, in both competitive and non-competitive forms under 60 min of magnetic agitation. The concentration of heavy metals in all experiments was about 0.045 mmol.L⁻¹, and the pH values tested were 1.8, 3.0, 4.0 and 6.4. pH was not raised upper to 7.0 in order to avoid the precipitation of the metal ions (Abbar et al., 2017).

196 The study of biosorbent concentration effect was also carried out at equal molar 197 concentrations of 0.044 mmol.L⁻¹ in both types of metal ion systems, and the tested 198 concentrations were 0.5 g.L⁻¹, 1 g.L⁻¹, 2 g.L⁻¹ and 5 g.L⁻¹.

199 **2.2.3. Biosorption curves at equilibrium**

For each batch test, a mass of 400 mg of flax fibers was added within 200 mL of zinc, copper and/or lead ions solutions, in monometal and ternary metal systems. The solutions were shaken for 60 min. Parameters values of the adsorption experiments are presented in Table 1.

Data obtained from adsorption experiments were adjusted to the Langmuir (Eq. (9)) and
Freundlich (Eq. (10)) models.

Where Q_m (mmol.kg⁻¹) is the maximum adsorption capacity, K_L (L.mmol⁻¹) the Langmuir constant related to the adsorption energy, and K_F (L^{1/n}.mmol^(1-1/n).kg⁻¹) and *n* (dimensionless) are the Freundlich coefficients in Eq. (4).

210 The essential characteristic of Langmuir model, expressed in term of dimensionless separation 211 factor R_L was defined as:

This parameter may indicate the nature of adsorption to be either unfavorable ($R_L > 1$), linear ($R_L = 1$), favorable $0 < R_L < 1$, or irreversible ($R_L = 0$).

We specify that in all the presented figures ahead, results related to zinc, copper and lead are referred to as Zn_tri, Cu_tri and Pb_tri respectively in the multimetal system, and Zn_mono, Cu mono and Pb mono in the monometal system.

218 **3. Results and discussion**

219 **3.1.** Characterization of biosorbent: SEM and FT-IR analysis

SEM images of dried flax fibers were performed, one of these is presented in Fig. S1 (SI)
with BSE mode and magnification of 500.

The resulted FT-IR spectrum of unloaded flax fibers, presented in the Fig. S2 in SI, indicated 222 the presence of several functional groups for binding metal ions. The band at 3330 suggests 223 the presence of phenolic, alcoholic or acidic hydroxyl groups (O-H), generally present in 224 lignocellulosic materials (López Pasquali and Herrera, 1997). Bands at 1050, 1104 and 1156 225 cm⁻¹ can be related to a C-O stretching of alcohols and carboxylic acids. The peaks at 1638 226 and 1731 can be assigned to the stretching vibrations of C=C, NH-group and C=O (Monier et 227 al., 2010), which indicate the presence of carboxyl groups and amides. The bands at 2916, 228 1314, 1368 and 1426 can be attributed to the C-H group, also found in sisal fibers used for 229 lead and cadmium biosorption (Dos santos et al., 2011), and other biosorbents such as wheat 230 straw (Coelho et al., 2016) and Crambe abyssinica Hochst seeds (Rubio et al., 2013). These 231 functional groups present in lignin, pectin and hemicellulose are reported to be involved in the 232

adsorption mechanism and responsible for metal binding (Lee and Rowell, 2004). The FT-IR 233 analysis of flax fibers after 60 min adsorption showed no specific difference at the use of 234 $0.044 \text{ mmol}.L^{-1}$ concentration of zinc, copper and lead in the ternary system (Fig. S2), same 235 bands were observed, which may suggest an abundance of active sites and that only few of 236 them were engaged in the biosorption process. At the use of higher concentrations, 0.6 237 $mmol.L^{-1}$ and 1.2 mmol.L⁻¹, the peaks previously observed at 1638 and 1731 disappeared and 238 the ones at 1368, 1426 were significantly dissipated (Fig. S2). This finding means that 239 biosorption process involved chemical reactions between studied metals and existent 240 241 functional groups. Also, the transmittance of the curves after adsorption was higher which confirms less present functional groups on the biosorbent after adsorption. 242

243 **3.2. Biosorption kinetics**

Each of zinc, copper and lead ions removal by flax fibers was plotted as a function of time and presented in Fig. 1, for both ternary and single metal ion solutions. Adsorption behavior was almost the same either in competitive or non-competitive form. Adsorption was very fast in the first 15 min then attained equilibrium within 60 min.





This result has also been found by other authors, when using waste beer yeast (Han et al., 258 2006) and seashells powder (Bozbaş and Boz, 2016), and was explained by a quick sites 259 saturation. We also notice that for the three metals, the adsorption is a bit faster in the single 260 metal ion solution (Fig. 1a, b, and c). As regards to the removal rate, it was higher in the 261 single metal form for the three metals. Metal removal was significantly more important in the 262 single ion solution for Zn (62.0% and 81.8% respectively in the ternary and the single metal 263 ion solution), slightly more important for Cu (75.4% and 80.1% respectively in the ternary 264 and single metal ion solutions), and quite the same for lead (94.4%) (Fig. 1a, b, and c). In the 265 266 ternary metal ion solution (Fig. 1d), the adsorption selectivity was in the order Pb > Cu > Zn, which is a similar result as Krishnani et al., (2008), Pehlivan et al., (2009), Coelho et al., 267 268 (2016) and Cutillas-Barreiro et al., (2014), found using different biosorbents mentioned in section 1. The difference in metals adsorption percentages as well as adsorption capacities at 269 equilibrium between both types of solutions (Table S1 in SI) highlighted the competition 270 271 taking place between metals when they are added simultaneously especially for zinc and copper. Besides, lead was still the most favorable removed heavy metal in both forms. 272

To describe zinc, copper and lead biosorption onto flax fibers in single and ternary metal ion 273 solutions, the experimental data were applied to pseudo first order (Figure S3 in SI) and 274 275 pseudo-second order (Figure S4 in SI) models. Adsorption capacities obtained from the 276 pseudo-first order and pseudo-second order models were very close to the ones observed experimentally (Table S2 in SI). Lead data showed a better fit with the pseudo-second order 277 278 with high correlation coefficients of 0.97 and 0.98 respectively in the monometal and ternary systems (Table S2 in SI), which assumes a chemisorption reaction due to valency forces 279 through sharing or exchange of electrons between flax fibers and divalent metals, and thus a 280 strong chemical bonding with functional groups. This model has been successfully applied to 281 metal ions adsorption from aqueous solutions onto various materials, mainly vegetative fibers, 282 activated carbons, bacteria and agricultural waste (Ho, 2006). Zinc data, on the contrary, 283 exhibited a better adjustment with the pseudo-first order model in both systems (Table S2 in 284 SI), which may indicate that zinc adsorption was controlled by weak interactions such as van 285

der Waals forces between flax and zinc ions, generated by the surface charge density of the adsorbent, explaining thus the weak attachment of zinc to flax fibers compared to lead and copper. Similarly to lead, copper data showed a better fit with the pseudo-second order model in the non-competitive system with a correlation coefficient of 0.98, while in the noncompetitive system no specific difference could be observed between both models, which indicated that both physisorption and chemisorption may be involved in the adsorption mechanism when the three metals are simultaneously added.

In order to analyze the rate limiting step, the intra-particle diffusion model was also used. The 293 data exhibited multilinear plots in this study for all the investigated metals (Fig. S5); 294 suggesting that more than one step influenced the process of biosorption and that other 295 mechanisms may be involved besides intra-particle diffusion (Duan et al., 2016). The values 296 of k_{pi} and c_i for all stages are listed in Table S3 in SI. It is reported that the first stage 297 describes an instantaneous adsorption where the adsorbate migrates from the aqueous solution 298 towards the external surface of the solid, representing a film diffusion. The second step 299 concerns a gradual adsorption, where adsorbate migrates within the pores of adsorbent. The 300 third and final equilibrium stage, also revealed very rapid, cannot be considered the rate 301 controlling step. Hence, the overall rate is either governed by film diffusion or intra-particle 302 diffusion or both. In addition, the obtained linear lines did not pass through the origin, this 303 deviation can be related to the difference in the mass transfer rate in the initial and final stages 304 of adsorption (Tan et al., 2009). 305

306 3.3. Effect of pH

Solution pH is a very essential parameter in adsorption process. It has been very well documented in literature. The effect of pH variation on the removal of metal ions by flax fibers is shown in Fig. 2. Metal biosorption efficiency was very dependent on pH, it decreased along with pH decreasing for the three metals Zn, Cu and Pb. Similarly to Antunes et al., (2003) and Dang et al., (2009) who investigated brown seaweed and wheat straw biosorption respectively, the results indicated that at lower pH, there might be more competition for the

active sites between H⁺ and metal ions, resulting in a very low biosorption of metals. This 313 may also be explained by electrostatic repulsion forces occurring between the surface and the 314 studied cations once active sites are occupied by the protons H⁺. In addition, it has been 315 reported in literature that functional groups which act like active sites for metal binding, may 316 react differently depending on pH. The same sorption selectivity of Pb > Cu > Zn, as in 317 section 3.2, was observed at all pH values tested. Regarding competitive and non-competitive 318 experiments for the three ions, it was apparent that each metal removal was higher in the non-319 competitive form, at all pH values. Overall, biosorption efficiency greatly depended on 320 321 solution pH and reached its optimal at 6.4 for the three metals in both mono and multimetal systems. 322

334 3.4- Effect of the amount of biosorbent

The effect of biosorbent concentration on zinc, copper and lead ions adsorption was studied in both single and multimetal forms at the concentration of 0.044 mmol.L⁻¹ and pH around 6.4. The removal of the three metals was found to increase rapidly with the increase in biosorbent concentration in all experiments (Fig. 3), showing higher availability of active sites. In multimetal solution, lead removal was observed to be the highest and zinc removal the least at

all biosorbent concentrations. Thus the sequence was still Pb > Cu > Zn as previously shown 340 in sections 3.2 and 3.3. However, zinc ion turned out to be well adsorbed when high amount 341 of biosorbent was utilized, mainly at biosorbent concentration of 5 g.L⁻¹, where no difference 342 was noticed between copper and zinc removal (Fig. 3a), owing to the abundance of 343 exchangeable sites, as similarly found in previous studies as Han et al., (2006), El-Ashtoukhy 344 et al., (2008) and Abbar et al., (2017). Regarding the competition effect, it was very visible 345 for zinc removal in the multimetal solution (Fig. 3b). In competitive experiments, Zn removal 346 increased from 4.0% to 62.0% while in non-competitive experiments it increased from 30.1% 347 to 81.8%, when biosorbent concentration increased from 0.25 g.L⁻¹ to 2 g.L⁻¹. The difference 348 of Zn removal between mono and multimetal solutions was though insignificant at the use of 349 5 g.L⁻¹ of flax fibers. A similar behavior was shown in copper and lead removal as functions 350 of biosorbent concentration (Fig. 3c, Fig. 3d), but only from 0.25 g.L⁻¹ up to 1 g.L⁻¹. Beyond 351 the concentration of 1 g.L⁻¹, a slight decrease of copper and lead removal was shown in the 352 353 single metal ion solution, which can be explained by particle interaction such as aggregation of biosorbent that may lead to a decrease in total surface area (Shukla et al., 2002; Semerjian, 354 2018). Therefore, the biosorbent concentration of 2 g.L⁻¹ was maintained in all subsequent 355 356 experiments.

359 3.5. Effect of initial concentration

To study the effect of initial concentration of heavy metals, metal ion solutions of zinc, 361 copper and lead were prepared in both single and multimetal forms, with initial concentrations 362 ranging from 0.04 mmol.L⁻¹ to 1.2 mmol.L⁻¹ (See Table 1). For each adsorption experiment, 363 400 mg of flax fibers was added to 200 mL of metal ion solution. Figure 4a and Figure 4b 364 show heavy metal removal and adsorption capacity, respectively, as functions of added 365 concentrations for the three heavy metals studied, in both types of systems. When initial 366 concentration increased, heavy metal removal generally decreased for the three metals in both 367 single and ternary metal solutions (Fig. 4a) while adsorption capacity increased for all metals 368 except for Zn in the ternary solution (Fig. 4b) where it decreased. 369

378 In non-competitive experiments, the sorption sequence was in the order Pb \gg Cu > Zn for trials with the lowest molar concentrations (0.04, 0.08, 0.16 and 0.36 mmol.L⁻¹) with optimal 379 adsorption capacity values of 108.76, 108.5 and 65.08 mmol.kg⁻¹ respectively (Fig. 4b), 380 corresponding to 58.0%, 57.5% and 36.2% of metal removal (Fig. 4a), obtained at the initial 381 concentration of 0.36 mmol.l⁻¹. Whereas for the highest concentrations (0.67 and 1.2 mmol.L⁻ 382 ¹), the selectivity sequence changed to Cu $\geq Pb \geq Zn$ with maximum adsorption capacity 383 values of 119.2, 112.3 and 80.1 mmol.kg⁻¹ respectively, corresponding to 32.3%, 31.3% and 384 24.1% of metal removal, obtained at the initial concentration of 0.67 mmol.L⁻¹. A slight 385 decrease of sorption capacity was shown at 1.2 mmol.L⁻¹ for the three ions. 386

On the other hand, the competitive experiments showed the selectivity sequence Pb > Cu >> 387 Zn at all times, and also a considerable favorable retention for lead and copper comparing 388 with zinc (Fig. 4a). Lead sorption capacities increased from 19.9 to 90.7 mmol.kg⁻¹, when the 389 initial concentration increased from 0.04 to 1.2 mmol.L⁻¹, although its removal percentage 390 decreased from 94.4% to 15.0%. Similarly, copper sorption capacities increased from 16.1 to 391 66.4 mmol.kg⁻¹ with the increase of initial concentration, while its removal percentage 392 decreased from 75.4% to 10.8%. For zinc, the adsorption behavior was different, sorption 393 capacities were very low decreasing from 13.0 to 2.7 mmol.kg⁻¹, and its removal percentage 394

also decreased from 62.0% to 0.9%, when initial concentrations increased from 0.04 to 1.2 395 mmol.L⁻¹. Zinc was thus the less adsorbed ion in all experiments. Comparing competitive and 396 non-competitive experiments, zinc was also the most affected ion by the presence of other 397 ions, its sorption was very considerably higher in the non-competitive trials (from 18.23 to 398 80.1 mmol.kg⁻¹) than in the competitive trials (from 13.0 to 2.7 mmol.kg⁻¹). For copper, the 399 competition effect was also visible. Its sorption was higher in the non-competitive (from 17.9 400 to 119.2 mmol.kg⁻¹) than in the competitive experiments (from 16.1 to 66.4 mmol.kg⁻¹). 401 Concerning lead, the impact of competition was the less important but still quite visible 402 between the non-competitive (21.9 to 112.3 mmol.kg⁻¹) and competitive trials (19.9 to 90.7 403 mmol.kg⁻¹). 404

Therefore, higher affinity with active sites was mainly observed for lead ions, as previously 405 shown by Al-Asheh and Duvnjak, (1998) and Park et al., (2016) at the use of pine bark and 406 sesame straw biochar respectively, which allows faster interaction with functional groups. As 407 evidenced in FT-IR analysis in section 3.1, flax fibers contain negatively charged functional 408 groups that are able to complex metals. The studies developed by Guo et al., (2008) and Lee 409 and Rowell, (2004) have demonstrated that the carboxylic and phenolic groups present in 410 lignin play an important role in adsorption processes. They can induce complexes formation 411 with heavy metals through the coordination bonds. In addition, and according to several 412 researches, it has been suggested that ion exchange is one of the most responsible 413 mechanisms in biosorption process. Chen et al. (2010) demonstrated that biosorption process 414 using Cinnamomum camphora leaves powder was dominated by ion-exchange mechanism 415 based on activation energies of the reactions. Božić et al. (2009) showed that heavy metals 416 and protons were substituted by the alkali-earth metals contained in the molecular structure of 417 sawdust of deciduous trees, by investigating the release of Ca²⁺, Mg²⁺, Na⁺, K⁺ and H⁺ from 418 the adsorbent. 419

420 It is also worthwhile to mention that the sorption capacities for the three metals in both 421 systems followed the same order as their electronegativities Pb (2.33) > Cu (1.90) > Zn (1.65) 422 (McBride, 1994), which is one of the justifications put forward to explain this selectivity 423 order, also found in studies using chitosan and egg shell (Shaheen et al., 2013), pine bark 424 (Cutillas-Barreiro et al., 2014), and sesame straw biochar (Park et al., 2016). This is in 425 particular attributed to the fact that metal ions with higher electronegativities exhibit higher 426 attractions for electrons (Deng et al., 2019). Another explanation is that the hydrated radius of 427 lead (4.01 Å) is smaller than that of copper (4.19 Å) and zinc (4.30 Å), which enables lead to 428 form stronger bonds with most functional groups (Park et al., 2016).

Regarding the ionic interaction effect between monometal and multimetal systems, one of the 429 methods consists in evaluating the ratio R of the ion sorption capacity in the multimetal 430 system Q_{e-mult} to the ion sorption capacity in the monometal system Q_{e-mono} (Mohan and 431 Chander, 2001), in a way that for R > 1, the ion sorption is promoted in the multimetal 432 system, and for R < 1 the ion sorption gets overcome by the presence of other ions, and for R 433 = 1 no interaction occurs between ions. In this study, a destructive effect was mainly shown 434 435 for zinc ions in the ternary metal system as zinc removal got promptly decreasing with the increase of metal initial concentrations. Its sorption capacities were also the lowest and quite 436 constant, unlike zinc behavior in the single metal form, where sorption capacity joined the 437 438 same behavior as copper and lead sorption capacities. In the ternary system, the ratios R(Zn) varied between 0.14 and 0.06 once beyond the initial concentration of 0.08 mmol.L⁻¹, while 439 for copper it was ranged between 0.52 and 0.43, and for lead between 0.84 and 0.68. Other 440 works have reported this destructive effect in multimetal aqueous solutions, such as the work 441 developed by Reynel-Avila et al., (2016), which used flamboyant and bush mango biomasses 442 in binary systems of Pb^{2+} - Ni^{2+} and Pb^{2+} - Cd^{2+} . Monometal experiments showed that 443 cadmium and nickel were considerably affected by the presence of lead whose adsorption 444 capacities in single and binary systems were almost identical ($R(Pb) \approx 1$). A similar behavior 445 was observed in a ternary metal system of Pb^{2+} - Cu^{2+} - Cd^{2+} , using wheat straw as biosorbent 446 (Coelho et al., 2016). Cadmium ions were efficiently removed in the single metal ion 447 experiments (metal removal ranging from 90.6% to 81.5%) but were overcome by the 448

449 presence of lead and copper especially at the highest concentration of 6.0 mmol.L^{-1} where

450 only 23.4% of cadmium was removed.

451 **3.6.** Biosorption curves in competitive and non-competitive experiments

Adsorption curves are essential to describe adsorption characteristics at a constant 452 temperature. For that purpose, several adsorption models have been established in literature, 453 the most common used are the Langmuir and Freundlich models. The first assumes a 454 homogeneous surface and that all active sites have equal energies, while the second describes 455 456 a heterogeneous surface and shows no limit saturation. To study biosorption curves of the three ions by flax fibers, experimental adsorption capacity at equilibrium Q_{e} was plotted 457 against equilibrium concentration C_{e} and compared with the Langmuir and Freundlich models 458 for both monometal and multimetal solutions (Fig. 5), except for zinc in the ternary system as 459 zinc adsorption capacity was significantly low and promptly decreased when added 460 concentration increased. Hence, zinc adsorption curve in the ternary system couldn't fit the 461 models and obtained values of K_L and n were meaningless, which confirmed a very difficult 462 adsorption of zinc on active sites. On the other hand, and based on the calculated values 463 (Table 2), it can be inferred that the Langmuir model provides a slightly better fit for flax 464 fibers suggesting thus a monolayer adsorption, besides for copper in the ternary system where 465 the Freundlich showed a better adjustment, indicating a probable multilayer adsorption of 466 copper when other ions are co-existent. 467

The monolayer adsorption capacities Q_{max} (mmol.kg⁻¹) of flax fibers determined using the Langmuir model followed the order Pb (81.61) > Cu (57.48) > Zn (8.03) in the competitive experiments, and changed to Cu (121.57) > Pb (111.68) > Zn (76.40) in the non-competitive experiments. All adsorption capacities were lower in the multimetal solution, as shown in section 3.5. The ratio $\frac{Q_{max}}{Q_{max}}$ of each metal where $Q_{max_{mono}}$ and $Q_{max_{multi}}$ are the maximum sorption capacities in the mono and multimetal systems respectively, indicated that zinc adsorption was 10 times lower in the competitive experiments, while copper and lead

adsorption were only 2 and 1.4 times lower respectively. This clearly showed that zinc ions 475 were very affected by competition and easily exchanged by other metals. In addition, the 476 Langmuir constant K_L , related to the affinity of the binding sites was higher in the non-477 competitive experiments for copper and lead (Table 2), showing a stronger affinity with the 478 adsorbent active sites. Furthermore, the parameter R_L was represented in Fig. S6 in SI for all 479 conducted experiments except for zinc in the multimetal solution. Fig. S6 (SI) indicated a 480 very favorable adsorption for the studied metals in the single form where $0.02 < R_L(Zn) <$ 481 0.41, 0.01 \leq R_L(Cu) \leq 0.32 and 0.003 \leq R_L(Pb) \leq 0.09. In the multimetal system, R_L got 482 higher but was still indicating a good adsorption for copper and lead as $0.02 < R_L(Cu) < 0.39$ 483 and $0.01 < R_1(Pb) < 0.22$. The competition effect was thus very important for zinc, and less 484 485 visible for copper and lead. Similarly, in a study conducted by Mahamadi and Nharringo, (2010) on Eichhornia crassipes, it has been shown that cadmium and zinc ions were overcome 486 in the presence of lead. Park et al. (2016) have also found that cadmium and zinc adsorption 487 488 were respectively 17.2 and 4.85 times lower in the multimetal system of (Cd, Zn, Cu, Cr, Pb) using sesame straw biochar. Liu and Lian (2019) have reported as well that the adsorption of 489 cadmium and nickel ions on biogenic vaterite were reduced by 82.42% and 65.09% 490 491 respectively in the presence of copper.

492 Compared to other lignocellulosic materials in the scientific literature, flax fibers adsorption capacity was very competitive (see Table S4 in SI). The maximum adsorption capacity of zinc 493 using flax fibers (76.40 mmol.kg⁻¹) was more important than that of jute fibers (54.30 494 mmol.kg⁻¹) and hemp fibers (35.00 mmol.kg⁻¹) (Shukla et al., 2005; Pejic et al., 2009). Also, 495 the maximum adsorption capacity of copper (121.57 mmol.kg⁻¹) was higher than those 496 reported for bornean oil palm shell (27.63 mmol.kg⁻¹), barley straw (73.01 mmol.kg⁻¹), jute 497 fibers (66.56 mmol.kg⁻¹) and sawdust (28.16 mmol.kg⁻¹) (Chong et al., 2013; Pehlivan et al., 498 2009a; Shukla et al., 2005; Yu et al., 2001). For lead, flax fibers biosorption (111.68 499 mmol.kg⁻¹) was very high comparing with sisal fibers (6.47 mmol.kg⁻¹), sawdust (15.40 500 mmol.kg⁻¹), bornean oil palm shell (16.36 mmol.kg⁻¹), chitosan (25.62 mmol.kg⁻¹), rice husk 501

(40.11 mmol.kg⁻¹), almond shell (38.99 mmol.kg⁻¹), and hemp fibers (74.00 mmol.kg⁻¹) (Dos
Santos et al., 2011; Yu et al., 2001; Chong et al., 2013; Zulkali et al., 2006; Pehlivan et al.,
2009b; Pejic et al., 2009), very close to that of barley straw (111.96 mmol.kg⁻¹), and slightly
lower than those of hazelnut shell (136.00 mmol.kg⁻¹) and cashew nut shell (138.27 mmol.kg⁻¹)
(Pehlivan et al., 2009b; Coelho et al., 2014). Based on these results, it has been shown that
flax fibers had a very good adsorption capacity and therefore it is a very efficient material for
water treatment and heavy metals removal.

Using the Freundlich model, the Freundlich constant K_F (L^{1/n}.mmol^(1-1/n).kg⁻¹) related to the 509 adsorption capacity was in the order Pb (92.66) > Cu (63.28) > Zn (8.03) in multimetal 510 511 solution and Cu (128.52) > Pb (120.65) > Zn (80.10) in monometal solution (Table 2). Comparing the ratio $\frac{K_{F \text{mono}}}{K_{F \text{multi}}}$ for each metal, it followed the order Zn (9.98) > Cu (2.02) > Pb 512 513 (1.30) indicating that zinc was very affected by competition while lead and copper were not very influenced, similarly as demonstrated above with the Langmuir model. Furthermore, the 514 Freundlich constant n ranging between 2 and 10 (Table 2), attested that the biosorption was 515 very favorable for all the ions, except again for zinc in the ternary metal system where *n* value 516 was meaningless. Therefore, both adsorption models showed the same behavior of ions, even 517 though a better adjustment was generally shown with the Langmuir rather than the Freundlich 518 model. 519

550 Conclusion

Flax fibers were used to remove heavy metals from aqueous solutions. A series of batch 551 experiments were performed adding lead, copper and zinc ions, either simultaneously or 552 individually. The aim of the study was to evaluate and compare adsorption behavior of these 553 metals in two conditions. The obtained results under competitive conditions were different 554 from those obtained in non-competitive conditions. The adsorption efficiency of flax fibers 555 related to each heavy metal was higher in the single metal ion solution, and the order of the 556 adsorption selectivity was Pb \approx Cu > Zn and changed to Pb > Cu >> Zn in the multimetal 557 solution. Lead was the most retained metal in multimetal solution followed by copper, while 558 zinc was very considerably affected by the presence of other ions. Electronegativity, hydrated 559 radius, and ions interactions with functional groups were the main justifications of this 560 finding, in addition to ion exchange which was reported to be the most dominant mechanism 561 in biosorption process. On the other hand, the effectiveness of the ions removal was found to 562 be very dependent on the aqueous solution pH, contact time, initial concentration of metals 563 and biosorbent concentration. 564

Based on the overall results, flax fibers demonstrated a high biosorption capacity of heavy metals in both forms of solutions, except for zinc in the multimetal solution. It is thus an available and efficient low-cost material for water treatment, whose recycling should be promoted. Hence, in order to regenerate flax fibers and judge the reversibility of biosorption, further studies will be conducted to evaluate ions desorption and investigate conditions of ions release.
