# A biharmonic transmission problem in $L^{p}$-spaces

#### Abstract

In this work we study, by a semigroup approach, a transmission problem based on biharmonic equations with boundary and transmission conditions, in two juxtaposed habitats. We give a result of existence and uniqueness of the classical solution in $L^{p}$-spaces, for $p \in(1,+\infty)$, using analytic semigroups and operators sum theory in Banach spaces. To this end, we invert explicitly the determinant operator of the transmission system in $L^{p}$-spaces using the $\mathcal{E}_{\infty}$-calculus and the Dore-Venni sums theory. ## 1 Introduction

In this work, we consider a system of linear biharmonic equations posed on two juxtaposed domains and coupled through boundary conditions at the interface. Throughout the paper we shall impose the continuity of the flux, of the dispersal and of its flux across the interface. Using an operator approach, we investigate the existence, uniqueness as well as maximal $L^{p}$-regularity for such a problem.

Transmission problems arise in various applicative fields including engineering, physics and biology. Here, we refer the reader for instance to [2], [11] or [17] for applications in plate theory, to [20], [29] or [37] for applications in electromagnetism and to [12], [23] or [36] for other applications in population dynamics. Let us also mention that mathematical models involving biharmonic operators also arise in various fields such as elasticity for instance see [8], [18] or [33], electrostatic see [5], [15] or [24], plate theory [2], [11] or [17] or population dynamics [7], [21], [22] or [28].

In this work, we consider a $n$-dimensional (with $n \geqslant 2$ ) straight cylinder of the form $\Omega=(a, b) \times \omega$ where $a<b$ are two given real numbers while the section $\omega \subset \mathbb{R}^{n-1}$ denotes a smooth bounded domain. This cylinder $\Omega$ is split into two (open) sub-cylinders $\Omega_{ \pm}$and an interface $\Gamma$ given for some $\gamma \in(a, b)$ by

\Omega_{-}=(a, \gamma) \times \omega, \quad \Omega_{+}=(\gamma, b) \times \omega \quad \text { and } \quad \Gamma=\{\gamma\} \times \omega,
$$

so that $\Omega=\Omega_{-} \cup \Gamma \cup \Omega_{+}$.
We consider the following biharmonic equations,

where $g_{-} \in L^{p}\left(\Omega_{-}\right), g_{+} \in L^{p}\left(\Omega_{+}\right)$are given and $k_{+}, k_{-}>0$.
We denote by $(x, y)$ the spatial variables with $x \in(a, b)$ and $y \in \omega$. Then, we consider the following conditions on $\partial \Omega \backslash \Gamma$, the lateral boundary of $\Omega$,
where $\varphi_{1}^{ \pm}$and $\varphi_{2}^{ \pm}$will be given in appropriated spaces. The system is coupled on the interface $\Gamma$ where we impose the following continuity conditions,

k_{-} \frac{\partial \Delta u_{-}}{\partial x} & =k_{+} \frac{\partial \Delta u_{+}}{\partial x} & & \text { on } \Gamma .
\end{aligned}\right.

Let us now explain, for instance, in population dynamics framework, the boundary and transmission conditions.

The first line of $\left(B C_{p d e}\right)-(1)$, means that the individuals could not lie on the boundaries $(a, b) \times \partial \omega$, because, for instance, they die or the edge is impassable. The second line means that there is no dispersal in the normal direction. We deduce that the dispersal vanishes on $(a, b) \times \partial \omega$.

In $\left(B C_{p d e}\right)-(2)$, the population density and the flux are given on $\{a, b\} \times \omega$. This means that the habitats are not isolated.

In $\left(T C_{p d e}\right)$, the two first transmission conditions mean the continuity of the density and its flux at the interface, while the two second express, in some sense, the continuity of the dispersal and its flux at $\Gamma$.

This work is a natural continuation of that done in [34]. Moreover, it completes the study realized in [22] where the authors have considered equations

and on the interface $\Gamma$, the last condition of $\left(T C_{p d e}\right)$ is replaced by

In the present work, $l_{ \pm}=0$, which must be treated differently, since the proof in [22] uses the representation formula obained in [21] which is not defined when $l_{ \pm}=0$. Thus, we use the representation formula obtained in [34] which is different.

Note that, due to the transmission conditions, we can not obtain a solution $u \in W^{4, p}(\Omega)$ in all $\Omega$. We only can obtain a solution $u$ such that $u_{\left.\right|_{\Omega_{-}}} \in W^{4, p}\left(\Omega_{-}\right)$and $u_{\left.\right|_{\Omega_{+}}} \in W^{4, p}\left(\Omega_{+}\right)$.

The paper is organized as follows.
First, in section 2, we recall the PDE transmission problem ( $P_{p d e}$ ) and we define the Laplace operator $A_{0}$, then we rewrite problem $\left(P_{p d e}\right)$ under operational form which will be generalized replacing $A_{0}$ by a more general operator $A$ in problem (P).

Then, in section 3, we recall some definitions about BIP operator and interpolation spaces. We give our hypotheses and their consequences. We explain how to solve our problem ( P ) by introducing two auxiliary problems $\left(P_{-}\right)$and $\left(P_{+}\right)$. Finally, we present our main result in Theorem 3.9 and as a consequence of this theorem, we obtain the Corollary 3.11 which states existence and uniqueness of the solution of problem $\left(P_{p d e}\right)$ that is $\left(E Q_{p d e}\right)-\left(B C_{p d e}\right)-\left(T C_{p d e}\right)$ quoted above.

In section 4, we state technical results which allow us to prove our main result. In Proposition 4.2 and in Proposition 4.4 we give necessary and sufficient condition to solve problems $\left(P_{-}\right)$and ( $P_{+}$). Moreover, we give an explicit representation formula of the solutions of $\left(P_{-}\right)$and $\left(P_{+}\right)$. We establish (see Theorem 4.6) a useful technical result which help us to prove Theorem 3.9. Then, we show some technical lemmas which lead us to apply functional calculus.

In Section 5, we give the proof of Theorem 3.9. This section is composed of three parts: in the first part, we use Theorem 4.6 to make explicit the determinant of the transmission system. In the second part, we explicitly inverse the determinant of the transmission system using functional calculus. Finally, in the last part, we show that the unique solution of the transmission problem ( P ) is a classical solution (see (2) in Section 2 below) by showing that this solution have the expected regularity.

## 2 Operational formulation

In this section, we first recall the PDE problem $\left(P_{p d e}\right)$ composed by $\left(E Q_{p d e}\right)-\left(B C_{p d e}\right)-\left(T C_{p d e}\right)$. Then, we define the Laplace operator $A_{0}$ and we use it to rewrite ( $P_{p d e}$ ) using $A_{0}$. Note that this operational form is a vector values problem. Finally, we generalize this problem replacing $A_{0}$ by a more general operator $A$.

We consider the following problem

Let us define $A_{0}$, the Laplace operator in $\mathbb{R}^{n-1}, n \in \mathbb{N} \backslash\{0,1\}$, as follows

Thus, using operator $A_{0}$, problem ( $P_{p d e}$ ) becomes the following vector valued problem

where

f_{-} \in L^{p}\left(a, \gamma ; L^{p}(\omega)\right), \quad f_{+} \in L^{p}\left(\gamma, b ; L^{p}(\omega)\right) \quad \text { and } \quad p \in(1,+\infty),
$$

with

$$
u_{ \pm}(x):=u(x, \cdot) \quad \text { and } \quad f_{ \pm}(x):=g_{ \pm}(x, \cdot) / k_{ \pm} .
$$

Note that the boundary conditions on $\partial \omega$ in $\left(P_{p d e}\right)$ do not appear in the previous system since they are already included in the domain of $A_{0}$. Thus, a classical solution of this problem satisfies the boundary conditions on $\partial \omega$ in $\left(P_{p d e}\right)$.

Then, using operator $(A, D(A))$ instead of $\left(A_{0}, D\left(A_{0}\right)\right)$ and $X$ instead of $L^{p}(\omega)$, we can write that $f_{-} \in L^{p}(a, \gamma ; X)$ and $f_{+} \in L^{p}(\gamma, b ; X)$.

Moreover, in all the sequel, we will study the following more general transmission problem (P):

The transmission conditions (TC) will be split into

and

Note that (TC2) is well defined from Lemma 3.7, see Section 3.2 below.
We will search a classical solution of problem (P), that is a solution $u$ such that

\begin{cases}u_{-}:=u_{\mid(a, \gamma)} \in W^{4, p}(a, \gamma ; X) \cap L^{p}\left(a, \gamma ; D\left(A^{2}\right)\right), & u_{-}^{\prime \prime} \in L^{p}(a, \gamma ; D(A)),  \tag{2}\\ u_{+}:=u_{\mid(\gamma, b)} \in W^{4, p}(\gamma, b ; X) \cap L^{p}\left(\gamma, b ; D\left(A^{2}\right)\right), & u_{+}^{\prime \prime} \in L^{p}(\gamma, b ; D(A)),\end{cases}
$$

and which satisfies $(E Q)-(B C)-(T C)$.

## 3 Assumptions, consequences and statement of results

### 3.1 The class $\operatorname{BIP}(X, \theta)$

Throughout the article, $(X,\|\cdot\|)$ is a complex Banach space. We give some definitions about UMD spaces, sectorial operators and BIP operators.

Definition 3.1. A Banach space $X$ is a UMD space if and only if for all $p \in(1,+\infty)$, the Hilbert transform is bounded from $L^{p}(\mathbb{R}, X)$ into itself (see [3] and [4]).

Definition 3.2. A closed linear operator $T_{1}$ is called sectorial of angle $\theta \in[0, \pi)$ if
i) $\sigma\left(T_{1}\right) \subset \overline{S_{\theta}}$,
ii) $\forall \theta^{\prime} \in(\theta, \pi), \quad \sup \left\{\left\|\lambda\left(\lambda I-T_{1}\right)^{-1}\right\|_{\mathcal{L}(X)}: \lambda \in \mathbb{C} \backslash \overline{S_{\omega^{\prime}}}\right\}<+\infty$,
where

$$
S_{\omega}:= \begin{cases}\{z \in \mathbb{C}: z \neq 0 \text { and }|\arg (z)|<\omega\} & \text { if } \omega \in(0, \pi),  \tag{3}\\ (0,+\infty) & \text { if } \omega=0,\end{cases}
$$

see [16], p. 19,
Remark 3.3. From [19], p. 342, we know that any injective sectorial operator $T_{1}$ admits imaginary powers $T_{1}^{i s}, s \in \mathbb{R}$, but, in general, $T_{1}^{i s}$ is not bounded.

Definition 3.4. Let $\theta \in[0, \pi)$. We denote by $\operatorname{BIP}(X, \theta)$, the class of sectorial injective operators $T_{1}$ such that
i) $\overline{D\left(T_{1}\right)}=\overline{R\left(T_{1}\right)}=X$,
ii) $\forall s \in \mathbb{R}, \quad T_{1}^{i s} \in \mathcal{L}(X)$,
iii) $\exists C \geq 1, \forall s \in \mathbb{R}, \quad\left\|T_{1}^{i s}\right\|_{\mathcal{L}(X)} \leq C e^{|s| \theta}$,
see [30], p. 430.
Remark 3.5. In the previous case, from [16], proof of Proposition 3.2.1, c), p. 71, $\overline{D\left(T_{1}\right) \cap R\left(T_{1}\right)}=X$.

### 3.2 Interpolation spaces

Here we recall a definition given, for instance, in [9], [14], [25] or in [35] and a result from [14] concerning real interpolation spaces.

Definition 3.6. Let $T_{2}: D\left(T_{2}\right) \subset X \longrightarrow X$ be a linear operator such that

Let $k \in \mathbb{N} \backslash\{0\}, \theta \in(0,1)$ and $q \in[1,+\infty]$. We will use the real interpolation spaces

\left(D\left(T_{2}^{k}\right), X\right)_{\theta, q}=\left(X, D\left(T_{2}^{k}\right)\right)_{1-\theta, q},
$$

defined, for instance, in [25], or in [26].
In particular, for $k=1$, we have the following characterization

\left(D\left(T_{2}\right), X\right)_{\theta, q}:=\left\{\psi \in X: t \longmapsto t^{1-\theta}\left\|T_{2}\left(T_{2}-t I\right)^{-1} \psi\right\|_{X} \in L_{*}^{q}(0,+\infty)\right\},
$$

where $L_{*}^{q}(0,+\infty)$ is given by

L_{*}^{q}(0,+\infty):=\left\{f \in L^{q}(0,+\infty):\left(\int_{0}^{+\infty}\|f(t)\|^{q} \frac{d t}{t}\right)^{1 / q}<+\infty\right\}, \quad \text { for } q \in[1,+\infty)
$$

and for $q=+\infty$, by

L_{*}^{\infty}(0,+\infty):=\sup _{t \in(0,+\infty)}\|f(t)\|,
$$

see [9] p. 325, or [14], p. 665, Teorema 3, or section 1.14 of [35], where this space is denoted by $\left(X, D\left(T_{2}\right)\right)_{1-\theta, q}$. Note that we can also characterize the space $\left(D\left(T_{2}\right), X\right)_{\theta, q}$ taking into account the Osservazione, p. 666, in [14].

We set also, for any $k \in \mathbb{N} \backslash\{0\}$

\left(D\left(T_{2}\right), X\right)_{k+\theta, q} & :=\left\{\psi \in D\left(T_{2}^{k}\right): T_{2}^{k} \psi \in\left(D\left(T_{2}\right), X\right)_{\theta, q}\right\}, \\
\left(X, D\left(T_{2}\right)\right)_{k+\theta, q} & :=\left\{\psi \in D\left(T_{2}^{k}\right): T_{2}^{k} \psi \in\left(X, D\left(T_{2}\right)\right)_{\theta, q}\right\} .
\end{aligned}

We recall the following lemma.
Lemma 3.7 ([14]). Let $T_{2}$ be a linear operator satisfying (4). Let u such that

u \in W^{n, p}\left(a_{1}, b_{1} ; X\right) \cap L^{p}\left(a_{1}, b_{1} ; D\left(T_{2}^{k}\right)\right),
$$

where $a_{1}, b_{1} \in \mathbb{R}$ with $a_{1}<b_{1}, n, k \in \mathbb{N} \backslash\{0\}$ and $p \in(1,+\infty)$. Then for any $j \in \mathbb{N}$ satisfying the Poulsen condition $0<\frac{1}{p}+j<n$ and $s \in\left\{a_{1}, b_{1}\right\}$, we have

u^{(j)}(s) \in\left(D\left(T_{2}^{k}\right), X\right)_{\frac{j}{n}+\frac{1}{n p}, p} .
$$

This result is proved in [14], p. 678, Teorema 2'.

### 3.3 Hypotheses

Througout this article, $k_{+}, k_{-} \in \mathbb{R}_{+} \backslash\{0\}$ and $A$ denotes a closed linear operator in $X$.
We assume the following hypotheses:

\left(H_{1}\right) & X \text { is a UMD space, } \\
\left(H_{2}\right) & 0 \in \rho(A), \\
\left(H_{3}\right) & -A \in \operatorname{BIP}\left(X, \theta_{A}\right) \text { for some } \theta_{A} \in(0, \pi / 2), \\
\left(H_{4}\right) & \sigma(A) \subset(-\infty, 0) \text { and } \forall \theta \in(0, \pi), \sup _{\lambda \in S_{\theta}}\left\|\lambda(\lambda I-A)^{-1}\right\|_{\mathcal{L}(X)}<+\infty .
\end{array}
$$

Note that assumption $\left(H_{4}\right)$ means that $-A$ is a sectorial operator of any angle $\theta \in(0, \pi)$. Now, we give some consequences on our hypotheses.

### 3.4 Consequences

1. Note that $A_{0}$ satisfies all the previous hypotheses with $X=L^{q}(\omega)$, with $q \in(1,+\infty)$. From [32], Proposition 3, p. 207, $X$ satisfies $\left(H_{1}\right)$ and from [13], Theorem 9.15, p. 241 and Lemma 9.17, p. 242, $A_{0}$ satisfies $\left(H_{2}\right)$. Moreover, from [31], Theorem C, p. 166-167, $\left(H_{3}\right)$ is satisfied for every $\theta_{A} \in(0, \pi)$, thus $\left(H_{4}\right)$ is also satisfied.
2. In the scalar case, to solve each equation of $(E Q)$, it is necessary to introduce the square roots $\pm \sqrt{-A}$ of the characteristic equations

$$

this is why, in our operational case, we consider,

$$
\begin{equation*}
M:=-\sqrt{-A} . \tag{5}
\end{equation*}
$$

From $\left(H_{3}\right),-A$ is a sectorial operator, thus the existence of $M$ is ensured, see for instance [16], e), p. 25.
3. From $\left(H_{3}\right)$, we have $-A \in \operatorname{BIP}\left(X, \theta_{A}\right)$, then, from [16], Proposition 3.2.1, e), p. 71, we deduce

$$
-M \in \operatorname{BIP}\left(X, \theta_{A} / 2\right) .
$$

Since $0<\theta_{A} / 2<\pi / 2$, we deduce that $M$ generate a bounded analytic semigroup $\left(e^{x M}\right)_{x \geqslant 0}$, see [30], Theorem 2, p. 437.
Furthermore, due to [30], Theorem 4, p. 441, for $n \in \mathbb{N} \backslash\{0\}$, we get $-n M \in \operatorname{BIP}\left(X, \theta_{A} / 4+\varepsilon\right)$, for any $\varepsilon \in\left(0, \pi / 2-\theta_{A} / 4\right)$. Then, due to [30], Theorem 2 , p. 437, $n M$ generate a bounded analytic semigroup $\left(e^{n x M}\right)_{x \geqslant 0}$. The last results use also the works of [9] and [10].

### 3.5 The main results

To solve our transmission problem (P), we introduce two auxiliary problems:

$$
\left(P_{-}\right)\left\{\begin{array}{l}

Remark 3.8. We say that $u$ is a classical solution of $(\mathrm{P})$ if and only if there exist $\psi_{1}, \psi_{2} \in X$ such that
(i) $\quad u_{-}$is a classical solution of $\left(P_{-}\right)$,
(ii) $\quad u_{+}$is a classical solution of $\left(P_{+}\right)$,
(iii) $\quad u_{-}$and $u_{+}$satisfy (TC2).

Note that by construction, if there exist a classical solution $u_{-}$of $\left(P_{-}\right)$and $u_{+}$of $\left(P_{+}\right)$, then $u_{-}$and $u_{+}$satisfy (TC1).

Our goal is to prove that there exists a unique couple $\left(\psi_{1}, \psi_{2}\right)$ which satisfies $(i),(i i)$ and (iii). This will lead us to obtain our main result.

Theorem 3.9. Let $f_{-} \in L^{p}(a, \gamma ; X)$ and $f_{+} \in L^{p}(\gamma, b ; X)$. Assume that $\left(H_{1}\right)$, ( $H_{2}$ ) and ( $H_{3}$ ) be satisfied. Then, there exists a unique classical solution $u$ of the transmission problem ( $P$ ) if and only if

## Remark 3.10.

1. In the proof of Theorem 3.9, we use operator $M$ and interpolation spaces $(D(M), X)_{3-j+\frac{1}{p}, p}$, $j=0,1,2,3$. But from the reiteration Theorem, we get

2. We can generalize the previous Theorem by considering a transmission problem between $n$ juxtaposed habitats, with $n \in \mathbb{N} \backslash\{0\}$. For instance, with $n=3$, it suffices to use Theorem 3.9 on the two first habitats and then apply it on the transmission problem between the second and third habitat to solve the problem. By recurrence, we obtain the result for $n$ habitats.

As consequence of Theorem 3.9, we deduce the following result for problem $\left(P_{p d e}\right)$. Consider the case $A=A_{0}$ (other cases can be treated).

Corollary 3.11. Assume that $\omega$ is a bounded open set of $\mathbb{R}^{n-1}$ where $n \geq 2$ with $C^{2}$-boundary. Let $g_{+} \in L^{p}\left(\Omega_{+}\right)$and $g_{-} \in L^{p}\left(\Omega_{-}\right)$with $p \in(1,+\infty)$ and $p>n$; let $k_{+}, k_{-} \in \mathbb{R}_{+} \backslash\{0\}$. Then, there exists a unique solution $u$ of $\left(P_{p d e}\right)$, such that

Proof. The proof is quite similar to the one of Corollary 3.6 in [22], see also Corollary 2.7 in [21].

Taking into account the result of Theorem 3.9, we can also obtain anisotropic results by considering $f_{-} \in L^{p}\left(a, \gamma ; L^{q}(\omega)\right)$ and $f_{+} \in L^{p}\left(\gamma, b ; L^{q}(\omega)\right)$ with $p, q \in(1,+\infty)$.

## 4 Preliminary results

Throughout this article, we set

From Remark 3.8, to solve problem ( P ), we first have to study problems ( $P_{-}$) and $\left(P_{+}\right)$. To this end, we need the following invertibility result obtained in [34].
Lemma 4.1 ([34]). The operators $U_{+}, U_{-}, V_{+}, V_{-} \in \mathcal{L}(X)$ defined by

### 4.4 Functional calculus

To prove Theorem 3.9, it remains, from Theorem 4.6, to solve system (19). To this end, we have to inverse the determinant operator of system (19) by using functional calculus.

We first recall some classical notations. Let $\theta \in(0, \pi)$, we denote by $H\left(S_{\theta}\right)$ the space of holomorphic functions on $S_{\theta}$ (defined by (3)). Moreover, we consider the following subspace of $H\left(S_{\theta}\right)$ :

Thus, $\mathcal{E}_{\infty}\left(S_{\theta}\right)$ is the space of polynomial decreasing holomorphic functions at $+\infty$.
Let $T$ be an invertible sectorial operator of angle $\theta_{T} \in(0, \pi)$ and let $f \in \mathcal{E}_{\infty}\left(S_{\theta}\right)$, with $\theta \in\left(\theta_{T}, \pi\right)$, then, by functional calculus, we can define $f(T) \in \mathcal{L}(X)$, see [16], p. 45. In this work, we use functional calculus, as classicaly done, see for instance [6] or for analytic semigroup generation [1] and [27].

We recall a useful invertibility result from [21], Lemma 5.3.
Lemma 4.7 ([21]). Let $P$ be an invertible sectorial operator in $X$ with angle $\theta$, for all $\theta \in(0, \pi)$. Let $G \in H\left(S_{\theta}\right)$, for some $\theta \in(0, \pi)$, such that
(i) $1-G \in \mathcal{E}_{\infty}\left(S_{\theta}\right)$,
(ii) $G(x) \neq 0$ for any $x \in \mathbb{R}_{+} \backslash\{0\}$.

Then, $G(P) \in \mathcal{L}(X)$, is invertible with bounded inverse.
Now, to inverse the determinant of system (19), we introduce some holomorphic functions which will play the role of $G$ in the previous lemma. Then, we study them on the positive real axis.

Let $\delta>0$ and $z \in \mathbb{C} \backslash \mathbb{R}_{-}$. We set

Note that $f \in H\left(S_{\theta}\right)$, for all $\theta \in(0, \pi)$. It follows that

Proof. Let $\delta>0$, from Lemma 4.4, in [34], for all $z \in \mathbb{C}_{+} \backslash\{0\}$, we have

## 5 Proof of the main result

Assume that (P) has a unique classical solution, then, (6) holds from Theorem 4.6.
Conversely, Assume that (6) holds. From Theorem 4.6, it suffices to show that system (19) has a unique solution such that (25) is satisfies.

The proof is divided in three parts. In the first part, we make explicit the determinant of system (19). Then, in the second part, we show the uniqueness of the solution, to this end, we inverse the determinant with the help of functional calculus. Finally, in the last part, we prove that $\psi_{1}$ and $\psi_{2}$ have the expected regularity.

### 5.1 Calculus of the determinant

In this section, we make explicit the determinant. Recall system (19):

& =-M\left(P_{1}^{+} P_{3}^{+}-\left(P_{2}^{+}\right)^{2}+P_{1}^{-} P_{3}^{-}-\left(P_{2}^{-}\right)^{2}+P_{1}^{+} P_{3}^{-}+P_{1}^{-} P_{3}^{+}+2 P_{2}^{+} P_{2}^{-}\right) .

We begin to calculate each terms separately. Then, we have

P_{1}^{+} P_{3}^{+}=k_{+}^{2}\left(\left(U_{+}^{-2}+V_{+}^{-2}\right)\left(I-e^{2 d M}\right)^{2}+2 U_{+}^{-1} V_{+}^{-1}\left(I+e^{2 d M}\right)^{2}+8 U_{+}^{-1} V_{+}^{-1} e^{2 d M}\right) .
$$

Moreover, we have

$$
\begin{aligned}
\left(P_{2}^{+}\right)^{2} & =k_{+}^{2}\left(U_{+}^{-1}+V_{+}^{-1}\right)^{2}\left(I-e^{2 d M}\right)^{2} \\
& =k_{+}^{2}\left(U_{+}^{-2}+V_{+}^{-2}\right)\left(I-e^{2 d M}\right)^{2}+2 k_{+}^{2} U_{+}^{-1} V_{+}^{-1}\left(I-e^{2 d M}\right)^{2} .
\end{aligned}
$$

It follows

$$
\begin{aligned}
P_{1}^{+} P_{3}^{+}-\left(P_{2}^{+}\right)^{2}= & k_{+}^{2}\left(\left(U_{+}^{-2}+V_{+}^{-2}\right)\left(I-e^{2 d M}\right)^{2}+2 U_{+}^{-1} V_{+}^{-1}\left(I+e^{2 d M}\right)^{2}+8 U_{+}^{-1} V_{+}^{-1} e^{2 d M}\right) \\
& -k_{+}^{2}\left(U_{+}^{-2}+V_{+}^{-2}\right)\left(I-e^{2 d M}\right)^{2}-2 k_{+}^{2} U_{+}^{-1} V_{+}^{-1}\left(I-e^{2 d M}\right)^{2} \\
= & 2 k_{+}^{2} U_{+}^{-1} V_{+}^{-1}\left(\left(I+e^{2 d M}\right)^{2}-\left(I-e^{2 d M}\right)^{2}+4 e^{2 d M}\right) \\
= & 2 k_{+}^{2} U_{+}^{-1} V_{+}^{-1}\left(\left(I+2 e^{2 d M}+e^{4 d M}\right)-\left(I-2 e^{2 d M}+e^{4 d M}\right)+4 e^{2 d M}\right) \\
= & 2 k_{+}^{2} U_{+}^{-1} V_{+}^{-1}\left(4 e^{2 d M}+4 e^{2 d M}\right) \\
= & 16 k_{+}^{2} U_{+}^{-1} V_{+}^{-1} e^{2 d M} .
\end{aligned}
$$

In the same way, replacing respectively $k_{+}, U_{+}^{-1}, V_{+}^{-1}$ and $d$ by $k_{-}, U_{-}^{-1}, V_{-}^{-1}$ and $c$, we obtain

$$
P_{1}^{-} P_{3}^{-}-\left(P_{2}^{-}\right)^{2}=16 k_{-}^{2} U_{-}^{-1} V_{-}^{-1} e^{2 c M}
$$

Thus, the determinant of $\Lambda$ writes

$$
\begin{equation*}
\operatorname{det}(\Lambda)=-M\left(16 k_{+}^{2} U_{+}^{-1} V_{+}^{-1} e^{2 d M}+16 k_{-}^{2} U_{-}^{-1} V_{-}^{-1} e^{2 c M}+P_{1}^{+} P_{3}^{-}+P_{1}^{-} P_{3}^{+}+2 P_{2}^{+} P_{2}^{-}\right) . \tag{33}
\end{equation*}
$$

Finally, from (32) and (33), we obtain

$$
\begin{equation*}
\operatorname{det}(\Lambda)=-M f(-A) \tag{34}
\end{equation*}
$$

### 5.2 Inversion of the determinant

Let $C_{1}, C_{2}$ two linear operators in $X$. We note $C_{1} \sim C_{2}$ to means that $C_{1}=C_{2}+\Sigma$, where $\Sigma$ is a finite sum of term of type $k M^{n} e^{\alpha M}$, with $k \in \mathbb{R}, n \in \mathbb{N}$ and $\alpha \in \mathbb{R}_{+} \backslash\{0\}$. Note that $\Sigma$ is a regular term in the sense:

$$
\Sigma \in \mathcal{L}(X) \quad \text { with } \quad \Sigma(X) \subset D\left(M^{\infty}\right):=\bigcap_{k \geqslant 0} D\left(M^{k}\right)
$$

Since $U_{ \pm} \sim I$ and $V_{ \pm} \sim I$, then setting $W=U_{+} U_{-} V_{+} V_{-} \sim I$, we obtain

$$
\left\{\begin{array}{l}
W P_{1}^{+} \sim 2 k_{+} I, W P_{1}^{-} \sim 2 k_{-} I, \\
W P_{2}^{+} \sim 2 k_{+} I, W P_{2}^{-} \sim 2 k_{-} I, \\
W P_{3}^{+} \sim 2 k_{+} I, W P_{3}^{-} \sim 2 k_{-} I .
\end{array}\right.
$$

Moreover, we have

$$
16 k_{+}^{2} W^{2} U_{+}^{-1} V_{+}^{-1} e^{2 d M} \sim 0 \quad \text { and } \quad 16 k_{-}^{2} W^{2} U_{-}^{-1} V_{-}^{-1} e^{2 c M} \sim 0
$$

We then deduce the following relation

$$
\begin{aligned}
-M^{-1} W^{2} \operatorname{det}(\Lambda)= & 16 k_{+}^{2} W^{2} U_{+}^{-1} V_{+}^{-1} e^{2 d M}+16 k_{-}^{2} W^{2} U_{-}^{-1} V_{-}^{-1} e^{2 c M} \\
& +W P_{1}^{+} W P_{3}^{-}+W P_{1}^{-} W P_{3}^{+}+2 W P_{2}^{+} W P_{2}^{-} \\
\sim & 4 k_{+} k_{-} I+4 k_{+} k_{-} I+8 k_{+} k_{-} I \\
\sim & 16 k_{+} k_{-} I .
\end{aligned}
$$

Thus, we get

$$
\begin{equation*}
\operatorname{det}(\Lambda)=-W^{-2} M\left(16 k_{+} k_{-} I+\sum_{j \in J} k_{j} M^{n_{j}} e^{\alpha_{j} M}\right) \tag{35}
\end{equation*}
$$

where $J$ is a finite set and for all $j \in J$ :

$$
k_{j} \in \mathbb{R}, n_{j} \in \mathbb{N} \quad \text { and } \quad \alpha_{j} \in \mathbb{R}_{+} \backslash\{0\} .
$$

From (35), we have

$$
\begin{equation*}
\operatorname{det}(\Lambda)=-16 k_{+} k_{-} W^{-2} M F, \tag{36}
\end{equation*}
$$

where

$$
\begin{equation*}
F=I+\sum_{j \in J} \frac{k_{j}}{16 k_{+} k_{-}} M^{n_{j}} e^{\alpha_{j} M} . \tag{37}
\end{equation*}
$$

For $z \in \mathbb{C} \backslash \mathbb{R}_{-}$, we set

$$
\tilde{f}(z)=1+\sum_{j \in J} \frac{k_{j}}{16 k_{+} k_{-}}(-\sqrt{z})^{n_{j}} e^{-\alpha_{j} \sqrt{z}} .
$$

Then, $F=\tilde{f}(-A)$ and from (34) and (36), we have

$$
f(-A)=-M^{-1} \operatorname{det}(\Lambda)=16 k_{+} k_{-} W^{-2} \tilde{f}(-A) .
$$

Thus, by construction, for $z \in \mathbb{C} \backslash \mathbb{R}_{-}$, the link between $f$ and $\tilde{f}$ is

$$
\begin{equation*}
f(z)=16 k_{+} k_{-} u_{d}^{-2}(z) u_{c}^{-2}(z) v_{d}^{-2}(z) v_{c}^{-2}(z) \tilde{f}(z) . \tag{38}
\end{equation*}
$$

Proposition 5.1. The operator $F \in \mathcal{L}(X)$ defined by (37), is invertible with bounded inverse.
Proof. Note that $f, \tilde{f} \in H\left(S_{\theta}\right)$, for a given $\theta \in(0, \pi)$. Moreover, for $z \in \mathbb{C} \backslash \mathbb{R}_{-}$and $j \in J$, functions $\frac{k_{j}}{16 k_{+} k_{-}}(-\sqrt{z})^{n_{j}}$ are polynomial. Thus, $1-\tilde{f} \in \mathcal{E}_{\infty}\left(S_{\theta}\right)$.

From Lemma 4.4 in [34], $u_{d}, u_{c}, v_{d}$ and $v_{c}$ do not vanish on $\mathbb{C}_{+} \backslash\{0\}$. Moreover, due to Lemma 4.8, $f$ does not vanish on $\mathbb{R}_{+} \backslash\{0\}$, Thus, we deduce from (38) that $\tilde{f}$ do not vanish on $\mathbb{R}_{+} \backslash\{0\}$.

Finally, we apply Lemma 4.7 with $P=-A$ and $G=\tilde{f}$ to obtain that $F=\tilde{f}(-A) \in \mathcal{L}(X)$ is invertible with bounded inverse.

We are now in position to prove the main result of this section.
Proposition 5.2. The operator $\operatorname{det}(\Lambda)$, defined by (36) is invertible with bounded inverse.
Proof. From Lemma 4.1, $U_{+}, U_{-}, V_{+}$and $V_{-}$are bounded invertible operators with bounded inverse. So we deduce that $W^{-2}$ is invertible with bounded inverse. Moreover, from $\left(H_{2}\right)$, (36) and Proposition 5.1, we obtain that $\operatorname{det}(\Lambda)$ is invertible with bounded inverse.

### 5.3 Regularity

To study the regularity, we need to recall the following technical result from [21], Lemma 5.1.
Lemma 5.3 ([21]). Let $V \in \mathcal{L}(X)$ such that $0 \in \rho(I+V)$. Then, there exists $W \in \mathcal{L}(X)$ such that

$$
(I+V)^{-1}=I-W,
$$

and $W(X) \subset V(X)$. Moreover, if $T$ is a linear operator in $X$ such that $V(X) \subset D(T)$ and for $\psi \in D(T), T V \psi=V T \psi$, then

$$
\forall \psi \in D(T), \quad W T \psi=T W \psi .
$$

From Proposition 5.2, system (19) has a unique solution $\left(\psi_{1}, \psi_{2}\right)$. From Theorem 4.6, it remains to prove that

$$
\psi_{1} \in(D(A), X)_{1+\frac{1}{2 p}, p} \quad \text { and } \quad \psi_{2} \in(D(A), X)_{1+\frac{1}{2}+\frac{1}{2 p}, p} .
$$

To this end, we have to study the regularity of the inverse of the determinant $\operatorname{det}(\Lambda)$.
Lemma 5.4. There exists $R_{d} \in D\left(M^{\infty}\right)$ such that

$$
[\operatorname{det}(\Lambda)]^{-1}=-\frac{1}{16 k_{+} k_{-}} M^{-1}+R_{d} .
$$

Proof. From (36) and Proposition 5.2, we have

$$
[\operatorname{det}(\Lambda)]^{-1}=-\frac{1}{16 k_{+} k_{-}} M^{-1} W^{2} F^{-1} .
$$

From Lemma 5.3, there exists $R_{F} \in D\left(M^{\infty}\right)$, such that

$$
F^{-1}=I+R_{F} .
$$

Moreover, for $\delta>0$, we know that

$$
\begin{equation*}
e^{\delta M} \psi \in D\left(M^{\infty}\right) \tag{39}
\end{equation*}
$$

Since $W=U_{+} U_{-} V_{+} V_{-}$, from (39), there exists $R_{W} \in D\left(M^{\infty}\right)$ such that

$$
W^{2}=I+R_{W} .
$$

We deduce that there exists $R_{d} \in D\left(M^{\infty}\right)$, such that

$$
[\operatorname{det}(\Lambda)]^{-1}=-\frac{1}{16 k_{+} k_{-}} M^{-1}+R_{d} .
$$

Now, we study the regularity of $\psi_{1}$ and $\psi_{2}$. We recall that

$$
\Lambda \Psi=S
$$

where $\Lambda$ is invertible from Proposition 5.2. From Lemma 5.3, there exist $R_{U_{ \pm}}, R_{V_{ \pm}} \in D\left(M^{\infty}\right)$, such that

$$
\begin{equation*}
U_{ \pm}^{-1}=I+R_{U_{ \pm}} \quad \text { and } \quad V_{ \pm}^{-1}=I+R_{V_{ \pm}} . \tag{40}
\end{equation*}
$$

From (39) and (40), there exist $R_{i} \in D\left(M^{\infty}\right), i=1,2,3,4$, such that

$$
\Lambda=\left(\begin{array}{cc}
2\left(k_{+}+k_{-}\right) M+R_{1} & -2\left(k_{+}-k_{-}\right) I+R_{2} \\
2\left(k_{+}-k_{-}\right) M+R_{3} & -2\left(k_{+}+k_{-}\right) I+R_{4}
\end{array}\right) .
$$

It follows that there exist $\mathcal{R}_{1}, \mathcal{R}_{2} \in D\left(M^{\infty}\right)$, such that

$$
\left\{\begin{array}{l}
\psi_{1}=\frac{\left(k_{+}+k_{-}\right)}{8 k_{+} k_{-}} M^{-1} S_{1}-\frac{\left(k_{+}-k_{-}\right)}{8 k_{+} k_{-}} M^{-1} S_{2}+\mathcal{R}_{1}  \tag{41}\\
\psi_{2}=\frac{\left(k_{+}-k_{-}\right)}{8 k_{+} k_{-}} S_{1}-\frac{\left(k_{+}+k_{-}\right)}{8 k_{+} k_{-}} S_{2}+\mathcal{R}_{2}
\end{array}\right.
$$

where $S_{1}$ is given by (22) and $S_{2}$ is given by (24).
Since $F_{+}$is a classical solution of problem $\left(P_{+}\right)$and $F_{-}$is a classical solution of problem $\left(P_{-}\right)$, then from Remark 4.3 and Remark 4.5, we obtain that $\check{S}$ defined by (23) has the following regularity

$$
\begin{equation*}
\check{S} \in(D(M), X)_{\frac{1}{p}, p} \tag{42}
\end{equation*}
$$

Moreover, from (7), we have

$$
\varphi_{1}^{+}, \varphi_{1}^{-} \in(D(A), X)_{1+\frac{1}{2 p}, p}=(D(M), X)_{3+\frac{1}{p}, p}
$$

and

$$
\varphi_{2}^{+}, \varphi_{2}^{-} \in(D(A), X)_{1+\frac{1}{2}+\frac{1}{2 p}, p}=(D(M), X)_{2+\frac{1}{p}, p}
$$

Thus, from (12), (17), Lemma 5.3, Remark 4.3 and Remark 4.5, we deduce that

$$
\begin{equation*}
\tilde{\varphi}_{1}^{+}, \tilde{\varphi}_{1}^{-}, \tilde{\varphi}_{3}^{+}, \tilde{\varphi}_{3}^{-} \in(D(M), X)_{3+\frac{1}{p}, p} \quad \text { and } \quad \tilde{\varphi}_{2}^{+}, \tilde{\varphi}_{2}^{-}, \tilde{\varphi}_{4}^{+}, \tilde{\varphi}_{4}^{-} \in(D(M), X)_{2+\frac{1}{p}, p} \tag{43}
\end{equation*}
$$

So, from (22), (24), (39), (42) and (43), we have

$$
\begin{equation*}
S_{1} \in(D(M), X)_{2+\frac{1}{p}, p} \quad \text { et } \quad S_{2} \in(D(M), X)_{2+\frac{1}{p}, p} \tag{44}
\end{equation*}
$$

Finally, from (7), (41) and (44), we obtain

$$
\psi_{1} \in(D(M), X)_{3+\frac{1}{p}, p}=(D(A), X)_{1+\frac{1}{2 p}, p} \quad \text { and } \quad \psi_{2} \in(D(M), X)_{2+\frac{1}{p}, p}=(D(A), X)_{1+\frac{1}{2}+\frac{1}{2 p}, p}
$$
