Ruthenium-Catalyzed Tandem C-H Fluoromethylation/Cyclization of N-Alkylhydrazones with CBr₃F: Access to 4-Fluoropyrazoles

ABSTRACT: 4-Fluoropyrazoles are accessible in a single step from readily available aldehyde-derived N-alkylhydrazones through double C-H fluoroalkylation with tribromofluoromethane (CBr_3F) . $RuCl_2(PPh_3)_3$ has been proven to be the most efficient catalyst for this transformation when compared to a range of other Cu-, Pd-, or Fe-based catalyst systems.

The importance of fluorine-containing pyrazoles to the pharmaceutical and agrochemical industries has been increasing steadily in recent years. As a consequence, the development of methods suitable for incorporation of fluorine or fluoroalkyl groups into the pyrazole ring continues to be the subject of intense research. In this area, the number of efficient strategies available for 4-fluoropyrazoles remains fairly limited. The most convenient and reliable methods developed over the past several years toward these valuable compounds are essentially based on a fluorinated building-block approach where the fluorine atom is incorporated early in the synthetic process. These include cyclocondensations of fluorinated carbonyl derivatives, i.e. β -dicarbonyl and $\alpha_i\beta$ -unsaturated compounds, with substituted hydrazines, as well as cycloaddition reactions of fluoroalkenes or fluoroalkynes with diazocompounds.³ Among limitations that may be associated with these methods are low global yields over several synthetic steps, poor regioselectivities, and the use of dangerous reagents. Unfortunately, alternative approaches based on direct fluorination of the pyrazole ring suffer from rather low reaction efficiency and a narrow substrate scope. Halogen exchange⁴ or Balz-Schiemann⁵ processes are low yielding and require the synthesis of appropriately prefunctionalized pyrazole substrates. On the other hand, direct electrophilic C-H fluorinations are highly substrate dependent and selectivity issues can arise from the use of highly reactive fluorinating species (i.e., F_2 , CF_3OF , Selectfluor, NFSI). Alongside the classical methods, goldcatalyzed tandem cyclization/fluorination reactions of Nmonosubstituted alkynylhydrazones in the presence of Selectfluor have also been established as an interesting approach toward 4-fluoropyrazoles, although the corresponding nonfluorinated derivatives are also produced as byproducts.

Recently, we developed a new synthetic method for the rapid assembly of pyrazole derivatives based on a copper-chloride-catalyzed double C–H functionalization of aldehyde-derived N,N-dialkylhydrazones with trihalomethane derivatives. The process is believed to follow $C(sp^2)$ –H haloalkylation/ $C(sp^3)$ –H cyclization/aromatization cascade reaction sequences. An important feature of the process pertains to the flexible incorporation of functional groups arising from the organic

halides at position C-4 of the pyrazole ring, which include ester, ketone, cyano, and halide (Cl, Br). The method was then envisioned as an attractive opportunity to also access 4fluoropyrazoles by using a trihalofluoromethane derivative as the alkylating species. The most important advantages of this new approach would be (1) the ready availability of starting materials; (2) the concomitant pyrazole formation and fluorine incorporation avoiding selectivity issues and the necessity for multistep synthesis of fluorinated substrates; (3) the avoidance of highly reactive and often rather expensive fluorinating reagents; and (4) an access to unusual pyrazolo-annelated compounds. Disappointingly, however, our previously established Cu-catalyzed process proved inefficient for this purpose, and this constrained us to re-examine the reaction conditions and possibly identify other metals as viable catalysts for promoting the desired transformation. Herein, we report the successful use of RuCl₂(PPh₃)₃ as an effective, alternative catalyst system in combination with CBr₃F as the fluoromethyl source (eq 1).

In our previous report, the following conditions [10 mol % CuCl(1,10-phen), Et₃N (4 equiv), 1,4-dioxane, 80 °C, 2 h] had been established as being optimal for the synthesis of 4-functionalized pyrazoles from a series of aromatic aldehydederived hydrazones, and various polyhalomethanes, with the notable exception of CCl₃F and CBr₃F. For instance, these conditions proved inefficient in converting 4-cyanobenzaldehyde *N,N*-dimethylhydrazone 1a, our model substrate for the

present study, into the corresponding 4-fluoropyrazole (2a), even over a prolonged period of time (18 h) in the presence of 5.0 equiv of the fluoromethylating reagents (Table 1, entries 1– 2). Although an increase in reaction temperature (up to 130 °C) using CBr₃F as the fluoromethyl radical source enhanced the reaction efficiency to some extent (Table 1, entry 3), this result was still not satisfying in terms of yield (50% as estimated by ¹⁹F NMR spectroscopy), and small amounts of several other unidentified side products were produced in the process. Other catalysts were thus investigated. Aside from copper salt derivatives, transition metal complexes derived from ruthenium, iron, palladium, or nickel are among the most commonly suggested catalysts for promoting radical reactions of polyhaloalkanes. 10 Gratifyingly, the commercially available and inexpensive ruthenium(II) complex [RuCl₂(PPh₃)₃] has been found to be a very effective alternative catalyst for the desired transformation even at a lower loading level (5 mol %) (Table 1, entry 4). 11 Furthermore, the ethereal solvent diglyme having a higher boiling point than 1,4-dioxane proved to be the solvent of choice, particularly when associated with potassium carbonate as a base in place of triethylamine (Table 1, entries 4-6). Pleasingly, these modified reaction conditions allowed clean formation of the desired pyrazole 2a in quantitative yield (Table 1, entry 7). Notably, the related palladium(II)- and copper(I)-derived catalysts (i.e., PdCl₂(PPh₃)₂; CuCl(PPh₃)₃) were found to be less effective (Table 1, entries 8-9). On the other hand, metal complexes of nitrogen-based bidentate ligands, e.g. CuCl(Phen) and FeCl₂(bpy)₃, gave satisfactory results under the new reaction conditions, but at higher catalyst loadings (Table 1, entries 10–11). Finally, it was found that the amount of both base and CBr₃F could be decreased to 2 equiv without any noticeable effect on yield, while lowering the amount of RuCl₂(PPh₃)₃ to 1 mol % still afforded the pyrazole in a good 75% yield (Table 1, entry 12). However, 5 mol % of the catalyst ensures complete reaction within 7 h (Table 1,

entry 13), and this loading level was thus used in the following experiments. It is of note that the same reaction performed in the absence of catalyst did only proceed to a very limited extent (Table 1, entry 14). The base was also found to be critical to the success of the reaction (Table 1, entry 15).

Next, we investigated the generality of the reaction by using a series of diversely substituted N-alkylhydrazones (Scheme 1). Variation of para- and meta-substituents on the aryl moiety of benzaldehyde N,N-dimethylhydrazone derivatives was well tolerated (see 2a-l), with the best yields being generally achieved with electron-withdrawing substituents. ¹² For instance, while the p-cyano-substituted benzaldehyde derivative furnished the highest isolated yield (2a, 85%), the analogous substrate bearing a strongly electron-donating p-dimethylamino group participated less efficiently in the reaction affording the desired pyrazole (21) in only 41% yield. However, the yield of 21 could be increased to 58% by simply raising the reaction temperature to 150 °C and using sodium carbonate as a base, which was found to be superior to potassium carbonate in this case. As illustrated by 2g, even sterically hindered orthosubstituted aryls were tolerated to some extent. Importantly, heterocyclic hydrazones (e.g., 2-quinolinyl (see 2m), and 2furyl (see 2n)) proved suitable substrates for the transformation (2m-n). We then attempted to expand the substrate scope to nonaromatic aldehyde hydrazones. Disappointingly, as already observed in our previous work, aliphatic aldehyde hydrazones were not tolerated in this reaction, as illustrated with 20. 13 On the other hand, we were pleased to discover that hydrazones derived from α -ketoaldehydes, and notably from ethyl glyoxylate (see 2p) and glyoxal (see 2q), were suitable substrates for this transformation, which further demonstrates the broad applicability of the method. Overall, the reaction displayed good tolerance toward a variety of functional groups, including cyano, carboxylic ester, formyl, and halide which may serve as useful reaction handles for further elaborations. Finally,

the effect of varying the nature of the terminal amino group of hydrazones was investigated. For example, a *N*-methyl-*N*-phenyl hydrazone provided the corresponding *N*-phenyl-substituted pyrazole (**2r**) but required a higher temperature. A *N*,*N*-dibenzylhydrazone furnished the corresponding *N*-benzyl derivative (**2s**) as a group potentially removable from *N*-1, while enabling installation of a phenyl substituent at the C-5 position of the pyrazole ring. Other hydrazones bearing cyclic amino groups, e.g. 1-piperidyl (see **2t**) and 1-homopiperidyl (see **2u**), also participated in the cyclization process, giving the corresponding pyrazolo-annelated products in fair yields.

The reaction path is assumed to follow a Ru^{II}/Ru^{III} redox mechanism similar to that previously proposed for the related copper-catalyzed process. Halide abstraction from CBr₃F by the Ru(II) complex would generate haloalkyl radical **A** with concomitant generation of Ru(III). Subsequent trapping of **A** by the hydrazone would generate aminyl radical **B**. Oxidation of this intermediate with Ru(III) would recycle Ru(II) and lead

to diazenium species C. Base-induced elimination of HBr from this cationic intermediate would then give unsaturated species D, which would tautomerize into the corresponding iminium cation E by proton abstraction from the *N*-methyl group. Subsequent intramolecular cyclization of the enamine-type structure would then provide pyrazoline 3. Finally, another loss of HBr from 3 would lead to the desired aromatized product 2 (Scheme 2). Total inhibition of the standard reaction

of 1a in the presence of radical scavenger 2,2,6,6-tetramethyl-1-piperidinoxyl (TEMPO, 2 equiv) supports such a radical-initiated mechanism.

In summary, we have developed a novel method for preparing 4-fluoropyrazoles from aldehyde-derived hydrazones, tribromofluoromethane, and a ruthenium(II) catalyst. The method has the advantages of ready availability of starting materials, a simple one-step protocol, a broad substrate scope, and excellent functional-group tolerance. Moreover, concomitant pyrazole formation and fluorine incorporation ensure total control over product selectivity.

EXPERIMENTAL SECTION

General Information. All starting aldehyde-derived hydrazones were prepared as described in our previous papers. 8,9a-d CCl3F and CBr₃F are commercially available reagents and were used as purchased. ¹H (300 or 400 MHz) NMR spectra were recorded in CDCl₃ with reference to the residual undeuterated solvent signal (δ 7.26 ppm). ¹³C (101 MHz) NMR spectra were recorded relative to the central CDCl₃ resonance (δ 77.16 ppm). ¹⁹F (282 MHz) NMR spectra with ¹H decoupling were recorded relative to CCl₃F (δ 0.0 ppm). NMR yields were determined by adding hexafluorobenzene (C_6F_6 , δ –164.9 ppm) as an internal standard to the crude reaction mixtures and by integration of crude ¹⁹F NMR. Flash chromatographies were performed on silica gel (40-63 μ m). Melting points (Mp) are uncorrected. The high resolution mass spectra were recorded by direct introduction in a positive and negative ion mode on a hybrid quadrupole time-of-flight mass spectrometer (MicroTOFQ-II, Bruker Daltonics, Bremen) with an Electrospray Ionization (ESI) ion source. The solutions were infused at 180 μ L/h. The mass range of the analysis was $50-1000 \, m/z$, and the calibration was done with sodium formate.

General Procedure. Preparation of 4-Fluoropyrazoles (2). In a 10 mL microwave reaction vial equipped with a magnetic stir bar, $K_2\text{CO}_3$ (166 mg, 1.2 mmol), CBr_3F (120 μL , 1.2 mmol), and $\text{RuCl}_2(\text{PPh}_3)_3$ (28 mg, 5 mol %) were successively added to a solution of the selected hydrazone (0.6 mmol) in diglyme (3 mL). The vial was flushed with argon and capped, and the reaction mixture was stirred overnight at 130 °C (oil bath). The mixture was cooled to room temperature and filtered through Celite using ethyl acetate as eluent to

remove solid residues. The volatiles were then removed from the filtrate under vacuum to yield a crude residue which was purified by silica gel flash chromatography to afford the corresponding pyrazole.
