# ON FIRST ORDER MEAN FIELD GAME SYSTEMS WITH A COMMON NOISE

#### Abstract

We consider Mean Field Games without idiosyncratic but with Brownian type common noise. We introduce a notion of solutions of the associated backward-forward system of stochastic partial differential equations. We show that the solution exists and is unique for monotone coupling functions. This the first general result for solutions of the Mean Field Games system with common and no idiosynctratic noise. We also use the solution to find approximate optimal strategies (Nash equilibria) for $N$-player differential games with common but no idiosyncratic noise. An important step in the analysis is the study of the well-posedness of a stochastic backward Hamilton-Jacobi equation.


## 1. Introduction

We consider Mean Field Games (MFG for short) without idiosyncratic but with Browniantype common noise described by the backward-forward system of stochastic partial differential equations (SPDEs for short)

We introduce a notion of solution of (1.1), which is adapted to the common noise $W$, and prove existence and uniqueness when the couplings $F$ and $G$ are nonlocal and satisfy the well-known Lasry-Lions monotonicity condition introduced in [30]. Exact assumptions are stated later. To the best of our knowledge, this is the first general result for solutions of the MFG-system with common and no idiosynctratic noise. We also use the solution to derive approximate Nash equilibria for $N$-player differential games with common but no idiosyncratic noise assuming a structure condition on $H$.
An important step in our analysis is the study of the well-posedness of strong, that is, a.e. in space-time and semiconcave in space, solutions of the backward stochastic Hamilton-Jacobi (HJ for short) equation

with $H$ uniformly convex; again exact assumptions are stated later.
MFG with common noise describe optimal control problems with infinitely many small and interacting controllers whose dynamics are subjected to common noise. Such models appear
often in macroeconomics under the name "heterogenous agent models"; see, for instance, the work of Krusell and Smith [24].
The mathematical description of MFG with common noise, which was introduced by Lions [31] and then discussed, at an informal level, in Bensoussan, Frehse and Yam [5] and Carmona and Delarue [13], is either probabilistic or analytic.
The probabilistic formulation takes the form of an optimal stochastic control problem involving a random distribution of the agents, which is the conditional law, given the common noise, of the optimal trajectory of the agents. In this setting, the existence of generalized solutions, that is, solutions adapted to a larger filtration than the one generated by the common noise, has been established by Carmona, Delarue and Lacker [15] under very general assumptions; see also Ahuja [1] and Lacker and Webster [27]. The former reference also establishes the existence and uniqueness of a strong solution, which is adapted to the filtration of the common noise, under the Lasry-Lions monotonicity condition and an assumption on the uniqueness of the optimal solution (with relaxed controls) of the stochastic control problem. Although the probabilistic formulation allows for general existence and uniqueness results, it requires the resolution of an optimal stochastic control problem, which is not convenient for the numerical approximation or the explicit analysis. Moreover, the condition on the uniqueness of the optimal solution, which is quite demanding, has been shown to be satisfied only under the strong assumption that either there is a nondegenerate idiosyncratic noise, or that the value function is convex in space. The latter is known to hold only for dynamics which are linear in space and for cost functions which are strictly convex in space and control.
The analytic approach to study MFG problems with common noise involves the value function and the partial differential equation (PDE for short) it satisfies. There are two different but also very related formulations involving either stochastic MFG systems or the so-called master equation.
The former describes the problem as a coupled system of SPDEs known as the backwardforward stochastic MFG system. For problems without common noise, the system was introduced and studied by Lasry and Lions in [28, 29]. In the presence of both idiosyncratic and common noises the stochastic MFG system was first investigated by Cardaliaguet, Delarue, Lasry and Lions in [10].
The second analytic approach, which was introduced by Lasry and Lions and presented by Lions in [31], is based on the master equation, which is a deterministic infinite dimensional PDE set in the space of measures. The existence and uniqueness of solutions of the general infinite dimensional version of the master equation with idiosyncratic and common noise was shown in [10]; see also [14] for a generalization. Among other recent references about the master equation we point out the works of Cardaliaguet, Cirant and Porretta [9] who proposed a splitting method, Lions [31] who introduced the Hilbertian approach, in which the master equation is embedded in the space of square integrable random variables, and, finally, Bayraktar, Cecchin, Cohen and Delarue [4] and Bertucci, Lasry and Lions [6, 7] who investigated the existence and uniqueness for problems with common noise in finite state spaces.
Here we study the stochastic MFG system (1.1) which consists of a backward stochastic HJ-equation coupled with a forward stochastic Kolmogorov-Focker-Plank (KFP for short) PDE. In (1.1), the Brownian motion $W$ is the common noise and the unknown is the triplet $(u, m, v)$, consisting of the value function $u$ of a small agent, which solves the backward HJ

SPDE with Hamiltonian of the form $H\left(D u_{t}, x\right)-F\left(x, m_{t}\right)$, an auxiliary function $v$ which ensures that $u$ is adapted to the filtration generated by the noise $W$, and the density $m$ of the players which solves the forward stochastic KFP SPDE. The two equations are coupled through $F$ and $G$, which depend on $m$ in a nonlocal way.
The main difference with previous works and, in particular, [10] is that, due to the absence of idiosyncratic noise, the solution of (1.1) is not expected to be "smooth" since the HJ and KFP equations are only degenerate parabolic.
To explain this problem, we first consider the HJ equation separately, that is, we look at (1.2), which is a backward SPDE (BSPDE for short) associated with an optimal control problem with random coefficients. It follows from the work of Peng [32] that (1.2) has a unique solution provided that the noise satisfies a nondegeneracy assumption, which, roughly speaking, means that the $\beta$ in front of $\Delta u_{t}$ is greater than the $\beta$ in front of the terms involving $v$. More recently, (1.2) was studied by Qiu [33] and Qiu and Wei [34], who introduced a notion of viscosity solution involving derivatives on the path space and proved its existence and uniqueness. The equations studied in the last references are more general than (1.2), in particular, the volatility is not constant, and require few conditions on the Hamiltonian other than the standard growth and regularity.
The study of MFG with common noise necessitates the use of a completely different approach, since the continuity equation for $m$ involves the derivative of $u$ in space and not a weak derivative in the path space.
To motivate the new approach we are putting forward here, we recall what happens for MFG problems without noise at all, that is, when $\beta=0$. In this deterministic case, where one can take $v \equiv 0$, the natural concept of solution for (1.1) requires $u$ to be Lipschitz continuous and to satisfy the HJ equation in the viscosity sense, while $m$ has to be bounded and to satisfy the KFP equation in the sense of distributions; see [30] and Cardaliaguet and Hadikhanloo [11] for details. We note that, since $m$ is absolutely continuous and bounded, the term $m D_{p} H\left(D u_{t}, x\right)$ is well-defined. However, it is also known that the boundedness condition on $m$ can hold on large time intervals only if $H=H(p, x)$ is convex in $p$; see, for example, Golse and James [21] where, to study a forward-forward system with nonconvex $H$, it is necessary to consider a much more degenerate notion of solution. When $H$ is convex in $p$, the solution of the HJ equation is naturally semiconcave. Then the notion of viscosity solution of HJ is equivalent to the one of the semiconcave a.e. solution studied by Kruzhkov [25]; see also Douglis [17], Evans [18], and Fleming [20].
The first contribution of the paper is to show that the notion of semiconcave a.e. solution can be adapted to the BSPDE (1.2) when reinterpreted in a suitable way. The starting point is the change of variable

The problem then becomes to find a pair $\left(\widetilde{u}_{t}, \widetilde{M}_{t}\right)_{t \in[0, T]}$ adapted to the filtration of $\left(W_{t}\right)_{t \in[0, T]}$, where $\widetilde{M}=\widetilde{M}_{t}(x)$ is a globally bounded martingale, $\widetilde{u}$ is continuous and semiconcave in the space variable, and (1.3) is satisfied in an integrated form.

Theorem 2.3 and Proposition 2.5 establish respectively that (1.3) has a solution and a comparison principle is satisfied. In Proposition 2.7 we also provide a stochastic control representation of the solution. The optimality conditions and the existence and the uniqueness of optimal trajectories are respectively the topics of Theorem 2.8 and Proposition 2.13. However, this last point, which relies on the analysis of a continuity equation associated with the drift $-D_{p} \widetilde{H}\left(D \widetilde{u}_{t}(x), x\right)$ (see Proposition 2.11 and Proposition 2.12) requires a much stronger structure condition on the Hamiltonian, which we discuss later.
Next we apply this approach to (1.1). After the formal change of variables

we obtain the new system

with $\widetilde{H}$ as in (1.4), and
$\widetilde{F}_{t}(x, m)=F\left(x+\sqrt{2 \beta} W_{t},\left(i d+\sqrt{2 \beta} W_{t}\right) \sharp m\right)$ and $\widetilde{G}(x)=G\left(x-\sqrt{2 \beta} W_{T},\left(i d+\sqrt{2 \beta} W_{T}\right) \sharp m_{T}\right)$.
This transformation was used in [10] to prove the existence of a strong solution of the stochastic MFG system with common and idiosyncratic noises, in which case (1.6) is non degenerate and has a "smooth" solution.
Coming back to the degenerate system (1.6), the problem is to find a solution $\left(\widetilde{u}_{t}, \widetilde{M}_{t}, \widetilde{m}_{t}\right)_{t \in[0, T]}$ which is adapted to the filtration $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$ generated by $W$ and $\widetilde{M}=$ $\widetilde{M}_{t}(x)$ is a $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$ martingale. By a solution, we mean that $\widetilde{u}$ is space-time continuous and semiconcave in space, while the martingale $\widetilde{M}$ is bounded, the HJ equation, once integrated in time, is satisfied $\mathbb{P}$-a.s. and a.e., and the random measure $\widetilde{m}$ has globally bounded density satisfying the continuity equation in the sense of distribution $\mathbb{P}$-a.s..
Our main result, Theorem 3.3, is that, under suitable structure and regularity assumptions on the data and assuming that $\underset{F}{ }$ and $G$ are strongly monotone in the Lasry-Lions sense, (1.6) has a unique solution ( $\widetilde{u}, \widetilde{M}, \widetilde{m})$. This is the first existence and uniqueness result of a strong solution for MFG problems with a common and without idiosyncratic noise with value function that is neither smooth nor convex in space in contrast with [10, 15].
The final result concerning MFG is Proposition 3.9. It asserts that it is possible to use the solution of the stochastic MFG system (1.1) to derive approximate Nash equilibria in $N$-player differential games with a common noise. Such a statement is standard in the MFG literature. The first results in this direction go back to Huang, Caines and Malhamé [22], [23] for linear and nonlinear dynamics respectively. In both these references, the dynamics and payoff depend on the empirical measure through an average. Hence, the Central Limit Theorem implies that the error term is of order $N^{-1 / 2}$. The result for a genuinely non linear version of MFG problems without common noise was obtained by Carmona and Delarue [12]; see also [13], Section 6 in Vol. II. Since then, there have been many variations and extensions, and we we refer to [13] and the references therein. As far as we know, Proposition 3.9 is the first result for MFG problems with common and without idiosyncratic noises. The main reason for proving it is that it justifies the (somewhat formal) change of variables made
to pass from the original MFG system (1.1) to the transformed one (1.6). Indeed, we use (1.6) to solve a problem which should actually involve the solution of (1.1).

In contrast with the analysis of the MFG system, to find the approximate Nash equilibria we need to consider a special class the Hamiltonian $\widetilde{H}$. Indeed, we assume that, for some smooth and strictly positive coefficient $\widetilde{a}$ and a smooth and bounded vector field $\widetilde{b}, \widetilde{H}$ is of the form

We suspect that (1.7) may not be necessary. The reason we have to require it is to obtain the uniqueness, for fixed $\omega$ and given the bounded variation vector field $-D_{p} H\left(D \widetilde{u}_{t}(x), x\right)$, of the solution of the continuity equation in (1.6).
The uniqueness of solutions of linear transport and continuity equations under weak assumptions on the vector field is a very intriguing problem. Its study goes back to DiPerna and Lions [16] and Ambrosio [2]. These results cannot be applied to the case at hand, since they require regularity which is not satisfied by $-D_{p} H\left(D \widetilde{u}_{t}(x), x\right)$. Instead, here we rely on a result of Bouchut, James and Mancini [8] which requires a half-Lipschitz condition on the vector field. To use it, however, here we need to assume (1.7).

Organization of the paper. The paper is organized in two parts. In the first, we study the backward HJ SPDE (1.2). We state the assumptions in subsection 2.1, show the existence of a solution in subsection 2.2, prove its uniqueness by a comparison principle in subsection 2.3, propose an optimal control representation and discuss a maximum principle in subsection 2.4. In order to prove the existence of optimal solutions in subsection 2.6, we first discuss in subsection 2.5 the continuity equation associated for the optimal drift. The second part is devoted to the stochastic MFG system (1.1). We state the assumptions in subsection 3.1, and the main existence and uniqueness result in subsection 3.2. In subsection 3.3 we recall the case without noise, for which we provide sharp estimates. We then construct approximate solutions of the stochastic MFG system in subsection 3.4 and, finally, pass to the limit to prove the main result in subsection 3.5. In subsection 3.6 we show the existence of the approximate Nash equilibria for the $N$-player game. Finally, in the appendix we revisit the result of [8] on the uniqueness of the solution to some continuity equations.

Notation. Throughout the paper $\mathcal{O}$ is an open subset of $\mathbb{R}^{d}$, and $C^{2}(\mathcal{O})$ is the space of $C^{2}$-maps on $\mathcal{O}$ with bounded derivatives endowed with the sup-norm

depending on the context, we often omit the subscript $L^{\infty}(\mathcal{O})$ and simply write $\|\cdot\|_{\infty}$. We work on a complete filtered probability space $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{t \geq 0}, \mathbb{P}\right)$ carrying an d-dimensional Wiener process $W=\left(W_{t}\right)_{t \in[0, T]}$ such that $\left(\mathcal{F}_{t}\right)_{t \geq 0}$ is the natural filtration generated by $W$ augmented by all the $\mathbb{P}$-null sets in $\mathcal{F}$. We denote by $\mathcal{P}$ the $\sigma$-algebra of the predictable sets on $\Omega \times[0, T]$ associated with $\left(\mathcal{F}_{t}\right)_{t \geq 0}$. Given a complete metric space $E$ and $p \geq 1$, $\mathcal{S}^{p}(E)$ is the space of continuous, $E$-valued, $\mathcal{P}$-measurable processes $X=\left(X_{t}\right)_{t \geq 0}$ such that, for some $x_{0} \in E$ and, therefore, any point in $E$,

We write $L^{\infty}\left(\left(\Omega \times \mathcal{F}_{T}\right) ; C^{2}\left(\mathbb{R}^{d}\right)\right)$ for the the space of bounded $C^{2}\left(\mathbb{R}^{d}\right)$-valued and $\mathcal{F}_{T}$ maps on $\Omega$. Finally, $\nu_{y}$ denotes the external normal vector to a ball $B_{r}$ at $y \in \partial B_{r}$.

Some assumptions and terminology. To ease the presentation and avoid repetitions in the rest of the paper, we summarize here some of the terminology we use and the assumptions make.

\sup _{m \in \mathcal{P}_{1}\left(\mathbb{R}^{d}\right), t \in[0, T]}\left[\|\mathcal{G}(\cdot, m)\|_{\infty}+\|D \mathcal{G}(\cdot, m)\|_{\infty}+\left\|D^{2} \mathcal{G}(\cdot, m)\right\|_{\infty}\right] \leq C_{0},
\end{array}\right.
$$

## 2. The stochastic backward Hamilton-Jacobi equation

Following the discussion in the introduction, here we study the $\operatorname{HJ} \operatorname{SPDE}(1.3)$ with $\widetilde{H}_{t}$ and $\widetilde{G}$ given by (1.4) and $\widetilde{M}$ an unknown martingale.
2.1. Assumptions and the notion of solution. We introduce the main assumptions about the continuity of $\widetilde{H}$ and $\widetilde{G}$, the convexity and coercivity in the gradient and the higher regularity in the space and gradient variables of $\widetilde{H}((\mathrm{H} 1)$ and (H2)), and the continuity in time of $\widetilde{H}(\mathrm{H} 3)$. To simplify the notation, when possible, we omit the explicit dependence on $\omega$.
We assume that

\widetilde{G} \in L^{\infty}\left(\Omega, \mathcal{F}_{T}, C^{2}\left(\mathbb{R}^{d}\right)\right) \quad \text { and } \quad \widetilde{H} \in \mathcal{S}^{r}\left(C_{l o c}^{2}\left(\mathbb{R}^{d} \times \mathbb{R}^{d}\right)\right) \quad \text { for all } r \geq 1 \tag{H1}
\end{equation*}
$$

and

$$
\begin{equation*}
\widetilde{H}_{t} \text { satisfies (1.10) uniformly in } t \in[0, T] \text { and in } \omega \in \Omega \text {. } \tag{H2}
\end{equation*}
$$

To quantify the continuity of $\widetilde{H}$ in time, we define, for $R>0$,

The notion of solution of (1.3) is introduced next.
Definition 2.1. The couple ( $\widetilde{u}, \widetilde{M}): \mathbb{R}^{d} \times[0, T] \times \Omega \rightarrow \mathbb{R}^{2}$ is a solution of (1.3) if the following conditions hold:
(i) $\widetilde{u} \in \mathcal{S}^{r}\left(W_{\text {loc }}^{1,1}\left(\mathbb{R}^{d}\right)\right)$ and $\widetilde{M} \in \mathcal{S}^{r}\left(L_{\text {loc }}^{1}\left(\mathbb{R}^{d}\right)\right)$ for all $r \geq 1$,
(ii) there exists $C>0$ such that, $\mathbb{P}$-a.s., for a.e. $t \in[0, T]$ and all $z \in \mathbb{R}^{d}$ such that $|z| \leq 1$ and in the sense of distributions,

(iii) for a.e. $x \in \mathbb{R}^{d}$, the process $\left(\widetilde{M}_{t}(x)\right)_{t \in[0, T]}$ is a continuous martingale, and
(iv) for a.e. $(x, t) \in \mathbb{R}^{d} \times[0, T]$ and $\mathbb{P}$-a.s.,

Remark 2.2. As it is often the case in the literature, the martingale $\widetilde{M}_{t}(x)$ can be written as a stochastic integral of an adapted process $\widetilde{Z}_{t}(x)$.
2.2. Existence of a solution. We prove that (1.3) has a solution as in Definition 2.1.

Theorem 2.3. Assume (H1), (H2) and (H3). Then there exists a solution of (1.3).
Proof. The solution is obtained as the limit of solutions of a sequence of approximate problems which we introduce next.
For each $N \in \mathbb{N}$, we consider the partition of $\left(t_{n}^{N}\right)_{n \in\{0, \ldots, N\}}$ of $(0, T)$ with $t_{n}^{N}=T n / N$, set

denote by $\left(\mathcal{F}_{t}^{N}\right)_{t \in[0, T]}$ the piecewise constant filtration given by

\mathcal{F}_{t}^{N}=\mathcal{F}_{t_{n}^{N}} \quad \text { if } t \in\left[t_{n}^{N}, t_{n+1}^{N}\right)
$$

define using backward induction the càdlàg in time processes $\widetilde{u}^{N}=\widetilde{u}_{t}^{N}(x)$ and $\Delta M^{N}=$ $\Delta M_{t_{n}}^{N}(x)$ by $\widetilde{u}_{T}^{N}=\widetilde{G}$ in $\mathbb{R}^{d}$, and, for $n=0, \ldots, N-1$,

-\partial_{t} \widetilde{u}_{t}^{N}+\widetilde{H}_{t}^{N}\left(D \widetilde{u}_{t}^{N}, x\right)=0 \text { in } \mathbb{R}^{d} \times\left(t_{n}^{N}, t_{n+1}^{N}\right),
$$

and, for $x \in \mathbb{R}^{d}$,

u_{t_{n+1}^{N,-}}^{N}(x)=\mathbb{E}\left[\widetilde{u}_{t_{n+1}^{N,+}}^{N}(x) \mid \mathcal{F}_{t_{n}}\right] \text { and } \Delta \widetilde{M}_{t_{n+1}^{N,-}}^{N}(x)=u_{t_{n+1}^{N,+}}^{N}(x)-\mathbb{E}\left[u_{t_{n+1}^{N,+}}^{N}(x) \mid \mathcal{F}_{t_{n}^{N}}\right],
$$

and, finally, set

\widetilde{M}_{t}^{N}(x)=\sum_{t_{n} \leq t} \Delta \widetilde{M}_{t_{n}}^{N}(x) .
$$

Using our assumptions, we have the following lemma. Its proof is presented after the end of the ongoing one.

Lemma 2.4. Assume (H1), (H2), and (H3). There exists a $C>0$ such that, $\mathbb{P}-a . s .$, a.e. $t \in[0, T]$ and for all $z \in \mathbb{R}^{d}$ with $|z| \leq 1$, and in the sense of distributions,

Moreover, for any $x \in \mathbb{R}^{d}$, the process $\left(\widetilde{u}_{t}^{N}(x)\right)_{t \in[0, T]}$ is adapted to the filtration $\left(\mathcal{F}_{t}^{N}\right)_{t \in[0, T]}$ and $\left(\widetilde{M}_{t_{n}}^{N}(x)\right)_{t \in[0, T]}$ is a martingale with respect to the discrete filtration $\left(\mathcal{F}_{t_{n}}\right)_{n=0, \ldots, N}$.
It is immediate from the definition of the filtration $\left(\mathcal{F}_{t}^{N}\right)_{t \in[0, T]}$ that $\left(\widetilde{u}_{t}^{N}(x)\right)_{t \in[0, T]}$ is also adapted to $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$.
Continuing with the ongoing proof we note that $\left(\widetilde{u}_{t}^{N}, \widetilde{M}_{t}^{N}\right)_{t \in[0, T]}$ solves the backward equation

d \widetilde{u}_{t}^{N}=\widetilde{H}_{t}^{N}\left(D \widetilde{u}_{t}^{N}, x\right) d t+d \widetilde{M}_{t}^{N} \quad \text { in } \mathbb{R}^{d} \times(0, T) \quad \widetilde{u}_{T}^{N}=\widetilde{G} \text { in } \mathbb{R}^{d}, \tag{2.3}
\end{equation*}
$$

in the sense that, $\mathbb{P}-$ a.s. and for a.e. $(x, t) \in \mathbb{R}^{d} \times[0, T]$,

\widetilde{u}_{t}^{N}(x)=\widetilde{G}(x)-\int_{t}^{T} \widetilde{H}_{s}^{N}\left(D \widetilde{u}_{s}^{N}(x), x\right) d s-\widetilde{M}_{T}^{N}(x)+\widetilde{M}_{t}^{N}(x) .
$$

We show next that $\left(\widetilde{u}_{t}^{N}, \widetilde{M}_{t}^{N}\right)_{t \in[0, T]}$ is Cauchy sequence in a suitable space, and for this we follow Douglis' [17] uniqueness proof (see also [18]).
Fix $0<N<K$, let $\phi: \mathbb{R} \rightarrow[0, \infty)$ be a smooth, Lipschitz continuous, convex and nonincreasing map, and set

Using induction and the convexity of $\phi$ to cancel the jump terms, which are martingales, we find that, for any $t \in[0, T)$ and $h \in(0, T-h)$,

&=\mathbb{E}\left[\int_{t}^{t+h}\left(\mathbf{b}_{s}(x) \cdot D w_{s}(x)+\zeta_{s}(x)\right) d s\right]
\end{align*}\right.
$$

where

\zeta_{s}(x)=\phi^{\prime}\left(\widetilde{u}_{s}^{N}(x)-\widetilde{u}_{s}^{K}(x)\right)\left(\widetilde{H}_{s}^{N}\left(D \widetilde{u}_{s}^{K}(x), x\right)-\widetilde{H}_{s}^{K}\left(D \widetilde{u}_{s}^{K}(x), x\right)\right),
$$

and

$$
\mathbf{b}_{s}(x)=\int_{0}^{1} D_{p} \widetilde{H}_{s}^{N}\left((1-\lambda) D \widetilde{u}_{s}^{N}(x)+\lambda D \widetilde{u}_{s}^{K}(x), x\right) d \lambda
$$

Let $\mathbf{b}^{\varepsilon}$ be a regularization of $b$ to be specified below. Then (2.4) can be rearranged to read

\mathbb{E}\left[w_{t+h}(x)-w_{t}(x)\right] \geq \mathbb{E}\left[\int_{t}^{t+h} \operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon} w_{s}\right)-\operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon}\right) w_{s}+\left(\mathbf{b}_{s}-\mathbf{b}_{s}^{\varepsilon}\right) \cdot D w_{s}+\zeta_{s} d s\right] \tag{2.5}
\end{equation*}
$$

For $\alpha, \beta>0$ to be chosen, we consider the quantity

and claim that

& \quad+\mathbb{E}\left[\int_{t}^{T} \int_{B_{\alpha+\beta s}} \operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon} w_{s}\right)-\operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon}\right) w_{s}+\left(\mathbf{b}_{s}-\mathbf{b}_{s}^{\varepsilon}\right) \cdot D w_{s}+\zeta_{s} d x d s\right]
\end{align*}\right.
$$

Indeed, let $k$ be a large integer and set $\theta_{r}^{k}=t+\frac{r}{k}(T-t)$ for $r \in\{0, \ldots, k\}$. Integrating (2.5) over $B_{\alpha+\beta \theta_{r}^{k}}$ with $t=\theta_{r}^{k}$ and $h=1 / k$ and summing over $r$ we obtain

& \geq \mathbb{E}\left[\sum_{r=0}^{k-1} \int_{\theta_{r}^{k}}^{\theta_{r+1}^{k}} \int_{B_{\alpha+\beta \theta_{r}^{k}}}\left(\operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon} w_{s}\right)-\operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon}\right) w_{s}+\left(\mathbf{b}_{s}-\mathbf{b}_{s}^{\varepsilon}\right) \cdot D w_{s}+\zeta_{s}\right) d y d s\right],
\end{aligned}
$$

and, after letting $k \rightarrow+\infty$, (2.6).
Next, rearranging (2.6) we find, for all $t \in(0, T)$.

e_{t} \leq & \mathbb{E}\left[-\left(\int_{t}^{T} \int_{B_{\alpha+\beta s}}\left(\operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon} w_{s}\right)-\operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon}\right) w_{s}+\left(\mathbf{b}_{s}-\mathbf{b}_{s}^{\varepsilon}\right) \cdot D w_{s}+\zeta_{s}\right) d y d s\right.\right. \\
& \left.\quad-\beta \int_{t}^{T} \int_{\partial B_{\alpha+\beta s}} w_{s} d x d s\right]+e_{T}
\end{aligned}\right.
$$

and, after integrating by parts,

$$
\left\{\begin{align*}
e_{t} \leq & \mathbb{E}\left[-\int_{t}^{T} \int_{B_{\alpha+\beta s}}\left(-\operatorname{div}\left(\mathbf{b}_{s}^{\varepsilon}\right) w_{s}+\left(\mathbf{b}_{s}-\mathbf{b}_{s}^{\varepsilon}\right) \cdot D w_{s}+\zeta_{s}\right) d y d s\right.  \tag{2.7}\\
& \left.-\int_{t}^{T} \int_{\partial B_{\alpha+\beta s}}\left(\mathbf{b}_{s}^{\varepsilon} \cdot \nu_{y}+\beta\right) w_{s} d y d s\right]+e_{T} .
\end{align*}\right.
$$

We return now to the choice of $\mathbf{b}^{\varepsilon}$. For this, let $\widetilde{u}^{N, \varepsilon}=\widetilde{u}^{N} * \xi^{\varepsilon}$ and $\widetilde{u}^{K, \varepsilon}=\widetilde{u}^{K} * \xi^{\varepsilon}$ be space-time regularizations of $\widetilde{u}^{N}$ and $\widetilde{u}^{K}$ with a smooth compactly supported kernel $\xi^{\varepsilon}$.
Then, for all $(x, t) \in \mathbb{R}^{d} \times(0, T), z \in \mathbb{R}^{d}$ such that $|z| \leq 1$ and in the sense of distributions,

\left|\widetilde{u}^{N, \varepsilon}(x, t)\right| \leq\left\|\widetilde{u}^{N}\right\|_{\infty}, \quad\left|\widetilde{u}^{K, \varepsilon}(x, t)\right| \leq\left\|\widetilde{u}^{K}\right\|_{\infty}  \tag{2.8}\\
\left|D \widetilde{u}^{N, \varepsilon}(x, t)\right| \leq\left\|D \widetilde{u}^{N}\right\|_{\infty}, \quad\left|D \widetilde{u}^{K, \varepsilon}(x, t)\right| \leq\left\|D \widetilde{u}^{K}\right\|_{\infty}, \\
D^{2} \widetilde{u}^{N, \varepsilon}(x, t) z \cdot z \leq C, \quad D^{2} \widetilde{u}^{K, \varepsilon}(x, t) z \cdot z \leq C
\end{array}\right.
$$

and, as $\varepsilon \rightarrow 0$ and for a.e. $(x, t)$,

$$
\begin{equation*}
D \widetilde{u}^{N, \varepsilon}(x, t) \rightarrow D u^{N}(x, t) \text { and } D \widetilde{u}^{K, \varepsilon}(x, t) \rightarrow D u^{K}(x, t) . \tag{2.9}
\end{equation*}
$$

Let

\mathbf{b}_{s}^{\varepsilon}(x)=\int_{0}^{1} D_{p} \widetilde{H}_{s}^{N}\left((1-\lambda) D \widetilde{u}_{s}^{N, \varepsilon}(x)+\lambda D \widetilde{u}_{s}^{K, \varepsilon}(x), x\right) d \lambda .
$$

It is immediate from the properties of $\widetilde{H},(2.8)$ and Lemma 2.4 that there exists $C_{1}>0$ such that, for all $(x, t)$ and $\mathbb{P}$-a.s. in $\omega$,

\left|\mathbf{b}_{s}^{\varepsilon}(x)\right| \leq \sup _{|p| \leq C, y \in \mathbb{R}^{d}, \omega \in \Omega}\left|D_{p} \widetilde{H}_{s}^{N}(p, y, \omega)\right| \leq C_{1}, \tag{2.10}
\end{equation*}
$$

where $C$ is the upper bound on $\left\|D \widetilde{u}^{N}\right\|_{\infty}$ and $\left\|D \widetilde{u}^{K}\right\|_{\infty}$ in Lemma 2.4.
Furthermore, as $\varepsilon \rightarrow 0$ and $\mathbb{P}$-a.s., $\mathbf{b}^{\varepsilon} \rightarrow \mathbf{b}$ for a.e. $(x, t)$ and in any $L_{l o c}^{p}$.
Finally, since

\operatorname{div}\left(\mathbf{b}_{t}^{\varepsilon}(x)\right) & =\int_{0}^{1} \operatorname{Tr}\left(D_{p p}^{2} \widetilde{H}_{t}^{N}\left((1-\lambda) D \widetilde{u}^{N, \varepsilon}+\lambda D \widetilde{u}^{K, \varepsilon}, x\right)\left((1-\lambda) D^{2} \widetilde{u}^{N, \varepsilon}+\lambda D^{2} \widetilde{u}^{K, \varepsilon}\right)\right) d \lambda \\
& +\int_{0}^{1} \operatorname{Tr}\left(D_{p x}^{2} \widetilde{H}_{t}^{N}\left((1-\lambda) D \widetilde{u}^{N, \varepsilon}+\lambda D \widetilde{u}^{K, \varepsilon}, x\right)\right) d \lambda,
\end{aligned}
$$

it follows from the convexity of $\widetilde{H},(\mathrm{H} 2)$ with $R=C$ from Lemma 2.4, and (2.8) that there exists $\widetilde{C}>0$ such that

We choose $\beta=C_{1}$ in (2.7). Recalling that $w \geq 0$, we find, for some other $C>0$,

& \leq C \int_{t}^{T} e_{s} d s+\mathbb{E}\left[\int_{t}^{T} \int_{B_{\alpha+\beta s}}\left(-\left(\mathbf{b}_{s}-\mathbf{b}_{s}^{\varepsilon}\right) \cdot D w_{t}-\zeta_{s}\right) d y d s\right]+e_{T}
\end{aligned}
$$

Using Gronwall's inequality and letting $\varepsilon \rightarrow 0$, we get

Next we note that, since, in view of Lemma 2.4, $\left\|D u^{N}\right\| \leq C$, if $\omega_{C}^{N}$ is as in (2.1), we have

Therefore, it follows from (2.11) and the above that, for all $t \in[0, T]$,

Since $\alpha$ is arbitrary and the $\widetilde{u}^{N}$ 's are uniformly bounded and uniformly Lipschitz continuous in space, the inequality

\|u\|_{L^{\infty}\left(B_{R}\right)} \leq C_{R}\|D u\|_{L^{\infty}\left(B_{R}\right)}^{d /(d+1)}\|u\|_{L^{1}\left(B_{R}\right)}^{1 /(d+1)}
$$

yields that, for all $R>0$,

$$
\sup _{t \in[0, T]} \mathbb{E}\left[\left\|\widetilde{u}_{t}^{N}-\widetilde{u}_{t}^{K}\right\|_{L^{\infty}\left(B_{R}\right)}^{d+1}\right] \leq C_{R} \mathbb{E}\left[\omega_{C}^{N}\right] .
$$

In view of (H3), it follows that $\left(\widetilde{u}^{N}\right)_{N \in \mathbb{N}}$ is a Cauchy sequence for the family of seminorms

$$
\left(\sup _{t \in[0, T]} \mathbb{E} l\left[\left\|\widetilde{u}_{t}\right\|_{L^{\infty}\left(B_{R}\right)}^{d+1}\right]\right)_{R>0}
$$

Thus, there is a subsequence, which we denote in the same way as the full sequence, along which the $\widetilde{u}^{N}$, s converge, in the seminorms above and for every $R>0$, to a limit $\widetilde{u}$, which, in view of the uniform estimates in Lemma 2.4, is Lipschitz continuous and semiconcave in $x$. Moreover, the process $\left(\widetilde{u}_{t}(x)\right)_{t \in[0, T]}$ is adapted to the filtration $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$. Finally, up to a further subsequence, we can assume that $\widetilde{u}^{N}$ converge to $\widetilde{u}$ locally uniformly in $x$, $\mathbb{P}-$ a.s. and a.e. $t \in[0, T]$. In view of the uniform semiconcavity, the last observation implies that, as $N \rightarrow \infty$ and $\mathbb{P}$-a.s. and for a.e. $(x, t) \in \mathbb{R}^{d} \times[0, T], D \widetilde{u}_{t}^{N}(x) \rightarrow D \widetilde{u}_{t}(x)$.
Let $\omega \in \Omega$ and $t \in[0, T]$ be such that, as $N \rightarrow \infty, \widetilde{u}_{t}^{N}(\cdot, \omega)$ converges locally uniformly to $\widetilde{u}_{t}(\cdot, \omega)$. Integrating (2.3) over $[t, T]$, we then find, using Fubini's theorem, that, for a.e. $x \in \mathbb{R}^{d}$,

Since $D \widetilde{u}^{N}$ converges a.e. to $D \widetilde{u}$ on $\mathbb{R}^{d} \times(0, T)$ and is bounded, we can pass in the $N \rightarrow \infty$ limit in the equality above to get, for a.e. $x \in \mathbb{R}^{d}$,

\lim _{N \rightarrow+\infty} \widetilde{M}_{t}^{N}(x)=\widetilde{u}_{t}(x)-\widetilde{G}(x)+\int_{t}^{T} \widetilde{H}_{s}^{N}\left(D \widetilde{u}_{s}^{N}(x), x\right) d s \tag{2.12}
\end{equation*}
$$

Hence, the $\widetilde{M}^{N}$,s converge $\mathbb{P}$-a.s. and for a.e. $x \in \mathbb{R}^{d}$ to some bounded process denoted by $\widetilde{M}$ and we have, for a.e. $x \in \mathbb{R}^{d}$,

\widetilde{M}_{t}(x)=\widetilde{u}_{t}(x)-\widetilde{G}(x)+\int_{t}^{T} \widetilde{H}_{s}^{N}\left(D \widetilde{u}_{s}^{N}(x), x\right) d s
$$

Since $\left(\widetilde{M}_{t_{n}}^{N}(x)\right)_{t \in[0, T]}$ is a martingale in the filtration $\left(\mathcal{F}_{t_{n}}\right)_{n=0, \ldots, N}$, it follows that $\left(\widetilde{M}_{t}(x)\right)_{t \in[0, T]}$ is, for a.e. $x \in \mathbb{R}^{d}$, a martingale in the filtration $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$. In particular, for a.e. $x \in \mathbb{R}^{d}$, $t \rightarrow \widetilde{M}_{t}(x)$ is continuous, which shows that $t \rightarrow \widetilde{u}_{t}(x)$ is continuous as well. Therefore $(\widetilde{u}, \widetilde{M})$ is a solution to (1.3).

We conclude this subsection with the proof of Lemma 2.4.

Proof of Lemma 2.4. Since the estimates are standard, here we explain only the formal ideas. As usual the computations can be justified by vanishing viscosity-type arguments.
The uniform $L^{\infty}$-bound follows by backward induction of a straightforward application of the comparison principle, which implies that, for any $n \in\{0, \ldots, N-1\}$,

where the last inequality holds because the conditional expectation is a contraction in the $L^{\infty}$-norm.

For the semiconcavity estimate, we note that, if $v$ is a viscosity solution of the HamiltonJacobi equation

with $H$ satisfying (1.10), then there exist $c_{0}, c_{1}>0$ such that, for any $|z| \leq 1$ and in the sense of distributions,

\text { if } D^{2} v_{T} z \cdot z-\lambda v_{T} \leq c_{1} \text {, then } D^{2} v_{t} z \cdot z-\lambda v_{t} \leq c_{1}+c_{0} T \tag{2.13}
\end{equation*}

Indeed, for any $z \in \mathbb{R}^{d}$ with $|z| \leq 1$, the map $w_{t}(x)=D^{2} v_{t}(x) z \cdot z-\lambda v_{t}(x)$ satisfies (formally)

\begin{aligned}
& -\partial_{t} w_{t}+D_{p} H_{t}\left(D v_{t}, x\right) \cdot D w_{t}+D_{p p}^{2} H_{t}\left(D v_{t}, x\right) D v_{t, z} \cdot D v_{t, z}+2 D_{p z}^{2} H_{t}\left(D v_{t}, x\right) \cdot D v_{t, z} \\
& \quad+D_{z z}^{2} H_{t}\left(D v_{t}, x\right)-\lambda\left(H_{t}\left(D v_{t}, x\right)-D_{p} H_{t}\left(D v_{t}, x\right) \cdot D v_{t}\right)=0
\end{aligned}
$$

and, hence, in view of given (1.10), (2.13) follows from the comparison principle.
Applying (2.13) to $\widetilde{u}^{N}$ provides the uniform semiconcavity estimate by a backward induction argument similar to the one for the $L^{\infty}$-bound. The bounds above immediately imply the Lipschitz estimate of $D \widetilde{u}^{N}$.
Recall that, for each $x \in \mathbb{R}^{d},\left(\widetilde{u}^{N}(x)\right)_{t \in[0, T]}$ is adapted to the filtration $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$ and $\left(\widetilde{M}_{t}^{N}(x)\right)_{t \in[0, T]}$ is a càdlàg martingale with respect to the discrete filtration $\left(\mathcal{F}_{t_{n}}\right)$.
The bound on $\widetilde{M}^{N}$ follows from the observation that, since $\widetilde{M}_{T}=0$, by induction we have, for $x \in \mathbb{R}^{d}$ and $\mathbb{P}$-a.s.,

2.3. Comparison and uniqueness. We say that ( $\widetilde{u}^{1}, \widetilde{M}^{1}$ ) (resp. ( $\left.\widetilde{u}^{2}, \widetilde{M}^{2}\right)$ ) is a supersolution (resp. subsolution) of (1.3), if $\widetilde{u}^{1}$ (resp. $\widetilde{u}^{2}$ ) satisfies all the conditions of Definition 2.1 but (2.2) which is replaced by the requirement that, $\mathbb{P}$-a.s., and for a.e $\left(x, t, t^{\prime}\right) \in \mathbb{R}^{d} \times[0, T] \times[0, T]$ with $t<t^{\prime}$,

\widetilde{u}_{t}^{1}(x) \geq \widetilde{u}_{t^{\prime}}^{1}(x)-\int_{t}^{t^{\prime}} \widetilde{H}_{s}\left(D \widetilde{u}_{s}^{1}(x), x\right) d s-\widetilde{M}_{t^{\prime}}^{1}(x)+\widetilde{M}_{t}^{1}(x) \text { and } u_{T}^{1} \geq \widetilde{G} \text { in } \mathbb{R}^{d}
$$

(resp.

$$
\left.\widetilde{u}_{t}^{2}(x) \leq \widetilde{u}_{t^{\prime}}^{2}(x)-\int_{t}^{t^{\prime}} \widetilde{H}_{s}\left(D \widetilde{u}_{s}^{2}(x), x\right) d s-\widetilde{M}_{t^{\prime}}^{2}(x)+\widetilde{M}_{t}^{2}(x) \text { and } u_{T}^{2} \leq \widetilde{G} \text { in } \mathbb{R}^{d} .\right)
$$

The comparison result between supersolutions and subsolutions is stated next.

Proposition 2.5 (Comparison). Assume (H1), (H2), (H2) and (H3), and let ( $\widetilde{u}^{1}, \widetilde{M}^{1}$ ) and $\left(\widetilde{u}^{2}, \widetilde{M}^{2}\right)$ be respectively a supersolution and a subsolution of (1.3). Then, $\mathbb{P}-$ a.s., $\widetilde{u}^{1} \geq \widetilde{u}^{2}$ in $\mathbb{R}^{d} \times[0, T]$.
The following uniqueness result follows immediately.
Corollary 2.6 (Uniqueness). Assume (H1), (H2) and (H3). Then there exists a unique solution to (1.3).
Proof of Proposition 2.5. The proof follows again Douglis's uniqueness proof and is very similar with the proof of Theorem 2.3 with $\widetilde{u}^{1}$ and $\widetilde{u}^{2}$ in place of $\widetilde{u}^{N}$ and $\widetilde{u}^{K}$. Hence, in what follows we present a brief sketch.
Fix a smooth, convex and nonincreasing map $\phi: \mathbb{R} \rightarrow \mathbb{R}^{+}$, and let $w_{t}(x)=\phi\left(\widetilde{u}_{t}^{1}(x)-\widetilde{u}_{t}^{2}(x)\right)$. Then by Itô's formula and the inequalities satisfied by the $\widetilde{u}^{i}$ 's, we have

d w_{t}(x) & \geq \phi^{\prime}\left(\widetilde{H}_{t}\left(D \widetilde{u}_{t}^{1}(x), x\right)-\widetilde{H}_{t}\left(D \widetilde{u}_{t}^{2}(x), x\right)\right) d t+\frac{1}{2} \phi^{\prime \prime} d<\widetilde{M}(x)>_{t}+\phi^{\prime} d \widetilde{M}_{t}(x) \\
& \geq \mathbf{b}_{t}(x) \cdot D w_{t}(x) d t+\phi^{\prime} d \widetilde{M}_{t}(x),
\end{aligned}
$$

where $\phi$ and its derivatives are evaluated at $\widetilde{u}_{t}^{1}(x)-\widetilde{u}_{t}^{2}(x), \widetilde{M}_{t}=\widetilde{M}_{t}^{1}-\widetilde{M}_{t}^{2}$ and

$$
\mathbf{b}_{t}(x)=\int_{0}^{1} D_{p} \widetilde{H}_{t}\left((1-s) D \widetilde{u}_{t}^{1}(x)+s D \widetilde{u}_{t}^{2}(x)\right) d s
$$

The rest of the proof follows almost verbatim the arguments of the proof of Theorem 2.3. It consists of an appropriate regularization $\mathbf{b}^{\varepsilon}$ similar to the one in the aforementioned proof and a rewriting of the inequality satisfied by $w_{t}$ as

$$
d w_{t}(x) \geq\left(\operatorname{div}\left(\mathbf{b}_{t}^{\varepsilon}(x) w_{t}\right)-\operatorname{div}\left(\mathbf{b}_{t}^{\varepsilon}(x)\right) w_{t}+\left(\mathbf{b}_{t}-\mathbf{b}_{t}^{\varepsilon}\right) \cdot D w_{t}\right) d t+\phi^{\prime} d \widetilde{M}_{t} .
$$

Next we consider the quantity

$$

and we find, as in the proof of Theorem 2.3, for $t_{1} \in[0, T]$,

e_{T}-e_{t_{1}} \geq \mathbb{E} & {\left[\int_{t_{1}}^{T} \int_{B_{\alpha+\beta t}}\left(\operatorname{div}\left(\mathbf{b}_{t}^{\varepsilon}(x) w_{t}\right)-\operatorname{div}\left(\mathbf{b}_{t}^{\varepsilon}(x)\right) w_{t}+\left(\mathbf{b}_{t}-\mathbf{b}_{t}^{\varepsilon}\right) \cdot D w_{t}\right) d y d t\right.} \\
& \left.+\beta \int_{t_{1}}^{T} \int_{\partial B_{\alpha+\beta t}} w_{t}(y) d y d t\right] \\
=\mathbb{E} & {\left[\int_{t_{1}}^{T} \int_{\partial B_{\alpha+\beta t}}\left(\mathbf{b}_{t}^{\varepsilon}(x) \cdot \nu_{y}+\beta\right) w_{t} d y d t\right.} \\
& \left.+\int_{t_{1}}^{T} \int_{B_{\alpha+\beta t}}\left(-\operatorname{div}\left(\mathbf{b}_{t}^{\varepsilon}(x)\right) w_{t}+\left(\mathbf{b}_{t}-\mathbf{b}_{t}^{\varepsilon}\right) \cdot D w_{t}\right) d y d t\right] .
\end{aligned}
$$

The properties of $\mathbf{b}^{\varepsilon}$, a suitable choice of $\beta$ and Grownwall's inequality lead after letting $\varepsilon \rightarrow$ to

e_{t_{1}} \leq e^{C T} e_{T}
$$

We choose (after approximation) $\phi(r)=(-r)_{+}$. Then $e_{T}=0$ since $\widetilde{u}_{T}^{1} \geq \widetilde{u}_{T}^{2}$. Therefore $e_{t}=0$ for any $t$, which shows that $\widetilde{u}^{1} \geq \widetilde{u}^{2}$ since $\alpha$ is arbitrary.
2.4. Optimal control representation. We develop a stochastic optimal control formulation for $\widetilde{u}$ and present a stochastic maximum principle-type result.
In what follows, $\widetilde{L}$ is the Legendre transform of $\widetilde{H}$, that is, for $x, \alpha \in \mathbb{R}^{d}, t \in[0, T]$ and $\omega \in \Omega$,

\widetilde{L}_{t}(\alpha, x, \omega)=\sup _{p \in \mathbb{R}^{d}}\left[-p \cdot \alpha-\widetilde{H}_{t}(p, x, \omega)\right] .
$$

Moreover, for $x \in \mathbb{R}^{d}$ and $t \in[0, T], \mathcal{A}_{t, x}$ is the set of admissible paths defined by

\mathcal{A}_{t, x}=\left\{\gamma \in \mathcal{S}^{2}\left(\mathbb{R}^{d}\right): \gamma_{t}=x \text { and } \gamma \in H^{1}\left([t, T] ; \mathbb{R}^{d}\right) \text { a.s. }\right\} .
$$

Proposition 2.7. Assume (H1), (H2), (H2) and (H3), and let $\widetilde{u}$ be the solution of (1.3). Then

$$
\begin{equation*}
\widetilde{u}_{t}(x)=\underset{\gamma \in \mathcal{A}_{t, x}}{\operatorname{essinf}} \mathbb{E}\left[\int_{t}^{T} \widetilde{L}_{s}\left(\dot{\gamma}_{s}, \gamma_{s}\right) d s+\widetilde{G}\left(\gamma_{T}\right) \mid \mathcal{F}_{t}\right] . \tag{2.14}
\end{equation*}
$$

Proof. To simplify the notation, we present the proof for $t=0$. Let $\left(\widetilde{u}^{N}\right)_{N \geq 1}$ be as in the proof of Theorem 2.3. Since on each time interval $\left(t_{n}^{N}, t_{n+1}^{N}\right), \widetilde{u}^{N}$ is a viscosity solution of a standard HJ equation, for any fixed $\omega$ and $\widetilde{L}^{N}$ the Legendre transform of $\widetilde{H}^{N}$, we have

\widetilde{u}_{t_{n}^{N}}^{N}(x)=\inf _{\gamma \in \widetilde{\mathcal{A}}_{t_{n}^{N}, t_{n+1}^{N}, x}} \int_{t_{n}^{N}}^{t_{n+1}^{N}} \widetilde{L}_{s}^{N}\left(\dot{\gamma}_{s}, \gamma_{s}\right) d s+\widetilde{u}_{t_{n+1}^{N,-}}^{N}\left(\gamma_{t_{n+1}^{N}}\right)
$$

where

$$
\widetilde{\mathcal{A}}_{t, s, x}=\left\{\gamma \in H^{1}\left([t, s] ; \mathbb{R}^{d}\right): \gamma_{t}=x\right\}
$$

The $\mathcal{F}_{t_{n}^{N}}$-measurability of $\widetilde{u}_{t_{n+1}^{-}}^{N}$ allows to find a $\mathcal{F}_{t_{n}}$-measurable selection $(\omega, x) \rightarrow\left(\widetilde{\gamma}_{t}^{N}(\omega, x)\right)_{t \in\left[t_{n}^{N}, t_{n+1}^{N}\right]}$ of minimizers. Note that, since $D \widetilde{u}^{N}$ is uniformly bounded, $\dot{\tilde{\gamma}}^{N}$ is uniformly bounded as well by some constant $C$.
Concatenating these minimizers, we find, for any $x \in \mathbb{R}^{d}$, a $\left(\mathcal{F}_{t_{n}^{N}}\right)_{n=0, \ldots, N}$-adapted path $\widetilde{\gamma}^{N} \in \mathcal{A}_{0, x}$ such that

\widetilde{u}_{0}^{N}(x)=\mathbb{E}\left[\int_{0}^{T} \widetilde{L}_{s}^{N}\left(\dot{\widetilde{\gamma}}_{s}^{N}, \widetilde{\gamma}_{s}^{N}\right) d s+\widetilde{G}\left(\widetilde{\gamma}_{T}^{N}\right)\right]=\inf _{\gamma \in \mathcal{A}_{0, x}} \mathbb{E}\left[\int_{0}^{T} \widetilde{L}_{s}^{N}\left(\dot{\gamma}_{s}, \gamma_{s}\right) d s+\widetilde{G}\left(\gamma_{T}\right)\right],
$$

where the second equality can be proved by dynamic programming and induction.
Then, in view of the continuity of the filtration $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$ and the definition of $\widetilde{L}^{N}$, we find

\widetilde{u}_{0}(x)=\lim _{N \rightarrow \infty} u_{0}^{N}(x) \leq \inf _{\gamma \in \mathcal{A}_{0, x}} \mathbb{E}\left[\int_{0}^{T} \widetilde{L}_{s}\left(\dot{\gamma}_{s}, \gamma_{s}\right) d s+\widetilde{G}\left(\gamma_{T}\right)\right] .
$$

On the other hand, the time regularity of $\widetilde{L}$ and the uniform in $N$ bound on $\dot{\tilde{\gamma}}^{N}$, which we denote by $C$, imply that

\widetilde{u}_{0}^{N}(x) \geq \mathbb{E}\left[\int_{0}^{T} \widetilde{L}_{s}\left(\dot{\tilde{\gamma}}_{s}^{N}, \widetilde{\gamma}_{s}^{N}\right) d s+\widetilde{G}\left(\widetilde{\gamma}_{T}^{N}\right)\right]-\mathbb{E}\left[\omega_{C}^{N}\right] .
$$

It follows that

\widetilde{u}_{0}(x) & =\lim _{N \rightarrow \infty} u_{0}^{N}(x) \geq \limsup _{N \rightarrow \infty}\left[\inf _{\gamma \in \mathcal{A}_{0, x}} \mathbb{E}\left[\int_{0}^{T} \widetilde{L}_{s}\left(\dot{\gamma}_{s}, \gamma_{s}\right) d s+\widetilde{G}\left(\gamma_{T}\right)\right]-\mathbb{E}\left[\omega_{C}^{N}\right]\right] \\
& =\inf _{\gamma \in \mathcal{A}_{0, x}} \mathbb{E}\left[\int_{0}^{T} \widetilde{L}_{s}\left(\dot{\gamma}_{s}, \gamma_{s}\right) d s+\widetilde{G}\left(\gamma_{T}\right)\right]
\end{aligned}
$$

We now discuss the maximum principle and the regularity of the value function along optimal solutions. We point, however, that we do not claim the existence of an optimal solution.

Theorem 2.8 (Maximum principle). Assume (H1), (H2), (H2) and (H3), let $\bar{\gamma} \in \mathcal{A}_{0, x}$ be optimal for $\widetilde{u}_{0}(x)$ and define, for $t \in[0, T]$, the $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}-$ adapted continuous process $\bar{p}$ by

\bar{p}_{t}=\mathbb{E}\left[\int_{t}^{T} D_{x} \widetilde{L}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right) d s+D \widetilde{G}\left(\bar{\gamma}_{T}\right) \mid \mathcal{F}_{t}\right] \tag{2.15}
\end{equation*}
$$

Then, for $t \in[0, T]$,

$$
\begin{equation*}
\dot{\bar{\gamma}}_{t}=-D_{p} \widetilde{H}_{t}\left(\bar{p}_{t}, \bar{\gamma}_{t}\right) \tag{2.16}
\end{equation*}
$$

and $\bar{p}$ solves the $B S D E$

$$
\begin{equation*}
d \bar{p}_{t}=D_{x} \widetilde{H}_{t}\left(\bar{p}_{t}, \bar{\gamma}_{t}\right) d t+d \bar{m}_{t} \quad \text { in } \quad[0, T], \quad \bar{p}_{T}=D \widetilde{G}\left(\bar{\gamma}_{T}\right) \tag{2.17}
\end{equation*}
$$

where $\left(\bar{m}_{t}\right)_{t \in[0, T]} \in \mathcal{S}^{r}(\mathbb{R})$ is a continuous martingale.
Remark 2.9. The theorem implies that $\bar{\gamma}$ is of class $C^{1}$.
Proof. Fix $h>0$ small and $t \in[0, T)$ at which $\bar{\gamma}$ is differentiable $\mathbb{P}$-a.s., and let $v \in$ $L^{\infty}\left(\Omega, \mathbb{R}^{d}\right)$ be $\mathcal{F}_{t}$-measuarable.
Define $\gamma^{h}$ by $\gamma^{h}(0)=x$ and

$\gamma^{h}$ is admissible, and use the dynamic programming principle to get

\mathbb{E}\left[\int_{t}^{T} \widetilde{L}_{s}\left(\dot{\gamma}_{s}^{h}, \gamma_{s}^{h}\right) d s+\widetilde{G}\left(\gamma_{T}^{h}\right) \mid \mathcal{F}_{t}\right] \geq \mathbb{E}\left[\int_{t}^{T} \widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right) d s+\widetilde{G}\left(\bar{\gamma}_{T}\right) \mid \mathcal{F}_{t}\right]
$$

Hence

$$
\begin{aligned}
& \mathbb{E}\left[\int_{t}^{t+h}\left(\widetilde{L}_{s}\left(v, \gamma_{s}^{h}\right)-\widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right)\right) d s\right. \\
& \left.\quad \quad+\int_{t+h}^{T}\left(\widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \gamma_{s}^{h}\right)-\widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right)\right) d s+\widetilde{G}\left(\gamma_{T}^{h}\right)-\widetilde{G}\left(\bar{\gamma}_{T}\right) \mid \mathcal{F}_{t}\right] \geq 0
\end{aligned}
$$

Then

$$
\begin{aligned}
& \mathbb{E}\left[\int_{t}^{t+h}\left(\widetilde{L}_{s}\left(v, \gamma_{s}^{h}\right)-\widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right)\right) d s\right. \\
& \left.+\int_{t+h}^{T}\left(\widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \gamma_{s}^{h}\right)-\widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right)\right) d s+D \widetilde{G}\left(\bar{\gamma}_{T}\right) \cdot\left(\gamma_{T}^{h}-\bar{\gamma}_{T}\right)+C\left|\gamma_{T}^{h}-\bar{\gamma}_{T}\right|^{2} \mid \mathcal{F}_{t}\right] \geq 0
\end{aligned}
$$

Dividing by $h$, letting $h \rightarrow 0^{+}$and using (2.18) we find

\widetilde{L}_{t}\left(v, \bar{\gamma}_{t}\right)-\widetilde{L}_{t}\left(\bar{\gamma}_{t}, \bar{\gamma}_{t}\right)+\left(v-\dot{\bar{\gamma}}_{t}\right) \cdot \mathbb{E}\left[\int_{t}^{T} D_{x} \widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right) d s+D \widetilde{G}\left(\bar{\gamma}_{T}\right) \mid \mathcal{F}_{t}\right] \geq 0
$$

Since $v \in \mathcal{F}_{t}$ is arbitrary, we conclude that, $\mathbb{P}$-a.s.,

D_{\alpha} \widetilde{L}_{t}\left(\bar{\gamma}_{t}, \bar{\gamma}_{t}\right)+\mathbb{E}\left[\int_{t}^{T} D_{x} \widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right) d s+D \widetilde{G}\left(\bar{\gamma}_{T}\right) \mid \mathcal{F}_{t}\right]=0
$$

and (2.16) holds with $\bar{p}_{t}$ is defined by (2.15).
To prove (2.17), we first note that the (standard) BSDE (2.17) has a unique solution and $D_{x} \widetilde{L}_{t}(\alpha, x)=-D_{x} \widetilde{H}_{t}(p, x)$ if $\alpha=-D_{p} \widetilde{H}_{t}(p, x)$. Thus, in view of (2.16), we have $D_{x} \widetilde{L}_{t}\left(\dot{\bar{\gamma}}_{t}, \bar{\gamma}_{t}\right)=-D_{p} \widetilde{H}_{t}\left(\bar{p}_{t}, \bar{\gamma}_{t}\right)$ and (2.15) can be written, for $t \in[0, T]$, as

It follows that $t \rightarrow \bar{p}_{t}-\bar{p}_{0}-\int_{0}^{t} D_{x} \widetilde{H}\left(\bar{p}_{s}, \bar{\gamma}_{s}\right) d s$ is a martingale, which proves (2.17).

The next result is about the regularity of $\widetilde{u}$ along the optimal path.
Lemma 2.10. Let $\bar{\gamma}$ and $\bar{p}$ be as in Theorem 2.8. Then, $\mathbb{P}-$ a.s. and for any $t \in(0, T]$, $x \rightarrow \widetilde{u}_{t}(x)$ is differentiable at $\bar{\gamma}_{t}$ and $\bar{p}_{t}=D \widetilde{u}_{t}\left(\bar{\gamma}_{t}\right)$.

Proof. It follows from the dynamic programming principle that, for any $h>0$ small, all $\mathcal{F}_{t}$ measurable and bounded $v$, and $\gamma^{h}$ such that $\gamma_{t-h}^{h}=\bar{\gamma}_{t-h}$ and $\dot{\gamma}_{s}^{h}=v^{h}=\mathbb{E}\left[v \mid \mathcal{F}_{t-h}\right]$ on $[t-h, t]$,
$\widetilde{u}_{t-h}\left(\bar{\gamma}_{t-h}\right)=\mathbb{E}\left[\int_{t-h}^{t} \widetilde{L}_{s}\left(\dot{\bar{\gamma}}_{s}, \bar{\gamma}_{s}\right) d s+\widetilde{u}_{t}\left(\bar{\gamma}_{t}\right) \mid \mathcal{F}_{t-h}\right] \leq \mathbb{E}\left[\int_{t-h}^{t} \widetilde{L}_{s}\left(v^{h}, \gamma_{s}^{h}\right) d s+\widetilde{u}_{t}\left(\gamma_{t}^{h}\right) \mid \mathcal{F}_{t-h}\right]$.
Let $q=q(\omega)$ be a measurable selection of $D^{+} u_{t}\left(\bar{\gamma}_{t}, \omega\right)$. Then, using the semiconcavity of $\widetilde{u}_{t}$, we find

$$

Dividing by $h$, letting $h \rightarrow 0^{+}$and using that the filtration $\left(\mathcal{F}_{t}\right)$ is continuous, we obtain

Since $\dot{\bar{\gamma}}_{t}$ maximizes $v \rightarrow-q \cdot v-\widetilde{L}_{t}\left(v, \bar{\gamma}_{t}\right)$, it follows from (2.16), that

Thus $q=\bar{p}_{t}$ and $D^{+} \widetilde{u}_{t}\left(\gamma_{t}\right)$ is a singleton. In view of the semiconcavity of $\widetilde{u}_{t}$, the last fact implies that $\widetilde{u}_{t}$ is differentiable at $\bar{\gamma}_{t}$ and $\bar{p}_{t}=D \widetilde{u}_{t}\left(\bar{\gamma}_{t}\right)$.
2.5. The continuity equation. We now investigate the continuity equation associated with the vector field $-D_{p} \widetilde{H}\left(D \widetilde{u}_{t}(x), x\right)$. As in the previous subsections, $(\widetilde{u}, \widetilde{M})$ is the solution of (1.3).

Proposition 2.11. Assume (H1), (H2) and (H3). Then, for each $\bar{m}_{0} \in L^{\infty}\left(\mathbb{R}^{d}\right) \cap \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, there exists a $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$-adapted process $\widetilde{m} \in \mathcal{S}^{r}\left(\mathcal{P}_{1}\left(\mathbb{R}^{d}\right)\right) \cap L^{\infty}\left(\mathbb{R}^{d} \times(0, T)\right)$ which solves, $\mathbb{P}$-a.s. and in the sense of distributions, the continuity equation (with random coefficients)

$$
\begin{equation*}
\partial_{t} \widetilde{m}_{t}=\operatorname{div}\left(\widetilde{m}_{t} D_{p} \widetilde{H}_{t}\left(D \widetilde{u}_{t}(x), x\right)\right) d t \quad \text { in } \quad \mathbb{R}^{d} \times(0, T) \quad \widetilde{m}_{0}=\bar{m}_{0} \quad \text { in } \quad \mathbb{R}^{d} \tag{2.19}
\end{equation*}
$$

Proof. We use the discretization in the proof of Theorem 2.3 and consider the solution $\left(\widetilde{u}^{N}, \widetilde{M}^{N}\right)$ of the discretized problem defined there.
Let $\widetilde{m}^{N} \in C\left([0, T] ; \mathcal{P}_{1}\left(\mathbb{R}^{d}\right)\right)$ be the $\left(\mathcal{F}_{t_{n}}\right)_{n=0, \ldots, N}$-adapted process that solves, in the sense of distributions,

$$
\begin{equation*}
\partial_{t} \widetilde{m}_{t}^{N}=\operatorname{div}\left(\widetilde{m}_{t}^{N} D_{p} \widetilde{H}_{t}^{N}\left(D \widetilde{u}_{t}^{N}, x\right)\right) d t \quad \text { in } \quad \mathbb{R}^{d} \times(0, T) \quad \widetilde{m}_{0}=\bar{m}_{0} \quad \text { in } \quad \mathbb{R}^{d} \tag{2.20}
\end{equation*}
$$

which, following the discussion in the appendix of [11], can be built by induction. Indeed, we can construct $\widetilde{m}^{N}$ on each time interval $\left[t_{n}^{N}, t_{n+1}^{N}\right]$, since on this interval $\widetilde{u}^{N}$ satisfies a standard HJ equation. In addition, for some $C>0$ and $\mathbb{P}$-a.s.,

& \text { (ii) } \mathbf{d}_{1}\left(\widetilde{m}_{t}^{N}, \widetilde{m}_{s}^{N}\right) \leq C|s-t| \text { for all } s, t \in[0, T] \\
& \text { (iii) }\left\|\widetilde{m}^{N}\right\|_{\infty} \leq C
\end{aligned}
$$

Let $\widetilde{m}$ be an (up to a subsequence) limit of $\left(\widetilde{m}^{N}\right)_{N \in \mathbb{N}}$ in $L^{\infty}\left(\mathbb{R}^{d} \times[0, T] \times \Omega\right)$-weak . Then, since, as $N \rightarrow \infty$ and $\mathbb{P}-$ a.s. and $(x, t)$ a.e., $D \widetilde{u}^{N} \rightarrow D \widetilde{u}$, we can pass to the limit in (2.20). The claim then follows.

We now turn to the question of uniqueness, for which, unfortunately, we require a much stronger condition than the standing ones. Indeed, we need to assume that $\widetilde{H}$ is of the form

where, for some constant $C_{0}>0$,

\widetilde{a}, \tilde{f} \in \mathcal{S}^{2}\left(C^{2}\left(\mathbb{R}^{d}\right)\right) \text { and } \widetilde{B} \in \mathcal{S}^{2}\left(C^{2}\left(\mathbb{R}^{d} ; \mathbb{R}^{d}\right)\right) \quad \text { with } C_{0}^{-1} \leq \widetilde{a}_{t}(x) \leq C_{0} \tag{2.22}
\end{equation*}
$$

We note that (2.21) and (2.22) yield that $\widetilde{H}$ satisfies (H1), (H2), and (H3).
The following result is a variation of the one in [7].
Proposition 2.12. Assume (H1), (2.21) and (2.22). Then, for each $\bar{m}_{0} \in L^{\infty}\left(\mathbb{R}^{d}\right) \cap$ $\mathcal{P}_{1}\left(\mathbb{R}^{d}\right)$, there exists a unique $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$-adapted process $\widetilde{m} \in \mathcal{S}^{2}\left(\mathcal{P}_{1}\left(\mathbb{R}^{d}\right)\right)$ with bounded density in $\left.\mathbb{R}^{d} \times(0, T)\right)$ which solves $(2.20), \mathbb{P}-$ a.s. and in the sense of distributions.

In the deterministic case considered in the appendix of [11], the uniqueness of a solution does not require an addition structure assumption on $\widetilde{H}$. Instead, it relies on the fact that the forward-forward Hamiltonian system (2.16)-(2.17) has a unique solution given the initial condition $\left(\bar{\gamma}_{0}, \bar{p}_{0}\right)$. Unfortunately this does not seem to be the case in the random setting.

Proof of Proposition 2.12. Set $\widetilde{b}_{t}(x)=-D_{p} \widetilde{H}_{t}\left(D \widetilde{u}_{t}(x), x\right)$. Then, in view of (2.21) and the definition of a solution $\widetilde{u}$ of (1.3), $\widetilde{b}_{t}(x)=-\widetilde{a}_{t}(x) D \widetilde{u}_{t}(x)-\widetilde{B}_{t}(x)$ is bounded and one-side Lipschitz, that is, there exists $C_{0}>0$ such that, for all $(x, y, t) \in \mathbb{R}^{d} \times \mathbb{R}^{d} \times[0, T]$,

\|\widetilde{b}\|_{\infty} \leq C_{0} \quad \text { and } \quad\left(\widetilde{b}_{t}(x)-\widetilde{b}_{t}(y)\right) \cdot(x-y) \geq-C_{0}|x-y|^{2}
$$

Then we can apply $\omega$ by $\omega$ the uniqueness result to the continuity equation given in Proposition A. 1 in the appendix.
2.6. Existence of optimal paths of the stochastic control problem. We now address the problem of the existence of optimal paths for the control representation of $\widetilde{u}$ established in Proposition 2.7. For simplicity we assume again that $t=0$ and recall that

\end{equation*}

The problem is that (2.23) is a non convex stochastic optimal control problem with a (a priori) non smooth value function, hence the existence of an optimal path is far from obvious.

Proposition 2.13. Assume (H1), (2.21) and (2.22). Then, $\mathbb{P}$-a.s. and for a.e. $x \in \mathbb{R}^{d}$ there exists a unique minimizer $\bar{\gamma}^{x} \in \mathcal{A}_{0, x}$ of the stochastic optimal control problem (2.23) and this minimizer satisfies $\dot{\bar{\gamma}}_{t}^{x}=-D_{p} \widetilde{H}_{t}\left(D \widetilde{u}_{t}\left(\bar{\gamma}_{t}\right), \bar{\gamma}_{t}\right)$.

Proof. Fix $\bar{m}_{0} \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ with smooth and positive density. According to Proposition 2.12, the random continuity equation

$$
\partial_{t} \widetilde{m}_{t}-\operatorname{div}\left(\widetilde{m}_{t} D_{p} \widetilde{H}_{t}\left(D \widetilde{u}_{t}, x\right)\right)=0 \text { in } \mathbb{R}^{d} \times(0, \infty) \quad \widetilde{m}_{0}=\bar{m}_{0} \text { in } \mathbb{R}^{d}
$$

has a unique solution $\widetilde{m}$ with bounded density.
A simple adaptation of the Lagrangian approach introduced in Ambrosio [2] shows that, in view of the uniqueness of the solution to the continuity equation, there exists a $d x \times d \mathbb{P}$-a.e. unique Borel measurable map $\mathbb{R}^{d} \times \Omega \ni(x, \omega) \rightarrow \bar{\gamma}^{x, \omega} \in \Gamma=C\left([0, T] ; \mathbb{R}^{d}\right)$, which is adapted to the filtration $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$, such that, $\mathbb{P}$-a.s. and for any $t \in[0, T], \bar{\gamma}_{0}^{x, \omega}=x$ and

$$
\widetilde{m}_{t}(\cdot, \omega)=\int_{\mathbb{R}^{d}} \delta_{\bar{\gamma}_{t}^{x}, \omega} \bar{m}_{0}(x) d x .
$$

We show next that the process $\left(\bar{\gamma}_{t}^{x}\right)_{t \in[0, T]}{ }_{\text {is }} \mathbb{R}^{d}$ optimal in the optimization problem (2.23) for $\bar{m}_{0}$-a.e. $x \in \mathbb{R}^{d}$. For this, we claim that

$$
\begin{equation*}
\int_{\mathbb{R}^{d}} \mathbb{E}\left[\int_{0}^{T} \widetilde{L}_{t}\left(\dot{\vec{\gamma}}_{t}^{x}, \bar{\gamma}_{t}^{x}\right) d t+\widetilde{G}\left(\bar{\gamma}_{T}^{x}\right)\right] m_{0}(x) d x=\int_{\mathbb{R}^{d}} \widetilde{u}_{0}(x) m_{0}(x) d x . \tag{2.24}
\end{equation*}
$$

Assuming for the moment (2.24), we proceed with the proof of the optimality, and recall that, for any $x \in \mathbb{R}^{d}$,

\widetilde{u}_{0}(x) \leq \mathbb{E}\left[\int_{0}^{T} \widetilde{L}_{t}\left(\dot{\bar{\gamma}}_{t}^{x}, \bar{\gamma}_{t}^{x}\right) d t+\widetilde{G}\left(\bar{\gamma}_{T}^{x}\right)\right]
$$

Integrating the inequality above against $\bar{m}_{0}$, we infer by (2.24) that $\bar{\gamma}^{x}$ is optimal for $\bar{m}_{0}-$ a.e. $x \in \mathbb{R}^{d}$. Since $\bar{m}_{0}>0$, this holds for a.e. $x \in \mathbb{R}^{d}$.
It remains to prove (2.24). For this let, $t_{n}=n T / N$ for $n \in\{0, \ldots, N\}$ with $N \in \mathbb{N}$ and note that, in view of the equation satisfied by $\widetilde{u}$, we have, for a.e. $x$,

Integrating (2.25) against $\widetilde{m}_{t_{n}}$, which is absolutely continuous with a bounded density, and summing over $n$ gives

& \quad=-\sum_{n=0}^{N-1} \int_{t_{n}}^{t_{n+1}} \int_{\mathbb{R}^{d}} \widetilde{H}_{t}\left(D \widetilde{u}_{t}(x), x\right) \widetilde{m}_{t_{n}}(x) d x d t-\sum_{n=0}^{N-1} \int_{\mathbb{R}^{d}}\left(\widetilde{M}_{t_{n+1}}(x)-\widetilde{M}_{t_{n}}(x)\right) \widetilde{m}_{t_{n}}(x) d x
\end{aligned}
$$

Reorganizing the left-hand side of the expression above taking into account the equation satisfied by $\widetilde{m}$ yields

& =\int_{\mathbb{R}^{d}} \widetilde{u}_{T}(x) \widetilde{m}_{t_{N-1}}(x) d x-\int_{\mathbb{R}^{d}} \widetilde{u}_{0}(x) \widetilde{m}_{0}(x) d x-\sum_{n=1}^{N-1} \int_{\mathbb{R}^{d}} \widetilde{u}_{t_{n}}(x)\left(\widetilde{m}_{t_{n}}(x)-\widetilde{m}_{t_{n-1}}(x)\right) d x \\
& =\int_{\mathbb{R}^{d}} \widetilde{G}(x) \widetilde{m}_{t_{N-1}}(x) d x-\int_{\mathbb{R}^{d}} \widetilde{u}_{0}(x) \bar{m}_{0}(x) d x \\
& \quad+\sum_{n=1}^{N-1} \int_{t_{n-1}}^{t_{n}} \int_{\mathbb{R}^{d}} D \widetilde{u}_{t_{n}}(x) \cdot D_{p} \widetilde{H}_{t}\left(D \widetilde{u}_{t}(x), x\right) \widetilde{m}_{t}(x) d x d t .
\end{aligned}
$$

We let $N \rightarrow+\infty$ and take expectation to find

& \mathbb{E}\left[\int_{\mathbb{R}^{d}} \widetilde{G}(x) \widetilde{m}_{T}(x) d x-\int_{\mathbb{R}^{d}} \widetilde{u}_{0}(x) \bar{m}_{0}(x) d x+\int_{0}^{T} \int_{\mathbb{R}^{d}} D \widetilde{u}_{t}(x) \cdot D_{p} \widetilde{H}_{t}\left(D \widetilde{u}_{t}(x), x\right) \widetilde{m}_{t}(x)\right] \\
& =\mathbb{E}\left[-\int_{0}^{T} \int_{\mathbb{R}^{d}} \widetilde{H}_{t}\left(D \widetilde{u}(x)_{t}, x\right) \widetilde{m}_{t}(x) d x d t-\int_{0}^{T} \int_{\mathbb{R}^{d}} \widetilde{m}_{t}(x) d \widetilde{M}_{t}(x) d x\right] .
\end{aligned}
$$

Recalling that $\widetilde{M}$ is a martingale and that $p \cdot D_{p} \widetilde{H}_{t}(p, x)+\widetilde{H}_{t}(p, x)=\widetilde{L}_{t}\left(-D_{p} \widetilde{H}_{t}\left(D \widetilde{u}_{t}(x), x\right), x\right)$, we rearrange the last expression to get

## 3. The stochastic MFG system

We investigate the stochastic MFG system (1.1). We begin recalling that, after the change of the unknowns in (1.5) we obtain, at least formally, (1.6) which we study here.
3.1. The assumptions and the notion of solution. To study (1.6) we assume that

Remark 3.1. It follows from (MFG2) and (MFG6) that $\widetilde{F}$ is Hölder continuous in $m$ with respect to the $\mathbf{d}_{1}-$ distance, that is, for all $m_{1}, m_{2} \in \mathcal{P}_{1}\left(\mathbb{R}^{d}\right)$

3.2. The existence and uniqueness result. The main result of the paper about the existence and uniqueness of a solution of (1.6) is stated next.

Theorem 3.3. Assume (MFG1), (MFG2), (MFG3), (MFG4), (MFG5) and (MFG6). Then there exists a unique solution of (1.6).

The proof consists of several steps. Similarly to the Hamilton-Jacobi case, the solution is constructed by discretizing the noise in time. Hence, the first step is to recall and refine known regularity results for deterministic MFG systems. Then we explain the construction of an approximate solution by time discretization and, finally, we pass to the limit to obtain the solution of (1.6).
3.3. The deterministic MFG system. We consider the deterministic MFG system

A solution of (3.1) is a pair $(u, m)$ such that $u$ is a continuous, bounded and semiconcave in $x$ uniformly in $t$ viscosity solution of the HJ equation, while $m \in C\left([0, T], \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right) \cap$ $L^{\infty}\left(\mathbb{R}^{d} \times(0, T)\right)$ is a solution of the continuity equation in the sense of distribution.
Next we state some general hypotheses, which imply the existence of a solution of (3.1).

We note the claim is that $u$ remains bounded and uniformly semiconcave in $x$ uniformly in time and in the initial measure $\bar{m}_{0}$.

In addition, $u$ is also uniformly Lipschitz continuous in $x$. This is a consequence of the elementary fact that, if $v: \mathbb{R}^{d} \rightarrow \mathbb{R}$ is bounded by some $M$ and semiconcave with constant $K, v$ is Lipschitz continuous with a Lipschitz constant bounded by $2(M K)^{1 / 2}$.
Finally, the fact that the estimates on $u$ and $m$ grow only linearly in time $T$ will be important in the construction of the next subsection and justifies the awkward formulation of the semiconcavity estimate.

The proof of Lemma 3.4. The existence and uniqueness of the solution $(u, m)$ and the estimates on $m$ can be found in [11,30]. The bound and the semiconcavity estimates on $u$ can be established as in the proof of Lemma 2.4. Here we only repeat some the formal argument for convenience, noting that everything can be justified using "viscous" regularizations.
Formally, it is immediate that

Later in the paper it will be convenient to define the solution of (3.1) in a unique way for less regular initial measures. For this we use the following regularity result.

Then, if $\left(u^{1}, m^{1}\right),\left(u^{2}, m^{2}\right)$ are the solutions of the MFG system (3.1) with $m_{0}^{1}, m_{0}^{2} \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \cap L^{\infty}\left(\mathbb{R}^{d}\right)$, then, there exist positive constants $C, C^{\prime}$, which depend on $d, \alpha_{G}, \alpha_{F}$ and $\left\|D u^{i}\right\|_{\infty}$, such that

Moreover, in view of Lemma 3.4 and Proposition 3.5, the extended map $U: \mathbb{R}^{d} \times[0, T] \times$ $\mathcal{P}_{1}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ is Hölder continuous in $m$ uniformly in $x$, Lipschitz continuous and semiconcave in $x$ uniformly in $m$, and strongly monotone in the sense of (3.4).
We also note that the map $\bar{m}_{0} \rightarrow m$, where $(u, m)$ is the solution of the MFG system (3.1) with initial condition $m(0)=\bar{m}_{0}$, is continuous in $C\left([0, T] ; \mathcal{P}_{1}\left(\mathbb{R}^{d}\right)\right)$. Indeed, Proposition 3.5 gives that the map $\bar{m}_{0} \rightarrow u$ is continuous from $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ to $C\left(\mathbb{R}^{d} \times[0, T]\right)$. In view of the semiconcavity estimate on $u$, this in turn yields the continuity of the map $\bar{m}_{0} \rightarrow D u$ in $L_{l o c}^{1}\left(\mathbb{R}^{d} \times[0, T]\right)$. The claimed continuity of $\bar{m}_{0} \rightarrow m$ follows combining the uniform in
time continuity of $m$ in $\mathcal{P}_{1}\left(\mathbb{R}^{d}\right)$, which depends on $\|D u\|_{\infty}$, the $L^{\infty}$-estimate on $m$ and the uniqueness of the solution of the associated continuity equation.

Proof of Proposition 3.5. Using a viscous approximation to justify it, the standard proof of uniqueness of the MFG system (3.1) yields

& \leq \int_{\mathbb{R}^{d}}\left(u^{1}(x, 0)-u^{2}(x, 0)\right)\left(m_{0}^{1}-m_{0}^{2}\right)(d x) \leq\left(\left\|D u^{1}\right\|_{\infty}+\left\|D u^{2}\right\|_{\infty}\right) \mathbf{d}_{1}\left(m_{0}^{1}, m_{0}^{2}\right)

Using the uniform Lipschitz estimates on $u^{i}$ and the comparison principle in the equations for the $u^{i}$ we find

3.4. The discretized stochastic MFG system. We use the same discretization technique and the same notation as in the proof of Theorem 2.3. Let $N \in \mathbb{N}$ and set $t_{n}^{N}=T n / N$,

The goal here is to build a triplet $\left(\widetilde{u}^{N}, \widetilde{M}^{N}, \widetilde{\mu}^{N}\right)$ such that
(i) $\left(\widetilde{u}^{N}, \widetilde{M}^{N}, \widetilde{\mu}^{N}\right)$ is adapted to the filtration $\left(\mathcal{F}_{t}^{N}\right)_{t \in[0, T]}$,
(ii) on each interval $\left(t_{n}^{N}, t_{n+1}^{N}\right)$ with $n=0, \ldots, N-1, \widetilde{u}^{N}$ is a viscosity solutions of the backward HJ equation

Then, there exists at least one solution $\left(\widetilde{u}^{N}, \widetilde{M}^{N}, \widetilde{\mu}^{N}\right)$ of the problem above and $C>0$ such that, $\mathbb{P}-$ a.s., a.e. in $t \in[0, T]$, all $z \in \mathbb{R}^{d}$ with $|z| \leq 1$, and in the sense of distributions,
(i) $\left\|\widetilde{u}^{N}\right\|_{\infty}+\left\|D \widetilde{u}^{N}\right\|_{\infty}+\|\widetilde{M}\|_{\infty}+\left\|\widetilde{\mu}^{N}\right\|_{\infty}+D^{2} \widetilde{u}_{t}^{N} z \cdot z \leq C$,
(ii) for any $x \in \mathbb{R}^{d},\left(\widetilde{u}_{t}^{N}(x)\right)_{t \in[0, T]}$ and $\left(\widetilde{\mu}_{t}^{N}(x)\right)_{t \in[0, T]}$ are adapted to the filtration $\left(\mathcal{F}_{t}^{N}\right)_{t \in[0, T]}$ and, therefore, the filtration $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$, and $\left(\widetilde{M}_{t_{n}}^{N}(x)\right)_{n=0, \ldots, N}$ is a martingale with respect to the discrete filtration $\left(\mathcal{F}_{t_{n}}\right)_{n=0, \ldots, N}$.
Proof. We show first $\left(\widetilde{u}^{N}, \widetilde{M}^{N}, \widetilde{\mu}^{N}\right)$ is well-posed. For this, we define by backward induction a sequence of maps $\widetilde{U}^{N}: \mathbb{R}^{d} \times\left[t_{n}^{N}, t_{n+1}^{N}\right) \times \mathcal{P}_{1}\left(\mathbb{R}^{d}\right) \times \Omega \rightarrow \mathbb{R}$ such that, for each $t \in\left[t_{n}^{N}, t_{n+1}^{N}\right)$, $\widetilde{U}_{t}^{N}$ is $\mathcal{F}_{t_{n}^{N}}$-measurable, Hölder continuous in $m$ uniformly in $x$, bounded and semiconcave in $x$ uniformly in $m$ and strongly monotone in the sense of (3.4).
We set $\widetilde{U}_{N}^{N}=\widetilde{G}$ and, given $\widetilde{U}_{t_{n+1}^{N}}^{N}$, we define $\widetilde{U}_{t}^{N}$ on $\left[t_{n}^{N}, t_{n+1}^{N}\right)$ as follows: for any $\bar{m}_{0} \in$ $\mathcal{P}_{2} \cap L^{\infty}$ we solve the MFG system

\widetilde{m}_{t_{n}}=\bar{m}_{0} \text { nd } \widetilde{v}_{t_{n+1}^{N,}}^{N,-}=\mathbb{E}\left[\widetilde{U}_{t_{n+1}^{N}}^{N}\left(\cdot, \widetilde{m}_{t_{n+1}^{N+1}}^{N}\right) \mid \mathcal{F}_{t_{n}^{N}}\right] \text { in } \mathbb{R}^{d} .
\end{array}\right.
$$

We know from the discussion after Proposition 3.5 that, if we set $\widetilde{U}_{t}^{N}\left(x, \bar{m}_{0}\right)=\widetilde{v}_{t}(x)$, then $\widetilde{U}_{t}^{N}$ can be extended on $\mathbb{R}^{d} \times \mathcal{P}_{1}$ and satisfies the required regularity properties.
In what follows it will be convenient to set $\widetilde{\rho}_{t}^{N, n}\left(x, \bar{m}_{0}\right)=\widetilde{m}_{t}(x)$. We remark that $\widetilde{\rho}^{N, n}$ is $\mathcal{F}_{t_{n}}$-measurable and continuous in $\bar{m}_{0}$ in $\mathcal{P}_{1}\left(\mathbb{R}^{d}\right)$.
Given $\bar{m}_{0} \in \mathcal{P}_{2} \cap L^{\infty}$, we now build ( $\widetilde{u}^{N}, \widetilde{\mu}^{N}, \widetilde{M}^{N}$ ). We set, for $t \in\left[0, t_{1}^{N}\right]$,

In view of the definition of $\widetilde{U}^{N}$ and $\rho^{N, n}$, the triplet ( $\widetilde{u}^{N}, \widetilde{M}^{N}, \widetilde{\mu}^{N}$ ) solves the required equations and is adapted to the discrete filtration $\left(\mathcal{F}_{t}^{N}\right)_{t \in[0, T]}$. The estimates on $\widetilde{u}^{N}$ and $\widetilde{\mu}^{N}$ follow from Lemma 3.4 applied on each time interval $\left(t_{n}^{N}, t_{n+1}^{N}\right)$. We remark that this is the place we use that the estimates in Lemma 3.4 is grow linearly in time. The bound on $\widetilde{M}^{N}$ is obtained as in the proof of Lemma 2.4.
3.5. Passing to the limit. The aim is to pass to the limit in the discrete MFG system. Using the strong monotonicity of $\widetilde{F}$ and $\widetilde{G}$, we obtain the following estimate.
Lemma 3.7. Let $\left(\widetilde{u}^{N}, \widetilde{M}^{N}, \widetilde{\mu}^{N}\right)$ be defined as above. There exists a random variable $\omega^{N}$ such that $\underset{N \rightarrow \infty}{\mathbb{E}}\left[\omega^{N}\right]=0$ and, for $K, N \in \mathbb{N}$ with $K \geq N$,

Proof. Using the fact that the pair $\left(\widetilde{u}^{N}, \widetilde{\mu}^{N}\right)$ is piecewise classical solution of the MFG system, with $\widetilde{\mu}^{N}$ continuous in time and adapted, we find, following the classical LasryLions computation, that

& \left.+\int_{\mathbb{R}^{d}}\left(\widetilde{u}_{t}^{N}(x)-\widetilde{u}_{t}^{K}(x)\right)\left(\operatorname{div}\left(\widetilde{\mu}_{t}^{N}(x) D_{p} \widetilde{H}_{t}^{N}\left(D \widetilde{u}_{t}^{N}(x), x\right)\right)-\operatorname{div}\left(\widetilde{\mu}_{t}^{K}(x) D_{p} \widetilde{H}_{t}^{K}\left(D \widetilde{u}_{t}^{K}(x), x\right)\right)\right) d x\right] \\
& =-\mathbb{E}\left[\int_{\mathbb{R}^{d}}\left(\widetilde{F}_{t}^{N}\left(x, \widetilde{\mu}_{t}^{N}\right)-\widetilde{F}_{t}^{K}\left(x, \widetilde{\mu}_{t}^{K}\right)\right)\left(\widetilde{\mu}_{t}^{N}(x)-\widetilde{\mu}_{t}^{K}(x)\right) d x\right] \\
& -\mathbb{E}\left[\int _ { \mathbb { R } ^ { d } } \mu _ { t } ^ { N } ( x ) \left(\widetilde{H}_{t}^{K}\left(D \widetilde{u}_{t}^{K}(x), x\right)-\widetilde{H}_{t}^{N}\left(D \widetilde{u}_{t}^{N}(x), x\right)\right.\right. \\
& \left.-\left(D \widetilde{u}_{t}^{N}(x)-D \widetilde{u}_{t}^{K}(x)\right) \cdot D_{p} \widetilde{H}_{t}^{N}\left(D \widetilde{u}_{t}^{N}(x), x\right)\right) d x+\int_{\mathbb{R}^{d}} \mu_{t}^{K}(x)\left(\widetilde{H}_{t}^{N}\left(D \widetilde{u}_{t}^{N}(x), x\right)\right. \\
& \left.\left.-\widetilde{H}_{t}^{K}\left(D \widetilde{u}_{t}^{K}(x), x\right)-\left(D \widetilde{u}_{t}^{K}(x)-D \widetilde{u}_{t}^{N}(x)\right) \cdot D_{p} \widetilde{H}_{t}^{K}\left(D \widetilde{u}_{t}^{K}(x), x\right)\right) d x\right] .
\end{aligned}
$$

In order to use the strong monotonicity assumption on $\widetilde{F}$ and the convexity of $\widetilde{H}$, we replace the discretized maps $\widetilde{F}^{N}$ and $\widetilde{H}^{N}$ by the continuous ones and find

\end{aligned}
$$

where, with $C$ being the uniform bound on $D \widetilde{u}^{N}$ and on $D \widetilde{u}^{K}$,

Let $1<N<K$ and $\phi: \mathbb{R} \rightarrow \mathbb{R}^{+}$smooth, Lipschitz continuous, convex and nonincreasing map, and set $w_{t}(x)=\phi\left(\widetilde{u}_{t}^{N}(x)-\widetilde{u}_{t}^{K}(x)\right)$. Using induction and the convexity of $\phi$ to cancel the jump terms, which are martingales, for any $t \in[0, T)$ and $h \in(0, T-h)$, we find

Lemma 3.8 and the properties of $\widetilde{F}$ and $\widetilde{G}$ yield that the sequences $\left(\widetilde{u}^{N}\right)_{N \in \mathbb{N}},\left(\widetilde{F}\left(\cdot, \widetilde{\mu}^{N} .\right)\right)_{N \in \mathbb{N}}$ and $\widetilde{G}\left(\cdot, \widetilde{\mu}_{T}^{N}\right)_{N \in \mathbb{N}}$ are Cauchy, with respective limits $\widetilde{u}, \widetilde{f}$ and $\widetilde{g}$.
It follows, as in the proof of Theorem 2.3, that the sequences $\left(D \widetilde{u}^{N}\right)_{N \in \mathbb{N}}$ and $\left(\widetilde{M}^{N}\right)_{N \in \mathbb{N}}$ also converge, as $N \rightarrow \infty$, to $D \widetilde{u}$ and $\widetilde{M}$ respectively, $\widetilde{M}$ is a continuous process, and, in addition, $(\widetilde{u}, \widetilde{M})$ solves

Fix $\omega$ for which $\widetilde{u}^{N}$ converges to $\widetilde{u}$ locally uniformly and $D \widetilde{u}^{N}$ converges to $D \widetilde{u}$ a.e.. In view of the bound on $\left(\widetilde{\mu}^{N}\right)_{N \in \mathbb{N}}$, the sequence $\left(\widetilde{\mu}^{N}\right)_{N \in \mathbb{N}}$ is relatively compact in $C\left([0, T] ; \mathcal{P}_{1}\left(\mathbb{R}^{d}\right)\right)$ and in $L^{\infty}$ weak-*. So we can find a subsequence, which we denote in the same way, which
converges, in $C\left([0, T] ; \mathcal{P}_{1}\left(\mathbb{R}^{d}\right)\right)$ and in $L^{\infty}$-weak-*, to some $\widetilde{\mu}$, which is a bounded solution of the continuity equation

It follows that the sequences $\left(\widetilde{F}_{t}^{N}\left(x, \widetilde{\mu}_{t}^{N}\right)\right)_{N \in \mathbb{N}}$ and $\left(\widetilde{G}^{N}\left(x, \widetilde{\mu}_{T}^{N}\right)\right)_{N \in \mathbb{N}}$ converge locally uniformly to $\widetilde{F}_{t}\left(x, \widetilde{\mu}_{t}\right)$ and $\widetilde{G}\left(x, \widetilde{\mu}_{T}\right)$ respectively. We can therefore conclude that the pair $(\widetilde{u}, \widetilde{M}, \widetilde{\mu})$ is a solution to the MFG system (1.6).

Since the proof of the uniqueness of solutions follows the standard argument, we only sketch it. Let ( $\widetilde{u}^{1}, \widetilde{M}^{1}, \widetilde{m}^{1}$ ) and ( $\widetilde{u}^{2}, \widetilde{M}^{2}, \widetilde{m}^{2}$ ) be two solutions of (1.6). We show that

Thus $\widetilde{u}^{1}$ and $\widetilde{u}^{2}$ solve the same HJ equation. It follows from Proposition (2.5) that $\widetilde{u}^{1}=\widetilde{u}^{2}$.
The equality $\widetilde{M}^{1}=\widetilde{M}^{2}$ follows from the equation satisfied by the $\widetilde{u}^{i}$.
3.6. Application to $N$-player differential games. We consider here a game with $N$ players and show that, if $N$ is large enough, the optimal controls given by the solution of the stochastic MFG system (1.6) provide an approximate Nash equilibrium for the game.
We begin with the notation, terminology and the general setting. In what follows, $N \in \mathbb{N}$, $\bar{m}_{0} \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ with an $L^{\infty}$-density, $\left(Z^{i}\right)_{i \in \mathbb{N}}$ is a sequence of independent random initial conditions on $\mathbb{R}^{d}$ with law $\bar{m}_{0}$, and $W$ is a Brownian motion independent of the $\left(Z^{i}\right)_{i \in \mathbb{N}}$. The state $X^{\alpha^{i}}$ of the $i-$ th player satisfies, for $i=1, \ldots, N$, the stochastic differential equation

Note that the noise $W$ is the same for all the players.
The cost of player $i$, associated to the admissible control $\alpha^{i}$ and given the admissible controls of the $\left(\alpha^{j}\right)_{j \neq i}$ of the other players, is

Set $\bar{\alpha}_{t}^{x}=\dot{\bar{\gamma}}_{t}^{x}=-D_{p} \widetilde{H}_{t}\left(D \widetilde{u}_{t}\left(\bar{\gamma}_{t}^{x}\right), \bar{\gamma}_{t}^{x}\right)$.
Proposition 3.9. Assume (MFG1), (3.13), (3.14) and (3.15). Then, for any $\varepsilon>0$, there exists $N_{0}=N_{0}(\varepsilon) \in \mathbb{N}$ such that, for any $N \geq N_{0}$, the family of random controls $\left(\bar{\alpha}^{Z^{i}}\right)_{i=1, \ldots, N}$ is an $\epsilon-$ Nash equilibrium of the game.

It follows from Proposition 2.12 that this solution is unique. Therefore, the conditional law $\tilde{\mu}_{t}$ of $\left(\bar{\gamma}_{t}^{Z^{i}}\right)_{t \in[0, T]}$ given $W$ is $\tilde{m}_{t}$. Since $\bar{X}_{t}^{i}=\bar{\gamma}_{t}^{Z^{i}}+\sqrt{2 \beta} W_{t}$, this implies that the conditional law of $\bar{X}_{t}^{i}$ given $W$ is $m_{t}$.
Since the $Z^{i}$,s and $W$ are independent, it is clear that the $\bar{X}^{i}$,s are conditionally independent and have the same law $m$ given $W$. It then follows from the Glivenko-Cantelli law of large numbers that, $\mathbb{P}$-a.s.,

## Appendix A. A uniqueness result for a continuity equation

We study here the uniqueness of distributional solutions of the forward continuity equation

where $\bar{m}_{0}$ is a Borel probability measure on $\mathbb{R}^{d}$ with a bounded density and $b:[0, T] \times \mathbb{R}^{d} \rightarrow$ $\mathbb{R}^{d}$ is a bounded, half-Lipschitz from below Borel vector field, that is, there is a constant $C_{0}$ such that, for all $x, y \in \mathbb{R}^{d}$ and $t \in[0, T]$,

The following result is a variant of a theorem in [7]:
Proposition A.1. Assume (A.2) and let $\bar{m}_{0} \in \mathcal{P}_{1}\left(\mathbb{R}^{d}\right)$ be absolutely continuous with bounded density. Then there exists a unique bounded and absolutely continuous with respect to the Lebesgue measure solution of (A.1).
The proof requires several steps and is based on the Filippov regularization $b^{F}$ of $b$; see Filippov [19]. Recall that $b^{F}$ is an upper semicontinuous set-valued map with convex compact values. It follows from (A.2), that, if $\mathcal{N}=\left\{(x, t):\left\{b_{t}(x)\right\} \neq b_{t}^{F}(x)\right\}$, then

It is known that, in view of (A.2), for any $\left(x_{0}, t_{0}\right) \in \mathbb{R}^{d} \times(0, T]$, there exists a unique absolutely continuous solution $X\left(x_{0}, t_{0}, \cdot\right)$ of the backward differential inclusion

which is referred to as the Filippov solution of the ODE, and, for all $x_{0}, x_{1} \in \mathbb{R}^{d}$ and $t \in\left[0, t_{0}\right]$,

Note that any smooth approximation $b^{\varepsilon}$ of $b$ obtained by, for example, a convolution with a nonnegative, smooth kernel, satisfies (A.2) with the same constant $C_{0}$.

It then follows that the classical backward flow $X^{\varepsilon}\left(x_{0}, t_{0}, \cdot\right)$ of

Proof. Arguing by contradiction, we assume that, for some $t \in\left[0, t_{0}\right]$, there exists $y \in$ $\mathbb{R}^{d} \backslash X\left(\mathbb{R}^{d}, t_{0}, t\right)$. The finite speed of propagation property and the continuity the flow yield some $\delta>0$ such that $B_{\delta}(y) \cap X\left(\mathbb{R}^{d}, t_{0}, t\right)=\emptyset$.
Let $\bar{m}_{0}$ be a probability measure with a smooth density supported in $B_{\delta}(y)$ and $b^{\varepsilon}$ a smooth approximation of $b$ satisfying (A.2) with a constant independent of $\varepsilon$. Note that, for any $0 \leq t \leq t_{0} \leq T$, the map $x \rightarrow X^{\varepsilon}\left(x, t_{0}, t\right)$ is smooth and one-to-one.
We consider the classical solution $m^{\varepsilon}$ to the continuity equation

Next, we use Ambrosio's superposition principle [2] which provides a connection between solutions of the continuity equation (A.6) and the ODE (A.3) in the form of a Borel measure $\eta$ on $\Gamma=C\left(\left[t, t_{0}\right], \mathbb{R}^{d}\right)$ which is concentrated on solutions of (A.3) and is such that $m(s)=$ $e_{s} \sharp \eta$ for $s \in[t, T]$.
We claim that, for $\eta$-a.e. $\gamma \in \Gamma, \gamma$ is a Filippov solution of (A.3). Indeed, it follows from (A.4) that, since $m$ is absolutely continuous with respect to the Lebesgue measure,

Lemma A.3. Assume (A.2). Then, for any $s, t \in[0, T]$ with $s<t$, there exists a set $E_{s, t}$ of full $\mathcal{L}^{d}$-measure on which $X^{-1}(\cdot, t, s)$ is a singleton.
Proof. The main step of the proof is the fact that, for any $x \in \mathbb{R}^{d}$, the set $X^{-1}(\{x\}, s, t)$, which, in view of Lemma A.2, is nonempty, is connected.
Since $X^{-1}(\{x\}, s, t)$ is compact, it suffices to show that, if $O_{1}$ and $O_{2}$ are two open subsets of $\mathbb{R}^{d}$ such that $X^{-1}(\{x\}, s, t) \subset O_{1} \cup O_{2}$ and $\bar{O}_{1} \cap \bar{O}_{2}=\emptyset$, then $X^{-1}(\{x\}, s, t)$ is contained either in $O_{1}$ or in $O_{2}$.

Let $O_{1}$ and $O_{2}$ be as above. The upper-semicontinuity of $X^{-1}(\cdot, s, t)$, which is a consequence of the stability of the flow, yields some $r>0$ such that $X^{-1}\left(B_{r}(x), s, t\right) \subset O_{1} \cup O_{2}$.
Let $b^{\varepsilon}$ and $X^{\varepsilon}$ be respectively a smooth approximation of $b$ and the associated group of solution. Then $\left(X^{\varepsilon}\right)^{-1}\left(B_{r}(x), s, t\right)=X^{\varepsilon}\left(B_{r}(x), t, s\right)$ is connected and, for $\varepsilon$ small enough, is contained in $O_{1} \cup O_{2}$. Thus, it is contained either in $O_{1}$ or in $O_{2}$. Without loss of generality, we can assume that there exists $\varepsilon_{n} \rightarrow 0$ such that $\left(X^{\varepsilon_{n}}\right)^{-1}\left(B_{r}(x), s, t\right) \subset O_{1}$.
Passing to the limit up to this subsequence, we infer that

$$
X^{-1}(\{x\}, s, t) \subset \bigcap_{r>0} \limsup \left(X^{\varepsilon_{n}}\right)^{-1}\left(B_{r}(x), s, t\right) \subset \overline{O_{1}}
$$

Since $\bar{O}_{1} \cap \bar{O}_{2}=\emptyset$ and $X^{-1}(\{x\}, s, t) \subset O_{1} \cup O_{2}$, this implies that $X^{-1}(\{x\}, s, t)$ is contained in $O_{1}$, and, hence, $X^{-1}(\{x\}, s, t)$ is connected.
The fact that $x \rightarrow X(x, s, t)$ is Lipschitz continuous and the area formula imply that $X^{-1}(\{x\}, s, t)$ is at most countable for a.e. $x \in \mathbb{R}^{d}$. Then the fact that $X^{-1}(\{x\}, s, t)$ is nonempty and connected implies that, as soon it is countable, $X^{-1}(\{x\}, s, t)$ must be a singleton for a.e. $x \in \mathbb{R}^{d}$.

The next Lemma is about the existence and uniqueness of a forward solution of the Fillipov ODE.

Lemma A.4. Assume (A.2). Then, there exists $E \subset R^{d}$ of full $\mathcal{L}^{d}$-measure such that, for any $x \in E$, there exists a unique forward maximal absolutely continuous solution of $\dot{x}_{t} \in b_{t}^{F}\left(x_{t}\right)$ on $[0, T]$ with $x_{0}=x$.

Proof. Let $\left(t_{n}\right)_{n \in N}$ be a countable and dense set of times in $[0, T]$ with $t_{0}=T$ and $E=$ $\bigcap_{n} E_{0, t_{n}}$, where $E_{s, t}$ is given in Lemma A.3. Note that $E$ had a full $\mathcal{L}^{d}$-measure in $\mathbb{R}^{d}$. Then, for any $x \in E$, there exists a unique $y \in \mathbb{R}^{d}$ such that $X(y, T, 0)=x$.
We claim that $t \rightarrow X(y, T, t)$ is the claimed unique forward maximal solution. Indeed, by definition, it is a maximal solution. Assume that $x:\left[0, t^{*}\right) \rightarrow \mathbb{R}^{d}$ is another maximal solution defined on an interval $\left[0, t^{*}\right)$ with $t^{*} \in(0, T]$ and $x_{0}=x$. Note that, the backward uniqueness of the flow, implies that $x_{s}=X\left(x_{t}, t, s\right)$ for any $0 \leq s<t<t^{*}$.
Let $t_{n} \in\left(0, t^{*}\right)$. Then $t \rightarrow X(y, T, t)$ is a solution on $\left[0, t_{n}\right]$ starting from $X\left(y, T, t_{n}\right)$. Therefore $x_{t_{n}}$ and $X\left(y, T, t_{n}\right)$ belong to $X^{-1}\left(\{x\}, t_{n}, 0\right)$, which is a singleton by the definition of $E_{0, t_{n}}$. It follows that $x_{t_{n}}=X\left(y, T, t_{n}\right)$. So $x_{t}=X(y, T, t)$ on $\left[0, t^{*}\right)$, and, hence, the uniqueness.

We are now in a position to complete the proof of the existence and uniqueness of bounded and absolutely continuous distributional solutions of the continuity equation.

Proof of Proposition A.1. Since the existence of a bounded solution of the continuity equation can be achieved by standard approximation, we concentrate only on the uniqueness.
Let $m$ be an absolutely continuous solution to the continuity equation with initial condition $\bar{m}_{0}$. The Ambrosio superposition Theorem [2] yields a measure $\eta$ on $\Gamma$ such that $m(t)=e_{t} \sharp \eta$, where $e_{t}(\gamma)=\gamma_{t}$, and for $\eta$-a.e. $\gamma \in \Gamma, \gamma$ is an absolutely continuous solution to the ODE $\dot{\gamma}_{t}=b_{t}\left(\gamma_{t}\right)$.
Arguing as in the proof of Lemma A.2, we find that, that $\eta$-a.e. $\gamma \in \Gamma$ is a Filippov solution of the ODE.

We now disintegrate $\eta$ with respect to $\bar{m}_{0}$ into $\eta(d \gamma)=\int_{\mathbb{R}^{d}} \eta_{x}(d \gamma) \bar{m}_{0}(x) d x$ in such a way that, for $\bar{m}_{0}$-a.e. $x \in \mathbb{R}^{d}$ and $\eta_{x}$-a.e. $\gamma \in \Gamma$, $\gamma_{0}=x$. Since, by Lemma A.4, the Filippov solution to the ODE is unique for a.e. $x \in \mathbb{R}^{d}$, we obtain that, for $\bar{m}_{0}$-a.e. $x \in \mathbb{R}^{d}, \eta_{x}$ is a Dirac mass. The uniqueness of the bounded and absolutely continuous solution of the continuity equation then easily follows from [2].
