# Influenza infection rewires energy metabolism and induces browning features in adipose cells and tissues

# 24 Abstract

Like all obligate intracellular pathogens, influenza A virus (IAV) reprograms host cell's glucose and lipid metabolism to promote its own replication. However, the impact of influenza infection on white adipose tissue (WAT), a key tissue in the control of systemic energy homeostasis, has not been yet characterized. Here, we show that influenza infection induces alterations in whole-body glucose metabolism that persist long after the virus has been cleared. We report depot-specific changes in the WAT of IAV-infected mice, notably characterized by the appearance of thermogenic brown-like adipocytes within the subcutaneous fat depot. Importantly, viral RNA- and viral antigen-harboring cells are detected in the WAT of infected mice. Using *in vitro* approaches, we find that IAV infection enhances the expression of brown-adipogenesis-related genes in preadipocytes. Overall, our findings enlight the role that the white adipose tissue, which lies at the crossroads of nutrition, metabolism and immunity, may have in influenza infection.

#### 49 Introduction

50 Influenza A viruses (IAVs) are important human respiratory pathogens that lead to substantial morbidity and severe disability during annual epidemics<sup>1</sup>. Older adults and pediatric 51 populations are particularly at risk for influenza complications. Influenza viruses can also 52 53 cause recurrent, sporadic and potentially devastating pandemic outbreaks, which create 54 enormous health and economic burdens worldwide. Despite great advances in our understanding of the mechanisms of IAV infection, there is still a major need for more 55 56 effective virus control modalities; achieving this goal will require a better understanding of 57 the complex virus-host interactions.

58 An IAV infection starts in the respiratory tract, where viruses must attach to, invade and replicate in airway epithelial cells before spreading to neighboring non-immune cells and 59 innate and adaptive immune cells<sup>2</sup>. The antiviral innate immune response has several major 60 61 roles in host defense: it limits (or at least controls) viral replication during the early phase of 62 infection, and induces the subsequent adaptive immune response that plays a critical role in 63 viral clearance and development of long-lasting immunity during the later stages of infection<sup>3</sup>. 64 Although influenza infection predominantly results in damage to the respiratory system, 65 various cardiovascular, neurological and gastrointestinal complications have also been reported<sup>4</sup>. Even though the data are subject to debate, it has been suggested that highly 66 pathogenic IAVs can replicate outside the respiratory system - notably in the intestine<sup>5,6</sup>. 67 68 The link between influenza infection and metabolic disorders remains elusive. On one hand, 69 data from animal and human studies have identified type 2 diabetes and obesity (both of 70 which are characterized by chronic subclinical inflammation and hyperglycemia<sup>7</sup>) as risk factors for severe influenza outcomes<sup>8,9</sup>. On the other hand, a few case reports have suggested 71 72 that influenza infection *per se* may trigger, unmask or aggravate metabolic disorders<sup>4</sup>. At the cellular level, influenza infection dramatically alters host cell's metabolism and thus 73

creates an environment that is propitious for viral replication. Pioneering studies in the 1950s 74 and 1960s observed greater glucose uptake and glycolysis in infected chick embryo cells<sup>10</sup>; in 75 contrast, the inhibition of glucose metabolism significantly reduced viral replication<sup>11</sup>. More 76 recently, Smallwood et al. reported elevated glucose metabolism in the lungs of IAV-infected 77 patients and in *in-vitro*-infected primary human bronchial epithelial cells<sup>12</sup>. Furthermore, 78 79 influenza infection increases lipid and cholesterol biosynthesis in the host pulmonary cells<sup>13,14</sup>; accordingly, the pharmacological inhibition of fatty acid biosynthesis suppresses 80 virus replication<sup>15</sup>. 81

82 White adipose tissue (WAT) is a key metabolic organ. It has a major role in the regulation of whole-body glucose and lipid metabolism<sup>16</sup>. In addition to mature, lipid-filled adipocytes, 83 84 WAT also contains stromal vascular fraction cells (composed of multiple cell types, including 85 adipocyte progenitors (preadipocytes), and innate and adaptive immune cells) whose number 86 and activation status can change as a function of physiological and pathological conditions, such as obesity<sup>17-20</sup>. As well as being the body's main energy reservoir (triglycerides stored in 87 88 adipocytes), WAT is acknowledged to be a highly active endocrine tissue that secretes numerous metabolites and hormones<sup>18</sup> - some of which (leptin) have immunoregulatory 89 functions<sup>21</sup>. Unlike other organs, WAT is compartmentalized into discrete depots distributed 90 91 throughout the body. The subcutaneous adipose tissue (SCAT) and the visceral adipose tissue 92 are the most frequently defined and studied depots. Importantly, these depots differ markedly 93 in their metabolic and endocrine functions, and in their associations with the development of metabolic diseases<sup>22</sup>. 94

With the exception of the report by Nishimura *et al.* showing that IAV (H5N1) can target
WAT *in vivo*<sup>23</sup>, the impact of influenza infection on the WAT of lean mice has not yet been
investigated. Here, we found that (intranasal) IAV infection (seasonal H3N2 subtype) leads to
profound changes in the major fat depots (namely, the inguinal SCAT and the visceral

99	(epididymal) adipose tissue (EWAT)), some of which are common to SCAT and EWAT
100	while others are unique to the SCAT, such as the appearance of thermogenic brown-like/beige
101	adipocytes. Importantly, viral RNA- and viral protein-harboring immune cells and (less
102	frequently) preadipocytes were detected in the WAT's stromal vascular fraction of infected
103	animals. Using in vitro approaches, we showed that IAV replication is abortive in
104	preadipocytes, and that infection yields brown-like/beige features in these cells, as evidenced
105	by elevated expression of brown-like/beige specific genes. Transcription analyses further
106	revealed that IAV infection was associated with unique metabolic rewiring in the SCAT of
107	infected mice, and in <i>in-vitro</i> -infected preadipocytes. Strikingly, infected mice display
108	alterations in whole-body glucose metabolism that persist long after infection has been
109	resolved.
110	Collectively, our findings may advance our understanding of the ramifications of influenza A
111	infection biology, and may bring novel aspects of metabolic control of the complex virus-host
112	interactions.

#### 125 **Results**

126 Influenza alters adipose tissues' functions C57BL/6 mice were intranasally inoculated with 127 a sublethal dose of H3N2 IAV or with PBS (mock). At 7 days post-infection (7 dpi, corresponding to the peak inflammatory response in the lungs), IAV-infected mice displayed 128 129 significant body weight loss (Fig. 1a) and reduced inguinal (SCAT) and epididymal (EWAT) 130 fat mass (Fig. 1b). It is noteworthy that the mass of SCAT was positively correlated with the 131 mass of EWAT in both mock-treated and IAV-infected animals (Supplementary Fig. 1); this 132 indicates that influenza infection did not lead to major changes in body fat distribution. As an 133 energy storage organ, adipose tissue stores neutral triglycerides through the lipogenic pathway and releases fatty acids through the lipolytic pathway<sup>16</sup>. Lipolysis of triglycerides requires 134 three consecutive steps involving at least three different enzymes: adipose triglyceride lipase 135 (ATGL), hormone-sensitive lipase (HSL), and monoglyceride lipase (MGL)<sup>24</sup>. Influenza 136 137 infection resulted in the marked repression of Atgl and Hsl transcription in SCAT and EWAT. 138 Strikingly, Mgl transcription was suppressed in EWAT but enhanced in SCAT. In both fat 139 depots, infection was associated with decreased expression of lipogenic genes, such as those 140 encoding glucose transporter 4 (*Glut4*), malic enzyme 2 (*Me2*) and fatty acid synthase (*Fasn*) 141 (Fig. 1c). 142 Adipose tissue is composed of several cell types that include mature adipocytes,

preadipocytes, and a range of innate and adaptive immune cells<sup>17-20</sup>. As an endocrine organ, WAT secretes numerous cytokines, metabolites and hormones that originate from all these cell types<sup>18</sup>. By preserving the physiological *in vivo* cross-talk between cells, explant cultures of WAT allow analyzing the secretory function of the whole tissue<sup>25</sup>. We therefore used tissue explant cultures to investigate whether influenza infection was associated with changes in SCAT and EWAT's secretory function (Fig. 1d). When compared with controls, the adipose tissues collected from infected mice produced higher levels of the proinflammatory cytokines

150 IL-1 $\beta$  and IL-6, and of the anti-inflammatory cytokine IL-10. Following IAV infection, the 151 release of leptin - a WAT-derived hormone that regulates feeding behavior, body weight<sup>26</sup>, 152 and innate and adaptive immune responses<sup>21</sup> - was enhanced for SCAT and decreased for 153 EWAT.

Thus, IAV infection was associated with marked changes in metabolic and inflammatory
features of the subcutaneous and visceral adipose tissues. Importantly, infection was
associated with depot-specific modifications in WAT's lipid metabolism and leptin secretion.

158 Influenza induces subcutaneous adipose tissue browning To determine whether SCAT and 159 EWAT undergo qualitative and/or quantitative changes following influenza infection, we 160 performed histologic and histomorphometric analyses at 7 dpi. The EWAT samples from 161 mock-treated and IAV-infected mice had a similar histological appearance: white adipocytes 162 containing large unilocular lipid droplets (a typical WAT histology) (Supplementary Fig. 2a). 163 In contrast, the SCAT samples from mock-treated and IAV-infected mice showed histological 164 differences: numerous pockets of dense, small and multilocular adipocytes - a feature of brown-like adipocytes, also known as beige or brite adipocytes<sup>27</sup> - were found interspersed 165 within the SCAT from infected animals (Fig. 2a). As reported in literature<sup>28</sup>, 166 167 histomorphometric analyses confirmed that adipocytes are smaller in SCAT than EWAT 168 (Supplementary Fig. 2c). In accordance with the appearance of small brown-like/beige 169 adipocytes, the SCAT from IAV-infected mice showed higher numbers of small adipocytes 170 and reduced numbers of large adipocytes than the SCAT from mock-treated mice (Fig. 2b). 171 The differences in adipocyte size between mock-treated and IAV-infected mice were less 172 pronounced for the EWAT (Supplementary Fig. 2b). Moreover, levels of the mitochondrial uncoupling protein 1 (UCP1, a marker of the brown adipose tissue<sup>29</sup>) were higher in SCAT 173 174 protein lysates from infected mice than in those from mock-treated controls. In contrast, no

175 UCP1 was detected in the lungs or EWAT lysates from IAV-infected mice (Fig. 2c, 2d and

176 Supplementary Fig. 2d). In line with increased levels of thermogenic UCP1, the surface

temperature generated from the SCAT was higher in IAV-infected mice than in mock-treatedmice (Fig. 2e).

These results emphasized the depot-specific nature of the effects of influenza infection on fat,
with the appearance of thermogenic brown-like/beige adipocytes in the subcutaneous depot
being the most notable.

183 Transcriptomics shows fat-depot-specific response to influenza To gain insights into the molecular basis of the depot-specific effects of influenza infection on fat tissues, we 184 185 performed transcriptomic analyses on the SCAT and EWAT isolated from mock-treated and 186 IAV-infected mice ( $p \le 0.05$  and fold change (FC) cutoff of  $\ge 2$ ). In SCAT, 1,214 genes were 187 found differentially expressed between mock-treated and IAV-infected mice. In EWAT, 660 188 differentially expressed genes (DEGs) were identified. Venn diagrams were used to display 189 comparison of the lists of upregulated or downregulated DEGs (Fig. 3a). Upon infection, 296 190 genes were upregulated in both SCAT and EWAT, 268 genes were upregulated only in 191 SCAT, and 177 genes were upregulated only in EWAT. Regarding infection-associated 192 downregulated genes, 148 genes were commonly downregulated in SCAT and EWAT, 502 193 genes were downregulated only in SCAT, and 39 were downregulated only in EWAT. Then, 194 canonical pathway analyses of these DEG lists were conducted using Ingenuity Pathways Analysis (IPA). The interferon signaling pathway was identified as the top canonical pathway 195 196 with the highest positive z-score in the list of 296 genes upregulated in SCAT and EWAT, 197 suggesting activation of the pathway in both fat depots during infection (Fig. 3b). For these 198 upregulated genes, IPA predicted potential upstream regulators. The top activated upstream 199 regulators and their targets are listed in Supplementary Table 1. Interestingly, the transcription

factors IRF3 and IRF7 are recognized as key regulators of type I IFN gene expression induced
 by viruses<sup>30</sup>.

202 IPA identification of pathways populated by genes upregulated during infection only in one 203 type of fat depots showed that the Rho-GTPase family signaling pathways were activated in 204 SCAT, and the T-cell-driven-immune/inflammatory pathways were activated in EWAT (yet 205 with relatively modest *p* values and percentages of overlap) (Supplementary Table 2). 206 From the core set of 148 genes that were downregulated during infection in both SCAT and 207 EWAT, IPA ranked multiple pathways linked to cholesterol biosynthesis as being the most 208 significantly associated with infection (Fig. 3c). Concordantly, the top upstream regulators were predicted to be the transcription factors sterol regulatory element binding proteins 209 210 (SREBPs, also called SREBFs) and the endoplasmic reticulum (ER) protein SCAP, all of which are master regulators of cholesterol biosynthesis<sup>31</sup> (Supplementary Table 3). 211 212 Interestingly, transcriptomic data indicated the inhibition of oxidative phosphorylation 213 (OXPHOS), tricarboxylic acid (TCA) cycle and glycolysis during infection only in SCAT 214 (Fig. 3d). Indeed, within the mitochondrial energy metabolic pathways, numerous genes 215 coding for functional/structural components of the electron transport-linked OXPHOS 216 (predominantly in complex I) as well as TCA cycle genes were found to be downregulated in 217 SCAT (Supplementary Fig. 3). Concomitantly, the sirtuin signaling pathway was activated in 218 this fat depot (Fig. 3d). Sirtuins are a group of NAD<sup>+</sup>-dependent protein-deacetylating stress-219 responsive enzymes that regulate glucose and lipid metabolism, inflammation and WAT browning, the latter through deacetylation regulation of pathways upstream of UCP1<sup>32,33</sup>. It is 220 221 noteworthy that opposite regulation directions of the OXPHOS pathway and the sirtuin signaling pathway have been recently reported<sup>34</sup>. 222 223 Overall, these results showed that influenza infection was associated with major

transcriptional changes in fat tissues. In both SCAT and EWAT, interferon signaling

pathways were activated and cholesterol biosynthesis pathways were repressed. Importantly,
infection impacted major metabolic pathways (glycolysis, OXPHOS, TCA cycle) only in
SCAT.

229 Influenza durably alters the host's energy metabolism Adipose tissue is a key metabolic organ in the regulation of whole-body energy homeostasis<sup>16,18</sup>. Thus, we looked at whether 230 influenza infection impacted on the host systemic metabolism. At 7 dpi, blood glucose levels 231 232 were lower in IAV-infected mice than in mock-treated controls, whereas insulin levels were 233 higher. Blood levels of resistin - originally described as a WAT-derived hormone modulating insulin resistance in rodents<sup>35</sup> - were lower in infected animals than in controls (Fig. 4a). 234 235 Remarkably, these changes in blood glucose, insulin and resistin levels persisted long after the 236 infection had resolved (up to 20 weeks post-infection) (Fig. 4b). However, these long-lasting 237 metabolic sequelae had no impact on the animals' glucose tolerance, as revealed by an 238 intraperitoneal glucose tolerance test (Supplementary Fig. 4a). 239 Studies in various rodent models have shown that white-to-brown adipose tissue remodeling prevents high-fat-diet (HFD)-induced obesity<sup>27,36</sup>. Hence, we hypothesized that IAV-infected 240 241 mice would be protected against obesity. Mock-treated and IAV-infected mice were fed an 242 HFD from 7 dpi (the time when SCAT browning became apparent). As expected, mock-243 treated mice fed an HFD (mock HFD) gained more weight than mock-treated mice fed a 244 standard diet (mock SD). Although IAV-infected mice fed an HFD (IAV HFD) gained less 245 weight than mock-treated mice fed an HFD (mock HFD), they still gained more weight than 246 when fed a standard diet (IAV SD) (Fig. 4c, and Supplementary Fig. 4b for the corresponding 247 area under the curve (AUC)). Accordingly, IAV-infected mice were not protected against 248 HFD-induced glucose intolerance (Fig. 4d, and Supplementary Fig. 4c for the corresponding 249 area under the curve (AUC)). However, it is noteworthy that HFD-fed IAV-infected animals

showed lower levels of blood glucose and resistin than HFD-fed mock-treated mice (Fig. 4e),
as was observed at 7 dpi and 20 weeks post-infection under standard diet conditions (see Fig.
4a, 4b).

These results indicated that influenza infection has a long-lasting impact on whole-body glucose metabolism that is independent of the host's dietary status (it occurred in lean and obese conditions).

257 Viral protein-expressing cells are detected in adipose tissues Next, we sought to quantify 258 viral RNA in the adipose tissues from IAV-infected mice (M1 negative strand specific qPCR 259 assay). Albeit at lower levels than in the lungs, viral RNA was detected in SCAT and EWAT 260 (but not in pancreas) at 7 dpi (Fig. 5a). To get some insight into the dynamics of viral RNA 261 accumulation, viral RNA levels were quantified in the lungs, SCAT and EWAT at 2, 4, 7, 14 262 and 28 dpi (Fig. 5b). In the lungs, the viral load rapidly increased from 2 dpi, peaked at 7 dpi, 263 and rapidly declined thereafter. In SCAT and EWAT, we also observed a time-dependency of 264 viral RNA accumulation, which started from 2 dpi, culminated at 7 dpi and decreased 265 afterwards, as noticed in the lungs.

WAT's cellularity is highly heterogenous<sup>18-20,22</sup>. Mature, lipid-filled adipocytes make up 266 267 approximately 30% of adipose tissue cells. The remaining stromal vascular fraction (SVF) 268 cells include vascular cells, fibroblasts, innate and adaptive immune cells, and adipocyte 269 precursor cells (preadipocytes). We therefore separated mature adipocytes from SVF cells 270 through enzymatic fractionation of the SCAT and EWAT from mock-treated and IAV-271 infected mice (Fig. 5c). As shown in Supplementary Fig. 5a, viral RNA was detected in SVF 272 cells isolated from SCAT and EWAT. No viral RNA was detected in adipocytes isolated from either fat depot. Thus, immune cells (identified as CD45<sup>+</sup> cells) and preadipocytes (identified 273 274 as CD45<sup>-</sup> CD31<sup>-</sup> CD29<sup>+</sup> CD34<sup>+</sup> Sca1<sup>+</sup> cells) from the SVF of the SCAT and EWAT from

mock-treated and IAV-infected mice were sorted by fluorescent-activated cell sorting (FACS)
(see gating strategy Supplementary Fig. 5b) and stained for the viral protein hemagglutinin
(HA) (Fig. 5d). HA-positive immune cells were found in the SCAT of nearly (84%) all
infected mice, a frequency that was much lower in the EWAT (17%). Half of infected mice
had HA-positive preadipocytes in the SCAT, while none were detected in any of the EWAT
samples.

Thus, immune cells and (less frequently) preadipocytes bearing viral RNA (M1) and viral protein (HA) were detected in the adipose tissues (mostly in SCAT) of influenza-infected mice. In contrast, no adipocytes bearing viral RNA were found in either fat depot.

284

285 Influenza induces brown-like adipogenesis in preadipocytes Preadipocytes share numerous phenotypic and functional properties with macrophages<sup>37</sup>. IAV replication in macrophages is 286 287 most often abortive (no release of new infectious virions), yet certain virus strains can replicate productively in these cells<sup>38,39</sup>. Thus, the detection of HA-positive preadipocytes in 288 289 the WAT from infected mice (see Fig. 5d) led us to question the IAV-infection ability of 290 murine preadipocytes in vitro. We used mouse preadipocyte 3T3-L1 cells, which can differentiate into adipocytes upon induction with a standard hormone cocktail<sup>40</sup>. Hence, 291 292 undifferentiated 3T3-L1 cells (from now on referred to as preadipocytes) were exposed to 293 graded doses of IAV (at MOI of 0.01, 0.25, 0.5, 1 or 2) and viral RNA levels were evaluated 294 at 6, 24 and 48 hours post-infection (hpi). As shown in Fig. 6a, viral RNA levels rose from 6 295 to 24 hpi at each MOI; this suggested efficient IAV infection and viral genome replication in 296 preadipocytes. It is noteworthy that infection did not affect the viability of preadipocytes, in 297 contrast to highly permissive Madin-Darby Canin Kidney (MDCK) cells (Supplementary Fig. 298 **6**a).

299 Unlike most RNA viruses, IAVs transcribe and replicate their genome inside the nucleus; this induces major nuclear and nucleolar ultrastructural changes<sup>41</sup>. As shown in Fig. 6b, high-300 301 resolution transmission electron microscopy revealed the marked accumulation of viral M1-302 associated rod-like tubular structures in the nucleus, and the complete segregation of nucleolar 303 components in infected preadipocytes (MOI of 5, at 24 hpi), relative to mock-treated cells. In 304 addition, the particles budding from the preadipocytes' plasma membranes appeared to be 305 empty (Fig. 6b). Consistently, no infectious particles were detected in the supernatants of 306 infected preadipocytes while fully infectious virions were released from infected murine lung 307 epithelial cells (MLE-15 cells) (MOI of 0.5, at 6, 24, 48 and 72 hpi) (Supplementary Fig. 6b). 308 We next sought to determine preadipocytes' response to infection (MOI of 1, at 24 hpi) by 309 quantifying the expression of the antiviral innate-immune-related genes Tlr3 (coding for Toll-310 like receptor 3), RigI (coding for retinoic acid-inducible protein I), Mda5 (coding for 311 melanoma-differentiation associated protein 5), Mx1 (coding for Mx1) and Vip (coding for 312 viperin) (Fig. 6c). Relative to mock-treated cells, the expression of these genes was enhanced 313 in infected preadipocytes. It is worth mentioning that *in vitro* infection of preadipocytes at 314 much lower MOI (0.01) also led to increased Tlr3, RigI, Mda5, Mx1 and Vip transcript levels 315 (Supplementary Fig. 6c). 316 Importantly, infection enhanced the expression of genes involved in the browning process, 317 such as Ucp1, Pgc1a (coding for peroxisome proliferator-activated receptor gamma 318 coactivator 1 alpha), Fgf21 (coding for fibroblast growth factor 21), Apln (coding for apelin), 319 Metrnl (coding for meteorin-like protein) and Tmem26 (coding for transmembrane protein 26)<sup>42-45</sup> in preadipocytes (MOI of 1, at 24, 48 and 72 hpi) (Fig. 6d). Accordingly, adipocytes 320 321 that had differentiated in vitro from IAV-infected preadipocytes had higher Ucp1 and Pgc1a 322 transcript levels than adipocytes that had differentiated from mock-treated preadipocytes 323 (Supplementary Fig. 6d).

324 Although no viral RNA-harboring adipocytes were detected in either fat depots from IAV-325 infected mice, previous literature reported that adipocytes might be permissive to IAV infection *in vitro*<sup>46,47</sup>. Thus, differentiated 3T3-L1 preadipocytes (from now on referred to as 326 327 adipocytes) were infected with IAV, in vitro. As shown in Supplementary Fig. 7, infection 328 had no impact on adipocytes' viability (Supplementary Fig. 7a), and resulted in increased 329 levels of viral RNA (Supplementary Fig. 7b), nuclear and nucleolar changes featuring 330 efficient viral genome replication, and budding of empty particles (Supplementary Fig. 7c), as 331 well as increased expression of the antiviral innate-immune-related genes Tlr3, RigI, Mda5, 332 Mx1 and Vip (Supplementary Fig. 7d). As opposed to preadipocytes (see Fig. 6d), IAV 333 infection of adipocytes did not increase the expression of the browning-like/beiging-related 334 genes Ucp1, Pgc1a, Fgf21, Apln, Metrnl and Tmem26 (Supplementary Fig. 7e). 335 Importantly, *in vitro* IAV infection of human primary preadipocytes (MOI of 1, 48 hpi) 336 significantly increased the expression of the browning-like/beiging-related genes Ucp1, Prdm16 (coding for PR domain containing 16), Tmem26 and Tbx15 (coding for T-Box15). As 337 338 observed with mouse cells, infection of human adipocytes (differentiated from human primary 339 preadipocytes) did not increase the expression of these genes (with the exception of *Ucp1*) 340 (Supplementary Fig. 7f). 341 These data showed that preadipocytes and adipocytes are permissive to *in vitro* IAV infection; 342 however, virus replication is abortive. Most importantly, in vitro infection induced the

- 343 commitment of preadipocytes to brown-like/beige adipocytes, and not the white-to-beige
- 344 conversion of mature adipocytes.

346 Influenza induces metabolic reprogramming of preadipocytes A comparative analysis of
347 the transcriptomes of *in vitro* mock-treated and IAV-infected (MOI of 1, at 24 hpi)

348 preadipocytes (3T3-L1 cells) and adipocytes (differentiated from 3T3-L1 cells) showed that

349 more genes were up- or down-regulated following infection in preadipocytes than in 350 adipocytes (1,472 genes vs. 585 genes, respectively), and that more genes were upregulated 351 than downregulated in both cell types (981 upregulated genes vs. 491 downregulated genes in preadipocytes, and 566 upregulated genes vs. 19 downregulated genes in adipocytes) (Fig. 352 353 7a). IPA analyses revealed that the 449 genes that were upregulated upon infection both in 354 preadipocytes and adipocytes were related to pathways endowed with interferon signaling, 355 virus sensing and antiviral immune response (Supplementary Table 4). 356 The 117 genes that were only upregulated in adipocytes were related to stress-signaling 357 pathways, yet with rather low *p* values and overlap percentages (Supplementary Table 5). 358 Strikingly, for the 532 genes exclusively upregulated in preadipocytes, the top-scored 359 canonical pathways were the serine-glycine biosynthesis, folate transformations (such as 360 polyglutamylation), and glycine biosynthesis, pathways (Supplementary Table 6). These 361 metabolic processes are connected by the serine-glycine-one-carbon (SGOC) pathway; an offshoot of glycolysis<sup>48</sup>. Indeed, the IAV-infection-gene-signature in preadipocytes includes 362 363 several genes encoding enzymes within the SGOC pathway, such as the cytosolic 364 phosphoglycerate dehydrogenase (PHGDH), phosphoserine phosphatase (PSPH) and serine 365 hydroxymethyltransferase (SHMT) 1, and the mitochondrial SHMT2, methylenetetrahydrofolate dehydrogenase (NADP<sup>+</sup> dependent) 1 like (MTHFD1L) and 366 367 MTHFD2 (Fig. 7b). It is worth mentioning that the upregulation of several enzymes involved in SGOC metabolism has been recently reported for IAV-infected macrophages<sup>49</sup>. The 368 369 upstream regulators predicted to be associated with the genes exclusively upregulated in 370 preadipocytes included activating transcription factor 4 (ATF4), UCP1 and MYC 371 (Supplementary Table 6). ATF4 and MYC form a positive feedback loop for transcriptional activation of the SGOC pathway<sup>50</sup>, and UCP1 was reported to induce Atf4 expression<sup>51</sup>. 372

The SGOC metabolism generates diverse outputs, such as the synthesis of lipids, nucleotides, 373 ATP and proteins<sup>48</sup>, suggesting that the infected preadipocytes' translational machinery might 374 375 have been activated. Indeed, tRNA charging was also identified as a top-ranked canonical 376 pathway activated in infected preadipocytes (Supplementary Table 6). Concordantly, the 377 mRNA expression levels of genes related to ribosome biogenesis (Urb2, coding for unhealthy 378 ribosome biogenesis protein 2, Wdr75, coding for WD repeat domain 75, Zfp593, coding for 379 zinc finger protein 593, Mrto4, coding for MRT4 homolog, ribosome maturation factor and 380 Nop58, coding for nucleolar protein 58) were enhanced upon *in vitro* infection in 381 preadipocytes and not in adipocytes (Fig. 7c). 382 Only a small number of genes were downregulated in adipocytes alone (n = 13) or in both 383 preadipocytes and adipocytes (n = 6); no biological functions or pathways could therefore be 384 assigned. In preadipocytes, pathways related to amino acid catabolism and cholesterol 385 biosynthesis were found to be downregulated upon infection, yet with modest p values and 386 overlap percentages (Supplementary Table 7). 387 Altogether, transcriptome analyses suggested activation of the interferon-dependent antiviral 388 response in both preadipocytes and adipocytes upon in vitro infection, and illuminated 389 intrinsic differences between the two types of cells. Indeed, preadipocytes dealt with infection 390 by acquiring a metabolic program mainly characterized by the transcriptional activation of the 391 SGOC metabolic pathway. 392

Influenza changes mitochondrial bioenergetics of adipose cells It has been reported that
IAV infection decreases host cell's respiration<sup>52</sup>. We above showed that *in vitro* IAV infection
of preadipocytes induced their commitment to brown-like/beige adipocytes, increased the
expression of genes involved in the SGOC metabolic pathway, and was associated with the
elevated expression of genes involved in ribosome biogenesis - all processes known to impact

#### 423 **Discussion**

424 Persistent, chronic infections by viruses, parasites or bacteria often lead to metabolic

425 anomalies due to the functionality impairment of metabolic tissues or organs such as the liver, 426 skeletal muscle, pancreas, brain and WAT<sup>56</sup>. Lymphocytic choriomeningitis virus, human and 427 simian immunodeficiency viruses, adenovirus, vaccinia virus, and several species of parasites 428 and bacteria have been reported to target murine and human WAT directly<sup>57-61</sup>. In contrast, it 429 is not clear whether acute infections also result in long-lasting metabolic changes - notably by 430 altering WAT's functions. This is a compelling question, given the frequency and diversity of 431 the acute infections with which modern societies are burdened.

432 Here, we report that a single acute (intranasal) infection with a respiratory pathogen (seasonal 433 influenza A virus subtype H3N2) profoundly modifies WAT's metabolic and immune 434 functions, in mice. Transcriptome analyses of the subcutaneous and visceral fat depots in 435 response to influenza infection (Fig. 8a) revealed the activation of type I interferon signaling 436 pathways associated with the concomitant inhibition of cholesterol biosynthesis pathways 437 both in SCAT and EWAT. The reciprocal negative crosstalk between antiviral type I IFN responses and cholesterol homeostasis is increasingly being recognized<sup>62</sup>. Reconfiguring 438 439 cholesterol metabolism is now considered as an integral component of the host's response to infection both through heightening antiviral immunity<sup>63,64</sup>, and creating an unfavorable 440 environment for virus stability and infectivity<sup>65</sup>. Interestingly, the transcriptional response to 441 442 infection also differed according to the localization of fat depots. Indeed, pathways related to 443 energy metabolism were altered upon infection only in SCAT: the glycolysis, TCA cycle and OXPHOS metabolic pathways were repressed, while the sirtuin signaling pathway was 444 445 activated. The mammalian sirtuin (SirT) family is categorized as stress-induced-NAD<sup>+</sup>-446 dependent protein deacetylases that regulate processes such as energy metabolism and 447 inflammation<sup>32</sup>. Several SirT family members have been reported to promote WAT lipolysis<sup>66</sup>

and WAT browning<sup>67</sup>, two processes that are closely linked<sup>68</sup>. In accordance with SirT 448 449 signaling pathway activation, Mgl expression level was increased and brown-like/beige 450 adipocytes were observed in the SCAT from infected mice; this suggested increased lipolysis<sup>69</sup> and thermogenesis. Indeed, expression of the thermogenic UCP1 protein was 451 452 increased in SCAT upon infection, and this correlated with elevated surface temperature, as expected from literature<sup>70</sup>. 453

454 In rodents, SCAT (less frequently EWAT) is readily able to convert to a brown-like state in 455 response to environmental stimuli including chronic cold adaptation, exercise and nutritional 456 challenges; as well as external and internal cues such as pharmacological treatment with  $\beta$ 3adrenergic receptor agonists and various peptides and hormones<sup>71</sup>. Leptin (which secretion is 457 458 enhanced in the SCAT upon infection) and insulin (which blood level is increased in infected mice) have been reported to promote WAT browning<sup>72</sup>. Influenza infection may also have 459 460 favored the accumulation of immune cells associated with WAT browning, such as M2 macrophages, eosinophils or innate lymphoid type 2 cells<sup>73</sup>, in the SCAT. 461 462 Strikingly, we found that immune cells harboring viral proteins (HA) were present in the WAT (mostly SCAT) of influenza-infected mice. Immune cell egress from the lungs has been 463 reported in the context of influenza infection<sup>74,75</sup>. Thus, immune cells (either infected or 464 465 harboring remnant viral antigens and RNA) may have entered the bloodstream through the 466 capillaries of damaged alveolar wall of the infected lungs and reached fat depots, participating 467 to the observed changes in WAT's secretory function and to the induction of antiviral-innate-468 immunity-related pathways. The phenotypic characterization of immune cells that are present 469 in the fat depots of IAV-infected mice is currently under investigation. 470

Alongside immune cells, viral antigen-positive preadipocytes were also found, although less

471 frequently, in the WAT from infected mice. How preadipocytes acquired viral antigens from

472 immune cells that have migrated from infected lungs to WAT, remains to be established. Also, determining whether other WAT's cell types are impacted during influenza infection
should be investigated since WAT's functionality result from the concerted interplay between
all these cells. Single-cell RNA sequencing combined with flow cytometry or mass cytometry
(CyTOF) could help answer this key question<sup>76</sup>.

Using *in vitro* approaches (Fig. 8b), we showed that preadipocytes - that share many
properties with macrophages<sup>37</sup> - are permissive to IAV infection, yet replication was abortive.
Importantly, infection induced the browning-like/beiging program in preadipocytes and this
was associated with the activation of the folate-dependent SGOC pathway, an offshoot of
glycolysis<sup>48</sup> recently reported to drive effector responses to IAV infection in macrophages<sup>49</sup>.

The impact of acute infections on the metabolism of the affected hosts has been rather set aside. Here, we reported a systemic response to influenza infection that modulates WAT's metabolic and immune functions. Importantly, infection was also associated with changes of host's metabolism that persist long after infection has been resolved. Altogether, these findings illustrate the complexity of influenza virus-host interactions, in which the adipose tissue may play an important role.

#### 498 Methods

#### 499 Mice, virus and *in vivo* infection protocol

- 500 Male C57BL/6JRj mice (6-week-old; Janvier Labs, Le Genest-Saint-Isle, France) were
- 501 housed and manipulated in an Animal Biosafety Level-2 facility, in strict accordance with
- 502 *Institut Pasteur*'s guidelines on animal care and use, and in compliance with European animal
- 503 welfare regulations (European Communities Council Directive of 1986 revised in 2010,
- 504 2010/63/EU). Protocols were approved by the regional Animal Experimentation Ethics
- 505 Committee (Comité d'Ethique en Expérimentation Animale, Hauts-de-France, CEEA 75) and
- 506 the French Ministry of Higher Education and Research (Ministère de l'Enseignement
- 507 Supérieur et de la Recherche) (authorization numbers: 00357.03 and 00033.02). Mice were
- 508 fed *ad libitum* with low-fat diet (LFD: 10% kcal from fat) or, when mentioned, with high-fat
- 509 diet (HFD: 60% kcal from fat) obtained from Research Diets (New Brunswick, NJ, USA).
- 510 The human-derived, mouse-adapted influenza A/Scotland/20/1974 (H3N2) virus was grown,
- 511 isolated and titrated in Madin-Darby Canine Kidney (MDCK) cells.
- 512 Mice were administrated intranasally with a sublethal dose (30 PFU, in 50 µl PBS) of H3N2
- 513 (IAV groups) or with PBS (mock groups). Body weights were monitored. Intraperitoneal
- 514 glucose tolerance tests and infrared thermography measurements were performed. Blood,
- 515 lungs, subcutaneous (inguinal) and visceral (epididymal) white adipose tissue depots (SCAT
- 516 and EWAT, respectively) were collected and weighed. SCAT and EWAT explants were
- 517 cultured for 16-24 hours for hormone and cytokine detection in culture supernatants by
- 518 ELISA. White adipose tissues were processed for further histological, flow cytometry,
- 519 Western blot or gene expression analyses.

520

# 521 In vivo assessment of metabolic phenotyping

522 For determination of intraperitoneal glucose tolerance, mice were fasted for 10-12 hours before being injected (intraperitoneally) with 1g/kg body weight of D-Glucose (Sigma-523 524 Aldrich, Saint-Louis, Missouri, USA). Glucose levels were measured by tail-tip bleeding with an automatic glucometer (ACCU-CHEK Performa, Roche, Mannheim, Germany) before 525 526 injection, and 15, 30, 60, 120 and 180 minutes after glucose administration. 527 For infrared thermography, an infrared camera (FLiR systems) was used to acquire static 528 images of the SCAT region of unrestrained, anesthetized mock-treated and IAV-infected 529 mice, 7 dpi, n = 3 mock-treated animals and n = 4 IAV-infected animals (3 measurements per mouse), as described in Crane *et al.*<sup>77</sup>. 530

531

# 532 Ex vivo mouse adipose tissue explant cultures

533 SCAT and EWAT samples were isolated from mock-treated and IAV-infected mice (7 dpi), and cultured as described in Thalmann *et al*<sup>25</sup>. Tissue explants were put into 6-well plates 534 535 (~50 mg/well) (Sarstedt, Nümbrecht, Germany) and incubated for 24 hours in DMEM without 536 serum and supplemented with 1% penicillin/streptomycin (Life Technologies, CA, USA) in a 537 humidified 37°C, 5% CO<sub>2</sub> incubator. After the incubation period, the medium was aspired 538 from the floating fat and centrifuge for 5 minutes at 500 g at room temperature to remove any 539 excess lipids or debris. The resultant explant culture supernatants were stored at -80°C until 540 further analysis.

541

# 542 Mouse adipose tissue histology and histomorphometry

543 SCAT and EWAT were harvested from mock-treated and IAV-infected mice, at 7 dpi. After

- overnight fixation in 4% paraformaldehyde, tissue samples were embedded in paraffin.
- 545 Multiple sections (5 µm) were de-paraffinized, rehydrated, and stained with hematoxylin and
- 546 eosin (H&E). For evaluation of adipocyte number and size by morphometry, at least 10 fields

547 per H&E-stained slide were visualized and images were digitally captured using a digital

548 camera (AxioCam HRc, Zeiss, Göttingen, Germany) connected to an optical microscope

549 (Axioplan 2 Imaging, Zeiss). Adipocyte area (in  $\mu$ m<sup>2</sup>) was measured using an in-house macro

specifically developed for automated image analysis of WAT on the Fiji-ImageJ software

551 (NIH).

552

# 553 Cell fractionation of mouse adipose tissue

Individual SCAT and EWAT were carefully excised from mock-treated and IAV-infected 554 mice at 7 dpi. Tissues were thoroughly minced with scissors (1-2 mm<sup>3</sup> pieces) and digested in 555 556 collagenase I (1 mg/ml, Sigma-Aldrich) for 1 hour at 37°C with gentle shaking by inversion 557 every 20 minutes. Digested tissues were then passed through a 250 µm nylon filter and 558 centrifuged at 150 g for 17 minutes at room temperature (RT). The floating fraction -559 containing intact, purified mature adipocytes with minimal stromal cell contamination (see 560 Supplementary Fig. 5c) - were carefully recovered with a wide opening plastic transfer pipette 561 and processed for further gene expression analyses. Remaining infranatants were centrifuged 562 at 400 g for 5 minutes, RT. The erythrocytes from the SVF cell-pellets were lysed with cold 563 lysis buffer (3 minutes, on ice) and SVF cells were filtered through a 90 µm and then a 40 µm 564 nvlon filter before being washed twice by centrifugation at 400 g for 5 minutes, RT. SVF cells 565 were counted and resuspended in PBS 0.5% BSA for further flow cytometry sorting.

566

# 567 Identification and sorting of cells from mouse adipose tissue

568 SVF cell suspensions were first incubated with an Fc blocking reagent (anti-mouse

569 CD16/CD32, clone 2.4G2, BD Pharmingen, San Jose, CA, USA). Afterward, cells were

570 stained with anti-mouse CD31 (BV421, clone 390), CD45 (BV510, clone 30-F11), CD34

571 (PE, clone HM34), CD29 (AF700, clone HMβ1-1) from BioLegend, and Sca-1 (APC-Cy7,

clone D7) from eBioscience, at a dilution of 1:100. Samples were then directly run into the BD Influx<sup>TM</sup> cell sorter (BD Biosciences) equipped with a 86  $\mu$ m nozzle and tuned at a pressure of 24.6 psi and a frequency of 48.25 kHz. Sample fluid pressure was adjusted to reach a throughput rate of 10,000 events per second. Immune cells and preadipocytes were selected as CD45<sup>+</sup> and CD45<sup>-</sup> CD31<sup>-</sup> CD34<sup>+</sup> CD29<sup>+</sup> Sca-1<sup>+</sup>, respectively. The gating strategy is shown on Supplementary Fig. 5b.

#### 579 In vitro differentiation of preadipocytes, and infection procedure

The mouse 3T3-L1 preadipose cell-line (ATCC<sup>®</sup>, CL-173<sup>TM</sup>) was used. 3T3-L1 cells were 580 cultured in Dulbecco's modified Eagle's medium (DMEM), high glucose, GlutaMAX<sup>TM</sup> 581 582 (Gibco, ThermoFisher Scientific, Waltham, M.A., USA) supplemented with 10% heat-583 inactivated fetal bovine serum (FBS) (Gibco) and 1% penicillin/streptomycin in a humidified 584 37°C, 5% CO<sub>2</sub> incubator. The differentiation of 3T3-L1 cells into mature adipocytes was conducted as indicated in<sup>40</sup>: 3T3-L1 preadipose cells were seeded in 6-well plates (Sarstedt) at 585 a density of  $4 \times 10^5$  cells per well, in 2 ml of culture medium. Two days after reaching 586 587 confluence, cells were incubated in the differentiation medium containing 1µg/ml insulin 588 (Sigma-Aldrich, Saint-Louis, Missouri, USA), 0.25µM dexamethasone (Sigma-Aldrich) and 589 0.5mM 3-isobutyl-1-methylxanthine (IBMX) (Sigma-Aldrich) for two days. The medium was 590 then replaced by the maintenance medium that consists of DMEM supplemented with 10% 591 FBS, 1% penicillin/streptomycin and 1µg/ml insulin. The maintenance medium was renewed 592 every two or three days. 593 Human primary preadipocytes were purchased from Lonza (Basel, Switzerland) together with 594 the differentiation kit and the culture medium. Preadipocytes were induced to differentiate

595 into fully mature adipocytes according to manufacturer's instructions.

596 Mouse or human preadipocytes and adipocytes  $(4x10^5)$  were infected with IAV at 0.01, 0.25,

597 0.5, 1, 2 or 5 multiplicities of infection (MOIs), as indicated. Mock-treated cells were used as

598 controls. Cell viability was determined using the Orangu<sup>TM</sup> colorimetric assay (Cell Guidance

599 Systems, Cambridge, UK). Supernatants were collected for quantification of released

600 infectious particles by using the plaque-forming assay on MDCK cells. Cells were used for

601 Western blot, transmission electron microscopy, immunostaining, or gene expression

analyses.

603

# 604 High-resolution respirometry on mouse adipose cells

605 Oxygen consumption rates (OCRs) of IAV-infected (MOI of 1) and mock-treated

606 preadipocytes and adipocytes ( $10^6$  cells), were determined using high-resolution respirometry

607 (Oxygraph-2k, OROBOROS Instruments, Innsbruck, Austria) at 24, 48 and 72 hours post-

608 infection (hpi). Experiments were performed under controlled temperature (37°C) and stirring
609 (750 rpm).

610 OCRs were measured under baseline conditions (recording resting respiration) and in

611 response to, successively, 2 μg/ml oligomycin (ATP synthase inhibitor; recording proton leak

612 respiration,  $H^+$  Leak), pulses of 0.5  $\mu$ M carbonyl cyanide *m*-chlorophenylhydrazone (CCCP)

613 (mitochondrial uncoupler; recording maximal respiration) and 2.5 µM antimycin A

614 (mitochondrial chain complex III inhibitor; recording residual respiration). Data acquisition

and analyses were performed with DatLab 4 software (OROBOROS Instruments).

# 617 Western blotting

618 Tissues (lungs, SCAT and EWAT) were homogenized in lysis buffer supplemented with

619 protease inhibitors (cOmplete<sup>TM</sup> Protease Inhibitor Cocktail, Sigma-Aldrich). Whole tissue

620 protein extracts (40-50 μg) were fractionated by 10% SDS-PAGE and transferred onto

polyvinylidene difluoride membranes using a transfer apparatus as per the manufacturer's
instructions (Life Technologies). Membranes were blocked with 5% Bovine Serum Albumin
(BSA) in PBS/0.1% Tween for 1 hour, washed and probed overnight at 4°C with polyclonal

antibody against UCP1 (1:500) (Abcam, Cambridge, UK). Membranes were washed and

625 incubated with horseradish peroxidase-conjugated goat anti-rabbit antibody (KPL, Milford,

626 MA, USA) for 2 hours. After three washings, blots were developed with the ECL system

627 (Bio-Rad Laboratories) according to the provided protocol. GAPDH (Santa Cruz

628 Biotechnology, Dallas, Tx, USA) was used as protein loading control.

629

# 630 Transmission electron microscopy

631 In vitro mock-treated and IAV-infected (MOI of 5) mouse preadipocytes and adipocytes

632 (5.10<sup>6</sup>) were fixed in 4% glutaraldehyde for 15 minutes at 4°C and post-fixed in cacodylate

633 (0.2 M, pH 7.4)/4% glutaraldehyde (1:1) for 30 minutes at 4°C. Cell pellets were embedded in

634 EPON<sup>TM</sup> resin (Sigma-Aldrich) that was allowed to polymerize at 60°C for 48 hours.

635 Ultrathin sections were cut, stained with 5% uranyl acetate and 5% citrate and deposited onto

636 gold electron microscopy grids for examination using a JEOL 1011 transmission electron

637 microscope (JEOL Ltd., Tokyo, Japan).

638

## 639 Immunofluorescence using confocal microscopy

640 Immune cells and preadipocytes sorted from the SCAT and EWAT of mock-treated and IAV-

641 infected mice (7 dpi) were fixed in 4% paraformaldehyde for 15 minutes at room temperature

642 (RT), carefully washed with PBS/0.1% Tween-20, and permeabilized with 0.1% Triton X-

- 643 100. After a blocking step with PBS/1% BSA (1 hour, RT), cells were overnight (4°C)
- 644 labelled with the anti-H3N2 hemagglutinin (HA) polyclonal antibody (ThermoFisher
- 645 Scientific, Waltham, MA, USA) before being incubated (1 hour, RT) with the secondary

- 646 antibody (goat anti-rabbit Alexa Fluor<sup>®</sup> 488-labeled, Invitrogen), at concentration
- 647 recommended by the suppliers. Nuclei were then stained with DAPI (ThermoFisher
- 648 Scientific) and coverslips and slides were assembled using a mounting medium (ProLong<sup>®</sup>
- 649 Gold Antifade Mountant, ThermoFisher Scientific). Preparations were observed on a confocal
- 650 laser microscope (Zeiss LSM 880, Oberkochen, Germany).
- 651

# 652 Gene expression quantification by real-time RT-PCR

653 Total RNAs were extracted from snap-frozen tissues (SCAT, EWAT and lungs), from the

654 stromal vascular and adipocyte fractions isolated from adipose tissues, or from *in vitro* 

- 655 cultured murine or human preadipocytes and adipocytes, according to the protocol supplied
- 656 with the RNeasy Lipid Tissue mini-kit (Qiagen, Hilden, Germany).
- 657 For RT-PCR amplification of all genes except the gene encoding the viral protein M1, RT
- 658 was performed with the High-capacity RNA-to-cDNA kit (Applied Biosystems, Foster City,
- 659 CA, USA) with oligo(dT)<sub>16</sub> primers and PCR was performed with the Power SYBR Green
- 660 PCR Master Mix (Applied Biosystems) using the QuantStudio<sup>TM</sup> 12K Flex Real-Time PCR
- 661 System (Applied Biosystems). Reactions were run in duplicate and the geometric mean of the
- housekeeping gene *Eef2* transcript levels was used as internal control to normalize the
- 663 variability in expression levels. Expression data were analyzed using the  $2^{-\Delta\Delta Ct}$  method.
- 664 For quantification of viral RNA, a negative strand specific RT-qPCR assay for IAV RNA
- 665 encoding the *M1* gene (segment 7) was performed. Total RNAs were treated with RNAse
- 666 OUT (Invitrogen) and reverse-transcribed with SuperScript<sup>®</sup> II Reverse Transcriptase
- 667 (Invitrogen) using primer specific for *M1* (5'-TCT AAC CGA GGT CGA AAC GTA-3').
- 668 PCR was performed with TaqMan Universal PCR Master Mix (Applied Biosystems),
- detection primer pairs for M1 (sense: 5'-AAG ACC AAT CCT GTC ACC TCT GA-3'; anti-
- 670 sense: 5'-CAA AGC GTC TAC GCT GCA GTC C-3') and *M1* specific TaqMan probe

671 ((FAM)5'-TTT GTG TTC ACG CTC ACC GTG CC-3'(TAMRA)), using the QuantStudio<sup>TM</sup>

672 12K Flex Real-Time PCR System (Applied Biosystems).

# 674 Whole-genome transcriptomics of adipose cells and tissues

675 To prevent DNA contamination, RNAs extracted from adipose cells and tissues were treated

676 with DNAse. The isolated RNAs were then dissolved in RNAse-free water, after which the

677 concentration of total RNAs was measured and the quality was assessed for further

678 microarray expression analyses. The transcriptional profilings of mock-treated vs. IAV-

679 infected adipose cells and tissues were performed using Agilent's SurePrint G3 Mouse Gene

680 Expression v2 8x60K Microarray kits (Agilent Technologies, Santa Clara, CA, USA),

681 according to manufacturer's instructions.

682 The microarray analysis of *in vitro* mock-treated and IAV-infected mouse preadipocytes and

adipocytes (MOI of 1, 24 hpi) was performed at the *Centre de Ressources Biologiques pour la* 

684 Génomique des Animaux Domestiques et d'Intérêt Economique (CRB GADIE), INRA Jouy-

685 en-Josas Research Center, France. Separate microarrays were run for each experimental

686 sample (one sample per culture condition, four independent experiments). A single-color

687 design was used to provide two types of comparisons: [mock-treated preadipocytes vs. IAV-

688 infected preadipocytes] and [mock-treated mature adipocytes vs. IAV-infected mature

adipocytes]. Identification of differentially expressed genes and functional investigation were

done using GeneSpring software (Version 14.8, Agilent Technologies). Differentially

691 expressed genes were identified using a moderated T-test. A Benjamini-Hochberg False

692 Discover Rate (FDR) was then used as multiple testing correction method and a corrected *p*-

693 value cutoff of 1% was applied. A fold-change >2 cutoff was then added to select for the

694 differentially expressed genes between the mock and infected conditions.

695 The microarray analysis of adipose tissues (SCAT and EWAT) of mock-treated and IAV-696 infected mice (30 PFU, 7 dpi) was performed at the Institut Pasteur's platform of 697 Transcriptomics and Applied Genomics. Separate microarrays were run for each experimental 698 sample (2 experimental groups, 4 mice per group, 2 tissues per mouse). After hybridization, 699 slides were scanned on a SureScan Microarray scanner (Agilent Technologies) and further 700 processed using Feature extraction v10.7.3.1 software. The resulting text files were uploaded 701 into language R v3.5.1 for LIMMA (Linear Model for Microarray Data) differential 702 expression analysis. A within-array normalization was performed using LOWESS (locally 703 weighed linear regression) to correct for dye and spatial effects. Moderated T-statistic with 704 empirical Bayes shrinkage of the standard errors was then used to determine significantly 705 modulated genes. Statistics were corrected for multiple testing using a FDR approach. 706 For functional analyses, Gene Ontology categories (www.geneontology.org) and Ingenuity 707 Pathway Analyses (IPA, www.qiagen.com/ingenuity, Ingenuity Systems, Inc. Redwood City, 708 CA, USA) were performed on the lists of commonly or exclusively differentially up- or 709 down- regulated genes.

710

#### 711 ELISA

712 Insulin levels were quantified using an Ultrasensitive Mouse Insulin ELISA (Mercodia,

713 Uppsala, Sweden). Leptin and resistin levels were measured using: Mouse/Rat Leptin and

714 Mouse Resistin Quantikine ELISA kits (R&D Systems, Minneapolis, MN, USA). IL-1β and

715 IL-6 dosages were carried out with ELISA Ready-SET-Go kits (eBioscience/Affymetrix,

716 ThermoFisher Scientific). IL-10 levels were determined using BD OptEIA<sup>TM</sup> kits (BD

717 Biosciences, Franklin Lakes, NJ, USA).

718

#### 719 Statistics and reproducibility

720	Differences between experimental groups were determined using unpaired two-tailed
721	student's <i>t</i> test or analysis of variance (ANOVA) as appropriate and were considered
722	significant when <i>p</i> -values were lower than 0.05. For repeated measures (body weight
723	evolution, IP-GTT tests), two-way ANOVA analyses with Bonferroni post-test were
724	performed. For respirometry analyses, a one-way ANOVA followed by Tukey post-hoc test
725	was carried out when comparing four groups or more. Statistics were performed using
726	GraphPad Prism 6 software.

The dotted line indicates the 6 hpi/0.01 MOI mean Ct value. \*\*\*\* p < 0.0001. **b** 1176 1177 Representative transmission electron microscopy sections of mock-treated and IAV-infected 1178 preadipocytes (MOI of 5, 24 hpi), n = 3 biologically independent samples per condition. 1179 Classical nuclear (yellow arrowheads) and nucleolar (yellow dashed frame) fingerprints 1180 associated with IAV infection are shown. A detailed view of empty viral particles at budding 1181 regions is presented. Murine preadipocytes 1196 (3T3-L1 cells) and adipocytes (differentiated from 3T3-L1 cells) were infected at a MOI of 1, 1197 and samples were prepared for transcriptomic analysis at 24 hpi, n = 4 biologically 1198 independent samples per condition. a Venn diagrams showing the numbers and intersections 1199 of the differentially expressed genes (DEGs), either upregulated or downregulated, in IAV-1200 infected vs. mock-treated preadipocytes and adipocytes in the whole-genome expression 1201 profiling microarray data set. 1216 Fig. 8 Metabolic reprogramming associated with influenza infection in subcutaneous adipose 1217 tissue (in vivo) and in preadipocytes (in vitro). a Transcriptome analysis of the subcutaneous (SCAT) and the visceral (EWAT) adipose tissues from mock-treated and IAV-infected mice 1218 1219 revealed activation of the STAT1-dependent-IFN-mediated signaling pathway and the 1220 concomitant inhibition of the cholesterol biosynthesis pathways in both SCAT and EWAT. 1221 IAV infection was associated with rewired energy metabolism only in the SCAT, as reflected 1222 by activation of the sirtuin signaling pathway and inhibition of glycolysis, OXPHOS, and 1223 TCA cycle. This was associated with a white-to-brown phenotypic change of the SCAT. b In vitro IAV infection of preadipocytes and adipocytes led to activation of the IFN signaling 1224 1225 pathways in both cell types. In preadipocytes only, IAV infection rewired cell metabolism 1226 through activation of the SGOC metabolic pathway. This was associated with the induction of 1227 a brown-like/beige genetic program in preadipocytes. 1228 OXPHOS = oxidative phosphorylation, ETC = electron transport chain, SGOC metabolism = 1229 serine-glycine-one-carbon metabolism. Activated and inhibited pathways are indicated in red

and blue, respectively. Top upstream regulators are indicated in brackets.
