## 24 ABSTRACT

25 Background: Overall, 10–15% of hospitalized children are undernourished. The present study

26 focuses on pediatric surgical wards. We assessed the impact of undernutrition upon admission

27 on the weight-for-height Z-score (Z-WFH) during hospitalization for surgery. Secondary aims

28 were to investigate the influence of associated factors and to report on the use of nutritional

support.

30 Methods: All children hospitalized for a surgical procedure between July 2015 and March

31 2016 were included in this monocentric, prospective study. Children were divided into two

32 groups: whether the Z-WFH upon admission was below -2 standard deviations

33 (undernourished) or not (not undernourished).

Results: A total of 161 of 278 eligible children were included; 27 were undernourished (17%).

35 The change in Z-WFH during hospitalization was greater in undernourished children

36 (0.31±0.11 vs. -0.05±0.05, *p*=0.005). Of undernourished children, 49% recovered a Z-WFH

37 above -2 SD during hospitalization. There was no difference between undernourished children

- 38 and not undernourished children regarding age, length of hospital stay, pre- and postoperative
- 39 duration of nil per os, duration of surgical procedure, ASA score, emergency level of the
- 40 surgical procedure, and enteral/parenteral nutrition.

41 Conclusion: Our data suggest that the Z-WFH of undernourished children upon admission

42 improved during hospitalization.

### 45 1. INTRODUCTION

46 Overall, 10–15% of hospitalized children are undernourished in medical and surgical wards. 47 The French national annual surveys of pediatric hospital undernutrition, called "e-Pinut," 48 report an almost constant rate of undernourished children of 8–12% [1]. 49 A surgical procedure is a stressor that increases catabolism, which is also increased by 50 underlying disease. Moreover, it is associated with a period of fasting that may affect 51 postoperative metabolism and nutritional status [2]. There are few data on the nutritional 52 consequences of a pediatric surgical procedure [3]. Undernutrition increases the risk of 53 postoperative complications and the duration of hospitalization [4–7]. In adults, perioperative 54 management was recommended by the French Anesthesia and Resuscitation Society (SFAR) 55 and the French-speaking Society of Clinical and Metabolic Nutrition (SFNCM) with 56 guidelines updated in 2010 [8]. 57 58 The primary aim of this study was to assess the change in weight-for-height Z-score (Z-WFH) 59 during hospitalization for surgical procedures of children who were undernourished or not 60 undernourished upon admission. We hypothesized that undernourished children upon 61 admission undergo a decrease in Z-WFH during hospitalization. 62 Secondary aims of the study were to investigate the influence of potential factors associated 63 with Z-WFH change and to report on the use of nutritional support. 64 65 66 2. MATERIAL AND METHODS 67 2.1 Study design and population 68 This prospective, exposed/non-exposed, observational study was carried out in the department

69 of visceral, urological, and pediatric plastic surgery in a university hospital in western France.

71 All children hospitalized for a surgical procedure were eligible for inclusion. Inclusion was 72 continued until at least 20 undernourished children with full data available had been included 73 (between July 2015 and March 2016). Children with anthropometric measures missing upon 74 admission and/or at discharge were excluded. In our institution, a resident in pediatrics is 75 specifically dedicated to nutritional status assessment in surgical wards. The resident's role 76 was, half day on work days, to perform screening and nutrition therapy of all hospitalized 77 children. This resident in pediatrics junior physician is a "go-between" and interacts with 78 surgeons, anesthetists, and pediatricians specialized in nutrition. 79 80 2.2 Clinical variables 81 Weight was measured for each child upon admission and at discharge with a weighing scale 82 ProDoc, PD200M, DETECTO® (100-g precision) (Webb City, Missouri, USA) for children weighing over 12 kg and a digital baby scale (10-g precision; product number 727, SECA<sup>®</sup>, 83 84 Hamburg, Germany) for children under 12 kg. Length was measured using a somatometer with the child lying down (0.1-cm precision; JER<sup>®</sup>, France) for children shorter than 1 m, and 85 86 height was measured with a wall-mounted stature meter (0.1-cm precision; SOEHNLE 87 PROFESSIONAL®, Backnang, Germany) for children over 1 m. Height was measured upon 88 admission and at discharge only in children younger than 6 months and those hospitalized for 89 longer than 20 days. Upon admission, children were divided into undernourished or non-90 undernourished groups according to whether the Z-WFH was below -2 standard deviations 91 using French growth charts; the index was chosen according to the World Health

92 Organization guidelines [9].

93 Surgical interventions were sorted into digestive, urological, plastic or other. The surgical

94 procedures were sorted into 3 levels of emergencies whether surgical procedure was carried

out within the 6 hours following admission (urgent), within 6 to 24 hours after admission
(semi-urgent) or as elective surgery. The American Society of Anesthesiologists (ASA) score
was recorded for each patient using the anesthesia record (1: healthy, 2: mild systemic
disease, 3: severe systemic disease, 4: score 3 with permanent threat to life). A clinical global
assessment was performed identifying children with severe clinical presentation according to
the French Pediatric Society (SFP) guidelines [10]. Nutritional support was defined as enteral
nutrition or parenteral nutrition.

103 2.3 Calculated variables

104 All data were gathered from the hospital's computerized medical records. e-Pinut expert

105 software (www.epinut.fr) was used for the calculation of height and Z-WFH. Length of stay

106 (LOS) was expressed in days. Preoperative nil per os (NPO) duration (hours) was the

107 difference between the last oral feeding and the starting time of the surgical procedure.

108 Postoperative NPO was the difference between the end of surgery and the time of recovery of

any type of oral intake. Surgical procedure duration was the time between surgical incision

110 and closure. The amount of infused sodium during the surgical procedure was calculated from

111 medical records and expressed in mEq/kg.

112

113 2.4 Ethics

114 The Internet data and e-Pinut expert software (www.epinut.fr) were approved by the advisory

115 committee on the processing of research information in the field of health (CCTIRS) on

116 23/03/2016. The National Commission for Data Protection and Freedoms (CNIL) issued a

117 declaration of conformity, no. 2034866, on 13/02/2017. Written information was delivered to

118 parents, giving them the opportunity to decline participation in this noninterventional study.

119 The local ethics committee approved the study.

### 121 2.5 Statistical analysis

122	Statistical analysis was performed using JMP <sup>®</sup> 12.2.0 software (SAS Institute Inc., Cary,
123	North Carolina, USA). Continuous variables are expressed as mean ± standard deviation. The
124	primary outcome for the two groups was tested using a $t$ test. Univariate associations between
125	the main outcome, Z-WFH change, and some variables of interest (age, Z-WFH upon
126	admission, LOS, pre- and postoperative NPO duration, duration of the surgical procedure)
127	were tested using Spearman's correlation coefficient. The effect of qualitative variables
128	(group, type of surgery, level of emergency of the surgical procedure, ASA score,
129	enteral/parenteral nutrition implementation) on the Z-WFH was analyzed through a $t$ test or
130	ANOVA for more than two categories. A multivariate logistic regression was used to test
131	continuous variables (age, duration of hospitalization, amount of sodium perfused during
132	surgery) and categorical variables (gender, presence of undernutrition) associated with
133	positive weight gain. Missing data were not considered. A value of $p < 0.05$ was considered
134	statistically significant.

# 137 **3 RESULTS**

138 3.1 Study population characteristics

139 A total of 161 children of 278 eligible participants were included in the analysis (Figure 1).

140 We compared the characteristics of the included children (n=161) with those of the excluded

141 children using the anthropometric data upon admission if they were available (n=78).

142 Excluded children did not differ in Z-WFH and sex ratio but they were older (8.6±0.6 vs.

143 5.5±0.4 years, *p*<0.0001).

144	Surgical procedures were digestive (61%), urological (22%), plastic (12%), or other (5%).
145	Surgical procedures were performed within 6 h and 24 h, respectively, in 8% and 47% of
146	cases. Elective surgery represented 45% of surgical procedures. ASA scores were 1 (64%), 2
147	(25%), 3 (11%), and only one child had an ASA score of 4.
148	The characteristics of the children are presented in Table 1. Overall, 27 children were
149	undernourished upon admission (17%). Undernourished children did not differ from non-
150	undernourished children regarding age, LOS, chronic disease frequency, pre- and
151	postoperative NPO duration, duration of the surgical procedure, ASA score, emergency level
152	of the surgical procedure, or enteral/parenteral nutrition implementation (Table 1). We did not
153	observe any effect of the ASA score and emergency level of the surgical procedures on the
154	frequency of undernutrition.
155	The change in Z-WFH during hospitalization was greater in children who were
156	undernourished upon admission. Of the children undernourished upon admission, 13 (49%)
157	recovered a Z-WFH above $-2$ SD at discharge. In total, 5% of children (n=8) lost $\ge$ 5% of
158	weight during hospitalization and in $4\%$ ( <i>n</i> =7) the Z-WFH decreased by 1 SD. In 2% of
159	children ( $n=4$ ) the Z-WFH decreased below -2 SD. In all, 8% ( $n=13$ ) had a height-for-age Z-
160	score (Z-HFA) of less than -2 SD (stunting), compatible with chronic malnutrition, among
161	which three patients had both Z-WFH and Z-HFA below -2 SD. The change in Z-WFH
162	during hospitalization was greater in children with stunting upon admission (0.38±0.17 SD vs.
163	-0.02±0.05 SD, <i>p</i> =0.02).
164	

165 3.2 Factors affecting outcome (univariate analysis)

166 The change in Z-WFH was greater in patients who received nutritional support  $(0.4\pm0.3 \text{ vs.})$ 

167  $0.0\pm0.1$ , p=0.007), and it was negatively correlated with age (p=0.0003). The Z-WFH upon

admission and postoperative NPO duration were positively correlated with LOS (all p < 0.05)

169 in univariate analysis. The correlations remained significant after multivariate analysis for all

170 factors, except for LOS and nutritional support. No association was observed with the type of

171 surgery, ASA score, level of emergency, preoperative NPO duration, saline infused during

172 surgical procedure, and duration of surgical procedure.

173 Children younger than 3 months stayed longer in hospital (Table 2). Children older than 2

174 years remained fasting for a longer period of time after the surgical procedure, while those

between 3 months and 2 years of age remained fasting for a shorter period of time before the

176 surgical procedure. No differences were observed between age groups regarding Z-WFH

177 upon admission and duration of the surgical procedure.

178

179 In total, 17 patients received nutritional support (enteral nutrition n=3). Age, pre- and

180 postoperative NPO duration did not differ in children receiving artificial nutrition. Surgical

181 procedure duration (113±18 vs. 61±4 min,  $p=10^{-4}$ ) and LOS (35±3 vs. 7±5 days,  $p=10^{-4}$ ) were

182 longer in the group of patients receiving nutritional support.

#### 185 4. DISCUSSION

186 The change in Z-WFH during hospitalization was greater in children who were

187 undernourished upon admission. The Z-WFH change was negatively correlated with age, but

188 no association with other factors was found. Patients receiving nutritional support had longer

189 surgical procedure and LOS. The pre- and post-NPO periods observed were far greater than

190 recommended in guidelines.

191

192 Most studies recommend the systematic use of screening tools for nutritional status or

193 nutritional risk, i.e., predicting weight loss during hospitalization [11–13]. Weight change was

194 greater in undernourished children and those with stunting, as reported in a previous study 195 [14], but only 50% of case were above -2 SD during hospitalization. Age was the only factor 196 found to be (negatively) correlated with the change in Z-WFH. This may suggest that 197 healthcare personnel pay more attention to infants and "lean" children when no standardized 198 nutritional care procedure is set-up. In our institution, a resident in pediatrics is specifically 199 dedicated to assessing nutritional status in surgical wards. This junior physician plays the "go-200 between" and interacts with surgeons, anesthetists, and pediatricians specialized in nutrition. 201 Therefore, extrapolation of these results to other surgical wards must be made with caution. 202 The frequency of undernutrition was 17%. Although these findings are consistent with data 203 we previously obtained from a large-scale survey, the frequency is higher than in a recent 204 study where undernutrition was present in 10% of children seen in preoperative consultation 205 for anesthesia (visceral and orthopedic surgery) [15] and in a European study, which found a 206 frequency of 13% [7]. The frequency of children who underwent a weight loss of >5% during 207 hospitalization was similar to the rate reported in the latter publication [7]. We did not find a 208 higher frequency of undernutrition in children with data on height and weight upon admission 209 not included (i.e., without discharge data), which rules out a recruitment bias. Our 210 observational study was not designed as a prevalence study. Our hospital is a reference center 211 for pediatric surgery and the only university hospital for the Loire Valley region in France 212 (total population 2.6 million in 2014). Therefore, the experience is that of a single center with 213 a strong focus on pediatric nutrition. Again, the extrapolation of these results to other centers 214 or more generally to the population of children hospitalized for visceral surgery must be made 215 with caution.

216

In total, 9% of the children received nutritional support, mostly parenteral nutrition. Inchildren, as well as in adults, nutritional support, i.e., enteral or parenteral nutrition, should

start as soon as the nutritional risk becomes apparent [16]. In children, artificial nutrition is recommended if nutritional goals cannot be reached within 7 days postoperatively [17]. Some authors proposed criteria for prolonged ileus and recovery in acute appendicitis that may be considered as risk factors for undernutrition [18]. It is noteworthy that the duration of the surgical procedure and LOS were longer in children requiring nutrition therapy. However, validation of this index is necessary. Efforts are needed to improve nutritional assessment and care with tools specific to surgical wards.

227 Although most scientific societies recommend shortening NPO periods either pre- or 228 postoperatively, the NPO periods observed were far longer than the recommendations. Solid 229 or artificial milk, breastfeeding, and clear fluids are allowed, respectively, up to 6, 4, and 2 h 230 before surgery [3,19,20] and fluid ingestion 3 h after surgical procedures [20]. Longer NPO 231 periods were reported by other authors [2,21]. It may take a long time to change practices. 232 The longer NPO periods may also contribute to weight loss after surgery, to related 233 complications, to increased LOS, and may impact on the wellbeing of the child. We found a 234 positive correlation between postoperative NPO duration and LOS. The Enhanced Recovery 235 After Surgery (ERAS) protocols were established mainly for adults [16] and need to be 236 implemented in children [21,22]; they may also help to better indicate and limit nutrition 237 support use. Failure to follow the recommendations may increase the children's discomfort 238 [2].

#### 240 **5. CONCLUSION**

One child in two loses weight during hospitalization for surgical procedures, while 10%
require nutritional support. In our study, pre- and postoperative NPO duration were longer
than recommended. Further research is needed to (1) target and follow up children at risk of

- undernutrition, (2) identify fast and simple items predicting weight loss in children
- undergoing surgery in order to initiate nutritional care as soon as possible, (3) improve factors
- that may contribute to hospital undernutrition (e.g., NPO duration, pain management, avoid
- 247 procedures that may impair food intake). A multidisciplinary approach gathering surgeons,
- anesthetists, and pediatricians is instrumental in establishing nutritional assessment and care
- 249 procedures with the whole pediatric surgical ward.
