1 Colored feathers in museum collections: a spectroscopic study of 3 bio-2 pigments and their lightfastness

12 Abstract

Yellow to red feathers in ornithological and ethnographical museum collections are known to be 13 14 sensitive to light exposure. However, only a few studies on the interaction of light with the color of feathers have been published. This work provides fresh insight into the sensitivity of feathers for 15 better conservation and exhibit of ethnographic collections, with a specific focus on carotenoids, 16 psittacofulvins and porphyrins-based feathers. A first approach was to evaluate the use of Fiber 17 Optics Reflectance Spectroscopy (FORS) in the visible range to characterize the chemical nature of 18 19 the bio-pigments. It was implemented on 19 ornithological specimens preserved in the Muséum 20 national d'histoire naturelle (MNHN) in Paris, and on assigned feathers from more than 40 objects 21 from the collections of the musée du quai Branly - Jacques Chirac (mqB-JC). Then, microfading tests 22 were carried out on molting feathers or picked up on dead birds. Two different setups were used in 23 order to determine a reproducible protocol for these 3D materials. Several variables were considered 24 including the positioning of the feather and the duration of measurements. In addition to the visible 25 range, the near-infrared (NIR) region was also investigated to determine if the color fading is 26 concomitant to any structural modification. Then the developed protocol was applied on some loose 27 lumps of feathers from objects of the mqB-JC collections. The data were compared against each 28 other and to the Blue Wool Standards fading rates.

33 1. Research aims

This research aims to compare the lightfastness of three bio-pigments (carotenoids, psittacofulvins and porphyrins) that are found in yellow to red feathers in ethnographic collections using microfading tests (MFT). An analytical procedure was developed on a set of loose feathers in order to determine the optimal conditions of analysis. The feasibility of this approach was then assessed on feathers from museum objects. Further insights into the color changes during the fading process are provided.

9 2. Introduction

11 Lighting in museums is a very challenging task as it must cover three important concepts: the 12 scenography of the exhibition, the visual comfort of the visitors and the conservation of the exhibited 13 objects. This last notion is a major concern for cultural heritage scientists, whose tasks are to 14 evaluate the alteration factors such as photodegradation, and to inform on the optimal conditions of 15 lighting. For that purpose, Paul Whitmore introduced in 1999 [1] an innovative technique he referred 16 to as the microfading tester, to evaluate the fading of an artwork during an exhibition. Since then, 17 microfading testing (MFT) has been widely used on flat and opaque artifacts: artworks on paper such 18 as pastels [2], drawings or documents containing iron gall inks [3], art materials [1,4], and photographs [5]; as well as more textured colored objects: textiles [6-8], Alaskan artefacts [9] and 19 20 tapestry [10]. Ford and Druzik [11] have specified the use, advantages and limitations of MFT with a 21 very detailed review. This technique consists in intensively illuminating a tiny surface of an artwork 22 (less than 0.5 mm in diameter) with a light source operating in the visible range, and simultaneously 23 following the spectral change, which is later converted to color change (ΔE) in a specific colorimetric 24 space (here CIELAB, defined in 1976 by the *Commission Internationale de l'Éclairage (CIE)* [12]). The 25 potential color modification is compared to the fading of normalized references, Blue Wool 26 Standards (BWS) of varying lightfastness (from BWS1 the most sensitive, to BWS8 the less sensitive; 27 typically, microfading tests use BWS1-3), that are tested under the same illuminating conditions. The 28 Just Noticeable Difference (JND) is a criterion introduced to determine the color change that is visible 29 to an observer, with average color perception under ideal viewing daylight conditions. It is obtained 30 by comparing side by side middle sized, smoothed, opaque and evenly colored materials. Reported average values for the characterization of a JND are Δ E94=1.7 [13], Δ E76=1.8 [14], Δ E00=1.6 [11]; the 31 corresponding exposures inducing the JND are given in Mlx.h. 32

1 The objective of this study was to get more insight into the use of MFT for poorly characterized 2 objects such as feathers in ethnographic collections. Feathers are curved and textured items and can 3 sometimes be very thin and fragile. Their various colors can be of different origins: physical and/or 4 chemical [15]. Physical colors can be due to the interference of light: the barbules contain 5 microlamellar structures that break down the light, and depending on the spacing of the 6 microlamels, the color differs. They can also be due to a spongy structure located in the barbs, 7 constituted of air cells regularly distributed in the keratin structure causing the reflection of short 8 wavelengths (blue and violet) [16]. Regarding the chemical colors, the most common pigment is 9 melanin responsible for brown and black colors which are stable to light. Carotenoids are responsible 10 for yellow, orange and red colors, and depend on the bird's diet [17]. Psittacofulvins are from 11 endogenous origin, and vary from yellow to red [18]. Porphyrins, also from endogenous origin, 12 produce several colors, as brown, red or green [18]. A given feather can present important variations 13 of color that may be due to the presence of a combination of physical and chemical colors, and/or a 14 combination of several bio-pigments in various concentrations and distribution. Among individuals of 15 a given species, the color variability of the feathers will depend on the age of the bird and the time of year during which the feathers were collected. In museums, conservation conditions and past 16 17 exposure to light of feathered objects can also have an impact on their colors. The mechanical 18 damage due to handling, packing and transportation, and the biological damage (insects) will mainly 19 have an impact on physical colors through the degradation of the structure [19].

Although structural colors can degrade with UV radiation (degradation of keratin) [20,21] chemical colors (i.e. bio-pigments) are sensitive to visible light. Few studies on the interaction of light with the color of feathers have been published. Some studies are related to the identification and differentiation of bird species using spectroscopic techniques such as visible reflectance spectroscopy [19,22,23] or Raman spectroscopy [24–27]. Some other publications are related to the conservation of museum artefacts by comparing MFT and window fading [20] or even the effects of exposure to light and laser radiation during laser cleaning [28].

27 In ethnographic collections, the bird species from which the feathers have been taken to make the objects - and hence the bio-pigments - are usually unidentified. In this work, only red to yellow 28 29 feathers containing carotenoids, psittacofulvins, or porphyrins were investigated, as they are 30 reputedly more sensitive to light exposure [28]. A first approach was to evaluate the use of Fiber 31 Optics Reflectance Spectroscopy (FORS) in the visible range to characterize the chemical nature of 32 the bio-pigments. It was implemented on a large corpus of 19 ornithological specimens of the 33 Muséum national d'histoire naturelle (MNHN) in Paris, and on assigned feathers from more than 40 34 objects from the collections of the *musée du quai Branly - Jacques Chirac (mqB-JC)*.

1 Microfading tests were carried out on molting feathers collected in menageries or picked up on dead 2 birds. Two different setups were used in order to determine a reproducible protocol for these 3D 3 materials. A comparison of two setups was conducted. This first device uses a xenon lamp and the 4 second one, most commonly found in museums, uses LEDs. Multiple variables were studied, among 5 them the positioning of the feather and the duration of measurements. The near-infrared (NIR) 6 region was investigated in addition to the visible range in order to highlight possible structural 7 modifications during the color fading. Then the developed protocol was applied on some loose lumps 8 of feathers from objects of the mqB-JC collections. The data were compared against each other and 9 to the BWS fading rates.

11 **3. Material and methods**

All samples and objects are described in Table 1, with the bird species they come from, their origins, their colors, and the type of bio-pigments they contain. The analyses that were performed for each sample or object are also indicated. Figure 1 presents images of the *mqB-JC* loose feathers, along with a specimen from the *MNHN*.

16 **3.1. Feathers**

17 *3.1.1. Loose feathers and ornithological specimens*

A total of 13 loose feathers consisting in molting feathers collected in menageries or picked up on dead birds were studied. They all date to the late 20th and 21st centuries. Most of them are yellow to orange with carotenoid pigments, three have psittacofulvin yellow pigments and one is red with porphyrin pigments. In addition, 19 specimens of the *MNHN* in Paris were analyzed. Mostly dated to the late 19th century, 13 specimens are with carotenoids-based colors (yellow and red), 5 with psittacofulvins-based colors (yellow and red) and one with red porphyrins.

25 3.1.2. Museum objects

A set of 44 feathered objects from the collections of the *mqB-JC* was analyzed. There are tunics and ponchos, headdresses, earrings, diadems, woven mats, bracelets, armlets, nasal ornaments, among others. They all come from South America and can be divided into two groups: archaeological (700-1450 AD) and ethnographical (1880's-1970's) collections. Their conservation state varies depending on their production period and former use, as well as on their conservation environment before and since entering the museum collections.

1 **3.2.** Spectroscopic study

3.2.1. Fiber optics reflectance spectroscopy (FORS)

3 FORS was performed using a FieldSpec Hi-4 (ASD Inc. Malvern Panalytical, Spectris plc, Egham, 4 Surray, UK), a spectrophotometer equipped with a halogen light source and a bundle of quartz-silica 5 optical fibers transmitting in the visible and near-infrared wavelengths (350-2500 nm), connected to 6 a contact probe-head operating in the 0°/45° geometry and a measuring spot size of approximately 7 6 mm². The spectrophotometer has 3 detectors to cover the whole spectral region: one for the 350-8 1000 nm range, another one for the 1000-1800 nm and the last one for the 1800-2500 nm. The 9 spectral resolution is of 3 nm for the first range and 10 nm for the other two. The instrument is 10 calibrated using a Spectralon[®] white reference, every 20 minutes approximately. Multiple spectra 11 were recorded on several spots for each sample or object. Each spectrum is an average of 50 spectra 12 with an acquisition time of 8.5 ms. FORS analyses were performed directly in contact with the 13 samples or objects, and when the feather was very thin, a black cardboard was placed under it in 14 order to absorb the light transmitted through the feather and prevent any back reflection.

3.2.2. Microfading Test (MFT)

The microfading test was performed using two different configurations: a LED setup developed by Pesme [29] and a slightly modified Whitmore setup [1]. For both instruments a set of Blue Wools Standards BWS1 to BWS5 (Deutsche Echtheits-kommission - DEK e.V.) was tested before each sample or object.

21 The LED setup is equipped with two LEDs: a warm white and a 405 nm light (Thorlab). The 22 combination of both lights is brought to the sample with a 400 μ m diameter optical fiber connected 23 to an 800 µm diameter optical fiber through a shutter allowing to quickly stop the illumination when 24 necessary. The estimated photometric intensity of the spot reaching the sample is 10 000 lx. The 25 signal is collected in the $0^{\circ}/45^{\circ}$ geometry using a 400 μ m optical fiber. In this setup, the measuring head, a semispherical angled fiber holder, is in contact with the sample and the analytical spot is 26 27 approximately of 0.6 mm in diameter. The spectrometer is a Control Development LM-1000. The 28 monitored reflectance spectrum is collected using the default settings: a 350-800 nm range, and an 29 average of 10 spectra with an acquisition time of 5.8 ms. The color change induced by the 30 illumination is calculated in real time (spectra are converted into CIELAB coordinates with D65 31 reference illuminant and 2° observer).

1 The Whitmore setup has optical and electronic components marketed by Newport: a xenon lamp 2 (75 W) equipped with a UV filter, and a neutral density filter of 0.09 to deliver a photometric 3 intensity at the sample between 0.3 and 0.5 Mlx. There was no IR filter in our experiment, as 4 opposed to Whitmore's initial setup. A shutter is placed after the lamp and filters to quickly stop the 5 illumination if needed. The light is brought to the sample with a 600 μ m diameter optical fiber and 6 the signal is collected in the 0°/45° geometry using the same bundle of fibers (without the contact 7 probe) and the same spectrophotometer as for the FORS analyses. A series of lenses are used at the 8 end of the fibers to focus the light on a small area (less than 0.5 mm in diameter) with a working 9 distance of 12 mm. For a more precise focus, two crossed mini lasers were attached on each side of 10 the measuring head: the focusing point is optimal when the two crosses meet (see Figure 3-b). The 11 use of the FieldSpec Hi-4 spectrophotometer (and the absence of an IR filter) was intended to follow 12 the infrared spectral range together with the visible range. The spectrometer tracks reflectance changes in real time, and the ΔE^*_{ab} [12] is monitored during the fading. 13

For both setups, MFT analyses were done on single feathers, and on loose feathers from the museum
 objects. A black cardboard was placed under the samples during the tests. The instrumental drift of
 the Whitmore setup was recorded on a Spectralon[®] white reference under the same conditions.

18 4. Results and discussion

19

20 **4.1.** Identification of bio-pigments by FORS in the visible range

In order to evaluate the use of FORS for the identification of bio-pigments, analyses were performed
on 19 ornithological specimens of the *MNHN*, and on assigned feathers from more than 40 objects
from the collections of the *mqB-JC*.

24 Figure 2 presents the reflectance spectra obtained on yellow (Y) feathers (Figure 2-a) and red (R)

feathers (Figure 2-b) from ornithological specimens containing three bio-pigments: carotenoids (C),
psittacofulvins (Ps) and porphyrins (Po) [17,18].

The spectral shape for the carotenoids and psittacofulvins based feathers (both red and yellow) have a sigmoid spectral shape [30,31] and a maximum reflectance of around 80 % for the lighter colors and 20 % for the darker shades. The "spectral location" of the feathers is defined as the wavelength at 50 % of the maximum reflectance and is used to characterized the hue [30,32,33]. In our study, this characteristic wavelength was determined using the first derivative of the reflectance spectra. Indeed, the knee-point of the sigmoid slope on the reflectance spectra coincides with the maximum intensity on the first derivative of the spectra. The positions of the first derivative maxima (λ_m) are presented in Table 1. Two distinct groups are observed: feathers with a yellow hue (λ_m between 467 and 529 nm) and feathers with a red hue (λ_m between 598 and 639 nm). Some feathers gather in between these two groups with a λ_m between 535 nm and 590 nm. They present various hues of orange, and depending on their ratio of red and yellow bio-pigments a shift of the slope is visible [23,33].

6 It is difficult to differentiate carotenoids and psittacofulvins bio-pigments based on this spectral 7 characteristic as their λ_m overlap, with both yellow and red feathers. Fortunately, the carotenoid 8 based yellow feathers (Figure 2-a, solid line spectrum) have absorption peaks at approximately 404, 9 430, 455 and 486 nm [32]; whereas the spectra of the yellow psittacofulvins feathers (Figure 2-a, 10 dotted spectrum) have additional absorption bands around 450 and 475 nm [34]. These absorption 11 bands clearly discriminate yellow carotenoids from yellow psittacofulvins.

Regarding red bio-pigments (Figure 2-b), carotenoids and psittacofulvins have very similar reflectance spectra, and no particular absorption bands are observed. It is thus impossible to discriminate between these two red chemical families using visible reflectance spectroscopy [22]. Porphyrins however (here turacin, see Table 1) present very specific reflectance spectra (Figure 2-b, grey spectrum) with absorption peaks at 452, 544 and 581 nm [22].

Using FORS on feathers can be helpful to determine if the yellow color is due to carotenoids or psittacofulvins. It is however less useful for the most encountered red feathers. One possible solution to identify red bio-pigments would be to probe red feathers that present some orange shades and look for – even weak – spectroscopic features of yellow bio-pigments, as red and yellow colors on a same species are produced by bio-pigments of similar molecular nature [35].

23 **4.2.** Microfading tests: Practical and technical considerations

24

In order to establish an analytical protocol for microfading tests, data were recorded on loose feathers, and most of the presented results were obtained on yellow psittacofulvins-based feathers (PJ04, see Table 1) and yellow carotenoids-based feathers (PJ06, see Table 1) as they were both in sufficient amount to run several experiments.

4.2.1. Feather orientation regarding the measuring head

Feathers have very specific shapes and structures making the microfading testing process complex [36]. To overcome this difficulty, several practical measures were set up. First, it was important to ensure the flatness of the feather barbs, on a local area that corresponds to the size of the light beam, i.e. less than 0,5 mm in diameter. For the Whitmore setup, since the probe is 12 mm away from the sample, light weights were place on the feathers or objects around the area of interest to locally flatten the barbs. For the LED setup, since the probing head is in contact with the sample, light weights were placed on top on the measuring head to ensure a proper contact.

5 Then, the orientation of the barbs regarding the probe was considered. This was pointed out by 6 Riedler et al. [16] as being critical: the barbs structure or the measurement geometry can influence 7 the analysis of the color, and hence, the microfading tests. Indeed, the orientation of the barbs can 8 have an impact on the collected data, as their microstructure can provoke the diffraction of the 9 incident light that may influence the reflectance spectra, and thus the measurement of the color 10 change. Riedler et al. [16] have come up with a setup using Mylar[®] templates to position the feather 11 under the probe using different angles on different planes (direction of observation and rotation of 12 the feather regarding the illumination direction and the observation collection). In this work, a 13 normal illumination is used and the direction of the collected light is fixed at 45°. The only angle that 14 varies is the one between the barbs' orientation and the direction of observation. Figure 3-a shows 15 the two positions that were considered: the L position with the barbs in line with the collecting 16 orientation (0° angle), and the P position where the barbs are perpendicular to the collecting geometry (90° angle). For the Whitmore device, the feather was precisely positioned under the 17 18 probing head by removing the illumination fiber to visualize the analytical spot, and using the crossed 19 lasers to orient the barbs (see Figure 3-b). For the Pesme setup, the Mylar[®] template from Riedler et 20 al. [16] was adapted with a thin paper template of the size of the probe, with a hole representing the 21 illumination spot, and two lines representing the L and P positions. The paper is placed in the proper 22 position onto the feather, then removed and replaced by the probing head. Figure 3-c shows the 23 MFT curves that were obtained using the Whitmore setup with the two positions on multiple spots of 24 a yellow psittacofulvins-based feather (PJ04c, see Table 1). The curves obtained in the P position are 25 clearly higher than the ones obtained with the L position, and are close to the BWS4 curve. This is 26 likely due to the contribution of the feather microstructure as it impacts the measured reflectance (and hence the color change) [37]. In order to obtain the most conservative results, the P position 27 28 must be chosen. Another interesting result is the high variability of the MFT curves regardless the 29 orientation of the feather. This is due to the inherent variability of the pigment concentration across 30 the surface of the feather [28]: in other terms the color saturation varies within a feather leading to 31 high MFT curves (more saturated colors) or lower ones (less saturated ones). In summary, when 32 performing MFT on feathers, three precautions must be followed: the tests must be done with the 33 barbs perpendicular to the measuring geometry, in multiple areas to ensure a homogeneity in the

data (at least 3 tests [20]), and in the most saturated areas where the bio-pigments are more
 concentrated.

3 *4.2.2. The duration of the tests*

4 Another important parameter is the duration of the microfading tests. Knowing that these tests must 5 be repeated on multiples spots, it would be best from an operational standpoint to perform brief 6 period tests to avoid long analysis campaigns. Indeed, when testing ahead of an exhibition or before 7 answering loan requests, there is often a time constraint: the shorter the tests, the better. Also, the 8 instrument internal drift is a critical parameter that must be considered as it may distort the results. 9 Figure 4-a presents MFT curves on 3 spots of another yellow psittacofulvins-based feather (PJ04I) 10 over a 40 minutes period. The shape of the curve (that will be discussed in paragraph 4.3.1) shows a 11 constant rate starting at 15-20 minutes. The spectrometer seems to be stable on that period of time, 12 as the instrumental drift remains quite flat (Figure 4-a, red dotted line).

4.2.3. The setups and light sources

As mentioned previously, two experimental setups where used in this study, and the main difference 15 is the light source: a xenon lamp versus LEDs (Warm White + Blue at 405 nm). Figure 4-b, shows MFT 16 17 curves obtained on similar feathers with both devices. For that test, the xenon lamp delivered approximately 0.42 Mlx, whereas the LEDs delivered around 0.01 Mlx (values recorded at the 18 19 sample). The curves are plotted as function of the time (left) and the dose (right). The consequence 20 on the curves is a rather bad signal to noise ratio for the ones collected with the LEDs system, making the reading of the color change (ΔE^*_{ab}) quite difficult. This result is consistent with the description of 21 22 the Pesme setup [29] stating that the device is made for testing sample and objects equivalent to 23 BWS1-2-3. Also, the contact mode of the Pesme probe makes the positioning of the feather more 24 difficult than the non-contact Whitmore setup. Whitmore's setup was therefore used for the 25 following MFT experiments.

27 4.3. Lightfastness of bio-pigments

28

4.3.1. Shape of the fading rate curves and exposure recommendation

Figure 5 presents the MFT curves that were obtained on the single feathers and the *mqB-JC* loose feathers, in comparison to the BWS curves (BWS2 to BWS5). The presented data are average curves of 3 reiterations with a maximal dose of 0.42 Mlx.h. It must to be noted that the measured doses in our study are higher than usual: a ΔE^*_{ab} of 1.8 is induced on BWS2 after a light dose corresponding of 0.025 Mlux.h and not after the expected light dose of 1 Mlux.h (see below). An explanation would be

1 that our Whitmore setup includes IR radiation leading to a higher illuminance than usual (xenon 2 peaks between 800 and 1000 nm, see online supplementary material), leading to faster color 3 changes. The average values and standard deviations for ΔE^*_{ab} after 40 minutes are also presented 4 (the $\Delta E00$ values are available as supplementary materials). The shape of the fading rate curves of 5 organic dyes were described by Cox Crews [38] according to Giles' work [39]. Five types were 6 established, depending on how the dyes are distributed in the sample (diffused, aggregated). Only 7 types I and II will be considered here. Type I presents a fading rate that has a constant decrease, and 8 is attributed to dyes molecularly dispersed throughout the fiber. BWS 1 to 3 fading rate curves match 9 this type [40]. Type II presents an initial rapid rate followed by a slower fading at constant rate. It is 10 supposed to be specific of mostly aggregated colored molecules, with a proportion of exposed 11 dispersed molecules that discolor at the very beginning of the fading process. BWS 4 and 5 fading 12 rate curves are close to this type but present a particularly slow second domain that looks more like a 13 plateau (see Figure 5 and references [40-42]). The fading rate curves for the analyzed feathers 14 (single feathers and from museum objects) are quite similar, and are typical of type II. This seems in 15 agreement with the fact that bio-pigments molecules are incorporated discretely into the shaft, 16 barbs and barbules [16]. Also, there is no particular discrepancy between the tested bio-pigments, in that they all show similar curve shapes. However, the difference in the curve shapes between BWS 17 18 and bio-pigments may be an issue. Indeed, testing for example psittacofulvins-based feathers for 19 10 minutes will give BWS4 equivalent, but if the test is longer (20 to 40 minutes) the BWS equivalent 20 shifts to BWS3 or between BWS3 and BWS4 (see Figure 5, yellow curves). This intersection between 21 curves over time was also observed by Tse et al. in a study of the light sensitivity of birch bark [43]. 22 Therefore, the minimal duration of the tests should be around 15-20 minutes, and if possible, users 23 must perform one longer test (30-40 minutes) to confirm the kinetics of the color fading.

24 ΔE^*_{ab} values, after 40 minutes differ depending on the tested bio-pigment: the most sensitive one is 25 the porphyrins-based red feather (ΔE^*_{ab} of 2.2), then the red psittacofulvins-based feathers (ΔE^*_{ab} around 1.5), then the yellow psittacofulvins-based feathers (ΔE^*_{ab} between 0.9 and 1.4) and finally 26 the red and yellow carotenoids-based feathers (ΔE^*_{ab} around 0.8). Beside the nature of the bio-27 pigment, the difference in the ΔE^*_{ab} can be related to the disparity in the age and conservation 28 29 conditions of feathers and objects. Indeed, a feather that is newly collected (i.e. PR01) will be 30 brighter in color – and richer in bio-pigments – than a feather from an artifact that has already been exposed to light in museums (i.e. 71.1917.3.83 D). Also, ritual objects likely start their fading process 31 32 during ceremonies and dances due to sun exposure [20].

33 Since, no alternative references to BWS have yet been developed [44], the exposure 34 recommendations are still based on BWS equivalents that categorize the sensitivity of museum

1 objects. Michalski published the following maximum doses before a JNF (Just Noticeable Fade), in 2 Mlx.h, which is considered as a detection threshold of a perceived color difference, that can be 3 assimilated to the JND: BWS1: 0.3, BWS2: 1, BWS3: 3 and BWS4: 10 with - at 50 lx - a JNF reached in 4 1.5 to 20 years for BWS1 to 3 respectively; and a JNF in 20 to 700 years for BWS4 to 6 respectively 5 [14]. Ford et al. [41] recommend for BWS3-4 equivalents a light level of 50 to 150 lx and an exposure 6 of 5 years per decade for high significance objects. Even if the JND values and associated light doses 7 found in the literature are not really suited for material such as feathers that present more complex 8 color appearance, adopting such values for lighting policy for feathers allows museums to stay on the 9 conservative side. At the mgB-JC, based on the concept of "Preservation Target" (PT) defined by 10 Pesme [45], maximum light doses where attributed to Blue Wool Standards Equivalent (BWSE) and a 11 PT set to 1 JND for a hundred years period. Because of the uncertainty of the published figures, and 12 the fact that data has slowly emerged since (see reference [10] and personal communications by C. Pesme on January 15, 2016; and J.-J. Ezrati on December 20, 2016) those doses are the following 13 14 (Mlx.h): BWSE1: 0.1, BWSE2: 0.7, BWSE3: 3. Concretely, it means that an object containing 15 psittacofulvins-based feathers with a BWS3 equivalent can be presented in the permanent exhibition at 150 lux for a duration of 96 weekly lighting hours for up to four years before a JND. Distinguishing 16 17 between red porphyrin-based feathers and, at the other end of the sensitivity spectrum, red 18 carotenoids-based feathers, could provide highly valuable insight in deciding the length of exhibition 19 before preparing a replacement object for rotation. At the mqB-JC, it has been suggested to set a 20 four years limit at 150 lux for objects containing yellow, green or blue feathers and a two years limit 21 at 100 lux for objects containing red or orange feathers. Hence, should an object contain red or 22 orange porphyrins-based feathers, these set points would enable a rotation before a JND is reached. 23 Admittedly this proposal is on the conservative side, in line with the preservation duties of the 24 museum.

25 4.3.2. Color changes

In order to demonstrate that the fading is permanent and cumulative, a carotenoids-based feather (PJ06b, see Table 1) was tested in a two-step procedure using the Whitmore setup. A 10 minutes run was performed, then the xenon light was shuttered for 5 min, and finally a second 10 minutes run was achieved, on the same exact spot (the feather was not moved during the whole experiment). Figure 6 shows the two fading curves for both runs. The first run sits above the second one, proving that once the fading has occurred, it is not reversible: the more a feather is exposed, the more it will lose its color.

In order to understand the color changes during the fading procedure, the chromatic coordinates: L*
(brightness), a* (green-red), b* (blue-yellow), C* (saturation) and h* (hue) were extracted from the
reflectance spectra using a homemade software based on the formulas established by the CIE [12]
and a D65 reference illuminant and 2° observer. C* and h* are calculated using a* and b* as:

$$C^* = \sqrt{a^{*2} + b^{*2}}$$
 and $h^* = \arctan\left(\frac{b^*}{a^*}\right) \times \frac{180}{\pi}$

Figure 6 (right side) shows the representation of the chromatic variations in polar scatter charts for both runs. In both cases, the hue does not vary, but the feather shifts to lower C* values, which means that the yellow color diminishes (loss of saturation). The variation is more important for the first run ($\Delta C_1^*=1.3$) than the second one ($\Delta C_2^*=0.8$).

4.3.3. Near Infrared (NIR) spectral changes

12 In addition to the visible range, the NIR (1000-2500 nm) was also exploited. This spectral area contains information regarding the molecular structure of the analyzed samples. The aim was to 13 14 determine if any changes are observable on this spectral area that might be linked to the color 15 change, for example variations in NIR bands relative to the bio-pigments. Figure 7 shows the visible-16 NIR reflectance spectra that were recorded during a 10 minutes fading test on a psittacofulvins-17 based feather (PJ04, see Table 1). Most of the bands in the 1200-2300 nm range are assigned to the 18 keratin matrix of the feather, and do not evolve with the time of exposure. The only bands that 19 present a notable decrease with time are the ones at approximately 1935 and 1975 nm (see insert in 20 Figure 7), assigned to water molecules. During the fading process, the intense light beam can induce 21 a local heating of the sample, leading to water loss. After a few hours, the water bands are visible 22 again on the spectra (data not shown here), which means that this process is reversible. This was 23 observed on most of the tested feathers.

26 5. Conclusions

Three bio-pigments encountered in feathers were studied using Fiber Optics Reflectance Spectroscopy (FORS) and microfading tests (MFT). FORS was able to differentiate yellow carotenoidsbased feathers from psittacofulvins-based feathers and to identify red porphyrins-based feathers using the visible range of the spectra. Red carotenoids and psittacofulvins show very similar spectra and cannot be sorted apart. Considering MFT, several practical and technical requirements were set up and discussed. The fading of the bio-pigments is optimal when the feather is at a 90° angle

1 regarding the geometry of the probing head: indeed, the highest the curve, the more accurate the 2 long-term fading prediction. For similar reasons, analytical spots must be chosen in the most 3 saturated areas of the feathers, where the bio-pigments are in higher concentration. Also, when 4 testing ahead of an exhibition or before answering loan requests, there is often a time constraint. 5 However, the fading tests should be repeated three times to ensure a homogeneity in the data, and 6 last at least 15 to 20 minutes with, if possible, one longer acquisition of 30 to 40 minutes. The loose 7 feathers and the museum objects show similar curves shapes with initial rapid rate followed by a 8 slower fading at constant rate, which is typical of type II. The ΔE^*_{ab} varies between 0.7 and 2.2, which 9 corresponds to a BWSE between 3 and 4. However, the number of tested feathers is not sufficient to 10 draw meaningful conclusions about the lightfastness of the various bio-pigments: additional 11 microfading tests are in process in order to complete this work.



- 8 psittacofulvins-based feather) and 71.1917.3.83 D (red carotenoids-based feather).



- 4 psittacofulvins-based feather (PJ04c) for both P and L positions, using Whitmore's setup.




Figure 4: a) Mutiple testing of a psittacofulvins-based feather (Blue macaw, Ara ararauna - PJ04I)

the time, right: as a function of the dose.




Figure 5: Average microfading curves collected with the Whitmore setup for 40 minutes on psittacofulvins-based (Ps), carotenoids-based (C) and porphyrins-based (P) feathers a) yellow (Y) and red (R) loose feathers and b) on some feathers from the *mqB-JC* objects. The dose is presented on the top axis, and data are compared to the BWS2 to 5. The table presents the average values and standard deviations for ΔE^*_{ab} after 40 minutes (the $\Delta E00$ values are available as supplementary materials).




Figure 6: Color change experiment (see text) on a carotenoids-based yellow feather (PJ06):

runs.




Figure 7: visible-NIR reflectance spectra recorded during a 10 minutes fading test on a
