# DEGREE GROWTH OF POLYNOMIAL AUTOMORPHISMS AND BIRATIONAL MAPS: SOME EXAMPLES

#### Abstract

We provide the existence of new degree growths in the context of polynomial automorphisms of $\mathbb{C}^{k}$ : if $k$ is an integer $\geq 3$, then for any $\ell \leq\left[\frac{k-1}{2}\right]$ there exist polynomial automorphisms $f$ of $\mathbb{C}^{k}$ such that $\operatorname{deg} f^{n} \sim n^{\ell}$. We also give counter-examples in dimension $k \geq 3$ to some classical properties satisfied by polynomial automorphisms of $\mathbb{C}^{2}$.

We provide the existence of new degree growths in the context of birational maps of $\mathbb{P}_{\mathbb{C}}^{k}$ : assume $k \geq 3$; forall $0 \leq \ell \leq k$ there exist birational maps $\phi$ of $\mathbb{P}_{\mathbb{C}}^{k}$ such that $\operatorname{deg} \phi^{n} \sim n^{\ell}$.


## 1. Introduction

Let $f$ be a polynomial automorphism of $\mathbb{C}^{2}$, then either $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ is bounded, or $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ grows exponentially. In higher dimensions there are intermediate growths:

Theorem A. Let $k$ be an integer $\geq 3$. For any $\ell \leq\left[\frac{k-1}{2}\right]$ there exist polynomial automorphisms $f$ of $\mathbb{C}^{k}$ such that

$$
\operatorname{deg} f^{n} \sim n^{\ell}
$$

The group of polynomial automorphisms of $\mathbb{C}^{2}$ has a structure of amalgamated product ([6]); using this rigidity a lot of properties of polynomial automorphisms of $\mathbb{C}^{2}$ have been established. All these properties show a dichotomy; up to conjugacy there are two types of polynomial automorphisms of $\mathbb{C}^{2}$ : the elementary ones and the Hénon ones. Furthermore if $f$ and $g$ are two polynomial automorphisms of $\mathbb{C}^{2}$ and $H_{\infty}$ denotes the line at infinity (we view $\mathbb{C}^{2}$ in $\mathbb{P}_{\mathbb{C}}^{2}$ ), then
$\left(\mathcal{P}_{1}\right): f$ is algebraically stable if and only if $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ grows exponentially;
$\left(\mathcal{P}_{2}\right)$ : for any $n \geq 1$ the equality $\operatorname{deg} f^{n}=(\operatorname{deg} f)^{n}$ holds if and only if $f$ does not preserve a fibration in hyperplanes;
$\left(\mathcal{P}_{3}\right)$ : the sequences $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ and $\left(\operatorname{deg} g^{n}\right)_{n \in \mathbb{N}}$ have the same growth if and only if the configurations of $\left(f\left(H_{\infty}\right), f^{-1}\left(H_{\infty}\right), \operatorname{Ind}(f), \operatorname{Ind}\left(f^{-1}\right)\right)$ and $\left(g\left(H_{\infty}\right), g^{-1}\left(H_{\infty}\right), \operatorname{Ind}(g), \operatorname{Ind}\left(g^{-1}\right)\right)$ are the same;
$\left(\mathcal{P}_{4}\right): \operatorname{deg} f^{2}=(\operatorname{deg} f)^{2}$ if and only if $\operatorname{deg} f^{n}=(\operatorname{deg} f)^{n}$ for any $n \in \mathbb{N}($ see [5, Proposition 3]).
Note that in $\left(\mathscr{P}_{1}\right),\left(\mathscr{P}_{2}\right)$ and $\left(\mathscr{P}_{4}\right)$ one can add "if and only if $f$ is of Hénon type".
Fact B. We give counter-examples to Properties $\left(\mathcal{P}_{1}\right),\left(\mathcal{P}_{2}\right),\left(\mathcal{P}_{3}\right)$ and $\left(\mathcal{P}_{4}\right)$ in dimension $\geq 3$.
Nevertheless one can prove a similar result to property $\mathscr{P}_{4}$ :
Proposition C. Let $f$ be a polynomial automorphism of $\mathbb{C}^{k}$. Then $\operatorname{deg} f^{i}=(\operatorname{deg} f)^{i}$ for $1 \leq i \leq k$ if and only if $\operatorname{deg} f^{n}=(\operatorname{deg} f)^{n}$ for any $n \geq 1$.

If $\phi$ is a birational self map of $\mathbb{P}_{\mathbb{C}}^{2}$, then $\left(\operatorname{deg} \phi^{n}\right)_{n \in \mathbb{N}}$ is either bounded, or grows linearly, or grows quadratically, or grows exponentially ([3]). In this context there exist other types of growth in higher
dimension. Lin has studied the degree growth of monomial maps of $\mathbb{P}_{\mathbb{C}}^{k}$ (see [8]); he proves in particular that if $A$ is a $k \times k$ integer matrix with nonzero determinant, then there exist two constants $\alpha \geq \beta \geq 0$ and a unique integer $0 \leq \ell \leq k-1$ such that for any $n \in \mathbb{N}$

$$
\beta \rho(A)^{\ell} n^{\ell} \leq \operatorname{deg} \phi_{A}^{n} \leq \alpha \rho(A)^{\ell} n^{\ell}
$$

where $\rho(A)$ denotes the spectral radius of $A$ and $\phi_{A}$ the monomial map associated to $A$. Does there exist in dimension $k$ birational maps of $\mathbb{P}_{\mathbb{C}}^{k}$ with growth $n^{\ell}$ with $\ell>k-1$ ?
Theorem D. Assume $k \geq 3$; forall $0 \leq \ell \leq k$ there exist birational maps $\phi$ of $\mathbb{P}_{\mathbb{C}}^{k}$ such that $\operatorname{deg} \phi^{n} \sim n^{\ell}$.
Note that there exists a birational self map $f$ of $\mathbb{P}_{\mathbb{C}}^{3}$ such that $\operatorname{deg} f^{n} \sim n^{4}$ (see [10]).

## 2. RECALLS, DEFINITIONS, NOTATIONS

2.1. The group of polynomial automorphisms of $\mathbb{C}^{k}$. A polynomial automorphism $f$ of $\mathbb{C}^{k}$ is a polynomial map of the type

$$
f: \mathbb{C}^{k} \rightarrow \mathbb{C}^{k}, \quad\left(z_{0}, z_{1}, \ldots, z_{k-1}\right) \mapsto\left(f_{0}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right), f_{1}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right), \ldots, f_{k-1}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right)\right)
$$

that is bijective. The set of polynomial automorphisms of $\mathbb{C}^{k}$ form a group denoted $\operatorname{Aut}\left(\mathbb{C}^{k}\right)$.
The automorphisms of $\mathbb{C}^{k}$ of the form $\left(f_{0}, f_{1}, \ldots, f_{k-1}\right)$ where $f_{i}$ depends only on $z_{i}, z_{i+1}, \ldots, z_{k-1}$ are called elementary automorphisms and form a subgroup $\mathrm{E}_{k}$ of $\operatorname{Aut}\left(\mathbb{C}^{k}\right)$. Moreover we have the inclusions

$$
\operatorname{GL}\left(\mathbb{C}^{k}\right) \subset \operatorname{Aff}_{k} \subset \operatorname{Aut}\left(\mathbb{C}^{k}\right)
$$

where $\mathrm{Aff}_{k}$ denotes the group of affine maps

$$
f:\left(z_{0}, z_{1}, \ldots, z_{k-1}\right) \mapsto\left(f_{0}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right), f_{1}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right), \ldots, f_{k-1}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right)\right)
$$

with $f_{i}$ affine; $\operatorname{Aff}_{k}$ is the semi-direct product of $\mathrm{GL}\left(\mathbb{C}^{k}\right)$ with the commutative subgroups of translations. The subgroup $\operatorname{Tame}_{k} \subset \operatorname{Aut}\left(\mathbb{C}^{k}\right)$ generated by $\mathrm{E}_{k}$ and $\mathrm{Aff}_{k}$ is called the group of tame automorphisms. If $k=2$ one has:

Theorem 2.1 ([6]). In dimension 2 the group of tame automorphisms coincides with the whole group of polynomial automorphism; more precisely

$$
\operatorname{Aut}\left(\mathbb{C}^{2}\right)=\operatorname{Aff}_{2} *_{\operatorname{Aff}_{2} \cap \mathrm{E}_{2}} \mathrm{E}_{2}
$$

But this is not the case in higher dimension: $\operatorname{Tame}_{3} \subsetneq \operatorname{Aut}\left(\mathbb{C}^{3}\right)($ see [9]).
Another important result in dimension 2 is the following:
Theorem 2.2 ([4]). Let $f$ be an element of $\operatorname{Aut}\left(\mathbb{C}^{2}\right)$. Then, up to conjugacy,

- either $f$ belongs to $\mathrm{E}_{2}$,
- or $f$ can be written as

$$
\varphi_{\ell} \circ \varphi_{\ell-1} \circ \ldots \varphi_{1}
$$

where $\varphi_{i}:\left(z_{0}, z_{1}\right) \mapsto\left(z_{1}, P_{i}\left(z_{1}\right)-\delta_{i} z_{0}\right), \delta_{i} \in \mathbb{C}^{*}, P_{i} \in \mathbb{C}\left[z_{1}\right], \operatorname{deg} P_{i} \geq 2$.
We denote by $\mathcal{H}$ the set of polynomial automorphisms of $\mathbb{C}^{2}$ can be written up to conjugacy as

$$
\varphi_{\ell} \circ \varphi_{\ell-1} \circ \ldots \varphi_{1}
$$

where $\varphi_{i}:\left(z_{0}, z_{1}\right) \mapsto\left(z_{1}, P_{i}\left(z_{1}\right)-\delta_{i} z_{0}\right), \delta_{i} \in \mathbb{C}^{*}, P_{i} \in \mathbb{C}\left[z_{1}\right], \operatorname{deg} P_{i} \geq 2$. The elements of $\mathcal{H}$ are of Hénon type.

From now one we will denote $f=\left(f_{0}, f_{1}, \ldots, f_{k-1}\right)$ instead of

$$
f:\left(z_{0}, z_{1}, \ldots, z_{k-1}\right) \mapsto\left(f_{0}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right), f_{1}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right), \ldots, f_{k-1}\left(z_{0}, z_{1}, \ldots, z_{k-1}\right)\right)
$$

The algebraic degree $\operatorname{deg} f$ of $f=\left(f_{0}, f_{1}, \ldots, f_{k-1}\right) \in \operatorname{Aut}\left(\mathbb{C}^{k}\right)$ is $\max \left(\operatorname{deg} f_{0}, \operatorname{deg} f_{1}, \ldots, \operatorname{deg} f_{k-1}\right)$.
2.2. The Cremona group. A rational self map $f$ of $\mathbb{P}_{\mathbb{C}}^{k}$ can be written

$$
\left(z_{0}: z_{1}: \ldots: z_{k}\right) \longrightarrow\left(f_{0}\left(z_{0}, z_{1}, \ldots, z_{k}\right): f_{1}\left(z_{0}, z_{1}, \ldots, z_{k}\right): \ldots: f_{k}\left(z_{0}, z_{1}, \ldots, z_{k}\right)\right)
$$

where the $f_{i}$ 's are homogeneous polynomials of the same degree $\geq 1$ and without common factor of positive degree. The degree of $f$ is the degree of the $f_{i}$. If there exists a rational self map $g$ of $\mathbb{P}_{\mathbb{C}}^{k}$ such that $f g=g f=$ id we say that the rational self map $f$ of $\mathbb{P}_{\mathbb{C}}^{k}$ is birational. The set of birational self maps of $\mathbb{P}_{\mathbb{C}}^{k}$ form a group denoted $\operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{k}\right)$ and called the Cremona group. Of course $\operatorname{Aut}\left(\mathbb{C}^{k}\right)$ is a subgroup of $\operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{k}\right)$. An other natural subgroup of $\operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{k}\right)$ is the $\operatorname{group} \operatorname{Aut}\left(\mathbb{P}_{\mathbb{C}}^{k}\right) \simeq \operatorname{PGL}(k+1 ; \mathbb{C})$ of automorphisms of $\mathbb{P}_{\mathbb{C}}^{k}$.

The indeterminacy set $\operatorname{Ind}(f)$ of $f$ is the set of the common zeros of the $f_{i}$ 's. The exceptional set $\operatorname{Exc}(f)$ of $f$ is the (finite) union of subvarieties $M_{i}$ of $\mathbb{P}_{\mathbb{C}}^{k}$ such that $f$ is not injective on any open subset of $M_{i}$.
2.3. A little bit of dynamics. Let $f$ be a polynomial automorphism of $\mathbb{C}^{k}$. One can see $f$ as a birational self map of $\mathbb{P}_{\mathbb{C}}^{k}$ still denoted $f$. We will say that $f$ is algebraically stable if for any $n>0$

$$
f^{n}\left(\left\{z_{k}=0\right\} \backslash \operatorname{Ind}\left(f^{n}\right)\right)
$$

is not contained in $\operatorname{Ind}(f)$. This is equivalent to the fact that $(\operatorname{deg} f)^{n}=\operatorname{deg} f^{n}$ for any $n>0$. For instance elements of $\mathcal{H}$ are algebraically stable.

Remark 2.3. Note that in dimension 2 one usually says that $f$ is algebraically stable if for any $n>0$

$$
f^{n}\left(\left\{z_{2}=0\right\} \backslash \operatorname{Ind}\left(f^{n}\right)\right) \cap \operatorname{Ind}(f)=\emptyset .
$$

Be careful this is not equivalent in higher dimension: consider for instance

$$
f=\left(5 z_{0}^{2}+z_{2}^{2}+6 z_{0} z_{2}+z_{1}, z_{2}^{2}+z_{0}, z_{2}\right)
$$

then

- on the one hand $(-1: 0: 1: 0)$ belongs to $\left\{z_{3}=0\right\} \backslash \operatorname{Ind}(f)$ and $f(-1: 0: 1: 0)=(0: 1: 0: 0) \in$ $\operatorname{Ind}(f)=\{(0: 1: 0: 0)\}$.
- on the other hand for any $n \geq 1 \operatorname{deg} f^{n}=(\operatorname{deg} f)^{n}$.

The algebraic degree of a birational map $f$ of $\mathbb{P}_{\mathbb{C}}^{n}\left(\right.$ resp. a polynomial automorphism of $\left.\mathbb{C}^{k}\right)$ is not a dynamical invariant so we introduce the dynamical degree

$$
\lambda(f)=\lim _{n \rightarrow+\infty}\left(\operatorname{deg} f^{n}\right)^{1 / n}
$$

which is a dynamical invariant. In other words if $f \in \operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{k}\right)\left(\right.$ resp. $\left.\operatorname{Aut}\left(\mathbb{C}^{k}\right)\right)$, then for any $g \in \operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{k}\right)$ (resp. $g \in \operatorname{Aut}\left(\mathbb{C}^{k}\right)$ ) one has $\lambda(f)=\lambda\left(g f g^{-1}\right)$. For any element $f$ in $\mathcal{H}$ the algebraic and dynamical degrees coincide; more precisely if

$$
f=\varphi_{\ell} \circ \varphi_{\ell-1} \circ \ldots \circ \varphi_{1}
$$

where $\varphi_{i}=\left(z_{1}, P_{i}\left(z_{1}\right)-\delta_{i} z_{0}\right), \delta_{i} \in \mathbb{C}^{*}, P_{i} \in \mathbb{C}\left[z_{1}\right], \operatorname{deg} P_{i} \geq 2$ one has ([4])

$$
\lambda(f)=\prod_{i=1}^{\ell} \operatorname{deg} \varphi_{i} \geq 2
$$

A polynomial automorphism $f$ is in $\mathrm{E}_{k}$ if and only if for any $n \geq 1$ the equality $\operatorname{deg} f=\operatorname{deg} f^{n}$ holds hence $\lambda(f)=1$. In other words a polynomial automorphism $f$ of $\mathbb{C}^{2}$ belongs to $\mathcal{H}$ if and only if $\lambda(f)>1$. There is an other characterization of the automorphisms of Hénon type:
Theorem 2.4 ([7]). The centralizer of $f$ in $\operatorname{Aut}\left(\mathbb{C}^{2}\right)$, that is $\left\{g \in \operatorname{Aut}\left(\mathbb{C}^{2}\right) \mid f g=g f\right\}$, is countable if and only if $f$ belongs to $\mathcal{H}$.

## 3. AUTOMORPHISMS WITH POLYNOMIAL GROWTHS

3.1. The growths of a polynomial automorphisms and its inverse. If $f$ is a polynomial automorphism of $\mathbb{C}^{k}$, then $\left(\operatorname{deg} f, \operatorname{deg} f^{-1}\right)$ is the bidegree of $f$. There is a relationship between $\operatorname{deg} f$ and $\operatorname{deg} f^{-1}(\operatorname{see}[1])$ :

$$
\left\{\begin{array}{l}
\operatorname{deg} f^{-1} \leq(\operatorname{deg} f)^{k-1}  \tag{3.1}\\
\operatorname{deg} f \leq\left(\operatorname{deg} f^{-1}\right)^{k-1}
\end{array}\right.
$$

As a result if $f$ is a polynomial automorphism of $\mathbb{C}^{k}$, the degree growths of $f$ and $f^{-1}$ are linked:
Proposition 3.1. Let $f$ be a polynomial automorphism of $\mathbb{C}^{k}$.

- The sequence $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ is bounded if and only if the sequence $\left(\operatorname{deg} f^{-n}\right)_{n \in \mathbb{N}}$ is bounded.
- The sequence $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ grows exponentially if and only if $\left(\operatorname{deg} f^{-n}\right)_{n \in \mathbb{N}}$ grows exponentially.
- If $\operatorname{deg} f^{n} \simeq n^{p}$ and $\operatorname{deg} f^{-n} \simeq n^{q}$ for some integers $p, q \geq 1$, then

$$
(p, q) \in\left\{\left(\left[\frac{q+1}{k}\right], q\right), \ldots,(k q, q)\right\}
$$

Remark 3.2. When we write "The sequence $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ grows exponentially if and only if $\left(\operatorname{deg} f^{-n}\right)_{n \in \mathbb{N}}$ grows exponentially" it does not mean that $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ and $\left(\operatorname{deg} f^{-n}\right)_{n \in \mathbb{N}}$ have exactly the same behavior: the polynomial automorphism of $\mathbb{C}^{3}$ given by $f=\left(z_{0}^{2}+z_{1}+z_{2}, z_{0}^{2}+z_{1}, z_{0}\right)$ satisfies forall $n \geq 1$

$$
\left\{\begin{array}{l}
\operatorname{deg} f^{n}=2^{n} \\
\operatorname{deg} f^{-n}=2^{\left[\frac{n+1}{2}\right]}
\end{array}\right.
$$

3.2. Examples of polynomial automorphisms with new polynomial growths. Let us now give examples of polynomial automorphisms with polynomial growths.
Lemma 3.3. Let us consider the polynomial automorphism of $\mathbb{C}^{3}$ given by

$$
f=\left(z_{1}+z_{0} z_{2}^{d}, z_{0}, z_{2}\right)
$$

where $d \geq 1$. One has $\operatorname{deg} f^{n}=d n+1$ and $\operatorname{deg} f^{n}=\operatorname{deg} f^{-n}$ for any $n \geq 1$.
Proof. Assume $n \geq 1$. Set $f^{n}=\left(f_{0, n}, f_{1, n}, z_{2}\right)$ and $\delta_{n}=\operatorname{deg} f^{n}$. Note that $\delta_{1}=d+1$ and since

$$
f^{n}=f f^{n-1}=\left(f_{1, n-1}+f_{0, n-1} z_{2}^{d}, f_{0, n-1}, z_{2}\right)
$$

one has

$$
\delta_{n}=\max \left(\operatorname{deg} f_{1, n-1}, \operatorname{deg} f_{0, n-1}+d, \operatorname{deg} f_{0, n-1}, 1\right)
$$

But $f_{1, n-1}=f_{0, n-2}$ and $d \geq 1$ so $\delta_{n}=\operatorname{deg} f_{0, n-1}+d=\delta_{n-1}+d$.

Similarly one can prove:
Lemma 3.4. Let us consider the polynomial automorphism of $\mathbb{C}^{5}$ given by

$$
g=\left(z_{1}+z_{0} z_{2}^{d}, z_{0}, z_{2}, z_{4}+z_{0}^{p} z_{3}, z_{3}\right)
$$

where $p \geq d \geq 1$. One has for any $n \geq 1$

$$
\operatorname{deg} g^{n}=\frac{p d}{2} n^{2}+\frac{p(2-d)}{2} n+1
$$

and $\operatorname{deg} g^{n}=\operatorname{deg} g^{-n}$ for any $n \geq 1$.
Let us consider the polynomial automorphism of $\mathbb{C}^{7}$ given by

$$
h=\left(z_{1}+z_{0} z_{2}^{d}, z_{0}, z_{2}, z_{4}+z_{0}^{p} z_{3}, z_{3}, z_{6}+z_{3}^{\ell} z_{5}, z_{5}\right)
$$

where $\ell \geq p \geq d \geq 1$. For any $n \geq 1$

$$
\operatorname{deg} h^{n}=1+\ell\left(1-\frac{p}{2}+\frac{p d}{3}\right) n+\frac{\ell p(1-d)}{2} n^{2}+\frac{\ell p d}{6} n^{3}
$$

and $\operatorname{deg} h^{n}=\operatorname{deg} h^{-n}$.
So Lemma 3.3 gives an example $f$ of polynomial automorphism of $\mathbb{C}^{3}$ with linear growth; from $f$ one gets a polynomial automorphism $g$ of $\mathbb{C}^{5}$ such that $\operatorname{deg} g^{n} \sim n^{2}$, and from $g$ one gets a polynomial automorphism $h$ of $\mathbb{C}^{7}$ such that $\operatorname{deg} h^{n} \sim n^{3}$ (Lemma 3.4). By repeating this process one gets the following statement:
Proposition 3.5. There exist polynomial automorphisms $f$ of $\mathbb{C}^{2 k+1}, k \geq 2$, such that

$$
\operatorname{deg} f^{n} \sim n^{k}
$$

Theorem A follows from Proposition 3.5.
3.3. A consequence. Come back to $f=\left(z_{1}+z_{0} z_{2}^{d}, z_{0}, z_{2}\right)$ and consider the birational map of $\mathbb{P}_{\mathbb{C}}^{4}$ given by $F=\left(f, z_{0}^{p} z_{3}\right)$, that is $F=\left(z_{1}+z_{0} z_{2}^{d}, z_{0}, z_{2}, z_{0}^{p} z_{3}\right)$. Assume that $d \leq p$. Then one can prove by induction that for any $n \geq 1$

$$
\operatorname{deg} F^{n}=\frac{p d}{2} n^{2}+\frac{p(2-d)}{2} n+1 .
$$

Let us now define the birational map $F$ of $\mathbb{P}_{\mathbb{C}}^{5}$ by

$$
G=\left(z_{1}+z_{0} z_{2}^{d}, z_{0}, z_{2}, z_{0}^{p} z_{3}, z_{3}^{\ell} z_{4}\right)
$$

for any $n \geq 1$ one has

$$
\operatorname{deg} G^{n}=\frac{\ell p d}{6} n^{3}+\left(1-\frac{3 d}{4}\right) \ell p n^{2}+\left(\frac{13}{12} p d-2 p+1\right) \ell n-\frac{\ell p d}{2}+\ell p+1
$$

Repeating this process one gets
Proposition 3.6. If $k \geq 3$, then for any $0 \leq \ell \leq k-2$ there exist birational maps $F$ of $\mathbb{P}_{\mathbb{C}}^{k}$ such that

$$
\operatorname{deg} F^{n} \sim n^{\ell}
$$

## 4. Properties $\left(\mathcal{P}_{i}\right)$

Note that Theorem 2.4 can be also stated as follows: the centralizer of a polyonomial automorphism $f$ of $\mathbb{C}^{2}$ is countable if and only if $\left(\operatorname{deg} f^{n}\right)_{n \in \mathbb{N}}$ grows exponentially. This property is not true in higher dimension: there exist polynomial automorphisms of $\mathbb{C}^{3}$ with uncountable centralizer and exponential degree growth ([2]). Let us now that this is also the case for other properties, and in particular for $\left(\mathcal{P}_{1}\right),\left(\mathcal{P}_{2}\right),\left(\mathcal{P}_{3}\right)$, $\left(\mathcal{P}_{4}\right)$.
4.1. Property $\left(\mathcal{P}_{1}\right)$. Property $\left(\mathcal{P}_{1}\right)$ is not satisfied in dimension 3:

Proposition 4.1. If

$$
f=\left(z_{2},\left(z_{2}^{2}+z_{0}\right)^{2}+z_{2}^{2}+z_{0}+z_{1}, z_{2}^{2}+z_{0}\right)
$$

then
$-\operatorname{Ind}(f)=\left\{z_{2}=z_{3}=0\right\}$ and $z_{3}=0$ is blown down by $f$ onto $(0: 1: 0: 0) \in \operatorname{Ind}(f)$,

- for all $n \geq 1$ one has $\operatorname{deg} f^{n}=2^{n+1}$.
4.2. Property $\left(\mathcal{P}_{2}\right)$. Property $\left(\mathcal{P}_{2}\right)$ does not hold in higher dimension:

Proposition 4.2. The polynomial automorphism $f$ of $\mathbb{C}^{3}$ given by

$$
\left(z_{0}^{2}+z_{1}, z_{0}, z_{2}+1\right)
$$

preserves the fibration $z_{2}=c s t$ and for all $n \geq 1$ the equality $\operatorname{deg} f^{n}=2^{n}$ holds.
The polynomial automorphism $g$ of $\mathbb{C}^{3}$ given by

$$
\left(z_{1}^{2}+z_{0} z_{1}+z_{2}, z_{1}+1, z_{0}\right)
$$

preserves the fibration $z_{1}=$ cst and for all $n \geq 1$ the equality $\operatorname{deg} g^{n}=n+1$ holds.
4.3. Property $\left(\mathscr{P}_{3}\right)$. Property $\left(\mathscr{P}_{3}\right)$ is not satisfied in dimension 3.

Proposition 4.3. Let us consider the polynomial automorphisms $f$ and $g$ of $\mathbb{C}^{3}$ defined by

$$
f=\left(z_{0}+z_{1}+z_{2}, z_{0}^{2}+z_{0}+z_{1}, z_{0}\right), \quad g=\left(z_{1}^{2}+z_{0}+z_{1}+z_{2}, z_{1}, z_{0}\right)
$$

For all $n \geq 1$ one has

$$
\left\{\begin{array}{l}
\operatorname{deg} f^{2 n}=2^{n+1}, \operatorname{deg} f^{2 n+1}=2^{n+1} \\
\operatorname{deg} f^{-n}=2^{n} \\
\operatorname{deg} g^{n}=\operatorname{deg} g^{-n}=2
\end{array}\right.
$$

The automorphism $f$ sends $z_{3}=0$ onto $(0: 1: 0: 0)$ and $f^{-1}$ sends $z_{3}=0$ onto $(0: 1: 1: 0)$. Furthermore $\operatorname{Ind}(f)=\left\{z_{0}=z_{3}=0\right\}$ and $\operatorname{Ind}\left(f^{-1}\right)=\left\{z_{2}=z_{3}=0\right\}$.

The automorphism $g$ sends $z_{3}=0$ onto $(1: 0: 0: 0)$ and $g^{-1}$ sends $z_{3}=0$ onto $(0: 0: 1: 0)$. Besides $\operatorname{Ind}(g)=\left\{z_{1}=z_{3}=0\right\}$ and $\operatorname{Ind}\left(g^{-1}\right)=\left\{z_{2}=z_{3}=0\right\}$.
4.4. Property $\left(\mathscr{P}_{4}\right)$. In [5] Furter proves that if $f$ is a polynomial automorphism of $\mathbb{C}^{2}$ then $\operatorname{deg} f^{2}=$ $(\operatorname{deg} f)^{2}$ if and only if $\operatorname{deg} f^{n}=(\operatorname{deg} f)^{n}$ for all $n \in \mathbb{N}$. This property does not hold in higher dimension: consider for instance the polynomial automorphism $f$ given by

$$
f=\left(z_{1}^{2}+z_{5}, z_{5}^{2}+z_{4}, z_{2}, z_{1}, z_{0}, z_{4}^{2}+z_{3}\right)
$$

One can check that $\operatorname{deg} f=2, \operatorname{deg} f^{2}=4, \operatorname{deg} f^{3}=8$ but $\operatorname{deg} f^{4}=8$.
Let $f$ be a polynomial automorphism of $\mathbb{C}^{k}$. For any integer $n \geq 0$ set $\Omega_{n}=f^{n}\left(\left(z_{k-1}=0\right) \backslash \operatorname{Ind}\left(f^{n}\right)\right)$; note that $\Omega_{n} \subset\left(z_{k-1}=0\right)$ for any $n$. We say that $f$ is not algebraically stable after $\ell$ steps if $\ell$ is the smallest integer such that $\Omega_{\ell} \subset \operatorname{Ind}(f)$.

Let us first remark that if $\Omega_{1} \cap \operatorname{Ind}(f)=\emptyset$, then $\Omega_{2}=f\left(\Omega_{1}\right) \subseteq \Omega_{1}$ so $\Omega_{2} \cap \operatorname{Ind}(f)=\emptyset$. By induction one gets for any $n \geq 1$ that $\Omega_{n} \cap \operatorname{Ind}(f)=\emptyset$ and $\operatorname{deg} f^{n}=(\operatorname{deg} f)^{n}$, i.e. $f$ is algebraically stable.

Let us now assume that $\Omega_{1} \cap \operatorname{Ind}(f) \neq \emptyset$. Then:
(1) Either $\Omega_{1} \subset \operatorname{Ind}(f)$, that is $f$ is not algebraically stable after 1 step.
(2) $\operatorname{Or} \Omega_{1} \not \subset \operatorname{Ind}(f)$ hence $\Omega_{2}=f\left(\Omega_{1} \backslash \operatorname{Ind}(f)\right) \subseteq \Omega_{1}$.

- Either $\operatorname{dim} \Omega_{2}=\operatorname{dim} \Omega_{1}$, so $\Omega_{2}=\Omega_{1}$ and then $\Omega_{n}=\Omega_{1}$ for any $n$; in particular $\Omega_{n} \not \subset \operatorname{Ind}(f)$ for any $n$ and $f$ is algebraically stable.
- Or $\operatorname{dim} \Omega_{2}<\operatorname{dim} \Omega_{1}$, then either $\Omega_{2} \subset \operatorname{Ind}(f)$ and $f$ is not algebraically stable after 2 steps or $\Omega_{2} \not \subset \operatorname{Ind}(f)$ and we come back to the previous alternative, that is either $\operatorname{dim} \Omega_{3}=\operatorname{dim} \Omega_{2}$ or $\operatorname{dim} \Omega_{3}<\operatorname{dim} \Omega_{2}$. Since for any $n$ one has $0 \leq \operatorname{dim} \Omega_{n} \leq k-1$ one gets that either $f$ is algebraically stable, or $f$ is not algebraically stable after at most $k-1$ steps.
Hence one can state:
Proposition 4.4. Let $f$ be a polynomial automorphism of $\mathbb{C}^{k}$. Either $f$ is algebraically stable, or $f$ is not algebraically stable after $\ell$ steps, with $\ell \leq k-1$.

In other words $\operatorname{deg} f^{i}=(\operatorname{deg} f)^{i}$ for $1 \leq i \leq k$ if and only if $\operatorname{deg} f^{n}=(\operatorname{deg} f)^{n}$ for any $n \geq 1$.

## 5. Birational maps with new polynomial growths

Let us first recall that
Lemma 5.1 ([3]). The birational self $\operatorname{map} \varphi$ of $\mathbb{P}_{\mathbb{C}}^{2}$ given in the affine chart $z_{2}=1$ by

$$
\varphi\left(z_{0}, z_{1}\right)=\left(z_{1}+\frac{2}{3}, z_{0} \frac{z_{1}-\frac{1}{3}}{z_{1}+1}\right)
$$

satisfies $\operatorname{deg} \varphi^{n} \sim n^{2}$.
Denote $\varphi^{n}$ by $\left(\frac{P_{n}}{Q_{n}}, \frac{R_{n}}{S_{n}}\right)$ where $P_{n}, Q_{n}, R_{n}$ and $S_{n}$ denote some elements of $\mathbb{C}\left[z_{0}, z_{1}\right]$ without common factor. Set $p_{n}=\operatorname{deg} P_{n}, q_{n}=\operatorname{deg} Q_{n}, r_{n}=\operatorname{deg} R_{n}$ and $s_{n}=\operatorname{deg} S_{n}$. The following equalities hold (by iteration)

$$
\left\{\begin{array}{l}
p_{n}=s_{n-1}+1 \\
q_{n}=s_{n-1} \\
r_{n}=s_{n}+1 \\
\operatorname{deg} \varphi^{n}=s_{n-1}+s_{n}+1
\end{array}\right.
$$

Let us now consider the birational self map of $\mathbb{P}_{\mathbb{C}}^{3}$ given in the affine chart $z_{3}=1$ by

$$
\Psi_{3}\left(z_{0}, z_{1}, z_{2}\right)=\left(z_{1}+\frac{2}{3}, z_{0} \frac{z_{1}-\frac{1}{3}}{z_{1}+1}, z_{0} z_{2}\right)
$$

One can also check that

$$
\Psi_{3}=\left(\frac{P_{n}}{Q_{n}}, \frac{R_{n}}{S_{n}}, \frac{U_{n}}{V_{n}}\right)
$$

where $U_{n}=z_{0} z_{2} P_{1} P_{2} \ldots P_{n-1}$ and $V_{n}=Q_{1} Q_{2} \ldots Q_{n-1}$ have no common factor. Since $s_{i} \sim i^{2}$ one gets:
Lemma 5.2. The birational self map $\Psi_{3}$ of $\mathbb{P}_{\mathbb{C}}^{3}$ satisfies

$$
\operatorname{deg} \Psi_{3} \sim n^{3}
$$

Let us now consider the birational self map of $\mathbb{P}_{\mathbb{C}}^{4}$ defined in the affine chart $z_{4}=1$ by

$$
\Psi_{4}\left(z_{0}, z_{1}, z_{2}, z_{3}\right)=\left(z_{1}+\frac{2}{3}, z_{0} \frac{z_{1}-\frac{1}{3}}{z_{1}+1}, z_{0} z_{2}, z_{2} z_{3}\right)
$$

One can check that $\Psi_{4}=\left(\frac{P_{n}}{Q_{n}}, \frac{R_{n}}{S_{n}}, \frac{U_{n}}{V_{n}}, \frac{W_{n}}{X_{n}}\right)$ where $W_{n}=W_{1} U_{1} U_{2} \ldots U_{n-1}$ and $X_{n}=X_{1} V_{1} V_{2} \ldots V_{n-1}$ have no common factor. Since $\operatorname{deg} U_{n} \sim n^{3}$ and $\operatorname{deg} V_{n} \sim n^{3}$ one has:

Lemma 5.3. The birational self map $\Psi_{4}$ of $\mathbb{P}_{\mathbb{C}}^{4}$ satisfies

$$
\operatorname{deg} \Psi_{4} \sim n^{4}
$$

By repeating this process one gets:
Theorem 5.4. Let $k$ be an integer $\geq 3$. There exist birational maps $\phi$ of $\mathbb{P}_{\mathbb{C}}^{k}$ such that

$$
\operatorname{deg} \phi^{n} \sim n^{k} .
$$

This statement and Lin's result ([8]) imply Theorem D.
