# ON CUBIC BIRATIONAL MAPS OF $\mathbb{P}_{\mathbb{C}}^{3}$ 

JULIE DÉSERTI AND FRÉDÉRIC HAN


#### Abstract

We study the birational maps of $\mathbb{P}_{\mathbb{C}}^{3}$. More precisely we describe the irreducible components of the set of birational maps of bidegree $(3,3)$ (resp. $(3,4)$, resp. $(3,5)$ ).


## 1. InTRODUCTION

The Cremona group, denoted $\operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{n}\right)$, is the group of birational maps of $\mathbb{P}_{\mathbb{C}}^{n}$ into itself. If $n=2$ a lot of properties have been established (see [4, 7] for example). As far as we know the situation is much more different for $n \geq 3$ (see $[12,3]$ for example). If $\psi$ is an element of $\operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{2}\right)$ then $\operatorname{deg} \psi=\operatorname{deg} \psi^{-1}$. It is not the case in higher dimensions; if $\psi$ belongs to $\operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ we only have the inequality $\operatorname{deg} \psi^{-1} \leq(\operatorname{deg} \psi)^{2}$ so one introduces the bidegree of $\psi$ as the pair $\left(\operatorname{deg} \psi, \operatorname{deg} \psi^{-1}\right)$. For $n=2, \mathfrak{B i x}_{d}\left(\mathbb{P}_{\mathbb{C}}^{2}\right)$ is the set of birational maps of the complex projective plane of degree $d$; for $n \geq 3$ denote by $\operatorname{Bir}_{d, d^{\prime}}\left(\mathbb{P}_{\mathbb{C}}^{n}\right)$ the set of elements of $\operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{n}\right)$ of bidegree $\left(d, d^{\prime}\right)$, and by $\mathfrak{B i r}\left(\mathbb{P}_{\mathbb{C}}^{n}\right)$ the union $\cup_{d^{\prime}} \operatorname{Bir}_{d, d^{\prime}}\left(\mathbb{P}_{\mathbb{C}}^{n}\right)$.

In [5] the sets $\mathfrak{B i r}{\underset{2}{ }}^{\left(\mathbb{P}_{\mathbb{C}}^{2}\right) \text {, and } \mathfrak{B i r}}\left(\mathbb{P}_{\mathbb{C}}^{2}\right)$ are described: $\mathfrak{B i r}_{2}\left(\mathbb{P}_{\mathbb{C}}^{2}\right)$ is smooth, and irreducible in the space of quadratic rational maps of the complex projective plane whereas $\mathfrak{B i r}\left(\mathbb{P}_{\mathbb{C}}^{2}\right)$ is irreducible, and rationnally connected. Besides, $\mathfrak{B i x}_{d}\left(\mathbb{P}_{\mathbb{C}}^{2}\right)$ is not irreducible as soon as $d>3$ (see [2]). In [6] CREmONA studies three types of generic elements of $\mathfrak{B i} \mathfrak{i r}_{2}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$. Then there were some articles on the subject, and finally a precise description of $\mathfrak{B i r} \mathfrak{r}_{2}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$; the left-right conjugacy is the following one

$$
\operatorname{PGL}(4 ; \mathbb{C}) \times \operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{3}\right) \times \operatorname{PGL}(4 ; \mathbb{C}) \rightarrow \operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{3}\right), \quad(A, \psi, B) \mapsto A \psi B^{-1}
$$

Pan, Ronga and Vust give quadratic birational maps of $\mathbb{P}_{\mathbb{C}}^{3}$ up to left-right conjugacy, and show that there are only finitely many biclasses ([13, Theorems 3.1.1, 3.2.1, 3.2.2, 3.3.1]). In particular they show that $\mathfrak{B i r}_{2}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ has three irreducible components of dimension $26,28,29$; the component of dimension 26 (resp. 28, resp. 29) corresponds to birational maps of bidegree $(2,4)$ (resp. $(2,3)$, resp. $(2,2)$ ). We will see that the situation is slightly different for $\mathfrak{B i r} \mathfrak{r}_{3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$; in particular we cannot expect such an explicit list of biclasses because there are infinitely many of biclasses (already the dimension of the family $\mathcal{E}_{2}$ of the classic cubo-cubic example is 39 that is strictly larger that $\operatorname{dim}(\operatorname{PGL}(4 ; \mathbb{C}) \times \operatorname{PGL}(4 ; \mathbb{C}))=30)$. That's why the approach is different.

We do not have such a precise description of $\mathfrak{B i x}{ }_{d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ for $d \geq 4$. Nevertheless we can find a very fine and classical contribution for $\mathfrak{B i r}_{3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ due to HUDSON ([9]); in §A we reproduce Table VI of [9]. HUdSON introduces there some invariants to establish her classification. But it gives rise to many cases, and we also find examples where invariants take values that do not

[^0]appear in her table. We do not know references explaining how her families fall into irreducible components of $\mathrm{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ so we focus on this natural question.

Definition. An element $\psi$ of $\operatorname{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is ruled if the strict transform of a generic plane under $\psi^{-1}$ is a ruled cubic surface.

Denote by $\mathfrak{r u l e d}_{3, d}$ the set of $(3, d)$ ruled maps. Let us remark that there are no ruled birational maps of bidegree $(3, d)$ with $d \geq 6$. We detail $\mathfrak{r u l e d}_{3, d}$ in Lemma 2.3.

We describe the irreducible components of $\operatorname{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ for $3 \leq d \leq 5$. Let us recall that the inverse of an element of $\operatorname{Bir}_{3,2}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is quadratic and treated in [13].

Theorem A. Assume that $2 \leq d \leq 5$. The set $\mathfrak{r u l e d}_{3, d}$ is an irreducible component of $\operatorname{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$.
In bidegree $(3,3)$ (resp. $(3,4))$ there is only an other irreducible component; in bidegree $(3,5)$ there are three others.

The set $\mathfrak{r u l e d} \boldsymbol{d}_{3,3}$ intersects the closure of any irreducible component of $\overline{\operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)}$ (the closures being taken in $\mathfrak{B i x}_{3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ ).

Notations 1.1. Consider a dominant rational map $\psi$ from $\mathbb{P}_{\mathbb{C}}^{3}$ into itself. For a generic line $\ell$, the preimage of $\ell$ by $\psi$ is a complete intersection $\Gamma_{\ell}$; let $\mathcal{C}_{2}$ be the union of the irreducible components of $\Gamma_{\ell}$ supported in the base locus of $\psi$. Define $\mathcal{C}_{1}$ by liaison from $\mathcal{C}_{2}$ in $\Gamma_{\ell}$. Remark that if $\psi$ is birational, then $\mathcal{C}_{1}=\psi_{*}^{-1}(\ell)$. Let us denote by $\mathfrak{p}_{a}\left(\mathcal{C}_{i}\right)$ the arithmetic genus of $\mathcal{C}_{i}$.

It is difficult to find a uniform approach to classify elements of $\mathfrak{B i r} \mathfrak{r}_{3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$. Nevertheless in small genus we succeed to obtain some common detailed results; before stating them, let us introduce some notations.

Let us remark that the inequality $\operatorname{deg} \psi^{-1} \leq(\operatorname{deg} \psi)^{2}$ mentioned previously directly follows from

$$
(\operatorname{deg} \psi)^{2}=\operatorname{deg} \psi^{-1}+\operatorname{deg} \mathcal{C}_{2}
$$

Proposition B. Let $\psi$ be a $(3, d)$ birational map.
Assume that $\psi$ is not ruled, and $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=0$, i.e. $\mathcal{C}_{1}$ is smooth. Then

- $d \leq 6$;
- and $\mathcal{C}_{2}$ is a curve of degree $9-d$, and arithmetic genus $9-2 d$.

Suppose $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=1$, and $2 \leq d \leq 6$. Then

- there exists a singular point $p$ of $\mathcal{C}_{1}$ independent of the choice of $\mathcal{C}_{1}$;
- if $d \leq 4$, all the cubic surfaces of the linear system $\Lambda_{\psi}$ are singular at $p$;
- the curve $\mathcal{C}_{2}$ is of degree $9-d$, of arithmetic genus $10-2 d$, and lies on a unique quadric $Q$; more precisely $I_{\mathcal{C}_{2}}=\left(Q, S_{1}, \ldots, S_{d-2}\right)$ where the $S_{i}$ 's are independent cubics modulo $Q$.

We denote by $\operatorname{Bir}_{3, d, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ the subset of non-ruled $(3, d)$ birational maps such that $\mathcal{C}_{2}$ is of degree $9-d$, and arithmetic genus $\mathfrak{p}_{2}$. One has the following statement:
Theorem C. If $\mathfrak{p}_{2} \in\{3,4\}$, then $\operatorname{Bir}_{3,3, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty, and irreducible; $\operatorname{Bir}_{3,3, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is empty as soon as $\mathfrak{p}_{2} \notin\{3,4\}$.

If $\mathfrak{p}_{2} \in\{1,2\}$, then $\operatorname{Bir}_{3,4, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty, and irreducible; $\operatorname{Bir}_{3,4, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is empty as soon as $\mathfrak{p}_{2} \notin\{1,2\}$.

The set $\operatorname{Bir}_{3,5, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is empty as soon as $\mathfrak{p}_{2} \notin\{-1,0,1\}$ and

- if $\mathfrak{p}_{2}=-1$, then $\operatorname{Bir}_{3,5, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty, and irreducible;
- if $\mathfrak{p}_{2}=0$, then $\operatorname{Bir}_{3,5, p_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty, and has two irreducible components;
- if $\mathfrak{p}_{2}=1$, then $\operatorname{Bir}_{3,5, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty, and has three irreducible components.

Organization of the article. In $\S 2$ we explain the particular case of ruled birational maps and set some notations. Then $\S 3$ is devoted to liaison theory that plays a big role in the description of the irreducible components of $\operatorname{Bir}_{3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)($ see $\S 4), \operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)\left(\right.$ see §5) and $\operatorname{Bir}_{3,5}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)($ see §6). In the last section we give some illustrations of invariants considered by HUDSON, especially concerning the local study of the preimage of a line. Since HudSOn's book is very old, let us recall her classification in the first part of the appendix.

## 2. DEFINITIONS, NOTATIONS AND FIRST PROPERTIES

2.1. Definitions and notations. Let $\psi: \mathbb{P}_{\mathbb{C}}^{3} \longrightarrow \mathbb{P}_{\mathbb{C}}^{3}$ be a rational map given, for some choice of coordinates, by

$$
\left(z_{0}: z_{1}: z_{2}: z_{3}\right) \longrightarrow\left(\psi_{0}\left(z_{0}, z_{1}, z_{2}, z_{3}\right): \psi_{1}\left(z_{0}, z_{1}, z_{2}, z_{3}\right): \psi_{2}\left(z_{0}, z_{1}, z_{2}, z_{3}\right): \psi_{3}\left(z_{0}, z_{1}, z_{2}, z_{3}\right)\right)
$$

where the $\psi_{i}$ 's are homogeneous polynomials of the same degree $d$, and without common factors. The map $\psi$ is called a Cremona transformation or a birational map of $\mathbb{P}_{\mathbb{C}}^{3}$ if it has a rational inverse $\psi^{-1}$. The degree of $\psi$, denoted $\operatorname{deg} \psi$, is $d$. The pair $\left(\operatorname{deg} \psi, \operatorname{deg} \psi^{-1}\right)$ is the bidegree of $\psi$, we say that $\psi$ is a $\left(\operatorname{deg} \psi, \operatorname{deg} \psi^{-1}\right)$ birational map. The indeterminacy set of $\psi$ is the set of the common zeros of the $\psi_{i}$ 's. Denote by $I_{\psi}$ the ideal generated by the $\psi_{i}$ 's, and by $\Lambda_{\psi} \subset \mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathbf{C}}^{3}}(d)\right)$ the subspace of dimension 4 generated by the $\psi_{i}$, and by deg $I_{\psi}$ the degree of the scheme defined by the ideal $I_{\psi}$. The scheme whose ideal is $I_{\psi}$ is denoted $F_{\psi}$. It is called base locus of $\psi$. If $\operatorname{dim} F_{\psi}=0$ than $F_{\psi}^{1}=\emptyset$, otherwise $F_{\psi}^{1}$ is the maximal subscheme of $F_{\psi}$ of dimension 1 without isolated point, and without embedded point. Furthermore if $\mathcal{C}_{i}$ is a curve, then $\omega_{\mathcal{C}_{i}}$ is its dualizing sheaf.
Remark 2.1. The second condition can also be stated as follows: $\mathbb{P}_{\mathbb{C}}^{3} \rightarrow|\mathcal{I}(3)|=\mathbb{P}_{\mathbb{C}}^{3+k}$ has an image of dimension 3 , and degree $k+1$.

Let us give a few comments about Table VI of [9]. For any subscheme $X$ of $\mathbb{P}_{\mathbb{C}}^{3}$ denote by $I_{X}$ the ideal of $X$ in $\mathbb{P}_{\mathbb{C}}^{3}$. Let $\psi$ be a $(3, d)$ birational map. A point $p$ is a double point if all the cubic surfaces of $\Lambda_{\psi}$ are singular at $p$. A point $p$ is a binode if all the cubic surfaces of $\Lambda_{\psi}$ are singular at $p$ with order 2 approximation at $p$ a quadratic form of rank $\leq 2$ (but this quadratic form is allowed to vary in $\Lambda_{\psi}$ ). In other words $p$ is a binode if there is a degree 1 element $h$ of $I_{p}$ such that all the cubics belong to $\left(h \cdot I_{p}\right)+I_{p}^{3}$. A point $p$ is a double point of contact if the general element of $\Lambda_{\psi}$ is singular at $p$ with order 2 approximation at $p$ a quadratic form generically constant on $\Lambda_{\psi}$. In other words $p$ is a double point of contact if all the cubics belong to $I_{p}^{3}+(Q)$ with $Q$ of degree 2 and singular at $p$. A point $p$ is a point of contact if all the cubics belong to $I_{p}^{2}+(S)$ where $S$ is a cubic smooth at $p$. A point $p$ is a point of osculation if all the cubics belong to $I_{p}^{3}+(\mathcal{S})$ where $\mathcal{S}$ is a cubic smooth at $p$.

Notations 2.2. We will denote by $\mathfrak{E}_{i}$ the $i$-th family of Table VI and by $\mathbb{C}\left[z_{0}, z_{1}, \ldots, z_{n}\right]_{d}$ the set of homogeneous polynomials of degree $d$ in the variables $z_{0}, z_{1}, \ldots, z_{n}$.
2.2. First properties. Let us now focus on particular birational maps that cannot be dealt as the others: the ruled birational maps of $\mathbb{P}_{\mathbb{C}}^{3}$. Recall that there are two projective models of irreducible ruled cubic surfaces ; they both have the same normalization: $\mathbb{P}_{\mathbb{C}}^{2}$ blown up at one point which can be realized as a cubic surface in $\mathbb{P}_{\mathbb{C}}^{4}$ (see [8, Chapter 10, introduction of § 4.4], [8, Chapter 9, § 2.1]).

Lemma 2.3. Assume that $2 \leq d \leq 5$.

- The set $\mathfrak{r u l e d}_{3, d}$ is irreducible.
- Let $\psi$ be a general element of $\mathfrak{r u l e d}_{3, d}$, and let $\delta$ be the common line to all elements of $\left\{\operatorname{Sing} \mathcal{S} \mid \mathcal{S} \in \Lambda_{\psi}\right\}$; then

$$
I_{\psi}=I_{\delta}^{2} \cap I_{\Delta_{1}} \cap I_{\Delta_{2}} \cap \ldots \cap I_{\Delta_{5-d}} \cap I_{K}
$$

where $\Delta_{i}$ are disjoint lines that intersect $\delta$ at a unique point, and $K$ is a general reduced scheme of length $2 d-4$.

Proof. Let $\psi$ be an element of $\mathfrak{r u l e d}_{3, d}$. Recall that $F_{\psi}^{1}$ is the maximal subscheme of $F_{\psi}$ of dimension 1 without isolated point, and without embedded point, i.e. $F_{\psi}^{1}$ is a curve locally COHENMacaulay. Let us define $I_{K}$ by: $I_{K}=\left(I_{\psi}: I_{F_{\psi}^{1}}\right)$.

An irreducible element $S$ of $\Lambda_{\psi}$ is a ruled surface; it is also the projection of a ruled surface $\widetilde{\mathcal{S}}$ of $\mathbb{P}_{\mathbb{C}}^{4}$. Recall that $\widetilde{\mathcal{S}}$ is also the blow-up $\widetilde{\mathbb{P}_{\mathbb{C}}^{2}}(p)$ of $\mathbb{P}_{\mathbb{C}}^{2}$ at $p$ embedded by $\left|I_{p}(2 h)\right|$, where $h$ is the class of an hyperplane in $\mathbb{P}_{\mathbb{C}}^{2}$. Let us denote by $\pi$ the projection $\widetilde{\mathcal{S}} \rightarrow \mathcal{S}$, by $H$ the class of an hyperplane of $\mathbb{P}_{\mathbb{C}}^{4}$, and by $E_{p}$ the exceptional divisor associated to the blow-up of $p$. Set $\widetilde{\delta}=\pi^{-1} \delta$, $\widetilde{\mathcal{C}}_{1}=\pi^{-1}\left(\mathcal{C}_{1}\right)$, and $\widetilde{F_{\psi}^{1}}=\pi^{-1}\left(F_{\psi}^{1}\right)$. One has

$$
\widetilde{\delta}=h, \quad H=2 h-E_{p}, \quad f=h-E_{p}, \quad \widetilde{F_{\psi}^{1}}=2 \widetilde{\delta}+D
$$

where $D$ is an effective divisor. As $\widetilde{\mathcal{C}}_{1}+\widetilde{F_{\psi}^{1}}=3 H, \widetilde{\mathcal{C}}_{1} \cdot f=1$ and $\widetilde{\mathcal{C}}_{1} \cdot H=d$ one gets $D \cdot f=0$, and $D \cdot H=5-d$; therefore $D=(5-d) f$. And we conclude that $\psi$ has a residual base scheme of length $2 d-4$ from $\widetilde{\mathcal{C}}_{1}^{2}=2 d-3$.

Conversely, take a general element of $\left|O_{\widetilde{S}}((5-d) f)\right|$ and $2 d-4$ general points on $\widetilde{S}$ of ideal $I$. We have $\mathrm{h}^{0}\left(I\left(\widetilde{\mathcal{C}}_{1}\right)\right)=3$, and thanks to the surjection $\mathrm{H}^{0} O_{\mathbb{P}_{\mathbb{C}}^{3}}(3) \rightarrow \mathrm{H}^{0} O_{S}(3)$ we get an element of $\mathfrak{r u l e d}_{3, d}$.

Lemma 2.4. The following inclusions hold:

$$
\mathfrak{r u l e d}_{3,2} \subset \overline{\mathfrak{r u l e d}_{3,3}}, \quad \mathfrak{r u l e d}_{3,3} \subset \overline{\mathfrak{r u l e d}_{3,4}}, \quad \mathfrak{r u l e d}_{3,4} \subset \overline{\mathfrak{r u l e d}_{3,5}}
$$

Proof (with the notations introduced in the proof of Lemma 2.3). Let us start with an element of $\overline{\mathfrak{r u l e d}}{ }_{3,5}$ with base curve $\delta^{2}$ and 6 base points $p_{i}$ in general position as decribed in Lemma 2.3. Then move two of the $p_{i}$, for instance $p_{1}, p_{2}$ until the line $\left(p_{1} p_{2}\right)$ intersects $\delta$. The line $\left(p_{1} p_{2}\right)$ is now automatically in the base locus of the linear system $\Lambda_{\psi}$, and we obtain like this a generic element of $\mathfrak{r u l e d}{ }_{3.4}$.

A similar argument allows to prove the two other inclusions.

Let us recall the notion of genus of a birational map ([9, Chapter IX]). The genus $\mathfrak{g}_{\psi}$ of $\psi \in$ $\operatorname{Bir}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is the geometric genus of the curve $h \cap \psi^{-1}\left(h^{\prime}\right)$ where $h$ and $h^{\prime}$ are generic hyperplanes of $\mathbb{P}_{\mathbb{C}}^{3}$. The equality $\mathfrak{g}_{\psi}=\mathfrak{g}_{\psi^{-1}}$ holds.

Remark 2.5. If $\psi$ is a birational map of $\mathbb{P}_{\mathbb{C}}^{3}$ of degree 1 (resp. 2, resp. 3) then $\mathfrak{g}_{\psi}=0$ (resp. $\mathfrak{g}_{\psi}=0$, resp. $\left.\mathfrak{g}_{\psi} \leq 1\right)$.

One can give a characterization of ruled maps of $\operatorname{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ in terms of the genus.
Proposition 2.6. Let $\psi$ be in $\operatorname{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right), 2 \leq d \leq 5$. The genus of $\psi$ is zero if and only if $\psi$ is ruled.

Proof. On the one hand the base scheme of an element of $\operatorname{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ has at most isolated singularities if and only if the map is not ruled; on the other hand $\mathfrak{g}_{\psi}=0$ if and only if for generic hyperplanes $h, h^{\prime}$ of $\mathbb{P}_{\mathbb{C}}^{3}$ the curve $h \cap \psi^{-1}\left(h^{\prime}\right)$ is a singular rational cubic.

## 3. LIAISON

According to [14] we say that two curves $\Gamma_{1}$ and $\Gamma_{2}$ of $\mathbb{P}_{\mathbb{C}}^{3}$ are geometrically linked if

- $\Gamma_{1} \cup \Gamma_{2}$ is a complete intersection,
- $\Gamma_{1}$ and $\Gamma_{2}$ have no common component.

Let $\Gamma_{1}$ and $\Gamma_{2}$ be two curves geometrically linked. Recall that $I_{\Gamma_{1} \cup \Gamma_{2}}=I_{\Gamma_{1}} \cap I_{\Gamma_{2}}$. According to [14, Proposition 1.1] one has $\frac{I_{\Gamma_{1}}}{I_{\Gamma_{1} \cup \Gamma_{2}}}=\operatorname{Hom}\left(O_{\Gamma_{2}}, O_{\Gamma_{1} \cup \Gamma_{2}}\right)$. Since the kernel of $O_{\Gamma_{1} \cup \Gamma_{2}} \longrightarrow O_{\Gamma_{2}}$ is $\frac{I_{\Gamma_{1}}}{I_{\Gamma_{1} \cup \Gamma_{2}}}$ one gets the following fundamental statement: if $\Gamma_{1}, \Gamma_{2}$ are two curves geometrically linked, then

$$
0 \longrightarrow \omega_{\Gamma_{1}} \longrightarrow \omega_{\Gamma_{1} \cup \Gamma_{2}} \longrightarrow O_{\Gamma_{2}} \otimes \omega_{\Gamma_{1} \cup \Gamma_{2}} \longrightarrow 0 .
$$

Lemma 3.1. Let $\psi$ be a rational map of $\mathbb{P}_{\mathbb{C}}^{3}$ of degree 3. We have

$$
\omega_{\mathcal{C}_{1} \cup \mathcal{C}_{2}}=O_{\mathcal{C}_{1} \cup \mathcal{C}_{2}}(2 h)
$$

where $h$ denotes an hyperplane of $\mathbb{P}_{\mathbb{C}}^{3}$, and for $i \in\{1,2\}$

$$
\begin{equation*}
0 \longrightarrow \omega_{C_{i}} \longrightarrow O_{\mathcal{C}_{i} \cup \mathcal{C}_{3-i}}(2 h) \longrightarrow O_{\mathcal{C}_{3-i}}(2 h) \longrightarrow 0 \tag{3.1}
\end{equation*}
$$

and

$$
\begin{equation*}
0 \longrightarrow I_{\mathcal{C}_{1} \cup \mathcal{C}_{2}}(3 h) \longrightarrow I_{\mathcal{C}_{i}}(3 h) \longrightarrow \omega_{\mathcal{C}_{3-i}}(h) \longrightarrow 0 \tag{3.2}
\end{equation*}
$$

The first exact sequence (3.1) directly implies the following equalities $(i \in\{1,2\})$

$$
\begin{aligned}
\mathrm{H}^{0}\left(\omega_{\mathcal{C}_{i}}(-h)\right)=\mathrm{H}^{0}\left(I_{\mathcal{C}_{3-i}}(h)\right), & \mathrm{H}^{0}\left(\omega_{\mathcal{C}_{i}}\right)=\mathrm{H}^{0}\left(I_{\mathcal{C}_{3-i}}(2 h)\right), \\
\mathrm{h}^{0} \omega_{\mathcal{C}_{i}}(h)+2=\mathrm{h}^{0}\left(I_{\mathcal{C}_{3-i}}(3 h)\right), & \mathrm{H}^{0}\left(\omega_{\mathcal{C}_{i}}(h)\right)=\frac{\mathrm{H}^{0}\left(I_{\mathcal{C}_{3-i}}(3 h)\right)}{\mathrm{H}^{0}\left(I_{\mathcal{C}_{1} \cup \mathcal{C}_{2}}(3 h)\right)} .
\end{aligned}
$$

Corollary 3.2. Let $\psi$ be a rational map of $\mathbb{P}_{\mathbb{C}}^{3}$ of degree 3. The ideal $I_{\mathcal{C}_{3-i}}$ is generated by cubics if and only if $\omega_{C_{i}}(h)$ is globally generated.

Proof. It directly follows from the exact sequence (3.2).

Corollary 3.3. Let $\psi$ be a rational map of $\mathbb{P}_{\mathbb{C}}^{3}$ of degree 3. Then

$$
\operatorname{deg} \mathcal{C}_{2}-\operatorname{deg} \mathcal{C}_{1}=\mathfrak{p}_{a}\left(\mathcal{C}_{2}\right)-\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)
$$

Proof. Taking the restriction of (3.1) to $\mathcal{C}_{i}$ for $i=1,2$ gives

$$
\operatorname{deg} \omega_{\mathcal{C}_{i}}=2 \operatorname{deg} \mathcal{C}_{i}-\operatorname{deg}\left(\mathcal{C}_{1} \cap \mathcal{C}_{2}\right)
$$

and hence

$$
\operatorname{deg} \mathcal{C}_{2}-\operatorname{deg} \mathcal{C}_{1}=\mathfrak{p}_{a}\left(\mathcal{C}_{2}\right)-\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)
$$

Furthermore when $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ have no common component, and $\omega_{\mathcal{C}_{i}}$ is locally free, then length $\left(\mathcal{C}_{1} \cap\right.$ $\left.\mathcal{C}_{2}\right)=\operatorname{deg} \omega_{\mathcal{C}_{i}}^{\vee}(2 h)$, i.e.

$$
\sum_{p \in \mathcal{\mathcal { C } _ { 1 } \cap \mathcal { C } _ { 2 }}} \text { length }\left(\mathcal{C}_{1} \cap \mathcal{C}_{2}\right)_{\{p\}}=2 \operatorname{deg} \mathcal{C}_{i}-2 \mathfrak{p}_{a}\left(\mathcal{C}_{i}\right)+2
$$

In the preimage of a generic point of $\mathbb{P}_{\mathbb{C}}^{3}$ by $\psi$, the number of points that do not lie in the base locus is given by

$$
3 \operatorname{deg} \mathcal{C}_{1}-\sum_{p \in \mathcal{\mathcal { C } _ { 1 } \cap \mathcal { C } _ { 2 }}} \text { length }\left(S \cap \mathcal{C}_{1}\right)_{\{p\}}-\sum_{p \in \Theta} \text { length }\left(S \cap \mathcal{C}_{1}\right)_{\{p\}}
$$

where $\mathcal{S} \in \Lambda_{\psi}$ is non-zero modulo $\mathrm{H}^{0}\left(I_{\mathcal{C}_{1} \cup \mathcal{C}_{2}}(3 h)\right)$, and where $\Theta$ denotes the set of irreducible components of dimension 0 of the base locus $F_{\psi}$ of $\psi$.
Lemma 3.4. Let $\psi$ be a rational map of $\mathbb{P}_{\mathbb{C}}^{3}$ of degree 3. Let $\Theta$ denote the set of irreducible components of dimension 0 of $F_{\psi}$. The map $\psi$ is birational if and only if

$$
1=3 \operatorname{deg} \mathcal{C}_{1}-\sum_{p \in \mathcal{\mathcal { C } _ { 1 } \cap \mathcal { C } _ { 2 }}} \operatorname{length}\left(\mathcal{S} \cap \mathcal{C}_{1}\right)_{\{p\}}-\sum_{p \in \Theta} \operatorname{length}\left(\mathcal{S} \cap \mathcal{C}_{1}\right)_{\{p\}}
$$

Remark that the computation of length $\left(\mathcal{S} \cap \mathcal{C}_{1}\right)_{\{p\}}$ depends on the nature of the singularity of the cubic surface and on the behavior of $\mathcal{C}_{2}$ in that point (see §7).

Lemma 3.5. Let $\psi$ be $a(3, d)$ CREMONA map. Assume that $d \geq 4$, then $\mathcal{C}_{1}$ is not contained in a plane.

Proof. Suppose for example that $d=4$; then $\mathcal{C}_{1}$ is contained in an irreducible cubic surface $\mathcal{S}$. If $\mathcal{C}_{1}$ is contained in a plane $\mathcal{P}$ then all the lines in $\mathcal{P}$ are quadrisecant to $\mathcal{S}$ : contradiction with the irreducibility of $\mathcal{S}$.

Lemma 3.6. Let $\psi$ be a $(3, d)$ birational map, and let $p$ be a point on $\mathcal{C}_{1}$. Assume that the degree of the tangent cone of $\mathcal{C}_{1}$ at $p$ is strictly less than 4. If any $\mathcal{S}$ in $\Lambda_{\psi}$ is singular at $p$, then $p$ belongs to $\mathcal{C}_{2}$.

Proof. If any $\mathcal{S}$ in $\Lambda_{\psi}$ is singular at $p$, then the degree of the tangent cone of the complete intersection $\mathcal{C}_{1} \cap \mathcal{C}_{2}$ at $p$ is at least 4 so $p$ has to belong to $\mathcal{C}_{2}$.

Lemma 3.7. Let $\psi$ be a non-ruled $(3, d)$ birational map, and let $\mathcal{C}_{1}$ be a general element of $\Lambda_{\psi}$. The support of $\operatorname{Sing} \mathcal{C}_{1}$ is independent of the choice of $\mathcal{C}_{1}$.

Proof. Let us show that there is a singular point independent of the choice of $\mathcal{C}_{1}$. Let us consider an element $\mathcal{S}$ of $\Lambda_{\psi}$ with finite singular locus. Let $\pi: \widetilde{\mathcal{S}} \rightarrow \mathcal{S}$ be a minimal desingularization of $\mathcal{S}$, and let $\widetilde{\mathcal{C}}_{1}$ be the strict transform of $\mathcal{C}_{1}$. The elements of $\Lambda_{\psi}$ give a linear system in $\left|O_{\tilde{S}^{\prime}}\left(\widetilde{\mathcal{C}}_{1}\right)\right|$ whose base locus denoted $\Omega$ is finite. According to BERTINI's theorem applied on $\widetilde{\mathcal{S}}$ one has the inclusion $\operatorname{Sing} \mathcal{C}_{1} \subset \pi(\Omega) \cup \operatorname{Sing} \mathcal{S}$. The first assertion thus follows from the fact that $\Omega \cup \operatorname{Sing} \mathcal{S}$ is finite.

Theorem 3.8. Let $\psi$ be a $(3, d)$ birational map, $2 \leq d \leq 6$, that is not ruled. Assume that $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=1$. Then

- there exists a singular point $p$ of $\mathcal{C}_{1}$ independent of the choice of $\mathcal{C}_{1}$;
- if $d \leq 4$, all the cubic surfaces of the linear system $\Lambda_{\psi}$ are singular at $p$;
- the curve $\mathcal{C}_{2}$ is of degree $9-d$, of arithmetic genus $10-2 d$, and lies on a unique quadric $Q$; more precisely $I_{\mathcal{C}_{2}}=\left(Q, \mathcal{S}_{1}, \ldots, S_{d-2}\right)$ where the $\mathcal{S}_{i}$ 's are independent cubics modulo $Q$.

Remark 3.9. As soon as $d=5$ the second assertion is not true. Indeed for $d=5$ we obtain two families: one for which all the elements of $\Lambda_{\psi}$ are singular, and another one for which it is not the case (§6).

Proof. The first assertion directly follows from Lemma 3.7.
Since $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=1$, the curve $\mathcal{C}_{2}$ lies on a unique quadric $Q$. The arithmetic genus of $\mathcal{C}_{2}$ is obtained from $\operatorname{deg} \mathcal{C}_{2}-\operatorname{deg} \mathcal{C}_{1}=\mathfrak{p}_{a}\left(\mathcal{C}_{2}\right)-\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)$ (Corollary 3.3).

As $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=1, \omega_{\mathcal{C}_{1}}(h)$ has no base point, and $I_{\mathcal{C}_{2}}$ is generated by cubics (Corollary 3.2). The number of cubics containing $\mathcal{C}_{2}$ independent modulo the multiple of $Q$ is $d-2$ : the liaison sequence (Lemma 3.1) becomes

$$
0 \longrightarrow O_{\mathcal{C}_{1}}(h) \longrightarrow O_{\mathcal{C}_{1} \cup \mathcal{C}_{2}}(3 h) \longrightarrow O_{\mathcal{C}_{2}}(3 h) \longrightarrow 0
$$

one gets that

$$
\mathrm{h}^{0} O_{\mathcal{C}_{2}}(3 h)=\mathrm{h}^{0} O_{\mathcal{C}_{1} \cup \mathcal{C}_{2}}(3 h)-\mathrm{h}^{0} O_{\mathcal{C}_{1}}(h)=18-d .
$$

This implies that

$$
\mathrm{h}^{0} I_{\mathcal{C}_{2}}(3 h)=20-\mathrm{h}^{0} O_{\mathcal{C}_{2}}(3 h)=d+2 .
$$

If we put away the four multiples of $Q$ one obtains $d+2-4=d-2$ cubics, and finally $I_{\mathcal{C}_{2}}=$ $\left(Q, \mathcal{S}_{1}, \ldots, \mathcal{S}_{d-2}\right)$.

Corollary 3.3 and Theorem 3.8 imply Proposition B.
Proposition 3.10. For $2 \leq d \leq 5$ the set $\mathfrak{r u l e d}_{3, d}$ is an irreducible component of $\operatorname{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$.
Proof. Let us use the notations introduced in Lemma 2.3. Note that $F_{\psi}^{1} \subset \mathcal{C}_{2}$. If $\psi \in \operatorname{Bir}_{3, d}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is not ruled then at a generic point $p \in F_{\psi}^{1}$ there exists an element of $\Lambda_{\psi}$ smooth at $p$. Hence $F_{\psi}^{1}$ is locally complete intersection at $p$ and $\operatorname{deg} F_{\psi}^{1}=\operatorname{deg} \mathcal{C}_{2}$. In particular $\operatorname{deg} I_{\psi}=9-d$.

Consider now an element $\psi$ in $\mathfrak{r u l e d}_{3, d}$. There is a line $\ell$ such that $\ell \subset \operatorname{Sing} \mathcal{S}$ for any $\mathcal{S} \in \Lambda_{\psi}$; the set $F_{\psi}^{1}$ has an irreducible component whose ideal is $I_{\ell}^{2}$ and $F_{\psi}^{1}$ is not locally complete intersection. This multiple structure has to be contained in $\mathcal{C}_{2}$ but since $\mathcal{C}_{2}$ is locally complete intersection the inequality $\operatorname{deg} \mathcal{C}_{2}>\operatorname{deg} F_{\psi}^{1}$ holds; it can be rewritten $\operatorname{deg} I_{\psi}<9-d$.

The number deg $I_{\psi}$ cannot decrease by specialization so we cannot specialize a non-ruled birational map into a ruled one while staying in the same bidegree ${ }^{1}$.

Elements of $\Lambda_{\psi}$ when $\psi$ is a ruled birational map have no isolated singularities whereas general elements of $\Lambda_{\psi}$ when $\psi$ is a non-ruled birational map have at most isolated singularities, it is impossible to specialize a ruled birational map into a non-ruled one.
Corollary 3.11. Let $\psi$ be a $(3, \cdot)$ birational map of $\mathbb{P}_{\mathbb{C}}^{3}$; if the general element of $\Lambda_{\psi}$ is smooth or if the singularities of a general element of $\Lambda_{\psi}$ are isolated, then $\operatorname{deg} F_{\psi}^{1}=\operatorname{deg} \mathcal{C}_{2}$.

## 4. $(3,3)$-CREMONA TRANSFORMATIONS

### 4.1. Some known results.

4.1.1. In the literature one can find different points of view concerning the classification of $(3,3)$ birational maps. For example HUDSON introduced many invariants related to singularities of families of surfaces and gave four families described in §A; nevertheless we do not understand why the family $\mathcal{E}_{3.5}$ defined below does not appear. PAN chose an other point of view and regrouped $(3,3)$ birational maps into three families. A $(3,3)$ birational map $\psi$ of $\mathbb{P}_{\mathbb{C}}^{3}$ is called determinantal if there exists a $4 \times 3$ matrix $M$ with linear entries such that $\psi$ is given by the four $3 \times 3$ minors of the matrix $M$; the inverse $\psi^{-1}$ is also determinantal. Let us denote by $\mathbf{T}_{3,3}^{\mathbf{D}}$ the set of determinantal maps. A $(3,3)$ CREMONA transformation is a DE JONQUIÈRES one if and only if the strict transform of a general line under $\psi^{-1}$ is a singular plane rational cubic curve whose singular point is fixed. For such a map there is always a quadric contracted onto a point, the corresponding fixed point for $\psi^{-1}$ which is also a DE JONQUIÈRES transformation. The DE JONQUIÈRES transformations form the set $\mathbf{T}_{3,3}^{\mathbf{J}}$. PAN established the following ([11, Theorem 1.2]):

$$
\operatorname{Bir}_{3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)=\mathbf{T}_{3,3}^{\mathbf{D}} \cup \mathbf{T}_{3,3}^{\mathbf{J}} \cup \mathfrak{r u l e d}_{3,3} ;
$$

in other words an element of $\operatorname{Bir}_{3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is a determinantal map, or a DE JONQUIÈRES map, or a ruled map.

Remark 4.1. One has $\mathbf{T}_{3,3}^{\mathbf{D}}=\operatorname{Bir}_{3,3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ and $\mathbf{T}_{3,3}^{\mathbf{J}}=\operatorname{Bir}_{3,3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$; hence $\operatorname{Bir}_{3,3, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is irreducible for $\mathfrak{p}_{2} \in\{3,4\}$ (see [11]).

Remark 4.2. The birational involution $\left(z_{0} z_{1}^{2}: z_{0}^{2} z_{1}: z_{0}^{2} z_{2}: z_{1}^{2} z_{3}\right)$ is determinantal, the matrix being

$$
\left[\begin{array}{ccc}
z_{0} & z_{3} & 0 \\
-z_{1} & 0 & z_{2} \\
0 & 0 & -z_{1} \\
0 & -z_{0} & 0
\end{array}\right]
$$

and also ruled: all the partial derivatives of the components of the map vanish on $z_{0}=z_{1}=0$. The CREMONA transformation $\left(z_{0}^{3}: z_{0}^{2} z_{1}: z_{0}^{2} z_{2}: z_{1}^{2} z_{3}\right)$ is a DE JONQUIERES and a ruled one.

One has ([10])

$$
\mathbf{T}_{3,3}^{\mathbf{D}} \cap \mathbf{T}_{3,3}^{\mathbf{J}}=\emptyset, \quad \mathbf{T}_{3,3}^{\mathbf{D}} \cap \mathfrak{r u l e d}_{3,3} \neq \emptyset, \quad \mathbf{T}_{3,3}^{\mathbf{J}} \cap \mathfrak{n u l e d}_{3,3} \neq \emptyset
$$

[^1]We deal with the natural description of the irreducible components of $\operatorname{Bir}_{3,3}$ which does not coincide with PaN's point of view since one of his family is contained in the closure of another one.

### 4.2. Irreducible components of the set of $(3,3)$ birational maps.

4.2.1. General description of $(3,3)$ birational maps. One already describes an irreducible component of $\operatorname{Bir}_{3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$, the one that contains $(3,3)$ ruled birational maps (Proposition 3.10). Hence let us consider the case where the linear system $\Lambda_{\psi}$ associated to $\psi \in \operatorname{Bir}_{3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ contains a cubic surface without double line.

- If $\mathcal{C}_{1}$ is smooth then it is a twisted cubic, we are in family $\mathcal{E}_{2}$ of Table VI (see §A). In that case $\psi$ is determinantal; more precisely a $(3,3)$ birational map is determinantal if and only if its base locus scheme is an arithmetically COHEN-MACAULAY curve of degree 6 and (arithmetic) genus 3 (see [1, Proposition 1]).
- Otherwise $\omega_{\mathcal{C}_{1}}=O_{\mathcal{C}_{1}}$, and $\psi$ belongs to the irreducible family $\mathbf{T}_{3,3}^{\mathbf{J}}$ of JONQUIÈRES maps ( $\mathcal{E}_{3}$ in terms of HUDSON's classification). The curve $\mathcal{C}_{2}$ lies on a quadric described by the quadratic form $Q$. According to Theorem 3.8 the ideal of $\mathcal{C}_{2}$ is $(Q, S)$, and there exists a point $p$ such that $p \in Q$, and $p$ is a singular point of $\mathcal{S}$. Furthermore $I_{\psi}=I_{p} Q+(S)$. Reciprocally such a triplet $(p, Q, S)$ induces a birational map.

The family $\mathbf{T}_{3,3}^{\mathbf{J}}$ is stratified as follows by HUDSON (all the cases belong to $\overline{\mathbb{E}_{3}}$ ):

- Description of $\mathcal{E}_{3}$. The general element of $I_{p} Q+(S)$ has an ordinary quadratic singularity at $p$ (configuration $(2,2)$ of Table 1 (see §7)), and the generic cubic is singular at $p$ with a quadratic form of rank 3.
- Description of $\mathcal{E}_{3.5}$. The point $p$ lies on $Q$ ( $p$ is a smooth point or not) and the generic cubic is singular at $p$ with a quadratic form of rank 2 . In other words $p$ is a binode and this happens when one of the two biplanes is contained in $\mathrm{T}_{p} Q$, it corresponds to the configuration $(2,3)^{\prime}$ of Table 1 (see §7). The generic cubic is singular at $p$ with a quadratic form of rank 2; this case does not appear in Table VI (see §A). Let us denote by $\mathcal{E}_{3.5}$ the set of the associated $(3,3)$ birational maps. The curve $\mathcal{C}_{2}$ has degree 6 and a triple point (in $Q$ ).
- Description of $\mathscr{E}_{4}$. The point $p$ is a double point of contact, it corresponds to configuration $(2,4)$ of Table 1 (see §7).


## Proposition 4.3. One has

$$
\operatorname{dim} \mathcal{E}_{2}=39, \quad \operatorname{dim} \mathcal{E}_{3}=38, \quad \operatorname{dim} \mathcal{E}_{3.5}=35, \quad \operatorname{dim} \mathcal{E}_{4}=35, \quad \operatorname{dim} \mathcal{E}_{5}=31
$$

and

Proof. Let us justify the equality $\operatorname{dim} \mathcal{E}_{3}=38$. We have to choose a quadric $Q$ and a point $p$ on $Q$, this gives $9+2=11$. Then we take a cubic surface singular at $p$ that yields to $19-4=15$; since we look at this surface modulo $p Q$ one gets $15-3=12$ so

$$
\operatorname{dim} \mathcal{E}_{3}=11+12+15=38
$$

Let us deal with $\operatorname{dim} \mathcal{E}_{4}$. We take a singular quadric $Q$ this gives 8 . Then we take a cubic singular at $p$, modulo $p Q$ and this yields to $19-4-3=12$, and finally one obtains $12+8+15=35$.

### 4.2.2. Irreducible components.

Theorem 4.4. The set $\mathfrak{r u l e d}_{3,3}$ is an irreducible component of $\operatorname{Bir}_{3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$, and there is only one another irreducible component in $\operatorname{Bir}_{3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$. More precisely the set of the Jonquières maps $\overline{\mathcal{E}_{3}}$ is contained in the closure of determinantal ones $\overline{\mathcal{E}_{2}}$ whereas $\mathfrak{r u l e d}_{3,3} \not \subset \overline{\mathcal{E}_{2}}$.

Proof. Let us consider the matrix $A$ given by

$$
\left[\begin{array}{ccc}
0 & 0 & 0 \\
-z_{1} & -z_{2} & 0 \\
z_{0} & 0 & -z_{2} \\
0 & z_{0} & z_{1}
\end{array}\right]
$$

and let $A_{i}$ denote the matrix $A$ minus the $(i+1)$-th line. If $i>0$, the $2 \times 2$ minors of $A_{i}$ are divisible by $z_{i-1}$.

Consider the $3 \times 4$ matrix $B$ given by $\left[b_{i j}\right]_{1 \leq i \leq 4,1 \leq j \leq 3}$ with $b_{i j} \in \mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathbb{C}}^{3}}(1)\right)$; as previously, $B_{i}$ is the matrix $B$ minus the $(i+1)$-th line. Denote by $\Delta^{j, k}$ the determinant of the matrix $A_{0}$ minus the $j$-th line and the $k$-th column. The $\Delta^{j, k}$ generate $\mathbb{C}\left[z_{0}, z_{1}, z_{2}\right]_{2}$. One has

$$
\operatorname{det}\left(A_{0}+t B_{0}\right)=t \cdot S \quad\left[t^{2}\right]
$$

where

$$
S=\left(b_{21}+b_{43}\right) \Delta^{1,1}-\left(b_{31}-b_{42}\right) \Delta^{2,1}+\left(b_{33}-b_{22}\right) \Delta^{1,2}+b_{23} \Delta^{1,3}+b_{32} \Delta^{2,2}+b_{41} \Delta^{3,1}
$$

is a generic cubic of the ideal $\left(z_{0}, z_{1}, z_{2}\right)^{2}$. For $i>0$

$$
\operatorname{det}\left(A_{i}+t B_{i}\right)=\operatorname{det} A_{i}+t \cdot\left(z_{i+1} Q\right)(-1)^{i+1}=t \cdot\left(z_{i+1} Q\right)(-1)^{i+1} \quad\left[t^{2}\right]
$$

where $Q=b_{1,1} z_{2}-b_{1,2} z_{1}+b_{1,3} z_{0}$ is the equation of a generic quadric that contains $(0,0,0,1)$. So the map

$$
\left[\frac{\operatorname{det}\left(A_{0}+t B_{0}\right)}{t}: \frac{\operatorname{det}\left(A_{1}+t B_{1}\right)}{t}: \frac{\operatorname{det}\left(A_{2}+t B_{2}\right)}{t}: \frac{\operatorname{det}\left(A_{3}+t B_{3}\right)}{t}\right]
$$

allows to go from $\mathcal{E}_{2}$ to a general element of $\overline{\mathcal{E}_{3}}$.

Furthermore $\overline{\mathcal{E}_{3}}$ and $\mathfrak{r u l e d}_{3,3}$ are different components (Proposition 3.10).

## 5. $(3,4)$-CREMONA TRANSFORMATIONS

5.1. General description of $(3,4)$ birational maps. The ruled maps $\mathfrak{r u l e d}_{3,4}$ give rise to an irreducible component (Proposition 3.10). Let us now focus on the case where the linear system $\Lambda_{\psi}$ associated to $\psi \in \operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ contains a cubic surface without double line.

- First case: $\mathcal{C}_{1}$ is smooth. From $h^{0} \omega_{\mathcal{C}_{1}}(h)=3$ one gets that $\mathcal{C}_{2}$ lies on five cubics. Since $\mathrm{h}^{0} O_{\mathcal{C}_{2}}(2 h)=0$ the curve $\mathcal{C}_{1}$ lies on a quadric, and $\mathrm{h}^{0} \omega_{\mathcal{C}_{2}}=1$ thus $\omega_{\mathcal{C}_{2}}=\mathcal{O}_{\mathcal{C}_{2}}$. This configuration corresponds to $\mathcal{E}_{6}$.
- Second case: $\mathcal{C}_{1}$ is a singular curve of degree 4 not contained in a plane (see Lemma 3.5) so $\omega_{\mathcal{C}_{1}}=O_{\mathcal{C}_{1}}$. The curve $\mathcal{C}_{1}$ lies on two quadrics and $\mathcal{C}_{2}$ on six cubics $\left(\mathrm{h}^{0} \omega_{\mathcal{C}_{1}}(h)=4\right)$. Let $p$ be the singular point of $\mathcal{C}_{1}$; all elements of $\Lambda_{\psi}$ are singular at $p$ (Theorem 3.8), and $p$ belongs to $\mathcal{C}_{2}$ (Lemma 3.6). The curve $\mathcal{C}_{2}$ lies on a unique quadric $Q$ (Theorem 3.8), is linked to a line $\ell$ in a $(2,3)$ complete intersection $Q \cap \mathcal{S}_{1}$ (with $\operatorname{deg} Q=2$ and $\operatorname{deg} \mathcal{S}_{1}=3$ ), and $I_{\mathcal{C}_{2}}=\left(Q, \mathcal{S}_{1}, \mathcal{S}_{2}\right)$ with $\operatorname{deg} \mathcal{S}_{2}=3$ (Theorem 3.8).

Since $\mathcal{C}_{1}$ is of degree 4 and arithmetic genus 1 , one has $\mathrm{H}^{0}\left(O_{\mathcal{C}_{1}}(h)\right)=\mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathbb{C}}^{3}}(1)\right)$. Let us consider $L=\mathrm{H}^{0}\left(I_{\mathcal{C}_{1} \cup \mathcal{C}_{2}}(3 h)\right) \subset \Lambda_{\psi}$ and the map

$$
\mathrm{H}^{0}\left(O_{\mathcal{C}_{1}}(h)\right) \longrightarrow \frac{\mathrm{H}^{0}\left(I_{\mathcal{C}_{2}}(3 h)\right)}{L}, \quad h \mapsto Q h ;
$$

it is injective. Indeed $\operatorname{dim}\left(\mathcal{C}_{1} \cap Q\right)=0$ thus modulo $Q$ the cubics defining $\mathcal{C}_{1}$ are independent. Therefore $\Lambda_{\psi}$ is contained in $\left(Q I_{p}, \mathcal{S}_{1}, \mathcal{S}_{2}\right)$. For $p^{\prime} \in \mathbb{P}_{\mathbb{C}}^{3} \backslash Q$ one has

$$
\left.\mathrm{H}^{0}\left(\left(Q I_{p}, \mathcal{S}_{1}, \mathcal{S}_{2}\right) \cap I_{p^{\prime}}\right)(3)\right)=\Lambda_{\phi}
$$

for some birational map $\phi$, and $\psi$ belongs to the closure of the set defined by all such maps $\phi$.
Reciprocally let $Q$ be a quadric, $p$ be a point on $Q, \mathcal{S}_{1}$ be a cubic singular at $p$ and that contains a line $\ell$ of $Q$. If $\mathcal{C}_{2}$ is the residual of $\ell$ in $\left(Q, \mathcal{S}_{1}\right)$, then there exists $\mathcal{S}_{2}$ singular at $p$ such that $I_{\mathcal{C}_{2}}=\left(Q, \mathcal{S}_{1}, \mathcal{S}_{2}\right)$. Set

$$
\Lambda=\mathrm{H}^{0}\left(\left(I_{p_{1}} \cap\left(Q I_{p}, \mathcal{S}_{1}, \mathcal{S}_{2}\right)(3)\right)\right.
$$

Let $L$ be a 2-dimensional general element of $\Lambda$; the general linked curve to $\mathcal{C}_{2}$ in $L$, denoted $\mathcal{C}_{1, L}$, is of degree 4 , is singular at $p$, lies on two quadrics; furthermore the linear system induced by $\Lambda$ on $\mathcal{C}_{1, L}$ has the two following properties:

- its base locus contains $p$ and $p_{1}$,
- it is birational.

In other words, $\Lambda=\Lambda_{\psi}$ for a (3,4)-birational map $\psi$.

Let us give some explicit examples, the generic one and the degeneracies considered by Hudson:

- Description of $\mathcal{E}_{7}$. The quadric $Q$ is smooth at $p$, and the rank of $Q$ is maximal. Hence the point $p$ is an ordinary quadratic singularity of the generic element of $\Lambda_{\psi}$, we are in the configuration $(2,2)$ of Table 1 (see §7).
- Description of $\mathcal{E}_{7.5}$. In that case, $p$ is a binode, $Q$ is smooth at $p$ and one of the two biplanes is contained in $T_{p} Q$; we are in the configuration $(2,3)^{\prime}$ of Table 1 (see §7). The set of such maps is denoted $\mathcal{E}_{7.5}$, this case does not appear in Table VI but should appear.
- Description of $\mathcal{E}_{8}$. The second way to obtain a binode is the following one: $Q$ is an irreducible cone with vertex $p$. This corresponds to the configuration $(2,3)$ of Table 1 (see §7).
- Description of $\mathcal{E}_{9}$. The rank of $Q$ is 2 , and the point $p$ is a double point of contact; we are in the configuration $(2,4)$ of Table 1 (see §7).
- Description of $\mathcal{E}_{10}$. The general element of $\Lambda_{\psi}$ has a double point of contact and a binode (configurations $(2,4)$ and $(1,4)$ of Table 1 , see $\S 7$ ). HUDSON details this case carefully ([9, Chap. XV]).

Proposition 5.1. One has the following properties:

$$
\operatorname{dim} \mathcal{E}_{6}=38, \quad \mathcal{E}_{7.5} \cup \mathcal{E}_{8} \subset \overline{\mathcal{E}_{7}}
$$

and

- a generic element of $\mathcal{E}_{7.5}$ is not a specialization of a generic element of $\mathcal{E}_{8}$;
- a generic element of $\mathcal{E}_{8}$ is not a specialization of a generic element of $\mathcal{E}_{7.5}$;
- a generic element of $\mathcal{E}_{9}$ is a specialization of a generic element of $\mathcal{E}_{8}$.

Proof. The arguments to establish $\operatorname{dim} \mathcal{E}_{6}=38$ are similar to those used in the proof of Proposition 4.3.

Let us justify that a generic element of $\mathcal{E}_{7.5}$ is not a specialization of a generic element of $\mathcal{E}_{8}$ (we take the notations of §5.1): as we see when $\psi \in \mathcal{E}_{8}$ the quadric $Q$ is always singular whereas it is not the case when $\psi \in \mathcal{E}_{7.5}$. Conversely if $\psi$ belongs to $\mathcal{E}_{7.5}$ then $\mathcal{C}_{2}$ is reducible but if $\psi$ belongs to $\mathcal{E}_{8}$ the curve $\mathcal{C}_{2}$ can be irreducible and reduced; hence a generic element of $\mathcal{E}_{8}$ is not a specialization of a generic element of $\mathcal{E}_{7.5}$.

Theorem 5.2. The set $\mathfrak{r u l e d}_{3,4}$ is an irreducible component of $\operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$. There is only one another irreducible component in $\operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$.
Proof. According to Proposition 3.10 the set $\mathfrak{r u l e d}_{3,4}$ is an irreducible component of $\operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$.
Any element $\psi$ of $\mathcal{E}_{7} \cup \mathcal{E}_{7.5} \cup \mathcal{E}_{8} \cup \mathcal{E}_{9} \cup \mathcal{E}_{10}$ satisfies the following property:

$$
\Lambda_{\psi}=\mathrm{H}^{0}\left(\left(\left(Q I_{p}, \mathcal{S}_{1}, \mathcal{S}_{2}\right) \cap I_{p_{1}}\right)(3)\right)
$$

where $p$ belongs to $Q, p_{1}$ is an ordinary base point, and

$$
Q=\operatorname{det}\left[\begin{array}{ll}
L_{0} & L_{1} \\
L_{2} & L_{3}
\end{array}\right], \quad S_{1}=L_{0} Q_{1}+L_{1} Q_{2}, \quad S_{2}=L_{2} Q_{1}+L_{3} Q_{2}
$$

with $L_{i} \in \mathbb{C}\left[z_{0}, z_{1}, z_{2}, z_{3}\right]_{1}, Q_{i} \in \mathbb{C}\left[z_{0}, z_{1}, z_{2}\right]_{2}$. So $\mathcal{E}_{7}, \mathcal{E}_{7.5}, \mathcal{E}_{8} \mathcal{E}_{9}$ and $\mathcal{E}_{10}$ belong to the same irreducible component $\mathscr{E}$.

It remains to show that $\mathscr{E}=\overline{\mathcal{E}_{6}}$ : let us consider

$$

0 & 0 & 1 & 0 \\
0 & -1 & 0 & 0 \\
-1 & 0 & 0 & 0
\end{array}\right], \quad N=\left[\begin{array}{cccc}

z_{2} & 0 & L_{1} & L_{2} \\
-z_{3} & -L_{1} & 0 & L_{3} \\
-L_{0} & -L_{2} & -L_{3} & 0
\end{array}\right], \quad v=\left[\begin{array}{c}
z_{2} \\
z_{1} \\
z_{0} \\
t z_{3}
\end{array}\right]
$$

with $L_{i}$ linear forms and

$$
M_{t}=\left[\begin{array}{c}
J v \\
N v
\end{array}\right]=\left[\begin{array}{cccc}
t z_{3} & z_{0} & -z_{1} & -z_{2} \\
t z_{3} L_{0}+Q & q_{1} & q_{2} & q_{3}
\end{array}\right]
$$

with

$$
\begin{array}{ll}
Q=z_{0} z_{3}-z_{1} z_{2}, & q_{1}=z_{2}^{2}+z_{0} L_{1}+t z_{3} L_{2} \\
q_{2}=-z_{2} z_{3}-z_{1} L_{1}+t z_{3} L_{3}, & q_{3}=-z_{2} L_{0}-z_{1} L_{2}-z_{0} L_{3}
\end{array}
$$

For generic $L_{i}$ 's and $t \neq 0$ the $2 \times 2$ minors of $M_{t}$ generate the ideal of a generic elliptic quintic curve as in $\mathcal{E}_{6}$. For $M_{0}$ the $2 \times 2$ minors become $Q z_{0}, Q z_{1}, Q z_{2}, \mathcal{S}_{1}, \mathcal{S}_{2}$, and $\mathcal{S}_{3}$ with

$$
\mathcal{S}_{1}=-z_{2} Q, \quad \mathcal{S}_{2}=-z_{1} q_{3}+z_{2} q_{2}, \quad \mathcal{S}_{3}=z_{0} q_{3}+z_{2} q_{1} .
$$

Therefore the ideal $\mathcal{M}_{2}$ generated by these minors is

$$
\left(Q z_{0}, Q z_{1}, Q z_{2}, \mathcal{S}_{2}, \mathcal{S}_{3}\right)
$$

Denote by $\ell$ the line defined by $I_{\ell}=\left(z_{1}, z_{3}\right)$. According to

$$
z_{3} \mathcal{S}_{3}=-z_{2} \mathcal{S}_{2}+Q\left(q_{3}+L_{1} z_{2}\right) \quad \& \quad z_{1} \mathcal{S}_{3}=-z_{0} \mathcal{S}_{2}-z_{2}^{2} Q
$$

$\mathcal{M}_{2}$ is the ideal of the residual of $\ell$ in the complete intersection of ideals $\left(Q, \mathcal{S}_{2}\right)$.
It only remains to prove that one can obtain the generic element of $\overline{\mathcal{E}_{7}}$ with a good choice of the $L_{i}$ 's; in other words it remains to prove that $S_{2}$ is generic among the cubics singular at $p$ that contain $\ell$. Modulo $Q$ one can assume that $q_{3}=-z_{3} a+b$, with $a$ (resp. b) an element of $\mathbb{C}\left[z_{1}, z_{2}\right]_{1}$ (resp. $\mathbb{C}\left[z_{0}, z_{1}, z_{2}\right]_{2}$ ). Then

$$
\mathcal{S}_{2}=-z_{3}\left(z_{1} a+z_{2}^{2}\right)+z_{1}\left(b-z_{2} L_{1}\right)
$$

in conclusion $\mathcal{S}_{2}=z_{3} A+z_{2} B$ for generic $A$ and $B$ in $\mathbb{C}\left[z_{0}, z_{1}, z_{2}\right]_{2}$.

### 5.2. Relations between $\overline{\operatorname{Bir}_{3,3}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)}$ and $\overline{\operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)}$. One can now state the following result:

Proposition 5.3. The set $\mathfrak{r u l e d}_{3,3}$ intersects the closure of any irreducible component of $\overline{\operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)}$.
Proof. According to Lemma 2.4 it is sufficient to prove that $\mathfrak{r u l e d}_{3,3}$ intersects the closure of $(3,4)$ birational maps that are non-ruled.

Let us consider an element $\psi$ of $\operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ whose $\mathcal{C}_{2}$ is the union of the lines of ideals

$$
I_{\delta}=\left(z_{0}, z_{1}^{2}\right), \quad\left(z_{0}-\varepsilon z_{2}, z_{1}\right), \quad I_{\ell_{1}}=\left(z_{0}, z_{3}\right), \quad I_{\ell_{2}}=\left(z_{1}, z_{2}\right)
$$

Denote by $\mathcal{J}_{\varepsilon}=\left(z_{0}, z_{1}^{2}\right) \cap\left(z_{0}-\varepsilon z_{2}, z_{1}\right) \cap\left(z_{0}, z_{3}\right) \cap\left(z_{1}, z_{2}\right)$. One can check that

$$
\mathcal{I}_{\varepsilon}=\left(z_{0} z_{1}, z_{0}^{2} z_{2}+\varepsilon z_{0} z_{2}^{2}, z_{1}^{2} z_{3}\right) .
$$

Set $I_{\varepsilon}=z_{0} z_{1}\left(z_{0}, z_{1}, z_{2}\right)+\left(z_{0}^{2} z_{2}+\varepsilon z_{0} z_{2}^{2}, z_{1}^{2} z_{3}\right)$. For a general $p_{2}$ the map $\psi_{\varepsilon}$ defined by $\Lambda_{\psi_{\varepsilon}}=$ $\mathrm{H}^{0}\left(\left(I_{\varepsilon} \cap I_{p_{2}}\right)(3)\right)$ is birational; furthermore

- $\psi_{\varepsilon} \in \operatorname{Bir}_{3,4}\left(\mathbb{P}_{\mathbb{C}}^{3}\right) \backslash \mathfrak{r u l e d}_{3,4}$ for $\varepsilon \neq 0$;
- $\psi_{0} \in \mathfrak{r u l e d}_{3,3}$.

As in the case of $(3,3)$ birational maps one has the following statement:
Theorem 5.4. If $\mathfrak{p}_{2} \in\{1,2\}$, then $\operatorname{Bir}_{3,4, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty and irreducible.

## 6. $(3,5)$-CREMONA TRANSFORMATIONS

6.1. General description of $(3,5)$ birational maps. We already find an irreducible component of the set of $(3,5)$ birational maps: $\mathfrak{r u l e d}_{3,5}$ (Proposition 3.10). Let us now consider a $(3,5)$ CREMONA transformation $\psi$ such that $\Lambda_{\psi}$ contains a cubic surface without double line.
6.1.1. Case: $\mathcal{C}_{1}$ smooth. In that situation $\operatorname{deg} \omega_{\mathcal{C}_{1}}(h)=3$ so according to (3.2) the map $\psi$ has two ordinary base points. The curve $\mathcal{C}_{2}$ has genus -1 and does not lie on a quadric; $\mathcal{C}_{2}$ is the disjoint union of a twisted cubic and a line, that is $\psi$ belongs to $\mathcal{E}_{12}$. Indeed suppose that $\psi \notin \overline{\mathcal{E}_{12}}$, then $\mathcal{C}_{2}$ is the union of two smooth conics $\Gamma_{1}$ and $\Gamma_{2}$ that do not intersect. Any $\Gamma_{i}$ is contained in a plane $\mathcal{P}_{i}$. Denote by $\ell$ the intersection $\mathcal{P}_{1} \cap \mathcal{P}_{2}$. As $\#\left(\ell \cap\left(\Gamma_{1} \cup \Gamma_{2}\right)\right)=4$, all the cubic surfaces that contain $\Gamma_{1} \cup \Gamma_{2}$ contain $\ell$. So $\ell \subset \mathcal{C}_{2}$ : contradiction.
6.1.2. Case: $\mathcal{C}_{1}$ not smooth. So $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right) \geq 1$, and

$$
\mathfrak{p}_{a}\left(\mathcal{C}_{2}\right)=\operatorname{deg} \mathcal{C}_{2}-\operatorname{deg} \mathcal{C}_{1}+\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=-1+\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right) \geq 0
$$

Since $\mathcal{C}_{1}$ is not in a plane, $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right) \leq 2$. Therefore we only have to distinguish the eventualities $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=1$ and $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=2$. Before looking at any of these eventualities let us introduce the set

$$
\mathscr{C}=\left\{\text { irreducible curves of } \mathbb{P}_{\mathbb{C}}^{3} \text { of degree } 5 \text { and geometric genus } 0\right\}
$$

- Assume first that $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=1$. Then $O_{\mathcal{C}_{1}}=\omega_{\mathcal{C}_{1}}$. We will denote by $\pi: \mathbb{P}_{\mathbb{C}}^{1} \rightarrow \mathcal{C}_{1}$ the normalization of $\mathcal{C}_{1}$.
$\left.a_{1}\right)$ Suppose first that all the elements of $\Lambda_{\psi}$ are singular at $p \in \mathbb{P}_{\mathbb{C}}^{3}$. Denote by $L$ the 2dimensional vector space $\Lambda_{\psi} \cap \mathrm{H}^{0}\left(\left(I_{p}^{2} \cap I_{\mathcal{C}_{1}}\right)(3 h)\right)$ defining $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$. By the liaison sequence (3.2) of Lemma 3.1 $\frac{\Lambda_{\psi}}{L}$ gives a vector subspace $u$ of $\mathrm{H}^{0}\left(\omega_{\mathcal{C}_{1}}(h)\right)=\mathrm{H}^{0}\left(O_{\mathcal{C}_{1}}(h)\right)$ of dimension 2. It induces a projection from $\mathcal{C}_{1}$ to $\left|u^{\vee}\right|$ that coincides with the restriction of $\psi$ to $\mathcal{C}_{1}$; hence this projection has degree 1. Moreover, via the identification $\mathrm{H}^{0}\left(O_{\mathcal{C}_{1}}(h)\right)=\mathrm{H}^{0}\left(\pi^{*} O_{\mathcal{C}_{1}}(h)\right), u$ is included in the set $V_{1}$ of sections of $O_{\mathbb{P}_{\mathbb{C}}^{1}}(5)$ whose base locus contains $\pi^{-1}(p)$; there are two other ordinary base points.

We would like to show that $\mathcal{C}_{2}$ moves in an irreducible family. We will do this by deforming $\psi\left(\right.$ and $\mathcal{C}_{2}$ ) while $\mathcal{C}_{1}$ is fixed. So, $p \in \mathbb{P}_{\mathbb{C}}^{3}$ being fixed, let us consider

$$
\mathcal{R}_{p, 1}=\left\{\mathcal{C} \in \mathscr{C} \mid\{p\}=\operatorname{Sing} \mathcal{C}, \mathfrak{p}_{a}(\mathcal{C})=1\right\}
$$

the set $\mathcal{R}_{p, 1}$ is an irreducible one. Remark that ${ }^{0} I_{\mathcal{C}}(3 h)=\operatorname{deg} \mathcal{C}+\mathfrak{p}_{a}(\mathcal{C})-1=5$ and $\left.\mathrm{h}^{0}\left(\left(I_{p}^{2} \cap I_{\mathcal{C}}\right)(3 h)\right)\right)=5-1=4$ because $\mathcal{C}$ has a double point at $p$ for all $\mathcal{C}$ in $\mathcal{R}_{p, 1}$.

Let us denote by $F_{1}$ the set of $(\mathcal{C}, L, u) \in \mathcal{R}_{1, p} \times \mathrm{H}^{0}\left(\left(I_{p}^{2} \cap I_{\mathcal{C}}\right)(3 h)\right) \times V_{1}$ defined by

- $L \subset \mathrm{H}^{0}\left(\left(I_{p}^{2} \cap I_{\mathcal{C}}\right)(3 h)\right)$ of dimension 2 such that the residual of $\mathcal{C}$ in the complete intersection defined by $L$ has no common component with $\mathcal{C}$, and $\mathcal{C}$ is geometrically linked to a curve denoted by $\mathcal{C}_{2, L}$,
$-u \subset V_{1}$ of dimension 2 such that $\mathbb{P}_{\mathbb{C}}^{1} \rightarrow\left|u^{\vee}\right|$ has degree 1 .
The set $F_{1}$ is irreducible since the choice of $\mathcal{C}$ is irreducible, and thus the choices of $L$ and $u$ too.

If $(C, L, u)$ belongs to $F_{1}$, let us set

$$
h_{L}: \mathrm{H}^{0}\left(I_{\mathcal{C}_{2, L}}(3 h)\right) \rightarrow \mathrm{H}^{0}\left(\omega_{\mathcal{C}}(h)\right)
$$

(recall that $\frac{\mathrm{H}^{0}\left(I_{\mathcal{C}_{2, L}}(3 h)\right)}{L} \simeq \mathrm{H}^{0}\left(\omega_{\mathcal{C}}(h)\right)$ ). Consider the map

$$
\kappa_{1}: F_{1} \rightarrow \mathbb{G}\left(4 ; \mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathbb{C}}^{3}}(3)\right)\right), \quad(\mathcal{C}, L, u) \mapsto h_{L}^{-1}(u)
$$

By construction of $F_{1}$ if $\psi$ is birational, if all elements of $\Lambda_{\psi}$ are singular at $p$, and $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=1$, then $\Lambda_{\psi}$ is in the image of $\kappa_{1}$.

Lemma 6.1. The general element of $\mathrm{im}_{1}$ coincides with $\Lambda_{\psi}$ for some birational map $\psi$ of $\mathcal{E}_{14}$.

Proof. As $F_{1}$ is irreducible it is enough to show that $h_{L}^{-1}(u)$ is a birational system when $(C, L, u)$ is general in $F_{1}$. In that situation $\mathcal{C}_{2, L}$ is a curve of degree 4 , arithmetic genus 0 , singular at $p$, lying on a smooth quadric. Therefore $\mathcal{C}_{2, L}$ is reducible; more precisely it is the union of a twisted cubic and a line of this smooth quadric. All the elements of $h_{L}^{-1}(u)$ are cubic surfaces singular at $p$ because $\mathcal{C}_{2, L}$ has a double point at $p$, and the residual pencil $u \subset \mathrm{H}^{0}\left(\omega_{C}(h)\right)$ vanishes at $p$ by definition of $F_{1}$. From definition of $u, h_{L}^{-1}(u)$ has two ordinary base points $p_{1}$ and $p_{2}$. Hence let $\mathcal{C}_{1}$ be the residual of $\mathcal{C}_{2, L}$ in the intersection of two general cubics of $h_{L}^{-1}(u)$. Then $\mathcal{C}_{1}$ is singular at $p, \psi_{C, L, u}$ has degree 5 on $\mathcal{C}_{1}$, sends $\mathcal{C}_{1}$ onto a line, is birational, and its base locus contains $p, p_{1}, p_{2}$.

Let us remark that the previous irreducibility result asserts that the following example (belonging to family $\mathcal{E}_{18}$ ) that is not on a smooth quadric is nevertheless a deformation of elements of $\mathcal{E}_{14}$.

Example 6.2. Let $\mathcal{C}_{2}$ be the union of a line doubled on a smooth quadric with two other lines, such that all these lines contain a same point $p$. Set

$$
Q=z_{0} z_{3}-z_{1} z_{2}, \quad I_{p}=\left(z_{0}, z_{1}, z_{2}\right) ;
$$

then $I_{\mathcal{C}_{2}}=\left(\left(z_{2}, z_{0}\right)^{2}+(Q)\right) \cap\left(z_{1}, z_{2}\right) \cap\left(z_{0}-z_{2}, z_{1}-z_{2}\right)$. Now chose a double point of contact (note that the tangent cone must contain the tangent cone of $\mathcal{C}_{2}$ ):

$$
I_{\mathrm{dpc}}=\left(z_{2}^{2} z_{3}-z_{0} z_{1} z_{3}\right)+\left(z_{0}, z_{1}, z_{2}\right)^{3}
$$

and let $p_{1}$ and $p_{2}$ be two general points. Define $I_{\psi}$ by $I_{\mathcal{C}_{2}} \cap I_{\mathrm{dpc}} \cap I_{p_{1}} \cap I_{p_{2}}$. So $I_{\psi}$ is the intersections of $I_{p_{1}} \cap I_{p_{2}}$ with

$$
I_{\mathcal{C}_{2}} \cap I_{\mathrm{dpc}}=\left(z_{1} z_{2}^{2}-z_{2}^{3}, z_{0} z_{2}^{2}-z_{2}^{3}, z_{1}^{2} z_{2}-z_{2}^{3}-z_{0} z_{1} z_{3}+z_{2}^{2} z_{3}, z_{0} z_{1} z_{2}-z_{2}^{3}, z_{0}^{2} z_{2}-z_{2}^{3}, z_{0}^{2} z_{1}-z_{2}^{3}\right) .
$$

The tangent cone of $\mathcal{C}_{2}$ at $p$ has degree 4 but the tangent cone of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$ at $p$ has degree 6 , so $\mathcal{C}_{1}$ belongs to $\mathcal{R}_{p, 1}$.
$b_{1}$ ) Suppose now that $\Lambda_{\psi}$ contains a smooth element at $p$. Then $p$ is a point of contact, all the cubic surfaces are tangent at $p ; \mathcal{C}_{2} \subset Q$ is linked to a curve of degree 2 and genus -1 . In that case we have no restriction on the curves of genus 0 and degree 4 contrary to the previous case. Hence in general $Q$ is smooth, and $\mathcal{C}_{2}$ is a smooth rational curve on $Q$. Set $Q=z_{0} z_{3}-z_{1} z_{2}, I_{\ell_{1}}=\left(z_{0}, z_{1}\right)$, and $I_{\ell_{2}}=\left(z_{2}, z_{3}\right)$; one has

$$
\mathcal{I}=I_{\ell_{1} \cup \ell_{2}}=\left(z_{0} z_{2}, z_{0} z_{3}, z_{1} z_{2}, z_{1} z_{3}\right) .
$$

Let $S_{0}$ be the element of $\mathcal{I}$ given by

$$
a z_{0} z_{2}+b z_{0} z_{3}+c z_{1} z_{3} \quad a, b, c \in \mathbb{C}\left[z_{0}, z_{1}, z_{2}, z_{3}\right]_{1}
$$

one has $I_{\mathcal{C}_{2}}=\left(\left(\mathcal{S}_{0}, Q\right): \mathcal{J}\right)=\left(Q, \mathcal{S}_{0}, \mathcal{S}_{1}, \mathcal{S}_{2}\right)$ with

$$
\mathcal{S}_{1}=z_{0}^{2} a+z_{0} z_{1} b+z_{1}^{2} c, \quad \mathcal{S}_{2}=z_{2}^{2} a+z_{2} z_{3} b+z_{3}^{2} c
$$

The dimension of $\mathrm{H}^{0}\left(I_{\mathcal{C}_{2}}(3 h)\right)$ is 7; indeed one has the following seven cubics:

$$
I_{\mathcal{C}_{2}}=\left\langle Q z_{0}, Q z_{1}, Q z_{2}, Q z_{3}, S_{0}, S_{1}, S_{2}\right\rangle
$$

The map $\psi$ has no base point. Indeed $u=\frac{\Lambda_{\psi}}{\mathrm{H}^{0}\left(I_{C_{1} \cup C_{2}}(3)\right)}$ is contained in the sections of $O_{\mathbb{P}_{\mathbb{C}}^{1}}(5)$ whose base locus contains $2 \pi^{-1}(p)$; we thus already have an isomorphism between $\mathbb{P}_{\mathbb{C}}^{1}$ and $\left|u^{\vee}\right|$. The map $\psi$ belongs to $\overline{\mathcal{E}_{23}}$.

- Suppose that $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=2$. Then $\mathfrak{p}_{a}\left(\mathcal{C}_{2}\right)=1, \mathcal{C}_{1}$ lies on a quadric and $\mathrm{h}^{0} I_{\mathcal{C}_{1}}(3)=6$. We will still denote by $\pi: \mathbb{P}_{\mathbb{C}}^{1} \rightarrow \mathcal{C}_{1}$ the normalization of $\mathcal{C}_{1}$.
$a_{2}$ ) Assume first that $\mathcal{C}_{1}$ has a triple point $p$. The curve $\mathcal{C}_{1}$ is linked to a line by a complete intersection $\left(Q, \mathcal{S}_{0}\right)$ where $Q$ (resp. $\mathcal{S}_{0}$ ) is a cone (resp. a cubic) singular at $p$. We can write the normalization $\pi$ as follows ( $\alpha^{2} A, \alpha \beta A, \beta^{2} A, B$ ) with $A \in \mathbb{C}[\alpha, \beta]_{3}, B \in \mathbb{C}[\alpha, \beta]_{5}$, and $A, B$ without common factors. Then $Q=z_{1}^{2}-z_{0} z_{2}$, and $\mathrm{H}^{0}\left(\omega_{\mathcal{C}_{1}}(h)\right)$ can be identified with $\mathrm{H}^{0}\left(I_{\ell}(2)\right)$, where $I_{\ell}=\left(z_{0}, z_{1}\right)$. So $\mathrm{H}^{0}\left(\omega_{\mathcal{C}_{1}}(h)\right)$ is the 6 -dimensional subspace $W$ of $\mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathrm{C}}^{1}}(6)\right)$ spanned by $(\alpha, \beta) \cdot\left(\alpha^{2} A, \alpha \beta A, \beta^{2} A, B\right)$. Let us consider the subspace $V_{A}=$ $W \cap(A)$ of $W$. Let $L$ be the 2-dimensional vector space $\Lambda_{\psi} \cap \mathrm{H}^{0}\left(I_{\mathcal{C}_{1}}(3 h)\right)$. Then $\frac{\Lambda_{\psi}}{L}$ gives a 2-dimensional vector subspace $u$ of $V_{A}$. The restriction of $\psi$ to $\mathcal{C}_{1}$ gives a birational map $\mathbb{P}_{\mathbb{C}}^{1} \rightarrow\left|u^{\vee}\right|$ induced by $u \subset V_{A} \subset \mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathbb{C}}^{1}}(6)\right)$. Furthermore $\psi$ has two ordinary base points. We would like to show that in that case $\mathcal{C}_{2}$ moves in an irreducible family whose general element is the complete intersection of two quadrics. We thus fix a point $p \in \mathbb{P}_{\mathbb{C}}^{3}$ and introduce the irreducible set

$$
\mathcal{R}_{p, 2}=\left\{\mathcal{C} \in \mathscr{C} \mid\{p\}=\operatorname{Sing} \mathcal{C}, \mathfrak{p}_{a}(\mathcal{C})=2\right\} .
$$

We define the set $F_{2}$ as the $(\mathcal{C}, L, u) \in \mathcal{R}_{p, 2} \times \mathrm{H}^{0}\left(I_{\mathcal{C}}(3 h)\right) \times V_{A}$ given by

- $L \subset \mathrm{H}^{0}\left(I_{\mathcal{C}}(3 h)\right)$ of dimension 2 such that the residual of $\mathcal{C}$ in the complete intersection defined by $L$ has no common component with $\mathcal{C}$, and $\mathcal{C}$ is geometrically linked to a curve denoted by $\mathcal{C}_{2, L}$,
$-u \subset V_{A}$ of dimension 2 such that $\mathbb{P}_{\mathbb{C}}^{1} \rightarrow\left|u^{\vee}\right|$ is birational and whose base locus contains $\pi^{-1}(p)$.
Let us consider the map

$$
\kappa_{2}: F_{2} \rightarrow \mathbb{G}\left(4 ; \mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathbb{C}}^{3}}(3)\right)\right), \quad(\mathcal{C}, L, u) \mapsto h_{L}^{-1}(u) .
$$

If $\psi$ is birational, if $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=2$, and $\mathcal{C}_{1}$ has a triple point then $\psi$ belongs to im $\kappa_{2}$.
Lemma 6.3. The general element of $\mathrm{im}_{2}$ coincides with $\Lambda_{\psi}$ for some birational map $\psi$ of $\mathcal{E}_{13}$.

Proof. As $F_{2}$ is irreducible one can consider a general element of $F_{2}$, and then $\mathcal{C}_{2, L}$ is a curve of degree 4 , genus 1 and is the complete intersection of two smooth quadrics. The map $\psi$ has two ordinary base points $p_{1}, p_{2}$, and belongs to $\mathcal{E}_{13}$. More precisely $\Lambda_{\psi}=\mathrm{H}^{0}\left(\left(I_{\mathcal{C}_{2},} \cdot I_{p} \cap I_{p_{1}} \cap I_{p_{2}}\right)(3)\right)$.

Note that this irreducibility result asserts that the following example, where $\mathcal{C}_{2}$ is not a complete intersection of two quadrics is nevertheless a deformation of elements of $\mathcal{E}_{13}$.

Example 6.4. Let $\mathcal{C}_{2}$ be the union of a plane cubic $\mathcal{C}_{3}$ singular at $p$ and a line $\ell$ containing $p$ but not in the plane spanned by $\mathcal{C}_{3}$. For instance take $I_{p}=\left(z_{0}, z_{1}, z_{2}\right), I_{\ell}=\left(z_{1}, z_{2}\right), I_{\mathcal{C}_{3}}=$ $\left(z_{1}-z_{0},\left(z_{1}-z_{2}\right) z_{1} z_{3}+z_{0}^{3}+z_{1}^{3}+z_{2}^{3}\right)$. Let $I_{\mathrm{dpc}}$ be a double point of contact at $p$. (As we have already chose $\mathcal{C}_{2}$, we must take a quadric cone containing the tangent cone to $\mathcal{C}_{2}$ ). For instance one can take: $I_{\mathrm{dpc}}=\left(z_{1}^{2}-z_{0} z_{2}\right)+I_{p}^{3}$, and let

$$
\begin{array}{r}
\mathcal{I}=I_{\mathcal{C}_{2}} \cap I_{\mathrm{dpc}}=\left(z_{0} z_{2}^{2}-z_{1} z_{2}^{2}, z_{0} z_{1} z_{2}-z_{1}^{2} z_{2}, z_{0}^{2} z_{2}-z_{1}^{2} z_{2}, 2 z_{1}^{3}+z_{2}^{3}+z_{1}^{2} z_{3}-z_{0} z_{2} z_{3}\right. \\
\left.2 z_{0} z_{1}^{2}+z_{2}^{3}+z_{1}^{2} z_{3}-z_{0} z_{2} z_{3}, 2 z_{0}^{2} z_{1}+z_{2}^{3}+z_{1}^{2} z_{3}-z_{0} z_{2} z_{3}\right)
\end{array}
$$

chose two general points $p_{1}$ and $p_{2}$ and define by $I_{\psi}$ the ideal generated by the 4 cubics of $\mathcal{I} \cap I_{p_{1}} \cap I_{p_{2}}$. The tangent cone of $\mathcal{C}_{2}$ at $p$ has degree 3 , the tangent cone of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$ at $p$ has degree 6 (because $p$ is a double point of contact); hence $\mathcal{C}_{1}$ has also a triple point at $p$, and belongs to $\mathcal{R}_{p, 2}$.
$b_{2}$ ) Suppose now that $\mathcal{C}_{1}$ hasn't a triple point; $\mathcal{C}_{1}$ has thus two distinct double points. Fix two distinct points $p$ and $q$ in $\mathbb{P}_{\mathbb{C}}^{3}$, and set

$$
\mathcal{R}_{p, q, 2}=\left\{\mathcal{C} \in \mathscr{C} \mid\{p, q\}=\operatorname{Sing} \mathcal{C}, \mathfrak{p}_{a}(\mathcal{C})=2\right\}
$$

Let $V_{3}$ (resp. $V_{4}$ ) be the sections of $O_{\mathbb{P}_{\mathbb{C}}^{1}}(7)$ whose base locus contains $\pi^{-1}(p)$ and $\pi^{-1}(q)$ (resp. $\pi^{-1}(p)$ and $2 \pi^{-1}(q)$ ). The set $\mathcal{R}_{p, q, 2}$ is irreducible. Remark that for all $\mathcal{C}$ in $\mathcal{R}_{p, q, 2}$ one has

$$
\mathrm{h}^{0} I_{\mathcal{C}}(3 h)=6, \quad \mathrm{~h}^{0}\left(\left(I_{\mathcal{C}} \cap I_{p}^{2}\right)(3 h)\right)=5, \quad \mathrm{~h}^{0}\left(\left(I_{\mathcal{C}} \cap I_{p}^{2} \cap I_{q}^{2}\right)(3 h)\right)=4
$$

Remark 6.5. One cannot have two distinct points of contact. Assume by contradiction that there are two distinct points of contact $p$ and $q$. Denote by $\pi: \widetilde{\mathcal{C}}_{1} \rightarrow \mathcal{C}_{1}$ the normalization of $\mathcal{C}_{1}$. One would have $\pi^{*} \omega_{\mathcal{C}_{1}}(h)=O_{\mathbb{P}_{\mathbb{C}}^{1}}(7)$ but the linear system induced by $\psi$ would contain in the base locus $2 \pi^{-1}(p)+2 \pi^{-1}(q)$ which is of length 8 : contradiction with the fact that $\psi\left(C_{1}\right)$ is a line.

So one has the following alternative:
$\left.b_{2}\right)$ i) Either all the cubics of $\Lambda_{\psi}$ are singular at $p$ and $q$. One can then define the set $F_{3}$ of $(\mathcal{C}, L, u) \in \mathcal{R}_{p, q, 2} \times \mathrm{H}^{0}\left(\left(I_{\mathcal{C}} \cap I_{p}^{2} \cap I_{q}^{2}\right)(3 h)\right) \times V_{3}$ given by

- $L \subset \mathrm{H}^{0}\left(\left(I_{\mathcal{C}} \cap I_{p}^{2} \cap I_{q}^{2}\right)(3 h)\right)$ of dimension 2 such that the residual of $\mathcal{C}$ in the complete intersection defined by $L$ has no common component with $C$;
$-u \subset V_{3}$ of dimension 2 such that $\mathcal{C} \rightarrow\left|u^{\vee}\right|$ has degree 1 .
Let us consider the map

$$
\kappa_{3}: F_{3} \rightarrow \mathbb{G}\left(4 ; \mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathbb{C}}^{3}}(3)\right)\right), \quad(\mathcal{C}, L, u) \mapsto h_{L}^{-1}(u)
$$

If $\psi$ is birational, if $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=2$, if $\mathcal{C}_{1}$ has two distinct double points at $p$ and $q$ and if all the cubics of $\Lambda_{\psi}$ are singular at $p$ and $q$, then $\Lambda_{\psi}$ belongs to im $\kappa_{3}$.

Lemma 6.6. The general element of $\mathrm{im}_{3}$ coincides with $\Lambda_{\psi}$ for some birational map $\psi$ of $\mathcal{E}_{19}$.

Proof. As $F_{3}$ is irreducible one can consider a general element $(C, L, u)$ of $F_{3}$ and then $\mathcal{C}_{2, L}$ is a curve of degree 4 and genus 1 , is singular at $p$ and $q$, lies on a smooth quadric, and is reducible: $\mathcal{C}_{2, L}$ is the union of a twisted cubic $\Gamma$ and the line $\ell=(p q)$. Moreover all the elements of $h_{L}^{-1}(u)$ are singular at $p$ and $q$ (by definition of $V_{3}$ and by the fact that $\mathcal{C}_{2, L}$ is singular at $p$ and $q$ ).

In this situation as all the cubic surfaces are singular at $p$ and $q$,

$$
h_{L}^{-1}(u)=\mathrm{H}^{0}\left(\left(I_{\Gamma} \cdot I_{\ell} \cap I_{p_{1}} \cap I_{p_{2}}\right)(3)\right)
$$

where $p_{1}, p_{2}$ are two ordinary base points; $\psi$ belongs to $\mathcal{E}_{19}$.
$\left.b_{2}\right)$ ii) Or one of the cubic of $\Lambda_{\psi}$ is smooth at (for instance) $q$. Let us introduce the set $F_{4}$ of pairs $(\mathcal{C}, L) \in \mathcal{R}_{p, q, 2} \times \mathrm{H}^{0}\left(\left(I_{\mathcal{C}} \cap I_{p}^{2}\right)(3 h)\right)$ satisfying: $L \subset \mathrm{H}^{0}\left(\left(I_{\mathcal{C}} \cap I_{p}^{2}\right)(3 h)\right)$ of dimension 2 such that the residual of $\mathcal{C}$ in the complete intersection defined by $L$ has no common component with $\mathcal{C}$.
Let us consider the map

$$
\kappa_{4}: F_{4} \rightarrow \mathbb{G}\left(4 ; \mathrm{H}^{0}\left(O_{\mathbb{P}_{\mathbb{C}}^{3}}(3)\right)\right), \quad(\mathcal{C}, L) \mapsto h_{L}^{-1}\left(V_{4}\right) ;
$$

note that $\operatorname{dim} V_{4}=2$.
If $\psi$ is birational, if $\mathfrak{p}_{a}\left(\mathcal{C}_{1}\right)=2, \mathcal{C}_{1}$ hasn't a triple point and one of the cubic of $\Lambda_{\psi}$ is smooth at (for instance) $q$, then $\Lambda_{\psi}$ belongs to im $\kappa_{4}$.

Lemma 6.7. The general element of $\mathrm{im}_{4}$ coincides with $\Lambda_{\psi}$ for some birational map $\psi$ of $\mathcal{E}_{24}$.

Proof. As $F_{4}$ is irreducible one can consider a general element of $F_{4}$, and then $\mathcal{C}_{2, L}$ is a curve of degree 4 , genus 1 , singular at $p$, and is the complete intersection of two quadrics. The map $\psi$ has no base point and belongs to $\mathcal{E}_{24}$.
6.2. Irreducible components. The following statement, and Theorems 4.4 and 5.2 imply Theorem A.
Theorem 6.8. One has the inclusions: $\mathcal{E}_{14} \subset \overline{\mathcal{E}_{12}}, \mathcal{E}_{24} \subset \overline{\mathcal{E}_{23}}$, and $\mathcal{E}_{19} \subset \overline{\mathcal{E}_{12}}$.
The set $\operatorname{Bir}_{3,5}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ has four irreducible components: $\mathcal{E}_{12}, \mathcal{E}_{13}, \mathcal{E}_{23}$, and $\mathcal{E}_{27}=\mathfrak{r u l e d}{ }_{3,5}$.
Proof. Let us first prove that $\mathcal{E}_{14} \subset \overline{\mathcal{E}_{12}}$. If $\psi$ belongs to $\mathcal{E}_{12}$, or to $\mathcal{E}_{14}$ the curve $\mathcal{C}_{2}$ is the union of a line $\ell$ and a twisted cubic $\Gamma$ such that length $(\ell \cap \Gamma) \leq 1$. Let $I_{\ell}$ (resp. $I_{\Gamma}$ ) be the ideal of $\ell$ (resp. $\Gamma$ ). We have $I_{\psi} \subset I_{\ell} \cap I_{\Gamma}$. If $\psi$ belongs to $\mathcal{E}_{12}$, then $\ell \cap \Gamma=\emptyset$, and $I_{\ell} \cap I_{\Gamma}=I_{\ell} \cdot I_{\Gamma}$. And if $\psi$ is in $\mathcal{E}_{14}$, then all the cubics are singular at $p=\ell \cap \Gamma$ so $I_{\psi}$ is again in $I_{\ell} \cdot I_{\Gamma}$.

Prove now that $\mathcal{E}_{24} \subset \overline{\mathcal{E}_{23}}$. Consider a general element $\psi$ of $\mathcal{E}_{24}$; the curve $\mathcal{C}_{2}$ is the complete intersection of a quadric $Q^{\prime}=a z_{2}+b z_{0}+c z_{1}$ passing through the double point $p$ and a cone $Q_{0}=$ $z_{1} z_{2}-z_{0}^{2}$. Furthermore all the cubics of $I_{\psi}$ are singular at $p$, and $I_{\psi} \subset g_{0}^{\prime}=\left(Q_{0}, z_{0} Q^{\prime}, z_{1} Q^{\prime}, z_{2} Q^{\prime}\right)$. Let $\mathfrak{c t}_{q}$ be the ideal of the point of contact $q$; one has $\mathfrak{c t}_{q}=I_{q}^{2}+\left(H_{q}\right)$ where $H_{q}$ is a plane passing through $q$. Denote by $I_{0}$ the intersection of $\mathscr{I}_{0}^{\prime}$ and $\mathfrak{c t}_{q}$. Set

Q_{t}=Z_{1} Z_{2}-Z_{0} Z_{3}, & \mathcal{S}_{0}=a Z_{0} Z_{2}+b Z_{0} Z_{3}+c Z_{1} Z_{3} \\
\mathcal{S}_{1}=a Z_{0}^{2}+b Z_{0} Z_{1}+c Z_{1}^{2}, & \mathcal{S}_{2}=a Z_{2}^{2}+b Z_{2} Z_{3}+c Z_{3}^{2}
\end{array}
$$

Hence $J_{t}=\left(Q_{t}, \mathcal{S}_{0}, \mathcal{S}_{1}, \mathcal{S}_{2}\right)$ is the ideal of a rational quartic if $t \neq 0\left(c f\right.$. the equations in $\left.\left.\S 6.1 .1 b_{1}\right)\right)$. The ideal $I_{t}=\mathcal{I}_{t} \cap \mathfrak{c t}_{q}$ is the ideal $I_{\psi}$ of $\psi \in \mathcal{E}_{23}$. Remark that if $t=0$, then

I_{0}=\left(Q_{0}, z_{0} Q^{\prime}, a z_{0}^{2}+b z_{0} z_{1}+c z_{1}^{2}, a z_{2}^{2}+b z_{0} z_{2}+c z_{0}^{2}\right)
$$

but $a z_{0}^{2}+b z_{0} z_{1}+c z_{1}^{2}=z_{1} Q^{\prime}$ modulo $Q$, and $a z_{2}^{2}+b z_{0} z_{2}+c z_{0}^{2}=z_{2} Q^{\prime}$ modulo $Q$, that is $g_{0}^{\prime}=g_{0}$. Therefore $I_{t}$ tends to $I_{0}$ as $t$ tends to 0 .

The inclusion $\mathcal{E}_{19} \subset \overline{\mathcal{E}_{12}}$ follows from $\Lambda_{\psi}=\mathrm{H}^{0}\left(\left(I_{\ell} \cdot I_{\Gamma} \cap I_{p_{1}} \cap I_{p_{2}}\right)(3)\right)$ found in $\left.b_{2}\right)$ i).
Note that $\mathcal{E}_{12} \not \subset \overline{\mathcal{E}_{13}}$ (resp. $\mathcal{E}_{12} \not \subset \overline{\mathcal{E}_{23}}$ ): if $\psi$ is in $\mathcal{E}_{12}$ then the associated $\mathcal{C}_{2}$ does not lie on a quadric whereas if $\psi$ belongs to $\mathcal{E}_{13}$ (resp. $\mathcal{E}_{23}$ ) then $\mathcal{C}_{2}$ lies on two quadrics (resp. one quadric). Conversely $\mathcal{E}_{13} \not \subset \overline{\mathcal{E}_{12}}$ (resp. $\mathcal{E}_{23} \not \subset \overline{\mathcal{E}_{12}}$ ): if $\psi$ is an element of $\mathcal{E}_{13}$ (resp. $\mathcal{E}_{23}$ ), then $\mathcal{C}_{2}$ is smooth and irreducible whereas the associated $\mathcal{C}_{2}$ of a general element of $\mathcal{E}_{12}$ is the disjoint union of a twisted cubic and a line.

Let us now justify that $\mathcal{E}_{23} \not \subset \overline{\mathcal{E}_{13}}$ : the linear system of an element of $\mathcal{E}_{23}$ has a smooth surface whereas the linear system of an element of $\mathcal{E}_{13}$ does not. Conversely $\mathcal{E}_{13} \not \subset \overline{\mathcal{E}_{23}}$; indeed $h^{0} I_{\mathcal{C}_{2}}(3 h)=6$ for a birational map of $\mathcal{E}_{13}$ and $h^{0} I_{\mathcal{C}_{2}}(3 h)=7$ for a birational map of $\mathcal{E}_{23}$.

In bidegree $(3,5)$ the description of $\operatorname{Bir}_{3,5, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is very different from those of smaller bidegrees. Let us now prove Theorem C.
Theorem 6.9. The set $\operatorname{Bir}_{3,5, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is empty as soon as $\mathfrak{p}_{2} \notin\{-1,0,1\}$ and

- if $\mathfrak{p}_{2}=-1$, then $\operatorname{Bir}_{3,5, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty, and irreducible;
- if $\mathfrak{p}_{2}=0$, then $\operatorname{Bir}_{3,5, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty, and has two irreducible components: one formed by the birational maps of $\mathcal{E}_{14}$, and the other one by the elements of $\mathcal{E}_{23}$;
- if $\mathfrak{p}_{2}=1$, then $\operatorname{Bir}_{3,5, \mathfrak{p}_{2}}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ is non-empty, and has three irreducible components: one formed by the birational maps of $\mathcal{E}_{13}$, a second one formed by the birational maps of $\mathcal{E}_{19}$, and a third one by the elements of $\mathcal{E}_{24}$.

Proof. • Assume $\mathfrak{p}_{2}=-1$. In that case only one family appears: $\mathcal{E}_{12}$ (see § 6.1.1), and according to Theorem 6.8 the family $\mathcal{E}_{12}$ is already an irreducible component of $\operatorname{Bir}_{3,5}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$ so an irreducible component of $\operatorname{Bir}_{3,5,-1}\left(\mathbb{P}_{\mathbb{C}}^{3}\right)$.

- Suppose $\mathfrak{p}_{2}=0$. We found two families : $\mathcal{E}_{14}$ (case $a_{1}$ ) of §6.1.1), and $\mathcal{E}_{23}$ (case $b_{1}$ ) of $\S$ 6.1.2). Note that for $\psi$ general in $\mathcal{E}_{23} \Lambda_{\psi}$ contains smooth cubics whereas all cubics of $\Lambda_{\psi}$ are singular as soon as $\psi$ belongs to $\mathcal{E}_{14}$. Hence $\mathcal{E}_{23} \not \subset \overline{\mathcal{E}_{14}}$.

Take a general element of $\mathcal{E}_{14}$; it hasn't a base scheme of dimension 0 , connected and of length $\geq 3$ whereas elements of $\overline{\mathcal{E}_{23}}$ have. Therefore $\mathcal{E}_{14} \not \subset \overline{\mathcal{E}_{23}}$.

- Assume last that $\mathfrak{p}_{2}=1$. Our study gives three families: $\mathcal{E}_{13}, \mathcal{E}_{19}$ and $\left.\left.\mathcal{E}_{24}\left(\operatorname{cases} a_{2}\right), b_{2}\right) \mathrm{i}\right)$ and $b_{2}$ )ii) of $\S 6.1 .2$ ). The general element of $\mathcal{E}_{19}$ has two double points whereas a general element of $\mathcal{E}_{13}$ (resp. $\mathcal{E}_{24}$ ) has only one; thus $\mathcal{E}_{19} \not \subset \overline{\mathcal{E}_{13}}$ and $\mathcal{E}_{19} \not \subset \overline{\mathcal{E}_{24}}$.

Take a general element in $\mathcal{E}_{13}$; its base locus is a smooth curve. On the contrary if $\psi$ belongs to $\mathcal{E}_{19}$ (resp. $\mathcal{E}_{24}$ ), then the base locus of $\psi$ is a singular curve. Thus $\mathcal{E}_{13} \not \subset \overline{\mathcal{E}_{19}}$ (resp. $\mathcal{E}_{13} \not \subset \overline{\mathcal{E}_{24}}$ ).

If $\psi$ is a general element of $\mathcal{E}_{24}$ its base locus is an irreducible curve that is not the case if $\psi \in \mathcal{E}_{19}$ so $\mathcal{E}_{24} \not \subset \overline{\mathcal{E}_{19}}$.

Let us now consider a general element of $\mathcal{E}_{24}$, the tangent plane at all cubic surfaces at the point of contact doesn't contain the double point $p$; hence if we denote by $Q_{1}$ and $Q_{2}$ the quadrics containing $\mathcal{C}_{2}$ there doesn't exist a plane $h$ passing through $p$ such that $\left(h Q_{1}, h Q_{2}\right) \subset \Lambda_{\psi}$. But if we take $\psi$ in $\mathcal{E}_{13}$ then $\Lambda_{\psi}=\mathrm{H}^{0}\left(\left(I_{\mathcal{C}_{2}} \cdot I_{p} \cap I_{p_{1}} \cap I_{p_{2}}\right)(3)\right)$ with $p_{1}, p_{2}$ two ordinary base points, and $p$ the triple point lying on $\mathcal{C}_{1}$. If $h$ is the plane passing through $p$, $p_{1}$ and $p_{2}$, if $I_{\mathcal{C}_{2}}=\left(Q_{1}, Q_{2}\right)$, then $\left(h Q_{1}, h Q_{2}\right) \subset \Lambda_{\psi}$. Thus $\mathcal{E}_{24} \not \subset \overline{\mathcal{E}_{13}}$.

## 7. Relations with Hudson's invariants

To prove the birationality of a linear system of cubics, the local properties of $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ are required. For instance to apply Lemma 3.4 one needs to understand the support of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$ and the local intersection of $\mathcal{C}_{1}$ with a general element of $\Lambda_{\psi}$ at any point of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$. So in the following table we make a schematic picture of the tangent cone of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$ at one of its singular point in the different cases considered by Hudson. Let us note that the degree of the tangent cone of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$ at a point of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$ varies from 1 to 6 . In particular if the linear system has a double point (resp. a double point of contact), then it is a complete intersection of two quadric cones (resp. of one quadric cone and one cubic cone). We draw pictures only when the quadric cone is irreducible. If the linear system has a binode, the tangent cone of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$ has degree 5 ; more precisely for a binode at $p=\left(z_{0}, z_{1}, z_{2}\right)$ whose fixed plane is $z_{0}$, i.e. $I_{\psi} \subset I_{p} \cdot\left(z_{0}\right)$, then the ideal of the tangent cone of $\mathcal{C}_{1} \cup \mathcal{C}_{2}$ at $p$ is $\left(z_{0} z_{1}, z_{0} z_{2}, P\right)$ where $P$ denotes an element of $\mathbb{C}\left[z_{1}, z_{2}\right]_{4}$. In our pictures the marked plane of the binode is vertical.

Convention. If the point is black (resp. white) then $\mathcal{C}_{2}$ does not pass (resp. passes through) through the point. For all cases mentioned in the paper we precise $\left(\widetilde{d}_{1}, \widetilde{d}_{2}\right)$ where $\widetilde{d}_{i}$ is the degree of the tangent cone of $\mathcal{C}_{i}$ at $p$.

Let us mention that this table in which we propose local illustrations could help the reader to visualize the different examples but the proofs are not based on it.
