# Asymptotic analysis of the transient response of a thermoelastic assembly involving a thin layer

#### Abstract

We study the transient response of a thermoelastic structure made of two three-dimensional bodies connected by a thin adhesive layer. Once more we highlight the powerful flexibility of Trotter's theory of approximation of semi-groups of operators acting on variable spaces: considering the geometrical and physical characteristics of the thin layer as parameters, we are able to show in a unitary way that this situation leads to a huge variety of limit models the properties of which are detailed. In particular, according to the relative behaviors of the different parameters involved, new features are evidenced such as the apparition of an added specific heat coefficient for the interface or of additional thermomechanical state variables defined not only on the limit geometric interface but on its cartesian product by any interval of real numbers.

## 1. Setting the problem

We pursue our investigations on thin junctions initiated in [1,2], then further developed in [3-11], and hereafter consider the situation of a transient multi-physical coupling within the scope of linear thermoelasticity. As in our previous works, we have chosen to use notations that may seem daunting but have the advantage of conveying all the information necessary to express the complexity of the studied problem.

Because interphases play a crucial role in the analysis of structure assemblies, the studies devoted to bonding problems cover a huge landscape. Within the scope of Mechanics, the

[^0]reader may refer to [12] and the references quoted therein for a good introduction. Rigorous mathematical approach to dynamical situations, however, are scarce. And because steady state cases should in fact be considered as particular cases of transient phenomena, the theory of approximation of semi-groups offers, from our point of view, an almost perfect tool dedicated to the mathematical modeling in Physics of continuous media. The interested reader will find good presentations of this theory in classical textbooks such as [13, 14], while Trotter's fundamental contribution [15] is presented and harnessed in various physical applications in [16]. More recently this theory has been the subject of a revival (see [17]) particularly because of the large number of problems it can address. Here, the power of this method will appear in three ways: first, despite the large number of parameters involved, we are able to carry out a rigorous mathematical study of this transient problem in a unitary manner (Section 2); second, this unitary study reveals a very wide variety of limit models (Section 3); third, we are able to extract new thermomechanical features from our models, such as the appearance of an additional specific heat coefficient for the interface or additional state variables (Section 4).

Let $\left\{e_{1}, e_{2}, e_{3}\right\}$ be an orthonormal basis of $\mathbb{R}^{3}$ assimilated to the physical Euclidean space. For all $\xi=\left(\xi_{1}, \xi_{2}, \xi_{3}\right)$ in $\mathbb{R}^{3}, \widehat{\xi}$ stands for $\left(\xi_{1}, \xi_{2}\right)$. The space of all $(n \times n)$ symmetric matrices is denoted by $\mathbb{S}^{n}$ and equipped with the usual inner product and norm denoted by $\cdot$ and \|| (as in $\mathbb{R}^{3}$ ). The space of linear symmetric mappings from $\mathbb{S}^{n}$ into $\mathbb{S}^{n}$ is denoted by $\operatorname{Lin}\left(\mathbb{S}^{n}\right.$ ). For all $\eta$ in $\mathbb{S}^{3}, \widehat{\eta}$ stands for the matrix $\left(\eta_{\alpha \beta}\right)_{1 \leq \alpha, \beta \leq 2}$ in $\mathbb{S}^{2}$. We study the dynamic response of a linearly thermoelastic structure consisting of two adhering bodies connected by a thin adhesive layer and subjected to a given loading. Let $\Omega$ be a domain of $\mathbb{R}^{3}$ with a Lipschitz-continuous boundary $\partial \Omega$. The intersection of $\Omega$ with $\left\{x_{3}=0\right\}$ is a domain $S$ of $\mathbb{R}^{2}$ with positive twodimensional Hausdorff measure $\mathscr{H}_{2}(S)$. Let $\varepsilon$ be a positive number and $\Omega^{ \pm}:=\Omega \cap\left\{ \pm x_{3}>0\right\}$, then the adhesive and the adhering bodies occupy $B_{\varepsilon}:=S \times\left(-\varepsilon,+\varepsilon\right.$ and $\Omega_{\varepsilon}^{ \pm}:=\Omega^{ \pm} \pm \varepsilon e_{3}$, respectively; we define $\Omega_{\varepsilon}:=\Omega_{\varepsilon}^{+} \cup \Omega_{\varepsilon}^{-}, S_{\varepsilon}^{ \pm}:=S \pm \varepsilon e_{3}$ and $\mathscr{O}_{\varepsilon}:=\Omega_{\varepsilon} \cup B_{\varepsilon} \cup S_{\varepsilon}^{+} \cup S_{\varepsilon}^{-}$. We consider two partitions $\left(\Gamma^{\mathcal{M}}, \Gamma^{\mathcal{M}}\right),\left(\Gamma^{\mathscr{T} \mathrm{D}}, \Gamma^{\mathscr{G}} \mathrm{N}\right)$ of $\partial \Omega$, and for all elements $\Gamma$ of these two partitions, the sets $\Gamma^{ \pm}, \Gamma_{\varepsilon}^{ \pm}$and $\Gamma_{\varepsilon}$ respectively denote $\Gamma \cap\left\{ \pm x_{3}>0\right\}, \Gamma^{ \pm} \pm \varepsilon e_{3}$ and $\Gamma_{\varepsilon}^{+} \cup \Gamma_{\varepsilon}^{-}$. Moreover we assume that $\mathscr{H}_{2}\left(\Gamma^{\mathcal{M}} \mathrm{D}+\right)$ and $\mathscr{H}_{2}\left(\Gamma^{\mathscr{G}} \mathrm{D}+\right)$ are positive. The contact between the adhesive and the two adhering bodies is assumed to be perfect from both thermal and mechanical points of view. The structure is clamped on $\Gamma_{\varepsilon}^{\mathcal{M} \mathrm{D}}$, subjected to body forces of density $f_{\varepsilon}$ and surface forces of density $g_{\varepsilon}^{\mathcal{M}}$ on $\Gamma_{\varepsilon}^{\mathcal{M}}$, it is maintained at a uniform temperature $T_{0}$ on $\Gamma_{\varepsilon}^{\mathscr{D}} \cup \gamma^{\mathscr{T}} \mathrm{D} \times(-\varepsilon, \varepsilon)$ and subjected to a thermal flux $g_{\varepsilon}^{\mathscr{G}}$ on $\Gamma_{\varepsilon}^{\mathscr{G}} \cup \gamma^{\mathscr{T}} \times(-\varepsilon, \varepsilon)$, where $\left(\gamma^{\mathscr{T} \mathrm{D}}, \gamma^{\mathscr{G} \mathrm{N}}\right)$ is a partition of $\partial S$. The whole structure is modeled as linearly thermoelastic in the following way. The symbols $\rho_{L}, \beta_{L}, \alpha_{L}, \kappa_{L}, \mu_{L} a_{L}$ respectively represent the mass density, the specific heat coefficient, the thermal dilatation, the thermal conductivity, and the elasticity tensor of the adhesive, while $d_{\varepsilon}=\left(\rho_{\varepsilon}, \beta_{\varepsilon}, \alpha_{\varepsilon}, \kappa_{\varepsilon}, a_{\varepsilon}\right)$ denotes the analogous quantities for the adhering bodies with

Thus the problem $\left(\mathscr{P}_{s}\right)$ of determining the evolution in the framework of small perturbations of the assembly, whose state is denoted by $U_{s}=\left(u_{s}, v_{s}, \theta_{s}\right), u_{s}, v_{s}, \theta_{s}$ being the fields of displacement, velocity and temperature increment with respect to $T_{0}$, involves a sextuplet $s:=$ ( $\left.\varepsilon, \rho_{L}, \mu_{L}, \beta_{L}, \kappa_{L}, \alpha_{L}\right)$ of data so that all the fields will be thereafter indexed by $s$. ## 3. A mathematical analysis of the asymptotic behavior

Now we regard the sextuplet $s$ of geometrical and thermomechanical data as a sextuplet of parameters taking values in a countable subset of $(0,+\infty)^{6}$ with a single cluster point $\bar{s}$ in $\{0\} \times[0,+\infty]^{5}$ and study the asymptotic behavior of $U_{s}$ in order to suggest a simplified but accurate enough model for the genuine physical situation. We will show that, depending on the relative behavior of ( $\rho_{L}, \mu_{L}, \beta_{L}, \kappa_{L}, \alpha_{L}$ ) with respect to $\varepsilon$, numerous (100!) limit models appear. They are indexed by $\mathrm{I}=\left(\mathrm{I}_{\mathrm{M}}, \mathrm{I}_{\mathrm{T}}\right) \in(\{0,1\} \times\{0,1,2,3,4\})^{2}, \mathrm{I}_{\mathrm{M}}=\left(\mathrm{I}_{\mathrm{M} 1}, \mathrm{I}_{\mathrm{M} 2}\right), \mathrm{I}_{\mathrm{T}}=\left(\mathrm{I}_{\mathrm{T} 1}, \mathrm{I}_{\mathrm{T} 2}\right)$ defined as follows. The physical properties of the adhesive layer corresponding to the various values of I will be conveyed in Section 4 through brief comments.

### 3.1. A candidate for the limit behavior

From now on, $C$ denotes various constants which may vary from line to line and we use the convention $0 \times \infty=\infty \times 0=0$.

### 3.1.1. The limit space $\mathfrak{H}^{\mathrm{I}}$

This candidate could be determined by studying the asymptotic behavior of sequences with bounded total thermomechanical energy. For the sake of notation simplicity, and when no confusion ensues, we will use the same symbols $U_{s}, u_{s}, v_{s}$ and $\theta_{s}$ to denote both the elements of general sequences and the solution to $\left(\mathscr{P}_{s}\right)$. It will appear that in some cases the thermomechanical state of the "limit structure", where the three-dimensional adhesive layer is geometrically replaced by the surface $S$ it shrinks to, does not involve the sole state variables of the adhering bodies but additional thermomechanical state variables not necessarily defined on $S$ but in $B:=S \times(-1,1)$ which accounts for the limit behavior of the adhesive layer.

It is convenient to introduce the following "scaling operators" which transform a field $y_{s}$ defined on $B_{\varepsilon}$ into a field $y_{s B}$ defined on $B$ in such a way that a bounded energy for $y_{s}$ is equivalent to a bounded "scaled" energy for $y_{s B}$ :

## 4. A thermomechanical presentation of the results

Here we intend to make more explicit the formulation (3.43) of the limit behavior of the structure. To lighten notations we skip the superscript I in ( $u^{\mathrm{I}}, \theta^{\mathrm{I}}$ ) and write ( $u, \theta$ ) instead; an over dot ${ }^{\prime \cdot \prime}$ denoting differentiation with respect to time, the motion equation reads as:

This corresponds to the transient response to the loading $\left(f, g^{\mathscr{M}}, g^{\mathscr{T}}\right)$ of each adhering body clamped on $\Gamma^{\mathcal{M}} \mathrm{D}^{ \pm}$maintained at a uniform temperature $T_{0}$ on $\Gamma^{\mathscr{G} \mathrm{D}^{ \pm}}$and thermomechanically linked along $S$. These contact conditions, which stem from the limit behavior of the adhesive layer, can be deduced from the various expressions of the two integrals on $B$ in (4.1)-(4.2). All this corresponds to a thermomechanical material surface occupying $S$ whose material constants are given by $\bar{\beta}+\bar{\beta}_{L}^{\text {add }}, \bar{\kappa}_{L}^{I}, \bar{\alpha}_{L}^{I}, \bar{\mu}_{L}^{I} \widetilde{a}_{L}$ subjected to an inner heat source and free of mechanical loading. When $\mathrm{I}_{\mathrm{T} 1}=1$ (high specific heat coefficient), as the additional temperature variable $\theta_{B}$ does depend on $x_{3}$, the limit thermoelastic behavior of the adhesive layer cannot be interpreted in terms of a material surface.

Thus, in order to clarify the thermomechanical condition between the two adhering bodies, difficulties occur when $\mathrm{I}_{\mathrm{M} 2}=1$ or 4 and/or $\mathrm{I}_{\mathrm{T} 2}=1$, which correspond to the cases when the additional state variable $u_{B}$ depends on $x_{3}\left(\mathrm{I}_{\mathrm{M} 2}=1\right)$, does not explicitly depends on the traces on $S$ of the displacements of the adhering bodies $\left(\mathrm{I}_{\mathrm{M} 2}=4\right)$ and/or the additional state variable $\theta_{B}$ depends on $x_{3}\left(\mathrm{I}_{\mathrm{T} 2}=1\right)$. In some of these cases, by adding a condition like $\mathrm{I}_{\mathrm{M} 1}=0$ (light adhesive layer) or $\mathrm{I}_{\mathrm{T} 1}=0$ (low specific heat coefficient) we again meet thermomechanical contact conditions involving the traces on $S$ of the state variables of the adhering bodies only as in the cases we listed previously.

so that, except when $\mathrm{I}_{\mathrm{M} 1}=0$ and $\mathrm{I}_{\mathrm{T} 2} \neq 0,1$ or $\bar{\alpha}_{L}^{\mathrm{I}}=0, u_{B}$ differs from $\operatorname{Aff}\left(u_{\Omega}\right)$ and the mechanical contact condition (4.11) does not involves the sole instantaneous values of the traces on $S$ of $u_{\Omega}^{ \pm}$ and $\theta_{\Omega}^{ \pm}$. Of course, as the equations governing the evolutions of $u_{B}$ and $\theta_{B}$ can be solved in terms of the whole history of the traces on $S$ of $u_{\Omega}^{ \pm}$and $\theta_{\Omega}^{ \pm}$, the contact condition at ( $\widehat{x}, t$ ) is a rather complex function of the history of $\gamma_{S}\left(u_{\Omega}^{ \pm}\right)(\widehat{x}, \cdot)$ and $\gamma_{S}\left(\theta_{\Omega}^{ \pm}\right)(\widehat{x}, \cdot)$ and not only of the history of the jumps $\llbracket u_{\Omega} \rrbracket(\widehat{x}, \cdot), \llbracket \theta_{\Omega} \rrbracket(\widehat{x}, \cdot)$.

When $\mathrm{I}_{\mathrm{T} 2}=1$, if $\operatorname{Aff}\left(\theta_{\Omega}\right)$ is defined similarly as $\operatorname{Aff}\left(u_{\Omega}\right)$ (see (4.13)), $\theta_{B}^{0}:=\theta_{B}-\operatorname{Aff}\left(\theta_{\Omega}\right)$ satisfies:

Except when $\left(\mathrm{I}_{\mathrm{M} 2}, \mathrm{I}_{\mathrm{T} 1}\right)=(2,0)$ or $\left(\bar{\alpha}_{L}^{\mathrm{I}}, I_{T 1}\right)=(0,0), \operatorname{Aff}\left(\theta_{\Omega}\right)$ does not solve (4.32), the thermal contact condition which at time $t$ reads as:

involves the whole history of $\gamma_{S}\left(u_{\Omega}^{ \pm}\right)$and $\gamma_{S}\left(\theta_{\Omega}^{ \pm}\right)$.
So, in every cases, the limit thermomechanical behavior of the two adhering bodies and of the adhesive layer are of the same (thermoelastic) type as that of the original situation. But, of course, peculiarities of the limit behavior of the layer and the thermomechanical contact condition which replaces it strongly depend on the relative behaviors of the geometric and thermomechanical
parameters. The thermomechanical coupling perpetuates when $\bar{\mu}_{L}^{\mathrm{I}} \bar{\alpha}_{L}^{\mathrm{I}} e_{B}^{u}$ does not vanish which is the case when $\mathrm{I}_{\mathrm{M} 2}$ differs from 0 or 2 with $\bar{\alpha}_{L}^{\mathrm{I}}$ positive.

## 5. Concluding remarks

This rather lengthy and complex thermomechanical presentation of the results of our mathematical analysis exemplifies the flexibility of use but also the power of Trotter's theory of approximation of semi-groups of operators acting on variable spaces: it permits a unitary treatment with very few technicalities.

Our proposal of simplified but accurate enough models for the behavior of the structure made of the two adhering bodies and the thin adhesive layer, which has to be formulated on the genuine reference configurations $\Omega_{\varepsilon}^{ \pm}$and $B_{\varepsilon}$ is of course obtained through the Trotter representant $P_{s}^{\mathrm{I}} U^{\mathrm{I}}$ of the solution $U^{\mathrm{I}}$ of the limit problem (3.43), s taking the values of the original data. When $\mathrm{I}_{\mathrm{M} 2}$ differs from 0 , a variant of $P_{s}^{\mathrm{I}} U^{\mathrm{I}}$ may be used through the construct detailed in the proof of Proposition 3.3. Thus, from a computational and practical point of view, a finite element approximation can be implemented without meshing the thin layer occupied by the adhesive!

It should be noted that, contrary to the cumbersome method-frequent in the literatureconsisting of firstly switching to a fixed abstract domain through a "scaling" (change of coordinates and unknowns), abstract domain where the convergence is formally or rigorously studied, and secondly returning-but not always-to the initial physical domain, we have hereby treated directly through the representation operator $P_{s}^{\mathrm{I}}$ the convergence of the initial problem where, obviously, the limit can be, according to index I, expressed in a fixed abstract domain defined through the "scaling" outlined above but which is used only when it is necessary to refine the determination of the asymptotic behavior of sequences of thermomechanical states with bounded energies.

To reduce the weight of our already copious study we have not detailed the cases $I_{M 2}=3+\alpha$ and $I_{M 2}=4+\beta$ corresponding to:

for which a straightforward comparison argument leads to the mechanical spaces defined by:

endowed by the norm defined in (3.9) together with the convention $\infty \times 0=0$.
Eventually the present study which corrects and improves [6] may be considered as a framework to assess the formal and partial modelings proposed in [22], concerning poroelasticity as it is well known that the equations involved in linear poroelasticity are the same as those in linear thermoelasticity, and [23].
