# GEOM-SPIDER-EM: FASTER VARIANCE REDUCED STOCHASTIC EXPECTATION MAXIMIZATION FOR NONCONVEX FINITE-SUM OPTIMIZATION

#### Abstract

The Expectation Maximization (EM) algorithm is a key reference for inference in latent variable models; unfortunately, its computational cost is prohibitive in the large scale learning setting. In this paper, we propose an extension of the Stochastic Path-Integrated Differential EstimatoR EM (SPIDER-EM) and derive complexity bounds for this novel algorithm, designed to solve smooth nonconvex finite-sum optimization problems. We show that it reaches the same state of the art complexity bounds as SPIDER-EM; and provide conditions for a linear rate of convergence. Numerical results support our findings.


Index Terms- Large scale learning, Latent variable analysis, Expectation Maximization, Stochastic nonconvex optimization, Variance reduction.

## 1. INTRODUCTION

Intelligent processing of large data set and efficient learning of highdimensional models require new optimization algorithms designed to be robust to big data and complex models era (see e.g. [1, 2, 3]). This paper is concerned with stochastic optimization of a nonconvex finite-sum smooth objective function

\operatorname{Argmin}_{\theta \in \Theta} F(\theta), \quad F(\theta) \stackrel{\text { def }}{=} \frac{1}{n} \sum_{i=1}^{n} \mathcal{L}_{i}(\theta)+\mathrm{R}(\theta) \tag{1}
\end{equation*}

when $\Theta \subseteq \mathbb{R}^{d}$ and $F$ cannot be explicitly evaluated (nor its gradient). Many statistical learning problems can be cast into this framework, where $n$ is the number of observations or examples, $\mathcal{L}_{i}$ is a loss function associated to example $\# i$ (most of often a negated log-likelihood), and R is a penalty term promoting sparsity, regularity, etc.. Intractability of $F(\theta)$ might come from two sources. The first, referred to as large scale learning setting, is that the number $n$ is very large so that the computations involving a sum over $n$ terms should be either simply avoided or sparingly used during the run of the optimization algorithm (see e.g. [4] for an introduction to the bridge between large scale learning and stochastic approximation; see [5, 6] for applications to training of deep neural networks for signal and image processing; and more generally, empirical risk minimization in machine learning is a matter for (1)). The second is due to the presence of latent variables: for any $i$, the function $\mathcal{L}_{i}$ as a (high-dimensional) integral over latent variables. Such a latent variable context is a classical statistical modeling: for example as a tool for solving inference in mixture models [7], for the definition of mixed models capturing variability among examples [8] or for

[^0]modeling hidden and/or missing variables (see e.g. applications in text modeling through latent Dirichlet allocation [9], in audio source separation [10, 11], in hyper-spectral imaging [12]).

In this contribution, we address the two levels of intractability in the case $\mathcal{L}_{i}$ is of the form

\mathcal{L}_{i}(\theta) \stackrel{\text { def }}{=}-\log \int_{\mathrm{Z}} h_{i}(z) \exp \left(\left\langle s_{i}(z), \phi(\theta)\right\rangle-\psi(\theta)\right) \mu(\mathrm{d} z) \tag{2}

This setting in particular covers the case when $\sum_{i=1}^{n} \mathcal{L}_{i}(\theta)$ is the negated log-likelihood of the observations $\left(Y_{1}, \cdots, Y_{n}\right)$, the pairs observation/latent variable $\left\{\left(Y_{i}, Z_{i}\right), i \leq n\right\}$ are independent, and the distribution of the complete data $\left(Y_{i}, Z_{i}\right)$ given by $\left(y_{i}, z\right) \mapsto$ $h_{i}(z) \exp \left(\left\langle s_{i}(z), \phi(\theta)\right\rangle-\psi(\theta)\right) \mu(\mathrm{d} z)$ is from the curved exponential family. Gaussian mixture models are typical examples, as well as mixtures of distributions from the curved exponential family.

In the framework (1)-(2), a Majorize-Minimization approach through the Expectation-Maximization (EM) algorithm [13] is standard; unfortunately, the computational cost of the batch EM can be prohibitive in the large scale learning setting. Different strategies were proposed to address this issue $[14,15,16,17,18]$ : they combine mini-batches processing, Stochastic Approximation (SA) techniques (see e.g. $[19,20]$ ) and variance reduction methods.

The first contribution of this paper is to provide a novel algorithm, the generalized Stochastic Path-Integrated Differential EstimatoR EM ( $9-S P$ IDER-EM), which is among the variance reduced stochastic EM methods for nonconvex finite-sum optimization of the form (1)-(2); the generalizations allow a reduced computational cost without altering the convergence properties. The second contribution is the proof of complexity bounds, that is the number of parameter updates (M-step) and the number of conditional expectations evaluations (E-step), in order to reach $\epsilon$-approximate stationary points; these bounds are derived for a specific form of g-SPIDER-EM: we show that its complexity bounds are the same as those of SPIDER-EM, bounds which are state of the art ones and overpass all the previous ones. Linear convergence rates are proved under a Polyak-Łojasiewicz condition. Finally, numerical results support our findings and provide insights on how to implement $g-S P$ IDER-EM in order to inherit the properties of SPIDER-EM while reducing the computational cost.

Notations For two vectors $a, b \in \mathbb{R}^{q},\langle a, b\rangle$ is the scalar product, and $\|\cdot\|$ the associated norm. For a matrix $A, A^{T}$ is its transpose. For a positive integer $n$, set $[n]^{\star} \stackrel{\text { def }}{=}\{1, \cdots, n\}$ and $[n] \stackrel{\text { def }}{=}\{0, \cdots, n\}$. $\nabla f$ denotes the gradient of a differentiable function $f$. The minimum of $a$ and $b$ is denoted by $a \wedge b$. Finally, we use standard big $O$ notation to leave out constants.

## 2. EM-BASED METHODS IN THE EXPECTATION SPACE

We begin by formulating the model assumptions:
A1. $\Theta \subseteq \mathbb{R}^{d}$ is a convex set. $(Z, \mathcal{Z})$ is a measurable space and $\mu$ is a $\sigma$-finite positive measure on $\mathcal{Z}$. The functions $\mathrm{R}: \Theta \rightarrow \mathbb{R}$, $\phi: \Theta \rightarrow \mathbb{R}^{q}, \psi: \Theta \rightarrow \mathbb{R}, s_{i}: \mathbf{Z} \rightarrow \mathbb{R}^{q}, h_{i}: \mathbf{Z} \rightarrow \mathbb{R}_{+}$for all $i \in[n]^{\star}$ are measurable. For any $\theta \in \Theta$ and $i \in[n]^{\star},\left|\mathcal{L}_{i}(\theta)\right|<\infty$.

For any $\theta \in \Theta$ and $i \in[n]^{\star}$, define the posterior density of the latent variable $Z_{i}$ given the observation $Y_{i}$ :

p_{i}(z ; \theta) \stackrel{\text { def }}{=} h_{i}(z) \exp \left(\left\langle s_{i}(z), \phi(\theta)\right\rangle-\psi(\theta)+\mathcal{L}_{i}(\theta)\right) \tag{3}
\end{equation*}

note that the dependence upon $y_{i}$ follows through the index $i$ in the above. Set

\begin{equation*}
\bar{s}_{i}(\theta) \stackrel{\text { def }}{=} \int_{\mathrm{Z}} s_{i}(z) p_{i}(z ; \theta) \mu(\mathrm{d} z), \quad \bar{s}(\theta) \stackrel{\text { def }}{=} n^{-1} \sum_{i=1}^{n} \bar{s}_{i}(\theta) \tag{4}
\end{equation*}

A2. The expectations $\bar{s}_{i}(\theta)$ are well defined for all $\theta \in \Theta$ and $i \in$ $[n]^{\star}$. For any $s \in \mathbb{R}^{q}$, $\operatorname{Argmin}_{\theta \in \Theta}(\psi(\theta)-\langle s, \phi(\theta)\rangle+\mathbf{R}(\theta))$ is a (non empty) singleton denoted by $\{\mathrm{T}(s)\}$.

EM is an iterative algorithm: given a current value $\tau_{k} \in \Theta$, the next value is $\tau_{k+1} \leftarrow \mathrm{~T} \circ \bar{s}\left(\tau_{k}\right)$. It combines an expectation step which boils down to the computation of $\bar{s}\left(\tau_{k}\right)$, the conditional expectation of $s(z)$ under $p\left(\cdot ; \tau_{k}\right)$; and a maximization step which corresponds to the computation of the map T. Equivalently, by using T which maps $\mathbb{R}^{q}$ to $\Theta$, it can be described in the expectation space (see [21]): given the current value $\bar{s}^{k} \in \bar{s}(\Theta)$, the next value is $\bar{s}^{k+1} \leftarrow \bar{s} \circ \mathbf{T}\left(\bar{s}^{k}\right)$.

In this paper, we see EM as an iterative algorithm operating in the expectation space. In that case, the fixed points of the EM operator $\bar{s} \circ \mathrm{~T}$ are the roots of the function $h$

h(s) \stackrel{\text { def }}{=} \bar{s} \circ \mathbf{T}(s)-s \tag{5}
\end{equation*}

EM possesses a Lyapunov function: in the parameter space, it is the objective function $F$ where by definition of the EM sequence, it holds $F\left(\tau_{k+1}\right) \leq F\left(\tau_{k}\right)$; in the expectation space, it is $\mathrm{W} \stackrel{\text { def }}{=}$ $F \circ \mathrm{~T}$, and $\mathrm{W}\left(\bar{s}^{k+1}\right) \leq \mathrm{W}\left(\bar{s}^{k}\right)$ holds. In order to derive complexity bounds, regularity assumptions are required on W :
A3. The functions $\phi, \psi$ and R are continuously differentiable on $\Theta^{v}$, where $\Theta^{v}$ is a neighborhood of $\Theta$. T is continuously differentiable on $\mathbb{R}^{q}$. The function $F$ is continuously differentiable on $\Theta^{v}$ and for any $\theta \in \Theta, \nabla F(\theta)=-\nabla \phi(\theta)^{T} \bar{s}(\theta)+\nabla \psi(\theta)+\nabla \mathrm{R}(\theta)$. For any $s \in \mathbb{R}^{q}, B(s) \stackrel{\text { def }}{=} \nabla(\phi \circ \mathrm{T})(s)$ is a symmetric $q \times q$ matrix and there exist $0<v_{\min } \leq v_{\max }<\infty$ such that for all $s \in \mathbb{R}^{q}$, the spectrum of $B(s)$ is in $\left[v_{\min }, v_{\max }\right]$. For any $i \in[n]^{\star}, \bar{s}_{i} \circ \mathrm{~T}$ is globally Lipschitz on $\mathbb{R}^{q}$ with constant $L_{i}$. The function $s \mapsto \nabla(F \circ \mathbf{T})(s)=$ $B(s)(\bar{s} \circ T(s)-s)$ is globally Lipschitz on $\mathbb{R}^{q}$ with constant $L_{\dot{\mathrm{W}}}$.

A6 implies that W has globally Lipschitz gradient and $\nabla W(s)=$ $-B(s) h(s)$ for some positive definite matrix $B(s)$ (see e.g. [21, Lemma 2]; see also [22, Propositions 1 and 2]). Note that this implies that $\nabla W\left(s^{\star}\right)=0$ iff $h\left(s^{\star}\right)=0$.

Unfortunately, in the large scale learning setting (when $n \gg 1$ ), EM can not be easily applied since each iteration involves $n$ conditional expectations (CE) evaluations through $\bar{s}=n^{-1} \sum_{i=1}^{n} \bar{s}_{i}$. Incremental EM techniques have been proposed to address this issue: the most straightforward approach amounts to use a SA scheme with mean field $h$ since. Upon noting that $h(s)=\mathbb{E}\left[\bar{s}_{I} \circ \mathrm{~T}(s)\right]-s$
where $I$ is a uniform random variable (r.v.) on $[n]^{\star}$, the fixed points of the EM operator $\bar{s} \circ \mathrm{~T}$ are those of the SA scheme

\widehat{S}_{k+1}=\widehat{S}_{k}+\gamma_{k+1}\left(\mathrm{~b}^{-1} \sum_{i \in \mathcal{B}_{k+1}} \bar{s}_{i} \circ \mathrm{~T}\left(\widehat{S}_{k}\right)-\widehat{S}_{k}\right) \tag{6}
\end{equation*}

where $\left\{\gamma_{k}, k \geq 0\right\}$ is a deterministic positive step size sequence, and $\mathcal{B}_{k+1}$ is sampled in $[n]^{\star}$ independently from the past of the algorithm. This forms the basis of Online-EM proposed by [15] (see also [23]). Variance reduced versions were also proposed and studied: Incremental EM (i-EM) [14, 24], Stochastic EM with variance reduction (sEM-vr) [16], Fast Incremental EM [17, 22] (FIEM) and more recently, Stochastic Path-Integrated Differential EstimatoR EM (SP IDER-EM) [18].

As shown in [22, section 2.3], these algorithms can be seen as a combination of SA with control variate: upon noting that $h(s)=$ $h(s)+\mathbb{E}[U]$ for any r.v. $U$ such that $\mathbb{E}[U]=0$, control variates within $S A$ procedures replace (6) with

\widehat{S}_{k+1}=\widehat{S}_{k}+\gamma_{k+1}\left(\mathrm{~b}^{-1} \sum_{i \in \mathcal{B}_{k+1}} \bar{s}_{i} \circ \mathrm{~T}\left(\widehat{S}_{k}\right)+U_{k+1}-\widehat{S}_{k}\right)
$$

for a choice of $U_{k+1}$ such that the new algorithm has better properties (for example, in terms of complexity - see the end of Section 3).

Lastly, we remark that A4-A6 are common assumptions satisfied by many statistical models such as the Gaussian Mixture Model; see [18] for a rigorous justification of these assumptions.

## 3. THE GEOM-SPIDER-EM ALGORITHM

Algorithm 1: The g-SPIDER-EM algorithm. The $\mathcal{E}_{t}$ 's are introduced as a perturbation to the computation of $\bar{s} \circ$ $\mathrm{T}\left(\widehat{S}_{t,-1}\right)$; they can be null.

The algorithm generalized Stochastic Path-Integrated Differential EstimatoR Expectation Maximization (g-SPIDER-EM) described by Algorithm 1 uses a new strategy when defining the approximation of $\bar{s} \circ \mathrm{~T}(s)$ at each iteration. It is composed of nested loops: $k_{\text {out }}$ outer loops, each of them formed with a possibly random number of inner loops. Within the $t$ th outer loop, 9 -SPIDER-EM mimics the identity $\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k}\right)=\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k-1}\right)+\left\{\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k}\right)-\bar{s} \circ\right.$ $\left.\mathrm{T}\left(\widehat{S}_{t, k-1}\right)\right\}$. More precisely, at iteration $k+1$, the approximation
$\mathrm{S}_{t, k+1}$ of the full sum $\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k}\right)$ is the sum of the current approximation $\mathrm{S}_{t, k}$ and of a Monte Carlo approximation of the difference (see Lines 5, 6, in Algorithm 1); the examples $i$ in $\mathcal{B}_{t, k+1}$ used in the approximation of $\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k}\right)$ and those used for the approximation of $\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k-1}\right)$ are the same - which make the approximations correlated and favor a variance reduction when plugged in the SA update (Line 7). $\mathcal{B}_{t, k+1}$ is sampled with or without replacement; even when $\mathcal{B}_{t, k+1}$ collects independent examples sampled uniformly in $[n]^{\star}$, we have $\mathbb{E}\left[\mathrm{S}_{t, k+1} \mid \mathcal{F}_{t, k}\right]-\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k}\right)=\mathrm{S}_{t, k}-\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k-1}\right)$ where $\mathcal{F}_{t, k}$ is the sigma-field collecting the randomness up to the end of the outer loop $\# t$ and inner loop $\# k$ : the approximation $\mathrm{S}_{t, k+1}$ of $\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, k}\right)$ is biased - a property which makes the theoretical analysis of the algorithm challenging. This approximation is reset (see Lines 2,9) at the end of an outer loop: in the "standard" SPIDER-EM, $\mathrm{S}_{t, 0}=\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t,-1}\right)$ is computed, but this "refresh" can be only partial, by computing an update on a (large) batch $\tilde{\mathcal{B}}_{t, 0}$ (size $\tilde{\mathrm{b}}_{t}$ ) of observations: $\mathrm{S}_{t, 0}=\tilde{\mathrm{b}}_{t}^{-1} \sum_{i \in \tilde{\mathcal{B}}_{t, 0}} \bar{s}_{i} \circ \mathrm{~T}\left(\widehat{S}_{t,-1}\right)$. Such a reset starts a so-called epoch (see Line 3). The number of inner loops $\xi_{t}$ at epoch $\# t$ can be deterministic $\xi_{t}$; or random, such as a uniform distribution on $\left[k_{\text {in }}\right]^{\star}$ or a geometric distribution, and drawn prior the run of the algorithm.

Comparing g-SPIDER-EM with SPIDER-EM [18], we notice that the former allows a perturbation $\mathcal{E}_{t}$ when initializing $\mathrm{S}_{t, 0}$. This is important for computational cost reduction. Moreover, g-SPIDER-EM considers epochs with time-varying length $\xi_{t}$ which covers situations when it is random and chosen independently of the other sources of randomness (the errors $\mathcal{E}_{t}$, the batches $\left.\mathcal{B}_{t, k+1}\right)$. Hereafter, we provide an original analysis of an g-SPIDER-EM, namely Geom-SPIDER-EM which corresponds to the case $\xi_{t} \leftarrow \Xi_{t}, \Xi_{t}$ being a geometric r.v. on $\mathbb{N}^{\star}$ with success probability $1-\rho_{t} \in(0,1): \mathbb{P}\left(\Xi_{t}=k\right)=\left(1-\rho_{t}\right) \rho_{t}^{k-1}$ for $k \geq 1$ (hereafter, we will write $\Xi_{t} \sim \mathcal{G}^{\star}\left(1-\rho_{t}\right)$ ). Since $\Xi_{t}$ is also the first success distribution in a sequence of independent Bernoulli trials, the geometric length could be replaced with: (i) at each iteration $k$ of epoch $t$, sample a Bernoulli r.v. with a probability of success ( $1-\rho_{t}$ ); (ii) when the coin comes up head, start a new epoch (see [ 25,26 ] for similar ideas on stochastic gradient algorithms).

Let us establish complexity bounds for Geom-SPIDER-EM. We analyze a randomized terminating iteration $\Xi^{\star}$ [27] and discuss how to choose $k_{\text {out }}, \mathbf{b}$ and $\xi_{1}, \cdots, \xi_{k_{\text {out }}}$ as a function of the batch size $n$ and an accuracy $\epsilon>0$ to reach $\epsilon$-approximate stationarity i.e. $\mathbb{E}\left[\left\|h\left(\widehat{S}_{\Xi^{\star}}\right)\right\|^{2}\right] \leq \epsilon$. To this end, we endow the probability space $(\Omega, \mathcal{A}, \mathbb{P})$ with the sigma-fields $\mathcal{F}_{1,0} \stackrel{\text { def }}{=} \sigma\left(\mathcal{E}_{1}\right)$, $\mathcal{F}_{t, 0} \stackrel{\text { def }}{=} \sigma\left(\mathcal{F}_{t-1, \xi_{t}}, \mathcal{E}_{t}\right)$ for $t \geq 2$, and $\mathcal{F}_{t, k+1} \stackrel{\text { def }}{=} \sigma\left(\mathcal{F}_{t, k}, \mathcal{B}_{t, k+1}\right)$ for $t \in\left[k_{\text {out }}\right]^{\star}, k \in\left[\xi_{t}-1\right]$. For a r.v. $\Xi_{t} \sim \mathcal{G}^{\star}\left(1-\rho_{t}\right)$, set $\overline{\mathbb{E}}_{t}\left[\phi\left(\Xi_{t}\right) \mid \mathcal{F}_{t, 0}\right] \stackrel{\text { def }}{=}\left(1-\rho_{t}\right) \sum_{k>1} \rho_{t}^{k-1} \mathbb{E}\left[\phi(k) \mid \mathcal{F}_{t, 0}\right]$ for any bounded measurable function $\phi$.

Theorem 1. Assume A4 to A6. For any $t \in\left[k_{\text {out }}\right]^{\star}$, let $\rho_{t} \in(0,1)$ and $\Xi_{t} \sim \mathcal{G}^{\star}\left(1-\rho_{t}\right)$. Run Algorithm 1 with $\gamma_{t, k+1}=\gamma_{t}>0$ and $\xi_{t} \leftarrow \Xi_{t}$ for any $t \in\left[k_{\text {out }}\right]^{\star}, k \geq 0$. Then, for any $t \in\left[k_{\text {out }}\right]^{\star}$,

$$
\begin{aligned}
& \frac{v_{\min } \gamma_{t}}{2\left(1-\rho_{t}\right)} \overline{\mathbb{E}}_{t}\left[\left\|h\left(\widehat{S}_{t, \Xi_{t}-1}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& \leq \mathrm{W}\left(\widehat{S}_{t, 0}\right)-\overline{\mathbb{E}}_{t}\left[\mathrm{~W}\left(\widehat{S}_{t, \Xi_{t}}\right) \mid \mathcal{F}_{t, 0}\right]+\frac{v_{\max } \gamma_{t}}{2\left(1-\rho_{t}\right)}\left\|\mathcal{E}_{t}\right\|^{2} \\
& +\frac{v_{\max } \gamma_{t} \gamma_{t, 0}^{2}}{2\left(1-\rho_{t}\right)} \frac{L^{2}}{\mathrm{~b}}\left\|\Delta \widehat{S}_{t, 0}\right\|^{2}+\mathcal{N}_{t} \overline{\mathbb{E}}_{t}\left[\left\|\Delta \widehat{S}_{t, \Xi}\right\|^{2} \mid \mathcal{F}_{t, 0}\right]
\end{aligned}
$$

where $\Delta \widehat{S}_{t, \xi} \stackrel{\text { def }}{=} \mathrm{S}_{t, \xi}-\widehat{S}_{t, \xi-1}, L^{2} \stackrel{\text { def }}{=} n^{-1} \sum_{i=1}^{n} L_{i}$, and

$$
\mathcal{N}_{t} \stackrel{\text { def }}{=}-\frac{\gamma_{t}}{2\left(1-\rho_{t}\right)}\left(v_{\min }-\gamma_{t} L_{\dot{\mathrm{W}}}-\frac{v_{\max } L^{2} \rho_{t}}{\left(1-\rho_{t}\right) \mathrm{b}} \gamma_{t}^{2}\right) .
$$

Theorem 1 is the key result from which our conclusions are drawn; its proof is adapted from [18, section 8] (also see [28]).

Let us discuss the rate of convergence and the complexity of Geom-SPIDER-SA in the case: for any $t \in\left[k_{\text {out }}\right]^{\star}$, the mean number of inner loops is $\left(1-\rho_{t}\right)^{-1}=k_{\text {in }}, \gamma_{t, 0}=0$ and $\gamma_{t}=\alpha / L$ for $\alpha>0$ satisfying

$$
v_{\min }-\alpha \frac{L_{\dot{\mathrm{W}}}}{L}-\alpha^{2} v_{\max } \frac{k_{\mathrm{in}}}{\mathrm{~b}}\left(1-\frac{1}{k_{\mathrm{in}}}\right)>0 .
$$

Linear rate. When $\Xi \sim \mathcal{G}^{\star}(1-\rho)$, we have

$$
\begin{equation*}
\rho \mathbb{E}\left[D_{\Xi}\right] \leq \rho \mathbb{E}\left[D_{\Xi}\right]+(1-\rho) D_{0}=\mathbb{E}\left[D_{\Xi-1}\right] \tag{7}
\end{equation*}
$$

for any positive sequence $\left\{D_{k}, k \geq 0\right\}$, Theorem 1 implies

$$
\begin{array}{r}
\overline{\mathbb{E}}_{t}\left[\left\|h\left(\widehat{S}_{t, \Xi_{t}}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \leq \frac{2 L}{v_{\min } \alpha\left(k_{\mathrm{in}}-1\right)}\left(\mathrm{W}\left(\widehat{S}_{t, 0}\right)-\min \mathrm{W}\right) \\
+\frac{v_{\max }}{v_{\text {min }}} \frac{k_{\mathrm{in}}}{k_{\mathrm{in}}-1}\left\|\mathcal{E}_{t}\right\|^{2} . \tag{8}
\end{array}
$$

Hence, when $\left\|\mathcal{E}_{t}\right\|=0$ and W satisfies a Polyak-Łojasiewicz condition [29], i.e.

$$
\begin{equation*}
\exists \tau>0, \forall s \in \mathbb{R}^{q}, \quad \mathrm{~W}(s)-\min \mathrm{W} \leq \tau\|\nabla \mathrm{W}(s)\|^{2} \tag{9}
\end{equation*}
$$

then (8) yields
$\mathcal{H}_{t} \stackrel{\text { def }}{=} \overline{\mathbb{E}}_{t}\left[\left\|h\left(\widehat{S}_{t, \Xi_{t}}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \leq \frac{2 L \tau v_{\max }^{2}}{v_{\min } \alpha\left(k_{\text {in }}-1\right)}\left\|h\left(\widehat{S}_{t-1, \xi_{t-1}}\right)\right\|^{2}$,
thus establishing a linear rate of the algorithm along the path $\left\{\widehat{S}_{t, \Xi_{t}}, t \in\left[k_{\text {out }}\right]^{\star}\right\}$ as soon as $k_{\text {in }}$ is large enough:

$$
\mathbb{E}\left[\mathcal{H}_{t}\right] \leq\left(\frac{2 L \tau v_{\max }^{2}}{v_{\min } \alpha\left(k_{\mathrm{in}}-1\right)}\right)^{t}\left\|h\left(\widehat{S}_{\mathrm{init}}\right)\right\|^{2} .
$$

Even if the Polyak-Łojasiewicz condition (9) is quite restrictive, the above discussion gives the intuition of the lock-in phenomenon which often happens at convergence: a linear rate of convergence is observed when the path is trapped in a neighborhood of its limiting point, which may be the consequence that locally, the PolyakŁojasiewicz condition holds (see figure 1 in Section 4).
Complexity for $\epsilon$-approximate stationarity. From Theorem 1, Eq. (7) and $\widehat{S}_{t, \Xi_{t}}=\widehat{S}_{t+1,0}$ (here $\gamma_{t, 0}=0$ ), it holds

$$
\frac{v_{\min } \alpha\left(k_{\mathrm{in}}-1\right)}{2 L} \mathbb{E}\left[\mathcal{H}_{t}\right] \leq \mathbb{E}\left[\mathrm{W}\left(\widehat{S}_{t, 0}\right)-\mathrm{W}\left(\widehat{S}_{t+1,0}\right)\right]
$$

Therefore,

$$
\begin{equation*}
\frac{1}{k_{\text {out }}} \sum_{t=1}^{k_{\text {out }}} \mathbb{E}\left[\mathcal{H}_{t}\right] \leq \frac{2 L\left(\mathrm{~W}\left(\widehat{S}_{\text {init }}\right)-\min \mathrm{W}\right)}{v_{\min } \alpha\left(k_{\mathrm{in}}-1\right) k_{\mathrm{out}}} \tag{10}
\end{equation*}
$$

Eq. (10) establishes that in order to obtain an $\epsilon$-approximate stationary point, it is sufficient to stop the algorithm at the end of the epoch $\# T$, where $T$ is sampled uniformly in $\left[k_{\text {out }}\right]^{\star}$ with $k_{\text {out }}=$ $O\left(\epsilon^{-1} L / k_{\text {in }}\right)$ - and return $\widehat{S}_{T, \xi_{T}}$. To do such, the mean number of conditional expectations evaluations is $\mathcal{K}_{\mathrm{CE}} \stackrel{\text { def }}{=} n+n k_{\text {out }}+$
$2 \mathrm{~b} k_{\text {in }} k_{\text {out }}$; and the mean number of optimization steps is $\mathcal{K}_{\text {Opt }} \stackrel{\text { def }}{=}$ $k_{\text {out }}+k_{\text {in }} k_{\text {out }}$. By choosing $k_{\text {in }}=O(\sqrt{n})$ and $\mathrm{b}=O(\sqrt{n})$, we have $\mathcal{K}_{\mathrm{CE}}=O\left(L \sqrt{n} \epsilon^{-1}\right)$ and $\mathcal{K}_{\mathrm{Opt}}=O\left(L \epsilon^{-1}\right)$. Similar randomized terminating strategies were proposed in the literature: their optimal complexity in terms of conditional expectations evaluations is $O\left(\epsilon^{-2}\right)$ for Online-EM [15], $O\left(\epsilon^{-1} n\right)$ for i-EM [14], $O\left(\epsilon^{-1} n^{2 / 3}\right)$ for sEM-vr [16, 17], $O\left(\left\{\epsilon^{-1} n^{2 / 3}\right\} \wedge\left\{\epsilon^{-3 / 2} \sqrt{n}\right\}\right)$ for FIEM [17, 22] and $O\left(\epsilon^{-1} \sqrt{n}\right)$ for SPIDER-EM - see [18, section 6] for a comparison of the complexities $\mathcal{K}_{\mathrm{CE}}$ and $\mathcal{K}_{\text {opt }}$ of these incremental EM algorithms. Hence, Geom-SPIDER-EM has the same complexity bounds as SPIDER-EM, and they are optimal among the class of incremental EM algorithms.

## 4. NUMERICAL ILLUSTRATION

We perform experiments on the MNIST dataset, which consists of $n=6 \times 10^{4}$ images of handwritten digits, each with 784 pixels. We pre-process the datas as detailed in [22, section 5]: 67 uninformative pixels are removed from each image, and then a principal component analysis is applied to further reduce the dimension; we keep the 20 principal components of each observation. The learning problem consists in fitting a Gaussian mixture model with $g=12$ components: $\theta$ collects the weights of the mixture, the expectations of the components (i.e. $g$ vectors in $\mathbb{R}^{20}$ ) and a full $20 \times 20$ covariance matrix; here, $\mathrm{R}=0$ (no penalty term). All the algorithms start from an initial value $\widehat{S}_{\text {init }}=\bar{s} \circ \mathrm{~T}\left(\theta_{\text {init }}\right)$ such that $-F\left(\theta_{\text {init }}\right)=-58.3$, and their first two epochs are Online-EM. The first epoch with a variance reduction technique is epoch $\# 3$; on Fig. 1, the plot starts at epoch $\# 2$.

The proposed Geom-SPIDER-EM is run with a constant step size $\gamma_{t, k}=0.01$ (and $\gamma_{t, 0}=0$ ); $k_{\text {out }}=148$ epochs (which are preceded with 2 epochs of Online-EM); a mini batch size $\mathrm{b}=\sqrt{n}$. Different strategies are considered for the initialization $\mathrm{S}_{t, 0}$ and the parameter of the geometric r.v. $\Xi_{t}$. In full-geom, $k_{\mathrm{in}}=\sqrt{n} / 2$ so that the mean total number of conditional expectations evaluations per outer loop is $2 \mathrm{~b} k_{\mathrm{in}}=n$; and $\mathcal{E}_{t}=0$ which means that $\mathrm{S}_{t, 0}$ requires the computation of the full sum $\bar{s}$ over $n$ terms. In half-geom, $k_{\text {in }}$ is defined as in full-geom, but for all $t \in$ $\left[k_{\text {out }}\right]^{\star}, \mathrm{S}_{t, 0}=(2 / n) \sum_{i \in \tilde{\mathcal{B}}_{t, 0}} \bar{s}_{i} \circ \mathrm{~T}\left(\widehat{S}_{t,-1}\right)$ where $\mathcal{B}_{t, 0}$ is of cardinality $n / 2$; therefore $\mathcal{E}_{t} \neq 0$. In quad-geom, a quadratic growth is considered both for the mean of the geometric random variables: $\mathbb{E}\left[\xi_{t}\right]=\min \left(n, \max \left(20 t^{2}, n / 50\right)\right) /(2 \mathrm{~b})$; and for the size of the mini batch when computing $\mathrm{S}_{t, 0}: \mathrm{S}_{t, 0}=\tilde{\mathrm{b}}_{t}^{-1} \sum_{i \in \tilde{\mathcal{B}}_{t}} \bar{s}_{i} \circ \mathrm{~T}\left(\widehat{S}_{t,-1}\right)$ with $\tilde{\mathrm{b}}_{t}=\min \left(n, \max \left(20 t^{2}, n / 50\right)\right)$. The $g-$ SP IDER-EM with a constant number of inner loops $\xi_{t}=k_{\text {in }}=n /(2 \mathrm{~b})$ is also run for comparison: different strategies for $S_{t, 0}$ are considered, the same as above (it corresponds to full-ctt, half-ctt and quad-ctt on the plots). Finally, in order to illustrate the benefit of the variance reduction, a pure Online-EM is run for 150 epochs, one epoch corresponding to $\sqrt{n}$ updates of the statistics $\widehat{S}$, each of them requiring a mini batch $\mathcal{B}_{k+1}$ of size $\sqrt{n}$ (see Eq.(6)).

The algorithms are compared through an estimation of the quantile of order 0.5 of $\left\|h\left(\widehat{S}_{t, \Xi_{t}}\right)\right\|^{2}$ over 30 independent realizations. It is plotted versus the number of epochs $t$ in Fig. 1 and the number of conditional expectations (CE) evaluations in Fig. 2. They are also compared through the objective function $F$ along the path; the mean value over 30 independent paths is displayed versus the number of CE, see Fig. 3.

We first observe that Online-EM has a poor convergence rate, thus justifying the interest of variance reduction techniques as shown in Fig. 1. Having a persistent bias along iterations when defining $S_{t, 0}$

i.e. considering $\tilde{\mathrm{b}}_{t} \neq n$ and therefore $\mathcal{E}_{t} \neq 0$, is also a bad strategy as seen in Fig. 1, 2 for half-ctt and half-geom. For the four other SP IDER-EM strategies, we observe a linear convergence rate in Fig. 1, 2. The best strategy, both in terms of CE evaluations and in terms of efficiency given a number of epochs, is quad-ctt: a constant and deterministic number of inner loops $\xi_{t}$ combined with an increasing accuracy when computing $\mathrm{S}_{t, 0}$; therefore, during the first iterations, it is better to reduce the computational cost of the algorithm by considering $\tilde{\mathrm{b}}_{t} \ll n$. When $\mathcal{E}_{t}=0$ (i.e. $\tilde{\mathrm{b}}_{t}=n$ so the computational cost of $\mathrm{S}_{t, 0}$ is maximal), it is possible to reduce the total CE computational cost of the algorithm by considering a random number of inner loops (see full-geom and full-ctt on Fig. 1, 2). Finally, the strategy which consists in increasing both $\tilde{\mathrm{b}}_{t}$ and the number of inner loops, does not look the best one (see quad-ctt and quad-geom on Fig. 1 to Fig. 3).

## 6. PROOF OF THEOREM 1

Let $\left\{\mathcal{E}_{t}, t \in\left[k_{\text {out }}\right]^{\star}\right\}$ and $\left\{\mathcal{B}_{t, k+1}, t \in\left[k_{\text {out }}\right]^{\star}, k \in\left[\xi_{t}-1\right]\right\}$ be random variables defined on the probability space $(\Omega, \mathcal{A}, \mathbb{P})$. Define the filtrations $\mathcal{F}_{1,0} \stackrel{\text { def }}{=} \sigma\left(\mathcal{E}_{1}\right), \mathcal{F}_{t, 0} \stackrel{\text { def }}{=} \sigma\left(\mathcal{F}_{t-1, \xi_{t}}, \mathcal{E}_{t}\right)$ for $t \geq 2$, and $\mathcal{F}_{t, k+1} \stackrel{\text { def }}{=} \sigma\left(\mathcal{F}_{t, k}, \mathcal{B}_{t, k+1}\right)$ for $t \in\left[k_{\text {out }}\right]^{\star}, k \in\left[\xi_{t}-1\right]$.

For $\rho_{t} \in(0,1)$, set

$$
\overline{\mathbb{E}}_{t}\left[\phi\left(\Xi_{t}\right) \mid \mathcal{F}_{t, 0}\right] \stackrel{\text { def }}{=}\left(1-\rho_{t}\right) \sum_{k \geq 1} \rho_{t}^{k-1} \mathbb{E}\left[\phi(k) \mid \mathcal{F}_{t, 0}\right]
$$

for any measurable positive function $\phi$.
A4. $\Theta \subseteq \mathbb{R}^{d}$ is a convex set. $(\mathrm{Z}, \mathcal{Z})$ is a measurable space and $\mu$ is a $\sigma$-finite positive measure on $\mathcal{Z}$. The functions $\mathrm{R}: \Theta \rightarrow \mathbb{R}$, $\phi: \Theta \rightarrow \mathbb{R}^{q}, \psi: \Theta \rightarrow \mathbb{R}, s_{i}: \mathbf{Z} \rightarrow \mathbb{R}^{q}, h_{i}: \mathbf{Z} \rightarrow \mathbb{R}_{+}$for all $i \in[n]^{\star}$ are measurable. For any $\theta \in \Theta$ and $i \in[n]^{\star},\left|\mathcal{L}_{i}(\theta)\right|<\infty$.

A5. The expectations $\bar{s}_{i}(\theta)$ are well defined for all $\theta \in \Theta$ and $i \in$ $[n]^{\star}$. For any $s \in \mathbb{R}^{q}, \operatorname{Argmin}_{\theta \in \Theta}(\psi(\theta)-\langle s, \phi(\theta)\rangle+\mathbf{R}(\theta))$ is a (non empty) singleton denoted by $\{\mathrm{T}(s)\}$.

A6. The functions $\phi, \psi$ and R are continuously differentiable on $\Theta^{v}$, where $\Theta^{v}$ is a neighborhood of $\Theta$. T is continuously differentiable on $\mathbb{R}^{q}$. The function $F$ is continuously differentiable on $\Theta^{v}$ and for any $\theta \in \Theta, \nabla F(\theta)=-\nabla \phi(\theta)^{T} \bar{s}(\theta)+\nabla \psi(\theta)+\nabla \mathrm{R}(\theta)$. For any $s \in \mathbb{R}^{q}, B(s) \stackrel{\text { def }}{=} \nabla(\phi \circ \mathbf{T})(s)$ is a symmetric $q \times q$ matrix and there exist $0<v_{\min } \leq v_{\max }<\infty$ such that for all $s \in \mathbb{R}^{q}$, the spectrum of $B(s)$ is in $\left[v_{\text {min }}, v_{\text {max }}\right]$. For any $i \in[n]^{\star}, \bar{s}_{i} \circ \mathrm{~T}$ is globally Lipschitz on $\mathbb{R}^{q}$ with constant $L_{i}$. The function $s \mapsto \nabla(F \circ \mathrm{~T})(s)=$ $B(s)(\bar{s} \circ T(s)-s)$ is globally Lipschitz on $\mathbb{R}^{q}$ with constant $L_{\dot{\mathrm{W}}}$.

Lemma 2. Let $\rho \in(0,1)$ and $\left\{D_{k}, k \geq 0\right\}$ be real numbers such that $\sum_{k \geq 0} \rho^{k}\left|D_{k}\right|<\infty$. Let $\xi \sim \mathcal{G}^{\star}(1-\rho)$. Then $\mathbb{E}\left[D_{\xi-1}\right]=$ $\rho \mathbb{E}\left[D_{\xi}\right]+(1-\rho) D_{0}=\mathbb{E}\left[D_{\xi}\right]+(1-\rho)\left(D_{0}-\mathbb{E}\left[D_{\xi}\right]\right)$.

This yields $\rho \mathbb{E}\left[D_{\xi}\right]=\mathbb{E}\left[D_{\xi-1}\right]-(1-\rho) D_{0}$ and concludes the proof.

Lemma 3. For any $t \in\left[k_{\text {out }}\right]^{\star}, k \in\left[\xi_{t}\right]^{\star}, \mathcal{B}_{t, k}$ and $\mathcal{F}_{t, k-1}$ are independent. where $L^{2} \stackrel{\text { def }}{=} n^{-1} \sum_{i=1}^{n} L_{i}^{2}$.
Proof. See [18, Lemma 4]; the proof holds true when $\mathcal{B}_{t, k}$ is sampled with or without replacement.

\mathrm{W}\left(s^{\prime}\right)-\mathrm{W}(s) \leq\left\langle\nabla \mathrm{W}(s), s^{\prime}-s\right\rangle+\frac{L_{\dot{\mathrm{W}}}}{2}\left\|s^{\prime}-s\right\|^{2}
$$

With Lemma 8, this yields when $s^{\prime}=s+\gamma S$ for $\gamma>0$ and $S \in \mathbb{R}^{q}$

$$
\begin{aligned}
\mathrm{W}(s+\gamma S)-\mathrm{W}(s) & \leq-\frac{\gamma}{2}\left(v_{\min }-\gamma L_{\dot{\mathrm{W}}}\right)\|S\|^{2}-\frac{\gamma v_{\min }}{2}\|h\|^{2} \\
& +\frac{v_{\max } \gamma}{2}\|h-S\|^{2} .
\end{aligned}
$$

Apply this inequality with $\gamma \leftarrow \gamma_{t+1,0}, s \leftarrow \widehat{S}_{t+1,-1}, S \leftarrow$ $\widehat{S}_{t+1,0}-\widehat{S}_{t+1,-1}$ and $h \leftarrow h(s)$ (which yields $s+\gamma S=$ $\left.\widehat{S}_{t+1,0}\right)$.

Theorem 11. Assume A4 to A6. For any $t \in\left[k_{\text {out }}\right]^{\star}$, let $\rho_{t} \in(0,1)$ and $\Xi_{t} \sim \mathcal{G}^{\star}\left(1-\rho_{t}\right)$. Finally, choose $\gamma_{t, k+1}=\gamma_{t}>0$ for any $k \geq 0$. For any $t \in\left[k_{\text {out }}\right]^{\star}$,

& +\frac{v_{\max }}{2\left(1-\rho_{t}\right)} \frac{L^{2}}{\mathrm{~b}} \gamma_{t} \gamma_{t, 0}^{2}\left\|\mathrm{~S}_{t, 0}-\widehat{S}_{t,-1}\right\|^{2}+\frac{v_{\max }}{2\left(1-\rho_{t}\right)} \gamma_{t, 1}\left\|\mathcal{E}_{t}\right\|^{2} \\
& -\frac{\gamma_{t}}{2\left(1-\rho_{t}\right)}\left(v_{\min }-\gamma_{t} L_{\dot{\mathrm{W}}}-\frac{v_{\max } L^{2} \rho_{t}}{\left(1-\rho_{t}\right) \mathrm{b}} \gamma_{t}^{2}\right) \cdots \\
& \quad \times \overline{\mathbb{E}}_{t}\left[\left\|\mathrm{~S}_{t, \Xi_{t}}-\widehat{S}_{t, \Xi_{t}-1}\right\|^{2} \mid \mathcal{F}_{t, 0}\right] .
\end{aligned}

Proof. Apply Proposition 9 with $k \leftarrow \xi_{t}-1$ and then set $\xi_{t} \leftarrow \Xi_{t}$; this yields

& +\frac{v_{\max }}{2} \overline{\mathbb{E}}_{t}\left[\gamma_{t, \Xi_{t}}\left\|\mathrm{~S}_{t, \Xi_{t}}-\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, \Xi_{t}-1}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& -\overline{\mathbb{E}}_{t}\left[\left.\frac{\gamma_{t, \Xi_{t}}}{2}\left(v_{\min }-\gamma_{t, \Xi_{t}} L_{\dot{\mathrm{W}}}\right)\left\|\mathrm{S}_{t, \Xi_{t}}-\widehat{S}_{t, \Xi_{t}-1}\right\|^{2} \right\rvert\, \mathcal{F}_{t, 0}\right] .
\end{aligned}
$$

Since $\Xi_{t} \geq 1$ and $\gamma_{t, k}=\gamma_{t}$ for any $k \geq 1$, we have

& \overline{\mathbb{E}}_{t}\left[\mathrm{~W}\left(\widehat{S}_{t, \Xi_{t}}\right) \mid \mathcal{F}_{t, 0}\right]+\frac{v_{\min }}{2} \gamma_{t} \overline{\mathbb{E}}_{t}\left[\left\|h\left(\widehat{S}_{t, \Xi_{t}-1}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& \leq \overline{\mathbb{E}}_{t}\left[\mathrm{~W}\left(\widehat{S}_{t, \Xi_{t}-1}\right) \mid \mathcal{F}_{t, 0}\right] \\
& +\frac{v_{\max }}{2} \gamma_{t} \overline{\mathbb{E}}_{t}\left[\left\|\mathrm{~S}_{t, \Xi_{t}}-\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, \Xi_{t}-1}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& -\frac{\gamma_{t}}{2}\left(v_{\min }-\gamma_{t} L_{\dot{\mathrm{W}}}\right) \overline{\mathbb{E}}_{t}\left[\left\|\mathrm{~S}_{t, \Xi_{t}}-\widehat{S}_{t, \Xi_{t}-1}\right\|^{2} \mid \mathcal{F}_{t, 0}\right]
\end{aligned}

By Lemma 2, it holds

\end{aligned}

Furthermore, by Corollary 7 applied with $\gamma_{t, \Xi_{t}}=\gamma_{t, \Xi_{t}+1}=\gamma_{t}$

& \left(1-\rho_{t}\right) \gamma_{t} \overline{\mathbb{E}}_{t}\left[\left\|\mathrm{~S}_{t, \Xi_{t}}-\bar{s} \circ \mathrm{~T}\left(\widehat{S}_{t, \Xi_{t}-1}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& \leq \frac{L^{2} \rho_{t}}{\mathrm{~b}} \gamma_{t}^{3} \overline{\mathbb{E}}_{t}\left[\left\|\mathrm{~S}_{t, \Xi_{t}}-\widehat{S}_{t, \Xi_{t-1}}\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& +\frac{L^{2}\left(1-\rho_{t}\right)}{\mathrm{b}} \gamma_{t} \gamma_{t, 0}^{2}\left\|\mathrm{~S}_{t, 0}-\widehat{S}_{t,-1}\right\|^{2}+\left(1-\rho_{t}\right) \gamma_{t, 1}\left\|\mathcal{E}_{t}\right\|^{2},
\end{aligned}
$$

Therefore,

& \leq\left(1-\rho_{t}\right) \mathrm{W}\left(\widehat{S}_{t, 0}\right)-\left(1-\rho_{t}\right) \overline{\mathbb{E}}_{t}\left[\mathrm{~W}\left(\widehat{S}_{t, \Xi_{t}}\right) \mid \mathcal{F}_{t, 0}\right] \\
& +\frac{v_{\max }}{2} \frac{L^{2} \rho_{t}}{\left(1-\rho_{t}\right) \mathrm{b}} \gamma_{t}^{3} \overline{\mathbb{E}}_{t}\left[\left\|\mathrm{~S}_{t, \Xi_{t}}-\widehat{S}_{t, \Xi_{t-1}}\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& +\frac{v_{\max }}{2} \frac{L^{2}}{\mathrm{~b}} \gamma_{t} \gamma_{t, 0}^{2}\left\|\mathrm{~S}_{t, 0}-\widehat{S}_{t,-1}\right\|^{2}+\frac{v_{\max }}{2} \gamma_{t}\left\|\mathcal{E}_{t}\right\|^{2} \\
& -\frac{\gamma_{t}}{2}\left(v_{\min }-\gamma_{t} L_{\dot{\mathrm{W}}}\right) \overline{\mathbb{E}}_{t}\left[\left\|\mathrm{~S}_{t, \Xi_{t}}-\widehat{S}_{t, \Xi_{t}-1}\right\|^{2} \mid \mathcal{F}_{t, 0}\right] .
\end{aligned}

This concludes the proof.

Corollary 12 (of Theorem 11). For any $t \in\left[k_{\text {out }}\right]^{\star}$,

& -\frac{\gamma_{t+1,0}}{2}\left(v_{\min }-\gamma_{t+1,0} L_{\dot{\mathrm{W}}}\right) \mathbb{E}\left[\left\|\mathrm{S}_{t+1,0}-\widehat{S}_{t+1,-1}\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& +\frac{v_{\max }}{2\left(1-\rho_{t}\right)} \frac{L^{2}}{\mathrm{~b}} \gamma_{t} \gamma_{t, 0}^{2}\left\|\mathrm{~S}_{t, 0}-\widehat{S}_{t,-1}\right\|^{2} \\
& +\frac{v_{\max }}{2\left(1-\rho_{t}\right)} \gamma_{t}\left\|\mathcal{E}_{t}\right\|^{2}+\frac{v_{\max } \gamma_{t+1,0}}{2} \mathbb{E}\left[\left\|\mathcal{E}_{t+1}\right\|^{2} \mid \mathcal{F}_{t, 0}\right] .
\end{aligned}

Proof. Let $t \in\left[k_{\text {out }}\right]^{\star}$. By Proposition 10, since $\widehat{S}_{t, \xi_{t}}=\widehat{S}_{t+1,-1}$ we have

& +\frac{v_{\max } \gamma_{t+1,0}}{2} \mathbb{E}\left[\left\|\mathcal{E}_{t+1}\right\|^{2} \mid \mathcal{F}_{t, 0}\right] \\
& -\frac{\gamma_{t+1,0}}{2}\left(v_{\min }-\gamma_{t+1,0} L_{\mathrm{W}}\right) \mathbb{E}\left[\left\|\mathrm{S}_{t+1,0}-\widehat{S}_{t+1,-1}\right\|^{2} \mid \mathcal{F}_{t, 0}\right] .

The previous inequality remains true when $\mathbb{E}\left[\mathrm{W}\left(\widehat{S}_{t, \xi_{t}}\right) \mid \mathcal{F}_{t, 0}\right]$ is replaced with $\overline{\mathbb{E}}_{t}\left[\mathrm{~W}\left(\widehat{S}_{t, \Xi_{t}}\right) \mid \mathcal{F}_{t, 0}\right]$; and $\mathbb{E}\left[\left\|h\left(\widehat{S}_{t, \xi_{t}}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right]=$ $\overline{\mathbb{E}}_{t}\left[\left\|h\left(\widehat{S}_{t, \Xi_{t}}\right)\right\|^{2} \mid \mathcal{F}_{t, 0}\right]$. The proof follows from Theorem 11, and (see Lemma 2)
