Shift work, and particularly permanent night shifts, promote dyslipidaemia: A systematic review and meta-analysis

Abstract

Background and aims: Shift work is common worldwide and linked to deleterious cardiovascular effects that might be underlined by dyslipidemia. The aim of this systematic review and meta-analysis is to determine the impact of shiftwork on dyslipidemia.

Methods: Searching in PubMed, Cochrane Library, Science Direct and Embase databases without language restriction on 15 February, 2020, included studies that describe blood lipids levels or a risk measure in shift workers compared with fixed-day workers (controls). Differences by study-level characteristics were estimated using stratified meta-analysis by type of shift work, and meta-regression to examine relations between dyslipidemia and demographic, lifestyle and work characteristics. Estimates were pooled using random-effect meta-analysis.

Results: We included a total of 66 articles, representing 197,063 workers. Shift work globally increased the levels of triglycerides (overall SMD = 0.09; 95CI 0.05 to 0.13; p < 0.001), and globally decreased the levels of c-HDL (-0.08; 95CI -0.12 to -0.03; p = 0.001). Permanent night shift workers were an at-risk type of shift for dyslipidemia with significantly higher blood levels of total cholesterol (0.22; 95CI 0.01 to 0.42; p = 0.043) and triglycerides (0.18; 0.03 to 0.33; p = 0.017), and significantly lower blood levels of c-HDL (-0.16; 95CI -0.32 to 0.00; p = 0.05). Permanent night shift workers were more at-risk for total cholesterol than rotating 3*8 shift workers (Coefficient 0.22; 95CI 0.01 to 0.42; p = 0.038) and rotating 2*12 shift workers (0.24; 0.02 to 0.46; p = 0.037), and more at-risk for triglycerides than rotating day shift workers (0.21; 95CI 0.03 to 0.38; p = 0.023). Results were non-significant for c-LDL, nor depending on type of shifts.

Conclusions: Shift work, and particularly permanent night shift, is associated with dyslipidaemia via elevated total cholesterol and triglycerides, and reduced HDL-cholesterol.

Our current study provides a practical and valuable strengthening of the evidence-base required for preventive health initiatives and workplace reform.

Introduction

Shift work that involves night time, is common, accounting for approximately 20% of the work force.[1] Although definitions vary slightly across sources, shift work can be defined as employment in any work schedule that is not a regular daytime schedule.[2] The full spectrum of shift work comprises regular evening or night schedules, rotating shifts, split shifts, on-call or casual shifts, irregular schedules, and other non-day schedules.[2] Unfortunately, shift work is linked to several health problems [3-5], including deleterious effects on the cardiovascular and metabolic systems.[6-13] For instance, shift workers appear to be at increased risk for coronary heart disease, [7,11-13] stroke, [6] insulin resistance, [7,8] and metabolic syndrome.[9,10] Lipid profiles are directly linked to the risk of cardiovascular diseases.[14,15] Specifically, in shift workers, both reduced high-density lipoprotein (HDL)cholesterol and elevated blood LDL and triglycerides may represent an increased risk of cardiovascular diseases.[9] Indeed, it is reasonable to expect that shift work may influence lipid metabolism, particularly deleterious for the health of workers.[16] Some cross-sectional and longitudinal studies have concluded that shift work may increase dyslipidemia.[17–19] However, results are conflicting, with some studies not supporting a link between shiftwork and dyslipidemia.[20-24] Moreover, most of the previous studies did not take into account the confounding factors such key demographic, lifestyle, workplace and shift work characteristics.

Therefore, the primary objective of this study was to conduct a systematic review and metaanalysis to determine the impact of shift work on dyslipidemia. Secondary objectives were to determine if one type of shift work would be particularly deleterious on dyslipidemia, and to examine relations between dyslipidemia and demographic, lifestyle and work characteristics.

Materials and methods

Literature search

A systematic search of all observational epidemiological studies about shift work and lipid metabolism was conducted. The following databases were searched on 15 February, 2020: PubMed, Embase, Cochrane Library, and ScienceDirect. The following relevant mesh terms/keywords were used: "night work" OR "nightwork" OR "shift work" OR "shiftwork" AND "lipids" OR "metabolism" OR "blood" OR "LDL" OR "HDL" OR "cholesterol" OR "triglycerides" (details of search strategy is presented in Supplementary Data 1). The search was not limited to specific years and no language restrictions applied. The studies included in the meta-analysis had to describe blood lipids levels or a risk measure i.e. odds ratio (OR), hazard ratio (HR) or relative risk (RR) in shift workers compared with fixed-day workers (controls). Studies could be cross-sectional, cohort studies or case-study designs. Reference lists of all publications meeting the inclusion criteria, as well as from putative reviews, were manually searched to identify any further studies missed through electronic searching. The search strategy is described in Figure 1. Three authors (Mélanie De Cesare, Alexia Vidal and Valentin Navel) conducted separately all literature searches and collated the abstracts. Four authors (Mélanie De Cesare, Alexia Vidal, Valentin Navel and Frédéric Dutheil) separately reviewed the abstracts and based on the selection criteria decided the suitability of the articles for inclusion. A fourth author (Geraldine Naughton) was asked to review the article where consensus on suitability was not met. Then, all authors reviewed the eligible articles. We followed the PRISMA guidelines (Supplementary Data 2) and we registered our search protocol (PROSPERO identification CRD42020168531).

Data collection

The data collected included first author's name, publication year, country, study design, aims and outcomes of included articles, sample size, mean age, sex, occupation / type of work, type of shift work (permanent night shift, rotating shift work, schedules), length of service, body mass index, smoking, alcohol, physical activity, blood lipid levels and risk measurements for total-, HDL-, LDL-cholesterol, and triglycerides.

Outcomes

The primary outcome was the effects of shift work on blood lipid profiles. Secondary outcomes were the risk of dyslipidaemia according to the type of shift work and the association between blood lipid profiles and covariates.

Quality of assessment

Although not designed to quantifyo the integrity of studies, [25] the "STrengthening the Reporting of OBservational studies in Epidemiology" (STROBE) criteria were used for checking the quality of reporting. [26] The 22 items identified in the STROBE criteria were evaluated for a maximal score of 34 for each study. The methodological quality of the studies was further evaluated by three authors (Frédéric Dutheil, Mélanie De Cesare and Valentin Navel) using the Newcastle-Ottawa Quality Assessment Scale (NOS) model. [27] The following 9 items were assessed in all cohort studies: 4 items on selection bias (representativeness of the exposed and non-exposed cohort, ascertainment of expose), 2 items on comparability bias (design and analysis) and 3 items on outcome bias (assessment of outcome, longer and adequacy of follow-up). Similar items were used to evaluate case control studies. Each item was assigned a judgment of "Yes", "No", "Can't say", or "Not applicable".

Disagreements were addressed by obtaining a consensus with a third author (Bruno Pereira) (Supplementary Data 3 and 4).

Statistical analysis

Statistical analyses were conducted using Comprehensive Meta-analysis software (version 2, Biostat Corporation) and Stata software (version 13, StataCorp, College Station, US).[28–34] Characteristics of the work and workers are summarized for each study sample and reported as mean ± standard-deviation (SD) and number (%) for continuous and categorical variables respectively. For rigor, effect sizes were defined as standard mean differences (SMD) of blood lipid levels or a measure of risk (i.e. odds ratio, hazard ratio, or relative risk). First, we conducted meta-analyses on blood lipids levels (total cholesterol, triglycerides, HDLcholesterol, LDL-cholesterol). Standard difference in means between groups (SMD, difference between means divided by the pooled standard deviation, with a correction for small sample bias) and 95% confidence interval (95%CI) were estimated using DerSimonian and Laird random-effects models (assuming that the true effect estimates varied among studies).[35] A SMD is defined as a unitless measure of the effects of shift work on blood lipids levels centered at zero if the blood lipids levels in shift workers are not different from fixed day workers. A positive SMD denoted higher blood lipid levels in shift workers than in fixed day workers. A scale for SMD has been suggested with 0.8 reflecting a large effect, 0.5 a moderate effect, and 0.2 a small effect. [35] p values less than 0.05 were considered statistically significant. Then, we conducted meta-analyses on risks (i.e. odds ratio, hazard ratio, or relative risk) for dyslipidemia in shift workers compared with fixed-day workers. We stratified these meta-analyses on the type of shift work. Statistical heterogeneity between results was assessed by examining forest plots, confidence intervals, and using I², which is the most common metric for measuring the magnitude of between-study heterogeneity and is

easily interpretable. I² values range between 0% and 100% and are typically considered low for heterogeneity scores of <25%, modest for 25–50%, and high for >50%. For example, a significant heterogeneity may be due to the variability between the characteristics of the studies, such as those of the workers (age, sex, etc), the type of shift work or the occupation. Publication bias was taken into consideration and funnel plots were compiled, with sensitivity analysis excluding studies not evenly distributed around the base of the funnel. We also computed sensitivity analyses depending on the type of risks. When possible (sufficient sample size), meta-regressions were proposed to study the relation between blood lipids levels and characteristics of workers (e.g. age, sex, smoking, alcohol, physical activity) and other working characteristics (e.g. duration of exposure to shift work, type of occupation). Results were expressed as regression coefficients and 95% CI.

Results

An initial search produced 5689 possible articles (Figure 1). We identified 66 eligible articles [7-10,16,17,21-24,36-91] 41 including cross-sectional studies,[7– 10,17,21,23,37,38,40,42,47-50,54,55,58-62,66-69,71,72,75,76,78,80-84,86,87,89-91] 24 prospective or retrospective cohort studies[16,22,24,36,39,43-46,51-53,56,57,63-65,70,73,74,77,79,85,88] and 1 case-control study.[41] Overall, these studies included a total of 80,254 shift workers and 116,809 day workers (Table 1). All articles were written in English, except two in French, [42,70] one in Spanish [52] and one in Italian. [44]

More details on quality of articles (Supplementary Data 3 and 4), population of workers (sample size, gender, age, body mass index, smoking and alcohol status, physical activity), occupational characteristics (type of work, type of shift work and length of service), bloods

lipids (levels and risk of dyslipidemia), study designs, geographic zones, follow-up, aims and outcomes of included articles are described in Table 1 and Supplementary Data 5.

Results

Meta-analysis of total cholesterol for each type of shift works

We included 43 studies.[7,10,16,17,21–24,36,38–43,46,48–50,52,55,60,63–66,68–70,72– 76,78–82,85,86,90,91] The overall SMD was 0.01 (95CI -0.03 to 0.04, p = 0.638) with an important heterogeneity ($l^2 = 73.0\%$) (Figure 2 and Supplementary Data 6). Among the 43 included studies, 4 studies reported permanent night shift,[39,41,69,82] 23 reported rotating 3*8 shift,[16,21–24,36,42,46,48,50,52,55,60,63–66,69,70,73,76,80,85] 10 reported rotating 2*12 shift,[10,24,40,60,72,74,78,86,90,91] 2 reported rotating day shift,[36,55] and 9 were unspecified.[7,17,38,43,49,68,75,79,81] Only permanent night shift workers had increased blood level of total cholesterol (SMD = 0.22; 95CI 0.01 to 0.42; p = 0.043; $l^2 = 60.3\%$) (Supplementary Data 6). Meta-regressions demonstrated that permanent night shift workers had higher blood levels of total cholesterol than rotating 3*8 shift workers (Coefficient 0.22; 95CI 0.01 to 0.42; p = 0.038), rotating 2*12 shift workers (0.24; 0.02 to 0.46; p = 0.037), and unspecified shift workers (0.23; 0.01 to 0.46; p = 0.049). We did not retrieve any significant results on the others socio-demographical parameters and between type of shift works (Figure 3 and 4).

Meta-analysis of triglycerides for each type of shift works

We included 48 studies.[10,17,21–23,36–43,46–60,62,66–71,73–84,86] Shift work globally increased the levels of triglycerides (overall SMD 0.09; 95CI 0.05 to 0.13; $\mathbf{p} < 0.001$) with an important heterogeneity ($I^2 = 80.3\%$) (Figure 2 and Supplementary Data 7). Among the 48 included studies, seven reported permanent night shift,[39,41,58,67,69,71,82] 21 reported

rotating 3*8 shift,[21,23,36,42,46–48,50,52–55,59,60,66,69,70,73,76,77,80] eleven reported rotating 2*12 shift,[10,40,51,56,57,60,74,78,83,86,91] four reported rotating day shift,[36,53– 55] and 12 were unspecified.[17,37,38,43,49,62,67,68,75,79,81,84] We found significantly increased blood levels of triglycerides among permanent night shift workers (0.18; 0.03 to 0.33; p = 0.017; $I^2 = 73.8\%$), rotating 3*8 shift workers (0.09; 0.03 to 0.16; p = 0.004; $I^2 =$ 73.6%), rotating 2*12 shift workers (0.07; 0.01 to 0.13; p = 0.017; $I^2 = 31.6\%$), and nonspecified shift workers (0.11; 0.03 to 0.18; p = 0.004; $I^2 = 80.9\%$) (Supplementary Data 7). Meta-regressions demonstrated that permanent night shift workers had a higher blood levels of triglycerides than rotating day shift workers (Coefficient = 0.21; 95CI 0.03 to 0.38; p =0.023). We did not retrieve any significant results on the other socio-demographical parameters and between types of shift works (Figure 3 and 4).

Meta-analysis of LDL cholesterol for each type of shift works

Among the 31 studies reporting LDL cholesterol, [7,10,17,38,40,43,48,49,51,52,54,55,62,65–70,74,76–82,84–86,91] permanent night shift was reported in 3 studies, [67,69,82] rotating 3*8 shift in 12 studies, [47,52,54,55,65,66,69,70,76,77,80,85] rotating 2*12 shift in 7 studies, [10,40,51,74,78,86,91] rotating day shift in 2 studies, [53,55] and unspecified in 11 studies (Figure 2 and Supplementary Data 8). [7,17,38,43,49,62,67,68,79,81,84] Meta-analysis, globally and stratified by type of shift works, as well as meta-regressions, did not retrieve any significant results (Figure 3 and 4).

Meta-analysis of HDL cholesterol for each type of shift works

We included 46 studies.[10,17,23,24,37,38,40,41,43,45,47–59,62,65–71,73–86,91] The overall SMD was -0.08 (95CI -0.12 to -0.03; p = 0.001) with an important heterogeneity ($I^2 = 85.9\%$) (Figure 2 and Supplementary Data 9). Among the 46 included studies, 6 studies

night shift,[41,58,67,69,71,82] reported rotating 3*8 reported permanent 19 shift,[23,24,47,48,50,52–55,59,65,66,69,70,73,76,77,80,85] 11 reported rotating 2*12 shift, [10,24,40,51,56,57,74,78,83,86,91] 3 reported rotating day shift, [53-55] and 13 were unspecified.[17,37,38,43,45,49,62,67,68,75,79,81,84] We found a significantly lower blood level of c-HDL among permanent night shift workers (SMD = -0.16; 95CI -0.32 to 0.00; p =0.05; $I^2 = 72.3\%$), rotating 3*8 shift workers (-0.10; 95CI -0.17 to -0.02; p = 0.018; $I^2 =$ 78.8%), and non-specified shift workers (-0.08; 95CI -0.15 to -0.01; p = 0.027; $I^2 = 81.7\%$). We also found a significantly higher blood level of c-HDL among rotating day shift workers $(0.18; 95CI \ 0.04 \text{ to } 0.31; p = 0.010; I^2 = 80.4\%)$ (Supplementary Data 9). Meta-regressions demonstrated that permanent night shift workers (Coefficient = -0.32; 95CI -0.57 to -0.07; p =0.014), rotating 3*8 shift workers (-0.26; 95CI -0.47 to -0.04; p = 0.019), and rotating 2*12 shift workers (-0.24; 95CI -0.47 to -0.02; p = 0.034) had lower blood levels of c-HDL than rotating day shift workers. We also showed that rotating day shift workers had higher blood levels of c-HDL than non-specified shift workers (0.24; 95CI 0.03 to 0.47; p = 0.028). We showed a negative role of regular physical activity on blood levels of c-HDL in condition of shift work (-0.01; 95CI -0.01 to 0.00; p = 0.007). We did not retrieve any significant results on the other socio-demographical parameters (Figure 3 and 4).

Meta-analyses of odds ratio for each type of lipid related risk

We included 3 studies reporting Odds Ratio (OR) for high total cholesterol (Supplementary Data 10),[17,38,89] 7 studies reporting OR for high triglyceride (Supplementary Data 11),[8,9,17,38,61,87,88] 2 studies reporting OR for high c-LDL (Supplementary Data 12),[17,89] and 6 studies reporting OR for low c-HDL (Supplementary Data 13).[8,9,17,38,44,87] Shift work exposure increased the risk of high triglyceride levels by

12% (ES = 1.12; 95CI 1.01 to 1.23; p < 0.001; I²=55.2%) without significance for total cholesterol, c-LDL, and c-HDL. Insufficient data did not permit meta-regression.

Discussion

This current meta-analysis presents a broad comprehensive review of the associations between shift work and dyslipidaemia in 197,063 workers. The main finding was that shift work induced dyslipidaemia with elevated triglycerides, elevated total, and decreased HDLcholesterol. More specifically, permanent night shifts were the most deleterious type of shift work on dyslipidemia; with elevated triglycerides, elevated total cholesterol, and decreased HDL-cholesterol. Results from meta-regressions confirmed the more negative impact of permanent night shifts than other types of shift work.

Shift work and dyslipidemia

Some potential biological mechanisms may explain the link between shift work and dyslipidemia. First, long-term exposure to shift work might disturb the normal circadian rhythm and generate an imbalance in lipid metabolism.[92] Melatonin is an important mediator of circadian rhythms. Production of melatonin is supported by darkness but inhibited by light at night, so night work can inhibit the secretion of melatonin. Animal studies showed that decreased secretion of melatonin was associated with dyslipidemia, such as an elevated blood level of triglyceride.[93] Alternatively, workers may consume meals at unusual times; the desynchronization of food intake and internal metabolic rhythm may also affect the energy balance and weight regulation.[94] It has been shown that nocturnal food intake (in particular those rich in carbohydrate) might aggravate metabolic disturbances of triglyceride and lipid levels.[51,95] Another potential mechanism may lie in the capacity of shift work to decrease sleep duration and quality, which may have an adverse impact on psychological and physical

heath.[96] Short sleep duration is associated with an increased risk of obesity,[97] type 2 diabetes,[98] cardiovascular outcomes[99] and all-cause mortality,[100] with a dose response relationship between short sleep duration (less than six hours) and mortality.[101] Restricting sleep duration over just one week resulted in significant reduction in insulin sensitivity in middle aged and older men.[102] Prolonged exposure to disturbed sleep may therefore have profound consequences on the metabolic health of shift workers. Interestingly, we showed that shift work is mainly deleterious on triglycerides and c-HDL, but not c-LDL. The literature already reported that night shifts may have a slight protective effect on c-LDL.[103] Even if it has been hypothesized a possible selection bias of healthy workers who might undergo night shift,[103] we want to acknowledge the important gap in the literature surrounding the physiology of the absence of influence of shift work on c-LDL.

The deleterious effect of permanent night shift

We demonstrated that permanent night shifts might be the worst schedule for workers in terms of dyslipidemia. The shift work is commonly regarded as the work outside regular day time, with working time during normally sleeping periods.[104] Putative explanations might be that, most often, permanent night shift workers keep a desynchronized circadian rhythm, with awakening during normal sleeping periods.[105] This desynchronized circadian rhythm might affect sleep quality involving chronical disrupted sleep.[106,107] Indeed, day sleeps have typically been found to be considerably shorter than normal night sleeps, because of multiple reasons including increased environmental noise, light levels, and conflicting social, domestic and family demands.[108] The circadian system is impacted by sleep disturbance, and contribute to the regulation of metabolism and energy expenditure.[104] Desynchronization between the central (brain) and peripheral (outside of brain, such as digestive system and adipose tissue) clocks by altered food intake and diet composition can

lead to the development of metabolic syndrome and obesity.[109,110] Many studies describe peripheral appetite regulation with circadian secretion of ghrelin, an orexigenic hormone secreted by stomachal tissue, and leptin, an anorexigenic hormone secreted by adipose tissue.[111,112] Permanent night shift workers present a disrupted control of ghrelin and leptin, associated with behavioral changes in diet, sleep and increased adiposity and related metabolic alterations.[109,110] It has been showed that ghrelin secretion was related to pituitary gland and pulsatile neuroendocrine secretion from the hypothalamus to modify sleep-wake pattern by increasing wakefulness and to decrease the duration of deep sleeping periods.[113,114] Thus, all these changes in the circadian clock are associated with temporal alteration in feeding behavior and increased weight gain, explaining the high proportion of obesity in night shift workers.[115] It seems also salient to note that night shift work is positively associated with abnormal eating patterns and BMI.[116,117] Then, dyslipidemia could be an epiphenomenon of snacking. Moreover, animal studies suggest that circadian disruption alters hepatic clock gene expression, bile acid metabolism and lipid homeostasis to contribute to dyslipidemia.[118]

Socio-demographic characteristics of workers

Despite we found no link between dyslipidemia and occupational settings, age, sex, marital status, smoking or drinking, physical activity, or obesity, the literature is abundant. We stratified our results by types of shift work to identify at-risk shifting for dyslipidemia without focusing on type of occupation, because of heterogeneity between included studies. However, occupational setting, particularly the manual work, is known to be a socioeconomic factor increasing dyslipidemia, hypertension, obesity and diabetes.[119–121] In our study, the proportion of women and elderly workers exposed to shift work remained low, with most studies including only men between 30 and 45 years, precluding further analyses.

Nevertheless, older individuals and men are at-risk populations for dyslipidemia, particularly in post-industrialised countries.[122,123] Despite an important social determinant of health,[124] marital status, seems to not influence the risk of dyslipidemia with contradictory and inconclusive results.[125,126] In our meta-analysis, smoking and alcohol intake were not linked to dyslipidaemia. However, smoking promotes dyslipidaemia by worsening the control of lipid metabolism.[127,128] Similarly, the link between misuse of alcohol and dyslipidemia is well established, with yet contradictory results for regular low doses.[129–131] Contrary to our results, physical activity might be protective on HDL levels. During the past decades, there was cumulative evidence concerning the impact of regular physical activity on plasma lipoprotein metabolism and, finally, reducing the incidence of cardiovascular diseases.[132]

Limitations

Several limitations in our review should be mentioned. Our meta-analysis inherited the limitations of the 66 individual studies of which it was composed and therefore is subjected to the bias of included studies. Even if a recent meta-analysis demonstrated associations between short sleep duration and cardiometabolic risk,[101] this is the first meta-analysis to systematically quantify the strength of associations between shift work and dyslipidemia. Despite our stratification by type of shift work (permanent night shift, 3*8, 2*12, rotating day shift), there is heterogeneity within each subgroup regarding schedule and rhythm of night shift. Moreover, although the shift work is relatively objective and specific, it was not clearly defined in some published studies, which might have affected the precision of the results. There is also heterogeneity in reporting blood lipid levels between studies, and different cut-off for dyslipidemia for studies reporting odds ratio or hazard ratio. Moreover, odds ratio and hazard ratio were adjusted on different variables between studies, precluding robust conclusions. Most studies have a cross-sectional design. Therefore, the associations between

shift work and dyslipidemia risk might be underestimated by the potential healthy worker survival effect in the cross-sectional studies.[133] Even if methodological quality of the included studies was evaluated by subjective assessments (STROBE and NOS), overall methodological quality was reasonably good without major comparability bias between exposed and non-exposed groups, with a large volume of data available and consistency for the main outcomes of interest. We also want to acknowledge that we were not able to increase the number of studies with c-LDL using the formula of Friedewald (LDL = total cholesterol - (triglycerides/5 + HDL)),[134] as we did not have access to raw data. Finally, few studies reported duration of exposure to shift work, precluding the analysis of a possible dose-response relation. Generalizability of our results may also suffer from the limited number of studies from Africa and South America. For the future, it would be interesting to investigate more prospective and interventional studies to explore the underlying mechanisms and putative preventive strategy.

Conclusions

Shift work, and particularly permanent night shift, is associated with dyslipidaemia via elevated triglycerides, elevated total cholesterol, and reduced HDL-cholesterol. Given the increasing prevalence of shift work worldwide and the heavy economic burden of cardiovascular diseases that may be promoted by dyslipidemia in shift workers, our current study provides a practical and valuable strengthening of the evidence-base required for preventive health initiatives and workplace reform. When shift work is unavoidable, permanent night shifts should be removed from schedules and at least replaced by rotating shifts, preferentially in two schedules; one during the day and one at night. Further studies should investigate economic benefits of removing permanent night shifts, both in terms of healthcare and for factories.
