A Fixed-Parameter Algorithm for Scheduling Unit Dependent Tasks on Parallel Machines with Time Windows

Abstract

This paper proves that the existence of a feasible schedule for a set of dependent tasks of unit execution times with release dates and deadlines on a limited number of processors is a fixed-parameter tractable problem. The parameter considered is the pathwidth of the interval graph associated with the time windows of the tasks. A fixed-parameter algorithm based on a dynamic programming approach is developed and proved to solve this decision problem.

Fixed-parameter algorithms for the two classical problems $P|prec, p_i = 1, r_i|C_{\text{max}}$ and $P|prec, p_i = 1, r_i|L_{\text{max}}$ are then derived using a binary search. They are, as far as we know, the first fixed-parameter algorithms for these scheduling problems.

Keywords: parallel identical machines, makespan, maximum lateness, parameterized complexity

1. Introduction

- This paper tackles a basic scheduling problem defined as follows: we con-
- sider a set T of n tasks of unit duration. Precedence relations are expressed
- by an (acyclic) precedence graph noted G = (T, A). If s_i^{σ} denotes the starting
- 5 time of a task $i \in T$ according to a feasible schedule σ , each arc $e = (i, j) \in A$
- expresses the precedence constraint $s_i^{\sigma} + 1 \leq s_i^{\sigma}$. Moreover, each task must
- be executed during its time window, i.e. for each task $i \in T$, $r_i \leq s_i^{\sigma} < d_i$
- where r_i is the release time of i and d_i its deadline. We assume without loss
- of generality that $\min_{i \in T} r_i = 0$. Lastly, m identical machines are available,

so that at most m tasks can be scheduled at each time instant. The question is the existence of a feasible schedule. This problem is referred to as $P|prec, p_i = 1, r_i, d_i|_{\star}$ using standard notations [11].

Let $C(\sigma) = \max_{i \in T} (s_i^{\sigma} + 1)$ be the makespan of a schedule σ and $L(\sigma) =$ $\max_{i \in T} (\max(0, s_i^{\sigma} + 1 - d_i))$ its maximum lateness. Let us consider the optimization problem $P|prec, p_i = 1, r_i|C_{\text{max}}$. For each upper bound $C \geq 0$ of the makespan, the deadline of each task $i \in T$ can be set to $d_i = C - \ell_i$ where ℓ_i is the maximum number of arcs of a path starting from i. We observe that any solution of the corresponding instance of $P|prec, p_i = 1, r_i, d_i|\star$ is a feasible solution of $P|prec, p_i = 1, r_i|C_{\text{max}}$. We conclude that any algorithm solving the decision problem $P|prec, p_i = 1, r_i, d_i|\star$ can be combined with binary search to solve $P|prec, p_i = 1, r_i|C_{\text{max}}$. A similar remark can be made for the optimisation problem $P|prec, p_i = 1, r_i|L_{\text{max}}$. Indeed, for each instance of this problem and each upper bound $\lambda \geq 0$ of the maximum lateness, we can set the deadline of each task $i \in T$ to $d'_i = d_i + \lambda$ and solve the associated decision problem $P|prec, p_i = 1, r_i, d_i|\star$. So, each algorithm solving the decision problem $P|prec, p_i = 1, r_i, d_i|\star$ can thus be extended for $P|prec, p_i = 1, r_i|C_{\text{max}}$ or $P|prec, p_i = 1, r_i|L_{\text{max}}$ by adding a binary search on the upper bound of respectively the makespan or the maximum lateness.

The optimisation problem $P|prec, p_i = 1|C_{\text{max}}$ has been widely studied. It was proved to be NP-hard initially for opposing forests by Garey et al. [10]. The recent survey of Prot and Bellenguez-Morineau [15] presents several complexity results depending on the structure of the precedence graph and the number of processors.

The development of fixed-parameter algorithms for NP-complete problems is a way to get polynomial-time algorithms when some parameters are fixed [6, 8]. More formally, a fixed-parameter algorithm solves any instance of the problem of size n in time $f(k) \times \text{poly}(n)$, where f is allowed to be a computable superpolynomial function and k the associated parameter.

Several authors developed exact algorithms for $P|prec, p_i = 1|C_{\text{max}}$. Dolev and Warmuth [7] developed a dynamic programming algorithm of time complexity $\mathcal{O}(n^{h(G)(m-1)+1})$ to solve this problem. The parameter h(G) represents the number of nodes of the longest path of the precedence graph G. Few years later, Möhring [14] developed another dynamic programming algorithm of time complexity $\mathcal{O}(n^{w(G)})$. The parameter w(G) is the width of the precedence graph G defined as the size of its largest antichain. None of these algorithms are fixed-parameter ones.

Mnich and van Bevern [13] surveyed main results on parameterized com-

plexity for scheduling problems and identified 15 open problems. They point out that the fixed-parameter tractability of $P3|prec, p_i = 1|C_{\text{max}}$ parameterized by the width w(G) of the precedence graph G is an open challenging question. The width w(G) leads to several negative results. Du et al. [9] proved that $P2|chains|C_{\text{max}}$ is strongly NP-hard for unbounded width. Günther et al. [12] proved that $P2|chains, w(G) \leq 3|C_{\text{max}}$ is weakly NP-hard. Bodlaender and Fellows [4] proved that $P|prec, p_i = 1|C_{\text{max}}$ is W[2]-hard parameterized by the width and the number of machines. More recently, van Bevern et al. [2] proved that $P2|prec, p_j \in \{1, 2\}|C_{\text{max}}$ is W[2]-hard parameterized by the width w(G), and that this result is an argument to look at the parameterized complexity of $P3|prec, p_i = 1|C_{\text{max}}$ using w(G) as parameter. The existence of a fixed-parameter algorithm for the optimisation problem $P|prec, p_i = 1|C_{\text{max}}$ is a challenging question, but as we described above, most of the authors focused their study on the width w(G) as a parameter.

The parameter considered in this paper is the pathwidth $pw(\mathcal{I})$ of an instance \mathcal{I} of the decision problem $P|prec, p_i = 1, r_i, d_i|_{\star}$. Let us consider the strictly increasing sequences u_{α} , $\alpha \in \mathbb{N}$ corresponding to all the time instants of the beginnings and endings of the intervals $[r_i, d_i]$, $i \in \mathcal{T}$. By definition of release dates, $u_0 = 0$. Moreover, the last element $u_{k^{\star}}$ of the sequence satisfies $k^{\star} \leq 2n - 1$. Then, for any $\alpha \in \{1, \ldots, k^{\star}\}$, we set $X_{\alpha} = \{i \in \mathcal{T}, (u_{\alpha-1}, u_{\alpha}) \cap (r_i, d_i) \neq \emptyset\}$. The pathwidth is defined as $pw(\mathcal{I}) = \max_{\alpha \in \{1, \ldots, k^{\star}\}} (|X_{\alpha}| - 1)$.

The pathwidth $pw(\mathcal{I})$ is a simple measure of the parallelism of the instance \mathcal{I} . One can observe that $pw(\mathcal{I})$ is the pathwidth of the interval graph associated with the set of intervals $\{(r_i, d_i), i \in T\}$ [3]. As far as we know, this measure was not yet considered as a parameter for a scheduling problem.

We prove in this paper that the decision problem $P|prec, p_i = 1, r_i, d_i|\star$ can be solved in time $\mathcal{O}(n^2 2^{4 \times pw(\mathcal{I})})$ using a dynamic programming approach based on a multistage auxiliary graph which longest paths model all the feasible schedules. By coupling our algorithm with a binary search based on a lower bound of the respective objectives, we get that the two optimisation problems $P|prec, p_i = 1, r_i|C_{\text{max}}$ and $P|prec, p_i = 1, r_i|L_{\text{max}}$ are fixed-parameter tractable parameterized by the pathwidth.

Baptiste and Timkovsky [1] developed a similar approach to get a polynomial time algorithm of time complexity $\mathcal{O}(n^9)$ for $P2|prec, p_i = 1, r_i| \sum C_j$. They also conjectured the existence of ideal schedules, i.e. that minimize both the makespan and the total completion time for the previous instance. More recently, Coffman et al. [5] proved that each optimal solution of $P2|prec, p_i = 1, r_i| \sum C_j$ minimizes the makespan of the same instance and they improved

the algorithm of Baptiste and Timkowsky to get a complexity in time $\mathcal{O}(n^3)$.

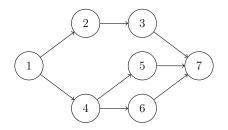
This paper is organised as follows: Section 2 presents additional notations and an example. Section 3 is devoted to the description of properties of feasible schedules. These properties will be considered in Section 4 to build the multistage auxiliary graph \mathcal{G} whose longest paths represent all the feasible solutions (if any). Section 5 details the complexity of the construction of \mathcal{G} . Section 6 is our conclusion.

2. Additional notations and example

For any task $i \in T$, the set of immediate successors and predecessors of i is respectively denoted by $\Gamma^+(i)$ and $\Gamma^-(i)$. For any couple of tasks $(i,j) \in T^2$, we denote by $i \to j$ if there is a path in G from i to j. The descendants of a task $i \in T$, denoted by $\Gamma^{+*}(i)$ is the set of tasks $j \neq i$ such that $i \to j$. Similarly, $\Gamma^{-*}(i)$ denotes the set of ancestors of i, i.e. the set of tasks $j \neq i$ such that $j \to i$.

We assume without loss of generality that release dates and deadlines are consistent with respect to precedence constraints, i.e. if $(i, j) \in A$ then $r_i + 1 \le r_j$ and $d_i + 1 \le d_j$. For any task $i \in T$, f(i) is the smallest value $\alpha \in \{1, \ldots, k^*\}$ such that $i \in X_{\alpha}$.

Figure 1 presents an instance \mathcal{I} of our scheduling problem for two machines. We get $k^* = 5$ and $u_{\alpha} = \alpha$ for $\alpha \in \{0, ..., 5\}$. The corresponding sets are $X_1 = \{1\}$, $X_2 = \{1, 2, 4\}$, $X_3 = \{2, 3, 4, 5, 6\}$, $X_4 = \{3, 5, 6, 7\}$ and $X_5 = \{7\}$. The pathwidth is $pw(\mathcal{I}) = |X_3| - 1 = 4$. We also have f(1) = 1, f(2) = f(4) = 2, f(3) = f(5) = f(6) = 3 and f(7) = 4.

3. Basic properties of feasible solutions

Let us suppose that σ is a feasible solution of our scheduling problem. For any value $\alpha \in \{1, \dots, k^*\}$, we define the slice $S_{\alpha} = \{i \in T, u_{\alpha-1} \leq s_i^{\sigma} < u_{\alpha}\}$.

Consider the feasible schedule σ for our example given in Figure 2. We get the slices $S_1 = \{1\}$, $S_2 = \{2, 4\}$, $S_3 = \{3, 5\}$, $S_4 = \{6\}$ and $S_5 = \{7\}$.



Figure 2: A feasible schedule σ associated with the example given in Figure 1.

Definition 1. A set of tasks $V \subseteq T$ is said to be consistent if for any couple $(i,j) \in V^2$ with $i \neq j$ such that $i \to j$, any task k of a path in G from i to j belongs to V.

Definition 2. A set $V \subseteq T$ is said to be strictly consistent if for any $x \in V$, $\Gamma^{+}(x) \subseteq V.$

We observe that any strictly consistent set V is consistent, but the reverse is not true. The consequence is that Definition 2 is more restrictive than Definition 1.

Lemma 1. For any value $\alpha \in \{1, \dots, k^*\}$, S_{α} is consistent.

Proof. Suppose, for the sake of contradiction, that S_{α} is not consistent. Then, there exist a couple $(i,j) \in S_{\alpha}^2$ and a task $k \in S_{\beta}$ with $\beta \neq \alpha$ and $i \to k \to j$.

If $\beta > \alpha$, then the precedence $k \to j$ cannot be fulfilled since $s_k^{\sigma} \geq u_{\alpha} > s_j^{\sigma}$. Similarly, if $\beta < \alpha$, the precedence $i \to k$ cannot be fulfilled as $s_k^{\sigma} < u_{\alpha-1} \leq s_i^{\sigma}$, thus the lemma is proved.

Lemma 2. For any value $\alpha \in \{1, ..., k^{\star}\}, \cup_{\beta=\alpha}^{k^{\star}} S_{\beta}$ is strictly consistent.

Proof. Suppose, for the sake of contradiction, that there exists $\alpha \in \{1, \ldots, k^*\}$ such that $\bigcup_{\beta=\alpha}^{k^*} S_{\beta}$ is not strictly consistent. Let then $i \in \bigcup_{\beta=\alpha}^{k^*} S_{\beta}$ with $\Gamma^+(i) \not\subseteq \bigcup_{\beta=\alpha}^{k^*} S_{\beta}$ and $j \in \Gamma^+(i) - \bigcup_{\beta=\alpha}^{k^*} S_{\beta}$. Thus, $j \in S_{\beta}$ with $\beta < \alpha$, and then $s_j^{\sigma} < u_{\alpha-1} \leq s_i^{\sigma}$. The precedence $i \to j$ is not fulfilled by σ , a contradiction.

Lemma 3. For any $\alpha \in \{1, ..., k^*\}$, let $Z_{\alpha} = \{i \in T, f(i) \geq \alpha\}$. If σ is a feasible schedule, then any subset $V_{\alpha} = \bigcup_{\beta=\alpha}^{k^*} S_{\beta}$ can be partitioned such as $V_{\alpha} = Z_{\alpha} \cup p(V)$ with $p(V) \subseteq X_{\alpha}$.

Proof. Any element $i \in Z_{\alpha}$ satisfies $f(i) \geq \alpha$ and thus $r_i \geq u_{\alpha-1}$. Since σ is feasible, $s_i^{\sigma} \geq r_i$, and thus $i \in V_{\alpha}$. We conclude that $Z_{\alpha} \subseteq V_{\alpha}$.

Now, let $i \in p(V_{\alpha}) = V_{\alpha} - Z_{\alpha}$, then $f(i) < \alpha$, thus $r_i < u_{\alpha-1}$. Then, there exists $\beta < \alpha$ with $i \in X_{\beta}$. Since $i \in V_{\alpha}$, there exists $\beta' \in \{\alpha, \dots, k^{\star}\}$ with $i \in S_{\beta'}$, and then $s_i^{\sigma} \leq u_{\beta'} \leq d_i$. Since $\beta' \geq \alpha$, $u_{\beta'} \geq u_{\alpha}$. As $r_i < u_{\alpha-1}$ and $d_i \geq u_{\alpha}$, $(r_i, d_i) \cap (u_{\alpha-1}, u_{\alpha}) \neq \emptyset$ and thus $i \in X_{\alpha}$, which concludes the proof.

For the example given by Figure 1, we get $Z_5 = \emptyset$, $Z_4 = \{7\}$, $Z_3 = \{3,5,6,7\}$, $Z_2 = \{2,3,4,5,6,7\}$ and $Z_1 = T$. For the schedule σ from Figure 2, $V_1 = T = Z_1$, $V_2 = \{2,3,4,5,6,7\} = Z_2$, $V_3 = \{3,5,6,7\} = Z_3$ $V_4 = \{6,7\} = \{6\} \cup Z_4$ and $V_5 = \{7\} = \{7\} \cup Z_5$. We deduce that $p(V_1) = p(V_2) = p(V_3) = \emptyset$, $p(V_4) = \{6\}$ and $p(V_5) = \{7\}$.

4. Representation of feasible solutions and description of the algorithm

Let \mathcal{I} be an instance of $P|prec, p_i = 1, r_i, d_i|_{\star}$. The idea of the algorithm is to build a multistage auxiliary graph $\mathcal{G} = (\mathcal{T}, \mathcal{A})$ whose longest paths describe all the feasible solutions (if any) of \mathcal{I} .

Elements of \mathcal{T} are associated with subsets of T. The set \mathcal{T} is partitioned into k^* sets $\mathcal{T}_1, \ldots, \mathcal{T}_{k^*}$ such that, for any value $\alpha \in \{1, \ldots, k^*\}$, elements of \mathcal{T}_{α} are strictly consistent subsets of $X_{\alpha} - Z_{\alpha}$. Then, every element $v \in \mathcal{T}_{\alpha}$ verifies $v \cup Z_{\alpha} \subseteq X_{\alpha} \cup Z_{\alpha} \subseteq \bigcup_{\beta=\alpha}^{k^*} X_{\beta}$. Moreover, $p(v \cup Z_{\alpha}) = v$.

Now, let us suppose that v and v' are two vertices respectively of \mathcal{T}_{α} and $\mathcal{T}_{\alpha+1}$ for $\alpha \in \{1, \dots, k^{\star} - 1\}$. Then, there is an arc (v, v') in \mathcal{A} if:

- 1. $v' \cup Z_{\alpha+1} \subseteq v \cup Z_{\alpha}$ and $S = v \cup Z_{\alpha} (v' \cup Z_{\alpha+1})$ is in X_{α} and is consistent;
- 2. There exists a schedule of tasks from S on m machines of makespan $C_{\alpha} = u_{\alpha} u_{\alpha-1}$ meeting the precedence constraints induced by the subgraph G' = (S, A) of G.

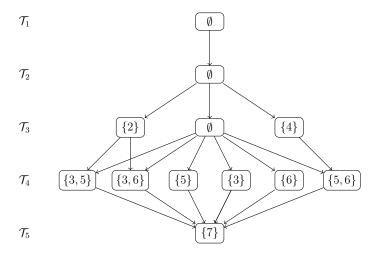


Figure 3: The multistage auxiliary graph $\mathcal{G} = (\mathcal{T}, \mathcal{A})$ associated with the example given in Figure 1. Vertices without successor are removed.

Figure 3 presents the multistage auxiliary graph $\mathcal{G} = (\mathcal{T}, \mathcal{A})$ associated with the instance given in Figure 1.

We prove in Lemma 4 that any feasible schedule σ is associated with a path of the multistage auxiliary graph \mathcal{G} from a vertex of \mathcal{T}_1 to a vertex

of $\mathcal{T}_{k^{\star}}$. Indeed, let $S_1, \ldots, S_{k^{\star}}$ be the slices of σ and the corresponding sequence $V_{\alpha} = \bigcup_{\beta=\alpha}^{k^{\star}} S_{\beta}$, for each $\alpha \in \{1, \ldots, k^{\star}\}$. Then, σ is associated with the path $p(V_1), p(V_2), \ldots, p(V_{k^{\star}})$ of \mathcal{G} .

Let us consider for example the schedule σ given in Figure 2. Recall that $p(V_1) = p(V_2) = p(V_3) = \emptyset$, $p(V_4) = \{6\}$ and $p(V_5) = \{7\}$. The schedule σ is thus associated with the path $\emptyset \to \emptyset \to \emptyset \to \{6\} \to \{7\}$.

Lemma 4. Each feasible solution σ of the instance \mathcal{I} is associated with a path of the multistage auxiliary graph \mathcal{G} from a vertex of \mathcal{T}_1 to a vertex of \mathcal{T}_{k^*} .

Proof. Let S_1, \ldots, S_{k^*} be the slices of σ and $V_{\alpha} = \bigcup_{\beta=\alpha}^{k^*} S_{\beta}$ for each $\alpha \in \{1, \ldots, k^*\}$. For any value $\alpha \in \{1, \ldots, k^*\}$, $V_{\alpha} \subseteq \bigcup_{\beta=\alpha}^{k^*} X_{\beta}$. V_{α} is strictly consistent by Lemma 2 and $Z_{\alpha} \subseteq V_{\alpha}$ by Lemma 3. Thus, $p(V_{\alpha}) \in \mathcal{T}_{\alpha}$.

Now, for any value $\alpha \in \{1, \ldots, k^* - 1\}$, $V_{\alpha+1} \subseteq V_{\alpha}$, and the set $S_{\alpha} = V_{\alpha} - V_{\alpha+1} \subseteq X_{\alpha}$ is consistent by Lemma 1. Lastly, as σ is a feasible solution, S_{α} can be scheduled according to the resource constraints and the precedence expressed by the sub-graph (S_{α}, A) . Thus the arc $(p(V_{\alpha}), p(V_{\alpha+1})) \in \mathcal{A}$, which concludes the proof.

Let us consider now a path $p(V_1), \ldots, p(V_{k^*})$ of \mathcal{G} . We prove in Lemma 5 that the sequence of slices $S_{k^*} = p(V_{k^*}) \cup Z_{k^*}$ and for each $\alpha \in \{1, \ldots, k^* - 1\}$, $S_{\alpha} = p(V_{\alpha}) \cup Z_{\alpha} - (p(V_{\alpha+1}) \cup Z_{\alpha+1})$ defines a feasible schedule.

Let us consider for example the path of the graph \mathcal{G} given by Figure 3 from $p(V_1)$ from $p(V_5)$ such that $p(V_1) = p(V_2) = \emptyset$, $p(V_3) = \{2\}$, $p(V_4) = \{3,6\}$ and $p(V_5) = \{7\}$. Corresponding slices are $S_5 = \{7\}$, $S_4 = \{3,6,7\} - \{7\} = \{3,6\}$, $S_3 = \{2,3,5,6,7\} - \{3,6,7\} = \{2,5\}$, $S_2 = \{2,3,4,5,6,7\} - \{2,3,5,6,7\} = \{4\}$, and $S_1 = T - \{2,3,4,5,6,7\} = \{1\}$. We get the schedule σ defined as $s_1^{\sigma} = 0$, $s_4^{\sigma} = 1$, $s_2^{\sigma} = s_5^{\sigma} = 2$, $s_3^{\sigma} = s_6^{\sigma} = 3$ and $s_7^{\sigma} = 4$.

Lemma 5. Each path of the multistage auxiliary graph G from a vertex of \mathcal{T}_1 to a vertex of \mathcal{T}_{k^*} is associated with a feasible solution.

Proof. Let $p(V_1), \ldots, p(V_{k^*})$ be a path of \mathcal{G} with $p(V_{\alpha}) \in \mathcal{T}_{\alpha}$. Let us define the sequences $V_{\alpha} = p(V_{\alpha}) \cup Z_{\alpha}$ for $\alpha \in \{1, \ldots, k^*\}$, $S_{k^*} = V_{k^*}$ and for each $\alpha \in \{1, \ldots, k^* - 1\}$, $S_{\alpha} = V_{\alpha} - V_{\alpha+1}$.

By definition of \mathcal{G} , each set S_{α} is consistent and can be scheduled following resource and precedence constraints of the sub-graph (S_{α}, A) within a makespan $C_{\alpha} = u_{\alpha} - u_{\alpha-1}$. We prove that the schedule obtained by merging the schedules of the successive slices S_1, \ldots, S_{k^*} is feasible.

By definition, $Z_1 \subseteq V_1$ and $Z_1 = \{i \in T, f(i) \geq 1\} = T$, thus $V_1 = T$. Moreover, for each arc $(p(V_{\alpha}), p(V_{\alpha+1}))$ of \mathcal{G} with $\alpha \in \{1, \ldots, k^* - 1\}$, $p(V_{\alpha+1}) \cup Z_{\alpha+1} \subseteq p(V_{\alpha}) \cup Z_{\alpha}$, thus $V_{\alpha+1} \subseteq V_{\alpha}$ and then $V_{k^*} \subseteq V_{k^*-1} \subseteq \ldots \subseteq V_1$. Then, each task $i \in T$ belongs to exactly one slice S_{α} and S_1, \ldots, S_{k^*} is a partition of T.

By definition, $S_{\alpha} \subseteq X_{\alpha}$, thus for any task of S_{α} , release dates and deadlines are fulfilled. Resource constraints are fulfilled by definition of each set S_{α} , for each $\alpha \in \{1, \ldots, k^{\star}\}$.

Lastly let us consider two tasks $(i,j) \in T^2$ with $(i,j) \in A$. Let suppose that $i \in S_{\alpha}$ and $j \in S_{\beta}$. If $\alpha = \beta$, the constraint is fulfilled since there exists a feasible schedule of S_{α} for the sub-graph (S_{α}, A) . If $\alpha < \beta$, the set S_{α} is scheduled before S_{β} , the constraint is then fulfilled. Lastly, if $\alpha > \beta$, then V_{α} is not strictly consistent since $i \in V_{\alpha}$ and $j \notin V_{\alpha}$, which is a contradiction. Thus, the lemma is proved.

The next theorem is a simple outcome of Lemmas 4 and 5.

Theorem 1. There exists a feasible schedule of makespan C if and only if there exists a path in the multistage auxiliary graph G from a vertex of T_1 to a vertex of T_{k^*} .

Our algorithm simply builds the multistage auxiliary graph \mathcal{G} starting from \mathcal{T}_{k^*} to \mathcal{T}_1 . Vertices without successor from \mathcal{T}_{α} with $\alpha \neq k^*$ are removed. In the next section, we investigate the time complexity for computing \mathcal{G} .

5. Complexity for the computation of the multistage auxiliary graph

Lemmas 6 and 7 study the complexity of two specific tests considered by our previous algorithm.

Lemma 6. Checking the consistency of a set $V \subseteq T$ can be done in time $\mathcal{O}(n^3)$ and checking the strict consistency of a set $V \subseteq T$ can be done in time $\mathcal{O}(n^2)$ (with n = |T|).

Proof. For any task $x \in T$, the computation of the sets of descendants $\Gamma(x)^{+\star}$ and of ancestors $\Gamma(x)^{-\star}$ can be done once in time $\mathcal{O}(n^2)$ using a depth-first search algorithm. Checking that V is consistent can be done by checking that, for any couple $(i,j) \in V^2$ with $i \neq j$, $\Gamma(i)^{+\star} \cap \Gamma(j)^{-\star} \subseteq V$. The overall complexity is then $\mathcal{O}(n^3)$.

Similarly, checking that for any task $x \in V$, $\Gamma^+(x) \subseteq V$ can be done in time $\mathcal{O}(|\Gamma^+(x)|)$. The overall complexity is bounded by

$$\sum_{x \in V} |\Gamma^+(x)| \le \sum_{x \in T} |\Gamma^+(x)| \le n^2,$$

the complexity of the algorithm is then $\mathcal{O}(n^2)$.

Lemma 7. The complexity of checking the existence of a feasible schedule of fixed duration C on m machines for a consistent set of tasks $V \subseteq T$ with the precedence relations modelled by G' = (V, A) is $\mathcal{O}(|V|^3 \times 2^{2|V|})$.

Proof. Let us denote by $\mathcal{P}(V)$ the set of consistent subsets of V. Let us consider the directed graph $H = (\mathcal{P}(V), E)$ which arcs are built as follows: an arc $(v, v') \in E$ if $v \subseteq v'$, $|v'-v| \leq m$ and for any task $i \in v'-v$, $\Gamma_{G'}^{-\star}(i) \subseteq v$ where $\Gamma_{G'}^{-\star}(i)$ is the set of the ancestors of i in G'.

Paths of H from \emptyset to V are associated to feasible schedules. Indeed, let us consider a path $v_0 = \emptyset, v_1, \ldots, v_p = V$ of H. For any value $\beta \in \{1, \ldots, p\}$, $Y_{\beta} = v_{\beta} - v_{\beta-1}$ are executed at time $\beta - 1$. Conversely any feasible schedule corresponds to a path of H. Thus, there exists a feasible schedule of makespan at most C if the value of a shortest path (considering each arc valued by 1) from \emptyset to V is inferior than or equal to C.

The number of vertices of H satisfies $|\mathcal{P}(V)| \leq 2^{|V|}$. By Lemma 6, checking that any element $v \in \mathcal{P}(V)$ is consistent can be done in time $\mathcal{O}(|V|^3 \times 2^{|V|})$. Checking that $e = (v, v') \in E$ has a time complexity bounded by $\mathcal{O}(|V|^2)$ thus the construction of H can be done in time $\mathcal{O}(|V|^3 \times 2^{2|V|})$.

Now, any arc e = (v, v') \in E verifies v \subseteq v' and thus |v| < |v'|. Then, H
     has no circuit. The shortest path can be computed from a topological sort
     in time complexity bounded by \mathcal{O}(2^{2|V|}), thus the lemma holds.
     Lemma 8. For any instance \mathcal{I}, the number of vertices |\mathcal{T}| of the multi-
     stage auxiliary graph \mathcal{G} is in \mathcal{O}(n2^{pw(\mathcal{I})}), while the number of arcs |\mathcal{A}| is in
     \mathcal{O}(n2^{2pw(\mathcal{I})}).
     Proof. By Lemma 3, for any value \alpha \in \{1, \ldots, k^{\star}\}, each element v \in \mathcal{T}_{\alpha}
     is included in X_{\alpha} thus |\mathcal{T}_{\alpha}| \leq 2^{|X_{\alpha}|} \leq 2^{pw(\mathcal{I})+1}. Then, |\mathcal{T}| = \sum_{\alpha=1}^{k^*} |\mathcal{T}_{\alpha}| \leq
     k^* \times 2^{pw(\mathcal{I})+1}. Since k^* \leq 2n, we get |\mathcal{T}| \leq 2n2^{pw(\mathcal{I})+1}.

          Now, the number or arcs of \mathcal{G} verifies |\mathcal{A}| \leq \sum_{\alpha=1}^{k^{\star}-1} (|\mathcal{T}_{\alpha}| \times |\mathcal{T}_{\alpha+1}|) \leq \sum_{\alpha=1}^{k^{\star}-1} (|\mathcal{T}_{\alpha}| \times |\mathcal{T}_{\alpha+1}|)

     k^{\star}(2^{pw(\mathcal{I})+1})^2 \leq 2n \times 2^{2pw(\mathcal{I})+2} which concludes the lemma.

          We are now ready to prove our main theorem:

     Theorem 2. Computing the graph \mathcal{G} is in time \mathcal{O}(n^4 2^{4pw(\mathcal{I})}) for any in-

     stance \mathcal{I}.

     Proof. Let us consider all the steps for the construction of the multistage
     auxiliary graph \mathcal{G} for an instance \mathcal{I} of the scheduling problem with n=|T|.
     The computation of sets X_{\alpha} and Z_{\alpha} for \alpha \in \{1, \ldots, k^{\star}\} can be done in
     time complexity \mathcal{O}(n \log n). For the definition of sets \mathcal{T}_{\alpha}, \alpha = 1, \ldots, k^{\star}, we
     observe that for each subset v \subseteq X_{\alpha}, we have to test if v \cup Z_{\alpha} is strictly
     consistent, which requires \mathcal{O}(n^2) instructions by Lemma 6. By Lemma 8,

     the construction of \mathcal{T} is thus in time \mathcal{O}(n^3 \times 2^{pw(\mathcal{I})}).
          Now, for any couple (v, v') \in \mathcal{T}_{\alpha} \times \mathcal{T}_{\alpha+1}, the consistency of S = (v \cup v)

     Z_{\alpha}) – (v' \cup Z_{\alpha+1}) is checked in time \mathcal{O}(n^3) by Lemma 6. The existence
     of a schedule of S on m machines within a makespan C_{\alpha} = u_{\alpha} - u_{\alpha-1} is
     in time \mathcal{O}(|S|^3 \times 2^{2|S|}) following Lemma 7. Now, since S \subseteq X_{\alpha}, |S| \leq
     pw(\mathcal{I}) + 1 and thus checking the existence of an arc (v, v') in \mathcal{A} is in time
     \mathcal{O}(n^3 + pw(\mathcal{I})^3 \times 2^{2(pw(\mathcal{I}))}). Following Lemma 8, the overall complexity for
     the determination of \mathcal{A} is then \mathcal{O}(n \times 2^{2pw(\mathcal{I})} \times (n^3 + pw(\mathcal{I})^3 \times 2^{2pw(\mathcal{I})})) and
     thus \mathcal{O}(n^4 \times 2^{4pw(\mathcal{I})}). The theorem follows.
     Corollary 1. P|prec, p_i = 1, r_i, d_i| \star is fixed-parameter tractable by the path-
     width pw(\mathcal{I}).
     Proof. By Theorem 1, an instance \mathcal{I} has a solution if and only if there exists
     a path in \mathcal{G} from a vertex of \mathcal{T}_1 to one from \mathcal{T}_{k^*}. By removing vertices
     without successor, it is equivalent to test that the remaining set |\mathcal{T}_1| > 0. By
```

Theorem 2, building \mathcal{G} is in time $\mathcal{O}(n^4 2^{4pw(\mathcal{I})})$, the corollary.

Corollary 2 is a simple outcome of Theorem 2.

Corollary 2. Let \mathcal{I} be an instance of $P|prec, p_i = 1, r_i, d_i| \star$ such that $pw(\mathcal{I})$ belongs to $\mathcal{O}(\log_2 n)$. The existence of a feasible schedule can be solved in time $\mathcal{O}(n^8)$.

By augmenting our algorithm by a binary search on an upper bound of the objectives, we obtain in the next corollary the fixed-parameter tractability of two optimization problems:

Corollary 3. Scheduling problems $P|prec, p_i = 1, r_i|C_{max}$ and $P|prec, p_i = 1, r_i|L_{max}$ are fixed-parameter tractable by the pathwidth $pw(\mathcal{I})$.

6. Conclusion and perspectives

For any instance \mathcal{I} of the decision problem $P|prec, p_i = 1, r_i, d_i|\star$, we introduced the pathwidth $pw(\mathcal{I})$ as a simple measure of the parallelism. We proved that the previous decision problem is fixed-parameter tractable by the parameter $pw(\mathcal{I})$. This result can be easily extended to $P|prec, p_i = 1, r_i|C_{\text{max}}$ and $P|prec, p_i = 1, r_i|L_{\text{max}}$ using a binary search. As far as we know, it is the first fixed-parameter algorithm for these scheduling problems. Extensions of this result should be considered to solve more general scheduling problems with precedence and resource constraints.
