1 **Structure of the antidiuretic hormone vasopressin receptor signalling complex.**

23 **Arginine-vasopressin (AVP) is a neurohypophysial peptide known as the**

24 **antidiuretic hormone. It forms an active signalling complex with the V2 receptor**

25 **(V2R) and the Gs protein, promoting a cAMP/PKA-dependent aquaporin insertion**

1 **in apical membranes of principal cells of the renal collecting ducts and ultimately,**  
2 **water reabsorption. Molecular mechanisms underlying activation of this critical G**  
3 **protein-coupled receptor (GPCR) signalling system are still unknown. To fill this**  
4 **gap of knowledge, we report here the structure of the AVP-V2R-Gs complex using**  
5 **cryo-electron microscopy (cryo-EM). Single-particle analysis revealed the**  
6 **presence of three different states. The two best maps were combined with**  
7 **computational and NMR spectroscopy constraints to reconstruct two structures of**  
8 **the ternary complex. These structures differ in AVP and Gs binding modes and**  
9 **could thus represent distinct complex conformations along the signalling**  
10 **activation pathway. Importantly, as compared to those of other class A GPCR-Gs**  
11 **complexes, the structures revealed an original receptor-Gs interface in which the**  
12 **Gs $\alpha$  subunit penetrates deeper into the active V2R, notably forming an ionic bond**  
13 **between its free C-terminal carboxylic function and the side chain of R137 in the**  
14 **V2R. Interestingly, the structures help to explain how V2R R137H or R137L/C**  
15 **variants can lead to two severe genetic diseases with opposite clinical outcomes,**  
16 **cNDI or NSIAD respectively. Our study thus provides important structural insights**  
17 **into the function of this clinically relevant GPCR signalling complex.**

18

19 The biological actions of AVP, a cyclic nonapeptide, are mediated through three GPCR  
20 subtypes, V1a, V1b and V2<sup>1</sup>. In addition, AVP is able to activate the related oxytocin (OT)  
21 receptor (OTR)<sup>2</sup>. The V2R is mainly expressed at the basolateral membrane of principal  
22 cells of the kidney collecting ducts and governs the crucial physiological function of body  
23 water homeostasis<sup>3</sup>. Binding of AVP to the V2R increases cAMP intracellular level via  
24 coupling to the adenylyl cyclase stimulatory Gs protein, leading to activation of protein  
25 kinase A, phosphorylation of aquaporin 2 water channels<sup>4</sup> and, ultimately to water

1 reabsorption and urine concentration. Activation of the V2R also elicits arrestin-  
2 dependent pathways such as receptor internalization and MAP kinase phosphorylation  
3 associated with cell growth and proliferation<sup>5,6</sup>. This GPCR is involved in many water  
4 balance disorders (hyponatremia consecutive to congestive heart failure, hypertension  
5 or hepatic cirrhosis) and voiding disorders (incontinence, nocturia), and as such  
6 constitutes a major therapeutic target<sup>7</sup>. Moreover, inactivating and constitutively active  
7 mutations in the V2R sequence are responsible for two rare X-linked genetic diseases  
8 with opposite clinical outcomes: 1) congenital nephrogenic diabetes insipidus (cNDI)  
9 characterized by excessive urine voiding<sup>8</sup>, 2) nephrogenic syndrome of inappropriate  
10 antidiuresis (NSIAD) characterized by excessive water loading and hyponatremia<sup>9</sup>. V2R  
11 is also a target for treating autosomal dominant polycystic kidney disease, the most  
12 frequent Mendelian inherited disorder affecting millions of people worldwide<sup>10</sup>. This  
13 pathology results from increased cell proliferation, apoptosis and dedifferentiation, in  
14 which cAMP- and MAP kinase-dependent signaling pathways are highly activated.

15 The structural biology of GPCRs has made significant progress during the last decade  
16 with a wealth of information on ligand binding and G protein coupling that shed light on  
17 structural and dynamic aspects of their function<sup>11,12</sup>. Yet V2R like many GPCRs, has been  
18 refractory to high-resolution structure determination. Cryo-EM has emerged as a  
19 powerful method for the determination of challenging membrane protein structures<sup>13</sup>,  
20 in particular when the intrinsic structural dynamics of the target prevents the use of  
21 crystallography. A growing list of GPCR-G protein complex structures has thus been  
22 determined<sup>14,15</sup>, revealing key molecular mechanisms of agonist binding and G protein  
23 (Gi, Gs, Gq, Go) coupling to class A and class B GPCRs. Here we have developed an *in vitro*  
24 purification strategy to reconstitute the GPCR signalling complex comprising the AVP-  
25 bound V2R and the heterotrimeric G<sub>s</sub> protein stabilized with the nanobody Nb35. Cryo-

1 EM single-particle analysis revealed the presence of three distinct populations of the  
2 ternary complex with two best maps at a mean resolution of 4.0 and 4.1 Å. A novel  
3 hybrid approach was used to build both corresponding structures. Analyses of the  
4 structural features of the distinct conformations provide unprecedented molecular  
5 insights into the dynamic process of ternary complex formation between the hormone  
6 AVP, the V2 receptor and the Gs protein.

### 8 **Determination of the AVP-V2R-Gs-Nb35 complex structure**

9 After extensive biochemical optimization, validation of the complex preparation and of  
10 cryo-EM grid sample vitrification, (see Methods, **Extended Data Fig. 1, Supplementary**  
11 **Figs. 1-2**), a total number of 25,770 movies were recorded, with 3.5 million particles  
12 picked and sorted out for further data processing (**Extended data Fig. 2-3**). After 3D  
13 classification of projections and 3D refinement, we identified three different  
14 conformational states of the complex, referred to as Loose (L), Tight-1 (T1) and Tight-2  
15 (T2). Reconstruction of each state was at 4.2 Å, 4.5 Å and 4.7 Å, with a distribution of  
16 16%, 48% and 36%, respectively (**Extended Data Fig. 2**), the local resolution varying  
17 from 3.2 to 6.4 Å (**Extended data Fig. 3c-d**). Using the recent algorithm developed to  
18 enhance cryo-EM maps by density modification<sup>16</sup>, the resolution of density maps were  
19 improved to 4.0 (L state), 4.1 (T1 state) and 4.5 Å (T2 state), respectively (**Extended**  
20 **data Fig. 2, Extended Data Table 1, Supplementary Fig. 3**). These maps mainly differ  
21 in the angle of Gs-Nb35 with the receptor 7TM, and may reflect an inherent high  
22 flexibility of the complex. A conformational heterogeneity analysis using multi-body  
23 refinement revealed that more than 78% of the variance is accounted for by the fourth  
24 first eigenvectors related to rotations and translations between AVP-V2R and Gs-Nb35  
25 (**Extended Data Fig. 4, Extended data Movie 1**). The 4.5 Å map of the T2 state was not

1 well enough resolved to compute a reliable structure. Therefore, only the L and T1  
2 structures, referred to as L and T states, were used for further analysis.

3 Because we could not unambiguously build the AVP in the calculated maps, we designed  
4 an original hybrid strategy based on a combination of cryo-EM maps, computational  
5 molecular dynamic simulations and experimental saturation transfer difference (STD)  
6 NMR (**Fig. 1a-e, Supplementary Discussion and Figs. 4-8**). Based on this approach, the  
7 L and T models were then built in a more conventional manner to match as closely as  
8 possible the density maps (**Fig. 1f-g, Extended Data Table 1**).

9 In the final models, side chains of most residues are clearly identifiable in the 7 TM and  
10 helix 8 of the V2R in both structures (**Extended Data Fig. 5**). Intracellular loop1 (ICL1)  
11 was well defined in the maps, as well as the contacts between V2R and the Gs protein.  
12 The  $\alpha$ -helical domain of G $\alpha$ s subunit was subtracted during single particle analysis for  
13 high-resolution map refinement. Intracellular loops 2 and 3 and the C-terminus of V2R  
14 were not seen in the density maps, and were not constructed in the final models.

15

## 16 **Overall architecture of the ternary complex**

17 Both L and T AVP-V2-Gs ternary complexes present a typical GPCR-G protein  
18 architecture with the receptor 7TM helix bundle engaging the peptide agonist on the  
19 extracellular side and the G $\alpha$ s C-terminus domain ( $\alpha$ 5 helix) on the intracellular side  
20 (**Fig 2a-d**). However, the L and T states present large structural differences most  
21 notably in the position of the G protein heterotrimer relative to V2R (**Fig. 2e**). The  $\alpha$ 5  
22 helix interacts more tightly in the T state than in the L state (**Fig. 2b and 2d**), inducing a  
23 translation of the whole Gs heterotrimer (**Fig. 2e**). In particular, the  $\alpha$ 4 helix and the  
24 Ras-like domain of G $\alpha$ s are translated from 4 Å and 5 Å between the L and T states,  
25 respectively. These movements position the  $\alpha$ N helix 5 Å closer to the receptor in the T

1 state in comparison to the L state (**Fig. 2e**). Those G $\alpha$  movements are also accompanied  
2 by a 7 Å translation of the G $\beta$  N-terminal helix, a translation of the  $\gamma$  subunit of 6 Å and a  
3 translation of Nb35 of 7 Å (**Fig. 2e**).

4 The presence of several conformational states and the multi-body refinement analysis  
5 reflect the dynamics of V2-Gs complex formation. From the final L structure model, a  
6 principal component analysis (PCA) obtained from classical molecular dynamic  
7 simulations revealed similar dynamics and suggests that the conformations captured by  
8 the cryo-EM 3D reconstructions represent averaged states that are part of a much larger  
9 conformational ensemble (**Extended data Movie 2, Supplementary Fig. 9**). Though  
10 those differences are less pronounced than the ones recently described for the  
11 neurotensin receptor NTSR1-Gi1 complexes<sup>17</sup>, they further indicate that GPCR-G protein  
12 coupling is a dynamic process in which the G protein may explore different set of  
13 conformations.

14

#### 15 **AVP binding pocket within V2R and comparison with OTR binding site**

16 Our hybrid approach allowed us to build convincing models of AVP binding poses in  
17 both L and T structures. The final calculated structures present a central position of AVP  
18 in the orthosteric pocket of the V2R along the axis of the helical bundle (**Fig. 3,**  
19 **Extended Data Fig. 6**). The extracellular domains of the V2R are widely opened in both  
20 L and T conformations, a feature consistent with the accommodation of a cyclic peptide  
21 like AVP (**Extended Data Fig. 6**), and in agreement with the recently reported inactive  
22 OTR structure<sup>18</sup>. In the L and T structures, AVP contacts residues from both TM helices  
23 and extracellular loops (**Fig. 3a-c, Extended Data Fig. 6**) in agreement with what was  
24 originally proposed based on pharmacological data<sup>19</sup>. Consistent with its amphipathic

1 nature, AVP interacts with two chemically distinct interfaces in a 15 Å deep binding  
2 pocket to form both polar and hydrophobic contacts (**Fig. 3a-c**).

3 While AVP conformations occupy a central position in both the L and T binding clefts,  
4 interesting changes are observed due to a translation of the Tyr<sup>2</sup> residue side-chain  
5 (from TM7 to TM3), and to a movement of the C-terminal tripeptide (inversion in Arg<sup>8</sup>  
6 and Gly<sup>9</sup>-NH<sub>2</sub> positions) at the V2R surface (**Extended data Fig. 6**). The cyclic part of  
7 AVP (Cys<sup>1</sup> to Cys<sup>6</sup>) and the Pro<sup>7</sup> are buried into the cleft defined by the seven-helix  
8 bundle of V2R, leaving only Arg<sup>8</sup> residue and C-terminal glycinamide exposed to the  
9 solvent (**Extended data Fig. 6**). In both the L and T structures, the Cys<sup>1</sup>-Tyr<sup>2</sup>-Phe<sup>3</sup>  
10 hydrophobic motif of AVP binds deeper in the binding site creating key contacts with the  
11 receptor (**Fig. 3a-c**), in agreement with STD spectroscopy data (**Fig. 1**).

12 V2R and OTR belong to the same subfamily of peptide class A GPCRs and share a  
13 common orthosteric binding site<sup>19,20</sup>. Although V2R and OTR (PDB 6TPK) structures<sup>18</sup>  
14 represent different GPCR conformations (active agonist-bound V2R vs inactive  
15 antagonist-bound OTR), it is interesting to compare the complete set of residues  
16 involved in the binding of the natural hormone AVP with the ones involved in retosiban  
17 binding to gain insights into ligand binding and efficacy in this receptor family (**Fig 3b-**  
18 **e**). Many OTR residues involved in the binding of retosiban are actually conserved  
19 among AVP/OT receptors and also interact with AVP in the V2R (**Fig. 3b-e**).

20 Interestingly, the conserved W<sup>6.48</sup> and F<sup>6.51</sup> (Ballesteros-Weinstein numbering) in  
21 AVP/OT receptors, interact with the highly hydrophobic indanyl moiety of retosiban in  
22 the crystal structure of inactive OTR. AVP also makes contact with F<sup>6.51</sup> through its Tyr<sup>2</sup>  
23 but is not in contact with W<sup>6.48</sup> in the V2R, probably because it is too bulky to bind  
24 deeper in the pocket. These data confirm that hydrophobic small molecule nonpeptide

1 antagonists and AVP partially superimpose at the bottom of the orthosteric binding  
2 pocket of AVP/OT receptors (**Fig. 3d-e**)<sup>21,22,23</sup>.

#### 4 **Activation of the V2R and comparison with other class A GPCRs**

5 The active-state structures of the V2R reveal key structural features of the activation  
6 process by comparison with the OTR inactive structure (**Fig. 4a-e**). Moreover, to get a  
7 more general view of V2R activation, it was also important to look at the canonical  
8 conformational changes of TMs and of conserved motifs involved in other ligand-  
9 activated GPCRs of class A<sup>24,25</sup>. Thus, compared to other active GPCR structures and to  
10 the inactive antagonist-bound OTR structure (**Fig. 4, Supplementary Fig. 10**), the L and  
11 T structures of V2R present all the features of active conformations, i.e. a large-scale  
12 displacement of TM6 (**Fig. 4a**), conformational changes of W<sup>6.48</sup> toggle switch (**Fig. 4b**),  
13 a rearrangement of the P<sup>5.50</sup>-S<sup>3.40</sup>-Y<sup>6.44</sup> transmission switch, equivalent to the PIF motif in  
14 other GPCRs (**Fig. 4c**), a rotation of the conserved NPxxY<sup>7.53</sup> motif (**Fig. 4d**) and a broken  
15 D136<sup>3.49</sup>-R137<sup>3.50</sup> ionic lock (**Fig 4e, Fig. 5e**).

16 Importantly by comparing the structures of the inactive antagonist-bound OTR with the  
17 active agonist-bound V2R, it appears that contacts between M123<sup>3.36</sup> and F287<sup>6.51</sup>-  
18 W284<sup>6.48</sup> motif (all in contact with Tyr<sup>2</sup> of AVP) undergo large conformational  
19 rearrangements (**Extended Data Fig. 6**). It is thus tempting to speculate that it is a key  
20 motif regulating the activity of this family of receptor.

21 As indicated above, the V2R R137<sup>3.50</sup> participates in the ionic lock motif involved in the  
22 balance of active *versus* inactive states of class A GPCRs<sup>24</sup>. In the inactive structure of  
23 OTR (**Fig. 4e**), D136<sup>3.49</sup> and R137<sup>3.50</sup> interact with each other through this ionic lock. For  
24 comparison, this salt bridge is broken in the L and T active conformations of the V2R-Gs  
25 complex (**Fig. 4e, Fig. 5e**). The observed constitutive activity towards Gs coupling for

1 the missense mutations C137<sup>3.50</sup> or L137<sup>3.50</sup> responsible for NSIAD<sup>9,26,27</sup> can thus be  
2 explained from a structural point of view since these hydrophobic residues are not able  
3 to form such an ionic lock to stabilize the inactive state. On the contrary, the mutant  
4 H137<sup>3.50</sup> causing cNDI<sup>28,29</sup> might still be able to maintain the balance between active and  
5 inactive states of the V2R through its partial positive charge. Its loss-of-function rather  
6 reflects the loss of accessibility to AVP because of a constitutive internalization<sup>27, 28,29</sup>.

### 8 **V2R-Gs interactions**

9 The cryo-EM maps of the ternary complex clearly establish the structural details of V2R-  
10 Gs coupling. As anticipated from the conserved mechanism of GPCR-G protein  
11 coupling<sup>30,31</sup>, both the L and T conformations show a similar overall architecture of the  
12 complex interface with the engagement of the G $\alpha$ s C-terminal  $\alpha$ 5 helix in the core of the  
13 7TM (**Fig. 5, Extended Data Fig. 7, Supplementary Fig. 10**). However, there are some  
14 interesting differences compared to other GPCR-Gs complex structures. Of note, in both  
15 the L and T structures, the V2R ILC1 makes many direct contacts with the G $\beta$  subunit. In  
16 the T state, ICL1 residues L62-A63-R64-R65-G66 interact with G $\beta$  R52, D312-N313 and  
17 D333-F335 (**Fig5a**). In the L state, ICL1 residues R65-G66-R67-R68 interact with G $\beta$   
18 R52, D312 and D333 (**Extended Data Fig. 7a**). These contacts between V2R and G $\beta$  are  
19 much more numerous than in the class A GPCR  $\beta$ 2AR- or A<sub>2A</sub>R-Gs complexes<sup>32,33</sup>.  
20 Moreover in the T conformation, there are some additional contacts between V2R ICL1  
21 (R67-G69-H70) with the N-terminal  $\alpha$  helix of G $\alpha$ s (Q31, Q35 and R38), resulting in a  
22 more compact interaction (**Fig 5b**). In the L state, V2R (W71) and N-terminal  $\alpha$  helix of  
23 G $\alpha$ s (Q35 and R38) contacts are more limited (**Extended Data Fig. 7b**). Contacts  
24 between the N-terminal  $\alpha$  helix of G $\alpha$ s with GPCRs have only been seen in GLP1R and  
25 CTR class B GPCR complexes<sup>34,35</sup>, not in class A GPCR-G complexes.

1 In contrast to what was observed for the  $\beta$ 2AR<sup>32</sup> and the  $\mu$ OR<sup>36</sup>, the G $\alpha$ s C-terminal  $\alpha$ 5  
2 helix appears to extend helix 8 (H8) of the V2 receptor, lying almost parallel to the  
3 membrane plane (**Fig. 5c, Extended Data Fig 7c, f-h**). Also, compared with the  $\beta$ 2AR,  
4 the C-terminus of G $\alpha$ s is interacting deeper in the V2R 7TM core making direct contact  
5 with residues (L and T states, respectively) of V2R that are part or in close proximity to  
6 the conserved NPxxY (TM7) and DRH (TM3) activation motifs (**Fig 5d-e, Extended Data**  
7 **Fig. 7d-h**). In this respect, the V2-Gs interaction resembles more the interaction seen in  
8 the  $\mu$ OR-Gi complex (**Extended Data Fig. 7f-h**). The V2R TM7-H8 hinge region also  
9 makes a strong contact with the G $\alpha$ s ELL motif, in particular through hydrophobic  
10 contacts with the F328<sup>7.56</sup> side chain (**Fig. 5d**). The T and L conformations differ here in  
11 the position of the G $\alpha$ s L394 side chain originating from a distinct F328<sup>7.56</sup> side chain  
12 conformation (pointing towards I78<sup>2.43</sup> of the receptor in the T structure or towards G $\alpha$ s  
13 L394 in the L structure) (**Fig. 5d, Extended Data Fig. 7d**). Most notably in the T state,  
14 the side chain of R137<sup>3.50</sup> which is part of the ionic lock motif, forms an ionic interaction  
15 with the free carboxylic acid function of the G $\alpha$ s C-terminus (**Fig. 5e**), a direct contact  
16 that was not observed before between a GPCR and a G protein of any family (Gs, Gi, Go  
17 or Gq)<sup>14,15,37</sup>. Moreover, in the L state, the density map suggests that the R137<sup>3.50</sup> side  
18 chain could adopt two conformations, one forming a similar ionic interaction with the  
19 carboxylic acid of G $\alpha$ s L394 main chain, and, the other one, pointing towards the  
20 Y325<sup>7.53</sup> from the NPxxY motif (**Extended Data Fig. 7e**).

## 22 **Conclusion**

23 In this study, we solved two structures of the active state of the AVP hormone-bound  
24 V2R in complex with the Gs protein. The structural insights into the function of this

1 signalling system pave the way for future drug development to treat water balance  
2 disorders<sup>7</sup>.

## 1 **METHODS**

2

### 3 **Data analysis and Figure preparation**

4 Figures were created using the PyMOL 2.3.5 Molecular Graphics System (Schrödinger,  
5 LLC) and the UCSF Chimera X 0.9 package. Data were plotted with GraphPad Prism 8.3.0.

6

### 7 **V2R expression and purification**

8 The version of the human V2R used for this study is described in Supplementary  
9 Methods and was cloned into a pFastBac™1 vector. It was expressed in Sf9 insect cells  
10 using the Bac-to-Bac® baculovirus expression system ((ThermoFisher) according to  
11 manufacturer's instructions. Insect cells were grown in suspension in EX-CELL® 420  
12 medium (SigmaAldrich) to a density of  $4 \times 10^6$  cells per ml and infected with the  
13 recombinant baculovirus at a MOI of 2-3. The culture medium was supplemented with  
14 the V2R pharmacochaperone antagonist Tolvaptan (TVP, SigmaAldrich) at 1  $\mu$ M to  
15 increase the receptor expression levels<sup>38,39</sup>. The cells were infected for 48h-54h at 28°C  
16 and expression of the V2R was checked by immunofluorescence using an anti-Flag M1  
17 antibody coupled to Alexa488. Cells were then harvested by centrifugation (2 steps, 20  
18 min, 3,000xg) and pellets were stored at -80°C until use.

19 The cell pellets were thawed and lysed by osmotic shock in 10 mM Tris-HCl pH 8, 1 mM  
20 EDTA buffer containing 2mg.ml<sup>-1</sup> iodoacetamide, Tolvaptan 1  $\mu$ M and protease  
21 inhibitors (leupeptine 5 $\mu$ g.ml<sup>-1</sup>, benzamidine 10 $\mu$ g.ml<sup>-1</sup> and PMSF 10 $\mu$ g.ml<sup>-1</sup>). After  
22 centrifugation (15 min, 38,400xg), the pellet containing crude membranes was  
23 solubilized using a glass dounce tissue grinder (15 + 20 strokes using A and B pestles,  
24 respectively) in a solubilization buffer containing 20 mM Tris-HCl pH 8, 500 mM NaCl,  
25 0.5 % (w/v) n-dodecyl- $\beta$ -D-maltopyranoside (DDM, Anatrace), 0.2% (w/v) sodium

1 cholate (SigmaAldrich), 0.03 % (w/v) cholesteryl hemisuccinate (CHS, SigmaAldrich), 20  
2 % Glycerol, 2 mg.ml<sup>-1</sup> iodoacetamide, 0.75 ml.L<sup>-1</sup> Biotin Biolock (IBA), Tolvaptan 1 μM  
3 and protease inhibitors. The extraction mixture was stirred for 1 h at 4 °C and  
4 centrifuged (20 min, 38,400xg). The cleared supernatant was poured onto an  
5 equilibrated Strep-Tactin® resin (IBA) for a first affinity purification step. After 2h of  
6 incubation at 4°C under stirring, the resin was washed three times with 10 CV of a buffer  
7 containing 20 mM Tris-HCl pH 8, 500 mM NaCl, 0.1 % (w/v) DDM, 0.02% (w/v) sodium  
8 cholate, 0.03 % (w/v) CHS, Tolvaptan 1 μM. The bound receptor was eluted in the same  
9 buffer supplemented with 2.5 mM desthiobiotin (IBA).

10 The eluate was supplemented with 2mM CaCl<sub>2</sub> and loaded onto a M1 anti-Flag affinity  
11 resin (SigmaAldrich). The resin was washed with 10 CV of two successive buffers  
12 containing 20 mM HEPES pH 7.5, 100 mM NaCl, 0,1% DDM, 0,01% CHS, 10 μM AVP,  
13 2mM CaCl<sub>2</sub>, then 20 mM HEPES pH 7.5, 100 mM NaCl, 0,025% DDM, 0,005% CHS, 10 μM  
14 AVP, 2mM CaCl<sub>2</sub>, respectively. The receptor was eluted from the Flag resin using a buffer  
15 containing 20 mM HEPES pH 7.5, 100 mM NaCl, 0,025% DDM, 0,005% CHS, 10 μM AVP,  
16 2 mM EDTA and 200 μg/mL Flag peptide (Covalab).

17 After concentration using a 50kDa MWCO concentrator (Millipore), the V2R was purified  
18 by size exclusion chromatography (SEC) using a Superdex 200 (10/300 column)  
19 connected to an AKTA purifier system (GE Healthcare). Fractions corresponding to the  
20 pure monomeric receptor were pooled (~ 2 ml) and concentrated to 50-100 μM with an  
21 excess of AVP (200 μM).

22

### 23 **Gs expression and purification**

24 Human G<sub>α</sub>s, G<sub>β</sub>1 with a N-terminal Twin-Strep-tag® and Gγ2 were all expressed in Sf9  
25 insect cells grown in EX-CELL® 420 medium (SigmaAldrich). A recombinant

1 baculovirus for G $\alpha$ s subunit was prepared using the BestBac™ (Expression Systems)  
2 strategy, whereas a baculovirus for G $\beta$ 1 and G $\gamma$ 2 was prepared using the Bac-to-Bac®  
3 system. G $\beta$ 1 and G $\gamma$ 2 were cloned in tandem into the pFastBac™ Dual vector  
4 (ThermoFisher). Sf9 cells, at a density of 4x10<sup>6</sup> cells/ml, were co-infected with both  
5 viruses at a 1:2 G $\alpha$ s:G $\beta$ 1 $\gamma$ 2 ratio for 72h at 28°C. Cells were harvested and pellets stored  
6 at -80°C.

7 Co-infected Sf9 cell pellets were thawed and lysed in a buffer containing 10 mM TRIS pH  
8 7.4, 1mM EDTA, 5 mM  $\beta$ -Mercapto-Ethanol, 10  $\mu$ M GDP and protease inhibitors  
9 (leupeptine 5 $\mu$ g.ml<sup>-1</sup>, benzamidine 10 $\mu$ g.ml<sup>-1</sup> and PMSF 10 $\mu$ g.ml<sup>-1</sup>). Lysed cells were  
10 centrifuged (20 minutes, 38,400xg). The pellets containing the crude membranes were  
11 homogeneized using a glass dounce tissue grinder (20 strokes with tight B pestle) in  
12 solubilization buffer containing 20 mM HEPES pH 7.5, 100 mM NaCl, 1% DDM, 5 mM  
13 MgCl<sub>2</sub> supplemented with 5 mM  $\beta$ -Mercapto-Ethanol, 10  $\mu$ M GDP, 0.75 ml.L<sup>-1</sup> biotin  
14 biolock and protease inhibitors. The mixture was stirred for 40 minutes at 4°C and  
15 centrifuged (20 min, 38,400xg). The supernatant was loaded onto a Strep-Tactin®  
16 affinity resin equilibrated with the same buffer. The resin was washed 3 times, first with  
17 5 CV of solubilization buffer, then with 5 CV of solubilisation buffer supplemented with  
18 100  $\mu$ M TCEP (instead of  $\beta$ -Mercapto-Ethanol), and finally with 10 CV of wash buffer  
19 containing 20 mM HEPES pH 7.5, 50 mM NaCl, 0.1% DDM, 1 mM MgCl<sub>2</sub>, 100  $\mu$ M TCEP, 10  
20  $\mu$ M GDP. The Gs heterotrimer protein was eluted in the same buffer supplemented with  
21 2.5 mM desthiobiotin. After a treatment with antarctic phosphatase (5 Units, NEB Inc.)  
22 for 30 minutes at 4°C, the Gs protein was concentrated to 10 mg/ml using 50 kDa MWCO  
23 concentrators. 20% glycerol was added to the sample and aliquots were flash-frozen in  
24 liquid nitrogen before storage at -80 °C.

25

## 1 **Nb35 expression and purification**

2 The production and purification of Nb35 were performed following a protocol  
3 established by Kobilka and coworkers<sup>40</sup>. It is described in Supplementary Methods.

4

## 5 **Purification of the AVP-V2R-Gs-Nb35 complex**

6 Formation of a stable complex was done by mixing the purified V2R with 1.2 molar  
7 excess of purified Gs heterotrimer, 250  $\mu$ M AVP and 2.5 mM  $MgCl_2$ . The coupling  
8 reaction was allowed to proceed at RT for 45 minutes and was followed by addition of  
9 apyrase (0.0125 Units, NEB Inc.) to hydrolyse residual GDP and maintain the high-  
10 affinity nucleotide-free state of Gs. 15 minutes later, Nb35 was added at a 2-fold molar  
11 excess compared to Gs. After 15 more minutes at RT, the mix was incubated overnight at  
12 4°C. In most reaction mixtures, the final concentration of V2R was 20-30  $\mu$ M, that of Gs  
13 30-40  $\mu$ M and the one of Nb35 around 80  $\mu$ M. To remove excess of G protein  
14 heterotrimer and Nb35, the complex AVP-V2R-Gs-Nb35 was purified by a M1 anti-Flag  
15 affinity chromatography. After loading, the DDM detergent was then gradually  
16 exchanged with Lauryl Maltose Neopentyl Glycol (LMNG, Anatrace). The LMNG  
17 concentration was then decreased gradually from 0.5% to 0.01%. The complex and the  
18 unbound V2R were eluted in 20 mM HEPES pH 7.5, 100 mM NaCl, 0.01% LMNG, 0.002%  
19 CHS, 2 mM EDTA, 10  $\mu$ M AVP and 0.2 mg.mL<sup>-1</sup> Flag peptide. The eluted AVP-V2R-Gs-  
20 Nb35 complex was separated from unbound V2R by SEC on a Superdex 200 10/300  
21 with a buffer containing 20 mM HEPES pH 7.5, 100 mM NaCl, 0.002% LMNG, 0.0025%  
22 glyco-diosgenin (GDN, Anatrace), 0.002% CHS, 10  $\mu$ M AVP. The fractions corresponding  
23 to the complex were collected, concentrated with a 50 kDa MWCO concentrator and  
24 subjected to a second SEC on a Superose 6 (10/300 GL, GE Healthcare) with a buffer  
25 containing 20 mM HEPES pH 7.5, 100 mM NaCl, 0.0011% LMNG, 0.001% GDN, 0.002%

1 CHS, 10  $\mu$ M AVP. Peak fractions were pooled and concentrated using a 50 kDa MWCO  
2 concentrator to concentrations ranging from  $\sim$ 1 mg.mL<sup>-1</sup> to  $\sim$ 4 mg.mL<sup>-1</sup> for Cryo-EM  
3 studies. The amphipol A8-35 (Anatrace) was added at 0.001% to help in the dispersion  
4 of the particles for Cryo-EM grid preparation.

5

## 6 **Negative stain microscopy observations**

7 Before preparing Cryo-EM grids, we first checked the quality and the homogeneity of the  
8 AVP-V2R-Gs-Nb35 sample by NS-EM. The procedure is described in Supplementary  
9 Methods.

10

## 11 **Cryo-EM sample preparation, image acquisition**

12 In this study, two datasets have been recorded from two different preparations of AVP-  
13 V2R-Gs-Nb35. For the first dataset acquisition, 3  $\mu$ L of purified AVP-V2R-Gs-Nb35 at  
14 0.75 mg/ml concentration were applied on glow-discharged Quantifoil R 1.2/1.3 300  
15 mesh copper holey-carbon grids (Quantifoil Micro tools GmbH, Germany), blotted for  
16 4.5s and then flash-frozen in liquid ethane using the semi-automated plunge freezing  
17 device Vitrobot Mark IV (ThermoFisher) maintained at 100% relative humidity and 4°C.  
18 For the second dataset acquisition, cryo-EM grids were prepared as previously, but the  
19 purified V2R-Gs-Nb35 complex was at a concentration of 4 mg/ml and the cryo-EM grids  
20 were prepared using a EM GP2 (Leica microsystems) plunge freezer with a 4s blotting  
21 time (100% humidity and 4°C).

22 Images were collected in 2 independent sessions on a TEI Titan Krios (ThermoFisher) at  
23 the EMBL of Heidelberg (Germany) at 300 keV through a Gatan Quantum 967 LS energy  
24 filter using a 20 eV slit width in zero-loss mode and equipped with a K2-Summit (Gatan  
25 inc.) direct electron detector configured in counting mode. Movies were recorded at a

1 nominal EFTEM (energy-filtered transmission electron microscope) magnification of  
2  $\times 165,000$  corresponding to  $0.81 \text{ \AA}$  calibrated pixel size. The movies were collected in 40  
3 frames in defocus range between  $-0.8$  and  $-2.2 \text{ \mu m}$  with a total dose of  $50.19 \text{ e}^-/\text{\AA}^2$  (1<sup>st</sup>  
4 dataset) and  $41.19 \text{ e}^-/\text{\AA}^2$  (2<sup>nd</sup> dataset). Data collection was fully automated using  
5 SerialEM<sup>41</sup>.

6

### 7 **Cryo-EM data processing**

8 All data processing operations were performed with RELION-3.0.7<sup>42</sup> unless otherwise  
9 specified.

10 In total, 17,290 movies of the AVP-V2R-Gs-Nb35 sample at  $0.75 \text{ mg/ml}$  were collected.  
11 Dose-fractionated image stacks were subjected to beam-induced motion correction and  
12 dose-weighting using Motioncorr own implementation. Gctf was used to determine the  
13 contrast transfer function parameters<sup>43</sup> from non-dose weighted images. After sorting,  
14 micrographs with maximum estimated resolution beyond  $5 \text{ \AA}$  were discarded. Particle  
15 picking was carried out using Gautomatch (K. Zhang, MRC LMB ([www.mrc-](http://www.mrc-lmb.cam.ac.uk/kzhang/)  
16 [lmb.cam.ac.uk/kzhang/](http://www.mrc-lmb.cam.ac.uk/kzhang/))) allowing to pick out 2,291,432 particles. Particles were  
17 extracted in a box-size of  $240 \text{ \AA}$ , downsampled to  $4 \text{ \AA/pix}$  and subjected to reference-free  
18 2D classifications to discard false-positive particles or particles categorized in poorly  
19 defined classes. A subset of 1,109,475 particles was selected for further processing. This  
20 particle set was subjected to a 3D classification with four classes using the  $30 \text{ \AA}$  low-pass  
21 filtered calcitonin receptor map as reference<sup>35</sup>. Particles from the 2 classes representing  
22 27% of total particles and showing a complete AVP-V2R-Gs-Nb35 complex were  
23 selected, re-extracted with a pixel size of  $1.62 \text{ \AA}$ , and subjected to a 3D refinement. This  
24 subset of 307,125 particles yielded a map with a global resolution (FSC = 0.143) of  $4.8 \text{ \AA}$   
25 resolution. Particles were then subjected to a focused 3D classification without angular

1 and translational alignments with a mask including the complex minus G $\alpha$ SAH. The best  
2 class corresponding to 150,000 particles were re-extracted without binning and  
3 submitted to a 3D refinement, allowing us to obtain a map at 4.4 Å resolution. All further  
4 processing including signal subtraction, using of different type of masks, CTF  
5 refinement and polishing did not improved the resolution of the map.

6 In total, 8,490 movies of the AVP-V2R-Gs-Nb35 sample at 4.0 mg/ml were recorded. The  
7 image processing steps were the same as previously described, except that the picking  
8 was performed using boxnet from Warp software package<sup>44</sup> allowing us to extract  
9 1,214,575 particles. After a 2D classification to clean the dataset, a subset of 917,990  
10 particles was subjected to two successive rounds of 3D classification. A subset of  
11 150,000 particles was used for further 3D refinements yielding a final map at 4.4 Å  
12 resolution.

13 Both cleaned datasets were merged, corresponding to 1,109,475 particles from dataset  
14 1 and 917,990 particles from dataset 2. Particles were subjected to 3D classification  
15 with 3 classes. One class displayed the expected structural features of the AVP-V2R-Gs-  
16 Nb35 complex corresponding to 877,003 particles and were selected for a new round of  
17 3D classification with 6 classes. This classification revealed structural variability in the  
18 ligand location and at the interface between the receptor and the Gs protein. Three  
19 subsets of particles were selected (L, T1 and T2 states), re-extracted with a pixel size of  
20 1.62 Å or 0.81 Å, and subjected to 3D refinements yielding maps at 4.5 Å, 4.7 Å and 5.5 Å  
21 respectively. New rounds of 3D refinements were performed in applying a mask to  
22 exclude both the micelle and the G $\alpha$ SAH yielding maps at 4.23 Å, 4.4 Å and 4.7 Å. CTF  
23 refinement and polishing steps were applied on the three subsets of particles, allowing  
24 us to improve the resolution of the best map to 4.17 Å (FSC = 0.143). The 1.62 Å/pixel  
25 T1 map was resampled at 0.81 Å/pixel for visualization purposes. Final refinements

1 were processed with the option masking individual particles with zero turned-off. All  
2 our attempts to refine our final subsets in cisTEM<sup>45</sup> and cryoSPARC<sup>46</sup> using non-uniform  
3 refinement did not improve the resolution of final maps.  
4 To investigate the conformational dynamics of the signalling complex, multi-body  
5 refinement was performed on 877,003 particles, with two bodies corresponding to AVP-  
6 V2R and Gs-Nb35. Local resolution was estimated with the Bsoft 2.0.3 package<sup>47,48</sup>. Map  
7 sharpening was re-evaluated with Phenix autosharpen tool<sup>49</sup>. Phenix resolve\_cryoEM  
8 tool<sup>16</sup> was used to improve the map interpretability and allowed to increase the  
9 estimated resolution to 4.04, 4.13 and 4.5 Å for L, T1 and T2 states, respectively  
10 **(Supplementary Fig. 3).**

11

## 12 **Model building and refinement**

### 13 *Receptor and AVP initial models*

14 The V2R was built by comparative modelling, using the MODELLER software<sup>50</sup> and the  
15 X-ray structure of the  $\delta$ -opioid receptor at 3.4 Å resolution (PDB:4EJ4) as a template<sup>51</sup>,  
16 sharing a sequence similarity of about 44% with the V2R (on the modeled region).  
17 Because modelling loops or terminal regions is a very challenging task and their  
18 dynamical behavior is very poorly described in CG simulations, N- and C-terminus of the  
19 receptor (residues 1-35 and 335-371, respectively) as well as part of the icl3 loop (237-  
20 262) were lacking in the used template. Thus, only residues 36 to 236 and 263 to 334  
21 were modeled. 500 models were generated and the one sharing the best objective  
22 function score was further selected as a starting point for the simulations. The disulfide  
23 bridge conserved among the class A GPCRs was included between residues 112 and 192  
24 of the V2R.

1 The AVP peptide ( $\text{NH}_3^+$ -CYFQNCPRG- $\text{CONH}_2$ ) was built from its X-ray structure available  
2 in the PDB (code 1JK4, 2.3 Å resolution) which describes the 6-residues cycle of the  
3 peptide in interaction with neurophysin<sup>52</sup>. As depicted in **Supplementary Fig. 4** this  
4 structure shows a cycle conformation equivalent to that found in bound (PDB code:  
5 1NPO) and unbound related peptide oxytocin (PDB code: 1XY2)<sup>53,54</sup>. It was thus  
6 preferred to the one describing the trypsin:vasopressin complex (PDB code : 1YF4)<sup>55</sup>  
7 harboring a completely different conformation of the cycle. The three last residues of the  
8 peptide (7-PRG-9) were also built with the oxytocin structure templates.

9 The obtained initial models of both receptor and peptide were then converted to a CG  
10 representation using the MARTINI forces field (version 2.2, Elnedyn)<sup>56</sup>. Using such a  
11 model, residues (backbone beads) closer than 9.0 Å are bound by a spring displaying a  
12 force constant of 500  $\text{kJ}\cdot\text{mol}^{-1}\cdot\text{nm}^{-2}$  (default value from the Elnedyn force field). Such a  
13 link is meant to maintain both the secondary and the tertiary structures of the  
14 polypeptides. The resulting elastic networks of both the peptide and the receptor are  
15 represented in **Supplementary Fig. 4**. For the peptide, only the springs involving two  
16 residues of the cycle were conserved for further calculations, the three last residues  
17 being free to move. The standard elastic network of the receptor was not modified and  
18 allowed the latter to open or close freely as no spring was bridging the extracellular  
19 loops.

#### 20 *MD simulations*

21 The receptor was inserted in a  $100\times 100$  Å<sup>2</sup> lipid bilayer exclusively composed of POPC.  
22 To avoid the exploration by the peptide of the intracellular side of the membrane during  
23 MD (because of periodic boundary conditions), the system was duplicated/rotated along  
24 the z-axis (the two extracellular sides of the receptors were facing each other), in order  
25 to create an extracellular compartment. Two copies of the peptide were added to

1 increase the interaction sampling with a 1:1 ratio. In a last step, water and chloride  
2 counter-ions were added to neutralize the system. The fully-solvated system included  
3 20004 beads. A representation of the simulated box with two receptors and two  
4 peptides is reported in Supplementary Fig. 3. After 10 000 steps of energy minimization  
5 using the conjugate gradient algorithm, the system was further equilibrated at 51  
6 different temperatures (in the range 300:450 K by steps of 3 K) in the NVT ensemble,  
7 using an integration step of 20 fs and over a period of 5 ns. The final production step  
8 was performed in the NPT ensemble, using an integration step of 20 fs and was stopped  
9 after 20  $\mu$ s. During production, Replica-Exchange MD (REMD) was used to improve the  
10 sampling of all possible configurations of the peptide:receptor complex. The potential  
11 energy difference of adjacent replicas was computed every 1000 steps (20 ps) and their  
12 coordinates were exchanged according to a Boltzmann criterion. With the used  
13 parameters, the probability of exchange between adjacent replica was in the range 0.11  
14 (300K):0.23(450K). Three independent CG-REMD simulations were run to verify the  
15 convergence of the obtained models, together representing a cumulated sampling time  
16 of  $\sim$ 3 ms (**Supplementary Fig. 5**). For each of these simulations, a clustering was  
17 performed on all conformations of the peptide:receptor complex obtained at the lowest  
18 temperature (300 K). To do so, we first concatenated the data corresponding to the four  
19 possible complexes (peptide1:receptor1, peptide1:receptor2, peptide2:receptor1 and  
20 peptide2:receptor2). For that step, only the conformations displaying at least one  
21 peptide:receptor contact were kept (a contact was defined using a cut-off distance of 7  
22 Å). For clustering, we used the algorithm of Daura *et al.*<sup>57</sup> with a RMSD cut-off of 3.0 Å.  
23 The RMSD was computed only on the backbone beads of the peptide's residues 1 to 6  
24 after structural fit onto those of the V2R. The two cysteines side-chains beads were also

1 included for RMSD calculations. All simulations and analyzes were performed with the  
2 Gromacs software (version 5)<sup>58</sup>. Figures were produced with VMD<sup>59</sup>.

### 3 *Refinement of the obtained CG-models in the cryo-EM maps*

4 The Correlation-Driven Molecular Dynamics (CDMD) method<sup>60</sup> was employed to refine  
5 the most populated clusters obtained in CG-REMD using the L state cryo-EM map of the  
6 AVP-V2-Gs-Nb35 complex. The principle of the method is to use an accurate force field  
7 and thermodynamic sampling to improve the real-space correlation between the  
8 modeled structure and the cryo-EM maps. Before this refinement step, the Gs  
9 heterotrimer and the Nb35 were modeled using the structure of the  $\beta$ 2AR-Gs-Nb35  
10 complex<sup>40</sup> as a reference. The MARTINI force field restrained the internal conformations  
11 of the different partners with an internal elastic network. To increase significantly the  
12 conformational plasticity of the receptor and explore new conformations specific to the  
13 V2R, we modified its default elastic network. We automatically deleted the “long-range”  
14 springs involving two beads whose indexes differ by at least 15. This contributed to  
15 delete all inter-helices springs. The resulting elastic network used at this step for the  
16 receptor is reported in **Supplementary Fig. 4**. The standard elastic network was  
17 conserved for all other partners including the AVP peptide, the G protein and the Nb35.  
18 No inter-chains springs were included for the G protein. After conversion of Gs and  
19 Nb35 into the CG model, the two proteins were placed at a rational position in respect to  
20 the V2R using the  $\beta$ 2AR-Gs-Nb35 complex<sup>40</sup>. The full system was inserted in a larger  
21 membrane (150x150 Å<sup>2</sup>) and solvated on each side for further calculations.

22 The fit in each cryo-EM maps was performed in four successive steps summarized in  
23 **Supplementary Fig. 6**. First, a quick energy minimization (2000 steps of conjugate  
24 gradient) was performed on the full system without taking the map into account. This  
25 step was dedicated to the removal of bad contacts resulting from the addition of Gs and

1 Nb35 proteins. Then the second step consisted in a first equilibration of 5 ns (10 fs time-  
2 step; NVT; 300 K) performed with CDMD and using a constant targeted low resolution of  
3 5 Å together with a strength constant of 10000 kJ.mol<sup>-1</sup> for the map potential. This bias  
4 was applied only to the backbone beads of the system. This step was useful to quickly  
5 optimize the alignment of the system with the targeted map. During this second step, an  
6 additional force of 50000 kJ.mol<sup>-1</sup>.nm<sup>-2</sup> was added to keep the distance between the two  
7 centers of masses (COMs) of both the peptide and surrounding residues of the receptor  
8 close to its initial value. This force prevented a quick motion of the AVP peptide in the  
9 first steps of the simulation that resulted from large forces applying to the receptor. For  
10 the subsequent steps of the fitting procedure, this additional force on COMs was  
11 removed. During the step 3 (30 ns), the same MD parameters were used but with a  
12 gradual increase of both the resolution (from 5 to 3 Å) and the strength constant (from  
13 10000 to 50000 KJ.mol<sup>-1</sup>), over a period of 25 ns. During the last 5 ns these values were  
14 kept constant. This step was the key step allowing the whole system to adapt and fit to  
15 the maps. Finally, the last step (10 ns) consisted in keeping the resolution and the  
16 strength constant at their reached values (3 Å; 50000 KJ.mol<sup>-1</sup>), but this time applying  
17 the force only to the backbone and side-chain beads of the peptide. All the other  
18 backbone beads of the system were restrained in positions during this step with a force  
19 constant of 5000 KJ.mol<sup>-1</sup>. This step was useful to refine the position of the peptide in the  
20 density, especially of its side-chains. For every step of the fitting procedure, the fit of  
21 each cluster was performed 5 times to verify the convergence of the obtained models  
22 **(Supplementary Fig. 7).**

23

24 *All-atom refinement of the models in the maps*

1 The CG-models obtained from the fitting procedure were back-mapped to a full-atom  
2 representation. We used the standard “initram” procedure provided by the developers  
3 of Martini<sup>61</sup> with subtle changes. These changes concerned restrains on omega angles  
4 and C $\alpha$ -positions for all chains (V2R, Gs, Nb-35), to keep omega angles in trans  
5 conformation and avoid large backbone motions which inevitably would lead to models  
6 out of cryo-EM maps. Those restrains were added during the minimization and the MD  
7 simulations inherent to the default “initram” procedure. In practice, the “initram”  
8 procedure was as follow: 1/ after the very raw guess of atomic positions, from CG-beads,  
9 done by the “initram” script, 2/ the Charmm36 force field<sup>62</sup> was used for 10000 steps of  
10 steepest descent disabling the non-bonded terms, 3/ followed by 5000 steps of steepest  
11 descent including all terms of the force field, and finally 4/ 300 steps of MD were  
12 performed. Except the number of steps, the parameters for minimization and MD  
13 simulations were set as default from the “initram” procedure. Minimization and MD  
14 simulations were performed using the Gromacs package<sup>58</sup>.  
15 As a final step, iterative manual adjustments were carried out in COOT<sup>63</sup>, and real space  
16 refinement using Phenix programs<sup>64</sup>. The model statistics were validated using  
17 Molprobit<sup>65</sup>.

18

### 19 **Classical all-atom molecular dynamics simulations**

20 The L state cryoEM structure was subjected to molecular dynamics simulations (MDS).  
21 The procedure is described in Supplementary Methods.

22

### 23 **NMR data analysis**

24 The purified V2R was prepared either in neutral amphipol (NAPol)<sup>66,67</sup> or in LMNG  
25 detergent. In both cases, the V2R was expressed in Sf9 insect cells and purified as

1 described above, except it was cleaved overnight at 4°C using the HRV3C protease at a  
2 1:20 weight ratio (HRV3C:V2R) before concentration and purification by SEC.  
3 1D STD NMR spectra<sup>68</sup> were recorded either on a mixture of AVP with V2R (400  
4 μM:2 μM), or on AVP (**Supplementary Fig. 8**). Selective methyl resonance saturation  
5 was achieved by equally spaced 60 ms Gaussian 180° pulses separated by 1 ms delay at  
6 0 ppm (-50 ppm for reference spectra) at 274K and 283K. An irradiation test was  
7 performed on a free peptide sample (400 μM) to verify that only V2R resonances were  
8 irradiated. Subtraction of free induction decay with on- and off-resonance protein  
9 saturation was achieved by phase cycling. A relaxation delay of 2.6s (Aq+D1) and 128  
10 dummy scans were employed to reduce subtraction artifacts. Investigation of the time  
11 dependence of the saturation transfer from 0.5 to 4 s with equally spaced 50-ms  
12 Gaussian shaped pulses (separated by a 1-ms delay) showed that 2 s was needed for  
13 efficient transfer of saturation from V2R to the AVP. A T1ρ filter of 30 ms was applied to  
14 eliminate background resonances of V2R. The transient number was typically 4k. To  
15 determine the specificity of STD signals, similar samples were prepared with the  
16 antagonist TVP as competitor, using 3 μM V2R, 80 μM AVP and 550 μM TVP. The STD  
17 effect was then calculated as  $(I_0 - I_{\text{sat}})/I_0$  where  $I_0$  and  $I_{\text{sat}}$  are the intensities of one signal  
18 in the reference NMR spectrum and in the on-resonance spectrum, respectively.  
19 We discriminated the different molecular models issued from CG-MD simulations by  
20 comparing the experimental STD values and the expected simulated STD from model  
21 structures. Back calculation of STD intensities were calculated with the 3.8 version of  
22 CORCEMA-ST software<sup>69</sup>. An order parameter value of 0.85 for methyl groups, and a Kon  
23 value of a  $10^8 \text{ s}^{-1}$  value were used. The correlation times were set to 0.5 and 40 ns for the  
24 free and bound states respectively. Calculations with different correlation time values  
25 exploring the 0.2-2 ns and 10-30 ns for the free and bound forms, respectively, showed

1 that the simulated profiles, and in particular the correlation coefficient between  
2 calculated and experimental values, were much more dependent on the template model  
3 than on the correlation time values. Coefficient correlations between simulated and  
4 experimental values were calculated for the whole peptide (residues 1-9). Mean  
5 correlations factors  $R_{1-9}$  were calculated for five representative structures of each  
6 cluster.

7

### 8 **TR-FRET binding assays**

9 V2R binding studies using TagLite® assays (Cisbio, Codolet, France) based on time-  
10 resolved-FRET measurements were previously described<sup>70,71</sup>. These are detailed in  
11 Supplementary Methods.

12

### 13 **cAMP accumulation assays**

14 As for V2R binding studies, V2R functional studies based on time-resolved FRET  
15 measurements were described previously<sup>39,26</sup>. These are detailed in Supplementary  
16 Methods.

### 18 **Data Availability**

19 The cryo-EM density maps for the AVP-V2R-Gs-Nb35 complex have been deposited in  
20 the Electron Microscopy Data Bank (EMDB) under accession code EMD-12128 (L state)  
21 and EMD-12129 (T state). The coordinates for the models of AVP-V2R-Gs-Nb35 complex  
22 have been deposited in the PDB under accession numbers 7BB6 and 7BB7 (L and T  
23 states, respectively). We declare that the data supporting findings for this study are all





The full system (centre) used for the CG-REMD simulations included two receptors and two peptides in order to create an artificial extracellular compartment and improve the conformational sampling. **b)** 10 most populated clusters obtained for the AVP-V2R complex after the 3 independent CG-REMD simulations. The upper parts of TM 6 and TM7 of V2R were removed for clarity. The 10 clusters describe 67.5% of the whole conformations analysed in the procedure. **c)** schematic representation of the successive steps employing the CDMD method to fit the models resulting from the CG-REMD simulations into the L cryo-EM map of the AVP-V2R-Gs-Nb35 complex. **d)** Mapping AVP contact surface by experimental STD NMR. The STD effect profile (in %) is shown as a function of AVP protons (aliphatic, N (backbone), aromatic). Intense STD signals were only observed in the presence of V2R, mostly for the aromatic protons of Tyr<sup>2</sup> and Phe<sup>3</sup> (and to a lesser extent of Cys<sup>1</sup>) residues of AVP. **e)** Cross-correlation between computational and STD NMR. First, variability of the position of AVP was calculated as mean RMSD values (in Å) after cross-comparison of models (5 for each cluster) resulting from the fitting procedure of each of the 10 clusters in the L density map. Cluster 5 showed the smaller variability (2.2 Å). Second, experimental STD values were compared to the expected STD values from all-atom models issued from MD simulations and correlation coefficients were calculated for the whole peptide ( $R_{1-9}$ ). Cluster 5 appeared as the best cluster fitting to experimental STD values. **f)** Remapping into the L density map. Based on cluster 5, the final L model was then built in a more conventional manner to match as closely as possible the L density map. **g)** Based on the L model, the T model was built to match the T density map.




**Figure 2 | Structures of AVP-V2R-Gs-Nb35 complexes in L and T conformations.**

**Figure 3 | AVP Binding site of the V2R, comparison with retosiban binding site in OTR.**




**Fig. 3| AVP binding site of the V2R, comparison with retosiban binding site in OTR.**

All TM helices and extracellular loop 2 and 3 interact with the hormone AVP. V2R residues are labeled according to the Ballesteros-Weinstein numbering. AVP binding modes in the L (pink) and T (light blue) structures, are compared to that of the small molecule antagonist retosiban in the OTR structure (green), all viewed from TM3. yellow for hydrophobic, green for polar, red and dark blue for negatively and positively charged, respectively. **c)** Side views of the binding pockets after a 180° rotation. The peptide agonist and the nonpeptide antagonist are superimposed after alignment of V2R and OTR structures. The most hydrophobic parts of both ligands superimpose at the bottom of the orthosteric binding pocket. **e)** Structure comparison of AVP and retosiban. AVP is shown using the same color code than in pannel a. The retosiban indanyl moiety, the sec-butyl group, and the oxazol-morpholine amide moiety superimpose with AVP Tyr2, Phe3 and Gln4 respectively. The retosiban 2,5-diketopiperazine core is positioned between AVP Tyr2 and Phe3.


**Figure 4 | Active conformations of L and T V2R states, comparison with inactive structure of OTR and active/inactive structures of  $\beta$ 2AR.**




### Fig. 5| Interface of the V2R T state with Gs.



# Extended Data Figure 1 | Overview of AVP-V2R-Gs-Nb35 complex preparation and purification.








Extended Data Figure 4 | Flexibility in the AVP-V2R-Gs-Nb35 complex.





**a** V2R L state




**b** V2R T state




