# CONVERGENCE AND ALMOST SURE PROPERTIES IN HARDY SPACES OF DIRICHLET SERIES 

FRÉDÉRIC BAYART


#### Abstract

Given a frequency $\lambda$, we study general Dirichlet series $\sum a_{n} e^{-\lambda_{n} s}$. First, we give a new condition on $\lambda$ which ensures that a somewhere convergent Dirichlet series defining a bounded holomorphic function in the right half-plane converges uniformly in this half-plane, improving classical results of Bohr and Landau. Then, following recent works of Defant and Schoolmann, we investigate Hardy spaces of these Dirichlet series. We get general results on almost sure convergence which have an harmonic analysis flavour. Nevertheless, we also exhibit examples showing that it seems hard to get general results on these spaces as spaces of holomorphic functions.


## 1. Introduction

1.1. $\lambda$-Dirichlet series and their convergence. A general Dirichlet series is a series $\sum_{n} a_{n} e^{-\lambda_{n} s}$ where $\left(a_{n}\right) \subset \mathbb{C}^{\mathbb{N}}, s \in \mathbb{C}$ and $\lambda=\left(\lambda_{n}\right)$ is an increasing sequence of nonnegative real numbers tending to $+\infty$, called a frequency. We shall denote by $\mathcal{D}(\lambda)$ the space of all formal $\lambda$-Dirichlet series. The two most natural examples are $\left(\lambda_{n}\right)=(n)$ which gives rise to power series and $\left(\lambda_{n}\right)=(\log n)$, the case of ordinary Dirichlet series. A proeminent problem at the beginning of the twentieth century was the study of the convergence of these series, starting from the following theorem of Bohr [5] on ordinary Dirichlet series: let $D=\sum_{n} a_{n} n^{-s}$ be a somewhere convergent ordinary Dirichlet series having a holomorphic and bounded extension to the half-plane $\mathbb{C}_{0}$. Then $D$ converges uniformly on each halfplace $\mathbb{C}_{\varepsilon}$ for all $\varepsilon>0$. Here, $\mathbb{C}_{\theta}$ means the right half-plane $[\operatorname{Res}>\theta]$.
An important effort was done to extend this result to general frequencies. Two sufficient conditions were isolated firstly by Bohr [5] and then by Landau [19]. Following the terminology of [21], we say that a frequency satisfies (BC) provided

\exists \ell>0, \exists C>0, \forall n \in \mathbb{N}, \lambda_{n+1}-\lambda_{n} \geq C e^{-\ell \lambda_{n}} . \tag{BC}
\end{equation*}
$$

A frequency $\lambda$ satisfies (LC) provided

$$
\begin{equation*}
\forall \delta>0, \exists C>0, \forall n \in \mathbb{N}, \lambda_{n+1}-\lambda_{n} \geq C e^{-e^{\delta \lambda_{n}}} \tag{LC}
\end{equation*}
$$

Of course, (BC) is a stronger condition than (LC), and Landau has shown that any frequency satisfying (LC) verifies Bohr's theorem: all Dirichlet series $D=\sum_{n} a_{n} e^{-\lambda_{n} s}$

[^0]belonging to $\mathcal{D}_{\infty}^{\text {ext }}(\lambda)$, the space of somewhere convergent $\lambda$-Dirichlet series which allow a holomorphic and bounded extension to $\mathbb{C}_{0}$, converge uniformly to $\mathbb{C}_{\varepsilon}$, for all $\varepsilon>0$.
This problem was studied again recently in [7] and [21] in connection with Banach spaces of Dirichlet series and quantitative estimates. Define by $\mathcal{D}_{\infty}(\lambda)$ the subspace of $\mathcal{D}_{\infty}^{\text {ext }}(\lambda)$ of Dirichet series which converge on $\mathbb{C}_{0}$ (in general, $\mathcal{D}_{\infty}(\lambda)$ can be a proper subspace of $\mathcal{D}_{\infty}^{\text {ext }}(\lambda)$ if $\lambda$ does not satisfy Bohr's theorem) and define $S_{N}: \mathcal{D}_{\infty}^{\text {ext }}(\lambda) \rightarrow \mathcal{D}_{\infty}(\lambda)$, $\sum_{1}^{+\infty} a_{n} e^{-\lambda_{n} s} \mapsto \sum_{1}^{N} a_{n} e^{-\lambda_{n} s}$ the $N$-th partial sum operator. In [21], a thorough study of the norm of $S_{N}$ is done (the case of ordinary Dirichlet series was settled in [1]), leading to consequences on the existence of a Montel's theorem in $\mathcal{D}_{\infty}^{\text {ext }}(\lambda)$ or on the completeness of $\mathcal{D}_{\infty}(\lambda)$.
Our first main result is an extension of the results of [5, 19, 21]: we provide a new class of frequencies, that we will call (NC) (see Definition 2.2) such that Bohr's theorem, and all its consequences, are true. Like (BC) or (LC), this class of frequencies quantifies how fast $\lambda$ goes to $+\infty$ and how close its terms are, but in a less demanding way since (NC) is strictly weaker than (LC).
Our method of proof also differs from that of [21]. In [21], the estimation of $\left\|S_{N}\right\|$ is based on Riesz means of $\lambda$-Dirichlet polynomials: recall that for a sequence of complex numbers $\left(c_{n}\right)$ and for $k>0$, the finite sum
$$
R_{x}^{\lambda, k}\left(\sum_{n} c_{n}\right):=\sum_{\lambda_{n}<x}\left(1-\frac{\lambda_{n}}{x}\right)^{k} c_{n}
$$
is called the first $(\lambda, k)$-Riesz mean of $\sum_{n} c_{n}$ of length $x>0$. I. Schoolmann uses approximation of $D$ by $R_{x}^{\lambda, k}(D)$ for a suitable choice of $k$ to deduce its result on $\left\|S_{N}\right\|$. Our alternate approach is based on mollifiers and on a formula of convolution due to Saksman for ordinary Dirichlet series.
1.2. Hardy spaces of $\lambda$-Dirichlet series: Banach spaces and harmonic analysis. Our second approach deals with Hardy spaces of Dirichlet series. For ordinary Dirichlet series, they have been introduced and studied in [15] (see also [1]) and this has caused an important renew of interest for this subject. The general case has been introduced and investigated very recently in $[10,12,11]$. For $p \in[1,+\infty)$, the Hardy space $\mathcal{H}_{p}(\lambda)$ may be defined as follows: given a $\lambda$-Dirichlet polynomial $D=\sum_{n=1}^{N} a_{n} e^{-\lambda_{n} s}$, define its $\mathcal{H}_{p}$-norm by
$$
\|D\|_{p}^{p}:=\lim _{T \rightarrow+\infty} \frac{1}{2 T} \int_{-T}^{T}|D(i t)|^{p} d t
$$

Then $\mathcal{H}_{p}(\lambda)$ is the completion of the set of $\lambda$-Dirichlet polynomials for this norm. However, this internal description is often not sufficient to get the main properties of $\mathcal{H}_{p}(\lambda)$ and we need a group approach. Let $G$ be a compact abelian group and let $\beta:(\mathbb{R},+) \rightarrow G$ be a continuous homomorphism with dense range. Then we say that $(G, \beta)$ is a $\lambda$-Dirichlet group provided, for all $n \in \mathbb{N}$, there exists $h_{\lambda_{n}} \in \hat{G}$ such that $h_{\lambda_{n}} \circ \beta=e^{-i \lambda_{n}}$. The space $H_{p}^{\lambda}(G), p \in[1,+\infty]$ is then defined as the subspace of $L^{p}(G)$ of functions $f$ such that
$\operatorname{supp}(\hat{f}) \subset\left\{h_{\lambda_{n}}: n \in \mathbb{N}\right\}$. Now define the Bohr map $\mathcal{B}$ by

$$
\begin{aligned}
\mathcal{B}: H_{p}^{\lambda}(G) & \rightarrow \mathcal{D}(\lambda) \\
f & \mapsto \sum \hat{f}\left(h_{\lambda_{n}}\right) e^{-\lambda_{n} s}
\end{aligned}
$$

and set $\mathcal{H}_{p}(\lambda)=\mathcal{B}\left(H_{p}^{\lambda}(G)\right)$ with $\|\mathcal{B} f\|_{p}:=\|f\|_{p}$. Then it has been shown in [10] that

- given a frequency $\lambda$, there always exists a $\lambda$-Dirichlet group $(G, \beta)$;
- the Hardy space $\mathcal{H}_{p}(\lambda)$ does not depend on the choosen $\lambda$-Dirichlet group;
- when $p \neq+\infty$, it coincides with $\mathcal{H}_{p}(\lambda)$ defined internally.

Our second aim in this paper is solve some of the problems on the spaces $\mathcal{H}_{p}(\lambda)$ raised in [9] and to exhibit new properties of them. In particular, we investigate properties of $\mathcal{H}_{p}(\lambda)$ coming from functional analysis and harmonic analysis.
As an example, let us discuss a famous therorem of Helson [17] which ensures, in our terminology, that if $\lambda$ satisfies (BC) and $D=\sum_{n} a_{n} e^{-\lambda_{n} s}$ belongs to $\mathcal{H}_{2}(\lambda)$, then for almost all homomorphisms $\omega:(\mathbb{R},+) \rightarrow \mathbb{T}$, the Dirichlet series $\sum_{n} a_{n} \omega\left(\lambda_{n}\right) e^{-\lambda_{n} s}$ converges on $\mathbb{C}_{0}$. This has been extended to the Hardy spaces $\mathcal{H}_{p}((\log n))$ for $p \geq 1$ by Bayart in [1] and this result is at the heart of many further investigations on these spaces (e.g. composition operators, Volterra operators). Therefore, it is a challenge to put it in the general framework of $\mathcal{H}_{p}(\lambda)$ or, equivalenty - via the Bohr transform - of $H_{p}^{\lambda}(G)$. When $\lambda$ satisfies (BC), this has been done in [12], adding moreover the maximal inequality.

Theorem A (Defant-Schoolmann). Let $\lambda$ satisfy ( $B C$ ), let $(G, \beta)$ be a $\lambda$-Dirichlet group. For every $u>0$, there exists a constant $C:=C(u, \lambda)$ such that, for all $1 \leq p \leq+\infty$ and for all $f \in H_{p}^{\lambda}(G)$,

$$
\begin{equation*}
\left\|\sup _{\sigma \geq u} \sup _{N}\left|\sum_{n=1}^{N} \hat{f}\left(h_{\lambda_{n}}\right) e^{-\sigma \lambda_{n}} h_{\lambda_{n}}\right|\right\|_{p} \leq C\|f\|_{p} . \tag{1}
\end{equation*}
$$

In particular, for every $u>0, \sum_{1}^{+\infty} \hat{f}\left(h_{\lambda_{n}}\right) e^{-u \lambda_{n}} h_{\lambda_{n}}$ converges almost everywhere on $G$.
When $\lambda$ satisfies (LC), the almost everywhere statement is known to be true, as well as the maximal inequality for $p>1$ with a constant now depending on $p$. When $p=1$, it is valid if we replace the $L_{1}(G)$-norm by the weak $L_{1}(G)$-norm. We shall prove that inequality (1) remains true even on the weaker assumption that $\lambda$ satisfies (NC), even for $p=1$, and with a constant independent of $p$. Our approach, which seems less technical than that of [12], is based again on a version of Saksman's convolution formula and on a Carleson-Hunt type maximal inequality of independent interest.
1.3. $\mathcal{H}_{p}(\lambda)$ as a Banach space of holomorphic functions. The results announced in the previous section indicate that the spaces $\mathcal{H}_{p}(\lambda)$ seem to behave well if we look at their almost sure properties. The classical case $\mathcal{H}_{p}((\log n))$ was also investigated as a Banach space of holomorphic function. Even in that case, it is a nontrivial problem to determine the optimal half-plane of convergence of elements in $\mathcal{H}_{p}(\lambda)$, namely to compute

$$
\sigma_{\mathcal{H}_{p}(\lambda)}:=\inf \left\{\sigma \in \mathbb{R}: \sigma_{c}(D) \leq \sigma \text { for all } D \in \mathcal{H}_{p}(\lambda)\right\}
$$

where, for a Dirichlet series $D \in \mathcal{D}(\lambda), \sigma_{c}(D):=\inf \left\{\sigma \in \mathbb{R}: D\right.$ converges on $\left.\mathbb{C}_{\sigma}\right\}$. This has been settled in [1], using that $\sigma_{\mathcal{H}_{2}((\log n))}=1 / 2$ (easy by the Cauchy-Schwarz inequality) and that $T_{\sigma}\left(\sum_{n} a_{n} e^{-\lambda s}\right)=\sum_{n} a_{n} e^{-\sigma \lambda_{n}} e^{-\lambda_{n} s}$ maps $\mathcal{H}_{p}((\log n))$ into $\mathcal{H}_{q}((\log n))$ for all $p, q \in[1,+\infty)$ and all $\sigma>0$. The argument is based on multiplicativity (namely on the fact that the natural $\lambda$-Dirichlet group for $(\log n)$ is the infinite polytorus $\left.\mathbb{T}^{\infty}\right)$ and on a hypercontractive estimate for the Poisson kernel acting on the Hardy spaces $H^{p}(\mathbb{T})$ of the disk.
We will show that there is no hope to get such a result for general frequencies $\lambda$ even if they satisfy (BC). For instance, if we will be able to prove that for all frequencies $\sigma_{\mathcal{H}_{1}(\lambda)} \leq 2 \sigma_{\mathcal{H}_{2}(\lambda)}$, we will nevertheless point out that, even if we assume (BC), this is optimal and in particulat that we may have $\sigma_{\mathcal{H}_{1}(\lambda)}>\sigma_{\mathcal{H}_{2}(\lambda)}$. We will also exhibit a sequence $\lambda$, which still satisfies (BC), such that $T_{\sigma}$ maps boundedly $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$ if and only if $\sigma \geq(k-1) / 2 k$. In particular, it seems very hard to compute $\sigma_{\mathcal{H}_{p}(\lambda)}$ in the general case and the behaviour of $\mathcal{H}_{p}(\lambda)$ as a space of holomorphic function seems more difficult to predict if we assume only growth and separation conditions on $\lambda$.
1.4. Notations. Throughout this work, we shall use the following notations. For $\lambda$ a frequency and $D \in \mathcal{D}(\lambda)$, the abscissa of absolute convergence of $D$ and the abscissa of uniform convergence of $D$ are defined by

$$
\begin{aligned}
& \sigma_{a}(D):=\inf \left\{\sigma \in \mathbb{R}: D \text { converges absolutely on } \mathbb{C}_{\sigma}\right\} \\
& \sigma_{u}(D):=\inf \left\{\sigma \in \mathbb{R}: D \text { converges uniformly on } \mathbb{C}_{\sigma}\right\} .
\end{aligned}
$$

We set

$$
\begin{aligned}
L(\lambda) & :=\limsup _{N \rightarrow+\infty} \frac{\log N}{\lambda_{N}} \\
& =\sup _{D \in \mathcal{D}(\lambda)} \sigma_{a}(D)-\sigma_{c}(D)
\end{aligned}
$$

Given $(G, \beta)$ a $\lambda$-Dirichlet group we shall denote by $\operatorname{Pol}_{\lambda}(G)$ the set of polynomials with spectrum in $\lambda$, namely finite sums $\sum_{k=1}^{n} a_{k} h_{\lambda_{k}}$ with $\lambda_{k} \in G$ for each $k=1, \ldots, n$. We shall also use the following result: for all $f: G \rightarrow \mathbb{C}$ measurable, for almost all $\omega \in G$, the function $f_{\omega}:=f(\omega \beta(\cdot)): \mathbb{R} \rightarrow \mathbb{C}$ is measurable. If additionally $f \in L_{\infty}(G)$, then for almost all $\omega \in G, f_{\omega} \in L_{\infty}(\mathbb{R})$ with $\left\|f_{\omega}\right\|_{\infty} \leq\|f\|_{\infty}$. Moreover, if $f \in L_{1}(G)$, then $f_{\omega}$ is locally integrable for almost all $\omega \in G$, and for $g \in L_{1}(\mathbb{R})$, the convolution

$$
g \star f_{\omega}(t):=\int_{\mathbb{R}} f(\omega \beta(t-y)) g(y) d y
$$

is almost everywhere defined on $\mathbb{R}$ and measurable (see [10, Lemma 3.11]).

## 2. Preliminaries

2.1. A new class of frequencies. We introduce our new condition, more general than (LC), under which most of our results will be satisfied. We first reformulate (LC).
Lemma 2.1. A frequency $\lambda$ satisfies $(L C)$ if and only if there exists $C>0$ such that, for all $\delta>0$, for all $n \in \mathbb{N}$,

$$
\log \left(\frac{\lambda_{n+1}+\lambda_{n}}{\lambda_{n+1}-\lambda_{n}}\right) \leq C e^{\delta \lambda_{n}}
$$

Proof. Assume first that $\lambda$ satisfies (LC) and let $\delta>0$. Then there exists $C>0$ such that, for all $n \in \mathbb{N}, \lambda_{n+1}-\lambda_{n} \geq C e^{-e^{\frac{\delta}{2} \lambda_{n}}}$. Let $n \in \mathbb{N}$ and set $\xi_{n}=\lambda_{n}+C e^{-e^{\frac{\delta}{2} \lambda_{n}}}$. Since the function $x \mapsto\left(x+\lambda_{n}\right) /\left(x-\lambda_{n}\right)$ is decreasing on $\left(\lambda_{n},+\infty\right)$, one gets

$$
\begin{aligned}
\frac{\lambda_{n+1}+\lambda_{n}}{\lambda_{n+1}-\lambda_{n}} & \leq \frac{\xi_{n}+\lambda_{n}}{\xi_{n}-\lambda_{n}} \\
& \leq C^{-1}\left(2 \lambda_{n}+C e^{-e^{\frac{\delta}{2} \lambda_{n}}}\right) e^{e^{\frac{\delta}{2} \lambda_{n}}} \\
& \leq C^{\prime} e^{e^{\delta \lambda_{n}}}
\end{aligned}
$$

The converse implication is easier and left to the reader.
The main idea to introduce (NC) is to allow to compare the position of $\lambda_{n}$ with $\lambda_{m}$ for some $m>n$ and not only with $\lambda_{n+1}$.

Definition 2.2. We say that a frequency $\lambda$ satisfies (NC) if, for all $\delta>0$, there exists $C>0$ such that, for all $n \geq 1$, there exists $m>n$ such that

$$
\begin{equation*}
\log \left(\frac{\lambda_{m}+\lambda_{n}}{\lambda_{m}-\lambda_{n}}\right)+(m-n) \leq C e^{\delta \lambda_{n}} \tag{NC}
\end{equation*}
$$

Condition (NC) provides a nontrivial extension of (LC).
Example 2.3. Let $\lambda$ be defined by $\lambda_{2^{n}+k}=n^{2}+k e^{-e^{n^{2}}}$ for $k=0, \ldots, 2^{n}-1$. Then $L(\lambda)=+\infty, \lambda$ satisfies (NC) and $\lambda$ is not the finite union of frequencies satisfying (LC).

Proof. Let $\delta>0, n \in \mathbb{N}, k \in\left\{0, \ldots, 2^{n}-1\right\}$, then provided $n$ is large enough

$$
\begin{aligned}
\log \left(\frac{\lambda_{2^{n+1}}+\lambda_{2^{n}+k}}{\lambda_{2^{n+1}}-\lambda_{2^{n}+k}}\right)+\left(2^{n+1}-2^{n}-k\right) & \leq \log \left(2(n+1)^{2}\right)+2^{n} \\
& \leq C e^{\delta n^{2}} \\
& \leq C e^{\delta \lambda_{2^{n}+k}}
\end{aligned}
$$

for some $C>0$. Moreover, if $\lambda$ was the finite union of $\lambda^{1}, \ldots, \lambda^{p}$, each $\lambda^{j}$ satisfying (LC), then at least one of the $\lambda^{j}$, say $\lambda^{1}$, will contain an infinite number of consecutive terms $\lambda_{m}^{1}=\lambda_{2^{n}+k}, \lambda_{m+1}^{1}=\lambda_{2^{n}+k^{\prime}}$ with $1 \leq k^{\prime}-k \leq p$ and $k, k^{\prime} \in\left\{0, \ldots, 2^{n}-1\right\}$. For these $m$,

$$
\log \left(\frac{\lambda_{m+1}^{1}+\lambda_{m}^{1}}{\lambda_{m+1}^{1}-\lambda_{m}^{1}}\right) \geq e^{n^{2}}-\log p \geq C e^{\lambda_{m}^{1} / 2}
$$

contradicting that $\lambda^{1}$ satisfies (LC).
2.2. Saksman's vertical convolution formula. Saksman's vertical convolution formula was introduced to express weighted sums of ordinary Dirichlet series using an integral. It says essentially that if $D=\sum_{n} a_{n} n^{-s}$ is an ordinary Dirichlet series and $\psi$ is in $L^{1}$ with $\hat{\psi}$ compactly supported, then

$$
\sum_{n=1}^{+\infty} a_{n} \hat{\psi}(\log n) n^{-s}=\int_{\mathbb{R}} D(s+i t) \psi(t) d t
$$

with a sense that has to be made precise. It was used in [4] for Dirichlet series in $\mathcal{H}_{1}$ and in [20] for Dirichlet series in $\mathcal{H}_{\infty}$. We shall extend it to general Dirichlet series and we will use it as a much more flexible substitute of Perron's formula.

Theorem 2.4. Let $\psi \in L^{1}(\mathbb{R})$ be such that $\hat{\psi}$ is compactly supported and let $\lambda$ be a frequency with $(G, \beta)$ an associated $\lambda$-Dirichlet group.
(a) Let $D=\sum_{n} a_{n} e^{-\lambda_{n} s} \in \mathcal{D}_{\infty}^{e x t}(\lambda)$ with bounded and holomorphic extension to $\mathbb{C}_{0}$ denoted by $f$. Then for all $s \in \mathbb{C}$ with $\Re e(s)>0$

$$
\sum_{n=1}^{+\infty} a_{n} \hat{\psi}\left(\lambda_{n}\right) e^{-\lambda_{n} s}=\int_{\mathbb{R}} f(s+i t) \psi(t) d t
$$

(b) Let $f=\sum_{n} a_{n} h_{\lambda_{n}} \in H_{1}^{\lambda}(G)$. Then for almost all $\omega \in G$,

$$
\sum_{n=1}^{+\infty} a_{n} \hat{\psi}\left(\lambda_{n}\right) h_{\lambda_{n}}(\omega)=\int_{\mathbb{R}} f_{\omega}(t) \psi(t) d t
$$

In the sequel, for $D=\sum_{n} a_{n} e^{-\lambda_{n} s} \in \mathcal{D}_{\infty}^{\operatorname{ext}}(\lambda)$, respectively for $f=\sum_{n} a_{n} h_{\lambda_{n}}$ in $H_{1}^{\lambda}(G)$, and for $\psi \in L^{1}(\mathbb{R})$ compactly supported, we shall denote

$$
\begin{aligned}
R_{\psi}(D) & :=\sum_{n} a_{n} \hat{\psi}\left(\lambda_{n}\right) e^{-\lambda_{n} s} \\
R_{\psi}(f) & :=\sum_{n} a_{n} \hat{\psi}\left(\lambda_{n}\right) h_{\lambda_{n}}
\end{aligned}
$$

Proof. (a) Observe first that the equality is true provided $D$ is a Dirichlet polynomial and that the two members of the equality define an analytic function on $\mathbb{C}_{0}$. Assume first that $L(\lambda)<+\infty$. Then $\sigma_{a}(D)<+\infty$ and for $s>\sigma_{a}(D)$, the formula is true just by exchanging the sum and the integral. We conclude by analytic continuation.
When $L(\lambda)=+\infty$, the proof is more difficult. We use (see [14, Theorem 41 p. 53] or [18, Theorem 22]) that there exist a half-plane $\mathbb{C}_{\theta}, \theta>0$, and a sequence of $\lambda$-Dirichlet polynomials $D_{j}=\sum_{n=1}^{+\infty} a_{n}^{j} e^{-\lambda_{n} s}$ such that $\left(a_{n}^{j}\right)$ tends to $a_{n}$ as $j$ tends to $+\infty$ for any $n$ and $\left(D_{j}\right)$ converges uniformly to $f$ on $\mathbb{C}_{\theta}$. Since each $D_{j}$ is a Dirichlet polynomial, we know that for all $s \in \mathbb{C}_{\theta}$ and all $j \in \mathbb{N}$,

$$
\sum_{n=1}^{+\infty} a_{n}^{j} \hat{\psi}\left(\lambda_{n}\right) e^{-\lambda_{n} s}=\int_{\mathbb{R}} D_{j}(s+i t) \psi(t) d t
$$

Letting $j$ to $+\infty$ in the previous inequality for a fixed $s \in \mathbb{C}_{\theta}$, since the sum on the left handside is finite ( $\hat{\psi}$ has compact support), and by uniform convergence, we get the result on $\mathbb{C}_{\theta}$. We conclude again by analytic continuation.
(b) When $f \in \operatorname{Pol}_{\lambda}(G)$, the equality follows immediately by interverting a finite sum and
an integral, and the definition of the objects that come into play:

$$
\begin{aligned}
R_{\psi}(f)(\omega) & =\int_{\mathbb{R}} \sum_{n} a_{n} e^{-i t \lambda_{n}} \psi(t) h_{\lambda_{n}}(\omega) d t \\
& =\int_{\mathbb{R}} \sum_{n} a_{n} h_{\lambda_{n}}(\beta(t)) h_{\lambda_{n}}(\omega) \psi(t) d t \\
& =\int_{\mathbb{R}} f_{\omega}(t) \psi(t) d t
\end{aligned}
$$

(here the equality is valid for all $\omega \in G$ ). Let now $f \in H_{1}^{\lambda}(G)$. Then

$$
\int_{G} \int_{\mathbb{R}}\left|f_{\omega}(t) \psi(t)\right| d t \leq\|f\|_{1}\|\psi\|_{1}
$$

Therefore, for almost all $\omega \in G$, the function $t \mapsto f_{\omega}(t) \psi(t)$ belongs to $L_{1}(\mathbb{R})$ and the operator $S_{\psi}: H_{1}^{\lambda}(G) \rightarrow L_{1}\left(G, L_{1}(\mathbb{R})\right), f \mapsto\left[\omega \mapsto f_{\omega}(\cdot) \psi(\cdot)\right]$ is continuous. If $\left(f_{n}\right)$ is a sequence in $\operatorname{Pol}_{\lambda}(G)$ tending to $f \in H_{1}^{\lambda}(G)$, then there exists a sequence $\left(n_{k}\right)$ such that, for a.e. $\omega \in G$,

$$
\begin{aligned}
& S_{\psi}\left(f_{n_{k}}\right)(\omega) \rightarrow S_{\psi}(f)(\omega) \text { in } L_{1}(\mathbb{R}) \\
& R_{\psi}\left(f_{n_{k}}\right)(\omega) \rightarrow R_{\psi}(f)(\omega)
\end{aligned}
$$

(recall that the sum defining $R_{\psi}$ is finite). Since $R_{\psi}\left(f_{n_{k}}\right)(\omega)=\int_{\mathbb{R}} S_{\psi}\left(f_{n_{k}}\right)(\omega)$ for all $k$ and all $\omega \in G$, we get the conclusion by taking the limit.

Remark 2.5. The statement of Theorem 2.4 remains true provided $\psi$ is not compactly supported but still satisfies $\sum_{n}\left|\hat{\psi}\left(\lambda_{n}\right)\right|<+\infty$.
Remark 2.6. To obtain Theorem 2.4, in both cases, we use the density of polynomials for a suitable topology. In $H_{1}^{\lambda}(G)$, this is trivial which is not the case in $\mathcal{D}_{\text {ext }}^{\infty}(\lambda)$. More specifically we intend to use Theorem 2.4 to obtain results that do not seem easily reachable using Riesz means. Therefore it is intesting to obtain a proof of Theorem 2.4 that do not use Riesz means. This is the case if we use [18, Theorem 22]. We thank A. Defant and I. Schoolmann for pointing out to me this reference.
Remark 2.7. Part (b) of the vertical convolution formula is more precised than the statement established and used in [4]. The equivalent statement in this context would be that, for all $f \in H_{1}^{\lambda}(G)$,

$$
\sum_{n=1}^{+\infty} a_{n} \hat{\psi}(n) h_{\lambda_{n}}=\int_{\mathbb{R}} T_{t} f \psi(t) d t
$$

where $T_{t}: H_{1}^{\lambda}(G) \rightarrow H_{1}^{\lambda}(G), f \mapsto f(\beta(t) \cdot)$ is an onto isometry of $H_{1}^{\lambda}(G)$ and the right handside denotes a vector-valued integral in $H_{1}^{\lambda}(G)$. We will need a pointwise statement in order to obtain maximal inequalities.
2.3. Riesz means and Saksman's vertical convolution formula. We now show how the results on $(\lambda, k)$-Riesz means will follow from our results coming from Saksman's vertical convolution formula. This is a consequence of the following easy proposition.

Proposition 2.8. Let $\alpha>0$. Then there exists an $L^{1}(\mathbb{R})$-function $\psi$ such that, for all $t \in \mathbb{R}, \hat{\psi}(x)=(1-|x|)^{\alpha}$ provided $|x|<1, \hat{\psi}(x)=0$ otherwise.

Proof. Define $u(x)=(1-|x|)^{\alpha} \mathbf{1}_{[-1,1]}(x)$. Then $u$ is piecewise $\mathcal{C}^{1}$, its derivative $u^{\prime}(x)=$ $\pm \alpha(1-|x|)^{\alpha-1} \mathbf{1}_{[-1,1]}(x)$ belongs to $L^{1}(\mathbb{R})$ and thus we know that, for all $t \neq 0, \hat{u}(t)=$ $\frac{1}{i t} \widehat{u^{\prime}}(t)$. Now, it is easy to see that $u^{\prime}$ belongs to $L^{1+\varepsilon}(\mathbb{R}) \cap L^{1}(\mathbb{R})$ for some $\varepsilon>0$. Hence, $u^{\prime}$ belongs to $L^{q}(\mathbb{R})$ for some $q<+\infty$. In particular, by Hölder's inequality, $\hat{u}$ belongs to $L^{1}$, so that we may apply the inverse Fourier transform to get the statement.

In the sequel, for $\lambda$ a frequency, $\alpha>0,(G, \beta)$ a $\lambda$-Dirichlet group and $N>0$, we shall use the following notations:

$$
\begin{aligned}
R_{N}^{\lambda, \alpha}(f) & =\sum_{\lambda_{n} \leq N} \widehat{f}\left(h_{\lambda_{n}}\right)\left(1-\frac{\lambda_{n}}{N}\right)^{\alpha} h_{\lambda_{n}} \\
R_{N}^{\lambda, \alpha}(D) & =\sum_{\lambda_{n} \leq N} a_{n}\left(1-\frac{\lambda_{n}}{N}\right)^{\alpha} e^{-\lambda_{n} s}
\end{aligned}
$$

where $f \in H_{1}^{\lambda}(G)$ and $D=\sum_{n} a_{n} e^{-\lambda_{n} s} \in \mathcal{D}(\lambda)$. Many of the results of [21, 12, 11] are based on a detailed study of these operators $R_{N}^{\lambda, \alpha}$. We shall extend them via the convolution formula to other operators $R_{\psi}$, allowing better results with a different choice of $\psi$.

## 3. Bohr's theorem under (NC)

3.1. The case of $\mathcal{D}_{\infty}^{\text {ext }}(\lambda)$. In his study of Bohr's theorem [21], I. Schoolmann used that, for all $D=\sum_{n} a_{n} e^{-\lambda_{n} s} \in \mathcal{D}_{\infty}^{\text {ext }}(\lambda)$ with extension $f$, the sequence of its Riesz means of order $k$

$$
R_{x}^{k}(D)=\sum_{\lambda_{n}<x} a_{n}\left(1-\frac{\lambda_{n}}{x}\right)^{k} e^{-\lambda_{n} s}
$$

converge uniformly to $f$ on each halfplane $\mathbb{C}_{\varepsilon}$, for all $\varepsilon>0$, as $x \rightarrow+\infty$. We now show that we may replace the function $\psi$ such that $\hat{\psi}(t)=(1-|t|)^{k} \mathbf{1}_{[-1,1]}(t)$ by any function $L^{1}$-function $\psi$ such that $\hat{\psi}$ has compact support.

Lemma 3.1. Let $\lambda$ be a frequency, let $\psi \in L^{1}(\mathbb{R})$ be such that $\hat{\psi}$ has compact support and let $D=\sum_{n} a_{n} e^{-\lambda_{n} s} \in \mathcal{D}_{\infty}^{\text {ext }}(\lambda)$ with extension $f$. Then

$$
\left\|R_{\psi}(D)\right\|_{\infty} \leq\|\psi\|_{1}\|f\|_{\infty} .
$$

Moreover, if $\int_{\mathbb{R}} \psi=1$, denoting by $\psi_{N}(\cdot)=N \psi(N \cdot)$, the sequence of $\lambda$-Dirichlet polynomials $\left(R_{\psi_{N}}(D)\right)$ converges uniformly to $f$ on each half-plane $\mathbb{C}_{\varepsilon}$, for all $\varepsilon>0$.

Proof. The inequality follows immediately from Theorem 2.4. The statement on uniform convergence follows as well from this formula and from standard results on mollifiers, provided we know that $f$ is uniformly continuous on $\mathbb{C}_{\varepsilon}$. Again, this can be deduced from the fact that on this half-plane, $f$ is the uniform limit of $\lambda$-Dirichlet polynomials, which are themselves uniformly continuous.

We shall now apply this to a suitable choice of $\psi$ in order to get good estimates of the norm of the projection $S_{N}$.

Theorem 3.2. Let $\lambda$ be a frequency. There exists $C>0$ such that, for all $M>N \geq 1$,

$$
\left\|S_{N}\right\|_{\mathcal{D}_{\infty}^{e x t}(\lambda) \rightarrow \mathcal{D}_{\infty}(\lambda)} \leq C\left(\log \left(\frac{\lambda_{M}+\lambda_{N}}{\lambda_{M}-\lambda_{N}}\right)+(M-N-1)\right)
$$

Proof. We set $h=\frac{\lambda_{M}-\lambda_{N}}{2}$. Let $u$ be the function equal to 1 on $\left[-\lambda_{N}, \lambda_{N}\right]$, to 0 on $\mathbb{R} \backslash\left(-\lambda_{M}, \lambda_{M}\right)$, and which is affine on $\left(-\lambda_{M}, \lambda_{N}\right)$ and on $\left(\lambda_{N}, \lambda_{M}\right)$. The function $u$ may be written

$$
u=\mathbf{1}_{\left[-\lambda_{N}-h, \lambda_{N}+h\right]} \star\left(\frac{1}{2 h} \mathbf{1}_{[-h, h]}\right) .
$$

This formula allows us to compute the Fourier transform of $u$ which is equal to

$$
\widehat{u}(t)=2 \frac{\sin \left(\left(\lambda_{N}+h\right) t\right)}{t} \cdot \frac{\sin (h t)}{h t}
$$

which is an $L^{1}$ function. Moreover

$$
\begin{aligned}
\|\widehat{u}\|_{1} & \leq 4 \int_{0}^{+\infty}\left|\frac{\sin \left(\left(\lambda_{N}+h\right) t\right)}{t}\right| \times\left|\frac{\sin (h t)}{h t}\right| d t \\
& \leq 4 \int_{0}^{+\infty}\left|\frac{\sin \left(\frac{\lambda_{N}+h}{h} x\right)}{x}\right| \times\left|\frac{\sin (x)}{x}\right| d x \\
& \leq 4 \int_{0}^{1}\left|\frac{\sin \left(\frac{\lambda_{N}+h}{h} x\right)}{x}\right| d x+4 \int_{1}^{+\infty} \frac{1}{x^{2}} d x \\
& \leq C \log \left(\frac{\lambda_{N}+h}{h}\right)+4=C \log \left(\frac{\lambda_{M}+\lambda_{N}}{\lambda_{M}-\lambda_{N}}\right)+4
\end{aligned}
$$

where we have used well-known estimates of the $L^{1}$-norm of the sinus cardinal function. We then applied Lemma 3.1 to $\psi \in L^{1}$ defined by $\widehat{\psi}=u$. By the Fourier inverse formula,

$$
\left\|\sum_{n=1}^{M-1} a_{n} \widehat{\psi}\left(\lambda_{n}\right) e^{-\lambda_{n} s}\right\|_{\infty} \leq\left(C \log \left(\frac{\lambda_{M}+\lambda_{N}}{\lambda_{M}-\lambda_{N}}\right)+4\right)\|f\|_{\infty}
$$

We get the conclusion by writing

$$
\sum_{n=1}^{N} a_{n} e^{-\lambda_{n} s}=\sum_{n=1}^{M-1} a_{n} \widehat{\psi}\left(\lambda_{n}\right) e^{-\lambda_{n} s}-\sum_{n=N+1}^{M-1} a_{n} \widehat{\psi}\left(\lambda_{n}\right) e^{-\lambda_{n} s}
$$

and by using that $\left|a_{n}\right| \leq\|f\|_{\infty}$ (see [21, Corollary 3.9]) and $\|\widehat{\psi}\|_{\infty} \leq 1$.
From the Bohr-Cahen formula to compute the abscissa of uniform convergence of a $\lambda$ Dirichlet series,

$$
\sigma_{u}(D) \leq \limsup _{N} \frac{\log \left(\sup _{t \in \mathbb{R}}\left|\sum_{n=1}^{N} a_{n} e^{-\lambda_{n} i t}\right|\right)}{\lambda_{N}}
$$

we get the following corollary.
Corollary 3.3. Let $\lambda$ be a frequency satisfying (NC). Then $\lambda$ satisfies Bohr's theorem.

Let us now compare Theorem 3.2 with the results of [21]. There it is shown that, for all $N \geq 1$ and all $k \in(0,1]$,

$$
\left\|S_{N}\right\|_{\mathcal{D}_{\infty}^{\mathrm{ext}}(\lambda) \rightarrow \mathcal{D}_{\infty}(\lambda)} \leq \frac{C}{k}\left(\frac{\lambda_{N+1}}{\lambda_{N+1}-\lambda_{N}}\right)^{1 / k}
$$

The right hand side is optimal for $k=\frac{1}{\log \left(\frac{\lambda_{N+1}}{\lambda_{N+1}-\lambda_{N}}\right)}$ which implies that

$$
\left\|S_{N}\right\|_{\mathcal{D}_{\infty}^{\operatorname{ext}}(\lambda) \rightarrow \mathcal{D}_{\infty}(\lambda)} \leq C \log \left(\frac{\lambda_{N+1}}{\lambda_{N+1}-\lambda_{N}}\right)
$$

Hence, we get the case $M=N+1$ of Theorem 3.2.
3.2. The case of $\mathcal{H}_{\infty}(\lambda)$. So far, we have defined three spaces which are candidates for being the $H_{\infty}$-space of $\lambda$-Dirichlet series: $\mathcal{D}_{\infty}(\lambda), \mathcal{D}_{\infty}^{\text {ext }}(\lambda)$, and $\mathcal{H}_{\infty}(\lambda)$. We know that we always have the canonical inclusion $\mathcal{D}_{\infty}(\lambda) \subset \mathcal{D}_{\infty}^{\text {ext }}(\lambda) \subset \mathcal{H}_{\infty}(\lambda)$ (see [11, Theorem 2.17]) and that, when $\lambda$ satisfies Bohr's theorem, the three spaces are equal. Observe also that $\mathcal{H}_{\infty}(\lambda)$ is the only space that is always complete.
Thus, Theorem 3.2 does not always provide an answer for estimating the norm of $S_{N}$ as an operator on $\mathcal{H}_{\infty}(\lambda)$. Fortunately, the proof extends easily using the second (and easiest part) of Theorem 2.4.

Theorem 3.4. Let $\lambda$ be a frequency. There exists $C>0$ such that, for all $M>N \geq 1$,

$$
\left\|S_{N}\right\|_{\mathcal{H}_{\infty}(\lambda) \rightarrow \mathcal{D}_{\infty}(\lambda)} \leq C\left(\log \left(\frac{\lambda_{M}+\lambda_{N}}{\lambda_{M}-\lambda_{N}}\right)+(M-N-1)\right)
$$

Proof. We do the proof in $H_{\infty}^{\lambda}(G)$. Let $f=\sum_{n} a_{n} h_{\lambda_{n}} \in H_{\infty}^{\lambda}(G)$. We pick the same function $\psi$ and observe, that for almost all $\omega \in G$,

$$
\begin{aligned}
\left|\sum_{n=1}^{+\infty} a_{n} \widehat{\psi}\left(\lambda_{n}\right) h_{\lambda_{n}}(\omega)\right| & \leq \int_{\mathbb{R}}\left|f_{\omega}(i t) \psi(t)\right| d t \\
& \leq\left(C \log \left(\frac{\lambda_{M}+\lambda_{N}}{\lambda_{M}-\lambda_{N}}\right)+4\right)\|f\|_{\infty}
\end{aligned}
$$

and we conclude as above.

## 4. Maximal inequalities in $H_{p}^{\lambda}(G)$

4.1. Helson's theorem under (NC). In this section, we prove the following theorem, which improves the main result of [12] and answers an open question of [9].

Theorem 4.1. Let $\lambda$ satisfy $(N C)$, let $(G, \beta)$ be a $\lambda$-Dirichlet group. For every $u>0$, there exists a constant $C:=C(u, \lambda)$ such that, for all $1 \leq p \leq+\infty$ and for all $f \in H_{p}^{\lambda}(G)$,

$$
\left\|\sup _{\sigma \geq u N} \mid \sum_{n=1}^{N} \hat{f}\left(h_{\lambda_{n}}\right) e^{-\sigma \lambda_{n}} h_{\lambda_{n}}\right\|\left\|_{p} \leq C\right\| f \|_{p}
$$

In particular, for every $u>0, \sum_{1}^{+\infty} \hat{f}\left(h_{\lambda_{n}}\right) e^{-u \lambda_{n}} h_{\lambda_{n}}$ converges almost everywhere on $G$.

Let us explain the strategy for the proof. When $p>1$, the almost everywhere convergence is known to hold without any assumption on $\lambda$. This is a consequence of the CarlesonHunt type result proved in [12]: for all frequencies $\lambda$, for all $(G, \beta)$ a $\lambda$-Dirichlet group, for all $p \in(1,+\infty)$, there exists $C(p)>0$ such that for all $f \in H_{p}^{\lambda}(G)$,

$$
\begin{equation*}
\left(\int_{G} \sup _{n}\left|S_{n} f(\omega)\right|^{p} d \omega\right)^{1 / p} \leq C(p)\|f\|_{p} \tag{2}
\end{equation*}
$$

where $S_{n}(f)=\sum_{k=1}^{n} \widehat{f}\left(h_{\lambda_{k}}\right) h_{\lambda_{k}}$ is the partial sum operator (the constant $C(p)$ does not even depend on $\lambda$ ). We shall prove a variant of (2) under (NC), namely

$$
\begin{equation*}
\left(\int_{G} \sup _{n} e^{-\delta \lambda_{n}}\left|S_{n} f(\omega)\right|^{p} d \omega\right)^{1 / p} \leq C(\lambda, \delta)\|f\|_{p} \tag{3}
\end{equation*}
$$

valid for all $p \geq 1$, all $\delta>0$ and all $f \in H_{p}^{\lambda}(G)$, with a constant $C(\lambda, \delta)$ independent of $p$. The proof of (3) will be done for $p=1$ and for $p=+\infty$ and will be finished by interpolation. Unfortunately, it is in general false that $\left[H_{p_{0}}^{\lambda}(G), H_{p_{1}}^{\lambda}(G)\right]_{\theta}=H_{p_{\theta}}^{\lambda}(G)$ (see [3]) and we will use an auxiliary operator defined on the whole $L_{1}(G)$.
We begin by establishing several lemmas. First, we shall prove that we may require additional properties on a sequence satisfying (NC).

Lemma 4.2. Let $\lambda$ be a frequency satisfying ( $N C$ ). Then there exists a frequency $\lambda^{\prime}$ such that $\lambda \subset \lambda^{\prime}$ and, for all $\delta>0$, there exists $C>0$ such that, for all $n \in \mathbb{N}$, there exists $m>n$ with

$$
\begin{align*}
\log \left(\lambda_{m}^{\prime}+\lambda_{n}^{\prime}\right) & \leq C e^{\delta \lambda_{n}^{\prime}}  \tag{4}\\
-\log \left(\lambda_{m}^{\prime}-\lambda_{n}^{\prime}\right) & \leq C e^{\delta \lambda_{n}^{\prime}}  \tag{5}\\
m-n & \leq C e^{\delta \lambda_{n}^{\prime}} \tag{6}
\end{align*}
$$

Proof. We construct inductively $\lambda^{\prime}$ as follows. We set $\lambda_{1}^{\prime}=\lambda_{1}$. Assume that the sequence $\lambda^{\prime}$ has been built until step $n$, namely that we have constructed $\lambda_{1}^{\prime}, \ldots, \lambda_{k_{n}}^{\prime}$ with $\lambda_{k_{n}}^{\prime}=\lambda_{n}$. If $\lambda_{n+1} \leq \lambda_{n}+1$, then we set $\lambda_{k_{n}+1}^{\prime}=\lambda_{n+1}$ and $k_{n+1}=k_{n}+1$. Otherwise, we include as many terms $\lambda_{k_{n}+1}^{\prime}, \ldots, \lambda_{k_{n+1}}^{\prime}$ as necessary so that, for all $j=k_{n}+1, \ldots, k_{n+1}-1$, $1 / 2 \leq \lambda_{j+1}^{\prime}-\lambda_{j}^{\prime} \leq 1$ and $\lambda_{k_{n+1}}^{\prime}=\lambda_{n+1}$. Namely, we add terms in the sequence $\lambda$ when there is a gap greater than 1 between two successive terms, and the difference between two consecutive terms of $\lambda^{\prime}$ is now less than 1.
Let us show that the sequence $\lambda^{\prime}$ satisfies the above conclusion. Let $\lambda_{n}^{\prime}$ be any term of the sequence $\lambda^{\prime}$. If $\lambda_{n}^{\prime}$ does not belong to $\lambda$, then we have just to consider $m=n+1$. Otherwise, if $\lambda_{n}^{\prime}=\lambda_{k}$ for some $k \leq n$, there exists $l>k$ such that

$$
\begin{align*}
\log \left(\frac{\lambda_{l}+\lambda_{k}}{\lambda_{l}-\lambda_{k}}\right) & \leq C e^{\delta \lambda_{k}}  \tag{7}\\
l-k & \leq C e^{\delta \lambda_{k}}
\end{align*}
$$

Set $m=n+(l-k)$ and observe that we have

$$
\log \left(\lambda_{m}^{\prime}+\lambda_{n}^{\prime}\right) \leq \log \left(C e^{\delta \lambda_{n}^{\prime}}+2 \lambda_{n}^{\prime}\right) \leq C^{\prime} e^{\delta \lambda_{n}^{\prime}}
$$

If there is no gap between $\lambda_{k}$ and $\lambda_{l}$, then $\lambda_{m}^{\prime}=\lambda_{l}$ and (7) implies

$$
-\log \left(\lambda_{m}^{\prime}-\lambda_{n}^{\prime}\right)=-\log \left(\lambda_{l}-\lambda_{k}\right) \leq C e^{\delta \lambda_{k}}=C e^{\delta \lambda_{n}^{\prime}}
$$

If there is a gap between $\lambda_{k}$ and $\lambda_{l}$, then $\lambda_{m}^{\prime}-\lambda_{n}^{\prime} \geq 1 / 2$, and (5) holds trivially.
In the sequel, when we will pick a frequency $\lambda$ satisfying (NC), we will in fact assume that it satisfies the stronger properties given by Lemma 4.2.
For $a>0$ and $h>0$, we shall denote by $\psi_{a, h}$ the function defined by

$$
\psi_{a, h}(t)=\frac{\sin ((a+h) t)}{t} \times \frac{\sin (h t)}{h t}
$$

The estimation of the $L^{1}$-norm of $\psi_{a, h}$ was a crucial point in order to apply Saksman's convolution formula during the proof of Theorem 3.2. In order to obtain our maximal estimates, we will need a similar inequality allowing now $a$ and $h$ to vary.

Lemma 4.3. Let $a: \mathbb{R} \rightarrow(0,+\infty)$ and $h: \mathbb{R} \rightarrow(0,+\infty)$ be two measurable functions. Assume that there exists $\kappa>0$ such that $a(t)+h(t) \leq \kappa$ and $h(t) \geq \kappa^{-1}$ for all $t \in \mathbb{R}$. Then

$$
\int_{\mathbb{R}}\left|\psi_{a(t), h(t)}(t)\right| d t \leq 4+4 \log \kappa
$$

Proof. It suffices to observe that

- when $0<|t| \leq \kappa^{-1}$, then

$$
\left|\psi_{a(t), h(t)}(t)\right| \leq|a(t)+h(t)| \times 1 \leq \kappa .
$$

- when $\kappa^{-1} \leq|t| \leq \kappa$, then

$$
\left|\psi_{a(t), h(t)}(t)\right| \leq \frac{1}{|t|} \times 1=\frac{1}{|t|}
$$

- when $|t| \geq \kappa$, then

$$
\left|\psi_{a(t), h(t)}(t)\right| \leq \frac{1}{h(t) t^{2}} \leq \frac{\kappa}{t^{2}}
$$

We now fix a frequency $\lambda$ satisfying (NC) and $\delta>0$. Let $C>0$ and $m: \mathbb{N} \rightarrow \mathbb{N}$ be such that $m(n)>n$ for all $n \in \mathbb{N}$ and (4), (5), (6) are satisfied for $m=m(n)$. For $n \in \mathbb{N}$, we shall denote by $h_{n}=\left(\lambda_{m(n)}-\lambda_{n}\right) / 2$ and by $\phi_{n}$ the function $\phi_{n}=\psi_{\lambda_{n}, h_{n}}$. Let us recall that $R_{\phi_{n}}$ is defined on $H_{1}^{\lambda}(G)$ by

$$
\begin{equation*}
R_{\phi_{n}}(f)=\sum_{k} \widehat{f}\left(h_{\lambda_{k}}\right) \widehat{\phi_{n}}\left(\lambda_{k}\right) h_{\lambda_{k}} \tag{8}
\end{equation*}
$$

By the vertical convolution formula, we also know that $R_{\phi_{n}}$ is given by, for a.e. $\omega \in G$,

$$
\begin{equation*}
R_{\phi_{n}}(f)(\omega)=\int_{\mathbb{R}} f(\omega \beta(t)) \phi_{n}(t) d t \tag{9}
\end{equation*}
$$

Now the right hand side of the previous equality is well-defined for all functions in $L_{1}(G)$. Thus we will think at $R_{\phi_{n}}$ as the operator on $L_{1}(G)$ defined by (9), keeping in mind that it also verifies (8) for $f \in H_{1}^{\lambda}(G)$. In this context, we shall prove the following maximal inequality on $R_{\phi_{n}}$ :

Lemma 4.4. For all $\delta>0$, there exists $C>0$ such that, for all $p \in[1,+\infty]$, for all $N \in \mathbb{N}$, for all $f \in L_{p}(G)$,

$$
\left(\int_{G} \sup _{n \leq N}\left|R_{\phi_{n}} f(\omega)\right|^{p} d \omega\right)^{1 / p} \leq C e^{\delta \lambda_{N}}\|f\|_{p}
$$

Proof. We start with the case $p=1$. It is enough to prove it for $f \in \mathcal{C}(G)$. Define $n: G \rightarrow\{1, \ldots, N\}, \omega \mapsto n(\omega)$ by

$$
n(\omega)=\inf \left\{l \in\{1, \ldots, N\}:\left|R_{\phi_{l}} f(\omega)\right|=\sup _{n \leq N}\left|R_{\phi_{n}} f(\omega)\right|\right\}
$$

The function $n$ is measurable and

$$
\begin{aligned}
\int_{G} \sup _{n \leq N}\left|R_{\phi_{n}}(f)(\omega)\right| d \omega & =\int_{G}\left|R_{\phi_{n(\omega)}}(f)(\omega)\right| d \omega \\
& \leq \int_{\mathbb{R}} \int_{G}|f(\omega \beta(t))| \cdot\left|\psi_{\lambda_{n(\omega)}, h_{n(\omega)}}(t)\right| d \omega d t
\end{aligned}
$$

In the inner integral we do the change of variables $\omega^{\prime}=\omega \beta(t)$ so that

$$
\begin{aligned}
\int_{G} \sup _{n \leq N}\left|R_{\phi_{n}}(f)(\omega)\right| d \omega & \leq \int_{\mathbb{R}} \int_{G}\left|f\left(\omega^{\prime}\right)\right| \cdot\left|\psi_{\lambda_{n\left(\omega^{\prime} \cdot \beta(t)^{-1}\right)}, h_{n\left(\omega^{\prime} \cdot \beta(t)-1\right)}}(t)\right| d \omega d t \\
& \leq \int_{G}\left|f\left(\omega^{\prime}\right)\right| \int_{\mathbb{R}}\left|\psi_{\lambda_{n\left(\omega^{\prime} \cdot \beta(t)^{-1}\right)}, h_{n\left(\omega^{\prime} \cdot \beta(t)^{-1}\right)}}(t)\right| d t d \omega
\end{aligned}
$$

We now use Lemma 4.3 together with (4) and (5). This yields

$$
\int_{G} \sup _{n \leq N}\left|R_{\phi_{n}}(f)(\omega)\right| d \omega \leq C \int_{G}\left|f\left(\omega^{\prime}\right)\right| e^{\delta \lambda_{N}} d \omega^{\prime}=C e^{\delta \lambda_{N}}\|f\|_{1}
$$

We then do the case $p=+\infty$. Let $f \in L_{\infty}(G)$. Then

$$
\begin{aligned}
\sup _{\omega \in G} \sup _{n \leq N}\left|R_{\phi_{n}} f(\omega)\right| & =\sup _{n \leq N} \sup _{\omega \in G} \int_{\mathbb{R}}|f(\omega \beta(t))| \cdot\left|\psi_{\lambda_{n}, h_{n}}(t)\right| d t \\
& \leq \sup _{n \leq N}\left\|\psi_{\lambda_{n}, h_{n}}\right\|_{1}\|f\|_{\infty} \\
& \leq C e^{\delta \lambda_{N}}\|f\|_{\infty}
\end{aligned}
$$

We then conclude by interpolation.
We deduce from the above work a weighted Carleson-Hunt maximal inequality for $H_{1}^{\lambda}(G)$ functions, which seems interesting for itself when $p=1$ (for $p \in(1,+\infty)$, an unweighted Carleson-Hunt inequality is true, the point here is that the constant does not depend on $p$ ). This statement was inspired by [2] where a similar result in the (much easier) case of $H_{1}(\mathbb{T})$ was essential to do a multifractal analysis of the divergence of Fourier series of functions of $H_{1}(\mathbb{T})$.

Theorem 4.5. Let $\lambda$ satisfying (NC). For all $\delta>0$ there exists $C>0$ such that, for all $N \in \mathbb{N}$, for all $p \geq 1$, for all $f \in H_{p}^{\lambda}(G)$,

$$
\left(\int_{G} \sup _{n \leq N}\left|S_{n} f(\omega)\right|^{p} d \omega\right)^{1 / p} \leq C e^{\delta \lambda_{N}}
$$

Proof. We argue as in the proof of Theorem 3.2, namely we write for a fixed $n \in \mathbb{N}$,

$$
\left|S_{n} f(\omega)\right| \leq\left|R_{\phi_{n}} f(\omega)\right|+m(n)-n \leq\left|R_{\phi(n)} f(\omega)\right|+C e^{\delta \lambda_{n}} .
$$

Therefore,

$$
\sup _{n \leq N}\left|S_{n} f(\omega)\right| \leq \sup _{n \leq N}\left|R_{\phi_{n}}(f)(\omega)\right|+C e^{\delta \lambda_{N}}
$$

and we conclude by taking the $L_{p}(G)$-norm.

We are now ready for the proof of Theorem 4.1.

Proof of Theorem 4.1. We first proceed with the case $p \in[1,+\infty)$. We may assume that $f \in \operatorname{Pol}_{\lambda}(G)$. Let $\delta=u / 3$. For $\sigma \geq u$, using Lemma 3.4 of [12], we have

$$
\left|\sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) e^{-\sigma \lambda_{n}} h_{\lambda_{n}}\right|^{p} \leq C(u)^{p} \sup _{n \leq N}\left|e^{-2 \delta \lambda_{n}} \sum_{k=1}^{n} \widehat{f}\left(h_{\lambda_{k}}\right) h_{\lambda_{k}}\right|^{p} .
$$

Hence,

$$
\sup _{\sigma>u} \sup _{N}\left|\sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) e^{-\sigma \lambda_{n}} h_{\lambda_{n}}\right|^{p} \leq C(u)^{p} \sup _{N}\left|e^{-2 \delta \lambda_{N}} \sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}\right|^{p} .
$$

For $\omega \in G$, we define

$$
n(\omega)=\inf \left\{l \geq 0:\left|e^{-2 \delta \lambda_{l}} \sum_{n=1}^{l} \widehat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}\right|=\sup _{N}\left|e^{-2 \delta \lambda_{N}} \sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}\right|\right\}
$$

which is measurable. For $k \geq 0$, we set

$$
\begin{gathered}
A_{k}=\left\{n: \lambda_{n} \in[k, k+1)\right\}, G_{k}=\left\{\omega \in G: n(\omega) \in A_{k}\right\} \\
I(\sigma)=\int_{G} \sup _{\sigma>u} \sup _{N}\left|\sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) e^{-\sigma \lambda_{n}} h_{\lambda_{n}}\right|^{p} d \omega
\end{gathered}
$$

We can write

$$
\begin{aligned}
I(\sigma) & \leq C(u)^{p} \sum_{k \geq 0} \int_{G_{k}} \sup _{N}\left|e^{-2 \delta \lambda_{N}} \sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}\right|^{p} d \omega \\
& \leq C(u)^{p} \sum_{k \geq 0} \int_{G_{k}} \sup _{N \in A_{k}}\left|e^{-2 \delta \lambda_{N}} \sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}\right|^{p} d \omega \\
& \leq C(u)^{p} \sum_{k \geq 0} \int_{G_{k}} e^{-2 \delta p k} \sup _{N \in A_{k}}\left|\sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}\right|^{p} d \omega \\
& \leq C(u, \lambda)^{p} \sum_{k \geq 0} e^{-2 \delta p k} e^{\delta p(k+1)}\|f\|_{p}^{p} \\
& \leq C(u, \lambda)^{p}\|f\|_{p}^{p} .
\end{aligned}
$$

As for the proof of Lemma 4.4, the proof is easier for $p=\infty$ and is left to the reader.

If we analyze the previous proof carefully, we observe that we have obtained the following (slightly stronger) variant of Theorem 4.5.

Corollary 4.6. Let $\lambda$ satisfying (NC). For all $\delta>0$, there exists $C>0$ such that, for all $p \geq 1$, for all $f \in H_{p}^{\lambda}(G)$,

$$
\left(\int_{G} \sup _{N}\left|\frac{S_{N} f(\omega)}{e^{\delta \lambda_{N}}}\right|^{p} d \omega\right)^{1 / p} \leq C(\delta)\|f\|_{p}
$$

When $\lambda$ satisfies (BC), it is possible to improve this inequality.
Proposition 4.7. Let $\lambda$ satisfy (BC). For all $\alpha>1$, there exists $C>1$ such that, for all $p \geq 1$, for all $f \in H_{p}^{\lambda}(G)$,

$$
\left(\int_{G} \sup _{N}\left|\frac{S_{N} f(\omega)}{\lambda_{N}^{\alpha}}\right|^{p} d \omega\right)^{1 / p} \leq C(\alpha)\|f\|_{p} .
$$

Proof. We just sketch the proof. If $\lambda$ satisfies (BC), then we know that there exists $C>0$ such that, for all $n \in \mathbb{N}, \log \left(\lambda_{n+1}-\lambda_{n}\right) \geq-C \lambda_{n}$. Adding terms if necessary, we can also assume that $\log \left(\lambda_{n+1}+\lambda_{n}\right) \leq C \lambda_{n}$. Arguing exactly as in the proof of Theorem 4.5, we can prove the existence of $C>0$ such that, for all $f \in H_{p}^{\lambda}(G)$, for all $n \in \mathbb{N}$,

$$
\int_{G} \sup _{n \leq N}\left|S_{n} f(\omega)\right|^{p} d \omega \leq C \lambda_{N}^{p}
$$

Let now $\alpha>1$, fix $f \in \operatorname{Pol}_{\lambda}(G)$ and define, for $\omega \in G$,

$$
\begin{aligned}
n(\omega) & =\inf \left\{l \geq 0:\left|\lambda_{l}^{-\alpha} \sum_{n=1}^{l} \widehat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}\right|=\sup _{N}\left|\lambda_{N}^{-\alpha} \sum_{n=1}^{N} \widehat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}\right|\right\} \\
A_{k} & =\left\{n: \lambda_{n} \in\left[2^{k}, 2^{k+1}\right)\right\} \\
G_{k} & =\left\{w: n(\omega) \in A_{k}\right\} .
\end{aligned}
$$

Then

$$
\begin{aligned}
\int_{G} \sup _{N}\left|\frac{S_{N} f(\omega)}{\lambda_{N}^{\alpha}}\right|^{p} d \omega & =\sum_{k} \int_{G_{k}} \sup _{N}\left|\frac{S_{N} f(\omega)}{\lambda_{N}^{\alpha}}\right|^{p} d \omega \\
& =\sum_{k} \int_{G_{k}} \sup _{N \in A_{k}}\left|\frac{S_{N} f(\omega)}{\lambda_{N}^{\alpha}}\right|^{p} d \omega \\
& \leq \sum_{k} 2^{-p k \alpha} \int_{G} \sup _{\lambda_{N} \leq 2^{k+1}}\left|S_{N} f(\omega)\right|^{p} d \omega \\
& \leq C \sum_{k} 2^{-p k \alpha} 2^{p(k+1)}\|f\|_{p}^{p}
\end{aligned}
$$

Question 4.8. We know that $\lambda$ satisfies Bohr's theorem if and only if for all $\delta>0$, there exists $C>0$ such that, for all $f \in H_{\infty}^{\lambda}(G)$, for all $N \geq 1$,

$$
\begin{equation*}
\left\|\sup _{n \leq N}\left|\sum_{k=1}^{n} \widehat{f}\left(h_{\lambda_{k}}\right) h_{\lambda_{k}}(\omega)\right|\right\|_{L_{\infty}(G)} \leq C e^{\delta \lambda_{N}}\|f\|_{\infty} . \tag{10}
\end{equation*}
$$

We have shown that if $\lambda$ satisfies (NC), then it satisfies the previous inequality. To prove that Helson's theorem is satisfied (and even to prove that the relevant maximal inequality holds true), it is sufficient to prove that, for all $\delta>0$, there exists $C>0$ such that, for all $f \in H_{1}^{\lambda}(G)$, for all $N \geq 1$,

$$
\begin{equation*}
\left\|\sup _{n \leq N}\left|\sum_{k=1}^{n} \widehat{f}\left(h_{\lambda_{k}}\right) h_{\lambda_{k}}(\omega)\right|\right\|_{L_{1}(G)} \leq C e^{\delta \lambda_{N}}\|f\|_{1} \tag{11}
\end{equation*}
$$

Again we have shown that if $\lambda$ satisfies (NC), then (11) is true. It seems natural to ask whether (11) always follows from (10) or, equivalently, if any frequency $\lambda$ satifying Bohr's theorem also satisfies Helson's theorem. Inequalities in $\mathcal{H}_{1}(\lambda)$ have already been deduced for their vector-valued counterpart in $\mathcal{H}_{\infty}(\lambda)$ in [10]. At first glance, it seems that this argument cannot be applied here.
4.2. Failure of Helson's theorem for $p=1$. Since for $p>1$, for any frequency $\lambda$, for any $(G, \beta)$ a $\lambda$-Dirichlet group, for any $g \in H_{p}^{\lambda}(G)$, the series $\sum_{n=1}^{+\infty} \hat{f}\left(h_{\lambda_{n}}\right) h_{\lambda_{n}}$ converges almost everywhere on $G$ (this follows from the Carleson-Hunt theorem of [12]), it is natural to ask whether Theorem 4.1 remains true without any assumption on $\lambda$. We show that this is not the case.

Theorem 4.9. There exists a frequency $\lambda$, a $\lambda$-Dirichlet group $(G, \beta)$ and $f \in H_{1}^{\lambda}(G)$ such that, for all $u>0$, the series $\sum_{n=1}^{+\infty} \hat{f}\left(h_{\lambda_{n}}\right) e^{-u \lambda_{n}} h_{\lambda_{n}}$ diverges almost everywhere on $G$.

As we might guess, the proof will use the results of Kolmogorov on a.e. divergent Fourier series in $L_{1}(\mathbb{T})$ (see for instance [22]).

Lemma 4.10. Let $A, \delta>0$. There exists $P \in H_{1}(\mathbb{T})$ a polynomial and $E \subset \mathbb{T}$ measurable such that

- $\|P\|_{1} \leq \delta$.
- $m_{\mathbb{T}}(E) \geq 1-\delta$ (here, $m_{\mathbb{T}}$ denotes the Lebesgue measure on $\mathbb{T}$ ).
- for all $z \in E$, there exists $n(z) \in \mathbb{N}$ such that $\left|S_{n(z)} P(z)\right| \geq A$.

Proof. By induction on $j \geq 1$, we construct a sequence of holomorphic polynomials $\left(P_{j}\right)$ with $\operatorname{deg}\left(P_{j}\right)=d_{j}$, two sequences of positive real numbers $\left(\mu_{j}\right)$ and $\left(\varepsilon_{j}\right)$ and a sequence $\left(E_{j}\right)$ of measurable subsets of $\mathbb{T}$ such that the following properties are true for each $j$ :
(a) $m_{\mathbb{T}}\left(E_{j}\right) \geq 1-2^{-j}$
(b) $\left\|P_{j}\right\|_{1} \leq 2^{-j}$
(c) $\mu_{j}>\mu_{j-1}+d_{j-1} \varepsilon_{j-1}$
(d) the real numbers $2 \pi, \mu_{1}, \ldots, \mu_{j}, \varepsilon_{1}, \ldots, \varepsilon_{j}$ are $\mathbb{Q}$-independent
(e) for each $z \in E_{j}$, there exists an integer $n_{j}(z)$ such that, for all $u \in[0, j]$,

$$
\left|\sum_{k=0}^{n_{j}(z)} \widehat{P_{j}}(k) e^{-u k \varepsilon_{j}} z^{k}\right| \geq j e^{j \mu_{j}}
$$

Let us proceed with the construction. We choose for $\mu_{j}$ any real number such that $\mu_{j}>$ $\mu_{j-1}+d_{j-1} \varepsilon_{j-1}$ and the real numbers $2 \pi, \mu_{1}, \ldots, \mu_{j}, \varepsilon_{1}, \ldots, \varepsilon_{j-1}$ are independent over $\mathbb{Q}$ (when $j=1$, we simply choose $\mu_{1}>2 \pi$ with $\left(2 \pi, \mu_{1}\right)$ independent over $\mathbb{Q}$ ). We then apply Lemma 4.10 with $A=(j+1) e^{j \mu_{j}}$ and $\delta=2^{-j}$ to get a polynomial $P_{j}$ with degree $d_{j}$ and a subset $E_{j} \subset \mathbb{T}$ satisfying (a) and (b). Since the functions $(u, z) \mapsto \sum_{k=0}^{n} \widehat{P}_{j}(k) e^{-u k \varepsilon} z^{k}$, for $0 \leq n \leq d_{j}$, converge uniformly on $[0, j] \times \mathbb{T}$ to $(u, z) \mapsto S_{n} P(z)$ as $\varepsilon \rightarrow 0$, we may choose $\varepsilon_{j}$ a sufficiently small positive real number such that (d) and (e) are satisfied.
Define now $\lambda=\left\{\mu_{j}+k \varepsilon_{j}: j \geq 1,0 \leq k \leq d_{j}\right\}, G=\prod_{j=1}^{+\infty} \mathbb{T}^{2}$ endowed with the canonical product structure and define $\beta:(\mathbb{R},+) \rightarrow G, t \mapsto\left(\left(e^{-i t \mu_{j}}, e^{-i t \varepsilon_{j}}\right)\right)_{j}$. By (d) and Kronecker's theorem, the homomorphism $\beta$ has dense range. Moreover, let $\lambda_{n} \in \lambda$. Then $\lambda_{n}=\mu_{j}+k \varepsilon_{j}$ for some $j \geq 1$ and some $0 \leq k \leq d_{j}$. Write an element $\omega \in G$ as $\prod_{l=1}^{+\infty}\left(w_{l}, z_{l}\right)$ and define $h_{\lambda_{n}}(\omega)=w_{j} z_{j}^{k}$. Then

$$
h_{\lambda_{n}} \circ \beta(t)=e^{-i t\left(\mu_{j}+k \varepsilon_{j}\right)}=e^{-i \lambda_{n} t}
$$

so that $(G, \beta)$ is a $\lambda$-Dirichlet group. Now, define

$$
f_{j}(\omega)=w_{j} P_{j}\left(z_{j}\right)=\sum_{k=0}^{d_{j}} \widehat{P}_{j}(k) h_{\mu_{j}+k \varepsilon_{j}}(\omega)
$$

We get $\left\|f_{j}\right\|_{H_{1}^{\lambda}(G)}=\left\|P_{j}\right\|_{H_{1}(\mathbb{T})}$ so that the series $f=\sum_{j \geq 1} f_{j}$ converges in $H_{1}^{\lambda}(G)$. Let us also define

$$
F_{j}=\left\{\omega \in G: z_{j} \in E_{j}\right\} .
$$

Then $m_{G}\left(F_{j}\right)=m_{\mathbb{T}}\left(E_{j}\right) \geq 1-2^{-j}$ (here, $m_{G}$ denotes the Haar measure on $G$ ). Thus, if we set $F=\bigcap_{j_{0} \geq 1} \bigcup_{j \geq j_{0}} F_{j}$, then $m_{G}(F)=1$. Pick now $\omega \in F$. We may find $j$ as large as we want such that $\omega \in F_{j}$. The construction of $P_{j}$ ensures that there exists $0 \leq n_{j}\left(z_{j}\right) \leq d_{j}$ such that, for all $u \in[0, j]$,

$$
\left|\sum_{k=0}^{n_{j}\left(z_{j}\right)} \widehat{P_{j}}(k) e^{-u\left(\mu_{j}+k \varepsilon_{j}\right)} z_{j}^{k}\right| \geq j
$$

Setting $N$, resp. $M$, such that $\lambda_{N}=\mu_{j-1}+d_{j-1} \varepsilon_{j-1}$, resp. $\lambda_{M}=\mu_{j}+n_{j}\left(z_{j}\right) \varepsilon_{j}$, the previous inequality translates into

$$
\left|\sum_{n=N+1}^{M} \hat{f}\left(h_{\lambda_{n}}\right) e^{-u \lambda_{n}} h_{\lambda_{n}}(\omega)\right| \geq j
$$

This easily yields the a.e. divergence of $\sum_{n=1}^{+\infty} \widehat{f}\left(h_{\lambda_{n}}\right) e^{-u \lambda_{n}} h_{\lambda_{n}}$.
4.3. Maximal inequalities for mollifiers. Since $\left(S_{n} f\right)$ does not necessarily converge pointwise or even in norm for all functions in $H_{1}^{\lambda}(G)$, Defant and Schoolmann looked in [11] for a substitute by changing the summation method. They succeeded by choosing Riesz means. Precisely they showed (see [11, Theorem 2.1]), through a maximal inequality, that for all frequencies $\lambda$, for all $f \in H_{\lambda}^{1}(G)$, for all $\alpha>0$, the sequence $\left(R_{N}^{\lambda, \alpha}(f)(\omega)\right)$ converges to $f(\omega)$ for almost all $\omega \in G$. We extend this to a large class of mollifiers.

Theorem 4.11. Let $\lambda$ be a frequency, $(G, \beta)$ a $\lambda$-Dirichlet group. Let $\psi \in L_{1}(\mathbb{R})$ be a continuous function (except at a finite number of points) such that $\widehat{\psi}$ has compact support and there exists a nonincreasing function $g \in L_{1}(0,+\infty)$ such that $|\psi(x)| \leq g(|x|)$ for all $x \in \mathbb{R}$. For $N \geq 1$, define $\psi_{N}(\cdot)=\psi(\cdot / N)$. Then

$$
R_{\max , \psi}(f):=\sup _{N}\left|R_{\psi_{N}}(f)\right|
$$

defines a bounded sublinear operator from $H_{1}^{\lambda}(G)$ into $L_{1, \infty}(G)$. Moreover, if $\int \psi=1$, then for all $f \in H_{1}^{\lambda}(G), R_{\psi_{N}}(f)(\omega)$ converges for almost every $\omega \in G$ to $f(\omega)$.

Proof. Again, the key point is the vertical convolution formula. Indeed, we know that for a.e. $\omega \in G$,

$$
R_{\psi_{N}}(f)(\omega)=f_{\omega} \star \psi_{N}(0)
$$

For those $\omega$, using [13, Theorem 2.1.10 and Remark 2.1.11],

$$
\begin{aligned}
\sup _{N}\left|R_{\psi_{N}}(f)(\omega)\right| & \leq \sup _{N}\left|f_{\omega}\right| \star \psi_{N}(0) \\
& \leq 2\|g\|_{1} \bar{M} f(\omega)
\end{aligned}
$$

where $\bar{M}(f)(\omega)=\sup _{T>0} \frac{1}{2 T} \int_{-T}^{T}\left|f_{\omega}(t)\right| d t$ is the appropriate Hardy-Littlewood maximal operator. Since $\bar{M}$ maps $H_{1}^{\lambda}(G)$ into $L_{1, \infty}(G)$ by [11, Theorem 2.10], we can conclude about the first assertion of the theorem. The result on a.e. convergence is then a standard corollary of it, using that it is clearly true for polynomials since $\widehat{\psi}(0)=1$.

Remark 4.12. We can replace the assumption that $\psi$ is compactly supported by the assumption that, for all $N \geq 1, \sum_{n}\left|\widehat{\psi}\left(\lambda_{n} / N\right)\right|<+\infty$.

This last theorem covers many examples. For instance, for all $0 \leq a<b$, we may choose the function $\psi \in L_{1}(\mathbb{R})$ such that $\hat{\psi}=1$ on $[-a, a], \hat{\psi}=0$ on $(-\infty,-b) \cup(b,+\infty)$ and $\hat{\psi}$ is affine on $(-b,-a)$ and on $(a, b)$. As already observed during the proof of Theorem 3.2, the function $\psi$ is given by

$$
\psi(x)=C(a, b) \frac{\sin \left(\frac{a+b}{2} x\right) \sin \left(\frac{b-a}{2} x\right)}{x^{2}}
$$

which clearly satisfies the assumptions of Theorem 4.11. This is also the case for $\psi(x)=$ $e^{-|x|}$ or $\psi(x)=e^{-x^{2}}$, provided the frequency $\lambda$ satisfies $\sum\left|\widehat{\psi}\left(\lambda_{n} / N\right)\right|<+\infty$ for all $N \geq 1$. To show that our result covers Theorem 2.1 of [11], we also have to show that for $\alpha>0$ the function $\psi \in L_{1}(\mathbb{R})$ that satisfies

$$
\widehat{\psi}(t)=(1-|t|)^{\alpha} \mathbf{1}_{[-1,1]}(t)
$$

verifies the assumptions of Theorem 4.11. Let $x>0$. We already have observed that

$$
\psi(x)=\frac{1}{i x} \mathcal{F}\left( \pm \alpha(1-|t|)^{\alpha-1} \mathbf{1}_{[-1,1]}\right)(x)
$$

Fix $\beta>0$ such that $|\beta(\alpha-1)|<1$ and let $x \geq 1$. Then

$$
\begin{aligned}
|\psi(x)| & \leq \frac{2 \alpha}{x}\left|\int_{0}^{1}(1-t)^{\alpha-1} e^{i t x} d t\right| \\
& \leq \frac{2 \alpha}{x}\left|\int_{0}^{1} u^{\alpha-1} e^{-i u x} d u\right|
\end{aligned}
$$

We split the integral into two parts. First,

$$
\left|\int_{0}^{x^{-\beta}} u^{\alpha-1} e^{-i u x} d u\right| \leq \frac{1}{\alpha} x^{-\alpha \beta}
$$

Second, integrating by parts,

$$
\int_{x^{-\beta}}^{1} u^{\alpha-1} e^{-i u x} d u=\frac{-1}{i x}\left[u^{\alpha-1} e^{-i u x}\right]_{x^{-\beta}}^{1}+\frac{\alpha-1}{i x} \int_{x^{-\beta}}^{1} u^{\alpha-2} e^{-i u x} d u
$$

so that

$$
\left|\int_{x^{-\beta}}^{1} u^{\alpha-1} e^{-i u x} d u\right| \leq C\left(\frac{1}{x}+\frac{1}{x^{1+(\alpha-1) \beta}}\right)
$$

Our choice of $\beta$ guarantees that there is $\delta>0$ and $C>0$ such that, for $x \geq 1$,

$$
|\psi(x)| \leq \frac{C}{x^{1+\delta}}
$$

This shows that the assumptions of Theorem 4.11 are satisfied with

$$
g(x)= \begin{cases}\frac{C}{x^{1+\delta}}, & x \geq 1 \\ \max \left(\|\psi\|_{\infty}, C\right), & x \in[0,1)\end{cases}
$$

Remark 4.13. Lemma 4.4 and Theorem 4.11 are of course very close. The latter one is true for all frequencies $\lambda$, but we start from a fixed function $\psi$ and it does not cover fully the case $p=1$. Lemma 4.4 adapts at each step the $L^{1}$-function to the frequency $\lambda$ and to the function $f$. The price to pay is that we lose some factor $e^{\delta \lambda_{N}}$ and that we cannot use general results on the Hardy-Littlewood maximal function.

## 5. Horizontal translations

In this section, we investigate the boundedness from $\mathcal{H}_{p}(\lambda)$ into $\mathcal{H}_{q}(\lambda)$, for $q>p$, of the horizontal translation map $T_{\sigma}\left(\sum_{n} a_{n} e^{-\lambda_{n} s}\right)=\sum_{n} a_{n} e^{-\sigma \lambda_{n}} e^{-\lambda_{n} s}$. We are interested in this map to determine the exact value of

$$
\sigma_{\mathcal{H}_{p}(\lambda)}=\inf \left\{\sigma \in \mathbb{R}: \sigma_{c}(D) \leq \sigma \text { for all } D \in \mathcal{H}_{p}(\lambda)\right\}
$$

since it is easy to prove, using the Cauchy-Schwarz inequality, that $\sigma_{\mathcal{H}_{2}(\lambda)}=L(\lambda) / 2$. Recall that, when $\lambda=(\log n), \sigma_{\mathcal{H}_{p}(\lambda)}=1 / 2$ for all $p \in[1,+\infty)$. In the general case, it is always possible to majorize $\sigma_{\mathcal{H}_{1}(\lambda)}$ if we know $\sigma_{\mathcal{H}_{2}(\lambda)}$.

Proposition 5.1. Let $\lambda$ be a frequency. Then $\sigma_{\mathcal{H}_{1}(\lambda)} \leq 2 \sigma_{\mathcal{H}_{2}(\lambda)}$.
Proof. Let $\varepsilon>0$. It is sufficient to prove that, for all $f=\sum_{j} a_{j} e^{-\lambda_{j} s}$ belonging to $\mathcal{H}_{1}(\lambda)$, for all $\sigma>2 \sigma_{\mathcal{H}_{2}(\lambda)}+\varepsilon=L(\lambda)+\varepsilon$,

$$
\sum_{j=1}^{+\infty}\left|a_{j}\right| e^{-\lambda_{j} \sigma}<+\infty .
$$

Let $J \geq 1$ be such that, for all $j \geq J, \log (j) / \lambda_{j} \leq L(\lambda)+\varepsilon$. Then

$$
\sum_{j}\left|a_{j}\right| e^{-\lambda_{j} \sigma} \leq(J-1)\|f\|_{1}+\sum_{j=J}^{+\infty}\|f\|_{1} e^{-\frac{\sigma}{L(\lambda)+\varepsilon} \log (j)}<+\infty
$$

by our assumption on $\sigma$.
It turns out that, even if we put strong growth and separation conditions on $\lambda$, we cannot go further.

Theorem 5.2. There exists a frequency $\lambda$ satisfying $(B C)$ such that $\sigma_{\mathcal{H}_{1}(\lambda)}=2 \sigma_{\mathcal{H}_{2}(\lambda)}$ and $\sigma_{\mathcal{H}_{2}(\lambda)}>0$.

Proof. For $n \geq 2$, let $\delta_{n} \in\left(2^{-n-1}, 2^{-n}\right]$ such that $\left(2 \pi, n, \delta_{n}\right)$ are $\mathbb{Z}$-independent. We set

$$
\lambda_{2^{n}+k}=n+k \delta_{n} \text { for } n \geq 1, k=0, \ldots, 2^{n}-1 .
$$

It is easy to check that $L(\lambda)=\log (2)$ so that $\sigma_{\mathcal{H}_{2}(\lambda)}=(\log 2) / 2$. Moreover, it is also easy to check that $\lambda$ satisfies (BC). Indeed, for $n \geq 2$ and $k=0, \ldots, 2^{n}-2$,

$$
\lambda_{2^{n}+k+1}-\lambda_{2^{n}+k}=\delta_{n} \geq \frac{1}{2} 2^{-n} \geq C e^{-(\log 2) \lambda_{2^{n}+k}}
$$

and similarly

$$
\lambda_{2^{n+1}}-\lambda_{2^{n+1}-1} \geq 2^{-n} \geq C e^{-(\log 2) \lambda_{2^{n+1}-1}} .
$$

Pick now any $\sigma>\sigma_{\mathcal{H}_{1}(\lambda)}$. By the principle of uniform boundedness, there exists $C_{0}>0$ such that, for all $D=\sum_{j} a_{j} e^{-\lambda_{j} s}$ belonging to $\mathcal{H}_{1}(\lambda)$, for all $N \geq 2$,

$$
\begin{equation*}
\left|\sum_{j=2}^{N} a_{j} e^{-\lambda_{j} \sigma}\right| \leq C_{0}\|D\|_{1} \tag{12}
\end{equation*}
$$

Let $n \geq 2$ and choose $D=\sum_{k=0}^{2^{n}-1} e^{-\lambda_{2^{n}+k} s}$. Then

$$
\begin{equation*}
\sum_{k=0}^{2^{n}-1} e^{-\lambda_{2^{n}+k} \sigma} \geq 2^{n} e^{-\sigma(n+1)} \geq C_{1} e^{(\log 2-\sigma) n} \tag{13}
\end{equation*}
$$

On the other hand, set $\lambda^{\prime}=\left\{n+k \delta_{n}: k \geq 0\right\}$ and observe that, using the internal description of the norm of $\mathcal{H}_{1}$,

$$
\|D\|_{\mathcal{H}_{1}(\lambda)}=\|D\|_{\mathcal{H}_{1}\left(\lambda^{\prime}\right)}
$$

We shall compute $\|D\|_{\mathcal{H}_{1}\left(\lambda^{\prime}\right)}$ using Fourier analysis. Indeed, since $\left(2 \pi, n, \delta_{n}\right)$ are $\mathbb{Z}$ independent, the map $\beta: \mathbb{R} \rightarrow \mathbb{T}^{2}, t \mapsto\left(e^{-i t n}, e^{-i t \delta_{n}}\right)$ has dense range, so that $\left(\mathbb{T}^{2}, \beta\right)$ is a $\lambda^{\prime}$-Dirichlet group. Therefore,

$$
\begin{equation*}
\|D\|_{\mathcal{H}_{1}\left(\lambda^{\prime}\right)}=\int_{\mathbb{T}^{2}}\left|\sum_{k=0}^{2^{n}-1} z_{1} z_{2}^{k}\right| d z_{1} d z_{2} \leq C_{2} n \tag{14}
\end{equation*}
$$

by the classical estimate of the norm of the Dirichlet kernel. Hence, (12), (13) and (14) imply that, for all $\sigma>\sigma_{\mathcal{H}_{1}(\lambda)}, \sigma \geq \log (2)$. This yields $\sigma_{\mathcal{H}_{1}(\lambda)} \geq 2 \sigma_{\mathcal{H}_{2}(\lambda)}$.

In view of the previous results, it seems natural to study how arithmetical properties of the frequency $\lambda$ can influence the values of $\sigma$ for which $T_{\sigma}: \mathcal{H}_{p}(\lambda) \rightarrow \mathcal{H}_{q}(\lambda), p<q$, is bounded. We concentrate on the case $p=2$ and $q=2 k, k \geq 1$, because we can compute the norms using the coefficients. We define $\lambda * \lambda$ as $\left\{\lambda_{l}+\lambda_{k}: l, k \geq 0\right\}$ and $\lambda^{* k}=\lambda * \cdots * \lambda$ (with $k$ factors).

Definition 5.3. Let $\lambda$ be a frequency and $k \geq 1$. Write $\lambda^{* k}=\left(\mu_{l}\right)$ where the sequence $\left(\mu_{l}\right)$ is increasing. We set

$$
A(\lambda, k)=\limsup _{l \rightarrow+\infty} \frac{\log \left(\operatorname{card}\left\{\left(n_{1}, \ldots, n_{k}\right): \lambda_{n_{1}}+\cdots+\lambda_{n_{k}}=\mu_{l}\right\}\right)}{2 \mu_{l}}
$$

Proposition 5.4. Let $\lambda$ be a frequency and $k \geq 1$. Then for $\sigma>A(\lambda, k)$, $T_{\sigma}$ maps boundedly $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$.

Proof. We shall prove a slightly stronger statement : if $\sigma>0$ is such that there exists $C>0$ such that for any $\mu>0$,

$$
e^{-2 \mu \sigma} \operatorname{card}\left\{\left(n_{1}, \ldots, n_{k}\right): \lambda_{n_{1}}+\cdots+\lambda_{n_{k}}=\mu\right\} \leq C
$$

then $T_{\sigma}$ maps boundedly $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$. Indeed, let $D=\sum_{n} a_{n} e^{-\lambda_{n} s}$ belonging to $\mathcal{H}_{2}(\lambda)$. We write $T_{\sigma}(D)^{k}=\sum_{l} b_{\mu_{l}} e^{-\mu_{l} s}$ where

$$
b_{\mu_{l}}=\sum_{\lambda_{n_{1}}+\cdots+\lambda_{n_{k}}=\mu_{l}} a_{n_{1}} \cdots a_{n_{k}} e^{-\mu_{l} \sigma} .
$$

We just need to prove that the sequence $\left(b_{\mu_{l}}\right)$ is square summable, namely that for all square summable sequences $\left(c_{\mu_{l}}\right), \sum_{l} b_{\mu_{l}} c_{\mu_{l}}$ is convergent, namely that

$$
\sum_{n_{1}, \ldots, n_{k}} a_{n_{1}} \cdots a_{n_{k}} e^{-\left(\lambda_{n_{1}}+\cdots+\lambda_{n_{k}}\right) \sigma} c_{\lambda_{n_{1}}+\cdots+\lambda_{n_{k}}} \text { is convergent. }
$$

By the Cauchy-Schwarz inequality, since $\left(a_{n}\right)$ is square summable, it is sufficient to prove that

$$
\sum_{n_{1}, \ldots, n_{k}} e^{-2 \lambda_{n_{1}} \sigma} \cdots e^{-2 \lambda_{n_{k}} \sigma}\left|c_{\lambda_{n_{1}}+\cdots+\lambda_{n_{k}}}\right|^{2}<+\infty
$$

Rewriting this

$$
\sum_{l}\left|c_{\mu_{l}}\right|^{2} e^{-2 \mu_{l} \sigma} \operatorname{card}\left\{\left(n_{1}, \ldots, n_{k}\right): \lambda_{n_{1}}+\cdots+\lambda_{n_{k}}=\mu_{l}\right\}<+\infty
$$

this follows from the assumption.
Corollary 5.5. Let $\lambda$ be a frequency, $k \geq 1$ and $\sigma>(k-1) L(\lambda) / 2$. Then $T_{\sigma}$ maps $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$.

Proof. Let $\varepsilon>0$. There exists $N \geq 1$ such that, for all $n \geq N, \log (n) / \lambda_{n} \leq L(\lambda)+\varepsilon$. Let $\mu \in\left(\lambda^{*}\right)^{k}$ and $n_{1}, \ldots, n_{k}$ be such that $\lambda_{n_{1}}+\cdots+\lambda_{n_{k}}=\mu$. Then each $\lambda_{n_{i}}$ is smaller than $\mu$ so that either $n_{i} \leq N$ or $n_{i} \leq \exp (\mu(L(\lambda)+\varepsilon))$. Since the knowledge of $n_{1}, \ldots, n_{k-1}$ determines the value of $n_{k}$, we have

$$
\operatorname{card}\left\{\left(n_{1}, \ldots, n_{k}\right): \lambda_{n_{1}}+\cdots+\lambda_{n_{k}}=\mu\right\} \leq N^{k-1} \exp ((k-1) \mu(L(\lambda)+\varepsilon))
$$

Taking the logarithm and letting $\mu$ to $+\infty$, we find $A(\lambda, k) \leq \frac{(k-1)(L(\lambda)+\varepsilon)}{2}$, hence the inequality $A(\lambda, k) \leq \frac{(k-1) L(\lambda)}{2}$ since $\varepsilon$ is arbitrary.

Corollary 5.6. Let $\lambda$ be a frequency such that $L(\lambda)=0$. Then $T_{\sigma}$ maps boundedly $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{q}(\lambda)$ for all $q \geq 2$.

Question 5.7. Let $p \geq 2$ and let $\lambda$ be a frequency. Does $T_{\sigma}$ maps $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{p}(\lambda)$ as soon as $\sigma>\frac{(p-2) L(\lambda)}{4}$ ?

Example 5.8. Let $\lambda=(\log n)$. Then for all $k \geq 1, A(\lambda, k)=0$.
Proof. We first observe that $\left(\lambda^{*}\right)^{k}=\lambda$. Pick now $\log n \in \lambda$. We want to know the cardinal number of $\left\{\left(n_{1}, \ldots, n_{k}\right) \in \mathbb{N}: n_{1} \times \cdots \times n_{k}=n\right\}$. Decompose $n$ into a product of prime numbers, $n=p_{1}^{\alpha_{1}} \cdots p_{r}^{\alpha_{r}}$. Then each $n_{k}$ writes $p_{1}^{\alpha_{1}(k)} \cdots p_{r}^{\alpha_{r}(k)}$ with $\alpha_{j}(1)+\cdots+\alpha_{j}(r)=\alpha_{j}$, $1 \leq j \leq r$. Hence, $\left(\alpha_{j}(1), \cdots \alpha_{j}(r)\right)$ is a weak composition of $\alpha_{j}$ into $k$ parts which can be done in $\binom{\alpha_{i}+k-1}{k-1}$ ways. In total, there are

$$
\prod_{i=1}^{r}\binom{\alpha_{i}+k-1}{k-1} \leq \prod_{i=1}^{r}\left(\alpha_{i}+k\right)^{k}
$$

ways to write $n$ as a product of $k$ factors. Thus,

$$
A(\lambda, k) \leq \limsup _{n=\prod_{i=1}^{r} p_{i}^{\alpha_{i}} \rightarrow+\infty} \frac{\sum_{i=1}^{r} k \log \left(\alpha_{i}+k\right)}{2 \sum_{i=1}^{r} \alpha_{i} \log \left(p_{i}\right)}=0
$$

We finish this section by exhibiting a frequency $\lambda$ satisfying (BC) and such that, for all $k \geq 1, T_{\sigma}$ maps $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$ if and only if $\sigma \geq A(\lambda, k)=\frac{k-1}{2 k}$. We begin with two combinatorial lemmas.

Lemma 5.9. Let $b, c>0$, let $n \in \mathbb{N}$ and let $\lambda_{j}=b+j c, j \geq 0$. For all $k \in \mathbb{N}$, there exist $\gamma_{k} \in(0,1]$ and $\delta_{k}>0$ such that, for all $n \geq 2^{k}$, for all $\ell \in\left[\left(k-\gamma_{k}\right) n,\left(k+\gamma_{k}\right) n\right] \cap \mathbb{N}_{0}$,

$$
\operatorname{card}\left\{\left(j_{1}, \ldots, j_{k}\right) \in\{0, \ldots, 2 n\}^{k}: \lambda_{j_{1}}+\cdots+\lambda_{j_{k}}=k b+\ell c\right\} \geq \delta_{k} n^{k-1}
$$

Proof. We define the sequences $\left(\gamma_{k}\right)$ and $\left(\delta_{k}\right)$ by $\gamma_{k}=2^{-(k-1)}$ and $\delta_{1}=1, \delta_{k+1}=\delta_{k} \cdot \gamma_{k+1}$. We proceed by induction over $k$. The case $k=1$ is trivial. Assume that the result has been proved for $k$ and let us prove it for $k+1$. Let $n \geq 2^{k+1}$. Choose $j_{k+1}$ any integer in $\left[\left(1-\gamma_{k+1}\right) n,\left(1+\gamma_{k+1}\right) n\right]$ and $\ell \in\left[\left(k+1-\gamma_{k+1}\right) n,\left(k+1+\gamma_{k+1}\right) n\right] \cap \mathbb{N}_{0}$. Then

$$
\begin{equation*}
\lambda_{j_{1}}+\cdots+\lambda_{j_{k+1}}=(k+1) b+\ell c \Longleftrightarrow \lambda_{j_{1}}+\cdots+\lambda_{j_{k}}=k b+\left(\ell-j_{k+1}\right) c . \tag{15}
\end{equation*}
$$

Now,

$$
\left|\ell-j_{k+1}-k n\right| \leq 2 \gamma_{k+1} n=\gamma_{k} n
$$

so that there exist at least $\delta_{k} n^{k-1}$ choices of $\left(j_{1}, \ldots, j_{k}\right)$ such that (15) is true, $j_{k+1}$ being fixed. Now, there are $2\left\lfloor\gamma_{k+1} n\right\rfloor+1$ choices of $j_{k+1}$ and since $\gamma_{k+1} n-1 \geq \gamma_{k+1} n / 2$ because $\gamma_{k+1} n \geq 2$, we get the result.

Lemma 5.10. Let $\left(b_{n}\right)$ and $\left(c_{n}\right)$ be two sequences of positive real numbers such that the sequences $\left(b_{1}, \ldots, b_{N}, c_{1}, \ldots, c_{N}\right)$ are $\mathbb{Z}$-independent for all $N \geq 1,2 n+1 \leq \exp \left(b_{n}\right)$ and $n c_{n} \leq 1$ for each $n \in \mathbb{N}$. Define a sequence $\left(\lambda_{n}\right)$ by $\lambda_{m^{2}+j}=b_{m}+j c_{m}$, $m \geq 1$, $j=0, \ldots, 2 m$. Then for all $k>0$ there exists $C_{k}>0$ such that, for all $\mu>0$,

$$
\operatorname{card}\left\{\left(n_{1}, \ldots, n_{k}\right) \in \mathbb{N}^{k}: \lambda_{n_{1}}+\cdots+\lambda_{n_{k}}=\mu\right\} \leq C_{k} \exp \left(\frac{(k-1) \mu}{k}\right)
$$

Proof. If $\mu$ can be written $\mu=\lambda_{n_{1}}+\cdots+\lambda_{n_{k}}$ for some sequence $\left(n_{1}, \ldots, n_{k}\right)$, it can be uniquely written

$$
\begin{equation*}
\mu=\alpha_{1} b_{r_{1}}+\beta_{1} c_{r_{1}}+\cdots+\alpha_{l} b_{r_{l}}+\beta_{l} c_{r_{l}} \tag{16}
\end{equation*}
$$

with $1 \leq l \leq k, r_{1}<r_{2}<\cdots<r_{l}, \alpha_{i} \geq 1, \alpha_{1}+\cdots+\alpha_{l}=k$ and $0 \leq \beta_{i} \leq 2 \alpha_{i} r_{i}$. We will first estimate card $\left\{\left(n_{1}, \ldots, n_{k}\right) \in \mathbb{N}^{k}: \lambda_{n_{1}}+\cdots+\lambda_{n_{k}}=\mu\right\}$ by a quantity depending on $k, l, \alpha_{i}, r_{i}$ and $\beta_{i}$. In view of the definition of the sequence $\lambda$ and of (16), we are reduced to estimate the number of $2 k$-tuples $\left(m_{1}, \ldots, m_{k}, j_{1}, \ldots, j_{k}\right)$ such that for all $s=1, \ldots, k$, $0 \leq j_{s} \leq 2 m_{s}$ and, for all $i=1, \ldots, l$,

- there are $\alpha_{i}$ elements in $m_{1}, \ldots, m_{k}$ which are equal to $r_{i}$;
- if $\phi_{i}(1), \ldots, \phi_{i}\left(\alpha_{i}\right)$ are the indices of these elements, then

$$
\begin{equation*}
j_{\phi_{i}(1)}+\cdots+j_{\phi_{i}\left(\alpha_{i}\right)}=\beta_{i} . \tag{17}
\end{equation*}
$$

We first choose the values of $m_{1}, \ldots, m_{k}$. We choose the $\alpha_{1}$ indices in $\{1, \ldots, k\}$ such that the corresponding $m_{i}$ are equal to $r_{1}$. We then do the same for the $\alpha_{2}$ elements equal to $r_{2}$ and so on until $k-1$ (the remaining $m_{i}$ are fixed and equal to $r_{l}$ ). Thus the number of choices for $m_{1}, \ldots, m_{k}$ is equal to

$$
\binom{k}{\alpha_{1}} \times\binom{ k-\alpha_{1}}{\alpha_{2}} \times \cdots \times\binom{ k-\left(\alpha_{1}+\cdots+\alpha_{l-2}\right)}{\alpha_{l-1}} .
$$

Because $l \leq k$ and $\alpha_{1}+\cdots+\alpha_{l}=k$, this number can be bounded from above by some number depending only on $k$. The integers $m_{1}, \ldots, m_{k}$ having been fixed, we now choose the integers $j_{1}, \ldots, j_{k}$. For each $i \in\{1, \ldots, l\},(17)$ implies that there are at most
$\left(2 r_{i}+1\right)^{\alpha_{i}-1}$ choices for the values of $j_{\phi_{i}(1)}, \ldots, j_{\phi_{i}\left(\alpha_{i}\right)}$ : indeed, each $j_{\phi_{i}(t)}$ belongs to $\left\{0, \ldots, 2 r_{i}\right\}$ and the last one is fixed when we know the values of the first $\alpha_{i}-1$ ones). Finally, we have found that

$$
\begin{aligned}
\operatorname{card}\left\{\left(n_{1}, \ldots, n_{k}\right) \in \mathbb{N}^{k}: \mu=\lambda_{n_{1}}+\cdots+\lambda_{n_{k}}\right\} & \leq C_{k} \prod_{i=1}^{l}\left(2 r_{i}+1\right)^{\alpha_{i}-1} \\
& \leq C_{k} \exp \left(\sum_{i=1}^{l}\left(\alpha_{i}-1\right) b_{r_{i}}\right)
\end{aligned}
$$

whre the last inequality follows from the assumption $2 n+1 \leq \exp \left(b_{n}\right)$ for all $n \in \mathbb{N}$. Now we have $\sum_{i=1}^{l} \alpha_{i} b_{r_{i}} \leq \mu$ and

$$
\begin{aligned}
k \sum_{i=1}^{l} b_{r_{i}} & \geq \sum_{i=1}^{l} \alpha_{i} b_{r_{i}}=\mu-\sum_{i=1}^{l} \beta_{i} c_{r_{i}} \\
& \geq \mu-2 \sum_{i=1}^{l} \alpha_{i} r_{i} c_{r_{i}} \geq \mu-2 k \sum_{i=1}^{l} r_{i} c_{r_{i}} \\
& \geq \mu-2 k^{2}
\end{aligned}
$$

since $n c_{n} \leq 1$ and $l \leq k$. This implies that

$$
\sum_{i=1}^{l}\left(\alpha_{i}-1\right) b_{r_{i}} \leq \mu-\frac{\mu}{k}+2 k=\frac{(k-1) \mu}{k}+2 k
$$

hence the result.
Theorem 5.11. There exists a frequency $\left(\lambda_{n}\right)$ satisfying $(B C)$ such that for all $k \geq 1, T_{\sigma}$ maps $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$ if and only if $\sigma \geq \frac{k-1}{2 k}=A(\lambda, k)$.

Proof. Let $\left(b_{n}\right)$ and $\left(c_{n}\right)$ be two sequences of positive real numbers such that

- for all $n \geq 1, \log (2 n+1) \leq b_{n} \leq \log (2 n+2)$;
- for all $n \geq 1,\left(b_{n+1}-b_{n}\right) / 8 n \leq c_{n} \leq\left(b_{n+1}-b_{n}\right) / 4 n$;
- for all $N \geq 1$, the sequences $\left(b_{1}, \ldots, b_{N}, c_{1}, \ldots, c_{N}\right)$ are $\mathbb{Z}$-independent.

We then define $\lambda$ by $\lambda_{m^{2}+j}=b_{m}+j c_{m}, m \geq 1, j=0, \ldots, 2 m$. We may argue as in the proof of Theorem 5.2 to show that the frequency $\lambda$ satisfies (BC). Using Proposition 5.4 (look at the first sentence of the proof) and Lemma 5.10, we get easily that $T_{\sigma}$ maps $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$ for $\sigma \geq \frac{k-1}{2 k}$ and also that $A(\lambda, k) \leq \frac{k-1}{2 k}$.
Conversely, assume that $T_{\sigma}$ maps $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$ (boundedness is automatic by the closed graph theorem). Let us consider $D^{[m]}=\sum_{j=0}^{2 m} e^{-\lambda_{m^{2}+j}^{s}}$ for $m \geq 1$, so that $\left\|D^{[m]}\right\|_{2}=\sqrt{2 m+1}$. Write $\lambda^{* k}$ as the increasing sequence $\left(\mu_{l}\right)$ and observe that

$$
\left(T_{\sigma} D^{[m]}\right)^{k}=\sum_{l} a_{\mu_{l}} e^{-\mu_{l} \sigma} e^{-\mu_{l} s}
$$

where $a_{\mu_{l}}=\operatorname{card}\left\{\left(j_{1}, \ldots, j_{k}\right) \in\{0, \ldots, 2 m\}^{k}: \mu_{l}=k b_{m}+\left(j_{1}+\cdots+j_{k}\right) c_{m}\right\}$. Lemma 5.9 tells us that, for $m$ sufficiently large, there is at least $\gamma_{k} m$ terms of the sequence $\left(\mu_{l}\right)$ so that $a_{\mu_{l}} \geq \delta_{k} m^{k-1}$. Furthermore, for those $\mu_{l}$,

$$
\mu_{l} \leq k\left(b_{m}+2 m c_{m}\right) \leq k \log m+A_{k}
$$

In particular,

$$
\frac{\log a_{\mu_{l}}}{2 \mu_{l}} \geq \frac{(k-1) \log m+\log \delta_{k}}{2\left(k \log m+A_{k}\right)}
$$

which shows that $A(\lambda, k) \geq \frac{k-1}{2 k}$. Furthermore,

$$
\begin{aligned}
\left\|T_{\sigma} D^{[m]}\right\|_{2 k}=\left\|\left(T_{\sigma} D^{[m]}\right)^{k}\right\|_{2}^{1 / k} & \geq C_{k}\left(m \cdot m^{2(k-1)} \cdot m^{-2 \sigma k}\right)^{1 / 2 k} \\
& \geq C_{k} m^{\frac{1}{2 k}+\frac{k-1}{k}-\sigma}
\end{aligned}
$$

Therefore, the boundedness of $T_{\sigma}$ from $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{2 k}(\lambda)$ implies that

$$
m^{\frac{1}{2 k}+\frac{k-1}{k}-\sigma} \leq C_{k}^{\prime} \sqrt{2 m+1}
$$

for all sufficiently large $m$, which itself yields $\sigma \geq \frac{k-1}{2 k}$.
Question 5.12. Let $p \geq 2$. Is it true that, for the previous sequence $\left(\lambda_{n}\right)$, $T_{\sigma}$ maps $\mathcal{H}_{2}(\lambda)$ into $\mathcal{H}_{p}(\lambda)$ if and only if $\sigma \geq \frac{p-2}{2 p}$ ?

## 6. Other Results

6.1. Norm of the projection in $\mathcal{H}_{1}(\lambda)$. In [10], Defant and Schoolmann have shown, using a vector-valued argument, that for all frequencies $\lambda$ and for all $N \geq 1,\left\|S_{N}\right\|_{\mathcal{H}_{1}(\lambda) \rightarrow \mathcal{H}_{1}(\lambda)} \leq$ $\left\|S_{N}\right\|_{\mathcal{H}_{\infty}(\lambda) \rightarrow \mathcal{H}_{\infty}(\lambda)}$. We provide a different approach to estimate $\left\|S_{N}\right\|_{\mathcal{H}_{1}(\lambda) \rightarrow \mathcal{H}_{1}(\lambda)}$, inspired by [6].
Proposition 6.1. Let $\lambda$ be a frequency. The, for all $N \geq 1,\left\|S_{N}\right\|_{\mathcal{H}_{1} \rightarrow \mathcal{H}_{1}} \leq C \log \left(\Lambda_{N}\right)$ where

$$
\Lambda_{N}=\sup \left\{\frac{\left\|\sum_{n=1}^{N} a_{n} e^{-\lambda_{n} s}\right\|_{2}}{\left\|\sum_{n=1}^{N} a_{n} e^{-\lambda_{n} s}\right\|_{1}}: a_{1}, \ldots, a_{N} \in \mathbb{C}\right\} .
$$

Proof. We work in $H_{1}^{\lambda}(G)$ where $(G, \beta)$ is a $\lambda$-Dirichlet group. Let $g \in L_{1}(G)$. Then, for $\varepsilon \in(0,1)$,

$$
\begin{aligned}
\int|g| & =\int|g|^{\frac{2 \varepsilon}{1+\varepsilon}}|g|^{\frac{1-\varepsilon}{1+\varepsilon}} \\
& \leq\left(\int|g|^{2}\right)^{\frac{\varepsilon}{1+\varepsilon}}\left(\int|g|^{1-\varepsilon}\right)^{\frac{1}{1+\varepsilon}}
\end{aligned}
$$

where we have applied Hölder's inequality for $(1+\varepsilon) / \varepsilon$ and $1+\varepsilon$. Applying this to $S_{N} f$, where $f \in H_{1}^{\lambda}(G)$, we get

$$
\left\|S_{N} f\right\|_{1} \leq\left\|S_{N} f\right\|_{2}^{\frac{2 \varepsilon}{1+\varepsilon}}\left\|S_{N} f\right\|_{1-\varepsilon}^{\frac{1-\varepsilon}{1+\varepsilon}}
$$

We now use a result of Helson [16], saying that

$$
\left\|S_{N} f\right\|_{1-\varepsilon} \leq \frac{A}{\varepsilon}\|f\|_{1}
$$

where the constant $A$ is absolute. Therefore, assuming $\|f\|_{1}=1$, after some simplifications, we get

$$
\left\|S_{N} f\right\|_{1} \leq\left(\frac{A}{\varepsilon}\right) \exp \left(\frac{2 \varepsilon}{1-\varepsilon} \log \left(\Lambda_{N}\right)\right)
$$

We conclude by choosing $\varepsilon=1 / \log \left(\Lambda_{N}\right)$.
Corollary 6.2. There exists $C>0$ such that, for all frequency $\lambda,\left\|S_{N}\right\|_{\mathcal{H}_{1}(\lambda) \rightarrow \mathcal{H}_{1}(\lambda)} \leq$ $C \log (N)$.

Proof. We get immediately that $\Lambda_{N} \leq \sqrt{N}$ by using the Cauchy-Schwarz inequality and the fact that $\left|a_{n}\right| \leq\|D\|_{1}$ for all $D=\sum_{n=1}^{N} a_{n} e^{-\lambda_{n} s}$.

This last corollary has an interest provided we are unable to prove that $\left\|S_{N}\right\|_{\mathcal{H}_{\infty}(\lambda) \rightarrow \mathcal{H}_{\infty}(\lambda)}$ is less than $C \log (N)$. The best known estimation on $\left\|S_{N}\right\|_{\mathcal{H}_{\infty}(\lambda) \rightarrow \mathcal{H}_{\infty}(\lambda)}$ is given by Theorem 3.4 and indeed it provides worst estimations for some sequences $\lambda$. Indeed, pick the sequence $\lambda$ defined in Example 2.3. Let $N=2^{n}$ for some $n$ and pick $M>N$. Then, if $M<2^{n+1}$, then

$$
\log \left(\frac{\lambda_{M}+\lambda_{N}}{\lambda_{M}-\lambda_{N}}\right) \geq \frac{1}{2} e^{n^{2}}
$$

whereas, if $M \geq 2^{n+1}$, then

$$
M-N-1 \geq 2^{n}-1
$$

A variant of Proposition 6.1 was already used in the classical case $\lambda=(\log n)$ to prove that $\left\|S_{N}\right\|_{\mathcal{H}_{1} \rightarrow \mathcal{H}_{1}} \leq C \frac{\log N}{\log \log N}$. A precise solution to the problem on how large can be $\Lambda_{N}$ in this case can be found in [8].
