SEMICLASSICAL LIMIT FOR ALMOST FERMIONIC ANYONS

THÉOTIME GIRARDOT AND NICOLAS ROUGERIE

ABSTRACT. In two-dimensional space there are possibilities for quantum statistics continuously interpolating between the bosonic and the fermionic one. Quasi-particles obeying such statistics can be described as ordinary bosons and fermions with magnetic interactions. We study a limit situation where the statistics/magnetic interaction is seen as a "perturbation from the fermionic end". We vindicate a mean-field approximation, proving that the ground state of a gas of anyons is described to leading order by a semi-classical, Vlasov-like, energy functional. The ground state of the latter displays anyonic behavior in its momentum distribution. Our proof is based on coherent states, Husimi functions, the Diaconis-Freedman theorem and a quantitative version of a semi-classical Pauli pinciple.

1. Model and main results

1.1. Introduction. In lower dimensions there are possibilities for quantum statistics other than the bosonic one and the fermionic one, so called intermediate or fractional statistics. Particles following such statistics, termed anyons (as in *any*thing in between bosons and fermions), can arise as effective quasi-particles in correlated many-body quantum systems confined to lower dimensions. They have been conjectured [2, 42, 53] to be relevant for the fractional quantum Hall effect (see [24, 30, 28] for review). They could also be simulated in certain cold atoms systems with synthetic gauge fields [17, 10, 61, 63, 64, 12].

The statistics of anyonic particles is labeled by a single parameter $\alpha \in [0, 2[$ where the cases $\alpha = 0, 1$ correspond to ordinary bosons and fermions, respectively. Since the many-anyon problem is not exactly soluble (even in the absence of interactions other than the statistical ones) except for the latter special values, it makes sense to study limiting parameter regimes where reduced models are obtained as effective descriptions.

The "almost bosonic" limit $\alpha \to 0$ is studied in [23, 41], in the joint limit $N \to \infty, \alpha \sim N^{-1}$, which turns out (N is the particle number) to be the relevant one for the non-trivial statistics to have an effect at leading order [13, 12]. Here we study an "almost fermionic limit" $\alpha \to 1$ in dependence with the particle number. The relevant scaling in dependence of N leads to a problem resembling the usual mean-field/semi-classical limit for interacting fermions [36, 20, 5, 4, 18, 22].

Our starting point is a trapped gas of anyonic particles evolving in \mathbb{R}^2 subjected to a magnetic field

$$\mathbf{B}_e = \operatorname{curl} \mathbf{A}_e$$

and a trapping external potential

$$V(x) \xrightarrow[|x| \to \infty]{} \infty$$

To model anyonic behavior we introduce the statistical gauge vector potential felt by particle j due to the influence of all the other particles

$$\mathbf{A}(x_j) = \sum_{j \neq k} \frac{(x_j - x_k)^{\perp}}{|x_j - x_k|^2}.$$
(1.1)

The statistics parameter is denoted by α , corresponding to a statistical phase $e^{i\pi(1+\alpha)}$ under a continuous simple interchange of two particles. In this so-called "magnetic gauge picture", 2D anyons are thus described as fermions, each of them carrying an Aharonov-Bohm magnetic flux of strength α . Instead of looking at the ground state of an usual Hamiltonian acting on anyonic wave-functions we thus study the following Hamiltonian

$$H_N = \sum_{j=1}^N \left((-i\hbar \nabla_j + \mathbf{A}_e(x_j) + \alpha \mathbf{A}(x_j))^2 + V(x_j) \right) \text{ acting on } L^2_{\text{asym}}(\mathbb{R}^{2N}).$$
(1.2)

We are interested in a joint limit $N \to \infty$, $\alpha \to 0$ in which the problem would simplify but still display signatures of anyonic behavior, i.e. a non-trivial dependence on α . Since we perturb around fermions, the Pauli principle implies that the kinetic energy grows faster than N. This behavior is encoded in the Lieb-Thirring inequality [40, 39] which, for any N-particles normalized antisymmetric function Ψ_N with support in a bounded domain Ω^N , gives

$$\sum_{j=1}^{N} \int_{\Omega^{N}} |\nabla_{j}\Psi|^{2} \ge C |\Omega|^{-\frac{2}{d}} N^{1+\frac{2}{d}}.$$
(1.3)

where d is the dimension of the physical space. Because of this rapid growth of the kinetic energy, the natural mean-field limit [5, 6, 20] for fermions involves a scaling $\hbar \sim N^{-1/d}$. Here with d = 2 we get a kinetic energy proportional to N^2 and thus, roughly speaking $-i\nabla_j \sim N^{1/2}$. Investigating the N-dependence of each term of (1.6) we thus expect

$$\langle H_N \rangle \approx C_1 N \left(\hbar N^{1/2} + \alpha N \right)^2 + C_2 N.$$

where the terms in parenthesis account for kinetic energy, including the influence of (1.1), and the second term is the energy in the external potential V. To make terms of the same order and obtain a non trivial limit when $\alpha \to 0$, a natural choice is to take

$$\hbar = \frac{1}{\sqrt{N}}$$
 and $\alpha = \frac{1}{N}$ (1.4)

and consider the limit

$$\lim_{N \to \infty} \frac{\langle H_N \rangle}{N}.$$

Such an approach combines two limits (see also Remark 1.2 below), the semi-classical $\hbar \to 0$ and the quasi-fermionic $\alpha \to 0$. Denoting

$$p_j^{\mathbf{A}} = -\mathrm{i}\hbar\nabla_j + \mathbf{A}_e(x_j) \tag{1.5}$$

we rewrite the Hamiltonian (1.2)

$$H_N = \sum_{j=1}^{N} \left((p_j^{\mathbf{A}} + \alpha \mathbf{A}(x_j))^2 + V(x_j) \right)$$
(1.6)

We are interested in the bottom of its spectrum in the fermionic subspace $L^2_{\text{asym}}(\mathbb{R}^{2N})$

$$E(N) := \inf\left\{ \left\langle \Psi_N, H_N \Psi_N \right\rangle, \Psi_N \in L^2_{asym}(\mathbb{R}^{2N}), \int_{\mathbb{R}^{2N}} |\Psi_N|^2 = 1 \right\}$$

1.2. Extended anyons: energy convergence. The Hamiltonian (1.6) is actually too singular to be thus considered. Consequently we introduce a length R over which the magnetic flux attached to our particles is smeared. In our approach, $R \to 0$ will make us recover the point-like anyons point of view. This "extended anyons" model is discussed in [47, 60, 9]. Anyons arising as quasi-particles in condensed-matter systems are not point-like objects. The radius R then corresponds to their size of the quasi-particle, i.e. a length-scale below which the quasi-particle description breaks down.

We introduce the 2D Coulomb potential generated by a unit charge smeared over the disc of radius ${\cal R}$

$$w_R(x) = (\log | . | * \chi_R) (x), \text{ with the convention } w_0 = \log | . |$$
(1.7)

and $\chi_R(x)$ a positive regularizing function of unit mass

$$\chi_R = \frac{1}{R^2} \chi\left(\frac{\cdot}{R}\right) \text{ and } \int_{\mathbb{R}^2} \chi = 1, \quad \chi(x) = \begin{cases} 1/\pi^2 & |x| \le 1\\ 0 & |x| \ge 2. \end{cases}$$
(1.8)

We take χ to be smooth, positive and decreasing between 1 and 2. The magnetic field associated to $\mathbf{A}(x_i)$ defined in (1.1) is

$$\operatorname{curl} \mathbf{A}(x_j) = 2\pi \sum_{k \neq j} \delta(x_j - x_k)$$

We will recover the same magnetic field (in a distributional sense) in the limit $R \to 0$ by defining

$$\mathbf{A}^{R}(x_{j}) = \sum_{k \neq j} \nabla^{\perp} w_{R}(x_{j} - x_{k}).$$
(1.9)

We henceforth work with the regularized Hamiltonian of N anyons of radius R

$$H_N^R := \sum_{j=1}^N \left(\left(p_j^{\mathbf{A}} + \alpha \mathbf{A}^R(x_j) \right)^2 + V(x_j) \right).$$
(1.10)

It is essentially self-adjoint on $L^2_{\text{asym}}(\mathbb{R}^{2N})$ (see [50, Theorem X.17] and [3]). The bottom of its spectrum then exists for any fixed R > 0, we denote it

$$E^{R}(N) = \inf \sigma \left(H_{N}^{R} \right).$$
(1.11)

Under our assumptions H_N^R will actually have compact resolovent, so the above is an eigenvalue. However, this operator does not have a unique limit as $R \to 0$ and the Hamiltonian at R = 0 (discussed e.g. in [45]) is *not* essentially self-adjoint (see for instance [14, 15, 1, 8]). Nevertheless, in the joint limit $R \to 0$ and $N \to \infty$ we recover a unique well-defined (non-linear) model. It is convenient to expand (1.10) and treat summands separately

$$H_N^R = \sum_{j=1}^N \left((p_j^{\mathbf{A}})^2 + V(x_j) \right) \text{ "Kinetic and potential terms"} + \alpha \sum_{j \neq k} \left(p_j^{\mathbf{A}} \cdot \nabla^\perp w_R(x_j - x_k) + \nabla^\perp w_R(x_j - x_k) \cdot p_j^{\mathbf{A}} \right) \text{ "Mixed two-body term"} + \alpha^2 \sum_{j \neq k \neq l} \nabla^\perp w_R(x_j - x_k) \cdot \nabla^\perp w_R(x_j - x_l) \text{ "Three-body term"} + \alpha^2 \sum_{j \neq k} \left| \nabla^\perp w_R(x_j - x_k) \right|^2 \text{ "Singular two-body term"}.$$
(1.12)

The fourth term of the above, being N times smaller than the others in the regime (1.4), will easily be discarded. Further heuristics will only involve the mixed two-body term and the three-body term. These being of the same order, we expect (as in other types of mean-field limits, see e.g. [55] and references therein) that, for large N, particles behave independently, and thus

$$\sum_{j \neq k} \nabla^{\perp} w_R(x_j - x_k) \approx \int_{\mathbb{R}^2} \nabla^{\perp} w_R(x_j - y) \rho(y) dy = \nabla^{\perp} w_R * \rho(x_j)$$

where ρ is the density of particles. Therefore, it is convenient to define, given a one-body density ρ normalized in $L^1(\mathbb{R}^2)$

$$\mathbf{A}[\rho] = \nabla^{\perp} w_0 * \rho \text{ and } \mathbf{A}^R[\rho] = \nabla^{\perp} w_R * \rho.$$

Natural mean-field functionals associated with (1.12) are then

$$\mathcal{E}_{R}^{\mathrm{af}}[\gamma] = \frac{1}{N} \operatorname{Tr}\left[\left(p_{1}^{\mathbf{A}} + \alpha \mathbf{A}^{R}[\rho_{\gamma}]\right)^{2} \gamma\right] + \frac{1}{N} \int_{\mathbb{R}^{2}} V(x_{1})\rho_{\gamma}(x_{1}) \mathrm{d}x_{1}$$
(1.13)

$$\mathcal{E}^{\mathrm{af}}[\gamma] = \frac{1}{N} \operatorname{Tr}\left[\left(p_1^{\mathbf{A}} + \alpha \mathbf{A}[\rho_{\gamma}]\right)^2 \gamma\right] + \frac{1}{N} \int_{\mathbb{R}^2} V(x_1) \rho_{\gamma}(x_1) \mathrm{d}x_1 \tag{1.14}$$

with γ the 1-body reduced density matrix of a state $\Gamma_N = |\Psi_N\rangle \langle \Psi_N|$

$$\gamma := N \operatorname{Tr}_{2 \to N} \Gamma_N.$$

Similar Hartree-like functionals were obtained in the almost-bosonic limit [23, 41]. Here we simplify things one step further by considering a semi-classical analogue

$$\mathcal{E}_{\text{Vla}}[m] = \frac{1}{(2\pi)^2} \int_{\mathbb{R}^2 \times \mathbb{R}^2} |p + \mathbf{A}_e(x) + \mathbf{A}[\rho](x)|^2 m(x, p) \mathrm{d}x \mathrm{d}p + \int_{\mathbb{R}^2} V(x) \rho_m(x) \mathrm{d}x \quad (1.15)$$

with m(x,p) a positive measure on the phase-space \mathbb{R}^4 of positions/momentas and

$$\rho_m(x) = \frac{1}{(2\pi)^2} \int_{\mathbb{R}^2} m(x, p) \mathrm{d}p.$$
(1.16)

Our convention is that m satisfies the mass constraint

$$\iint_{\mathbb{R}^2 \times \mathbb{R}^2} m(x, p) \mathrm{d}x \mathrm{d}p = (2\pi)^2 \,. \tag{1.17}$$

and the semi-classical Pauli principle

$$0 \le m(x, p) \le 1$$
 a.e. (1.18)

The latter is imposed at the classical level by the requirement that a classical state (x, p)cannot be occupied by more than one fermion. By the Bathtub principle [34, Theorem 1.14] we can perform the minimization in p explicitly (this parallels the considerations in [20]). We find minimizers of the form

$$m_{\rho}(x,p) = \mathbb{1}\left(\left|p + \mathbf{A}_{e}(x) + \mathbf{A}[\rho](x)\right|^{2} \le 4\pi\rho(x)\right)$$

where ρ minimizes the Thomas-Fermi energy

$$\mathcal{E}_{\rm TF}[\rho] = \mathcal{E}_{\rm Vla}[m_{\rho}] = 2\pi \int_{\mathbb{R}^2} \rho^2(x) dx + \int_{\mathbb{R}^2} V(x)\rho(x) dx.$$
(1.19)

We define the minimum of the Thomas-Fermi functional

$$e_{\rm TF} = \inf \left\{ \mathcal{E}_{\rm TF}[\rho] : 0 \le \rho \in L^1(\mathbb{R}^2) \cap L^2(\mathbb{R}^2), \int_{\mathbb{R}^2} \rho = 1 \right\}.$$
 (1.20)

Our first purpose is to obtain the above as the limit of the true many-body energy. We shall prove this under the following assumptions

Assumption 1.1 (External Potentials).

The external potentials entering (1.10) satisfy

- $\mathbf{A}_e \in L^2(\mathbb{R}^2) \cap W^{2,\infty}(\mathbb{R}^2)$
- $|\mathbf{A}_e|^2 \in W^{1,\infty}(\mathbb{R}^2) \cap L^2(\mathbb{R}^2)$
- $V(x) \ge c|x|^s C$ for some s > 1• $|\nabla V(x)| \le c'|x|^{s-1} + C'$ and $|\Delta V(x)| \le c''|x|^{s-2} + C''$

Theorem 1.1 (Convergence of the ground state energy).

We consider N extended anyons of radius $R = N^{-\eta}$ in an external potential V. Under Assumption (1.1) and setting

$$0 < \eta < \frac{1}{4}$$

we have, in the parameter regime (1.4)

$$\lim_{N \to \infty} \frac{E^R(N)}{N} = e_{\rm TF}$$

where the many-anyon ground state energy $E^{R}(N)$ and the Thomas-Fermi energy are defined in (1.11) and (1.20), respectively.

The study of the regime (1.4) resembles the usual Thomas-Fermi limit for a large fermionic system [36, 20, 59, 33], but with important new aspects:

- The effective interaction comprises a three-body term, and a two-body term (see Equation (1.12)) which mixes position and momentum variables.
- The limit problem (1.15) comprises an effective self-consistent magnetic field $\mathbf{A}[\rho]$.
- One should deal with the limit $R \to 0$, $\alpha \to 0$ and $\hbar \to 0$ at the same time as $N \to \infty$.

Regarding the last point, we make the

Remark 1.2 (Scaling of parameters).

Extracting a multiplicative factor N from the energy, the parameter regime (1.4) we consider is equivalent to

$$\hbar = 1 \text{ and } \alpha = \frac{1}{\sqrt{N}}$$
 (1.21)

provided we replace the external potential V(x) by NV(x) and a similar replacement for the external vector potential \mathbf{A}_e . The scaling (1.21) better highlights the quasi-fermionic character of the limit we take. We however find it preferable technically to work with (1.4), where the semi-classical aspect is more apparent.

Regarding the scaling of R, it would be highly desirable (and challenging) to be able to deal with a dilute regime $\eta > 1/2$ where the radius of the magnetic flux is much smaller than the typical inter-particle distance. We could probably relax our constraint $\eta < 1/4$ to $\eta < 1/2$ if we assume a Lieb-Thirring inequality for extended anyons of the form

$$\left\langle \Psi_N, \sum_{j=1}^N \left(p_j^{\mathbf{A}} + \alpha \mathbf{A}^R(x_j) \right)^2 \Psi_N \right\rangle \ge C_{\alpha,R} \int_{\mathbb{R}^2} \rho_{\Psi_N}(x)^2 \mathrm{d}x$$

for any fermionic wave-function Ψ_N with one-particle density ρ_{Ψ_N} . In the above we would need a $C_{\alpha,R}$ uniformly bounded from below when $N \to \infty, \alpha \to 0$ and $R \gg N^{-1/2}$. Such an inequality is made very plausible by the results of [29] on the homogeneous extended anyon gas and the known Lieb-Thirring inequalities for point-like anyons [43, 44, 45, 46]. We plan to return to this matter in the future.

The limit ground state energy $e_{\rm TF}$ does not reveal any anyonic behavior, i.e. it does not depend on α . This is however deceptive, for the behavior of the system's ground state *does* depend on α and shows the influence of the non-trivial statistics. This will become

apparent when we state the second part of our result, the convergence of ground states. It is expressed in terms of Husimi functions, constructed using coherent states. We discuss this next.

1.3. Squeezed coherent states. Let¹

$$f(x) := \frac{1}{\sqrt{\pi}} e^{-\frac{|x|^2}{2}} \tag{1.22}$$

For every (x, p) in the phase space $\mathbb{R}^2 \times \mathbb{R}^2$ we define the squeezed coherent state

$$F_{x,p}(y) := \frac{1}{\sqrt{\hbar_x}} f\left(\frac{y-x}{\sqrt{\hbar_x}}\right) e^{i\frac{p\cdot y}{\hbar}}.$$
(1.23)

It has the property of being localized on a scale $\sqrt{\hbar_x}$ in space and $\sqrt{\hbar_p}$ in momentum, these two scales being related by

$$\hbar = \sqrt{\hbar_x} \sqrt{\hbar_p}.$$
(1.24)

The usual coherent state [20, Section 2.1] is the particular case $\sqrt{h_x} = \sqrt{h_p} = \sqrt{h}$. Any such state saturates Heisenberg's uncertainty principle, and is thus as classical as a quantum state can be. Indeed, for the two observables x_1 and $p_1 = -i\partial_{x_1}$ evaluated in this state we get

$$\Delta_{x_1} \Delta_{p_1} = \frac{\hbar}{2} \quad \text{where} \quad \Delta_a = \left\langle F_{x,p}, a^2 F_{x,p} \right\rangle - \left\langle F_{x,p}, a F_{x,p} \right\rangle^2.$$

In our proofs we will take $\hbar_x \ll \hbar_p \to 0$, which is convenient because our Hamiltonian is singular in x but not in p.

We define the \hbar -Fourier tranform

$$\mathcal{F}_{\hbar}[\psi](p) = \frac{1}{2\pi\hbar} \int_{\mathbb{R}^2} \psi(x) e^{-\mathrm{i}\frac{p\cdot x}{\hbar}} \mathrm{d}x \qquad (1.25)$$

and denote

$$F_{\hbar_x}(x) = F_{0,0}(x) = \frac{1}{\sqrt{\hbar_x}\sqrt{\pi}} e^{-\frac{|x|^2}{2\hbar_x}}.$$
(1.26)

Its Fourier transform (see the calculation in Appendix C)

$$G_{\hbar_p}(p) = \mathcal{F}_{\hbar}[F_{\hbar_x}](p) = \frac{1}{\sqrt{\hbar_p}\sqrt{\pi}} e^{-\frac{|p|^2}{2\hbar_p}}$$
(1.27)

makes apparent the localization in momentum space we just claimed.

To $F_{x,p}$ we associate the orthogonal projector $P_{x,p}$

$$P_{x,p} := |F_{x,p}\rangle \langle F_{x,p}|. \tag{1.28}$$

Then we have the well-known

Lemma 1.3 (Resolution of the identity on $L^2(\mathbb{R}^2)$).

We have

$$\frac{1}{(2\pi\hbar)^2} \int_{\mathbb{R}^2} \int_{\mathbb{R}^2} P_{x,p} \, \mathrm{d}x \mathrm{d}p = \mathbb{1}_{L^2(\mathbb{R}^2)}$$
(1.29)

The proof is recalled in Appendix C, see also [34, Theorem 12.8].

¹We make the standard choice that f is a gaussian but any radial L^2 function could be used instead.

1.4. Convergence of Husimi functions. The Husimi function $m_{\Psi_N}^{(k)}(x_1, p_1, \ldots, x_k, p_k)$ [27, 11, 58] describes how many particles are distributed in the k semi-classical boxes of size $\sqrt{h_x} \times \sqrt{h_p}$ centered at its arguments $(x_1, p_1), \ldots, (x_k, p_k)$. A wave function Ψ_N being given we define

$$m_{\Psi_N}^{(k)}(x_1, p_1, \dots, x_k, p_k) = \frac{N!}{(N-k)!} \left\langle \Psi_N, \bigotimes_{j=1}^k P_{x_j, p_j} \otimes \mathbb{1}_{N-k} \Psi_N \right\rangle$$
(1.30)

Alternatively,

$$m_{\Psi_N}^{(k)}(x_1, p_1, \dots, x_k, p_k) = \frac{N!}{(N-k)!} \int_{\mathbb{R}^{2(N-k)}} \left| \left\langle F_{x_1, p_1} \otimes \dots \otimes F_{x_k, p_k}, \Psi_N(\cdot, z) \right\rangle_{L^2(\mathbb{R}^{2k})} \right|^2 \mathrm{d}z$$

or, in terms of fermionic annihilation and creation operators (see (2.2) below)

$$m_{\Psi_N}^{(k)}(x_1, p_1, \dots, x_k, p_k) = \langle \Psi_N, a^* (F_{x_1, p_1}) \dots a^* (F_{x_k, p_k}) a (F_{x_k, p_k}) \dots a (F_{x_1, p_1}) \Psi_N \rangle$$

where a and a^* satisfy the Canonical Anticommutation Relations [57, 25]

$$a^{*}(f)a(g) + a(g)a^{*}(f) = \langle g, f \rangle$$

 $a^{*}(f)a^{*}(g) + a^{*}(g)a^{*}(f) = 0.$

We will also use the k-particles density matrices of Ψ_N , i.e. the operator $\gamma_{\Psi_N}^{(k)}$ with integral kernel

These objects are further related to the density marginals in space and in momentum, respectively defined as

Consequently we also have the convergence of the k-particles marginals in position and momentum

weakly as measures.

We could also have proved the convergence of Wigner functions, see for instance [20, Theorem 2.1], and the fact that the result does not depend on the choice of function f used to construct the coherent states [20, Lemma 2.8]. Likewise, the result is the same with any choice of $\hbar_x, \hbar_p \to 0$ satisfying (1.24). In our proof of energy convergence it will however be convenient to make a particular choice, and in particular use squeezed coherent states, $\hbar_x \ll \hbar_p$.

Recall that the semi-classical Thomas-Fermi energy does not depend on α , but the Vlasov minimizer does. Anyonic features are retained e.g. in the limiting object's momentum distribution (1.37).

1.5. Outline and Sketch of the proof. Our general strategy is inspired by works on mean-field limits for interacting fermions [36, 37, 38, 21, 31, 59], in particular by the method of [20]. Several improvements are required to handle the singularity of the anyonic Hamiltonian that emerges in the limit $R \to 0$. In particular

- we replace the use of the Hewitt-Savage theorem by that of its' quantitative version, the Diaconis-Freedman theorem.
- we implement the Pauli principle quantitatively at the semi-classical level.

To obtain an energy upper bound (Section 2) we use a Slater determinant as trial state, leading by Wick's theorem to a Hartree-Fock-like energy. We then discard exchange terms to get to the simpler Hartree energy (1.13). Finally, a suitable choice of the trial state's one-body density matrix γ allows to take the semi-classical limit and establish an upper bound in terms of the Vlasov energy(1.15).

For the corresponding lower bound we first express (Section 3) the energy semi-classically, in terms of the Husimi functions. The remainder terms are shown to be negligible when $N \rightarrow \infty$. The use of squeezed coherent states with $\hbar_x \ll \hbar_p$ takes into account the singularities of the Hamiltonian, more severe in position than in momentum space.

Section 4 contains the main novelties compared to [20]. There we tackle the meanfield limit of the semi-classical functional expressed in terms of Husimi functions. We use the Diaconis-Freedman theorem [16] to express the latter as statistical superpositions of factorized measures, with a quantitatively controled error. We then estimate quantitatively the probability for the Diaconis-Freedman measure to violate the Pauli-principle (1.18). This leads to the sought-after energy lower bound and completes the proof of Theorem 1.1. The convergence of states Theorem 1.4 follows as a corollary.

2. Energy upper bound

In this section we derive an upper bound to the ground state energy (1.11). We first introduce a Hartree-Fock trial state and apply Wick's theorem to calculate its energy. We next discard lower contributions (exchange terms) to obtain a regularized (R > 0) Hartree energy in Lemma 2.4 and use Lemma 2.5 to send the regularization to 0. We conclude by using a particular sequence of semi-classical states, which will make the Hartree energy converge to the Thomas-Fermi one. All in all this will prove the

Proposition 2.1 (Energy upper bound).

Under Assumption 1.1, setting $R = N^{-\eta}$ with $\eta < 1/2$, we have

$$\mathcal{E}_{R}^{\mathrm{af}}[\gamma_{N}] = \mathrm{Tr}\left(\left(p^{\mathbf{A}} + \mathbf{A}_{R}[\widetilde{\rho}]\right)^{2}\widetilde{\gamma}\right) + \int_{\mathbb{R}^{2}} V\widetilde{\rho}$$
(2.18)

and similarly for \mathcal{E}^{af} , which is the case R = 0. The Lieb-Thirring inequality [35, Theorem 4.1] yields

$$\operatorname{Tr}\left(\left(p^{\mathbf{A}} + \mathbf{A}_{R}[\widetilde{\rho}]\right)^{2}\widetilde{\gamma}\right) \geq C \int_{\mathbb{R}^{2}} \widetilde{\rho}^{2}$$

and

while the weak Young inequality (see e.g. similar estimates in [23, Appendix A], [41, Appendix A] or Appendix A below) gives

as per the above estimates, and bounds on ∇w_R following from [23, Lemma 2.1]. As for the mixed term

$$\operatorname{Tr}\left[\left(\mathbf{A}^{R}[\widetilde{\rho}] - \mathbf{A}[\widetilde{\rho}]\right) \cdot p^{\mathbf{A}}\widetilde{\gamma}\right] \leq \left\|p^{\mathbf{A}}\sqrt{\widetilde{\gamma}}\right\|_{\mathfrak{S}^{2}} \left\|\left(\mathbf{A}^{R}[\widetilde{\rho}] - \mathbf{A}[\widetilde{\rho}]\right)\sqrt{\widetilde{\gamma}}\right\|_{\mathfrak{S}^{2}} \\ \leq C\mathcal{E}^{\operatorname{af}}\left[\widetilde{\gamma}\right]^{1/2} \left\|\left|\mathbf{A}^{R}[\widetilde{\rho}] - \mathbf{A}[\widetilde{\rho}]\right|\right\|_{L^{4}} \left\|\widetilde{\rho}\right\|_{L^{2}}^{1/2} \\ \leq C\mathcal{E}^{\operatorname{af}}\left[\widetilde{\gamma}\right]^{1/2} \left\|\left(\nabla w_{R} - \nabla w_{0}\right) * \widetilde{\rho}\right\|_{L^{4}} \left\|\widetilde{\rho}\right\|_{L^{2}}^{1/2} \\ \leq C\mathcal{E}^{\operatorname{af}}\left[\widetilde{\gamma}\right]^{1/2} \left\|\nabla w_{R} - \nabla w_{0}\right\|_{L^{4/3}} \left\|\widetilde{\rho}\right\|_{L^{2}}^{3/2} \\ \leq CR\mathcal{E}^{\operatorname{af}}\left[\widetilde{\gamma}\right]^{3/2}$$

where $||W||_{\mathfrak{S}^p} = \operatorname{Tr}[|W|^p]^{\frac{1}{p}}$ is the Schatten norm [56, Chapter 2] and where we used Young's inequality.

Inserting (2.17) in (2.4) we get

for a sequence γ_N with uniformly bounded Hartree energy. The last step consists in using constructing such a sequence γ_N , whose energy will behave semi-classicaly.

2.2. Semi-classical upper bound for the Hartree energy. We use [20, Lemma 3.2], whose statement we reproduce for the convenience of the reader.

Lemma 2.6 (Semi-classical limit of the Hartree energy).

Let $\rho \ge 0$ be a fixed function in $C_c^{\infty}(\mathbb{R}^2)$ with support in the cube $C_r = (-r/2, r/2)^2$ such that $\rho \ge 0$ and $\int_{C_r} \rho = 1$. Let $\mathbf{A} \in L^4(C_r)$ be a magnetic vector potential. If we define

where $((-i\hbar\nabla + \mathbf{A})_{C_r}^2$ is the magnetic Dirichlet Laplacian in the cube and $\hbar = 1/\sqrt{N}$ we have

and

and weakly-* in $L^{\infty}(\mathbb{R}^2)$, strongly in $L^1(\mathbb{R}^2)$ and $L^2(\mathbb{R}^2)$. Furthermore, the same properties stay true if we replace γ_N by $\tilde{\gamma}_N$ the projection onto the N lowest eigenvectors of $(-i\hbar\nabla + \mathbf{A})_{C_r}^2 - 4\pi\rho(x)$.

The convergences we claim for $N^{-1}\rho_{\gamma_N}$ are stronger than in the statement of [20, Lemma 3.2]. They easily follow from the proof therein.

We are now able to complete the proof of Proposition 2.1. We take

We now use (2.21) to take the limit of the trace and (2.22) to take the limit of the potential term $(V \in L^1_{loc}(\mathbb{R}^2))$ by assumption).

Combining with the bounds from Lemmas 2.5 and 2.4 we finally obtain

= e_{\mathrm{TF}} + o_{N}(1)$$

provided $R = N^{-\eta}$ with $0 < \eta < \frac{1}{2}$, completing the proof of Proposition 2.1.

3. Energy lower bound: semi-classical limit

In this section we first derive some useful a priori bounds and properties of the Husimi functions. Next we express our energy in terms of the latter and obtain a classical energy approximation on the phase space, plus some errors terms that we show to be negligible. We will use this expression in Section 4 to construct our lower bound.

3.1. A priori estimates.

Lemma 3.1 (Kinetic energy bound).

Let $\Psi_N \in L_{asym}(\mathbb{R}^{2N})$ be a fermionic wave-function such that

Proof. We expand the Hamiltonian and use the Cauchy-Schwarz inequality for operators to get

$$= \sum_{j=1}^N \left(\frac{1}{2} (\left(p_j^{\mathbf{A}} \right)^2 + V(x_j) \right) - 7\alpha^2 |\mathbf{A}_j^R|^2 \right)$$

choosing $\delta = 4$. Thus we have

where $\gamma_N^{(1)}$ is the 1-particle reduced density matrix

We estimate the second term of the above using [23, Lemma 2.1]:

recalling that $\alpha = N^{-1}$ we get

Now we use that

recalling that $V \ge 0$. But $|\mathbf{A}_e|^2 \in L^{\infty}(\mathbb{R}^2)$, we thus deduce (3.1). We obtain (3.2) by using the Lieb-Thirring inequality [39, 40]

Finally (3.3) is a straightforward consequence of the positivity of the full kinetic energy (first term in (1.6)).

3.2. Properties of the phase space measures. The following connects the space and momentum densities (1.33) and (1.34) with the Husimi function and is extracted from [20, Lemma 2.4]. The generalization to squeezed states we use does not change the properties of the phase space measures.

Lemma 3.2 (Densities and fermionic semi-classical measures).

Let F_{\hbar_x} , G_{\hbar_p} be defined as in (1.26) and (1.27) (recall that $\hbar = \sqrt{\hbar_x}\sqrt{\hbar_p}$). Let $\Psi_N \in L^2_{\text{asym}}(\mathbb{R}^{2N})$ be any normalized fermionic function. We have

The proof is similar to considerations from [20]. We recall it in Appendix C for completeness.

Let $\Psi_N \in L^2_{asym}(\mathbb{R}^{2N})$ be a normalized fermionic function. For every $1 \leq k \leq N$ the function $m_{\Psi_N}^{(k)}$ defined in (1.30) is symmetric and satisfies

Our aim is to show that it correctly captures the leading order of the full quantum energy.

We now use that $G_{\hbar_p}(-p) = \overline{G_{\hbar_p}(p)}$ which makes $|G_{\hbar_p}(p)|^2$ an even function (recall that G_{\hbar_p} is the Fourier transform of F_{\hbar_x} (1.26)) to discard the last term of the above. On the other hand, using (1.34) we find

thus concluding that

For the magnetic cross term (3.14) we use (C.2) to obtain, for any $u \in L^2(\mathbb{R}^2)$,

Then since $F_{x,0}$ and $|u|^2$ are real we obtain

Combining the spectral decomposition of the one-body density matrix with the above we get

$$= \int_{\mathbb{R}^{2(N-2)}} \int_{\mathbb{R}^{4}} \left(\left(\nabla^{\perp} w_{R} * |F_{\hbar_{x}}|^{2} \right) * |F_{\hbar_{x}}|^{2} \right) (x_{1} - x_{2}) \Re\left[-\mathrm{i}\hbar \nabla_{x_{1}} \Psi_{N} \overline{\Psi}_{N} \right] \mathrm{d}x_{1} \mathrm{d}x_{2} \mathrm{d}y^{*}$$

and conclude

$$\begin{split} \hbar \sum_{j=1}^{N} \sum_{k \neq j} \left\langle p_{j} \cdot \nabla^{\perp} w_{R}(x_{j} - x_{k}) \right\rangle &= \frac{1}{(2\pi\hbar)^{4}} \int_{\mathbb{R}^{4} \times \mathbb{R}^{4}} \left(p_{1} \cdot \nabla^{\perp} w_{R}(x_{1} - x_{2}) \right) \mathrm{d}m_{\Psi_{N}}^{(2)} \\ &+ \Re \left\langle \sum_{j=1}^{N} \sum_{k \neq j} \left(\nabla^{\perp} w_{R} - \nabla^{\perp} w_{R} * |F_{\hbar_{x}}|^{2} * |F_{\hbar_{x}}|^{2} \right) (x_{j} - x_{k}) \cdot (-\mathrm{i}\hbar\nabla_{j}) \right\rangle. \end{split}$$

For the terms which do not involve the variable p we only discuss the three-body term (3.12), the others being treated in the same way. We apply Lemma (3.2)

We now show than all errors in (3.13) are smaller than the classical energy \mathcal{E}^{C} . This will conclude the proof of Proposition 3.4. The following lemma will deal with all convolutions involved in the estimates.

4. Energy lower bound: mean field limit

This section is dedicated to a lower bound matching (1.10). We have reduced the problem to a classical one in the previous section. We now perform a mean-field approximation of the classical energy (3.7), showing that its infimum is (asymptotically) attained by a factorized Husimi function. The crucial point is to keep track of the semi-classical Pauli principle (1.18).

We first recall the Diaconis-Freedman theorem. We use it to rewrite many-particle probability measures as statistical superpositions of factorized ones. We then estimate quantitatively the probability for the measures in the superposition to violate the Pauli principle. This is the main novelty compared to the approach of [20]. We finally prove the convergence of the energy and states, Theorems 1.1 and 1.4.

4.1. The Diaconis-Freedman measure. For $Z_N \in \mathbb{R}^{4N}$ a set of points in the phase space, we define the associated empirical measure

We thus have to estimate the probability for a box to have the right density of points. This is the purpose of the following lemmas. We denote for a given measure μ :

with $\Gamma_{n,k}$ the set of ordered samples of *n* indices amongst *N* (allowing repetitions) with exactly *k* distinct indices. Integrating on each side of (4.28) and using the symetry of (recall Lemma 3.3)

$$\mu_N^{(k)} = m_N^{(k)} \le \frac{1}{(2\pi\hbar)^{2k} N(N-1)...(N-k+1)}$$

we obtain

$$\int_{\Omega^n} \widetilde{m}_N^{(n)} \le N^{-n} \sum_{k=1}^n \frac{|\Gamma_{n,k}| |\Omega|^k}{(2\pi\hbar)^{2k} N(N-1)...(N-k+1)}.$$

Now we calculate the cardinal $|\Gamma_{n,k}|$. For a given k, choose k indices among N (without order) to, next, be distributed in n boxes. The first step gives us

$$\frac{N!}{(N-k)!k!}$$

choices. For each of these choices we have to distribute n balls in k boxes (boxes can be empty) which corresponds to the number of surjections from $\{1, 2, ..., n\}$ to $\{1, 2, ..., k\}$, M(n, k) (with $k \leq n$). Then

$$|\Gamma_{n,k}| = \frac{N!}{(N-k)!k!}M(n,k)$$

with [7, Theorem 1.17]

$$M(n,k) = k! S(n,k)$$

and S(n,k) is the Stirling number of the second kind [7, Lemma 1.16]. Thus

$$|\Gamma_{n,k}| = \frac{N!}{(N-k)!}S(n,k).$$

We now need a rough control of the sum appearing in (4.27) when the set Ω is not too small.

Lemma 4.6 (Control of the sum).

Take $|\Omega_m| = N^{-\beta}$ with $\beta < 1$. Choose some

$$0<\delta<\frac{1-\beta}{2}$$

and define

$$n = \left\lfloor N^{\delta} \right\rfloor$$

the integer part of N^{δ} . We have that

$$(2\pi)^{2n} N^{-n} \sum_{k=1}^{n} \frac{|\Omega_m|^{(k-n)} S(n,k)}{(2\pi\hbar)^{2k}} \le C N^{\delta'}$$

for some exponent $\delta' > 0$ depending only on δ .

Proof. We recall Stirling's formula

$$C_1 \sqrt{N} \left(\frac{N}{e}\right)^N \le N! \le C_2 \sqrt{N} \left(\frac{N}{e}\right)^N \tag{4.29}$$

and a bound for the Stirling number of the second kind from [51](see also [48, 32])

$$S(n,k) \le C\binom{n}{k} k^{(n-k)}.$$
(4.30)

Inserting these bounds we have that

$$(2\pi)^{2n} N^{-n} \frac{|\Omega_m|^{(k-n)} S(n,k)}{(2\pi\hbar)^{2k}} \le C \sqrt{\frac{n}{k(n-k)}} \exp(f_\beta(k))$$

with

$$\begin{split} f_{\beta}(k) &= (n-k) \bigg(\log k + (\beta - 1) \log N + 2 \log(2\pi) \bigg) + n \log n - k \log k - (n-k) \log(n-k) \\ &= (n-k) \bigg(2 \log k + \log n + (\beta - 1) \log N + 2 \log(2\pi) - \log(n-k) \bigg) + k \log n - n \log k \\ &= (n-k) \bigg(\log k + \log n + (\beta - 1) \log N + 2 \log(2\pi) - \log(n-k) \bigg) + k \log \bigg(1 + \frac{n-k}{k} \bigg) \\ &\leq (n-k) \bigg(\log k + \log n + (\beta - 1) \log N + 2 \log(2\pi) + 1 - \log(n-k) \bigg), \end{split}$$

using $\log(1+x) \leq x$. Since $k \leq n \sim N^{\delta}$ we find that the leading order of the above is

$$f_{\beta}(k) \lesssim (n-k) \left(2\delta + \beta - 1\right) \log N \le 0$$

under our assumptions. Hence we find

$$(2\pi)^{2n} N^{-n} \sum_{k=1}^{n} \frac{|\Omega_m|^{(k-n)} S(n,k)}{(2\pi\hbar)^{2k}} \le C \sum_{k=1}^{n} \sqrt{\frac{n}{k(n-k)}},$$

which yields the result.

Now we can complete the

Proof of Theorem 4.4. We call

$$\Gamma = \left\{ \operatorname{Emp}_{Z_N}, \int_{\Omega_m} \operatorname{Emp}_{Z_N} \ge \frac{(1+\varepsilon)}{(2\pi)^2} |\Omega_m| \right\}$$
(4.31)

the set of all empirical measure violating the Pauli principle in Ω_m by a finite amount. We have, using (4.3) that, for any $n \leq N$,

$$\frac{(1+\varepsilon)^n}{(2\pi)^{2n}} |\Omega_m|^n \mathbb{P}_{P_N^{\mathrm{DF}}}(\Gamma) \le \int_{\rho \in \Gamma} \left(\int_{\Omega_m} \rho^{\otimes n} \right) \mathrm{d}P_N^{\mathrm{DF}}(\rho) = \int_{(\Omega_m)^n} \widetilde{\mu}_N^{(n)}.$$

Next, using Lemma 4.5 we obtain

$$\mathbb{P}_{P_N^{\mathrm{DF}}}(\Gamma) \le (1+\varepsilon)^{-n} (2\pi)^{2n} N^{-n} \sum_{k=1}^n \frac{|\Omega_m|^{(k-n)} S(n,k)}{(2\pi\hbar)^{2k}}$$

Choosing n as in Lemma 4.6 and inserting the latter result we deduce

$$\mathbb{P}_{P_{N}^{\mathrm{DF}}}\left(\Gamma\right) \leq C \frac{N^{\delta'}}{\left(1+\varepsilon\right)^{n}} \leq C N^{\delta'} e^{-N^{\delta} \ln\left(1+\varepsilon\right)}$$

and the result follows.

4.3. Averaging the Diaconis-Freedman measure. We divide \mathbb{R}^4 into hyperrectangles

$$\Omega_m = \Omega_{m_x} \times \Omega_{m_p}$$

as in (4.23). We set

$$|\Omega_m| = |\Omega_{m_x}| |\Omega_{m_p}| = l_x^2 l_p^2 = N^{-\beta}.$$

for some $0 < \beta < 1$ to be fixed later. We know from Theorem 4.4 that the probability for one such square to violate the Pauli principle is exponentially small. This means that the contribution to (4.20) of empirical measures

$$\mu = \frac{1}{N} \sum_{j=1}^{N} \delta_{z_j}$$

with $Z_N = (z_1, \ldots, z_j) \in \Gamma$ (see (4.31)) will be negligible (by the union bound), provided the number of hyperrectangles is not too large. The next steps of our proof are thus

- to reduce estimates to the contribution of a finite set of phase-space.
- in the latter set, to average empirical measures to replace μ in (4.20) by true Pauliprinciple abiding measures (in the sense of (1.18)).

As for the first step, let L > 0 be a number of the form

$$L = nN^{-\frac{\beta}{4}} \tag{4.32}$$

for some $n \in \mathbb{N}$ and define the square

$$S_L = [-L, L]^4$$

of side 2L centered at the origin. This way the number of Ω_m -hyperrectangles contained within S_L is 2^4n^4 . We first discard the energetic contribution of S_L^c .

Lemma 4.7 (Reduction to the energy in the finite phase-space square S_L). Let $\sigma > 0$ and μ a probability measure satisfying

$$\int_{\mathbb{R}^4} \left(|p|^2 + V(x) \right) d\mu(x, p) \le D.$$
(4.33)

Its energy can be bounded from below as

$$\mathcal{E}_{V}^{R}\left[\mu\right] \ge (1-\sigma) \int_{\mathbb{R}^{4}} \left(\left|p^{\mathbf{A}} + \mathbf{A}^{R}\left[\mathbbm{1}_{S_{L}}\mu\right]\right|^{2} + V\right) \mathbbm{1}_{S_{L}} \mathrm{d}\mu(x,p) - C \frac{D^{2}}{\sigma R^{2} \inf(L^{4}, L^{2s})} \quad (4.34)$$

where (cf(4.22))

$$\mathbf{A}^{R}\left[\mathbbm{1}_{S_{L}}\mu\right] = \mathbf{A}^{R}\left[\rho_{\mathbbm{1}_{S_{L}}\mu}\right].$$

and (cf (1.5))

$$p^{\mathbf{A}} = p + \mathbf{A}_e(x).$$

The parameter σ will tend to 0 at the very end of the proof (after we take $N \to \infty, L \to \infty, R \to 0$ while ensuring $R^6 \inf(L^4, L^{2s}) \to \infty$).

Proof. First, the positivity of the integrand gives

$$\mathcal{E}_{V}^{R}\left[\mu\right] \geq \int_{S_{L}} \left(\left|p^{\mathbf{A}} + \mathbf{A}^{R}\left[\mu\right]\right|^{2} + V\right) \mathrm{d}\mu(x, p)$$

Then we split $\mathbf{A}^{R}[\mu]$ into a contribution from S_{L} and one from its complement,

$$\mathbf{A}^{R}[\mu] = \mathbf{A}^{R}[\mathbb{1}_{S_{L}}\mu] + \mathbf{A}^{R}[\mathbb{1}_{S_{L}^{c}}\mu],$$

obtaining

$$\begin{split} \left(p^{\mathbf{A}} + \mathbf{A}^{R} \left[\mathbbm{1}_{S_{L}} \mu \right] + \mathbf{A}^{R} \left[\mathbbm{1}_{S_{L}^{c}} \mu \right] \right)^{2} &= \left(p^{\mathbf{A}} + \mathbf{A}^{R} \left[\mathbbm{1}_{S_{L}} \mu \right] \right)^{2} + \left| \mathbf{A}^{R} \left[\mathbbm{1}_{S_{L}^{c}} \mu \right] \right|^{2} \\ &+ 2 \left(p^{\mathbf{A}} + \mathbf{A}^{R} \left[\mathbbm{1}_{S_{L}} \mu \right] \right) \cdot \mathbf{A}^{R} \left[\mathbbm{1}_{S_{L}^{c}} \mu \right] . \end{split}$$

Next we use that

$$ab \le \frac{a^2}{2\sigma} + \frac{\sigma b^2}{2}$$

to deduce

$$2\left(p^{\mathbf{A}} + \mathbf{A}^{R}\left[\mathbb{1}_{S_{L}}\mu\right]\right) \cdot \mathbf{A}^{R}\left[\mathbb{1}_{S_{L}^{c}}\mu\right] \geq -\sigma\left(p^{\mathbf{A}} + \mathbf{A}^{R}\left[\mathbb{1}_{S_{L}}\mu\right]\right)^{2} - \frac{1}{\sigma}\left|\mathbf{A}^{R}\left[\mathbb{1}_{S_{L}^{c}}\mu\right]\right|^{2}.$$

But

$$\begin{split} \int_{S_L} \left| \mathbf{A}^R \left[\mathbbm{1}_{S_L^c} \mu \right] \right|^2 (x) \, \mathrm{d}\mu(x, p) &\leq \left\| \mathbf{A}^R \left[\mathbbm{1}_{S_L^c} \mu \right] \right\|_{L^{\infty}}^2 \\ &\leq \left\| \nabla^\perp w_R * \mathbbm{1}_{S_L^c} \mu \right\|_{L^{\infty}}^2 \\ &\leq \left\| \mathbbm{1}_{S_L^c} \mu \right\|_{L^1}^2 \left\| \nabla^\perp w_R \right\|_{L^{\infty}}^2 \\ &\leq \frac{C}{R^2} \left\| \mathbbm{1}_{S_L^c} \mu \right\|_{L^1}^2 \end{split}$$

where we used Young's inequality combined with [23, Lemma 2.1]. The measure μ satisfies (4.33) so, using Assumption 1.1,

$$\int_{\mathbb{R}^4} \mathbb{1}_{S_L^c} \mu(x, p) \mathrm{d}x \mathrm{d}p \le \frac{D}{\inf(L^2, L^s)}$$

which concludes the proof.

We now turn to the averaing procedure turning empirical measures based on configurations from Γ^c (recall (4.31)) into bounded measures satisfying the Pauli principle (1.18):

Definition 4.8 (Averaging map).

Let μ be a positive measure on the phase-space square $S_L = [-L, L]^4$. We associate to it its local average with respect to the grid (4.23):

Ave
$$[\mu] = \sum_{m=1}^{16n^4} \mathbb{1}_{\Omega_m} \int_{\Omega_m} \frac{\mu}{|\Omega_m|}$$
 (4.35)

with the associated position-space density (recall that $\Omega_m = \Omega_{m_x} \times \Omega_{m_p}$)

$$\rho_{\text{Ave}[\mu]} := \int \text{Ave}\left[\mu\right] dp = \sum_{m=1}^{16n^4} \mathbb{1}_{\Omega_{m_x}} \int_{\Omega_m} \frac{\mu}{|\Omega_{m_x}|}.$$
(4.36)

Note that Ave $[\mu]$ lives on S_L by definition. We next quantify the energetic cost of the above procedure:

Theorem 4.9 (Averaging the empirical measure).

Assume $\beta < 1$ in (4.24) as well as

$$l_x \ll R, \quad l_p \ll 1 \text{ in the limit } N \to \infty.$$
 (4.37)

Let $Z_N = (x_1, p_1, ..., x_N, p_N)$ with $\operatorname{Emp}_{Z_N} \in \Gamma_{\varepsilon}^c$,

$$\Gamma_{\varepsilon} = \left\{ \operatorname{Emp}_{Z_N}, \exists \Omega_m \subset S_L \text{ such that } \int_{\Omega_m} \operatorname{Emp}_{Z_N} \ge \frac{(1+\varepsilon)}{(2\pi)^2} |\Omega_m| \right\}.$$
(4.38)

Assume that (4.33) holds for $\mu = \text{Emp}_{Z_N}$. Then, for any $\sigma > 0$,

$$\mathcal{E}_{V}^{R}[\operatorname{Emp}_{Z_{N}}] \geq (1-\sigma) (1-o_{N}(1)) \mathcal{E}_{V}^{R} \left[\operatorname{Ave}\left[\operatorname{Emp}_{Z_{N}}\right]\right] - o_{N}(1) - C \frac{D^{2}}{\sigma R^{2} \inf(L^{4}, L^{2s})}.$$
 (4.39)

Proof. In this proof we denote

$$\mu = \operatorname{Emp}_{Z_N}$$

for brevity. We first use Lemma 4.7 to write

$$\mathcal{E}_V^R[\mu] \ge (1-\sigma)\mathcal{E}_V^R[\mathbb{1}_{S_L}\mu] - C\frac{D^2}{\sigma R^2 \inf(L^4, L^{2s})}$$

and now estimate $|\mathcal{E}_{V}^{R}[\mathbb{1}_{S_{L}}\mu] - \mathcal{E}_{V}^{R}[\operatorname{Ave}[\mu]]|$. We expand \mathcal{E}_{V}^{R} (4.21) and proceed term by term. Recall from (4.32) that

$$S_L = \bigcup_{m=1}^{2^4 n^4} \Omega_m.$$

We first calculate

$$\int_{S_L} \left((p^{\mathbf{A}})^2 + V(x) \right) \mathrm{d}(\mu - \operatorname{Ave}[\mu]) = \int_{S_L} \left(\left(p^{\mathbf{A}} \right)^2 + V(x) \right) \operatorname{Emp}_{Z_N} \mathrm{d}x \mathrm{d}p$$
$$- \frac{1}{N} \sum_{m=1}^{16n^4} \int_{\Omega_m} \frac{(p^{\mathbf{A}})^2 + V(x)}{|\Omega_m|} \mathrm{d}x \mathrm{d}p \int_{\Omega_m} \sum_{i=1}^N \delta_{z_i = (x, p)} \mathrm{d}x \mathrm{d}p$$

We denote

$$G_N = \{i, z_i \in S_L\}$$
$$G_N^c = \{i, z_i \in S_L^c\}$$

and let m(i) be the label of the box Ω_m particle z_i is in. This way

$$\sum_{i=1}^{N} \int_{\Omega_m} \delta_{z_i=(x,p)} \mathrm{d}x \mathrm{d}p = \sum_{i \in G_N} \delta_{m=m(i)}$$

and

$$\int_{S_L} \left((p^{\mathbf{A}})^2 + V(x) \right) \mathrm{d}(\mu - \operatorname{Ave}\left[\operatorname{Emp}_{Z_N}\right]) = \frac{1}{N} \sum_{i \in G_N} \left(\left(p_i^{\mathbf{A}} \right)^2 + V(x_i) \right)$$
$$- \int_{\Omega_{m(i)}} \frac{\left(p^{\mathbf{A}} \right)^2 + V(x)}{|\Omega_{m(i)}|} \mathrm{d}x \mathrm{d}p$$

By the mean value theorem applied in each Ω_m there exists a point $\tilde{z}_i = (\tilde{x}_i, \tilde{p}_i) \in \Omega_{m(i)}$ such that

$$\int_{\Omega_{m(i)}} \frac{\left(p^{\mathbf{A}}\right)^2 + V(x)}{|\Omega_{m(i)}|} \mathrm{d}x \mathrm{d}p = \left(\widetilde{p}_i^{\mathbf{A}}\right)^2 + V(\widetilde{x}_i)$$

and we have, using Assumption 1.1 to control the variations of \mathbf{A}_e ,

$$\begin{aligned} \left| \int_{S_L} \left((p^{\mathbf{A}})^2 + V(x) \right) \mathrm{d}(\operatorname{Ave}\left[\operatorname{Emp}_{Z_N}\right] - \mu) \right| &\leq \frac{1}{N} \sum_{i \in G_N} \left| \left((p_i^{\mathbf{A}})^2 - (\tilde{p}_i^{\mathbf{A}})^2 + V(x_i) - V(\tilde{x}_i) \right) \right| \\ &\leq \frac{C}{N} \sum_{i \in G_N} \left(\sup_{z = (x, p) \in \Omega_{m(i)}} l_p |p| + l_x \sup_{z = (x, p) \in \Omega_{m(i)}} |\nabla V(x)| \right) + Cl_x \\ &= \frac{C}{N} \sum_{\Omega_m \subset S_L} \left(N_m l_p \sup_{z = (x, p) \in \Omega_m} |p| + N_m l_x \sup_{z = (x, p) \in \Omega_m} |\nabla V(x)| \right) + Cl_x \end{aligned}$$

where we denote

$$N_m := \sharp \{ z_i \in Z_N \cap \Omega_m \} \le C |\Omega_m|.$$

$$(4.40)$$

Since our assumptions imply that for any $\Omega_m \subset S_L$

$$N_m \le C |\Omega_m| \tag{4.41}$$

we may recognize Riemann sums and use Assumption 1.1 again to deduce

$$\begin{split} \left| \int_{S_L} \left((p^{\mathbf{A}})^2 + V(x) \right) \mathrm{d}(\operatorname{Ave}\left[\operatorname{Emp}_{Z_N}\right] - \mu) \right| \\ & \leq C l_p \int_{\mathbb{R}^4} |p| \mathrm{dAve}\left[\mu\right] + C l_x \int_{\mathbb{R}^4} |x|^{s-1} \mathrm{dAve}\left[\mu\right] + C l_p \\ & \leq C l_p \int_{\mathbb{R}^4} |p|^2 \mathrm{dAve}\left[\mu\right] + C l_x \int_{\mathbb{R}^4} V \mathrm{dAve}\left[\mu\right] + C l_x + C l_p \end{split}$$

using Young's inequality

$$r^{s-1} \le \frac{s-1}{s}r^s + \frac{1}{s}.$$

We next treat the two body operator W_{12} defined in (2.6) (undestanding now p as a momentum variable rather than an operator) in the same way. We set

$$\mathrm{d}x = \mathrm{d}x_1\mathrm{d}x_2, \quad \mathrm{d}p = \mathrm{d}p_1\mathrm{d}p_2.$$

By the mean-value theorem, for each $(x_i, p_i) \in \Omega_{m(i)}$ there exists some $\tilde{z}_i = (\tilde{x}_i, \tilde{p}_i) \in \Omega_{m(i)}$ such that

$$\int_{\mathbb{R}^8} W_{12} d\left(\operatorname{Ave}\left[\operatorname{Emp}_{Z_N}\right]^{\otimes 2} - (\mathbb{1}_{S_L}\mu)^{\otimes 2}\right) = \int_{S_L \times S_L} W_{12} \left[\mu^{\otimes 2} - \operatorname{Ave}\left[\operatorname{Emp}_{Z_N}\right]^{\otimes 2}\right] dxdp$$
$$= \frac{1}{N^2} \sum_{i \in G_N} \sum_{j \in G_N} \left[\left(p_i + \mathbf{A}_e(x_i)\right) \cdot \nabla^{\perp} w_R(x_i, x_j) - \left(\widetilde{p}_i + \mathbf{A}_e(\widetilde{x}_i)\right) \cdot \nabla^{\perp} w_R(\widetilde{x}_i, \widetilde{x}_j)\right]$$
(4.42)

Expanding the functions around the points \tilde{z}_i of the sum there exists a $c_i \in \Omega_{m(i)}$ such that

$$\begin{aligned} \left| \nabla^{\perp} w_R(x_i) - \nabla^{\perp} w_R(\widetilde{x}_i) \right| &\leq J_{\nabla w_R}(c_i) \cdot (x_i - \widetilde{x}_i) \\ |p_i - \widetilde{p}_i| &\leq l_p \end{aligned}$$

with $J_{\nabla w_R}$ the Jacobian matrix of ∇w_R . We denote

$$W = \partial_u^2 w_R \tag{4.43}$$

where ∂_u is the radial derivative explicitly calculated in (B.8). We then use (B.1) and estimate

$$\left| \int_{\mathbb{R}^{8}} W_{12} d\left(\operatorname{Ave}\left[\operatorname{Emp}_{Z_{N}} \right]^{\otimes 2} - (\mathbb{1}_{S_{L}} \mu)^{\otimes 2} \right) \right| \\ \leq \frac{C}{N^{2}} \sum_{\Omega_{m} \subset S_{L}} \sum_{\Omega_{q} \subset S_{L}} l_{x} N_{m} N_{q} \sup_{z_{m} \in \Omega_{m}, z_{q} \in \Omega_{q}} |p_{m}| |W(x_{m} - x_{q})| \\ + \frac{C}{N^{2}} \sum_{\Omega_{m} \subset S_{L}} \sum_{\Omega_{q} \subset S_{L}} N_{m} N_{q} l_{p} \sup_{z_{m} \in \Omega_{m}, z_{q} \in \Omega_{q}} \left| \nabla^{\perp} w_{R} (x_{m} - x_{q}) \right|$$
(4.44)

where we used that \mathbf{A}_e and its derivatives are in L^{∞} by assumption and use the convention $z_i = (x_i, p_i)$ systematically. We denote

$$\overline{W_1}(x_1 - x_2) = \sup \{ |W(y_1 - y_2)|, y_1 \in \Omega_{m_x}(x_1), y_2 \in \Omega_{m_x}(x_2) \}$$
$$\overline{W_2}(x_1 - x_2) = \sup \{ |\nabla^{\perp} w_R(y_1 - y_2)|, y_1 \in \Omega_{m_x}(x_1), y_2 \in \Omega_{m_x}(x_2) \}$$
$$P(p_1) = \sup \{ |p|, p \in \Omega_{m_p}(p) \}$$

with $\Omega_{m_x}(x)$ the rectangle of our grid x belongs to, and similar notation. Hence

$$\begin{split} \left| \int_{\mathbb{R}^8} W_{12} \operatorname{d} \left(\operatorname{Ave} \left[\operatorname{Emp}_{Z_N} \right]^{\otimes 2} - (\mathbb{1}_{S_L} \mu)^{\otimes 2} \right) \right| \\ & \leq C l_x \iint_{\mathbb{R}^8} P(p_1) \overline{W_1}(x_1 - x_2) \operatorname{Ave}[\mu](x_1, p_1) \operatorname{Ave}[\mu](x_2, p_2) \operatorname{d} x_1 \operatorname{d} x_2 \operatorname{d} p_1 \operatorname{d} p_2 \\ & + C l_p \iint_{\mathbb{R}^8} \overline{W_2}(x_1 - x_2) \operatorname{Ave}[\mu](x_1, p_1) \operatorname{Ave}[\mu](x_2, p_2) \operatorname{d} x_1 \operatorname{d} x_2 \operatorname{d} p_1 \operatorname{d} p_2 =: \mathrm{I} + \mathrm{II} \mathrm{I$$

A Riemann sum argument using the properties of W (see (B.8)) gives

$$\begin{split} \mathbf{I} &\leq C l_x \int_{\mathbb{R}^4} |p_1| \operatorname{Ave}[\mu](x_1, p_1) \int_{\mathbb{R}^2} \left(\frac{1}{R} |\nabla w_0(x_1 - x_2)| + \frac{1}{R^2} \mathbb{1}_{|x_1 - x_2| \leq R} \right) \rho_{\operatorname{Ave}[\mu]}(x_2) \mathrm{d}x_2 \mathrm{d}x_1 \mathrm{d}p_1 \\ &\leq C \frac{l_x}{R} \left\| \rho_{\operatorname{Ave}[\mu]} \right\|_{L^2} \int |p| \operatorname{Ave}[\mu](x, p) \mathrm{d}x \mathrm{d}p \\ &\leq C \frac{l_x}{R} \left\| \rho_{\operatorname{Ave}[\mu]} \right\|_{L^2} \left(\int |p|^2 \operatorname{Ave}[\mu](x, p) \mathrm{d}x \mathrm{d}p \right)^{1/2} \end{split}$$

where we also used the weak Young and the Cauchy-Schwarz inequality. Similarly, since $\nabla w_R \in L^{2,w}$,

$$\mathrm{II} \leq Cl_p \iint_{\mathbb{R}^4} \left| \nabla w_R(x_1 - x_2) \right| \rho_{\mathrm{Ave}[\mu](x_1)} \rho_{\mathrm{Ave}[\mu](x_2)} \mathrm{d}x_1 \mathrm{d}x_2 \leq Cl_p \left\| \rho_{\mathrm{Ave}[\mu]} \right\|_{L^2}.$$

We next turn to the three-body term (2.7)

$$\operatorname{III} := \left| \int_{\mathbb{R}^{12}} W_{123} \mathrm{d} \left(\left(\mathbb{1}_{S_L} \mu \right)^{\otimes 3} - \operatorname{Ave} \left[\operatorname{Emp}_{Z_N} \right]^{\otimes 3} \right) \right|$$

with

$$W_{123} = \nabla^{\perp} w_R (x_1 - x_2) \nabla^{\perp} w_R (x_1 - x_3).$$

We denote (with W as in (4.43))

$$G(x_1, x_2, x_3) = |W(x_1 - x_2)| \left| \nabla^{\perp} w_R(x_1 - x_3) \right| + \left| \nabla^{\perp} w_R(x_1 - x_2) \right| |W(x_1 - x_3)|$$

$$\overline{G}(x_1, x_2, x_3) = \sup \left\{ G(x_1, x_2, x_3) \right\} = \sum_{n=1}^{\infty} \left\{ G(x_1, x_2, x_3) \right\}$$

$$G(x_1, x_2, x_3) = \sup \{ G(y_1, y_2, y_3), y_1 \in \Omega_{m_x}(x_1), y_2 \in \Omega_{m_x}(x_2), y_3 \in \Omega_{m_x}(x_3) \}$$

and observe that G gives a pointwise upper bound to gradients of W_{123} in any variable. Hence, arguing as above

$$\begin{aligned} \operatorname{III} &\leq C l_x \int_{R^6} \overline{G}(x_1, x_2, x_3) \rho_{\operatorname{Ave}[\mu]}(x_1) \rho_{\operatorname{Ave}[\mu]}(x_2) \rho_{\operatorname{Ave}[\mu]}(x_3) \mathrm{d}x_1 \mathrm{d}x_2 \mathrm{d}x_3 \\ &\leq C \frac{l_x}{R} \left\| \rho_{\operatorname{Ave}[\mu]} \right\|_{L^2}^2 \end{aligned}$$

where we used the weak Young inequality twice. Collecting the previous inequalities we conclude

$$\begin{aligned} \mathcal{E}_{V}^{R}\left[\mu\right] &\geq (1-\sigma)\mathcal{E}_{V}^{R}\left[\operatorname{Ave}[\mu]\right] - C(l_{x}+l_{p}) \\ &- C\frac{l_{x}}{R} \left\|\rho_{\operatorname{Ave}[\mu]}\right\|_{L^{2}} \left(\left\|\rho_{\operatorname{Ave}[\mu]}\right\|_{L^{2}} + \left(\int |p|^{2} \mathrm{dAve}[\mu]\right)^{1/2}\right) \\ &- Cl_{p} \left\|\rho_{\operatorname{Ave}[\mu]}\right\|_{L^{2}} - C\frac{D^{2}}{\sigma R^{2} \inf(L^{4}, L^{2s})} \end{aligned}$$

$$\geq (1-\sigma)\mathcal{E}_V^R[\operatorname{Ave}[\mu]] - o_N(1) - o_N(1) \int |p|^2 \mathrm{dAve}[\mu] - C \frac{D^2}{\sigma R^2 \inf(L^4, L^{2s})},$$

inserting our assumptions on the various parameters involved. We have also used the fact that, since

$$\operatorname{Ave}[\mu] \le \frac{1+\varepsilon}{2\pi^2},\tag{4.45}$$

the bathtub principle [34, Theorem 1.14] implies that

$$\int |p|^2 \mathrm{dAve}[\mu] \ge C_{\varepsilon} \left\| \rho_{\mathrm{Ave}[\mu]} \right\|^2.$$

Finally, arguing as in Appendix A below (using (4.45) again),

$$\mathcal{E}_{V}^{R}\left[\operatorname{Ave}[\mu]\right] \geq \frac{1}{2} \int |p|^{2} \mathrm{dAve}[\mu] - C \left\|\rho_{\operatorname{Ave}[\mu]}\right\|^{2}$$

and we can absorb an error term in the main term to obtain

$$\mathcal{E}_{V}^{R}[\mu] \ge (1-\sigma)(1-o_{N}(1))\mathcal{E}_{V}^{R}[\operatorname{Ave}[\mu]] - o_{N}(1) - o_{N}(1) \left\| \rho_{\operatorname{Ave}[\mu]} \right\|^{2} - C \frac{D^{2}}{\sigma R^{2} \inf(L^{4}, L^{2s})}.$$

A last use of the bathtub principle gives

$$\mathcal{E}_{V}^{R}\left[\operatorname{Ave}[\mu]\right] \geq C \left\|\rho_{\operatorname{Ave}[\mu]}\right\|^{2}$$

Thus the proof is concluded by absorbing one last error term in the main expression. \Box

4.4. Convergence of the energy. Going back to our lower bound (4.20), assuming $R = N^{-\eta}, 0 < \eta < 1/4$, we have

$$\frac{E^{R}(N)}{N} = \frac{\left\langle \Psi_{N}, H_{N}^{R}\Psi_{N} \right\rangle}{N} \\
\geq \int_{\mathcal{P}(\mathbb{R}^{4})} \mathcal{E}_{V}^{R}[\mu] \mathrm{d}P_{m_{N}}^{\mathrm{DF}}(\mu) - o_{N}(1) \\
\geq \int_{\Gamma_{\varepsilon}^{c} \cap \Xi_{\tau}} \mathcal{E}_{V}^{R}[\mu] \mathrm{d}P_{m_{N}}^{\mathrm{DF}}(\mu) - o_{N}(1)$$
(4.46)

where

$$\mathcal{E}_{V}^{R}[\mu] = \int_{\mathbb{R}^{4}} \left(\left| p^{\mathbf{A}} + \mathbf{A}^{R}[\mu](x) \right|^{2} + V(x) \right) \mathrm{d}\mu, \qquad (4.47)$$

 Γ^{ε} is as in (4.31),

$$\Xi_{\tau} = \left\{ \mu \in \mathcal{P}(\mathbb{R}^4) \int_{\mathbb{R}^4} \left(|p|^2 + V(x) \right) \mathrm{d}\mu(x, p) \le \frac{\tau}{R^2} \right\},\$$

and we have used the positivity of the integrand to go to the second line of (4.46). We next pick l_x, l_p to enforce

$$l_x \ll R, \quad l_p \ll 1, \quad l_x^2 l_p^2 = N^{-\beta}$$

for some $\beta < 1$. This is certainly compatible with our other requirements, since $R \gg N^{-1/4}$ by assumption. We can then use Theorem 4.9 to deduce

$$\frac{E^{R}(N)}{N} \ge (1 - \sigma)(1 - o_{N}(1)) \int_{\Gamma_{\varepsilon}^{c} \cap \Xi_{\tau}} \mathcal{E}_{V}^{R} \left[\operatorname{Ave}[\mu]\right] dP_{m_{N}}^{\mathrm{DF}}(\mu) - o_{N}(1) - C \frac{\tau^{2}}{\sigma R^{6} \inf(L^{4}, L^{2s})}.$$
(4.48)

Next, denote, for some $\gamma > 0$

$$\Theta_{\gamma} = \left\{ \mu \in \mathcal{P}(\mathbb{R}^4) \text{ such that } \int_{S_L^c} \mu < \gamma \right\}$$
(4.49)

the set of measures whose mass lie mostly in S_L and note that, as per Lemmas A.3 and A.4,

$$\mathcal{E}_V^R[\operatorname{Ave}[\mu]] \ge (1 - CR)(1 - 2\varepsilon)(1 - \gamma)e_{\operatorname{TF}}$$

for any $\mu \in \Gamma_{\varepsilon}^{c} \cap \Theta_{\gamma}$. Clearly, if we set

$$\gamma = c \frac{\tau}{R^2 \inf(L^2, L^{2s})} \tag{4.50}$$

with a suitable c > 0 we have that

$$\Theta_{\gamma} \subset \Xi_{\tau}$$

Hence, with this choice,

$$\frac{E^{R}(N)}{N} \geq (1 - CR)(1 - 2\varepsilon)(1 - \gamma)(1 - \sigma)(1 - o_{N}(1))e_{\mathrm{TF}} \int_{\Gamma_{\varepsilon}^{c} \cap \Xi_{\tau}} \mathrm{d}P_{m_{N}}^{\mathrm{DF}}(\mu) - o_{N}(1)
- \frac{C\tau^{2}}{\sigma R^{6} \inf(L^{2}, L^{2s})}
\geq (1 - 2\varepsilon)(1 - \gamma)(1 - \sigma)(1 - o_{N}(1))e_{\mathrm{TF}} \left(1 - \mathbb{P}_{m_{N}}^{\mathrm{DF}}(\Gamma_{\varepsilon}) - \mathbb{P}_{m_{N}}^{\mathrm{DF}}(\Xi_{\tau}^{c})\right)
- \frac{C\tau^{2}}{\sigma R^{6} \inf(L^{2}, L^{2s})},$$
(4.51)

with a self-explanatory notation for $\mathbb{P}_{m_N}^{\text{DF}}$. There remains to estimate the probability of the "bad events" in the last inequality. First, there is a $\delta > 0$ such that

$$\mathbb{P}_{m_N}^{\mathrm{DF}}\left(\Gamma_{\varepsilon}\right) = \mathbb{P}_{m_N}^{\mathrm{DF}}\left(\bigcup_{S_K \in S_L} \left\{ \mathrm{Emp}_{Z_N}, \int_{\Omega_k} \mathrm{Emp}_{Z_N} \ge \frac{(1+\varepsilon)}{(2\pi)^2} |\Omega_k| \right\} \right)$$
$$\leq \sum_{k=1}^{16n^4} \mathbb{P}_{m_N}^{\mathrm{DF}}\left(\left\{ \mathrm{Emp}_{Z_N}, \int_{\Omega_k} \mathrm{Emp}_{Z_N} \ge \frac{(1+\varepsilon)}{(2\pi)^2} |\Omega_k| \right\} \right)$$
$$\leq C_{\delta} L^4 N^{\beta} e^{-c_{\delta} N^{\delta} \ln(1+\varepsilon)}. \tag{4.52}$$

We used the union bound, the bound on the probability of violating the Pauli principle in a single box from Theorem 4.4 and the relation (4.32).

On the other hand, using Markov's inequality, (3.1), Lemma 3.2 and (4.6) we find

$$\mathbb{P}_{m_{N}}^{\mathrm{DF}}(\Xi_{\tau}) \leq R^{2} \tau^{-1} \int_{\mathcal{P}(\mathbb{R}^{4})} \left(\int_{\mathbb{R}^{4}} \left(|p|^{2} + V(x) \right) \mathrm{d}\mu(x,p) \right) \mathrm{d}P_{m_{N}}^{\mathrm{DF}}(\mu) \\ = CR^{2} \tau^{-1} \int_{\mathbb{R}^{4}} \left(|p|^{2} + V(x) \right) \mathrm{d}m_{N}^{(1)}(x,p) \\ \leq C \tau^{-1}.$$
(4.53)

There remains to insert (4.52) and (4.53) in (4.51). We can now set $L = N^{\kappa}$ with $\kappa > 0$ a suitably large, fixed number and $\tau = N^{\kappa'}$ with κ' a suitably small, fixed number. This makes all errors depending on N negligible because, crucially, (4.52) contains an exponentially small term in N. In particular, recalling (4.50), $\gamma \to 0$ with such a choice of a parameters. Hence we can pass to the limit in (4.51), first letting $N, R^{-1}, L \to \infty$ with the previously specified scalings, and finally let $\varepsilon, \sigma \to 0$, obtaining the energy lower bound claimed in 1.1, matching the upper bound from Section 2.

4.5. Convergence of states. We turn to the proof of Theorem 1.4. Coming back to (4.48) and inserting the previous choice of parameters we have that

$$e^{\mathrm{TF}} \ge (1-\sigma)(1-o_N(1)) \int_{\mathcal{P}(\mathbb{R}^4)} \mathbb{1}_{\Xi_{\tau}}(\mu) \mathbb{1}_{\Gamma_{\varepsilon}^c}(\mu) \mathcal{E}_V \left[\operatorname{Ave}\left[\mu\right]\right] \mathrm{d}P_{m_N}^{\mathrm{DF}}(\mu) - o_N(1)(1+\sigma^{-1}).$$
(4.54)

It follows from (4.54) and results of Appendix A that $m_N^{(1)}$ is tight. Applying the last part of Theorem 4.1 we thus obtain that the Diaconis-Freedman measure that $P_{m_N}^{\rm DF}$ weakly converges to a probability measure $P \in \mathcal{P}(\mathcal{P}(\mathbb{R}^4))$ (this is the Hewitt-Savage measure). It follows from Theorem 4.4 (or [20, Theorem 2.6]) that P is concentrated on probability measures satisfying $\mu \leq (2\pi)^{-2}$. Combining with Lemma 3.3 and (4.12) we have that, for any fixed $k \geq 0$

$$\frac{1}{(2\pi)^{2k}} m_{\Psi_N}^{(k)} \xrightarrow[N \to \infty]{} \int_{\mathcal{P}(\mathbb{R}^4)} \mu^{\otimes k} \mathrm{d}P(\mu)$$

weakly as measures. We now identify the limit measure P to conclude the proof of Theorem 1.4.

To this aim it is convenient to write the integral above as

$$\int_{\mathcal{P}(\mathbb{R}^4)} \mathbb{1}_{\Xi_{\tau}}(\mu) \mathbb{1}_{\Gamma_{\varepsilon}^c}(\mu) \mathcal{E}_V \left[\operatorname{Ave}\left[\mu\right]\right] \mathrm{d}P_N^{\mathrm{DF}}(\mu) = \int_{\mathcal{P}(\mathbb{R}^4)} \mathcal{E}_V \left[\operatorname{Ave}\left[\mu\right]\right] \mathrm{d}Q_N(\mu) \tag{4.55}$$

with

$$dQ_N[\mu] := \mathbb{1}_{\Xi_\tau}(\mu) \mathbb{1}_{\Gamma_\varepsilon^c}(\mu) dP_N^{\rm DF}(\mu).$$
(4.56)

We will see $\mathcal{E}_{V}[\operatorname{Ave}[\mu]]$ as a lower semi-continuous function on the space $(\mathcal{P}(\mathbb{R}^{4}), d_{1}^{W})$ where

$$d_1^W = \sup_{\|\phi\|_{\text{Lip}} \le 1} \left| \int_{\mathbb{R}^4} \phi d\mu - \int_{\mathbb{R}^4} \phi d\nu \right|$$

is the Monge-Kantorovitch-Wasserstein distance, known to metrize the weak convergence of measures [62, Theorem 6.9] (and we use Kantorovitch-Rubinstein duality [62, Remark 6.5]). We have

Lemma 4.10 (Limit of Ave).

Let $\mu \in \mathcal{P}(\mathbb{R}^4)$. In the d_1^W metric,

Ave
$$[\mu] = \sum_{m=1}^{16n^4} \mathbb{1}_{\Omega_m} \int_{\Omega_m} \frac{\mathrm{d}\mu}{|\Omega_m|} \to \mu,$$
 (4.57)

when $N \to \infty$ and $L \to \infty$.

Proof. We pick a function $\phi, \, \|\nabla \phi\|_{L^\infty} \leq 1$ and denote

$$\mathbf{a}\left[\phi\right]_{m} = \int_{\Omega_{m}} \frac{\phi(x,p)}{|\Omega_{m}|} \mathrm{d}x \mathrm{d}p$$

its average over a box Ω_m . We have that, for any $x \in \Omega_m$,

$$|\phi(x) - \mathbf{a} [\phi]_m| \le C l \, \|\nabla\phi\|_{L^{\infty}} \tag{4.58}$$

where $l = \max(l_x, l_p)$ is the largest dimension of the box Ω_m . We thus have

$$\int_{\mathbb{R}^4} \phi(x) \mathrm{dAve}\left[\mu\right] = \sum_m^{16n^4} \int_{\Omega_m} \mathbf{a}\left[\phi\right]_m \mathrm{d}\mu = \sum_m \int_{\Omega_m} \phi \mathrm{d}\mu + o_N(1)$$

where the $o_N(1)$ is uniform in $\|\nabla \phi\|_{L^{\infty}}$ by (4.58).

It follows that, if we take a sequence $\mu_n \to \mu$ when $N \to \infty$,

$$d_1^W (\operatorname{Ave}[\mu_n], \mu) \le d_1^W (\operatorname{Ave}[\mu_n], \mu') + d_1^W (\mu_n, \mu) \le o_N(1)$$

Hence, combining with Lemma (A.1), we deduce

$$\liminf_{N \to \infty, \, \mu' \to \mu} \mathcal{E}_V \left[\operatorname{Ave} \left[\mu' \right] \right] \ge \mathcal{E}_V \left[\mu \right]. \tag{4.59}$$

We turn to the convergence of Q_N defined in (4.56). For any continous bounded function $\Phi \in C_b(\mathcal{P}(\mathbb{R}^4))$ over probability measures,

$$\left| \int_{\mathcal{P}(\mathbb{R}^4)} \Phi(\mu) \left(\mathrm{d}Q_N(\mu) - \mathrm{d}P_{m_N}^{\mathrm{DF}}(\mu) \right) \right| \underset{N \to \infty}{\to} 0$$

by (4.52) and (4.53). Hence, applying Theorem 4.1 we have that

$$Q_N \to P$$

as measures over $\mathcal{P}(\mathbb{R}^4)$, where *P* is the limit of the Diaconis-Freedman measure. Combining with (4.59) we may apply the improved Fatou Lemma of [19, Theorem 1.1] to (4.55), obtaining

$$\liminf_{N \to \infty} \int_{\mathcal{P}(\mathbb{R}^4)} \mathcal{E}_V \left[\operatorname{Ave} \left[\mu \right] \right] \mathrm{d}Q_N(\mu) \ge \int_{\mathcal{P}(\mathbb{R}^4)} \mathcal{E}_V \left[\mu \right] \mathrm{d}P(\mu).$$

Combining with (4.54) and letting $\sigma \to 0$ after $N \to \infty$ we conclude

$$e^{\mathrm{TF}} \ge \int_{\mathcal{P}(\mathbb{R}^4)} \mathcal{E}_V[\mu] \,\mathrm{d}P(\mu).$$

Recall that P is concentrated on probability measures satisfying $\mu \leq (2\pi)^{-2}$ and that e^{TF} is the infimum of $\mathcal{E}_V[\mu]$ over those. Hence P must be concentrated on the unique minimizer of $\mathcal{E}_V[\mu]$, and this concludes the proof.

Appendix A. Properties of the Vlasov functional

In this appendix we etablish some of the fundamental properties of the functionnal \mathcal{E}_V and some useful bounds on the vector potential $\mathbf{A}^R[\rho]$ associated to a measure ρ .

Lemma A.1 (Lower semicontinuity of \mathcal{E}_V).

Let $(\mu_n)_{n\geq 0}$ be a sequence of positive measures on \mathbb{R}^4 satisfying

$$0 \le \mu_n \le (2\pi)^{-2}, \quad \int_{\mathbb{R}^4} \mu_n \le C$$

with C independent of N. If μ_n converges to μ as measures we have

$$\liminf_{n \to \infty} \mathcal{E}_V[\mu_n] \ge \mathcal{E}_V[\mu]. \tag{A.1}$$

Proof. We recall that the marginal in p of μ_n is

$$\rho_n(x) = \int_{\mathbb{R}^2} \mu_n(x, p) \mathrm{d}p \tag{A.2}$$

It follows from applying the bathtub principle [34, Theorem 1.14] in the p variable that

$$\mathcal{E}_{V}\left[\mu_{n}\right] \geq \mathcal{E}_{V}^{\mathrm{TF}}\left[\rho_{n}\right] := 2\pi \int_{\mathbb{R}^{2}} \rho_{n}^{2}(x) \mathrm{d}x + \int_{\mathbb{R}^{2}} V(x)\rho_{n}(x) \mathrm{d}x$$

Hence we may assume that $\|\rho_n\|_{L^2}$ is uniformly bounded and that $\rho_n \rightarrow \rho$ weakly in $L^2(\mathbb{R}^2)$. We then deduce from the weak Young inequality [34, Chapter 4] that

$$\left\|\mathbf{A}^{2}[\rho_{n}]\rho_{n}\right\|_{L^{1}} \leq \int_{\rho_{n}} \left\|\nabla^{\perp}w * \rho_{n}\right\|_{L^{\infty}}^{2} \leq C \left\|\rho_{n}\right\|_{L^{2}}^{2} \left\|\nabla^{\perp}w\right\|_{L^{2,w}}^{2} \leq C.$$

We recall that the weak $L^p(\mathbb{R}^d)$ space is the set of functions

$$L^{w,2} = \left\{ f \mid \text{Leb}\left(\left\{x \in \mathbb{R}^d : |f(x)| > \lambda\right\}\right) \le \left(\frac{C}{\lambda}\right)^p \right\}$$

with the associated norm

$$\|f\|_{L^{w,2}} = \sup_{\lambda > 0} \lambda \operatorname{Leb} \left(x \in \mathbb{R}^d, \; |f(x)| > \lambda \right)^{1/2}$$

where Leb is the Lebesgue measure. We expand the energy

$$\mathcal{E}_{V}\left[\mu_{n}\right] = \int_{\mathbb{R}^{4}} \left(\left(p^{\mathbf{A}}\right)^{2} + 2p^{\mathbf{A}} \cdot \mathbf{A}[\rho_{n}] + \mathbf{A}^{2}[\rho_{n}] + V\right) \mu_{n}(x, p) \mathrm{d}x \mathrm{d}p \tag{A.3}$$

and use that

$$ab \leq \frac{a^2}{2\sigma} + \frac{\sigma b^2}{2}$$

to get

$$2(p^{\mathbf{A}}) \cdot \mathbf{A}[\rho_n] \ge -\sigma |p^{\mathbf{A}}|^2 - \frac{1}{\sigma} |\mathbf{A}[\rho_n]|^2$$

and hence

$$\mathcal{E}_{V}\left[\mu_{n}\right] + C \left\|\mathbf{A}^{2}\left[\rho_{n}\right]\rho_{n}\right\|_{L^{1}} \geq C \int_{\mathbb{R}^{4}} \left(|p^{\mathbf{A}}|^{2} + V\right) \mathrm{d}\mu_{n}$$

Thus (μ_n) is tight and, up to extraction, converges strongly in $L^1(\mathbb{R}^4)$. In order to obtain the convergence of $\mathbf{A}^2[\rho_n]\mu_n$ we write

$$\rho_n(x_1)\rho_n(x_2)\mu_n(x_3, p_3) - \rho(x_1)\rho(x_2)\mu(x_3, p_3) = (\rho_n(x_1) - \rho(x_1))(\rho_n(x_2) - \rho(x_2))\mu_n(x_3, p_3) + (\rho_n(x_1) - \rho(x_1))\rho(x_2)\mu_n(x_3, p_3) + \rho(x_1)(\rho_n(x_2) - \rho(x_2))\mu_n(x_3, p_3) - \rho(x_1)\rho(x_2)(\mu_n(x_3, p_3) - \mu(x_3, p_3))$$
(A.4)

and treat each resulting term separately. The first term yields

$$\left\|\mathbf{A}^{2}[\rho_{n}-\rho]\mu_{n}\right\|_{L^{1}} \leq \left\|\mu_{n}\right\|_{L^{1}} \left\|\nabla^{\perp}w*(\rho_{n}-\rho)\right\|_{L^{\infty}}^{2} \leq \left\|\rho_{n}-\rho\right\|_{L^{2}}^{2} \left\|\nabla^{\perp}w\right\|_{L^{2,u}}^{2}$$

using that $||\mu_n||_{L^1} \leq C$ and the weak Young inequality. For the second term of (A.4)

$$\|\mathbf{A}[\rho_n - \rho]\mathbf{A}[\rho]\mu_n\|_{L^1} \le \|\mathbf{A}[\rho]\|_{L^{\infty}} \left\|\nabla^{\perp}w * (\rho_n - \rho)\right\|_{L^{\infty}} \le \|\rho\|_{L^2} \left\|\rho_n - \rho\|_{L^2} \left\|\nabla^{\perp}w\right\|_{L^{2,w}}^2$$

and for the last one

$$\left\|\mathbf{A}^{2}[\rho](\mu_{n}-\mu)\right\|_{L^{1}} \leq \left\|\mu_{n}-\mu\right\|_{L^{1}} \left\|\mathbf{A}^{2}[\rho]\right\|_{L^{\infty}} \leq \left\|\mu_{n}-\mu\right\|_{L^{1}} \left\|\nabla^{\perp}w\right\|_{L^{2,w}}^{2} \left\|\rho\right\|_{L^{2}}$$

For the cross term of (A.3), $p^{\mathbf{A}} \cdot \mathbf{A} \left[\rho_n \right] \mu_n$ we observe that

$$\|\mathbf{A}[\rho - \rho_n]\|_{L^2} \le \|\rho - \rho_n\|_{L^1} \left\|\nabla^{\perp} w\right\|_{L^{2,u}}$$

so $\mathbf{A}[\rho_n]$ converges strongly in L^2 . We have $||(p^{\mathbf{A}})^2 \mu_n||_{L^1} \leq C$ so $p^{\mathbf{A}}\mu_n$ converges weakly in L^2 and by weak-strong convergence we deduce that the cross term converges. We conclude using Fatou's lemma for V and the kinetic term

$$\liminf_{n \to \infty} \int_{\mathbb{R}^4} |p + \mathbf{A}_e(x)|^2 \mu_n(x, p) \mathrm{d}x \mathrm{d}p \ge \int_{\mathbb{R}^4} |p + \mathbf{A}_e(x)|^2 \mu(x, p) \mathrm{d}x \mathrm{d}p$$
$$\liminf_{n \to \infty} \int_{\mathbb{R}^2} V(x) \rho_n(x) \mathrm{d}x \ge \int_{\mathbb{R}^2} V(x) \rho(x) \mathrm{d}x$$

Lemma A.2 (Existence of minimizers).

There exists a minimizer for the problem

$$e^{\mathrm{TF}} = \inf \left\{ \mathcal{E}_{V}[\mu] \mid 0 \le \mu \le (2\pi)^{-2} \mid \int_{\mathbb{R}^{4}} \mu = 1 \right\}$$

Proof. We consider a minimizing sequence $(\mu_n)_n$ converging to a candidate minimizer μ_{∞} . By Lemma (A.1) we have

$$e^{\mathrm{TF}} = \inf_{n \to \infty} \mathcal{E}_V[\mu_n] \ge \mathcal{E}_V[\mu_\infty]$$

We also found during the previous proof that $(\mu_n)_n$ must be tight, hence

$$\int_{\mathbb{R}^4} \mu_{\infty} = 1.$$

Lemma A.3 (Convergence to \mathcal{E}_V when $R \to 0$). For any measure $\mu \leq (2\pi)^{-2}$ such that $\int_{\mathbb{R}^4} \mu \leq C$ we have that

$$\left|\mathcal{E}_{V}^{R}[\mu] - \mathcal{E}_{V}^{0}[\mu]\right| \leq CR \left(\mathcal{E}_{V}^{0}[\mu] + \mathcal{E}_{V}^{R}[\mu]\right)$$

where

$$\mathcal{E}_{V}^{R}[\mu] = \int_{\mathbb{R}^{4}} \left(p^{\mathbf{A}} + \mathbf{A}^{R}[\mu](x) \right)^{2} + V(x) \mathrm{d}\mu$$

Proof.

$$\begin{aligned} \left| \mathcal{E}_{V}^{R}[\mu] - \mathcal{E}_{V}^{0}[\mu] \right| &= \left| \left\| \left(p^{\mathbf{A}} + \mathbf{A}^{R}[\mu](x) \right) \sqrt{\mu} \right\|_{L^{2}}^{2} - \left\| \left(p^{\mathbf{A}} + \mathbf{A}^{0}[\mu](x) \right) \sqrt{\mu} \right\|_{L^{2}}^{2} \right| \\ &\leq \left| \left\| \left(p^{\mathbf{A}} + \mathbf{A}^{R}[\mu](x) \right) \sqrt{\mu} \right\|_{L^{2}} - \left\| \left(p^{\mathbf{A}} + \mathbf{A}^{0}[\mu](x) \right) \sqrt{\mu} \right\|_{L^{2}} \right| \\ &\cdot \left(\mathcal{E}_{V}^{R}[\mu]^{1/2} + \mathcal{E}_{V}[\mu]^{1/2} \right) \\ &\leq \left\| \left(\mathbf{A}^{R}[\mu] - \mathbf{A}[\mu] \right) \sqrt{\mu} \right\|_{L^{2}} \left(\mathcal{E}_{V}^{R}[\mu]^{1/2} + \mathcal{E}_{V}[\mu]^{1/2} \right) \end{aligned}$$

where we have used the triangle inequality. Moreover we have that

$$\left\| \left(\mathbf{A}^{R} \left[\mu \right] - \mathbf{A} \left[\mu \right] \right)^{2} \rho \right\|_{L^{1}}^{1/2} \leq \|\rho\|_{L^{1}}^{1/2} \left\| \left(\nabla^{\perp} w_{R} - \nabla^{\perp} w_{0} \right) * \rho \right\|_{L^{\infty}} \\ \leq \|\rho\|_{L^{2}} \left\| \nabla^{\perp} w_{R} - \nabla^{\perp} w_{0} \right\|_{L^{2,w}}$$

by the weak Young inequality and because

$$\int_{\mathbb{R}^2} \left(\int_{\mathbb{R}^2} \frac{1}{|x|} \chi(u) \mathrm{d}u - \int_{B(0,R)} \frac{1}{|x|} \chi(u) \mathrm{d}u \right) \mathrm{d}x \le \int_{B(0,2R)} \frac{1}{|x|} \mathrm{d}x = CR$$

Using that the minimizer in p

$$\mu^{\mathrm{TF}} = (2\pi)^{-2} \,\mathbbm{1}\left(|p^{\mathbf{A}} + \mathbf{A}[\rho]| \le \sqrt{4\pi\rho}\right)$$

is explicit we have

$$\mathcal{E}_{V}[\mu] \ge \mathcal{E}_{\mathrm{TF}}(\rho) = 2\pi \int_{\mathbb{R}^{2}} \rho^{2}(x) \mathrm{d}x + \int_{\mathbb{R}^{2}} V(x)\rho(x) \mathrm{d}x$$

and the minimization problem is now formulated in terms of

$$\rho(x) = \int_{\mathbb{R}^2} \mu(x, p) \mathrm{d}p.$$

This gives

$$\mathcal{E}_V[\mu] \ge C \, \|\rho\|_{L^2}^2$$

and concludes the proof.

Lemma A.4 (Dependence on the upper perturbed constraint).
The infimum of
$$\mathcal{E}_V$$
 does not depend on ε nor γ at first order

$$\inf\left\{\mathcal{E}_{V}[\mu] \mid 0 \leq \mu \leq \frac{1+\varepsilon}{(2\pi)^{2}}, \ \int \mu = 1-\gamma\right\} \geq (1-2\varepsilon)(1-\gamma)e_{\mathrm{TF}}$$

44

Proof. We calculate the infimum with the Bathtub principle [34, Theorem 1.14]. This infimum is achieved for

$$\mu = \mu_{\varepsilon}^{\mathrm{TF}} = (2\pi)^{-2} \left(1 + \varepsilon\right) \mathbb{1} \left(|p^{\mathbf{A}} + \mathbf{A}[\rho]|^2 \le s(x) \right)$$

where $s(x) = \frac{4\pi\rho}{1+\varepsilon}$ because

$$\int_{\mathbb{R}^2} \mu^{\mathrm{TF}}(x, p) \mathrm{d}p = \rho(x) = \int_{\mathbb{R}^2} (1 + \varepsilon) \mathbb{1}\left(|p^{\mathbf{A}} + \mathbf{A}[\rho]| \le s(x) \right) \mathrm{d}p = \pi (1 + \varepsilon) s(x)$$

So, evaluating the energy

$$\mathcal{E}_{V}[\mu_{\varepsilon}^{\mathrm{TF}}] = \mathcal{E}_{\mathrm{TF}}^{\varepsilon}[\rho] = 2\pi \int_{\mathbb{R}^{2}} \frac{\rho^{2}(x)}{(1+\varepsilon)^{2}} \mathrm{d}x + \int_{\mathbb{R}^{2}} \frac{V(x)\rho(x)}{(1+\varepsilon)} \mathrm{d}x$$
(A.5)

but we can see that

$$\mathcal{E}_{\rm TF}^{\varepsilon}[\rho] \ge \mathcal{E}_{\rm TF}[\rho] \left(1 - 2\varepsilon\right) \tag{A.6}$$

where $\mathcal{E}_{TF}[\rho]$ is given in (1.19).

APPENDIX B. BOUNDS FOR \mathbf{A}^{R} .

Lemma B.1 (Bounds linked to \mathbf{A}^{R}).

Every element of the Jacobian matrix of

$$\nabla^{\perp} w_R(u_1, u_2) : \mathbb{R}^2 \to \mathbb{R}^2$$

is bounded in absolute value as follows

$$\left|J_{\nabla w_R}^{ij}(\vec{u})\right| \le C \left|\partial_u^2 w_R(u)\right| \tag{B.1}$$

we also have the estimates

$$\left\| \Delta \nabla^{\perp} w_R \right\|_{L^{\infty}} \le \frac{C}{R^3} \tag{B.2}$$

$$\left\|\nabla^{\perp} w_R\right\|_{L^{\infty}} \le \frac{C}{R} \tag{B.3}$$

$$\left\| \Delta \nabla^{\perp} w_R \right\|_2^2 \le \frac{C}{R^2} \tag{B.4}$$

$$||\nabla \left(\nabla^{\perp} w_R(u)\right)^i||_{L^{\infty}} \le \frac{C}{R^2}$$
(B.5)

$$||\nabla\left(\nabla^{\perp}w_{R}(u).\nabla^{\perp}w_{R}(v)\right)||_{L^{\infty}} \leq \frac{C}{R^{3}}$$
(B.6)

Proof. Recall that

$$w_R(x) = (\log \mid . \mid * \chi_R) (x)$$

with χ_R defined as in (1.8). We call u_1 and u_2 the two components of the vector \vec{u} and u its norm. Using Newton's theorem [34, Theorem 9.7] we write

$$w_R(u) = \int_{\mathbb{R}^2} \log |\vec{u} - \vec{v}| \chi_R(v) dv = 2\pi \log(u) \int_0^u \chi_R(r) r dr + 2\pi \int_u^{+\infty} r \log(r) \chi_R(r) dr$$

hence

$$\partial_{u} w_{R}(u) = \frac{1}{u} \int_{B(0,u)} \chi_{R}(v) dv$$

$$\partial_{u}^{2} w_{R}(u) = -\frac{1}{u^{2}} \int_{B(0,u)} \chi_{R}(v) dv + 2\pi \chi_{R}(u)$$
(B.7)

$$\partial_u^3 w_R(u) = \frac{1}{u^3} \int_{B(0,u)} \chi_R(v) dv + C \frac{\chi_R(u)}{u} + C \phi_R(u)$$
(B.8)

where $\phi_R(u) = \partial_u \chi_R(u)$ is bounded with compact support. We observe that regardless of whether u is smaller or greater than 2R we have

$$|\partial_u w_R(u)| \le \frac{C}{R}$$
 and $|\partial_u^2 w_R(u)| \le \frac{C}{R^2}$ (B.9)

and get (B.3). Moreover

$$\nabla^{\perp} w_R(u_1, u_2) = \nabla^{\perp} w_R(u) = \frac{\partial_u w_R(u)}{u} \vec{u}^{\perp}$$
(B.10)

We compute the two derivatives of the second component of (B.10)

$$\left| \partial_{u_1} \left(\frac{u_1}{u} \partial_u w_R \right) \right| = \left| \frac{\partial_u w_R}{u} + \frac{u_1^2}{u^2} \partial_u^2 w_R - \frac{u_1^2}{u^3} \partial_u w_R \right| \le \frac{C}{u^2} \int_{B(0,u)} \chi_R(v) dv + C \chi_R(u)$$
(B.11)
$$\left| \partial_{u_2} \left(\frac{u_1}{u} \partial_u w_R \right) \right| = \left| -\frac{u_1 u_2}{u^3} \partial_u w_R(u) + \frac{u_1 u_2}{u^2} \partial_u^2 w_R(u) \right| \le \frac{C}{u^2} \int_{B(0,u)} \chi_R(v) dv + C \chi_R(u)$$
(B.12)

we do the same with the first component of $\nabla^{\perp} w_R$ and get (B.1). If we differentiate once again we get

$$\left|\partial_{u_1}^2\left(\frac{u_1}{u}\partial_u w_R\right)\right| \le \frac{C}{u^3} \int_{B(0,u)} \chi_R(v) \mathrm{d}v + C\frac{\chi_R(u)}{u} + C\phi_R(u)$$

which is also the case for the other component and derivative. We deduce

$$\left\| \Delta \nabla^{\perp} w_R \right\|_{L^{\infty}} \le \frac{C}{R^3}$$

We can also compute

$$\left\| \Delta \nabla^{\perp} w_R \right\|_{L^2}^2 \leq \frac{C}{R^4}$$

which gives (B.4). To get (B.5) we combine (B.9) and (B.12). For the third inequality (B.6) we expand a little bit our first expression

$$\nabla^{\perp} w_R(u) \cdot \nabla^{\perp} w_R(v) = (u_1 v_1 + u_2 v_2) \frac{\partial_u w_R(u) \partial_v w_R(v)}{uv}$$

so the first component of the gradient is

$$\partial_{u_1} \nabla^{\perp} w_R(u) \cdot \nabla^{\perp} w_R(v) = v_1 \frac{\partial_u w_R(u) \partial_v w_R(v)}{uv} + \frac{u_1}{u} \partial_u \left[\frac{\partial_u w_R(u) \partial_v w_R(v)}{uv} \right] (u_1 v_1 + u_2 v_2)$$

Now

$$\left\|\nabla\left(\nabla^{\perp}w_{R}(u).\nabla^{\perp}w_{R}(v)\right)\right\|_{L^{\infty}}^{2} = \sum_{x=u_{1},u_{2},v_{1},v_{2}}\left(\partial_{x}\nabla^{\perp}w_{R}(u).\nabla^{\perp}w_{R}(v)\right)^{2}$$

The rest of the proof consists on the computation of the above term using basic inequalities. $\hfill\square$

Appendix C. Computations for squeezed coherent states

We give for completeness three proofs that we skipped in the main text.

Proof of Lemma (1.3). For any $u \in L^2(\mathbb{R}^2)$,

$$\langle F_{x,p}, u \rangle = \int_{\mathbb{R}^2} F_{\hbar_x}(y-x)u(y)e^{-i\frac{p\cdot y}{\hbar}}dy$$

= $2\pi\hbar\mathcal{F}_{\hbar}\left[F_{\hbar_x}(\cdot-x)u(\cdot)\right](p) = 2\pi\hbar\left(\mathcal{F}_{\hbar}\left[F_{\hbar_x}(\cdot-x)\right]*\mathcal{F}_{\hbar}\left[u(\cdot)\right]\right)(p)$ (C.1)
$$\int_{\mathbb{R}^2} G_{\mu\nu}(u-x)\mathcal{T}\left[u(\cdot)\right] = \frac{-i\frac{k\cdot x}{\hbar}}{\hbar}u = 2\pi\hbar\mathcal{T}\left[G_{\mu\nu}(u-x)\mathcal{T}\left[u(\cdot)\right]\right)(p)$$
 (C.2)

$$= \int_{\mathbb{R}^2} G_{\hbar_p}(k-p) \mathcal{F}_{\hbar}[u](k) e^{-\mathrm{i}\frac{k\cdot x}{\hbar}} \mathrm{d}k = 2\pi\hbar\mathcal{F}_{\hbar}\left[G_{\hbar_p}(\cdot-p)\mathcal{F}_{\hbar}[u]\right](x)$$
(C.2)

from we derive that

$$\frac{1}{(2\pi\hbar)^2} \int_{\mathbb{R}^2} \int_{\mathbb{R}^2} \langle \psi, P_{x,p}\psi \rangle \, \mathrm{d}x \mathrm{d}p = \frac{1}{(2\pi\hbar)^2} \int_{\mathbb{R}^2} \int_{\mathbb{R}^2} \int_{\mathbb{R}^2} |\langle F_{x,p}, u \rangle|^2 \mathrm{d}x \mathrm{d}p$$
$$= \int_{\mathbb{R}^2} \left(\int_{\mathbb{R}^2} |\mathcal{F}_{\hbar} \left[F_{\hbar_x}(\cdot - x)u(\cdot) \right](p)|^2 \, \mathrm{d}p \right) \mathrm{d}x$$
$$= \int_{\mathbb{R}^2} \left(\int_{\mathbb{R}^2} |F_{\hbar_x}(y - x)u(y)|^2 \, \mathrm{d}y \right) \mathrm{d}x$$
$$= ||F_{\hbar_x}||^2_{L^2(\mathbb{R}^2)} ||u||^2_{L^2(\mathbb{R}^2)} = ||u||^2_{L^2(\mathbb{R}^2)}.$$

Fourier transform of F.

We need to calculate the Fourier Transform of the Gaussian

$$G_{\hbar_p}(p) = \frac{1}{2\pi\hbar} \frac{\sqrt{\hbar_x}^2}{\sqrt{\hbar_x}} \frac{1}{\sqrt{\pi}} \left(\int_{\mathbb{R}} e^{-\frac{u^2}{2} - \frac{ipu}{\sqrt{\hbar_p}}} \mathrm{d}u \right)^2 = \frac{1}{2\pi\sqrt{\hbar_p}} \frac{1}{\sqrt{\pi}} G_1^2(p)$$

with

$$G_1(p) = \int_{\mathbb{R}} e^{-\frac{u^2}{2} - \frac{\mathrm{i}pu}{\sqrt{\hbar p}}} \mathrm{d}u$$

but we also have

$$\frac{\mathrm{d}G_1(p)}{\mathrm{d}p} = -\frac{p}{\hbar_p}G_1(p)$$

which gives the result.

Proof of Lemma 3.2. We use (C.2) and write for every fixed $y \in \mathbb{R}^{2(N-k)}$

$$\left\langle F_{x_1,p_1}(\cdot) \otimes \ldots \otimes F_{x_k,p_k}(\cdot), \Psi_N(\cdot,z) \right\rangle_{L^2(\mathbb{R}^{2k})}$$

= $(2\pi\hbar)^{2k} \mathcal{F}_{\hbar} \left[F_{x_1,0}(\cdot) \otimes \ldots \otimes F_{x_k,0}(\cdot) \Psi_N(\cdot,z) \right] (p_1,\ldots,p_k)$
= $(2\pi\hbar)^{2k} \mathcal{F}_{\hbar} \left[G_{0,p_1}(\cdot) \otimes \ldots \otimes G_{0,p_k}(\cdot) \mathcal{F}_{\hbar} \left[\Psi_N \right] (\cdot,z) \right] (x_1,\ldots,x_k).$

Next we sum over the p_j 's using (1.30):

$$\begin{split} &\frac{1}{(2\pi)^{2k}} \int_{\mathbb{R}^{2k}} m_{\Psi_N}^{(k)}(x_1, p_1, ..., x_k, p_k) \mathrm{d}p_1 ... \mathrm{d}p_k \\ &= \frac{k!}{(2\pi)^{2k}} \binom{N}{k} \int_{\mathbb{R}^{2k}} \mathrm{d}p_1 ... \mathrm{d}p_k \int_{\mathbb{R}^{2(N-k)}} \left| \left\langle F_{x_1, p_1}(\cdot) \otimes ... \otimes F_{x_k, p_k}(\cdot), \Psi_N(\cdot, z) \right\rangle \right|^2 \mathrm{d}z \\ &= k! \binom{N}{k} \int_{\mathbb{R}^{2k}} \mathrm{d}p_1 ... \mathrm{d}p_k \int_{\mathbb{R}^{2(N-k)}} \left| \mathcal{F}_{\hbar} \left[F_{x_1, 0}(\cdot) \otimes ... \otimes F_{x_k, 0}(\cdot) \Psi_N(\cdot, z) \right] (p_1, ..., p_k) \right|^2 \mathrm{d}z \\ &= k! \binom{N}{k} \int_{\mathbb{R}^{2k}} |F_{\hbar_x}(y_1 - x_1) ... F_{\hbar_x}(y_k - x_k) \Psi_N(y)|^2 \mathrm{d}y_1 ... \mathrm{d}y_N \\ &= k! \hbar^{2k} \rho_{\Psi_N}^{(k)} * \left(|F_{\hbar_x}|^2 \right)^{\otimes k} (x_1, ..., x_k). \end{split}$$

which gives (3.4). The proof of (3.5) is similar.
