## Goal

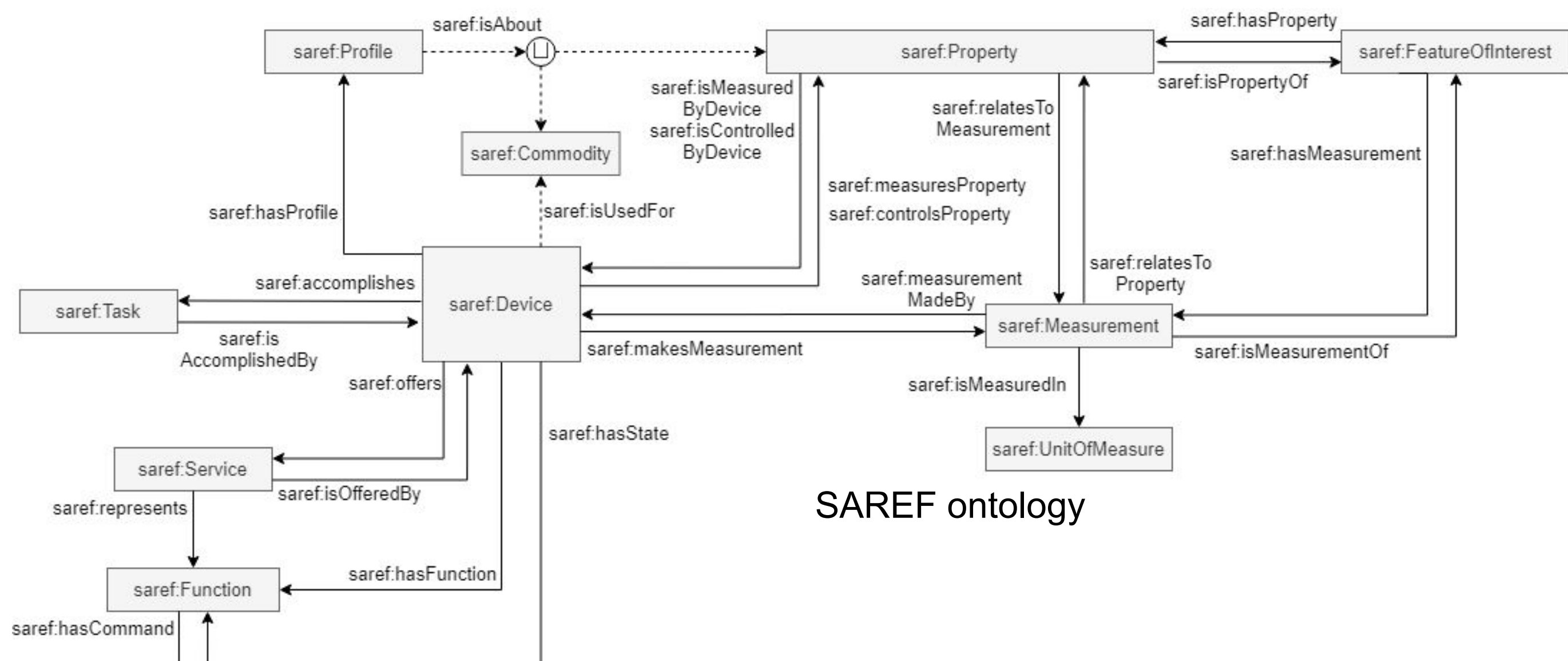
- The Web of Things (WoT) integrates Web standards with physical devices

- Limited CPU, Memory, Network, resources...

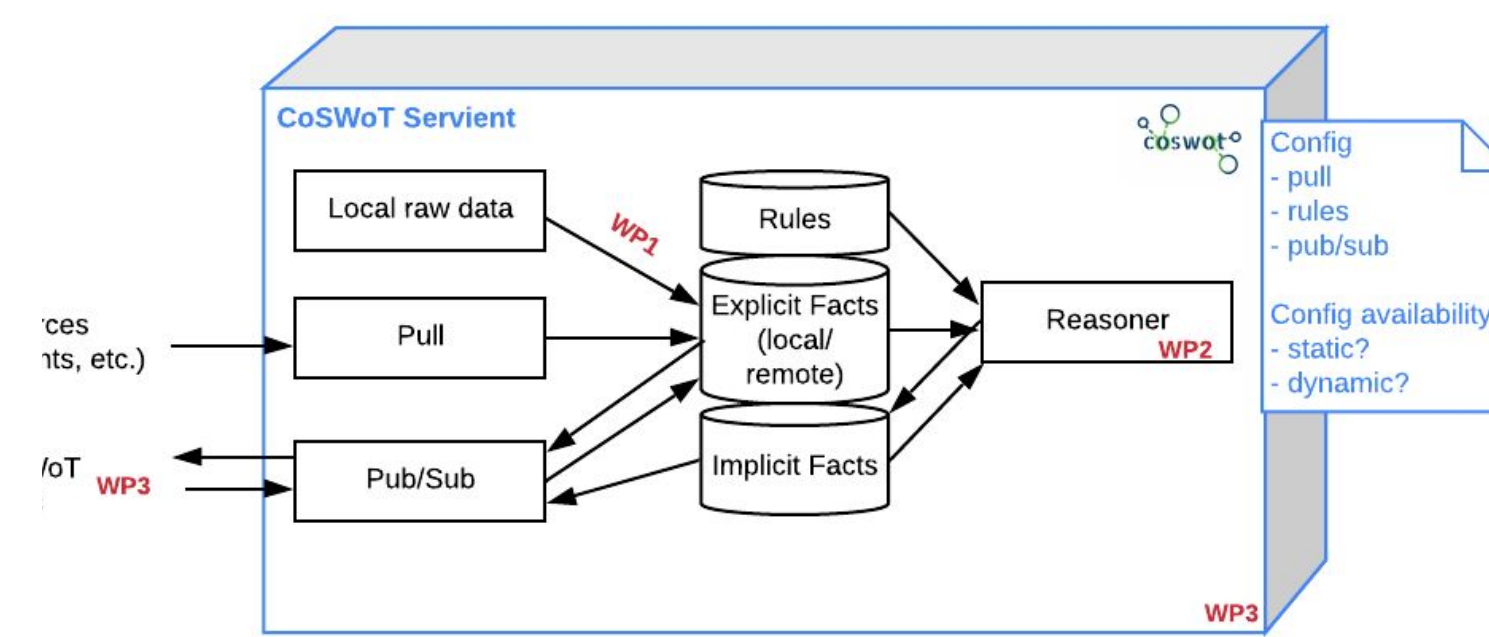


## Semantic Web technologies for Interoperability



Network of ontologies:

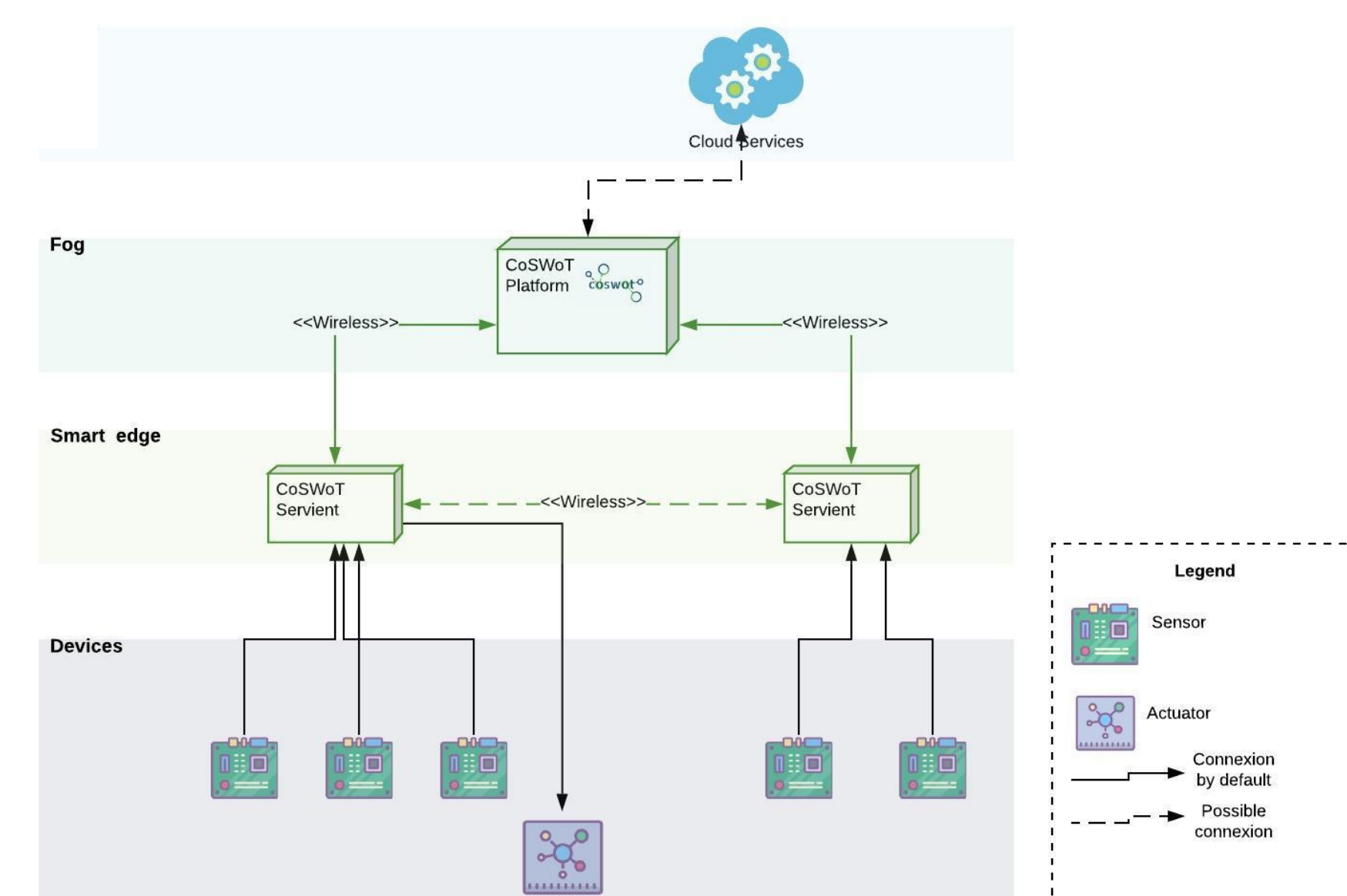
- Sensor Ontologies: SSN/SOSA, SAREF, CASO...

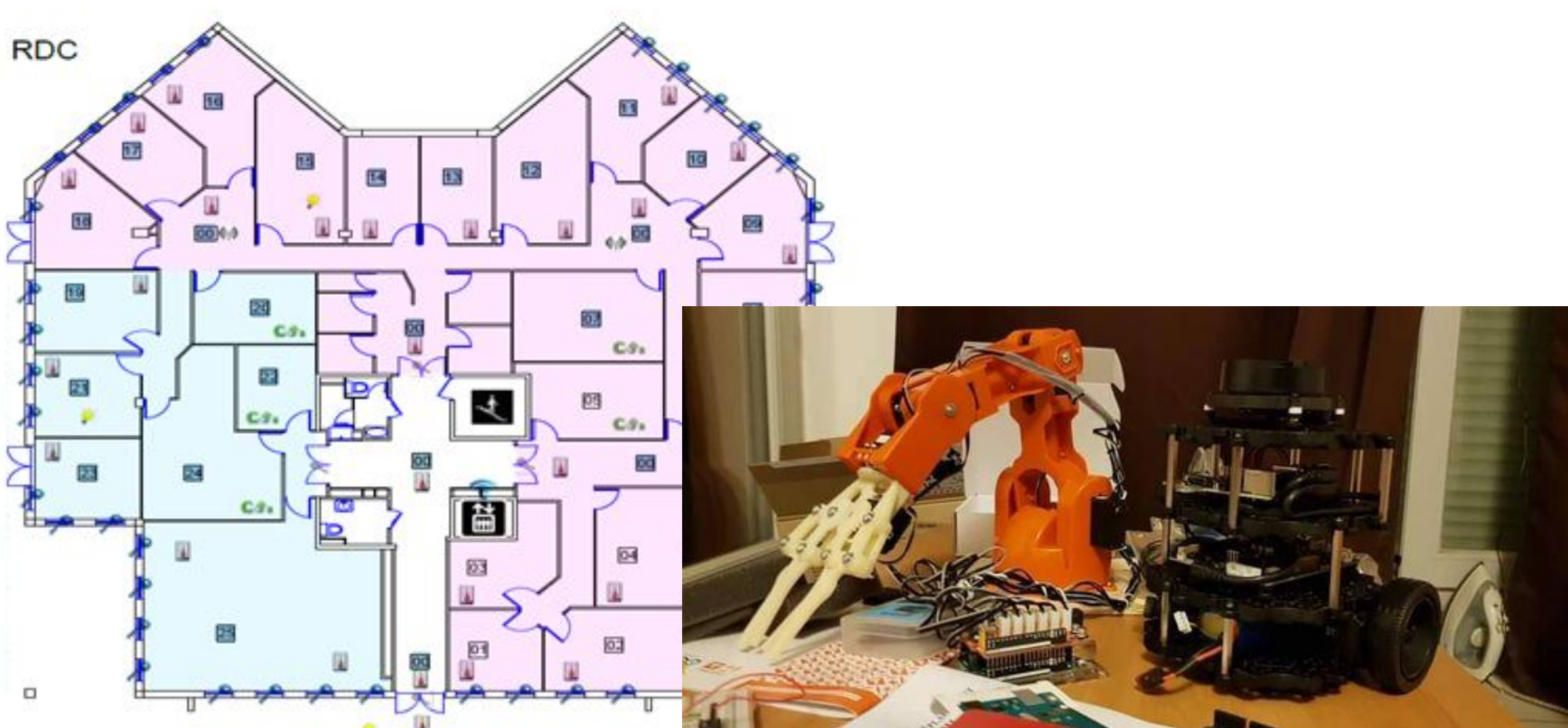
