#### 1 Stress response in terrestrial isopods: a comparative study on glycaemia

#### 14 Abstract

Stressors are omnipresent in the environment and trigger specific physiological and/or 15 behavioural responses that remain relatively less known in invertebrates. Among the 16 parameters used to quantify the impact of stress on physiology, the circulating level of 17 glucose is commonly used in aquatic crustacean species. Terrestrial isopods are small 18 crustaceans commonly used as bioindicators of soil quality; however, their response to 19 environmental stressors remains poorly documented. In laboratory conditions, we 20 investigated how different stressors influence the physiological response of two terrestrial 21 22 isopod species. Thus, we exposed Armadillidium vulgare and Porcellio dilatatus to a series 23 of both acute (physical) and chronic (temperature, social isolation, and exposure to herbicide) stressors that mimic potentially stressful situations encountered in their environment. Our 24 25 results revealed that, for both species, glycaemia is not impacted by thermic shock (1 h at 4°C), mechanical disturbances (1 minute of shaking or upside-down motion) or social 26 27 isolation (4 weeks) at the population level. Nevertheless, we observed a significantly higher 28 sensitivity in male P. dilatatus exposed to upside-down movements and in males of both 29 species exposed to social isolation. Acute (96 hours) and chronic (21 days) exposure to glyphosate (1.8-2.5 kg.ha<sup>-1</sup>) did not impact glycaemia levels in *A. vulgare*. However, at both 30 31 tested doses, individuals exposed to glyphosate for 25 days and subjected to an additional 32 stressor (haemolymph sampling at 96 hours) had significantly higher glycaemia in comparison to their control. Survival was also impacted by the joint application of chronic 33 glyphosate exposure and intermediate haemolymph sampling. We conclude that glucose is a 34 potentially good indicator to study the stress response of terrestrial isopods. Additional 35 studies for this parameter, combined with other physiological indicators, are needed to better 36 characterize this response. 37

#### 41 **1. Introduction**

In ecology, the ability of an organism or a population to respond to a given change can be 42 used as a biological indicator, also called a bioindicator, of the quality of an environment 43 (Whitfield and Elliott, 2002). For instance, bioindicator species can be used to measure and 44 evaluate the impact of potentially harmful chemicals, such as heavy metals or pesticides, on 45 the environment (Bargańska et al., 2016; Hopkin et al., 1993). Changes can be measured at 46 different levels, such as specific diversity and abundance (Santorufo et al., 2012), or at the 47 individual level with records of mortality and fecundity (Jones and Hopkin, 1996), 48 physiology (Folguera et al., 2011) or behaviour (Zidar et al., 2005) to evaluate the direct 49 impact of environmental changes. To date, several vertebrate and invertebrate species have 50 51 been identified as reliable bioindicators of their natural habitat (Bargańska et al., 2016; 52 Carravieri et al., 2013; Gerlach et al., 2013; Paoletti and Hassall, 1999; Park, 2015; Pearce 53 and Venier, 2005; Souty-Grosset et al., 2005). Among invertebrate bioindicator species, terrestrial isopods have the potential to be used as indicators in both moist areas and 54 55 grasslands (Gerlach et al., 2013; Souty-Grosset et al., 2005). Terrestrial isopods are important decomposers of leaf litter, and their integrity may be rapidly threatened when a disturbance 56 57 occurs in the soil (Dallinger et al., 1992; Souty-Grosset et al., 2005).

When an organism is threatened, its resources are mobilized and redirected from functions 58 such as growth or reproduction to face the challenges and preserve its integrity (Moberg and 59 Mench, 2000). This response is known as the stress response. Invertebrates are frequently 60 exposed to a number of stressors, including repeated predation attempts (Hawlena et al., 61 62 2011), adverse environmental conditions (Chown and Nicolson, 2004) and parasitism (Chang et al., 2005). As stressors are omnipresent in the environment, the stress response is essential 63 for the survival of an individual and relatively well preserved during the course of evolution 64 (Nesse et al., 2016). Reactions towards stress are highly variable not only among different 65 66 species but also within individuals of the same species (Koehn and Bayne, 1989). As the 67 stress response is initially adaptive and protective, prolonged exposure to a given stressor or a combination of stressors can further evolve into maladaptive responses and be detrimental for 68 69 an organism or a community (Moberg and Mench, 2000). Stress can cause severe damage to 70 an organism with a negative impact on its survival and fitness and potential consequences at 71 the population level (Hoffmann and Hercus, 2000). As an example, the accumulation of 72 various stressors resulted in the recent worldwide increase in colony failure rates, or 'colony 73 collapse disorder', in honeybee (Even et al., 2012).

74 The stress response has been extensively studied in vertebrates and is the result of 75 physiological changes in response to stressful stimuli (Kassahn et al., 2009). The stress 76 response can be measured at three levels. The primary stress response is the release of stress hormones, such as corticosteroids and catecholamines, in the bloodstream (Tsalafouta et al., 77 78 2014). The main role of these compounds is to restore homeostasis following exposure to stressors. The secondary stress response acts at the cellular level by mobilizing and 79 80 reallocating energy and increasing cardiac output and oxygen uptake and transfer. In mammals, for example, cortisol can facilitate the increase in the production and availability 81 82 of metabolites such as glucose. Gluconeogenesis is promoted in the liver, while glucose use by the cells is limited to increase blood glucose availability to meet the needs of the organism 83 in response to stressful stimuli (Desborough, 2000). The tertiary response affects the entire 84 organism and can inhibit functions such as growth, reproduction, immune response and the 85 ability to face additional stressors (Moberg and Mench, 2000; Sapolsky et al., 2000; Tsigos 86 and Chrousos, 2002). 87

Although invertebrates are susceptible to stressors, the stress response in invertebrates has 88 89 been studied to a lesser extent than it has in vertebrates. Therefore, fewer cellular and physiological indicators of stress in invertebrates are known. At the cellular level, the 90 91 increased production or activation of antioxidant proteins and heat shock proteins is seen in 92 response to a stressor, which is similar to the vertebrate response (Feder and Hofmann, 1999). Relatively few invertebrate species have been studied regarding the stress response. Among 93 them, we find some model species for biological processes, such as Caenorhabditis elegans 94 or Drosophila melanogaster (Feder and Hofmann, 1999), or economically and ecologically 95 96 important species, such as the honeybee Apis mellifera (Even et al., 2012) and aquatic crustacean species, such as the American lobster Hommarus gammarus (Chang et al., 2005) 97 or the white leg shrimp Litopenaeus vannamei (Chang et al., 2009). In aquatic crustacean 98 species, it has been shown that exposure to harmful physical or chemical stimuli resulted in 99 100 an elevation of glucose haemolymph (Lorenzon, 2005; Lorenzon et al., 1997). These 101 physiological changes were shown to be under the control of the crustacean hyperglycaemic 102 hormone (CHH) (Chang et al., 1998; Chang et al., 2005; Lorenzon, 2005; Lorenzon et al., 1997). This hormone is secreted from the sinus gland (Fanjul-Moles, 2006) in response to 103 104 stressful stimuli in crustaceans (Chang et al., 2005). Moreover, this hormone has been described as the crustacean equivalent of cortisol and corticosterone (Elwood et al., 2009). 105

106 Terrestrial isopods have been used in tests of the toxicity of soil, and the parameters of evaluation were mainly the abundance of individuals (Faulkner and Lochmiller, 2000), 107 reproduction rate (Niemeyer et al., 2009) and survival (Stanek et al., 2006). Porcellio scaber 108 were studied most often regarding the metal bioaccumulation process (da Silva Souza and 109 Fontanetti, 2011). In this study, we chose to investigate the impact of several potential 110 stressors on the glucose levels of circulating haemolymph in two terrestrial isopod species, 111 112 Armadillidium vulgare (Latreille, 1804) and Porcellio dilatatus (Brandt, 1833). These species belong to two different ecomorphological groups, with different defence strategies: A. 113 vulgare is a roller and P. dilatatus is a clinger (Schmalfuss, 1984). In their habitat, these 114 organisms can be exposed to various stressors that can be biotic or abiotic and acute or 115 chronic. The main stressors encountered can be separated into three categories: 1) biological 116 stressors (predators, parasites, fungi, bacteria and viruses); 2) chemical stressors (pesticides, 117 fungicides, and herbicides), which can cause damage to non-target species; and 3) 118 environmental stressors (agricultural practices, (micro)climate change, resource abundance 119 fluctuation, social interactions, humidity, etc.). In our laboratory, we investigated the impact 120 of five different stimuli that mimicked the whole range of potentially stressful situations 121 encountered in the natural habitat or cultivated areas of these species (Swan et al., 2011; 122 123 Szlavecz et al., 2018). The main objective of the present study was to assess the importance of three extrinsic factors (temperature, shaking, and falling), one intrinsic factor (gender) and 124 125 social privation on the glycaemia level.

The approach of using more subtle endpoints, such as physiological and behavioural changes, to assess the toxicity of potentially harmful substances has become more popular and has been shown to be more accurate than the traditional survival, growth and reproduction responses (Drobne, 1997). In line with this approach, we use glycaemia as a physiological endpoint to measure the potential stress responses in two terrestrial isopod species.

#### 131 **2.** Material and methods

#### 132 **2.1** Animals

The terrestrial isopods *A. vulgare* and *P. dilatatus* were derived from two natural populations
collected in France (Nice, Alpes Maritimes, 1967, for *A. vulgare* and Rom, Deux-Sèvres,
1988, for *P. dilatatus*). The animals were maintained in standard laboratory conditions (in
boxes of moistened compost, at 20°C, and with the natural photoperiod of Poitiers, France

46°40'N) and fed *ad libitum* fresh organic carrots and dried leaves of linden (*Tilia* sp.). For 137 Experiments 1 and 2, we selected one-year-old adult A. vulgare and P. dilatatus of similar 138 size (around 60 mg and 150 mg respectively). For Experiment 3, we selected a mixture of 139 virgin 1- to 3-year-old A. vulgare individuals (60-150 mg). All animals used were in 140 intermoult (di-ecdysis or beginning the pre-ecdysis stages  $C/D_0$ ) (for growth cycle details, see 141 Beauché and Richard, 2013 and Zidar et al., 1998). The period of each experiment was 142 143 chosen to match the moult cycle of each species (at least 26 days for both species; Beauché and Richard, 2013; Zidar et al., 1998) in order to avoid moulting during the course of 144 experiment. None of the tested individuals were moulting during the course of the 145 experiment. Gravid females were excluded from the experimental pool. The experimental 146 procedures and animal manipulations did not require an ethics statement. The stimuli used in 147 these experiments were carefully selected to elicit a subtle response without causing any 148 unnecessary distress. 149

#### 150 **2.2 Experimental procedure**

All procedures were carried out in laboratory conditions during daylight hours between 10:00 and 16:00 in the spring and summer of 2016. We chose five different stimuli to be applied to the isopods: "cold", "shake", "upside-down" (Experiment 1), social isolation (Experiment 2) and chronic exposure to glyphosate (Experiment 3). The stimuli were chosen as they could mimic threats that the animals encounter in natural situations.

#### 156 2.2.1 Experiment 1: biological stressor

Animals were randomly subjected to one of the three following acute stimuli: exposure to 157 cold temperature, shaking or an upside-down movement. The cold stimulus was chosen as 158 ectothermic animals, including terrestrial isopods, are sensitive to severe temperature changes 159 as their body temperature is mostly dependent on the temperature of their environment 160 161 (Dahlhoff and Rank, 2007). The shaking stimulus was used to mimic the impact of modern agricultural practices, such loud noises and vibration disturbances caused by heavy 162 machinery (Schlacher and Thompson, 2007; Soane and van Ouwerkerk, 1994). The upside-163 down stimulus aimed to mimic the impact of predator attacks. In nature, terrestrial isopods 164 can be targeted by numerous predators which could catch, move and drop them (Tuf et al., 165 2015). 166

For each species, 20 undisturbed individuals (10 males and 10 females) were randomly 167 picked from the holding tanks and served as control groups. The 'cold' stimulus consisted of 168 placing two individuals in one box (Ø 8 cm, H 5 cm) kept at 4°C for one hour. The light 169 condition was kept constant during this period (refrigerator with a glass door), and the box 170 was kept moist using water-dipped tissues in the bottom). The "shake" stimulus consisted of 171 shaking the animals individually in a box (Ø 8 cm, H 5 cm) attached to an IKA KS 130 Basic 172 173 2D shaker (IKA, Staufen, Germany) for one minute at 560 rpm. The "upside-down" stimulus consisted of placing the animals in individual boxes (Ø 9.5 cm, H 5 cm) and overturning the 174 175 box repeatedly by performing ample movements (180°) from right to left for one minute. This stimulus was carried out by the same experimenter at a constant speed (approximately 176 177 70 movements). Stimuli were applied randomly to different individuals.

#### 178 2.2.2 Experiment 2: social isolation

We investigated the impact of social isolation, which could be considered a chronic stressor 179 for the studied species. Terrestrial isopods are known to be gregarious organisms. Living in 180 groups has been demonstrated to offer several advantages, such as the prevention of 181 desiccation, the potential protection from predators and better access to mates and secondary 182 food resources (Broly et al., 2013). For this stimulus, 36 animals per species (18 males and 18 183 females) were placed in individual boxes (Ø 8 cm, H 5 cm) and kept isolated for a period of 4 184 weeks. The boxes were visually isolated from each other by cardboard sheets. In parallel, 120 185 individuals 120 were sexed and kept in groups of 6 (20 boxes, Ø 11 cm, H 5 cm; 10 boxes for 186 187 males and 10 boxes for females) and served as the controls. On the sampling day, the analyses of both the isolated and grouped individuals were performed simultaneously. In 188 189 total, 20 animals (10 males, 10 females, one individual per box) were sampled.

#### 190 2.2.3 Experiment 3: chemical stressor

The animals were chronically exposed to the glyphosate-based herbicide Roundup® (Monsanto, USA). Glyphosate-based herbicides are among the most widely used herbicides for weed control and have become one of the most commonly used agrochemicals worldwide (Shang et al., 2011). Despite studies of the impact of glyphosate on several non-target species (Balbuena et al., 2015; Giesy et al., 2000), the sublethal effect remains poorly studied. Terrestrial isopods have been proposed as good candidates to study the impact of pollutants in terrestrial environments (Drobne, 1997). 198

Animals (A. vulgare) were randomly exposed to one of three doses of glyphosate (0, 1.8 and 199 2.5 kg.ha<sup>-1</sup>) for up to 25 days. These doses are related to the mg of glyphosate present in the 200 glyphosate-formulated herbicide Roundup<sup>®</sup>. In this study, we did not aim to observe high 201 202 mortality but rather to test the impact of the doses recommended by the manufacturer and approved by the French Ministry of Agriculture and Food at the time of the experiment for 203 204 use against easy-to-control (1.8 kg.ha<sup>-1</sup>) and difficult-to-control (2.5 kg.ha<sup>-1</sup>) weeds. Animals were subsequently placed in plastic boxes (Ø 10 cm, 5 cm H) containing 70 (±0.5) g of 205 moistened compost. Each box contained 5 animals of the same sex and same age class 206 207 (N=40/treatment). The animals were acclimated in the boxes for four days, during which they received their usual food. After this acclimatization period, the uneaten food was removed. 208 209 The glyphosate used in our study was in the form of isopropylamine salt  $(170 \text{ g.l}^{-1})$  as specified in the Roundup® formulation. Animals were exposed to the desired dose of 210 glyphosate (Roundup®) through the food and the soil. For each box, 5-6 pieces of thinly 211 sliced carrot and the equivalent of two linden leaves were soaked with a mixture of 7 ml of 212 water and 0 µl, 8.3 µl or 11.5 µl of Roundup® for 15 minutes prior to being placed in the 213 214 appropriate box. The remaining solution was subsequently pipetted homogeneously into the 215 box, where it was placed on the soil, not directly on the animals. This process was repeated weekly until the completion of the experiment (25 days maximum). Mortality was recorded 216 217 during these processes, and dead individuals were removed from the experimental boxes. One group was sampled after 96 hours (acute exposure), and one group was sampled after 21 days 218 219 (chronic exposure). In addition, after the puncture, the animals from the group sampled after 96 hours were kept moist in recovery boxes with water-dipped tissues at the bottom for 24 220 221 hours. Surviving individuals were placed back into their original experimental boxes and sampled after 21 additional days (25 days in total). This was done to investigate the effect of 222 223 an extra stressor (haemolymph sampling, mimicking a wound) in addition to the chronic exposure to glyphosate. 224

Immediately after each stimulus, circulating haemolymph was sampled by making a puncture in the intersegmental membrane between the thorax and the abdomen. The respective control groups from each experiment were also sampled for haemolymph at the same time. In total, 5-10  $\mu$ l of haemolymph per individual was collected using a micropipette and stored at -20°C until further analyses. After the puncture, the animals were kept moist in recovery boxes using water-dipped tissues on the bottom for 24 hours. Surviving individuals (>50%) were placed back into their original housing boxes with moistened compost litter and were notfurther used for another study.

#### 233 **2.3 Glucose determination**

Haemolymph glucose was measured with a commercially available enzymatic test kit (Glucose HK, Sigma-Aldrich, St. Louis, USA), with protocols adapted to a 96-well microplate (Schram et al., 2010). Samples are first diluted in distilled water (1:6); then, 10  $\mu$ l of the diluted sample or standard (5.55 mmol.l<sup>-1</sup> glucose) are mixed with 200  $\mu$ l of the reagent provided with the kit and incubated for 15 minutes at 20°C. Absorbance was read within 30 minutes at 340 nm (Berthold LB941 Multimode reader, Berthold Technologies, Zug, Switzerland).

#### 241 **2.4 Data analyses and statistics**

Data are summarized by box and whisker plots that present first, second (median), and third 242 quartiles as horizontal lines in the box and upper and lower values as "whiskers" extending 243 from the boxes; In some instances, not all samples collected were analysed because of 244 insufficient haemolymph quantity. For Experiment 1 (the "cold" and "shake" stimuli) and 245 Experiment 3, there were no gender differences, and, therefore, the data were pooled. 246 However, for the "upside-down" stimulus (Experiment 1) and Experiment 2, the data were 247 split between males and females. The data were not normally distributed; therefore, the non-248 parametric Mann-Whitney test was used to assess statistical significance for all the 249 250 experiments. We used the Chi-square test to compare the survival of individuals in Experiment 3. 251

#### 252 **3. Results**

#### **3.1 Experiment 1: biological stressor**

There were no differences in the glucose haemolymph concentration regardless of the species or the type of stimulus tested in comparison with the control condition when the data were pooled (Fig 1A and 1B) (Mann-Whitney test; for *P. dilatatus* and *A. vulgare*, respectively: "cold": W=59, p=0.32; W=151, p=0.27; "shake": W=93.5, p=0.41; W=141, p=0.17; "upsidedown": W=100, p=0.16; W=180.5, p=0.79). For *A. vulgare*, no gender-specific differences were found (Mann-Whitney test, p> 0.05 for all stimuli, Fig 1B and 2B). Similarly, *P. dilatatus* subjected to the cold and shake stimuli did not display gender differences regarding their glucose haemolymph (Fig 1A). However, male *P. dilatatus* had significantly haemolymph glucose levels compared to those of their female counterparts for the upsidedown stimulus only (Mann-Whitney test, W=20, p=0.03, Fig 2A). These levels were significantly higher than those of the male control group (Mann-Whitney test, W=13, p=0.02, Fig 2A).

#### 266 **3.2 Experiment 2: social isolation**

267 There were no differences in the glucose haemolymph concentration for either species in comparison with their respective controls when the data were pooled (Mann-Whitney test; 268 W=106.5, p=0.20 for *P. dilatatus* and W=157, p=0.08 for *A. vulgare*). However, we observed 269 a gender difference for both species: male P. dilatatus and A. vulgare subjected to social 270 isolation for a month had significantly higher haemolymph glucose levels compared to those 271 of their respective control groups (Mann-Whitney test, W=56, p=0.04 for P. dilatatus,; and 272 W=14.5, p<0.01 for A. vulgare, Fig 3A and 3B). No differences in glucose haemolymph were 273 found between females subjected to social isolations and females kept in group for either 274 species (Mann-Whitney test, W=98, p=0.96 for P. dilatatus and W=53, p=0.47 for A. 275 vulgare). 276

#### 277 **3.3 Experiment 3: chemical stressor**

278 There was no effect on the glucose haemolymph concentration when A. vulgare individuals were exposed to either dose of glyphosate for 96 hours (Mann-Whitney test, W=506.5, 279 p=0.47 for the 1.8 kg.ha<sup>-1</sup> group and W=475, p=0.21 for the 2.5 kg.ha<sup>-1</sup> group, Fig 4A) or 21 280 days (Mann-Whitney test, W=353, p=0.45 and W=295.5, p=0.18, Fig 4B). However, 281 individuals who were sampled after 25 days of exposure to either concentration and received 282 another stressor (i.e., a haemolymph puncture after 96 hours) had significantly higher glucose 283 haemolymph than that of the control group (Mann-Whitney test, W=57, p=0.01 for the 1.8 284 kg.ha<sup>-1</sup> group and W=64.5, p=0.05 for the 2.5 kg.ha<sup>-1</sup> group, Fig 4C). Survival tended to 285 decrease naturally with time in all groups (non-significant;  $X^2=0.13$ , ddl=2;  $X^2=0.33$ , ddl=2; 286 and  $X^2=0.58$ , ddl=2 for the control group and the 1.8 and 2.5 kg.ha<sup>-1</sup> glyphosate groups, 287 288 respectively) (Fig 5). Survival was only negatively affected by the combination of chronic exposure to glyphosate and the application of an extra stressor (Fig 5). No differences in 289 290 survival were observed between individuals from the control group samples after 96 hours and those from the group exposed to glyphosate for 96 hours + 21 days ( $X^2=3.63$ , ddl=1), 291

while survival decreased in both the 1.8 and 2.5 kg.ha<sup>-1</sup> glyphosate groups ( $X^2$ =6.23, ddl=1 and  $X^2$ =7.41, ddl=1, respectively). There were no differences in survival among all groups after 96 hours and 21 days of exposure ( $X^2$ =0.58, ddl=1;  $X^2$ =0,01, ddl=1; and  $X^2$ =0.053, ddl=1 for the control group and the 1.8 and 2.5 kg.ha<sup>-1</sup> glyphosate groups, respectively) (Fig 5).

#### 297 4. Discussion

The elevation of circulating glucose levels is a common response to stressors and is found 298 299 throughout the animal kingdom, including crustaceans. Crustaceans have been widely used for stress risk assessment and are used as bioindicators or biomonitors, especially in various 300 301 aquatic systems (Rinderhagen et al., 2000). Among commercial aquatic crustaceans species, stress exposure, such as emersion, transport and handling, is common and causes hypoxia and 302 variation in physiology (Lorenzon, 2005). For example, the decapods, *Liocarcinus depurator* 303 and Munida rugosa showed a higher concentration of glucose when subjected to trawling in 304 comparison to creel-caught crustaceans (Bergmann et al., 2001). Another study revealed that 305 the CHH hormone concentration increased in the haemolymph in less than 1 hour after acute 306 stress (handling) in lobsters, which is slower than the appearance of biogenic amines (Chang 307 et al., 2005). The production and action of these hormones leads to mobilization of energy 308 reserves, such as glucose. In the current study, we used two terrestrial isopod species to test 309 the glucose level variation in response to different stressors. 310

We found that stress induced in *A. vulgare* and *P. dilatatus* adults by the cold and shake stimuli had no significant impact on the haemolymph glucose levels, which were collected right after the application of the stimuli to test the short-term impact of our stressors.

When exposed to the upside-down acute stressor, we observed that males of *P. dilatatus* had significantly higher glucose levels than those of their controls, while there was no effect on male *A. vulgare*. These two species have different defence strategies. *A. vulgare* can roll and may isolate themselves from the exterior (Schmalfuss, 1984). However, *P. dilatatus* corresponds to the clinger ecomorphological group (Schmalfuss, 1984) and is highly responsive to stimuli, but the duration of response (tonic immobility) is relatively short, with no difference between sex (Quadros et al., 2012).

In the second experiment, we observed a sex difference for both species when individuals were isolated for one month. The glucose levels of male are apparently affected, while those 323 of females are not. These results indicate that male isopods, regardless of their defence strategies, are more sensitive to non-physical and chronic stress, such as social isolation, than 324 their female counterpart. Here, we showed that different types of stress have different impacts 325 between species, but we also observed differences in sensitivity between females and males. 326 327 Differences in sensitivity between sexes exist and have been previously observed in several invertebrates and in both aquatic and terrestrial systems (Sornom et al., 2010) and reference 328 329 therein (McClellan-Green et al., 2007; Wilczek et al., 2008; Zeng et al., 2011). For example, under oxidative stress conditions, male flies ingested and excreted less food than females 330 331 (Zeng et al., 2011). In two species of spider, cellular reactions against stress caused by metal pollutants seemed to be sex-dependant (Wilczek et al., 2008). In the terrestrial isopod P. 332 scaber, a close relative of *P. dilatatus*, an exposure to dimethoate for 48 hours impacted the 333 locomotor behaviour (increased hyperactivity and suppressed turning rate) of males only 334 (Bayley, 1995). 335

In the third experiment, we evaluated the effect of two recommended concentrations of 336 337 glyphosate used in agriculture (1.8 and 2.5 kg.ha<sup>-1</sup>). Glyphosate ingestion might affect the learning and retrieval of memory for the recognition of food (Balbuena et al., 2015), and 338 339 chronic exposure to traces of glyphosate reduces the responsiveness to sucrose in honeybee (Herbert et al., 2014). Glyphosate is also known to reduce growth in the earthworm (Springett 340 and Gray, 1992) and affect reproduction and development in the freshwater snail (Tate et al., 341 1997). In our experiment, we observed no significant impact on A. vulgare glycaemia. 342 However, individuals who were chronically exposed to glyphosate and an additional stressor 343 (intermediate haemolymph sampling) had altered glucose levels in comparison with 344 individuals that only received the additional stressor without glyphosate. No individual 345 moulted between the two sampling sessions. Stressors are omnipresent in the environment 346 and can potentially interact with each other and affect the capacity of an organism to cope 347 348 with a specific stressor (Sornom et al., 2010). While assessing the sublethal impact of a contaminant on an organism, it is important to take into account that the potential of an 349 organism to cope with stressors and survive is determined by the ability of all its biological 350 systems to work in concert (Hebel et al., 1997). For instance, here, we observed no direct 351 impact of exposure to the recommended doses of glyphosate, but when animals were exposed 352 to an additional stressor (haemolymph puncture) that can be compared to a minor wound, we 353 observed that its combination with glyphosate exposure resulted in stress. 354

In conclusion, changes in glycemia can be used to assess stress in terrestrial isopods. Males of both species seemed to be more sensitive than female to stressors such as upside-down movements or social isolation. In our study, we have focussed on the very short term impact of single stressor. The effect combined stressors and the impact of glyphosate exposure on the middle and longer term require further investigations.
