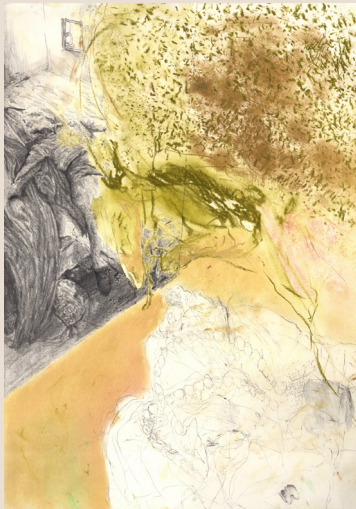

**Musicological subversions**  
*Identifying Derridian graft in musical analysis*

*Abstract*

This paper initially questions the position and the use of subversion in musicology. Among the different possibilities, we will consider the concept of *graft*: the beginning of this subversive concept can be found in Jacques Derrida's philosophical reflections. From the biological field, the French philosopher applied this word to describe a necessary and integral condition of writing and creating literary texts. On this basis, we propose a further application of the same (enriched) notion to music, proved as a subversive and innovative interpretation of musicological language and reflection, that is generally considered as a less important lexical possibility in this field. Through a theoretical and etymological approach, our study will demonstrate that music incorporates graft elements in musical writing as well as in cultural interactions. Nevertheless, these abstract considerations will be used in a concrete analysis of musical grafted texts, particularly in works by Zad Moulataka. In his first composing period, it is possible to single out his purpose of union and meeting between Occidental contemporary music technique and the sonorities of his Arab roots.

Questo contributo si interroga inizialmente sulle modalità di sovversione appartenenti alla musicologia. Tra le diverse possibilità, si prenderà in considerazione il concetto di *innesto*. Le prime origini sovversive di questo termine risalgono alle riflessioni filosofiche di Jacques Derrida. Infatti, il filosofo francese traspose e applicò il significato scientifico del concetto alla descrizione di una necessaria e integrale condizione di creazione e scrittura del testo letterario. Sulle orme di questa operazione derridiana, proporremo un'estensione della nozione (di conseguenza arricchita) alla musica, considerandola dunque lettura innovativa e sovversiva nell'ambito del linguaggio e dell'analisi musicale, ambito in cui è ritenuta come possibilità minore (o spesso inesistente). Attraverso un approccio teorico ed etimologico, questo studio dimostrerà altresì che, in fondo, la musica incarna degli ideali di innesto già all'interno della scrittura o anche riguardo le interazioni culturali che spesso contempla. Ad ogni modo, le considerazioni astratte proposte saranno corredate da analisi di testi musicali, in particolare alcune delle opere di Zad Moulataka. Agli inizi della sua carriera compositiva, si può osservare un orientamento di incontro tra la tecnica della musica contemporanea (occidentale) e le sonorità delle sue radici arabe.



How can the notion of subversion in musicology be defined<sup>1</sup>? This question seems hard to answer. Nevertheless, the explanation can be found within the definition of musicology and its functions. Although humans have always taken interest in understanding music by way of different points of view, the official birth of musicology dates back to the late 19<sup>th</sup> century<sup>2</sup>. Before this historical moment, it was not considered an autonomous science as it is nowadays. On the contrary, it was often thought as an appendix of culture, of other disciplines. This marginal role of musicology (or rather, the ancient *discipline to study music phenomena*) derived from its specificity and the difficult to approach musical art<sup>3</sup>, even with the lack of particular means to undertake research into it. From Romantic ideals, the intellectual study of music started to become closer to the investigation of other arts<sup>4</sup>. This revolutionary thought can be considered an important step for its independence as a science. From the second half of the 19<sup>th</sup> century, slowly, it overcame the simple resemblance to history or analysis of music<sup>5</sup> and it started to be studied as a multi-

faceted discipline<sup>6</sup>, seeing its natural interests and the support that it seeks in other sciences. As Jean-Jacques Nattiez wrote:

Ce qu'étudie la musicologie, ce ne sont pas seulement les sons et les structures d'une sonate, d'un opéra, d'une chanson rock ou d'une musique africaine, c'est aussi l'étude de ses contextes (historique, social, culturel) et de ses stratégies de production (composition, interprétation) et de perception auditive.<sup>7</sup>

According to this scholar, musicology can be defined as «total musical fact»<sup>8</sup>, given that it concerns not only the auditory representations but also the circumstances of its development. Consequently, this implicates other disciplines, and musicology must learn to collaborate with them to enrich its analytical action. Therefore, musicological terminology seems to be original and exclusive only in part since it has to feed itself on extra-musical materials. Contemporary musicology is aware of the need for working in conjunction with «les sciences dites annexes [...] qui apportent un éclairage nouveau pour la compréhension du phénomène et du milieu musical»<sup>9</sup>. Among these disciplines, we can find hard sciences as well as human sciences<sup>10</sup>.

This collaboration can be observed in different aspects, not only in analyzing music or investigating the representation of music: its real interest lies in

the propensity that musicology often shows in using words taken from other scientific lexicons to explain its own phenomena. For instance, in its branch of music theory, it is possible to find some words clearly deriving from other contexts like *ictus* (from medicine), acephalous rhythm<sup>11</sup> (from visual arts or poetry), accent (from grammar), tonality (from visual arts) and many others. In these examples, the original meaning of the words has been completely adjusted to the musical description.

This is the first great subversion that musicology achieves, a semantic appropriation<sup>12</sup> where it borrows not only single words to readapt but also images, representations, and processes to use for the definition and the explanation of musical events. As the Latin sources state, *subversion* indicates a change of perspective, breaking a previous order to create a new one. Subversion is also de-construction: it means depriving a word or a concept of its ordinary guises to acquire new ones by joining it to a different context. Musicology can widen its expressive means (and above all, carry out subversion proposals) thanks to a descriptive device, metaphor<sup>13</sup>. It can make subversion extreme and provoke a deep transformation in the concepts involved. Finally, metaphor can be defined as an «instrument en mesure de reconfigurer un domaine différent de celui où il [le mot, l'expression] appartient à l'origine»<sup>14</sup>.

In this research, we want to consider a specific case of subversion in musicology that is achieved through metaphor: *graft*. This concept was born in the hard scientific domain, developed particularly in the biological branches<sup>15</sup>.

*Graft* indicates a particular production process that consists of implanting a foreign tissue in a body, joining them together so that they can continue the growth and become one. This technique can be practiced thanks to its two main components: the *rootstock*, that is the base, the foundation, the element that receives, the implantation of the process, and the *scion*, the element to insert, to integrate into the other<sup>16</sup>. The aim of this union represents, in its origins, the human will to handle life and its development. Nevertheless, this inner purpose is in conflict with the direct consequence of the union between rootstock and scion, the unpredictability of the result. In this respect, E. Morin wrote:

Ce n'est pas tant la multiplicité des composants, ni même la diversité de leurs interactions, qui caractérisent la complexité d'un système (...) C'est l'imprévisibilité potentielle (non calculable a priori) des comportements de ce système, liée en particulier à la récursivité qui affecte le fonctionnement de ses composants ("en fonctionnant ils se transforment"), suscitant des phénomènes d'émergence certes intelligibles, mais non toujours prévisibles.<sup>17</sup>

Outside the biological domain, in other disciplines, graft can be identified, as we mentioned above, thanks to metaphor, a linguistic expedient that allows the transposition of a concept besides its origin fields. It is a phenomenon where visual representations do not really need a translation in words, since «images are immanent in words»<sup>18</sup>. The borrowing of terminology in a metaphor is an operation that refuses symbolic and scientific conventions. To make this point clear, it is useful to define the concept of *vocable* as a linguistic device to implement metaphor. It does not have the same limited nature as the

graft a *transplant*. The French language proposes a different linguistic solution: it uses the word *greffe* to indicate both botanic and medical processes.

symbol<sup>19</sup> that is linked to an exact idea. On the contrary, it is an open reality that can receive in its sense different possibilities. *Vocable* is thus the element whose result (meaning) can change according to the context. That is why the *vocable* has a double or multiple life<sup>20</sup>: it has in itself a plurality of levels that can refer to different domains, for which it represents a reference. It shows a signifier that is unique and an infinity of signified/meanings that increase through the arbitrary associations that can develop. This feature causes not only a loss of the word/*vocable* original image, but rather a contortion, an extension of its meaning giving an enrichment to the discipline where it is applied. These effects are a result of the appropriate adaptation that it has to carry out in order to obtain a new existence in a different context.

Consequently, graft, as *vocable* in a metaphor, has shown that its field goes alongside the biological one. In fact, it can achieve more linguistic shades<sup>21</sup>: by the application in linguistics to describe a notable articulation of the language<sup>22</sup>, to illustrate some types of literature, to reference the mixed creations in visual arts and stage arts<sup>23</sup>.

Thanks to Derrida's reflections, this concept was also exported to philosophy. «To write means to graft»<sup>24</sup> is the statement that opens the last chapter of *Dissemination*. The intention of this short sentence is clearly subversive. The center of Derridian thought acquires a larger definition: the sense of this word is now

subverted by a metaphor applied to the text and to its configuration. In the aforementioned chapter, he refers above all to literary text<sup>25</sup>, describing it as «[a] tree [...] ultimately rootless»<sup>26</sup>. This image can be explained for the reason that a text cannot be analyzed (nor conceived) as a unique body<sup>27</sup>: Derridian notion defines «an authentic subversion about what was always considered [...] the Occidental metaphysical thought [...]»<sup>28</sup>. It is like an open reality where, under the apparent unitarity, multiple texts meet, get in touch, and influence each other<sup>29</sup>.

The French philosopher explains (and this is the real innovation) that writing (or reading) a text does not represent a cre-a[c]tion, an act of creation, it does not mean inventing something new, but it corresponds to a reconstruction from different texts<sup>30</sup>.

Therefore, the main text can be considered as a particular texture without its own clear identity. It is open towards its «surroundings»<sup>31</sup>; while the involved texts, or rather their plurality, submit to a transformation that leads, through development, to a harmonious union. The way to connect these different texts that consequently give birth to the main text, is found by Derrida evocating the images of «overcast seam» and «quotation»<sup>32</sup>. The first word, which comes from the medical and couture contexts, defines a system to link two edges of tissue, of material. This is exactly what happens in the production of a text, according to the French philosopher: «the texts [...] pass elliptically one into the other and become regenerated in the repetition, along the edges of an *overcast seam* [*un surjet*]»<sup>33</sup>.

For this reason, a text is always composed of external insertions that generate movement, which Derrida calls «quotation», referring to the Latin root of this word<sup>34</sup>. This feature of the text defines it as not static, holding a deep dynamism and keeping heterogeneity in its inner nature. In this regard, Derrida wrote: «the motif of homogeneity, the teleological motif par excellence, is decidedly the one to be destroyed»<sup>35</sup>.

Moreover, for this philosophical thought, *greffe*<sup>36</sup> turns out to be not only an essential condition belonging to the nature of the text, but also something necessary for its production. It flows unconsciously but is strictly linked to the way the text is structured. *Greffe* can also become a necessary and integral condition for all types of writing, a kind of *pan-greffism*.

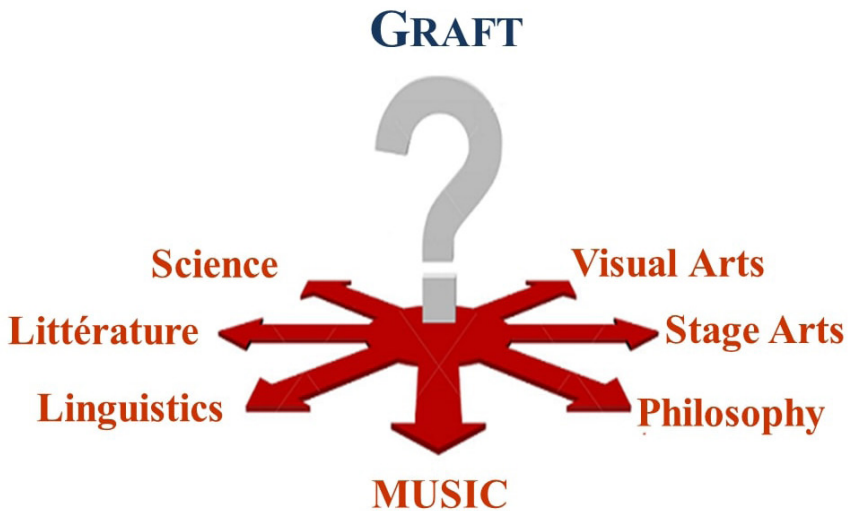


Figure 1. Semantic enlargement of the word *graft*.

The possibility of identifying all kinds of arts and creative acts raises the question of extending this idea to music, or rather to musicology, since in this

case graft represents an interpretation to observe and explain artistic production activities. Musicology is a science that often uses concepts from other disciplines to conduct its studies, for this reason, among the collaborative domains, it could also interact with botany and medicine, as in the case of the graft that we have demonstrated.

At this point, it is also interesting to illustrate the reasons why we propose the word *greffe* to explain some musical processes. In this domain, this concept can be used to analyze some musical meetings of different types. Nevertheless, the musicological language does not often consider the use of this word (in the Derridian sense), or rather its general sense is considered as a less important lexical possibility. In fact, it is common to find other kinds of linguistic solutions that express definitions that are too large and vague. For this reason, the concept of *greffe* can be a useful interpretation to precisely observe the heterogeneity of the elements of a composition and their quantity.

We previously explained how subversive the interpretation of a text (or a kind of language) through the concept of *greffe* could be: a word that comes from biology to the linguistic/literary field (thanks to Derrida), and to the musical one (from the Derridian metaphor), updating the process of the composition of the literary or musical text. Nonetheless, when analyzing the etymology something surprising happens. As Derrida wrote: «[it] appears to be a simple etymological coincidence uniting the graft and the graph [...]»<sup>37</sup>. The linguistic origin of the graft leads to both Latin and Greek sources. It derives from the Latin *graphium* that means *stylus* and from the Greek γράφω [*grapho*], a verb that denotes the act of *engraving, cutting into, writing*<sup>38</sup>. Thus, *greffe* keeps in itself the sense of generating by hand. Consequently, the subversion, that we (thanks to Derrida) observed for this notion, seems to disappear as result of that analysis. In a metaphor, its worth stands in its being a *vocable*, keeping the unity of the signifier and the infinity of the signified.

Indeed, since we realized that *greffe* is no more a real subversion in its application as metaphor, we should also add that it continuously exists as sub-

version in musicology (as well as in the theory of the text by Derrida) for being an innovative interpretation, different from the various existing approaches, to explain some musical structures, resulting as a less considered and less known practice.

We recognize Derridian reflections as a powerful instrument that can allow musicologists to read and interpret music indicating its different parts with a specific terminology. This application of the *greffe theory* represents an innovation as well as a deep need of the analytic process, in order to allow a more detailed description of distinct kinds of music phenomena and to acquire a consciousness about the construction (even if we admit its unconsciousness - about being *grafted* in its creation). At present, we have not found any type of musical analysis that includes the consideration of music as the graft of different elements. Besides this aspect, in musical analysis its components are often referred to with vague expressions (like «element A, element B» etc.). Thanks to the adoption of Derridian reading of the text, also in the musical field we could *express* using a specialized imported lexicon to indicate all the elements.

The ascertainment of the existence of a musical *greffe* can be observed from what we could call *endogenous*<sup>39</sup> and *exogenous* aspects<sup>40</sup>. With regards to the exogenous aspect, it can be observed studying cultural interactions that are present in some kinds of music. In this situation, graft, through its constituents of the rootstock and the scion, can act on the participating elements, transforming and re-interpreting them. It subverts their original balance.

How can we use *greffe* in practice to analyze this kind of music? That is not an easy question to answer, as for this case, we cannot find any previous

specific examples of analysis. Derrida<sup>41</sup> proposes a theory, some observations about writing creation process, about the genesis of a text, but does not put these reflections into practice, giving a concrete study of a literary text through his deductions<sup>42</sup>. The best context we found to analyze music through Derrida's reflections is about compositions based on cultural interactions. To lead a musical analysis construction, with notions coming from graft theories (the biological<sup>43</sup> and the Derridian ones), we will use some more reflections about cultural interferences in music. For instance, during his lessons about interculturality, the musicologist Nicolas Darbon theorizes: «Il faut déterminer la culture de base (a) et la culture extérieure (b), quels sont les éléments ajoutés et de quelle manière ils le sont»<sup>44</sup>. This statement can be useful to introduce and set up an analysis about the (exogenous) graft. In fact, it is necessary to point out the rootstock (the *bearing* element) and the scion[s] (the insertion[s]). Consequently, how can we distinguish the rootstock and the scion[s] and how to measure and quantify them? They can be found and appraised according to their presence rate.

As such, we propose a detailed example focusing on works by the Lebanese composer Zad Moultaqa. Our choice fell on this musical personality for different reasons. As we will explain later, we found in his composition creative actions that support an ideological center and then temporarily move away to explore also other aspects: a dissemination<sup>45</sup>. It could be considered a music made of *movement*, the same dynamism that Derrida saw in the (natu-

ral) citations of a text<sup>46</sup>. This oscillation develops between the two geographical and cultural references that Moultaqa has in his life.

Born in Beirut in 1967, Moultaqa started his music education in Lebanon and then during the 80's moved to France to study at CNSMD in Paris. He started composing, being an autodidact. Thanks to his particular style, he is appreciated in France and abroad. In his first composing period, it is possible to single out his purpose of synthesis between contemporary music technique and the sonorities of Arab musical roots<sup>47</sup>. We will analyze some of his compositions through the application of the concepts that we have explained above. We will lead this evaluation presenting and pointing out its advantages and its more accurate descriptive effects, comparing the ordinary types of analysis of this kind.

At first, we will consider *Ikhtifa*<sup>48</sup>, composed by Zad Moultaqa in 2008, for an ensemble of twelve singers. It is based on Arabic texts<sup>49</sup> by Abū al-‘Alā’ al-Ma‘arrī<sup>50</sup>. The core of this composition is founded on repetition about formal shape and melody. In particular, the melodic line develops through chromaticism and small intervals, since the melody repeats itself and always goes back

on the same turns<sup>51</sup>. This feature recalls traditional Arab<sup>52</sup> melodies, presenting the same monotony and reiteration. Melody seems to be the key element of the composition that is also evidenced by the fact that there are no instruments for the accompaniment, voices sound *a cappella* and consequently, all the attention is focused on what they sing. The rhythmical variety follows and supports the peculiar accentuation of the Arabic verses; this represents an important difference (or rather a contradiction) towards the melodic repetition<sup>53</sup>. Voices sing in homophony with short moments of heterophony. This balance is sometimes broken by some interventions: participation of different groups of voices, polyphonic and imitation<sup>54</sup> episodes, pedal sounds, emphasis of special phonemes, contemporary *silent sounds*. Through this short and general analysis, we can propose different observations.

If we examined the composition by an ordinary method, we would consider the existence of almost two different cultural influences that contribute to the construction of this music. Usual approaches do not seem to focus on or appraise the way through which interactions can be built, nor on the evaluation of the presence rate of the elements. An interpretation supported by the graft theory can explain this aspect, indeed, in this case, we can state that this music consists of an Arab rootstock that often moves away from itself to reach some occidental scions<sup>55</sup>. The general setting of the composition leads us to

confirm this reflection. In fact, it is assembled keeping the natural features of Arabic language, of Arab monodical melody and, partially, of rhythm: this clearly represents the rootstock. The sporadic insertions that we listed above change the flux of the conception, they constitute the *foreign* elements. We can also note the quality of this graft, as it concerns elements from traditional music and artistic music, in other words oral and written music. A deeper study on this work could strengthen and corroborate what we have demonstrated.

Another example can clarify the explanation. *Ya ghazali*<sup>57</sup> is a composition belonging to a song cycle, *Zarani*, a redrafting of traditional Lebanese songs, called *muwashshahāt*. For the popular tradition, these melodies are performed by different voices and ensembles, but in this case, Zad Moultaqa chose to interpret it through a specific group of instruments accompanying a solo voice<sup>58</sup>: oud, percussion (zarb) and piano. We can observe primarily an organology graft, because of the presence of some instruments that come from Arabic-Lebanese tradition, such as the oud or the zarb, and then their crossing and fusion with the occidental presence of the piano. The structure of this composition proposes important changes towards the original version. For example, the choice of an occidental formal aspect through different sections<sup>59</sup> where, besides the accompaniment of melody, instruments (above all the oud and the piano) show virtuoso passages. The composer presents different instrumental techniques, like clusters, harmonic sounds and strings playing for piano, nail plucking sounds and glissando for oud. Piano often represents a harmonic sustain, playing chords: this is a strong occidental<sup>60</sup> element, supporting and underlining the melody. The original melodic line is extended through the different sections, it is always preserved, keeping the traditional Arabic singing, with particular small intervals like the quarters of tone. This fleeting description leads to the conclusion that the Arabic soul of this music maintains a central role, consequently it can be considered as the rootstock of

this work<sup>61</sup>. All sporadic actions of redrafting (the formal structure, the instrumental insertions, and the piano chord accompaniment) represent the scions<sup>62</sup>.

A further example shows other aspects of graft analysis. We will consider another work by the Lebanese composer, for solo voice<sup>63</sup> and electronics: *Neb Ankh*<sup>64</sup>,

based on a text written by Zad Moultaqa in an invented language<sup>65</sup>, inspired by the Egyptian Book of Shu. It is a complex composition where vocal melodies and electronic sounds seem to tell a story about a Princess that leaves her sarcophagus and explores life<sup>66</sup>. Music depicts this story, through its five stanzas, starting with intimate vocal melopoeias supported by a metallic sound environment produced by electronics. Voice makes use of percussive effects on consonants and extensions of the melodic line as well as concentrating on small intervals (such as quarters of tone). Electronics, in the different stanzas of the composition, works by supporting or dominating the voice, representing different kinds of sounds and samples reproducing indoor, external environments, until the musical atmosphere evokes Arab folkloristic celebrations. In this heterogeneous situation, graft allows us to quantify the participation of the different elements. As a result, we can note certain aspects: the formal structure (following the organization of the text), the main occidental contemporary vocal techniques, and the predominance of electronics which constitute the occidental rootstock that receives the occasional insertions of Arab scions.

The condensed examples that we have examined describe an idea about what graft is and how to find its elements in order to analyze a musical composition. Throughout the history of the culture and branched evolution, graft has become an instrument to recognize the heterogeneity of music and its effects. The real subversion consists of its utilization in musicology, where it has not yet found its extensive use.

This metaphor describes the many-sided development of musical composition and at the same time, it ensures that the original sense of graft is never forgotten, that is to say grafting to extend existence, that in music could also mean expanding the boundaries of creation.
