# TWO DIMENSIONAL GROSS-PITAEVSKII EQUATION WITH SPACE-TIME WHITE NOISE

#### Abstract

In this paper we consider the two-dimensional stochastic Gross-Pitaevskii equation, which is a model to describe Bose-Einstein condensation at positive temperature. The equation is a complex Ginzburg Landau equation with a harmonic potential and an additive space-time white noise. We study the well-posedness of the model using an inhomogeneous Wick renormalization due to the potential, and prove the existence of an invariant measure and of stationary martingale solutions.


## 1. Introduction

The paper is concerned with the mathematical analysis of the two-dimensional Gross-Pitaevskii equation, which is a model for Bose-Einstein condensates in the presence of stochastic effects, e.g. temperature effects arising around the critical temperature of condensation. Interactions of the condensate with the "thermal cloud" formed by non-condensed atoms need to be taken into account in this situation. Those interactions should preserve the principles of the fluctuationdissipation theorem, which ensures formally the relaxation of the system to the expected physical equilibrium (see $[2,10,12]$ ), leading to the so-called Projected Gross-Pitaevskii equation.

Neglecting the projection operator on the lowest energy modes, and setting the chemical potential to zero, the equation for the macroscopic wave function $\psi$ may be written in its simplest dimensionless form :

\end{equation*}

where $V(x)$ is a confining, generally harmonic, potential, and $\dot{W}_{\gamma}$ is a two-dimensional space-time white noise that is a Gaussian field with delta correlations in time and space :

\left\langle\dot{W}_{\gamma}^{*}(s, y), \dot{W}_{\gamma}(t, x)\right\rangle=2 \gamma \delta_{t-s} \delta_{x-y}
$$

[^0]The constant $g$ is a positive physical constant. When $\gamma=0$, one recovers the standard GrossPitaevskii equation for the wave function $\psi$, and in this case the hamiltonian

$$
\mathcal{H}(\psi)=\frac{1}{2} \int_{\mathbb{R}^{2}}|\nabla \psi(x)|^{2} d x+\frac{1}{2} \int_{\mathbb{R}^{2}} V(x)|\psi(x)|^{2} d x+\frac{g}{4} \int_{\mathbb{R}^{2}}|\psi(x)|^{4} d x

is conserved. It follows that for $\gamma>0$, a formal Gibbs measure for (1.1) is given by

$$
\rho(d \psi)=\Gamma \exp [-\mathcal{H}(\psi)] d \psi,
$$

for some normalizing constant $\Gamma$.
In this article we consider the harmonic potential $V(x)=|x|^{2}$. Equation (1.1) has been studied in space dimension one in [3], and the existence of global solutions for all initial data was proved. The convergence to equilibrium was also obtained in [3], thanks to a Poincaré inequality, and to the properties of the invariant measure previously proved in [4], where its support was in particular shown to contain $L^{p}(\mathbb{R})$ for any $p>2$.

The aim of the present paper is to extend part of those results to the two-dimensional case. Note that nothing was known in this case about the Gibbs measure, which has to be built. A first remark to be done is that the Gaussian measure generated by the linear equation is only supported in $\mathcal{W}^{-s, q}$, with $s>0, q \geq 2$, and $s q>2$ (here, $\mathcal{W}^{-s, q}$ is a Sobolev space based on the operator $-\Delta+V$, see Section 2 below). Hence, as is the case for the stochastic quantization equations, the use of renormalization is necessary in order to give a meaning to the solutions of (1.1) in the support of the latter Gaussian measure.

Renormalization procedures, using Wick products, have been by now widely used in the context of stochastic partial differential equations (see e.g. for the case of dimension 2 considered here $[5,6,8,17,22]$ and references therein), in particular for parabolic equations based on gradient flows. The complex Ginzburg-Landau equation driven by space-time white noise, i.e. (1.1) without the confining potential, posed on the three-dimensional torus, was studied in [13] and for the two-dimensional torus in $[16,21]$. The main difference in our case is the presence of the harmonic potential $V$. It is thus natural to use functional spaces based on the operator $-H=-\Delta+V$, rather than on standard Sobolev or Besov spaces; we chose to work on Sobolev spaces based on $-H$ since it is enough for our analysis, but we need to prove all the necessary product rules in these spaces.

Several difficulties arise when trying to adapt the previous methods to the present twodimensional case. First, the diverging constant in the definition of the Wick product is no more a constant, but rather a function of the space variable $x$; This is already the case for SPDEs on manifolds for instance and does not imply many difficulties. However, up to our knowledge, Wick products corresponding to the Gaussian measure associated to the operator $-H$ considered here have never been constructed. An essential tool in the definition of the Wick products is the kernel $K(x, y)$ of the operator $(-H)^{-1}$, and in particular its integrability properties. It appears ([19]) that $K$ is never in $L^{p}\left(\mathbb{R}_{x} \times \mathbb{R}_{y}\right)$, for any $p \geq 1$, but we only have $K \in L^{r}\left(\mathbb{R}_{x} ; L^{p}\left(\mathbb{R}_{y}\right)\right)$ for $r>p \geq 2$ (see Proposition 5 below).

Using these properties of the kernel $K$, we construct the Wick products with respect to the Gaussian measure with covariance $(-H)^{-1}$ and use the method of [6] to construct local solutions. Then using ideas from [17], we are able to prove that the solutions are global when $\gamma$ is sufficiently large. Moreover, we prove that (1.1) has an invariant measure which is the limit of

Gibbs measures corresponding to finite dimensional approximations of this equation. This can be seen as a construction of the infinite dimensional Gibbs measure $\rho$.

Since the kernel $K$ is not in $L^{4}\left(\mathbb{R}_{x} \times \mathbb{R}_{y}\right)$, we strongly believe that, contrary to the space dimension one, this Gibbs measure is singular with respect to the equilibrium Gaussian measure of the linear equation.

It is expected that (1.1) has a unique invariant measure. Strong Feller property of the associated transition semigroup can be proved using similar arguments as in [22] or [7]. Unfortunately, irreducibility seems to be much more difficult. This question will be the object of a future work.

Another problem we encounter is that we are not able to prove global existence for any $\gamma$. We cannot use the same argument as in [3]. This would need a better understanding of the Gibbs measure $\rho$. Instead, we construct martingale stationary solutions when $\gamma$ is small.

## 2. Preliminaries and main Results.

Writing equation (1.1) in a more mathematical form, we will consider in what follows the infinite dimensional, stochastic complex Ginzburg-Landau equation, with a harmonic potential:

d X=\left(\gamma_{1}+i \gamma_{2}\right)\left(H X-|X|^{2} X\right) d t+\sqrt{2 \gamma_{1}} d W, \quad t>0, \quad x \in \mathbb{R}^{2}, \tag{2.1}
\end{equation*}
$$

where $H=\Delta-|x|^{2}, x \in \mathbb{R}^{2}$. We consider a more general equation with parameters $\gamma_{1}>0$, and $\gamma_{2} \in \mathbb{R}$, in order to clarify the effects of the dissipation induced by $\gamma_{1}$. Let $\left\{h_{k}\right\}_{k \in \mathbb{N}^{2}}$ be the orthonormal basis of $L^{2}\left(\mathbb{R}^{2}, \mathbb{R}\right)$, consisting of eigenfunctions of $-H$ with corresponding eigenvalues $\left\{\lambda_{k}^{2}\right\}_{k \in \mathbb{N}^{2}}$, i.e. $-H h_{k}=\lambda_{k}^{2} h_{k}$. It is known that $\lambda_{k}^{2}=2|k|+2$ with $k=\left(k_{1}, k_{2}\right) \in \mathbb{N}^{2}$, and the functions $h_{k}(x)$ are the Hermite functions. The unknown function $X$ is a complex valued random field on a probability space $(\Omega, \mathcal{F}, \mathbb{P})$ endowed with a standard filtration $\left(\mathcal{F}_{t}\right)_{t \geq 0}$.

We take $\left\{h_{k}, i h_{k}\right\}_{k \geq 0}$ as a complete orthonormal system in $L^{2}\left(\mathbb{R}^{2}, \mathbb{C}\right)$, and we may write the cylindrical Wiener process as

\begin{equation*}
W(t, x)=\sum_{k \in \mathbb{N}^{2}}\left(\beta_{k, R}(t)+i \beta_{k, I}(t)\right) h_{k}(x) . \tag{2.2}
\end{equation*}
$$

Here, $\left(\beta_{k, R}(t)\right)_{t \geq 0}$ and $\left(\beta_{k, I}(t)\right)_{t \geq 0}$ are sequences of independent real-valued Brownian motions, on the stochastic basis $\left(\Omega, \mathcal{F}, \mathbb{P},\left(\mathcal{F}_{t}\right)_{t \geq 0}\right)$. In all what follows, the notation $\mathbb{E}$ stands for the expectation with respect to $\mathbb{P}$.

For $1 \leq p \leq+\infty$, and $s \in \mathbb{R}$, we define the Sobolev space associated to the operator $H$ :

\mathcal{W}^{s, p}\left(\mathbb{R}^{2}\right)=\left\{v \in \mathcal{S}^{\prime}\left(\mathbb{R}^{2}\right),|v|_{\mathcal{W}^{s, p}\left(\mathbb{R}^{2}\right)}:=\left|(-H)^{s / 2} v\right|_{L^{p}\left(\mathbb{R}^{2}\right)}<+\infty\right\},
$$

where $\mathcal{S}$ and $\mathcal{S}^{\prime}$ denote the Schwartz space and its dual space, respectively. If $I$ is an interval of $\mathbb{R}$, $E$ is a Banach space, and $1 \leq r \leq \infty$, then $L^{r}(I, E)$ is the space of strongly Lebesgue measurable functions $v$ from $I$ into $E$ such that the function $t \rightarrow|v(t)|_{E}$ is in $L^{r}(I)$. We define similarly the spaces $C(I, E), C^{\alpha}(I, E)$ or $L^{r}(\Omega, E)$. For a complex Hilbert space $E$, the inner product will be understood as taking the real part, i.e., for $u=u^{R}+i u^{I} \in E$ and $v=v^{R}+i v^{I} \in E$, then we set $(u, v)_{E}:=\left(u^{R}, v^{R}\right)_{E}+\left(u^{I}, v^{I}\right)_{E}$ that is we use the identification $\mathbb{C} \simeq \mathbb{R}^{2}$. The bracket notation is used for the meaning $\langle f\rangle:=\left(1+|f|^{2}\right)^{1 / 2}$. We denote by $E_{N}^{\mathbb{C}}$ the complex vector space spanned by the Hermite functions, $E_{N}^{\mathbb{C}}=\operatorname{span}\left\{h_{0}, h_{1}, \ldots, h_{N}\right\}$. If we write $E_{N}^{\mathbb{R}}$ this means the real vector space instead.

In the course of the proofs, we will frequently use an approximation by finite dimensional objects. In order to clarify the convergence properties of a function series of the form $u=\sum_{k \in \mathbb{N}^{2}} c_{k} h_{k}$, we define, for any $N \in \mathbb{N}$ fixed, for any $p \in[1, \infty]$, and $s \in \mathbb{R}$, a smooth projection operator $S_{N}: L^{2}\left(\mathbb{R}^{2}, \mathbb{C}\right) \rightarrow E_{N}^{\mathbb{C}}$ by

\begin{equation*}
S_{N}\left[\sum_{k \in \mathbb{N}^{2}} c_{k} h_{k}\right]:=\sum_{k \in \mathbb{N}^{2}} \chi\left[\frac{\lambda_{k}^{2}}{\lambda_{N}^{2}}\right] c_{k} h_{k}=\chi\left[\frac{-H}{\lambda_{N}^{2}}\right]\left[\sum_{k \in \mathbb{N}^{2}} c_{k} h_{k}\right], \tag{2.3}
\end{equation*}
$$

where $\chi \geq 0$ is a cut-off function such that $\chi \in C_{0}^{\infty}(-1,1), \chi=1$ on $\left[-\frac{1}{2}, \frac{1}{2}\right]$. Note that here and in what follows, we denote by $\lambda_{N}$ the value $\lambda_{(N, 0)}$, for simplicity. The operator $S_{N}$, which is self-adjoint and commutes with $H$, may easily be extended by duality to any Sobolev space $\mathcal{W}^{s, 2}\left(\mathbb{R}^{2} ; \mathbb{C}\right)$, with $s \in \mathbb{R}$, and thus by Sobolev embeddings, to any space $\mathcal{W}^{s, p}\left(\mathbb{R}^{2} ; \mathbb{C}\right)$, with $p \geq 1$. We will use of the following lemma, whose proof is similar to Theorem 1.1 of [14].

Lemma 2.1. For any $\psi \in \mathcal{S}(\mathbb{R})$ and any $p \in[1, \infty]$, there exists a constant $C=C(\psi)>0$ such that

$$
|\psi(-\theta H)|_{\mathcal{L}\left(L^{p}, L^{p}\right)} \leq C,
$$

for any $\theta \in(0,1)$.
This lemma implies that $S_{N}$ is a bounded operator from $L^{p}$ to $L^{p}$, uniformly in $N$, for any $p \in[1, \infty]$. Note that the usual spectral projector,

$$
\Pi_{N}\left[\sum_{k \in \mathbb{N}^{2}} c_{k} h_{k}\right]:=\sum_{k \in \mathbb{N}^{2},|k| \leq N} c_{k} h_{k},

does not satisfy this property.
As was pointed out in the introduction, due to the space-time white noise, the solution of (2.1) is expected to have negative space regularity, and thus the nonlinear term $-|X|^{2} X$ is illdefined. In order to make sense of this term, we use a renormalization procedure based on Wick products. This amounts to "subtract an infinite constant" from the nonlinear term in (2.1). More precisely, writing the solution $X=u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}$ with

Z_{\infty}^{\gamma_{1}, \gamma_{2}}(t)=\sqrt{2 \gamma_{1}} \int_{-\infty}^{t} e^{(t-\tau)\left(\gamma_{1}+i \gamma_{2}\right) H} d W(\tau) \tag{2.4}
\end{equation*}
$$

which is the stationary solution for the linear stochastic equation

$$
\begin{equation*}
d Z=\left(\gamma_{1}+i \gamma_{2}\right) H Z d t+\sqrt{2 \gamma_{1}} d W \tag{2.5}
\end{equation*}
$$

we find out the following random partial differential equation for $u$ :

$$
\begin{equation*}
\partial_{t} u=\left(\gamma_{1}+i \gamma_{2}\right)\left(H u-\left|u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right|^{2}\left(u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)\right), \quad u(0)=u_{0}:=X(0)-Z_{\infty}^{\gamma_{1}, \gamma_{2}}(0) . \tag{2.6}
\end{equation*}
$$

We are therefore required to solve this random partial differential equation. However, using standard arguments, it is not difficult to find that the best regularity we may expect for $Z_{\infty}^{\gamma_{1}, \gamma_{2}}$ is almost surely: $Z_{\infty}^{\gamma_{1}, \gamma_{2}} \in \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)$ for $s>0, q \geq 2, s q>2$, see Lemma 3.6 below. Developing

\left|u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right|^{2}\left(u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)= & |u|^{2} u+2|u|^{2} Z_{\infty}^{\gamma_{1}, \gamma_{2}}+\bar{u}\left(Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{2}+u^{2} \overline{Z_{\infty}^{\gamma_{1}, \gamma_{2}}} \\
& +2 u\left|Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right|^{2}+\left|Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right|^{2} Z_{\infty}^{\gamma_{1}, \gamma_{2}}, \tag{2.7}
\end{align*}

we are led to multiply functions having both negative Sobolev regularity, which cannot be defined in the usual distribution sense.

We need some preliminaries before we introduce the renormalization procedure. Let us recall a few facts about Hermite polynomials $H_{n}(x), n \in \mathbb{N}$, These are defined through the generating functions

e^{-\frac{t^{2}}{2}+t x}=\sum_{n=0}^{\infty} \frac{t^{n}}{\sqrt{n!}} H_{n}(x), \quad x, t \in \mathbb{R},

where

H_{n}(x)=\frac{(-1)^{n}}{\sqrt{n!}} e^{\frac{x^{2}}{2}} \frac{d^{n}}{d x^{n}}\left(e^{-\frac{x^{2}}{2}}\right), \quad n \geq 1 \tag{2.8}
\end{equation*}
$$

and $H_{0}(x)=1$. The Wick products of $Z_{\infty}^{\gamma_{1}, \gamma_{2}}$ are defined as follows. We write $Z_{R, \infty}=\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}$ and $Z_{I, \infty}=\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}$. For any $k, l \in \mathbb{N}$, we define

$$
:\left(Z_{R, \infty}\right)^{k}\left(Z_{I, \infty}\right)^{l}: \quad:=\lim _{N \rightarrow \infty}:\left(S_{N} Z_{R, \infty}\right)^{k}::\left(S_{N} Z_{I, \infty}\right)^{l}:, \quad \text { in } \quad L^{q}\left(\Omega, \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)\right)
$$

where $s>0, q \geq 4$ and $s q>8$. In the right hand side, the notation : $\left(S_{N} z\right)^{n}:(x)$ for $n \in \mathbb{N}$, $N \in \mathbb{N}, x \in \mathbb{R}^{2}$, and for a real-valued centered Gaussian white noise $z$, means

:\left(S_{N} z\right)^{n}:(x)=\rho_{N}(x)^{n} \sqrt{n!} H_{n}\left[\frac{1}{\rho_{N}(x)} S_{N} z(x)\right], \quad x \in \mathbb{R}^{2}
$$

with

$$
\rho_{N}(x)=\left[\sum_{k \in \mathbb{N}^{2}} \chi^{2}\left(\frac{\lambda_{k}^{2}}{\lambda_{N}^{2}}\right) \frac{1}{\lambda_{k}^{2}}\left(h_{k}(x)\right)^{2}\right]^{\frac{1}{2}} .
$$

More details about the Wick products will be given in Section 3.1, where the above convergence will be proved, and we will see that the Wick product is indeed well-defined in $\mathcal{W}^{-s, q}$, as soon as $s>0, q \geq 4$ and $q s>8$ (see Proposition 4).

We thus consider the following renormalized equation in the space $\mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)$ (in the weak sense):

d X & =\left(\gamma_{1}+i \gamma_{2}\right)\left(H X-:|X|^{2} X:\right) d t+\sqrt{2 \gamma_{1}} d W, \quad t>0, \quad x \in \mathbb{R}^{2},  \tag{2.9}\\
X(0) & =X_{0},
\end{align*}
$$

in the sense that we solve the shifted equation (2.6) with $\left|u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right|^{2}\left(u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)$ replaced by $:\left|u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right|^{2}\left(u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)$ : defined by replacing in (2.7) all the terms involving $Z_{\infty}^{\gamma_{1}, \gamma_{2}}$ by the corresponding wick products (see (3.24) for a more precise definition).

Hence we consider

$$
\begin{equation*}
\partial_{t} u=\left(\gamma_{1}+i \gamma_{2}\right)\left[H u-:\left|u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right|^{2}\left(u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right):\right], \tag{2.10}
\end{equation*}
$$

supplemented with the initial condition

$$
u(0)=u_{0}=X_{0}-Z_{\infty}^{\gamma_{1}, \gamma_{2}}(0) .
$$

We will first prove the following local well-posedness result of equation (2.10).

Theorem 1. Fix any $T>0$. Let $\gamma_{1}>0, \gamma_{2} \in \mathbb{R}$ and $q>p>3 r, r>6$. Assume $0<s<\beta<$ $2 / p$, qs $>8, \beta-s>\frac{2}{p}-\beta$ and $s+2\left(\frac{2}{p}-\beta\right)<2\left(1-\frac{1}{q}\right)$. Let $u_{0} \in \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)$. Then there exists a random stopping time $T_{0}^{*}(\omega)>0$, which depends on $u_{0}$ and $\left(:\left(\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{k}\left(\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{l}:\right)_{0 \leq k+l \leq 3}$, and a unique solution $u$ of (2.10) such that $u \in C\left(\left[0, T_{0}^{*}\right), W^{-s, q}\left(\mathbb{R}^{2}\right)\right) \cap L^{r}\left(0, T_{0}^{*}, W^{\beta, p}\left(\mathbb{R}^{2}\right)\right)$ a.s. We have moreover almost surely $T_{0}^{*}=T$ or $\lim _{t \uparrow T_{0}^{*}}|u(t)|_{\mathcal{W}^{-s, q}}=+\infty$.

When the dissipation coefficient $\gamma_{1}$ is sufficiently large, an energy estimate allows to get a bound on the $L^{q}$ norm of the solution, and to deduce a global existence result, as is stated in the next Propositions and Theorem. This method of globalization has been widely used for the complex Ginzburg-Landau equation (see [1, 9]) and has been adapted in the renormalized case ( $[13,17]$ ).

Proposition 1. Let $\gamma_{1}>0, \gamma_{2} \in \mathbb{R}$ and $q>p>3 r, r>6$. Assume $0<s<\beta<2 / p$ satisfy the assumptions of Theorem 1 and that we have in addition $s \leq \frac{2}{p}-\beta<\frac{1}{12}$, with $2\left(\frac{2}{p}-\beta\right)<\beta$ and $3\left(\frac{2}{p}-\beta\right)<2\left(1-\frac{1}{q}\right)$. Let $u_{0} \in L^{q}\left(\mathbb{R}^{2}\right)$. Then the solution $u$ of $(2.10)$ given by Theorem 1 satisfies : $u \in C\left(\left[0, T_{0}^{*}\right), L^{q}\left(\mathbb{R}^{2}\right)\right)$.

In the next Proposition we give the $L^{q}$ a priori bound.
Proposition 2. $\left[L^{q}\right.$ a priori estimate]. Let $\gamma_{1}>0$ and $q>p>3 r, r>6$. Assume $0<s<$ $\beta<2 / p$ satisfy the assumptions of Theorem 1 and we have in addition $s \leq \frac{2}{p}-\beta<\frac{1}{12}$, with $2\left(\frac{2}{p}-\beta\right)<\beta$ and $3\left(\frac{2}{p}-\beta\right)<2\left(1-\frac{1}{q}\right)$. Moreover assume $\gamma_{2}=0$, or $q<2+2\left(\kappa^{2}+\kappa \sqrt{1+\kappa^{2}}\right)$ with $\kappa=\gamma_{1} / \gamma_{2}$ if $\gamma_{2} \neq 0$. Let $u_{0} \in L^{q}\left(\mathbb{R}^{2}\right)$, and let $u$ be the unique solution constructed in Theorem 1. Then, there exists a constant $C>0$ depending on $\gamma_{1}, \gamma_{2}, q$ and $\left(:\left(\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{k}\left(\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{l}\right.$ : $)_{0 \leq k+l \leq 3}$, such that for any $t$ with $0<t<T_{0}^{*}$,

$$
|u(t)|_{L^{q}}^{q} \leq e^{-\frac{\gamma_{1} t \delta}{4}}\left|u_{0}\right|_{L^{q}}^{q}+C
$$

where $T_{0}^{*}$ is the maximal existence time given in Theorem 1. The coefficient $\delta$ is given by $\delta=1$ if $\gamma_{2}=0$, and $\delta=1-\frac{q-2}{2\left(\kappa^{2}+\kappa \sqrt{1+\kappa^{2}}\right)}$ if $\gamma_{2} \neq 0$.

Gathering the previous results and using the smoothing properties of the heat semi-group, we finally obtain the global existence of solutions in the case of large dissipation.

Theorem 2. Let $\gamma_{1}>0$ and $q>p>3 r, r>6$. Assume $0<s<\beta<2 / p$ satisfy the assumptions of Theorem 1 and we have in addition $s \leq \frac{2}{p}-\beta<\frac{1}{12}$, with $2\left(\frac{2}{p}-\beta\right)<\beta$ and $3\left(\frac{2}{p}-\beta\right)<2\left(1-\frac{1}{q}\right)$. Moreover assume $\gamma_{2}=0$, or $q<2+2\left(\kappa^{2}+\kappa \sqrt{1+\kappa^{2}}\right)$ with $\kappa=\frac{\gamma_{1}}{\gamma_{2}}$ if $\gamma_{2} \neq 0$. Let $u_{0} \in \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)$. Then there exists a unique global solution $u$ of (2.10) in $C\left([0, T], \mathcal{W}^{-s, q}\right) \cap L^{r}\left(0, T ; \mathcal{W}^{\beta, p}\right)$ a.s. for any $T>0$.

Now that we have at hand a global flow, for $\gamma_{1}$ large enough, the next step is the construction of a Gibbs measure. The Gibbs measure is formally written as an infinite-dimensional measure of the following form:

\rho(d u)=\Gamma e^{-\mathcal{H}(u)} d u
$$

where

\mathcal{H}(u)=\frac{1}{2} \int_{\mathbb{R}^{2}}|\nabla u(x)|^{2} d x+\frac{1}{2} \int_{\mathbb{R}^{2}}|x u(x)|^{2} d x+\frac{1}{4} \int_{\mathbb{R}^{2}}|u(x)|^{4} d x,
$$

and $\Gamma$ is a normalizing constant. We will make sense of this infinite dimensional measure as follows. Using (2.2), it may be easily seen that (2.4) can be written as

Z_{\infty}^{\gamma_{1}, \gamma_{2}}(t)=\sum_{k \in \mathbb{N}^{2}} \frac{\sqrt{2}}{\lambda_{k}} g_{k}(\omega, t) h_{k}(x), \tag{2.11}
\end{equation*}
$$

where $\left\{g_{k}(\omega, t)\right\}_{k \in \mathbb{N}^{2}}$ is a system of independent, complex-valued random variables with law $\mathcal{N}_{\mathbb{C}}(0,1)$. Thus, the projection onto $E_{N}^{\mathbb{C}}$ of the stationary solution $Z_{\infty}^{\gamma_{1}, \gamma_{2}}(t)$ has the same law as the Gaussian measure $\mu_{N}$ induced by a random series

$$
\varphi_{N}(\omega, x):=\sum_{k \in \mathbb{N}^{2},|k| \leq N} \frac{\sqrt{2}}{\lambda_{k}} g_{k}(\omega) h_{k}(x)
$$

defined on $(\Omega, \mathcal{F}, \mathbb{P})$ where $\left\{g_{k}(\omega)\right\}_{k \in \mathbb{N}^{2}}$ is a system of independent, complex-valued random variables with the law $\mathcal{N}_{\mathbb{C}}(0,1)$. Thanks to the same argument as Lemma 2.1 in [3], combined with Proposition 5 below, the series converges in $L^{q}\left(\Omega, \mathcal{W}^{-s, q}\right)$ if $s>0, q \geq 2$ and $s q>2$ (see Lemma 3.6 below), and the limit defines the infinite-dimensional Gaussian measure $\mu$ on $\mathcal{W}^{-s, q}$. However, although the above Gibbs expression may be formally written as

\rho(d u)=\Gamma e^{-\frac{1}{4} \int_{\mathbb{R}^{2}}|u(x)|^{4} d x} \mu(d u),
$$

we cannot make sense of it, since $L^{4}\left(\mathbb{R}^{2}\right)$ is not in the support of $\mu$. For that reason, we should also renormalize the $L^{4}$ norm in the Gibbs measure. However, it is not clear how this can be done in a compatible way. This fact leads us to define the Gibbs measure for (2.9) as a limit of

\tilde{\rho}_{N}(d y)=\Gamma_{N} \exp \left\{-\int_{\mathbb{R}^{2}}\left(\frac{1}{4}\left|S_{N} y(x)\right|^{4}-2 \rho_{N}^{2}(x)\left|S_{N} y(x)\right|^{2}+2 \rho_{N}^{4}(x)\right) d x\right\} \mu_{N}(d y), \quad y \in E_{N}^{\mathbb{C}}
$$

where $\Gamma_{N}$ is the normalizing constant. We can indeed prove the tightness of the family of measures $\left(\tilde{\rho}_{N}\right)_{N \in \mathbb{N}}$.

Theorem 3. Let $\gamma_{1}, \gamma_{2}, q, s$ be as in Theorem 2. Then, there exists an invariant measure $\rho$ supported in $\mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)$, for the transition semi-group associated with equation (2.9), which is well-defined according to Theorem 2. Moreover, $\rho$ is the weak limit of a subsequence of the family $\left(\tilde{\rho}_{N}\right)_{N}$ defined above.

Note that the measure $\tilde{\rho}_{N}$ does not depend on $\gamma_{1}$ or $\gamma_{2}$, but the tightness $\left(\tilde{\rho}_{N}\right)_{N \in \mathbb{N}}$ is not induced by a $L^{q}$ bound as in Proposition 2, which does not a priori hold for the finite dimensional approximations of equation (2.10). We thus have to prove an alternative bound (see Proposition 7 in Section 4) and, unfortunately, this latter bound does not provide higher moment bounds on the measures $\tilde{\rho}_{N}$, preventing us to obtain global strong solutions in the small dissipation case, as would be expected. Nevertheless, the bound in Proposition 7 allows us to construct a stationary martingale solution for any dissipation coefficients:

Theorem 4. Let $\gamma_{1}>0$ and $\gamma_{2} \in \mathbb{R}$, and let $0<s<1, q>8$, $s q>8$. Then, there exists a stationary martingale solution $X$ of (2.9) having trajectories in $C\left(\mathbb{R}_{+}, \mathcal{W}^{-s, q}\right)$ and such that for any $t \geq 0, \mathcal{L}(X(t))=\rho$, the measure constructed in Theorem 3 .

The paper is organized as follows. Section 3 consists of three parts. In Section 3.1, we begin with the definition of Wick products suitable to our equation, and study the regularity of the Wick products. In Section 3.2, we list up the properties of the heat semigroup $\left(e^{t\left(\gamma_{1}+i \gamma_{2}\right) H}\right)_{t \geq 0}$. Section 3.3 is devoted to the proof of Theorem 1 introducing a polynomial estimate to deal with the nonlinear terms. In Section 4.1, we pay attention to the global existence of solutions in the case of large dissipation. We derive the $L^{q}$ a priori bound and prove that the solution exists globally in time by the smoothing properties of the heat semigroup. Furthermore, in Section 4.2, we consider a finite-dimensional approximation to (2.9), and the associated finitedimensional Gibbs measure. The tightness of this finite-dimensional family of measures is proved and the limit is obtained to be an invariant measure for the case of large dissipation concluding Theorem 3. Finally, using moment bounds and a compactness argument, we prove in Section 5 the existence of a stationary martingale solution without restriction on the dissipation parameter.

## 3. Local Existence

3.1. Preliminary results on the regularity of Wick products. We begin with introducing some useful tools in the space $\mathcal{W}^{s, p}\left(\mathbb{R}^{2}\right)$.

Proposition 3. (1) For any $p \in(1, \infty)$ and $s \geq 0$, there exists $C>0$ such that

$$
\frac{1}{C}|f|_{\mathcal{W}^{s, p}\left(\mathbb{R}^{2}\right)} \leq\left|\left\langle D_{x}\right\rangle^{s} f\right|_{L^{p}\left(\mathbb{R}^{2}\right)}+\left|\langle x\rangle^{s} f\right|_{L^{p}\left(\mathbb{R}^{2}\right)} \leq C|f|_{\mathcal{W}^{s, p}\left(\mathbb{R}^{2}\right)}
$$

(2) Let $\alpha \geq 0$. Then the following estimates hold.

|f g|_{\mathcal{W}^{\alpha, q}} \leq C\left(|f|_{L^{q_{1}}}|g|_{\mathcal{W}^{\alpha, q_{1}}}+|f|_{\mathcal{W}^{\alpha, q_{2}}}|g|_{L^{\overline{q_{2}}}}\right)
$$

where $1<q<\infty, q_{1}, q_{2} \in(1, \infty], \overline{q_{1}}, \overline{q_{2}} \in[1, \infty)$ with $\frac{1}{q}=\frac{1}{q_{1}}+\frac{1}{\overline{q_{1}}}=\frac{1}{q_{2}}+\frac{1}{\overline{q_{2}}}$.
Proof. The norm equivalence (1) was proved in [11], and for the interpolation estimate (2), see Proposition 1.1 of [20].

Let us now give some details on the construction of the Wick products. Let $\xi(x, \omega)$ be a mean-zero (real-valued) Gaussian white noise on $\mathbb{R}^{2}$ defined by

\xi(x, \omega)=\sum_{n \in \mathbb{N}^{2}} g_{n}(\omega) h_{n}(x)
$$

where $\left\{g_{n}(\omega)\right\}_{n}$ is a system of independent, real-valued random variables with $\mathcal{N}(0,1)$ law. For $f \in L^{2}\left(\mathbb{R}^{2}, \mathbb{R}\right)$, we define the mapping $W_{(\cdot)}: L^{2}\left(\mathbb{R}^{2}\right) \rightarrow L^{2}(\Omega), f \mapsto W_{f}$, by

W_{f}(\omega)=(f, \xi(\omega))_{L^{2}}=\sum_{n \in \mathbb{N}^{2}}\left(f, h_{n}\right)_{L^{2}} g_{n}(\omega)
$$

Then, $W_{f}$ is a mean-zero Gaussian random variable with variance $|f|_{L^{2}\left(\mathbb{R}^{2}\right)}^{2}$, and

$$
\mathbb{E}\left(W_{f} W_{g}\right)=(f, g)_{L^{2}}, \quad f, g \in L^{2}\left(\mathbb{R}^{2}, \mathbb{R}\right)
$$

This implies that $W_{(\cdot)}$ is an isometry from $L^{2}\left(\mathbb{R}^{2}, \mathbb{R}\right)$ to $L^{2}(\Omega)$. Moreover we have the relation

\mathbb{E}\left(H_{k}\left(W_{f}\right) H_{l}\left(W_{g}\right)\right)=\delta_{k, l} k!(f, g)_{L^{2}}^{k} \tag{3.1}
\end{equation*}

for any $f, g \in L^{2}\left(\mathbb{R}^{2}\right)$ with $|f|_{L^{2}}=|g|_{L^{2}}=1$, with the use of the Hermite polynomials (2.8).

Let us define for $n \geq 0$, the Wiener chaos of order $n$ as

\mathcal{H}_{n}=\overline{\left\{H_{n}\left(W_{f}\right): f \in L^{2}\left(\mathbb{R}^{2}\right),|f|_{L^{2}}=1\right\}},
$$

where the closure is taken in $L^{2}(\Omega)$. It is known that

L^{2}(\Omega, \mathcal{G}, \mathbb{P})=\bigoplus_{n=0}^{\infty} \mathcal{H}_{n}
$$

where $\mathcal{G}$ is the $\sigma$-algebra generated by $\left\{W_{f}, f \in L^{2}\left(\mathbb{R}^{2}\right)\right\}$ (see Theorem 1.1 of [18]). We shall denote by $P_{n}$ the orthogonal projection of $L^{2}(\Omega, \mathcal{G}, \mathbb{P})$ on $\mathcal{H}_{n}$. Then $\left(W_{f}\right)^{n} \in L^{2}(\Omega, \mathcal{G}, \mathbb{P})$ for any $f \in L^{2}\left(\mathbb{R}^{2}\right)$ with $|f|_{L^{2}}=1$, and the following holds.
Lemma 3.1. Let $f \in L^{2}\left(\mathbb{R}^{2}\right)$ satisfying $|f|_{L^{2}}=1$. Then we have,

P_{n}\left(\left(W_{f}\right)^{n}\right)=\sqrt{n!} H_{n}\left(W_{f}\right)
$$

Lemma 3.2. For any $F \in \mathcal{H}_{n}$, and $p \geq 2$,

\eta_{N}(x)(\cdot)=\frac{1}{\rho_{N}(x)} \sum_{k \in \mathbb{N}^{2}} \chi\left(\frac{\lambda_{k}^{2}}{\lambda_{N}^{2}}\right) \frac{h_{k}(x)}{\lambda_{k}} h_{k}(\cdot) \tag{3.3}
\end{equation*}
$$

for a fixed $x \in \mathbb{R}^{2}$, with

\rho_{N}^{2}=\rho_{N}^{2}(x)=\sum_{k \in \mathbb{N}^{2}} \chi^{2}\left(\frac{\lambda_{k}^{2}}{\lambda_{N}^{2}}\right) \frac{1}{\lambda_{k}^{2}}\left(h_{k}(x)\right)^{2}, \tag{3.4}
\end{equation*}
$$

so that $\left|\eta_{N}(x)\right|_{L^{2}\left(\mathbb{R}^{2}\right)}=1$. Then if $z(\omega, x)$ is of the form

z(\omega, x)=\sum_{k \in \mathbb{N}^{2}} \frac{\sqrt{2}}{\lambda_{k}} g_{k}(\omega) h_{k}(x), \quad \omega \in \Omega, x \in \mathbb{R}^{2}, \tag{3.5}
\end{equation*}

with a real-valued Gaussian system $\left\{g_{k}(\omega)\right\}_{k}$ with law $\mathcal{N}(0,1 / 2)$, we note that $S_{N} z(x)$ makes sense in $L^{2}(\Omega)$ for any $x \in \mathbb{R}^{2}$ and we may write

S_{N} z(x)=\sum_{k \in \mathbb{N}^{2}} \sqrt{2} g_{k}\left(\rho_{N}(x) \eta_{N}(x), h_{k}\right)_{L^{2}}=\rho_{N}(x) W_{\eta_{N}(x)}

We can thus, by Lemma 3.1, define the Wick product of $\left(S_{N} z\right)^{n}$ as follows.

For the reader's convenience, we give hereafter the expressions of the first three Wick products.

& :\left(S_{N} z\right)^{1}:(x)=S_{N} z(x) \\
& :\left(S_{N} z\right)^{2}:(x)=\left(S_{N} z\right)^{2}(x)-\rho_{N}(x)^{2}, \\
& :\left(S_{N} z\right)^{3}:(x)=\left(S_{N} z\right)^{3}(x)-3 \rho_{N}(x)^{2} S_{N} z(x)
\end{aligned}
$$

Note that the renormalization factor $\rho_{N}(x)$ depends on $x \in \mathbb{R}^{2}$, this is different from the torus case (see for ex., $[5,17,22]$ ). Since it is known from [15] that for any $k \in \mathbb{N}^{2}$,

we have for any $p \in[2,+\infty]$,

Note that $\theta(p)$ is at most $\frac{1}{5}$ so that $\rho_{N}^{2}$ may diverge a priori faster than in the torus case.
Recall that $Z_{\infty}^{\gamma_{1}, \gamma_{2}}$ can be written as (2.11). In order to consider a renormalization for the nonlinear term in (2.9), we decompose $Z_{\infty}^{\gamma_{1}, \gamma_{2}}=Z_{R, \infty}+i Z_{I, \infty}$ where $Z_{R, \infty}=\operatorname{Re}\left(Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)$ and $Z_{I, \infty}=\operatorname{Im}\left(Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)$ are independent, each of the form (3.5) and thus equal in law. Note that all the terms in (2.7) are products of powers of $\operatorname{Re} u, \operatorname{Im} u, Z_{R, \infty}$ and $Z_{I, \infty}$. Applying the above construction to $Z_{R, \infty}$ and $Z_{I, \infty}$, we may then define, for any integers $k, l \in \mathbb{N}$, the real valued Gaussian random variables : $\left(S_{N} Z_{R, \infty}\right)^{k}:$ and $:\left(S_{N} Z_{I, \infty}\right)^{l}:$, which are still independent. It is then natural to define, for all integers $k, l \in \mathbb{N}$, the Wick product : $\left(Z_{R, \infty}\right)^{k}\left(Z_{I, \infty}\right)^{l}$ : as the limit in $N$ of the product : $\left(S_{N} Z_{R, \infty}\right)^{k}::\left(S_{N} Z_{I, \infty}\right)^{l}$ :. The next proposition indeed shows that this limit is well defined in $L^{q}\left(\Omega ; W^{-s, q}\left(\mathbb{R}^{2}\right)\right)$ for $q \geq 4, s>0$ and $s q>8$. It would not be difficult to prove that this definition coincides with the Wick product that would be obtained with the use of an $\mathbb{R}^{2}$-valued white noise measure.

Proposition 4. For any $k, l \in \mathbb{N}$, the sequence $\left\{:\left(S_{N} Z_{R, \infty}\right)^{k}::\left(S_{N} Z_{I, \infty}\right)^{l}:\right\}_{N \in \mathbb{N}}$ is a Cauchy sequence in $L^{q}\left(\Omega, \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)\right)$, for $q \geq 4, s>0$ with $q s>8$.

Moreover, defining then, for any $k, l \in \mathbb{N}$,

:\left(Z_{R, \infty}\right)^{k}\left(Z_{I, \infty}\right)^{l}: \quad:=\lim _{N \rightarrow \infty}:\left(S_{N} Z_{R, \infty}\right)^{k}::\left(S_{N} Z_{I, \infty}\right)^{l}:, \quad \text { in } \quad L^{q}\left(\Omega, \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)\right)
$$

where $s>0, q \geq 4$ and $s q>8$, there exists a constant $M_{s, q, k, l}$ such that

\mathbb{E}\left[\left|:\left(\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{k}\left(\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{l}:\right|_{\mathcal{W}-s, q}^{q}\right] \leq M_{s, q, k, l} \tag{3.7}
\end{equation*}
$$

Higher order moments may also be estimated thanks to Nelson formula. The following corollary will be useful later.

Corollary 3.3. Let $s>0, m>q \geq 4$ and $s q>8$. Then there is a constant $M_{s, q, k, l, m}$ such that

& \quad \leq\left(\int_{\mathbb{R}^{2}}\left(\int_{\Omega}\left|(-H)^{-s / 2}:\left(\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{k}\left(\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{l}:\right|^{m} d \mathbb{P}\right)^{\frac{q}{m}} d x\right)^{\frac{m}{q}}
\end{aligned}
$$

Here we use Nelson estimate (3.2), and the right hand side is bounded by

(m-1)^{\frac{3}{2}}\left(\int_{\mathbb{R}^{2}} \mathbb{E}\left(\left|(-H)^{-s / 2}:\left(\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{k}\left(\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{l}:\right|^{2}\right)^{\frac{q}{2}} d x\right)^{\frac{m}{q}}
$$

Again, we apply Minkowski inequality to obtain

$$
\begin{aligned}
\mathbb{E}\left[\left|:\left(\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{k}\left(\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{l}:\right|_{\mathcal{W}^{-s, q}}^{m}\right] & \leq C_{m} \mathbb{E}\left(\left|:\left(\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{k}\left(\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{l}:\right|_{\mathcal{W}^{-s, q}}^{2}\right)^{\frac{m}{2}} \\
\leq C_{m} \mathbb{E}\left(\left|:\left(\operatorname{Re} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{k}\left(\operatorname{Im} Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)^{l}:\right|_{\mathcal{W}^{-s, q}}^{q}\right)^{\frac{m}{q}} & \leq C_{m} M_{s, q, k, l}^{\frac{m}{q}},
\end{aligned}
$$

thanks to Hölder inequality and (3.7).
For the proof of Proposition 4, the key ingredients are estimates on the kernel $K$ of the operator $(-H)^{-1}$, which is defined by $(-H)^{-1} f(x)=\int_{\mathbb{R}^{2}} K(x, y) f(y) d y$, and may be written as

\begin{equation*}
K(x, y)=\sum_{k \in \mathbb{N}^{2}} \frac{h_{k}(x) h_{k}(y)}{\lambda_{k}^{2}}, \quad x, y \in \mathbb{R}^{2} . \tag{3.9}
\end{equation*}
$$

The kernel $K$ has the following regularity properties.
Proposition 5. For any $n \in \mathbb{N}^{*}$, we have $K^{n} \in L_{x}^{r} \mathcal{W}_{y}^{\alpha, 2}$ for any $r \geq 2$ and $\alpha<1-\frac{2}{r}$.
For the proof of Proposition 5 we will need the following lemmas.
Lemma 3.4. Let $r, r_{1}, r_{2} \geq 1, p \geq 2$, and $0<\alpha<\sigma$ with $\frac{1}{r}=\frac{1}{r_{1}}+\frac{1}{r_{2}}$ and $\frac{\sigma-\alpha}{2}=\frac{1}{p}$. If the functions $f(x, y)$ and $g(x, y)\left(x, y \in \mathbb{R}^{2}\right)$ satisfy $f, g \in L_{x}^{r_{1}} L_{y}^{p} \cap L_{x}^{r_{2}} \mathcal{W}_{y}^{\sigma, 2}$, then $f g \in L_{x}^{r} \mathcal{W}_{y}^{\alpha, 2}$. Moreover,

$$
|f g|_{L_{x}^{r} \mathcal{W}_{y}^{\alpha, 2}} \lesssim|f|_{L_{x}^{r_{1}} L_{y}^{p}}|g|_{L_{x}^{r_{2}} \mathcal{W}_{y}^{\sigma, 2}}+|f|_{L_{x}^{r_{2}} \mathcal{W}_{y}^{\sigma, 2}}|g|_{L_{x}^{r_{1}} L_{y}^{p}}
$$

Proof. Set $\varepsilon:=\frac{\sigma-\alpha}{2}$, and choose $q_{1}=p=\overline{q_{2}}, \overline{q_{1}}=q_{2}=\frac{2}{1-2 \varepsilon}$ in Proposition 3 (2). Then, we obtain

$$
\begin{equation*}
|f g(x, \cdot)|_{\mathcal{W}_{y}^{\alpha, 2}} \lesssim|f(x, \cdot)|_{L_{y}^{p}}|g(x, \cdot)|_{\mathcal{W}^{\alpha, \frac{1}{1}-2 \varepsilon}}+|f(x, \cdot)|_{\mathcal{W}^{\alpha, 1-1-2 \varepsilon}}|g(x, \cdot)|_{L_{y}^{p}} . \tag{3.10}
\end{equation*}
$$

By Sobolev embedding, $\mathcal{W}^{\sigma, 2}\left(\mathbb{R}^{2}\right) \subset \mathcal{W}^{\alpha, \frac{2}{1-2 \varepsilon}}\left(\mathbb{R}^{2}\right)$. Thus, the right hand side above is majorized by

$$
C\left(|f(x, \cdot)|_{L_{y}^{p}}|g(x, \cdot)|_{\mathcal{W}_{y}^{\sigma, 2}}+|f(x, \cdot)|_{\mathcal{W}_{y}^{\sigma, 2}}|g(x, \cdot)|_{L_{y}^{p}}\right)
$$

Now we take the $L_{x}^{r}$ norm of both sides of the inequality, and use Hölder inequality with $\frac{1}{r}=$ $\frac{1}{r_{1}}+\frac{1}{r_{2}}$, to get the result.

Corollary 3.5. Let $n \in \mathbb{N}, r, r_{1}, r_{2} \geq 1, p \geq 2$, and $0<\tilde{\alpha}<\sigma$ with $\frac{1}{r}=\frac{n}{r_{1}}+\frac{1}{r_{2}}$ and $\frac{\sigma-\tilde{\alpha}}{2}=\frac{n}{p}$. If the function $f(x, y)\left(x, y \in \mathbb{R}^{2}\right)$ satisfies $f \in L_{x}^{r_{1}} L_{y}^{p} \cap L_{x}^{r_{2}} \mathcal{W}_{y}^{\sigma, 2}$, then $f^{n+1} \in L_{x}^{r} \mathcal{W}_{y}^{\tilde{\alpha}, 2}$. Moreover,

$$
\left|f^{n+1}\right|_{L_{x}^{r} \mathcal{W}_{y}^{\bar{\alpha}, 2}} \lesssim|f|_{L_{x}^{r_{1}} L_{y}^{p}}^{n}|f|_{L_{x}^{r_{2}} \mathcal{W}_{y}^{\sigma, 2}}
$$

Proof. We prove the result by induction on $n$. The case $n=1$ is straightforward from the inequality (3.10) setting $f=g$, combining with Hölder inequality. We now assume that the inequality

\left|f^{k+1}\right|_{\mathcal{W}_{y}^{\sigma, 2}} \lesssim|f|_{L_{y}^{p}}^{k}|f|_{\mathcal{W}_{y}^{\sigma, 2}}
$$

holds for any $\sigma, \tilde{\sigma}$ satisfying $\frac{\tilde{\sigma}-\sigma}{2}=\frac{k}{p}$. Applying again Proposition 3 (2) with $\alpha=\tilde{\alpha}, p=2$, $q_{1}=p$ and $(k+1) \overline{q_{2}}=p$, we have

\left|f^{k+1} f\right|_{\mathcal{W}_{y}^{\tilde{\alpha}, 2}} \lesssim|f|_{L_{y}^{p}}\left|f^{k+1}\right|_{\mathcal{W}_{y}^{\tilde{\alpha}, q_{1}}}+|f|_{\mathcal{W}_{y}^{\tilde{\alpha}, q_{2}}}|f|_{L_{y}^{p}}^{k+1} . \tag{3.11}
\end{equation*}
$$

Note that this choice of parameters implies $\frac{1}{\bar{q}_{1}}=\frac{1}{2}-\frac{1}{p}$ and $\frac{1}{q_{2}}=\frac{1}{2}-\frac{k+1}{p}$. Now choose $\sigma$ such that $\sigma=1+\tilde{\alpha}-\frac{2}{q_{1}}=\tilde{\alpha}+\frac{2}{p}$, and $\frac{\tilde{\sigma}-\sigma}{2}=\frac{k}{p}$. By Sobolev embedding $\mathcal{W}^{\sigma, 2} \subset \mathcal{W}^{\tilde{\alpha}, \overline{q_{1}}}$, and by the induction assumption,

\left|f^{k+1}\right|_{\mathcal{W}_{y}^{\tilde{\alpha}, q_{1}}} \lesssim\left|f^{k+1}\right|_{\mathcal{W}_{y}^{\sigma, 2}} \lesssim|f|_{L_{y}^{p}}^{k}|f|_{\mathcal{W}_{y}^{\tilde{\sigma}, 2}} .

Next, the relation $\frac{\tilde{\sigma}-\tilde{\alpha}}{2}=\frac{k+1}{p}$ implies $\tilde{\sigma}-1=\tilde{\alpha}-\frac{2}{q_{2}}$, thus by Sobolev embedding, $|f|_{\mathcal{W}_{y}^{\tilde{\alpha}, q_{2}}} \lesssim$ $|f|_{\mathcal{W}_{y}^{\tilde{\sigma}, 2}}$. In summary, we estimate the right hand side of (3.11) by $C|f|_{L_{y}^{p}}^{k+1}|f|_{\mathcal{W}_{y}^{\tilde{\sigma}, 2}}$ with $\frac{\tilde{\sigma}-\tilde{\alpha}}{2}=\frac{k+1}{p}$, this proves the $n=k+1$ case. Finally, as in Lemma 3.4, we use Hölder inequality to conclude the statement.

Proof of Proposition 5. First of all, we consider the $L^{2}$ norm in $x_{2}$ of the kernel $K\left(x_{1}, x_{2}\right)$, $x_{1}, x_{2} \in \mathbb{R}^{2}$, on which we apply the cut-off $S_{N}$; denoting $\chi_{k, N}=\chi\left[\frac{\lambda_{k}^{2}}{\lambda_{N}^{2}}\right]$, we may write

\left[\int_{\mathbb{R}^{2}}\left|S_{N} K\left(x_{1}, x_{2}\right)\right|^{2} d x_{2}\right]^{\frac{1}{2}}=\left[\sum_{k \in \mathbb{N}^{2}} \chi_{k, N}^{2} \frac{\left|h_{k}\left(x_{1}\right)\right|^{2}}{\lambda_{k}^{4}}\right]^{\frac{1}{2}} .
$$

Next we take, for $q>2$, the $L^{q}$ norm in $x_{1}$,

$$
\left|S_{N} K\right|_{L_{x_{1}}^{q} L_{x_{2}}^{2}}^{2}=\left[\int_{\mathbb{R}^{2}}\left[\sum_{k \in \mathbb{N}^{2}} \chi_{k, N}^{2} \frac{\left|h_{k}\left(x_{1}\right)\right|^{2}}{\lambda_{k}^{4}}\right]^{\frac{q}{2}} d x_{1}\right]^{\frac{2}{q}} \leq \sum_{k \in \mathbb{N}^{2}} \chi_{k, N}^{2} \frac{\left|h_{k}\right|_{L^{q}}^{2}}{\lambda_{k}^{4}},
$$

where we have used Minkowski inequality. It follows from (3.6) that $\left|h_{k}\right|_{L^{q}\left(\mathbb{R}^{2}\right)} \leq \lambda_{k}^{-\theta(q)}$ for some $\theta(q)>0$ if $q>2$, thus

$$
\sum_{k \in \mathbb{N}^{2}} \chi_{k, N}^{2} \frac{\left|h_{k}\right|_{L^{q}}^{2}}{\lambda_{k}^{4}} \leq \sum_{k \in \mathbb{N}^{2},|k| \leq N} \frac{1}{\lambda_{k}^{4+2 \theta(q)}},
$$

which converges as $N \rightarrow \infty$. Namely $K \in L_{x_{1}}^{q} L_{x_{2}}^{2}$ for any $q \in(2,+\infty]$. On the other hand, for $2 \leq q<+\infty$, by Sobolev embedding $\mathcal{W}^{1-\frac{2}{q}, 2}\left(\mathbb{R}^{2}\right) \subset L^{q}\left(\mathbb{R}^{2}\right)$, and by duality $L^{q *}\left(\mathbb{R}^{2}\right) \subset$ $\mathcal{W}^{1-\frac{2}{q^{*}}, 2}\left(\mathbb{R}^{2}\right)$, where $\frac{1}{q}+\frac{1}{q^{*}}=1$. We also know that the operator $(-H)^{-1}=\left(-\Delta+|x|^{2}\right)^{-1}$ maps $\mathcal{W}^{1-\frac{2}{q^{*}}, 2}\left(\mathbb{R}^{2}\right)$ into $\mathcal{W}^{3-\frac{2}{q^{*}, 2}}\left(\mathbb{R}^{2}\right) \subset L^{\infty}\left(\mathbb{R}^{2}\right)$. Therefore, we have

$$
\sup _{x_{1} \in \mathbb{R}^{2}}\left|\int_{\mathbb{R}^{2}} K\left(x_{1}, x_{2}\right) f\left(x_{2}\right) d x_{2}\right|=\left|(-H)^{-1} f\right|_{L^{\infty}} \lesssim\left|(-H)^{-1} f\right|_{\mathcal{W}^{3-\frac{2}{q^{*}, 2}}} \lesssim|f|_{\mathcal{W}^{1-\frac{2}{q^{*}, 2}}} \lesssim|f|_{L^{q^{*}}} .
$$

This means that there exists $C>0$ which is independent of $x_{1}$ such that $\left|K\left(x_{1}, \cdot\right)\right|_{L^{q}} \leq C$ for any $x_{1} \in \mathbb{R}^{2}$, i.e. $K \in L_{x_{1}}^{\infty} L_{x_{2}}^{q}$. Thus, by interpolation between $L_{x_{1}}^{q} L_{x_{2}}^{2}$, for $q \in(2,+\infty]$, and $L_{x_{1}}^{\infty} L_{x_{2}}^{q}$, for $q \in[2,+\infty)$, we have

\begin{equation*}
K \in L_{x_{1}}^{\alpha} L_{x_{2}}^{\beta}, \quad \text { for any } \alpha>\beta \geq 2 \tag{3.12}
\end{equation*}
$$

The same idea as above can be used to prove that

$$
\begin{equation*}
K \in L_{x_{1}}^{\infty} \mathcal{W}_{x_{2}}^{\sigma, 2}, \quad \text { for any } \sigma<1 \tag{3.13}
\end{equation*}
$$

Indeed, for any $0<\varepsilon<1$,

$$
\sup _{x_{1} \in \mathbb{R}^{2}}\left|\int_{\mathbb{R}^{2}} K\left(x_{1}, x_{2}\right) f\left(x_{2}\right) d x_{2}\right|=\left|(-H)^{-1} f\right|_{L^{\infty}} \leq C|f|_{\mathcal{W}^{-1+\varepsilon, 2}} .
$$

By interpolation between (3.12) and (3.13), we have for all $\sigma<1-\frac{2}{q}$, and $q \geq 2$,

$$
K \in L_{x_{1}}^{q} \mathcal{W}_{x_{2}}^{\sigma, 2}
$$

Now, the use of (3.12) and Corollary 3.5 allows to obtain the statement of Proposition 5.
We note that, as a simple consequence of Proposition 5, we obtain the following regularity results for $Z_{\infty}^{\gamma_{1}, \gamma_{2}}$.

Lemma 3.6. Fix any $T>0$. Let $\gamma_{1}>0, \gamma_{2} \in \mathbb{R}, s>0, q \geq 2, s q>2$ and $0<\alpha<\frac{1}{2}\left(s-\frac{2}{q}\right)$. The stationary solution $Z_{\infty}^{\gamma_{1}, \gamma_{2}}$ of (2.5) has a modification in $C^{\alpha}\left([0, T], \mathcal{W}^{-s, q}\right)$. Moreover, there exists a positive constant $C_{T}$ such that

\mathbb{E}\left[\sup _{t \in[0, T]}\left|Z_{\infty}^{\gamma_{1}, \gamma_{2}}(t)\right|_{\mathcal{W}^{-s, q}}\right] \leq C_{T} .
$$

Proof. Since the computation is almost the same as in Lemma 2.1 in [3], we note only the points in the arguments. In order to apply the Kolmogorov test, consider, for $t, \tau$ with $\tau<t \leq T$,

Z_{\infty}^{\gamma_{1}, \gamma_{2}}(t, x)-Z_{\infty}^{\gamma_{1}, \gamma_{2}}(\tau, x)= & \sqrt{2 \gamma_{1}} \sum_{k \in \mathbb{N}^{2}}\left[\int_{\tau}^{t} e^{-\lambda_{k}^{2}\left(\gamma_{1}+i \gamma_{2}\right)(t-\sigma)} d \beta_{k}(\sigma) h_{k}(x)\right. \\
& \left.+\int_{-\infty}^{\tau}\left(e^{-\lambda_{k}^{2}\left(\gamma_{1}+i \gamma_{2}\right)(t-\sigma)}-e^{-\lambda_{k}^{2}\left(\gamma_{1}+i \gamma_{2}\right)(\tau-\sigma)}\right) d \beta_{k}(\sigma) h_{k}(x)\right] .
\end{aligned}
$$

with $\beta_{k}=\beta_{k, R}+i \beta_{k, I}$. Denote by $f_{1, t, \tau}$ the first term in the right hand side above, and by $f_{2, t, \tau}$ the second term. For any $\alpha \in[0,1]$, and $m \in \mathbb{N} \backslash\{0\}$, since $f_{1, t, \tau}$ is Gaussian, we have the moment estimate:

\mathbb{E}\left[\left|(-H)^{-\frac{s}{2}} f_{1, t, \tau}(\cdot, x)\right|^{2 m}\right]^{\frac{1}{2 m}} \lesssim(t-\tau)^{\frac{\alpha}{2}}\left[\sum_{k \in \mathbb{N}^{2}} \lambda_{k}^{-2 s+2(\alpha-1)}\left|h_{k}(x)\right|^{2}\right]^{\frac{1}{2}} .

We take the $L_{x}^{q}$ norm and write the right hand side using the kernel $K\left(x_{1}, x_{2}\right)$ (see (3.9)):

\left|\mathbb{E}\left[\left|(-H)^{-\frac{s}{2}} f_{1, t, \tau}\right|^{2 m}\right]^{\frac{1}{2 m}}\right|_{L_{x}^{q}} \leq(t-\tau)^{\frac{\alpha}{2}}|K|_{L_{x_{1}}^{q} \mathcal{W}_{x_{2}}^{2-s+(\alpha-1), 2}}
$$

By Proposition 5, the above norm is finite if $q \geq 2$ and $1-s+\alpha<1-2 / q$. Finally, using Minkowskii inequality for $2 m \geq q$, we obtain

for $2 m \geq q \geq 2,0<\alpha<s-2 / q$. The second term can be estimated in a similar way and we obtain the same estimate for $f_{2, t, \tau}$. Applying the Kolmogorov test then gives the result.

We now use Proposition 5 to prove the convergence of the Wick products.
Proof of Proposition 4. In order to lighten the notations, we write in all what follows $Z_{1, N}$ for $S_{N} Z_{R, \infty}$ and $Z_{2, N}$ for $S_{N} Z_{I, \infty}$. We show below that the sequence $\left\{: Z_{1, N}^{k}:: Z_{2, N}^{l}:\right\}_{N \in \mathbb{N}}$ is Cauchy in $L^{q}\left(\Omega, \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)\right)$ for any $k, l \in \mathbb{N}$, and any $q \geq 4, s>0$ with $q s>8$. Let $M, N \in \mathbb{N}$ with $M<N$. Then

\begin{aligned}
\mathbb{E}\left(\left|: Z_{1, N}^{k}:: Z_{2, N}^{l}:-: Z_{1, M}^{k}:: Z_{2, M}^{l}:\right|_{\mathcal{W}^{-s, q}}^{q}\right) \leq & C \mathbb{E}\left(\left|\left(: Z_{1, N}^{k}:-: Z_{1, M}^{k}:\right): Z_{2, M}^{l}:\right|_{\mathcal{W}^{-s, q}}^{q}\right) \\
& +C \mathbb{E}\left(\left|: Z_{1, N}^{k}:\left(: Z_{2, N}^{l}:-: Z_{2, M}^{l}:\right)\right|_{\mathcal{W}^{-s, q}}^{q}\right) \\
= & (\mathrm{I})+(\mathrm{II})
\end{aligned}
$$

We only show the estimates for (I) since (II) can be treated similarly. Using Fubini Theorem we may write

(\mathrm{I}) & =\int_{\Omega} \left\lvert\,(-H)^{-\frac{s}{2}}\left(\left(: Z_{1, N}^{k}:-: Z_{1, M}^{k}:\right): Z_{2, M}^{l}:\left.\right|_{L^{q}} ^{q} d \mathbb{P}\right.\right. \\
& =\int_{\mathbb{R}^{2}} \int_{\Omega}\left|\sum_{m \in \mathbb{N}^{2}}\left(\left(: Z_{1, N}^{k}:-: Z_{1, M}^{k}:\right): Z_{2, M}^{l}:, h_{m}\right)_{L^{2}} \lambda_{m}^{-s} h_{m}(x)\right|^{q} d \mathbb{P} d x . \tag{3.14}
\end{align*}
$$

We set for $x \in \mathbb{R}^{2}$,

A(x):=\int_{\Omega}\left|\sum_{m \in \mathbb{N}^{2}}\left(\left(: Z_{1, N}^{k}:-: Z_{1, M}^{k}:\right): Z_{2, M}^{l}:, h_{m}\right)_{L^{2}} \lambda_{m}^{-s} h_{m}(x)\right|^{2} d \mathbb{P}
$$

and for any fixed $N, M \in \mathbb{N}$,

$$
\begin{equation*}
K_{N, M}\left(x_{1}, x_{2}\right):=\sum_{k \in \mathbb{N}^{2}} \chi\left(\frac{\lambda_{k}^{2}}{\lambda_{N}^{2}}\right) \chi\left(\frac{\lambda_{k}^{2}}{\lambda_{M}^{2}}\right) \frac{h_{k}\left(x_{1}\right) h_{k}\left(x_{2}\right)}{\lambda_{k}^{2}}, \quad x_{1}, x_{2} \in \mathbb{R}^{2}, \tag{3.15}
\end{equation*}
$$

and $K_{N}\left(x_{1}, x_{2}\right):=K_{N, N}\left(x_{1}, x_{2}\right)$. Then, by the Nelson estimate (3.2), and since

\sum_{m \in \mathbb{N}^{2}}\left(\left(: Z_{1, N}^{k}:-: Z_{1, M}^{k}:\right): Z_{2, M}^{l}:, h_{m}\right)_{L^{2}} \lambda_{m}^{-s} h_{m}(x) \in \mathcal{H}_{k+l},
$$

the right hand side of (3.14) is bounded above by $C_{q, k+l}|A|_{L^{\frac{q}{2}}\left(\mathbb{R}^{2}\right)}^{\frac{q}{2}}$. Let us first check that $A(x)$ can be written as

A(x)=k!l!\left(-H_{x_{1}}\right)^{-s / 2}\left(-H_{x_{2}}\right)^{-s / 2}\left[\left(K_{N}^{k}-2 K_{N, M}^{k}+K_{M}^{k}\right) K_{M}^{l}\right](x, x), \quad x \in \mathbb{R}^{2} . \tag{3.16}
\end{equation*}

Indeed,

A(x)= & \left.\int_{\Omega} \sum_{m_{1} \in \mathbb{N}^{2}} \sum_{m_{2} \in \mathbb{N}^{2}}\left(\left(: Z_{1, N}^{k}:-: Z_{1, M}^{k}:\right)\right): Z_{2, M}^{l}:, h_{m_{1}}\right)_{L^{2}} \lambda_{m_{1}}^{-s} h_{m_{1}}(x) \\

& \quad \times\left(: Z_{1, N}^{k}:-: Z_{1, M}^{k}:\right)\left(x_{2}\right): Z_{2, M}^{l}:\left(x_{2}\right) h_{m_{2}}\left(x_{2}\right) \lambda_{m_{2}}^{-s} h_{m_{2}}(x) d x_{1} d x_{2} d \mathbb{P} .

The fact that $Z_{1, M}$ and $Z_{2, M}$ are independent allows us to compute the integrals on $\Omega$ separately. Recalling the definition,

& \leq\left|\left(K_{N}^{k}-2 K_{N, M}^{k}+K_{M}^{k}\right) K_{M}^{l}\right|_{L_{\eta}^{\frac{q}{2}}}^{\frac{q}{2}} \mathcal{W}_{\xi}^{1-\frac{s}{2}, 2} \\

\leq & {\left[\int_{\mathbb{R}^{2}}\left[\sum_{|j|=\frac{M}{2}}^{N} \lambda_{j}^{-2+2\left(1-\frac{s}{4}\right)} h_{j}^{2}(x)\right]^{\frac{q}{2}} d x\right]^{\frac{1}{2}}\left[\sum_{j=0}^{k-1}\left|K^{j}\right|_{L_{\eta}^{2 q} \mathcal{W}_{\xi}^{1-\frac{s}{8}, 2}}\left|K^{k-1-j}\right|_{L_{\eta}^{4 q} \mathcal{W}_{\xi}^{1-\frac{s}{16}, 2}}\left|K^{l}\right|_{L_{\eta}^{4 q} \mathcal{W}_{\xi}^{1-\frac{s}{16}, 2}}\right]^{\frac{q}{2}} . }

This shows that the sequence $\left\{: Z_{1, N}^{k}:: Z_{2, N}^{l}:\right\}_{N \in \mathbb{N}}$ is a Cauchy sequence in $L^{q}\left(\Omega, \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)\right)$ for any $k, l \in \mathbb{N}$. The bound (3.7) is obtained by estimating $\mathbb{E}\left[\left|:\left(S_{N} Z_{R, \infty}\right)^{k}::\left(S_{N} Z_{I, \infty}\right)^{l}:\right|_{\mathcal{W}^{-s, q}}^{q}\right]$ uniformly in $N$, using the same arguments as above.
3.2. Properties of the semigroup. The purpose of this section is to give some lemmas listing useful properties of the semigroup $\left(e^{t\left(\gamma_{1}+i \gamma_{2}\right) H}\right)_{t \geq 0}$, that will later be used in the course of the proofs of the theorems.

Lemma 3.7. Let $\gamma_{1}>0$ and $\gamma_{2} \in \mathbb{R}$. There exists a constant $C_{0}=C_{0}\left(\gamma_{1}, \gamma_{2}\right)>0$ such that for $t>0$ satisfying $\gamma_{1} t,\left|\gamma_{2} t\right| \ll 1$,

Proof. The proof of Proposition 3.1 of [3] can be applied with minor modifications.

The proof of the next lemmas will be given in Appendix 1.
Lemma 3.8. Let $\gamma_{1}>0, \gamma_{2} \in \mathbb{R}, 1<p<\infty$ and $s \in(0,2]$. Then there exists a constant $C_{1}=C_{1}\left(\gamma_{1}, \gamma_{2}\right)>0$ such that,

Remark 3.1. In the purely dissipative case, i.e. the case $\gamma_{2}=0$, the above estimate holds for all $s>0$.

Lemma 3.9. Let $\gamma_{1}>0, \gamma_{2} \in \mathbb{R}, p>2$ and $\beta>\frac{1}{2}-\frac{1}{p}$. For $t>0$ satisfying $\gamma_{1} t,\left|\gamma_{2} t\right| \ll 1$,

The following lemma is a consequence of Lemmas 3.7 and 3.9, and an interpolation argument.
Lemma 3.10. Let $\gamma_{1}>0, \gamma_{2} \in \mathbb{R}, q>p>2$ and $\sigma>\frac{1}{p}-\frac{1}{q}$. Then there exists a constant $C_{2}=C_{2}\left(\gamma_{1}, \gamma_{2}\right)>0$ such that for $t>0$ satisfying $\gamma_{1} t,\left|\gamma_{2} t\right| \ll 1$,

We still need some preliminaries before proving Theorem 1 . Let $T>0$ be fixed so that the above semigroup estimates are valid in the time interval $[0, T]$. Let $s, \beta>0$ and $r, p, q \geq 1$. We consider the function space

Then, there exists a constant $C_{3}=C_{3}\left(\gamma_{1}, \gamma_{2}, T\right)$ such that for any $f \in \mathcal{W}^{-s, q}$,

Proof. First, by Lemma 3.7, for any $t \in[0, T]$,

Using Lemmas 3.10 and 3.8 , we have

\end{aligned}

which ends the proof.
Lemma 3.12. Let $\gamma_{1}, s>0, \gamma_{2} \in \mathbb{R}, l \in \mathbb{N}, q>p>2,0<\beta<2 / p, \sigma>\frac{1}{p}-\frac{1}{q}$, and $r \geq l+1$ be such that $\varepsilon:=-\sigma-\frac{\beta+s}{2}+\frac{1}{r}>0$ and $\delta:=\frac{l}{2}\left(\beta-\frac{2}{p}\right)-\frac{l+1}{r}+1>0$. Let $f \in L^{\frac{r}{l+1}}\left(0, T ; \mathcal{W}^{-\alpha, q}\right)$, where $\alpha=s+l\left(\frac{2}{p}-\beta\right)$. Then,

$$

and

\left|\int_{0}^{\cdot} e^{(\cdot-\tau)\left(\gamma_{1}+i \gamma_{2}\right) H} f(\tau) d \tau\right|_{L^{r}\left(0, T ; \mathcal{W}^{\beta, p}\right)} \leq \tilde{C}_{l} T^{\varepsilon+\delta}|f|_{L^{\frac{r}{l+1}}\left(0, T ; \mathcal{W}^{-\alpha, q}\right)} .

Proof. By Lemma 3.8, if $t \in[0, T]$,

where we have used the Hölder inequality with $\frac{1}{r^{\prime}}+\frac{l+1}{r}=1$ in the second inequality. The continuity in time with values in $\mathcal{W}^{-s, q}$ follows from the strong continuity of the semi-group and the above estimate. Also, applying Lemma 3.8 and Lemma 3.10,

\end{aligned}

Haussdorf-Young inequality with $1+\frac{1}{r}=\frac{1}{\tilde{\gamma}}+\frac{l+1}{r}$ implies

where we note that $-\frac{\alpha+\beta}{2}-\sigma+\frac{1}{\tilde{\gamma}}=\varepsilon+\delta>0$.
3.3. Local existence. In order to handle the nonlinear term, we will need the following estimate on $\mathcal{W}^{s, p}$ norms of products of functions.

Lemma 3.13. Let $q>p>2,0<s<\beta<2 / p$, and $m \in \mathbb{N}^{*}$. Suppose $\beta-s-(m-1)\left(\frac{2}{p}-\beta\right)>0$, and $s+m\left(\frac{2}{p}-\beta\right)<2\left(1-\frac{1}{q}\right)$. Then, there is a constant $C>0$ such that

The proof of Lemma 3.13 will be found in Appendix 2.
Remark 3.2. The conditions on the parameters are typically satisfied for $q$ very large, $s$ small and $\beta$ close to $\frac{2}{p}$. By Hölder inequality, we infer from Lemma 3.13 that

We will use this estimate to control the nonlinearity, the cubic nonlinear power corresponds to the case $m \leq 2$ in Lemma 3.13.

Remark 3.3. Let us show that we can find parameters satisfying the conditions in Lemmas 3.11 to 3.13 when we consider more general polynomial nonlinearities with an even integer $m \in \mathbb{N}^{*}$ :

$$

Let $p>3 r$, with $r>2(m+1)$. Then, $\frac{2}{p}-\frac{1}{m}<0<\frac{2}{p}<\frac{1}{r}-\frac{1}{p}$. Since $\frac{2}{p}-\frac{1}{m}<\frac{2}{r}-\frac{1}{m}<\frac{1}{m+1}-\frac{1}{m}<0$, we can then take $s$ and $\beta$ such that $\frac{2}{p}-\frac{1}{m}<0<s<\beta<\frac{2}{p}<\frac{1}{r}-\frac{1}{p}$. Thus, $\frac{2}{p}-\beta<\frac{1}{m}$, so that

Next, take $\sigma=\frac{1}{p}$. Then we have $\varepsilon=\frac{1}{r}-\frac{1}{p}-\frac{\beta+s}{2}>\frac{1}{r}-\frac{1}{p}-\beta>0$. In addition, $\beta$ and $s$ should satisfy the conditions in Lemma 3.13, and $q$ should satisfy $q$ s $>8$, but this is possible if we take $s$ very small, $\beta$ close to $\frac{2}{p}$ and $q>p$ very large. Note that the assumptions in Theorem 1 allow us to use Lemmas 3.7 to 3.13 when $m=2$.

We now have all the estimates in hand to solve equation (2.6) in the mild form: for any fixed $T>0$, we consider for $t \in[0, T]$ :

By the definition of the Wick product, we may write, using again the notation $Z_{R, \infty}=\operatorname{Re}\left(Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)$, $Z_{I, \infty}=\operatorname{Im}\left(Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right), u_{R}=\operatorname{Re} u$, and $u_{I}=\operatorname{Im} u$,

Proof of Theorem 1. We fix all the parameters appearing in lemmas 3.9 and 3.10, as in Remark 3.3 (with $m=2$ ). Let us fix any $T>0$, and take $T_{0} \leq T \wedge 1$ small enough so that the estimates in Lemma 3.11 and Lemma 3.12 hold. We consider the closed ball in $\mathcal{E}_{T_{0}}$ with radius $R>0$ :

Here, the constants $C_{0}$ and $\tilde{C}_{0}$ are the constants appearing in Lemmas 3.7 and 3.12. Note that $R$ is random, but a.s. finite, as follows from Proposition 4 and Hölder's inequality. Consider the mapping, for $t \leq T_{0}$, and $u \in B_{R}\left(T_{0}\right)$,

We next apply Lemma 3.12 with $l=0$, then with $\delta_{0}:=-\frac{s+\beta}{2}+1-\frac{1}{r}>0$, we have,

\end{aligned}
$$

with $\delta_{1}:=1-\frac{2}{r}-\frac{1}{2}\left(\frac{2}{p}-\beta\right)>0$; the use of formula (3.24) and Lemma 3.13 with $m=1$ allows then to bound the above term by

\leq & 3 C\left(\gamma_{1}+\left|\gamma_{2}\right|\right)\left(C_{1}+\tilde{C}_{1}\right) T_{0}^{\delta_{1}} R \sum_{l=0}^{2}\left|: Z_{R, \infty}^{l} Z_{I, \infty}^{2-l}:\right|_{L^{r}\left(0, T_{0} ; \mathcal{W}^{-s, q}\right)} .
\end{aligned}
$$

In the same way, the term involving $F_{1}$ is estimated thanks to Lemma 3.12 and Lemma 3.13, respectively with $l=2$ and $m=2$; we obtain

\leq & \left(\gamma_{1}+\left|\gamma_{2}\right|\right)\left(C_{1}+\tilde{C}_{2}\right) T_{0}^{\delta_{2}}\left|F_{1}(\tau)\right|_{L^{\frac{r}{3}}\left(0, T_{0} ; \mathcal{W}^{-\left(s+2\left(\frac{2}{p}-\beta\right)\right), q}\right)} \\
\leq & 3 C\left(\gamma_{1}+\left|\gamma_{2}\right|\right)\left(C_{1}+\tilde{C}_{2}\right) T_{0}^{\delta_{2}}\left(\left|Z_{R, \infty}\right|_{L^{r}\left(0, T_{0} ; \mathcal{W}^{-s, q}\right)}+\left|Z_{I, \infty}\right|_{L^{r}\left(0, T_{0} ; \mathcal{W}^{-s, q}\right)}\right)|u|_{L^{r}\left(0, T_{0} ; \mathcal{W}^{\beta, p}\right)}^{2} \\
\leq & 3 C\left(\gamma_{1}+\left|\gamma_{2}\right|\right)\left(C_{1}+\tilde{C}_{2}\right) R^{2} T_{0}^{\delta_{2}}\left|Z_{\infty}\right|_{L^{r}\left(0, T ; \mathcal{W}^{-s, q}\right)},
\end{aligned}
$$

with $\delta_{2}:=1-\frac{3}{r}-\left(\frac{2}{p}-\beta\right)>0$. Finally, using again Lemma 3.12 and Lemma 3.13 with $l=m=2$ leads to

\leq & \left(\gamma_{1}+\left|\gamma_{2}\right|\right) C\left(C_{1}+\tilde{C}_{2}\right) T_{0}^{\delta_{2}} R^{3} .
\end{aligned}
$$

Gathering all the above estimates, and since $T_{0} \leq 1$, we have for some constants $C>0$,

By classical PDE arguments, the continuity of the solution $u$ with respect to the initial data $u_{0}$, and the following alternative also hold: Let $T_{0}^{*}$ be the maximal time $T_{0}^{*}(\omega):=\sup \left\{T_{0} \geq\right.$ $0, \exists$ unique solution $\left.u \in \mathcal{E}_{T_{0}}\right\}$. Then, almost surely, $T_{0}^{*}=+\infty$ or $T_{0}^{*}<+\infty$ and

## 4. Long time behaviour in the large dissipation case

When the dissipation parameter $\gamma_{1}$ is sufficiently large compared to $\gamma_{2}$, an energy bound allows us to globalize the solution. This is the object of the first part of the section. In a second part, we use another energy bound to prove the existence of an invariant measure, still in the large dissipation case.
4.1. Global existence. Before proving the global existence result, we start with the proof of Proposition 1, which gives another version of local existence result for initial data in $L^{q}\left(\mathbb{R}^{2}\right)$, under slightly more restrictive conditions on the parameters.

Proof of Proposition 1. Let $u_{0} \in L^{q}\left(\mathbb{R}^{2}\right)$, and $u \in C\left(\left[0, T_{0}^{*}\right) ; \mathcal{W}^{-s, q}\right) \cap L^{r}\left(0, T_{0}^{*-} ; \mathcal{W}^{\beta, p}\right)$ be the solution of (3.23) given by Theorem 1. First, it is clear from Lemma 3.11 that $t \mapsto e^{t\left(\gamma_{1}+i \gamma_{2}\right) H} u_{0}$ is in $C\left(\left[0, T_{0}^{*}\right) ; L^{q}\left(\mathbb{R}^{2}\right)\right)$. On the other hand, applying Lemma 3.12 with $s=\frac{2}{p}-\beta$, an integer $l$ such that $1 \leq l \leq 3$, and $\alpha=(l+1)\left(\frac{2}{p}-\beta\right)$, and noticing moreover that the condition $\frac{l}{2}\left(\beta-\frac{2}{p}\right)-$ $\frac{l+1}{r}+1>0$ is satisfied for $r>6$ since $\frac{2}{p}-\beta<\frac{2}{9}$, we obtain, for all $f \in L^{\frac{r}{l+1}}\left(0, T ; \mathcal{W}^{-l\left(\frac{2}{p}-\beta\right), q}\right)$, with $T<T_{0}^{*}$ and all $t \in[0, T]$,

& \leq C_{1} T^{\delta}\left|(-H)^{\frac{s}{2}} f\right|_{L^{\frac{r}{l+1}}\left(0, T ; \mathcal{W}^{-\alpha, q}\right)}  \tag{4.1}\\
& \leq C_{1} T^{\delta}|f|_{L^{\frac{r}{l+1}}\left(0, T ; \mathcal{W}^{-l\left(\frac{2}{p}-\beta\right), q}\right)^{\prime}}
\end{align*}
$$

It remains to estimate the right hand side above taking $f=:\left|u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right|^{2}\left(u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right):=$ $F_{0}+F_{1}+F_{2}+F_{3}$ as in (3.24). Applying Lemma 3.13 with $m=2$, and $s=\frac{2}{p}-\beta$ (it is easily checked that the conditions are satisfied under the assumptions of Proposition 1), we have

In the same way, applying, for $k=1,2,3$ Lemma 3.13 with $m=3-k$ leads to

\end{aligned}

Combining the above estimate with (4.2) and (4.1), we deduce that the second term in the right hand side of equation (3.23) is in $L^{\infty}\left(0, T ; L^{q}\left(\mathbb{R}^{2}\right)\right)$ for any $T<T_{0}^{*}$. Again, the continuity in time with values in $L^{q}\left(\mathbb{R}^{2}\right)$ follows from the strong continuity of the semi-group and the above estimate, and this concludes the proof.

Proof of Proposition 2. Here, we assume that $\gamma_{1}, \gamma_{2}$ and $q$ satisfy the assumptions of Proposition 2 , that is the dissipation is sufficiently large. All the formal computations below to estimate the $L^{q}$ norm of the solution may be justified as in [17] (see also Remark 4.1 below). Let $u$ be solution of

& -\gamma_{1}\left(|u|^{2} u,|u|^{q-2} u\right)_{L^{2}}-\left(\left(\gamma_{1}+i \gamma_{2}\right)\left(F_{1}+F_{2}+F_{3}\right),|u|^{q-2} u\right)_{L^{2}} .
\end{aligned}

The first term in the right hand side can be written by integration by parts as follows.

then $\operatorname{tr} A_{\delta} \geq 0$ since $q \geq 2$. On the other hand, $\operatorname{det} A_{\delta} \geq 0$ if and only if : either $\gamma_{2}=0$, or $\gamma_{2} \neq 0$ and $q-2 \leq 2(1-\delta)\left\{\kappa^{2}+\kappa \sqrt{1+\kappa^{2}}\right\}$ with $\kappa=\gamma_{1} / \gamma_{2}$. Thus, choosing from now on $\delta$ such that the previous condition is satisfied (which is always possible under the assumptions of Theorem 2 ), we obtain

Remark 4.1. These computations may be justified as in [17]. Indeed, it is not difficult to prove, using similar estimates as for the proof of Proposition 1, that the solution $u$ is in $C^{1 / 2+}\left(0, \tau ; L^{q}\left(\mathbb{R}^{2}\right)\right)$, for any $\tau<T^{*}$, a.s., provided the initial state $u_{0}$ is sufficiently regular. Now, the local solution of Theorem 1 being obtained thanks to a fixed point argument, it is continuous with respect to the initial state, so that proving the estimate for regular initial data is actually sufficient.

Finally we show the global existence result.
Proof of Theorem 2. Here again, we assume that $\gamma_{1}, \gamma_{2}$ and $q$ satisfy the assumptions of Proposition 2, that is the dissipation is sufficiently large. Let $u$ be the solution of (3.23) given by Theorem 1, and let $0<\tilde{T}_{0}<1 \wedge T_{0}^{*} \wedge T$, then

Thus, using Lemma 3.8 and the same estimates as in the proof of Proposition 1, it is not difficult to see that $u\left(\tilde{T}_{0}\right) \in L^{q}\left(\mathbb{R}^{2}\right)$; we may then solve equation (2.10) starting from $\tilde{T}_{0}$ using Proposition

1, and the combination of Theorem 1, Proposition 1 and Proposition 2 shows that the solution is global in time, concluding the statement of Theorem 2.
4.2. Galerkin approximation and tightness of the Gibbs measure. In order to get an invariant measure for equation 2.1, we will use Galerkin approximations, and show that their family of Gibbs measure is tight in a certain function space.

Let us consider the Galerkin approximation to (2.9):

We may of course apply Theorem 1 to equation (4.23) and prove, using the same arguments as in [3], Proposition 3, that the solution $u_{N}$ is globally defined. We deduce the following result for equation (4.22) by Proposition 4:

Proposition 6. Fix any $T>0$. Let $\gamma_{1}>0$ and $q>p>3 r, r>6$. Assume $0<s<\beta<2 / p$, qs $>8,(\beta-s)>\left(\frac{2}{p}-\beta\right)$, and $s+2\left(\frac{2}{p}-\beta\right)<2\left(1-\frac{1}{q}\right)$. Then there exists a unique global solution in $C\left([0, T], E_{N}^{\mathbb{C}}\right)$, denoted by $X_{N}$, of (4.22). Moreover, if $X_{N}(0)$ converges to $X_{0}$ a.s. in $\mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)$, then $X_{N}$ converges to $X$ in $C\left([0, T] ; \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)\right)$ a.s. as $N$ goes to infinity, for any $T<T_{0}^{*}$, where $X=u+Z_{\infty}^{\gamma_{1}, \gamma_{2}}$, $u$ being the solution of equation (2.10) given by Theorem 1 and $T_{0}^{*}$ being its maximal existence time.

Define the Feller transition semigroup $P_{t}^{N} \phi(y)=\mathbb{E}\left(\phi\left(X_{N}(t, y)\right)\right)$, for $y \in E_{N}^{\mathbb{C}}$, associated with equation (4.22). The finite-dimensional measure $\tilde{\rho}_{N}$ is an invariant measure for $\left(P_{t}^{N}\right)_{t \geq 0}$, according to the same argument as in Proposition 4 of [3]. We now wish to prove the tightness of the family of measures $\left(\tilde{\rho}_{N}\right)_{N}$. Note that we cannot directly use the $L^{q}$-bound provided by Proposition 2 due to the presence of the cut-off $S_{N}$ in front of the nonlinear term in (4.23).

Alternatively, considering the coupled evolution on $E_{N}^{\mathbb{C}}$ given by

one may easily prove, using e.g. similar estimates as in the proof of Proposition 7 below, together with the Gaussianity of $Z$, and a Krylov-Bogolyubov argument, that (4.24) has an invariant measure $\nu_{N}$ on $E_{N}^{\mathbb{C}} \times \mathbb{E}_{N}^{\mathbb{C}}$. Moreover, by uniqueness of the invariant measure of (4.22), we necessarily have for any bounded continuous function $\varphi$ on $\mathbb{E}_{N}^{\mathbb{C}}$ :

We first estimate the term containing $F_{3}$ in the right hand side above. Thanks to Proposition 4, taking $0<s<1$ and $q>8$ such that $s q>8$, we may bound

\end{align*}

Next, we consider the term containing $F_{2}$ in the right hand side of (4.26). First, by (3.24) and Proposition 3,

& \lesssim \sum_{l=0}^{2}\left|: S_{N} Z_{N, R}^{l} Z_{N, I}^{2-l}:\left|\mathcal{W}^{-s, q}\right| S_{N} u_{N}\right|_{L^{4}}\left|S_{N} u_{N}\right|_{\mathcal{W}^{s, p}}
\end{aligned}
$$

with $\frac{1}{q^{\prime}}=\frac{1}{4}+\frac{1}{p}$. Note that $p \in(1,2)$ and we may use the same procedure as before to obtain

& +\frac{\gamma_{1}}{4\left(\gamma_{1}+\left|\gamma_{2}\right|\right)}\left|(-H)^{\frac{1}{2}} S_{N} u_{N}\right|_{L^{2}}^{2} .
\end{align*}

We finally turn to the term containing $F_{1}$ in the right hand side of (4.26). We easily get, thanks again to Proposition 3,

If $2<m \leq 4$, we interpolate $L^{m}$ between $L^{2}$ and $L^{4}$, then use $\mathcal{W}^{1,2} \subset L^{2}$. In both cases we obtain, using in addition the Poincaré inequality for $(-H)$ :

\leq & \left.C\left|S_{N} Z_{N}\right|\right|_{\mathcal{W}^{-s, q}} ^{-\frac{1}{1-\alpha}}+\frac{\gamma_{1}}{2\left(\gamma_{1}+\left|\gamma_{2}\right|\right)}\left[\left|S_{N} u_{N}\right|_{L^{4}}^{4}+\frac{1}{2}\left|(-H)^{\frac{1}{2}} S_{N} u_{N}\right|_{L^{2}}^{2}\right], \tag{4.29}
\end{align*}
$$

by Young inequality.

Gathering (4.26)-(4.29), and noticing that $\left|(-H)^{\frac{1}{2}} S_{N} u_{N}\right|_{L^{2}} \leq\left|(-H)^{\frac{1}{2}} u_{N}\right|_{L^{2}}$, leads to

Applying the interpolation inequality

for any $\varepsilon>0$ and constants $C_{\varepsilon}>0$ and $m_{k, l}^{\prime}>0$. We choose $\varepsilon=\frac{\gamma_{1} \lambda_{1}^{2}}{4 C_{m}^{2 m}}$ after using Poincaré inequality so that the first term of the right hand side is absorbed in the left hand side,

Integrating in time, taking expectations on both sides and using the stationarity of $u_{N}$ and of the Wick products, together with Corollary 3.3, yields

Let $\left(u_{N}, Z_{N}\right)$ be a stationary solution of (4.24) in $E_{N}^{\mathbb{C}} \times E_{N}^{\mathbb{C}}$. Applying Proposition 7 with $m=1$, we deduce that for some positive constant $C$ not depending on $N$, and for any $t \geq 0$,

\end{aligned}

and the right hand side above is bounded indepently of $N$ and $t$, since $\mu_{N}$ converges to a Gaussian measure $\mu$ on $\mathcal{W}^{-s^{\prime}, q}$. The tightness of $\left(\tilde{\rho}_{N}\right)_{N}$ follows from Markov inequality and the compact embedding $\mathcal{W}^{-s^{\prime}, q} \subset \mathcal{W}^{-s, q}$, for any $s>s^{\prime}$.

Proof of Theorem 3. Assume now that $\gamma_{1}, \gamma_{2}, s$ and $q$ satisfy the hypothesis of Theorem 3, so that the solution $X$ of equation (2.9) with $X_{0} \in \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)$ is globally defined. The tightness of $\tilde{\rho}_{N}$ ensures in particular that there exists a subsequence weakly converging to a measure $\rho$ on $\mathcal{W}^{-s, q}$. Let $P_{t}$ be the transition semigroup associated with equation (2.9) defined by $P_{t} \phi\left(X_{0}\right)=\mathbb{E}\left(\phi\left(X\left(t, X_{0}\right)\right)\right)$. Since $P_{t}^{N} \phi\left(S_{N} X_{0}\right)$ converges to $P_{t} \phi\left(X_{0}\right)$ for any $X_{0} \in \mathcal{W}^{-s, q}\left(\mathbb{R}^{2}\right)$, by Proposition 6, it is not difficult to prove that the limit measure $\rho$ is an invariant measure for $P_{t}$.

## 5. EXistence of a stationary martingale solution for any dissipation

The aim of this section is to construct a stationary solution of (2.9) for any values of $\gamma_{1}>0$ and $\gamma_{2} \in \mathbb{R}$. We have seen in the previous section that the system (4.24) has a stationary solution $\left(u_{N}, Z_{N}\right)$ where $Z_{N}=\Pi_{N} Z_{\infty}^{\gamma_{1}, \gamma_{2}}$. Moreover, it is clear that $\left(u_{N}, Z_{\infty}^{\gamma_{1}, \gamma_{2}}\right)$ is then a stationary solution of

$$
\left\{\begin{align*}
\frac{d u}{d t} & =\left(\gamma_{1}+i \gamma_{2}\right)\left[H u-S_{N}\left(:\left|S_{N}(u+Z)\right|^{2} S_{N}(u+Z):\right)\right]  \tag{5.1}\\
d Z & =\left(\gamma_{1}+i \gamma_{2}\right) H Z d t+\sqrt{2 \gamma_{1}} d W .
\end{align*}\right.
$$

In this section we will denote $Z_{\infty}^{\gamma_{1}, \gamma_{2}}$ by $Z$ for the sake of simplicity. Using Proposition 7, we first prove that the the law of this sequence $\left\{\left(u_{N}, Z\right)\right\}_{N \in \mathbb{N}}$ is tight in an appropriate space to construct a martingale solution.

Lemma 5.1. Let $\gamma_{1}>0, \gamma_{2} \in \mathbb{R}, 0<s<1$, and $q>8$ such that $q s>8$. Let also $p>$ $\max \{q, 96\}$, and $0<\delta<\frac{1}{6}$. The sequence $\left(u_{N}, Z\right)_{N \in \mathbb{N}}$ is bounded in

L^{2 m}\left(\Omega, L^{2 m}\left(0, T, H^{\frac{1}{m}}\right)\right) \cap L^{\frac{4}{3}}\left(\Omega, \mathcal{W}^{1, \frac{4}{3}}\left(0, T, \mathcal{W}^{-2, p}\right)\right) \times C^{\alpha}\left([0, T], \mathcal{W}^{-s, q} \cap \mathcal{W}^{-\delta, p}\right)
$$

for any $m>0$, and $\alpha>0$ satisfying $\alpha<\min \left(\frac{s}{2}-\frac{1}{q}, \frac{\delta}{2}-\frac{1}{p}\right)$.
Proof. It suffices to check the bound in $L^{\frac{4}{3}}\left(\Omega, \mathcal{W}^{1, \frac{4}{3}}\left(0, T, \mathcal{W}^{-2, p}\right)\right)$, since the other bounds follow from Proposition 7, the stationarity of $u_{N}$, and Lemma 3.6 for $Z$. We write the equation for $u_{N}$;

In the right hand side, the first term is constant and clearly bounded in $L^{\frac{4}{3}}\left(\Omega, \mathcal{W}^{1, \frac{4}{3}}\left(0, T, \mathcal{W}^{-2, p}\right)\right)$ by Proposition 7 and Hölder inequality. For the second term, we have

& \leq C_{T} \mathbb{E}\left(\left|u_{N}\right|_{L^{2}\left(0, T, \mathcal{W}^{1,2}\right)}^{2}\right)
\end{aligned}
$$

where we have used Sobolev embedding and Hölder inequality in the last inequality. To estimate the nonlinear terms, we decompose as in (3.24),

The terms in $F_{3}$ are simply estimated thanks to Proposition 4 as follows.

For the term $F_{0}$, using Sobolev embeddings $L^{\frac{4}{3}} \subset \mathcal{W}^{-2, p}$ and $\mathcal{W}^{\frac{1}{2}, 2} \subset L^{4}$, we obtain

& \leq C_{T} \mathbb{E}\left(\left.\left.| | S_{N} u_{N}\right|^{2} S_{N} u_{N}\right|_{L^{\frac{4}{3}}} ^{\frac{4}{3}}\right)=C_{T} \mathbb{E}\left(\left|S_{N} u_{N}\right|_{L^{4}}^{4}\right) \leq C_{T} \mathbb{E}\left(\left|u_{N}\right|_{\mathcal{W}^{\frac{1}{2}, 2}}^{4}\right),
\end{aligned}
$$

which is bounded independently of $N$ by Proposition 7. To estimate the $F_{1}$-terms, we fix $s^{\prime}>0$ such that $s^{\prime}<\frac{1}{12}$ and $s^{\prime} p>8$, and apply Lemma 3.13 to get

Using then the Sobolev embedding $\mathcal{W}^{\frac{17}{24}, 2} \subset \mathcal{W}^{\frac{3}{8}, 3}$ and Hölder inequality, the right hand side is majorized by

and is thus bounded independently of $N$ thanks to Propositions 4 and 7 . Finally, for the terms in $F_{2}$, we apply again Lemma 3.13:

& \leq C_{T} \sum_{k+l=2} \mathbb{E}\left(\left|:\left(S_{N} Z_{R}\right)^{k}\left(S_{N} Z_{I}\right)^{l}:\right|_{\mathcal{W}^{-s^{\prime}, p}}^{3}\right)^{\frac{4}{9}} \mathbb{E}\left(\left|u_{N}\right|_{\left.\mathcal{W}^{\frac{5}{5}}\right)^{\frac{12}{5}}}^{5^{\frac{5}{2}}},\right.
\end{aligned}
$$

which is bounded again by Propositions 4 and 7 . Note that in the last inequality we have used the Sobolev embedding $\mathcal{W}^{\frac{5}{6}, 2} \subset \mathcal{W}^{\frac{1}{3}, 4}$ and Hölder inequality.

Remark 5.1. We note that by Lemma 5.1, $\left(u_{N}\right)_{N \in \mathbb{N}}$ is bounded in

L^{3}\left(\Omega, L^{3}\left(0, T, \mathcal{W}^{\frac{2}{3}, 2}\right)\right) & \cap L^{\frac{4}{3}}\left(\Omega, \mathcal{W}^{1, \frac{4}{3}}\left(0, T, \mathcal{W}^{-2, p}\right)\right) \\
& \subset L^{\frac{4}{3}}\left(\Omega, L^{3}\left(0, T, \mathcal{W}^{\frac{2}{3}, 2}\right)\right) \cap L^{\frac{4}{3}}\left(\Omega, \mathcal{W}^{\frac{1}{12}, 3}\left(0, T, \mathcal{W}^{-2, p}\right)\right),
\end{aligned}
$$

and $L^{3}\left(0, T, \mathcal{W}^{\frac{2}{3}, 2}\right) \cap \mathcal{W}^{\frac{1}{12}, 3}\left(0, T, \mathcal{W}^{-2, p}\right)$ is compactly embedded in $L^{3}\left(0, T, L_{x}^{4}\right)$. On the other hand, $\left(u_{N}\right)_{N \in \mathbb{N}}$ is also bounded in

\begin{aligned}
L^{2}\left(\Omega, L^{2}\left(0, T, \mathcal{W}^{1,2}\right)\right) & \cap L^{\frac{4}{3}}\left(\Omega, \mathcal{W}^{1, \frac{4}{3}}\left(0, T, \mathcal{W}^{-2, p}\right)\right) \\
& \subset L^{\frac{4}{3}}\left(\Omega, L^{2}\left(0, T, \mathcal{W}^{1,2}\right) \cap \mathcal{W}^{\frac{1}{12}, 2}\left(0, T, \mathcal{W}^{-2, p}\right)\right)
\end{aligned}
$$

and $L^{2}\left(0, T, \mathcal{W}^{1,2}\right) \cap \mathcal{W}^{\frac{1}{12}, 2}\left(0, T, \mathcal{W}^{-2, p}\right)$ is compactly embedded in $L^{2}\left(0, T, \mathcal{W}^{s, 2}\right)$ for any $s$ with $0 \leq s<1$. In particular, since $\mathcal{W}^{\frac{5}{6}, 2} \subset \mathcal{W}^{\frac{1}{3}, 4}$, the embedding is compact in $L^{2}\left(0, T, \mathcal{W}^{\frac{1}{3}, 4}\right)$. Finally, we note that $\mathcal{W}^{1, \frac{4}{3}}\left(0, T, \mathcal{W}^{-2, p}\right)$ is compactly embedded in $C\left([0, T], \mathcal{W}^{-3, p}\right)$.
Proof of Theorem 4. Let $\alpha>0$ satisfy the condition in Lemma 5.1. We deduce from Lemma 5.1, Remark 5.1 and Markov inequality that the sequence $\left\{\left(u_{N}, Z\right)_{N \in \mathbb{N}}\right\}$ is tight in

L^{3}\left(0, T, L^{4}\right) \cap L^{2}\left(0, T, \mathcal{W}^{\frac{5}{6}, 2}\right) \cap C\left([0, T], \mathcal{W}^{-3, p}\right) \times C^{\beta}\left([0, T], \mathcal{W}^{-s^{\prime}, q} \cap \mathcal{W}^{-\delta, p}\right) \tag{5.2}
\end{equation*}
$$

for any $\beta<\alpha$ and $s^{\prime}>s$. Fix such $\beta$ and $s^{\prime}$. By Prokhorov Theorem, there exists a subsequence, still denoted $\left\{\left(u_{N}, Z\right)_{N \in \mathbb{N}}\right\}$ which converges in law to a measure $\nu$ on the space (5.2). By Skorokhod Theorem, there exist $(\tilde{\Omega}, \tilde{\mathcal{F}}, \tilde{\mathbb{P}}),\left(\tilde{u}_{N}, \tilde{Z}_{N}\right)_{N \in \mathbb{N}}$ and $(\tilde{u}, \tilde{Z})$ taking values in the same space (5.2), satisfying $\mathcal{L}\left(\left(u_{N}, Z\right)\right)=\mathcal{L}\left(\left(\tilde{u}_{N}, \tilde{Z}_{N}\right)\right)$ for any $N \in \mathbb{N}, \mathcal{L}((\tilde{u}, \tilde{Z}))=\nu$, and $\tilde{u}_{N}$ converges to $\tilde{u}$, $\tilde{\mathbb{P}}$-a.s. in $L^{3}\left(0, T, L^{4}\right) \cap L^{2}\left(0, T, \mathcal{W}^{\frac{5}{6}}, 2\right) \cap C\left([0, T], \mathcal{W}^{-3, p}\right), \tilde{Z}_{N}$ converges to $\tilde{Z}$, $\tilde{\mathbb{P}}$-a.s. in $C^{\beta}\left([0, T], \mathcal{W}^{-s^{\prime}, q} \cap \mathcal{W}^{-\delta, p}\right)$. Moreover, by diagonal extraction, it can be assumed that this holds for any $T>0$. It is easily seen that $(\tilde{u}, \tilde{Z})$ is a stationary process thanks to the convergence of $\left(\tilde{u}_{N}, \tilde{Z}_{N}\right)$ to $(\tilde{u}, \tilde{Z})$ in $C\left([0, T], \mathcal{W}^{-3, p}\right) \times C^{\beta}\left([0, T], \mathcal{W}^{-s^{\prime}, q}\right)$. This convergence also implies $\mathcal{L}(Z)=\mathcal{L}(\tilde{Z})$. Note also that if we extract from the subsequence used in the proof of Theorem 3, we have that for each $t \in \mathbb{R}, \mathcal{L}(\tilde{X}(t))=\mathcal{L}(\tilde{u}(t)+\tilde{Z}(t))=\rho$.

Write then,

$\tilde{\mathbb{P}}$-a.s. in $C\left([0, T], \mathcal{W}^{-2, p}\right)$. This can be checked as follows. First, the convergence of the linear term follows from the convergence of $\tilde{u}_{N}$ to $\tilde{u}$ in $L^{2}\left(0, T, \mathcal{W}^{\frac{5}{6}, 2}\right) \subset L^{1}\left(0, T, \mathcal{W}^{-2, p}\right)$. In order to prove the convergence of nonlinear terms, we again decompose the nonlinear terms into the four terms $F_{0}, \ldots, F_{3}$ as in (3.24) and estimate them separately, i.e.,

\leq & \sum_{k=0}^{3} \int_{0}^{T}\left|F_{k}(\tilde{u}, \tilde{Z})-S_{N} F_{k}\left(S_{N} \tilde{u}_{N}, S_{N} \tilde{Z}_{N}\right)\right|_{\mathcal{W}^{-2, p}} d \sigma \\
= & I_{0}^{N}+I_{1}^{N}+I_{2}^{N}+I_{3}^{N} .
\end{aligned}
$$

We begin with the convergence of $I_{0}^{N}$.

& \leq\left.\int_{0}^{T}| | S_{N} \tilde{u}_{N}\right|^{2} S_{N} \tilde{u}_{N}-\left.|\tilde{u}|^{2} \tilde{u}\right|_{L^{\frac{4}{3}}} d \sigma+\left.\left.\int_{0}^{T}\left|\left(S_{N}-I\right)\right| \tilde{u}\right|^{2} \tilde{u}\right|_{L^{\frac{1}{3}}} d \sigma
\end{aligned}
$$

Since $\tilde{u}_{N}$ converges to $\tilde{u}$ a.s. in $L^{3}\left(0, T, L_{x}^{4}\right)$, by dominated convergence, the same holds for $S_{N} \tilde{u}_{N}$, thus $\left|S_{N} \tilde{u}_{N}\right|^{2} S_{N} \tilde{u}_{N}$ converges to $|\tilde{u}|^{2} \tilde{u}$ a.s. in $L^{\frac{4}{3}}\left(0, T, L^{\frac{4}{3}}\right)$. Similarly, the second term converges to zero by dominated convergence, therefore, $I_{0}^{N}$ converges to 0 . Next, we use Lemma 3.13 to obtain

& +\left(\left|S_{N} \tilde{Z}_{N}\right|_{C\left([0, T], \mathcal{W}^{-\delta, p}\right)}+|\tilde{Z}|_{C\left([0, T], \mathcal{W}^{-\delta, p}\right)}\right)\left(\left|S_{N} \tilde{u}_{N}\right|_{L^{2}\left(0, T, \mathcal{W}^{\frac{1}{3}, 4}\right)}+|\tilde{u}|_{L^{2}\left(0, T, \mathcal{W}^{\frac{1}{3}, 4}\right)}\right) \\
& \times\left|S_{N} \tilde{u}_{N}-\tilde{u}\right|_{L^{2}\left(0, T, \mathcal{W}^{\frac{1}{3}, 4}\right)}
\end{aligned}

Hence, $I_{1}^{N}$ converges to 0 since $S_{N} \tilde{Z}_{N}$ converges to $\tilde{Z}$ in $C\left([0, T], \mathcal{W}^{-\delta, p}\right)$ and, by Remark 5.1, $S_{N} \tilde{u}_{N}$ converges to $\tilde{u}$ in $L^{2}\left(0, T, \mathcal{W}^{\frac{1}{3}, 4}\right)$. Concerning $F_{2}$, we proceed as for $F_{1}$, and we use Lemma 3.13 in the same way;

Note that Proposition 4 implies the convergence to zero of the second term in $L^{p}(\Omega)$, thus extracting a subsequence, $\tilde{\mathbb{P}}$-a.s. The first term goes to 0 , too since, again, $S_{N} \tilde{u}_{N}$ converges to $\tilde{u}$ in $L^{2}\left(0, T, \mathcal{W}^{\frac{1}{3}, 4}\right)$. The term $I_{3}^{N}$ can be treated similarly. We deduce from this convergence result that $\tilde{u}$ satisfies

\left.\tilde{u}(t)-\tilde{u}(0)=\left(\gamma_{1}+i \gamma_{2}\right) \int_{0}^{t} H \tilde{u}(\sigma) d \sigma-\left(\gamma_{1}+i \gamma_{2}\right) \int_{0}^{t}:|(\tilde{u}+\tilde{Z})|^{2}(\tilde{u}+\tilde{Z}):\right)(\sigma) d \sigma
$$

Since it is clear that $\tilde{Z}$ satisfies the second equation in (5.1), we easily deduce that $\tilde{X}=\tilde{u}+\tilde{Z}$ is a stationary solution of $(2.9)$ on $(\tilde{\Omega}, \tilde{F}, \tilde{\mathbb{P}})$. Moreover, it is not difficult to prove that $\tilde{u}$ is continuous with values in $\mathcal{W}^{-s, q}$, which ends the proof of Theorem 4.

## 6. Appendix 1

Proof for Lemma 3.8. It suffices to show (3.22) for the case $s=2$. Indeed, all other cases $s \in[0,2)$ follow by the interpolation

$$
|f|_{\mathcal{W}^{s, p}} \leq|f|_{\mathcal{W}^{s_{0}, p}}^{1-\theta}|f|_{\mathcal{W}^{s_{1}, p}}^{\theta}
$$

with $s=(1-\theta) s_{0}+\theta s_{1}$, and $0<\theta<1$, since Lemma 3.7 gives the inequality in the case $s=0$. Due to the Mehler formula, the expression of the kernel of $e^{t\left(\gamma_{1}+i \gamma_{2}\right) H}$ for $d=2$ is given by

$$
e^{t\left(\gamma_{1}+i \gamma_{2}\right) H} f(x)=\int_{\mathbb{R}^{2}} \Xi_{t}(x, y) f(y) d y, \quad t>0, \quad x \in \mathbb{R}^{2}
$$

with

$$
\begin{aligned}
\Xi_{t}(x, y) & :=\frac{\exp \left[-\frac{\cosh \left(2 t\left(\gamma_{1}+i \gamma_{2}\right)\right)}{2 \sinh \left(2 t\left(\gamma_{1}+i \gamma_{2}\right)\right)}\left(|x|^{2}+|y|^{2}\right)+\frac{1}{\sinh \left(2 t\left(\gamma_{1}+i \gamma_{2}\right)\right)} x \cdot y\right]}{2 \pi \sinh \left(2 t\left(\gamma_{1}+i \gamma_{2}\right)\right)} \\
& =\frac{\delta}{\pi} \exp \left(-(\beta-\delta)|x|^{2}\right) \exp \left(-\delta|x-y|^{2}\right) \exp \left(-(\beta-\delta)|y|^{2}\right),
\end{aligned}
$$

where we have set

$$
\delta=\frac{1}{2 \sinh \left(2 t\left(\gamma_{1}+i \gamma_{2}\right)\right)}, \quad \beta=\frac{\cosh \left(2 t\left(\gamma_{1}+i \gamma_{2}\right)\right)}{2 \sinh \left(2 t\left(\gamma_{1}+i \gamma_{2}\right)\right)} .
$$

Note that $\operatorname{Re}(\delta)>0$ for $0<t<\frac{\pi}{4\left|\gamma_{2}\right|}$ if $\gamma_{2} \neq 0$, and for all $t>0$ if $\gamma_{2}=0$. Also, $\operatorname{Re}(\beta-\delta)>0$ for any $t>0$. Here we rewrite the kernel of $e^{t\left(\gamma_{1}+i \gamma_{2}\right) H}$ as

$$
\left(e^{\left(\gamma_{1}+i \gamma_{2}\right) t H} f\right)(x)=e^{-(\beta-\delta)|x|^{2}}\left(e^{\delta^{-1} \Delta} g\right)(x), \quad g(x)=e^{-(\beta-\delta)|x|^{2}} f(x),
$$

where we denoted $e^{\delta^{-1} \Delta}$ the evolution operator associated to the kernel $\frac{\delta}{\pi} e^{-\delta|x-y|^{2}}$; thus

$$
\left(e^{\delta^{-1} \Delta} g\right)(x)=\int_{\mathbb{R}_{y}^{2}} \frac{\delta}{\pi} e^{-\delta|x-y|^{2}} g(y) d y=(U * g)(x)
$$

with the notation

$$
U(x)=\frac{\delta}{\pi} e^{-\delta|x|^{2}} .
$$

Remark that $\mathcal{F}(U)(\xi)=e^{-\frac{|\xi|^{2}}{4 \delta}}$ since $\operatorname{Re}(\delta)>0$, where $\mathcal{F}$ denotes the Fourier transform.
Thanks to the norm equivalence in Proposition 3 (1), we shall estimate for any $1<p<\infty$, $\left|\langle D\rangle^{2} e^{\left(\gamma_{1}+i \gamma_{2}\right) t H} f\right|_{L^{p}}$ and $\left|\langle x\rangle^{2} e^{\left(\gamma_{1}+i \gamma_{2}\right) t H} f\right|_{L^{p}}$, and show that these terms are bounded by $C t^{-1}$.

First,

$$
\left.\left.\left.\begin{array}{rl}
\langle D\rangle^{2} e^{\left(\gamma_{1}+i \gamma_{2}\right) t H} f(x) & =\mathcal{F}^{-1} \mathcal{F}\left\{\langle D\rangle^{2} e^{-(\beta-\delta)|x|^{2}}\left(e^{\delta-1} \Delta g\right)\right\} \\
& =\frac{\pi}{\beta-\delta} \mathcal{F}^{-1}\left[\langle \xi \rangle ^ { 2 } \left(e ^ { - \frac { 1 . | ^ { 2 } } { 4 ( \beta - \delta ) } } * \mathcal { F } \left(e^{\delta-1} \Delta\right.\right.\right.
\end{array}\right)\right)\right] \quad \text { (i) (ii)+(iii)+(iv),}
$$

where, using the Fubini theorem, the change of variables $\xi^{\prime}=\xi-\eta$, and developing the bracket $\left\langle\xi^{\prime}+\eta\right\rangle^{2}=\left\langle\xi^{\prime}\right\rangle^{2}+\langle\eta\rangle^{2}-1+2 \xi^{\prime} \cdot \eta$ in the last equality,

$$
\begin{aligned}
\text { (i) } & =-\frac{\pi}{\beta-\delta} \int_{\mathbb{R}_{\xi^{\prime}}^{2}} \int_{\mathbb{R}_{\eta}^{2}} e^{i x \cdot\left(\xi^{\prime}+\eta\right)} e^{-\frac{\left|\xi^{\prime}\right|^{2}}{4(\beta-\delta)}} \widehat{U * g}(\eta) d \eta d \xi^{\prime} \\
\text { (ii) } & =\frac{\pi}{\beta-\delta} \int_{\mathbb{R}_{\xi^{\prime}}^{2}} \int_{\mathbb{R}_{\eta}^{2}} e^{i x \cdot\left(\xi^{\prime}+\eta\right)}\left\langle\xi^{\prime}\right\rangle^{2} e^{-\frac{\left|\xi^{\prime}\right|^{2}}{4(\beta-\delta)}} \widehat{U * g}(\eta) d \eta d \xi^{\prime} \\
\text { (iii) } & =\frac{\pi}{\beta-\delta} \int_{\mathbb{R}_{\xi^{\prime}}^{2}} \int_{\mathbb{R}_{\eta}^{2}} e^{i x \cdot\left(\xi^{\prime}+\eta\right)}\langle\eta\rangle^{2} e^{-\frac{\left|\xi^{\prime}\right|^{2}}{4(\beta-\delta)}} \widehat{U * g}(\eta) d \eta d \xi^{\prime} \\
\text { (iv) } & =\frac{2 \pi}{\beta-\delta} \int_{\mathbb{R}_{\xi^{\prime}}^{2}} \int_{\mathbb{R}_{\eta}^{2}} e^{i x \cdot\left(\xi^{\prime}+\eta\right)} \xi^{\prime} \cdot \eta e^{-\frac{\left|\xi^{\prime}\right|^{2}}{4(\beta-\delta)}} \widehat{U * g}(\eta) d \eta d \xi^{\prime} .
\end{aligned}
$$

Note that (i) may be written as $-e^{-(\beta-\delta)|x|^{2}}(U * g)(x)$, thus

$$
|(\mathrm{i})|_{L^{p}} \leq|U * g|_{L^{p}} \leq|U|_{L^{1}}|g|_{L^{p}} \leq|f|_{L^{p}},
$$

by Young inequality. On the other hand, (ii) equals $\left(\langle D\rangle^{2} e^{-(\beta-\delta)|x|^{2}}\right)(U * g)(x)$, therefore we have

$$
|(\mathrm{ii})|_{L^{p}} \leq\left|\langle D\rangle^{2} e^{-(\beta-\delta)|x|^{2}}\right|_{L^{\infty}}|U * g|_{L^{p}} \leq C_{\gamma_{1}, \gamma_{2}}(1+|\beta-\delta|)|f|_{L^{p}},
$$

for $t>0$ with $\gamma_{1} t,\left|\gamma_{2} t\right| \ll 1$, since

$$
\left|\langle D\rangle^{2} e^{-(\beta-\delta)|x|^{2}}\right|_{L^{\infty}} \leq C_{\gamma_{1}, \gamma_{2}}(1+|\beta-\delta|)
$$

for $t>0$ with $\gamma_{1} t,\left|\gamma_{2} t\right| \ll 1$. Here we used the fact that $\left|\frac{\operatorname{Im}(\beta-\delta)}{\operatorname{Re}(\beta-\delta)}\right| \leq C_{\gamma_{1}, \gamma_{2}}$ for $t>0$ with $\gamma_{1} t,\left|\gamma_{2} t\right| \ll 1$. Next, (iii) $=e^{-(\beta-\delta)|x|^{2}}\langle D\rangle^{2}(U * g)(x)$, thus we obtain

$$
\mid\left.(\text { iii })\right|_{L^{p}} \leq\left|\left(\langle D\rangle^{2} U\right) * g\right|_{L^{p}} \leq C(1+|\delta|)|f|_{L^{p}} .
$$

Similarly as above, we estimate

$$
\begin{aligned}
|(\mathrm{iv})|_{L^{p}} & \leq C\left|\langle D\rangle e^{-(\beta-\delta)|x|^{2}}\right|_{L^{\infty}}|\langle D\rangle(U * g)|_{L^{p}} \\
& \leq C_{\gamma_{1}, \gamma_{2}}(1+|\beta-\delta|)^{\frac{1}{2}}(1+|\delta|)^{\frac{1}{2}}|f|_{L^{p}}
\end{aligned}
$$

for $t>0$ with $\gamma_{1} t,\left|\gamma_{2} t\right| \ll 1$.
The other term may be estimated as follows using the notation

$$
\begin{aligned}
|f|_{L_{\sigma}^{p}}^{p} & =\int_{\mathbb{R}^{2}}|f(x)|^{p}\langle x\rangle^{\sigma} d x, \quad \sigma \geq 0: \\
\left|\langle x\rangle^{2} e^{\left(\gamma_{1}+i \gamma_{2}\right) t H} f\right|_{L^{p}} & =\left|e^{\left(\gamma_{1}+i \gamma_{2}\right) t H} f\right|_{L_{2 p}^{p}}=\left|e^{-(\beta-\delta)|x|^{2}}\left(e^{\delta-1} \Delta g\right)\right|_{L_{2 p}^{p}}^{p} \\
& \leq \sup _{x \in \mathbb{R}^{2}}\left(e^{-\operatorname{Re}(\beta-\delta)|x|^{2}}\langle x\rangle^{2}\right)\left|e^{\delta^{-1} \Delta} g\right|_{L^{p}} \\
& \leq \frac{C}{\operatorname{Re}(\beta-\delta)}|f|_{L^{p}} .
\end{aligned}
$$

The proof is completed by the fact that $\operatorname{Re}(\beta-\delta) \sim \frac{\gamma_{1}}{2} t$ and $|\delta| \sim C_{\gamma_{1}, \gamma_{2}} t^{-1}$, for $t>0$ with $\gamma_{1} t,\left|\gamma_{2} t\right| \ll 1$.

Proof of Lemma 3.9. Let $\delta>0$; by Hölder inequality, for any $g \in \mathcal{W}^{\delta, 2 p}$ with $\delta p^{*}>1$ and $\frac{1}{p}+\frac{1}{p^{*}}=1$,

$$
|g|_{L^{2}}^{2}=\int_{\mathbb{R}^{2}}\left(1+|x|^{2}\right)^{-\delta}\left(1+|x|^{2}\right)^{\delta}|g(x)|^{2} d x \leq C\left[\int_{\mathbb{R}^{2}}\left(1+|x|^{2}\right)^{\delta p}|g(x)|^{2 p} d x\right]^{\frac{1}{p}} .
$$

By (1) of Proposition 3,

$$
\left[\int_{\mathbb{R}^{2}}\left(1+|x|^{2}\right)^{\delta p}|g(x)|^{2 p} d x\right]^{\frac{1}{2 p}} \leq C\left|(-H)^{\frac{\delta}{2}} g\right|_{L^{2 p}}
$$

Writing $f=(-H)^{\frac{\delta}{2}} g$, we then deduce $\left|(-H)^{-\frac{\delta}{2}} f\right|_{L^{2}} \leq C|f|_{L^{2 p}}$, if $\delta p^{*}>1$, i.e. if $\delta>1-\frac{1}{p}$. Then we get

$$
\begin{aligned}
\left|e^{t\left(\gamma_{1}+i \gamma_{2}\right) H} f\right|_{L^{2}} & =\left|(-H)^{\frac{\delta}{2}} e^{t\left(\gamma_{1}+i \gamma_{2}\right) H}(-H)^{-\frac{\delta}{2}} f\right|_{L^{2}} \leq C\left|e^{t\left(\gamma_{1}+i \gamma_{2}\right) H}(-H)^{-\frac{\delta}{2}} f\right|_{\mathcal{W}^{\delta, 2}} \\
& \leq C t^{-\frac{\delta}{2}}\left|(-H)^{-\frac{\delta}{2}} f\right|_{L^{2}} \leq C t^{-\frac{\delta}{2}}|f|_{L^{2 p}},
\end{aligned}
$$

where we have used Lemma 3.8 in the fourth inequality. Replacing $2 p$ by $p$ and writing $\beta=\frac{\delta}{2}$, we have for $p \geq 2, t>0$,

$$
\left|e^{t\left(\gamma_{1}+i \gamma_{2}\right) H} f\right|_{L^{2}} \leq C t^{-\beta}|f|_{L^{p}}
$$

for $\beta>\frac{1}{2}-\frac{1}{p}$, which gives the expected result.

## 7. Appendix 2

In this section we give a proof of Lemma 3.13. Before proving Lemma 3.13 we need two preliminary results.

Lemma 7.1. Let $\beta, \gamma \geq \alpha>0, \gamma<\frac{2}{p_{2}}, \beta<\frac{2}{p_{1}}, 1<q, p_{1}, p_{2}<+\infty$, and

$$
\frac{1}{p_{1}}+\frac{1}{p_{2}}-\frac{\beta}{2}-\frac{\gamma}{2}+\frac{\alpha}{2}=\frac{1}{q} .
$$

Then, for any $f \in \mathcal{W}^{\beta, p_{1}}\left(\mathbb{R}^{2}\right), g \in \mathcal{W}^{\gamma, p_{2}}\left(\mathbb{R}^{2}\right)$,

$$
|f g|_{\mathcal{W}^{\alpha, q}} \lesssim|f|_{\mathcal{W}^{\beta, p_{1}}}|g|_{\mathcal{W}^{\gamma, p_{2}}} .
$$

Proof. Under the condition on the parameters, we may find, by the Sobolev embedding, $q_{1}$ with $1<p_{1} \leq q_{1}<+\infty$ such that $\frac{1}{q_{1}}=\frac{1}{p_{1}}-\frac{\beta}{2}$, so that $|f|_{L^{q_{1}}} \lesssim|f|_{\mathcal{W}^{\beta, p_{1}}}$. On the other hand, we have $\frac{2}{p_{1}} \geq \frac{2}{p_{1}}-(\beta-\alpha)>0$, thus there exists $q_{2}$ such that $1<p_{1} \leq q_{2}<+\infty$ and $\frac{1}{q_{2}}=\frac{1}{p_{1}}-\frac{\beta-\alpha}{2}$, i.e., $|f|_{\mathcal{W}^{\alpha, q_{2}}} \lesssim|f|_{\mathcal{W}^{\beta, p_{1}}}$. Similarly, we may find $\tilde{q_{2}}$ with $1<p_{2}<\tilde{q_{2}}<+\infty$ such that $\frac{1}{\tilde{q}_{2}}=\frac{1}{p_{2}}-\frac{\gamma}{2}$, i.e. $|g|_{L^{q q_{2}}} \lesssim|g|_{\mathcal{W}^{\gamma}, p_{2}}$, and we may find $\tilde{q_{1}}$ with $1<p_{2} \leq \tilde{q_{1}}<+\infty$ such that $\frac{1}{\tilde{q}_{1}}=\frac{1}{p_{2}}-\frac{\gamma-\alpha}{2}$, i.e. $|g|_{\mathcal{W}^{\alpha, q_{1}}} \lesssim|g|_{\mathcal{W}^{\gamma}, p_{2}}$. At last, the relation $\frac{1}{p_{1}}+\frac{1}{p_{2}}-\frac{\beta}{2}-\frac{\gamma}{2}+\frac{\alpha}{2}=\frac{1}{q}$ implies $\frac{1}{q_{1}}+\frac{1}{\tilde{q}_{1}}=\frac{1}{q_{2}}+\frac{1}{\tilde{q}_{2}}=\frac{1}{q}$.
Therefore, applying Proposition 3 (2) and obtain

$$
|f g|_{\mathcal{W}^{\alpha, q}} \leq C\left(|f|_{L^{q_{1}}}|g|_{\mathcal{W}^{\alpha, q_{1}}}+|f|_{\mathcal{W}^{\alpha, q_{2}}}|g|_{L^{q_{2}}}\right) .
$$

Combining with the above inequalities leads to the desired result.
With the use of a duality argument, we obtain the following lemma.

Lemma 7.2. Let $\beta, \gamma \geq \alpha>0, \gamma<2\left(1-\frac{1}{q}\right), \beta<\frac{2}{p_{2}}, 1<q, p_{1}, p_{2}<+\infty$, and

$$
\frac{1}{p_{1}}+\frac{1}{p_{2}}-\frac{\beta}{2}-\frac{\gamma}{2}+\frac{\alpha}{2}=\frac{1}{q}
$$

Then, for any $f \in \mathcal{W}^{\beta, p_{2}}\left(\mathbb{R}^{2}\right), h \in \mathcal{W}^{-\alpha, p_{1}}\left(\mathbb{R}^{2}\right)$,

$$
|f h|_{\mathcal{W}^{-\gamma, q}} \lesssim|f|_{\mathcal{W}^{\beta, p_{2}}}|h|_{\mathcal{W}^{-\alpha, p_{1}}}
$$

Proof. By duality for $f \in \mathcal{W}^{\beta, p_{2}}, g \in \mathcal{W}^{\gamma, \tilde{q}}$ and $h \in \mathcal{W}^{-\alpha, p_{1}}$ with $\frac{1}{q}+\frac{1}{\tilde{q}}=1, \frac{1}{p_{1}}+\frac{1}{\tilde{p_{1}}}=1$, we have

$$
(h f, g)=(h, f g) \leq|h|_{\mathcal{W}^{-\alpha, p_{1}}}|f g|_{\mathcal{W}^{\alpha, p_{1}}}
$$

In order to use Lemma 7.1, let us check the conditions on the parameters : by the assumption, we have $\beta<\frac{2}{p_{2}}$ and $\gamma<\frac{2}{\tilde{q}}$. On the other hand, $\frac{1}{p_{2}}+\frac{1}{\tilde{q}}-\frac{\beta}{2}-\frac{\gamma}{2}+\frac{\alpha}{2}=\frac{1}{p_{2}}+1-\frac{1}{q}-\frac{\beta}{2}-\frac{\gamma}{2}+\frac{\alpha}{2}$, which in turn is equal to $1-\frac{1}{p_{1}}=\frac{1}{\tilde{p_{1}}}$. Thus it follows from Lemma 7.1 that $|f g|_{\mathcal{W}^{\alpha, \tilde{p_{1}}}} \lesssim|f|_{\mathcal{W}^{\beta, p_{2}}}|g|_{\mathcal{W}^{\gamma, \tilde{q}}}$, which implies $|h f|_{\mathcal{W}^{-\gamma, \tilde{q}}} \lesssim|h|_{\mathcal{W}^{-\alpha, p_{1}}}|f|_{\mathcal{W}^{\beta, p_{2}}}$.

Proof of Lemma 3.13. It suffices to apply Lemma 7.2 with

$$
\gamma=s+l\left(\frac{2}{p}-\beta\right) \geq s+(l-1)\left(\frac{2}{p}-\beta\right)=\alpha, \quad p_{1}=q, \quad p_{2}=p
$$

to obtain

$$
\begin{equation*}
\left|h f^{l}\right|_{\mathcal{W}^{-\left(s+l\left(\frac{2}{p}-\beta\right)\right), q}} \leq C\left|h f^{l-1}\right|_{\mathcal{W}^{-\left(s+(l-1)\left(\frac{2}{p}-\beta\right)\right), q}}|f|_{\mathcal{W}^{\beta, p}} \tag{7.1}
\end{equation*}
$$

Repeating recursively the argument gives the result.
