# KERNEL ESTIMATION FOR LÉVY DRIVEN STOCHASTIC CONVOLUTIONS

#### Abstract

We consider a Lévy driven stochastic convolution, also called continuous time Lévydriven moving average model, $X(t)=\int_{0}^{t} a(t-s) d Z(s)$ where $Z$ is a Lévy martingale and the kernel $a($.$) a deterministic function square integrable on \mathbb{R}^{+}$. Given $N$ i.i.d. continuous time observations $\left(X_{i}(t)\right)_{t \in[0, T]}$ on $[0, T]$, for $i=1, \ldots, N$ distributed like $(X(t))_{t \in[0, T]}$, we propose two types of nonparametric projection estimators of $a^{2}$ under different sets of assumptions. We bound the $\mathbb{L}^{2}$-risk of the estimators and propose a data-driven procedure to select the dimension of the projection space. February 17, 2021

## 1. Introduction

In this paper, we consider the continuous time moving average (CMA) process, also called stochastic convolution,

$$
\begin{equation*}
X(t)=\int_{0}^{t} a(t-s) d Z(s) \tag{1}
\end{equation*}
$$

where $(Z(t))_{t \geq 0}$ is a Lévy process such that $\mathbb{E} Z(1)=0, \mathbb{E} Z^{2}(1)=1$, and the kernel $a():. \mathbb{R}^{+} \rightarrow \mathbb{R}$ is a deterministic square integrable function. Our aim is the nonparametric estimation of $a^{2}$ (.) from i.i.d. observations $\left(X_{i}(t), t \in[0, T], i=1, \ldots, N\right)$ distributed as $(X(t), t \in[0, T])$.
CMA processes have been largely studied in the past decades. Indeed, they provide a large class of stochastic processes including the classical continuous time ARMA (CARMA) processes and also more involved models such as fractional Lévy processes. Generally, stationary versions of $(X(t))_{t \geq 0}$ are investigated, i.e. $Y(t)=\int_{-\infty}^{+\infty} a(t-s) d Z(s)$ (see e.g. Rajput and Rosinski (1989), Brockwell (2001), Marquart (2006), Brockwell and Lindner (2009), Bender et al. (2012), Brockwell et al. (2013)). These processes are well fitted to modelling various phenomena in fields such as econometrics and finance (see Comte and Renault (1996)), electricity prices (see Klüppelberg et al. (2010)). Schnurr and Woerner (2011) study the so-called well-balanced Ornstein-Uhlenbeck process and its correlation structure and show that this model can be used as volatility process in stochastic volatility models.
Estimation properties are generally studied from the observation of one sample path in stationary regime (like $(Y(t))_{t \geq 0}$ (see e.g. Brockwell et al. (2013)). In the same framework, Belomestny et al. (2019) are interested in estimation of the Lévy characteristics of $(Z(t))_{t \geq 0}$.

[^0]In our contribution, stationarity of the process is not required: $T$ is fixed and $N$ is large. To our knowledge, few papers are concerned with statistical properties in this context. In a previous paper (Comte and Genon-Catalot (2021)), we restrict our attention to Gaussian CMA processes, i.e. $Z(t)=W(t)$ is a Wiener process and provide nonparametric projection estimators of the function $a^{2}($.$) . Proofs, especially for the data-driven procedure, strongly rely on the Gaussian$ character of $(X(t))_{t \geq 0}$ and cannot be straightforwardly extended to the case where $(Z(t))_{t \geq 0}$ is a Lévy process. The question of this extension is studied here.
In Section 2, we precise the model and the assumptions. In Section 3, we define two collections of projection estimators depending on whether $X(t)$ is a semi-martingale or not. Relying on results of Basse and Pedersen (2009), we establish that the distinction between these two cases is the same as when $Z=W$ is a Brownian motion, i.e. when $a($.$) is continuously differen-$ tiable on $[0,+\infty)$ or not. The projection spaces are either, for fixed $T$, spaces generated by the trigonometric basis of $\mathbb{L}^{2}([0, T])$, or for large $T$ spaces generated by the Laguerre basis of $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$. Bounds for the $\mathbb{L}^{2}$-risk of the estimators are provided. In Section 4, we propose a datadriven procedure to select the dimension of the projection space and obtain risk bounds for the resulting estimator proving that it is adaptive in the sense that its risk automatically achieves the compromise between the squared bias and the variance. Proofs, especially of the adaptive result, are completely different from the ones in Comte and Genon-Catalot (2021). Section 5 states some concluding remarks. Section 6 contains proofs. Finally Section 7 gives the necessary recap on Laguerre functions, the Talagrand inequality on which relies our proof of Section 4 and the way to compute or bound moments of $\left(X(t)_{t \geq 0}\right)$.

## 2. Lévy driven moving averages

Consider a Lévy process $(Z(t))$ with no Gaussian part and Lévy measure $\nu(d x)=n(x) d x$ satisfying
$[\mathrm{H} 1] \int_{\mathbb{R}} x^{2} n(x) d x<+\infty$ and we assume that $\int_{\mathbb{R}} x^{2} n(x) d x=1$.
The second part of [H1] is an identifiability condition. Without it, we would estimate $\left(\int_{\mathbb{R}} x^{2} n(x) d x\right) \times$ $a^{2}$ (.). Below, we need stronger conditions near infinity for the Lévy density summarized by :
$[\mathrm{H} 2](p) \quad k_{2 p}:=\int_{\mathbb{R}} x^{2 p} n(x) d x<+\infty$.
We assume that the characteristic function of $Z(t)$ is equal to:

$$
\mathbb{E} e^{i u Z(t)}=\exp \left[t \int_{\mathbb{R}}\left(e^{i u x}-1-i u x\right) n(x) d x\right],
$$

so that $\mathbb{E} Z(1)=0, \mathbb{E} Z^{2}(1)=1$. Then, $(Z(t))$ is a Lévy martingale which can be written as:

$$
Z(t)=\int_{(0, t]} \int_{\mathbb{R}} x(\hat{p}(d s, d x)-d s n(x) d x),
$$

where $\hat{p}(d s, d x)$ is the random Poisson measure associated with its jumps. We consider a càdlàg version of the Lévy moving average process:

$$
\begin{equation*}
X(t)=\int_{0}^{t} a(t-s) d Z(s) . \tag{2}
\end{equation*}
$$

where we aim at estimating $g=a^{2}$ under assumptions of type:
$[\mathrm{H} 3](q)$ The function $g(t)=a^{2}(t)$ belongs to $\mathbb{L}^{q}\left(\mathbb{R}^{+}\right)$, i.e. $\quad \int_{0}^{+\infty} g^{q}(s) d s=\int_{0}^{+\infty} a^{2 q}(s) d s<+\infty$.
Assumptions [H1] and [H3](1) ensure the existence of (2) (see Section 6.1). Setting

$$
\begin{equation*}
G(t)=\int_{0}^{t} a^{2}(s) d s=\int_{0}^{t} g(s) d s \tag{3}
\end{equation*}
$$

we have:

$$
\mathbb{E} X^{2}(t)=\int_{0}^{t} \int_{\mathbb{R}} a^{2}(t-s) d s x^{2} n(x) d x=\int_{0}^{t} a^{2}(u) d u=G(t)
$$

Two cases are to be distinguished:
(1) $X(t)$ is a semi-martingale (more precisely, a $\left(\mathcal{F}_{t}^{Z}\right)_{t \geq 0}$-semimartingale where $\left(\mathcal{F}_{t}^{Z}\right)_{t \geq 0}$ is the natural filtration of $\left.\left(Z_{t}\right)_{t \geq 0}\right)$,
(2) $X(t)$ is not a semi-martingale.

In Case (2), we cannot give sense to a stochastic integral $\int_{0}^{t} H(s) d X(s)$ for a predictable process $H(s)$. A sufficient condition for case (1) to hold is stated in the following proposition.

Proposition 1. Assume that $a(t)$ belongs to $C^{1}([0,+\infty))$. Then,

$$
\begin{equation*}
X(t)=a(0) Z(t)+\int_{0}^{t}\left(\int_{0}^{u} a^{\prime}(u-s) d Z(s)\right) d u, \quad t \geq 0 \tag{4}
\end{equation*}
$$

## 3. Projection estimators on a fixed space.

We denote respectively by $\|\cdot\|_{T}$ (resp. $\left.\langle., .\rangle_{T}\right)$ the norm (resp. the scalar product) of $\mathbb{L}^{2}([0, T])$ and $\|$.$\| (resp. \langle.,\rangle$.$) the norm (resp. the scalar product) of \mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$. To build estimators of $g$, we use two collections of projection spaces.
(1) For fixed $T$, we estimate $g$ on $[0, T]$. We define the collection $\left(S_{m}^{T r i g}, m \geq 0\right)$ of subspaces of $\mathbb{L}^{2}([0, T])$ where $m$ is odd, generated by the orthonormal trigonometric basis $\left(\varphi_{j, T}\right), \varphi_{0, T}(t)=\sqrt{1 / T} \mathbf{1}_{[0, T]}(t), \varphi_{2 j-1, T}(t)=\sqrt{2 / T} \cos (2 \pi j t / T) \mathbf{1}_{[0, T]}(t)$ and $\varphi_{2 j, T}(t)=$ $\sqrt{2 / T} \sin (2 \pi j t / T) \mathbf{1}_{[0, T]}(t)$ for $j=1, \ldots,(m-1) / 2$. The following properties are useful

$$
\sum_{j=0}^{m-1} \varphi_{j, T}^{2}(t)=\frac{m}{T} \quad \text { and } \quad \int_{0}^{T} \varphi_{0, T}(t) d t=\sqrt{T}, \int_{0}^{T} \varphi_{j, T}(t) d t=0 \quad \text { for } \quad j \neq 0
$$

(2) For either $T$ fixed but large enough, or $T$ tending to infinity, we estimate $g$ on $\mathbb{R}^{+}$. We define the collection of subspaces of $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$, generated by the orthonormal Laguerre basis (see Section 7.1):

\begin{equation*}
\ell_{j}(t)=\sqrt{2} L_{j}(2 t) e^{-t} \mathbf{1}_{t \geq 0}, \quad j \geq 0, \quad L_{j}(t)=\sum_{k=0}^{j}(-1)^{k}\binom{j}{k} \frac{t^{k}}{k!} \tag{5}
\end{equation*}
$$

We set $S_{m}^{L a g}=\operatorname{span}\left\{\ell_{j}, j=0, \ldots, m-1\right\}$, and the following holds

$$
\forall t \geq 0, \quad \sum_{j=0}^{m-1} \ell_{j}^{2}(t) \leq 2 m, \quad \text { and } \quad \int_{0}^{+\infty} \ell_{j}(t) d t=\sqrt{2}(-1)^{j} .
$$

3.1. Estimation of $g=a^{2}$ when $(X(t))_{t \geq 0}$ is a semimartingale. Here, we assume:
[H4] $a(t)$ belongs to $C^{1}([0,+\infty))$.
Lemma 1. Assume [H1], [H3](1) and [H4]. Denoting by $\theta_{j}=\left\langle g, \varphi_{j}\right\rangle$, we have

$$
\mathbb{E}\left(\int_{0}^{+\infty} \varphi_{j}(s) X\left(s_{-}\right) d X(s)\right)=\frac{1}{2}\left(\theta_{j}-g(0) \int_{0}^{+\infty} \varphi_{j}(s) d s\right), \quad \mathbb{E}\left(\sum_{s \leq T}[\Delta X(s)]^{2}\right)=T g(0) .
$$

Relying on this lemma, we can set:

$$
\begin{equation*}
\widehat{\theta}_{j}=\widehat{\theta}_{j}(N, T)=2\left[\frac{1}{N} \sum_{i=1}^{N}\left(\int_{0}^{T} \varphi_{j}(s) X_{i}\left(s_{-}\right) d X_{i}(s)\right)\right]+(g(0))^{\dagger} \int_{0}^{T} \varphi_{j}(s) d s \tag{6}
\end{equation*}
$$

where $(g(0))^{\dagger}$ is an estimator of $g(0)$ equal to

$$
\begin{equation*}
(g(0))^{\dagger}=\frac{1}{T} \frac{1}{N} \sum_{i=1}^{N} \sum_{s \leq T}\left(\Delta X_{i}(s)\right)^{2} \tag{7}
\end{equation*}
$$

The projection estimator of $g$ on a fixed space $S_{m}$ is given by:

$$
\widehat{g}_{m}=\sum_{j=0}^{m-1} \widehat{\theta}_{j} \varphi_{j} .
$$

Remark 1. By the Ito formula with jumps, we have:

$$
\begin{equation*}
-\int_{(0, T]} X^{2}(s) \varphi_{j}^{\prime}(s) d s=2 \int_{(0, T]} \varphi_{j}(s) X\left(s_{-}\right) d X(s)+\sum_{0<s \leq T} \varphi_{j}(s)(\Delta X(s))^{2}-\varphi_{j}(T) X_{T}^{2} \tag{8}
\end{equation*}
$$

where:

$$
\mathbb{E} \sum_{0<s \leq t} \varphi_{j}(s)(\Delta X(s))^{2}=a^{2}(0) \mathbb{E} \sum_{0<s \leq T} \varphi_{j}(s)(\Delta Z(s))^{2}=a^{2}(0) \int_{0}^{T} \varphi_{j}(s) d s
$$

This formula is useful to understand the link between $\widehat{\theta}_{j}$ defined above and $\widetilde{\theta}_{j}$ defined in the second strategy below, but it only holds under [H4] (which is not assumed in the second case).

The following proposition gives bounds for the $\mathbb{L}^{2}$-risk of $\widehat{g}_{m}$ in the case of fixed $T$ and the trigonometric basis.
Proposition 2. Assume [H1], [H3](1), [H3](2) and $[\mathrm{H} 4]$. When $\left(\varphi_{j}=\varphi_{j, T}\right)$ is the trigonometric basis,

$$
\begin{align*}
\mathbb{E}\left(\left\|\widehat{g}_{m}-g\right\|_{T}^{2}\right) \leq & \left\|g_{m}-g\right\|_{T}^{2}+16 g(0) G(T) \frac{m}{N}+8 \mathfrak{C}_{1, T} \frac{T}{N}+2 g^{2}(0) \frac{k_{4}}{N}  \tag{9}\\
\text { where } & \mathfrak{C}_{1, T}:=3\left(G^{2}(T)+G_{1}^{2}(T)\right)+k_{4}\left(\|g\|_{T}^{2}+\left\|g_{1}\right\|_{T}^{2}\right)
\end{align*}
$$

where $k_{4}=\int x^{4} n(x) d x, g_{1}=\left(a^{\prime}\right)^{2}, G_{1}()=.\int_{0} g_{1}(s) d s$. Recall that $G$ is defined in (3), that $g_{m}$ denotes the orthogonal projection of $g$ on $S_{m}^{T r i g}$ and that $\|u\|_{T}^{2}=\int_{0}^{T} u^{2}(s) d s$.

Now, we give risk-bounds in case of an orthonormal basis of $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$and a special inequality for the Laguerre basis.

Proposition 3. Assume $[\mathrm{H} 1],[\mathrm{H} 3](1),[\mathrm{H} 3](2)$ and $[\mathrm{H} 4]$ and that $\left\|g_{1}\right\|<+\infty$. If $\left(\varphi_{j}\right)$ is an orthonormal basis of $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$, for all $T \geq 1, N \geq 1, m \geq 0$, we have

$$
\begin{align*}
\mathbb{E}\left(\left\|\widehat{g}_{m}-g\right\|^{2}\right) \leq & \left\|g_{m}-g\right\|^{2}+16 g(0) G(T) \frac{m}{N}+8 \mathfrak{C}_{2, T} \frac{T}{N}+2 g^{2}(0) \frac{k_{4}}{N}+\int_{T}^{+\infty} g^{2}(s) d s  \tag{10}\\
\text { where } & \left.\mathfrak{C}_{2, T}:=3\left(G^{2}(T)+G_{1}^{2}(T)\right)+k_{4}\left(\|g\|^{2}+\left\|g_{1}\right\|^{2}\right)\right]
\end{align*}
$$

If $\left(\varphi_{j}\right)$ is the Laguerre basis of $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$and $T \geq 6 m-3$, then

$$
\begin{array}{r}
\mathbb{E}\left(\left\|\widehat{g}_{m}-g\right\|^{2}\right) \leq\left\|g_{m}-g\right\|^{2}+8 C \mathfrak{C}_{2, T} \frac{m^{2}}{N}+16 g(0) G(T) \frac{m}{N}+\frac{2}{N} k_{4} g^{2}(0)  \tag{11}\\
+C^{\prime}\|a\|^{2} m \exp \left(-12 \gamma_{2} m\right)
\end{array}
$$

where $C, C^{\prime}$ and $\gamma_{2}$ are positive constants depending on the basis only.
The bounds obtained in Propositions 2 and 3 contain three types of terms: the first one is the usual squared bias term $\left\|g_{m}-g\right\|^{2}$ due to the projection method, decreasing when $m$ increases, the second one is the variance term, increasing with $m$, and the last ones are residuals.

Let us comment (9) and (10). If $g(0) \neq 0$, the variance order in both cases is $m / N$. For choosing $m$, a compromise must be done between the first two terms. If $g(0)=0$, the variance term vanishes, and $m$ must be chosen as large as possible. Note that this case corresponds to $(X(t))$ derivable.

The difference between (9) and (10) lies in the additional term $\int_{T}^{+\infty} g^{2}(s) d s$. In (9), $T$ is fixed and the residual term has negligible order $1 / N$. In (10), $T$ must be large enough for the additional term to be small, but not too much because the other residuals terms are of order $T / N$ (see numerical results in Table 1 of Comte and Genon-Catalot (2021)).

The result in (11) is specific to the Laguerre basis with $T \geq 6 m-3$. The variance order $m^{2} / N$ is larger but the residual terms do not depend on $T(G(T)$ is bounded). The choice of $m$ relies on a compromise between $\left\|g-g_{m}\right\|^{2}$ and $m^{2} / N$. We can consider here the case where $T \rightarrow+\infty$ : if, in addition to the condition $\left\|g_{1}\right\|<+\infty$, it holds that $\left.\left(a^{\prime}\right)^{2} \in \mathbb{L}^{1}\left(\mathbb{R}^{+}\right)\right)$, then $\mathfrak{C}_{2, T}$ is bounded independently of $T$.
3.2. Estimation of $g=a^{2}$ when $(X(t))$ is not a semi-martingale. In this section, we assume that the basis functions are differentiable on their support. The following Lemma allows to define another estimator.

Lemma 2. Assume that $[\mathrm{H} 1],[\mathrm{H} 3](1)$ hold and that $\left(\varphi_{j}\right)_{j}$ is differentiable on $[0, T]$, then

$$
\mathbb{E}\left(\int_{0}^{T} \varphi_{j}^{\prime}(s) X^{2}(s) d s\right)=\varphi_{j}(T) G(T)-\int_{0}^{T} g(u) \varphi_{j}(u) d u .
$$

Therefore, we can set

$$
\begin{equation*}
\widetilde{\theta}_{j}=-\frac{1}{N} \sum_{i=1}^{N}\left(\int_{0}^{T} \varphi_{j}^{\prime}(s) X_{i}^{2}(s) d s\right)+\varphi_{j}(T) \widehat{G}(T) \quad \text { and } \quad \widehat{G}(T)=\frac{1}{N} \sum_{i=1}^{N} X_{i}^{2}(T) \tag{12}
\end{equation*}
$$

If $\varphi_{j}=\varphi_{j, T}$ is the trigonometric basis, then $\varphi_{0, T}(T)=1 / \sqrt{T}, \varphi_{2 j-1, T}(T)=\sqrt{2 / T}, \varphi_{2 j, T}(T)=0$, $j \geq 1$. Then we define the estimator by

$$
\widetilde{g}_{m}=\sum_{j=0}^{m-1} \widetilde{\theta}_{j} \varphi_{j} .
$$

We introduce the assumption:
[H5] $\int_{0}^{1} \frac{\|g\|_{s}^{2}}{s} d s=c_{0}<+\infty$, where we recall that $\|g\|_{s}^{2}=\int_{0}^{s} g^{2}(s) d s$.
Proposition 4. Assume $[\mathrm{H} 1]$ and $[\mathrm{H} 3](2)$.

- If $\left(\varphi_{j}=\varphi_{j, T}\right)$ the trigonometric basis, then

$$
\begin{equation*}
\mathbb{E}\left(\left\|\widetilde{g}_{m}-g\right\|_{T}^{2}\right) \leq\left\|g_{m}-g\right\|_{T}^{2}+\frac{2}{N}\left(3 G^{2}(T)+k_{4}\|g\|_{T}^{2}\right)\left(\frac{4 \pi^{2} m^{2}}{T}+\frac{m}{T}\right) . \tag{13}
\end{equation*}
$$

- Let $\left(\varphi_{j}=\ell_{j}\right)$ be the Laguerre basis.
- Then, for all $T \geq 1, N \geq 1, m \geq 0$,

$$
\begin{array}{r}
\mathbb{E}\left(\left\|\widetilde{g}_{m}-g\right\|^{2}\right) \leq\left\|g_{m}-g\right\|^{2}+4 \mathfrak{C}_{3, T} \frac{m}{N}+4 \frac{T}{N}\left(3 G^{2}(T)+k_{4}\|g\|_{T}^{2}\right)+\int_{T}^{\infty} g^{2}(s) d s \\
\text { with } \quad \mathfrak{C}_{3, T}:=\left[3 G^{2}(T)+k_{4}\|g\|_{T}^{2}+2\left(\int_{0}^{T} s^{-1}\left[3 G^{2}(s)+k_{4}\|g\|_{s}^{2}\right] d s\right)\right]
\end{array}
$$

where, if, in addition, [H5] holds,

$$
\begin{gather*}
\left(\int_{0}^{T} s^{-1}\left[3 G^{2}(s)+k_{4}\|g\|_{s}^{2}\right] d s\right) \leq\left(3+k_{4}\right)\left(c_{0}+\log (T)\|g\|_{T}^{2}\right) \\
- \text { If } T \geq 6(m-1)+3=6 m-3 \text { and }\left(\varphi_{j}\right) \text { is the Laguerre basis, then } \\
\mathbb{E}\left(\left\|\widetilde{g}_{m}-g\right\|^{2}\right) \leq\left\|g_{m}-g\right\|^{2}+c_{1}\left(3 G^{2}(T)+k_{4}\|g\|_{T}^{2}\right) \frac{m^{3}}{N}+c_{2}\|a\|^{2} \frac{m}{N} \exp \left(-12 \gamma_{2} m\right) \tag{14}
\end{gather*}
$$

where $c_{1}, c_{2}, \gamma_{2}$ are constants depending on the basis only.
Comments on the bounds obtained in Proposition 4 are similar to the comments given after Proposition 2 and 3. Inequality (13) can be compared to (9), and we mainly notice that the variance term increases from $m / N$ to $m^{2} / N$; Inequality (14) corresponds to (11) with variance increase from $m^{2} / N$ to $m^{3} / N$. These losses are due to the more general assumptions. In Inequality (14), we can consider $T \rightarrow+\infty$.

Moreover, we refer to Section 3 of Comte and Genon-Catalot (2021) for a discussion on rates of convergence that can be deduced from Propositions 2, 3 and 4, on dedicated function spaces: periodic Fourier-Sobolev spaces for the trigonometric basis and on Sobolev-Laguerre spaces for the Laguerre basis.

## 4. Adaptation

Considering the main terms of all risk bounds, we can see that a compromise must be done between the squared bias terms which decrease when $m$ increases while the variance terms increase. In this section, we describe a procedure allowing for a data driven selection of $m$, and we prove that the final estimator reaches an effective tradeoff, in term of its integrated $\mathbb{L}^{2}$-risk bound.

Let $\mathcal{M}_{N}=\left\{m \in \mathbb{N}, m^{2} \leq N T\right\}$ be a collection of models such that the variance of $\widetilde{g}_{m}$ is bounded and set

$$
\widetilde{m}=\arg \min _{m \in \mathcal{M}_{N}}\left\{-\left\|\widetilde{g}_{m}\right\|^{2}+\operatorname{pen}(m)\right\}
$$

where, for a constant $\kappa$ precised below,

$$
\operatorname{pen}(m)=\kappa \log N \frac{m^{2}}{N T} \mathbb{E} X^{4}(T)
$$

Theorem 1. Assume $N \geq 3$, [H1], [H2](4) and [H3](4). Then, there exists a numerical constant $\kappa_{0}$ such that, for all $\kappa \geq \kappa_{0}$, the following holds:

\mathbb{E}\left\|\widetilde{g}_{\widetilde{m}}-g\right\|^{2} \leq \inf _{m \in \mathcal{M}_{N}}\left(3\left\|g_{m}-g\right\|^{2}+4 \operatorname{pen}(m)\right)+C \frac{\log N}{N}
$$

The infimum in the risk bound implies that the $\mathbb{L}^{2}$-risk of $\widetilde{g}_{\widetilde{m}}$ achieves automatically the best compromise between the square bias term and the variance term.

In practice, we replace the unknown term $\mathbb{E} X^{4}(T)$ in the penalty by its empirical estimator $N^{-1} \sum_{i=1}^{N} X_{i}^{4}(T)$. Theorem 1 can be extended to this substitution. For the implementation, the constant $\kappa$ must be fixed. It is standard that the numerical value for $\kappa_{0}$ given in the proof is too large. This is why it must rather be calibrated by preliminary simulation experiments; this is done in Section 5 of Comte and Genon-Catalot (2021), for $Z$ a Brownian motion. More generally, results on simulated data are given in the latter paper especially for examples where $a(t)=t^{d} \exp (-\alpha t)$ with various values of $d$. It is worth noting that our assumptions [H3](2) and [H5] hold if $d>-1 / 4$.

## 5. Concluding Remarks

In this paper, we study the nonparametric estimation of $a^{2}$ from i.i.d. observations $\left(X_{i}(t), t \in\right.$ $[0, T]), i=1, \ldots, N)$ distributed as (1). We proceed by projection method on finite dimensional subspaces of $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$. Two different types of estimators are proposed depending on whether $(X(t))_{t \geq 0}$ is a semi-martingale or not and a data-driven procedure is proposed for the most general type of estimators. In our previous paper (where $Z=W$ a Wiener process, Comte and Genon-Catalot (2021)), proofs relied strongly on the Gaussian character of $(X(t))$. The extension to the Lévy case is not straightforward and relies on the general deviation inequality given in the Appendix.
From the theoretical and practical points of view, the estimation using discretized data would be worth of investigation together with the questions of optimality of our estimators.

## 6. PROOFS

### 6.1. Proof of the existence of (2).

where $\gamma=-\int_{\mathbb{R}} x \mathbf{1}_{|x|>1} n(x) d x$ and $\mathbb{E} Z(1)=0=\gamma+\int_{\mathbb{R}} x \mathbf{1}_{|x|>1} n(x) d x$. According to Rajput and Rosiński (1989) (Theorem 2.7), see also Basse and Pedersen (2009), the existence of (2) is ensured if and only if, for all $t$, the following conditions hold:

= & \int_{0}^{t}|a(s) \mathbb{E} Z(1)| d s+\int_{0}^{t}\left|x a(s)\left(\mathbf{1}_{|x a(s)| \leq 1}-1\right)\right| n(x) d x d s \\
= & \int_{0}^{t}\left|x a(s)\left(\mathbf{1}_{|x a(s)|>1}\right)\right| n(x) d x d s \leq \int_{0}^{+\infty} a^{2}(s) d s \int_{\mathbb{R}} x^{2} n(x) d x .
\end{aligned}
$$

6.2. Proof of Proposition 1. In Basse and Pedersen (2009) (Theorem 3.1), it is proved that, if $(Z(t))$ is of unbounded variation, $(X(t))$ is an $\left(\mathcal{F}_{t}^{Z}\right)_{t \geq 0}$-semimartingale if and only if $a(t)$ is absolutely continuous on $\mathbb{R}^{+}$with a density $a^{\prime}$ satisfying, for all $t \geq 0$ :

So (15) holds. If $(Z(t))$ is of bounded variation (which is equivalent to $\left.\int|x| n(x) d x<\infty\right),(X(t))$ is an $\left(\mathcal{F}_{t}^{Z}\right)_{t \geq 0}$-semimartingale if and only if it is of bounded variation which is equivalent to $a$ is of bounded variation.
If $(Z(t))$ is of unbounded variation and $(X(t))$ is an $\left(\mathcal{F}_{t}^{Z}\right)_{t \geq 0}$-semimartingale, it can be decomposed as :

\end{aligned}

As

\mathbb{E}\left(\int_{0}^{+\infty} \varphi_{j}(s) X\left(s_{-}\right) d Z(s)\right)^{2} & =\int_{0}^{+\infty} \varphi_{j}^{2}(s) \mathbb{E} X^{2}(s) d s \times \int_{\mathbb{R}} x^{2} n(x) d x \\
& =\int_{0}^{+\infty} \varphi_{j}^{2}(s) G(s) d s \leq\|a\|^{2}<+\infty
\end{aligned}
$$

$\mathbb{E} \int_{0}^{+\infty} \varphi_{j}(s) X\left(s_{-}\right) d Z(s)=0$ and the first equality follows by:

Using [H3](1) and (4), as $\Delta X(s)=a(0) \Delta Z(s)$,

6.4. Proof of Proposition 2. Note that for functions on $S_{m, T}$, the norms $\|.\|_{T}$ and $\|$.$\| are$ identical.

When $\left(\varphi_{j}\right)=\left(\varphi_{j, T}\right)$ is the trigonometric basis on $[0, T], \widehat{\theta}_{j}$ is an unbiased estimator of $\theta_{j}$. This implies $\mathbb{E}\left\|\widehat{g}_{m}-g\right\|_{T}^{2}=\mathbb{E}\left\|\widehat{g}_{m}-\mathbb{E} \widehat{g}_{m}\right\|^{2}+\left\|g_{m}-g\right\|_{T}^{2}$. We have, setting $X=X_{1}$, and using that $\sum_{j=0}^{m-1}\left(\int_{0}^{T} \varphi_{j}(s) d s\right)^{2} \leq T$,

\mathbb{E}\left\|\widehat{g}_{m}-\mathbb{E} \widehat{g}_{m}\right\|^{2} & \leq \frac{2}{N} \sum_{j=0}^{m-1} \operatorname{Var}\left(2 \int_{0}^{T} \varphi_{j}(s) X\left(s_{-}\right) d X(s)\right)+\frac{2 T}{N} \operatorname{Var}\left(\frac{1}{T} \sum_{s \leq T}(\Delta X(s))^{2}\right) \\
& \leq \frac{2}{N} \sum_{j=0}^{m-1} \mathbb{E}\left(2 \int_{0}^{T} \varphi_{j}(s) X\left(s_{-}\right) d X(s)\right)^{2}+\frac{2 T}{N} \operatorname{Var}\left(\frac{1}{T} \sum_{s \leq T}(\Delta X(s))^{2}\right)
\end{aligned}
$$

We have:

\left(\int_{0}^{T} \varphi_{j}(s) X\left(s_{-}\right) d X(s)\right)^{2} \leq 2 g(0)\left(\int_{0}^{T} \varphi_{j}(s) X\left(s_{-}\right) d Z(s)\right)^{2}+2\left(\int_{0}^{T} \varphi_{j}(s) X(s) Y(s) d s\right)^{2}
$$

where $Y(s)=\int_{0}^{s} a^{\prime}(s-u) d Z(u)$. Next,

\mathbb{E}\left(\int_{0}^{T} \varphi_{j}(s) X\left(s_{-}\right) d Z(s)\right)^{2}=\int_{0}^{T} \varphi_{j}^{2}(s) \mathbb{E}\left(X^{2}(s)\right) d s \leq G(T)

Since $\left(\varphi_{j}\right)=\left(\varphi_{j, T}\right)$ is an orthonormal basis of $\mathbb{L}^{2}([0, T])$,

We use that $x^{2} y^{2} \leq\left(x^{4}+y^{4}\right) / 2$ and (see section 7.3)

\mathbb{E} X^{4}(s) & =3\left(\int_{0}^{s} a^{2}(u) d u\right)^{2}+\int_{0}^{s} a^{4}(u) d u \int x^{4} n(x) d x \\
& =3 G^{2}(s)+k_{4} \int_{0}^{s} a^{4}(u) d u \tag{16}
\end{align*}

Analogously, setting $G_{1}(s)=\int_{0}^{s}\left(a^{\prime}\right)^{2}(u) d u$, we obtain:

It remains to study $\mathbb{E}\left(\frac{1}{T} \sum_{s \leq T}(\Delta X(s))^{2}\right)^{2}=T^{-2} a^{4}(0) \mathbb{E}\left(\sum_{s \leq T}(\Delta Z(s))^{2}\right)^{2}$. By the exponential formula (see e.g. Revuz and Yor, 1999, Chap. XII, Prop. 1.12),

Consider a basis $\left(\varphi_{j}\right)$ of $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$with arbitrary support. We have $\mathbb{E} \widehat{\theta}_{j}=\theta_{j}-\int_{T}^{+\infty} g(s) \varphi_{j}(s) d s$ so that $\widehat{g}_{m}-g=\widehat{g}_{m}-\mathbb{E} \widehat{g}_{m}+\mathbb{E} \widehat{g}_{m}-g_{m}+g_{m}-g$ and this implies

The first term is the usual bias term due to the projection method. The middle term is a variance term which can be treated as in the previous proposition. The last term is an additional bias term, due to the truncation of the integrals. We have:

If $\left(\varphi_{j}\right)$ is the Laguerre basis, we bound the variance term $\mathbb{E}\left\|\widehat{g}_{m}-\mathbb{E} \widehat{g}_{m}\right\|^{2}$ and the additional bias term $\left\|\mathbb{E} \widehat{g}_{m}-g_{m}\right\|^{2}$ differently. For the variance term, we write:

& \left.=\left(\int_{0}^{T}\left|\varphi_{j}(s)\right|\left\{\mathbb{E}\left[(X(s) Y(s))^{2}\right)\right]\right\}^{1 / 2} d s\right)^{2}
\end{aligned}
$$

We use the following bound proved in section 6.4:

There remains to bound $\int_{0}^{T}\left|\varphi_{j}(s)\right| d s$. This is done in [12], see Formula (31)-(32). For $j=$ $0, \ldots, m-1$ and $T \geq 6(m-1)+3=6 m-3$, we have

where $\gamma_{2}$ is a constant depending on the Laguerre basis only, see Section 7. Therefore, the proof of Proposition 3 is complete.

\end{aligned}
$$

which is the result.
6.7. Proof of Proposition 4. Assume that $\left(\varphi_{j}=\varphi_{j, T}\right)$ is the trigonometric basis. Then, $\widetilde{\theta}_{j}$ is an unbiased estimator of $\theta_{j}$. We only need to study the variance term of the risk.

$$

where $\mathbb{E} X^{4}(T)=3\left(G^{2}(T)+k_{4}\|g\|_{T}^{2}\right)$ and $\sum_{j=0}^{m-1} \varphi_{j}^{2}(T)=m / T$. We have

\varphi_{0, T}^{\prime}(s)=0, \quad \varphi_{2 j, T}^{\prime}(s)=(2 \pi j / T) \varphi_{2 j-1, T}(s), \quad \varphi_{2 j-1, T}^{\prime}(s)=-(2 \pi j / T) \varphi_{2 j, T}(s), \quad j \geq 1 \tag{22}
\end{equation*}

Using that $\left(\varphi_{j, T}\right)$ is an orthonormal basis, we obtain, as $\mathbb{E} X^{4}(s) \leq \mathbb{E} X^{4}(T)$ (see (16)),

This gives (13).
Now, assume that $\left(\varphi_{j}=\ell_{j}\right)$ is the Laguerre basis on $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$(see Section 7 ). We still have:

First,

\mathbb{E}\left\|\widetilde{g}_{m}-\mathbb{E} \tilde{g}_{m}\right\|^{2} & =\frac{1}{N} \sum_{j=0}^{m-1} \operatorname{Var}\left(\int_{0}^{T} \ell_{j}^{\prime}(s) X_{1}^{2}(s) d s-X_{1}^{2}(T) \ell_{j}(T)\right) \\
& \leq \frac{2}{N} \sum_{j=0}^{m-1} \mathbb{E}\left[\left(\int_{0}^{T} \ell_{j}^{\prime}(s) X_{1}^{2}(s) d s\right)^{2}\right]+\frac{2}{N} \sum_{j=0}^{m-1} \ell_{j}^{2}(T) \mathbb{E}\left[X_{1}^{4}(T)\right]:=\mathbb{T}_{1}+\mathbb{T}_{2} .
\end{aligned}
$$

Using that $\left|\ell_{j}\right| \leq \sqrt{2}$, we get

Next, we use that the Laguerre basis satisfies $\ell_{0}^{\prime}(x)=-\ell_{0}(x)$ and $\ell_{j}^{\prime}(x)=-\ell_{j}(x)-\sqrt{2 j / x} \ell_{j-1}^{(1)}(x)$ for $j \geq 1$ where ( $\ell_{k}^{(1)}(x), k \geq 0$ ) is the Laguerre basis with index 1 (see section 7) to find

& \leq \frac{4}{N} \mathbb{E}\left(\int_{0}^{T} X_{1}^{4}(s) d s\right)+\frac{8 m}{N} \mathbb{E}\left(\int_{0}^{T} \frac{X_{1}^{4}(s)}{s} d s\right) \\
& \leq \frac{4}{N} T\left(3 G^{2}(T)+k_{4}\|g\|_{T}^{2}\right)+\frac{8 m}{N}\left(3 \int_{0}^{T} s^{-1}\left[G^{2}(s)+k_{4}\|g\|_{s}^{2}\right] d s\right)
\end{aligned}
$$

where we have used (16). Finally, the variance term is bounded by

$$
\begin{aligned}
\mathbb{E}\left\|\widetilde{g}_{m}-\mathbb{E} \tilde{g}_{m}\right\|^{2} \leq & \frac{4}{N} T\left(3 G^{2}(T)+k_{4}\|g\|_{T}^{2}\right)+\frac{8 m}{N}\left(3 \int_{0}^{T} s^{-1}\left[G^{2}(s)+k_{4}\|g\|_{s}^{2}\right] d s\right) \\
& \left.+\frac{4 m}{N}\left(3 G^{2}(T)+k_{4}\|g\|_{T}^{2}\right)\right) .
\end{aligned}
$$

Using [H5] and writing $\int_{0}^{T} \cdots=\int_{0}^{1} \cdots+\int_{1}^{T} \cdots$, we get

3 \int_{0}^{T} s^{-1}\left[G^{2}(s)+k_{4}\|g\|_{s}^{2}\right] d s \leq\left(3+k_{4}\right)\left(c_{0}+\log (T)\|g\|_{T}^{2}\right)

If [H5] does not hold and $T \geq 6 m-3$, we can bound differently the variance and bias terms. Proceeding as in [12], proof of Proposition 3, we have

Still using [12], we have

\left(\int_{0}^{T}\left[\sum_{j=0}^{m-1}\left(\ell_{j}^{\prime}(s)\right)^{2}\right]^{1 / 2} d s\right)^{2} \leq 12 m^{3}+\frac{4 m^{3}}{\gamma_{2}^{2}} \exp \left(-(12 m-6) \gamma_{2}\right)
$$

Finally, we get

\mathbb{E}\left\|\tilde{g}_{m}-\mathbb{E} \tilde{g}_{m}\right\|^{2} \leq \frac{1}{N}\left(3 G^{2}(T)+k_{4}\|g\|_{T}^{2}\right)\left(12 m^{3}+\frac{4 m^{3}}{\gamma_{2}^{2}} \exp \left(-(12 m-6) \gamma_{2}\right)\right) \tag{23}
\end{equation*}
$$

So, we have the two variance bounds.
Next, we have $\mathbb{E} \widetilde{\theta}_{j}=\theta_{j}-\ell_{j}(T) G(T)-\int_{T}^{+\infty} \ell_{j}(s) g(s) d s$. Therefore

\left\|\mathbb{E} \widetilde{g}_{m}-g_{m}\right\|^{2} & =\sum_{j=0}^{m-1}\left[\mathbb{E}\left(\widetilde{\theta}_{j}\right)-\theta_{j}\right]^{2}=\sum_{j=0}^{m-1}\left(\ell_{j}(T) G(T)+\int_{T}^{+\infty} \ell_{j}(s) g(s) d s\right)^{2} \\
& \leq 2 G^{2}(T) \sum_{j=0}^{m-1} \ell_{j}^{2}(T)+2 \sum_{j=0}^{m-1}\left(\int_{T}^{+\infty} \ell_{j}(s) g(s) d s\right)^{2} \\
& \lesssim\|a\|^{2} m \exp \left(-12 \gamma_{2} m\right)+\|a\|^{2} m \exp \left(12 \gamma_{2} m\right)
\end{aligned}
$$

Indeed $\ell_{j}(T) \lesssim \exp \left(-12 \gamma_{2} m\right)$ for $T \geq 6 m-3$ (first term) and we use (21) (second term). For both, we use $G(T) \leq G(+\infty)=\|a\|^{2}$.
6.8. Proof of Theorem 1. Note that, as $G(0)=0,\langle h, g\rangle_{T}=h(T) G(T)-\left\langle h^{\prime}, G\right\rangle_{T}$. Let us set:

$$

where

\begin{equation*}
\nu_{N, T}(h)=-\frac{1}{N} \sum_{i=1}^{N} \int_{0}^{T} h^{\prime}(u)\left[X_{i}^{2}(u)-G(u)\right] d u, \quad \mu_{N, T}(h)=\frac{1}{N} \sum_{i=1}^{N} h(T)\left(X_{i}^{2}(T)-G(T)\right) . \tag{24}
\end{equation*}
$$

Therefore,

\gamma_{N, T}\left(h_{1}\right)-\gamma_{N, T}\left(h_{2}\right)=\left\|h_{1}-g\right\|^{2}-\left\|h_{2}-g\right\|^{2}-2 \nu_{N, T}\left(h_{1}-h_{2}\right)-2 \mu_{N, T}\left(h_{1}-h_{2}\right)
$$

Using the definition of $\tilde{m}$, we have for all $g_{m} \in S_{m}$,

\gamma_{N, T}\left(\tilde{g}_{\tilde{m}}\right)+\operatorname{pen}(\widetilde{m}) \leq \gamma_{N, T}\left(\widetilde{g}_{m}\right)+\operatorname{pen}(m) .
$$

We deduce, for $\xi_{N, T}=\nu_{N, T}+\mu_{N, T}$,

\left\|\widetilde{g}_{\widetilde{m}}-g\right\|^{2} \leq\left\|g_{m}-g\right\|^{2}+2 \xi_{N, T}\left(\widetilde{g}_{\widetilde{m}}-g_{m}\right)+\operatorname{pen}(m)-\operatorname{pen}(\widetilde{m})
$$

Let $B_{m}=\left\{h \in S_{m},\|h\| \leq 1\right\}$. We use that

\begin{aligned}
2 \xi_{N, T}\left(\tilde{g}_{\widetilde{m}}-g_{m}\right) & \leq \frac{1}{4}\left\|\tilde{g}_{\tilde{m}}-g_{m}\right\|^{2}+4 \sup _{h \in B_{\tilde{m} \vee m}} \xi_{N, T}^{2}(h) \\
& \leq \frac{1}{2}\left(\left\|\tilde{g}_{\widetilde{m}}-g\right\|^{2}+\left\|g-g_{m}\right\|^{2}\right)+4 \sup _{h \in B_{\tilde{m} \vee m}} \xi_{N, T}^{2}(h) \\
& \leq \frac{1}{2}\left(\left\|\tilde{g}_{\widetilde{m}}-g\right\|^{2}+\left\|g-g_{m}\right\|^{2}\right)+8 \sup _{h \in B_{\tilde{m} \vee m}}\left(\nu_{N, T}^{2}(h)+\mu_{N, T}^{2}(h)\right)
\end{aligned}
$$

Recall that $\mathbb{E}\left[X_{i}^{2}(u)\right]=G(u)$. For $\theta$ a constant to be chosen below, we can split $\nu_{N, T}(h)$ into:

& \nu_{N, T, \theta}^{c}(h)=-\frac{1}{N} \sum_{i=1}^{N} \int_{0}^{T} h^{\prime}(u)\left[X_{i}^{2}(u) \mathbf{1}_{X_{i}^{2}(u)>\theta}-\mathbb{E}\left(X_{i}^{2}(u) \mathbf{1}_{X_{i}^{2}(u)>\theta}\right)\right] d u \tag{26}
\end{align*}
$$

Analogously, we define $\mu_{N, T, \theta}(h)$ and $\mu_{N, T, \theta}^{c}(h)$, by splitting $\mu_{N, T}(h)$.
Introducing quantities $p_{1}\left(m, m^{\prime}\right)$ and $p_{2}\left(m, m^{\prime}\right)$ to be determined below, we write:

\frac{1}{2}\left\|\tilde{g}_{\widetilde{m}}-g\right\|^{2} \leq & \frac{3}{2}\left\|g_{m}-g\right\|^{2}+16 \sup _{h \in B_{\tilde{m} \vee m}}\left[\nu_{N, T, \theta}^{c}(h)\right]^{2}+16 \sup _{h \in B_{\widetilde{m} \vee m}}\left[\mu_{N, T, \theta}^{c}(h)\right]^{2} \\
& +\operatorname{pen}(m)-\operatorname{pen}(\widetilde{m}) \\
& +16 p_{1}(m, \widetilde{m})+16\left(\sup _{h \in B_{\tilde{m} \vee m}} \nu_{N, T, \theta}^{2}(h)-p_{1}(m, \widetilde{m})\right) \\
& +16 p_{2}(m, \widetilde{m})+16\left(\sup _{h \in B_{\tilde{m} \vee m}} \mu_{N, T, \theta}^{2}(h)-p_{2}(m, \widetilde{m})\right)
\end{aligned}
$$

Below, $p_{1}\left(m, m^{\prime}\right)$ and $p_{2}\left(m, m^{\prime}\right)$ are chosen such that, for $\kappa$ greater than a well chosen constant $\kappa_{0}$, for all $m, m^{\prime}, 16\left(p_{1}\left(m, m^{\prime}\right)+p_{2}\left(m, m^{\prime}\right)\right) \leq \operatorname{pen}(m)+\operatorname{pen}\left(m^{\prime}\right)$ implying that

16\left(p_{1}(m, \widetilde{m})+p_{2}(m, \widetilde{m})\right)+\operatorname{pen}(m)-\operatorname{pen}(\widetilde{m}) \leq 2 \operatorname{pen}(m) .

And we bound the expectation of the other terms.
Lemma 3. Under Assumptions [H1], [H2](2+p) and $[\mathrm{H} 3](2+p)$, we have:

& \mathbb{E}\left(\sup _{h \in S_{m},\|h\| \leq 1}\left[\mu_{N, T, \theta}^{c}(h)\right]^{2}\right) \leq \frac{m}{N T} \frac{1}{\theta^{p}}\left(G^{2+p}(T)+k_{4+2 p} \int_{0}^{T} a^{4+2 p}(u) d u\right) .
\end{aligned}
$$

Now, we choose $p=2$ and $\theta=\mathfrak{c} \sqrt{N} / \sqrt{\log (N)}$ where $\mathfrak{c}$ is precised below. As for all $m \in \mathcal{M}_{N}$, $m^{2} \leq N T$, we set $M_{N}=[\sqrt{N T}]$ the largest dimension of the collection, and we have

\end{equation*}

Lemma 4. Under $[\mathrm{H} 1]$, $[\mathrm{H} 2]$ (4) and $[\mathrm{H} 3](4)$, choosing $\theta=\mathfrak{c} \sqrt{N} / \sqrt{\log (N)}, \mathfrak{c}=c \mathbb{E}^{1 / 2}\left[X^{4}(T)\right]$, $c=\sqrt{2} / 21$, we have for

& p_{1}\left(m, m^{\prime}\right)=2(1+18 \log (N)) \mathbb{E}\left(X^{4}(T)\right) \frac{4 \pi^{2}\left(m \vee m^{\prime}\right)^{2}}{N T}, \\
& p_{2}\left(m, m^{\prime}\right)=2(1+18 \log (N)) \mathbb{E}\left(X^{4}(T)\right) \frac{m \vee m^{\prime}}{N T}, \\
& \mathbb{E}\left[\left(\sup _{h \in B_{\widetilde{m} \vee m}} \nu_{N, T, \theta}^{2}(h)-p_{1}(m, \widetilde{m})\right)_{+}\right] \lesssim \frac{1}{N}, \quad \mathbb{E}\left[\left(\sup _{h \in B_{\widetilde{m} \vee m}} \mu_{N, T, \theta}^{2}(h)-p_{2}(m, \widetilde{m})\right)_{+}\right] \lesssim \frac{1}{N} .
\end{aligned}
$$

Therefore, using (27) and Lemma 4, we can conclude that for $\kappa \geq \kappa_{0}=16 \times 2 \times 19 \times 8 \pi^{2}$, $\operatorname{pen}(m)-\operatorname{pen}(\widetilde{m})+16\left(p_{1}(m, \widetilde{m})+p_{2}(m, \widetilde{m})\right) \leq 2 \operatorname{pen}(m)$, we obtain

& \leq \frac{1}{N} \sum_{j=0}^{m-1} \mathbb{E}\left(\int_{0}^{T} \varphi_{j, T}^{\prime}(u) X_{1}^{2}(u) \mathbf{1}_{X_{1}^{2}(u)>\theta} d u\right)^{2} \\
& \leq \frac{4 \pi^{2} m^{2}}{N T^{2}} \mathbb{E}\left(\int_{0}^{T} X^{4}(u) \mathbf{1}_{X_{1}^{2}(u)>\theta} d u\right),
\end{aligned}
$$

see (22). Then, for all $p \geq 1$, we get

& \leq \frac{4 \pi^{2} m^{2}}{N T} \frac{1}{\theta^{p}}\left(G^{2+p}(T)+k_{4+2 p} \int_{0}^{T} a^{4+2 p}(u) d u\right)
\end{aligned}
$$

where the last bound is obtained by Kunita's Inequality, see Section 7. In the same way, we get

& \leq \frac{1}{N} \sum_{j=0}^{m-1} \mathbb{E}\left[\left(\varphi_{j, T}(T) X^{2}(T) \mathbf{1}_{X_{1}^{2}(T)>\theta}\right)^{2}\right]=\frac{m}{N T} \mathbb{E}\left(X^{4}(T) \mathbf{1}_{X_{1}^{2}(T)>\theta}\right) \\
& \leq \frac{m}{N T} \frac{1}{\theta^{p}}\left(G^{2+p}(T)+k_{4+2 p} \int_{0}^{T} a^{4+2 p}(u) d u\right) .
\end{aligned}
$$

This is the second bound of Lemma 3 and the proof of Lemma 3 is complete.
Proof of Lemma 4. First note that

\sup _{h \in B_{m}}\left[\nu_{N, T, \theta}(h)\right]^{2} & \leq \sum_{j=0}^{m-1}\left[\nu_{N, T, \theta}\left(\varphi_{j, T}\right)\right]^{2}=\frac{1}{N} \sum_{j=0}^{m-1} \operatorname{Var}\left(\int_{0}^{T} \varphi_{j, T}^{\prime}(u) X_{1}^{2}(u) \mathbf{1}_{X_{1}^{2}(u)<\theta} d u\right) \\
& \leq \frac{1}{N} \sum_{j=0}^{m-1} \mathbb{E}\left(\int_{0}^{T} \varphi_{j, T}^{\prime}(u) X_{1}^{2}(u) \mathbf{1}_{X_{1}^{2}(u)<\theta} d u\right)^{2} \leq \frac{4 \pi^{2} m^{2}}{N T} \mathbb{E}\left(X^{4}(T)\right)
\end{aligned}
$$

where $\mathbb{E}\left(X^{4}(T)\right)=3 G^{2}(T)+k_{4} \int_{0}^{T} a^{4}(u) d u$. We set

$$
H^{2}(m)=H^{2}=\frac{4 \pi^{2} m^{2}}{N T} \mathbb{E}\left(X^{4}(T)\right)
$$

Now, we bound

$$
\mathbb{V}:=\sup _{h \in B_{m}} \operatorname{Var}\left(\int_{0}^{T} h^{\prime}(u) X_{1}^{2}(u) \mathbf{1}_{X_{1}^{2}(u)<\theta} d u\right) \leq \sup _{h \in B_{m}} \mathbb{E}\left(\int_{0}^{T} h^{\prime}(u) X_{1}^{2}(u) \mathbf{1}_{X_{1}^{2}(u)<\theta} d u\right)^{2}
$$

Proceeding as previously, we get that the above term is less than

\mathbb{V} \leq \sup _{h \in B_{m}} \int_{0}^{T}\left[h^{\prime}(u)\right]^{2} d u T \mathbb{E}\left[X^{4}(T)\right] \leq \frac{4 \pi^{2} m^{2}}{T^{2}} \mathbb{E}\left[X^{4}(T)\right]:=v^{2}(m)=v^{2}
$$

Therefore, $N H^{2}=v^{2}, N H / M=\sqrt{N} \mathbb{E}^{1 / 2}\left(X^{4}(T)\right) \theta^{-1}$.
First, using the Talagrand inequality with our values of $M\left(m \vee m^{\prime}\right), H\left(m \vee m^{\prime}\right), v^{2}\left(m \vee m^{\prime}\right)$, we bound

\theta=c \mathbb{E}^{1 / 2}\left(X^{4}(T)\right) \frac{\sqrt{N}}{\sqrt{\log (N)}}, \quad \epsilon^{2}=\frac{3}{2} \frac{\log (N)}{K_{1}}=9 \log (N), \quad p_{1}\left(m, m^{\prime}\right)=2\left(1+2 \epsilon^{2}\right) H^{2}\left(m \vee m^{\prime}\right)
$$

Thus,

$$
\frac{v^{2}\left(m \vee m^{\prime}\right)}{N} \exp \left(-K_{1} \epsilon \frac{N H^{2}\left(m \vee m^{\prime}\right)}{v^{2}\left(m \vee m^{\prime}\right)}\right) \lesssim \frac{\left(m \vee m^{\prime}\right)^{2}}{N} e^{-(3 / 2) \log (N)} \lesssim \frac{1}{N^{3 / 2}}
$$

and,

\frac{M^{2}\left(m \vee m^{\prime}\right)}{C^{2}\left(\epsilon^{2}\right) N^{2}} e^{-\frac{2 K_{1} C\left(\epsilon^{2}\right) \epsilon}{7 \sqrt{2}} \frac{N H\left(m \vee m^{\prime}\right)}{M\left(m \vee m^{\prime}\right)}} \lesssim \frac{1}{\log (N)} \exp (-(3 / 2) \log (N)) \lesssim \frac{1}{N^{3 / 2}}
$$

for $C\left(\epsilon^{2}\right)=1$ and $c=\sqrt{2} / 21$. Theorem 2 (Appendix) implies

$$
\sum_{m^{\prime} \in \mathcal{M}_{N}} \mathbb{E}\left[\left(\sup _{h \in S_{m^{\prime}},\|h\|=1} \nu_{N, T, \theta}^{2}(h)-p_{1}\left(m, m^{\prime}\right)\right)_{+}\right] \lesssim \frac{1}{N} .
$$

We proceed analogously to bound $\mathbb{E}\left[\left(\sup _{h \in B_{m \vee m^{\prime}}} \mu_{N, T, \theta}^{2}(h)-p_{2}\left(m, m^{\prime}\right)\right)_{+}\right]$. We set $\mu_{N, T, \theta}(h)=$ $\frac{1}{N} \sum_{i=1}^{N}\left[g_{h}\left(X_{i}\right)-\mathbb{E}\left(g_{h}\left(X_{i}\right)\right)\right]$ where, for $\left.x \in C([0, T]), g_{h}(x)=h(T) x^{2}(T) \mathbf{1}_{x^{2}(T) \leq \theta}\right]$. We have

$$
\sup _{h \in B_{m}, x \in C([0, T])}\left|g_{h}(x)\right| \leq \theta \sup _{h \in B_{m}}|h(T)| \leq \theta\left(\sum_{j=0}^{m-1} \varphi_{j, T}^{2}(T)\right)^{1 / 2}=\theta \sqrt{\frac{m}{T}}:=M(m)
$$

Next,

$$
\mathbb{E}\left[\sup _{h \in B_{m}}\left[\mu_{N, T, \theta}(h)\right]^{2}\right] \leq \frac{1}{N} \sum_{j=0}^{m-1}\left(\varphi_{j, T}(T)\right)^{2} \mathbb{E}\left(X^{4}(T)\right)=\frac{m}{N T} \mathbb{E}\left(X^{4}(T)\right):=H^{2}(m) .
$$

Last

$$
\sup _{h \in B_{m}} \operatorname{Var}\left(h(T) X_{1}^{2}(T) \mathbf{1}_{X_{1}^{2}(T)<\theta}\right) \leq(m / T) \mathbb{E}\left(X^{4}(T)\right):=v^{2}(m)
$$

When choosing $\left.p_{2}\left(m, m^{\prime}\right)=2(1+18 \log N)\left(m \vee m^{\prime}\right) / N T\right) \mathbb{E}\left(X^{4}(T)\right)$, and proceeding as above with Theorem 2 (see Appendix), we obtain the second part of Lemma 4.

## 7. Appendix

7.1. Formulae for Laguerre functions. For this paragraph, we refer to Abramowitz and Stegun (1964) and Comte and Genon-Catalot (2018).

The Laguerre polynomial with index $\delta, \delta>-1$, and degree $k$ is given by

$$
L_{k}^{(\delta)}(x)=\frac{1}{k!} e^{x} x^{-\delta} \frac{d^{k}}{d x^{k}}\left(x^{\delta+k} e^{-x}\right)=\sum_{j=0}^{k}\binom{k+\delta}{k-j} \frac{(-x)^{j}}{j!} .
$$

The following holds:

$$
\begin{equation*}
\left(L_{k}^{(\delta)}(x)\right)^{\prime}=-L_{k-1}^{(\delta+1)}(x), \quad \text { for } k \geq 1, \quad \text { and } \quad \int_{0}^{+\infty}\left(L_{k}^{(\delta)}(x)\right)^{2} x^{\delta} e^{-x} d x=\frac{\Gamma(k+\alpha+1)}{k!} . \tag{28}
\end{equation*}
$$

We consider the Laguerre functions with index $\delta$, given by

$$
\begin{equation*}
\ell_{k}^{(\delta)}(x)=2^{(\delta+1) / 2}\left(\frac{k!}{\Gamma(k+\delta+1)}\right)^{1 / 2} L_{k}^{(\delta)}(2 x) e^{-x} x^{\delta / 2} \tag{29}
\end{equation*}
$$

The family $\left(\ell_{k}^{(\delta)}\right)_{k \geq 0}$ is an orthonormal basis of $\mathbb{L}^{2}\left(\mathbb{R}^{+}\right)$.
For $\delta=0$, we set $L_{k}^{(0)}=L_{k}, \varphi_{k}^{(0)}=\ell_{k}$. Using (28), we obtain for $j \geq 1$ :

$$
\begin{equation*}
\ell_{j}^{\prime}(x)=-\ell_{j}(x)-\sqrt{\frac{2 j}{x}} \ell_{j-1}^{(1)}(x) . \tag{30}
\end{equation*}
$$

The following properties hold for the $\ell_{j}$ 's. For all $x \geq 0$,

$$
\begin{align*}
& \left|\ell_{j}(x)\right| \leq \sqrt{2}, \quad \int_{0}^{+\infty} \ell_{j}(x) d x=\sqrt{2}(-1)^{j}, \quad j \geq 0 \\
& \ell_{0}^{\prime}(x)=-\ell_{0}(x), \quad \ell_{j}^{\prime}(x)=-\ell_{j}(x)-2 \sum_{k=0}^{j-1} \ell_{k}(x), j \geq 1 \tag{31}
\end{align*}
$$

Moreover, the following asymptotic formulae can be found in Askey and Wainger (1965). For $\nu=4 k+2$, and $k$ large enough

$$
\left|\ell_{k}(x / 2)\right| \leq C\left\{\begin{array}{lll}
a) & 1 & \text { if } 0 \leq x \leq 1 / \nu \\
b) & (x \nu)^{-1 / 4} & \text { if } 1 / \nu \leq x \leq \nu / 2 \\
c) & \nu^{-1 / 4}(\nu-x)^{-1 / 4} & \text { if } \nu / 2 \leq x \leq \nu-\nu^{1 / 3} \\
d) & \nu^{-1 / 3} & \text { if } \nu-\nu^{1 / 3} \leq x \leq \nu+\nu^{1 / 3} \\
e) & \nu^{-1 / 4}(x-\nu)^{-1 / 4} e^{-\gamma_{1} \nu^{-1 / 2}(x-\nu)^{3 / 2}} & \text { if } \nu+\nu^{1 / 3} \leq x \leq 3 \nu / 2 \\
f) & e^{-\gamma_{2} x} & \text { if } x \geq 3 \nu / 2
\end{array}\right.
$$

where $\gamma_{1}$ and $\gamma_{2}$ are positive and fixed constants.
7.2. A useful inequality. We recall the Talagrand inequality. The result below follows from the Talagrand concentration inequality given in Klein and Rio (2005) [14] and arguments in Birgé and Massart (1998) [7] (see the proof of their Corollary 2 page 354).

Theorem 2. (Talagrand Inequality) Let $Y_{1}, \ldots, Y_{n}$ be independent random variables with values in a Polish space, let $\nu_{n, Y}(f)=(1 / n) \sum_{i=1}^{n}\left[f\left(Y_{i}\right)-\mathbb{E}\left(f\left(Y_{i}\right)\right)\right]$ and let $\mathcal{F}$ be a countable class of uniformly bounded measurable functions. Then for $\epsilon^{2}>0$

$$
\begin{aligned}
& \mathbb{E}\left[\sup _{f \in \mathcal{F}}\left|\nu_{n, Y}(f)\right|^{2}-2\left(1+2 \epsilon^{2}\right) H^{2}\right]_{+} \\
\leq & \frac{4}{K_{1}}\left(\frac{v^{2}}{n} e^{-K_{1} \epsilon^{2} \frac{n H^{2}}{v^{2}}}+\frac{98 M^{2}}{K_{1} n^{2} C^{2}\left(\epsilon^{2}\right)} e^{-\frac{2 K_{1} C\left(\epsilon^{2}\right) \epsilon}{7 \sqrt{2}} \frac{n H}{M}}\right),
\end{aligned}
$$

with $C\left(\epsilon^{2}\right)=\left(\sqrt{1+\epsilon^{2}}-1\right) \wedge 1, K_{1}=1 / 6$, and

$$
\sup _{f \in \mathcal{F}}\|f\|_{\infty} \leq M, \quad \mathbb{E}\left[\sup _{f \in \mathcal{F}}\left|\nu_{n, Y}(f)\right|\right] \leq H, \sup _{f \in \mathcal{F}} \frac{1}{n} \sum_{k=1}^{n} \operatorname{Var}\left(f\left(Y_{k}\right)\right) \leq v^{2}
$$

By standard density arguments, this result can be extended to the case where $\mathcal{F}$ is a unit ball of a linear normed space, after checking that $f \mapsto \nu_{n}(f)$ is continuous and $\mathcal{F}$ contains a countable dense family.

### 7.3. Characteristic function and moments of $X(t)$.

## Proposition 5.

$$
\mathbb{E} e^{i u X(t)}=\exp \left[\int_{0}^{t} \psi(u a(v))\right] d v, \quad \psi(u)=\int_{\mathbb{R}}\left(e^{i u x}-1-i u x\right) n(x) d x
$$

Proof of Proposition 5. Consider first the case where $Z(t)=\sum_{i=1}^{N(t)} \xi_{i}$ is a compound Poisson process, with $(N(t))$ a Poisson process with intensity $\lambda,\left(\xi_{i}, i \geq 1\right)$ a sequence of i.i.d. random variables independent of the Poisson process $(N(t))$. Then,

$$
X(t)=\sum_{n: T_{n} \leq t} a\left(t-T_{n}\right) \xi_{n}
$$

where $\left(T_{n}\right)$ is the sequence of jumps times of $(N(t))$. We have $X(t)=0$ on $(N(t)=0)$ and $X(t)=\sum_{k=1}^{n} a\left(t-T_{k}\right) \xi_{k}$ on $(N(t)=n)$. Let $f$ denote the common density of the $\xi_{i} \mathrm{~s}$ and $f^{*}$ their characteristic function. We use that the conditional distribution of $\left(T_{1}, \ldots, T_{n}\right)$ given $(N(t)=n)$ is equal to the distribution of $\left(U_{(k)}, k=1, \ldots, n\right)$ the order statistic of $\left(U_{1}, \ldots, U_{n}\right)$ $n$ i.i.d. random variables with uniform distribution on $[0, t]$ :

$$
\begin{aligned}
\mathbb{E} e^{i u X(t)} \mathbf{1}_{(N(t)=n)} & =\mathbb{E}\left[\mathbf{1}_{(N(t)=n)} \int e^{i u \sum_{k=1}^{n} a\left(t-T_{k}\right) x_{k}} f\left(x_{1}\right) \ldots f\left(x_{k}\right) d x_{1} \ldots d x_{k}\right] \\
& =\mathbb{E}\left[\mathbf{1}_{(N(t)=n)} \prod_{k=1}^{n} f^{*}\left(u a\left(t-T_{k}\right)\right)=\mathbb{E}\left[\mathbf{1}_{(N(t)=n)} \mathbb{E} \prod_{k=1}^{n} f^{*}\left(u a\left(t-U_{(k)}\right)\right)\right.\right. \\
& =\mathbb{E}\left[\mathbf{1}_{(N(t)=n)} \mathbb{E}\left[\prod_{k=1}^{n} f^{*}\left(u a\left(t-U_{k}\right)\right)\right]=\mathbb{E}\left[\mathbf{1}_{(N(t)=n)}\left(\frac{1}{t} \int_{0}^{t} f^{*}(u a(t-v)) d v\right)^{n}\right.\right.
\end{aligned}
$$

Therefore,

$$
\mathbb{E} e^{i u X(t)}=e^{(-\lambda t)} e^{\left[\lambda t \int_{0}^{t} d v f^{*}(u a(t-v) d v / t]\right.}=\exp \int_{0}^{t} d v \psi(u a(t-v))
$$

where $\psi(u)=\int_{\mathbb{R}}\left(e^{i u x}-1\right) \lambda f(x) d x$ is the characteristic exponent of $(Z(t))$. Note that if $f$ is centered, we can write $\psi(u)=\int_{\mathbb{R}}\left(e^{i u x}-1-i u x\right) \lambda f(x) d x$.

In the general case, we have
$\mathbb{E} e^{i u Z(t)}=\exp \left[t \int_{\mathbb{R}}\left(e^{i u x}-1-i u x\right) n(x) d x\right]=\exp t \psi(u), \quad Z(t)=\int_{(0, t]} \int_{\mathbb{R}} x(\hat{p}(d s, d x)-d s n(x) d x)$,
where $\hat{p}(d s, d x)$ is the random Poisson measure associated with the jumps of $(Z(t))$. We consider for $\varepsilon>0$,

$$
Z_{\varepsilon}(t)=\int_{(0, t]} \int_{|x|>\varepsilon} x(\hat{p}(d s, d x)-d s n(x) d x)=Y_{\varepsilon}(t)-t \int_{|x|>\varepsilon} x n(x) d x
$$

We have

$$
\mathbb{E} e^{i u Z_{\varepsilon}(t)}=\exp \left[t \int_{|x|>\varepsilon}\left(e^{i u x}-1-i u x\right) n(x) d x\right]=\exp t \psi_{\varepsilon}(u)
$$

and $X_{\varepsilon}(t)=\int_{0}^{t} a(t-v) d Z_{\varepsilon}(v)=\int_{0}^{t} a(t-v) d Y_{\varepsilon}(v)-\int_{0}^{t} a(t-v) d v \int_{|x|>\varepsilon} x n(x) d x$. The process $\left(Y_{\varepsilon}(t)\right)$ is a compound Poisson process with intensity $\mathbf{1}_{|x|>\varepsilon} n(x) d x$. Therefore,

$$
\mathbb{E} e^{i u X_{\varepsilon}(t)}=\exp \left[\int_{0}^{t} d v \int_{|x|>\varepsilon}\left(e^{i u a(t-v) x}-1\right) n(x) d x-i u \int_{0}^{t} a(t-v) d v \int_{|x|>\varepsilon} x n(x) d x\right]
$$

Thus, $\mathbb{E} e^{i u X_{\varepsilon}(t)}=\exp \left[\int_{0}^{t} d v \psi_{\varepsilon}(u a(t-v))\right]$. Now, it is enough to let $\varepsilon$ tend to 0 and the proof is achieved.

Proposition 6. We have:

$$
\mathbb{E} X^{4}(t)=3\left(\int_{0}^{t} a^{2}(u) d u\right)^{2}+k_{4} \int_{0}^{t} a^{4}(u) d u
$$

For all $p \geq 1$, there exists a constant $D(4+2 p)$ depending only on $p$ such that

$$
\begin{aligned}
\mathbb{E}\left[X^{4}(t) \mathbf{1}_{X^{2}(t)>\theta}\right] & \leq \frac{1}{\theta^{p}} \mathbb{E} X^{4+2 p}(t) \\
& \leq \frac{D(4+2 p)}{\theta^{p}}\left(G^{2+p}(t)+k_{4+2 p} \int_{0}^{t} a^{4+2 p}(u) d u\right) .
\end{aligned}
$$

Proof of Proposition 6. We derivate four times the characteristic function of $X(t)$ and use that for $\psi(u)=\int\left(e^{i u x}-1-i u x\right) n(x) d x, \psi^{\prime}(0)=0, \psi^{\prime \prime}(0)=-1, \psi^{(4)}(0)=k_{4}$.
The second inequality is a direct application of the first Kunita inequality (see Applebaum (2009)) where $D(4+2 p)$ is the constant given in this inequality.
