#### Abstract

It is recognized that disturbances by fossorial small mammals are important factors determining plant community diversity, especially in grasslands. However, although information about the effects of disturbances by fossorial small mammals on species richness are starting to accumulate, we know little about the impact of these disturbances on the functional and phylogenetic facets of plant community diversity in grasslands. In a study site located in the French Jura Mountains, we compared taxonomic, functional and phylogenetic diversity of plant communities in areas highly disturbed by montane water vole (Arvicola terrestris) with areas lowly disturbed by this small mammal. In accordance with previous studies, we found that species richness was higher in highly disturbed communities. Indeed, competitive species unable to withstand disturbances were less abundant in disturbed communities, allowing species less adapted to competition for light to survive. Because these species have different trait values in comparison to strong competitors, functional richness was also higher in highly disturbed communities. Results were similar for phylogenetic richness, maybe due to the fact that the used metric was not independent from species richness. Although species composition differed between highly and lowly disturbed communities, functional composition was very similar. Thereby, the studied disturbances were probably not strong enough to affect plant community functioning. Rao functional diversity and functional evenness were not different between both community types. Interestingly, phylogenetic evenness was lower in highly disturbed areas, supporting the idea that disturbances might select for disturbance tolerance traits that are phylogenetically conserved. Though correlational, our results suggest that water vole disturbances may modify multiple facets of plant community diversity, while ecosystem functioning is maintained across disturbance levels. Further research is needed to understand causal mechanisms in this system and the ecological repercussions of small mammal disturbances more broadly.

#### 1. Introduction

Fossorial small mammals provide valuable ecosystem services in many grassland ecosystems throughout the world (Delibes-Mateos et al. 2011; Davidson et al. 2012). In particular, fossorial small mammals are important in structuring plant assemblages in grasslands. Many studies have highlighted that their presence increases plant species richness in grasslands (Martinsen et al. 1990; Kotliar et al. 1999; Fahnestock and Detling 2002; Bagchi et al. 2006; Questad and Foster 2007), especially through the creation of a mosaic of micro-habitats at the community level (Collins 1989; Canals and Sebastià 2000; Yoshihara et al. 2009). Martinsen et al. (1990) and Hobbs et al. (2007) highlighted that the cover of competitive species is lower in plant communities where small mammals are presents. Consequently, subordinate and annual species are present at higher abundances (Martinsen et al. 1990; Questad and Foster 2007; Yoshihara et al. 2009). Small mammals can affect plant communities via engineering interactions and non-engineering interactions such as trophic effects (Sanders et al. 2014). In particular, soil disturbances by fossorial small mammals when they create their burrows are important in shaping vegetation assemblages. Indeed, it is recognized that disturbances affect plant species diversity and community composition (White 1979) by creating niche or colonization opportunities through released resources and impaired relationships between species (Huston 1994; Grime 2001; Platt and Connell 2003). Disturbances by ecosystem engineers act also as a major source of heterogeneity in many ecosystems (Jones et al. 1997; Davidson et al. 2012), which is an important driver of species diversity (Huston 1994; Tilman 1999). Earth tumuli (i.e. the mounds of earth raised at the entrance of the burrows of fossorial small mammals) damage the existing vegetation when they are created, allowing light to reach lower vegetation layers. Thereby, competition for light is reduced near earth tumuli, permitting species less adapted to competition for light to survive (Seifan et al. 2010) and seedlings to grow faster (Martinsen et al. 1990). Moreover, changes in soil properties following soil disturbances by fossorial small

mammals can improve germination success of certain plant species (Fahenstock et al. 2003; Mallen-Cooper et al. 2019). Indeed, it has been shown that activities of small mammals may also indirectly impact plant species distribution through effects on circulation and release of soil nutrients (Gervais et al. 2010; Yurkewycz et al. 2014; Risch et al. 2015) and on distribution of soil micro-organisms (Aguilera et al. 2016). Herbivorous small mammals preferentially consume geophyte species (Hobbs et al. 2007), legume species (Kopp 1988; Lantová and Lanta 2009) or grass biomass when easily available (Stenseth et al. 1977) while granivorous small mammals preferentially consume seeds of large-seeded species (Stenseth et al. 1977). Herbivory by small mammals negatively affects the consumed species (Korell et al. 2017) but may increase plant diversity by suppressing dominant species (Prugh and Brashares 2012). However, some authors pointed out that small mammals allow active seed dispersal and increase the germination success of some plant species through endozoochory (Soriguer 1986; Dellafiore et al. 2009). Even if engineering interactions (i.e. disturbances during the creation of the burrows) seem to have stronger effects on plant community than non-engineering interactions (Prugh and Brashares 2012), both engineering and non-engineering effects are likely to affect plant communities in different ways (Sanders et al. 2014) and have to be considered. Since the early 1970s, subsequent to the specialization of agriculture in dairy production in the French Jura Mountains, almost all the utilized agricultural area has been converted into permanent grasslands, resulting in an increase of montane water vole (Arvicola terrestris) densities (Giraudoux et al. 1997). Montane water voles are herbivorous small mammals feeding on plant roots. They find roots by tunneling underground at approximately 20 cm depth (Delattre and Giraudoux 2009). Thus, their foraging activities have engineering effects on soils. Cyclic outbreaks of montane water vole populations (200 to 1000 individuals per hectare) occur every 5 to 8 years (Berthier et al. 2014) and do considerable damage on vegetation (Delattre and Giraudoux 2009), resulting in an important loss of

forage production (Quéré et al. 1999; Schouwey et al. 2014). Many studies have been conducted to understand the determinism of these outbreaks (Giraudoux et al. 1997; Morilhat et al. 2007; Morilhat et al. 2008) and to limit their intensity (Couval and Truchetet 2014; Foltête et al. 2016). However, the impact of montane water vole disturbances on plant diversity and composition in grassland ecosystems have not been assessed yet. In the French Jura mountains, montane water vole density is positively correlated with their disturbance activity (Giraudoux et al. 1995). Thus, it is not possible to separate the engineering from the trophic effects of montane water vole on plant diversity and composition. Thereby, the next mentions of disturbances by montane water voles will refer to both engineering and trophic effects. Although the effects of disturbances by small mammals on species richness are well documented, the functional and phylogenetic facets of plant diversity have been taken into account in very few studies. As taxonomic, functional and phylogenetic diversity have been acknowledged to be complementary aspects of community structure, responding differently to environmental changes (Cadotte et al. 2013; Pavoine et al. 2013), the objective of this work was to investigate the effects of disturbances by montane water voles on different facets of grassland plant alpha diversity and composition in the French Jura Mountains. To do so, we selected a site disturbed by montane water voles at the beginning of the study year and compared plant communities in areas highly vs. lowly disturbed by montane water voles. Richness and evenness were evaluated for both taxonomic, functional and phylogenetic facets of community diversity. We also evaluated taxonomic diversity using the inverse Simpson index and functional and phylogenetic diversity through Rao quadratic diversity with Jost correction. As it corresponds to a generalization of the inverse Simpson index (Jost 2007; de Bello et al. 2010), it allows for direct comparison of the taxonomic, functional, and phylogenetic facets of community diversity. Moreover, we also considered species composition and functional composition

through plant life forms (*i.e.* forbs, legumes and grasses), CSR strategies (Pierce *et al.* 2017) and community weighted means of functional traits.

We expected plant taxonomic, functional and phylogenetic diversity metrics to be higher in highly disturbed areas because of the creation of niche opportunities through reduction of resource competition, mainly for light. We hypothesized light availability to be principally altered in comparison to soil resources because the study was conducted in a productive hay meadow fertilized once a year for forage production. Thus, the reduction of competition for light through disturbances by montane water voles would allow the colonization by species less adapted to light competition. We expected the cover of ruderal species to be higher in highly disturbed areas, because these species are favored by disturbances (Pierce et al. 2017). At the opposite, the cover of competitive species was expected to be lower because these species do not tolerate disturbances (Pierce et al. 2017). Moreover, the cover of legume species was also expected to be lower in highly disturbed areas because they are preferentially consumed by montane water voles (Kopp 1988). However, we supposed that competitive and legume species would still be present along with those that colonized highly disturbed areas, therefore leading to higher plant taxonomic, functional and phylogenetic diversity in highly disturbed areas.

## 2. Material and methods

## 124 2.1. Study site and sampling design

The study site is located in the central part of the French Jura Mountains (La Planée, 6°15'42" E, 46°49'36" N) at 975 m a.s.l. Climate is nemoral with a strong suboceanic influence. The mean annual temperature is 6.6°C and the mean annual precipitation is 1187 mm (http://www.meteofrance.com). The study site covers approximately 4 ha used for forage production and is not grazed by cattle.

According to the farmer, management practices on the study site did not change during the last 5

years. The vegetation is fertilized once a year (precise information about the nutrient input were not communicated but it doesn't exceed 120 kg N ha<sup>-1</sup> yr<sup>-1</sup>), mowed twice a year (in late spring and middle summer) and belongs to the *Triseto flavescentis—Polygonion bistortae* Braun-Blanquet & Tüxen ex Marschall 1947 (mountain mesic hay meadows). The study was carried out 18 months after a high density phase of a montane water vole population cycle, during the decrease period.

We divided the study site into contiguous sampling units of 100 m² (10 m  $\times$  10 m) arranged in a cell grid. To avoid potential edge effects, units located at the border of the study site were excluded. Thus, we obtained a grid of 312 units. During the last week of April 2018, we counted the number of earth tumuli made by montane water voles in each of the 312 units, which has been identified to be positively correlated with their density and disturbance activity (Giraudoux *et al.* 1995). The number of tumuli in a distinct unit ranged from 3 to 53 (mean = 25). According to Giraudoux *et al.* (1995), in units of 25 m², the number of tumuli is significantly positively correlated with water vole abundance for a number higher than 10. Thus, we defined units with more than 40 tumuli as "high density units" (HDU, n = 37) and units with less than 20 tumuli as "low density units" (LDU, n = 135). Searching for the most contrasted situations, we paired a HDU with an adjacent LDU. In order to limit spatial autocorrelation, each pair had to be separated from the others by at least two units (20 m). As a result, we obtained 16 different pairs.

The vegetation was sampled during the last week of May 2018 in a plot of 16 m² (4 m × 4 m) located at the center of each selected unit. Total surface covered by plants was significantly different in plots located in HDU (94.7%  $\pm$  1.6%) in comparison to plots located in LDU (100%  $\pm$  0%) (P = 0.004 using a Wilcoxon-Mann-Whitney paired test). All encountered vascular plant species were listed and their cover estimated using the Braun-Blanquet scale (r, +,1, 2, 3, 4, 5). We converted these codes into absolute percentage cover (van der Maarel 1979) and adjusted them to relative percentage cover by

summing to 100% for each plot (Appendix A). Based on these calculated values, we computed different diversity metrics for the 32 plots.

## 2.2. Diversity metrics and functional composition

To account for the complementary facets of community diversity, we computed taxonomic, functional and phylogenetic alpha diversities at the plot level (Devictor et al. 2010; Cadotte et al. 2013; Dainese et al. 2015). All metrics computations were done under R v 3.4.2 (http://www.R-project.org). Species richness (N0) and inverse Simpson diversity (N2) were computed to evaluate taxonomic diversity, using respectively the specnumber() and diversity() functions from the vegan package (Oksanen et al. 2018). These metrics are based on Rényi general entropy and expressed as species number equivalents (Hill 1973). Pielou evenness (J1) was also computed according to Jost (2010). To compute functional diversity, we selected four functional traits: specific leaf area (SLA), leaf nitrogen content per dry mass (LNC), leaf dry matter content (LDMC) and maximum plant height (MH). These traits were chosen as they are commonly used in functional ecology of grasslands (Louault et al. 2005; Ansquer et al. 2009; Garnier and Navas 2012; Lososová et al. 2016; Mauchamp et al., 2016). Maximum plant height is a morphological trait conditioning plant competitive ability (Tilman 1988; Westoby et al. 2002). LNC, SLA and LDMC provide information about plant growing strategy as they are linked to resource acquisition or conservation (Garnier et al. 2004). These functional traits were extracted from two databases: TRY database for LNC and MH (Kattge et al. 2011) and LEDA Traitbase for SLA and LDMC (Kleyer et al. 2008). From a standardized Euclidean distance matrix, we computed multi-trait Rao quadratic diversity (RaoFD) weighted by the relative percentage cover of each individual plant species. To do so, we used the Rao() function provided in de Bello et al. (2010). We also calculated multidimensional functional diversity indices: functional richness (FRic) and functional evenness (FEve) (Villéger et al. 2008; Laliberté and Legendre 2010) using the dbFD() function from the FD package (Laliberté et al. 2014). Species with missing trait values were excluded

from the calculations (7 species out of 56). Thereby, functional metrics were sometimes computed with a bit less than 90% of the sum of relative percentage cover (at least 87%).

To summarize the functional composition of each plot, we calculated the relative percentage cover of the usual agronomic plant-life forms (*i.e.* grasses, legumes and forbs) by summing the relative percentage cover of the corresponding species. We also computed community-weighted means for the four functional traits and community-weighted means of CSR strategies, using the values given by Pierce *et al.* (2017).

To compute phylogenetic diversity, we constructed a phylogenetic tree composed of the vascular plant species identified in the 32 plots. To build this phylogenetic tree, we followed the same procedure presented in many studies in the French Jura Mountains (Perronne et al. 2014; Mauchamp et al. 2014; Gillet et al. 2016; Mauchamp et al. 2016). From GenBank database (Benson et al. 2006), we extracted the sequences of two genes encoding chloroplast proteins (rbcL and matK) for each species. Their complementarity allows to have a good resolution of the phylogenetic tree (Hilu et al. 2003). Species not yet sequenced for the selected genes were replaced by their closest available relative (2 species out of 56), according to the APG III classification (APG 2009). We first aligned the sequences using ClustalX 2.1 software (Larkin et al. 2007) and then adjusted them manually for both genes. Following the Bayesian Monte Carlo Markov Chain (MCMC) approach under BEAST 1.8.4 software (Drummond and Rambaut 2007), we performed a combined analysis of these two gene datasets. We used MrModeltest2 software (v. 2.0, Evolutionary Biology Center, Uppsala University, SE) to select the model of nucleotides substitution that best fitted the data according to Akaike's information criterion. The retained model was the general time reversible model (GTR), with among-site substitution rate heterogeneity described by a gamma distribution (Yang 1994). Following the APG III phylogeny (APG 2009), several family relationships were constrained in BEAST in order to calibrate the rates of molecular evolution of each lineage for angiosperms clades (Bell et al. 2005). For branch length

calculation, we used an uncorrelated relaxed molecular clock that takes into account evolutionary heterogeneity between lineages (Drummond *et al.* 2006). The ultrametric tree topology was saved in a newick format. To compute phylogenetic diversity (RaoPD), we used Rao quadratic entropy weighted by the ultrametric distances of the phylogenetic tree. To do so, we used the Rao() function provided in de Bello *et al.* (2010). We computed the Faith's PD index (Faith 1992; Tucker *et al.* 2017) to assess phylogenetic richness (PRic), using the pd() function from the picante package (Kembel *et al.* 2019). Phylogenetic evenness (PEve) was calculated using the pse() function (Helmus *et al.* 2007) from the picante package (Kembel *et al.* 2019).

## 2.3. Statistical analyses

We first tested for differences in average species composition between HDU and LDU applying a PermANOVA (Anderson and Walsh 2013) on the Bray-Curtiss dissimilarity matrix of the 32 vegetation plots. To do so, we used the adonis() function from the vegan package (Oksanen *et al.* 2018) setting 5000 permutations. Because each plot in a HDU was paired with an adjacent plot in a LDU, permutations were constrained within each pair of plots. A nonmetric multidimensional scaling (NMDS) on the Bray-Curtis dissimilarity matrix of the 32 vegetation plots was then performed (Borcard *et al.* 2018). We used the vegdist() functions from the vegan package (Oksanen *et al.* 2018) to compute the dissimilarity matrix and the ggplot() function from the ggplot2 package (Wickham *et al.* 2019) to differentiate vegetation plots made in HDU and LDU. We also drew ellipses at 95% confidence level around these two groups to visualize whether their species composition was related or different. Then, we used the betadisper() function from the vegan package (Oksanen *et al.* 2018) to compare the amount of variation in species composition within HDU and LDU.

To assess if some species were associated with HDU or LDU, we used the phi coefficient of association (De Cáceres and Legendre 2009), a measure of species fidelity. Applied to species cover

data, this index is the Pearson correlation computed between a quantitative vector (i.e., the vector

containing the species cover values in the vegetation plots) and a binary vector (*i.e.*, "1" for vegetation plots belonging to the target group, HDU for example, and "0" for vegetation plots belonging to the other group). We performed the computation using the multipatt() function from the indicspecies package (De Cáceres and Legendre 2009) setting 5000 permutations.

We tested for differences in diversity metrics, cover of grasses, legumes and forbs and community-weighted means of CSR strategies between the two plots groups. To do so, we used Wilcoxon-Mann-Whitney paired tests.

We finally tested for differences in average functional composition between HDU and LDU applying a PermANOVA (Anderson and Walsh 2013) on community-weighted means of functional traits (SLA, LNC, LDMC and MH). Because the selected quantitative functional traits were expressed in different units, we computed a Euclidean distance matrix on the scaled data. To perform the PermANOVA, we used the adonis() function from the vegan package (Oksanen *et al.* 2018) setting 5000 permutations. Permutations were constrained within each pair of plots.

All analyses were performed under R v 3.6.2 (http://www.R-project.org).

## 3. Results

#### 3.1. Plant community composition

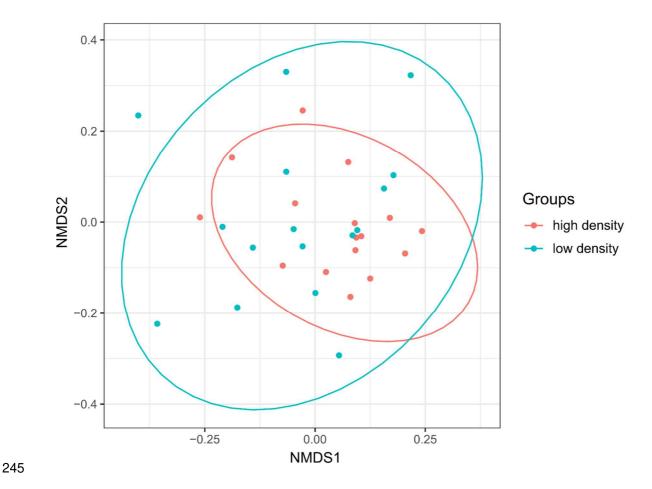


Fig. 1: Nonmetric multidimensional scaling of the Bray-Curtis dissimilarity matrix of the 32 vegetation plots. Vegetation plots located in "high density units" are displayed in red. Vegetation plots located in "low density units" are displayed in blue. The confidence level for ellipses is 95%.

Results of the PermANOVA on species relative cover ( $R^2 = 0.064$ , P = 0.007) revealed that plant communities located in LDU and HDU were different. However, differences were not very large. As evidenced by NMDS (Fig. 1), HDU vegetation plots were more closely related than LDU vegetation plots, which were more scattered (average distance to centroid was 0.28 for HDU and 0.34 for LDU).

The fidelity analysis showed that some species were associated with LDU or HDU (Table 1, see Appendix B for non-significant results). Larger phi values (close to 1) indicate a greater degree of joint fidelity between the species and the considered group. As these values were rather low, they indicated a low degree of joint fidelity. *Anthriscus sylvestris* and *Geranium sylvaticum*, two competitive forbs, were associated with LDU. At the opposite, the short species *Veronica chamaedrys*, *Cerastium fontanum*, *Alchemilla monticola*, *Bellis perennis* and *Ajuga reptans*, as well as *Achillea millefolium* and *Vicia cracca*, were associated with HDU.

## 3.2. Plant community diversity and functional composition

According to Wilcoxon-Mann-Whitney paired tests (Table 2), plant communities sampled in HDU generally showed higher species richness (N0), functional richness (FRic), phylogenetic richness (PRic) and relative cover of grass species (grass). On the other side, plant communities sampled in LDU generally showed higher phylogenetic evenness (PEve), relative cover of forbs (forb) and competitive species (straC). Moreover, Rao phylogenetic diversity (RaoPD) showed P = 0.074 and tended to be higher in communities sampled in LDU. Results of the PermANOVA on community-weighted mean trait values ( $R^2 = 0.043$ , P = 0.144) revealed that plant communities located in LDU were not functionally different from plant communities located in HDU.

## 4. Discussion

According to the results of this study, we discuss several possible ecological processes that may explain our observations. As previously mentioned, the density of montane water voles is positively correlated with their disturbance activities (Giraudoux *et al.* 1995). Thus, we discuss the disturbances by montane water voles as including both engineering and non-engineering (trophic) interactions. The expression of the disturbances by fossorial small mammals is linked to their behavior and population dynamics. Here, the study has been carried out 18 months after a high-density phase of a montane water vole population cycle, during the decrease period. However, in the French Jura Mountains, we

do not know whether montane water voles select the place where they create their burrows under the influence of specific environmental factors, or if this selection is random. Thereby, the results of our study may suggest causal effects of vole disturbances on plant communities, but they should be interpreted in light of area selection being a potentially confounding variable.

Moreover, the total percentage of the surface covered by plants was significantly lower in plots located in HDU in comparison to plots located in LDU. Despite the fact that cover differences were rather small between each pair of plots (approximately 5%), diversity metrics may have been underestimated in HDU because the cover was lower.

### 4.1. Differences in plant community composition

By altering species interactions, disturbances by small mammals can affect plant communities via engineering interactions and non-engineering interactions such as trophic effects (Sanders *et al.* 2014). The comparison of plant communities in areas highly disturbed by montane water voles with plant communities in lowly disturbed ones revealed differences in plant community composition.

Differences in plant community composition concerned only a restricted number of species. Only a small set of species was associated with lowly or highly disturbed communities. Contrary to our expectation, the cover of legume species was not lower in highly disturbed plant communities. Moreover, *Taraxacum officinale* and *Trifolium pratense* were not associated with lowly disturbed plant communities although they are known to be preferentially consumed by montane water voles (Kopp 1988). Forage quality has been shown to have a positive effect on prairie vole habitat selection (Lin *et al.* 2006). Thereby, it might be possible that *Taraxacum officinale* and *Trifolium pratense* were more abundant in areas that were highly disturbed by montane water voles. Because these species were preferentially consumed, their cover could have been decreased before the field work, resulting in an absence of association with lowly or highly disturbed communities. Contrary to our expectations and to

findings of other studies (Questad and Foster 2007; Yoshihara et al. 2009), the relative cover of ruderal species was not significantly higher in highly disturbed plant communities. The fact that earth tumuli might be quickly colonized by the neighbouring vegetation (Sebastià and Puig 2008), not allowing exogenous ruderal species to colonize the study site, could explain these results. In plant communities highly disturbed by montane water voles, the relative percentage cover of competitive species was lower, probably because these species are not able to withstand disturbances (Grime 1974; Grime 1977; Grime and Pierce 2012). Anthriscus sylvestris and Geranium sylvaticum, two competitive species, seemed to be affected by disturbances. In the study region, these species are commonly found in forest-edge communities and advanced stages of ecological succession in hay meadows (Ferrez et al. 2011). Disturbances are known to shift back the stage of succession (Huston 1994; Chesson and Huntly 1997), which could explain why these species presented lower relative cover in highly disturbed plant communities. It is also possible that Anthriscus sylvestris and Geranium sylvaticum were consumed by water voles, thus being less abundant in highly disturbed areas. As these two dominant forbs seemed to be strongly affected by disturbances in our study site, the relative percent cover of forbs was lower in plant communities highly disturbed by montane water voles, contrary to the results of other studies (Martinsen et al. 1990; Questad and Foster 2007; Yoshihara et al. 2009). Moreover, in our study site, the relative percent cover of grass species was greater in highly disturbed plant communities although it did not concern some species in particular, suggesting that grass species predominate in the fast recovery of vegetation (Rogers et al. 2001). In grasslands, the creation of disturbances allows weaker competitors for light to survive in the community (Rajaniemi 2002), which can explain that short species such as Veronica chamaedrys, Cerastium fontanum, Alchemilla monticola, Bellis perennis and Ajuga reptans were associated with

highly disturbed plant communities. Indeed, earth tumuli created by montane water voles may provide

colonization opportunities for species less competitive for light, as it has been shown to be the case for molehills (Seifan *et al.* 2010). Moreover, the regression of competitive species probably caused by soil disturbances and trophic interactions could also have allowed the development of short species at higher abundance. However, we were able to find these results because we were working in a productive site with a high plant canopy. It is expected that, in less productive sites with a low plant canopy, limitation of light competition by disturbances by montane water voles should be less important. *Achillea millefolium* was also associated with highly disturbed plant communities, which is not surprising considering the fact that this species is typical of intensively grazed grasslands and well adapted to soil disturbances (Sebastià and Puig 2008).

## 4.2. Differences in plant community diversity

In accordance with previous studies (Martinsen *et al.* 1990; Kotliar *et al.* 1999; Fahnestock and Detling 2002; Bagchi *et al.* 2006; Questad and Foster 2007), we observed that plant communities highly disturbed by montane water voles presented higher species richness. Indeed, herbivory by water voles may increase species richness by impacting dominant species (Prugh and Brashares 2012), thus allowing more species to coexist. Moreover, in accordance to the observed differences in plant community composition, this could also be explained by the fact that soil disturbances by montane water voles play an important role in enhancing species richness by providing sites with altered resource availability and reduced competition for light (Seifan *et al.* 2010). Because species less adapted to strong light competition are shorter and present different functional traits in comparison to strong competitors (Ansquer *et al.* 2009; Garnier and Navas 2012), a greater functional richness was also observed in highly disturbed communities

Interestingly, we observed no differences in Rao functional diversity and functional evenness between highly and lowly disturbed plant communities. Moreover, as revealed by the PermANOVA on

community-weighted mean trait values, functional composition was not different between the two

community types. These results support the idea that disturbances by montane water voles, which occurred in our study site before the field work, may not be strong enough to affect community functioning. This also highlights the strong resilience of the studied plant communities. Indeed, permanent grassland vegetation is known to recover relatively quickly from disturbances by small mammals (Quéré et al. 1999; Sebastià and Puig 2008). However, since our functional analyses relied on four functional traits, it was important to consider phylogenetic diversity, which summarizes the trait space within a community (Srivastava et al. 2012; Winter et al. 2013). Results showed that phylogenetic richness was greater in plant communities highly disturbed by montane water voles. However, this was likely due to the fact that phylogenetic richness is not independent from species richness (Faith 1992). At the opposite, phylogenetic evenness was lower in plant communities highly disturbed by montane water voles, suggesting that disturbances might select for disturbance tolerance traits which could be phylogenetically conserved (Dinnage 2009). Indeed, some studies have shown that disturbance increases average relatedness among species (Warwick and Clarke 1998; Verdu and Pausas 2007). Because of reduced competition, disturbed plant communities might be more strongly influenced by environmental filtering of niche traits (Dinnage 2009), allowing only closely related species to become dominant. The limitation of light competition through the creation of gaps in the plant canopy (likely as a result of both herbivory and vegetation destruction during the burrow creation) seems to be the main process affecting plant diversity in highly disturbed plant communities. However, like it was the case for other small mammals (Fahnestock et al. 2003; Verdú et al. 2009), the seedling recruitment of species associated with highly disturbed communities could also have been improved by soil disturbances and

endozoochory. It has been shown by various authors (Kalisz and Davis 1992; Huntly and Reichman

1994; Whitford and Kay 1999; Questad and Foster 2007; Mallen-Cooper et al. 2019) that disturbances

by small mammals might increase soil nutrient input, suggesting that plants located in disturbed areas

grow on more fertile soils. However, as plant species associated with highly disturbed communities were mainly short species, it is likely that disturbances principally altered light availability in comparison to the distribution of soil resources. Moreover, changes in soil resources should have been detected by a difference in functional composition because the functional traits used in this study are linked to resource acquisition and conservation (Garnier *et al.* 2004).

## 5. Conclusion

Our results suggest that disturbances by montane water voles may modify plant community diversity and composition in the grasslands of the French Jura Mountains. In our study site, like disturbances induced by many other fossorial small mammals, disturbances by montane water voles probably increased species richness and functional richness mainly through the reduction of light competition, allowing weaker competitors for light to occur. However, according to our set of traits, it seems that such disturbances were not strong enough to modify Rao functional diversity, functional evenness and functional composition. Nevertheless, disturbed communities were more dominated by closely related species and thus presented a lower phylogenetic evenness. Montane water voles, perceived as pests and targeted for control in the French Jura Mountains, are likely to play an important role in shaping plant community diversity in permanent grasslands. Indeed, causal effects established in other studies suggest that the results here are also causal. However, pre-disturbance differences in soil structure and in plant community composition within our study site could have influenced our results. Such differences probably influenced area selection by voles, which is thereby a potential confounding variable in our study. Moreover, the observed differences in plant community diversity and composition may also be linked to the past-history of the study site. Thus, further studies aiming at understanding the role of montane water voles on the long-term functioning of grassland ecosystems have to be conducted. Longitudinal monitoring of plots over population cycles of montane water vole, recording jointly plant community, soil properties and small mammal population dynamics, should be a priority.

Such monitoring would allow to disentangle the results of area selection by montane water voles from the effects of their disturbances on plant community diversity and composition. Moreover, manipulative experiments should also be conducted to establish causal mechanisms.
