SHAPE OPTIMIZATION OF A DIRICHLET TYPE ENERGY FOR SEMILINEAR ELLIPTIC PARTIAL DIFFERENTIAL EQUATIONS

Abstract. Minimizing the so-called "Dirichlet energy" with respect to the domain under a volume constraint is a standard problem in shape optimization which is now well understood. This article is devoted to a prototypal non-linear version of the problem, where one aims at minimizing a Dirichlet-type energy involving the solution to a semilinear elliptic PDE with respect to the domain, under a volume constraint. One of the main differences with the standard version of this problem rests upon the fact that the criterion to minimize does not write as the minimum of an energy, and thus most of the usual tools to analyze this problem cannot be used. By using a relaxed version of this problem, we first prove the existence of optimal shapes under several assumptions on the problem parameters. We then analyze the stability of the ball, expected to be a good candidate for solving the shape optimization problem, when the coefficients of the involved PDE are radially symmetric.

1. Introduction

1.1. Motivations and state of the art

Existence and characterization of domains minimizing or maximizing a given shape functional under constraint is a long story. Such issues have been much studied over the last decades (see *e.g.* [1, 7, 11, 13, 17]). Recent progress has been made in understanding such issues for problems involving for instance spectral functionals (see *e.g.* [12]).

The issue of minimizing the Dirichlet energy (in the linear case) with respect to the domain is a basic and academical shape optimization problem under PDE constraint, which is by now well understood. This problem reads:

Let $d \in \mathbb{N}^*$ and D be a \mathscr{C}^2 compact set of \mathbb{R}^d . Given $g \in L^2(D)$ and $m \leq |D|$, minimize the Dirichlet energy

$$J(\Omega) = \frac{1}{2} \int_{\Omega} |\nabla u_{\Omega}|^2 - \int_{\Omega} g u_{\Omega},$$

where u_{Ω} is the unique solution of the Dirichlet problem¹ on Ω associated to g, among all open bounded sets $\Omega \subset D$ of Lebesgue measure $|\Omega| \leq m$.

As such, this problem is not well-posed and it has been shown (see e.g. [10] or [13, Chap. 4] for a survey of results about this problem) that optimal sets only exist within the class

$$\mathcal{O}_m = \{ \Omega \in \mathcal{A}(D), \ |\Omega| \leqslant m \}, \tag{1.1}$$

where $\mathcal{A}(D)$ denotes the class of quasi-open sets² of D.

This article is motivated by the observation that, in general, the techniques used to prove existence, regularity and even characterization of optimal shapes for this problem rely on the fact that the functional is "energetic", in other words that the PDE constraint can be handled by noting that the full shape optimization problem rewrites

$$\min_{\substack{\Omega \in \mathcal{A}(D) \\ |\Omega| \leqslant m}} \min_{u \in W_0^{1,2}(\Omega)} \left\{ \frac{1}{2} \int_{\Omega} |\nabla u_{\Omega}|^2 - \int_{\Omega} g u_{\Omega} \right\}.$$

In this article, we introduce and investigate a prototypal problem close to the standard "Dirichlet energy shape minimization", involving a nonlinear differential operator. The questions we wish to study here concern existence of optimal shapes and stability issues for "non energetic" models. We note that the literature regarding existence and qualitative properties for non-energetic, non-linear optimization problems is scarce. We nevertheless mention [18], where existence results are established in certain asymptotic regimes for a shape optimization problem arising in population dynamics.

Since our aim is to investigate the optimization problems in the broadest classes of measurable domains, we consider a volume constraint, which is known to lead to potential difficulties. Indeed, the literature in shape optimization is full of optimization problems that are not well-posed under such constraints.

In the perturbed version of the Dirichlet problem we will deal with, the linear PDE solved by u_{Ω} is changed into a nonlinear one but the functional to minimize remains the same. Since, in this case, the problem is not "energetic" anymore (in the sense described above), the PDE constraint cannot be incorporated into the shape functional. This calls for new tools to be developed in order to overcome this difficulty. Among others, we are interested in the following issues:

- **Existence:** is the resulting shape optimization problem well-posed?
- Stability of optimal sets: given a minimizer Ω_0^* for the Dirichlet energy in the linear case, is Ω_0^* still a minimizer when considering a "small enough" non-linear perturbation of the problem?

This article is organized as follows: the main results, related to the existence of optimal shapes for Problem (1.3) and the criticality/stability of the ball are gathered in Section 2. Section 3 is dedicated to the proofs of the existence results whereas Section 4 is dedicated to the proofs of the stability results.

1.2. The shape optimization problem

In what follows, we consider a modified version of the problem described above, where the involved PDE constraint is now nonlinear.

$$u_{\Omega} = \operatorname*{argmin}_{u \in W_0^{1,2}(\Omega)} \left\{ \frac{1}{2} \int_{\Omega} |\nabla u_{\Omega}|^2 - \int_{\Omega} g u_{\Omega} \right\}.$$

$$\forall n \in \mathbb{N}, \ \Omega \cup \omega_n \text{ is open} \quad \text{ and } \quad \lim_{n \to +\infty} \operatorname{cap}(\omega_n) = 0$$

Let $d \in \mathbb{N}^*$, D be a compact set of \mathbb{R}^d with a \mathscr{C}^2 boundary, $g \in L^p(D)$ where $p > \frac{d}{2}$ and $p \geqslant 2$, and $f \in W^{1,\infty}(\mathbb{R})$. For a small enough positive parameter ρ , let $u_{\Omega} \in W_0^{1,2}(\Omega)$ be the unique solution of the problem

$$\begin{cases} -\Delta u_{\rho,\Omega} + \rho f(u_{\rho,\Omega}) = g & \text{in } \Omega \\ u_{\rho,\Omega} \in W_0^{1,2}(\Omega). \end{cases}$$
 (1.2)

For $m \leq |D|$, solve the problem:

$$\inf_{\Omega \in \mathcal{O}_m} J_{\rho}(\Omega) \quad \text{where } J_{\rho}(\Omega) = \frac{1}{2} \int_{\Omega} |\nabla u_{\rho,\Omega}|^2 - \int_{\Omega} g u_{\rho,\Omega}, \tag{1.3}$$

and where \mathcal{O}_m is defined in (1.1).

Remark 1.1. The assumption $p > \frac{d}{2}$ guarantees that that the embedding $W^{2,p}(D) \hookrightarrow L^{\infty}(D)$ holds and is continuous. It will be used here to obtain regularity properties (see Lem. 2.2), namely, that the solutions of the involved elliptic PDEs belong to $L^{\infty}(D)$. This is for instance true whenever $g \in L^2(D)$ and d = 2, 3. The assumption $p \geqslant 2$ ensures that $g \in L^2(D)$, which enables us to work directly with the weak formulation of the equations in $W_0^{1,2}(\Omega)$ or later in $W_0^{1,2}(D)$.

In this problem, the smallness assumption on the parameter ρ guarantees the well-posedness of the PDE problem (1.2) for generic choices of nonlinearities f.

Lemma 1.2. There exists $\underline{\rho} > 0$ such that, for any $\Omega \in \mathcal{O}_m$, for any $\rho \in [0,\underline{\rho})$, equation (1.2), understood through its variational formulation, has a unique solution in $W_0^{1,2}(\Omega)$.

This follows from a simple fixed-point argument: let $\lambda_1(\Omega)$ be the first eigenvalue of the Dirichlet Laplacian on Ω . We note that the operator

$$T: W_0^{1,2}(\Omega) \longrightarrow W_0^{1,2}(\Omega)$$

 $u \longmapsto w_{\Omega},$

where w_{Ω} is the unique solution of

$$\begin{cases} -\Delta w - g = -\rho f(u) & \text{in } \Omega \\ w \in W_0^{1,2}(\Omega), \end{cases}$$

is Lipschitz with Lipschitz constant $C_T(\Omega)$ such that $C_T(\Omega) \leqslant \rho \frac{1}{\lambda_1(\Omega)} ||f||_{W^{1,\infty}}$. By the monotonicity of λ_1 with respect to domain inclusion (see [11]), we have, for every $\Omega \in \mathcal{O}_m$, $\lambda_1(D) \leqslant \lambda_1(\Omega)$, so that $C_T(\Omega) \leqslant \frac{\rho ||f||_{W^{1,\infty}}}{\lambda_1(D)}$.

2. Main results of the paper

2.1. Existence results

We state hereafter a partial existence result inherited from the linear case. Indeed, we will exploit a monotonicity property of the shape functional J_{ρ} together with its lower-semi continuity for the γ -convergence to apply the classical theorem by Buttazzo-DalMaso (see Sect. 3.1). Our approach takes advantage of the analysis of a relaxed formulation of problem (1.3). To introduce it, let us first consider the given box $D \subset \mathbb{R}^n$ (which we recall is compact subset of \mathbb{R}^n with a \mathscr{C}^2 boundary) such that |D| > m.

In the minimization problem (1.3), let us identify a shape Ω with its characteristic function $\mathbb{1}_{\Omega}$. This leads to introducing the "relaxation" set

$$\widehat{\mathcal{O}}_m = \left\{ a \in L^{\infty}(D, [0, 1]) \text{ such that } \int_D a \leqslant m \right\}$$

For a given positive relaxation parameter M, we define the (relaxed) functional $\hat{J}_{M,\rho}$ by

$$\hat{J}_{M,\rho}(a) = \frac{1}{2} \int_{D} |\nabla u_{M,\rho,a}|^2 + \frac{M}{2} \int_{D} (1-a)u_{M,\rho,a}^2 - \int_{D} gu_{M,\rho,a}, \tag{2.1}$$

for every $a \in \widehat{\mathcal{O}}_m$, where $u_{M,\rho,a} \in W_0^{1,2}(D)$ denotes the unique solution of the non-linear problem

$$\begin{cases} -\Delta u_{M,\rho,a} + M(1-a)u_{M,\rho,a} + \rho f(u_{M,\rho,a}) = g & \text{in } D \\ u_{M,\rho,a} \in W_0^{1,2}(D). \end{cases}$$
 (2.2)

Our existence result involves a careful asymptotic analysis of $u_{M,\rho,a}$ as $\rho \to 0$ to derive a monotonicity property. Standard elliptic estimates entail that, for every M>0 and $a\in\widehat{\mathcal{O}}_m$, one has $u_{M,\rho,a}\in\mathscr{C}^0(\overline{\Omega})$.

Remark 2.1. Such an approximation of $u_{\rho,\Omega}$ is rather standard in the framework of fictitious domains. The introduction of the term M(1-a) in the PDE has an interpretation in terms of porous materials (see e.g. [8]) and it may be expected that $u_{M,\rho,a}$ converges in some sense to $u_{\rho,\Omega}$ as $M \to +\infty$ and whenever $a = \mathbb{1}_{\Omega}$. This will be confirmed in the analysis to follow.

Roughly speaking, the existence result stated in what follows requires the right-hand side of equation (1.2) to have a constant sign. To write the hypothesis down, we need a few notations related to the relaxed problem (2.2), which is the purpose of the next lemma.

Lemma 2.2. Let $m \in [0, |D|]$, $a \in \widehat{\mathcal{O}}_m$ and $g \in L^p(D)$ with $p > \frac{d}{2}$, $p \ge 2$, be a nonnegative function. There exists a positive constant $N_{m,g}$ such that

$$\forall a \in \widehat{\mathcal{O}}_m, \forall M > 0, \forall \rho \in [0, \underline{\rho}), \quad \|u_{M,\rho,a}\|_{\infty} \leqslant N_{m,g}, \tag{2.3}$$

where $\underline{\rho}$ is defined in Lemma 1.2, $u_{M,\rho,a}$ denotes the unique solution to (2.2). In what follows, $N_{m,g}$ will denote the optimal constant in the inequality above, namely

$$N_{m,g} = \sup\{\|u_{M,\rho,a}\|_{\infty}, \ a \in \widehat{\mathcal{O}}_m, M > 0, \rho \in [0,\underline{\rho})\}.$$

This follows from standard arguments postponed to Appendix A.

We now state the main results of this section. Let us introduce the assumptions we will consider hereafter:

- (**H**₁) There exist two positive numbers g_0 , g_1 such that $g_0 < g_1$ and $g_0 \le g(\cdot) \le g_1$ a.e. in D.
- (**H₂**) One has $f \in W^{1,\infty}(\mathbb{R}) \cap \mathcal{D}^2(\mathbb{R})$, where $\mathcal{D}^2(\mathbb{R})$ is the set of twice differentiable functions (with second derivatives not necessarily continuous). Moreover, $f(0) \leq 0$ and there exists $\delta > 0$ such that the mapping $x \mapsto x f(x)$ is non-decreasing on $[0, N_{m,g} + \delta]$ where $N_{m,g}$ is given by Lemma 2.2.

Theorem 2.3. Let us assume that one of the following assumptions holds true:

- g or -g satisfies assumption $(\mathbf{H_1})$;
- g is non-negative, $g \in L^p(D)$ with $p > \frac{d}{2}$ and $p \ge 2$, and the function f satisfies assumption $(\mathbf{H_2})$ or g is non-positive, $g \in L^p(D)$ with $p > \frac{d}{2}$ and $p \ge 2$, and the function -f satisfies assumption $(\mathbf{H_2})$;

Then, there exists a positive constant $\rho_0 = \rho_0(D, f(0), ||f||_{W^{1,\infty}}, g_0, g_1)$ such that the shape optimization problem (1.3) has a solution Ω^* for every $\rho \in (0, \rho_0)$.

Furthermore, there exists at least one optimal shape Ω^* such that $|\Omega^*| = m$.

Remark 2.4. The proof of Theorem 2.3 rests upon a monotonicity property of the relaxed functional $J_{M,\rho}$ given by (2.1). This is the first ingredient that subsequently allows the well-known existence result of Buttazzo and Dal-Maso to be applied.

It is natural to wonder whether or not it would be possible to obtain this result in a more direct way, for instance by using shape derivatives to obtain a monotonicity property. In other words, an idea could be to consider, for a set E, and for a regular vector field $V : \mathbb{R}^n \to \mathbb{R}^n$, the shape derivative

$$\lim_{\varepsilon \to 0} \frac{J_{\rho}((\operatorname{Id} + \varepsilon V)E) - J_{\rho}(E)}{\varepsilon}$$

and to prove that this quantity is positive for any vector field enlarging the domain (basically such that $V \cdot \nu > 0$ on ∂E if E is regular). Writing in a tractable way this shape derivative would require some minimal regularity for the sets under consideration. Thus our approach seems more natural since it allows to handle the general case of quasi-open sets.

It is interesting to note that Theorem 2.3 also yields an existence result when restricting ourselves to the set $\tilde{\mathcal{O}}_m := \{\Omega \text{ quasi-open}, \Omega \subset D, |\Omega| = m\}$, since Theorem 2.3 ensures that, under the appropriate assumption, there exists an optimizer fulfilling the volume constraint.

We end this section by providing an example where existence within the class of open sets does not hold. It thus shows that it is in general hopeless to get a general existence property for this kind of problem, even by assuming stronger regularity on f and g. Let us consider the case where g = 0 and the function f is such that

$$f(0) < 0$$
 and $x \mapsto x f(x)$ is decreasing. (H₄)

An example of such f is $f(x) = -e^{x^2}$. In order to make it a globally $W^{1,\infty}(\mathbb{R})$ function, one can truncate f outside of a large interval [-M, M] and retain Property $(\mathbf{H_4})$.

Theorem 2.5. If g = 0 and f satisfies $(\mathbf{H_4})$, if the optimization problem (1.3) has a solution Ω , then Ω has no interior point. In particular, the problem of minimizing $J_{\rho}(\Omega)$ given by (1.3) over the set of non-empty open domains Ω such that $|\Omega| \leq m$ has no solution.

Remark 2.6. As will be emphasized in the proof of Theorem 2.5, the key ingredient is the use of topological derivatives. More precisely, we will argue by contradiction that, under the assumptions that g = 0 and f satisfies (\mathbf{H}_4) , if a maximiser Ω^* exists and has an interior point x_0 , then for $\varepsilon > 0$ small enough, the set $\Omega^*_{\varepsilon} := \Omega^* \setminus \mathbb{B}(x_0; \varepsilon)$ satisfies $J_{\rho}(\Omega^*_{\varepsilon}) < J_{\rho}(\Omega^*)$.

2.2. Stability results

In what follows, we will work in \mathbb{R}^2 . We assume that D is a centered ball $D = \mathbb{B}(0, R_D)$ strictly containing a centered ball $\mathbb{B}^* = \mathbb{B}(0, R)$ of volume m, in other words we assume that $R < R_D$. We denote by R > 0 the radius of \mathbb{B}^* and introduce $\mathbb{S}^* = \partial \mathbb{B}^*$. The notation ν stands for the outward unit vector on \mathbb{S}^* , in other words $\nu(x) = x/|x|$ for all $x \in \mathbb{S}^*$.

In this section, we will discuss the local optimality of the ball for small nonlinearities. We will in particular highlight that the local optimality of the ball can be either preserved or lost depending on the choice of the right-hand side g. Indeed, if $\rho = 0$ and if g is radially symmetric and non-increasing, the Schwarz rearrangement³ ensures that, for any $\Omega \in \mathcal{O}_m$, $J_0(\Omega) \geqslant J_0(\mathbb{B}^*)$. Without such assumptions, not much is known about the qualitative properties of the optimizers.

According to the considerations above, we assume in the whole section that the following hypothesis holds:

(**H₃**) $D = \mathbb{B}(0, R_D)$ is a ball containing $\mathbb{B}^* = \mathbb{B}(0, R)$, $|\mathbb{B}^*| = m$, $R < R_D$, g is a non-increasing, radially symmetric and non-negative function in $L^2(D)$ and f is $\mathscr{C}^2(\mathbb{R}) \cap W^{1,\infty}(\mathbb{R})$.

Notice that the analysis to follow can be generalized to sign-changing g. Here, this assumption allows us to avoid distinguishing between the cases where the signs of normal derivatives on \mathbb{S}^* are positive or negative. For the sake of simplicity, for every $\rho \geqslant 0$, we will call u_{ρ} the solution of the PDE

$$\begin{cases}
-\Delta u_{\rho} + \rho f(u_{\rho}) = g & \text{in } \mathbb{B}^* \\
u_{\rho} \in W_0^{1,2}(\mathbb{B}^*) & \text{on } \partial \mathbb{B}^* = \mathbb{S}^*.
\end{cases}$$
(2.4)

Proving a full stationarity result⁴ seems too intricate, since we do not know the minimizers' topology. Hereafter, we investigate the local stability of the ball \mathbb{B}^* : we will prove that the ball is always a critical point, and show that we obtain different stability results, related to the non-negativity of the second shape derivative of the Lagrangian, depending on f and g.

To compute the first and second order shape derivatives, it is convenient to consider vector fields $V \in W^{3,\infty}(\mathbb{R}^2,\mathbb{R}^2)$ and to introduce, for a given vector field V in $W^{3,\infty}$ (note that since $\mathbb{B}^* \subsetneq D$, one has $(\mathrm{Id} + tV)\mathbb{B}^* \in \mathcal{O}_m$ for t small enough), the mapping

$$f_V: t \mapsto J_\rho\left((\operatorname{Id} + tV)\mathbb{B}^*\right).$$

The first (resp. second) order shape derivative of J_{ρ} in the direction V is defined as

$$J'_{\rho}(\mathbb{B}^*)[V] := f'_{V}(0), (\text{resp. } J''_{\rho}(\mathbb{B}^*)[V, V] := f''_{V}(0)).$$

To enforce the volume constraint $|\Omega| = m$, we work with the unconstrained functional

$$\mathcal{L}_{\Lambda_{\rho}}: \Omega \mapsto J_{\rho}(\Omega) - \Lambda_{\rho} \left(\operatorname{Vol}(\Omega) - m \right),$$

where Vol denotes the Lebesgue measure in \mathbb{R}^2 and Λ_{ρ} denotes a Lagrange multiplier associated with the volume constraint. Recall that, for every domain Ω with a \mathscr{C}^2 boundary and every vector field $V \in W^{3,\infty}(\mathbb{R}^2,\mathbb{R}^2)$, we have

$$\operatorname{Vol}'(\Omega)[V] = \int_{\partial\Omega} V \cdot \nu \quad \text{and} \quad \operatorname{Vol}''(\Omega)[V,V] = \int_{\partial\Omega} H(V \cdot \nu)^2,$$

where H stands for the mean curvature of $\partial\Omega$. The local first and second order necessary optimality conditions for problem (1.3) read as follow:

$$\left. \begin{array}{l} \mathcal{L}'_{\Lambda_{\rho}}(\Omega)[V] = 0 \\ \mathcal{L}''_{\Lambda_{\rho}}(\Omega)[V,V] \geqslant 0 \end{array} \right\} \ \, \text{for every} \, \, V \in W^{3,\infty}(\mathbb{R}^2,\mathbb{R}^2) \, \, \text{such that} \, \, \int_{\mathbb{S}^*} V \cdot \nu = 0. \end{array}$$

For further informations about shape derivatives, we refer for instance to [13], Chapitre 5. Let us state the main result of this section. In what follows, ρ is chosen small enough so that equation (1.2) has a unique solution.

Theorem 2.7. Let f and g satisfying the assumption $(\mathbf{H_3})$. Let $V \in W^{3,\infty}(\mathbb{R}^2,\mathbb{R}^2)$ denote a vector field such that $\int_{\mathbb{R}^*} V \cdot \nu = 0$.

1. (Shape criticality) \mathbb{B}^* is a critical shape, in other words $J'_{o}(\mathbb{B}^*)[V] = 0$.

 $[\]overline{}^{4}$ in other words, proving that, for any $\rho \leqslant \rho^{*}$, \mathbb{B}^{*} is the unique minimizer of J_{ρ} in \mathcal{O}_{m} .

2. (Shape stability) Assume that

$$2\pi R^2 g(R) \leqslant \int_{\mathbb{B}^*} g \quad and \quad 0 < \int_{\mathbb{B}^*} g, \tag{2.5}$$

where R denotes the radius of the ball \mathbb{B}^* . Let Λ_{ρ} be the Lagrange multiplier associated with the volume constraint. There exists $\overline{\rho} > 0$ and C > 0 such that, for any $\rho \leqslant \overline{\rho}$,

$$(J_{\rho} - \Lambda_{\rho} \operatorname{Vol})''(\mathbb{B}^*)[V, V] \geqslant C \|V \cdot \nu\|_{H^{\frac{1}{2}}(\partial \mathbb{B}^*)}^2.$$
 (2.6)

3. (Shape instability) Assume that g is the constant function equal to 1 and that f is a non-negative function such that f' < -1 on $[0,2||u_0||_{\infty})$, where u_0 is the solution of (1.2) with $\rho = 0$ and $\Omega = \mathbb{B}^*$. Then, the second order optimality conditions are not fulfilled on \mathbb{B}^* : there exists $\overline{\rho} > 0$ and $\hat{V} \in W^{3,\infty}(\mathbb{R}^2,\mathbb{R}^2)$ such that $\int_{\mathbb{S}^*} \hat{V} \cdot \nu = 0$ and, for any $\rho \leq \overline{\rho}$,

$$(J_{\rho} - \Lambda_{\rho} \operatorname{Vol})''(\mathbb{B}^*)[\hat{V}, \hat{V}] < 0.$$

Remark 2.8. Although we do not tackle this issue in this article, we believe that the coercivity norm obtained in (2.6) could also be obtained in the three-dimensional case. We comment on it in Remark 4.11.

Remark 2.9. Let us comment on the strategy of proof. It is known that estimates of the kind (2.6) can lead to local quantitative inequalities [5]. We first establish (2.6) in the case $\rho = 0$, and then extend it to small parameters ρ with the help of a perturbation argument. Assumptions of the type (2.5) are fairly well-known, and amount to requiring that \mathbb{B}^* is a stable shape minimizer [6, 14]. Finally, the instability result rests upon the following observation: if g = 1 and if V is the vector field given by $V(r\cos(\theta), r\sin(\theta)) = \cos(\theta)(r\cos(\theta), r\sin(\theta))$, then one has

$$(J_0'' - \Lambda_0 \text{ Vol})''(\mathbb{B}^*)[V, V] = 0$$

while higher order modes are stable [6, 14]. It therefore seems natural to consider such perturbations when dealing with small parameters ρ .

It should also be noted that our proof uses a comparison principle, which shortens many otherwise lengthy computations.

Remark 2.10. The $H^{1/2}$ coercivity norm obtained for the second order shape derivative of the Lagrangian in Estimate (2.6) is the natural one in the framework of shape optimization, see for instance [5]. We emphasize that in the case of the functional under study here, completely explicit computations are not available, but that we obtain this norm through a very careful analysis of the diagonalized shape hessian, using comparison principles.

Although this is not the primary focus of this article, we believe that, with this coercivity property at hand, one can apply the techniques and results of [5] to derive a local quantitative inequality at the ball.

3. Proof of Theorem 2.3

3.1. General outline of the proof

The proof of Theorem 2.3 rests upon an adaptation of the standard existence result by Buttazzo-DalMaso (see either the original article [2] or [13], Thm 4.7.6 for a proof), based on the notion of γ -convergence, that we recall below.

Definition 3.1. For any quasi-open set Ω , let R_{Ω} be the resolvent of the Laplace operator on Ω . We say that a sequence of quasi-open sets $(\Omega_k)_{k\in\mathbb{N}}$ in \mathcal{O}_m γ -converges to $\Omega\in\mathcal{O}_m$ if, for any $\ell\in W^{-1,2}(D)$, $(R_{\Omega_k}(\ell))_{k\in\mathbb{N}}$ converges in $W_0^{1,2}(D)$ to $R_{\Omega}(\ell)$.

The aforementioned existence theorem reads as follows.

Theorem (Buttazzo-DalMaso). Let $J: \mathcal{O}_m \to \mathbb{R}$ be a shape functional satisfying the two following assumptions:

- 1. (monotonicity) For every $\Omega_1, \Omega_2 \in \mathcal{O}_m, \Omega_1 \subseteq \Omega_2 \Rightarrow J(\Omega_2) \leqslant J(\Omega_1)$.
- 2. $(\gamma$ -continuity) J is lover semi-continuous for the γ -convergence.

Then the shape optimization problem

$$\inf_{\Omega \in \mathcal{O}_m} J(\Omega)$$

has a solution.

As is customary when using this result, the lower semi-continuity for the γ -convergence is valid regardless of any sign assumptions on g or of any additional hypothesis on f. This is the content of the next result, whose proof is standard, and thus postponed to Appendix B.

Proposition 3.2. Let $f \in W^{1,\infty}(\mathbb{R})$ and $\rho \geqslant 0$. The functional J_{ρ} is continuous for the γ -convergence.

It hence remains to investigate the monotonicity of J_{ρ} . Our approach uses a relaxed version of J_{ρ} , namely the functional $\hat{J}_{M,\rho}$ defined by (2.1). More precisely, we will prove under suitable assumptions that

$$\forall M \geqslant 0, \forall a_1, a_2 \in \widehat{\mathcal{O}}_m, a_1 \leqslant a_2 \Longrightarrow \widehat{J}_{M,\rho}(a_1) \geqslant \widehat{J}_{M,\rho}(a_2). \tag{3.1}$$

It now remains to pass to the limit in (3.1) to obtain monotonicity of the functional J_{ρ} . One could expect, for any $\Omega \in \mathcal{O}_m$, that choosing $a = \mathbb{1}_{\Omega}$ and taking the limit $M \to \infty$ would give

$$\hat{J}_{M,\rho}(\mathbb{1}_{\Omega}) \xrightarrow[M \to +\infty]{} J_{\rho}(\mathbb{1}_{\Omega}).$$

This is not true in general, but it holds for sets Ω that are *stable*, see [13], Theorem 3.4.6; we recall that a set Ω is said to be stable if, for any $w \in W^{1,2}(D)$, the property "w = 0 almost-everywhere on $D \setminus \Omega$ " is equivalent to the property "w = 0 quasi-everywhere on $D \setminus \Omega$ ". We underline the fact that, if Ω_1 and Ω_2 are two admissible sets that are equal almost everywhere but not quasi-everywhere, we expect the limits $\lim_{M\to\infty} J_{M,\rho}(\mathbb{1}_{\Omega_1})$ and $\lim_{M\to\infty} J_{M,\rho}(\mathbb{1}_{\Omega_2})$ to be equal. Our strategy is then to first use this relaxation to prove that the functional J_{ρ} is monotonous on the set of stable quasi-open sets and then to use the continuity of J_{ρ} with respect to the γ -convergence to establish its monotonicity on \mathcal{O}_m .

Using the relaxation for stable quasi-open sets The following result, whose proof is postponed to Appendix C for the sake of clarity, allows us to make the link between $\hat{J}_{M,\rho}$ and J_{ρ} .

Lemma 3.3. Let $\Omega \in \mathcal{O}_m$ be a stable quasi-open set. One has

$$\lim_{M \to +\infty} \hat{J}_{M,\rho}(\mathbb{1}_{\Omega}) = J_{\rho}(\Omega).$$

Setting $a_1 = \mathbb{1}_{\Omega_1}$, $a_2 = \mathbb{1}_{\Omega_2}$, and passing to the limit in (3.1) as $M \to \infty$ gives the monotonicity of J_{ρ} on the set

$$\mathcal{O}_{m,s} := \{ \Omega \in \mathcal{O}_m, \Omega \text{ is stable} \}.$$

Passing from stable quasi-open sets to \mathcal{O}_m The monotonicity of J_ρ on \mathcal{O}_m is established using the following Lemma, whose proof is postponed to Appendix D:

Lemma 3.4. If J_{ρ} is monotonous on $\mathcal{O}_{m,s}$, then it is monotonous on \mathcal{O}_{m} .

Combining Lemma 3.4 with Lemma 3.3 and equation (3.1) gives the required monotonicity of the functional J_{ρ} .

In the next sections, we will concentrate on showing the monotonicity property (3.1). To this aim, we will carefully analyze the so-called "switching function" (representing the gradient of the functional $\hat{J}_{M,\rho}$).

3.2. Structure of the switching function

It is notable that, in this section, we will not make any assumption on g or f other than $f \in W^{1,\infty}(\mathbb{R})$ and $g \in L^2(D)$. Let M > 0. Considering the following relaxed version of Problem (1.3)

$$\inf_{a \in \widehat{\mathcal{O}}_m} \widehat{J}_{M,\rho}(a), \tag{3.2}$$

it is convenient to introduce the set of admissible perturbations in view of deriving first order optimality conditions.

Definition 3.5 (tangent cone, see e.g. [4]). Let $a^* \in \widehat{\mathcal{O}}_m$ and \mathcal{T}_{a^*} be the tangent cone to the set $\widehat{\mathcal{O}}_m$ at a^* . The cone \mathcal{T}_{a^*} is the set of functions $h \in L^{\infty}(D)$ such that, for any sequence of positive real numbers ε_n decreasing to 0, there exists a sequence of functions $h_n \in L^{\infty}(D)$ converging to h for the weak-star topology of $L^{\infty}(D)$ as $n \to +\infty$, and $a^* + \varepsilon_n h_n \in \widehat{\mathcal{O}}_m$ for every $n \in \mathbb{N}$.

In what follows, for any $a \in \widehat{\mathcal{O}}_m$, any element h of the tangent cone \mathcal{T}_a will be called an admissible direction.

Lemma 3.6 (Differential of $\hat{J}_{M,\rho}$). Let $a \in \widehat{\mathcal{O}}_m$ and $h \in \mathcal{T}_a$. Let $v_{M,\rho,a}$ be the unique solution of

$$\begin{cases} -\Delta v_{M,\rho,a} + M(1-a)v_{M,\rho,a} + \rho f'(u_{M,\rho,a})v_{M,\rho,a} = \rho f(u_{M,a}) & in \ D \\ v_{M,\rho,a} \in W_0^{1,2}(D). \end{cases}$$
(3.3)

Then, $\hat{J}_{M,\rho}$ is differentiable in the sense of Fréchet at a in the direction h and its differential reads $\langle d\hat{J}_{M,\rho}(a),h\rangle = \int_D h\Psi_a$, where Ψ_a is the so-called "switching function" defined by

$$\Psi_a = -M \left(v_{M,\rho,a} + \frac{u_{M,\rho,a}}{2} \right) u_{M,\rho,a}.$$

Proof of Lemma 3.6. The Fréchet-differentiability of $\hat{J}_{M,\rho}$ and of the mapping $\mathcal{O}_m \ni a \mapsto u_{M,\rho,a} \in W_0^{1,2}(D)$ at m^* is standard (see e.g. [13], Chap. 5). Let us consider an admissible perturbation h of a and let $\dot{u}_{M,\rho,a}$ be the differential of $u_{M,\rho,a}$ at a in direction h. One has

$$\langle d\hat{J}_{M,\rho}(a), h \rangle = \int_{D} \nabla u_{M,\rho,a} \cdot \nabla \dot{u}_{M,\rho,a} + M \int_{D} (1-a)u_{M,\rho,a} \dot{u}_{M,\rho,a} - \frac{M}{2} \int_{D} h u_{M,\rho,a}^{2} - \int_{D} g \dot{u}_{M,\rho,a},$$

where $\dot{u}_{M,\rho,a}$ solves the system

$$\begin{cases}
-\Delta \dot{u}_{M,\rho,a} + M(1-a)\dot{u} + \rho f'(u_{M,\rho,a})\dot{u}_{M,\rho,a} = Mhu_{M,a} & \text{in } D \\
\dot{u}_{M,\rho,a} \in W_0^{1,2}(D).
\end{cases}$$
(3.4)

Let us multiply the main equation of (2.2) by $\dot{u}_{M,\rho,a}$ and then integrate by parts. We get

$$\int_{D} \nabla u_{M,\rho,a} \cdot \nabla \dot{u}_{M,\rho,a} + M \int_{D} (1-a) u_{M,\rho,a} \dot{u}_{M,\rho,a} + \rho \int_{D} f(u_{M,\rho,a}) \dot{u}_{M,\rho,a} = \int_{D} g \dot{u}_{M,\rho,a}$$

and therefore

$$\langle d\hat{J}_{M,\rho}(a),h\rangle = -\frac{M}{2} \int_{D} h u_{M,\rho,a^*}^2 - \rho \int_{D} f(u_{M,\rho,a^*}) \dot{u}_{M,\rho,a^*}$$

Let us multiply the main equation of (3.4) by $v_{M,\rho,a}$ and then integrate by parts. We get

$$\int_{D} \nabla v_{M,\rho,a} \cdot \nabla \dot{u}_{M,\rho,a} + M \int_{D} (1-a) v_{M,\rho,a} \dot{u}_{M,\rho,a} + \rho \int_{D} f'(u_{M,a}) \dot{u}_{M,a} v_{M,\rho,a} = M \int_{D} h u_{M,a} v_{M,\rho,a}.$$

Similarly, multiplying the main equation of (3.3) by $\dot{u}_{M,\rho,a}$ and then integrating by parts yields

$$\int_{D} \nabla v_{M,\rho,a} \cdot \nabla \dot{u}_{M,\rho,a} + M \int_{D} (1-a)v_{M,\rho,a} \dot{u}_{M,\rho,a} + \rho \int_{D} f'(u_{M,\rho,a}) \dot{u}_{M,\rho,a} v_{M,\rho,a} = \rho \int_{D} f(u_{M,\rho,a}) \dot{u}_{M,\rho,a}.$$

Combining the two relations above leads to

$$\rho \int_D f(u_{M,\rho,a}) \dot{u}_{M,\rho,a} = M \int_D h u_{M,\rho,a} v_{M,\rho,a}.$$

Plugging this relation into the expression of $\langle d\hat{J}_{M,\rho}(a), h \rangle$ above yields the expected conclusion.

3.3. Proof that (3.1) holds true whenever ρ is small enough

Let us consider each set of assumptions separately.

Existence under the first assumption: g or -g satisfies the assumption $(\mathbf{H_1})$.

According to the discussion carried out in Section 3.1, proving Theorem 2.3 boils down to proving monotonicity properties for the functional $\hat{J}_{M,\rho}$ whenever ρ is small enough, which is the purpose of the next result.

Lemma 3.7. Let a_1 and a_2 be two elements of $\widehat{\mathcal{O}}_m$ such that $a_1 \leqslant a_2$ a.e. in D. If g or -g satisfies the assumption $(\mathbf{H_1})$, then there exists $\rho_1 = \rho_1(D, g_0, g_1, ||f||_{W^{1,\infty}}) > 0$ such that

$$\forall M > 0, \quad \forall \rho \in (0, \rho_1) \Rightarrow \hat{J}_{M,\rho}(a_1) \geqslant \hat{J}_{M,\rho}(a_2).$$

Proof of Lemma 3.7. Assume without loss of generality that $0 < g_0 \le g \le g_1$,, the case $0 < g_0 \le -g \le g_1$ being easily inferred by modifying all the signs in the proof below. Then, one has

$$-\Delta u_{M,\rho,a} + M(1-a)u_{M,\rho,a} = g - \rho f(u_{M,\rho,a}) \geqslant 0 \quad \text{in } D,$$

whenever $\rho \in (0, g_0/\|f\|_{\infty})$, and therefore one has $u_{M,\rho,a} \ge 0$ by the comparison principle. Similarly, notice that

$$-\Delta u_{M,\rho,a} \leqslant g_1 + \rho ||f||_{\infty}$$
 in D ,

which implies that $u_{M,\rho,a} \leq (g_1 + \rho \|f\|_{\infty}) w_D$ were w_D is the torsion function of D. By the classical Talenti's estimate of the torsion function [21], we have $\|w_D\|_{\infty} \leq \frac{1}{2d} \left(\frac{|D|}{\omega_d}\right)^{2/d}$ (where ω_d is the volume of the unit ball). Thus

$$||u_{M,\rho,a}||_{\infty} \leqslant (g_1 + \rho||f||_{\infty}) \frac{1}{2d} \left(\frac{|D|}{\omega_d}\right)^{2/d} := C(g_0, \rho, ||f||_{\infty}, D).$$
(3.5)

Setting $U_{M,\rho,a} = \frac{1}{2}u_{M,\rho,a} + v_{M,\rho,a}$, elementary computations show that $U_{M,\rho,a}$ solves the problem

$$\begin{cases} -\Delta U_{M,\rho,a} + (M(1-a) + \rho f'(u_{M,\rho,a})) U_{M,\rho,a} = \frac{\rho}{2} \left(f(u_{M,\rho,a}) + u_{M,\rho,a} f'(u_{M,\rho,a}) \right) + \frac{g}{2} & \text{in } D, \\ U_{M,\rho,a} = 0 & \text{on } \partial D. \end{cases}$$
(3.6)

Before we conclude the proof of Lemma 3.7, we need the following intermediate result on the sign of $U_{M,\rho,a}$.

Lemma 3.8. Let us choose ρ_1 in such a way that

$$\rho_1(\|f\|_{\infty} + C(g_0, \|f\|_{\infty}, D)\|f'\|_{\infty}) < g_0, \quad and \quad \rho_1\|f'\|_{\infty} \leqslant \frac{\lambda_1(D)}{2}, \tag{3.7}$$

where $\lambda_1(D)$ denotes the first eigenvalue of the Dirichlet-Laplacian operator on D and $C(g_0, ||f||_{\infty}, D)$ is given by estimate (3.5). For every $\rho \in [0, \rho_1)$, $U_{M,\rho,a}$ is non-negative in D.

Proof of Lemma 3.8. The result follows immediately from the generalized maximum principle which claims that if a function v satisfies

$$-\Delta v + a(\cdot)v \geqslant 0 \quad \text{with } a(\cdot) > -\lambda_1(D)$$
(3.8)

and v = 0 on ∂D , then $v \ge 0$ a.e. in D. This is readily seen by multiplying the above inequality by the negative part v_- of v and integrating by part. Here we have chosen ρ_1 in such a way that

$$M(1-a) + \rho f'(u_{M,o,a}) \geqslant -\lambda_1(D)$$

and the right-hand side of (3.6) is non-negative which yields the result.

Coming back to the proof of Lemma 3.7, consider $h = a_2 - a_1$. According to the mean value theorem, there exists $\varepsilon \in (0,1)$ such that

$$\hat{J}_{M,\rho}(a_2) - \hat{J}_{M,\rho}(a_1) = \langle d\hat{J}_{M,\rho}(a_1 + \varepsilon h), h \rangle = -M \int_D h u_{M,a_1 + \varepsilon h} U_{M,a_1 + \varepsilon h} \leqslant 0,$$

according to the combination of the analysis above with Lemma 3.6. The expected conclusion follows.

Existence under the second assumption: g is non-negative and the function f satisfies the assumption $(\mathbf{H_2})$ or g is non-positive and the function -f satisfies the assumption $(\mathbf{H_2})$.

The main difference with the previous case is that g might possibly be zero. Deriving the conclusion is therefore trickier and relies on a careful asymptotic analysis of the solution $u_{M,\rho,a}$ as $\rho \to 0$.

Proposition 3.9. There exists $C = C(D, ||f||_{\infty}) > 0$ such that, for any $M \in \mathbb{R}_+$, any $a \in \widehat{\mathcal{O}}_m$, there holds

$$||u_{M,\rho,a} - u_{M,0,a}||_{L^{\infty}(D)} \leqslant C\rho.$$
 (3.9)

Proof. Let us set $z_{\rho} = u_{M,\rho,a} - u_{M,0,a}$ for any $\rho > 0$. A direct computation yields that z_{ρ} satisfies

$$-\Delta z_{\rho} + M(1-a)z_{\rho} = -\rho f(u_{M,\rho,a}).$$

By comparison with the torsion function w_D of D, this implies

$$||z_{\rho}||_{\infty} \leqslant \rho ||f||_{\infty} ||w_D||_{\infty}$$

and the result follows, with a constant C explicit by Talenti's Theorem like in the proof of Lemma 3.7.

Let us consider the switching function $\Psi = -MU_{M,\rho,a}u_{M,\rho,a}$ where $u_{M,\rho,a}$ and $U_{M,\rho,a}$ respectively solve (2.2) and (3.6), and we will prove that both $u_{M,\rho,a}$ and $U_{M,\rho,a}$ are non-negative, so that one can conclude similarly to the previous case.

Lemma 3.10. The functions $u_{M,\rho,a}$ and $U_{M,\rho,a}$ are non-negative whenever ρ is small enough.

Proof. Let us choose ρ such that $\rho \|f'\|_{\infty} < \lambda_1(D)$. Then $u_{M,\rho,a}$ satisfies

$$-\Delta u_{M,\rho,a} + M(1-a)u_{M,\rho,a} + \rho \frac{f(u_{M,\rho,a}) - f(0)}{u_{M,\rho,a}} u_{M,\rho,a} \geqslant g - \rho f(0) \geqslant 0$$

because f satisfies assumption $(\mathbf{H_2})$.

The non-negativity of $u_{M,\rho,a}$ is a consequence of the generalized maximum principle (3.8). Indeed, for ρ small enough, we have

$$M(1-a) + \rho \frac{f(u_{M,\rho,a}) - f(0)}{u_{M,\rho,a}} > -\lambda_1(D).$$

Since $U_{M,\rho,a}$ satisfies (3.6), the proof follows the same lines assuming the $\rho ||f'||_{\infty} < \lambda_1(D)$ and using the assumption (**H**₂) to get non-negativity of the right-hand side. By mimicking the reasoning done at the end of the first case, one gets that (3.1) is true if ρ is small enough.

Thus, in both cases, the monotonicity of the functional is established, so that the theorem of Buttazzo and Dal Maso applies: there exists a solution $\Omega^* \in \mathcal{O}_m$ of (1.3). The fact that there exists at least one optimizer Ω^* such that $|\Omega^*| = m$ is a simple consequence of the monotonicity of the functional.

3.4. Proof of Theorem 2.5: non-existence of regular optimal domains for some (q, f)

This proof is based on the use of topological derivatives of shape functionals [19]. Let us assume the existence of a minimizer Ω of J_{ρ} in \mathcal{O}_m and of an interior point x_0 in Ω . Notice that existence of such a point x_0 is not guaranteed for general quasi-open sets, see *e.g.* [22, Remark 4.4.7].

Let us perform a small circular hole within the domain: let $\Omega_{\varepsilon} = \Omega \setminus \mathbb{B}(x_0, \varepsilon)$ where $\varepsilon > 0$ is small enough so that $\Omega_{\varepsilon} \subset \Omega$.

Following [9, 15], the following asymptotic expansion of J_{ρ} holds:

$$J_{\rho}(\Omega_{\varepsilon}) = J_{\rho}(\Omega) + \pi \varepsilon^{2} u_{\rho,\Omega}(x_{0}) U_{\rho,\Omega}(x_{0}) + o(\varepsilon^{2}), \tag{3.10}$$

where $u_{\rho,\Omega}$ solves (1.2) and $U_{\rho,\Omega}$, the adjoint state, solves

$$\begin{cases}
-\Delta U_{\rho,\Omega} + \rho f'(u_{\rho,\Omega})U_{\rho,\Omega} = \frac{\rho}{2} \left(f(u_{\rho,\Omega}) + u_{\rho,\Omega} f'(u_{\rho,\Omega}) \right) & \text{in } \Omega \\
U_{\rho,\Omega} \in W_0^{1,2}(\Omega).
\end{cases}$$
(3.11)

Since $u_{\rho,\Omega}$ satisfies

$$-\Delta u_{\rho,\Omega} + \rho \frac{f(u_{\rho,\Omega}) - f(0)}{u_{\rho,\Omega}} u_{\rho,\Omega} = -\rho f(0) > 0$$

according to assumption ($\mathbf{H_4}$) and since x_0 is an interior point, it follows from the strong maximum principle that one has $u_{\rho,\Omega}(x_0) > 0$.

On the other hand, assumption $(\mathbf{H_4})$ ensures that

$$-\Delta U_{\rho,\Omega} + \rho f'(u_{\rho,\Omega})U_{\rho,\Omega} < 0$$

so that $U_{\rho,\Omega}(x_0) < 0$. As a consequence, for $\varepsilon > 0$ small enough, we have

$$J_{\rho}(\Omega_{\varepsilon}) < J_{\rho}(\Omega),$$

leading to a contradiction with the minimality of Ω .

Remark 3.11. It is interesting to observe that the asymptotic expansion (3.10) can be formally obtained by using the relaxation method: for a given M > 0, for $a = \mathbb{1}_{\Omega}$ and $h_{\varepsilon} := -\mathbb{1}_{\mathbb{B}(x_0, \varepsilon)}$, Lemma 3.6 yields

$$\langle d\hat{J}_{M,\rho}(a), h_{\varepsilon} \rangle = -\int_{D} h_{\varepsilon} u_{M,\rho,a} U_{M,\rho,a} = \int_{\mathbb{B}(x_{0},\varepsilon)} u_{M,\rho,a} U_{M,\rho,a} \underset{\varepsilon \to 0}{\approx} \pi \varepsilon^{2} u_{M,\rho,a}(x_{0}) U_{M,\rho,a}(x_{0}).$$

Passing to the limit $M \to \infty$ provides the expected expression. Of course, such a method is purely formal.

4. Proof of Theorem 2.7

Note first that the functional J_{ρ} is shape differentiable, which follows from standard arguments, see e.g. [13], Chapitre 5.

Our proof of Theorem 2.7 is divided into two steps: after proving the criticality of \mathbb{B}^* for ρ small enough, we compute the second order shape derivative of the Lagrangian associated with the problem at the ball. Next, we establish that, under Assumption (2.5), there exists a positive constant C_0 such that, for any regular V, one has

$$(J_0 - \Lambda_0 \operatorname{Vol})''(\mathbb{B}^*)[V, V] \geqslant C_0 \|V \cdot \nu\|_{L^2(\Omega)}^2.$$
(4.1)

Finally, we prove that, for any radially symmetric, non-increasing non-negative g, there exists $M \in \mathbb{R}$ such that, for any admissible V, one has

$$(J_{\rho} - \Lambda_{\rho} \operatorname{Vol})''(\mathbb{B}^{*})[V, V] \geqslant (J_{0} - \Lambda_{0} \operatorname{Vol})''(\mathbb{B}^{*})[V, V] - M\rho \|V \cdot \nu\|_{L^{2}(\Omega)}^{2}. \tag{4.2}$$

Local shape minimality of \mathbb{B}^* for ρ small enough can then be inferred in a straightforward way.

If V is an admissible vector field, we will denote by $u'_{\rho,V}$ and $u''_{\rho,V}$ the first and second order (eulerian) shape derivatives of u_{ρ} at \mathbb{B}^* with respect to V.

4.1. Preliminary material

Lemma 4.1. Under the assumptions of Theorem 2.7, i.e. when g is radially symmetric and non-increasing function, for ρ small enough, the function u_{ρ} is radially symmetric nonincreasing. We write it $u_{\rho} = \varphi_{\rho}(|\cdot|)$. Furthermore, if $\rho = 0$, one has

$$-\frac{\partial u_0}{\partial \nu} \geqslant \frac{R}{2}g(R).$$

Proof of Lemma 4.1. The fact that u_{ρ} is a radially symmetric nonincreasing function follows from a simple application of the Schwarz rearrangement. Integrating the equation on the ball \mathbb{B}^* yields

$$-\int_{\mathbb{R}^*} \Delta u_0 = -\int_{\partial \mathbb{R}^*} \frac{\partial u_0}{\partial \nu} = -2\pi R \frac{\partial u_0}{\partial \nu}$$

on the one-hand, while using the fact that g is decreasing:

$$-\int_{\mathbb{B}^*} \Delta u_0 = \int_{\mathbb{B}^*} g \geqslant 2\pi g(R) \int_0^R r dr = \pi R^2 g(R)$$

By differentiating the main equation (1.2) with respect to the domain and the boundary conditions (see e.g. [13], Chapt. 5), we get that the functions $u'_{\rho,V}$ and $u''_{\rho,V}$ satisfy

$$\begin{cases}
-\Delta u'_{\rho,V} + \rho f'(u_{\rho}) u'_{\rho,V} = 0 & \text{in } \mathbb{B}^* \\
u'_{\rho,V} = -\frac{\partial u_{\rho}}{\partial \nu} V \cdot \nu & \text{on } \partial \mathbb{B}^*
\end{cases}$$
(4.3)

and

$$\begin{cases}
-\Delta u_{\rho,V}'' + \rho f'(u_{\rho}) u_{\rho,V}'' + \rho f''(u_{\rho}) (u_{\rho,V}')^2 = 0 & \text{in } \mathbb{B}^* \\
u_{\rho,V}'' = -2 \frac{\partial u_{\rho,V}'}{\partial \nu} V \cdot \nu - (V \cdot \nu)^2 \frac{\partial^2 u_{\rho}}{\partial \nu^2} & \text{on } \partial \mathbb{B}^*.
\end{cases}$$
(4.4)

4.2. Proof of the shape criticality of the ball

Proving the shape criticality of the ball boils down to showing the existence of a Lagrange multiplier $\Lambda_{\rho} \in \mathbb{R}$ such that for every admissible vector field $V \in W^{3,\infty}(\mathbb{R}^2,\mathbb{R}^2)$, one has

$$(J_{\rho} - \Lambda_{\rho} \operatorname{Vol})'(\mathbb{B}^*)[V] = 0 \tag{4.5}$$

Standard computations (see e.g. [13], chapt. 5) yield

$$\begin{split} J_{\rho}'(\mathbb{B}^*)[V] &= \int_{\mathbb{B}^*} \langle \nabla u_{\rho}, \nabla u_{\rho,V}' \rangle - \int_{\mathbb{B}^*} g u_{\rho,V}' + \int_{\mathbb{S}^*} \frac{1}{2} |\nabla u_{\rho}|^2 V \cdot \nu \\ &= \int_{\mathbb{S}^*} u_{\rho,V}' \frac{\partial u_{\rho}}{\partial \nu} - \rho \int_{\mathbb{B}^*} u_{\rho,V}' f(u_{\rho}) + \int_{\mathbb{S}^*} \frac{1}{2} |\nabla u_{\rho}|^2 V \cdot \nu \\ &= - \int_{\mathbb{S}^*} \left(\frac{\partial u_{\rho}}{\partial \nu} \right)^2 V \cdot \nu + \int_{\mathbb{S}^*} \frac{1}{2} |\nabla u_{\rho}|^2 V \cdot \nu - \rho \int_{\mathbb{B}^*} u_{\rho,V}' f(u_{\rho}) \\ &= - \frac{1}{2} \int_{\mathbb{S}^*} |\nabla u_{\rho}|^2 V \cdot \nu - \rho \int_{\mathbb{B}^*} u_{\rho,V}' f(u_{\rho}). \end{split}$$

We introduce the adjoint state p_{ρ} as the unique solution of

$$\begin{cases}
-\Delta p_{\rho} + \rho p_{\rho} f'(u_{\rho}) + \rho f(u_{\rho}) = 0 & \text{in } \mathbb{B}^* \\
p_{\rho} = 0 & \text{on } \mathbb{S}^*.
\end{cases}$$
(4.6)

П

Since u_{ρ} is radially symmetric, so is p_{ρ} . Multiplying the main equation of (4.6) by $u'_{\rho,V}$ and integrating by parts yields

$$-\rho \int_{\mathbb{R}^*} u'_{\rho,V} f(u_{\rho}) = \int_{\mathbb{S}^*} \frac{\partial p_{\rho}}{\partial \nu} \frac{\partial u_{\rho}}{\partial \nu} V \cdot \nu,$$

and finally

$$J_{\rho}'(\mathbb{B}^*)[V] = \int_{\mathbb{S}^*} \left(\frac{\partial p_{\rho}}{\partial \nu} \frac{\partial u_{\rho}}{\partial \nu} - \frac{1}{2} \left(\frac{\partial u_{\rho}}{\partial \nu} \right)^2 \right) V \cdot \nu.$$

Observe that $\frac{\partial p_{\rho}}{\partial \nu}$ and $\frac{\partial u_{\rho}}{\partial \nu}$ are constant on \mathbb{S}^* since u_{ρ} and p_{ρ} are radially symmetric. Introduce the real number Λ_{ρ} given by

$$\Lambda_{\rho} = \left. \frac{\partial p_{\rho}}{\partial \nu} \frac{\partial u_{\rho}}{\partial \nu} - \frac{1}{2} \left(\frac{\partial u_{\rho}}{\partial \nu} \right)^{2} \right|_{\mathbb{S}^{*}}, \tag{4.7}$$

we get that (4.5) is satisfied, whence the result.

In what follows, we will exploit the fact that the adjoint state is radially symmetric. In the following definition, we sum-up the notations we will use.

Definition 4.2. Recall that φ_{ρ} (defined in Lem. 4.1) is such that

$$u_{\rho}(x) = \varphi_{\rho}(|x|), \quad \forall x \in \mathbb{B}^*.$$

Since p_{ρ} is also radially symmetric, introduce ϕ_{ρ} such that

$$p_o(x) = \phi_o(|x|), \quad \forall x \in \mathbb{B}^*.$$

4.3. Second order optimality conditions

Let us focus on the second and third points of Theorem 2.7, especially on (2.6). Since \mathbb{B}^* is a critical shape, it is enough to work with normal vector fields, in other words vector fields V such that $V = (V \cdot \nu)\nu$ on \mathbb{S}^* . Consider such a vector field V. For the sake of notational simplicity, let us set $J''_{\rho} = J''_{\rho}(\mathbb{B}^*)[V,V]$, $\mathcal{L}''_{\Lambda_{\rho}} = (J_{\rho} - \Lambda_{\rho} \operatorname{Vol})''(\mathbb{B}^*)[V,V]$, $u = u_{\rho}$, $u' = u'_{\rho,V}$ and $u'' = u''_{\rho,V}$.

4.3.1. Computation of the Second Order Derivative at the Ball

To compute the second order derivative, we use the Hadamard second order formula ([13], Chap. 5, p. 253) for normal vector fields, namely

$$\frac{\mathrm{d}^2}{\mathrm{d}t^2}\bigg|_{t=0} \int_{(\mathrm{Id}\,+tV)\mathbb{R}^*} k(t) = \int_{\mathbb{R}^*} k''(0) + 2\int_{\mathbb{S}^*} k'(0)V\cdot\nu + \int_{\mathbb{S}^*} \left(\frac{1}{R}k(0) + \frac{\partial k(0)}{\partial \nu}\right)(V\cdot\nu)^2,$$

applied to $k(t) = \frac{1}{2} |\nabla u_t|^2 - gu_t$, where u_t denotes the solution of (1.2) on $(\mathrm{Id} + tV)\mathbb{B}^*$.

The Hadamard formula along with the weak formulation of equations (4.3)-(4.4) yields

$$J_{\rho}^{"} = \int_{\mathbb{R}^*} \langle \nabla u, \nabla u^{"} \rangle - \int_{\mathbb{R}^*} g u^{"} + \int_{\mathbb{R}^*} |\nabla u^{'}|^2 + 2 \int_{\mathbb{S}^*} \frac{\partial u}{\partial \nu} \frac{\partial u^{'}}{\partial \nu} V \cdot \nu - 2 \int_{\mathbb{S}^*} g u^{'} V \cdot \nu$$

$$-\rho \int_{\mathbb{R}^*} f(u)u'' = \int_{\mathbb{S}^*} u'' \frac{\partial p_{\rho}}{\partial \nu} - \rho \int_{\mathbb{R}^*} (u')^2 p_{\rho} f''(u).$$

To handle the last term of the right-hand side, let us introduce the function λ_{ρ} defined as the solution of

$$\begin{cases} -\Delta \lambda_{\rho} + \rho \lambda_{\rho} f'(u) + \rho u' p_{\rho} f''(u) = 0 & \text{in } \mathbb{B}^* \\ \lambda_{\rho} = 0 & \text{on } \mathbb{S}^*. \end{cases}$$
(4.8)

Multiplying this equation by u' and integrating by parts gives

$$-\rho \int_{\mathbb{R}^*} f''(u)(u')^2 = \int_{\mathbb{S}^*} u' \frac{\partial \lambda_{\rho}}{\partial \nu}.$$

To handle the term $-\rho \int_{\mathbb{B}^*} (u')^2 f'(u)$ of J''_{ρ} , we introduce the function η_{ρ} , defined as the only solution to

$$\begin{cases}
-\Delta \eta_{\rho} + \rho \eta_{\rho} f'(u) + \rho u' f'(u) = 0 & \text{in } \mathbb{B}^* \\
\eta_{\rho} = 0 & \text{on } \mathbb{S}^*.
\end{cases}$$
(4.9)

Multiplying this equation by u' and integrating by parts gives

$$-\rho \int_{\mathbb{R}^*} (u')^2 f'(u) = \int_{\mathbb{R}^*} u' \frac{\partial \eta_\rho}{\partial \nu} = -\int_{\mathbb{R}^*} V \cdot \nu \frac{\partial \eta_\rho}{\partial \nu} \frac{\partial u}{\partial \nu}$$

Gathering these terms, we have

$$\begin{split} J_{\rho}^{\prime\prime\prime} &= \int_{\mathbb{S}^*} u^{\prime\prime} \frac{\partial p_{\rho}}{\partial \nu} + \int_{\mathbb{S}^*} u^{\prime} \frac{\partial \lambda_{\rho}}{\partial \nu} - \int_{\mathbb{S}^*} \frac{\partial \eta_{\rho}}{\partial \nu} \frac{\partial u}{\partial \nu} V \cdot \nu - \int_{\mathbb{S}^*} \frac{\partial u}{\partial \nu} \frac{\partial u^{\prime}}{\partial \nu} V \cdot \nu \\ &+ \int_{\mathbb{S}^*} \left(\frac{1}{2R} \left(\frac{\partial u}{\partial \nu} \right)^2 + g \frac{\partial u}{\partial \nu} \right) (V \cdot \nu)^2. \end{split}$$

Using that

$$\Lambda_{\rho} = \frac{\partial p_{\rho}}{\partial \nu} \frac{\partial u_{\rho}}{\partial \nu} - \frac{1}{2} \left(\frac{\partial u_{\rho}}{\partial \nu} \right)^{2} \bigg|_{\mathbb{S}^{*}} \quad \text{and} \quad \operatorname{Vol}''(\mathbb{B}^{*}) = \int_{\mathbb{S}^{*}} \frac{1}{R} (V \cdot \nu)^{2},$$

one computes

$$\mathcal{L}_{\Lambda_{\rho}}^{"} = \int_{\mathbb{S}^{*}} u^{"} \frac{\partial p_{\rho}}{\partial \nu} + \int_{\mathbb{S}^{*}} u^{'} \frac{\partial \lambda_{\rho}}{\partial \nu} - \int_{\mathbb{S}^{*}} \frac{\partial \eta_{\rho}}{\partial \nu} \frac{\partial u}{\partial \nu} V \cdot \nu - \int_{\mathbb{S}^{*}} \frac{\partial u}{\partial \nu} \frac{\partial u^{'}}{\partial \nu} V \cdot \nu + \int_{\mathbb{S}^{*}} \left(-\frac{\Lambda_{\rho}}{R} + \frac{1}{2R} \left(\frac{\partial u}{\partial \nu} \right)^{2} + g \frac{\partial u}{\partial \nu} \right) (V \cdot \nu)^{2}$$
(4.10)

4.3.2. Expansion in Fourier Series

In this section, we recast the expression of $\mathcal{L}''_{\Lambda_{\rho}}$ in a more tractable form, by using the method introduced by Lord Rayleigh: since we are dealing with vector fields normal to \mathbb{S}^* , we expand $V \cdot \nu$ as a Fourier series. This leads to introducing the sequences of Fourier coefficients $(\alpha_k)_{k \in \mathbb{N}^*}$ and $(\beta_k)_{k \in \mathbb{N}^*}$ defined by:

$$V \cdot \nu = \sum_{k \in \mathbb{N}^*} \left(\alpha_k \cos(k \cdot) + \beta_k \sin(k \cdot) \right),$$

the equality above being understood in a $L^2(\mathbb{S}^*)$ sense.

Let $v_{k,\rho}$ (resp. $w_{k,\rho}$) denote the function u' associated to the perturbation choice V_k given by $V_k = V_k^c := \cos(k \cdot) \nu$ (resp. $V_k = V_k^s := \sin(k \cdot) \nu$), in other words, $v_{k,\rho} = u'_{\rho,V_k^c}$ (resp. $w_{k,\rho} = u'_{\rho,V_k^s}$). Then, one shows easily (by uniqueness of the solutions of the considered PDEs) that for every $k \in \mathbb{N}$, there holds

$$v_{k,\rho}(r,\theta) = \psi_{k,\rho}(r)\cos(k\theta)$$
 (resp. $w_{k,\rho}(r,\theta) = \psi_{k,\rho}(r)\sin(k\theta)$),

where (r,θ) denote the polar coordinates in \mathbb{R}^2 , where $\psi_{k,\rho}$ solves

$$\begin{cases} -\frac{1}{r}(r\psi'_{k,\rho})' = -\left(\frac{k^2}{r^2} + \rho f'(u)\right)\psi_{k,\rho} & \text{in } (0,R) \\ \psi_{k,\rho}(R) = -\varphi'_{\rho}(R). \end{cases}$$
(4.11)

By linearity, we infer that

$$u' = \sum_{k \in \mathbb{N}^*} \alpha_k v_{k,\rho} + \beta_k w_{k,\rho}.$$

For every $k \in \mathbb{N}^*$, let us introduce $\eta_{k,\rho}$ as the solution of (4.9) associated with $v_{k,\rho}$. One shows that $\eta_{k,\rho}$ satisfies

$$\begin{cases} -\Delta \eta_{k,\rho} + \rho f'(u)\eta_{k,\rho} + \rho f'(u)v_{k,\rho} = 0 & \text{in } \mathbb{B}^* \\ \eta_{k,\rho} = 0 & \text{on } \mathbb{S}^*. \end{cases}$$
(4.12)

Similarly, one shows easily that

$$\eta_{k,\rho}(r,\theta) = \xi_{k,\rho}(r)\cos(k\theta),$$

where $\xi_{k,\rho}$ satisfies

$$\begin{cases} -\frac{1}{r}(r\xi'_{k,\rho})' = -\left(\frac{k^2}{r^2} + \rho f'(u)\right)\xi_{k,\rho} - \rho\psi_{k,\rho} & \text{in } (0,R) \\ \xi_{k,\rho}(R) = 0. \end{cases}$$
(4.13)

Notice that one has $\xi_{k,\rho} = 0$ whenever $\rho = 0$, which can be derived obviously from (4.9).

We recall that u_{ρ} is radially symmetric and that we denote by $r \mapsto \varphi_{\rho}(r)$ the corresponding one-dimensional function:

$$u_{\rho}(x) = \varphi_{\rho}(|x|).$$

Finally, we introduce a last set of equations related to λ_{ρ} . Let us define $\zeta_{k,\rho}$ as the solution of

$$\begin{cases} -(r\zeta'_{k,\rho})' = -\frac{k^2}{r^2}\zeta_{k,\rho} - r\rho\zeta_{k,\rho}f'(u) - \rho r\psi_{k,\rho}\phi_{\rho}f''(u) & \text{in } (0,R) \\ \zeta_{k,\rho}(R) = 0. \end{cases}$$
(4.14)

and verify that $\lambda_{\rho} = \zeta_{k,\rho}(r)\cos(k\theta)$ whenever $V = V_k$.

Proposition 4.3. The quadratic form $\mathcal{L}''_{\Lambda_{\varrho}}$ expands as

$$\mathcal{L}_{\Lambda_{\rho}}^{"} = \sum_{k=1}^{\infty} \omega_{k,\rho} \left(\alpha_k^2 + \beta_k^2 \right), \tag{4.15}$$

where, for any $k \in \mathbb{N}^*$,

$$\omega_{k,\rho} = \pi R \left(-2\psi'_{k,\rho}(R)\phi'_{\rho}(R) - \varphi'_{\rho}(R)\zeta'_{k,\rho}(R) - \varphi''_{\rho}(R)\phi'_{\rho}(R) - \xi'_{k,\rho}(R)\varphi'_{\rho}(R) - \frac{\Lambda_{\rho}}{R} + \frac{1}{2R}(\varphi'_{\rho})^2 + g(R)\varphi'_{\rho}(R) - \varphi'_{\rho}(R)\psi'_{k,\rho}(R) \right), \tag{4.16}$$

the functions $\psi_{k,\rho}$, $\xi_{k,\rho}$, $\zeta_{k,\rho}$ being respectively defined by (4.11), (4.13), (4.14), and Λ_{ρ} is given by (4.7). Proof of Proposition 4.3. Let us first deal with the particular case $V \cdot \nu = \cos(k \cdot)$. According to (4.3), (4.4) and (4.10), one has

$$\mathcal{L}_{\Lambda_{\rho}}^{"} = \int_{\mathbb{S}^{*}} u^{"} \frac{\partial p_{\rho}}{\partial \nu} + \int_{\mathbb{S}^{*}} u^{'} \frac{\partial \lambda_{\rho}}{\partial \nu} - \int_{\mathbb{S}^{*}} \frac{\partial \eta_{\rho}}{\partial \nu} \frac{\partial u}{\partial \nu} V \cdot \nu - \int_{\mathbb{S}^{*}} \frac{\partial u}{\partial \nu} \frac{\partial u^{'}}{\partial \nu} V \cdot \nu$$

$$+ \int_{\mathbb{S}^{*}} \left(-\frac{\Lambda_{\rho}}{R} + \frac{1}{2R} \left(\frac{\partial u}{\partial \nu} \right)^{2} + g \frac{\partial u}{\partial \nu} \right) (V \cdot \nu)^{2}$$

$$= R \int_{0}^{2\pi} \left(-2\cos(k\theta)^{2} \psi_{k,\rho}^{\prime}(R) - \cos(k\theta)^{2} \varphi_{\rho}^{"}(R) \right) \phi_{\rho}^{\prime}(R) d\theta - R \int_{0}^{2\pi} \cos(k\theta)^{2} \varphi_{\rho}^{\prime}(R) \zeta_{k,\rho}^{\prime}(R) d\theta$$

$$-R \int_0^{2\pi} \cos(k\theta)^2 \xi'_{k,\rho}(R) \varphi'_{\rho}(R) d\theta + R \int_0^{2\pi} \cos(k\theta)^2 \left(-\frac{\Lambda_{\rho}}{R} + \frac{1}{2R} (\varphi'_{\rho})^2 + g(R) \varphi'_{\rho}(R) \right) d\theta$$
$$-R \int_0^{2\pi} \cos(k\theta)^2 \varphi'_{\rho}(R) \psi'_{k,\rho}(R) d\theta$$

and therefore

$$\frac{\mathcal{L}''_{\Lambda_{\rho}}}{\pi R} = -2\psi'_{k,\rho}(R)\phi'_{\rho}(R) - \varphi'_{\rho}(R)\zeta'_{k,\rho}(R) - \varphi''_{\rho}(R)\phi'_{\rho}(R) - \xi'_{k,\rho}(R)\varphi'_{\rho}(R) - \frac{\Lambda_{\rho}}{R} + \frac{1}{2R}(\varphi'_{\rho})^{2} + g(R)\varphi'_{\rho}(R) - \varphi'_{\rho}(R)\psi'_{k,\rho}(R)$$

We have then obtained the expected expression for this particular choice of vector field V. Similar computations enable us to recover the formula when dealing with the vector field V given by $V \cdot \nu = \sin(k \cdot)$. Finally, for general V, one has to expand the square $(V \cdot \nu)^2$, and the computation follows exactly the same lines as before. Note that all the crossed terms of the sum (i.e. the term that do not write as squares of real numbers) vanish, by using the $L^2(\mathbb{S}^*)$ orthogonality properties of the families $(\cos(k \cdot), \sin(k \cdot))_{k \in \mathbb{N}}$.

4.3.3. Comparison Principle on the Family $\{\omega_{k,\rho}\}_{k\in\mathbb{N}^*}$

The next result allows us to recast the ball stability issue in terms of the sign of $\omega_{1,\rho}$.

Proposition 4.4. There exists M > 0 such that, for any ρ small enough,

$$\forall k \in \mathbb{N}^*, \ \omega_{k,\rho} - \omega_{1,\rho} \geqslant -M\rho \quad and \quad |\omega_{1,\rho} - \omega_{1,0}| \leqslant M\rho.$$

Proof of Proposition 4.4. Fix $k \in \mathbb{N}$ and introduce $\tilde{\omega}_{k,\rho} = \omega_{k,\rho}/(\pi R)$. Using (4.16), one computes

$$\tilde{\omega}_{k,\rho} - \tilde{\omega}_{1,\rho} = \left(-\varphi'_{\rho}(R) - 2\phi'_{\rho}(R) \right) \left(\psi'_{k,\rho}(R) - \psi'_{1,\rho}(R) \right) \\ -\varphi'_{\rho}(R) \left(\xi'_{k,\rho}(R) - \xi'_{1,\rho}(R) + \zeta'_{k,\rho}(R) - \zeta'_{1,\rho}(R) \right).$$

We need to control each term of the expression above, which is the goal of the next results, whose proofs are postponed at the end of this section.

Lemma 4.5. There exists M > 0 and $\bar{\rho} > 0$ such that for $\rho \in [0, \bar{\rho}]$, one has

$$\max \left\{ \|\varphi_{o}' - \varphi_{o}'\|_{L^{\infty}(0,R)}, \|\varphi_{o}'\|_{L^{\infty}(0,R)}, \|\xi_{k,o}'\|_{\infty} \right\} \leqslant M\rho \quad and \quad \|\zeta_{k,o}'\|_{\infty} \leqslant M\rho^{2}.$$

According to Lemma 4.1, one has in particular $\varphi_0'(R) < 0$. We thus infer from Lemma 4.5 the existence of $\delta > 0$ such that

$$\min\{-\varphi_{\rho}'(R) - 2\phi_{\rho}'(R), -\varphi_{\rho}'(R)\} \geqslant \delta > 0.$$

for ρ small enough. Furthermore, Lemma 4.5 also yields easily the estimate

$$|\zeta'_{k,\rho}(R) - \zeta'_{1,\rho}(R)| \leqslant M\rho^2$$

Hence, we are done by applying the following result.

Lemma 4.6. There exists $\hat{M} > 0$ and $\bar{\rho} > 0$ such that for $\rho \in [0, \bar{\rho}]$, one has

$$\psi'_{k,\rho}(R) - \psi'_{1,\rho}(R) \ge 0 \quad and \quad \left| \xi'_{k,\rho}(R) - \xi'_{1,\rho} \right| (R) \le \hat{M}\rho.$$
 (4.17)

Indeed, the results above lead to

$$\omega_{k,\rho} - \omega_{1,\rho} \geqslant \delta(\psi_k'(R) - \psi_{k,\rho}'(R) + \xi_{k,\rho}'(R) - \xi_{k,\rho}'(R)) \geqslant 0$$

for every $k \ge 1$ and ρ small enough.

Finally, the proof of the second inequality follows the same lines and are left to the reader.

Proof of Lemma 4.5. These convergence rates are simple consequences of elliptic regularity theory. Since the reasonings for each term are similar, we only focus on the estimate of $\|\phi'_{\rho}\|_{\infty}$. Recall that p_{ρ} solves the equation (4.6). Multiplying this equation by p_{ρ} , integrating by parts and using the Poincaré inequality yield the existence of C > 0 such that

$$(1 - \rho C \|f'\|_{L^{\infty}(\mathbb{B}^*)}) \|\nabla p_{\rho}\|_{L^{2}(\mathbb{B}^*)}^{2} \leq \rho \|f\|_{L^{\infty}(\mathbb{B}^*)} \|p_{\rho}\|_{L^{2}(\mathbb{B}^*)},$$

so that $\|p_{\rho}\|_{W_0^{1,2}(\mathbb{B}^*)}$ is uniformly bounded for ρ small enough. Hence, the elliptic regularity theory yields that p_{ρ} is in fact uniformly bounded in $W^{2,2}(\mathbb{B}^*)$, and there exists $\hat{M}>0$ such that, defining $W_0^{2,2}(\mathbb{B}^*):=W^{2,2}(\mathbb{B}^*)\cap W_0^{1,2}(\mathbb{B}^*)$, $\|p_{\rho}\|_{W_0^{2,2}(\mathbb{B}^*)}\leqslant \hat{M}\rho$ and, since $\mathbb{B}^*\subset\mathbb{R}^2$, we get

$$||p_{\rho}||_{L^{\infty}(\mathbb{B}^*)} \leqslant M\rho$$

for a new constant M. Since $\Delta p_{\rho} = \rho p_{\rho} f'(u_{\rho}) + \rho f(u_{\rho})$ and the right-hand side belongs to $L^{s}(\mathbb{B}^{*})$ for all $s \geq 1$, elliptic regularity theory [3], Theorem 6.3 yields the existence of C > 0 such that

$$||p_{\rho}||_{W_0^{2,s}(\Omega)} \le C(\rho||p_{\rho}||_{\infty}||f'||_{\infty} + \rho||f||_{\infty}) \le M\rho$$

and using the embedding $W^{2,s} \hookrightarrow \mathscr{C}^{1,\alpha}$ for s large enough, one finally gets

$$\|\nabla p_{\rho}\|_{L^{\infty}(\mathbb{B}^*)} \leqslant M\rho.$$

Proof of Lemma 4.6. The two estimates are proved using the maximum principle. Let us first prove that, for any k and any ρ small enough, $\psi_{k,\rho}$ is non-negative on (0,R). First of all, for ρ small enough, $-\varphi'_{\rho}(R)$ is positive, and therefore $\psi_{k,\rho}(R) > 0$. Since v_k belongs to $W_0^{1,2}$, one has necessarily $\psi_{k,\rho}(0) = 0$. Furthermore, according to (4.11), by considering $\rho > 0$ small enough so that

$$-\frac{1}{r^2} + \rho \|f'\|_{\infty} \leqslant -\frac{1}{2r^2}$$

it follows that

$$-\frac{1}{r}(r\psi'_{k,\rho})' = c_{k,\rho}(r)\psi_{k,\rho} \quad \text{with} \quad c_{k,\rho} = -\frac{k^2}{r^2} - \rho f'(u_0) < 0.$$

Let us argue by contradiction, assuming that $\psi_{k,\rho}$ reaches a negative minimum at a point r_1 . Because of the boundary condition, r_1 is necessarily an interior point of (0,R). Then, from the equation,

$$0 \geqslant -\psi_{k,\rho}''(r_1) = c_{k,\rho}(r_1)\psi_{k,\rho}(r_1) > 0,$$

which is a contradiction. Thus there exists $\overline{\rho} > 0$ small enough such that, for any $\rho \leqslant \overline{\rho}$ and every $k \in \mathbb{N}^*$, $\psi_{k,\rho}$ is non-negative on (0,R).

Now, introduce $z_k = \psi_{k,\rho} - \psi_{1,\rho}$ for every $k \ge 1$ and notice that it satisfies

$$-\frac{1}{r}(rz_k')' = \frac{1}{r^2}\psi_{1,\rho} - \frac{k^2}{r^2}\psi_{k,\rho} - \rho f'(u_0)z_k.$$

Since $\psi_{k,\rho}$ is non-negative, it implies

$$-\frac{1}{r}(rz'_k)' \leqslant \left(-\frac{k^2}{r^2} - \rho f'(u_0)\right) z_k$$
, and $z_k(R) = z_k(0) = 0$.

Up to decreasing $\bar{\rho}$, one may assume that for $\rho \leqslant \bar{\rho}$, $-\frac{k^2}{r^2} - \rho f'(u_0) < 0$ in (0, R). If z_k reached a positive maximum, it would be at an interior point r_1 , but we would have

$$0 \leqslant -z_k''(r_1) < \left(-\frac{k^2}{r^2} - \rho f'(u_0)\right) z_k(r_1) < 0.$$

Hence, one has necessarily $z_k \leq 0$ in (0, R) and z_k reaches a maximum at R, which means in particular that $z'_k(R) = \psi'_{k,\rho}(R) - \psi'_{1,\rho}(R) \geq 0$.

4.4. A further comparison result on the family $\{\omega_{k,\rho}\}_{k\in\mathbb{N}}$

While the previous section helps us determine the sign of the sequence $\{\omega_{k,\rho}\}_{k\in\mathbb{N}^*}$ and thus gives us a stability criterion for the ball, we address here a more precise property, that of the optimal coercivity norm. We keep the same notation. If we assume that

$$\forall k \in \mathbb{N}, \omega_{k,\rho} > 0$$

which is guaranteed provided we have $\omega_{1,\rho} > 0$ (see the next subsection 4.5), obtaining the $H^{1/2}$ -coercivity norm is equivalent to proving that, for some constant $\mathfrak{L}_{0,\rho} > 0$ we have

$$\omega_{k,o} \geqslant \mathfrak{L}_{0,o}k > 0$$
 for any k large enough.

This property is established thanks to the following result.

Proposition 4.7. There exist $l_1 > 0$, $k_1 > 0$ and M > 0 such that, for any ρ small enough,

$$\forall k \in \mathbb{N}^*, \qquad k \geqslant k_1 \Longrightarrow \omega_{k,\rho} \geqslant \mathfrak{l}_1 k - M \rho.$$

As a consequence if $\omega_{k,\rho} > 0$ for any $k \in \mathbb{N}$, then there exists a constant $\mathfrak{L}_{0,\rho} > 0$ such that

$$\forall k \in \mathbb{N}^*, \omega_{k,\rho} \geqslant \mathfrak{L}_{0,\rho} k.$$

Proof of Proposition 4.7. We know from Lemma 4.5 that, for any $k \in \mathbb{N}$, there holds

$$\tilde{\omega}_{k,\rho} \geqslant \left(-\varphi_{\rho}'(R) - 2\phi_{\rho}'(R)\right)\psi_{k,\rho}'(R) - M\rho.$$

We also recall that there exists $\delta > 0$ such that

$$\min\{-\varphi_o'(R) - 2\phi_o'(R), -\varphi_o'(R)\} \geqslant \delta > 0.$$

for ρ small enough.

Let us state the main ingredient of the proof.

Lemma 4.8. There exist $l_0 > 0$, $\hat{M} > 0$ and $\bar{\rho} > 0$ such that for $\rho \in [0, \bar{\rho}]$, one has

for any
$$k \geqslant k_1, \ \psi'_{k,\rho}(R) \geqslant \mathfrak{l}_0 k - \hat{M} \rho.$$
 (4.18)

According to Lemma 4.6, one has $\omega_{k,\rho} \geqslant \delta(\mathfrak{l}_0 k - \hat{M}\rho)$, yielding to the conclusion of Proposition 4.7 for ρ small enough.

Let us prove Lemma 4.8.

Proof of Lemma 4.8. Observe that, for any $k \in \mathbb{N}$, the function $y_{k,\rho}: r \mapsto \left(\frac{r}{R}\right)^{\frac{k}{\sqrt{2}}} \left(-\varphi_{\rho}'(R)\right)$ solves the ODE

$$\begin{cases}
-\frac{1}{r}(ry'_{k,\rho})' = -\frac{k^2}{2r^2}y_{k,\rho} & \text{in } (0,1), \\
y_{k,\rho}(R) = -\varphi'_{\rho}(R).
\end{cases}$$
(4.19)

Let us consider the function $z_k := \psi_{k,\rho} - y_{k,\rho}$. Using the same idea as in the proof of Lemma 4.6, we want to prove that $z'_k(R) \ge 0$.

To do so, we note that the function z_k satisfies

$$-\frac{1}{r}(rz_k')' = -\left(\frac{k^2}{r^2} + \rho f'(u_0)\right)\psi_{k,\rho} + \frac{k^2}{2r^2}y_k \leqslant -\frac{k^2}{2r^2}(\psi_{k,\rho} - y_{k,\rho}).$$

Indeed, $\psi_{k,\rho} \geqslant 0$ and $\frac{k^2}{r^2} + \rho f'(u_0) \geqslant \frac{k^2}{2r^2}$ for ρ small enough, uniformly in $k \in \mathbb{N}^*$. As a consequence, we have $z_k \leqslant 0$. Since $z_k(R) = 0$, we have $z_k'(R) \geqslant 0$. Since

$$y'_{k,\rho}(R) = \frac{k}{\sqrt{2}R}(-\varphi'_{\rho}(R))$$

and since we have $-\varphi'_{\rho}(R) \ge \delta > 0$ according to Lemma 4.5 for any $\rho > 0$ small enough, one gets the desired conclusion.

4.5. Shape (in)stability of \mathbb{B}^*

4.5.1. Proof of the stability of the ball under assumption (2.5)

Stability under assumption (2.5) is well known (see [6]) in the case $\rho = 0$. Hereafter, we recall the proof, showing by the same method a stability result for $\rho > 0$.

Lemma 4.9. Under assumption (2.5), one has $\omega_{1,0} > 0$.

This Lemma concludes the proof of the second part of Theorem 2.7. Indeed, according to Propositions 4.3 and 4.4 we have, for $\rho > 0$ small enough, and any $k \in \mathbb{N}^*$,

$$\omega_{k,\rho} > 0.$$

From Lemma 4.8, there holds, for some constant $\mathfrak{L}_{0,\rho} > 0$,

$$\forall k \in \mathbb{N}^*, \omega_{k,\rho} \geqslant \mathfrak{L}_{0,\rho} k.$$

$$\mathcal{L}_{\Lambda_{\rho}}^{"}(\mathbb{B}^{*})[V,V] \geqslant \sum_{k=1}^{\infty} \mathfrak{L}_{0,\rho} k \left(\alpha_{k}^{2} + \beta_{k}^{2}\right)$$
$$= \mathfrak{L}_{0,\rho} \|V \cdot \nu\|_{H^{\frac{1}{2}}(\mathbb{S}^{*})}^{2}$$

for ρ small enough.

Proof of Lemma 4.9. To compute $\omega_{1,0}$, recall that, for $\rho = 0$, the function $\psi_{1,0}$ solves

$$-\frac{1}{r}(r\psi'_{1,0})' = -\frac{1}{r^2}\psi_{1,0} \quad \text{and} \quad \psi_{1,0}(R) = -\varphi'_0(R),$$

and therefore, $\psi_{1,0}(r) = -\frac{r}{R}\varphi_0'(R)$ for all $r \in [0,R]$, so that

$$\begin{split} \frac{\omega_{1,0}}{\pi R} &= -\frac{\Lambda_0}{R} + \frac{1}{2R} (\varphi_0'(R))^2 + g(R) \varphi_0'(R) - \varphi_0'(R) \psi_{1,0}'(R) \\ &= \frac{1}{R} (\varphi_0'(R))^2 + g(R) \varphi_0'(R) + \frac{1}{R} (\varphi_0'(R))^2 \\ &= \frac{2}{R} (\varphi_0'(R))^2 + g(R) \varphi_0'(R) \\ &= -\varphi_0'(R) \left(-\frac{2}{R} \varphi_0'(R) - g(R) \right) \end{split}$$

where the expression of Λ_0 is given by (4.7). Since $-R\varphi_0'(R) = \int_0^R tg(t)dt = \frac{1}{2\pi} \int_{\mathbb{B}^*} g$, and $\varphi_0'(R) < 0$, we infer that the sign of $\omega_{1,0}$ is the sign of

$$-\frac{2}{R}\varphi_0'(R) - g(R) = \frac{1}{\pi R^2} \int_{\mathbb{R}^*} g - g(R),$$

and the positivity of this last quantity is exactly assumption (2.5). The conclusion follows.

4.5.2. An example of instability

In this part, we will assume that g is the constant function equal to 1, i.e. g=1. Even if the ball \mathbb{B}^* is known to be a minimizer in the case $\rho=0$, it is a degenerate one in the sense that $\omega_{1,0}=0$; this is because of the invariance by translations of the problem. In what follows, we exploit this fact and will construct a suitable nonlinearity f such that \mathbb{B}^* is not a local minimizer for ρ small enough, in other words such that $\omega_{1,\rho}<0$.

We assume without loss of generality that R = 1 for the sake of simplicity.

Lemma 4.10. There holds

$$\omega_{1,\rho} = \frac{\rho}{2}(w_1 + w_1')(1) + \mathcal{O}(\rho^2)$$

where w_1 solves

$$\begin{cases} -(rw_1')' = -\frac{1}{r}w_1 - \frac{r^2}{2}f'(\varphi_0) - \frac{r^2}{2} & in (0, 1) \\ w_1(1) = -\int_0^1 tf(\varphi_0) dt. \end{cases}$$
(4.20)

Proof of Lemma 4.10. The techniques to derive estimates follow exactly the same lines as in Lemma 4.5. First, we claim that

$$\varphi_{\rho} = \varphi_0 + \rho \varphi_1 + \mathcal{O}(\rho^2) \quad \text{in } \mathscr{C}^1, \tag{4.21}$$

where φ_1 satisfies

$$\begin{cases} -\frac{1}{r}(r\varphi_1')' = -f(\varphi_0) & \text{in } (0,1) \\ \varphi_1(1) = 0. \end{cases}$$
 (4.22)

Indeed, considering the function $\delta = \varphi_{\rho} - \varphi_{0} - \rho \varphi_{1}$, one shows easily that it satisfies

$$\begin{cases} -\frac{1}{r}(r\delta')' = \rho(f(\varphi_0) - f(\varphi_\rho)) & \text{in } (0,1) \\ \delta(1) = 0. \end{cases}$$

Therefore, by mimicking the reasonings done in the proof of Lemma 4.5, involving elliptic regularity theory, and the fact that $\|\varphi_{\rho} - \varphi_0\|_{W^{1,\infty}} = O(\rho)$, we infer that $\|\delta\|_{\mathscr{C}^1} = O(\rho^2)$, whence the result.

Using that φ_{ρ} satisfies $-\frac{1}{r}(r\varphi'_{\rho})' + \rho f(\varphi_{\rho}) = g$ and integrating this equation yields

$$-\varphi_{\rho}'(1) = \frac{1}{2} - \rho \int_{0}^{1} t f(\varphi_{\rho}) dt = \frac{1}{2} - \rho \int_{0}^{1} t f(\varphi_{0}(t)) dt + O(\rho^{2}). \tag{4.23}$$

The equation on ϕ_{ρ} reads

$$\begin{cases} -(r\phi'_{\rho})' = r\Big(-\rho\phi_{\rho}f'(\varphi_{\rho}) - \rho f(\varphi_{\rho})\Big) & \text{in } (0,1) \\ \phi_{\rho}(0) = 0. \end{cases}$$

and according to Lemma 4.5, there holds $\|\phi_{\rho}\|_{\infty} = O(\rho)$. We thus infer that

$$-\phi_{\rho}'(1) = -\rho \int_0^1 t f(\varphi_0) dt + O(\rho^2). \tag{4.24}$$

From (4.23) and (4.24), we infer that

$$\Lambda_{\rho} = \frac{1}{2} ((\varphi_{\rho}'(1))^{2} - \varphi_{\rho}'(1)\varphi_{\rho}'(1)) = \frac{1}{2}\varphi_{0}'(1)^{2} - \rho\varphi_{0}'(1) \int_{0}^{1} tf(\varphi_{0}) dt + \rho\varphi_{0}'(1) \int_{0}^{1} tf(\varphi_{0}) dt + O(\rho^{2})$$

$$= \frac{1}{2}\varphi_{0}'(1)^{2} + O(\rho^{2}). \tag{4.25}$$

Regarding $\psi_{1,\rho}$ and using that it satisfies (4.11), we get

$$\psi_{1,\rho}(1) = -\varphi'_{\rho}(1) = \frac{1}{2} - \rho \int_0^1 t f(\varphi_0) \, dt.$$

We then infer that $\|\psi_{1,\rho} + r\varphi'_{0,\rho}(1)\|_{\mathscr{C}^1} = O(\rho)$. Plugging this estimate in (4.11) allows us to show that

$$\psi_{1,\rho}(r) = -\varphi_0'(1)r + \rho y_1(r) + \mathcal{O}(\rho^2) \quad \text{in } \mathscr{C}^1(0,1), \tag{4.26}$$

where y_1 solves

$$\begin{cases} -(ry_1')' = -\frac{1}{r}y_1 + r^2\varphi_0'(1)f'(\varphi_0) & \text{in } (0,1) \\ y_1(1) = -\int_0^1 tf(\varphi_0) \, \mathrm{d}t. \end{cases}$$
(4.27)

Regarding $\xi_{1,\rho}$ and using that it satisfies (4.13), we easily get that $\|\xi_{1,\rho}\|_{W^{1,\infty}} = O(\rho)$, according to Lemma 4.5. This allows us to write

$$\xi_{1,\rho} = \rho z_1 + \mathcal{O}(\rho^2) \quad \text{in } \mathscr{C}^1(0,1)$$
 (4.28)

where z_1 satisfies

$$\begin{cases} -(rz_1')' = -\frac{1}{r}z_1 + r^2\varphi_0'(1) & \text{in } (0,1) \\ z_1(1) = 0. \end{cases}$$
(4.29)

Let us now expand $\omega_{1,\rho}$ with respect to the parameter ρ . Recall that

$$\omega_{1,\rho} = \frac{1}{2} \left(-2\psi'_{1,\rho}(1)\phi'_{1,\rho}(1) - \varphi''_{\rho}(1)\phi'_{1,\rho}(1) - \varphi'_{\rho}(R)\zeta'_{1,\rho}(R) - \xi'_{1,\rho}(1)\varphi'_{\rho}(1) + \Lambda_{\rho} + \frac{1}{2}(\varphi'_{\rho})^{2} + \varphi'_{\rho}(1) - \varphi'_{\rho}(1)\psi'_{1,\rho}(1) \right).$$

Regarding the term $\varphi'_{0,\rho}(R)\zeta'_{1,\rho}(R)$, we know from Lemma 4.5 that $\|\zeta'_{1,\rho}(R)\|_{\infty} = O(\rho^2)$.

Using this estimate and plugging the expansions (4.21)–(4.25)–(4.26)–(4.28) in the expression above yields successively

$$\begin{split} -2\psi_{1,\rho}'(1)\phi_{\rho}'(1) &= 2\rho\varphi_0'(1)\int_0^1 tf(\varphi_0)\,\mathrm{d}t + \mathcal{O}(\rho^2) = -\rho\int_0^1 tf(\varphi_0)\,\mathrm{d}t + \mathcal{O}(\rho^2). \\ -\varphi_\rho''(1)\phi_\rho'(1) &= -\varphi_0''(1)\phi_\rho'(1) + \mathcal{O}(\rho^2) = \frac{\rho}{2}\int_0^1 tf(\varphi_0)\,\mathrm{d}t + \mathcal{O}(\rho^2). \\ -\xi_{1,\rho}'(1)\varphi_\rho'(1) &= -\varphi_0'(1)\xi_{1,\rho}'(1) + \mathcal{O}(\rho^2) = \frac{\rho}{2}z_1'(1) \\ \Lambda_\rho + \frac{1}{2}(\varphi_\rho')^2 &= \varphi_0'(1)^2 - \frac{\rho}{2}\int_0^1 tf(\varphi_0)\,\mathrm{d}t + \mathcal{O}(\rho^2) = \frac{1}{4} - \frac{\rho}{2}\int_0^1 tf(\varphi_0)\,\mathrm{d}t + \mathcal{O}(\rho^2) \\ \varphi_\rho'(1) &= -\frac{1}{2} + \rho\int_0^1 tf(\varphi_0)\,\mathrm{d}t + \mathcal{O}(\rho^2) \\ -\varphi_\rho'(1)\psi_{1,\rho}'(1) &= \varphi_0'(1)^2 - \rho\varphi_0'(1)y_1'(1) + \rho\varphi_0'(1)\int_0^1 tf(\varphi_0)\,\mathrm{d}t + \mathcal{O}(\rho^2) \\ &= \frac{1}{4} + \frac{\rho}{2}y_1'(1) - \frac{\rho}{2}\int_0^1 tf(\varphi_0)\,\mathrm{d}t, \end{split}$$

by using that $\|\phi_{\rho}\|_{W^{1,\infty}} = O(\rho)$ and $\|\xi_{1,\rho}\|_{W^{1,\infty}} = O(\rho)$. This gives

$$\omega_{1,\rho} = -\rho \int_0^1 t f(\varphi_0) dt + \frac{\rho}{2} \int_0^1 t f(\varphi_0) dt + \frac{\rho}{2} z_1'(1)$$

$$+ \frac{1}{4} - \frac{\rho}{2} \int_0^1 t f(\varphi_0) dt - \frac{1}{2} + \rho \int_0^1 t f(\varphi_0) dt + \frac{1}{4} + \frac{\rho}{2} y_1'(1) - \frac{\rho}{2} \int_0^1 t f(\varphi_0) dt + O(\rho^2).$$

As expected, the zero order terms cancel each other out and we get

$$\omega_{1,\rho} = -\frac{\rho}{2} \int_0^1 t f(\varphi_0) dt + \frac{\rho}{2} z_1'(1) + \frac{\rho}{2} y_1'(1) + O(\rho^2),$$

which concludes the proof by setting $w_1 = y_1 + z_1$.

Construction of the non-linearity. Recall that we are looking for a non-linearity f such that $\omega_{1,\rho} < 0$, in other words such that $(w_1 + w_1')(1) < 0$ according to Lemma 4.10. To this aim, let us consider the function w_1 solving (4.20). Let us consider a non-negative function f such that

$$f'(\cdot) < -1 \quad \text{on } [0, \|\varphi_0\|_{\infty}].$$
 (4.30)

It follows that

$$w_1(1) = -\int_0^1 t f(\varphi_0) \, \mathrm{d}t < 0.$$

Besides,

$$-(rw_1')' = -\frac{1}{r}w_1 - \frac{r^2}{2}(f'(\varphi_0) + 1) \geqslant -\frac{1}{r}w_1$$

by using (4.30). Thus w_1 cannot reach a local negative minimum in (0,1). Moreover, by using that w_1 is regular (w_1 is the sum of two functions at least \mathscr{C}^1 according to the proof of Lemma 4.10) and integrating the equation above yields

$$-rw_1'(r) + \frac{1}{2} \int_0^r s^2 \left(f((\varphi_0(s)) + 1) ds = -\int_0^r \frac{w_1(s)}{s} ds \right)$$

for r > 0. The left-hand side is well-defined and it follows that so is the right-hand side, which implies that necessarily $w_1(0) = 0$ (else, we would immediately reach a contradiction).

Since w_1 cannot reach a local minimum on (0,1) and since $0 = w_1(0) > w_1(1)$, we get that w_1 is decreasing on $(1 - \delta, 1)$ for some $\delta > 0$, ensuring that $w'_1(1) < 0$. The conclusion follows.

Remark 4.11 (Toward an extension of Thm. 2.7 to dimension d=3). It is likely that the stability result of Theorem 2.7 can be generalized to the three-dimensional case by following the same lines. Since the adaptation of this result seems lengthy, and since the objective of this paper is to introduce a methodology to study the stability issue for these models, we limit ourselves to laying out the main steps of such a possible generalization to the case d=3.

Let us assume that D is the ball $\mathbb{B}(0, R_D)$ in \mathbb{R}^3 and that \mathbb{B}^* is a three-dimensional ball $\mathbb{B}(0, R)$ of volume m contained in D (i.e. $R < R_D$). Without loss of generality, we assume that R = 1, so that $\partial \mathbb{B}^*$ is the Euclidean

sphere \mathbb{S}^2 . Regarding the assumptions on f and g, we still assume that f belongs to $\mathscr{C}^2(\mathbb{R}) \cap W^{1,\infty}(\mathbb{R})$ and that g is a radially symmetric and non-negative function in $L^2(D)$.

One must first prove that u_{ρ} (the solution on \mathbb{B}^*) is a radially symmetric function and that \mathbb{B}^* is a critical shape by the same arguments as in the proof of Theorem 2.7. The Lagrange multiplier Λ_{ρ} associated to the volume constraint can hence be computed. Let $\mathcal{L}_{\Lambda_{\rho}}$ be the associated shape Lagrangian.

For an integer k, we define H_k as the space of spherical harmonics of degree k *i.e.* as the eigenspace associated with the eigenvalue -k(k+1) of the Laplace-Beltrami operator $\Delta_{\mathbb{S}^2}$. H_k has finite dimension d_k , and we furthermore have

$$L^2(\mathbb{S}^2) = \bigoplus_{k=1}^{\infty} H_k.$$

Let us consider a Hilbert basis $\{y_{k,\ell}\}_{\ell=1,\ldots,d_k}$ of H_k .

For an admissible vector field V, one must then expand $\langle V \cdot \nu \rangle$ in the basis of spherical harmonics as

$$\langle V \cdot \nu \rangle = \sum_{k=1}^{\infty} \sum_{\ell=1}^{d_k} \alpha_{k,\ell} (V \cdot \nu) y_{k,\ell}. \tag{4.31}$$

Then, one has to diagonalize the second-order shape derivative of $\mathcal{L}_{\Lambda_{\rho}}$ and prove that there exists a sequence of coefficients $\{\omega_{k,\ell,\rho}\}_{k\in\mathbb{N},0\leqslant\ell\leqslant d_k}$ such that for every $V\cdot\nu$ expanding as (4.31), the second order derivative of the shape Lagrangian in direction V reads

$$\mathcal{L}_{\Lambda_{\rho}}^{"} = \sum_{k=1}^{\infty} \sum_{\ell=1}^{d_k} \alpha_{k,\ell} (V \cdot \nu)^2 \omega_{k,\ell}.$$

We believe this diagonalization can be proved using separation of variables and the orthogonality properties of the family $\{y_{k,\ell}\}_{k\in\mathbb{N}^*,\ell=1,\ldots,d_k}$.

Using the separation of variables, each coefficient $\omega_{k,\ell}$ can be written in terms of derivatives of a family of solutions of one dimensional differential equations. The main difference with the proof of Theorem 2.7 comes from the fact that the main part of the ODE is not $-\frac{1}{r}\frac{d}{dr}(r\frac{d}{dr})$ anymore, but $-\frac{1}{r^2}\frac{d}{dr}(r^2\frac{d}{dr})$. The important fact is that maximum principle arguments may still be used to analyze the diagonalized expression of $\mathcal{L}''_{\Lambda_{\rho}}$ and to obtain a comparison result analogous to Proposition 4.4.

APPENDIX A. PROOF OF LEMMA 2.2

Since g is assumed to be non-negative and since f belongs to $L^{\infty}(\mathbb{R})$, it follows that

$$g - \rho ||f||_{\infty} \leqslant -\Delta u_{M,\rho,a} + M(1-a)u_{M,\rho,a} \leqslant g + \rho ||f||_{\infty}.$$

Let Φ_1 denote the unique solution of

$$\left\{ \begin{array}{ll} -\Delta\overline{\Phi}_1 + M(1-a)\Phi_1 = g & \text{ in } D \\ \overline{\Phi}_1 \in W_0^{1,2}(D), \end{array} \right.$$

and $\overline{\Phi}_2$ the unique solution of

$$\begin{cases} -\Delta \overline{\Phi}_2 + M(1-a)\overline{\Phi}_2 = -\rho \|f\|_{\infty}, \overline{\Phi}_2 & \text{in } D \\ \in W_0^{1,2}(D). \end{cases}$$

Observe that

$$-\Delta \left(u_{M,\rho,a} - (\overline{\Phi}_1 + \overline{\Phi}_2)\right) + M(1-a)(u_{M,\rho,a} - (\overline{\Phi}_1 + \overline{\Phi}_2)) \geqslant 0$$

in D, and one has therefore

$$u_{M,\rho,a} \geqslant \overline{\Phi}_1 + \overline{\Phi}_2$$

as a consequence of the generalized maximum principle (3.8). In the same way, we obtain

$$u_{M,\rho,a} \leqslant \overline{\Phi}_1 - \overline{\Phi}_2 \quad \text{in } D.$$

To conclude, let us prove that there exists N>0 such that for any $\rho\in[0,\overline{\rho})$,

$$\|\overline{\Phi}_1\|_{\infty} \leqslant N \quad \text{and} \quad \|\overline{\Phi}_2\|_{\infty} \leqslant N\rho.$$

Let us first deal with the estimate on Φ_1 . To this aim, one needs to introduce Ψ_1 as the unique solution of

$$\begin{cases} -\Delta \Psi_1 = g & \text{in } D \\ \Psi_1 \in W_0^{1,2}(D). \end{cases}$$

Since g is non-negative, the maximum principle ensures that $\overline{\Phi}_1 \geqslant 0$ and $\Psi_1 \geqslant 0$ in D. Furthermore, since D has a \mathscr{C}^2 boundary, classical $W^{2,p}$ elliptic estimates [3], Theorem 6.3 yield

$$||\Psi_1||_{W^{2,p}(D)} \leqslant C||g||_p$$

so that

$$\|\Psi_1\|_{\infty} \leqslant C' \|g\|_p =: N_1$$

for some constant C' = C'(D), by the Sobolev embedding $W^{2,p}(D) \hookrightarrow L^{\infty}(D)$. We now notice that

$$-\Delta(\overline{\Phi}_1 - \Psi_1) + M(1 - a)(\overline{\Phi}_1 - \Psi_1) = -M(1 - a)\Psi_1 \leqslant 0,$$

so that the generalized maximum principle (3.8) yields $\overline{\Phi}_1 \leq \Psi_1$ in D. Since $\overline{\Phi}_1$ is non-negative, the conclusion follows.

Let us now deal with $\overline{\Phi}_2$. It can be estimated thanks to Talenti's estimate for the torsion function [21]: let w_D be the torsion function of D, we then have $||w_D||_{\infty} \leqslant \frac{1}{2d} \left(\frac{|D|}{\omega_d}\right)^{2/d}$ (where ω_d is the volume of the unit ball). Thus

$$\|\overline{\Phi}_2\|_{\infty} \leqslant \frac{\rho}{2d} \left(\frac{|D|}{\omega_d}\right)^{2/d} := \rho N_2. \tag{A.1}$$

Setting $N = \max(N_1, N_2)$ yields the desired conclusion.

Appendix B. Proof of Proposition 3.2

We recall that we want to establish that if $(\Omega_k)_{k\in\mathbb{N}}\in\mathcal{O}_m^{\mathbb{N}}$ γ -converges to Ω , then

$$J_{\rho}(\Omega) = \lim_{k \to \infty} J_{\rho}(\Omega_k).$$

Fix such a sequence $(\Omega_k)_{k\in\mathbb{N}}$ that γ -converges to Ω . For the sake of clarity, we drop the subscript ρ , f and g and define, for every $k \in \mathbb{N}$, $u_k \in W_0^{1,2}(D)$ the unique solution to

$$\begin{cases}
-\Delta u_k + \rho f(u_k) = g \text{ in } \Omega_k, \\
u_k \in W_0^{1,2}(\Omega_k), \\
u_k \text{ is extended by zero as a function in } W_0^{1,2}(D).
\end{cases}$$

First note that, for any $k \in \mathbb{N}$, multiplying the equation by u_k and integrating by parts immediately yields

$$\lambda_{1}(D) \int_{D} u_{k}^{2} = \lambda_{1}(D) \int_{\Omega_{k}} u_{k}^{2} \leqslant \lambda_{1}(\Omega_{k}) \int_{\Omega_{k}} u_{k}^{2} \leqslant \int_{\Omega_{k}} |\nabla u_{k}|^{2}$$

$$\leqslant ||g||_{L^{2}(\Omega_{k})} ||u||_{L^{2}(\Omega_{k})} + \rho ||f||_{L^{\infty}(\mathbb{R})} |\Omega_{k}|^{\frac{1}{2}} ||u_{k}||_{L^{2}(\Omega_{k})}.$$

The sequence $(u_k)_{k\in\mathbb{N}}$ is thus uniformly bounded in $W_0^{1,2}(D)$. By the Rellich-Kondrachov Theorem, $(u_k)_{k\in\mathbb{N}}$ converges (up to a subsequence, strongly in $L^2(D)$ and weakly in $W_0^{1,2}(D)$) to a function $u\in W_0^{1,2}(D)$.

The dominated convergence theorem then yields that the sequence $(f(u_k))_{k\in\mathbb{N}}$ converges strongly in $L^2(D)$, to f(u). Thus, the sequence $(g-f(u_k))_{k\in\mathbb{N}}$ converges strongly in $L^2(D)$ to g-f(u). Since by assumption $(\Omega_k)_{k\in\mathbb{N}}$ γ -converges to Ω and since the right hand term converges strongly to $g-\rho f(u)$ in $L^2(D)$, it follows that $(u_k)_{k\in\mathbb{N}}$ converges strongly in $W_0^{1,2}(D)$ to u and that u solves

$$\begin{cases} -\Delta u + \rho f(u) = g \text{ in } \Omega, \\ u \in W_0^{1,2}(\Omega), \end{cases}$$

which is unique.

This strong convergence immediately implies that

$$J(\Omega) = \lim_{k \to \infty} J(\Omega_k),$$

thus concluding the proof of Proposition 3.2.

APPENDIX C. PROOF OF LEMMA 3.3

Proof of Lemma 3.3. Let us first prove that $(u_{M,\rho,a})_{M\geqslant 0}$ is uniformly bounded in $W_0^{1,2}(D)$ with respect to M and ρ . To this aim, let us multiply (2.2) by $u_{M,\rho,a}$ and integrate by parts. One gets

$$\int_{D} |\nabla u_{M,\rho,a}|^{2} \leq \int_{D} |\nabla u_{M,\rho,a}|^{2} + M(1-a)u_{M,\rho,a}^{2}$$

$$\leq \|g\|_{L^{2}(D)} \|u_{M,\rho,a}\|_{L^{2}(D)} + \rho \left(f(0) + \|f\|_{W^{1,\infty}}\right) \|u_{M,\rho,a}\|_{L^{2}(D)}.$$

By using the Poincaré inequality, we infer a uniform estimate of $u_{M,\rho,a}$ in $W_0^{1,2}(D)$. According to the Rellich-Kondrachov Theorem, there exists $u^* \in W_0^{1,2}(D)$ such that, up to a subfamily, $(u_{M,\rho,a})_{M\geqslant 0}$ converges to u^* weakly in $W^{1,2}(D)$ and strongly in $L^2(D)$. As a consequence, up to a subsequence, $(f(u_{M,\rho,a}))_{M\geqslant 0}$ converges to $f(u^*)$ in $L^2(D)$ by using that f is Lipschitz and $\int_D gu_{M,a_n}$ converges to $\int_D gu^*$ By rewriting (2.2) under variational form with $u=u_{M,\rho,a}$, and passing to the limit as $M\to +\infty$ after having adequately extracted subsequences, we infer that u^* is the unique solution of (2.2). Using $u_{M,\rho,a}$ as a test function in (1.2) and plugging the expression yielded in the definition of $\hat{J}_{M,\rho}(a)$, we first obtain

$$\hat{J}_{M,\rho}(a) = -\frac{\rho}{2} \int_{D} u_{M,\rho,a} f(u_{M,\rho,a}) - \int_{D} g, u_{M,\rho,a}$$

so that, from the previous convergence result, we have

$$\hat{J}_{M,\rho}(a) \to -\frac{\rho}{2} \int_D u^* f(u^*) - \int_D g, u^* \quad \text{as } M \to +\infty.$$

Finally, if $a = \mathbb{1}_{\Omega}$ and if Ω is a stable quasi-open set, by multiplying (2.2) by $u_{M,\rho,a}$ and integrating by parts, one gets

$$\int_{D} |\nabla u_{M,\rho,a}|^{2} + M \int_{D \setminus \Omega} u_{M,\rho,a}^{2} = \int_{D} (g - \rho f(u_{M,\rho,a})) u_{M,\rho,a},$$

and since the right-hand side is uniformly bounded with respect to M, we infer that $\sqrt{M}u_{M,\rho,a}$ is bounded in $L^2(D\backslash\Omega)$ so that $u^*=0$ almost everywhere in $D\backslash\Omega$. Since Ω is stable, this is, by definition, equivalent to $u^*\in W_0^{1,2}(\Omega)$.

The conclusion follows by observing that this convergence result is indeed valid without need to extract subfamily, since the closure points of $\{u_{M,\rho,a}\}_{M>0}$ reduces to a unique element.

Appendix D. Proof of Lemma 3.4

We recall that Ω is a stable quasi-open set if the sets

$$W_0^{1,2}(\Omega) := \{ w \in W^{1,2}(D), w = 0 \text{ q.e in } D \setminus \Omega \}$$

and

$$\hat{W}_0^{1,2}(\Omega) := \left\{ w \in W^{1,2}(D) \,, w = 0 \text{ a.e in } D \backslash \Omega \right\}$$

coincide.

The assumption of Lemma 3.4 is that for $0 < \rho \leq \overline{\rho}$, the functional J_{ρ} is monotonous on the set of stable quasi-open sets $\mathcal{O}_{m,s}(D)$:

$$\forall (\Omega_1, \Omega_2) \in (\mathcal{O}_{m,s}(D))^2, \quad \Omega_1 \subset \Omega_2 \Rightarrow J_{\rho}(\Omega_1) \geqslant J_{\rho}(\Omega_2).$$

Let us now prove that the functional J_{ρ} is monotonous on $\mathcal{O}(D)$, namely

$$\forall (\Omega_1, \Omega_2) \in (\mathcal{O}(D))^2, \quad \Omega_1 \subset \Omega_2 \Rightarrow J_\rho(\Omega_1) \geqslant J_\rho(\Omega_2).$$

We first prove that J_{ρ} is monotonous on the set of open sets

$$\mathcal{O}_{m,o}(D) := \{ \Omega \in \mathcal{O}_m(D), \Omega \text{ is open} \}.$$

Proof of the monotonicity on $\mathcal{O}_{m,o}(D)$. We use results from [20], Lemmas 2.3 and 2.6.

We consider two admissible open sets $\Omega_1 \subset \Omega_2$, where $\Omega_1, \Omega_2 \in \mathcal{O}_{m,o}(D)$. Let us consider, for i = 1, 2, an increasing sequence $(\Omega_{i,k})_{k \in \mathbb{N}}$ of smooth open sets included in Ω_i which Hausdorff converges to Ω_i .

We can assume that, for every $k \in \mathbb{N}$, $\Omega_{2,k} = \Omega_{2,k} \cup \Omega_{1,k}$, and that this sequence still Hausdorff-converges to Ω_2 . As in [20], Proof of Point (2), Lemma 3.6, the sequence $(\Omega_{i,k})_{k\in\mathbb{N}}$ (strong) γ -converges to Ω_i , i=1,2. Since the functional is continuous for the strong γ -convergence, we can pass to the limit in the inequalities

$$J_{\rho}(\Omega_{1,k}) \geqslant J_{\rho}(\Omega_{2,k})$$

and obtain the required conclusion.

We can now prove Lemma 3.4.

Proof of Lemma 3.4. From a classical result recalled in [20], Lemma 2.6, for any $\Omega_1 \subset \Omega_2$ such that $\Omega_1, \Omega_2 \in \mathcal{O}_m(D)$ and i = 1, 2, there exists a sequence $(\Omega_{i,k})_{k \in \mathbb{N}}$ of open sets included in Ω_i that γ -converges to Ω_i .

Up to replacing $\Omega_{2,k}$ with $\Omega_{1,k} \cup \Omega_{2,k}$, giving a new sequence that still γ -converges to Ω_2 and is still open, we can assume that

$$\forall k \in \mathbb{N}, \Omega_{1,k} \subset \Omega_{2,k}.$$

Since J_{ρ} is monotonous on $\mathcal{O}_{m,\rho}$, we have, for every k,

$$J_{\rho}(\Omega_{1,k}) \geqslant J_{\rho}(\Omega_{2,k})$$

and the strong continuity for the γ -convergence of sets allows us to pass to the limit in these inequalities, yielding the desired result.
