CLASSIFICATION OF BACKWARD FILTRATIONS AND FACTOR FILTRATIONS: EXAMPLES FROM CELLULAR AUTOMATA

ABSTRACT. We consider backward filtrations generated by processes coming from deterministic and probabilistic cellular automata. We prove that these filtrations are standard in the classical sense of Vershik's theory, but we also study them from another point of view that takes into account the measure-preserving action of the shift map, for which each sigma-algebra in the filtrations is invariant. This initiates what we call the dynamical classification of factor filtrations, and the examples we study show that this classification leads to different results.

1. Introduction

The topic of this paper is the study of some backward filtrations, or filtrations in discrete negative time, which are non-decreasing sequences of the form $\mathscr{F} = (\mathscr{F}_n)_{n\leq 0}$ where each \mathscr{F}_n is a sub-sigma-algebra on a given probability space. In the sequel, we will simply refer to them as *filtrations*.

In this work, all measure spaces are implicitely assumed to be Polish spaces equipped with their Borel sigma-algebra, and we only consider random variables taking their values in such spaces. If X is a random variable defined on some probability space (Ω, \mathbb{P}) , taking values in a Polish space E, the law of X is the probability measure $\mathcal{L}(X)$ on E which is the pushforward measure of \mathbb{P} by the measurable map X. We call copy of X any random variable X', possibly defined on another probability space, such that $\mathcal{L}(X') = \mathcal{L}(X)$ (in particular, X' takes its values in the same space as X). Given a family $(X_m)_{m \in I}$ of random variables defined on a given probability space (Ω, \mathbb{P}) , we denote by $\Sigma(X_m : m \in I)$ the subsigma algebra generated by the random variables X_m , $m \in I$ and the negligible sets. All sigma-algebras are supposed to be complete and essentially separable: they are generated (modulo negligible sets) by countably many events (or, equivalentely, by countably many random variables).

Therefore, each filtration $\mathscr{F} = (\mathscr{F}_n)_{n\leq 0}$ we consider can be generated by a process in negative time (that is to say a family $X = (X_n)_{n\leq 0}$ of random variables), which means that for each $n \leq 0$, $\mathscr{F}_n = \Sigma(X_m : m \leq n)$. The filtration \mathscr{F} is then the mathematical object that describes the acquisition of information as the process $(X_n)_{n\leq 0}$ evolves from $-\infty$ up to the present time. Of course there is not a unique process generating a given filtration, and the classification of filtrations is roughly

equivalent to answering the following question: given a filtration \mathscr{F} , can we find a "nice" process generating it?

In this direction, the simplest structure we can have is called a *filtration of product* type, which means a filtration which can be generated by a sequence $X = (X_n)_{n \le 0}$ of independent random variables. Then there is the slightly more general notion of standard filtration: a filtration which is immersible into a filtration of product type (see Definition 2.3 below).

Classification of backward filtrations was initiated by Vershik in the 1970's [16]. His work, which was written in the language of ergodic theory, remained quite confidential until a new publication in the 1990's [17]. Then some authors started to bring the subject into probability theory where they found nice applications (see in particular [5, 15, 6]). In the present paper, among other things we propose a return trip to ergodic theory by considering special families of filtrations on measure-theoretic dynamical systems (such systems are given by the action of a measure-preserving transformation T on a probability space $(\Omega, \mathcal{A}, \mathbb{P})$. Filtrations in measure-theoretic dynamical systems have already been considered by many authors (see e.g. [8, 9, 2, 3]), but in situations where the transformation acts "in the direction of the filtration": in these works the filtrations are such that $\mathscr{F}_{n-1} = T^{-1}\mathscr{F}_n \subsetneq \mathscr{F}_n$. Here we adopt a transverse point of view: we consider examples where the sigma-algebras forming the filtration are invariant with respect to the underlying transformation: $\mathscr{F}_n = T^{-1}\mathscr{F}_n$ for each $n \leq 0$. We get what we call factor filtrations, and we would like to classify these objects by taking into account the transverse action of the transformation. To emphasize the role of the underlying dynamical system, we will call the classification of factor filtrations the dynamical classification of factor filtrations. By opposition, we will refer to the usual classification of filtrations as the *static* classification.

The examples that we consider in this paper are all derived from the theory of cellular automata, where the underlying measure-preserving transformation is the shift of coordinates. We provide in this context natural examples of factor filtrations, some of which show a different behaviour depending on whether we look at them from a static or a dynamical point of view.

- 1.1. Examples of filtrations built from cellular automata. We define in this section the two filtrations which will be studied in the paper. The first one is built from an algebraic cellular automaton τ , and the second one from a random perturbation of τ , depending on a parameter ε and denoted by τ_{ε} . Both automata are one-dimensional (cells are indexed by \mathbb{Z}) and the state of each cell is an element of a fixed finite Abelian group $(\mathbb{A}, +)$, which we assume non trivial: $|\mathbb{A}| \geq 2$.
- 1.1.1. The deterministic cellular automaton τ and the filtration $\mathscr{F}^{\tau^{-1}}$. We first define the deterministic cellular automaton $\tau: \mathbb{A}^{\mathbb{Z}} \to \mathbb{A}^{\mathbb{Z}}$. Given a configuration $x = (x(i))_{i \in \mathbb{Z}}$, the image configuration τx is given by

(1)
$$\forall i \in \mathbb{Z}, \ \tau x(i) := x(i) + x(i+1).$$

Observe that τ can be written as $\tau = \sigma + \mathrm{Id}$, where σ is the left shift on $\mathbb{A}^{\mathbb{Z}}$.

For any finite set S, we denote by \mathcal{U}_S the uniform probability measure on S. We consider on $\mathbb{A}^{\mathbb{Z}}$ the product probability measure $\mu := \mathcal{U}_{\mathbb{A}}^{\otimes \mathbb{Z}}$, which is the normalized Haar measure on the compact Abelian group $\mathbb{A}^{\mathbb{Z}}$. The measure μ is invariant by τ .

On the probability space $(\mathbb{A}^{\mathbb{Z}}, \mu)$, we construct a negative-time process $(X_n)_{n \leq 0}$ as follows: we first consider the random variable X_0 taking values in $\mathbb{A}^{\mathbb{Z}}$ and simply defined by the identity on $\mathbb{A}^{\mathbb{Z}}$. Then we set for each integer $n \leq 0$,

$$X_n := \tau^{|n|} X_0.$$

Since the law μ of X_0 is preserved by τ , all the random variables X_n defined in this way have the same law μ .

We denote by $\mathscr{F}^{\tau^{-1}}$ the filtration generated by this process $(X_n)_{n\leq 0}$: for each $n\leq 0$, $\mathscr{F}_n^{\tau^{-1}}=\Sigma(X_m:m\leq n)=\Sigma(X_m)$. We use τ^{-1} instead of τ in this notation to insist on the fact that the time of the process generating this filtration goes in the other direction than that of the cellular automaton τ .

1.1.2. The probabilistic cellular automaton τ_{ε} and the filtration $\mathscr{F}^{\tau_{\varepsilon}}$. We also introduce a random perturbation of the deterministic cellular automaton τ , depending on a parameter ε which is the probability of making an error in the computation of the new state of a given cell. More precisely, we fix $\varepsilon > 0$ and we define τ_{ε} as the Markov kernel on $\mathbb{A}^{\mathbb{Z}}$ given by the following: for each $x \in \mathbb{A}^{\mathbb{Z}}$, $\tau_{\varepsilon}(x, \cdot)$ is the law of a random variable of the form $\tau x + \xi$, where ξ is a random error, wih law

$$\mathscr{L}(\xi) = \bigotimes_{i \in \mathbb{Z}} \Big((1 - \varepsilon) \delta_{0_{\mathbb{A}}} + \frac{\varepsilon}{|\mathbb{A}| - 1} \sum_{a \in \mathbb{A} \setminus \{0_{\mathbb{A}}\}} \delta_a \Big).$$

In the sequel, we will always assume that

$$(2) 0 < \varepsilon < \frac{[\mathbb{A}|-1}{|\mathbb{A}|}.$$

Thus, setting

(3)
$$\tilde{\varepsilon} := \varepsilon \frac{|\mathbb{A}|}{|\mathbb{A}| - 1} < 1,$$

we can also write the law of the random error ξ as

(4)
$$\mathscr{L}(\xi) = \bigotimes_{i \in \mathbb{Z}} \left((1 - \tilde{\varepsilon}) \delta_{0_{\mathbb{A}}} + \frac{\tilde{\varepsilon}}{|\mathbb{A}|} \sum_{a \in \mathbb{A}} \delta_a \right).$$

The following lemma shows that the probability measure μ on $\mathbb{A}^{\mathbb{Z}}$ defined in Section 1.1.1 is invariant by this Markov kernel (in fact, as we will prove later, it is the only one: see Corollary 2.16).

Lemma 1.1. Let $X = (X(i) : i \in \mathbb{Z})$ and $\xi = (\xi(i) : i \in \mathbb{Z})$ be two independent random variables taking values in $\mathbb{A}^{\mathbb{Z}}$, where $\mathcal{L}(X) = \mu$. Then $\mathcal{L}(\tau X + \xi) = \mu$.

Proof. We already know that $\mathcal{L}(\tau X) = \mu$. By independence of τX and ξ , and since μ is the Haar measure on $\mathbb{A}^{\mathbb{Z}}$, for $a \in \mathbb{A}^{\mathbb{Z}}$ we have

$$\mathcal{L}(\tau X + \xi | \xi = a) = \mathcal{L}(\tau X + a) = \mu.$$

(Note that the proof of the lemma is valid regardless of the law of the error ξ .) By invariance of μ under τ_{ε} , we can construct on some probability space (Ω, \mathbb{P}) a stationary Markov chain $(X_n)_{n\in\mathbb{Z}}$, where for each $n\in\mathbb{Z}$, X_n takes its values in

 $\mathbb{A}^{\mathbb{Z}}$, the law of X_n is $\mathscr{L}(X_n) = \mu$, and for each $x \in \mathbb{A}^{\mathbb{Z}}$, the conditional distribution of X_{n+1} given $X_n = x$ is

$$\mathscr{L}(X_{n+1}|X_n=x)=\tau_{\varepsilon}(x,\cdot).$$

We will denote by $\mathscr{F}^{\tau_{\varepsilon}}$ the filtration generated by the negative-time part of such a process: for each $n \leq 0$, $\mathscr{F}_n^{\tau_{\varepsilon}} = \Sigma(X_m : m \leq n)$. If we want to define $\mathscr{F}^{\tau_{\varepsilon}}$ in a canonical way, we can always assume that in this construction, $\Omega = (\mathbb{A}^{\mathbb{Z}})^{\mathbb{Z}}$ and \mathbb{P} is the law of the stationary Markov chain on Ω .

2. Usual (Static) classification of filtrations

2.1. A very short abstract of the theory. We recall the main points in the usual theory of classification of filtrations. We refer to [6, 11] for details.

We start with the following definition of isomorphic filtrations, which is of course equivalent to the definition provided in the cited references.

Definition 2.1 (Isomorphism of filtrations). Let \mathscr{F} and \mathscr{F}' be two filtrations, possibly defined on two different probability spaces. We say that they are isomorphic if we can find two processes $X=(X_n)_{n\leq 0}$ and $X'=(X'_n)_{n\leq 0}$ with the same law generating respectively $\mathscr F$ and $\mathscr F'$. We write in this case $\mathscr F\sim \mathscr F'$, or $\mathscr F\stackrel{X,X'}{\sim}\mathscr F'$ to specify the processes involved in the isomorphism.

It may not seem obvious in the above formulation that this notion of isomorphism is transitive. We refer the reader who would like details on this point to [10,

Let \mathscr{F} and \mathscr{F}' be two isomorphic filtrations, and let X and X' be two processes such that $\mathscr{F} \overset{X,X'}{\sim} \mathscr{F}'$. If Y is an \mathscr{F}_0 -measurable random variable, it is a classical result in measure theory that there exists some measurable map ϕ satisfying Y = $\phi(X)$ a.s. Then the isomorphism implicitely provides an \mathscr{F}'_0 -measurable copy of Y, namely random variable $Y' := \phi(X')$. Of course, this copy depends on the choice of the processes X and X' used in the isomorphism.

Let \mathscr{A} , \mathscr{B} and \mathscr{C} be 3 sub-sigma-algebras on the same probability space, with $\mathscr{C} \subset \mathscr{A} \cap \mathscr{B}$. We recall that \mathscr{A} and \mathscr{B} are independent conditionally to \mathscr{C} if, whenever X and Y are bounded real random variables, respectively \mathscr{A} and \mathscr{B} measurable, we have

$$\mathbb{E}\big[XY|\mathscr{C}\big] = \mathbb{E}\big[X|\mathscr{C}\big]\,\mathbb{E}\big[Y|\mathscr{C}\big] \quad \text{(a.s.)}$$

We note in this case

$$\mathscr{A} \stackrel{\mathscr{C}}{\underline{\parallel}} \mathscr{B}.$$

Definition 2.2 (Immersion). Let \mathscr{F} and \mathscr{G} be two filtrations on the same probability space. We say that $\mathscr F$ is immersed in $\mathscr G$ if the following conditions are satisfied:

- for each $n \leq 0$, $\mathscr{F}_n \subset \mathscr{G}_n$ (\mathscr{F} is included in \mathscr{G}); for each $n \leq -1$, $\mathscr{F}_{n+1} \perp \!\!\! \perp \!\!\! \perp \!\!\! \perp \!\!\! \subseteq_n$.

We write in this case $\mathscr{F} \prec \mathscr{G}$.

We say that \mathscr{F} and \mathscr{G} are jointly immersed if both \mathscr{F} and \mathscr{G} are immersed in the filtration $\mathscr{F} \vee \mathscr{G}$.

Definition 2.3 (Immersibility). Let \mathscr{F} and \mathscr{G} be two filtrations, possibly defined on different probability spaces. We say that \mathscr{F} is immersible in \mathscr{G} if there exists a filtration \mathscr{F}' immersed in \mathscr{G} such that \mathscr{F}' and \mathscr{F} are isomorphic. We write in this case $\mathscr{F} \prec \mathscr{G}$.

We can now define the following basic hierarchy of properties for filtrations.

Definition 2.4. The filtration \mathscr{F} is said to be of product type if it can be generated by a process formed of independent random variables.

The filtration \mathscr{F} is said to be standard if it is immersible in a filtration of product type.

The filtration \mathscr{F} is said to be Kolmogorovian if its tail sigma-algebra

$$\mathscr{F}_{-\infty} := \bigcap_{n \le 0} \mathscr{F}_n$$

is trivial (it only contains events of probability 0 or 1).

It is a direct consequence of the definitions and of Kolmogorov 0-1 law that the following chain of implications holds:

Product type
$$\Longrightarrow$$
 Standard \Longrightarrow Kolmogorovian.

A simple example of a standard filtration which is not of product type has been provided by Vinokurov (see [6]). The construcion of a Kolmogorovian filtration which is not standard was one of the first spectacular achievements of Vershik in this theory.

2.2. Filtrations of Product type: Example of $\mathscr{F}^{\tau^{-1}}$. We now come back to the filtration $\mathscr{F}^{\tau^{-1}}$ defined in Section 1.1.1, and we use here the same notations as in this section. In particular, the process $X=(X_n)_{n\leq 0}$ generating $\mathscr{F}^{\tau^{-1}}$ is a process where each coordinate X_n takes its values in $\mathbb{A}^{\mathbb{Z}}$, $\mathscr{L}(X_n)=\mu$, and $X_{n-1}=\tau X_n$. The purpose of this section is to prove the following result.

Theorem 2.5. The filtration $\mathscr{F}^{\tau^{-1}}$ is of product type.

The above theorem is a direct consequence of the two following lemmas.

Lemma 2.6. For each sequence $(i_n)_{n\leq 0}$ of integers, the random variables $X_n(i_n)$, $n\leq 0$, are independent.

Lemma 2.7. Consider the sequence $(i_n)_{n\leq 0}$ of integers defined by $i_n := -\lfloor |n|/2 \rfloor$. Then the process $(X_n(i_n))_{n\leq 0}$ generates the filtration $\mathscr{F}^{\tau^{-1}}$.

Proof of Lemma 2.6. Let us first consider, on a probability space (Ω, \mathbb{P}) , a random variable $Y = (Y(i) : i \in \mathbb{Z})$ taking values in $\mathbb{A}^{\mathbb{Z}}$, and such that $\mathcal{L}(Y) = \mu$. Let us fix some integers i, j, k such that $j \leq k$ and $i \in \{j, \dots, k, k+1\}$. For each block $w \in \mathbb{A}^{\{j,\dots,k\}}$ and each $a \in \mathbb{A}$, it is straightforward to check from the construction of τ that there exists a unique block $w' \in \mathbb{A}^{\{j,\dots,k,k+1\}}$ such that

- w'(i) = a
- $Y[j, k+1] = w' \Longrightarrow \tau Y[j, k] = w$.

Let us denote by $\tau_{a,i}^{-1}(w)$ this block w'. We then have the following equivalence:

$$\tau Y[j,k] = w \iff \exists a \in \mathbb{A}, \ Y[j,k+1] = \tau_{a,i}^{-1}(w).$$




FIGURE 1. Illustration of Lemma 2.8: the variables marked with a circle can be computed from the ones marked with a square.

But by construction of μ , all the $|\mathbb{A}|$ events $(Y[j, k+1] = \tau_{a,i}^{-1}(w))$, $a \in \mathbb{A}$ have the same probability (and are of course disjoint). It follows that, for each $a \in \mathbb{A}$,

$$\mathbb{P}\big(Y(0) = a \,|\, \tau Y[j,k] = w\big) = \mathbb{P}\Big(Y[j,k+1] = \tau_{a,i}^{-1}(w) \,|\, \tau Y[j,k] = w\Big) = \frac{1}{|\mathbb{A}|}.$$

Since this holds for any block $w \in \mathbb{A}^{\{j,\dots,k\}}$, this proves that Y(i) is independent of $\tau Y[j,k]$. Then, since this is true for each j,k such that $i \in \{j,\dots,k,k+1\}$, Y(i) is independent of τY .

Let us apply this with $Y=X_n$ for some $n \leq 0$: we get that, for each $i_n \in \mathbb{Z}$, $X_n(i_n)$ is independent of $\tau X_n = X_{n-1}$. Now if we have an arbitrary sequence $(i_n)_{n \leq 0}$ of integers, we note that for each $n \geq 0$, the random variables $X_m(i_m)$, $m \leq n-1$ are all $\mathscr{F}_{n-1}^{\tau^{-1}}$ -measurable, hence $X_n(i_n)$ is independent of $\Sigma(X_m(i_m): m \leq n-1)$.

Lemma 2.7 will be derived from the following result (see Figure 1).

Lemma 2.8. Consider integers $m \le n \le 0$, and let $(i_m, i_{m+1}, ..., i_n)$ be a finite sequence of integers such that, for each $m \le \ell \le n-1$,

(5)
$$i_{\ell+1} = i_{\ell} \quad \text{or} \quad i_{\ell+1} = i_{\ell} + 1.$$

Then $X_n[i_m, i_m + n - m]$ is measurable with respect to $\Sigma(X_m(i_m), ..., X_n(i_n))$.

Proof. For a fixed m, we prove the result by induction on n. If n=m the result is obvious. Assume now that, for some $m+1 \leq n \leq 0$, the result holds up to n-1. Then $X_{n-1}[i_m,i_m+n-1-m]$ is measurable with respect to $\Sigma(X_m(i_m),...,X_{n-1}(i_{n-1}))$. Remembering the notation $\tau_{a,i}^{-1}(w)$ from the proof of Lemma 2.6, and since by assumption we have $i_n \in \{i_m,\ldots,i_m+n-1\}$, we can then write

$$X_n[i_m, i_m + n - m] = \tau_{X_n(i_n), i_n}^{-1} (X_{n-1}[i_m, i_m + n - 1 - m]),$$

hence $X_n[i_m, i_m + n - m]$ is measurable with respect to $\Sigma(X_m(i_m), ..., X_n(i_n))$ as claimed.

Proof of Lemma 2.7. The sequence (i_n) defined in the statement of Lemma 2.7 obviously satisfies (5). Moreover, we have $i_m \to -\infty$ as $m \to -\infty$, and for any fixed $n \le 0$, $i_m + n - m \to +\infty$ as $m \to -\infty$. By application of Lemma 2.8, it follows that X_n is measurable with respect to $\Sigma(X_m(i_m): m \le n)$. But conversely all the random variables $X_m(i_m)$, $m \le n$, are $\mathscr{F}_n^{\tau^{-1}}$ -measurable. Hence these variables generate $\mathscr{F}_n^{\tau^{-1}}$.

2.3. Standardness and I-cosiness. The example of the filtration $\mathscr{F}^{\tau^{-1}}$ is very special, as it is not so hard to explicit a process with independent coordinates which generates the filtration. In general, when we have a standard filtration, it may be very hard to find such a process from which the filtration is built. This is one of the reasons why several criteria of standardity have been developed, allowing to prove the standardity of a filtration without giving explicitly the process with independent coordinates. The first such criterion was given by Vershik [17], but here we will be interested in another one, called *I-cosiness*, introduced by Émery and Schachermayer [6] and strongly inspired by ideas of Tsirelson [15] and Smorodinsky [14].

We first have to define the concept of real-time coupling for a filtration.

Definition 2.9 (Real-time coupling). Let $\mathscr{F} = (\mathscr{F}_n)_{n \leq 0}$ a filtration on a probability space (Ω, \mathbb{P}) . We call real-time coupling of \mathscr{F} a pair $(\mathscr{F}', \mathscr{F}'')$ of filtrations, both defined on the same probability space (but possibly different from (Ω, \mathbb{P})), such that

- $\mathscr{F}' \sim \mathscr{F}$,
- $\mathcal{F}'' \sim \mathcal{F}$,
- \mathscr{F}' and \mathscr{F}'' are jointly immersed.

Such a real-time coupling of \mathscr{F} is said to be independent in the distant past if there exists $n_0 \leq 0$ such that \mathscr{F}'_{n_0} and \mathscr{F}''_{n_0} are independent. In this case, we also say n_0 -independent if we want to highlight n_0 .

In practice, if we want to construct a real-time coupling of a filtration generated by a process $X = (X_n)_{n \leq 0}$, we have to build on the same probability space two copies $X' = (X'_n)_{n \leq 0}$ and $X'' = (X''_n)_{n \leq 0}$ of X. The joint immersion of the filtrations they generate amonts to the following conditions for each $n \leq -1$:

$$\begin{split} \mathscr{L}\big(X_{n+1}'|\mathscr{F}_n'\vee\mathscr{F}_n''\big) &= \mathscr{L}\big(X_{n+1}'|\mathscr{F}_n'\big),\\ \text{and}\quad \mathscr{L}\big(X_{n+1}''|\mathscr{F}_n'\vee\mathscr{F}_n''\big) &= \mathscr{L}\big(X_{n+1}''|\mathscr{F}_n''\big). \end{split}$$

So, if we want to construct such a coupling step by step, assuming that we already have defined X'_m and X''_m for each $m \leq n$, the construction continues at time n+1 with the realization, conditionally to $\mathscr{F}'_n \vee \mathscr{F}''_n$, of a coupling of the two conditional laws $\mathscr{L}(X'_{n+1}|\mathscr{F}'_n)$ and $\mathscr{L}(X''_{n+1}|\mathscr{F}''_n)$. This explains the denomination real-time coupling.

Definition 2.10 (I-cosiness). Let \mathscr{F} be a filtration, and let Y be an \mathscr{F}_0 -measurable random variable Y taking values in some Polish metric space (E,d). Then Y is said to be I-cosy (with respect to \mathscr{F}) if, for each real number $\delta > 0$, we can find

a real-time coupling $(\mathcal{F}', \mathcal{F}'')$ of \mathcal{F} which is independent in the distant past, and such that the two copies Y' and Y'' of Y in \mathcal{F}' and \mathcal{F}'' respectively satisfy

(6)
$$d(Y',Y'') < \delta \text{ with probability } > 1 - \delta.$$

The filtration itself is said to be I-cosy if each \mathscr{F}_0 -measurable random variable Y is I-cosy with respect to \mathscr{F} .

The variable Y whose copies we want to be close together is called a *target*. Classical arguments of measure theory allow to considerably reduce the number of targets to test when we want to establish I-cosiness for a given filtration (see [11], or [10, Section 1.2.4]. In particular we will use the following proposition.

Proposition 2.11. Assume that \mathscr{F}_0 is generated by a countable family $(Z_i)_{i\in I}$ of random variables taking values in finite sets. Assume also that we have written the countable set I as an increasing union of finite sets I_k , $k \geq 0$. For each integer $k \geq 0$, denote by Y_k the random variable $(Z_i)_{i\in I_k}$. If Y_k is I-cosy for each k, then the filtration is I-cosy.

Note that, in the context of the above proposition, since Y_k takes only finitely many values, we can replace condition (6) by

$$Y'_k = Y''_k$$
 with probability $> 1 - \delta$.

The following result is proved in [6] using ideas from [17] (see also [11]).

Theorem 2.12. A filtration \mathscr{F} is standard if and only if it is I-cosy.

2.4. Standardity of the filtration $\mathscr{F}^{\tau_{\varepsilon}}$. We will apply the I-cosiness criterion to prove the standardity of the filtration $\mathscr{F}^{\tau_{\varepsilon}}$ defined in Section 1.1.1. We use now the notations introduced in this section: $X = (X_n)_{n \in \mathbb{Z}}$ is a stationary Markov process with transitions given by the Markov kernel τ_{ε} , for each n, X_n takes its values in $\mathbb{A}^{\mathbb{Z}}$ and follows the law μ . The filtration $\mathscr{F}^{\tau_{\varepsilon}}$ is generated by the negative part of this process.

Theorem 2.13. For each $0 < \varepsilon < \frac{[\mathbb{A}]-1}{|\mathbb{A}|}$, the filtration $\mathscr{F}^{\tau_{\varepsilon}}$ is I-cosy, hence it is standard.

Proof. Since $\mathscr{F}_0^{\tau_{\varepsilon}}$ is generated by the countable family of random variables $(X_n(i): n \leq 0, i \in \mathbb{Z})$, it is sufficient by Proposition 2.11 to check that, for each integer $k \geq 0$, the random variable $Y_k := (X_n[-k, k]: -k \leq n \leq 0)$ is I-cosy. In fact we will consider simpler targets, which are the random variables of the form $(X_0[-k, k])$, $(k \geq 0)$, and we will see at the end of the proof why this is enough.

So we fix an integer $k \geq 0$, we consider the target $(X_0[-k,k])$, and we fix a real number $\delta > 0$. To check the I-cosiness of $(X_0[-k,k])$, we have to construct on some probability space (Ω, \mathbb{P}) two copies X' and X'' of the process X, such that

- for some $n_0 \leq 0$,
- (7) $\mathscr{F}'_{n_0} = \Sigma(X'_m : m \le n_0)$ and $\mathscr{F}''_{n_0} = \Sigma(X''_m : m \le n_0)$ are independent, (to ensure that the filtrations \mathscr{F}' and \mathscr{F}'' generated by the negative parts of these process are independent in the distant past),
 - for each $n_0 + 1 \le n \le 0$,
- (8) $\mathscr{L}(X_n'|\mathscr{F}_{n-1}'\vee\mathscr{F}_{n-1}'')=\tau_{\varepsilon}(X_{n-1}',\cdot)$ and $\mathscr{L}(X_n''|\mathscr{F}_{n-1}'\vee\mathscr{F}_{n-1}'')=\tau_{\varepsilon}(X_{n-1}'',\cdot)$ (to get the joint immersion of the filtrations \mathscr{F}' and \mathscr{F}''), and

• the copies $(X'_0[-k,k])$ and $(X''_0[-k,k])$ of the target random variable satisfy

(9)
$$\mathbb{P}(X_0'[-k,k] = X_0''[-k,k]) > 1 - \delta.$$

Here is how we will proceed. We fix some $n_0 \leq 0$ and consider a probability space (Ω, \mathbb{P}) in which we have two independent copies $(X'_n : n \leq n_0)$ and $(X''_n : n \leq n_0)$ of $(X_n : n \leq n_0)$, and an independent family of i.i.d random variables $(U_n(i) : n \geq n_0 + 1, i \in \mathbb{Z})$ which are all uniformly distributed on the interval [0, 1]. These random variables will be used to construct inductively the error processes $(\xi'_n(i) : n \geq n_0 + 1, i \in \mathbb{Z})$ and $(\xi''_n(i) : n \geq n_0 + 1, i \in \mathbb{Z})$ and the rest of the Markov processes $(X'_n : n \geq n_0 + 1)$ and $(X''_n : n \geq n_0 + 1)$ through the formula

$$X'_n := \tau X'_{n-1} + \xi'_n$$
, and $X''_n := \tau X''_{n-1} + \xi''_n$.

We will use the auxilliary process Z := X' - X'', and we note that for $n \ge n_0 + 1$ we have

(10)
$$Z_n = \tau Z_{n-1} + \xi_n' - \xi_n''.$$

Rewriting (9) with this notation, we want to achieve the coupling in such a way that, provided $|n_0|$ is large enough,

(11)
$$\mathbb{P}(Z_0[-k,k] = (0_{\mathbb{A}}, \dots, 0_{\mathbb{A}})) > 1 - \delta.$$

We explain now how we construct inductively the error processes. Assuming that, for some $n \geq n_0 + 1$, we already have defined the processes X' and X'' up to time n-1, we choose for each $i \in \mathbb{Z}$ two random maps $g'_{n,i}$ and g''_{n_i} from [0,1] to \mathbb{A} and set $\xi'_n(i) := g'_{n,i}(U_n(i))$ and $\xi''_n(i) := g''_{n,i}(U_n(i))$. These maps are random in the sense that they depend on the realizations of the processes up to time n-1. However they have to comply with the required law for the errors, which we ensure as follows. Recalling the definition (3) of $\tilde{\varepsilon}$ and the formulation (4) of the law of the error, we build each of the maps $g'_{n,i}$ and g''_{n_i} by cutting the interval [0,1] into $|\mathbb{A}|+1$ subintervals: $|\mathbb{A}|$ of them are of the same length $\tilde{\varepsilon}/|\mathbb{A}|$ and we assign exactly one element of \mathbb{A} to each of them (which correspond to the uniform measure part of the error). The last subinterval is of length $1-\tilde{\varepsilon}$ and we set the value of the map to be $0_{\mathbb{A}}$ there. In this way we get the correct conditionnal law of the errors ξ'_n and ξ''_n knowing $\mathscr{F}'_{n-1} \vee \mathscr{F}''_{n-1}$, and we have (8).





FIGURE 2. Choice of $g'_{n,i}$ and $g''_{n,i}$ when we apply the strategy S_a

More precisely, given a site (n,i), for each $a \in \mathbb{A}$ we define the strategy S_a for the choice of the maps $g'_{n,i}$ and $g''_{n,i}$ (see Figure 2):

• The left part of the interval [0,1] is cut into $|\mathbb{A}|$ subintervals of the same length $\tilde{\varepsilon}/|\mathbb{A}|$, which we denote by J_b , $b \in \mathbb{A}$, and we set for $u \in J_b$:

$$g'_{n,i}(u) := b$$
 and $g''_{n,i}(u) := b + a$.

• On the remaining part on the right, which is of length $1 - \tilde{\varepsilon}$, we set

$$g'_{n,i}(u) := g''_{n,i}(u) := 0_{\mathbb{A}}.$$

In this way, when we apply this strategy we obtain

$$\xi_n''(i) - \xi_n'(i) = \begin{cases} a & \text{if } U_n(i) \in [0, \varepsilon), \\ 0_{\mathbb{A}} & \text{otherwise.} \end{cases}$$

The special case $a=0_{\mathbb{A}}$ gives $\xi_n''(i)-\xi_n'(i)=0_{\mathbb{A}}$ with probability one, and thus the choice of the strategy $S_{0_{\mathbb{A}}}$ on a given site (n,i) ensures that, locally, the

evolution of the Z process is given by the the determinist action of the cellular automaton τ (remember (10)).

The set of sites (n,i) for which we have to define $g'_{n,i}$ and $g''_{n,i}$ is partitionned into "diagonals" $\mathcal{D}(j), j \in \mathbb{Z}$, where

$$\mathcal{D}(j) := \{(n, i)/n \ge n_0 + 1, \ i = j - n\}.$$

(See Figure 3.) We observe that, for $i < j \in \mathbb{Z}$, any error added on some site of $\mathcal{D}(j)$ has no influence on $Z_0(i)$.

On all the diagonals $\mathcal{D}(j)$, j < -k or j > k, we systematically choose the strategy $S_{0_{\mathbb{A}}}$, so that Z follows the deterministic evolution of the cellular automaton τ in these areas. It remains to explain the choice of the strategies on the sites of the diagonals $\mathcal{D}(j)$, $-k \leq j \leq k$.

Consider an integer n, $n_0 < n \le 0$, and assume that we know the Z process up to time n-1. We compute $\tau^{|n-1|}(Z_{n-1})$, and according to what we get we make the following choices:

- If $\tau^{|n-1|}(Z_{n-1})[-k,k] = (0_{\mathbb{A}},\ldots,0_{\mathbb{A}})$, we can easily ensure that $Z_0[-k,k] = (0_{\mathbb{A}},\ldots,0_{\mathbb{A}})$ by choosing the strategy $S_{0_{\mathbb{A}}}$ for all the following sites. We set in this case $j_{n-1} := k+1$.
- Otherwise, we define j_{n-1} as the smallest integer $j \in \{-k, \dots, k\}$ such that

$$\tau^{|n-1|}(Z_{n-1})(j) \neq 0_{\mathbb{A}},$$

and we note $a_{n-1} := \tau^{|n-1|}(Z_{n-1})(j_{n-1})$. For $j < j_{n-1}$ and $(n, i) \in \mathcal{D}_j$, we apply the strategy $S_{0_{\mathbb{A}}}$. For $(n, i) \in \mathcal{D}_{j_{n-1}}$, we apply the strategy $S_{-a_{n-1}}$. Finally for $j > j_{n-1}$ and $(n, i) \in \mathcal{D}_j$, we get back to the strategy $S_{0_{\mathbb{A}}}$.

With this method, if $j_{n-1} \in \{-k, ..., k\}$, the only i on line n for which $Z_{n,i}$ is not determined is the unique i such that $(n, i) \in \mathcal{D}_{j_{n-1}}$, (that is to say, for $i = j_{n-1} + |n|$), and the value of this $Z_{n,i}$ now depends only on the random variable $U_n(j_{n-1} + |n|)$:

- If $U_n(j_{n-1}+|n|) \in [0,\varepsilon)$, the difference $\xi'_n(i)-\xi''_n(i)$ takes the value $-a_{n-1}$. This exactly compensates the determinist action of τ for the target site $(0,j_{n-1})$, which ensures that at the next step we get $\tau^{|n|}(Z_n)(j_{n-1})=0_{\mathbb{A}}$, and thus $j_n \geq j_{n-1}+1$.
- Otherwise, we have $\xi'_n(i) \xi''_n(i) = 0$, so that $\tau^{|n|}(Z_n)(j_{n-1}) = a(n)$ and $j_n = j_{n-1}$.

We construct inductively the real-time coupling by applying the above method for $n_0 + 1 \le n \le 0$. How we build the coupling for times $n \ge 0$ is irrelevant, we can for example choose always the strategy $S_{0_{\mathbb{A}}}$ for these positive times. Now we have to prove that (11) is achieved for $|n_0|$ large enough.

We define inductively random times $T(-k), \ldots, T(k)$. We start with T(-k), which only depends on the random variables $U_n(i), (n, i) \in \mathcal{D}(-k)$:

$$T(-k) := \min\{n > n_0 + 1 : U_n(-k - n) \in [0, \tilde{\varepsilon})\}.$$

(With the usual convention that $\min \emptyset = +\infty$, but observe that $T(-k) < \infty$ with probability 1.) The random variable $T(-k) - n_0$ then follows a geometric law of parameter $\tilde{\varepsilon}$. And by construction of the coupling, for each $n_0 + 1 \le n \le 0$ we have

$$T(-k) \le n \Longrightarrow j_n > -k$$
.

Then, if we have already defined T(i) for some $-k \le i \le k-1$, we set

$$T(j+1) := \min\{n \ge T(j) + 1 : U_n(j+1-n) \in [0,\varepsilon)\}.$$

Note that T(j+1) only depends on T(j) and on the random variables $U_n(i)$, $(n,i) \in \mathcal{D}(j+1)$. And by construction of the coupling, we get by induction that, for each $j \in \{-k, \ldots, k\}$ and each $n \leq 0$,

$$T(j) \le n \Longrightarrow j_n > j$$
.

In particular,

(12)
$$T(k) \le 0 \Longrightarrow j_0 > k \Longrightarrow Z_0[-k, k] = (0_{\mathbb{A}}, \dots, 0_{\mathbb{A}}).$$

For $j \in \{-k, ..., k-1\}$, the difference T(j+1) - T(j) is distributed according to a geometric law of parameter $\tilde{\varepsilon}$, and is independent of T(-k), ..., T(j). Hence $T(k) - n_0$ is distributed as the sum of 2k+1 independent geometric random variables of parameter $\tilde{\varepsilon}$. Therefore, as $\tilde{\varepsilon}$ and k are fixed, we get

(13)
$$\mathbb{P}(T(k) \le 0) \xrightarrow[r_0 \to -\infty]{} 1.$$

By (13) and (12), we get that (11) is satisfied for $|n_0|$ large enough.

This proves that for each $k \geq 0$, the target $X_0[-k,k]$ is I-cosy. Now, the same argument works also to prove the I-cosiness of $X_{-k}[-2k,2k]$ for each $k \geq 0$. This gives us a real-time coupling up to time -k for which

$$\mathbb{P}(Z_{-k}[-2k,2k] = (0_{\mathbb{A}},\ldots,0_{\mathbb{A}})) > 1 - \delta.$$

Note that

$$Z_{-k}[-2k,2k] = (0_{\mathbb{A}},\ldots,0_{\mathbb{A}}) \Longrightarrow \forall 0 \le \ell \le k, \ \tau^{\ell}Z_{k}[-k,k] = (0_{\mathbb{A}},\ldots,0_{\mathbb{A}})$$

So we can continue this coupling by always using the strategy $S_{0_{\mathbb{A}}}$ on lines $-k+1,\ldots,0$ to prove the I-cosiness of $Y_k=\big(X_n[-k,k]:-k\leq n\leq 0\big).$

2.5. Uniform cosiness and ergodicity of the Markov kernel. If we look carefully at the proof that the filtration $\mathscr{F}^{\tau_{\varepsilon}}$ is I-cosy, we see that the probability that the two copies of the target coincide in the real-time coupling converge to 1 as $|n_0| \to \infty$, uniformly with respect to the states of the two copies at time n_0 . We get in fact a stronger property than I-cosiness, which we call uniform cosiness, and which implies not only the I-cosiness of the filtration, but also the ergodicity of the Markov kernel.

Recall that a Markov kernel on a compact metric space (\mathcal{X}, d) is Feller if $x \mapsto P(x, \cdot)$ is continuous for the weak* topology. Any Feller Markov kernel on a compact metric space admits an invariant probability distribution on X. The Markov kernel is said to be *ergodic in the Markov sense* if there exists a probability distribution μ on X such that, for each probability measure ν on \mathcal{X} ,

$$\nu Q^n \xrightarrow[n\to\infty]{w*} \mu.$$

In this case, μ is the unique Q-invariant probability measure.

Definition 2.14 (Uniform cosiness). Let Q be a Markov kernel on a compact metric space (\mathcal{X},d) . We say that Q is uniformly cosy if, for each $\delta>0$, there exist $M=M(\delta)>0$ such that, whenever n_0 is a negative integer with $|n_0|\geq M$, for each $x',x''\in\mathcal{X}$, there exists a probability measure $m_{x',x''}$ on $\left(\mathcal{X}^{\{n_0,\dots,0\}}\right)^2$, depending measurably on (x',x'') such that, denoting by $(X'_n)_{n_0\leq n\leq 0}$ and $(X''_n)_{n_0\leq n\leq 0}$ the canonical processes defined by the coordinates on $\left(\mathcal{X}^{\{n_0,\dots,0\}}\right)^2$, the following conditions hold:

- The starting points of the processes are given by $X'_{n_0} = x'$ and $X''_{n_0} = x''$, $m_{x',x''}$ -almost surely.
- Under $m_{x',x''}$, for each $n_0 \le n \le -1$, the conditionnal distribution

$$\mathscr{L}\big((X_{n+1}',X_{n+1}'')\,|\,\mathbf{\Sigma}(X_{n_0}',\ldots,X_n',X_{n_0}'',\ldots,X_n'')\big)$$

is almost surely a coupling of the two probability distributions $Q(X'_n, \cdot)$ and $Q(X''_n, \cdot)$ (we thus realize from n_0 a real-time coupling of two Markov

processes of transitions probabilities given by Q; one starting at x' and the other at x'').

• We have

$$m_{x',x''}(d(X_0',X_0'') > \delta) < \delta.$$

For example, the proof of Theorem 2.13 shows that the Markov kernel defined by the probabilistic cellular automaton τ_{ε} is uniformly cosy.

Theorem 2.15. Let Q be a Feller Markov kernel on the compact metric space (\mathcal{X}, d) . If Q is uniformly cosy, then Q is ergodic in the Markov sense.

Proof. Let μ be a Q-invariant probability measure on \mathcal{X} , and let ν be any probability measure on \mathcal{X} . We want to prove that, for each continuous function $f: \mathcal{X} \to \mathbb{R}$ and each $\varepsilon > 0$, for n large enough we have

$$\left| \int_{\mathcal{X}} f \, d(\nu Q^n) - \int_{\mathcal{X}} f \, d\mu \right| \le \varepsilon.$$

Given f and ε , by uniform continuity of f on the compact \mathcal{X} , we get $\delta>0$ such that :

$$\forall x, y \in \mathcal{X}, \ d(x, y) \le \delta \Longrightarrow |f(x) - f(y)| < \varepsilon/2.$$

We can also assume that $\delta ||f||_{\infty} < \varepsilon/4$.

By uniform cosiness, we can take M>0 such that, given any integer $n_0 \leq -M$, there exist a family of probability measures $(m_{x',x''})_{x',x''\in\mathcal{X}}$ associated to this δ as in the statement of the definition of uniform cosiness. We then define the probability measure $m_{\mu,\nu}$ on $(\mathcal{X}^{\{n_0,\dots,0\}})^2$ by

$$m_{\mu,\nu} := \int_{\mathcal{X}} \int_{\mathcal{X}} m_{x',x''} d\mu(x') d\nu(x'').$$

Under $m_{\mu,\nu}$, $(X'_n)_{n_0 \leq n \leq 0}$ and $(X''_n)_{n_0 \leq n \leq 0}$ are two Markov chain with transitions given by Q, with respective initial laws $\mathscr{L}(X'_{n_0}) = \mu$ and $\mathscr{L}(X''_{n_0}) = \nu$. We then have $\mathscr{L}(X'_0) = \mu Q^{|n_0|} \mu = \mu$ by invariance of μ , and $\mathscr{L}(X''_0) = \nu Q^{|n_0|}$. The uniform cosiness yields

$$m_{\mu,\nu}\left(d(X_0',X_0'')>\delta\right)=\int_{\mathcal{X}}\int_{\mathcal{X}}\underbrace{m_{x',x''}\left(d(X_0',X_0'')>\delta\right)}_{<\delta}d\mu(x')\,d\nu(x'')<\delta.$$

We then have

$$\left| \int_{\mathcal{X}} f d(\nu Q^{|n_0|}) - \int_{\mathcal{X}} f d\mu \right| \leq \mathbb{E}_{m_{\mu,\nu}} \left[\left| f(X_0'') - f(X_0') \right| \right]$$

$$\leq \int_{d(X_0', X_0'') > \delta} \left| f(X_0'') - f(X_0') \right| dm_{\mu,\nu} + \varepsilon/2$$

$$\leq 2\delta \|f\|_{\infty} + \varepsilon/2 \leq \varepsilon.$$

Corollary 2.16. The Markov kernel given by the cellular automaton τ_{ε} is ergodic in the Markov sense, and $\mu = \mathcal{U}_{\mathbb{A}}^{\otimes \mathbb{Z}}$ is the unique τ_{ε} -invariant probability measure.

3. Dynamical classification of factor filtrations

3.1. Factor filtrations. In the two cases we have studied above, we observe that the filtrations $\mathscr{F}^{\tau^{-1}}$ and $\mathscr{F}^{\tau_{\varepsilon}}$ both enjoy an important property: if we consider their canonical construction, which is on $\mathbb{A}^{\mathbb{Z}}$ for $\mathscr{F}^{\tau^{-1}}$ and on $(\mathbb{A}^{\mathbb{Z}})^{\mathbb{Z}}$ for τ_{ε} , we have on the ambient probability space the action of the left shift σ , which is a measurepreserving transformation, and moreover all the sigma-algebras in those filtrations are invariant with respect to this automorphism. Our purpose in this section is to formalize such a situation, and adapt the study of the filtration to this context.

We call here dynamical system any system of the form (Ω, \mathbb{P}, T) , where (Ω, \mathbb{P}) is a probability space, and $T:\Omega\to\Omega$ is an invertible, bi-measurable transformation which preserves the probability measure \mathbb{P} . Given such a system, we call factor sigma-algebra of (Ω, \mathbb{P}, T) any sub-sigma algebra \mathscr{A} of the Borel sigma algebra of Ω which is invariant by T: for each $A \in \mathcal{A}$, $T^{-1}A$ and TA are also in \mathcal{A} . For any random variable X_0 defined on (Ω, \mathbb{P}) , as T preserves \mathbb{P} , the process $X = (X_n)_{n \in \mathbb{Z}}$ defined by

$$(14) \forall n \in \mathbb{Z}, \ X_n := X_0 \circ T^n$$

is stationary. Such a stationary process will be called a T-process. Whenever X is a T-process, the sigma-algebra generated by X is clearly a factor sigma-algebra of (Ω, \mathbb{P}, T) . Conversely, any factor sigma-algebra of (Ω, \mathbb{P}, T) is generated by some Tprocess (remember that all sigma-algebras are assumed to be essentially separable).

Definition 3.1. We call factor filtration any pair (\mathcal{F},T) where

- $\mathscr{F} = (\mathscr{F}_n)_{n \leq 0}$ is a filtration on some probability space (Ω, \mathbb{P}) ,
- (Ω, \mathbb{P}, T) is \bar{a} dynamical system,
- for each $n \leq 0$, \mathscr{F}_n is a factor sigma-algebra of (Ω, \mathbb{P}, T) .

In view of the above discussion, in a factor filtration (\mathcal{F},T) the filtration \mathcal{F} is always generated by a process $(X_n)_{n\leq 0}$, where for each $n, X_n = (X_n(i))_{i\in\mathbb{Z}}$ is a T-process.

The dynamical classification of factor filtrations that we want to introduce now aims at distinguishing these objects up to the following notion of isomorphism, which is the adaptation of Definition 2.1 to the dynamical context.

Definition 3.2 (Dynamical isomorphism of factor filtrations). Let (\mathscr{F},T) and (\mathscr{F}',T') be two factor filtrations, possibly defined on two different dynamical systems. We say that they are dynamically isomorphic if we can find two processes $X=(X_n)_{n\leq 0}$ and $X'=(X_n')_{n\leq 0}$ generating respectively $\mathscr F$ and $\mathscr F'$, and such that

- for each n, $X_n = (X_n(i))_{i \in \mathbb{Z}}$ is a T-process, and $X'_n = (X'_n(i))_{i \in \mathbb{Z}}$ is a T'-process; • $\mathcal{L}(X) = \mathcal{L}(X')$.

We write in this case $(\mathscr{F},T)\sim (\mathscr{F}',T'),$ or $(\mathscr{F},T)\stackrel{X,X'}{\sim} (\mathscr{F}',T')$ to specify the processes involved in the isomorphism.

We note the following specificity of dynamical isomorphism: if $(\mathscr{F},T) \overset{X,X'}{\sim}$ (\mathscr{F}',T') , and if Y' is the copy of an \mathscr{F}_0 random variable Y provided by this isomorphism, then $Y' \circ T'$ is the corresponding copy of $Y \circ T$.

The notion of immersion is unchanged: (\mathcal{F},T) and (\mathcal{G},T) being two factor filtrations in the same dynamical system, we simply say that (\mathcal{F},T) is immersed

in (\mathcal{G},T) if \mathcal{F} is immersed in \mathcal{G} . However the notion of immersibility takes into account the above definition of dynamical isomorphism.

Definition 3.3 (Dynamical immersibility of factor filtrations). Let (\mathscr{F},T) and (\mathcal{G}, S) be two factor filtrations, possibly defined on two different dynamical systems. We say that (\mathcal{F},T) is dynamically immersible in (\mathcal{G},S) if there exists a factor filtration (\mathscr{F}', S) immersed in (\mathscr{G}, S) , which is dynamically isomorphic to (\mathscr{F}, T) .

We can now adapt the notions of product type and standardness to factor filtrations.

Definition 3.4. The factor filtration (\mathcal{F}, T) is said to be dynamically of product type if there exists a family $(\mathcal{G}_n)_{n\leq 0}$ of independent factor sigma-algebras such that for each $n \leq 0$, $\mathscr{F}_n = \bigvee_{m \leq n} \mathscr{G}_m$.

Equivalently, (\mathcal{F},T) is of product type if \mathcal{F} can be generated by a process $X = (X_n)_{n \le 0}$ whose coordinates X_n are independent T-processes. Of course, if the factor filtration (\mathcal{F}, T) is of product type, then the filtration \mathcal{F} is itself of product type, but the converse is not true (see the example in Section 3.2).

Definition 3.5. The factor filtration (\mathscr{F},T) is said to be dynamically standard if it is dynamically immersible in some factor filtration dynamically of product type.

It is natural also to translate the notions of real-time coupling and I-cosiness to the dynamical context. The corresponding notions are formally the same as in the static case, except that we have to replace the isomorphism of filtrations by the dynamical isomorphism of factor filtrations:

Definition 3.6 (Dynamical real-time coupling). Let (\mathscr{F},T) be a factor filtration on a dynamical system (Ω, \mathbb{P}, T) . We call dynamical real-time coupling of (\mathscr{F}, T) a pair $((\mathscr{F}',S),(\mathscr{F}'',S))$ of factor filtrations, both defined on the same dynamical system (but possibly different from (Ω, \mathbb{P}, T)), such that

- $(\mathscr{F}', S) \sim (\mathscr{F}, T)$,
- $(\mathscr{F}'',S) \sim (\mathscr{F},T)$, \mathscr{F}' and \mathscr{F}'' are jointly immersed.

Definition 3.7 (Dynamical I-cosiness). Let (\mathscr{F}, T) be a factor filtration, and let Y be an \mathcal{F}_0 -measurable random variable Y taking values in some Polish metric space (E,d). Then Y is said to be dynamically I-cosy with respect to (\mathscr{F},T) if, for each real number $\delta > 0$, we can find a dynamical real-time coupling $((\mathscr{F}', S), (\mathscr{F}'', S))$ of (\mathcal{F},T) which is independent in the distant past, and such that the two copies Y' and Y'' of Y in \mathscr{F}' and \mathscr{F}'' respectively satisfy

(15)
$$d(Y', Y'') < \delta \text{ with probability } > 1 - \delta.$$

The factor filtration (\mathcal{F}, T) is said to be dynamically I-cosy if each \mathcal{F}_0 -measurable random variable Y is dynamically I-cosy with respect to (\mathcal{F}, T) .

We expect of course some relationship between dynamical I-cosiness and dynamical standardness. In the static case, showing that standardness implies I-cosiness is not very difficult, and in fact exactly the same arguments apply in the dynamical case. We provide them below.

Lemma 3.8. Let (\mathscr{F},T) be a factor filtration which is dynamically of product type. Then (\mathcal{F}, T) is dynamically I-cosy.

Proof. Let (Ω, \mathbb{P}, T) be the dynamical system where the factor filtration is defined, and let $X = (X_n)_{n \leq 0}$ be a process generating \mathscr{F} , where the coordinates X_n are independent T-processes: $X_n = (X_n(i))_{i \in \mathbb{Z}} = (X_n(0) \circ T^i)_{i \in \mathbb{Z}}$.

We have to check the dynamical I-cosiness with respect to (\mathscr{F},T) of a target random variable Y which is \mathscr{F}_0 -measurable. It is enough to consider the case where Y is measurable with respect to $\Sigma(X_{n_0+1},\ldots,X_0)$ for some $n_0 \leq -1$.

On the product dynamical system $(\Omega \times \Omega, \mathbb{P} \otimes \mathbb{P}, T \times T)$, we have two independent copies $X^{(1)}$ and $X^{(2)}$ of X, whose coordinates are independent $(T \times T)$ -processes. Let us now consider the two copies X' and X'' of X defined by $X' := X^{(1)}$, and

$$X_n'' := \begin{cases} X_n^{(2)} & \text{if } n \le n_0, \\ X_n^{(1)} & \text{if } n \ge n_0 + 1. \end{cases}$$

Define \mathscr{F}' (respectively \mathscr{F}'') as the filtration generated by X' (respectively X''). Then $((\mathscr{F}', T \times T), (\mathscr{F}'', T \times T))$ is an n_0 -independent dynamical coupling of (\mathscr{F}, T) . Moreover, since by construction we have $X'_n = X''_n$ for $n \geq n_0 + 1$, the corresponding copies of Y' and Y'' of Y satisfy Y' = Y''. This concludes the proof.

Lemma 3.9. Let (\mathscr{F},T) and (\mathscr{G},S) be two factor filtrations. Assume that (\mathscr{G},S) is dynamically I-cosy, and that (\mathscr{F},T) is dynamically immersible in (\mathscr{G},S) . Then (\mathscr{F},T) is dynamically I-cosy.

Proof. Without loss of generality, we can assume that (\mathcal{F}, T) is immersed in some dynamically I-cosy factor filtration (\mathcal{G},T) . let $X=(X_n)_{n\leq 0}$ be a process generating \mathscr{F} , where the coordinates X_n are T-processes. Let Y be an \mathscr{F}_0 -measurable random variable, taking values in the Polish metric space (E,d), and let $\delta > 0$. Since $\mathscr{F}_0 \subset \mathscr{G}_0$, and since (\mathscr{G},T) is dynamically I-cosy, there exists a dynamical real-time coupling $((\mathscr{G}',S),(\mathscr{G}'',S))$ of (\mathscr{G},T) , independent in the distant past, such that the corresponding copies Y' and Y'' of Y satisfy $d(Y',Y'') < \delta$ with probability at least $1 - \delta$. But the generating process X is \mathscr{G}_0 -measurable, so we can consider its copies X' and X'' in \mathscr{G}' and \mathscr{G}'' respectively. Let \mathscr{F}' (respectively \mathscr{F}'') be the filtration generated by X' (respectively X''). Since these copies are provided by a dynamical isomorphism, the coordinates of X' and X'' are S-processes, hence we get two dynamically isomorphic copies (\mathscr{F}',S) and (\mathscr{F}'',S) of the factor filtration (\mathscr{F},T) . Since \mathscr{G}' and \mathscr{G}'' are jointly immersed, and \mathscr{F}' (respectively \mathscr{F}'') is immersed in \mathscr{G}' (respectively \mathscr{G}''), \mathscr{F}' and \mathscr{F}'' are jointly immersed. Hence we get a dynamical real-time coupling $((\mathscr{F}',S),(\mathscr{F}'',S))$ of the factor filtration (\mathscr{F},T) . Moreover this coupling is independent in the distant past because this is the case for $((\mathscr{G}', S), (\mathscr{G}'', S))$. But Y' and Y'' are also the corresponding copies of Y in this dynamical real-time coupling.

From Lemma 3.8 and Lemma 3.9, we immediately derive the following theorem:

Theorem 3.10. If the factor filtration (\mathcal{F}, T) is dynamically standard, then it is dynamically I-cosy.

Whether the converse of the above theorem is true is still for us an open question (see a partial result in this direction in Section 3.4). However the fact that dynamical I-cosiness is necessary for dynamical standardness can already be used to establish that some factor filtrations are not dynamically standard, as in the following section.

3.2. Dynamical vs. static classification of filtrations: the example of $\mathscr{F}^{\tau^{-1}}$. We come back again to the filtration $\mathscr{F}^{\tau^{-1}}$ associated to the deterministic cellular automaton τ , and defined in Section 1.1.1. The probability measure $\mu =$ $\mathcal{U}_{\mathbb{A}}^{\otimes \mathbb{Z}}$ on $\mathbb{A}^{\mathbb{Z}}$ is invariant by the shift map σ , and each coordinate X_n of the process generating the filtration $\mathscr{F}^{\tau^{-1}}$ is itself a stationary σ -process $X_n = (X_n(i))_{i \in \mathbb{Z}}$ where $X_n(i) = X_n(0) \circ \sigma^i$. Thus, $(\mathscr{F}^{\tau^{-1}}, \sigma)$ is a factor filtration in the dynamical system $(\mathbb{A}^{\mathbb{Z}}, \mu, \sigma)$.

We recall that, if we look at the filtration $\mathscr{F}^{\tau^{-1}}$ from the static point of view, it is of product type (Theorem 2.5). However the following result shows that dynamical classification of factor filtrations may lead to different results than the static one.

Theorem 3.11. The factor filtration $(\mathscr{F}^{\tau^{-1}}, \sigma)$ is not dynamically standard.

Proof. The strategy consists in showing that the factor filtration $(\mathscr{F}^{\tau^{-1}}, \sigma)$ is not dynamically I-cosy. For this, we consider a real-time dynamical coupling of this factor filtration in a dynamical system (Ω, \mathbb{P}, T) , so that we have two copies X' = $(X'_n)_{n\leq 0}$ and $X''=(X''_n)_{n\leq 0}$ of the process (X_n) , where for each $n\leq 0$,

- $$\begin{split} \bullet \ \ X_n' &= \left(X_n'(i) \right)_{i \in \mathbb{Z}} = \tau^{|n|} X_0', \\ \bullet \ \ X_n'' &= \left(X_n''(i) \right)_{i \in \mathbb{Z}} = \tau^{|n|} X_0'', \end{split}$$

and for each $i \in \mathbb{Z}$,

- $\begin{array}{ll} \bullet & X_n'(i) = X_n'(0) \circ T^i, \\ \bullet & X_n''(i) = X_n''(0) \circ T^i. \end{array}$

For each $n \leq 0$, set $Z_n := X'_n - X''_n$. Then for each n, $Z_n = (Z_n(i))_{i \in \mathbb{Z}} = (Z_n(0) \circ T^i)_{i \in \mathbb{Z}}$ is a stationary T-process taking values in \mathbb{A} . And since τ is an endomorphism of the group $\mathbb{A}^{\mathbb{Z}}$, we also have $Z_n = \tau^{|n|} Z_0$ for each $n \leq 0$.

Assume that this coupling is n_0 -independent for some $n_0 \leq 0$, in other words X'_{n_0} and X''_{n_0} are independent. Then the probability distribution of Z_{n_0} is nothing but $\mu = \mathcal{U}_{\mathbb{A}}^{\otimes \mathbb{Z}}$. Therefore, the Kolmogorov-Sinaï entropy of this T-process is

$$h(Z_{n_0}, T) = \log |\mathbb{A}|.$$

But we have

$$Z_{n_0} = \tau^{|n_0|} Z_0,$$

so that the T-process Z_{n_0} is a factor of the T-process Z_0 . In particular, since the Kolmogorov-Sinaï entropy can not increase when we pass to a factor, and observing that Z_0 is a T process taking values in A

$$\log |\mathbb{A}| = h(Z_{n_0}, T) \le h(Z_0, T) \le \log |\mathbb{A}|.$$

However the only T-process taking values in A and whose entropy is $\log |A|$ is the uniform Bernoulli process. It follows that the probability distribution of Z_0 is necessarily also μ . Therefore,

$$\mathbb{P}(X_0'(0) = X_0''(0)) = \mathbb{P}(Z_0(0) = 0) = \frac{1}{|\mathbb{A}|},$$

which prevents the dynamical I-cosiness of the target $X_0(0)$.

3.2.1. An alternative proof for the case of an infinite group. In this section only we allow the non-trivial Abelian group (A, +) to be compact, not necessarily finite. The action of the deterministic cellular automaton τ on $\mathbb{A}^{\mathbb{Z}}$ can be defined by the same formula as in the finite case (1). We denote by $\mathcal{U}_{\mathbb{A}}$ the Haar measure on \mathbb{A} (which is the uniform measure in the case of a finite group). Still, $\mu = \mathcal{U}_{\mathbb{A}}^{\otimes \mathbb{Z}}$ is invariant by τ and by the shift map σ , and we can consider the filtration $\mathscr{F}^{\tau^{-1}}$ defined in Section 1.1.1, as well as the factor filtration $(\mathscr{F}^{\tau^{-1}}, \sigma)$ in this more general context. Like in the finite case, we can show by exactly the same arguments that $\mathscr{F}^{\tau^{-1}}$ is of product type even in the non-finite case. But the above proof of Theorem 3.11 makes an essential use of the fact that \mathbb{A} is a *finite* Abelian group. We propose below an alternative proof, which replaces the entropy argument by a coupling argument, and which is also valid in the infinite case.

We first need to recall some basic facts about joinings of stationary processes in ergodic theory.

Definition 3.12 (Joining). For i = 1, 2, let X_i be a T_i -process in a dynamical system $(\Omega_i, \mathbb{P}_i, T_i)$. We call dynamical coupling or joining of X_1 and X_2 the simultaneous realization in the same dynamical system $(\overline{\Omega}, \overline{\mathbb{P}}, \overline{T})$ of two \overline{T} -processes \overline{X}_1 and \overline{X}_2 such that $\mathcal{L}(\overline{X}_i) = \mathcal{L}(X_i)$, i = 1, 2.

This definition of joining extends in an obvious way to any finite or countable family of stationary processes.

Definition 3.13 (Disjointness). The stationary processes X_1 and X_2 are said to be disjoint if, for each joining $(\overline{X}_1, \overline{X}_2)$ of X_1 and X_2 , \overline{X}_1 and \overline{X}_2 are independent.

Disjointness was introduced by Furstenberg in 1967 in his famous paper [7], where he also provided one of the first example of disjointness:

Theorem 3.14. Let X_1 be a Bernoulli process (i.e. a stationary process with independent coordinates), and let X_2 be a stationary process with zero entropy. Then X_1 and X_2 are disjoint.

The following result is a direct application of the construction of a relatively independent joining over a common factor (see for example [4]):

Lemma 3.15. Let X_1 and Y_1 be two T_1 -processes in a dynamical system $(\Omega_1, \mathbb{P}_1, T_1)$, and let Let X_2 and Y_2 be two T_2 -processes in a second dynamical system $(\Omega_2, \mathbb{P}_2, T_2)$. Assume that $\mathcal{L}(Y_1) = \mathcal{L}(Y_2)$. then there exists a joining $(\overline{X}_1, \overline{Y}_1, \overline{X}_2, \overline{Y}_2)$ of X_1 , $Y_1, X_2, Y_2,$ such that

- $$\begin{split} \bullet \ \ & \mathcal{L}(\overline{X}_1,\overline{Y}_1) = \mathcal{L}(X_1,Y_1), \\ \bullet \ \ & \mathcal{L}(\overline{X}_2,\overline{Y}_2) = \mathcal{L}(X_2,Y_2), \\ \bullet \ \ & \overline{Y}_1 = \overline{Y}_2 \ a.s. \end{split}$$

The invariance of μ by τ tells us that, if a random variable X takes its values in $\mathbb{A}^{\mathbb{Z}}$ and follows the distribution μ , then the law of τX is also μ . The following lemma, which is the key ingredient in the alternative proof, can be viewed as the reciprocal of this fact in the stationary case.

Lemma 3.16. Let X be a random variable taking values in $\mathbb{A}^{\mathbb{Z}}$, whose law is σ invariant. If $\mathcal{L}(\tau X) = \mu$, then $\mathcal{L}(X) = \mu$.

Proof. Let ρ be a σ -invariant probability measure on $\mathbb{A}^{\mathbb{Z}}$, whose pushforward measure by τ is $\tau_*(\rho) = \mu$. In the dynamical system $(\mathbb{A}^{\mathbb{Z}}, \rho, \sigma)$, we consider the σ -process X_1 defined by the coordinates, and we set $Y_1 := \tau(X_1)$, so that Y_1 is a σ -process with law μ . We also consider a second dynamical system $(\mathbb{A}^{\mathbb{Z}}, \mu, \sigma)$, where we define the σ -process X_2 by the coordinates, and we set $Y_2 := \tau(X_2)$. We have $\mathscr{L}(X_2) = \mathscr{L}(Y_2) = \mu$. By Lemma 3.15 there exists a joining $(\overline{X}_1, \overline{Y}_1, \overline{X}_2, \overline{Y}_2)$ realized in a dynamical system $(\overline{\Omega},\overline{\mathbb{P}},\overline{T}),$ such that:

- $$\begin{split} \bullet \ & \mathcal{L}(\overline{X}_1) = \rho, \\ \bullet \ & \mathcal{L}(\overline{X}_2) = \mu, \\ \bullet \ & \tau(\overline{X}_1) = \overline{Y}_1 = \overline{Y}_2 = \tau(\overline{X}_2). \end{split}$$

Set $Z := \overline{X}_1 - \overline{X}_2$. We have $\tau(Z) = \tau(\overline{X}_1) - \tau(\overline{X}_2) = 0$, therefore for each $i \in \mathbb{Z}$,

$$Z(i) = Z(0) \circ \overline{T}^i = (-1)^i Z(0).$$

The process Z being 2-periodic, its Kolmogorov-Sinaï entropy vanishes:

$$h(Z, \overline{T}) = 0.$$

Moreover, \overline{X}_2 has independent coordinates since its law is μ . By Theorem 3.14, \overline{X}_2 is disjoint of Z, hence independent of Z. But we have $\overline{X}_1 = Z + \overline{X}_2$, and the law of \overline{X}_2 is the Haar measure μ on $\mathbb{A}^{\mathbb{Z}}$. It follows that the law ρ of \overline{X}_1 is also μ .

Note that the assumption of σ -invariance in Lemma 3.16 cannot be removed, because we could take a random variable Y of law μ , and define X as the only preimage of Y by τ whose coordinate X_0 satisfies $X_0 = 0_{\mathbb{A}}$. Then $\mathcal{L}(\tau X) =$ $\mathcal{L}(Y) = \mu$, but $\mathcal{L}(X) \neq \mu$ since A is not the trivial group.

We now have all the tools to modify the the end of the proof of Theorem 3.11, so that it can also be valid also in the infinite case.

Alternative proof of Theorem 3.11. We consider the same situation as in the first proof, but we just modify the final argument. We know that Z_{n_0} has law μ , and $\tau^{|n_0|}Z_0=Z_{n_0}$. All processes are stationary, so we can apply Lemma 3.16 $|n_0|$ times to prove recursively that each Z_n , $n_0 \le n \le 0$, has law μ . Then, for each $\delta > 0$ we

$$\mathbb{P}(d(X_0', X_0'') < \delta) = \mathcal{U}_{\mathbb{A}}(B_{\delta}),$$

where B_{δ} denotes the ball of center $0_{\mathbb{A}}$ and with radius δ . But, as $\delta \to 0$, $\mathcal{U}_{\mathbb{A}}(B_{\delta})$ converges to $\mathcal{U}_{\mathbb{A}}(\{0_{\mathbb{A}}\}) < 1$ since \mathbb{A} is not the trivial group. This shows that the target $X_0(0)$ is not dynamically I-cosy.

3.3. The factor filtration $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$. We come back now to the case of a finite Abelian group, and we wish to study the dynamical standardity of the factor filtration $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$, where $\mathscr{F}^{\tau_{\varepsilon}}$ is the filtration associated to the probabilistic cellular automaton τ_{ε} . This section is essentially devoted to the proof of the following result.

Theorem 3.17. There exists $0 < \varepsilon_0 < \frac{|\mathbb{A}|-1}{|\mathbb{A}|}$ such that, for each $\varepsilon_0 < \varepsilon \leq \frac{|\mathbb{A}|-1}{|\mathbb{A}|}$, $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$ is dynamically standard.

For this we will construct the filtration $\mathscr{F}^{\tau_{\varepsilon}}$ on a bigger space than $(\mathbb{A}^{\mathbb{Z}})^{\mathbb{Z}}$, namely we will consider the probability space $\Omega:=[0,1]^{\mathbb{Z}\times\mathbb{Z}}$ equipped with the product probability measure $\mathbb{P} := \lambda^{\otimes (\mathbb{Z} \times \mathbb{Z})}$ (λ denotes the Lebesgue measure on [0, 1] here).

On (Ω, \mathbb{P}) we define the measure preserving \mathbb{Z}^2 -action of shift maps: for $m, j \in \mathbb{Z}$, we define

$$\sigma_{m,j}: \omega = (\omega_{n,i})_{n \in \mathbb{Z}, i \in \mathbb{Z}} \mapsto \sigma_{m,j}\omega := (\omega_{n+m,i+j})_{n \in \mathbb{Z}, i \in \mathbb{Z}},$$

and we simply denote by σ the usual left-shift: $\sigma:=\sigma_{0,1}$. For each $n\in\mathbb{Z},\ i\in\mathbb{Z}$, we set $U_n(i)(\omega):=\omega_{n,i}$, so that $\left(U_n(i)\right)_{n\in\mathbb{Z},i\in\mathbb{Z}}$ is a family of independent variables, uniformly distributed in [0,1]. For each $n\in\mathbb{Z}$, we denote by U_n the σ -process $U_n:=\left(U_n(i)\right)_{i\in\mathbb{Z}}$. Let $\mathscr{G}=(\mathscr{G}_n)_{n\leq 0}$ be the filtration generated by $(U_n)_{n\leq 0}$: then (\mathscr{G},σ) is a factor filtration, and as the random variables $U_n,\ n\in\mathbb{Z}$, are independent, (\mathscr{G},σ) is dynamically of product type. We want now to construct the factor filtration $(\mathscr{F}^{\tau_\varepsilon},\sigma)$ in this dynamical system $(\Omega,\mathbb{P},\sigma)$ in such a way that $\mathscr{F}^{\tau_\varepsilon}$ be immersed in \mathscr{G} . For this, we will construct a process $X=(X_n)_{n\in\mathbb{Z}}$ taking values in $\mathbb{A}^\mathbb{Z}$ such that for each $n\in\mathbb{Z}$:

- (a) $X_n = (X_n(i))_{i \in \mathbb{Z}} = (X_n(0) \circ \sigma^i)_{i \in \mathbb{Z}}$ is a σ -process,
- (b) $\mathcal{L}(X_n) = \mu$,
- (c) for each $x \in \mathbb{A}^{\mathbb{Z}}$, $\mathcal{L}(X_{n+1}|X_n=x)=\tau_{\varepsilon}(x,\cdot)$,
- (d) X_n is \mathcal{G}_n -measurable,
- (e) X_{n+1} is measurable with respect to $\Sigma(X_n, U_{n+1})$.

Conditions (a), (b) and (c) ensure that $(X_n)_{n\leq 0}$ generates the correct factor filtration $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$ that we want to study. Condition (d) shows that $\mathscr{F}^{\tau_{\varepsilon}}$ is a sub-filtration of \mathscr{G} , and Condition (e) implies that $\mathscr{F}^{\tau_{\varepsilon}}$ is immersed in \mathscr{G} .

Condition (d) is the most difficult to obtain. Our strategy will be strongly inspired by clever techniques introduced by Marcovici [13] to prove ergodicity in the Markov sense for some probabilistic cellular automata. These techniques are based on two ingredients: the introduction of an auxiliary probabilistic cellular automaton (the *envelope PCA*), and a coupling with some percolation process.




FIGURE 4. The oriented site percolation model

3.3.1. Oriented site percolation. The percolation model that we will use is built on an infinite oriented graph whose vertices (sites) are the elements of \mathbb{Z}^2 , and the oriented edges connect each site (n,i) to the sites (n+1,i) and (n+1,i-1). We fix $p \in [0,1]$ (this parameter will be specified later), and we use the random variables $U_n(i)$ to define a random configuration of the graph: the site (n,i) is declared to be open if $U_n(i) \in [0,p[$, and closed otherwise. In this random configuration, we say that a site (n,i) leads to a site (m,j) if $n \leq m$ and there exists in the oriented graph a path starting from (n,i), ending in (m,j) and passing only through open sites, which in particular requires that both sites (n,i) and (m,j) be open (see Figure 4).

For $n \geq 0$, we denote by O_n the event "there exists $i \in \mathbb{Z}$ such that (0,0) leads to (n,i)", and similarly, when $n \leq 0$, O_n stands for the events "there exists $i \in \mathbb{Z}$ such that (n,i) leads to (0,0)". We also set

$$O_{\infty} := \bigcap_{n \ge 0} O_n$$
, and $O_{-\infty} := \bigcap_{n \le 0} O_n$.

We note that $\mathbb{P}(O_n) = \mathbb{P}(O_{-n})$ since exchanging each random variable $U_n(i)$ with $U_{-n}(-i)$ does not affet the law of the process, but exchanges O_n and O_{-n} . It follows that $\mathbb{P}(O_{\infty}) = \mathbb{P}(O_{-\infty})$.

The essential question in percolation theory asks whether the probability of O_{∞} is positive or not. In the model presented here, this question has been addressed by Liggett [12], who proved the following:

Theorem 3.18 (Liggett). There exists a critical value $p_c \in [\frac{2}{3}, \frac{3}{4}]$ such that

- $p < p_c \Longrightarrow \mathbb{P}(O_\infty) = 0$, $p > p_c \Longrightarrow \mathbb{P}(O_\infty) > 0$.

Corollary 3.19. If $0 \le p < p_c$, we can almost surely define the random integer $N_0 \leq 0$, measurable with respect to $\Sigma(U_n, n \leq 0)$, as the largest integer $n_0 \leq 0$ such that O_{n_0} is not satisfied.

3.3.2. Envelope automaton. The envelope automaton associated to τ_{ε} is an auxiliary probabilistic cellular automaton acting on configurations built on a larger alphabet: $\mathbb{A}_{\text{env}} := \mathbb{A} \cup \{?\}$. We associate to each finite word $w \in (\mathbb{A}_{\text{env}})^*$ the set \overline{w} of all words in \mathbb{A}^* obtained from w by replacing each question mark with any symbol from A. For example, if $A = \{0, 1\}$ and w = ?1?, we have $\overline{w} = \{010, 011, 110, 111\}$.

To define the envelope automaton we first have to introduce the local transition rules of τ_{ε} : if (X_n) is a Markov chain evolving according the Markov kernel τ_{ε} , we define for $a, b, c \in \mathbb{A}$

$$f_{\tau_{\varepsilon}}(a \mid bc) := \mathbb{P}(X_{n+1}(i) = a \mid X_n(i) = b, X_n(i+1) = c)$$

$$= \begin{cases} 1 - \varepsilon & \text{if } a = b + c \\ \frac{\varepsilon}{|\mathbb{A}| - 1} & \text{otherwise.} \end{cases}$$

Now we define the local transition rules of the envelope PCA: if w is a word of length 2 over the alphabet \mathbb{A}_{env} , and $a \in \mathbb{A}$, we set

$$f_{\tau_{\varepsilon}}^{\mathrm{env}}(a \mid w) := \min_{bc \in \overline{w}} f_{\tau_{\varepsilon}}(a \mid bc),$$

and

$$f^{\mathrm{env}}_{\tau_{\varepsilon}}(? \,|\, w) := 1 - \sum_{a \in \mathbb{A}} \min_{bc \in \overline{w}} f_{\tau_{\varepsilon}}(a \,|\, bc).$$

Note that, if w contains at least one?, for each $a \in \mathbb{A}$ there exists $bc \in \overline{w}$ such that $b+c \neq a$. Recalling the assumption (2) we made on ε and the definition (3) of $\tilde{\varepsilon}$, we thus get the following rules: for each $a, b, c \in \mathbb{A}_{env}$,

$$f_{\tau_{\varepsilon}}^{\text{env}}(a \mid bc) = \begin{cases} f_{\tau_{\varepsilon}}(a \mid bc) & \text{if } a, b, c \in \mathbb{A}, \\ 0 & \text{if } a = ? \text{ and } b, c \in \mathbb{A}, \\ \frac{\varepsilon}{\mid \mathbb{A} \mid -1} & \text{if } a \in \mathbb{A} \text{ and } ? \in \{b, c\}, \\ 1 - \tilde{\varepsilon} & \text{if } a = ? \text{ and } ? \in \{b, c\}. \end{cases}$$

In particular, the symbol ? cannot appear if the two preceding symbols are in \mathbb{A} , and in this case the local transition rules of the envelope PCA coincides with those of τ_{ε} .

For each $b,c\in\mathbb{A}_{\mathrm{env}},\,f_{\tau_{\varepsilon}}^{\mathrm{env}}(\cdot\,|\,bc)$ can be viewed as a probability measure on $\mathbb{A}_{\mathrm{env}}$. Then the envelope PCA $\tau_{\varepsilon}^{\mathrm{env}}$ is defined as the Markov kernel on $\mathbb{A}_{\mathrm{env}}^{\mathbb{Z}}$ given by

$$\forall x \in \mathbb{A}_{\mathrm{env}}^{\mathbb{Z}}, \ \tau_{\varepsilon}^{\mathrm{env}}(\cdot \,|\, x) := \bigotimes_{i \in \mathbb{Z}} f_{\tau_{\varepsilon}}^{\mathrm{env}}\big(\cdot \,|\, x(i)x(i+1)\big).$$

3.3.3. Simultaneous implementation of the two PCA's. We are going to realize a coupling of τ_{ε} and $\tau_{\varepsilon}^{\text{env}}$ on our space Ω , using the independent uniform random variables $(U_n(i))_{n,i\in\mathbb{Z}}$. This will be done by means of two updating functions

$$\varphi_{\varepsilon}: \mathbb{A} \times \mathbb{A} \times [0,1] \to \mathbb{A}$$

and

$$\varphi_{\varepsilon}^{\mathrm{env}}: \mathbb{A}_{\mathrm{env}} \times \mathbb{A}_{\mathrm{env}} \times [0, 1] \to \mathbb{A}_{\mathrm{env}},$$

adapted respectively to the local transition rules of τ_{ε} and $\tau_{\varepsilon}^{\text{env}}$. Here is how we define these updating functions (see Figure 5): we split the interval [0,1] into $|\mathbb{A}|+1$ disjointsub-intervals, labelled by symbols from \mathbb{A}_{env} . The first one is

$$I_? := \left[0, 1 - \frac{\varepsilon |\mathbb{A}|}{|\mathbb{A}| - 1}\right] = \left[0, 1 - \tilde{\varepsilon}\right],$$

and the complement of $I_{?}$ is itself split into $|\mathbb{A}|$ subintervals of equal length $\frac{\varepsilon}{|\mathbb{A}|-1}$, denoted by I_a , $a \in \mathbb{A}$. Now for each $b, c \in \mathbb{A}$, $u \in [0, 1]$, we set

$$\varphi_{\varepsilon}(b,c,u) := \begin{cases} b+c & \text{if } u \in I_?, \\ a & \text{if } u \in I_a, \ a \in \mathbb{A}. \end{cases}$$

In this way, for a random variable U uniformly distributed in [0,1], we have for each $b,c\in\mathbb{A}$

$$\mathscr{L}(\varphi_{\varepsilon}(b,c,U)) = f_{\tau_{\varepsilon}}(\cdot \mid bc).$$

To define $\varphi_{\varepsilon}^{\text{env}}$, we use the same partition of [0,1] and we set for $b,c\in\mathbb{A}_{\text{env}}$ and $u\in[0,1]$

$$\varphi_{\varepsilon}^{\text{env}}(b, c, u) := \begin{cases} b + c & \text{if } b, c \in \mathbb{A} \text{ and } u \in I_{?}, \\ ? & \text{if } b \text{ or } c \text{ is } ? \text{ and } u \in I_{?}, \\ a & \text{if } u \in I_{a}, \ a \in \mathbb{A}. \end{cases}$$

Likewise, we see that for a random variable U uniformly distributed in [0,1], we have for each $b,c\in\mathbb{A}_{\text{env}}$

$$\mathscr{L}(\varphi_{\varepsilon}^{\mathrm{env}}(b, c, U)) = f_{\tau_{\varepsilon}}^{\mathrm{env}}(\cdot \mid bc).$$

Let $n_0 \leq 0$ be a fixed integer and $x \in \mathbb{A}^{\mathbb{Z}}$ be an arbitrary configuration. We realize simultaneously two Markov chains $(X_n^x)_{n\geq n_0}$ and $X^{\mathrm{env}} = (X_n^{\mathrm{env}})_{n\geq n_0}$ evolving respectively according to τ_{ε} and $\tau_{\varepsilon}^{\mathrm{env}}$: first we initialize by setting $X_{n_0}^x := x$, and $X_{n_0}^{\mathrm{env}} := \dots$??????... (the configuration with only symbols?). Later times of the processes are computed recursively through the formula

(16)
$$X_{n+1}^{x}(i) := \varphi_{\varepsilon}(X_{n}^{x}(i), X_{n}^{x}(i+1), U_{n+1}(i)),$$

and

(17)
$$X_{n+1}^{\text{env}}(i) := \varphi_{\varepsilon}^{\text{env}} \big(X_n^{\text{env}}(i), X_n^{\text{env}}(i+1), U_{n+1}(i) \big).$$

3.3.4. Coupling with the percolation model. We come back now to the oriented site percolation model we have defined in Section 3.3.1 from the same random variables $(U_n(i))_{n,i\in\mathbb{Z}}$. We just set the parameter p to be equal to $1-\tilde{\varepsilon}$. In this way, the site (n,i) is open if and only if $U_n(i) \in I_r$ (see Figure 5)).

The way we constructed the three processes together yields interesting properties which we describe in the two following lemmas.

Lemma 3.20. For each $n \ge n_0 + 1$, $i \in \mathbb{Z}$, we have $X_n^{\text{env}}(i) = ?$ if and only if in the percolation model there exists $j \in \mathbb{Z}$ such that $(n_0 + 1, j)$ leads to (n, i).

Proof. We prove the lemma by induction on $n \ge n_0 + 1$. Since $X_{n_0}^{\text{env}}(i) = ?$, we have $X_{n_0+1}^{\text{env}}(i) = ?$ if and only if $U_{n_0+1}(i) \in I_?$, that is if and only if the site (n_0+1,i) is open, which proves the result for $n = n_0 + 1$. Now assume that the result is true up

to level $n \ge n_0 + 1$. By construction, $X_{n+1}^{\text{env}}(i) = ?$ if and only if the two following conditions hold

- $X_n^{\text{env}}(i) = ?$ or $X_n^{\text{env}}(i+1) = ?$, which by assumption means that there exists $j \in \mathbb{Z}$ such that $(n_0 + 1, j)$ leads to (n, i) or to (n, I + 1);
- $U_{n+1}(i) \in I_{?}$, which means that the site (n+1,i) is open.

Therefore $X_{n+1}^{\text{env}}(i) = ?$ if and only if there exists $j \in \mathbb{Z}$ such that $(n_0 + 1, j)$ leads to (n + 1, i), which ends the proof.

The next lemma is a key result: it shows that wherever the process X^{env} displays symbols different from ?, the process X^x displays the same symbols as X^{env} , regardless of the initial configuration x.

Lemma 3.21. For each
$$n \geq n_0$$
, $i \in \mathbb{Z}$, if $X_n^{\text{env}}(i) \neq ?$ then $X_n^x(i) = X_n^{\text{env}}(i)$.

Proof. Again we prove the result by induction on $n \ge n_0$. For $n = n_0$ this is obvious since $X_{n_0}^{\text{env}}(i) = ?$ for all $i \in \mathbb{Z}$. Now assume that the property holds up to some level $n \ge n_0$, and let us consider some site (n+1,i). There are two cases.

- First case: $X_n^{\text{env}}(i) = ?$ or $X_n^{\text{env}}(i+1) = ?$. Then the only way to have $X_n^{\text{env}}(i) \neq ?$ is that there exists $a \in \mathbb{A}$ such that $U_{n+1}(i) \in I_a$. By construction of the updating functions, this implies that $X_{n+1}^x(i) = a = X_{n+1}^{\text{env}}(i)$.
- Second case: $X_n^{\text{env}}(i) \in \mathbb{A}$ and $X_n^{\text{env}}(i+1) \in \mathbb{A}$. Then by assumption this implies that we have both $X_n^x(i) = X_n^{\text{env}}(i)$ et $X_n^x(i+1) = X_n^{\text{env}}(i+1)$. By construction of the updating functions, we deduce on the one hand that $X_{n+1}^{\text{env}}(i) \in \mathbb{A}$, and on the other hand that $X_{n+1}^x(i) = X_{n+1}^{\text{env}}(i)$.

In both cases the property also holds for the site (n+1,i).

3.3.5. Construction of the process (X_n) generating $\mathscr{F}^{\tau_{\varepsilon}}$. We are now going to let n_0 vary in the preceding construction, and to make explicit the dependence in n_0 we now denote $(X_n^{n_0,x})_{n\geq n_0}$ and $(X_n^{n_0,\text{env}})_{n\geq n_0}$ the processes respectively initialized at the configuration x and at the configuration ...????..., and defined inductively by (16) and (17).

Since the initial configuration of the envelope processes is σ -invariant, the action of the shifts $\sigma_{n,i}$ on the envelope processes yields the following formula, valid for all $n_0 \leq n$, $i \in \mathbb{Z}$:

(18)
$$X_n^{n_0, \text{env}}(i) = X_0^{n_0 - n, \text{env}}(0) \circ \sigma_{n, i}.$$

By a similar argument to the proof of Lemma (3.21), we get the following relations between all those processes.

Lemma 3.22. For each $n \geq n_0$, $i \in \mathbb{Z}$, if $X_n^{n_0,\text{env}}(i) \neq ?$, then for all $n_1 \leq n_0$ we have $X_n^{n_1,\text{env}}(i) = X_n^{n_0,\text{env}}(i)$.

The next proposition will be used to define the process $(X_n)_{n\in\mathbb{Z}}$, evolving according to τ_{ε} , under the assumption that ε be not too close to 0. We recall p_c stands for the critical value for the oriented site percolation process, defined in Theorem 3.18.

Proposition 3.23. Assume that

$$(19) (1-p_c)\frac{|\mathbb{A}|-1}{|\mathbb{A}|} < \varepsilon \le \frac{|\mathbb{A}|-1}{|\mathbb{A}|}.$$

Then, with probability 1, for all $n, i \in \mathbb{Z}$, there exists $N_0(n, i) \leq n$, taking values in \mathbb{Z} , and satisfying the following properties:

- $N_0(n,i)$ is measurable with respect to $\mathscr{G}_n = \Sigma(U_m(j): m \leq n, j \in \mathbb{Z})$.
- If $n_1 \le n_0 \le N_0(n,i)$, then $X_n^{n_0,\text{env}}(i) \ne ?$ and $X_n^{n_1,\text{env}}(i) = X_n^{n_0,\text{env}}(i)$.
- For each $n, i \in \mathbb{Z}$, $N_0(n, i) = N_0(0, 0) \circ \sigma_{n, i}$.

Proof. Recall that the right-hand-side inequality, $\varepsilon \leq \frac{|\mathbb{A}|-1}{|\mathbb{A}|}$, is just the the reformulation of condition (2). The left-hand-side inequality, $(1-p_c)\frac{|\mathbb{A}|-1}{|\mathbb{A}|} < \varepsilon$ is equivalent to $p < p_c$, where $p = 1 - \tilde{\varepsilon} = 1 - \frac{\varepsilon |\mathbb{A}|}{|\mathbb{A}|-1}$ is the parameter of the percolation process constructed in the coupling.

Consider first the case (n,i)=(0,0). For $p < p_c$, Corollary 3.19 ensures the almost sure existence of $N_0 = N_0(0,0) \le 0$, \mathscr{G}_0 -mesurable, which is the greatest integer $n_0 \le 0$ such that O_{n_0} is not satisfied, *i.e.* there is no $j \in \mathbb{Z}$ with (n_0,j) leading to (0,0). Then Lemma 3.20 shows that for each $n_0 \le N_0(0,0)$, $X_0^{n_0,\text{env}}(0) \ne 2$, and Lemma 3.22 gives

$$n_1 \le n_0 \le N_0(0,0) \Longrightarrow X_0^{n_1,\text{env}}(0) = X_0^{n_0,\text{env}}(0).$$

Then we can generalize this result to any site $(n,i) \in \mathbb{Z} \times \mathbb{Z}$, setting $N_0(n,i) := N_0 \circ \sigma_{n,i}$. Note that $N_0(n,i)$ is the greatest integer $n_0 \leq n$ such that there is no $j \in \mathbb{Z}$ with (n_0,j) leading to (n,i).

We assume now that ε satisfies (19), and we explain how to construct the process (X_n) satisfying the conditions (a), (b), (c), (d) and (e) (see page 20). With the above proposition, we can almost surely define, for each $n, i \in \mathbb{Z}$,

(20)
$$X_n(i) := X_n^{N_0(n,i),\text{env}}(i) = \lim_{n_0 \to -\infty} X_n^{n_0,\text{env}}(i).$$

For each $n \leq n_0 \in \mathbb{Z}$, $X_n^{n_0,\text{env}}$ is measurable with respect to $\mathscr{G}_n = \Sigma (U_m(j))_{m \leq n, j \in \mathbb{Z}}$, so the same holds for X_n and we have condition (d).

Considering an integer $n_0 \leq \min\{N_0(n,i), N_0(n,i+1), N_0(n+1,i)\}$, we have simultaneously: $X_n(i) = X_n^{n_0,\text{env}}(i), \ X_n(i+1) = X_n^{n_0,\text{env}}(i+1)$ and $X_{n+1}(i) = X_{n+1}^{n_0,\text{env}}(i)$. As the process $(X_n^{n_0,\text{env}})$ satisfies the induction relation (17) at (n+1,i), it is therefore the same for (X_n) . This proves that the process $(X_n)_{n\in\mathbb{Z}}$ actually evolves according to to the ACP τ_{ε} , and we have conditions (c) and (e). Moreover, from (18) we get for each $n,i\in\mathbb{Z}$

$$X_n(i) = X_0(0) \circ \sigma_{n,i}$$
.

This gives on the one side that each row X_n is a σ -process, so we have condition (a), and on the other side we also get $X_n = X_0 \circ \sigma_{n,0}$. The rows X_n therefore all follow the same law, which has to be μ by Corollary 2.16, and we have condition (b). This concludes the proof of Theorem 3.17.

3.3.6. Questions about the factor filtration $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$. When ε satisfies (19), we prove the dynamical standardity of $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$ by immersing it into a factor filtration (\mathscr{G}, σ) dynamically of product type. The way we construct \mathscr{G} , it is clear that it carries more information than $\mathscr{F}^{\tau_{\varepsilon}}$, so that $\mathscr{F}^{\tau_{\varepsilon}}$ is a strict subfiltration of \mathscr{G} . Thus we may ask whether, in this case, $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$ is itself a factor filtration dynamically of product type.

Another natural question is of course whether the dynamical standardity of $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$ persists as ε gets close to 0, which prevents the percolation argument to apply. One could already ask whether, for ε close to 0, the criterion of dynamical I-cosiness is satisfied for the factor filtration $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$. We do not have the answer

to this question, but we provide below a somewhat naive argument suggesting that $(\mathcal{F}^{\tau_{\varepsilon}}, \sigma)$ might be not dynamically I-cosy when ε is close enough to 0.

We consider the case where the group \mathbb{A} is $\mathbb{Z}/2\mathbb{Z}$. In an attempt to establish dynamical I-cosiness, we try to realize a real-time dynamical coupling of $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$, independent in the distant past, and for which the two copies X' and X'' of the process $X = (X_n)$ satisfy $X_0'(0) = X_0''(0)$ with probability close to 1. We want to construct this coupling in a dynamical system (Ω, \mathbb{P}, T) , in which for some $n_0 < 0$ we already have two independent copies $(X_n')_{n \le n_0}$ and $(X_n'')_{n \le n_0}$ of $(X_n)_{n \le n_0}$ (of course, each X_n' and each X_n'' is supposed to be a T-process of law μ). We assume that we also have an independent family $(U_n)_{n \ge n_0+1} = (U_n(i): i \in \mathbb{Z})_{n \ge n_0+1}$ of T-processes, each U_n being of law $\lambda^{\otimes \mathbb{Z}}$ (λ is the Lebesgue measure on [0,1]), and the U_n 's being independent. We want to use this family to construct error processes $(\xi_n') n \ge n_0 + 1$ and $(\xi_n'') n \ge n_0 + 1$, and then complete the processes X' and X'' inductively via the usual relations

$$X'_n = \tau X'_{n-1} + \xi'_n$$
 and $X''_n = \tau X''_{n-1} + \xi''_n$ $(n \ge n_0 + 1)$.

As in Section 2.4, we still want to define the error processes in the form $\xi'_n(i) = g'_{n,i}(U_n(i))$ and $\xi''_n(i) = g''_{n,i}(U_n(i))$, where $g'_{n,i}$ and $g''_{n,i}$ are random updating functions, but we point out the essential difference with the construction in Section 2.4: we now want the law of the coupling to be invariant with respect to the left shift of coordinates. This means that these updating function are still allowed to depend on the realizations of the processes up to time n-1, but in an equivariant way. In other words, they can be chosen according to what we see around the site (n,i), but the rule for the choice should be independent of i.

We also introduce the auxiliary process Z := X' - X'', which satisfies the same relation (10) for $n \ge n_0 + 1$. To get dynamical I-cosiness, we have to realize the coupling in such a way that

$$\mathbb{P}(Z_0(i) = 0) \xrightarrow[n_0 \to -\infty]{} 1$$

(note that the probability on the left-hand side does not depend on i).

Here is a natural idea to get what we are aiming at: we wish to encourage as much as possible the appearance of 0's in the Z process. For this, let us observe that we have for each $n, i \in \mathbb{Z}$

(21)
$$0 \leq \mathbb{P}(Z_n(i) \neq \tau Z_{n-1}(i)) = \mathbb{P}(\xi'_n(i) \neq \xi''_n(i))$$
$$\leq \mathbb{P}(\xi'_n(i) \neq 0 \text{ or } \xi''_n(i) \neq 0)$$
$$\leq \mathbb{P}(\xi'_n(i) \neq 0) + \mathbb{P}(\xi''_n(i) \neq 0)$$
$$< 2\varepsilon.$$

Moreover, we have the possibility to make the inequality on the left-hand side an equality, by deciding to take $g'_{n,i} = g''_{n,i}$ (we call it $Option\ 0$). On the other hand, we can also choose to turn the right-hand side inequalities into equalities, by choosing $g'_{n,i}$ and $g''_{n,i}$ in such a way that the subsets $\{u \in [0,1]: g'_{n,i}(u)=1\}$ and $\{u \in [0,1]: g''_{n,i}(u)=1\}$ are disjoint (we call it $Option\ 1$). So a natural dynamical coupling is obtained by the following strategy: knowing the processes up to time n-1, we compute $\tau Z_{n-1}(i)$. If $\tau Z_{n-1}(i)=0$ we decide to keep this 0, by choosing Option 0. If $\tau Z_{n-1}(i)=1$, we maximize the probability that $Z_n(i)$ will still be 0 by choosing Option 1.

Applying systematically this strategy, we are left with a process $(Z_n)_{n\geq n_0}$ taking values in $\mathbb{Z}/2\mathbb{Z}$, which evolves according to the following PCA rule: for each n, i, if $\tau Z_{n-1}(i) = 0$ then $Z_n(i) = 0$, otherwise $Z_n(i) = 0$ with probability 2ε . Observe that the initial configuration Z_{n_0} has law $\mathcal{U}_{\mathbb{Z}/2\mathbb{Z}}^{\otimes \mathbb{Z}}$, so that the initial density of 1's is 1/2. The question now is whether those 1's can survive over the long term?

It turns out that this type of evolution falls into the domain of a family of PCA's studied by Bramson and Neuhauser [1], who have proved that if ε is small enough, then symbols 1 survive. More precisely, we can state the following consequence of their result:

Theorem 3.24 (Bramson-Neuhauser). In the coupling described above, for $\varepsilon > 0$ small enough, there exists $\rho = \rho(\varepsilon) > 0$ such that

$$\liminf_{n_0 \to -\infty} \mathbb{P}(Z_0(0) = 1) \ge \rho.$$

This shows that this attempt to get dynamical I-cosiness for $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$ fails if ε is small.

3.4. A partial converse to Theorem 3.10. The question whether dynamical I-cosiness of a factor filtration implies its dynamical standardity (as in the static case) is so far open. However the construction given in Section 3.3 (for ε not too close to 0) provides an example where we are able to derive dynamical standardity from a particular form of dynamical I-cosiness. We want now to formalize this kind of situation, which can be viewed as the dynamic counterpart of the so-called Rosenblatt's self-joining criterion in [11].

In a dynamical system (Ω, \mathbb{P}, T) , consider a factor filtration (\mathscr{F}, T) generated by a family $X = (X_n)_{n < 0}$ of T-processes, each $X_n(i)$ taking its values in a fixed finite set A. We also assume the existence of a factor filtration (\mathcal{G}, T) , dynamically of product type, and generated by a family of independent T-processes $(U_n)_{n\leq 0}$, satisfying the following:

- for each $n \leq 0$, U_n is independent of $\mathscr{F}_{n-1} \vee \mathscr{G}_{n-1}$,
- $\mathscr{F}_n \subset \mathscr{F}_{n-1} \vee \Sigma(U_n)$.

In particular there exists a measurable map ϕ_n such that

$$X_n = \phi_n(U_n, X_{n-1}, X_{n-2}, \ldots).$$

We can also assume without loss of generality that there exists in (Ω, \mathbb{P}, T) a copy X' of X, whose coordinates X'_n are also T-processes, and which is independent of $\mathscr{G}_0 \vee \mathscr{F}_0$ (if not, we place ourselves on the product $(\Omega \times \Omega, \mathbb{P} \otimes \mathbb{P}, T \times T)$ as in the proof of Lemma 3.8). Now we build a family of dynamical real-time couplings of (\mathscr{F},T) in the following way: for a fixed $n_0 \leq 0$, define $\bar{X}^{n_0} = (\bar{X}_n^{n_0})_{n \leq 0}$ by

- $\bar{X}_n^{n_0} = X_n'$ for $n \le n_0$, then, inductively for $n_0 + 1 \le n \le 0$: $\bar{X}_n^{n_0} := \phi_n(U_n, \bar{X}_{n-1}^{n_0}, \bar{X}_{n-2}^{n_0}, \ldots)$.

(The important point here is that, for $n \geq n_0 + 1$, the same random variable U_n is involved in the inductive relations giving X_n and $\bar{X}_n^{n_0}$.) Then the filtration \mathscr{F}^{n_0} generated by \bar{X}^{n_0} is dynamically isomorphic to \mathscr{F} , and the pair $((\mathscr{F},T),(\bar{\mathscr{F}}^{n_0},T)$ is a dynamical real-time coupling of (\mathcal{F}, T) , which is n_0 independent.

Definition 3.25 (Simple dynamical I-cosiness). If, in the above construction, we have for each integer $m \leq 0$

(22)
$$\mathbb{P}\left(\bar{X}_m^{n_0}(0) = X_m(0)\right) \xrightarrow[n_0 \to -\infty]{} 1,$$

then we say that the factor filtration (\mathcal{F}, T) is simply dynamically I-cosy.

Clearly, simple dynamical I-cosiness implies dynamical I-cosiness. Observe also that, when ε satisfies (19), the results of Section 3.3 prove that the factor filtration $(\mathscr{F}^{\tau_{\varepsilon}}, \sigma)$ is simply dynamically I-cosy.

The following theorem generalizes the conclusion of Section 3.3.

Theorem 3.26. If the factor filtration (\mathcal{F}, T) is simply dynamically I-cosy, then it is dynamically standard.

Proof. We fix some interger $m \leq 0$. For each $n_0 \leq m-1$, we denote by $U_{n_0+1}^m$ the collection of T-processes U_{n_0+1}, \ldots, U_m . We have

$$\mathbb{P}\Big(\bar{X}_{m}^{n_{0}}(0) = X_{m}(0)\Big) = \sum_{a \in \mathbb{A}} \mathbb{P}\Big(\bar{X}_{m}^{n_{0}}(0) = X_{m}(0) = a\Big)$$
$$= \sum_{a \in \mathbb{A}} \mathbb{E}_{\mathbb{P}}\left[\mathbb{P}\Big(\bar{X}_{m}^{n_{0}}(0) = X_{m}(0) = a \mid U_{n_{0}+1}^{m}\Big)\right].$$

But $\bar{X}_m^{n_0}(0)$ and $X_m(0)$ are independent conditionally to $U_{n_0+1}^m$: indeed, once we know $U_{n_0+1}^m$, $\bar{X}_m^{n_0}(0)$ only depends on \bar{X}_{n_0} while $X_m(0)$ only depends on X_{n_0} . We thus get

$$\mathbb{P}\Big(\bar{X}_{m}^{n_{0}}(0) = X_{m}(0)\Big) = \sum_{a \in \mathbb{A}} \mathbb{E}_{\mathbb{P}} \left[\mathbb{P}\Big(\bar{X}_{m}^{n_{0}}(0) = a \mid U_{n_{0}+1}^{m}\Big) \mathbb{P}\Big(X_{m}(0) = a \mid U_{n_{0}+1}^{m}\Big) \right] \\
= \sum_{a \in \mathbb{A}} \mathbb{E}_{\mathbb{P}} \left[\mathbb{P}\Big(X_{m}(0) = a \mid U_{n_{0}+1}^{m}\Big)^{2} \right] \\
= \mathbb{E}_{\mathbb{P}} \left[\sum_{a \in \mathbb{A}} \mathbb{P}\Big(X_{m}(0) = a \mid U_{n_{0}+1}^{m}\Big)^{2} \right].$$

Let M_{n_0} be the random variable, measurable with respect to $\Sigma(U_{n_0+1}^m)$, and defined by

$$M_{n_0} := \arg \max_{a \in \mathbb{A}} \mathbb{P}\Big(X_m(0) = a \,|\, U_{n_0+1}^m\Big).$$

(In case the maximum is reached for several symbols in \mathbb{A} , we take the first of them with respect to some fixed total order on \mathbb{A} .) We get

$$\mathbb{P}\Big(\bar{X}_{m}^{n_{0}}(0) = X_{m}(0)\Big) \leq \mathbb{E}_{\mathbb{P}}\left[\sum_{a \in \mathbb{A}} \mathbb{P}\Big(X_{m}(0) = M_{n_{0}} \mid U_{n_{0}+1}^{m}\Big) \mathbb{P}\Big(X_{m}(0) = a \mid U_{n_{0}+1}^{m}\Big)\right] \\
= \mathbb{E}_{\mathbb{P}}\left[\mathbb{P}\Big(X_{m}(0) = M_{n_{0}} \mid U_{n_{0}+1}^{m}\Big) \underbrace{\sum_{a \in \mathbb{A}} \mathbb{P}\Big(X_{m}(0) = a \mid U_{n_{0}+1}^{m}\Big)}_{=1}\right] \\
= \mathbb{P}\Big(X_{m}(0) = M_{n_{0}}\Big).$$

But we assumed that (\mathcal{F}, T) is simply dynamically I-cosy. So we have (22), which yields

$$\mathbb{P}\Big(X_m(0) = M_{n_0}\Big) \xrightarrow[n_0 \to -\infty]{} 1.$$

For each integer $k \geq 1$, we can thus find $n_k \leq m-1$ such that

$$\mathbb{P}\Big(X_m(0) \neq M_{n_k}\Big) < 2^{-k}.$$

By Borel-Cantelli, we get $X_m(0) = \lim_{k \to \infty} M_{n_k}$ (\mathbb{P} -a.s.). Moreover, M_{n_k} is always \mathscr{G}_m -measurable. Therefore $X_m(0)$ is measurable with respect to \mathscr{G}_m , and since the sigma-algebras are factor sigma-algebras, the whole T-process X_m is \mathscr{G}_m -measurable.

It follows that (\mathscr{F},T) is dynamically immersed in the factor filtration (\mathscr{G},T) of product type, hence it is dynamically standard.
