# WEAKLY NONLINEAR MULTIPHASE GEOMETRIC OPTICS FOR HYPERBOLIC QUASILINEAR BOUNDARY VALUE PROBLEMS: CONSTRUCTION OF A LEADING PROFILE

#### Abstract

We investigate in this paper the existence of the leading profile of a WKB expansion for quasilinear initial boundary value problems with a highly oscillating forcing boundary term. The framework is weakly nonlinear, as the boundary term is of order $O(\varepsilon)$ where the frequencies are of order $O(1 / \varepsilon)$. We consider here multiple phases on the boundary, generating a countable infinite number of phases inside the domain, and we therefore use an almost periodic functional framework. The major difficulties of this work are the lack of symmetry in the leading profile equation and the occurrence of infinitely many resonances (opposite to the simple phase case studied earlier) The leading profile is constructed as the solution of a quasilinear problem, which is solved using a priori estimates without loss of derivatives. The assumptions of this work are illustrated with the example of isentropic Euler equations in space dimension two.

## 1. Introduction

We consider in this paper hyperbolic quasilinear initial boundary value problems with a highly oscillating forcing boundary term. We are interested in constructing, in the high frequency asymptotic, an approximate solution to this problem in the form of a WKB expansion. In [Wil02], [CGW11], and [Her15], the authors study the same quasilinear problem, but with only one phase on the boundary. This work is an extension to the multiphase case. The nonlinearity of the problem generates a countable infinite number of phases inside the domain, forcing us to consider an almost-periodic framework, the group of frequencies being, in general, not finitely generated.

This almost-periodic functional framework has been previously used to construct approximate solutions to semilinear systems in the context of Wiener algebras by [JMR94] for the Cauchy problem and [Wil96] for the boundary value problem, as well as for quasilinear systems in the context of Bohr-Besicovich spaces, notably by [JMR95] for the Cauchy problem. In this work we attempt to achieve the next step, namely to obtain a similar result as the one of [JMR95], for quasilinear boundary value problems. We adapt the functional framework of [JMR95] to the context of boundary value problems, by considering functions that are quasi-periodic with respect to the tangential fast variables and almost-periodic with respect to the normal fast variable. Concerning the regularity, we choose a Sobolev control for the (slow and fast) tangential variables, and a uniform control for the normal variables. The leading profile of the WKB expansion is then obtained as the solution of a quasilinear problem which takes into account the potentially infinite number of resonances between the phases. We solve this quasilinear problem in a classical way by proving estimates without loss of regularity. The example of gas dynamics is used all along the paper to illustrate the general assumptions that will be made during the analysis. The main difference between this paper and [JMR95] is the absence of symmetry in the problem. Indeed, starting with an evolution problem in time, we modify it to obtain a propagation problem in the normal variable $x_{d}$, with respect to which the system is not hyperbolic. In [JMR95], these symmetries are used for the a priori estimates to handle the resonance terms that appear in the equations. Even though it is relatively easy in our problem to create symmetries for the self-interaction terms, it is more delicate for the resonance terms, which, unlike the case of [CGW11], are in infinite number. The last assumption of the paper is made to deal with this issue.

After introducing the problem studied here, we look into the characteristic frequencies associated with it, and we make several assumptions about the system, ensuring that the initial boundary problem is well posed locally in time for the exact solution. At this stage, due to the high frequencies in the forcing term, we do not know if the lifespan of the exact solution is uniform with respect to the small wavelength. Next we describe the functional framework used in this work, justified by a formal study of the frequencies that may occur in the solution. Then we define the ansatz for the asymptotic expansion of the exact solution, and we state the main result of this paper, namely the existence and uniqueness of the WKB expansion leading profile. At first we formally derive the equations for the leading profile, and we proceed by solving them. We start by reducing the studied system to two decoupled systems on the evanescent and oscillating parts, and by decoupling the resonant part and each non-resonant mode for the oscillating part. The evanescent part is easy to solve, and we show a priori estimates without loss of regularity for the linearized oscillating systems, which allow us to prove the well-posedness of these linearized systems, and then by an iterative scheme the existence of solutions to the original systems. Reassembling the constructed profiles we finally get the leading profile solution of the initial system.

We shall describe the studied problem in Section 2, as well as the hyperbolicity assumption, the uniform Kreiss-Lopatinskii condition, the example of Euler equations and the proof of some preliminary tools. In Section 3, after motivating it with the example, we construct the functional framework that will be used to state the main theorem. After this long introduction, the main result of the article will be stated, and the plan of the continuation of the analysis will be announced. Some technical proofs are finally postponed in an appendix.

In all the paper the letter $C$ denotes a positive constant that may vary during the analysis, possibly without any mention being made.

## 2. Notations and assumptions

2.1. Presentation of the problem. Given a time $T>0$ and an integer $d \geqslant 2$, let $\Omega_{T}$ be the domain $\Omega_{T}:=(-\infty, T] \times \mathbb{R}^{d-1} \times \mathbb{R}_{+}$and $\omega_{T}:=(-\infty, T] \times \mathbb{R}^{d-1}$ its boundary. We denote as $t \in(-\infty, T]$ the time variable, $x=\left(y, x_{d}\right) \in \mathbb{R}^{d-1} \times \mathbb{R}_{+}$the space variable, with $y \in \mathbb{R}^{d-1}$ the tangential variable and $x_{d} \in \mathbb{R}_{+}$the normal variable, and at last $z=(t, x)=\left(t, y, x_{d}\right)$. We also denote by $z^{\prime}=(t, y) \in \omega_{T}$ the variable of the boundary $\left\{x_{d}=0\right\}$. For $i=1, \ldots, d$, we denote by $\partial_{i}$ the operator of partial derivative with respect to $x_{i}$. Finally we denote as $\alpha \in \mathbb{R}^{d+1}$ and $\zeta \in \mathbb{R}^{d}$ the dual variables of $z \in \Omega_{T}$ and $z^{\prime} \in \omega_{T}$. We consider the following problem

where the unknown $u^{\varepsilon}$ is a function from $\Omega_{T}$ to an open set $\mathcal{O}$ of $\mathbb{R}^{N}$ containing zero, with $N \geqslant 1$, the matrices $A_{j}$ are regular functions of $\mathcal{O}$ with values in $\mathcal{M}_{N}(\mathbb{R})$ and the matrix $B$ belongs to $\mathcal{M}_{M \times N}(\mathbb{R})$ and is of maximal rank. The integer $M$ is made precise in Assumption 3 below. To simplify the notations and clarify the proofs we consider here linear boundary conditions, but it would be possible to deal with non-linear ones. Furthermore we assume the boundary to be noncharacteristic, that is the following assumption is made.

Assumption 1 (Noncharacteristic boundary). For all $u$ in $\mathcal{O}$, the matrix $A_{d}(u)$ is invertible.
The dependence on $\varepsilon>0$ of the system (2.1) comes from the source term $\varepsilon g^{\varepsilon}$ on the boundary $\omega_{T}$, where the quasi-periodic function $g^{\varepsilon}$ is defined, for $z^{\prime}$ in $\omega_{T}$, as

where $G$ is a function of the Sobolev space $H^{\infty}\left(\mathbb{R}^{d} \times \mathbb{T}^{m}\right)$, that vanishes for negative times $t$ and of zero mean with respect to $\theta$ in $\mathbb{T}^{m}$, and where $\zeta_{1}, \ldots, \zeta_{m}$ are frequencies of $\mathbb{R}^{d} \backslash\{0\}$. Here the notation $\mathbb{T}$ stands for the torus $\mathbb{R} / 2 \pi \mathbb{Z}$. We denote by $\boldsymbol{\zeta}$ the $m$-tuple $\boldsymbol{\zeta}:=\left(\zeta_{1}, \ldots, \zeta_{m}\right)$. The function $G$ being periodic and of zero mean with respect to $\theta$, we may write

where $G_{\mathbf{n}}$ is in $H^{\infty}\left(\mathbb{R}^{d}\right)$ and is zero for negative times $t$, for all $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$. The condition $u_{\mid t \leqslant 0}^{\varepsilon}=0$ in (2.1) express the nullity of the initial conditions. The time of existence $T>0$ is not fixed at first and is likely to become sufficiently small to ensure the existence of a leading profile.

The study of [Wil02], [CGW11] and [Her15] is here extended to several phases on the boundary. No assumption on the group of boundary frequencies generated by the frequencies $\left(\zeta_{1}, \ldots\right.$, $\zeta_{m}$ ) is made, apart from it being finitely generated. In particular it may not be discrete.

We want to show that the exact solution of (2.1) behaves, in the limit where $\varepsilon$ goes to 0 , as $\varepsilon$ in range, and $1 / \varepsilon$ in frequencies, and this on a time interval independent of $\varepsilon$. This is the weakly nonlinear geometric optics framework, see [Rau12] and [Mét09]. To obtain this kind of result, we first have to make several suitable assumptions about the original problem. The rest of this section is devoted to these assumptions, and focuses on the characteristic frequencies associated with the system. Let us first detail the example that inspires the general framework developed in this paper.

Example 2.1. The isentropic compressible Euler equations in two dimensions provide a system of the form of (2.1). Under regularity assumptions on the solution, the associated boundary value problem reads

with $V^{\varepsilon}=\left(v^{\varepsilon}, \mathbf{u}^{\varepsilon}\right) \in \mathbb{R}^{3}$, where $v^{\varepsilon} \in \mathbb{R}_{+}^{*}$ represents the fluid volume, and $\mathbf{u}^{\varepsilon} \in \mathbb{R}^{2}$ its velocity, and where the functions $A_{1}$ and $A_{2}$ are defined on $\mathbb{R}_{+}^{*} \times \mathbb{R}^{2}$ as

with $c(v)>0$ representing the sound velocity in the fluid, which depends on its volume $v$. The noncharacteristic boundary Assumption 1 for the system (2.4) is now discussed. In this article, we consider geometric optics expansions for the system (2.1) constructed as perturbations around the equilibrium 0 , performing a change of variables if necessary. For the Euler system the natural coefficients $A_{1}, A_{2}$ are rather used, and a perturbation around the equilibrium $V_{0}=\left(v_{0}, 0, u_{0}\right)$ is considered, where $v_{0}>0$ is a fixed volume, and $\left(0, u_{0}\right)$ is an incoming subsonic velocity, that is such that $0<u_{0}<c_{0}$, where we denote $c_{0}:=c\left(v_{0}\right)$.

The Assumption 1 concerns in this case the invertibility of the matrix $A_{2}(V)$ for $V=$ $\left(v, u_{1}, u_{2}\right) \in \mathbb{R}_{+}^{*} \times \mathbb{R}^{2}$ in the neighborhood $V_{0}$. The determinant of the matrix $A_{2}(V)$ is given by $\operatorname{det}\left(A_{2}(V)\right)=u_{2}\left(u_{2}^{2}-c(v)^{2}\right)$, which is nonzero if the velocity $u_{2}$ satisfies $0<u_{2}<c(v)$. The equilibrium $V_{0}$ verifying this condition, every small enough neighborhood $\mathcal{O}$ of $V_{0}$ suits to satisfy the Assumption 1.

The rest of the section is dedicated to the characteristic frequencies related to the problem and the associated assumptions.
2.2. Strict hyperbolicity. The following definition introduces the notion of characteristic frequency.
Definition 2.2. For $\alpha=(\tau, \eta, \xi) \in \mathbb{R} \times \mathbb{R}^{d-1} \times \mathbb{R}$, the symbol $L(0, \alpha)$ associated with $L\left(0, \partial_{z}\right)$ is defined as

L(0, \alpha):=\tau I+\sum_{i=1}^{d-1} \eta_{i} A_{i}(0)+\xi A_{d}(0)
$$

Then we define its characteristic polynomial as $p(\tau, \eta, \xi):=\operatorname{det} L(0,(\tau, \eta, \xi))$. We say that $\alpha \in \mathbb{R}^{1+d}$ is a characteristic frequency if it is a root of the polynomial $p$, and we denote by $\mathcal{C}$ the set of characteristic frequencies.

The following assumption, called strict hyperbolicity (see [BGS07]), is made.
Assumption 2 (Strict hyperbolicity). There exist real functions $\tau_{1}<\cdots<\tau_{N}$, analytic with respect to $(\eta, \xi)$ in $\mathbb{R}^{d} \backslash\{0\}$, such that for all $(\eta, \xi) \in \mathbb{R}^{d} \backslash\{0\}$ and for all $\tau \in \mathbb{R}$, the following factorisation is verified

p(\tau, \eta, \xi)=\operatorname{det}\left(\tau I+\sum_{i=1}^{d-1} \eta_{i} A_{i}(0)+\xi A_{d}(0)\right)=\prod_{k=1}^{N}\left(\tau-\tau_{k}(\eta, \xi)\right)
$$

where the eigenvalues $-\tau_{k}(\eta, \xi)$ of the matrix $A(\eta, \xi):=\sum_{i=1}^{d-1} \eta_{i} A_{i}(0)+\xi A_{d}(0)$ are therefore simple. Consequently, for all $(\eta, \xi) \in \mathbb{R}^{d} \backslash\{0\}$, the following decompositions of $\mathbb{C}^{N}$ into dimension

## 1 eigenspaces hold

For $k=1, \ldots, N$ and for $(\eta, \xi)$ in $\mathbb{R}^{d} \backslash\{0\}$, we define the projectors $\pi_{k}(\eta, \xi)$ and $\widetilde{\pi}_{k}(\eta, \xi)$, respectively associated with the decompositions (2.6) and (2.7).

For $k=1, \ldots, N$ and $(\eta, \xi) \in \mathbb{R}^{d} \backslash\{0\}$, we also denote as $E_{k}(\eta, \xi)$ a unitary eigenvector generating the eigenspace $\operatorname{ker} L\left(0, \tau_{k}(\eta, \xi), \eta, \xi\right)$, so that

is a real normal basis of $\mathbb{C}^{N}$ adapted to the decomposition (2.6). Observe that the family

is therefore a real normal basis of $\mathbb{C}^{N}$ adapted to the decomposition (2.7).
Remark 2.3. i) We will be led further on to consider the modified operator

$$
\widetilde{L}\left(0, \partial_{z}\right):=A_{d}(0)^{-1} L\left(0, \partial_{z}\right)
$$

This justifies the introduction of the modified symbol $\widetilde{L}(0, \alpha):=A_{d}(0)^{-1} L(0, \alpha)$, and thus of the projector $\widetilde{\pi}_{k}(\eta, \xi)$, the symbols $L(0, \alpha)$ and $\widetilde{L}(0, \alpha)$ having different ranges.
ii) Since the matrix $A(\eta, \xi)=\sum_{i=1}^{d-1} \eta_{i} A_{i}(0)+\xi A_{d}(0)$ is real for $(\eta, \xi) \in \mathbb{R}^{d}$ and the eigenvalues $\tau_{1}, \ldots, \tau_{N}$ are real, the decompositions (2.6) and (2.7) also hold in $\mathbb{R}^{N}$, but we are interested in the ones of $\mathbb{C}^{N}$ since some functions that will be studied are complex valued.
iii) If $\alpha=(\tau, \eta, \xi)$ is a characteristic frequency, then by definition and according to Assumption 2 , the triplet $(\tau, \eta, \xi)$ satisfies

$$
\prod_{k=1}^{N}\left(\tau-\tau_{k}(\eta, \xi)\right)=0
$$

There exists therefore an integer $k$ between 1 and $N$ such that $\tau=\tau_{k}(\eta, \xi)$. In other words, the characteristic manifold $\mathcal{C}$ is the union of the $N$ hypersurfaces given by $\left\{\tau=\tau_{k}(\eta, \xi)\right\}$, $k=1, \ldots, N$.

Remark 2.4. One can verify that in Assumption 2, the functions $\tau_{k}$ for $k=1, \ldots, N$ are positively homogeneous of degree 1 in $\mathbb{R}^{d} \backslash\{0\}$. The projectors $\pi_{k}$ and $\widetilde{\pi}_{k}$ for $k=1, \ldots, N$ are therefore positively homogeneous of degree 0 in $\mathbb{R}^{d} \backslash\{0\}$.

Example 2.5. Returning to the Example 2.1, for the system (2.4) linearized around $V_{0}=$ $\left(v_{0}, 0, u_{0}\right)$, the characteristic polynomial $p$ reads

p(\tau, \eta, \xi)=\operatorname{det}\left(\begin{array}{ccc}
\tau+\xi u_{0} & -v_{0} \eta & -v_{0} \xi \\
-c_{0}^{2} \eta / v_{0} & \tau+\xi u_{0} & 0 \\
-c_{0}^{2} \xi / v_{0} & 0 & \tau+\xi u_{0}
\end{array}\right)=\left(\tau+\xi u_{0}\right)\left(\left(\tau+\xi u_{0}\right)^{2}-c_{0}^{2}\left(\eta^{2}+\xi^{2}\right)\right)
$$

Thus the eigenvalues of the matrix $A(\eta, \xi)=\eta A_{1}\left(V_{0}\right)+\xi A_{2}\left(V_{0}\right)$ are the opposite of the roots with respect to $\tau$ of the polynomial $p$, given by

\begin{equation*}
\tau_{1}(\eta, \xi):=-u_{0} \xi-c_{0} \sqrt{\eta^{2}+\xi^{2}}, \quad \tau_{2}(\eta, \xi):=-u_{0} \xi, \quad \tau_{3}(\eta, \xi):=-u_{0} \xi+c_{0} \sqrt{\eta^{2}+\xi^{2}} \tag{2.10}
\end{equation*}

The functions $\tau_{1}, \tau_{2}$ and $\tau_{3}$ are analytic and distinct in $\mathbb{R}^{2} \backslash\{0\}$. The system (2.4) is therefore strictly hyperbolic, which means that it satisfies the Assumption 2 of strict hyperbolicity. We have represented in Figure 1 the characteristic frequencies $\alpha=(\tau, \eta, \xi) \in \mathbb{R}^{3}$ for the system (2.4).


Figure 1. Characteristic frequencies for the isentropic compressible Euler system (2.4)

We now define projectors derived from the $\mathbb{C}^{N}$ decomposition (2.6), that we extend to noncharacteristic frequencies. We also determine some equalities between the kernel and range of the projectors $\pi_{\alpha}$ and $\widetilde{\pi}_{\alpha}$ and of the matrices $L(0, \alpha)$ and $\widetilde{L}(0, \alpha)$. The proof is based on the one of [CG10, Lemma 3.2].

Definition 2.6. Let $\alpha=(\tau, \eta, \xi) \in \mathbb{R}^{1+d} \backslash\{0\}$ be a characteristic frequency and $k$ the integer between 1 and $N$ such that $\tau=\tau_{k}(\eta, \xi)$. We denote by $\pi_{\alpha}:=\pi_{k}(\eta, \xi)$ (resp. $\widetilde{\pi}_{\alpha}:=$ $\widetilde{\pi}_{k}(\eta, \xi)$ ) the projection from $\mathbb{C}^{N}$ onto the eigenspace $\operatorname{ker} L\left(0, \tau_{k}(\eta, \xi), \eta, \xi\right)$ (resp. the subspace $\left.A_{d}(0)^{-1} \operatorname{ker} L\left(0, \tau_{k}(\eta, \xi), \eta, \xi\right)\right)$ according to decomposition (2.6) (resp. (2.7)). If the frequency $\alpha \in \mathbb{R}^{1+d} \backslash\{0\}$ is not characteristic, we denote $\pi_{\alpha}=\widetilde{\pi}_{\alpha}:=0$ and if $\alpha=0$ we denote $\pi_{0}:=\widetilde{\pi}_{0}:=I$. For all $\alpha$ in $\mathbb{R}^{d+1}$, we can verify that $\pi_{\alpha}$ satisfies

$$
\begin{equation*}
\operatorname{ker} L(0, \alpha)=\operatorname{ker} \widetilde{L}(0, \alpha)=\operatorname{Im} \pi_{\alpha}, \tag{2.11}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Im} L(0, \alpha)=\operatorname{ker} \pi_{\alpha}, \tag{2.12}
\end{equation*}
$$

and that the projector $\widetilde{\pi}_{\alpha}$ satisfies

$$
\begin{equation*}
\operatorname{Im} \widetilde{L}(0, \alpha)=\operatorname{ker} \widetilde{\pi}_{\alpha}, \tag{2.13}
\end{equation*}
$$

recalling that $\widetilde{L}(0, \alpha)$ refers to the modified symbol $\widetilde{L}(0, \alpha):=A_{d}(0)^{-1} L(0, \alpha)$.
For all $\alpha \in \mathbb{R}^{1+d} \backslash\{0\}$, we denote by $Q_{\alpha}$ the partial inverse of the matrix $L(0, \alpha)$, namely the unique matrix $Q_{\alpha}$ such that $Q_{\alpha} L(0, \alpha)=L(0, \alpha) Q_{\alpha}=I-\pi_{\alpha}$. If $\alpha=0$, we define $Q_{\alpha}:=I$.

Proof. Consider $\alpha=(\tau, \eta, \xi)$ in $\mathbb{R}^{d+1}$. The equation (2.11) is satisfied by definition of $\pi_{\alpha}$, and equality of the kernels $\operatorname{ker} L(0, \alpha)$ and $\operatorname{ker} \widetilde{L}(0, \alpha)$, the matrix $A_{d}(0)$ being invertible. Regarding the equation (2.12), we first note that by the rank-nullity theorem and by definition of $\pi_{\alpha}$, the subspaces $\operatorname{Im} L(0, \alpha)$ and $\operatorname{ker} \pi_{\alpha}$ have the same dimension. We denote by $k_{0}$ the integer between 1 and $N$ such that $\tau=\tau_{k_{0}}(\eta, \xi)$. We consider then an element $L(0, \alpha) X$ of $\operatorname{Im} L(0, \alpha)$, with $X$ in $\mathbb{C}^{N}$ that we decompose according to (2.6), as $X=\sum_{k=1}^{N} \pi_{k}(\eta, \xi) X$. For $k=1, \ldots, N$, the projector $\pi_{k}(\eta, \xi)$ admitting the eigenspace of the matrix $A(\eta, \xi)$ associated with the eigenvalue
$-\tau_{k}(\eta, \xi)$ as range, we have

$$
\begin{aligned}
L(0, \alpha) X & =\sum_{k=1}^{N}\left(\tau_{k_{0}}(\eta, \xi) I+A(\eta, \xi)\right) \pi_{k}(\eta, \xi) X \\
& =\sum_{k \neq k_{0}}\left(\tau_{k_{0}}(\eta, \xi)-\tau_{k}(\eta, \xi)\right) \pi_{k}(\eta, \xi) X
\end{aligned}
$$

The equation (2.11) being satisfied, we deduce that $L(0, \alpha) X$ belongs to

$$
\bigoplus_{k \neq k_{0}} \operatorname{ker} L\left(0,\left(\tau_{k}(\eta, \xi), \eta, \xi\right)\right)
$$

which, by definition of the projectors $\pi_{k}$, is equal to the kernel of $\pi_{k_{0}}(\eta, \xi)=\pi_{\alpha}$. With the equality of dimensions the equation (2.12) is therefore verified. The proof of the equation (2.13) is similar: we consider $X$ in $\mathbb{C}^{N}$ that we decompose as $X=\sum_{k=1}^{N} \pi_{k}(\eta, \xi) X$, and then we write

$$
\begin{aligned}
\widetilde{L}(0, \alpha) X & =A_{d}(0)^{-1} \sum_{k=1}^{N}\left(\tau_{k_{0}}(\eta, \xi) I+A(\eta, \xi)\right) \pi_{k}(\eta, \xi) X \\
& =A_{d}(0)^{-1} \sum_{k \neq k_{0}}\left(\tau_{k_{0}}(\eta, \xi)-\tau_{k}(\eta, \xi)\right) \pi_{k}(\eta, \xi) X
\end{aligned}
$$

so that $\widetilde{L}(0, \alpha) X$ belongs to

$$
\bigoplus_{k \neq k_{0}} A_{d}(0)^{-1} \operatorname{ker} L\left(0,\left(\tau_{k}(\eta, \xi), \eta, \xi\right)\right)=\operatorname{ker} \widetilde{\pi}_{\alpha} .
$$

Once again by equality of dimensions it leads to equation (2.13).
Remark 2.7. i) For every $k=1, \ldots, N$, the projectors $\pi_{k}(\eta, \xi)$ and $\widetilde{\pi}_{k}(\eta, \xi)$ are positively homogeneous of degree 0 in $(\eta, \xi) \in \mathbb{R}^{d} \backslash\{0\}$. Furthermore, by strict hyperbolicity, the basis $E_{1}(\eta, \xi), \ldots, E_{N}(\eta, \xi)$ and $A_{d}(0)^{-1} E_{1}(\eta, \xi), \ldots, A_{d}(0)^{-1} E_{N}(\eta, \xi)$ are analytic with respect to $(\eta, \xi) \in \mathbb{R}^{d} \backslash\{0\}$, and the maps $(\eta, \xi) \mapsto \pi_{k}(\eta, \xi)$ and $(\eta, \xi) \mapsto \widetilde{\pi}_{k}(\eta, \xi)$ are therefore analytic in $\mathbb{R}^{d} \backslash\{0\}$. Thus, by compactness of the sphere $\mathbb{S}^{d-1}$, for all $k=1, \ldots, N$, the projectors $\pi_{k}(\eta, \xi)$ and $\widetilde{\pi}_{k}(\eta, \xi)$ are uniformly bounded with respect to $(\eta, \xi) \in \mathbb{R}^{d} \backslash\{0\}$. The projectors $\pi_{\alpha}$ and $\widetilde{\pi}_{\alpha}$ are therefore bounded with respect to $\alpha$ in $\mathbb{R}^{1+d}$.
ii) Unlike the projectors $\pi_{k}$ and $\widetilde{\pi}_{k}, k=1, \ldots, N$, the projectors $\pi_{\alpha}$ and $\widetilde{\pi}_{\alpha}$ are homogeneous of degree 0 with respect to $\alpha$ in $\mathbb{R}^{d+1}$, and not only positively homogeneous. Indeed, the claim is obvious if $\alpha$ is zero or noncharacteristic, and if $\alpha$ is a nonzero characteristic frequency, and $\lambda$ a nonzero real number, then, since $\operatorname{ker} L(0, \lambda \alpha)=\operatorname{ker} L(0, \alpha)$ and $\operatorname{Im} L(0, \lambda \alpha)=\operatorname{Im} L(0, \alpha)$, we have $\pi_{\lambda \alpha}=\pi_{\alpha}$. The proof is the same for $\widetilde{\pi}_{\alpha}$.
2.3. The uniform Kreiss-Lopatinskii condition and some preliminary results. We define the following space of frequencies

$$
\begin{aligned}
\Xi & :=\left\{\zeta=(\sigma=\tau-i \gamma, \eta) \in\left(\mathbb{C} \times \mathbb{R}^{d-1}\right) \backslash\{0\} \mid \gamma \geqslant 0\right\}, \\
\Sigma & :=\left\{\zeta \in \Xi\left|\tau^{2}+\gamma^{2}+|\eta|^{2}=1\right\},\right. \\
\Xi_{0} & :=\{\zeta \in \Xi \mid \gamma=0\}, \\
\Sigma_{0} & :=\Xi_{0} \cap \Sigma .
\end{aligned}
$$

We also define the matrix that we get when applying the Laplace-Fourier transform to the operator $L\left(0, \partial_{z}\right)$. For all $\zeta=(\sigma, \eta) \in \Xi$, let

$$
\mathcal{A}(\zeta):=-i A_{d}(0)^{-1}\left(\sigma I+\sum_{i=1}^{d-1} \eta_{j} A_{j}(0)\right) .
$$

The noncharacteristic boundary Assumption 1 is used here to define the matrix $\mathcal{A}(\zeta)$. We note that if $\zeta=(\tau, \eta) \in \Xi_{0}$, and if $i \xi$ is an imaginary eigenvalue of $\mathcal{A}(\zeta)$, then the frequency $(\tau, \eta, \xi)$ is a real characteristic frequency, and vice versa.

The Hersh lemma ([Her63]) ensures that for $\zeta$ in $\Xi \backslash \Xi_{0}$, the matrix $\mathcal{A}(\zeta)$ has no eigenvalue of zero real part, and that the stable subspace associated with the eigenvalues of negative real part, denoted by $E_{-}(\zeta)$, is of constant dimension, denoted $p$. Furthermore, the integer $p$ is obtained as the number of positive eigenvalues of the matrix $A_{d}(0)$. We denote by $E_{+}(\zeta)$ the unstable subspace $\mathcal{A}(\zeta)$ associated with eigenvalues of positive real part, that is of dimension $N-p$.

In [Kre70] (see also [CP82] and [BGS07]) it is shown that the stable and unstable subspaces $E_{ \pm}$extend continuously to the whole space $\Xi$ in the strictly hyperbolic case (Assumption 2). We still denote by $E_{ \pm}$the extensions to $\Xi$. The main assumption of this work may now be stated, which, along with Assumptions 1 and 2, ensures that the system (2.1) is well posed locally in time. Indeed the three assumptions 1,2 and 3 are stable under small perturbations around the equilibrium.

Assumption 3 (Uniform Kreiss-Lopatinskii condition). For all $\zeta \in \Xi$, we have

$$
\text { ker } B \cap E_{-}(\zeta)=\{0\} .
$$

In particular, it forces the rank of the matrix $B$ to be equal to the dimension of $E_{-}(\zeta)$, namely $M=p$.

Remark 2.8. Historically, the first given definition of the uniform Kreiss-Lopatinskii condition did not involve the extension of $E_{-}$to $\Xi_{0}$. The original definition states that, for all $\zeta \in \Xi \backslash \Xi_{0}$,

$$
\operatorname{ker} B \cap E_{-}(\zeta)=\{0\},
$$

and that the linear map $\left(B_{\mid E_{-}(\zeta)}\right)^{-1}$ is uniformly bounded with respect to $\zeta \in \Xi \backslash \Xi_{0}$, see for instance [Sar65]. Indeed, the space $E_{-}(\zeta)$ being homogeneous of degree zero and continuous with respect to $\zeta \in \Xi$, and by compactness of the unitary sphere $\Sigma$, we note that the Assumption 3 implies that the linear map $\left(B_{\mid E_{-}(\zeta)}\right)^{-1}$ is uniformly bounded with respect to $\zeta \in \Xi$.

It has already been discussed that for $\zeta \in \Xi \backslash \Xi_{0}$, the matrix $\mathcal{A}(\zeta)$ has no imaginary eigenvalue. We now commit to describe more precisely the matrix $\mathcal{A}(\zeta)$ for $\zeta$ in $\Xi_{0}$ as well as the continuous extension to $\Xi_{0}$ of the spaces $E_{ \pm}(\zeta)$. The following result, proved by Kreiss [Kre70] for the strictly hyperbolic case that is of interest here, Métivier [Mét00] for the constantly hyperbolic case, and extended by Métivier and Zumbrun [MZ05] to an even more general framework, gives a very useful decomposition of the matrix $\mathcal{A}(\zeta)$ when $\zeta$ belongs to $\Xi_{0}$.
Proposition 2.9 (Block structure). When the Assumption 2 is satisfied, for all $\bar{\zeta} \in \Xi$, there exist a neighborhood $\mathcal{V}$ of $\underline{\zeta}$ in $\Xi$, an integer $L \geqslant 1$, a partition $N=\rho_{1}+\cdots+\rho_{L}$ and an invertible matrix $T$ analytic in $\mathcal{V}$ such that for all $\zeta \in \mathcal{V}$, we have

$$
T(\zeta) \mathcal{A}(\zeta) T(\zeta)^{-1}=\operatorname{diag}\left(\mathcal{A}_{1}(\zeta), \ldots, \mathcal{A}_{L}(\zeta)\right)
$$

where for all $j$ the matrix $\mathcal{A}_{j}(\zeta)$ is of size $\rho_{j}$ and satisfies one of the following properties:
i) the real part of the matrix $\mathcal{A}_{j}(\zeta)$, defined by $\left(\mathcal{A}_{j}(\zeta)+\mathcal{A}_{j}(\zeta)^{*}\right) / 2$, is positive-definite,
ii) the real part of the matrix $\mathcal{A}_{j}(\zeta)$ is negative-definite,
iii) $\rho_{j}=1, \mathcal{A}_{j}(\zeta)$ is imaginary when $\gamma$ is zero and $\partial_{\gamma} \mathcal{A}_{j}(\underline{\zeta}) \in \mathbb{R}^{*}$,
iv) $\rho_{j}>1$, the coefficients of $\mathcal{A}_{j}(\zeta)$ are imaginary when $\bar{\gamma}$ is zero, there exists $\xi_{j} \in \mathbb{R}$ such that

$$
\mathcal{A}_{j}(\underline{\zeta})=\left(\begin{array}{ccc}
i \xi_{j} & i & 0 \\
& \ddots & i \\
0 & & i \xi_{j}
\end{array}\right)
$$

and the bottom left coefficient of $\partial_{\gamma} \mathcal{A}_{j}(\underline{\zeta})$ is real and non zero.
This result, commonly referred to as "block structure" [BGS07], is fundamental for the proof of Proposition 2.21 below. In the aim of describing the subspaces $E_{ \pm}(\zeta)$ for $\zeta \in \Xi_{0}$, the vector fields associated with each real characteristic phase are now defined.


Figure 2. Incoming ( $i$ ), outgoing ( $o$ ) and glancing ( $g$ ) vector field.
Definition 2.10. Let $\alpha=(\tau, \eta, \xi) \in \mathbb{R}^{d+1} \backslash\{0\}$ be a characteristic frequency, and $k$ the integer between 1 and $N$ such that $\tau=\tau_{k}(\eta, \xi)$. The group velocity $\mathbf{v}_{\alpha}$ associated with $\alpha$ is defined as

$$
\mathbf{v}_{\alpha}:=\nabla_{\eta, \xi} \tau_{k}(\eta, \xi)
$$

We shall say that $\alpha$ is glancing (resp. incoming, outgoing) if $\partial_{\xi} \tau_{k}(\eta, \xi)$ is zero (resp. negative, positive). Then the vector field $X_{\alpha}$ associated with $\alpha$ is defined as

$$
\begin{equation*}
X_{\alpha}:=\partial_{t}-\mathbf{v}_{\alpha} \cdot \nabla_{x}=\partial_{t}-\nabla_{\eta} \tau_{k}(\eta, \xi) \cdot \nabla_{y}-\partial_{\xi} \tau_{k}(\eta, \xi) \partial_{x_{d}} . \tag{2.14}
\end{equation*}
$$

The vector field $X_{\alpha}$ is represented in Figure 2 in the glancing, incoming and outgoing case.
Example 2.11. We start by giving an example of a boundary condition for the Example 2.1 satisfying the uniform Kreiss-Lopatinskii condition. For this purpose we look for a matrix $B$ in $\mathcal{M}_{2,3}(\mathbb{R})$ of maximal rank, that generates strictly dissipative boundary conditions (see [BGS07]), namely such that its kernel, which is of dimension 1 , is generated by a nonzero vector $E$ satisfying

$$
{ }^{t} E S(V) A_{2}(V) E<0
$$

for all $V$ in the neighborhood of $V_{0}$, where the matrix $S(V)$ refers to a Friedrichs symmetrizer of the system. Such strictly dissipative boundary conditions satisfy in particular the uniform Kreiss-Lopatinskii condition, see [BGS07]. In our example, the following symmetrizer may be considered

$$
S(V)=\operatorname{diag}\left(c(v)^{2}, v^{2}, v^{2}\right) .
$$

Recall that, in the notations of the example, a symmetrizer $S(V)$ is a positive definite matrix such that the matrices $S(V) A_{1}(V)$ and $S(V) A_{2}(V)$ are symmetric for all $V$ in a neighborhood of $V_{0}$. It is then determined that a suitable vector $E$ is given by $E=\left(v_{0}, 0, u_{0}\right)$, since in that case we have

$$
{ }^{t} E S\left(V_{0}\right) A_{2}\left(V_{0}\right) E=u_{0} v_{0}^{2}\left(u_{0}^{2}-c_{0}^{2}\right)
$$

the right-hand side quantity being negative by assumption on $V_{0}$, so it stays negative in a neighborhood of $V_{0}$. Thus a matrix $B$ of maximal rank whose kernel is generated by $E$ is for example given by

$$
B:=\left(\begin{array}{ccc}
0 & v_{0} & 0 \\
-u_{0} & 0 & v_{0}
\end{array}\right),
$$

which gives an example of a boundary condition satisfying the uniform Kreiss-Lopatinskii condition for the Example 2.1 of compressible isentropic Euler equations in dimension 2.

Interest is now made on the eigenvalues of the matrix $\mathcal{A}(\tau, \eta)$ for the system of Example 2.1. Their expressions, for $(\tau, \eta) \in \mathbb{R}^{2} \backslash\{0\}$, depend on the sign of $\tau^{2}-\eta^{2}\left(c_{0}^{2}-u_{0}^{2}\right)$, as represented in Figure 3.

If $|\tau|>\sqrt{c_{0}^{2}-u_{0}^{2}}|\eta|$, i.e. if $\zeta=(\tau, \eta)$ is in the so-called hyperbolic region $\mathcal{H}$ ([Ben14, Definition 2.1]), then the matrix $\mathcal{A}(\zeta)$ admits three simple imaginary eigenvalues given by

$$
\begin{align*}
i \xi_{1}(\tau, \eta) & :=i \frac{\tau u_{0}+\operatorname{sign}(\tau) c_{0} \sqrt{\tau^{2}-\eta^{2}\left(c_{0}^{2}-u_{0}^{2}\right)}}{c_{0}^{2}-u_{0}^{2}}  \tag{2.15a}\\
i \xi_{2}(\tau, \eta) & :=i \frac{\tau u_{0}-\operatorname{sign}(\tau) c_{0} \sqrt{\tau^{2}-\eta^{2}\left(c_{0}^{2}-u_{0}^{2}\right)}}{c_{0}^{2}-u_{0}^{2}}  \tag{2.15b}\\
i \xi_{3}(\tau, \eta) & :=i \frac{-\tau}{u_{0}} \tag{2.15c}
\end{align*}
$$

where $\operatorname{sign}(x):=x /|x|$ for $x \neq 0$. The number $\xi_{1}(\tau, \eta)$ being real, the frequency $\alpha_{1}(\tau, \eta):=$ $\left(\tau, \eta, \xi_{1}(\tau, \eta)\right)$ is a real characteristic frequency. It is then determined that we have $\tau=$ $\tau_{3}\left(\eta, \xi_{1}(\tau, \eta)\right)$ if $\tau>0$ and $\tau=\tau_{1}\left(\eta, \xi_{1}(\tau, \eta)\right)$ if $\tau<0$. A calculation gives, if $\tau>0$,

$$
\partial_{\xi} \tau_{3}\left(\eta, \xi_{1}(\tau, \eta)\right)=\sqrt{\frac{\tau^{2}-\eta^{2}\left(c_{0}^{2}-u_{0}^{2}\right)}{\eta^{2}+\xi_{1}^{2}(\tau, \eta)}}
$$

and, if $\tau<0$,

$$
\partial_{\xi} \tau_{1}\left(\eta, \xi_{1}(\tau, \eta)\right)=\sqrt{\frac{\tau^{2}-\eta^{2}\left(c_{0}^{2}-u_{0}^{2}\right)}{\eta^{2}+\xi_{1}^{2}(\tau, \eta)}}
$$

Thus the frequency $\alpha_{1}(\tau, \eta)=\left(\tau, \eta, \xi_{1}(\tau, \eta)\right)$ is always outgoing. Likewise, it is determined that the real characteristic frequency $\alpha_{2}(\tau, \eta):=\left(\tau, \eta, \xi_{2}(\tau, \eta)\right)$ is always incoming, and the frequency $\alpha_{3}(\tau, \eta):=\left(\tau, \eta, \xi_{3}(\tau, \eta)\right)$ is incoming as well.

If $\zeta$ is located in the so-called glancing region $\mathcal{G}$, i.e. if $|\tau|=\sqrt{c_{0}^{2}-u_{0}^{2}}|\eta|$, then the matrix $\mathcal{A}(\zeta)$ admits one imaginary simple eigenvalue $i \xi_{3}(\zeta)$ which is still given by the formula $(2.15 \mathrm{c})$, and a double imaginary eigenvalue given by

$$
i \xi_{1}(\zeta)=i \xi_{2}(\zeta)=i \frac{\tau u_{0}}{c_{0}^{2}-u_{0}^{2}}
$$

In this case we still have $\tau=\tau_{3}\left(\eta, \xi_{1}(\tau, \eta)\right)$ if $\tau>0$ and $\tau=\tau_{1}\left(\eta, \xi_{1}(\tau, \eta)\right)$ if $\tau<0$, and regarding the characteristic frequency $\alpha_{3}(\tau, \eta)=\left(\tau, \eta, \xi_{3}(\tau, \eta)\right)$, we still have $\tau=\tau_{2}\left(\eta, \xi_{3}(\tau, \eta)\right)$. Thus it is determined that

$$
\partial_{\xi} \tau_{1}\left(\eta, \xi_{1}(\tau, \eta)\right)=\partial_{\xi} \tau_{3}\left(\eta, \xi_{1}(\tau, \eta)\right)=0
$$

and therefore, regardless of the sign of $\tau$, the frequency $\alpha_{1}(\tau, \eta)$ is glancing. As for it, the frequency $\alpha_{3}(\tau, \eta)$ is always incoming.

Finally if $|\tau|<\sqrt{c_{0}^{2}-u_{0}^{2}}|\eta|$ and so if $\zeta$ is in the so-called mixed region $\mathcal{E} \mathcal{H}$, then the matrix $\mathcal{A}(\zeta)$ has one simple imaginary eigenvalue $i \xi_{3}(\zeta)$ given by the formula (2.15c), and two simple eigenvalues of nonzero real part (symmetric with respect to the imaginary axis), that are still denoted by $i \xi_{1}$ et $i \xi_{2}$ and which are given by

$$
\begin{aligned}
i \xi_{1}(\tau, \eta) & :=i \frac{\tau u_{0}+i c_{0} \operatorname{sign}(\tau) \sqrt{\eta^{2}\left(c_{0}^{2}-u_{0}^{2}\right)-\tau^{2}}}{c_{0}^{2}-u_{0}^{2}} \\
i \xi_{2}(\tau, \eta) & :=i \frac{\tau u_{0}-i c_{0} \operatorname{sign}(\tau) \sqrt{\eta^{2}\left(c_{0}^{2}-u_{0}^{2}\right)-\tau^{2}}}{c_{0}^{2}-u_{0}^{2}}
\end{aligned}
$$

The real characteristic frequency $\alpha_{3}(\tau, \eta)=\left(\tau, \eta, \xi_{3}(\tau, \eta)\right)$ is once again incoming.

In the following, in order for the matrix in factor of the partial derivative with respect to the normal variable $x_{d}$ in the equations to be the identity matrix, the modified operator $\widetilde{L}\left(u, \partial_{z}\right):=$ $A_{d}(u)^{-1} L\left(u, \partial_{z}\right)$ shall be considered. The following lemma, which is a result of [Lax57] adapted

by [CGW11, Lemma 2.11], shows that, under suitable assumptions, the operator $\widetilde{\pi}_{\alpha} \widetilde{L}\left(0, \partial_{z}\right) \pi_{\alpha}$ is given by a constant coefficient scalar transport operator, and therefore that the operator $\widetilde{\pi}_{\alpha} \widetilde{L}\left(0, \partial_{z}\right)$ acts on polarized profiles (i.e. profiles $U$ such that $\pi_{\alpha} U=U$ ) as a much simpler operator.
Lemma 2.12 ([CGW11, Lax Lemma]). Let $\alpha=(\tau, \eta, \xi) \in \mathbb{R}^{1+d} \backslash\{0\}$ be a real non glancing characteristic frequency and $k$ the integer between 1 and $N$ such that $\tau=\tau_{k}(\eta, \xi)$. Then we have

$$
\widetilde{\pi}_{\alpha} \widetilde{L}\left(0, \partial_{z}\right) \pi_{\alpha}=\frac{-1}{\partial_{\xi} \tau_{k}(\eta, \xi)} X_{\alpha} \widetilde{\pi}_{\alpha} \pi_{\alpha}
$$

where $X_{\alpha}$ is the vector field associated with $\alpha$ defined by (2.14). Then we denote

$$
\widetilde{X}_{\alpha}:=\frac{-1}{\partial_{\xi} \tau_{k}(\eta, \xi)} X_{\alpha} .
$$

For the sake of completeness, the proof of [CGW11] is recalled here.
Proof. The notations of the Lemma are used. According to the identity (2.11), we have

$$
\begin{equation*}
\widetilde{L}\left(0,\left(\tau_{k}(\eta, \xi), \eta, \xi\right)\right) \pi_{k}(\eta, \xi)=\left(\tau_{k}(\eta, \xi) \widetilde{A}_{0}(0)+\sum_{i=1}^{d-1} \eta_{i} \widetilde{A}_{i}(0)+\xi I\right) \pi_{k}(\eta, \xi)=0 \tag{2.16}
\end{equation*}
$$

The Dunford formula and the implicit function theorem ensure that in the strictly hyperbolic case, the projectors $\pi_{k}$ as well as the real functions $\tau_{k}$ are differentiable with respect to $(\eta, \xi)$ in $\mathbb{R}^{d} \backslash\{0\}$ (they even depend analytically of $(\eta, \xi)$ ). Thus the identity (2.16) is differentiated with respect to $\xi$ in a neighborhood of a frequency $(\eta, \xi)$ in $\mathbb{R}^{d} \backslash\{0\}$ to obtain

$$
\left(\partial_{\xi} \tau_{k}(\eta, \xi) \widetilde{A}_{0}(0)+I\right) \pi_{k}(\eta, \xi)+\left(\tau_{k}(\eta, \xi) \widetilde{A}_{0}(0)+\sum_{i=1}^{d-1} \eta_{i} \widetilde{A}_{i}(0)+\xi I\right) \partial_{\xi} \pi_{k}(\eta, \xi)=0
$$

and therefore, multiplying by $\widetilde{\pi}_{k}(\eta, \xi)$ on the left, according to identity (2.13), we get

$$
\begin{equation*}
\widetilde{\pi}_{k}(\eta, \xi) \widetilde{A}_{0}(0) \pi_{k}(\eta, \xi)=-\frac{1}{\partial_{\xi} \tau_{k}(\eta, \xi)} \tilde{\pi}_{k}(\eta, \xi) \pi_{k}(\eta, \xi) \tag{2.17}
\end{equation*}
$$

Likewise, for $i=1, \ldots, d-1$, the equality (2.16) is differentiated with respect to $\eta_{i}$ and next multiplied by $\widetilde{\pi}_{k}(\eta, \xi)$ to obtain

$$
\widetilde{\pi}_{k}(\eta, \xi)\left(\partial_{\eta_{j}} \tau_{k}(\eta, \xi) \widetilde{A}_{0}(0)+\widetilde{A}_{i}(0)\right) \pi_{k}(\eta, \xi)=0 .
$$

With (2.17), we thus get

$$
\widetilde{\pi}_{k}(\eta, \xi) \widetilde{A}_{i}(0) \pi_{k}(\eta, \xi)=\frac{\partial_{\eta_{i}} \tau_{k}(\eta, \xi)}{\partial_{\xi} \tau_{k}(\eta, \xi)} \widetilde{\pi}_{k}(\eta, \xi) \pi_{k}(\eta, \xi)
$$

which concludes the proof of the lemma.

The following results use the classical Lax Lemma, whose proof is similar to 2.12. The result is recalled here.
Lemma 2.13 ([Lax57]). Let $\alpha=(\tau, \eta, \xi) \in \mathbb{R}^{1+d} \backslash\{0\}$ be a real characteristic frequency and $k$ the integer between 1 and $N$ such that $\tau=\tau_{k}(\eta, \xi)$. Then we have

$$
\pi_{\alpha} L\left(0, \partial_{z}\right) \pi_{\alpha}=X_{\alpha} \pi_{\alpha},
$$

where $X_{\alpha}$ is the vector field associated with $\alpha$ defined by (2.14).
The first lemma below, quite standard, states that the group velocities $\mathbf{v}_{\alpha}$ are bounded. The result presented here is not optimal, considering the constant $C$ can be taken equal to 1 , but it is sufficient for our analysis, and its proof is simpler.
Lemma 2.14. There exists a positive constant $C$ such that, for $k=1 \ldots, N$ and $(\eta, \xi)$ in $\mathbb{R}^{d} \backslash\{0\}$, we have

$$
\left|\nabla_{\eta, \xi} \tau_{k}(\eta, \xi)\right| \leqslant C \sup _{(\eta, \xi) \in \mathbb{S}^{d-1}} \rho(A(\eta, \xi))
$$

where we recall that $A(\eta, \xi)$ has been defined for $(\eta, \xi)$ in $\mathbb{R}^{d} \backslash\{0\}$ in Assumption 2, and where $\rho(A(\eta, \xi))$ refers to the spectral radius of the matrix $A(\eta, \xi)$. Then we denote by $\mathcal{V}^{*}$ the finite quantity

$$
\mathcal{V}^{*}:=C \sup _{(\eta, \xi) \in \mathbb{S}^{d-1}} \rho(A(\eta, \xi))
$$

which bounds the group velocities.
Proof. First note that the quantity $\mathcal{V}^{*}$ is actually finite. Indeed, according to Assumption 2, we have

$$
\rho\left(A\left(\eta^{\prime}, \xi^{\prime}\right)\right)=\max _{k=1, \ldots, N}\left|\tau_{k}\left(\eta^{\prime}, \xi^{\prime}\right)\right|,
$$

and the real functions $\tau_{1}, \ldots, \tau_{N}$ are analytic in $\mathbb{R}^{d} \backslash\{0\}$, and thus bounded on $\mathbb{S}^{d-1}$.
Now let $(\eta, \xi)$ be in $\mathbb{R}^{d} \backslash\{0\}$ and $k$ between 1 and $N$. According to the Lax Lemma 2.13, we have, for $\left(\eta^{\prime}, \xi^{\prime}\right)$ in $\mathbb{S}^{d-1}$,

$$
\pi_{k}(\eta, \xi) A\left(\eta^{\prime}, \xi^{\prime}\right) \pi_{k}(\eta, \xi)=-d \tau_{k}(\eta, \xi) \cdot\left(\eta^{\prime}, \xi^{\prime}\right) \pi_{k}(\eta, \xi)
$$

But since the following equality holds,

$$
\left|\nabla_{\eta, \xi} \tau_{k}(\eta, \xi)\right|=\sup _{\left(\eta^{\prime}, \xi^{\prime}\right) \in \mathbb{S}^{d-1}}\left|d \tau_{k}(\eta, \xi) \cdot\left(\eta^{\prime}, \xi^{\prime}\right)\right|
$$

we obtain

$$
\begin{equation*}
\left|\nabla_{\eta, \xi} \tau_{k}(\eta, \xi)\right| \leqslant\left\|\pi_{k}(\eta, \xi)\right\| \sup _{\left(\eta^{\prime}, \xi^{\prime}\right) \in \mathbb{S}^{d-1}}\left\|A\left(\eta^{\prime}, \xi^{\prime}\right)\right\| \tag{2.18}
\end{equation*}
$$

On an other hand, because of Remark 2.7, there exists a positive constant $C$ such that

$$
\begin{equation*}
\left\|\pi_{k}(\eta, \xi)\right\| \leqslant C, \quad k=1, \ldots, N \tag{2.19}
\end{equation*}
$$

uniformly with respect to $(\eta, \xi)$ in $\mathbb{R}^{d} \backslash\{0\}$. Finally, Assumption 2 claims that the matrix $A\left(\eta^{\prime}, \xi^{\prime}\right)$ is diagonalizable and well-conditioned, so there exists a positive constant $C$ such that

$$
\begin{equation*}
\sup _{\left(\eta^{\prime}, \xi^{\prime}\right) \in \mathbb{S}^{d-1}}\left\|A\left(\eta^{\prime}, \xi^{\prime}\right)\right\| \leqslant C \sup _{\left(\eta^{\prime}, \xi^{\prime}\right) \in \mathbb{S}^{d-1}} \rho\left(A\left(\eta^{\prime}, \xi^{\prime}\right)\right) \tag{2.20}
\end{equation*}
$$

Equations (2.18), (2.19), and (2.20) then lead to the result.
The second result quantitatively links the vector $\widetilde{\pi}_{\alpha} E_{k}(\eta, \xi)$ to the vector $E_{k}(\eta, \xi)$, which will be useful in the following to get a control from below of the first vector. It is mentioned, for its second part, in [CG10].
Lemma 2.15. Let $\alpha=(\tau, \eta, \xi) \in \mathbb{R}^{1+d} \backslash\{0\}$ be a real characteristic frequency and $k$ the integer between 1 and $N$ such that $\tau=\tau_{k}(\eta, \xi)$. Then we have

$$
\widetilde{\pi}_{\alpha} E_{k}(\eta, \xi)=-\partial_{\xi} \tau_{k}(\eta, \xi) A_{d}(0)^{-1} E_{k}(\eta, \xi) .
$$

In particular, if the frequency $\alpha$ is not glancing, the projector $\widetilde{\pi}_{\alpha}$ induces an isomorphism from $\operatorname{Im} \pi_{\alpha}$ to $\operatorname{Im} \widetilde{\pi}_{\alpha}$.

Proof. First the vector $E_{k}(\eta, \xi)$ is decomposed in the basis (2.9) adapted to the decomposition (2.7):

$$
\begin{equation*}
E_{k}(\eta, \xi)=\sum_{j=1}^{N} \lambda_{j} A_{d}(0)^{-1} E_{j}(\eta, \xi), \tag{2.21}
\end{equation*}
$$

so that we have $\widetilde{\pi}_{\alpha} E_{k}(\eta, \xi)=\lambda_{k} A_{d}(0)^{-1} E_{k}(\eta, \xi)$. Thus the aim is to determine the coefficient $\lambda_{k}$. Given that $\pi_{\alpha} E_{k}(\eta, \xi)=E_{k}(\eta, \xi)$, and according to decomposition (2.21), we have

$$
A_{d}(0) \pi_{\alpha} E_{k}(\eta, \xi)=\sum_{j=1}^{N} \lambda_{j} E_{j}(\eta, \xi),
$$

thus

$$
\pi_{\alpha} A_{d}(0) \pi_{\alpha} E_{k}(\eta, \xi)=\lambda_{k} E_{k}(\eta, \xi) .
$$

And we conclude using the Lax Lemma 2.13 which claims that $\pi_{\alpha} A_{d}(0) \pi_{\alpha}=-\partial_{\xi} \tau_{k}(\eta, \xi) \pi_{\alpha}$.
To show that the projector $\widetilde{\pi}_{\alpha}$ induces an isomorphism from $\operatorname{Im} \pi_{\alpha}$ to $\operatorname{Im} \widetilde{\pi}_{\alpha}$, the two spaces $\operatorname{Im} \pi_{\alpha}$ and $\operatorname{Im} \widetilde{\pi}_{\alpha}$ having the same dimension, it is sufficient to prove that the intersection

$$
\operatorname{ker} \widetilde{\pi}_{\alpha} \cap \operatorname{Im} \pi_{\alpha}
$$

is trivial. So we consider a vector $X$ of $\mathbb{C}^{N}$ belonging to this intersection. Because $X$ belongs to $\operatorname{Im} \widetilde{\pi}_{\alpha}$, by definition of the vector $E_{k}(\eta, \xi)$, it writes

$$
X=\lambda E_{k}(\eta, \xi),
$$

where $k$ is the integer between 1 and $N$ such that $\alpha=\left(\tau_{k}(\eta, \xi), \eta, \xi\right)$ and $\lambda \in \mathbb{R}$. According to the previous result, we have

$$
\widetilde{\pi}_{\alpha} X=-\partial_{\xi} \tau_{k}(\eta, \xi) A_{d}(0)^{-1} X
$$

But we also have $\widetilde{\pi}_{\alpha} X=0$ by assumption and $\partial_{\xi} \tau_{k}(\eta, \xi) \neq 0$, the frequency $\alpha$ being nonglancing. We therefore obtain $X=0$, which is the sought result.

We are now in position to describe the decomposition of the stable subspace $E_{-}(\zeta)$ for $\zeta \in \Xi_{0}$, which requires the strict hyperbolicity Assumption 2.

Proposition 2.16 ([Wil96], Proposition 3.4). Consider $\zeta=(\tau, \eta) \in \Xi_{0}$. We denote by $i \xi_{j}(\zeta)$ for $j=1, \ldots, \mathcal{M}(\zeta)$ the distinct eigenvalues of the matrix $\mathcal{A}(\zeta)$, and if $\xi_{j}(\zeta)$ is real, we shall denote by $\alpha_{j}(\zeta):=\left(\tau, \eta, \xi_{j}(\tau, \eta)\right)$ the associated real characteristic frequency. If $\xi_{j}(\zeta)$ is real, we also denote by $k_{j}$ the integer between 1 and $N$ such that $\tau=\tau_{k_{j}}\left(\eta, \xi_{j}(\zeta)\right)$. Then the set $\{1,2, \ldots, \mathcal{M}(\zeta)\}$ decomposes as the disjoint union

$$
\begin{equation*}
\{1,2, \ldots, \mathcal{M}(\zeta)\}=\mathcal{G}(\zeta) \cup \mathcal{R}(\zeta) \cup \mathcal{P}(\zeta) \cup \mathcal{S}(\zeta) \cup \mathcal{N}(\zeta) \tag{2.22}
\end{equation*}
$$

where the sets $\mathcal{G}(\zeta), \mathcal{R}(\zeta), \mathcal{P}(\zeta), \mathcal{S}(\zeta)$ and $\mathcal{N}(\zeta)$ correspond to indexes $j$ such that respectively $\alpha_{j}(\zeta)$ is glancing, $\alpha_{j}(\zeta)$ is incoming, $\operatorname{Im}\left(\xi_{j}(\zeta)\right)$ is positive, $\alpha_{j}(\zeta)$ is outgoing and $\operatorname{Im}\left(\xi_{j}(\zeta)\right)$ is negative.

Then the following decomposition of $E_{-}(\zeta)$ holds

$$
\begin{equation*}
E_{-}(\zeta)=\bigoplus_{j \in \mathcal{G}(\zeta)} E_{-}^{j}(\zeta) \oplus \bigoplus_{j \in \mathcal{R}(\zeta)} E_{-}^{j}(\zeta) \oplus \bigoplus_{j \in \mathcal{P}(\zeta)} E_{-}^{j}(\zeta) \tag{2.23}
\end{equation*}
$$

where for each index $j$, the subspace $E_{-}^{j}(\zeta)$ is precisely described as follows.
i) If $j \in \mathcal{P}(\zeta)$, the space $E_{-}^{j}(\zeta)$ is the generalized eigenspace $\mathcal{A}(\zeta)$ associated with the eigenvalue $i \xi_{j}(\zeta)$.
ii) If $j \in \mathcal{R}(\zeta)$, we have $E_{-}^{j}(\zeta)=\operatorname{ker} L\left(0, \alpha_{j}(\zeta)\right)$, which is of dimension 1 .
iii) If $j \in \mathcal{G}(\zeta)$, we denote by $n_{j}$ the algebraic multiplicity of the imaginary eigenvalue $i \xi_{j}(\zeta)$. For small positive $\gamma$, the multiple eigenvalue $i \xi_{j}(\tau, \eta)$ splits into $n_{j}$ simple eigenvalues, denoted by $i \xi_{j}^{k}(\tau-i \gamma, \eta), k=1, \ldots, n_{j}$, all of nonzero real part. We denote by $\mu_{j}$ the number (independent of $\gamma>0$ ) of the eigenvalues $i \xi_{j}^{k}(\tau-i \gamma, \eta)$ of negative real part. Then $E_{-}^{j}(\zeta)$ is of dimension $\mu_{j}$ and is generated by the vectors $w$ satisfying $[\mathcal{A}(\zeta)-$
$\left.i \xi_{j}(\zeta)\right]^{\mu_{j}} w=0$. Furthermore, if $n_{j}$ is even, $\mu_{j}=n_{j} / 2$ and if $n_{j}$ is odd, $\mu_{j}$ is equal to $\left(n_{j}-1\right) / 2$ or $\left(n_{j}+1\right) / 2$.
Likewise, the unstable subspace $E_{+}(\zeta)$ decomposes as

$$
\begin{equation*}
E_{+}(\zeta)=\bigoplus_{j \in \mathcal{G}(\zeta)} E_{+}^{j}(\zeta) \oplus \bigoplus_{j \in \mathcal{S}(\zeta)} E_{+}^{j}(\zeta) \oplus \bigoplus_{j \in \mathcal{N}(\zeta)} E_{+}^{j}(\zeta) \tag{2.24}
\end{equation*}
$$

with similar description of the subspaces $E_{+}^{j}(\zeta)$. In particular, if the set $\mathcal{G}(\zeta)$ is empty, then

$$
\mathbb{C}^{N}=E_{-}(\zeta) \oplus E_{+}(\zeta)
$$

Remark 2.17. The notation $\xi_{j}(\zeta)$ should not be taken for a function $\xi_{j}$ depending on $\zeta \in$ $\Xi_{0}$. Indeed for example the set $\mathcal{M}(\zeta)$ depends on $\zeta$. However, note that the matrix $\mathcal{A}(\zeta)$ is homogeneous of degree 1 with respect to $\zeta$ in $\Xi_{0}$. Thus the number $\mathcal{M}(\zeta)$ as well as the cardinality of the sets $\mathcal{G}(\zeta), \mathcal{R}(\zeta) \cup \mathcal{S}(\zeta)$ and $\mathcal{P}(\zeta) \cup \mathcal{N}(\zeta)$ do not depend on the direction of $\zeta$ in $\Xi_{0}$. We therefore assume that, $\zeta \in \Xi_{0}$ being fixed, for $\lambda \in \mathbb{R}^{*}$, the indexes $1, \ldots, \mathcal{M}(\lambda \zeta)$ are arranged in a way that, for $j=1, \ldots, \mathcal{M}(\zeta)$, we have

$$
\xi_{j}(\lambda \zeta)=\lambda \xi_{j}(\zeta), \quad \text { so that } \quad \alpha_{j}(\lambda \zeta)=\lambda \alpha_{j}(\zeta)
$$

With this ordering, we note that if for $\zeta \in \Xi_{0}$, the frequency $\alpha_{j}(\zeta)$ is glancing, incoming or outgoing (resp. $\xi_{j}(\zeta)$ is of nonzero imaginary part), i.e. if $j \in \mathcal{G}(\zeta) \cup \mathcal{S}(\zeta) \cup \mathcal{R}(\zeta)$ (resp. $j \in \mathcal{P}(\zeta) \cup \mathcal{N}(\zeta))$, then for $\lambda \in \mathbb{R}^{*}$, the frequency $\alpha_{j}(\lambda \zeta)=\lambda \alpha_{j}(\zeta)$ is still glancing, incoming or outgoing (resp. $\xi_{j}(\lambda \zeta)$ is still of nonzero imaginary part), that is to say $j \in \mathcal{G}(\lambda \zeta) \cup \mathcal{S}(\lambda \zeta) \cup$ $\mathcal{R}(\lambda \zeta)$ (resp. $j \in \mathcal{P}(\lambda \zeta) \cup \mathcal{N}(\lambda \zeta)$ ). More precisely, if $j \in \mathcal{P}(\zeta)$ (resp. $\mathcal{N}(\zeta)$ ), then $j \in \mathcal{N}(-\zeta)$ (resp. $\mathcal{P}(-\zeta))$.
Definition 2.18. Consider $\zeta \in \Xi_{0}$. We say that $\zeta$ is a glancing point and we denote $\zeta \in \mathcal{G}$ if, with notations of Proposition 2.16, there exists an index $j$ between 1 and $\mathcal{M}(\zeta)$ such that $j \in \mathcal{G}(\zeta)$, in other words, if $\zeta$ is such that there exists a real nonzero number $\xi$ such that the frequency $(\zeta, \xi)$ is characteristic and glancing.

An assumption is now made, that helps to prove that the projectors associated with the decomposition (2.23) are bounded uniformly with respect to $\zeta$ in $\Xi_{0}$. This assumption has already been made in [Sar65] and [Wil96].
Assumption 4. For all $k=1, \ldots, N$, and for all $(\underline{\eta}, \underline{\xi}) \in \mathbb{R}^{d} \backslash\{0\}$, we have

$$
\frac{\partial \tau_{k}}{\partial \xi}(\underline{\eta}, \underline{\xi})=0 \quad \Rightarrow \quad \frac{\partial^{2} \tau_{k}}{\partial \xi^{2}}(\underline{\eta}, \underline{\xi}) \neq 0
$$

Remark 2.19. We will see during the proof of the Proposition 2.21 in appendix A that the assumption 4 implies that for all $\zeta$ in $\Xi_{0}$, for all index $j$ in $\mathcal{G}(\zeta)$, we have $n_{j}=2$, using the notations of Proposition 2.16. We deduce that $\mu_{j}=1$ and that the component $E_{-}^{j}(\zeta)$ of the stable subspace $E_{-}(\zeta)$ is of dimension 1 and given by $\operatorname{ker} L\left(0, \alpha_{j}(\zeta)\right)$.
Definition 2.20. For $\zeta \in \Xi_{0}$ and, using the notations of Proposition 2.16, for an index $j$ in $\mathcal{G}(\zeta) \cup \mathcal{R}(\zeta)$, we denote by $\Pi_{-}^{j}(\zeta)$ the projection from $E_{-}(\zeta)$ on the component $E_{-}^{j}(\zeta)$ according to decomposition (2.23).

We also denote by $\Pi_{-}^{e}(\zeta)$ the projection from $E_{-}(\zeta)$ on the elliptic stable component $E_{-}^{e}(\zeta):=$ $\oplus_{j \in \mathcal{P}(\zeta)} E_{-}^{j}(\zeta)$ according to the decomposition (2.23).

Finally, if $\zeta$ is not glancing, that is if the set $\mathcal{G}(\zeta)$ is empty, then according to Proposition 2.16 we have the following decomposition of $\mathbb{C}^{N}$

$$
\begin{equation*}
\mathbb{C}^{N}=\bigoplus_{j \in \mathcal{S}(\zeta)} E_{+}^{j}(\zeta) \oplus \bigoplus_{j \in \mathcal{N}(\zeta)} E_{+}^{j}(\zeta) \oplus \bigoplus_{j \in \mathcal{R}(\zeta)} E_{-}^{j}(\zeta) \oplus \bigoplus_{j \in \mathcal{P}(\zeta)} E_{-}^{j}(\zeta) \tag{2.25}
\end{equation*}
$$

In that case we denote by $\Pi_{\mathbb{C}^{N}}^{e}(\zeta)$ the projection from $\mathbb{C}^{N}$ on the stable elliptic component $E_{-}^{e}(\zeta)$ according to this decomposition.

The following proposition will be a key result in our analysis. It uses in a crucial way the Assumption 4, as well as the strict hyperbolicity Assumption 2.

Proposition 2.21 ([Wil96]). For all $\zeta \in \Xi_{0}$ the projectors $\Pi_{-}^{j}(\zeta)$ for $j$ in $\mathcal{G}(\zeta) \cup \mathcal{R}(\zeta)$, and the projectors $\Pi_{-}^{e}(\zeta)$ are uniformly bounded with respect to $\zeta$ in $\Xi_{0}$.

The proof of this result, omitted in [Wil96] and which requires some work, is postponed until Appendix A.

Thanks to Assumption 4 we are also able to prove the following result, which continues the Lemma 2.15, and establishes a control from below over the normal component of the group velocity, and therefore over the vector $\widetilde{\pi}_{\alpha} E_{k}(\eta, \xi)$ for all $\alpha=\left(\tau_{k}(\eta, \xi), \eta, \xi\right)$, involving the distance from $\left(\tau_{k}(\eta, \xi), \eta\right)$ to the glancing set $\mathcal{G}$. Its proof uses notations and results from the one of Proposition 2.21, and is therefore also skipped until Appendix A.

Lemma 2.22. There exists a positive constant $C>0$ such that, if the real frequency $\alpha=(\tau, \eta, \xi)$ in $\mathbb{R}^{1+d} \backslash\{0\}$ is characteristic, and if $k$ between 1 and $N$ is such that $\tau=\tau_{k}(\eta, \xi)$, then we have

$$
\left|\partial_{\xi} \tau_{k}(\eta, \xi)\right| \geqslant C \frac{\operatorname{dist}((\tau, \eta), \mathcal{G})^{1 / 2}}{|\tau, \eta|^{1 / 2}}
$$

Using Lemma 2.15, we therefore obtain the following estimate

\begin{equation*}
\left|\widetilde{\pi}_{\alpha} E_{k}(\eta, \xi)\right| \geqslant C \frac{\operatorname{dist}((\tau, \eta), \mathcal{G})^{1 / 2}}{|\tau, \eta|^{1 / 2}} \tag{2.26}
\end{equation*}
$$

## 3. Functional framework

3.1. Set of frequencies inside the domain. To define the functional framework that will be used, we need first to determine a priori which frequencies may appear in the solution of (2.1). For a detailed discussion of this analysis, reference is made to [Rau12, Chapters 9 and 10] and [MA88]. The presence on the boundary of the frequencies $\zeta_{1}, \ldots, \zeta_{m}$ creates, by nonlinear interaction, the following group of frequencies on the boundary

$$
\begin{equation*}
\mathcal{F}_{b}:=\zeta_{1} \mathbb{Z}+\cdots+\zeta_{m} \mathbb{Z} \subset \mathbb{R}^{d} \tag{3.1}
\end{equation*}
$$

The assumption is now made that this group does not contain any glancing point, which have been introduced in Definition 2.18.

Assumption 5. We have

$$
\left(\mathcal{F}_{b} \backslash\{0\}\right) \cap \mathcal{G}=\emptyset .
$$

In other words, with the notations of Proposition 2.16, for all $\zeta \in \mathcal{F}_{b} \backslash\{0\}$, the set $\mathcal{G}(\zeta)$ of indexes $j$ between 1 and $\mathcal{M}(\zeta)$ such that the characteristic frequency $\left(\zeta, \xi_{j}(\zeta)\right)$ is glancing, is an empty set.

However, attention must be paid on the fact that despite Assumption 5 , the set $\mathcal{F}_{b} \backslash\{0\}$ may contain frequencies arbitrary close to the set of glancing frequencies $\mathcal{G}$, namely frequencies $\zeta$ admitting a lifting inside the domain $\alpha=\left(\tau_{k}(\eta, \xi), \eta, \xi\right)$ of which the normal component of the group velocity given by $-\partial_{\xi} \tau_{k}(\eta, \xi)$ is arbitrary close to zero. This phenomenon is well illustrated in Example 3.1 of compressible isentropic Euler equations below. In the following, we will need a control on the projectors $\Pi_{\mathbb{C}^{N}}^{e}(\zeta)$ for $\zeta$ in the group $\mathcal{F}_{b} \backslash\{0\}$, defined for $\zeta$ non glancing. Indeed the norm of this projector increases when $\zeta$ gets close to the glancing set $\mathcal{G}$. This is why a small divisor assumption is now made, that gives a control over the distance between $\zeta$ in $\mathcal{F}_{b}$ and $\mathcal{G}$ for large $\zeta$, notably leading to Proposition 6.16 below.
Assumption 6. There exists a real number $a_{1}$ and a positive constant $c$ such that for all $\zeta$ in $\mathcal{F}_{b} \backslash\{0\}$, we have

$$
\operatorname{dist}(\zeta, \mathcal{G}) \geqslant c|\zeta|^{-a_{1}}
$$

The operator $L\left(0, \partial_{z}\right)$ being hyperbolic, the frequencies on the boundary $\zeta \in \mathcal{F}_{b} \backslash\{0\}$ are then lifted inside the domain into frequencies $(\zeta, \xi)$. We will see that the polarization conditions for the leading profile cancel the modes associated with noncharacteristic frequencies. Therefore, since we are interested in bounded solutions, at this point only the incoming and evanescent characteristic frequencies lifted from frequencies on the boundary are created. Assumption 5
is used here to exclude the possibility of creating glancing frequencies $\left(\zeta, \xi_{j}(\zeta)\right)$, that is with $j \in \mathcal{G}(\zeta)$. Thus, at this stage, the set of frequencies $\{0\} \cup \mathcal{F}^{\text {in }} \cup \mathcal{F}^{\text {ev }}$ has been obtained for the leading profile, where the sets $\mathcal{F}^{\text {in }}$ and $\mathcal{F}^{\text {ev }}$ are given by

$$
\begin{equation*}
\mathcal{F}^{\text {in }}:=\left\{\left(\zeta, \xi_{j}(\zeta)\right), \zeta \in \mathcal{F}_{b} \backslash\{0\}, j \in \mathcal{R}(\zeta)\right\}, \quad \mathcal{F}^{\mathrm{ev}}:=\left\{\left(\zeta, \xi_{j}(\zeta)\right), \zeta \in \mathcal{F}_{b} \backslash\{0\}, j \in \mathcal{P}(\zeta)\right\} . \tag{3.2}
\end{equation*}
$$

Apart from exceptional cases, the set $\mathcal{F}^{\text {in }}$ is not finitely generated, which imposes an almostperiodic framework for the normal fast variable.

Interest is now made on resonances that may occur inside the domain. By nonlinear interaction, two frequencies $\alpha_{j_{p}}\left(\zeta_{p}\right)=\left(\zeta_{p}, \xi_{j_{p}}\left(\zeta_{p}\right)\right)$ and $\alpha_{j_{q}}\left(\zeta_{q}\right)=\left(\zeta_{q}, \xi_{j_{q}}\left(\zeta_{q}\right)\right)$ of $\mathcal{F}^{\text {in }}$ may resonate to create a characteristic frequency $\alpha_{j_{r}}\left(\zeta_{r}\right)=\left(\zeta_{r}, \xi_{j_{r}}\left(\zeta_{r}\right)\right)$ in the following way:

$$
n_{p} \alpha_{j_{p}}\left(\zeta_{p}\right)+n_{q} \alpha_{j_{q}}\left(\zeta_{q}\right)=n_{r} \alpha_{j_{r}}\left(\zeta_{r}\right), \quad n_{p}, n_{q}, n_{r} \in \mathbb{Z} \backslash\{0\} .
$$

If the index $j_{r}$ belongs to the set $\mathcal{S}\left(\zeta_{r}\right)$, that is to say if $\alpha_{j_{r}}\left(\zeta_{r}\right)$ is an outgoing real characteristic frequency, a new frequency inside the domain is thus created, which does not already belong to the initial set $\mathcal{F}^{\text {in }}$ defined above. The simplifying assumption that it does not occur is made, so there is no outgoing characteristic frequency created through a resonant triplet. More precisely, we assume that the outgoing and the incoming frequencies do not resonate one with the other. The set of outgoing frequencies $\mathcal{F}^{\text {out }}$ is defined as

$$
\begin{equation*}
\mathcal{F}^{\text {out }}:=\left\{\left(\zeta, \xi_{j}(\zeta)\right), \zeta \in \mathcal{F}_{b} \backslash\{0\}, j \in \mathcal{S}(\zeta)\right\} . \tag{3.3}
\end{equation*}
$$

Assumption 7. i) There does not exist a couple ( $\alpha_{p}, \alpha_{q}$ ) of incoming characteristic frequencies $\mathcal{F}^{\mathrm{in}}$ and a couple of integer $\left(n_{p}, n_{q}\right)$ such that the frequency

$$
n_{p} \alpha_{p}+n_{q} \alpha_{q}
$$

is real, characteristic and outgoing.
ii) There does not exist a couple $\left(\alpha_{p}, \alpha_{q}\right)$ of outgoing characteristic frequencies $\mathcal{F}^{\text {out }}$ and a couple of integer $\left(n_{p}, n_{q}\right)$ such that the frequency

$$
n_{p} \alpha_{p}+n_{q} \alpha_{q}
$$

is real, characteristic and incoming.
Note that if three real characteristic frequencies $\alpha_{p}, \alpha_{q}, \alpha_{r}$ resonate as

$$
n_{p} \alpha_{p}+n_{q} \alpha_{q}=n_{r} \alpha_{r}, \quad n_{p}, n_{q}, n_{r} \in \mathbb{Z},
$$

then according to the previous assumption, the frequencies $\alpha_{p}, \alpha_{q}, \alpha_{r}$ are either all incoming or all outgoing. On an other hand, despite Assumption 7, there may exist a countable infinite number of resonances between incoming frequencies, as it is the case in Example 3.1 of compressible isentropic Euler equations in dimension 2.

At this stage, for a new frequency to be created from $\mathcal{F}^{\text {in }}$, there must exist a resonance between two frequencies of $\mathcal{F}^{\text {in }}$, that creates a real characteristic frequency which does not already belong to $\mathcal{F}^{\text {in }}$. The frequencies in $\mathcal{F}^{\text {in }}$ are incoming, and according to Assumption 7 above, a resonance between two incoming frequencies may only produce an incoming frequency, which already belongs to $\mathcal{F}^{\mathrm{in}}$. There is therefore no new frequency created, and the final set of frequencies inside the domain created by nonlinear interaction on the boundary and lifting inside the domain is given by

$$
\begin{equation*}
\mathcal{F}:=\{0\} \cup\left\{\alpha_{j}(\zeta), \zeta \in \mathcal{F}_{b} \backslash\{0\}, j \in \mathcal{R}(\zeta) \cup \mathcal{P}(\zeta)\right\} . \tag{3.4}
\end{equation*}
$$

We expect for the leading profile of the solution of (2.1) to feature all frequencies in $\mathcal{F}$ created by lifting. It leads to consider, to maintain generality, all frequencies in $\mathcal{F}$. Yet it seems unlikely that the group generated by $\mathcal{F}$ may be finitely generated, which a priori excludes an asymptotic expansion of the solution $u^{\varepsilon}$ in the form of quasi-periodic functions. Following [JMR95] and [CGW11] after, a quasi-periodic framework is nevertheless considered for the tangential fast variables (the group of frequencies on the boundary being finitely generated), but an almostperiodic framework for the normal fast variable is considered. The next subsection is devoted to

that question and describes the functional framework used in this analysis. This part is ended by verifying the different assumptions and assertions made in this subsection for the Example 2.1 of compressible isentropic Euler equations in dimension 2.

Example 3.1. The notations of Example 2.1 and those after are used. The assumptions 5,6 and 7 concern the group of frequencies on the boundary $\mathcal{F}_{b}$, thus adequate frequencies on the boundary must be considered for Example 2.1. To simplify the calculations, we take two frequencies $\zeta^{1}$ and $\zeta^{\delta}$ given by $\zeta^{1}:=\left(c_{0} \eta_{0}, \eta_{0}\right)$ and $\zeta^{\delta}:=\left(c_{0} \delta \eta_{0}, \eta_{0}\right)$, with $\eta_{0}>0$ and $\delta$ an irrational number strictly larger than 1 , so that $\zeta^{1}$ and $\zeta^{\delta}$ are both in the hyperbolic region $\mathcal{H}$. Recall that $c_{0}=c\left(v_{0}\right)>0$ refers to the sound velocity and that the equilibrium $V_{0}=\left(v_{0}, 0, u_{0}\right)$ satisfies $0<u_{0}<c_{0}$. The boundary frequencies lattice $\mathcal{F}_{b}$ is therefore given in this example by

$$
\mathcal{F}_{b}=\left\{\left(c_{0} \eta_{0}(p+\delta q), \eta_{0}(p+q)\right) \mid p, q \in \mathbb{Z}\right\} \subset \mathbb{R}^{2}
$$

We denote by $\zeta_{p, q}:=\left(\tau_{p, q}, \eta_{p, q}\right):=\left(c_{0} \eta_{0}(p+\delta q), \eta_{0}(p+q)\right)$ the frequency of $\mathcal{F}_{b}$ given by $p \zeta^{1}+q \zeta^{\delta}$, for $p, q$ in $\mathbb{Z}$.

A nonzero frequency $\zeta_{p, q}$ is glancing if and only if $\left|\tau_{p, q}\right|=\sqrt{c_{0}^{2}-u_{0}^{2}}\left|\eta_{p, q}\right|$, that is to say if and only if ${ }^{1}$

$$
\begin{equation*}
\frac{p}{q} \in\left\{\frac{\sqrt{1-M^{2}}-\delta}{1-\sqrt{1-M^{2}}}, \frac{-\sqrt{1-M^{2}}-\delta}{1+\sqrt{1-M^{2}}}\right\} \tag{3.5}
\end{equation*}
$$

We have denoted by $M$ the Mach number given by $M:=u_{0} / c_{0}$, belonging to ( 0,1 ). If the two real numbers

$$
\begin{equation*}
K_{-}:=\frac{\sqrt{1-M^{2}}-\delta}{1-\sqrt{1-M^{2}}} \quad \text { et } \quad K_{+}:=\frac{-\sqrt{1-M^{2}}-\delta}{1+\sqrt{1-M^{2}}} \tag{3.6}
\end{equation*}
$$

are irrational, then there does not exist a relation of the form (3.5), and there is therefore no glancing frequency in the group $\mathcal{F}_{b} \backslash\{0\}$. Thus we make the assumption that $K_{-}$and $K_{+}$are irrational, so that the assumption 5 is verified. We may for example take $M=\sqrt{3} / 2$ and $\delta>1$ irrational. We summarize now the different areas where the frequencies $\zeta_{p, q}$ may be, depending on $p$ and $q$. First note that we have $0>K_{+}>K_{-}>-\delta$. Recall that the frequency $\zeta_{p, q}$ is in the hyperbolic region (resp. mixed region) if and only if $\left|\tau_{p, q}\right|>\sqrt{c_{0}^{2}-u_{0}^{2}}\left|\eta_{p, q}\right|$ (resp. $\left.\left|\tau_{p, q}\right|<\sqrt{c_{0}^{2}-u_{0}^{2}}\left|\eta_{p, q}\right|\right)$. We thus infer the classification given in Figure 4. The calculation steps are not detailed, but one case is treated in more details below.

The remark concerning the group velocities that follows Assumption 5 is now illustrated. For that purpose a sequence of frequencies on the boundary that draw near the glancing set is considered, see Figure 5. The real number $K_{+}$given (3.6) being irrational, there exist two sequences $\left(p_{k}\right)_{k}$ and $\left(q_{k}\right)_{k}$ of integers such that for $k \geqslant 0, p_{k}$ and $q_{k}$ are coprime, $q_{k}>0$, and such that

$$
\frac{p_{k}}{q_{k}} \xrightarrow[k \rightarrow+\infty]{>} \frac{-\sqrt{1-M^{2}}-\delta}{1+\sqrt{1-M^{2}}}=K_{+}
$$

Note that since $K_{+}>K_{-}>-\delta$, for all $k \geqslant 0$, we have $p_{k} / q_{k}>K_{-}>-\delta$, so on one hand we have $p_{k}+\delta q_{k}>0$, and on the other hand, independently of the sign of $p_{k}+q_{k}$, we have

[^0]$p_{k}+\delta q_{k}>\sqrt{1-M^{2}}\left|p_{k}+q_{k}\right|$. The frequencies $\zeta_{p_{k}, q_{k}}$ are therefore in the hyperbolic region $\mathcal{H}$ with $\tau>0$, and draw near the glancing region $\mathcal{G}$, see Figure 5 . Since $\tau_{p_{k}, q_{k}}>0$, according to Example 2.11, the last component of the group velocity associated with the frequency on the inside $\alpha_{1}\left(\tau_{p_{k}, q_{k}}, \eta_{p_{k}, q_{k}}\right)$ is given by
\[

$$
\begin{align*}
& \partial_{\xi} \tau_{3}\left(\eta_{p_{k}, q_{k}}, \xi_{1}\left(\tau_{p_{k}, q_{k}}, \eta_{p_{k}, q_{k}}\right)\right) \leqslant \sqrt{\frac{\tau_{p_{k}, q_{k}}^{2}-\eta_{p_{k}, q_{k}}^{2}\left(c_{0}^{2}-u_{0}^{2}\right)}{\eta_{p_{k}, q_{k}}}}  \tag{3.7}\\
& \quad=c_{0} \sqrt{q_{k}\left(1+\sqrt{1-M^{2}}\right) \frac{p_{k}+\delta q_{k}-\left(p_{k}+q_{k}\right)\left(1-M^{2}\right)}{\left(p_{k}+q_{k}\right)^{2}}} \sqrt{\frac{p_{k}}{q_{k}}-\frac{-\sqrt{1-M^{2}}-\delta}{1+\sqrt{1-M^{2}}}} \tag{3.8}
\end{align*}
$$
\]

Note that the quantity under the first square root sign of (3.8) is non negative, since for all $k \geqslant 0, q_{k}>0$ and $p_{k} / q_{k}>K_{-}$, so that $p_{k}+\delta q_{k}-\left(p_{k}+q_{k}\right)\left(1-M^{2}\right)>0$. This quantity being bounded, the quantity (3.8) converges towards zero by construction of the integers ( $p_{k}, q_{k}$ ). We see that the normal group velocity (3.7) of the hyperbolic frequencies $\zeta_{p_{k}, q_{k}}$ converges towards zero as $k$ goes to infinity. It shows that the normal group velocity of the hyperbolic frequencies, although nonzero, may be arbitrary close to zero.


Figure 5. Sequence of frequencies that draw near the glancing region, of which the normal group velocity goes to zero.

Interest is now made on Assumption 7 and into the resonances between real characteristic frequencies. We recall the notations of Example 2.11, and we first determine that, in the hyperbolic region, the eigenvalues $i \xi_{1}(\zeta), i \xi_{2}(\zeta)$ and $i \xi_{3}(\zeta)$, defined by (2.15), are given, for $\zeta=\zeta_{p, q}$ in $\mathcal{F}_{b} \backslash\{0\}$, by

$$
\begin{aligned}
i \xi_{1}\left(\zeta_{p, q}\right) & =i \eta_{0} \frac{M(p+\delta q)+\operatorname{sign}(p+\delta q) \sqrt{(p+q)^{2} M^{2}+2 p q(\delta-1)+q^{2}\left(\delta^{2}-1\right)}}{1-M^{2}} \\
i \xi_{2}\left(\zeta_{p, q}\right) & =i \eta_{0} \frac{M(p+\delta q)-\operatorname{sign}(p+\delta q) \sqrt{(p+q)^{2} M^{2}+2 p q(\delta-1)+q^{2}\left(\delta^{2}-1\right)}}{1-M^{2}} \\
i \xi_{3}\left(\zeta_{p, q}\right) & =-i \eta_{0} \frac{p+\delta q}{M} .
\end{aligned}
$$

The case of the glancing region is excluded by assumption, and the one of the mixed region is included in the following, considering there is in this case only one imaginary eigenvalue, which is the linear eigenvalue $i \xi_{3}(\zeta)$. We first observe that, the eigenvalue $i \xi_{3}\left(\zeta_{p, q}\right)$ begin linear, it generates resonances of the form

$$
\alpha_{3}\left(\zeta_{p, q}\right)+\alpha_{3}\left(\zeta_{r, s}\right)=\alpha_{3}\left(\zeta_{p+r, q+s}\right), \quad \forall p, q, r, s \in \mathbb{Z}
$$

The frequency $\alpha_{3}\left(\zeta_{p, q}\right)$ being always incoming, there are therefore already an infinite number of resonances between incoming frequencies. From now on the notation $\alpha_{1,2}$ refers to one of the characteristic frequency $\alpha_{1}$ or $\alpha_{2}$. Since by linearity of $\alpha_{3}$, the resonance between two frequencies $\alpha_{3}$ and a frequency $\alpha_{1,2}$ is impossible, the two following cases of resonance are still to be investigated:

$$
\alpha_{1,2}\left(\zeta_{p, q}\right)+\alpha_{1,2}\left(\zeta_{r, s}\right)=\alpha_{3}\left(\zeta_{p+r, q+s}\right) \quad \text { et } \quad \alpha_{1,2}\left(\zeta_{p, q}\right)+\alpha_{1,2}\left(\zeta_{r, s}\right)=\alpha_{1,2}\left(\zeta_{p+r, q+s}\right) .
$$

In the first case, it is equivalent to the relation

$$
\begin{align*}
{\left[(p+q)^{2}-(r+s)^{2}\right] M^{8} } & +2\left[(p+q)^{2}-(r+s)^{2}\right]\left(2(r s-p q)(\delta-1)+\left(s^{2}-q^{2}\right)\left(\delta^{2}-1\right)\right) M^{6}  \tag{3.9}\\
& +C_{4}(p, q, r, s, \delta) M^{4}+C_{2}(p, q, r, s, \delta) M^{2}+(p+r+\delta q+\delta s)^{2}=0
\end{align*}
$$

where coefficients $C_{4}(p, q, r, s, \delta)$ and $C_{2}(p, q, r, s, \delta)$ are polynomial in their variables. Two cases may now occur, depending on whether the coefficient in front of $M^{8}$ in equation (3.9) is zero or not.
i) Either we have $(p+q)^{2}-(r+s)^{2} \neq 0$, in which case the equation (3.9) is a polynomial equation of degree 4 in $\mathbb{Q}[\delta]$ satisfied by $M^{2}$.
ii) Or we have $(p+q)^{2}=(r+s)^{2}$, and in this case (3.9) is a polynomial equation of degree at most 2 satisfied by $M^{2}$ in $\mathbb{Q}[\delta]$. If once again the coefficients $C_{4}(p, q, r, s, \delta)$ and $C_{2}(p, q, r, s, \delta)$ in front of $M^{4}$ and $M^{2}$ are zero, then we get $p+r+\delta q+\delta s=0$. Therefore we have $r=-p$ and $s=-q$, that is to say $\zeta_{r, s}=-\zeta_{p, q}$, so the studied resonance is actually self-interaction of $\zeta_{p, q}$ with itself to generate the zero frequency. Thus, if $(p+q)^{2}=(r+s)^{2}$, the only cases of a real resonance are those where $M^{2}$ is a root of a polynomial of degree 1 or 2 in $\mathbb{Q}[\delta]$.
It has therefore been determined that for a resonance of the first type to occur (not of selfinteraction type), then $M^{2}$ needs to be a root of a polynomial of degree at most 4 in $\mathbb{Q}[\delta]$.

For the second type of resonance, such a relation is verified if and if only if the following relation holds

$$
\begin{equation*}
(p s-q r)^{2}\left(1-M^{2}\right)(\delta-1)^{2}=0, \tag{3.10}
\end{equation*}
$$

that is to say, since we have $0<M<1$ and $\delta>1$, if and only if the two frequencies $\zeta_{p, q}$ and $\zeta_{r, s}$ are collinear. Then one may write $\zeta_{p, q}=\lambda \zeta_{t, w}$ and $\zeta_{r, s}=\mu \zeta_{t, w}$, with $\zeta_{t, w}$ a hyperbolic frequency, and $\lambda, \mu$ in $\mathbb{Z}^{*}$. Next verify that, since we have $\operatorname{sign}(\lambda(t-w))=\operatorname{sign}(\lambda) \operatorname{sign}(t-w)$, the two following relations hold $\xi_{1}\left(\lambda \zeta_{t, w}\right)=\lambda \xi_{1}\left(\zeta_{t, w}\right)$ and $\xi_{2}\left(\lambda \zeta_{t, w}\right)=\lambda \xi_{2}\left(\zeta_{t, w}\right)$. The same holds for the two frequencies $\mu \zeta_{t, w}$ and $(\lambda+\mu) \zeta_{t, w}$. The only two resonances that may occur are therefore

$$
\lambda \alpha_{1}\left(\zeta_{t, w}\right)+\mu \alpha_{1}\left(\zeta_{t, w}\right)=(\lambda+\mu) \alpha_{1}\left(\zeta_{t, w}\right) \quad \text { et } \quad \lambda \alpha_{2}\left(\zeta_{t, w}\right)+\mu \alpha_{2}\left(\zeta_{t, w}\right)=(\lambda+\mu) \alpha_{2}\left(\zeta_{t, w}\right),
$$

which both are actually self-interaction of frequencies $\alpha_{1}\left(\zeta_{t, w}\right)$ and $\alpha_{2}\left(\zeta_{t, w}\right)$ with themselves: the evolution of the harmonics $\lambda$ and $\mu$ are coupled with the one of $\lambda+\mu$. In particular, the three frequencies implied in this resonance are either all incoming or all outgoing. Thus, if $M^{2}$ is not a root of a polynomial of degree at most 4 in $\mathbf{Q}[\delta]$, Assumption 7 is verified for the compressible isentropic Euler equations in dimension 2, with the group of frequencies on the boundary that has been considered.

We finally dig into the small divisors Assumption 6. One can check that ${ }^{2}$, depending on the sign of $p, q$, the distance between $\zeta_{p, q}$ and the glancing set $\mathcal{G}$ is given by

\operatorname{dist}\left(\zeta_{p, q}, \mathcal{G}\right)=C\left|(p+\delta q) \pm \sqrt{1-M^{2}}(p+q)\right|=C q\left(1 \pm \sqrt{1-M^{2}}\right)\left|\frac{p}{q}-K_{ \pm}\right|
$$

[^1]If $p$ and $q$ are not of the same size scale, then the same holds of $p+\delta q$ and $p+q$, so the previous distance can be lower bounded by a positive constant. We thus may in the following assume that

C_{1}|p| \leqslant|q| \leqslant C_{2}|p| . \tag{3.11}
\end{equation*}
$$

According to Roth theorem, see [Sch91, Theorem 2A], if the real numbers $K_{+}$and $K_{-}$given by (3.6) are algebraic numbers (and irrational, which has been previously assumed), then they satisfy

$$
\left|K_{ \pm}-\frac{p}{q}\right| \geqslant C|q|^{-(2+\varepsilon)},
$$

for all $q \in \mathbb{N}^{*}, p \in \mathbb{Z}$ and $\varepsilon>0$. So for all $\zeta_{p, q}$ in $\mathcal{F}_{b} \backslash\{0\}$, we get, using (3.11),

\operatorname{dist}\left(\zeta_{p, q}, \mathcal{G}\right) \geqslant C|q|^{-3 / 2} \geqslant C\left|\zeta_{p, q}\right|^{-3 / 2}
$$

and Assumption 6 is therefore verified.
In conclusion, for the compressible isentropic Euler equations in dimension 2 to satisfies Assumptions 5, 6 and 7, it is therefore sufficient that the Mach number $M$ and the parameter $\delta>1$ are such that $K_{+}$and $K_{-}$are irrational algebraic numbers and that $M^{2}$ is not a polynomial solution of degree at most 4 in $\mathbb{Q}[\delta]$. The set of solutions of such equations being countable, one may convince himself that the set of real numbers $M$ satisfying these properties is not empty. On may for example choose $M:=\sqrt{3} / 2$, which gives $K_{-}=1-2 \delta$ and $K_{+}=-(1+2 \delta) / 3$, and also choose $\delta=\sqrt[7]{2}>1$. In this way the real numbers $K_{+}$and $K_{-}$are actually irrational algebraic numbers. On an other hand, a relation of the form (3.9) cannot be satisfied, except for trivial cases on $p, q, r, s$, because one can check that it forms an algebraic equation of degree 4 in $\delta$, which is not an algebraic number of degree 4.
3.2. Spaces of profiles. According to the analysis of which frequencies may appear in the solution of (2.1), we must define for the leading profile a functional framework that allows to consider superposition of waves of the form

$$
a(z) e^{i \alpha \cdot z / \varepsilon},
$$

for $\alpha$ a characteristic frequency in $\mathcal{F}$. Since we choose a quasi-periodic framework for the fast tangential variables, we write such a wave as

$$
a(z) e^{i n_{1} \zeta_{1} \cdot z^{\prime} / \varepsilon} \cdots e^{i n_{m} \zeta_{m} \cdot z^{\prime} / \varepsilon} e^{i \xi x_{d} / \varepsilon}
$$

where $\alpha=(\zeta, \xi)$ with $\zeta=n_{1} \zeta_{1}+\cdots+n_{m} \zeta_{m} \in \mathcal{F}_{b}$ and $\xi \in \mathbb{C}$. Next we denote by $\theta=$ $\left(\theta_{1}, \ldots, \theta_{m}\right) \in \mathbb{T}^{m}$ the fast tangential variables which substitute to $\left(z^{\prime} \cdot \zeta_{1} / \varepsilon, \ldots, z^{\prime} \cdot \zeta_{m} / \varepsilon\right)$ and $\psi_{d} \in \mathbb{R}_{+}$the fast normal variable substituting to $x_{d} / \varepsilon$.

For each integer $s \geqslant 0$ and for $T>0$, we denote by $H_{+}^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ the space of functions of $(t, y, \theta) \in \omega_{T} \times \mathbb{T}^{m}$, zero for negative times $t$, of which all derivatives of order less or equal to $s$ belong to $L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)$.

Now we describe the general space that will contain the oscillating and evanescent profiles spaces. We choose only a uniform control with respect to the fast and slow normal variables since it would be difficult to control derivatives of the leading profile with respect to these two variables.

Definition 3.2. For an integer $s \geqslant 0$ and for $T>0$, we define the space $\mathcal{E}_{s, T}$ as the set of functions $U$ of $\left(z^{\prime}, x_{d}, \theta, \psi_{d}\right) \in \omega_{T} \times \mathbb{R}_{+} \times \mathbb{T}^{m} \times \mathbb{R}_{+}$, bounded continuous with respect to ( $x_{d}, \psi_{d}$ ) in $\mathbb{R}_{+} \times \mathbb{R}_{+}$with values in $H_{+}^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$, equipped with the obvious norm

$$
\|U\|_{\mathcal{E}_{s, T}}:=\sup _{x_{d}>0, \psi_{d}>0}\left\|U\left(., x_{d}, ., \psi_{d}\right)\right\|_{H_{+}^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)} .
$$

We may now introduce the space of oscillating profiles, corresponding to real frequencies $\alpha_{j}(\zeta)$. Following [JMR95], we choose a quasi-periodic framework with respect to $\theta$ and an almostperiodic one with respect to $\psi_{d}$, namely we consider the closure of the space of trigonometric polynomials with respect to $\psi_{d}$ in the space $\mathcal{E}_{s, T}$ of quasi-periodic functions with respect to $\theta$. See [Cor09] for more details about almost-periodic functions with values in a Banach space.

Definition 3.3 ([Cor09]). We call a trigonometric polynomial with respect to $\psi_{d}$ every function $U$ of $\mathcal{E}_{s, T}$ that writes as a finite sum in real numbers $\xi$,

U\left(z, \theta, \psi_{d}\right)=\sum_{\xi} U_{\xi}(z, \theta) e^{i \psi_{d} \xi}
$$

with $U_{\xi}$ in $\mathcal{C}_{b}\left(\mathbb{R}_{x_{d}}^{+}, H_{+}^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)\right)$ for all $\xi$.
The space of oscillating profiles $\mathcal{P}_{s, T}^{\text {osc }}$ is then defined as the closure in $\mathcal{E}_{s, T}$ of the set of trigonometric polynomials with respect to $\psi_{d}$. This space is equipped with the norm of $\mathcal{E}_{s, T}$.

Concerning evanescent profiles, corresponding to frequencies $\alpha_{j}(\zeta)$ with $j \in \mathcal{P}(\zeta)$, we consider quasi-periodic functions with respect to $\theta^{\prime}$. The factors $e^{i \xi \psi_{d}}$ with $\operatorname{Im} \xi>0$ are expressed with an exponential decay in $\psi_{d}$.
Definition 3.4. For $s \geqslant 0$ and $T>0$, the space $\mathcal{P}_{s, T}^{\mathrm{ev}}$ of evanescent profiles is defined as the set of functions $U$ of $\mathcal{E}_{s, T}$, converging to zero in $H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ as $\psi_{d}$ goes to infinity (for every fixed $x_{d} \geqslant 0$ ), that writes

$$
U\left(z, \theta, \psi_{d}\right)=\sum_{\mathbf{n} \in \mathbb{Z}^{m}} U_{\mathbf{n}}\left(z, \psi_{d}\right) e^{i \mathbf{n} \cdot \theta}
$$

and such that for all $\mathbf{n}$ in $\mathbb{Z}^{m}$, there exists a real number $\delta_{\mathbf{n}}>0$ such that the following function

$$
\left(z, \psi_{d}\right) \mapsto e^{\delta_{\mathbf{n}} \psi_{d}} U_{\mathbf{n}}\left(z, \psi_{d}\right)
$$

belongs to the space $\mathcal{C}_{b}\left(\mathbb{R}_{\psi_{d}}^{+} \times \mathbb{R}_{x_{d}}^{+}, H_{+}^{s}\left(\omega_{T}\right)\right)$. The space $\mathcal{P}_{s, T}^{\mathrm{ev}}$ is equipped with the norm of $\mathcal{E}_{s, T}$.
We may now describe the space of profiles, constructed as the sum of an oscillating and an evanescent part.

Definition 3.5. For $T>0$ and $s \geqslant 0$, we define the space of profiles $\mathcal{P}_{s, T}$ of regularity of order $s$ as

$$
\mathcal{P}_{s, T}:=\mathcal{P}_{s, T}^{\mathrm{osc}} \oplus \mathcal{P}_{s, T}^{\mathrm{ev}}
$$

equipped with the obvious norm. If $U$ belongs to $\mathcal{P}_{s, T}$, we denote by $U^{\mathrm{osc}} \in \mathcal{P}_{s, T}^{\mathrm{osc}}$ and $U^{\mathrm{ev}} \in \mathcal{P}_{s, T}^{\mathrm{ev}}$ the profiles such that $U=U^{\mathrm{osc}}+U^{\mathrm{ev}}$.

The proof of the fact that the spaces $\mathcal{P}_{s, T}^{\text {osc }}$ and $\mathcal{P}_{s, T}^{\text {osc }}$ are indeed in a direct sum is presented later, after the introduction of a scalar product used in the proof.

One can find in [JMR95] a partial proof of the following result, that we recall here for the sake of clarity.

Lemma 3.6 ([JMR95, Lemma 6.1.2]). For all $T>0$ and for $s>(d+m) / 2$, the spaces $\mathcal{E}_{s, T}, \mathcal{P}_{s, T}^{\mathrm{osc}}, \mathcal{P}_{s, T}^{\mathrm{ev}}$ and $\mathcal{P}_{s, T}$ are all normed algebras. Furthermore, if $U$ and $V$ decomposes in $\mathcal{P}_{s, T}=\mathcal{P}_{s, T}^{\mathrm{osc}} \oplus \mathcal{P}_{s, T}^{\mathrm{ev}}$ as $U=U^{\mathrm{osc}}+U^{\mathrm{ev}}$ and $V=V^{\mathrm{osc}}+V^{\mathrm{ev}}$, then the oscillating part of the profile $U V$ is given by $U^{\mathrm{osc}} V^{\mathrm{osc}}$ and and its evanescent part by $U^{\mathrm{osc}} V^{\mathrm{ev}}+U^{\mathrm{ev}} V^{\mathrm{osc}}+U^{\mathrm{ev}} V^{\mathrm{ev}}$.

Moreover, for $T>0$ and $s \geqslant 0$, the spaces $\mathcal{E}_{s, T}$ and $\mathcal{P}_{s, T}^{\text {osc }}$ are Banach spaces.
Proof. The algebra properties for $\mathcal{E}_{s, T}$ and $\mathcal{P}_{s, T}^{\mathrm{ev}}$ arise immediately from the one of $H_{+}^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$. The same holds for $\mathcal{P}_{s, T}^{\text {osc }}$ since the set of trigonometric polynomials is stable under multiplication. Finally, this algebra property for $H_{+}^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ shows that if $U$ belongs to $\mathcal{P}_{s, T}^{\text {osc }}$ and $V$ to $\mathcal{P}_{s, T}^{\mathrm{ev}}$, then the product $U V$ belongs to $\mathcal{P}_{s, T}^{\mathrm{ev}}$, so the space $\mathcal{P}_{s, T}$ is also an algebra.

As for them, the completeness properties are obvious.
3.3. Scalar products on the space of oscillating profiles. We now define three scalar products that will be useful in the following, notably to obtain a priori estimates. This part is adapted from [JMR95] to the framework of boundary value problems. We shall use a scalar product with the time variable $t$ fixed (as in [JMR95], which is a priori adapted to the Cauchy problem) as well as a scalar product with the space variable $x_{d}$ fixed, more adapted to the initial boundary problem.

For $U, V$ two functions of $\omega_{T} \times \mathbb{R}_{+} \times \mathbb{T}^{m} \times \mathbb{R}_{+}$, we denote, when the formulas are licit, for $x_{d}>0$,

\begin{equation*}
\langle U \mid V\rangle_{\mathrm{in}}\left(x_{d}\right):=\lim _{R \rightarrow+\infty} \frac{1}{R} \int_{0}^{R}\langle U \mid V\rangle_{L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)}\left(x_{d}, \psi_{d}\right) d \psi_{d} \tag{3.12}
\end{equation*}
$$

for $0<t<T$,

$$
\begin{equation*}
\langle U \mid V\rangle_{\text {out }}(t):=\lim _{R \rightarrow+\infty} \frac{1}{R} \int_{0}^{R}\langle U \mid V\rangle_{L^{2}\left(\mathbb{R}^{d-1} \times \mathbb{R}_{+} \times \mathbb{T}^{m}\right)}\left(t, \psi_{d}\right) d \psi_{d} \tag{3.13}
\end{equation*}
$$

and, if $\mathcal{K}$ is a domain of $\Omega_{T}$ bounded in the $x_{d}$ direction,

$$
\begin{equation*}
\langle U \mid V\rangle_{\mathcal{K}}:=\lim _{R \rightarrow+\infty} \frac{1}{R} \int_{0}^{R}\langle U \mid V\rangle_{L^{2}\left(\mathcal{K} \times \mathbb{T}^{m}\right)}\left(\psi_{d}\right) d \psi_{d} \tag{3.14}
\end{equation*}
$$

The first scalar product is suited to the study of incoming modes when the second one is for the outgoing modes, and the last one will be used to prove the finite velocity propagation of the leading profile oscillating part.

If $U$ and $V$ are trigonometric polynomials of $\mathcal{P}_{s, T}^{\text {osc }}$ of the form ${ }^{3}$

U\left(z, \theta, \psi_{d}\right)=\sum_{\mathbf{n} \in \mathbb{Z}^{m}} \sum_{\xi \in \mathbb{R}} U_{\mathbf{n}, \xi}(z) e^{i \mathbf{n} \cdot \theta} e^{i \xi \psi_{d}}, \quad V\left(z, \theta, \psi_{d}\right)=\sum_{\mathbf{n} \in \mathbb{Z}^{m}} \sum_{\xi \in \mathbb{R}} V_{\mathbf{n}, \xi}(z) e^{i \mathbf{n} \cdot \theta} e^{i \xi \psi_{d}}
$$

then Theorem 3.4 and Remark 4.17 of [Cor09] ensure that the scalar products $\langle U \mid V\rangle_{\text {in }}\left(x_{d}\right)$ and $\langle U \mid V\rangle_{\mathcal{K}}$ are well-defined and satisfies, for $x_{d} \geqslant 0$,

\begin{equation*}
\langle U \mid V\rangle_{\text {in }}\left(x_{d}\right)=(2 \pi)^{m} \sum_{\mathbf{n} \in \mathbb{Z}^{m}} \sum_{\xi \in \mathbb{R}}\left\langle U_{\mathbf{n}, \xi} \mid V_{\mathbf{n}, \xi}\right\rangle_{L^{2}\left(\omega_{T}\right)}\left(x_{d}\right), \tag{3.15}
\end{equation*}
$$

and

$$
\begin{equation*}
\langle U \mid V\rangle_{\mathcal{K}}=(2 \pi)^{m} \sum_{\mathbf{n} \in \mathbb{Z}^{m}} \sum_{\xi \in \mathbb{R}}\left\langle U_{\mathbf{n}, \xi} \mid V_{\mathbf{n}, \xi}\right\rangle_{L^{2}(\mathcal{K})} . \tag{3.16}
\end{equation*}
$$

Indeed, each function $U$ of $\mathcal{P}_{s, T}^{\text {osc }}$ belongs to $L^{2}\left(\mathcal{K} \times \mathbb{T}^{m}\right)$ and their traces with respect to $x_{d}$ belong to $L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ for all $x_{d} \geqslant 0$. If $U$ and $V$ are moreover of compact support with respect to $x_{d}$ and if $s \geqslant 1$, then the traces of $U$ and $V$ with respect to $t$ belong to $L^{2}\left(\mathbb{R}^{d-1} \times \mathbb{R}_{+} \times \mathbb{T}^{m}\right)$, and the same results from [Cor09] ensure that the scalar product $\langle U \mid V\rangle_{\text {out }}(t)$ is well-defined and satisfy, for $t>0$,

$$
\begin{equation*}
\langle U \mid V\rangle_{\text {out }}(t)=(2 \pi)^{m} \sum_{\mathbf{n} \in \mathbb{Z}^{m}} \sum_{\xi \in \mathbb{R}}\left\langle U_{\mathbf{n}, \xi} \mid V_{\mathbf{n}, \xi}\right\rangle_{L^{2}\left(\mathbb{R}^{d-1} \times \mathbb{R}_{+}\right)}(t) . \tag{3.17}
\end{equation*}
$$

In short, the scalar products (3.12) and (3.14) (resp. (3.13)) are well-defined on the space of profiles $\mathcal{P}_{s, T}^{\text {osc }}, s \geqslant 0$ (resp. for profiles of $\mathcal{P}_{s, T}^{\text {osc }}$ with compact support with respect to $x_{d}$ with $s \geqslant 1$ ), and formulas (3.15), (3.16) and (3.17) are satisfied in this case.

The incoming scalar product (3.12) is used to prove the following result.
Lemma 3.7. For all $T>0$, the spaces $\mathcal{P}_{0, T}^{\text {osc }}$ and $\mathcal{P}_{0, T}^{\mathrm{ev}}$ are in direct sum.
Proof. Consider a profile $U$ in $\mathcal{P}_{0, T}^{\text {osc }} \cap \mathcal{P}_{0, T}^{\mathrm{ev}}$ that writes, because it is an oscillating profile,

$$
U\left(z, \theta, \psi_{d}\right)=\sum_{\mathbf{n} \in \mathbb{Z}^{m}} \sum_{\xi \in \mathbb{R}} U_{\mathbf{n}, \xi}(z) e^{i \mathbf{n} \cdot \theta} e^{i \xi \psi_{d}},
$$

the sum in $\xi$ being countable. The profile $U$ also being evanescent, for all $x_{d} \geqslant 0$, the function $\psi_{d} \mapsto U\left(., x_{d}, ., \psi_{d}\right)$ converges to zero in $L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ as $\psi_{d}$ goes to infinity. Thus, for all $x_{d} \geqslant 0$, we have

$$
\langle U \mid U\rangle_{\text {in }}\left(x_{d}\right)=0,
$$

[^2]since the mean value (in terms of (3.12)) of a continuous function on $\mathbb{R}_{+}$converging to zero at infinity is zero. But, since $U$ is an oscillating profile, we have
$$
\langle U \mid U\rangle_{\text {in }}\left(x_{d}\right)=(2 \pi)^{m} \sum_{\mathbf{n} \in \mathbb{Z}^{m}} \sum_{\xi \in \mathbb{R}}\left\|U_{\mathbf{n}, \xi}\right\|_{L^{2}\left(\omega_{T}\right)}^{2}\left(x_{d}\right)
$$
so, for all $\mathbf{n}, \xi$, the function $U_{\mathbf{n}, \xi}\left(x_{d}\right)$ is zero in $L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)$, and the profile $U$ is therefore zero as well.

## 4. Ansatz and main result

We seek to construct an approximate solution of (2.1) under the form of a formal series $u^{\varepsilon, \text { app }}\left(z, z^{\prime} \cdot \zeta_{1} / \varepsilon, \ldots, z^{\prime} \cdot \zeta_{m} / \varepsilon, x_{d} / \varepsilon\right)$, where $u^{\varepsilon, \text { app }}$ is given by

$$
\begin{equation*}
u^{\varepsilon, \text { app }}\left(z, \theta, \psi_{d}\right):=\sum_{k \geqslant 1} \varepsilon^{k} U_{k}\left(z, \theta, \psi_{d}\right), \tag{4.1}
\end{equation*}
$$

with at least $U_{1}$ in $\mathcal{P}_{s, T}$ for some $s \geqslant 0$. As for them, correctors $\left(U_{k}\right)_{k \geqslant 2}$ a priori exhibit frequencies that may not be characteristic. The convergence of the associated series then relies on a small divisor assumption which is different from the previously made small divisor assumption 6. Thus we only consider correctors as formal trigonometric series involving all frequencies in the group $\langle\mathcal{F}\rangle$ generated by the set $\mathcal{F}$.

We are now in place to state the main result of this work. It is placed under Assumptions 1 to 7 , as well as Assumption 8 that will be made further on. We denote by $h$ an integer larger than or equal to $\left(3-a_{1}\right) / 2$ where $a_{1}$ is the real number introduced in the small divisors Assumption 6. Then we denote $s_{0}:=h+(d+m) / 2$.

Theorem 4.1. Let $s$ be an integer such that $s \geqslant s_{0}$. Under previously listed assumptions, there exists a time $T>0$ such that the system (5.10) described below and that governs the evolution of the leading profile in the asymptotic expansion (4.1) admits a unique solution $U_{1}$ in $\mathcal{P}_{s, T}$.

We recall that we have considered a forcing term $G$ in $H^{\infty}\left(\mathbb{R}^{d} \times \mathbb{T}^{m}\right)$, zero for negative times $t$ and of zero mean with respect to $\theta$ in $\mathbb{T}^{m}$, but the infinite regularity assumption is made only for simplicity, and the estimates, and thus the existence time $T$, only depend on the $H^{s}\left(\mathbb{R}^{d} \times \mathbb{T}^{m}\right)$ norm of $G$. More precisely, the existence time $T$ depends on the operator $L\left(0, \partial_{z}\right)$, the frequencies on the boundary $\zeta_{1}, \ldots, \zeta_{m}$, the order of regularity $s$, and the $H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ norm of the forcing term $G$.

The formal WKB study shows that the function

$$
z \mapsto \varepsilon U_{1}\left(z, z^{\prime} \cdot \zeta_{1} / \varepsilon, \ldots, z^{\prime} \cdot \zeta_{m} / \varepsilon, x_{d} / \varepsilon\right)

is formally an approximate solution of the system (2.1).
We start by formally deriving the cascade of equations that must be verified by the amplitudes $\left(U_{k}\right)_{k \geqslant 1}$. By resolving, first formally and then rigorously for a part of it, a fast problem, this cascade is triangularized and a system of equations for the leading profile is extracted from it. After a discussion about the different types of resonances that appear, the system is reduced to two decoupled systems for the oscillating and evanescent parts, the one on the oscillating part involving only the incoming phases. The oscillating system is even decoupled in a system for all resonant modes, and a system for each non-resonant mode. Next a priori estimates are proved for the linearized system for the oscillating parts, leading to the construction of solutions to these linearized systems. Such estimates prove in particular that the solution of (5.10) is unique. An iterative scheme is then used to construct solutions to the nonlinear systems, and the evanescent part is finally determined. Unlike in [JMR95, Part 6], from which the following is mainly inspired, there is no symmetry in the system, since it is not hyperbolic as a propagation system in the variable $x_{d}$. This lack of symmetry is a genuine obstacle to deal with the resonance terms (that are in infinite number) in the a priori estimates. Assumption 8, concerning all resonances with the possible exception of a finite number of them, allows to work around the problem and to obtain estimates for the associated terms. Assumption 8 will be carefully verified for the Euler system.

## 5. Formal WKB study

5.1. Cascade of equations for the profiles. We seek to formally determine the equations the sequence of profiles $\left(U_{n}\right)_{n \geqslant 1}$ must satisfy for the formal series $z \mapsto u^{\varepsilon, \text { app }}\left(z, z^{\prime} \cdot \zeta_{1} / \varepsilon, \ldots, z^{\prime}\right.$. $\left.\zeta_{m} / \varepsilon, x_{d} / \varepsilon\right)$ given by (4.1) to be solution of the system (2.1). In the following we wish for the coefficient (a priori dependent on $u^{\varepsilon, \text { app }}$ ) in factor of the partial derivative with respect to $x_{d}$ to be the identity matrix, so that its differential is zero. The analogous property for the partial derivative in time is crucial in [JMR95] from which we mainly draw our analysis. This choice is justified here by the particular role of the variable $x_{d}$ in a priori estimates for the principal profile. This is why we are interested from now on in the following equivalent system

5.1.1. WKB Cascade inside the domain. We are now able to write the equations verified by the profiles $U_{k}, k \geqslant 1$. First, we note that the following Taylor expansion is verified, for $i=0, \ldots, d-1$ :

For $k \geqslant 2$, despite the fact that only the $U_{k}$ dependency is indicated in the operators $\widetilde{L}_{k}\left(U_{k}, \partial_{z^{\prime}}\right)$, these ones also depend on the profiles $U_{1}, \ldots, U_{k-1}$, via the functions $G_{k-1}^{i}$. The operator $\widetilde{L}_{1}\left(U_{1}, \partial_{z^{\prime}}\right)$ depends however only on $U_{1}$.

We see here the benefit of considering the modified operator $\widetilde{L}\left(u, \partial_{z}\right)$ : there is an $x_{d}$ derivative only in the leading operator $\widetilde{L}\left(0, \partial_{z}\right)$, and not in the other operators $\widetilde{L}_{k}\left(U_{k}, \partial_{z^{\prime}}\right)$. Furthermore, we verify that

The Duhamel's principle then applies separately to $\Pi_{\mathbb{C}^{N}}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta}) U_{\mathbb{C}^{N}}^{\mathrm{ev}}$ and $\left(I-\Pi_{\mathbb{C}^{N}}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta})\right) U_{\mathbb{C}^{N}}^{\mathrm{ev}}$, and the integrals converge since, according to Proposition 6.16 proved in appendix, the matrix $e^{t \mathcal{A}(\mathbf{n} \cdot \boldsymbol{\zeta})} \Pi_{\mathbb{C}^{N}}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta})$ is bounded by a decaying exponential for $t \geqslant 0$, and the matrix $e^{t \mathcal{A}(\mathbf{n} \cdot \zeta)}\left(I-\Pi_{\mathbb{C}^{N}}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta})\right)$ is bounded for $t \leqslant 0$, with estimates depending on the frequency $\mathbf{n} \cdot \boldsymbol{\zeta}$. where projectors $\mathbf{E}$ and $\widetilde{\mathbf{E}^{i}}$ and operator $\mathbf{Q}$ are defined further on. In particular we have

Even if the operator $\mathbf{Q}$ cannot be rigorously defined in the functional framework used here (the issue is essentially the same as in [JMR95] and relies on a small divisor control), the projectors $\mathbf{E}$ and $\widetilde{\mathbf{E}}$, that are the only one involved in the leading profile equations, can be defined in the space $\mathcal{P}_{s, T}$. This result will constitute a part of the following section.
5.3. System of equations satisfied by the leading profile. According to expressions (5.6a) and (5.6b) of the amplitudes $W_{0}$ and $W_{1}$, and using the previous Lemma 5.1, we get the following system of equations for the leading profile $U_{1}$, simply denoted from now on by $U$ :

We note that the leading profile $U_{1}$ is polarized, in the sense that it satisfies the equation (5.10a), so according to Definition (5.9) of the projector $\mathbf{E}$, only the characteristic frequencies occur in its Fourier expansion. We shall see in the next section that the oscillating part $U^{\text {osc }}$ of profile $U$ satisfies the problem

The question is to know whether or not the boundary condition (5.11c) determines on its own the trace $U_{\mid x_{d}=0, \psi_{d}=0}^{\mathrm{osc}}$. As already explained in [CGW11] and [CW17], the answer depends on the existence of a resonance between two incoming frequencies that generates an outgoing frequency. Such a resonance pattern is excluded by Assumption 7. In this case the boundary condition (5.11c) also determines the trace $U_{\mid x_{d}=0, \psi_{d}=0}^{\mathrm{ev}}$, which, according to the polarization conditions, immediately leads to construction of the evanescent part of $U$.

## 6. Construction of the leading profile

We are now in position of constructing the leading profile $U$ solution of the system (5.10). First some notations are introduced and an additional assumption is made, mainly involving the resonances. Then the projectors $\mathbf{E}$ and $\widetilde{\mathbf{E}}^{i}$ are rigorously defined, and it is shown that the mean value and the outgoing part of every solution of (5.10) are zero, which allows to decouple the system. Next a priori estimates on the linearized systems are proved, which are used to prove existence of solutions to these problems, and the convergence of some iterative schemes towards functions constituting the profile $U^{\mathrm{osc}}$. We conclude by determining the evanescent part.
6.1. Resonance coefficient and additional assumption. The sets defined below permit to gather the characteristic frequencies according to collinearity.
Definition 6.1. We consider the subset of $\mathbb{Z}^{m} \backslash\{0\}$, denoted by $\mathcal{B}_{\mathbb{Z}^{m}}$, constituted of all m-tuples of coprime integers of which the first nonzero term is positive:

On can verify that for all $\mathbf{n}$ of $\mathbb{Z}^{m} \backslash\{0\}$, there exists a unique element $\mathbf{n}_{0}$ of $\mathcal{B}_{\mathbb{Z}^{M}}$ and a unique nonzero integer $\lambda$ such that $\mathbf{n}=\lambda \mathbf{n}_{0}$.

Then we introduce the following notation for real characteristic frequencies lifted from frequencies on the boundary.
Definition 6.2. For $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$, we denote by $\mathcal{C}(\mathbf{n})$ the finite set of real numbers $\xi$ such that the frequency $(\mathbf{n} \cdot \boldsymbol{\zeta}, \xi)$ is real and characteristic, namely

We also denote by $\mathcal{C}_{\mathbf{i n}}(\mathbf{n})$ (resp. $\mathcal{C}_{\text {out }}(\mathbf{n})$ ) the set of real numbers $\xi$ such that the frequency $(\mathbf{n} \cdot \boldsymbol{\zeta}, \xi)$ is real, characteristic and incoming (resp. outgoing), namely

with notations of Proposition 2.16.
We recall that according to Assumption 5, there is no glancing frequency in $\mathcal{F}$, so the disjoint union

is satisfied for all $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$. All real characteristic frequencies have been considered here, but there may also exist non-real characteristic frequencies lifted from $\mathbf{n} \cdot \boldsymbol{\zeta}$.

Remark 6.3. One can check that, according to Remark 2.17, the sets $\mathcal{C}, \mathcal{C}_{\text {in }}$ and $\mathcal{C}_{\text {out }}$ are homogeneous of degree 1 . Thus, if $\mathbf{n}$ belongs to $\mathbb{Z}^{m} \backslash\{0\}$ and $\xi$ to $\mathcal{C}(\mathbf{n})$, and if $\mathbf{n}_{0}$ in $\mathcal{B}_{\mathbb{Z}^{m}}$ and $\lambda$ in $\mathbb{Z}^{*}$ are such that $\mathbf{n}=\lambda \mathbf{n}_{0}$, then there exists $\xi_{0}$ in $\mathcal{C}\left(\mathbf{n}_{0}\right)$ such that $\xi=\lambda \xi_{0}$.

We now introduce some notations for the resonances.
Definition 6.4. For $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$ and $\xi$ in $\mathcal{C}(\mathbf{n})$, we denote by $E(\mathbf{n}, \xi)$ the vector of the basis $E_{1}, \ldots, E_{N}$ of $\mathbb{C}^{N}$ given by (2.8) that generates the linear line $\operatorname{ker} L(0,(\mathbf{n} \cdot \boldsymbol{\zeta}, \xi))$.
Remark 6.5. Note that for $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}, \xi$ in $\mathcal{C}(\mathbf{n})$ and $\lambda$ in $\mathbb{Z}^{*}$, since the linear subspaces $\operatorname{ker} L(0,(\mathbf{n} \cdot \boldsymbol{\zeta}, \xi))$ and $\operatorname{ker} L(0,(\lambda \mathbf{n} \cdot \boldsymbol{\zeta}, \lambda \xi))$ are equal, we infer $E(\mathbf{n}, \xi)=E(\lambda \mathbf{n}, \lambda \xi)$, so the vector $E(\mathbf{n}, \xi)$ is homogeneous of degree 0 .

The following definition is based on [Rau12, Chapter 11].
Definition 6.6. Let $\mathbf{n}_{p}, \mathbf{n}_{q}$ be two elements of $\mathbb{Z}^{m} \backslash\{0\}$, and let $\left(\xi_{p}, \xi_{q}\right)$ in $\mathcal{C}\left(\mathbf{n}_{p}\right) \times \mathcal{C}\left(\mathbf{n}_{q}\right)$ be such that the frequency

is real and characteristic (i.e. such that there is a resonance). Then the resonance coefficient $\bar{\Gamma}\left(\left(\mathbf{n}_{p}, \xi_{p}\right),\left(\mathbf{n}_{q}, \xi_{q}\right)\right)$ is defined by the equation

This coefficient exists by definition of the projectors $\widetilde{\pi}_{k}$, for $k=1, \ldots, N$ and according to Lemma 2.15.

Remark 6.7. i) Since all quantities involved in the definition of $\Gamma$ are homogeneous of degree 0 or 1 , the coefficient $\Gamma$ is homogeneous of 1 , i.e. for all $\mathbf{n}_{p}, \mathbf{n}_{q}$ in $\mathbb{Z}^{m} \backslash\{0\},\left(\xi_{p}, \xi_{q}\right)$ in $\mathcal{C}\left(\mathbf{n}_{p}\right) \times \mathcal{C}\left(\mathbf{n}_{q}\right)$ such that the frequency $\left(\mathbf{n}_{p} \cdot \boldsymbol{\zeta}, \xi_{p}\right)+\left(\mathbf{n}_{q} \cdot \boldsymbol{\zeta}, \xi_{q}\right)$ is characteristic (that is such that there is a resonance) and for all $\lambda$ in $\mathbb{Z}^{*}$, we have

By definition and for the same reason, we also have, for $\mathbf{n}_{0}$ in $\mathbb{Z}^{m} \backslash\{0\}$ and $\xi_{0}$ in $\mathcal{C}\left(\mathbf{n}_{0}\right)$, and for $\lambda_{1}, \lambda_{2}$ in $\mathbb{Z}^{*}$,

ii) Since according to Remark 2.7 the projectors $\widetilde{\pi}_{\alpha}$ are bounded and the vectors $E(\mathbf{n}, \xi)$ are of norm 1, for all $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$ and all $\xi$ in $\mathcal{C}(\mathbf{n})$, we have

Therefore, according to the lower bound (2.26) of Lemma 2.22 and the small divisors Assumption 6 , for all $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$ and all $\xi$ in $\mathcal{C}(\mathbf{n})$, we have

iii) The quantity $\widetilde{\pi}_{\left(\mathbf{n}_{r} \cdot \zeta, \xi_{r}\right)} \widetilde{L}_{1}\left(E\left(\mathbf{n}_{p}, \xi_{p}\right), \mathbf{n}_{q} \cdot \boldsymbol{\zeta}\right) E\left(\mathbf{n}_{q}, \xi_{q}\right)$ being homogeneous of degree 1 with respect to $\mathbf{n}_{q}$, the resonance coefficient $\Gamma\left(\left(\mathbf{n}_{p}, \xi_{p}\right),\left(\mathbf{n}_{q}, \xi_{q}\right)\right)$ formally corresponds to a partial derivative with respect to the fast tangential variables, applied to the profile associated with the frequency $\left(\mathbf{n}_{q} \cdot \zeta, \xi_{q}\right)$.

The coefficients $\Gamma$ defined above shall appear in the computations to obtain a priori estimates for the system (5.10). In particular, when these coefficients present some symmetry property, the associated resonance is easy to control in the a priori estimates. Thus we discriminate the resonances satisfying this symmetry property from the others.

Definition 6.8. Fix a constant $C_{0}>0$. Let $\mathbf{n}_{r}$ be in $\mathcal{B}_{\mathbb{Z}^{m}}$, and $\xi_{r}$ in $\mathcal{C}\left(\mathbf{n}_{r}\right)$. We consider the set of 7-tuples $\left(\lambda_{p}, \lambda_{q}, \lambda_{r}, \mathbf{n}_{p}, \mathbf{n}_{q}, \xi_{p}, \xi_{q}\right)$ with $\lambda_{p}, \lambda_{q}, \lambda_{r}$ in $\mathbb{Z}^{*}, \mathbf{n}_{p}, \mathbf{n}_{q}$ in $\mathcal{B}_{\mathbb{Z}^{m}}$, $\left(\xi_{p}, \xi_{q}\right)$ in $\mathcal{C}\left(\mathbf{n}_{p}\right) \times \mathcal{C}\left(\mathbf{n}_{q}\right)$, $\left(\mathbf{n}_{p} \cdot \boldsymbol{\zeta}, \xi_{p}\right)$ and $\left(\mathbf{n}_{q} \cdot \boldsymbol{\zeta}, \xi_{q}\right)$ non collinear and $\lambda_{p}, \lambda_{q}, \lambda_{r}$ coprime numbers, that resonate to give the resonance $\lambda_{r}\left(\mathbf{n}_{r} \cdot \boldsymbol{\zeta}, \xi\right)$ in the following way

where the sets $\mathcal{R}_{1}\left(\mathbf{n}_{r}, \xi_{r}\right)$ and $\mathcal{R}_{2}\left(\mathbf{n}_{r}, \xi_{r}\right)$ are defined as follows.
i) The set $\mathcal{R}_{1}\left(\mathbf{n}_{r}, \xi_{r}\right)$ is constituted of 7-tuples $\left(\lambda_{p}, \lambda_{q}, \lambda_{r}, \mathbf{n}_{p}, \mathbf{n}_{q}, \xi_{p}, \xi_{q}\right)$ satisfying

where $C_{0}>0$ is the constant which have been fixed in the beginning and which does not depend on $\lambda_{p}, \lambda_{q}, \lambda_{r}, \mathbf{n}_{p}, \mathbf{n}_{q}, \mathbf{n}_{r}, \xi_{p}, \xi_{q}, \xi_{r}$. These resonances are said to be of type 1.
ii) The 7-tuples $\left(\lambda_{p}, \lambda_{q}, \lambda_{r}, \mathbf{n}_{p}, \mathbf{n}_{q}, \xi_{p}, \xi_{q}\right)$ which do not satisfy the previous property constitute the set of type 2 resonances, denoted by $\mathcal{R}_{2}\left(\mathbf{n}_{r}, \xi_{r}\right)$.

Remark 6.9. i) Note that the sets $\mathcal{R}_{1}(\mathbf{n}, \xi)$ and $\mathcal{R}_{2}(\mathbf{n}, \xi)$ depend on the constant $C_{0}>0$ fixed at the beginning, although this dependence is not indicated.
ii) According to Assumption 7, note that if the frequency ( $\mathbf{n} \cdot \boldsymbol{\zeta}, \xi$ ) is outgoing (resp.incoming), then both sets $\mathcal{R}_{1}(\mathbf{n}, \xi)$ and $\mathcal{R}_{2}(\mathbf{n}, \xi)$ are constituted only of 7 -tuples corresponding to outgoing (resp. incoming) frequencies.
iii) Note that since the coefficients $\Gamma$ are not symmetrical, the type of a resonance

is of type 1 if and only if the resonance

is of type 1 .
iv) Also note that if a resonance of the form

holds, then for $k$ in $\mathbb{Z}^{*}$, the following resonance relation is also satisfied

This explains the choice made in Definition 6.8 to consider only 3-tuples $\left(\lambda_{p}, \lambda_{q}, \lambda_{r}\right)$ of coprime integers and $m$-tuples $\mathbf{n}_{p}, \mathbf{n}_{q}$ and $\mathbf{n}_{r}$ of $\mathcal{B}_{\mathbb{Z}^{m}}$.

The previous definition leads to the last assumption of this work.
Assumption 8. There exists a constant $C_{0}>0$ such that the sets $\mathcal{R}_{1}(\mathbf{n}, \xi)$ and $\mathcal{R}_{2}(\mathbf{n}, \xi)$, for $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$ and $\xi$ in $\mathcal{C}(\mathbf{n})$, defined in Definition 6.8 satisfy the two following properties.
a) The sets of incoming resonances of type 2 and outgoing resonances of types 1 and 2

are finite sets.
b) For all incoming frequency $(\mathbf{n}, \xi)$ of $\mathcal{B}_{\mathbb{Z}^{m}} \times \mathcal{C}_{\mathrm{in}}(\mathbf{n})$ such that the set $\mathcal{R}_{1}(\mathbf{n}, \xi)$ is nonempty, the following lower bound holds

Remark 6.10. i) The self-interaction between two collinear frequencies always constitute a resonance, but these terms should not be an issue in the analysis, since they induce terms of Burgers type, which are commonly treated in the estimates. However the resonances of type 2 are difficult to control, that is why a finiteness assumption is made on this set, whereas the property (6.4) satisfied by resonances of type 1 allows to treat an infinite number of them (to the prize of a uniform control). Such an infinity of resonances appears irremediably in Example 2.1 of compressible isentropic Euler equations in dimension 2. It constitute one of the main additional difficulty addressed here in comparison to the monophase case of [CGW11].
ii) We already know that for $(\mathbf{n}, \xi)$ in $\mathcal{B}_{\mathbb{Z}^{m}} \times \mathcal{C}(\mathbf{n})$, the vector $\widetilde{\pi}_{(\mathbf{n} \cdot \zeta, \xi)} E(\mathbf{n}, \xi)$ is bounded, according to Remark 2.7, and that it goes to zero in a controlled way, according to estimate (2.26) and Assumption 6. In the case of an infinite number of resonances, namely for incoming resonances of type 1 , we also need to make sure that these vectors do not go to zero, for a technical reason explained below. This is why the uniform lower bound Assumption (6.5) is made. This assumption excludes the possibility of the existence of a sequence of frequencies $(\mathbf{n}, \xi)$ such that $\mathcal{R}_{1}(\mathbf{n}, \xi)$ is nonempty, converging to the glancing set $\mathcal{G}$.

According to Assumption 7, it has already been established that the sets of incoming and outgoing frequencies $\mathcal{F}^{\text {in }}$ and $\mathcal{F}^{\text {out }}$ defined in (3.2) and (3.3) do not resonate with each other. This decomposition of the frequencies set in sets that do not resonate with each other is now to be refined, which will allow to decouple the studied system according to these sets.

Definition 6.11. In this definition we confuse the frequency $(\mathbf{n} \cdot \boldsymbol{\zeta}, \xi)$ with the couple $(\mathbf{n}, \xi)$. Let $C_{0}>0$ be the constant fixed in Assumption 8. We denote by $\mathcal{F}_{\text {res }}^{\text {out }}$ the set of outgoing frequencies $(\mathbf{n}, \xi)$ of $\mathcal{B}_{\mathbb{Z}^{m}} \times \mathcal{C}_{\text {out }}(\mathbf{n})$ involved in resonances of type 1 or 2 , namely such that $\mathcal{R}_{1}(\mathbf{n}, \xi) \cup \mathcal{R}_{2}(\mathbf{n}, \xi)$ is nonempty. Then the following disjoint union holds

where the set involved in the disjoint union do not resonate with each other. The set $\mathcal{F}_{\mathrm{res}}^{\mathrm{in}}$ is defined in a similar way for incoming frequencies, so that the following decomposition holds

where the set involved in the disjoint union do not resonate with each other.
Remark 6.12. In Assumption 8, the bound (6.5) a priori applies to couples ( $\mathbf{n}, \xi$ ) such that the set $\mathcal{R}_{1}(\mathbf{n}, \xi)$ is nonempty. But since according to Assumption 8 there is only a finite number of type 2 resonances, we can assume without loss of generality that this bound also applies to couples $(\mathbf{n}, \xi)$ such that $\mathcal{R}_{1}(\mathbf{n}, \xi)$ is empty but $\mathcal{R}_{2}(\mathbf{n}, \xi)$ is not, namely to all elements of $\mathcal{F}_{\text {res }}^{\text {in }}$. Therefore for all $(\mathbf{n}, \xi)$ in $\mathcal{F}_{\text {res }}^{\text {in }}$, the following bound holds

Note that the previous estimate differs from (6.3) by a linear control and not an algebraic control of degree $h$.

Finally the projectors analogous to $\mathbf{E}$ and $\widetilde{\mathbf{E}^{i}}$, selecting only the resonant frequencies, are defined, and we verify after that Assumption 8 for the Euler equations example considered in this paper.

Example 6.14. We return to Example 2.1 of compressible isentropic Euler equations in dimension 2 , for which we check the last assumption of this work, namely Assumption 8 about the control of resonances. Recall the notations and results of Example 2.1 and those after, and notably the analysis of the resonances made in Example 3.1, and consider a Mach number $M$ satisfying the previously made assumptions. Is has been shown that if $M^{2}$ is not an algebraic number of degree less than 4 in $\mathbb{Q}[\delta]$, then the only resonances (except for the self-interactions) occurring are those involving the linear frequency $\alpha_{3}(\zeta)$, which are in infinite number, even with collinearity, and between incoming frequencies. It will be shown that there exists a constant $C_{0}>0$ such that these resonances satisfy the property (6.4) and such that all frequencies $\alpha_{3}\left(\zeta_{p, q}\right)$ satisfy the lower bound (6.5), proving that the system (2.4) verifies Assumption 8. First we look for the coefficients $\Gamma$ for this type of resonances. Consider $(p, q)$ and $(r, s)$ in $\mathbb{Z}^{2} \backslash\{0\}$. The aim is to determine the coefficient

Also computing the vectors $E_{1}(\eta, \xi)$ and $E_{3}(\eta, \xi)$ for $(\eta, \xi) \in \mathbb{R}^{2} \backslash\{0\}$, it is determined that the projector $\widetilde{\pi}_{\left((p+r, q+s) \cdot \zeta, \xi_{3}\left(\zeta_{p+r, q+s)}\right)\right.}$ occurring in the coefficient $\Gamma((p, q),(r, s))$ is given in this
example by $\widetilde{\pi}_{2}\left(\eta_{p+r, q+s}, \xi_{3}\left(\zeta_{p+r, q+s}\right)\right)$ where, for $(\eta, \xi)$ in $\mathbb{R}^{2} \backslash\{0\}$,

Thus the vector $\widetilde{\pi}_{2}(\eta, \xi) E_{2}(\eta, \xi)$ is given by $u_{0} A_{2}\left(V_{0}\right)^{-1} E_{2}(\eta, \xi)$, for $(\eta, \xi)$ in $\mathbb{R}^{2} \backslash\{0\}$. It ensures in particular that Assumption 8 is verified, since the following uniform lower bound holds

We now check the estimate (6.4) with these coefficients. Let $(p, q),(r, s)$ and $(t, w)$ be in $\mathbb{Z}^{2} \backslash\{0\}$ such that $(p, q)+(r, s)+(t, w)=(0,0)$. One can verify, using the formulas $\tau_{p, q}=$ $c_{0}(p+\delta q) \eta_{0}, \eta_{p, q}=(p+q) \eta_{0}, p+r=-t$ and $q+s=-w$, that we get

so estimate (6.4) is in particular trivially satisfied and therefore so is Assumption 8. Note that in this example, the set $\mathcal{F}_{\text {res }}^{\text {out }}$ is empty and the set $\mathcal{F}_{\text {res }}^{\text {in }}$ is given by

It concludes the analysis in this paper of the example of compressible isentropic Euler equations in dimension 2 , which, with the chosen parameters, satisfies all assumptions of this work.

Remark 6.15. Note that the coefficient $\Gamma$ determined above corresponds to the one in [Rau12, (11.5.9)].

In the following subsection, some rigorous results on projectors $\mathbf{E}$ and $\widetilde{\mathbf{E}^{i}}$ will be proved, using the small divisors Assumption 6.
6.2. Rigorous definition of projectors $\mathbf{E}, \widetilde{\mathbf{E}^{i}}, \mathbf{E}_{\mathrm{res}}^{\mathrm{in}}$ and $\widetilde{\mathbf{E}^{i}}{ }_{\mathrm{res}}^{\mathrm{in}}$. This part follows [JMR95, Section 6.2]. Before considering the projectors $\mathbf{E}, \widetilde{\mathbf{E}^{i}}, \mathbf{E}_{\text {res }}^{\text {in }}$ and $\widetilde{\mathbf{E}^{i}}{ }_{\text {res }}^{\text {in }}$, we state the following controls over spectral projectors, that will be used to rigorously define the projectors $\mathbf{E}$ and $\mathbf{E}_{\mathrm{res}}^{\mathrm{in}}$. The proof of these controls uses notations and results from the one of Proposition 2.21, and is therefore postponed after it, in Appendix A.

Proposition 6.16. Under Assumption 6, there exists a constant $c_{1}>0$ and a real number $b_{1}$ such that, for all $\zeta$ in $\mathcal{F}_{b} \backslash\{0\}$, the following estimates hold

\left|e^{t \mathcal{A}(\zeta)} \Pi_{-}^{e}(\zeta)\right| \leqslant c_{1} e^{-c_{1} t|\zeta|^{-b_{1}}} \leqslant c_{1}, & \forall t \geqslant 0 \\
\left|e^{t \mathcal{A}(\zeta)} \Pi_{\mathbb{C}^{N}}^{e}(\zeta)\right| \leqslant c_{1}|\zeta|^{b_{1}} e^{-c_{1} t|\zeta|^{-b_{1}}}, & \forall t \geqslant 0 \\
\left|e^{t \mathcal{A}(\zeta)}\left(I-\Pi_{\mathbb{C}^{N}}^{e}(\zeta)\right)\right| \leqslant c_{1}|\zeta|^{b_{1}}, & \forall t \leqslant 0 \tag{6.12c}
\end{array}
$$

We are now in position to rigorously define projectors $\mathbf{E}$ and $\widetilde{\mathbf{E}^{i}}$. The result concerning the oscillating part comes from [JMR95, Proposition 6.2.1] and [CGW11, Proposition 2.2], but the proof is recalled here. The result concerning the evanescent part is simpler, and reduces to prove that some series converges.
Lemma 6.17 ([JMR95, Proposition 6.2.1]). For all $T>0$ and $s \geqslant 0$, the projectors $\widetilde{\mathbf{E}^{i}}$ and $\mathbf{E}$ defined by (5.8) and (5.9) on the space of trigonometric polynomials each admit a unique extension from the space $\mathcal{P}_{s, T}^{\mathrm{osc}}$ to itself. Moreover, for $T_{0}>0$, their norm is uniformly bounded with respect to $T$ in $] 0, T_{0}$ ].

On an other hand, for $T>0$ and $s \geqslant 0$, the projector $\mathbf{E}$ is well-defined from the space $\mathcal{P}_{s+\left\lceil b_{1}\right\rceil, T}^{\mathrm{ev}}$ to the space $\mathcal{P}_{s, T}^{\mathrm{ev}}$. Furthermore it is uniformly bounded with respect to $s$ and $T$. Recall that $b_{1}$ refers to the real number of Proposition 6.16.

Finally, for $T>0$ and $s \geqslant 0$, the projectors $\widetilde{\mathbf{E}^{i}}{ }_{\text {res }}^{\text {in }}$ and $\mathbf{E}_{\mathrm{res}}^{\mathrm{in}}$ defined as (6.9) and (6.10) on the space of trigonometric polynomials each admit a unique extension from the space $\mathcal{P}_{s, T}$ to itself. Moreover, for $T_{0}>0$, their norm is uniformly bounded with respect to $T$ in $] 0, T_{0}$ ].

Proof. First the oscillating case is investigated. We consider $U^{\text {osc }}$ a trigonometric polynomial writing

U^{\mathrm{osc}}\left(z, \theta, \psi_{d}\right)=\sum_{\mathbf{n} \in \mathbb{Z}^{m}} \sum_{\xi \in \mathbb{R}} U_{\mathbf{n}, \xi}^{\mathrm{osc}}(z) e^{i \mathbf{n} \cdot \theta} e^{i \xi \psi_{d}}
$$

where each sum in $\xi$ is finite, and we denote, for $\mathbf{n} \in \mathbb{Z}^{m}$,

$$
\begin{equation*}
U_{\mathbf{n}}^{\mathrm{osc}}\left(z, \psi_{d}\right):=\sum_{\xi} U_{\mathbf{n}, \xi}^{\mathrm{osc}}(z) e^{i \xi \psi_{d}} \tag{6.13}
\end{equation*}
$$

According to the formula (5.9) for the projector $\mathbf{E}$ and since the projectors $\pi_{\alpha}$ are zero for every noncharacteristic frequency $\alpha$, we obtain, for $\mathbf{n} \in \mathbb{Z}^{m}$,

$$
\mathbf{E} U_{\mathbf{n}}^{\mathrm{osc}}\left(z, \psi_{d}\right)=\sum_{\xi \in \mathcal{C}(\mathbf{n})} \pi_{(\mathbf{n} \cdot \zeta, \xi)} U_{\mathbf{n}, \xi}^{\mathrm{osc}}(z) e^{i \xi \psi_{d}}
$$

so that, according to Remark 2.7 ensuring that the projectors $\pi_{\alpha}$ are uniformly bounded,

$$
\left|\mathbf{E} U_{\mathbf{n}}^{\mathrm{osc}}\left(z, \psi_{d}\right)\right|^{2} \leqslant C N \sum_{\xi \in \mathcal{C}(\mathbf{n})}\left|U_{\mathbf{n}, \xi}^{\mathrm{osc}}(z)\right|^{2}
$$

On an other hand, according to (6.13), for $\mathbf{n}$ in $\mathbb{Z}^{m}$ and $\xi$ in $\mathbb{R}$, we have

U_{\mathbf{n}, \xi}^{\mathrm{osc}}(z)=\lim _{R \rightarrow+\infty} \frac{1}{R} \int_{0}^{R} U_{\mathbf{n}}^{\mathrm{osc}}\left(z, \psi_{d}\right) e^{-i \xi \psi_{d}} d \psi_{d},
$$

so that, using Cauchy-Schwarz inequality,

\left|\mathbf{E} U_{\mathbf{n}}^{\mathrm{osc}}\left(z, \psi_{d}\right)\right|^{2} \leqslant C N^{2} \lim _{R \rightarrow+\infty} \frac{1}{R} \int_{0}^{R}\left|U_{\mathbf{n}}^{\mathrm{osc}}\left(z, \psi_{d}\right)\right|^{2} d \psi_{d}
$$

Then Fatou's lemma is applied to the sum with respect to $\mathbf{n}$ in $\mathbb{Z}^{m}$ and the integration with respect to $z^{\prime}$ in $\omega_{T}$ to get

\sum_{\mathbf{n} \in \mathbb{Z}^{m}}\left\|\mathbf{E} U_{\mathbf{n}}^{\mathrm{osc}}\left(., x_{d}, \psi_{d}\right)\right\|_{L^{2}\left(\omega_{T}\right)}^{2} \leqslant C N^{2} \liminf _{R \rightarrow+\infty} \frac{1}{R} \int_{0}^{R} \sum_{\mathbf{n} \in \mathbb{Z}^{m}}\left\|U_{\mathbf{n}}^{\mathrm{osc}}\left(., x_{d}, \psi_{d}\right)\right\|_{L^{2}\left(\omega_{T}\right)}^{2} d \psi_{d}
$$

thus

$$
\left\|\mathbf{E} U\left(., x_{d}, ., \psi_{d}\right)\right\|_{L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)}^{2} \leqslant C N^{2} \sup _{\psi_{d}>0}\left\|U^{\mathrm{osc}}\left(., x_{d}, ., \psi_{d}\right)\right\|_{L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)}^{2},
$$

that is to say

$$
\|\mathbf{E} U\|_{\mathcal{E}_{0, T}} \leqslant \sqrt{C} N\|U\|_{\mathcal{E}_{0, T}}
$$

The projector $\mathbf{E}$ thus admits a uniformly bounded unique extension from $\mathcal{P}_{0, T}$ to $\mathcal{P}_{0, T}$. The result for the space $\mathcal{P}_{s, T}$ for $s \geqslant 1$ is obtained by observing that the projector $\mathbf{E}$ commutes with the partial derivatives with respect to $z^{\prime}$ and $\theta$. The same argument applies to the projector $\widetilde{\mathbf{E}^{i}}$, which concludes the proof relative to the oscillating part.

Concerning the evanescent part of $\mathbf{E}$, it must be proved that if $U^{\mathrm{ev}}$ writing

U^{\mathrm{ev}}\left(z, \theta, \psi_{d}\right)=\sum_{\mathbf{n} \in \mathbb{Z}^{m}} U_{\mathbf{n}}^{\mathrm{ev}}\left(z, \psi_{d}\right) e^{i \mathbf{n} \cdot \theta}
$$

belongs to $\mathcal{P}_{s+\left\lceil b_{1}\right\rceil, T}^{\mathrm{ev}}$, then $\mathbf{E} U^{\mathrm{ev}}$ is in $\mathcal{P}_{s, T}^{\mathrm{ev}}$. By definition of the norm of $\mathcal{E}_{s, T}$ and according to the Parseval's identity, we obtain

\begin{aligned}
\left\|\mathbf{E} U^{\mathrm{ev}}\right\|_{\mathcal{E}_{s, T}}^{2} & =\sup _{x_{d}>0, \psi_{d}>0} \sum_{\mathbf{n} \in \mathbb{Z}^{m} \backslash\{0\}} \sum_{l=0}^{s}\left(1+|\mathbf{n}|^{2}\right)^{s-l}\left\|e^{\psi_{d} \mathcal{A}(\mathbf{n} \cdot \zeta)} \Pi_{\mathbb{C}^{N}}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta}) U_{\mathbf{n}}^{\mathrm{ev}}(., 0)\right\|_{H_{+}^{l}\left(\omega_{T}\right)}^{2} \\
& \leqslant \sup _{x_{d}>0, \psi_{d}>0} \sum_{\mathbf{n} \in \mathbb{Z}^{m} \backslash\{0\}} \sum_{l=0}^{s}\left(1+|\mathbf{n}|^{2}\right)^{s-l} c_{1}^{2}|\mathbf{n} \cdot \zeta|^{2 b_{1}}\left\|U_{\mathbf{n}}^{\mathrm{ev}}(., 0)\right\|_{H_{+}^{l}\left(\omega_{T}\right)}^{2},
\end{aligned}
$$

according to estimate (6.12b) of Proposition 6.16 and recalling the notations of this result. It leads to the following estimate

\left\|\mathbf{E} U^{\mathrm{ev}}\right\|_{\mathcal{E}_{s, T}} \leqslant C\left\|U^{\mathrm{ev}}\right\|_{\mathcal{E}_{s+\left\lceil b_{1}\right\rceil, T}} .
$$

We get in a similar manner, for $x_{d}>0$,

\left\|\mathbf{E} U^{\mathrm{ev}}\left(x_{d}, \psi_{d}\right)\right\|_{H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)} \leqslant C\left\|U^{\mathrm{ev}}\left(x_{d}, \psi_{d}\right)\right\|_{H^{s+\left\lceil b_{1}\right\rceil}\left(\omega_{T} \times \mathbb{T}^{m}\right)} \xrightarrow[\psi_{d} \rightarrow+\infty]{ } 0,
$$

therefore the profile $\mathbf{E} U^{\text {ev }}$ goes to zero in $\mathcal{C}\left(\mathbb{R}_{x_{d}}^{+}, H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)\right)$ when $\psi_{d}$ goes to infinity. Concerning the exponential decay of each mode of $\mathbf{E} U^{\mathrm{ev}}$, the following inequality holds

\begin{aligned}
& \sup _{x_{d}>0, \psi_{d}>0}\left\|e^{\psi_{d} \mathcal{A}(\mathbf{n} \cdot \boldsymbol{\zeta})} \Pi_{\mathbb{C}^{N}}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta}) U_{\mathbf{n}}^{\mathrm{ev}}\left(., x_{d}, 0\right)\right\|_{H^{s}\left(\omega_{T}\right)}^{2} \\
\leqslant & \sup _{x_{d}>0, \psi_{d}>0}\left\|c_{1}|\mathbf{n} \cdot \boldsymbol{\zeta}|^{b_{1}} e^{-c_{1} \psi_{d}|\mathbf{n} \cdot \zeta|^{-b_{1}}} U_{\mathbf{n}}^{\mathrm{ev}}\left(., x_{d}, 0\right)\right\|_{H^{s}\left(\omega_{T}\right)}^{2},
\end{aligned}
$$

and the mode $\mathbf{n} \in \mathbb{Z}^{m}$ of $\mathbf{E} U^{\text {ev }}$ is therefore exponentially decaying at velocity $\delta_{\mathbf{n}}:=c_{1}|\mathbf{n} \cdot \boldsymbol{\zeta}|^{-b_{1}}$, which is positive. The profile $\mathbf{E} U^{\text {ev }}$ thus satisfies the condition of Definition 3.4 of the evanescent profiles of $\mathcal{P}_{s, T}^{\mathrm{ev}}$, concluding the proof.

Concerning the projectors $\mathbf{E}_{\text {res }}^{\mathrm{in}}$ and $\widetilde{\mathbf{E}^{i}}{ }_{\text {res }}^{\text {in }}$, the proof is analogous to the one for the oscillating part of $\mathbf{E}$ and $\widetilde{\mathbf{E}}$.

Now that the projectors $\mathbf{E}, \widetilde{\mathbf{E}^{i}}, \mathbf{E}_{\text {res }}^{\text {in }}$ and $\widetilde{\mathbf{E}^{i}}{ }_{\text {res }}^{\text {in }}$ are well-defined, it can be proved that the kernel in $\mathcal{P}_{s, T}$ of the fast operator $\mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right)$ is actually given by the range of the projector $\mathbf{E}$.
Definition 6.18. For $s \geqslant 0$ and $T>0$, we denote by $\mathcal{N}_{s, T}$ the range in $\mathcal{P}_{s, T}$ of $\mathcal{P}_{s+\left\lceil b_{1}\right\rceil, T}$ projected by $\mathbf{E}$. We also denote $\mathcal{N}_{s, T}^{\mathrm{osc}}:=\mathcal{N}_{s, T} \cap \mathcal{P}_{s, T}^{\mathrm{osc}}$ and $\mathcal{N}_{s, T}^{\mathrm{ev}}:=\mathcal{N}_{s, T} \cap \mathcal{P}_{s, T}^{\mathrm{ev}}$.
Lemma 6.19 ([JMR95, Lemma 6.2.3.]). The space $\mathcal{N}_{s, T}$ is the kernel in $\mathcal{P}_{s, T}$ of the operator $\mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right)$.
Proof. Since $\mathcal{N}_{s, T}$ is equal to the kernel $\operatorname{ker} I-\mathbf{E}$ in $\mathcal{P}_{s, T}$, it must be shown that the equality of kernels ker $I-\mathbf{E}=\operatorname{ker} \mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right)$ holds in $\mathcal{P}_{s, T}$. Let $U=U^{\mathrm{osc}}+U^{\mathrm{ev}}$ be in $\operatorname{ker} \mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right)$. Since the operator $\mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right)$ keeps stable the decomposition $\mathcal{P}_{s, T}=\mathcal{P}_{s, T}^{\mathrm{osc}} \oplus \mathcal{P}_{s, T}^{\mathrm{ev}}$, each of the profiles $U^{\text {osc }}$ and $U^{\mathrm{ev}}$ are in the kernel of $\mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right)$. Writing $U^{\mathrm{ev}}$ in $\mathcal{P}_{s, T}^{\mathrm{ev}}$ as

$$
U^{\mathrm{ev}}\left(z, \theta, \psi_{d}\right)=\sum_{\mathbf{n} \in \mathbb{Z}^{m}} U_{\mathbf{n}}^{\mathrm{ev}}\left(z, \psi_{d}\right) e^{i \mathbf{n} \cdot \theta}
$$

and resolving the differential equations

$$
\left(-\mathcal{A}(\mathbf{n} \cdot \boldsymbol{\zeta})+\partial_{\psi_{d}}\right) U_{\mathbf{n}}^{\mathrm{ev}}=0
$$

for $\mathbf{n}$ in $\mathbb{Z}^{m}$, one gets $\mathbf{E} U^{\mathrm{ev}}=U^{\mathrm{ev}}$. Concerning the oscillating part, the profile $U^{\mathrm{osc}}$ is expanded in Fourier series with respect to $\theta$ as

$$
U^{\mathrm{osc}}\left(z, \theta, \psi_{d}\right)=U^{*}\left(z, \psi_{d}\right)+\sum_{\mathbf{n} \in \mathbb{Z}^{m} \backslash\{0\}} U_{\mathbf{n}}^{\mathrm{osc}}\left(z, \psi_{d}\right) e^{i \mathbf{n} \cdot \theta}
$$

Performing the integration, for $\mathbf{n}$ in $\mathbb{Z}^{m}$,

$$
\int_{\mathbb{T}^{m}} \mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right) U^{\mathrm{osc}}\left(z, \theta, \psi_{d}\right) e^{-i \mathbf{n} \cdot \theta} d \theta
$$

one gets

$$
\begin{equation*}
\partial_{\psi_{d}} U^{*}=0 \tag{6.14a}
\end{equation*}
$$

and

$$
\begin{equation*}
\left(i \widetilde{L}(0,(\mathbf{n} \cdot \boldsymbol{\zeta}, 0))+\partial_{\psi_{d}}\right) U_{\mathbf{n}}^{\mathrm{osc}}=0, \quad \forall \mathbf{n} \in \mathbb{Z}^{m} \backslash\{0\} \tag{6.14b}
\end{equation*}
$$

Thus, for $z$ in $\Omega_{T}$, we have $U^{*}\left(z, \psi_{d}\right)=U^{*}(z, 0)$, that we denote by $U^{*}(z)$. On an other hand, since $U_{\mathbf{n}}^{\text {osc }}$ is a limit of trigonometric polynomials in $\mathcal{C}_{b}\left(\mathbb{R}_{\psi_{d}}^{+} \times \mathbb{R}_{x_{d}}^{+}, H_{+}^{s}\left(\omega_{T}\right)\right)$, and according to Proposition 2.16 , every profile $U_{\mathbf{n}}^{\text {osc }}$ may be written as

$$
U_{\mathbf{n}}^{\mathrm{osc}}=\sum_{\xi \in \mathcal{C}(\mathbf{n})} \pi_{(\mathbf{n} \cdot \zeta, \xi)} U_{\mathbf{n}}^{\mathrm{osc}}
$$

where we recall that the set $\mathcal{C}(\mathbf{n})$ has been introduced in Definition 6.2. For $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$, equation (6.14b) leads to

\partial_{\psi_{d}} \pi_{(\mathbf{n} \cdot \zeta, \xi)} U_{\mathbf{n}}^{\mathrm{osc}}=i \xi \pi_{(\mathbf{n} \cdot \zeta, \xi)} U_{\mathbf{n}}^{\mathrm{osc}}, \quad \xi \in \mathcal{C}(\mathbf{n})
$$

Thus, for $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$,

$$
U_{\mathbf{n}}^{\mathrm{osc}}\left(z, \psi_{d}\right)=\sum_{\xi \in \mathcal{C}(\mathbf{n})} \pi_{(\mathbf{n} \cdot \zeta, \xi)} U_{\mathbf{n}}^{\mathrm{osc}}(z, 0) e^{i \xi \psi_{d}}
$$

so that $U^{\mathrm{osc}}=\mathbf{E} U^{\mathrm{osc}}$.
Conversely, if $U^{\mathrm{ev}}=\mathbf{E} U^{\mathrm{ev}}$, it immediately leads to $\mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right) U^{\mathrm{ev}}=0$. On an other hand, supposing $U^{\mathrm{osc}}=\mathbf{E} U^{\mathrm{osc}}$, we consider a sequence $\left(U_{\nu}^{\mathrm{osc}}\right)_{\nu}$ of trigonometric polynomials converging in $\mathcal{E}_{s+\left\lceil b_{1}\right\rceil, T}$ towards $U^{\mathrm{osc}}$. By continuity of the projector $\mathbf{E}$, the sequence of trigonometric polynomials $\left(\mathbf{E} U_{\nu}^{\mathrm{osc}}\right)_{\nu}$ converges in $\mathcal{E}_{s, T}$ towards $U^{\mathrm{osc}}$. But one can check immediately that
these trigonometric polynomials satisfy $\mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right) \mathbf{E} U_{\nu}^{\text {osc }}=0$, then passing to the limit yields to $\mathcal{L}\left(\partial_{\theta}, \partial_{\psi_{d}}\right) U^{\text {osc }}=0$.

Remark 6.20. In the proof above, it has been proven in particular that if $U=U^{\mathrm{osc}}+U^{\mathrm{ev}}$ belongs to $\mathcal{N}_{s, T}^{\mathrm{osc}} \oplus \mathcal{N}_{s, T}^{\mathrm{ev}}$, then the profile $U^{\mathrm{osc}}$ writes

$$
\begin{equation*}
U^{\mathrm{osc}}\left(z, \theta, \psi_{d}\right)=U^{*}(z)+\sum_{\mathbf{n} \in \mathbb{Z}^{m} \backslash\{0\}} \sum_{\xi \in \mathcal{C}(\mathbf{n})} U_{\mathbf{n}, \xi}^{\mathrm{osc}}(z) e^{i \mathbf{n} \cdot \theta} e^{i \xi \psi_{d}} \tag{6.15}
\end{equation*}
$$

with, for $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$ and $\xi$ in $\mathcal{C}(\mathbf{n}), \pi_{(\mathbf{n} \cdot \zeta, \xi)} U_{\mathbf{n}, \xi}^{\mathrm{osc}}=U_{\mathbf{n}, \xi}^{\mathrm{osc}}$, and the profile $U^{\text {ev }}$ writes

$$
\begin{equation*}
U^{\mathrm{ev}}\left(z, \theta, \psi_{d}\right)=\sum_{\mathbf{n} \in \mathbb{Z}^{m} \backslash\{0\}} e^{\psi_{d} \mathcal{A}(\mathbf{n} \cdot \boldsymbol{\zeta})} \Pi_{\mathbb{C}^{N}}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta}) U_{\mathbf{n}}^{\mathrm{ev}}(z, 0) e^{i \mathbf{n} \cdot \theta} \tag{6.16}
\end{equation*}
$$

The previous remark leads to the following result, which links the norm $\mathcal{C}_{b}\left(\mathbb{R}_{\psi_{d}}^{+}, L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)\right)$ of a profile of $\mathcal{N}_{0, T}^{\text {osc }}$ and its incoming scalar product (3.12) with itself. This result will be used in the following to deduce from a priori estimates on the scalar product a priori estimates on the norm $\mathcal{P}_{s, T}^{\text {osc }}$. It is analogous to [JMR95, Lemma 6.2.4], in a weaker form (because of a lack of symmetry in our context).
Lemma 6.21. There exists a constant $C>0$ such that for every profile $U^{\mathrm{osc}}$ of $\mathcal{N}_{0, T}^{\mathrm{osc}}$, we have, for $x_{d} \geqslant 0$,

C\left\|U^{\mathrm{osc}}\right\|_{\mathcal{C}_{b}\left(\mathbb{R}_{\psi_{d}}^{+}, L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)\right)}^{2}\left(x_{d}\right) \leqslant\left\langle U^{\mathrm{osc}} \mid U^{\mathrm{osc}}\right\rangle_{\text {in }}\left(x_{d}\right) \leqslant\left\|U^{\mathrm{osc}}\right\|_{\mathcal{C}_{b}\left(\mathbb{R}_{\psi_{d}}^{+}, L^{2}\left(\omega_{T} \times \mathbb{T}^{m}\right)\right)}^{2}\left(x_{d}\right)
$$

Proof. 6.3. Reducing the system. It is shown in this part that in every solution of the system (5.10) there occur only incoming modes (in particular every solution is of zero mean), and every solution is supported in a finite interval in $x_{d}$. We also show that the system (5.10) decouples according to the oscillating and the evanescent part, and even, for the oscillating part, according to the set $\mathcal{F}_{\text {res }}^{\mathrm{in}}$ of resonant modes and each non resonant mode. More precisely, the following result is proved. Recall that $s_{0}$ is given by $s_{0}=h+(d+m) / 2$ where $h$ is an integer greater or equal to $\left(3-a_{1}\right) / 2$ occurring in estimate (6.3), with $a_{1}$ the real number of Assumption 6.

To show that there is no outgoing mode, the scalar product (3.13) for outgoing modes is used, which is defined for profiles of compact support with respect to $x_{d}$. Thus we must prove before that the considered solution $U$ is of compact support with respect to $x_{d}$. Then the outgoing modes are isolated in equation (5.10), deducing that they are zero. First the left term of equation (5.10b) is rewritten.

ii) If $\mathbf{n}_{1}=\mathbf{n}_{2}, \xi_{1}=\xi_{2}$ and $\lambda_{1}+\lambda_{2} \neq 0$, then the nonzero frequency obtained is given by $\left(\lambda_{1}+\lambda_{2}\right)\left(\mathbf{n}_{1} \cdot \boldsymbol{\zeta}, \xi_{1}\right)$ which is characteristic. This is called self-interaction of the frequency $\left(\mathbf{n}_{1} \cdot \boldsymbol{\zeta}, \xi_{1}\right)$ with itself, and constitutes the term (6.23e) of equation (6.23).
iii) Finally, in the remaining cases, if the nonzero frequency obtained $\lambda_{1}\left(\mathbf{n}_{1} \cdot \boldsymbol{\zeta}, \xi_{1}\right)+\lambda_{2}\left(\mathbf{n}_{2} \cdot \boldsymbol{\zeta}, \xi_{2}\right)$ is characteristic, then it corresponds to a resonance in the sense of Definition 6.8. 6.3.3. Finite velocity propagation. It can be proved that if $U$ is a smooth enough solution of (5.10), then it is supported in a finite interval in $x_{d}$. More precisely the following result is verified.

The proof of this lemma uses techniques developed below, so it is postponed, in order to focus on the derivation of a priori estimates. We use the fact that $U$ travels at finite velocity in the normal direction, according to Lemma 2.14.

According to this result, in the system (5.10) and the associated linearized systems, the profile $U^{\text {osc }}$ can be replaced by $\beta_{T} U^{\text {osc }}$, where $\beta_{T}$ is the function of $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}_{x_{d}}^{+}\right)$introduced in Proposition 6.22 , equating 1 on $\left[0, \mathcal{V}^{*} T\right]$ and 0 on $\left[2 \mathcal{V}^{*} T,+\infty\right)$. In the following, the scalar product (3.13) suited for outgoing profiles can be used, since it is well-defined for profile of compact support with respect to $x_{d}$.

Resonant modes. Outgoing modes involved in resonances are now investigated, namely the couples $\left(\mathbf{n}_{0}, \xi_{0}\right)$ of the set $\mathcal{F}_{\text {res }}^{\text {out }}$, that are coupled through the equation (6.25), because of the resonances, and therefore must be treated all together. From equation (6.25) is deduced the equation for the resonant modes, occurring, in addition to a transport and a Burgers terms, a resonant one. There holds

In conclusion, it has been proven that for every profile $U$ regular enough solution of the system (5.10), its mean value $U^{*}$ as well as each of its outgoing modes $U_{\mathbf{n}, \xi}^{\text {osc }}, \mathbf{n} \in \mathbb{Z}^{m} \backslash\{0\}, \xi \in \mathcal{C}_{\text {out }}(\mathbf{n})$, are zero.
6.3.5. Decoupling the system. Because of the algebra property of the space of profiles $\mathcal{P}_{s, T}$, and since the projectors $\mathbf{E}$ and $\widetilde{\mathbf{E}^{i}}$ preserve the decomposition $\mathcal{P}_{s, T}=\mathcal{P}_{s, T}^{\text {osc }} \oplus \mathcal{P}_{s, T}^{\mathrm{ev}}$, equations (5.10a) and (5.10b) decoupled according to the oscillating and evanescent parts, and the same holds for equation $(5.10 \mathrm{~d})$. The evanescent part therefore satisfies the equation

The control in $H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ for all $s \geqslant 0$ follows, using that the quantities $\Pi_{-}^{j(\mathbf{n}, \xi)}(\mathbf{n} \cdot \boldsymbol{\zeta})\left(B_{\mid E_{-}(\mathbf{n} \cdot \boldsymbol{\zeta})}\right)^{-1}$ and $\Pi_{-}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta})\left(B_{\mid E_{-}(\mathbf{n} \cdot \boldsymbol{\zeta})}\right)^{-1}$ do not depend on $z^{\prime}$ in $\omega_{T}$. Therefore we obtain

6.4. A priori estimate on the linearized system for the oscillating resonant part. According to Proposition 6.22, the study may be narrowed down to the one of the systems (6.17), (6.18) and (6.19). This part deals with the first one, and we will prove a priori estimates on the associated linearized system, which will be used to show the convergence of an iterative scheme. Recall that $s_{0}$ is given by $s_{0}=h+(d+m) / 2$ where $h$ is an integer greater than $\left(3-a_{1}\right) / 2$, occurring in estimate (6.3), whith $a_{1}$ the real number of Assumption 6.

The terms (6.43c) and (6.43e) are treated in the same way as the corresponding terms for the outgoing modes, whereas the assumption 8 is used to treat the term (6.43d) of resonances of type 1 .
6.4.2. $L^{2}$ estimate. This subsection is devoted to the proof of the following lemma.

Now the right hand side terms of the equality obtained by taking the double of the real part of the scalar product of equality (6.43) with $\widetilde{U}_{\text {res }}^{\text {osc }}$ are investigated. The analysis of the terms corresponding to the terms $(6.43 \mathrm{~b}),(6.43 \mathrm{c})$ and $(6.43 \mathrm{e})$ is analogous to the one made for the outgoing modes.

Only the profiles $V_{\text {res }}^{\text {osc }}$ and $U_{\text {res }}^{\text {osc }}$ appear in the estimate since only frequencies of $\mathcal{F}_{\text {res }}^{\text {in }}$ occur in $\mathcal{R}_{1}$.

Equations (6.43) and (6.46) and estimates (6.45), (6.48), (6.49) and (6.50) finally lead to

6.4.3. Proof of Lemma 6.23. All requisite techniques to show Lemma 6.23 have now been developed, so the proof is given here. It follows [BGS07, Section 1.3.1]. Recall that at this stage, we have considered a solution $U$ of (5.10) regular enough, and we have shown that its mean value is zero.

6.4.4. Estimating the derivatives. Returning to the proof of the a priori estimate, Proposition 6.24 is proved here using estimate (6.44) of Lemma 6.25. Consider a multi-index $\alpha$ of $\mathbb{N}^{d+m}$ such that $|\alpha| \leqslant s$. Since the operator $\partial_{z^{\prime}, \theta}^{\alpha}$ commutes with the projectors $\mathbf{E}_{\text {res }}^{\text {in }}$ and $\widetilde{\mathbf{E}^{i}{ }_{\text {res }}{ }^{\text {in }} \text {, the profile }}$ $\partial_{z^{\prime}, \theta}^{\alpha} U^{\text {osc }}$ satisfies a system of the form (6.38), with $\partial_{z^{\prime}, \theta}^{\alpha} G$ as boundary term, and $\widetilde{\mathbf{E}^{i}{ }_{\text {res }}^{\text {in }}\left[\partial_{z^{\prime}, \theta}^{\alpha} F_{\text {res }}^{\text {osc }}+\right.}$ $\left.F_{\alpha}\right]$ as source term, where $F_{\alpha}$ is the following commutator

6.5. A priori estimate for the linearized Burgers equations. We prove now a priori estimates for the linearized Burgers equations (6.18), corresponding to the non-resonant incoming modes. These a priori estimates will be used to prove the existence of solution to these Burgers equations. However the estimates will have to be summed with respect to $\left(\mathbf{n}_{0}, \xi_{0}\right)$, so we wish for constants independent of $\left(\mathbf{n}_{0}, \xi_{0}\right)$. This part is devoted to the proof of the following result.

Here the order of regularity must be taken down to $h$ since we wish for an upper bound independent of $\mathbf{n}_{0}$, in the purpose of summing the inequality with respect to $\mathbf{n}_{0}$. An upper bound of the form $C\left(\mathbf{n}_{0}\right)\left|\lambda_{1}\right|$ instead of $C\left|\lambda_{1} \mathbf{n}_{0}\right|^{h}$ could be obtained, but where the constant $C\left(\mathbf{n}_{0}\right)$ depends
on $\mathbf{n}_{0}$, and may be arbitrarily large since we consider modes $\mathbf{n}_{0}$ close to the glancing set. The right hand side of the equality being of the form $\langle f g \mid g\rangle$, the following inequality holds

The a priori estimates (6.44) and (6.63) (for $s=0$ ) as well as the equivalence property 6.22 ensure the uniqueness of the solution to (5.10).

### 6.6. Construction of a solution.

6.6.1. Construction of an oscillating solution to the linearized system for the resonant incoming modes. Thanks to the a priori estimate (6.39) of Proposition 6.24 on the linearized system (6.38), a solution to this system can be constructed, proving the following result.
Proposition 6.27. Consider $s>s_{0}$ and $T>0$, and let $V_{\text {res }}^{\mathrm{osc}}$ be a profile of $\mathcal{N}_{s, T}^{\mathrm{osc}}$ involving only resonant incoming modes, $F_{\text {res }}^{\text {osc }}$ be in $\mathcal{P}_{s, T}^{\mathrm{osc}}$ and $G$ be in $H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$. Then there exists a solution $U_{\text {res }}^{\mathrm{osc}}$ in $\mathcal{P}_{s, T}^{\mathrm{osc}}$ to the system (6.38), involving only resonant incoming modes, that moreover satisfies the following estimate

The proof of such a result using an a priori estimate of the form (6.39) is detailed in [JMR95, Theorem 6.3.3]. Its main ideas are recalled here.

The uniqueness of the solution follows directly from the a priori estimate (6.39). Concerning the existence, a finite difference scheme is used. Since the operators $\partial_{\theta_{j}}$ for $j=1, \ldots, m$, are skew-symmetric, skew-symmetric finite difference operators must be considered. Denoting $e_{1}, \ldots, e_{m}$ the canonical basis of $\mathbb{R}^{m}$, we define, for every function $U$ of $\Omega_{T} \times \mathbb{T}^{m} \times \mathbb{R}_{+}$,

Then the proof consists in showing that the sequence $\left(U_{\nu}^{\text {osc }}\right)_{\nu}$ is bounded in high norm, and contracting in small norm, in order to deduce its weak convergence in the Banach space $\mathcal{P}_{s, T}^{\text {osc }}$.

One may however note that the existence time $T$ is indeed independent of $\left(\mathbf{n}_{0}, \xi_{0}\right)$, since the constants in estimate (6.63) are independent of $\left(\mathbf{n}_{0}, \xi_{0}\right)$, and since according to estimate (6.37), each boundary term $h_{\mathbf{n}_{0}, \xi_{0}}$ is controlled in $H^{s}\left(\omega_{T} \times \mathbb{T}\right)$ by $C\|G\|_{H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)}$, uniformly with respect to $\left(\mathbf{n}_{0}, \xi_{0}\right)$.

& \leqslant C\left\|U_{\text {res }}^{\text {osc }}\right\|_{\mathcal{E}_{s, T}}^{2}+C \sum_{\substack{\left(\mathbf{n}_{0}, \xi_{0}\right) \in \\
\left(\mathcal{B}_{\mathbb{Z}^{m}} \times \mathcal{C}_{\text {in }}\left(\mathbf{n}_{0}\right)\right) \backslash \mathcal{F}_{\text {res }}^{\text {in }}}}\left\|S_{\mathbf{n}_{0}, \xi_{0}}\right\|_{\mathcal{C}_{\left(\mathbb{R}_{+}, H^{s}\left(\omega_{T} \times \mathbb{T}\right)\right)}^{2},},
\end{aligned}
$$

so that, using the a priori estimates (6.39) and (6.63) as well as the boundary term estimates (6.37), one gets

6.6.3. Determination of the evanescent part and conclusion. To conclude as to the proof of Theorem 4.1, it must be proved that there exists a solution $U^{\mathrm{ev}}$ in $\mathcal{P}_{s, T}^{\mathrm{ev}}$ to the system (6.19), where the parameters $s$ and $T$ are those given in Proposition 6.28.

The polarization condition (6.19a) results, according to Remark 6.20, to

The traces $\left(\Pi_{\mathbb{C}^{N}}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta}) U_{\mathbf{n}}^{\mathrm{ev}}\right)_{\mid \psi_{d}=0}$ for $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$ must therefore be determined to find the profile $U^{\mathrm{ev}}$. The boundary condition (6.19b) gives the double trace on the boundary, for $\mathbf{n}$ in $\mathbb{Z}^{m} \backslash\{0\}$,

Then this trace is lifted with respect to $x_{d}$ using a function $\chi$ of $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}_{+}\right)$, equaling 1 in 0 . Namely we set

Note that, by construction, the profile $U^{\text {ev }}$ satisfies the polarization condition (6.19a) as well as the boundary condition (6.19b). It must be now verified that it belongs to the space of evanescent profiles $\mathcal{P}_{s, T}^{\mathrm{ev}}$. First we note that the profile $U^{\mathrm{ev}}$ belongs to $L^{\infty}\left(\mathbb{R}_{x_{d}}^{+} \times \mathbb{R}_{\psi_{d}}^{+}, H_{+}^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)\right)$. Indeed, on one hand, the functions $G_{\mathbf{n}}$ being zero for negative times $t$, the profile $U^{\text {ev }}$ is zero for negative times $t$. On the other hand, since the function $\chi$ is bounded, the inverse map $\left(B_{\mid E_{-}(\mathbf{n} \cdot \boldsymbol{\zeta})}\right)^{-1}$ is uniformly bounded according to remark 2.8, and the terms $e^{\psi_{d} \mathcal{A}(\mathbf{n} \cdot \boldsymbol{\zeta})} \Pi_{-}^{e}(\mathbf{n} \cdot \boldsymbol{\zeta})$ are also uniformly bounded according to the estimate (6.12a) of Proposition 6.16, for $x_{d}, \psi_{d} \geqslant 0$, the following estimate holds:

Then it is proved that the profile $U^{\text {ev }}$ is continuous with respect to $\left(x_{d}, \psi_{d}\right)$ in $\mathbb{R}_{+} \times \mathbb{R}_{+}$with values in $H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$. Consider $\left(x_{d}^{0}, \psi_{d}^{0}\right)$ in $\mathbb{R}_{+} \times \mathbb{R}_{+}$, and $\varepsilon>0$. There holds, for $x_{d}, \psi_{d} \geqslant 0$,

and we seek to estimate the two terms on the right hand side of the inequality. For the first one, according to the estimate (6.12a) of Proposition (6.16) and Remark 2.8, for $\psi_{d} \geqslant 0$, we get

& +\left\|\sum_{|\mathbf{n}|>M}\left[U_{\mathbf{n}}^{\mathrm{ev}}\left(y, x_{d}^{0}, \psi_{d}\right)-U_{\mathbf{n}}^{\mathrm{ev}}\left(y, x_{d}^{0}, \psi_{d}^{0}\right)\right] e^{i \mathbf{n} \cdot \theta}\right\|_{H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)} \tag{6.78b}
\end{align*}

The sum in the term (6.78a) being finite and the functions $U_{\mathbf{n}}^{\text {ev }}$ being continuous with respect to $\psi_{d}$, there exists $\delta_{2}>0$ such that for all $\psi_{d}$ such that $\left|\psi_{d}-\psi_{d}^{0}\right|<\delta_{2}$, we have (6.78a) $<\varepsilon$. On an other hand, according to estimate (6.12a), Remark 2.8 and since $\chi$ is bounded, we have, by construction of $M$, for all $\psi_{d} \geqslant 0,(6.78 \mathrm{~b})<C \varepsilon$ where $C>0$ does not depend on $\varepsilon$. It is then possible to conclude: for all $\left(x_{d}, \psi_{d}\right)$ such that $\left|\left(x_{d}, \psi_{d}\right)-\left(x_{d}^{0}, \psi_{d}^{0}\right)\right|<\min \left(\delta_{1}, \delta_{2}\right)$, we have

Finally, with similar arguments as above for the continuity property, it is possible to show that the profile $U^{\text {ev }}$ converges towards zero in the space $\mathcal{C}\left(\mathbb{R}_{x_{d}}^{+}, H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)\right)$ when $\psi_{d}$ goes to infinity (so in particular in $H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ for every fixed $\left.x_{d}\right)$.

All points of Definition 3.4 of evanescent profiles have therefore been verified, so it has been proven that the profile $U^{\text {ev }}$ belongs to the space $\mathcal{P}_{s, T}^{\mathrm{ev}}$ of evanescent profiles.

Remark 6.29. It has been shown in the previous paragraph, in estimate (6.76), that the oscillating part $U^{\text {osc }}$ is controlled in $\mathcal{E}_{s, T}$ by the $H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ norm of the boundary term $G$. On an other hand, according to estimate (6.77), the evanescent part $U^{\text {ev }}$ is also controlled by the $H^{s}\left(\omega_{T} \times \mathbb{T}^{m}\right)$ norm of $G$. Thus the leading profile $U$ satisfies

6.7. Conclusion and perspectives. It has therefore been proven that for $s>h+(d+m) / 2$, there exists a time $T>0$ small enough such that the systems (6.17), (6.18) and (6.19) admit solutions $U_{\text {res }}^{\text {osc }}, S_{\mathbf{n}_{0}, \xi_{0}}$ and $U^{\mathrm{ev}}$ in $\mathcal{P}_{s, T}^{\mathrm{osc}}, \mathcal{C}\left(\mathbb{R}_{+}, H^{s}\left(\omega_{T} \times \mathbb{T}\right)\right)$ and $\mathcal{P}_{s, T}^{\mathrm{ev}}$. According to Proposition 6.22 , the profile $U=U^{\mathrm{osc}}+U^{\mathrm{ev}}$ (where $U^{\mathrm{osc}}$ is defined from $U_{\text {res }}^{\text {osc }}$ and $S_{\mathbf{n}_{0}, \xi_{0}}$ by equation (6.70)) is therefore a solution in $\mathcal{P}_{s, T}$ of the system (5.10). It concludes the proof of theorem 4.1.

The estimate (6.39) is not tame since the norm of $V^{\text {osc }}$ in the estimate depends on the regularity index $s$. Therefore, it is a priori not possible to obtain the existence of a solution $U^{\text {osc }}$ of infinite regularity considering a boundary term $G$ infinitely regular, since without a tame estimate, the existence time $T$ a priori depends on the considered index $s$. It has been chosen not to attempt to keep the estimates tame until the end for the sake of simplicity, for example in estimate (6.44), but it is however conceivable to achieve this more precise statement in further work.

Possible extensions of the result of this article to less restrictive assumptions are now discussed. It seems reasonable to consider a similar result under the assumption that the system under study is hyperbolic with constant multiplicity, and not strictly hyperbolic (Assumption 2). Similarly, the Hypothesis 7 could be removed to allow outgoing frequencies to exist within the domain. It is a situation of this type which is considered in [CGW11]. But in this case it is no longer possible to determine beforehand the traces of incoming modes, as done in Proposition 6.22. This may also open the way to an infinite number of resonances with outgoing phases, which complicates the functional framework. The weakening of the uniform Kreiss-Lopatinskii condition Assumption 3 shall be discussed in a future work. Concerning the glancing frequencies, the Assumption 4 stating that all glancing frequencies are of order 2 seems to be crucial, see [Wil00]. Likewise, it seems difficult to do without Assumption 5 ensuring that no glancing frequencies are created on the boundary.

Finally, this work raises the question of the justification of the geometric optic expansion that has been constructed, namely to prove that the function

is indeed a good approximation on a fixed time interval of the exact solution of (2.1) as $\varepsilon$ goes to zero. To do so, two main methods are practicable. As conducted in [Wil96], if there exists a solution on a time interval independent on the parameter $\varepsilon$, it is conceivable to show that this exact solution and the function defined above draw near each other when $\varepsilon$ goes to 0 , see [JMR95] and [CGW11]. The problem is that in this work we do not have an exact solution on a fixed time interval. An other strategy relies on using a large number of corrector profiles, which we do not dispose either here (constructing correctors relies on small divisor accurate controls for noncharacteristic modes, which goes even further beyond assumption 6). Both of these points (getting an existence time of the exact solution independent of epsilon and building a large number of correctors) do not seem to be within our reach for the moment, but will be the topics of future studies.

## Appendix A. Additional proofs

A.1. Proof of Proposition 2.21. We detail here the proof of Proposition 2.21, omitted at first because of its length.

Recall that, for $\zeta$ in $\Xi_{0}$, the projectors $\Pi_{j}(\zeta)$, for $j$ in $\mathcal{G}(\zeta) \cup \mathcal{R}(\zeta)$, are defined as the projectors from $E_{-}(\zeta)$ on $E_{-}^{j}(\zeta)$ according to decomposition (2.23), and that $\Pi_{-}^{e}(\zeta)$ is defined as the projector from $E_{-}(\zeta)$ on the elliptic stable component $E_{-}^{e}(\zeta)=\oplus_{j \in \mathcal{P}(\zeta)} E_{-}^{j}(\zeta)$ according to the same decomposition. Proposition 2.21 then reads as follows.

Proposition A. 1 ([Wil96]). For all $\zeta \in \Xi_{0}$ the projectors $\Pi_{-}^{j}(\zeta)$ for $j$ in $\mathcal{G}(\zeta) \cup \mathcal{R}(\zeta)$, and the projectors $\Pi_{-}^{e}(\zeta)$ are uniformly bounded with respect to $\zeta$ in $\Xi_{0}$.

Proof. In all the proof we indistinctly denote by $e$ every analytic function which, evaluated in a particular point $\underline{\alpha}$ precised below, is nonzero, and which is therefore nonzero in a neighborhood of the point $\underline{\alpha}$. Since the projectors $\Pi_{-}^{j}(\zeta), j \in \mathcal{G}(\zeta) \cup \mathcal{R}(\zeta)$ and $\Pi_{-}^{e}(\zeta)$ are homogeneous of degree 0 with respect to $\zeta$, the claim is proved locally in $\Sigma_{0}$, and the result follows from the
compactness of the sphere $\Sigma_{0}$. The study is therefore reduced locally in a neighborhood of every point of $\Sigma_{0}$.

Consider $\underline{\zeta}=(\underline{\tau}, \underline{\eta}) \in \Sigma_{0}$. We are interested in the behavior, on a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$, of the projectors $\Pi_{-}^{j}(\zeta), j \in \mathcal{G}(\zeta) \cup \mathcal{R}(\zeta)$ and $\Pi_{-}^{e}(\zeta)$, and therefore in the behavior, in a neighborhood of $\underline{\zeta}$, of the eigenvalues of $\mathcal{A}(\zeta)$. According to Proposition 2.9 there exists a neighborhood $\mathcal{V}$ of $\underline{\zeta}$ in $\Sigma_{0}$, an integer $L \geqslant 0$, and a regular basis $\mathbb{C}^{N}$ in which the matrix $\mathcal{A}(\zeta)$ is a block diagonal matrix of the form

where the block $\mathcal{A}_{-}(\zeta)$ (resp. $\mathcal{A}_{+}(\zeta)$ ), eventually of size zero, is of negative definite (resp. positive definite) real part, and where the blocks $\mathcal{A}_{j}(\zeta)$ are of type $\left.i i i\right)$ or $i v$ ) with the notations of Proposition 2.9. According to this proposition, the eigenvalues associated with the blocks of type iii) remain imaginary for $\zeta \in \Sigma_{0}$ in a neighborhood of $\underline{\zeta}$ and therefore do not contribute to the elliptic parts of the stable and unstable subspaces. However, the eigenvalues of the blocks of type $i v$ ) may have a nonzero real part in a neighborhood of $\underline{\zeta}$ and thus contribute to the elliptic parts. Thus, in a neighborhood of $\frac{\zeta}{}$ in $\Sigma_{0}$, the elliptic part $\oplus_{j \in \mathcal{P}(\zeta)} E_{-}^{j}(\zeta)$ writes as the direct sum of the stable subspace for $\mathcal{A}(\bar{\zeta})$ associated with the block $\mathcal{A}_{-}(\zeta)$ and of the generalized eigenspaces associated with the potential eigenvalues of negative real part of the blocks $\mathcal{A}_{j}(\zeta)$ of type $i v$ ). The detailed description of these eigenspaces constitutes the central point of the analysis below.

In the basis adapted to the decomposition (A.1), which is analytic with respect to $\zeta \in \Sigma_{0}$, we consider the first vectors associated with the block $\mathcal{A}_{-}(\zeta)$ and the aim is to complete this set of vectors into an analytic basis of the stable subspace $E_{-}(\zeta)$. The purpose is to construct, in a neighborhood of $\underline{\zeta}$, a determination, continuous with respect to $\zeta$, of the stable eigenvectors of $\mathcal{A}(\zeta)$ associated with the blocks $\mathcal{A}_{j}(\zeta)$ of type $\left.i i i\right)$ and $i v$ ) (which are therefore imaginary in $\underline{\zeta}$ ) and to deduce from that the existence of a linearly independent set of generalized eigenvectors continuously depending on $\zeta$. To this end, the analyis of [Mét00] is followed.

Let $i \underline{\xi}_{j}$ be an imaginary eigenvalue of $\mathcal{A}(\underline{\zeta})$ of algebraic multiplicity $n_{j}$. By definition of $\mathcal{A}(\underline{\zeta})$ and with the notations of Assumption2, there exists a unique index $k_{j}$ between 1 and $N$ such that

$$
\underline{\tau}=\tau_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)
$$

Two cases may occur, depending on the cancellation of the quantity $\frac{\partial \tau_{k_{j}}}{\partial \xi}\left(\underline{\eta}, \underline{\xi}_{j}\right)$. In the first case we shall see that there exists a continuous extension of the eigenvalue $i \underline{\xi}_{j}$ which remains imaginary for $\zeta \in \Sigma_{0}$ in a neighborhood of $\underline{\zeta}$, and that there exists a regular projector on the associated subspace. In the second case, the eigenvalue $i \underline{\xi}_{j}$ is degenerate (i.e. is not semisimple) and extends to a continuous eigenvalue $i \xi_{j}$, which, depending on the position of $\zeta$ in the neighborhood of $\underline{\zeta}$, may become of nonzero real part, or imaginary and simple, or even remains imaginary and degenerate.

First suppose that

$$
\frac{\partial \tau_{k_{j}}}{\partial \xi}\left(\underline{\eta}, \underline{\xi}_{j}\right) \neq 0
$$

that is $\left(\underline{\tau}, \underline{\eta}, \underline{\xi}_{j}\right)$ is incoming or outgoing. According to Assumption 2, for $(\zeta, \xi)$ in $\mathbb{R}^{d+1} \backslash\{0\}$, we have

\operatorname{det}(\mathcal{A}(\zeta)-i \xi I)=\operatorname{det}\left(A_{d}(0)\right)^{-1} i^{N} \operatorname{det} L(0,(\zeta, \xi))=\left(\tau-\tau_{k_{j}}(\eta, \xi)\right) e(\zeta, \xi), \tag{A.2}
\end{equation*}
$$

where $e\left(\underline{\zeta}, \underline{\xi}_{j}\right) \neq 0$. Since $\frac{\partial \tau_{k_{j}}}{\partial \xi}\left(\underline{\eta}, \underline{\xi}_{j}\right) \neq 0$, according to the Weierstrass preparation theorem [Hör90], there exists a unique real analytic function $\xi_{j}$ defined in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$ satisfying $\xi_{j}(\underline{\zeta})=\underline{\xi}_{j}$ and such that in a neighborhood of $\left(\underline{\zeta}, \underline{\xi}_{j}\right)$ in $\Sigma_{0} \times \mathbb{R}$ we have

\tau-\tau_{k_{j}}(\eta, \xi)=\left(\xi-\xi_{j}(\zeta)\right) e(\zeta, \xi) \tag{A.3}
\end{equation*}
$$

where $e\left(\underline{\zeta}, \underline{\xi}_{j}\right) \neq 0$. Thus, in a neighborhood of $\left(\underline{\zeta}, \underline{\xi}_{j}\right)$ in $\Sigma_{0} \times \mathbb{R}$ we have

$$
\operatorname{det}(\mathcal{A}(\zeta)-i \xi I)=\left(\xi-\xi_{j}(\zeta)\right) e(\zeta, \xi)
$$

where $e\left(\underline{\zeta}_{\boldsymbol{\zeta}} \underline{\xi}_{j}\right) \neq 0$, so in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}, i \xi_{j}(\zeta)$ is an eigenvalue (analytic with respect to $\zeta$ ) of $\mathcal{A}(\zeta)$ of algebraic multiplicity 1 . On an other hand, according to identity (A.3), we have $\tau=\tau_{k_{j}}\left(\eta, \xi_{j}(\zeta)\right)$, thus

\mathcal{A}(\zeta) \pi_{k_{j}}\left(\eta, \xi_{j}(\zeta)\right)=i \xi_{j}(\zeta) \pi_{k_{j}}\left(\eta, \xi_{j}(\zeta)\right)
$$

In a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}, i \xi_{j}(\zeta)$ is therefore an eigenvalue of $\mathcal{A}(\zeta)$ of algebraic multiplicity 1, thus simple. Furthermore the projector $\pi_{k_{j}}\left(\eta, \xi_{j}(\zeta)\right)$ is analytic with respect to $\zeta$ and is a projector on the eigenspace of $\mathcal{A}(\zeta)$ associated with $i \xi_{j}(\zeta)$. Thus, in the block decomposition (A.1), there is a unique scalar block among the blocks $\mathcal{A}_{l}(\zeta)$ corresponding to the eigenvalue $i \xi_{j}(\zeta)$. In the incoming case, we then obtain associated eigenvectors depending analyticly on $\zeta \in \Sigma_{0}$ in a neighborhood of $\underline{\zeta}$, contributing to the stable subspace $E_{-}(\zeta)$.

If now $\frac{\partial \tau_{k_{j}}}{\partial \xi}\left(\underline{\eta}, \underline{\xi}_{j}\right)=0$, then, according to Assumption 4, we have $\frac{\partial^{2} \tau_{k_{j}}}{\partial \xi^{2}}\left(\underline{\eta}, \underline{\xi}_{j}\right) \neq 0$ and in that case we say that $\underline{\xi}_{j}$ is glancing. Thus there exists a function $e$ defined in a neighborhood of $\underline{\xi}_{j}$ with $e\left(\underline{\xi}_{j}\right) \neq 0$ such that for $\xi$ close to $\underline{\xi}_{j}$, we have

$$
\underline{\tau}-\tau_{k_{j}}(\underline{\eta}, \xi)=\left(\xi-\underline{\xi}_{j}\right)^{2} e(\xi)
$$

We deduce, according to (A.2) that for $\xi$ close to $\underline{\xi}_{j}$,

$$
\operatorname{det}(\mathcal{A}(\underline{\zeta})-i \xi I)=\left(\xi-\underline{\xi}_{j}\right)^{2} e(\xi)
$$

where $e\left(\underline{\xi}_{j}\right) \neq 0$. The algebraic multiplicity $n_{j}$ of the eigenvalue $i \underline{\xi}_{j}$ is therefore equal to 2 whereas its geometric multiplicity equals 1 since

\operatorname{ker}\left(\mathcal{A}(\underline{\zeta})-i \underline{\xi}_{j} I\right)=\operatorname{ker} L\left(0,\left(\underline{\zeta}_{,}, \underline{\xi}_{j}\right)\right)=\operatorname{Im} \pi_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right),
$$

and since the projector $\pi_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)$ is of rank 1 . The aim is therefore to find a basis of the generalized eigenspace associated with $i \underline{\xi}_{j}$, which is of dimension 2 . By definition of the analytic function $\tau_{k_{j}}$ and of the projector $\pi_{k_{j}}$, we have, for $\xi$ close to $\underline{\xi}_{j}$,

L\left(0, \tau_{k_{j}}(\underline{\eta}, \xi), \underline{\eta}, \xi\right) \pi_{k_{j}}(\underline{\eta}, \xi)=0 .
$$

Differentiating this equation with respect to $\xi$ and evaluating in $\xi=\underline{\xi}_{j}$, one gets, since $\tau_{k_{j}}\left(\underline{\eta}^{\prime}, \underline{\xi}_{j}\right)=$ $\underline{\tau}$,
$\partial_{\xi} \tau_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right) \partial_{\tau} L\left(0, \underline{\tau}, \underline{\eta}, \underline{\xi}_{j}\right) \pi_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)+\partial_{\xi} L\left(0, \underline{\tau}, \underline{\eta}, \underline{\xi}_{j}\right) \pi_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)+L\left(0, \underline{\tau}, \underline{\eta}, \underline{\xi}_{j}\right) \partial_{\xi} \pi_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)=0$, that is to say, according to the expression of $L(0,(\tau, \eta, \xi))$ and using $\partial_{\xi} \tau_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)=0$,

$$
A_{d}(0) \pi_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)+i A_{d}(0)\left(\mathcal{A}(\underline{\zeta})-i \underline{\xi}_{j}\right) \frac{\partial \pi_{k_{j}}}{\partial \xi}\left(\underline{\eta}, \underline{\xi}_{j}\right)=0
$$

Denoting $\underline{P}_{0}:=\pi_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)$ and $\underline{P}_{1}:=\frac{\partial \pi_{k_{j}}}{\partial \xi}\left(\underline{\eta}, \underline{\xi}_{j}\right)$ we obtain

$$
\begin{equation*}
\left(\mathcal{A}(\underline{\zeta})-i \underline{\xi}_{j}\right) \underline{P}_{1}=i \underline{P}_{0} . \tag{A.4}
\end{equation*}
$$

We then denote by $\underline{E}_{j}$ a nonzero vector of the linear $\operatorname{line} \operatorname{Im} \pi_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)$. The equation (A.4) thus leads to

\left(\mathcal{A}(\underline{\zeta})-i \underline{\xi}_{j}\right) \underline{P}_{1} \underline{E}_{j}=i \underline{E}_{j} . \tag{A.5}
\end{equation*}

One can then verify that the set of vectors $\underline{E}_{j}, \underline{P}_{1} \underline{E}_{j}$ is linearly independent and that it therefore forms a basis of the generalized eigenspace associated with $i \underline{\xi}_{j}$. In this basis, according to (A.5),
the operator $\mathcal{A}(\underline{\zeta})$ restricted to the generalized eigenspace associated with $i \underline{\xi}_{j}$ is given by the following matrix:

We have therefore obtained a triangularization of the matrix $\mathcal{A}(\underline{\zeta})$ restricted to the generalized eigenspace associated with $i \underline{\xi}_{j}$, and we seek to extend this structure in a neighborhood of $\underline{\zeta}$ and to study the behavior of the stable eigenvalues of the matrix $\mathcal{A}(\underline{\zeta})$ restricted to the generalized eigenspace associated with $i \underline{\xi}_{j}$ in a neighborhood of $\underline{\zeta}$. In [Mét00] and using a result of [Ral71], it is proved that there exists a linearly independent set of vectors $E_{j}^{0}(\zeta), E_{j}^{1}(\zeta)$, analytic with respect to $\zeta \in \Sigma$ in a neighborhood of $\underline{\zeta}$, generating a subspace $F_{j}(\zeta)$ which is stable under $\mathcal{A}(\zeta)$, such that $E_{j}^{0}(\underline{\zeta})=\underline{E}_{j}$ and $E_{j}^{1}(\underline{\zeta})=\underline{P}_{1} \underline{E}_{j}$ and such that the restriction of $\mathcal{A}(\zeta)$ to the subspace $F_{j}(\zeta)$ is given by

$$
Q(\zeta)=i\left(\begin{array}{cc}
\underline{\xi}_{j}+q_{1}(\zeta) & 1  \tag{A.7}\\
q_{2}(\zeta) & \underline{\xi}_{j}
\end{array}\right)
$$

where $q_{1}(\underline{\zeta})=q_{2}(\underline{\zeta})=0$ and where $\frac{\partial q_{2}}{\partial \tau}(\underline{\zeta}) \neq 0$. Among the blocks $\mathcal{A}_{l}(\zeta)$ of the block diagonalization (A.1) of the matrix $\mathcal{A}(\zeta)$ in a neighborhood of $\underline{\zeta}$, there is therefore a $2 \times 2$ block given by $Q(\zeta)$.

The aim is now to study the eigenvalues of the $2 \times 2$ block $Q(\zeta)$ above and to find a continuous determination of the stable eigenvalue in a neighborhood of $\underline{\zeta}$ in $\Sigma$ (and not only in $\Sigma_{0}$ ), namely the Laplace parameter $\gamma$ is allowed to be positive. First the expression of the characteristic polynomial of $Q(\zeta)$ is investigated. It is of degree 2, allowing to obtain an explicit formula for the eigenvalues of $Q(\zeta)$. According to (A.2), in a neighborhood of $\left(\underline{\zeta}, \underline{\xi}_{j}\right)$, we have

$$
\operatorname{det}(\mathcal{A}(\zeta)-i \xi I)=\left(\tau-\tau_{k_{j}}(\eta, \xi)\right) e(\zeta, \xi)
$$

On an other hand, according to the Weierstrass preparation theorem and since $\partial_{\xi} \tau_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)=0$ and $\partial_{\xi}^{2} \tau_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right) \neq 0$, there exists a couple of functions $\left(f_{0}, f_{1}\right)$, analytic with respect to $\underline{\zeta}$, satisfying $f_{0}(\underline{\zeta})=f_{1}(\underline{\zeta})=0$ and such that for $(\zeta, \xi)$ close to $\left(\underline{\zeta}, \underline{\xi}_{j}\right)$,

$$
\begin{equation*}
\tau-\tau_{k_{j}}(\eta, \xi)=\left(\xi^{2}-\left(2 \underline{\xi}_{j}+f_{1}(\zeta)\right) \xi+\underline{\xi}_{j}^{2}+f_{0}(\zeta)\right) e(\zeta, \xi) \tag{A.8}
\end{equation*}
$$

where $e\left(\underline{\zeta}_{,} \underline{\xi}_{j}\right) \neq 0$. Thus

$$
\operatorname{det}(\mathcal{A}(\zeta)-i \xi I)=\left(\xi^{2}-\left(2 \underline{\xi}_{j}+f_{1}(\zeta)\right) \xi+\underline{\xi}_{j}^{2}+f_{0}(\zeta)\right) e(\zeta, \xi)
$$

where $e\left(\underline{\zeta}, \underline{\xi}_{j}\right) \neq 0$. But according to the block decomposition of $\mathcal{A}(\zeta)$ we have

$$
\operatorname{det}(\mathcal{A}(\zeta)-i \xi I)=(\operatorname{det}(Q(\zeta)-i \xi I)) e(\zeta, \xi)
$$

where $e\left(\underline{\zeta}, \underline{\xi}_{j}\right) \neq 0$ so that

$$
\left(\xi^{2}-\left(2 \underline{\xi}_{j}+f_{1}(\zeta)\right) \xi+\underline{\xi}_{j}^{2}+f_{0}(\zeta)\right)=(\operatorname{det}(Q(\zeta)-i \xi I)) e(\zeta, \xi)
$$

where $e\left(\underline{\zeta}, \underline{\xi}_{j}\right) \neq 0$. Since according to (A.7) the $\xi$ polynomial given by $\operatorname{det}(Q(\zeta)-i \xi I)$ is of degree 2 and of leading coefficient -1 , we obtain

$$
\operatorname{det}(Q(\zeta)-i \xi I)=-\left(\xi^{2}-\left(2 \underline{\xi}_{j}+f_{1}(\zeta)\right) \xi+\underline{\xi}_{j}^{2}+f_{0}(\zeta)\right)
$$

By identification, according to (A.7), we get $f_{1}=q_{1}$ and $f_{0}=\underline{\xi}_{j} q_{1}-q_{2}$.
The interest is now made on the behavior of the eigenvalues of $Q(\zeta)$, and therefore on the roots of the polynomial $\xi^{2}-\left(2 \underline{\xi}_{j}+f_{1}(\zeta)\right) \xi+\underline{\xi}_{j}^{2}+f_{0}(\zeta)$, for $\zeta$ in a neighborhood of $\underline{\zeta}$ in $\Sigma$. The

Puiseux expansion theory ensure that for $\gamma>0$ small, the eigenvalues of $Q(\zeta)$ with $\zeta=(\underline{\tau}-i \gamma, \underline{\eta})$ admit an expansion of the form

\xi(\zeta)=\underline{\xi}_{j}+\alpha_{1,2} \gamma^{1 / 2}+O(\gamma)
$$

where the coefficients $\alpha_{1,2}$ are obtained resolving

$$
\left(\alpha_{1,2}\right)^{2}=i\left(\partial_{\tau} f_{0}(\underline{\zeta})-\partial_{\tau} f_{1}(\underline{\zeta}) \underline{\xi}_{j}\right) .
$$

But since $f_{1}=q_{1}$ and $f_{0}=\underline{\xi}_{j} q_{1}-q_{2}$, we have

\partial_{\tau} f_{0}(\underline{\zeta})-\partial_{\tau} f_{1}(\underline{\zeta}) \underline{\xi}_{j}=-\partial_{\tau} q_{2}(\underline{\zeta}) \neq 0
$$

so that $\operatorname{Im} \alpha_{1,2}= \pm c$ where $c>0$. Thus for $\gamma>0, Q(\underline{\tau}-i \gamma, \underline{\eta})$ admits a unique stable eigenvalue $\xi_{j}^{-}(\zeta)$ (namely such that $\operatorname{Im} \xi_{j}^{-}(\zeta)>0$ ) and a unique unstable eigenvalue $\xi_{j}^{+}(\zeta)$ (such that $\left.\operatorname{Im} \xi_{j}^{+}(\zeta)<0\right)$. It is deduced that for $\zeta$ in a neighborhood of $\underline{\zeta}$ in $\Sigma \backslash \Sigma_{0}, Q(\zeta)$ admits a unique stable eigenvalue denoted by $\xi_{j}(\zeta)$. We then seek to continuously extend the eigenvalue $\xi_{j}$ for $\gamma=0$, that is to say we are interested in the root $\xi^{2}-\left(2 \underline{\xi}_{j}+f_{1}(\zeta)\right) \xi+\underline{\xi}_{j}^{2}+f_{0}(\zeta)$ that extends $\xi_{j}(\zeta)$ to a neighborhood of $\underline{\zeta}$ in $\Sigma$. The behavior of this extension $\xi_{j}$ shall then depends on the sign of the discriminant (real when $\zeta$ is real) $\Delta_{j}(\zeta):=4 \underline{\xi}_{j} f_{1}(\zeta)+f_{1}(\zeta)^{2}-4 f_{0}(\zeta)$ which has been represented in Figure 7.


Figure 7. Sign of the discriminant $\Delta_{j}(\zeta)$ in a neighborhood of $\underline{\zeta}$.
When the discriminant $\Delta_{j}(\zeta)$ of this polynomial is negative, the eigenvalue $\xi_{j}(\zeta)$ is necessarily given by

$$
\xi_{j}(\zeta)=\frac{2 \underline{\xi}_{j}+f_{1}(\zeta)+i \sqrt{4 f_{0}(\zeta)-4 \underline{\xi}_{j} f_{1}(\zeta)-f_{1}(\zeta)^{2}}}{2}
$$

since it must be of non-negative imaginary part. When the discriminant $\Delta_{j}(\zeta)$ is zero, $\xi_{j}(\zeta)$ is given by

$$
\xi_{j}(\zeta)=\frac{2 \underline{\xi}_{j}+f_{1}(\zeta)}{2}
$$

The location of the discriminant roots may even be made precise, since it satisfies $\partial_{\tau} \Delta_{j}(\underline{\zeta})=$ $4\left(\partial_{\tau} f_{1}(\underline{\zeta}) \underline{\xi}_{j}-\partial_{\tau} f_{0}(\underline{\zeta})\right) \neq 0$, so according to the implicit functions theorem, there exists an analytic function $\tau_{j}^{g}$ defined in a neighborhood of $\underline{\eta}$ which parameterizes in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$ the set of the discriminant's roots, see Figure 7. Finally, when the discriminant $\Delta_{j}(\zeta)$ is positive, we must determine which one of the real roots

\begin{equation*}
\frac{2 \underline{\xi}_{j}+f_{1}(\zeta) \pm \sqrt{4 \underline{\xi}_{j} f_{1}(\zeta)+f_{1}(\zeta)^{2}-4 f_{0}(\zeta)}}{2} \tag{A.9}
\end{equation*}
$$

continuously extends the stable eigenvalue $\xi_{j}(\zeta)$ when $\gamma=0$. If $\xi_{j}(\zeta)$ refers to the sought eigenvalue until $\gamma=0$, and if we denote $\zeta=(\sigma, \eta):=(\tau-i \gamma, \eta)$, since $\xi_{j}(\zeta)$ is real when $\gamma=0$ and $\operatorname{Im} \xi_{j}(\zeta)>0$ when $\gamma>0$, we have necessarily

$$
\left.\frac{\partial \operatorname{Im} \xi_{j}}{\partial \operatorname{Im} \sigma}\right|_{\gamma=0} \leqslant 0
$$

so that according to the Cauchy-Riemann equations, we must have

$$
\left.\partial_{\tau}\left(\operatorname{Re} \xi_{j}\right)\right|_{\gamma=0} \leqslant 0 .
$$

Thus, if $\partial_{\tau} f_{0}(\underline{\zeta})-\partial_{\tau} f_{1}(\underline{\zeta}) \underline{\xi}_{j}>0$, the real root

$$
\frac{2 \underline{\xi}_{j}+f_{1}(\zeta)+\sqrt{4 \underline{\xi}_{j} f_{1}(\zeta)+f_{1}(\zeta)^{2}-4 f_{0}(\zeta)}}{2}
$$

is the one that continuously extends the stable eigenvalue $\xi_{j}(\zeta)$ when $\gamma=0$, and in the other case, the other root must be chosen. We have therefore obtained of continuous determination of the stable eigenvalue $\xi_{j}(\zeta)$ of the matrix $Q(\zeta)$ in a neighborhood of $\underline{\zeta}$. Note now that an eigenvector of the matrix

$$
\left(\begin{array}{cc}
\underline{\xi}_{j}+q_{1}(\zeta) & 1 \\
q_{2}(\zeta) & \underline{\xi}_{j}
\end{array}\right)
$$

associated with the eigenvalue $\xi_{j}(\zeta)$ writes $\left(1, \frac{q_{2}(\zeta)}{\xi_{j}(\zeta)-\underline{\xi}_{j}}\right)$. One thus gets, using the linearly independent set of vectors $E_{j}^{0}(\zeta), E_{j}^{1}(\zeta)$, an eigenvector $\mathcal{A}(\zeta)$ associated with the stable eigenvalue $i \xi_{j}(\zeta)$ continuous with respect to $\zeta^{4}$.

In a nutshell, in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$, the degenerate imaginary eigenvalue $i \underline{\xi}_{j}$ continuously extends in a stable eigenvalue $i \xi_{j}(\zeta)$ of which the behavior depends on the sign of the discriminant $\Delta_{j}(\zeta)$ in the neighborhood of $\underline{\zeta}$, which has been figured in Figure 7. If $\Delta_{j}(\zeta)$ is negative, then $i \xi_{j}(\zeta)$ is of negative real part so the eigenvalue $i \xi_{j}(\zeta)$ contributes to the elliptic part of the stable subspace $E_{-}(\zeta)$. If $\Delta_{j}(\zeta)$ is positive, then $i \xi_{j}(\zeta)$ is a simple imaginary eigenvalue of $\mathcal{A}(\zeta)$ so it contributes to a subspace $E_{-}^{l}(\zeta)$ with $l$ in $\mathcal{R}(\zeta)$. Finally if $\Delta_{j}(\zeta)$ is zero, the eigenvalue $i \xi_{j}(\zeta)$ remains imaginary and degenerate so it contributes to a subspace $E_{-}^{l}(\zeta)$ with $l$ in $\mathcal{G}(\zeta)$.

We denote now by $i \underline{\xi}_{l}, l=1, \ldots, r$ the real incoming eigenvalues and by $i \underline{\xi}_{l}, l=r+1, \ldots, r+$ $g$ the glancing eigenvalues of the matrix $\mathcal{A}(\underline{\zeta})$. Using the notations of the beginning of the proof, we have found continuous extensions $i \xi_{l}, l=1, \ldots, r+g$, of these eigenvalues in a neighborhood of $\underline{\zeta}$. Therefore, a continuous determination of the stable eigenvalues of the blocks $\mathcal{A}_{1}(\zeta), \ldots, \mathcal{A}_{L}(\zeta)$ has been determined, as well as a continuous basis of the stable subspace $E_{-}(\zeta)$ constituted of generalized eigenvectors of the matrix $\mathcal{A}_{-}(\zeta)$ and of eigenvectors of the matrix $\mathcal{A}(\zeta)$ associated with the eigenvalues $i \xi_{l}(\zeta)$ for $l=1, \ldots, r+g$. Then we denote by $\widetilde{\Pi}_{-}^{e}(\zeta)$ the analytic projector from $E_{-}(\zeta)$ to the stable subspace associated with the elliptic block $\mathcal{A}_{-}(\zeta)$, and, for $l=1, \ldots, r+g, \widetilde{\Pi}_{-}^{l}(\zeta)$ the continuous projector from $E_{-}(\zeta)$ to the eigenspace associated with $i \xi_{l}(\zeta)$. Since these projectors are continuous with respect to $\zeta$ in a neighborhood of $\underline{\zeta}$, they can be assumed to be bounded on this neighborhood.

If $l=1, \ldots, r$, the eigenvalue $i \xi_{l}(\zeta)$ is imaginary and simple in a neighborhood of $\underline{\zeta}$, so, for all $\zeta$, the projector $\widetilde{\Pi}_{-}^{l}(\zeta)$ contributes to a projector $\Pi_{-}^{j}(\zeta)$ for some $j$ (depending on $\zeta$ ) in $\mathcal{R}(\zeta)$. If $l=r+1, \ldots, r+g$, then, depending on the sign of $\Delta_{l}$, the eigenvalue $i \xi_{l}(\zeta)$ may be imaginary and simple, or imaginary and degenerate, or even of nonzero real part, so depending on where $\zeta$ is in a neighborhood of $\underline{\zeta}$, the projector $\widetilde{\Pi}_{-}^{l}(\zeta)$ contributes to $\Pi_{-}^{e}(\zeta)$ (when $\left.\Delta_{l}<0\right)$, to $\Pi_{-}^{j}(\zeta)$ for some $j$ in $\mathcal{G}(\zeta)$ (when $\Delta_{l}=0$ ) or to $\Pi_{-}^{j}(\zeta)$ for some $j$ in $\mathcal{R}(\zeta)$ (when $\Delta_{l}>0$ ). As for it, the projector $\widetilde{\Pi}_{-}^{e}(\zeta)$ always contributes to $\Pi_{-}^{e}(\zeta)$.

We seek now to explicitly describe the projectors $\Pi_{-}^{e}(\zeta)$ and $\Pi_{-}^{j}(\zeta)$ for $j \in \mathcal{R}(\zeta) \cup \mathcal{G}(\zeta)$. To simplify the notations, we assume that among the imaginary eigenvalues $i \xi_{l}$, there is only one of them which is glancing, namely that $g=1$. The expressions of the sought projectors depend on whether the eigenvalue $i \xi_{r+1}(\zeta)$ is incoming, glancing, or of negative real part, and therefore

[^3]on where is $\zeta$ in the neighborhood of $\underline{\zeta}$, see 7 . If $\zeta$ belongs to the area of the neighborhood of $\underline{\zeta}$ where $\Delta_{r+1}(\zeta)>0$, then the eigenvalue $i \xi_{r+1}(\zeta)$ is incoming, so $\mathcal{R}(\zeta)$ is of cardinality $r+1$ and $\mathcal{G}(\zeta)$ is empty. In this case, for all index $j$ in $\mathcal{R}(\zeta)$, we have
$$
\Pi_{-}^{j}(\zeta)=\widetilde{\Pi}_{-}^{l}(\zeta)
$$
for some $l$ between 1 and $r+1$, and
$$
\Pi_{-}^{e}(\zeta)=\widetilde{\Pi}_{-}^{e}(\zeta)
$$

If $\zeta$ is, in the neighborhood of $\underline{\zeta}$, on the hypersurface defined by $\Delta_{r+1}=0$, then $i \xi_{r+1}(\zeta)$ is glancing and in that case $\mathcal{R}(\zeta)$ is of cardinality $r$ and $\mathcal{G}(\zeta)$ is if cardinality 1 . We have therefore, for $j$ in $\mathcal{R}(\zeta)$,

$$
\Pi_{-}^{j}(\zeta)=\widetilde{\Pi}_{-}^{l}(\zeta)
$$

for some $l$ between 1 and $r$, for the index $j$ of $\mathcal{G}(\zeta)$,

$$
\Pi_{-}^{j}(\zeta)=\widetilde{\Pi}_{-}^{r+1}(\zeta)
$$

and

$$
\Pi_{-}^{e}(\zeta)=\widetilde{\Pi}_{-}^{e}(\zeta)
$$

Finally, if $\zeta$ belongs to the area of the neighborhood of $\underline{\zeta}$ where $\Delta_{j}(\zeta)<0$, then $i \xi_{r+1}(\zeta)$ is of negative real part so it contributes to the elliptic part $\bar{E}_{-}(\zeta)$. Thus $\mathcal{R}(\zeta)$ is of cardinality $r$, $\mathcal{G}(\zeta)$ is empty and the extension of the degenerate eigenvalue $i \xi_{r+1}(\zeta)$ contributes to the elliptic part. In this case, for all index $j$ in $\mathcal{R}(\zeta)$, we have

$$
\Pi_{-}^{j}(\zeta)=\widetilde{\Pi}_{-}^{l}(\zeta)
$$

for some $l$ between 1 and $r$, and

$$
\Pi_{-}^{e}(\zeta)=\widetilde{\Pi}_{-}^{e}(\zeta)+\widetilde{\Pi}_{-}^{r+1}(\zeta)
$$

Therefore, since the projectors $\widetilde{\Pi}_{-}^{l}(\zeta), l=1, \ldots, r+1$ and $\widetilde{\Pi}_{-}^{e}(\zeta)$ are bounded uniformly with respect to $\zeta$ in a neighborhood of $\underline{\zeta}$, we deduce that the projectors $\Pi_{-}^{e}(\zeta)$ and $\Pi_{-}^{j}(\zeta)$ for $j \in$ $\mathcal{R}(\zeta) \cup \mathcal{G}(\zeta)$ are bounded uniformly with respect to $\zeta$ in a neighborhood of $\underline{\zeta}$, which concludes the proof of Proposition 2.21.

In the general case where there are multiple glancing eigenvalues $i \underline{\xi}_{l}$ (namely when $g \geqslant 1$ ), the projectors $\Pi_{-}^{e}(\zeta)$ and $\Pi_{-}^{j}(\zeta)$ for $j \in \mathcal{R}(\zeta) \cup \mathcal{G}(\zeta)$ can still be expressed using the projectors $\widetilde{\Pi}_{-}^{l}(\zeta), l=1, \ldots, r+g$ and $\widetilde{\Pi}_{-}^{e}(\zeta)$. Since the expression of $\Pi_{-}^{e}(\zeta)$ will be needed in the proof of Proposition 6.16 below, it is given here. For $\zeta$ in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$, we have

$$
\begin{equation*}
\Pi_{-}^{e}(\zeta)=\widetilde{\Pi}_{-}^{e}(\zeta)+\sum_{j=r+1}^{r+g} \mathbb{1}_{\Delta_{j}(\zeta)<0} \widetilde{\Pi}_{-}^{j}(\zeta) \tag{A.10}
\end{equation*}
$$

A.2. Proof of Lemma 2.22. The following proof of Lemma 2.22 uses results and notations from the previous one, and is therefore given now. First we recall the statement of the Lemma.
Lemma A.2. There exists a positive constant $C>0$ such that, if the real frequency $\alpha=(\tau, \eta, \xi)$ in $\mathbb{R}^{1+d} \backslash\{0\}$ is characteristic, and if $k$ between 1 and $N$ is such that $\tau=\tau_{k}(\eta, \xi)$, then we have

$$
\left|\partial_{\xi} \tau_{k}(\eta, \xi)\right| \geqslant C \frac{\operatorname{dist}((\tau, \eta), \mathcal{G})^{1 / 2}}{|\tau, \eta|^{1 / 2}}
$$

Using Lemma 2.15, we therefore obtain the following estimate

\begin{equation*}
\left|\tilde{\pi}_{\alpha} E_{k}(\eta, \xi)\right| \geqslant C \frac{\operatorname{dist}((\tau, \eta), \mathcal{G})^{1 / 2}}{|\tau, \eta|^{1 / 2}} \tag{A.11}
\end{equation*}
$$

Proof. The interest is made at first in the first equality, which is proved using the homogeneity of degree zero of $\partial_{\xi} \tau_{k}(\eta, \xi)$ and of degree one of the distance. The analysis is therefore made on the sphere $\Sigma_{0}$, and we denote, for $\zeta$ in $\Sigma_{0}$,

m_{g}(\zeta)=\left\{\begin{array}{cl}
1 & \text { if } \operatorname{sp}(\mathcal{A}(\zeta)) \cap i \mathbb{R}=\emptyset \\
\min _{\substack{j \in \mathcal{G}(\zeta) \cup \\
\mathcal{R}(\zeta) \cup \mathcal{S}(\zeta)}}\left|\partial_{\xi} \tau_{k_{j}}\left(\eta, \xi_{j}(\zeta)\right)\right| & \text { otherwise }
\end{array}\right.
$$

where $\operatorname{sp}(\mathcal{A}(\zeta))$ refers to the spectrum of the matrix $\mathcal{A}(\zeta)$, and where the notations $k_{j}$ and $\xi_{j}(\zeta)$ has been introduced in Proposition 2.16. Using the compactness of the sphere $\Sigma_{0}$, it will be proved that $m_{g}$ satisfies

$$
\begin{equation*}
m_{g}(\zeta) \geqslant C \operatorname{dist}(\zeta, \mathcal{G})^{1 / 2} \tag{A.12}
\end{equation*}
$$

for all $\zeta$ in $\Sigma_{0}$, where $C>0$ is a suitable fixed constant. We thus consider $\underline{\zeta}:=(\underline{\tau}, \underline{\eta})$ in $\Sigma_{0}$, and we show that there exists a neighborhood $\mathcal{V}$ of $\underline{\zeta}$ in which the previous equality (A.12) is satisfied.

We recall the results obtained in the proof of Proposition 2.21, in which a continuous determination of the eigenvalues of $\mathcal{A}(\zeta)$ for $\zeta$ in a neighborhood of $\underline{\zeta}$ has been determined. The previous proof focused on describing the stable eigenvalues, but it can be immediately extended to all eigenvalues of $\mathcal{A}(\zeta)$. Denote by $i \underline{\xi}_{j}$ the imaginary eigenvalues of $\mathcal{A}(\underline{\zeta})$. If the imaginary eigenvalue $i \underline{\xi}_{j}$ is not glancing, the proof of the Proposition 2.21 yields to a continuous extension $i \xi_{j}(\zeta)$ in a neighborhood of $\underline{\zeta}$, which is an eigenvalue of $\mathcal{A}(\zeta)$. If $i \underline{\xi}_{j}$ is glancing, then we obtain, in a neighborhood of $\underline{\zeta}$, two continuous eigenvalues $i \xi_{j}^{-}(\zeta)$ and $i \xi_{j}^{+}(\zeta)$ extending $i \underline{\xi}_{j}$, which are possibly equals (when they are glancing). Finally, the block structure 2.9 and the Proposition 2.21 provide a basis of $\mathbb{C}^{N}$ in which the matrix $\mathcal{A}(\zeta)$ is, in a neighborhood of $\underline{\zeta}$, block diagonal, with a block $\mathcal{A}_{ \pm}(\zeta)$ with eigenvalues of nonzero real part, and scalar blocks corresponding to the eigenvalues $i \xi_{j}(\zeta)$. Three cases are then to be investigated.

- All eigenvalues of $\mathcal{A}_{ \pm}(\zeta)$ are of nonzero real part in a neighborhood of $\underline{\zeta}$, so they don't contribute to $m_{g}(\zeta)$.
- If $i \underline{\xi}_{j}$ is imaginary and $\partial_{\xi} \tau_{k_{j}}\left(\underline{\eta}, \xi_{j}(\underline{\tau}, \underline{\eta})\right) \neq 0$, namely if the real characteristic frequency $\alpha_{j}(\underline{\zeta})$ is incoming or outgoing, then it has been proven that the eigenvalue $i \xi_{j}(\zeta)$ is still incoming or outgoing in a neighborhood of $\underline{\zeta}$. Furthermore, according to equation (A.3) differentiated with respect to $\xi$ and evaluated in $\xi=\xi_{j}(\zeta)$, for $\zeta$ in a neighborhood of $\underline{\zeta}$, we have

$$
\partial_{\xi} \tau_{k_{j}}\left(\eta, \xi_{j}(\zeta)\right)=-e\left(\eta, \xi_{j}(\zeta)\right),
$$

where $e$ is an analytic function nonzero in $\underline{\zeta}$, which is therefore lower bounded in a neighborhood of $\left(\underline{\zeta}, \xi_{j}(\underline{\zeta})\right)$. Thus, for $\zeta$ in a neighborhood of $\underline{\zeta}$, we have

$$
\left|\partial_{\xi} \tau_{k_{j}}\left(\eta, \xi_{j}(\zeta)\right)\right| \geqslant C,
$$

with $C>0$.

- Finally, if $i \underline{\xi}_{j}$ is glancing, namely if $i \underline{\xi}_{j}$ is imaginary and $\partial_{\xi} \tau_{k_{j}}\left(\underline{\eta}, \underline{\xi}_{j}\right)=0$, then $i \underline{\xi}_{j}$ is extended by two eigenvalues $i \xi_{j}^{ \pm}(\zeta)$, of which the behavior depends on where $\zeta$ is in the neighborhood of $\underline{\zeta}$, see Figure 7. Denote by $\Delta_{j}(\zeta)$ the discriminant of the characteristic polynomial of the $2 \times 2$ block associated with the glancing eigenvalue. If $\zeta$ is such that $\Delta_{j}(\zeta)<0$, then the two eigenvalues $i \xi_{j}^{ \pm}(\zeta)$ are of nonzero real part, so they do not contribute to $m_{g}(\zeta)$. If $\Delta_{j}(\zeta)=0$, then $\xi_{j}^{-}(\zeta)=\xi_{j}^{+}(\zeta)$ and the characteristic frequency $\left(\zeta, \xi_{j}^{ \pm}(\zeta)\right)$ is glancing, so the equality (A.12) is immediately satisfied. Finally, if $\Delta_{j}(\zeta)>0$, then the two distinct eigenvalues $i \xi_{j}^{ \pm}(\zeta)$ are imaginary, and contributes to $m_{g}(\zeta)$. According to the relation (A.8), differentiate with respect to $\xi$ and evaluated in $\xi=\xi_{j}^{+}(\zeta)$, we have, for
$\zeta=(\tau, \eta)$ in a neighborhood of $\underline{\zeta}$,

$$
\partial_{\xi} \tau_{k_{j}}\left(\eta, \xi_{j}^{+}(\zeta)\right)=2\left(f_{1}(\zeta) / 2+\underline{\xi}_{j}-\xi_{j}^{+}(\zeta)\right) e\left(\zeta, \xi_{j}^{+}(\zeta)\right),
$$

where $e$ is an analytic function, nonzero in $\left(\underline{\zeta}, \underline{\xi}_{j}\right)$. According to the expression (A.9) of the roots $\xi_{j}^{ \pm}(\zeta)$, we obtain

$$
\partial_{\xi} \tau_{k_{j}}\left(\eta, \xi_{j}^{+}(\zeta)\right)= \pm \sqrt{\Delta_{j}(\zeta)} e\left(\zeta, \xi_{j}^{+}(\zeta)\right)
$$

But, according to the proof of Proposition 2.21 above, one may write, for $\zeta=(\tau, \eta)$ in a neighborhood of $\underline{\zeta}$,

$$
\Delta_{j}(\zeta)=\left(\tau-\tau_{j}^{g}(\eta)\right) e(\zeta)
$$

where $e$ is an analytic function, nonzero in $\underline{\zeta}$, and where the function $\tau_{j}^{g}$ parameterizes the surface of the zeros of $\Delta_{j}$. We finally infer

$$
\left|\partial_{\xi} \tau_{k_{j}}\left(\eta, \xi_{j}^{+}(\zeta)\right)\right| \geqslant C\left|\tau-\tau_{j}^{g}(\eta)\right|^{1 / 2}=C\left|(\tau, \eta)-\left(\tau_{j}^{g}(\eta), \eta\right)\right|^{1 / 2} \geqslant C \operatorname{dist}(\zeta, \mathcal{G})^{1 / 2}
$$

since the frequency $\left(\tau_{j}^{g}(\eta), \eta\right)$ is glancing by construction of $\tau_{j}^{g}$. The same arguments apply to $i \xi_{j}^{-}(\zeta)$.
Up to reducing the constant $C$, we have therefore proved the existence of a neighborhood $\mathcal{V}$ in which the equality (A.12) is satisfied. The result follows from the compactness of $\Sigma_{0}$ and by homogeneity.

The second inequality of the Lemma 2.22 is obtained immediately using the result of Lemma 2.15.
A.3. Proof of Proposition 6.16. The following proof also comes after the one of Proposition 2.21.

We recall that $\Pi_{-}^{e}(\zeta)$ is the projector from $E_{-}(\zeta)$ on the elliptic stable component $E_{-}^{e}(\zeta)=$ $\oplus_{j \in \mathcal{P}(\zeta)} E_{-}^{j}(\zeta)$ according to the decomposition (2.23) and that, when $\zeta$ is not glancing, $\Pi_{\mathbb{C}^{N}}^{e}(\zeta)$ is the projection from $\mathbb{C}^{N}$ on the stable elliptic component $E_{-}^{e}(\zeta)$ according decomposition (2.25). The statement of Proposition 6.16 reads as follows.

Proposition A.3. Under Assumption 6, there exists a constant $c_{1}>0$ and a real number $b_{1}$ such that, for all $\zeta$ in $\mathcal{F}_{b} \backslash\{0\}$, the following estimates hold

$$
\begin{array}{ll}
\left|e^{t \mathcal{A}(\zeta)} \Pi_{-}^{e}(\zeta)\right| \leqslant c_{1} e^{-c_{1} t|\zeta|^{-b_{1}}} \leqslant c_{1}, & \forall t \geqslant 0,  \tag{A.13a}\\
\left|e^{t \mathcal{A}(\zeta)} \Pi_{\mathbb{C}^{N}}^{e}(\zeta)\right| \leqslant c_{1}|\zeta|^{b_{1}} e^{-c_{1} t|\zeta|^{-b_{1}},} & \forall t \geqslant 0, \\
\left|e^{t \mathcal{A}(\zeta)}\left(I-\Pi_{\mathbb{C}^{N}}^{e}(\zeta)\right)\right| \leqslant c_{1}|\zeta|^{b_{1}}, & \forall t \leqslant 0 .
\end{array}
$$

Proof. The homogeneity of degree 1 of the matrix $\mathcal{A}(\zeta)$ and of degree zero of the projectors $\Pi_{-}^{e}(\zeta)$ and $\Pi_{\mathbb{C}^{N}}^{e}(\zeta)$, and the compactness of the unit ball $\Sigma_{0}$ are used, and we therefore work in a neighborhood of every point $\underline{\zeta}$ of $\Sigma_{0}$. The result is then extended to a finite conic covering of $\Xi_{0}$. Since the projector $\Pi_{\mathbb{C}^{N}}^{e}(\zeta)$ is defined only for $\zeta$ non glancing, for inequalities (A.13b) and (A.13c) where it occurs, we are only interested in the points of the neighborhood of $\underline{\zeta}$ which are not glancing. Thus we consider a point $\underline{\zeta}$ of $\Sigma_{0}$ and we come back to the notations of the proof of Proposition 2.21.

The interest is first made on the first estimate (A.13a). In the proof of Proposition 2.21, we have constructed, in a neighborhood of $\underline{\zeta}$, a continuous basis of $E_{-}(\zeta)$ associated with a regular change-of-basis matrix $T(\zeta)$ in which the matrix $\mathcal{A}(\zeta)$ restricted to $E_{-}(\zeta)$ is the following block
diagonal matrix of size $p \times p$

$$
\left(\begin{array}{cccc}
\mathcal{A}_{-}(\zeta) & & & 0 \\
& i \xi_{1}(\zeta) I_{\omega_{1}} & & \\
& & \ddots & \\
0 & & & i \xi_{r+g}(\zeta) I_{\omega_{r+g}}
\end{array}\right)
$$

constituted of a block $\mathcal{A}_{-}(\zeta)$ of negative definite real part, of diagonal blocks $i \xi_{j}(\zeta) I_{\omega_{j}}, j=$ $1, \ldots, r$ associated with the incoming eigenvalues $\underline{\xi}_{j}$ and of diagonal blocks $i \xi_{j}(\zeta) I_{\omega_{j}}, j=r+$ $1, \ldots, r+g$ associated with the eigenvalues $\underline{\xi}_{j}$ which are glancing in $\underline{\zeta}$. In that case, according to the expression (A.10) of the projector $\Pi_{-}^{e}(\zeta)$ in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$, the linear map $e^{t \mathcal{A}(\zeta)} \Pi_{-}^{e}(\zeta)$ from $E_{-}(\zeta)$ to itself is given, in the basis associated with the matrix $T(\zeta)$, by the following $p \times p$ block diagonal matrix

$$
\left(\begin{array}{cccc}
e^{t \mathcal{A}_{-}(\zeta)} & & & \\
& 0 & & \\
& & e^{i t \xi_{r+1}(\zeta)} \mathbb{1}_{\Delta_{r+1}(\zeta)<0} I_{\omega_{r+1}} & \\
& & \ddots & \\
& & & e^{i t \xi_{r+g}(\zeta)} \mathbb{1}_{\Delta_{r+g}(\zeta)<0} I_{\omega_{r+g}}
\end{array}\right)
$$

On one hand, the block $\mathcal{A}_{-}(\zeta)$ is of negative definite real part, uniformly with respect to $\zeta$. On the other hand, one can check that

$$
\operatorname{Im} \xi_{r+l}(\zeta)=\left|\Delta_{r+l}(\zeta)\right|^{1 / 2} / 2
$$

for $l=1, \ldots, g$, where $\Delta_{r+l}(\zeta)$ refers to the discriminant of the characteristic polynomial associated with the glancing eigenvalue $\underline{\xi}_{r+l}$ defined in the proof of Proposition 2.21 and is figured in Figure 7. But one can write, in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$,

$$
\Delta_{j}(\zeta)=\left[\tau-\tau_{j}^{g}(\eta)\right] e(\zeta)
$$

with $e(\underline{\zeta}) \neq 0$, where we recall that $\tau_{j}^{g}$ parameterizes in $\Sigma_{0}$ the surface of cancellation of $\Delta_{j}$. It yields to the following estimate on $\Delta_{j}$,

$$
\begin{equation*}
\left|\Delta_{j}(\zeta)\right| \geqslant C\left|\tau-\tau_{j}^{g}(\eta)\right|=C\left|\zeta-\left(\tau_{j}^{g}(\eta), \eta\right)\right| \geqslant C \operatorname{dist}(\zeta, \mathcal{G}) \tag{A.14}
\end{equation*}
$$

Since the matrix $T$ is regular, and therefore uniformly bounded with respect to $\zeta$ in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$, according (A.14), we get

$$
\begin{equation*}
\left|e^{t \mathcal{A}(\zeta)} \Pi_{-}^{e}(\zeta)\right| \leqslant C e^{-C \operatorname{dist}(\zeta, \mathcal{G})^{1 / 2} t} \tag{A.15}
\end{equation*}
$$

We consider now $\zeta$ in a conic neighborhood of $\underline{\zeta}$ in $\Xi_{0}$ with $\zeta=\lambda \zeta^{*}$ where $\lambda=|\zeta| \in \mathbb{R}_{+}^{*}$ and $\zeta^{*}$ is in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$. Then, by homogeneity and using (A.15) and Assumption 6, we obtain

$$
\begin{aligned}
&\left|e^{t \mathcal{A}(\zeta)} \Pi_{-}^{e}(\zeta)\right|=\left|e^{\lambda t \mathcal{A}\left(\zeta^{*}\right)} \Pi_{-}^{e}\left(\zeta^{*}\right)\right| \leqslant C e^{-C \operatorname{dist}\left(\zeta^{*}, \mathcal{G}\right)^{1 / 2} \lambda t} \\
&=C e^{-C \operatorname{dist}\left(\lambda \zeta^{*}, \mathcal{G}\right)^{1 / 2} \lambda^{1 / 2} t} \leqslant C e^{-C|\zeta|^{\left(a_{1}+1\right) / 2} t}
\end{aligned}
$$

Finally the inequality extends to the whole space $\Xi_{0}$ by compactness of $\Sigma_{0}$, yielding to the required inequality (A.13a) for all $\zeta$ in $\mathcal{F}_{b} \backslash\{0\}$.

Concerning estimate (A.13b), note that, for $t \geqslant 0$ and for $\zeta$ non glancing,

$$
e^{t \mathcal{A}(\zeta)} \Pi_{\mathbb{C}^{N}}^{e}(\zeta)=e^{t \mathcal{A}(\zeta)} \Pi_{-}^{e}(\zeta) \Pi_{\mathbb{C}^{N}}^{-}(\zeta),
$$

where $\Pi_{\mathbb{C}^{N}}^{-}(\zeta)$ is the projector from $\mathbb{C}^{N}$ to the stable subspace $E_{-}(\zeta)$ according to the decomposition (2.25), defined for $\zeta$ non glancing. The aim is therefore to control the projector $\Pi_{\mathbb{C}^{N}}^{-}(\zeta)$, and then use the inequality (A.13a) to conclude. We still work in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$ and, to simplify the notations, we assume that there exists in $\underline{\zeta}$ a unique glancing eigenvalue $\underline{\xi}_{g}$ of algebraic multiplicity 2 .

Applying the arguments of the proof of Proposition 2.21 to the unstable part $E^{+}(\zeta)$, one obtain an analytic basis

$$
E_{1}(\zeta), \ldots, E_{N}(\zeta)
$$

of $\mathbb{C}^{N}$ associated with a change-of-basis matrix $\widetilde{T}(\zeta)$, analytic in a neighborhood of $\underline{\zeta}$ in $\Sigma_{0}$, such that in this basis, the linear map $\mathcal{A}(\zeta)$ writes

$$
\widetilde{T}(\zeta)^{-1} \mathcal{A}(\zeta) \widetilde{T}(\zeta)=\operatorname{diag}\left(\mathcal{A}_{-}(\zeta), \mathcal{A}_{1}(\zeta), Q(\zeta), \mathcal{A}_{+}(\zeta), \mathcal{A}_{2}(\zeta)\right)
$$

where $\mathcal{A}_{-}(\zeta)$ is of negative definite real part, $\mathcal{A}_{1}(\zeta)$ is the diagonal block associated with the incoming eigenvalues, $\mathcal{A}_{+}(\zeta)$ is of positive definite real part, $\mathcal{A}_{2}(\zeta)$ is the diagonal block associated with the outgoing eigenvalues, and the unique $2 \times 2$ block $Q(\zeta)$, associated with the glancing eigenvalue $\underline{\xi}_{g}$, writes

$$
Q(\zeta)=i\left(\begin{array}{cc}
\underline{\xi}_{g}+q_{1}(\zeta) & 1 \\
q_{2}(\zeta) & \underline{\xi}_{g}
\end{array}\right)
$$

where $q_{1}(\underline{\zeta})=q_{2}(\underline{\zeta})=0$ and $\frac{\partial q_{2}}{\partial \tau}(\underline{\zeta}) \neq 0$.
We want now to construct, using the basis $E_{1}, \ldots, E_{N}$, a new basis $F_{1}, \ldots, F_{N}$ adapted to the decomposition

$$
\mathbb{C}^{N}=E_{-}(\zeta) \oplus E_{+}(\zeta)
$$

for $\zeta$ non glancing. If $E_{1}(\zeta), \ldots, E_{p-1}(\zeta)$ are the $p-1$ first vectors corresponding to the blocks $\mathcal{A}_{-}(\zeta)$ and $\mathcal{A}_{1}(\zeta)$ of the basis of $\mathbb{C}^{N}$ associated with $T(\zeta)$, we set, for $j=1, \ldots, p-1, F_{j}(\zeta):=$ $E_{j}(\zeta)$. Note that $F_{1}(\zeta), \ldots, F_{p-1}(\zeta)$ is therefore a set of linearly independent vectors of $E_{-}(\zeta)$. We set as well $F_{j}(\zeta):=E_{j}(\zeta)$ for $j=p+2, \ldots, N$, where $E_{p+2}(\zeta), \ldots, E_{N}(\zeta)$ are the vectors of the basis of $\mathbb{C}^{N}$ defined by $T(\zeta)$ associated with the blocks $\mathcal{A}_{+}(\zeta)$ and $\mathcal{A}_{2}(\zeta)$, constituting a set of linearly independent vectors of $E_{+}(\zeta)$.

The two vectors $F_{p}(\zeta)$ and $F_{p+1}(\zeta)$ are now to be determined, which are the stable and unstable eigenvectors of $\mathcal{A}(\zeta)$ associated with the block $Q(\zeta)$. If $\xi_{-}(\zeta), \xi_{+}(\zeta)$ are the two stable and unstable eigenvalues (equal for $\zeta$ glancing) associated with the glancing eigenvalue $\underline{\xi}_{g}$, then the stable and unstable eigenvectors of $\mathcal{A}(\zeta)$ associated with $\xi_{-}(\zeta)$ and $\xi_{+}(\zeta)$ are given by

$$
F_{p}(\zeta):=E_{p}(\zeta)+\frac{q_{2}(\zeta)}{\xi_{-}(\zeta)-\underline{\xi}_{g}} E_{p+1}(\zeta), \quad F_{p+1}(\zeta):=E_{p}(\zeta)+\frac{q_{2}(\zeta)}{\xi_{+}(\zeta)-\underline{\xi}_{g}} E_{p+1}(\zeta)
$$

Indeed, an eigenvector of the matrix $\widetilde{T}(\zeta)^{-1} \mathcal{A}(\zeta) \widetilde{T}(\zeta)$ associated with the eigenvalue $\xi_{ \pm}(\zeta)$ is given by ${ }^{t}\left(0, \ldots, 0,1, \frac{q_{2}(\zeta)}{\xi_{ \pm}(\zeta)-\underline{\xi}_{g}}, 0, \ldots, 0\right)$. Note that when $\zeta$ est glancing, namely when $\xi_{-}(\zeta)=$ $\xi_{+}(\zeta)$ and $q_{2}(\zeta)=0$, we have $F_{p}(\zeta)=F_{p+1}(\zeta)=E_{p}(\zeta)$.

The change-of-basis matrix from the canonical basis of $\mathbb{C}^{N}$ to the basis $F_{1}, \ldots, F_{N}$ is therefore given by the product of the matrix $T(\zeta)$ and the block diagonal matrix

$$
P(\zeta):=\operatorname{diag}\left(I_{p-1},\left(\begin{array}{cc}
1 & 1 \\
\frac{q_{2}(\zeta)}{\xi_{-}(\zeta)-\underline{\xi}_{g}} & \frac{q_{2}(\zeta)}{\xi_{+}(\zeta)-\underline{\xi}_{g}}
\end{array}\right), I_{N-p-1}\right) .
$$

Thus the projector $\Pi_{\mathbb{C}^{N}}^{-}$writes

$$
\Pi_{\mathbb{C}^{N}}^{-}=T(\zeta) P(\zeta)\left(\begin{array}{cc}
I_{p} & 0 \\
0 & 0
\end{array}\right) P(\zeta)^{-1} T(\zeta)^{-1}
$$

The matrix $T(\zeta)$ is analytic and therefore bounded as well as its inverse in a neighborhood of $\underline{\zeta}$. Since it has already been proven that $\frac{q_{2}(\zeta)}{\xi_{-}(\zeta)-\underline{\xi}_{g}}$ and $\frac{q_{2}(\zeta)}{\xi_{+}(\zeta)-\underline{\xi}_{g}}$ are bounded in a neighborhood of $\underline{\zeta}$, the matrix $P(\zeta)$ and ${ }^{t} \operatorname{com} P(\zeta)$ are bounded. The determinant $\operatorname{det} P(\zeta)$ shall now be estimated. Since $\xi_{-}(\zeta)$ and $\xi_{+}(\zeta)$ are the two (possibly equal) roots of the polynomial $\xi^{2}-$ $\left(2 \underline{\xi}_{g}+q_{1}(\zeta)\right) \xi+\underline{\xi}_{g}^{2}+\underline{\xi}_{g} q_{1}(\zeta)-q_{2}(\zeta)$, we obtain

$$
\left(\xi_{-}(\zeta)-\underline{\xi}_{g}\right)\left(\xi_{+}(\zeta)-\underline{\xi}_{g}\right)=-q_{2}(\zeta)
$$

so that

$$
\operatorname{det} P(\zeta)=\frac{q_{2}(\zeta)\left(\xi_{-}(\zeta)-\xi_{+}(\zeta)\right)}{\left(\xi_{-}(\zeta)-\underline{\xi}_{g}\right)\left(\xi_{+}(\zeta)-\underline{\xi}_{g}\right)}=-\left(\xi_{-}(\zeta)-\xi_{+}(\zeta)\right)
$$

It yields to

$$
|\operatorname{det} P(\zeta)|=\left|\Delta_{g}(\zeta)\right|^{1 / 2} \geqslant C \operatorname{dist}(\zeta, \mathcal{G})^{1 / 2}
$$

according to estimate (A.14). The control (A.13b) follows in the same way as the one of (A.13a) using estimate (A.13a) and Assumption 6.

Finally, for estimate (A.13c), taking back the notations and the results of the previous point, the matrix $e^{t \mathcal{A}(\zeta)}\left(I-\Pi_{\mathbb{C}^{N}}^{e}(\zeta)\right)$ can be written as

$$
\begin{aligned}
& e^{t \mathcal{A}(\zeta)}\left(I-\Pi_{\mathbb{C}^{N}}^{e}(\zeta)\right)= \\
& \widetilde{T}(\zeta)^{-1} P(\zeta)^{-1}\left(\begin{array}{cccc}
0 & & \\
e^{t \mathcal{A}_{1}(\zeta)} & \\
& & e^{t Q(\zeta)} \mathbb{1}_{\Delta_{g}(\zeta)>0} & \\
0 & & \\
\\
& & & e^{t \mathcal{A}_{+}(\zeta)} \\
\\
& & & \\
e^{t \mathcal{A}_{2}(\zeta)}
\end{array}\right) P(\zeta) \widetilde{T}(\zeta)
\end{aligned}
$$

Note that the eigenvalues of the matrices $\mathcal{A}_{1}(\zeta), \mathcal{A}_{2}(\zeta)$ and of the matrix $Q(\zeta)$ when $\Delta_{g}(\zeta)>0$, are imaginary, and that the matrix $\mathcal{A}_{+}(\zeta)$ is of positive definite real part uniformly with respect to $\zeta$. Thus, using the estimate on the change-of-basis matrix $P(\zeta)^{-1}$ proved above, one may conclude as for the estimate (A.13c).

Thus the following limit holds $\frac{q_{2}(\zeta)}{\xi_{j}(\zeta)-\underline{\xi}_{j}} \xrightarrow[\zeta \rightarrow \underline{\zeta}]{\longrightarrow} 0$, and the considered eigenvector continuously depends on $\zeta$ in a neighborhood of $\underline{\zeta}$
