#### Abstract

Earthworms contribute to a wide range of ecosystem services in agriculture. Most studies focusing on impacts of annual crop management on earthworm communities are related to soil tillage, fertilisation or pesticides, while the effect of introducing temporary grassland into an annual crop rotation remains largely unknown. In this context, the aims of the present study were to evaluate effects of (i) introducing grassland into a crop rotation, (ii) grassland duration and (iii) grassland fertilisation on earthworm communities and grassland forage production in a long-term experimental station in western France. Three years of highly fertilised (230 kg ha<sup>-1</sup> yr<sup>-1</sup> of mineral nitrogen) grassland preceded by three years of annual crop rotation was compared to an annual crop rotation without grassland and to six years of grassland either lightly (30 kg ha<sup>-1</sup> yr<sup>-1</sup> of mineral nitrogen) or highly (230 kg ha<sup>-1</sup> yr<sup>-1</sup> of mineral nitrogen) fertilised. Grassland introduction into a crop rotation significantly increased earthworm abundance, biomass, and diversity, especially for anecic species, and improved the functional structure of the earthworm community. Grassland duration and fertilisation increased earthworm abundance and biomass, especially for anecics, without affecting endogeic species and earthworm diversity. Grassland duration did not increase forage production, but the increase in fertilisation did. Three years of highly fertilised grassland significantly increased earthworm abundance and biomass, improved the functional structure of the earthworm community and produced as much forage per year as six years of highly fertilised grassland. Overall, the introduction of grassland into annual crop rotations appears an effective way to rapidly increase earthworm community parameters and, given the important role of earthworms in soils, enhance soil functioning.

#### 1. Introduction

In response to global changes, and because farmers are facing crucial issues, annual cropping systems are changing; focussing not only on fertility performance (yield), but also seeking to promote other ecosystem services supported by soils, such as climate regulation through carbon sequestration, water flux and water quality regulation, maintenance of soil structure to limit soil erosion, and biodiversity conservation (Albizua et al., 2015; Keesstra et al., 2016; Chabbi et al., 2017). Therefore, even if the economical aspect is a crucial pillar for farmers, environmental and social sustainability are becoming more important leading to increasingly complex rotations that include temporary grassland (Albizua et al., 2015; Lemaire et al., 2015; Tsiafouli et al., 2015). Introducing grassland into an annual crop rotation has several demonstrated benefits, including improving soil structure (Loaiza Puerta et al., 2018), soil organic matter storage (Crème et al., 2018; Panettieri et al., 2017), yield of subsequent crops (Franzluebbers et al., 2014) and soil organism community parameters (van Eekeren et al., 2008; Postma-Blaauw et al., 2010; Tsiafouli et al., 2015). Earthworms are known to play an important role in the provision of soil ecosystem services (Blouin et al., 2013) including contributing to element regulation (Marinissen and de Ruiter, 1993), plant production (van Groenigen et al., 2014), soil structure maintenance (Blanchart et al., 2009; Pérès et al., 2010) and water regulation (Bastardie et al., 2003), which are particularly valued in agricultural environments (Bertrand et al., 2015). There is considerable evidence that the implementation of an annual crop after a grassland leads to a rapid decrease in earthworm abundance and diversity, however, the effects of introducing grassland after annual crops on earthworm communities remain poorly studied (van Eekeren et al., 2008; Postma-Blaauw et al., 2010; Crotty et al., 2016). The available literature tends to be biased towards experimental sites with limited (3-5 species) earthworm diversity (van Eekeren et al., 2008;

Postma-Blaauw et al., 2010). However, it is widely reported that earthworm diversity may be much higher in agricultural contexts ranging from six to eleven species per field (Cluzeau et al., 2012; Richard et al., 2012). Therefore, effects of introducing grassland after annual crops could modify the development earthworm communities (Bouché, 1977; Satchell, 1980; Butt, 1993) and their contribution to ecosystem services.

Since earthworms are influenced by the presence and quality of food and soil properties (Curry, 2004; Rutgers et al., 2016; Hoeffner et al., 2021), grassland management factors such as stocking rate, cutting frequency and fertilisation modify earthworm communities (Cluzeau et al., 1992; Muldowney et al., 2003; Bueno and Jiménez, 2014). For example, in grassland Curry et al., (2008) observed positive relationships between nitrogen (N) application and earthworm abundance and biomass. Mineral fertilization, by increasing primary production, increases the food supply for earthworms and increases protection against predators and climatic hazards (Curry et al., 2008; Mariotte et al., 2016; Stroud, 2020). However, to our knowledge, no previous study focused on the impact of N application on the restoration of grassland earthworm communities.

The first objective of the present study was to evaluate both the effects of introducing grassland into an annual crop rotation and grassland duration on the composition of the earthworm community and grassland forage production. We hypothesised that introducing grassland into a crop rotation would have a positive effect on earthworm community parameters that in turn would increase with grassland duration. The second objective was to evaluate the effects of grassland mineral fertilisation on the composition of earthworm communities and grassland forage production. We hypothesised that fertilising grassland would have a positive effect on earthworm community parameters and forage production. A treatment of three years of fertilised grassland preceded by three years of annual crop rotation (grain maize, wheat and lastly

barley) was compared to treatments of six years of an annual crop rotation without grassland (grain maize, wheat, barley, grain maize, wheat and lastly barley) and six years of fertilised grassland (fertilised either highly or lightly).

#### 2. Materials and methods

## 2.1 Site description and experimental design

The experimental site is part of the Agro-ecosystems, Biogeochemical Cycles and Biodiversity long-term experimental stations on environmental research (SOERE ACBB), managed by the French National Institute of Agricultural Research and Environment (INRAE), located in Lusignan (46°25′12.91″ N; 0°07′29.35″ E), France. The climate is oceanic, with a mean annual precipitation of 796 mm and mean annual temperature of 11.4 °C, a monthly minimum of -1.9 °C and a monthly maximum of 30.6 °C (data from Agroclim, 2006-2011). In 2011, soil cores (0-30 cm depth) were collected at 16 locations to characterise bulk density, pH and carbon (C) and nitrogen (N) content for the site. Soil cores were sent to the analytical laboratory of INRAE (Arras, France) for pH, C and N measurements following the NF ISO 10390, 10694 and 13878 respectively. Bulk density was measured with calibrated cylinders. The soil is a Plinthic Cambisol (Moni et al., 2010) with a silt loam texture, the 0-30 cm soil layer is characterised by a pH-H<sub>2</sub>0 of 6.67, C content of 10.67 mg g<sup>-1</sup>, N content of 1.27 mg g<sup>-1</sup> and bulk density of 1.48 g cm<sup>-3</sup> (Supplementary Table S1, data from Arras, France, soil analysis laboratory).

Experimental treatments were established in 2005 and management of the crops and grasslands was ensured according to agricultural practices to achieve yields and forage production close to the potential determined in the region by soil and climate. Before the start of the experiment, the site was homogenously cultivated as a succession of winter triticale (2004-

2005), winter barley (2003-2004) and rapeseed, winter wheat or winter barley (2000-2002). Previously, the site was cultivated under annual crops and mown grassland rotations for at least 70 years. During the period 1990-2000, the field was covered with 2/3 annual crops and 1/3 temporary grasslands.

Four treatments were compared (Table 1): (i) six years of fertilised annual crop rotation (grain maize, wheat, barley, grain maize, wheat and lastly barley) (AC); (ii) three years of highly fertilised grassland preceded by three years of annual crop rotation (grain maize, wheat, barley) (G3N+); (iii) six years of highly fertilised grassland (G6N+) and (iv) six years of lightly fertilised grassland (G6N-). Each treatment was replicated four times randomly (i.e. four blocks). For more details about the experimental design, see Kunrath et al. (2015). Crops and grass were sown after ploughing to a depth of 25 cm. Maize was sown in April and harvested in October; winter wheat was sown in October and harvested in July; barley was sown in November and harvested in July; after barley harvest, soil was left fallow till sown with maize. Grain maize residue was crushed and left on the soil surface, while the straw of wheat and barley was removed. After barley harvest, soil remained bare until maize was sown in March. Grasslands were sown as a mixture of perennial ryegrass (Lolium perenne cv. Milca), tall fescue (Festuca arundinacea cv. Soni) and cocksfoot (Dactylis glomerata cv. Ludac). Grasslands were cut to 5-7 cm and harvested three or four times per year (depending on seasonal climate and grassland productivity of the year). Nitrogen (ammonium nitrate) was the only mineral element added through mineral fertilizer application. For annual crops, N application rates and timing were adjusted each year using the PC-AZOTE program (for more details, see Kunrath et al. 2015). On average over the experimental period, N application on annual crops was 106 kg N ha<sup>-1</sup>. For grasslands, regular estimations of the Nitrogen Nutrition Index (NNI) were made to maintain a NNI of between 0.9 and 1.0, i.e. close to a non-limiting N nutrition allowing for potential herbage production (for

more details, see Kunrath et al. 2015). On average over the experimental period, annual N application was 230 kg ha<sup>-1</sup> on highly fertilised grassland (divided among applications performed after cutting) and 30 kg ha<sup>-1</sup> on lightly fertilised grassland.

#### 2.2 Earthworm sampling and laboratory analyses

Earthworm sampling for the present study was performed in March 2004 before the establishment of the experimental site, and in March 2011 (after the harvest of the barley for AC and in grassland for G3N+, G6N+ and G6N-). In 2004, earthworms were sampled at nine locations homogeneously distributed to cover the entire site, which provided a baseline value of the earthworm community before experimental establishment. In 2011, earthworms were sampled in each plot, at three locations spaced at least 10 m apart and at least 10 m from the plot edge, before sowing the maize in AC and during the grassland phase of G3N+, G6N+ and G6N-. Earthworms were sampled according to the ISO 23611-1 protocol modified according to Pérès et al., (2010), which combines chemical and physical extraction. Briefly, each earthworm-sampling event consisted of applying three 10 L applications of water with an increasing concentration of formaldehyde (0.25%, 0.25% and 0.40%) on one square meter. To recover earthworms unable to reach the surface, a block of soil (25 × 25 × 20 cm), corresponding to an area of 1/16 square meter, was hand-sorted inside the sample square (for more details, see Pérès et al., 2010).

In the laboratory, earthworms were counted, individually weighed (± 10 mg), assigned to a stage of development (juvenile, sub-adult and adult), identified to species level using Bouché's (1972) key and assigned to an ecological category: epigeic, epi-anecic (*Lumbricus* sp.), strictanecic (*Aporrectodea* sp.) or endogeic (Bouché, 1977; Jégou et al., 1998; Hoeffner et al., 2019). Juvenile earthworms that could not be determined at the species level (29% of the dataset) were allocated to species according to the proportion of adult and sub-adult identified within a square

meter and within the same functional group. The earthworm community was analysed by total abundance, total biomass, abundance and biomass of ecological categories, species richness, and species evenness (i.e. similar distributions of species).

# 2.3 Forage production and composition

In 2010, grass was cut three times during the year (April, June, and July). Above-ground biomass was estimated by cutting an area of  $1.5 \times 5.0$  m with an experimental harvester (Haldrup, Germany). Grass was dried in an oven at 70 °C and weighed to determine dry matter content. It was then ground for chemical analysis. Total C and N concentrations were determined by the Dumas method using an elemental analyser (Carlo Erba EA 1108).

### 2.4 Statistical analyses

Statistical analyses were performed using R software 3.5.2 (R. Core Team, 2020). All differences were considered significant at P < 0.05. The conditions of normality and homoscedasticity were tested.

We firstly used linear mixed-effects models ("nlme" package), followed by Tukey HSD tests for post hoc pairwise comparisons, to assess differences between 2004 (i.e. before the establishment of the experimental site) and 2011 with the four treatments (annual crop, highly fertilised 3- and 6-year-old grassland and lightly fertilised 6-year-old grassland) on total earthworm abundance, biomass and species richness. To account for pseudo-replication the random part of the model specified that earthworm-sampling events were nested within a block. Secondly, we used linear mixed-effects models ("nlme" package), followed by Tukey HSD tests for post hoc pairwise comparisons, to test in 2011 effects of the four treatments (annual crop, highly fertilised 3- and 6-year-old grassland and lightly fertilised 6-year-old grassland) on each

earthworm community parameter. To account for pseudo-replication, the random part of the model specified that earthworm-sampling events were nested within a block. We then used separate one-way ANOVAs, followed by Tukey HSD tests for post hoc pairwise comparisons, to assess differences in 2010 for forage production and composition (C and N) between the treatments. Next, we calculated Pearson correlations between grassland forage production and composition (C and N) and earthworm community parameters.

#### 3. Results

Compared to the 2004 baseline, total earthworm abundance and biomass in 2011 decreased significantly by 3.5 and 5.5 times in AC respectively and increased by 1.9 and 2.3 times in G6N+ respectively (ANOVA, P < 0.001, Fig. 1a and b), while no significant difference was observed for G3N+ and G6N-. In addition, earthworm species richness decreased by 1.4 times in AC (ANOVA, P < 0.001, data not shown) whereas no difference was observed between 2004 and 2011 for the grassland treatments (G3N+, G6N- and G6N+).

In 2011, on the whole experimental site, 13 earthworm species were observed (Table 2): one epigeic (*Lumbricus castaneus*), four epi-anecic (dominated by *Lumbricus centralis*), three strict-anecic (dominated by *Aporrectodea longa longa*) and five endogeic (dominated by *Allolobophora chlorotica chlorotica* and *Aporrectodea caliginosa caliginosa*, Table 2). Epigeic earthworms were only present in highly fertilised grasslands (G3N+ and G6N+) and absent in the other treatments (AC and G6N-, Table 2).

In 2011, total earthworm abundance and biomass were significantly higher in G3N+ than in AC (4.6 and 8.3 times, respectively; ANOVA, P < 0.001, Fig. 1a and b, Supplementary Table S2). Except for epigeic earthworms, abundance and biomass of ecological categories were significantly higher in G3N+ than in AC (ANOVA, P < 0.008, Fig. 1a and b). These differences

were greater for epi-anecic (153.3 and 130.0 times, respectively) than for strict-anecic (15.3 and 16.5 times, respectively) or endogeic earthworms (2.8 and 3.9 times, respectively, Fig. 1a and b). Interestingly, there was an unequal proportion between strict-anecic and epi-anecic in G3N+, as strict-anecic abundance and biomass were 3.2 and 2.1 times higher (Fig. 1a and b). Earthworm species richness was 1.6 times higher in G3N+ than AC (ANOVA, P < 0.001, Supplementary Table S2), due to the absence in AC of L castaneus (epigeic), Lumbricus terrestris (epi-anecic), L0.05, Supplementary Table S2).

In 2011, regarding the effects of grassland duration (G3N+ vs G6N+), total abundance and biomass were 1.5 times higher in G6N+ than G3N+ (ANOVA, P < 0.001, Fig. 1a and b), due to the presence of strict-anecic earthworms (ANOVA, P < 0.003, Fig. 1a and b). Epigeic, epianecic and endogeic abundance and biomass did not differ significantly between G3N+ and G6N+ (Fig. 1a and b). Moreover, earthworm species richness, species evenness, and forage production and composition (C and N) did not differ significantly between G3N+ and G6N+ (Table 3 and Supplementary Table S2).

In 2011, regarding the effects of mineral fertilisation (G6N+ vs G6N-), total earthworm abundance and biomass were 1.6 and 1.4 times higher, respectively, in G6N+ than G6N-, due to the presence of strict-anecic earthworms (ANOVA, P < 0.001, Fig. 1a and b). Once again, epigeic, epi-anecic and endogeic abundance and biomass, as well as earthworm species richness and species evenness, did not differ significantly between G6N- and G6N+ (Supplementary Table S2). Interestingly, there was also an unequal distribution of strict-anecic and epi-anecic as strict-anecic abundance was 3.1 and 3.5 times higher than epi-anecic abundance in G6N+ and G6N-respectively (Fig. 1a). Nevertheless, forage production was 3.3 times as high in G6N+ as in G6N-

(ANOVA, P < 0.001, Table 3), whereas forage composition did not differ between them with a mean C content of 432.81  $\pm$  0.83 (SE) mg g<sup>-1</sup> and a mean N content of 24.91  $\pm$  1.17 (SE) mg g<sup>-1</sup> (ANOVA, P > 0.448, Table 3). Finally, neither forage production nor composition (C and N) correlated significantly with any earthworm community parameter ( $R^2 < 0.56$ , P > 0.05, data not shown).

#### 4. Discussion

In the present study, between 2004 and 2011, total earthworm abundance and species richness in the annual crop treatment declined sharply (71 and 49%, respectively), which highlights the strong negative effect of annual crop practices applied in our study on earthworm communities. In 2011 earthworm communities were characterized by an average of 92.0 ind. m<sup>-2</sup> and 4.5 species m<sup>-2</sup>. Although these 2011 values are consistent with results obtained from annual crops in other experimental fields (van Eekeren et al., 2008; Postma-Blaauw et al., 2010; Roarty et al., 2017), they are noticeably lower than values recorded in non-experimental fields (Decaëns et al., 2008; Cluzeau et al., 2012; Frazão et al., 2017). Among 52 crops in western France, Cluzeau et al. (2012) observed total earthworm abundance of 215 ind. m<sup>-2</sup> and 7.4 species m<sup>-2</sup>, and Frazão et al. (2017), among 13 crops with semi-natural field edges in south-western Netherlands, observed total earthworm abundance of 414.1 ind. m<sup>-2</sup> and 4.9 species m<sup>-2</sup>. The low values in the present study could have been related to the absence of organic fertilisation, which is known to be beneficial for soil fauna (Marhan and Scheu, 2005; Bünemann et al., 2006; Cluzeau et al., 2012) or changes in the use of pesticides that are known to be detrimental to soil fauna (Pelosi et al., 2013). Results could also be explained by the basic and short annual crop rotation (maize, wheat, barley) without cover or inter-crops which left the soil bare for five months in winter, which can be detrimental for earthworms (Schmidt et al., 2001; Edwards,

2004). Conversely, between 2004 and 2011, total earthworm abundance and species richness in grassland treatments stabilized or slightly increased to reach an average of 479.9 ind. m<sup>-2</sup> and 7.3 species m<sup>-2</sup>, respectively, which is of similar magnitude to those found in previous studies. For example, Didden (2001) observed a total earthworm abundance of 384 ind. m<sup>-2</sup> and 2.1 species m<sup>-2</sup> in 20 Dutch grasslands while Cluzeau et al. (2012) observed a total abundance of 350.0 ind. m<sup>-2</sup> and 9.6 species m<sup>-2</sup> in 47 French grasslands. In the present study, we observed that grassland treatments (G3N+, G6N+ and G6N-) had higher earthworm abundance, biomass and species richness than those observed in the annual crop treatment. This result reinforces previous studies which showed that annual crops benefit earthworms less than grasslands (Decaëns et al., 2008; Rutgers et al., 2009; Tsiafouli et al., 2015). The lower values under crops could be explained by negative effects of soil tillage (Chan, 2001; Pelosi et al., 2016; Briones and Schmidt, 2017), less food resource for earthworms (Schmidt et al., 2001; Edwards, 2004) and negative effects of pesticide application (Pelosi et al., 2013). Interestingly, this result was obtained in all grassland treatments, including the young grassland, i.e. three years of grassland preceded by three years of crops (G3N+), which demonstrates that the earthworm community can recover rapidly, even in a grassland preceded by three years of annual crops.

The increase in earthworm species richness in grassland could be explained by their ability to colonise soil at a rate of 1.5-14 m year-1 (Eijsackers, 2011) from surrounding edges or by residual surviving populations in the field (Lagerlöf et al., 2002; Roarty and Schmidt, 2013; Hoeffner et al., 2021). Nevertheless, even though species richness differed between crop and grassland treatments, the four treatments had similar species evenness. All ecological categories of earthworms had higher abundance and biomass in grassland treatments (G3N+, G6N- and G6N+) than in the annual crop treatment (except epigeic earthworms, whose density was too low to be discussed). However, abundances of epi-anecic and strict-anecic earthworms increased

more than that of endogeics, because the former are more sensitive to soil tillage due to their permanent or semi-permanent vertical burrows (Chan, 2001; Peigné et al., 2009; Briones and Schmidt, 2017). Moreover, anecic earthworms may be more sensitive to pesticide application, especially fungicides and insecticides (Pelosi et al., 2013), and to bare-soil conditions (Lowe and Butt, 2002; Marhan and Scheu, 2005; Frazão et al., 2019). An increase in epi-anecic and strictanecic earthworms in grassland would alter soil functioning substantially, transferring more plant litter into the soil (Jégou et al., 1998; Hoeffner et al., 2019), increasing tubular soil porosity, which may increase water infiltration (Jégou et al., 1997; Bastardie et al., 2003), and increasing soil surface roughness by producing surface casts, which may decrease soil erosion (Le Bayon et al., 2002). Regarding the ratio between anecic sub-categories, strict-anecic abundance was on average 3.2 times as high as epi-anecic abundance in grassland treatments. This relative difference has been recorded in the literature: in western France, Decaëns et al. (2008) observed a ratio of 2.5 among 22 grasslands, and Richard et al. (2012) observed one of 4.9 and 3.7 for a 5and 42-year-old grassland, respectively. Regarding effects of endogeics, despite the smaller increase in their abundance and biomass in grassland treatments compared to those in annual crop rotation, the ecosystem functions they provide, such as soil structure maintenance (Le Couteulx et al., 2015), may also have been improved.

While the present study demonstrated that introducing three years of grassland into a crop rotation rapidly benefits earthworm communities, it also showed that total earthworm abundance and biomass do not peak after three years of grassland, as they were still lower than those after six years of grassland. Considering the six years of grassland treatments (G6N- and G6N+) as permanent grassland, our results contrast with those of van Eekeren et al., (2008), who observed that earthworm communities can be restored more rapidly, as total earthworm abundance and species richness in two- and three-year-old grasslands were similar to those in a permanent

grassland. Furthermore, Postma-Blaauw et al., (2010) observed that total earthworm abundance and biomass in three-year-old grasslands were 1.5 times higher than in permanent grassland. These differences between the rates of response of the earthworm community to grassland introduction could be explained by differences in cutting frequency (depending on the growth rate of the grass), annual crop rotations preceding grassland introduction and soil properties such as soil texture (loamy vs sandy-loam texture), soil structure and organic matter content. In addition, the studies of van Eekeren et al. (2008) and Postma-Blaauw et al., (2010) observed total earthworm abundances that were generally much lower than in the present study (i.e. lower baseline) with different and fewer earthworm species (five including three endogeics and three including two endogeics, respectively) than the present study (13 species including four epianecic, three strict-anecic and five endogeic). Thus, the lower total earthworm abundance and demographic strategies of different species could lead to different responses of the earthworm community to grassland introduction (Bouché, 1977; Satchell, 1980; Butt, 1993). In the present study, higher total earthworm abundance and biomass after six compared to three years of grassland was due mainly to a large increase in anecic species abundance (1.8 and 1.7 times higher for epi-anecic and strict-anecic earthworms, respectively). Thus, grassland duration could have significant consequences for soil functioning, especially soil porosity and associated ecosystem services such as soil water regulation, due to the burrow network of anecic species (Jégou et al., 1997, 2001; Bastardie et al., 2003). Contrasting results were obtained for the provisioning ecosystem service (i.e. forage production). Indeed, while the present study demonstrated greater effects of six than three years of grassland in a crop rotation on the earthworm community, no effect on forage production was observed. This result contrasts with the meta-analysis of van Groenigen et al., (2014) that showed a positive relation between total earthworm abundance and plant growth, reaching +30% of plant growth in pasture without

legumes. This contrasted finding could be explained by several mechanisms not measured in the present study, such as climate parameters (Fay et al., 2003) or deficiency in macronutrients (e.g. P, K, S, Ca, Mg) in the soil (Maathuis, 2009) which could have limited grass growth and explains the apparent low levels of N and C recovery (Whitehead, 1995; Graux et al., 2020). Indeed, Graux et al., (2020) predicted a grassland dry matter yield of 7.7 t ha<sup>-1</sup> yr<sup>-1</sup> over the 1984-2013 period in the same district of our study site, which is noticeably higher than those observed in the current grassland treatments (5.4, 5.5 and 1.7 t ha<sup>-1</sup> yr<sup>-1</sup> for the G3N+, G6N+ and G6N-respectively).

The present study demonstrated that grassland N fertilisation did not modify earthworm diversity but did increase total earthworm abundance and biomass by 1.4 and 1.6 times, respectively, for the highly fertilised grassland (230 kg N ha<sup>-1</sup> yr<sup>-1</sup>). This positive effect of N fertilisation in grassland has been attributed to an increase in primary production, resulting in a greater supply of plant-derived material and thus a greater supply of food and refuge for earthworm communities (Muldowney et al., 2003; Curry et al., 2008). This assumption was confirmed in the present study by annual forage production being 3.3 times higher in highly fertilised than lightly fertilised grassland. This increase in the food resource was beneficial for anecic species, especially strict-anecics, whose abundance and biomass increased by 1.7 and 2.0 times, respectively. Therefore, to decrease use of mineral N fertilisers, future studies could examine effects of organic grassland fertilisation or the addition of legumes to the grassland during sowing on earthworm communities and the possible consequences on soil functioning, which are still rarely studied (Haas et al., 2019).

#### 5. Conclusion

The present study clearly illustrated positive effects of introducing grassland into an annual crop rotation on earthworm abundance, biomass, species richness and functional structure. Further, this study highlights that earthworm communities can react quickly, at least within three years, to the introduction of grassland into an annual crop rotation. Grassland duration (3 years *vs* 6 years) and fertilisation (N- *vs* N+) increased earthworm total abundance and biomass and were beneficial for anecics (strict-anecics), without affecting endogeics, which means that ecosystem services provided by earthworms may become more effective as grassland duration and fertilisation increase. Nevertheless, increased grassland duration did not increase forage production, but increased grassland fertilisation (30 *vs* 230 kg N ha<sup>-1</sup> yr<sup>-1</sup>) did. In order to reach both forage performance and earthworm community restoration, the introduction of three years of grassland in the rotation, combined with nitrogen fertilisation, appears (in our context) as the most suitable management technique. Ideally, maintaining the grassland for more than three years could allow a better earthworm community restoration.
