# Boundary Control for Transport Equations

#### Abstract

This paper considers two types of boundary control problems for linear transport equations. The first one shows that transport solutions on a subdomain of a domain $X$ can be controlled exactly from incoming boundary conditions for $X$ under appropriate convexity assumptions. This is in contrast with the only approximate control one typically obtains for elliptic equations by an application of a unique continuation property, a property which we prove does not hold for transport equations. We also consider the control of an outgoing solution from incoming conditions, a transport notion similar to the Dirichlet-to-Neumann map for elliptic equations. We show that for well-chosen coefficients in the transport equation, this control may not be possible. In such situations and by (Fredholm) duality, we obtain the existence of non-trivial incoming conditions that are compatible with vanishing outgoing conditions.


Keywords: Transport theory; boundary control; albedo operator; diffusion approximation; unique continuation.

## 1 Introduction

This paper concerns the control of steady-state (linear Boltzmann) transport equations from boundary data. The most general transport equation considered here is of the form:

\end{equation*}

where $u(x, v)$ is the transport solution, posed on a spatial domain $x \in X$, an open bounded subset of $\mathbb{R}^{d}$ for $d \geq 1$ of class $C^{1}$, and a set of velocities $v \in V$, which is either a bounded open subset in $\mathbb{R}^{d}$ excluding a vicinity of $v=0$, or a co-dimension 1 closed surface also excluding $v=0$ such as for instance the unit sphere for concreteness. Here, $\sigma(x, v)$ is the total absorption coefficient and $k\left(x, v^{\prime}, v\right)$ the scattering coefficient.

Let us define the sets of incoming and outgoing directions $\Gamma_{ \pm}=\Gamma_{ \pm}(X):=\{(x, v) \in$ $\partial X \times V \mid \pm v \cdot \nu(x)>0\}$ while $\Gamma:=\Gamma_{+} \cup \Gamma_{-}$. Under appropriate conditions on $(\sigma, k)$, the above equation is well-posed when augmented with prescribed incoming conditions $u=g$ on $\Gamma_{-}$. Within this framework, we consider two types of boundary controls.

The first one concerns the control of a prescribed transport solution $u_{0}(x, v)$ on a subdomain $X_{0} \times V$, where $X_{0}$ is an open subset such that $\bar{X}_{0} \subset X$ : can one find $g$ on $\Gamma_{-}(X)$ such that $u_{\mid X_{0}}=u_{0}$ for $u$ solution of the above transport equation on $X$ ? A similar question arises in

[^0]the setting of second-order scalar elliptic operators. In such a case, the control is approximate, as an application of the Runge approximation result, itself a rather direct consequence of the (weak) Unique Continuation Property (UCP) enjoyed by such operators. One of the main results of this paper is to show, under appropriate convexity assumptions on $X_{0}$ and $X$, that such a control is in fact exact for transport equations. Moreover, the control is not unique, so that the difference of two controls may result in a solution $u$ that does not vanish on $X \backslash X_{0}$ whereas $u_{\mid X_{0}}=0$. In other words, UCP (in that sense) does not hold for the transport equation independently of the scattering coefficients ( $\sigma, k$ ).

The two models, transport and elliptic equations, both describe transport in highly scattering media. For instance, if $k=k(x)$ is replaced by $k(x) / \varepsilon$ and $\sigma(x)=k(x) / \varepsilon+\varepsilon \sigma_{a}(x)$, then the transport solution is well approximated by the solution of an elliptic equation [9, 14] as the mean free path $\varepsilon \rightarrow 0$. For an infinite mean free path, with $k \equiv 0$, transport solutions can be supported arbitrarily close to any line segment in $X$ so that UCP clearly does not hold. The limit $\varepsilon \rightarrow 0$ is, however, singular in the sense that boundary control is exact at $\varepsilon>0$ and only approximate in the limit $\varepsilon=0$, whereas what makes the approximation possible at $\varepsilon=0$, namely UCP, does not hold for any $\varepsilon>0$.

The second type of control we consider aims to find an incoming condition $u=g$ on $\Gamma_{-}$ such that $u_{\mid \Gamma_{+}}=f$ is prescribed. For second-order elliptic equations, this corresponds to finding Dirichlet conditions for prescribed Neumann conditions, or vice-versa, which is a well posed problem as the Dirichlet-to-Neumann map is a isomorphism in appropriate topologies. For the transport equation, the problem is richer. We show that the albedo operator, a well defined operator which maps $u$ on $\Gamma_{-}$to $u_{\mid \Gamma_{+}}$, is surjective when scattering is sufficiently small. However, we identify a number of cases where the albedo operator, while still Fredholm (of index 0 ), has a non-trivial kernel. In such settings, the outgoing condition $f$ needs to satisfy appropriate orthogonality properties to be controlled as the trace $u_{\mid \Gamma_{+}}=f$ of a transport solution $u$ in $X \times V$. In such cases, we also find by duality the existence of non trivial incoming conditions $u=g$ on $\Gamma_{-}$such that $u_{\mid \Gamma_{+}}=0$, i.e., the effect of $g$ is invisible on the outgoing solution.

The outline of the paper is as follows. To understand the first control problem, we need to construct a transport solution on $X \backslash X_{0}$ with prescribed boundary conditions on $\Gamma_{-}\left(X_{0}\right) \cup$ $\Gamma_{+}\left(X_{0}\right)$, which is not a subset of $\Gamma_{-}\left(X \backslash X_{0}\right)$. Section 2 is devoted to the analysis of (1.1) augmented with boundary conditions on general sets $\mathcal{C}$ defined such that for each line segment passing through $X$, we prescribe a boundary condition on one of its two points of intersections with $\partial X$. Under appropriate conditions on the coefficients $(\sigma, k)$, we obtain a transport solution and the definition of an albedo operator mapping conditions on $\mathcal{C}$ to conditions on $\Gamma \backslash \mathcal{C}$. This general transport theory will be the starting point of the analysis of the boundary control of solutions on a subdomain presented in section 4. The Fredholm theory of the albedo operator from $\mathcal{C}$ to $\Gamma \backslash \mathcal{C}$ is presented in section 3 and used in section 5 to analyze the specific control of outgoing boundary conditions on $\Gamma \backslash \mathcal{C}=\Gamma_{+}$from incoming conditions $\mathcal{C}=\Gamma_{-}$.

The boundary control of solutions on subdomains find several applications in the field of hybrid inverse problems; see $[2,5,6]$ for results in the elliptic framework and [3] for results in the setting of transport equations.

## 2 Forward transport theory

We assume that $X$ is an open bounded subset of $\mathbb{R}^{d}$ for $d \geq 1$ of class $C^{1}$. The set of velocities $V$ is either a bounded open subset in $\mathbb{R}^{d}$ excluding a vicinity of $v=0$, or a co-dimension 1 closed surface also excluding $v=0$.

Let $\Gamma_{ \pm}:=\{(x, v) \in \partial X \times V \mid \pm v \cdot \nu(x)>0\}$ and $\Gamma:=\Gamma_{+} \cup \Gamma_{-}$. We endow $\Gamma$ with the measure $d \xi(x, v)=|\nu(x) \cdot v| d \mu(x) d v$, where $d \mu$ denotes the canonical measure on $\partial X$ and $d v$ that on $V$. Both $\Gamma_{+}$and $\Gamma_{-}$parametrize the set of lines in $\mathbb{R}^{n}$ passing through $X$. Typical boundary conditions consist in prescribing the trace of the solution on $\Gamma_{-}$. We consider the following general boundary conditions.

Let $C_{+}$be an arbitrary measurable subset of $\Gamma_{+}$and $C_{-}$the measurable subset of $\Gamma_{-}$ defined by

C_{-}:=\Gamma_{-} \backslash\left\{(x, v) \in \Gamma_{-} \mid\left(x+\tau_{+}(x, v) v, v\right) \in C_{+}\right\} .
$$

We then define $\mathcal{C}=C_{-} \cup C_{+}$. Note that $\mathcal{C}$ also provides a parametrization of the set of lines passing through $X$. We now consider a transport theory with boundary conditions prescribed on $\mathcal{C}$.

We first need to define a functional setting for the transport solution and its boundary traces. For $1 \leq p<\infty$, we define two natural topologies to describe transport solutions

Above, we have introduced the usual travel times

We also define the real valued function $\tau$ on $\bar{X} \times V$ by

Traces are then well defined according to the
Lemma 2.1. Let $\mathcal{G}$ be a measurable subset of $\Gamma$. Then, for $1 \leq p<\infty$ (it also holds for $p=\infty$ ),

The Lemma will be used for $\mathcal{G}=\mathcal{C}$ or $\mathcal{G}=\Gamma \backslash \mathcal{C}$.
Proof. Set $\mathcal{G}_{ \pm}:=\mathcal{G} \cap \Gamma_{ \pm}$. Let $u \in C^{1}(\bar{X} \times V)$. Then for $(x, v) \in \Gamma_{ \pm}$

Adjoint to the notion of trace is that of a lifting operator $J_{\mathcal{C}}$ defined by

for $g \in L^{\infty}(\mathcal{C}, \mathbb{R})$. Note that $\left(v \cdot \nabla_{x}\right) J_{\mathcal{C}} g=0$. We have the
Lemma 2.2. Let $1 \leq p<\infty$ (it actually holds for $p=\infty$ ). The operator $J_{\mathcal{C}}$ extends as a bounded operator from $L^{p}(\mathcal{C}, d \xi)$ to $W^{p}$, and from $L^{p}(\mathcal{C}, \tau d \xi)$ to $\tilde{W}^{p}$.
Proof. This is the calculation

We now consider the transport equation (1.1) with general boundary condition

We assume that $\tau \sigma \in L^{\infty}$, and define the scattering coefficients

We provide a proof of the Lemma in Appendix C. The above results allow us to solve the transport equation in the absence of scattering, which is then incorporated as a perturbation. We then need the following bounds

Lemma 2.4. Let $1 \leq p<\infty$. Assume either

Then the operator $K$ is bounded from $\tau^{\frac{1}{p}} L^{p}$ to $\tau^{-\frac{p-1}{p}} L^{p}$, and

We provide a proof of Lemma 2.4 in Appendix C.
Remark 2.5. Assumptions (2.10) and (2.11) (resp. (2.13) and (2.14)) are not equivalent. Indeed we provide the following two examples.
(i) Let $k\left(\theta, \theta^{\prime}\right)=\frac{1}{\sqrt{\left|\theta-\theta^{\prime}\right|}},\left(\theta, \theta^{\prime}\right) \in(0,2 \pi)^{2}$. Then $k \in L^{\infty}\left((0,2 \pi)_{\theta}, L^{1}\left((0,2 \pi)_{\theta^{\prime}}\right)\right)$ but $k \notin L^{2}\left((0,2 \pi)^{2}\right)$. We can construct a scattering coefficient $k$ that satisfies (2.11) but not (2.10) for $p=2$.
(ii) Let $g \in L^{2}(0,2 \pi) \backslash L^{\infty}(0,2 \pi), g>0$, and set $k\left(\theta, \theta^{\prime}\right)=g(\theta) g\left(\theta^{\prime}\right)$ for a.e. $\left(\theta, \theta^{\prime}\right) \in$ $(0,2 \pi)^{2}$. Then, $k \in L^{2}\left((0,2 \pi)^{2}\right)$ but $k \notin L^{\infty}\left((0,2 \pi)_{\theta}, L^{1}\left((0,2 \pi)_{\theta^{\prime}}\right)\right)$. We can again construct a scattering coefficient $k$ that satisfies (2.10) but not (2.11) for $p=2$.

Note that estimates on the norm of the operator $K$ under assumptions (2.11) or (2.14) may also be obtained by interpolation [11].

Condition (2.11) can be relaxed to the condition $\sigma_{s} \in L^{\infty}(X \times V)$ when $p=1$ and to the condition $\sigma_{s}^{\prime} \in L^{\infty}(X \times V)$ when $p=\infty$ with the obvious convention $\|f\|_{\infty}^{0}=1$ for any measurable function $f$. Similarly condition (2.14) can be relaxed to the condition $\tau \sigma_{s} \in L^{\infty}(X \times V)$ when $p=1$ and to the condition $\tau \sigma_{s}^{\prime} \in L^{\infty}(X \times V)$ when $p=\infty$.

We recast the stationary linear Boltzmann equation as the following integral equation

$$
\begin{equation*}
\left(I-T_{\mathcal{C}}^{-1} K\right) u=L_{\mathcal{C}} g \tag{2.16}
\end{equation*}
$$

We may now collect the above results to obtain the following existence and uniqueness result.
Theorem 2.6. Let $1 \leq p \leq \infty$. Under conditions (2.13) or (2.14), further assume that

$$
\begin{equation*}
I-T_{\mathcal{C}}^{-1} K \text { is invertible in } \mathcal{L}\left(\tau^{\frac{1}{p}} L^{p}(X \times V)\right) . \tag{2.17}
\end{equation*}
$$

Then, for any $f \in L^{p}(\mathcal{C}, d \xi)$, there is a unique solution $u$ of (1.1) in $W^{p}(X \times V)$ and the albedo operator $A=\left(\left(I-T_{\mathcal{C}}^{-1} K\right)^{-1} L_{\mathcal{C}}\right)_{\mid \Gamma \backslash \mathcal{C}}$ is well defined and bounded from $L^{p}(\mathcal{C}, d \xi)$ to $L^{p}(\Gamma \backslash \mathcal{C}, d \xi)$.

Similarly, under conditions (2.10) or (2.11), further assume that

$$
\begin{equation*}
I-T_{\mathcal{C}}^{-1} K \text { is invertible in } \mathcal{L}\left(L^{p}(X \times V)\right) . \tag{2.18}
\end{equation*}
$$

Then, for any $f \in L^{p}(\mathcal{C}, \tau d \xi)$ there is a unique solution $u$ of (1.1) in $\tilde{W}^{p}(X \times V)$, and the albedo operator $A$ is bounded from $L^{p}(\mathcal{C}, \tau d \xi)$ to $L^{p}(\Gamma \backslash \mathcal{C}, \tau d \xi)$.

Proof. Assume (2.17). Let $f \in L^{p}(\mathcal{C}, d \xi)$. Then set $u=\left(I-T_{\mathcal{C}}^{-1} K\right)^{-1} L_{\mathcal{C}} f \in \tau^{\frac{1}{p}} L^{p}(X \times V)$. We have

$$
u=T_{\mathcal{C}}^{-1} K u+L_{\mathcal{C}} f .
$$

Hence we have $v \cdot \nabla_{x} u=\sigma u+K u$ and we obtain that $u \in W^{p}(X \times V)$ and

$$
\left\|\tau^{1-\frac{1}{p}} v \cdot \nabla_{x} u\right\|_{L^{p}} \leq\left(\|\tau \sigma\|_{\infty}+\|K\|_{\left.\mathcal{L}\left(\tau^{\frac{1}{p}} L^{p}(X \times V)\right), \tau^{-1+\frac{1}{p}} L^{p}(X \times V)\right)}\right)\left\|\tau^{-\frac{1}{p}} u\right\|_{L^{p}} .
$$

We perform the analysis for $f \in L^{p}(\mathcal{C}, \tau d \xi)$ similarly.
We verify that (2.17) and (2.18) hold as soon as the scattering coefficient $k$ is sufficiently small. Let $1 \leq p<\infty$ and assume that $K$ defines a bounded operator in $L^{p}(X \times V)$. Then $I-T_{\mathcal{C}}^{-1} K$ is invertible in $\tau^{\frac{1}{p}} L^{p}(X \times V)$ when $I-T_{\mathcal{C}}^{-1} K$ is invertible in $L^{p}(X \times V)$. This statement follows from the fact that $\tau^{\frac{1}{p}} L^{p}(X \times V)$ is a subspace of $L^{p}(X \times V)$ and that $T_{\mathcal{C}}^{-1}$ maps $L^{p}(X \times V)$ to $\tau L^{p}(X \times V)$. Then we have the quantitative result:

Lemma 2.7. Assume that

$$
\begin{equation*}
\left\|\kappa_{p}(x)\right\|_{L^{\infty}(X)}^{\frac{1}{p}}<\frac{e^{-\|\tau \sigma\|_{\infty}}}{\|\tau\|_{\infty}} \tag{2.19}
\end{equation*}
$$

when $p>1$ or

$$
\begin{equation*}
\left\|\sigma_{s}\right\|_{\infty}<\frac{e^{-\|\tau \sigma\|_{\infty}}}{\|\tau\|_{\infty}} \tag{2.20}
\end{equation*}
$$

when $p=1$. Then condition (2.18) (and (2.17)) holds.
Proof. By (2.8), (2.12) and (2.19), it follows that $\left\|T_{\mathcal{C}}^{-1} K\right\|_{\mathcal{L}\left(L^{p}(X \times V)\right)}<1$, which proves (2.18). When $p=1$ we recall that condition (2.11) can be relaxed by the condition $\sigma_{s} \in L^{\infty}(X \times V)$ and then (2.8), (2.12) and (2.20) give $\left\|T_{\mathcal{C}}^{-1} K\right\|_{\mathcal{L}\left(L^{p}(X \times V)\right)}<1$.

This confirms the intuition that scattering may be seen as a perturbation to the (scattering)free transport equation and provides existence and uniqueness results for the transport equation under a smallness condition. More general results will be obtained below under the assumption that $T_{\mathcal{C}}^{-1} K$ is compact as a standard application of the theory of Fredholm operators (with vanishing index). We refer to, e.g., [9], [11] for other sufficient conditions in the setting of boundary conditions imposed on $\Gamma_{-}$.

Before considering (standard) compactness results, we show that backward equations may be solved under conditions on the forward operators as follows. The dual operators $K^{*}$ and $\left(T_{\mathcal{C}}^{-1}\right)^{*}$ for the usual inner products are given by

$$
\begin{equation*}
K^{*} f(x, v)=\int_{V} k\left(x, v, v^{\prime}\right) f\left(x, v^{\prime}\right) d v^{\prime}, f \in L^{\frac{p}{p-1}}(X \times V) \tag{2.21}
\end{equation*}
$$

and

T_{\mathcal{C}}^{-1^{*}} \phi(x, v)=\left\{\begin{array}{l}
\int_{0}^{\tau_{+}(x, v)} E_{-}(x+t v, v, t) \phi(x+t v, v) d t,\left(x-\tau_{-}(x, v) v, v\right) \in \mathcal{C}_{-} \\
-\int_{0}^{\tau_{-}(x, v)} E_{+}(x-t v, v, t) \phi(x-t v, v) d t,\left(x+\tau_{+}(x, v) v, v\right) \in \mathcal{C}_{+}
\end{array}\right.
$$

We find

$$
v \cdot \nabla_{x}\left(T_{\mathcal{C}}^{-1}\right)^{*} \phi(x, v)=\sigma(x, v)\left(T_{\mathcal{C}}^{-1}\right)^{*} \phi(x, v)-\phi(x, v)
$$

and the identity $\left(\left(T_{\mathcal{C}}^{-1}\right)^{*}\right)_{\mid \Gamma \backslash \mathcal{C}}=0$. The operator $T_{\mathcal{C}}^{-1}$ is bounded from $\tau^{\varepsilon-1} L^{p}(X \times V)$ to $\tau^{\varepsilon} L^{p}(X \times V)$ and, hence, $\left(T_{\mathcal{C}}^{-1}\right)^{*}$ is bounded from $\tau^{-\varepsilon} L^{\frac{p}{p-1}}(X \times V)$ to $\tau^{1-\varepsilon} L^{\frac{p}{p-1}}(X \times V)$. We consider the following backward equation

$$
\begin{align*}
& v \cdot \nabla_{x} u(x, v)-\sigma(x, v) u(x, v)=-K^{*} u(x, v),  \tag{2.22}\\
& u_{\mid \Gamma \backslash \mathcal{C}}=g . \tag{2.23}
\end{align*}
$$

We may recast it as the following integral equation

$$
\begin{equation*}
\left(I-\left(T_{\mathcal{C}}^{-1}\right)^{*} K^{*}\right) u=L_{\Gamma \backslash \mathcal{C},-\sigma} g . \tag{2.24}
\end{equation*}
$$

Here $L_{\Gamma \backslash \mathcal{C},-\sigma}$ denotes the operator " $L_{\mathcal{C}}$ " related to " $(\mathcal{C}, \sigma)$ " given by $(\Gamma \backslash \mathcal{C},-\sigma)$.
Theorem 2.8. Assume that (2.18) holds. Then

$$
I-\left(T_{\mathcal{C}}^{-1}\right)^{*} K^{*} \text { is invertible in } \mathcal{L}\left(L^{\frac{p}{p-1}}(X \times V)\right)
$$

and the backward equation is well-posed in $\tilde{W}^{\frac{p}{p-1}}(X \times V)$ and the albedo operator $A_{\text {back }} \in$ $\mathcal{L}\left(L^{\frac{p}{p-1}}(\Gamma \backslash \mathcal{C}, \tau d \xi), L^{\frac{p}{p-1}}(\mathcal{C}, \tau d \xi)\right)$ is bounded. In addition the following Green's formula is valid

$$
\begin{equation*}
\int_{\Gamma_{+} \backslash \mathcal{C}_{+}} \psi(A \phi) \tau d \xi-\int_{\Gamma_{-} \backslash \mathcal{C}_{-}} \psi(A \phi) \tau d \xi=\int_{\mathcal{C}_{-}} \phi\left(A_{\mathrm{back}} \psi\right) \tau d \xi-\int_{\mathcal{C}_{+}} \phi\left(A_{\mathrm{back}} \psi\right) \tau d \xi \tag{2.25}
\end{equation*}
$$

Proof. Condition (2.18) already provides that

$$
I-K^{*}\left(T_{\mathcal{C}}^{-1}\right)^{*} \text { is invertible in } \mathcal{L}\left(L^{\frac{p}{p-1}}(X \times V)\right)
$$

Then by Jacobson's Lemma we obtain that $I-\left(T_{\mathcal{C}}^{-1}\right)^{*} K^{*}$ is invertible in $\mathcal{L}\left(L^{\frac{p}{p-1}}(X \times V)\right)$ and we can repeat Thm. 2.6 for the backward equation. Then a simple application of Green's formula over $X \times V$ on $v \cdot \nabla_{x}\left(\tau u_{1} u_{2}\right)=\tau v \cdot \nabla_{x}\left(u_{1} u_{2}\right)$ where $u_{1}$ (resp. $u_{2}$ ) solves the forward (resp. backward) Boltzmann equation with boundary condition $\phi$ on $\mathcal{C}$ (resp. $\psi$ on $\Gamma \backslash \mathcal{C}$ ).

The same proof provides the following result.
Theorem 2.9. Assume that (2.17) holds. Then

$$
I-\left(T_{\mathcal{C}}^{-1}\right)^{*} K^{*} \text { is invertible in } \mathcal{L}\left(\tau^{1-\frac{1}{p}} L^{\frac{p}{p-1}}(X \times V)\right)
$$

and the backward equation is well-posed in $W^{\frac{p}{p-1}}(X \times V)$ and the albedo operator $A_{\mathrm{back}} \in$ $\mathcal{L}\left(L^{\frac{p}{p-1}}(\Gamma \backslash \mathcal{C}, d \xi), L^{\frac{p}{p-1}}(\mathcal{C}, d \xi)\right)$ is bounded. In addition the following Green's formula is valid

$$
\begin{equation*}
\int_{\Gamma_{+} \backslash \mathcal{C}_{+}} \psi(A \phi) d \xi-\int_{\Gamma_{-} \backslash \mathcal{C}_{-}} \psi(A \phi) d \xi=\int_{\mathcal{C}_{-}} \phi\left(A_{\mathrm{back}} \psi\right) d \xi-\int_{\mathcal{C}_{+}} \phi\left(A_{\mathrm{back}} \psi\right) d \xi \tag{2.26}
\end{equation*}
$$

We conclude this section with a technical lemma on a gain of regularity in $L^{p}$-spaces of scattered components of the transport solution for a very specific geometry used in section 4.3. In that lemma, the velocity set $V$ is the unit sphere $\mathbb{S}^{d-1}$ and $X$ is the annulus $B\left(0, r_{1}\right) \backslash \overline{B\left(0, r_{2}\right)}$ where $0<r_{2}<r_{1}$.

We introduce the following norm in dimension $d \geq 3$. Let $\mathcal{M}$ the ( $3 d-5$ )- dimensional smooth manifold $\left\{\left(v_{-}, \omega, y\right) \in\left(\mathbb{S}^{d-1}\right)^{2} \times \mathbb{R}^{d} \mid v_{-} \cdot \omega=v_{-} \cdot y=\omega \cdot y=0\right\}$ and $P_{v_{-}, \omega, y}$ the 2 -dimensional plane passing through $y$ with directions $\omega$ and $v_{-}$for $\left(v_{-}, \omega, y\right) \in \mathcal{M}$. We also use the notation $\mathcal{M}_{v_{-}}$for the $(2 d-4)$ - dimensional smooth manifold $\left\{(\omega, y) \in \mathbb{S}^{d-1} \times\right.$ $\left.\mathbb{R}^{d} \mid\left(v_{-}, \omega, y\right) \in \mathcal{M}\right\}$ for $v_{-} \in \mathbb{S}^{d-1}$.

We denote by $\gamma_{v_{-}, \omega, y}$ the intersection of $P_{v_{-}, \omega, y}$ with the boundary $\partial X=\partial B\left(0, r_{1}\right) \cap$ $\partial B\left(0, r_{2}\right)$. The set $\gamma_{v_{-}, \omega, y}$ is either a circle or the union of 2 circles for almost every $\left(v_{-}, \omega, y\right) \in$ $\mathcal{M}$, and we denote by $\nu_{P_{v_{-}, \omega, y}}(z)$ a unit normal vector to $X \cap P_{v_{-}, \omega, y}$ at the boundary point $z \in \gamma_{v_{-}, \omega, y}$.

For a measurable bounded function $\phi$ on $\partial X \times V$, we consider the norm

$$
\|\phi\|_{L *(\Gamma)}=\int_{V}\left(\operatorname{supess}_{(\omega, y) \in \mathcal{M}_{v_{-}}} \int_{\gamma_{v_{-}, \omega, y}}|\phi|\left(\gamma_{v_{-}, \omega, y}, v_{-}\right)\left|\nu_{P_{v_{-}, \omega, y}}\left(\gamma_{v_{-}, \omega, y}\right) \cdot v_{-}\right| d \gamma_{v_{-}, \omega, y}\right) d v_{-}
$$

We denote by $L_{*}(\Gamma)$ the completion of $L^{\infty}(\partial X \times V)$ under this norm. For $\phi \in L_{*}(\Gamma)$, we also denote by $L_{\mathcal{C}} \phi$ the function obtained after applying the operator $L_{\mathcal{C}}$ to the restriction of $\phi$ to the set $\mathcal{C}$.

In dimension $d=2$, the space $L_{*}(\Gamma)$ is the usual space $L^{1}(\Gamma, d \xi)$. We then have the following regularity result, whose proof is postponed to Appendix A:

Lemma 2.10. Assume that $\sigma \in L^{\infty}(X \times V)$ and $k \in L^{\infty}\left(X \times V^{2}\right)$ where $V$ is the unit sphere $\mathbb{S}^{d-1}$ and $X$ is the annulus $B\left(0, r_{1}\right) \backslash \overline{B\left(0, r_{2}\right)}$ for some $0<r_{2}<r_{1}$.

In dimension $d=2$, the operator $\left[T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}\right]_{\mid \Gamma \backslash \mathcal{C}}$ is bounded from $L^{1}(\mathcal{C}, d \xi)$ to
$L^{p}(\Gamma \backslash \mathcal{C}, d \xi)$ and the operator $T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}$ is bounded from $L^{1}(\mathcal{C}, d \xi)$ to $L^{p}(X \times V)$ for $1 \leq$ $p<2$. When condition(2.17) is satisfied for some $1 \leq p<2$ then the operator $[(I-$ $\left.\left.T_{\mathcal{C}}^{-1} K\right)^{-1} T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}\right]_{\mid \Gamma \backslash \mathcal{C}}$ is bounded from $L^{1}(\mathcal{C}, d \xi)$ to $L^{p}(\Gamma \backslash \mathcal{C}, d \xi)$.

In dimension $d \geq 3$, the operator $\left[T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}\right]_{\mid \Gamma \backslash \mathcal{C}}$ is bounded from $L_{*}(\Gamma)$ to $L^{p}(\Gamma \backslash \mathcal{C}, d \xi)$ and the operator $T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}$ is bounded from $L_{*}(\Gamma)$ to $L^{p}(X \times V)$ for $1 \leq p<d$. When condition (2.17) is satisfied for some $1 \leq p<d$, then the operator $\left[\left(I-T_{\mathcal{C}}^{-1} K\right)^{-1} T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}\right]_{\mid \Gamma \backslash \mathcal{C}}$ is bounded from $L_{*}(\Gamma, d \xi)$ to $L^{p}(\Gamma \backslash \mathcal{C}, d \xi)$ and the operator $\left[L_{\mathcal{C}}\right]_{\mid \Gamma}$ is a bounded operator from $L_{*}(\Gamma)$ to $L_{*}(\Gamma)$ with a uniform bound $1+e^{2 \sqrt{r_{1}^{2}-r_{2}^{2}}\|\sigma\|_{\infty}}$.

## 3 Albedo operator and Fredholm theory

We now develop results on the well-posedness of the transport equation under additional regularity assumptions on the scattering coefficient. We assume below that $1<p<\infty$ and define

$$
\begin{equation*}
W_{\mathcal{C}}^{p}(X \times V):=\left\{u \in L^{p}(X \times V) \mid v \cdot \nabla_{x} u \in L^{p}(X \times V), u_{\mid \mathcal{C}} \in L^{p}(\mathcal{C}, d \xi)\right\} . \tag{3.1}
\end{equation*}
$$

We have the following result, identifying $W_{\mathcal{C}}^{p}(X \times V)$ with more standard spaces:
Lemma 3.1. We have

$$
\begin{align*}
W_{\mathcal{C}}^{p}(X \times V) & =W_{ \pm}^{p}(X \times V)  \tag{3.2}\\
& :=\left\{u \in L^{p}(X \times V) \mid v \cdot \nabla_{x} u \in L^{p}(X \times V), u_{\mid \Gamma_{ \pm}} \in L^{p}\left(\Gamma_{ \pm}, d \xi\right)\right\} .
\end{align*}
$$

Proof. According to [8], we have that $W_{-}^{p}(X \times V)=W_{+}^{p}(X \times V)=\left\{u \in L^{p}(X \times V) \mid v \cdot \nabla_{x} u \in\right.$ $\left.L^{p}(X \times V), u_{\mid \Gamma} \in L^{p}(\Gamma, d \xi)\right\}$. Hence we have $W_{-}^{p}(X \times V) \subseteq W_{\mathcal{C}}^{p}(X \times V)$. We now prove $W_{\mathcal{C}}^{p}(X \times V) \subseteq W_{-}^{p}(X \times V)$. Let $u \in W_{\mathcal{C}}^{p}(X \times V)$ and consider the functions $\chi_{ \pm}$defined by

$$
\chi_{ \pm}(x, v)=\left\{\begin{array}{l}
1 \text { when }\left(x \pm \tau_{ \pm}(x, v) v, v\right) \in \mathcal{C}_{ \pm} \\
0 \text { otherwise }
\end{array}\right.
$$

Note that $\chi_{+}+\chi_{-}=1$ and we have

$$
v \cdot \nabla_{x}\left(\chi_{ \pm} u\right)=\chi_{ \pm} v \cdot \nabla_{x} u,\left(\chi_{ \pm} u\right)_{\mid \Gamma_{ \pm} \backslash \mathcal{C}_{ \pm}}=0, \quad\left(\chi_{ \pm} u\right)_{\mid \mathcal{C}_{ \pm}}=u_{\mid \mathcal{C}_{ \pm}} .
$$

Thus, $\chi_{ \pm} u \in W_{-}^{p}(X \times V)$ and $u=\chi_{+} u+\chi_{-} u \in W_{-}^{p}(X \times V)$.
Lemma 3.2. The operator $T_{\mathcal{C}}^{-1}$ is bounded from $L^{p}(X \times V)$ to $W_{-}^{p}(X \times V)$.
Proof. We start with $u \in L^{p}(X \times V)$. Then $T_{\mathcal{C}}^{-1} u$ has the following properties

$$
v \cdot \nabla_{x} T_{\mathcal{C}}^{-1} u+\sigma T_{\mathcal{C}}^{-1} u=u
$$

and

$$
\begin{aligned}
\left\|\sigma T_{\mathcal{C}}^{-1} u\right\|_{L^{p}(X \times V)} & \leq\|\tau \sigma\|_{\infty} e^{\|\tau \sigma\|_{\infty}}\|u\|_{L^{p}}, \\
\left\|T_{\mathcal{C}}^{-1} u\right\|_{L^{p}(X \times V)} & \leq e^{\|\tau \sigma\|_{\infty}}\|\tau u\|_{L^{p}} \leq\|\tau\|_{\infty} e^{\|\tau \sigma\|_{\infty}}\|u\|_{L^{p}},
\end{aligned}
$$

and $\left(T_{\mathcal{C}}^{-1}\right)_{{ }_{\mathcal{C}}} u=0$. Thus, $T_{\mathcal{C}}^{-1}$ is a bounded operator from $L^{p}(X \times V)$ to $W_{\mathcal{C}}^{p}(X \times V)=$ $W_{-}^{p}(X \times V)$.

We are now ready to state several results on the compactness of the operator $T_{\mathcal{C}}^{-1} K$; see also [16, Chapter 4]. We first recall the

Lemma 3.3 ([12]). The bounded operator $M$ from $W_{-}^{p}(X \times V)$ to $L^{p}(X)$ defined by

$$
M u(x, v)=\int_{V} u(x, v) d v, u \in W_{-}^{p}(X \times V)
$$

is compact.
Lemma 3.4. Let $1<p<\infty$. Assume that

$$
k \in C\left(\bar{X}, L^{p}\left(V_{v}, L^{\frac{p}{p-1}}\left(V_{v^{\prime}}\right)\right)\right)
$$

The bounded operator $K$ from $W_{-}^{p}(X \times V)$ to $L^{p}(X \times V)$ is compact.
Proof. By density of $C^{1}(\bar{X} \times V \times V)$ in $C\left(\bar{X}, L^{p}\left(V_{v}, L^{\frac{p}{p-1}}\left(V_{v^{\prime}}\right)\right)\right)$ there exists a sequence $\left(k_{n}\right) \in$ $C^{1}(\bar{X} \times V \times V)$ so that

$$
\begin{equation*}
\lim _{n \rightarrow+\infty} k_{n}=k \text { in } C\left(\bar{X}, L^{p}\left(V_{v}, L^{\frac{p}{p-1}}\left(V_{v^{\prime}}\right)\right)\right) \tag{3.3}
\end{equation*}
$$

and

$$
\begin{equation*}
k_{n}\left(x, v^{\prime}, v\right)=\sum_{j=0}^{n} k_{n, j}(x, v) \phi_{n, j}\left(v^{\prime}\right),\left(x, v^{\prime}, v\right) \in \bar{X} \times V \times V \tag{3.4}
\end{equation*}
$$

for each $n \in \mathbb{N}$ and some functions $\left(k_{n, j}\right)_{0 \leq j \leq n} \in C(\bar{X} \times V)^{n+1},\left(\phi_{n, j}\right)_{0 \leq j \leq n} \in C(V)^{n+1}$. We define the operators

$$
\begin{equation*}
K_{n} f(x, v)=\int_{V} k_{n}\left(x, v^{\prime}, v\right) f\left(x, v^{\prime}\right) d v^{\prime}, f \in L^{p}(X \times V) \tag{3.5}
\end{equation*}
$$

We have

$$
K_{n} f(x, v)=\sum_{j=0}^{n} k_{n, j}(x, v) M\left(\phi_{n, j} f\right)(x), \text { a.e. }(x, v) \in X \times V ; f \in L^{p}(X \times V)
$$

The multiplication operator by the function $\phi_{n, j}$ (that we still denote by $\phi_{n, j}$ ) is bounded in $W_{-}^{p}(X \times V)$. Then $M\left(\phi_{n, j}.\right)$ is a compact operator from $W_{-}^{p}(X \times V)$ to $L^{p}(X \times V)$. Then multiplication operators by the functions $k_{n, j}$ (that we still denote by $k_{n, j}$ ) is bounded in $L^{p}(X \times V)$. Therefore $k_{n, j} M\left(\phi_{n, j}.\right)$ is a compact operator from $W_{-}^{p}(X \times V)$ to $L^{p}(X \times V)$. Hence we obtain that $K_{n}$ is a compact operator from $W_{-}^{p}(X \times V)$ to $L^{p}(X \times V)$.

The limit (3.3) shows that $K$ is the uniform limit of $\left(K_{n}\right)$ as bounded operators in $L^{p}(X \times$ $V)$. Therefore $K$ is also a compact operator from $W_{-}^{p}(X \times V)$ to $L^{p}(X \times V)$.

Our main compactness results is then:
Proposition 3.5. Let $1<p<\infty$. Assume that

$$
\begin{equation*}
k \in C\left(\bar{X}, L^{p}\left(V_{v}, L^{\frac{p}{p-1}}\left(V_{v^{\prime}}\right)\right)\right) \tag{3.6}
\end{equation*}
$$

Then the operator $K T_{\mathcal{C}}^{-1}$ is a compact operator in $L^{p}(X \times V)$.
Theorem 3.6. Under the assumption (2.10) the operator $I-K T_{\mathcal{C}}^{-1}$ is invertible in $L^{p}(X \times V)$ if and only if $I-T_{\mathcal{C}}^{-1} K$ is invertible in $L^{p}(X \times V)$ or in other words condition (2.18) is fulfilled (as well as the stronger condition (2.17)).

Under the stronger assumption (3.6), $I-T_{\mathcal{C}}^{-1} K$ is invertible if and only if 1 is not an eigenvalue of the compact operator $K T_{\mathcal{C}}^{-1}$. And if the scattering coefficient $k$ is replaced by $\lambda k$, then the forward transport equation with general boundary conditions is invertible for all values of $\lambda$ except possibly for a countable number of values $\lambda$ such that 1 belongs to the spectrum of $(\lambda K) T_{\mathcal{C}}^{-1}$, in which case the transport equation is not invertible.

The proof of the Theorem relies on the identity $(I-A B)^{-1}=I+A(I-B A)^{-1} B$ for bounded operators $A, B$ with $I-B A$ invertible. Indeed the operator $K$ defines a bounded operator in $L^{p}(X \times V)$ by Lemma 2.4. The rest of the statements relies on the standard spectral properties of compact operators.

Using a compactness result in [13], we may also derive a compactness result in the $L^{1}$ framework; see [16, Chapter 4].

We now develop the Fredholm theory of the albedo operator under the above compactness conditions. Let $1<p<\infty$ and $\mathcal{G}$ be a subset of $\Gamma$. We define $\gamma_{\mathcal{G}}$ the involution in $L^{\frac{p}{p-1}}(\mathcal{G}, \tau d \xi)$ (or $L^{\frac{p}{p-1}}(\mathcal{G}, d \xi)$ ) given by

\gamma_{\mathcal{G}}(\phi)(x, v)=\left\{\begin{array}{l}
\phi(x, v),(x, v) \in \mathcal{G} \cap \Gamma_{+}  \tag{3.7}\\
-\phi(x, v),(x, v) \in \mathcal{G} \cap \Gamma_{-} .
\end{array}\right.
$$

Theorem 3.7. Assume that (2.18) and (3.6) holds. Then the albedo operator $A \in \mathcal{L}\left(L^{p}(\mathcal{C}, \tau d \xi), L^{p}(\Gamma \backslash \mathcal{C}, \tau d \xi)\right)$ is a Fredholm operator of index 0. Moreover,

$$
\begin{equation*}
\operatorname{dim}(\operatorname{ker} A)=\operatorname{dim}\left(\operatorname{ker}\left(I-K T_{\Gamma \backslash \mathcal{C}}^{-1}\right)\right) \tag{3.8}
\end{equation*}
$$

Proof. We first prove that the albedo operator has a finite dimensional kernel. By the last proposition we know that $\left(T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)^{2}$ is a compact operator in $L^{p}(X \times V)$. Hence $\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$ has a finite dimensional kernel. Moreover for $u \in \operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$, we have $u=T_{\Gamma \backslash \mathcal{C}}^{-1} K u \in$ $\tilde{W}^{p}(X \times V)$,

$$
\begin{align*}
& A\left(u_{\mid \mathcal{C}}\right)=u_{\mid \Gamma \backslash \mathcal{C}}=0  \tag{3.9}\\
& v \cdot \nabla_{x} u+\sigma u=K u . \tag{3.10}
\end{align*}
$$

Hence, the operator $\Phi: \operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right) \rightarrow \operatorname{ker} A$ defined by $\Phi u:=u_{\mid \mathcal{C}}$ is well defined and actually an isomorphism. It is one-to-one, since by (3.10) and assumption (2.18), we have $u=\left(I-T_{\mathcal{C}}^{-1} K\right) L_{\mathcal{C}} u_{\mid \mathcal{C}}$ for any $u \in \operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$.

It is also onto. Take $g \in L^{p}(\mathcal{C}, \tau d \xi)$ and consider the solution $u \in \tilde{W}^{p}(X \times V)$ of the stationary Boltzmann equation (1.1) with boundary condition given by $g$. Then $u=T_{\Gamma \backslash \mathcal{C}}^{-1} K u+$ $L_{\Gamma \backslash \mathcal{C}} A g$, and we obtain that $u \in \operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$ when $A g=0$. Hence

$$
\operatorname{dim}(\operatorname{ker} A)=\operatorname{dim}\left(\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)\right)
$$

We now prove that the cokernel of $A$ is finite-dimensional. It is equivalent to proving that the kernel of $A^{*}$ is finite-dimensional. By (2.25) we actually have that

\begin{equation*}
\operatorname{ker} A^{*}=\gamma_{\Gamma \backslash \mathcal{C}}\left(\operatorname{ker} A_{\mathrm{back}}\right) \tag{3.11}
\end{equation*}
$$

Indeed we have

$$
\begin{aligned}
& \int_{\mathcal{C}} \psi\left(A_{\text {back }} \phi\right) \tau d \xi=-\left[-\int_{\mathcal{C}_{+}} \gamma_{\mathcal{C}}(\psi) A_{\text {back }}(\phi) \tau d \xi+\int_{\mathcal{C}_{-}} \gamma_{\mathcal{C}}(\psi)\left(A_{\text {back }} \phi\right) \tau d \xi\right] \\
= & -\left[\int_{\Gamma_{+} \backslash \mathcal{C}_{+}}\left(A \gamma_{\mathcal{C}}(\psi)\right) \phi \tau d \xi-\int_{\Gamma_{-} \backslash \mathcal{C}_{-}}\left(A \gamma_{\mathcal{C}}(\psi)\right) \phi \tau d \xi\right]=-\int_{\Gamma \backslash \mathcal{C}} \gamma_{\mathcal{C}}(\psi) A^{*}\left(\gamma_{\Gamma \backslash \mathcal{C}}(\phi)\right) \tau d \xi .
\end{aligned}
$$

Then as above we have that $\operatorname{ker} A_{\text {back }}$ is isomorphic to $\operatorname{ker}\left(I-\left(T_{\Gamma \backslash \mathcal{C}}^{-1}\right)^{*} K^{*}\right)$. The latter kernel is finite dimensional since $\left(T_{\Gamma \backslash \mathcal{C}}^{-1}\right)^{*} K^{*}=\left(K T_{\Gamma \backslash \mathcal{C}}^{-1}\right)^{*}$ is a compact operator and

$$
\begin{equation*}
\operatorname{dim}\left(\operatorname{ker} A^{*}\right)=\operatorname{dim}\left(\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1 *} K^{*}\right)\right) \tag{3.12}
\end{equation*}
$$

It remains to prove that

$$
\operatorname{dim}\left(\operatorname{ker} A^{*}\right)=\operatorname{dim}\left(\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)\right)=\operatorname{dim}\left(\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1 *} K^{*}\right)\right)=\operatorname{dim}(\operatorname{ker} A)
$$

Since $\left(T_{\Gamma \backslash \mathcal{C}}^{-1}\right)^{*} K^{*}$ is a compact operator, then $I-\left(\left(T_{\Gamma \backslash \mathcal{C}}^{-1}\right)^{*} K^{*}\right)$ is a Fredholm operator of index $0\left[10\right.$, Page 208] and $\operatorname{dim}\left(\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1}{ }^{*} K^{*}\right)\right)=\operatorname{dim}\left(\operatorname{ker}\left(I-K T_{\Gamma \backslash \mathcal{C}}^{-1}\right)\right)$. Therefore it remains to prove that

$$
\begin{equation*}
\operatorname{dim}\left(\operatorname{ker}\left(I-K T_{\Gamma \backslash \mathcal{C}}^{-1}\right)\right)=\operatorname{dim}\left(\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)\right) \tag{3.13}
\end{equation*}
$$

We just have to prove that $T_{\Gamma \backslash \mathcal{C}}^{-1}$ defines an isomorphism from $\operatorname{ker}\left(I-K T_{\Gamma \backslash \mathcal{C}}^{-1}\right)$ to $\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$. Indeed we have $T_{\Gamma \backslash \mathcal{C}}^{-1} u=T_{\Gamma \backslash \mathcal{C}}^{-1} K T_{\Gamma \backslash \mathcal{C}}^{-1} u$ when $u=K T_{\Gamma \backslash \mathcal{C}}^{-1} u$ and $v \cdot \nabla_{x} T_{\Gamma \backslash \mathcal{C}}^{-1} u+\sigma T_{\Gamma \backslash \mathcal{C}}^{-1} u=u$, which proves that $T_{\Gamma \backslash \mathcal{C}}^{-1}$ is one-to-one. For $w \in \operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$ then $w=T_{\Gamma \backslash \mathcal{C}}^{-1} K w \in \tilde{W}^{p}(X \times V)$ and $v \cdot \nabla_{x} w+\sigma w=K w$. Hence set $u=K w$ and we have $K T_{\Gamma \backslash \mathcal{C}}^{-1} u=K T_{\Gamma \backslash \mathcal{C}}^{-1} K w=K w=u$. Hence $T_{\Gamma \backslash \mathcal{C}}^{-1}$ is onto from $\operatorname{ker}\left(I-K T_{\Gamma \backslash \mathcal{C}}^{-1}\right)$ to $\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$. Identity (3.13) is proved.

Theorem 3.8. Assume that (2.17) and (3.6) holds. Then the albedo operator $A \in \mathcal{L}\left(L^{p}(\mathcal{C}, d \xi)\right.$, $\left.L^{p}(\Gamma \backslash \mathcal{C}, d \xi)\right)$ is a Fredholm operator of index 0 and (3.8) holds.

Proof. The proof follows the same lines as the proof of Theorem 3.7. By the last proposition $\left(T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)^{2}$ is a compact operator in $\tau^{\frac{1}{p}} L^{p}(X \times V)$. Hence $\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$ has a finite dimensional kernel. Moreover for $u \in \operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)$, we have $u=T_{\Gamma \backslash \mathcal{C}}^{-1} K u \in W_{\Gamma \backslash \mathcal{C}}^{p}(X \times V)$ and (3.9) and (3.10) hold. Hence the operator $\Phi: \operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right) \rightarrow \operatorname{ker} A$ defined by $\Phi u:=u_{\mid \mathcal{C}}$ is well defined and it is actually an isomorphism. Use (2.17), $W^{p}(X \times V), L^{p}(\mathcal{C}, d \xi)$ in place of (2.18), $\tilde{W}^{p}(X \times V), L^{p}(\mathcal{C}, \tau d \xi)$ appearing in the proof of Theorem 3.7. Hence

$$
\operatorname{dim}(\operatorname{ker} A)=\operatorname{dim}\left(\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1} K\right)\right)
$$

The cokernel of $A$ is finite-dimensional (replace $\tau d \xi$ by $d \xi$ in the Green's formula in the proof of Theorem 3.7), and

$$
\operatorname{dim}\left(\operatorname{ker} A^{*}\right)=\operatorname{dim}\left(\operatorname{ker}\left(I-T_{\Gamma \backslash \mathcal{C}}^{-1 *} K^{*}\right)\right)
$$

Note that $\operatorname{ker}\left(I-\left(T_{\Gamma \backslash \mathcal{C}}^{-1}\right)^{*} K^{*}\right)$ does not depend on the ambient space $\tau^{1-\frac{1}{p}} L^{\frac{p}{p-1}}(X \times V)$ or $L^{\frac{p}{p-1}}(X \times V)$ because of nice properties of $\left(T_{\Gamma \backslash \mathcal{C}}^{-1}\right)^{*}$. We conclude as in the end of the previous proof.

## 4 Control of solutions on convex subdomains

We now consider boundary control problems for the transport equation. By boundary control, we mean control of the transport solution on $\Gamma \backslash \mathcal{C}$ from prescriptions on $\mathcal{C}$. We primarily consider two situations. The first one, treated in this section, concerns the control of a transport solution on $X_{0} \subset X$ from the incoming conditions on $\Gamma_{-}(X)$. Denoting by $Y=X \backslash X_{0}$, this is a problem of control of $\Gamma(Y) \backslash \mathcal{C}$ from $\mathcal{C} \subset \Gamma(Y)$. The second one is the control on the outgoing set $\Gamma_{+}$from the prescription of the incoming conditions on $\Gamma_{-}$. It will be analyzed in the next section.

### 4.1 Extension result

We start with an extension result, which is a relatively direct consequence of the forward transport theory developed in section 2.

Let $Z$ and $Y$ be bounded open domains of class $C^{1}, Z \cap Y=\emptyset$ with $Z$ convex and $\partial Z \subset \partial Y$. Define $Z_{\text {ext }}=\bar{Z} \cup Y$ the open domain containing $Z, Y$. The objective is to write any transport solution on $Z$ as the restriction of a transport solution on $Z_{\text {ext }}$. We will see that such extended solutions are not unique.

We assume that $\sigma \in L^{\infty}(Y \times V)$. Let $1 \leq p<\infty$. We consider the boundary value problem (1.1) in $Z$ where the boundary conditions are taken at " $\left(\mathcal{C}_{-}, \mathcal{C}_{+}\right)=\left(\Gamma_{-}(Z), \emptyset\right)$ ". For $g \in L^{p}\left(\Gamma_{-}(Z), d \xi\right)$, let us assume that there exists $u_{0} \in W^{p}(Z \times V)$ solution of the Boltzmann equation in $Z \times V$ with $u_{0 \mid \Gamma_{-}(Z)}=g$. Existence of $u_{0}$ is granted when the condition (2.18) related to $\left(Z, \Gamma_{-}(Z), \emptyset\right)$ holds.

Set

$$
\begin{aligned}
& \mathcal{G}_{-}\left(Z_{\text {ext }}, Z\right)=\left\{(x, v) \in \Gamma_{-}\left(Z_{\text {ext }}\right) \mid x+t v \notin Z, \quad t \in\left[0, \tau_{+}(x, v)\right]\right\}, \\
& \mathcal{C}_{-, 1}=\mathcal{G}_{-}\left(Z_{\mathrm{ext}}, Z\right) \cup \Gamma_{+}(Z), \quad \mathcal{C}_{+, 1}=\Gamma_{-}(Z), \quad \mathcal{C}_{1}=\mathcal{C}_{-, 1} \cup \mathcal{C}_{+, 1} .
\end{aligned}
$$

Note that $\Gamma_{ \pm}(Y) \cap(\partial Z \times V)=\Gamma_{\mp}(Z)$. Let $\gamma \in L^{p}\left(\mathcal{G}_{-}\left(Z_{\text {ext }}, Z\right), d \xi\right)$ and assume that there exists a solution $u_{1} \in W^{p}(Y \times V)$ of the Boltzmann equation in $Y \times V$ with $u_{1 \mid \mathcal{G}_{-}\left(Z_{\text {ext }}, Z\right)}=\gamma$ and $u_{1 \Gamma(Z)}=u_{0 \mid \Gamma(Z)}$. Existence of $u_{1}$ is granted when the related condition (2.18) holds for $\left(Y, \mathcal{C}_{1}\right)$, for instance when $Y$ is 'sufficiently small'. Set now

$$
u(x, v):= \begin{cases}u_{0}(x, v), & (x, v) \in Z \times V,  \tag{4.1}\\ u_{1}(x, v), & (x, v) \in Y \times V\end{cases}
$$

Lemma 4.1. The function $u$ belongs to $W^{p}\left(Z_{\text {ext }} \times V\right)$ and satisfies the Boltzmann equation in $Z_{\text {ext }} \times V$.

Proof. We have $u_{0} \in W^{p}(Z \times V)$ and $u_{1} \in W^{p}(Y \times V)$. Hence we have $\tau^{-\frac{1}{p}} u \in L^{p}\left(Z_{\text {ext }} \times V\right)$ (indeed we always have $\max (\tau(Y), \tau(Z)) \leq \tau\left(Z_{\text {ext }}\right.$ ), where $\tau(X)$ is the function $\tau$ related to a bounded open set $X$ ). We now prove that the weak derivative $v \cdot \nabla_{x} u$ exists and is equal to $K u-\sigma u$, which will prove that $u \in W^{p}\left(Z_{\text {ext }} \times V\right)$ and that $u$ solves the Boltzmann equation in $Z_{\text {ext }} \times V$. Indeed, for $\phi \in C_{0}^{1}\left(Z_{\text {ext }} \times V\right)$

$$
\begin{aligned}
& \int_{Z_{\mathrm{ext} \times V}} u\left(v \cdot \nabla_{x} \phi\right) d x d v=\int_{Z \times V} u_{0}\left(v \cdot \nabla_{x} \phi\right) d x d v+\int_{Y \times V} u_{1}\left(v \cdot \nabla_{x} \phi\right) d x d v \\
= & -\int_{Z \times V}\left(v \cdot \nabla_{x}\right) u_{0} \phi d x d v+\int_{\Gamma_{+}(Z)} u_{0} \phi d \xi-\int_{\Gamma_{-}(Z)} u_{0} \phi d \xi \\
& -\int_{Y \times V}\left(v \cdot \nabla_{x}\right) u_{1} \phi d x d v-\int_{\Gamma_{-}(Y) \cap(\partial Z \times V)} u_{1} \phi d \xi+\int_{\Gamma_{+}(Y) \cap(\partial Z \times V)} u_{1} \phi d \xi \\
= & -\int_{Z \times V}\left(K u_{0}-\sigma u_{0}\right) \phi d x d v-\int_{Y \times V}\left(K u_{1}-\sigma u_{1}\right) \phi d x d v=-\int_{Z_{\mathrm{ext}} \times V}(K u-\sigma u) \phi d x d v .
\end{aligned}
$$

Remark 4.2. The extension result may fail when $\partial Y \cap \partial Z$ is not the boundary of the convex hull of $Z$. In that case, the solution of the Boltzmann equation in $Z$ must satisfy additional compatibility conditions at the boundary $\partial Z \cap \partial Y$.

Note that the extension result was very specific to the transport equations. Another way of stating the above result is to observe that any transport solution on a convex domain $Z$ may be seen as the restriction of a transport solution on a larger domain. This is clearly not true for solutions of elliptic or even wave equations, where restrictions to subsets of solutions defined on large domains have regularity properties that arbitrary solutions on such subsets do not need to possess. Such extensions are clear in the absence of scattering (only for convex domains $Z$ ). Our main result is that they continue to hold in the presence of scattering.

### 4.2 Control by a layer peeling argument

In this section, we still assume $1 \leq p<\infty$. Let $\rho \in C^{2}\left(\mathbb{R}^{d}\right)$ so that

$$
\begin{equation*}
\text { Hess } \rho(x)>0 x \in \mathbb{R}^{d} \backslash\{0\}, \nabla \rho(0)=0 \text { and } \rho(0)=-1 . \tag{4.2}
\end{equation*}
$$

We also assume that $|\rho(x)| \rightarrow \infty$ as $|x| \rightarrow \infty$. For $-1<s \leq 1$, we denote by $Z_{s}$ the convex and bounded domain $\left\{x \in \mathbb{R}^{d} \mid \rho(x)<s\right\}$.

For $-1<s_{1}<s_{2} \leq 1$, we denote

$$
\begin{equation*}
\mathcal{G}_{-}\left(s_{2}, s_{1}\right):=\left\{(x, v) \in \Gamma_{-}\left(Z_{s_{2}}\right) \mid(x+\mathbb{R} v) \cap Z_{s_{1}}=\emptyset\right\}, 1 \leq k \leq N . \tag{4.3}
\end{equation*}
$$

Consider $X:=Z_{1} \backslash \bar{Z}_{0}$. Then the following result holds.
Theorem 4.3. Let $\sigma \in L^{\infty}(X \times V)$. Let $k \in L^{\infty}\left(X, L^{p}\left(V_{v}, L^{\frac{p}{p-1}}\left(V_{v^{\prime}}\right)\right)\right.$ when $p>1$ and $k \in L^{\infty}(X \times V \times V)$ when $p=1$. Then there exists $\varepsilon>0$ so that for any $(\beta, \gamma) \in L^{p}\left(\partial Z_{0} \times\right.$ $V, d \xi) \times L^{p}\left(\mathcal{G}_{-}(1,1-\varepsilon), d \xi\right)$ there exists a solution of the linear Boltzmann transport equation $u \in W^{p}(X \times V)$ with the following boundary conditions

$$
\begin{equation*}
u_{\mid \partial Z_{0} \times V}=\beta, u_{\mid \mathcal{G}_{-}(1,1-\varepsilon)}=\gamma . \tag{4.4}
\end{equation*}
$$

The theorem should be interpreted as follows. A transport solution is constructed on the domain $X \times V$ with boundary conditions arbitrarily prescribed on the whole boundary of $Z_{0}$, i.e., on $\Gamma_{+}\left(Z_{0}\right) \cup \Gamma_{-}\left(Z_{0}\right)$, as well as on the incoming directions of $Z_{1}$ that are sufficiently grazing. How grazing, i.e., how small $\varepsilon$ has to be, depends on the scattering coefficients.

The proof uses the following Lemma. Let $N \in \mathbb{N}$, and denote

In each layer $Y_{k, N}$ we denote $\tau_{k}$ the function $\tau$ related to $Y_{k, N}$,

and we denote $L_{\mathcal{C}_{k}}, T_{\mathcal{C}_{k}}^{-1}, K, A_{\mathcal{C}_{k}}$ the operators " $L_{\mathcal{C}}, T_{\mathcal{C}}^{-1}, K$ and $A$ " introduced in section 2 for the couple "domain-boundary conditions $(X, \mathcal{C})$ " $=\left(Y_{k, N}, \mathcal{C}_{k}\right)$.

Lemma 4.4. There exists a constant $C_{\rho}$ so that

First assume that $\left|\nabla \rho\left(x+s_{0} v\right) \cdot v\right| \leq \frac{1}{\sqrt{N}}$. Then

\geq & C_{1}\left(\tau_{k}-s_{0}\right)^{2}(x, v)-\frac{1}{\sqrt{N}}\left(\tau_{k}(x, v)-s_{0}\right)
\end{aligned}
$$

where $C_{1}=\inf _{(z, w) \in X \times V} \operatorname{Hess} \rho(z)(w, w)$, and we obtain that $\tau_{k}(x, v)-s_{0} \leq \frac{1}{\sqrt{N}} \frac{1+\sqrt{1+4 C_{1}}}{2 C_{1}}$. Similarly replacing $x+\tau_{k}(x, v) v$ by $x$, we obtain that $s_{0} \leq \frac{1}{\sqrt{N}} \frac{1+\sqrt{1+4 C_{1}}}{2 C_{1}}$, and we get $\tau_{k}(x, v) \leq$ $\frac{2}{\sqrt{N}} \frac{1+\sqrt{1+4 C_{1}}}{2 C_{1}}$. Now assume that $\left|\nabla \rho\left(x+s_{0} v\right) \cdot v\right| \geq \frac{1}{\sqrt{N}}$. Then $\frac{1}{N}=\left|\rho\left(x+\tau_{k}(x, v) v\right)-\rho(x)\right| \geq$ $\frac{\tau_{k}(x, v)}{\sqrt{N}}$.

Proof of Theorem 4.3. Let $N \in \mathbb{N}, N \geq 3$ so that

when $p=1(|V|$ is the nonzero Lebesgue measure of $V$ as a $(n-1)$-dimensional closed hypersurface or as a bounded open set in $\mathbb{R}^{n}$ excluding 0 ). We have

Using Lemma 4.4, it follows that estimate (2.19) is fulfilled in each subdomain $Y_{k, N}, 1 \leq k \leq N$ when $p>1$. When $p=1$ the estimate (2.20) is fulfilled instead. We first consider (1.1) in $Y_{1, N}$ and obtain that there exists a unique solution $u_{1} \in W^{p}\left(Y_{1, N} \times V\right)$ so that $u_{1 \left\lvert\, \Gamma\left(Z_{\frac{1}{N}}\right)\right.}=\beta$, $u_{1 \left\lvert\, \mathcal{G}_{\frac{1}{N}, 0}\right.}=0$, where $\mathcal{G}_{\frac{k}{N}, \frac{k-1}{N}}$ is defined by (4.3). Then inductively we consider the unique solution $u_{k} \in W^{p}\left(Y_{k, N} \times V\right)$ of (1.1) in $Y_{k, N}$ with boundary conditions $u_{k \left\lvert\, \Gamma\left(Z_{\frac{k-1}{N}}\right)\right.}=u_{k-1 \left\lvert\, \Gamma\left(Z_{\frac{k-1}{N}}\right)\right.}$ and $u_{k_{\left\lvert\, \mathcal{G}_{-}\left(\frac{k}{N}, \frac{k-1}{N}\right)\right.}=0 \text { for } k<N \text {. For } k=N \text { we consider the unique solution } u_{N} \in W^{p}\left(Y_{N, N} \times V\right), ~\left(Y^{\prime}\right)}$ of $(1.1)$ in $Y_{N, N}$ with boundary conditions $u_{N \left\lvert\, \Gamma\left(Z_{\frac{N-1}{N}}\right)\right.}=u_{N-1 \left\lvert\, \Gamma\left(Z_{\frac{N-1}{N}}\right)\right.}$ and $u_{N \left\lvert\, \mathcal{G}_{-}\left(\frac{k}{N}, \frac{k-1}{N}\right)\right.}=\gamma$. Then using the extension Lemma 4.1 it follows that the function $u$ equal to $u_{k}$ in each $Y_{k, N}$, $1 \leq k \leq N$, solves the transport equation with boundary condition $u_{\mid \partial Z_{0} \times V}=\beta, u_{\left\lvert\, \mathcal{G}_{-}\left(1, \frac{N-1}{N}\right)\right.}=$ $\gamma, \varepsilon=\frac{1}{N}$.

A first conclusion of this theorem is that a transport solution posed on a convex domain $Z_{0}$ can be controlled from the boundary of a larger convex domain $Z_{1}$. This generalizes results obtained in [3] and finds applications in a class of hybrid inverse problems for the transport equation; see [3].

Another conclusion concerns the violation of a Unique Continuation Property (UCP) for the transport equation in the following sense. No matter "how big" the scattering coefficient is, this does not imply a unique continuation property. Indeed let $u_{1}$ and $u_{2}$ be solutions of the transport equation with boundary conditions $u_{1 \mid \Gamma \cap\left(\partial Z_{0} \times V\right)}=u_{2 \mid \Gamma \cap\left(\partial Z_{0} \times V\right)}$ and $u_{i \mid \mathcal{G}_{\varepsilon}}=\gamma_{i}$,
$i=1,2, \gamma_{1} \neq \gamma_{2}$. Thus, $w=u_{1}-u_{2}$ is a non zero solution of the transport equation with zero incoming and outgoing boundary conditions at $\partial Z_{0}$. Therefore $w$ can be continued by zero in $Z_{0}$ and the continuation remains a solution of the Boltzmann transport equation in $Z_{1}$.

The above results should be contrasted with the case of second-order scalar elliptic equations. For such equations, the UCP holds and is equivalent to a Runge Approximation stating that any elliptic solution on a (not necessarily convex) subdomain may be approximately controlled from the boundary. On the other hand, transport solutions in the presence of large scattering (small mean free paths $\varepsilon$ ) are well approximated by diffusion solutions, with a vanishing error as $\varepsilon \rightarrow 0$. The latter limit is therefore singular as $\varepsilon \rightarrow 0$. For each $\varepsilon>0$, we obtain an exact controllability of the transport solution on a convex sub-domain while UCP does not hold. In the limit ' $\varepsilon=0$ ' of the diffusion equation, the control is only approximate and a result of the UCP.

Of course, the above exact control has to become unstable in the limit $\varepsilon \rightarrow 0$. This instability is analyzed in the next section.

### 4.3 Example of boundary control in the diffusive regime

In this subsection the domain $X$ is the annulus $B(0,2) \backslash \overline{B(0,1)}$, and the velocity space $V$ is the $(d-1)$-dimensional unit sphere $\mathbb{S}^{d-1}$. We assume that the absorption and scattering coefficients are constant: $\sigma=\varepsilon^{-1}$ and $k=|V|^{-1} \varepsilon^{-1}$. Hence the linear Boltzmann equation is

$$
v \cdot \nabla_{x} u(x, v)+\frac{1}{\varepsilon}(u(x, v)-\bar{u}(x))=0, \quad(x, v) \in X \times V .
$$

Here $\bar{u}$ is the mean value of $u$ over $V$.
We also slightly change the setting of the previous subsection: $Z_{0}$ is the inner ball $B(0,1)$ of center 0 and radius 1 and the layers $Y_{k, N}$ are now the annuli of thickness $\frac{1}{N} B\left(0, \frac{k}{N}+\right.$ 1) $\backslash \overline{B\left(0, \frac{k-1}{N}+1\right)}$ and $Z_{\frac{k}{N}}=B\left(0, \frac{k}{N}+1\right)$ while the sets $\mathcal{G}_{-}\left(\frac{k}{N}, \frac{k-1}{N}\right)$ are defined by (4.3). In this new setting, Lemma 4.4 is replaced by the explicit estimates: For $(x, v) \in Y_{k, N} \times V$

Conditions (2.19) and (2.20) are satisfied inside any layer $Y_{k, N}$ when

We construct a solution $u$ as in the proof of Theorem 4.3. We set $\beta=0$ on $\partial Z_{0} \times V$ which means that our constructed solution vanishes in the inner ball $Z_{0}$, and we place a boundary source $\phi$ at the boundary of the first layer:

$$

Also, $C_{p}$ and $C_{p, \varepsilon}, 1 \leq p<d$, denote the constants:

where $\left\||\cdot \||\right.$ denotes either the uniform norm of linear bounded operators from $L^{1}\left(\mathcal{C}_{k}, d \xi\right)$ to $L^{p}\left(\Gamma\left(Z_{\frac{k}{N}}\right) \backslash \mathcal{C}_{k}, d \xi\right)$ in dimension $d=2$ or the uniform norm of linear bounded operators from $L_{*}\left(\Gamma\left(Z_{\frac{k}{N}}^{N}\right)\right)$ to $L^{p}\left(\Gamma\left(Z_{\frac{k}{N}}\right) \backslash \mathcal{C}_{k}, d \xi\right)$ in dimension $d \geq 3$.

Lemma 4.5. Let $1 \leq p<d$. For $k=1 \ldots N, s=\frac{k}{N}$, we have

where the source $\phi \in L^{\infty}\left(\mathcal{G}_{-}\left(\frac{1}{N}, 0\right)\right)$ is extended by 0 on $\cup_{l=1}^{N} \partial Z_{\frac{l}{N}} \times V$. Both $f_{0}^{(k)}$ and $f_{1}^{(k)}$ vanish on $\mathcal{G}_{-}\left(s, s-\frac{1}{N}\right)$ when $k \geq 2$.

In addition

This lemma is proved in appendix B.

Construction of the source. Let $\eta \in(0,1)$ and $\rho \in C_{0}^{\infty}(\mathbb{R}, \mathbb{R}), \rho \geq 0, \operatorname{supp} \rho \subseteq(-1,1)$ with $\int_{-1}^{1} \rho(s) d s=1$ and $\rho$ even. We set

When $\eta \leq \frac{1}{2 N}$, then any ray $x+\mathbb{R} v,(x, v) \in \operatorname{supp} \rho_{\eta}$, intersects the ball $Z_{\frac{1}{N}}$ without penetrating $Z_{0}$. We denote by $u_{\eta}$ the transport solution in Lemma 4.5 where " $\phi$ " $=\phi_{\eta}=\left[\rho_{\eta}\right]_{\left\lvert\, \Gamma_{-}\left(Z_{\frac{1}{N}}\right)\right.}$.

We obtain the following result.
Theorem 4.6. Let $N \geq 2$. The source $\phi_{\eta}$ satisfies

for some universal constant $C$ and a constant $\tilde{C}$ which depends only on $\rho$, then the lower bound (4.16) holds.

The theorem is also proved in appendix B. Its interpretation is as follows. For any source $\phi_{\eta}$ generating a solution of order $O(1)$ in the vicinity of the ball $B(0,1)$, while the solution is exactly 0 inside that ball, then the transport solution inside the ball $B(0,2)$ is necessarily exponentially large (see (4.16)) close to $|x|=2$. Equivalently, by linearity of the transport equation, the above rescaled control of order $O(1)$ at the boundary $|x|=2$ generates a source in the vicinity of $|x|=1$ of order at most $e^{-\frac{1}{2 \varepsilon}}$. This provides a quantitative example of the instability of the boundary control in the diffusive regime that is consistent with the unique continuation principle that applies in the diffusion limit.

## 5 Control of outgoing boundary conditions

We now consider the control problem aiming to find incoming conditions on $\Gamma_{-}$such that the outgoing conditions on $\Gamma_{+}$are prescribed. This is a question on the range of the albedo operator. We obtained in an earlier section that the albedo operator was a Fredholm operator with vanishing index. We now show that the dimensions of its kernels and co-kernels, which have to be equal, do not necessarily vanish. In that case, some outgoing conditions cannot be controlled from $\Gamma_{-}$, answering the control problem negatively. By duality, this also shows the existence of non-trivial incoming conditions such that nothing comes out of the domain (the trace of the solution on $\Gamma_{+}$vanishes.

### 5.1 Selfadjoint operators

In this section we assume that $p=2$ and consider the setting with $\mathcal{C}=\Gamma_{-}$and hence $\Gamma \backslash \mathcal{C}=\Gamma_{+}$. We denote by $L_{\text {even }}^{2}(X \times V)$, resp. $L_{\text {odd }}^{2}(X \times V)$, the closed subspace of $L^{2}(X \times V)$ that consists of functions that are even, resp. odd, in the $v$-variable:

We start with the following lemma:

The right-hand side goes to $\infty$ as $C \rightarrow+\infty$. Hence for $C$ large enough the right-hand side of the latter estimate is bigger than 1 and the selfadjoint operator $R T_{\Gamma_{+}}^{-1} R$ admits a positive eigenvalue $\mu_{0}$ bigger than one. And $\mu_{0}$ is also an eigenvalue for the operator $K T_{\Gamma_{+}}^{-1}=R^{2} T_{\Gamma_{+}}^{-1}$. Then rescaling $k$ by $\mu_{0}^{-1} k$ we obtain that $\mu_{0}^{-1} K T_{\Gamma_{+}}^{-1}$ has 1 as an eigenvalue. By (5.5) it follows that the albedo operator for the coefficients $\left(\sigma, \mu_{0}^{-1} k\right)$ has a nontrivial kernel.

We have the following improvement of Theorem 5.3.

& \geq \gamma_{1}(C)\left(1-\frac{N(N-1)}{2 \gamma_{2}(C)}\right) \rightarrow+\infty,
\end{aligned}
$$

as $C \rightarrow \infty$. Therefore, for $C$ sufficiently large, $R T_{\Gamma_{+}}^{-1} R$ must have (at least) $N$ positive eigenvalues greater than one. As a consequence, $K T_{\Gamma_{+}}^{-1}$ also has $N$ positive eigenvalues greater than one.

Theorem 5.3 shows that the albedo operator has a non-trivial kernel for specific choices of the scattering coefficients $(\sigma, k)$. Theorem 5.4 states that $(\sigma, \lambda k)$ gives rise to non-trivial kernels for $N$ different values of $\lambda$ (counting multiplicities). Since the index of the albedo operator vanishes, we obtain by duality a corresponding number of incoming conditions on $\Gamma_{-}$ leading to vanishing outgoing solutions on $\Gamma_{+}$.

The next result shows that when the kernel is non-trivial, it is generically one-dimensional.

### 5.3 Simple eigenvalues are generic.

Theorem 5.5. Let $\sigma \in C(\bar{X} \times V)$ satisfy (5.1). Let $H$ be the subspace of $C\left(X, L^{2}\left(V^{2}\right)\right)$ defined by

$$
H:=\left\{k \in C(\bar{X} \times V \times V) \mid k \text { satisfies (5.6) and } K \text { nonnegative operator in } L^{2}(X \times V)\right\} .
$$

Then there is a dense subset $D$ of $H$ in $C(\bar{X} \times V \times V)$ so that for any $k \in D$ the non zero eigenvalues of the operator $T_{\Gamma_{+}}^{-1} K$ are simple. In addition all the eigenvalues of the operator $T_{\Gamma_{+}}^{-1} K$ restricted to $L_{\text {even }}^{2}(X \times V)$ are generically simple.

Proof. We first prove that 0 is generically not an eigenvalue of the operator $T_{\Gamma_{+}}^{-1} K$ restricted to $L_{\text {even }}^{2}(X \times V)$. Assume that $\lambda=0$ is an eigenvalue for $T_{\Gamma_{+}}^{-1} K$ restricted to $L_{\text {even }}^{2}(X \times V)$. This is equivalent to saying that 0 is an eigenvalue for $K P_{\text {even }}$ since $T_{\Gamma_{+}}^{-1}$ is one-to-one. Therefore we just need to consider an appropriate deformation of the nonnegative operator $K$.

Let $\left(e_{n}\right)_{n \in \mathbb{N}}$ be an orthornormal basis of $L_{\text {even }}^{2}(V)=\left\{\phi \in L^{2}(V) \mid \phi(v)=\phi(-v)\right\}$ so that the basis is made of smooth functions. Then we would like to consider the following deformation

$$
K_{\tau}:=K+\tau K_{w} .
$$

where

$$
w\left(v^{\prime}, v\right)=\sum_{n \in \mathbb{N}} \frac{e_{n}(v) e_{n}\left(v^{\prime}\right)}{\gamma_{n}}
$$

and the $\gamma_{n}$ are appropriately chosen positive constants so that the series is absolutely convergent and $w \in C^{\infty}(V \times V)$. Here

$$
K_{w} \phi(x, v)=\int_{V} w\left(v^{\prime}, v\right) \phi\left(x, v^{\prime}\right) d v^{\prime} .
$$

We would like to prove that for small positive $\tau$, then $K_{\tau}$ is one-to-one on $L_{\text {even }}^{2}(X \times V)$. We have

$$
\left\langle K_{\tau} \phi, \phi\right\rangle \geq \tau \sum_{n \in \mathbb{N}} \gamma_{n}^{-1} \int_{X}\left|\left\langle e_{n}, \phi(x, .)\right\rangle_{L^{2}(V)}\right|^{2}
$$

for any $\phi \in L_{\text {even }}^{2}(X \times V)$. Therefore, for $\phi \in L_{\text {even }}^{2}(X \times V)$ and $\tau>0, K_{\tau} \phi=0$ and we have $\sum_{n \in \mathbb{N}} \gamma_{n}^{-1} \int_{X}\left|\left\langle e_{n}, \phi(x, .)\right\rangle_{L^{2}(V)}\right|^{2} d x=0$, which proves that $\phi=0$. Hence 0 is not an eigenvalue of the operator $T_{\Gamma_{+}}^{-1} K_{\tau}$ restricted to $L_{\text {even }}^{2}(X \times V)$. This proves the second statement of the Theorem assuming the first one is proved.

For $\gamma \in C(\bar{X} \times V \times V)$ satisfying (5.6), we denote by $K_{\gamma}$ the bounded self-adjoint operator in $L^{2}(X \times V)$

$$
K_{\gamma} \phi(x, v)=\int_{V} \gamma\left(x, v^{\prime}, v\right) \phi\left(x, v^{\prime}\right) d v^{\prime},(x, v) \in X \times V, \phi \in L^{2}(X \times V)
$$

For $\left(\gamma_{1}, \gamma_{2}\right) \in C(\bar{X} \times V \times V)^{2}$ both satisfying (5.6), the following operator identity holds

$$
K_{\gamma_{1}} K_{\gamma_{2}}+K_{\gamma_{2}} K_{\gamma_{1}}=K_{\gamma_{3}},
$$

where $\gamma_{3} \in C(\bar{X} \times V \times V)$ also satisfies (5.6) and is defined by

$$
\gamma_{3}\left(x, v^{\prime}, v\right)=\int_{V}\left(\gamma_{1}\left(x, v^{\prime \prime}, v\right) \gamma_{2}\left(x, v^{\prime}, v^{\prime \prime}\right)+\gamma_{2}\left(x, v^{\prime \prime}, v\right) \gamma_{1}\left(x, v^{\prime}, v^{\prime \prime}\right)\right) d v^{\prime \prime}
$$

We also consider a selfadjoint square root $R$ of the operator $K$, see [19, Theorem VI.9]. We recall that

$$
R=\sqrt{M} \sum_{n=0}^{\infty} c_{n}\left(I-\frac{K}{M}\right)^{n}
$$

for $M$ large enough where the $c_{i}$ 's are all negative numbers for $i>0$ and their series is convergent. Here the operator $I-\frac{K}{M}$ is a selfadjoint bounded and nonnegative operator and its uniform norm is 1 by assumption on the function $k \in H$. We note that for $(\phi, \psi) \in L^{2}(X \times V)^{2}$

$$
\int_{V}(K \phi)(x, v) \psi(x, v) d v=\int_{V} \phi(x, v)(K \psi)(x, v) d v \text { a.e. } x \in X .
$$

Hence we obtain that

$$
\begin{equation*}
\int_{V}(R \phi)(x, v) \psi(x, v) d v=\int_{V} \phi(x, v)(R \psi)(x, v) d v \text { a.e. } x \in X \text {. } \tag{5.18}
\end{equation*}
$$

Now we prove the first statement of the Theorem. We consider the bounded operator

$$
A=K_{\gamma} R \text { for some } \gamma \in C(\bar{X} \times V \times V) \text { satisfying (5.6), }
$$

and the analytic deformation of $R$ given by $R_{\tau}=(R+\tau A)$. Hence

$$
A R+R A^{*}=K_{\gamma} K+K K_{\gamma}=K_{\gamma_{4}}, A A^{*}=K_{\gamma} K K_{\gamma}=K_{\gamma_{5}}
$$

where $\gamma_{4}$ and $\gamma_{5}$ belong to $C(\bar{X} \times V \times V)$, also satisfy (5.6), and are defined by

$$
\begin{gathered}
\gamma_{4}\left(x, v^{\prime}, v\right)=\int_{V}\left(\gamma\left(x, v^{\prime \prime}, v\right) k\left(x, v^{\prime}, v^{\prime \prime}\right)+k\left(x, v^{\prime \prime}, v\right) \gamma\left(x, v^{\prime}, v^{\prime \prime}\right)\right) d v^{\prime \prime} \\
\gamma_{5}\left(x, v^{\prime}, v\right)=\int_{V^{2}} \gamma\left(x, v_{1}, v\right) k\left(x, v_{2}, v_{1}\right) \gamma\left(x, v^{\prime}, v_{2}\right) d v_{1} d v_{2}
\end{gathered}
$$

for $\left(x, v^{\prime}, v\right) \in \bar{X} \times V \times V$. Therefore $R_{\tau} R_{\tau}^{*}$ is the analytic deformation of $K=R^{2}$ given by

$$
R_{\tau} R_{\tau}^{*}=K+\tau\left(A R+R A^{*}\right)+\tau^{2}\left(A A^{*}\right)=K_{k_{\tau}}, k_{\tau}=k+\tau \gamma_{4}+\tau^{2} \gamma_{5} .
$$

By construction the function $k_{\tau}$ belongs to $H$ for any real $\tau$. The operator $T_{\Gamma_{+}}^{-1} K_{k_{\tau}}=T_{\Gamma_{+}}^{-1} R_{\tau} R_{\tau}^{*}$ also defines a $\tau$-analytic deformation of $T_{\Gamma_{+}}^{-1} K$.

We then apply Albert's approach [1] on the analytic deformation $R_{\tau}^{*} T_{\Gamma_{+}}^{-1} R_{\tau}$.
Let $\lambda$ be a nonnegative (isolated) eigenvalue of $T_{\Gamma_{+}}^{-1} K=T_{\Gamma_{+}}^{-1} R^{2}$ with multiplicity $h>1$. Then $\lambda$ is also a nonnegative eigenvalue of $R T_{\Gamma_{+}}^{-1} R$ with multiplicity $h$. By Rellich's Theorem [18, Chapter 2, Section 2], there exist analytic deformations $\lambda_{j}(\tau)$ and $u_{j}(\tau), j=1 \ldots h$, so that $\lambda_{j}(0)=\lambda$ and $\left(u_{j}(\tau)\right)_{j=1 \ldots h}$ is an orthonormal family of eigenvectors of $R_{\tau}^{*} T_{\Gamma_{+}}^{-1} R_{\tau}$, $R_{\tau}^{*} T_{\Gamma_{+}}^{-1} R_{\tau} u_{j}(\tau)=\lambda_{j}(\tau) u_{j}(\tau)$. We expand $R_{\tau}^{*} T_{\Gamma_{+}}^{-1} R_{\tau}$ and use (5.3) to obtain

$$
R_{\tau}^{*} T_{\Gamma_{+}}^{-1} R_{\tau}=R T_{\Gamma_{+}}^{-1} R+\tau\left(R K_{\gamma} T_{\Gamma_{+}}^{-1} R+R T_{\Gamma_{+}}^{-1} K_{\gamma} R\right)+\tau^{2}\left(A^{*} T_{\Gamma_{+}}^{-1} A\right) .
$$

We write $\lambda_{j}(\tau)=\lambda+\tau \alpha_{j}+O\left(\tau^{2}\right)$ and $u_{j}(\tau)=u_{j}+\tau v_{j}+O\left(\tau^{2}\right)$. We obtain

$$
\alpha_{j} u_{j}+\left(\lambda-R T_{\Gamma_{+}}^{-1} R\right) v_{j}-\left(R K_{\gamma} T_{\Gamma_{+}}^{-1} R+R T_{\Gamma_{+}}^{-1} K_{\gamma} R\right) u_{j}=0 .
$$

We note that $\left(\lambda-R T_{\Gamma_{+}}^{-1} R\right) v_{j} \in \operatorname{ker}\left(\lambda-R T_{\Gamma_{+}}^{-1} R\right)^{\perp}$. Hence we obtain

$$
\begin{equation*}
\alpha_{j} \delta_{j, l}=\left\langle\left(K_{\gamma} T_{\Gamma_{+}}^{-1}+T_{\Gamma_{+}}^{-1} K_{\gamma}\right) R u_{j}, R u_{l}\right\rangle=\left\langle K_{\gamma} T_{\Gamma_{+}}^{-1} R u_{j}, R u_{l}\right\rangle+\left\langle K_{\gamma} R u_{j}, T_{\Gamma_{+}}^{-1} R u_{l}\right\rangle . \tag{5.19}
\end{equation*}
$$

We use that $R$ maps $L^{2}(X \times V)$ to $L_{\text {even }}^{2}(X \times V)$ and we use selfadjointness of the operator $P_{\text {even }} T_{\Gamma_{+}}^{-1} P_{\text {even }}$ in the last identity. We finally obtained that

$$
\begin{equation*}
\alpha_{j} \delta_{j, l}=\int_{X \times V^{2}} \gamma\left(\left(P_{\mathrm{even}} T_{\Gamma_{+}}^{-1} R u_{j}\right)\left(x, v^{\prime}\right) R u_{l}(x, v)+R u_{j}\left(x, v^{\prime}\right)\left(P_{\mathrm{even}} T_{\Gamma_{+}}^{-1} R u_{l}\right)(x, v)\right) d x d v d v^{\prime} . \tag{5.20}
\end{equation*}
$$

Above, $\gamma=\gamma\left(x, v^{\prime}, v\right)$. Our goal is to prove that we can choose the function $\gamma$ in the definition of the operator $A$ so that there exists at least a couple of distinct values of $\alpha_{j}$ 's, which proves that for small non zero $\tau, \lambda_{1}(\tau)$ has at most multiplicity $h-1$. This implies the analog of [1, Theorem 2] in our setting. Then the conclusion of the proof of genericity of simple non zero eigenvalues of $T_{\Gamma_{+}}^{-1} K$ follows by reproducing the reasoning in [1].

We now proceed by contradiction and follow [1, Lemma]. Assume that the function $\gamma$ is such that all $\alpha_{j}$ 's have the same value $\alpha$. Then it follows from (5.19) that for any couple ( $\tilde{u}_{1}, \tilde{u}_{2}$ ) of orthonormal real valued eigenvectors of $\operatorname{ker}\left(R T_{\Gamma_{+}}^{-1} R-\lambda\right)$

$$
\begin{equation*}
0=\left\langle\left(K_{\gamma} T_{\Gamma_{+}}^{-1}+T_{\Gamma_{+}}^{-1} K_{\gamma}\right) R \tilde{u}_{1}, R \tilde{u}_{2}\right\rangle=\left\langle K_{\gamma} T_{\Gamma_{+}}^{-1} R \tilde{u}_{1}, R \tilde{u}_{2}\right\rangle+\left\langle K_{\gamma} R \tilde{u}_{1}, T_{\Gamma_{+}}^{-1} R \tilde{u}_{2}\right\rangle . \tag{5.21}
\end{equation*}
$$

Lemma 5.6. Under the assumptions of Theorem 5.5, Ru is continuous on $\bar{X} \times V$ for any $u \in \operatorname{ker}\left(R T_{\Gamma_{+}}^{-1} R-\lambda\right)$.

The proof of Lemma 5.6 is given in Appendix D.
Lemma 5.7. Let $\left(\tilde{u}_{1}, \tilde{u}_{2}\right)$ be two orthonormal real valued eigenvectors of $\operatorname{ker}\left(R T_{\Gamma_{+}}^{-1} R-\lambda\right)$. One of the following statements is satisfied:
i. Identity (5.21) does not hold when

$$
\gamma\left(x, v^{\prime}, v\right)=R \tilde{u}_{1}\left(x, v^{\prime}\right) R \tilde{u}_{2}(x, v)+R \tilde{u}_{1}(x, v) R \tilde{u}_{2}\left(x, v^{\prime}\right),\left(x, v^{\prime}, v\right) \in X \times V \times V
$$

ii. Identity (5.21) does not hold when

$$
\gamma\left(x, v^{\prime}, v\right)=R \tilde{u}_{1}\left(x, v^{\prime}\right) R \tilde{u}_{1}(x, v), \quad\left(x, v^{\prime}, v\right) \in X \times V \times V,
$$

and the couple $\left(\tilde{u}_{1}, \tilde{u}_{2}\right)$ is replaced by the couple $\left(\frac{\tilde{u}_{1}-\tilde{u}_{2}}{\sqrt{2}}, \frac{\tilde{u}_{1}+\tilde{u}_{2}}{\sqrt{2}}\right)$ in (5.21).
The proof of Lemma 5.7 is given in Appendix D.
Remark 5.8. The kernel of $T_{\Gamma_{+}}^{-1} K$ is infinite dimensional with the assumptions of Theorem 5.5. For $k\left(x, v^{\prime}, v\right)=k\left(x, v,-v^{\prime}\right)$ and $u \in L_{\text {odd }}^{2}(X \times V)$, we indeed have $K u=0, T_{\Gamma_{+}}^{-1} K u=0$.

### 5.4 High-dimensional obstruction to controllability.

We now show that in specific, highly symmetric, situations, the kernel of the albedo operator may have an arbitrarily large dimension. For the rest of this section, we consider the case $X=B(0,1)$ the unit Euclidean Ball of dimension $d$ centered at $0, \sigma$ is a constant and the function $k$ is identically equal to 1 .

The operator of interest is $K T_{\Gamma_{+}}^{-1}$ on $L^{2}(X \times V)$. We restrict $K T_{\Gamma_{+}}^{-1}$ to $L_{\text {odd }}^{2}(X)=\{g \in$ $\left.L^{2}(X) \mid g(-)=-g.\right\}$, and we denote by $F$ this restriction. Then

$$
F f(x)=-\int_{X} \frac{e^{\sigma|x-y|}}{|x-y|^{d-1}} f(y), \text { a. e. } x \in X, f \in L_{\text {odd }}^{2}(X) .
$$

The main properties of $F$ are invariance by complex conjugation and by orthogonal transformations of $\mathbb{R}^{d}$. The operator $F$ is a compact self-adjoint operator on $L_{\text {odd }}^{2}(X)$.

Consider the space $H_{l}(V)$ of spherical harmonics of degree $l, l \in \mathbb{N}$. The spherical harmonics of degree $l$ are the traces of harmonic homogeneous polynomials in $\mathbb{R}^{d}$ of degree $l$. We denote by $N_{l}$ the dimension of $H_{l}(V)$ and recall that $N_{l}=\binom{d+l-1}{d-1}-\binom{d+l-3}{d-1}$ for $l \geq 2, N_{1}=d$, $N_{0}=1$ (see [7]). We also denote by $\left(Y_{1, l}, \ldots, Y_{N_{l}, l}\right)$ an orthonormal basis for $H_{l}(V)$ endowed with the $L^{2}$-product on $V$.

Let $l$ be odd and $L_{k, l}$ be the subspace of $L_{\text {odd }}^{2}(X)$ consisting of square summable functions $f$ written in spherical coordinates as

$$
f(r \omega)=g(r) Y_{k, l}(\omega) \text { a.e. }(r, \omega) \in(0,1) \times V,
$$

for some function $g \in L^{2}\left([0,1], r^{d-1} d r\right)$. The space $L_{k, l}$ can be identified to $L^{2}\left([0,1], r^{d-1} d r\right)$.
Lemma 5.9. The operator $F$ leaves stable the subspace $L_{k, l}$. For any $g \in L^{2}\left([0,1], r^{d-1} d r\right)$,

$$
F\left(g Y_{k, l}\right)=F_{l}(g) Y_{k, l},
$$

where $F_{l}$ is a selfadjoint compact (Hilbert-Schmidt) operator in $L^{2}\left([0,1], r^{d-1} d r\right)$.
The proof of the Lemma is given in Appendix D. Note that the orthogonal sum

$$
\oplus_{l \in \mathbb{N}, l \text { odd }, k=1 \ldots N_{l} L_{k, l}, ~}^{\text {and }}
$$

is dense in $L_{\text {odd }}^{2}(X)$. Hence Lemma 5.9 provides a spectral decomposition of the operator $F$ once each $F_{l}$ 's are diagonalized. The eigenvalues of $F$ have a multiplicity greater than or equal to $d$ since $N_{l} \geq d$ for any $l \geq 1$. There does not exist a (uniform) bound on the multiplicity of eigenvalues for the operator $F$.

Lemma 5.10. Let $l \in \mathbb{N}, l$ odd. When the constant $\sigma$ is large enough then the operator $F_{l}$ in $L^{2}\left([0,1], r^{d-1} d r\right)$ has a positive eigenvalue $\mu$ greater than 1 and $\mu$ is also an eigenvalue for the operator $F$ with multiplicity at least $N_{l}$.

The proof of the Lemma is given in Appendix D. We observe that the dimension $N_{l}$ grows to $+\infty$ as $l \rightarrow+\infty$ when the spatial dimension $d$ is greater or equal to 3 . As a corollary of Lemma 5.10, we deduce the existence of kernels of the albedo operator with arbitrary large dimension when $d \geq 3$.

& -\chi_{\mathcal{C}_{+}}\left(x+\tau_{+}(x, v) v, v\right) \int_{\mathbb{S}} \int_{0}^{\tau_{+}(x, v)}{ }_{E}^{E}(x, v, t) \int_{V} k\left(x+t v, v_{-}, v\right) L_{\mathcal{C}} \phi\left(x+t v, v_{-}\right) d v_{-} d t .
\end{aligned}
$$

Hence

$$
\begin{aligned}
& \left|T_{\mathcal{C}}^{-1} K \phi(x, v)\right| \leq\|k\|_{\infty} \chi_{\mathcal{C}_{-}}\left(x-\tau_{-}(x, v) v, v\right) \int_{\mathbb{S}} \int_{0}^{\tau_{-}(x, v)} \int_{V}\left|L_{\mathcal{C}} \phi\right|\left(x-t v, v_{-}\right) d v v_{-} d t \\
& \quad+\|k\|_{\infty} e^{\|\sigma\|_{\infty} \tau_{+}(x, v)} \chi_{\mathcal{C}_{+}}\left(x+\tau_{+}(x, v) v, v\right) \int_{\mathbb{S}} \int_{0}^{\tau_{+}(x, v)} \int_{V}\left|L_{\mathcal{C}} \phi\right|\left(x+t v, v_{-}\right) d v_{-} d t
\end{aligned}
$$

From the definition of $L_{\mathcal{C}}$, we have

$$
\left|L_{\mathcal{C}} \phi\left(y, v_{-}\right)\right| \leq\left\{\begin{array}{l}
|\phi|\left(y-\tau_{-}\left(y, v_{-}\right) v_{-}, v_{-}\right),\left(y-\tau_{-}\left(y, v_{-}\right) v_{-}, v_{-}\right) \in \mathcal{C}_{-} \\
e^{\|\sigma\|_{\infty} \tau_{+}(y, v)}|\phi|\left(y+\tau_{+}\left(y, v_{-}\right) v_{-}, v_{-}\right),\left(y+\tau_{+}\left(y, v_{-}\right) v_{-}, v_{-}\right) \in \mathcal{C}_{+}
\end{array}\right.
$$

for a.e. $\left(y, v_{-}\right) \in X \times V$. Now set

$$
\begin{aligned}
I_{ \pm}^{-}(\phi, x, v) & =\int_{\mathbb{S}} \int_{0}^{\tau_{ \pm}(x, v)} \int_{V}|\phi|\left(x \pm t v-\tau_{-}\left(x \pm t v, v_{-}\right) v_{-}, v_{-}\right) d v_{-} d t \\
I_{ \pm}^{+}(\phi, x, v) & =\int_{\mathbb{S}} \int_{0}^{\tau_{ \pm}(x, v)} \int_{V}|\phi|\left(x \pm t v+\tau_{+}\left(x \pm t v, v_{-}\right) v_{-}, v_{-}\right) d v_{-} d t
\end{aligned}
$$

We obtain

$$
\begin{aligned}
\left|T_{\mathcal{C}}^{-1} K \phi(x, v)\right| \leq & \|k\|_{\infty}\left[\chi _ { \mathcal { C } _ { - } } ( x - \tau _ { - } ( x , v ) v , v ) \left(I_{-}^{-}+e^{\left.\|\sigma\|_{\infty}\left\|\tau_{+}\right\|_{\infty} I_{-}^{+}\right)}\right.\right. \\

\end{aligned}
$$

We omitted the arguments $(\phi, x, v)$ in front of $I_{-}^{ \pm}$and $I_{+}^{ \pm}$for clarity. We first find a bound for $I_{-}^{-}$. The study of $I_{ \pm}^{+}$and $I_{+}^{-}$is similar. We make the change of variables

Here $v^{\perp}$ denotes one unit vector orthogonal to $v$ in the vector plane spanned by $v$ and $v_{-}$. We set

This concludes the proof on boundedness of $T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}$ from $L_{*}(\Gamma)$ to $L^{p}(X \times V)$.

\times \int_{\gamma_{v_{-}, \omega, y}}\left|\nu_{P_{v_{-}, \omega, y}}\left(\gamma_{v_{-}, \omega, y}\right) \cdot v_{-} \| \phi\right|\left(\gamma_{v_{-}, \omega, y}, v_{-}\right) d \gamma_{v_{-}, \omega, y} d \omega d y d v_{-} \\
\leq 2 r_{1} C_{X} C_{p}|V|\left|\mathbb{S}^{d-2}\left\|B_{d-2}\left(0, r_{1}\right) \mid\right\| \phi \|_{L_{*}(\Gamma)}^{p},\right.
\end{array}
$$

which conclude the proof on boundedness of $T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}$ from $L_{*}(\Gamma)$ to $L^{p}(\Gamma \backslash \mathcal{C}, d \xi)$.
Boundedness of $\left[\left(I-T_{\mathcal{C}}^{-1} K\right)^{-1}\left(T_{\mathcal{C}}^{-1} K\right) L_{\mathcal{C}}\right]_{\mid \Gamma \backslash \mathcal{C}}$ under condition (2.17). Under condition (2.17) we write

for any $\phi \in L^{\infty}(\mathcal{C}, d \xi)$. Let us consider dimension $d=2$. The higher dimensional case $d \geq 3$ is handled similarly: replace $L^{1}(\mathcal{C}, d \xi)$ by $L_{*}(\Gamma(X))$.

We have already proved that $T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}$ defined a bounded operator from $L^{1}(\mathcal{C}, d \xi)$ to $L^{p}(\Gamma \backslash \mathcal{C}, d \xi)$. It remains to prove that the second term also defines a bounded operator from $L^{1}(\mathcal{C}, d \xi)$ to $L^{p}(\Gamma \backslash \mathcal{C}, d \xi)$.

We have proved above that $T_{\mathcal{C}}^{-1} K L_{\mathcal{C}}$ defined a bounded operator from $L^{1}(\mathcal{C}, d \xi)$ to $L^{p}(X \times$ $V)$. Then by Lemmas 2.3 and $2.4,\left(T_{\mathcal{C}}^{-1} K\right)^{2} L_{\mathcal{C}}$ defines a bounded operator from $L^{1}(\mathcal{C}, d \xi)$ to $W^{p}(X \times V)$. Hence we obtain that $\left(I-T_{\mathcal{C}}^{-1} K\right)\left(T_{\mathcal{C}}^{-1} K\right)^{2} L_{\mathcal{C}}$ is bounded from $L^{1}(\mathcal{C}, d \xi)$ to $W^{p}(X \times V)$ and Lemma 2.2 concludes the proof.

Boundedness of $\left[L_{\mathcal{C}}\right]_{\mid \Gamma}$ on $L_{*}(\Gamma)$ in dimension $d \geq 3$. Let us recall first a formula for a 2-dimensional $C^{1}$ bounded domain $X$, a velocity space $V$ and a boundary set $\mathcal{C}$ : For $f \in L^{\infty}(\mathcal{C})$

=\int_{V} g(v)\left(\int_{\mathcal{C}_{v}} f(x, v)|\nu(x) \cdot v| d \mu(x)\right) d v,
\end{array}

for any $g \in L^{1}(V)$. Now let us return to dimension $d \geq 3$. Let $\phi \in L^{\infty}(\partial X \times V)$ and let $\left(v_{-}, \omega, y\right) \in \mathcal{M}$ so that $\gamma_{v_{-}, \omega, y}$ is either a circle or the union of 2 circles and $X \cap P_{v_{-}, \omega, y}$ is either a disk or a planar annulus depending on the value of $y$ (either $0 \leq|y|<r_{2}$ or $\left.r_{2}<|y|<r_{1}\right)$. We denote by $\mathbb{S}_{\omega, v_{-}}$the unit sphere in the vector plane spanned by ( $\omega, v_{-}$) and $\Gamma_{v_{-}, \omega, y}=\gamma_{v_{-}, \omega, y} \times \mathbb{S}_{\omega, v_{-}}$. The subsets $C_{ \pm, v_{-}, \omega, y}=\Gamma_{v_{-}, \omega, y} \cap C_{ \pm}$are measurable subsets of $\Gamma_{v_{-}, \omega, y}$ and their union $\mathcal{C}_{v_{-}, \omega, y}=\Gamma_{v_{-}, \omega, y} \cap C$ has a non zero measure for a.e. $\left(v_{-}, \omega, y\right) \in \mathcal{M}$. We also denote by $\phi_{\mid \Gamma_{v_{-}, \omega, y}}$ the measurable bounded function obtained by restricting $\phi$ on $\Gamma_{v_{-}, \omega, y}$ for a.e. $\left(v_{-}, \omega, y\right) \in \mathcal{M}$. In addition $L_{\mathcal{C}_{v_{-}, \omega, y}}\left(\phi_{\mid \Gamma_{v_{-}, \omega, y}}\right)=L_{\mathcal{C}} \phi$ for a.e. $\left(v_{-}, \omega, y\right) \in \mathcal{M}$ where $B_{\mathcal{C}_{v_{-}, \omega, y}}$ denotes any operator " $B_{\mathcal{C}}$ " of Section 2 for " $(X, V, \mathcal{C})=\left(X \cap P_{v_{-}, \omega, y}, \mathbb{S}_{\omega, v_{-}}, \mathcal{C}_{v_{-}, \omega, y}\right)$ ". In addition

\left[L_{\mathcal{C}_{v_{-}, \omega, y}}\right]_{\mid \Gamma_{v_{-}, \omega, y}}\left(\phi_{\mid \Gamma_{v_{-}, \omega, y}}\right)=\left[\left[L_{\mathcal{C}}\right]_{\mid \Gamma}(\phi)\right]_{\mid \Gamma_{v_{-}, \omega, y}} \tag{A.11}
\end{equation*}
$$

for a.e. $\left(v_{-}, \omega, y\right) \in \mathcal{M}$.
Then, the above left-hand side defines a bounded function (see Lemma 2.3 and $\phi \in$ $\left.L^{\infty}(\partial X \times V)\right)$ and we apply (A.10) to obtain

\leq & e^{\|\tau\|_{\infty}\|\sigma\|_{\infty}} \int_{\gamma_{v_{-}, \omega, y}}\left|\left[J_{\mathcal{C}_{v_{-}, \omega, y}}\right]_{\mid \Gamma_{v_{-}, \omega, y} \backslash \mathcal{C}_{v_{-}, \omega, y}}\left(\phi_{\mid \Gamma_{v_{-}, \omega, y}}\right)\right| \nu_{\nu_{v_{-}, \omega, y}}\left(\gamma_{v_{-}, \omega, y}\right) \cdot v_{-} \mid d \gamma_{v_{-}, \omega, y} \\
\leq & e^{\|\tau\|_{\infty}\|\sigma\|_{\infty}} \int_{\gamma_{v_{-}, \omega, y}}\left|\phi_{\mid \mathcal{C}_{v_{-}, \omega, y}}\right| \nu_{\nu_{v_{-}, \omega, y}}\left(\gamma_{v_{-}, \omega, y}\right) \cdot v_{-} \mid d \gamma_{v_{-}, \omega, y},
\end{aligned}

for a.e. $\left(v_{-}, \omega, y\right) \in \mathcal{M}$. Since $\left[L_{\mathcal{C}_{v_{-}, \omega, y}}\right]_{\left.\right|_{\mathcal{C}_{-}, \omega, y}} f=f$ for any $f \in L^{\infty}\left(\mathcal{C}_{v_{-}, \omega, y}\right)$, we finally obtain

\leq & \left(1+e^{\|\tau\|_{\infty}\|\sigma\|_{\infty}}\right) \int_{\gamma_{v_{-}, \omega, y}}|\phi|\left|\nu_{P_{v_{-}, \omega, y}}\left(\gamma_{v_{-}, \omega, y}\right) \cdot v_{-}\right| d \gamma_{v_{-}, \omega, y} .
\end{aligned}

We combine (A.11) and (A.12) to obtain that $\left[L_{\mathcal{C}}\right]_{\mid \Gamma}$ is a bounded operator from $L_{*}(\Gamma)$ to $L_{*}(\Gamma)$ with $e^{\|\tau\|_{\infty}\|\sigma\|_{\infty}}$ as a uniform bound. Here a straightforward computation for $X=$ $B\left(0, r_{1}\right) \backslash B\left(0, r_{2}\right)$ gives $\|\tau\|_{\infty}=2 \sqrt{r_{1}^{2}-r_{2}^{2}}$.

Proof of (A.3) and their higher dimensional counterparts. We prove the first estimate in (A.3). We first assume that $X$ is a disk of center 0 and radius 1. The constant $C_{X}$ behaves linearly with the radius of the disk. By symmetry, we can assume that $x_{-}=\left(-\sqrt{1-q^{2}}, q\right)$ for some $q \in(0,1)$ and $v_{-}=(1,0)$. We introduce the angle $\theta_{q}=\arcsin (q)$. The point $x_{-}$is located at the angle $\pi-\theta_{q}$ and its tangent vector has an angle $\pi / 2-\theta_{q}$. We write $\left.v=(\cos (\theta), \sin (\theta))\right)$, $\theta \in(-\pi, \pi)$. Then for a point $x \in \partial X$

if and only if $x=x_{-}+s v_{-}+t v$ for some positive number $t$ and $0<s<2 \sqrt{1-q^{2}}$. Let $\tilde{x}_{-}=\left(\cos \left(\theta_{q}\right), \sin \left(\theta_{q}\right)\right)$. The lines $x_{-}+\mathbb{R} v_{-}, x_{-}+\mathbb{R} v$ and $\tilde{x}_{-}+\mathbb{R} v$ cross the boundary at the point $\tilde{x}_{-}, x_{-}+2 \cos \left(\theta+\theta_{q}\right) v=\left(\cos \left(\theta_{q}+2 \theta\right), \sin \left(\theta_{q}+2 \theta\right)\right)$ and $\tilde{x}_{-}+2 \cos \left(\theta+\pi-\theta_{q}\right) v=$ $\left(\cos \left(-\pi-\theta_{q}+2 \theta\right), \sin \left(-\pi-\theta_{q}+2 \theta\right)\right)$, respectively. Then $x$ lies at the intersection of the boundary with the sector based at $x_{-}$and directed by $\left(v_{-}, v\right)$ and the sector based at $\tilde{x}_{-}$and directed by $\left(-v_{-}, v\right)$. We denote $A\left(x_{-}, v_{-}, v\right)=\int_{\partial X} \chi_{\partial X_{-, v_{-}, v, x}}\left(x_{-}\right)|\nu(x) \cdot v| d \mu(x)$. Then,

A\left(x_{-}, v_{-}, v\right)=\int_{\left[\theta_{q}, 2 \theta+\theta_{q}\right]}|\cos (\theta-\phi)| d \phi \leq 4 \pi \sin (\theta)=4 \pi\left|v_{-} \cdot v^{\perp}\right| . \tag{A.12}
\end{equation*}
$$

When $\theta \in\left(-\pi / 2-\theta_{q},-\pi / 2+\theta_{q}\right)$, then $v$ is ingoing at $x_{-}$and at $\tilde{x}_{-}$and $x=(\cos (\phi), \sin (\phi))$ for some $\phi$ between the angles $\theta_{q}+2 \theta$ and $\pi-\theta_{q}+2 \theta$. Then $\phi-2 \theta$ is between the angles $\theta_{q}$ and $\pi-\theta_{q}$. Hence $|\cos (\phi-2 \theta)| \leq \cos \left(\theta_{q}\right) \leq|\sin (\theta)|$. Then we obtain that $|\cos (\phi-2 \theta+\theta)| \leq$ $|\cos (\phi-2 \theta)|+|\sin (\theta)|$ and $A\left(x_{-}, v_{-}, v\right)$ is bounded by $4 \pi|\sin (\theta)|$ as above.

When $\theta \in\left(-\pi / 2+\theta_{q}, \pi / 2-\theta_{q}\right)$, then $v$ is ingoing at $x_{-}$and outgoing at $\tilde{x}_{-}$and $x=$ $(\cos (\phi), \sin (\phi))$ for some $\phi$ between the angle $\theta_{q}$ and $2 \theta+\theta_{q}$. In that case $A\left(x_{-}, v_{-}, v\right)$ is trivially bounded by the length $2|\theta|$ which is bounded by $C \sin (\theta)$ for some constant $C$.

When $\theta \in\left(\pi / 2+\theta_{q}, \pi\right)$, then $v$ is outgoing at $x_{-}$and ingoing at $\tilde{x}_{-}$and $x=(\cos (\phi), \sin (\phi))$ for some $\phi$ between the angles $-\pi-\theta_{q}+2 \theta$ and $\pi-\theta_{q}$. Then for $\theta^{\prime}=\theta-\pi$, we have $\theta^{\prime} \in\left(-\pi / 2+\theta_{q}, 0\right)$ and $\phi$ between the angles $\pi-\theta_{q}+2 \theta^{\prime}$ and $\pi-\theta_{q}$. In that case $A\left(x_{-}, v_{-}, v\right)$ is bounded by the length $2\left|\theta^{\prime}\right|$ which is bounded by $C\left|\sin \left(\theta^{\prime}\right)\right|=C \sin (\theta)$ for some constant $C$.

When $\theta \in\left(-\pi,-\pi / 2-\theta_{q}\right)$, then $v$ is outgoing at $x_{-}$and ingoing at $\tilde{x}_{-}$and $x=(\cos (\phi)$, $\sin (\phi))$ for some $\phi$ between the angles $\pi-\theta_{q}+2 \theta$ and $-\pi-\theta_{q}$. Then for $\theta^{\prime}=\theta+\pi$, we have $\theta^{\prime} \in\left(0, \pi / 2-\theta_{q}\right)$ and $\phi$ between the angles $-\pi-\theta_{q}+2 \theta^{\prime}$ and $-\pi-\theta_{q}$. Again $A\left(x_{-}, v_{-}, v\right)$ is bounded by $C|\sin (\theta)|$ for some constant $C$.

Now assume that $X$ is the annulus $B(0,1) \backslash \overline{B(0, r)}$ for some $0<r<1$. (Again $C_{X}$ behaves linearly with the radius of the bigger disk.) Let $A$ be a measurable subset of $\partial B(0, r)$ so that any straight line in direction $v$ has at most one point in $A$. Then for $v \in V$ consider the measurable set $A_{+}=\{x+t v \in \partial B(0,1) \mid x \in A, t>0\}$. One has

Hence for $\left(x_{-}, v_{-}\right) \in \partial X \times V$

where $\tilde{X}$ is the disk $D(0,1)$ and $\tilde{x}_{-} \in \partial B(0,1), \tilde{x}_{-}=x$ if $x \in \partial B(0,1)$ and $x_{-}=\tilde{x}_{-}+s v_{-}$, $\tilde{x} \in$ for some positive $s$ otherwise. This ends the proof of the first estimate in (A.3).

We now prove that the first estimate implies the second one in (A.3) when $X$ is a planar domain. Let $\left(v, v_{-}\right) \in V^{2}$ and $x_{-} \in \partial X$. We perform the change of variables $x=y-t v$, $y \in \partial X, d x=|\nu(y) \cdot v| d t d \mu(y), \nu(y) \cdot v>0$ and we obtain the formula

The higher dimensional counterpart (A.7) also follows from a straightforward use of the first estimate (A.3) on the planar domain $X \cap P_{v_{-}, \omega, y}$ which is either an annulus with " $\left(r_{1}^{2}, r_{2}^{2}\right)$ " $=$ $\left(r_{1}^{2}-|y|^{2}, r_{2}^{2}-|y|^{2}\right), 0 \leq|y|<r_{2}$, or a disk of center 0 and radius the square root of $r_{1}^{2}-|y|^{2}$. We use notation introduced before (A.7).

The higher dimensional counterpart (A.9) is also derived by (A.3) applied on the planar domain $X \cap P_{v_{-}, \omega, y}$. Indeed consider a boundary point $x \in \gamma_{v_{-}, \omega, y}$ and a unit vector $v$ lying on the plane $P_{v_{-}, \omega, y}$. We denote by $\nu_{P_{v_{-}, \omega, y}}(x)^{\perp}$ a unit vector lying on the plane $P_{v_{-}, \omega, y}$ and orthogonal to the normal vector $\nu_{P_{v_{-}, \omega, y}}(x)$. The vector $\nu_{P_{v_{-}, \omega, y}}(x)^{\perp}$ is tangent to the boundary $\gamma_{v_{-}, \omega, y}$. Hence it is also a tangent vector to the d-dimensional domain $X$. Therefore $\nu(x)$ is orthogonal to $\nu_{P_{v_{-}, \omega, y}}(x)^{\perp}$. Then $v=\alpha_{1} \nu_{P_{v_{-}, \omega, y}}(x)+\alpha_{2} \nu_{P_{v_{-}, \omega, y}}(x)^{\perp}$ for some real numbers $\alpha_{i}, i=1,2$, and obviously

This proves the estimate $|\nu(x) \cdot v(\theta, \omega)| \leq\left|\nu_{P_{v_{-}, \omega, y}}(x) \cdot v(\theta, \omega)\right|$ when $x=x\left(r_{i}, y, \theta^{\prime}\right)$, and we have reduced the proof of (A.9) to (A.3).

F_{l} g(s)=\int_{0}^{1} g(r) f_{l}(s, r) r^{d-1} d r \tag{D.10}
\end{equation*}
$$

is a selfadjoint compact (in fact Hilbert-Schmidt) operator in $L^{2}\left([0,1], r^{d-1} d r\right)$.
For these last statements we used the following estimates

$$
\begin{align*}
r^{d-1}\left|f_{l}(s, r)\right| & \leq C_{l} \int_{0}^{\pi} \frac{r^{d-1} \sin \left(\theta_{1}\right)^{d-2}}{\left(s^{2}+r^{2}-2 r s \cos \left(\theta_{1}\right)\right)^{\frac{d-1}{2}}} d \theta_{1} \\
& =C_{l} \int_{0}^{\pi} \frac{r^{d-1} \sin \left(\theta_{1}\right)^{d-2}}{\left.\left(r^{2} \sin \left(\theta_{1}\right)^{2}+\left(s-r \cos \left(\theta_{1}\right)\right)^{2}\right)^{\frac{d-2}{2}} \sqrt{\left(s^{2}+r^{2}-2 r s \cos \left(\theta_{1}\right)\right.}\right)} d \theta_{1} \\
& \leq C_{l} \int_{0}^{\pi} \frac{r}{\left.\sqrt{\left(s^{2}+r^{2}-2 r s \cos \left(\theta_{1}\right)\right.}\right)} d \theta_{1} \leq C_{l}^{\prime}\left(\ln \left(\frac{1}{r-s}\right)+1\right), \tag{D.11}
\end{align*}
$$

for any $(s, r) \in[0,1]^{2}, s<r$, and for some constants $C_{l}$ and $C_{l}^{\prime}$.

## D. 4 Proof of Lemma 5.10

Let us first consider the Gegenbauer polynomials introduced above in (D.8). We recall the property [15, Chapter V, 5.2.1 and 5.1.3]: $G_{l}^{\frac{d-2}{2}}(-x)=(-1)^{l} G_{l}^{\frac{d-2}{2}}(x)$. Hence $l$ being odd we actually have $G_{l}^{\frac{d-2}{2}}(-1)=-G_{l}^{\frac{d-2}{2}}(1)=-1$. Therefore there exist positive numbers $\varepsilon$ and $\eta$, $\eta<1 / 2$ so that

$$
-\left|\mathbb{S}^{d-2}\right| G_{l}^{\frac{d-2}{2}}(t) \geq \varepsilon
$$

for $t \in(-1,-1+\eta)$. Now let $(s, r) \in[\eta, 1]^{2}, s \neq r$. Then the above estimate gives

$$
-\left|\mathbb{S}^{d-2}\right| \int_{-1}^{-1+\eta} \frac{\left(1-t^{2}\right)^{\frac{d-3}{2}} G_{l}^{\frac{d-2}{2}}(t) e^{\sigma \sqrt{s^{2}+r^{2}-2 r s t}}}{\left(s^{2}+r^{2}-2 r s t\right)^{\frac{d-1}{2}}} d t \geq \varepsilon \int_{-1}^{-1+\eta} \frac{\left(1-t^{2}\right)^{\frac{d-3}{2}} e^{\sigma \sqrt{s^{2}+r^{2}-2 r s t}}}{\left(s^{2}+r^{2}\right)^{\frac{d-1}{2}}} d t .
$$

The integrand on the right hand side is non-negative and the integral over $(-1,-1+\eta)$ is bounded below by the integral of the same integrand over the smallest interval ( $-1+\eta / 2,-1+$ $\eta)$. In addition using monotonicity in $t$ of the denominator and of the exponential we easily obtain

$$
\begin{equation*}
-\left|\mathbb{S}^{d-2}\right| \int_{-1+\eta / 2}^{-1+\eta} \frac{\left(1-t^{2}\right)^{\frac{d-3}{2}} G_{l}^{\frac{d-2}{2}}(t) e^{\sigma \sqrt{s^{2}+r^{2}-2 r s t}}}{\left(s^{2}+r^{2}\right)^{\frac{d-1}{2}}} d t \geq c(\varepsilon, \eta) e^{\sigma \sqrt{(s+r)^{2}-2 \eta s r}} \tag{D.12}
\end{equation*}
$$

where $c(\varepsilon, \eta)$ is the positive constant $\varepsilon \eta\left(\eta-\eta^{2} / 4\right)^{\frac{d-3}{2}} /\left(2^{\frac{d+1}{2}} \eta^{d-1}\right)$. We also have the following bound

$$
\begin{array}{r}
-\left|\mathbb{S}^{d-2}\right| \int_{-1+\eta}^{1} \frac{\left(1-t^{2}\right)^{\frac{d-3}{2}} G_{l}^{\frac{d-2}{2}}(t) e^{\sigma \sqrt{s^{2}+r^{2}-2 r s t}}}{\left(s^{2}+r^{2}-2 r s t\right)^{\frac{d-1}{2}}} d t \\
\geq-C_{l}\left(2 \eta^{2}\right)^{\frac{1-d}{2}} \int_{-1+\eta}^{0} e^{\sigma \sqrt{s^{2}+r^{2}-2 r s t}} d t-C_{l} e^{\sigma \sqrt{s^{2}+r^{2}}} \int_{0}^{1} \frac{\left(1-t^{2}\right)^{\frac{d-3}{2}} d t}{\left(s^{2}+r^{2}-2 r s t\right)^{\frac{d-1}{2}}} \tag{D.13}
\end{array}
$$

for some positive constant $C_{l}$ that depends only on $l$. We combine (D.8), (D.12) and (D.13) and obtain

$$
\begin{align*}
& f_{l}(s, r) \geq c(\varepsilon, \eta) e^{\sigma \sqrt{(s+r)^{2}-2 \eta s r}} \\
& \times\left[1-\frac{C_{l}}{c(\varepsilon, \eta)}\left(2 \eta^{2}\right)^{\frac{1-d}{2}} \int_{-1+\eta}^{0} e^{\sigma\left(\sqrt{s^{2}+r^{2}-2 r s t}-\sqrt{\left.(s+r)^{2}-2 \eta s r\right)}\right.} d t\right.  \tag{D.14}\\
& \left.-\frac{C_{l}}{c(\varepsilon, \eta)} e^{\sigma\left(\sqrt{s^{2}+r^{2}}-\sqrt{\left.(s+r)^{2}-2 \eta s r\right)}\right.} \int_{0}^{1} \frac{\left(1-t^{2}\right)^{\frac{d-3}{2}} d t}{\left(s^{2}+r^{2}-2 r s t\right)^{\frac{d-1}{2}}}\right] .
\end{align*}
$$

We note that the second term inside the brackets of the right hand side goes to 0 uniformly in $(s, r) \in[\eta, 1]^{2}$ as $\sigma \rightarrow+\infty$. Indeed we use the identity " $a-b=\left(a^{2}-b^{2}\right) /(a+b)$ " and obtain that

$$
\int_{-1+\eta}^{0} e^{\sigma\left(\sqrt{s^{2}+r^{2}-2 r s t}-\sqrt{\left.(s+r)^{2}-2 \eta s r\right)}\right.} d t \leq \int_{0}^{1-\eta} e^{\frac{-\sigma \eta^{2} t}{2}} d t
$$

Hence there exists $\sigma_{0}(l, \eta)$ so that for any $\sigma \geq \sigma_{0}(l, \eta)$ the second term is bounded by $\frac{c(\varepsilon, \eta)\left(2 \eta^{2}\right)^{\frac{d-1}{2}}}{2 C_{l}}$, and we obtain

$$
\begin{equation*}
f_{l}(s, r) \geq c(\varepsilon, \eta)\left[\frac{e^{\sigma \sqrt{(s+r)^{2}-2 \eta s r}}}{2}-\frac{C_{l}}{c(\varepsilon, \eta)} e^{\sigma\left(\sqrt{s^{2}+r^{2}}\right)} \int_{0}^{1} \frac{\left(1-t^{2}\right)^{\frac{d-3}{2}} d t}{\left(s^{2}+r^{2}-2 r s t\right)^{\frac{d-1}{2}}}\right] \tag{D.15}
\end{equation*}
$$

when $\sigma \geq \sigma_{0}(l, \eta)$.
Now pick any point $r_{0} \in(\eta, 1)$. There exist $\delta \in\left(0, \min \left(r_{0}-\eta, 1-r_{0}\right)\right)$ and $\varepsilon_{1}>0$ so that

$$
\begin{equation*}
\inf _{(r, s) \in\left[r_{0}-\delta, r_{0}+\delta\right]^{2}} \sqrt{(s+r)^{2}-2 \eta s r} \geq \varepsilon_{1}+\sup _{(r, s) \in\left[r_{0}-\delta, r_{0}+\delta\right]^{2}} \sqrt{s^{2}+r^{2}} . \tag{D.16}
\end{equation*}
$$

We denote $\varepsilon_{2}$ the positive number $\sup _{(r, s) \in\left[r_{0}-\delta, r_{0}+\delta\right]^{2}} \sqrt{s^{2}+r^{2}}$.
Let $g$ be any continuous and non-negative function on $[0,1]$ normalized by the condition $\|g\|_{L^{2}\left([0,1], r^{d-1} d r\right)}=1$ so that $g$ is compactly supported inside $\left[r_{0}-\delta, r_{0}+\delta\right]$. We combine (D.10), (D.15), (D.16) and we obtain for any $\sigma \geq \sigma_{0}(l, \eta)$

$$
\begin{aligned}
& \left\langle F_{l} g, g\right\rangle_{L^{2}\left([0,1], r^{d-1} d r\right)}=\int_{[0,1]^{2}} g(r) g(s) f_{l}(s, r)(r s)^{d-1} d r d s \\
\geq & c(\varepsilon, \eta) e^{\sigma\left(\varepsilon_{1}+\varepsilon_{2}\right)} \int_{[0,1]^{2}} g(r) g(s)(r s)^{d-1}\left[\frac{1}{2}-\frac{C_{l} e^{-\sigma \varepsilon_{1}}}{c(\varepsilon, \eta)} \int_{0}^{1} \frac{\left(1-t^{2}\right)^{\frac{d-3}{2}} d t}{\left(s^{2}+r^{2}-2 r s t\right)^{\frac{d-1}{2}}}\right] d r d s .
\end{aligned}
$$

The integrand in $r, s, t$ inside the integral in $t$ is integrable in $L^{1}\left([0,1]^{2} \times[-1,1],(r s)^{d-1} d r d s d t\right)$, see (D.11). Hence we obtain that there exists a constant $\sigma(l, g)$ so that for any $\sigma \geq \sigma(l, g)$

$$
\left\langle F_{l} g, g\right\rangle_{L^{2}\left([0,1], r^{d-1} d r\right)} \geq \frac{c(\varepsilon, \eta)}{2} e^{\sigma \varepsilon_{1} / 2}\left(\int_{0}^{1} g(r) r^{d-1} d r\right)^{2} .
$$

Obviously there exists a constant $\sigma_{1}(l, g) \geq \sigma(l, g)$ so that for any $\sigma \geq \sigma_{1}(l, g)$

$$
\left\langle F_{l} g, g\right\rangle_{L^{2}\left([0,1], r^{d-1} d r\right)} \geq 2,
$$

which proves that the selfadjoint compact operator $F_{l}$ has a positive eigenvalue greater or equal to 2 .
