# Congruences modulo powers of 5 for the rank parity function

# Dandan Chen, Rong Chen and Frank Garvan

Abstract. It is well known that Ramanujan conjectured congruences modulo powers of 5, 7 and 11 for the partition function. These were subsequently proved by Watson (1938) and Atkin (1967). In 2009 Choi, Kang, and Lovejoy proved congruences modulo powers of 5 for the crank parity function. The generating function for the rank parity function is  $f(q)$ , which is the first example of a mock theta function that Ramanujan mentioned in his last letter to Hardy. We prove congruences modulo powers of 5 for the rank parity function.

# 1. Introduction

Let  $p(n)$  be the number of unrestricted partitions of n. Ramanujan discovered and later proved that

 $p(5n + 4) \equiv 0 \pmod{5},$  (1.1)

$$
p(7n+5) \equiv 0 \pmod{7},\tag{1.2}
$$

$$
p(11n + 6) \equiv 0 \pmod{11}.
$$
 (1.3)

In 1944 Dyson [Dy44] defined the *rank* of a partition as the largest part minus the number of parts and conjectured that the residue of the rank mod 5 (resp. mod 7) divides the partitions of  $5n+4$  (resp.  $7n+5$ ) into 5 (resp. 7) equal classes thus giving combinatorial explanations of Ramanujan's partition congruences mod 5 (resp. 7). Dyson's rank conjectures were proved by Atkin and Swinnerton-Dyer [AS-D54]. Dyson also conjectured the existence of another statistic, he called the crank, which would likewise explain Ramanujan's partition congruence mod 11. The crank was found by Andrews and the third author [AnGa88] who defined the crank as the largest part, if the partition has no ones, and otherwise as the difference between the number of parts larger than the number of ones and the number of ones.

Let  $M_e(n)$  (resp.  $M_o(n)$ ) denote the number of partitions of n with even (resp. odd) crank. Choi, Kang and Lovejoy [CKL09] proved congruences modulo powers of 5 for the difference, which we call the crank parity function.

## Theorem 1.1. (Choi, Kang and Lovejoy [CKL09, Theorem 1.1]) For all  $\alpha \geq 0$  we have

$$
M_e(n) - M_o(n) \equiv 0 \pmod{5^{\alpha+1}}, \qquad \text{if } 24n \equiv 1 \pmod{5^{2\alpha+1}}.
$$

This gives a weak refinement of Ramanujan's partition congruence modulo powers of 5:

 $p(n) \equiv 0 \pmod{5^{\alpha}}$ , if  $24n \equiv 1 \pmod{5^{\alpha}}$ .

This was proved by Watson [Wa38].

In this paper we prove an analogue of Theorem 1.1 for the rank parity function. Analogous to  $M_e(n)$  and  $M_o(n)$ , we let  $N_e(n)$  (resp.  $N_o(n)$ ) denote the number of partitions of n with even (resp. odd) rank. It is well known that the difference is related to Ramanujan's mock theta function  $f(q)$ . This is the first example of a mock theta function that Ramanujan gave in his last letter to Hardy. Let

$$
f(q) = \sum_{n=0}^{\infty} a_f(n)q^n = 1 + \sum_{n=1}^{\infty} \frac{q^{n^2}}{(1+q)^2(1+q^2)^2 \cdots (1+q^n)^2}
$$
  
= 1 + q - 2q<sup>2</sup> + 3q<sup>3</sup> - 3q<sup>4</sup> + 3q<sup>5</sup> - 5q<sup>6</sup> + 7q<sup>7</sup> - 6q<sup>8</sup> + 6q<sup>9</sup> - 10q<sup>10</sup> + 12q<sup>11</sup> - 11q<sup>12</sup> + ...

This function has been studied by many authors. Ramanujan conjectured an asymptotic formula for the coefficients  $a_f(n)$ . Dragonette [Dr52] improved this result by finding a Rademacher-type asymptotic expansion for the coefficients. The error term was subsequently improved by Andrews [An66], Bringmann and Ono [BrOn06], and Ahlgren and Dunn [AhDu19]. We have

$$
a_f(n) = N_e(n) - N_o(n),
$$

for  $n > 0$ .

Our main theorem is

**Theorem 1.2.** For all  $\alpha \geq 3$  and all  $n \geq 0$  we have

$$
a_f(5^{\alpha}n + \delta_{\alpha}) + a_f(5^{\alpha - 2}n + \delta_{\alpha - 2}) \equiv 0 \pmod{5^{\left\lfloor \frac{1}{2} \alpha \right\rfloor}},\tag{1.4}
$$

where  $\delta_{\alpha}$  satisfies  $0 < \delta_{\alpha} < 5^{\alpha}$  and  $24\delta_{\alpha} \equiv 1 \pmod{5^{\alpha}}$ .

Since this paper was first written, we have found that Karl-Heinz Fricke [Fr13, p.9] independently observed (1.4) but without proof. Fricke [Fr13, p.232] also independently observed analogous congruences modulo powers of 7 and analogous congruences for Ramanujan's third order mock theta function

$$
\omega(q) = \sum_{n=0}^{\infty} \frac{q^{2n(n+1)}}{(1+q)^2(1+q^3)^2 \cdots (1+q^{2n+1})^2}.
$$

In a subsequent paper  $[CCG21]$  we will extend our methods to prove these other congruences.

Below in Section 3.A. we show that the generating function for

$$
a_f(5n-1) + a_f(n/5)
$$

is a linear combination of two eta-products. See Theorem 3.1. This enables us to use the theory of modular functions to obtain congruences. Our presentations and methods are similar to those of Paule and Radu [PaRa12], who solved a difficult conjecture of Sellers [Se94] for congruences modulo powers of 5 for Andrews's two-colored generalized Frobenius partitions [An84]. In Section 2. we include the necessary background and algorithms from the theory of modular functions for proving identities. In Section 3. we apply the theory of modular functions to prove our main theorem. In Section 4. we conclude the paper by discussing congruences modulo powers of 7 for both the rank and crank parity functions.

#### Some Remarks and Notation

Throughout this paper we use the standard  $q$ -notation. For finite products we use

$$
(z;q)_n = (z)_n = \begin{cases} \prod_{j=0}^{n-1} (1 - zq^j), & n > 0 \\ 1, & n = 0. \end{cases}
$$

For infinite products we use

$$
(z;q)_{\infty} = (z)_{\infty} = \lim_{n \to \infty} (z;q)_n = \prod_{n=1}^{\infty} (1 - zq^{(n-1)}),
$$
  

$$
(z_1, z_2, \dots, z_k; q)_{\infty} = (z_1; q)_{\infty} (z_2; q)_{\infty} \cdots (z_k; q)_{\infty},
$$
  

$$
[z;q]_{\infty} = (z;q)_{\infty} (z^{-1}q;q)_{\infty} = \prod_{n=1}^{\infty} (1 - zq^{(n-1)})(1 - z^{-1}q^n),
$$
  

$$
[z_1, z_2, \dots, z_k; q]_{\infty} = [z_1; q]_{\infty} [z_2; q]_{\infty} \cdots [z_k; q]_{\infty},
$$

for  $|q| < 1$  and  $z, z_1, z_2, \ldots, z_k \neq 0$ . For  $\theta$ -products we use

$$
J_{a,b} = (q^a, q^{b-a}, q^b; q^b)_{\infty}
$$
, and  $J_b = (q^b; q^b)_{\infty}$ ,

and the Dedekind eta-function is given by

$$
\eta(\tau) = \exp(\pi i \tau / 12) \prod_{n=1}^{\infty} (1 - \exp(2\pi i n \tau)) = q^{1/24} \prod_{n=1}^{\infty} (1 - q^n), \tag{1.5}
$$

where  $\text{Im}(\tau) > 0$ .

Throughout this paper we let |x| denote the largest integer less than or equal to x, and let [x] denote the smallest integer greater than or equal to x.

We need some notation for formal Laurent series. See the remarks at the end of [PaRa12, Section] 1, p.823. Let R be a ring and q be an indeterminant. We let  $R((q))$  denote the formal Laurent series in  $q$  with coefficients in  $R$ . These are series of the form

$$
f = \sum_{n \in \mathbb{Z}} a_n q^n,
$$

where  $a_n \neq 0$  for at most finitely many  $n < 0$ . For  $f \neq 0$  we define the order of f (with respect to q) as the smallest integer N such that  $a_N \neq 0$  and we write  $N = \text{ord}_q(f)$ . We note that if f is a modular function this coincides with  $\text{ord}(f, \infty)$ . See equation (2.6) below for this other notation. Suppose t and  $f \in R((q))$  and the composition  $f \circ t$  is well-defined as a formal Laurent series. This is the case if  $\text{ord}_q(t) > 0$ . The *t*-order of

$$
F = f \circ t = \sum_{n \in \mathbb{Z}} a_n t^n,
$$

where  $t = \sum_{n \in \mathbb{Z}} b_n q^n$ , is defined to be the smallest integer N such that  $a_N \neq 0$  and we write  $N = \text{ord}_t(F)$ . For example, if

$$
f = q^{-1} + 1 + 2q + \cdots
$$
,  $t = q^2 + 3q^3 + 5q^4 + \cdots$ ,

then

$$
F = f \circ t = t^{-1} + 1 + 2t + \dots = q^{-2} - 3q^{-1} + 5 + \dots,
$$

so that  $\operatorname{ord}_q(f) = -1$ ,  $\operatorname{ord}_q(t) = 2$ ,  $\operatorname{ord}_t(F) = -1$  and  $\operatorname{ord}_q(F) = -2$ .

# 2. Modular Functions

In this section we present the needed theory of modular functions which we use to prove identities. A general reference is Rankin's book [Ra77].

# 2.A. Background theory

Our presentation is based on [Be91, pp.326-329]. Let  $\mathcal{H} = {\tau : \text{Im}(\tau) > 0}$  (the complex upper halfplane). For each  $M = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in M_2^+(\mathbb{Z})$ , the set of integer  $2 \times 2$  matrices with positive determinant, the bilinear transformation  $M(\tau)$  is defined by

$$
M\tau = M(\tau) = \frac{a\tau + b}{c\tau + d}.
$$

The slash operator is defined by

$$
(f \mid M) (\tau) = f(M\tau),
$$

and satisfies

$$
f \mid MS = f \mid M \mid S,
$$

for matrices M and S. The modular group  $\Gamma(1)$  is defined by

$$
\Gamma(1) = \left\{ \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in M_2^+(\mathbb{Z}) \, : \, ad - bc = 1 \right\}.
$$

We consider the following subgroups  $\Gamma$  of the modular group with finite index

$$
\Gamma_0(N) = \left\{ \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \Gamma(1) : c \equiv 0 \pmod{N} \right\},\
$$

$$
\Gamma_1(N) = \left\{ \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \Gamma(1) : \begin{pmatrix} a & b \\ c & d \end{pmatrix} \equiv \begin{pmatrix} 1 & * \\ 0 & 1 \end{pmatrix} \pmod{N} \right\}.
$$

Such a group  $\Gamma$  acts on  $\mathscr{H}\cup\mathbb{Q}\cup\infty$  by the transformation  $V(\tau)$ , for  $V\in\Gamma$  which induces an equivalence relation. We call a set  $\mathscr{F} \subseteq \mathscr{H} \cup \mathbb{Q} \cup {\infty}$  a fundamental set for Γ if it contains one element of each equivalence class. The finite set  $\mathcal{F} \cap (\mathbb{Q} \cup {\infty})$  is called the *complete set of inequivalent cusps*.

A function  $f : \mathcal{H} \longrightarrow \mathbb{C}$  is a *modular function* on  $\Gamma$  if the following conditions hold:

- (i) f is holomorphic on  $\mathscr{H}$ .
- (ii)  $f | V = f$  for all  $V \in \Gamma$ .
- (iii) For every  $A \in \Gamma(1)$  the function  $f \mid A^{-1}$  has an expansion

$$
(f | A^{-1})(\tau) = \sum_{m=m_0}^{\infty} b(m) \exp(2\pi i \tau m/\kappa)
$$

on some half-plane  $\{\tau : \text{Im }\tau > h \ge 0\}$ , where  $T = \begin{pmatrix} 1 & 1 \\ 0 & 1 \end{pmatrix}$  and

$$
\kappa = \min\left\{k > 0 \,:\, \pm A^{-1}T^k A \in \Gamma\right\}.
$$

The positive integer  $\kappa = \kappa(\Gamma;\zeta)$  is called the fan width of  $\Gamma$  at the cusp  $\zeta = A^{-1}\infty$ . If  $b(m_0) \neq 0$ , then we write

$$
\mathrm{Ord}(f,\zeta,\Gamma)=m_0
$$

which is called the *order* of f at  $\zeta$  with respect to Γ. We also write

$$
\operatorname{ord}(f;\zeta) = \frac{m_0}{\kappa} = \frac{m_0}{\kappa(\Gamma,\zeta)},\tag{2.6}
$$

which is called the *invariant order* of f at  $\zeta$ . For each  $z \in \mathcal{H}$ , ord $(f; z)$  denotes the order of f at z as an analytic function of z, and the order of f with respect to  $\Gamma$  is defined by

$$
\mathrm{Ord}(f,z,\Gamma)=\frac{1}{\ell}\,\mathrm{ord}(f;z)
$$

where  $\ell$  is the order of z as a fixed point of Γ. We note  $\ell = 1, 2$  or 3. Our main tool for proving modular function identities is the valence formula [Ra77, Theorem 4.1.4, p.98]: If  $f \neq 0$  is a modular function on  $\Gamma$  and  $\mathscr F$  is any fundamental set for  $\Gamma$  then

$$
\sum_{z \in \mathcal{F}} \text{Ord}(f, z, \Gamma) = 0. \tag{2.7}
$$

## 2.B. Eta-product identities

We will consider eta-products of the form

$$
f(\tau) = \prod_{d|N} \eta(d\tau)^{m_d},\tag{2.8}
$$

where N is a positive integer, each  $d > 0$  and  $m_d \in \mathbb{Z}$ .

#### Modularity

Newman [Ne59] has found necessary and sufficient conditions under which an eta-product is a modular function on  $\Gamma_0(N)$ .

**Theorem 2.1.** ([Ne59, Theorem 4.7]) The function  $f(\tau)$  (given in (2.8)) is a modular function on  $\Gamma_0(N)$  if and only if

1. 
$$
\sum_{d|N} m_d = 0,
$$
  
\n2. 
$$
\sum_{d|N} dm_d \equiv 0 \pmod{24},
$$
  
\n3. 
$$
\sum_{d|N} \frac{Nm_d}{d} \equiv 0 \pmod{24}, \text{ and}
$$
  
\n4. 
$$
\prod_{d|N} d^{|m_d|} \text{ is a square.}
$$

# Orders at cusps

Ligozat [Li75] has computed the invariant order of an eta-product at the cusps of  $\Gamma_0(N)$ .

**Theorem 2.2.** ([Li75, Theorem 4.8]) If the eta-product  $f(\tau)$  (given in (2.8)) is a modular function on  $\Gamma_0(N)$ , then its order at the cusp  $\zeta = \frac{b}{c}$  $\frac{b}{c}$  (assuming  $(b, c) = 1$ ) is

$$
\operatorname{ord}(f(\tau);\zeta) = \sum_{d|N} \frac{(d,c)^2 m_d}{24d}.\tag{2.9}
$$

Chua and Lang [ChLa04] have found a set of inequivalent cusps for  $\Gamma_0(N)$ .

**Theorem 2.3.** ([ChLa04, p.354]) Let N be a positive integer and for each positive divisor d of N let  $e_d = (d, N/d)$ . Then the set

$$
\Delta = \bigcup_{d|N} S_d
$$

is a complete set of inequivalent cusps of  $\Gamma_0(N)$  where

$$
S_d = \{x_i/d : (x_i, d) = 1, \quad 0 \le x_i \le d - 1, \quad x_i \not\equiv x_j \pmod{e_d}\}.
$$

Biagioli [Bi89] has found the fan width of the cusps of  $\Gamma_0(N)$ .

**Lemma 2.4.** ([Bi89, Lemma 4.2]) If  $(r, s) = 1$ , then the fan width of  $\Gamma_0(N)$  at  $\frac{r}{s}$  is

$$
\kappa\left(\Gamma_0(N); \frac{r}{s}\right) = \frac{N}{(N, s^2)}.
$$

## An application of the valence formula

Since eta-products have no zeros or poles in  $\mathcal{H}$ , the following result follows easily from the valence formula  $(2.7)$ .

**Theorem 2.5.** Let  $f_1(\tau)$ ,  $f_2(\tau)$ , ...,  $f_n(\tau)$  be eta-products that are modular functions on  $\Gamma_0(N)$ . Let  $\mathcal{S}_N$  be a set of inequivalent cusps for  $\Gamma_0(N)$ . Define the constant

$$
B = \sum_{\substack{\zeta \in \mathcal{S}_N \\ \zeta \neq \infty}} min(\{Ord(f_j, \zeta, \Gamma_0(N)) : 1 \le j \le n\}),\tag{2.10}
$$

and consider

$$
g(\tau) := \alpha_1 f_1(\tau) + \alpha_2 f_2(\tau) + \dots + \alpha_n f_n(\tau), \qquad (2.11)
$$

where each  $\alpha_j \in \mathbb{C}$ . Then

 $g(\tau) \equiv 0$ 

if and only if

$$
Ord(g(\tau), \infty, \Gamma_0(N)) > -B.
$$
\n(2.12)

An algorithm for proving eta-product identities.

STEP 0. Write the identity in the following form:

$$
\alpha_1 f_1(\tau) + \alpha_2 f_2(\tau) + \dots + \alpha_n f_n(\tau) = 0,\tag{2.13}
$$

where each  $\alpha_i \in \mathbb{C}$  and each  $f_i(\tau)$  is an eta-product of level N.

STEP 1. Use Theorem 2.1 to check that  $f_j(\tau)$  is a modular function on  $\Gamma_0(N)$  for each  $1 \leq j \leq n$ .

STEP 2. Use Theorem 2.3 to find a set  $S_N$  of inequivalent cusps for  $\Gamma_0(N)$  and the fan width of each cusp.

STEP 3. Use Theorem 2.2 to calculate the order of each eta-product  $f_j(\tau)$  at each cusp of  $\Gamma_0(N)$ .

STEP 4. Calculate

$$
B = \sum_{\substack{\zeta \in \mathcal{S}_N \\ \zeta \neq \infty}} \min(\{\text{Ord}(f_j, \zeta, \Gamma_0(N)) : 1 \leq j \leq n\}).
$$

STEP 5. Show that

$$
Ord(g(\tau),\infty,\Gamma_0(N))>-B
$$

where

$$
g(\tau) = \alpha_1 f_1(\tau) + \alpha_2 f_2(\tau) + \cdots + \alpha_n f_n(\tau).
$$

Theorem 2.5 then implies that  $g(\tau) \equiv 0$  and hence the eta-product identity (2.13).

The third author has written a MAPLE package called ETA which implements this algorithm. See

#### A modular equation

Define

$$
t := t(\tau) := \frac{\eta(\tau)^2 \eta(10\tau)^4}{\eta(2\tau)^4 \eta(5\tau)^2}
$$
  
=  $q - 2q^2 + 3q^3 - 6q^4 + 11q^5 - 16q^6 + 24q^7 - 38q^8 + 57q^9 - 82q^{10} + 117q^{11} + \cdots$  (2.14)

We note that  $t(\tau)$  is a Hauptmodul for  $\Gamma_0(10)$  [Ma09]. As an application of our algorithm we prove the following theorem which will be needed later.

# Theorem 2.6. Let

$$
\sigma_0(\tau) = -t,\tag{2.15}
$$

$$
\sigma_1(\tau) = -5t^2 + 2 \cdot 5t,\tag{2.16}
$$

$$
\sigma_2(\tau) = -5^2 t^3 + 2 \cdot 5^2 t^2 - 7 \cdot 5t,\tag{2.17}
$$

$$
\sigma_3(\tau) = -5^3 t^4 + 2 \cdot 5^3 t^3 - 7 \cdot 5^2 t^2 + 12 \cdot 5t,\tag{2.18}
$$

$$
\sigma_4(\tau) = -5^4 t^5 + 2 \cdot 5^4 t^4 - 7 \cdot 5^3 t^3 + 12 \cdot 5^2 t^2 - 11 \cdot 5t,\tag{2.19}
$$

where  $t = t(\tau)$  is defined in  $(2.14)$ . Then

$$
t(\tau)^5 + \sum_{j=0}^4 \sigma_j(5\tau) t(\tau)^j = 0.
$$
 (2.20)

*Proof.* From Theorem 2.1 we find that  $t(\tau)$  is a modular function on  $\Gamma_0(10)$  and  $t(5\tau)$  is a modular function on  $\Gamma_0(50)$ . Hence each term on the left side of  $(2.20)$  is a modular function on  $\Gamma_0(50)$ . For convenience we divide by  $t(\tau)^5$  and let

$$
g(\tau) = 1 + \sum_{j=0}^{4} \sigma_j(5\tau) t(\tau)^{j-5}.
$$
 (2.21)

From Theorem 2.3, Lemma 2.4 and Theorem 2.2 we have the following table of fan widths for the cusps of  $\Gamma_0(50)$ , with the orders and invariant orders of both  $t(\tau)$  and  $t(5\tau)$ .

Expanding the right side of  $(2.21)$  gives 16 terms of the form  $t(5\tau)^k t(\tau)^{j-5}$  with  $1 \leq k \leq j+1$  where  $0 \leq j \leq 4$ , together with  $(k, j) = (0, 5)$ . We calculate the order of each term at each cusp  $\zeta$  of  $\Gamma_0(50)$ , and thus giving lower bounds for  $\text{Ord}(g(\tau), \zeta, \Gamma_0(50))$  at each cusp in the following.



Thus the constant B in Theorem 2.5 is  $B = -24$ . It suffices to show that

 $\text{Ord}(g(\tau), \infty, \Gamma_0(50)) > 24.$ 

This is easily verified. Thus by Theorem 2.5 we have  $g(\tau) \equiv 0$  and the result follows.

# 2.C. The  $U_p$  operator

Let  $p$  be prime and

$$
f = \sum_{m=m_0}^{\infty} a(m)q^m
$$

be a formal Laurent series. We define  $U_p$  by

$$
U_p(f) := \sum_{pm \ge m_0} a(pm)q^m.
$$
\n
$$
(2.22)
$$

If f is a modular function (with  $q = \exp(2\pi i \tau)$ ),

$$
U_p(f) = \frac{1}{p} \sum_{j=0}^p f \mid \begin{pmatrix} 1/p & j/p \\ 0 & 1 \end{pmatrix} = \frac{1}{p} \sum_{j=0}^p f\left(\frac{\tau + j}{p}\right). \tag{2.23}
$$

By [AtLe70, Lemma 7, p.138] we have

**Theorem 2.7.** Let p be prime. If f is a modular function on  $\Gamma_0(pN)$  and p | N, then  $U_p(f)$  is a modular function on  $\Gamma_0(N)$ .

Gordon and Hughes [GoHu81, Theorem 4, p.336] have found lower bounds for the invariant orders of  $U_p(f)$  at cusps. Let  $\nu_p(n)$  denote the p-adic order of an integer n; i.e. the highest power of p that divides n.

**Theorem 2.8.** ([GoHu81, Theorem 4]) Suppose  $f(\tau)$  is a modular function on  $\Gamma_0(pN)$ , where p is prime and  $p \mid N$ . Let  $r = \frac{\beta}{\delta}$  $\frac{\beta}{\delta}$  be a cusp of  $\Gamma_0(N)$ , where  $\delta \mid N$  and  $(\beta, \delta) = 1$ . Then

$$
\operatorname{Ord}(U_p(f), r, \Gamma_0(N)) \ge \begin{cases} \frac{1}{p} \operatorname{Ord}(f, r/p, \Gamma_0(pN)) & \text{if } \nu_p(\delta) \ge \frac{1}{2}\nu_p(N) \\ \operatorname{Ord}(f, r/p, \Gamma_0(pN)) & \text{if } 0 < \nu_p(\delta) < \frac{1}{2}\nu_p(N) \\ \min_{0 \le k \le p-1} \operatorname{Ord}(f, (r+k)/p, \Gamma_0(pN)) & \text{if } \nu_p(\delta) = 0. \end{cases}
$$

Theorems 2.5, 2.7 and 2.8 give the following algorithm.

# An algorithm for proving  $U_p$  eta-product identities

STEP 0. Write the identity in the form

$$
U_p(\alpha_1 g_1(\tau) + \alpha_2 g_2(\tau) + \dots + \alpha_k g_k(\tau)) = \beta_1 f_1(\tau) + \beta_2 f_2(\tau) + \dots + \beta_n f_n(\tau), \tag{2.24}
$$

where p is prime,  $p \mid N$ , each  $g_i(\tau)$  is an eta-product and a modular function on  $\Gamma_0(pN)$ , and each  $f_j(\tau)$  is an eta-product and modular function on  $\Gamma_0(N)$ .

STEP 1. Use Theorem 2.1 to check that  $f_j(\tau)$  is a modular function on  $\Gamma_0(N)$  for each  $1 \leq j \leq n$ , and  $g_j(\tau)$  is a modular function on  $\Gamma_0(pN)$  for each  $1 \leq j \leq k$ .

STEP 2. Use Theorem 2.3 to find a set  $S_N$  of inequivalent cusps for  $\Gamma_0(N)$  and the fan width of each cusp.

STEP 3a. Compute  $\text{Ord}(f_j, \zeta, \Gamma_0(N))$  for each j at each cusp  $\zeta$  of  $\Gamma_0(N)$  apart from  $\infty$ .

*STEP 3b.* Use Theorem 2.8 to find lower bounds  $L(g_j, \zeta, N)$  for

$$
\mathrm{Ord}(U_p(g_j),\zeta,\Gamma_0(N))
$$

for each cusp  $\zeta$  of  $\Gamma_0(N)$ , and each  $1 \leq j \leq k$ .

STEP 4. Calculate

$$
B = \sum_{\substack{\zeta \in \mathcal{S}_N \\ \zeta \neq \infty}} \min(\{\text{Ord}(f_j, \zeta, \Gamma_0(N)) : 1 \le j \le n\} \cup \{L(g_j, \zeta, N) : 1 \le j \le k\}).\tag{2.25}
$$

STEP 5. Show that

$$
Ord(h(\tau),\infty,\Gamma_0(N))>-B
$$

where

$$
h(\tau) = U_p(\alpha_1 g_1(\tau) + \alpha_2 g_2(\tau) + \cdots + \alpha_k g_k(\tau)) - (\beta_1 f_1(\tau) + \beta_2 f_2(\tau) + \cdots + \beta_n f_n(\tau)).
$$

Theorem 2.5 then implies that  $h(\tau) \equiv 0$  and hence the  $U_p$  eta-product identity (2.24).

The third author has included an implementation of this algorithm in his ETA MAPLE package. As an application of our algorithm we sketch the proof of

$$
U_5(g) = 5 f_1(\tau) + 2 f_2(\tau), \tag{2.26}
$$

where

$$
g(\tau) = \frac{\eta (50\,\tau)^5 \,\eta (5\,\tau)^4 \,\eta (4\,\tau)^3 \,\eta (2\,\tau)^3}{\eta (100\,\tau)^3 \,\eta (25\,\tau)^2 \,\eta (10\,\tau)^8 \,\eta (\tau)^2},
$$

$$
f_1(\tau) = \frac{\eta (10\,\tau)^8 \,\eta (\tau)^4}{\eta (5\,\tau)^4 \,\eta (2\,\tau)^8}, \quad f_2(\tau) = \frac{\eta (10\,\tau)^5 \,\eta (\tau)^2}{\eta (20\,\tau)^3 \,\eta (5\,\tau)^2 \,\eta (4\,\tau) \,\eta (2\,\tau)}.
$$

We use Theorem 2.1 to check that  $f_j(\tau)$  is a modular function on  $\Gamma_0(20)$  for each  $1 \leq j \leq 2$ , and  $g(\tau)$  is a modular function on  $\Gamma_0(100)$ . We use Theorem 2.3 to find a set  $\mathcal{S}_{20}$  of inequivalent cusps for  $\Gamma_0(20)$  and the fan width of each cusp. By Theorems 2.3, 2.2 and Lemma 2.4 we have the following table of orders.



Using Theorems 2.3, 2.2, 2.8 and some calculation we have the following table of lower bounds  $L(g,\zeta, 20)$ .



Thus the constant B in  $(2.25)$  is  $B = -18/5$ . It suffices to show that

$$
Ord(h(\tau),\infty,\Gamma_0(20))\geq 4,
$$

where

$$
h(\tau) = U_5(g) - (5f_1(\tau) + 2f_2(\tau)).
$$

This is easily verified. Thus by Theorem 2.5 we have  $h(\tau) \equiv 0$  and the result (2.26) follows.

## 2.D. Generalized eta-functions

The generalized Dedekind eta function is defined to be

$$
\eta_{\delta,g}(\tau) = q^{\frac{\delta}{2}P_2(g/\delta)} \prod_{m \equiv \pm g \pmod{\delta}} (1 - q^m),\tag{2.27}
$$

where  $P_2(t) = \{t\}^2 - \{t\} + \frac{1}{6}$  $\frac{1}{6}$  is the second periodic Bernoulli polynomial,  $\{t\} = t-[t]$  is the fractional part of t,  $g, \delta, m \in \mathbb{Z}^+$  and  $0 < g < \delta$ . The function  $\eta_{\delta,g}(\tau)$  is a modular function on  $SL_2(\mathbb{Z})$  with a

multiplier system. Let  $N$  be a fixed positive integer. A generalized Dedekind eta-product of level  $N$ has the form

$$
f(\tau) = \prod_{\substack{\delta \mid N \\ 0 < g < \delta}} \eta_{\delta,g}^{r_{\delta,g}}(\tau),\tag{2.28}
$$

where

$$
r_{\delta,g} \in \begin{cases} \frac{1}{2}\mathbb{Z} & \text{if } g = \delta/2, \\ \mathbb{Z} & \text{otherwise.} \end{cases}
$$
 (2.29)

Robins [Ro94] has found sufficient conditions under which a generalized eta-product is a modular function on  $\Gamma_1(N)$ .

**Theorem 2.9.** ([Ro94, Theorem 3]) The function  $f(\tau)$ , defined in (2.28), is a modular function on  $\Gamma_1(N)$  if

(i) 
$$
\sum_{\delta|N \atop g} \delta P_2(\frac{g}{\delta}) r_{\delta,g} \equiv 0 \pmod{2}, \text{ and}
$$
  
(ii) 
$$
\sum_{\delta|N \atop g} \frac{N}{\delta} P_2(0) r_{\delta,g} \equiv 0 \pmod{2}.
$$

Cho, Koo and Park [CKP09] have found a set of inequivalent cusps for  $\Gamma_1(N) \cap \Gamma_0(mN)$ . The group  $\Gamma_1(N)$  corresponds to the case  $m = 1$ .

Theorem 2.10. ([CKP09, Corollary 4, p.930]) Let a, c, a',  $c' \in \mathbb{Z}$  with  $(a, c) = (a', c') = 1$ .

(i) The cusps  $\frac{a}{c}$  and  $\frac{a'}{c'}$  $\frac{a'}{c'}$  are equivalent mod  $\Gamma_1(N)$  if and only if

$$
\begin{pmatrix} a' \\ c' \end{pmatrix} \equiv \pm \begin{pmatrix} a+nc \\ c \end{pmatrix} \pmod{N}
$$

for some integer n.

(ii) The following is a complete set of inequivalent cusps mod  $\Gamma_1(N)$ .

$$
\mathcal{S} = \left\{ \frac{y_{c,j}}{x_{c,i}} : 0 < c \mid N, 0 < s_{c,i}, a_{c,j} \leq N, (s_{c,i}, N) = (a_{c,j}, N) = 1, \right.
$$
\n
$$
s_{c,i} = s_{c,i'} \iff s_{c,1} \equiv \pm s_{c',i'} \pmod{\frac{N}{c}},
$$
\n
$$
a_{c,j} = a_{c,j'} \iff \begin{cases} a_{c,j} \equiv \pm a_{c,j'} \pmod{c}, & \text{if } c = \frac{N}{2} \text{ or } N, \right. \ a_{c,j} \equiv a_{c,j'} \pmod{c}, & \text{otherwise,} \end{cases}
$$
\n
$$
x_{c,i}, y_{c,i} \in \mathbb{Z} \text{ chosen so that } x_{c,i} \equiv cs_{c,i}, y_{c,j} \equiv a_{c,j} \pmod{N}, (x_{c,i}, y_{c,j}) = 1 \right\}.
$$

$$
x_{c,i}, y_{c,j} \in \mathbb{Z} \text{ chosen so that } x_{c,i} \equiv cs_{c,i}, y_{c,j} \equiv a_{c,j} \pmod{N}, (x_{c,i}, y_{c,j}) = 1 \bigg\}
$$

(iii) The fan width of the cusp  $\frac{a}{c}$  is given by

$$
\kappa(\frac{a}{c}, \Gamma_1(N)) = \begin{cases} 1, & \text{if } N = 4 \text{ and } (c, 4) = 2, \\ \frac{N}{(c, N)}, & \text{otherwise.} \end{cases}
$$

In this theorem, it is understood as usual that the fraction  $\frac{\pm 1}{0}$  corresponds to  $\infty$ .

Robins [Ro94] has calculated the invariant order of  $\eta_{\delta,g}(\tau)$  at any cusp. This gives a method for calculating the invariant order at any cusp of a generalized eta-product.

**Theorem 2.11.** ([Ro94]) The order at the cusp  $\zeta = \frac{a}{c}$  $\frac{a}{c}$  (assuming  $(a, c) = 1)$  of the generalized eta-function  $\eta_{\delta,q}(\tau)$  (defined in (2.27) and assuming  $0 < g < \delta$ ) is

$$
\operatorname{ord}(\eta_{\delta,g}(\tau);\zeta) = \frac{\varepsilon^2}{2\delta} P_2\left(\frac{ag}{\varepsilon}\right),\tag{2.30}
$$

where  $\varepsilon = (\delta, c)$ .

# An algorithm for proving generalized eta-product identities

We note that the analog of Theorem 2.5 holds for generalized eta-products which are modular functions on  $\Gamma_1(N)$ , and follows easily from the valence formula (2.7).

**Theorem 2.12.** ([FrGa19, Cor.2.5]) Let  $f_1(\tau)$ ,  $f_2(\tau)$ , ...,  $f_n(\tau)$  be generalized eta-products that are modular functions on  $\Gamma_1(N)$ . Let  $\mathcal{S}_N$  be a set of inequivalent cusps for  $\Gamma_1(N)$ . Define the constant

$$
B = \sum_{\substack{s \in \mathcal{S}_N \\ s \neq \infty}} min(\{Ord(f_j, s, \Gamma_1(N)) : 1 \leq j \leq n\} \cup \{0\}),
$$
\n(2.31)

and consider

$$
g(\tau) := \alpha_1 f_1(\tau) + \alpha_2 f_2(\tau) + \dots + \alpha_n f_n(\tau) + 1,
$$
\n(2.32)

where each  $\alpha_j \in \mathbb{C}$ . Then

 $g(\tau) \equiv 0$ 

if and only if

$$
Ord(g(\tau), \infty, \Gamma_1(N)) > -B.
$$
\n(2.33)

The algorithm for proving generalized eta-product identities is completely analogous to the method for proving eta-product identities described in Section 2.B.. To prove an identity in the form

$$
\alpha_1 f_1(\tau) + \alpha_2 f_2(\tau) + \cdots + \alpha_n f_n(\tau) + 1 = 0,
$$

the algorithm simply involves calculating the constant  $B$  in  $(2.31)$  and then calculating enough coefficients to show that the inequality (2.33) holds. A more complete description is given in [FrGa19].

The third author has written a MAPLE package called thetaids which implements this algorithm. See

# 3. The rank parity function modulo powers of 5

# 3.A. A Generating Function

In this section we prove an identity for the generating function of

$$
a_f(5n-1) + a_f(n/5),
$$

where it is understood that  $a_f(n) = 0$  if n is not a non-negative integer. Our proof depends on some results of Mao [Mao13] who found 5-dissection results for the rank modulo 10.

Theorem 3.1.

$$
\sum_{n=0}^{\infty} (a_f(5n-1) + a_f(n/5))q^n = \frac{J_2^4 J_{10}^2}{J_1 J_4^3 J_{20}} - 4q \frac{J_1^2 J_4^3 J_5 J_{20}}{J_2^5 J_{10}}.
$$
\n(3.34)

Proof. From Watson [Wa36, p.64] we have

$$
f(q) = \frac{2}{(q;q)_{\infty}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2}}{1+q^n}.
$$
 (3.35)

We find by replacing  $n$  by  $-n$  that

$$
\sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2+4n}}{1+q^{5n}} = \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2}}{1+q^{5n}},
$$
\n
$$
\sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2+3n}}{1+q^{5n}} = \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2+n}}{1+q^{5n}}.
$$
\n(3.36)

By [Mao13, Lemma 3.1] we have

$$
\sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2}}{1+q^{5n}} = P(q^5, -q^5; q^{25}) - \frac{P(q^{10}, -q^5; q^{25})}{q^3} + \frac{(q;q)_{\infty}}{J_{25}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{75n(n+1)/2+5}}{1+q^{25n+5}},
$$
\n(3.37)\n
$$
\sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2+n}}{1+q^{5n}} = P(q^{10}, -q^{10}; q^{25}) - q^3 P(q^5, -q^{10}; q^{25}) - \frac{(q;q)_{\infty}}{J_{25}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{75n(n+1)/2+8}}{1+q^{25n+10}},
$$
\n(3.38)\n
$$
\sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2+2n}}{1+q^{5n}} = \frac{P(q^5, -1; q^{25})}{q^6} - \frac{P(q^{10}, -1; q^{25})}{q^9} - \frac{(q;q)_{\infty}}{J_{25}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{25n(3n+1)/2-1}}{1+q^{25n}},
$$
\n(3.39)

where

$$
P(a, b; q) = \frac{[a, a^2; q]_{\infty}(q; q)_{\infty}^2}{[b/a, ab, b; q]_{\infty}}.
$$
\n(3.40)

From (3.35)-(3.39), and noting that  $P(q^5, -q^5; q^{25}) = P(q^{10}, -q^{10}; q^{25})$  we have

$$
f(q) = \frac{2}{(q;q)_{\infty}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2}}{1+q^n}
$$
(3.41)  
\n
$$
= \frac{2}{(q;q)_{\infty}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2} (1-q^n+q^{2n}-q^{3n}+q^{4n})}{1+q^{5n}}
$$
  
\n
$$
= \frac{2}{(q;q)_{\infty}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{n(3n+1)/2} (2-2q^n+q^{2n})}{1+q^{5n}}
$$
  
\n
$$
= \frac{2}{J_1} \left\{ 2q^3 P(q^5,-q^{10};q^{25}) - \frac{2P(q^{10},-q^5;q^{25})}{q^3} + \frac{P(q^5,-1;q^{25})}{q^6} - \frac{P(q^{10},-1;q^{25})}{q^9} \right\}
$$
  
\n
$$
+ \frac{4}{J_{25}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{75n(n+1)/2+5}}{1+q^{25n+5}} + \frac{4}{J_{25}} \sum_{n=-\infty}^{\infty} \frac{(-1)^n q^{75n(n+1)/2+8}}{1+q^{25n+10}} - \frac{1}{q} f(q^{25}).
$$
(3.41)

We let

$$
g(q) = \frac{2}{J_1} \left\{ 2q^3 P(q^5, -q^{10}; q^{25}) - \frac{2P(q^{10}, -q^5; q^{25})}{q^3} + \frac{P(q^5, -1; q^{25})}{q^6} - \frac{P(q^{10}, -1; q^{25})}{q^9} \right\},
$$
 (3.42)

and write the 5-dissection of  $g(\boldsymbol{q})$  as

$$
g(q) = g_0(q^5) + q g_1(q^5) + q^2 g_2(q^5) + q^3 g_3(q^5) + q^4 g_4(q^5).
$$
 (3.43)

From  $(3.35)$ ,  $(3.42)$  and  $(3.43)$ , replacing  $q^5$  by q, we have

$$
\sum_{n=0}^{\infty} a_f (5n+4) q^n = -\frac{1}{q} f(q^5) + g_4(q), \tag{3.44}
$$

after dividing both sides by  $q^4$  and replacing  $q^5$  by q.

The 5-dissection of  $J_1$  is well-known

$$
J_1 = J_{25} \left( B(q^5) - q - q^2 \frac{1}{B(q^5)} \right), \tag{3.45}
$$

where

$$
B(q) = \frac{J_{2,5}}{J_{1,5}}.
$$

See for example [Ga88, Lemma  $(3.18)$ ].

From (3.42), (3.43) and (3.45)

$$
J_{25}(g_0(q^5) + q g_1(q^5) + q^2 g_2(q^5) + q^3 g_3(q^5) + q^4 g_4(q^5)) \left( B(q^5) - q - q^2 \frac{1}{B(q^5)} \right)
$$
  
=  $4q^3 P(q^5, -q^{10}; q^{25}) - \frac{4P(q^{10}, -q^5; q^{25})}{q^3} + \frac{2P(q^5, -1; q^{25})}{q^6} - \frac{2P(q^{10}, -1; q^{25})}{q^9}.$  (3.46)

By expanding the left side of (3.46) and comparing both sides according to the residue of the exponent of  $q$  modulo 5, we obtain 5 equations:

$$
B(q)g_0 - qg_4 - \frac{q}{B(q)}g_3 = 0,
$$
\n(3.47)

$$
B(q)g_1 - g_0 - \frac{q}{B(q)}g_4 = -\frac{2P(q^2, -1; q^5)}{q^2 J_5},
$$
\n(3.48)

$$
B(q)g_2 - g_1 - \frac{1}{B(q)}g_0 = -\frac{4P(q^2, -q; q^5)}{qJ_5},
$$
\n(3.49)

$$
B(q)g_3 - g_2 - \frac{1}{B(q)}g_1 = \frac{4P(q, -q^2; q^5)}{J_5},
$$
\n(3.50)

$$
B(q)g_4 - g_3 - \frac{1}{B(q)}g_2 = \frac{2P(q, -1; q^5)}{q^2 J_5},
$$
\n(3.51)

where  $g_j = g_j(q)$  for  $0 \le j \le 4$ .

Solving these equations we find that

$$
g_4(q) = \frac{1}{J_5(B^5 - 11q - q^2/B^5)} \left(\frac{2}{q^2} X_2 B^4 - \frac{2}{q} X_1 B^{-4} + 4X_4 B^3 + 4X_3 B^{-3} - \frac{8}{q} X_3 B^2 + 8q X_4 B^{-2} - \frac{6}{q^2} X_1 B - \frac{6}{q} X_2 B^{-1}\right),
$$
\n(3.52)

where  $B := B(q)$  and

$$
X_1 = P(q^2, -1; q^5) = \frac{q^2 J_{1,10} J_{2,10}^3 J_{3,10}^3 J_{5,10}^2}{2J_{10}^6 J_{4,10}}, \quad X_2 = P(q, -1; q^5) = \frac{q J_{1,10}^3 J_{3,10} J_{4,10}^3 J_{5,10}^2}{2J_{10}^6 J_{2,10}},
$$
  

$$
X_3 = P(q^2, -q; q^5) = \frac{q J_{1,10}^3 J_{3,10}^2 J_{4,10}^2 J_{5,10}^2}{J_{10}^6}, \quad X_4 = P(q, -q^2; q^5) = \frac{J_{1,10}^2 J_{2,10}^2 J_{3,10}^3 J_{5,10}^2}{J_{10}^6}.
$$

The following identity is also well-known

$$
\frac{J_1^6}{J_5^6} = B^5 - 11q - q^2 \frac{1}{B^5}.\tag{3.53}
$$

See for example [HiHu81, Lemma  $(2.5)$ ].

By  $(3.52)$  and  $(3.53)$ , we have

$$
g_{4}(q) = \frac{J_{1,10}^{3} J_{3,10} J_{4,10}^{3} J_{5,10}^{2} J_{5}^{4} J_{5}^{5}}{q J_{2,10} J_{1,5}^{4} J_{10}^{6} J_{6}^{6}} - \frac{q J_{1,10} J_{2,10}^{3} J_{3,10}^{3} J_{5,10}^{2} J_{1,5}^{1} J_{5}^{5}}{J_{1,10}^{4} J_{2,5}^{4} J_{10}^{6} J_{6}^{6}} + 4 \frac{J_{1,10}^{2} J_{2,10}^{2} J_{3,10}^{3} J_{5,10}^{1} J_{2,5}^{3} J_{5}^{5}}{J_{1,5}^{3} J_{10}^{6} J_{6}^{6}} + 4 \frac{q J_{1,10}^{3} J_{2,10}^{2} J_{1,10}^{2} J_{2,10}^{2} J_{1,10}^{2} J_{2,10}^{2} J_{10}^{2} J_{10}^{2}}{J_{2,5}^{3} J_{10}^{6} J_{1}^{6}} - 8 \frac{J_{1,10}^{3} J_{2,10}^{3} J_{2,10}^{2} J_{2,10}^{2} J_{2,10}^{2} J_{2,10}^{3} J_{2,10}^{3} J_{5}^{5} J_{5}^{5}}{J_{2,5}^{2} J_{10}^{6} J_{1}^{6}}

We prove

$$
g_4(q) = -4 \frac{J_1^2 J_4^3 J_5 J_{20}}{J_2^5 J_{10}} + \frac{1}{q} \frac{J_2^4 J_{10}^2}{J_1 J_4^3 J_{20}},
$$
\n(3.55)

using the algorithm described in Section 2.D. We first use  $(3.54)$  to rewrite  $(3.55)$  as the following modular function identity for generalized eta-products on  $\Gamma_1(20)$ .

$$

We use Theorem 2.9 to check that each generalized eta-product is a modular function on  $\Gamma_1(20)$ . We then use Theorems 2.10 and 2.11 to calculate the order of each generalized eta-product at each cusp of  $\Gamma_1(20)$ . We calculate the constant in equation  $(2.31)$  to find that  $B = 24$ . We let  $g(\tau)$  be the right side of (3.56) and easily show that  $\text{Ord}(g(\tau), \infty, \Gamma_1(20)) > 24$ . The required identity follows by Theorem 2.12.

From  $(3.44)$  and  $(3.55)$  we have

$$
\sum_{n=0}^{\infty} a_f (5n-1)q^n + f(q^5) = q g_4(q) = \frac{J_2^4 J_{10}^2}{J_1 J_4^3 J_{20}} - 4q \frac{J_1^2 J_4^3 J_5 J_{20}}{J_2^5 J_{10}},
$$
\n(3.57)

which is our result  $(3.34)$ .

## 3.B. A Fundamental Lemma

We need the following fundamental lemma, whose proof follows easily from Theorem 2.6.

**Lemma 3.2. (A Fundamental Lemma)** Suppose  $u = u(\tau)$ , and j is any integer. Then

$$
U_5(u t^j) = -\sum_{l=0}^4 \sigma_l(\tau) U_5(u t^{j+l-5}),
$$

where  $t = t(\tau)$  is defined in (2.14) and the  $\sigma_j(\tau)$  are given in (2.15)–(2.19).

*Proof.* The result follows easily from (2.20) by multiplying both sides by  $u t^{j-5}$  and applying  $U_5$ .

**Lemma 3.3.** Let  $u = u(\tau)$ , and  $l \in \mathbb{Z}$ . Suppose for  $l \leq k \leq l+4$  there exist Laurent polynomials  $p_{u,k}(t) \in \mathbb{Z}[t, t^{-1}]$  such that

$$
U_5(u t^k) = v p_{u,k}(t),
$$
\n(3.58)

and

$$
ordt(pu,k(t)) \ge \left\lceil \frac{k+s}{5} \right\rceil,
$$
\n(3.59)

for a fixed integer s, where  $t = t(\tau)$  is defined in (2.14) and where  $v = v(\tau)$ . Then there exists a sequence of Laurent polynomials  $p_{u,k}(t) \in \mathbb{Z}[t,t^{-1}], k \in \mathbb{Z}$ , such that (3.58) and (3.59) hold for all  $k \in \mathbb{Z}$ .

*Proof.* We proceed by induction on k. Let  $N > l + 4$  and assume the result holds for  $l \leq k \leq N - 1$ . Then by Lemma 3.2 we have

$$
U_5(u t^N) = -\sum_{j=0}^4 \sigma_j(\tau) U_5(u t^{N+j-5}) = -v \sum_{j=0}^4 \sigma_j(\tau) p_{u, N+j-5}(t) = v p_{u, N}(t),
$$

where

$$
p_{u,N}(t) = -\sum_{j=0}^{4} \sigma_j(\tau) p_{u,N+j-5}(t) \in \mathbb{Z}[t, t^{-1}],
$$

and

$$
\begin{aligned} \operatorname{ord}_t(p_{u,N}(t)) &\geq \min_{0 \leq j \leq 4} (\operatorname{ord}_t(\sigma_j) + \operatorname{ord}_t(p_{u,N+j-5}(t))) \\ &\geq \min_{0 \leq j \leq 4} \left( 1 + \left\lceil \frac{N+j+s-5}{5} \right\rceil \right) = \left\lceil \frac{N+s}{5} \right\rceil. \end{aligned}
$$

The result for all  $k \geq l$  follows. The induction proof for  $k < l$  is similar.

**Lemma 3.4.** Let  $u = u(\tau)$ , and  $l \in \mathbb{Z}$ . Suppose for  $l \leq k \leq l+4$  there exist Laurent polynomials  $p_{u,k}(t) \in \mathbb{Z}[t, t^{-1}]$  such that

$$
U_5(ut^k) = v p_{u,k}(t), \t\t(3.60)
$$

where

$$
p_{u,k}(t) = \sum_{n} c_u(k,n) t^n, \quad \nu_5(c_u(k,n)) \ge \left\lfloor \frac{3n-k+r}{4} \right\rfloor
$$

for a fixed integer r, where  $t = t(\tau)$  is defined in (2.14) and where  $v = v(\tau)$ . Then there exists a sequence of Laurent polynomials  $p_{u,k}(t) \in \mathbb{Z}[t, t^{-1}], k \in \mathbb{Z}$ , such that  $(3.60)$  holds for  $k > l + 4$ , where

$$
p_{u,k}(t) = \sum_{n} c_u(k,n) t^n, \quad and \quad \nu_5(c_u(k,n)) \ge \left\lfloor \frac{3n-k+r+2}{4} \right\rfloor.
$$

**Remark 3.5.** Recall that  $\nu_p(n)$  denotes the p-adic order of an integer n; i.e. the highest power of p that divides n.

*Proof.* We proceed by induction on k. Let  $N > l + 4$  and assume (3.60) holds for  $l \leq k \leq N - 1$ where

$$
p_{u,k}(t) = \sum_{n} c_u(k,n) t^n, \quad \nu_5(c_u(k,n)) = \left[ \frac{3n - k + r}{4} \right].
$$

As in the proof of Lemma 3.3 we have

$$
U_5(u t^N) = v p_{u,N}(t),
$$

where

$$
p_{u,N}(t) = -\sum_{j=0}^{4} \sigma_j(\tau) p_{u,N+j-5}(t) \in \mathbb{Z}[t, t^{-1}],
$$

From Lemma 3.2 we have

$$
\sigma_j(\tau) = \sum_{l=1}^{j+1} s(j,l) t^l \in \mathbb{Z}[t],
$$

where

$$
\nu_5(s(j,l)) \geq \left\lfloor \frac{3l+j}{4} \right\rfloor,
$$

for  $1 \leq l \leq j+1, 0 \leq j \leq 4$ . Therefore

$$
p_{u,N}(t) = -\sum_{j=0}^{4} \sum_{l=1}^{j+1} s(j,l) \sum_{m} c_u(N+j-5,m)t^{m+l} = \sum_{n} c_u(N,n) t^n,
$$

where

$$
c_u(N,n) = -\sum_{j=0}^4 \sum_{l=1}^{j+1} s(j,l) c_u(N+j-5, n-l),
$$

and

$$
\nu_5(c_u(N,n)) \ge \min_{\substack{1 \le l \le j+1 \\ 0 \le j \le 4}} \left( \nu_5(s(j,l)) + \nu_5(c_u(N+j-5,n-l) \right)
$$
  
\n
$$
\ge \min_{\substack{1 \le l \le j+1 \\ 0 \le j \le 4}} \left( \left\lfloor \frac{3l+j}{4} \right\rfloor + \left\lfloor \frac{3(n-l)-(N+j-5)+r}{4} \right\rfloor \right)
$$
  
\n
$$
\ge \min_{\substack{1 \le l \le j+1 \\ 0 \le j \le 4}} \left\lfloor \frac{3l+j+3(n-l)-(N+j-5)+r-3}{4} \right\rfloor \ge \left\lfloor \frac{3n-N+r+2}{4} \right\rfloor.
$$

The result follows.

We define the following functions which will be needed in the proof of Theorem 1.2.

$$
P_A := \frac{J_{10}^2 J_5 J_2^6}{J_{20} J_4^3 J_1^5} - 4 \frac{q J_{20} J_5^2 J_4^3}{J_{10} J_2^3 J_1^2}, \quad P_B := \frac{J_{10}^6 J_2^2 J_1}{q J_{20}^3 J_5^5 J_4} + 4 \frac{q J_{20}^3 J_4 J_1^2}{J_{10}^3 J_5^2 J_2}, \quad A := \frac{J_{50}^2 J_1^4}{J_{25}^4 J_2^2}, \quad B := \frac{q J_{25}}{J_1}. \tag{3.61}
$$

For  $f = f(\tau)$  we define

$$
U_A(f) := U_5(A f), \qquad U_B(f) := U_5(B f). \tag{3.62}
$$

First we need some initial values of  $U_A(P_A t^k)$  and  $U_B(P_B t^k)$ .

Proof. We use the algorithm described in Section 2.C. to prove each of these identities. The identities take the form

$$
U_5(g)=f,
$$

where f, g are linear combinations of eta-products. For each identity we check that f is a linear combination of eta-products which are modular functions on  $\Gamma_0(20)$  and that g is a linear combination of eta-products which are modular functions on  $\Gamma_0(100)$ . For each of the identities we follow the 5 steps in the algorithm given after Theorem 2.8. We note that the smallest value of the constant B (defined in equation  $(2.25)$ ) encountered is  $B = -14$ . These steps have been carried out with the help of MAPLE, including all necessary verifications so that the results are proved.

Following [PaRa12] a map  $a : \mathbb{Z} \times \mathbb{Z} \longrightarrow \mathbb{Z}$  is called a *discrete array* if for each i the map  $a(i, -): \mathbb{Z} \longrightarrow \mathbb{Z}$ , by  $j \mapsto a(i, j)$  has finite support.

**Lemma 3.7.** There exist discrete arrays a and b such that for  $k \geq 1$ 

$$
U_A(P_A t^k) = P_B \sum_{n \ge [(k+5)/5]} a(k,n) t^n, \quad where \quad \nu_5(a(k,n)) \ge \left\lfloor \frac{3n-k}{4} \right\rfloor, \tag{3.63}
$$

$$
U_B(P_B t^k) = P_A \sum_{n \ge \lceil k/5 \rceil} b(k, n) t^n, \quad \text{where} \quad \nu_5(b(k, n)) \ge \left\lfloor \frac{3n - k + 2}{4} \right\rfloor. \tag{3.64}
$$

*Proof.* From Lemma 3.6, Group I we find there is a discrete array a such that

$$
U_A(P_A t^k) = P_B \sum_{n \ge [(k+5)/5]} a(k, n) t^n, \text{ where } \nu_5(a(k, n)) \ge \left\lfloor \frac{3n - k - 2}{4} \right\rfloor,
$$

for  $-4 \leq k \leq 0$ . Lemma 3.3 (with  $s = 4$ ) and Lemma 3.4 (with  $r = -2$ ) imply (3.63) for  $k \geq 1$ . From Lemma  $3.6$ , Group II we find there is a discrete array b such that

$$
U_B(P_B t^k) = P_A \sum_{n \geq \lceil k/5 \rceil} b(k, n) t^n, \quad \text{where} \quad \nu_5(b(k, n)) \geq \left\lfloor \frac{3n - k}{4} \right\rfloor,
$$

for  $-4 \le k \le 0$ . Lemma 3.3 (with  $s = 0$ ) and Lemma 3.4 (with  $r = 0$ ) imply (3.64) for  $k \ge 1$ .

# 3.C. Proof of Theorem 1.2

For  $\alpha \ge 1$  define an integer  $\delta_{\alpha}$  by  $0 < \delta_{\alpha} < 5^{\alpha}$  and  $24\delta_{\alpha} \equiv 1 \pmod{5^{\alpha}}$ . Then

$$
\delta_{2\alpha} = \frac{23 \times 5^{2\alpha} + 1}{24}, \qquad \delta_{2\alpha+1} = \frac{19 \times 5^{2\alpha+1} + 1}{24}.
$$

We let

$$
\lambda_{2\alpha} = \lambda_{2\alpha+1} = \frac{5}{24} (1 - 5^{2\alpha}).
$$

For  $n \geq 0$  we define

$$
c_f(n) := a_f(5n - 1) + a_f(n/5). \tag{3.65}
$$

We find that for  $\alpha \geq 3$ 

$$
\sum_{n=0}^{\infty} \left( a_f (5^{\alpha} n + \delta_{\alpha}) + a_f (5^{\alpha - 2} n + \delta_{\alpha - 2}) \right) q^{n+1} = \sum_{n=1}^{\infty} c_f (5^{\alpha - 1} n + \lambda_{\alpha - 1}) q^n.
$$
 (3.66)

We define the sequence of functions  $(L_{\alpha})_{\alpha=0}^{\infty}$  by  $L_0 := P_A$  and for  $\alpha \ge 0$ 

$$
L_{2\alpha+1} := U_A(L_{2\alpha}),
$$
 and  $L_{2\alpha+2} := U_B(L_{2\alpha+1}).$ 

Lemma 3.8. For  $\alpha \geq 0$ ,

$$
L_{2\alpha} = \frac{J_5 J_2^2}{J_1^4} \sum_{n=0}^{\infty} c_f (5^{2\alpha} n + \lambda_{2\alpha}) q^n,
$$

and

$$
L_{2\alpha+1} = \frac{J_{10}^2 J_1}{J_5^4} \sum_{n=0}^{\infty} c_f (5^{2\alpha+1}n + \lambda_{2\alpha+1}) q^n.
$$

Proof. By Theorem 3.1 we have

$$
L_0 = P_A = \frac{J_{10}^2 J_5 J_2^6}{J_{20} J_4^3 J_1^5} - 4q \frac{J_{20} J_5^2 J_4^3}{J_{10} J_2^3 J_1^2} = \frac{J_5 J_2^2}{J_1^4} \left( \frac{J_{10}^2 J_2^4}{J_{20} J_4^3 J_1} - 4q \frac{J_{20} J_5 J_4^3 J_1^2}{J_{10} J_2^5} \right)
$$
  
= 
$$
\frac{J_5 J_2^2}{J_1^4} \sum_{n=0}^{\infty} (a_f (5n - 1) + a_f(n/5)) q^n = \frac{J_5 J_2^2}{J_1^4} \sum_{n=0}^{\infty} c_f(n + \lambda_0) q^n,
$$

since  $\lambda_0 = 0$ .

$$
L_1 = U_A(L_0) = U_5(AL_0) = U_5 \left( \frac{J_{50}^2 J_5}{J_{25}^4} \sum_{n=0}^{\infty} c_f(n) q^n \right)
$$
  
= 
$$
\frac{J_{10}^2 J_1}{J_5^4} \sum_{n=0}^{\infty} c_f(5n + \lambda_1) q^n,
$$

since  $\lambda_1 = 0$ . This is the second equation with  $\alpha = 0$ . The general result follows similarly using a routine induction argument, by noting that

$$
5\lambda_{\alpha-1} - 1 = \delta_{\alpha} - 5^{\alpha}, \quad \frac{1}{5}\lambda_{\alpha-1} = \delta_{\alpha-2}.
$$

Our main result for the rank parity function modulo powers of 5 is the following theorem.

**Theorem 3.9.** There exists a discrete array  $\ell$  such that for  $\alpha \geq 1$ 

$$
L_{2\alpha} = P_A \sum_{n \ge 1} \ell(2\alpha, n) t^n, \quad \text{where} \quad \nu_5(\ell(2\alpha, n)) \ge \alpha + \left\lfloor \frac{3n - 3}{4} \right\rfloor, \tag{3.67}
$$

$$
L_{2\alpha+1} = P_B \sum_{n \ge 2} \ell(2\alpha+1, n) t^n, \quad \text{where} \quad \nu_5(\ell(2\alpha+1, n)) \ge \alpha+1 + \left\lfloor \frac{3n-6}{4} \right\rfloor. \tag{3.68}
$$

*Proof.* We define the discrete array  $\ell$  recursively. Define

$$
\ell(1,1) = 1, \, \ell(1,2) = -2 \cdot 5^2, \, \ell(1,3) = 14 \cdot 5^2, \, \ell(1,4) = -7 \cdot 5^3, \, \ell(1,5) = 5^4,
$$
  
and 
$$
\ell(1,k) = 0, \text{ for } k \ge 6.
$$

For  $\alpha \geq 1$  define

$$
\ell(2\alpha, n) = \sum_{k \ge 1} \ell(2\alpha - 1, k) b(k, n) \qquad \text{(for } n \ge 1),
$$
\n(3.69)

and

$$
\ell(2\alpha + 1, n) = \sum_{k \ge 1} \ell(2\alpha, k) a(k, n) \qquad \text{(for } n \ge 2), \tag{3.70}
$$

where  $a$  and  $b$  are the discrete arrays given in Lemma 3.7. From Lemma 3.6, Group I and by Lemma 3.7 and equation (3.69) we have

$$
L_1 = U_A(L_0) = U_A(P_A) = P_B \sum_{n=1}^{5} \ell(1, n) t^n, \text{ where } \nu_5(\ell(1, n)) \ge \left\lfloor \frac{3n-2}{4} \right\rfloor.
$$
  

$$
L_2 = U_B(L_1) = \sum_{n=1}^{5} \ell(1, n) U_B(P_B t^n),
$$

$$
= \sum_{n=1}^{5} \ell(1, n) P_A \sum_{k \ge 1} b(n, k) t^k
$$

$$
= P_A \sum_{n \ge 1} \sum_{k=1}^{5} \ell(1, k) b(k, n) t^n
$$

$$
= P_A \sum_{n \ge 1} \ell(2, n) t^n,
$$

where

$$
\nu_5(\ell(2,n)) \geq \min_{1 \leq k \leq 5} \left( \nu_5(\ell(1,k)) + \nu_5(b(k,n) \right) \geq \min_{1 \leq k \leq 5} \left( \left\lfloor \frac{3k-2}{4} \right\rfloor + \left\lfloor \frac{3n-k+2}{4} \right\rfloor \right) = \left\lfloor \frac{3n+1}{4} \right\rfloor,
$$

since when  $k = 1, \lfloor \frac{3k-2}{4} \rfloor$  $\left\lfloor \frac{3n-k+2}{4} \right\rfloor + \left\lfloor \frac{3n-k+2}{4} \right\rfloor$  $\left\lfloor\frac{k+2}{4}\right\rfloor=\left\lfloor\frac{3n+1}{4}\right\rfloor$  $\left[\frac{k+1}{4}\right]$ , and for  $k \geq 2$ ,

$$
\left\lfloor \frac{3k-2}{4} \right\rfloor + \left\lfloor \frac{3n-k+2}{4} \right\rfloor \ge \left\lfloor \frac{3n+2k-3}{4} \right\rfloor \ge \left\lfloor \frac{3n+1}{4} \right\rfloor.

Thus the result holds for  $L_{2\alpha}$  when  $\alpha = 1$ . We proceed by induction. Suppose the result holds for  $L_{2\alpha}$  for a given  $\alpha \geq 1$ . Then by Lemma 3.7 and equation (3.70) we have

=

P_B \sum_{n\geq 2} \ell(2\alpha + 1, n) t^n,

where

$$
\nu_5(\ell(2\alpha+1,n)) \ge \min_{1 \le k} \left( \nu_5(\ell(2\alpha,k)) + \nu_5(a(k,n)) \right) \ge \min_{1 \le k} \left( \alpha + \left\lfloor \frac{3k-3}{4} \right\rfloor + \left\lfloor \frac{3n-k}{4} \right\rfloor \right)
$$

$$
\ge \alpha + 1 + \left\lfloor \frac{3n-6}{4} \right\rfloor,
$$

since when  $k = 1, \lfloor \frac{3k-3}{4} \rfloor$  $\left\lfloor \frac{3n-k}{4}\right\rfloor+\left\lfloor \frac{3n-k}{4}\right\rfloor$  $\left\lfloor\frac{a-k}{4}\right\rfloor = 1 + \left\lfloor\frac{3n-5}{4}\right\rfloor$  $\left[\frac{k-5}{4}\right]$ , and for  $k \geq 2$ ,

$$
\left\lfloor \frac{3k-3}{4} \right\rfloor + \left\lfloor \frac{3n-k}{4} \right\rfloor \ge \left\lfloor \frac{3n+2k-6}{4} \right\rfloor \ge 1 + \left\lfloor \frac{3n-6}{4} \right\rfloor.
$$

Thus the result holds for  $L_{2\alpha+1}$ . Suppose the result holds for  $L_{2\alpha+1}$  for a given  $\alpha \geq 1$ . Then again by Lemma  $3.7$  and equation  $(3.69)$  we have

$$
L_{2\alpha+2} = U_B(L_{2\alpha+1}) = \sum_{n \ge 2} \ell(2\alpha+1, n)U_B(P_B t^n),
$$
  
= 
$$
\sum_{n \ge 2} \ell(2\alpha+1, n)P_A \sum_{k \ge 1} b(n, k)t^k
$$
  
= 
$$
P_A \sum_{n \ge 1} \sum_{k \ge 2} \ell(2\alpha+1, k)b(k, n)t^n
$$
  
= 
$$
P_A \sum_{n \ge 1} \ell(2\alpha+2, n)t^n,
$$

where  $\ell(2\alpha + 1, 1) = 0$ . Here

$$
\nu_5(\ell(2\alpha+2,n)) \ge \min_{2\le k} \left( \nu_5(\ell(2\alpha+1,k)) + \nu_5(b(k,n)) \right) \ge \min_{2\le k} \left( \alpha+1+\left\lfloor \frac{3k-6}{4} \right\rfloor + \left\lfloor \frac{3n-k+2}{4} \right\rfloor \right)
$$

$$
\ge \min_{2\le k} \left( \alpha+1+\left\lfloor \frac{3n+2k-7}{4} \right\rfloor \right) = \alpha+1+\left\lfloor \frac{3n-3}{4} \right\rfloor.
$$

Thus the result holds for  $L_{2\alpha+2}$ , and the result holds in general by induction.

**Corollary 3.10.** For  $\alpha \geq 1$  and all  $n \geq 0$  we have

$$
c_f(5^{2\alpha}n + \lambda_{2\alpha}) \equiv 0 \pmod{5^{\alpha}},\tag{3.71}
$$

$$
c_f(5^{2\alpha+1}n + \lambda_{2\alpha+1}) \equiv 0 \pmod{5^{\alpha+1}}.
$$
 (3.72)

Proof. The congruences follow immediately from Lemma 3.8 and Theorem 3.9.

In view of  $(3.66)$  and Corollary 3.10 we obtain  $(1.4)$ . This completes the proof of Theorem 1.2.

# 4. Further results

The methods of this paper can be extended to study congruences mod powers of 7 for both the rank and crank parity functions. We describe some of these results, which we will prove in a subsequent paper [CCG21]. Analogous to (3.34) we find that

$$
\sum_{n=0}^{\infty} (a_f(n/7) - a_f(7n-2))q^n = \frac{J_7^3}{J_2^2} \left( \frac{J_1^3 J_7^3}{J_2^3 J_{14}^3} + 6q^2 \frac{J_{14}^4 J_1^4}{J_2^4 J_7^4} \right),
$$
\n(4.73)

which leads to the following

**Theorem 4.1.** For all  $\alpha \geq 3$  and all  $n \geq 0$  we have

$$
a_f(7^{\alpha}n + \delta_{\alpha}) - a_f(7^{\alpha - 2}n + \delta_{\alpha - 2}) \equiv 0 \pmod{7^{\left\lfloor \frac{1}{2}(\alpha - 1) \right\rfloor}},\tag{4.74}
$$

where  $\delta_{\alpha}$  satisfies  $0 < \delta_{\alpha} < 7^{\alpha}$  and  $24\delta_{\alpha} \equiv 1 \pmod{7^{\alpha}}$ .

As mentioned earlier in Section 1., Karl-Heinz Fricke [Fr13, p.232] independently observed this theorem and related results for Ramanujan's third order mock theta function  $\omega(q)$ , but without proof.

It turns out that for the crank parity function congruences mod powers of 7 are more difficult. Define the crank parity function

$$
\beta(n) = M_e(n) - M_o(n),
$$
\n(4.75)

for all  $n \geq 0$ . The following is our analog of Choi, Kang and Lovejoy's Theorem 1.1.

**Theorem 4.2.** For each  $\alpha \geq 1$  there is an integral constant  $K_{\alpha}$  such that

$$
\beta(49n - 2) \equiv K_{\alpha}\,\beta(n) \pmod{7^{\alpha}}, \qquad \text{if } 24n \equiv 1 \pmod{7^{\alpha}}. \tag{4.76}
$$

This gives a weak refinement of Ramanujan's partition congruence modulo powers of 7:

$$
p(n) \equiv 0 \pmod{7^{\alpha}}
$$
, if  $24n \equiv 1 \pmod{7^{\left\lfloor \frac{a+2}{2} \right\rfloor}}$ .

This was also proved by Watson [Wa38]. Atkin and O'Brien [AO67] obtained congruences mod powers of 13 for the partition function similar to (4.76).
