Abstract

Microbiological spoilage of meat is considered as a process which involves mainly bacterial

metabolism leading to degradation of meat sensory qualities. Studying spoilage requires the

collection of different types of experimental data encompassing microbiological, physicochemical

and sensorial measurements. Within this framework, the objective herein was to carry out a

multiblock path modelling workflow to decipher causality relationships between different types of

spoilage-related responses: composition of microbiota, volatilome and off-odour profiles. Analyses

were performed with the Path-ComDim approach on a large-scale dataset collected on fresh turkey sausages. This approach enabled to quantify the importance of causality relationships determined *a priori* between each type of responses as well as to identify important responses involved in spoilage, then to validate causality assumptions. Results were very promising: the data integration confirmed and quantified the causality between data blocks, exhibiting the dynamical nature of spoilage, mainly characterised by the evolution of off-odour profiles caused by the production of volatile organic compounds such as ethanol or ethyl acetate. This production was possibly associated with several bacterial species like *Lactococcus piscium*, *Leuconostoc gelidum*, *Psycin rebacter sp.* or *Latilactobacillus fuchuensis*. Likewise, the production of acetoin and diacetyl in mean spoilage was highlighted. The Path-ComDim approach illustrated here with meat spoilage can be applied to other large-scale and heterogeneous datasets associated with pathway scenarics and represents a promising key tool for deciphering causality in complex biological phenom inc.

1 Introduction

Meat spoilage can be defined as any change in the product organoleptic quality during storage, such as off-odours or discolouration, that renders it unsuitable for human consumption (Huis in't Veld, 1996; Pellissery et al., 2019). Meat spoilage is mainly due to the contamination by microorganisms hosted by animals as well as spread into the factory environment of transmitted through human handling (Hultman et al., 2015). During storage, the growt', c +1 ese microorganisms may lead to defects such as olfactory side-effects associated with undesire ble volatile compounds produced from mainly bacterial metabolisms (Casaburi et al., 2015). 'n particular, off-odours are often a cause of rejection by consumers of spoiled products (Amnur et al., 2009). Therefore, studying meat spoilage process by bacteria requires generally different types of analyses encompassing microbiological, physicochemical and sensorial measure in hts. Hence, the collected experimental data may represent high-dimension heterogeneous datise. These datasets can be divided into several "data blocks" according to the associated experimental analyses. Within the meat study framework, several types of analyses can be nowad ups investigated, providing then different spoilage responses. Firstly, the characterisation of bacterial microbiota has been widely investigated thanks to recent advances in high throughput sequencing (HTS) methods of 16S rRNA amplicons, giving relative abundances of Operational Taxonomic Units (OTUs) (Cao et al., 2017; Cardinali et al., 2017). Volatilome profiles of spoiled foods defined as the complete set of volatile organic compounds (VOC) generated during storage is quantified using gas chromatography - mass spectrometry (GC-MS) analyses (Holm et al., 2013; Jääskeläinen et al., 2016). Finally, the characterization of off-odours is commonly done by sensory evaluation carried out by trained assessors on the basis of several appropriate attributes (Pereira et al., 2015).

Since the above responses can be nowadays easily measured, a novel challenge consists in integrating these large, heterogeneous, datasets and analysing the relationships between these responses. In general, each data block (microbiota, volatilome, sensory) is analysed separately or by relating one block to another one, using unsupervised or supervised approaches. Unsupervised approaches, which correspond to situations where no dependency relationship has been assumed between blocks (Tchandao Mangamana et al., 2019), have already been applied in the context of microbiology (Ferrocino et al., 2018; Mazerolles et al., 2006; Parlapani et al., 2020). Supervised approaches correspond to predictive modeling where blocks do not play a symmetrical role in the data integration, aiming especially to explain a response block by **l.e others (Cocchi, 2019). Such approaches have become increasingly popular in food science as they can shed light on relationships between responses from different sources and exhibit common dimensions from related datasets (Biancoliillo et al., 2019; Borràs et al., 2015).

Integrating multivariate data in meat spoilage can generally serve completely different purposes. One can cite, for example, analyses seeking for data structuration (similarities/differences between meat samples) with Principal Component's /.nalysis (PCA)-based methods (Argyri et al., 2011; Holm et al., 2013; Vestergaard et al., 2001) or Principal Coordinates Analysis (PCoA) (Raimondi et al., 2018; Säde et al., 2017), discrimination purposes depending on experimental design with discriminant analyses such as Linear Discriminant Analysis (LDA), Partial Least Squares — Discriminant Analysis (PLS-DA) or Multiblock (MrB)-PLS-DA (Argyri et al., 2011; Biancolillo et al., 2015; Chen et al., 2014; Girón et al., 2014), or classification purposes (Fontana et al., 2016; Rahkila et al., 2012), etc. Herein, we are interested in evaluating the importance of relationships between data blocks corresponding to different types of instrumental measurements. Relationships in meat spoilage can express supervised situations where the off-odour sensory profiles characterizing the various products under study are assumed to result from the volatilome and/or underlying bacterial metabolic pathways. Such assumptions on causality relationships can be included in the analysis by specifying *a priori* directed (oriented) paths between data blocks. This directional modelling specifically refers to path

modelling approach. Herein, not only the sensory profile of the sausages has to be explained but also intermediate links between microbiota and volatilome may be evaluated (Casaburi et al., 2015; Koutsoumanis and Nychas, 1999). This leads to set up a generalized path scenario where a block can be simultaneously assumed to be explanatory and to be explained by the other blocks. In the case of meat spoilage, such a path structure reflects the extent to which the formation of volatile compounds is the consequence of the microbiota dynamics and the cause of off-odour attributes detected by panellists (Casaburi et al., 2015; Pellissery et al., 2019). Several path fitting methods have been developed in the literature within the framework of Structure! Equation Modelling (Bollen, 1989; Kline, 2010; Wardrop and Loehlin, 1987), for example FLSTM (Lohmöller, 1989), rGCCA (Tenenhaus and Tenenhaus, 2014; Tenenhaus et al., 2017), 17th-comDim (Cariou et al., 2018) or SO-PLS (Menichelli et al., 2014; Naes et al., 2011). Herein, we folus on the application of Path-ComDim which has been already applied in sensometrics and environment (Breitwieser et al., 2018; Cariou et al., 2018) but not in food microbiology et. The originality of such an approach lies in the determination of saliences associated with each Jependency relationship which makes it possible to evaluate assumptions on generalised or at scenario as well as to evaluate the importance of the causality links between data blocks, ssociated with spoilage responses.

The objective of this paper was to present a multiblock path modelling workflow as a data analysis tool within the meat area area for evaluating causality relationships between microbiota composition, volatilome and off-odour sensory profiles. To this end, a large-scale dataset on spoilage of fresh turkey sausages, previously collected (Poirier et al., 2020), was analysed. The data analysis was carried out with Path-ComDim, an extension of the ComDim approach for analysing several data blocks having oriented relations between them (Cariou et al., 2018).

2 Materials and methods

2.1 The raw dataset

The dataset used in this work was extracted from data collected in a collaborative project in which we took part (Redlosses Project, Grant ANR-16-CE21-0006, funded by the French National Research Agency) and published in a data paper (Poirier et al., 2020). The dataset corresponded to several measurements of spoilage responses of fresh turkey sausages during chilled storage. Turkey sausages were industrially produced in ten independent batches with different formulations in each batch, packed under three gas mixtures for packaging, and monitored at rour time points (day 2, 8, 15, 22 after production). For simplification purpose, we denoted: "Fu'll dose", "Half-dose" and "Zero lactate" for the two formulations of lactate (2%, 1% and 0% w/w in turkey sausages, respectively); "Air", "MAP1" and "MAP2" for the three initial atmospheres used for packaging (Air packaging, MAP1: 70%O₂-30%CO₂ and MAP2: 50%CO₂-50%N₂, respectively). The overall experimental design and all protocols are provided in the data paper.

The extracted dataset used in the present article included three blocks of measurements: (i) microbiota composition monitored by *gyrB* amplicon sequencing, (ii) quantification of VOCs by Headspace Gas Chromatography and Mass Spectrometry (HS-GC-MS) and (iii) sensory profile of the products assessed by trained panellists. Since the experimentations were conducted independently by different laboratories, raw data were structured differently from block to block with more or less samples considered due to differences in techniques, equipment and resources. The dimensions of each block, the data pre-processing workflow as well as the pattern of the directed path between blocks are shown in Figure 1.

Microbiota composition

OTU-based (Operational taxonomic units) microbial diversity analyses were carried out using high-throughput *gyrB* amplicon sequencing in turkey sausages from ten batches, formulated with three initial lactate contents and conditioned under three MAPs at four time points. The total number of samples considered across all batches and all conditions was equal to 360. The extracted raw data included the sequencing read counts of 150 OTUs and the counts had been merged by the authors of the data paper at the 'Species' taxonomy level. These OTUs were assigned according to a recent taxonomic classification proposed by Zheng et al. (2020).

Volatilome

Identification and quantification of VOCs were conducted by comparing gas chromatography retention times and mass spectra with those of standard, co. pounds. Peak area in 1-g samples was used as quantitative data. Raw data in the block 'Volatiome' were obtained from the quantification of twenty-seven detected volatile organic comparings across all measurements in turkey sausages collected from the ten production batches, 'armulated with two initial concentrations of lactate ("Full dose" and "Zero-lactate"), packed unclar the three packaging atmospheres, monitored at the four time points and measured in triplicates (technical replicates).

Sensory profile

Sensory profiles were a selected for turkey sausages from six independent batches chosen among the 10 batches after a sensorial pre-screening step (Luong et al., 2020). Fresh sausages, with two lactate concentrations ("Full dose" and "Zero lactate"), were packed at day 2 under three different MAPs and assessed afterward at days 2, 8 and 15. The total number of samples considered in sensory analyses across all the above conditions was 80 products (N=80). Off-odours were assessed by a panel of 15 experts who had developed during an 8-month training period a consensus vocabulary to define relevant descriptors for spoiled sausages (see details in Appendix A-2). The off-odours in each sample were then evaluated by at least 12 panellists on the basis of seven descriptors. These descriptors included the global odour of rotten meat, rancid, pungent/sour, ethereal/fermented

fruit, fermented meat/old dry sausage-like, old cheese-like and sulphurous odour. Each panellist rated each descriptor intensity of each sample on a continuous scale from 0 to 10 (from "absent" to "very intense", respectively).

2.2 Statistical pre-treatments of raw data

Microbiota

Two criteria were applied for filtering OTUs with very low counts as previously done by Bouju-Albert et al. (2017). A normalisation by Centered Log Ratio transformation was performed on the retained OTUs as suggested by Bodein et al. (2019) (see Appendix A.1).

Volatilome

Quantification of each VOC (expressed in peak are.) was firstly averaged across the three technical measurements from the same sample. Afterwards, averaged data were log₁₀-transformed for all VOCs to reduce right-skewness in distributions due to low frequencies of very high counts, since their distributions were right-skewed.

Sensory profile

To take into account the dr_{61} e or agreement of each assessor with the panel sensitivity to different off-odour descriptors, a reighted average across the panellists of their product ratings was determined by applying the STATIS method (Schlich, 1996). This led to identifying a product configuration compromise where each product is described for each descriptor by a weighted average of the various scores of panellists (see Appendix A.2).

2.3 Multiblock Path-ComDim approach

For the investigation of the relationships between microbiota composition, volatilome and sensory profile, the path-ComDim approach was applied (Cariou et al., 2018). Path-ComDim is an extension of

the unsupervised multi-block method ComDim which aims at simultaneously exhibiting common dimensions shared by the various blocks and, associated with each common dimension, a vector of saliences depicting the degree of agreement of each block with this common dimension (Cariou et al., 2018; Mazerolles et al., 2006; Qannari et al., 2001). Herein, a path modelling strategy was considered with the *a priori* oriented links retrieved from the literature: 1) from "Microbiota" and "Volatilome" to the block "Sensory profile" and 2) from the "Microbiota" to "Volatilome" block (Figure 1). These links were chosen since the off-odours were *a priori* assumed to result from the bacterial development leading to the formation of the VOCs. As an blocks must share the same observations (only variables differ from one block to another), only measurements corresponding to samples evaluated by sensory analyses (N = 80) were kept in the path modeling. All blocks were assumed to be column-wise centred.

Path-ComDim criterion is given in Appendix B. 5c a detailed presentation of Path-ComDim we referred to studies of Cariou et al. (2018, '01'). Synthetically, the rationale behind Path-ComDim analysis is to seek a common latent variaule to associated with the explanatory blocks together with a common latent variable u associated with the blocks to be explained, so that they maximize the association between the block or mpunents linked by a causal path. Moreover, a salience reflecting the strength of each depende. Ty link is determined jointly with the two common components t and u. This is achieved by a propertial procedure whereby, at each stage, the couple of common components is determined for the corresponding dimension. As output, the relative importance of each dimension in retrieving the structuration of data was computed as well as the explained inertia of each block (variance accounted for each dimension). The strength of the links between blocks in each common dimension was evaluated using its relative salience (expressed in %). In the present study, the significance of each link was discussed using the p-value associated with a Linear Regression model (LRM-LV) as well as R2 coefficient from Partial Least Squares between latent variables (PLS-LV) (see Appendix B). To get insights into the contributions of each pair of variables to each common dimension retrieved, indices have been defined which makes it possible to decompose

each salience into pairwise covariance between the variables involved. Considering the dimension d, for each link oriented from the block X_k to X_l , a contribution matrix, denoted $A_{kl(d)}$ was computed in order to evaluate how each pair of variables from X_k and X_l contributes to the determination of the common latent variables of Path-ComDim.

In summary, the Path-ComDim approach determines common dimensions across data blocks "Microbiota", "Volatilome" and "Sensory profile" in such a way that these blocks are highly associated while assuming causality links between them. The importance of these links was evaluated (tested and quantified) using the relative importance sinach dimension as well as the inertia of each block. In each dimension, the importance of each hark between blocks was discussed based on its relative salience as well as p-value from LRM IV model or R2 coefficient from PLS-LV. Within the food microbiology context, for simplification and comprehensive purposes, in this work: (i) the notion of "data structuration" can be interired as the different ways that the food samples could be similar or different from each other v nile taking into account all measured responses, (ii) these above ways were observed by the determination of common "dimensions" which possibly reflect, after exploring the dataset, som a factors in the experimental design, (iii) the "saliences" of causality links show how important one type of spoilage responses is related to others, and (iv) the "inertia" quantities of each at a block correspond to the amount of variance accounted for each dimension, that is the progration of the block retrieved by each dimension. Finally, specific relationships between spoilage-related responses from different blocks were identified by representing graphically the contribution matrices between blocks. The R software (R Core Team, 2017) was used for the pre-treatments of raw data, executing the Path-ComDim approach as well as for generating different graphs illustrated in this paper. The R scripts are available upon request to the authors.

3 Results

3.1 Spoilage associated responses in the pre-treated dataset

After the pre-treatment step, the number of OTUs in microbial community across all 80 samples retained for the Path-ComDim was reduced from 150 to 86 species, belonging to 37 different genera, according to the recent taxonomic classification proposed by (Zheng et al., 2020). Among these 86 species, the data showed mostly the presence of several Lactic Acid Racteria such as genera from the family of Lactobacillaceae (union from Lactobacillaceae and Leucynos ocaceae), Lactococcus as well as different species of Psychrobacter and Pseudomonar. Resides, some species of Serratia, Enterobacter and Aeromonas were also observed. The aluncynce observed in the 80 samples under study varied to a large extent from one species to art. The (the species list and the variance plot for all species is provided in Supplementary data. Figure S1). Concerning the volatilome block, the 27 detected VOCs belonged to five groups of chetaical compounds including alcohol, aldehyde, ketone, sulphurous and some compounds associuted with spices.

3.2 Structuration of the Lata by Path-ComDim common dimensions

The importance of the det :rmi. ed common dimensions is given by absolute and relative values as in Table 1. The three blocks, Nicrobiota, Volatilome and Sensory, were mainly structured by the three first dimensions, with relative importance of 74%, 7.2% and 6.4%, for dimension 1, 2 and 3, respectively (Table 1). An important drop in inertia of the subsequent dimensions below 3% was then observed. In the three first dimensions, the variability of the block "Sensory profiles" was the best explained between the three blocks, with a cumulative inertia of 58.5%. This was mainly associated with the first and the third dimensions with 42.4% and 15.2% of explained inertia, respectively. The volatilome profile was also well explained by the three first dimensions with a cumulative inertia of

44.4%. The microbiota composition was the least well explained, with a cumulative inertia of 20.8% mainly associated with the second dimension (9.8% explained).

An example of visualisation of data structuration in Path-ComDim dimensions is given in Figure 2. In Figure 2, projected data on the first and second dimension of Path-ComDim were plotted and coloured according to storage time (2, 8 or 15 days). Such graphs could also be generated for projection in other dimensions and according to other factors such as lactate formulation and modified atmosphere packaging: some graph examples are provided in Supplementary data, Figure S2, since the analysis of these factors was out of scope for the procent study. As shown in Figure 2, spoilage-related data were strongly structured according to the subrage time in the first dimension (74%), confirming the dynamical nature of spoilage in turkey sausages. Table 1 shows that this dimension explained important proportions of variability in the blocks "Sensory profile" (42.4%) and "Volatilome" (26.1%), suggesting that the spc:la, a dynamics was mainly highlighted by the production of VOCs over time and the evolution of off-odours. In dimension one, the causality link from volatilome (26.1% explained) to sen ary profiles (42.4% explained) was also shown as the most important among the three links: the rale tive salience associated with this link equalled to 78.3% associated with a significant LRM LV coefficient (p < 0.05) (Table 1). In contrast, dimension one only explained 5.2% of the variability in the microbiota block. This low value of inertia might be associated with the high number of species in the microbiota compared to the number of samples. Moreover, all species might not contribute to the spoilage dynamics or might exhibit nonlinear evolutions. On the other hand, the link oriented from the microbiota block to volatilome (26.1% explained) was significant (LRM-LV p-value < 0.05), suggesting then that 5.2% of the variability in the microbiota could explain the observed change in the volatilome structure.

The second dimension explained the best the microbiota block with inertia of 9.8%, *i.e.* almost two-fold higher than for the other two dimensions. This dimension also explained 14.1% of the volatilome. Nevertheless, unlike dimension one, dimension two (relative importance estimated at

7.2%) did not allow the data to be clearly separated according to storage time, atmosphere or lactate formulation (Supplementary data, Figure S2 a,b,c). Finally, the third dimension showed respectively 5.8%, 4.2% and 15.2% of inertia in each block "Microbiota", "Volatilome" and "Sensory profile".

3.3 Causality relationships between specific spoilage-associated responses

With regard to dimension one, the contribution matrices corresponding to the path directed links are plotted in the heatmap shown in Figure 3. Figure 3 highlights the pairwise variables which contributed the most to the determination of each dimension and then causality relationships between specific responses from the different blocks. Data car is structured differently in different dimensions, these matrices appeared thus to be different from one to another dimension, thus giving specific contribution profiles for each dimension.

As already mentioned, the explained inertia was the inghest for the blocks sensory profile (42.4%) and volatilome (26.1%) in the first dimension of Path-ComDim, which highlighted the link oriented from volatilome to off-odours (relative sapinace 78.3% and LRM-LV p < 0.05). The overall odour of rotten meat appeared to contribute the loss to this dimension compared to its contribution value as shown in Figure 3. This off-odour descriptor was related to different volatile molecules, such as ethanol or ethyl acetate (Figure 3 right graph). Since the data were well structured by storage time in dimension one, these results suggested that the spoilage dynamics was characterized by the evolution of volatilome leading to off-odour profiles, in particular by the production of ethanol and ethyl acetate probably causing the overall odour of rotten meat. The dimension one also highlighted the causality link from microbiota to volatilome (relative salience 4.9%, LRM-LV p < 0.05, Figure 3). In spite of the low inertia in microbiota (5.2% explained), plotting contribution matrices pairing microbiota and volatilome can represent a useful tool for understanding microbial mechanisms involved in spoilage process. In this respect, as illustrated in Figure 3 (left graph), the production of ethanol and ethyl acetate were strongly linked to different LAB species such as *Lactococcus piscium*, *Leuconostoc gelidum*, *Latilactobacillus fuchuensis* as well as several *Serratia* and *Psychrobacter*

species. The species *Psychrobacter, Lc. piscium* and *L. gelidum* were also shown to be linked to other detected molecules such as 1-propanol, 3-methyl-1-butanol as well as 2-butanone. The above observed links could likely correspond to different fermentation products of LAB over time. In dimension one, since the data were strongly structured depending on the sampling time, the fermentation process of LAB may play an important role in the spoilage dynamics. Besides the LAB species mentioned above, contributions of several *Serratia* species were also highlighted, and the production of ethyl acetate or ethanol could correspond to fermentation products by these species.

In the same way as described above, one can visualise contribution and ices for other dimensions of Path-ComDim as graphical tools for understanding causal relationships between the blocks or the responses. For instance, matrices contribution associated with the second and third dimension are shown in Figure 4 and Figure 5 respectively. In Figure 4 (chinch sion 2), the contribution matrix pairing the blocks 'Microbiota' (9.8%) and 'Volatilome' (14.11') showed strong contribution of the quantity of acetoin, diacetyl and some LAB species, for example, *Dellaglioa algida, Latilactobacillus curvatus, Latilactobacillus sakei* as well as *Pharobacterium iliopiscarium, Pseudomonas versuta* and *Psychrobacter*. In the same way, in Figure 5, one can observe important contributions of *Aeromonas salmonicida, Dellaglioa algida* as well as the production of 2-methylbutyraldehyde. Finally, the molecules α -thujene, α -pine, as poinene, α -phellandrene and α -terpinene seemed to be neither related to the microbio 'a composition nor to the off-odours descriptors, since their contribution values were low whatever the dimension. This result was expected since these molecules originated from the spices mix of the sausages formulation. These spices-related molecules appeared with small variabilities across different conditions and across different time points as well, because concentration of spices mixes in sausages did not vary over time.

4 Discussion

In this paper, a multiblock path modelling approach was carried out in order to evaluate causality relationships between different types of responses within a meat spoilage framework. The major novelties in our data analysis approach with Path-ComDim consisted in including assumptions of oriented connections between data blocks while taking into account the particularities in each block by appropriate statistical pre-treatment. These causality assumptions were tested and quantified for a better biological interpretation of relationships between blocks. N. del outputs made it possible to also assess the contribution of a variable to the strength of each aus. I relationship. To the best of our knowledge, these tests and quantifications have never been carried out in the meat spoilage area. Such assumptions help identify significant patter s of specific spoilage-related relationships complementary to other unsupervised approaches at the as correlation analyses, using a graphical representation of contributions matrices. In the present study, correlations were also pre-assessed between responses from different blocks of pin-treated data using Spearman rank sum correlation, independently from Path-ComDim (Supplementary data, Figure S3, S4). The correlations profiles between blocks did not clearly show any particular link between one or several specific responses. Spearman correlation based on the rank sum correlation is generally useful in cases where relationships between value's are non-linear (as for microbiota composition, production of metabolites, etc.). Path-Co 1Dim enables to take into account additional differences in variabilities between responses, unconsidered in Spearman correlation, since this approach is multidimensional with a global optimisation criterion based on squared covariance. Therefore, among a large number of responses highly correlated together, Path-ComDim may shed light to more specific relationships from one response to another by including variabilities in the model.

It is important to note that, in the present study, we focused particularly on the evaluation of causality between different types of spoilage responses, rather than looking for a way to discriminate / separate meat samples depending on initial factors of experimental design such as lactate

formulation or atmosphere, hence the choice of Path-ComDim. Unlike other commonly used data integration approaches such as PLS-DA, sPLS-DA or MB-PLS-DA (Biancolillo et al., 2015; Cao et al., 2016; Panagou et al., 2014) for which these factors should be included as model input, Path-ComDim can be run without requiring these inputs since its algorithm was not intended to separate samples. It still gives a possibility to visualise the structuring of the data from its outputs according to factors as we have illustrated here and could provide complementary results compared to other data integration approaches.

Among the initial large number of spoilage responses (more than 100 v. riables from three different blocks) included in model input, our results enabled to ide itity specific microbial and spoilagerelated responses globally consistent with the literature. For instance, Path-ComDim identified many alcohol molecules such as ethanol, isopropanol, 1-propagol or 3 methyl-1-butanol, which have been found as some of the most common alcohols in racirally spoiled meat and in model meat systems inoculated with different spoilage microo anisms (Casaburi et al., 2015). Alcohol molecules are likely to be associated with fermentation processes by LAB as suggested in a previous work of Nordvi et al. (2007). For instance, ethanol or 3-n et nyl-1-butanol have been associated with LAB species such as L. carnosum or C. divergens since they have been detected in monocultures of these species in a study of Vasilopoulos et al. (2010). Ethanol is one of the end-products of LAB heterofermentation such as by L. gelidum of Lo. fr.chuensis (Matamoros et al., 2009) and is a precursor of ethyl esters such as ethyl acetate, also identified in the present study. Lc. piscium and L. gelidum were shown to contribute mainly to the link between the microbiota and the volatilome blocks, which is consistent with their fermentative capabilities (Jung et al., 2012, Marché et al., 2017). 1-propanol has been detected in spoiled beef samples in the presence of one or several LAB species such as Latilactobacillus sakei, Lc. piscium, or Carnobacterium divergens (Hernández-Macedo et al., 2012), also identified in our study. As expected, our results mainly highlighted the importance of the fermentation process in spoilage dynamics of fresh turkey sausages. Another example of deciphering the spoilage mechanisms of meat using the approach carried out here was the production of acetoin

and diacetyl. Acetoin, the ketone the most found in meat no matter the storage conditions, may also originate from the glucose catabolism of B. thermosphacta under aerobic atmospheres (Casaburi et al., 2015; Pin et al., 2002). Acetoin could also come from the microbial degradation of aspartate (Ardö, 2006), as well as a consequence of heme-mediated respiration metabolism by L. gelidum (Pothakos et al., 2015). Acetoin and diacetyl have also been associated with natural spoiled meat under air packaging (Dainty and Mackey, 1992; La Storia et al., 2012). Finally, the analysis with Path-ComDim also identified causality relationships between some volatile compounds and several bacterial species/groups even if these species were generally not abundant in microbiota of spoiled meat such as for Serratia, Aeromonas or Psychrobacter. Serratia so, Las been reported as belonging to Enterobacteriaceae species commonly present on work surfaces in the processing of meat or meat taken from slaughterhouses (Casaburi et al., 2015; Doclar, aki et al., 2011). Contamination and growth of these species of Enterobacteriaceae curing storage must correspond to a possible fermentation of glucose (Illeghems et al., 7J1.; Refii, 2014). For instance, Illeghems et al. (2015) suggested that several Enterobacteriacene species could be associated with mixed-acid fermentation by methylglyoxal pathway converting the case into acid lactic, as well as the production of acetate, lactate, succinate and ethanol. A recent study by Wang et al., (2017) also figured out that S. liquefaciens and A. salmonicidu showed important activities on chicken meat, leading to the production of alcohol molecules such as 1-propanol or 3-methyl-1-propanol. Regarding Psychrobacter spp., to our best knowledge, there is little information concerning their possible spoilage-associated metabolisms. These results, consistent and complementary to the literature, showed the promising capacities of Path-ComDim and, in general, path modelling methods, as a data integration tool for evaluating causal relationships in biological phenomena such as meat spoilage.

In this work considering three data blocks, the sensory and volatilome blocks were globally well explained by Path-ComDim. The limited inertia in the microbiota could probably be due to the important number of variables in this block compared with the others. Another possible limitation for exploring the composition of the microbiota was indeed the complexity of the intra-block

dynamics of the bacterial community, in particular with regard to interspecies interactions, some species possibly using substrates produced by other species. Complexity in the integration of microbiota and volatilome data could also be translated by the fact that different bacterial species could have similar metabolic pathways, leading to similar end-products, and should probably then contribute to the formation of the same volatilome. Finally, although primarily associated with microbial growth, quality changes resulting from meat spoilage and production of volatile compounds may also be associated optionally with other chemical mechanisms independent of microbial metabolisms such as lipid and protein oxidation due to lipaces and proteases. However, as our results point out, once the volatilome is structured, the off-order outcome profiles could be well explained.

Another potential limitation could lie in the possible influence of some VOCs on the microbiota development over time. In the present study, the unidirectional influence oriented from the microbiota towards VOCs was assumed incompleted from the microbiota towards VOCs was assumed incompleted from the microbiota development. The reverse influence from VOCs towards microbiota attesting to the potential effect of certain VOCs on the microbiota development, was not considered because only some VOCs and not the entire block of VOCs would be likely to influence the microbiota development. Through the present paper, we aimed to focus on the presentation of the statistical approach to explore a multiblock dataset especial, when prior information is limited. This approach could then be adapted to further studies by experts in microbiology field in order to decipher more specific causality relationships, for example by splitting data into smaller sub-blocks and/or by adapting the corresponding path diagram in the model.

In this paper, we aimed at suggesting a generic data integration workflow for evaluating causality for complex path scenarios occurring in meat spoilage using Path-ComDim. At first glance, the notion of "causality" used herein could appear as a strong wording for correlations. However, directed (oriented) relationships between the different blocks were carefully designed and included in the

statistical model by the means of a path diagram. Thus, relationships between blocks can then be encoded from one block to another one, without considering the reverse direction (orientation). The proposed path diagram mainly aimed to evaluate and assess these directed relationships designed from initial global knowledge about microbiological spoilage (microbiota, volatilome, etc.). Such path diagram, which is asymmetrical by design, represented a key step in the model, since oriented relationships between blocks could be interpreted further than correlations which do not consider any orientation. Finally, the sequential procedure of Path-ComDim for determining common dimensions, while taking into account the above path diagram, viso considered distinctly the explanatory blocks and the blocks to be explained as well.

Herein, only three blocks were considered, but this workfloor could be easily extended for other scenarios with more blocks and/or more connections to tes. For example, to overcome the limited inertia observed in microbiota, one could subdivide nicrobiota into several blocks corresponding to bacterial genera. The reduced number of rysponses in each block as well as new causality connections may thus provide interesting additional results. Another possible subdivision of blocks could be done depending on factors of ϵ ϕ rimental design (such as lactate or atmosphere) in order to take into account these factors, which could be an alternative approach to other existing discriminant ones. The main goal of this work was to explore a large-scale dataset for better understanding causality re. rionships, and the approach carried out enabled interpreting several causality relationships. The relationships observed from the results were globally consistent with the literature. It is worth noting that these relationships were not "discovered" from a biological or chemical point of view. Notwithstanding, one novelty in our approach consisted herein in the way that the model was set-up: we arbitrarily included little expert information a priori from the beginning in order to conduct a data-driven approach, providing consistent results eventually. Regarding these results in such an approach, we are convinced that the approach illustrated here with meat spoilage may be applied to other path scenarii or other datasets as a key tool for

deciphering causality in complex biological phenomena through the analysis of a large-scale heterogeneous dataset.

In a context where numerous multivariate tools can be mainly used in recent food microbiology studies, we think that the success key for exploring spoilage, especially for non-modeller researchers, is to determine the main purposes from the very beginning of the analysis. These purposes (classification, discrimination, seeking for similarities, causality, etc.) should be defined before manipulating multivariate data because the research questions will undeniably condition the choice of statistical techniques (and not the reverse). Afterwards, the actaset can be investigated thoroughly (type of responses, scale, variability, number of samples, etc.) and pre-treatments (preprocessing or data transformation), should be undertaken corefully depending on the data type. These pre-treatments could represent a key step in the civeral workflow as they can greatly improve the reliability of data integration. Depending on the considered purposes, the choice of one integration method can only be made afte: var is, for example investigating data configuration with PCA or PCoA, discriminant purposes with LDA or PLS-DA, etc. Based on these purposes and the chosen methods, other biological assur prions can be included and tested in models with expert knowledge, for example the orientation of different pathways between blocks in our study. To our knowledge, a "universal" statistical workflow for exploring spoilage or other biological phenomena with multivariate data n. am arc-processing to dedicated integration steps unfortunately does not yet exist. However, several generic frameworks have been proposed for processing different kinds of data, for example the integration of microbiome data (Bodein et al., 2019), data fusion strategies in sensory evaluation in food (Biancolillo et al., 2019, 2015; Cariou et al., 2019). Thus, in view of possible difficulties due to different processing steps, we focused merely on exploratory aspect in our illustrated workflow. In respect of the above, Path-ComDim seems to be a promising workflow since it provides not only the comprehensive structuring of spoilage profiles but also the most important relationships between specific responses. For further studies, validating the model proposed herein on external data and building generic predictive models could undoubtedly be of primary interest to

microbiologists, even if they must be handled with great care, especially for data pre-processing

steps. Although there were no predictive insights developed in our study, several perspectives could

be investigated. Indeed, on the basis of the obtained common components, approaches such as

regression model on latent variables involving cross-validation strategies, could be undertaken for a

predictive purpose, for example in estimating off-odour intensities from microbiota and VOCs

compositions.

Appendices

A - Data pre-treatment of the block

A.1 Microbiota

Only raw data associated with microbiota in turkey sausages were concidered from the data paper published by Poirier et al., (2020). These data could present a high number of zero or very low counts in several OTUs possibly when (i) the latter were observed exclusively in pork samples and/or (ii) because of the very low counts of non-dominant bacterial species as well as their low occurrence frequency across all samples. Two criteria were the considered for low count data removal. Firstly, only OTUs with non-zero counts in at least 20% of the total number of samples were kept, as previously done by Bouju-Albert, Pilet, a Guillou (2017). Afterwards, only OTUs with a total count higher than 0.05% of the total country from all OTUs across all samples were kept (arbitrary threshold). This resulted in a decrease of the total number of OTUs from 150 to 86. For each considered sample, a normalization by Centered Log Ratio transformation (CLR) was performed as suggested by Bodein et al. (2013).

A.2 Sensory profiles

The entire procedure for sensory analysis was carried out according to the Quantitative Descriptive Analysis (QDA) by a panel of 15 persons ($n_{panel}=15$). The descriptors used for the analyses were proposed and preliminarily selected by the panel in several steps. Firstly, each panellist proposed potential off-odour descriptors after sausage samples sniffing, and 59 descriptors in total were gathered. These descriptors were afterwards scored by the panellists during separated sessions. Analyses of Variance (ANOVA) were then performed on these scores in order to select discriminating

descriptors against products and led to retain 19 descriptors. A second evaluation using these 19 descriptors was carried out and 7 descriptors were finally retained on the basis of analysis of variance as previously done as well as expert elicitation. Panellists were eventually trained on the 7 retained descriptors: tainted meat odour (global spoilage odour), rancid, sour/pungent, ethereal/ fermented fruit, fermented meat/ old dry sausage-like, old cheese-like and sulphurous odour. References used in the training of the panellists are described below.

For these last six attributes, the subjects validated for each of them a chemical reference (nature and concentration) or food reference among an initial choice of 15 references with 1 to 5 possible concentrations. Panellists were trained to recognized the different odours and to rate their intensity.

After training sessions, the sensory profile was carried out for evaluating the 7 retained descriptors on 80 products (N=80) across all two conditions of lactate, 3 MAP and 3 time points. Each product (randomly chosen during different analysis sessions) was evaluated by at least 12 panellists. All panellists did not evaluate the same number and type of products. Firstly, data with off-odour score evaluated by the three 'less participating' panellists mentioned above were removed from the raw dataset. The remaining data were then divided into 12 subsets corresponding to 12 remaining 'relevant' panellists ($N_{panellists} = 12$), the aim was then to determine the consensus profile associated with the panel by weighting each remaining panellis, according to his degree of agreement with the panel. The STATIS method was carried out this bell et al., 2018; Pizarro et al., 2013) to seek the best consensus by weighting each as essor scores with a weight, denoted $\alpha_k(k=1,...N_{panellists})$. These weights were obtained by computing the first eigenvector of the matrix of the RV coefficients between the 12 data visits (RV coefficient between two subsets can be interpreted as a generalized correlation incex between the associated panellist matrices). The STATIS method required that the scores need to be measured on exactly the same products (Llobell et al., 2018). In our case, only 40 procures were commonly evaluated by the 12 relevant panellists $(N'_{prod} = 40)$. Our strategy was then to firstly perform the STATIS method on data associated with these 40 products in order to determine the weights $\alpha_k(k=1,...,N_{panellists})$ corresponding to each panelist, and afterward's to take into account these weights in the calculation of the global score for each product among the initial 80 products (which were not necessarily evaluated by the same panellists).

The STATIS method applied in the 12 data subsets concerning 40 products, denoted $V_{k,k=1,\dots,N_panellists}$) was performed using the R package ClustBlock (Llobell et al., 2019) to obtain the computed weights $\alpha_k(k=1,\dots,N_{panellists})$ associated with the 12 panelists. STATIS also computed the inertia of each panelist' matrix by calculating the corresponding Frobenius norm, denoted $F_k(k=1,\dots,N_{panellists})$, which should be taken into account to deal with the between-panelists

scale factor since the score range effectively used might be different from one panellist to another. Considering the panelist k, the corresponding Frobenius norm is given by:

Hence, for the product i, the weighted average global score for the off-odour descriptor j ($j=1,\ldots,p_s,p_s=7$) evaluated by $N_{panellists(i)}$ persons with the contexponding weights ($\alpha_{1(i)},\ldots,\alpha_{N_{panellists(i)}}$) and inertia, denoted $g_{S_i(i)}$ is given by:

The global score for all descriptors across all the 80 products were then structured in the block "Sensory profile" (dim $N*_F$, $N=80, P_S=7$).

B – Details for Path-ComDim approach

Let us denote X_1, X_2, X_3 the data blocks "Microbiota", "Volatilome" and "Sensory profile" measured on the same products, respectively. The given directed links in the path diagram between K blocks (K=3) were encoded using the path matrix $\Delta_{K,K}=(\delta_{kl})$ where $\delta_{kl}=1$ if we considered a directed link from X_k to X_l and $\delta_{kl}=0$ otherwise. The Path-ComDim approach determines, in subsequent dimensions d=1,2,..., common components $t_{(d)}$ and $u_{(d)}$ together with the saliences $\lambda_{kl(d)}$ associated with the links going from the block X_k to X_l , by maximising the quantity:

where cov stands for the covariance, $t_{k(d)} = X_k X_k^T t_{(d)}$ and $u_{l(d)} = X_l X_l^T u_{(d)}$ are denoted as latent variables (LV) associated respectively with the blocks X_k and X_l connected by a directed link from X_k to X_l . (Cariou et al., 2019, 2018)

The strength of the relationships between blocks in the dimension d of Path-ComDim was evaluated by computing the absolute value of the obtained saliences, $\lambda_{kl(d)}$. The importance of the subsequent dimensions d=1,2,..., denoted $I_{a(d)}$ was expressed by the quantities $I_{a(d)}=\sum_{k=1}^K\sum_{l=1}^K\delta_{kl}|\lambda_{kl(d)}|$. The relative importance of each dimension (expressed in %), was given by $I_{r(d)}=I_{a(d)}/\sum_{d=1,2,...}I_{a(d)}$. In the present study, we fixed a total number of 10 subsequent dimensions for the Path-ComDim algorithm. For each dimension, the relative contribution of each link (oriented from X_k to X_l) to the determination of the common components was given by the relative saliences (expressed in %). The significance of each link was evaluated by Linear Regression Models between latent variables determined by Path-ComDim (LRM-LV) (model without intercept since latent variables are centred) as well as by factor least Square regression between Latent Variables (PLS-LV) $u_{l(d)} \sim t_{k(d)}$. The significance was then discussed based on the p-value associated with LRM-LV coefficients and the coefficient of the PLS model.

Considering the dimension X_k , for each link oriented from the block X_k to X_l , the contribution matrix, denoted $A_{kl(d)}$ for evaluating the contribution by each pair of variables from X_k and X_l to the determination of the common components of Path-ComDim (with dimensions $p_k * p_l$ corresponding to the number of variables of X_k and X_l) was determined by computing the following quantities:

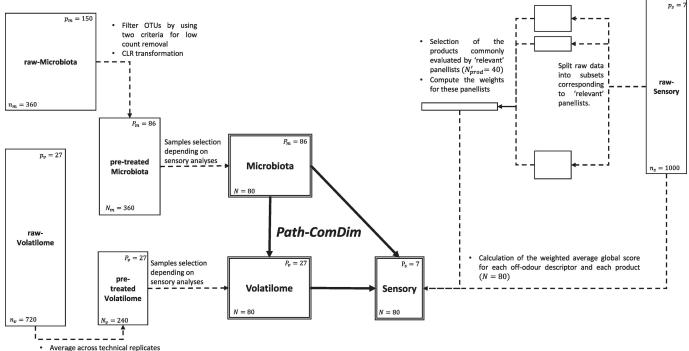

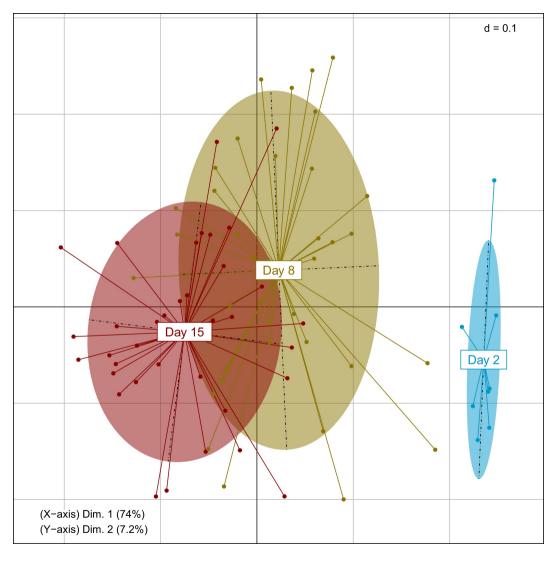
